# Max/Min Puzzles in Geometry II ${ }^{\dagger}$

#### Abstract

In this paper we continue the investigation of finding the max/min polygons which can be inscribed in a given triangle. Here we are concerned with equilateral triangles. This may seem uninteresting or benign at first, but there are some surprises later.


Recall an inscribed polygon in a given triangle is a polygon which has all of its vertices on the triangle [3]. Fig. 1 shows two examples of inscribed equilateral triangles in $\triangle A B C$ [4].

The use of Sketchpad* will be evident throughout the paper.
The first Puzzle is a quick investigation of equilateral triangles ( $E T$ for short).

Puzzle 1. If the sides of the ET $\triangle X Y Z$ have known length s, determine the height h, and the area of $\triangle X Y Z$, denoted by $(X Y Z)$.
If the height h of $E T \triangle X Y Z$ is known, determine the length of the side $s$, and the area (XYZ).

Hint: The left and right hand sides of $\triangle X Y Z$ are $30^{\circ}-60^{\circ}-90^{\circ}$ triangles with sides $s / 2$, $s$, and $h=s \sqrt{ } 3 / 2$. Thus $(X Y Z)=h s / 2=s^{2} \sqrt{ } 3 / 4$.
On the other hand, given $h$, the ratios $h / \sqrt{ } 3=s / 2$ hold, by the above observation,


Figure 2 hence $\mathrm{s}=2 h \sqrt{ } 3 / 3$, and $(X Y Z)=h^{2} \sqrt{ } 3 / 3$.

Puzzle 2. Show an inscribed ET of largest area in $\triangle A B C$, always share at least one vertex with $\triangle A B C$.

By trial and error it can be shown that there are only two ways an $E T$ of maximum area will fit in a given $\triangle A B C$. With its base on one side of the triangle and its upper vertex coinciding with the upper vertex of the given triangle, Fig. 3a, or with it's base on one side of the triangle and at least one of it's base vertices coinciding with one of the base vertices of the given triangle, Fig. 3b.
That one side of the largest $E T$ must be on a side of the triangle is well known [5].

Observe that if the base angles of a side of $\triangle A B C$ are both greater than $60^{\circ}$, then there is no inscribed $E T$ possible on that side (look at examples, or see Fig. 11).
In Fig. 3a notice that both base angles of $\triangle A B C$ are less than $60^{\circ}$, so the area of the largest $E T$ for this side is determined by the height h of $\triangle A B C$. From Puzzle $1,(A B C)=h^{2} \sqrt{3} / 3$.
In Fig. 3b base angle $B$ of $\triangle A B C$ is greater than $60^{\circ}$, and base angle $A$ is less than $60^{\circ}$, so it will take some additional calculating to compute the area of the largest $E T$ for that side of $\triangle A B C$ (see Puzzles 3 \& 4).

Since we are looking for the inscribed $E T$ of maximum area, if we can determine the largest $E T$ for each side of the given triangle, then the largest of these three is called the max inscribed ET of the triangle, and the smallest of these 3 is called the min inscribed ET of the triangle.
By the results in Puzzle 2 we know exactly where to look for the max and min ETs. We will see below that this makes our search much easier.

Consider an example, Puzzle 3, which illustrates Fig. 3b.
Puzzle 3. Let $\triangle A B C$ be the given triangle in Fig. 4 with $\alpha=45^{\circ}, \beta=75^{\circ}, \gamma$ $=60^{\circ}$, and side a of length 2. If $\triangle B D E$ is the largest $E T$ with base $E B$ on side $A B$, and $D$ on side $A C$. Compute $s$, the length of the side of $\triangle B D E$, and the exact area of $\triangle B D E$. Is $\triangle B D E$ the max inscribed ET in $\triangle A B C$ ?

Hint: Drop a perpendicular from $B$ to $A C$ at $M$.
Then $\triangle M B C$ is a $30^{\circ}-60^{\circ}-90^{\circ}$ triangle with $B M=\sqrt{ } 3$.
This means that $c=\sqrt{6}$, since $\triangle A B M$ is a $45^{\circ}-45^{\circ}-90^{\circ}$ triangle.
By the Law of Sines, $s=\sqrt{ } 6 \sin 45^{\circ} / \sin 75^{\circ}$, since angle $B D A=75^{\circ}$.
Hence $(B D E)=s^{2} \sqrt{3} / 4 \sim 1.392$.
For sides $a, b$ construct a point $F$ on $A C$ such that $|F C|=2$.

Then $\triangle B C F$ is an $E T$ which is the largest $E T$ on both sides $a$ and $b$, and
$(B C F)=\sqrt{ } 3 \sim 1.732$, by Puzzle 1 .
So $\triangle B C F$ is the $\max E T$ in $\triangle A B C$.
The key to solving Puzzle 3 was knowing that $\gamma=60^{\circ}$. But what if $\gamma \neq 60^{\circ}$ ? How do we compute the area of $\triangle B D E$ in this case? Here's a way to compute the area of such an ET, Fig. 5.

Puzzle 4. Compute the area of the largest inscribed ET on side cof $\triangle A B C$,
when $\alpha<60^{\circ}$, and $\beta>60^{\circ}$.

Hint: By the Exterior Angle Theorem, angle $C D B=60^{\circ}+\alpha$.
By the Law of Sines, $s=a \sin \gamma / \sin \left(60^{\circ}+\alpha\right)$.
But if $h_{b}$ is the altitude of $B$ to $A C$, then $\sin \gamma=h_{b} / a$, so $s=h_{b} / \sin \left(60^{\circ}+\alpha\right)$.
So by Puzzle 1, $(B D E)=\left(h_{b} / \sin \left(60^{\circ}+\alpha\right)\right)^{2} \sqrt{ } 3 / 4$.

We will now determine the location of the max and min ETs for all triangles. Also, assume from here on that $\triangle A B C$ is scalene, and in particular
$\alpha>\beta>\gamma$ iff $a>b>c$, [2, Vol.1, Props. 18, 19].
By symmetry, any result we get under these assumptions will also hold for a triangle reflected about the vertical line through the mid-point of the base $A B$. So we need only consider those triangles with upper vertex $C$ to the left of this vertical line. If $C$ is on this line, then $\triangle A B C$ is an isosceles triangle, which is a much simpler case to work with.

In the chart in Fig. 6, there is a list of examples generated on GSP.


The ratio of the area of the $E T$ to the area of $\triangle A B C$ is listed in the right-hand column, marked Ratios, as this makes it easier to compare the sizes of the areas of the ETs.
The bold $\mathbf{x}$ marks the side $a, b, c$, where the $\max E T$ is found, and the italic $x$ marks the side where the $\min E T$ is found.
There are several patterns which can be observed here.
The general results are given in Puzzle 5. In each part of Puzzle 5 an example(s) of triangles from this chart is given.

Puzzle 5. Given $\triangle A B C$, suppose the sides satisfy $a>b>c$. Show that the max ET is always on the long side $a$ ( $a$ and $c$, when $\beta=60^{\circ}$ ), and the min ET is on:
A. side $c$, when $120^{\circ}<\alpha$; and sides $b$ and $c$, when $\alpha=120^{\circ}$;
B. side $b$, when $60^{\circ}<\alpha<120^{\circ}$, and $\beta<60^{\circ}$;
C. side $b$, when $60^{\circ} \leq \beta$.

In Figures $7-10$, notice that all 3 largest ETs ( 2 ETs coincide in Fig.10) have vertex $A$ in common. Then $E T \triangle G H A$, on the long side $a$, is the max $E T$, since $J A$ and $F A$ are interior to it (a consequence of Euclid Prop. 19 [2]. Since $\triangle G H A$ and $\triangle A E F$ coincide when $\beta=60^{\circ}$, Fig. 10, the max $E T$ is on both the long side $a$ and the short side $c$ for this case.
If $\beta>60^{\circ}$, Fig. 10 , then $\alpha>\beta>60^{\circ}$, and $\mathrm{m} \angle J A B>\mathrm{m} \angle I B A$.
So $|H I|>|J A|$, by Euclid Prop. 19 [2], and $\Delta G H I$ is the $\max E T$ on the long side $a$.
These results coincide with what is observed in the chart, Fig.6.
A. Fig. 7 shows a $130^{\circ}-30^{\circ}-20^{\circ}$ triangle with $E T$ $\triangle G H A$ on the long side $a$, which is clearly the max $E T$. If you compare $|A J|$ and $|A F|$ you will discover that $\triangle A E F$ is the $\min E T$.
For the general case for $\alpha>120^{\circ}$, since $\mathrm{m} \angle C A J$ $=60^{\circ}=\mathrm{m} \angle F A B$, it follows that $\mathrm{m} \angle A J C>$ $\mathrm{m} \angle A F B$. So, in $\triangle A J F, s_{b}=|J A|>|F A|=s_{c}$, and the $\min E T$ is on the short side $c$.

Fig. 8 shows a $120^{\circ}-35^{\circ}-25^{\circ}$ triangle with the $\max E T, \triangle G H A$, on the long side $a$.
From part A. above, it follows that $\triangle G H A$ is larger than the other two $E T s$, and that $\triangle A E F$ and $\triangle J K A$ are congruent.
For a general argument, if $\alpha=120^{\circ}$, then $s_{b}=|J A|=|F A|=s_{c}$, so $\triangle A E F$ and $\triangle A J K$ are congruent, and the $\min E T$ is on both the short side $c$, and the middle side $b$.
B. In the $110^{\circ}-40^{\circ}-30^{\circ}$ triangle, Fig. 9, the area of the min $E T, \triangle A J K$ on side $b$, is less in area than that of $E T \triangle A E F$ on side $c$, which is less in area than the max $E T$ $\triangle G H A$ on side $a$, by comparing sides $A G, A F$, and $A J$.
For a formal argument, the situation is similar to part $\mathbf{A}$, since $\mathrm{m} \angle C A J=60^{\circ}=$ $\mathrm{m} \angle F A B$, so we have $\mathrm{m} \angle A J C>\mathrm{m} \angle A F B$. In $\triangle A J F$ it follows that $s_{b}=|J A|<|F A|=$ $s_{c}$, and $\triangle A J K$ is the min $E T$ on the middle side $b$.

C. In the $75^{\circ}-60^{\circ}-45^{\circ}$ triangle Fig. 10, the ETs on sides $c$ and $a$ coincide, and have sides of length $c$, while the $E T \triangle A J K$ has side $s_{b}<c$.
In general, if $\beta=60^{\circ}$, then $\triangle A E F$ and $\triangle G H A$ coincide. As $A J$ is interior to $\triangle A E F, s_{b}=|J A|<|A E|=s_{c}=c$. This means the $\min E T$ is $\triangle A J K$ on the middle side $b$.

In the $70^{\circ}-65^{\circ}-45^{\circ}$ triangle, Fig.11, the length of the side of the $\min E T, \triangle A J K$ on side $b$, is less than that of the max ET $\Delta G H I$ on side $a$, by comparing $|A J|$ and $|I B|$.
For the general argument, suppose $\beta>60^{\circ}$, then $\alpha>\beta>60^{\circ}$, and by subtracting $60^{\circ}$ from $\alpha$ and $\beta$ it follows that $\mathrm{m} \angle J A B>$ $\mathrm{m} \angle I B A$. This means $s_{a}=|H I|>|J A|=s_{b}$, and $\triangle J K A$ is the min $E T$ on the middle side $b$. There is no $E T$ on side $c$ in this case, as the base angles are greater than $60^{\circ}$.

In Fig. 12 the graphs of the regions which correspond to Puzzles $5 \boldsymbol{A}, 5 \boldsymbol{B}$, and $5 \boldsymbol{C}$, are shown. The regions are labeled with the puzzle letter. A typical triangle is shown with vertex $C$ in the region $\boldsymbol{B}$. Ignoring isosceles triangles, the dashed lines in red and green are off limits, as is the white circular area (recall it is assumed that $a>b>c$ ).
If $E T s$ of largest area on side $c$ are allowed, when vertex $C$ is in region $\boldsymbol{C}$, there is a wedged $E T$ (WET for short) [1], [4]. These are not inscribed ETS as defined above, since they do not have all 3 vertices on $\triangle A B C$, but they are the largest ETs on side $c$.
The term wedged is borrowed from Calabi [1].


The new results under this change will happen in Puzzle 5C, for then a $W E T$ on the base side $c$ of the triangle can be included, see Figures 11, 13.

5C.1. Let $\triangle A B C$ satisfy $60^{\circ} \leq \beta<80^{\circ}, 60^{\circ}<\alpha<90^{\circ}$, and $\alpha+\beta / 2<120^{\circ}$. Then the max WET is on the short side $c$, and the min WET is on the middle side $b$.

5C.2. In $\triangle A B C$, if we assume:
i.) $60^{\circ}<\beta<80^{\circ}<\alpha<90^{\circ}, \alpha / 2+\beta<120^{\circ}$, and $\alpha+\beta / 2 \geq 120^{\circ}$, then the min WET is on the middle side $b$, and the max WET is on both the short side $c$ and the long side $a$, when $\alpha+\beta / 2=120^{\circ}$, and on the long side $a$, when $\alpha+\beta / 2>120^{\circ}$.
ii.) $75^{\circ}<\beta<90^{\circ}, 80^{\circ}<\alpha<90^{\circ}$, and $\alpha / 2+\beta \geq 120^{\circ}$, then the max WET is on the long side $a$, and the min WET is on the short side $c$, when $\alpha / 2+\beta>120^{\circ}$; and on the short side $c$ and the middle side $b$, when $\alpha / 2+\beta=120^{\circ}$.

5C.3. In $\triangle A B C$, if $60^{\circ}<\beta<90^{\circ}<\alpha$, then the max WET is on the long side $a$, and the min WET is on:
i.) the middle side $b$, when $\alpha / 2+\beta<120^{\circ}$, and on the short side $c$ and the middle
side $b$, when $\alpha / 2+\beta=120^{\circ}$,
ii.) the short side $c$, when $\alpha / 2+\beta>120^{\circ}$.

As might be expected, the arguments for these results are a little more involved than those given for Puzzles 5A, 5B, and 5C above.
The following is an example of an argument for result $\mathbf{5 C . 2 i}$.
Suppose $60^{\circ}<\beta<80^{\circ}<\alpha<90^{\circ}, \alpha / 2+\beta<120^{\circ}, \alpha+\beta / 2=120^{\circ}$, and $20^{\circ}<\gamma<$ $30^{\circ}$, by the boundaries of the subregion. This means $90^{\circ}<\mathrm{m} \angle A E C=\mathrm{m} \angle B G C<$ $100^{\circ}$. Since $\beta<\alpha, \mathrm{m} \angle E A B>\mathrm{m} \angle G B A$, and $|G B|>|A E|$. So $\triangle B H G$ is a possible max $W E T$ on side $a$, and $\triangle A E F$ is a possible min WET on side $b$.
Let $B J$ be the angle bisector of $\beta, J$ on $C A$, Fig. 13. Then $\mathrm{m} \angle A J B=60^{\circ}$, since $\alpha+$ $\beta / 2=120^{\circ}$. This also means $\gamma+\beta / 2=60^{\circ}$, by the Ext. Angle Th., so $\mathrm{m} \angle C J B=$ $120^{\circ}=\mathrm{m} \angle C H G$, and $\mathrm{m} \angle C G H=\beta / 2$. But then $\mathrm{m} \angle A G B=\alpha$, since $\alpha+\beta / 2=120^{\circ}$, so $\triangle A B G$ is isosceles, and $c=|G B|$. Therefore $\triangle A B D$ and $\triangle B H G$ are max WETs on sides $c$ and $a$, resp., and $\triangle A E F$ is the min $W E T$ on side $b$.

On the other hand, if $60^{\circ}<\beta<80^{\circ}<\alpha<90^{\circ}, \alpha / 2+\beta<120^{\circ}$, and $\alpha+\beta / 2>120^{\circ}$, then $15^{\circ}<\gamma<30^{\circ}$ (check the conditions for $\alpha=$ $90^{\circ}$ ), and as above $\triangle C A E$ and $\triangle C B G$ are similar, so $\mathrm{m} \angle A G B=$ $\mathrm{m} \angle A E B$. Then $\alpha>\beta$ implies $\alpha+\beta / 2>\alpha / 2+\beta, \mathrm{m} \angle E A B>\mathrm{m} \angle G B A$, and $\mathrm{m} \angle A E B>\beta$, so $|G B|>c>|A E|$. This means that $\triangle B H G$ is the $\max W E T$ on side $a$ and $\triangle A E F$ is the min $W E T$ on side $b$.
The argument for $\mathbf{5 C . 2 i i}$ is analogous, but the angle $\alpha$ is bisected instead of angle $\beta$ in this case. Also, a similar argument can be used in 5C.3.
The other cases for isosceles triangles with central angle less than $90^{\circ}$ are contained in results 5C.1, and 5C.2ii.

These new results for Part $5 \boldsymbol{C}$ divide region $\boldsymbol{C}$ into subregions which correspond to each new result, Fig. 14.
The subregion $\boldsymbol{C} .2 \boldsymbol{i}$ is of particular interest, as two of the boundaries are the graphs of cubic equations, determined by the conditions on the angles in that part.
In region $\boldsymbol{C}$.2ii, if we have $\alpha / 2+\beta=120^{\circ}$, then $\gamma=60^{\circ}-\alpha / 2$, so by the law of sines, if $c=1$, then

$$
\begin{aligned}
& b=\sin \beta / \sin \gamma=\sin \left(120^{\circ}-\alpha / 2\right) / \sin \left(60^{\circ}-\alpha / 2\right)= \\
& \sin \left(60^{\circ}+\alpha / 2\right) / \sin \left(60^{\circ}-\alpha / 2\right),[2] .
\end{aligned}
$$

This is equivalent to the polar coordinate equation

$$
r=\sin \left(60^{\circ}+\theta / 2\right) / \sin \left(60^{\circ}-\theta / 2\right), \text { for } 80^{\circ}<\theta<90^{\circ}
$$

where $A=(0,0)$ is the polar pole, $B=(1,0), \theta=\alpha$, and $A B$ is on the polar axis.
Changing this equation to rectangular coordinates by the usual method, determines the associated cubic equation:

$$
\sqrt{ } 3 x^{3}+x^{2}(y-2 \sqrt{ } 3)+\sqrt{ } 3 x\left(y^{2}+1\right)+y^{3}-2 \sqrt{ } 3 y^{2}-y=0 .
$$

The graph of this curve (green) is the lower bound of region C.2ii and the upper bound of region $\boldsymbol{C} .2 \boldsymbol{i}$.

Similarly, the lower bound of region $\boldsymbol{C} .2 \boldsymbol{i}$ which is the upper bound of region $\boldsymbol{C} .1$ satisfies the condition $\alpha+\beta / 2=120^{\circ}$, so $\gamma=60^{\circ}-\beta / 2$. By the law of sines, if $c=1$, then

$$
b=\sin \beta / \sin \gamma=\sin \left(240^{\circ}-2 \alpha\right) / \sin \left(\alpha-60^{\circ}\right) .
$$

The corresponding polar coordinates equation is $r=\sin \left(240^{\circ}-2 \theta\right) / \sin \left(\theta-60^{\circ}\right)$, for $80^{\circ}<\theta<90^{\circ}$. In rectangular coordinates this corresponds to the cubic equation:

$$
\sqrt{ } 3 x^{3}-x^{2}(y+\sqrt{ } 3)+x\left(\sqrt{ } 3 y^{2}+2 y\right)+\sqrt{ } 3 y^{2}-y^{3}=0 .
$$

The graph of this curve (blue) is the lower bound of region C.2i, and the upper bound of region C.1.
The two cubic curves are symmetric about the vertical line through points $D$ and $I$. The point labeled $I$ is the upper vertex of the "Calabi" triangle in Puzzle 6, and also a point where the 2 cubics intersect [4].

It is obvious if $\triangle A B C$ is itself an $E T$, then all inscribed $E T s$ of largest area will coincide with $\triangle A B C$. From our analysis above this is the only triangle where the 3 largest inscribed ETs are equal.
However, if $W E T s$ are admitted, then a new possibility exists, Fig. 15.
Puzzle 6. If $\triangle A B C$ is isosceles with base angles of $80^{\circ}$, show that the largest WETs on sides $a, b$, and $c$ are congruent.

Hint: If $\alpha=\beta=80^{\circ}$, then $\gamma=m \angle E A B=m \angle G B A=20^{\circ}$.
So, $m \angle A E B=m \angle B G A=80^{\circ}$.
Then, triangles $\triangle A B E$ and $\triangle A B G$ are isosceles, $|G B|=c=|A E|$, and all 3 largest $W E T s \triangle A B D, \triangle A E F$, and $\triangle B G H$, are congruent, Fig. 15.
