# On Coupled Dirac Systems under Boundary Condition

#### Abstract

In this article we study the existence of solutions for the Dirac systems $$
\left\{\begin{array}{c} P u=\frac{\partial H}{\partial v}(x, u, v) \quad \text { on } M,  \tag{1}\\ P v=\frac{\partial H}{\partial u}(x, u, v) \quad \text { on } M, \\ B_{\mathrm{CHI}} u=B_{\mathrm{CHI}} v=0 \quad \text { on } \partial M \end{array}\right.
$$ where $M$ is an $m$-dimensional compact oriented Riemannian spin manifold with smooth boundary $\partial M, P$ is the Dirac operator under the boundary condition $B_{\mathrm{CHI}} u=B_{\mathrm{CHI}} v=0$ on $\partial M, u, v \in C^{\infty}(M, \Sigma M)$ are spinors. Using an analytic framework of proper products of fractional Sobolev spaces, the solutions existence results of the coupled Dirac systems are obtained for nonlinearity with superquadratic growth rates.


Keywords: Dirac systems, Boundary condition, Variational methods

## 1 Introduction and main results

Dirac operators on compact spin manifolds play prominent role in the geometry and mathematical physics, such as the generalized Weierstrass representation of the surface in three manifolds [17] and the supersymmetric nonlinear sigma model in quantum field theory [1112. The existence of solutions of the Dirac equation has been studied on compact spin manifolds without boundaries by Ammann 344, Raulot 31, Isobe 24|25|26, Gong and Lu 19|20, Yang 34]. In addition, be different with these existing works, Ding and Li [13] studied a class of boundary value problem on a compact spin manifold $M$ with smooth boundary. The problem is a general relativistic model of confined particles by means of nonlinear Dirac fields on $M$. In this paper, we are concerned with a nonlinear Dirac systems on compact spin manifolds with smooth boundary, and deal with some existence results.

Spin manifold $(M, g)$ equipped with a spin structure $\sigma: P_{\operatorname{spin}(M)} \rightarrow P_{s o(M)}$, and let $\Sigma M=P_{\text {spin }(M)} \times{ }_{\sigma} \Sigma_{m}$ denote the complex spinor bundle on $M$, which is a complex vector bundle of rank $2^{[m / 2]}$ endowed with the spinorial Levi-Civita connection $\nabla$ and a pointwise Hermitian scalar product $\langle\cdot, \cdot\rangle$. We always assume $m \geq 2$ in this paper. Consider Whitney direct sum $\Sigma M \oplus \Sigma M$ and Write a point of it as $(x, u, v)$, where $x \in M$ and $u, v \in \Sigma_{x} M . P$ is the Dirac operator under
the boundary condition $B_{\mathrm{CHI}} u=B_{\mathrm{CHI}} v=0$ on $\partial M$. We consider the following system of the coupled equations

B_{\mathrm{CHI}}=B_{\mathrm{CHI}} v=0 \quad \text { on } \partial M
\end{array}\right.
$$

where fiber preserving map $H: \Sigma M \oplus \Sigma M \rightarrow \mathbb{R}$ is a real valued superquadratic function of class $C^{1}$ with subcritical growth rates. (2) is the Euler-lagrange equation of the functional

where $d x$ is the Riemann volume measure on $M$ with respect to the metric $g$, $\langle\cdot, \cdot\rangle$ is the compatible metric on $\Sigma M$.

Let $z=(u, v), L=\left(\begin{array}{cc}0 & P \\ P & 0\end{array}\right)$, and $L z:=(P v, P u)$. Then (3) becomes

The problem (2) describes two coupled fermionic fields in quantum. It can be viewed as a spinorial analogue of other strongly indefinite variational problems such as infinite dynamical systems [78 and elliptic systems [516]. A typical way to deal with such problems is the min-max method of Benci and Rabinowitz [10], including the mountain pass theorem, linking arguments. Another is a homological method, Morse theory and Rabinowitz-Floer homology as in [1|9|27|29|30]. For the Dirac operator associated with appropriate boundary condition, Farinell, Schwarz [15] prove that Dirac operator $P$ is elliptic and extends to a self-adjoint operator with a discrete spectrum. Except for the work, this type of boundary condition was also considered by Hijazi, Montiel,Roldán, Zhang[21|22]. In this paper we use the techniques introduced by Hulshof and Van Der Vorst [23] to prove the existence of solutions of (21), and apply a generalized fountain theorem established by Batkam and Colin [6] to obtain infinitely many solutions of the coupled Dirac system provided the nonlinearity $H$ is even.

In the following we assume that two real numbers $p, q$ satisfy

For the nonlinearity $H$, we make the following hypotheses:
$H \in C^{0}(\Sigma M \oplus \Sigma M, \mathbb{R})$ is $C^{1}$ in the fiber direction. Real constants $2<p, q<$ $2^{*}:=\frac{2 m}{m-1}$ and $\mu$ satisfy
(i) $\max \{p-1, q-1,2\}<\mu \leq \min \{p, q\}$,
(ii) $\left(1-\frac{1}{p}\right) \max \left\{\frac{p}{\mu}, \frac{q}{\mu}\right\}<\frac{1}{2}+\frac{1}{2 m}$,
(iii) $\left(1-\frac{1}{q}\right) \max \left\{\frac{p}{\mu}, \frac{q}{\mu}\right\}<\frac{1}{2}+\frac{1}{2 m}$,
(iv) $\frac{p-1}{p} \frac{q}{\mu}<1$ and $\frac{q-1}{q} \frac{p}{\mu}<1$.
$\left(\mathbf{H}_{1}\right)$ There exist a constant $C_{1}>0$ such that

$\left(\mathbf{H}_{2}\right)$ There exist $R_{1}>0$, such that

for all $(x, u, v) \in \Sigma M \oplus \Sigma M$ with $|(u, v)| \geq R_{1}$.
$\left(\mathbf{H}_{3}\right) H(x, u, v) \geq 0$ for all $(x, u, v) \in \Sigma M \oplus \Sigma M$.
$\left(\mathbf{H}_{4}\right) H(x, u, v)=o\left(|(u, v)|^{2}\right)$ as $|(u, v)| \rightarrow 0$ uniformly for $x \in M$.
$\left(\mathbf{H}_{5}\right) H(x,-u,-v)=H(x, u, v)$ for any $(x, u, v) \in \Sigma M \oplus \Sigma M$.
Notice: That $H(x, u, v)=|u|^{p}+|v|^{q}$ satisfies these conditions. In [35] existence results for the Dirac system without boundary condition are give under the same assumptions on $H(x, u, v)$. The above condition $\left(\mathbf{H}_{2}\right)$ looses associated condition in Gong and Lu [19].

Our main result is as follow.
Theorem 1. If the above $H$ satisfies $\left(\mathbf{H}_{1}\right)-\left(\mathbf{H}_{4}\right)$, then Dirac system (2) possesses at least one solution.

Furthermore, for odd nonlinearities we have the following multiplicity result:

Theorem 2. If the above $H$ satisfies $\left(\mathbf{H}_{1}\right)-\left(\mathbf{H}_{5}\right)$, then there exists a sequence of solutions $\left\{\left(u_{k}, v_{k}\right)\right\}_{k=1}^{\infty}$ to (2) with $\mathfrak{L}\left(u_{k}, v_{k}\right) \rightarrow \infty$ as $k \rightarrow \infty$.

## 2 About boundary condition

We collect here some basic definitions and facts about spin structures on manifolds and Dirac operators. For more detailed exposition, please consult [13|28|18].

Define $(\Sigma M,\langle\rangle,, \gamma, \nabla)$ is a Dirac bundle if $\nabla: C^{\infty}(M, \Sigma M) \rightarrow C^{\infty}\left(M, T^{*} M \otimes\right.$ $\Sigma M)$ and $\gamma: C^{\infty}\left(M, T^{*} M \otimes \Sigma M\right) \rightarrow C^{\infty}(M, \Sigma M)$ satisfies:

\nabla \gamma=0,\langle\gamma(\omega) \phi, \psi\rangle+\langle\phi, \gamma(\omega) \psi\rangle=0, \nabla(\gamma(\omega) \phi)=\gamma(\nabla \omega) \phi+\gamma(\omega) \nabla \phi
$$

for any $\omega \in T M$ and $\phi, \psi \in C^{\infty}(M, \Sigma M)$. We have used the identification $T^{*} M \cong T M$ by the metric on $M$, then $C^{\infty}\left(M, T^{*} M \otimes \Sigma M\right) \cong C^{\infty}(M, T M \otimes$ $\Sigma M)$, therefore, Dirac operator $P$ act on spinors on $M$ is defined by

P \psi=\gamma \circ \nabla \psi, \quad \text { for any } \psi \in C^{\infty}(M, \Sigma M)
$$

In particular, if we choose an local orthogonal tangent frame $\left\{e_{1}, e_{2}, \ldots, e_{m}\right\}$, the Dirac operator $P$ becomes

P \psi=\Sigma_{j=1}^{m} \gamma\left(e_{j}\right) \nabla_{e_{j}} \psi, \quad \text { for any } \psi \in C^{\infty}(M, \Sigma M)
$$

Then we consider a Chirality operator associated with the Dirac bundle

\langle\Sigma M,\langle\cdot\rangle, \gamma, \nabla\rangle
$$

If a linear map $F: E n d_{\mathbb{C}}(\Sigma M) \rightarrow E n d_{\mathbb{C}}(\Sigma M)$ satisfies

$$
F^{2}=\operatorname{Id},\langle F \psi, F \varphi\rangle=\langle\psi, \varphi\rangle, \nabla_{X}(F \psi)=F \nabla_{X} \psi, \gamma(X) F \psi=-F \gamma(X) \psi
$$

for each vector field $X \in T M$ and spinor fields $\psi, \varphi \in C^{\infty}(M, \Sigma M)$.
The boundary hypersurface $\partial M$ is also a spin manifold and so we have the corresponding spinor bundle $\Sigma \partial M$, the clifford multiplication $\gamma^{\partial M}$, the spin connection $\nabla^{\partial M}$ and the intrinsic Dirac operator $P^{\partial M}$. In 21], Hijazi, Montiel, Roldán show that the restricted Hermitian bundle $\left.\Sigma M\right|_{\partial M}$ can be identified with the intrinsic Hermitian spinor bundle $\Sigma \partial M$, provided that $m$ is odd. Instead, if $m$ is even, the restricted Hermitian bundle $\left.\Sigma M\right|_{\partial M}$ could be identified with the sum $\Sigma \partial M \oplus \Sigma \partial M$.

Define an operator $\Gamma:=\left.F\right|_{\partial M} \gamma(N)$, where $N$ denotes the unite inner normal vector field on $\partial M$. By the definition, we know $F$ is a local operator on the spinor bundle over $\partial M . F$ is a self-adjoint operator and has two eigenvalues +1 and -1 . The corresponding eigenspaces are

\Gamma_{+}=\left\{\phi \in C^{\infty}(\partial M, \Sigma \partial M) \mid F \phi=\phi\right\}, \Gamma_{-}=\left\{\phi \in C^{\infty}(\partial M, \Sigma \partial M) \mid F \phi=-\phi\right\} .
$$

Now consider the boundary condition in problem (2). The operator $B_{\mathrm{CHI}}$ on $\partial M$ is defined as $B_{\mathrm{CHI}}=\frac{1}{2}(\operatorname{Id}-F)=\frac{1}{2}(\operatorname{Id}-\gamma(N) G)$. Then $B_{\mathrm{CHI}}$ is a self-adjoint operator and it is not difficult to see that

\left.B_{\mathrm{CHI}} \psi\right|_{\partial M}=0 \Leftrightarrow \psi \in C^{\infty}(M, \Sigma M) \quad \text { and }\left.\quad \psi\right|_{\partial M} \in \Gamma_{+} .
$$

For the space $C^{\infty}(M, \Sigma M)$, define an inner product

$$
(\psi, \varphi)_{H^{1}}=(\psi, \varphi)_{2}+(\nabla \psi, \nabla \varphi)_{2}, \quad \forall \psi, \varphi \in C^{\infty}(M, \Sigma M)
$$

Then $H^{1}(M, \Sigma M)$ is the completion of the space $C^{\infty}(M, \Sigma M)$ with respect to the norm $\|\cdot\|_{H^{1}}$. Since $P$ is a first operator, it extends to a linear operator $P: H^{1}(M, \Sigma M) \rightarrow L^{2}(M, \Sigma M)$ and $\left.P\right|_{\partial M}: H^{1}(M, \Sigma M) \rightarrow L^{2}(\partial M, \Sigma \partial M)$. Let

$$
\mathfrak{D}(P)=\left\{\psi \in H^{1}(M, \Sigma M)|\psi|_{\partial M} \in L^{2} \Gamma_{+}\right\} .
$$

Then the Dirac operator $P$ with Chirality boundary condition $\left.B_{\mathrm{CHI}} \psi\right|_{\partial M}=0$ is well defined in the domain $\mathfrak{D}(P)$. For simplicity, in the following, we will denote the $\mathfrak{D}(P)$ by $\mathfrak{D}$.

For $\psi, \varphi \in \mathfrak{D}$,By the integrated version of Lichnerowitz Formula, we have $(P \psi, \varphi)=(\psi, P \varphi)$, Actually, $P$ is a self-adjoint operator in $L^{2}(M, \Sigma M)$ with domain $\mathfrak{D}$.

## 3 The analytic framework

Recall the operator $P$ is an unbounded self-adjoint operator, Let $\operatorname{Spec}(\mathrm{P})$ denote the spectrum of the Dirac operator $P$ under the local boundary condition $\left.B_{\mathrm{CHI}} \psi\right|_{\partial M}=0$. Moreover, there exists a complete orthonormal basis $\left\{\eta_{k}\right\}_{k=1}^{\infty}$ of the Hilbert space $\mathfrak{D}$ consisting of the eigenspinors of the operator $P: P \eta_{k}=\lambda_{k}^{\mathrm{CHI}} \eta_{k}$. Moreover, $\left|\lambda_{k}^{\mathrm{CHI}}\right| \rightarrow \infty$ (as $k \rightarrow \infty$ ) and all corresponding eigenvalues $\left\{\lambda_{k}^{\mathrm{CHI}}\right\}_{k=1}^{\infty}$ have finite multiplicity.

If $(M, g)$ has positive scalar curvature, it is obviously $0 \notin \operatorname{Spec}(P)$ By the Fridrich's inequality.

Define

$$
(\psi, \varphi)_{1,2}:=(P \psi, P \varphi)_{2}, \quad \forall \psi, \varphi \in \mathfrak{D}
$$

where $(\cdot, \cdot)_{2}$ is the $L^{2}$-inner product on spinors. We denote $\|\psi\|_{1,2}=(\psi, \psi)_{1,2}^{\frac{1}{2}}$. Since $P$ is self-adjoint, we can prove ( $\mathfrak{D},\|\cdot\|_{1,2}$ ) is a Hilbert space. In addition, the following lemma tells us that $\left(\mathfrak{D},\|\cdot\|_{1,2}\right)$ embeds continuously in $H^{1}(M, \Sigma M)$.
Lemma 1. [15] There exists a universal constant $C \in[1,+\infty]$ such that

Let $|P|$ denote the absolute value operator of $P$ defined in $L^{2}(M, \Sigma M)$, and $|P|^{\frac{1}{2}}$ is the square root operator of $|P|$ with its spectrum

\operatorname{Spec}\left(|P|^{\frac{1}{2}}\right)=\left\{\left.\left|\lambda_{k}^{\mathrm{CHI}}\right|^{\frac{1}{2}} \right\rvert\, k=1,2,3, \cdots\right\} .

The inner product is define by

(\psi, \varphi)_{\frac{1}{2}, 2}:=\left(|P|^{\frac{1}{2}} \psi,|P|^{\frac{1}{2}} \varphi\right)_{2}, \quad \forall \psi, \varphi \in \mathfrak{D}
$$

Let $E^{\frac{1}{2}}:=\mathfrak{D}\left(|P|^{\frac{1}{2}}\right)$ denote the domain of the operator $|P|^{\frac{1}{2}}$ and $|P|^{\frac{1}{2}}$ is self-adjoint in $L^{2}(M, \Sigma M)$. We denote $\|\psi\|_{\frac{1}{2}, 2}=(\psi, \psi)_{\frac{1}{2}, 2}^{\frac{1}{2}}$. Then $\left(E^{\frac{1}{2}},\|\cdot\|_{\frac{1}{2}, 2}\right)$ is a Hilbert space, Its dual space is denoted by $E^{-\frac{1}{2}}$. Then $|P|^{-1}$ is a Hilbert space isomorphism from $E^{-\frac{1}{2}}$ to $E^{\frac{1}{2}}$ with respect to the equivalent inner products $(\cdot, \cdot)_{\frac{1}{2}, 2}$.

Consider the Hilbert space

with inner product

and norm $\|z\|_{E}:=\left(\|u\|_{\frac{1}{2}, 2}^{2}+\|v\|_{\frac{1}{2}, 2}^{2}\right)^{\frac{1}{2}}$ for $z=(u, v) \in E$. Let $E^{*}=$ $E^{-\frac{1}{2}} \times E^{-\frac{1}{2}}$, which is the dual space of $E$. Then

is a Hilbert space isomorphism by the arguments above. Hence

denote

\end{array}\right)

It is a self-adjoint isometry operator and $B \circ B=\mathrm{Id}: E \rightarrow E$ is identity operator. Introducing the "diagonals"

E_{ \pm}=\left\{\left( \pm|P|^{-1} P v, v\right) \left\lvert\, v \in E^{\frac{1}{2}}\right.\right\}
$$

We have

E=E_{+} \oplus E_{-}=\left\{z=z^{+}+z^{-} \mid z^{ \pm} \in E_{ \pm}\right\}
$$

Note that $B z^{ \pm}= \pm z^{ \pm}$, so that $E_{+}$and $E_{-}$are the mutually orthogonal eigenspaces of the eigenvalues 1 and -1 of $B$. Orthonormal bases consisting of eigenvectors of $E_{ \pm}$are given by

E_{+}:=\overline{\bigoplus_{j=1}^{\infty} \mathbb{R} e_{j}} \quad \text { with } e_{j}=\frac{1}{\sqrt{2}}\left(\left|\lambda_{k}^{\mathrm{CHI}}\right|^{-\frac{1}{2}} \eta_{k},\left|\lambda_{k}^{\mathrm{CHI}}\right|^{-\frac{3}{2}} \lambda_{k}^{\mathrm{CHI}} \eta_{k}\right)
$$

We have

(L z, z)_{2} & \left.=\int_{M}\langle L z, z\rangle d x=2 \int_{M}\langle P u, v\rangle d x=\left.2 \int_{M}\langle | P\right|^{\frac{1}{2}}|P|^{-1} P u,|P|^{\frac{1}{2}} v\right\rangle d x \\
& =2\left(|P|^{-1} P u, v\right)_{\frac{1}{2}, 2}=(B z, z)_{E} .
\end{aligned}
$$

Then for each $z=z^{+}+z^{-}$, we have

(L z, z)_{2}=\int_{M}\langle L z, z\rangle d x=(B z, z)_{E}=\left\|z^{+}\right\|_{E}^{2}-\left\|z^{-}\right\|_{E}^{2} .
$$

Now we can define a functional $\mathcal{L}: E \rightarrow \mathbb{R}$ as

\end{equation*}

where $\mathcal{H}(z)=\int_{M} H(x, z) d x$.
Since $M$ is compact, by the assumption ( $H_{1}$ ) and integrating we obtain

and let $u=0$, similarly, we prove that

From (9), (10) and Young' inequality to derive

for some constant $C>0$.
By an analysis of interpolation of the Sobolev spaces,

E^{\frac{1}{2}}=\left[\mathfrak{D}, L^{2}\right]_{\frac{1}{2}} \quad \text { and } \quad H^{\frac{1}{2}}(M, \Sigma M)=\left[H^{1}, L^{2}\right]_{\frac{1}{2}}
$$

where $[\cdot, \cdot]_{\frac{1}{2}}$ means the interpolation and $H^{\frac{1}{2}}(M, \Sigma M)$ coincides with the usual $L^{2}-$ Sobolev space of order $s, W^{s, 2}(M, \Sigma M)$,see [2].

Since $\left(\mathfrak{D},\|\cdot\|_{1,2}\right)$ embeds $H^{1}(M, \Sigma M)$ continuously, there holds the continuous embedding

E^{\frac{1}{2}} \times E^{\frac{1}{2}}=\left[\mathfrak{D}, L^{2}\right]_{\frac{1}{2}} \times\left[\mathfrak{D}, L^{2}\right]_{\frac{1}{2}} \hookrightarrow\left[H^{1}, L^{2}\right]_{\frac{1}{2}} \times\left[H^{1}, L^{2}\right]_{\frac{1}{2}}=H^{\frac{1}{2}} \times H^{\frac{1}{2}}
$$

By the fact $H^{\frac{1}{2}}(M, \Sigma M)$ embeds $L^{p}(M, \Sigma M)$ continuously for $1 \leq p \leq \frac{2 m}{m-1}$. Moreover, this embedding is compact if $1 \leq p<\frac{2 m}{m-1}$. we obtain the following lemma:

Lemma 2. $E^{\frac{1}{2}} \times E^{\frac{1}{2}}$ embeds $L^{p}(M, \Sigma M) \times L^{q}(M, \Sigma M)$ continuously for $1 \leq$ $p \leq \frac{2 m}{m-1}, 1 \leq q \leq \frac{2 m}{m-1}$. Moreover, this embedding is compact if $1 \leq p<$ $\frac{2 m}{m-1}, 1 \leq q<\frac{2 m}{m-1}$. Where norm $\|z\|_{L^{p} \times L^{q}}:=\left(\|u\|_{p}^{p}+\|v\|_{q}^{q}\right)^{\frac{1}{2}}$ for $z=$ $(u, v) \in L^{p}(M, \Sigma M) \times L^{q}(M, \Sigma M)$.

Then using (11) we can define the functional $\mathcal{H}: E \rightarrow \mathbb{R}$ as

$$
\mathcal{H}(u, v)=\int_{M} H(x, u, v) d x
$$

is of class $C^{1}$ and its derivative at $(u, v) \in E$ is given by

$$
D \mathcal{H}(u, v)(\xi, \zeta)=\int_{M}\left(\left\langle H_{u}(x, u, v), \xi\right\rangle+\left\langle H_{v}(x, u, v), \zeta\right\rangle\right) d x \quad(\xi, \zeta) \in E
$$

Moreover $D \mathcal{H}: E \rightarrow E^{*}$ is a compact operator.
In fact, Using Hölder inequality and embeddings we have

$$
\int_{M}\left\langle H_{u}(x, u, v), \xi\right\rangle d x \leq C\left(\|u\|_{\frac{1}{2}, 2}^{p-1}+\|v\|_{\frac{1}{2}, 2}^{\frac{(p-1) q}{p}}+1\right)\|\xi\|_{\frac{1}{2}, 2}
$$

In a similar way we obtain an inequality for the derivative with respect to $v$. Thus $D \mathcal{H}(u, v)$ is well defined and bounded in $E$. Next, by the Sobolev embeddings, usual arguments give that $D \mathcal{H}(u, v)$ is compact.

## 4 The Palais-Smale condition for $\mathfrak{L}$

Let $F$ be a $C^{1}$ functional on a Banach space $E, c \in \mathbb{R}$. Recall that a sequence $\left\{x_{n}\right\} \subset E$ is called a $(P S)_{c}-$ sequence if $F\left(x_{n}\right) \rightarrow c$ as $n \rightarrow \infty$ and $\left\|D F\left(x_{n}\right)\right\|_{E^{*} \rightarrow 0}$ as $n \rightarrow \infty$. If all $(P S)_{c}$-sequences converge in $E$, we say that $F$ satisfies the $(P S)_{c}$ condition. In this section we prove the $(P S)_{c}$ condition for $\mathfrak{L}$.

Lemma 3. Suppose $H$ satisfies $\left(\mathbf{H}_{1}\right),\left(\mathbf{H}_{2}\right)$. Then for any $c \in \mathbb{R}, \mathfrak{L}$ satisfies the $(P S)_{c}$-condition with respect to $E$.

Proof. let $\left\{z_{n}\right\}=\left\{\left(u_{n}, v_{n}\right)\right\} \subset E$ be a $(P S)_{c}$-sequence with respect to $E$, i.e., $z_{n} \in E$ and satisfy

\begin{equation*}
\mathfrak{L}\left(z_{n}\right) \rightarrow c \quad \text { as } n \rightarrow \infty \tag{12}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|D \mathfrak{L}\left(z_{n}\right)\right\|_{E^{*}} \rightarrow 0 \quad \text { as } n \rightarrow \infty \tag{13}
\end{equation*}
$$

Claim. $\left\{z_{n}\right\} \subset E$ is bounded.
The condition $\left(\mathbf{H}_{2}\right)$ implies that there are constants $C_{2}, C_{3}>0$ such that

$$
\begin{equation*}
H\left(x, u_{n}, v_{n}\right) \geq C_{2}\left(\left|u_{n}\right|^{\mu}+\left|v_{n}\right|^{\mu}\right)-C_{3} . \tag{14}
\end{equation*}
$$

See [14] for a proof. By (12)-(14) and $\left(\mathbf{H}_{2}\right)$, for large $n$ we have

\begin{align*}
C+\left\|z_{n}\right\|_{E} & \geq 2 \mathfrak{L}\left(z_{n}\right)-\left\langle D \mathfrak{L}\left(z_{n}\right), z_{n}\right\rangle \\
& =\int_{M}\left\langle H_{z}, z_{n}\right\rangle d x-2 \int_{M} H\left(x, z_{n}\right) d x \\
& \geq(\mu-2) \int_{M} H\left(x, z_{n}\right) d x-C \\
& \geq C_{2}(\mu-2) \int_{M}\left(\left|u_{n}\right|^{\mu}+\left|v_{n}\right|^{\mu}\right) d x-C_{3}(\mu-2)|M|-C . \tag{15}
\end{align*}
$$

Hereafter $C$ denote various positive constants which do not depend on $n$. Clearly, (15) implies that for large $n,\left\|u_{n}\right\|_{\mu}^{\mu}+\left\|v_{n}\right\|_{\mu}^{\mu} \leq C\left(1+\left\|z_{n}\right\|_{E}\right)$ and so

\left\|u_{n}\right\|_{\mu}^{\mu} \leq C\left(1+\left\|z_{n}\right\|_{E}\right) \quad \text { and } \quad\left\|v_{n}\right\|_{\mu}^{\mu} \leq C\left(1+\left\|z_{n}\right\|_{E}\right) \tag{16}
\end{equation*}
$$

Write $z_{n}=z_{n}^{-}+z_{n}^{+}$according to the decomposition $E=E_{-} \oplus E_{+}$. By (13), for large $n$, we have

\left|\left\langle D \mathfrak{L}\left(z_{n}\right), z_{n}^{+}\right\rangle\right|=\left|\left\|z_{n}^{+}\right\|_{E}^{2}-\int_{M}\left\langle z_{n}^{+}, H_{z}\right\rangle d x\right| \leq\left\|z_{n}^{+}\right\|_{E} . \tag{17}
\end{equation*}
$$

This and $\left(\mathbf{H}_{1}\right)$ lead to

$$
\begin{align*}
& \left\|z_{n}^{+}\right\|_{E}^{2} \leq\left|\int_{M}\left\langle z_{n}^{+}, H_{z}\right\rangle d x\right|+\left\|z_{n}^{+}\right\|_{E} \\
\leq & \left|\int_{M}\left\langle u_{n}^{+}, H_{u}\right\rangle d x\right|+\left|\int_{M}\left\langle v_{n}^{+}, H_{v}\right\rangle d x\right|+\left\|z_{n}^{+}\right\|_{E} \\
\leq & \int_{M}\left|u_{n}^{+}\right|\left|H_{u}\right| d x+\int_{M}\left|v_{n}^{+}\right|\left|H_{v}\right| d x+\left\|z_{n}^{+}\right\|_{E} \\
\leq & \int_{M} c_{1}\left(\left|u_{n}\right|^{p-1}+\left|v_{n}\right|^{\frac{(p-1) q}{p}}+1\right)\left|u_{n}^{+}\right| d x+ \\
+ & \int_{M} c_{1}\left(\left|v_{n}\right|^{q-1}+\left|u_{n}\right|^{\frac{(q-1) p}{q}}+1\right)\left|v_{n}^{+}\right|+\left\|z_{n}^{+}\right\|_{E} \tag{18}
\end{align*}
$$

Note that $1<\frac{\mu}{\mu-p+1}<2^{*}$ and $1<\frac{\mu p}{\mu p-(p-1) q}<2^{*}$ by the conditions (ii) and (iv) above $\left(\mathbf{H}_{1}\right)$. We derive

E^{\frac{1}{2}} \hookrightarrow L^{\frac{\mu}{\mu-p+1}}, \quad E^{\frac{1}{2}} \hookrightarrow L^{\frac{\mu p}{\mu p-(p-1) q}}
$$

and therefore

\int_{M}\left|u_{n}\right|^{p-1}\left|u_{n}^{+}\right| d x \leq C\left\|u_{n}\right\|_{\mu}^{p-1}\left\|u_{n}^{+}\right\|_{\frac{1}{2}, 2}  \tag{19}\\
\int_{M}\left|v_{n}\right|^{\frac{(p-1) q}{p}}\left|u_{n}^{+}\right| d x \leq C\left\|v_{n}\right\|_{\mu}^{\frac{(p-1) q}{p}}\left\|u_{n}^{+}\right\|_{\frac{1}{2}, 2} \tag{20}
\end{gather*}
$$

Using the conditions (iii) and (iv) above $\left(\mathbf{H}_{1}\right)$, an analogous reasoning yields

\int_{M}\left|v_{n}\right|^{q-1}\left|v_{n}^{+}\right| d x \leq C\left\|v_{n}\right\|_{\mu}^{q-1}\left\|v_{n}^{+}\right\|_{\frac{1}{2}, 2}  \tag{21}\\
\int_{M}\left|u_{n}\right|^{\frac{(q-1) p}{q}}\left|v_{n}^{+}\right| d x \leq C\left\|u_{n}\right\|_{\mu}^{\frac{(q-1) p}{q}}\left\|v_{n}^{+}\right\|_{\frac{1}{2}, 2} \tag{22}
\end{gather*}
$$

Moreover, it also holds that

\begin{equation*}
\int_{M}\left|u_{n}^{+}\right| d x \leq C\left\|u_{n}^{+}\right\|_{\frac{1}{2}, 2}, \quad \int_{M}\left|v_{n}^{+}\right| d x \leq C\left\|v_{n}^{+}\right\|_{\frac{1}{2}, 2} \tag{23}
\end{equation*}
$$

By (18)-(23), we deduce

\left\|z_{n}^{+}\right\|_{E}^{2} \leq & C\left(\left\|u_{n}\right\|_{\mu}^{p-1}+\left\|v_{n}\right\|_{\mu}^{\frac{(p-1) q}{p}}+1\right)\left\|u_{n}^{+}\right\|_{\frac{1}{2}, 2}+ \\
& +C\left(\left\|v_{n}\right\|_{\mu}^{q-1}+\left\|u_{n}\right\|_{\mu}^{\frac{(q-1) p}{q}}+1\right)\left\|v_{n}^{+}\right\|_{\frac{1}{2}, 2}+\left\|z_{n}^{+}\right\|_{E} \tag{24}
\end{align*}
$$

Hence this and (16) lead to

\left\|z_{n}^{+}\right\|_{E}^{2} & \leq C\left(\left\|z_{n}\right\|_{E}^{\frac{p-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(p-1) q}{\mu_{p}}}+1\right)\left\|z_{n}\right\|_{E}+ \\
& +C\left(\left\|z_{n}\right\|_{E}^{\frac{q-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(q-1) p}{\mu q}}+1\right)\left\|z_{n}\right\|_{E}+\left\|z_{n}\right\|_{E} \tag{25}
\end{align*}
$$

For any $z^{-} \in E_{-}$, then the similar arguments will lead to

$$
\begin{align*}
\left\|z_{n}^{-}\right\|_{E}^{2} & \leq C\left(\left\|z_{n}\right\|_{E}^{\frac{p-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(p-1) q}{\mu_{p}}}+1\right)\left\|z_{n}\right\|_{E}+ \\
& +C\left(\left\|z_{n}\right\|_{E}^{\frac{q-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(q-1) p}{\mu q}}+1\right)\left\|z_{n}\right\|_{E}+\left\|z_{n}\right\|_{E} . \tag{26}
\end{align*}
$$

Adding (25) and (26) yields

$$
\begin{align*}
& \left\|z_{n}\right\|_{E}^{2} \leq C\left(\left\|z_{n}\right\|_{E}^{\frac{p-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(p-1) q}{\mu_{p}}}+1\right)\left\|z_{n}\right\|_{E}+ \\
+ & C\left(\left\|z_{n}\right\|_{E}^{\frac{q-1}{\mu}}+\left\|z_{n}\right\|_{E}^{\frac{(q-1) p}{\mu q}}+1\right)\left\|z_{n}\right\|_{E}+2\left\|z_{n}\right\|_{E} . \tag{27}
\end{align*}
$$

By the assumptions on $p, q, \mu$ above $\left(\mathbf{H}_{1}\right)$, it is easily checked that the total exponent each term in the right-hand side of (27) is less than 2 . It follows that the sequence $\left\{z_{n}\right\}$ is bounded in $E$. Claim is proved.

Passing to a subsequence we may assume that for some $z \in E, z_{n} \rightharpoonup z$ weakly in $E$. From here on a usual argument based on the compactness of $D \mathcal{H}$ and invertibility of $B$ give the existence of a subsequence of $z_{n}=B^{-1}\left(D \mathfrak{L}\left(z_{n}\right)+\right.$ $\left.D \mathcal{H}\left(z_{n}\right)\right)$ that converges $z$ in $E$. So the $(P S)_{c}$-condition is verified.

## 5 Proof of the Theorems

The proof of Theorem 1 is based on an application of the following theorem of Benci and Rabinowtitz[10.

Theorem 3. (Indefinite Functional Theorem). Let $H$ be a real Hilbert space with $H=H_{1} \bigoplus H_{2}$. satisfies the Palais-Smale conditon, and
$\left(I_{1}\right): \mathfrak{L}(z)=\frac{1}{2}(L z, z)-\mathcal{H}(z)$, where $L: H \rightarrow H$ is bounded and self-adjoint, and $L$ leaves $H_{1}$ and $H_{2}$ invariant;
$\left(I_{2}\right): D \mathcal{H}$ is compact;
$\left(I_{3}\right)$ :there exists a subspace $\widetilde{H} \subset H$ and sets $S \subset H, Q \subset \widetilde{H}$ and constants $\alpha>\omega$ such that
(i) : S $\subset H_{1}$ and $\left.\mathfrak{L}\right|_{S} \geq \alpha$,
(ii) : $Q$ is bounded and $\mathfrak{L} \leq \omega$ on the boundary $\partial Q$ of $Q \in \widetilde{H}$;
(iii) : $S$ and $\partial Q$ link.
then $\mathfrak{L}$ possesses a critical value $c \geq \alpha$.
Before giving the geometric conditions for the first linking property, We set $s_{1}, s_{2}, \rho>0$ with $0<\rho<s_{2},\left[0, s_{1} e^{+}\right]=:\left\{s e^{+} \mid 0 \leq s \leq s_{1}\right\}$, and

$$
Q=\left[0, s_{1} e^{+}\right] \oplus\left(\bar{B}_{s_{2}} \cap E_{-}\right), \quad \widetilde{H}=\operatorname{span}\left[e^{+}\right] \oplus E_{-}, \quad S=\partial B_{\rho} \cap E_{+}
$$

where $B_{\rho}$ denotes an open ball with radius $\rho$ centered at the origin, $e^{+}=$ $\left(\xi^{+}, \eta^{+}\right) \in E_{+}$with $\eta^{+}$some eigenspinor of $P$ corresponding to the first positive eigenvalue $\lambda_{1}^{\mathrm{CHI}}$.

Lemma 4. There exists $\rho>0$ and $\alpha>0$ such that

$$
\mathfrak{L}(z) \geq \alpha \quad \forall z \in S
$$

proof: Conditon $\left(H_{1}\right),\left(H_{3}\right)$ and $\left(H_{4}\right)$ imply that for any $\varepsilon>0$ there exists a constant $C(\varepsilon)>0$ such that

$$
\begin{equation*}
H(x, u, v) \leq \varepsilon\left(|u|^{2}+|v|^{2}\right)+C(\varepsilon)\left(|u|^{p}+|v|^{q}\right) \tag{28}
\end{equation*}
$$

for all $(u, v) \in E$, combining (28) and the Sobolev embedding, it is straightforward to show that

$$
\mathfrak{L}\left(z^{+}\right) \geq\left(\frac{1}{2}-C_{4} \varepsilon\right)\left\|z^{+}\right\|_{E}^{2}-C_{5} C(\varepsilon)\left(\left\|z^{+}\right\|_{E}^{p}+\left\|z^{+}\right\|_{E}^{q}\right)
$$

for some constants $C_{4}>0$ and $C_{5}>0$. Thus we can fix $\varepsilon<\frac{1}{2 C_{4}}$ and take enough small $\rho>0, \alpha>0$ such that $\mathfrak{L}\left(z^{+}\right) \geq \alpha$ on $S$.
Lemma 5. There exists $s_{1}, s_{2}, \rho>0$ with $0<\rho<s_{2}$ such that

$$
\mathfrak{L}(z) \leq 0, \quad \forall z \in \partial Q
$$

proof: Note that the boundary $\partial Q$ of the cylinder $Q$ is taken in the space $\widetilde{H}$, and consists of three parts, namely the bottom $Q \cap\{s=0\}$, the lid $Q \cap\left\{s=s_{1}\right\}$, and $\left[0, s_{1} e^{+}\right] \oplus\left(\partial B_{s_{2}} \cap E_{-}\right)$. Clearly $\mathfrak{L}(z) \leq 0$ on the bottom because by $\left(H_{3}\right)$. For the remaining two parts of the boundary we first observe that, for $z=z^{-}+r e^{+} \in \widetilde{H}$,

$$
\begin{equation*}
\mathfrak{L}\left(z^{-}+r e^{+}\right)=\frac{1}{2} r^{2}-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2}-\mathcal{H}\left(z^{-}+r e^{+}\right) . \tag{29}
\end{equation*}
$$

By definition of $E_{+}$we have $\xi^{+}=|P|^{-1} P \eta^{+}=\eta^{+}$, therefore, $e^{+}=\left(\eta^{+}, \eta^{+}\right)$.
We set $z^{-}=\left(u^{-}, v^{-}\right)$, for $z^{-}+r e^{+}=\left(u^{-}+r \eta^{+}, v^{-}+r \eta^{+}\right)$, using (14), we have
$\mathfrak{L}\left(z^{-}+r e^{+}\right) \leq \frac{1}{2} r^{2}-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2}-C_{2} \int_{M}\left|u^{-}+r \eta^{+}\right|^{\mu}-C_{2} \int_{M}\left|v^{-}+r \eta^{+}\right|^{\mu}+C_{3}$.
Thus, writing $v^{-}=t \eta^{+}+\widehat{v}$, where $\eta^{+}$is orthogonal to $\widehat{v}$ in $L^{2}(M, \Sigma M)$. By definition of $E_{ \pm}$we have

u^{-}=-|P|^{-1} P v^{-}=-|P|^{-1} P\left(t \eta^{+}+\widehat{v}\right)=-t \eta^{+}-|P|^{-1} P \widehat{v}
$$

Similarly, $\eta^{+}$is orthogonal to $|P|^{-1} P \widehat{v}$ in $L^{2}(M, \Sigma M)$. By the Hölder's inequality,

(r+t) \int\left|\eta^{+}\right|^{2} d x=\int\left\langle r \eta^{+}+v^{-}, \eta^{+}\right\rangle d x \leq\left\|r \eta^{+}+v^{-}\right\|_{\mu}\left\|\eta^{+}\right\|_{\frac{\mu}{\mu-1}}
$$

which implies

r+t \leq C_{6}\left\|r \eta^{+}+v^{-}\right\|_{\mu} \tag{31}
\end{equation*}
$$

for some constant $C_{6}$ depending on $\eta^{+}$. Similarly, we have

r-t \leq C_{7}\left\|r \eta^{+}+u^{-}\right\|_{\mu} . \tag{32}
\end{equation*}
$$

Therefore, we deduce from (30), (31) and (32) that

\mathfrak{L}\left(z^{-}+r e^{+}\right) \leq \frac{1}{2} r^{2}-C r^{\mu}+C . \tag{33}
\end{equation*}
$$

By $\mu>2$, taking $r=s_{1}$ large enough we see in (33) that $\mathfrak{L}\left(z^{-}+r e^{+}\right)<0$ on the lid $Q \cap\left\{s=s_{1}\right\}$.

For $z^{-}+r e^{+} \in\left[0, s_{1} e^{+}\right] \oplus\left(\partial B_{s_{2}} \cap E_{-}\right)$, we deduce from the condition $\left(H_{3}\right)$ that

\mathfrak{L}\left(z^{-}+r e^{+}\right) \leq \frac{1}{2} r^{2}-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2} .
$$

Taking $\left\|z^{-}\right\|_{E}=s_{2}$ large enough, it holds that

$$
\mathfrak{L}\left(z^{-}+r e^{+}\right) \leq 0 .
$$

The desired result is proved.
Proof of Theorem 1, Let $H=E, H_{1}=E_{+}, H_{2}=E_{-}$, we apply Lemma(3) to the functional $\mathfrak{L}$. The Palais-Smale conditon is satisfied. We can use the standard methods to show that Condition $I_{1}, I_{2}$ and $\mathfrak{L}$ is continuously differentiable. The geometric conditions $I_{3}(i),(i i)$ is proved in Lemma(4) and Lemma(5). For the proof of $\left(I_{3}\right)($ iii) we refer to [10]. Therefore $\mathfrak{L}$ possesses a critical value point $z \in E$ and satisfies $\mathfrak{L}(z) \geq \alpha>0$.

To obtain the theorem 2, we recall the Generalized fountain theorem for semi-definite functionals, see [14] for the detailed exposition.

Theorem 4. (Generalized fountain theorem) Let $X$ be a real Hilbert space with $X=Y \oplus Z$, where $Y$ is closed and seperable, $Z=\bigoplus_{j=0}^{\infty} \mathbb{R} \epsilon_{j} . \mathfrak{L} \in C^{1}(E)$ is an even functional, i.e. $\mathfrak{L}(z)=\mathfrak{L}(-z)$ for all $z \in X$. Assume $\mathfrak{L}$ is $\tau$-upper semicontinuous and $D \mathfrak{L}$ is weakly sequentially continuous. If for every $k \in \mathbb{N}$, there exists $\rho_{k}>r_{k}>0$ such that
$\left(A_{1}\right): a_{k}:=\inf _{\substack{z \in Z_{k} \\\|z\|=r_{k}}} \mathfrak{L}(z) \rightarrow \infty, k \rightarrow \infty ;$
$\left(A_{2}\right): b_{k}:=\sup _{\substack{z \in Y_{k} \\\|z\|=\rho_{k}}} \mathfrak{L}(z) \leq 0$ and $d_{k}:=\sup _{\substack{z \in Y_{k} \\\|z\| \leq \rho_{k}}} \mathfrak{L}(z)<\infty ;$
$\left(A_{3}\right): \mathfrak{L}$ satisfies the Palais-Smale condition;
where

$$
Y_{k}:=Y \oplus\left(\bigoplus_{j=1}^{k} \mathbb{R} \epsilon_{j}\right), \quad Z_{k}:=\overline{\bigoplus_{j=k}^{\infty} \mathbb{R} \epsilon_{j}}
$$

$\left\{\epsilon_{j}\right\}_{j=1}^{\infty}$ is a total orthonormal sequence in $Z$. then $\mathfrak{L}$ has an unbounded sequence of critical values.

We will define the following subsets for giving the geometric conditions of the linking property:

$$
Y_{k}:=E_{-} \oplus\left(\bigoplus_{j=1}^{k} \mathbb{R} e_{j}\right), \quad Z_{k}:=\overline{\bigoplus_{j=k}^{\infty} \mathbb{R} e_{j}}
$$

$B_{k}:=\left\{z \in Y_{k} \mid\|z\|_{E} \leq \rho_{k}\right\}, N_{k}:=\left\{z \in Z_{k} \mid\|z\|_{E}=r_{k}\right\}, \partial B_{k}:=\left\{z \in Y_{k} \mid\|z\|_{E}=\rho_{k}\right\}$, where $0<r_{k}<\rho_{k}, k \geq 2$.

Lemma 6. There exists $\rho_{k}>r_{k}>0$ such that
$\left(A_{1}\right) a_{k}:=\inf _{z \in N_{k}} \mathfrak{L}(z) \rightarrow \infty, k \rightarrow \infty ;$
$\left(A_{2}\right) b_{k}:=\sup _{z \in \partial B_{k}} \mathfrak{L}(z) \leq 0$ and $d_{k}:=\sup _{z \in B_{k}} \mathfrak{L}(z)<\infty$.
Proof: (i) Let $z=(u, v) \in Z_{k}, T=\max \{p, q\}, t=\min \{p, q\}$, Then by (28), which implies that

\mathfrak{L}(z) & =\frac{1}{2}\|z\|_{E}^{2}-\int_{M} H(x, z) d x \\
& \geq \frac{1}{2}\|z\|_{E}^{2}-\varepsilon\left(\|u\|_{2}^{2}+\|v\|_{2}^{2}\right)-C(\varepsilon)\left(\|u\|_{p}^{p}+\|v\|_{q}^{q}\right) \\
& \geq\left(\frac{1}{2}-C_{8} \varepsilon\right)\|z\|_{E}^{2}-C_{9} C(\varepsilon)\left(\|z\|_{E}^{p}+\|z\|_{E}^{q}\right) \tag{34}
\end{align*}
$$

where $C_{8}, C_{9}$ is constants. Choosing $\varepsilon=\frac{1}{4 C_{8}}$, for $0<\alpha_{k} \leq 1$ and $\|z\|_{E} \geq 1$, we obtain from (34) that

\mathfrak{L}(z) & \geq \frac{1}{4}\|z\|_{E}^{2}-C(\varepsilon) C_{9} C_{10} \alpha_{k}^{p}\|z\|_{E}^{p}-C(\varepsilon) C_{9} C_{10} \alpha_{k}^{q}\|z\|_{E}^{q} \\
& \geq \frac{1}{4}\|z\|_{E}^{2}-2 C(\varepsilon) C_{9} C_{10} \alpha_{k}^{t}\|z\|_{E}^{T} \tag{35}
\end{align*}
$$

Then we have for $\|z\|_{E}=r_{k}:=\left(4 T C(\varepsilon) C_{9} C_{10} \alpha_{k}^{t}\right)^{\frac{1}{2-T}}$,

$$
\mathfrak{L}(z) \geq\left(\frac{1}{4}-\frac{1}{2 T}\right)\left(4 T C(\varepsilon) C_{9} C_{10} \alpha_{k}^{t}\right)^{\frac{2}{2-T}}
$$

We know by lemma 3.8 in [33] that $\alpha_{k} \rightarrow 0$ as $k \rightarrow \infty$, so $\mathfrak{L}(z) \rightarrow \infty$ as $k \rightarrow \infty$, and condition $\left(A_{1}\right)$ is satisfied.
(ii) Let $z=z^{-}+w^{+} \in Y_{k}$, where $z^{-}=\left(z_{1}^{-}, z_{2}^{-}\right) \in E_{-}, w^{+}=\left(w_{1}^{+}, w_{2}^{+}\right) \in$ $\bigoplus_{j=1}^{k} \mathbb{R} e_{j}$. The condition $\left(H_{2}\right)$ and $\left(H_{4}\right)$ implies that for every $\delta>0$ there exists a constant $C(\delta)>0$ such that

$$
H\left(x, z_{1}^{-}+w_{1}^{+}, z_{2}^{-}+w_{2}^{+}\right) \geq \delta\left(\left|z_{1}^{-}+w_{1}^{+}\right|^{2}+\left|z_{2}^{-}+w_{2}^{+}\right|^{2}\right)-C(\delta)
$$

Since $E_{+}$is orthogonal to $E_{-}$in $L^{2}(M, \Sigma M \oplus \Sigma M)$, we deduce

$$
\begin{align*}
& -\int_{M} H\left(x, z_{1}^{-}+w_{1}^{+}, z_{2}^{-}+w_{2}^{+}\right) d x \leq-\delta\left(\left\|z_{1}^{-}+w_{1}^{+}\right\|_{2}^{2}+\left\|z_{2}^{-}+w_{2}^{+}\right\|_{2}^{2}\right)+C(\delta)|M| \\
& \leq-\delta\left(\left\|z_{1}^{-}\right\|_{2}^{2}+\left\|w_{1}^{+}\right\|_{2}^{2}+\left\|z_{2}^{-}\right\|_{2}^{2}+\left\|w_{2}^{+}\right\|_{2}^{2}\right)+C(\delta)|M| \\
& \leq-\delta\left(\left\|w_{1}^{+}\right\|_{2}^{2}+\left\|w_{2}^{+}\right\|_{2}^{2}\right)+C(\delta)|M| \tag{36}
\end{align*}
$$

All norms are equavalent on the space $\bigoplus_{j=1}^{k} \mathbb{R} e_{j}$, there exists a constant $C>0$ such that

$$
C\left\|w^{+}\right\|_{E}^{2} \leq\left\|w^{+}\right\|_{L^{2} \times L^{2}}^{2}=\left\|w_{1}^{+}\right\|_{2}^{2}+\left\|w_{2}^{+}\right\|_{2}^{2}
$$

Combining (8) with (36) yields

$$
\begin{align*}
\mathfrak{L}(z) & =-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2}+\frac{1}{2}\left\|w^{+}\right\|_{E}^{2}-\int_{M} H(x, z) d x \\
& \leq-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2}+\frac{1}{2}\left\|w^{+}\right\|_{E}^{2}-\delta\left(\left\|w_{1}^{+}\right\|_{2}^{2}+\left\|w_{2}^{+}\right\|_{2}^{2}\right)+C(\delta)|M| \\
& \leq-\frac{1}{2}\left\|z^{-}\right\|_{E}^{2}+\frac{1}{2}\left\|w^{+}\right\|_{E}^{2}-C(\delta)\left\|w^{+}\right\|_{E}^{2}+C(\delta)|M| \tag{37}
\end{align*}
$$

Takeing $\delta>\frac{1}{2 C}$, this shows that $\mathfrak{L}(z) \rightarrow-\infty$ as $\|z\|_{E} \rightarrow \infty$, so $\left(A_{2}\right)$ is satisfied for $\rho_{k}$ large enough. The desired result is proved.

Let $\Pi_{-}: E \rightarrow E_{-}$and $\Pi_{+}: E \rightarrow E_{+}$be the orthogonal projections, $\left\{\theta_{j}\right\}_{j=1}^{\infty}$ be an orthonormal basis of $E_{-}$. On $E$ we consider a new norm

||||z||||:=\max \left(\sum_{j=0}^{\infty} \frac{1}{2^{j+1}}\left|\left(\Pi_{-} z, \theta_{j}\right)\right|,\left\|\Pi_{+} z\right\|_{E}\right)
$$

We use the $\tau$-topology is generated by the norm |||| $\cdot|||\mid$ (see[27] or [33]). It is clear that $\left\|\Pi_{+} z\right\|_{E} \leq\| \| z\| \| \leq\|z\|_{E}$. Moreover, if $\left\{z_{n}\right\}$ is a bounded sequence in $E$ then

z_{n} \xrightarrow{\tau} z \Leftrightarrow \Pi_{-} z_{n} \rightharpoonup \Pi_{-} z \text { and } \Pi_{+} z_{n} \rightarrow \Pi_{+} z
$$

Let $\mathfrak{L} \in C^{1}(E)$, recall that $\mathfrak{L}$ is $\tau$-upper semicontinous if $z_{n} \xrightarrow{\tau} z$ implies $\mathfrak{L}(z) \geq \lim _{n \rightarrow \infty} \mathfrak{L}\left(z_{n}\right)$.

Lemma 7. Under assumption $\left(H_{1}\right)$ and $\left(H_{3}\right), \mathfrak{L}$ is $\tau$ - upper semicontinuous and $D \mathfrak{L}$ is weakly sequentially continuous.
Proof:(i) Assume $z_{n} \in E$ such that $z_{n} \xrightarrow{\tau} z$ and $\mathfrak{L}\left(z_{n}\right) \geq c$. By the definition of $\tau$ we obtain $\Pi_{+} z_{n} \rightarrow \Pi_{+} z$. Noting that $\mathfrak{L}\left(z_{n}\right) \geq c$ and $H \geq 0$, then $\Pi_{-} z_{n}$ is bounded and $\Pi_{-} z_{n} \rightharpoonup \Pi_{-} z$. Now since the embedding $E \hookrightarrow L^{p} \times L^{q}$ is compact, then $z_{n} \rightarrow z$ in $L^{p} \times L^{q}$. Thus up to a subsequence $z_{n} \rightarrow z$ a.e. on $M$, and by $H \in C^{0}(\Sigma M \oplus \Sigma M, \mathbb{R})$ is $C^{1}$ in the fiber direction, we obtain $H\left(x, z_{n}\right) \rightarrow H(x, z)$ a.e. on $M$. Using the Fatou lemma and the weak lower semicontinuity of the norm $\|\cdot\|_{E}$ that $\mathfrak{L}(z) \geq \varlimsup_{n \rightarrow \infty} \mathfrak{L}\left(z_{n}\right) \geq c$. Therefore, $\mathfrak{L}$ is $\tau$-upper semicontinuous.
(ii) Assumen $\left(u_{n}, v_{n}\right) \in E$ such that $\left(u_{n}, v_{n}\right) \rightharpoonup(u, v)$, then by Rellich's theorem $u_{n} \rightarrow u$ in $L^{p}(M, \Sigma M)$ and $v_{n} \rightarrow v$ in $L^{q}(M, \Sigma M)$. then by the Hölder inequality we have

& \left|D \mathfrak{L}\left(u_{n}, v_{n}\right)(\xi, \zeta)-D \mathfrak{L}(u, v)(\xi, \zeta)\right| \leq \\
\leq & \int_{M}\left|\xi\left\|H_{u}\left(x, u_{n}, v_{n}\right)-H_{u}(x, u, v)\left|d x+\int_{M}\right| \zeta\right\| H_{v}\left(x, u_{n}, v_{n}\right)-H_{v}(x, u, v)\right| d x \\
\leq & \|\xi\|_{p}\left\|H_{u}\left(x, u_{n}, v_{n}\right)-H_{u}(x, u, v)\right\|_{\frac{p}{p-1}}+\|\zeta\|_{q}\left\|H_{v}\left(x, u_{n}, v_{n}\right)-H_{v}(x, u, v)\right\|_{\frac{q}{q-1}}
\end{aligned}
$$

It follows from

$$
L^{p}(M, \Sigma M) \times L^{q}(M, \Sigma M) \rightarrow L^{\frac{p}{p-1}}(M, \Sigma M)
$$

and

$$
L^{p}(M, \Sigma M) \times L^{q}(M, \Sigma M) \rightarrow L^{\frac{q}{q-1}}(M, \Sigma M)
$$

are continuous by $\left(H_{1}\right)$ that

$$
D \mathfrak{L}\left(u_{n}, v_{n}\right)(\xi, \zeta) \rightarrow D \mathfrak{L}(u, v)(\xi, \zeta) \quad \text { as } n \rightarrow \infty
$$

This shows that $D \mathfrak{L}$ is weakly sequentially continuous.
Now we use Theorem 4 to obtain infinitely many critical points of the even functional $\mathfrak{L}$ in Theorem 2 ,

Proof of Theorem 2 We know by Lemma 3 that $\mathfrak{L}$ satisfies the PalaisSmale condition, Lemma 6 gives the geometric conditions $A_{1}$ and $A_{2}$ of the linking geometry. Lemma 7 implies $\mathfrak{L}$ is $\tau$ - upper semicontinuous and $D \mathfrak{L}$ is weakly sequentially continuous. Then $\mathfrak{L}$ has an unbounded sequence of critical values.
