# ADDITIONAL NUMERICAL AND GRAPHICAL EVIDENCE TO SUPPORT SOME CONJECTURES ON DISCRETE SCHRÖDINGER OPERATORS WITH A MORE GENERAL LONG RANGE CONDITION 

SYLVAIN GOLÉNIA AND MARC-ADRIEN MANDICH


#### Abstract

This document contains additional numerical and graphical evidence to support some of the conjectures mentioned in [GM3]. We give more evidence for $\kappa=3,4$ in dimension 2. As mentioned in that article we still don't quite understand the sets $\boldsymbol{\mu}_{\kappa}(\Delta)$ and $\boldsymbol{\Theta}_{\kappa}(\Delta)$ on $(0,1 / 2)$ for $\kappa=3$ in dimension 2. Here we give a bunch more threshold energies for $\kappa=3$ in dimension 2.

## 1. Introduction

The notation in this document is $100 \%$ consistent with that of [GM3]. We start by listing the 2 Conjectures of [GM3] for which the material presented in this document is relevant. The first has to do with the rate of convergence of the thresholds $\mathcal{E}_{n} \in J_{2}=J_{2}(\kappa):=(2 \cos (\pi / \kappa), 1+\cos (\pi / \kappa))$.

Conjecture 1.1. Let $\left\{\mathcal{E}_{n}\right\}$ be the sequence in [GM3, Theorem 1.7]. Then $\mathcal{E}_{n}-\inf J_{2}=c(\kappa) / n^{2}+$ $o\left(1 / n^{2}\right), \forall \kappa \geq 3$, where $c(\kappa)$ means a constant depending on $\kappa$.

For this conjecture, see section 2 . The second conjecture has to do with the existence of a conjugate operator giving a strict Mourre estimate on bands $\left(\mathcal{E}_{n}, \mathcal{E}_{n-1}\right) \subset J_{2}$.

[^0]Conjecture 1.2. Fix $\kappa \geq 2$. Let $\left\{\mathcal{E}_{n}\right\}$ be the sequence in [GM3, Theorem 1.7]. For each interval $\left(\mathcal{E}_{n}, \mathcal{E}_{n-1}\right), n \geq 1, \exists$ a conjugate operator $\mathbb{A}(n)=\sum_{q=1}^{N(n)} \rho_{j_{q} \kappa}(n) A_{j_{q} \kappa}, A_{j_{q} \kappa}=\sum_{1 \leq i \leq 2} A_{i}\left(j_{q}, \kappa\right)$, such that the Mourre estimate for $\Delta$ holds wrt. $\mathbb{A}(n), \forall E \in\left(\mathcal{E}_{n}, \mathcal{E}_{n-1}\right)$. $\mathbb{A}(n)$ is typically not unique. It can be chosen so that $N(n)=2 n$. In particular, $\left\{\mathcal{E}_{n}\right\}=J_{2} \cap \boldsymbol{\Theta}_{\kappa}(\Delta), \forall \kappa \geq 2$.

For this conjecture, see sections 5, 6, 7 and 8. Section 4 lists some thresholds $\in \boldsymbol{\Theta}_{m=1, \kappa=4}(\Delta)$ in dimension 2, and section 9 gives a graphical illustration of some thresholds $\in \boldsymbol{\Theta}_{m, \kappa=3}(\Delta) \cap(0,1 / 2)$ in dimension $2, m \geq 1$.

## 2. More evidence for the conjecture on the rate of convergence of $\mathcal{E}_{n}$

Figure 1 illustrates solutions $\mathcal{E}_{2 n}(\kappa)$ of [GM3, Proposition 7.2] for $\kappa=5,6,8$. In these graphs the slope of the orange trend line is close to -2 , and this is our rationale behind [GM3, Conjecture 1.9].


Figure 1. Graphs with $\log (n)$ on $x$-axis and $\log \left(\mathcal{E}_{2 n}(\kappa)-2 \cos (\pi / \kappa)\right)$ on $y$-axis. Left : $\kappa=5$; Middle : $\kappa=6$, Right : $\kappa=8$. Green dots are $1 \leq n \leq 400$ ; black dots are $n=400,800,1200, \ldots, 4800$. Orange line is trend line based on linear regression of black dots.

## 3. Energy solutions in $J_{2}(\kappa):=(2 \cos (\pi / \kappa), 1+\cos (\pi / \kappa))$

Table 1 below lists the first few energy solutions for $\kappa \in\{2,3,4\}$ in [GM3, Theorem 1.7]. In particular we have some exact expressions for $\kappa=4$.

4. Thresholds in dimension 2 , for $\kappa=4, m=1$ (THE BRUTE FORCE APPROACH)

In [GM3, subsection 4.2], we listed Ansatzes $(1)-(6)$ to find threshold solutions $\in \boldsymbol{\Theta}_{1, \kappa}(\Delta)$, and in [GM3, Lemma 4.2] we listed those solutions for $\kappa=3$. Table 2 below lists the corresponding solutions for $\kappa=4$. We recall that these solutions belong to $\Theta_{1, \kappa=4}(\Delta)$, but it is an open question for us if they constitute all of $\Theta_{1, \kappa=4}(\Delta)$.

5. Polynomial Interpolation for the case $\kappa=2$ in dimension $2,5 \leq n \leq 9$

In [GM3, section 13] we gave numerical evidence of bands of a.c. spectrum for bands $n=$ $1,2,3,4$, for $\kappa=2$ in dimension 2 . We briefly mention that :

- For the 5 th band, we checked that $\Sigma=[2,4,6,8,10,12,14,16, \alpha, \beta]$ is also valid for $(\alpha, \beta)=$ $(18,20),(20,24),(22,24),(24,28),(24,32),(28,32)$ whereas it is not valid for $(\alpha, \beta)=(18,24)$, $(18,26),(18,28)$.
- For the 6 th band we checked that $\Sigma=[2,4,6,8,10,12,14,16,18,20, \alpha, \beta]$ is valid for $(\alpha, \beta)=$ $(22,28),(22,30)$ but not valid for $(\alpha, \beta)=(22,24),(22,26)$.
- For the 7 th band we checked that $\Sigma=[2,4,6,8,10,12,14,16,18,20,22,24, \alpha, \beta]$ is valid for $(\alpha, \beta)=(26,28)$ but not valid for $(\alpha, \beta)=(28,36)$.
- For the 8 th band we checked that $\Sigma=[2,4,6,8,10,12,14,16,18,20,22,24,26,28, \alpha, \beta]$ is valid for $(\alpha, \beta)=(30,38),(30,40)$ but not valid for $(\alpha, \beta)=(30,32),(30,36)$.
- For the 9 th band we checked $\Sigma=[2,4,6,8,10,12,14,16,18,20,22,24,26,28,30,32,34,36]$ is valid.


## 6. Polynomial Interpolation for the case $\kappa=3$ in dimension $2, n=5$

In [GM3, section 14] we gave numerical evidence of bands of a.c. spectrum for bands $n=$ $1,2,3,4$, for $\kappa=3$ in dimension 2 . We briefly give the numerical details for $n=5$, i.e. the $5^{t h}$ band. $X_{3}=\mathcal{E}_{5} / 2$ and

Using Python's $f$ solve we get $\left[\mathcal{E}_{5}, X_{1}, X_{2}\right] \simeq[1.112,0.307,0.441]$. For an analytical solution or perhaps more precise, expand the equations and get rid of the $X_{1}^{2}$ and $X_{2}^{2}$ terms. One ends up with $4\left(9 \mathcal{E}_{5}^{2} / 4-4 \mathcal{E}_{5} X_{1}+X_{1} X_{2}-3 \mathcal{E}_{5}+1+5 \mathcal{E}_{5} X_{2} / 2+X_{1}\right)=3$. Then use the fact that

$$
X_{1}=-\frac{1}{2}+\frac{3 \mathcal{E}_{5}}{2}-\frac{\sqrt{3}}{2} \sqrt{\mathcal{E}_{5}\left(2-\mathcal{E}_{5}\right)}, \quad X_{2}=-\frac{\mathcal{E}_{5}}{4}+\frac{\sqrt{3}}{4} \sqrt{4-\mathcal{E}_{5}^{2}}
$$

(signs are chosen based on numerical solution). We get an equation in $\mathcal{E}_{5}$ only, which is

0= & -\left(35 \mathcal{E}_{5}^{2}\right) / 8+\left(3 \mathcal{E}_{5}-\sqrt{3} \sqrt{\left(2-\mathcal{E}_{5}\right) \mathcal{E}_{5}}-1\right)\left((1 / 8) \sqrt{3} \sqrt{4-\mathcal{E}_{5}^{2}}-\mathcal{E}_{5} / 8\right) \\
& +(5 / 8) \sqrt{3} \mathcal{E}_{5} \sqrt{4-\mathcal{E}_{5}^{2}}+2 \sqrt{3} \mathcal{E}_{5} \sqrt{\left(2-\mathcal{E}_{5}\right) \mathcal{E}_{5}}+\mathcal{E}_{5} / 2-1 / 2 \sqrt{3} \sqrt{\left(2-\mathcal{E}_{5}\right) \mathcal{E}_{5}}-1 / 4
\end{aligned}
$$

$\mathcal{E}_{5}$ is a root of
$m p(E)=372775 E^{8}-750010 E^{7}+536359 E^{6}-270784 E^{5}+128593 E^{4}-36442 E^{3}+4333 E^{2}-220 E+4$.
and we suspect it's its minimal polynomial. $\mathcal{E}_{5} \simeq 1.11207$. We are not aware of a closed formula for $\mathcal{E}_{5}$. It follows that $X_{1} \simeq 0.30753, X_{2} \simeq 0.44178, X_{3} \simeq 0.55603, X_{4} \simeq 0.67028, X_{5} \simeq 0.80453$.

Next we suppose $\Sigma=[3,6,9,12,15,18,21,24,27,30]$. We fill the matrix $M$ with floats. Python says the solution to $M \rho=0$ is $\left[\rho_{3}, \rho_{6}, \rho_{9}, \rho_{12}, \rho_{15}, \rho_{18}, \rho_{21}, \rho_{24}, \rho_{27}, \rho_{30}\right]^{T}$ equals

\simeq[1,1.599931,1.645307,1.27734,0.77838,0.37292,0.13741,0.03703,0.00657,0.00058]^{T} .
$$

Graphically it seems $x \mapsto G_{\kappa}^{E}(x)>0$ for $E \in\left(\mathcal{E}_{5}, \mathcal{E}_{4}\right), x \in[E-1,1]$. So $\Sigma$ is valid.

## 7. Polynomial Interpolation for the case $\kappa=4$ in dimension $2,1 \leq n \leq 6$

This section is the analogue of [GM3, section 13] and [GM3, section 14], but for $\kappa=4$.
First we note that

T_{4}(x)=8 x^{4}-8 x^{2}+1 \quad \text { and } \quad T_{4}(x)=T_{4}(y) \Leftrightarrow 8(x-y)(x+y)\left[x^{2}+y^{2}-1\right]=0 \tag{7.1}
\end{equation*}
$$

Let $\mathcal{E}_{n}$ be the energy solutions of [GM3, Proposition 7.1] and [GM3, Proposition 7.2], for $\kappa=4$. We have : $\mathcal{E}_{n} \in J_{2}(\kappa=4)=(2 \cos (\pi / 4), 1+\cos (\pi / 4))=(\sqrt{2}, 1+\sqrt{2} / 2)$, and

$$
\mathcal{E}_{n}-1=X_{0}<X_{1}<X_{2}<\ldots<X_{n}<X_{n+1}:=1
$$

7.1. $n=1: 1$ st band. On the left, $\mathcal{E}_{1}=8 / 5, X_{1}=4 / 5$. On the right, $\mathcal{E}_{0}=1+\cos \left(\frac{\pi}{4}\right)=1+\frac{\sqrt{2}}{2}$. We choose $\Sigma=[4,8]$ and get $\rho=\left[\rho_{4}, \rho_{8}\right]^{T}=[1,625 / 1054]^{T}$. The function $x \mapsto G_{\kappa}^{E}(x)$ is strictly positive for $E \in\left(\mathcal{E}_{1}, \mathcal{E}_{0}\right), x \in[E-1,1]$.


Figure 2. $G_{\kappa=4}^{E}(x) . \quad x \in[E-1,1]$. From left to right: $E=\mathcal{E}_{1}, E=1.65$, $E=\mathcal{E}_{0} . G_{\kappa=4}^{E}(x)>0$ in the middle picture, but not in the other two.
7.2. $n=2: 2 n d$ band. $X_{1}=\sqrt{2} / 2$. Then we solve $T_{4}\left(\mathcal{E}_{2}-1\right)=T_{4}\left(\mathcal{E}_{2}-\sqrt{2} / 2\right)$ which has 2 solutions $\mathcal{E}_{2}=(2+\sqrt{2} \pm \sqrt{2+4 \sqrt{2}}) / 4$. Using the context, it must be that

$$
\begin{equation*}
\mathcal{E}_{2}=\frac{2+\sqrt{2}+\sqrt{2+4 \sqrt{2}}}{4} \simeq 1.54532 . \tag{7.2}
\end{equation*}
$$

It follows that $X_{2}=\mathcal{E}_{2}-X_{1}=(2-\sqrt{2}+\sqrt{2+4 \sqrt{2}}) / 4$. We suppose $\Sigma=[4,8,12,24]$. The solution to $M \rho=0$ is $\left[\rho_{4}, \rho_{8}, \rho_{12}, \rho_{24}\right]^{T} \simeq[1,0.81070,0.21647,-0.06593]^{T}$. The function $x \mapsto G_{\kappa}^{E}(x)$ is plotted in Figure 3 for some values $E \in\left[\mathcal{E}_{2}, \mathcal{E}_{1}\right]$.


Figure 3. $G_{\kappa=4}^{E}(x) . x \in[E-1,1]$. From left to right: $E=\mathcal{E}_{2}, E=1.57$, $E=\mathcal{E}_{1} . G_{\kappa=4}^{E}(x)>0$ in the middle picture, but not in the other two.

Moreover it would appear that the combinations $\Sigma=[4,8,12,28],[4,8,12,32],[4,8,16,24]$ are equally valid, whereas $\Sigma=[4,8,12,16],[4,8,12,20],[4,8,16,20]$ are not valid. The linear dependency between rows of $M$ seems to rely (at least partly) on the relations

$$
U_{4 j-1}(1 / \sqrt{2})=0, \quad \text { and } \quad U_{4 j-1}(\sqrt{2} / \sqrt{3})=-\sqrt{2} U_{4 j-1}(1 / \sqrt{3}), \quad j \in \mathbb{N}^{*}
$$

7.3. $n=3: 3 r d$ band. $X_{2}=\mathcal{E}_{3} / 2$ and $T_{4}\left(\mathcal{E}_{3}-1\right)=T_{4}\left(\mathcal{E}_{3}-X_{1}\right), T_{4}\left(X_{1}\right)=T_{4}\left(\mathcal{E}_{3} / 2\right)$. Taking the context into account and applying (7.1) leads to $\left(\mathcal{E}_{3}-1\right)^{2}+\left(\mathcal{E}_{3}-X_{1}\right)^{2}=1$ and $X_{1}^{2}+\mathcal{E}_{3}^{2} / 4=1$. So

$$
\begin{equation*}
\mathcal{E}_{3}=\frac{28}{65}+\frac{2}{65 t}+\frac{1}{2} \sqrt{\frac{4256}{12675}+\frac{368}{195 s}-\frac{16}{195} s+\frac{121088 t}{4225}} \simeq 1.51271, \quad t:=\sqrt{\frac{3}{133-\frac{1495}{s}+65 s}} \tag{7.3}
\end{equation*}
$$

and $s:=(629+48 \sqrt{177})^{1 / 3}$. The minimal polynomial for $\mathcal{E}_{3}$ is $m p(E)=65 E^{4}-112 E^{3}+56 E^{2}-$ $64 E+16$. Also $X_{1} \simeq 0.65415, X_{2} \simeq 0.75635$. We choose the combination $\Sigma=[4,8,12,16,24,36]$. The solution to $M \rho=0$ is

$$
\left[\rho_{4}, \rho_{8}, \rho_{12}, \rho_{16}, \rho_{24}, \rho_{36}\right]^{T} \simeq[1,1.18290,0.68875,0.18594,-0.00794,-0.00288]^{T} .
$$

The function $G_{\kappa}^{E}(x)$ is plotted in Figure 4 for some values $E \in\left[\mathcal{E}_{3}, \mathcal{E}_{2}\right]$. The linear dependency between rows of $M$ seems to rely (at least partly) on the relation

$$
\left[U_{4 j-1}(x), U_{4 l-1}\left(\sqrt{1-x^{2}}\right)\right]=0, \quad \forall j, l \in \mathbb{N}^{*},
$$

where $[\cdot, \cdot]$ is the Bezoutian defined by [GM3, (2.3) of section 2].


Figure 4. $G_{\kappa=4}^{E}(x) . \quad x \in[E-1,1]$. From left to right: $E=\mathcal{E}_{3}, E=1.525$, $E=\mathcal{E}_{2} . G_{\kappa=4}^{E}(x)>0$ in the middle picture, but not in the other two.

The combination $\Sigma=[4,8,12,16,20,24]$ is equally valid and it gives

$$
\left[\rho_{4}, \rho_{8}, \rho_{12}, \rho_{16}, \rho_{20}, \rho_{24}\right]^{T} \simeq[1,1.37002,1.06973,0.53992,0.16964,0.02655]^{T} .
$$

7.4. $n=4: 4$ th band. $X_{2}=\sqrt{2} / 2$. Then we have to solve $\left(\mathcal{E}_{4}-1\right)^{2}+\left(\mathcal{E}_{4}-X_{1}\right)^{2}=1$, $X_{1}^{2}+\left(\mathcal{E}_{4}-\sqrt{2} / 2\right)^{2}=1$. This leads to $1-\left(\mathcal{E}_{4}-\sqrt{2} / 2\right)^{2}=\left(\mathcal{E}_{4}-\sqrt{\mathcal{E}_{4}\left(2-\mathcal{E}_{4}\right)}\right)^{2}$. Thus $\mathcal{E}_{4}$ is the root of

$$
m p(E)=5 E^{4}-(2 \sqrt{2}+4) E^{3}+(5-4 \sqrt{2}) E^{2}+(\sqrt{2}-2) E+1 / 4=0 .
$$

The closed form formula of $\mathcal{E}_{4}$ is horrendous; but $\mathcal{E}_{4} \simeq 1.49137$. In turn, $X_{1} \simeq 0.62042$.
The simplest valid combination of indices we have found is $\Sigma=[4,8,12,16,20,24,28,52]$. The solution to $M \rho=0$ is $\rho=\left[\rho_{4}, \rho_{8}, \rho_{12}, \rho_{16}, \rho_{20}, \rho_{24}, \rho_{28}, \rho_{52}\right]^{T} \simeq$

$$
[1,1.46864,1.29941,0.80098,0.34657,0.09808,0.01417,0.000030]^{T}
$$

Graphically $x \mapsto G_{\kappa}^{E}(x)$ is strictly positive for $E \in\left(\mathcal{E}_{4}, \mathcal{E}_{3}\right), x \in[E-1,1]$.
7.5. $n=5$ : 5 th band. We have $X_{3}=\mathcal{E}_{5} / 2,\left(\mathcal{E}_{5}-1\right)^{2}+\left(\mathcal{E}_{5}-X_{1}\right)^{2}=1, X_{1}^{2}+\left(\mathcal{E}_{5}-X_{2}\right)^{2}=1$, and $X_{2}^{2}+\left(\mathcal{E}_{5} / 2\right)^{2}=1$. This leads to $1-\left(\mathcal{E}_{5}-\left(1-\mathcal{E}_{5}^{2} / 4\right)^{1 / 2}\right)^{2}=\left(\mathcal{E}_{5}-\mathcal{E}_{5}^{1 / 2}\left(2-\mathcal{E}_{5}\right)^{1 / 2}\right)^{2}$. The solution is

$$
\begin{equation*}
\mathcal{E}_{5}=\frac{16}{1275}\left(42+\frac{w}{3^{2 / 3}}-\frac{32533 w^{-1}}{3^{1 / 3}}\right) \simeq 1.47650, \quad w:=(13025367+208250 \sqrt{6294})^{1 / 3} \tag{7.4}
\end{equation*}
$$

and its minimal polynomial is $m p(E)=-32768+22784 E-6048 E^{2}+3825 E^{3}$. In turn $X_{1} \simeq$ $0.59734, X_{2} \simeq 0.67452, X_{3} \simeq 0.73825, X_{4} \simeq 0.80198$ and $X_{5} \simeq 0.87916$. We choose $\Sigma=$ $[4,8,12,16,20,24,28,32,36,40] . M \rho=0$ gives $\left[\rho_{4}, \rho_{8}, \rho_{12}, \rho_{16}, \rho_{20}, \rho_{24}, \rho_{28}, \rho_{32}, \rho_{36}, \rho_{40}\right]^{T} \simeq$
$[1,1.58691,1.60962,1.22543,0.72779,0.33759,0.11956,0.03071,0.00514,0.00042]^{T}$.
It appears graphically that $x \mapsto G_{\kappa}^{E}(x)$ is strictly positive for $E \in\left(\mathcal{E}_{5}, \mathcal{E}_{4}\right), x \in[E-1,1]$.
7.6. $n=6$ : 6th band. $X_{3}=\sqrt{2} / 2,\left(\mathcal{E}_{6}-1\right)^{2}+\left(\mathcal{E}_{6}-X_{1}\right)^{2}=1, X_{1}^{2}+\left(\mathcal{E}_{6}-X_{2}\right)^{2}=1$ and $X_{2}^{2}+\left(\mathcal{E}_{6}-\sqrt{2} / 2\right)^{2}=1$. Performing elementary operations shows that $\mathcal{E}_{6} \simeq 1.46568$ is a root of the polynomial
$m p(E)=384 E^{6}+(-448-224 \sqrt{2}) E^{5}+(200+128 \sqrt{2}) E^{4}+(-72-52 \sqrt{2}) E^{3}+(16+12 \sqrt{2}) E^{2}+(-2-\sqrt{2}) E+1 / 8$.

In turn $X_{1} \simeq 0.58072, X_{2} \simeq 0.65158, X_{3} \simeq 0.70710, X_{4} \simeq 0.75857, X_{5} \simeq 0.81409, X_{6} \simeq 0.88495$.

## 8. Application of Polynomial Interpolation for the first band ( $n=1$ ), $2 \leq \kappa \leq 9$

This section is about the first band $(n=1)$ in the interval $J_{2}(\kappa)$. For the 1 st band we suppose only 2 terms in the linear combination [GM3, (1.6) of Introduction] are required. In other words, we suppose $\Sigma=\left[j_{1} \kappa, j_{2} \kappa\right]$. According to [GM3, section 12] we look to solve the system

$$
\begin{cases}g_{j_{1} \kappa}^{\mathcal{E}_{1}}(x)+\rho_{j_{2} \kappa} \cdot g_{j_{2} \kappa}^{\mathcal{E}_{1}}(x)=0, & \text { at } x=X_{0}=\mathcal{E}_{1}-1,  \tag{8.1}\\ g_{j_{1} \kappa}^{\mathcal{E}_{1}}(x)+\rho_{j_{2} \kappa} \cdot g_{j_{2} \kappa}^{\mathcal{E}_{1}}(x)=0, & \text { at } x=X_{1}, \\ \frac{d}{d x} g_{j_{1} \kappa}^{\mathcal{E}_{1}}(x)+\rho_{j_{2} \kappa} \cdot \frac{d}{d x} g_{j_{2} \kappa}^{\mathcal{E}_{1}}(x)=0, & \text { at } x=X_{1}, \\ g_{j_{1} \kappa}^{\mathcal{E}_{0}}(x)+\rho_{j_{2} \kappa} \cdot g_{j_{2} \kappa}^{\mathcal{E}_{0}}(x)=0, & \text { at } \mathcal{E}_{0}=1+\cos (\pi / \kappa), x=\mathcal{E}_{0}-1 .\end{cases}
$$

Note we are assuming $\rho_{j_{1} \kappa}=1$. By [GM3, Remark 5.2], $X_{1}=\mathcal{E}_{1} / 2$. So the $3 r d$ line of (8.1) is trivially true, by [GM3, Lemma 3.4]. The 4 th line is also always true, by [GM3, Lemma 1.4]. Assuming $\mathcal{E}_{1} \neq 0, \pm 2$, the system (8.1) is equivalent to

$$
\left\{\begin{array}{l}
{\left[U_{j_{1} \kappa-1}\left(\mathcal{E}_{1}-1\right), U_{j_{2} \kappa-1}\left(\mathcal{E}_{1} / 2\right)\right]=0,}  \tag{8.2}\\
X_{1}=\mathcal{E}_{1} / 2 \\
\rho_{j_{2} \kappa}=-U_{j_{1} \kappa-1}\left(\mathcal{E}_{1}-1\right) / U_{j_{2} \kappa-1}\left(\mathcal{E}_{1}-1\right)=-U_{j_{1} \kappa-1}\left(\mathcal{E}_{1} / 2\right) / U_{j_{2} \kappa-1}\left(\mathcal{E}_{1} / 2\right)
\end{array}\right.
$$

Let $X_{2}:=1, X_{0}=\mathcal{E}_{1}-X_{2}=\mathcal{E}_{1}-1$. From the $3 r d$ line of (8.2) we see that we want $U_{j \kappa-1}\left(X_{0}\right) \neq 0$ and $U_{j \kappa-1}\left(X_{1}\right) \neq 0$, in particular $U_{\kappa-1}\left(X_{0}\right), U_{\kappa-1}\left(X_{1}\right) \neq 0$. Thus, by [GM3, Corollary 2.3] we see that (8.2) is equivalent to

$$
\left\{\begin{array}{l}
X_{2}=1  \tag{8.3}\\
X_{0}=\mathcal{E}_{1}-X_{2} \\
X_{1}=\mathcal{E}_{1} / 2 \\
T_{\kappa}\left(X_{0}\right)=T_{\kappa}\left(X_{1}\right), \\
\rho_{j_{2} \kappa}=-U_{j_{1} \kappa-1}\left(\mathcal{E}_{1}-1\right) / U_{j_{2} \kappa-1}\left(\mathcal{E}_{1}-1\right)=-U_{j_{1} \kappa-1}\left(\mathcal{E}_{1} / 2\right) / U_{j_{2} \kappa-1}\left(\mathcal{E}_{1} / 2\right)
\end{array}\right.
$$

This is in agreement with [GM3, (5.1) of section 5] for $n=1$. In practice, our assessment is that it is best to simply take $\Sigma=\left\{j_{1} \kappa, j_{2} \kappa\right\}=\{\kappa, 2 \kappa\}$. Table 3 lists the results for $\kappa \in\{2, \ldots, 9\}$.

9. Energy thresholds in $(0,1 / 2)$ For $\kappa=3$ in dimension 2

Fix $\kappa=3$, in dimension 2. We construct graphically a bunch of thresholds in ( $0,1 / 2$ ). Recall that by [GM3, Lemma 5.3], $\mathfrak{T}_{n, \kappa}=-\mathfrak{T}_{n, \kappa}$, or by [GM3, Lemma 3.2], $\boldsymbol{\Theta}_{\kappa}(\Delta)=-\boldsymbol{\Theta}_{\kappa}(\Delta)$. So the negative thresholds listed below have a positive counterpart.
