# POSITIVE SOLUTIONS TO MULTI-CRITICAL ELLIPTIC PROBLEMS

Abstract. In this paper, we investigate the existence of multiple solutions to the following multi-critical elliptic problem

-\Delta u & =\lambda|u|^{p-2} u+\sum_{i=1}^{k}\left(|x|^{-\left(N-\alpha_{i}\right)} *|u|^{2_{i}^{*}}\right)|u|^{2_{i}^{*}-2} u \quad \text { in } \quad \Omega  \tag{0.1}\\
& u \in H_{0}^{1}(\Omega)
\end{align*}\right.
$$

in connection with the topology of the bounded domain $\Omega \subset \mathbb{R}^{N}, N \geq 4$, where $\lambda>0$, $2_{i}^{*}=\frac{N+\alpha_{i}}{N-2}$ with $N-4<\alpha_{i}<N, \quad i=1,2, \cdots, k$ are critical Hardy-Littlewood-Sobolev exponents and $2<p<22_{\text {min }}^{*}$ with $2_{\text {min }}^{*}=\min \left\{2_{i}^{*}, i=1,2, \cdots, k\right\}$. We show that there is $\lambda^{*}>0$ such that if $0<\lambda<\lambda^{*}$ problem (0.1) possesses at least cat ${ }_{\Omega}(\Omega)$ positive solutions. We also study the existence and uniqueness of solutions for the limit problem of (0.1).

Key words : Multi-critical problem, Multiple solutions, elliptic equation.

## 1. Introduction

In this paper, we investigate the existence of multiple positive solutions to the following multi-critical elliptic problem

u & \in H_{0}^{1}(\Omega)
\end{align*}\right.
$$

in connection with the topology of the bounded domain $\Omega \subset \mathbb{R}^{N}, N \geq 4$, where $\lambda>0$, $H_{0}^{1}(\Omega)$ is the usual Sobolev space equipped with the norm $\|u\|_{H_{0}^{1}(\Omega)}=\left(\int_{\Omega}|\nabla u|^{2} d x\right)^{\frac{1}{2}}$, $2_{i}^{*}=\frac{N+\alpha_{i}}{N-2}$ with $N-4<\alpha_{i}<N, \quad i=1,2, \cdots, k$ are critical Hardy-Littlewood-Sobolev exponents and $2<p<22_{\text {min }}^{*}$ with $2_{\text {min }}^{*}=\min \left\{2_{i}^{*}, i=1,2, \cdots, k\right\}$.

[^0]If $k=1$ and $p=2$, equation (1.1) becomes the critical Choquard problem

$$

\end{array}\right.

where $2_{\alpha}^{*}=\frac{N+\alpha}{N-\alpha}$. Such a problem has been extensively studied for subcritical and critical cases in $[13,14,15,16,21,22]$ and references therein. Especially, a solution of critical problem (1.2) was found in [13] by the mountain pass lemma in spirit of [5]. In [13], the compactness of the $(P S)_{c}$ sequence associated with problem (1.2) is retained if $c$ is strictly less than a threshold value related to the best constant

of the Hardy-Littlewood-Sobolev inequality. For multi-critical problems, such a threshold value varies from problem to problem. Indeed, for the doubly critical problem defined in a bounded domain $\Omega \subset \mathbb{R}^{N}$

where $x_{0} \in \Omega$ and $x_{0} \neq 0,2^{*}(s)=\frac{2(N-s)}{N-2}$ and $2^{*}(t)=\frac{2(N-t)}{N-2}$ are the critical Sobolev-Hardy exponents, it was proved in [12] that the $(P S)_{c}$ condition holds true if

c \in\left(0, \min \left\{\frac{2-s}{2(N-s)} K(0)^{\frac{N-2}{s-2}} S_{\mu, s}^{\frac{N-s}{2-s}}, \frac{2-t}{2(N-t)} Q\left(x_{0}\right)^{\frac{N-2}{t-2}} S_{0, t}^{\frac{N-t}{2-t}}\right\}\right)
$$

where $S_{\mu, s}$ and $S_{0, t}$ are the best Sobolev-Hardy constants defined in [12]. In general, it was studied in [18] the existence of solutions for multi-critical Sobolev-Hardy problems with different singularities. The situation becomes different if $x_{0}=0$, or all Sobolve-Hardy terms have the same singular point. In this case, the multi-critical problem

was considered in [11]. The threshold value for compactness relies on the ground state solution of the limit problem

\end{equation*}

that is, a minimizer of the problem

P_{\min }=\inf \left\{E(u): u \in \mathcal{M}_{E}\right\} \tag{1.7}
\end{equation*}

where

E(u)=\frac{1}{2} \int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\sum_{i=0}^{l} \frac{\lambda_{i}}{2^{*}\left(s_{i}\right)} \int_{\mathbb{R}^{N}} \frac{|u|^{2^{*}\left(s_{i}\right)}}{|x|^{s_{i}}} d x-\frac{1}{2^{*}} \int_{\mathbb{R}^{N}}|u|^{2^{*}} d x
$$

and

\mathcal{M}_{E}=\left\{u \in D^{1,2}\left(\mathbb{R}^{N}\right) \backslash\{0\}:\left\langle E^{\prime}(u), u\right\rangle=0\right\}
$$

as well as

D^{1,2}\left(\mathbb{R}^{N}\right)=\left\{u \in L^{\frac{2 N}{N-2}}\left(\mathbb{R}^{N}\right):|\nabla u| \in L^{2}\left(\mathbb{R}^{N}\right)\right\}
$$

with the norm $\|u\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}=\left(\int_{\mathbb{R}^{N}}|\nabla u|^{2} d x\right)^{\frac{1}{2}}$. It is known from [28] that problem (1.6) has a positive ground state solution $U$ satisfying

U(x) \leq C\left(1+|x|^{2-N}\right) \quad|\nabla U(x)| \leq C\left(1+|x|^{1-N}\right) \tag{1.8}
\end{equation*}
$$

The decaying law in (1.8) allows one to verify $(P S)_{c}$ condition for the functional associated with problem (1.6) if $c \in\left(0, P_{\text {min }}\right)$. An existence result of problem (1.6) is then given in [11]. We remark that similar problems with the singular point $0 \in \partial \Omega$ have been extensively studied in $[8,17,20]$ etc, see also references therein.

In this paper, we first consider the existence of positive solution of problem (1.1). Such a solution will be found as a critical point of the functional

in $H_{0}^{1}(\Omega)$, where $u_{+}=\max \{u, 0\}$. In the context, for the simplicity we write $u^{q}$ as $u_{+}^{q}$ for $2 \leq q \leq 2^{*}$ etc in functionals. It is standard to show that critical points of $I_{\lambda, \Omega}(u)$ are positive solutions of problem (1.1), see for instance [25]. In order to verify $(P S)_{c}$ condition for $I_{\lambda, \Omega}(u)$, that is, any sequence $\left\{u_{n}\right\} \subset H_{0}^{1}(\Omega)$ such that $I_{\lambda, \Omega}\left(u_{n}\right) \rightarrow c, \quad I_{\lambda, \Omega}^{\prime}\left(u_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$, contains a convergent subsequence, we need to take into account the limit problem of problem (1.1):

The threshold value for the compactness of $I_{\lambda, \Omega}(u)$ will be given by

where

J(u)=\frac{1}{2} \int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\sum_{i=1}^{k} \frac{1}{22_{i}^{*}} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{u(x)^{2_{i}^{*}} u(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y \tag{1.12}
\end{equation*}

is the corresponding functional of problem (1.10) and

\mathcal{M}_{\mathbb{R}^{N}}=\left\{u \in D^{1,2}\left(\mathbb{R}^{N}\right) \backslash\{0\}:\left\langle J^{\prime}(u), u\right\rangle=0\right\} \tag{1.13}

is the associated Nehari manifold. We will show that $I_{\lambda, \Omega}(u)$ satisfies $(P S)_{c}$ condition if $c \in\left(0, m\left(\mathbb{R}^{N}\right)\right)$. To verify this condition, one has to know not only the existence of a ground state solution of problem (1.10), but also the decaying law of the solution at infinity. Our first result consists of the existence of ground state solutions of problem (1.10) and their decay at infinity. Actually, we find a ground state solution of problem (1.10) with an explicit form. The result is stated as follows.

Theorem 1.1. Problem (1.10) has a unique positive solution in the form

U(x)=C\left(\frac{\varepsilon}{\varepsilon^{2}+\left|x-x_{0}\right|^{2}}\right)^{\frac{N-2}{2}}
$$

for $x_{0} \in \mathbb{R}^{N}$ and $\varepsilon>0$.
Our proof of the existence part in Theorem 1.1 is elementary and straightforward in contrast with variational approaches used in [26] and [28] etc. The approach for the uniqueness is based on the moving spheres method. Similar result for double critical problems was presented in [27].

Using Theorem 1.1, we prove that there is a positive solution for problem (1.1).
Theorem 1.2. Suppose $N \geq 4$ and $2<p<22_{\text {min }}^{*}$, then $m_{\lambda, \Omega}$ is achieved and problem (1.1) possesses at least a positive solution.

Next, we consider the existence of multiple solutions of problem (1.1) linking with the topology of the domain $\Omega$. The study of the existence of positive solutions in noncontractible was initiated by Kazdan and Warner [19] and Coron [10]. Actually, the existence and the multiplicity of solutions of

linking to the topology of domain $\Omega$ have been obtained in [10] for $\lambda=0$ and $q=2^{*}=$ $\frac{2 N}{N-2}, N \geq 3$ provided $\Omega$ is non-contractible. Later on, it was proved in [2] that critical problem (1.14) has a positive solution if $H_{d}\left(\Omega, \mathbb{Z}_{2}\right) \neq 0$ for some $d$. In critical and near critical cases, it is shown in $[1,3,4,24,25]$ that problem (1.14) possesses at least $c^{c a t_{\Omega}}(\Omega)$ positive solutions. The subcritical problem of (1.14) was studied in [6, 7] in exterior domains, cat $_{\Omega}(\Omega)$ number positive high energy solutions was found by the LjusternikSchnirelman theory.

Multiple positive solutions for the nonlinear Choquard problem

$$
\left\{\begin{array}{c}
-\Delta u+\lambda u=\left(|x|^{-(N-\alpha)} *|u|^{q}\right)|u|^{q-2} u \quad \text { in } \quad \Omega,  \tag{1.15}\\
u \in H_{0}^{1}(\Omega)
\end{array}\right.
$$

are obtained in [14] related to the Ljusternik-Schnirelman category $\operatorname{cat}_{\Omega}(\Omega)$ of domain $\Omega$. It was proved that if $\Omega$ is bounded and $q$ is closed to the critical exponent $2_{\alpha}^{*}=\frac{N+\alpha}{N-2}$, problem (1.15) possesses at least $\operatorname{cat}_{\Omega}(\Omega)$ positive solutions; similar results were obtained in [15] for
the critical case $q=2_{\alpha}^{*}$. Moreover, positive high energy solutions was also found in [16] for the critical case in an annular domain. It seems that for the multi-critical problem (1.1), no multiple solutions linking to the topology of the domain $\Omega$ might be found in literatures. Our result in Theorem 1.1 allows us to find such a result as follows.

Theorem 1.3. Suppose $N \geq 4$ and $2<p<22_{\text {min }}^{*}$, then there exists $\lambda^{*}>0$ such that for $0<\lambda<\lambda^{*}$, problem (1.1) possesses at least cat ${ }_{\Omega}(\Omega)$ positive solutions.

We remark that one might easily imagine similar multiple results hold for problem (1.6), but it will encounter essential difficulties in doing so.

In the proof of Theorem 1.3, a key ingredient is to show that the barycenter of functions in certain level set belonging to a neighborhood of $\Omega$. In general, this is done by the concentration-compactness principle. Such an argument seems hard to apply to multicritical problems. We use improved Sobolev inequalities related to the Morrey space to replace the concentration-compactness principle, we prove essentially that any minimizing sequence of $m\left(\mathbb{R}^{N}\right)$ has a subsequence strongly converging in $D^{1,2}\left(\mathbb{R}^{N}\right)$ up to translations and dilations.

This paper is organized as follows. We first study the limit problem in Sections 2 and 3, then the existence of a positive solution is proved in Section 4. Multiple results are established in Section 5.

## 2. The Limit problem: Existence

In this section, we will show that the limit problem (1.10) has a ground state solution. By a ground state of equation (1.10) we mean a solution that minimizes the associated functional $I(u)$ defined in (1.12) among all nontrivial solutions. Furthermore, we prove the uniqueness of positive solutions for equation (1.10) up to translations and dilations, and work out explicitly form of the solution.

Lemma 2.1. The function

$$
\begin{equation*}
f(t)=\frac{1}{2} t-\sum_{i=1}^{k} \frac{1}{22_{i}^{*}}\left(\frac{t}{S_{i}}\right)^{2_{i}^{*}} \tag{2.1}
\end{equation*}
$$

has a unique maximum point, where $S_{i}=S_{\alpha_{i}}$ defined in (1.3).
Proof. Since $f(t)>0$ if $t>0$ small and $f(t) \rightarrow-\infty$ if $t \rightarrow+\infty$, there exists $t_{0} \in(0,+\infty)$ such that

$$

and

Now we show the maximum point is unique. Suppose on the contrary, there would exist another maximum point $t_{1} \in(0,+\infty)$ of $f(t)$ satisfying

If $t_{1} \neq t_{0}$, we find a contradiction from (2.2) and (2.3). The proof is complete.

We consider the minimization problem $m\left(\mathbb{R}^{N}\right)$ defined in (1.11). We may prove as Lemma 2.1 that for any $u \in D^{1,2}\left(\mathbb{R}^{N}\right)$, there is a unique $t_{u}>0$ such that $t_{u} u \in \mathcal{M}_{\mathbb{R}^{N}}$. This enables us to show as [25] that

m\left(\mathbb{R}^{N}\right)=\inf _{u \neq 0} \max _{t>0} J(t u)=\inf _{\gamma \in \Gamma} \max _{t \in[0,1]} J(\gamma(t)) \tag{2.4}
\end{equation*}
$$

where

\Gamma:=\left\{\gamma \in C\left([0,1], D^{1,2}\left(\mathbb{R}^{N}\right)\right): \gamma(0)=0, J(\gamma(1)) \leq 0, \gamma(1) \neq 0\right\}
$$

Moreover, we may verify that there exists $c>0$ such that for every $u \in \mathcal{M}_{\mathbb{R}^{N}}$, there holds $c \leq\|u\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}$, and $m\left(\mathbb{R}^{N}\right)>0$.

It is known from [13] that $S_{\alpha}$ defined in (1.3) is achieved if and only if

\end{equation*}

where $\lambda \in(0,+\infty)$ and $\xi \in \mathbb{R}^{N}$. Based on Lemma 2.1 and (2.5), we have the following existence result.

Proposition 2.2. There is a positive constant $C_{0}>0$ such that the minimization problem $m\left(\mathbb{R}^{N}\right)$ defined in (1.11) is achieved by the function

V_{\varepsilon, \xi}(x)=C_{0}\left(\frac{\varepsilon}{\varepsilon^{2}+|x-\xi|^{2}}\right)^{\frac{N-2}{2}} \tag{2.6}
\end{equation*}
$$

for $\varepsilon>0$. Alternatively, $V_{\varepsilon, \xi}$ is a ground state solution of problem (1.10).
Proof. Denote $U(x)=u_{1,0}$, where $u_{1,0}$ is defined in (2.5). Since $I(u)$ is invariant under translations and dilations, we need only to find a minimizer of $m\left(\mathbb{R}^{N}\right)$ in the form of $U(x)$. Observing that

m\left(\mathbb{R}^{N}\right)=\inf _{u \neq 0} \max _{t>0} J(t u)=\inf _{\|u\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}=1} \max _{t>0} J(\sqrt{t} u)
$$

for $u \in D^{1,2}\left(\mathbb{R}^{N}\right)$, we deduce from the Hardy-Littlewood-Sobolev inequality that

J(\sqrt{t} u) \geq \frac{1}{2} t \int_{\mathbb{R}^{N}}|\nabla u|^{2} d x-\sum_{i=1}^{k} \frac{t^{2_{i}^{*}}}{22_{i}^{*}}\left(\frac{1}{S_{i}} \int_{\mathbb{R}^{N}}|\nabla u|^{2} d x\right)^{2_{i}^{*}}=f(t) .
$$

Thus,

\max _{t>0} J(\sqrt{t} u) \geq \max _{t>0} f(t)=f\left(t_{0}\right)
$$

implying

m\left(\mathbb{R}^{N}\right) \geq f\left(t_{0}\right)
$$

On the other hand, we may choose $\tilde{C}>0$ such that $V=\tilde{C} U$ satisfying $\|V\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}=1$. Noting that $S_{i}=S_{\alpha_{i}}$ is achieved by $U$, we have that

J(\sqrt{t} V) & =\frac{1}{2} t \int_{\mathbb{R}^{N}}|\nabla V|^{2} d x-\sum_{i=1}^{k} \frac{t^{2_{i}^{*}} \tilde{C}^{22_{i}^{*}}}{22_{i}^{*}}\left(\frac{1}{S_{i}} \int_{\mathbb{R}^{N}}|\nabla U|^{2} d x\right)^{2_{i}^{*}} \\
& =\frac{1}{2} t \int_{\mathbb{R}^{N}}|\nabla V|^{2} d x-\sum_{i=1}^{k} \frac{t^{2_{i}^{*}}}{22_{i}^{*}}\left(\frac{1}{S_{i}} \int_{\mathbb{R}^{N}}|\nabla V|^{2} d x\right)^{2_{i}^{*}}  \tag{2.7}\\
& =f(t) .
\end{align*}
$$

Hence,

\max _{t>0} J(\sqrt{t} V)=f\left(t_{0}\right)
$$

which yields

m\left(\mathbb{R}^{N}\right)=\inf _{\|u\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}=1} \max _{t>0} J(\sqrt{t} u) \leq f\left(t_{0}\right)
$$

Consequently,

m\left(\mathbb{R}^{N}\right)=f\left(t_{0}\right)=J\left(\sqrt{t_{0}} V\right)
$$

Let $V_{0}(x)=\sqrt{t_{0}} V(x)=\sqrt{t_{0}} \tilde{C} U(x)$. By the fact

0=f^{\prime}\left(t_{0}\right)=\frac{1}{2}-\sum_{i=1}^{k} \frac{1}{2} S_{i}^{-2_{i}^{*}} t_{0}^{2_{i}^{*}-1}
$$

and $\|V\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}=1$, we obtain as (2.7) that

0 & =\int_{\mathbb{R}^{N}} t_{0}|\nabla V|^{2} d x-\sum_{i=1}^{k} t_{0}^{2_{i}^{*}}\left(\frac{1}{S_{i}} \int_{\mathbb{R}^{N}}|\nabla V|^{2} d x\right)^{2_{i}^{*}} \\
& =\int_{\mathbb{R}^{N}}\left|\nabla V_{0}\right|^{2} d x-\sum_{i=1}^{k} t_{0}^{2_{i}^{*}} \tilde{C}^{22_{i}^{*}}\left(\frac{1}{S_{i}} \int_{\mathbb{R}^{N}}|\nabla U|^{2} d x\right)^{2_{i}^{*}} \\
& =\int_{\mathbb{R}^{N}}\left|\nabla V_{0}\right|^{2} d x-\sum_{i=1}^{k} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{V_{0}^{2_{i}^{*}}(x) V_{0}^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y,
\end{aligned}
$$

that is, $V_{0} \in \mathcal{M}_{\mathbb{R}^{N}}$. This means that $V_{0}$ is a minimizer of $m\left(\mathbb{R}^{N}\right)$, the assertion follows.

## 3. The limit problem: uniqueness

In this section, we prove the uniqueness of positive solution for the limit problem (1.10) up to translations and dilations, the argument used is based on the moving spheres method. Denote

$$
w^{i}(x)=\int_{\mathbb{R}^{N}} \frac{u(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y, \quad i=1, \cdots, k
$$

then (1.10) can be written as

$$
\begin{equation*}
-\Delta u(x)=\sum_{i=1}^{k} w^{i}(x) u(x)^{\frac{2+\alpha_{i}}{N-2}} \quad \text { in } \quad \mathbb{R}^{N} \tag{3.1}
\end{equation*}
$$

The moving spheres method can not be directly applied to $u$ since no decay law of $u$ at infinity is known. So we turn to use the moving spheres method on the Kelvin transformation of $u$. The Kelvin transformations of $u$ and $w^{i}$ are defined as

$$
v(x)=\frac{1}{|x|^{N-2}} u\left(\frac{x}{|x|^{2}}\right), \quad z^{i}(x)=\frac{1}{|x|^{N-\alpha_{i}}} w^{i}\left(\frac{x}{|x|^{2}}\right), \quad i=1, \cdots, k .
$$

We remark that the solution $u$ of (1.10) belongs to $C^{2}\left(\mathbb{R}^{N}\right)$, this can be done by the same argument in [27]. Therefore, $v(x)$ and $z^{i}(x)$ decay at infinity as $|x|^{2-N}$ and $|x|^{\alpha_{i}-N}$ respectively. It can be verified that $v(x)$ and $z^{i}(x)$ satisfy

$$
\begin{cases}z^{i}(x)=\int_{\mathbb{R}^{N}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y & \text { in } \mathbb{R}^{N} \backslash\{0\},  \tag{3.2}\\ -\Delta v(x)=\sum_{i=1}^{k} z^{i}(x) v(x)^{\frac{2+\alpha_{i}}{N-2}} & \text { in } \mathbb{R}^{N} \backslash\{0\} .\end{cases}
$$

We can also verify that the reflection functions

$$
v_{\lambda}(x)=\left(\frac{\lambda}{|x|}\right)^{N-2} v\left(\frac{\lambda^{2} x}{|x|^{2}}\right)=\frac{1}{\lambda^{N-2}} u\left(\frac{x}{\lambda^{2}}\right)
$$

and

$$
z_{\lambda}^{i}(x)=\left(\frac{\lambda}{|x|}\right)^{N-\alpha_{i}} z\left(\frac{\lambda^{2} x}{|x|^{2}}\right)=\frac{1}{\lambda^{N-\alpha_{i}}} w^{i}\left(\frac{x}{\lambda^{2}}\right),
$$

of $v(x)$ and $z^{i}(x)$ with respect to $\partial B_{\lambda}(0)$ satisfy

$$
\begin{cases}z_{\lambda}^{i}(x)=\int_{\mathbb{R}^{N}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y & \text { in } \mathbb{R}^{N}  \tag{3.3}\\ -\Delta v_{\lambda}(x)=\sum_{i=1}^{k} z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}} & \text { in } \mathbb{R}^{N}\end{cases}
$$

The spirit of the moving spheres method is to compare the value of functions with their reflections with respect to the sphere. For this purpose, we have the following result.

Lemma 3.1. Suppose that $z^{i}(x)$ and $z_{\lambda}^{i}(x)$ satisfy equation (3.2) and equation (3.3) respectively, then we have

\begin{equation*}
z_{\lambda}^{i}(x)-z^{i}(x)=\int_{B_{\lambda}}\left[\frac{1}{|x-y|^{N-\alpha_{i}}}-\frac{1}{\left|x-\frac{\lambda^{2} y}{|y|^{2}}\right|^{N-\alpha_{i}}}\left(\frac{\lambda}{|y|}\right)^{N-\alpha_{i}}\right]\left[v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}-v(y)^{\frac{N+\alpha_{i}}{N-2}}\right] d y \tag{3.4}
\end{equation*}
$$

Proof. The result is a direct consequence of (3.2) and (3.3). Indeed, we deduce from (3.2) and (3.3) that

& z_{\lambda}^{i}(x)-z^{i}(x) \\
& =\int_{\mathbb{R}^{N}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y-\int_{\mathbb{R}^{N}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y \\
& =\int_{B_{\lambda}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y+\int_{B_{\lambda}^{C}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y-\int_{B_{\lambda}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y-\int_{B_{\lambda}^{C}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y \\
& =\int_{B_{\lambda}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y+\int_{B_{\lambda}} \frac{v_{\lambda}\left(\frac{\lambda^{2} y}{\left.|y|^{2}\right)^{\frac{N+\alpha_{i}}{N-2}}}\right.}{\left\lvert\, x-\frac{\lambda^{2} y}{\left.|y|^{2}\right|^{N-\alpha_{i}}}\right.} \frac{\lambda^{2 N}}{|y|^{2 N}} d y \\
& -\int_{B_{\lambda}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y-\int_{B_{\lambda}} \frac{v\left(\frac{\lambda^{2} y}{|y|^{2}}\right)^{\frac{N+\alpha_{i}}{N-2}}}{\left|x-\frac{\lambda^{2} y}{|y|^{2}}\right|^{N-\alpha_{i}}} \frac{\lambda^{2 N}}{|y|^{2 N}} d y \\
& =\int_{B_{\lambda}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y+\int_{B_{\lambda}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{\left\lvert\, x-\frac{\lambda^{2} y}{\left.|y|^{2}\right|^{N-\alpha_{i}}}\right.} \frac{\lambda^{N-\alpha_{i}}}{|y|^{N-\alpha_{i}}} d y \\
& -\int_{B_{\lambda}} \frac{v(y)^{\frac{N+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}} d y-\int_{B_{\lambda}} \frac{v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}}{\left|x-\frac{\lambda^{2} y}{|y|^{2}}\right|^{N-\alpha_{i}}}\left(\frac{\lambda}{|y|^{N-\alpha_{i}}} d y\right. \\
& =\int_{B_{\lambda}}\left[\frac{1}{|x-y|^{N-\alpha_{i}}}-\frac{1}{\left\lvert\, x-\frac{\lambda^{2} y}{\left.|y|^{2}\right|^{N-\alpha_{i}}}\right.}\left(\frac{\lambda}{|y|}\right)^{N-\alpha_{i}}\right]\left[v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}-v_{\lambda}(y)^{\frac{N+\alpha_{i}}{N-2}}\right] d y .
\end{aligned}
$$

This completes the proof of Lemma 3.1.
To compare the values of $v(x)$ and $v_{\lambda}(x)$ in $B_{\lambda}(0)$, we need the following result.
Lemma 3.2. Suppose that $v(x)$ and $z^{i}(x)$ satisfy (3.2) and (3.3) respectively, then we have the following inequality

\int_{B_{\lambda}}\left|\nabla\left(v_{\lambda}(x)-v(x)\right)^{+}\right|^{2} d x & \leq C\left[\sum_{i=1}^{k}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+2 \alpha_{i}}{N-2}}+\sum_{i=1}^{k}\left\|z_{\lambda}^{i}\right\|_{L^{\frac{2 N}{N-\alpha_{i}}\left(B_{\lambda}\right)}}\left\|v_{\lambda}(x)\right\|_{L^{\frac{4+\alpha_{i}-N}{N N}}}^{\frac{2 N}{N-2}\left(B_{\lambda}\right)}\right.
\end{array}\right]
$$

Proof. To deal with the possible singularity of $v$ at zero, we first define a cut-off function

$$
\eta_{\varepsilon}(x)=\eta_{\varepsilon}(|x|)= \begin{cases}0 & \text { for } x \in B_{\varepsilon} \\ 1 & \text { for } x \in B_{2 \varepsilon}^{c}\end{cases}
$$

with $|\nabla \eta| \leq \frac{2}{\varepsilon}$ in $B_{2 \varepsilon} \backslash B_{\varepsilon}$. Let

$$
\varphi_{\varepsilon}(x)=\eta_{\varepsilon}^{2}\left(v_{\lambda}(x)-v(x)\right)^{+}, \quad \psi_{\varepsilon}(x)=\eta_{\varepsilon}\left(v_{\lambda}(x)-v(x)\right)^{+}
$$

then we have

$$
\left|\nabla \psi_{\varepsilon}(x)\right|^{2}=\nabla\left(v_{\lambda}(x)-v(x)\right) \nabla \varphi_{\varepsilon}+\left[\left(v_{\lambda}(x)-v(x)\right)^{+}\right]^{2}\left|\nabla \eta_{\varepsilon}\right|^{2}
$$

We estimate

$$
\begin{align*}
& \int_{B_{\lambda} \backslash B_{2 \varepsilon}}\left|\nabla\left(v_{\lambda}(x)-v(x)\right)^{+}\right|^{2} d x \\
& \leq \int_{B_{\lambda}}\left|\nabla \psi_{\varepsilon}(x)\right|^{2} d x \\
& =\int_{B_{\lambda}} \nabla\left(v_{\lambda}(x)-v(x)\right) \nabla \varphi_{\varepsilon}(x) d x+\int_{B_{\lambda}}\left[\left(v_{\lambda}(x)-v(x)\right)^{+}\right]^{2}\left|\nabla \eta_{\varepsilon}\right|^{2} d x  \tag{3.6}\\
& =-\int_{B_{\lambda}} \Delta\left(v_{\lambda}(x)-v(x)\right) \varphi_{\varepsilon}(x) d x+I_{\varepsilon} \\
& \leq \int_{B_{\lambda}} \sum_{i=1}^{k}\left[z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-z^{i}(x) v(x)^{\frac{2+\alpha_{i}}{N-2}}\right]\left(v_{\lambda}(x)-v(x)\right)^{+} d x+I_{\varepsilon}
\end{align*}
$$

where $I_{\varepsilon}=\int_{B_{\lambda}}\left[\left(v_{\lambda}(x)-v(x)\right)^{+}\right]^{2}\left|\nabla \eta_{\varepsilon}\right|^{2} d x$. We claim that $I_{\varepsilon} \rightarrow 0$ as $\varepsilon \rightarrow 0$. In fact,

$$
\begin{aligned}
I_{\varepsilon} & \leq\left(\int_{B_{2 \varepsilon}}\left[\left(v_{\lambda}(y)-v(x)\right)^{+}\right]^{\frac{2 N}{N-2}} d x\right)^{\frac{N-2}{N}}\left(\int_{B_{2 \varepsilon}}|\nabla \eta|^{N} d x\right)^{\frac{2}{N}} \\
& \leq\left(\int_{B_{\frac{2 \varepsilon}{\lambda^{2}}}} u(x)^{\frac{2 N}{N-2}} d x\right)^{\frac{N-2}{N}}\left(\int_{B_{2 \varepsilon}}|\nabla \eta|^{N} d x\right)^{\frac{2}{N}} \rightarrow 0
\end{aligned}
$$

as $\varepsilon \rightarrow 0$.
Next, we estimate $z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-z^{i}(x) v(x)^{\frac{2+\alpha_{i}}{N-2}}$ in $B_{\lambda}$. If $z_{\lambda}^{i}(x) \leq z^{i}(x)$, apparently we have

$$
\begin{equation*}
z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-z^{i}(x) v(x)^{\frac{2+\alpha_{i}}{N-2}} \leq z_{\lambda}^{i}(x)\left[v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-v(x)^{\frac{2+\alpha_{i}}{N-2}}\right] . \tag{3.7}
\end{equation*}
$$

While if $z_{\lambda}^{i}(x)>z^{i}(x)$, there holds

$$
\begin{align*}
& z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-z^{i}(x) v(x)^{\frac{2+\alpha_{i}}{N-2}} \\
& =\left[z_{\lambda}^{i}(x)-z^{i}(x)\right] v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}+z^{i}(x)\left[v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-v(x)^{\frac{2+\alpha_{i}}{N-2}}\right] \\
& \leq\left[z_{\lambda}^{i}(x)-z^{i}(x)\right]^{+} v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}+z^{i}(x)\left[v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-v(x)^{\frac{2+\alpha_{i}}{N-2}}\right]^{+}  \tag{3.8}\\
& \leq\left[z_{\lambda}^{i}(x)-z^{i}(x)\right]^{+} v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}+z_{\lambda}^{i}(x)\left[v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}-v(x)^{\frac{2+\alpha_{i}}{N-2}}\right]^{+} .
\end{align*}
$$

Substituting (3.7) and (3.8) into (3.6), we get

\begin{aligned}
& \int_{B_{\lambda} \backslash B_{2 \varepsilon}}\left|\nabla\left(v_{\lambda}(x)-v(x)\right)^{+}\right|^{2} d x \\
& \leq \sum_{i=1}^{k} \int_{B_{\lambda}}\left[z_{\lambda}^{i}(x)-z^{i}(x)\right]^{+} v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}\left(v_{\lambda}(x)-v(x)\right)^{+} d x \\
& +\sum_{i=1}^{k} \int_{B_{\lambda}} z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{4+\alpha_{i}-N}{N-2}}\left[\left(v_{\lambda}(x)-v(x)\right)^{+}\right]^{2} d x+I_{\varepsilon} \\
& \leq \sum_{i=1}^{k} \int_{B_{\lambda}} \int_{B_{\lambda}} \frac{v_{\lambda}(y)^{\frac{2+\alpha_{i}}{N-2}}}{|x-y|^{N-\alpha_{i}}}\left[v_{\lambda}(y)-v(y)\right]^{+} v_{\lambda}(x)^{\frac{2+\alpha_{i}}{N-2}}\left[v_{\lambda}(x)-v(x)\right]^{+} d x d y \\
& +\sum_{i=1}^{k} \int_{B_{\lambda}} z_{\lambda}^{i}(x) v_{\lambda}(x)^{\frac{4+\alpha_{i}-N}{N-2}}\left[\left(v_{\lambda}(x)-v(x)\right)^{+}\right]^{2} d x+I_{\varepsilon} \\
& \leq \sum_{i=1}^{k}\left\|v_{\lambda}(y)^{\frac{2+\alpha_{i}}{N-2}}\left(v_{\lambda}(y)-v(y)\right)^{+}\right\|_{L^{\frac{2 N}{N+\alpha_{i}}}\left(B_{\lambda}\right)}^{2} \\
& +\sum_{i=1}^{k}\left\|z_{\lambda}^{i}(x)\right\|_{L^{\frac{2 N}{N-\alpha_{i}}}\left(B_{\lambda}\right)}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+\alpha_{i}-N}{N-2}}\left\|\left(v_{\lambda}(y)-v(y)\right)^{+}\right\|_{L^{\frac{2 N}{N-2}\left(B_{\lambda}\right)}}^{2}+I_{\varepsilon} \\
& \leq \sum_{i=1}^{k}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+2 \alpha_{i}}{N-2}}\left\|\left(v_{\lambda}(x)-v(x)\right)^{+}\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{2} \\
& +\sum_{i=1}^{k}\left\|z_{\lambda}^{i}(x)\right\|_{L^{\frac{2 N}{N-\alpha_{i}}\left(B_{\lambda}\right)}}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}\left(B_{\lambda}\right)}}^{\frac{4+\alpha_{i}-N}{N-2}}\left\|\left(v_{\lambda}(x)-v(x)\right)^{+}\right\|_{L^{\frac{2 N}{N-2}\left(B_{\lambda}\right)}}^{2}+I_{\varepsilon} .
\end{aligned}
$$

Using Sobolev inequality and letting $\varepsilon \rightarrow 0$, we obtain

\begin{aligned}
\int_{B_{\lambda}}\left|\nabla\left(v_{\lambda}(x)-v(x)\right)^{+}\right|^{2} d x & \leq C\left[\sum_{i=1}^{k}\left\|v_{\lambda}(x)\right\|_{L^{2 N} N}^{\frac{4+2 \alpha_{i}}{N-2}}+\sum_{i=1}^{k}\left\|z_{\lambda}^{i}\right\|_{L^{\frac{2 N}{N-\alpha_{i}}\left(B_{\lambda}\right)}}\left\|v_{\lambda}(x)\right\|_{L^{\frac{4+\alpha_{i}-N}{N-2}}}^{\frac{2 N}{N-2}\left(B_{\lambda}\right)}\right. \\
& \times \int_{B_{\lambda}}\left|\nabla\left(v_{\lambda}(x)-v(x)\right)^{+}\right|^{2} d x
\end{aligned}
$$

this completes the proof of Lemma 3.2.

Lemmas 3.1 and 3.2 are the maximum principles in an integral form, they can be used to replace the usual maximum principles in a differential form. In fact, if

C\left[\sum_{i=1}^{k}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+2 \alpha_{i}}{N}}+\sum_{i=1}^{k}\left\|z_{\lambda}^{i}\right\|_{L^{\frac{2 N}{N-\alpha_{i}}}\left(B_{\lambda}\right)}\left\|v_{\lambda}(x)\right\|_{L^{2 N}\left(B_{\lambda}\right)}^{\frac{4+\alpha_{i}-N}{N-2}}\right]<1
$$

we may infer from equation (3.5) that $v_{\lambda}(x) \leq v(x)$ in $B_{\lambda} \backslash\{0\}$. By Lemma 3.1, we have $z_{\lambda}^{i}(x) \leq z^{i}(x)$ in $B_{\lambda} \backslash\{0\}$. The conclusion is the same as that of the maximum principle.

Now, we show that the spheres can be moved from infinity.
Lemma 3.3. There exists $\lambda>0$ large enough, such that

v_{\lambda}(x) \leq v(x) \quad \text { in } B_{\lambda} \backslash\{0\}
$$

and

z_{\lambda}^{i}(x) \leq z^{i}(x) \quad \text { in } B_{\lambda} \backslash\{0\}, i=1,2, \ldots, k
$$

Proof. By the definition of $v_{\lambda}$, we have

\int_{B_{\lambda}} v_{\lambda}(x)^{\frac{2 N}{N-2}} d x=\int_{B_{\frac{1}{\lambda}}} u(y)^{\frac{2 N}{N-2}} d y \rightarrow 0 \text { as } \lambda \rightarrow+\infty
$$

and

$$
\int_{B_{\lambda}} z_{\lambda}^{i}(x)^{\frac{2 N}{N-\alpha_{i}}} d x=\int_{B_{\frac{1}{\lambda}}} w^{i}(y)^{\frac{2 N}{N-\alpha_{i}}} d y \rightarrow 0 \text { as } \lambda \rightarrow+\infty
$$

for $i=1,2, \ldots, k$.
Hence, we can choose $\lambda$ large enough, such that

$$
C\left[\sum_{i=1}^{k}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+2 \alpha_{i}}{N-2}}+\sum_{i=1}^{k}\left\|z_{\lambda}^{i}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}\left\|v_{\lambda}(x)\right\|_{L^{\frac{2 N}{N-2}}\left(B_{\lambda}\right)}^{\frac{4+\alpha_{i}-N}{N-2}}\right]<\frac{1}{2},
$$

and Lemma 3.2 implies that $v_{\lambda}(x) \leq v(x)$ in $B_{\lambda} \backslash\{0\}$. Moreover, we infer from Lemma 3.1 that $z_{\lambda}^{i}(x) \leq z^{i}(x)$ in $B_{\lambda} \backslash\{0\}$ for $i=1,2, \ldots, k$.

We note that the above process also works for

$$
u^{b}(x)=u(x+b)
$$

with $b \in \mathbb{R}^{N}$. In particular, for any $b \in \mathbb{R}^{N}$ and $\lambda$ large enough, we have

$$
v_{\lambda}^{b}(x) \leq v^{b}(x) \quad \text { in } B_{\lambda} \backslash\{0\}
$$

and

$$
z_{\lambda}^{b, i}(x) \leq z^{b, i}(x) \quad \text { in } B_{\lambda} \backslash\{0\} \text { for } i=1,2, \ldots, k,
$$

where $v^{b}(x)$ is the Kelvin transformation of $u^{b}(x)$, and $z_{\lambda}^{b, i}(x)$ is defined in a similar way. Let

$$
\lambda_{b}=\inf \left\{\lambda \mid v_{\mu}^{b}(x) \leq v^{b}(x), z_{\mu}^{b, i}(x) \leq z^{b, i}(x)(i=1,2, \ldots, k) \text { in } B_{\mu} \backslash\{0\} \text { with } \lambda<\mu<+\infty\right\}
$$

Lemma 3.4. There exists $\bar{b} \in \mathbb{R}^{N}$, such that $\lambda_{\bar{b}}>0$.
Before proving Lemma 3.4, we establish a technical lemma.

Lemma 3.5. Suppose $u \in C^{1}\left(\mathbb{R}^{N}\right)$, if for all $b \in \mathbb{R}^{N}$ and $\lambda>0$, the following inequality holds

$$
\begin{equation*}
\frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right)-\frac{1}{\lambda^{N-2}} u_{b}\left(\frac{x}{\lambda^{2}}\right) \geq 0, \quad \forall x \in B_{\lambda} \backslash\{0\} \tag{3.9}
\end{equation*}
$$

then we have $u(x) \equiv C$, where $u_{b}(x)=u(x+b)$.
Proof. Let $g_{b, \lambda}(x)=\frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right)-\frac{1}{\lambda^{N-2}} u_{b}\left(\frac{x}{\lambda^{2}}\right)$. Then,

$$
\begin{equation*}
g_{b,|x|}(x)=\frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right)-\frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right)=0 \tag{3.10}
\end{equation*}
$$

and for any $0<r<1$, we infer from equation (3.9) that

$$
\begin{equation*}
g_{b,|x|}(r x)=\frac{1}{|r x|^{N-2}} u_{b}\left(\frac{r x}{|r x|^{2}}\right)-\frac{1}{|x|^{N-2}} u_{b}\left(\frac{r x}{|x|^{2}}\right) \geq 0 \tag{3.11}
\end{equation*}
$$

This implies

$$
\begin{equation*}
\left.\frac{d g_{b,|x|}(r x)}{d r}\right|_{r=1} \leq 0 \tag{3.12}
\end{equation*}
$$

that is,

$$
\begin{equation*}
(N-2) \frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right)+\frac{2}{|x|^{N}} \nabla u_{b}\left(\frac{x}{|x|^{2}}\right) x \geq 0 \tag{3.13}
\end{equation*}
$$

In other word,

$$
\begin{equation*}
(N-2) u(y+b)+2 y \cdot \nabla u(y+b) \geq 0 \tag{3.14}
\end{equation*}
$$

namely,

$$
\begin{equation*}
(N-2) u(x)+2(x-b) \nabla u(x) \geq 0 \tag{3.15}
\end{equation*}
$$

Dividing both sides of (3.15) by $|b|$ and letting $|b| \rightarrow \infty$, we find $\nabla u(x) \frac{b}{|b|} \leq 0$. Since $b$ is arbitrary, we have $\nabla u(x)=0$ or $u \equiv C$. The assertion follows.

Proof of Lemma 3.4. Suppose on the contrary that $\lambda_{b} \equiv 0$ for all $b \in \mathbb{R}^{N}$, then we infer from Lemma 3.5 that $v(x) \equiv 0$, which yields $u \equiv 0$. This is a contradiction because $u$ is a positive solution.

Lemma 3.6. If $\lambda_{b}>0$, then $v_{\lambda_{b}}^{b}(x) \equiv v^{b}(x), z_{\lambda_{b}}^{b, i}(x) \equiv z^{b, i}(x)(i=1,2, \ldots, k)$ in $B_{\lambda_{b}} \backslash\{0\}$.
Proof. Without loss of generality we assume $b=0$ and denote

$$
v_{\lambda_{0}}(x)=v_{\lambda_{0}}^{0}(x), z_{\lambda_{0}}^{i}(x)=z_{\lambda_{0}}^{0, i}(x), i=1,2, \ldots, k
$$

Assume on the contrary, we claim that there exists a constant $\gamma>0$ such that $v(x)-$ $v_{\lambda_{0}}(x) \geq \gamma$ in $B_{\frac{\lambda_{0}}{2}} \backslash\{0\}$. Indeed, by the strong maximum principle, we have $v_{\lambda_{0}}(x)<v(x)$ in $B_{\lambda_{0}}(0) \backslash\{0\}$. In particular, $\gamma=\inf _{\partial B_{\frac{\lambda_{0}}{2}}}\left[v(x)-v_{\lambda_{0}}(x)\right]>0$.

Set $\varphi(x)=\gamma\left(1-\frac{r^{N-2}}{|x|^{N-2}}\right)$ with $0<r<\frac{\lambda_{0}}{2}$ and $\psi(x)=\left[v(x)-v_{\lambda_{0}}(x)\right]-\varphi(x)$, then we have

$$
\begin{cases}\psi(x)>0 & \text { on } \partial B_{\frac{\lambda_{0}}{2}} \\ \left.\psi(x)\right|_{\partial B_{r}} \geq 0 & \text { on } \partial B_{r} \\ -\Delta \psi(x) \geq 0 & \text { in } \partial B_{\frac{\lambda_{0}}{2}} \backslash B_{r}\end{cases}
$$

We infer from the maximum principle that

$$
v(x)-v_{\lambda_{0}}(x) \geq \gamma\left(1-\frac{r^{N-2}}{|x|^{N-2}}\right)
$$

Let $r \rightarrow 0$, then we get $v(x)-v_{\lambda_{0}}(x) \geq \gamma$ in $B_{\frac{\lambda_{0}}{2}} \backslash\{0\}$. This proves the claim.
If the conclusion of this lemma does not hold, then there exists a sequence $\lambda_{n}$ with $\lambda_{n}<\lambda_{0}, \lambda_{n} \rightarrow \lambda_{0}$ and $\inf _{B_{\lambda_{n}} \backslash\{0\}}\left[v(x)-v_{\lambda_{n}}(x)\right]<0$. We deduce from the above claim that $v(x)-v_{\lambda_{n}}(x) \geq \frac{\gamma}{2}>0$ for $n$ large enough. Hence, $\inf _{B_{\lambda_{n}} \backslash\{0\}}\left[v(x)-v_{\lambda_{n}}(x)\right]$ is attained at some $x_{n}$ with $\frac{\lambda_{0}}{2}<\left|x_{n}\right|<\lambda_{n}$. In particular, we have $v\left(x_{n}\right)-v_{\lambda_{n}}\left(x_{n}\right)<0$ and $\nabla\left(v\left(x_{n}\right)-\right.$ $\left.v_{\lambda_{n}}\left(x_{n}\right)\right)=0$.

We can assume that, up to a subsequence, $x_{n} \rightarrow x_{0}$, then we conclude that $x_{0} \in \partial B_{\lambda_{0}}$ and $\nabla\left(v\left(x_{0}\right)-v_{\lambda_{0}}\left(x_{0}\right)\right)=0$. However, this contradicts to the Hopf Lemma.

Lemma 3.7. For all $b \in \mathbb{R}^{N}$, we have $\lambda_{b}>0$.
Proof. Since we have proved $\lambda_{\bar{b}}>0$ for some $\bar{b} \in \mathbb{R}^{N}$, it follows from Lemma 3.6 that

$$
v_{\bar{b}}(x)=\frac{\lambda_{\bar{b}}^{N-2}}{|x|^{N-2}} v_{\bar{b}}\left(\frac{\lambda_{\bar{b}}^{2} x}{|x|^{2}}\right)
$$

for $x \neq 0$. That is

$$
\frac{\lambda_{\bar{b}}^{N-2}}{|x|^{N-2}} u_{\bar{b}}\left(\frac{x}{|x|^{2}}\right)=u_{\bar{b}}\left(\frac{x}{\lambda_{\bar{b}}^{2}}\right) .
$$

for $x \neq 0$. Let $y=\frac{x}{|x|^{2}}$ and $|y| \rightarrow \infty$, we get

$$
\begin{equation*}
\lim _{|y| \rightarrow \infty}|y|^{N-2} u_{\bar{b}}(y)=\frac{1}{\lambda_{\bar{b}}^{N-2}} u_{\bar{b}}(0) \tag{3.16}
\end{equation*}
$$

On the other hand, if the conclusion of the lemma does not hold, then there exists $b \in \mathbb{R}^{N}$, such that

$$
v_{b}(x) \geq \frac{\lambda^{N-2}}{|x|^{N-2}} v_{b}\left(\frac{\lambda^{2} x}{|x|^{2}}\right)
$$

for all $\lambda>0$ and $x \in B_{\lambda} \backslash\{0\}$. That is

$$
\frac{1}{|x|^{N-2}} u_{b}\left(\frac{x}{|x|^{2}}\right) \geq \frac{1}{\lambda^{N-2}} u_{b}\left(\frac{x}{\lambda^{2}}\right)
$$

for all $\lambda>0$ and $x \in B_{\lambda} \backslash\{0\}$. Letting $x \rightarrow 0$ and using (3.16), we obtain

$$
\frac{\lambda^{N-2}}{\lambda_{\bar{b}}^{N-2}} u_{\bar{b}}(0) \geq u_{b}(0)
$$

for all $\lambda>0$, which is impossible for $\lambda$ small.

Lemma 3.8. The positive solution $u$ of problem (1.10) must have the following form

$$
u(x)=C\left(\frac{\varepsilon}{\varepsilon^{2}+\left|x-x_{0}\right|^{2}}\right)^{\frac{N-2}{2}}
$$

for $\varepsilon>0$.
Proof. By Lemmas 3.6 and 3.7, for all $b \in \mathbb{R}^{N}$, there holds

$$
u(x)=\frac{\lambda_{b}^{N-2}}{|x-b|^{N-2}} u\left(\frac{\lambda_{b}^{2}(x-b)}{|x-b|^{2}}+b\right)
$$

which implies

$$
\lim _{|x| \rightarrow \infty}|x|^{N-2} u(x)=\lambda_{b}^{N-2} u(b)=\lambda_{0}^{N-2} u(0)=B>0
$$

If $B=1$, we have

$$
\begin{equation*}
u(x)=\frac{\lambda_{0}^{N-2}}{|x|^{N-2}}\left[u(0)+\nabla u(0) \frac{\lambda_{0}^{2} x}{|x|^{2}}+o\left(\frac{1}{|x|}\right)\right] \tag{3.17}
\end{equation*}
$$

and

$$
\begin{equation*}
u(x)=\frac{\lambda_{b}^{N-2}}{|x-b|^{N-2}}\left[u(b)+\nabla u(b) \frac{\lambda_{b}^{2}(x-b)}{|x-b|^{2}}+o\left(\frac{1}{|x-b|}\right)\right] \tag{3.18}
\end{equation*}
$$

as $x \rightarrow+\infty$. Replacing

$$
\frac{1}{|x-b|^{N-2}}=\frac{1}{|x|^{N-2}}+(N-2) \frac{x \cdot b}{|x|^{N}}+O\left(\frac{1}{|x|^{N}}\right)
$$

and

$$
\frac{1}{|x-b|^{2}}=\frac{1}{|x|^{2}}+2 \frac{x \cdot b}{|x|^{4}}+O\left(\frac{1}{|x|^{4}}\right)
$$

into (3.18) we find

$$
\begin{equation*}
u(x)=\lambda_{b}^{N-2}\left[\frac{u(b)}{|x|^{N-2}}+(N-2) \frac{x \cdot b u(b)}{|x|^{N}}+\frac{\nabla u(b) \cdot x \lambda_{b}^{2}}{|x|^{N}}+O\left(\frac{1}{|x|^{N}}\right)\right] . \tag{3.19}
\end{equation*}
$$

Comparing the coefficients of $\frac{1}{|x|^{N-2}}$ and $\frac{x}{|x|^{N}}$ in (3.17) and (3.19), we obtain

$$
\lambda_{0}^{N-2} u(0)=\lambda_{b}^{N-2} u(b)
$$

and

$$
\begin{equation*}
\nabla u(0) \lambda_{0}^{N}=\nabla u(b) \lambda_{b}^{N}+(N-2) b u(b) \lambda_{b}^{N-2} \tag{3.20}
\end{equation*}
$$

It follows from $B=1$ that $\lambda_{b}=u(b)^{-\frac{1}{N-2}}$ and $\lambda_{0}=u(0)^{-\frac{1}{N-2}}$, hence (3.20) can be written as

$$
u^{-\frac{N}{N-2}}(b) \frac{\partial u}{\partial x_{i}}(b)=u^{-\frac{N}{N-2}}(0) \frac{\partial u}{\partial x_{i}}(0)-(N-2) b_{i} .
$$

Therefore, we have

$$
u^{-\frac{2}{N-2}}(x)=\left|x-x_{0}\right|^{2}+d
$$

or

$$
u(x)=\left(\frac{1}{d+\left|x-x_{0}\right|^{2}}\right)^{\frac{N-2}{2}}
$$

If $B \neq 1$, the same argument shows that

$$
u(x)=C\left(\frac{\varepsilon}{\varepsilon^{2}+\left|x-x_{0}\right|^{2}}\right)^{\frac{N-2}{2}}
$$

for $\varepsilon>0$.

## 4. A positive solution

In this section, we show that there is a positive solution of (1.1) at the mountain pass value

$$
\begin{equation*}
c_{\lambda, \Omega}=\inf _{\gamma \in \Gamma} \max _{t \in[0,1]} I_{\lambda, \Omega}(\gamma(t)), \tag{4.1}
\end{equation*}
$$

where

$$
\Gamma:=\left\{\gamma \in C\left([0,1], H_{0}^{1}(\Omega)\right): \gamma(0)=0, I_{\lambda, \Omega}(\gamma(1)) \leq 0, \gamma(1) \neq 0\right\}
$$

Let

$$
\begin{equation*}
\mathcal{N}_{\lambda, \Omega}=\left\{u \in H_{0}^{1}(\Omega) \backslash\{0\}:\left\langle I_{\lambda, \Omega}^{\prime}(u), u\right\rangle=0\right\} \tag{4.2}
\end{equation*}
$$

We may verify that $\mathcal{N}_{\lambda, \Omega}$ is a manifold, and for each $u \in H_{0}^{1}(\Omega)$, there is a unique $t_{u}>0$ such that $t_{u} u \in \mathcal{N}_{\lambda, \Omega}$. Define

$$
\begin{equation*}
m_{\lambda, \Omega}=\inf \left\{I_{\lambda, \Omega}(u): u \in \mathcal{N}_{\lambda, \Omega}\right\} \tag{4.3}
\end{equation*}
$$

and

$$
\begin{equation*}
c_{\lambda, \Omega}^{s}=\inf _{u \in H_{0}^{1}(\Omega) \backslash\{0\}} \sup _{t>0} I_{\lambda, \Omega}(t u) \tag{4.4}
\end{equation*}
$$

Arguing as the proof of Theorem 4.2 in [25], we see that

$$
\begin{equation*}
m_{\lambda, \Omega}=c_{\lambda, \Omega}=c_{\lambda, \Omega}^{s} \tag{4.5}
\end{equation*}
$$

It was proved in [13] the following Brézis-Lieb type lemma.

Lemma 4.1. Let $N \geq 3$ and $0<\alpha<N$. If $\left\{u_{n}\right\}$ is a bounded sequence in $L^{\frac{2 N}{N-2}}\left(\mathbb{R}^{N}\right)$ and $u_{n} \rightarrow u$ almost everywhere in $\mathbb{R}^{N}$ as $n \rightarrow \infty$. Then we have

$$
\begin{aligned}
& \lim _{n \rightarrow \infty} \int_{\mathbb{R}^{N}}\left(|x|^{-(N-\alpha)} *\left|u_{n}\right|^{2_{\alpha}^{*}}\right)\left|u_{n}\right|^{2_{\alpha}^{*}} d x-\int_{\mathbb{R}^{N}}\left(|x|^{-(N-\alpha)} *\left|u_{n}-u\right|^{2_{\alpha}^{*}}\right)\left|u_{n}-u\right|^{2_{\alpha}^{*}} d x \\
& =\int_{\mathbb{R}^{N}}\left(|x|^{-(N-\alpha)} *|u|^{2_{\alpha}^{*}}\right)|u|^{2_{\alpha}^{*}} d x .
\end{aligned}
$$

We derive from Lemma 4.1 the following result.
Lemma 4.2. The functional $I_{\lambda, \Omega}$ satisfies $(P S)_{c}$ condition if $c<m\left(\mathbb{R}^{N}\right)$.
Proof. Let $\left\{u_{n}\right\} \subset H_{0}^{1}(\Omega)$ be a $(P S)_{c}$ sequence of $I_{\lambda, \Omega}$ with $c<m\left(\mathbb{R}^{N}\right)$, that is,

$$
I_{\lambda, \Omega}\left(u_{n}\right) \rightarrow c, \quad I_{\lambda, \Omega}^{\prime}\left(u_{n}\right) \rightarrow 0
$$

as $n \rightarrow \infty$. This yields

$$
c+o(1)=\left(\frac{1}{2}-\frac{1}{p}\right) \lambda \int_{\Omega} u_{n}^{p} d x+\sum_{i=1}^{k}\left(\frac{1}{2}-\frac{1}{22_{i}^{*}}\right) \int_{\Omega} \int_{\Omega} \frac{u_{n}^{2_{i}^{*}}(x) u_{n}^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y
$$

implying that there is a positive constant $C$ such that for $i=1,2, \cdots, k$,

$$
\int_{\Omega} u_{n}^{p} d x \leq C, \quad \int_{\Omega} \int_{\Omega} \frac{u_{n}^{2_{n}^{*}}(x) u_{n}^{2_{n}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y \leq C
$$

and then $\left\{u_{n}\right\}$ is bounded in $H_{0}^{1}(\Omega)$. So we may assume that

$$
\begin{equation*}
u_{n} \rightharpoonup u_{0} \quad \text { in } \quad H_{0}^{1}(\Omega) ; \quad u_{n} \rightarrow u_{0} \quad \text { a.e. } \quad \text { in } \quad \Omega ; \quad u_{n} \rightarrow u_{0} \quad \text { in } \quad L^{p}(\Omega) . \tag{4.6}
\end{equation*}
$$

The weak convergence implies that $I_{\lambda, \Omega}^{\prime}\left(u_{0}\right)=0$, namely, $u_{0}$ is a weak solution of (1.1). Moreover, $I_{\lambda, \Omega}\left(u_{0}\right) \geq 0$. Let $v_{n}=u_{n}-u_{0}$. By Lemma 4.1 and (4.6), we deduce that

$$
\begin{equation*}
o(1)=\left\langle I_{\lambda, \Omega}^{\prime}\left(v_{n}\right), v_{n}\right\rangle+\left\langle I_{\lambda, \Omega}^{\prime}\left(u_{0}\right), u_{0}\right\rangle=\left\langle I_{\lambda, \Omega}^{\prime}\left(v_{n}\right), v_{n}\right\rangle \tag{4.7}
\end{equation*}
$$

and

$$
\begin{equation*}
c+o(1)=I_{\lambda, \Omega}\left(v_{n}\right)+I_{\lambda, \Omega}\left(u_{0}\right) \geq I_{\lambda, \Omega}\left(v_{n}\right) \tag{4.8}
\end{equation*}
$$

Suppose now on the contrary that $u_{n}$ does not converge strongly to $u_{0}$ in $H_{0}^{1}(\Omega)$, then $v_{n}=u_{n}-u_{0} \nrightarrow 0$ in $H_{0}^{1}(\Omega)$ as $n \rightarrow \infty$. Extending $v_{n}$ to $\mathbb{R}^{N}$ by setting $v_{n}=0$ outside $\Omega$. Then, there is $t_{n}>0, t_{n} \rightarrow 1$ as $n \rightarrow \infty$ such that $t_{n} v_{n} \in \mathcal{M}_{\mathbb{R}^{N}}$. We derive from (4.7) and (4.8) that $c \geq m\left(\mathbb{R}^{N}\right)$ a contradiction. The assertion follows.

Now, we verify the condition in Lemma 4.2. Without loss of generality, we assume $B_{2 r}(0) \subset \Omega$ for $r>0$ small. Let $\varphi \in C_{0}^{1}\left(B_{2 r}(0)\right)$ be a cut-off function satisfying $\varphi \equiv 1$ on $B_{r}(0)$. Define

$$
\begin{equation*}
U_{\varepsilon}(x)=\varepsilon^{-\frac{N-2}{2}} U\left(\frac{x}{\varepsilon}\right), \quad u_{\varepsilon}(x)=\varphi(x) U_{\varepsilon}(x) \tag{4.9}
\end{equation*}
$$

where $U(x)=\frac{C}{\left(1+|x|^{2}\right)^{\frac{N-2}{2}}}$ is the minimizer of $m\left(\mathbb{R}^{N}\right)$.

Lemma 4.3. There holds $c_{\lambda, \Omega}<m\left(\mathbb{R}^{N}\right)$.
Proof. We may verify as [13] that

$$
\begin{equation*}
\int_{\Omega}\left|\nabla u_{\varepsilon}(x)\right|^{2} d x=\int_{\mathbb{R}^{N}}|\nabla U(x)|^{2} d x+O\left(\varepsilon^{N-2}\right) \tag{4.10}
\end{equation*}
$$

and for each $i$,

$$
\begin{equation*}
\int_{\Omega} \int_{\Omega} \frac{u_{\varepsilon}^{2_{i}^{*}}(x) u_{\varepsilon}^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y=\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{U^{2_{i}^{*}}(x) U^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y+O\left(\varepsilon^{N+\alpha_{i}}\right) \tag{4.11}
\end{equation*}
$$

Denote

$$
d_{p}=\int_{\mathbb{R}^{N}} U^{p}(x) d x
$$

Since $2<p<2_{m i n}^{*}$, we have $N-(N-2) p<0$ and $N-\frac{(N-2) p}{2}>0$ if $N \geq 4$. Hence,

$$
\begin{aligned}
\int_{\Omega} u_{\varepsilon}^{p}(x) d x & \geq \int_{B_{r}(0)} U_{\varepsilon}^{p}(x) d x=\left(\int_{\mathbb{R}^{N}}-\int_{B_{r}^{c}(0)}\right) U_{\varepsilon}^{p}(x) d x \\
& =\varepsilon^{N-\frac{(N-2) p}{2}} d_{p}+O\left(\varepsilon^{\frac{(N-2) p}{2}}\right) .
\end{aligned}
$$

and

$$
\begin{aligned}
\int_{\Omega} u_{\varepsilon}^{p}(x) d x & \leq \int_{B_{2 r}(0)} U_{\varepsilon}^{p}(x) d x=\left(\int_{\mathbb{R}^{N}}-\int_{B_{2 r}^{c}(0)}\right) U_{\varepsilon}^{p}(x) d x \\
& =\varepsilon^{N-\frac{(N-2) p}{2}} d_{p}+O\left(\varepsilon^{\frac{(N-2) p}{2}}\right) .
\end{aligned}
$$

Thus,

$$
\begin{equation*}
\int_{\Omega} u_{\varepsilon}^{p}(x) d x=\varepsilon^{N-\frac{(N-2) p}{2}} d_{p}+O\left(\varepsilon^{\frac{(N-2) p}{2}}\right) . \tag{4.12}
\end{equation*}
$$

We know that there exists $t_{\varepsilon}>0$ such that $t_{\varepsilon} u_{\varepsilon} \in \mathcal{N}_{\lambda, \Omega}$, that is,

\end{equation*}
$$

By (4.10) - (4.12),

\begin{align*}
\int_{\mathbb{R}^{N}}|\nabla U|^{2} d x+O\left(\varepsilon^{N-2}\right) & =\lambda t_{\varepsilon}^{p-2}\left(\varepsilon^{N-\frac{(N-2) p}{2}} d_{p}+O\left(\varepsilon^{\frac{(N-2) p}{2}}\right)\right) \\
& +\sum_{i=1}^{k} t_{\varepsilon}^{22_{i}^{*}-2}\left(\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{U^{2_{i}^{*}}(x) U^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y+O\left(\varepsilon^{\frac{N+\alpha_{i}}{2}}\right)\right) . \tag{4.14}
\end{align*}
$$

The fact $U \in \mathcal{M}_{\mathbb{R}^{N}}$ implies $t_{\varepsilon} \rightarrow 1$ as $\varepsilon \rightarrow 0$. Therefore, $t_{\varepsilon}=1+o(1)$ and the derivative $t_{\varepsilon}^{\prime}$ of $t_{\varepsilon}$ is given by

$$

Hence, there exists $C_{p}>0$ such that

c_{\lambda, \Omega} & \leq I_{\lambda, \Omega}\left(t_{\varepsilon} u_{\varepsilon}\right)=\frac{1-2 C_{p} \varepsilon^{N-\frac{(N-2) p}{2}}(1+o(1))}{2}\left(\int_{\mathbb{R}^{N}}|\nabla U(x)|^{2} d x+O\left(\varepsilon^{N-2}\right)\right) \\
& -\frac{1-p C_{p} \varepsilon^{N-\frac{(N-2) p}{2}}(1+o(1))}{p}\left(\lambda \varepsilon^{N-\frac{(N-2) p}{2}} d_{p}+O\left(\varepsilon^{\frac{(N-2) p}{2}}\right)\right) \\
& -\sum_{i=1}^{k} \frac{1-2_{i}^{*} C_{p} \varepsilon^{N-\frac{(N-2) p}{2}}(1+o(1))}{2_{i}^{*}}\left(\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{U^{2_{i}^{*}}(x) U^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y+O\left(\varepsilon^{\frac{N+\alpha_{i}}{2}}\right)\right) \\
& =m\left(\mathbb{R}^{N}\right)-\frac{1}{p} \lambda \varepsilon^{N-\frac{(N-2) p}{2}} d_{p}(1+o(1))<m\left(\mathbb{R}^{N}\right)
\end{aligned}
$$

if $\varepsilon>0$ small enough.

Proof of Theorem 1.2. Since $m_{\lambda, \Omega}=c_{\lambda, \Omega}$, let $\left\{u_{n}\right\} \subset \mathcal{N}_{\lambda, \Omega}$ be a minimizing sequence of $I_{\lambda, \Omega}$. Lemmas 4.2 and 4.3 imply $\left\{u_{n}\right\}$ contains a convergent subsequence, the result readily follows.

## 5. Multiple solutions

In this section, we prove that problem (1.1) possesses at least $\operatorname{cat}_{\Omega}(\Omega)$ positive solutions. Denote

\Omega_{r}^{+}=\left\{x \in \mathbb{R}^{N}: d(x, \Omega) \leq r\right\} \quad \text { and } \quad \Omega_{r}^{-}=\{x \in \Omega: d(x, \partial \Omega) \geq r\}

Choose $r>0$ so that $\Omega_{r}^{+}, \Omega_{r}^{-}$and $\Omega$ are homotopically equivalent.
Let

J_{\Omega}(u)=\frac{1}{2} \int_{\Omega}|\nabla u|^{2} d x-\sum_{i=1}^{k} \frac{1}{22_{i}^{*}} \int_{\Omega} \int_{\Omega} \frac{u(x)^{2_{i}^{*}} u(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y
$$

and define

\mathcal{M}_{\Omega}=\left\{u \in H_{0}^{1}(\Omega) \backslash\{0\}:\left\langle J_{\Omega}^{\prime}(u), u\right\rangle=0\right\} .
$$

We define as (4.1) and (4.4) that

b_{m}=\inf _{\gamma \in \Gamma} \max _{t \in[0,1]} J(\gamma(t)),
$$

where

$$
\Gamma:=\left\{\gamma \in C\left([0,1], D^{1,2}\left(\mathbb{R}^{N}\right)\right): \gamma(0)=0, J(\gamma(1)) \leq 0, \gamma(1) \neq 0\right\}
$$

and

$$
b_{s}=\inf _{u \in D^{1,2}\left(\mathbb{R}^{N}\right) \backslash\{0\}} \sup _{t>0} J(t u)
$$

We also have

m_{\mathbb{R}^{N}}=b_{m}=b_{s}
$$

We recall that a measurable function $u: \mathbb{R}^{N} \rightarrow \mathbb{R}$ belongs to the Morrey space $\mathcal{L}^{p, \mu}\left(\mathbb{R}^{N}\right)$ with $p \in[1, \infty)$ and $\mu \in(0, N]$, if and only if

Proposition 5.1. Let $\left\{u_{n}\right\} \subset \mathcal{M}_{\Omega}$ be a sequence such that $J_{\Omega}\left(u_{n}\right) \rightarrow m\left(\mathbb{R}^{N}\right)$ as $n \rightarrow \infty$. Then there exist $\left(\gamma_{n}, x_{n}\right) \in \mathbb{R}_{+} \times \Omega$ such that

v_{n}(x)=\gamma_{n}^{\frac{N-2}{2}} u_{n}\left(\gamma_{n} x+x_{n}\right)

contains a convergent subsequence in $D^{1,2}\left(\mathbb{R}^{N}\right)$. Moreover, $\gamma_{n} \rightarrow 0, x_{n} \rightarrow x \in \bar{\Omega}$ and $v_{n} \rightarrow U$ in $D^{1,2}\left(\mathbb{R}^{N}\right)$.
Proof. Since $\left\{u_{n}\right\} \subset \mathcal{M}_{\Omega}$, we have

\end{equation*}

Extending $u_{n}$ to $\mathbb{R}^{N}$ by setting $u_{n}=0$ outside $\Omega$ if necessary, then we have

m\left(\mathbb{R}^{N}\right)+o(1)=J_{\Omega}\left(u_{n}\right)=\sum_{i=1}^{k}\left(\frac{1}{2}-\frac{1}{22_{i}^{*}}\right) \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y \tag{5.3}
\end{equation*}
$$

which implies that for all $i=1, \cdots, k$, there exists $C>0$ such that

\int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y \leq C

By (5.2), $\left\{u_{n}\right\}$ is uniformly bounded in $H_{0}^{1}(\Omega)$. Moreover, by the definition of $S_{i}=S_{\alpha_{i}}$ in (1.3) and Sobolev embedding, we have

Hence, there exists $C>0$ such that $\left\|u_{n}\right\|_{H_{0}^{1}(\Omega)} \geq C$, and we deduce from (5.2) that

for some $\sigma>0$. Extending $u_{n}$ to $\mathbb{R}^{N}$ by setting $u_{n}=0$ outside $\Omega$, we infer from the Hardy-Littlewood-Sobolev inequality that

The improved Sobolev inequality

\left\|u_{n}\right\|_{L^{2^{*}}\left(\mathbb{R}^{N}\right)} \leq\left\|u_{n}\right\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}^{\theta}\left\|u_{n}\right\|_{\mathcal{L}^{2, N-2}\left(\mathbb{R}^{N}\right)}^{1-\theta} \tag{5.6}
\end{equation*}
$$

in [23] together with (5.5) yield

\left(\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{u_{n}(x)^{2_{1}^{*}} u_{n}(y)^{2_{1}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y\right)^{\frac{N-2}{2(N+\alpha)}} \leq\left\|u_{n}\right\|_{D^{1,2}\left(\mathbb{R}^{N}\right)}^{\theta}\left\|u_{n}\right\|_{\mathcal{L}^{2}, N-2\left(\mathbb{R}^{N}\right)}^{1-\theta} \tag{5.7}
\end{equation*}
$$

where $\frac{N-2}{N} \leq \theta<1$. Since $\left\{u_{n}\right\}$ is bounded in $D^{1,2}\left(\mathbb{R}^{N}\right)$, (5.4) implies

for some $\sigma_{1}>0$. Note that for each $n$, the support of $u_{n}$ is contained in $\Omega$, then there exist $x_{n} \in \Omega$ and $\gamma_{n} \in \mathbb{R}$ such that

Let $v_{n}(x)=\gamma_{n}^{\frac{N-2}{2}} u_{n}\left(\gamma_{n} x+x_{n}\right)$. Then

We remark that $\left\{v_{n}\right\} \subset \mathcal{M}_{\mathbb{R}^{N}}$ and $I\left(v_{n}\right) \rightarrow m\left(\mathbb{R}^{N}\right)$ as $n \rightarrow \infty$. Therefore, $\left\{v_{n}\right\}$ is bounded in $D^{1,2}\left(\mathbb{R}^{N}\right)$, and we may assume that

v_{n} \rightharpoonup v_{0} \quad \text { in } \quad D^{1,2}\left(\mathbb{R}^{N}\right) ; \quad v_{n} \rightarrow v_{0} \in L_{l o c}^{p}\left(\mathbb{R}^{N}\right) ; \quad v_{n} \rightarrow v_{0} \quad \text { a.e. } \quad \mathbb{R}^{N}
$$

As a result of (5.9), $v_{0} \not \equiv 0$.
Now, we show that $J\left(v_{0}\right)=b_{s}$. Indeed, using the fact that $\left\langle J^{\prime}\left(v_{n}\right), v_{n}\right\rangle=o(1)$, we obtain

b_{s}=\sum_{i=1}^{k} \frac{1}{2}\left(\frac{1}{2}-\frac{1}{2_{i}^{*}}\right) \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\left|v_{n}(x)\right|^{2_{i}^{*}}\left|v_{n}(y)\right|^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y+o(1)
$$

By Lemma 4.1,

\lim _{n \rightarrow \infty} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\left|v_{n}(x)\right|^{2_{i}^{*}}\left|v_{n}(y)\right|^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y \geq \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\left|v_{0}(x)\right|^{2_{i}^{*}}\left|v_{0}(y)\right|^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y
$$

and using the fact $\left\langle J^{\prime}\left(v_{0}\right), \varphi\right\rangle=0$ for $\varphi \in D^{1,2}\left(\mathbb{R}^{N}\right)$, we obtain

b_{s} \geq \sum_{i=1}^{k} \frac{1}{2}\left(\frac{1}{2}-\frac{1}{2_{i}^{*}}\right) \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\left|v_{0}(x)\right|^{2_{i}^{*}}\left|v_{0}(y)\right|^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y=J\left(v_{0}\right) \geq m\left(\mathbb{R}^{N}\right)=b_{m}=b_{s}
$$

Next, we show that actually $v_{n}$ converges strongly to $v$ in $D^{1,2}\left(\mathbb{R}^{N}\right)$. In fact, we deduce from $\lim _{n \rightarrow \infty} J\left(v_{n}\right)=b_{s}=J\left(v_{0}\right)$ and $\left\langle J^{\prime}\left(v_{n}\right), v_{n}\right\rangle=\left\langle J^{\prime}\left(v_{0}\right), v_{0}\right\rangle+o(1)$ as well as Lemma 4.1 that

$$
J\left(v_{n}-v_{0}\right)=o(1) \quad \text { and } \quad\left\langle J^{\prime}\left(v_{n}-v_{0}\right), v_{n}-v_{0}\right\rangle=o(1)
$$

leading to the result. By Theorem 1.1, $v_{0}=U$.
Finally, we show that $\gamma_{n} \rightarrow 0$ as $n \rightarrow \infty$. Suppose on the contrary that $\gamma_{n} \nrightarrow 0$ as $n \rightarrow \infty$, then we have, up to a subsequence, either $\gamma_{n} \rightarrow \gamma_{0}>0$ or $\gamma_{n} \rightarrow \infty$.

If $\gamma_{n} \rightarrow \gamma_{0}$, we see that supp $v_{n}$ is contained in a bounded domain, so does supp $v_{0}$. However, $v_{0}=U$, which is a contradiction.

If $\gamma_{n} \rightarrow \infty$, the boundedness of $\left\{u_{n}\right\}$ in $H_{0}^{1}(\Omega)$ yields

\gamma_{n}^{-2} \int_{B_{\gamma_{n}}\left(x_{n}\right)}\left|u_{n}(y)\right|^{2} d y \leq \gamma_{n}^{-2}\left(\int_{\Omega}\left|u_{n}(y)\right|^{2^{*}} d y\right)^{\frac{N-2}{N}}\left(\int_{\Omega} 1 d y\right)^{\frac{2}{N}} \leq \frac{C}{\gamma_{n}} \rightarrow 0
$$

as $n \rightarrow \infty$, which contradicts to (5.8).

We may assume that $B_{r}(0) \subset \Omega$ and define

By Theorem 1.2, $m(\lambda, r)$ is achieved by a positive function, which is radially symmetric about the origin. We remark that $m(\lambda, r)$ does not depend on the choice of the center of the ball, but only on the radius. So for every $x \in \mathbb{R}^{N}$, we have $m(\lambda, r)=m\left(\lambda, B_{r}(x)\right)$. Obviously, $m(\lambda, \Omega)<m(\lambda, r)$.

Denote

\|u\|_{H L}^{22_{i}^{*}}=\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{u^{2_{i}^{*}}(x) u^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y

Let $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{N}, \mathbb{R}^{N}\right)$ be such that $\eta(x)=x$ for all $x \in \bar{\Omega}$. We introduce the barycenter of a function $u \in H^{1}\left(\mathbb{R}^{N}\right)$ as

Lemma 5.2. There exists $\lambda^{*}>0$ such that if $\lambda \in\left(0, \lambda^{*}\right)$ and $u \in \mathcal{N}_{\lambda, \Omega}$ satisfying $I_{\lambda, \Omega}(u)<$ $m(\lambda, r)$, then $\beta(u) \in \Omega_{r}^{+}$.
Proof. We argue indirectly. Suppose by condition that there exist $\lambda_{n} \rightarrow 0, u_{n} \in \mathcal{N}_{\lambda_{n}, \Omega}$ such that

$g_{u_{n}}(t)=I_{\lambda_{n}, \Omega}\left(t u_{n}\right)=\frac{t^{2}}{2} \int_{\Omega}\left|\nabla u_{n}\right|^{2} d x-\frac{t^{p}}{p} \lambda_{n} \int_{\Omega} u_{n}^{p} d x-\sum_{i=1}^{k} \frac{t^{22_{i}^{*}}}{22_{i}^{*}} \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y$.

For each fixed $n, g_{u_{n}}(0)=0, g_{u_{n}}(t) \rightarrow-\infty$ if $t \rightarrow \infty$. Thus there exists a maximum point $t_{n}>0$ of $g_{u_{n}}(t)$ such that $g_{u_{n}}^{\prime}\left(t_{n}\right)=0$. We claim that the maximum point $t_{n}>0$ is unique. Indeed,
$g_{u_{n}}^{\prime}(t)=t \int_{\Omega}\left|\nabla u_{n}\right|^{2} d x-t^{p-1} \lambda_{n} \int_{\Omega} u_{n}^{p} d x-\sum_{i=1}^{k} t^{22_{i}^{*}-1} \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y=t h_{u_{n}}(t)$,
where

h_{u_{n}}(t)=\int_{\Omega}\left|\nabla u_{n}\right|^{2} d x-t^{p-2} \lambda_{n} \int_{\Omega} u_{n}^{p} d x-\sum_{i=1}^{k} t^{22_{i}^{*}-2} \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y
$$

Apparently, there exists unique $t_{n}>0$ such that $h_{u_{n}}\left(t_{n}\right)=0$, which is the maximum point of $g_{u_{n}}(t)$. Since $u_{n} \in \mathcal{N}_{\lambda_{n}, \Omega}$, we get $t_{n}=1$, that is,

Moreover, by the definition of $S_{i}=S_{\alpha_{i}}$ in (1.3) and Sobolev embedding, we may prove as the proof of Proposition 5.1 that there exists $C>0$ such that $C^{-1} \leq\left\|u_{n}\right\|_{H_{0}^{1}(\Omega)} \leq C$. Solving

$$
\left\|s u_{n}\right\|_{H_{0}^{1}(\Omega)}^{2}=\sum_{i=1}^{k} s^{22_{i}^{*}} \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y
$$

we find there exists a unique $s_{n}>0$ such that $s_{n} u_{n} \in \mathcal{M}_{\lambda_{n}, \Omega}$, that is,

$$
\left\|u_{n}\right\|_{H_{0}^{1}(\Omega)}^{2}=\sum_{i=1}^{k} s_{n}^{22_{i}^{*}-2} \int_{\Omega} \int_{\Omega} \frac{u_{n}(x)^{2_{i}^{*}} u_{n}(y)^{2_{i}^{*}}}{|x-y|^{N-\alpha_{i}}} d x d y
$$

The boundedness of $\left\{u_{n}\right\}$ in $H_{0}^{1}(\Omega)$ implies that $\left\{s_{n}\right\}$ is bounded.
Let $v_{n}(x)=s_{n} u_{n}(x)$. Then, $\left\{v_{n}\right\}$ is uniformly bounded in $H_{0}^{1}(\Omega)$ and $\lambda_{n} \int_{\Omega}\left|v_{n}\right|^{p} d x \rightarrow 0$ as $n \rightarrow \infty$. We conclude by (5.13) that

$$
\begin{align*}
m\left(\mathbb{R}^{N}\right) & \leq J\left(v_{n}\right)=J\left(s_{n} u_{n}\right)=I_{\lambda_{n}, \Omega}\left(s_{n} u_{n}\right)+\lambda_{n} \int_{\Omega}\left|v_{n}\right|^{p} d x  \tag{5.14}\\
& \leq I_{\lambda_{n}, \Omega}\left(u_{n}\right)+o(1) \leq m\left(\mathbb{R}^{N}\right)+o(1)
\end{align*}
$$

which yields

$$
J\left(v_{n}\right) \rightarrow m\left(\mathbb{R}^{N}\right)
$$

as $n \rightarrow \infty$. By Proposition 5.1, there exist $\gamma_{n} \in \mathbb{R}$ and $x_{n} \in \Omega$ such that $x_{n} \rightarrow x_{0} \in \bar{\Omega}$, $w_{n}(x)=\gamma_{n}^{\frac{N-2}{2}} v_{n}\left(\gamma_{n} x+x_{n}\right) \rightarrow U(x)$ in $D^{1,2}\left(\mathbb{R}^{N}\right)$ as $n \rightarrow \infty$. Therefore, the Lebesgue
dominated theorem yields

$$
\begin{align*}
\beta\left(u_{n}\right) & =\beta\left(s_{n} u_{n}\right)=\beta\left(v_{n}\right)=\sum_{i=1}^{k} \frac{1}{\left\|v_{n}\right\|_{H L}^{22_{i}^{*}},} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\eta(x) v_{n}^{2_{i}^{*}}(x) v_{n}^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y \\
& =\sum_{i=1}^{k} \frac{1}{\left\|w_{n}\right\|_{H L,}^{22_{i}^{*}}} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} \frac{\eta\left(\gamma x+x_{n}\right) w_{n}^{2_{i}^{*}}(x) w_{n}^{2_{i}^{*}}(y)}{|x-y|^{N-\alpha_{i}}} d x d y  \tag{5.15}\\
& \rightarrow x_{0} \in \bar{\Omega}
\end{align*}
$$

This contradicts the assumption $\beta\left(u_{n}\right) \notin \Omega_{r}^{+}$. The assertion follows.

Proof of Theorem 1.3: Let $I_{\lambda}^{c}\left(\mathcal{N}_{\lambda, \Omega}\right)=\left\{u \in \mathcal{N}_{\lambda, \Omega}: I_{\lambda}(u) \leq c\right\}$ be a level set. We claim that

$$
\operatorname{cat}_{I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q * \delta}}\left(\mathcal{N}_{\lambda, \Omega)}\right.}\left(I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q *} \delta}\left(\mathcal{N}_{\lambda, \Omega}\right)\right) \geq \operatorname{cat}_{\Omega}(\Omega)
$$

Indeed, let us define $\gamma: \Omega_{r}^{-} \rightarrow I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q^{*} \delta}}\left(\mathcal{N}_{\lambda, \Omega}\right)$ by

$$
\gamma(y)(x)=v(x-y) \quad \text { if } \quad x \in B_{r}(y) ; \quad \gamma(y)(x)=0 \quad \text { if } \quad x \notin B_{r}(y)
$$

where $v \in H_{0}^{1}\left(B_{r}(0)\right)$ is a positive minimizer of $m(\lambda, r)$. We can assume that $v$ is radial, see [21] and references therein. Therefore, $\beta \circ \gamma=i d: \Omega_{r}^{-} \rightarrow \Omega_{r}^{-}$. Suppose now that

$$
n=c a t_{I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q *} \delta}\left(\mathcal{N}_{\lambda, \Omega}\right)}\left(I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q *} \delta}\left(\mathcal{N}_{\lambda, \Omega}\right)\right)
$$

Then

$$
I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q^{*} \delta}}\left(\mathcal{N}_{\lambda, \Omega}\right)=\cup_{i=1}^{n} A_{i}
$$

where $A_{i}, i=1, \ldots, n$, is closed and contractible in $I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{q^{*} \delta}}\left(\mathcal{N}_{\lambda, \Omega}\right)$, that is, there exists $h_{i} \in C\left([0,1] \times A_{i}, I_{\lambda, \Omega}^{m(\lambda, r)+\lambda^{* *} \delta}\left(\mathcal{N}_{\lambda, \Omega}\right)\right)$ such that, for every $u, v \in A_{i}$,

$$
h_{i}(0, u)=u, \quad h_{j}(1, u)=h_{j}(1, v)
$$

Let $B_{i}=\gamma^{-1}\left(A_{i}\right), 1 \leq i \leq n$. Then $B_{i}$ are closed and

$$
\Omega_{r}^{-}=\cup_{i=1}^{n} B_{i} .
$$

By Lemma 5.2 and the deformation

$$
g_{i}(t, x)=\beta\left(h_{i}(t, \gamma(x))\right)
$$

we see that $B_{i}$ is contractible in $\Omega_{r}^{+}$. It follows that

$$
\operatorname{cat}_{\Omega}(\Omega)=c a t_{\Omega_{r}^{+}}\left(\Omega_{r}^{-}\right) \leq \sum_{i=1}^{n} c a t_{\Omega_{r}^{+}}\left(B_{i}\right)=n .
$$

Hence, $I_{\lambda, \Omega}$ has at least $\operatorname{cat}_{\Omega}(\Omega)$ critical points on $\mathcal{N}_{\lambda, \Omega}$. The proof is completed.
