# Small Solitons and Multi-Solitons in Generalized 

Davey-Stewartson System

#### Abstract

This paper is concerned with the generalized Davey-Stewarston system in two dimensional space. Existence and stability of small solitons are proved by solving two correlative constrained variational problems and spectrum analysis. In addition, multi-solitons with different speeds are constructed by bootstrap argument.

## 1 Introduction

Consider the generalized Davey-Stewartson system in two dimensional space,

Here $1<p<\infty$ and $E_{1}$ is the singular integral operator with symbol $\sigma_{1}(\xi)=$ $\frac{\xi_{1}^{2}}{|\xi|^{2}}, \xi \in \mathbb{R}^{2}$, that is $E_{1}(\varphi)(x)=\mathcal{F}^{-1}\left(\frac{\xi_{1}^{2}}{|\xi|^{2}} \mathcal{F}(\varphi)(\xi)\right)$, where $\mathcal{F}$ and $\mathcal{F}^{-1}$ represent the Fourier transform and Fourier inverse transform on $\mathbb{R}^{2}$ respectively, and $\mathcal{F}(\varphi)(\xi)=$

[^0]$\frac{1}{2 \pi} \int e^{-i x \xi} \varphi(x) d x$. Here and hereafter we denote $\int_{\mathbb{R}^{2}} \cdot d x$ by $\int \cdot d x, L^{2}\left(\mathbb{R}^{2}\right)$ by $L^{2}$ and $H^{1}\left(\mathbb{R}^{2}\right)$ by $H^{1}$.
(1.1) origins from fluid mechanics, and it models the evolution of weakly nonlinear water waves having a predominant direction of travel. More precisely, (1.1) is the extension of the Davey-Stewartson systems in the elliptic-elliptic case, namely

$\left(a \in \mathbb{R}, \lambda, \mu, \nu, b_{1}\right.$ and $\left.b_{2}>0\right)$ which describes the time evolution of two-dimensional surface of water wave having a propagation preponderantly in the $x_{1}$-direction (see [7, 13, 16, 25).

Ghidaglia and Saut [13] showed the local well-posedness of the Cauchy problem of (1.1) in the natural energy space $H^{1}$ for $p=3$, then Guo and Wang [16] generalized this result to $1<p<\infty$. Ozawa [24] constructed the exact blow up solutions of the Cauchy problem of (1.1) for $p=3$ (also see the numerical simulation result of Sulem C. and Sulem P. L.[31]). By Ghidaglia and Saut[13] as well as Ohta [27], it was known that the Cauchy problem of (1.1) has blow up solutions to appear for $1<p<\infty$. In addition, Gan and Zhang [12] studied sharp threshold of blow up and global existence for the Cauchy problem of (1.1). In terms of Zhang's argument 38, Zhu [39] got global existence of small solutions with the mass for the Cauchy problem of (1.1).

For $\omega>0$, consider the following nonlinear elliptic equation

\end{equation*}

If $u(x)$ is a non-trivial solution of (1.3), then $e^{i \omega t} u(x)$ is a soliton of (1.1).
Cipolatti 7 proved the existence of positive solutions of (1.3) by means of P. L. Lion's concentration-compactness method (see [20, 21]). Then Cipolatti (see [8]), Ohta [27, Gan and Zhang [12] showed the instability of the solitons of (1.1) for $3 \leq p<\infty$ respectively by different methods. Because of the singular operator $E_{1}$ in (1.3) (see 31), the uniqueness of positive solutions for (1.3) is still open. Under
the assumption of uniqueness of positive solutions of (1.3), Ohta 25 proved that for $1<p<3$, there exists a sequence of frequency $\omega_{n}>0$ such that $\omega_{n} \rightarrow 0$ and the solitons $e^{i \omega_{n} t} Q_{n}$ are stable, where $Q_{n}$ is the unique positive solution of (1.3) corresponding to $\omega_{n}>0$. Moreover Ohta [27] got the stability of the solitons generated by the set of minimizers of the associated variational problem. From [8, 26, 12, the instability of solitons for (1.1) has gotten a comprehensive study. And from 25, 27, further study to stability of solitons for (1.1) becomes an interesting topic. In this paper we develop some new technologyies to study stability of solitons for (1.1).

For $u \in H^{1} \backslash\{0\}$, we define the funtional

Then we consider the variational problem

It is known that (1.5) possesses a positive minimizer $u \in H^{1}$ (see 39). Therefore $d_{J}$ is a positive constant. Moreover, for arbitrary $u \in H^{1}$, one has the sharp interpolation inequality:

Let

where $Q_{\omega}$ is the positive solution of (1.3). Firstly we can prove that $\omega_{J}>0$. Then we prove the following crucial results of stability of solitons for (1.1).

Theorem A. Let $\omega \in\left(0, w_{J}\right), 1<p<3$ and $Q_{\omega}(x)$ is the positive solution of (1.3). Suppose that the positive solution of (1.3) is unique, then the small solitons $e^{i \omega t} Q_{\omega}(x)$ of (1.1) is orbitally stable. Moreover it is true that $\frac{d}{d \omega} \int Q_{\omega}^{2} d x>0$ for all $\omega \in\left(0, \omega_{J}\right)$.

In order to prove Theorem A, we construct and solve two correlative constrained variational problems. Then we ascertain frequency from mass by establishing a one-toone mapping. Finally we bridge Grillakis-Shatah-Strauss method [15] and CazenaveLions method 4 for stability of the solitons by spectrum analysis. It is clear that

Theorem A includes the results in [25, 27]. Moreover technologies developed in this paper can be used to determine frequency from the prescribed mass in the normalized solution problems (see [1, 2, 3, 38). We discuss this problem in other papers.

In terms of Côte and Le Coz's arguments [9, Wang and Cui 35] constructed the high speed excited multi-solitons of (1.1). Multi-solitons are concerned with the famous soliton resolution conjecture, which is emphasized in Tao 32, Zakharov and Shabat [37. The stability of solitons and the soliton resolution problems are crucial topics in understanding the dynamics of nonlinear dispersive evolution equations (see Tao (33). Therefore we use the stable solitons of (1.1) obtained in Theorem A to construct multi-solitons with different speeds for (1.1) according to Martel, Merle and Tsai's scheme (see [22, 23]). We prove the following theorem.

Theorem B: Let $1<p<3$. For $K \geq 2$ and $k=1,2, \cdots, K$, taking $\omega_{k} \in\left(0, \omega_{J}\right)$, $\gamma_{k} \in \mathbb{R}, x_{k} \in \mathbb{R}^{2}, v_{k} \in \mathbb{R}^{2}$ with $v_{k} \neq v_{k^{\prime}}$ to $k \neq k^{\prime}$ and

\end{equation*}

with $(t, x) \in \mathbb{R} \times \mathbb{R}^{2}$, there exists a solution $\varphi(t, x)$ of (1.1) such that

\end{equation*}

The solution $\varphi(t, x)$ of (1.1) holding (1.9) is called multi-soliton of (1.1).

The rest contents of this paper are organized as follows. In section 2, we show global existence of small solutions of the Cauchy problem for (1.1) and existence of solitons for (1.1). In section 3, by solving two correlative constrained variational problems, we establish a one-to-one mapping between mass and frequency. In section 4, we prove orbital stability of small solitons depending on mass for (1.1). Moreover by spectrum analysis, we communicate the relationship between Cazenave-Lions method 4] and Grillakis-Shatah-Strauss method [15]. In addition, we get orbital stability of solitons depending on frequencies $\omega \in\left(0, \omega_{J}\right)$ for (1.1). In section 5 , we construct multisolitons with different speeds for (1.1) by all stable solitons in terms of the bootstrap scheme and the uniform backward estimate according to [9, 22, 23, 35.

## 2 Well-Posedness

For $t_{0} \in \mathbb{R}$, we impose the initial data of (1.1) as follows.

In $H^{1}$, we define the energy functional

E(\varphi)=\int|\nabla \varphi|^{2} d x-\frac{2}{p+1} \int|\varphi|^{p+1} d x-\frac{1}{2} \int E_{1}\left(|\varphi|^{2}\right)|\varphi|^{2} d x \tag{2.2}
\end{equation*}

the mass functional

M(\varphi)=\int|\varphi|^{2} d x \tag{2.3}
\end{equation*}
$$

and the momentum functional

$$
\begin{equation*}
P(\varphi)=\operatorname{Im} \int \bar{\varphi} \nabla \varphi d x \tag{2.4}
\end{equation*}

First we have the following lemma by Zhu [39].
Lemma 2.1. Define the variational problem

d_{J}=\inf _{\left\{\phi \in H^{1} \backslash\{0\}\right\}} J(\phi) \text { with } J(\phi)=\frac{\left(\int|\phi|^{2} d x\right)\left(\int|\nabla \phi|^{2} d x\right)}{\int E_{1}\left(|\phi|^{2}\right)|\phi|^{2} d x} . \tag{2.5}
\end{equation*}
$$

Then (2.5) possesses a nontrivial minimizer and $d_{J}>0$. Moreover for $\phi \in H^{1}$, we have the sharp Gagliardo-Nirenberg type inequality

Then we have the following global well-posedness for (1.1) with small mass.
Theorem 2.2. Let $1<p<3, \varphi_{0} \in H^{1}$ and $\left\|\varphi_{0}\right\|_{L^{2}}<\sqrt{2 d_{J}}$. Then the Cauchy problem (1.1)-(2.1) possesses a unique global solution $\varphi(t, x) \in C\left(\mathbb{R}, H^{1}\right)$ with mass conservation $M(\varphi)=M\left(\varphi_{0}\right)$, energy conservation $E(\varphi)=E\left(\varphi_{0}\right)$ and momentum conservation $P(\varphi)=P\left(\varphi_{0}\right)$ for all $t \in \mathbb{R}$.

Proof. By [6] and [14], for $\varphi_{0} \in H^{1}$ with $\left\|\varphi_{0}\right\|_{L^{2}}<\sqrt{2 d_{J}}$, there exists a unique solution $\varphi(t, x)$ of the Cauchy problem (1.1)-(2.1) in $C\left((-T, T) ; H^{1}\right)$ to some $T>0$ (maximal existence time). And $\varphi(t, \cdot)$ satisfies mass conservation $M(\varphi)=M\left(\varphi_{0}\right)$, energy conservation $E(\varphi)=E\left(\varphi_{0}\right)$ and momentum conservation $P(\varphi)=P\left(\varphi_{0}\right)$ for
all $t \in(-T, T)$. Furthermore one has the alternatives: $T=\infty$ (global existence) or else $T<\infty$ and $\lim _{t \rightarrow T}\|\varphi\|_{H^{1}}=\infty$ (blow up). Thus from (2.2), (2.6), we have that

From the Gagliardo-Nirenberg inequality

\int|\varphi|^{p+1} d x \leq C(p)\left(\int|\varphi|^{2} d x\right)\left(\int|\nabla \varphi|^{2} d x\right)^{\frac{p-1}{2}}, \varphi \in H^{1} \tag{2.8}
\end{equation*}

mass conservation and energy conservation, (2.7) yields that

C_{1} \int|\nabla \varphi|^{2} d x-C_{2}\left(\int|\nabla \varphi|^{2} d x\right)^{\frac{p-1}{2}} \leq E\left(\varphi_{0}\right) \tag{2.9}
\end{equation*}
$$

where $C_{1}$ and $C_{2}$ are positive constants only concerning $d$ and $\varphi_{0} \in H^{1}$. From $1<p<3, \int|\nabla \varphi|^{2} d x$ is bounded for $t \in(-T, T)$ with any $T<\infty$. Therefore combining with the mass conservation, we get that $\varphi(t, x)$ globally exists in $t \in$ $(-\infty, \infty)$. Moreover, the mass conservation and the energy conservation, as well as the momentum conservation are true to all $t \in \mathbb{R}$.

This proves Theorem 2.2.
Theorem 2.3. Let $1<p<3$ and $\omega \in \mathbb{R}$. Then the necessary condition for the nonlinear elliptic equation

\end{equation*}

to possess nontrivial solutions is $\omega>0$.
Proof. Let $u(x)$ be a nontrivial solution of (2.10). By the Pohozaev's identity (see [28]), we have that,

\int E_{1}\left(|u|^{2}\right)|u|^{2} d x=\int|u|^{2} \mathcal{F}^{-1}\left(\sigma_{1}(\xi) \mathcal{F}\left(|u|^{2}\right)\right) d x=\int \sigma_{1}(\xi)\left|\mathcal{F}\left(|u|^{2}\right)\right|^{2} d \xi>0 \tag{2.12}
\end{equation*}
$$

from (2.11) it follows that $\omega>0$.
This proves Theorem 2.3.
From Cipolatti 7 we state the following lemma.

Lemma 2.4. Let $1<p<3$ and $\omega>0$. Then the nonlinear elliptic equation (2.10) possesses a positive solution $Q_{\omega}(x)$, and $Q_{\omega}(x)$ has exponential decay property with $C_{1}, C_{2}>0$ :

In addition, let $E_{j}, j=1,2$ be the pseudo-differential operator with symbol $\sigma_{j}(\xi)=$ $\frac{\xi_{1} \xi_{j}}{|\xi|^{2}}$. Then $E_{j}\left(\left|Q_{\omega}(x)\right|^{2}\right)$ has exponential decay property:

Proof. The proof of (2.13) is from [7]. For reader's convenience, we give the proof of (2.14) (also see [35]). Let $f=\mathcal{B} *\left|Q_{\omega}(x)\right|^{2}$, where $\mathcal{B}$ is the fundamental solution of the Laplacian. Then $f$ is a solution of the following equation:

It is easy to see that

E_{j}\left(\left|Q_{\omega}(x)\right|^{2}\right)=-\partial_{1} \partial_{j} f, \quad j=1,2 \tag{2.16}
\end{equation*}
$$

Hence, in order to prove (2.14), it is sufficient to prove the spatial exponential decay of $\partial_{1} \partial_{j} f$. Note that

-\Delta \partial_{1} \partial_{j} f=2 \operatorname{Re}\left(\partial_{1} \partial_{j} Q_{\omega} \bar{Q}_{\omega}+\partial_{1} Q_{\omega} \partial_{j} \bar{Q}_{\omega}\right), \quad j=1,2
$$

By (2.13), we see that there exists positive constants $C_{1}$ such that the absolute value of the right-hand side of the above equation is bounded by $C_{1} e^{-C_{2}|x|}$, let $g=g(|x|)$ be the unique radial solution of the problem

-\Delta g=C_{1} e^{-\sqrt{\omega}|x|}, \quad \lim _{|x| \rightarrow \infty} g(|x|)=0
$$

A simple computation shows that there exists a polynomial $P(x)$ such that

|g(|x|)| \leq C_{1} P(x) e^{-C_{2}|x|}, \quad \text { for }|x| \geq 0
$$

Hence, by using the standard super and sub-solutions method, we obtain $\left|\partial_{1} \partial_{j} f\right| \leq$ $C_{1} e^{-C_{2}|x|}$.

This completes the proof.

## 3 Correlative Variational Framework

Firstly we state the profile decomposition theory of a bounded sequence in $H^{1}$, which is proposed by Hmidi and Keraani in (34].

Lemma 3.1. Let $\left\{u_{n}\right\}_{n=1}^{+\infty}$ be a bounded sequence in $H^{1}$. Then, there exists a subsequence of $\left\{u_{n}\right\}_{n=1}^{+\infty}$ (still denoted by $\left\{u_{n}\right\}_{n=1}^{+\infty}$ ) and a sequence $\left\{U^{j}\right\}_{j=1}^{+\infty}$ in $H^{1}$ and a family of $\left\{x_{n}^{j}\right\}_{j=1}^{+\infty} \subset \mathbb{R}^{2}$ satisfying the following.
(i) For every $j \neq k,\left|x_{n}^{j}-x_{n}^{k}\right| \rightarrow+\infty$ as $n \rightarrow+\infty$.
(ii) For every $l \geq 1$ and every $x \in \mathbb{R}^{2}, u_{n}(x)$ can be decomposed by

with the remaining term $u_{n}^{l}:=u_{n}^{l}(x)$ satisfying

\lim _{l \rightarrow+\infty} \limsup _{n \rightarrow+\infty}\left\|u_{n}^{l}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}=0, \text { for every } q \in(2,+\infty)
$$

Moreover, as $n \rightarrow+\infty$,

\left\|u_{n}\right\|_{L^{2}}^{2}=\sum_{j=1}^{l}\left\|U^{j}\right\|_{L^{2}}^{2}+\left\|u_{n}^{l}\right\|_{L^{2}}^{2}+o(1),\left\|\nabla u_{n}\right\|_{L^{2}}^{2}=\sum_{j=1}^{l}\left\|\nabla U^{j}\right\|_{L^{2}}^{2}+\left\|\nabla u_{n}^{l}\right\|_{L^{2}}^{2}+o(1) \tag{3.1}
\end{equation*}
$$

where $\lim _{n \rightarrow+\infty} o(1)=0$.
The sequence $\left\{x_{n}^{j}\right\}_{n=1}^{+\infty}$ is called to satisfy the orthogonality condition if and only if for every $k \neq j,\left|x_{n}^{k}-x_{n}^{j}\right| \rightarrow+\infty$ as $n \rightarrow \infty$.

Then we show the following lemma.
Lemma 3.2. Let $\left\{U^{j}\right\}_{j=1}^{l}$ be a family of bounded sequences in $H^{1}$ and $\left\{x_{n}^{j}\right\}_{n=1}^{+\infty}$ be a orthogonality sequence in $\mathbb{R}^{2}$. We claim that for every $1<p<\infty$,

& \left.\left.\int E_{1}\left(\left|\sum_{j=1}^{l} U_{n}^{j}\right|^{2}\right)\right|_{j=1} ^{l} U_{n}^{j}\right|^{2} d x \rightarrow \sum_{j=1}^{l} \int E_{1}\left(\left|U_{n}^{j}\right|^{2}\right)\left|U_{n}^{j}\right|^{2} d x \quad \text { as } \quad n \rightarrow+\infty . \tag{3.3}

Proof. We give the proof of (3.2). Then (3.3) can be obtained by the same arguments, (also see [39]). Assume that every $U^{j}$ is continuous and compactly supported. From the basic inequality: for every $p>1$

we have that it is sufficient to prove that the mixed terms in the left hand side of (3.2) vanish. More precisely, for all $j \neq k$, we claim that

To show (3.4), based on some basic computations we deduce the following inequality

\int\left|U^{j} U^{k}\right|\left|U^{m}\right| d x & \leq C\left(\int\left|U^{j} U^{k}\right|^{\frac{p+1}{2}} d x\right)^{\frac{2}{p+1}} \int\left|\nabla U^{m}\right|^{p-1} d x \\
& \leq C\left(\int\left|U^{j} U^{k}\right|^{\frac{p+1}{2}} d x\right)^{\frac{2}{p+1}} \tag{3.5}
\end{align*}
$$

From Lemma 3.1, we deduce that

This completes the proof of Lemma 3.2.

Step 2. Minimizing sequence is bounded in $H^{1}$.
Let $\left\{u_{n}\right\}_{n=1}^{+\infty}$ be a minimizing sequence of (3.7). Then we have that

E\left(u_{n}^{l}\right) & =\frac{E\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+\frac{\left.2\left(\lambda_{n}^{l}\right)^{p-1}-1\right)}{p+1} \int\left|u_{n}^{l}\right|^{p+1} d x+\frac{\left(\lambda_{n}^{l}\right)^{2}-1}{2} \int E_{1}\left(\left|u_{n}^{l}\right|^{2}\right)\left|u_{n}^{l}\right|^{2} d x \\
& \geq \frac{E\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+o(1) \text { as } n \rightarrow+\infty, l \rightarrow+\infty . \tag{3.26}
\end{align*}

& \left.+\frac{\lambda_{j}^{2}-1}{2} \int E_{1}\left(\left|U_{n}^{j}\right|^{2}\right)\left|U_{n}^{j}\right|^{2} d x\right)+\frac{E\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+o(1) \tag{3.28}
\end{align*}
$$

Since $1<p<3$, combining with (3.15), (3.24) and (3.27), we deduce that by (3.28),

& \left.+\frac{2}{p+1} \int\left|u_{n}\right|^{p+1} d x\right)+o(1) \\
& \geq d_{m}+\left(\left(\frac{\sqrt{m}}{\left\|U^{j}\right\|_{L^{2}}}\right)^{p-1}-1\right) C_{0}+o(1) \tag{3.29}
\end{align*}
$$

where $C_{0}>0$ is given in (3.15). Let $n \rightarrow+\infty$ and $l \rightarrow+\infty$ in (3.29), the following inequality holds

Thus $\left|U^{j_{0}}\right|=Q_{m}(x)$ is a positive minimizer of (3.7). Moreover $Q_{m}$ is the positive solution of (2.10) with $\omega=\omega_{m}$.

This completes the proof of Theorem 3.3.
Remark 3.4. In fact, Ohta [26] solved the variational problem (3.7) with small mass by the concentration compactness principle 20, 21. But here we solve the variational problem (3.7) with definite mass $0<m<2 d_{J}$ by the profile decomposition.

Theorem 3.5. Let $d_{J}$ be defined as (2.5) and $Q_{\omega}$ be the positive solution of (2.10).

This proves Theorem 3.5.
Theorem 3.6. Let $1<p<3$ and $Q_{m} \in H^{1}$ be a positive minimizer of (3.7). Suppose that the positive solution of (2.10) is unique for every $\omega>0$. Then the set of all solutions of (3.7) is $S_{m}=\left\{e^{i \theta} Q_{m}(\cdot+y), \quad \theta \in \mathbb{R}, \quad y \in \mathbb{R}^{2}\right\}$. In addition, for arbitrary $u \in S_{m}$, there exists a unique $\omega_{m}>0$ such that $\varphi(t, x)=e^{i \omega_{m} t} u(x)$ is a soliton of (1.1).

Proof. From Theorem 3.3, (3.7) has a positive minimizer $Q_{m} \in H^{1}$. Now suppose that $v \in H^{1}$ is an arbitrary solution of (3.7). Let $v=v^{1}+i v^{2}$, where $v^{1}, v^{2} \in H^{1}$ are real-valued. Then $\widetilde{v}=\left|v^{1}\right|+i\left|v^{2}\right|$ is still a solution of (3.7). Thus there exists a unique $\omega_{m}>0$ such that $v$ and $\widetilde{v}$ satisfy (2.10). It follows that for $j=1,2$,

This shows that $\omega$ is the first eigenvalue of the operator $\Delta+|v|^{p-1}+E_{1}\left(|v|^{2}\right)$ acting over $H^{1}$ and thus, $v^{1}, v^{2},\left|v^{1}\right|$ and $\left|v^{2}\right|$ are all multiples of a positive normalized eigenfunction $v_{0}$ of $\Delta+|v|^{p-1}+E_{1}\left(|v|^{2}\right)$, i.e.

It is now obvious to deduce that: $v=e^{i \theta} v_{0}(\cdot+y)$ for some $\theta \in \mathbb{R}, y \in \mathbb{R}^{2}$ and that $v_{0}$ is still a positive solution of (3.7). By the supposition, $v_{0}$ is the unique positive solution of (2.10) with $\omega=\omega_{m}$. It follows that $v_{0}=Q_{m}(\cdot+y)$ for some $y \in \mathbb{R}^{2}$. Thus $v=e^{i \theta} Q_{m}(\cdot+y)$ for some $\theta \in \mathbb{R}$. It is obvious that for any $\theta \in \mathbb{R}$ and $y \in \mathbb{R}^{2}$, $e^{i \theta} Q_{m}(\cdot+y)$ is also a solution of (3.7). Therefore

This completes the proof of Theorem 3.6.
Lemma 3.7 For $1<p<\infty$ and $u \in H^{1} \backslash\{0\}$, define the functional

Proof. By a direct calculation, it is shown that (3.38) is true. It follows that $E\left(u_{\lambda}\right)+$ $\omega \int\left|u_{\lambda}\right|^{2} d x$ attains the minimum at $\lambda_{0}$ satisfying $I\left(u_{\lambda_{0}}\right)=0$. Moreover if $u$ is a solution of (2.10), from (2.11) it follows that $I(u)=0$.

This completes the proof of Lemma 3.7.
Theorem 3.8. For $1<p<3$ and $\omega \in\left(0, \omega_{J}\right)$, where $\omega_{J}$ is defined as (1.7) and $d_{J}$ is defined as (1.5), we set the constrained variational problem

Then (3.39) possesses a positive minimizer $Q_{\omega} \in H^{1}$. Moreover $Q_{\omega}$ is the positive solution of (2.10).

Proof. In the following we complete this proof by five steps.
Step 1. $\left\{u \in H^{1}, 0<\int|u|^{2} d x<2 d_{J}, I(u)=0\right\}$ is not empty.

Take $0<m<2 d_{J}$. From Theorem 3.3 we have that there exists a positive minimizer $Q_{m}(x) \in H^{1}$ such that $0<\int\left|Q_{m}(x)\right|^{2} d x<2 d_{J}$ and $Q_{m}(x)$ satisfying (2.10) with $\omega=\omega_{m} \in\left(0, \omega_{J}\right)$. By Lemma 3.6 it follows that $I\left(Q_{m}\right)=0$. Thus $Q_{m} \in\{u \in$ $\left.H^{1}, 0<\int|u|^{2} d x<2 d_{J}, I(u)=0\right\}$. Therefore $\left\{u \in H^{1}, 0<\int|u|^{2} d x<2 d_{J}, I(u)=0\right\}$ is not empty.

Step 2. $d_{\omega}>-\infty$.
Take $u \in H^{1}$ satisfying $0<\int|u|^{2} d x<2 d_{J}$ and $I(u)=0$. For $\omega \in\left(0, \omega_{J}\right)$, we put

H(u)=E(u)+\omega \int|u|^{2} d x . \tag{3.40}
\end{equation*}
$$

From (3.8), it follows that

H(u)= & \int|\nabla u|^{2} d x-\frac{1}{2} \int E_{1}\left(|u|^{2}\right)|u|^{2} d x-\frac{2}{p+1} \int|u|^{p+1} d x+\omega \int|u|^{2} d x \\
& \geq\left(1-\frac{\|u\|_{L^{2}}^{2}}{2 d_{J}}-\varepsilon\right)\|\nabla u\|_{L^{2}}^{2}-C\left(\varepsilon,\|u\|_{L^{2}}\right) \tag{3.41}
\end{align*}
$$

where $0<\varepsilon<1-\frac{\|u\|_{L^{2}}^{2}}{2 d_{J}}$. Since $0<\int|u|^{2} d x<2 d_{J}$, by (3.41) we have that

Step 3. Minimizing sequence is bounded in $H^{1}$.
Let $\left\{u_{n}\right\}_{n=1}^{+\infty} \subset\left\{u \in H^{1}, 0<\int|u|^{2} d x<2 d_{J}, I(u)=0\right\}$ be a minimizing sequence of (3.39). Then for all $n \in \mathbb{N}$,

Step 4. Existence of minimizer.
We apply Lemma 3.1 to the minimizing sequence $\left\{u_{n}\right\}_{n=1}^{+\infty}$. Then there exists a subsequence still denoted by $\left\{u_{n}\right\}_{n=1}^{+\infty}$ such that

H\left(u_{n}^{l}\right) & =\frac{H\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+\frac{\left.2\left(\lambda_{n}^{l}\right)^{p-1}-1\right)}{p+1} \int\left|u_{n}^{l}\right|^{p+1} d x+\frac{\left(\lambda_{n}^{l}\right)^{2}-1}{2} \int E_{1}\left(\left|u_{n}^{l}\right|^{2}\right)\left|u_{n}^{l}\right|^{2} d x \\
& \geq \frac{H\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+o(1), \text { as } n \rightarrow+\infty, l \rightarrow+\infty . \tag{3.52}
\end{align*}

For $j=1, \cdots, l$, let

Then there exist $0<\mu_{j}, \mu_{n}^{l}<\infty$ such that

$$

From (3.39), it follows that

& \left.+\frac{\lambda_{j}^{2}-1}{2} \int E_{1}\left(\left|U_{n}^{j}\right|^{2}\right)\left|U_{n}^{j}\right|^{2} d x\right)+\frac{H\left(\widetilde{u}_{n}^{l}\right)}{\left(\lambda_{n}^{l}\right)^{2}}+o(1) . \tag{3.56}
\end{align*}
$$

Since $1<p<3$, combining with (3.48), (3.50), (3.55) and (3.56), we deduce that

& \left.+\frac{2}{p+1} \int\left|u_{n}\right|^{p+1} d x\right)+o(1) \\
& \geq d_{m}+\left(\left(\frac{\sqrt{m}}{\left\|U^{j_{0}}\right\|_{L^{2}}}\right)^{p-1}-1\right) C_{0}+o(1) \tag{3.57}
\end{align*}
$$

where $C_{0}>0$ is given in (3.48). Let $n \rightarrow+\infty$ and $l \rightarrow+\infty$ in (3.57), the following inequality holds

Put more precisely, in (3.48) there exists only one non-zero term $U^{j_{0}}$, and the others are zero. Moreover, from (3.19)-(3.21), it follows that $E\left(U^{j_{0}}\right)=d_{m}$, and then the variational problem (3.39) attains its infimum at $U^{j_{0}}$.

Secondly, we consider the case $d_{\omega} \geq 0$.

By the profile decomposition, for $n$ large enough, we have

There exists $0<\lambda<\infty$ such that $I\left(U^{j_{0}}\right)=0$ and $0<\int\left|U^{j_{0}}\right|^{2} d x<$ $2 d_{J}$. It follows that $H\left(U^{j_{0}}\right) \geq d_{\omega}$. Combining with Lemma 3.7, we have $H\left(U^{j_{0}}\right)=d_{\omega}$

Therefore, no matter $d_{\omega}<0$ or $d_{\omega} \geq 0$, there exists $U^{j_{0}} \neq 0$ such that the variational problem (3.39) attains its infimum at $U^{j_{0}}$. Then $Q_{\omega}(x)=\left|U^{j_{0}}\right| \geq 0$ is a minimizer of (3.39).

Step 5. $Q_{\omega}(x)$ is the positive solution of (2.10).
In terms of (3.39), there exists a unique $\Lambda \in \mathbb{R}$ such that $Q_{\omega}(x)=\left|U^{j_{0}}\right|$ satisfies the Euler-Lagrange equation for $\eta \in C_{0}^{\infty}\left(\mathbb{R}^{2}\right)$

\left.\frac{d}{d \varepsilon}\right|_{\epsilon=0}\left(E\left(Q_{\omega}+\varepsilon \eta\right)+\omega \int\left|Q_{\omega}+\varepsilon \eta\right|^{2} d x+\Lambda I\left(Q_{\omega}+\varepsilon \eta\right)\right)=0 . \tag{3.60}
\end{equation*}

It follows that
$-\Delta Q_{\omega}-Q_{\omega}^{p}-E_{1}\left(\left|Q_{\omega}\right|^{2}\right) Q_{\omega}+\omega Q_{\omega}+\Lambda\left(-2 \Delta Q_{\omega}-(p-1) Q_{\omega}^{p}-2 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) Q_{\omega}\right)=0$.

From (3.61), we have that

(1+\Lambda(p-1)) \frac{2}{p+1}\left|Q_{\omega}\right|^{p+1}+\frac{1}{2}(1+2 \Lambda) E_{1}\left(\left|Q_{\omega}\right|^{2}\right)\left|Q_{\omega}\right|^{2}-\omega\left|Q_{\omega}\right|^{2} d x=0 . \tag{3.63}
\end{equation*}
$$

By $I\left(Q_{\omega}\right)=0,(3.62)$ and (3.63), we have that

\Lambda \int \frac{(p-3)(p-1)}{p+1}\left|Q_{\omega}\right|^{p+1} d x=0 . \tag{3.64}

Since $1<p<3$ and $Q_{\omega} \geq 0$, from (3.64), we have $\Lambda=0$. It follows that $Q_{\omega}$ satisfies (2.10). Since $Q_{\omega}=\left|U^{j_{0}}\right| \geq 0$ a.e. in $\mathbb{R}^{2}$, by the strong maximum principle, we get that $Q_{\omega}(x)>0$ for $x \in \mathbb{R}^{2}$. Thus $Q_{\omega}=\left|U^{j_{0}}\right|$ is a positive minimizer of (3.39). Moreover $Q_{\omega}$ is the positive solution of (2.10).

This completes the proof of Theorem 3.8.

Theorem 3.9. Suppose that the positive solution of (2.10) is unique for every $\omega>0$. Then the variational problem (3.7) determines a one-to-one mapping between $m \in$ $\left(0,2 d_{J}\right)$ and $\omega \in\left(0, \omega_{J}\right)$. In detail, for $\omega \in\left(0, \omega_{J}\right)$ and $m=\int Q_{\omega}^{2} d x$ with positive solution $Q_{\omega}(x)$ of (2.10), one has that $\frac{d m}{d \omega}=\frac{d}{d \omega} \int Q_{\omega}^{2} d x \neq 0$.

Proof. For arbitrary $m \in\left(0,2 d_{J}\right)$, in terms of Theorem 3.3, the variational problem (3.7) determines a positive $Q_{m}(x) \in H^{1}\left(\mathbb{R}^{2}\right)$ and a unique $\omega_{m}$ such that (2.10) with $\int Q_{m}^{2} d x=m$. By Lemma 2.3 (also see [11] and [18]), $\omega_{m} \in\left(0, \omega_{J}\right)$.

Now suppose that there exists another $\omega^{\prime} \in\left(0, \omega_{J}\right)$ such that $\omega^{\prime} \neq \omega_{m}$ and $\int Q_{\omega^{\prime}}^{2} d x=m$ for the positive solution $Q_{\omega^{\prime}}(x)$ of (2.10) with $\omega=\omega^{\prime}$. By the supposition of uniqueness, $Q_{\omega^{\prime}}(x)>0$ is unique for (2.10) with $\omega=\omega^{\prime}$. In addition, $\omega^{\prime} \neq \omega_{m}$ leads that $Q_{\omega^{\prime}}(x) \neq Q_{m}(x)$. From Theorem 3.3, $Q_{\omega^{\prime}}(x)$ is not a minimizer of (3.7). According to Theorem 3.8, $Q_{\omega^{\prime}}(x)$ must be the positive minimizer of the variational problem (3.39) with $\omega=\omega^{\prime}$.

We see that $Q_{m}$ satisfies (2.10) with $\omega=\omega_{m}$ and $Q_{\omega^{\prime}}$ satisfies (2.10) with $\omega=\omega^{\prime}$. By Lemma 3.7, it follows that $I\left(Q_{m}\right)=0=I\left(Q_{\omega^{\prime}}\right)$.

Summarizing the above facts, we get that

Since $Q_{\omega^{\prime}}$ is not a minimizer of (3.7), by (3.65) and (3.67), Theorem 3.3 derives

From (3.65), it is clear that (3.70) is contradictory with (3.69). Therefore it is necessary that $\omega_{m}=\omega^{\prime}$. It turns that for $\omega \in\left(0, \omega_{J}\right)$ and positive solution $Q_{\omega}(x)$ of (2.10),
we have that

This completes the proof of Theorem 3.9.
Theorem 3.10. Let $\mu$ be the set of all Lagrange multipliers corresponding to the all positive minimizers of (3.7).Then $\mu=\left(0, \omega_{J}\right)$, where $\omega_{J}$ is defined as (1.7). In addition $\mu_{J}=\left(0, \omega_{J}\right)$, where $\mu_{J}$ is defined as (3.31).

Proof. Theorem 3.5 derives that $\mu \subset \mu_{J} \subset\left(0, \omega_{J}\right)$. Now suppose that $\omega \in\left(0, \omega_{J}\right)$. By Theorem 3.8, this $\omega$ determines a unique $m \in\left(0,2 d_{J}\right)$, and this $m$ determines a unique $\omega_{m} \in \mu$. Then this $\omega_{m}$ can only be $\omega$, that is $\omega_{m}=\omega$. Thus $\left(0, \omega_{J}\right) \subset \mu$. Therefore $\mu=\left(0, \omega_{J}\right)$. It follows that $\mu=\left(0, \omega_{J}\right)=\mu_{J}$.

This proves Theorem 3.10.
Remark 3.11. Theorem 3.9 shows that for $m<2 d_{J}$, the normalized solution problem (2.10) with $\int|u|^{2} d x=m$ possesses a unique $\omega_{m} \in\left(0, \omega_{J}\right)$ such that $Q_{m}$ is the unique positive solution of (2.10) with $\omega=\omega_{m}$. It gives a positive answer that for (2.10), the mapping from the prescribed mass $m$ to the Lagrange multiplier, that is the soliton frequency $\omega$ is injective. Moreover the approach introduced here can be used to deal with more nonlinear Schrödinger equations.

## 4 Orbital Stability of Small Solitons

Theorem 4.1. The soliton $e^{i \omega t} u(x)$ in Theorem 3.6 holds the orbital stability, i.e. for arbitrary $\varepsilon>0$, there exists $\delta>0$ such that for any $\varphi_{0} \in H^{1}$ and $0<\int\left|\varphi_{0}\right|^{2} d x<2 d_{J}$, if

\inf _{\left\{\theta \in \mathbb{R}, y \in \mathbb{R}^{2}\right\}}\left\|\varphi_{0}(\cdot)-e^{i \theta} u(\cdot+y)\right\|_{H^{1}}<\delta, \tag{4.1}

then the solution $\varphi(t, x)$ of the Cauchy problem (1.1)-(2.1) satisfies

\operatorname{in} f_{\left\{\theta \in \mathbb{R}, y \in \mathbb{R}^{2}\right\}}\left\|\varphi(t, \cdot)-e^{i \theta} u(\cdot+y)\right\|_{H^{1}}<\varepsilon, \quad t \in \mathbb{R} . \tag{4.2}
\end{equation*}
$$

Proof. By Theorem 3.6, it is clear that for arbitrary $u \in S_{m}$ one has that

In terms of Theorem 2.1, for any $\varphi_{0} \in H^{1}$, the Cauchy problem (1.1)-(2.1) possesses a unique global solution $\varphi(t, x) \in C\left(\mathbb{R}, H^{1}\right)$ with mass conservation $M(\varphi)=M\left(\varphi_{0}\right)$ and energy conservation $E(\varphi)=E\left(\varphi_{0}\right)$ for all $t \in \mathbb{R}$.

Now arguing by contradiction, if the conclusion of Theorem 4.1 does not hold, then there exist $\varepsilon>0$, a sequence $\left(\varphi_{0}^{n}\right)_{n \in \mathbb{N}^{+}}$such that

and a sequence $\left(t_{n}\right)_{n \in \mathbb{N}^{+}}$such that

\left.\inf _{\{\theta \in \mathbb{R},} y \in \mathbb{R}^{2}\right\}\left\|\varphi_{n}\left(t_{n}, \cdot\right)-e^{i \theta} u(\cdot+y)\right\|_{H^{1}} \geq \varepsilon \tag{4.5}
\end{equation*}
$$

where $\varphi_{n}$ denotes the solution of the Cauchy problem (1.1)-(2.1) with initial datum $\varphi_{0}^{n}$. From (4.4) we yield that

Thus (4.6), (4.7), the conservations of mass and energy derive that $\left\{\varphi_{n}\left(t_{n}, \cdot\right)\right\}$ is a minimizing sequence for the problem (3.7). Therefore (4.6) and (4.7) derive that there exists $\theta \in \mathbb{R}$ and $y \in \mathbb{R}^{2}$ such that

\lim _{n \rightarrow \infty}\left\|\varphi_{n}\left(t_{n}, \cdot\right)-e^{i \theta} u(\cdot+y)\right\|_{H^{1}}=0 \tag{4.8}
\end{equation*}

This is contradictory with (4.5). Theorem 4.1 is proved.
Theorem 4.2. Let $\omega \in(0, \infty)$ and $Q_{\omega}$ be a positive solution of (2.10). Then we have

\frac{d}{d \omega} E\left(Q_{\omega}\right)=-\omega \frac{d}{d \omega} M\left(Q_{\omega}\right)=-\omega \frac{d}{d \omega} \int Q_{\omega}^{2} d x \tag{4.9}

Proof. Since $Q_{\omega}$ is a positive solution of (2.10), it follows that

From (2.2) and (4.10), we have

\frac{d}{d \omega} E\left(Q_{\omega}\right)=\frac{d}{d \omega}\left(\int\left|\nabla Q_{\omega}\right|^{2}-\frac{2}{p+1}\left|Q_{\omega}\right|^{p+1}-\frac{1}{2} E_{1}\left(\left|Q_{\omega}\right|^{2}\right)\left|Q_{\omega}\right|^{2} d x\right)
$$

$$
\begin{aligned}
& =\int 2\left|\nabla Q_{\omega}\right| \frac{d}{d \omega}\left|\nabla Q_{\omega}\right|-2 Q_{\omega}^{p} \frac{d}{d \omega} Q_{\omega}-2 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) Q_{\omega} \frac{d}{d \omega} Q_{\omega} d x \\
& =\int-2 \Delta Q_{\omega} \frac{d}{d \omega} Q_{\omega}-2 Q_{\omega}^{p} \frac{d}{d \omega} Q_{\omega}-2 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) Q_{\omega} \frac{d}{d \omega} Q_{\omega} d x \\
& =\int-2 \omega Q_{\omega} \frac{d}{d \omega} Q_{\omega} d x=-\omega \int \frac{d}{d \omega} Q_{\omega}^{2} d x=-\omega \frac{d}{d \omega} \int Q_{\omega}^{2} d x
\end{aligned}
$$

Noting (2.3), this proves (4.9) and completes the proof.
Let $\omega \in\left(0, \omega_{J}\right)$ and $Q_{\omega}(x)$ be the unique positive solution of (2.10). We set the scalar

D(\omega)=E\left(Q_{\omega}\right)+\omega M\left(Q_{\omega}\right) \tag{4.11}
\end{equation*}
$$

and the linearized operator of (4.10)

\begin{equation*}
H_{\omega}=-\Delta+\omega-p Q_{\omega}^{p-1}-3 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) \tag{4.12}
\end{equation*}
$$

It is clear that

\begin{equation*}
H_{\omega}=\frac{1}{2} E^{\prime \prime}\left(Q_{\omega}\right)+\frac{1}{2} \omega M^{\prime \prime}\left(Q_{\omega}\right) . \tag{4.13}
\end{equation*}
$$

Theorem 4.3. Let $\omega \in\left(0, \omega_{J}\right)$ and $Q_{\omega}(x)$ be the unique positive solution of (2.10). Then the operator $H_{\omega}$ has one negative simple eigenvalue and has its kernel spanned by $i Q_{\omega}$. Moreover the positive spectrum of $H_{\omega}$ is bounded away from zero.

Proof. Since $\omega \in\left(0, \omega_{J}\right)$, By Lemma 2.3, there exists a positive function $Q_{\omega}(x)$ satisfying (4.10). Now suppose that $\lambda \in \mathbb{R}$ satisfies $H_{\omega} Q_{\omega}=\lambda Q_{\omega}$, that is

-\Delta Q_{\omega}+\omega Q_{\omega}-p Q_{\omega}^{p}-3 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) Q_{\omega}=\lambda Q_{\omega} \tag{4.14}

From (4.10), it follows that

\begin{equation*}
(1-p) Q_{\omega}^{p-1}-2 E_{1}\left(\left|Q_{\omega}\right|^{2}\right)=\lambda \tag{4.15}
\end{equation*}
$$

By Lemma 2.3 and (4.15), we can uniquely determine $\lambda$ as follows

\lambda=\lambda_{-}=\int(1-p) Q_{\omega}^{p+1}-2 E_{1}\left(\left|Q_{\omega}\right|^{2}\right)\left|Q_{\omega}\right|^{2} d x / \int Q_{\omega}^{2} d x \tag{4.16}
\end{equation*}
$$

From (4.16), we have $\lambda<0$. Therefore we get that $H_{\omega}$ has one negative simple eigenvalue $\lambda_{-}$. It follows that $H_{\omega}\left(i Q_{\omega}\right)=\lambda_{-}\left(i Q_{\omega}\right)$ and the kernel is spanned by $i Q_{\omega}$.

Now suppose that $\lambda>0$ and $u \in H^{1} \backslash\{0\}$ satisfying $H_{\omega} u=\lambda u$, that is

-\Delta u+\omega u-p Q_{\omega}^{p-1} u-3 E_{1}\left(\left|Q_{\omega}\right|^{2}\right) u=\lambda u . \tag{4.17}
\end{equation*}
$$

By Lemma 2.3,

-p Q_{\omega}^{p-1}-3 E_{1}\left(\left|Q_{\omega}\right|^{2}\right):=g(x)=o\left(|x|^{-1}\right) . \tag{4.18}
\end{equation*}
$$

From Kato [17, $-\Delta+g(x)$ has no positive eigenvalues. Thus (4.17) derives that $\lambda \leq \omega$. By Weyl's theorem on the essential spectrum, the rest of the spectrum of $H_{\omega}$ is bounded away from zero (see [29]).

This proves Theorem 4.3.

By Theorem 4.3, $H_{\omega}$ with $T^{\prime}(0)=i$ satisfies Assumption 3 in 15 for $\omega \in \mu_{J}$. With $J=-i, X=H^{1}$ and $E$ as (2.2), by Theorem 2.1 and Lemma 2.3, (1.1) satisfies Assumption 1 and 2 in [15] for $\omega \in \mu_{J}$. Thus we can use Theorem 4.7 in [15] and get the following lemma.

Lemma 4.4. Let $\omega \in\left(0, \omega_{J}\right)$ and $Q_{\omega}(x)$ be the unique positive solution of (2.10). If $D^{\prime \prime}(\omega)=\frac{d^{2}}{d \omega^{2}} D(\omega)<0$, the soliton $e^{i \omega t} Q_{\omega}(x)$ of (1.1) is unstable.

Then we get the following theorem.
Theorem 4.5. Let $\omega \in\left(0, \omega_{J}\right)$ and $Q_{\omega}(x)$ be the unique positive solution of (2.10).
Then we have that

\frac{d}{d \omega} \int Q_{\omega}^{2} d x>0
$$

Proof. From Theorem 4.2, (4.11) and (4.13), we have that

D^{\prime \prime}(\omega)=\frac{d}{d \omega} \int Q_{\omega}^{2} d x \tag{4.19}
\end{equation*}
$$

Since $\omega \in\left(0, \omega_{J}\right)$, from Theorem 3.10 it follows that $\omega \in \mu_{J}$. In terms of Theorem 4.1, the soliton $e^{i \omega t} Q_{\omega}(x)$ holds the orbital stability. By Lemma 4.4, we deduce that $D^{\prime \prime}(\omega) \geq 0$. From (4.19) it follows that $\frac{d}{d \omega} \int Q_{\omega}^{2} d x \geq 0$. Set $m(\omega)=\int Q_{\omega}^{2} d x$. From $\omega \in\left(0, \omega_{J}\right)$, Theorem 3.9 deduces that $\frac{d}{d \omega} \int Q_{\omega}^{2} d x=\frac{d m}{d \omega} \neq 0$. Therefore we get that $\frac{d}{d \omega} \int Q_{\omega}^{2} d x>0$.

This proves Theorem 4.5.
Proof of Theorem A. In fact, we have given the proof of Theorem A in the proof of Theorem 4.6. On the other hand, from Theorem 3.5 in [15], Theorem 4.5 also deduces Theorem A.

## 5 Construction of Multi-Solitons

It is clear that (1.1) admits the following symmetries.
Time-space translation invariance: if $\varphi(t, x)$ satisfies (1.1), then for any $t_{0}, x_{0} \in$ $\mathbb{R} \times \mathbb{R}^{2}$,

$$
\begin{equation*}
\psi(t, x)=\varphi\left(t-t_{0}, x-x_{0}\right) \tag{5.1}
\end{equation*}
$$

also satisfies (1.1).
Phase invariance: if $\varphi(t, x)$ satisfies (1.1), then for any $\gamma_{0} \in \mathbb{R}$,

\begin{equation*}
\psi(t, x)=\varphi(t, x) e^{i \gamma_{0}} \tag{5.2}
\end{equation*}
$$

also satisfies (1.1).
Galilean invariance: if $\varphi(t, x)$ satisfies (1.1), then for any $v_{0} \in \mathbb{R}^{2}$,

$$
\begin{equation*}
\psi(t, x)=\varphi\left(t, x-v_{0} t\right) e^{i\left(\frac{1}{2} v_{0} x-\frac{1}{4}\left|v_{0}\right|^{2} t\right)} \tag{5.3}
\end{equation*}
$$

also satisfies (1.1).
Let $1<p<3$ and $\omega_{J}$ be defined in (1.7). For $K \geq 2$ and $k=1,2, \cdots, K$, we take $\omega_{k}^{0} \in\left(0, \omega_{J}\right), \quad \gamma_{k}^{0} \in \mathbb{R}, \quad x_{k}^{0} \in \mathbb{R}^{2}$ and $v_{k} \in \mathbb{R}^{2}$ with $v_{k} \neq v_{k^{\prime}}$ to $k \neq k^{\prime}$. By Theorem A,

\begin{equation*}
e^{i \omega_{k}^{0} t} Q_{\omega_{k}^{0}}(x), \quad k=1,2, \cdots, K \tag{5.4}
\end{equation*}
$$

are the stable solitons of (1.1). Then in terms of the above symmetries for $k=$ $1,2, \cdots, K$,

$$
\begin{equation*}
R_{k}(t, x)=Q_{\omega_{k}^{0}}\left(x-x_{k}^{0}-v_{k} t\right) e^{i\left(\frac{1}{2} v_{k} x-\frac{1}{4}\left|v_{k}\right|^{2} t+\omega_{k}^{0} t+\gamma_{k}^{0}\right)},(t, x) \in \mathbb{R} \times \mathbb{R}^{2} \tag{5.5}
\end{equation*}
$$

are also the solitons of (1.1). It is obvious that

$$
\begin{equation*}
\left\|R_{k}(t, \cdot)\right\|_{L^{2}}=\left\|Q_{\omega_{k}^{0}}(\cdot)\right\|_{L^{2}}<\sqrt{2 d_{J}}, t \in \mathbb{R}, k=1,2, \cdots, K \tag{5.6}
\end{equation*}
$$

Now we suppose that $K \geq 2, \omega_{k}^{0} \in\left(0, \omega_{J}\right)$ for $k=1,2, \cdots, K$, and

$$
\begin{equation*}
\sum_{k=1}^{K}\left\|Q_{\omega_{k}^{0}}(\cdot)\right\|_{L^{2}}<\sqrt{2 d_{J}} \tag{5.7}
\end{equation*}
$$

Thus

$$
\begin{equation*}
\left\|\sum_{k=1}^{K} R_{k}(t, \cdot)\right\|_{L^{2}} \leq \sum_{k=1}^{K}\left\|R_{k}(t, \cdot)\right\|_{L^{2}}<\sqrt{2 d_{J}} \tag{5.8}
\end{equation*}
$$

Now we set

\begin{equation*}
R(t)=\sum_{k=1}^{K} R_{k}(t, \cdot), \quad t \in \mathbb{R} \tag{5.9}
\end{equation*}
$$

Theorem 5.1. Let $1<p<3$. For $K \geq 2$ and $k=1, \cdots, K$, taking $\omega_{k}^{0} \in\left(0, \omega_{J}\right)$, $\gamma_{k}^{0} \in \mathbb{R}, x_{k}^{0} \in \mathbb{R}^{2}, v_{k} \in \mathbb{R}^{2}$ with $v_{k} \neq v_{k^{\prime}}$ to $k \neq k^{\prime}, \sum_{k=1}^{K}\left\|Q_{\omega_{k}^{0}}(\cdot)\right\|_{L^{2}}<\sqrt{2 d_{J}}$ and

$$
\begin{equation*}
R_{k}(t, x)=Q_{\omega_{k}^{0}}\left(x-x_{k}^{0}-v_{k} t\right) e^{i\left(\frac{1}{2} v_{k} x-\frac{1}{4}\left|v_{k}\right|^{2} t+\omega_{k}^{0} t+\gamma_{k}^{0}\right)} \tag{5.10}
\end{equation*}
$$

with $(t, x) \in \mathbb{R} \times \mathbb{R}^{2}$, there exists a solution $\varphi(t, x)$ of (1.1) such that

$$
\begin{equation*}
\forall t \geq 0,\left\|\varphi(t)-\sum_{k=1}^{K} R_{k}(t)\right\|_{H^{1}} \leq C e^{-\theta_{0} t} \tag{5.11}
\end{equation*}
$$

for some $\theta_{0}>0$ and $C>0$.
Proof of Theorem B. Theorem 5.1 directly implies that Theorem B is true.
Let $T_{n}>0, n=1,2, \cdots$ and $\lim _{n \rightarrow \infty} T_{n}=+\infty$. For $n=1,2, \cdots$, by Theorem 2.1 we can let $\varphi_{n}$ be the unique global solution in $H^{1}$ for the Cauchy problem

$$
\left\{\begin{array}{l}
i \partial_{t} \varphi_{n}+\Delta \varphi_{n}+\left|\varphi_{n}\right|^{p-1} \varphi_{n}+E_{1}\left(\left|\varphi_{n}\right|^{2}\right) \varphi_{n}=0, \quad(t, x) \in \mathbb{R} \times \mathbb{R}^{2}  \tag{5.12}\\
\varphi_{n}\left(T_{n}, x\right)=R\left(T_{n}\right)
\end{array}\right.
$$

In the following, according to Martel, Merle and Tsai's way (see [22] and [23]), we first state the following claim.

Claim 5.2. (Claim 1 in [22) Let $\left(v_{k}\right), k=1, \cdots, K$ be $K$ vectors of $\mathbb{R}^{2}$ such that for any $k \neq k^{\prime}, v_{k} \neq v_{k^{\prime}}$. Then, there exists an orthonormal basis $\left(e_{1}, e_{2}\right)$ of $\mathbb{R}^{2}$ such that for any $k \neq k^{\prime},\left(v_{k}, e_{1}\right) \neq\left(v_{k^{\prime}}, e_{1}\right)$.

Without any restriction, we can assume that the direction $e_{1}$ given by Claim 5.2 is $x_{1}$, since (1.1) is invariant by rotation. Therefore, we may assume that for any $k \neq k^{\prime}, v_{k, 1} \neq v_{k^{\prime}, 1}$. We suppose in fact that

\begin{equation*}
v_{1,1}<v_{2,1}<\cdots<v_{K, 1} \tag{5.13}
\end{equation*}
$$

Since (5.13) and $\omega_{k}^{0} \in\left(0, \omega_{J}\right)$ with $k=1, \cdots, K$, we can set $\theta_{0}>0$ such that

\sqrt{\theta_{0}}=\frac{1}{16} \min \left(v_{2,1}-v_{1,1}, \cdots, v_{K, 1}-v_{K-1,1}, \quad \sqrt{\omega_{1}^{0}}, \cdots, \sqrt{\omega_{K}^{0}}\right) . \tag{5.14}
\end{equation*}
$$

Now we state the following uniform estimates about the sequence $\left(\varphi_{n}\right)$ in (5.12), which is the key point of the proof of Theorem 5.1.

Proposition 5.3. There exist $T_{0}>0, C_{0}>0, \theta_{0}>0$ such that, for all $n \geq 1$,

\forall t \in\left[T_{0}, T_{n}\right], \quad\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}} \leq C_{0} e^{-\theta_{0} t} \tag{5.15}
\end{equation*}

In addition, the sequence $\left(\varphi_{n}\right)$ has the following global bounded property.
Lemma 5.4. There exists a constant $C>0$, such that, for any $t \in\left[T_{0}, T_{n}\right]$ and all $n \geq 1$,

\left\|\varphi_{n}(t)\right\|_{H^{1}} \leq C
$$

Claim 5.5. ((25) in (9) Take $\epsilon_{0}>0$. There exists $K_{0}=K_{0}\left(\epsilon_{0}\right)>0$ such that for all $n$ large enough, we have

\int_{|x|>K_{0}}\left|\varphi_{n}\left(T_{0}, x\right)\right|^{2} d x \leq \epsilon_{0} . \tag{5.16}
\end{equation*}
$$

Lemma 5.6. There exists $\psi_{0} \in H^{1}$ such that up to a subsequence for $0 \leq s<1$

$$
\begin{equation*}
\varphi_{n}\left(T_{0}\right) \rightarrow \psi_{0}, \quad \text { in } H^{s}\left(\mathbb{R}^{2}\right) \text { as } n \rightarrow+\infty \tag{5.17}
\end{equation*}
$$

Proof. By Lemma 5.4, there exists $\psi_{0} \in H^{1}$ such that up to a subsequence,

$$
\varphi_{n}\left(T_{0}\right) \rightharpoonup \psi_{0} \quad \text { in } H^{1} \text { as } n \rightarrow+\infty
$$

From Lemma 5.5, it follows that

\varphi_{n}\left(T_{0}\right) \rightarrow \psi_{0} \quad \text { in } L_{\text {loc }}^{2}\left(\mathbb{R}^{2}\right) \text { as } n \rightarrow+\infty
$$

we conclude that

$$
\varphi_{n}\left(T_{0}\right) \rightarrow \psi_{0} \quad \text { in } L^{2} \text { as } n \rightarrow+\infty
$$

By interpolation we get (5.17).
This completes the proof of Lemma 5.6.
Proof of Theorem 5.1. Let $\psi_{0}$ be given by Lemma 5.6. There exists $0<\sigma<1$ such that $1<p<1+\frac{4}{2-2 \sigma}$ and

\begin{align*}
\mid\left(\left|z_{1}\right|^{p-1} z_{1}+E_{1}\left(\left|z_{1}\right|^{2}\right) z_{1}\right) & -\left(\left|z_{2}\right|^{p-1} z_{2}+E_{1}\left(\left|z_{2}\right|^{2}\right) z_{2}\right) \mid \\
& \leq C\left(1+\left|z_{1}\right|+\left|z_{2}\right|\right)\left|z_{1}-z_{2}\right| \tag{5.18}
\end{align*}
$$

for all $z_{1}, z_{2} \in \mathbb{C}$. This implies that the Cauchy problem of $(1.1)$ with $\varphi\left(T_{0}, x\right)=\psi_{0}$ is well-posedness in $H^{\sigma}\left(\mathbb{R}^{2}\right)$ (see Theorem 5.1.1 in [6], also refer to [5). Then we let
$\varphi(t, x) \in C\left(\left[T_{0}, T\right], H^{\sigma}\left(\mathbb{R}^{2}\right)\right)$ be the corresponding maximal solution of (1.1) with $\varphi\left(T_{0}, x\right)=\psi_{0}$. Combining with Lemma 5.6 , we can obtain

\varphi_{n}(t) \rightarrow \varphi(t) \text { in } H^{\sigma}\left(\mathbb{R}^{2}\right) \text { as } n \rightarrow+\infty
$$

for any $t \in\left[T_{0}, T\right)$. By boundedness of $\varphi_{n}(t)$ in $H^{1}$, we also have

\varphi_{n}(t) \rightharpoonup \varphi(t) \text { in } H^{1} \text { as } n \rightarrow+\infty
$$

for any $t \in\left[T_{0}, T\right)$. By Proposition 5.3, for any $t \in\left[T_{0}, T\right)$, we have

$$
\begin{equation*}
\|\varphi(t)-R(t)\|_{H^{1}} \leq \liminf _{n \rightarrow \infty}\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}} \leq C_{0} e^{-\theta_{0} t} \tag{5.19}
\end{equation*}
$$

In particular, since $R(t)$ is bounded in $H^{1}$ there exists $C>0$ such that for any $t \in\left[T_{0}, T\right)$ we have

$$
\begin{equation*}
\|\varphi(t)\|_{H^{1}} \leq C_{0} e^{-\theta_{0} t}+\|-R(t)\|_{H^{1}} \leq C \tag{5.20}
\end{equation*}
$$

Recall that, by the blow up alternative (see [6), either $T=+\infty$ or $T<+\infty$ and $\lim _{t \rightarrow T}\|\varphi(t)\|_{H^{1}}=+\infty$. Therefore (5.20) implies that $T=+\infty$. From (5.19) we infer that for all $t \in\left[T_{0},+\infty\right)$ we have

\|\varphi(t)-R(t)\|_{H^{1}} \leq C_{0} e^{-\theta_{0} t} .
$$

This completes the proof of Theorem 5.1.
The proof of the uniform estimates Proposition 5.3 relies on a bootstrap argument. We first state the following bootstrap result.

Proposition 5.7. There exist $A_{0}>0, \theta_{0}>0, T_{0}>0$ and $N_{0}>0$ such that for all $n \geq N_{0}$ and $t^{*} \in\left[T_{0}, T_{n}\right]$, if

\forall t \in\left[t^{*}, T_{n}\right], \quad\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}} \leq A_{0} e^{-\theta_{0} t} \tag{5.21}
\end{equation*}

\forall t \in\left[t^{*}, T_{n}\right], \quad\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}} \leq \frac{A_{0}}{2} e^{-\theta_{0} t} \tag{5.22}
\end{equation*}
$$

By Proposition 5.7, we deduce the uniform estimates Proposition 5.3.
Proof of Proposition 5.3.(Proposition 1 in [22]) Let $t^{*}$ be the minimal time such that (5.21) holds:

t^{*}=\min \left\{\tau \in\left[T_{0}, T_{n}\right] ;(5.21) \text { holds for all } t \in\left[\tau, T_{n}\right]\right\} .

We prove by contradiction that $t^{*}=T_{0}$. Indeed, assume that $t^{*}>T_{0}$. Then

$$

and by Proposition 5.7 we can improve this estimate in

\left\|\varphi_{n}\left(t^{*}\right)-R\left(t^{*}\right)\right\|_{H^{1}} \leq \frac{A_{0}}{2} e^{-\theta_{0} t}
$$

Hence, by continuity of $\varphi_{n}(t)$ in $H^{1}$, there exists $T_{0} \leq t^{* *}<t^{*}$ such that (5.21) holds for all $t \in\left[t^{* *}, t^{*}\right]$. This contradicts the minimality of $t^{*}$.

This completes the proof of Proposition 5.3.

& -E_{1}(\operatorname{Re}(\widetilde{\widetilde{R}} \varepsilon))|\widetilde{R}|^{2}+\|\varepsilon\|_{H^{1}}^{2} \beta\left(\|\varepsilon\|_{H^{1}}\right) \tag{5.73}
\end{align*}
$$

Note that the $\widetilde{R}_{k}(t)$ and $E_{1}\left(\left|\widetilde{R}_{k}(t)\right|^{2}\right)$ are exponentially decaying, we have that

$$
\begin{align*}
E\left(\varphi_{n}\right) & =\sum_{k=1}^{K}\left(E\left(\widetilde{R}_{k}\right)-2 \operatorname{Re} \int\left(\Delta \overline{\widetilde{R}}_{k}+\left|\widetilde{R}_{k}(t)\right|^{p-1} \overline{\widetilde{R}}_{k}+E_{1}\left(\left|\widetilde{R}_{k}\right|^{2}\right) \overline{\widetilde{R}}_{k}\right) \varepsilon d x\right) \\
& -\sum_{k=1}^{K} \int\left|\widetilde{R}_{k}\right|^{p-1}|\varepsilon|^{2}+(p-1)\left|\widetilde{R}_{k}\right|^{p-3}\left(\operatorname{Re}\left(\widetilde{\widetilde{R}}_{k} \varepsilon\right)\right)^{2} d x \\
- & \sum_{k=1}^{K} \frac{1}{2} \int\left(E_{1}\left(\left|\widetilde{R}_{k}\right|^{2}\right)|\varepsilon|^{2}+E_{1}\left(|\varepsilon|^{2}\right)\left|\widetilde{R}_{k}\right|^{2}+4 E_{1}\left(\operatorname{Re}\left(\overline{\widetilde{R}}_{k} \varepsilon\right)\right) \overline{\widetilde{R}}_{k} \varepsilon\right) d x \\
& +\int|\nabla \varepsilon|^{2} d x+\|\varepsilon\|_{H^{1}}^{2} \beta\left(\|\varepsilon\|_{H^{1}}\right)+O\left(e^{-2 \theta_{0} t}\right) \tag{5.74}
\end{align*}
$$

Now we turn to $J(t)$. Expanding $\varphi_{n}(t)=\widetilde{R}(t)+\varepsilon(t)$ in the expression of $I_{k}(t)$

$$
I_{k}(t)=\int|\widetilde{R}(t)|^{2} y_{k}(t) d x+\int|\varepsilon(t)|^{2} y_{k}(t) d x+2 \operatorname{Re} \int \overline{\widetilde{R}}(t) \varepsilon(t) y_{k}(t) d x
$$

By the properties of $y_{k}$, the properties of $\widetilde{R}(t)$ and the orthogonality conditions on $\varepsilon(t)$, we get that

$$
I_{k}(t)=\int\left|\widetilde{R}_{k}(t)\right|^{2} d x+\int|\varepsilon(t)|^{2} y_{k}(t) d x+O\left(e^{-2 \theta_{0} t}\right)
$$

Similarly, for $M_{k}(t)$, we have

$$
M_{k}(t)=\operatorname{Im} \int \nabla \widetilde{R}_{k} \widetilde{\widetilde{R}}_{k} d x-2 \operatorname{Im} \int \nabla \overline{\widetilde{R}}_{k} \varepsilon d x+\operatorname{Im} \int \nabla \varepsilon \bar{\varepsilon} y_{k}(t) d x+O\left(e^{-2 \theta_{0} t}\right)
$$

It follows that

$$
\begin{align*}
J(t) & =\sum_{k=1}^{K}\left(\left(\omega_{k}^{0}+\frac{1}{4}\left|v_{k}\right|^{2}\right)\left(\int\left|\widetilde{R}_{k}\right|^{2} d x+2 \operatorname{Re} \int \widetilde{\widetilde{R}}_{k} \varepsilon d x+\int|\varepsilon|^{2} y_{k}(t) d x\right)\right) \\
& -\sum_{k=1}^{K}\left(v_{k}\left(\operatorname{Im} \int \nabla \widetilde{R}_{k} \widetilde{\widetilde{R}}_{k} d x-2 \operatorname{Im} \int \nabla \widetilde{\widetilde{R}}_{k} \varepsilon d x+\operatorname{Im} \int \nabla \varepsilon \bar{\varepsilon} y_{k}(t) d x\right)\right) \\
& +O\left(e^{-2 \theta_{0} t}\right) \tag{5.75}
\end{align*}
$$

By the equation of $\widetilde{R}_{k}(t)$, and the orthogonality conditions on $\varepsilon(t)$, we have

$$
\begin{array}{r}
-2 R e \int\left(\Delta \overline{\widetilde{R}}_{k}+\left|\widetilde{R}_{k}\right|^{p-1} \overline{\widetilde{R}}_{k}+E_{1}\left(\left|\widetilde{R}_{k}\right|^{2}\right) \overline{\widetilde{R}}_{k}\right) \varepsilon d x+2\left(\omega_{k}^{0}+\frac{1}{4}\left|v_{k}\right|^{2}\right) R e \int \overline{\widetilde{R}}_{k} \varepsilon d x \\
+2 v_{k} \operatorname{Im} \int \nabla \overline{\widetilde{R}}_{k} \varepsilon d x=0
\end{array}
$$

which means that the terms of order 1 in $\varepsilon(t)$ all disappear when we sum $E\left(\varphi_{n}(t)\right)$ and $J(t)$. Therefore, with the definition of $P(\varepsilon(t), \varepsilon(t))$, we obtain (5.69).

This completes the proof of Lemma 5.15.
Lemma 5.16.(Lemma 4.11 in [23]) There exists $\lambda>0$ such that for all $t \in\left[t^{*}, T_{n}\right]$,

$$
\begin{equation*}
P(\varepsilon(t), \varepsilon(t)) \geq \lambda\|\varepsilon(t)\|_{H^{1}}^{2} . \tag{5.76}
\end{equation*}
$$

Combining with Lemma 5.10, Lemma 5.11, Lemma 5.15 and Lemma 5.16, we can deduce the following lemma according to Martel and Merle's way [22].

Lemma 5.17. (Lemma 5 in [22]) For any $t \in\left[t^{*}, T_{n}\right]$

$$
\begin{equation*}
\|\varepsilon(t)\|_{H^{1}}^{2}+\left|\omega_{k}(t)-\omega_{k}^{0}\right|+\left|x_{k}(t)\right|^{2}+\left|\gamma_{k}(t)-\gamma_{k}^{0}\right|^{2} \leq C\left(\frac{A_{0}^{2}}{L}+1\right) e^{-2 \theta_{0} t} \tag{5.77}
\end{equation*}
$$

Lemma 5.18. For any $t \in\left[t^{*}, T_{n}\right]$, there exists $C>0$ such that

$$
\begin{equation*}
\|R(t)-\tilde{R}(t)\|_{H^{1}\left(\mathbb{R}^{2}\right)} \leq C \sum_{k=1}^{K}\left(\left|\omega_{k}(t)-\omega_{k}^{0}\right|+\left|x_{k}(t)\right|+\left|\gamma_{k}(t)-\gamma_{k}^{0}\right|\right) \tag{5.78}
\end{equation*}
$$

Proof. By (5.5), (5.9), (5.32), (5.33) and (5.34), we have

$$
\begin{align*}
\widetilde{R}_{k}(t) & =R_{k}(t)+\left.\left(\omega_{k}(t)-\omega_{k}^{0}\right) \frac{d Q_{\omega_{k}(t)}}{d \omega}\left(\cdot-\widetilde{x}_{k}(t)\right) e^{i\left(\frac{1}{2} v_{k} x+\delta_{k}(t)\right)}\right|_{\omega_{k}(t)=\omega_{k}^{0}, x_{k}(t)=0, \gamma_{k}(t)=\gamma_{k}^{0}} \\
& -\left.x_{k}(t) \nabla \widetilde{R}_{k}(t)\right|_{\omega_{k}(t)=\omega_{k}^{0}, x_{k}(t)=0, \gamma_{k}(t)=\gamma_{k}^{0}}+\left.i\left(\gamma_{k}(t)-\gamma_{k}^{0}\right) \widetilde{R}_{k}(t)\right|_{\omega_{k}(t)=\omega_{k}^{0}, x_{k}(t)=0, \gamma_{k}(t)=\gamma_{k}^{0}} \\
& +O\left(\left(\omega_{k}(t)-\omega_{k}^{0}\right)^{2}\right)+O\left(x_{k}^{2}(t)\right)+O\left(\left(\gamma_{k}(t)-\gamma_{k}^{0}\right)^{2}\right) \tag{5.79}
\end{align*}
$$

By (5.79), Lemma 5.9 and Lemma 5.17 deduce that

$$
\|R(t)-\tilde{R}(t)\|_{H^{1}} \leq C \sum_{k=1}^{K}\left(\left|\omega_{k}(t)-\omega_{k}^{0}\right|+\left|x_{k}(t)\right|+\left|\gamma_{k}(t)-\gamma_{k}^{0}\right|\right)
$$

This proves Lemma 5.18.
Proof of Proposition 5.7. From Lemma 5.18, we get for all $t \in\left[t^{*}, T_{n}\right]$

$$
\begin{align*}
\|R(t)-\tilde{R}(t)\|_{H^{1}}^{2} & \leq C \sum_{k=1}^{K}\left(\left|\omega_{k}(t)-\omega_{k}^{0}\right|^{2}+\left|\gamma_{k}(t)-\gamma_{k}^{0}\right|^{2}+\left|x_{k}(t)\right|^{2}\right) \\
& \leq C\left(\frac{A_{0}^{2}}{L}+1\right) e^{-2 \theta_{0} t} \tag{5.80}
\end{align*}
$$

By Lemma 5.17 and (5.80), we have

$$
\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}}^{2} \leq 2\|\varepsilon(t)\|_{H^{1}}^{2}+2\|\tilde{R}(t)-R(t)\|_{H^{1}}^{2} \leq C\left(\frac{A_{0}^{2}}{L}+1\right) e^{-2 \theta_{0} t}
$$

where $C>0$ does not depend on $A_{0}$. Now we choose $A_{0}^{2}>8 C, L=A_{0}^{2}$, and $T_{0}$ large enough. It follows that

$$
\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}}^{2} \leq 2 C e^{-2 \theta_{0} t} \leq \frac{A_{0}^{2}}{4} e^{-2 \theta_{0} t}
$$

Therefore, the conclusion is that for any $t \in\left[t^{*}, T_{n}\right],\left\|\varphi_{n}(t)-R(t)\right\|_{H^{1}} \leq \frac{A_{0}}{2} e^{-\theta_{0} t}$.
This completes the proof of Proposition 5.7.
Corollary 5.19. For multi-solitons $\varphi(t, x)$ of (1.1) in Theorem 5.1, we have that $\varphi(t, x)$ satisfying $\int|\varphi(t, x)|^{2} d x<2 d_{J}$ with $t \in \mathbb{R}$.

Proof. From Claim 5.5,

$$
\left\|\psi_{0}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)} \leq \liminf _{n \rightarrow \infty}\left\|\varphi_{n}\left(T_{0}\right)\right\|_{L^{2}}<\sqrt{2 d_{J}}
$$

By Theorem 5.1,

$$
\|\varphi(t)\|_{L^{2}}=\left\|\psi_{0}\right\|_{L^{2}}, \quad t \in \mathbb{R}
$$

It follows that $\int|\varphi(t)|^{2} d x<2 d_{J}$ for $t \in \mathbb{R}$.
This proves Corollary 5.19.
