# Repeated Angles in the Plane for Angles with Algebraic Tangents

#### Abstract

We construct a set of points with $\Omega\left(n^{2} \log n\right)$ triples determining an angle $\theta$ whenever $\tan (\theta)$ is algebraic over $\mathbb{Q}$, matching the upper bound of Pach and Sharir. This improves upon the original construction, which was optimal only for $\tan (\theta)=a \sqrt{m} / b$ with $a, b, m$ positive integers.


## 1 Introduction

Pach and Sharir [4] proved that, for all $0<\theta<\pi$, any set of $n$ points in the Euclidean plane contains at most $O\left(n^{2} \log n\right)$ triples which determine an angle with measure $\theta$. They also showed that, for $\tan (\theta)=\frac{a \sqrt{m}}{b}$ with $a, b, m$ positive integers, this upper bound is tight, and that there exists a configuration of $n$ points in the plane with $\Omega_{\theta}\left(n^{2} \log n\right)$ triples determining angle $\theta$. However, for other $\theta$, it remains open whether the upper bound is asymptotically tight (see problem 6, Chapter 6.2 in [1]).
We shall construct a configuration of $n$ points with $\Omega_{\theta}\left(n^{2} \log n\right)$ triples determining angle $\theta$ for any $0<\theta<$ $\pi$ where $\tan (\theta)$ is algebraic over $\mathbb{Q}$. This class contains many angles of geometric interest; in particular, this gives a construction with $\Omega\left(n^{2} \log n\right)$ triples if $\theta$ is any rational multiple of $\pi$, as well as for any constructible angle $\theta$.

The question remains open in the case that $\tan (\theta)$ is transcendental. We note the similar problem of determining the maximum number of subsets similar to a desired set $S$; Laczkovich and Ruzsa [3] showed that there exist configurations with $\Omega\left(n^{2}\right)$ copies, matching the trivial upper bound, if and only if the crossratio of every quadruple in $S$ is algebraic. Their construction builds upon that of Elekes and Erdős [2], which finds similar copies within "pseudo-grids," which are grid-like configurations of points made from generalized arithemetic progressions. Our construction makes use of a similar idea, generalizing the original approach of Pach and Sharir [4] from rectangle lattice grids to similar grid-like sets.

## 2 Proof

Theorem 2.1. If $\tan (\theta)$ is algebraic over $\mathbb{Q}$, then for $n \geq 3$, there exist arrangements of $n$ points in the Euclidean plane with $\Omega_{\theta}\left(n^{2} \ln n\right)$ triples determining angle $\theta$.

Proof. Let $\tan (\theta)$ be a algebraic. Then we can write $\tan (\theta)=\frac{\alpha}{b}$, where $b \in \mathbb{Z}$ and $\alpha$ is a positive real algebraic integer. Then we can write $\alpha$ as the root of a monic, irreducible polynomial of degree $d$ in $\mathbb{Z}[x]$. So $\mathbb{Z}[\alpha]$ is a $\mathbb{Z}$-module with basis $1, \alpha, \ldots, \alpha^{d-1}$.

We shall represent the Euclidean plane as $\mathbb{C}$. Note that $b+i \alpha$ will have argument $\theta$, so we seek triples of the form $z, z+\lambda_{1} v, z+(b+i \alpha) \lambda_{2} v$, with $z, v \in \mathbb{C}$ and $\lambda_{1}, \lambda_{2} \in \mathbb{R}$. Fix some positive integer $t$ (to be determined later), and define $\mathcal{K}_{t}$ and $\mathcal{G}_{t}$ as

$$
\begin{gathered}
\mathcal{K}_{t}:=\left\{\sum_{k=0}^{d-1} a_{k} \alpha^{k}: a_{k} \in \mathbb{Z},\left|a_{k}\right| \leq t\right\} \\
\mathcal{G}_{t}:=\mathcal{K}_{t}+i \mathcal{K}_{t}=\left\{u_{1}+i u_{2}: u_{1}, u_{2} \in \mathcal{K}_{t}\right\}
\end{gathered}
$$

Note that $\mathcal{G}_{t}$ is the cartesian product of two real generalized arithmetic progression, while the pseduo-grids of Elekes and Erdős [2] are one complex generalized arithmetic progression. Clearly, $\left|\mathcal{K}_{t}\right|=(2 t+1)^{d}$ and $\left|\mathcal{G}_{t}\right|=(2 t+1)^{2 d}$.

First, suppose $\mu \in \mathcal{K}_{s}$ and $\lambda \in \mathcal{K}_{t}$; clearly, $\mu+\lambda \in \mathcal{K}_{s+t}$. We shall now consider $\mu \lambda$. Since $\alpha$ is an algebraic integer with minimal polynomial of degree $d$, we can write $\alpha^{d}=c_{0}+c_{1} \alpha+\cdots+c_{d-1} \alpha^{d-1}$ for $c_{i} \in \mathbb{Z}$; let $C_{1}=1+\max \left(\left|c_{0}\right|,\left|c_{1}\right|, \ldots,\left|c_{d-1}\right|\right)$. By writing $\lambda=a_{0}+a_{1} \alpha+\cdots+a_{d-1} \alpha^{d-1}$ with $a_{i} \in \mathbb{Z}$, $\left|a_{i}\right| \leq t$, we see that $\alpha \lambda=\left(a_{0} \alpha+\cdots+a_{d-2} \alpha^{d-1}\right)+a_{d-1}\left(c_{0}+\cdots+c_{d-1} \alpha^{d-1}\right) \in \mathcal{K}_{C_{1} t}$. Applying this observation repeatedly, we see that $\alpha^{k} \lambda \in \mathcal{K}_{C_{1}^{k} t}$. Hence, if we write $\mu=b_{0}+b_{1} \alpha+\cdots+b_{d-1} \alpha^{d-1}$, we see that $\mu \lambda=b_{0} \lambda+b_{1} \alpha \lambda+\cdots+b_{d-1} \alpha^{d-1} \lambda \in \mathcal{K}_{d C_{1}^{d-1} s t}$.

Now suppose $u=\left(u_{1}+i u_{2}\right) \in \mathcal{G}_{s}$ and $v=\left(v_{1}+i v_{2}\right) \in \mathcal{G}_{t}$. Then $u+v=\left(u_{1}+u_{2}\right)+i\left(v_{1}+v_{2}\right) \in \mathcal{G}_{s+t}$, and $u v=\left(u_{1}+i u_{2}\right)\left(v_{1}+i v_{2}\right)=\left(u_{1} v_{1}-u_{2} v_{2}\right)+i\left(u_{1} v_{2}+u_{2} v_{1}\right) \in \mathcal{G}_{2 d C_{1}^{d-1}}$. Letting $C_{2}=2 d C_{1}^{d-1}$, we have that $u v \in \mathcal{G}_{C_{2} s t}$.

Ungar [5] proved that a set of $N$ points forms has at least $N-1$ pairs of points each forming a distinct direction. By applying this to the set $\mathcal{G}_{t}$, we see that $\mathcal{G}_{t}$ contains at least $(2 t+1)^{2 d}-1 \geq(2 t)^{2 d}$ pairs giving distinct directions. Since $\mathcal{G}_{t}-\mathcal{G}_{t} \subseteq \mathcal{G}_{2 t}$, this means that the nonzero elements of $\mathcal{G}_{2 t}$ determine at least $(2 t)^{2 d}$ distinct arguments (directions) from $[0, \pi)$.
Now, for each $1 \leq k \leq t$, pick $T_{k}$ as $(2 k)^{2 d}-(2(k-1))^{2 d} \geq(2 k)^{2 d-1}$ elements from $\mathcal{G}_{2 k}$ whose angles are all distinct from each other and those of $T_{1}, \ldots, T_{k-1}$.
For each choice of $v \in \bigcup_{k=1}^{t} T_{k}$ and each $0<\lambda \in \mathcal{K}_{\lfloor t / k\rfloor}$, the element $\lambda v$ is distinct, since each $v \in T_{k}$ has a distinct angle and each $\lambda$ is a unique positive real number. Moreover, if $v \in T_{k} \subseteq \mathcal{G}_{2 k}$ and $\lambda \in \mathcal{K}_{\lfloor t / k\rfloor}$, $\lambda v \in \mathcal{G}_{C_{2}(2 k)\lfloor t / k\rfloor} \subseteq \mathcal{G}_{2 C_{2} t}$. Therefore, for any choice of $1 \leq k \leq t$ and any $z \in \mathcal{G}_{t}, v \in T_{k} \subseteq \mathcal{G}_{2 k}$, and $\lambda_{1}, \lambda_{2} \in \mathcal{K}_{\lfloor t / k\rfloor}$ with $\lambda_{1}, \lambda_{2}>0$, the triple

$$
\left(z, z+\lambda_{1} v, z+(b+i \alpha) \lambda_{2} v\right)
$$

is a unique triple determining angle $\theta$. Observe that $z+\lambda_{1} v \in \mathcal{G}_{t+2 C_{2} t}$ and (since $\left.b+i \alpha \in \mathcal{G}_{|b|}\right) z+(b+$ $\alpha i) \lambda_{2} v \in \mathcal{G}_{t+C_{2}|b|\left(2 C_{2} t\right)}=\mathcal{G}_{\left(1+2|b| C_{2}^{2}\right) t}$, so for all choices of $z, v, \lambda_{1}, \lambda_{2}$, we have $z, z+\lambda_{1} v, z+(b+i \alpha) v \in$ $\mathcal{G}_{\left(1+2|b| C_{2}^{2}\right) t}$. Since the elements of $\mathcal{K}_{\lfloor t / k\rfloor}$ are equally distributed between positive and negative, with one element 0 , the number of choices for $\lambda_{1}$ and $\lambda_{2}$ is $\left(\frac{\left|\mathcal{K}_{\lfloor t / k\rfloor}\right|-1}{2}\right)=\frac{\left(2\left\lfloor\frac{t}{k}\right\rfloor+1\right)^{2 d}-1}{2} \geq\left\lfloor\frac{t}{k}\right\rfloor^{2 d}$. Hence the total number of triples chosen in this way is

$$
\begin{aligned}
\left|\mathcal{G}_{t}\right| \sum_{k=1}^{t}\left|T_{k}\right|\left\lfloor\frac{t}{k}\right]^{2 d} & \geq(2 t+1)^{2 d} \sum_{k=1}^{t}(2 k)^{d-1}\left(\frac{t}{2 k}\right)^{2 d} \\
& \geq t^{2 d} \sum_{k=1}^{t} k^{2 d-1}\left(\frac{t}{k}\right)^{2 d} \\
& =t^{4 d} \sum_{k=1}^{t} \frac{1}{k} \\
& \geq t^{4 d} \ln t
\end{aligned}
$$

Hence, there are at least $t^{4 d} \ln t$ triples which determine angle $\theta$ with elements chosen from $\mathcal{G}_{\left(1+2|b| C_{2}^{2}\right) t}$. This set contains $\left(2\left(1+2|b| C_{2}^{2}\right) t+1\right)^{2 d} \leq\left(4|b| C_{2}^{2}+3\right)^{2 d} t^{2 d}$, so if we let $C_{3}=\left(4|b| C_{2}^{2}+3\right)^{2 d}$, we have a set of at most $C_{3} t^{2 d}$ points whose elements form at least $t^{4 d} \ln t$ triples.
Now, for an arbitrary $n$, pick $t$ so that $C_{3} t^{2 d}<n \leq C_{3}(t+1)^{2 d}$. If $n \geq C_{3}$, then we have a set with $C_{3} t^{2 d} \leq n$ points. Moreover, if $t \geq 1$, then $n \leq C_{3}(2 t)^{2 d}$, so $t \geq \frac{\left(n / C_{3}\right)^{1 / 2 d}}{2}$, so the number of triples determining angle $\theta$ is at least $t^{4 d} \ln t \geq \frac{\left(n / C_{3}\right)^{2}}{2^{4 d}} \ln \left(\frac{\left(n / C_{3}\right)^{1 / 2 d}}{2}\right)=\frac{n^{2}}{2 d C_{3}^{2} 2^{4 d}} \ln \left(\frac{n}{2^{2 d} C_{3}}\right)$. Since $d$ and $C_{3}$ depend only on our angle $\theta$ and not on $n$, we have a construction of at most $n$ points with $\Omega_{\theta}\left(n^{2} \log n\right)$ triples determining angle $\theta$, as desired.
