# EXISTENCE OF WEAK SOLUTION TO VOLUME PRESERVING MEAN CURVATURE FLOW IN HIGHER DIMENSIONS

#### Abstract

In this paper, we construct a family of integral varifolds, which is a global weak solution to the volume preserving mean curvature flow in the sense of $L^{2}$-flow. This flow is also a distributional BV-solution for a short time, when the perimeter of the initial data is sufficiently close to that of ball with the same volume. To construct the flow, we use the Allen-Cahn equation with non-local term motivated by studies of Mugnai, Seis, and Spadaro, and Kim and Kwon. We prove the convergence of the solution for the AllenCahn equation to the family of integral varifolds with only natural assumptions for the initial data.


## 1. Introduction

Let $d \geq 2$ be an integer and $\Omega:=\mathbb{T}^{d}=(\mathbb{R} / \mathbb{Z})^{d}$. Assume that $T>0$ and $U_{t} \subset \Omega$ is an open set with the smooth boundary $M_{t}:=\partial U_{t}$ for any $t \in[0, T)$. The family of the hypersurfaces $\left\{M_{t}\right\}_{t \in[0, T)}$ is called the volume preserving mean curvature flow if the normal velocity vector $\vec{v}$ satisfies

\vec{v}=\vec{h}-\left(\frac{1}{\mathscr{H}^{d-1}\left(M_{t}\right)} \int_{M_{t}} \vec{h} \cdot \vec{\nu} d \mathscr{H}^{d-1}\right) \vec{\nu}, \quad \text { on } M_{t}, t \in(0, T) . \tag{1.1}
\end{equation*}
$$

Here, $\mathscr{H}^{d-1}$ is the $(d-1)$-dimensional Hausdorff measure, and $\vec{h}$ and $\vec{\nu}$ are the mean curvature vector and the inner unit normal vector of $M_{t}$, respectively. Note that the solution $\left\{M_{t}\right\}_{t \in[0, T)}$ to (1.1) satisfies

\frac{d}{d t} \mathscr{H}^{d-1}\left(M_{t}\right) \leq 0 \quad \text { and } \quad \frac{d}{d t} \mathscr{L}^{d}\left(U_{t}\right)=-\int_{M_{t}} \vec{v} \cdot \vec{\nu} d \mathscr{H}^{d-1}=0, \quad t \in(0, T), \tag{1.2}
\end{equation*}
$$

where $\mathscr{L}^{d}$ is the $d$-dimensional Lebesgue measure. From (1.2), $\left\{M_{t}\right\}_{t \in[0, T)}$ has the volume preserving property, that is, $\mathscr{L}^{d}\left(U_{t}\right)$ is constant with respect to $t$.

When $U_{0}$ is convex, Gage [13] and Huisken [16] proved that there exists a solution to (1.1) and it converges to a sphere as $t \rightarrow \infty$. Escher and Simonett [10] showed the short time existence of the solution to (1.1) for smooth initial data $M_{0}$ and they also proved that if $M_{0}$ is sufficiently close to a sphere in the sense of the little Hölder norm $h^{1+\alpha}$, then there exists a global solution and it converges to some sphere as $t \rightarrow \infty$ (see also [3, 4, 25] for related results). Mugnai, Seis, and Spadaro 31 studied the minimizing movement for (1.1) and they proved the global existence of the flat flow, that is, there exist $C=C\left(d, U_{0}\right)>0$ and a family of Caccioppoli sets $\left\{U_{t}\right\}_{t \in[0, \infty)}$ such that $\mathscr{L}^{d}\left(U_{s} \triangle U_{t}\right) \leq C \sqrt{s-t}$ for any $0 \leq t<s, \mathscr{H}^{d-1}\left(\partial^{*} U_{t}\right)$ is monotone decreasing, and $\mathscr{L}^{d}\left(U_{t}\right)$ is constant. Here, $\partial^{*} U_{t}$ is the reduced boundary of $U_{t}$. In addition, for $d \leq 7$, they proved the global existence of the

[^0]weak solution to (1.1) in the sense of the distribution, under the reasonable assumption for the convergence, that is,

where $\left\{U_{t}^{k}\right\}_{t \in[0, T)}$ is the time-discretized approximate solution to (1.1). This kind of condition was introduced in [27] (see also [1, 22]). Laux and Swartz [24] showed the convergence of the thresholding schemes to the distributional BV-solutions of (1.1) under an assumption of the convergence similar to (1.3). Laux and Simon [23] also proved similar results in the case of the phase field method. On the other hand, the author [36] proved the existence of the weak solution (family of integral varifolds) to (1.1) in the sense of $L^{2}$-flow for $2 \leq d \leq 3$ without any such convergence assumption, via the phase field method studied by Golovaty [15]. Recently, Kim and Kwon [21] proved the existence of the viscosity solution to (1.1) for the case where $U_{0}$ satisfies a geometric condition called $\rho$-reflection. Moreover, they also proved that the viscosity solution converges to some sphere uniformly as $t \rightarrow \infty$.

Let $\left\{\delta_{i}\right\}_{i=1}^{\infty}$ be a positive sequence with $\delta_{i} \rightarrow 0$ as $i \rightarrow \infty$ and we denote $\delta_{i}$ as $\delta$ for simplicity. Suppose that $U_{t}^{\delta}$ is an open set with smooth boundary $M_{t}^{\delta}$ for any $t \in[0, T)$. The approximate solutions studied in [31] and [21] correspond to the following mean curvature flow $\left\{M_{t}^{\delta}\right\}_{t \in[0, T)}$ with non-local term:

\begin{equation*}
\vec{v}=\vec{h}-\lambda^{\delta} \vec{\nu}, \quad \text { on } M_{t}^{\delta}, t \in(0, T), \tag{1.4}
\end{equation*}
$$

where

$$
\lambda^{\delta}(t)=\frac{1}{\delta}\left(\mathscr{L}^{d}\left(U_{0}^{\delta}\right)-\mathscr{L}^{d}\left(U_{t}^{\delta}\right)\right)
$$

One can check that (1.4) is a $L^{2}$-gradient flow of

$$
E^{\delta}(t)=\mathscr{H}^{d-1}\left(M_{t}^{\delta}\right)+\frac{1}{2 \delta}\left(\mathscr{L}^{d}\left(U_{0}^{\delta}\right)-\mathscr{L}^{d}\left(U_{t}^{\delta}\right)\right)^{2}
$$

that is,

$$
\frac{d}{d t} E^{\delta}(t)=-\int_{M_{t}^{\delta}}|\vec{v}|^{2} d \mathscr{H}^{d-1} \leq 0 \quad \text { for any } t \in(0, T)
$$

Hence $\left\{M_{t}^{\delta}\right\}_{t \in[0, T)}$ satisfies a relaxed volume preserving property, namely,

$$
\left(\mathscr{L}^{d}\left(U_{0}^{\delta}\right)-\mathscr{L}^{d}\left(U_{t}^{\delta}\right)\right)^{2} \leq 2 \delta E^{\delta}(t) \leq 2 \delta E^{\delta}(0)=2 \delta \mathscr{H}^{d-1}\left(M_{0}^{\delta}\right) .
$$

Therefore $\left\{M_{t}^{\delta}\right\}_{t \in[0, T)}$ converges to the solution $\left\{M_{t}\right\}_{t \in[0, T)}$ to (1.1) as $\delta \rightarrow 0$ formally. Note that we cannot directly obtain the monotonically decreasing of $\mathscr{H}^{d-1}\left(M_{t}\right)$ by the energy estimates above. However, if we have a natural energy estimate $\sup _{i} \int_{0}^{T}\left|\lambda^{\delta_{i}}(t)\right|^{2} d t \leq C_{T}$ for some constant $C_{T}>0$, we can expect the property in some sense, because

\liminf _{i \rightarrow \infty} \frac{1}{2 \delta_{i}}\left(\mathscr{L}^{d}\left(U_{0}^{\delta_{i}}\right)-\mathscr{L}^{d}\left(U_{t}^{\delta_{i}}\right)\right)^{2}=\liminf _{i \rightarrow \infty} \frac{\delta_{i}}{2}\left|\lambda^{\delta_{i}}(t)\right|^{2}=0 \quad \text { for a.e. } t \in[0, T)
$$

by Fatou's lemma (see Proposition (3.14). The reason why the $L^{2}$-estimate is natural is because the non-local term of the solution to (1.1) satisfies it (see Proposition 6.2). Mugnai, Seis, and Spadaro [31] used a minimizing movement scheme corresponding to (1.4), and Kim and Kwon [21] used (1.4) to prove the existence of the viscosity solution to (1.1). Based on these results, in this paper we show the global existence of the weak solution to (1.1), via the phase field method corresponding to (1.4).

We denote $W(a):=\frac{\left(1-a^{2}\right)^{2}}{2}$ and $k(s)=\int_{0}^{s} \sqrt{2 W(a)} d a=s-\frac{1}{3} s^{3}$. Let $\varepsilon \in(0,1)$, $T>0$, and $\alpha \in(0,1)$. With reference to [31 and [21], in this paper we consider the following Allen-Cahn equation with non-local term:

\begin{cases}\varepsilon \varphi_{t}^{\varepsilon}=\varepsilon \Delta \varphi^{\varepsilon}-\frac{W^{\prime}\left(\varphi^{\varepsilon}\right)}{\varepsilon}+\lambda^{\varepsilon} \sqrt{2 W\left(\varphi^{\varepsilon}\right)}, & (x, t) \in \Omega \times(0, \infty)  \tag{1.5}\\ \varphi^{\varepsilon}(x, 0)=\varphi_{0}^{\varepsilon}(x), & x \in \Omega,\end{cases}
$$

where $\lambda^{\varepsilon}$ is given by

$$
\begin{equation*}
\lambda^{\varepsilon}(t)=\frac{1}{\varepsilon^{\alpha}}\left(\int_{\Omega} k\left(\varphi_{0}^{\varepsilon}(x)\right) d x-\int_{\Omega} k\left(\varphi^{\varepsilon}(x, t)\right) d x\right) . \tag{1.6}
\end{equation*}
$$

Note that if $\varphi_{0}^{\varepsilon}$ satisfies suitable assumptions, the standard PDE theories imply the global existence and uniqueness of the solution to (1.5) (see Remark 3.2). Set

$$
\begin{aligned}
E^{\varepsilon}(t) & =\int_{\Omega}\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}(x, t)\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}(x, t)\right)}{\varepsilon}\right) d x+\frac{1}{2 \varepsilon^{\alpha}}\left(\int_{\Omega} k\left(\varphi_{0}^{\varepsilon}(x)\right) d x-\int_{\Omega} k\left(\varphi^{\varepsilon}(x, t)\right) d x\right)^{2} \\
& =: E_{S}^{\varepsilon}(t)+E_{P}^{\varepsilon}(t)
\end{aligned}
$$

As above, one can check that the solution $\varphi^{\varepsilon}$ to (1.5) satisfies

$$
\begin{gather*}
\frac{d}{d t} E^{\varepsilon}(t)=-\int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x \leq 0 \quad \text { for any } t \in(0, \infty)  \tag{1.7}\\
E^{\varepsilon}(T)+\int_{0}^{T} \int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x d t=E^{\varepsilon}(0)=E_{S}^{\varepsilon}(0) \quad \text { for any } T \geq 0, \tag{1.8}
\end{gather*}
$$

and

$$
\begin{equation*}
\left(\int_{\Omega} k\left(\varphi_{0}^{\varepsilon}(x)\right) d x-\int_{\Omega} k\left(\varphi^{\varepsilon}(x, t)\right) d x\right)^{2}=2 \varepsilon^{\alpha} E_{P}^{\varepsilon}(t) \leq 2 \varepsilon^{\alpha} E_{S}^{\varepsilon}(0) \quad \text { for any } t \in[0, \infty) \tag{1.9}
\end{equation*}
$$

Assume $\sup _{\varepsilon \in(0,1)} E_{S}^{\varepsilon}(0)<\infty$ (this assumption corresponds to $\mathscr{H}^{d-1}\left(M_{0}\right)<\infty$ for (1.1)). Then, we can expect that $\varphi^{\varepsilon}(x, t) \approx 1$ or -1 when $x$ is outside the neighborhood of the zero level set $M_{t}^{\varepsilon}=\left\{x \in \Omega \mid \varphi^{\varepsilon}(x, t)=0\right\}$ for sufficiently small $\varepsilon$. Then we have $\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x \approx$ $\frac{2}{3} \int_{\Omega} \varphi^{\varepsilon} d x$ and thus we can regard (1.9) as a relaxed volume preserving property. The function $\sqrt{2 W\left(\varphi^{\varepsilon}\right)}$ expresses that the non-local term is almost zero when $x$ is outside the neighborhood of $M_{t}^{\varepsilon}$. In addition, $\sqrt{2 W\left(\varphi^{\varepsilon}\right)}$ plays important roles in $L^{\infty}$-estimates and energy estimates (see Proposition 3.3 and Theorem (3.16).

The first main result of this paper is that there exists a global-in-time weak solution to (1.1) for any $d \geq 2$ in the sense of $L^{2}$-flow, under the assumptions on the regularity of $M_{0}$ (see Theorem (2.6). We employ (1.5) to construct the solution. Note that we do not require assumptions such as (1.3). The second main result is that, when $M_{0}$ is $C^{1}$ and the value $\mathscr{H}^{d-1}\left(M_{0}\right) /\left(\mathscr{L}^{d}\left(U_{0}\right)\right)^{\frac{d-1}{d}}$ is sufficiently close to that of a ball, there exists $T_{1}>0$ such that the flow has a unit density for a.e. $t \in\left[0, T_{1}\right)$ and is also a distributional BV-solution up to $t=T_{1}$ (see Theorem [2.8). To obtain the main results, we need to prove that the varifold $V_{t}^{\varepsilon}$ defined by the Modica-Mortola functional [29] converges to a integral varifold for a.e. $t \geq 0$ (roughly speaking, the condition (1.3) corresponds to this convergence). For the standard Allen-Cahn equation without non-local term, this convergence was shown by Ilmanen [20] and Tonegawa 40]. Therefore we can expect the convergence for (1.5) if $\lambda^{\varepsilon}$ has suitable properties. In fact, $\lambda^{\varepsilon}$ can be regarded as an error term when we consider the parabolic
rescaled equation of (1.5). We explain this more precisely. Define $\tilde{\varphi}^{\varepsilon}(\tilde{x}, \tilde{t})=\varphi^{\varepsilon}\left(\varepsilon \tilde{x}, \varepsilon^{2} \tilde{t}\right)$. Then $\tilde{\varphi}^{\varepsilon}$ satisfies

\begin{equation*}
\tilde{\varphi}_{\tilde{t}}^{\varepsilon}=\Delta_{\tilde{x}} \tilde{\varphi}^{\varepsilon}-W^{\prime}\left(\tilde{\varphi}^{\varepsilon}\right)+\varepsilon \lambda^{\varepsilon}\left(\varepsilon^{2} \tilde{t}\right) \sqrt{2 W\left(\tilde{\varphi}^{\varepsilon}\right)} \tag{1.10}
\end{equation*}
$$

where $\Delta_{\tilde{x}}$ is a Laplacian with respect to $\tilde{x}$. Assume $\sup _{x}\left|\varphi_{0}^{\varepsilon}(x)\right|<1$. Then Proposition 3.1 below yields $\sup _{x, t}\left|\varphi^{\varepsilon}(x, t)\right|<1$. Thus we have

\begin{equation*}
\sup _{\tilde{t} \geq 0}\left|\varepsilon \lambda^{\varepsilon}\left(\varepsilon^{2} \tilde{t}\right) \sqrt{2 W\left(\tilde{\varphi}^{\varepsilon}\right)}\right| \leq \sup _{\tilde{t} \geq 0}\left|\varepsilon \lambda^{\varepsilon}\left(\varepsilon^{2} \tilde{t}\right)\right| \leq \frac{4}{3} \mathscr{L}^{d}(\Omega) \varepsilon^{1-\alpha}=\frac{4}{3} \varepsilon^{1-\alpha} \tag{1.11}
\end{equation*}
$$

where we used $\max _{s \in[-1,1]}|k(s)|=\frac{2}{3}$. Therefore, broadly speaking, the non-local term $\varepsilon \lambda^{\varepsilon}\left(\varepsilon^{2} \tilde{t}\right) \sqrt{2 W\left(\tilde{\varphi}^{\varepsilon}\right)}$ is a perturbation (to the best of our knowledge, for (1.1), no phase field model with such a property has been known). Hence we can show the rectifiability and the integrality of the varifold $V_{t}$ with arguments similar to that in [20, 40] (see also [38]). However, the proofs are not exactly the same as those, because the monotonicity formula for (1.5) is different from the standard one (see Proposition 3.9). Therefore we give the proofs in Section 4. In addition, as another good property of $\lambda^{\varepsilon}$, the $L^{2}$-norm can be controlled (see Lemma 3.6). This property is useful when proving the monotonicity formula and the rectifiability of $V_{t}$.

The most well-known phase field model for (1.1) studied by Rubinstein and Sternberg [33] is the following equation.

\begin{cases}\varepsilon \varphi_{t}^{\varepsilon}=\varepsilon \Delta \varphi^{\varepsilon}-\frac{W^{\prime}\left(\varphi^{\varepsilon}\right)}{\varepsilon}+\Lambda^{\varepsilon}, & (x, t) \in \Omega \times(0, T)  \tag{1.12}\\ \varphi^{\varepsilon}(x, 0)=\varphi_{0}^{\varepsilon}(x), & x \in \Omega\end{cases}
$$

where $\Lambda^{\varepsilon}(t)=\frac{1}{\mathscr{L}^{d}(\Omega)} \int_{\Omega} \frac{W^{\prime}\left(\varphi^{\varepsilon}(x, t)\right)}{\varepsilon} d x$. As above, the solution to (1.12) has the volume preserving property $\frac{d}{d t} \int_{\Omega} \varphi^{\varepsilon} d x=0$. Chen, Hilhorst, and Logak 8 proved that for the smooth solution $\left\{M_{t}\right\}_{t \in[0, T)}$ to (1.1), there exists a family of functions $\left\{\varphi_{0}^{\varepsilon_{i}}\right\}_{i=1}^{\infty}$ with $\varepsilon_{i} \rightarrow 0$ such that the level set $M_{t}^{\varepsilon_{i}}=\left\{x \in \Omega \mid \varphi^{\varepsilon_{i}}(x, t)=0\right\}$ converges to $M_{t}$, where $\varphi^{\varepsilon}$ is a solution to (1.12) with initial data $\varphi_{0}^{\varepsilon}$. In addition, as mentioned above, Laux and Simon [23] proved the convergence of the vector-valued version of (1.12) to the weak volume preserving multiphase mean curvature flow under an assumption corresponds to (1.3). However, it is an open problem to show its convergence for (1.12) without such assumptions. One of the difficulties is that the boundedness of $\sup _{\varepsilon>0} \int_{0}^{T}\left|\Lambda^{\varepsilon}\right|^{2} d t$ proved by Bronsard and Stoth [7] does not immediately lead to

\sup _{\varepsilon>0} \int_{0}^{T} \int_{\Omega} \varepsilon\left(\Delta \varphi^{\varepsilon}-\frac{W^{\prime}\left(\varphi^{\varepsilon}\right)}{\varepsilon^{2}}\right)^{2} d x d t<\infty \tag{1.13}
\end{equation*}
$$

Note that (1.13) corresponds to $\int_{0}^{T} \int_{M_{t}}|\vec{h}|^{2} d \mathscr{H}^{d-1} d t<\infty$ of the solution to (1.1) and is important to show the rectifiability of the varifold (see Theorem 3.16 and Theorem 4.9). As another phase field method for (1.1), the study of Brassel and Bretin [6] is known (see [36, Section 1] for a comparison of these equations).

The organization of this paper is as follows. In Section 2, we set our notations and state the main results. In Section 3, to obtain the existence theorem we prove the energy estimates and $L^{\infty}$-estimates for the solution to (1.5). In addition, for $d=2$ or 3 , we give a short proof for the integrality of the limit measure $\mu_{t}$ constructed as a weak solution to (1.1). In Section 4 , we show the integrality of $\mu_{t}$ for any $d \geq 2$. In Section 5 , we prove the main results. In Section 6, we give some supplements for this paper.

## 2. Preliminaries and main results

2.1. Notations and definitions. For $r>0, d \in \mathbb{N}$, and $x \in \mathbb{R}^{d}$, we denote $B_{r}^{d}(x):=$ $\left\{y \in \mathbb{R}^{d}| | x-y \mid<r\right\}$ (we often write this as $B_{r}(x)$ for simplicity). We define $\omega_{d}:=$ $\mathscr{L}^{d}\left(B_{1}^{d}(0)\right)$. For $d \times d$ matrix $A=\left(a_{i j}\right)$ and $B=\left(b_{i j}\right)$, we define $A \cdot B:=\sum_{i, j} a_{i j} b_{i j}$. For $a=\left(a_{1}, a_{2}, \ldots, a_{d}\right) \in \mathbb{R}^{d}$, we define a $d \times d$ matrix $a \otimes a$ by $a \otimes a:=\left(a_{i} a_{j}\right)$. Next we recall notations and definitions from the geometric measure theory and refer to [11, 14, 34, 40, for more details. For a Caccioppoli set $E \subset \mathbb{R}^{d}$, we denote the reduced boundary of $E$ by $\partial^{*} E$. For the characteristic function $\chi_{E}$, we denote the total variation measure of the distributional derivative $\nabla \chi_{E}$ by $\left\|\nabla \chi_{E}\right\|$. Let $U \subset \mathbb{R}^{d}$ be an open set. We write the space of bounded variation functions on $U$ as $B V(U)$. For any Radon measure $\mu$ on $U$ and $\phi \in C_{c}(U)$, we often write $\int \phi d \mu$ as $\mu(\phi)$. For $p \geq 1$, we write $f \in L^{p}(\mu)$ if $f$ is $\mu$-measurable and $\int|f|^{p} d \mu<\infty$. For $d, k \in \mathbb{N}$ with $k<d$, let $\mathbb{G}(d, k)$ be the space of $k$-dimensional subspace of $\mathbb{R}^{d}$. For an open set $U \subset \mathbb{R}^{d}$, let $G_{k}(U):=U \times \mathbb{G}(d, k)$. We say $V$ is a general $k$-varifold on $U$ if $V$ is a Radon measure on $G_{k}(U)$. We denote the set of all general $k$-varifolds on $U$ by $\mathbb{V}_{k}(U)$. For a general varifold $V \in \mathbb{V}_{k}(U)$, we define the weight measure $\|V\|$ by

\|V\|(\phi):=\int_{G_{k}(U)} \phi(x) d V(x, S) \quad \text { for any } \phi \in C_{c}(U)
$$

We call $V \in \mathbb{V}_{k}(U)$ is rectifiable if there exist a $\mathscr{H}^{k}$-measurable $k$-countably rectifiable set $M \subset U$ and $\theta \in L_{l o c}^{1}\left(\mathscr{H}^{k}{ }_{L}{ }_{M}\right)$ such that

$$
V(\phi)=\int_{M} \phi\left(x, T_{x} M\right) \theta(x) d \mathscr{H}^{k} \quad \text { for any } \phi \in C_{c}\left(G_{k}(U)\right)
$$

where $T_{x} M$ is the approximate tangent space of $M$ at $x$. Note that such $x$ does exists for $\mathscr{H}^{k}$-a.e. on $M$. If $\theta \in \mathbb{N} \mathscr{H}^{k}$-a.e. on $M$, we call $V$ is integral. In addition, if $\theta=1 \mathscr{H}^{k}$-a.e. on $M$, we say $V$ has unit density.

For $V \in \mathbb{V}_{k}(U)$, we define the first variation $\delta V$ by

\delta V(\vec{\phi}):=\int_{G_{k}(U)} \nabla \vec{\phi}(x) \cdot S d V(x, S) \quad \text { for any } \vec{\phi} \in C_{c}^{1}\left(U ; \mathbb{R}^{d}\right)
$$

Here, we identify $S \in \mathbb{G}(d, k)$ with the corresponding orthogonal projection of $\mathbb{R}^{d}$ onto $S$. When the total variation $\|\delta V\|$ of $\delta V$ is locally bounded and absolutely continuous with respect to $\|V\|$, there exists a measurable vector field $\vec{h}$ such that

\delta V(\vec{\phi})=-\int_{U} \vec{\phi}(x) \cdot \vec{h}(x) d\|V\|(x) \quad \text { for any } \vec{\phi} \in C_{c}^{1}\left(U ; \mathbb{R}^{d}\right)
$$

The vector valued function $\vec{h}$ is called the generalized mean curvature vector of $V$. In addition, a Radon measure $\mu$ is called a $k$-rectifiable if there exists a $k$-rectifiable varifold such that $\mu$ is represented by $\mu=\|V\|$. Note that this $V$ is uniquely determined, so the first variation and the generalized mean curvature vector of $\mu$ is naturally determined by $V$. The definition of an integral Radon measure is determined in the same way.

The formulation of the following is similar to that of the Brakke flow [5, 41].
Definition 2.1 ( $L^{2}$-flow 30]). Let $T>0, U \subset \mathbb{R}^{d}$ be an open set, and $\left\{\mu_{t}\right\}_{t \in[0, T)}$ be a family of Radon measures on $U$. Set $d \mu:=d \mu_{t} d t$. We call $\left\{\mu_{t}\right\}_{t \in[0, T)}$ an $L^{2}$-flow with a generalized velocity vector $\vec{v}$ if the following hold:
(1) For a.e. $t \in(0, T), \mu_{t}$ is $(d-1)$-integral, and also has a generalized mean curvature vector $\vec{h} \in L^{2}\left(\mu_{t} ; \mathbb{R}^{d}\right)$.
(2) The vector field $\vec{v}$ belongs to $L^{2}\left(0, T ;\left(L^{2}\left(\mu_{t}\right)\right)^{d}\right)$ and

$$
\vec{v}(x, t) \perp T_{x} \mu_{t} \quad \text { for } \mu \text {-a.e. }(x, t) \in U \times(0, T)
$$

where $T_{x} \mu_{t} \in \mathbb{G}(d, d-1)$ is the approximate tangent space of $\mu_{t}$ at $x$.
(3) There exists $C_{T}>0$ such that

$$
\begin{equation*}
\left|\int_{0}^{T} \int_{U}\left(\eta_{t}+\nabla \eta \cdot \vec{v}\right) d \mu_{t} d t\right| \leq C_{T}\|\eta\|_{C^{0}(U \times(0, T))} \tag{2.1}
\end{equation*}
$$

for any $\eta \in C_{c}^{1}(U \times(0, T))$.
Remark 2.2. If there exists a family of smooth hypersurfaces $\left\{M_{t}\right\}_{t \in[0, T)}$ with the normal velocity vector $\vec{w}$, then (2.1) holds with $\vec{v}=\vec{w}$ and $\mu_{t}=\mathscr{H}^{d-1}{ }_{M_{t}}$. In addition, if $\vec{v}$ satisfies (2.1) with $\mu_{t}=\mathscr{H}^{d-1}{ }_{M_{t}}$, then $\vec{v}=\vec{w}$. This proof is almost identical to the proof in [41, Proposition 2.1].

The $L^{2}$-flow has the following property.
Proposition 2.3 (See Proposition 3.3 of [30]). Assume that $\left\{\mu_{t}\right\}_{t \in(0, T)}$ is an $L^{2}$-flow with the generalized velocity vector $\vec{v}$ and set $d \mu:=d \mu_{t} d t$. Then

\left(\vec{v}\left(x_{0}, t_{0}\right), 1\right) \in T_{\left(x_{0}, t_{0}\right)} \mu
$$

at $\mu$-a.e. $\left(x_{0}, t_{0}\right) \in \Sigma(\mu)$, where $T_{\left(x_{0}, t_{0}\right)} \mu \in \mathbb{G}(d+1, d)$ is the approximate tangent space of $\mu$ at $\left(x_{0}, t_{0}\right)$ and $\Sigma(\mu)=\left\{(x, t) \mid T_{(x, t)} \mu\right.$ exists at $\left.(x, t)\right\}$.
2.2. Assumptions for initial data. Let $U_{0} \subset \subset(0,1)^{d}$ be a bounded open set with the following properties.
(1) There exists $D_{0}>0$ such that

where $M_{0}=\partial U_{0}$.
(2) There exists a family of open sets $\left\{U_{0}^{i}\right\}_{i=1}^{\infty}$ such that $U_{0}^{i}$ has a $C^{3}$ boundary $M_{0}^{i}=\partial U_{0}^{i}$ for any $i$ and the following hold:

\lim _{i \rightarrow \infty} \mathscr{L}^{d}\left(U_{0} \triangle U_{0}^{i}\right)=0 \quad \text { and } \quad \lim _{i \rightarrow \infty}\left\|\nabla \chi_{U_{0}^{i}}\right\|=\left\|\nabla \chi_{U_{0}}\right\| \quad \text { as Radon measures. } \tag{2.3}
\end{equation*}
$$

Note that the second assumption is satisfied when $U_{0}$ is a Caccioppoli set, and both conditions are fulfilled when $M_{0}$ is $C^{1}$ (see [14]).

We denote $q^{\varepsilon}(r):=\tanh (r / \varepsilon)$ for $r \in \mathbb{R}$. Then $q^{\varepsilon}$ satisfies

\frac{\varepsilon\left(q_{r}^{\varepsilon}(r)\right)^{2}}{2}=\frac{W\left(q^{\varepsilon}(r)\right)}{\varepsilon} \quad \text { for any } r \in \mathbb{R} \tag{2.4}

q_{r r}^{\varepsilon}(r)=\frac{W^{\prime}\left(q^{\varepsilon}(r)\right)}{\varepsilon^{2}} \quad \text { for any } r \in \mathbb{R} \tag{2.5}
\end{equation*}
$$

In addition, (2.4) yields

\int_{\mathbb{R}}\left(\frac{\varepsilon\left(q_{r}^{\varepsilon}(r)\right)^{2}}{2}+\frac{W\left(q^{\varepsilon}(r)\right)}{\varepsilon}\right) d r=\int_{\mathbb{R}} \sqrt{2 W\left(q^{\varepsilon}\right)} q_{r}^{\varepsilon} d r=\int_{-1}^{1} \sqrt{2 W(q)} d q=: \sigma .
$$

This means that the Radon measure $\mu_{t}^{\varepsilon}$ defined below needs to be normalized by $\sigma$.

Next we extend $U_{0}^{i}$ and $M_{0}^{i}$ periodically to $\mathbb{R}^{d}$ with period $\Omega$ and define

r_{i}(x)= \begin{cases}\operatorname{dist}\left(x, M_{0}^{i}\right), & \text { if } x \in U_{0}^{i}, \\ -\operatorname{dist}\left(x, M_{0}^{i}\right), & \text { if } x \notin U_{0}^{i} .\end{cases}

Then $\left|\nabla r_{i}(x)\right| \leq 1$ for a.e. $x \in \mathbb{R}^{d}$ and there exists $b_{i}>0$ such that $r_{i}$ is $C^{3}$ on $N_{b_{i}}:=\{x \mid$ $\left.\operatorname{dist}\left(x, M_{0}^{i}\right)<b_{i}\right\}$ (see [9]). Let $d_{i}$ be a smooth monotone increase function such that

d_{i}(r)= \begin{cases}r, & \text { if }|r|<\frac{1}{4} b_{i}, \\ \frac{2}{3} b_{i}, & \text { if } r>\frac{3}{4} b_{i} \\ -\frac{2}{3} b_{i}, & \text { if } r<-\frac{3}{4} b_{i}\end{cases}
$$

and $\left|\frac{d}{d r} d_{i}\right| \leq 1$. Set $\overline{r_{i}}:=d_{i}\left(r_{i}\right)$. Then $\overline{r_{i}} \in C^{3}(\Omega), \overline{r_{i}}=r_{i}$ on $N_{b_{i} / 4}$, and $\left|\nabla \overline{r_{i}}(x)\right| \leq 1$ for any $x \in \mathbb{R}^{d}$. Let $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$ be a positive sequence with $\varepsilon_{i} \rightarrow 0$ and $\frac{\varepsilon_{i}}{b_{i}^{2}} \rightarrow 0$ as $i \rightarrow \infty$, and

$$
\begin{equation*}
\sup _{x \in \mathbb{R}^{d}}\left|\nabla^{j+1} \overline{r_{i}}(x)\right| \leq \varepsilon_{i}^{-j} \quad \text { for any } i \in \mathbb{N}, j=1,2 . \tag{2.6}
\end{equation*}
$$

Note that (2.6) corresponds to the condition (3.2) below. We define a periodic function $\varphi_{0}^{\varepsilon_{i}} \in C^{3}(\Omega)$ by

We define a Radon measure $\mu_{t}^{\varepsilon_{i}}$ by

\mu_{t}^{\varepsilon_{i}}(\phi):=\frac{1}{\sigma} \int_{\Omega} \phi\left(\frac{\varepsilon_{i}\left|\nabla \varphi^{\varepsilon_{i}}(x, t)\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon_{i}}(x, t)\right)}{\varepsilon_{i}}\right) d x, \quad \phi \in C_{c}(\Omega) \tag{2.8}
\end{equation*}
$$

where $\varphi^{\varepsilon_{i}}$ is the solution to (1.5) with initial data $\varphi_{0}^{\varepsilon_{i}}$ defined by (2.7) and $\sigma=\int_{-1}^{1} \sqrt{2 W(s)} d s$.
For $\varphi_{0}^{\varepsilon_{i}}$ and $\mu_{0}^{\varepsilon_{i}}$, we have the following properties (see [20, p. 423] and [26, Section 5]).
Proposition 2.4. There exists a subsequence $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$ (denoted by the same index and the subsequence is taken only for $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$, not for $\left\{M_{0}^{i}\right\}_{i=1}^{\infty}$ ) such that the following hold.
(1) For any $i \in \mathbb{N}$ and $x \in \Omega$, we have $\frac{\varepsilon_{i}\left|\nabla \varphi_{0}^{\varepsilon_{i}}(x)\right|^{2}}{2} \leq \frac{W\left(\varphi_{0}^{\varepsilon_{i}}(x)\right)}{\varepsilon_{i}}$.
(2) There exists $D_{1}=D_{1}\left(D_{0}\right)>0$ such that

$$
\begin{equation*}
\max \left\{\sup _{i \in \mathbb{N}} \mu_{0}^{\varepsilon_{i}}(\Omega), \sup _{i \in \mathbb{N},}, x \in \Omega, r \in(0,1), ~ \frac{\mu_{0}^{\varepsilon_{i}}\left(B_{r}(x)\right)}{\omega^{d-1} r^{d-1}}\right\} \leq D_{1} \tag{2.9}
\end{equation*}
$$

(3) $\mu_{0}^{\varepsilon_{i}} \rightarrow \mathscr{H}^{d-1} L_{M_{0}}$ as Radon measures, that is,

\int_{\Omega} \phi d \mu_{0}^{\varepsilon_{i}} \rightarrow \int_{M_{0}} \phi d \mathscr{H}^{d-1} \quad \text { for any } \phi \in C_{c}(\Omega)
$$

(4) For $\psi^{\varepsilon_{i}}=\frac{1}{2}\left(\varphi^{\varepsilon_{i}}+1\right), \lim _{i \rightarrow \infty} \psi^{\varepsilon_{i}}=\chi_{U_{0}}$ in $L^{1}$ and $\lim _{i \rightarrow \infty}\left\|\nabla \psi^{\varepsilon_{i}}\right\|=\left\|\nabla \chi_{U_{0}}\right\|$ as Radon measures.

Remark 2.5. The first property (1) is obtained from $\left|\nabla \overline{r_{i}}\right| \leq 1$ (see the proof of Proposition 3.3). The assumption $\frac{\varepsilon_{i}}{b_{i}^{2}} \rightarrow 0$ is used to show $\int_{\Omega \backslash N_{b_{i} / 4}}\left(\frac{\varepsilon_{i}\left|\nabla \varphi_{0}^{\varepsilon_{i}}\right|^{2}}{2}+\frac{W\left(\varphi_{0}^{\varepsilon_{i}}\right)}{\varepsilon_{i}}\right) d x \rightarrow 0$.
2.3. Main results. We denote the approximate velocity vector $\vec{v}^{\varepsilon_{i}}$ by

\frac{-\varphi_{t}^{\varepsilon_{i}}}{\left|\nabla \varphi^{\varepsilon_{i}}\right|} \frac{\nabla \varphi^{\varepsilon_{i}}}{\left|\nabla \varphi^{\varepsilon_{i}}\right|}, & \text { if }\left|\nabla \varphi^{\varepsilon_{i}}\right| \neq 0, \\
0, & \text { otherwise }
\end{array}\right.
$$

The first main result of this paper is the following.
Theorem 2.6. Suppose that $d \geq 2$ and $U_{0}$ satisfies (2.2) and (2.3). For any $i \in \mathbb{N}$, let $\varphi_{0}^{\varepsilon_{i}}$ be defined so that all the claims of Proposition 2.4 are satisfied and $\varphi^{\varepsilon_{i}}$ be a solution to (1.5) with initial data $\varphi_{0}^{\varepsilon_{i}}$. Then there exists a subsequence $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$ (denoted by the same index) such that the following hold.
(a) There exist a countable subset $B \subset[0, \infty)$ and a family of $(d-1)$-integral Radon measures $\left\{\mu_{t}\right\}_{t \in[0, \infty)}$ on $\Omega$ such that

\mu_{0}=\mathscr{H}^{d-1}\left\lfloor_{M_{0}}, \quad \mu_{t}^{\varepsilon_{i}} \rightarrow \mu_{t} \quad \text { as Radon measures for any } t \geq 0\right.
$$

and

$$
\mu_{s}(\Omega) \leq \mu_{t}(\Omega) \quad \text { for any } s, t \in[0, \infty) \backslash B \text { with } 0 \leq t<s<\infty
$$

(b) There exists $\psi \in B V_{l o c}(\Omega \times[0, \infty)) \cap C_{l o c}^{\frac{1}{2}}\left([0, \infty) ; L^{1}(\Omega)\right)$ such that the following hold.
(b1) $\psi^{\varepsilon_{i}} \rightarrow \psi$ in $L_{l o c}^{1}(\Omega \times[0, \infty))$ and a.e. pointwise, where $\psi^{\varepsilon_{i}}=\frac{1}{2}\left(\varphi^{\varepsilon_{i}}+1\right)$.
(b2) $\left.\psi\right|_{t=0}=\chi_{U_{0}}$ a.e. on $\Omega$.
(b3) For any $t \in[0, \infty), \psi(\cdot, t)=1$ or 0 a.e. on $\Omega$ and $\psi$ satisfies the volume preserving property, that is,

(b4) For any $t \in[0, \infty)$ and for any $\phi \in C_{c}(\Omega ;[0, \infty))$, we have $\|\nabla \psi(\cdot, t)\|(\phi) \leq \mu_{t}(\phi)$.
(c) For $\lambda^{\varepsilon_{i}}$ given by (1.6), we have

and there exists $\lambda \in L_{l o c}^{2}(0, \infty)$ such that $\lambda^{\varepsilon_{i}} \rightarrow \lambda$ weakly in $L^{2}(0, T)$ for any $T>0$.
(d) There exists $\vec{f} \in L_{l o c}^{2}\left([0, \infty) ;\left(L^{2}\left(\mu_{t}\right)\right)^{d}\right)$ such that

& \lim _{i \rightarrow \infty} \frac{1}{\sigma} \int_{0}^{\infty} \int_{\Omega}-\lambda^{\varepsilon_{i}} \sqrt{2 W\left(\varphi^{\varepsilon_{i}}\right)} \nabla \varphi^{\varepsilon_{i}} \cdot \vec{\phi} d x d t  \tag{2.10}\\
= & \int_{0}^{\infty} \int_{\Omega} \vec{f} \cdot \vec{\phi} d \mu_{t} d t=\int_{0}^{\infty} \int_{\Omega}-\lambda \vec{\nu} \cdot \vec{\phi} d\|\nabla \psi(\cdot, t)\| d t
\end{align*}
$$

for any $\vec{\phi} \in C_{c}\left(\Omega \times[0, \infty) ; \mathbb{R}^{d}\right)$, where $\vec{\nu}$ is the inner unit normal vector of $\{\psi(\cdot, t)=1\}$ on spt $\|\nabla \psi(\cdot, t)\|$.
(e) The family of Radon measures $\left\{\mu_{t}\right\}_{t \in[0, \infty)}$ is an $L^{2}$-flow with a generalized velocity vector $\vec{v}=\vec{h}+\vec{f}$, where $\vec{h} \in L_{l o c}^{2}\left([0, \infty) ;\left(L^{2}\left(\mu_{t}\right)\right)^{d}\right)$ is the generalized mean curvature vector of $\mu_{t}$. Moreover, for any $\vec{\phi} \in C_{c}\left(\Omega \times[0, \infty) ; \mathbb{R}^{d}\right)$,

$$
\begin{equation*}
\lim _{i \rightarrow \infty} \int_{0}^{\infty} \int_{\Omega} \vec{v}^{\varepsilon_{i}} \cdot \vec{\phi} d \mu_{t}^{\varepsilon_{i}} d t=\int_{0}^{\infty} \int_{\Omega} \vec{v} \cdot \vec{\phi} d \mu_{t} d t \tag{2.11}
\end{equation*}
$$

Remark 2.7. From (d) and (e), we have

$$
\int_{0}^{\infty} \int_{\Omega} \vec{v} \cdot \vec{\phi} d \mu_{t} d t=\int_{0}^{\infty} \int_{\Omega}\left(\vec{h}-\lambda \frac{d\|\nabla \psi(\cdot, t)\|}{d \mu_{t}} \vec{\nu}\right) \cdot \vec{\phi} d \mu_{t} d t
$$

for any $\vec{\phi} \in C_{c}\left(\Omega \times(0, \infty) ; \mathbb{R}^{d}\right)$, where $\frac{d\|\nabla \psi(\cdot, t)\|}{d \mu_{t}}$ is the Radon-Nikodym derivative. Hence we have $\vec{v}=\vec{h}-\lambda \vec{\nu}$ in the sense of $L^{2}$-flow if $\mu_{t}=\|\nabla \psi(\cdot, t)\|$ for a.e. $t$ (from Theorem 2.8 below, this is correct for a short time if the initial data is sufficiently close to a ball). Since $\mu_{t}$ is integral for a.e. $t$, for such $t$, we have $\left(\frac{d\|\nabla \psi(\cdot, t)\|}{d \mu_{t}}\right)^{-1} \in \mathbb{N}$ for $\mu_{t}$-a.e. $x \in \Omega$, if $\frac{d\|\nabla \psi(\cdot, t)\|}{d \mu_{t}} \neq 0$.

Set $U_{t}:=\{x \in \Omega \mid \psi(x, t)=1\}$ for $t>0$. Let $B \subset \subset(0,1)^{d}$ be an open ball. We also show that if $U_{0} \approx B$ in the following sense, then there exists $T_{1}>0$ such that $\left\{\partial^{*} U_{t}\right\}_{t \in\left[0, T_{1}\right)}$ is a distributional solution to (1.1) in the framework of BV functions.
Theorem 2.8. For any $r \in\left(0, \frac{1}{4}\right)$, there exists $\delta_{1}>0$ depending only on $d$ and $r$ with the following properties. Assume that $U_{0} \subset\left(\frac{1}{4}, \frac{3}{4}\right)^{d}$ satisfies $\mathscr{L}^{d}\left(U_{0}\right)=\mathscr{L}^{d}\left(B_{r}(0)\right)$ and has a $C^{1}$ boundary $M_{0}$ with $\mathscr{H}^{d-1}\left(M_{0}\right) \leq 2 \mathscr{H}^{d-1}\left(\partial B_{r}(0)\right)$ and

$$
\begin{equation*}
\mathscr{H}^{d-1}\left(M_{0}\right)-d \omega_{d}^{\frac{1}{d}}\left(\mathscr{L}^{d}\left(U_{0}\right)\right)^{\frac{d-1}{d}} \leq \delta_{1} . \tag{2.12}
\end{equation*}
$$

Then there exists $T_{1}=T_{1}\left(d, r, M_{0}\right)>0$ such that the following hold.
(a) For a.e. $t \in\left[0, T_{1}\right), \mu_{t}=\|\nabla \psi(\cdot, t)\|=\mathscr{H}^{d-1}\left\lfloor_{\partial^{*} U_{t}}\right.$, where $\left\{\mu_{t}\right\}_{t \in[0, \infty)}$ is the $L^{2}$-flow with initial data $\mu_{0}=\mathscr{H}^{d-1}{ }_{M_{0}}$, given by Theorem [2.6.
(b) Let $\vec{v}, \vec{h}, \vec{\nu}$, and $\lambda$ be functions given by Theorem [2.6. Then $\left\{\partial^{*} U_{t}\right\}_{t \in\left[0, T_{1}\right)}$ is a distributional solution to (1.1) with initial data $\partial U_{0}=M_{0}$ in the following sense.
(b1) For any $t \in\left[0, T_{1}\right), \mathscr{L}^{d}\left(U_{t}\right)=\mathscr{L}^{d}\left(U_{0}\right)$.
(b2) For a.e. $t \in\left[0, T_{1}\right), \vec{h}$ is also a generalized mean curvature vector of $\mathscr{H}^{d-1}\left\lfloor\partial^{*} U_{t}\right.$.
(b3) For any $\vec{\phi} \in C_{c}\left(\Omega \times\left[0, T_{1}\right) ; \mathbb{R}^{d}\right)$, we have

\int_{0}^{T_{1}} \int_{\partial^{*} U_{t}}\{\vec{v}-\vec{h}+\lambda \vec{\nu}\} \cdot \vec{\phi} d \mathscr{H}^{d-1} d t=0
$$

(b4) For any $\phi \in C_{c}^{1}\left(\Omega \times\left(0, T_{1}\right)\right)$, we have

\int_{0}^{T_{1}} \int_{U_{t}} \phi_{t} d x d t=\int_{0}^{T_{1}} \int_{\partial^{*} U_{t}} \vec{v} \cdot \vec{\nu} \phi d \mathscr{H}^{d-1} d t
$$

(b5) (Additional volume preserving property). For a.e. $t \in\left[0, T_{1}\right.$ ), we have

\int_{\partial^{*} U_{t}} \vec{v} \cdot \vec{\nu} d \mathscr{H}^{d-1}=\int_{\Omega} \vec{v} \cdot \vec{\nu} d\|\nabla \psi(\cdot, t)\|=0
$$

(b6) For a.e. $t \in\left[0, T_{1}\right)$, we have

\lambda(t)=\frac{1}{\mathscr{H}^{d-1}\left(\partial^{*} U_{t}\right)} \int_{\partial^{*} U_{t}} \vec{h} \cdot \vec{\nu} d \mathscr{H}^{d-1} .
$$

Remark 2.9. The isoperimetric inequality tells us that $d \omega_{d}^{\frac{1}{d}}\left(\mathscr{L}^{d}(U)\right)^{\frac{d-1}{d}} \leq \mathscr{H}^{d-1}\left(\partial^{*} U\right)$ for any Caccioppoli set $U \subset \mathbb{R}^{d}$ with $\mathscr{L}^{d}(U)<\infty$ and the equality holds if and only if there exists a ball $B \subset \mathbb{R}^{d}$ such that $\mathscr{L}^{d}(U \triangle B)=0$ (see [12, 39] and references therein). Therefore the assumption (2.12) means that $U_{0}$ is sufficiently close to a ball in some sense. On the other hand, $M_{0}$ does not have to be close to a sphere in $C^{0}$ (for example, $U_{0}$ does not have to be connected).

Remark 2.10. The property (b4) claims that $\vec{v}$ is a normal velocity vector in a weak sense, since

$$
\frac{d}{d t} \int_{U_{t}} \phi d x=\int_{U_{t}} \phi_{t} d x-\int_{\partial U_{t}} \vec{v} \cdot \vec{\nu} \phi d \mathscr{H}^{d-1}
$$

holds for any $\phi \in C_{c}^{1}\left(\Omega \times\left(0, T_{1}\right)\right)$ and $t \in\left(0, T_{1}\right)$, where $\left\{U_{t}\right\}_{t \in\left[0, T_{1}\right)}$ is a family of open sets and the smooth boundary $\partial U_{t}$ moves by the normal velocity vector $\vec{v}$. By (1.2), we can regard (b5) as a volume preserving property in a weak sense.

## 3. Energy and pointwise estimates

In this section we show standard estimates for (1.5) such as the uniform $L^{2}$-estimate for $\lambda^{\varepsilon}$ and the monotonicity formula.
3.1. Assumptions. Let $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$ be a positive sequence with $\varepsilon_{i} \rightarrow 0$ as $i \rightarrow \infty$. In this section, we assume that there exist $D_{1}>0$ and $\omega>0$ such that (2.9) and

$$
\begin{equation*}
\frac{2}{3}-\left|\int_{\Omega} k\left(\varphi_{0}^{\varepsilon_{i}}(x)\right) d x\right|>\omega>0 \tag{3.1}
\end{equation*}
$$

hold for any $i \in \mathbb{N}$. The set $\left\{x \in \Omega \mid \varphi_{0}^{\varepsilon_{i}}(x)=0\right\}$ corresponds to the initial data $M_{0}$ of (1.1), and (3.1) yields that $\mathscr{L}^{d}\left(\left\{x \in \Omega \mid \varphi_{0}^{\varepsilon_{i}} \approx 1\right\}\right)>0$ formally, since $\int_{\Omega} k( \pm 1) d x= \pm \frac{2}{3} \mathscr{L}^{d}(\Omega)=$ $\pm \frac{2}{3}$. For some $C_{1}>0$, we also assume that the initial data $\varphi_{0}^{\varepsilon_{i}}$ of the solution to (1.5) satisfies

$$
\begin{equation*}
\varphi_{0}^{\varepsilon_{i}} \in C^{3}(\Omega), \quad \sup _{x \in \Omega}\left|\varphi_{0}^{\varepsilon_{i}}(x)\right|<1, \quad \text { and } \quad \varepsilon_{i}^{j} \sup _{x \in \Omega}\left|\nabla^{j} \varphi_{0}^{\varepsilon_{i}}(x)\right| \leq C_{1} \tag{3.2}
\end{equation*}
$$

for any $i \in \mathbb{N}$ and $j=1,2,3$. In addition, to control the discrepancy measure $\xi_{t}^{\varepsilon}$ defined below, we assume

$$
\begin{equation*}
\frac{\varepsilon_{i}\left|\nabla \varphi_{0}^{\varepsilon_{i}}(x)\right|^{2}}{2} \leq \frac{W\left(\varphi_{0}^{\varepsilon_{i}}(x)\right)}{\varepsilon_{i}} \quad \text { for any } x \in \Omega \text { and } i \in \mathbb{N} . \tag{3.3}
\end{equation*}
$$

Note that the function $\varphi_{0}^{\varepsilon_{i}}$ defined by (2.7) satisfies all the assumptions above, for sufficiently large $i$. Throughout this paper, we often write $\varepsilon$ as $\varepsilon_{i}$ for simplicity.
3.2. Pointwise estimates. The comparison principle implies the following estimate.

Proposition 3.1. The solution $\varphi^{\varepsilon}$ to (1.5) with (3.2) satisfies

$$
\begin{equation*}
\left|\varphi^{\varepsilon}(x, t)\right|<1, \quad x \in \Omega, t \geq 0 . \tag{3.4}
\end{equation*}
$$

Remark 3.2. The estimate (3.4) implies $\sqrt{2 W\left(\varphi^{\varepsilon}\right)}=1-\left(\varphi^{\varepsilon}\right)^{2}$. By a priori estimates including Proposition 3.3 below, standard PDE theories imply the global existence and uniqueness of the classical solution to (1.5) with initial data $\varphi_{0}^{\varepsilon}$ satisfying (3.2).

Proof. Suppose that $t_{0}:=\inf \left\{t \in[0, \infty) \mid \sup _{x \in \Omega} \varphi^{\varepsilon}(x, t) \geq 1\right\}<\infty$. Then $t_{0}>0$ since $\sup _{x \in \Omega} \varphi_{0}^{\varepsilon}(x)<1$. We may assume that there exists $t_{1} \in\left(t_{0}, \infty\right)$ such that $\sup _{x \in \Omega} \varphi^{\varepsilon}(x, t) \leq$ 2 for any $t<t_{1}$. Let $\varphi_{+}^{\varepsilon}$ be a solution to

$$
\begin{equation*}
\varepsilon\left(\varphi_{+}^{\varepsilon}\right)_{t}=\varepsilon \Delta \varphi_{+}^{\varepsilon}-\frac{W^{\prime}\left(\varphi_{+}^{\varepsilon}\right)}{\varepsilon}+L^{\varepsilon} \sqrt{2 W\left(\varphi_{+}^{\varepsilon}\right)}, \quad(x, t) \in \Omega \times\left(0, t_{1}\right) \tag{3.5}
\end{equation*}
$$

with initial data $\varphi_{+}^{\varepsilon}(x, 0)=\sup _{x \in \Omega} \varphi_{0}^{\varepsilon}(x)$, where $L^{\varepsilon}:=2 \varepsilon^{-\alpha} \max _{|s| \leq 2}|k(s)|$. Note that $\sup _{t \in\left(0, t_{1}\right)}\left|\lambda^{\varepsilon}(t)\right| \leq L^{\varepsilon}$, where $\lambda^{\varepsilon}$ is given by the solution $\varphi^{\varepsilon}$ to (1.5), and this implies that $\varphi_{+}^{\varepsilon}$ is a supersolution to (1.5) if we regard $\lambda^{\varepsilon}$ as a given function. Since the initial data is constant and $W^{\prime}(s), \sqrt{2 W(s)} \rightarrow 0$ as $s \rightarrow 1$, one can easily check that the solution $\varphi_{+}^{\varepsilon}$ to (3.5) depends only on $t$ and satisfies $\varphi_{+}^{\varepsilon}(t)<1$ for any $t \in\left(0, t_{1}\right)$. Therefore the comparison principle implies that $\varphi^{\varepsilon}(x, t) \leq \varphi_{+}^{\varepsilon}(t)<1$ for any $(x, t) \in \Omega \times\left(0, t_{1}\right)$. This
yields a contradiction. Hence $\varphi^{\varepsilon}(x, t)<1$ for any $(x, t) \in \Omega \times[0, \infty)$ and the remained claim can be proved similarly.

In addition, by Proposition 3.1 and the maximum principle we have the following Proposition (see [20]).

Proposition 3.3. If the solution $\varphi^{\varepsilon}$ to (1.5) satisfies (3.2) and (3.3), then we have

$$
\begin{equation*}
\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}(x, t)\right|^{2}}{2} \leq \frac{W\left(\varphi^{\varepsilon}(x, t)\right)}{\varepsilon}, \quad x \in \Omega, t \geq 0 \tag{3.6}
\end{equation*}
$$

Proof. By (3.4), we can define a function $r^{\varepsilon}$ by

$$
r^{\varepsilon}(x, t)=\left(q^{\varepsilon}\right)^{-1}\left(\varphi^{\varepsilon}(x, t)\right), \quad x \in \Omega, t \geq 0
$$

since $q^{\varepsilon}: \mathbb{R} \rightarrow(-1,1)$ is one to one and surjective. We compute that

$$
\begin{aligned}
\varepsilon q_{r}^{\varepsilon} r_{t}^{\varepsilon} & =\varepsilon q_{r}^{\varepsilon} \Delta r^{\varepsilon}+\varepsilon q_{r r}^{\varepsilon}\left|\nabla r^{\varepsilon}\right|^{2}-\frac{W^{\prime}\left(q^{\varepsilon}\right)}{\varepsilon}+\lambda^{\varepsilon} \sqrt{2 W\left(q^{\varepsilon}\right)} \\
& =\sqrt{2 W\left(q^{\varepsilon}\right)} \Delta r^{\varepsilon}+\frac{W^{\prime}\left(q^{\varepsilon}\right)}{\varepsilon}\left(\left|\nabla r^{\varepsilon}\right|^{2}-1\right)+\lambda^{\varepsilon} \sqrt{2 W\left(q^{\varepsilon}\right)},
\end{aligned}
$$

where we used (2.4) and (2.5). Then we obtain

$$
\begin{equation*}
r_{t}^{\varepsilon}=\Delta r^{\varepsilon}-\frac{2 q^{\varepsilon}\left(r^{\varepsilon}\right)}{\varepsilon}\left(\left|\nabla r^{\varepsilon}\right|^{2}-1\right)+\lambda^{\varepsilon} \tag{3.7}
\end{equation*}
$$

where we used $W^{\prime}\left(q^{\varepsilon}\right) / \sqrt{2 W\left(q^{\varepsilon}\right)}=-2 q^{\varepsilon}$. We compute

$$
\frac{1}{2} \partial_{t}\left|\nabla r^{\varepsilon}\right|^{2}=\frac{1}{2} \Delta\left|\nabla r^{\varepsilon}\right|^{2}-\left|\nabla r^{\varepsilon}\right|^{2}-\nabla r^{\varepsilon} \cdot \nabla\left(\frac{2 q^{\varepsilon}\left(r^{\varepsilon}\right)}{\varepsilon}\left(\left|\nabla r^{\varepsilon}\right|^{2}-1\right)\right),
$$

where we used $\nabla \lambda^{\varepsilon}=0$. Set $w^{\varepsilon}=\left|\nabla r^{\varepsilon}\right|^{2}-1$. Then $w^{\varepsilon}$ satisfies

$$
w_{t}^{\varepsilon} \leq \Delta w^{\varepsilon}-\frac{4 q^{\varepsilon}\left(r^{\varepsilon}\right)}{\varepsilon} \nabla r^{\varepsilon} \cdot \nabla w^{\varepsilon}-2\left(\nabla r^{\varepsilon} \cdot \nabla \frac{2 q^{\varepsilon}\left(r^{\varepsilon}\right)}{\varepsilon}\right) w^{\varepsilon} .
$$

In addition, we have $w^{\varepsilon}(x, 0) \leq 0$, because

$$
\frac{\varepsilon\left|\nabla \varphi_{0}^{\varepsilon}(x)\right|^{2}}{2}-\frac{W\left(\varphi_{0}^{\varepsilon}(x)\right)}{\varepsilon}=\frac{W\left(q^{\varepsilon}\left(r^{\varepsilon}(x, 0)\right)\right)}{\varepsilon}\left(\left|\nabla r^{\varepsilon}(x, 0)\right|^{2}-1\right) \leq 0
$$

by (3.3). Hence the maximum principle implies $w^{\varepsilon}(x, t) \leq 0$ for any $x \in \Omega$ and $t \in[0, \infty)$, and we obtain (3.6) by $\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}-\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}=\frac{W\left(q^{\varepsilon}\right)}{\varepsilon} w^{\varepsilon} \leq 0$.
3.3. Energy estimates. By $E_{S}^{\varepsilon}(t)=\sigma \mu_{t}^{\varepsilon}(\Omega)$, (1.7), (1.8), and (2.9), we can easily obtain the following estimates.

Proposition 3.4. For any $\varepsilon>0$ and $T>0$, we have

$$
\begin{equation*}
\mu_{T}^{\varepsilon}(\Omega)+\frac{1}{\sigma} \int_{0}^{T} \int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x d t \leq \mu_{0}^{\varepsilon}(\Omega) \tag{3.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\sup _{\varepsilon \in(0,1)} \mu_{T}^{\varepsilon}(\Omega) \leq \sup _{\varepsilon \in(0,1)} \mu_{0}^{\varepsilon}(\Omega) \leq D_{1} \tag{3.9}
\end{equation*}
$$

Remark 3.5. Generally, " $\mu_{s}^{\varepsilon}(\Omega) \leq \mu_{t}^{\varepsilon}(\Omega)$ for any $0 \leq t<s<\infty$ " can not be shown from the energy estimates above. However, there exists a countable set $B$ such that $\mu_{s}(\Omega) \leq \mu_{t}(\Omega)$ holds for any $t, s \in[0, \infty) \backslash B$ with $t<s$, where $\mu_{t}(\Omega)=\lim _{\varepsilon \rightarrow 0} \mu_{t}^{\varepsilon}(\Omega)$ (see Proposition (3.14).

Set $D_{1}^{\prime}:=\sup _{\varepsilon \in(0,1)} \mu_{0}^{\varepsilon}(\Omega)$. Note that $D_{1}^{\prime} \leq D_{1}$. By an argument similar to that in [7], we have the following lemma.

Lemma 3.6. There exist constants $C_{2}=C_{2}\left(\omega, d, D_{1}^{\prime}\right)>0, C_{3}=C_{3}\left(\omega, d, D_{1}^{\prime}\right)>0$, and $\epsilon_{1}=\epsilon_{1}\left(\omega, d, D_{1}^{\prime}, \alpha\right)>0$ such that

$$
\begin{equation*}
\int_{0}^{T}\left|\lambda^{\varepsilon}(t)\right|^{2} d t \leq C_{2}\left(\mu_{0}^{\varepsilon}(\Omega)-\mu_{T}^{\varepsilon}(\Omega)+T\right) \quad \text { for any } \varepsilon \in\left(0, \epsilon_{1}\right) \text { and } T>0 \tag{3.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\sup _{\varepsilon \in\left(0, \epsilon_{1}\right)} \int_{t_{1}}^{t_{2}}\left|\lambda^{\varepsilon}(t)\right|^{2} d t \leq C_{3}\left(1+t_{2}-t_{1}\right) \quad \text { for any } 0 \leq t_{1}<t_{2}<\infty . \tag{3.11}
\end{equation*}
$$

Proof. Let $\vec{\zeta}=\left(\zeta^{1}, \zeta^{2}, \ldots, \zeta^{d}\right): \Omega \times[0, \infty) \rightarrow \mathbb{R}^{d}$ be a smooth periodic test function. Multiply (1.5) by $\nabla \varphi^{\varepsilon} \cdot \vec{\zeta}$ and integrate over $\Omega$. Then we have

$$
\begin{align*}
& \int_{\Omega} \varepsilon \varphi_{t}^{\varepsilon} \nabla \varphi^{\varepsilon} \cdot \vec{\zeta} d x+\sum_{i, j=1}^{d} \int_{\Omega} \varepsilon \varphi_{x_{i}}^{\varepsilon} \varphi_{x_{j}}^{\varepsilon} \zeta_{x_{i}}^{j} d x-\int_{\Omega}\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x  \tag{3.12}\\
= & -\lambda^{\varepsilon} \int_{\Omega} k\left(\varphi^{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x,
\end{align*}
$$

by the integration by parts. Here we used $\nabla k\left(\varphi^{\varepsilon}\right)=\sqrt{2 W\left(\varphi^{\varepsilon}\right)} \nabla \varphi^{\varepsilon}$ and

$$
\int_{\Omega} \Delta \varphi^{\varepsilon} \nabla \varphi^{\varepsilon} \cdot \vec{\zeta} d x=-\sum_{i, j=1}^{d} \int_{\Omega} \varphi_{x_{i}}^{\varepsilon} \varphi_{x_{j}}^{\varepsilon} \zeta_{x_{i}}^{j} d x+\int_{\Omega} \frac{\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2} \operatorname{div} \vec{\zeta} d x .
$$

The Cauchy-Schwarz inequality, (3.8), and (3.12) imply

$$
\begin{align*}
& \left|\int_{\Omega} \varepsilon \varphi_{t}^{\varepsilon} \nabla \varphi^{\varepsilon} \cdot \vec{\zeta} d x+\sum_{i, j=1}^{d} \int_{\Omega} \varepsilon \varphi_{x_{i}}^{\varepsilon} \varphi_{x_{j}}^{\varepsilon} \zeta_{x_{i}}^{j} d x-\int_{\Omega}\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x\right| \\
\leq & C_{4}\|\vec{\zeta}(\cdot, t)\|_{C^{1}(\Omega)}\left(\left(D_{1}^{\prime}\right)^{\frac{1}{2}}\left(\int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x\right)^{\frac{1}{2}}+D_{1}^{\prime}\right) \tag{3.13}
\end{align*}
$$

where $C_{4}>0$ depends only on $d$. Let $\eta \in C_{c}^{\infty}\left(B_{1}(0)\right)$ be a smooth nonnegative function with $\int_{B_{1}(0)} \eta d x=1$ and define the standard mollifier $\eta_{\delta}$ by $\eta_{\delta}(x)=\delta^{-d} \eta(x / \delta)$ for $\delta>0$. Let $u=u(x, t)$ be a periodic solution to

$$
\begin{cases}-\Delta u & =k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}-f_{\Omega}\left(k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}\right) \quad \text { in } \Omega \\ \int_{\Omega} u d x & =0\end{cases}
$$

Note that

$$
\int_{\Omega}\left\{k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}-f_{\Omega}\left(k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}\right)\right\}=0
$$

and there exists $C>0$ depending only on $\mathscr{L}^{d}(\Omega)$ such that

$$
\left\|k\left(\varphi^{\varepsilon}(\cdot, t)\right) * \eta_{\delta}-f_{\Omega}\left(k\left(\varphi^{\varepsilon}(\cdot, t)\right) * \eta_{\delta}\right)\right\|_{C^{1}(\Omega)} \leq C\left(1+\delta^{-1}\right), \quad t \geq 0
$$

where we used $\left\|\varphi^{\varepsilon}\right\|_{L^{\infty}} \leq 1$. Therefore the standard PDE arguments imply the existence and uniqueness of the solution $u$ and

$$
\|u(\cdot, t)\|_{C^{2, \beta}(\Omega)} \leq C_{5}, \quad t \geq 0
$$

where $\beta \in(0,1)$ and $C_{5}>0$ depends only on $\beta$, $d$, and $\delta$. Set $\vec{\zeta}(x, t)=\nabla u(x, t)$. Then, by (3.12) and (3.13), we have

$$
\begin{equation*}
\left|\lambda^{\varepsilon}\right|\left|\int_{\Omega} k\left(\varphi^{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x\right| \leq C_{4} C_{5}\left(\left(D_{1}^{\prime}\right)^{\frac{1}{2}}\left(\int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x\right)^{\frac{1}{2}}+D_{1}^{\prime}\right) \tag{3.14}
\end{equation*}
$$

We compute

$$
\begin{align*}
& -\int_{\Omega} k\left(\varphi^{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x=\int_{\Omega} k\left(\varphi^{\varepsilon}\right)(-\Delta u) d x \\
= & \int_{\Omega} k\left(\varphi^{\varepsilon}\right)\left\{k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}-f_{\Omega}\left(k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}\right)\right\} d x \\
= & \frac{4}{9} \mathscr{L}^{d}(\Omega)+\int_{\Omega}\left(k\left(\varphi^{\varepsilon}\right)\right)^{2}-\frac{4}{9} d x+\int_{\Omega} k\left(\varphi^{\varepsilon}\right)\left\{k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}-k\left(\varphi^{\varepsilon}\right)\right\} d x \\
& -\frac{1}{\mathscr{L}^{d}(\Omega)}\left(\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x\right)^{2}+\frac{1}{\mathscr{L}^{d}(\Omega)} \int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x\left(\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x-\int_{\Omega} k\left(\varphi^{\varepsilon}\right) * \eta_{\delta} d x\right) . \tag{3.15}
\end{align*}
$$

By $(k(s))^{2}-\frac{4}{9} \geq-W(s)$ for any $s \in[-1,1]$, we have

$$
\begin{equation*}
\int_{\Omega}\left(k\left(\varphi^{\varepsilon}\right)\right)^{2}-\frac{4}{9} d x \geq-\varepsilon \sigma \mu_{t}^{\varepsilon}(\Omega) \geq-\varepsilon \sigma D_{1}^{\prime} \tag{3.16}
\end{equation*}
$$

By using

$$
\int_{\Omega}\left|\nabla\left(k\left(\varphi^{\varepsilon}\right)\right)\right| d x=\int_{\Omega} \sqrt{2 W\left(\varphi^{\varepsilon}\right)}\left|\nabla \varphi^{\varepsilon}\right| d x \leq \sigma \mu_{t}^{\varepsilon}(\Omega) \leq \sigma D_{1}^{\prime}
$$

$\left\|\varphi^{\varepsilon}\right\|_{L^{\infty}} \leq 1$, and Proposition 6.1, we have

$$
\begin{equation*}
\left|\int_{\Omega} k\left(\varphi^{\varepsilon}\right)\left\{k\left(\varphi^{\varepsilon}\right) * \eta_{\delta}-k\left(\varphi^{\varepsilon}\right)\right\} d x\right| \leq C_{6} \delta \tag{3.17}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\frac{1}{\mathscr{L}^{d}(\Omega)} \int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x\left(\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x-\int_{\Omega} k\left(\varphi^{\varepsilon}\right) * \eta_{\delta} d x\right)\right| \leq C_{6} \delta \tag{3.18}
\end{equation*}
$$

where $C_{6}>0$ depends only on $D_{1}^{\prime}$ and $\mathscr{L}^{d}(\Omega)$. Set $\delta=\frac{\omega^{2}}{4 C_{6} \mathscr{L}^{d}(\Omega)}$. By (1.9), (3.1), (3.15), (3.16), (3.17), and (3.18), there exists $\epsilon_{1}>0$ depending only on $\alpha, D_{1}^{\prime}, \mathscr{L}^{d}(\Omega)$, and $\omega$ such that

\begin{align*}
& -\int_{\Omega} k\left(\varphi^{\varepsilon}\right) \operatorname{div} \vec{\zeta} d x \\
\geq & \frac{4}{9} \mathscr{L}^{d}(\Omega)-\frac{1}{\mathscr{L}^{d}(\Omega)}\left(\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x\right)^{2}-\varepsilon \sigma D_{1}^{\prime}-2 C_{6} \delta \\
\geq & \frac{1}{\mathscr{L}^{d}(\Omega)}\left(\omega^{2}-\frac{4 \sqrt{2}}{3} \varepsilon^{\frac{\alpha}{2}}\left(D_{1}^{\prime}\right)^{\frac{1}{2}}\right)-\varepsilon \sigma D_{1}^{\prime}-2 C_{6} \delta  \tag{3.19}\\
\geq & \frac{1}{4 \mathscr{L}^{d}(\Omega)} \omega^{2}
\end{align*}
$$

holds for any $\varepsilon \in\left(0, \epsilon_{1}\right)$, where we used $\left(\int_{\Omega} k\left(\varphi_{0}^{\varepsilon}\right) d x\right)^{2}-\left(\int_{\Omega} k\left(\varphi^{\varepsilon}\right) d x\right)^{2} \leq \frac{4 \sqrt{2}}{3} \varepsilon^{\frac{\alpha}{2}}\left(D_{1}^{\prime}\right)^{\frac{1}{2}}$ by (1.9). From (3.8), (3.9), (3.14), and (3.19), we obtain (3.10) and (3.11).

Remark 3.7. For the classical solution to the volume preserving mean curvature flow, we can obtain a similar estimate for the non-local term (see Proposition 6.2).

We define the discrepancy measure $\xi_{t}^{\varepsilon}$ on $\Omega$ by

\xi_{t}^{\varepsilon}(\phi):=\frac{1}{\sigma} \int_{\Omega} \phi(x)\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}(x, t)\right|^{2}}{2}-\frac{W\left(\varphi^{\varepsilon}(x, t)\right)}{\varepsilon}\right) d x, \quad \phi \in C_{c}(\Omega) . \tag{3.20}
\end{equation*}
$$

In addition, we denote

$$
\xi_{\varepsilon}(x, t)=\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}(x, t)\right|^{2}}{2}-\frac{W\left(\varphi^{\varepsilon}(x, t)\right)}{\varepsilon}
$$

Proposition 3.3 implies the following lemma.
Lemma 3.8. Assume (3.3). Then $\xi_{\varepsilon}(x, t) \leq 0$ for any $(x, t) \in \Omega \times[0, \infty)$. In addition, $\xi_{t}^{\varepsilon}$ is a non-positive measure for any $t \geq 0$.

We denote the backward heat kernel $\rho=\rho_{(y, s)}(x, t)$ by

\rho_{(y, s)}(x, t)=\frac{1}{(4 \pi(s-t))^{\frac{d-1}{2}}} e^{-\frac{|x-y|^{2}}{4(s-t)}}, \quad x, y \in \mathbb{R}^{d}, 0 \leq t<s .
$$

With exactly the same proof as in [36, p. 2028], we obtain the following estimates similar to the monotonicity formula obtaind by Huisken [17] (for convenience, we call the following as the monotonicity formula).
Proposition 3.9 (See [36]). Let $\xi_{\varepsilon}(x, 0) \leq 0$ for any $x \in \Omega$. Assume (3.3). Then

\frac{d}{d t} \int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x) \leq \frac{1}{2(s-t)} \int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \xi_{t}^{\varepsilon}(x)+\frac{1}{2}\left(\lambda^{\varepsilon}\right)^{2} \int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x) \tag{3.21}
\end{equation*}
$$

holds for any $0 \leq t<s<\infty$ and for any $y \in \mathbb{R}^{d}$. Here, $\mu_{t}^{\varepsilon}$ and $\xi_{t}^{\varepsilon}$ are extended periodically to $\mathbb{R}^{d}$. In addition, we have

$$
\begin{align*}
\left.\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x)\right|_{t=t_{2}} & \leq\left(\left.\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x)\right|_{t=t_{1}}\right) e^{\frac{1}{2} \int_{t_{1}}^{t_{2}}\left|\lambda^{\varepsilon}\right|^{2} d t}  \tag{3.22}\\
& \leq\left(\left.\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x)\right|_{t=t_{1}}\right) e^{C_{3}\left(t_{2}-t_{1}+1\right)}
\end{align*}
$$

for any $y \in \mathbb{R}^{d}, 0 \leq t_{1}<t_{2}<\infty$, and $\varepsilon \in\left(0, \epsilon_{1}\right)$.
Remark 3.10. Ilmanen [20] proved the monotone decreasing of $\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}(x)$ with respect to $t$, for the solution to the Allen-Cahn equation without the non-local term under suitable assumptions. In general, one can show that the Brakke flow with smooth initial data has unit density for a short time by using the monotonicity formula (see [38]). However, in order to show a similar conclusion for our problem, it is necessary that $\mu_{0}^{\varepsilon}(\Omega)-\mu_{t}^{\varepsilon}(\Omega)$ is small enough, due to (3.10) (see Lemma 5.3 below).

As a corollary of the monotonicity formula, we can obtain the following upper bounds of the densities of $\mu_{t}^{\varepsilon}$.
Corollary 3.11 (See [20, 35]). There exists $0<D_{2}<\infty$ depending only on $d, C_{3}, D_{1}$, and $T$ such that

\mu_{t}^{\varepsilon}\left(B_{R}(y)\right) \leq D_{2} R^{d-1} \tag{3.23}
\end{equation*}
$$

for all $y \in \mathbb{R}^{d}, R \in(0,1), \varepsilon \in\left(0, \epsilon_{1}\right)$, and $t \in[0, T]$.
Proof. Using the same calculation as (6.10) below, we have

\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, 0) d \mu_{0}^{\varepsilon} \leq \frac{D_{1} \omega_{d-1}}{\pi^{\frac{d-1}{2}}} \int_{0}^{1}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k=D_{1} \tag{3.24}
\end{equation*}
$$

for any $s>0$ and $y \in \mathbb{R}^{d}$, where we used $\int_{0}^{1}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k=\Gamma\left(\frac{d-1}{2}+1\right)=\pi^{\frac{d-1}{2}} / \omega_{d-1}$. By (3.22) and (3.24),

$$
\begin{equation*}
\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon} \leq D_{1} e^{C_{3}(T+1)} \tag{3.25}
\end{equation*}
$$

for any $t \in[0, T)$ with $0<t<s$ and $y \in \mathbb{R}^{d}$. Set $R=2 \sqrt{s-t}$. We compute

$$
\begin{equation*}
\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}^{\varepsilon}=\frac{1}{\pi^{\frac{d-1}{2}} R^{d-1}} \int_{\mathbb{R}^{d}} e^{-\frac{|x-y|^{2}}{R^{2}}} d \mu_{t}^{\varepsilon} \geq \frac{1}{\pi^{\frac{d-1}{2}} R^{d-1}} \int_{B_{R}(y)} e^{-1} d \mu_{t}^{\varepsilon} . \tag{3.26}
\end{equation*}
$$

Therefore we have (3.23) by (3.25) and (3.26).
By the integration by parts, we have the following estimate.
Lemma 3.12. For any nonnegative test function $\phi \in C_{c}^{2}(\Omega)$, there exists $C_{7}>0$ depends only on $D_{1},\|\phi\|_{C^{2}(\Omega)}, \omega$, and $d$ such that

\int_{0}^{T}\left|\frac{d}{d t} \mu_{t}^{\varepsilon}(\phi)\right| d t \leq C_{7}(1+T) \quad \text { for any } \varepsilon \in\left(0, \epsilon_{1}\right) \text { and } T>0 \tag{3.27}
\end{equation*}
$$

Proof. By the integration by parts, we have

& \frac{d}{d t} \int_{\Omega} \phi\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}\right) d x \\
= & -\int_{\Omega} \varepsilon \phi\left(\varphi_{t}^{\varepsilon}\right)^{2} d x+\lambda^{\varepsilon} \int_{\Omega} \phi \sqrt{2 W\left(\varphi^{\varepsilon}\right)} \varphi_{t}^{\varepsilon} d x-\int_{\Omega} \varepsilon\left(\nabla \phi \cdot \nabla \varphi^{\varepsilon}\right) \varphi_{t}^{\varepsilon} d x . \tag{3.28}
\end{align*}
$$

Hence,

$$
\begin{align*}
& \left|\frac{d}{d t} \int_{\Omega} \phi\left(\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}\right) d x\right| \\
\leq & \left|\lambda^{\varepsilon}\right|^{2} \int_{\Omega} \phi \frac{2 W\left(\varphi^{\varepsilon}\right)}{\varepsilon} d x+\int_{\Omega} \frac{|\nabla \phi|^{2}}{\phi} \varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2} d x+2 \int_{\Omega} \varepsilon \phi\left(\varphi_{t}^{\varepsilon}\right)^{2} d x  \tag{3.29}\\
\leq & C \sigma D_{1}\left(1+\left|\lambda^{\varepsilon}\right|^{2}+\int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x\right),
\end{align*}
$$

where $C>0$ depends only on $\|\phi\|_{C^{2}(\Omega)}$. Note that there exists $c=c(d)>0$ such that $\sup \frac{|\nabla \phi|^{2}}{\phi} \leq c(d)\left\|\nabla^{2} \phi\right\|_{C^{0}(\Omega)}$ by Cauchy's mean-value theorem. Thus (3.8), (3.11), and (3.29) imply (3.27).

With an argument similar to [20], we can show the following proposition by using (3.27).
Proposition 3.13. There exist a subsequence $\left\{\varepsilon_{i_{j}}\right\}_{j=1}^{\infty}$ and a family of Radon measures $\left\{\mu_{t}\right\}_{t \geq 0}$ such that

\mu_{t}^{\varepsilon_{i_{j}}} \rightarrow \mu_{t} \quad \text { as Radon measures on } \Omega \tag{3.30}
\end{equation*}
$$

for any $t \in[0, \infty)$ and for any $d \geq 2$. In addition, there exists a countable set $B \subset[0, \infty)$ such that $\mu_{t}(\Omega)$ is continuous on $[0, \infty) \backslash B$.
Proof. Let $\left\{\phi_{k}\right\}_{k=1}^{\infty} \subset C_{c}(\Omega)$ be a dense subset with $\phi_{k} \in C_{c}^{2}(\Omega)$ for any $k$, and for any $x \in \Omega \cap \mathbb{Q}^{d}$ and $r \in(0,1) \cap \mathbb{Q}$, there exists $k \in \mathbb{N}$ such that $\phi_{k} \in C_{c}^{2}\left(B_{r}(x)\right)$. Let $f_{k}^{i}(t)=\mu_{0}^{\varepsilon_{i}}\left(\phi_{k}\right)+\int_{0}^{t}\left(\frac{d}{d s} \mu_{s}^{\varepsilon_{i}}\left(\phi_{k}\right)\right)_{+} d s$ and $g_{k}^{i}(t)=\int_{0}^{t}\left(\frac{d}{d s} \mu_{s}^{\varepsilon_{i}}\left(\phi_{k}\right)\right)_{-} d s$. Then

$$
\mu_{t}^{\varepsilon_{i}}\left(\phi_{k}\right)=f_{k}^{i}(t)-g_{k}^{i}(t)
$$

and $f_{k}^{i}(t)$ and $g_{k}^{i}(t)$ are non decreasing functions with

$$
0 \leq f_{k}^{i}(t) \leq C_{k} \quad \text { and } \quad 0 \leq g_{k}^{i}(t) \leq C_{k}
$$

for any $i$ and $t \in[0, T)$, where $C_{k}>0$ depends only on $D_{1},\left\|\phi_{k}\right\|_{C^{2}(\Omega)}, \omega$, and $d$, by (3.27). Then Helly's selection theorem implies that there exist a subsequence $\varepsilon_{i} \rightarrow 0$ (denoted by the same index), $f_{k}, g_{k}:[0, T) \rightarrow[0, \infty)$ such that $\lim _{i \rightarrow \infty} f_{k}^{i}(t)=f_{k}(t)$ and $\lim _{i \rightarrow \infty} g_{k}^{i}(t)=g_{k}(t)$ for any $t \in[0, T)$. Therefore we have

$$
\begin{equation*}
\lim _{i \rightarrow \infty} \mu_{t}^{\varepsilon_{i}}\left(\phi_{k}\right)=f_{k}(t)-g_{k}(t) \tag{3.31}
\end{equation*}
$$

for any $t \in[0, T)$. By this and the diagonal argument, we can choose a subsequence such that (3.31) holds for any $t \in[0, T)$ and $k \in \mathbb{N}$. On the other hand, for any $t \in[0, T)$, the compactness of Radon measures yields that there exist $\mu_{t}$ and a subsequence $\varepsilon_{i} \rightarrow 0$ (depending on $t$ ) such that $\mu_{t}^{\varepsilon_{i}} \rightarrow \mu_{t}$ as Radon measures. However, $\mu_{t}$ is uniquely determined by (3.31). Hence we obtain (3.30) for any $t \in[0, T)$. By the diagonal argument with $T \rightarrow \infty$, we have (3.30) for any $t \in[0, \infty)$.

From the similar argument as above, there exists monotone increasing functions $f$ and $g$ such that $\mu_{t}(\Omega)=f(t)-g(t)$. By the monotonicity, there exists a countable set $B$ such that $f$ and $g$ are continuous on $[0, \infty) \backslash B$. This concludes the proof.

Proposition 3.14. Let $B$ be the countable set given by Proposition 3.13, For any $t, s \in$ $[0, \infty) \backslash B$ with $t<s$, we have $\mu_{s}(\Omega) \leq \mu_{t}(\Omega)$.

Proof. From Proposition [3.13, we may assume that $\mu_{t}^{\varepsilon_{i}}(\Omega) \rightarrow \mu_{t}(\Omega)$ for any $t \in[0, \infty)$. By (1.7) and $E^{\varepsilon_{i}}(t) \leq E_{S}^{\varepsilon_{i}}(0) \leq D_{1}$, Helly's selection theorem yields that there exist a subsequence $\varepsilon_{i} \rightarrow 0$ (denoted by the same index) and a monotone decreasing function $E(t)$ such that $E^{\varepsilon_{i}}(t) \rightarrow E(t)$ for any $t \in[0, \infty)$. For any $T>0$, the estimate (3.11) and Fatou's lemma imply

\int_{0}^{T} \liminf _{i \rightarrow \infty} E_{P}^{\varepsilon_{i}}(t) d t \leq \liminf _{i \rightarrow \infty} \int_{0}^{T} E_{P}^{\varepsilon_{i}}(t) d t=\liminf _{i \rightarrow \infty} \int_{0}^{T} \frac{\varepsilon_{i}^{\alpha}}{2}\left|\lambda^{\varepsilon_{i}}\right|^{2} d t=0
$$

Therefore $\lim _{\inf }^{i \rightarrow \infty}$ $E_{P}^{\varepsilon_{i}}(t)=0$ a.e. $t \geq 0$ and hence $E(t)=\sigma \mu_{t}(\Omega)$ for a.e. $t \geq 0$. By this, the monotonicity of $E(t)$, and the continuity of $\mu_{t}(\Omega)$ on $[0, \infty) \backslash B$, we obtain the claim.

We define a Radon measure $\mu$ on $\Omega \times[0, \infty)$ by $d \mu:=d \mu_{t} d t$. By the boundedness of $\sup _{i} \mu_{t}^{\varepsilon_{i}}(\Omega)$, the dominated convergence theorem implies

$$
\lim _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \phi d \mu_{t}^{\varepsilon_{i}} d t=\int_{\Omega \times[0, T)} \phi d \mu \quad \text { for any } \phi \in C_{c}(\Omega \times[0, T))
$$

For measures $\mu$ and $\mu_{t}$, we have the following property.
Proposition 3.15. There exists a countable set $\tilde{B} \subset[0, \infty)$ such that

$$
\begin{equation*}
\operatorname{spt} \mu_{t} \subset\{x \in \Omega \mid(x, t) \in \operatorname{spt} \mu\} \tag{3.32}
\end{equation*}
$$

for any $t \in(0, \infty) \backslash \tilde{B}$.
Proof. Let $f_{k}$ and $g_{k}$ be monotone increase functions given by Proposition 3.13. Then there exists a countable set $\tilde{B}$ such that $f_{k}$ and $g_{k}$ are continuous on $[0, \infty) \backslash \tilde{B}$ for any $k$. Suppose that there exists $t_{0} \in[0, \infty) \backslash \tilde{B}$ such that $x \in \operatorname{spt} \mu_{t_{0}}$ and $\left(x, t_{0}\right) \notin \operatorname{spt} \mu$. Then we may assume that there exists $k$ such that $x \in \operatorname{spt} \phi_{k}$ and $\mu\left(\phi_{k} \times\left(t_{0}-\delta, t_{0}+\delta\right)\right)=0$ for sufficiently small $\delta>0$, where $\phi_{k}$ is a function given by Proposition 3.13. From $x \in \operatorname{spt} \mu_{t_{0}}, \mu_{t_{0}}\left(\phi_{k}\right)>0$ and there exists $\delta^{\prime}>0$ such that $\mu_{t}\left(\phi_{k}\right)>0$ for any $t \in\left(t_{0}-\delta^{\prime}, t_{0}+\delta^{\prime}\right)$ by the continuity of $f_{k}$ and $g_{k}$. However, this contradicts $\mu\left(\phi_{k} \times\left(t_{0}-\delta, t_{0}+\delta\right)\right)=0$. Therefore we obtain (3.32) for $t \in[0, \infty) \backslash \tilde{B}$.
3.4. Integrarity of $\mu_{t}$ for $d \leq 3$. In the case of $d \leq 3$, we can use the results of [32]. For $d \geq 4$, we employ the arguments of [20, 28, 38] in Section 4 below.
Theorem 3.16. Assume that $d=2$ or 3 and (3.30). Then $\mu_{t}$ is integral for a.e. $t \geq 0$.
Proof. The estimates (3.8), (3.9), and (3.11) imply

$$
\begin{align*}
& \int_{0}^{T} \int_{\Omega} \varepsilon\left(\Delta \varphi^{\varepsilon}-\frac{W^{\prime}\left(\varphi^{\varepsilon}\right)}{\varepsilon^{2}}\right)^{2} d x d t \leq \int_{0}^{T} \int_{\Omega} \varepsilon\left(\varphi_{t}^{\varepsilon}\right)^{2} d x d t+\int_{0}^{T}\left|\lambda^{\varepsilon}\right|^{2} \int_{\Omega} \frac{2 W\left(\varphi^{\varepsilon}\right)}{\varepsilon} d x d t \\
\leq & \sigma \mu_{0}^{\varepsilon}(\Omega)+2 D_{1} C_{3}(1+T) \leq \sigma D_{1}+2 D_{1} C_{3}(1+T) \tag{3.33}
\end{align*}
$$

for any $T>0$. Then Fatou's lemma yields

$$
\begin{aligned}
& \int_{0}^{T} \liminf _{i \rightarrow \infty} \int_{\Omega} \varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x d t \\
\leq & \liminf _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x d t<\infty .
\end{aligned}
$$

Therefore

$$
\liminf _{i \rightarrow \infty} \int_{\Omega} \varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x<\infty \quad \text { for a.e. } t \geq 0
$$

By this, $2 \leq d \leq 3$, and (3.9), $\mu_{t}$ is integral for a.e. $t \geq 0$ (see [32, Theorem 5.1]).

## 4. Rectifiability and integrality of $\mu_{t}$

We already proved the rectifiability and integrality of $\mu_{t}$ with $d \leq 3$ in Theorem 3.16, Next we consider the case of $d \geq 2$ and basically follow [20, 28, 38].
4.1. Assumptions. We assume (2.9) and (3.1)-(3.3) again in this section. Let $\left\{\varepsilon_{i}\right\}_{i=1}^{\infty}$ be a positive sequence such that $\varepsilon_{i} \rightarrow 0$ as $i \rightarrow \infty$. By the weak compactness of the Radon measures and Proposition 3.13, we may assume that there exist Radon measures $\mu,|\xi|$ and a family of Radon measures $\left\{\mu_{t}\right\}_{t \in[0, T)}$ such that

$$
\mu(\phi)=\lim _{i \rightarrow \infty} \int_{0}^{T} \mu_{t}^{\varepsilon_{i}}(\phi) d t, \quad|\xi|(\phi)=\lim _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \sigma^{-1}\left|\xi_{\varepsilon_{i}}\right| \phi d x d t, \quad \phi \in C_{c}(\Omega \times(0, T))
$$

and

$$
\mu_{t}(\phi)=\lim _{i \rightarrow \infty} \mu_{t}^{\varepsilon_{i}}(\phi), \quad \phi \in C_{c}(\Omega), t \in[0, T)
$$

Remark 4.1. In the discussion above, we proved that there exists $\mu_{t}=\lim _{\varepsilon \rightarrow 0} \mu_{t}^{\varepsilon}$ for any $t \geq 0$, however such a property does not necessarily hold for $\xi_{t}^{\varepsilon}$.

By the standard PDE theories and the rescaling arguments, we obtain the following lemma. The proof is almost the same as [38, Lemma 4.1]. So, we skip this.

Lemma 4.2. There exists $C_{8}>0$ depending only on $d$ and $C_{1}$ such that

$$

\sup _{\Omega \times[0, T)} \varepsilon\left|\nabla \varphi^{\varepsilon}\right|+\sup _{x, y \in \Omega,} t \in[0, T), \frac{\varepsilon^{\frac{3}{2}}\left|\nabla \varphi^{\varepsilon}(x, t)-\nabla \varphi^{\varepsilon}(y, t)\right|}{|x-y|^{\frac{1}{2}}} \leq C_{8} \tag{4.1}
\end{equation*}
$$

for any $\varepsilon \in(0,1)$.
4.2. Vanishing of $\xi$. First we show $|\xi|=0$ for any $d \geq 2$.

Lemma 4.3. Assume $\left(x^{\prime}, t^{\prime}\right) \in \operatorname{spt} \mu$ and $\alpha_{1} \in(0,1)$. Then there exist a sequence $\left\{\left(x_{j}, t_{j}\right)\right\}_{j=1}^{\infty}$ and a subsequence $\left\{\varepsilon_{i_{j}}\right\}_{j=1}^{\infty}$ such that $\left|\left(x_{j}, t_{j}\right)-\left(x^{\prime}, t^{\prime}\right)\right|<\frac{1}{j}$ and $\left|\varphi^{\varepsilon_{i_{j}}}\left(x_{j}, t_{j}\right)\right|<\alpha_{1}$ for all $j$.
Proof. Define $Q_{r}=\overline{B_{r}\left(x^{\prime}\right) \times\left(t^{\prime}-r, t^{\prime}+r\right)}$ for $r>0$. If the claim is not true, then there are $r>0$ and $N>1$ such that $\inf _{Q_{r}}\left|\varphi^{\varepsilon_{i}}\right| \geq \alpha_{1}$ for any $i>N$. Without loss of generality, we may assume that $\inf _{Q_{r}} \varphi^{\varepsilon_{i}} \geq \alpha_{1}$ for any $i>N$. For $s \in\left[\alpha_{1}, 1\right)$, we have $W(s)=$ $\frac{1}{4 s} W^{\prime}(s)\left(s^{2}-1\right) \leq \frac{1}{4 \alpha_{1}} W^{\prime}(s)\left(s^{2}-1\right)$. Assume that $\phi \in C_{c}^{\infty}\left(B_{r}\left(x^{\prime}\right)\right)$ satisfies $0 \leq \phi \leq 1$ and $\phi=1$ on $B_{r / 2}\left(x^{\prime}\right)$. We compute

& =\frac{1}{4 \alpha_{1}} \int_{Q_{r}} \phi^{2}\left(-\varphi_{t}^{\varepsilon}+\Delta \varphi^{\varepsilon}+\lambda^{\varepsilon} \frac{\sqrt{2 W\left(\varphi^{\varepsilon}\right)}}{\varepsilon}\right)\left(\left(\varphi^{\varepsilon}\right)^{2}-1\right) d x d t
\end{aligned}
$$

We compute

$$
\left|\int_{Q_{r}} \phi^{2} \varphi_{t}^{\varepsilon}\left(\left(\varphi^{\varepsilon}\right)^{2}-1\right) d x d t\right|=\left|\int_{t^{\prime}-r}^{t^{\prime}+r} \frac{d}{d t} \int_{B_{r}\left(x^{\prime}\right)} \phi^{2}\left(\frac{1}{3}\left(\varphi^{\varepsilon}\right)^{3}-\varphi^{\varepsilon}\right) d x d t\right| \leq C
$$

where $C>0$ depends only on $r$. Here we used $\left\|\varphi^{\varepsilon}\right\|_{L^{\infty}} \leq 1$. By $\inf _{Q_{r}} \varphi^{\varepsilon_{i}} \geq \alpha_{1}$, the integration by parts, and Young's inequality,

& \leq \int_{Q_{r}} \alpha_{1} \phi^{2}\left|\nabla \varphi^{\varepsilon}\right|^{2}+\frac{1}{\alpha_{1}}|\nabla \phi|^{2}\left(\left(\varphi^{\varepsilon}\right)^{2}-1\right)^{2}-2 \phi^{2}\left|\nabla \varphi^{\varepsilon}\right|^{2} \alpha_{1} d x d t \\
& \leq \frac{1}{\alpha_{1}} \int_{Q_{r}}|\nabla \phi|^{2} d x d t \leq C,
\end{aligned}
$$

where $C>0$ depends only on $\alpha_{1}, r$, and $\|\nabla \phi\|_{L^{\infty}}$. By $\sqrt{2 W\left(\varphi^{\varepsilon}\right)}\left(\left(\varphi^{\varepsilon}\right)^{2}-1\right)=-2 W\left(\varphi^{\varepsilon}\right)$,

& \left|\int_{Q_{r}} \phi^{2} \lambda^{\varepsilon} \frac{\sqrt{2 W\left(\varphi^{\varepsilon}\right)}}{\varepsilon}\left(\left(\varphi^{\varepsilon}\right)^{2}-1\right) d x d t\right| \leq \int_{Q_{r}} \phi^{2}\left|\lambda^{\varepsilon}\right| \frac{2 W\left(\varphi^{\varepsilon}\right)}{\varepsilon} d x d t \\
\leq & \int_{t^{\prime}-r}^{t^{\prime}+r}\left|\lambda^{\varepsilon}\right| \int_{B_{r}\left(x^{\prime}\right)} \frac{2 W\left(\varphi^{\varepsilon}\right)}{\varepsilon} d x d t \\
\leq & 2 \sigma D_{1} \sqrt{2 r}\left(\int_{t^{\prime}-r}^{t^{\prime}+r}\left|\lambda^{\varepsilon}\right|^{2} d t\right)^{\frac{1}{2}} \leq 2 \sigma D_{1} \sqrt{2 r} C_{3}^{\frac{1}{2}}\left(1+t^{\prime}\right)^{\frac{1}{2}}
\end{aligned}
$$

Therefore there exists $C>0$ depending only on $\alpha_{1}, r, C_{3},\|\nabla \phi\|_{L^{\infty}}, t^{\prime}$, and $D_{1}$ such that

\rho_{y}^{r}(x):=\frac{1}{(\sqrt{2 \pi} r)^{d-1}} e^{-\frac{|x-y|^{2}}{2 r^{2}}}, \quad r>0, x, y \in \mathbb{R}^{d} \tag{4.2}
\end{equation*}
$$

Note that $\rho_{(y, s)}(x, t)=\rho_{y}^{r}(x)=\rho_{x}^{r}(y)$ for $r=\sqrt{2(s-t)}$.
Lemma 4.4. There exist $\gamma_{1}, \eta_{1}, \eta_{2} \in(0,1)$ depending only on $d, W, T, D_{2}$, and $C_{3}$ such that the following hold. For $t, s \in[0, T / 2)$ with $0<s-t \leq \eta_{1}$, we denote $r=\sqrt{2(s-t)}$ and $t^{\prime}=s+r^{2} / 2$. If $x \in \Omega$ satisfies

Proof. First we remark that $0 \leq t<s<t^{\prime}<T, s=\frac{t+t^{\prime}}{2}$, and $r=\sqrt{2(s-t)}=\sqrt{2\left(t^{\prime}-s\right)}$. Assume that $x \in \Omega$ satisfies (4.3), $\left(x^{\prime}, t^{\prime}\right) \in \operatorname{spt} \mu$, and $x^{\prime} \in B_{\gamma_{1} r}(x)$. We choose $\gamma_{1}, \eta_{1}$, and $\eta_{2}$ later. Let $\alpha_{1} \in(0,1)$ be a constant. By Lemma 4.3, there exist a sequence $\left\{\left(x_{j}, t_{j}\right)\right\}_{j=1}^{\infty}$ and a subsequence $\varepsilon_{j} \rightarrow 0$ such that $\lim _{j \rightarrow \infty}\left(x_{j}, t_{j}\right)=\left(x^{\prime}, t^{\prime}\right)$ and $\left|\varphi^{\varepsilon_{j}}\left(x_{j}, t_{j}\right)\right|<\alpha_{1}$ for all $j$. Then we may assume that for $\alpha^{\prime}=\left(\alpha_{1}+1\right) / 2>\alpha_{1}$, there exists $\gamma_{2}=\gamma_{2}\left(W, \alpha_{1}\right)>0$ such that $\frac{W\left(\varphi^{\varepsilon_{j}}\left(y, t_{j}\right)\right)}{\varepsilon_{j}} \geq \frac{W\left(\alpha^{\prime}\right)}{\varepsilon_{j}}$ for any $j$ and for any $y \in B_{\gamma_{2} \varepsilon_{j}}\left(x_{j}\right)$, because $W\left(\alpha_{1}\right)>W\left(\alpha^{\prime}\right)$ and

$$

for any $y \in B_{\gamma_{2} \varepsilon_{j}}\left(x_{j}\right)$, where we used (3.6). Thus, there exists $\eta_{3}=\eta_{3}\left(d, \gamma_{2}\right)>0$ such that

\eta_{3} \leq \int_{B_{\gamma_{2} \varepsilon_{j}\left(x_{j}\right)}} \frac{W\left(\alpha^{\prime}\right)}{\varepsilon_{j}} \rho_{\left(x_{j}, t_{j}+\varepsilon_{j}^{2}\right)}\left(y, t_{j}\right) d y \leq \int_{B_{\gamma_{2} \varepsilon_{j}\left(x_{j}\right)}} \frac{W\left(\varphi^{\varepsilon_{j}}\left(y, t_{j}\right)\right)}{\varepsilon_{j}} \rho_{\left(x_{j}, t_{j}+\varepsilon_{j}^{2}\right)}\left(y, t_{j}\right) d y
$$

Here we used

\inf _{\left.y \in B_{\gamma_{2} \varepsilon} \varepsilon x_{j}\right)} \rho_{x_{j}, t_{j}+\varepsilon_{j}^{2}}\left(y, t_{j}\right)>C_{9} \varepsilon_{j}^{1-d}>0
$$

where $C_{9}>0$ depends only on $d$ and $\gamma_{2}$. By the monotonicity formula, we have

\eta_{3} \leq \int_{\mathbb{R}^{d}} \rho_{\left(x_{j}, t_{j}+\varepsilon_{j}^{2}\right)}\left(y, t_{j}\right) d \mu_{t_{j}}^{\varepsilon_{j}}(y) \leq e^{C_{3}(T+1)} \int_{\mathbb{R}^{d}} \rho_{\left(x_{j}, t_{j}+\varepsilon_{j}^{2}\right)}(y, s) d \mu_{s}^{\varepsilon_{j}}(y)

Choose $\eta_{2}=\eta_{2}\left(d, \gamma_{2}, T, C_{3}\right)>0$ such that

2 \eta_{2} \leq \int_{\mathbb{R}^{d}} \rho_{\left(x_{j}, t_{j}+\varepsilon_{j}^{2}\right)}(y, s) d \mu_{s}^{\varepsilon_{j}}(y)
$$

and letting $j \rightarrow \infty$, we have

Changing the center of the backward heat kernel by using (6.8), we have

We can also show the following using the estimate (4.4).

for any $t \in(0, T) \backslash \tilde{B}$ and for any open set $U \subset \Omega$, where $\tilde{B}$ is the countable set given by Proposition 3.15.

Proof. We need only prove (4.5) for any compact set $K \subset U$. Let $X_{t}:=\{x \in K \mid(x, t) \in$ $\operatorname{spt} \mu\}$ with $t \in(0, T) \backslash \tilde{B}$. For any $x \in X_{t}$, by (4.4), we have

By the Besicovitch covering theorem, there exists a finite sub-collection $\mathcal{B}_{1}, \mathcal{B}_{2}, \ldots, \mathcal{B}_{N(d)}$ such that each $\mathcal{B}_{i}$ is a family of the disjoint closed balls and

Let $\mathscr{H}_{\delta}^{d-1}$ be defined in [11, Chapter 2]. Note that $\mathscr{H}^{d-1}=\lim _{\delta \downarrow 0} \mathscr{H}_{\delta}^{d-1}$. By (4.6) and (4.7), we compute

& \leq \sum_{i=1}^{N(d)} \sum_{\bar{B}_{L r}\left(x_{j}\right) \in \mathcal{B}_{i}} L^{d-1} C_{11} \mu_{t-r^{2}}\left(\bar{B}_{L r}\left(x_{j}\right)\right) \\
& \leq \sum_{i=1}^{N(d)} L^{d-1} C_{11} \mu_{t-r^{2}}(U)=N(d) L^{d-1} C_{11} \mu_{t-r^{2}}(U)
\end{aligned}
$$

Letting $r \downarrow 0$, we have $\mathscr{H}^{d-1}\left(X_{t}\right) \leq N(d) L^{d-1} C_{11} \liminf _{r \downarrow 0} \mu_{t-r^{2}}(U)$. By this and (3.32), we obtain (4.5).

By Lemma 4.4, we obtain the following lemma.

Lemma 4.6 (see [20, 28]). For $T \in[1, \infty)$, let $\eta_{2}$ be a constant as in Lemma 4.4. Set

Proof. Let $\eta_{1}, \eta_{2}$, and $\gamma_{1}$ be constants as in Lemma 4.4. For $\tau \in\left(0, \eta_{1}\right)$, we denote

Let $\left\{\tau_{m}\right\}_{m=1}^{\infty}$ be a positive sequence with $\tau_{m} \rightarrow 0$ as $m \rightarrow \infty$. Then $Z_{T} \subset \cup_{m=1}^{\infty} Z^{\tau_{m}}$. Therefore we need only show $\mu\left(Z^{\tau}\right)=0$ for any $\tau \in\left(0, \eta_{1}\right)$. Set

P_{\tau}(x, t):=\left\{\left(x^{\prime}, t^{\prime}\right)\left|\tau>\left|t-t^{\prime}\right|>\gamma_{1}^{-2}\right| x-\left.x^{\prime}\right|^{2}\right\}, \quad x \in \Omega, t \in[0, T / 2) .
$$

We now show that if $(x, t) \in Z^{\tau}$, then

Assume that $\left(x^{\prime}, t^{\prime}\right) \in P_{\tau}(x, t) \cap Z^{\tau}$ for a contradiction. First we consider the case of $t^{\prime}>t$. Set $s=\frac{t^{\prime}+t}{2}$ and $r=\sqrt{t^{\prime}-t}=\sqrt{2(s-t)}$. Since $(x, t) \in Z^{\tau}$,

This yields a contradiction. In the case of $t^{\prime}<t$, we can show $(x, t) \notin \operatorname{spt} \mu$ similarly. This is a contradiction. Therefore (4.8) holds.

For $\left(x_{0}, t_{0}\right) \in \Omega \times[\tau / 2, T / 2]$, we denote

We can choose a countable set $\left\{\left(x_{j}, t_{j}\right)\right\}_{j=1}^{\infty}$ such that $Z^{\tau} \subset \cup_{j=1}^{\infty} Z^{\tau, x_{j}, t_{j}}$. Thus we need only prove $\mu\left(Z^{\tau, x_{0}, t_{0}}\right)=0$. Let $P: \mathbb{R}^{d+1} \rightarrow \mathbb{R}^{d}$ be a projection such that $P(x, t)=x$. For $\rho \in(0,1)$ and $r \leq \rho$, let $\left\{\bar{B}_{r / 5}\left(x_{\lambda}\right)\right\}_{\lambda \in \Lambda}$ be a covering of $P\left(Z^{\tau, x_{0}, t_{0}}\right) \subset B_{\frac{\gamma_{1}}{2} \sqrt{\tau}}\left(x_{0}\right)$. Then, we may choose a countable covering $\mathcal{F}=\left\{\bar{B}_{r}\left(x_{i}\right)\right\}_{i=1}^{\infty}$ of $P\left(Z^{\tau, x_{0}, t_{0}}\right)$ with $\left(x_{i}, t_{i}\right) \in Z^{\tau, x_{0}, t_{0}}$ for some $t_{i}$, by Vitali's covering theorem. Let $A$ be a set of centers of all balls in $\left\{\bar{B}_{r}\left(x_{i}\right)\right\}_{i=1}^{\infty}$. Then, by Besicovitch's covering theorem, there exist $N(d)$ and subcollections $\mathcal{F}_{1}, \mathcal{F}_{2}, \ldots$, $\mathcal{F}_{N(d)} \subset \mathcal{F}$ of disjoint balls such that

Note that $\mathcal{F}_{k}$ is finite $\left(\mathcal{F}_{k}=\left\{B_{k, 1}, \ldots, B_{k, n_{k}}\right\}\right)$ and

\mathscr{L}^{d}\left(\cup_{i=1}^{n_{k}} B_{k, i}\right)=\sum_{i=1}^{n_{k}} \mathscr{L}^{d}\left(B_{k, i}\right) \leq \mathscr{L}^{d}\left(\bar{B}_{\frac{\gamma_{1}}{2} \sqrt{\tau}+\rho}\left(x_{0}\right)\right)
$$

since each balls in $\mathcal{F}_{k}$ are disjoint and $B_{k, i} \subset \bar{B}_{\frac{\gamma_{1}}{2} \sqrt{\tau}+\rho}\left(x_{0}\right)$. Therefore

If $(x, t) \in Z^{\tau, x_{0}, t_{0}}$, then there exists $B_{k, i}=\bar{B}_{r}\left(x_{k, i}\right) \in \mathcal{F}_{k}$ for some $k$ and $i$ such that $x \in \bar{B}_{2 r}\left(x_{k, i}\right)$ and $\left|t_{k, i}-t\right| \leq \gamma_{1}^{-1}\left|x_{k, i}-x\right|^{2} \leq 4 \gamma_{1}^{-1} r^{2}$ by (4.8) and (4.9) (note that we should change the radius because $A$ is not a covering of $\left.Z^{\tau, x_{0}, t_{0}}\right)$. Hence, we have

& \leq \sum_{k=1}^{N(d)} \sum_{i=1}^{n_{k}} D_{2}(2 r)^{d-1} \times 8 \gamma_{1}^{-2} r^{2} \leq 2^{d+2} \gamma_{1}^{-2} \omega_{d}^{-1} N^{\prime} D_{2} \rho,
\end{aligned}
$$

where we used (4.10). Letting $\rho \rightarrow 0$, we have $\mu\left(Z^{\tau, x_{0}, t_{0}}\right)=0$. Thus $\mu\left(Z_{T}\right)=0$ holds.
Theorem 4.7 (see [20]). We see that $|\xi|=0$ and $\lim _{i \rightarrow \infty}\left|\xi_{t}^{\varepsilon_{i}}\right|(\Omega)=0$ for a.e. $t \in[0, T)$.

\leq & e^{C_{3}\left(\beta-\beta_{i}+1\right)} \int_{\Omega} \rho_{\left(y, t+2 e^{\beta}\right)}\left(x, t+e^{\beta_{i}}\right) d \mu_{t+e^{\beta_{i}}}(y) \\
\leq & e^{2 C_{3}} \int_{\Omega} \rho_{\left(y, t+2 e^{\beta}-e^{\left.\beta_{i}\right)}\right.}(x, t) d \mu_{t+e^{\beta_{i}}}(y)  \tag{4.16}\\
\leq & e^{2 C_{3}} \int_{B_{M r}(x)} \rho_{\left(y, t+2 e^{\beta}-e^{\left.\beta_{i}\right)}\right.}(x, t) d \mu_{t+e^{\beta_{i}}}(y)+e^{2 C_{3}} 2^{d-1} e^{-\frac{3 M^{2}}{8}} D_{2} \\
\leq & e^{2 C_{3}} e^{M^{2}\left(1-e^{\theta}\right)} \int_{B_{M r}(x)} \rho_{\left(y, t+e^{\left.\beta_{i}\right)}\right.}(x, t) d \mu_{t+e^{\beta_{i}}}(y)+e^{2 C_{3}} 2^{d-1} e^{-\frac{3 M^{2}}{8}} D_{2} \\
\leq & e^{2 C_{3}} e^{M^{2}\left(1-e^{\theta}\right)} \theta+e^{2 C_{3}} 2^{d-1} e^{-\frac{3 M^{2}}{8}} D_{2},
\end{align*}
$$

where we used (3.22), (6.9), and

\end{aligned}
$$

for $\vec{\phi} \in C_{c}^{1}\left(\Omega ; \mathbb{R}^{d}\right)$. By the integration by parts, we have

& +\int_{\Omega \cap\left\{\left|\nabla \varphi^{\varepsilon}(x, t)\right| \neq 0\right\}} \nabla \vec{\phi} \cdot\left(\frac{\nabla \varphi^{\varepsilon}(x, t)}{\left|\nabla \varphi^{\varepsilon}(x, t)\right|} \otimes \frac{\nabla \varphi^{\varepsilon}(x, t)}{\left|\nabla \varphi^{\varepsilon}(x, t)\right|}\right) \xi_{\varepsilon} d x .

\leq & \liminf _{i \rightarrow \infty}\left(\int_{\Omega} \varepsilon_{i}\left|\nabla \varphi^{\varepsilon_{i}}\right|^{2} d x\right)^{\frac{1}{2}}\left(\int_{\Omega} \varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x\right)^{\frac{1}{2}}  \tag{4.20}\\
\leq & D_{1}^{\frac{1}{2}} \liminf _{i \rightarrow \infty}\left(\int_{\Omega} \varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x\right)^{\frac{1}{2}}<\infty
\end{align*}
$$

for a.e. $t \in[0, T)$ and for any $\vec{\phi} \in C_{c}^{1}\left(\Omega ; \mathbb{R}^{d}\right)$ with $\sup |\vec{\phi}| \leq 1$. Let $t \in[0, T) \backslash \tilde{B}$ satisfy (4.20), where $\tilde{B}$ is given by Proposition 3.15. Taking a subsequence $i_{j} \rightarrow \infty$, there exists a varifold $V_{t}$ such that $V_{t}^{\varepsilon_{i j}} \rightarrow V_{t}$ as Radon measures and $\delta V_{t}$ is a Radon measure by (4.20). In addition, Proposition 3.15, Lemma 4.5, and the standard measure theoretic argument imply

\int_{\Omega} \phi|\vec{h}|^{2} d \mu_{t} \leq \frac{1}{\sigma} \liminf _{i \rightarrow \infty} \int_{\Omega} \varepsilon_{i} \phi\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}\right)^{2} d x<\infty
$$

for any $\phi \in C_{c}(\Omega ;[0, \infty))$ and $\vec{\phi} \in C_{c}\left(\Omega ; \mathbb{R}^{d}\right)$.
Detailed proof of this is in [20, 38], so we omit it (however, the essential part has already been discussed above).
4.4. Integrality. To prove the integrality, we mainly follow [19, 38, 40]. The propositions that are directly applicable to our problem are in Appendix for readers' convenience. Let $\left\{r_{i}\right\}_{i=1}^{\infty}$ be a positive sequence with $r_{i} \rightarrow 0$ and $\frac{\varepsilon_{i}}{r_{i}} \rightarrow 0$ as $i \rightarrow \infty$. Set $u^{\tilde{\varepsilon}}(\tilde{x}, \tilde{t})=\varphi^{\varepsilon}(x, t)$ and $g^{\tilde{\varepsilon}}(\tilde{t})=r \lambda^{\varepsilon}(t)$ for $\tilde{x}=\frac{x}{r}, \tilde{t}=\frac{t}{r^{2}}$, and $\tilde{\varepsilon}=\frac{\varepsilon}{r}$. Then, $u^{\tilde{\varepsilon}}$ is a solution to

by (3.23). We subsequently drop $\tilde{\sim}$ for simplicity. First we consider the energy estimate on $\left\{x \in B_{1}(0)| | u^{\varepsilon}(x, t) \mid \geq 1-b\right\}$.
Proposition 4.10 (See [40). For any $s>0$ and $a \in(0, T)$, there exist positive constants $b$ and $\epsilon_{2}$ depending only on $D_{1}, D_{2}, C_{3}, a, \alpha$, and $s$ such that

for all $t \in(a, T)$ whenever $\varepsilon \in\left(0, \epsilon_{2}\right)$.
To prove Proposition 4.10, we prepare following two lemmas.
Lemma 4.11 (See 40). For any $\delta \in(0, T)$, there exist positive constants $C_{12}$ and $\epsilon_{3}$ depending only on $d, \delta, \alpha$, and $C_{1}$ with the following property. Assume that there exist $\left(x_{0}, t_{0}\right) \in B_{1}(0) \times(\delta, T)$ and $\gamma \in\left(0, \frac{2}{3}\right]$ such that

where $\tilde{u}^{\varepsilon}(\tilde{x}, \tilde{t})=u^{\varepsilon}(x, t)$ and $\tilde{g}^{\varepsilon}(\tilde{t})=g^{\varepsilon}(t)$. Note that (1.11) and $\mathscr{L}^{d}(\Omega)=1$ yield

for some constant $C_{13}>0$. For example, $\psi=e^{-\frac{\tilde{t}}{100}-1} e^{\frac{1}{100 d} \sqrt{1+|\tilde{x}|^{2}}}$ satisfies (4.26). Set $\tilde{r}:=C_{13} \gamma|\log \varepsilon|$. We may assume that $\tilde{r} \geq 1$ for sufficiently small $\varepsilon$. Note that

Moreover, by $\tilde{r} \geq 1$,

\psi \geq e^{\frac{|\hat{x}|+|\tilde{\mid}|}{C_{13}}} \geq e^{\frac{\tilde{r}}{C_{13}}} \quad \text { on } \partial\left(B_{\tilde{r}}(0) \times\left(-\tilde{r}^{2}, 0\right)\right)
$$

Therefore

\phi^{\varepsilon}=1-\varepsilon^{\gamma} \psi \leq 1-\varepsilon^{\gamma} e^{\frac{\tilde{r}}{C_{13}}}=0<\frac{1}{2} \leq \tilde{u}^{\varepsilon} \quad \text { on } \partial\left(B_{\tilde{r}}(0) \times\left(-\tilde{r}^{2}, 0\right)\right) \tag{4.31}
\end{equation*}
$$

by (4.27) and (4.29). We consider a function $w=\phi^{\varepsilon}-\tilde{u}^{\varepsilon}$ on $B_{\tilde{r}}(0) \times\left(-\tilde{r}^{2}, 0\right)$. By (4.30) and (4.31), $w$ attains its positive maximum at an interior point $\left(x^{\prime}, t^{\prime}\right) \in B_{\tilde{r}}(0) \times\left(-\tilde{r}^{2}, 0\right)$, and hence $w_{\tilde{t}}-\Delta_{\tilde{x}} w \geq 0$ and $w>0$ at $\left(x^{\prime}, t^{\prime}\right)$. At $\left(x^{\prime}, t^{\prime}\right)$, we compute that

& =\frac{1}{10}\left(1-\phi^{\varepsilon}\right)-2 \tilde{u}^{\varepsilon}\left(1-\left(\tilde{u}^{\varepsilon}\right)^{2}\right)-\varepsilon \tilde{g}^{\varepsilon}\left(1-\left(\tilde{u}^{\varepsilon}\right)^{2}\right) \\
& \leq \frac{1}{10}\left(1-\phi^{\varepsilon}\right)+\left(-1+\frac{8}{3} \varepsilon^{1-\alpha}\right)\left(1-\left(\tilde{u}^{\varepsilon}\right)^{2}\right) \\
& \leq \frac{1}{10}\left(1-\phi^{\varepsilon}\right)+\frac{3}{2}\left(-1+\frac{8}{3} \varepsilon^{1-\alpha}\right)\left(1-\phi^{\varepsilon}\right)<0
\end{aligned}
$$

for sufficiently small $\varepsilon$, where we used (4.25) and $1>\phi^{\varepsilon}>\tilde{u}^{\varepsilon} \geq \frac{1}{2}$ at $\left(x^{\prime}, t^{\prime}\right)$. This is a contradiction. The other case can be proved similarly.

Lemma 4.12 (See [40]). For any $\delta \in(0, T)$, there exist positive constants $C_{14}$ and $\epsilon_{4}$ depending only on $\delta, \alpha, d, C_{3}$, and $D_{2}$ such that the following holds. For $t \in(\delta, T)$ and $r \in\left(0, \frac{1}{2}\right)$, set

By $\left|u^{\varepsilon}\left(x_{1}, t_{1}\right)\right|<\frac{1}{2}$, repeating the proof of Lemma 4.4, there exists $\eta=\eta(\alpha, d)>0$ such that

$$

where $\eta^{\prime}=\eta^{\prime}\left(\alpha, d, C_{3}\right)>0$. By $\left|t_{1}-t_{0}\right|<r^{2}$ and $\varepsilon \leq r$, we have $e^{-\frac{3 R^{2}}{16\left(t_{1}+\varepsilon^{2}-t_{0}+2 r^{2}\right)}} \leq e^{-\frac{3 R^{2}}{64 r^{2}}}$. Thus there exists $\gamma>0$ depending only on $\alpha, d, C_{3}, D_{2}$ such that

By an argument similar to that in the proof of Lemma 4.6, there exist $\mathcal{F}_{1}, \ldots, \mathcal{F}_{N(d)}$ such that $N(d)$ depends only on $d, \mathcal{F}_{k}=$ $\left\{\bar{B}_{\tilde{r}}\left(x_{k, 1}\right), \ldots, \bar{B}_{\tilde{r}}\left(x_{k, n_{k}}\right)\right\}$ is a family of disjoint closed balls for any $k$, and

Z_{r, t_{0}} \subset \cup_{k=1}^{N(d)} \cup_{i=1}^{n_{k}} \bar{B}_{2 \tilde{r}}\left(x_{k, i}\right), \quad x_{k, i} \in Z_{r, t_{0}} \quad \text { for any } k \text { and } i .
$$

Therefore

\mathscr{L}^{d}\left(Z_{r, t_{0}}\right) & \leq \sum_{k=1}^{N(d)} \sum_{i=1}^{n_{k}} \mathscr{L}^{d}\left(\bar{B}_{2 \tilde{r}}\left(x_{k, i}\right)\right)=2^{d} \sum_{k=1}^{N(d)} \sum_{i=1}^{n_{k}} \mathscr{L}^{d}\left(\bar{B}_{\tilde{r}}\left(x_{k, i}\right)\right) \\
& \leq 2^{d} \sum_{k=1}^{N(d)} \sum_{i=1}^{n_{k}} r C_{17} \mu_{t_{0}-2 r^{2}}^{\varepsilon}\left(\bar{B}_{\tilde{r}}\left(x_{k, i}\right)\right)=2^{d} r C_{17} \sum_{k=1}^{N(d)} \mu_{t_{0}-2 r^{2}}^{\varepsilon}\left(\cup_{i=1}^{n_{k}} \bar{B}_{\tilde{r}}\left(x_{k, i}\right)\right) \\
& \leq 2^{d} r C_{17} \sum_{k=1}^{N(d)} \mu_{t_{0}-2 r^{2}}^{\varepsilon}\left(B_{1+C_{15} / 2}(0)\right) \leq 2^{d} r C_{17} N(d) D_{2},
\end{aligned}
$$

where we used (3.23), (4.36), and the property that $\mathcal{F}_{k}$ is a family of disjoint balls. Hence, we obtain (4.32).

\leq & C_{19}|\log \varepsilon| \int_{1}^{J+1} 2^{-t} \varepsilon^{2^{-t}} d t=C_{19} \frac{\varepsilon^{\frac{1}{2^{J+1}}}-\sqrt{\varepsilon}}{\log 2} \leq C_{19} \frac{\sqrt{b}}{\log 2},

\leq & \frac{2}{3} C_{19} \varepsilon|\log \varepsilon|,
\end{align*}
$$

where we used Lemma 4.11 with $\gamma=\frac{2}{3}$. Since $\left|u^{\varepsilon}\right| \leq 1$, we have

\leq & \frac{W\left(1-\varepsilon^{\frac{2}{3}}\right)}{\varepsilon} \mathscr{L}^{d}\left(\left\{x \in B_{1}(0)\left|1-\varepsilon^{\frac{2}{3}} \leq\left|u^{\varepsilon}\left(x, t_{0}\right)\right|\right\}\right)\right.  \tag{4.46}\\
\leq & \varepsilon^{\frac{1}{3}} \mathscr{L}^{d}\left(B_{1}(0)\right) .
\end{align*}

By (4.44), (4.45), and (4.46), Proposition 4.10 holds for sufficiently small $b$ and $\varepsilon$.
Now we prove the integrality of $\mu_{t}$.

For a.e. $t>0$, there exist a countably $(d-1)$-rectifiable set $M_{t}$ and $\mathscr{H}^{d-1}$ measurable function $\theta_{t}: M_{t} \rightarrow \mathbb{N}$ with $\theta_{t} \in L_{l o c}^{1}\left(\mathscr{H}^{d-1}\left\lfloor_{M_{t}}\right)\right.$ such that $\mu_{t}=\theta_{t} \mathscr{H}^{d-1}{ }_{M_{t}}$ holds. Proof. Set $H^{\varepsilon}:=\Delta \varphi^{\varepsilon}-\frac{W^{\prime}\left(\varphi^{\varepsilon}\right)}{\varepsilon^{2}}$. Then for a.e. $t_{0}>0$, we can choose a subsequence $\left\{V_{t_{0}}^{\varepsilon_{i_{j}}}\right\}_{j=1}^{\infty}$ such that $V_{t_{0}}^{\varepsilon_{i j}} \rightarrow V_{t_{0}}$,

\end{equation*}

hold by Theorem 4.7 and (4.19). Note that $V_{t_{0}}$ is a countably $(d-1)$-rectifiable varifold and determined by $\mu_{t_{0}}$ uniquely from Theorem 4.9. We fix such $t_{0}>0$ and show the claim for $\mu_{t_{0}}$. In this proof, even if we take a subsequence $\varepsilon_{i_{j}}$, we always write $\varepsilon_{i_{j}}$ by $\varepsilon_{i}$ for simplicity. Set

A_{m}:=\left\{x \in \Omega \mid \text { there exists } x_{i} \in A_{i, m} \text { for any } i \in \mathbb{N} \text { such that } x_{i} \rightarrow x\right\}
$$

for any $m \in \mathbb{N}$. Then the Besicovitch covering theorem implies

For any $x \in K$, there is a neighborhood $B_{r}(x)$ such that $B_{r}(x) \cap A_{i, m}=\emptyset$ for sufficiently large $i$, by the definition of $A_{m}$. This and the compactness of $K$ imply that there exist an open set $O_{m}$ and $i_{0} \in \mathbb{N}$
such that $K \subset O_{m}$ and $O_{m} \cap A_{i, m}=\emptyset$ for any $i \geq i_{0}$. Let $\phi_{m} \in C_{c}\left(O_{m}\right)$ be a nonnegative test function such that $0 \leq \phi_{m} \leq 1$ and $\phi_{m}=1$ on $K$. We compute

& \leq \liminf _{i \rightarrow \infty} \mu_{t_{0}}^{\varepsilon_{i}}\left(\Omega \backslash A_{k, m}\right)
\end{align*}
$$

for any $k \geq i_{0}$. Combining (4.49) and (4.51), we obtain $\mu_{t_{0}}(K)=0$. Therefore we have proved (4.50).

By the rectifiability of $\mu_{t_{0}}$ and (4.50), for $\mu_{t_{0}}$ a.e. $x \in \operatorname{spt} \mu_{t_{0}}$, it has an approximate tangent space $P$ and $x \in A_{m}$ for some $m$. Fix such $x$. We may assume that $x=0$ and $P=\left\{x \in \mathbb{R}^{d} \mid x_{d}=0\right\}$ by a parallel translation and a rotation. Set $\theta:=\lim _{r \downarrow 0} \frac{\mu_{t_{0}}\left(B_{r}(0)\right)}{\omega_{d-1} r^{d-1}}$. We need only prove $\theta \in \mathbb{N}$. Let $\Phi_{r}(x)=\frac{x}{r}$ for $r>0$ and $\left(\Phi_{r}\right)_{\#} V_{t_{0}}$ be the usual push forward of the varifold. Then for any positive sequence $r_{i} \rightarrow 0$, we have $\lim _{i \rightarrow \infty}\left(\Phi_{r_{i}}\right)_{\#} V_{t_{0}}=\theta|P|$, where $|P|$ is the unit density varifold generated by $P$. By the assumption $0 \in A_{m}$, there exists $\left\{x_{i}\right\}_{i=1}^{\infty}$ such that $x_{i} \in A_{i, m}$ and $x_{i} \rightarrow 0$ as $i \rightarrow \infty$. Passing to a subsequence if necessary, we may assume that

Set $u^{\tilde{\varepsilon}_{i}}(\tilde{x}, \tilde{t})=\varphi^{\varepsilon_{i}}(x, t)$ and $g^{\tilde{\varepsilon}_{i}}(\tilde{t})=r_{i} \lambda^{\varepsilon_{i}}(t)$ for $\tilde{x}=\frac{x}{r_{i}}, \tilde{t}=\frac{t-t_{0}}{r_{i}^{2}}$, and $\tilde{\varepsilon}_{i}=\frac{\varepsilon_{i}}{r_{i}}$ (another functions $\tilde{\xi}_{\tilde{\varepsilon}_{i}}$ and $\tilde{H}^{\tilde{\varepsilon}_{i}}$ are defined in the same way). Note that $\tilde{x}_{i}:=\frac{x_{i}}{r_{i}} \rightarrow 0$ and $\tilde{\varepsilon}_{i} \rightarrow 0$ by (4.52) and $u^{\tilde{\varepsilon}_{i}}$ is a solution to (4.21) with $\tilde{\varepsilon}_{i}$ instead of $\tilde{\varepsilon}$. We compute

\tilde{\varepsilon}_{i} \int_{B_{3}(0)}\left|\tilde{H}^{\tilde{\varepsilon}_{i}} \nabla_{\tilde{x}} \tilde{u}^{\tilde{\varepsilon}_{i}}(\tilde{x}, 0)\right| d \tilde{x} & =\frac{\varepsilon_{i}}{r_{i}^{d-2}} \int_{B_{3 r_{i}}(0)}\left|H^{\varepsilon_{i}} \nabla \varphi^{\varepsilon_{i}}\left(x, t_{0}\right)\right| d x \leq \frac{m}{r_{i}^{d-2}} \mu_{t_{0}}^{\varepsilon_{i}}\left(B_{4 r_{i}}\left(x_{i}\right)\right)  \tag{4.55}\\
& \leq 4^{d-1} m \omega_{d-1} D_{2} r_{i} \rightarrow 0 \quad \text { as } i \rightarrow \infty,
\end{align*}
$$

where we used (3.23), (4.52), and $x_{i} \in A_{i, m}$. Let $\tilde{V}_{\tilde{t}}^{\tilde{\varepsilon}_{i}}$ be a varifold defined by (4.17) with $u^{\tilde{\varepsilon}_{i}}$ instead of $\varphi^{\varepsilon}$. Then $\tilde{V}_{0}^{\tilde{\varepsilon}_{i}}=\left(\Phi_{r_{i}}\right)_{\#} V_{t_{0}}^{\varepsilon_{i}}$. Next we show

where $\nu^{i}=\left(\nu_{1}^{i}, \nu_{2}^{i}, \ldots, \nu_{d}^{i}\right)=\frac{\nabla_{\tilde{\tilde{x}}} u^{\varepsilon_{i}}}{\nabla_{\tilde{x}} u^{\varepsilon_{i}} \mid}$. For $S \in \mathbb{G}(d, d-1)$, set $\psi(S):=1-\nu_{d}^{2}$, where $\nu \in \mathbb{S}^{d-1}$ be one of the unit normal vectors to $S$. Then $\psi: \mathbb{G}(d, d-1) \rightarrow \mathbb{R}$ is well-defined, continuous,
and $\psi(P)=0$. Hence, for any $\phi \in C_{c}\left(\mathbb{R}^{d}\right), \phi \psi \in C_{c}\left(G_{d-1}\left(\mathbb{R}^{d}\right)\right)$ and

where we used (4.53) and $\psi(P)=0$. Thus (4.57) proves (4.56). We subsequently fix the subsequence and drop $\tilde{\sim}$ and time variable (for example, we write $u^{\tilde{\varepsilon}_{i}}(\tilde{x}, 0)$ as $u^{\varepsilon_{i}}$ ) for simplicity. We assume that $N \in \mathbb{N}$ is a smallest positive integer grater than $\theta$, namely,

For these $s>0, b>0$, and $c>0$ given by Lemma 4.2, we choose $\varrho$ and $L$ given by propositions 6.4 and 6.5 in Appendix with $R=2$ (we may restrict $\varrho$ to be small if necessary). We choose $a=L \varepsilon_{i}$ as a constant in Proposition 6.4. Set

\end{align*}
$$

for sufficiently large $i$. The Besicovitch covering theorem, (4.54), (4.55), and (4.56) yield

\leq & \frac{c(d)}{\varrho} \int_{B_{3}(0)} \varepsilon_{i}\left|H^{\varepsilon_{i}} \nabla u^{\varepsilon_{i}}\right|+\left|\xi_{\varepsilon_{i}}\right|+\left(1-\nu_{d}^{2}\right) \varepsilon_{i}\left|\nabla u^{\varepsilon_{i}}\right|^{2} d x \rightarrow 0 \quad \text { as } i \rightarrow \infty \tag{4.61}
\end{align*}
$$

Next we show that for sufficiently large $i$

\end{equation*}

Note that all the assumptions in Proposition 6.5 are satisfied by Lemma 4.2, (3.6), and (4.60). Thus we have (4.62) with $r=L \varepsilon_{i}$. By the integration by parts, we have

Thus we can compute

\left.\frac{1}{\sigma \tau^{d-1}} \int_{B_{\tau}(x)} e_{\varepsilon_{i}} d y\right|_{\tau=L \varepsilon_{i}} ^{r} & \geq-\int_{L \varepsilon_{i}}^{r} \frac{1}{\sigma \tau^{d}} \int_{B_{\tau}(x)} \varepsilon_{i} H^{\varepsilon_{i}}\left(y \cdot \nabla u^{\varepsilon_{i}}\right) d y d \tau \\
& \geq-\int_{L \varepsilon_{i}}^{1} \frac{1}{\sigma \tau^{d}} \int_{B_{\tau}(x)} \varepsilon_{i} \tau\left|H^{\varepsilon_{i}} \nabla u^{\varepsilon_{i}}\right| d y d \tau \\
& \geq-\frac{\varrho D_{2}}{\sigma}
\end{aligned}
$$

where we used (3.23), (4.60), and $\xi_{\varepsilon_{i}} \leq 0$. Therefore we obtain (4.62) for sufficiently large $i$ by restricting $\varrho$ to be small. Let $\delta>0$ and $\phi \in C_{c}\left(B_{3}(0)\right)$ be a nonnegative test function such that $\phi=1$ on $B_{2}(0) \cap\left\{\left|x_{d}\right|>\delta\right\}$. Then there exists $i_{0} \geq 1$ such that

We use Proposition 6.4 with $R=1, a=L \varepsilon_{i}$ and $Y^{\prime}=\left\{y_{j}\right\}_{j=1}^{N}$ instead of $Y$. Note that the smallness of $\operatorname{diam} Y^{\prime}$ is true from (4.64) and $\left|y_{j}-y_{k}\right|>3 L \varepsilon_{i}$ for any $1 \leq j<k \leq N$ holds by (6.14). Then (6.13) yields

By this, $\# Y^{\prime}=N$, (4.62), and (4.66) we have

We regard $P$ as a diagonal matrix $\left(p_{j k}\right)$ with $p_{k k}=1$ for $1 \leq k \leq d-1$ and $p_{d d}=0$. Then the push-forward of $\hat{V}_{0}^{\varepsilon_{i}}$ by $P$ is given by

& =\int_{\left\{\left|x_{d}\right| \leq 1\right\}} \phi\left(P x, P \circ\left(I-\nu^{i} \otimes \nu^{i}\right)\right)\left|\nu_{d}^{i}\right| d \mu_{0}^{\varepsilon_{i}}
\end{aligned}
$$

for any $\phi \in C_{c}\left(P \cap B_{2}(0) \times \mathbb{G}(d, d-1)\right)$. Here $\left|\Lambda_{d-1} \nabla P x \circ\left(I-\nu^{i} \otimes \nu^{i}\right)\right|$ is the Jacobian and $\nu_{d}^{i}=\frac{\partial_{x_{d}} u^{\varepsilon_{i}}}{\mid \nabla u^{\varepsilon_{i} \mid}}$. Due to (4.53), $P_{\#} \hat{V}_{0}^{\varepsilon_{i}} \rightarrow P_{\#}\left(\theta \mathscr{H}^{d-1}{ }_{P}\right)=\theta \mathscr{H}^{d-1}{ }_{P}$ as $i \rightarrow \infty$. By (4.54),

\end{equation*}
$$

holds (see (5.1) below). We compute

\omega_{d-1} \theta & =\mathscr{H}^{d-1}\left\lfloor_{P}\left(B_{1}(0)\right) \leq \liminf _{i \rightarrow \infty}\left\|P_{\#} \hat{V}_{0}^{\varepsilon_{i}}\right\|\left(B_{1}(0)\right)=\liminf _{i \rightarrow \infty} \int_{B_{1}(0)}\left|\nu_{d}^{i}\right| d \mu_{0}^{\varepsilon_{i}}\right. \\
& \leq \liminf _{i \rightarrow \infty} \int_{B_{1}(0) \cap G_{i}}\left|\nu_{d}^{i}\right| d \mu_{0}^{\varepsilon_{i}}+2 s  \tag{4.68}\\
& \leq \liminf _{i \rightarrow \infty} \frac{1}{\sigma} \int_{B_{1}(0) \cap G_{i}}\left|\nu_{d}^{i}\right| \sqrt{2 W\left(u^{\varepsilon_{i}}\right)}\left|\nabla u^{\varepsilon_{i}}\right| d x+2 s
\end{align*}
$$

where we used (4.59), (4.61), and (4.67). By the co-area formula and the area formula, we have

= & \int_{-1+b}^{1-b} \sqrt{2 W(\tau)} \int_{B_{1}(0) \cap\left\{x_{d}=0\right\}} \mathscr{H}^{0}\left(\left\{u^{\varepsilon_{i}}=\tau\right\} \cap G_{i} \cap P^{-1}(x)\right) d \mathscr{H}^{d-1}(x) d \tau \\
\leq & \int_{-1+b}^{1-b} \sqrt{2 W(\tau)} \int_{B_{1}(0) \cap\left\{x_{d}=0\right\}}(N-1) d \mathscr{H}^{d-1}(x) d \tau \\
\leq & \sigma(N-1) \omega_{d-1},
\end{aligned}
$$

where we used (4.65) and $\sigma=\int_{-1}^{1} \sqrt{2 W(\tau)} d \tau$. Hence $\theta \leq N-1$ due to (4.68) and (4.69) and the arbitrariness of $s$. By this and (4.58), $\theta=N-1$.

## 5. Proofs of main theorems

In this section we prove Theorem 2.6 and Theorem 2.8 on the existence of the weak solution in the sense of $L^{2}$-flow and distributional $B V$-solution.
Proof of Theorem 2.6. Let $\left\{\varphi_{0}^{\varepsilon_{i}}\right\}_{i=1}^{\infty}$ be a family of functions such that all the claims of Proposition 2.4 are satisfied. Then one can check that all the assumptions in Section 3 and 4 are fulfilled. Therefore (a) holds by propositions [2.4, 3.13, and 3.14, By taking a subsequence $\varepsilon_{i} \rightarrow 0$, we obtain (b) (the proof is standard and is exactly the same as that in [36], so we omit it). By Lemma 3.6 and the weak compactness of $L^{2}(0, T)$, we may take a subsequence $\varepsilon_{i} \rightarrow 0$ such that (c) holds (for the weak convergence for all $T>0$, we only need to use the diagonal argument).

Next we show (d). We compute

$$
\begin{equation*}
\frac{\varepsilon\left|\nabla \varphi^{\varepsilon}\right|^{2}}{2}+\frac{W\left(\varphi^{\varepsilon}\right)}{\varepsilon}-\sqrt{2 W\left(\varphi^{\varepsilon}\right)}\left|\nabla \varphi^{\varepsilon}\right|=\left(\frac{\sqrt{\varepsilon}\left|\nabla \varphi^{\varepsilon}\right|}{\sqrt{2}}-\frac{\sqrt{W\left(\varphi^{\varepsilon}\right)}}{\sqrt{\varepsilon}}\right)^{2} \leq\left|\xi_{\varepsilon}\right| \tag{5.1}
\end{equation*}
$$

Set $d \hat{\mu}^{\varepsilon}:=\frac{1}{\sigma} \sqrt{2 W\left(\varphi^{\varepsilon}\right)}\left|\nabla \varphi^{\varepsilon}\right| d x d t$. By (5.1), Proposition 3.13, and Theorem 4.7, we have

where $d \mu:=d \mu_{t} d t$. By (3.8), (3.11), (5.1), and (5.2), we obtain

\sup _{i \in \mathbb{N}} \int_{\Omega \times(0, T)}\left|\lambda^{\varepsilon_{i}}\right|^{2} d \hat{\mu}^{\varepsilon_{i}} \leq \sup _{i \in \mathbb{N}} \int_{\Omega \times(0, T)}\left|\lambda^{\varepsilon_{i}}\right|^{2} d \mu_{t}^{\varepsilon_{i}} d t \leq D_{1} C_{3}(1+T)
$$

Then there exist $\vec{f} \in\left(L_{l o c}^{2}(\mu)\right)^{d}$ and the subsequence $\varepsilon_{i} \rightarrow 0$ such that

\begin{aligned}
\frac{1}{\sigma} \int_{\Omega \times(0, T)}-\lambda^{\varepsilon_{i}} \sqrt{2 W\left(\varphi^{\varepsilon_{i}}\right)} \nabla \varphi^{\varepsilon_{i}} \cdot \vec{\phi} d x d t & =\int_{\Omega \times(0, T) \cap\left\{\left|\nabla \varphi^{\varepsilon_{i}}\right| \neq 0\right\}}-\lambda^{\varepsilon_{i}} \frac{\nabla \varphi^{\varepsilon_{i}}}{\left|\nabla \varphi^{\varepsilon_{i}}\right|} \cdot \vec{\phi} d \hat{\mu}^{\varepsilon_{i}} \\
& \rightarrow \int_{\Omega \times(0, T)} \vec{f} \cdot \vec{\phi} d \mu_{t} d t
\end{aligned}
$$

for any $\vec{\phi} \in C_{c}\left(\Omega \times[0, T) ; \mathbb{R}^{d}\right)$ (see [18, Theorem 4.4.2]). Moreover, if $\vec{\phi}$ is smooth, we have

\begin{aligned}
& \int_{\Omega \times(0, T)} \vec{f} \cdot \vec{\phi} d \mu=\lim _{i \rightarrow \infty} \frac{1}{\sigma} \int_{\Omega \times(0, T)}-\lambda^{\varepsilon_{i}} \sqrt{2 W\left(\varphi^{\varepsilon_{i}}\right)} \nabla \varphi^{\varepsilon_{i}} \cdot \vec{\phi} d x d t \\
= & \lim _{i \rightarrow \infty} \frac{1}{\sigma} \int_{\Omega \times(0, T)} \lambda^{\varepsilon_{i}} k\left(\varphi^{\varepsilon_{i}}\right) \operatorname{div} \vec{\phi} d x d t=\int_{0}^{T} \lambda \int_{\Omega} \psi \operatorname{div} \vec{\phi} d x d t \\
= & -\int_{0}^{T} \lambda \int_{\Omega} \vec{\phi} \cdot \nu d\|\nabla \psi(\cdot, t)\| d t,
\end{aligned}
$$

where we used (c), $k^{\prime}(s)=\sqrt{2 W(s)}, \lim _{i \rightarrow \infty} k\left(\varphi^{\varepsilon_{i}}\right)=\sigma\left(\psi-\frac{1}{2}\right)$ for a.e. $(x, t)$, and the dominated convergence theorem. Hence we have (2.10).

Now we prove (e). By replacing $d \hat{\mu}^{\varepsilon}$ with $d \tilde{\mu}^{\varepsilon}:=\frac{\varepsilon}{\sigma}\left|\nabla \varphi^{\varepsilon}\right|^{2} d x d t$, the convergence (2.11) is obtained in the same way as (d). In addition, for any $\vec{\phi} \in C_{c}\left(\Omega \times[0, T) ; \mathbb{R}^{d}\right)$, we compute

& \int_{0}^{T} \int_{\Omega} \vec{v} \cdot \vec{\phi} d \mu_{t} d t=\lim _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \vec{v}^{\varepsilon_{i}} \cdot \vec{\phi} d \mu_{t}^{\varepsilon_{i}} d t=\lim _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega} \vec{v}^{\varepsilon_{i}} \cdot \vec{\phi} d \tilde{\mu}^{\varepsilon_{i}} \\
= & \lim _{i \rightarrow \infty} \int_{0}^{T} \int_{\Omega}-\varepsilon_{i}\left(\Delta \varphi^{\varepsilon_{i}}-\frac{W^{\prime}\left(\varphi^{\varepsilon_{i}}\right)}{\varepsilon_{i}^{2}}+\lambda^{\varepsilon_{i}} \frac{\sqrt{2 W\left(\varphi^{\varepsilon_{i}}\right)}}{\varepsilon_{i}}\right) \nabla \varphi^{\varepsilon_{i}} \cdot \vec{\phi} d x d t \\
= & \int_{0}^{T} \int_{\Omega}(\vec{h}+\vec{f}) \cdot \vec{\phi} d \mu_{t} d t,
\end{aligned}
$$

where we used Theorem 4.9 and (d). Thus $\vec{v}=\vec{h}+\vec{f}$. One can check that $\left\{\mu_{t}\right\}_{t \in[0, \infty)}$ is an $L^{2}$-flow with the generalized velocity vector $\vec{v}$ (see [36, Proposition 4.3] for the inequality (2.1) and [30, Lemma 6.3] for the perpendicularity).

To prove Theorem 2.8, we use the following proposition and lemmas. In the original proof of the following proposition, $2 \leq d \leq 3$ is assumed to use the results of [32, Proposition 4.9, Theorem 5.1]. However, we already know that $|\xi|=0$ and $\mu_{t}$ is integral for a.e. $t$, so we can show the claim in the same way.

Proposition 5.1 (See Proposition 4.5 of [30]). Let $\psi, \vec{v}$, and $\vec{\nu}$ are given by Theorem 2.6. Then $\int|\vec{v} \cdot \vec{\nu}| d\|\nabla \psi(\cdot, t)\| d t<\infty$ and

\int_{0}^{T} \int_{\Omega} \phi \vec{v} \cdot \vec{\nu} d\|\nabla \psi(\cdot, t)\| d t=\int_{0}^{T} \int_{\Omega} \phi_{t} \psi d x d t \tag{5.3}

for any $\phi \in C_{c}^{1}(\Omega \times(0, T))$ and for any $T>0$.
Proof. Set $\nabla_{x, t}=\left(\nabla, \partial_{t}\right)$ in the sense of BV. One can check that $\left\|\nabla_{x, t} \psi\right\| \ll \mu, \mu\left\lfloor_{\partial^{*}\{\psi=1\}}\right.$ is rectifiable, $\int|\vec{v} \cdot \vec{\nu}| d\|\nabla \psi(\cdot, t)\| d t<\infty$, and the approximate tangent space coincides with
that of $\left\|\nabla_{x, t} \psi\right\|$ for $\mu$-a.e. and $\left\|\nabla_{x, t} \psi\right\|$-a.e. (see [30, Proposition 8.1-8.3] and [2, Proposition 2.85]). By this and Proposition [2.3, we have

0=\int_{0}^{T} \int_{\Omega} \phi(\vec{v}, 1) \cdot \vec{\nu}_{x, t} d\left\|\nabla_{x, t} \psi\right\|=\int_{0}^{T} \int_{\Omega} \phi \vec{v} \cdot \vec{\nu} d\|\nabla \psi(\cdot, t)\| d t+\int_{0}^{T} \int_{\Omega} \phi \psi_{t} d x d t
$$

for any $\phi \in C_{c}^{1}(\Omega \times(0, T))$, where $\vec{\nu}_{x, t}$ is the inner unit normal vector of $\{(x, t) \mid \psi(x, t)=1\}$. Therefore we obtain (5.3).

Lemma 5.2. Let $\gamma$ and $\delta$ be positive constants with $\delta<\gamma$. Under the same assumptions of Theorem [2.8, there exist $T_{2} \in(0,1)$ and $\epsilon_{5} \in(0,1)$ depending only on $\gamma, \delta$, and $C_{3}\left(\omega, d, D_{1}^{\prime}\right)$ with the following property. Let $g: \mathbb{R} \rightarrow[0, \infty)$ be a smooth even function such that $g(0)=0,0 \leq g^{\prime \prime}(s) \leq 2$ for any $s \in \mathbb{R}$, and $g(s)=|s|-\frac{1}{2}$ if $|s| \geq 1$. Set $g^{\delta}(s):=\delta g(s / \delta)$ and define $\tilde{r}^{\varepsilon, \delta} \in C^{\infty}\left(\mathbb{R}^{d} \times[0, \infty)\right)$ by

\tilde{r}^{\varepsilon, \delta}(x, t):=g^{\delta}\left(x_{1}\right)+\int_{0}^{t} \lambda^{\varepsilon}(\tau) d \tau+2 \delta^{-1} t-\gamma,

where $\lambda^{\varepsilon}$ is given by (1.6). Set $\tilde{\phi}^{\varepsilon, \delta}:=q^{\varepsilon}\left(\tilde{r}^{\varepsilon, \delta}\right)$ and assume that $\tilde{\phi}^{\varepsilon}(x, 0) \geq \varphi_{0}^{\varepsilon}(x)$ for any $x \in \mathbb{R}^{d}$. Then

\tilde{\phi}^{\varepsilon, \delta} \geq \varphi^{\varepsilon} \quad \text { in } \mathbb{R}^{d} \times\left[0, T_{2}\right) \tag{5.4}
\end{equation*}
$$

for any $\varepsilon \in\left(0, \epsilon_{5}\right)$.
Proof. We denote $\tilde{r}=\tilde{r}^{, \delta}$ for simplicity. By (3.7) and the comparison principle, we need only prove

\tilde{r}_{t} \geq \Delta \tilde{r}-\frac{2 q^{\varepsilon}(\tilde{r})}{\varepsilon}\left(|\nabla \tilde{r}|^{2}-1\right)+\lambda^{\varepsilon} \quad \text { in } \mathbb{R}^{d} \times\left(0, T_{2}\right) \tag{5.5}
\end{equation*}
$$

for sufficiently small $T_{2}>0$ and $\varepsilon>0$, since $\tilde{\phi}^{\varepsilon, \delta} \geq \varphi^{\varepsilon}$ if and only if $\tilde{r} \geq r^{\varepsilon}$. In the case of $\left|x_{1}\right| \geq \delta$, (5.5) holds by $\tilde{r}_{t}=2 \delta^{-1}+\lambda^{\varepsilon},|\nabla \tilde{r}|=1$, and $\Delta \tilde{r}=0$. Next we consider the case of $\left|x_{1}\right| \leq \delta$. Set $O_{\delta}:=\left\{x \in \mathbb{R}^{d}| | x_{1} \mid \leq \delta\right\}$. By $\tilde{r}(x, 0) \leq-\gamma+\frac{\delta}{2}$ on $O_{\delta}$ and

$$
|\tilde{r}(x, t)-\tilde{r}(x, 0)| \leq \int_{0}^{t}\left|\lambda^{\varepsilon}(\tau)\right| d \tau+2 \delta^{-1} t \leq \sqrt{C_{3}(1+t)} \sqrt{t}+2 \delta^{-1} t
$$

there exists $T_{2}>0$ such that

$$
\begin{equation*}
\tilde{r}(x, t) \leq-\frac{\gamma}{4}<0 \quad \text { for any }(x, t) \in O_{\delta} \times\left[0, T_{2}\right) \tag{5.6}
\end{equation*}
$$

By ([5.6) and $|\nabla \tilde{r}| \leq 1, \frac{2 q^{\varepsilon}(\tilde{r})}{\varepsilon}\left(|\nabla \tilde{r}|^{2}-1\right) \geq 0$. By using this, for any $(x, t) \in O_{\delta} \times\left[0, T_{2}\right)$,

\tilde{r}_{t}-\Delta \tilde{r}+\frac{2 q^{\varepsilon}(\tilde{r})}{\varepsilon}\left(|\nabla \tilde{r}|^{2}-1\right)-\lambda^{\varepsilon} \geq 2 \delta^{-1}-\Delta \tilde{r} \geq 0 \tag{5.7}
\end{equation*}
$$

where we used $\Delta \tilde{r} \leq \delta^{-1} g^{\prime \prime}\left(x_{1} / \delta\right) \leq 2 \delta^{-1}$. Therefore we obtain (5.5).
Lemma 5.3. Let $r \in\left(0, \frac{1}{4}\right)$. Then there exists $T_{3}>0$ depending only on $d$ and $r$ with the following property. Let $U_{0} \subset \subset\left(\frac{1}{4}, \frac{3}{4}\right)^{d}$ satisfies $\mathscr{L}^{d}\left(U_{0}\right)=\mathscr{L}^{d}\left(B_{r}(0)\right)$ and has a $C^{1}$ boundary $M_{0}$ with (2.12) for $\delta_{1}>0$. In addition, we assume $\mathscr{H}^{d-1}\left(M_{0}\right) \leq 2 \mathscr{H}^{d-1}\left(\partial B_{r}(0)\right)$. Then we have

0 \leq \mu_{0}(\Omega)-\mu_{t}(\Omega) \leq \delta_{1} \quad \text { for any } t \in\left[0, T_{3}\right) \tag{5.8}
\end{equation*}
$$

where $\mu_{t}$ is a weak solution to (1.1) with initial data $M_{0}$.

Proof. First we claim that there exists $T_{3}>0$ depending only on $d$ and $r$ such that

for any $t \in\left[0, T_{3}\right)$, where $\psi=\lim _{i \rightarrow \infty} \psi^{\varepsilon_{i}}=\lim _{i \rightarrow \infty} \frac{1}{2}\left(\varphi^{\varepsilon_{i}}+1\right)$. Let $\tilde{\phi}^{\varepsilon, \delta}$ be a function given by Lemma 5.2 with $\gamma=\frac{1}{10}$ and $\delta=\frac{1}{20}$. By (5.4) and (5.6), one can check that there exists $T_{3}=T_{3}\left(C_{3}\left(\omega, d, D_{1}^{\prime}\right)\right)>0$ such that $\lim _{i \rightarrow \infty} \varphi^{\varepsilon_{i}}(x, t)=-1$ on $\left\{x \in \mathbb{R}^{d}| | x_{1} \left\lvert\, \leq \frac{1}{10}\right.\right\}$ for any $t \in\left[0, T_{3}\right)$. Note that $\omega$ and $D_{1}^{\prime}$ depend only on $r$ by $\mathscr{L}^{d}\left(U_{0}\right)=\mathscr{L}^{d}\left(B_{r}(0)\right)$ and $\mathscr{H}^{d-1}\left(M_{0}\right) \leq 2 \mathscr{H}^{d-1}\left(\partial B_{r}(0)\right)$. Hence $T_{3}$ depends only on $d$ and $r$. Therefore $U_{t} \cap\left\{x \in \mathbb{R}^{d} \mid\right.$ $\left.\left|x_{1}\right| \leq \frac{1}{10}\right\}=\emptyset$ for any $t \in\left[0, T_{3}\right)$. Similarly we have (5.9). Thus $\partial^{*}\left(U_{t} \cap(0,1)^{d}\right)=\partial^{*} U_{t}$ for any $t \in\left[0, T_{3}\right)$. Hence, by using the isoperimetric inequality for Caccioppoli sets (see [12, 39]), and (b3) and (b4) of Theorem [2.6, we have

d \omega_{d}^{\frac{1}{d}}\left(\mathscr{L}^{d}\left(U_{0}\right)\right)^{\frac{d-1}{d}}=d \omega_{d}^{\frac{1}{d}}\left(\mathscr{L}^{d}\left(U_{t}\right)\right)^{\frac{d-1}{d}} \leq \mathscr{H}^{d-1}\left(\partial^{*} U_{t}\right) \leq \mu_{t}(\Omega) \quad \text { for any } t \in\left[0, T_{3}\right) \tag{5.10}
\end{equation*}
$$

By (2.12) and (5.10), we obtain (5.8).
Finally we prove Theorem 2.8.
Proof of Theorem 2.8. First we show (a). From (3.10),

\int_{0}^{T}\left|\lambda^{\varepsilon}(t)\right|^{2} d t \leq C_{2}\left(\mu_{0}^{\varepsilon}(\Omega)-\mu_{T}^{\varepsilon}(\Omega)+T\right)
$$

for any $T>0$ and for any $\varepsilon \in\left(0, \epsilon_{1}\right)$. By this and (5.8), we can choose $\delta_{1}=\delta_{1}\left(C_{2}\left(\omega, d, D_{1}^{\prime}\right)\right)>$ 0 so that

\begin{equation*}
\limsup _{i \rightarrow \infty} e^{\frac{1}{2} \int_{0}^{T_{4}}\left|\lambda^{\varepsilon}\right|^{2} d t} \leq \limsup _{i \rightarrow \infty} e^{\frac{1}{2} C_{2} \delta_{1}} e^{\frac{1}{2} C_{2} T_{4}} \leq \frac{10}{9} \tag{5.11}
\end{equation*}
$$

where $T_{4}=T_{4}(d, r)=\min \left\{T_{3}, \frac{2}{C_{2}} \log \frac{100}{99}\right\}>0$ and $\delta_{1}$ also depends only on $d$ and $r$ since $\mathscr{L}^{d}\left(U_{0}\right)=\mathscr{L}^{d}\left(B_{r}(0)\right)$ and $\mathscr{H}^{d-1}\left(M_{0}\right) \leq 2 \mathscr{H}^{d-1}\left(\partial B_{r}(0)\right)$. Then (3.22) and (5.11) imply

\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, t) d \mu_{t}(x) \leq \frac{10}{9} \int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, 0) d \mu_{0}(x) \tag{5.12}
\end{equation*}
$$

for any $y \in \mathbb{R}^{d}, t \in\left[0, T_{4}\right)$, and $s>0$ with $0 \leq t<s$. Recall that $\rho_{(y, s)}(x, 0)$ converges to ( $d-1$ )-dimensional delta function at $y$ as $s \downarrow 0$. Therefore, since $M_{0}$ is $C^{1}$, we may assume that there exists $s_{0}>0$ depending only on $M_{0}$ such that

\int_{\mathbb{R}^{d}} \rho_{(y, s)}(x, 0) d \mu_{0} \leq \frac{3}{2} \tag{5.13}
\end{equation*}
$$

for any $y \in \mathbb{R}^{d}$ and $s \in\left(0, s_{0}\right)$. Set $T_{1}=T_{1}\left(d, r, M_{0}\right):=\min \left\{T_{4}, s_{0}\right\}$. Let $t_{0} \in\left(0, T_{1}\right)$ be a number such that $\mu_{t_{0}}$ is integral. Then there exist a countably $(d-1)$-rectifiable set $M_{t_{0}}$ and $\theta_{t_{0}} \in L_{l o c}^{1}\left(\mathscr{H}^{d-1} L_{t_{0}}\right)$ such that $\mu_{t_{0}}=\theta_{t_{0}} \mathscr{H}^{d-1}{ }_{M_{t_{0}}}$. Assume that there exist $x_{0} \in M_{t_{0}}$ and $N \geq 2$ such that $M_{t_{0}}$ has an approximate tangent space at $x_{0}$ and $\lim _{r \rightarrow 0} \frac{\mu_{t_{0}}\left(B_{r}\left(x_{0}\right)\right)}{\omega_{d-1} r^{d-1}}=$ $\theta_{t_{0}}\left(x_{0}\right)=N$. Set $r=\sqrt{2\left(s-t_{0}\right)}$ for $t_{0}<s<T_{1}$. Using the same calculation as (6.10), for any $\delta \in(0,1)$, we obtain

\begin{aligned}
& \int_{\mathbb{R}^{d}} \rho_{\left(x_{0}, s\right)}(x, t) d \mu_{t_{0}} \geq \frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{\delta}^{1} \mu_{t_{0}}\left(B_{\sqrt{2 r^{2} \log \frac{1}{k}}}\left(x_{0}\right)\right) d k \\
\rightarrow & \frac{N \omega_{d-1}}{\pi^{\frac{d-1}{2}}} \int_{\delta}^{1}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k \quad \text { as } r \rightarrow 0\left(s \downarrow t_{0}\right) .
\end{aligned}
$$

By this and $\int_{0}^{1}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k=\Gamma\left(\frac{d-1}{2}+1\right)=\pi^{\frac{d-1}{2}} / \omega_{d-1}$, we have

\lim _{s \downarrow t_{0}} \int_{\mathbb{R}^{d}} \rho_{\left(x_{0}, s\right)}(x, t) d \mu_{t_{0}}=N
$$

Then we have a contradiction by (5.12) and (5.13). Hence we obtain (a).
The claim (b1) and (b2) are clear and (b3) is also obvious by Remark 2.7 and $\mu_{t}=$ $\|\nabla \psi(\cdot, t)\|$ for a.e. $t \in\left(0, T_{1}\right)$. By (5.1), we have (b4).

Next we prove (b5). By (5.3), for any $\phi \in C_{c}^{1}((0, T))$, we compute

\int_{0}^{T_{1}} \phi \int_{\Omega} \vec{v} \cdot \vec{\nu} d\|\nabla \psi(\cdot, t)\| d t=\int_{0}^{T_{1}} \phi_{t} \int_{\Omega} \psi d x d t=0
$$

where we used (b3) of Theorem 2.6. Thus $\int_{\Omega} \vec{v} \cdot \vec{\nu} d\|\nabla \psi(\cdot, t)\|=0$ for a.e. $t \in\left(0, T_{1}\right)$.
Now we prove (b6). Set $d \nu:=d \mathscr{H}^{d-1}\left\lfloor\partial_{\partial^{*} U_{t}} d t\right.$. Since the space $C_{c}(\Omega)$ is dense in $L^{2}(\nu)$, for any $\eta \in C_{c}\left(\left(0, T_{1}\right)\right)$ we have

0 & =\int_{0}^{T_{1}} \int_{\partial^{*} U_{t}}\{\vec{v}-\vec{h}+\lambda \vec{\nu}\} \cdot \vec{\nu} \eta d \mathscr{H}^{d-1} d t \\
& =\int_{0}^{T_{1}}\left(-\int_{\partial^{*} U_{t}} \vec{h} \cdot \vec{\nu} d \mathscr{H}^{d-1}+\lambda \mathscr{H}^{d-1}\left(\partial^{*} U_{t}\right)\right) \eta d t
\end{aligned}
$$

where we used (b3) and (b5). Hence we obtain (b6).

## 6. Appendix

Proposition 6.1 (See Lemma 3.24 in [2]). Let $U \subset \mathbb{R}^{d}$ be an open set. Assume that $u \in B V(U)$ and $K \subset U$ is a compact set. Then

\int_{K}\left|u * \eta_{\delta}-u\right| d x \leq \delta\|\nabla u\|(U)
$$

for all $\delta \in(0, \operatorname{dist}(K, \partial U))$, where $\eta_{\delta}$ is the standard mollifier defined in Section 3.

As in Lemma 3.6, we can obtain the following estimate for the classical solution to the volume preserving mean curvature flow.
Proposition 6.2. Let $\Omega=\mathbb{T}^{d}$ and $U_{t} \subset \Omega$ be a bounded open set with smooth boundary $M_{t}$ for any $t \in[0, T)$ and $0<\mathscr{L}^{d}\left(U_{0}\right)<\mathscr{L}^{d}(\Omega)$. Assume that $\left\{M_{t}\right\}_{t \in[0, T)}$ is the volume preserving mean curvature flow. Then there exists $C_{\lambda}>0$ depending only on $d, \mathscr{L}^{d}\left(U_{0}\right)$, and $\mathscr{H}^{d-1}\left(M_{0}\right)$ such that

$$
\begin{equation*}
\int_{0}^{s}|\lambda(t)|^{2} d t \leq C_{\lambda}(1+s), \quad s \in(0, T) \tag{6.1}
\end{equation*}
$$

where $\lambda(t)=\frac{1}{\mathscr{C}^{d-1}\left(M_{t}\right)} \int_{M_{t}} \vec{h} \cdot \vec{\nu} d \mathscr{H}^{d-1}$.
Proof. Let $\vec{\zeta}: \Omega \times[0, \infty) \rightarrow \mathbb{R}^{d}$ be a smooth periodic function. By (1.1), (1.2), the divergence theorem, and the property of the mean curvature, we have

$$
\begin{equation*}
\frac{d}{d t} \mathscr{H}^{d-1}\left(M_{t}\right)=-\int_{M_{t}} \vec{h} \cdot \vec{v} d \mathscr{H}^{d-1}=-\int_{M_{t}}|\vec{v}|^{2} d \mathscr{H}^{d-1} \leq 0 \tag{6.2}
\end{equation*}
$$

and

$$
\begin{align*}
\int_{M_{t}} \vec{v} \cdot \vec{\zeta} d \mathscr{H}^{d-1} & =\int_{M_{t}} \vec{h} \cdot \vec{\zeta} d \mathscr{H}^{d-1}-\lambda \int_{M_{t}} \vec{\nu} \cdot \vec{\zeta} d \mathscr{H}^{d-1} \\
& =-\int_{M_{t}} \operatorname{div}_{M_{t}} \vec{\zeta} d \mathscr{H}^{d-1}+\lambda \int_{U_{t}} \operatorname{div} \vec{\zeta} d x . \tag{6.3}
\end{align*}
$$

By (6.2) and (6.3), we obtain

$$
\begin{align*}
|\lambda|\left|\int_{U_{t}} \operatorname{div} \vec{\zeta} d x\right| & \leq\|\vec{\zeta}(\cdot, t)\|_{C^{1}}\left(\mathscr{H}^{d-1}\left(M_{t}\right)+\int_{M_{t}}|\vec{v}| d \mathscr{H}^{d-1}\right) \\
& \leq\|\vec{\zeta}(\cdot, t)\|_{C^{1}}\left(\mathscr{H}^{d-1}\left(M_{0}\right)+\int_{M_{t}}|\vec{v}| d \mathscr{H}^{d-1}\right) . \tag{6.4}
\end{align*}
$$

Let $\alpha, \delta \in(0,1)$ and $u=u(x, t)$ be a periodic solution to

$$
\begin{cases}-\Delta u & =\chi_{U_{t}} * \eta_{\delta}-f_{\Omega}\left(\chi_{U_{t}} * \eta_{\delta}\right) \quad \text { in } \Omega, \\ \int_{\Omega} u d x & =0\end{cases}
$$

Then the standard PDE arguments imply the existence and uniqueness of the solution $u$ and

$$
\|u(\cdot, t)\|_{C^{2, \alpha}(\Omega)} \leq C_{\delta}, \quad t \in[0, T)
$$

where $C_{\delta}>0$ depends only on $d$ and $\delta$. Set $\vec{\zeta}(x, t)=\nabla u(x, t)$. We compute that

$$
\begin{aligned}
& -\int_{U_{t}} \operatorname{div} \vec{\zeta} d x=\int_{U_{t}}(-\Delta u) d x \\
= & \int_{U_{t}}\left(\chi_{U_{t}} * \eta_{\delta}-f_{\Omega}\left(\chi_{U_{t}} * \eta_{\delta}\right)\right) d x \\
= & \int_{\Omega} \chi_{U_{t}}\left(\chi_{U_{t}} * \eta_{\delta}\right) d x-\frac{\mathscr{L}^{d}\left(U_{t}\right)}{\mathscr{L}^{d}(\Omega)} \int_{\Omega}\left(\chi_{U_{t}} * \eta_{\delta}\right) d x \\
= & \int_{\Omega} \chi_{U_{t}}\left(\chi_{U_{t}} * \eta_{\delta}-\chi_{U_{t}}\right) d x+\int_{\Omega} \chi_{U_{t}}^{2} d x \\
& -\frac{\mathscr{L}^{d}\left(U_{t}\right)}{\mathscr{L}^{d}(\Omega)} \int_{\Omega}\left(\chi_{U_{t}} * \eta_{\delta}-\chi_{U_{t}}\right) d x-\frac{\mathscr{L}^{d}\left(U_{t}\right)}{\mathscr{L}^{d}(\Omega)} \int_{\Omega} \chi_{U_{t}} d x \\
\geq & -C \delta \mathscr{H}^{d-1}\left(M_{t}\right)+\mathscr{L}^{d}\left(U_{t}\right)\left(1-\frac{\mathscr{L}^{d}\left(U_{t}\right)}{\mathscr{L}^{d}(\Omega)}\right) \\
\geq & -C \delta \mathscr{H}^{d-1}\left(M_{0}\right)+\mathscr{L}^{d}\left(U_{0}\right)\left(1-\frac{\mathscr{L}^{d}\left(U_{0}\right)}{\mathscr{L}^{d}(\Omega)}\right),
\end{aligned}
$$

where we used Proposition 6.1, $\left\|\nabla \chi_{U_{t}}\right\|(\Omega)=\mathscr{H}^{d-1}\left(M_{t}\right)$, (6.2), and the volume preserving property. We choose $\delta>0$ such that

$$
-\int_{U_{t}} \operatorname{div} \vec{\zeta} d x \geq \frac{1}{2} \mathscr{L}^{d}\left(U_{0}\right)\left(1-\frac{\mathscr{L}^{d}\left(U_{0}\right)}{\mathscr{L}^{d}(\Omega)}\right)>0
$$

By this and (6.4),

$$
\begin{equation*}
|\lambda| \leq \frac{C_{\delta}}{\omega^{\prime}}\left(\mathscr{H}^{d-1}\left(M_{0}\right)+\int_{M_{t}}|\vec{v}| d \mathscr{H}^{d-1}\right) \tag{6.5}
\end{equation*}
$$

where $\omega^{\prime}=\frac{1}{2} \mathscr{L}^{d}\left(U_{0}\right)\left(1-\frac{\mathscr{L}^{d}\left(U_{0}\right)}{\mathscr{L}^{d}(\Omega)}\right)$. The equality (16.2) implies

$$
\begin{equation*}
\int_{0}^{s} \int_{M_{t}}|\vec{v}|^{2} d \mathscr{H}^{d-1} d t \leq \mathscr{H}^{d-1}\left(M_{0}\right), \quad s \in[0, T) \tag{6.6}
\end{equation*}
$$

Therefore we obtain (6.1) by (6.5) and (6.6).

Next we show some properties of the backward heat kernel.
Lemma 6.3 (See[20]). Let $D>0$ and $\nu$ be a Radon measure on $\mathbb{R}^{d}$ satisfying

$$
\begin{equation*}
\sup _{R>0, x \in \mathbb{R}^{d}} \frac{\nu\left(B_{R}(x)\right)}{\omega_{d-1} R^{d-1}} \leq D \tag{6.7}
\end{equation*}
$$

Then the following hold:
(1) For any $a>0$ there exists $\gamma_{1}=\gamma_{1}(a)>0$ such that for any $r>0$ and for any $x, x_{1} \in \mathbb{R}^{d}$ with $\left|x-x_{1}\right| \leq \gamma_{1} r$, we have the estimate

$$
\begin{equation*}
\int_{\mathbb{R}^{d}} \rho_{x_{1}}^{r}(y) d \nu(y) \leq \int_{\mathbb{R}^{d}} \rho_{x}^{r} d \nu(y)+a D \tag{6.8}
\end{equation*}
$$

where $\rho_{x}^{r}$ is given by (4.2).
(2) For any $r, R>0$ and for any $x \in \mathbb{R}^{d}$, we have

$$
\begin{equation*}
\int_{\mathbb{R}^{d} \backslash B_{R}(x)} \rho_{x}^{r}(y) d \nu(y) \leq 2^{d-1} e^{-3 R^{2} / 8 r^{2}} D \tag{6.9}
\end{equation*}
$$

Proof. We only show (6.8) here (the estimate (6.9) can be shown more easily). For $\beta \in(0,1)$, we have

$$
\begin{align*}
& \int_{\mathbb{R}^{d}} \rho_{x_{1}}^{r}(y) d \nu(y)=\frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{\mathbb{R}^{d}} e^{-\frac{\left|x x_{1}-y\right|^{2}}{2 r^{2}}} d \nu(y) \\
= & \frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{0}^{1} \nu\left(\left\{y \left\lvert\, e^{-\frac{\left|x_{1}-y\right|^{2}}{2 r^{2}}}>k\right.\right\}\right) d k=\frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{0}^{1} \nu\left(B_{\sqrt{2 r^{2} \log \frac{1}{k}}}\left(x_{1}\right)\right) d k  \tag{6.10}\\
\leq & \omega^{d-1} D \int_{0}^{\beta}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k+\frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{\beta}^{1} \nu\left(B_{r \sqrt{2 \log \frac{1}{k}}}\left(x_{1}\right)\right) d k,
\end{align*}
$$

where we used (6.7). By $\int_{0}^{1}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k=\Gamma\left(\frac{d-1}{2}+1\right)=\pi^{\frac{d-1}{2}} / \omega_{d-1}$, we have

$$
\begin{equation*}
\int_{0}^{\beta}\left(\log \frac{1}{k}\right)^{\frac{d-1}{2}} d k \rightarrow 0 \quad \text { as } \quad \beta \rightarrow 0 \tag{6.11}
\end{equation*}
$$

We choose $\gamma_{1}>0$ depending only on $\beta$ such that

$$
\sqrt{2 \log \frac{1}{k}}+\gamma_{1} \leq \sqrt{2 \log \frac{1}{k-\beta}} \quad \text { for any } \quad k \in(\beta, 1]
$$

For any $x \in \mathbb{R}^{d}$ with $\left|x-x_{1}\right| \leq \gamma_{1} r$, we have $B_{r \sqrt{2 \log \frac{1}{k}}}\left(x_{1}\right) \subset B_{\left(\sqrt{2 \log \frac{1}{k}}+\gamma_{1}\right) r}(x) \subset B_{r \sqrt{2 \log \frac{1}{k-\beta}}}(x)$ for $k \in(\beta, 1]$. Therefore

$$
\begin{align*}
& \frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{\beta}^{1} \nu\left(B_{r \sqrt{2 \log \frac{1}{k}}}\left(x_{1}\right)\right) d k \leq \frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{\beta}^{1} \nu\left(B_{r \sqrt{2 \log \frac{1}{k-\beta}}}(x)\right) d k \\
\leq & \frac{1}{(\sqrt{2 \pi} r)^{d-1}} \int_{0}^{1} \nu\left(B_{r \sqrt{2 \log \frac{1}{k^{\prime}}}}(x)\right) d k^{\prime}=\int_{\mathbb{R}^{d}} \rho_{x}^{r}(y) d \nu(y) \tag{6.12}
\end{align*}
$$

Hence (6.10), (6.11), and (6.12) imply (6.8).
Let $u^{\varepsilon}=u^{\varepsilon}(x)$ be a smooth function and define

$$
e_{\varepsilon}(x)=\frac{\varepsilon\left|\nabla u^{\varepsilon}(x)\right|^{2}}{2}+\frac{W\left(u^{\varepsilon}(x)\right)}{\varepsilon}, \quad \xi_{\varepsilon}(x)=\frac{\varepsilon\left|\nabla u^{\varepsilon}(x)\right|^{2}}{2}-\frac{W\left(u^{\varepsilon}(x)\right)}{\varepsilon} .
$$

The following propositions are used in the proof of the integrality of $\mu_{t}$.
Proposition 6.4 (See [19, 38, 40). For any $R \in(0, \infty), E_{0} \in(0, \infty), s \in(0,1)$, and $N \in \mathbb{N}$, there exists $\varrho \in(0,1)$ with the following property: Assume that a set $Y \in \mathbb{R}^{d}$ has no more than $N+1$ elements and $Y \subset\left\{\left(0, \ldots, 0, x_{d}\right) \in \mathbb{R}^{d} \mid x_{d} \in \mathbb{R}\right\}$, $\operatorname{diam} Y \leq \varrho R$, and there exists $a \in(0, R)$ such that $|y-z|>3 a$ holds for any $y, z \in Y$ with $y \neq z$. Moreover, we assume the following.
(1) $u^{\varepsilon} \in C^{2}\left(\left\{y \in \mathbb{R}^{d} \mid \operatorname{dist}(y, Y)<R\right\}\right)$.
(2) For any $x \in Y$ and $r \in[a, R]$,

$$
\int_{B_{r}(x)}\left|\xi_{\varepsilon}\right|+\left(1-\left(\nu_{d}\right)^{2}\right) \varepsilon\left|\nabla u^{\varepsilon}\right|^{2}+\varepsilon\left|\nabla u^{\varepsilon}\right|\left|\Delta u^{\varepsilon}-\frac{W^{\prime}\left(u^{\varepsilon}\right)}{\varepsilon^{2}}\right| d y \leq \varrho r^{d-1} .
$$

Here $\nu=\left(\nu_{1}, \ldots, \nu_{d}\right)=\frac{\nabla u^{\varepsilon}}{\left|\nabla u^{\varepsilon}\right|}$.
(3) For any $x \in Y$,

$$
\int_{a}^{R} \frac{d \tau}{\tau^{d}} \int_{B_{\tau}(x)}\left(\xi_{\varepsilon}\right)_{+} d y \leq \varrho .
$$

(4) For any $x \in Y$ and $r \in[a, R]$,

$$
\int_{B_{r}(x)} \varepsilon\left|\nabla u^{\varepsilon}\right|^{2} d y \leq E_{0} r^{d-1} .
$$

Then, we have

$$
\begin{equation*}
\sum_{x \in Y} \frac{1}{a^{d-1}} \int_{B_{a}(x)} e_{\varepsilon} \leq s+\frac{1+s}{R^{d-1}} \int_{\{x \mid \operatorname{dist}(x, Y)<R\}} e_{\varepsilon} . \tag{6.13}
\end{equation*}
$$

Proposition 6.5 (See [19, 38, 40]). For any $s, b, \beta \in(0,1)$, and $c \in(1, \infty)$, there exist $\varrho, \epsilon \in$ $(0,1)$ and $L \in(1, \infty)$ with the following property: Assume that $\varepsilon \in(0, \epsilon), u^{\varepsilon} \in C^{2}\left(B_{4 \varepsilon L}(0)\right)$ and

$$
\begin{aligned}
& \sup _{B_{4 \varepsilon L}(0)} \varepsilon\left|\nabla u^{\varepsilon}\right| \leq c, \quad \sup _{x, y \in B_{4 \varepsilon L}(0), x \neq y} \varepsilon^{\frac{3}{2}} \frac{\left|\nabla u^{\varepsilon}(x)-\nabla u^{\varepsilon}(y)\right|}{|x-y|^{\frac{1}{2}}} \leq c, \quad\left|u^{\varepsilon}(0)\right|<1-b, \\
& \int_{B_{4 \varepsilon L}(0)}\left(\left|\xi_{\varepsilon}\right|+\left(1-\left(\nu_{d}\right)^{2}\right) \varepsilon\left|\nabla u^{\varepsilon}\right|^{2}\right) d x \leq \varrho(4 \varepsilon L)^{d-1},
\end{aligned}
$$

and

$$
\sup _{B_{4 \varepsilon L}(0)}\left(\xi_{\varepsilon}\right)_{+} \leq \varepsilon^{-\beta}
$$

Then we have

$$
\begin{equation*}
[-1+b, 1-b] \subset u^{\varepsilon}(J) \quad \text { and } \quad \inf _{x \in J} \partial_{x_{d}} u^{\varepsilon}(x)>0 \quad \text { or } \sup _{x \in J} \partial_{x_{d}} u^{\varepsilon}(x)<0, \tag{6.14}
\end{equation*}
$$

where $J=B_{3 \varepsilon L}(0) \cap\left\{\left(0, \ldots, 0, x_{d}\right) \in \mathbb{R}^{d} \mid x_{d} \in \mathbb{R}\right\}$. In addition, we have

$$
\left|\sigma-\frac{1}{\omega_{d-1}(L \varepsilon)^{d-1}} \int_{B_{\varepsilon L}(0)} e_{\varepsilon}\right| \leq s .
$$

Remark 6.6. Note that the assumptions for $\left(\xi_{\varepsilon}\right)_{+}$in the propositions above hold for the solution to (1.5) with suitable initial data (see (3.6)).
