# A REMARK ON THE HALF WAVE SCHRÖDINGER EQUATION IN THE ENERGY SPACE

#### Abstract

We investigate the Cauchy problem for the half wave Schrödinger equation in the energy space. We derive the local well-posedness in the energy space for the odd power type nonlinearities under certain additional assumption for the initial data, namely $\hat{u}_{0} \in L_{\xi, \eta}^{1}\left(\mathbb{R}^{2}\right)$.


## 1. Introduction

We study the Cauchy problem for the following equation:

$$
\begin{align*}
i \partial_{t} u+\partial_{x}^{2} u-\left|D_{y}\right| u & =\mu|u|^{p-1} u, \quad(t, x, y) \in[-T, T] \times \mathbb{R}^{2}, \\
u(0, x, y) & =u_{0}(x, y) \in H^{s_{1}, s_{2}}\left(\mathbb{R}^{2}\right) \tag{1.1}
\end{align*}
$$

where $\left|D_{y}\right|=\left(-\partial_{y}^{2}\right)^{\frac{1}{2}}, \mu= \pm 1, p>1, T>0$ and $s_{1}, s_{2} \in \mathbb{R}$. Also, we define the anisotropic Sobolev spaces $H^{s_{1}, s_{2}}\left(\mathbb{R}^{2}\right)$ as

$$
\begin{aligned}
H^{s_{1}, s_{2}}\left(\mathbb{R}^{2}\right) & =\left\{f \in \mathcal{S}^{\prime}\left(\mathbb{R}^{2}\right) ;\|f\|_{H^{s_{1}, s_{2}}}<\infty\right\} \\
\|f\|_{H^{s_{1}, s_{2}}} & :=\left(\int_{\mathbb{R}^{2}}\langle\xi\rangle^{2 s_{1}}\langle\eta\rangle^{2 s_{2}}|\hat{f}(\xi, \eta)|^{2} \mathrm{~d} \xi \mathrm{~d} \eta\right)^{\frac{1}{2}}, \quad\langle\cdot\rangle:=\sqrt{1+|\cdot|^{2}}
\end{aligned}
$$

(1.1) with $\mu=1, p=3$ is firstly considered by Xu [5] in the analysis of large time behavior of the solution for smooth data. After [5], Bahri, Ibrahim and Kikuchi [1] obtained the local wellposedness for rough data, namely $s_{1}=0,(1>) s_{2}>\frac{1}{2}$ and $1<p \leqslant 5$ by the fixed point argument. (1.1) has the following conservation laws (the mass $M(u)$ and the energy $E(u)$ ):

$$
\begin{aligned}
M(u) & =\int_{\mathbb{R}^{2}}|u|^{2} \mathrm{~d} x \mathrm{~d} y \\
E(u) & =\frac{1}{2} \int_{\mathbb{R}^{2}}\left(\left|\partial_{x} u\right|^{2}+\left|D_{y}\right| u \cdot \bar{u}\right) \mathrm{d} x \mathrm{~d} y-\frac{\mu}{p+1} \int_{\mathbb{R}^{2}}|u|^{p+1} \mathrm{~d} x \mathrm{~d} y
\end{aligned}
$$

Hence the energy space $E$ for (1.1) lies in $H^{1,0}\left(\mathbb{R}^{2}\right) \cap H^{0, \frac{1}{2}}\left(\mathbb{R}^{2}\right)$ equipped with the norm

$$
\|u\|_{E}:=\left(\left\|\partial_{x} u\right\|_{L^{2}}^{2}+\left\|\left|D_{y}\right|^{\frac{1}{2}} u\right\|_{L^{2}}^{2}+\|u\|_{L^{2}}^{2}\right)^{\frac{1}{2}}
$$

The well-posedness in $E$ is unknown. In Proposition 5.4 [1], the Strichartz estimates require $s_{2}>\frac{1}{2}$, hence we cannot apply it for the problem. Moreover, we cannot apply the Yudovich argument directly to prove uniqueness for (1.1). If we apply the argument, we need to show $\|u\|_{L_{x, y}^{q}}<\infty$ for $q$ large enough. However, the Gagliardo-Nirenberg inequality shows that it only holds for $(2<) q<6$. These are the main obstacles to obtain well-posedness in $E$.

In this paper, we verify the following local well-posedness result in $E=H^{1,0}\left(\mathbb{R}^{2}\right) \cap H^{0, \frac{1}{2}}\left(\mathbb{R}^{2}\right)$ under additional assumption on the initial data.

Theorem 1.1. Let $p=2 k+1, k \in \mathbb{N}, \mu= \pm 1$. Suppose that $u_{0} \in E$ and $\hat{u}_{0} \in L_{\xi, \eta}^{1}\left(\mathbb{R}^{2}\right)$. Then, (1.1) is locally well-posed. More precisely, there exists $T=T\left(\left\|u_{0}\right\|_{E},\left\|\hat{u}_{0}\right\|_{L_{\xi, \eta}^{1}}\right)>0$ such that (1.1) has a unique solution u satisfying

$$
u \in C([-T, T] ; E) \cap L_{T, x, y}^{\infty} \quad \text { and } \quad \hat{u} \in L_{T}^{\infty} L_{\xi, \eta}^{1}
$$

$\hat{u}_{0} \in L_{\xi, \eta}^{1}\left(\mathbb{R}^{2}\right)$ in Theorem 1.1 seems to be somewhat extra assumption. However in order to control $\|u\|_{L_{T, x, y}^{\infty}}$, we need this assumption. Also, we suppose the power $p$ is odd to estimate the Duhamel term, see section 2 for details. We remark that in Theorem 1.1 [4], the norm inflation (ill-posedness) holds in $E$ for $p>5$, however in our Theorem 1.1, if we additionally suppose $\hat{u}_{0} \in L_{\xi, \eta}^{1}\left(\mathbb{R}^{2}\right)$, then (local) well-posedness in $E$ holds even if $p>5$ provided that $p$ is odd.

## 2. Proof of Theorem 1.1

In this section, we prove Theorem 1.1 For a Banach space $X$ and $r>0$, we define $B_{r}(X):=$ $\left\{f \in X ;\|f\|_{X} \leqslant r\right\}$. Throughout the paper, $\hat{\bullet}$ denotes the Fourier transform with respect to spatial variables $x$ and $y$.

Proof of Theorem 1.1. We prove the local well-posedness for (1.1) with initial data $u_{0} \in E$ and $\hat{u}_{0} \in L_{\xi, \eta}^{1}\left(\mathbb{R}^{2}\right)$ by the fixed point argument. By the Duhamel formula,

$$
\begin{equation*}
\Phi(u)=S(t) u_{0}-i \mu \int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u\right)(\tau) \mathrm{d} \tau \tag{2.1}
\end{equation*}
$$

where $S(t):=\exp \left\{i t\left(\partial_{x}^{2}-\left|D_{y}\right|\right)\right\}$ be the $L_{x, y}^{2}$ unitary operator for (1.1). From (2.1),

$$
\widehat{\Phi(u)}=e^{-i t\left(\xi^{2}+|\eta|\right)} \hat{u}_{0}-i \mu \int_{0}^{t} e^{-(t-\tau)\left(\xi^{2}+|\eta|\right)} \mid \widehat{\left.u\right|^{p-1}} u(\tau) \mathrm{d} \tau
$$

Let $Y:=\left\{u \in C([-T, T] ; E) \cap L_{T, x, y}^{\infty} ; \hat{u} \in L_{T}^{\infty} L_{\xi, \eta}^{1}\right.$ and $\left.\|u\|_{Y}<\infty\right\}$ endowed with the norm

$$
\|u\|_{Y}:=\|u\|_{L_{T}^{\infty} E}+\|u\|_{L_{T, x, y}^{\infty}}+\|\hat{u}\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}}
$$

Let us verify $\Phi$ is a contraction map in $Y$. Firstly, we show $\Phi$ is a map in $Y$. Suppose that $u_{0} \in B_{\delta}(E), \hat{u}_{0} \in B_{\delta}\left(L_{\xi, \eta}^{1}\right)$ and $u \in B_{r}(Y)$. Then by $\widehat{S(t) u_{0}}=e^{-i t\left(\xi^{2}+|\eta|\right)} \hat{u}_{0}$, it is clear that

$$
\begin{align*}
\left\|S(t) u_{0}\right\|_{Y} & =\left\|S(t) u_{0}\right\|_{L_{T}^{\infty} E}+\left\|S(t) u_{0}\right\|_{L_{T, x, y}^{\infty}}+\left\|\widehat{S(t) u_{0}}\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \\
& \leqslant\left\|u_{0}\right\|_{E}+2\left\|\hat{u}_{0}\right\|_{L_{\xi, \eta}^{1}} \leqslant 3 \delta \tag{2.2}
\end{align*}
$$

The Duhamel term is estimated as follows. Since $S$ is the unitary operator in $L_{x, y}^{2}\left(\mathbb{R}^{2}\right)$ and $p=2 k+1, k \in \mathbb{N}$, we obtain

$$
\begin{align*}
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u\right)(\tau) \mathrm{d} \tau\right\|_{L_{T}^{\infty} E} & \leqslant \int_{0}^{T}\left\|S(t-\tau)\left(|u|^{p-1} u\right)(\tau)\right\|_{L_{T}^{\infty} E} \mathrm{~d} \tau \\
& \leqslant C T\left\||u|^{p-1} u\right\|_{L_{T}^{\infty} E} \\
& \leqslant C T\|u\|_{L_{T, x, y}^{\infty}}^{p-1}\|u\|_{L_{T}^{\infty} E} \leqslant C T r^{p} \tag{2.3}
\end{align*}
$$

By $p=2 k+1, k \in \mathbb{N}$ and the Young inequality, we have

$$
\begin{equation*}
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u\right)(\tau) \mathrm{d} \tau\right\|_{L_{T, x, y}^{\infty}} \leqslant C T \| \widehat{\left.u\right|^{p-1} u\left\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \leqslant C T\right\| \hat{u} \|_{L_{T}^{\infty} L_{\xi, \eta}^{1}}^{p} \leqslant C T r^{p} . . . . .} \tag{2.4}
\end{equation*}
$$

Again by $p=2 k+1, k \in \mathbb{N}$ and the Young inequality lead

$$
\begin{equation*}
\left\|\int_{0}^{t} e^{-i(t-\tau)\left(\xi^{2}+|\eta|\right)}\left|\widehat{\left.u\right|^{p-1} u}(\tau) \mathrm{d} \tau\left\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \leqslant C T\right\|\right| \widehat{\left.u\right|^{p-1} u}\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \leqslant C T r^{p} \tag{2.5}
\end{equation*}
$$

From (2.2)-(2.5), if we take $\delta, T>0$ such that $3 \delta \leqslant \frac{1}{2} r$ and $3 C T r^{p} \leqslant \frac{1}{2} r$, then $\Phi$ is a map in $Y$.
Next, we show the contraction of $\Phi$. Set $u, v \in B_{r}(Y)$. Then from $p=2 k+1, k \in \mathbb{N}$, we have

$$
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u-|v|^{p-1} v\right)(\tau) \mathrm{d} \tau\right\|_{L_{T}^{\infty} E} \leqslant C T\left\||u|^{2 k} u-|v|^{2 k} v\right\|_{L_{T}^{\infty} E} .
$$

By induction, we easily check

$$
\left\||u|^{2 k} u-|v|^{2 k} v\right\|_{L_{T}^{\infty} E} \leqslant(2 k+1)^{2} r^{2 k}\|u-v\|_{L_{T}^{\infty} E \cap L_{T, x, y}^{\infty}}
$$

Hence we obtain

$$
\begin{align*}
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u-|v|^{p-1} v\right)(\tau) \mathrm{d} \tau\right\|_{L_{T}^{\infty} E} & \leqslant C T(2 k+1)^{2} r^{2 k}\|u-v\|_{L_{T}^{\infty} E \cap L_{T, x, y}^{\infty}} \\
& \leqslant C T(2 k+1)^{2} r^{2 k}\|u-v\|_{Y} \tag{2.6}
\end{align*}
$$

From $p=2 k+1, k \in \mathbb{N}$, we have

$$
\begin{equation*}
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u-|v|^{p-1} v\right)(\tau) \mathrm{d} \tau\right\|_{L_{T, x, y}^{\infty}} \leqslant C T\left\|\mathcal{F}_{x, y}\left[|u|^{2 k} u-|v|^{2 k} v\right]\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \tag{2.7}
\end{equation*}
$$

By induction and the Young inequality, we see

$$
\begin{equation*}
\left\|\mathcal{F}_{x, y}\left[|u|^{2 k} u-|v|^{2 k} v\right]\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \leqslant(2 k+1) r^{2 k}\|\hat{u}-\hat{v}\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \tag{2.8}
\end{equation*}
$$

From (2.7) and (2.8), we have

$$
\begin{equation*}
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u-|v|^{p-1} v\right)(\tau) \mathrm{d} \tau\right\|_{L_{T, x, y}^{\infty}} \leqslant C T(2 k+1)^{2} r^{2 k}\|u-v\|_{Y} \tag{2.9}
\end{equation*}
$$

From (2.7)-(2.9), we also obtain

$$
\begin{align*}
\left\|\int_{0}^{t} e^{-i(t-\tau)\left(\xi^{2}+|\eta|\right)} \mathcal{F}_{x, y}\left[|u|^{p-1} u-|v|^{p-1} v\right](\tau) \mathrm{d} \tau\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} & \leqslant C T\left\|\mathcal{F}_{x, y}\left[|u|^{p-1} u-|v|^{p-1} v\right]\right\|_{L_{T}^{\infty} L_{\xi, \eta}^{1}} \\
& \leqslant C T(2 k+1)^{2} r^{2 k}\|u-v\|_{Y} \tag{2.10}
\end{align*}
$$

Collecting (2.6), (2.9), (2.10) and taking $T>0$ such that $3 C T(2 k+1)^{2} r^{2 k}=\frac{1}{2}$, then

$$
\left\|\int_{0}^{t} S(t-\tau)\left(|u|^{p-1} u-|v|^{p-1} v\right)(\tau) \mathrm{d} \tau\right\|_{Y} \leqslant \frac{1}{2}\|u-v\|_{Y}
$$

Therefore $\Phi: Y \rightarrow Y$ is a contraction map. Thus by the fixed point argument, we have the desired result.
