# Adaptive guaranteed lower eigenvalue bounds with optimal convergence rates

#### Abstract

Guaranteed lower Dirichlet eigenvalue bounds (GLB) can be computed for the $m$-th Laplace operator with a recently introduced extra-stabilized nonconforming Crouzeix-Raviart ( $m=1$ ) or Morley ( $m=2$ ) finite element eigensolver. Striking numerical evidence for the superiority of a new adaptive eigensolver motivates the convergence analysis in this paper with a proof of optimal convergence rates of the GLB towards a simple eigenvalue. The proof is based on (a generalization of) known abstract arguments entitled as the axioms of adaptivity. Beyond the known a priori convergence rates, a medius analysis is enfolded in this paper for the proof of best-approximation results. This and subordinated $L^{2}$ error estimates for locally refined triangulations appear of independent interest. The analysis of optimal convergence rates of an adaptive mesh-refining algorithm is performed in 3 D and highlights a new version of discrete reliability.


## 1. Introduction

Motivation. Guaranteed lower Dirichlet eigenvalue bounds (GLB) can be computed for the $m$-th Laplace operator from a global postprocessing of respective nonconforming finite element eigensolvers like the Crouzeix-Raviart resp. Morley finite element method (FEM) for $m=1$ resp. $m=2$ [CG14a, CG14b]. The maximal mesh-size $h_{\text {max }}$ enters as an explicit parameter and this can be non-effective for an imperative adaptive mesh-refinement. This has recently motivated the design of extra-stabilized nonconforming finite element eigensolvers for $m=1,2$ that directly compute GLB under moderate mesh-size restrictions and allow an efficacious adaptive mesh-refinement [CZZ20, CEP21, CP21]. The striking superiority of those adaptive schemes has been displayed in numerical experiments in [CEP21, CP21] and motivates the mathematical analysis of optimal convergence rates in this paper. This appears to be the first method that combines the localization of eigenvalues as GLB with their efficient approximation.
Model problem. The continuous eigenvalue problem (EVP) seeks eigenpairs $(\lambda, u) \in \mathbb{R}^{+} \times$ ( $V \backslash\{0\}$ ) with

in the Hilbert space $V:=H_{0}^{m}(\Omega)$ and its energy scalar product $a(\cdot, \bullet):=\left(D^{m} \bullet, D^{m} \bullet\right)_{L^{2}(\Omega)}$ with the gradient $D^{1}:=\nabla$ or the Hessian $D^{2}$ and the $L^{2}$ scalar product $b(\cdot, \cdot):=(\cdot, \cdot)_{L^{2}(\Omega)}$

[^0]on a bounded polyhedral Lipschitz domain $\Omega \subset \mathbb{R}^{3}$. The infinite but countably many eigenvalues $0<\lambda_{1} \leqslant \lambda_{2} \leqslant \ldots$ with $\lim _{j \rightarrow \infty} \lambda_{j}=\infty$ in (1.1) are enumerated in ascending order counting multiplicities [BO91, Bof10].
Discretization. The discrete space $\boldsymbol{V}_{\boldsymbol{h}}=P_{m}(\mathcal{T}) \times V(\mathcal{T}) \subset P_{m}(\mathcal{T}) \times P_{m}(\mathcal{T})$ consists of piecewise polynomials of degree at most $m$ on the shape-regular triangulation $\mathcal{T}$ of $\Omega \subset \mathbb{R}^{3}$ into closed tetrahedra. Throughout this paper, $V(\mathcal{T})$ abbreviates the Crouzeix-Raviart finite element space $C R_{0}^{1}(\mathcal{T})$ [CR73] for $m=1$ and the Morley finite element space $M(\mathcal{T})$ [Mor68, MX06] for $m=2$. The algebraic eigenvalue problem seeks eigenpairs $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right) \in \mathbb{R}^{+} \times\left(\boldsymbol{V}_{\boldsymbol{h}} \backslash\{0\}\right)$ with

The discrete scalar product $\boldsymbol{a}_{\boldsymbol{h}}$ contains the scalar product $a_{\mathrm{pw}}(\bullet, \bullet):=\left(D_{\mathrm{pw}}^{m} \bullet, D_{\mathrm{pw}}^{m} \cdot\right)_{L^{2}(\Omega)}$ of the piecewise derivatives of order $m$ and some stabilization with explicit (known) constant $\kappa_{m}>0$ from [CP21], while the bilinear form $\boldsymbol{b}_{\boldsymbol{h}}$ is the $L^{2}$ scalar product $b(\cdot, \cdot)$ of the piecewise polynomial components,

The piecewise constant mesh-size function $h_{\mathcal{T}} \in P_{0}(\mathcal{T})$ has the value $\left.h_{\mathcal{T}}\right|_{T}=h_{T}:=\operatorname{diam}(T)$ in each tetrahedron $T \in \mathcal{T}$ and $h_{\max }:=\max _{T \in \mathcal{T}} h_{T}$ denotes the maximal mesh-size. The $M:=\operatorname{dim}\left(P_{m}(\mathcal{T})\right)$ finite discrete eigenvalues of (1.2) are enumerated in ascending order $0<\lambda_{h}(1) \leqslant \lambda_{h}(2) \leqslant \cdots \leqslant \lambda_{h}(M)<\infty$ counting multiplicity.
GLB. For the biharmonic operator $(m=2)$ the discrete eigenvalue problem (1.2) is analysed in [CP21]. For the Laplace operator $(m=1)$ in 2D, (1.2) describes the lowest-order skeleton method in [CZZ20]; for 3D it is different and suggested in [CP21]. The discrete eigenvalue problem (1.2) directly computes guaranteed lower bounds [CP21, Thm. 1.1] in that

AFEM. The adaptive algorithm [Dör96, MNS02, CFPP14, CR17] is based on the refinement indicator $\eta(T)$ defined in (1.4) below for any triangulation $\mathcal{T}$ and any tetrahedron $T \in \mathcal{T}$. Let $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right) \in \mathbb{R}^{+} \times \boldsymbol{V}_{\boldsymbol{h}}$ denote the $k$-th eigenpair of (1.2) with $\lambda_{h}:=\lambda_{h}(k)$ and $\boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right) \in$ $\boldsymbol{V}_{\boldsymbol{h}}$. For any tetrahedron $T \in \mathcal{T}$ with volume $|T|$ and set of faces $\mathcal{F}(T)$, the local estimator contribution $\eta^{2}(T)=(\eta(T))^{2}$ reads

with the tangential components $\left[D_{\mathrm{pw}}^{m} u_{\mathrm{nc}}\right]_{F} \times \nu_{F}$ of the jump [ $\left.D_{\mathrm{pw}}^{m} u_{\mathrm{nc}}\right]_{F}$ along any face $F \in$ $\mathcal{F}(T)$ and the (piecewise) gradient $D_{\mathrm{pw}}^{1}=\nabla_{\mathrm{pw}}(m=1)$ or Hessian $D_{\mathrm{pw}}^{2}(m=2)$. Let $\mathbb{T}:=\mathbb{T}\left(\mathcal{T}_{0}\right)$ denote the set of all admissible regular triangulations computed by successive newest-vertex bisection (NVB) [Ste08, GSS14] of a regular initial triangulation $\mathcal{T}_{0}$ of $\Omega \subset \mathbb{R}^{3}$. The AFEM algorithm with Dörfler marking and newest-vertex bisection abbreviates $\eta_{\ell}(T)$ for any $T \in$ $\mathcal{T}:=\mathcal{T}_{\ell} \in \mathbb{T}$ and $\eta_{\ell}^{2}:=\eta^{2}\left(\mathcal{T}_{\ell}\right):=\sum_{T \in \mathcal{T}_{\ell}} \eta_{\ell}^{2}(T)$. The selection of the set $\mathcal{M}_{\ell}$ in the step Mark of AFEM4EVP with minimal cardinality is possible at linear cost [PP20].

Optimal convergence rates. The optimal convergence rates of AFEM4EVP in the error estimator means that the outputs $\left(\mathcal{T}_{\ell}\right)_{\ell \in \mathbb{N}_{0}}$ and $\left(\eta_{\ell}\right)_{\ell \in \mathbb{N}_{0}}$ of AFEM4EVP satisfy

for any $s>0$ and the counting measure $|\cdot|=\operatorname{card}(\cdot)$. In other words, if the estimator $\eta(\mathcal{T})$ converges with rate $s>0$ for some optimal selection of triangulations $\mathcal{T} \in \mathbb{T}$, then the output $\eta_{\ell}$ of AFEM4EVP converges with the same rate.

Theorem 1.1 (rate optimality of AFEM4EVP). Suppose that $\lambda_{k}=\lambda$ is a simple eigenvalue of (1.1), then there exist $\varepsilon>0$ and $0<\theta_{0}<1$ such that $\mathcal{T}_{0} \in \mathbb{T}(\varepsilon):=\left\{\mathcal{T} \in \mathbb{T}: h_{\max }:=\right.$ $\left.\max _{T \in \mathcal{T}} h_{T} \leqslant \varepsilon\right\}$ and $\theta$ with $0<\theta \leqslant \theta_{0}$ imply (1.5) for any $s>0$.

At first glance the discrete problem (1.2) involves a stabilization that is expected to generate the additional term $\kappa_{m}^{-2}|T|^{-2 m / 3}\left\|u_{\mathrm{pw}}-u_{\mathrm{nc}}\right\|_{L^{2}(T)}^{2}$ in the error estimator (1.4). The negative power of the mesh-size in the latter term prevents a reduction property [MNS02, CFPP14, CR17] and has to be circumvented. The only other known affirmative result for optimal convergence rates of an adaptive algorithm with stabilization (and negative powers of the mesh-size in the discrete problem) is [BN10] on discontinuous Galerkin (dG) schemes. An over-penalization therein diminishes the influence of the stabilization and eventually shows the dominance of the remaining a posteriori error terms. In the present case, the stabilization parameter $\kappa_{m}$ is fixed to maintain the GLB property and this requires a different argument: Since (1.2) is equivalent to a rational eigenvalue problem for a nonconforming scheme, a careful perturbation analysis eventually shows efficiency and reliability of the nonconforming error estimator (1.4) for sufficiently small mesh-sizes. The verification requires a medius analysis [Gud10], which applies arguments from a posteriori error analysis (e.g., efficiency in (3.10) below) in an a priori error analysis.

Outline. The remaining parts of this paper are devoted to the proof of Theorem 1.1 and are organized as follows. A general interpolation operator $I$ and a right-inverse $J$ in Section 2 allow for a simultaneous analysis for $m=1$ and $m=2$ in the Crouzeix-Raviart and Morley FEM. The medius analysis in Section 3 provides new best-approximation results and thereby prepares the proof of Theorem 1.1 in Section 4-5. The proof of the optimal convergence rates requires a framework extended from [CFPP14, CR17] in Appendix A.

The results hold in 2D and 3D and are presented in 3D for brevity.

## 2. Preliminaries

This section summarizes abstract conditions (I1)-(I4) on an interpolation operator $I: V \rightarrow$ $V(\mathcal{T})$ and (J1)-(J4) on a right inverse $J: V(\mathcal{T}) \rightarrow V$. The conditions hold for the CrouzeixRaviart and the Morley finite element space in the two model examples for the Laplacian $m=1$ and the bi-Laplacian $m=2$.

### 2.1. Notation

Standard notation on Lebesgue and Sobolev spaces applies throughout this paper; $(\cdot, \cdot)_{L^{2}(\Omega)}$ abbreviates the $L^{2}$ scalar product and $H^{m}(T)$ abbreviates $H^{m}(\operatorname{int}(T))$ for a tetrahedron $T \in$ $\mathcal{T}$. The vector space $H^{m}(\mathcal{T}):=\left\{v \in L^{2}(\Omega):\left.v\right|_{T} \in H^{m}(T)\right\}$ consists of piecewise $H^{m}$ functions and is equipped with the semi-norm $\|\bullet \bullet\|_{\mathrm{pw}}^{2}:=\left(D_{\mathrm{pw}}^{m} \bullet, D_{\mathrm{pw}}^{m} \bullet\right)_{L^{2}(\Omega)}$. The piecewise gradient $D_{\mathrm{pw}}^{1}$ or piecewise Hessian $D_{\mathrm{pw}}^{2}$ is understood with respect to the (non-displayed) regular triangulation $\mathcal{T} \in \mathbb{T}$ of the bounded polyhedral Lipschitz domain $\Omega \subset \mathbb{R}^{3}$ into tetrahedra. The triangulation $\mathcal{T}$ is computed by successive newest-vertex bisection (NVB) [Ste08, GSS14] of a regular initial triangulation $\mathcal{T}_{0}$ (plus some initialization of tagged tetrahedra) of $\Omega \subset \mathbb{R}^{3}$. The set $\mathbb{T}:=\mathbb{T}\left(\mathcal{T}_{0}\right)$ of all admissible triangulations is (uniformly) shape-regular. For any $\mathcal{T} \in \mathbb{T}$, let $\mathbb{T}(\mathcal{T})$ abbreviate the set of all admissible refinements of $\mathcal{T}$. For any $0<\varepsilon<1$ let $\mathbb{T}(\varepsilon):=\{\mathcal{T} \in$ $\left.\mathbb{T}: h_{\max }:=\max _{T \in \mathcal{T}} h_{T} \leqslant \varepsilon\right\}$ denote the set of all admissible triangulations with maximal mesh-size $h_{\max } \leqslant \varepsilon$. The context-depending notation $|\cdot|$ denotes the Euclidean length of a vector, the cardinality of a finite set, as well as the non-trivial three-, two-, or one-dimensional Lebesgue measure of a subset of $\mathbb{R}^{3}$. For any positive, piecewise polynomial $\varrho \in P_{k}(\mathcal{T})$ with $\varrho \geqslant 0, k \in \mathbb{N}_{0},(\cdot, \cdot)_{\varrho}:=(\varrho \cdot, \cdot)_{L^{2}(\Omega)}$ abbreviates the weighted $L^{2}$ scalar product with induced $\varrho$-weighted $L^{2}$ norm $\|\cdot\|_{\varrho}:=\left\|\varrho^{1 / 2} \bullet\right\|_{L^{2}(\Omega)}$. The discrete space $P_{m}(\mathcal{T}):=\left\{p_{m} \in L^{2}(\Omega):\left.p_{m}\right|_{T} \in\right.$ $P_{m}(T)$ is a polynomial of degree at most $m$ for any $\left.T \in \mathcal{T}\right\}$ consists of piecewise polynomials, the spaces $C R_{0}^{1}(\mathcal{T})$ resp. $M(\mathcal{T})$ will be defined in Subsection 2.4.1 resp. 2.4.2 below. Given a function $v \in L^{2}(\omega)$, define the integral mean $f_{\omega} v \mathrm{~d} x:=1 /|\omega| \int_{\omega} v \mathrm{~d} x$. The $L^{2}$ projection $\Pi_{0}$ onto the piecewise constant functions $P_{0}(\mathcal{T})$ reads $\left.\left(\Pi_{0} f\right)\right|_{T}:=f_{T} f \mathrm{~d} x$ for all $f \in L^{2}(\Omega)$ and $T \in \mathcal{T}$. Let $\sigma:=\min \left\{1, \sigma_{\mathrm{reg}}\right\}$ denote the minimum of one and the index of elliptic regularity $\sigma_{\text {reg }}>0$ for the source problem of the $m$-Laplacian $(-1)^{m} \Delta^{m}$ in $H_{0}^{m}(\Omega)$ : Given any right-hand side $f \in L^{2}(\Omega)$, the weak solution $u \in V$ to $(-1)^{m} \Delta^{m} u=f$ satisfies

(This is well-established for $m=1$ [Neč67, GT83, Dau88, Gri92, Agm10] and $m=2$ in 2D [BR80] with $\sigma_{\text {reg }}>1 / 2$ and otherwise a hypothesis throughout this paper.) The Sobolev space $H^{m+s}(\Omega)$ is defined for $0<s<1$ by complex interpolation of $H^{m}(\Omega)$ and $H^{m+1}(\Omega), m \in \mathbb{N}_{0}$. Throughout this paper, $a \lesssim b$ abbreviates $a \leqslant C b$ with a generic constant $C$ depending on $\sigma$ in (2.1) and the shape-regularity of $\mathcal{T} \in \mathbb{T}$ only; $a \approx b$ stands for $a \lesssim b \lesssim a$.

### 2.2. Interpolation

The operators $I$ and $J$ concern the (nonconforming) discrete space $V(\mathcal{T}) \subset P_{m}(\mathcal{T})$ and $V:=H_{0}^{m}(\Omega)$ for an admissible triangulation $\mathcal{T} \in \mathbb{T}$. An advantage of separate interest is that the analysis with $I$ and $J$ is performed simultaneously for $m \geqslant 1$, while the examples in Subsection 2.4 below concern $m=1,2$.
Suppose that, for each admissible triangulation $\mathcal{T} \in \mathbb{T}$, there exists a linear interpolation operator $I$ onto $V(\mathcal{T})$ that is defined on $V+V(\widehat{\mathcal{T}})$ for any refinement $\hat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$ and that satisfies the following properties with universal positive constants $\kappa_{m}$ and $\kappa_{d}$; in all examples below $\kappa_{m}$ is known and the existence of $\kappa_{d}$ is clarified.
(I1) Any $T \in \mathcal{T}$ and $v \in H^{m}(T)$ satisfy $\|v-I v\|_{L^{2}(T)} \leqslant \kappa_{m} h_{T}^{m}|v-I v|_{H^{m}(T)}$.
(I2) The piecewise derivative $D_{\mathrm{pw}}^{m}$ of any $v \in V+V(\hat{\mathcal{T}})$ satisfies $D_{\mathrm{pw}}^{m} I v=\Pi_{0} D_{\mathrm{pw}}^{m} v$.
(I3) The operator $I$ acts as identity in non-refined tetrahedra in that $\left.(1-I) \widehat{v}_{\mathrm{nc}}\right|_{T}=0$ in $T \in$ $\mathcal{T} \cap \hat{\mathcal{T}}$ for all $\widehat{v}_{\text {nc }} \in V(\hat{\mathcal{T}})$. The interpolation operator $\hat{I}$ associated with $V(\hat{\mathcal{T}})$ satisfies $I \circ \hat{I}=I$ in $V+V(\hat{\mathcal{T}})$.
(I4) Any $T \in \mathcal{T}$ and $\hat{v}_{\text {nc }} \in V(\hat{\mathcal{T}})$ satisfy $\left\|\hat{v}_{\mathrm{nc}}-I \hat{v}_{\mathrm{nc}}\right\|_{L^{2}(T)} \leqslant \kappa_{d} h_{T}^{m}\left|\hat{v}_{\mathrm{nc}}-I \hat{v}_{\mathrm{nc}}\right|_{H^{m}(T)}$.
Corollary 2.1 (properties of I). (a) Given $\hat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$, any $v \in V+V(\widehat{\mathcal{T}})$ and $w_{\mathrm{nc}} \in V(\mathcal{T})$ satisfy $a_{\mathrm{pw}}\left(v-I v, w_{\mathrm{nc}}\right)=0$ and $\|v-I v\|_{\mathrm{pw}}=\min _{v_{\mathrm{nc}} \in V(\mathcal{T})}\left\|v-v_{\mathrm{nc}}\right\|_{\mathrm{pw}}$.
(b) Any $v \in H^{m+s}(\Omega)$ with $1 / 2<s \leqslant 1$ satisfies $\|(1-I) v\|_{\mathrm{pw}} \leqslant\left(h_{\max } / \pi\right)^{s}\|v\|_{H^{m+s}(\Omega)}$.
(c) Any $v, w \in V$ and $v_{\mathrm{nc}} \in V(\mathcal{T})$ satisfy $a_{\mathrm{pw}}\left(v, v_{\mathrm{nc}}\right)=a_{\mathrm{pw}}\left(I v, v_{\mathrm{nc}}\right)$ and $a_{\mathrm{pw}}(v,(1-I) w)=a_{\mathrm{pw}}((1-I) v,(1-I) w) \leqslant \min _{v_{\mathrm{nc}} \in V(\mathcal{T})}\left\|v-v_{\mathrm{nc}}\right\|_{\mathrm{pw}} \min _{w_{\mathrm{nc}} \in V(\mathcal{T})}\left\|w-w_{\mathrm{nc}}\right\|_{\mathrm{pw}}$.
(d) Any $w \in V$ and $v \in V+V(\mathcal{T})$ satisfy
$b(v,(1-I) w) \leqslant\left\|h_{\mathcal{T}}^{m} v\right\|_{L^{2}(\Omega)}\left\|h_{\mathcal{T}}^{-m}(1-I) w\right\|_{L^{2}(\Omega)} \leqslant \kappa_{m}\left\|h_{\mathcal{T}}^{m} v\right\|_{L^{2}(\Omega)} \min _{w_{\mathrm{nc}} \in V(\mathcal{T})}\left\|w-w_{\mathrm{nc}}\right\|_{\mathrm{pw}}$.
Proof. Since $D_{\mathrm{pw}}^{m} w_{\mathrm{nc}} \in P_{0}\left(\mathcal{T} ; \mathbb{R}^{3^{m}}\right)$, (I2) implies (a). In combination with a piecewise Poincaré inequality, (I2) implies (b) (see [CP21, Cor. 2.2.a] for details). The first claim in (c) follows from (a). The combination of (a) with the Cauchy-Schwarz inequality proves (c). The CauchySchwarz inequality, the approximation property (I1), and (c) conclude the proof of (d).

### 2.3. Conforming companion

Given any tetrahedron $T \in \mathcal{T}$ in a triangulation $\mathcal{T} \in \mathbb{T}$, let $\mathcal{V}(T)$ denote the set of its vertices ( 0 -subsimplices) and let $\mathcal{F}(T)$ denote the set of its faces ( 2 -subsimplices). A linear operator $J: V(\mathcal{T}) \rightarrow V$ is called conforming companion if (J1)-(J4) hold with universal constants $M_{1}, M_{2}, M_{4}$ (that exclusively depend on $\mathbb{T}$ ).
(J1) $J$ is a right inverse to the interpolation $I$ in the sense that $I \circ J=1$ in $V(\mathcal{T})$.

& \left\|h_{\mathcal{T}}^{-m}(1-J) v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}+\left\|(1-J) v_{\mathrm{nc}}\right\|_{\mathrm{pw}} \leqslant\left(M_{1} \sum_{T \in \mathcal{T}}|T|^{1 / 3} \sum_{F \in \mathcal{F}(T)}\left\|\left[D_{\mathrm{pw}}^{m} v_{\mathrm{nc}}\right]_{F} \times \nu_{F}\right\|_{L^{2}(F)}^{2}\right)^{1 / 2}  \tag{J2}\\
& \leqslant M_{2} \min _{v \in V}\left\|v_{\mathrm{nc}}-v\right\|_{\mathrm{pw}} \text { for any } v_{\mathrm{nc}} \in V(\mathcal{T}) .
\end{align*}
$$

(J3) $(1-J)(V(\mathcal{T})) \perp P_{m}(\mathcal{T})$ holds in $L^{2}(\Omega)$.
(J4) $\left|v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right|_{H^{m}(K)}^{2} \leqslant M_{4} \sum_{T \in \mathcal{T}(\Omega(K))}|T|^{1 / 3} \sum_{F \in \mathcal{F}(T)}\left\|\left[D_{\mathrm{pw}}^{m} v_{\mathrm{nc}}\right]_{F} \times \nu_{F}\right\|_{L^{2}(F)}^{2}$ holds for any $v_{\mathrm{nc}} \in$ $V(\mathcal{T})$ and $K \in \mathcal{T}$ with the $\operatorname{set} \mathcal{T}(\Omega(K)):=\{T \in \mathcal{T}: \operatorname{dist}(T, K)=0\}$ of adjacent tetrahedra.

The properties (J1)-(J4) [CGS15, Gal15a, CP21] are stated for convenient quotation throughout this paper. The localized version (J4) applies at the very end (in Theorem 4.6) and implies parts of (J2). The second inequality in (J2) is the efficiency of a posteriori error estimators.

Remark 2.2 (on (J4)) For any refinement $\hat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$ of a triangulation $\mathcal{T} \in \mathbb{T}$, let $\mathcal{R}_{1}:=\{K \in$ $\mathcal{T}: \exists T \in \mathcal{T} \backslash \widehat{\mathcal{T}}$ with $\operatorname{dist}(K, T)=0\} \subset \mathcal{T}$ denote the set of coarse but not fine tetrahedra plus one layer of coarse tetrahedra around. Then (J4) and a finite overlap argument imply the existence of $M_{5}>0$ such that any $v_{\mathrm{nc}} \in V(\mathcal{T})$ satisfies

The superset $\mathcal{R}_{1}$ of $\mathcal{T} \backslash \hat{\mathcal{T}}$ serves as a simple example and could indeed be replaced by $\mathcal{T} \backslash \hat{\mathcal{T}}$ provided $J$ may depend on $\widehat{\mathcal{T}}$; cf. [CP20, $\S 6]$ for details in the two model problems below.

Corollary 2.3 (properties of $\boldsymbol{J}$ ). Any $w \in V$ and $v_{\mathrm{nc}} \in V(\mathcal{T})$ satisfy
(a) $\left\|v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=\left\|(1-I) J v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant \kappa_{m}\left\|h_{\mathcal{T}}^{m}\left(v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right)\right\|_{\mathrm{pw}}$

$$
\leqslant h_{\max }^{m} \kappa_{m} M_{2} \min _{v \in V}\| \| v_{\mathrm{nc}}-v \|_{\mathrm{pw}}
$$

(b) $b\left(w, v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right)=b\left(w-I w, v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right) \leqslant\|w-I w\|_{L^{2}(\Omega)}\left\|v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$

\leqslant h_{\max }^{2 m} \kappa_{m}^{2} M_{2} \min _{w_{\mathrm{nc}} \in V(\mathcal{T})}\| \| w-w_{\mathrm{nc}}\left\|_{\mathrm{pw}} \min _{v \in V}\right\|\left\|v_{\mathrm{nc}}-v\right\|_{\mathrm{pw}}

(c) $a_{\mathrm{pw}}\left(w, v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right)=a_{\mathrm{pw}}\left(w-I w, v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right) \leqslant\|w-I w\|_{\mathrm{pw}}\left\|v_{\mathrm{nc}}-J v_{\mathrm{nc}}\right\|_{\mathrm{pw}}$ $\leqslant M_{2} \min _{w_{\mathrm{nc}} \in V(\mathcal{T})}\left\|w-w_{\mathrm{nc}}\right\|_{\mathrm{pw}} \min _{v \in V}\| \| v-v_{\mathrm{nc}} \|_{\mathrm{pw}}$.

Proof. The combination of (J1), (I1), and (J2) proves (a). The claim (b) follows from (J3), the Cauchy-Schwarz inequality, (I1), and (a). Corollary 2.1.c and (J1)-(J2) lead to (c).

### 2.4. Examples

Two examples for $V(\mathcal{T}) \subset P_{m}(\mathcal{T})$ are analysed simultaneously in this paper for $m=1,2$. It is appealing to follow our methodology for $m \geqslant 3$ [WX13] in future research.

### 2.4.1. Crouzeix-Raviart finite elements for the Laplacian ( $m=1$ )

Given the shape-regular triangulation $\mathcal{T} \in \mathbb{T}$, let $\mathcal{F}$ (resp. $\mathcal{F}(\Omega)$ or $\mathcal{F}(\partial \Omega)$ ) denote the set of all (resp. interior or boundary) faces. Throughout this paper, the model problem with $m=1$ approximates the Dirichlet eigenvectors $u \in H_{0}^{1}(\Omega)$ of the Laplacian $-\Delta u=\lambda u$ in the Crouzeix-Raviart finite element space [CR73]

V(\mathcal{T}):=C R_{0}^{1}(\mathcal{T}):=\left\{v \in P_{1}(\mathcal{T}):\right. & v \text { is continuous at } \operatorname{mid}(F) \text { for all } F \in \mathcal{F}(\Omega) \text { and } \\
& v(\operatorname{mid}(F))=0 \text { for all } F \in \mathcal{F}(\partial \Omega)\} .
\end{aligned}
$$

Given the face-oriented basis functions $\psi_{F} \in C R^{1}(\mathcal{T})$ with $\psi_{F}(\operatorname{mid}(E))=\delta_{E F}$ for all faces $E, F \in \mathcal{F}$ ( $\delta_{E F}$ is Kronecker's delta), the standard interpolation operator reads

I_{\mathrm{CR}}(v):=\sum_{F \in \mathcal{F}(\Omega)}\left(f_{F} v \mathrm{~d} \sigma\right) \psi_{F} \quad \text { for any } v \in H_{0}^{1}(\Omega)+C R_{0}^{1}(\widehat{\mathcal{T}})
$$

The interpolation operator $I_{\text {CR }}$ satisfies (I1)-(I4) with $\kappa_{1}:=\sqrt{1 / \pi^{2}+1 / 120}$, see [CP20, Sec. 4.2-4.4] and the references therein. The constant $\kappa_{1}$ is provided in [CG14a, CG14b, CZZ20]. The design of the conforming companion $J: C R_{0}^{1}(\mathcal{T}) \rightarrow S_{0}^{5}(\mathcal{T}):=P_{5}(\mathcal{T}) \cap C_{0}(\Omega)$ with (J1)(J4) is a straightforward generalization of [CGS15, Prop. 2.3] to 3D. The arguments in [CGS15, Prop. 2.3] can be localized [CEHL12, Thm. 5.1] and lead with [CBJ02, Thm. 3.2],[CGS13, Thm. 4.9] to (J2) and (J4).

### 2.4.2. Morley finite elements for the bi-Laplacian ( $m=2$ )

Given the shape-regular triangulation $\mathcal{T} \in \mathbb{T}$, let $\mathcal{E}$ (resp. $\mathcal{E}(\Omega)$ or $\mathcal{E}(\partial \Omega)$ ) denote the set of all (resp. interior or boundary) edges. Let $\mathcal{F}(E):=\{F \in \mathcal{F}: E \subset \bar{F}\}$ denote the set of all faces containing the edge $E \in \mathcal{E}$. For any face $F \in \mathcal{F}$, let $\nu_{F}$ denote the unit normal with fixed orientation and $[\cdot]_{F}$ the jump across $F$. The model problem with $m=2$ approximates the Dirichlet eigenvectors $u \in H_{0}^{2}(\Omega)$ of the bi-Laplacian $\Delta^{2} u=\lambda u$ in the discrete Morley finite element space [Mor68, MX06]

V(\mathcal{T}):=M(\mathcal{T}):=\left\{v \in P_{2}(\mathcal{T}):\right. & f_{E}[v]_{F} \mathrm{~d} s=0 \text { for all } E \in \mathcal{E} \text { and } F \in \mathcal{F}(E) \\
& \text { and } \left.f_{F}[\nabla v]_{F} \cdot \nu_{F} \mathrm{~d} \sigma=0 \text { for all } F \in \mathcal{F}\right\}
\end{aligned}
$$

Given the nodal basis functions $\Phi_{E}, \Phi_{F}$ for any $E \in \mathcal{E}$ and $F \in \mathcal{F}$ (see [CP21, Eq. (2.1)-(2.2)] for details), the standard interpolation operator [CG14a, Gal15a, CP20, CP21] reads

I_{M}(v):=\sum_{E \in \mathcal{E}(\Omega)}\left(f_{E} v \mathrm{~d} s\right) \phi_{E}+\sum_{F \in \mathcal{F}(\Omega)}\left(f_{F} \nabla v \cdot \nu_{F} \mathrm{~d} \sigma\right) \phi_{F} \quad \text { for any } v \in H_{0}^{2}(\Omega)+M(\hat{\mathcal{T}})
$$

The operator $I_{M}$ satisfies (I1)-(I4) with $\kappa_{2}:=\kappa_{1} / \pi+\sqrt{\left(3 \kappa_{1}^{2}+2 \kappa_{1}\right) / 80}$ as discussed in [CP20, CP21]; $\kappa_{2}$ is provided in [CG14a, CP21].
There exists a conforming companion $J: M(\mathcal{T}) \rightarrow V$ based on the Hsieh-Clough-Tocher FEM [Cia78, Chap. 6] with (J1)-(J4) in [Gal15a, VZ19, CP20] in 2D and on the Worsey-Farin FEM [WF87] with (J1)-(J3) in [CP21] in 3D. Since the arguments in the proof of (J2) in [CP21, Thm. 3.1.b] are local, (J4) follows in 3D as well.

## 3. Medius analysis

This section shows that (I1)-(I2) and (J1)-(J3) lead to best-approximation and error estimates in weaker Sobolev norms.

### 3.1. Main result and layout of the proof

Throughout this paper, $k \in \mathbb{N}$ is the number of a simple exact eigenvalue $\lambda \equiv \lambda_{k}$. The aim of this section is the proof of Theorem 3.1 with $\|\bullet\|_{\delta}$ defined in (3.1) below.

Theorem 3.1 (best-approximation). Let $(\lambda, u) \in \mathbb{R}^{+} \times V$ denote the $k$-th continuous eigenpair of (1.1) with a simple eigenvalue $\lambda \equiv \lambda_{k}$ and $\|u\|_{L^{2}(\Omega)}=1$. There exist $\varepsilon_{5}>0$ and $C_{0}>0$ such that, for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right):=\left\{\mathcal{T} \in \mathbb{T}: h_{\max } \leqslant \varepsilon_{5}\right\}$, there exists a discrete eigenpair $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right) \in \mathbb{R}^{+} \times \boldsymbol{V}_{\boldsymbol{h}}$ of number $k$ of (1.2) with $\lambda_{h} \equiv \lambda_{h}(k), \boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right),\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$, and $b\left(u, u_{\mathrm{nc}}\right)>0$ such that
(a) $\lambda_{h}(k)$ is a simple algebraic eigenvalue of (3.3) with $\lambda_{k} / 2 \leqslant \lambda_{h}(k)$,
(b) $\lambda_{h}(j) \leqslant \lambda_{j}$ for all $j=1, \ldots, k+1$,
(c) $\left|\lambda-\lambda_{h}\right|+\left\|u-u_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2}+h_{\max }^{-2 \sigma}\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}^{2}+\left\|u_{\mathrm{nc}}\right\|_{\delta}^{2} \leqslant C_{0}\|u-I u\|_{\mathrm{pw}}^{2}$.

Some comments on related results and an outline of the proof of Theorem 3.1 are in order before Subsections 3.2-3.5 provide details.

Remark 3.2 (known convergence results) The analysis in [CP21] (§ 2.3 .3 for $m=1$ and Thm. 1.2 for $m=2$ ) guarantees the convergence of the eigenvalues $\lambda_{h}$ to $\lambda$ and the component $u_{\mathrm{pw}} \in P_{m}(\mathcal{T})$ to $u \in V$. The assumption that $\lambda=\lambda_{k}$ is a simple eigenvalue of (1.1) and the convergence $\lambda_{h}(k) \equiv \lambda_{h} \rightarrow \lambda$ as $h_{\max } \rightarrow 0$ lead to the existence of $\varepsilon_{0}>0$ such that the number $M:=\operatorname{dim}\left(P_{m}(\mathcal{T})\right)$ of discrete eigenvalues of (1.2) is larger than $k+1$ and $\lambda_{h}(k-1)<\lambda_{h}(k) \equiv \lambda_{h}<\lambda_{h}(k+1)$ as well as $\lambda_{k} / 2 \leqslant \lambda_{h}(k)$ for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{0}\right)$. Then the eigenfunction $\boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right) \in \boldsymbol{V}_{\boldsymbol{h}} \backslash\{0\}$ is unique.

The convergence analysis in [CP21] displays convergence of the eigenvector $u_{\mathrm{pw}} \in P_{m}(\mathcal{T})$ but not for the nonconforming component $u_{\mathrm{nc}} \in V(\mathcal{T})$. This section focusses on the convergence analysis for $u_{\mathrm{nc}} \in V(\mathcal{T})$. Recall that $k \in \mathbb{N}$ is fixed and $(\lambda, u)$ denotes the $k$-th eigenpair of (1.1) with a simple eigenvalue $\lambda \equiv \lambda_{k}>0$ and $\|u\|_{L^{2}(\Omega)}=1$. Set $\varepsilon_{1}:=\min \left\{\varepsilon_{0},\left(2 \lambda_{k+1} \kappa_{m}^{2}\right)^{-1 /(2 m)}\right\}$ and suppose $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{1}\right)$. Let $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right)$ denote the $k$-th discrete eigenpair in (1.2) with $\lambda_{h} \equiv$ $\lambda_{h}(k)>0, \boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right) \in \boldsymbol{V}_{\boldsymbol{h}},\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$, and $b\left(u, u_{\mathrm{nc}}\right) \geqslant 0$.

Proof of Theorem 3.1.a. This follows from Remark 3.2 for $\varepsilon_{1}:=\min \left\{\varepsilon_{0},\left(2 \lambda_{k+1} \kappa_{m}^{2}\right)^{-1 /(2 m)}\right\}$.
Proof of Theorem 3.1.b. The choice $\varepsilon_{1}:=\min \left\{\varepsilon_{0},\left(2 \lambda_{k+1} \kappa_{m}^{2}\right)^{-1 /(2 m)}\right\}$ implies for all $j=$ $1, \ldots, k$ that $\lambda_{j} \kappa_{m}^{2} h_{\max }^{2 m} \leqslant \lambda_{k+1} \kappa_{m}^{2} \varepsilon_{1}^{2 m}=1 / 2$. Hence (1.3) proves Theorem 3.1.b.

Remark 3.3 (weight $\delta$ ) The piecewise constant weight $\delta \in P_{0}(\mathcal{T})$ in the weighted $L^{2}$ norm $\|\cdot\|_{\delta}:=\|\sqrt{\delta} \cdot\|_{L^{2}(\Omega)}$ on the left-hand side of Theorem 3.1.c reads

\delta:=\frac{1}{1-\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}}-1=\frac{\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}}{1-\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}}=\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}(1+\delta) \in P_{0}(\mathcal{T}) . \tag{3.1}
\end{equation*}
$$

Notice that $h_{\max } \leqslant \varepsilon_{1}$ implies $\delta \leqslant \delta_{\max }:=\left(1-\lambda_{h} \kappa_{m}^{2} h_{\max }^{2 m}\right)^{-1}-1 \leqslant 1$. The constant $C_{\delta}:=2 \lambda \kappa_{m}^{2}$ satisfies $\delta \leqslant C_{\delta} h_{\mathcal{T}}^{2 m} \leqslant C_{\delta} h_{\max }^{2 m}$ (because $\lambda_{h} \leqslant \lambda$ from Theorem 3.1.b) and $\delta$ converges to zero as the maximal mesh-size $h_{\max } \rightarrow 0$ approaches zero.

Remark 3.4 (related work) This section extends the analysis in [CGS15, Section 2-3] to a simultaneous analysis of the Crouzeix-Raviart and Morley FEM and to the extra-stabilized discrete eigenvalue problem (EVP) (1.2) and to 3D.

Remark 3.5 (equivalent problem) Since $\lambda_{h} \kappa_{m}^{2} h_{\max }^{2 m} \leqslant \lambda_{k+1} \kappa_{m}^{2} \varepsilon_{1}^{2 m}=1 / 2$, (1.2) is equivalent to a reduced rational eigenvalue problem that seeks $\left(\lambda_{h}, u_{\mathrm{nc}}\right) \in \mathbb{R}^{+} \times(V(\mathcal{T}) \backslash\{0\})$ with

a_{\mathrm{pw}}\left(u_{\mathrm{nc}}, v_{\mathrm{nc}}\right)=\lambda_{h}\left(\frac{u_{\mathrm{nc}}}{1-\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}}, v_{\mathrm{nc}}\right)_{L^{2}(\Omega)} \quad \text { for all } v_{\mathrm{nc}} \in V(\mathcal{T}) \tag{3.2}

and $u_{\mathrm{pw}}=\left(1-\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}\right)^{-1} u_{\mathrm{nc}}$ [CP21, Prop. 2.5, § 2.3.3].
Outline of the proof of Theorem 3.1.c. The outline of the proof of Theorem 3.1.c provides an overview and clarifies the various steps for a reduction of $\varepsilon_{1}$ to $\varepsilon_{5}$, before the technical details follow in the subsequent subsections. The coefficient $\left(1-\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}\right)^{-1}=1+\delta \in P_{0}(\mathcal{T})$ with $\lambda_{h} \equiv \lambda_{h}(k)$ on the right-hand side of (3.2) is frozen in the intermediate EVP.

Definition 3.6 (intermediate EVP). Recall $(\cdot, \cdot)_{1+\delta}:=((1+\delta) \cdot, \cdot)_{L^{2}(\Omega)}$. Let $(\mu, \phi) \in$ $\mathbb{R}^{+} \times V(\mathcal{T}) \backslash\{0\}$ solve the (algebraic) eigenvalue problem

The two coefficient matrices in (3.3) are SPD and there exist $N:=\operatorname{dim} V(\mathcal{T})$ (algebraic) eigenpairs $\left(\mu_{1}, \phi_{1}\right), \ldots,\left(\mu_{N}, \phi_{N}\right)$ of (3.3). The eigenvectors $\phi_{1}, \ldots, \phi_{N}$ are $(\cdot, \cdot)_{1+\delta}$-orthonormal and the eigenvalues $\mu_{1} \leqslant \cdots \leqslant \mu_{N}$ are enumerated in ascending order counting multiplicities.

Since $\lambda_{h}$ is an eigenvalue of the rational problem (3.2), $\lambda_{h} \in\left\{\mu_{1}, \ldots, \mu_{N}\right\}$ belongs to the eigenvalues of (3.3). Lemma 3.9 below guarantees the convergence $\left|\mu_{j}-\lambda_{h}(j)\right| \rightarrow 0$ as $h_{\max } \rightarrow$ 0 for $j=1, \ldots, k+1$. Hence there exist positive $\varepsilon_{2} \leqslant \min \left\{1 / 2, \varepsilon_{1}\right\}$ and $M_{6}$ such that $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{2}\right)$ implies
(H1) $\quad \mu_{k}=\lambda_{h}(k)$ is a simple algebraic eigenvalue of (3.3),
(H2) $\max _{\substack{j=1, \ldots, N \\ j \neq k}} \frac{\lambda_{k}}{\lambda_{k}-\mu_{j} \mid} \leqslant M_{6}$.
The intermediate EVP and the following associated source problem allow for the control of the extra-stabilization.

Definition 3.7 (auxiliary source problem). Let $z_{\text {nc }} \in V(\mathcal{T})$ denote the solution to

The proof of (3.5) in Subsection 3.3 extends [CGS15, Lem. 2.4]. The proof of (3.6) utilizes another continuous source problem with the right-hand side $u-J z_{\mathrm{nc}}$. For all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{2}\right)$, Subsection 3.4 below provides a constant $C_{3}>0$ such that

The control of $\|\delta \lambda u\|_{L^{2}(\Omega)}$ on the right-hand side of (3.8) consists of two steps and leads to $c_{1}:=2 \lambda^{2} \kappa_{m}^{2} C_{1} C_{2}\left(1+C_{3}\right)$ and $\varepsilon_{3}:=\min \left\{\varepsilon_{2},\left(2 c_{1}\right)^{-1 / 2 m}\right\}$. A triangle inequality $\|\delta \lambda u\|_{L^{2}(\Omega)} \leqslant$ $\left\|\delta \lambda\left(u-u_{\mathrm{nc}}\right)\right\|_{L^{2}(\Omega)}+\left\|\delta \lambda u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$, the estimate $\delta \leqslant 2 \lambda \kappa_{m}^{2} h_{\text {max }}^{2 m}$ in Remark 3.3, and (3.8) imply

\|\delta \lambda u\|_{L^{2}(\Omega)} \leqslant \frac{c_{1} C_{3} h_{\max }^{2 m}}{1+C_{3}} h_{\max }^{\sigma}\|u-I u\|_{\mathrm{pw}}+c_{1} h_{\max }^{2 m}\|\delta \lambda u\|_{L^{2}(\Omega)}+\left\|\delta \lambda u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} .
$$

The choice of $\varepsilon_{3}$ shows $c_{1} h_{\max }^{2 m}\|\delta \lambda u\|_{L^{2}(\Omega)} \leqslant\|\delta \lambda u\|_{L^{2}(\Omega)} / 2$ for any $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{3}\right)$. Therefore

Notice that $\left\|\delta u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant 2 \lambda \kappa_{m}^{2} h_{\max }^{m}\left\|h_{\mathcal{T}}^{m} u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$ (from Remark 3.3) allows for the application of an efficiency estimate

based on Verführt's bubble-function methodology [Ver13]; see Subsection 3.4 for the proof of (3.10). Abbreviate $c_{2}:=4 \lambda^{2} \kappa_{m}^{2} C_{1} C_{2}\left(1+C_{3}\right) C_{4}$ and $C_{5}:=2 C_{1} C_{2}\left(2 C_{3}+4 \lambda \kappa_{m}^{2}\left(1+C_{3}\right) C_{4}\right)$. The combination of (3.9)-(3.10) controls $\|\delta \lambda u\|_{L^{2}(\Omega)}$ in (3.8) and shows

\begin{equation*}
\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant \frac{C_{5}}{2} h_{\max }^{\sigma}\|u-I u\|_{\mathrm{pw}}+c_{2} h_{\max }^{2 m}\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} . \tag{3.11}
\end{equation*}
$$

The choice $\varepsilon_{4}:=\min \left\{\varepsilon_{3},\left(2 c_{2}\right)^{-1 / 2 m}\right\}<1$ shows $c_{2} h_{\max }^{2 m}\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} / 2$ for $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{4}\right)$. This and (3.11) show the central estimate in Theorem 3.1.c

\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant C_{5} h_{\max }^{\sigma}\|u-I u\|_{\mathrm{pw}} \tag{3.12}
\end{equation*}

Note that (3.12) and (I2) imply the convergence $\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \rightarrow 0$ as $h_{\max } \rightarrow 0$. This and some $\varepsilon_{5} \leqslant \varepsilon_{4}$ ensures $b\left(u, u_{\text {nc }}\right)>0$ for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right)$. Based on this outline, it remains to prove (3.5)-(3.7), (3.10), and (3.12) and to identify $C_{0}, \ldots, C_{4}$ below. The remaining estimates in Theorem 3.1.c follow in Subsection 3.5.

### 3.2. Intermediate EVP

Recall $\varepsilon_{1}:=\min \left\{\varepsilon_{0},\left(2 \lambda_{k+1} \kappa_{m}^{2}\right)^{-1 /(2 m)}\right\}$ and that $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right)$ denotes the $k$-th eigenpair of (1.2) with $\lambda_{h} \equiv \lambda_{h}(k)>0, \boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right) \in \boldsymbol{V}_{\boldsymbol{h}},\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$, and $b\left(u, u_{\mathrm{nc}}\right) \geqslant 0$. Recall the intermediate EVP (3.3) and that $\left(\lambda_{h}, u_{\text {nc }}\right) \in \mathbb{R}^{+} \times V(\mathcal{T})$ solves the rational EVP (3.2).

Remark $3.8\left(\|\cdot\|_{1+\delta} \approx\|\cdot\|_{L^{2}(\Omega)}\right)$ The weighted norm $\|\cdot\|_{1+\delta}$ is equivalent to the $L^{2}$-norm. Since $\lambda_{h} \kappa_{m}^{2} \varepsilon_{1}^{2 m}<\lambda_{k+1} \kappa_{m}^{2} \varepsilon_{1}^{2 m} \leqslant 1 / 2$ and $1 \leqslant\left.(1+\delta)\right|_{T} \leqslant 2$ for all $T \in \mathcal{T} \in \mathbb{T}\left(\varepsilon_{1}\right),\left\|v_{\text {nct }}\right\|_{L^{2}(\Omega)} \leqslant$ $\left\|v_{\mathrm{nc}}\right\|_{1+\delta} \leqslant \sqrt{2}\left\|v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$ holds for any $v_{\mathrm{nc}} \in V(\mathcal{T})$.

Lemma 3.9 (comparison of (1.2) with (3.3)). Given $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{1}\right)$, let $\lambda_{h}(j)$ denote the $j$-th eigenvalue of (1.2), and $\mu_{j}$ the $j$-th eigenvalue of (3.3) for any $j=1, \ldots, k+1$. Then

\left(1-\lambda_{k+1} \kappa_{m}^{2} h_{\max }^{2 m}\right) \mu_{j} \leqslant\left(1-\lambda_{h}(j) \kappa_{m}^{2} h_{\max }^{2 m}\right) \mu_{j} \leqslant \lambda_{h}(j) \leqslant \mu_{j}+2 \lambda_{h}^{2} \kappa_{m}^{2} h_{\max }^{2 m} . \tag{3.13}
\end{equation*}

The upper bound $\lambda_{h}(j) \leqslant \mu_{j}+2 \lambda_{h}^{2} \kappa_{m}^{2} h_{\max }^{2 m}$ holds for all $j=1, \ldots, N ; N:=\operatorname{dim} V(\mathcal{T})$.
Proof of the upper bound. Since the eigenfunctions $\phi_{1}, \ldots, \phi_{N}$ of (3.3) are $(\cdot, \cdot)_{1+\delta}$-orthonormal, $a_{\mathrm{pw}}\left(\phi_{j}, \phi_{\ell}\right)=\mu_{j} \delta_{j \ell}$ and $\left(\phi_{j}, \phi_{\ell}\right)_{1+\delta}=\delta_{j \ell}$ for all $j, \ell=1, \ldots, N$. Set $\psi_{j}:=(1+$ $\delta) \phi_{j}$ and $\boldsymbol{U}_{\boldsymbol{j}}:=\operatorname{span}\left\{\left(\psi_{1}, \phi_{1}\right), \ldots,\left(\psi_{j}, \phi_{j}\right)\right\} \subset \boldsymbol{V}_{\boldsymbol{h}}$. Since $b\left(\psi_{j}, \phi_{\ell}\right)=\left(\phi_{j}, \phi_{\ell}\right)_{1+\delta}=\delta_{j \ell}$, the functions $\phi_{1}, \ldots, \phi_{N}$ are linear independent and so $\operatorname{dim}\left(\boldsymbol{U}_{\boldsymbol{j}}\right)=j$ for any $j=1, \ldots, N$. The discrete min-max principle [SF08, Bof10] for the algebraic eigenvalue problem (1.2) shows

\lambda_{h}(j) \leqslant \max _{\boldsymbol{v}_{\boldsymbol{h}} \in \boldsymbol{U}_{j} \backslash\{0\}} \boldsymbol{a}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right) / \boldsymbol{b}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right) . \tag{3.14}
\end{equation*}
$$

The maximum in (3.14) is attained for some $\boldsymbol{v}_{\boldsymbol{h}}=(\psi, \phi) \in \boldsymbol{U}_{\boldsymbol{j}} \backslash\{0\}$ with $\phi=\sum_{\ell=1}^{j} \alpha_{\ell} \phi_{\ell} \in$ $V(\mathcal{T}), \psi=\sum_{\ell=1}^{j} \alpha_{\ell} \psi_{\ell}=(1+\delta) \phi \in P_{m}(\mathcal{T})$, and $1=\|\phi\|_{1+\delta}^{2}=\sum_{\ell=1}^{j} \alpha_{\ell}^{2}$. Then $\boldsymbol{b}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right)=$ $\|(1+\delta) \phi\|_{L^{2}(\Omega)}^{2} \geqslant 1$ and $\boldsymbol{a}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right)=\|\phi\|_{\mathrm{pw}}^{2}+\left\|\kappa_{m}^{-1} h_{\mathcal{T}}^{-m}(\psi-\phi)\right\|_{L^{2}(\Omega)}^{2}$. Since $a_{\mathrm{pw}}\left(\phi_{j}, \phi_{\ell}\right)=\mu_{j} \delta_{j \ell}$ for $\ell, j=1, \ldots, N, \sum_{\ell=1}^{j} \alpha_{\ell}^{2}=1$ implies $\|\phi\|_{\mathrm{pw}}^{2}=\sum_{\ell=1}^{j} \alpha_{\ell}^{2} \mu_{\ell} \leqslant \mu_{j}$. Since $\delta=\lambda_{h} \kappa_{m}^{2} h_{\mathcal{T}}^{2 m}(1+\delta)$ a.e. in $\Omega$, the stabilization term in $\boldsymbol{a}_{\boldsymbol{h}}$ reads

The bound $1+\delta \leqslant 2$ from Remark 3.3 and $\|\phi\|_{1+\delta}=1$ imply $\left\|h_{\mathcal{T}}^{m}(1+\delta) \phi\right\|_{L^{2}(\Omega)}^{2} \leqslant 2 h_{\max }^{2 m}$. Consequently, $\left\|\kappa_{m}^{-1} h_{\mathcal{T}}^{-m}(\psi-\phi)\right\|_{L^{2}(\Omega)}^{2} \leqslant 2 \lambda_{h}^{2} \kappa_{m}^{2} h_{\max }^{2 m}$. The substitution of the resulting estimates $\boldsymbol{b}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right) \geqslant 1$ and $\boldsymbol{a}_{\boldsymbol{h}}\left(\boldsymbol{v}_{\boldsymbol{h}}, \boldsymbol{v}_{\boldsymbol{h}}\right) \leqslant \mu_{j}+2 \lambda_{h}^{2} \kappa_{m}^{2} h_{\max }^{2 m}$ in (3.14) concludes the proof of $\lambda_{h}(j) \leqslant \mu_{j}+2 \lambda_{h}^{2} \kappa_{m}^{2} h_{\max }^{2 m}$ in (3.13) for $j=1, \ldots, N$.

Proof of the lower bound. This situation is similar to [CZZ20, Thm. 6.4] and adapted below for completeness. For $j=1, \ldots, k+1$, let $\left(\lambda_{h}(j), \boldsymbol{\phi}_{\boldsymbol{h}}(j)\right) \in \mathbb{R}^{+} \times \boldsymbol{V}_{\boldsymbol{h}}$ denote the first $\boldsymbol{b}_{\boldsymbol{h}^{-}}$ orthonormal eigenpairs of (1.2) with $\phi_{\boldsymbol{h}}(j)=\left(\phi_{\mathrm{pw}}(j), \phi_{\mathrm{nc}}(j)\right)$. The test functions $\left(v_{\mathrm{nc}}, v_{\mathrm{nc}}\right) \in$ $V(\mathcal{T}) \times V(\mathcal{T}) \subset \boldsymbol{V}_{\boldsymbol{h}}$ and $\left(v_{\mathrm{pw}}, 0\right) \in \boldsymbol{V}_{\boldsymbol{h}}$ in (1.2) show

a_{\mathrm{pw}}\left(\phi_{\mathrm{nc}}(j), v_{\mathrm{nc}}\right)=\lambda_{h}(j) b\left(\phi_{\mathrm{pw}}(j), v_{\mathrm{nc}}\right) \quad \text { and } \quad \phi_{\mathrm{pw}}(j)-\phi_{\mathrm{nc}}(j)=\lambda_{h}(j) \kappa_{m}^{2} h_{\mathcal{T}}^{2 m} \phi_{\mathrm{pw}}(j) \tag{3.15}
\end{equation*}
$$

For $\xi=\left(\xi_{1}, \ldots, \xi_{j}\right) \in \mathbb{R}^{j}$ with $\sum_{\ell=1}^{j} \xi_{\ell}^{2}=1$, set

$$
v_{\mathrm{nc}}:=\sum_{\ell=1}^{j} \xi_{\ell} \phi_{\mathrm{nc}}(\ell), \quad v_{\mathrm{pw}}:=\sum_{\ell=1}^{j} \xi_{\ell} \phi_{\mathrm{pw}}(\ell), \quad \text { and } \quad w_{\mathrm{pw}}:=\sum_{\ell=1}^{j} \xi_{\ell} \lambda_{h}(\ell) \phi_{\mathrm{pw}}(\ell)
$$

Since $\left(\phi_{\mathrm{pw}}(\alpha), \phi_{\mathrm{pw}}(\beta)\right)_{L^{2}(\Omega)}=\delta_{\alpha \beta}$ for $\alpha, \beta=1, \ldots, k+1,\left\|v_{\mathrm{pw}}\right\|_{L^{2}(\Omega)}=1$ and $\left\|w_{\mathrm{pw}}\right\|_{L^{2}(\Omega)}=$ $\sqrt{\sum_{\ell=1}^{j} \xi_{\ell}^{2} \lambda_{h}(\ell)^{2}} \leqslant \lambda_{h}(j)$. The combination of this with (3.15) and a Cauchy-Schwarz inequality leads to $\left\|v_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2}=b\left(w_{\mathrm{pw}}, v_{\mathrm{nc}}\right) \leqslant \lambda_{h}(j)\left\|v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$ and $v_{\mathrm{pw}}-v_{\mathrm{nc}}=\kappa_{m}^{2} h_{\mathcal{T}}^{2 m} w_{\mathrm{pw}}$. This and a reverse triangle inequality result in

\end{equation*}

This holds for all $v_{\mathrm{nc}} \in U_{j}:=\operatorname{span}\left\{\phi_{\mathrm{nc}}(1), \ldots, \phi_{\mathrm{nc}}(j)\right\} \subset V(\mathcal{T})$ with coefficients $\left(\xi_{1}, \ldots, \xi_{j}\right) \in$ $\mathbb{R}^{j}$ of Euclidean norm one. Hence $\operatorname{dim}\left(U_{j}\right)=j$ and the discrete min-max principle [SF08, Bof10] for (3.3) show

\mu_{j} \leqslant \max _{v_{\mathrm{nc}} \in U_{j} \backslash\{0\}}\left\|v_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2} /\left\|v_{\mathrm{nc}}\right\|_{1+\delta}^{2} \tag{3.17}
\end{equation*}
$$

Let $v_{\mathrm{nc}}=\sum_{\ell=1}^{j} \alpha_{\ell} \phi_{\mathrm{nc}}(\ell) \in U_{j}$ denote a maximizer in (3.17) with $\sum_{\ell=1}^{j} \alpha_{\ell}^{2}=1$. The combination of $\left\|v_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2} \leqslant \lambda_{h}(j)\left\|v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)},(3.16)-(3.17)$, and $\left\|v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant\left\|v_{\mathrm{nc}}\right\|_{1+\delta}$ from Remark 3.8 provides

Recall $\lambda_{h}(j) \leqslant \lambda_{h}(k+1) \leqslant \lambda_{k+1}$ from the lower bound property (1.3) to conclude the proof of the associated lower bound for all $j=1, \ldots, k$.
The subsequent corollaries adapt the notation $\mu_{j}, \lambda_{h}(j), \lambda_{j}$ from Lemma 3.9.

Corollary 3.10 and $\lambda_{h}=\lambda_{h}(k) \in\left\{\mu_{1}, \ldots, \mu_{N}\right\}$ lead to $\varepsilon_{a}>0$ such that $\lambda_{h}=\lambda_{h}(k)=$ $\mu_{k}$ has the correct index $k$ for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{a}\right)$. It also leads to some $\varepsilon_{b}>0$ such that $\mu_{k-1}<$ $\mu_{k}<\mu_{k+1}$ for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{b}\right)$. Then $\varepsilon_{2}:=\min \left\{1 / 2, \varepsilon_{1}, \varepsilon_{a}, \varepsilon_{b}\right\}$ and $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{2}\right)$ imply (H1)-(H2). $\square$

Since the eigenvectors $\phi_{1}, \ldots, \phi_{N}$ of $(3.3)$ are $(\cdot, \cdot)_{1+\delta}$-orthonormal and form a basis of $V(\mathcal{T})$, there exist Fourier coefficients $\alpha_{1}, \ldots, \alpha_{N} \in \mathbb{R}$ with $v_{\mathrm{nc}}=\sum_{j=1}^{N} \alpha_{j} \phi_{j}$ and $\left\|v_{\mathrm{nc}}\right\|_{1+\delta}^{2}=\sum_{j=1}^{N} \alpha_{j}^{2}$. Since ( $\lambda_{h}, u_{\mathrm{nc}}$ ) solves (3.2), (H1) implies $u_{\mathrm{nc}} \in \operatorname{span}\left\{\phi_{k}\right\}$ with $\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$. Since $\phi_{j}$ is an eigenvector in (3.3) and $z_{\mathrm{nc}}$ solves (3.4), it follows

for a sign in $\alpha_{j}^{\prime} \in\left\{ \pm \alpha_{j}\right\}$ such that $\left|\left(u-z_{\mathrm{nc}}, \alpha_{j} \phi_{j}\right)_{1+\delta}\right|=\left(u-z_{\mathrm{nc}}, \alpha_{j}^{\prime} \phi_{j}\right)_{1+\delta}$ and with the abbreviation $\sum_{j \neq k}=\sum_{j=1, j \neq k}^{N}$. This and a Cauchy-Schwarz inequality show

M_{6}^{-1}\left\|v_{\mathrm{nc}}\right\|_{1+\delta}^{2} \leqslant\left(u-z_{\mathrm{nc}}, \sum_{j \neq k} \alpha_{j}^{\prime} \phi_{j}\right)_{1+\delta} \leqslant\left\|u-z_{\mathrm{nc}}\right\|_{1+\delta}\left\|v_{\mathrm{nc}}\right\|_{1+\delta} .

The norm equivalence in Remark 3.8 proves $\left\|v_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant\left\|v_{\mathrm{nc}}\right\|_{1+\delta} \leqslant \sqrt{2} M_{6}\left\|u-z_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$. This and (3.18) conclude the proof of (3.5) with $C_{1}:=\sqrt{2}\left(1+\sqrt{2} M_{6}\right)$.

is a direct consequence of the Friedrichs inequality $\|v\|_{L^{2}(\Omega)} \leqslant C_{F}\|v\|$ for any $v \in V$ and (J2); cf. [CH17, Cor. 4.11] for details in case $m=1$; the proof for $m=2$ is analogous. This, (I2), and the boundedness of $\Pi_{0}$ imply $C_{\mathrm{dF}}^{-1}\|I w\|_{L^{2}(\Omega)} \leqslant\|I w\|_{\mathrm{pw}}=\left\|\Pi_{0} D^{m} w\right\|_{L^{2}(\Omega)} \leqslant\|w\|_{H^{m}(\Omega)}$. with the constant $C_{2}:=\max \left\{C(\sigma)\left(1+5 M_{2} / 2\right) / \pi^{\sigma}+M_{2} \kappa_{m}, C(\sigma) C_{\mathrm{dF}}\right\}$.

This and $3 M_{2} / 2\|u-I u\|_{\mathrm{pw}}\left\|u-z_{\mathrm{nc}}\right\|_{\mathrm{pw}} \leqslant 9 M_{2}^{2} / 4\|u-I u\|_{\mathrm{pw}}^{2}+\left\|u-z_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2} / 4$ conclude the proof of (3.7) with $C_{3}^{2}:=2 \max \left\{1+3 M_{2} / 2+9 M_{2}{ }^{2} / 4,\left(C_{2}+\kappa_{m}\right)^{2} h_{\max }^{2 \sigma}+C_{2}\right\}$.

Proof of (3.10). The proof of the efficiency estimate of the volume residual is based on Verführt's bubble-function methodology [Ver13], comparable to [BdVNS07, Thm. 2], [Gal15b, Prop. 3.1], and given here for completeness. Let $\varphi_{z} \in S^{1}(\mathcal{T}):=P_{1}(\mathcal{T}) \cap C(\Omega)$ denote the nodal basis function associated with the vertex $z \in \mathcal{V}$. For any $T \in \mathcal{T}$, let $b_{T}:=4^{4 m} \prod_{z \in \mathcal{V}(T)} \varphi_{z}^{m} \in$ $P_{4 m}(T) \cap W_{0}^{m, \infty}(T) \subset V$ denote the volume-bubble-function with $\operatorname{supp}\left(b_{T}\right)=T$ and $\left\|b_{T}\right\|_{\infty}=$ 1. An inverse estimate $\|p\|_{L^{2}(T)} \leqslant c_{b}\|p\|_{b_{T}}$ for any polynomial $p \in P_{m}(T)$ leads to

The Cauchy-Schwarz inequality and $\left\|b_{T}\right\|_{\infty}=1$ show $\left(u_{\mathrm{nc}}, u-u_{\mathrm{nc}}\right)_{b_{T}} \leqslant\left\|u_{\mathrm{nc}}\right\|_{L^{2}(T)} \| u-$ $u_{\mathrm{nc}} \|_{L^{2}(T)}$. An integration by parts proves $\int_{T} D^{m}\left(b_{T} u_{\mathrm{nc}}\right) \mathrm{d} x=0$ since $b_{T} u_{\mathrm{nc}} \in H_{0}^{m}(T)$, i.e.,
$D^{m} b_{T} u_{\mathrm{nc}}$ is $L^{2}$-orthogonal to $P_{0}(T)$. Recall that $(\lambda, u)$ is an eigenpair of (1.1) and the support of $b_{T} u_{\text {nc }}$ is $T$. This, (I2), and the Cauchy-Schwarz inequality result in

An inverse estimate for polynomials in $P_{5 m}(T)$ with the constant $c_{\mathrm{inv}}$ and the boundedness of $b_{T}$ show $\lambda b\left(u, b_{T} u_{\mathrm{nc}}\right) \leqslant c_{\mathrm{inv}} h_{T}^{-m}|u-I u|_{H^{m}(T)}\left\|u_{\mathrm{nc}}\right\|_{L^{2}(T)}$. This provides $c_{b}^{-2} h_{T}^{m}\left\|u_{\mathrm{nc}}\right\|_{L^{2}(T)} \leqslant$ $h_{T}^{m}\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(T)}+c_{\mathrm{inv}} \lambda^{-1}|u-I u|_{H^{m}(T)}$ for all $T \in \mathcal{T}$ in (3.25). The sum over all $T \in \mathcal{T}$ concludes the proof of (3.10) with $C_{4}=c_{b}^{2} \max \left\{1, c_{\text {inv }}\right\}$.

### 3.5. Proof of Theorem 3.1.c

Proof of (3.12) for $\varepsilon_{4}>0$. Recall $c_{1}:=2 \lambda^{2} \kappa_{m}^{2} C_{1} C_{2}\left(1+C_{3}\right)$ and (3.8) as a result of (3.5)(3.7). A triangle inequality, Remark 3.3, and (3.8) show

\end{aligned}
$$

Since $0<\varepsilon_{3}:=\min \left\{\varepsilon_{2},\left(2 c_{1}\right)^{-1 / 2 m}\right\}$ ensures $c_{1} h_{\max }^{2 m} \leqslant 1 / 2$ for all $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{3}\right)$, the previous displayed estimate reads $\|\delta \lambda u\|_{L^{2}(\Omega)} \leqslant \frac{c_{1} C_{3} h_{\max }^{2 m}}{1+C_{3}} h_{\max }^{\sigma}\|u-I u\|_{\mathrm{pw}}+\|\delta \lambda u\|_{L^{2}(\Omega)} / 2+\left\|\delta \lambda u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$. This implies (3.9). The bound (3.9) for $\|\delta \lambda u\|_{L^{2}(\Omega)}$ recasts (3.8) as

Recall that $c_{2}:=4 \lambda^{2} \kappa_{m}^{2} C_{1} C_{2}\left(1+C_{3}\right) C_{4}$ and $\varepsilon_{4}:=\min \left\{\varepsilon_{3},\left(2 c_{2}\right)^{-1 / 2 m}\right\}<1$ ensure $c_{2} h_{\max }^{2 m} \leqslant$ $1 / 2$. Hence the last term in (3.11) is $\leqslant\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} / 2$ and can be absorbed. This concludes the proof of (3.12) with $C_{5}:=2 C_{1} C_{2}\left(2 C_{3}+4 \kappa_{m}^{2} \lambda\left(1+C_{3}\right) C_{4}\right)$.

Recall $0<\varepsilon_{5} \leqslant \varepsilon_{4}$ such that $b\left(u, u_{\text {nc }}\right)>0$ for any $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right)$.
Proof of Theorem 3.1.c for $\varepsilon_{5}$. Recall $\lambda_{h} \leqslant \lambda$ and $\|u\|_{L^{2}(\Omega)}=\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$. The continuous eigenpair ( $\lambda, u$ ) in (1.1) satisfies $\lambda=\|u\|^{2}$. The discrete eigenpair ( $\lambda_{h}, u_{\mathrm{nc}}$ ) solves (3.2) and so $\lambda_{h}=\left\|u_{\mathrm{nc}}\right\|_{\mathrm{pw}}^{2} /\left\|u_{\mathrm{nc}}\right\|_{1+\delta}^{2}$ with $\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$. Then

This and elementary algebra show for the left-hand side of Theorem 3.1.c that

Since $u$ is the eigenfunction in (1.1) and $2 b\left(u, u-u_{\mathrm{nc}}\right)=\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}^{2}$ from $\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=$ $1=\|u\|_{L^{2}(\Omega)}$, it follows

Corollary 2.3.b asserts $2 \lambda b\left(u, u_{\mathrm{nc}}-\right.$ $\left.J u_{\mathrm{nc}}\right) \leqslant M_{2}\|u-I u\|_{\mathrm{pw}}\left\|u-u_{\mathrm{nc}}\right\|_{\mathrm{pw}}$. Corollary 2.3.c shows $a_{\mathrm{pw}}\left(u, J u_{\mathrm{nc}}-u_{\mathrm{nc}}\right) \leqslant M_{2} \| u-$ $I u\left\|_{\mathrm{pw}}\right\| u-u_{\mathrm{nc}} \|_{\mathrm{pw}}$. Since $\lambda_{h} \leqslant \lambda$, these estimates lead in (3.26) to

A weighted Young inequality and the absorption of $\left\|u_{\mathrm{nc}}-u\right\|_{\mathrm{pw}}^{2} / 2$ conclude the proof of Theorem 3.1.c with $C_{0}:=\max \left\{C_{5}^{2}, 2\left((1+\lambda) C_{4}^{2}\left(C_{5} h_{\max }^{\sigma}+\sqrt{2 / \lambda} \kappa_{m}\right)^{2}+\lambda C_{5}^{2} h_{\max }^{2 \sigma}\right)+9 M_{2}^{2}\right\}$.

## 4. Optimal convergence rates

This section verifies some general axioms of adaptivity [CFPP14, CR17] sufficient for optimal rates for AFEM4EVP and prepares the conclusion of the proof of Theorem 1.1 in Section 5.

### 4.1. Stability and reduction

The 2-level notation of Table 4.1 concerns one coarse triangulation $\mathcal{T} \in \mathbb{T}$ and one fine triangulation $\hat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$. Let $(\lambda, u) \in \mathbb{R}^{+} \times V$ denote the $k$-th continuous eigenpair of (1.1) with a simple eigenvalue $\lambda \equiv \lambda_{k}$ and the normalization $\|u\|_{L^{2}(\Omega)}=1$. Choose $\varepsilon_{5}>0$ as in Theorem 3.1, suppose $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right)$, and let $\widehat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$ be any admissible refinement of $\mathcal{T}$.
Definition 4.1 (2-level notation). Let $\left(\lambda_{h}, \boldsymbol{u}_{\boldsymbol{h}}\right) \in \mathbb{R}^{+} \times \boldsymbol{V}_{\boldsymbol{h}}$ (resp. $\left.\left(\hat{\lambda}_{h}, \widehat{\boldsymbol{u}}_{\boldsymbol{h}}\right) \in \mathbb{R}^{+} \times \widehat{\boldsymbol{V}}_{\boldsymbol{h}}\right)$ with $\boldsymbol{u}_{\boldsymbol{h}}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right) \in \boldsymbol{V}_{\boldsymbol{h}}:=P_{m}(\mathcal{T}) \times V(\mathcal{T})\left(\right.$ resp. $\left.\widehat{\boldsymbol{u}}_{\boldsymbol{h}}=\left(\widehat{u}_{\mathrm{pw}}, \widehat{u}_{\mathrm{nc}}\right) \in \widehat{\boldsymbol{V}}_{\boldsymbol{h}}:=P_{m}(\widehat{\mathcal{T}}) \times V(\widehat{\mathcal{T}})\right)$ denote the $k$-th discrete eigenpair of (1.2) with the simple algebraic eigenvalue $\lambda_{h} \equiv \lambda_{h}(k)$ (resp. $\left.\widehat{\lambda}_{h} \equiv \hat{\lambda}_{h}(k)\right)$, the normalization $\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$ (resp. $\left\|\widehat{u}_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$ ), and the sign convention $b\left(u, u_{\mathrm{nc}}\right)>0\left(\right.$ resp. $\left.b\left(u, \widehat{u}_{\mathrm{nc}}\right)>0\right)$. Recall $\widehat{h}_{\max }:=\max _{T \in \hat{\mathcal{T}}} h_{T} \leqslant h_{\max }:=\max _{T \in \mathcal{T}} h_{T} \leqslant$ $\varepsilon_{5}, \lambda_{h}, \hat{\lambda}_{h} \leqslant \lambda$ from Theorem 3.1.b, and $\delta$ from Remark 3.3 with its analogue $\widehat{\delta}:=(1-$ $\left.\hat{\lambda}_{h} \kappa_{m}^{2} h_{\hat{\mathcal{T}}}^{2 m}\right)^{-1}-1 \in P_{0}(\hat{\mathcal{T}})$ on the fine level. The constant $C_{\delta}:=2 \lambda \kappa_{m}^{2}$ satisfies $\delta \leqslant C_{\delta} h_{\mathcal{T}}^{2 m}$ and $\widehat{\delta} \leqslant C_{\delta} h_{\hat{\mathcal{T}}}^{2 m}$. Recall the estimator $\eta^{2}(T)$ for any $T \in \mathcal{T}$ from (1.4) and define $\widehat{\eta}^{2}(T)$, for any $T \in \widehat{\mathcal{T}}$ with volume $|T|$ and the set of faces $\hat{\mathcal{F}}(T)$, by

The sum conventions $\eta^{2}(\mathcal{M}):=\sum_{T \in \mathcal{M}} \eta^{2}(T)$ for $\mathcal{M} \subset \mathcal{T}$ and $\widehat{\eta}^{2}(\widehat{\mathcal{M}}):=\sum_{T \in \widehat{\mathcal{M}}} \widehat{\eta}^{2}(T)$ for $\widehat{\mathcal{M}} \subset \widehat{\mathcal{T}}$ from Table 4.1 apply throughout this section. Abbreviate the distance function

A reverse triangle inequality in $\mathbb{R}^{L}$ for the number $L:=|\mathcal{T} \cap \hat{\mathcal{T}}|$ of tetrahedra in $\mathcal{T} \cap \hat{\mathcal{T}}$ and one for each common tetrahedra $T \in \mathcal{T} \cap \widehat{\mathcal{T}}$ and each of its faces $F \in \mathcal{F}(T)$ lead to

& \left.+|T|^{1 / 3} \sum_{F \in \mathcal{F}(T)}\left\|\left[D_{\mathrm{pw}}^{m}\left(u_{\mathrm{nc}}-\widehat{u}_{\mathrm{nc}}\right)\right]_{F} \times \nu_{F}\right\|_{L^{2}(F)}^{2}\right)
\end{aligned}

The discrete jump control from [CR17, Lem. 5.2] with constant $C_{\mathrm{jc}}(\ell)$ (that only depends on the shape-regularity of $\mathbb{T}$ and the polynomial degree $\ell \in \mathbb{N}_{0}$ ) reads

The combination of the two displayed estimates concludes the proof of (A1) with $\Lambda_{1}^{2}=$ $\max \left\{\max _{T \in \mathcal{T}_{0}}|T|^{2 m / 3}, C_{\mathrm{jc}}(0)^{2}\right\}$. For any tetrahedron $K \in \mathcal{T} \backslash \hat{\mathcal{T}}$, let $\hat{\mathcal{T}}(K):=\{T \in \widehat{\mathcal{T}}: T \subset$ $K\}$ denote its fine triangulation. The newest-vertex bisection guarantees $|T| \leqslant|K| / 2$ for the volume $|T|$ of any $T \in \widehat{\mathcal{T}}(K)$. This, a triangle inequality, and $(a+b)^{2} \leqslant(1+\beta) a^{2}+(1+1 / \beta) b^{2}$ for $a, b \geqslant 0, \beta=2^{1 / 6}-1>0$ show

\end{aligned}

The summation over all $K \in \mathcal{T} \backslash \hat{\mathcal{T}}$ and the above jump control conclude the proof of (A2) with $\Lambda_{2}^{2}=2^{1 / 6} /\left(2^{1 / 6}-1\right) \max \left\{\max _{T \in \mathcal{T}_{0}}|T|^{2 m / 3}, C_{\mathrm{jc}}(0)^{2}\right\}$. The arguments for (A1)-(A2) are similiar for other problems; cf., e.g., [CKNS08, CFPP14, CR17, CH18] for more details.

### 4.2. Towards discrete reliability

Given the 2-level notation of Definition 4.1 with respect to $\mathcal{T}$ and $\hat{\mathcal{T}}$, let $\mathcal{R}_{1}:=\{K \in \mathcal{T}$ : $\exists T \in \mathcal{T} \backslash \widehat{\mathcal{T}}$ with $\operatorname{dist}(K, T)=0\} \subset \mathcal{T}$ denote the set of coarse but not fine tetrahedra plus one layer of coarse tetrahedra around. Lemma 4.3-4.5 prepare the proof of the discrete reliability in Theorem 4.6 below. Let $\widehat{I}: V+V(\widehat{\mathcal{T}}) \rightarrow V(\widehat{\mathcal{T}})$ denote the interpolation operator on the fine level of $\hat{\mathcal{T}}$ so that (I3) and a Cauchy-Schwarz inequality show, for any $v \in V+V(\hat{\mathcal{T}})$ and any $w \in V+V(\mathcal{T})+V(\widehat{\mathcal{T}})$, that

Lemma 4.3 (distance control I). There exists $C_{6}>0$ such that any $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right)$ and the difference $e:=\widehat{u}_{\mathrm{nc}}-u_{\mathrm{nc}}$ satisfy

& +b\left(\widehat{\lambda}_{h} \widehat{u}_{\mathrm{nc}},(1+\widehat{\delta})\left(u_{\mathrm{nc}}-\widehat{I} J u_{\mathrm{nc}}\right)\right)+b\left(\lambda_{h} u_{\mathrm{nc}},(1+\delta)\left(\widehat{u}_{\mathrm{nc}}-I \widehat{u}_{\mathrm{nc}}\right)\right) . \tag{4.4}

Elementary algebra with $\left\|u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=\left\|\widehat{u}_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}=1$ shows (as, e.g., in [CG11, Lem. 3.1])

The triangle inequality $\left\|h_{\mathcal{T}}^{m} \lambda \widehat{u}_{\mathrm{nc}}\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})} \leqslant h_{\max }^{m} \lambda\|e\|_{L^{2}(\Omega)}+\left\|h_{\mathcal{T}}^{m} \lambda u_{\mathrm{nc}}\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})}$ and $\lambda / \lambda_{h} \leqslant 2$ from Theorem 3.1.a imply $\left\|h_{\mathcal{T}}^{m} \lambda u_{\mathrm{nc}}\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})} \leqslant 2\left\|h_{\mathcal{T}}^{m} \lambda_{h} u_{\mathrm{nc}}\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})}$. The estimate (4.3) and $\delta \leqslant 1$ from Table 4.1 imply the first inequality and (I4) and Corollary 2.1.a the second in

with weighted Young inequalities in the last step. This concludes the proof with $C_{6}:=$ $2 \max \left\{1+4 \kappa_{d}^{2}+\kappa_{d}^{2} \lambda^{2} h_{\max }^{2 m}, 1+\lambda+\lambda^{2} / 2\right\}$.

### 4.2.1. Reliability and efficiency

A first consequence of Lemma 4.3 is the reliability of the error estimator $\eta(\mathcal{T})$ from (1.4).
Theorem 4.4 (reliability and efficiency). There exist $C_{\text {rel }}, C_{\text {eff }}$, and $\varepsilon_{6}>0$ such that

Proof of reliability. Lemma 4.3 holds for any refinement $\hat{\mathcal{T}} \in \mathbb{T}(\mathcal{T})$ of $\mathcal{T} \in \mathbb{T}\left(\varepsilon_{5}\right)$ and we may consider a sequence $\widehat{\mathcal{T}}=\widehat{\mathcal{T}}_{\ell}$ of uniform mesh-refinements of $\mathcal{T}$. The reliability follows in the limit as $\widehat{h}_{\max } \rightarrow 0$ for $\ell \rightarrow \infty$ and $\left\|u-\widehat{u}_{\mathrm{nc}}\right\|_{\mathrm{pw}} \rightarrow 0$ from Theorem 3.1.c. The left-hand side of Lemma 4.3 converges to $C_{6}^{-1}\left\|u-u_{\mathrm{nc}}\right\|_{\text {pw }}$. On the right-hand side, $\left\|\hat{\delta} \widehat{u}_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \leqslant C_{\delta} \hat{h}_{\max }^{2 m}$ converges to zero and $\|e\|_{L^{2}(\Omega)} \rightarrow\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)}$ as $\widehat{h}_{\max } \rightarrow 0$. \left\|h_{\mathcal{T}}^{m} \lambda_{h} u_{\mathrm{nc}}\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})} & \leqslant\left\|h_{\mathcal{T}}^{m} \lambda u\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})}+\lambda h_{\max }^{m}\left\|u-u_{\mathrm{nc}}\right\|_{L^{2}(\Omega)} \\
& \leqslant\left\|h_{\mathcal{T}}^{m} \lambda u\right\|_{L^{2}(\mathcal{T} \backslash \hat{\mathcal{T}})}+C_{5} \lambda h_{\max }^{m+\sigma}\left\|u-u_{\mathrm{nc}}\right\|_{\mathrm{pw}} .
\end{aligned}
$$

Hence the upper bound $t_{1}+t_{2}$ in (4.5) is controlled and the above estimates lead to the assertion with $C_{\mathrm{qo}}:=\max \left\{2 \kappa_{d}, \max \{1, \lambda\} C_{7} C_{\mathrm{dF}}+2 C_{5} \lambda h_{\max }^{m} \kappa_{d}\right\}$.

Proof of Theorem 4.7. Recall that $u_{j} \in V\left(\mathcal{T}_{j}\right)$ is the nonconforming component of the discrete solution $\boldsymbol{u}_{j}=\left(u_{\mathrm{pw}}, u_{\mathrm{nc}}\right)=:\left(u_{\mathrm{pw}}, u_{j}\right) \in P_{m}\left(\mathcal{T}_{j}\right) \times V\left(\mathcal{T}_{j}\right)$ and that $\lambda_{j}(k) \leqslant \lambda$ is the associated eigenvalue from AFEM4EVP on the $j$-th level for $\ell \leqslant j \leqslant \ell+L$. Since $\mathcal{T}_{j}$, $\mathcal{T}_{j+1} \in \mathbb{T}\left(\mathcal{T}_{0}\right)$ for $\ell \leqslant j \leqslant \ell+L$, Lemma 4.5 shows

& \leqslant \frac{2 C_{\mathrm{qo}}^{2}}{\beta} h_{0}^{2 \sigma} C_{\mathrm{rel}}^{2} \eta_{j}^{2}+\beta C_{\mathrm{rel}}^{2} \eta_{j+1}^{2}+\frac{2 C_{\mathrm{qo}}^{2}}{\beta}\left\|h_{\mathcal{T}_{j}}^{m} \lambda u\right\|_{L^{2}\left(\mathcal{T}_{j} \backslash \mathcal{T}_{j+1}\right)}^{2}

with Theorem 4.4 in the last step. Theorem 4.4 controls the telescoping sum

Since $\beta \leqslant C_{\text {eff }}^{2} / C_{\text {rel }}^{2}$ implies $\left(\beta C_{\mathrm{rel}}^{2}-C_{\mathrm{eff}}^{2}\right) \eta_{\ell+L+1}^{2} \leqslant 0$, the last three displayed estimates show

Recall that $\left.h_{\mathcal{T}_{j}}\right|_{T}:=\operatorname{diam}(T)$ for any $T \in \mathcal{T}_{j}$ and compare it with the piecewise constant function $\tilde{h}_{j} \in P_{0}\left(\mathcal{T}_{j}\right)$ defined by $\left.\tilde{h}_{j}\right|_{T}:=|T|^{1 / 3} \leqslant h_{\tilde{\sim}_{\sim}} \leqslant C_{\mathrm{sr}}|T|^{1 / 3}$ (from shape-regularity) for any $T \in \mathcal{T}_{j}$ and $j \in \mathbb{N}_{0}$. Then $\tilde{h}_{j} \approx h_{\mathcal{T}_{j}} \in P_{0}\left(\mathcal{T}_{j}\right)$ and $\tilde{h}_{j} \in P_{0}\left(\mathcal{T}_{j}\right)$ satisfies the reduction $\tilde{h}_{j+1} \leqslant$ $\tilde{h}_{j} / 2^{1 / 3}$ a.e. in the set of refined tetrahedra $\bigcup\left(\mathcal{T}_{j} \backslash \mathcal{T}_{j+1}\right)$. Hence $\tilde{h}_{j}^{m} \leqslant \frac{2^{m / 3}}{\sqrt{4^{m / 3}-1}} \sqrt{\tilde{h}_{j}^{2 m}-\tilde{h}_{j+1}^{2 m}}$ a.e. in $\bigcup\left(\mathcal{T}_{j} \backslash \mathcal{T}_{j+1}\right)$ and

& \quad \leqslant \sum_{j=\ell}^{\ell+L}\left\|\sqrt{\tilde{h}_{j}^{2 m}-\tilde{h}_{j+1}^{2 m}} \lambda u\right\|_{L^{2}(\Omega)}^{2}=\int_{\Omega}\left(\tilde{h}_{\ell}^{2 m}-\tilde{h}_{\ell+L+1}^{2 m}\right)(\lambda u)^{2} \mathrm{~d} x \leqslant\left\|\tilde{h}_{\ell}^{m} \lambda u\right\|_{L^{2}(\Omega)}^{2}

Since $\tilde{h}_{\ell} \leqslant h_{\mathcal{T}_{\ell}} \leqslant h_{0}:=\max _{T \in \mathcal{T}_{0}} h_{T} \leqslant \varepsilon_{6}$, a triangle inequality implies

Theorem 3.1.a and (1.4) show $\left(\lambda / \lambda_{\ell}(k)\right)^{2}\left\|\tilde{h}_{\ell}^{m} \lambda_{\ell}(k) u_{\ell}\right\|_{L^{2}(\Omega)}^{2} \leqslant 4 \eta_{\ell}^{2}$. Corollary 2.1.a, Theorem 4.4, and (3.12) imply $\left\|u-u_{\ell}\right\|_{L^{2}(\Omega)}^{2} \leqslant h_{0}^{2 \sigma} C_{5}^{2} C_{\mathrm{rel}}^{2} \eta_{\ell}^{2}$. The substitution in (4.6) concludes the proof with $\Lambda_{4}:=\max \left\{C_{\mathrm{rel}}^{2}, C_{\mathrm{qo}}^{2} C_{\mathrm{sr}}^{2 m} \frac{4^{m / 3+1}}{4^{m / 3}-1}\left(4+h_{0}^{2 m+2 \sigma} C_{5}^{2} C_{\mathrm{rel}}^{2} \lambda^{2}\right)\right\}$ and $\widetilde{\Lambda}_{4}:=C_{\mathrm{rel}}^{2} \max \left\{1,2 C_{\mathrm{qo}}^{2}, C_{7}^{2}\right\}$.

## 5. Conclusion and comments

### 5.1. Proof of Theorem 1.1

The proven properties (A1)-(A4 $\varepsilon_{\varepsilon}$ ) are the axioms of adaptivity in [CFPP14, CR17] and known to imply (1.5). Compared to [CFPP14, CR17] the discrete reliability in Theorem 4.6 is extended in that $\left(\mathrm{A} 3_{\varepsilon}\right)$ includes the additional term $M_{3} h_{\max }^{2 \sigma} \eta^{2}(\mathcal{T})$. Minor modifications of the arguments in [CFPP14, CR17] prove that (A1) $-\left(\mathrm{A} 4_{\varepsilon}\right)$ imply (1.5). This is stated and proven as Theorem A. 1 in Appendix A for some $\varepsilon:=\varepsilon_{7} \leqslant \varepsilon_{6}$.

### 5.2. Optimal convergence rates of the error

The reliability and efficiency in Theorem 4.4 provide the equivalence $\left\|u-u_{\ell}\right\|_{\mathrm{pw}} \approx \eta_{\ell}\left(\mathcal{T}_{\ell}\right)$. This and Theorem 1.1 lead to optimal convergence rates for the error as well.

### 5.3. Global convergence

This paper on the asymptotic convergence rates justifies that a small initial mesh-size guarantees the asymptotic convergence from the beginning. Although the reasons are presented in several steps for $\varepsilon_{0}, \ldots, \varepsilon_{7}$, the computation of $\varepsilon_{7}$ may be cumbersome and a huge overestimation in practice. To guarantee global convergence without a priori knowledge of $\varepsilon_{7}$, we may modify the marking step in AFEM4EVP as follows: Enlarge the set $\mathcal{M}_{\ell}$ in AFEM4EVP by one tetrahedron of maximal mesh-size in $\mathcal{T}_{\ell}$. This guarantees that the maximal mesh-size tends to zero as the level $\ell \rightarrow \infty$. Consequently there exists some $L \in \mathbb{N}$ such that $\mathcal{T}_{\ell} \in \mathbb{T}\left(\varepsilon_{7}\right)$ for all $\ell=L, L+1, L+2, \ldots$ Relabel $\mathcal{T}_{L}$ by $\mathcal{T}_{0}$ so that Theorem 1.1 leads to optimal convergence rates for $\eta_{L}, \eta_{L+1}, \eta_{L+2}, \ldots$, whence for the entire outcome of the adaptive algorithm. However, the constant in the overhead control [Ste08, Thm. 6.1] depends on $\mathcal{T}_{L}$ and this possibly enlarges the equivalence constants in (1.5).

### 5.4. Numerical experiments

Numerical experiments in [CP21, CEP21] show an asymptotic convergences of AFEM4EVP with $\theta=0.5$ even for coarse initial triangulation and confirm the optimal convergence rates of Theorem 1.1 even for one example with a multiple eigenvalue. The extension to eigenvalue clusters requires an algorithm from [Gal15b, DHZ15, BGGG17]. This paper assumes exact solve of the algebraic eigenvalue problem (1.2), but perturbation results in numerical linear algebra [Par98] can be included as in [CG12].

## A. Appendix - A review and extension of the axioms of adaptivity

The framework (A1)-(A4 $\varepsilon_{\varepsilon}$ in Section 4 is a modification of [CFPP14, CR17] with a more general discrete reliability $\left(\mathrm{A} 3_{\varepsilon}\right)$. Theorem A. 1 below proves that the modified axioms are sufficient for optimal convergence rates of the AFEM algorithm with Dörfler marking and newest-vertex bisection [CFPP14, Algorithm 2.2]. On level $\ell \in \mathbb{N}_{0}$ of the general purpose adaptive algorithm AFEM there is given a regular triangulation $\mathcal{T}_{\ell}$ of $\Omega \subset \mathbb{R}^{n}$ into closed simplices and an undisplayed discrete problem with a discrete solution $u_{\ell}$. These allow for the computation of $\eta_{\ell}(T)$ for all $T \in \mathcal{T}_{\ell}$ in the step compute. The step mark uses the sum convention $\eta_{\ell}^{2}(\mathcal{M}):=\sum_{T \in \mathcal{M}} \eta_{\ell}^{2}(T)$ for any $\mathcal{M} \subseteq \mathcal{T}_{\ell}$ and $\eta_{\ell}^{2}:=\eta_{\ell}^{2}\left(\mathcal{T}_{\ell}\right)$. The selection of a set $\mathcal{M}_{\ell}$ with almost minimal cardinality in this step means that there exists a constant $\Lambda_{\mathrm{opt}} \geqslant 1$ such that the cardinality satisfies $\left|\mathcal{M}_{\ell}\right| \leqslant \Lambda_{\text {opt }}\left|\mathcal{M}_{\ell}^{\star}\right|$, where $\mathcal{M}_{\ell}^{\star} \subset \mathcal{T}_{\ell}$ denotes some set of minimal cardinality $\left|\mathcal{M}_{\ell}^{\star}\right|$ with $\theta \eta_{\ell}^{2} \leqslant \sum_{T \in \mathcal{M}_{\ell}^{*}} \eta_{\ell}^{2}(T)$; cf. [Ste07, CFPP14, CR17] for details; this is more general than in AFEM4EVP, which utilizes a minimal set $M_{\ell}$ with $\Lambda_{\text {opt }}=1$ constructed at linear cost in [PP20].

This appendix is written in a self-contained way based on the set $\mathbb{T}:=\mathbb{T}\left(\mathcal{T}_{0}\right)$ of all admissible triangulation computed by successive newest-vertex bisection [Ste08, GSS14] of a regular initial triangulation $\mathcal{T}_{0}$ (plus some initialization of tagged $n$-simplices) of the bounded polyhedral Lipschitz domain $\Omega \subset \mathbb{R}^{n}$ into closed simplices and the subset $\mathbb{T}(\mathcal{T})$ of admissible refinements of $\mathcal{T} \in \mathbb{T}$. For $N \in \mathbb{N}_{0}$, set $\mathbb{T}(N):=\left\{\mathcal{T} \in \mathbb{T}:|\mathcal{T}| \leqslant\left|\mathcal{T}_{0}\right|+N\right\}$. To analyse the error estimates $\eta_{\ell}\left(\mathcal{T}_{\ell}\right)$ and their rates and in particular to compare with error estimators $\eta(\mathcal{T}, \bullet)$ for any admissible triangulation $\mathcal{T} \in \mathbb{T}$, we need to assume that the error estimators are computable for any $\mathcal{T} \in \mathbb{T}$. This leads to a family $\eta(\mathcal{T}, \bullet) \in \mathbb{R}^{\mathcal{T}}$ of error estimators parametrized by $\mathcal{T} \in \mathbb{T}$ with $\eta(\mathcal{T}, K) \geqslant 0$ for all $K \in \mathcal{T}$. For any subset $\mathcal{M} \subseteq \mathcal{T} \in \mathbb{T}$, the sum convention reads

Theorem A. 1 below contains smallness assumptions for the constants $\hat{\Lambda}_{3}, \epsilon_{3}$, and $\epsilon_{4}$. In a typical application such as Theorem 1.1 the quantities $\widehat{\Lambda}_{3}, \epsilon_{3}, \epsilon_{4}$ contain a power of the initial mesh-size $h_{0}:=\max _{T \in \mathcal{T}_{0}} h_{T}$ such that the assumptions are satisfied for a sufficiently fine initial triangulation $\mathcal{T}_{0}$. Given $\epsilon_{3}<\Lambda_{1}^{-2}$, set $\Theta:=\left(1-\Lambda_{1}^{2} \epsilon_{3}\right) /\left(1+\Lambda_{1}^{2} \Lambda_{3}\right)$. Any choice of $\mu$ and $\xi$ with $0<\mu<\rho_{2}^{-2}-1$ and $0<\xi<\left(1-(1+\mu) \rho_{2}^{2}\right) \Theta /(1-\Theta)$ implies

The proof of Theorem A. 1 reviews parts of the analysis in [CFPP14, CR17] and focusses on the relevant extensions in Theorem A. 2 and Lemma A. 3 below. The following results (A12), (A4), and (2) follow verbatim as in [CFPP14, CR17]: (A1)-(A2) and the Dörfler marking strategy with bulk parameter $\theta<\Theta<1$ provide the estimator reduction [CR17, Thm. 4.1]

On the other hand, (A1)-(A3) are sufficient for the quasimonotonicity ( QM ) and the comparison lemma. But the discrete reliability is relaxed in $\left(\mathrm{A} \varepsilon_{\varepsilon}\right)$ in this paper, so the proofs of (QM) and the comparison lemma are revisited below.
Theorem A. $2(\mathrm{QM})$. with $(a+b)^{2} \leqslant(1+\alpha) a^{2}+(1+1 / \alpha) b^{2}$ for any positive $a, b$ and $0<\alpha<\left(\left(\Lambda_{1}^{2}+\Lambda_{2}^{2}\right) \hat{\Lambda}_{3}\right)^{-1}-1$ in the second step. (For $\widehat{\Lambda}_{3}=0$, the upper bound for $0<\alpha<\infty$ is understood as infinity.) The Axiom $\left(\mathrm{A} 3_{\varepsilon}\right)$ controls the distance $\delta^{2}(\mathcal{T}, \widehat{\mathcal{T}})$ and leads to

The convergence is guaranteed with (2) and the optimality requires the sufficient smallness of the bulk parameter $\theta<\Theta$ in the adaptive algorithm. This enters with the help of the comparison lemma, where some $\theta_{0}(\varkappa, \alpha)$ depends on parameter $\varkappa, \alpha$ that allow for $\theta \leqslant \theta_{0}(\varkappa, \alpha)<\Theta$. The lemma dates back to the seminal contribution [Ste07].

The proof of Theorem A. 1 can be concluded as in [CFPP14, Proof of Theorem 4.1 (ii)] or [CR17, Section 4.3]. The function $\theta_{0}(\alpha, \varkappa)$ in Lemma A.3.b is bounded from above by $\lim _{\alpha \rightarrow \infty} \theta_{0}(0, \alpha)=\left(1-\Lambda_{1}^{2} \epsilon_{3}\right) /\left(1+\Lambda_{1}^{2} \Lambda_{3}\right)$ and there exist a choice of $0<\varkappa<1$ and $0<\alpha<\infty$ such that $0<\theta<\theta_{0}(\alpha, \varkappa)<\Theta$. This is the first formula on page 2655 in [CR17] and the remaining parts of the proof are summarized below for convenient reading and almost verbatim to Case A in [CR17]. The choice of $\theta$ and Lemma A.3.b show

For the proof of the converse implication, assume, without loss of generality, that $0<$ $\min _{\mathcal{T} \in \mathbb{T}(N)} \eta(\mathcal{T})$ and so $0<\eta_{\ell}$ for any $\ell \in \mathbb{N}_{0}$ with $N_{\ell}:=\left|\mathcal{T}_{\ell}\right|-\left|\mathcal{T}_{0}\right| \leqslant N$. AFEM leads to $N_{\ell}<N_{\ell+1}$ (since no refinement only occurs for $\eta_{\ell}=0$ ). Hence there exists a level $\ell$ with $N_{\ell}<N \leqslant N_{\ell+1}$ and $(N+1)^{s} \min _{\mathcal{T} \in \mathbb{T}(N)} \eta(\mathcal{T}) \leqslant\left(N_{\ell+1}+1\right)^{s} \eta_{\ell}$. On each refinement level $\ell$ each simplex creates at most a finite number $K(n)$ (depending only on the spatial dimension $n$ ) of children in the next level $\ell+1$ [GSS14]. In other words $\left|\mathcal{T}_{\ell+1}\right| \leqslant K(n)\left|\mathcal{T}_{\ell}\right|$ and $\left(N_{\ell+1}+1\right) /\left(N_{\ell}+1\right) \leqslant K(n)+(K(n)-1)\left(\left|\mathcal{T}_{0}\right|-1\right) \lesssim 1$. This concludes the proof of rate optimality for AFEM in Theorem A.1.
Proof of Theorem 1.1. Once $\rho_{12}$ and $\Lambda_{12}$ have been selected, abbreviate $c_{3}:=\left(1-\rho_{12}\right) /\left(2 \Lambda_{12} \widetilde{\Lambda}_{4}\right), \beta:=\min \left\{C_{\text {eff }}^{2} / C_{\text {rel }}^{2}, c_{3} / 2\right\}$, and

$$
\begin{equation*}
\varepsilon:=\varepsilon_{7}:=\min \left\{\varepsilon_{6},\left(2 \Lambda_{1}^{2} M_{3}\right)^{-1 /(2 \sigma)},\left(\left(c_{3}-\beta\right) /(1+1 / \beta)\right)^{1 /(2 \sigma)}\right\} . \tag{9}
\end{equation*}
$$

Then $\hat{\Lambda}_{3}\left(\Lambda_{1}^{2}+\Lambda_{2}^{2}\right)=0, \epsilon_{3} \Lambda_{1}^{2} \leqslant 1 / 2$, and $\epsilon_{4} \leqslant\left(1-\rho_{12}\right) /\left(2 \Lambda_{12}\right)$ in Theorem A.1.
Remark A. 4 (smallness assumptions on $\varepsilon_{5}, \varepsilon_{6}, \varepsilon_{7}$ ) The reduction to $\varepsilon_{5}$ guarantees the best approximation result in Theorem 3.1, while $\varepsilon_{6}:=\min \left\{\varepsilon_{5},\left(2 C_{5}^{2}\right)^{-1 /(2 \sigma)}\right\}$ is sufficient for reliability in Theorem 4.4. Optimal rates follow with $\varepsilon:=\varepsilon_{7}$ from (9). Since $C_{5}$ from (3.12), $c_{3}:=\left(1-\rho_{12}\right) /\left(2 \Lambda_{12} \widetilde{\Lambda}_{4}\right)$, and $M_{3}$ are bounded $\mathcal{O}(1)$, independent of the mesh-size, $\varepsilon_{6}=\min \left\{\varepsilon_{5}, \mathcal{O}(1)\right\}$ and $\varepsilon_{7}=\min \left\{\varepsilon_{6}, \mathcal{O}(1)\right\}$ are not expected to be dramatically smaller than $\varepsilon_{5}$.

Remark A. 5 (modification with global convergence) The modified algorithm of Subsection 5.3, with $\mathcal{T}_{L}, \mathcal{T}_{L+1}, \ldots$ has no influence on the constants $1 / 2 \leqslant \Theta\left(1+\Lambda_{1}^{2}+\Lambda_{3}\right) \leqslant 1, \Lambda_{4} \leqslant \Lambda_{\mathrm{qo}} \leqslant$ $2 \Lambda_{4}+1 / \Lambda_{12}, 1+\left(\Lambda_{1}^{2}+\Lambda_{2}^{2}\right) \Lambda_{3} \leqslant \Lambda_{\text {mon }}^{2} \leqslant\left(1+\sqrt{\left(\Lambda_{1}^{2}+\Lambda_{2}^{2}\right)\left(\Lambda_{3}+\Lambda_{1}^{-2} / 2\right)}\right)^{2}$. But $\Lambda_{\text {BDdV }}$ in the overhead control (6) (e.g. [Ste08, Thm. 6.1]) depends on $\mathcal{T}_{L}$ and could become larger (when replacing $\mathcal{T}_{0}$ by $\mathcal{T}_{L}$ ) and leads to larger equivalence constants in Theorem A.1. Fortunately, the asymptotic convergence rate remains optimal and the choice of $\theta$ is not affected.

Remark A. 6 (parameter choice in praxis) In a practical computation, we suggest uniform mesh-refinement until the eigenvalue $\lambda_{k}$ of interest is resolved in that $5 h_{\text {max }}$ is smaller or equal the estimated wavelength of $\lambda_{k}$. This triangulation serves as initial triangulation in $\mathcal{T}_{0}$ in the modified algorithm of Subsection 5.3 with some bulk parameter $\theta$ smaller than $\left(1-\Lambda_{1}^{2} \Lambda_{3}\right)^{-1}$. In this way, the pre-asymptotic range is (hopefully) kept small while the asymptotic convergence rate remains optimal.
