# A DUALITY THEOREM FOR THE IC-RESURGENCE OF EDGE IDEALS 

RAFAEL H. VILLARREAL


#### Abstract

The aim of this work is to use linear programming and polyhedral geometry to prove a duality formula for the ic-resurgence of edge ideals. We show that the ic-resurgence of the edge ideal $I$ of a clutter $\mathcal{C}$ and the ic-resurgence of the edge ideal $I^{\vee}$ of the blocker $\mathcal{C}^{\vee}$ of $\mathcal{C}$ coincide. If $\mathcal{C}$ is the clutter of bases of certain uniform matroids, we recover a formula for the resurgence of $I$, and if $\mathcal{C}$ is a connected non-bipartite graph with a perfect matching, we show a formula for the Waldschmidt constant of $I^{\vee}$.


## 1. Introduction

Let $\mathcal{C}$ be a clutter with vertex set $V(\mathcal{C})=\left\{t_{1}, \ldots, t_{s}\right\}$, that is, $\mathcal{C}$ is a family of subsets $E(\mathcal{C})$ of $V(\mathcal{C})$, called edges, none of which is contained in another [11]. We assume that all edges of $\mathcal{C}$ have at least two vertices. For example, a graph (no multiple edges or loops) is a clutter. Regarding each vertex $t_{i}$ as a variable, we consider the polynomial ring $S=K\left[t_{1}, \ldots, t_{s}\right]$ over a field $K$. The monomials of $S$ are denoted by $t^{a}:=t_{1}^{a_{1}} \cdots t_{s}^{a_{s}}, a=\left(a_{1}, \ldots, a_{s}\right)$ in $\mathbb{N}^{s}$, where $\mathbb{N}=\{0,1, \ldots\}$. The edge ideal of $\mathcal{C}$, denoted $I(\mathcal{C})$, is the ideal of $S$ given by

$$
I(\mathcal{C}):=\left(\left\{\prod_{t_{i} \in e} t_{i} \mid e \in E(\mathcal{C})\right\}\right)
$$

The minimal set of generators of $I(\mathcal{C})$, denoted $G(I(\mathcal{C}))$, is the set of all squarefree monomials $t_{e}=\prod_{t_{i} \in e} t_{i}$ such that $e \in E(\mathcal{C})$. Any squarefree monomial ideal $I$ of $S$ is the edge ideal $I(\mathcal{C})$ of a clutter $\mathcal{C}$ with vertex set $V(\mathcal{C})=\left\{t_{1}, \ldots, t_{s}\right\}$. A set of vertices $C$ of $\mathcal{C}$ is called a vertex cover if every edge of $\mathcal{C}$ contains at least one vertex of $C$. A minimal vertex cover of $\mathcal{C}$ is a vertex cover which is minimal with respect to inclusion. The clutter of minimal vertex covers of $\mathcal{C}$, denoted $\mathcal{C}^{\vee}$, is called the blocker of $\mathcal{C}$, and the edge ideal $I\left(\mathcal{C}^{\vee}\right)$ of $\mathcal{C}^{\vee}$ is called the Alexander dual of $I(\mathcal{C})$ and is denoted by $I(\mathcal{C})^{\vee}$ [40, p. 221]. We assume that $|C| \geq 2$ for all $C \in E\left(\mathcal{C}^{\vee}\right)$.

We denote the edge ideal $I(\mathcal{C})$ of $\mathcal{C}$ by $I$ and denote the minimal set of generators of $I$ by $G(I):=\left\{t^{v_{1}}, \ldots, t^{v_{q}}\right\}$. The incidence matrix of $I$, denoted by $A$, is the $s \times q$ matrix with column vectors $v_{1}, \ldots, v_{q}$. This matrix is the incidence matrix of $\mathcal{C}$. The covering polyhedron of $I$, denoted by $\mathcal{Q}(I)$, is the rational polyhedron

$$
\mathcal{Q}(I):=\{x \mid x \geq 0 ; x A \geq 1\},
$$

where $1=(1, \ldots, 1)$. The map $E\left(\mathcal{C}^{\vee}\right) \rightarrow\{0,1\}^{s}, C \mapsto \sum_{t_{i} \in C} e_{i}$, induces a bijection between $E\left(\mathcal{C}^{\vee}\right)$ and the set $\left\{u_{1}, \ldots, u_{m}\right\}$ of integral vertices of $\mathcal{Q}(I)$ [40, Corollary 13.1.3]. Given an integer $n \geq 1$, the $n$-th symbolic power of $I$, denoted $I^{(n)}$, is given by [18, p. 78]:

I^{(n)}=\left(\left\{t^{a} \mid a / n \in \mathcal{Q}\left(I^{\vee}\right)\right\}\right)=\left(\left\{t^{a} \mid\left\langle a, u_{i}\right\rangle \geq n \text { for } i=1, \ldots, m\right\}\right), \tag{1.1}
\end{equation*}
$$

[^0]where $\langle$,$\rangle denotes the ordinary inner product. The Newton polyhedron of I$, denoted $\mathrm{NP}(I)$, is the integral polyhedron
$$
\mathrm{NP}(I)=\mathbb{R}_{+}^{s}+\operatorname{conv}\left(v_{1}, \ldots, v_{q}\right)
$$
where $\mathbb{R}_{+}=\{\lambda \in \mathbb{R} \mid \lambda \geq 0\}$. It is well known that $\operatorname{NP}(I)$ is equal to
$$
\mathcal{Q}(\bar{B}):=\{x \mid x \geq 0 ; x \bar{B} \geq 1\}
$$
where $\bar{B}$ is the rational matrix whose columns are precisely the vertices $u_{1}, \ldots, u_{p}$ of the covering polyhedron $\mathcal{Q}(I)$ of $I$ [18, Proposition $3.5(\mathrm{~b})]$. Note that $m \leq p$, that is, not all vertices of $\mathcal{Q}(I)$ are integral. The integral closure of $I^{n}$, denoted $\overline{I^{n}}$, can be described as

\overline{I^{n}}=\left(\left\{t^{a} \mid a / n \in \operatorname{NP}(I)\right\}\right)=\left(\left\{t^{a} \mid\left\langle a, u_{i}\right\rangle \geq n \text { for } i=1, \ldots, p\right\}\right) \tag{1.2}
\end{equation*}
$$

\]

for every $n \geq 1$ [18, Proposition 3.5(a)]. If $I^{n}=\overline{I^{n}}$ for all $n \geq 1, I$ is said to be normal.
The resurgence and asymptotic resurgence of ideals were introduced in [5, 22]. The resurgence of an ideal relative to the integral closure was introduced in [13]. We define the resurgence, asymptotic resurgence, and ic-resurgence of $I$ to be

$$
\begin{aligned}
& \rho(I):=\sup \left\{n / r \mid I^{(n)} \not \subset I^{r}\right\}, \\
& \widehat{\rho}(I):=\sup \left\{n / r \mid I^{(n t)} \not \subset I^{r t} \text { for all } t \gg 0\right\}, \\
& \quad \rho_{i c}(I):=\sup \left\{n / r \mid I^{(n)} \not \subset \overline{I^{r}}\right\}, \text { respectively. }
\end{aligned}
$$

In general, $\rho(I) \geq \rho_{i c}(I)$ and $\widehat{\rho}(I)=\rho_{i c}(I)$ [13, Corollary 4.14]. In particular $\widehat{\rho}(I)$ is $\rho(I)$ if $I$ is normal. A related well studied invariant is $\widehat{\alpha}(I)$, the Waldschmidt constant of $I$ [10, 13]:

$$
\widehat{\alpha}(I):=\lim _{n \rightarrow \infty} \frac{\alpha\left(I^{(n)}\right)}{n},
$$

where $\alpha\left(I^{(n)}\right)$ is the least degree of a minimal generator of $I^{(n)}$. Let $B$ be the incidence matrix of $I^{\vee}$. Note that the columns of $B$ are $u_{1}, \ldots, u_{m}$. The number $\widehat{\alpha}(I)$ is the optimal value of the linear program

$$
\begin{aligned}
& \operatorname{minimize} y_{1}+\cdots+y_{s} \\
& \text { subject to } \\
& y B \geq 1 \text { and } y \geq 0
\end{aligned}
$$

which is attained at a vertex of $\mathcal{Q}\left(I^{\vee}\right)$ [4, Theorem 3.2]. If $\alpha(\mathcal{Q}(I))$ is the minimum of all $|a|=\sum_{i=1}^{s} a_{i}$ with $a=\left(a_{1}, \ldots, a_{s}\right)$ a vertex of $\mathcal{Q}(I)$, then $\widehat{\alpha}\left(I^{\vee}\right)=\alpha(\mathcal{Q}(I))$ [10, Corollary 6.3].

It is known that the ic-resurgence of the edge ideal $I(G)$ of a graph $G$ can be expressed in terms of the vertices of $\mathcal{Q}\left(I(G)^{\vee}\right)$. The following formula was given in [13, Theorem 3.12]:

$$
\rho_{i c}(I(G))=\widehat{\rho}(I(G))=\frac{2}{\widehat{\alpha}(I(G))}=\frac{2}{\alpha\left(\mathcal{Q}\left(I(G)^{\vee}\right)\right)} \geq 1 .
$$

Our main result is a formula for the ic-resurgence $\rho_{i c}(I)$ of $I$ in terms of the vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ (Theorem [3.7).

As we now explain computing the ic-resurgence $\rho_{i c}(I)$ of the ideal $I$ is a linear-fractional programming problem [7]. Let $V(\mathcal{Q}(I))=\left\{u_{1}, \ldots, u_{p}\right\}$ be the vertex set of $\mathcal{Q}(I)$, we can write $u_{i}=\gamma_{i} / d_{i}, \gamma_{i} \in \mathbb{N}^{s} \backslash\{0\}, d_{i} \in \mathbb{N}_{+}$for all $i$ (Section (3). Recall that we may assume that $d_{i}=1$ for $i=1, \ldots, m$, i.e., $u_{1}, \ldots, u_{m}$ are the characteristic vectors of the minimal vertex covers of $\mathcal{C}$
and $m \leq p$. By Eqs. (1.1)-(1.2), a monomial $t^{a}$ is in $I^{(n)} \backslash \overline{I^{r}}$ if and only if $a / n \in \mathcal{Q}\left(I^{\vee}\right)$ and $a / r \notin \mathrm{NP}(I)$, that is, $t^{a}$ is in $I^{(n)} \backslash \overline{I^{r}}$ if and only if $a=\left(a_{1}, \ldots, a_{s}\right)$ satisfies

$$
\begin{equation*}
\left\langle a, u_{i}\right\rangle \geq n \text { for } i=1, \ldots, m \text { and }\left\langle a, \gamma_{j}\right\rangle \leq r d_{j}-1 \text { for some } 1 \leq j \leq p \tag{1.3}
\end{equation*}
$$

Let $x_{1}, \ldots, x_{s}$ be variables that correspond to the entries of $a$ and let $x_{s+1}, x_{s+2}$ be two extra variables that correspond to $n$ and $r$, respectively. By Eq. (1.3), $t^{a}$ is in $I^{(n)} \backslash \overline{I^{r}}$ if and only if there exists $1 \leq j \leq p$ such that $(a, n, r)$ is a feasible point for the linear-fractional program:

$$
\begin{array}{cl}
\operatorname{maximize} & h_{j}(x)=\frac{x_{s+1}}{x_{s+2}} \\
\text { subject to } & \left\langle\left(x_{1}, \ldots, x_{s}\right), u_{i}\right\rangle-x_{s+1} \geq 0, i=1, \ldots, m, x_{s+1} \geq 1  \tag{1.4}\\
& x_{i} \geq 0, i=1, \ldots, s \\
& d_{j} x_{s+2}-\left\langle\left(x_{1}, \ldots, x_{s}\right), \gamma_{j}\right\rangle \geq 1, x_{s+2} \geq 1
\end{array}
$$

This type of program can be solved using linear programming [7, Section 4.3.2, p. 151]. The linear-fractional program of Eq. (1.4) is equivalent to the linear program of Eq. (1.5) below [21, p. 18]. The next result solves the problem of computing the ic-resurgence of $I$. An algorithm to compute $\rho_{i c}(I)$ has been implemented in Macaulay 2 using its interface to Normaliz [8 (see [21, Procedure A.3, Algorithm A.4]). We use the next result to prove a duality formula for the ic-resurgence of $I$ that implies the equality $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)$.

Theorem 1.1. [21, Theorem 5.3] For each $1 \leq j \leq p$, let $\rho_{j}$ be the optimal value of the following linear program with variables $y_{1}, \ldots, y_{s+3}$. Then, $\rho_{i c}(I)=\max \left\{\rho_{j}\right\}_{j=1}^{p}$ and $\rho_{j}$ is attained at a rational vertex of the polyhedron $\mathcal{P}_{j}$ of feasible points of Eq. (1.5).

$$
\begin{array}{ll}
\text { maximize } & g_{j}(y)=y_{s+1} \\
\text { subject to } & \left\langle\left(y_{1}, \ldots, y_{s}\right), u_{i}\right\rangle-y_{s+1} \geq 0, i=1, \ldots, m, y_{s+1} \geq y_{s+3}  \tag{1.5}\\
& y_{i} \geq 0, i=1, \ldots, s, y_{s+3} \geq 0 \\
& d_{j} y_{s+2}-\left\langle\left(y_{1}, \ldots, y_{s}\right), \gamma_{j}\right\rangle \geq y_{s+3}, y_{s+2}=1 .
\end{array}
$$

First, we determine all vertices $y$ of $\mathcal{P}_{j}$ with $y_{s+1}>0$ and relate them with the vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$. To introduce our result, let $V\left(\mathcal{Q}\left(I^{\vee}\right)\right)=\left\{v_{1}, \ldots, v_{p_{1}}\right\}$ be the vertex set of $\mathcal{Q}\left(I^{\vee}\right)$, we can write $v_{i}=\delta_{i} / f_{i}, \delta_{i} \in \mathbb{N}^{s} \backslash\{0\}, f_{i} \in \mathbb{N}_{+}$for all $i$ (Section (3). Recall that we may assume that $f_{i}=1$ for $i=1, \ldots, q$, i.e., $v_{1}, \ldots, v_{q}$ are the characteristic vectors of the edges of $\mathcal{C}$ and $q \leq p_{1}$. We introduce the Rees cones of $I$ and $I^{\vee}$ as a device to compute the vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$, and the linear constraints that define the Newton polyhedron of $I$ (Theorems (3.1)-(3.4)). Then, we collect some basic properties of $\mathcal{P}_{j}$ showing that $\mathcal{P}_{j}$ could be unbounded, and proving that $\rho_{j} \leq d_{j}$ and $\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \geq d_{i} \geq 1$ for all $i, \ell$ (Lemma 3.5).

We come to our main auxiliary result.
Theorem 3.6. Let $y=\left(y_{1}, \ldots, y_{s+3}\right)$ be a point in $\mathbb{R}^{s+3}$ with $y_{s+1}>0$ and let $1 \leq j \leq p$, then $y$ is a vertex of $\mathcal{P}_{j}$ if and only if $y$ has one of the following two forms:
(a) $y=\left(y_{s+1}\left(\delta_{k} / f_{k}\right), y_{s+1}, 1,0\right)$, where $y_{s+1}=d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle$ and $1 \leq k \leq p_{1}$, or
(b) $y=\left(y_{s+1}\left(\delta_{k} / f_{k}\right), y_{s+1}, 1, y_{s+1}\right)$, where $y_{s+1}=d_{j} f_{k} /\left(\left\langle\gamma_{j}, \delta_{k}\right\rangle+f_{k}\right)$ and $1 \leq k \leq p_{1}$.

The first evidence that the equality $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)$ could be true came from [13] and [21, 26] where it is shown that for the edge ideal $I(G)$ of a perfect graph $G$, one has

$$
\rho_{i c}(I(G))=\frac{2(\omega(G)-1)}{\omega(G)}=\rho_{i c}\left(I(G)^{\vee}\right),
$$

respectively, where $\omega(G)$ is the clique number of $G$, that is, $\omega(G)$ is the number of vertices in a maximum complete subgraph of $G$. If $G$ is a perfect graph, then $\rho\left(I(G)^{\vee}\right)$ is equal to $\rho_{i c}\left(I(G)^{\vee}\right)$ because $I(G)^{\vee}$ is normal [38, Theorem 2.10].

We come to our main result.
Theorem 3.7. (Duality formula) If $I$ is the edge ideal of a clutter $\mathcal{C}$, then

$$
\frac{1}{\rho_{i c}(I)}=\min \left\{\langle u, v\rangle \mid u \in V(\mathcal{Q}(I)), v \in V\left(\mathcal{Q}\left(I^{\vee}\right)\right)\right\}
$$

where $V(\mathcal{Q}(I))$ is the vertex set of $\mathcal{Q}(I)$. In particular, $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)$.
A covering polyhedron is integral if and only if it has only integral vertices [30, p. 232]. The ic-resurgence of $I$ classifies the integrality of the covering polyhedron $\mathcal{Q}(I)$ because $\rho_{i c}(I)=1$ if and only if $\mathcal{Q}(I)$ is integral (Proposition [3.8). As a consequence of the duality formula for the ic-resurgence, we recover the fact that $\mathcal{Q}(I)$ is integral if and only if $\mathcal{Q}\left(I^{\vee}\right)$ is integral [11, Theorem 1.17] (Corollary (3.9), and recover two results of Jayanthan, Kumar and Mukundan [26, Theorems 4.8 and 5.3] showing that when $I(G)$ is the edge ideal of a graph $G$ the following conditions are equivalent
(a) $\rho(I(G))=1$;
(b) $\rho_{i c}(I(G))=1$;
(c) $G$ is bipartite;
(d) $\rho\left(I(G)^{\vee}\right)=1$;
see Corollary 3.10. Then, we show a formula for the ic-resurgence of the sum of two edge ideals of clutters generated by monomials in disjoint sets of variables (Corollary 3.11). A similar formula is known for the Waldschmidt constant (Remark 3.121). If $G$ is a connected non-bipartite graph with a perfect matching, we show that $\widehat{\alpha}\left(I(G)^{\vee}\right)=|V(G)| / 2$ (Proposition 3.17).

To compute the vertices of the covering polyhedron $\mathcal{Q}(I)$ of the edge ideal $I$ of a clutter $\mathcal{C}$, we have used Theorems 3.1 and 3.2, see Procedure A.1. Another way to compute the vertices of $\mathcal{Q}(I)$ is to find the extreme rays, i.e., the 1-dimensional faces of the following polyhedral cone

$$
\mathrm{SC}\left(I^{\vee}\right):=\left\{x \in \mathbb{R}^{s+1} \mid x \geq 0 ;\left\langle x,\left(v_{i},-1\right)\right\rangle \geq 0 \text { for } i=1, \ldots, q\right\}
$$

see [21, Proposition 3.15]. The cone $\mathrm{SC}\left(I^{\vee}\right)$ is called the Simis cone of $I^{\vee}$ [15]. For a discussion on how to find all vertices of a general polyhedron we refer to [2, 3].

The algebraic properties and invariants of the ideal $I=I_{d, s}$, generated by all squarefree monomials of $S$ of degree $d$ in $s$ variables, were studied in [1, 4, 16, 37, 39]. This ideal is normal [37] and its Alexander dual $I^{\vee}$ is equal to $I_{s-d+1, s}$. The minimal generators of $I$ correspond to the bases of a matroid of rank $d$. The statement about resurgence in Theorem 3.19 is due originally to Lampa-Baczyńska and Malara [28, Theorem C]. In a more general form, it appears in a paper by Geramita, Harbourne, Migliore and Nagel [16, Theorem 4.8]. The Waldschmidt constant of $I$ was computed in [4, Theorem 7.5]. Using the Rees cones of $I$ and $I^{\vee}$, we compute the vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ and use Theorem 3.7 to recover the formulas for $\rho(I)$ and $\widehat{\alpha}(I)$. Theorem 3.19, [4, 28] The resurgence and ic-resurgence of $I_{s, d}$ and $I_{s, d}^{\vee}$ are given by

$$
\rho\left(I_{d, s}\right)=\rho_{i c}\left(I_{d, s}\right)=\rho_{i c}\left(\left(I_{d, s}\right)^{\vee}\right)=\frac{d(s-d+1)}{s}=\frac{d}{\widehat{\alpha}\left(I_{d, s}\right)}=\frac{s-d+1}{\widehat{\alpha}\left(\left(I_{d, s}\right)^{\vee}\right)} .
$$

In Section 4 we present examples illustrating our results. Then in Appendix A we give the procedures for Macaulay2 [20], that are used in the examples.

For unexplained terminology and additional information, we refer to [12, 25, 34, 35] for the theory of integral closure, [23, 40] for the theory of edge ideals and monomial ideals, and [27, 30, 31 for combinatorial optimization and integer programing.

## 2. Preliminaries

In this section we introduce a few results from polyhedral geometry and commutative algebra. We continue to employ the notations and definitions used in Section 1 .

Given $a \in \mathbb{R}^{s} \backslash\{0\}$ and $c \in \mathbb{R}$, the affine hyperplane $H(a, c)$ and the positive closed halfspace $H^{+}(a, c)$ bounded by $H(a, c)$ are defined as

$$
H(a, c):=\left\{x \in \mathbb{R}^{s} \mid\langle x, a\rangle=c\right\} \text { and } H^{+}(a, c):=\left\{x \in \mathbb{R}^{s} \mid\langle x, a\rangle \geq c\right\} .
$$

If $c=0, H_{a}$ will denote $H(a, c)$ and $H_{a}^{+}$will denote $H^{+}(a, c)$. If $a$ and $c$ are rational, $H^{+}(a, c)$ is called a rational closed halfspace.

A rational polyhedron is a subset of $\mathbb{R}^{s}$ which is the intersection of a finite number of rational closed halfspaces of $\mathbb{R}^{s}$. Let $\Gamma$ be a subset of $\mathbb{R}^{s}$. The cone generated by $\Gamma$, denoted $\mathbb{R}_{+} \Gamma$, is the set of all linear combinations of $\Gamma$ with coefficients in the set $\mathbb{R}_{+}$of nonnegative real numbers. The finite basis theorem asserts that a subset $\mathcal{U}$ of $\mathbb{R}^{s}$ is a rational polyhedron if and only if

$$
\mathcal{U}=\mathbb{R}_{+} \Gamma+\mathcal{P},
$$

where $\mathbb{R}_{+} \Gamma$ is a cone generated by a finite set $\Gamma$ of rational points and $\mathcal{P}$ is the convex hull $\operatorname{conv}(\mathcal{A})$ of a finite set $\mathcal{A}$ of rational points [30, Corollary 7.1b]. The computer programs Normaliz [8] and PORTA [9] can be used to switch between these two representations.

Theorem 2.1. [6, Theorem 4.3] Let $I$ be a squarefree monomial ideal. If $\mathcal{Q}(I)$ is integral, then $\widehat{\alpha}(I)=\alpha(I)$ and $\widehat{\alpha}\left(I^{\vee}\right)=\alpha\left(I^{\vee}\right)$.

Theorem 2.2. Let I be a squarefree monomial ideal. The following hold.
(a) [19] $I^{n}=I^{(n)}$ for all $n \geq 1$ if and only if $\mathcal{Q}(I)$ is integral and $I$ is normal.
(b) [19, 33] $\overline{I^{n}}=I^{(n)}$ for all $n \geq 1$ if and only if $\mathcal{Q}(I)$ is integral.

## 3. Duality formula for the ic-RESURGENCE

In this part we give a duality formula for the ic-resurgence of edge ideals of clutters. To avoid repetitions, we continue to employ the notations and definitions used in Sections 1 and 2.

Let $S=K\left[t_{1}, \ldots, t_{s}\right]$ be a polynomial ring over a field $K$, let $I \subset S$ be the edge ideal of a clutter $\mathcal{C}$, and let $G(I)=\left\{t^{v_{1}}, \ldots, t^{v_{q}}\right\}$ be the minimal set of generators of $I$. To study $\rho_{i c}(I)$, we need a convenient way to determine the polyhedron $\mathcal{P}_{j}$ of feasible points of the linear program of Theorem 1.1 for $1 \leq j \leq p$. Our approach is based on the computation of the supporting hyperplanes of the Rees cone of $I$ which is the finitely generated rational cone defined as [15):

\begin{equation*}
\mathrm{RC}(I):=\mathbb{R}_{+}\left\{e_{1}, \ldots, e_{s},\left(v_{1}, 1\right), \ldots,\left(v_{q}, 1\right)\right\} . \tag{3.1}
\end{equation*}
$$

Theorem 3.1. [40, Proposition 1.1.51, Theorem 14.1.1] The Rees cone of I has a unique irreducible representation

$$
\begin{equation*}
\mathrm{RC}(I)=\left(\bigcap_{i=1}^{s+1} H_{e_{i}}^{+}\right) \bigcap\left(\bigcap_{i=1}^{m} H_{\left(\gamma_{i},-d_{i}\right)}^{+}\right) \bigcap\left(\bigcap_{i=m}^{p} H_{\left(\gamma_{i},-d_{i}\right)}^{+}\right), \tag{3.2}
\end{equation*}
$$

where none of the closed halfspaces can be omitted from the intersection, $d_{i}=1$ for $i=1, \ldots, m$, $t^{\gamma_{1}}, \ldots, t^{\gamma_{m}}$ are the minimal generators of $I^{\vee}, \gamma_{i} \in \mathbb{N}^{s} \backslash\{0\}$ for $i>m, d_{i} \in \mathbb{N} \backslash\{0,1\}$ for $i>m$, and the non-zero entries of $\left(\gamma_{i},-d_{i}\right)$ are relatively prime for all $i$.

The hyperplanes defining the closed halfspaces of Eq. (3.2) are the supporting hyperplanes of the Rees cone of $I$, and the $\gamma_{i}$ 's and $d_{i}$ 's can be computed using Normaliz [8]. Thus, for each $1 \leq j \leq p$, we can determine the polyhedron $\mathcal{P}_{j}$.

The following theorem justifies the a priori naming coincidence between the constants appearing in Theorem 3.1 and the description given for the $u_{i}$ in the introduction before Eq. (1.3).

Theorem 3.2. [18, Theorem 3.1] The vertex set of $\mathcal{Q}(I)$ is $V(\mathcal{Q}(I))=\left\{\gamma_{1} / d_{1}, \ldots, \gamma_{p} / d_{p}\right\}$.
The last two results say that finding the supporting hyperplanes of $\mathrm{RC}(I)$ is equivalent to finding the vertices of $\mathcal{Q}(I)$.

For use below we set $u_{i}=\gamma_{i} / d_{i}=\gamma_{i}$ for $i=1, \ldots, m$. To study the vertices of $\mathcal{P}_{j}$ we need the following dual versions of Theorems 3.1 and 3.2. The Rees cone of $I^{\vee}$ is given by

\operatorname{RC}\left(I^{\vee}\right)=\mathbb{R}_{+}\left\{e_{1}, \ldots, e_{s},\left(u_{1}, 1\right), \ldots,\left(u_{m}, 1\right)\right\} \tag{3.3}
\end{equation*}
$$

Theorem 3.3. The Rees cone of $I^{\vee}$ has a unique irreducible representation

$$
\begin{equation*}
\operatorname{RC}\left(I^{\vee}\right)=\left(\bigcap_{i=1}^{s+1} H_{e_{i}}^{+}\right) \bigcap\left(\bigcap_{i=1}^{q} H_{\left(\delta_{i},-f_{i}\right)}^{+}\right) \bigcap\left(\bigcap_{i=q+1}^{p_{1}} H_{\left(\delta_{i},-f_{i}\right)}^{+}\right), \tag{3.4}
\end{equation*}
$$

where $f_{i}=1$ for $i=1, \ldots, q, t^{\delta_{1}}, \ldots, t^{\delta_{q}}$ are the minimal generators of $I, \delta_{i} \in \mathbb{N}^{s} \backslash\{0\}$ for $i>q$, $f_{i} \in \mathbb{N} \backslash\{0,1\}$ for $i>q$, and the non-zero entries of $\left(\delta_{i},-f_{i}\right)$ are relatively prime for all $i$.

Theorem 3.4. The vertex set of $\mathcal{Q}\left(I^{\vee}\right)$ is $V\left(\mathcal{Q}\left(I^{\vee}\right)\right)=\left\{\delta_{1} / f_{1}, \ldots, \delta_{p_{1}} / f_{p_{1}}\right\}$.
In what follows we set $v_{i}=\delta_{i} / f_{i}$ for $i=1, \ldots, p_{1}$ and $u_{i}=\gamma_{i} / d_{i}$ for $i=1, \ldots, p$. Recall that $\left\{t^{v_{1}}, \ldots, t^{v_{q}}\right\}$ is the minimal generating set of the edge ideal $I=I(\mathcal{C})$ of $\mathcal{C}$. The minimal generating set for $I^{\vee}$ is $\left\{t^{u_{1}}, \ldots, t^{u_{m}}\right\}$ and $I^{\vee}=I\left(\mathcal{C}^{\vee}\right)$ is the edge ideal of the blocker $\mathcal{C}^{\vee}$ of $\mathcal{C}$.
Lemma 3.5. Let I be the edge ideal of a clutter $\mathcal{C}$. The following hold.
(a) Given $\gamma_{i}$ and $\delta_{\ell}$, there are $u \in\left\{u_{i}\right\}_{i=1}^{m}$ and $v \in\left\{v_{i}\right\}_{i=1}^{q}$ such that $\gamma_{i} \geq u$ and $\delta_{\ell} \geq v$ componentwise.
(b) $\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \geq d_{i} \geq 1$ and $\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \geq f_{\ell} \geq 1$ for all $i, \ell$.
(c) If $\rho_{j}$ is the optimal value of the linear program of Eq. (1.5), then $\rho_{j} \leq d_{j}$.
(d) If $\gamma_{j}=\left(\gamma_{j, 1}, \ldots, \gamma_{j, s}\right)$ and $\gamma_{j, k}=0$ for some $k$, then $\mathcal{P}_{j}$ is an unbounded polyhedron.
(e) If $\gamma_{j}=\left(\gamma_{j, 1}, \ldots, \gamma_{j, s}\right)$ and $\gamma_{j, k}>0$ for $k=1, \ldots, s$, then $\mathcal{P}_{j}$ is a bounded polyhedron.

Proof. (a)-(b) Given $a \in \mathbb{N}^{s}, a=\left(a_{1}, \ldots, a_{s}\right)$, we set $F_{a}=\operatorname{supp}\left(t^{a}\right)=\left\{t_{k} \mid a_{k}>0\right\}$. From Eq. (3.2), $\left\langle v_{n}, \gamma_{i}\right\rangle \geq d_{i}$ for $n=1, \ldots, q$. Then, $F_{v_{n}} \cap F_{\gamma_{i}} \neq \emptyset$ for $n=1, \ldots, q$. As $F_{v_{1}}, \ldots, F_{v_{q}}$ are the edges of $\mathcal{C}, F_{\gamma_{i}}$ is a vertex cover of $\mathcal{C}$, and consequently $F_{\gamma_{i}}$ contains a minimal vertex cover $C$ of $\mathcal{C}$. Similarly, from Eq. (3.4), $\left\langle u_{n}, \delta_{\ell}\right\rangle \geq f_{\ell}$ for $n=1, \ldots, m$. Then, $F_{u_{n}} \cap F_{\delta_{\ell}} \neq \emptyset$ for $n=1, \ldots, m$. As $F_{u_{1}}, \ldots, F_{u_{m}}$ are the edges of $\mathcal{C}^{\vee}, F_{\delta_{\ell}}$ is a vertex cover of $\mathcal{C}^{\vee}$, and consequently $F_{\delta_{\ell}}$ contains a minimal vertex cover $D$ of $\mathcal{C}^{\vee}$. Note that $D$ is an edge of $\mathcal{C}$ because $\left(\mathcal{C}^{\vee}\right)^{\vee}=\mathcal{C}$. Let $u=\sum_{t_{i} \in C} e_{i}$ and $v=\sum_{t_{i} \in D} e_{i}$ be the characteristic vectors of $C$ and $D$, respectively. Then, $\delta_{\ell} \geq v$ and $\gamma_{i} \geq u$. Hence, using Eq. (3.2) and Eq. (3.4), we obtain

$$
\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \geq\left\langle\gamma_{i}, v\right\rangle \geq d_{i} \geq 1 \text { and }\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \geq\left\langle u, \delta_{\ell}\right\rangle \geq f_{\ell} \geq 1
$$

(c) Let $y=\left(y_{1}, \ldots, y_{s+3}\right)$ be any point in $\mathcal{P}_{j}$, that is, $y$ is feasible for Eq. (1.5). By part (a), one can pick $u \in\left\{u_{i}\right\}_{i=1}^{m}$ such that $\gamma_{j} \geq u$. Then, using the constraints that define $\mathcal{P}_{j}$, we get

$$
y_{s+1} \leq\left\langle\left(y_{1}, \ldots, y_{s}\right), u\right\rangle \leq\left\langle\left(y_{1}, \ldots y_{s}\right), \gamma_{j}\right\rangle \leq d_{j}-y_{s+3} \leq d_{j}
$$

Thus, $y_{s+1} \leq d_{j}$, and consequently $\rho_{j} \leq d_{j}$.
(d) For simplicity, we may assume that $k=1$. Setting $x=\left(x_{1}, \ldots, x_{s+3}\right)=\ell e_{1}+e_{s+2}$ for $\ell \geq 0$ and using that $\gamma_{j, 1}=0$, one obtains

$$
\begin{aligned}
& \left\langle\left(x_{1}, \ldots, x_{s}\right), u_{i}\right\rangle \geq x_{s+1}=0, i=1, \ldots, m, x_{s+1} \geq x_{s+3} \\
& x_{i} \geq 0, i=1, \ldots, s, x_{s+3} \geq 0 \\
& d_{j} x_{s+2}-\left\langle\left(x_{1}, \ldots, x_{s}\right), \gamma_{j}\right\rangle=d_{j}-x_{1} \gamma_{j, 1}=d_{j} \geq x_{s+3}=0, x_{s+2}=1
\end{aligned}
$$

and consequently $x \in \mathcal{P}_{j}$ for all $\ell \geq 0$. This proves that $\mathcal{P}_{j}$ is unbounded.
(e) Let $y=\left(y_{1}, \ldots, y_{s+3}\right)$ be any point in $\mathcal{P}_{j}$. It suffices to show that $y_{i} \leq d_{j}$ for $i=1, \ldots, s+3$. By part (a), one can pick $u \in\left\{u_{i}\right\}_{i=1}^{m}$ such that $\gamma_{j} \geq u$. As $\gamma_{j}$ is integral, $\gamma_{j, k} \geq 1$ for all $k$. Then, using the constraints that define $\mathcal{P}_{j}$, we get

$$
\begin{aligned}
& y_{i} \leq\left\langle\left(y_{1}, \ldots y_{s}\right), \gamma_{j}\right\rangle \leq d_{j}-y_{s+3} \leq d_{j}, i=1, \ldots, s \\
& y_{s+3} \leq y_{s+1} \leq\left\langle\left(y_{1}, \ldots, y_{s}\right), u\right\rangle \leq\left\langle\left(y_{1}, \ldots y_{s}\right), \gamma_{j}\right\rangle \leq d_{j}-y_{s+3} \leq d_{j}
\end{aligned}
$$

and the proof is complete.
Theorem 3.6. Let $\mathcal{P}_{j}$ be the polyhedron of feasible points of Eq. (1.5), $1 \leq j \leq p$, and let $y=\left(y_{1}, \ldots, y_{s+3}\right)$ be a point in $\mathbb{R}^{s+3}$ with $y_{s+1}>0$, then $y$ is a vertex of $\mathcal{P}_{j}$ if and only if $y$ has one of the following two forms:
(a) $y=\left(y_{s+1}\left(\delta_{k} / f_{k}\right), y_{s+1}, 1,0\right)$, where $y_{s+1}=d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle$ and $1 \leq k \leq p_{1}$, or
(b) $y=\left(y_{s+1}\left(\delta_{k} / f_{k}\right), y_{s+1}, 1, y_{s+1}\right)$, where $y_{s+1}=d_{j} f_{k} /\left(\left\langle\gamma_{j}, \delta_{k}\right\rangle+f_{k}\right)$ and $1 \leq k \leq p_{1}$.

Proof. $\Rightarrow)$ Assume that $y=\left(y_{1}, \ldots, y_{s+3}\right)$ is a vertex of $\mathcal{P}_{j}$ with $y_{s+1}>0$. The constraints that define $\mathcal{P}_{j}$ can be written as

$$
\begin{align*}
& \left\langle y,\left(-u_{i}, 1,0,0\right)\right\rangle \leq 0, i=1, \ldots, m,\left\langle y,-e_{s+1}+e_{s+3}\right\rangle \leq 0 \\
& \left\langle y,-e_{i}\right\rangle \leq 0, i=1, \ldots, s,\left\langle y,-e_{s+3}\right\rangle \leq 0  \tag{3.5}\\
& \left\langle y,\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}\right\rangle \leq 0,\left\langle y, e_{s+2}\right\rangle \leq 1,\left\langle y,-e_{s+2}\right\rangle \leq-1 .
\end{align*}
$$

As $y$ is a vertex of $\mathcal{P}_{j}$, by [40, Corollary 1.1.47], there are $s+3$ linearly independent constraints that are satisfied with equality. The hyperplane $H_{\left(y_{1}, \ldots, y_{s+1}\right)}$ of $\mathbb{R}^{s+1}$ contains at most $s$ linearly independent vectors because $y_{s+1}>0$. Therefore, there are exactly $s$ constraints of the form

$$
\begin{align*}
& \left\langle y,\left(-u_{i}, 1,0,0\right)\right\rangle \leq 0, i=1, \ldots, m  \tag{3.6}\\
& \left\langle y,-e_{i}\right\rangle \leq 0, i=1, \ldots, s \tag{3.7}
\end{align*}
$$

that are satisfied with equality because the remaining constraints that define $\mathcal{P}_{j}$ are

$$
\begin{align*}
& \left\langle y,-e_{s+1}+e_{s+3}\right\rangle \leq 0  \tag{3.8}\\
& \left\langle y,-e_{s+3}\right\rangle \leq 0  \tag{3.9}\\
& \left\langle y,\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}\right\rangle \leq 0  \tag{3.10}\\
& \left\langle y, e_{s+2}\right\rangle \leq 1,\left\langle y,-e_{s+2}\right\rangle \leq-1 \tag{3.11}
\end{align*}
$$

and the constraints of Eqs. (3.8) and (3.9) cannot hold simultaneously with equality. Then, recalling that $y_{s+2}=1$ in $\mathcal{P}_{j}$, one has

$$
\begin{equation*}
\left\langle\left(y_{1}, \ldots, y_{s}\right), \gamma_{j}\right\rangle=d_{j}-y_{s+3} \tag{3.12}
\end{equation*}
$$

because the constraint of Eq. (3.10) must hold with equality, and either $y_{s+1}=y_{s+3}$ if Eq.(3.8) holds with equality or $y_{s+3}=0$ if Eq.(3.9) holds with equality. Let

$$
\mathcal{B}=\left\{\left(-w_{i}, 1\right)\right\}_{i=1}^{r-1} \bigcup\left\{\left(-w_{i}, 0\right)\right\}_{i=r}^{s}
$$

be the set of vectors in $\mathbb{R}^{s+1}$ that correspond to the $s$ linearly independent constraints of Eqs. (3.6) and (3.7) that are satisfied with equality. Note that $\mathcal{B}$ is linearly independent if and only if $\mathcal{B}^{\prime}=\left\{\left(w_{i}, 1\right)\right\}_{i=1}^{r-1} \bigcup\left\{\left(w_{i}, 0\right)\right\}_{i=r}^{s}$ is linearly independent. Consider the hyperplane

$$
H=H_{\left(y_{1}, \ldots, y_{s},-y_{s+1}\right)} .
$$

The set $\mathcal{B}^{\prime}$ is contained in $H$, and $\mathcal{B}^{\prime}$ is also contained in the Rees cone $\operatorname{RC}\left(I^{\vee}\right)$ of $I^{\vee}$ because $w_{i} \in\left\{u_{1}, \ldots, u_{m}\right\}$ for $1 \leq i \leq r-1$ and $w_{i} \in\left\{e_{1}, \ldots, e_{s}\right\}$ for $r \leq i \leq s$. Then, $F=H \cap \operatorname{RC}\left(I^{\vee}\right)$ is a facet of the Rees cone $\mathrm{RC}\left(I^{\vee}\right)$ of $I^{\vee}$. Hence, by Theorem [3.3 and [41, Theorem 3.2.1], we obtain that $F=H_{\left(\delta_{k},-f_{k}\right)} \cap \mathrm{RC}\left(I^{\vee}\right)$ for some $1 \leq k \leq p_{1}$, and consequently

$$
\left(\delta_{k},-f_{k}\right)=\lambda\left(y_{1}, \ldots, y_{s},-y_{s+1}\right)
$$

for some $\lambda \in \mathbb{R}$. Thus, $\left(y_{1}, \ldots, y_{s}\right) / y_{s+1}=\delta_{k} / f_{k}$ for some $1 \leq k \leq p_{1}$.
Case (I) $y_{s+3}=0$. Then, dividing Eq. (3.12) by $y_{s+1}$, we get

$$
\frac{\left\langle\delta_{k}, \gamma_{j}\right\rangle}{f_{k}}=\frac{d_{j}}{y_{s+1}},
$$

and solving for $y_{s+1}$ gives $y_{s+1}=d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle$. Thus, $y$ is as in (a).
Case (II) $y_{s+1}=y_{s+3}$. Then, dividing Eq. (3.12) by $y_{s+1}$, we get

$$
\frac{\left\langle\delta_{k}, \gamma_{j}\right\rangle+f_{k}}{f_{k}}=\frac{\left\langle\delta_{k}, \gamma_{j}\right\rangle}{f_{k}}+1=\frac{d_{j}}{y_{s+1}},
$$

and solving for $y_{s+1}$ gives $y_{s+1}=d_{j} f_{k} /\left(\left\langle\gamma_{j}, \delta_{k}\right\rangle+f_{k}\right)$. Thus, $y$ is as in (b).
$\Leftrightarrow)$ Assume that $y$ is as in (a). As $\left(y_{1}, \ldots, y_{s}\right) / y_{s+1}=\delta_{k} / f_{k}$ is a vertex of $\mathcal{Q}\left(I^{\vee}\right)$, it follows that $y$ satisfies the constraints of Eqs. (3.6)-(3.7) and that $s$ of them occur with equality and are linearly independent. Let $\Gamma$ be the set of vectors in $\mathbb{R}^{s+3}$ that correspond to these independent constraints. Then, $\langle\alpha, y\rangle=0$ for all $\alpha \in \Gamma$. The following three constraints are also satisfied with equality

$$
\begin{aligned}
& \left\langle y,-e_{s+3}\right\rangle \leq 0 \\
& \left\langle y,\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}\right\rangle \leq 0 \\
& \left\langle y, e_{s+2}\right\rangle \leq 1
\end{aligned}
$$

As $y \in \mathcal{P}_{j}$, to prove that $y$ is a vertex of $\mathcal{P}_{j}$ we need only show that the set

$$
\Gamma \cup\left\{-e_{s+3},\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}, e_{s+2}\right\}
$$

is linearly independent or equivalently that $\Gamma \cup\left\{e_{s+3},\left(\gamma_{j}, 0,0,0\right), e_{s+2}\right\}$ is linearly independent. This follows noticing that $\Gamma \cup\left\{e_{s+2}, e_{s+3}\right\}$ is linearly independent and observing that ( $\gamma_{j}, 0,0,0$ ) cannot be in $\mathbb{R}\left(\Gamma \cup\left\{e_{s+2}, e_{s+3}\right\}\right)$, the linear span of $\Gamma \cup\left\{e_{s+2}, e_{s+3}\right\}$, because $\left\langle y,\left(\gamma_{j}, 0,0,0\right)\right\rangle=d_{j}$ and $\langle\alpha, y\rangle=0$ for all $\alpha \in \Gamma$.

Assume that $y$ is as in (b). As $\left(y_{1}, \ldots, y_{s}\right) / y_{s+1}=\delta_{k} / f_{k}$ is a vertex of $\mathcal{Q}\left(I^{\vee}\right)$, it follows that $y$ satisfies the constraints of Eqs. (3.6)-(3.7) and that $s$ of them occur with equality and are linearly independent. Let $\Gamma$ be the set of vectors in $\mathbb{R}^{s+3}$ that correspond to these independent constraints. Then, $\langle\alpha, y\rangle=0$ for all $\alpha \in \Gamma$. The following constraints are satisfied with equality

$$
\begin{aligned}
& \left\langle y,-e_{s+1}+e_{s+3}\right\rangle \leq 0 \\
& \left\langle y,\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}\right\rangle \leq 0, \\
& \left\langle y, e_{s+2}\right\rangle \leq 1
\end{aligned}
$$

As $y \in \mathcal{P}_{j}$, to prove that $y$ is a vertex of $\mathcal{P}_{j}$ we need only show that the set

$$
\Gamma \cup\left\{-e_{s+1}+e_{s+3},\left(\gamma_{j}, 0,0,0\right)-d_{j} e_{s+2}+e_{s+3}, e_{s+2}\right\}
$$

is linearly independent or equivalently that the set

$$
\Gamma \cup\left\{-e_{s+1}+e_{s+3},\left(\gamma_{j}, 0,0,0\right)+e_{s+3}, e_{s+2}\right\}
$$

is linearly independent. Clearly the set $\Gamma \cup\left\{-e_{s+1}+e_{s+3}, e_{s+2}\right\}$ is linearly independent. Hence, it suffices to notice that $\left(\gamma_{j}, 0,0,0\right)$ cannot be in $\mathbb{R}\left(\Gamma \cup\left\{-e_{s+1}+e_{s+3}, e_{s+2}\right\}\right)$ because $\left\langle y,\left(\gamma_{j}, 0,0,0\right)\right\rangle$ is equal to $d_{j}-y_{s+1},\langle\alpha, y\rangle=0$ for all $\alpha \in \Gamma$, and $d_{j}-y_{s+1} \neq 0$ (Lemma 3.5).
Theorem 3.7. (Duality formula) If $I=I(\mathcal{C})$ is the edge ideal of a clutter $\mathcal{C}$ and $\rho_{i c}(I)$ is the ic-resurgence of $I$, then

$$
\frac{1}{\rho_{i c}(I)}=\min \left\{\langle u, v\rangle \mid u \in V(\mathcal{Q}(I)), v \in V\left(\mathcal{Q}\left(I^{\vee}\right)\right)\right\},
$$

where $V(\mathcal{Q}(I))$ is the vertex set of $\mathcal{Q}(I)$. In particular, $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)$.
Proof. The sets of vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ are $\left\{\gamma_{i} / d_{i}\right\}_{i=1}^{p}$ and $\left\{\delta_{\ell} / f_{\ell}\right\}_{\ell=1}^{p_{1}}$, respectively. This follows from Theorems 3.2 and 3.4. Then, noticing the equalities

$$
1 / \min \left\{\left\langle\gamma_{i} / d_{i}, \delta_{\ell} / f_{\ell}\right\rangle\right\}_{i, \ell}=\max \left\{1 /\left\langle\gamma_{i} / d_{i}, \delta_{\ell} / f_{\ell}\right\rangle\right\}_{i, \ell}=\max \left\{\left(d_{i} f_{\ell}\right) /\left\langle\gamma_{i}, \delta_{\ell}\right\rangle\right\}_{i, \ell},
$$

it suffices to prove the following equality

$$
\begin{equation*}
\rho_{i c}(I)=\max \left\{\left(d_{i} f_{\ell}\right) /\left\langle\gamma_{i}, \delta_{\ell}\right\rangle\right\}_{i, \ell} . \tag{3.13}
\end{equation*}
$$

Given integers $1 \leq i \leq p$ and $1 \leq \ell \leq p_{1}$, by Theorem [3.6, there is a vertex $y_{i, \ell}$ of $\mathcal{P}_{i}$ such that the $(s+1)$-th entry $\left(y_{i, \ell}\right)_{s+1}$ of $y_{i, \ell}$ is equal to $\left(d_{i} f_{\ell}\right) /\left\langle\gamma_{i}, \delta_{\ell}\right\rangle$. As $y_{i, \ell}$ is in $\mathcal{P}_{i}$, we obtain that $\rho_{i} \geq\left(d_{i} f_{\ell}\right) /\left\langle\gamma_{i}, \delta_{\ell}\right\rangle$, and consequently one has

$$
\begin{equation*}
\rho_{i c}(I) \geq \rho_{i} \geq d_{i} f_{\ell} /\left\langle\gamma_{i}, \delta_{\ell}\right\rangle \forall i, \ell . \tag{3.14}
\end{equation*}
$$

By Theorems 1.1 and 3.6, $\rho_{i c}(I)=\rho_{j}$ for some $1 \leq j \leq p$ and there is $y=\left(y_{1}, \ldots, y_{s+3}\right)$ a vertex of $\mathcal{P}_{j}$ such that $y_{s+1}=\rho_{i c}(I)$, and either

$$
y_{s+1}=d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle \text { or } y_{s+1}=d_{j} f_{k} /\left(\left\langle\gamma_{j}, \delta_{k}\right\rangle+f_{k}\right)
$$

for some $k$. The second equality cannot occur because

$$
d_{j} f_{k} /\left(\left\langle\gamma_{j}, \delta_{k}\right\rangle+f_{k}\right)<d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle \leq \rho_{i c}(I) .
$$

Thus, one has $y_{s+1}=d_{j} f_{k} /\left\langle\gamma_{j}, \delta_{k}\right\rangle$ and, by Eq. (3.14), we get equality in Eq. (3.13).
Proposition 3.8. If $I$ is a squarefree monomial ideal, then $\rho_{i c}(I) \geq 1$ with equality if and only if $\mathcal{Q}(I)$ is integral.

Proof. By [13, Corollaries 4.14 and 4.16], $\rho_{i c}(I) \geq 1$ with equality if and only if $I^{(n)}=\overline{I^{n}}$ for every $n \geq 1$. Therefore, by Theorem [2.2, $\rho_{i c}(I)=1$ if and only if $\mathcal{Q}(I)$ is integral.
Corollary 3.9. [11, Theorem 1.17] $\mathcal{Q}(I)$ is integral if and only if $\mathcal{Q}\left(I^{\vee}\right)$ is integral.
Proof. If $\mathcal{Q}(I)$ is integral, by Proposition [3.8, $\rho_{i c}(I)=1$. Then, by Theorem 3.7, $\rho_{i c}\left(I^{\vee}\right)=1$. Thus, by Proposition 3.8, $\mathcal{Q}\left(I^{\vee}\right)$ is integral. The converse follows by replacing $I$ with $I^{\vee}$, in the first part of the proof, and recalling that $\left(I^{\vee}\right)^{\vee}$ is equal to $I$.

Corollary 3.10. [26, Theorems 4.8 and 5.3] Let $I=I(G)$ be the edge ideal of a graph. The following conditions are equivalent.
(a) $\rho(I)=1$;
(b) $\rho_{i c}(I)=1$;
(c) $G$ is bipartite;
(d) $\rho\left(I^{\vee}\right)=1$.

Proof. (a) $\Rightarrow$ (b) Assume that $\rho(I)=1$. Then, $\rho(I) \geq \rho_{i c}(I) \geq 1$, and $\rho_{i c}(I)=1$.
$(\mathrm{b}) \Rightarrow(\mathrm{c})$ Assume that $\rho_{i c}(I)=1$. Then, by Proposition 3.8, we get that $\mathcal{Q}(I)$ is integral. Hence, by [40, Proposition 14.3.39], $G$ is bipartite.
$(\mathrm{c}) \Rightarrow(\mathrm{d})$ Assume that $G$ is bipartite. Then, by [17, Corollary 2.6] and [40, Proposition 14.3.6], $I^{\vee}$ is normal and $\mathcal{Q}\left(I^{\vee}\right)$ integral. Hence, by Proposition 3.8, we get $\rho\left(I^{\vee}\right)=\rho_{i c}\left(I^{\vee}\right)=1$.
(d) $\Rightarrow$ (a) Assume that $\rho\left(I^{\vee}\right)=1$. Then, $\rho\left(I^{\vee}\right) \geq \rho_{i c}\left(I^{\vee}\right) \geq 1$, and $\rho_{i c}\left(I^{\vee}\right)=1$. Then, by the duality formula and Proposition [3.8, we get that $\mathcal{Q}(I)$ is integral and $\rho_{i c}(I)=1$. Then, by [40, Proposition 14.3.39] and [32, Theorem 5.9], $G$ is bipartite and $I$ is normal. Hence, $\rho(I)=\rho_{i c}(I)=1$.

Corollary 3.11. If $I_{1}$ and $I_{2}$ are squarefree monomial ideals of $S$ generated by monomials in disjoint sets of variables, then

$$
\rho_{i c}\left(I_{1}+I_{2}\right)=\max \left\{\rho_{i c}\left(I_{1}\right), \rho_{i c}\left(I_{2}\right)\right\}
$$

Proof. We may assume that $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are clutters with vertex sets $\left\{t_{1}, \ldots, t_{r}\right\}$ and $\left\{t_{r+1}, \ldots, t_{s}\right\}$ such that $I_{i}$ is the edge ideal of $\mathcal{C}_{i}$ for $i=1,2$. If $\mathcal{C}=\mathcal{C}_{1} \cup \mathcal{C}_{2}$ and $I=I_{1}+I_{2}$, then $I$ is the edge ideal of $\mathcal{C}$ and $C$ is a minimal vertex cover of $\mathcal{C}$ if and only if $C=C_{1} \cup C_{2}$ with $C_{i}$ a minimal vertex cover of $\mathcal{C}_{i}$ for $i=1,2$. Hence, $I^{\vee}=I_{1}^{\vee} I_{2}^{\vee}$ and, by [26, Proposition 3.5], $\rho_{i c}\left(I^{\vee}\right)$ is equal to $\max \left\{\rho_{i c}\left(I_{1}^{\vee}\right), \rho_{i c}\left(I_{2}^{\vee}\right)\right\}$. Therefore, using Theorem 3.7, we get

$$
\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=\rho_{i c}\left(I_{1}^{\vee} I_{2}^{\vee}\right)=\max \left\{\rho_{i c}\left(I_{1}^{\vee}\right), \rho_{i c}\left(I_{2}^{\vee}\right)\right\}=\max \left\{\rho_{i c}\left(I_{1}\right), \rho_{i c}\left(I_{2}\right)\right\}
$$

Thus, $\rho_{i c}(I)=\max \left\{\rho_{i c}\left(I_{1}\right), \rho_{i c}\left(I_{2}\right)\right\}$ and the proof is complete.
Remark 3.12. There is a similar formula for $\widehat{\alpha}\left(I_{1}+I_{2}\right)$ [4, Corollary 7.10]:

$$
\widehat{\alpha}\left(I_{1}+I_{2}\right)=\min \left\{\widehat{\alpha}\left(I_{1}\right), \widehat{\alpha}\left(I_{2}\right)\right\} .
$$

Definition 3.13. [40, p. 541] Let $a=\left(a_{i}\right) \neq 0$ be a vector in $\mathbb{N}^{s}$ and let $b \in \mathbb{N}$. If $a, b$ satisfy $\left\langle a, v_{i}\right\rangle \geq b$ for $i=1, \ldots, q$, we say that $a$ is a $b$-cover of $\mathcal{C}$.

The notion of a $b$-cover occurs in combinatorial optimization [31, Chapter 77, p. 1378] and algebraic combinatorics [15, 24].

Definition 3.14. A $b$-cover $a$ of $\mathcal{C}$ is called reducible if there exists an $i$-cover $c$ and a $j$-cover $d$ of $\mathcal{C}$ such that $a=c+d$ and $b=i+j$. If $a$ is not reducible, we call $a$ irreducible.

Lemma 3.15. [14, Lemma 1.8] If $\left(\gamma_{k},-d_{k}\right)$ is any of the vectors of Eq. (3.2), then $\gamma_{k}$ is an irreducible $d_{k}$-cover of $\mathcal{C}$.

Definition 3.16. Let $G$ be a graph. A set $P$ of pairwise disjoint edges of $G$ is a perfect matching of $G$ if $V(G)=\bigcup_{e \in P} e$. A set of vertices of $G$ is stable if no two of them are adjacent.

Proposition 3.17. Let $G$ be a connected non-bipartite graph with a perfect matching and let $I(G)$ be its edge ideal. Then, $\widehat{\alpha}\left(I(G)^{\vee}\right)=|V(G)| / 2$.

Proof. Let $u_{i}=\gamma_{i} / d_{i}$ be any vertex of $\mathcal{Q}(I)$. By Theorem 3.2, $\left(\gamma_{i},-d_{i}\right)$ occurs in Eq. (3.2). Hence, by Lemma 3.15, $\gamma_{i}$ is an irreducible $d_{i}$-cover of $G$. Therefore, using the classification of the irreducible covers of a graph [14, Theorem 1.7], $\gamma_{i}$ and $d_{i}$ have one of the following forms
(a) $d_{i}=1$ and $\gamma_{i}=\sum_{t_{j} \in C} e_{j}$ for some $C \in E\left(G^{\vee}\right)$, that is, $1 \leq i \leq m$,
(b) $d_{i}=2$ and $\gamma_{i}=(1, \ldots, 1)$,
(c) $d_{i}=2$ and up to permutation of vertices

$$
\begin{equation*}
\gamma_{i}=(\underbrace{0, \ldots, 0}_{|\mathfrak{A}|}, \underbrace{2, \ldots, 2}_{\left|N_{G}(\mathfrak{A})\right|}, 1, \ldots, 1) \tag{3.15}
\end{equation*}
$$

for some stable set of vertices $\mathfrak{A} \neq \emptyset$ of $G$, where $N_{G}(\mathfrak{A})$ is the neighbor set of $\mathfrak{A}$.
The incidence matrix of $I$ has rank $s=|V(G)|$ because $G$ is connected and non-bipartite [36, Lemma 2.1]. Hence, $\beta=(1 / 2, \ldots, 1 / 2)$ is a vertex of $\mathcal{Q}(I)$. Indeed, note that $\beta A \geq 1$, where $A$ is the incidence matrix of $I$. There are $s$ linearly independent columns of $A$, say $v_{1}, \ldots, v_{s}$, such that $\left\langle\beta, v_{i}\right\rangle=1$ for $i=1, \ldots, s$. Thus, $\beta$ is a basic feasible solution of the system $x A \geq 1 ; x \geq 0$ and, by [40, Corollary 1.1.49], $\beta$ is a vertex of $\mathcal{Q}(I)$. Then, by [4, Theorem 3.2], one has

$$
\widehat{\alpha}\left(I^{\vee}\right)=\min \left\{\left|u_{k}\right|: u_{k} \in V(\mathcal{Q}(I))\right\} \leq|\beta|=s / 2 .
$$

Therefore, it suffices to show that $\left|u_{i}\right| \geq s / 2$. If $u_{i}=\gamma_{i} / d_{i}$ is as in (a), then $\left|u_{i}\right| \geq s / 2$ because $G$ has a perfect matching and any minimal vertex cover $C$ of $G$ has at least $s / 2$ vertices of $G$. If $u_{i}$ is as in (c), by Eq. (3.15), we obtain

$$
\left|u_{i}\right|=\left|\gamma_{i} / 2\right|=\left|N_{G}(\mathfrak{A})\right|+(1 / 2)\left(s-|\mathfrak{A}|-\left|N_{G}(\mathfrak{A})\right|\right)=(1 / 2)\left|N_{G}(\mathfrak{A})\right|+(s / 2)-(1 / 2)|\mathfrak{A}| .
$$

As the graph $G$ has a perfect matching and the set $\mathfrak{A}$ contains no edges of $G$ since $\mathfrak{A}$ is stable, one has $\left|N_{G}(\mathfrak{A})\right| \geq|\mathfrak{A}|$. Thus, $\left|u_{i}\right| \geq s / 2$.

Lemma 3.18. Let $d, k, \ell, s$ be integers such that $1 \leq d \leq \ell \leq s$ and $s-d+1 \leq k \leq s$. If $A$ and $B$ are subsets of $\{1, \ldots, s\}, k=|A|, \ell=|B|$, then

$$
\begin{equation*}
\frac{|A \cap B|}{(k-s+d)(\ell-d+1)} \geq \frac{s}{d(s-d+1)} \tag{3.16}
\end{equation*}
$$

with equality if $A=B=\{1, \ldots, s\}$.
Proof. We can write $\ell=d+i$ and $|A \cup B|=s-\epsilon$, where $0 \leq i \leq s-d$ and $\epsilon \geq 0$. As $|A \cap B|$ is equal to $k+\ell-|A \cup B|$, we obtain that Eq. (3.16) is equivalent to

$$
(k+d+i-s+\epsilon) d(s-d+1) \geq s(k-s+d)(i+1) .
$$

By factoring out $i$, this inequality is equivalent to

$$
\begin{equation*}
\epsilon d(s-d+1)+(k+d-s)(d-1)(s-d) \geq i[s(k-s+d)-d(s-d+1)] . \tag{3.17}
\end{equation*}
$$

We set $f=s(k-s+d)-d(s-d+1)$. If $f \leq 0$, the inequality of Eq. (3.17) holds because the left-hand side is non-negative and the right-hand side is $i f$. Thus, we may assume that $f \geq 1$. Since $s-d \geq i$, one has $(s-d) f \geq i f$, and we need only prove the inequality

$$
\begin{equation*}
\epsilon d(s-d+1)+(k+d-s)(d-1)(s-d) \geq(s-d)[s(k-s+d)-d(s-d+1)] . \tag{3.18}
\end{equation*}
$$

This inequality is equivalent to

$$
d(s-d+1)(\epsilon+(s-d)) \geq(s-d)(s-(d-1))(k-s+d) .
$$

By cancelling out $s-d+1$, the proof reduces to showing that

$$
d(\epsilon+(s-d)) \geq(s-d)(k-s+d) .
$$

As $d(s-d)$ appears as a summand on both sides of this inequality it suffices to notice that $d \epsilon \geq(s-d)(k-s)$ because $k \leq s$.

Theorem 3.19. [4, 28] If $I_{d, s}$ is the $d$-th squarefree Veronese ideal of $S$ generated by all squarefree monomials of $S$ of degree $d$ in $s$ variables, then

$$
\begin{equation*}
\rho\left(I_{d, s}\right)=\rho_{i c}\left(I_{d, s}\right)=\rho_{i c}\left(\left(I_{d, s}\right)^{\vee}\right)=\frac{d(s-d+1)}{s}=\frac{d}{\widehat{\alpha}\left(I_{d, s}\right)}=\frac{s-d+1}{\widehat{\alpha}\left(\left(I_{d, s}\right)^{\vee}\right)} . \tag{3.19}
\end{equation*}
$$

Proof. We set $I=I_{d, s}$ and $J=I_{s-d+1, s}$. The primary decomposition of $I$ is

$$
\begin{equation*}
I=\bigcap_{1 \leq j_{1}<\cdots<j_{s-d+1} \leq s}\left(t_{j_{1}}, \ldots, t_{j_{s-d+1}}\right) . \tag{3.20}
\end{equation*}
$$

Then, $\left(I_{d, s}\right)^{\vee}=I_{s-d+1, s}$ and $J=\left(I_{d, s}\right)^{\vee}$. If $d=s$, then $I=\left(t_{1} \cdots t_{s}\right), I^{\vee}=\left(t_{1}, \ldots, t_{s}\right)$, the vertex set of $\mathcal{Q}(I)$ is $\left\{e_{1}, \ldots, e_{s}\right\}$, and the vertex set of $\mathcal{Q}\left(I^{\vee}\right)$ is $\left\{e_{1}+\cdots+e_{s}\right\}$. Then, by [4, Theorem 3.2] and Theorem 3.7, we get $\widehat{\alpha}\left(I^{\vee}\right)=1, \widehat{\alpha}(I)=s$, and $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=1$. Then, Eq. (3.19) holds. For similar reasons Eq. (3.19) holds if $d=1$.

Thus, we may assume that $2 \leq d<s$. We claim that the vertex sets of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ are

$$
\begin{align*}
& V(Q(I))=\left\{\left.\frac{e_{i_{1}}+\cdots+e_{i_{k}}}{k-s+d} \right\rvert\, s-d+1 \leq k \leq s, 1 \leq i_{1}<\cdots<i_{k} \leq s\right\}  \tag{3.21}\\
& V\left(Q\left(I^{\vee}\right)\right)=\left\{\left.\frac{e_{j_{1}}+\cdots+e_{j_{\ell}}}{\ell-d+1} \right\rvert\, d \leq \ell \leq s, 1 \leq j_{1}<\cdots<j_{\ell} \leq s\right\} \tag{3.22}
\end{align*}
$$

To prove the first equality, we use the Rees cone $\mathrm{RC}(I)$ of $I$ defined in Eq. (3.1). The second equality will follow by using the Rees cone $\mathrm{RC}(J)$ of $J$ or by replacing $I_{d, s}$ with $I_{s-d+1, s}$. Next we prove that the irreducible representation of $\mathrm{RC}(I)$ is given by

$$
\begin{equation*}
\operatorname{RC}(I)=\left(\bigcap_{i=1}^{s+1} H_{e_{i}}^{+}\right) \bigcap\left(\bigcap_{\substack{1 \leq i_{1}<\cdots<i_{k} \leq s \\ s-d+1 \leq k \leq s}} H_{\left(e_{i_{1}}+\cdots+e_{i_{k}},-(k-s+d)\right)}^{+}\right) \tag{3.23}
\end{equation*}
$$

First we show that the non-trivial closed halfspaces on the right-hand side of this equality occur in the irreducible representation of $\mathrm{RC}(I)$. Consider the hyperplane

$$
H=H_{\left(e_{i_{1}}+\cdots+e_{i_{k}},-(k-s+d)\right)},
$$

where $1 \leq i_{1}<\cdots<i_{k} \leq s$ and $s-d+1 \leq k \leq s$. To show that $H^{+}$occurs in the irreducible representation of $\mathrm{RC}(I)$ we need only show that the set $F=H \cap \mathrm{RC}(I)$ is a facet of $\mathrm{RC}(I)$ [41, Theorem 3.2.1]. Recall that $\operatorname{RC}(I)$ is the cone $\mathbb{R}_{+} \mathcal{A}^{\prime}$ generated by the set

$$
\mathcal{A}^{\prime}=\left\{e_{1}, \ldots, e_{s}\right\} \cup\left\{e_{j_{1}}+\cdots+e_{j_{d}}+e_{s+1} \mid 1 \leq j_{1}<\cdots<j_{d} \leq s\right\} .
$$

That $H$ is a supporting hyperplane of the Rees cone, that is, $\mathrm{RC}(I) \subset H^{+}$, follows using that for any sequence of integers $1 \leq j_{1}<\cdots<j_{d} \leq s$ one has

$$
\begin{aligned}
& \left\langle e_{i_{1}}+\cdots+e_{i_{k}}, e_{j_{1}}+\cdots+e_{j_{d}}\right\rangle=\left|\left\{i_{1}, \ldots, i_{k}\right\} \cap\left\{j_{1}, \ldots, j_{d}\right\}\right|= \\
& k+d-\left|\left\{i_{1}, \ldots, i_{k}\right\} \cup\left\{j_{1}, \ldots, j_{d}\right\}\right| \geq k+d-s .
\end{aligned}
$$

Hence, to prove that $F$ is a facet of $\mathrm{RC}(I)$, it suffices to prove that $F$ contains $s$ linearly independent vectors in $\mathcal{A}^{\prime}$. Recall that $d-s+k<k$ because $d<s$. Take any subset $A_{1}$ of $\left\{i_{1}, \ldots, i_{k}\right\}$ with $d-s+k$ elements and any subset $A_{2}$ of $\{1, \ldots, s\} \backslash\left\{i_{1}, \ldots, i_{k}\right\}$ with $s-k$ elements. Then

$$
\begin{equation*}
\left\langle\sum_{i \in A_{1} \cup A_{2}} e_{i}, e_{i_{1}}+\cdots+e_{i_{k}}\right\rangle=\left|\left(A_{1} \cup A_{2}\right) \cap\left\{i_{1}, \ldots, i_{k}\right\}\right|=d-s+k, \text { and } \tag{3.24}
\end{equation*}
$$

$$
\begin{equation*}
e_{i} \in H \text { for } i \in\{1, \ldots, s\} \backslash\left\{i_{1}, \ldots, i_{k}\right\} . \tag{3.25}
\end{equation*}
$$

Let $I_{d-s+k, k}$ be the $(d-s+k)$-th squarefree Veronese ideal in the $k$ variables $\left\{t_{i_{1}}, \ldots, t_{i_{k}}\right\}$. The incidence matrix of $I_{d-s+k, k}$ has rank $k$ because $d-s+k<k$ [40, Remarks 12.4.1, 12.4.11]. Hence, using Eqs. (3.24)-(3.25), it follows that $F$ contains $s$ linearly independent vectors in $\mathcal{A}^{\prime}$, and $F$ is a facet of $\mathrm{RC}(I)$.

Conversely, let $H_{\left(\gamma_{p},-d_{p}\right)}^{+}$be any of the non-trivial closed halfspaces that occur in the irreducible representation of $\mathrm{RC}(I)$ in Eq. (3.2) of Theorem 3.1. Then, by [39, Theorem 3.5],

$$
\left(\gamma_{p},-d_{p}\right)=\left(e_{i_{1}}+\cdots+e_{i_{k}},-f_{p}\right)
$$

for some $1 \leq i_{1}<\cdots<i_{k} \leq s$. Let $\mathcal{C}$ be the clutter with edge ideal $I$ and let $\mathcal{C}^{\vee}$ be its blocker. Consider the induced subclutter $\mathcal{D}=\mathcal{C}^{\vee}\left[\left\{t_{i_{1}}, \ldots, t_{i_{k}}\right\}\right]$ of $\mathcal{C}^{\vee}$ consisting of all minimal vertex covers $\left\{t_{j_{1}}, \ldots, t_{j_{s-d+1}}\right\}$ of $\mathcal{C}$ contained in $\left\{t_{i_{1}}, \ldots, t_{i_{k}}\right\}$. Then, $I(\mathcal{D})=I_{s-d+1, k}$. Using Lemma 3.15 and [29, Theorem 2.6], it follows that $\gamma_{p}$ is an irreducible $d_{p}$-cover of $\mathcal{C}$ and $\alpha_{0}(\mathcal{D})$ is equal to $d_{p}$, where $\alpha_{0}(\mathcal{D})$ is the covering number of $\mathcal{D}$, i.e., the size of the smallest minimal vertex cover of $\mathcal{D}$. In particular $\mathcal{D} \neq \emptyset$ because $d_{p} \geq 1$, that is, $k \geq s-d+1$. Using the primary decomposition of $I_{s-d+1, k}$ (cf. Eq (3.20)), we get

$$
\alpha_{0}(\mathcal{D})=k-(s-d+1)+1=k-s+d .
$$

Thus, $d_{p}=k-s+d$ and $H_{\left(\gamma_{p},-d_{p}\right)}^{+}$occurs in the right-hand side of Eq. (3.23).
Using Eq. (3.23) and Theorem (3.2 we obtain that Eq. (3.21) holds. Let $u$ and $v$ be any vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$, respectively. Then, by Eqs. (3.21)-(3.22) and Lemma 3.18, we get

$$
\langle u, v\rangle=\left\langle\frac{e_{i_{1}}+\cdots+e_{i_{k}}}{k-s+d}, \frac{e_{j_{1}}+\cdots+e_{j_{\ell}}}{\ell-d+1}\right\rangle=\frac{|A \cap B|}{(k-s+d)(\ell-d+1)} \geq \frac{s}{d(s-d+1)},
$$

where $A=\left\{i_{1}, \ldots, i_{k}\right\}$ and $B=\left\{j_{1}, \ldots, j_{\ell}\right\}$, with equality if $A=B=\{1, \ldots, s\}$. Hence

$$
\min \left\{\langle u, v\rangle \mid u \in V(\mathcal{Q}(I)), v \in V\left(\mathcal{Q}\left(I^{\vee}\right)\right)\right\}=s / d(s-d+1)
$$

and by Theorem 3.7, we get $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=d(s-d+1) / s$. Furthermore, by Eqs. (3.21)-(3.22) and [4, Theorem 3.2], one has

$$
\widehat{\alpha}(I)=\min \left\{|v|: v \in V\left(\mathcal{Q}\left(I^{\vee}\right)\right)\right\}=\frac{s}{s-d+1} \text { and } \widehat{\alpha}\left(I^{\vee}\right)=\min \{|u|: u \in V(\mathcal{Q}(I))\}=\frac{s}{d},
$$

where equality is attained at $(1 /(s-d+1))(1, \ldots, 1)$ and $(1 / d)(1, \ldots, 1)$, respectively. As $I$ is normal [37, Proposition 2.9], one has $\rho(I)=\rho_{i c}(I)$.

Remark 3.20. If $I=I_{d, s}$ and $2 \leq d<s$, then the number of vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ are

$$
|V(\mathcal{Q}(I))|=\sum_{k=s-d+1}^{s}\binom{s}{k} \text { and }\left|V\left(\mathcal{Q}\left(I^{\vee}\right)\right)\right|=\sum_{\ell=d}^{s}\binom{s}{\ell} .
$$

This follows from Eqs. (3.21)-(3.22).

## 4. Examples

Example 4.1. Let $S=\mathbb{Q}\left[t_{1}, \ldots, t_{7}\right]$ be a polynomial ring and let

$$
I=I(G)=\left(t_{1} t_{3}, t_{1} t_{4}, t_{2} t_{4}, t_{1} t_{5}, t_{2} t_{5}, t_{3} t_{5}, t_{1} t_{6}, t_{2} t_{6}, t_{3} t_{6}, t_{4} t_{6}, t_{2} t_{7}, t_{3} t_{7}, t_{4} t_{7}, t_{5} t_{7}\right)
$$

be the edge ideal of the graph $G$ of Figure. This graph is the complement of a cycle of length 7 and is called an odd antihole in the theory of perfect graphs.


Figure 1. Graph $G$ is the complement of a cycle of length 7.

From the minimal generating set of $I$, we get that the incidence matrix $A$ of $I$ is given by

$$
A=\left[\begin{array}{llllllllllllll}
1 & 1 & 0 & 1 & 0 & 0 & 1 & 0 & 0 & 0 & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 & 1 & 0 & 0 & 1 & 0 & 0 & 1 & 0 & 0 & 0 \\
1 & 0 & 0 & 0 & 0 & 1 & 0 & 0 & 1 & 0 & 0 & 1 & 0 & 0 \\
0 & 1 & 1 & 0 & 0 & 0 & 0 & 0 & 0 & 1 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 1 & 1 & 1 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 0 & 0 & 1 & 1 & 1 & 1 & 0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 1 & 1 & 1 & 1
\end{array}\right]
$$

Using Procedure A.1, Macaulay 2 [20] and Theorem 3.7, we obtain the following information. The vertex set $V(\mathcal{Q}(I))$ of $\mathcal{Q}(I)$ is given by

$$
\begin{aligned}
V(\mathcal{Q}(I))= & \{(0,0,1,1,1,1,1),(0,1,1,1,1,1,0),(1,0,0,1,1,1,1) \\
& (1,1,0,0,1,1,1),(1,1,1,0,0,1,1),(1,1,1,1,0,0,1) \\
& (1,1,1,1,1,0,0),(1 / 2,1 / 2,1 / 2,1 / 2,1 / 2,1 / 2,1 / 2)\}
\end{aligned}
$$

and $\widehat{\alpha}\left(I^{\vee}\right)=7 / 2$. The incidence matrix $B$ of $I^{\vee}$ is

$$
B=\left[\begin{array}{lllllll}
1 & 0 & 1 & 1 & 1 & 1 & 0 \\
1 & 1 & 1 & 1 & 1 & 0 & 0 \\
1 & 1 & 1 & 1 & 0 & 0 & 1 \\
1 & 1 & 1 & 0 & 0 & 1 & 1 \\
1 & 1 & 0 & 0 & 1 & 1 & 1 \\
0 & 1 & 0 & 1 & 1 & 1 & 1 \\
0 & 0 & 1 & 1 & 1 & 1 & 1
\end{array}\right]
$$

the vertex set $V\left(\mathcal{Q}\left(I^{\vee}\right)\right)$ of $\mathcal{Q}\left(I^{\vee}\right)$ is given by

$$
\begin{aligned}
V\left(\mathcal{Q}\left(I^{\vee}\right)\right)= & \{(0,0,0,0,1,0,1),(0,0,0,1,0,0,1),(0,0,0,1,0,1,0) \\
& (0,0,1,0,0,0,1),(0,0,1,0,0,1,0),(0,0,1,0,1,0,0) \\
& (0,0,1 / 2,0,1 / 2,0,1 / 2),(0,1,0,0,0,0,1) \\
& (0,1,0,0,0,1,0),(0,1,0,0,1,0,0),(0,1,0,1,0,0,0) \\
& (0,1 / 2,0,0,1 / 2,0,1 / 2),(0,1 / 2,0,1 / 2,0,0,1 / 2) \\
& (0,1 / 2,0,1 / 2,0,1 / 2,0),(1,0,0,0,0,1,0) \\
& (1,0,0,0,1,0,0),(1,0,0,1,0,0,0),(1,0,1,0,0,0,0) \\
& (1 / 2,0,0,1 / 2,0,1 / 2,0),(1 / 2,0,1 / 2,0,0,1 / 2,0) \\
& (1 / 2,0,1 / 2,0,1 / 2,0,0),(1 / 5,1 / 5,1 / 5,1 / 5,1 / 5,1 / 5,1 / 5)\}
\end{aligned}
$$

and $\widehat{\alpha}(I)=7 / 5$. The ic-resurgences of $I$ and $I^{\vee}$ are equal to $10 / 7$.
Example 4.2. Let $S=\mathbb{Q}\left[t_{1}, \ldots, t_{4}\right]$ be a polynomial ring and let $I=\left(t_{1} t_{2} t_{3}, t_{1} t_{4}, t_{2} t_{4}, t_{3} t_{4}\right)$ be the edge ideal of the clutter $\mathcal{C}$ (cf. [13, Example 2.26]). Using Procedure A.1, we obtain the following information. The vertex set of $\mathcal{Q}(I)$ is

$$
V(\mathcal{Q}(I))=\{(0,0,1,1),(0,1,0,1),(1,0,0,1),(1,1,1,0),(1 / 3,1 / 3,1 / 3,2 / 3)\}
$$

$\widehat{\alpha}(I)=5 / 3, I=I^{\vee}$, and $\rho_{i c}(I)=9 / 7$.
Example 4.3. Let $S=\mathbb{Q}\left[t_{1}, \ldots, t_{7}\right]$ be a polynomial ring and let

$$
I=\left(t_{1} t_{3} t_{4}, t_{1} t_{3} t_{5}, t_{1} t_{4} t_{6}, t_{2} t_{4} t_{6}, t_{5} t_{6}, t_{1} t_{3} t_{7}, t_{2} t_{3} t_{7}, t_{3} t_{5} t_{7}, t_{2} t_{6} t_{7}\right)
$$

be the edge ideal of the clutter $\mathcal{C}$. Using Procedure A. 1 and Theorem 3.7 we obtain

$$
I^{\vee}=\left(t_{1} t_{2} t_{5}, t_{2} t_{3} t_{4} t_{5}, t_{3} t_{6}, t_{4} t_{5} t_{7}, t_{1} t_{6} t_{7}\right)
$$

$\widehat{\alpha}(I)=\widehat{\alpha}\left(I^{\vee}\right)=2$, and $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=4 / 3$.
Example 4.4. Let $S=\mathbb{Q}\left[t_{1}, \ldots, t_{7}\right]$ be a polynomial ring and let

$$
I=\left(t_{1} t_{2}, t_{2} t_{3}, t_{3} t_{4}, t_{1} t_{5}, t_{4} t_{5}, t_{1} t_{6}, t_{2} t_{6}, t_{3} t_{6}, t_{4} t_{6}, t_{5} t_{6}, t_{1} t_{7}, t_{2} t_{7}, t_{3} t_{7}, t_{4} t_{7}, t_{5} t_{7}, t_{6} t_{7}\right)
$$

be the edge ideal of the clutter $\mathcal{C}$. Using Procedure A. 1 and Theorem 3.7 we obtain

$$
I^{\vee}=\left(t_{1} t_{2} t_{3} t_{4} t_{5} t_{6}, t_{1} t_{2} t_{3} t_{4} t_{5} t_{7}, t_{1} t_{2} t_{4} t_{6} t_{7}, t_{1} t_{3} t_{4} t_{6} t_{7}, t_{1} t_{3} t_{5} t_{6} t_{7}, t_{2} t_{3} t_{5} t_{6} t_{7}, t_{2} t_{4} t_{5} t_{6} t_{7}\right)
$$

$\alpha=(1 / 2,1 / 2,1 / 2,1 / 2,1 / 2,1 / 2,1 / 2)$ is a vertex of $\mathcal{Q}(I), \widehat{\alpha}\left(I^{\vee}\right)=|\alpha|=7 / 2$,

$$
\beta=(1 / 7,1 / 7,1 / 7,1 / 7,1 / 7,2 / 7,2 / 7)
$$

is a vertex of $\mathcal{Q}\left(I^{\vee}\right), \widehat{\alpha}(I)=|\beta|=9 / 7$, and $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=14 / 9$.
Example 4.5. Let $S=\mathbb{Q}\left[t_{1}, \ldots, t_{6}\right]$ be a polynomial ring and let $I=I_{d, s}$ be the $d$-th squarefree Veronese ideal of $S$ with $d=3$ and $s=6$. The ideal $I^{\vee}$ is $I_{s-d+1, s}=I_{4,6}$, that is, $I^{\vee}$ is generated in degree $4, \alpha=(1 / 4)(1,1,1,1,1,1)$ is a vertex of $\mathcal{Q}\left(I^{\vee}\right), \widehat{\alpha}(I)=|\alpha|=3 / 2$,

$$
\beta=(1 / 3)(1,1,1,1,1,1)
$$

is a vertex of $\mathcal{Q}(I), \widehat{\alpha}\left(I^{\vee}\right)=|\beta|=6 / 3=2$, and $\rho_{i c}(I)=\rho_{i c}\left(I^{\vee}\right)=2$. The number of vertices of $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$ are 22 and 42 , respectively.

## Appendix A. Procedures

In this appendix we give procedures for Macaulay2 [20] to compute the vertices of covering polyhedra and the ic-resurgence of any squarefree monomial ideal.

Procedure A.1. Let $I$ be a squarefree monomial ideal. We implement a procedure - that uses the interface of Macaulay2 [20] to Normaliz [8]-to compute the vertices of the covering polyhedra $\mathcal{Q}(I)$ and $\mathcal{Q}\left(I^{\vee}\right)$, using the Rees cones of $I$ and $I^{\vee}$ defined in Eqs. (3.1) and (3.3). Then, using Theorem 3.7, we compute the ic-resurgence $\rho_{i c}(I)$ of $I$. For convenience, in this procedure we also include the function "rhoichypes" that was given in [21, Algorithm A.4]. This procedure corresponds to Example 4.1. To compute other examples, in the next procedure simply change the polynomial rings $R$ and $S$, and the generators of $I$.
