# TOTAL STIEFEL WHITNEY CLASSES FOR REAL REPRESENTATIONS OF $\mathrm{GL}_{n}$ OVER $\mathbb{F}_{q}, \mathbb{R}$ AND $\mathbb{C}$

#### Abstract

We compute the total Stiefel Whitney class for a real representation $\pi$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd in terms of character values of $\pi$ on order 2 diagonal elements. We also compute the total Stiefel Whitney classes of real representations of $G L_{n}(\mathbb{R})$ and $\mathrm{GL}_{n}(\mathbb{C})$.

## 1. Introduction

Let $\pi$ be a real representation of a finite group $G$. One can define Stiefel Whitney classes (SWC) $w_{i}(\pi)$ for $0 \leq i \leq \operatorname{deg} \pi$ as members of the cohomology groups $H^{i}(G)=H^{i}(G, \mathbb{Z} / 2 \mathbb{Z})$. The total Stiefel Whitney class of $\pi$ in the cohomology ring $H^{*}(G)$ is defined as

$$
w(\pi)=w_{0}(\pi)+w_{1}(\pi)+\cdots+w_{d}(\pi)
$$

where $d=\operatorname{deg} \pi$. (see Ben91, Section 2.6, page no. 50] for details).
In this article, we compute the total SWC for a real representation $\pi$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd, in terms of the character values on diagonal elements of order 2. The computations for the particular case of $n=2$ can be found in GJ22. We also compute the total SWC of a real representation of $\mathrm{GL}_{n}(\mathbb{C})$ and $\mathrm{GL}_{n}(\mathbb{R})$.

The computation of second SWC for representations of $S_{n}$ and related groups can be found in GS20. Explicit expressions for the first and second SWC of the representations of $\mathrm{O}_{n}(\mathbb{R})$ were found in [GJ21] in terms of highest weights.

We will now describe our results in some more detail. Let $\mathfrak{X}$ denote the set of binary strings of length $n$. For $a=\left(a_{1}, a_{2}, \ldots, a_{n}\right) \in \mathfrak{X}$, define $\nu(a)=\sum_{i=1}^{n} a_{i} \in \mathbb{Z}$. Put $\mathfrak{X}_{i}=\{a \in \mathfrak{X} \mid \nu(a)=i\}$. Let $C_{m}$ denote the additive cyclic group of order $m$. We fix a generator $x$ for $C_{m}$.

Consider the linear character $\chi^{j}$ of $C_{m}$ given by $\chi^{j}(x)=\zeta_{m}^{j}$, where $\zeta_{m}$ is the primitive $m$ th root of unity. For $m$ even, write 'sgn' for $\chi^{m / 2}$. For a binary string $a \in \mathfrak{X}$ and $m$ even, consider the representation $\operatorname{sgn}_{a}$ of $C_{m}^{n}$, defined as $\operatorname{sgn}_{a}=$ $\boxtimes_{j=1}^{n}(\mathrm{sgn})^{a_{j}}$ (external tensor product), where

$$
(\operatorname{sgn})^{\epsilon}=\left\{\begin{array}{l}
\mathbb{1}, \quad \text { if } \epsilon=0 \\
\operatorname{sgn}, \quad \text { if } \epsilon=1
\end{array}\right.
$$

Here we use some terminologies from supercharacter theory. For more details we refer the reader to DI08. Consider the action of $S_{n}$ on $C_{2}^{n}$ by permuting the copies of $C_{2}$. If we identify $C_{2}^{n}$ with set of binary strings $\mathfrak{X}$, then the superclasses are $\mathfrak{X}_{i}$ which are orbits of $S_{n}$ action.

We will identify $C_{2}^{n}$ with the subgroup

$$
\operatorname{diag}( \pm 1, \ldots, \pm 1) \subset \operatorname{GL}_{n}(F)
$$

where $F=\mathbb{F}_{q}, \mathbb{R}$ or $\mathbb{C}$ depending upon the context. We will write

$$
h_{i}=\operatorname{diag}(\underbrace{-1, \ldots,-1}_{i \text { times }}, 1, \ldots, 1) \in \mathrm{GL}_{n}(F) .
$$

Then $h_{i}$ represents the superclass $\mathfrak{X}_{i}$. Consider the representations

$$
\begin{equation*}
\sigma_{i}=\bigoplus_{l \in \mathfrak{X}_{i}} \operatorname{sgn}_{l} \tag{1}
\end{equation*}
$$

of $C_{m}^{n}$ for $1 \leq i \leq n$. The supercharacters are the direct sum of the representations in a single orbit for the action of $S_{n}$ on characters of $C_{2}^{m}$. Then clearly the supercharacters are $\sigma_{i}$.

For $l \in \mathfrak{X}$, consider the linear character $\chi(l)$ of $C_{m}^{n}$ given by $\chi(l)=\bigotimes_{k=1}^{n} \chi^{l_{k}}$. For $1 \leq i \leq n$, take $e_{i} \in \mathfrak{X}$ such that $e_{i j}=1$ if $i=j$ and $e_{i j}=0$ otherwise. If $4 \mid m$ then

$$
H^{*}\left(C_{m}^{n}\right)=\frac{\mathbb{Z} / 2 \mathbb{Z}\left[s_{1}, \ldots, s_{n}, t_{1}, \ldots, t_{n}\right]}{\left(s_{1}^{2}, \ldots, s_{n}^{2}\right)}
$$

where $s_{i}=w_{1}\left(\operatorname{sgn}_{e_{i}}\right)$ and $t_{i}=w_{2}\left(\chi\left(e_{i}\right)_{\mathbb{R}}\right)$. On the other hand

$$
H^{*}\left(C_{2}^{n}\right)=\mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{n}\right]
$$

where $v_{i}=w_{1}\left(\operatorname{sgn}_{e_{i}}\right)$. Let $v=\left(v_{1}, \ldots, v_{n}\right)$ and $t=\left(t_{1}, \ldots, t_{n}\right)$. For $l \in \mathfrak{X}$ we write $l \cdot v($ resp. $l \cdot t)$ for $\sum_{i=1}^{n} l_{i} v_{i}$ (resp. $\left.\sum_{i=1}^{n} l_{i} t_{i}\right)$.

For a real representation $\pi$ of $\mathrm{GL}_{n}(F)$ where $F=\mathbb{F}_{q}$ or $\mathbb{R}$ or $\mathbb{C}$, consider the term

$$
c_{k}=\frac{1}{2^{n}} \sum_{i=0}^{n} \chi_{\sigma_{i}}\left(h_{k}\right) \chi_{\pi}\left(h_{i}\right),
$$

where $M=\left(\chi_{\sigma_{i}}\left(h_{k}\right)\right)$ is the matrix which is exactly the supercharacter table. Thus we explicitly compute the table by proving that $\chi_{\sigma_{i}}\left(h_{k}\right)$ is the coefficient of $y^{i}$ in the expression $(1-y)^{k}(1+y)^{n-k}$ (see Proposition (2).

TOTAL STIEFEL WHITNEY CLASSES FOR REAL REPRESENTATIONS OF GL ${ }_{n}$ OVER $\mathbb{F}_{q}, \mathbb{R}$ AND $\mathbb{C} 3$

For a real representation $\pi$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ we define

$$
\delta= \begin{cases}0, & \text { if } \operatorname{det} \pi=1 \\ 1, & \text { otherwise }\end{cases}
$$

For a subgroup $H$ of $G$ we denote by $w^{H}(\pi)$ (resp. $\left.w_{i}^{H}(\pi)\right)$ the total Stiefel Whitney class $w\left(\left.\pi\right|_{H}\right)=\operatorname{res}_{H}^{G}(w(\pi))\left(\right.$ resp. $\left.w_{i}\left(\left.\pi\right|_{H}\right)\right)$. Let $D$ denote the diagonal torus of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. We have res : $H^{*}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)\right) \hookrightarrow H^{*}(D)$ for $q \equiv 1(\bmod 4)$ and res : $H^{*}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)\right) \hookrightarrow H^{*}\left(C_{2}^{n}\right)$ for $q \equiv 3(\bmod 4)$ are injections (see AM13, Theorem 4.4, page 227]). Our main theorem, proved in Section [4, says that

Theorem 1 (Main Theorem). Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ where $q$ is odd.
(1) If $q \equiv 1(\bmod 4)$ then

$$
w^{D}(\pi)=\left(1+\delta b_{1}\right) \prod_{i=1}^{n}\left(\prod_{p \in \mathfrak{X}_{i}}(1+p \cdot t)\right)^{c_{i} / 2}
$$

where $p \cdot t=\sum_{i=1}^{n} p_{i} t_{i}$ and $b_{1}=\sum_{i=1}^{n} s_{i}$.
(2) If $q \equiv 3(\bmod 4)$ then

$$
w^{C_{2}^{n}}(\pi)=\prod_{i=1}^{n}\left(\prod_{l \in \mathfrak{X}_{i}}(1+l \cdot v)\right)^{c_{i}}
$$

where $l \cdot v=\sum_{i=1}^{n} l_{i} v_{i}$.
We use the same approach to compute the total Stiefel Whitney class of real representations of $\mathrm{GL}_{n}(\mathbb{C})$ and $\mathrm{GL}_{n}(\mathbb{R})$. We have res : $H^{*}\left(\mathrm{GL}_{n}(k)\right) \hookrightarrow H^{*}\left(C_{2}^{n}\right)$ is injective when $k=\mathbb{R}$ or $\mathbb{C}$.

Theorem 2. Let $\pi$ be a real representation of $\mathrm{GL}_{n}(\mathbb{C})$ or $\mathrm{GL}_{n}(\mathbb{R})$. Then the total Stiefel Whitney class of $\pi$ is given by

$$
\begin{equation*}
w^{C_{2}^{n}}(\pi)=\prod_{i=1}^{n}\left(\prod_{l \in \mathfrak{X}_{i}}(1+l \cdot v)\right)^{c_{i}} \tag{2}
\end{equation*}
$$

In Nak60, Corollary 6.7] Nakaoka proved that the cohomology of the symmetric group stabilizes. In particular, the result says that if $i<n / 2$, then the map res : $H^{i}\left(S_{n}\right) \rightarrow H^{i}\left(S_{2 i}\right)$ is an isomorphism. We prove a similar result for $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$.

Theorem 3. The map res : $H^{i}\left(\mathrm{GL}_{m}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{i}\left(\mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right)\right)$, where $m \geq n$ and $q \equiv 1(\bmod 4)$, is injective for $i<2 n-1$.

We have a similar result for the case when $q \equiv 3(\bmod 4)$ (see Theorem 8). We also provide criteria for spinoriality of real representations of $\operatorname{GL}_{n}\left(\mathbb{F}_{q}\right)$ where $q$ is odd (see Theorem [14). This recovers the main result in [JS21, Theorem 1]

Theorem 3 allows further simplification to calculate the second and fourth Stiefel Whitney classes. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd. Then we have

$$
\begin{aligned}
w_{2}^{D}(\pi) & =\frac{m_{\pi}}{2}\left(\sum_{i=1}^{n} t_{i}\right), \quad \text { if } q \equiv 1 \quad(\bmod 4) \\
w_{2}^{C_{2}^{n}}(\pi) & =\binom{m_{\pi}}{2}\left(\sum_{i=1}^{n} v_{i}^{2}\right), \quad \text { if } q \equiv 3 \quad(\bmod 4),
\end{aligned}
$$

where $m_{\pi}=\frac{\operatorname{dim} \pi-\chi_{\pi}\left(h_{1}\right)}{2}$. Moreover, if $q \equiv 1(\bmod 4)$, then

$$
w_{4}^{D}(\pi)=\binom{m_{\pi} / 2}{2} \sum_{i=1}^{n} t_{i}^{2}+\frac{\operatorname{dim} \pi-\chi_{\pi}\left(h_{2}\right)}{8} \sum_{1 \leq i<j \leq n} t_{i} t_{j} .
$$

As an application of the result we obtain the following property for the real principal series representations (see Section 9.1).

Theorem 4. Let $\pi$ be a real principal series representation for $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ where $q \equiv 1(\bmod 4)$. Then $w_{4}(\pi)=0$ for $n \geq 5$.

We also compute the second SWC for $q$ odd and the fourth SWC for $q \equiv 1$ $(\bmod 4)$.

We now describe the layout of the paper. In Section 2 recall some basic facts on cohomology of the groups $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ and $C_{m}^{n}$. In Section 3 we compute the SWC for $S_{n}$ invariant real representations of $C_{2}^{n}$. We prove the main theorem in Section 4. The theorems 3 and 8 are proved in Section 5. We compute the second and the fourth SWC in Section 6 using the previous results. Section 7 d shows some applications of the theory. Section 8 deals with the cases of $\mathrm{GL}_{n}(\mathbb{C})$ and $\mathrm{GL}_{n}(\mathbb{R})$. We work out some examples in Section 9 .

## 2. Notation and Preliminaries

A complex representation $(\pi, V)$ of a finite group $G$ is called orthogonal if it preserves a non degenerate symmetric bilinear form. We call $\pi$ real if the representation space $V$ is real. For a complex representation $\pi$ one can consider its realisation $\left(\pi_{\mathbb{R}}, V_{\mathbb{R}}\right)$ by forgetting the complex structure of $V$ and regarding it as a real vector space.

### 2.1. Irreducible Representations of $C_{m}^{n}$. Take the set of ordered pairs

$$
\mathcal{P}=\left\{\tau=\left(\tau_{1}, \ldots, \tau_{n}\right) \mid \tau_{j} \in C_{m}, 1 \leq j \leq n\right\}
$$

Consider the subset $\mathcal{P}^{\prime}$ of $\mathcal{P}$ given by

$$
\mathcal{P}^{\prime}=\left\{\tau=\left(\tau_{1}, \ldots, \tau_{n}\right) \mid \tau_{j} \in\{0, m / 2\}, 1 \leq j \leq n\right\} .
$$

Consider the linear character $\chi_{\tau}=\left(\chi^{\tau_{1}} \otimes \chi^{\tau_{2}} \otimes \cdots \otimes \chi^{\tau_{n}}\right)$ of $C_{m}^{n}$ (See Section 24). We have $\chi_{-\tau}=\chi_{\tau}^{\vee}$. Note that $\chi_{\tau}$ is real if $\tau \in \mathcal{P}^{\prime}$. Define an equivalence relation on $\mathcal{P}$ as

$$
\tau \sim\left(-\tau_{1},-\tau_{2}, \ldots,-\tau_{n}\right)
$$

Put $\widehat{\mathcal{P}}=\left(\mathcal{P}-\mathcal{P}^{\prime}\right) / \sim$. Therefore a real irreducible representations of $C_{m}^{n}$ is either of the form $\left(\chi_{\tau}\right)_{\mathbb{R}}$ for $\tau \in \widehat{\mathcal{P}}$ or of the form $\chi_{\tau}$ where $\tau \in \mathcal{P}^{\prime}$.

2.2. Cohomology of $G L_{n}\left(\mathbb{F}_{q}\right)$, for $q \equiv 1(\bmod 4)$. The cohomology ring of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 1(\bmod 4)$ is given by

$$
\begin{equation*}
H^{*}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right), \mathbb{Z} / 2 \mathbb{Z}\right)=\mathbb{Z} / 2 \mathbb{Z}\left[a_{2}, a_{4}, \ldots, a_{2 n}\right] \otimes E\left[b_{1}, b_{3}, \ldots, b_{2 n-1}\right] \tag{3}
\end{equation*}
$$

where
$a_{2 l}=\sum_{i_{1}<i_{2}<\ldots<i_{l}} t_{i_{1}} \cdots t_{i_{l}}, \quad b_{2 l-1}=\sum_{i_{1}<i_{2}<\ldots<i_{l}, 1 \leq j \leq l} t_{i_{1}} \cdots \hat{t}_{i_{j}} \cdots t_{i_{l}} s_{i_{j}}, \quad 1 \leq l \leq n$, and $E\left[b_{1}, \ldots, b_{2 n-1}\right]$ denotes the alternating algebra. For details we refer the reader to [FP06, Theorem 8.1, page 288].

We know that the symmetric group $S_{n}$ is the Weyl group of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ with respect to the diagonal torus $D$. It acts on $D$ by permuting the diagonal entries.

Proposition 1. Let $\pi$ be a representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. Then $\left.\pi\right|_{D}$ is $S_{n}$ invariant. Proof. We leave the proof to the reader.

This enables us to work with $S_{n}$ invariant representations of $D$.
Definition 1. Let $G^{\prime}$ be a subgroup of a finite group $G$. We say that $G^{\prime}$ detects the (mod 2) cohomology of $G$, provided that the restriction map

$$
\begin{equation*}
\text { res : } H^{*}(G, \mathbb{Z} / 2 \mathbb{Z}) \rightarrow H^{*}\left(G^{\prime}, \mathbb{Z} / 2 \mathbb{Z}\right) \tag{4}
\end{equation*}
$$

is injective.
The action of $S_{n}$ on $D$ induces an action of $S_{n}$ on $H^{*}(D)$. We write $H^{*}(D)^{S_{n}}$ to denote the subalgebra fixed under the action.

Theorem 5 (Corollary of Theorem 3, page 571 Quillen). The diagonal subgroup $D$ detects the cohomology of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. In fact, the homomorphism

$$
H^{*}\left(\operatorname{GL}_{n}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{*}(D)
$$

induced from the restriction of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ to $D$ is injective. Moreover, the image lies inside $H^{*}(D)^{S_{n}}$.

## 3. SWC of $S_{n}$ Invariant Representations of $C_{2}^{n}$

An $S_{n}$ invariant representation of $C_{2}^{n}$ will be of the form

$$
\begin{equation*}
\pi=\bigoplus_{i=0}^{n} c_{i} \sigma_{i} \tag{5}
\end{equation*}
$$

where $\sigma_{i}$ is as in (1).
Proposition 2. The character value $\chi_{\sigma_{i}}\left(h_{k}\right)$ is equal to the coefficient of $y^{i}$ in the expression $(1-y)^{k}(1+y)^{n-k}$.
Proof. Fix two integers $i, k$ such that $0 \leq i, k \leq n$. Let $R_{l}$ denote the set of elements $a \in \mathfrak{X}_{i}$ such that the first $k$ coordinates of $a$ contains $l$ number of 1 's. Then for $a \in R_{l}$ we have $\chi_{\operatorname{sgn}_{a}}\left(h_{k}\right)=(-1)^{l}$. Put $\tau_{l}=\bigoplus_{a \in R_{l}} \operatorname{sgn}_{a}$. Then

$$
\chi_{\tau_{l}}\left(h_{k}\right)=\binom{k}{l}\binom{n-k}{i-l}(-1)^{l} .
$$

Observe that $\bigoplus_{l=0}^{k} \tau_{l}=\sigma_{i}$. Thus

$$
\begin{equation*}
\chi_{\sigma_{i}}\left(h_{k}\right)=\sum_{l=0}^{k}\binom{k}{l} \cdot\binom{n-k}{i-l}(-1)^{l} . \tag{6}
\end{equation*}
$$

Note that this gives the coefficient of $y^{i}$ in $(1-y)^{k}(1+y)^{n-k}$.

From (5) we have

$$
\begin{equation*}
\chi_{\pi}\left(h_{i}\right)=\sum_{j=0}^{n} c_{j} \cdot \chi_{\sigma_{j}}\left(h_{i}\right) \tag{7}
\end{equation*}
$$

Define matrix $M=\left(m_{i j}\right)$ where $0 \leq i, j \leq n$ such that

$$
\begin{equation*}
m_{i j}=\chi_{\sigma_{j}}\left(h_{i}\right) \tag{8}
\end{equation*}
$$

Take $a={ }^{t}\left(\chi_{\pi}\left(h_{0}\right), \ldots, \chi_{\pi}\left(h_{n}\right)\right)$ and $m={ }^{t}\left(c_{0}, \ldots, c_{n}\right)$, where ${ }^{t} A$ denotes the transpose of the matrix $A$. Observe that

$$
\begin{equation*}
a=M \cdot m \tag{9}
\end{equation*}
$$

Theorem 6. We have

$$
M^{2}=2^{n} I_{n+1}
$$

where $I_{n+1}$ denotes the identity matrix of rank $n+1$.
Proof. Let

$$
R_{i}=\left(m_{i 0}, \ldots, m_{i n}\right)
$$

be the $i$-th row of $M$. Note that from Proposition 2 the element $m_{i l}, 0 \leq l \leq n$, is equal to the coefficient of $y^{l}$ in $(1-y)^{i}(1+y)^{n-i}$.

We calculate the $x$-th row in the matrix $M^{2}$.

$$
\begin{aligned}
\sum_{l=0}^{n}\left(M^{2}\right)_{x l} y^{l} & =\sum_{l=0}^{n}\left(\sum_{i=0}^{n} m_{x i} m_{i l} y^{l}\right) \\
& =\sum_{i=0}^{n} m_{x i}\left(\sum_{l=0}^{n} m_{i l} y^{l}\right) \\
& =\sum_{i=0}^{n} \chi_{\sigma_{i}}\left(h_{x}\right)(1-y)^{i}(1+y)^{n-i} \\
& =\sum_{i=0}^{n}\left(\sum_{l=0}^{x}\binom{x}{l} \cdot\binom{n-x}{i-l}(-1)^{l}\right)(1-y)^{i}(1+y)^{n-i} \\

& =\sum_{l=0}^{x}\binom{x}{l}(-1)^{l}\left(\sum_{t=0}^{n-x}\binom{n-x}{t}(1-y)^{t+l}(1+y)^{n-t-l}\right) \\
& \left.=\sum_{l=0}^{x}\binom{x}{l}(-1)^{l}(1-y)^{l}\left(\begin{array}{c}
n-x \\
t=0 \\
n-x \\
t
\end{array}\right)(1-y)^{t}(1+y)^{n-t-l-x+x}\right) \\
& =\sum_{l=0}^{x}\binom{x}{l}(-1)^{l}(1-y)^{l}(1+y)^{x-l}\left(\sum_{t=0}^{n-x}\binom{n-x}{t}(1-y)^{t}(1+y)^{n-x-t}\right) \\
& =\sum_{l=0}^{x}\binom{x}{l}(y-1)^{l}(y+1)^{x-l}(1-y+1+y)^{n-x} \\
& =(2 y)^{x} 2^{n-x} \\
& =2^{n} y^{x} .
\end{aligned}
$$

Since $M$ is invertible, we have

Proposition 3. Let $\pi$ be the representation of $C_{2}^{n}$ as in equation (5). Then we have

Proof. The proof follows from Equations (8) (10) and Theorem 6 .
Theorem 7. Let $\pi$ be an $S_{n}$ invariant representation of $C_{2}^{n}$ of the form $\pi=$ $\bigoplus_{i=1}^{n} c_{i} \sigma_{i}$. Then we have

Proof. We have

## 4. PROOF OF MAIN THEOREM

For a subset $\mathrm{I}=\left\{i_{1}, i_{2}, \ldots, i_{l}\right\}$ of $\{1,2, \ldots, n\}$ and for a multiset $\mathrm{J}=\left\{j_{1}, j_{2}, \ldots, j_{k}\right\}$ where $j_{i} \in\{1,2, \ldots, n\}$ we define

s^{\mathrm{I}}=s_{i_{1}} \cdots s_{i_{l}} \text { and } t^{\mathrm{J}}=t_{j_{1}} t_{j_{2}} \cdots t_{j_{k}} .

Observe that $H^{*}\left(C_{4 m}^{n}\right)=\frac{\mathbb{Z} / 2 \mathbb{Z}\left[s_{1}, \ldots, s_{n}, t_{1}, \ldots, t_{n}\right]}{\left(s_{1}^{2}, \ldots, s_{n}^{2}\right)}$ is a $\mathbb{Z} / 2 \mathbb{Z}$ vector space with basis $s^{\mathrm{I}} t^{\mathrm{J}}$, where I ( resp. J) varies over all subsets (resp. multi-sets) over $\{1,2, \ldots, n\}$.

Proposition 4. Let $q \equiv 1(\bmod 4)$. If $\pi$ is a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ and if $w(\pi)=\sum_{I, J} a_{I, J} s^{I} t^{J}$, then elements of the form $s^{I}$ have coefficient 0 i.e. $a_{I, \emptyset}=0$ if $|I| \geq 2$.

Proof. Consider the projection map

$$
\operatorname{pr}: \frac{\mathbb{Z} / 2 \mathbb{Z}\left[s_{1}, \ldots, s_{n}, t_{1}, \ldots, t_{n}\right]}{\left(s_{1}^{2}, \ldots, s_{n}^{2}\right)} \rightarrow \frac{\mathbb{Z} / 2 \mathbb{Z}\left[s_{1}, \ldots, s_{n}\right]}{\left(s_{1}^{2}, \ldots, s_{n}^{2}\right)}
$$

defined by $\operatorname{pr}\left(s_{i}\right)=s_{i}$ and $\operatorname{pr}\left(t_{i}\right)=0$ for all $i$. This gives $\operatorname{pr}\left(a_{2 i}\right)=0$ for all $i$ and $\operatorname{pr}\left(b_{2 i-1}\right)=0$ for $i>1$. Then from Equation (3) we have

Now if $s^{I}$ appears as a term in $w(\pi)$, where $|I| \geq 2$, then it survives in $\operatorname{pr}(w(\pi))$. But this contradicts Equation (12).

Proof of Main Theorem 1. Let $\widehat{P}$ be as defined in Section 2, Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. Recall that for a subgroup $H$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ we write $w_{i}^{H}(\pi)$ and $w^{H}(\pi)$ to denote $w_{i}\left(\left.\pi\right|_{H}\right)$ and $w\left(\left.\pi\right|_{H}\right)$ respectively.

Since $\left.\pi\right|_{D}$ is an $S_{n}$ invariant representation of $D$ we write

\left.\pi\right|_{D}=\mathbb{1}^{\oplus m_{0}} \bigoplus_{i=1}^{n} \sigma_{i}^{\oplus m_{i}} \bigoplus_{\tau \in \widehat{P}}\left(\left(\chi_{\tau}\right)_{\mathbb{R}}\right)^{\oplus m_{\tau}} \tag{13}
\end{equation*}
$$

Therefore we may write

w^{D}(\pi) & =w\left(\mathbb{1}^{\oplus m_{0}} \bigoplus_{i=1}^{n} \sigma_{i}^{\oplus m_{i}}\right) \cdot w\left(\bigoplus_{\tau \in \widehat{P}}\left(\left(\chi_{\tau}\right)_{\mathbb{R}}\right)^{\oplus m_{\tau}}\right) \\
& =\left(1+Q\left(s_{1}, \ldots, s_{n}\right)\right)\left(1+P\left(t_{1}, \ldots, t_{n}\right)\right)(\text { where } P, Q \text { do not have constant term) } \\
& =\left(1+\delta b_{1}\right)\left(1+P\left(t_{1}, \ldots t_{n}\right)\right)(\text { follows from Proposition4) }
\end{aligned}
$$

This calculation shows that $w_{1}^{D}(\pi)=\delta b_{1}$. From this we conclude that

$$
\delta=\left\{\begin{array}{l}
0, \text { if } \operatorname{det} \pi=1 \\
1, \text { otherwise }
\end{array}\right.
$$

Consider the representation $\psi=\left(\chi^{1}\right)_{\mathbb{R}}$ of $C_{q-1}$. Let $C_{2}<C_{q-1}$ be the subgroup of order 2. Then the restriction map res : $H^{*}\left(C_{q-1}\right) \rightarrow H^{*}\left(C_{2}\right)$ maps $t=w_{2}(\psi)$ to $w_{2}^{C_{2}}(\psi)=w_{2}(\operatorname{sgn} \oplus \operatorname{sgn})=v^{2}$. Thus the restriction map $\operatorname{res}_{n}: H^{*}\left(C_{q-1}^{n}\right) \rightarrow$ $H^{*}\left(C_{2}^{n}\right)$ maps $t_{i}$ to $v_{i}^{2}$ and $s_{i}$ to 0.

w^{C_{2}^{n}}(\pi) & =1+P\left(v_{1}^{2}, \ldots, v_{n}^{2}\right)  \tag{14}\\
& =\left(1+P\left(v_{1}, \ldots, v_{n}\right)\right)^{2} . \tag{15}
\end{align*}
$$

On the other hand $\left.\pi\right|_{C_{2}^{n}}$ is an $S_{n}$ invariant representation, therefore by Theorem 7 we have

w^{C_{2}^{n}}(\pi)=\prod_{i=1}^{n}\left(\prod_{l \in \mathfrak{X}_{i}}\left(1+\sum_{j} l_{j} v_{j}\right)\right)^{c_{i}}
$$

where $c_{i}=\frac{1}{2^{n}} \sum_{k=0}^{n} \chi_{\sigma_{k}}\left(h_{i}\right) \chi_{\pi}\left(h_{k}\right)$. Now since $H^{*}\left(C_{2}^{n}\right)=\mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{n}\right]$ is a Unique Factorization domain, we have $1+P\left(v_{1}, \ldots, v_{n}\right)=\prod_{i=1}^{n}\left(\prod_{l \in \mathfrak{X}_{i}}\left(1+\sum_{j} l_{j} v_{j}\right)\right)^{c_{i} / 2}$.

Thus we obtain

w^{D}(\pi)=\left(1+\delta b_{1}\right) \prod_{i=1}^{n}\left(\prod_{l \in \mathfrak{X}_{i}}(1+l \cdot t)\right)^{c_{i} / 2}
$$

where $l \cdot t=\sum_{j} l_{j} t_{j}$.
In the case $q \equiv 3(\bmod 4)$ we have

\operatorname{res}_{\mathrm{C}_{2}^{\mathrm{n}}}^{\mathrm{D}}: H^{*}(D) \rightarrow H^{*}\left(C_{2}^{n}\right)
$$

is an isomorphism as $C_{2}^{n}$ is the 2 Sylow subgroup of $D$. (see GJ22, Propositions 5 and 6$]$ ). Now we apply Theorem 7 to obtain

where again $c_{i}=\frac{1}{2^{n}} \sum_{k} \chi_{\sigma_{k}}\left(h_{i}\right) \chi_{\pi}\left(h_{k}\right)$. This completes the proof of the main theorem.

Remark 1. Since $c_{i}$ is the multiplicity of $\sigma_{i}$ in $\left.\pi\right|_{C_{2}^{n}}$, it is an integer, where $\sigma_{i}$ is a representation of $C_{2}^{n}$. Moreover, if $q \equiv 1(\bmod 4)$, then $\left.\sigma_{j}\right|_{C_{2}^{n}}=\binom{n}{j} \mathbb{1}$, where $\sigma_{j}$ is a representation of $D$. Also $\left.(\chi)_{\mathbb{R}}\right|_{C_{2}^{n}}=\left.2 \chi\right|_{C_{2}^{n}}$. Therefore the integers $c_{i}$ are even for $i \geq 1$.

Remark 2. For a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 1(\bmod 4)$, one can write the expression for $w(\pi)$ in terms of the generators of $H^{*}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)\right)$, namely $a_{2 l}, b_{2 l-1}$ for $1 \leq l \leq n$. This follows from the fact that the terms $a_{2 l}$ are elementary symmetric functions in $t_{i}$ for $1 \leq i \leq n$. For example if $n=3$, then

& \left(1+t_{1}+t_{2}+t_{3}\right)^{m_{3}} .
\end{aligned}
$$

Therefore one has

w(\pi)= & \left(1+\delta \cdot b_{1}\right)\left(1+a_{2}+a_{4}+a_{6}\right)^{m_{1}} \\
& \left(1+a_{2}^{2}+2 a_{2}+a_{4}+a_{2} a_{4}-a_{6}\right)^{m_{2}} \\
& \left(1+a_{2}\right)^{m_{3}} .
\end{aligned}
$$

## 5. Detection Results

We write

E\left[x_{1}, \ldots, x_{n}\right]=\frac{\mathbb{Z} / 2 \mathbb{Z}\left[x_{1}, \ldots, x_{n}\right]}{\left(x_{1}^{2}, \ldots, x_{n}^{2}\right)}
$$

Let $D_{n}$ denote the diagonal torus of $\operatorname{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 1(\bmod 4)$. Take $m \geq n$. We have

H^{*}\left(D_{m}\right)=\frac{\mathbb{Z} / 2 \mathbb{Z}\left[t_{1}, \ldots, t_{m}, s_{1}, \ldots, s_{m}\right]}{\left(s_{1}^{2}, \ldots, s_{n}^{2}\right)}
$$

and

$$
H^{*}\left(D_{n-1}\right)=\frac{\mathbb{Z} / 2 \mathbb{Z}\left[t_{1}^{\prime}, \ldots, t_{n-1}^{\prime}, s_{1}^{\prime}, \ldots, s_{n-1}^{\prime}\right]}{\left(s_{1}^{\prime 2}, \ldots, s_{n}^{\prime 2}\right)}
$$

Consider the inclusion map $j_{n}: \mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right) \rightarrow \mathrm{GL}_{m}\left(\mathbb{F}_{q}\right)$ given by

$$
j_{n}(A)=\left(\begin{array}{cc}
A & 0 \\
0 & I_{m-n+1}
\end{array}\right),
$$

where $A \in \mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right)$. It will induce a map on the diagonal subgroups namely $j_{n}: D_{n-1} \rightarrow D_{m}$ (we use the same notation for the induced map). We have

j_{n}^{*}\left(t_{l}\right)= \begin{cases}t_{l}^{\prime}, & \text { if } l<n \\ 0, & \text { if } l \geq n\end{cases}
$$

Similarly

j_{n}^{*}\left(s_{l}\right)= \begin{cases}s_{l}^{\prime}, & \text { if } l<n \\ 0, & \text { if } l \geq n\end{cases}
$$

It will induce a map
$j_{n}^{*}: \mathbb{Z} / 2 \mathbb{Z}\left[a_{2}, \ldots, a_{2 m}\right] \otimes E\left[b_{1}, b_{3}, \ldots, b_{2 m-1}\right] \rightarrow \mathbb{Z} / 2 \mathbb{Z}\left[a_{2}^{\prime}, \ldots, a_{2 n-2}^{\prime}\right] \otimes E\left[b_{1}^{\prime}, \ldots, b_{2 n-3}^{\prime}\right]$,
where

$$
j_{n}^{*}\left(a_{2 l}\right)=a_{2 l}^{\prime}=\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{l} \leq n-1} t_{i_{1}}^{\prime} \cdots t_{i_{l}}^{\prime}
$$

for $l<n$ and

$$
j_{n}^{*}\left(b_{2 k-1}\right)=b_{2 k-1}^{\prime}=\sum_{1 \leq j \leq k}\left(\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k} \leq n-1} t_{i_{1}}^{\prime} \cdots \hat{t}_{i_{j}}^{\prime} \cdots t_{i_{k}}^{\prime} s_{i_{j}}^{\prime}\right)
$$

for $k<n$. Therefore $j_{n}^{*}\left(a_{2 l}\right)=0$ when $l \geq n$ and $j_{n}^{*}\left(b_{2 k-1}\right)=0$ for $k \geq n$.
Proof of Theorem 3. Put $R_{m}=\mathbb{Z} / 2 \mathbb{Z}\left[a_{2}, \ldots, a_{2 m}\right], E_{m}=E\left[b_{1}, b_{3}, \ldots, b_{2 m-1}\right], R_{n-1}^{\prime}=$ $\mathbb{Z} / 2 \mathbb{Z}\left[a_{2}^{\prime}, \ldots, a_{2 n-2}^{\prime}\right]$ and $E_{n-1}^{\prime}=E\left[b_{1}^{\prime}, b_{3}^{\prime}, \ldots, b_{2 n-3}^{\prime}\right]$. Since the elements $a_{2}, \ldots, a_{2 n-2}$ are algebraically independent, we have

\left.\operatorname{ker} j_{n}^{*}\right|_{R_{m}}=\left\langle a_{2 n}, a_{2 n+2}, \ldots, a_{2 m}\right\rangle
$$

Take $R_{m}=\bigoplus_{i} A_{i}$ and $R_{n-1}^{\prime}=\bigoplus_{i} A_{i}^{\prime}$, where $A_{i}$ and $A_{i}^{\prime}$ are the $i$-th degree components. Then comparing degrees we have $A_{i} \cap \operatorname{ker} j_{n}^{*}=0$, for $i<2 n$. So the map $j_{n}^{*}: A_{i} \rightarrow A_{i}^{\prime}$ is injective for $i<2 n-1$.

Note that $E\left[b_{1}, b_{3}, \ldots, b_{2 m-1}\right]$ is a $\mathbb{Z} / 2 \mathbb{Z}$ vector space with basis elements

b_{2 i_{1}-1} \cdots b_{2 i_{k}-1}
$$

where $1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq m$ and $1 \leq k \leq m$. In each basis element a particular $b_{j}$ can have exponent 1 or 0 . Therefore $\operatorname{dim} E\left[b_{1}, b_{3}, \ldots, b_{2 m-1}\right]=2^{m}$. Similarly $\operatorname{dim} E\left[b_{1}^{\prime}, b_{3}^{\prime}, \ldots, b_{2 n-3}^{\prime}\right]=2^{n-1}$. Since $j_{n}^{*}$ is surjective we have $\left.\operatorname{dim} \operatorname{ker} j_{n}^{*}\right|_{E_{m}}=$ $2^{m}-2^{n-1}$.

Consider the ideal $\mathfrak{I}=\left\langle b_{2 n-1}, b_{2 n+1}, \ldots, b_{2 m-1}\right\rangle$ of $E_{m}$. As a $\mathbb{Z} / 2 \mathbb{Z}$ vector space $\operatorname{dim} \mathfrak{I}=2^{m}-2^{n-1}$. Also for $x \in \mathfrak{I}$ one has $j_{n}^{*}(x)=0$. Therefore we obtain

\left.\operatorname{ker} j_{n}^{*}\right|_{E_{m}}=\left\langle b_{2 n-1}, b_{2 n+1}, \ldots, b_{2 m-1}\right\rangle
$$

Let $E_{m}=\bigoplus_{i} B_{i}$ and $E_{n-1}^{\prime}=\bigoplus_{j} B_{j}^{\prime}$. Comparing the degrees we get ker $j_{n}^{*} \cap B_{i}=0$ for $i<2 n-1$. So the map $j_{n}^{*}: B_{i} \rightarrow B_{i}^{\prime}$ is injective for $i<2 n-1$.

The $i$ th graded part of $R_{m} \otimes E_{m}$ is of the form $\bigoplus_{k+l=i} A_{k} \otimes B_{l}$. Similarly, the $i$ th graded part of $R_{(n-1)}^{\prime} \otimes E_{(n-1)}^{\prime}$ is of the form $\underset{k+l=i}{ } A_{k}^{\prime} \otimes B_{l}^{\prime}$. To show the injectivity of the map $j_{n}^{*}$ it is enough to show that the map $j_{n}^{*}: A_{k} \otimes B_{i-k} \rightarrow A_{k}^{\prime} \otimes B_{i-k}^{\prime}$ is injective for every $0 \leq k \leq i<2 n-1$. It follows from the fact that the maps $j_{n}^{*}: A_{k} \rightarrow A_{k}^{\prime}$ and $j_{n}^{*}: B_{k} \rightarrow B_{k}^{\prime}$ are injective for $0 \leq i<2 n-1$.
Theorem 8. The map res : $H^{i}\left(\mathrm{GL}_{m}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{i}\left(\mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right)\right)$, where $m \geq n$ and $q \equiv 3(\bmod 4)$ is injective for $i<n$.

Proof. From Theorembwe obtain that the map res ${ }_{m}: H^{i}\left(\mathrm{GL}_{m}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{i}\left(D_{m}\right)^{S_{m}}$ is injective. Let $\alpha: H^{i}\left(\mathrm{GL}_{m}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{i}\left(\mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right)\right)$ denote the restriction map.

We have $H^{*}\left(D_{k}\right)^{S_{k}}=\mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{k}\right]^{S_{k}}$. Consider the map

$$
\beta_{n}^{*}: \mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{m}\right]^{S_{m}} \rightarrow \mathbb{Z} / 2 \mathbb{Z}\left[v_{1}^{\prime}, \ldots, v_{n-1}^{\prime}\right]^{S_{n-1}}
$$

given by

$$
\beta_{n}^{*}\left(v_{i}\right)= \begin{cases}v_{i}^{\prime}, & \text { if } i<n \\ 0, & \text { if } i \geq n\end{cases}
$$

Note that $\beta_{n}^{*}$ induces a map

$$
\beta_{n i}^{*}: H^{i}\left(D_{m}\right)^{S_{m}} \rightarrow H^{i}\left(D_{n-1}\right)^{S_{n-1}} .
$$

Consider the following commutative diagram.


Since the maps $\operatorname{res}_{m}$ and $\operatorname{res}_{n-1}$ are injective, it is enough to prove that the map $\beta_{n i}^{*}$ is injective. Let $f_{i}^{k}$ denote the elementary symmetric polynomial of degree $i$ in $k$ variables $v_{1}, \ldots, v_{k}$, where $k \geq i$. Note that $\beta_{n i}^{*}\left(f_{i}^{k}\right) \neq 0$ for $1 \leq i \leq n-1 \leq k$. We know that the set of elementary symmetric functions form a basis for the algebra $\mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{m}\right]^{S_{m}}$. An element in $\mathbb{Z} / 2 \mathbb{Z}\left[v_{1}, \ldots, v_{m}\right]^{S_{m}}$ of degree $i \leq n-1$ is of the form $P\left(f_{1}^{m}, \ldots, f_{i}^{m}\right)$, where $P$ is a polynomial (see Lan02, Theorem 6.1, page 191]). We have $\beta_{n i}^{*}\left(P\left(f_{1}^{m}, \ldots, f_{i}^{m}\right)\right)=P\left(f_{1}^{n-1}, \ldots, f_{i}^{n-1}\right)$. Therefore $\beta_{n}^{*}\left(P\left(f_{1}^{m}, \ldots, f_{i}^{m}\right)\right) \neq 0$ as the elements $f_{1}^{n-1}, \ldots, f_{i}^{n-1}$ are algebraically independent. So $\beta_{n i}^{*}$ is injective for $i \leq n-1$.

## 6. Calculations of Some SWC

6.1. Calculations Using the Main Theorem. Here we calculate small SWCs using the main result.
6.1.1. For $\mathbf{q} \equiv \mathbf{1}(\bmod 4)$. From the main theorem we have for $q \equiv 1(\bmod 4)$,

w(\pi)=\left(1+\delta b_{1}\right) \prod_{i=1}^{n}\left(\prod_{p \in \mathfrak{X}_{i}}(1+p \cdot t)\right)^{c_{i} / 2}
$$

Here we calculate $w_{2}(\pi)$. It is clear from the above expression that

w_{2}(\pi) & =\sum_{j=1}^{n}\left(c_{j} / 2\right)\left(\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{j} \leq n}\left(t_{i_{1}}+t_{i_{2}}+\cdots+t_{i_{j}}\right)\right) \\
& =\frac{1}{2} \sum_{j=1}^{n} c_{j}\binom{n-1}{j-1}\left(\sum_{i=1}^{n} t_{i}\right) \\
& =\frac{1}{2} \sum_{j=1}^{n} c_{j}\binom{n-1}{j-1} a_{2}
\end{aligned}
$$

Let $m={ }^{t}\left[c_{0}, c_{1}, \ldots, c_{n}\right]$ and $J=\left[0,\binom{n-1}{0},\binom{n-1}{1}, \ldots,\binom{n-1}{n-1}\right]$. So we have

$$
\begin{equation*}
J m=\sum_{j=1}^{n}\binom{n-1}{j-1} c_{j} . \tag{16}
\end{equation*}
$$

Using Equation (9) and Theorem 6 we have $m=\left(1 / 2^{n}\right) M a$. As in the proof of Theorem 1, let $R_{i}=\left(m_{i 0}, m_{i 1}, \ldots, m_{i n}\right)$ be the $i$-th row of $M$ which satisfies $\sum_{j=0}^{n} m_{i j} y^{j}=(1-y)^{i}(1+y)^{n-i}$. We calculate $J M$.

Proposition 5. We have $J m=\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)}{2}$.

Proof. We identify a $1 \times(n+1)$ vector $\left(m_{i 0}, \ldots, m_{i n}\right)$ with the polynomial $\sum_{j=0}^{n} m_{i j} y^{j}=$ $(1-y)^{i}(1+y)^{n-i}$. We compute

J M & =\sum_{i=1}^{n}\binom{n-1}{i-1}(1-y)^{i}(1+y)^{n-i} \quad \text { Put } \quad i-1=\alpha \\
& =\sum_{\alpha=0}^{n-1}\binom{n-1}{\alpha}(1-y)^{\alpha+1}(1+y)^{n-1-\alpha} \\
& =(1-y) \sum_{\alpha=0}^{n-1}\binom{n-1}{\alpha}(1-y)^{\alpha}(1+y)^{n-1-\alpha} \\
& =(1-y)(1-y+1+y)^{n-1} \\
& =2^{n-1}(1-y) \\
& =\left[2^{n-1},-2^{n-1}, 0, \ldots, 0\right] .
\end{aligned}
$$

Thus we have

J m & =\left(1 / 2^{n}\right) J M a \\
& =\left(1 / 2^{n}\right)\left[2^{n-1},-2^{n-1}, 0, \ldots, 0\right]^{t}\left[\chi_{\pi}\left(h_{0}\right), \chi_{\pi}\left(h_{1}\right), \ldots, \chi_{\pi}\left(h_{n}\right)\right] \\
& =(1 / 2)\left(\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)\right) .
\end{aligned}
$$

So for $q \equiv 1(\bmod 4)$ we have

$$
w_{2}(\pi)=\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)}{4} a_{2}
$$

### 6.1.2. $\operatorname{For} \mathbf{q} \equiv \mathbf{3} \bmod 4$.

Theorem 9. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 3(\bmod 4)$.
Then

$$
w_{1}(\pi)=\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)}{2}\left(\sum_{i=1}^{n} v_{i}\right) .
$$

Proof. We have

$$
w(\pi)=\prod_{i=1}^{n}\left(\prod_{b \in \mathfrak{X}_{i}}(1+v \cdot b)\right)^{c_{i}}
$$

We write $v \cdot b$ for $\sum_{i=1}^{n} v_{i} b_{i}$. In particular,

$$
w_{1}(\pi)=\sum_{i=1}^{n} c_{i}\binom{n-1}{i-1}\left(\sum_{i=1}^{n} v_{i}\right)=\operatorname{Jm}\left(\sum_{i=1}^{n} v_{i}\right) .
$$

Now the proof follows from Proposition 5
Now we calculate $w_{2}(\pi)$. For $b \in \mathfrak{X}_{i}$ let $E_{b}=(1+v \cdot b)^{c_{i}}$ and $P_{i}=\prod_{b \in \mathfrak{X}_{i}} E_{b}$. Note that
$(1+v \cdot b)^{c_{i}}=\left(1+c_{i}\left(\sum_{s=1}^{i} v_{j_{s}}\right)+\binom{c_{i}}{2}\left(\sum_{s=1}^{i} v_{j_{s}}^{2}\right)+2\binom{c_{i}}{2}\left(\sum_{k<l} v_{j_{k}} v_{j_{l}}\right)+T_{3}\right)$,
where $\left\{j_{1}, \ldots, j_{i}\right\}$ are such that $b_{j_{s}}=1$ and $T_{3}$ denotes the terms with degree greater than or equal to 3 . Let $N_{i}$ denote the number of elements in $\mathfrak{X}_{i}$ with 1 in a fixed position. We have $N_{i}=\binom{n-1}{i-1}$. Put $N_{i}^{\prime}=\binom{n-2}{i-2}$ which is the number of

Also consider $N_{i}^{\prime \prime}=\binom{n-2}{i-1}$ to be the number of elements in $\mathfrak{X}_{i}$ with 1 in one fixed position and 0 in other fixed position. The coefficient of $\sum_{t=1}^{n} v_{t}^{2}$ in the symmetric polynomial $P_{i}$ is

$$

The coefficient of $\sum_{1 \leq l<k \leq n} v_{k} v_{l}$ in $P_{i}$ is

2\binom{n-2}{i-2}\binom{c_{i}}{2}+c_{i}^{2} N_{i}^{\prime}\left(N_{i}^{\prime}-1\right)+c_{i}^{2} \cdot 2 N_{i}^{\prime} N_{i}^{\prime \prime}+c_{i}^{2} N_{i}^{\prime \prime 2} \tag{17}
\end{equation*}
$$

We ignore the term $2\binom{n-2}{i-2}\binom{c_{i}}{2}$ since it is even.
We calculate

c_{i}^{2} N_{i}^{\prime}\left(N_{i}^{\prime}-1\right)+c_{i}^{2} \cdot 2 N_{i}^{\prime} N_{i}^{\prime \prime}+c_{i}^{2} N_{i}^{\prime \prime 2} & =c_{i}^{2}\left(N_{i}^{\prime 2}+2 N_{i}^{\prime} N_{i}^{\prime \prime}+N_{i}^{\prime \prime 2}-N_{i}^{\prime}\right) \\
& =c_{i}^{2}\left(\left(N_{i}^{\prime}+N_{i}^{\prime \prime}\right)^{2}-N_{i}^{\prime}\right) \\
& =c_{i}^{2}\left(N_{i}^{2}-N_{i}^{\prime}\right),\left(\operatorname{using} \text { identity } N_{i}^{\prime}+N_{i}^{\prime \prime}=N_{i}\right) \\
& =c_{i}\left(N_{i}-N_{i}^{\prime}\right) \quad(\bmod 2) \\
& =c_{i} N_{i}^{\prime \prime} \quad(\bmod 2) .
\end{aligned}
$$

Since $w(\pi)=\prod_{i} P_{i}$, we have

w_{2}(\pi) & =\left(\sum_{1 \leq i<j \leq n} N_{i} N_{j} c_{i} c_{j}+\sum_{i=1}^{n} N_{i}\binom{c_{i}}{2}+\sum_{i=1}^{n} c_{i}^{2}\binom{N_{i}}{2}\right)\left(\sum_{t=1}^{n} v_{t}^{2}\right) \\
& +\left(\sum_{i=1}^{n} c_{i} N_{i}^{\prime \prime}+2 \sum_{1 \leq i<j \leq n} N_{i} N_{j} c_{i} c_{j}\right) \cdot\left(\sum_{k<l} v_{k} v_{l}\right) \tag{18}
\end{align*}
$$

The Vandermonde identity says

Using this identity we calculate

\binom{\sum_{i=1}^{n} c_{i} N_{i}}{2} & =\sum_{i=1}^{n}\binom{c_{i} N_{i}}{2}+\sum_{1 \leq l<k \leq n} c_{l} c_{k} N_{l} N_{k} \\
& =\sum_{i=1}^{n}\left(\sum_{k_{1}+\cdots+k_{N_{i}}=2}\binom{c_{i}}{k_{1}} \cdots\binom{c_{i}}{k_{N_{i}}}\right)+\sum_{1 \leq l<k \leq n} c_{l} c_{k} N_{l} N_{k} \\
& =\sum_{i=1}^{n} N_{i}\binom{c_{i}}{2}+\sum_{i=1}^{n} c_{i}^{2}\binom{N_{i}}{2}+\sum_{1 \leq l<k \leq n} c_{l} c_{k} N_{l} N_{k}
\end{aligned}
$$

Thus we have

w_{2}(\pi)=\binom{\sum_{i=1}^{n} c_{i} N_{i}}{2}\left(\sum_{l=1}^{n} v_{l}^{2}\right)+\left(\sum_{i=1}^{n} c_{i} N_{i}^{\prime \prime}\right)\left(\sum_{1 \leq l<k \leq n} v_{l} v_{k}\right) \tag{19}
\end{equation*}
$$

Put $N=\left[N_{0}^{\prime \prime}, N_{1}^{\prime \prime}, N_{2}^{\prime \prime}, \ldots, N_{n}^{\prime \prime}\right]$. So we have $N m=\sum_{j=1}^{n} c_{i} N_{i}^{\prime \prime}$. We calculate $N M$.
Proposition 6. We have $\sum_{i} c_{i} N_{i}^{\prime \prime}=N m=\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{2}\right)}{4}$.

Proof. The proof is similar to Proposition 5 .
Theorem 10. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 3(\bmod 4)$. Then

w_{2}(\pi)=\binom{m_{\pi}}{2} \sum_{i} v_{i}^{2}
$$

Proof. Observe that $\sum_{i=1}^{n} c_{i} N_{i}=\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)}{2}=m_{\pi}$ by equation (16) and Proposition 5. From Equation (19) and Proposition (6) we have

w_{2}(\pi)=\binom{m_{\pi}}{2} \sum_{l} v_{l}^{2}+\frac{\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{2}\right)}{4} \cdot \sum_{1 \leq l<k \leq n} v_{l} v_{k}
$$

Now from GJ22 [Lemma 4.4] it follows that the coefficient of $\sum_{1 \leq l<k \leq n} v_{l} v_{k}$ is even. Hence we get the result.
6.2. Calculations of SWC Using Detection Results. Let $i_{k}: \mathrm{GL}_{k}\left(\mathbb{F}_{q}\right) \hookrightarrow$ $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $k<n$, denote the injection of $\mathrm{GL}_{k}\left(\mathbb{F}_{q}\right)$ inside $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ at the top left corner with rest diagonal entries 1 . When $q \equiv 1(\bmod 4)$ we have $i_{1}^{*}\left(a_{2}\right)=t_{1}$ and when $q \equiv 3(\bmod 4)$ we have $i_{2}^{*}\left(\sum_{i=1}^{n} v_{i}^{2}\right)=v_{1}^{2}+v_{2}^{2}$.

For a real representation $\pi$ of $\mathrm{GL}_{1}\left(\mathbb{F}_{q}\right)$, Theorem 1 gives

w(\pi)= \begin{cases}\left(1+\delta s_{1}\right)\left(1+t_{1}\right)^{c_{1} / 2}, & \text { if } q \equiv 1 \quad(\bmod 4) \\ \left(1+v_{1}\right)^{c_{1}}, & \text { if } q \equiv 3 \quad(\bmod 4)\end{cases}
$$

For a real representation $\pi$ of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$, Theorem 1 says
$w(\pi)=\left\{\begin{array}{lll}\left(1+\delta\left(s_{1}+s_{2}\right)\right)\left(\left(1+t_{1}\right)\left(1+t_{2}\right)\right)^{c_{1}^{\prime} / 2}\left(1+t_{1}+t_{2}\right)^{c_{2}^{\prime} / 2}, & \text { if } q \equiv 1 \quad(\bmod 4), \\ \left(1+v_{1}\right)^{c_{1}^{\prime}}\left(1+v_{2}\right)^{c_{1}^{\prime}}\left(1+v_{1}+v_{2}\right)^{c_{2}^{\prime}}, & \text { if } q \equiv 3 \quad(\bmod 4) .\end{array}\right.$
For the case of $\mathrm{GL}_{1}\left(\mathbb{F}_{q}\right)$ we have

\binom{c_{0}}{c_{1}}=(1 / 2)\left(\begin{array}{cc}
1 & 1 \\
1 & -1
\end{array}\right) \cdot\binom{\chi_{\pi}\left(h_{0}\right)}{\chi_{\pi}\left(h_{1}\right)}
$$

while for the case of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$ we have

$$
\left(\begin{array}{l}
c_{0}^{\prime} \\
c_{1}^{\prime} \\
c_{2}^{\prime}
\end{array}\right)=(1 / 4)\left(\begin{array}{ccc}
1 & 2 & 1 \\
1 & 0 & -1 \\
1 & -2 & 1
\end{array}\right) \cdot\left(\begin{array}{l}
\chi_{\pi}\left(h_{0}\right) \\
\chi_{\pi}\left(h_{1}\right) \\
\chi_{\pi}\left(h_{2}\right)
\end{array}\right) .
$$

For $q \equiv 3(\bmod 4)$ we compute $w_{1}(\pi)$ in terms of character values.
Theorem 11. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 3(\bmod 4)$. Then we have

w_{1}(\pi)=m_{\pi}\left(\sum_{i=1}^{n} v_{i}\right)
$$

Proof. Since $i=1$ in Theorem [8, we have $n=2$. We calculate for $\mathrm{GL}_{1}\left(\mathbb{F}_{q}\right)$. So for the representation $\pi$ we have

$$
w_{1}(\pi)=c_{1} v_{1} .
$$

Since $c_{1}=m_{\pi}$, we have the result.

Next we compute the second SWC.

Theorem 12. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd. Then we have

$$
w_{2}(\pi)=\left\{\begin{array}{lll}
\frac{m_{\pi}}{2} a_{2}, & \text { if } q \equiv 1 & (\bmod 4) \\
\binom{m_{\pi}}{2}\left(\sum_{i=1}^{n} v_{i}^{2}\right), & \text { if } q \equiv 3 & (\bmod 4)
\end{array}\right.
$$

Proof. For a real representation $\pi$ of $\mathrm{GL}_{1}\left(\mathbb{F}_{q}\right)$, where $q \equiv 1(\bmod 4)$, we have

$$
w_{2}(\pi)=\frac{c_{1}}{2} t_{1}
$$

We have $c_{1}=(1 / 2)\left(\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)\right)=m_{\pi}$. Thus by Theorem 3 we have

$$
w_{2}(\pi)=\frac{m_{\pi}}{2} a_{2}
$$

For a real representation $\pi$ of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$ and $q \equiv 3(\bmod 4)$ we have

$$
w_{2}(\pi)=\binom{c_{1}^{\prime}+c_{2}^{\prime}}{2}\left(v_{1}^{2}+v_{2}^{2}\right)+c_{1}^{\prime 2} v_{1} v_{2} .
$$

We know from [GJ22, Lemma 4.4]) that $c_{1}^{\prime}$ is even. Moreover we have $c_{1}^{\prime}+c_{2}^{\prime}=$ $(1 / 2)\left(\chi_{\pi}\left(h_{0}\right)-\chi_{\pi}\left(h_{1}\right)\right)=m_{\pi}$. Hence the Theorem follows from Theorem 8 .

Using the detection result we compute the fourth SWC in terms of character values when $q \equiv 1(\bmod 4)$.

Theorem 13. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q \equiv 1(\bmod 4)$. Then

w_{4}(\pi)=\binom{m_{\pi} / 2}{2} \sum_{i=1}^{n} t_{i}^{2}+\frac{\operatorname{dim} \pi-\chi_{\pi}\left(h_{2}\right)}{8} \sum_{1 \leq i<j \leq n} t_{i} t_{j}
$$

Proof. From Theorem 3 we know that the map res : $H^{4}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)\right) \rightarrow H^{4}\left(\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)\right)$ is injective. We have

$$
w^{\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)}(\pi)=\left(1+\delta\left(s_{1}+s_{2}\right)\right)\left(\left(1+t_{1}\right)\left(1+t_{2}\right)\right)^{c_{1}^{\prime} / 2}\left(1+t_{1}+t_{2}\right)^{c_{2}^{\prime} / 2} .
$$

Then we calculate

$$
\begin{aligned}
\operatorname{res}\left(w_{4}(\pi)\right) & =\left(\binom{c_{1}^{\prime} / 2}{2}+\binom{c_{2}^{\prime} / 2}{2}+\frac{c_{1}^{\prime} c_{2}^{\prime}}{4}\right)\left(t_{1}^{2}+t_{2}^{2}\right)+\frac{c_{1}^{\prime}}{2} t_{1} t_{2} \\
& =\binom{\frac{c_{1}^{\prime}}{2}+\frac{c_{2}^{\prime}}{2}}{2}\left(t_{1}^{2}+t_{2}^{2}\right)+\frac{c_{1}^{\prime}}{2} t_{1} t_{2} \\
& =\binom{m_{\pi} / 2}{2}\left(t_{1}^{2}+t_{2}^{2}\right)+\frac{\operatorname{dim} \pi-\chi_{\pi}\left(h_{2}\right)}{8} t_{1} t_{2} .
\end{aligned}
$$

So we have

## 7. Some Applications

7.1. Lifting Criteria for Real Representations of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. A real representation $\pi$ of a finite group $G$ is called spinorial provided it lifts to the Pin group, which is a double cover of the orthogonal group. One knows that $\pi$ is spinorial iff $w_{2}(\pi)+w_{1}^{2}(\pi)=0$ (see [GKT89, page 328]).

The main result in [JS21, Theorem 1] provides a criterion for spinoriality of a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ in terms of character values except for some particular pairs $(n, q)$. We recover the result here for $q$ odd.
Theorem 14. Let $\pi$ be a real representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd. Then
(1) for $q \equiv 1(\bmod 4)$, we have $\pi$ is spinorial iff $m_{\pi} \equiv 0(\bmod 4)$,
(2) for $q \equiv 3(\bmod 4)$, we have $\pi$ is spinorial iff $m_{\pi} \equiv 0$ or $3(\bmod 4)$.

Proof. We know that $\pi$ is spinorial iff $w_{2}(\pi)+w_{1}^{2}(\pi)=0$. From Theorems 3 and 8 we deduce that $\pi$ is spinorial iff $\operatorname{res}\left(w_{2}(\pi)+w_{1}^{2}(\pi)\right)=0$, where res : $H^{*}\left(\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right), \mathbb{Z} / 2 \mathbb{Z}\right) \rightarrow H^{*}\left(\mathrm{GL}_{k}\left(\mathbb{F}_{q}\right), \mathbb{Z} / 2 \mathbb{Z}\right)$ denotes the restriction map, where $k=1$ for $q \equiv 1(\bmod 4)$ and $k=2$ for $q \equiv 3(\bmod 4)$.

From Theorems 11 and 12, it follows that for a real representation $\pi$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$, we have

$$
\operatorname{res}\left(w_{2}(\pi)+w_{1}^{2}(\pi)\right)=\left\{\begin{array}{lll}
\frac{m_{\pi}}{2} t_{1}, & \text { if } q \equiv 1 & (\bmod 4) \\
\frac{m_{\pi}\left(m_{\pi}+1\right)}{2}\left(v_{1}^{2}+v_{2}^{2}\right), & \text { if } q \equiv 3 & (\bmod 4)
\end{array}\right.
$$

7.2. Non-Detection by An-isotropic Torus. Let $a \in \mathbb{F}_{q^{n}}^{\times}$and $G=\operatorname{GL}_{n}\left(\mathbb{F}_{q}\right)$, where $q$ is odd. We fix a basis of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$. Then the map $x \rightarrow a \cdot x$ gives a linear map $M_{a} \in G$. Then $M=\left\{M_{a}, a \in \mathbb{F}_{q^{n}}^{\times}\right\}$is a cyclic group of order $q^{n}-1$ and is called an anisotropic torus.
Theorem 15. The anisotropic torus $M$ does not detect the mod-2 cohomology of $G$.

Proof. Consider the representation $\pi=(\chi)_{\mathbb{R}}$, where $\chi=\chi^{j} \circ$ det and $j$ is odd. One has

$$
\begin{aligned}
\chi_{\pi}\left(h_{1}\right) & =2 \chi_{j}\left(\operatorname{det}\left(h_{1}\right)\right) \\
& =2 \chi_{j}(-1) \\
& =2(-1)^{j} .
\end{aligned}
$$

Since $j$ is odd we have $\chi_{\pi}\left(h_{1}\right)=-2$. This gives

$$
m_{\pi}=\frac{1}{2}(2+2)=2 .
$$

Then from Theorem 12 one obtains $w_{2}(\pi) \neq 0$.
Let $\hat{g}$ be a generator of $M$. Now we have

$$
w_{2}\left(\left.\pi\right|_{M}\right)=\kappa\left(c_{1}\left(\left.\chi^{j} \circ \operatorname{det}\right|_{M}\right)\right)
$$

We have

$$
\chi(\hat{g})=\chi^{j} \circ \operatorname{det}(\hat{g})=\zeta_{q-1}^{j}=\zeta_{q^{2}-1}^{(q+1) j}
$$

Take $u=c_{1}(\dot{\chi}) \in H^{2}(M, \mathbb{Z})$ where $\dot{\chi} \in \operatorname{Hom}\left(M, \mathbb{C}^{\times}\right)$such that $\dot{\chi}(\hat{g})=\zeta_{q^{2}-1}$. As a result we get

$$
\begin{aligned}
\kappa\left(c_{1}\left(\left.\chi^{j} \circ \operatorname{det}\right|_{M}\right)\right) & =\kappa((q+1) j u) \\
& =(q+1) j \kappa(u) \\
& =0 .
\end{aligned}
$$

This shows that $w_{2}\left(\left.\pi\right|_{M}\right)=\operatorname{res}_{M}^{G}\left(w_{2}(\pi)\right)=0$ whereas $w_{2}(\pi) \neq 0$.

## 8. The Case of $\mathrm{GL}_{n}(\mathbb{C})$ and $\mathrm{GL}_{n}(\mathbb{R})$

For a Lie group $G$ we write $H^{i}(G)$ to denote the (singular) cohomology $H^{i}(B G)$ of a classifying space $B G$ of $G$. Consider the subgroup

$$
\Gamma=\operatorname{diag}( \pm 1, \pm 1, \ldots, \pm 1) \cong C_{2}^{n}
$$

of $\mathrm{GL}_{n}(k)$, where $k=\mathbb{R}$ or $\mathbb{C}$. Take $T=\left(S^{1}\right)^{n}$ to be the diagonal torus of the unitary group $U_{n}$. Now we establish some useful detection results.

Proposition 7. The mod 2 cohomology of $\mathrm{GL}_{n}(\mathbb{C})$ is detected by the group $\Gamma$.
Proof. From [ $\mathrm{T}^{+87}$, Theorem 2.1] we obtain that the maps $i_{1}^{*}: H^{*}\left(\mathrm{GL}_{n}(\mathbb{C})\right) \rightarrow$ $H^{*}\left(U_{n}\right)$ and $i_{2}^{*}: H^{*}\left(U_{n}\right) \rightarrow H^{*}(T)$ are injective. As a result we conclude that the $\bmod 2$ cohomology of $\mathrm{GL}_{n}(\mathbb{C})$ is detected by the diagonal torus $T$. First we prove that the mod 2 cohomology of $S^{1}$ is detected by $C_{2}$. Note that the circle group $S^{1}$ is isomorphic to $\mathrm{SO}_{2}(\mathbb{R})$. We know that $H^{*}\left(\mathrm{SO}_{2}(\mathbb{R})\right)=\mathbb{Z} / 2 \mathbb{Z}\left[w_{2}\right]$, where $w_{2}$ denotes the second Stiefel Whitney class of standard representation of $\mathrm{SO}_{2}(\mathbb{R})$. The standard representation of $\mathrm{SO}_{2}(\mathbb{R})$ can be thought of as the representation $\pi=\rho \oplus \rho^{\vee}$ of $S^{1}$ where $\rho(z)=z$ for $z \in S^{1}$. So $w_{2}=w_{2}(\pi)$. One can consider $C_{2}=\{ \pm 1\}$ as a subgroup of $S^{1}$ to obtain a map res : $H^{*}\left(\mathrm{SO}_{2}(\mathbb{R})\right) \rightarrow H^{*}\left(C_{2}, \mathbb{Z} / 2 \mathbb{Z}\right)$. We have $H^{*}\left(C_{2}, \mathbb{Z} / 2 \mathbb{Z}\right)=\mathbb{Z} / 2 \mathbb{Z}[v]$, where $\operatorname{deg} v=1$. Note that $\left.\pi\right|_{C_{2}}=\operatorname{sgn} \oplus \operatorname{sgn}$. Thus we have

$$
\operatorname{res} w_{2}(\pi)=w_{2}(\operatorname{sgn} \oplus \operatorname{sgn})=w_{1}^{2}(\operatorname{sgn}) \neq 0
$$

So res $\left(w_{2}\right)=v^{2}$. This implies that the map 'res' is injective. Now the result follows from Kunneth formula.

Proposition 8. The mod 2 cohomology of $G L_{n}(\mathbb{R})$ is detected by $\Gamma$.
Proof. From [Mit01, Theorem 7.7] we know that $B \mathrm{GL}_{n}(\mathbb{R})$ is homotopy equivalent to $B O_{n}(\mathbb{R})$. Thus the restriction map $\operatorname{res}_{O}: H^{*}\left(\mathrm{GL}_{n}(\mathbb{R})\right) \rightarrow H^{*}\left(O_{n}(\mathbb{R})\right)$ is an isomorphism. From $\mathrm{T}^{+} 87$, Theorem 2.2] we obtain that $\operatorname{res}_{\Gamma}: H^{*}\left(O_{n}(\mathbb{R})\right) \rightarrow$ $H^{*}(\Gamma)$ is an injection. Thus the $\mathbb{Z} / 2 \mathbb{Z}$ cohomology of $\mathrm{GL}_{n}(\mathbb{R})$ is detected by the subgroup $\Gamma \cong C_{2}^{n}$.
Proof of Theorem 圆, Given a real representation $\pi$ of $\mathrm{GL}_{n}(\mathbb{R})$ ( or $\mathrm{GL}_{n}(\mathbb{C})$ ), we calculate the total Stiefel Whitney class of $\psi=\left.\pi\right|_{\Gamma}$. Moreover $\psi$ is a $S_{n}$ invariant representation as it is a restriction of representation of $\mathrm{GL}_{n}(\mathbb{R})\left(\right.$ or $\left.\mathrm{GL}_{n}(\mathbb{C})\right)$. Now the Theorem 2 follows from Theorem 7 .

Remark 3. Let $\pi$ be a representation of $\mathrm{O}_{n}(\mathbb{R})$. Then the proof of Proposition 8 gives that the total SWC of $\pi$ is same as the expression in Equation (2).

## 9. Examples

We have

$$
w_{2}(\pi)= \begin{cases}\frac{m_{\pi}}{2} a_{2}, & \text { if } q \equiv 1 \bmod 4, \\ \binom{m_{\pi}}{2}\left(\sum v_{i}^{2}\right), & \text { if } q \equiv 3 \bmod 4\end{cases}
$$

where $m_{\pi}=(1 / 2)\left(\operatorname{dim} \pi-\chi_{\pi}\left(h_{1}\right)\right)$. Also

$$
w_{4}(\pi)=\binom{m_{\pi} / 2}{2} \sum_{i} t_{i}^{2}+\frac{n_{\pi}}{4} \sum_{i<j} t_{i} t_{j},
$$

where $n_{\pi}=\frac{\operatorname{dim} \pi-\chi_{\pi}\left(h_{2}\right)}{2}$.
9.1. Principal Series Representation. Let $\chi_{1}, \chi_{2}, \ldots, \chi_{n}$ are linear characters of $\mathbb{F}_{q}^{\times}$and let $B$ be the Borel subgroup of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. Put

$$
\pi=\operatorname{Ind}_{B}^{G}\left(\chi_{1} \boxtimes \chi_{2} \boxtimes \cdots \boxtimes \chi_{n}\right)
$$

Such representations are called principal series representations of $G$. Such a representation $\pi$ is orthogonal iff

$$
\left\{\chi_{1}, \ldots, \chi_{n}\right\}=\left\{\chi_{1}^{-1}, \ldots, \chi_{n}^{-1}\right\}
$$

as multisets. We introduce the notation

$$
\begin{aligned}
{[n]_{q}!} & =\prod_{i=1}^{n} \frac{q^{i}-1}{q-1} \\
& =(q+1)\left(q^{2}+q+1\right) \cdots\left(q^{n-1}+q^{n-2}+\cdots+q+1\right)
\end{aligned}
$$

From Car85, Proposition 7.5.3, page no. 233] we obtain the following result.

$$
\begin{equation*}
\chi_{\pi}\left(h_{k}\right)=[k]_{q}![n-k]_{q}!\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n} \chi_{i_{1}}(-1) \chi_{i_{2}}(-1) \cdots \chi_{i_{k}}(-1) . \tag{20}
\end{equation*}
$$

Put

$$
T_{i}=\left(1+q+q^{2}+\cdots+q^{i}\right) .
$$

So we calculate

$$
\begin{aligned}
m_{\pi} & =\frac{1}{2}\left(\operatorname{dim} \pi-\chi_{\pi}\left(h_{1}\right)\right) \\
& =\frac{1}{2}\left([n]_{q}!-[n-1]_{q}!\left(\sum_{i=1}^{n} \chi_{i}(-1)\right)\right) \\
& =\frac{1}{2}[n-1]_{q}!\left(T_{n-1}-\sum_{i=1}^{n} \chi_{i}(-1)\right) .
\end{aligned}
$$

Similarly one has

$$
\begin{aligned}
n_{\pi} & =\frac{1}{2}\left(\operatorname{dim} \pi-\chi_{\pi}\left(h_{2}\right)\right) \\
& =\frac{1}{2}[n-2]_{q}!\left(T_{n-2} T_{n-1}-(1+q) \sum_{i<j} \chi_{i}(-1) \chi_{j}(-1)\right) .
\end{aligned}
$$

Theorem 16. Let $\pi$ be a real principal series representation for $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ where $q$ is odd. Then $w_{2}(\pi)=0$ for $n \geq 3$.

Proof. From JS21, Thorem 5] we know that if $n \geq 3$, then all the real principal series representations of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ are spinorial. Now $\pi$ is spinorial iff $w_{2}(\pi)=$ $w_{1}^{2}(\pi)$ (see GS20, Proposition 6.1]). If $q \equiv 1(\bmod 4)$,then $w_{1}^{2}(\pi)=0$. Therefore $w_{2}(\pi)=0$.

Now consider the case for $q \equiv 3(\bmod 4)$. We have

$$
m_{\pi}=\frac{1}{2}[n-1]_{q}!\left(T_{n-1}-\sum_{i=1}^{n} \chi_{i}(-1)\right) .
$$

Also

$$
T_{n-1} \equiv \sum_{i=1}^{n} \chi_{i}(-1) \equiv n \quad(\bmod 2)
$$

TOTAL STIEFEL WHITNEY CLASSES FOR REAL REPRESENTATIONS OF GL ${ }_{n}$ OVER $\mathbb{F}_{q}, \mathbb{R}$ AND $\mathbb{C} 9$
This gives $T_{n-1}-\sum_{i=1}^{n} \chi_{i}(-1) \equiv 0(\bmod 2)$. We have $[m]_{q}!\equiv 0(\bmod 4)$ for $m \geq 2$.
For $n \geq 3$, we have $v_{2}\left(m_{\pi}\right) \geq 2$. Therefore $\binom{m_{\pi}}{2} \equiv 0(\bmod 2)$. Therefore $w_{2}(\pi)=0$ for $n \geq 3$.

Proof of Theorem 4. We have

$$
n_{\pi}=\frac{1}{2}[n-2]_{q}!\left(T_{n-2} T_{n-1}-(1+q) \sum_{i<j} \chi_{i}(-1) \chi_{j}(-1)\right)
$$

Observe that $T_{n-2} T_{n-1}-(1+q) \sum_{i<j} \chi_{i}(-1) \chi_{j}(-1)$ is always even. Also $v_{2}([n-$ $\left.2]_{q}!\right) \geq 3$ for $n \geq 6$. Therefore $n_{\pi} / 4$ remains even for $n \geq 6$.

We have

$$
m_{\pi}=\frac{1}{2}[n-1]_{q}!\left(T_{n-1}-\sum_{i=1}^{n} \chi_{i}(-1)\right) .
$$

Also

$$
T_{n-1} \equiv \sum_{i=1}^{n} \chi_{i}(-1) \equiv n \quad(\bmod 2)
$$

This gives $T_{n-1}-\sum_{i=1}^{n} \chi_{i}(-1) \equiv 0(\bmod 2)$. For $n \geq 6$, the term $m_{\pi} / 2$ remains even. So we have $\binom{m_{\pi} / 2}{2} \equiv \frac{m_{\pi}}{4}(\bmod 2)$. Now $v_{2}\left(m_{\pi}\right) \geq 4$ for $n \geq 6$. Therefore $w_{4}(\pi)=0$ for $n \geq 6$.

For $n=5$ the two possible real Principal series representations are $\pi_{1}=\left\{\mathbb{1}, \chi_{i}, \chi_{i}^{-1}, \chi_{j}, \chi_{j}^{-1}\right\}$ and $\pi_{2}=\left\{\operatorname{sgn}, \chi_{i}, \chi_{i}^{-1}, \chi_{j}, \chi_{j}^{-1}\right\}$.

We calculate

$$
\begin{aligned}
m_{\pi_{1}} & =\frac{1}{2}\left([5]_{q}!-[4]_{q}!\left(1+2(-1)^{i}+2(-1)^{j}\right)\right) \\
& =\frac{1}{2}(q+1)^{2}\left(q^{2}+1\right)\left(q^{2}+q+1\right)\left(q(q+1)\left(q^{2}+1\right)-2(-1)^{i}-2(-1)^{j}\right)
\end{aligned}
$$

This shows $v_{2}\left(m_{\pi_{1}}\right) \geq 4$. Similarly one obtains $v_{2}\left(m_{\pi_{2}}\right) \geq 4$.
We have

$$
\begin{aligned}
n_{\pi_{1}} & =\frac{1}{2}\left([5]_{q}!-[2]_{q}![3]_{q}!\left(2+2(-1)^{i}+2(-1)^{j}+4(-1)^{i+j}\right)\right) \\
& =\frac{1}{2}(q+1)^{2}\left(q^{2}+q+1\right)\left(\left(q^{2}+1\right)\left(q^{4}+q^{3}+q^{2}+q+1\right)-\left(2+2(-1)^{i}+2(-1)^{j}+4(-1)^{i+j}\right)\right) \\
& \left.=\frac{1}{2}(q+1)^{2}\left(q^{2}+q+1\right)\left(\left\{q^{6}+q^{5}+2\left(q^{4}+q^{3}+q^{2}\right)\right\}+\{q-1\}-\left\{2(-1)^{i}+2(-1)^{j}\right)+4(-1)^{i+j}\right\}\right) .
\end{aligned}
$$

Note that the all the terms in the curly brackets and $(q+1)^{2}$ are divisible by 4 . Therefore $v_{2}\left(n_{\pi_{1}}\right) \geq 3$. Similar calculation shows that $v_{2}\left(n_{\pi_{2}}\right) \geq 3$. Now the result follows from Theorem 13 .

Here we list down the value of $w_{4}(\pi)$, where $\pi$ is an orthogonal principal series representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ for $q \equiv 1(\bmod 4)$.
(1) Take $n=3$ and $\pi=\left\{\mathbb{1}, \chi_{j}, \chi_{j}^{-1}\right\}$ or $\left\{\operatorname{sgn}, \chi_{j}, \chi_{j}^{-1}\right\}$ Then

$$
w_{4}(\pi)=\sum_{i=1}^{3} t_{i}^{2}+\sum_{1 \leq i<j \leq 3} t_{i} t_{j}
$$

if $q \equiv 1,9(\bmod 16)$ and $j$ is odd or $q \equiv 5,13(\bmod 16)$ and $j$ is even. Otherwise $w_{4}(\pi)=0$.
(2) Take $n=4$ and $\pi=\left\{\mathbb{1}\right.$, sgn, $\left.\chi_{i}, \chi_{i}^{-1}\right\}$. Then

$$
w_{4}(\pi)= \begin{cases}\sum_{i=1}^{4} t_{i}^{2}, & \text { if } i \text { is odd } \\ 0, & \text { if } i \text { is even }\end{cases}
$$

(3) Take $n=4$ and $\pi=\left\{\chi_{j}, \chi_{j}^{-1}, \chi_{k}, \chi_{k}^{-1}\right\}$.

$$
w_{4}(\pi)= \begin{cases}\sum_{i=1}^{4} t_{i}^{2}, & \text { if } j \text { and } k \text { have different parity } \\ 0, & \text { otherwise }\end{cases}
$$

9.2. Cuspidal Representations. Let $\theta$ be a regular character of full anisotropic torus $T$ of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$. Then there is a cuspidal representation $\pi_{\theta}$ associated to it. The representation $\pi_{\theta}$ is real iff there exists a Weyl group element $w$ such that $w(\theta)=\theta^{-1}$.

Let $\pi$ be a real Cuspidal representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$.
9.2.1. Computation of $w_{2}(\pi)$. We know that $\chi_{\pi}\left(h_{1}\right)=0$ and $\operatorname{dim} \pi=\psi_{n-1}(q)$ where

$$
\psi_{m}(q)=\prod_{i=1}^{m}\left(q^{i}-1\right)
$$

Thus $m_{\pi}=\psi_{n-1}(q) / 2$.
Theorem 17. Let $\pi$ be a real Cuspidal representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$ such that $n \geq 3$. Then $w_{2}(\pi)=0$.

Proof. For $n \geq 3$, the term $\frac{(q-1)\left(q^{2}-1\right)}{2}$ divides $m_{\pi}$, Thus $m_{\pi} \equiv 0 \bmod 4$, and therefore $w_{2}(\pi)=0$.

For $n=2$ and $q \equiv 1 \bmod 4$, we have $m_{\pi}=(q-1) / 2$ and $w_{2}=\frac{q-1}{4} a_{2}$.

$$
w_{2}(\pi)=\left\{\begin{array}{lll}
0, & \text { if } q \equiv 1 & \bmod 8 \\
a_{2}, & \text { if } q \equiv 5 & \bmod 8
\end{array}\right.
$$

For $n=2$ and $q \equiv 3 \bmod 4$, we have $m_{\pi}=(q-1) / 2$ and $w_{2}=\binom{m_{\pi}}{2} \cdot\left(v_{1}^{2}+v_{2}^{2}\right)$. Therefore

$$
w_{2}(\pi)= \begin{cases}0, & \text { if } q \equiv 3 \bmod 8 \\ v_{1}^{2}+v_{2}^{2}, & \text { if } q \equiv 7 \bmod 8\end{cases}
$$

9.2.2. Computation of $w_{4}(\pi)$. We summerize the computations in the following table.
9.3. Steinberg Representation. Let $\pi$ be the Steinberg representation of $\mathrm{GL}_{n}\left(\mathbb{F}_{q}\right)$.

9.3.1. Computation of $w_{2}(\pi)$. We have $\chi_{\pi}\left(h_{1}\right)=p^{k}$ where $p^{k}$ is the highest power of $p$ dividing $\left|Z_{G}\left(h_{1}\right)\right|$ (see Car85, Theorem 6.4.7, page 195]). We have $Z_{G}\left(h_{1}\right) \cong \mathrm{GL}_{1}\left(\mathbb{F}_{q}\right) \times \mathrm{GL}_{n-1}\left(\mathbb{F}_{q}\right)$. Thus $\chi_{\pi}\left(h_{1}\right)=q^{(1 / 2)(n-1)(n-2)}$. Therefore

$$
\begin{aligned}
m_{\pi} & =\frac{q^{(1 / 2)(n(n-1))}-q^{(1 / 2)(n-1)(n-2)}}{2} \\
& =(1 / 2) \cdot q^{(1 / 2)(n-1)(n-2)}\left(q^{n-1}-1\right) \\
& =\frac{q-1}{2} \cdot q^{(1 / 2)(n-1)(n-2)} \cdot\left(1+q+q^{2}+\cdots+q^{n-2}\right) .
\end{aligned}
$$

For $q \equiv 1(\bmod 4)$ we have

$$
w_{2}(\pi)= \begin{cases}a_{2}, & \text { if } q \equiv 5 \bmod 8 \text { and for } n \text { even } \\ 0, & \text { otherwise }\end{cases}
$$

For $q \equiv 3(\bmod 4)$ we have

$$
w_{2}(\pi)= \begin{cases}\sum_{i=1}^{n} v_{i}^{2}, & \text { if } q \equiv 3 \bmod 8 \text { and for } n \equiv 0 \quad(\bmod 4) \\ \sum_{i=1}^{n} v_{i}^{2}, & \text { if } q \equiv 7 \bmod 8 \text { and for } n \equiv 2 \quad(\bmod 4) \\ 0, & \text { otherwise }\end{cases}
$$

9.3.2. Computation of $w_{4}(\pi)$. We summerize the computations in the following table.
