# COGRAPHIC SPLITTING OF GRAPHIC MATROIDS WITH RESPECT TO A SET WITH THREE ELEMENTS

#### Abstract

In general, the splitting operation on binary matroids does not preserve the graphicness and cographicness properties of binary matroids. In this paper, we obtain a characterization of the class of graphic matroids whose splitting with respect to a set of three elements gives cographic matroids. We also provide an alternate proof to such characterization when the set contains two elements which was provided by Borse et al. 2].

## 1. Introduction

We refer to Oxley [10] for undefined terminology and notations. There are many operations in graph theory that are of great importance. The Splitting operation is one of them, which is introduced by Fleischner [3]. He has characterized Eulerian graphs using this operation. The Splitting operation is given as follows. Let $v$ be a vertex of a connected graph G such that $d(v) \geq 3$. If $x, y$ are two edges incident at $v$ such that $x=v v_{1}$ and $y=v v_{2}$. Let $G_{x, y}$ be obtained from $G$ by removing edges $x, y$ and by adding a vertex $v_{x, y}$ adjacent to $v_{1}$ and $v_{2}$. The splitting operation on the graph $G$ with respect to $x$ and $y$ is defined as the transition from $G$ to $G_{x, y}$.

The Splitting operation is further extended to binary matroids by Raghunathan et al. [6] and defined the splitting operation with respect to a pair of elements of a binary matroid. Later, it is generalized by Shikare at al. [8] by defining the splitting of a binary matroid with respect to any set $T$ as follows.

Definition 1.1. 8] Let $M$ be a binary matroid and let $A$ be the standard matrix representation of $M$ over the field $G F(2)$ and let $T \subseteq E(M)$. Obtain a matrix $A_{T}$ by adjoining one row at the bottom of the matrix $A$ with entries 1 in the columns corresponding to the elements of the set $T$ and zero otherwise. Then the vector matroid, denoted by $M_{T}$, is called
the splitting matroid of $M$ with respect to $T$, and the splitting operation with respect to $T$ is the transition from $M$ to $M_{T}$.

Some properties of a binary matroid are not preserved under the splitting operation. Connectedness, graphicness and cographicness are a few properties among the properties of binary matroids which are not preserves under the splitting operation. Shikare and Waphare [7] obtained characterization for a graphic matroid $M$ whose splitting matroid $M_{T}$ is also graphic for any $T$ with two elements. Mundhe [4] obtained a similar characterization for a set $T$ with three elements. Borse et al. [2] characterized the class of graphic matroids, which yields a cographic matroid under the splitting operation with respect to a pair of elements. In this paper, we characterize a graphic matroid that gives a cographic matroid under the splitting operation with respect to any set $T$ with $|T|=3$.

Let $\mathcal{M}_{k}$ be the class of graphic matroid whose splitting with respect to any set of $k$-elements is cographic. Let $N$ be an extension of $M\left(K_{5}\right)$ or $M\left(K_{3,3}\right)$ by an element $a$. Then the splitting of $N$ with respect to $a$ is not cographic. Therefore the single element extensions of $M\left(K_{5}\right)$ and $M\left(K_{3,3}\right)$ are the forbidden minors the class $\mathcal{M}_{1}$ and only these are the forbidden minors as per the definition of the splitting operation. Let $N$ be an extension of $M\left(K_{5}\right)$ by a set $T$ with $|T|=2$ such that $T$ be a 2 -cocircuit of $N$. Then $N \backslash T=M\left(K_{5}\right)$ and, by Definition 1.1, $N_{T} \backslash T=N \backslash T=M\left(K_{5}\right)$. Thus $N$ is a forbidden minor for the class $\mathcal{M}_{2}$. Similarly, it is easy to check that $\mathcal{N}_{2}$ contains a forbidden minor $N$ which arise as follows. (i) $N$ is an extension of $M\left(K_{5}\right)$ or $M\left(K_{3,3}\right)$ by two elements $x, y$ such that $x, y$ is a 2 -cocircuit of $N$ or (ii) $N$ is a coextension of $M\left(K_{5}\right)$ or $M\left(K_{3,3}\right)$ by an element $x$ such that $x, y$ is a 2-cocircuit of $N$ for some $y \in E(N)$.

If $N$ is a forbidden minor for the class $\mathcal{M}_{k}$ which is isomorphic to $M\left(K_{5}\right), M\left(K_{3,3}\right)$ or a matroid which arises by extensions and coextensions of $M\left(K_{5}\right)$ or $M\left(K_{3,3}\right)$, then we call $N$ is a trivial forbidden minor for the class $\mathcal{M}_{k}$. Let $\mathcal{T}_{k}$ be a set containing all trivial forbidden minors for the class $\mathcal{M}_{k}$. We focus on the forbidden minors of the class $\mathcal{M}_{k}$ other than the members of $\mathcal{T}_{k}$.

In the following result, Borse et al. [2] have given forbidden minors for the class $\mathcal{M}_{2}$.
Theorem 1.1. [2] Let $M$ be a graphic matroid without containing a minor isomorphic to any member of $\mathcal{T}_{2}$. Then $M \in \mathcal{M}_{2}$ if and only if $M$ does not contain a minor isomorphic to any one of the circuit matroids $M\left(G_{1}\right), M\left(G_{2}\right)$ and $M\left(G_{3}\right)$, where $G_{1}, G_{2}$ and $G_{3}$ are the graphs as shown in Figure 1.

Denote, by $\tilde{M}$, the single element extension of $M$. Later on, Mundhe 4] obtained forbidden minor for a class of graphic matroid which yields graphic matroid under the splitting operation with respect to a set of three elements as follows.


Figure 1. Forbidden Minors for the Class $\mathcal{M}_{2}$.
Theorem 1.2. [4] Let $M$ be a graphic matroid. Then $M_{T}$ is graphic for any $T \subseteq E(M)$ with $|T|=3$ if and only if $M$ does not contain a minor isomorphic to any of the circuit matroids $\tilde{M}\left(Q_{1}\right), \tilde{M}\left(Q_{2}\right), M\left(Q_{3}\right), M\left(Q_{4}\right), M\left(Q_{5}\right)$ and $M\left(Q_{6}\right)$, where $Q_{i}$ is the graph as shown in Figure 2, for $i=1,2, \ldots, 6$.


Figure 2. Forbidden Minors for the Class of Graphic Matroid which yields Graphic Matroid.

In this paper, we obtain excluded minors for the class $\mathcal{M}_{3}$. The following is the main result of the paper.

Theorem 1.3. Let $M$ be a graphic matroid without containing a minor isomorphic to any member of the set $\mathcal{T}_{3}$. Then $M \in \mathcal{M}_{3}$ if and only if $M$ does not contain a minor isomorphic to any of the matroid $\tilde{M}\left(G_{1}\right), \tilde{M}\left(G_{3}\right), M\left(G_{4}\right), M\left(G_{5}\right), M\left(G_{6}\right)$ and $M\left(G_{7}\right)$, where $G_{i}$ is the graph shown in Figure 1 or Figure 3, for $i=1,3,4,5,6,7$.

We prove the main result in Section 5. We also give an alternate and short proof to the characterization of the class $\mathcal{M}_{2}$ in the fourth section. Section 2 and Section 3 contain results that are useful to prove the paper's main result.

## 2. Minimal Matroid

In this section, we prove that if the splitting of a graphic matroid is not cographic, then it contains a special type of graphic matroid as a minor. Let $\mathcal{F}=\left\{F_{7}, F_{7}^{*}, M\left(K_{5}\right), M\left(K_{3,3}\right)\right\}$.

We use the following result from Oxley's book [10].
Theorem 2.1. 10] Let $M$ be a binary matroid. Then $M$ is a cographic matroid if and only if $M$ does not contain a minor isomorphic to any member of the set $\mathcal{F}$.

The following result is proved in [4].
Lemma 2.2. [4] Let $M$ be a binary matroid and $T \subseteq E(M)$. Then the following holds.
(i). If $x \in E(M)-T$, then $\left(M_{T}\right) \backslash x=(M \backslash x)_{T}$ and $\left(M_{T}\right) / x=(M / x)_{T}$.
(ii). If $y \in T$, then $\left(M_{T}\right) \backslash y=((M) \backslash y)_{T-y}$.
(iii). $M_{T} \backslash T=M \backslash T$.
(iv). $M_{T}=M$, if $T$ is a cocircuit of $M$.

In the following result, we prove that if the splitting matroid of a graphic matroid is not cographic, then it contains a minimal minor whose splitting is not cographic.

Lemma 2.3. Let $M$ be a graphic matroid and $k=2,3$. If $M_{T}$ contains a minor isomorphic to $F$ for some $F \in \mathcal{F}$ and $T \subseteq E(M)$ with $|T|=k$, then $M$ has a minor $N$ with $T \subseteq N$, such that one of the following holds.
(i). $N_{T} \cong F$.
(ii). $N_{T} / T^{\prime} \cong F$ for some non-empty subset $T^{\prime}$ of $T$.
(iii). $N$ is isomorphic to one element extension of forbidden minors for the class $\mathcal{M}_{k-1}$.
(iv). $N$ is isomorphic to some member of $\mathcal{T}_{k}$.

Proof. Let $M_{T}$ contains a minor isomorphic to $F$ for some $F \in \mathcal{F}$ and $T \subseteq E(M)$ with $|T|=k$, where $k=2,3$. Then there exist $T_{1}, T_{2} \subseteq E(M)$ such that $M_{T} \backslash T_{1} / T_{2} \cong F$. Now let $T_{i}^{\prime}=T \cap T_{i}$ and $T_{i}^{\prime \prime}=T_{i}-T_{i}^{\prime}$ for $i=1,2$. Then $T_{i}^{\prime} \subseteq T$ and $T_{i}^{\prime \prime} \cap T=\phi$. By Lemma 2.2(1), $M_{T} \backslash T_{1}^{\prime \prime} / T_{2}^{\prime \prime}=\left(M \backslash T_{1}^{\prime \prime} / T_{2}^{\prime \prime}\right)_{T}$. Let $N=M \backslash T_{1}^{\prime \prime} / T_{2}^{\prime \prime}$. Then $N$ is minor of $M$ containing $T$ and $N_{T} \backslash T_{1}^{\prime} / T_{2}^{\prime}=\left(M \backslash T_{1}^{\prime \prime} / T_{2}^{\prime \prime}\right)_{T} \backslash T_{1}^{\prime} / T_{2}^{\prime}=M_{T} \backslash T_{1}^{\prime \prime} / T_{2}^{\prime \prime} \backslash T_{1}^{\prime} / T_{2}^{\prime}=M_{T} \backslash T_{1} / T_{2} \cong F$.

If $T_{1}^{\prime}=\phi$ and $T_{2}^{\prime}=\phi$, then (i) or (iv) holds. If $T_{1}^{\prime}=\phi$ and $T_{2}^{\prime} \neq \phi$ then (ii) or (iv) holds. If $T_{1}^{\prime} \neq \phi$, then $\left|T_{1}^{\prime}\right| \leq k=|T|$. Suppose $\left|T_{1}^{\prime}\right|=k$. Then $T_{1}^{\prime}=T$ and $F \cong$ $N_{T} \backslash T_{1}^{\prime}=N_{T} \backslash T=N \backslash T$ this shows that $F$ is minor of graphic matroid $M$ which shows that (iv) holds. Let $\left|T_{1}^{\prime}\right|<k$ and $z \in T_{1}^{\prime}$. Suppose $N \backslash z=P$. Then, by Lemma 2.3 (ii), $N_{T} \backslash T_{1}^{\prime} / T_{2}^{\prime}=N_{T} \backslash z \backslash T_{1}^{\prime}-\{z\} \backslash T_{2}^{\prime}=P_{T-\{z\}} \backslash T_{1}^{\prime}-\{z\} / T_{2}^{\prime} \cong F$. Therefore $N$ is extension of $P$, which is a forbidden minor for the class $\mathcal{M}_{k-1}$. Which means (iii) hold.

We focus on finding forbidden minors for the class $\mathcal{M}_{k}$ other than the members of $\mathcal{T}_{k}$ for $k=2,3$. Henceforth, we consider the graphic matroids, which do not contain a minor isomorphic to any member of $\mathcal{T}_{k}$ for $k=2,3$.

Lemma 2.4. Let $N$ be the minor of the matroid $M$ stated in Lemma 2.3 and without containing a minor isomorphic to any member of $\mathfrak{T}_{k}$. Then $N$ does not contain 2-cocircuit.

Proof. The proof is similar to the proof of Lemma 3.3.2, in [4].
Lemma 2.5. Let $N$ be the minor of the matroid $M$ stated in Lemma 2.3, such that $N$ does not satisfy conditions (iii) and (iv). Then $N$ does not contain a coloop.

Proof. The proof is similar to the proof of Lemma 3.3.3, in [4].
We call the matroid $N$ of Lemmas 2.3, 2.4 and 2.5 as a $k$-minimal matroid with repsect to $F$ where $F \in \mathcal{F}$. We define a $k$-minimal matroid with respect $F \in \mathcal{F}$ as follows.

Definition 2.1. Let $k=2,3$ and $N$ be a graphic matroid without containing any member of $\mathfrak{T}_{k}$. Then $N$ is called $k$-minimal matroid with respect to some $F$ of $\mathcal{F}$ if the following conditions hold.
(i). $N$ contains no coloop and no 2-cocircuit.
(ii). $N$ is not a single element extension of any member of forbidden minors of $\mathcal{M}_{k-1}$.
(iii). There is a set $T \subseteq E(N)$ with $|T|=k$ such that $N_{T} \cong F$ or $N_{T} / T^{\prime} \cong F$ for some non-empty subset $T^{\prime}$ of $T$.

In light of Lemma 2.3 and Definition 2.1, we focus on to find the $k$-minimal matroids with respect to every member of $\mathcal{F}$, for $k=2,3$. Let $M$ be a matroid. Then matroid $Q$ is called a quotient of $M$ if there exist a matroid $N$ such that $Q=N / a$ and $N \backslash a=M$ for some $a \in N$. Here $M$ is called a lift of $Q$. We prove that a $k$-minimal matroid with respect to $F$ contains a minor isomorphic to a quotient of $F$ in the following lemma.

Lemma 2.6. Let $k=2,3$ and let $M$ be a $k$-minimal matroid with respect to $F \in \mathcal{F}$. Then there is a binary matroid $N$ containing an element $a$ such that $N \backslash a \cong F$. Further, $N / a$ is a minor of $M$ such that either $M=N / a$ or $M$ is a coextension of $N / a$ by at most $k$ elements.

Proof. Since $M$ is a $k$-minimal matroid, $M$ is graphic and $M_{T} \cong F$ or $M_{T} / T^{\prime} \cong F$ for some $T \subseteq E(M)$ and $T^{\prime} \subseteq T$ with $|T|=k$. Let $A$ be the standard matrix representation of $M$ over the field $G F(2)$. Let $A_{T}^{\prime}$ be the matrix obtained from $A$ by adding one extra row to the matrix $A$ at the bottom whose entries are 1 in the columns corresponding to the elements of $T$ and zero otherwise and then adding one extra column labeled $a$ with entry 1 in the last row and 0 elsewhere. Let $M_{T}^{\prime}$ be the vector matroid of $A_{T}^{\prime}$. Here $E\left(M_{T}^{\prime}\right)=E(M) \cup\{a\}$. Therefore (i). $M_{T}=M_{T}^{\prime} \backslash a$ and (ii). $M_{T}^{\prime} / a \cong M$.

Suppose $M_{T} \cong F$. Let $N=M_{T}^{\prime}$. Then $N$ is a binary matroid containing $a$, such that $M_{T}^{\prime} / a \cong N / a \cong M$ and $M_{T}^{\prime} \backslash a \cong M_{T} \cong F \cong N \backslash a$.


Suppose $M_{T} / T^{\prime} \cong F$ for some $T^{\prime} \subset T$. Let $N=M_{T}^{\prime} / T^{\prime}$. Then $N \backslash a \cong M_{T}^{\prime} / T^{\prime} \backslash a \cong$ $M_{T}^{\prime} \backslash a / T^{\prime} \cong M_{T} / T^{\prime} \cong F$ and $N / a \cong M_{T}^{\prime} / T^{\prime} / a \cong M_{T}^{\prime} / a / T^{\prime} \cong M / T^{\prime}$. Here $M$ is a coextension of $N / a$ by at most $k$ elements as $\left|T^{\prime}\right| \leq|T|=k$.

In the above result, $N / a$ is a quotient of $F$, and $M$ is isomorphic to a quotient of $F$ or a coextension of a quotient of $F$. Note that $N$ is binary, and we obtain quotients through binary matroid coextension/extension. Since $M$ is graphic, in the next section, we determine graphic quotients of $F \in \mathcal{F}$.

## 3. Graphic Quotients of Non-Cographic Matroids

In this section, we obtain graphic quotients of every member of the set $\mathcal{F}$. First, we prove the following lemma.

Lemma 3.1. Let $N$ be a binary matroid containing an element $a$ such that $N \backslash a \cong F$ for some $F \in \mathcal{F}$ and $N / a \cong M(G)$ for some connected graph $G$. Then the following holds.
(i). The graph $G$ is a block, or it has at most two blocks, one of which is a loop.
(ii). The graph $G$ contains at most one loop.
(iii). The graph $G$ does not contain more than two parallel edges with the same end vertices.
(iv). The graph $G$ does not contain a 2-edge cut.
(v). If $F$ is Eulerian, then G is also Eulerian.

Proof. The proof is similar to the proof of Lemma 3.4.1, in [4].
Mundhe [4], determined graphic quotients for $F_{7}^{*}$ and $F_{7}$ as follows.
Lemma 3.2. [4] Every graphic quotient of $F_{7}$ is isomorphic to the circuit matroid $M\left(H_{3}\right)$ and every graphic quotient of $F_{7}^{*}$ is isomorphic to the circuit matroid $M\left(H_{1}\right)$ or $M\left(H_{2}\right)$, where $H_{1}, H_{2}, H_{3}$ are shown in Figure 4.

We find all graphic quotients of $M\left(K_{5}\right)$ and $M\left(K_{3,3}\right)$.
Lemma 3.3. Every graphic quotient of $M\left(K_{5}\right)$ obtained via binary extension is isomorphic to the circuit matroid $M\left(H_{4}\right), M\left(H_{5}\right)$ or $M\left(H_{6}\right)$, where $H_{4}, H_{5}$ and $H_{6}$ are the graphs as shown in Figure 5.

Proof. Let $N$ be binary matroid containing $a$ such that $N \backslash a \cong M\left(K_{5}\right)$ and $N / a$ is graphic. Assume that $N / a=M(G)$ for a connected graph $G$. Suppose $a$ is a loop or a coloop of $N$. Then $N / a=N \backslash a \cong M\left(K_{5}\right)$. Thus $G \cong H_{4}$.

Suppose $a$ is not a loop or a coloop of $N$. Since the graph $K_{5}$ has 5 vertices and 10 edges, $r(N)=4$ and $|E(N)|=11$. Hence $r(N / a)=3$ and $|E(N / a)|=10$. Thus graph $G$ corresponding to $N / a$ has 4 vertices and 10 edges. By Lemma 3.1(v), $G$ is Eulerian as $K_{5}$ is Eulerian and by Lemma 3.1, $G$ contains at most one loop.
If $G$ does not contain a loop, then, by Harary (5, pg 230), there is only one Eulerian graph on 4 vertices and 10 edges as shown in Figure 6. It contains five distinct 2-cycles. That is, $N / a$ contains five 2 -circuits. One can easily check that $N \backslash a$ contains an odd cocircuit or a 2-circuit. Since $N \backslash a \cong M\left(K_{5}\right), M\left(K_{5}\right)$ contains an odd cocircuit or a 2-circuit, a contradiction to $M\left(K_{5}\right)$ is a Eulerian graph. Hence we discard this graph.

If $G$ contains a loop, then $G$ minus that loop is an Eulerian graph of 4 vertices and 9 edges. By Harary ( 5 , pg 230), there is only one Eulerian graph of 4 vertices and 9 edges. That graph is $H_{5}$ minus the loop as shown in Figure 5. Thus $G$ can be obtained by adding a loop to that graph. Hence $G$ is isomorphic to either the graph $H_{5}$ or $H_{6}$ as shown in Figure 5.

We need the following result to find graphic quotients of $M\left(K_{3,3}\right)$.

Lemma 3.4. Let $N$ be a binary matroid and $a \in E(N)$. If $N \backslash a \cong M\left(K_{3,3}\right)$, then no element of $N / a$ belongs to 2 -circuit and odd circuit.

Proof. Since $M\left(K_{3,3}\right)$ is a bipartite graph, it contain only circuits with even length. On contrary, let $x_{1}$ be an element of $N / a$ belongs to both 2 -circuit and odd circuit. Suppose $\left\{x_{1}, x\right\}$ is a 2 -circuit and $C_{1}=\left\{x_{1}, y_{1}, y_{2}, \cdots y_{k}\right\}$ is an odd circuit, where $k$ is an even integer. Then $C_{2}=\left\{x, y_{1}, y_{2}, \cdots y_{k}\right\}$ is also a circuit of $N / a$. Then $D_{1}=\left\{x_{1}, y_{1}, y_{2}, \cdots y_{k}, a\right\}$ and $D_{2}=\left\{x, y_{1}, y_{2}, \cdots y_{k}, a\right\}$ are circuits of $N$ otherwise $N \backslash a$ contains odd circuit, a contradiction to $N \backslash a$ is bipartite. Suppose $D_{1}$ and $D_{2}$ are circuits of $N$. Then $D_{1} \triangle D_{2}=\left\{x_{1}, x\right\}$ is a circuit in $N$ and also in $N \backslash a \cong M\left(K_{3,3}\right)$, a contradiction. Thus no element of $N / a$ lies in a 2 -circuit as well as in an odd circuit.

In this paper, we aim to find the forbidden minors for the class $\mathcal{M}_{3}$ and, we also intend to give an alternative proof for the forbidden minor characterization of the class $\mathcal{M}_{2}$. By Theorem 1.1, $M\left(G_{2}\right)$ is a forbidden minor for the class $\mathcal{M}_{2}$. Therefore, by Lemma 2.3, $\tilde{M}\left(G_{2}\right)$ is a forbidden minor for the class $\mathcal{M}_{3}$, where $\tilde{M}\left(G_{2}\right)$ is an extension of $G_{2}$ by single element. Thus it is sufficient, if we consider the graphic quotients $M\left(K_{3,3}\right)$ which avoids $\tilde{M}\left(G_{2}\right)$ as a minor.

We now find quotient for $M\left(K_{3,3}\right)$.
Lemma 3.5. Every graphic quotient of $M\left(K_{3,3}\right)$ obtained via binary extension and without containing a minor isomorphic to $\tilde{M}\left(G_{2}\right)$ is isomorphic to the circuit matroid of $H_{i}$ for some $i \in\{7,8,9,10,11\}$, where $H_{i}$ is the graph as shown in Figure 7, for $i=7,8,9,10,11$.

Proof. Let $N$ be a binary matroid and $a \in E(N)$ such that $N \backslash a \cong M\left(K_{3,3}\right)$ and $N / a$ is graphic. Suppose $N / a=M(G)$ for some connected graph $G$. Assume that $M(G)$ does not contain a $\tilde{M}\left(G_{2}\right)$ as a minor. If $a$ is a loop or coloop of $N$, then $N \backslash a=N / a=K_{3,3}$. Thus $G \cong H_{7}$.

Suppose $a$ is not a loop or a coloop. Since the graph $K_{3,3}$ has 6 vertices and 9 edges, $r(N)=5$ and $|E(N)|=10$. Thus $r(N / a)=4$ and $|E(N / a)|=9$. Hence $N / a$ corresponds to a graph $G$ on 5 vertices and 9 edges. By Lemma 3.1(1) and (4), $G$ contains at most two block one of which is a loop and $G$ does not contain 2-edge cut. Suppose $G$ is a simple
graph. As $G$ is 2-connected, by Harary ([5], Pg. 217), $H_{8}$ is only 2-connected simple graph as shown in Figure 7. Thus $G \cong H_{8}$.

Suppose $G$ is not a simple graph. Then $G$ contains a loop or 2-cycle. By Lemma 3.111], $G$ is 2 -connected, or $G$ can be obtained by adding one loop or parallel edges to 2 -connected or both. Thus there are the following cases. (i). $G$ contains either a loop or a 2-cycle. (ii). $G$ contains either a loop and a 2 -cycle or two 2 -cycles. (iii). $G$ contains a loop and two 2-cycles or three 2-cycle. (iv) $G$ contains a loop and three 2-cycles or four 2-cycles. (v) $G$ contains a loop and four 2-cycles or at least five 2 -cycles. We consider all these cases one by one.

Case (i). Suppose $G$ contains either one loop or one 2-cycle.
Then $G$ can be obtained by adding a loop or a parallel edge to a 2 -connected simple graph on 5 vertices and 8 edges. By Harary ([5, Pg 217), there are two non-isomorphic simple graphs $A_{i}$ and $A_{i i}$ on 5 vertices and 8 as shown in Figure 8.

$A_{i}$

Suppose $G$ is obtained from $A_{i}$ by adding a loop. Then $G$ contains a 2-edge cut, by Lemma 3.1 (4), which is a contradiction. Hence $G$ is obtained from $A_{i}$ by adding a 2 -cycle such that $G$ does not contain a 2-edge cut. Then $M(G) \cong M\left(\tilde{G}_{2}\right)$, a contradiction. Hence we discard $A_{i}$.

If $G$ is obtained from $A_{i i}$ by adding a loop, then $G \cong H_{9}$ or $G \cong H_{10}$ shown in Figure 7. Suppose $G$ is obtained from $A_{i i}$ by adding a edge parallel to some edge of $A_{i i}$. Then either $M(G) \cong \tilde{M}\left(G_{2}\right)$ or by Lemma 3.4, $N \backslash a$ contains a 3 -circuit or 2-circuit, which is a contradiction. Hence we discard it.

Case (ii). Suppose $G$ contains either a loop and a 2-cycle or two 2-cycles. $G$ can be obtained from a 2 -connected simple graph on 5 vertices and 7 edges by adding a loop and a parallel edge or 2 parallel edges. By Harary ([5], Pg 217), there are three non-isomorphic 2-connected simple graphs $A_{i i}, A_{i v}$, and $A_{v}$ on 5 vertices and 7 edges as shown in Figure 9 .

The graph $A_{v}$ contains three 2-edge cuts. Therefore, adding a loop and a parallel edge or two parallel edges to $A_{v}$ still contains a 2-edge cut. Hence we discard $A_{v}$. If $G$ is obtained from $A_{i i i}$ by adding a loop and a parallel edge, then $G$ contains a 2-edge cut. Suppose $G$

is obtained from $A_{i i i}$ by adding two parallel edges such that no 2-edge cut is there in $G$. Then we get a contradiction by Lemma 3.4. Thus $G$ can not be obtained from $A_{i i i}$. If $G$ is obtained from $A_{i v}$ by adding a loop and a parallel edge or two parallel edges such that $G$ does not contain 2-edge, then $M(G) \cong \tilde{M}\left(G_{2}\right)$. Thus $G$ can not be obtained from $A_{i v}$.

Case-(iii) If $G$ contains either a loop and two 2-cycles or three 2-cycles.
Then $G$ is obtained from a 2 -connected simple graph on 5 vertex and 6 edges. By Harary ( 5 ] $\operatorname{Pg} 217$ ), there are two non-isomorphic 2 -connected simple graphs on 5 vertices and 6 edges as shown in Figure 10.

If $G$ is obtained from $A_{v i}$ or $A_{v i i}$ by adding a loop and two parallel edges, then $G$ contains a 2-edge cut, which is a contradiction by Lemma 3.1. Suppose $G$ obtained from $A_{v i}$ by adding three parallel edges such that $G$ does not contain a 2-edge cut. Then $G \cong a_{i}$ or $G \cong a_{i i}$ where $a_{i}, a_{i i}$ are shown in Figure 11. By Lemma 3.4, we discard both the graphs $a_{i}$ and $a_{i i}$. Suppose $G$ is obtained from $A_{v i i}$ by adding three parallel edges such that $G$ does not contain

since due to cycles of $G, N \backslash a$ does not contain circuit with 6 elements, thus $N \backslash a \nsupseteq K_{3,3}$. Hence $G \nexists a_{i v}$.

Case-(iv) If $G$ contains either a loop and three pairs of parallel edges or four pairs of parallel edges.
Then $G$ is obtained from a 2-connected simple graph on 5 vertices and 5 edges by adding a loop and three parallel edges or four parallel edges. By Harary ([5], $\operatorname{Pg} 216$ ), a cycle on 5 vertices is the only a 2 -connected graph on 5 vertices and 5 edges. Thus $G$ is obtained by adding a loop and three parallel edges such that $G$ does not contain a 2 -edge cut, but there is no graph without a 2-edge cut. Suppose $G$ is obtained from a cycle on 5 vertices by adding four parallel edges such that it does not contain a 2-edge cut. Then $a_{i i i}$ is the only graph with this condition, where $a_{i i i}$ is a graph shown in Figure 11. By Lemma 3.4, $G \neq a_{i i i}$.

Case (v) If $G$ contains a loop and four pairs of parallel edges or five pairs of parallel edges.
Then $G$ is obtained from a 2-connected simple graph on 5 vertices and four edges. By Harary ([5], Pg 216 ), there is no 2-connected simple graph on 5 vertices and 4 edges.

Therefore $G$ is isomorphic to $H_{i}$, for some $i \in\{7,8,9,10,11\}$.

## 4. Forbidden Minors for the class $\mathcal{M}_{2}$

This section gives alternative proof for the forbidden minor characterization of the class $\mathcal{M}_{2}$ using the results obtained from the last two sections. Recall that $\mathcal{N}_{k}$ is the class of graphic matroid whose splitting with respect to any set of $k$-elements is cographic and $\mathcal{F}=\left\{F_{7}, F_{7}^{*}, M\left(K_{5}\right), M\left(K_{3,3}\right)\right\}$.

We need the following lemmas, which follow easily from the definition of the splitting operation.

Lemma 4.1. Let $M$ be a binary matroid such that it contains more than two 2-circuits. Then $M_{T}$ will contain at least one 2 -circuit for any $T \subseteq E(M)$ with $|T|=2$.

Lemma 4.2. If $M(G)$ is a graphic matroid and contains a loop, then $M(G)_{T}$ is graphic with $|T|=2$ or includes a loop.

Lemma 4.3. Let $\mathrm{M}(\mathrm{G})$ be a graphic matroid such that it contains two adjacent 2-circuits. Then $M(G)_{T}$ is graphic for some $T \subseteq E(M)$ with $|T|=2$ or $M_{T}$ contains a 2 -circuit.

Now, we give an alternate prove to Theorem 1.1. Here we restate the result along with the graphs.

Theorem 4.4. Let $M$ be a graphic matroid without containing a minor isomorphic to any member of $\mathcal{T}_{2}$. Then $M \in \mathcal{M}_{2}$ if and only if $M$ does not contain a minor isomorphic to any one of the circuit matroids $M\left(G_{1}\right), M\left(G_{2}\right)$ and $M\left(G_{3}\right)$, where $G_{1}, G_{2}$ and $G_{3}$ are the graphs as shown in Figure 12.

Proof. Let $M$ be a graphic matroid such that it contains a minor isomorphic to $M\left(G_{i}\right)$ for some $i \in\{1,2,3\}$. Then we can easily prove that $M_{T}$ is not cographic for some $T \subseteq E(M)$ and $|T|=2$.

Conversely, assume that $M$ avoids a minor isomorphic to $M\left(G_{i}\right)$ for every $i \in\{1,2,3\}$. Then we prove that $M \in \mathcal{M}_{2}$. On contrary, assume that $M \notin \mathcal{M}_{2}$. Then, by Lemma 2.1, $M$ contains a minor isomorphic to $F \in \mathcal{F}$. Note that $\mathcal{M}_{1}$ is empty and $M$ does not contain a minor isomorphic to any element of $\mathcal{T}_{2}$. Hence, by Lemma 2.3, $M$ has a minor $Q$ such that (i) $Q_{T} \cong F$, (ii) $Q_{T} / T^{\prime} \cong F$ for $T^{\prime} \subseteq T$. By Lemma 2.4 and Lemma 2.5, $Q$ is without 2 -cocircuit and a coloop. Therefore $Q$ is 2-minimal matroid with respect to $F \in \mathcal{F}$. Thus, by Lemma [2.6, there exist a binary matroid $N$ containing $a$ such that $N \backslash a \cong F$ and $Q=N / a$ or $Q$ is coextension of $N / a$ by one or two elements. Since $M$ is graphic, $Q$ is also graphic. Let $Q=M(G)$ for some connected graph $G$. Since, by Definition 1.1, $Q_{T}$ contains a 2-cocircuit as $|T|=2, Q_{T} \nexists F$. Therefore $Q_{T} / T^{\prime} \cong F$. Hence $Q$ is a coextension of $N / a$ by one or two elements.

Case (i). Suppose $F=F_{7}^{*}$. Then $N \backslash a \cong F_{7}^{*}$ and, by Lemma 3.2, $N / a \cong M\left(H_{1}\right)$ or $N / a \cong M\left(H_{2}\right)$, where $H_{1}$ and $H_{2}$ are the graphs shown in Figure 4. Therefore $G$ is a coextension of $H_{1}$ or $H_{2}$ by one or two elements. Suppose $G$ is a coextension of $H_{1}$ by an element. By Lemma 3.1 (4), $G$ can not contain a 2-edge cut. We take coextensions of $H_{1}$ such that it does not contain a 2-edge cut. There is only one non-isomorphic coextension $C_{1}$ of $H_{1}$ by an element as shown in Figure 13, Since $C_{1} \cong G_{2}, G$ can not arise from $H_{1}$.

Suppose $G$ arise from $H_{2}$. Then $G$ is a coextension of $H_{2}$ by one or two elements. There are two non-isomorphic coextensions of $H_{2}$ by an element as shown in Figure 14, such that it does not contain a 2 -edge cut.

Here $C_{3} \cong G_{2}$. Therefore $G \nsubseteq C_{3}$. By Lemma 4.1, the splitting of $M\left(C_{2}\right)$ with respect to any two elements contains a 2 -circuit. Thus $\left(C_{2}\right)_{T} \not \equiv F_{7}^{*}$ for any $T \in E\left(C_{2}\right)$ with $|T|=2$ as $F_{7}^{*}$ is a 3 -connected matroid. Thus $G \not \not C_{2}$. Also there is no coextension of $C_{2}$ by an element, which does not contain a 2 -edge cut. Hence, we discard $C_{2}$.

Case (ii). Suppose $F=F_{7}$. Then $N \backslash a \cong F_{7}$ and, by Lemma 3.2, $N / a \cong M\left(H_{3}\right)$, where $H_{3}$ is the graph as shown in Figure 4. Therefore $G$ is a coextension of $M\left(H_{3}\right)$ by one or two elements. Suppose $G$ is a coextension of $H_{3}$ by an element. There are five $C_{4}, C_{5}, C_{6}, C_{7}, C_{8}$ non-isomorphic coextensions of $M\left(H_{3}\right)$ by an element as shown in Figure 15. By Lemma 4.1, the splitting of the matroids $M\left(C_{4}\right), M\left(C_{7}\right)$ and $M\left(C_{8}\right)$ contains a 2-circuit after splitting with any two elements set. Also, there is no coextension of $C_{4}, C_{7}$ and $C_{8}$ by one element such that it does not contain a loop or 2-edge cut or a minor isomorphic to $M\left(G_{1}\right), M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. Hence we discard coextensions of $C_{4}, C_{7}$ and $C_{8}$. By Lemma 4.2, splitting of $M\left(C_{5}\right)$ with respect to any two elements is either graphic or contains a loop. Also coextension of $C_{5}$ by one element either contains a loop or a minor isomorphic to $M\left(G_{2}\right)$. Hence $G \nsubseteq C_{5}$. Here $M\left(C_{6}\right) \cong M\left(G_{1}\right)$. Hence $G \nsubseteq C_{6}$.

Case (iii). Suppose $F=M\left(K_{5}\right)$. Then $N \backslash a \cong M\left(K_{5}\right)$ and, by Lemma 3.3, $N / a \cong$ $M\left(H_{4}\right), N / a \cong M\left(H_{5}\right)$ or $N / a \cong M\left(H_{6}\right)$, where $H_{4}, H_{5}$ and $H_{6}$ are the graphs shown in Figure 5. Suppose $N / a \cong M\left(H_{4}\right)$. Then $M\left(H_{4}\right)_{T} \nsubseteq M\left(K_{5}\right)$ for any $T$ with $|T|=2$.

Thus we take coextension of $H_{4}$. Here all coextensions of $H_{4}$ by an element belongs to $\mathcal{T}_{2}$, hence we discard $H_{4}$. Suppose $N / a \cong M\left(H_{5}\right)$. Therefore $G$ is a coextension of $H_{5}$ by one or two elements. There are seven coextensions of $H_{5}$ by an element shown in Figure 16, without containing a minor isomorphic to $M\left(G_{1}\right), M\left(G_{2}\right)$ and $M\left(G_{3}\right)$. Since $M\left(C_{i}\right)$ contains a loop and at least two 2-circuits, the splitting with respect to any two elements set $T$ will contain a loop or a 2 -circuit for $i=9,10, \cdots, 15$. Therefore we take coextensions of $C_{i}$ for $i=9,10, \cdots 15$ such that it does not contain a minor isomorphic to $M\left(G_{1}\right)$ or $M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. Also, it does not contain a loop or more than two 2 -circuits. It is observed that there is no coextension with these conditions. Hence we discard $H_{5}$. Suppose $N / a \cong M\left(H_{6}\right)$. Then, by using similar argument as above, we discard $H_{6}$.

Case (iv). Suppose $F=M\left(K_{3,3}\right)$. Then, by Lemma 3.5, $N / a \cong M\left(H_{i}\right)$ for $i=$ 7, $8,9,10,11$, where $H_{i}$ is the graph as shown in Figure 7, for $i=7,8,9,10,11$.

Suppose $N / a \cong M\left(H_{7}\right)$, then $M\left(H_{7}\right)_{T} \nexists M\left(K_{3,3}\right)$ for any $T$ with $|T|=2$, thus we take coextension of $H_{7}$, but all coextension of $H_{7}$ belongs to $\mathcal{T}_{2}$. Hence we discard the graph $H_{7}$. Let $N / a \cong M\left(H_{8}\right)$. Then $G$ is a coextension of $H_{8}$ by one or two elements. There are three coextensions of $H_{8}$ by an element as shown in Figure 17, without containing a 2-edge cut. Here $M\left(C_{16}\right)$ and $M\left(C_{17}\right)$ contains a minor isomorphic to $M\left(G_{1}\right)$ and $M\left(C_{18}\right)$ contains a minor isomorphic to $M\left(G_{3}\right)$. Thus we discard these coextensions.

Let $N / a \cong M\left(H_{9}\right)$. Thus we take the coextension of $H_{9}$ by one or two elements. There is no coextension of $H_{9}$ by one element as well as by two elements, such that it does not contain a loop, a 2-cocircuit or a minor isomorphic to $M\left(G_{1}\right), M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. Hence we discard $H_{9}$.

If $N / a \cong M\left(H_{10}\right)$ then, $G$ is a coextension of $H_{10}$ by one or two elements such that it does not contain 2-cocircuit or minor $M\left(G_{1}\right), M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. Such non-isomorphic coextensions of $H_{10}$ by one element are shown in Figure 18, Here $C_{19}$ and $C_{20}$ contains a

loop. Since $M\left(C_{19}\right) \in \mathcal{T}_{2}, G \not \equiv C_{19}$. By Lemma 4.2, the splitting of $M\left(C_{20}\right)$ contains a loop or its graphic. Hence we take coextensions by $H_{10}$ by two elements such that it does not contain a loop, a 2-cocircuit and a minor isomorphic to $M\left(G_{1}\right), M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. It is observed that there is no such coextension. Thus we discard $H_{10}$.

If $N / a \cong M\left(H_{11}\right)$, then, we take coextensions of $H_{11}$ by one element such that it does not contain 2-cocircuit and minor $M\left(G_{1}\right), M\left(G_{2}\right)$ or $M\left(G_{3}\right)$. One can easily check that there is no such coextension. Hence we discard $H_{11}$.

Therefore $M_{T}$ is cographic for any $T$ with $|T|=2$. Hence proved.

## 5. Forbidden-Minor Characterization of the class $\mathcal{M}_{3}$

In this section, we prove Theorem 1.3. We now first prove 'if part' of Theorem 1.3 in the following proposition.

Proposition 5.1. Let $M$ be a graphic matroid. If $M$ contains a minor isomorphic to any of the matroids $M\left(\tilde{G}_{1}\right), M\left(\tilde{G}_{3}\right)$ and $M\left(G_{i}\right)$ for $i=4,5,6,7$, then $M_{T}$ is not cographic for some $T \subseteq E(M)$ with $|T|=3$, where $G_{i}$ is the graph as shown in Figure 19, for $i=1,3,4,5,6,7$.

Proof. Note that, by Theorem 1.1, $M\left(G_{1}\right), M\left(G_{2}\right)$ and $M\left(G_{3}\right)$ are the forbidden minors for the class $\mathcal{M}_{2}$. For $k=1,3$, let $\tilde{M}\left(G_{k}\right)$ be a matroid obtained by adding an element $z_{k}$ to $M\left(G_{k}\right)$. Then $\tilde{M}\left(G_{k}\right) \backslash z_{k}=M\left(G_{k}\right)$. By Theorem 1.1, there is $T_{k}$ with $\left|T_{k}\right|=2$ such that $M\left(G_{k}\right)_{T_{k}}$ is not a cographic matroid. Let $T=T_{k} \cup z_{k}$. Then, by Lemma 2.2(ii), $\tilde{M}\left(G_{k}\right)_{T} \backslash z_{k} \cong\left(\tilde{M}\left(G_{k}\right) \backslash z_{k}\right)_{T_{k}} \cong M\left(G_{k}\right)_{T_{k}} \cong M\left(G_{k}\right)_{T_{k}}$ is not cographic. $\tilde{M}\left(G_{k}\right)_{T}$ is not cographic. Also $G_{2}$ is minor of $G_{5}$.

Suppose $M=M\left(G_{4}\right)$ and $T=\{x, y, z\}$, where $x, y, z$ are as shown in the graph $G_{4}$. Let $A_{4}$ be the standard matrix representation of $G_{4}$ as follows:

x & y & z & & & & \\
1 & 0 & 0 & 0 & 1 & 0 & 1 \\
0 & 1 & 0 & 0 & 1 & 1 & 0 \\
0 & 0 & 0 & 1 & 1 & 1 & 1
\end{array}\right] . \text { Then }\left(A_{4}\right)_{T}=\left[\begin{array}{lllllll}
x & y & z & & & & \\
1 & 0 & 0 & 0 & 1 & 0 & 1 \\
0 & 1 & 0 & 0 & 1 & 1 & 0 \\
0 & 0 & 0 & 1 & 1 & 1 & 1 \\
1 & 1 & 1 & 0 & 0 & 0 & 0
\end{array}\right]
$$

Let $\left(A_{4}\right)_{T}^{\prime}$ be the matrix obtained by applying the row transformations $R_{4} \Longrightarrow R_{4}+\left(R_{1}+R_{2}\right)$ and $R_{34}$. Then we have

$$
\left(A_{4}\right)_{T}^{\prime}=\left[\begin{array}{lllllll}
1 & 0 & 0 & 0 & 1 & 0 & 1 \\
0 & 1 & 0 & 0 & 1 & 1 & 0 \\
0 & 0 & 1 & 0 & 0 & 1 & 1 \\
0 & 0 & 0 & 1 & 1 & 1 & 1
\end{array}\right]
$$

Since the vector matroid of $\left(A_{4}\right)_{T}^{\prime}$ is isomorphic to $F_{7}^{*}, M\left(G_{4}\right)_{T} \cong M\left[\left(A_{4}\right)_{T}\right] \cong M\left[\left(A_{4}\right)_{T}^{\prime}\right] \cong$ $F_{7}^{*}$. By Theorem 2.1, $M\left(G_{4}\right)_{T}$ is not cographic. Similarly, we can prove that $M\left(G_{5}\right)_{T_{5}} \cong F_{7}^{*}$, $M\left(G_{6}\right)_{T_{6}} \cong M\left(K_{3,3}\right)$ and $M\left(G_{7}\right)_{T_{7}} \cong M\left(K_{3,3}\right)$ for $T_{i}=\{x, y, z\}$, where $x, y, z$ are as shown in the graph $G_{i}$ in Figure 19, for $i=5,6,7$.

Suppose $M$ contains a minor $N$ isomorphic to any of circuit matroids $M\left(G_{k}\right), k=4,5,6,7$. Then $N_{T}$ is not cographic for some $T \subseteq E(N)$ with $|T|=3$. Since $N$ is a minor of $M$, there exist subsets $T_{1}$ and $T_{2}$ of $E(M)$ such that $M \backslash T_{1} / T_{2} \cong N$. Then, by repeated application of Lemma [2.2, we have $M_{T} \backslash T_{1} / T_{2} \cong\left(M \backslash T_{1} / T_{2}\right)_{T} \cong N_{T}$. As $N_{T}$ is not cographic, $M_{T}$ is also not cographic.

Now we prove the main theorem. For convenience, we restate the main theorem here along with graphs.

Theorem 5.2. Let $M$ be a graphic matroid without containing a minor isomorphic to any member of the set $\mathcal{T}_{3}$. Then $M \in \mathcal{M}_{3}$ if and only if $M$ does not contain a minor isomorphic to any of the matroid $\tilde{M}\left(G_{1}\right), \tilde{M}\left(G_{3}\right), M\left(G_{4}\right), M\left(G_{5}\right), M\left(G_{6}\right)$ and $M\left(G_{7}\right)$, where $G_{i}$ is the graph as shown in Figure 19, for $i=1,3,4,5,6,7$.

Proof. If $M$ has a minor isomorphic to one of the circuit matroids $\tilde{M}\left(G_{1}\right)$, and $\tilde{M}\left(G_{3}\right)$ and $M\left(G_{k}\right)$ for $k=4,5,6,7$, then $M_{T}$ is not cographic for some $T \in E(N)$ with $|T|=3$ by Proposition 5.1.

Conversely, assume that $M$ does not contain a minor isomorphic to any of the circuit matroid $\tilde{M}\left(G_{1}\right), \tilde{M}\left(G_{3}\right)$ and $M\left(G_{k}\right)$ for $k=4,5,6,7$. Then we will prove that $M_{T}$ is cographic for any $T \subseteq E(M)$ with $|T|=3$. On contrary, assume that $M_{T}$ is not cographic for some $T \subseteq E(M)$ with $|T|=3$. Then, by Theorem $2.1 M_{T}$, has a minor isomorphic to $F \in \mathcal{F}$. Then, by Lemma 2.3, $M$ has a minor $Q$ containing T such that one of the following holds.
(i). $Q$ isomorphic to one of the circuit matroids $\tilde{M}\left(G_{1}\right), \tilde{M}\left(G_{2}\right)$ and $\tilde{M}\left(G_{3}\right)$.
(ii). $Q_{T} \cong F$ or $Q_{T} / T^{\prime} \cong F$ for some $T^{\prime} \subseteq T$.

Note that the graph $G_{2}$ contains a minor isomorphic to the graph $G_{5}$. If $Q$ is isomorphic to $\tilde{M}\left(G_{1}\right), \tilde{M}\left(G_{2}\right)$ and $\tilde{M}\left(G_{3}\right)$, then it is clear that $M$ contains a minor isomorphic to $\tilde{M}\left(G_{1}\right)$, $\tilde{M}\left(G_{3}\right)$ or $M\left(G_{5}\right)$, a contradiction. Thus (i) does not hold. Suppose (ii) holds. By Lemma 2.4 and Lemma 2.5, assume that $Q$ do not contain a 2 -cocircuit and a coloop. Thus $Q$ is 3-minimal with respect to $F$. Then, by Lemma [2.6, there exist a binary matroid $N$ such that $N \backslash a \cong F$ and $N / a=Q$ or $Q$ is a coextension of $N / a$ by one, two or three elements. If $M$ is graphic, then $Q$ and $N / a$ are also graphic. Let $Q \cong M(G)$ for some connected graph $G$. We assume that $G$ does not contain a loop or 2-edge cut.

Case (i). Suppose $F=F_{7}^{*}$. Then $N \backslash a=F_{7}^{*}$ and, by Lemma 3.2, $N / a \cong M\left(H_{1}\right)$ or $M\left(H_{2}\right)$, where $H_{1}$ and $H_{2}$ are the graphs as shown in Figure 4. Here $H_{1} \cong G_{4}$ and $H_{2} \cong G_{5}$. Thus $Q=N / a \cong M\left(G_{4}\right)$ or $Q=N / a \cong M\left(G_{5}\right)$. Hence $M$ contains a minor isomorphic to $M\left(G_{4}\right)$ or $M\left(G_{5}\right)$, a contradiction.

Case (ii). Suppose $F=F_{7}$. Then $N \backslash a=F_{7}$ and, by Lemma 3.2, $N / a \cong M\left(H_{3}\right)$, where $H_{3}$ is the graph as shown in Figure 4. The graph $H_{3}$ contain three pairs parallel edges and a loop. Therefore $M\left(H_{3}\right)_{T}$ contains at least one 2-circuit or a loop for any $T$ with $|T|=3$. Therefore $M\left(H_{3}\right)_{T} \nsubseteq F_{7}$ and $Q \nsubseteq M\left(H_{3}\right)$. Hence $Q$ is a coextension of $M\left(H_{3}\right)$ by one, two or three elements. There are five non-isomorphic coextension of $M\left(H_{3}\right)$ as shown in Figure 15. without containing 2-edge cut. The graphs $C_{4}, C_{7}$ and $C_{8}$ contains a minor isomorphic to the graph $G_{5}$ and $C_{5}$ contains a minor isomorphic to graph $G_{4}$. Therefore we discard them.

Let $Q=M\left(C_{6}\right)$ or $Q$ is a coextension of $M\left(C_{6}\right)$ by one or two elements. Coextensions of $M\left(C_{6}\right)$ by one or two elements contains 2 -cocircuit or $G_{5}$ as a minor, a contradiction. Hence $Q=M\left(C_{6}\right)$. Since $C_{6}$ has two 2-circuits and eight edges whereas $F_{7}$ has seven edges, there is $T \subseteq E\left(C_{6}\right)$ with $|T|=3$ such that $M\left(C_{6}\right)_{T} / x \cong F_{7}$ for some $x \in T$. If a 2-circuit does not intersect $T$ or contained in $T$, then it remains a 2 -circuit in $M\left(C_{6}\right)_{T}$. Thus $M\left(C_{6}\right)_{T} / x \cong F_{7}$ contains a 2 -circuit or a loop, a contradiction. Hence $T$ contains exactly one edge from each

2-circuits of $C_{6}$. We assume that $x \in T$ does not belong to any 2 -circuit of $C_{6}$. Then there is triangle in $G$ containing two edges from $T$ one of which is $x$. Then that 3 -circuit of $M\left(C_{6}\right)$ is get preserved in $M\left(C_{6}\right)_{T}$. Therefore $Q_{T} / x \cong F_{7}$ contains a 2-circuit, a contradiction.

Case (iii). Suppose $F=M\left(K_{5}\right)$. Then $N \backslash a \cong M\left(K_{5}\right)$ and, by Lemma 3.3, $N / a \cong$ $M\left(H_{4}\right), N / a \cong M\left(H_{5}\right)$ or $N / a \cong M\left(H_{6}\right)$, where $H_{4}, H_{5}$ and $H_{6}$ are the graphs as shown in Figure 5. The matroid $M\left(H_{4}\right)$ does not give $M\left(K_{5}\right)$ after splitting with respect to a three elements set. Hence we take coextension of $M\left(H_{4}\right)$, but coextension of $M\left(H_{4}\right)$ is a trivial minor for the class $\mathcal{M}_{2}$. Hence we discard $M\left(H_{4}\right)$. The matroid $M\left(H_{5}\right)$ contains a minor isomorphic to $M\left(G_{4}\right)$. Hence $M$ can not be arise from $M\left(H_{5}\right)$. The matroid $M\left(H_{6}\right)$ contains a minor isomorphic to $M\left(G_{4}\right)$, and hence $G$ not arise from $H_{5}$ and $H_{6}$.

Case (iv). Suppose $F=M\left(K_{3,3}\right)$. Then $N \backslash a \cong M\left(K_{3,3}\right)$ and, by Lemma 3.5, $N / a \cong$ $M\left(H_{i}\right)$, where $H_{i}$ is the graph shown in Figure 7, for $i=7,8,9,10,11$. The matroid $M\left(H_{7}\right)$ belongs to $\mathcal{T}_{2}$. Hence we discard the graph $H_{7}$. Note that $H_{8} \cong G_{6}$ and $H_{11}=G_{7}$. The matroid $M\left(H_{i}\right)$, for $i=9,10$ contains a minor isomorphic to $M\left(G_{4}\right)$. Therefore $M$ can not be arise from these matroid.

Thus from all the above cases, $M_{T}$ does not contain $F$ as a minor for any $F \in \mathcal{F}$. Therefore $M_{T}$ is cographic and hence proved.
