DUALITY VIA CONVOLUTION OF W-ALGEBRAS

ABSTRACT. Feigin-Frenkel duality is the isomorphism between the principal W-algebras of a simple Lie algebra \mathfrak{g} and its Langlands dual Lie algebra $^{L}\mathfrak{g}$. A generalization of this duality to a larger family of W-algebras called *hook-type* was recently conjectured by Gaiotto and Rapčák and proved by the first two authors. It says that the affine cosets of two different hook-type W-algebras are isomorphic. A natural question is whether the duality between affine cosets can be enhanced to a duality between the full W-algebras. There is a convolution operation that maps a hook-type W-algebra W to a certain relative semi-infinite cohomology of W tensored with a suitable kernel VOA. The first two authors conjectured previously that this cohomology is isomorphic to the Feigin-Frenkel dual hook-type W-algebra. Our main result is a proof of this conjecture.

1. INTRODUCTION

Let \mathfrak{g} be a simple Lie algebra or basic Lie superalgebra and let $V^k(\mathfrak{g})$ be the affine vertex algebra of \mathfrak{g} at the complex level k. We assume k to be generic. To any even nilpotent element f in \mathfrak{g} one constructs from $V^k(\mathfrak{g})$ a corresponding W-algebra, denoted by $W^k(\mathfrak{g}, f)$, via quantum Hamiltonian reduction [KRW, KW]. If f is a principal nilpotent then one often omits the symbol f. Principal W-algebras enjoy Feigin-Frenkel duality [FF2], that is

$$\mathcal{W}^k(\mathfrak{g}) \cong \mathcal{W}^\ell({}^L\mathfrak{g}), \qquad r^{\vee}(k+h^{\vee})(\ell+{}^Lh^{\vee})=1.$$

Here \mathfrak{g} is a simple Lie algebra, ${}^{L}\mathfrak{g}$ is its Langlands dual, r^{\vee} is the lacing number of \mathfrak{g} and h^{\vee} , ${}^{L}h^{\vee}$ are the dual Coxeter numbers of \mathfrak{g} and ${}^{L}\mathfrak{g}$. In the Lie superalgebra case a similar duality holds for $\mathfrak{g} = \mathfrak{osp}_{1|2n}$ and replacing r^{\vee} by 4 [Ge, CL2].

Hook-type W-superalgebras [CL1, CL2] are W-superalgebras such that $f = f_{\mathfrak{a}}$ is principal inside an subalgebra \mathfrak{a} whose centralizer $\mathfrak{b} = \mathfrak{z}_{\mathfrak{a}}(\mathfrak{g})$ satisfies the following property: \mathfrak{g} decomposes as a $\mathfrak{a} \oplus \mathfrak{b}$ -module into

$$\mathfrak{g} \simeq \begin{cases} (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}}^{\dagger} \oplus \rho_{\mathfrak{a}}^{\dagger} \otimes \rho_{\mathfrak{b}} & \text{if } \mathfrak{g} = \mathfrak{sl}_{n|m}, \\ (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}} & \text{if } \mathfrak{g} = \mathfrak{osp}_{n|2m} \end{cases}$$

This family contains the principal W-algebras of type A, B, C, and D and the principal W-superalgebras of $\mathfrak{osp}_{1|2n}$, as well as other familiar examples including subregular and minimal W-superalgebras. In order to present our results uniformly for all types, we introduce slightly different notation $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ for the Wsuperalgebras $\mathcal{W}^{k}(\mathfrak{g}, f_{\mathfrak{a}})$ from the notation in [CL1, CL2]; see Table 1. In all cases, they contain $V^{k_{\mathfrak{b}}}(\mathfrak{b})$ as the maximal affine vertex subalgebra.

Davide Gaiotto and Miroslav Rapčák studied vertex algebras at two-dimensional corners in four dimensional quantum field theories [GR]. The associated corner vertex algebras are cosets of hook-type W-superalgebras and the S_3 -symmetry of the gauge theory led them to conjecture a remarkable family of *trialities* among these vertex algebras, i.e., isomorphisms of three such algebras. These isomorphisms fall into two types; one type generalizes Feigin-Frenkel duality, and the other type generalizes the coset realization of certain principal W-algebras obtained in [ACL, CL2], namely

$$\begin{split} \mathcal{W}^{k}(\mathfrak{g}) &\cong \operatorname{Com}\left(V^{\ell}(\mathfrak{g}), V^{\ell-1}(\mathfrak{g}) \otimes L_{1}(\mathfrak{g})\right), & \frac{1}{k+h^{\vee}} + \frac{1}{\ell+h^{\vee}} = 1, \\ \mathcal{W}^{k}(\mathfrak{sp}_{2n}) &\cong \operatorname{Com}\left(V^{\ell}(\mathfrak{sp}_{2n}), V^{\ell}(\mathfrak{osp}_{1|2n})\right), & \frac{1}{k+h^{\vee}} + \frac{1}{\ell+h^{\vee}} = 2, \\ \mathcal{W}^{k}(\mathfrak{osp}_{1|2n}) &\cong \operatorname{Com}\left(V^{\ell}(\mathfrak{so}_{2n+1}), V^{\ell-1}(\mathfrak{so}_{2n+1}) \otimes F^{2n+1}\right), & \frac{1}{k+h^{\vee}} + \frac{2}{\ell+h^{\vee}} = 2. \end{split}$$

Here \mathfrak{g} is of type A or D and $L_1(\mathfrak{g})$ is the simple affine vertex algebra of \mathfrak{g} at level one. (In fact the first isomorphism was proven for all simply-laced types in [ACL], but the type E case is not part of these trialities). Also, F^{2n+1} is the vertex superalgebra of 2n + 1 free fermions. Note that for $\mathfrak{g} = \mathfrak{g}_2$ and \mathfrak{f}_4 , no coset realization of $\mathcal{W}^k(\mathfrak{g})$ is known at present.

The triality conjectures were recently proven by the first two authors in [CL1, CL2]. The four-dimensional quantum field theories allow for dualities, called S-duality, and these are the physics perspective on (quantum) geometric Langlands duality [KaW]. Vertex algebras play an important role [CG, FG] and in particular it is conjectured that a certain convolution operation against quantum geometric Langlands kernel VOAs realizes the S-duality operations on the level of associated vertex algebras [CG, Section 7.3]. The kernel VOAs bear similarity to Gaitsgory's master chiral algebras [G]; they are parametrized by an associated Lie algebra g and an integer n. For n = 0, the kernel VOA is the algebra of chiral differential operators of the Lie group whose Lie algebra is g [MSV] and the convolution operation has been used by Arakawa in his proof of the Moore-Tachikawa conjecture [A].

1.1. Convolution with kernel VOAs. Let k be generic. The general kernel VOAs are extensions of $V^k(\mathfrak{g}) \otimes V^{\ell}(\tilde{\mathfrak{g}})$ of the form

$$\mathfrak{A}^{n}[\mathfrak{g},k] = \bigoplus_{\lambda \in R} \mathbb{V}^{k}_{\lambda} \otimes \mathbb{V}^{\ell}_{\lambda^{\dagger}},$$

where the inverses of the shifted levels add up to a multiple of n, \mathbb{V}^{k}_{λ} and $\mathbb{V}^{\ell}_{\lambda^{\dagger}}$ are Weyl-modules of weight λ and λ^{\dagger} of $V^{k}(\mathfrak{g})$ and $V^{\ell}(\tilde{\mathfrak{g}})$, R is a certain subset of dominant weights and $\tilde{\mathfrak{g}}$ is a Lie algebra related to \mathfrak{g} and λ^{\dagger} is a dominant weight of $\tilde{\mathfrak{g}}$ naturally identified with λ , see subsection 2.3 for all the concrete details. We are interested in $\mathfrak{g} \in {\mathfrak{gl}_n, \mathfrak{so}_n, \mathfrak{sp}_{2n}, \mathfrak{osp}_{1|2n}}$. We have that the Lie algebra related to $\mathfrak{osp}_{1|2n}$ is \mathfrak{so}_{2n+1} and vice versa, while all others satisfy $\mathfrak{g} = \tilde{\mathfrak{g}}$. Yuto Moriwaki [M] recently proved the existence of the kernel VOAs when $\mathfrak{g} = \tilde{\mathfrak{g}}$. The case of the pair $\mathfrak{so}_3, \mathfrak{osp}_{1|2}$ is just $A^1[\mathfrak{so}_3, k] = L_1(\mathfrak{d}(2, 1; -2k))$ and $A^1[\mathfrak{osp}_{1|2}, k] = L_1(\mathfrak{d}(2, 1; -\frac{1}{k+1}))$ [CG, (9.6)] together with [CGL2, Thm. 3.2]).

Let V be another vertex algebra that has an affine subalgebra $V^{-k-2h^{\vee}}(\mathfrak{g})$. Then the convolution operation is the relative semi-infinite Lie algebra cohomology on $V \otimes \mathfrak{A}^n[\mathfrak{g}, k]$. We explain the relative semi-infinite Lie algebra cohomology in §3.1 and the Appendix and in particular prove that the results of [FGZ] also hold for $\mathfrak{g} = \mathfrak{osp}_{1|2n}$.

Assume that V decomposes as

$$V = \bigoplus_{\lambda \in R} \mathbb{V}_{\lambda}^{-k-2h^{\vee}} \otimes C_{\lambda}$$

with $C = C_0 = \operatorname{Com}(V^{-k-2h^{\vee}}(\mathfrak{g}), V)$ the coset and C_{λ} are modules of C. Then

$$H^{\frac{\infty}{2}+m}_{\mathrm{rel}}(\mathfrak{g}, V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]) = \delta_{m,0} \bigoplus_{\lambda \in R} C_{\lambda} \otimes \mathbb{V}^{\ell}_{\lambda^{\dagger}}$$

as a $C \otimes V^{\ell}(\tilde{\mathfrak{g}})$ -module. Set $\widetilde{V} := H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(\mathfrak{g}, V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]).$

This type of convolution operation has been used to construct the large N = 4 superconformal algebra [CFL] and it motivated the conjecture that Feigin-Frenkel dual hook-type W-superalgebras are related via the convolution operation [CL2, Conjecture 1.2]. If $\mathfrak{g} = \mathfrak{gl}_1$, then the kernel VOAs are just the lattice VOAs of the lattices $\sqrt{n\mathbb{Z}}$ times a rank one Heisenberg VOA. In this case the conjecture connects subregular W-algebras of type A, B with principal W-superalgebras of type $\mathfrak{sl}_{n|1}$ and $\mathfrak{osp}_{2|2n}$. The correspondence in this case is often also called Feigin-Semikhatov duality due to their work [FS]. In this case, the conjecture is proven and exploited in [CGN, CGNS]. We have

Main Theorem. (Theorem 4.4) For $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$ under $r_X(k + h_{X^+}^{\vee})(\ell + h_{Y^-}^{\vee}) = 1$, there exist isomorphisms of vertex superalgebras

$$\begin{split} & \mathcal{W}_{Y^{-}}^{\ell}(n,m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n,m) \otimes A^{1}[\mathfrak{b},\alpha_{+}]\right), \\ & \mathcal{W}_{X^{+}}^{k}(n,m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n,m) \otimes A^{-1}[\mathfrak{b},\alpha_{-}]\right), \end{split}$$

 (α_+, α_-) are given in Theorem 4.4, $(X, Y) \in \{(A, A), (B, O), (C, C), (D, D), (O, B)\}$. The statements for $X \in \{B, O\}$ with m > 1 are understood under the assumption of the existence of a simple vertex superalgebra structure on $A^{\pm 1}[\mathfrak{so}_{2m+1}, k] = A^{\pm 1}[\mathfrak{osp}_{1|2m}, \ell]$.

One main interest is that one can now take a module, say $M \otimes N$ of $V \otimes \mathfrak{A}^n[\mathfrak{g}, k]$ and the cohomology then gives a module of the dual algebra. This means that for a fixed $\mathfrak{A}^n[\mathfrak{g}, k]$ -module N, there is a functor from V-modules to modules of the dual algebra \widetilde{V}

$$\mathfrak{F}_N: V\text{-} \mod \to \widetilde{V}\text{-} \mod, \qquad M \mapsto H^{\frac{\infty}{2}+0}_{\mathrm{rel}}(M \otimes N).$$

If V, \tilde{V} is as in our main theorem, that is $V \cong H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(\tilde{\mathfrak{g}}, \tilde{V} \otimes \mathfrak{A}^{-n}[\tilde{\mathfrak{g}}, \ell])$, then one immediately also gets functors in the other direction and one might hope to be able to use them to prove equivalences of blocks of categories of V-mod and \tilde{V} -mod. In the instance of subregular W-algebras of type A, B and principal W-superalgebras of type $\mathfrak{sl}_{n|1}$ and $\mathfrak{osp}_{2|2n}$, this family of functors gives indeed a block-wise equivalence of module categories together with isomorphisms of spaces of intertwining operators, see [CGNS]. In the spirit of the quantum geometric Langlands correspondence one also would like to get an equivalence of conformal blocks. A strong indication that such an equivalence might be true is that there is a conformal field theory approach using the path integral that indeed gives identifications of correlation functions [CH1, CH2, CHS, CH3]. We aim to pursue this direction further and are currently studying the behavior of characters under our convolution operation.

2. Kernel vertex superalgebras

2.1. Affine vertex superalgebras. Let $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$ be a finite dimensional Lie superalgebra equipped with an even non-degenerate supersymmetric invariant bilinear form $\kappa = (\cdot|\cdot)$. The one-dimensional central extension $\widehat{\mathfrak{g}}_{\kappa} = \mathfrak{g}[t^{\pm 1}] \oplus \mathbb{C}K$ of the loop superalgebra $\mathfrak{g}[t^{\pm 1}] = \mathfrak{g} \otimes \mathbb{C}[t^{\pm 1}]$, whose commutator is $[X_n, Y_m] = [X, Y]_{n+m} + (X|Y)K$, $(X_n := Xt^n)$, is called the affine Lie algebra of \mathfrak{g} . Then the induced representation $V^{\kappa}(\mathfrak{g}) := \operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C}K}^{\widehat{\mathfrak{g}}_{\kappa}} \mathbb{C}$ where $\mathfrak{g}[t]$ acts on \mathbb{C} by zero and K by identity has a structure of vertex superalgebra, called the universal affine vertex superalgebra associated with \mathfrak{g} at level κ . As a vertex superalgebra, $V^{\kappa}(\mathfrak{g})$ is generated by fields $Y(X_{-1}\mathbf{1}, z) := X(z) = \sum_{n \in \mathbb{Z}} X_n z^{-n-1}$, $(X \in \mathfrak{g})$ which satisfy the OPEs

$$X(z)Y(z) \sim \frac{[X,Y]}{(z-w)} + \frac{(X|Y)}{(z-w)^2}, \quad (X,Y \in \mathfrak{g}).$$

The vertex superalgebra $V^{\kappa}(\mathfrak{g})$ is $\mathbb{Z}_{\geq 0}$ -graded by setting $\Delta(x_{1,n_1}\cdots x_{m,n_m}\mathbf{1}) = -\sum_{p=1}^m n_p$, $(x_i \in \mathfrak{g})$. We denote by $\mathbf{KL}_{\kappa}(\mathfrak{g})$ the Kazhdan–Lusztig category of $V^{\kappa}(\mathfrak{g})$ at level κ , that is, the full subcategory of all the (\mathbb{Z}_2 -graded) positive-energy representations of $V^{\kappa}(\mathfrak{g})$ consisting of integrable \mathfrak{g} -modules.

2.2. Tensor representations. Here we recollect and fix notation of tensor representations of Lie superalgebras $\mathfrak{g} = \mathfrak{gl}_m \mathfrak{sl}_m, \mathfrak{so}_m, \mathfrak{sp}_{2m}$, and $\mathfrak{osp}_{1|2m}$.

We first consider the case when \mathfrak{g} is simple. Let $\mathfrak{g} = \mathfrak{n}_+ \oplus \mathfrak{h} \oplus \mathfrak{n}_-$ be the triangular decomposition, $\{\alpha_i\}_{i=1}^{\operatorname{rank}\mathfrak{g}} \subset \mathfrak{h}^*$ the set of simple roots, and $\{\varpi_i\}_{i=1}^{\operatorname{rank}\mathfrak{g}}$ the set of fundamental weights. We set $P = \bigoplus_i \mathbb{Z} \varpi_i$ (resp. $Q = \bigoplus_i \mathbb{Z} \alpha_i$) the weight lattice (resp. the root lattice). Then we denote by $P_+ = \bigoplus_i \mathbb{Z}_{\geq 0} \varpi_i$ the set of dominant integral weights and by L_{λ} , $(\lambda \in P_+)$, the simple \mathfrak{g} -module generated by highest weight vector of even parity and of highest weight λ . In particular, L_{ϖ_1} corresponds to the natural representation $\rho_{\mathfrak{g}}$, which is \mathbb{C}^m (resp. \mathbb{C}^m , \mathbb{C}^{2m} , $\mathbb{C}^{1|2m}$) when $\mathfrak{g} = \mathfrak{sl}_m$ (resp. \mathfrak{so}_m , \mathfrak{sp}_{2m} , $\mathfrak{osp}_{1|2m}$). Given $\lambda \in P_+$, let λ^{\dagger} denote the highest weight for the dual representation $\operatorname{Hom}_{\mathbb{C}}(L_{\lambda}, \mathbb{C}^{1|0})$. By using the Weyl group W of \mathfrak{g} and its longest element w_0 , we have $\lambda^{\dagger} = -w_0\lambda$.

Lemma 2.1. For $\lambda \in P_+$, \mathfrak{g} -module isomorphisms $L_{\lambda^{\dagger}} \simeq \operatorname{Hom}_{\mathbb{C}}(L_{\lambda}, \mathbb{C}^{1|0})$ are even.

Proof. It suffices to prove the case $\mathfrak{g} = \mathfrak{osp}_{1|2m}$. Decompose L_{λ} as a \mathfrak{sp}_{2m} -module: $L_{\lambda}|_{\mathfrak{sp}_{2m}} \simeq \bigoplus_{\mu} n_{\lambda,\mu} L_{\mu}(\mathfrak{sp}_{2m})$. Since the Cartan subalgebras of $\mathfrak{osp}_{1|2m}$ and \mathfrak{sp}_{2m} coincide, $n_{\lambda,\mu}$ is non-zero only if λ dominates μ . Hence, the lowest weight of L_{λ} coincides with that of $L_{\lambda}(\mathfrak{sp}_{2m})$.

Tensor representations of \mathfrak{g} are, by definition, modules appearing as submodules in the tensor algebra $T^{\bullet}(L_{\varpi_1} \oplus L_{\varpi_1^{\dagger}})$. We denote by $R \subset P_+$ the set of their highest weights. The condition is given in Table 2 below. We make two remarks when $\mathfrak{g} \neq \mathfrak{sl}_m$: $L_{\lambda^{\dagger}} \simeq L_{\lambda}$ holds for all $\lambda \in R$ since $\varpi_1^{\dagger} = \varpi_1$; by [RS], we have the one-to-one correspondence

$$R(\mathfrak{osp}_{1|2m}) \xrightarrow{\simeq} R(\mathfrak{so}_{2m+1}), \quad \lambda = \sum_{i=1}^{m} \lambda_i \varpi_i \mapsto {}^s \lambda := \sum_{i=1}^{m-1} \lambda_i \varpi_i + 2\lambda_m \varpi_m$$
(2.1)

under which the characters are identified and thus the branchings of tensor products coincide, see also [C]. By abuse of notation, we denote the inverse of (2.1) also by $\lambda \mapsto {}^{s}\lambda$.

Next, we consider the case $\mathfrak{g} = \mathfrak{gl}_m$. We decompose $\mathfrak{gl}_m = \mathfrak{sl}_m \oplus \mathbb{C}$ Id as usual and set the set of fundamental weights $\{\varpi_i\}_{i=1}^m$ so that under the above decomposition $\{\varpi_i\}_{i=1}^{m-1}$ corresponds to that of \mathfrak{sl}_m and ϖ_m to the dual of Id. Then we set $P_+ = \bigoplus_{i=1}^{m-1} \mathbb{Z}_{\geq 0} \varpi_i \oplus \mathbb{Z} \varpi_m$ and the remaining notation is the same as before. In particular, the natural representation $\rho_{\mathfrak{gl}_m} = \mathbb{C}^m$ and its dual representation $\rho_{\mathfrak{gl}_m}^\dagger = \mathbb{C}^m$ corresponds to $L_{\varpi_1 + \varpi_m}$ and $L_{\varpi_{m-1} - \varpi_m}$ respectively. The condition for the set $R \subset P_+$ of highest weights of tensor representations is given in Table 2 below.

In this paper, we will consider the pairs $(\mathfrak{gl}_m, \mathfrak{gl}_m)$, $(\mathfrak{sl}_m, \mathfrak{sl}_m)$, $(\mathfrak{so}_{2m+1}, \mathfrak{osp}_{1|2m})$, $(\mathfrak{sp}_{2m}, \mathfrak{sp}_{2m})$, $(\mathfrak{so}_{2m}, \mathfrak{so}_{2m})$ and it will be useful to extend the notation $\lambda \leftrightarrow {}^s \lambda$ for $(\mathfrak{so}_{2m+1}, \mathfrak{osp}_{1|2m})$ to all pairs by setting ${}^s \lambda = \lambda$ and also to the Lie superalgebras e.g. ${}^s \mathfrak{gl}_m = \mathfrak{gl}_m$.

2.3. Kernel vertex superalgebras. Let $\mathfrak{g} = \mathfrak{sl}_m$, \mathfrak{so}_m or \mathfrak{sp}_{2m} , and set $\kappa = k\kappa_0$ where κ_0 is the normalized invariant bilinear form on \mathfrak{g} and write $V^k(\mathfrak{g}) = V^{\kappa}(\mathfrak{g})$, $\mathbf{KL}_k(\mathfrak{g}) = \mathbf{KL}_{\kappa}(\mathfrak{g})$ and so on.

From now on, we assume $k \in \mathbb{C} \setminus \mathbb{Q}$. Therefore, $\mathbf{KL}_k(\mathfrak{g})$ is semisimple and the complete set of representatives of simple objects is given by the Weyl modules $\mathbb{V}_{\mathfrak{g}}^k(\lambda) = \operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C}K}^{\widehat{\mathfrak{g}}_k} L_{\lambda}, (\lambda \in P_+)$. When \mathfrak{g} is clear, we also write it as \mathbb{V}_{λ}^k . For $n \in \mathbb{Z}$, introduce the following ind-object of the Deligne product $\mathbf{KL}_k(\mathfrak{g}) \boxtimes \mathbf{KL}_\ell(\mathfrak{g})$:

$$\mathfrak{A}^{n}[\mathfrak{g},k] = \bigoplus_{\lambda \in R} \mathbb{V}^{k}_{\lambda} \otimes \mathbb{V}^{\ell}_{\lambda^{\dagger}}$$

$$(2.2)$$

where $\ell \in \mathbb{C}$ is defined by the relation

$$\frac{1}{r^{\vee}(k+h^{\vee})} + \frac{1}{r^{\vee}(\ell+h^{\vee})} = nN_{\mathfrak{g},R}.$$
(2.3)

Here r^{\vee} (resp. h^{\vee}) is the lacing number (resp. the dual Coxeter number) of \mathfrak{g} and $N_{\mathfrak{g},R}$ is the level of the lattice R, which is m (resp. 1) if $\mathfrak{g} = \mathfrak{sl}_m$ (resp. $\mathfrak{so}_m, \mathfrak{sp}_{2m}$). In [CG, FG], $\mathfrak{A}^n[\mathfrak{g},k]$ is conjectured to have a structure of simple vertex superalgebra and called the geometric Langlands kernel (super)algebra. For even n, this conjecture was first proven in [CKM, Corollary 1.4] and, in particular, for n = 0, $A^0[\mathfrak{g},k]$ is realized by the vertex algebra of chiral differential operators

$$\mathcal{D}_{G,\kappa}^{\mathrm{ch}} := \mathrm{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C}K}^{\mathfrak{g}_k} \mathbb{C}[J_\infty G].$$

Here $J_{\infty}G$ is the infinite jet scheme of $G = SL_m$ (resp. SO_m, Sp_{2m}) for $\mathfrak{g} = \mathfrak{sl}_m$ (resp. $\mathfrak{so}_m, \mathfrak{sp}_{2m}$) and $\mathfrak{g}[t]$ acts on $\mathbb{C}[J_{\infty}G]$ through the left-invariant vector fields on G. This $\mathfrak{g}[t]$ -action is induced from the \mathfrak{g} -action on $\mathbb{C}[G]$, which commutes with another \mathfrak{g} -action by the right-invariant vector fields. The Peter–Weyl theorem asserts that $\mathbb{C}[G] \simeq \bigoplus_{\lambda \in R} L_{\lambda} \otimes L_{\lambda^{\dagger}}$ as $(\mathfrak{g}, \mathfrak{g})$ -bimodules, which induces the decomposition of $\mathcal{D}_{G,k}^{ch}$ into (2.2) as $V^k(\mathfrak{g}) \otimes V^{-k-h^{\vee}}(\mathfrak{g})$ -modules [AG, GMS1, GMS2]. The coordinate ring $\mathbb{C}[G]$ has a q-deformation $O_q(G)$, called the quantum coordinate ring. It is a Hopf algebra dual to the quantum enveloping algebra $U_q(\mathfrak{g})$ and is a commutative algebra (ind-)object of the Deligne product $(U_q(\mathfrak{g}), R_{\rho})$ -mod $\boxtimes (U_{q^{-1}}(\mathfrak{g}), R_{-\rho})$ -mod). Here $(U_q(\mathfrak{g}), R_{\rho})$ -mod is the tensor category of finite dimensional $U_q(\mathfrak{g})$ -modules of type 1 equipped with a braiding defined by the R-matrix R_{ρ} depending on $\rho \in \mathbb{C}$ such that $\exp(\pi \sqrt{-1} \rho) = q$, which gives a braiding on the category, see e.g. [KS].

In [M], by using $O_q(G)$ and twists of the braided tensor category $(U_q(\mathfrak{g}), R_\rho)$ -mod by abelian 3-cocycles, Moriwaki has constructed various kinds of simple vertex superalgebras which are extensions of affine vertex algebras and lattice vertex superalgebras including (2.2) via the Kazhdan–Lusztig correspondence

$$(U_q(\mathfrak{g}), R_{1/r^{\vee}(k+h^{\vee})}) \operatorname{-mod} \xrightarrow{\simeq} \mathbf{KL}_k(\mathfrak{g})$$

In particular, $\mathfrak{A}[\mathfrak{sl}_m, k]$ has a variant corresponding to $\mathfrak{g} = \mathfrak{gl}_m$. More precisely, set

$$\mathfrak{A}^{n}[\mathfrak{gl}_{m},k] = \bigoplus_{\lambda \in R(\mathfrak{sl}_{m})} \mathbb{V}^{k}_{\mathfrak{sl}_{m}}(\lambda) \otimes \mathbb{V}^{\ell}_{\mathfrak{sl}_{m}}(\lambda^{\dagger}) \otimes V_{\frac{n\pi(\lambda)}{\sqrt{nm}} + \sqrt{nm}\mathbb{Z}}$$
(2.4)

with $\ell \in \mathbb{C}$ defined through (2.3) and $r^{\vee} = 1$, $N_{\mathfrak{gl}_m,R} = 1$. Here $V_{\sqrt{nm}\mathbb{Z}}$ is the lattice vertex superalgebra associated with the lattice $\sqrt{nm}\mathbb{Z}$, whose simple modules are $\{V_{\frac{a}{\sqrt{mn}}+\sqrt{mn}\mathbb{Z}}\}_{a\in\mathbb{Z}_{nm}}$, and π is the projection $P \twoheadrightarrow P/Q \xrightarrow{\simeq} \mathbb{Z}_m, (\varpi_i \mapsto i)$. Note that (2.4) is compatible with the Peter–Weyl theorem for $G = GL_m$ since weights appearing in the lattice part are regarded as one-dimensional representations for $\mathbb{C}\text{Id} \subset \mathfrak{gl}_m$. Then [M, Main Theorem B] specializes to the following statement:

Theorem 2.2 ([M]). For $k \in \mathbb{C} \setminus \mathbb{Q}$, $\mathfrak{A}^n[\mathfrak{g}, k]$ with $\mathfrak{g} = \mathfrak{gl}_m, \mathfrak{so}_m$, or \mathfrak{sp}_{2m} has a structure of simple vertex algebra (resp. superalgebra) if n is even (resp. odd).

For later use, we set

 $A^n[\mathfrak{gl}_m,k]=\mathfrak{A}^n[\mathfrak{gl}_m,k]\otimes\pi,\quad A^n[\mathfrak{g},k]=\mathfrak{A}^n[\mathfrak{g},k],\quad (\mathfrak{g}=\mathfrak{sp}_{2m},\mathfrak{so}_{2m}),$

where π is the rank one Heisenberg vertex algebra, and

$$A^{n}[\mathfrak{so}_{2m+1},k] = \bigoplus_{\lambda \in R} \mathbb{V}^{k}_{\mathfrak{so}_{2m+1}}(\lambda) \otimes \mathbb{V}^{\ell}_{\mathfrak{osp}_{1|2m}}({}^{s}\lambda) = A^{n}[\mathfrak{osp}_{1|2m},\ell]$$
(2.5)

where (k, ℓ) satisfies the relation

$$\frac{1}{a(k+h^{\vee})} + \frac{1}{b(\ell+h^{\vee})} = cn$$
(2.6)

with (a, b, c) given in Table 3 below. The existence of simple vertex superalgebra structure on (2.5) has been conjectured in [CL2]. Low rank cases are understood to be related to W-algebras of the exceptional Lie superalgebra $\mathfrak{d}(2, 1; \alpha)$

(1) $A^1[\mathfrak{gl}_2, k] = L_1(\mathfrak{d}(2, 1; -\frac{1}{k+1})) \otimes \pi$, the simple affine vertex superalgebra of $\mathfrak{d}(2, 1; -\frac{1}{k+1})$ at level one times a rank one Heisenberg algebra, this follows from [CG, Thm. 9.1].

- (2) $A^1[\mathfrak{so}_3, k] = L_1(\mathfrak{d}(2, 1; -2k)), [CG, (9.6)]$ together with [CGL2, Thm. 3.2].
- (3) $A^1[\mathfrak{sp}_2, k] = \mathcal{W}_{\frac{1}{2}}(\mathfrak{d}(2, 1; -2k-3), f_{\min})$, the simple minimal \mathcal{W} -superalgebra of $\mathfrak{d}(2, 1; -2k-3)$ at level 1/2 [CGL1, Cor. 2.6].
- (4) $A^1[\mathfrak{so}_4, k] = \operatorname{Hom}_{\mathfrak{C}(A_1^2)}(L_1(\mathfrak{d}(2, 1; -\frac{1}{k+1}))^{\otimes 2}, V_{\mathbb{Z}^2})$, here $\mathfrak{C}(L)$ is the category of modules of the lattice vertex algebra V_L of the lattice L. This statement follows easily from [CG, Thm. 9.1].
- (5) $A^1[\mathfrak{osp}_{1|2}, k] = L_1(\mathfrak{d}(2, 1; -\frac{1}{k+1})), [CG, (9.6)]$ together with [CGL2, Thm. 3.2].

In §4, we will use $A^{\pm 1}[\mathfrak{g}, k]$ for $\mathfrak{g} = \mathfrak{gl}_m$, \mathfrak{so}_{2m} , \mathfrak{sp}_{2m} and also \mathfrak{so}_{2m+1} , $\mathfrak{osp}_{1|2m}$ under the conjecture for m > 1. In Table 3, we summarize the values (a, b, c) in the relation (2.6), the parity and conformal weight Δ_K for the lowest conformal weights of the natural representation $\rho_{\mathfrak{g}} \otimes \rho_{\mathfrak{sg}}^{\dagger}$ and its dual $\rho_{\mathfrak{g}}^{\dagger} \otimes \rho_{\mathfrak{sg}}$ as $(\mathfrak{g}, \mathfrak{sg})$ -modules appearing in the decomposition

$$A^{n}[\mathfrak{g},k] = \bigoplus_{\lambda \in R} \mathbb{V}^{k}_{\mathfrak{g}}(\lambda) \otimes \mathbb{V}^{\ell}_{s_{\mathfrak{g}}}({}^{s}\lambda).$$

Here Π denotes the odd isomorphism for arbitrary vector superspaces which interchanges the parity.

Lemma 2.3. For $k \in \mathbb{C} \setminus \mathbb{Q}$, the bilinear form

$$\langle \cdot | \cdot \rangle \colon \left(\rho_{\mathfrak{g}} \otimes \rho_{s_{\mathfrak{g}}}^{\dagger} \right) \otimes \left(\rho_{\mathfrak{g}}^{\dagger} \otimes \rho_{s_{\mathfrak{g}}} \right) \to \mathbb{C}, \quad (x, y) \mapsto x_{(2\Delta_{K}-1)} y$$

is non-degenerate.

Proof. Since $\langle \cdot | \cdot \rangle$ is a $(\mathfrak{g}, {}^{s}\mathfrak{g})$ -invariant bilinear form, it is non-degenerate if it is non-zero. The latter is an immediate consequence of the structure of the Hopf algebra $O_q(G)$ as a $(U_q(\mathfrak{g}), U_{q^{-1}}(\mathfrak{g}))$ -bimodule for $\mathfrak{g} = \mathfrak{gl}_m$, \mathfrak{so}_{2m} , \mathfrak{sp}_{2m} and of the construction in [CG] for $\mathfrak{g} = \mathfrak{so}_3$, $\mathfrak{osp}_{1|2}$.

3. Relative semi-infinite cohomology

3.1. Relative semi-infinite cohomology. Let \mathfrak{g} be as in §2.2 and take a parity-homogeneous basis $\{x_i\}_{i=1}^{\dim \mathfrak{g}}$ with structure constants $c_{i,j}^k$, i.e. $[x_i, x_j] = \sum_k c_{i,j}^k x_k$.

Introduce a vertex superalgebra $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ generated by the fields

$$\varphi_i^*(z) = \sum_{n \in \mathbb{Z}} \varphi_{i,n}^* z^{-n}, \quad \varphi_i(z) = \sum_{n \in \mathbb{Z}} \varphi_{i,n} z^{-n-1}, \quad (i = 1, \dots, \dim \mathfrak{g})$$

with parity opposite to $x_i(z)$ satisfying the OPEs

$$\varphi_i(z)\varphi_j^*(w) \sim \frac{\delta_{i,j}}{z-w}, \quad \varphi_i(z)\varphi_j(w) \sim 0 \sim \varphi_i^*(z)\varphi_j^*(w).$$

As a vector superspace, $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ carries a cohomological grading $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g}) = \bigoplus_{n\in\mathbb{Z}}\bigwedge^{\frac{\infty}{2}+n}(\mathfrak{g})$ defined by deg $\partial^n \varphi_i^* = -\deg \partial^n \varphi_i = 1$. On the other hand, $V^{\kappa_{\mathfrak{g}}}(\mathfrak{g})$ acts on $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ by

$$x_i(z) \mapsto \sum_{j,k=1}^{\dim \mathfrak{g}} (-1)^{\bar{x}_j} c_{i,j}^k : \varphi_k(z) \varphi_j^*(z) :,$$

which preserves the cohomological grading. As a $V^{\kappa_{\mathfrak{g}}}(\mathfrak{g})$ -module, $\bigwedge^{\underline{\infty}}_{2}^{+\bullet}(\mathfrak{g})$ is a positive energy representation $\bigwedge^{\underline{\infty}}_{2}^{+\bullet}(\mathfrak{g}) = \bigoplus_{\Delta \geq 0} \bigwedge^{\underline{\infty}}_{2}^{+\bullet}(\mathfrak{g})_{\Delta}$ by setting the compatible grading to be $\Delta(\varphi_{i}^{*}) = 0$ and $\Delta(\varphi_{i}) = 1$. Since the dimension of $\bigwedge^{\underline{\infty}}_{2}^{+n}(\mathfrak{g})_{\Delta} = \bigwedge^{\underline{\infty}}_{2}^{+n}(\mathfrak{g}) \cap \bigwedge^{\underline{\infty}}_{2}^{+\bullet}(\mathfrak{g})_{\Delta}$ is finite, $\bigwedge^{\underline{\infty}}_{2}^{+\bullet}(\mathfrak{g})$ is an object in $\mathbf{KL}_{\kappa_{\mathfrak{g}}}(\mathfrak{g})$.

Given an object M in $\mathbf{KL}_{-\kappa_{\mathfrak{g}}}$, we associate a differential graded $V^{0}(\mathfrak{g})$ -module

$$C^{\frac{\infty}{2}+\bullet}(\mathfrak{g},M) := M \otimes \bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$$

equipped with (odd) differential

$$d = \int dz \sum_{i} (-1)^{\bar{x}_{i}} : x_{i}(z)\varphi_{i}^{*}(z) : -\frac{1}{2} \sum_{i,j,k} (-1)^{\bar{x}_{i}\bar{x}_{k}} c_{i,j}^{k} : \varphi_{i}^{*}(z)\varphi_{j}^{*}(z)\varphi_{k}(z) :$$

and grading given by that of $\bigwedge_{2}^{\infty} + \bullet(\mathfrak{g})$. The cohomology $H^{\frac{\infty}{2}} + \bullet(\mathfrak{g}, M)$ is called the semi-infinite cohomology of $\widehat{\mathfrak{g}}$ with coefficients in M. In this paper, we consider a relative version, which assigns the cohomology of the following subcomplex:

$$C_{\rm rel}^{\frac{\infty}{2}+\bullet}(\mathfrak{g},M) := \left(M \otimes \bigwedge_{\rm rel}^{\frac{\infty}{2}+\bullet}(\mathfrak{g})\right)^{\mathfrak{g}}.$$
(3.1)

Here $\bigwedge_{\text{rel}}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}) \subset \bigwedge_{\frac{\infty}{2}+\bullet}^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ is the subalgebra generated by $\{\partial \varphi_i^*(z), \varphi_i(z)\}_{i=1}^{\dim \mathfrak{g}}$ and $(?)^{\mathfrak{g}}$ denotes the \mathfrak{g} -invariant subspace by the diagonal \mathfrak{g} -action. It is called the relative semi-infinite cohomology functor and denoted by

$$H^{\underline{\mathfrak{Z}}^{+\bullet}}_{\mathrm{rel}}(\mathfrak{g},\cdot)\colon \mathbf{KL}_{-\kappa_{\mathfrak{g}}}\to \mathrm{SVect}^{\mathbb{Z}},$$

where $\operatorname{SVect}^{\mathbb{Z}}$ denotes the category of $(\mathbb{Z}_2 \times \mathbb{Z})$ -graded vector spaces over \mathbb{C} .

Remark 3.1. Since d is of conformal degree 0, $C^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)$ and $C^{\frac{\infty}{2}+\bullet}_{rel}(\mathfrak{g}, M)$ decompose into direct sums of subcomplexes consisting of finite dimensional objects.

For a finite dimensional \mathfrak{g} -module M, we have an even natural isomorphism

$$\operatorname{Hom}_{\mathbb{C}}(M, \mathbb{C}^{1|0}) \otimes M \xrightarrow{\simeq} \operatorname{End}(M), \quad f \otimes v \mapsto (w \mapsto f(w)v)$$

Let str_M denote the pull-back of id_M under this isomorphism. In particular, when $M = L_\lambda$, we write $\operatorname{str}_M = \operatorname{str}_\lambda$.

Lemma 3.2. For $\lambda, \mu \in P_+$, we have an even isomorphism of vector superspaces $\operatorname{Hom}_{\mathfrak{g}}(\mathbb{C}^{1|0}, L_{\lambda} \otimes L_{\mu}) \simeq \delta_{\lambda,\mu^{\dagger}} \mathbb{C}\operatorname{str}_{\mu}$.

Proof. Immediate from Schur's lemma:

$$\operatorname{Hom}_{\mathfrak{g}}(\mathbb{C}^{1|0}, L_{\lambda} \otimes L_{\mu}) \simeq \operatorname{Hom}_{\mathfrak{g}}(L_{\lambda^{\dagger}}, L_{\mu}) \simeq \delta_{\lambda^{\dagger}, \mu} \mathbb{C} \mathrm{id}_{L_{\mu}}.$$

The following property, proven in [CFL, FGZ] for simple Lie algebras, is called the formality of the relative semi-infinite cohomology.

Theorem 3.3 ([CFL, FGZ]). For $\lambda, \mu \in P_+$,

$$H_{\mathrm{rel}}^{\frac{\infty}{2}+n}\left(\mathfrak{g},\mathbb{V}_{\lambda}^{\kappa_{1}}\otimes\mathbb{V}_{\mu}^{\kappa_{2}}\right)\simeq\delta_{n,0}\delta_{\lambda,\mu^{\dagger}}\mathbb{C}[\mathrm{str}_{\mu}]$$

holds for (κ_1, κ_2) such that $\kappa_1 + \kappa_2 = -\kappa_g$ and the restriction of κ_i to the semisimple part of \mathfrak{g}_i is a irrational level and to the abelian part is nonzero.

See [CGNS, Proposition 6.1] for a short proof in the abelian case. In Appendix A, we give a detailed proof when \mathfrak{g} is simple, especially $\mathfrak{osp}_{1|2n}$, following [FGZ].

Remark 3.4. By the restriction (3.1), Theorem 3.3 also holds for Wakimoto modules \mathbb{W}^k_{λ} [FF1, Fr]:

$$H^{\frac{\infty}{2}+n}_{\mathrm{rel}}\left(\mathfrak{g},\mathbb{W}^{k}_{\lambda}\otimes\mathbb{W}^{\ell}_{\mu}\right)\simeq H^{\frac{\infty}{2}+n}_{\mathrm{rel}}\left(\mathfrak{g},\mathbb{W}^{k}_{\lambda}\otimes\mathbb{V}^{\ell}_{\mu}\right)\simeq\delta_{n,0}\delta_{\lambda,\mu^{\dagger}}\mathbb{C}[\mathrm{str}_{\mu}]$$

since $\mathbb{W}^k_{\lambda} \simeq \operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C}K}^{\widehat{\mathfrak{g}}_k} M^{\vee}_{\lambda}$ for $k \in \mathbb{C} \setminus \mathbb{Q}$. Here M^{\vee}_{λ} is the contravariant Verma module of \mathfrak{g} with highest weight λ .

3.2. Bilinear form. Let V be an arbitrary vertex superalgebra and suppose that we have parity-homogeneous elements a_i , ϕ_i (i = 1, 2) of V satisfying the OPEs

$$a_1(z)a_2(w) \sim \frac{\alpha}{(z-w)^N} + \cdots, \quad b_1(z)b_2(w) \sim \frac{\beta}{(z-w)^M} + \cdots,$$

for some $\alpha, \beta \in \mathbb{C}$ and $N, M \geq 0$. Here we mean by "…" the terms of lower order poles with respect to (z - w). Then by using e.g. the λ -bracket formalism [DK], it is straightforward to show the OPE of the fields $Y(a_{i(-1)}b_i, z)$ (i = 1, 2) has the following shape.

Lemma 3.5. We have

$$Y(a_{1(-1)}b_1, z)Y(a_{2(-1)}b_2, w) \sim \frac{(-1)^{\bar{a}_2 b_1} \alpha \beta}{(z-w)^{N+M}} + \cdots .$$
(3.2)

Now, let \mathfrak{g} and κ_i be as in Theorem 3.3 and suppose that we have $\frac{1}{2}\mathbb{Z}$ -graded vertex superalgebras

$$\mathscr{A}_i = \bigoplus_{\lambda \in P_+} \mathscr{C}^i_{\lambda} \otimes \mathbb{V}^{\kappa_i}_{\lambda}(\mathfrak{g}), \quad (i = 1, 2)$$

such that $\mathscr{C}_0^i = \bigoplus_{\Delta \in \frac{1}{2}\mathbb{Z}_{\geq 0}} \mathscr{C}_{0,\Delta}^i$ are $\frac{1}{2}\mathbb{Z}_{\geq 0}$ -graded vertex superalgebras with $\mathscr{C}_{0,0}^i = \mathbb{C}\mathbf{1}$ and \mathscr{C}_{λ}^i are all positive energy representations of \mathscr{C}_0^i with lowest weight subspaces C_{λ}^i . Then Lemma 3.5 implies that we have bilinear forms

$$\langle \cdot | \cdot \rangle^i_{\lambda} \colon \left(\mathsf{C}^i_{\lambda} \otimes L_{\lambda} \right) \otimes \left(\mathsf{C}^i_{\lambda^{\dagger}} \otimes L_{\lambda^{\dagger}} \right) \to \mathbb{C}, \quad (i = 1, 2)$$

which are \mathfrak{g} -invariant and a bilienar form on the relative semi-infinite cohomolgy $H^{\frac{\infty}{2}+0}_{\mathrm{rel}}(\mathfrak{g},\mathscr{A}_1\otimes\mathscr{A}_2)\simeq \bigoplus_{\lambda\in P_+}\mathscr{C}^1_{\lambda}\otimes\mathscr{C}^2_{\lambda^+}$:

$$\langle \cdot | \cdot \rangle_{\lambda} \colon \left(\mathsf{C}^{1}_{\lambda} \otimes \mathsf{C}^{2}_{\lambda^{\dagger}}
ight) \otimes \left(\mathsf{C}^{1}_{\lambda^{\dagger}} \otimes \mathsf{C}^{2}_{\lambda}
ight)
ightarrow \mathbb{C}.$$

Corollary 3.6. If $\langle \cdot | \cdot \rangle_{\lambda}^{i}$ (i = 1, 2) are non-degenerate, then so is $\langle \cdot | \cdot \rangle_{\lambda}$.

Proof. By Theorem 3.3, the bilienar form $\langle \cdot | \cdot \rangle_{\lambda}$ is the restriction to

$$\left(\mathsf{C}^{1}_{\lambda}\otimes[\operatorname{str}_{\lambda}]\otimes\mathsf{C}^{2}_{\lambda^{\dagger}}\right)\otimes\left(\mathsf{C}^{1}_{\lambda^{\dagger}}\otimes[\operatorname{str}_{\lambda^{\dagger}}]\otimes\mathsf{C}^{2}_{\lambda}\right)\to\mathbb{C}$$
(3.3)

of the bilinear form on the complex

$$\langle \cdot | \cdot \rangle^{1}_{\lambda} \otimes \langle \cdot | \cdot \rangle^{2}_{\lambda^{\dagger}} \colon \left(\mathsf{C}^{1}_{\lambda} \otimes L_{\lambda} \otimes L_{\lambda^{\dagger}} \otimes \mathsf{C}^{2}_{\lambda^{\dagger}} \right) \otimes \left(\mathsf{C}^{1}_{\lambda^{\dagger}} \otimes L_{\lambda} \otimes \mathsf{C}^{2}_{\lambda} \right) \to \mathbb{C}$$

$$(3.4)$$

by Lemma 3.5. Note that (3.4) is a $(\mathfrak{g}, \mathfrak{g})$ -invariant bilinear form and that the restriction (3.3) is exactly to the diagonal \mathfrak{g} -invariant subspace. Since \mathfrak{g} -invariant bilinear forms $L_{\mu} \otimes L_{\nu} \to \mathbb{C}$ is zero unless $\mu = \nu^{\dagger}$, the non-degeneracy of (3.4) implies that of (3.3).

4. Duality in hook-type W-superalgebras

4.1. Hook-type W-superalgebras. Let \mathfrak{g} and κ be as in §2.1, $f \in \mathfrak{g}_0$ a nilpotent element, and $\Gamma : \mathfrak{g} = \bigoplus_{j \in \frac{1}{2}\mathbb{Z}} \mathfrak{g}_j$ a $\frac{1}{2}\mathbb{Z}$ -grading on \mathfrak{g} good for f. Then one can define the W-superalgebra $W^{\kappa}(\mathfrak{g}, f; \Gamma)$ associated with \mathfrak{g}, f, κ and Γ via the (generalized) Drinfeld-Sokolov reduction from $V^{\kappa}(\mathfrak{g})$, [FF2, KRW].

Hook-type W-superalgebras [CL1, CL2] are W-superalgebras such that f is principal inside an subalgebra \mathfrak{a} whose centralizer $\mathfrak{b} = \mathfrak{z}_{\mathfrak{a}}(\mathfrak{g})$ satisfies the following property: \mathfrak{g} decomposes as a $\mathfrak{a} \oplus \mathfrak{b}$ -module into

$$\mathfrak{g} \simeq \begin{cases} (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}}^{\dagger} \oplus \rho_{\mathfrak{a}}^{\dagger} \otimes \rho_{\mathfrak{b}} & \text{if } \mathfrak{g} = \mathfrak{sl}_{n|m}, \\ (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}} & \text{if } \mathfrak{g} = \mathfrak{osp}_{n|2m} \end{cases}$$

In this paper, we consider hook-type \mathcal{W} -superalgebras listed in Table 4 below. The \mathcal{W} -superalgebra $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ contains $V^{k_{\mathfrak{b}}}(\mathfrak{b})$ as the maximal affine vertex subalgebra. We denote its coset algebra by

$$C_{X^{\pm}}^{k}(n,m) = \operatorname{Com}\left(V^{k_{\mathfrak{b}}}(\mathfrak{b}), \mathcal{W}_{X^{\pm}}^{k}(n,m)\right)$$

For X = B (resp. D, O), the W-superalgebra $\mathcal{W}_{X^{\pm}}^{k}(n, m)$ has an automorphism group O_{2m+1} (resp. O_{2m} , $OSp_{1|2m}$), which is induced by their adjoint action on \mathfrak{g} . They give rise to an automorphism group $\mathbb{Z}_{2} \simeq O_{2m+1}/SO_{2m+1}$ (resp. $O_{2m}/SO_{2m}, OSp_{1|2m}/SOSp_{1|2m}$) on $C_{X^{\pm}}^{k}(n,m)$. We set

$$D_{X^{\pm}}^{k}(n,m) = \begin{cases} C_{X^{\pm}}^{k}(n,m), & \text{if } X = A, C, \\ C_{X^{\pm}}^{k}(n,m)^{\mathbb{Z}_{2}}, & \text{if } X = B, D, O \end{cases}$$

Then $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ satisfies the following properties:

(P1) It has a free strong generating set of type

$$\begin{cases} \mathcal{W}\left(1^{\dim\mathfrak{b}}, e_1, e_2, \cdots, e_{\mathrm{rank}} \mathfrak{a}, \left(\frac{\dim\rho_{\mathfrak{a}}+1}{2}\right)^{2\dim\rho_{\mathfrak{b}}}\right) & \text{if } X = A, \\ \mathcal{W}\left(1^{\dim\mathfrak{b}}, e_1, e_2, \cdots, e_{\mathrm{rank}} \mathfrak{a}, \left(\frac{\dim\rho_{\mathfrak{a}}+1}{2}\right)^{\dim\rho_{\mathfrak{b}}}\right) & \text{if } X = B, C, D, O. \end{cases}$$

The first dim \mathfrak{b} elements of conformal dimension $\Delta = 1$ correspond to a basis of \mathfrak{b} and generate $V_{k_{\mathfrak{b}}^{\pm}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$. The second set which we denote by $S_{\text{coset}} = \{W_{X^{\pm}}^{i} \mid i = e_{1}, e_{2}, \cdots, e_{\text{rank }\mathfrak{a}}\}$ are all even and have conformal weights $\Delta = e_{1}, e_{2}, \cdots, e_{\text{rank }\mathfrak{a}}$, which are exponents of \mathfrak{a} shifted by one. They form a strong generating set of $C_{X^{\pm}}^{k}(n,m)$ and $W_{X^{\pm}}^{2}$ is the conformal vector of $C_{X^{\pm}}^{k}(n,m)$. The third set which we denote $S_{\text{nat}} \sqcup S_{\text{nat}}^{\dagger}$ (resp. S_{nat}) if X = A (resp. if X = B, C, D, O), corresponds to a standard basis of $\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}$ (resp. $\rho_{\mathfrak{b}}$). They span a vector subspace $V_{\text{nat}} \oplus V_{\text{nat}}^{\dagger} = \mathbb{C}S_{\text{nat}} \oplus \mathbb{C}S_{\text{nat}}^{\dagger}$ (resp. $V_{\text{nat}} = \mathbb{C}S_{\text{nat}}$) whose parity and conformal weight Δ_{ρ} are as in Table 5 and generate Weyl modules $\mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b}) \oplus \mathbb{V}_{\rho_{\mathfrak{b}}^{\dagger}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$.

(P2) For $k \in \mathbb{C} \setminus \mathbb{Q}$, we may normalize the elements of $S_{nat} \sqcup S_{nat}^{\dagger}$ (resp. S_{nat}) so that the bilinear form

$$V_{\mathsf{nat}} \otimes V_{\mathsf{nat}} \to \mathbb{C}, \quad (a,b) \mapsto a_{(2\Delta_a-1)}b$$

coincides with the natural $\mathfrak b\text{-invariant}$ bilinear form

$$\begin{cases} \langle \cdot | \cdot \rangle \colon (\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}) \otimes (\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}) \to \mathbb{C} & \text{if } X = A, \\ \langle \cdot | \cdot \rangle \colon \rho_{\mathfrak{b}} \otimes \rho_{\mathfrak{b}} \to \mathbb{C} & \text{if } X = B, C, D, O. \end{cases}$$

Then the elements in $S_{nat} \sqcup S_{nat}^{\dagger}$ (resp. S_{nat}) satisfy the OPEs of the form

$$A(z)B(w) \sim \frac{\langle A|B\rangle}{(z-w)^{2\Delta_{\rho}}} + \cdots$$

Theorem 4.1 ([CL1, CL2]). If $k \in \mathbb{C} \setminus \mathbb{Q}$, then the vertex superalgebra $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ is the unique vertex superalgebra extension of $D_{X^{\pm}}^{k}(n,m) \otimes V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$ satisfying the properties (P1) and (P2).

The proof in *loc. cit* ([CL1, Theorem 9.1] for X = A and [CL2, Theorem 6.3] for X = B, C, D, O) only uses (P2) together with the following property which is implied by (P1):

$$\begin{split} \mathcal{W}_{X^{\pm}}^{k}(n,m) \text{ is an extension of } D_{X^{\pm}}^{k}(n,m) \otimes V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b}) \text{ by modules} \\ \begin{cases} M_{A^{\pm}}^{+} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b}) \oplus M_{A^{\pm}}^{-} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}^{\dagger}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b}) & \text{if } X = A, \\ M_{X^{\pm}} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b}) & \text{if } X = B, C, D, O, \end{cases} \end{split}$$

whose lowest conformal weight subspace coincides with V_{nat} of the same parity and conformal weight as in Table 5. Moreover, the lower conformal weight subspaces

$$\bigoplus_{i=0}^{\operatorname{frank}} M_{A^{\pm},\Delta_{\rho}+i}^{\pm}, \quad \bigoplus_{i=0}^{e_{\operatorname{rank}}} M_{X^{\pm},\Delta_{\rho}+i}$$

(X = B, C, D, O) has a PBW basis in terms of $W^2_{X^{\pm}(-n)}, W^i_{X^{\pm}(-n-1)}$, for $n \ge 0$ and $i = e_2, e_3, \cdots, e_{\text{rank }\mathfrak{a}}$.

Suppose $k \in \mathbb{C} \setminus \mathbb{Q}$. Since $\mathbf{KL}_{k_{\mathfrak{h}}^{\pm}}(\mathfrak{b})$ is semisimple, $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ decomposes into

$$\mathcal{W}_{X^{\pm}}^{k}(n,m) \simeq \bigoplus_{\lambda \in P_{+}} \mathcal{C}_{X^{\pm}}^{k}(\lambda) \otimes \mathbb{V}_{\lambda}^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$$

$$(4.1)$$

as $C_{X^{\pm}}^{k}(n,m) \otimes V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$ -modules. Here $\mathcal{C}_{X^{\pm}}^{k}(\lambda)$ is the $C_{X^{\pm}}^{k}(n,m)$ -module consisting of highest weight vectors of $V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{b})$ of highest weight λ appearing in $\mathcal{W}_{X^{\pm}}^{k}(n,m)$. It follows from (P1) and the character computation that

$$\{\lambda \in P_+ \mid \mathfrak{C}_{X^+}^{\lambda} \neq 0\} = \{\lambda \in P_+ \mid \mathfrak{C}_{X^-}^{\lambda} \neq 0\} = R,\tag{4.2}$$

see [CL1, Theorem 4.11, Remark 4.1] for a proof in the case X = A which holds also for X = B, C, D, O. In the case X = A, we use the decomposition

$$V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{gl}_{m})\simeq V^{k_{\mathfrak{b}}^{\pm}}(\mathfrak{sl}_{m})\otimes\pi^{\pm}$$

where π^{\pm} is the Heisenberg vertex algebra generated by a field $h^{\pm}(z)$ which corresponds to Id in the decomposition $\mathfrak{gl}_m = \mathfrak{sl}_m \oplus \mathbb{C}$ Id. It satisfies the OPE

$$h^{+}(z)h^{+}(w) \sim \frac{-m + \frac{mn}{n+m}(k+h_{A^{+}}^{\vee})}{(z-w)^{2}}, \quad h^{-}(z)h^{-}(w) \sim \frac{m - \frac{m(n+m)}{n}(k+h_{A^{-}}^{\vee})}{(z-w)^{2}},$$

respectively.

Proposition 4.2. If \mathfrak{g} is a Lie algebra (resp. Lie superalgebra), then (1) ([CL1, Theorem 3.6]) $\mathcal{W}_{X^{\pm}}^{k}(n,m)$ is simple for all (resp. generic) $k \in \mathbb{C} \setminus \mathbb{Q}$. (2) The coset $C_{X^{\pm}}^{k}(n,m)$ is simple for all (resp. generic) $k \in \mathbb{C} \setminus \mathbb{Q}$. (3) ([CL1, Theorem 4.11]) The multiplicity space $\mathcal{C}_{X^{\pm}}^{k}(\lambda)$, $(\lambda \in \mathbb{R})$, is simple as a $C_{X^{\pm}}^{k}(n,m)$ -module for generic $k \in \mathbb{C} \setminus \mathbb{Q}$.

We note that the second statement (2) follows from (1) by [CGN, Proposition 5.4].

4.2. Duality in $\mathcal{W}_{X\pm}^k(n,m)$. Let (X,Y) denote one of the pairs

 $(A,A), \quad (B,O), \quad (C,C), \quad (D,D), \quad (O,B).$

The following statement, which naturally generalizes Feigin-Frenkel duality in the above types, was conjectured by Gaiotto–Rapčák [GR] in the physics literature and proven by two of the authors for generic levels.

Theorem 4.3 ([CL1, CL2]).

For generic $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$, there is an isomorphism of vertex algebras

$$D_{X^+}^k(n,m) \simeq D_{Y^-}^\ell(n,m),$$
(4.3)

if (k, ℓ) satisfies the relation

$$r_X(k+h_{X^+}^{\vee})(\ell+h_{Y^-}^{\vee}) = 1 \tag{4.4}$$

with r_X given in Table 6. Moreover, if $X^+ = A^+$, B^+ , C^+ , D^+ , then (4.3) holds for all $k \in \mathbb{C} \setminus \mathbb{Q}$.

Proof. Since the second statement is essentially obtained in the proof of [CL1, CL2] for generic case, we only sketch the proof. By the same proof in *loc. cit*, $D_{X^+}^k(n,m)$ and $D_{Y^-}^\ell(n,m)$ are quotients of the two-parameter \mathcal{W}_{∞} -algebra $\mathcal{W}(c,\lambda)$ constructed in [L] (resp. even spin \mathcal{W}_{∞} -algebra $\mathcal{W}^{\text{ev}}(c,\lambda)$ in [KL]) if X = A (resp. X = B, C, D, O) with the same specialization for (c,λ) . Then it follows that the simple quotients of $D_{X^+}^k(n,m)$ and $D_{Y^-}^\ell(n,m)$ are isomorphic as vertex algebras. On the other hand, by Proposition 4.2 (2), $C_{X^+}^k(n,m)$ is simple as a vertex algebra and thus so is $D_{X^+}^k(n,m)$ by [DLM]. Therefore, we have a surjective homomorphism $D_{Y^-}^\ell(n,m) \to D_{X^+}^k(n,m)$ of vertex algebras, which is an isomorphism for generic $k \in \mathbb{C}\setminus\mathbb{Q}$. Since their q-characters are the same for all $k, \ell \in \mathbb{C}\setminus\mathbb{Q}, D_{Y^-}^\ell(n,m) \xrightarrow{\simeq} D_{X^+}^k(n,m)$ holds for all $k \in \mathbb{C}\setminus\mathbb{Q}$.

In the remainder of this subsection, the statements for type X = B, O with m > 1 are understood under the assumption of the existence of $A^{\pm 1}[\mathfrak{so}_{2m+1}, k] = A^{\pm 1}[\mathfrak{osp}_{1|2m}, \ell]$. The main results of this paper is the following theorem conjectured by two of the authors [CL1, CL2]:

Theorem 4.4. For $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$ under (4.4), there exist isomorphisms of vertex superalgebras

$$\mathcal{W}_{Y^{-}}^{\ell}(n,m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n,m) \otimes A^{1}[\mathfrak{b},\alpha_{+}]\right),\tag{4.5}$$

$$\mathcal{W}_{X^+}^k(n,m) \simeq H_{\mathrm{rel}}^{\frac{\alpha}{2}+0} \left(\mathfrak{b}, \mathcal{W}_{Y^-}^\ell(n,m) \otimes A^{-1}[\mathfrak{b},\alpha_-]\right), \tag{4.6}$$

where (α_+, α_-) are given by

$$\alpha_{+} = -p_{\scriptscriptstyle +}(k + h_{X^{+}}^{\vee}) + q_{\scriptscriptstyle +} - h_{\mathfrak{b}}^{\vee}, \quad \alpha_{-} = p_{\scriptscriptstyle -}(\ell + h_{Y^{-}}^{\vee}) - q_{\scriptscriptstyle -} - h_{\mathfrak{b}}^{\vee}$$

with (p_{\pm}, q_{\pm}) as in Table 7 below.

We will give a proof of Theorem 4.4 in §4.3. By taking the affine cosets of both hand sides (4.5), we obtain the following improvement of Theorem 4.3:

Corollary 4.5. For $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$ under (4.4), there exists an isomorphism of vertex algebras

$$C_{X^+}^k(n,m) \simeq C_{Y^-}^\ell(n,m).$$

Actually, this corollary will be obtained in the proof of Theorem 4.4.

Corollary 4.6. For $Y = A, C, D, O, W_{Y^{-}}^{\ell}(n, m)$ is simple for all $\ell \in \mathbb{C} \setminus \mathbb{Q}$.

Proof. Take a nonzero ideal \mathscr{I} of $\mathcal{W}_{Y^-}^{\ell}(n,m)$. Since $\mathbf{KL}_{\ell^-}(\mathfrak{b})$ is semisimple, \mathscr{I} decomposes into

$$\mathscr{I} = \bigoplus_{\lambda \in R} \mathscr{I}_{\lambda} \otimes \mathbb{V}_{\lambda}^{\ell_{\mathfrak{b}}^{-}}(\mathfrak{b})$$

under (4.1) for some $C_{Y^-}^{\ell}(n,m)$ -submodules $\mathscr{I}_{\lambda} \subset C_{Y^-}^{\ell}(\lambda)$. Applying the functor $H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(\mathfrak{b},?\otimes A^{-1}[\mathfrak{b},\alpha_{-}])$, we obtain a nonzero ideal

$$\mathscr{J} = H_{\mathrm{rel}}^{\frac{\infty}{2}+0} \left(\mathfrak{b}, \mathscr{I} \otimes A^{-1}[\mathfrak{b}, \alpha_{-}] \right) \simeq \bigoplus_{\lambda \in R} \mathscr{I}_{\lambda} \otimes \mathbb{V}_{\lambda}^{k_{\mathfrak{b}}^{+}}(\mathfrak{b})$$

of $\mathcal{W}_{X^+}^k(n,m)$ by Theorem 4.4. It follows from Proposition 4.2 (1) that $\mathscr{J} = \mathcal{W}_{X^+}^k(n,m)$ and thus $\mathscr{I} = \mathcal{W}_{Y^-}^\ell(n,m)$.

4.3. **Proof of Theorem 4.4.** It is immediate from the equality

$$k_{\mathfrak{b}}^{+} + \alpha_{+} = -2h_{\mathfrak{b}}^{\vee} = \ell_{\mathfrak{b}}^{-} + \alpha_{-}$$

that we may apply $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{b},\cdot)$ in the right-hand side of (4.5) and (4.6) except for $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{gl}_1,\cdot)$ appearing in $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{gl}_m,\cdot)$. The case $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{gl}_1,\cdot)$ follows from the isomorphism of Heisenberg vertex algebras

$$\begin{array}{rcl} \pi^{\sqrt{-1}h^{\pm}} \otimes \pi^{h^{\mp}} &\simeq & \pi^{\alpha}\sqrt{\pm m} \otimes \pi^{\alpha}\sqrt{\pm m} \\ \sqrt{-1}h^{\pm}(z) \otimes 1 &\mapsto & \alpha_{\sqrt{\pm m}}(z) \otimes 1 \mp u^{\pm} \otimes \alpha_{\sqrt{\pm m}}(z) \\ 1 \otimes h^{\mp}(z) &\mapsto & -\alpha_{\sqrt{\pm m}}(z) \otimes 1 \mp u^{\mp} \otimes \alpha_{\sqrt{\pm m}}(z), \end{array}$$

where $u = \sqrt{\frac{-n}{m+n}(k+h_{A^+}^{\vee})}$ and thus $u^{-1} = \sqrt{\frac{m+n}{-n}(\ell+h_{A^-}^{\vee})}$. Here $\alpha_{\sqrt{\pm m}}(z)$ is the Heisenberg field satisfying the OPE $\alpha_{\sqrt{\pm m}}(z)\alpha_{\sqrt{\pm m}}(w) \sim \pm m/(z-w)^2$. It induces the isomorphisms of their Fock modules

$$\pi_a^{\alpha_{\sqrt{\pm m}}} \otimes \pi^{\alpha_{\sqrt{\pm m}}} \simeq \pi_a^{\sqrt{-1}h^{\pm}} \otimes \pi_{-a}^{h^{\mp}}, \quad (a \in \mathbb{C}).$$

By using Theorem 3.3, we obtain, case by case, isomorphisms

$$\begin{split} H^{\frac{\infty}{2}+0}_{\mathrm{rel}}\left(\mathfrak{b}, \mathcal{W}^{k}_{X^{+}}(n,m) \otimes A^{1}[\mathfrak{b},\alpha_{+}]\right) &\simeq \bigoplus_{\lambda \in R} \mathcal{C}^{k}_{X^{+}}(\lambda) \otimes \mathbb{V}^{\ell^{-}_{s,\mathfrak{b}}}_{s,\lambda}({}^{s}\mathfrak{b}), \\ H^{\frac{\infty}{2}+0}_{\mathrm{rel}}\left(\mathfrak{b}, \mathcal{W}^{\ell}_{Y^{-}}(n,m) \otimes A^{-1}[\mathfrak{b},\alpha_{-}]\right) &\simeq \bigoplus_{\lambda \in R} \mathcal{C}^{\ell}_{Y^{-}}(\lambda) \otimes \mathbb{V}^{k^{+}_{s,\mathfrak{b}}}_{s,\lambda}({}^{s}\mathfrak{b}), \end{split}$$

as modules of $C_{X^+}^k(n,m) \otimes V^{\ell_s^-}({}^s\mathfrak{b})$ (resp. $C_{Y^-}^k(n,m) \otimes V^{k_s^+}({}^s\mathfrak{b})$) and thus as modules of the subalgebra $D_{Y^-}^\ell(n,m) \otimes V^{\ell_b^-}(\mathfrak{b}) \subset \mathcal{W}_{Y^-}^\ell(n,m)$ (resp. $D_{X^+}^k(n,m) \otimes V^{k_b^+}(\mathfrak{b}) \subset \mathcal{W}_{X^+}^k(n,m)$) by Theorem 4.3.

Finally, we apply Theorem 4.1 to complete the proof. By Theorem 3.3, we may associate with $A \in \rho_{sb}$ or ρ_{sb}^{\dagger} the following (nonzero) cohomology class

$$\left[\operatorname{str}_{\rho_{\mathfrak{b}}}\otimes A\right], \quad \left[\operatorname{str}_{\rho_{\mathfrak{b}}^{\dagger}}\otimes A\right],$$

respectively. Let \widehat{A} denote the above cohomology class. By using Table 3 and 5, we find case by case that the parity and conformal dimension of \widehat{A} agree with those of S_{nat} and S_{nat}^{\dagger} for $\mathcal{W}_{Y^-}^{\ell}(n,m)$ and $\mathcal{W}_{X^+}^{k}(n,m)$, respectively. Then it follows from Corollary 3.6 that the pairing for the cohomology classes \widehat{A} , $(A \in \rho_{sb}, \rho_{sb}^{\dagger})$, is non-degenerate by Theorem 4.1 and Lemma 2.3.

We first complete the proof of (4.6). Since $m \ge 0$, the PBW basis property implied by (P1) for $\mathcal{W}_{Y^-}^{\ell}(n,m)$ implies that of $H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(\mathfrak{b}, \mathcal{W}_{Y^-}^{\ell}(n,m) \otimes A^{-1}[\mathfrak{b}, \alpha_-])$. Then by Theorem 4.1, we have a nonzero homomorphism of vertex superalgebras

$$\mathcal{W}_{X^+}^k(n,m) \to H^{\frac{\infty}{2}+0}_{\mathrm{rel}}\left(\mathfrak{b}, \mathcal{W}_{Y^-}^\ell(n,m) \otimes A^{-1}[\mathfrak{b},\alpha_-]\right).$$

$$(4.7)$$

By Proposition 4.2 (1), it is injective and thus $\mathcal{C}_{X^+}^k(\lambda) \hookrightarrow \mathcal{C}_{Y^-}^\ell({}^s\lambda)$ as $D_{X^+}^k(n,m)$ -submodules for all $\lambda \in R$. In particular, we have $C_{X^+}^k(n,m) \hookrightarrow C_{Y^-}^\ell(n,m)$. In the case X = A, C, this is indeed an isomorphism by Theorem 4.3. In the case X = B, C, O, these coset algebras are second order extensions of the same algebra $D_{X^+}^k(n,m) \simeq D_{Y^-}^\ell(n,m)$ by Theorem 4.3 and therefore $C_{X^+}^k(n,m) \simeq C_{Y^-}^\ell(n,m)$ as well. Now, if $k \in \mathbb{C} \setminus \mathbb{Q}$ is generic, then it follows from Proposition 4.2 (3) that $\mathcal{C}_{X^+}^k(\lambda) \hookrightarrow \mathcal{C}_{Y^-}^\ell({}^s\lambda)$ is indeed an isomorphism of $C_{X^+}^k(n,m)$ -modules. Hence, the q-characters of $\mathcal{C}_{X^+}^k(\lambda)$ and $\mathcal{C}_{Y^-}^\ell({}^s\lambda)$ coincide. Since the q-characters are all equal for $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$, $\mathcal{C}_{X^+}^k(\lambda) \simeq \mathcal{C}_{Y^-}^\ell({}^s\lambda)$ holds for all $k \in \mathbb{C} \setminus \mathbb{Q}$. Therefore, (4.7) is an isomorphism of vertex algebras for all $k \in \mathbb{C} \setminus \mathbb{Q}$. This completes the proof of (4.6). In particular, it follows that $\mathcal{C}_{X^+}^k(\rho_b)$ (and $\mathcal{C}_{X^+}^k(\rho_b^{\dagger})$ for X = A) has the PBW basis property implied by (P1) as a $D_{Y^-}^\ell(n,m)$ -module. Then we may apply Theorem 4.1 and obtain a (nonzero) homomorphism of

$$\mathcal{W}_{Y^{-}}^{\ell}(n,m) \to H^{\frac{\infty}{2}+0}_{\mathrm{rel}}\left(\mathfrak{b}, \mathcal{W}^{k}_{X^{+}}(n,m) \otimes A^{1}[\mathfrak{b},\alpha_{+}]\right),$$

vertex superalgebras. It follows from (4.6) and Theorem 3.3 that it is an isomorphism as $D_{Y^-}^{\ell}(n,m) \otimes V^{\ell_{\mathfrak{b}}^-}(\mathfrak{b})$ modules and thus as vertex superalgebras. This completes the proof of (4.5).

APPENDIX A. PROOF OF THEOREM 3.3

In this appendix, we prove Theorem 3.3 when \mathfrak{g} is simple. We set $\kappa_1 = k\kappa_0$, $\kappa_2 = \ell\kappa_0$ by using the normalized invariant bilinear form κ_0 and thus $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$. We will use the decompositions of the loop algebra $L\mathfrak{g} = \mathfrak{g}[t^{\pm 1}] = L^+\mathfrak{g} \oplus \mathfrak{g}[t^{-1}] = \mathfrak{g}[t] \oplus L^-\mathfrak{g}$ with $L^{\pm}\mathfrak{g} = \mathfrak{g}[t^{\pm 1}]t^{\pm 1}$.

A.1. Spectral sequences. In order to prove Theorem 3.3, we consider spectral sequences in general setting. Given an object $M = \bigoplus_{\Delta \in \mathbb{Z}} M_{\Delta}$ in $\mathbf{KL}_{-2h^{\vee}}$, let us write $\mathscr{C}^{\bullet}(M) = C^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)$ (resp. $\mathscr{C}^{\bullet}_{\mathrm{rel}}(M) = C^{\frac{\infty}{2}+\bullet}_{\mathrm{rel}}(\mathfrak{g}, M)$) and introduce on it a filtration $F_{\bullet}\mathscr{C}^{\bullet}(M)$ in the following way: we define a grading $\mathscr{C}^{\bullet}(M) = \bigoplus_{\Delta_F \in \mathbb{Z}} \mathscr{C}^{\bullet}_{\Delta_F}(M)$ by setting

$$\Delta_F(X_n) = n, \quad \Delta_F(\varphi_{i,n}) = |n|, \quad \Delta_F(\varphi_{i,n}^*) = -|n|, \quad \Delta_F|_{M_\Delta} = -\Delta$$
(A.1)

and then

$$F_p \mathscr{C}^{\bullet}(M) = \bigoplus_{\Delta_F \leq -p} \mathscr{C}^{\bullet}_{\Delta_F}(M), \quad (p \in \mathbb{Z}).$$

The filtration $F_{\bullet}\mathscr{C}^{\bullet}(M)$ is decreasing, exhausitive and separated, i.e. satisfies $F_p\mathscr{C}^{\bullet}(M) \supset F_{p+1}\mathscr{C}^{\bullet}(M)$, $\cup_p F_p\mathscr{C}^{\bullet}(M) = \mathscr{C}^{\bullet}(M)$ and $\cap_p F_p\mathscr{C}^{\bullet}(M) = 0$, respectively. Since the differential d preserves the filtration $d: F_p\mathscr{C}^{\bullet}(M) \to F_p\mathscr{C}^{\bullet}(M)$, we have the associated spectral sequence

$$E_1^F = H^{\bullet}(\operatorname{gr}_F \mathscr{C}^{\bullet}(M), \operatorname{gr}_F d) \Rightarrow E_{\infty}^F = \operatorname{gr}_F H^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, M).$$
(A.2)

Note that by Remark 3.1, the spectral sequence converges. The induced differential decomposes into $\operatorname{gr}_F d = d_1^F + d_2^F$ with

$$d_{1}^{F} = \sum_{n \ge 0} (-1)^{\bar{x}_{i}} x_{i(n)} \varphi_{i,-n}^{*} - \frac{1}{2} \sum_{p,q \ge 0} (-1)^{\bar{x}_{i}\bar{x}_{k}} c_{i,j}^{k} \varphi_{i,-p}^{*} \varphi_{j,-q}^{*} \frac{\partial}{\partial \varphi_{k,-p-q}^{*}},$$

$$d_{2}^{F} = -\frac{1}{2} \sum_{p,q > 0} (-1)^{\bar{x}_{i}\bar{x}_{k} + \bar{x}_{i} + \bar{x}_{j}} c_{i,j}^{k} \varphi_{k,-p-q} \frac{\partial}{\partial \varphi_{i,-p}} \frac{\partial}{\partial \varphi_{j,-q}}.$$
(A.3)

Then it follows that the complex $(\operatorname{gr}_F \mathscr{C}^{\bullet}(M), \operatorname{gr}_F d)$ decomposes into the tensor product

$$(\operatorname{gr}_F \mathscr{C}^{\bullet}(M), \operatorname{gr}_F d) \simeq \left(M \otimes \bigwedge_{\partial^n \varphi_i^*}, d_1^F \right) \otimes \left(\mathbb{C} \otimes \bigwedge_{\partial^n \varphi_i}, d_2^F \right)$$

and that the first component in the right-hand side is nothing but the Chevalley–Eilenberg cochain complex of $\mathfrak{g}[t]$ with coefficients in M and the second component the chain complex of $\mathcal{L}^-\mathfrak{g}$ with coefficients in \mathbb{C} . Therefore, $E_1^F \simeq H^{\bullet}(\mathfrak{g}[t], M) \otimes H_{\bullet}(\mathcal{L}^-\mathfrak{g}, \mathbb{C})$.

By restricting $F_{\bullet}\mathscr{C}^{\bullet}(M)$ to $\mathscr{C}^{\bullet}_{rel}(M)$, namely, $F_p\mathscr{C}^{\bullet}_{rel}(M) = \mathscr{C}^{\bullet}_{rel}(M) \cap F_p\mathscr{C}^{\bullet}(M)$, we obtain a similar spectral sequence

$$E_{1,\mathrm{rel}}^F = H^{\bullet}(\operatorname{gr}_F \mathscr{C}^{\bullet}_{\mathrm{rel}}(M), \operatorname{gr}_F d) \Rightarrow E_{\infty,\mathrm{rel}}^F = \operatorname{gr}_F H_{\mathrm{rel}}^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, M)$$

with $\operatorname{gr}_F d = d_{1,\operatorname{rel}}^F + d_2^F$ where

$$d_{1,\text{rel}}^F = \sum_{n>0} (-1)^{\bar{x}_i} x_{i,n} \varphi_{i,-n}^* - \frac{1}{2} \sum_{p,q>0} (-1)^{\bar{x}_i \bar{x}_k} c_{i,j}^k \varphi_{i,-p}^* \varphi_{j,-q}^* \frac{\partial}{\partial \varphi_{k,-p-q}^*}.$$

In this case, we have

$$\begin{split} E_{1,\mathrm{rel}}^{F} &= H^{\bullet} \left(\left(\left(M \otimes \bigwedge_{\partial^{n+1} \varphi_{i}^{*}}, d_{1,\mathrm{rel}}^{F} \right) \otimes \left(\mathbb{C} \otimes \bigwedge_{\partial^{n} \varphi_{i}}, d_{2}^{F} \right) \right)^{\mathfrak{g}} \right) \\ &\simeq H^{\bullet} \left(\left(M \otimes \bigwedge_{\partial^{n+1} \varphi_{i}^{*}}, d_{1,\mathrm{rel}}^{F} \right) \otimes \left(\mathbb{C} \otimes \bigwedge_{\partial^{n} \varphi_{i}}, d_{2}^{F} \right) \right)^{\mathfrak{g}} \\ &= \left(H^{\bullet}(\mathrm{L}^{+}\mathfrak{g}, M) \otimes H_{\bullet}(\mathrm{L}^{-}\mathfrak{g}, \mathbb{C}) \right)^{\mathfrak{g}}. \end{split}$$

Here in the second line, we have used the commutativity of taking cohomology and \mathfrak{g} -invariant subspace, which follows from the complete reducibility of integrable \mathfrak{g} -modules.

Next, we introduce another filtration $G_{\bullet} \mathscr{C}^{\bullet}(M)$ on $\mathscr{C}^{\bullet}(M)$ in the following way: we define a grading Δ_G in the following way: we replace (A.1) with

$$\Delta_G(X_n) = n, \quad \Delta_G(\varphi_{i,n}) = -|n|, \quad \Delta_G(\varphi_{i,n}^*) = |n|, \quad \Delta_G|_{M_\Delta} = -\Delta$$

and set $G_{\bullet} \mathscr{C}^{\bullet}(M)$ by

$$G_p \mathscr{C}^{\bullet}(M) = \bigoplus_{\Delta_G \ge p} \mathscr{C}^{\bullet}_{\Delta_G}(M), \quad (p \in \mathbb{Z}).$$

Again, the filtration $G_{\bullet} \mathscr{C}^{\bullet}(M)$ is decreasing, exhausitive and separated. Since d preserves the filtration, we have the associated spectral sequence

$$E_1^G = H^{\bullet}(\operatorname{gr}_G \mathscr{C}^{\bullet}(M), \operatorname{gr}_G d) \Rightarrow E_{\infty}^G = \operatorname{gr}_G H^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, M)$$

with $\operatorname{gr}_G d = d_1^G + d_2^G$ where

$$d_{1}^{G} = \sum_{n \ge 0} (-1)^{\bar{x}_{i}} x_{i,-n} \varphi_{i,n}^{*} - \frac{1}{2} \sum_{p,q \ge 0} (-1)^{\bar{x}_{i}\bar{x}_{k}} c_{i,j}^{k} : \varphi_{i,p}^{*} \varphi_{j,q}^{*} \varphi_{k,-p-q} :,$$

$$d_{2}^{G} = -\frac{1}{2} \sum_{p,q > 0} (-1)^{\bar{x}_{i}\bar{x}_{k}} c_{i,j}^{k} \varphi_{i,-p}^{*} \varphi_{j,-q}^{*} \frac{\partial}{\partial \varphi_{k,-p-q}^{*}}.$$
(A.4)

In this case, the complex $(\operatorname{gr}_G \mathscr{C}^{\bullet}(M), \operatorname{gr}_G d)$ decomposes into

$$\left(\operatorname{gr}_{G} \mathscr{C}^{\bullet}(M), \operatorname{gr}_{G} d\right) \simeq \left(M \otimes \bigwedge \varphi_{i}^{*}, \partial^{n} \varphi_{i}, d_{1}^{G}\right) \otimes \left(\mathbb{C} \otimes \bigwedge \partial^{n+1} \varphi_{i}^{*}, d_{2}^{G}\right)$$

and the second component in the right-hand side is the cochain complex calculating $H^{\bullet}(L^{+}\mathfrak{g}, \mathbb{C})$. Although the first component lacks a clear meaning, by restricting to

$$\operatorname{gr}_{G}\mathscr{C}^{\bullet}_{\operatorname{rel}}(M) = \left(\left(M \otimes \bigwedge_{\partial^{n+1}\varphi_{i}^{*}} \right) \otimes \left(\mathbb{C} \otimes \bigwedge_{\partial^{n}\varphi_{i}} \right) \right)^{\mathfrak{g}}$$

we find that the induced differential d_1^G acts on the first componet by

$$d_{1,\mathrm{rel}}^G = \sum_{n>0} x_{i,-n} \frac{\partial}{\partial \varphi_{i,-n}} - \frac{1}{2} \sum_{p,q>0} (-1)^{\bar{x}_i \bar{x}_k + \bar{x}_i + \bar{x}_j} c_{i,j}^k \varphi_{k,-p-q} \frac{\partial}{\partial \varphi_{i,-p}} \frac{\partial}{\partial \varphi_{j,-q}}.$$

Thus the first component in the right-hand side is the chain complex calculating $H_{\bullet}(L^{-}\mathfrak{g}, M)$. Therefore, we have obtained a convergent spectral sequence with

$$E_{1,\mathrm{rel}}^G \simeq \left(H_{\bullet}(\mathrm{L}^{-}\mathfrak{g}, M) \otimes H^{\bullet}(\mathrm{L}^{+}\mathfrak{g}, \mathbb{C}) \right)^{\mathfrak{g}}.$$

To summarize, we have obtained the following proposition.

Proposition A.1. For an object M in $\mathbf{KL}_{-2h^{\vee}}$, we have convergent spectral sequences

$$\begin{split} E_{1,\mathrm{rel}}^{F} &\simeq \left(H^{\bullet}(\mathrm{L}^{+}\mathfrak{g}, M) \otimes H_{\bullet}(\mathrm{L}^{-}\mathfrak{g}, \mathbb{C})\right)^{\mathfrak{g}} \Rightarrow E_{\infty}^{F} = \mathrm{gr}_{F} \, H_{\mathrm{rel}}^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, M), \\ E_{1,\mathrm{rel}}^{G} &\simeq \left(H_{\bullet}(\mathrm{L}^{-}\mathfrak{g}, M) \otimes H^{\bullet}(\mathrm{L}^{+}\mathfrak{g}, \mathbb{C})\right)^{\mathfrak{g}} \Rightarrow E_{\infty}^{G} = \mathrm{gr}_{G} \, H_{\mathrm{rel}}^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, M). \end{split}$$

In particular, if $H^n(L^+\mathfrak{g}, M) = 0$, $H_n(L^-\mathfrak{g}, M) = 0$, (n > 0), then $H^{\frac{\infty}{2}+n}_{rel}(\mathfrak{g}, M) = 0$ holds for $n \neq 0$.

A.2. Pairings between cohomology and homology. We make a digression for pairings between Lie superalgebra cohomology and homology

$$H^n(\mathfrak{g}_1, M_1) \otimes H_n(\mathfrak{g}_2, M_2) \to \mathbb{C}$$
 (A.5)

for (different) Lie superalgebras \mathfrak{g}_i and their modules M_i (i = 1, 2) under suitable conditions, which we will use Proposition A.9 below. Let \mathfrak{g} be an arbitrary Lie superalgebra and M a \mathfrak{g} -module. The cochain complex of \mathfrak{g} with coefficients in M is defined as

$$C^{\bullet}(\mathfrak{g}, M) = \bigoplus_{n \in \mathbb{Z}_{\geq 0}} C^{n}(\mathfrak{g}, M), \quad C^{n}(\mathfrak{g}, M) = \operatorname{Hom}_{\mathbb{C}}(\operatorname{Sym}^{n}(\Pi \mathfrak{g}), M),$$

equipped with $d_n \colon C^n(\mathfrak{g}, M) \to C^{n+1}(\mathfrak{g}, M)$ given by

$$d_n f(x_1 x_2 \cdots x_{n+1}) = \sum_{1 \le i \le n+1} (-1)^{A_i} x_i f(x_1 \cdots \hat{x}_i \cdots x_{n+1}) + \sum_{1 \le i < j \le n+1} (-1)^{A_{i,j}} f([x_i, x_j] x_1 \cdots \hat{x}_i \cdots \hat{x}_j \cdots x_{n+1}),$$

where

$$A_{i} = \bar{x}_{i} + (f + k_{i-1})(\bar{x}_{i} + 1),$$

$$A_{i,j} = \bar{f} + (k_{i-1} + 1)(\bar{x}_{i} + 1) + (k_{j-1} + \bar{x}_{i} + 1)(\bar{x}_{j} + 1),$$

with $k_i = \overline{x}_1 + \cdots + \overline{x}_i + i$. Similarly, the chain complex of \mathfrak{g} with coefficients in M is defined as

$$C_{\bullet}(\mathfrak{g}, M) = \bigoplus_{n \in \mathbb{Z}_{\geq 0}} C_n(\mathfrak{g}, M), \quad C_n(\mathfrak{g}, M) = M \otimes \operatorname{Sym}(\Pi \mathfrak{g}),$$

equipped with $\partial_n \colon C_n(\mathfrak{g}; M) \to C_{n-1}(\mathfrak{g}; M)$ given by

$$\partial_n(\alpha \otimes x_1 x_2 \cdots x_n) = \sum_{1 \le i \le n} (-1)^{B_i}(x_i \alpha) \otimes x_1 \cdots \hat{x}_i \cdots x_n + \sum_{1 \le i < j \le n} (-1)^{B_{i,j}} \alpha \otimes [x_i, x_j] x_1 \cdots \hat{x}_i \cdots \hat{x}_j \cdots x_n$$

where

$$B_i = (\bar{\alpha} + k_{i-1})(\bar{x}_i + 1),$$

$$B_{i,j} = 1 + \bar{\alpha} + (k_{i-1} + 1)(\bar{x}_i + 1) + (k_{j-1} + \bar{x}_i + 1)(\bar{x}_j + 1)$$

Remark A.2. The identification of the cochain (resp. chain) complex given above and the one in the vertex algebraic formulation appearing in $\S{A.1}$ is as follows:

$$\begin{array}{rcl}
 M \otimes \wedge_{\varphi_i} & \xrightarrow{\simeq} & \operatorname{Hom}_{\mathbb{C}}(\operatorname{Sym}(\Pi \mathfrak{g}), M) \\
 m \otimes \varphi_{i_1} \cdots \varphi_{i_n} & \mapsto & \left[x_{j_1} \cdots x_{j_n} \mapsto \sum_{\sigma \in S_n} (-1)^{\bullet} \delta_{(i_1, \cdots i_n), (j_1, \cdots, j_n)} m \right], \\
 M \otimes \wedge_{\varphi_i} & \xrightarrow{\simeq} & M \otimes \operatorname{Sym}(\Pi \mathfrak{g}) \\
 m \otimes \varphi_{i_1} \cdots \varphi_{i_n} & \mapsto & m \otimes x_{i_1} \cdots x_{i_n}.
\end{array}$$

Here S_n is the n-th symmetric group and the sign $(-1)^{\bullet}$ is assigned as

$$\varphi_{i_1}\varphi_{i_2}\colon x_{j_1}x_{j_2}\mapsto \delta_{i_2,j_1}\delta_{i_1,j_2}+(-1)^{(\bar{x}_{i_2}+1)(\bar{x}_{j_1}+1)}\delta_{i_1,j_1}\delta_{i_2,j_2}.$$

Given even linear maps

$${}^t\colon \mathfrak{g}_2\to \mathfrak{g}_1, \quad \Psi\colon M_1\otimes M_2\to \mathbb{C},$$

we may extend the pairing Ψ to the even pairing Ψ_{\bullet} on the whole complex by

$$\begin{array}{rcl} \Psi_n \colon & C^n(\mathfrak{g}_1, M_1) \otimes C_n(\mathfrak{g}_2, M_2) & \to & \mathbb{C} \\ & & f \otimes (\alpha \otimes x_1 \cdots x_n) & \mapsto & (-1)^{\bar{x}_1 + \cdots \bar{x}_n} \Psi\left(f\left({}^t x_n \cdots {}^t x_1\right) \otimes \alpha\right). \end{array}$$

Lemma A.3. If Ψ_{\bullet} satisfies

$$\Psi_{n+1}(d_n f \otimes P) = \Psi_n(f \otimes \partial_{n+1} P), \tag{A.6}$$

then Ψ induces an even pairing $[\Psi_{\bullet}]$: $H^{\bullet}(\mathfrak{g}_1, M_1) \otimes H_{\bullet}(\mathfrak{g}_2, M_2) \to \mathbb{C}$. Moreover, if Ψ_{\bullet} is non-degenerate and ι is an isomorphism, then so is $[\Psi_{\bullet}]$.

This is immediate from the following statement in linear algebra:

Lemma A.4. Let S_i and T_i (i = 1, 2) be vector superspaces (over \mathbb{C}) equipped with odd homomorphisms $f: S_1 \to S_2, \quad g: T_2 \to T_1$ and even pairings $(\cdot, \cdot)_i: S_i \otimes T_i \to \mathbb{C}$ (i = 1, 2) such that $(f\alpha, \beta)_2 = (\alpha, g\beta)_1$ for $\alpha \in S_1, \beta \in T_2$. Then the pairings induce even pairings

 $\langle \cdot, \cdot \rangle_1 \colon \operatorname{Ker} f \otimes \operatorname{Coker} g \to \mathbb{C}, \quad \langle \cdot, \cdot \rangle_2 \colon \operatorname{Coker} f \otimes \operatorname{Ker} g \to \mathbb{C}.$

If $(\cdot, \cdot)_i$ are non-degenerate, then so are $\langle \cdot, \cdot \rangle_i$.

Proof. Straightforward.

Proposition A.5. Let \mathfrak{g}_i (i = 1, 2) be Lie superalgebras and M_i (i = 1, 2) \mathfrak{g}_i -modules. Suppose that we have an even linear isomorphism $\iota: \mathfrak{g}_2 \xrightarrow{\simeq} \mathfrak{g}_1$ and a non-degenerate even pairing $\Psi: M_1 \otimes M_2 \to \mathbb{C}$ (as vector superspaces). Then the condition (A.6) holds if and only if

- (P1) ^t is an anti-isomorphism of Lie superalgebras,
- (P2) Ψ satisfies $\Psi(m_1 \otimes x.m_2) = \Psi({}^tx.m_1 \otimes m_2)$ $(x \in \mathfrak{g}_2, m_i \in M_i).$

Proof. It is straightforward to see that (A.6) for n = 0 is (P2) and then that (A.6) for n = 1 is (P1). We prove that (P1) and (P2) are sufficient. Suppose $n \ge 2$ and take $f \in \operatorname{Hom}_{\mathbb{C}}(\operatorname{Sym}^{n}(\Pi \mathfrak{g}_{1}), M_{1})$ and $P = \alpha \otimes x_{1}x_{2} \cdots x_{n+1} \in M_{2} \otimes \operatorname{Sym}^{n+1}(\Pi \mathfrak{g}_{2})$. Firstly, we have

$$\Psi_{n+1}(d_n f, P) = (-1)^{\bigstar} \Psi(d_n f({}^t x_1 \cdots {}^t x_{n+1}), \alpha)$$

with $\bigstar = \sum_{p} \bar{x}_{p} + \sum_{p} (\bar{x}_{p} + 1) k_{p-1}$. Then the right-hand side is equal to

$$\begin{split} &\sum_{i=1}^{n+1} (-1)^{\bigstar + A_i} \Psi\left({}^t x_i f({}^t x_1 \dots {}^t \hat{x}_i \dots {}^t x_{n+1}), \alpha\right) \\ &+ \sum_{1 \le i < j \le n+1} (-1)^{\bigstar + A_i, j} \Psi\left(f([{}^t x_i, {}^t x_j]{}^t x_1 \dots {}^t \hat{x}_i \dots {}^t \hat{x}_j \dots {}^t x_{n+1}), \alpha\right) \\ &= \sum_{i=1}^{n+1} (-1)^{\bigstar + A_i} \Psi(f({}^t x_1 \dots {}^t \hat{x}_i \dots {}^t x_{n+1}), x_i \alpha) \\ &+ \sum_{1 \le i < j \le n+1} (-1)^{\bigstar + A_{i, j} + \bar{x}_i \bar{x}_j + 1} \Psi\left(f({}^t [x_i, x_j]{}^t x_1 \dots {}^t \hat{x}_i \dots {}^t \hat{x}_j \dots {}^t x_{n+1}), \alpha\right) \\ &= \sum_{i=1}^{n+1} (-1)^{A_i + \bar{x}_i + \sum_p (\bar{x}_p + 1)k_{p-1}} \Psi(f, x_i \alpha \otimes x_{n+1} \dots \hat{x}_i \dots x_1) \\ &+ \sum_{1 \le i < j \le n+1} (-1)^{\bigstar + A_{i, j} + \bar{x}_i \bar{x}_j + 1} \Psi\left(f, \alpha \otimes x_{n+1} \dots \hat{x}_j \dots \hat{x}_i \dots x_1 [x_i, x_j]\right) \\ &= \sum_{i=1}^{n+1} (-1)^{B_i} \Psi(f, x_i \alpha \otimes x_1 \dots \hat{x}_i \dots x_{n+1}) \\ &+ \sum_{1 \le i < j \le n+1} (-1)^{B_{i, j}} \Psi(f, \alpha \otimes [x_i, x_j] x_1 \dots \hat{x}_i \dots \hat{x}_j \dots x_{n+1}) \\ &= \Psi_n(f, \partial_{n+1} P). \end{split}$$

This completes the proof.

A.3. **Proof of Theorem 3.3.** The following is well-known.

Proposition A.6 (e.g. [Fu]). For an arbitrary Lie superalgebra \mathfrak{g} , and a free $U(\mathfrak{g})$ -module M, we have $H_n(\mathfrak{g}, M) \simeq \delta_{n,0} M/\mathfrak{g} M$.

Proof. We include a sketch of proof for the completeness of the paper. Since free modules are inductive limit of direct sums of $U(\mathfrak{g})$ and inductive limit commutes with taking cohomology, we may assume $M = U(\mathfrak{g})$ from the beginning. Then it is straightforward to see $H_0(\mathfrak{g}, U(\mathfrak{g})) \simeq U(\mathfrak{g})/\mathfrak{g}U(\mathfrak{g})(\simeq \mathbb{C})$ and thus it suffices to show $H_n(\mathfrak{g}, U(\mathfrak{g})) = 0$ for $n \neq 0$. By using a PBW filtration $U_{\leq n}(\mathfrak{g})$, we define the following decreasing filtration on the complex

$$F_pC_{\bullet}(\mathfrak{g}, U(\mathfrak{g})) = \bigoplus_{n+m=p} U_{\leq n}(\mathfrak{g}) \otimes \operatorname{Sym}^m(\Pi \mathfrak{g}).$$

The filtration $F_{\bullet}C_{\bullet}(\mathfrak{g}, U(\mathfrak{g}))$ is exhausitive, separated and preserved by the differential. Thus we have the associated spectral sequence

$$E_1 = H_{\bullet}(\operatorname{gr}_F C_{\bullet}(\mathfrak{g}, U(\mathfrak{g})), \operatorname{gr}_F \partial) \Rightarrow E_{\infty} = \operatorname{gr}_F H_{\bullet}(\mathfrak{g}, U(\mathfrak{g}))$$

which converges since each $C_n(\mathfrak{g}, U(\mathfrak{g}))$ is finitely filtered. Now, $\operatorname{gr}_F C_{\bullet}(\mathfrak{g}, U(\mathfrak{g})) = \operatorname{Sym}(\mathfrak{g}) \otimes \operatorname{Sym}(\Pi \mathfrak{g})$ with

$$\operatorname{gr}_F \partial \colon \alpha \otimes x_1 \cdots x_n \mapsto \sum_{i=1}^n (-1)^{B_i} x_i \alpha \otimes x_1 \cdots \hat{x}_i \cdots x_n.$$

Then it is straightforward to show that the spectral sequence collapses at the r = 1: $E_1^{p,q} \simeq \delta_{(p,q),(0,0)}\mathbb{C}$. This completes the proof.

Applying it to the tensor products of Weyl modules as $L^-\mathfrak{g}$ -modules, we obtain:

Corollary A.7. For $\lambda, \mu \in P_+$ and $k, \ell \in \mathbb{C}$, we have (1) $H_n(L^-\mathfrak{g}, \mathbb{V}^k_{\lambda}) \simeq \delta_{n,0}L_{\lambda}$, (2) $H_n(L^-\mathfrak{g}, \mathbb{V}^k_{\lambda} \otimes \mathbb{V}^\ell_{\mu}) = 0 \ (n > 0).$

Next, we will show the analogous statement for the cohomology.

Lemma A.8. For $\lambda \in P_+$ and $k \in \mathbb{C} \setminus \mathbb{Q}$, \mathbb{V}^k_{λ} is simple as a $V^k(\mathfrak{g})$ -module.

Proof. The proof is the same as the purely even case and thus we only sketch it. Note that $L_0 = \int T(z)zdz$ acts on \mathbb{V}^k_{λ} semisimply and the L_0 -eigenspace decomposition is $\mathbb{V}^k_{\lambda} = \bigoplus_{n \in \mathbb{Z}_{\geq 0}} \mathbb{V}^k_{\lambda, \Delta_{\lambda}+n}$ with $\Delta_{\lambda} = \frac{(\lambda|\lambda+2\rho)}{2(k+h^{\vee})}$. Each $\mathbb{V}^k_{\lambda, \Delta_{\lambda}+n}$ is finite dimensional and $\mathbb{V}^k_{\lambda, \Delta_{\lambda}} = L_{\lambda}$. Suppose that \mathbb{V}^k_{λ} has a proper submodule N. Then N must have a highest weight vector v and gives rise to a non-zero homomorphism $\mathbb{V}^k_{\mu} \to \mathbb{V}^k_{\lambda}$ for some $\mu \in P_+$. By considering the L_0 -eigenvalue of v, we have $\Delta_{\mu} = \Delta_{\lambda} + n$ for some $n \geq 1$, which contradicts $k \in \mathbb{C} \setminus \mathbb{Q}$. This completes the proof.

To apply Proposition A.5, we use the anti-isomorphism of Lie superalgebras

t:

$$\mathfrak{g}[t^{\pm 1}] \oplus \mathbb{C}K \to \mathfrak{g}[t^{\pm 1}] \oplus \mathbb{C}K$$

$$X_n \mapsto (\iota X)_{-n}$$

$$K \mapsto K$$

where ι is the Chevalley anti-involution of \mathfrak{g} . It is obvious that t restricts to $t: L^{-}\mathfrak{g} \xrightarrow{\simeq} L^{+}\mathfrak{g}$. Let \mathbb{M}^{k}_{λ} denote the Verma module of $\widehat{\mathfrak{g}}$ generated by a highest weight vector $v_{\lambda,k}$ of highest weight $\lambda + k\Lambda_{0}$ and $\mathbb{M}^{k}_{\lambda} \twoheadrightarrow \mathbb{V}^{k}_{\lambda}$ the natural projection. Recall that \mathbb{M}^{k}_{λ} has a unique bilinear form

$$\Psi_{\lambda,k} \colon \mathbb{M}^k_{\lambda} \otimes \mathbb{M}^k_{\lambda} \to \mathbb{C}, \quad v_{\lambda,k} \otimes v_{\lambda,k} \to 1$$

which satisfies (P2) in Proposition A.5. It induces a non-degenerate bilinear form on the simple quotient $\Psi_{\lambda,k} : \mathbb{V}^k_{\lambda} \otimes \mathbb{V}^k_{\lambda} \to \mathbb{C}$ for $k \in \mathbb{C} \setminus \mathbb{Q}$.

Proposition A.9. For $\lambda, \mu \in P_+$ and $k, \ell \in \mathbb{C} \setminus \mathbb{Q}$, we have (1) $H^n(L^+\mathfrak{g}, \mathbb{V}^k_{\lambda}) \simeq \delta_{n,0}L_{\lambda}$, (2) $H^n(L^+\mathfrak{g}, \mathbb{V}^k_{\lambda} \otimes \mathbb{V}^{\ell}_{\mu}) = 0$ (n > 0). *Proof.* (1) is a direct consequence of Proposition A.5 and Corollary A.7. (2) is also immediate by using the non-degenerate bilinear form

$$\Psi_{\lambda,k} \otimes \Psi_{\mu,\ell} \colon \left(\mathbb{V}_{\lambda}^k \otimes \mathbb{V}_{\mu}^\ell \right) \otimes \left(\mathbb{V}_{\lambda}^k \otimes \mathbb{V}_{\mu}^\ell \right) \to \mathbb{C}.$$

Proof of Theorem 3.3. It follows from Proposition A.1, Corollary A.7 (2) and Proposition A.9 (2) that $H_{\text{rel}}^{\frac{\infty}{2}+n}(\mathfrak{g}, \mathbb{V}_{\lambda}^k \otimes \mathbb{V}_{\mu}^\ell) = 0$ $(n \neq 0)$. Then, the character of $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{g}, \mathbb{V}_{\lambda}^k \otimes \mathbb{V}_{\mu}^\ell)$ is calculated by the Euler–Poincaré principle [CFL]. Let $\chi_{L_{\lambda}}$ denote the character of L_{λ} as a \mathfrak{g} -module, namely,

$$\chi_{L_{\lambda}}(z) = \frac{\sum_{w \in W} (-1)^{\ell(w)} e^{w(\lambda+\rho)-\rho}}{\prod_{\alpha \in \Delta_{+}} (1-(-1)^{\bar{\alpha}} e^{-\alpha})^{\bar{\alpha}}}$$

and set

$$\Pi(z,q) := \prod_{n=1}^{\infty} (1-q^n)^{\operatorname{rank}\mathfrak{g}} \prod_{\alpha \in \Delta_+} (1-(-1)^{\bar{\alpha}} z^{\alpha} q^n)^{\bar{\alpha}} (1-(-1)^{\bar{\alpha}} z^{-\alpha} q^n)^{\bar{\alpha}}.$$

It follows that

$$\operatorname{ch}[\mathbb{V}_{\lambda}^{k}](z,q) = \frac{q^{\frac{(\lambda|\lambda+2\rho)}{2(k+h^{\vee})}}\chi_{L_{\lambda}}(z)}{\Pi(z,q)}, \quad \operatorname{sch}\left[\bigwedge_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}\right](z,q) = \Pi(z,q)^{2}$$

and thus

$$\operatorname{sch}\left[\mathbb{V}_{\lambda}^{k}\otimes\mathbb{V}_{\mu}^{\ell}\otimes\bigwedge_{\operatorname{rel}}^{\frac{\infty}{2}+\bullet}\right](z,q) = q^{\frac{|\lambda+\rho|^{2}-|\mu+\rho|^{2}}{2(k+h^{\vee})}}\chi_{L_{\lambda}\otimes L_{\mu}}(z).$$
(A.7)

Here we have used the relation $k + h^{\vee} = -(\ell + h^{\vee})$. Since $C_{\text{rel}}^{\frac{\infty}{2} + \bullet}(\mathfrak{g}, \mathbb{V}^k_{\lambda} \otimes \mathbb{V}^{\ell}_{\mu}) = (\mathbb{V}^k_{\lambda} \otimes \mathbb{V}^{\ell}_{\mu} \otimes \bigwedge_{\text{rel}}^{\frac{\infty}{2} + \bullet})^{\mathfrak{g}}$, we have

$$\operatorname{ch}\left[H_{\operatorname{rel}}^{\frac{\infty}{2}+0}(\mathfrak{g},\mathbb{V}^k_{\lambda}\otimes\mathbb{V}^\ell_{\mu})\right](z,q)=\operatorname{sch}\left[(\mathbb{V}^k_{\lambda}\otimes\mathbb{V}^\ell_{\mu}\otimes\bigwedge_{\operatorname{rel}}^{\frac{\infty}{2}+\bullet})^{\mathfrak{g}}\right](z,q).$$

By (A.7), it follows from the complete reducibility of integrable g-modules that the right-hand side is

$$\dim \operatorname{Hom}_{\mathfrak{g}}(L_0, L_\lambda \otimes L_\mu) q^{\frac{|\lambda+\rho|^2 - |\mu+\rho|^2}{2(k+h^{\vee})}} = \delta_{\lambda,\mu^{\dagger}} q^{\frac{|\lambda+\rho|^2 - |\mu+\rho|^2}{2(k+h^{\vee})}}$$

Therefore, $H_{\text{rel}}^{\frac{\infty}{2}+0}(\mathfrak{g}, \mathbb{V}^k_{\lambda} \otimes \mathbb{V}^{\ell}_{\mu})$ is of one dimension and of the lowest conformal weight of the complex. The corresponding subcomplex is $(L_{\lambda} \otimes L_{\mu})^{\mathfrak{g}}$ with trivial differential and thus the cohomology is $(L_{\lambda} \otimes L_{\mu})^{\mathfrak{g}}$ itself. Therefore, the assertion follows from Lemma 3.2.
