# DUALITY VIA CONVOLUTION OF $\mathcal{W}$-ALGEBRAS

#### Abstract

Feigin-Frenkel duality is the isomorphism between the principal $\mathcal{W}$-algebras of a simple Lie algebra $\mathfrak{g}$ and its Langlands dual Lie algebra ${ }^{L} \mathfrak{g}$. A generalization of this duality to a larger family of $\mathcal{W}$-algebras called hook-type was recently conjectured by Gaiotto and Rapčák and proved by the first two authors. It says that the affine cosets of two different hook-type $\mathcal{W}$-algebras are isomorphic. A natural question is whether the duality between affine cosets can be enhanced to a duality between the full $\mathcal{W}$-algebras. There is a convolution operation that maps a hook-type $\mathcal{W}$-algebra $\mathcal{W}$ to a certain relative semi-infinite cohomology of $\mathcal{W}$ tensored with a suitable kernel VOA. The first two authors conjectured previously that this cohomology is isomorphic to the Feigin-Frenkel dual hook-type $\mathcal{W}$-algebra. Our main result is a proof of this conjecture.


## 1. Introduction

Let $\mathfrak{g}$ be a simple Lie algebra or basic Lie superalgebra and let $V^{k}(\mathfrak{g})$ be the affine vertex algebra of $\mathfrak{g}$ at the complex level $k$. We assume $k$ to be generic. To any even nilpotent element $f$ in $\mathfrak{g}$ one constructs from $V^{k}(\mathfrak{g})$ a corresponding $\mathcal{W}$-algebra, denoted by $\mathcal{W}^{k}(\mathfrak{g}, f)$, via quantum Hamiltonian reduction [KRW, KW]. If $f$ is a principal nilpotent then one often omits the symbol $f$. Principal $\mathcal{W}$-algebras enjoy Feigin-Frenkel duality [FF2], that is

\mathcal{W}^{k}(\mathfrak{g}) \cong \mathcal{W}^{\ell}\left({ }^{L} \mathfrak{g}\right), \quad r^{\vee}\left(k+h^{\vee}\right)\left(\ell+{ }^{L} h^{\vee}\right)=1
$$

Here $\mathfrak{g}$ is a simple Lie algebra, ${ }^{L} \mathfrak{g}$ is its Langlands dual, $r^{\vee}$ is the lacing number of $\mathfrak{g}$ and $h^{\vee},{ }^{L} h^{\vee}$ are the dual Coxeter numbers of $\mathfrak{g}$ and ${ }^{L} \mathfrak{g}$. In the Lie superalgebra case a similar duality holds for $\mathfrak{g}=\mathfrak{o s p}_{1 \mid 2 n}$ and replacing $r^{\vee}$ by 4 [Ge, CL2].

Hook-type $\mathcal{W}$-superalgebras [CL1, CL2] are $\mathcal{W}$-superalgebras such that $f=f_{\mathfrak{a}}$ is principal inside an subalgebra $\mathfrak{a}$ whose centralizer $\mathfrak{b}=\mathfrak{z}_{\mathfrak{a}}(\mathfrak{g})$ satisfies the following property: $\mathfrak{g}$ decomposes as a $\mathfrak{a} \oplus \mathfrak{b}$-module into

$$
\mathfrak{g} \simeq \begin{cases}(\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}}^{\dagger} \oplus \rho_{\mathfrak{a}}^{\dagger} \otimes \rho_{\mathfrak{b}} & \text { if } \mathfrak{g}=\mathfrak{s l}_{n \mid m} \\ (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}} & \text { if } \mathfrak{g}=\mathfrak{o s p}_{n \mid 2 m}\end{cases}
$$

This family contains the principal $\mathcal{W}$-algebras of type $A, B, C$, and $D$ and the principal $\mathcal{W}$-superalgebras of $\mathfrak{o s p}_{1 \mid 2 n}$, as well as other familiar examples including subregular and minimal $\mathcal{W}$-superalgebras. In order to present our results uniformly for all types, we introduce slightly different notation $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ for the $\mathcal{W}$ superalgebras $\mathcal{W}^{k}\left(\mathfrak{g}, f_{\mathfrak{a}}\right)$ from the notation in [CL1, CL2]; see Table 1. In all cases, they contain $V^{k_{\mathfrak{b}}}(\mathfrak{b})$ as the maximal affine vertex subalgebra.

Davide Gaiotto and Miroslav Rapčák studied vertex algebras at two-dimensional corners in four dimensional quantum field theories [GR]. The associated corner vertex algebras are cosets of hook-type $\mathcal{W}$-superalgebras and the $S_{3}$-symmetry of the gauge theory led them to conjecture a remarkable family of trialities among these vertex algebras, i.e., isomorphisms of three such algebras. These isomorphisms fall into two types; one type generalizes Feigin-Frenkel duality, and the other type generalizes the coset realization of certain principal $\mathcal{W}$ algebras obtained in [ACL, CL2], namely

Here $\mathfrak{g}$ is of type $A$ or $D$ and $L_{1}(\mathfrak{g})$ is the simple affine vertex algebra of $\mathfrak{g}$ at level one. (In fact the first isomorphism was proven for all simply-laced types in [ACL], but the type $E$ case is not part of these trialities). Also, $F^{2 n+1}$ is the vertex superalgebra of $2 n+1$ free fermions. Note that for $\mathfrak{g}=\mathfrak{g}_{2}$ and $\mathfrak{f}_{4}$, no coset realization of $\mathcal{W}^{k}(\mathfrak{g})$ is known at present.

The triality conjectures were recently proven by the first two authors in [CL1, CL2]. The four-dimensional quantum field theories allow for dualities, called $S$-duality, and these are the physics perspective on (quantum) geometric Langlands duality [KaW]. Vertex algebras play an important role [CG, FG] and in particular it is conjectured that a certain convolution operation against quantum geometric Langlands kernel VOAs realizes the $S$-duality operations on the level of associated vertex algebras [CG, Section 7.3]. The kernel VOAs bear similarity to Gaitsgory's master chiral algebras [G]; they are parametrized by an associated Lie algebra $\mathfrak{g}$ and an integer $n$. For $n=0$, the kernel VOA is the algebra of chiral differential operators of the Lie group whose Lie algebra is $\mathfrak{g}[\mathrm{MSV}]$ and the convolution operation has been used by Arakawa in his proof of the Moore-Tachikawa conjecture [A].
1.1. Convolution with kernel VOAs. Let $k$ be generic. The general kernel VOAs are extensions of $V^{k}(\mathfrak{g}) \otimes$ $V^{\ell}(\tilde{\mathfrak{g}})$ of the form

$$
\mathfrak{A}^{n}[\mathfrak{g}, k]=\bigoplus_{\lambda \in R} \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\lambda^{\dagger}}^{\ell}
$$

where the inverses of the shifted levels add up to a multiple of $n, \mathbb{V}_{\lambda}^{k}$ and $\mathbb{V}_{\lambda^{\dagger}}^{\ell}$ are Weyl-modules of weight $\lambda$ and $\lambda^{\dagger}$ of $V^{k}(\mathfrak{g})$ and $V^{\ell}(\tilde{\mathfrak{g}}), R$ is a certain subset of dominant weights and $\tilde{\mathfrak{g}}$ is a Lie algebra related to $\mathfrak{g}$ and $\lambda^{\dagger}$ is a dominant weight of $\tilde{\mathfrak{g}}$ naturally identified with $\lambda$, see subsection 2.3 for all the concrete details. We are interested in $\mathfrak{g} \in\left\{\mathfrak{g l}_{n}, \mathfrak{s o}_{n}, \mathfrak{S p}_{2 n}, \mathfrak{o s p}_{1 \mid 2 n}\right\}$. We have that the Lie algebra related to $\mathfrak{o s p}_{1 \mid 2 n}$ is $\mathfrak{s o}_{2 n+1}$ and vice versa, while all others satisfy $\mathfrak{g}=\tilde{\mathfrak{g}}$. Yuto Moriwaki [M] recently proved the existence of the kernel VOAs when $\mathfrak{g}=\tilde{\mathfrak{g}}$. The case of the pair $\mathfrak{s o}_{3}, \mathfrak{o s p}_{1 \mid 2}$ is just $A^{1}\left[\mathfrak{s o}_{3}, k\right]=L_{1}(\mathfrak{d}(2,1 ;-2 k))$ and $A^{1}\left[\mathfrak{o s p}_{1 \mid 2}, k\right]=L_{1}\left(\mathfrak{d}\left(2,1 ;-\frac{1}{k+1}\right)\right)$ [CG, (9.6)] together with [CGL2, Thm. 3.2]).

Let $V$ be another vertex algebra that has an affine subalgebra $V^{-k-2 h^{\vee}}(\mathfrak{g})$. Then the convolution operation is the relative semi-infinite Lie algebra cohomology on $V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]$. We explain the relative semi-infinite Lie algebra cohomology in $\S 3.1$ and the Appendix and in particular prove that the results of [FGZ] also hold for $\mathfrak{g}=\mathfrak{o s p}_{1 \mid 2 n}$.

Assume that $V$ decomposes as

$$
V=\bigoplus_{\lambda \in R} \mathbb{V}_{\lambda}^{-k-2 h^{\vee}} \otimes C_{\lambda}
$$

with $C=C_{0}=\operatorname{Com}\left(V^{-k-2 h^{\vee}}(\mathfrak{g}), V\right)$ the coset and $C_{\lambda}$ are modules of $C$. Then

$$
H_{\mathrm{rel}}^{\frac{\infty}{2}+m}\left(\mathfrak{g}, V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]\right)=\delta_{m, 0} \bigoplus_{\lambda \in R} C_{\lambda} \otimes \mathbb{V}_{\lambda^{\dagger}}^{\ell}
$$

as a $C \otimes V^{\ell}(\tilde{\mathfrak{g}})$-module. Set $\widetilde{V}:=H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{g}, V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]\right)$.
This type of convolution operation has been used to construct the large $N=4$ superconformal algebra [CFL] and it motivated the conjecture that Feigin-Frenkel dual hook-type $\mathcal{W}$-superalgebras are related via the convolution operation [CL2, Conjecture 1.2]. If $\mathfrak{g}=\mathfrak{g l}_{1}$, then the kernel VOAs are just the lattice VOAs of the lattices $\sqrt{n} \mathbb{Z}$ times a rank one Heisenberg VOA. In this case the conjecture connects subregular $\mathcal{W}$-algebras of type $A, B$ with principal $\mathcal{W}$-superalgebras of type $\mathfrak{s l}_{n \mid 1}$ and $\mathfrak{o s p}_{2 \mid 2 n}$. The correspondence in this case is often also called Feigin-Semikhatov duality due to their work [FS]. In this case, the conjecture is proven and exploited in [CGN, CGNS]. We have

Main Theorem. (Theorem 4.4) For $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$ under $r_{X}\left(k+h_{X^{+}}^{\vee}\right)\left(\ell+h_{Y^{-}}^{\vee}\right)=1$, there exist isomorphisms of vertex superalgebras

\begin{aligned}
& \mathcal{W}_{Y^{-}}^{\ell}(n, m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n, m) \otimes A^{1}\left[\mathfrak{b}, \alpha_{+}\right]\right), \\
& \mathcal{W}_{X^{+}}^{k}(n, m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n, m) \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right),
\end{aligned}

$\left(\alpha_{+}, \alpha_{-}\right)$are given in Theorem $4.4,(X, Y) \in\{(A, A),(B, O),(C, C),(D, D),(O, B)\}$. The statements for $X \in$ $\{B, O\}$ with $m>1$ are understood under the assumption of the existence of a simple vertex superalgebra structure on $A^{ \pm 1}\left[\mathfrak{s o}_{2 m+1}, k\right]=A^{ \pm 1}\left[\mathfrak{o s p}_{1 \mid 2 m}, \ell\right]$.

One main interest is that one can now take a module, say $M \otimes N$ of $V \otimes \mathfrak{A}^{n}[\mathfrak{g}, k]$ and the cohomology then gives a module of the dual algebra. This means that for a fixed $\mathfrak{A}^{n}[\mathfrak{g}, k]$-module $N$, there is a functor from $V$-modules to modules of the dual algebra $\widetilde{V}$

$$
\mathcal{F}_{N}: V-\bmod \rightarrow \tilde{V}-\bmod , \quad M \mapsto H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(M \otimes N) .
$$

If $V, \tilde{V}$ is as in our main theorem, that is $V \cong H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\tilde{\mathfrak{g}}, \tilde{V} \otimes \mathfrak{A}^{-n}[\tilde{\mathfrak{g}}, \ell]\right)$, then one immediately also gets functors in the other direction and one might hope to be able to use them to prove equivalences of blocks of categories of $V-\bmod$ and $\widetilde{V}$-mod. In the instance of subregular $\mathcal{W}$-algebras of type $A, B$ and principal $\mathcal{W}$-superalgebras of type $\mathfrak{s l}_{n \mid 1}$ and $\mathfrak{o s p}_{2 \mid 2 n}$, this family of functors gives indeed a block-wise equivalence of module categories together with isomorphisms of spaces of intertwining operators, see [CGNS]. In the spirit of the quantum geometric Langlands correspondence one also would like to get an equivalence of conformal blocks. A strong indication that such an equivalence might be true is that there is a conformal field theory approach using the path integral that indeed gives identifications of correlation functions [CH1, CH2, CHS, CH3]. We aim to pursue this direction further and are currently studying the behavior of characters under our convolution operation.

## 2. Kernel vertex superalgebras

2.1. Affine vertex superalgebras. Let $\mathfrak{g}=\mathfrak{g}_{\overline{0}} \oplus \mathfrak{g}_{\overline{1}}$ be a finite dimensional Lie superalgebra equipped with an even non-degenerate supersymmetric invariant bilinear form $\kappa=(\cdot \mid \cdot)$. The one-dimensional central extension $\widehat{\mathfrak{g}}_{\kappa}=\mathfrak{g}\left[t^{ \pm 1}\right] \oplus \mathbb{C} K$ of the loop superalgebra $\mathfrak{g}\left[t^{ \pm 1}\right]=\mathfrak{g} \otimes \mathbb{C}\left[t^{ \pm 1}\right]$, whose commutator is $\left[X_{n}, Y_{m}\right]=$ $[X, Y]_{n+m}+(X \mid Y) K,\left(X_{n}:=X t^{n}\right)$, is called the affine Lie algebra of $\mathfrak{g}$. Then the induced representation $V^{\kappa}(\mathfrak{g}):=\operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C} K}^{\widehat{\mathfrak{g}}_{\kappa}} \mathbb{C}$ where $\mathfrak{g}[t]$ acts on $\mathbb{C}$ by zero and $K$ by identity has a structure of vertex superalgebra, called the universal affine vertex superalgebra associated with $\mathfrak{g}$ at level $\kappa$. As a vertex superalgebra, $V^{\kappa}(\mathfrak{g})$ is generated by fields $Y\left(X_{-1} \mathbf{1}, z\right):=X(z)=\sum_{n \in \mathbb{Z}} X_{n} z^{-n-1},(X \in \mathfrak{g})$ which satisfy the OPEs

$$
X(z) Y(z) \sim \frac{[X, Y]}{(z-w)}+\frac{(X \mid Y)}{(z-w)^{2}}, \quad(X, Y \in \mathfrak{g})
$$

The vertex superalgebra $V^{\kappa}(\mathfrak{g})$ is $\mathbb{Z}_{\geq 0}$-graded by setting $\Delta\left(x_{1, n_{1}} \cdots x_{m, n_{m}} \mathbf{1}\right)=-\sum_{p=1}^{m} n_{p},\left(x_{i} \in \mathfrak{g}\right)$. We denote by $\mathbf{K L}_{\kappa}(\mathfrak{g})$ the Kazhdan-Lusztig category of $V^{\kappa}(\mathfrak{g})$ at level $\kappa$, that is, the full subcategory of all the ( $\mathbb{Z}_{2}$-graded) positive-energy representations of $V^{\kappa}(\mathfrak{g})$ consisting of integrable $\mathfrak{g}$-modules.
2.2. Tensor representations. Here we recollect and fix notation of tensor representations of Lie superalgebras $\mathfrak{g}=\mathfrak{g l}_{m} \mathfrak{s l}_{m}, \mathfrak{s o}_{m}, \mathfrak{s p}_{2 m}$, and $\mathfrak{o s p}_{1 \mid 2 m}$.

We first consider the case when $\mathfrak{g}$ is simple. Let $\mathfrak{g}=\mathfrak{n}_{+} \oplus \mathfrak{h} \oplus \mathfrak{n}_{-}$be the triangular decomposition, $\left\{\alpha_{i}\right\}_{i=1}^{\text {rankg }} \subset$ $\mathfrak{h}^{*}$ the set of simple roots, and $\left\{\varpi_{i}\right\}_{i=1}^{\text {rankg }}$ the set of fundamental weights. We set $P=\oplus_{i} \mathbb{Z} \varpi_{i}$ (resp. $Q=\oplus_{i} \mathbb{Z} \alpha_{i}$ ) the weight lattice (resp. the root lattice). Then we denote by $P_{+}=\oplus_{i} \mathbb{Z}_{\geq 0} \varpi_{i}$ the set of dominant integral weights and by $L_{\lambda},\left(\lambda \in P_{+}\right)$, the simple $\mathfrak{g}$-module generated by highest weight vector of even parity and of highest weight $\lambda$. In particular, $L_{\varpi_{1}}$ corresponds to the natural representation $\rho_{\mathfrak{g}}$, which is $\mathbb{C}^{m}$ (resp. $\mathbb{C}^{m}$, $\mathbb{C}^{2 m}, \mathbb{C}^{1 \mid 2 m}$ ) when $\mathfrak{g}=\mathfrak{s l}_{m}$ (resp. $\mathfrak{s o}_{m}, \mathfrak{s p}_{2 m}, \mathfrak{o s p}_{1 \mid 2 m}$ ). Given $\lambda \in P_{+}$, let $\lambda^{\dagger}$ denote the highest weight for the dual representation $\operatorname{Hom}_{\mathbb{C}}\left(L_{\lambda}, \mathbb{C}^{1 \mid 0}\right)$. By using the Weyl group $W$ of $\mathfrak{g}$ and its longest element $w_{0}$, we have $\lambda^{\dagger}=-w_{0} \lambda$.
Lemma 2.1. For $\lambda \in P_{+}$, $\mathfrak{g}$-module isomorphisms $L_{\lambda^{\dagger}} \simeq \operatorname{Hom}_{\mathbb{C}}\left(L_{\lambda}, \mathbb{C}^{1 \mid 0}\right)$ are even.
Proof. It suffices to prove the case $\mathfrak{g}=\mathfrak{o s p}_{1 \mid 2 m}$. Decompose $L_{\lambda}$ as a $\mathfrak{s p}_{2 m}$-module: $\left.L_{\lambda}\right|_{\mathfrak{s p}_{2 m}} \simeq \bigoplus_{\mu} n_{\lambda, \mu} L_{\mu}\left(\mathfrak{s p}_{2 m}\right)$. Since the Cartan subalgebras of $\mathfrak{o s p}_{1 \mid 2 m}$ and $\mathfrak{s p}_{2 m}$ coincide, $n_{\lambda, \mu}$ is non-zero only if $\lambda$ dominates $\mu$. Hence, the lowest weight of $L_{\lambda}$ coincides with that of $L_{\lambda}\left(\mathfrak{s p}_{2 m}\right)$.

Tensor representations of $\mathfrak{g}$ are, by definition, modules appearing as submodules in the tensor algebra $T^{\bullet}\left(L_{\varpi_{1}} \oplus\right.$ $\left.L_{\varpi_{1}^{\dagger}}\right)$. We denote by $R \subset P_{+}$the set of their highest weights. The condition is given in Table 2 below. We make two remarks when $\mathfrak{g} \neq \mathfrak{s l}_{m}: L_{\lambda^{\dagger}} \simeq L_{\lambda}$ holds for all $\lambda \in R$ since $\varpi_{1}^{\dagger}=\varpi_{1}$; by [RS], we have the one-to-one correspondence

R\left(\mathfrak{o s p}_{1 \mid 2 m}\right) \xrightarrow{\simeq} R\left(\mathfrak{s o}_{2 m+1}\right), \quad \lambda=\sum_{i=1}^{m} \lambda_{i} \varpi_{i} \mapsto^{s} \lambda:=\sum_{i=1}^{m-1} \lambda_{i} \varpi_{i}+2 \lambda_{m} \varpi_{m} \tag{2.1}
\end{equation*}
$$

under which the characters are identified and thus the branchings of tensor products coincide, see also [C]. By abuse of notation, we denote the inverse of (2.1) also by $\lambda \mapsto{ }^{s} \lambda$.

Next, we consider the case $\mathfrak{g}=\mathfrak{g l}_{m}$. We decompose $\mathfrak{g l}_{m}=\mathfrak{s l}_{m} \oplus \mathbb{C I d}$ as usual and set the set of fundamental weights $\left\{\varpi_{i}\right\}_{i=1}^{m}$ so that under the above decomposition $\left\{\varpi_{i}\right\}_{i=1}^{m-1}$ corresponds to that of $\mathfrak{s l}_{m}$ and $\varpi_{m}$ to the dual of Id. Then we set $P_{+}=\oplus_{i=1}^{m-1} \mathbb{Z}_{\geq 0} \varpi_{i} \oplus \mathbb{Z} \varpi_{m}$ and the remaining notation is the same as before. In particular, the natural representation $\rho_{\mathfrak{g} r_{m}}=\mathbb{C}^{m}$ and its dual representation $\rho_{\mathfrak{g} r_{m}}^{\dagger}=\overline{\mathbb{C}}^{m}$ corresponds to $L_{\varpi_{1}+\varpi_{m}}$ and $L_{\varpi_{m-1}-\varpi_{m}}$ respectively. The condition for the set $R \subset P_{+}$of highest weights of tensor representations is given in Table 2 below.

In this paper, we will consider the pairs $\left(\mathfrak{g l}_{m}, \mathfrak{g l}_{m}\right),\left(\mathfrak{s l}_{m}, \mathfrak{s l}_{m}\right),\left(\mathfrak{s o}_{2 m+1}, \mathfrak{o s p}_{1 \mid 2 m}\right),\left(\mathfrak{s p}_{2 m}, \mathfrak{s p}_{2 m}\right),\left(\mathfrak{s o}_{2 m}, \mathfrak{s o}_{2 m}\right)$ and it will be useful to extend the notation $\lambda \leftrightarrow^{s} \lambda$ for $\left(\mathfrak{s o}_{2 m+1}, \mathfrak{o s p}_{1 \mid 2 m}\right)$ to all pairs by setting ${ }^{s} \lambda=\lambda$ and also to the Lie superalgebras e.g. ${ }^{s} \mathfrak{g l}_{m}=\mathfrak{g l}_{m}$.
2.3. Kernel vertex superalgebras. Let $\mathfrak{g}=\mathfrak{s l}_{m}, \mathfrak{s o}_{m}$ or $\mathfrak{s p}_{2 m}$, and set $\kappa=k \kappa_{0}$ where $\kappa_{0}$ is the normalized invariant bilinear form on $\mathfrak{g}$ and write $V^{k}(\mathfrak{g})=V^{\kappa}(\mathfrak{g}), \mathbf{K} \mathbf{L}_{k}(\mathfrak{g})=\mathbf{K} \mathbf{L}_{\kappa}(\mathfrak{g})$ and so on.

From now on, we assume $k \in \mathbb{C} \backslash \mathbb{Q}$. Therefore, $\mathbf{K L}_{k}(\mathfrak{g})$ is semisimple and the complete set of representatives of simple objects is given by the Weyl modules $\mathbb{V}_{\mathfrak{g}}^{k}(\lambda)=\operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C} K}^{\widehat{\mathfrak{g}}_{k}} L_{\lambda},\left(\lambda \in P_{+}\right)$. When $\mathfrak{g}$ is clear, we also write it as $\mathbb{V}_{\lambda}^{k}$. For $n \in \mathbb{Z}$, introduce the following ind-object of the Deligne product $\mathbf{K L}_{k}(\mathfrak{g}) \boxtimes \mathbf{K} \mathbf{L}_{\ell}(\mathfrak{g})$ :

where $\ell \in \mathbb{C}$ is defined by the relation

\frac{1}{r^{\vee}\left(k+h^{\vee}\right)}+\frac{1}{r^{\vee}\left(\ell+h^{\vee}\right)}=n N_{\mathfrak{g}, R} \tag{2.3}
\end{equation*}

Here $r^{\vee}$ (resp. $h^{\vee}$ ) is the lacing number (resp. the dual Coxeter number) of $\mathfrak{g}$ and $N_{\mathfrak{g}, R}$ is the level of the lattice $R$, which is $m$ (resp. 1) if $\mathfrak{g}=\mathfrak{s l}_{m}$ (resp. $\mathfrak{s o}_{m}, \mathfrak{s p}_{2 m}$ ). In [CG, FG], $\mathfrak{A}^{n}[\mathfrak{g}, k]$ is conjectured to have a structure of simple vertex superalgebra and called the geometric Langlands kernel (super)algebra. For even $n$, this conjecture was first proven in [CKM, Corollary 1.4] and, in particular, for $n=0, A^{0}[\mathfrak{g}, k]$ is realized by the vertex algebra of chiral differential operators

\mathcal{D}_{G, \kappa}^{\mathrm{ch}}:=\operatorname{Ind}_{\mathfrak{g}[t] \oplus \mathbb{C} K}^{\widehat{\mathfrak{g}}_{k}} \mathbb{C}\left[J_{\infty} G\right] .
$$

Here $J_{\infty} G$ is the infinite jet scheme of $G=S L_{m}$ (resp. $S O_{m}, S p_{2 m}$ ) for $\mathfrak{g}=\mathfrak{s l}_{m}\left(\right.$ resp. $\left.\mathfrak{s o}_{m}, \mathfrak{s p}_{2 m}\right)$ and $\mathfrak{g}[t]$ acts on $\mathbb{C}\left[J_{\infty} G\right]$ through the left-invariant vector fields on $G$. This $\mathfrak{g}[t]$-action is induced from the $\mathfrak{g}$-action on $\mathbb{C}[G]$, which commutes with another $\mathfrak{g}$-action by the right-invariant vector fields. The Peter-Weyl theorem asserts that $\mathbb{C}[G] \simeq \bigoplus_{\lambda \in R} L_{\lambda} \otimes L_{\lambda \dagger}$ as $(\mathfrak{g}, \mathfrak{g})$-bimodules, which induces the decomposition of $\mathcal{D}_{G, k}^{\mathrm{ch}}$ into (2.2) as $V^{k}(\mathfrak{g}) \otimes V^{-k-h^{\vee}}(\mathfrak{g})$-modules [AG, GMS1, GMS2]. The coordinate ring $\mathbb{C}[G]$ has a $q$-deformation $O_{q}(G)$, called the quantum coordinate ring. It is a Hopf algebra dual to the quantum enveloping algebra $U_{q}(\mathfrak{g})$ and is a commutative algebra (ind-)object of the Deligne product $\left(U_{q}(\mathfrak{g}), R_{\rho}\right)$ - $\bmod \boxtimes\left(U_{q^{-1}}(\mathfrak{g}), R_{-\rho}\right)$-mod). Here $\left(U_{q}(\mathfrak{g}), R_{\rho}\right)$-mod is the tensor category of finite dimensional $U_{q}(\mathfrak{g})$-modules of type 1 equipped with a braiding defined by the R-matrix $R_{\rho}$ depending on $\rho \in \mathbb{C}$ such that $\exp (\pi \sqrt{-1} \rho)=q$, which gives a braiding on the category, see e.g. [KS].

In [M], by using $O_{q}(G)$ and twists of the braided tensor category $\left(U_{q}(\mathfrak{g}), R_{\rho}\right)$-mod by abelian 3-cocycles, Moriwaki has constructed various kinds of simple vertex superalgebras which are extensions of affine vertex algebras and lattice vertex superalgebras including (2.2) via the Kazhdan-Lusztig correspondence

\left(U_{q}(\mathfrak{g}), R_{1 / r^{\vee}\left(k+h^{\vee}\right)}\right)-\bmod \xrightarrow{\simeq} \mathbf{K} \mathbf{L}_{k}(\mathfrak{g}) .
$$

In particular, $\mathfrak{A}\left[\mathfrak{s l}_{m}, k\right]$ has a variant corresponding to $\mathfrak{g}=\mathfrak{g l}_{m}$. More precisely, set

$$
\begin{equation*}
\mathfrak{A}^{n}\left[\mathfrak{g l}_{m}, k\right]=\bigoplus_{\lambda \in R\left(\mathfrak{s l}_{m}\right)} \mathbb{V}_{\mathfrak{s l}_{m}}^{k}(\lambda) \otimes \mathbb{V}_{\mathfrak{s l}_{m}}^{\ell}\left(\lambda^{\dagger}\right) \otimes V_{\frac{n \pi(\lambda)}{\sqrt{n m}}+\sqrt{n m} \mathbb{Z}} \tag{2.4}
\end{equation*}
$$

with $\ell \in \mathbb{C}$ defined through (2.3) and $r^{\vee}=1, N_{\mathfrak{g r}_{m}, R}=1$. Here $V_{\sqrt{n m} \mathbb{Z}}$ is the lattice vertex superalgebra associated with the lattice $\sqrt{n m} \mathbb{Z}$, whose simple modules are $\left\{V_{\frac{a}{\sqrt{m n}}+\sqrt{m n} \mathbb{Z}}\right\}_{a \in \mathbb{Z}_{n m}}$, and $\pi$ is the projection $P \rightarrow P / Q \xrightarrow{\simeq} \mathbb{Z}_{m},\left(\varpi_{i} \mapsto i\right)$. Note that (2.4) is compatible with the Peter-Weyl theorem for $G=G L_{m}$ since weights appearing in the lattice part are regarded as one-dimensional representations for $\mathbb{C I d} \subset \mathfrak{g l}_{m}$. Then [M, Main Theorem B] specializes to the following statement:

Theorem $2.2([\mathrm{M}])$. For $k \in \mathbb{C} \backslash \mathbb{Q}, \mathfrak{A}^{n}[\mathfrak{g}, k]$ with $\mathfrak{g}=\mathfrak{g l}_{m}, \mathfrak{s o}_{m}$, or $\mathfrak{s p}_{2 m}$ has a structure of simple vertex algebra (resp. superalgebra) if $n$ is even (resp. odd).

For later use, we set

A^{n}\left[\mathfrak{g l}_{m}, k\right]=\mathfrak{A}^{n}\left[\mathfrak{g l}_{m}, k\right] \otimes \pi, \quad A^{n}[\mathfrak{g}, k]=\mathfrak{A}^{n}[\mathfrak{g}, k], \quad\left(\mathfrak{g}=\mathfrak{s p}_{2 m}, \mathfrak{s o}_{2 m}\right),
$$

where $\pi$ is the rank one Heisenberg vertex algebra, and

A^{n}\left[\mathfrak{s o}_{2 m+1}, k\right]=\bigoplus_{\lambda \in R} \mathbb{V}_{\mathfrak{s o}_{2 m+1}}^{k}(\lambda) \otimes \mathbb{V}_{\mathfrak{o s p}_{1 \mid 2 m}^{\ell}}\left({ }^{s} \lambda\right)=A^{n}\left[\mathfrak{o s p}_{1 \mid 2 m}, \ell\right] \tag{2.5}
\end{equation*}

where $(k, \ell)$ satisfies the relation

\frac{1}{a\left(k+h^{\vee}\right)}+\frac{1}{b\left(\ell+h^{\vee}\right)}=c n \tag{2.6}
\end{equation*}

with $(a, b, c)$ given in Table 3 below. The existence of simple vertex superalgebra structure on (2.5) has been conjectured in [CL2]. Low rank cases are understood to be related to $\mathcal{W}$-algebras of the exceptional Lie superalgebra $\mathfrak{d}(2,1 ; \alpha)$
(1) $A^{1}\left[\mathfrak{g l}_{2}, k\right]=L_{1}\left(\mathfrak{d}\left(2,1 ;-\frac{1}{k+1}\right)\right) \otimes \pi$, the simple affine vertex superalgebra of $\mathfrak{d}\left(2,1 ;-\frac{1}{k+1}\right)$ at level one times a rank one Heisenberg algebra, this follows from [CG, Thm. 9.1].
(2) $A^{1}\left[\mathfrak{s o}_{3}, k\right]=L_{1}(\mathfrak{d}(2,1 ;-2 k))$, [CG, (9.6)] together with [CGL2, Thm. 3.2].
(3) $A^{1}\left[\mathfrak{s p}_{2}, k\right]=\mathcal{W}_{\frac{1}{2}}\left(\mathfrak{d}(2,1 ;-2 k-3), f_{\text {min }}\right)$, the simple minimal $\mathcal{W}$-superalgebra of $\mathfrak{d}(2,1 ;-2 k-3)$ at level 1/2 [CGL1, Cor. 2.6].
(4) $A^{1}\left[\mathfrak{s o}_{4}, k\right]=\operatorname{Hom}_{\mathcal{C}\left(A_{1}^{2}\right)}\left(L_{1}\left(\mathfrak{d}\left(2,1 ;-\frac{1}{k+1}\right)\right)^{\otimes 2}, V_{\mathbb{Z}^{2}}\right)$, here $\mathcal{C}(L)$ is the category of modules of the lattice vertex algebra $V_{L}$ of the lattice $L$. This statement follows easily from [CG, Thm. 9.1].
(5) $A^{1}\left[\mathfrak{o s p}_{1 \mid 2}, k\right]=L_{1}\left(\mathfrak{d}\left(2,1 ;-\frac{1}{k+1}\right)\right)$, [CG, (9.6)] together with [CGL2, Thm. 3.2].

In $\S 4$, we will use $A^{ \pm 1}[\mathfrak{g}, k]$ for $\mathfrak{g}=\mathfrak{g l}_{m}, \mathfrak{s o}_{2 m}, \mathfrak{s p}_{2 m}$ and also $\mathfrak{s o}_{2 m+1}, \mathfrak{o s p}_{1 \mid 2 m}$ under the conjecture for $m>1$. In Table 3 , we summarize the values $(a, b, c)$ in the relation (2.6), the parity and conformal weight $\Delta_{K}$ for the lowest conformal weights of the natural representation $\rho_{\mathfrak{g}} \otimes \rho_{s_{\mathfrak{g}}}^{\dagger}$ and its dual $\rho_{\mathfrak{g}}^{\dagger} \otimes \rho_{s_{\mathfrak{g}}}$ as $\left(\mathfrak{g},{ }^{s} \mathfrak{g}\right)$-modules appearing in the decomposition

Here $\Pi$ denotes the odd isomorphism for arbitrary vector superspaces which interchanges the parity.

Lemma 2.3. For $k \in \mathbb{C} \backslash \mathbb{Q}$, the bilinear form

\langle\cdot \mid \cdot\rangle:\left(\rho_{\mathfrak{g}} \otimes \rho_{s} \dagger\right) \otimes\left(\rho_{\mathfrak{g}}^{\dagger} \otimes \rho_{s} \mathfrak{g}\right) \rightarrow \mathbb{C}, \quad(x, y) \mapsto x_{\left(2 \Delta_{K}-1\right)} y
$$

is non-degenerate.
Proof. Since $\langle\cdot \mid \cdot\rangle$ is a $\left(\mathfrak{g},{ }^{s} \mathfrak{g}\right)$-invariant bilinear form, it is non-degenerate if it is non-zero. The latter is an immediate consequence of the structure of the Hopf algebra $O_{q}(G)$ as a $\left(U_{q}(\mathfrak{g}), U_{q^{-1}}(\mathfrak{g})\right)$-bimodule for $\mathfrak{g}=\mathfrak{g l}_{m}$, $\mathfrak{s o}_{2 m}, \mathfrak{s p}_{2 m}$ and of the construction in [CG] for $\mathfrak{g}=\mathfrak{s o}_{3}, \mathfrak{o s p}_{1 \mid 2}$.

## 3. Relative semi-infinite cohomology

3.1. Relative semi-infinite cohomology. Let $\mathfrak{g}$ be as in $\S 2.2$ and take a parity-homogeneous basis $\left\{x_{i}\right\}_{i=1}^{\operatorname{dim}} \mathfrak{g}$ with structure constants $c_{i, j}^{k}$, i.e. $\left[x_{i}, x_{j}\right]=\sum_{k} c_{i, j}^{k} x_{k}$.

Introduce a vertex superalgebra $\Lambda^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ generated by the fields

$$
\varphi_{i}^{*}(z)=\sum_{n \in \mathbb{Z}} \varphi_{i, n}^{*} z^{-n}, \quad \varphi_{i}(z)=\sum_{n \in \mathbb{Z}} \varphi_{i, n} z^{-n-1}, \quad(i=1, \ldots, \operatorname{dim} \mathfrak{g})
$$

with parity opposite to $x_{i}(z)$ satisfying the OPEs

$$
\varphi_{i}(z) \varphi_{j}^{*}(w) \sim \frac{\delta_{i, j}}{z-w}, \quad \varphi_{i}(z) \varphi_{j}(w) \sim 0 \sim \varphi_{i}^{*}(z) \varphi_{j}^{*}(w)
$$

As a vector superspace, $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ carries a cohomological grading $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})=\bigoplus_{n \in \mathbb{Z}} \bigwedge^{\frac{\infty}{2}+n}(\mathfrak{g})$ defined by $\operatorname{deg} \partial^{n} \varphi_{i}^{*}=-\operatorname{deg} \partial^{n} \varphi_{i}=1$. On the other hand, $V^{\kappa_{\mathfrak{g}}}(\mathfrak{g})$ acts on $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ by

x_{i}(z) \mapsto \sum_{j, k=1}^{\operatorname{dim} \mathfrak{g}}(-1)^{\bar{x}_{j}} c_{i, j}^{k}: \varphi_{k}(z) \varphi_{j}^{*}(z):,
$$

which preserves the cohomological grading. As a $V^{\kappa_{\mathfrak{g}}}(\mathfrak{g})$-module, $\Lambda^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ is a positive energy representation $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})=\bigoplus_{\Delta>0} \Lambda^{\frac{\infty}{2}+\bullet}(\mathfrak{g})_{\Delta}$ by setting the compatible grading to be $\Delta\left(\varphi_{i}^{*}\right)=0$ and $\Delta\left(\varphi_{i}\right)=1$. Since the dimension of $\bigwedge^{\frac{\infty}{2}+n}(\mathfrak{g})_{\Delta}=\bigwedge^{\frac{\infty}{2}+n}(\mathfrak{g}) \cap \bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})_{\Delta}$ is finite, $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ is an object in $\mathbf{K L}_{\kappa_{\mathfrak{g}}}(\mathfrak{g})$.

Given an object $M$ in $\mathbf{K L}_{-\kappa_{\mathfrak{g}}}$, we associate a differential graded $V^{0}(\mathfrak{g})$-module

C^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M):=M \otimes \bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})
$$

equipped with (odd) differential

$$
d=\int d z \sum_{i}(-1)^{\bar{x}_{i}}: x_{i}(z) \varphi_{i}^{*}(z):-\frac{1}{2} \sum_{i, j, k}(-1)^{\bar{x}_{i} \bar{x}_{k}} c_{i, j}^{k}: \varphi_{i}^{*}(z) \varphi_{j}^{*}(z) \varphi_{k}(z):
$$

and grading given by that of $\bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$. The cohomology $H^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)$ is called the semi-infinite cohomology of $\widehat{\mathfrak{g}}$ with coefficients in $M$. In this paper, we consider a relative version, which assigns the cohomology of the following subcomplex:

$$
\begin{equation*}
C_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M):=\left(M \otimes \bigwedge_{\text {rel }}^{\frac{\infty}{2}+\bullet}(\mathfrak{g})\right)^{\mathfrak{g}} \tag{3.1}
\end{equation*}
$$

Here $\bigwedge_{\text {rel }}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}) \subset \bigwedge^{\frac{\infty}{2}+\bullet}(\mathfrak{g})$ is the subalgebra generated by $\left\{\partial \varphi_{i}^{*}(z), \varphi_{i}(z)\right\}_{i=1}^{\text {dim }} \mathfrak{g}$ and $(?)^{\mathfrak{g}}$ denotes the $\mathfrak{g}$-invariant subspace by the diagonal $\mathfrak{g}$-action. It is called the relative semi-infinite cohomology functor and denoted by

$$
H_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, \cdot): \mathbf{K L}_{-\kappa_{\mathfrak{g}}} \rightarrow \text { SVect }^{\mathbb{Z}}
$$

where SVect ${ }^{\mathbb{Z}}$ denotes the category of $\left(\mathbb{Z}_{2} \times \mathbb{Z}\right)$-graded vector spaces over $\mathbb{C}$.
Remark 3.1. Since $d$ is of conformal degree $0, C^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)$ and $C_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)$ decompose into direct sums of subcomplexes consisting of finite dimensional objects.

For a finite dimensional $\mathfrak{g}$-module $M$, we have an even natural isomorphism

$$
\operatorname{Hom}_{\mathbb{C}}\left(M, \mathbb{C}^{1 \mid 0}\right) \otimes M \xrightarrow{\simeq} \operatorname{End}(M), \quad f \otimes v \mapsto(w \mapsto f(w) v) .
$$

Let $\operatorname{str}_{M}$ denote the pull-back of $\mathrm{id}_{M}$ under this isomorphism. In particular, when $M=L_{\lambda}$, we write $\operatorname{str}_{M}=\operatorname{str}_{\lambda}$.
Lemma 3.2. For $\lambda, \mu \in P_{+}$, we have an even isomorphism of vector superspaces $\operatorname{Hom}_{\mathfrak{g}}\left(\mathbb{C}^{1 \mid 0}, L_{\lambda} \otimes L_{\mu}\right) \simeq$ $\delta_{\lambda, \mu^{\dagger}} \operatorname{Cstr}_{\mu}$.

Proof. Immediate from Schur's lemma:

$$
\operatorname{Hom}_{\mathfrak{g}}\left(\mathbb{C}^{1 \mid 0}, L_{\lambda} \otimes L_{\mu}\right) \simeq \operatorname{Hom}_{\mathfrak{g}}\left(L_{\lambda^{\dagger}}, L_{\mu}\right) \simeq \delta_{\lambda^{\dagger}, \mu} \mathbb{C i d}_{L_{\mu}}
$$

The following property, proven in [CFL, FGZ] for simple Lie algebras, is called the formality of the relative semi-infinite cohomology.
Theorem 3.3 ([CFL, FGZ]). For $\lambda, \mu \in P_{+}$,

$$
H_{\mathrm{rel}}^{\frac{\infty}{2}+n}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{\kappa_{1}} \otimes \mathbb{V}_{\mu}^{\kappa_{2}}\right) \simeq \delta_{n, 0} \delta_{\lambda, \mu^{\dagger}} \mathbb{C}\left[\operatorname{str}_{\mu}\right]
$$

holds for $\left(\kappa_{1}, \kappa_{2}\right)$ such that $\kappa_{1}+\kappa_{2}=-\kappa_{\mathfrak{g}}$ and the restriction of $\kappa_{i}$ to the semisimple part of $\mathfrak{g}_{i}$ is a irrational level and to the abelian part is nonzero.

See [CGNS, Proposition 6.1] for a short proof in the abelian case. In Appendix A, we give a detailed proof when $\mathfrak{g}$ is simple, especially $\mathfrak{o s p}_{1 \mid 2 n}$, following [FGZ].

Remark 3.4. By the restriction (3.1), Theorem 3.3 also holds for Wakimoto modules $\mathbb{W}_{\lambda}^{k}[\mathrm{FF} 1, \mathrm{Fr}]$ :

$$
H_{\mathrm{rel}}^{\frac{\infty}{2}+n}\left(\mathfrak{g}, \mathbb{W}_{\lambda}^{k} \otimes \mathbb{W}_{\mu}^{\ell}\right) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+n}\left(\mathfrak{g}, \mathbb{W}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right) \simeq \delta_{n, 0} \delta_{\lambda, \mu^{\dagger}} \mathbb{C}\left[\operatorname{str}_{\mu}\right]
$$

since $\mathbb{W}_{\lambda}^{k} \simeq \operatorname{Ind} \mathfrak{g}_{\mathfrak{g}[t] \oplus \mathbb{C} K}^{\widehat{\mathfrak{g}}_{k}} M_{\lambda}^{\vee}$ for $k \in \mathbb{C} \backslash \mathbb{Q}$. Here $M_{\lambda}^{\vee}$ is the contravariant Verma module of $\mathfrak{g}$ with highest weight $\lambda$.
3.2. Bilinear form. Let $V$ be an arbitrary vertex superalgebra and suppose that we have parity-homogeneous elements $a_{i}, \phi_{i}(i=1,2)$ of $V$ satisfying the OPEs

$$
a_{1}(z) a_{2}(w) \sim \frac{\alpha}{(z-w)^{N}}+\cdots, \quad b_{1}(z) b_{2}(w) \sim \frac{\beta}{(z-w)^{M}}+\cdots
$$

for some $\alpha, \beta \in \mathbb{C}$ and $N, M \geq 0$. Here we mean by "..." the terms of lower order poles with respect to $(z-w)$. Then by using e.g. the $\lambda$-bracket formalism [DK], it is straightforward to show the OPE of the fields $Y\left(a_{i(-1)} b_{i}, z\right)(i=1,2)$ has the following shape.

Lemma 3.5. We have

$$
\begin{equation*}
Y\left(a_{1(-1)} b_{1}, z\right) Y\left(a_{2(-1)} b_{2}, w\right) \sim \frac{(-1)^{\bar{a}_{2} \bar{b}_{1}} \alpha \beta}{(z-w)^{N+M}}+\cdots \tag{3.2}
\end{equation*}
$$

Now, let $\mathfrak{g}$ and $\kappa_{i}$ be as in Theorem 3.3 and suppose that we have $\frac{1}{2} \mathbb{Z}$-graded vertex superalgebras

$$
\mathscr{A}_{i}=\bigoplus_{\lambda \in P_{+}} \mathscr{C}_{\lambda}^{i} \otimes \mathbb{V}_{\lambda}^{\kappa_{i}}(\mathfrak{g}), \quad(i=1,2)
$$

such that $\mathscr{C}_{0}^{i}=\oplus_{\Delta \in \frac{1}{2} \mathbb{Z}_{\geq 0}} \mathscr{C}_{0, \Delta}^{i}$ are $\frac{1}{2} \mathbb{Z}_{\geq 0}$ - graded vertex superalgebras with $\mathscr{C}_{0,0}^{i}=\mathbb{C} \mathbf{1}$ and $\mathscr{C}_{\lambda}^{i}$ are all positive energy representations of $\mathscr{C}_{0}^{i}$ with lowest weight subspaces $\mathrm{C}_{\lambda}^{i}$. Then Lemma 3.5 implies that we have bilinear forms

$$
\langle\cdot \mid \cdot\rangle_{\lambda}^{i}:\left(\mathrm{C}_{\lambda}^{i} \otimes L_{\lambda}\right) \otimes\left(\mathrm{C}_{\lambda^{\dagger}}^{i} \otimes L_{\lambda^{\dagger}}\right) \rightarrow \mathbb{C}, \quad(i=1,2)
$$

which are $\mathfrak{g}$-invariant and a bilienar form on the relative semi-infintie cohomolgy $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{g}, \mathscr{A}_{1} \otimes \mathscr{A}_{2}\right) \simeq \bigoplus_{\lambda \in P_{+}} \mathscr{C}_{\lambda}^{1} \otimes$ $\mathscr{C}_{\lambda^{\dagger}}^{2}$ :

$$
\langle\cdot \mid \cdot\rangle_{\lambda}:\left(\mathrm{C}_{\lambda}^{1} \otimes \mathrm{C}_{\lambda^{\dagger}}^{2}\right) \otimes\left(\mathrm{C}_{\lambda^{\dagger}}^{1} \otimes \mathrm{C}_{\lambda}^{2}\right) \rightarrow \mathbb{C} .
$$

Corollary 3.6. If $\langle\cdot \mid \cdot\rangle_{\lambda}^{i}(i=1,2)$ are non-degenerate, then so is $\langle\cdot \mid \cdot\rangle_{\lambda}$.
Proof. By Theorem 3.3, the bilienar form $\langle\cdot \mid \cdot\rangle_{\lambda}$ is the restriction to

$$
\begin{equation*}
\left(\mathrm{C}_{\lambda}^{1} \otimes\left[\operatorname{str}_{\lambda}\right] \otimes \mathrm{C}_{\lambda^{\dagger}}^{2}\right) \otimes\left(\mathrm{C}_{\lambda^{\dagger}}^{1} \otimes\left[\operatorname{str}_{\lambda^{\dagger}}\right] \otimes \mathrm{C}_{\lambda}^{2}\right) \rightarrow \mathbb{C} \tag{3.3}
\end{equation*}
$$

of the bilinear form on the complex

$$
\begin{equation*}
\langle\cdot \mid \cdot\rangle_{\lambda}^{1} \otimes\langle\cdot \mid \cdot\rangle_{\lambda^{\dagger}}^{2}:\left(\mathrm{C}_{\lambda}^{1} \otimes L_{\lambda} \otimes L_{\lambda^{\dagger}} \otimes \mathrm{C}_{\lambda^{\dagger}}^{2}\right) \otimes\left(\mathrm{C}_{\lambda^{\dagger}}^{1} \otimes L_{\lambda^{\dagger}} \otimes L_{\lambda} \otimes \mathrm{C}_{\lambda}^{2}\right) \rightarrow \mathbb{C} \tag{3.4}
\end{equation*}
$$

by Lemma 3.5. Note that (3.4) is a $(\mathfrak{g}, \mathfrak{g})$-invariant bilinear form and that the restriction (3.3) is exactly to the diagonal $\mathfrak{g}$-invariant subspace. Since $\mathfrak{g}$-invarinat bilinear forms $L_{\mu} \otimes L_{\nu} \rightarrow \mathbb{C}$ is zero unless $\mu=\nu^{\dagger}$, the non-degeneracy of (3.4) implies that of (3.3).

## 4. Duality in hook-type $\mathcal{W}$-superalgebras

4.1. Hook-type $\mathcal{W}$-superalgebras. Let $\mathfrak{g}$ and $\kappa$ be as in $\S 2.1, f \in \mathfrak{g}_{\overline{0}}$ a nilpotent element, and $\Gamma: \mathfrak{g}=$ $\bigoplus_{j \in \frac{1}{2} \mathbb{Z}} \mathfrak{g}_{j}$ a $\frac{1}{2} \mathbb{Z}$-grading on $\mathfrak{g}$ good for $f$. Then one can define the $\mathcal{W}$-superalgebra $\mathcal{W}^{\kappa}(\mathfrak{g}, f ; \Gamma)$ associated with $\mathfrak{g}, f, \kappa$ and $\Gamma$ via the (generalized) Drinfeld-Sokolov reduction from $V^{\kappa}(\mathfrak{g})$, [FF2, KRW].

Hook-type $\mathcal{W}$-superalgebras [CL1, CL2] are $\mathcal{W}$-superalgebras such that $f$ is principal inside an subalgebra $\mathfrak{a}$ whose centralizer $\mathfrak{b}=\mathfrak{z} \mathfrak{a}(\mathfrak{g})$ satisfies the following property: $\mathfrak{g}$ decomposes as a $\mathfrak{a} \oplus \mathfrak{b}$-module into

$$
\mathfrak{g} \simeq \begin{cases}(\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}}^{\dagger} \oplus \rho_{\mathfrak{a}}^{\dagger} \otimes \rho_{\mathfrak{b}} & \text { if } \mathfrak{g}=\mathfrak{s l}_{n \mid m} \\ (\mathfrak{a} \oplus \mathfrak{b}) \oplus \rho_{\mathfrak{a}} \otimes \rho_{\mathfrak{b}} & \text { if } \mathfrak{g}=\mathfrak{o s p}_{n \mid 2 m}\end{cases}
$$

In this paper, we consider hook-type $\mathcal{W}$-superalgebras listed in Table 4 below. The $\mathcal{W}$-superalgebra $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ contains $V^{k_{\mathfrak{b}}}(\mathfrak{b})$ as the maximal affine vertex subalgebra. We denote its coset algebra by

$$
C_{X^{ \pm}}^{k}(n, m)=\operatorname{Com}\left(V^{k_{\mathfrak{b}}}(\mathfrak{b}), \mathcal{W}_{X^{ \pm}}^{k}(n, m)\right) .
$$

For $X=B$ (resp. $D, O$ ), the $\mathcal{W}$-superalgebra $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ has an automorphism group $O_{2 m+1}$ (resp. $O_{2 m}$, $O S p_{1 \mid 2 m}$ ), which is induced by their adjoint action on $\mathfrak{g}$. They give rise to an automorphism group $\mathbb{Z}_{2} \simeq$ $O_{2 m+1} / S O_{2 m+1}$ (resp. $O_{2 m} / S O_{2 m}, O S p_{1 \mid 2 m} / S O S p_{1 \mid 2 m}$ ) on $C_{X^{ \pm}}^{k}(n, m)$. We set

$$
D_{X^{ \pm}}^{k}(n, m)= \begin{cases}C_{X^{ \pm}}^{k}(n, m), & \text { if } X=A, C \\ C_{X^{ \pm}}^{k}(n, m)^{\mathbb{Z}_{2}}, & \text { if } X=B, D, O .\end{cases}
$$

Then $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ satisfies the following properties:
(P1) It has a free strong generating set of type

$$
\begin{cases}\mathcal{W}\left(1^{\operatorname{dim} \mathfrak{b}}, e_{1}, e_{2}, \cdots, e_{\mathrm{rank} \mathfrak{a}},\left(\frac{\operatorname{dim} \rho_{\mathfrak{a}}+1}{2}\right)^{2 \operatorname{dim} \rho_{\mathfrak{b}}}\right) & \text { if } X=A \\ \mathcal{W}\left(1^{\operatorname{dim} \mathfrak{b}}, e_{1}, e_{2}, \cdots, e_{\mathrm{rank} \mathfrak{a}},\left(\frac{\operatorname{dim} \rho_{\mathfrak{a}}+1}{2}\right)^{\operatorname{dim} \rho_{\mathfrak{b}}}\right) & \text { if } X=B, C, D, O\end{cases}
$$

The first $\operatorname{dim} \mathfrak{b}$ elements of conformal dimension $\Delta=1$ correspond to a basis of $\mathfrak{b}$ and generate $V^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$. The second set which we denote by $S_{\text {coset }}=\left\{W_{X^{ \pm}}^{i} \mid i=e_{1}, e_{2}, \cdots, e_{\text {rank } \mathfrak{a}}\right\}$ are all even and have conformal weights $\Delta=e_{1}, e_{2}, \cdots, e_{\text {rank }} \mathfrak{a}$, which are exponents of $\mathfrak{a}$ shifted by one. They form a strong generating set of $C_{X^{ \pm}}^{k}(n, m)$ and $W_{X^{ \pm}}^{2}$ is the conformal vector of $C_{X^{ \pm}}^{k}(n, m)$. The third set which we denote $S_{\text {nat }} \sqcup S_{\text {nat }}^{\dagger}$ (resp. $S_{\text {nat }}$ ) if $X=A$ (resp. if $X=B, C, D, O$ ), corresponds to a standard basis of $\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}$ (resp. $\rho_{\mathfrak{b}}$ ). They span a vector subspace $V_{\text {nat }} \oplus V_{\text {nat }}^{\dagger}=\mathbb{C} S_{\text {nat }} \oplus \mathbb{C} S_{\text {nat }}^{\dagger}$ (resp. $V_{\text {nat }}=\mathbb{C} S_{\text {nat }}$ ) whose parity and conformal weight $\Delta_{\rho}$ are as in Table 5 and generate Weyl modules $\mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b}) \oplus \mathbb{V}_{\rho_{\mathfrak{b}}^{\dagger}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$ (resp. $\left.\mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})\right)$.
(P2) For $k \in \mathbb{C} \backslash \mathbb{Q}$, we may normalize the elements of $S_{\text {nat }} \sqcup S_{\text {nat }}^{\dagger}$ (resp. $S_{\text {nat }}$ ) so that the bilinear form

$$
V_{\text {nat }} \otimes V_{\text {nat }} \rightarrow \mathbb{C}, \quad(a, b) \mapsto a_{\left(2 \Delta_{\rho}-1\right)} b
$$

coincides with the natural $\mathfrak{b}$-invariant bilinear form

$$
\begin{cases}\langle\cdot \cdot \cdot\rangle:\left(\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}\right) \otimes\left(\rho_{\mathfrak{b}} \oplus \rho_{\mathfrak{b}}^{\dagger}\right) \rightarrow \mathbb{C} & \text { if } X=A \\ \langle\cdot \mid \cdot\rangle: \rho_{\mathfrak{b}} \otimes \rho_{\mathfrak{b}} \rightarrow \mathbb{C} & \text { if } X=B, C, D, O\end{cases}
$$

Then the elements in $S_{\text {nat }} \sqcup S_{\text {nat }}^{\dagger}$ (resp. $S_{\text {nat }}$ ) satisfy the OPEs of the form

$$
A(z) B(w) \sim \frac{\langle A \mid B\rangle}{(z-w)^{2 \Delta_{\rho}}}+\cdots
$$

Theorem 4.1 ([CL1, CL2]). If $k \in \mathbb{C} \backslash \mathbb{Q}$, then the vertex superalgebra $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ is the unique vertex superalgebra extension of $D_{X^{ \pm}}^{k}(n, m) \otimes V^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$ satisfying the properties (P1) and (P2).

The proof in loc. cit ([CL1, Theorem 9.1] for $X=A$ and [CL2, Theorem 6.3$]$ for $X=B, C, D, O$ ) only uses (P2) together with the following property which is implied by (P1):
$\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ is an extension of $D_{X^{ \pm}}^{k}(n, m) \otimes V^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$ by modules

$$
\begin{cases}M_{A^{ \pm}}^{+} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b}) \oplus M_{A^{ \pm}}^{-} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}^{+}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b}) & \text { if } X=A, \\ M_{X^{ \pm}} \otimes \mathbb{V}_{\rho_{\mathfrak{b}}}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b}) & \text { if } X=B, C, D, O,\end{cases}
$$

whose lowest conformal weight subspace coincides with $V_{\text {nat }}$ of the same parity and conformal weight as in Table 5. Moreover, the lower conformal weight subspaces

$$
\bigoplus_{i=0}^{e_{\text {rank }} \mathfrak{a}} M_{A^{ \pm}, \Delta_{\rho}+i}^{ \pm}, \quad \bigoplus_{i=0}^{e_{\text {rank }} \mathfrak{a}} M_{X^{ \pm}, \Delta_{\rho}+i}
$$

$(X=B, C, D, O)$ has a PBW basis in terms of $W_{X^{ \pm}(-n)}^{2}, W_{X^{ \pm}(-n-1)}^{i}$, for $n \geq 0$ and $i=e_{2}, e_{3}, \cdots, e_{\text {rank } \mathfrak{a}}$. Suppose $k \in \mathbb{C} \backslash \mathbb{Q}$. Since $\mathbf{K L}_{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$ is semisimple, $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ decomposes into

$$
\begin{equation*}
\mathcal{W}_{X^{ \pm}}^{k}(n, m) \simeq \bigoplus_{\lambda \in P_{+}} \mathcal{C}_{X^{ \pm}}^{k}(\lambda) \otimes \mathbb{V}_{\lambda}^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b}) \tag{4.1}
\end{equation*}
$$

as $C_{X^{ \pm}}^{k}(n, m) \otimes V^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$-modules. Here $\mathcal{C}_{X^{ \pm}}^{k}(\lambda)$ is the $C_{X^{ \pm}}^{k}(n, m)$-module consisting of highest weight vectors of $V^{k_{\mathfrak{b}}^{ \pm}}(\mathfrak{b})$ of highest weight $\lambda$ appearing in $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$. It follows from (P1) and the character computation that

$$
\begin{equation*}
\left\{\lambda \in P_{+} \mid \mathcal{C}_{X^{+}}^{\lambda} \neq 0\right\}=\left\{\lambda \in P_{+} \mid \mathcal{C}_{X^{-}}^{\lambda} \neq 0\right\}=R \tag{4.2}
\end{equation*}
$$

see [CL1, Theorem 4.11, Remark 4.1] for a proof in the case $X=A$ which holds also for $X=B, C, D, O$. In the case $X=A$, we use the decomposition

$$
V^{k_{\mathfrak{b}}^{ \pm}}\left(\mathfrak{g l}_{m}\right) \simeq V^{k_{\mathfrak{b}}^{ \pm}}\left(\mathfrak{s l}_{m}\right) \otimes \pi^{ \pm}
$$

where $\pi^{ \pm}$is the Heisenberg vertex algebra generated by a field $h^{ \pm}(z)$ which corresponds to Id in the decomposition $\mathfrak{g l}_{m}=\mathfrak{s l}_{m} \oplus \mathbb{C}$ Id. It satisfies the OPE

$$
h^{+}(z) h^{+}(w) \sim \frac{-m+\frac{m n}{n+m}\left(k+h_{A^{+}}^{\vee}\right)}{(z-w)^{2}}, \quad h^{-}(z) h^{-}(w) \sim \frac{m-\frac{m(n+m)}{n}\left(k+h_{A^{-}}^{\vee}\right)}{(z-w)^{2}}
$$

respectively.
Proposition 4.2. If $\mathfrak{g}$ is a Lie algebra (resp. Lie superalgebra), then
(1) $\left(\left[\mathrm{CL} 1\right.\right.$, Theorem 3.6]) $\mathcal{W}_{X^{ \pm}}^{k}(n, m)$ is simple for all (resp. generic) $k \in \mathbb{C} \backslash \mathbb{Q}$.
(2) The coset $C_{X^{ \pm}}^{k}(n, m)$ is simple for all (resp. generic) $k \in \mathbb{C} \backslash \mathbb{Q}$.
(3) ([CL1, Theorem 4.11]) The multiplicity space $\mathcal{C}_{X^{ \pm}}^{k}(\lambda),(\lambda \in R)$, is simple as a $C_{X^{ \pm}}^{k}(n, m)$-module for generic $k \in \mathbb{C} \backslash \mathbb{Q}$.

We note that the second statement (2) follows from (1) by [CGN, Proposition 5.4].
4.2. Duality in $\mathcal{W}_{X \pm}^{k}(n, m)$. Let $(X, Y)$ denote one of the pairs

$$
(A, A), \quad(B, O), \quad(C, C), \quad(D, D), \quad(O, B)
$$

The following statement, which naturally generalizes Feigin-Frenkel duality in the above types, was conjectured by Gaiotto-Rapčák [GR] in the physics literature and proven by two of the authors for generic levels.

Theorem 4.3 ([CL1, CL2]).
For generic $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$, there is an isomorphism of vertex algebras

$$
\begin{equation*}
D_{X^{+}}^{k}(n, m) \simeq D_{Y^{-}}^{\ell}(n, m) \tag{4.3}
\end{equation*}
$$

if $(k, \ell)$ satisfies the relation

$$
\begin{equation*}
r_{X}\left(k+h_{X^{+}}^{\vee}\right)\left(\ell+h_{Y^{-}}^{\vee}\right)=1 \tag{4.4}
\end{equation*}
$$

with $r_{X}$ given in Table 6. Moreover, if $X^{+}=A^{+}, B^{+}, C^{+}, D^{+}$, then (4.3) holds for all $k \in \mathbb{C} \backslash \mathbb{Q}$.
Proof. Since the second statement is essentially obtained in the proof of [CL1, CL2] for generic case, we only sketch the proof. By the same proof in loc. cit, $D_{X^{+}}^{k}(n, m)$ and $D_{Y^{-}}^{\ell}(n, m)$ are quotients of the two-parameter $\mathcal{W}_{\infty}$-algebra $\mathcal{W}(c, \lambda)$ constructed in [L] (resp. even spin $\mathcal{W}_{\infty}$-algebra $\mathcal{W}^{\mathrm{ev}}(c, \lambda)$ in [KL]) if $X=A$ (resp. $X=$ $B, C, D, O)$ with the same specialization for $(c, \lambda)$. Then it follows that the simple quotients of $D_{X^{+}}^{k}(n, m)$ and $D_{Y^{-}}^{\ell}(n, m)$ are isomorphic as vertex algebras. On the other hand, by Proposition $4.2(2), C_{X^{+}}^{k}(n, m)$ is simple as a vertex algebra and thus so is $D_{X^{+}}^{k}(n, m)$ by [DLM]. Therefore, we have a surjective homomorphism $D_{Y^{-}}^{\ell}(n, m) \rightarrow D_{X^{+}}^{k}(n, m)$ of vertex algebras, which is an isomorphism for generic $k \in \mathbb{C} \backslash \mathbb{Q}$. Since their $q$ characters are the same for all $k, \ell \in \mathbb{C} \backslash \mathbb{Q}, D_{Y^{-}}^{\ell}(n, m) \xrightarrow{\simeq} D_{X^{+}}^{k}(n, m)$ holds for all $k \in \mathbb{C} \backslash \mathbb{Q}$.

In the remainder of this subsection, the statements for type $X=B, O$ with $m>1$ are understood under the assumption of the existence of $A^{ \pm 1}\left[\mathfrak{s o}_{2 m+1}, k\right]=A^{ \pm 1}\left[\mathfrak{o s p}_{1 \mid 2 m}, \ell\right]$. The main results of this paper is the following theorem conjectured by two of the authors [CL1, CL2]:
Theorem 4.4. For $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$ under (4.4), there exist isomorphisms of vertex superalgebras

$$
\begin{align*}
& \mathcal{W}_{Y^{-}}^{\ell}(n, m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n, m) \otimes A^{1}\left[\mathfrak{b}, \alpha_{+}\right]\right)  \tag{4.5}\\
& \mathcal{W}_{X^{+}}^{k}(n, m) \simeq H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n, m) \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right), \tag{4.6}
\end{align*}
$$

where $\left(\alpha_{+}, \alpha_{-}\right)$are given by

$$
\alpha_{+}=-p_{+}\left(k+h_{X^{+}}^{\vee}\right)+q_{+}-h_{\mathfrak{b}}^{\vee}, \quad \alpha_{-}=p_{-}\left(\ell+h_{Y^{-}}^{\vee}\right)-q_{-}-h_{\mathfrak{b}}^{\vee}
$$

with $\left(p_{ \pm}, q_{ \pm}\right)$as in Table 7 below.

We will give a proof of Theorem 4.4 in $\S 4.3$. By taking the affine cosets of both hand sides (4.5), we obtain the following improvement of Theorem 4.3:
Corollary 4.5. For $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$ under (4.4), there exists an isomorphism of vertex algebras

$$
C_{X^{+}}^{k}(n, m) \simeq C_{Y^{-}}^{\ell}(n, m)
$$

Actually, this corollary will be obtained in the proof of Theorem 4.4.
Corollary 4.6. For $Y=A, C, D, O, \mathcal{W}_{Y^{-}}^{\ell}(n, m)$ is simple for all $\ell \in \mathbb{C} \backslash \mathbb{Q}$.
Proof. Take a nonzero ideal $\mathscr{I}$ of $\mathcal{W}_{Y^{-}}^{\ell}(n, m)$. Since $\mathbf{K L}_{\ell_{\mathfrak{b}}^{-}}(\mathfrak{b})$ is semisimple, $\mathscr{I}$ decomposes into

$$
\mathscr{I}=\bigoplus_{\lambda \in R} \mathscr{I}_{\lambda} \otimes \mathbb{V}_{\lambda}^{\ell_{\mathfrak{b}}^{-}}(\mathfrak{b})
$$

under (4.1) for some $C_{Y^{-}}^{\ell}(n, m)$-submodules $\mathscr{I}_{\lambda} \subset \mathcal{C}_{Y^{-}}^{\ell}(\lambda)$. Applying the functor $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, ? \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right)$, we obtain a nonzero ideal

$$
\mathscr{J}=H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathscr{I} \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right) \simeq \bigoplus_{\lambda \in R} \mathscr{I}_{\lambda} \otimes \mathbb{V}_{\lambda}^{k_{\mathfrak{b}}^{+}}(\mathfrak{b})
$$

of $\mathcal{W}_{X^{+}}^{k}(n, m)$ by Theorem 4.4. It follows from Proposition $4.2(1)$ that $\mathscr{J}=\mathcal{W}_{X^{+}}^{k}(n, m)$ and thus $\mathscr{I}=$ $\mathcal{W}_{Y^{-}}^{\ell}(n, m)$.
4.3. Proof of Theorem 4.4. It is immediate from the equality

$$
k_{\mathfrak{b}}^{+}+\alpha_{+}=-2 h_{\mathfrak{b}}^{\vee}=\ell_{\mathfrak{b}}^{-}+\alpha_{-}
$$

that we may apply $H_{\mathrm{rel}}^{\frac{\infty}{2}+0}(\mathfrak{b}, \cdot)$ in the right-hand side of (4.5) and (4.6) except for $H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{g l}_{1}, \cdot\right)$ appearing in $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{g l}_{m}, \cdot\right)$. The case $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{g l}_{1}, \cdot\right)$ follows from the isomorphism of Heisenberg vertex algebras

$$
\begin{array}{ccc}
\pi^{\sqrt{-1}} h^{ \pm} \otimes \pi^{h^{\mp}} & \simeq & \pi^{\alpha} \sqrt{ \pm m} \otimes \pi^{\alpha \sqrt{ \pm m}} \\
\sqrt{-1} h^{ \pm}(z) \otimes 1 & \mapsto & \alpha_{\sqrt{ \pm m}}(z) \otimes 1 \mp u^{ \pm} \otimes \alpha_{\sqrt{ \pm m}}(z) \\
1 \otimes h^{\mp}(z) & \mapsto & -\alpha_{\sqrt{ \pm m}}(z) \otimes 1 \mp u^{\mp} \otimes \alpha_{\sqrt{ \pm m}}(z),
\end{array}
$$

where $u=\sqrt{\frac{-n}{m+n}\left(k+h_{A^{+}}^{\vee}\right)}$ and thus $u^{-1}=\sqrt{\frac{m+n}{-n}\left(\ell+h_{A^{-}}^{\vee}\right)}$. Here $\alpha_{\sqrt{ \pm m}}(z)$ is the Heisenberg field satisfying the OPE $\alpha_{\sqrt{ \pm m}}(z) \alpha_{\sqrt{ \pm m}}(w) \sim \pm m /(z-w)^{2}$. It induces the isomorphisms of their Fock modules

$$
\pi_{a}^{\alpha \sqrt{ \pm m}} \otimes \pi^{\alpha} \sqrt{ \pm m} \simeq \pi_{a}^{\sqrt{-1} h^{ \pm}} \otimes \pi_{-a}^{h^{\mp}}, \quad(a \in \mathbb{C})
$$

By using Theorem 3.3, we obtain, case by case, isomorphisms

$$
\begin{aligned}
& H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n, m) \otimes A^{1}\left[\mathfrak{b}, \alpha_{+}\right]\right) \simeq \bigoplus_{\lambda \in R} \mathcal{C}_{X^{+}}^{k}(\lambda) \otimes \mathbb{V}_{s_{\lambda}}^{\ell_{s_{\mathfrak{b}}}}\left({ }^{s} \mathfrak{b}\right), \\
& H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n, m) \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right) \simeq \bigoplus_{\lambda \in R} \mathcal{C}_{Y^{-}}^{\ell}(\lambda) \otimes \mathbb{V}_{s_{\lambda}}^{k_{s_{\mathfrak{b}}}^{+}}\left({ }^{s} \mathfrak{b}\right)
\end{aligned}
$$

 $D_{Y^{-}}^{\ell}(n, m) \otimes V^{\ell_{\mathfrak{b}}^{-}}(\mathfrak{b}) \subset \mathcal{W}_{Y^{-}}^{\ell}(n, m)\left(\right.$ resp. $\left.D_{X^{+}}^{k}(n, m) \otimes V^{k_{\mathfrak{b}}^{+}}(\mathfrak{b}) \subset \mathcal{W}_{X^{+}}^{k}(n, m)\right)$ by Theorem 4.3.

Finally, we apply Theorem 4.1 to complete the proof. By Theorem 3.3, we may associate with $A \in \rho_{s_{\mathfrak{b}}}$ or $\rho_{s_{\mathfrak{b}}}^{\dagger}$ the following (nonzero) cohomology class

$$
\left[\operatorname{str}_{\rho_{\mathfrak{b}}} \otimes A\right], \quad\left[\operatorname{str}_{\rho_{\mathfrak{b}}^{\dagger}} \otimes A\right],
$$

respectively. Let $\widehat{A}$ denote the above cohomology class. By using Table 3 and 5 , we find case by case that the parity and conformal dimension of $\widehat{A}$ agree with those of $S_{\text {nat }}$ and $S_{\text {nat }}^{\dagger}$ for $\mathcal{W}_{Y^{-}}^{\ell}(n, m)$ and $\mathcal{W}_{X^{+}}^{k}(n, m)$, respectively. Then it follows from Corollary 3.6 that the pairing for the cohomology classes $\widehat{A},\left(A \in \rho_{s \mathfrak{b}}, \rho_{s \mathfrak{b}}^{\dagger}\right)$, is non-degenerate by Theorem 4.1 and Lemma 2.3.

We first complete the proof of (4.6). Since $m \geq 0$, the PBW basis property implied by (P1) for $\mathcal{W}_{Y^{-}}^{\ell}(n, m)$ implies that of $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n, m) \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right)$. Then by Theorem 4.1, we have a nonzero homomorphism of vertex superalgebras

$$
\begin{equation*}
\mathcal{W}_{X^{+}}^{k}(n, m) \rightarrow H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{Y^{-}}^{\ell}(n, m) \otimes A^{-1}\left[\mathfrak{b}, \alpha_{-}\right]\right) . \tag{4.7}
\end{equation*}
$$

By Proposition 4.2 (1), it is injective and thus $\mathcal{C}_{X^{+}}^{k}(\lambda) \hookrightarrow \mathcal{C}_{Y^{-}}^{\ell}\left({ }^{s} \lambda\right)$ as $D_{X^{+}}^{k}(n, m)$-submodules for all $\lambda \in R$. In particular, we have $C_{X^{+}}^{k}(n, m) \hookrightarrow C_{Y^{-}}^{\ell}(n, m)$. In the case $X=A, C$, this is indeed an isomorphism by Theorem 4.3. In the case $X=B, C, O$, these coset algebras are second order extensions of the same algebra $D_{X^{+}}^{k}(n, m) \simeq D_{Y^{-}}^{\ell}(n, m)$ by Theorem 4.3 and therefore $C_{X^{+}}^{k}(n, m) \simeq C_{Y^{-}}^{\ell}(n, m)$ as well. Now, if $k \in \mathbb{C} \backslash \mathbb{Q}$ is generic, then it follows from Proposition 4.2 (3) that $\mathcal{C}_{X^{+}}^{k}(\lambda) \hookrightarrow \mathcal{C}_{Y^{-}}^{\ell}\left({ }^{s} \lambda\right)$ is indeed an isomorphism of $C_{X^{+}}^{k}(n, m)$-modules. Hence, the $q$-characters of $\mathcal{C}_{X^{+}}^{k}(\lambda)$ and $\mathcal{C}_{Y^{-}}^{\ell}\left({ }^{s} \lambda\right)$ coincide. Since the $q$-characters are all equal for $k, \ell \in \mathbb{C} \backslash \mathbb{Q}, \mathcal{C}_{X^{+}}^{k}(\lambda) \simeq \mathcal{C}_{Y^{-}}^{\ell}\left({ }^{s} \lambda\right)$ holds for all $k \in \mathbb{C} \backslash \mathbb{Q}$. Therefore, (4.7) is an isomorphism of vertex algebras for all $k \in \mathbb{C} \backslash \mathbb{Q}$. This completes the proof of (4.6). In particular, it follows that $\mathcal{C}_{X^{+}}^{k}\left(\rho_{\mathfrak{b}}\right)$ (and $\mathcal{C}_{X^{+}}^{k}\left(\rho_{\mathfrak{b}}^{\dagger}\right)$ for $X=A$ ) has the PBW basis property implied by (P1) as a $D_{Y^{-}}^{\ell}(n, m)$-module. Then we may apply Theorem 4.1 and obtain a (nonzero) homomorphism of

$$
\mathcal{W}_{Y^{-}}^{\ell}(n, m) \rightarrow H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{b}, \mathcal{W}_{X^{+}}^{k}(n, m) \otimes A^{1}\left[\mathfrak{b}, \alpha_{+}\right]\right)
$$

vertex superalgebras. It follows from (4.6) and Theorem 3.3 that it is an isomorphism as $D_{Y^{-}}^{\ell}(n, m) \otimes V^{\ell_{\mathfrak{b}}^{-}}(\mathfrak{b})$ modules and thus as vertex superalgebras. This completes the proof of (4.5).

## Appendix A. Proof of Theorem 3.3

In this appendix, we prove Theorem 3.3 when $\mathfrak{g}$ is simple. We set $\kappa_{1}=k \kappa_{0}, \kappa_{2}=\ell \kappa_{0}$ by using the normalized invariant bilinear form $\kappa_{0}$ and thus $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$. We will use the decompositions of the loop algebra $\mathrm{L} \mathfrak{g}=\mathfrak{g}\left[t^{ \pm 1}\right]=\mathrm{L}^{+} \mathfrak{g} \oplus \mathfrak{g}\left[t^{-1}\right]=\mathfrak{g}[t] \oplus \mathrm{L}^{-} \mathfrak{g}$ with $\mathrm{L}^{ \pm} \mathfrak{g}=\mathfrak{g}\left[t^{ \pm 1}\right] t^{ \pm 1}$.
A.1. Spectral sequences. In order to prove Theorem 3.3, we consider spectral sequences in general setting. Given an object $M=\bigoplus_{\Delta \in \mathbb{Z}} M_{\Delta}$ in $\mathbf{K L}_{-2 h^{\vee}}$, let us write $\mathscr{C} \bullet(M)=C^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)\left(\operatorname{resp} . \mathscr{C}_{\text {rel }}^{\bullet}(M)=C_{\text {rel }}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)\right)$ and introduce on it a filtration $F_{\bullet} \mathscr{C}^{\bullet}(M)$ in the following way: we define a grading $\mathscr{C} \bullet(M)=\bigoplus_{\Delta_{F} \in \mathbb{Z}} \mathscr{C}_{\Delta_{F}}^{\bullet}(M)$ by setting

The filtration $F_{\bullet} \mathscr{C}^{\bullet}(M)$ is decreasing, exhausitive and separated, i.e. satisfies $F_{p} \mathscr{C} \bullet(M) \supset F_{p+1} \mathscr{C} \bullet(M)$, $\cup_{p} F_{p} \mathscr{C}^{\bullet}(M)=\mathscr{C}^{\bullet}(M)$ and $\cap_{p} F_{p} \mathscr{C}^{\bullet}(M)=0$, respectively. Since the differential $d$ preserves the filtration $d: F_{p} \mathscr{C} \bullet(M) \rightarrow F_{p} \mathscr{C}^{\bullet}(M)$, we have the assoicated spectral sequence

Note that by Remark 3.1, the spectral sequence converges. The induced differential decomposes into $\operatorname{gr}_{F} d=$ $d_{1}^{F}+d_{2}^{F}$ with

d_{2}^{F} & =-\frac{1}{2} \sum_{p, q>0}(-1)^{\bar{x}_{i} \bar{x}_{k}+\bar{x}_{i}+\bar{x}_{j}} c_{i, j}^{k} \varphi_{k,-p-q} \frac{\partial}{\partial \varphi_{i,-p}} \frac{\partial}{\partial \varphi_{j,-q}} . \tag{A.3}
\end{align*}
$$

Then it follows that the complex $\left(\operatorname{gr}_{F} \mathscr{C} \bullet(M), \operatorname{gr}_{F} d\right)$ decomposes into the tensor product

\left(\operatorname{gr}_{F} \mathscr{C}^{\bullet}(M), \operatorname{gr}_{F} d\right) \simeq\left(M \otimes \bigwedge \partial^{n} \varphi_{i}^{*}, d_{1}^{F}\right) \otimes\left(\mathbb{C} \otimes \bigwedge \partial^{n} \varphi_{i}, d_{2}^{F}\right)
$$

and that the first component in the right-hand side is nothing but the Chevalley-Eilenberg cochain complex of $\mathfrak{g}[t]$ with coefficients in $M$ and the second component the chain complex of $\mathrm{L}^{-} \mathfrak{g}$ with coefficients in $\mathbb{C}$. Therefore, $E_{1}^{F} \simeq H^{\bullet}(\mathfrak{g}[t], M) \otimes H_{\bullet}\left(\mathrm{L}^{-} \mathfrak{g}, \mathbb{C}\right)$.

By restricting $F_{\bullet} \mathscr{C}^{\bullet}(M)$ to $\mathscr{C}_{\text {rel }}^{\bullet}(M)$, namely, $F_{p} \mathscr{C}_{\text {rel }}^{\bullet}(M)=\mathscr{C}_{\text {rel }}^{\bullet}(M) \cap F_{p} \mathscr{C}^{\bullet}(M)$, we obtain a similar spectral sequence

with $\operatorname{gr}_{F} d=d_{1, \text { rel }}^{F}+d_{2}^{F}$ where

d_{1, \mathrm{rel}}^{F}=\sum_{n>0}(-1)^{\bar{x}_{i}} x_{i, n} \varphi_{i,-n}^{*}-\frac{1}{2} \sum_{p, q>0}(-1)^{\bar{x}_{i} \bar{x}_{k}} c_{i, j}^{k} \varphi_{i,-p}^{*} \varphi_{j,-q}^{*} \frac{\partial}{\partial \varphi_{k,-p-q}^{*}}
$$

In this case, we have

E_{1, \text { rel }}^{F} & =H^{\bullet}\left(\left(\left(M \otimes \bigwedge \partial^{n+1} \varphi_{i}^{*}, d_{1, \text { rel }}^{F}\right) \otimes\left(\mathbb{C} \otimes \bigwedge \partial^{n} \varphi_{i}, d_{2}^{F}\right)\right)^{\mathfrak{g}}\right) \\
& \simeq H^{\bullet}\left(\left(M \otimes \bigwedge \partial^{n+1} \varphi_{i}^{*}, d_{1, \text { rel }}^{F}\right) \otimes\left(\mathbb{C} \otimes \bigwedge \partial^{n} \varphi_{i}, d_{2}^{F}\right)\right)^{\mathfrak{g}} \\
& =\left(H^{\bullet}\left(\mathrm{L}^{+} \mathfrak{g}, M\right) \otimes H_{\bullet}\left(\mathrm{L}^{-} \mathfrak{g}, \mathbb{C}\right)\right)^{\mathfrak{g}} .
\end{aligned}
$$

Here in the second line, we have used the commutativity of taking cohomology and $\mathfrak{g}$-invariant subspace, which follows from the complete reducibility of integrable $\mathfrak{g}$-modules.

Next, we introduce another filtration $G_{\bullet} \mathscr{C}^{\bullet}(M)$ on $\mathscr{C}^{\bullet}(M)$ in the following way: we define a grading $\Delta_{G}$ in the following way: we replace (A.1) with

Again, the filtration $G_{\bullet} \mathscr{C}^{\bullet}(M)$ is decreasing, exhausitive and separated. Since $d$ preserves the filtration, we have the associated spectral sequence

E_{1}^{G}=H^{\bullet}\left(\operatorname{gr}_{G} \mathscr{C}^{\bullet}(M), \operatorname{gr}_{G} d\right) \Rightarrow E_{\infty}^{G}=\operatorname{gr}_{G} H^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M)
$$

with $\operatorname{gr}_{G} d=d_{1}^{G}+d_{2}^{G}$ where

d_{1}^{G} & =\sum_{n \geq 0}(-1)^{\bar{x}_{i}} x_{i,-n} \varphi_{i, n}^{*}-\frac{1}{2} \sum_{p, q \geq 0}(-1)^{\bar{x}_{i} \bar{x}_{k}} c_{i, j}^{k}: \varphi_{i, p}^{*} \varphi_{j, q}^{*} \varphi_{k,-p-q}: \\
d_{2}^{G} & =-\frac{1}{2} \sum_{p, q>0}(-1)^{\bar{x}_{i} \bar{x}_{k}} c_{i, j}^{k} \varphi_{i,-p}^{*} \varphi_{j,-q}^{*} \frac{\partial}{\partial \varphi_{k,-p-q}^{*}} \tag{A.4}
\end{align*}

In this case, the complex $\left(\operatorname{gr}_{G} \mathscr{C}^{\bullet}(M), \mathrm{gr}_{G} d\right)$ decomposes into

\left(\operatorname{gr}_{G} \mathscr{C}^{\bullet}(M), \operatorname{gr}_{G} d\right) \simeq\left(M \otimes \bigwedge \varphi_{i}^{*}, \partial^{n} \varphi_{i}, d_{1}^{G}\right) \otimes\left(\mathbb{C} \otimes \bigwedge \partial^{n+1} \varphi_{i}^{*}, d_{2}^{G}\right)
$$

and the second component in the right-hand side is the cochain complex calculating $H^{\bullet}\left(\mathrm{L}^{+} \mathfrak{g}, \mathbb{C}\right)$. Although the first component lacks a clear meaning, by restricting to

we find that the induced differential $d_{1}^{G}$ acts on the first componet by

Thus the first component in the right-hand side is the chain complex calculating $H_{\bullet}\left(\mathrm{L}^{-} \mathfrak{g}, M\right)$. Therefore, we have obtained a convergent spectral sequence with

E_{1, \mathrm{rel}}^{G} \simeq\left(H_{\bullet}\left(\mathrm{L}^{-} \mathfrak{g}, M\right) \otimes H^{\bullet}\left(\mathrm{L}^{+} \mathfrak{g}, \mathbb{C}\right)\right)^{\mathfrak{g}}

To summarize, we have obtained the following proposition.
Proposition A.1. For an object $M$ in $\mathbf{K L}_{-2 h^{\vee}}$, we have convergent spectral sequences

& E_{1, \mathrm{rel}}^{G} \simeq\left(H_{\bullet}\left(\mathrm{L}^{-} \mathfrak{g}, M\right) \otimes H^{\bullet}\left(\mathrm{L}^{+} \mathfrak{g}, \mathbb{C}\right)\right)^{\mathfrak{g}} \Rightarrow E_{\infty}^{G}=\operatorname{gr}_{G} H_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}(\mathfrak{g}, M) .
\end{aligned}

In particular, if $H^{n}\left(\mathrm{~L}^{+} \mathfrak{g}, M\right)=0, H_{n}\left(\mathrm{~L}^{-} \mathfrak{g}, M\right)=0,(n>0)$, then $H_{\mathrm{rel}}^{\frac{\infty}{2}+n}(\mathfrak{g}, M)=0$ holds for $n \neq 0$.
A.2. Pairings between cohomology and homology. We make a digression for pairings between Lie superalgebra cohomology and homology

with $k_{i}=\bar{x}_{1}+\cdots+\bar{x}_{i}+i$. Similarly, the chain complex of $\mathfrak{g}$ with coefficients in $M$ is defined as

Then the pairings induce even pairings

Suppose that we have an even linear isomorphism $\iota: \mathfrak{g}_{2} \xrightarrow{\simeq} \mathfrak{g}_{1}$ and a non-degenerate even pairing $\Psi: M_{1} \otimes M_{2} \rightarrow \mathbb{C}$ (as vector superspaces). Then the condition (A.6) holds if and only if
$(\mathrm{P} 1)^{t}$ is an anti-isomorphism of Lie superalgebras,
(P2) $\Psi$ satisfies $\Psi\left(m_{1} \otimes x . m_{2}\right)=\Psi\left({ }^{t} x . m_{1} \otimes m_{2}\right)\left(x \in \mathfrak{g}_{2}, m_{i} \in M_{i}\right)$.
Proof. It is straightforward to see that (A.6) for $n=0$ is (P2) and then that (A.6) for $n=1$ is (P1). We prove that (P1) and (P2) are sufficient. Suppose $n \geq 2$ and take $f \in \operatorname{Hom}_{\mathbb{C}}\left(\operatorname{Sym}^{n}\left(\Pi_{1}\right), M_{1}\right)$ and $P=$ $\alpha \otimes x_{1} x_{2} \cdots x_{n+1} \in M_{2} \otimes \operatorname{Sym}^{n+1}\left(\Pi \mathfrak{g}_{2}\right)$. Firstly, we have

& \quad+\sum_{1 \leq i<j \leq n+1}(-1)^{\star+A_{i, j}} \Psi\left(f\left(\left[{ }^{t} x_{i},{ }^{t} x_{j}\right]^{t} x_{1} \cdots{ }^{t} \widehat{x}_{i} \cdots{ }^{t} \widehat{x}_{j} \cdots{ }^{t} x_{n+1}\right), \alpha\right) \\
& =\sum_{i=1}^{n+1}(-1)^{\star+A_{i}} \Psi\left(f\left({ }^{t} x_{1} \cdots{ }^{t} \widehat{x}_{i} \cdots^{t} x_{n+1}\right), x_{i} \alpha\right) \\
& \quad+\sum_{1 \leq i<j \leq n+1}(-1)^{\star+A_{i, j}+\bar{x}_{i} \bar{x}_{j}+1} \Psi\left(f\left({ }^{t}\left[x_{i}, x_{j}\right]^{t} x_{1} \cdots{ }^{t} \widehat{x}_{i} \cdots{ }^{t} \widehat{x}_{j} \cdots{ }^{t} x_{n+1}\right), \alpha\right) \\
& =\sum_{i=1}^{n+1}(-1)^{A_{i}+\bar{x}_{i}+\sum_{p}\left(\bar{x}_{p}+1\right) k_{p-1}} \Psi\left(f, x_{i} \alpha \otimes x_{n+1} \cdots \widehat{x}_{i} \cdots x_{1}\right) \\
& \quad+\sum_{1 \leq i<j \leq n+1}(-1)^{\star+A_{i, j}+\bar{x}_{i} \bar{x}_{j}+1} \Psi\left(f, \alpha \otimes x_{n+1} \cdots \widehat{x}_{j} \cdots \widehat{x}_{i} \cdots x_{1}\left[x_{i}, x_{j}\right]\right) \\
& =\sum_{i=1}^{n+1}(-1)^{B_{i}} \Psi\left(f, x_{i} \alpha \otimes x_{1} \cdots \widehat{x}_{i} \cdots x_{n+1}\right) \\
& \quad+\sum_{1 \leq i<j \leq n+1}(-1)^{B_{i, j}} \Psi\left(f, \alpha \otimes\left[x_{i}, x_{j}\right] x_{1} \cdots \widehat{x}_{i} \cdots \widehat{x}_{j} \cdots x_{n+1}\right) \\
& =\Psi_{n}\left(f, \partial_{n+1} P\right) .
\end{aligned}
$$

This completes the proof.
A.3. Proof of Theorem 3.3. The following is well-known.

Proposition A. 6 (e.g. [Fu]). For an arbitrary Lie superalgebra $\mathfrak{g}$, and a free $U(\mathfrak{g})$-module $M$, we have $H_{n}(\mathfrak{g}, M) \simeq \delta_{n, 0} M / \mathfrak{g} M$.

Proof. We include a sketch of proof for the completeness of the paper. Since free modules are inductive limit of direct sums of $U(\mathfrak{g})$ and inductive limit commutes with taking cohomology, we may assume $M=U(\mathfrak{g})$ from the beginning. Then it is straightforward to see $H_{0}(\mathfrak{g}, U(\mathfrak{g})) \simeq U(\mathfrak{g}) / \mathfrak{g} U(\mathfrak{g})(\simeq \mathbb{C})$ and thus it suffices to show $H_{n}(\mathfrak{g}, U(\mathfrak{g}))=0$ for $n \neq 0$. By using a PBW filtration $U_{\leq n}(\mathfrak{g})$, we define the following decreasing filtration on the complex

$$
F_{p} C \bullet(\mathfrak{g}, U(\mathfrak{g}))=\bigoplus_{n+m=p} U_{\leq n}(\mathfrak{g}) \otimes \operatorname{Sym}^{m}(\Pi \mathfrak{g})
$$

The filtration $F_{\bullet} C_{\bullet}(\mathfrak{g}, U(\mathfrak{g}))$ is exhausitive, separated and preserved by the differential. Thus we have the associated spectral sequence

$$
E_{1}=H_{\bullet}\left(\operatorname{gr}_{F} C_{\bullet}(\mathfrak{g}, U(\mathfrak{g})), \operatorname{gr}_{F} \partial\right) \Rightarrow E_{\infty}=\operatorname{gr}_{F} H_{\bullet}(\mathfrak{g}, U(\mathfrak{g}))
$$

which converges since each $C_{n}(\mathfrak{g}, U(\mathfrak{g}))$ is finitely filtered. Now, $\operatorname{gr}_{F} C \bullet(\mathfrak{g}, U(\mathfrak{g}))=\operatorname{Sym}(\mathfrak{g}) \otimes \operatorname{Sym}(\Pi \mathfrak{g})$ with

$$
\operatorname{gr}_{F} \partial: \alpha \otimes x_{1} \cdots x_{n} \mapsto \sum_{i=1}^{n}(-1)^{B_{i}} x_{i} \alpha \otimes x_{1} \cdots \hat{x}_{i} \cdots x_{n}
$$

Then it is straightforward to show that the spectral sequence collapses at the $r=1: E_{1}^{p, q} \simeq \delta_{(p, q),(0,0)} \mathbb{C}$. This completes the proof.

Applying it to the tensor products of Weyl modules as $\mathrm{L}^{-} \mathfrak{g}$-modules, we obtain:
Corollary A.7. For $\lambda, \mu \in P_{+}$and $k, \ell \in \mathbb{C}$, we have
(1) $H_{n}\left(\mathrm{~L}^{-} \mathfrak{g}, \mathbb{V}_{\lambda}^{k}\right) \simeq \delta_{n, 0} L_{\lambda}$,
(2) $H_{n}\left(\mathrm{~L}^{-} \mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)=0(n>0)$.

Next, we will show the analogous statement for the cohomology.
Lemma A.8. For $\lambda \in P_{+}$and $k \in \mathbb{C} \backslash \mathbb{Q}, \mathbb{V}_{\lambda}^{k}$ is simple as a $V^{k}(\mathfrak{g})$-module.
Proof. The proof is the same as the purely even case and thus we only sketch it. Note that $L_{0}=\int T(z) z d z$ acts on $\mathbb{V}_{\lambda}^{k}$ semisimply and the $L_{0}$-eigenspace decomposition is $\mathbb{V}_{\lambda}^{k}=\bigoplus_{n \in \mathbb{Z}_{\geq 0}} \mathbb{V}_{\lambda, \Delta_{\lambda}+n}^{k}$ with $\Delta_{\lambda}=\frac{(\lambda \mid \lambda+2 \rho)}{2\left(k+h^{v}\right)}$. Each $\mathbb{V}_{\lambda, \Delta_{\lambda}+n}^{k}$ is finite dimensional and $\mathbb{V}_{\lambda, \Delta_{\lambda}}^{k}=L_{\lambda}$. Suppose that $\mathbb{V}_{\lambda}^{k}$ has a proper submodule $N$. Then $N$ must have a highest weight vector $v$ and gives rise to a non-zero homomorphism $\mathbb{V}_{\mu}^{k} \rightarrow \mathbb{V}_{\lambda}^{k}$ for some $\mu \in P_{+}$. By considering the $L_{0}$-eigenvalue of $v$, we have $\Delta_{\mu}=\Delta_{\lambda}+n$ for some $n \geq 1$, which contradicts $k \in \mathbb{C} \backslash \mathbb{Q}$. This completes the proof.

To apply Proposition A.5, we use the anti-isomorphism of Lie superalgebras

$$
\begin{aligned}
& \\
&\left.\mathfrak{g}: t^{ \pm 1}\right] \oplus \mathbb{C} K \\
& \rightarrow \\
& X_{n}\left[t^{ \pm 1}\right] \oplus \mathbb{C} K \\
& K \mapsto
\end{aligned}\left(\begin{array}{c}
\iota X)_{-n} \\
\end{array}\right.
$$

where $\iota$ is the Chevalley anti-involution of $\mathfrak{g}$. It is obvious that ${ }^{t}$ restricts to ${ }^{t}: \mathrm{L}^{-} \mathfrak{g} \xrightarrow{\simeq} \mathrm{L}^{+} \mathfrak{g}$. Let $\mathbb{M}_{\lambda}^{k}$ denote the Verma module of $\widehat{\mathfrak{g}}$ generated by a highest weight vector $v_{\lambda, k}$ of highest weight $\lambda+k \Lambda_{0}$ and $\mathbb{M}_{\lambda}^{k} \rightarrow \mathbb{V}_{\lambda}^{k}$ the natural projection. Recall that $\mathbb{M}_{\lambda}^{k}$ has a unique bilinear form

$$
\Psi_{\lambda, k}: \mathbb{M}_{\lambda}^{k} \otimes \mathbb{M}_{\lambda}^{k} \rightarrow \mathbb{C}, \quad v_{\lambda, k} \otimes v_{\lambda, k} \rightarrow 1
$$

which satisfies (P2) in Proposition A.5. It induces a non-degenerate bilinear form on the simple quotient $\Psi_{\lambda, k}: \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\lambda}^{k} \rightarrow \mathbb{C}$ for $k \in \mathbb{C} \backslash \mathbb{Q}$.

Proposition A.9. For $\lambda, \mu \in P_{+}$and $k, \ell \in \mathbb{C} \backslash \mathbb{Q}$, we have
(1) $H^{n}\left(\mathrm{~L}^{+} \mathfrak{g}, \mathbb{V}_{\lambda}^{k}\right) \simeq \delta_{n, 0} L_{\lambda}$,
(2) $H^{n}\left(\mathrm{~L}^{+} \mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)=0(n>0)$.

Proof. (1) is a direct consequence of Proposition A. 5 and Corollary A.7. (2) is also immediate by using the non-degenerate bilinear form

$$
\Psi_{\lambda, k} \otimes \Psi_{\mu, \ell}:\left(\mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right) \otimes\left(\mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right) \rightarrow \mathbb{C}
$$

Proof of Theorem 3.3. It follows from Proposition A.1, Corollary A.7 (2) and Proposition A. 9 (2) that $H_{\mathrm{rel}}^{\frac{\infty}{2}+n}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes\right.$ $\left.\mathbb{V}_{\mu}^{\ell}\right)=0(n \neq 0)$. Then, the character of $H_{\text {rel }}^{\frac{\infty}{2}+0}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)$ is calculated by the Euler-Poincaré principle [CFL]. Let $\chi_{L_{\lambda}}$ denote the character of $L_{\lambda}$ as a $\mathfrak{g}$-module, namely,

$$
\chi_{L_{\lambda}}(z)=\frac{\sum_{w \in W}(-1)^{\ell(w)} e^{w(\lambda+\rho)-\rho}}{\prod_{\alpha \in \Delta_{+}}\left(1-(-1)^{\bar{\alpha}} e^{-\alpha}\right)^{\bar{\alpha}}}
$$

and set

$$
\Pi(z, q):=\prod_{n=1}^{\infty}\left(1-q^{n}\right)^{\mathrm{rankg}} \prod_{\alpha \in \Delta_{+}}\left(1-(-1)^{\bar{\alpha}} z^{\alpha} q^{n}\right)^{\bar{\alpha}}\left(1-(-1)^{\bar{\alpha}} z^{-\alpha} q^{n}\right)^{\bar{\alpha}}
$$

It follows that

$$
\operatorname{ch}\left[\mathbb{V}_{\lambda}^{k}\right](z, q)=\frac{q^{\frac{(\lambda \mid \lambda+2 \rho)}{2(k+h \vee)}} \chi_{L_{\lambda}}(z)}{\Pi(z, q)}, \quad \operatorname{sch}\left[\bigwedge_{\substack{\frac{\infty}{2}+\bullet \\ \text { rel }}}^{\frac{1}{2}}\right](z, q)=\Pi(z, q)^{2}
$$

and thus

$$
\begin{equation*}
\operatorname{sch}\left[\mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell} \otimes \bigwedge_{\mathrm{rel}}^{\frac{\infty}{2}+\bullet}\right](z, q)=q^{\frac{|\lambda+\rho|^{2}-|\mu+\rho|^{2}}{2\left(k+h^{\vee}\right)}} \chi_{L_{\lambda}} \otimes L_{\mu}(z) \tag{A.7}
\end{equation*}
$$

Here we have used the relation $k+h^{\vee}=-\left(\ell+h^{\vee}\right)$. Since $C_{\text {rel }}^{\frac{\infty}{2}+\bullet}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)=\left(\mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell} \otimes \bigwedge_{\text {rel }}^{\frac{\infty}{2}+\bullet}\right)^{\mathfrak{g}}$, we have

$$
\operatorname{ch}\left[H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)\right](z, q)=\operatorname{sch}\left[\left(\mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell} \otimes \bigwedge_{\text {rel }}^{\frac{\infty}{2}+\bullet}\right)^{\mathfrak{g}}\right](z, q)
$$

By (A.7), it follows from the complete reducibility of integrable $\mathfrak{g}$-modules that the right-hand side is

$$
\operatorname{dim} \operatorname{Hom}_{\mathfrak{g}}\left(L_{0}, L_{\lambda} \otimes L_{\mu}\right) q^{\frac{|\lambda+\rho|^{2}-|\mu+\rho|^{2}}{2(k+h)}}=\delta_{\lambda, \mu^{\dagger}} q^{\frac{|\lambda+\rho|^{2}-|\mu+\rho|^{2}}{2(k+h \nabla)}} .
$$

Therefore, $H_{\mathrm{rel}}^{\frac{\infty}{2}+0}\left(\mathfrak{g}, \mathbb{V}_{\lambda}^{k} \otimes \mathbb{V}_{\mu}^{\ell}\right)$ is of one dimension and of the lowest conformal weight of the complex. The corresponding subcomplex is $\left(L_{\lambda} \otimes L_{\mu}\right)^{\mathfrak{g}}$ with trivial differential and thus the cohomology is $\left(L_{\lambda} \otimes L_{\mu}\right)^{\mathfrak{g}}$ itself. Therefore, the assertion follows from Lemma 3.2.
