# THE INTEGRAL COHOMOLOGY RINGS OF PETERSON VARIETIES IN TYPE A 

HIRAKU ABE AND HAOZHI ZENG


#### Abstract

In this paper, we study the ring structure of the integral cohomology of the Peterson variety of type $\mathrm{A}_{n-1}$. We give two kinds of descriptions: (1) we show that it is isomorphic to the $\mathfrak{S}_{n}$-invariant subring of the integral cohomology ring of the permutohedral variety, (2) we determine the ring structure in terms of ring generators and their relations.


## 1. Introduction

Let $n(\geq 2)$ be a positive integer and $F l_{n}=F l\left(\mathbb{C}^{n}\right)$ the flag variety of $\mathbb{C}^{n}$ which is the collection of nested sequence of linear subspaces of $\mathbb{C}^{n}$ :

$$
F l_{n}=\left\{V_{\bullet}=\left(V_{1} \subset V_{2} \subset \cdots \subset V_{n}=\mathbb{C}^{n}\right) \mid \operatorname{dim}_{\mathbb{C}} V_{i}=i(1 \leq i \leq n)\right\}
$$

Let $N$ be an $n \times n$ regular nilpotent matrix viewed as a linear map $N: \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$. The Peterson variety (of type $\mathrm{A}_{n-1}$ ) is a subvariety of $F l_{n}$ defined by

$$
P e t_{n}:=\left\{V_{\bullet} \in F l_{n} \mid N V_{j} \subseteq V_{j+1} \text { for all } 1 \leq j<n\right\},
$$

where $N V_{j}$ denotes the image of $V_{j}$ under the map $N: \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$. It was introduced by Dale Peterson to study the quantum cohomology ring of $F l_{n}$, and it has appeared in several contexts (e.g., [3, 7, [17, 22, 25]).

The cohomology ring $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{C}\right)$ has been studied in Harada-Tymoczo ([18]), Fukukawa-Harada-Masuda ([11]), and Harada-Horiguchi-Masuda ([17]). Moreover, a natural basis of $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{C}\right)$ which has certain positivity and integrality was discovered ([5, [14, 15, 18]), and it is now actively studied in connection with mixed Eulerian numbers in combinatorics ([5, 14, 15, 16, 19]). In this paper, we study the ring structure of the cohomology of $P e t_{n}$ with $\mathbb{Z}$ coefficients.

To state the first theorem of this paper, we need to introduce a toric variety which is called the permutohedral variety. Let $S$ be an $n \times n$ regular semisimple matrix viewed as a linear map $S: \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$ as above. The permutohedral variety is defined by

$$
\operatorname{Perm}_{n}:=\left\{V_{\bullet} \in F l_{n} \mid S V_{j} \subseteq V_{j+1} \text { for all } 1 \leq j<n\right\} .
$$

It is known that $\operatorname{Perm}_{n}$ is the non-singular projective toric variety associated with the fan consisting of the set of Weyl chambers of type $\mathrm{A}_{n-1}$ ([9, Theorems 6 and 11]). The symmetric group $\mathfrak{S}_{n}$ of $n$-letters permutes the set of Weyl chambers, and hence there is a natural $\mathfrak{S}_{n}$-action on the cohomology ring $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$ which preserves the grading and the cup product. This implies that the invariant subgroup $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}$ is in fact a graded ring with respect to the cup product.

The first theorem of this paper is the following.
Theorem 1.1. As graded rings, we have $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right) \cong H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}$.
We note that the corresponding claim for cohomology rings with $\mathbb{C}$ coefficients is known as mentioned in [4, Sect. 1] based on the explicit presentations for the rings
$H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{C}\right)$ and $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{C}\right)^{\mathfrak{G}_{n}}$ due to Fukukawa-Harada-Masuda ([11]) and Klyachko ([21]), respectively (see also [3, 17]).

As the second theorem, we give an explicit presentation of the ring structure of $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$ in terms of ring generators and their relations. For simplicity, we assume that the regular nilpotent matrix $N$ appearing in the definition of $P e t_{n}$ is in Jordan canonical form. Let $L_{i}$ be the $i$-th tautological line bundle over $F l_{n}(1 \leq i \leq n)$. By abusing notation, we denote the restriction of $L_{i}$ over Pet $_{n}$ by the same symbol. Let $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ be the polynomial ring over $\mathbb{Z}$ with indeterminates $y_{1}, y_{2}, \ldots, y_{n}$. We regard this polynomial ring as a graded ring with $\operatorname{deg} y_{i}=2$ for $1 \leq i \leq n$. Let

$$
\phi: \mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] \rightarrow H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

be the ring homomorphism which sends $y_{i}$ to the first Chern class $c_{1}\left(L_{i}^{*}\right)$, where $L_{i}^{*}$ is the dual line bundle of $L_{i}(1 \leq i \leq n)$. We introduce the following homogeneous ideals of $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ :

$$
\begin{aligned}
& I:=\left(e_{k}\left(y_{1}, y_{2}, \ldots, y_{n}\right) \mid 1 \leq k \leq n\right), \\
& I^{\prime}:=\left(\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right) \mid 1 \leq i \leq n-1,1 \leq k \leq \min \{i, n-i\}\right),
\end{aligned}
$$

where $e_{k}$ denotes the $k$-th elementary symmetric polynomial. We now state the second theorem of this paper.

Theorem 1.2. The map $\phi$ induces an isomorphism

$$
H^{*}\left(P e t_{n} ; \mathbb{Z}\right) \cong \mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right)
$$

as graded rings.
Explicit presentations of the cohomology ring $H^{*}\left(P e t_{n} ; \mathbb{C}\right)$ were given in [11, 17, 18] as mentioned above, and the definition of the ideal $I^{\prime}$ is motivated algebraically by [11, 17 and geometrically by [5]. See Section 4 for details.

## 2. Background and preliminaries

2.1. Hessenberg varieties. Let $n(\geq 2)$ be a positive integer. We use the notation $[n]:=\{1,2, \ldots, n\}$ throughout this paper. A function $h:[n] \rightarrow[n]$ is a Hessenberg function if it satisfies the following two conditions:
(i) $h(1) \leq h(2) \leq \cdots \leq h(n)$,
(ii) $h(j) \geq j$ for all $j \in[n]$.

We identify a Hessenberg function $h$ with a configuration of shaded boxes on a square grid of size $n \times n$ which consists of boxes in the $i$-th row and the $j$-th column satisfying $i \leq h(j)$ for $i, j \in[n]$.

Example 2.1. If $n=5$ and $h:[5] \rightarrow[5]$ is given by

$$
(h(1), h(2), h(3), h(4), h(5))=(3,3,4,5,5),
$$

then $h$ is a Hessenberg function corresponding to the configuration of the shaded boxes drawn in Figure 1


Figure 1. The configuration of shaded boxes for Example 2.1
Let $F l_{n}=F l\left(\mathbb{C}^{n}\right)$ be the flag variety of $\mathbb{C}^{n}$. For an $n \times n$ matrix $X$ (viewed as a linear map $X: \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$ ) and a Hessenberg function $h:[n] \rightarrow[n]$, the Hessenberg variety associated with $X$ and $h$ is defined by

$$
\operatorname{Hess}(X, h):=\left\{V_{\bullet} \in F l_{n} \mid X V_{j} \subseteq V_{h(j)} \text { for all } 1 \leq j \leq n\right\}
$$

The Peterson variety and the permutohedral variety are both special cases of Hessenberg varieties as we will see in the next subsection.

We denote by $\mathrm{GL}_{n}(\mathbb{C})$ the complex general linear group of degree $n$. There is a natural action of $\mathrm{GL}_{n}(\mathbb{C})$ on $F l_{n}$, and we have $\operatorname{Hess}\left(g X g^{-1}, h\right)=g \cdot \operatorname{Hess}(X, h)$ in $F l_{n}$. This implies that

$$
\begin{equation*}
\operatorname{Hess}\left(g X g^{-1}, h\right) \cong \operatorname{Hess}(X, h) \tag{2.1}
\end{equation*}
$$

for $g \in \mathrm{GL}_{n}(\mathbb{C})$ so that taking conjugation of the matrix $X$ does not change the isomorphism class of $\operatorname{Hess}(X, h)$.
2.2. Peterson varieties. Let $N$ be an $n \times n$ regular nilpotent matrix (i.e., a nilpotent matrix consisting of a single Jordan block), and let $h_{2}:[n] \rightarrow[n]$ be the Hessenberg function given by

$$
\begin{equation*}
h_{2}(j)=j+1 \quad \text { for } 1 \leq j<n . \tag{2.2}
\end{equation*}
$$

The Peterson variety Pet $_{n}$ is defined as a special case of Hessenberg varieties:

$$
\begin{equation*}
\text { Pet }_{n}:=\operatorname{Hess}\left(N, h_{2}\right)=\left\{V_{\bullet} \in F l_{n} \mid N V_{j} \subseteq V_{j+1} \text { for all } 1 \leq j<n\right\} . \tag{2.3}
\end{equation*}
$$

For simplicity, we assume that $N$ is in Jordan canonical form in the rest of this paper. It is well-known (cf. [24] or [6, Lemma 7.1]) that

$$
\begin{equation*}
\operatorname{dim}_{\mathbb{C}} P e t_{n}=n-1 \tag{2.4}
\end{equation*}
$$

For a topological space $X$, we denote by $H_{*}(X ; \mathbb{Z})$ and $H^{*}(X ; \mathbb{Z})$ the singular homology group of $X$ and the singular cohomology ring of $X$, respectively. We set $H_{\text {odd }}(X ; \mathbb{Z}):=$ $\oplus_{k \geq 0} H_{2 k+1}(X ; \mathbb{Z})$.
Proposition 2.2. ([24] and [29, Theorem 7.1])
(i) $H_{*}\left(P e t_{n} ; \mathbb{Z}\right)$ is a torsion free $\mathbb{Z}$-module of rank $2^{n-1}$.
(ii) $H_{\text {odd }}\left(P e t_{n} ; \mathbb{Z}\right)=0$.
2.3. Permutohedral varieties. Let $S$ be an $n \times n$ regular semisimple matrix (i.e., an $n \times n$ matrix with $n$ distinct eigenvalues), and let $h_{2}:[n] \rightarrow[n]$ be the Hessenberg function defined in (2.2). The permutohedral variety $\operatorname{Perm}_{n}$ is also a special case of Hessenberg varieties:

$$
\begin{equation*}
\operatorname{Perm}_{n}:=\operatorname{Hess}\left(S, h_{2}\right)=\left\{V_{\bullet} \in F l_{n} \mid S V_{j} \subseteq V_{j+1} \text { for all } 1 \leq j<n\right\} . \tag{2.5}
\end{equation*}
$$

It is known that $\operatorname{Perm}_{n}$ is the non-singular projective toric variety associated with the fan consisting of the set of Weyl chambers of type $\mathrm{A}_{n-1}$ (9, Theorems 6 and 11]). This implies that the isomorphism class of $\operatorname{Hess}\left(S, h_{2}\right)$ does not depend on a choice of a regular semisimple matrix $S$. It also follows from [9, Theorem 11] that

$$
\operatorname{dim}_{\mathbb{C}} \operatorname{Perm}_{n}=n-1
$$

Proposition 2.3. (9, Section III])
(i) $H_{*}\left(\right.$ Perm $\left._{n} ; \mathbb{Z}\right)$ is a torsion free $\mathbb{Z}$-module of rank $n$ !.
(ii) $H_{\text {odd }}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)=0$.

The Weyl group $\mathfrak{S}_{n}$ permutes the set of Weyl chambers of type $\mathrm{A}_{n-1}$, and hence it induces an $\mathfrak{S}_{n}$-action on the cohomology ring $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$ of the toric variety Perm ${ }_{n}$. It is known (e.g., [8, Sect. 1]) that this $\mathfrak{S}_{n}$-module can also be constructed as a special case of the dot action due to Tymoczko ([30]) which we briefly review in what follows.

Recalling that we have (2.1), we may assume that the matrix $S$ in the diagonal form. Let $h:[n] \rightarrow[n]$ be an arbitrary Hessenberg function. We denote by $T$ the maximal torus of $\mathrm{GL}_{n}(\mathbb{C})$ consisting of diagonal matrices. There is a natural action of $G L_{n}(\mathbb{C})$ on $F l_{n}$, and hence $T$ acts on $F l_{n}$ through the action of $G L_{n}(\mathbb{C})$. This $T$-action preserves $\operatorname{Hess}(S, h) \subseteq F l_{n}$ since the matrix $S$ and elements of $T$ commute. In this way, we obtain a $T$-action on $\operatorname{Hess}(S, h)$. In [30], Tymoczko constructed a representation of $\mathfrak{S}_{n}$ on the $T$-equivariant cohomology $H_{T}^{*}(\operatorname{Hess}(S, h) ; \mathbb{C})$ by using its GKM presentation, and she showed that it induces a representation of $\mathfrak{S}_{n}$ on the ordinary cohomology ring $H^{*}(\operatorname{Hess}(S, h) ; \mathbb{C})$ which preserves the degree and the cup product. As mentioned in [2, Remark 2.4], the same construction works for the integral cohomology ring $H^{*}(\operatorname{Hess}(S, h) ; \mathbb{Z})$ as well. Since we have $\operatorname{Perm} m_{n}=\operatorname{Hess}\left(S, h_{2}\right)$ by definition, we regard $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$ as an $\mathfrak{S}_{n}$-module by this way throughout the paper. For this $\mathfrak{S}_{n}$-module, the following claim is deduced from [4, 21, 26].

## Proposition 2.4.

(i) The image of the restriction map $H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\right.$ Perm $\left._{n} ; \mathbb{Z}\right)$ lies in the invariant submodule $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}$.
(ii) $\operatorname{rank} H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}} \leq 2^{n-1}$.

Proof. The claim (i) for $\mathbb{Q}$ coefficients follows from [21] or 4, Sect. 8]. Since the argument of [4, Sect. 8] works verbatim for $\mathbb{Z}$ coefficients as well, we explain only the outline of the proof. Let $h_{n}:[n] \rightarrow[n]$ be the Hessenberg function given by $h_{n}(j)=n$ for $1 \leq j \leq n$. Since $F l_{n}=\operatorname{Hess}\left(S, h_{n}\right)$, the cohomology ring $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$ also admits Tymoczko's $\mathfrak{S}_{n}$-action. By the construction of this $\mathfrak{S}_{n}$-action, it follows that the restriction map $H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$ is a homomorphism of $\mathfrak{S}_{n}$-modules ( 4 , Lemma 8.1]). Also, it is known from [30, Proposition 4.4] that the $\mathfrak{S}_{n}$-action on $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$ is trivial. This proves the claim (i).

For the claim (ii), it is clear that we have the inclusion map

$$
H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}} \hookrightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)
$$

Since both of these are free $\mathbb{Z}$-modules by Proposition 2.3, this map induces an injective linear map over $\mathbb{C}$ :

$$
\begin{equation*}
H^{*}\left(\text { Perm }_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}} \otimes_{\mathbb{Z}} \mathbb{C} \hookrightarrow H^{*}\left(\text { Perm }_{n} ; \mathbb{Z}\right) \otimes_{\mathbb{Z}} \mathbb{C} \tag{2.6}
\end{equation*}
$$

Here, the target vector space $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right) \otimes_{\mathbb{Z}} \mathbb{C}$ has a natural structure of an $\mathfrak{S}_{n^{-}}$ representation induced by that of $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$, and it is isomorphic to $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{C}\right)$ as $\mathfrak{S}_{n}$-representations by construction (cf. [2, Remark 2.4]). The image of the map (2.6) lies on the $\mathfrak{S}_{n}$-invariant subspace of $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right) \otimes_{\mathbb{Z}} \mathbb{C} \cong H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{C}\right)$ so that we obtain an injective linear map

$$
H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}} \otimes_{\mathbb{Z}} \mathbb{C} \hookrightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{C}\right)^{\mathfrak{G}_{n}}
$$

Thus, it follows that

$$
\operatorname{rank} H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}} \leq \operatorname{dim}_{\mathbb{C}} H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{C}\right)^{\mathfrak{S}_{n}}=2^{n-1}
$$

where the last equality follows from [26, Theorem 3.1].
Remark 2.5. For the second claim of Proposition [2.4, we show that the equality rank $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}}=2^{n-1}$ holds in the next section. See Remark 3.10 for details.
2.4. A connection between Peterson varieties and permutohedral varieties.

Let $\lambda_{1}, \lambda_{2}, \ldots, \lambda_{n} \in \mathbb{C}$ be distinct complex numbers. For $t \in \mathbb{C}$, we consider an $n \times n$ matrix $S_{t}$ given by

$$
S_{t}=\left(\begin{array}{cccccc}
t \lambda_{1} & 1 & & & & \\
& t \lambda_{2} & 1 & & & \\
& & \ddots & \ddots & \\
& & & t \lambda_{n-1} & 1 \\
& & & & & t \lambda_{n}
\end{array}\right) \quad(t \in \mathbb{C})
$$

For a (fixed) Hessenberg function $h:[n] \rightarrow[n]$, this leads us to consider a family of Hessenberg varieties over the 1 -dimensional base space $\mathbb{C}$ such that the fiber over $t \in \mathbb{C}$ is $\operatorname{Hess}\left(S_{t}, h\right)$ (see [1, Section 4] for details). For our purpose, we take $h=h_{2}$, where $h_{2}$ is the Hessenberg function given in (2.2). When $t \neq 0$, the matrix $S_{t}$ is a regular semisimple matrix, and hence we have $\operatorname{Hess}\left(S_{t}, h_{2}\right) \cong \operatorname{Perm}_{n}$ by (2.1). When $t=0$, it is clear that $\operatorname{Hess}\left(S_{0}, h_{2}\right)=$ Pet $_{n}$. Thus, we obtain a degeneration from $\operatorname{Perm}_{n}$ to Pet $_{n}$. This family was studied in [1] to prove the following.

Proposition 2.6. ([1, Corollary 4.3]) We have

$$
\left[\text { Pet }_{n}\right]=\left[\text { Perm }_{n}\right] \quad \text { in } H_{*}\left(F l_{n} ; \mathbb{Z}\right)
$$

where $\left[\right.$ Pet $\left._{n}\right]$ and $\left[\right.$ Perm $\left._{n}\right]$ are the cycles representing the subvarieties Pet ${ }_{n}$ and Perm$n$ in $F l_{n}$, respectively.
2.5. Combinatorics on Dynkin diagrams of type A. Recall from our notation that $[n-1]=\{1,2, \ldots, n-1\}$. We regard it as the set of vertices of the Dynkin diagram of type $A_{n-1}$. Namely, two vertices $i, j \in[n-1]$ are connected by an edge if and only if $|i-j|=1$. See Figure 2.


Figure 2. The Dynkin diagram of type $\mathrm{A}_{n-1}$.
We also regard each subset $J \subseteq[n-1]$ as a full-subgraph of the Dynkin diagram. We may decompose it into the connected components:

$$
J=J_{1} \sqcup J_{2} \sqcup \cdots \sqcup J_{m},
$$

where $J_{k}(1 \leq k \leq m)$ is the set of vertices of a maximal connected subgraph of $J$. To determine each $J_{k}$ uniquely, we require that elements of $J_{k}$ are less than elements of $J_{k^{\prime}}$ when $k<k^{\prime}$.

Example 2.7. Let $n=10$ and $J=\{1,2,4,5,6,9\}$. Then we have

$$
J_{1}=\{1,2\}, \quad J_{2}=\{4,5,6\}, \quad J_{3}=\{9\}
$$

so that $J=J_{1} \sqcup J_{2} \sqcup J_{3}=\{1,2\} \sqcup\{4,5,6\} \sqcup\{9\}$.

For $J \subseteq[n-1]$, let us consider the associated Young subgroup

$$
\mathfrak{S}_{J}:=\mathfrak{S}_{J_{1}} \times \mathfrak{S}_{J_{2}} \times \cdots \times \mathfrak{S}_{J_{m}} \subseteq \mathfrak{S}_{n}
$$

where $\mathfrak{S}_{J_{k}}(1 \leq k \leq m)$ is the subgroup of $\mathfrak{S}_{n}$ generated by the simple reflections $s_{i}$ for all $i \in J_{k}$. Let $w_{J}$ be the longest element of $\mathfrak{S}_{J}$, i.e.,

$$
\begin{equation*}
w_{J}:=w_{0}^{\left(J_{1}\right)} w_{0}^{\left(J_{2}\right)} \cdots w_{0}^{\left(J_{m}\right)} \in \mathfrak{S}_{J}, \tag{2.7}
\end{equation*}
$$

where $w_{0}^{\left(J_{k}\right)}$ is the longest element of $\mathfrak{S}_{J_{k}}(1 \leq k \leq m)$.
Example 2.8. If $n=10$ and $J=\{1,2\} \sqcup\{4,5,6\} \sqcup\{9\}=J_{1} \sqcup J_{2} \sqcup J_{3}$ as above, then the permutation $w_{J}$ in the form of its permutation matrix is given by

For $J \subseteq[n-1]$, there is a natural Hessenberg function which is determined by $J$ as follows. Let $h_{J}:[n] \rightarrow[n]$ be a function given by

$$
h_{J}(j)= \begin{cases}j+1 & \text { if } j \in J,  \tag{2.8}\\ j & \text { if } j \notin J .\end{cases}
$$

We note that

$$
\begin{equation*}
h_{J}(j) \leq h_{2}(j) \quad \text { for } 1 \leq j \leq n, \tag{2.9}
\end{equation*}
$$

where $h_{2}$ is the Hessenberg function defined in (2.2).
Example 2.9. If $n=10$ and $J=\{1,2,4,5,6,9\}$ as above, then the configuration of boxes of $h_{J}$ is given in Figure 3 (cf. Example 2.8).


Figure 3. The Hessenberg function $h_{J}$

## 3. The Relation between $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$ and $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)$

The aim of this section is to prove that there is an isomorphism

$$
H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right) \cong H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}
$$

as graded rings.
3.1. The Schubert varieties $X_{w_{J}}$ associated with $w_{J}$. Let $J \subseteq[n-1]$. Recall that we have the decomposition $J=J_{1} \sqcup \cdots \sqcup J_{m}$ into the connected components. For $1 \leq k \leq m$, we define $\overline{J_{k}} \subseteq[n]$ by

$$
\overline{J_{k}}:=J_{k} \sqcup\left\{\max J_{k}+1\right\} .
$$

We also set

$$
n_{k}:=\left|\overline{J_{k}}\right|=\left|J_{k}\right|+1 \quad \text { for } 1 \leq k \leq m .
$$

The permutation $w_{J} \in \mathfrak{S}_{n}$ defined in (2.7) determines the corresponding Schubert variety $X_{w_{J}} \subseteq F l_{n}$. Since $w_{J}$ is a product of longest permutations of smaller ranks (see also Example (2.8), it follows that the associated Schubert variety $X_{w_{J}}$ is isomorphic to a product of flag varieties of smaller ranks:

$$
\begin{equation*}
X_{w_{J}} \cong \prod_{k=1}^{m} F l_{n_{k}} \tag{3.1}
\end{equation*}
$$

Although this is well-known, let us construct an explicit isomorphism (3.1) to use it in the next subsection. We begin with the map

$$
\begin{equation*}
\prod_{k=1}^{m} \mathrm{GL}_{n_{k}}(\mathbb{C}) \rightarrow \mathrm{GL}_{n}(\mathbb{C}) \quad ; \quad\left(g_{1}, \cdots, g_{m}\right) \mapsto g_{J} \tag{3.2}
\end{equation*}
$$

where $g_{J}$ is an $n \times n$ block-diagonal matrix defined as follows. For $1 \leq k \leq m$, the $\overline{J_{k}} \times \overline{J_{k}}(\subseteq[n] \times[n])$ diagonal block of $g_{J}$ is $g_{k}$, and the remaining diagonal blocks are matrices of size 1 having 1 as their entries.

Example 3.1. Let $n=10$ and $J=\{1,2,4,5,6,9\}=\{1,2\} \sqcup\{4,5,6\} \sqcup\{9\}$ as above. Then we have

$$
\overline{J_{1}}=\{1,2,3\}, \overline{J_{2}}=\{4,5,6,7\}, \text { and } \overline{J_{3}}=\{9,10\}
$$

so that $n_{1}=3, n_{2}=4$, and $n_{3}=2$. The map (3.2) sends an element $\left(g_{1}, g_{2}, g_{3}\right) \in$ $\mathrm{GL}_{3}(\mathbb{C}) \times \mathrm{GL}_{4}(\mathbb{C}) \times \mathrm{GL}_{2}(\mathbb{C})$ to the block-diagonal matrix

(cf. Example 2.8).

Let $B_{n} \subseteq \mathrm{GL}_{n}(\mathbb{C})$ be the Borel subgroup consisting of upper triangular matrices. We then have the standard identification $F l_{n}=\mathrm{GL}_{n}(\mathbb{C}) / B_{n}$ as is well-known. For $g \in \mathrm{GL}_{n}(\mathbb{C})$, we write $[g]=g B_{n} \in \mathrm{GL}_{n}(\mathbb{C}) / B_{n}$ for simplicity. It is clear that the map (3.2) induces an embedding

$$
\begin{equation*}
\phi_{J}: \prod_{k=1}^{m} F l_{n_{k}} \rightarrow F l_{n} \quad ; \quad\left(\left[g_{1}\right], \cdots,\left[g_{m}\right]\right) \mapsto\left[g_{J}\right] . \tag{3.3}
\end{equation*}
$$

We now show that the image of $\phi_{J}$ coincides with the Schubert variety $X_{w_{J}}$. For simplicity, we identify the permutation $w_{J}$ and the element of $F l_{n}$ represented by its permutation matrix (see Example [2.8). Under this identification, it is straightforward to see that the embedding $\phi_{J}$ sends $\left(w_{0}^{\left(J_{1}\right)}, w_{0}^{\left(J_{2}\right)}, \ldots, w_{0}^{\left(J_{m}\right)}\right) \in \prod_{k=1}^{m} F l_{n_{k}}$ to $w_{J} \in F l_{n}$. This means that the image of $\phi_{J}$ contains $w_{J}$. It also follows from the definition that the image of $\phi_{J}$ is stable under the action of $B_{n}\left(\subseteq \mathrm{GL}_{n}(\mathbb{C})\right)$, where $B_{n}$ acts on $F l_{n}=\mathrm{GL}_{n}(\mathbb{C}) / B$ by restricting the left multiplication of $\mathrm{GL}_{n}(\mathbb{C})$ on $\mathrm{GL}_{n}(\mathbb{C}) / B$. Therefore, the image of $\phi_{J}$ is a $B$-stable (Zariski-)closed subset of $F l_{n}$ containing $w_{J}$. This means that $X_{w_{J}} \subseteq \operatorname{Im} \phi_{J}$. Since the product $\prod_{k=1}^{m} F l_{n_{k}}$ is irreducible, so is the
image of $\phi_{J}$. We also know that the dimensions of $X_{w_{J}}$ and $\operatorname{Im} \phi_{J}$ coincide since

$$
\operatorname{dim}_{\mathbb{C}} X_{w_{J}}=\ell\left(w_{J}\right)=\sum_{k=1}^{m} \ell\left(w_{0}^{\left(J_{k}\right)}\right)=\operatorname{dim}_{\mathbb{C}}\left(\prod_{k=1}^{m} F l_{n_{k}}\right)=\operatorname{dim}_{\mathbb{C}} \operatorname{Im} \phi_{J}
$$

where $w_{0}^{\left(J_{k}\right)}$ is the permutation appeared in (2.7). Hence, we conclude that

$$
X_{w_{J}}=\operatorname{Im} \phi_{J}
$$

Therefore, we verified that the map (3.3) is an embedding onto the Schubert variety $X_{w_{J}}$. This gives us the isomorphism in (3.1).
3.2. Varieties associated with $J$. For each $J \subseteq[n-1]$, we introduce varieties $F l_{J}$, Pet $_{J}$, Perm $_{J}$ associated with $J$ in what follows. First, we set

$$
\begin{equation*}
F l_{J}:=X_{w_{J}} \cong \prod_{k=1}^{m} F l_{n_{k}}, \tag{3.4}
\end{equation*}
$$

where the last isomorphism is given by (3.1).
Example 3.2. Let $n=10$ and $J=\{1,2,4,5,6,9\}=\{1,2\} \sqcup\{4,5,6\} \sqcup\{9\}$ as above. Then we have

$$
F l_{J} \cong F l_{3} \times F l_{4} \times F l_{2}
$$

(cf. Example 3.1).
Recall that $h_{J}:[n] \rightarrow[n]$ is the Hessenberg function defined in (2.8). Associated with $h_{J}$, we consider two varieties $\operatorname{Hess}\left(N, h_{J}\right)$ and $\operatorname{Hess}\left(S, h_{J}\right)$, where we note that $\operatorname{Hess}\left(S, h_{J}\right)$ is not connected when $J \neq[n-1]$ (9, Corollary 9] or [28, Lemma 3.12]). It is clear that the identity flag

$$
\left\langle e_{1}\right\rangle \subset\left\langle e_{1}, e_{2}\right\rangle \subset \cdots \subset\left\langle e_{1}, e_{2}, \ldots, e_{n}\right\rangle=\mathbb{C}^{n}
$$

belongs to $\operatorname{Hess}\left(S, h_{J}\right)$ by definition. We denote by $\operatorname{Hess}^{*}\left(S, h_{J}\right)$ the connected component of $\operatorname{Hess}\left(S, h_{J}\right)$ containing the identity flag. We set

$$
\begin{aligned}
& \operatorname{Pet}_{J}:=\operatorname{Hess}\left(N, h_{J}\right) \subseteq F l_{n}, \\
& \operatorname{Perm}_{J}:=\operatorname{Hess}^{*}\left(S, h_{J}\right) \subseteq F l_{n} .
\end{aligned}
$$

Recalling that $\operatorname{Pet}_{n}=\operatorname{Hess}\left(N, h_{2}\right)$ and $\operatorname{Perm}_{n}=\operatorname{Hess}\left(S, h_{2}\right)$ from (2.3) and (2.5), it follows that

$$
\text { Pet }_{J} \subseteq \text { Pet }_{n} \quad \text { and } \quad \operatorname{Perm}_{J} \subseteq \text { Perm }_{n}
$$

by (2.9).
Lemma 3.3. For $J \subseteq[n-1]$, the following hold.
(i) Pet $_{J}$ and Perm $_{J}$ are irreducible.
(ii) $\operatorname{dim}_{\mathbb{C}}$ Pet $_{J}=\operatorname{dim}_{\mathbb{C}}$ Perm $_{J}=|J|$.

Proof. The irreducibility of $\operatorname{Pet}_{J}\left(=\operatorname{Hess}\left(N, h_{J}\right)\right)$ follows from [6, Sect. 7]. For Perm${ }_{J}$ $\left(=\operatorname{Hess}^{*}\left(S, h_{J}\right)\right)$, it is non-singular (see section (2.3) and connected so that it is irreducible. This proves the claim (i).

For the claim (ii), we have

$$
\operatorname{dim}_{\mathbb{C}} \text { Pet }_{J}=\sum_{j=1}^{n}\left(h_{J}(j)-j\right)=\operatorname{dim}_{\mathbb{C}} \text { Perm}_{J}
$$

by [27, Theorem 10.2] and [9, Theorem 8] (see also [6, Sect. 7]). It is clear that this value is equal to $|J|$ by the definition of $h_{J}$.

We now use the embedding $\phi_{J}: \prod_{k=1}^{m} F l_{n_{k}} \rightarrow F l_{n}$ given in (3.3) to study the structure of Pet $_{J}$ and $\operatorname{Perm}_{J}$ for $J \subseteq[n-1]$. We begin with considering the image of $\prod_{k=1}^{m}$ Pet $_{n_{k}}$ under $\phi_{J}$. It follows from the construction of $\phi_{J}$ that an arbitrary element $V_{\bullet} \in \phi_{J}\left(\prod_{k=1}^{m} P e t_{n_{k}}\right)$ satisfies

$$
N V_{j} \subseteq V_{h_{J}(j)} \quad(1 \leq j \leq n)
$$

(see also Example 3.1). Namely, we have

$$
\phi_{J}\left(\prod_{k=1}^{m} P e t_{n_{k}}\right) \subseteq \operatorname{Hess}\left(N, h_{J}\right)=P e t_{J}
$$

Here, we know that $\operatorname{dim}_{\mathbb{C}} \phi_{J}\left(\prod_{k=1}^{m} P e t_{n_{k}}\right)$ is equal to $\operatorname{dim}_{\mathbb{C}} P e t_{J}$ since

$$
\operatorname{dim}_{\mathbb{C}} \phi_{J}\left(\prod_{k=1}^{m} \text { Pet }_{n_{k}}\right)=\sum_{k=1}^{m}\left(n_{k}-1\right)=\sum_{i=1}^{n}\left(h_{J}(i)-i\right)=\operatorname{dim}_{\mathbb{C}} \text { Pet }_{J}
$$

by (2.4) and (2.8). Since $\mathrm{Pet}_{J}$ is irreducible, we obtain

$$
\begin{equation*}
\phi_{J}\left(\prod_{k=1}^{m} \operatorname{Pet}_{n_{k}}\right)=P e t_{J} . \tag{3.5}
\end{equation*}
$$

To obtain a similar result for $\operatorname{Perm}_{J}$, recall that $\operatorname{Perm}_{J}=\operatorname{Hess}^{*}\left(S, h_{J}\right)$ is the connected component of $\operatorname{Hess}\left(S, h_{J}\right)$ containing the identity flag. We also recall that $\operatorname{Perm}_{J}$ is irreducible from Lemma 3.3. Also, it is clear that the image $\phi_{J}\left(\prod_{k=1}^{m} \operatorname{Perm}_{n_{k}}\right)$ contains the identity flag in $F l_{n}$. Thus, by an argument similar to that above, we obtain

$$
\begin{equation*}
\phi_{J}\left(\prod_{k=1}^{m} \operatorname{Perm}_{n_{k}}\right)=\operatorname{Perm}_{J} . \tag{3.6}
\end{equation*}
$$

Since the image of $\phi_{J}$ is $F l_{J}\left(=X_{w_{J}}\right)$, the equalities (3.5) and (3.6) imply the following claim.

Lemma 3.4. For $J \subseteq[n-1]$, both of $P e t_{J}$ and Perm $_{J}$ are contained in $F l_{J}$.
Since $\phi_{J}$ is an embedding, the equalities (3.5) and (3.6) also imply the following decompositions into products (cf. [10, Theorem 4.5] and [28, Proposition 3.13]):

$$
\begin{equation*}
\text { Pet }_{J} \cong \prod_{k=1}^{m} \text { Pet }_{n_{k}} \quad \text { and } \quad \operatorname{Perm}_{J} \cong \prod_{k=1}^{m} \operatorname{Perm}_{n_{k}} . \tag{3.7}
\end{equation*}
$$

It is clear from the construction that these decompositions are compatible with the one in (3.4).

Example 3.5. If $n=10$ and $J=\{1,2,4,5,6,9\}=\{1,2\} \sqcup\{4,5,6\} \sqcup\{9\}$ as above, then we have

$$
\begin{aligned}
& \text { Pet }_{J} \cong \text { Pet }_{3} \times \text { Pet }_{4} \times \text { Pet }_{2}, \\
& \text { Perm }_{J} \cong \text { Perm }_{3} \times \text { Perm }_{4} \times \text { Perm }_{2}
\end{aligned}
$$

which are compatible with the decomposition of $F l_{J}$ given in Example 3.2,

The following is a direct implication of Proposition 2.6,
Lemma 3.6. For $J \subseteq[n-1]$, we have

$$
\left[\text { Pet }_{J}\right]=\left[\text { Perm }_{J}\right] \quad \text { in } H_{*}\left(F l_{n} ; \mathbb{Z}\right)
$$

where $\left[\right.$ Pet $\left._{J}\right]$ and $\left[\right.$ Perm $\left._{J}\right]$ are the cycles representing the subvarieties Pet ${ }_{J}$ and Perm in $F l_{n}$, respectively.

Proof. Since Pet $_{J}$ and Perm $_{J}$ are both subvariety of $F l_{J}\left(\subseteq F l_{n}\right)$ by Lemma 3.4, it suffices to prove the equality in $H^{*}\left(F l_{J} ; \mathbb{Z}\right)$. The decomposition $F l_{J} \cong \prod_{k=1}^{m} F l_{n_{k}}$ given in (3.4) induces an isomorphism

$$
\xi: H_{*}\left(\prod_{k=1}^{m} F l_{n_{k}} ; \mathbb{Z}\right) \cong H_{*}\left(F l_{J} ; \mathbb{Z}\right)
$$

By [13, Example 1.10.2], we also have an isomorphism

$$
\zeta: \bigotimes_{k=1}^{m} H_{*}\left(F l_{n_{k}} ; \mathbb{Z}\right) \xlongequal{\cong} H_{*}\left(\prod_{k=1}^{m} F l_{n_{k}} ; \mathbb{Z}\right)
$$

such that $\zeta\left(\otimes_{k=1}^{m}\left[V_{k}\right]\right)=\left[\prod_{k=1}^{m} V_{k}\right]$ for irreducible subvarieties $V_{k} \subseteq F l_{n_{k}}$. By composing these two isomorphisms, we have

$$
\begin{align*}
& \xi \circ \zeta\left(\otimes_{k=1}^{m}\left[\text { Pet }_{n_{k}}\right]\right)=\xi\left(\left[\prod_{k=1}^{m} \text { Pet }_{n_{k}}\right]\right)=\left[\text { Pet }_{J}\right], \\
& \xi \circ \zeta\left(\otimes_{k=1}^{m}\left[\text { Perm }_{n_{k}}\right]\right)=\xi\left(\left[\prod_{k=1}^{m} \text { Perm }_{n_{k}}\right]\right)=\left[\text { Perm }_{J}\right] \tag{3.8}
\end{align*}
$$

since the isomorphisms in (3.7) are compatible with the isomorphism $F l_{J} \cong \prod_{k=1}^{m} F l_{n_{k}}$. By Proposition 2.6, we have the following equalities:

$$
\left[\text { Pet }_{n_{k}}\right]=\left[\operatorname{Perm}_{n_{k}}\right] \quad \text { in } H_{*}\left(F l_{n_{k}} ; \mathbb{Z}\right) \quad(1 \leq k \leq m)
$$

Therefore, (3.8) implies that

$$
\left[\text { Pet }_{J}\right]=\left[\text { Perm }_{J}\right] \quad \text { in } H_{*}\left(F l_{J} ; \mathbb{Z}\right)
$$

### 3.3. A proof of Theorem 1.1, Let

$$
i: \text { Pet }_{n} \hookrightarrow F l_{n}, \quad \text { and } \quad j: \operatorname{Perm}_{n} \hookrightarrow F l_{n}
$$

be the inclusion maps. We recall the following claim from 20 .
Proposition 3.7. ([20, Theorem 17]) The induced map $i_{*}: H_{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right) \rightarrow H_{*}\left(F l_{n} ; \mathbb{Z}\right)$ is an injective map whose image is a direct summand of $H_{*}\left(F l_{n} ; \mathbb{Z}\right)$.

Recall from Proposition 2.2 that $H_{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$ and $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$ are torsion free. Thus, the restriction map $i^{*}: H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$ on the cohomology groups is the dual map of $i_{*}$ in Proposition 3.7.

Corollary 3.8. ([20]) The restriction map $i^{*}: H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$ is surjective.
We now prove the following which gives us Theorem 1.1 in Section 1.
Theorem 3.9. There exists a unique isomorphism

$$
\varphi: H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}
$$

as graded rings such that the following diagram commutes.


Proof. The uniqueness of $\varphi$ follows from the commutativity of the diagram and the surjectivity of $i^{*}$ (Corollary 3.8). We construct such an isomorphism $\varphi$.

Let us begin with studying the induced maps on the homology groups:

$$
\begin{aligned}
& i_{*}: H_{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right) \rightarrow H_{*}\left(F l_{n} ; \mathbb{Z}\right), \\
& j_{*}: H_{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right) \rightarrow H_{*}\left(F l_{n} ; \mathbb{Z}\right) .
\end{aligned}
$$

We first claim that

$$
\begin{equation*}
\operatorname{Im} i_{*}=\operatorname{Im} j_{*} \quad \text { in } H_{*}\left(F l_{n} ; \mathbb{Z}\right) \tag{3.9}
\end{equation*}
$$

Let us prove this in the following. For this purpose, we take a particular basis of $H_{*}\left(P e t_{n} ; \mathbb{Z}\right)$ as follows. For each $J \subseteq[n-1]$, we have a cycle $\left[\right.$ Pet $\left._{J}\right]$ in $H_{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$, and it is shown in [5, Proposition 3.4 and Proposition 4.1] that these cycles form a $\mathbb{Z}$-basis of $H_{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$ :

$$
H_{*}\left(P e t_{n} ; \mathbb{Z}\right)=\bigoplus_{J \subseteq[n-1]} \mathbb{Z}\left[P e t_{J}\right]
$$

By Lemma 3.6, we have $i_{*}\left[\operatorname{Pet}{ }_{J}\right]=j_{*}\left[\operatorname{Perm}_{J}\right] \in \operatorname{Im} j_{*}$ for $J \subseteq[n-1]$. This implies that

$$
\begin{equation*}
\operatorname{Im} i_{*} \subseteq \operatorname{Im} j_{*} . \tag{3.10}
\end{equation*}
$$

Let us prove that $\operatorname{Im} i_{*}=\operatorname{Im} j_{*}$. Since the map $i_{*}$ is injective by Proposition 3.7, it follows from (3.10) and Proposition 2.2 that

$$
\begin{equation*}
2^{n-1}=\operatorname{rank}\left(\operatorname{Im} i_{*}\right) \leq \operatorname{rank}\left(\operatorname{Im} j_{*}\right) . \tag{3.11}
\end{equation*}
$$

As for $i_{*}$, the dual map of $j_{*}$ is precisely the restriction map

$$
j^{*}: H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)
$$

on the cohomology groups. For this map, we know from Proposition 2.4 that

$$
\begin{equation*}
\operatorname{rank}\left(\operatorname{Im} j^{*}\right) \leq \operatorname{rank} H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}} \leq 2^{n-1} \tag{3.12}
\end{equation*}
$$

Since $j^{*}$ is the dual map of $j_{*}$, we have

$$
\operatorname{rank}\left(\operatorname{Im} j_{*}\right)=\operatorname{dim}_{\mathbb{Q}}\left(\operatorname{Im} j_{*}^{\mathbb{Q}}\right)=\operatorname{dim}_{\mathbb{Q}}\left(\operatorname{Im} j_{\mathbb{Q}}^{*}\right)=\operatorname{rank}\left(\operatorname{Im} j^{*}\right),
$$

where the maps $j_{*}^{\mathbb{Q}}$ and $j_{\mathbb{Q}}^{*}$ are the homomorphisms $H_{*}\left(\operatorname{Perm}_{n} ; \mathbb{Q}\right) \rightarrow H_{*}\left(F l_{n} ; \mathbb{Q}\right)$ and $H^{*}\left(F l_{n} ; \mathbb{Q}\right) \rightarrow H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Q}\right)$ induced by the inclusion map $j:$ Perm $_{n} \rightarrow F l_{n}$, respectively. Thus, the inequalities in (3.11) and (3.12) must be equalities, and we
obtain $\operatorname{rank}\left(\operatorname{Im} i_{*}\right)=\operatorname{rank}\left(\operatorname{Im} j_{*}\right)$. Hence, by (3.10) and Proposition 3.7, it follows that $\operatorname{Im} i_{*}=\operatorname{Im} j_{*}$ as we claimed in (3.9).

Since $i_{*}: H_{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right) \rightarrow H_{*}\left(F l_{n} ; \mathbb{Z}\right)$ is an isomorphism onto its image, (3.9) means that there exists a surjective group homomorphism

$$
\psi: H_{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right) \rightarrow H_{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)
$$

which satisfies the following commutative diagram.


Now, we consider the following commutative diagram on the cohomology groups, where we denote by $\psi^{*}$ the dual map of $\psi$.


Since $i^{*}$ is surjective by Corollary 3.8, we have $\operatorname{Im} \psi^{*}=\operatorname{Im} j^{*}$ by the commutativity of this diagram. Also, we know from Proposition 2.4 (i) that $\operatorname{Im} j^{*} \subseteq H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}}$. Thus, we obtain the following commutative diagram.

$$
H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right) \xrightarrow[\psi^{*}]{H^{*}\left(F l_{n} ; \mathbb{Z}\right)} H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}}
$$

Since the map $i^{*}$ is a surjective ring homomorphism, it is the quotient map by an ideal of $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$. Hence, it follows that the map $\psi^{*}$ must be a ring homomorphism by the commutativity of this diagram. Namely, $\psi^{*}$ is the (graded) ring homomorphism induced by $j^{*}$. Since $\psi$ is surjective, the dual map $\psi^{*}$ is an injective map whose image is a direct summand of $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{S}_{n}}$. Thus, the quotient $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}} / \operatorname{Im} \psi^{*}$ is a free $\mathbb{Z}$-module, and its rank is less than or equal to 0 by Proposition 2.2 (i) and Proposition 2.4 (ii). Therefore, it follows that $\operatorname{Im} \psi^{*}=H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}$ so that $\psi^{*}$ is surjective. Letting $\varphi:=\psi^{*}$, we complete the proof.

Remark 3.10. Since we proved that $\psi^{*}$ is an isomorphism, it follows that the equality

$$
\operatorname{rank} H_{*}\left(\operatorname{Perm}_{n} ; \mathbb{Z}\right)^{\mathfrak{G}_{n}}=2^{n-1}
$$

holds for the inequality of Proposition 2.4 (ii).

Remark 3.11. The invariant subring $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Q}\right)^{\mathfrak{E}_{n}}$ with $\mathbb{Q}$ coefficients was studied by Klyachko $\left([21)\right.$, and he gave an explicit presentation of $H^{*}\left(\operatorname{Perm}_{n} ; \mathbb{Q}\right)^{\mathfrak{S}_{n}}$ (for arbitrary Lie types). See Nadeau-Tewari ([23, Sect. 8]) for an exposition of Klyachko's results. One can verify that it coincides with the presentation of $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Q}\right)$ given by Fukukawa-Harada-Masuda ([1]). See [3, 17] for a generalization to arbitrary Lie types.

## 4. An explicit presentation of the ring $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$

The aim of this section is to give an explicit presentation of the ring $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$ in terms of ring generators and their relations.
4.1. A ring presentation of $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$. We review the following well-known presentation of the cohomology ring of the flag variety $F l_{n}$. Our main reference is [12, Sect. 10.2]. For $1 \leq i \leq n$, let $E_{i}$ be the tautological vector bundle over $F l_{n}$ whose fiber over a point $V_{\bullet} \in F l_{n}$ is $V_{i}$. As a convention, let $E_{0}$ be the sub-bundle of $E_{1}$ of rank 0. Set

$$
\tau_{i}:=c_{1}\left(\left(E_{i} / E_{i-1}\right)^{*}\right) \in H^{2}\left(F l_{n} ; \mathbb{Z}\right) \quad(1 \leq i \leq n)
$$

where $c_{1}\left(\left(E_{i} / E_{i-1}\right)^{*}\right)$ is the first Chern class of the dual line bundle of the tautological line bundld $E_{i} / E_{i-1}$. By definition, we have short exact sequences

$$
0 \rightarrow\left(E_{i} / E_{i-1}\right)^{*} \rightarrow E_{i}^{*} \rightarrow E_{i-1}^{*} \rightarrow 0 \quad(1 \leq i \leq n)
$$

From these sequences, it follows that

$$
c_{k}\left(E_{n}^{*}\right)=e_{k}\left(\tau_{1}, \tau_{2}, \ldots, \tau_{n}\right) \quad(1 \leq k \leq n),
$$

where $e_{k}\left(\tau_{1}, \tau_{2}, \ldots, \tau_{n}\right)$ is the $k$-th elementary symmetric polynomial in $\tau_{1}, \tau_{2}, \ldots, \tau_{n}$. Since $E_{n}^{*}$ is a trivial bundle of rank $n$, this implies that we have

$$
\begin{equation*}
e_{k}\left(\tau_{1}, \tau_{2}, \ldots, \tau_{n}\right)=0 \quad \text { in } H^{*}\left(F l_{n} ; \mathbb{Z}\right) \quad(1 \leq k \leq n) \tag{4.1}
\end{equation*}
$$

Let $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ be the polynomial ring over $\mathbb{Z}$ with indeterminates $y_{1}, y_{2}, \ldots, y_{n}$. The ring $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$ is generated by $\tau_{1}, \tau_{2}, \ldots, \tau_{n}$, and hence we have a surjective ring homomorphism

$$
\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] \rightarrow H^{*}\left(F l_{n} ; \mathbb{Z}\right)
$$

which sends $y_{i}$ to $\tau_{i}(1 \leq i \leq n)$. By (4.1), this induces a surjective ring homomorphism

$$
\begin{equation*}
\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(e_{1}(y), e_{2}(y), \ldots, e_{n}(y)\right) \rightarrow H^{*}\left(F l_{n} ; \mathbb{Z}\right) \tag{4.2}
\end{equation*}
$$

where $\left(e_{1}(y), e_{2}(y), \ldots, e_{n}(y)\right)$ is the ideal of $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ generated by $e_{k}(y)=$ $e_{k}\left(y_{1}, y_{2}, \ldots, y_{n}\right)$ for $1 \leq k \leq n$. It is well-known that (4.2) is an isomorphism.

[^0]4.2. A module basis of $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$. We set
\[

$$
\begin{equation*}
x_{i}:=c_{1}\left(\left.\left(E_{i} / E_{i-1}\right)^{*}\right|_{\text {Pet }_{n}}\right) \in H^{2}\left(\text { Pet }_{n} ; \mathbb{Z}\right) \quad(1 \leq i \leq n) . \tag{4.3}
\end{equation*}
$$

\]

Namely, $x_{i}$ is the image of $\tau_{i}$ under the restriction map $i^{*}: H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$ for $1 \leq i \leq n$. We also set

$$
\begin{equation*}
\varpi_{i}:=x_{1}+x_{2}+\cdots+x_{i} \in H^{2}\left(\text { Pet }_{n} ; \mathbb{Z}\right) \quad(1 \leq i \leq n-1) . \tag{4.4}
\end{equation*}
$$

For $J \subseteq[n-1]$, we have the decomposition $J=J_{1} \sqcup \cdots \sqcup J_{m}$ into the connected components (see section 2.5), and we set

$$
\begin{equation*}
\varpi_{J}:=\frac{1}{m_{J}} \prod_{i \in J} \varpi_{i}, \tag{4.5}
\end{equation*}
$$

where $m_{J}$ is the positive integer defined by $m_{J}:=\left|J_{1}\right|!\left|J_{2}\right|!\cdots\left|J_{m}\right|!$. This $\varpi_{J}$ is defined in $H^{2|J|}\left(\right.$ Pet $\left._{n} ; \mathbb{Q}\right)$, but we have the following theorem.

Theorem 4.1. ([5, Theorem 4.13]) For each $J \subseteq[n-1]$, the cohomology class $\varpi_{J}$ is an element of the integral cohomology group $H^{2|J|}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$, and the set

$$
\left\{\varpi_{J} \in H^{2|J|}\left(\text { Pet }_{n} ; \mathbb{Z}\right) \mid J \subseteq[n-1]\right\}
$$

is a $\mathbb{Z}$-basis of $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$.

In what follows, we give an integral expression for $\varpi_{J}$ in terms of $x_{1}, x_{2}, \ldots, x_{n}$ (see Corollary 4.7 below). For this purpose, we prepare two technical lemmas.

Lemma 4.2. For $1 \leq i \leq n-1$, we have

$$
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}=\left(x_{1}^{d}+x_{2}^{d}+\cdots+x_{i}^{d}\right) x_{i+1} \quad(d=1,2, \ldots) .
$$

Proof. We first prove the claim for the case $d=1$ with $1 \leq i \leq n-1$. Recall from [5, Lemma 4.7] (cf. [11] and [17]) that we have

$$
\begin{equation*}
\alpha_{j} \varpi_{j}=0 \quad(1 \leq j \leq n-1), \tag{4.6}
\end{equation*}
$$

where $\alpha_{j}:=x_{j}-x_{j+1}$. Since we have $\varpi_{j}=\varpi_{j-1}+x_{j}$ by definition (with the convention $\varpi_{0}=0$ ), we have from (4.6) that

$$
\left(x_{j}-x_{j+1}\right)\left(\varpi_{j-1}+x_{j}\right)=0 \quad(1 \leq j \leq n-1) .
$$

From this, we obtain

$$
\begin{align*}
x_{j}^{2} & =\left(\varpi_{j-1}+x_{j}\right) x_{j+1}-\varpi_{j-1} x_{j}  \tag{4.7}\\
& \left.=\varpi_{j} x_{j+1}-\varpi_{j-1} x_{j} \quad \text { (by } \varpi_{j}=\varpi_{j-1}+x_{j} \text { again }\right)
\end{align*}
$$

for $1 \leq j \leq n-1$. Thus, we obtain

$$
\begin{aligned}
x_{1}^{2}+x_{2}^{2}+\cdots+x_{i}^{2} & =\left(\varpi_{1} x_{2}-\varpi_{0} x_{1}\right)+\left(\varpi_{2} x_{3}-\varpi_{1} x_{2}\right)+\cdots+\left(\varpi_{i} x_{i+1}-\varpi_{i-1} x_{i}\right) \\
& =-\varpi_{0} x_{1}+\varpi_{i} x_{i+1} \\
& =\left(x_{1}+x_{2}+\cdots+x_{i}\right) x_{i+1}
\end{aligned}
$$

which gives the claim for $d=1$.
We assume that $d \geq 2$ in what follows, and we prove the claim of this lemma by induction on $d$. Assume by induction that

$$
\begin{equation*}
x_{1}^{\ell+1}+x_{2}^{\ell+1}+\cdots+x_{i}^{\ell+1}=\left(x_{1}^{\ell}+x_{2}^{\ell}+\cdots+x_{i}^{\ell}\right) x_{i+1} \quad(1 \leq \ell \leq d-1), \tag{4.8}
\end{equation*}
$$

and we prove the claim for the case $\ell=d$. To begin with, notice that

$$
x_{j}^{d+1}=x_{j}^{2} \cdot x_{j}^{d-1}=\varpi_{j} x_{j}^{d-1} x_{j+1}-\varpi_{j-1} x_{j}^{d} \quad(1 \leq j \leq n-1)
$$

by (4.7). Thus, we have

$$
\begin{equation*}
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}=\sum_{j=1}^{i} \varpi_{j} x_{j}^{d-1} x_{j+1}-\sum_{j=1}^{i} \varpi_{j-1} x_{j}^{d} . \tag{4.9}
\end{equation*}
$$

The second summand in the right hand side can be written as

$$
-\sum_{j=1}^{i} \varpi_{j-1} x_{j}^{d}=-\sum_{j=0}^{i-1} \varpi_{j} x_{j+1}^{d}=-\sum_{j=1}^{i} \varpi_{j} x_{j+1}^{d}+\varpi_{i} x_{i+1}^{d}
$$

since $\varpi_{0}=0$ by convention. Applying this to (4.9), we obtain

$$
\begin{equation*}
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}=\sum_{j=1}^{i} \varpi_{j}\left(x_{j}^{d-1}-x_{j+1}^{d-1}\right) x_{j+1}+\varpi_{i} x_{i+1}^{d} . \tag{4.10}
\end{equation*}
$$

In this equality, the first summand in the right hand side vanishes since it can be computed as

$$
\begin{aligned}
\sum_{j=1}^{i} \varpi_{j}\left(x_{j}^{d-1}-x_{j+1}^{d-1}\right) x_{j+1} & =\sum_{j=1}^{i} \varpi_{j}\left(x_{j}-x_{j+1}\right)\left(x_{j}^{d-2}+x_{j}^{d-3} x_{j+1}+\cdots+x_{j+1}^{d-2}\right) x_{j+1} \\
& =0 \quad(\text { by (4.6) }),
\end{aligned}
$$

where we take the convention $x_{j}^{d-2}+x_{j}^{d-3} x_{j+1}+\cdots+x_{j+1}^{d-2}=1$ when $d=2$. Therefore, (4.10) and $\varpi_{i}=x_{1}+x_{2}+\cdots+x_{i}$ imply that

$$
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}=\left(x_{1}+x_{2}+\cdots+x_{i}\right) x_{i+1}^{d} .
$$

Applying the inductive hypothesis (4.8) to the right hand side repeatedly, we obtain

$$
\begin{aligned}
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1} & =\left(x_{1}+x_{2}+\cdots+x_{i}\right) x_{i+1}^{d} \\
& =\left(x_{1}^{2}+x_{2}^{2}+\cdots+x_{i}^{2}\right) x_{i+1}^{d-1} \\
& =\cdots \\
& =\left(x_{1}^{d}+x_{2}^{d}+\cdots+x_{i}^{d}\right) x_{i+1}
\end{aligned}
$$

which gives (4.8) for the case $\ell=d$, as desired.

For $1 \leq i \leq n$ and a partition $\lambda=\left(\lambda_{1}, \lambda_{2}, \ldots\right)$ consisting of a weakly decreasing sequence of non-negative integers, let $m_{\lambda}\left(x_{1}, x_{2} \ldots, x_{i}\right)$ be the monomial symmetric polynomial in $x_{1}, x_{2} \ldots, x_{i} \in H^{2}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$. That is, $m_{\lambda}\left(x_{1}, x_{2} \ldots, x_{i}\right)$ is the sum of all distinct monomials obtained from $x_{1}^{\lambda_{1}} x_{2}^{\lambda_{2}} \cdots x_{i}^{\lambda_{i}}$ by permuting the indices (e.g., [12, Sect. 6.1]). For a positive integer $d$ and a non-negative integer $k$, we denote by ( $d, 1^{k}$ ) the partition given by

$$
\left(d, 1^{k}\right)=(d, \underbrace{1,1, \ldots, 1}_{k}, 0,0, \cdots) .
$$

For $1 \leq k<i \leq n$, we have the following identity:

$$
\begin{align*}
\left(x_{1}^{d}+\right. & \left.\cdots+x_{i}^{d}\right) e_{k}\left(x_{1}, x_{2}, \ldots x_{i}\right) \\
& =m_{d+1,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)+m_{d, 1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) \quad(d=2,3, \ldots) . \tag{4.11}
\end{align*}
$$

One may obtain this identity by expanding the product in the left hand side and rearranging terms, without using any non-trivial algebraic relations for $x_{1}, x_{2}, \ldots, x_{n}$ in $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$. The following example illustrates the idea of the proof.

Example 4.3. Let $d=5, i=4$, and $k=3$. Then we have

$$
\begin{aligned}
\left(x_{1}^{5}\right. & \left.+x_{2}^{5}+x_{3}^{5}+x_{4}^{5}\right) e_{3}\left(x_{1}, x_{2}, x_{3}, x_{4}\right) \\
& =\left(x_{1}^{5}+x_{2}^{5}+x_{3}^{5}+x_{4}^{5}\right) \cdot\left(x_{1} x_{2} x_{3}+x_{1} x_{2} x_{4}+x_{1} x_{3} x_{4}+x_{2} x_{3} x_{4}\right) \\
& =m_{6,1,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)+m_{5,1,1,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)
\end{aligned}
$$

where we have

$$
\begin{array}{r}
m_{6,1,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)=x_{1}^{6} x_{2} x_{3}+x_{1}^{6} x_{2} x_{4}+x_{1}^{6} x_{3} x_{4}+x_{2}^{6} x_{1} x_{3}+x_{2}^{6} x_{1} x_{4}+x_{2}^{6} x_{3} x_{4} \\
+x_{3}^{6} x_{1} x_{2}+x_{3}^{6} x_{1} x_{4}+x_{3}^{6} x_{2} x_{4}+x_{4}^{6} x_{1} x_{2}+x_{4}^{6} x_{1} x_{3}+x_{4}^{6} x_{2} x_{3}
\end{array}
$$

and

$$
m_{5,1,1,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)=x_{1}^{5} x_{2} x_{3} x_{4}+x_{2}^{5} x_{1} x_{3} x_{4}+x_{3}^{5} x_{1} x_{2} x_{4}+x_{4}^{5} x_{1} x_{2} x_{3} .
$$

We note that we have a slightly different identity when $d=1$. Namely, we have

$$
\begin{align*}
\left(x_{1}+\right. & \left.\cdots+x_{i}\right) e_{k}\left(x_{1}, x_{2}, \ldots x_{i}\right)  \tag{4.12}\\
& =m_{2,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)+(k+1) m_{1^{k+1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)
\end{align*}
$$

for $1 \leq k<i \leq n$. Similarly to (4.11), this identity can be obtained by expanding the product in the left hand side as illustrated in the following example.

Example 4.4. Let $i=4$ and $k=2$. Then we have

$$
\begin{aligned}
& \left(x_{1}+x_{2}+x_{3}+x_{4}\right) e_{2}\left(x_{1}, x_{2}, x_{3}, x_{4}\right) \\
& \quad=\left(x_{1}+x_{2}+x_{3}+x_{4}\right)\left(x_{1} x_{2}+x_{1} x_{3}+x_{1} x_{4}+x_{2} x_{3}+x_{2} x_{4}+x_{3} x_{4}\right)
\end{aligned}
$$

which is equal to the sum of

$$
\begin{aligned}
m_{2,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)=x_{1}^{2} x_{2} & +x_{1}^{2} x_{3}+x_{1}^{2} x_{4}+x_{2}^{2} x_{1}+x_{2}^{2} x_{3}+x_{2}^{2} x_{4} \\
& +x_{3}^{2} x_{1}+x_{3}^{2} x_{2}+x_{3}^{2} x_{4}+x_{4}^{2} x_{1}+x_{4}^{2} x_{2}+x_{4}^{2} x_{3}
\end{aligned}
$$

and

$$
\begin{aligned}
& x_{1}\left(x_{2} x_{3}+x_{3} x_{4}+x_{2} x_{4}\right)+x_{2}\left(x_{1} x_{3}+x_{1} x_{4}+x_{3} x_{4}\right) \\
& \quad+x_{3}\left(x_{1} x_{2}+x_{1} x_{4}+x_{2} x_{4}\right)+x_{4}\left(x_{1} x_{2}+x_{1} x_{3}+x_{2} x_{3}\right)=3 m_{1,1,1}\left(x_{1}, x_{2}, x_{3}, x_{4}\right) .
\end{aligned}
$$

The next claim generalizes the previous lemma.
Lemma 4.5. For $0 \leq k<i \leq n-1$, we have

$$
m_{d+1,1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)= \begin{cases}m_{d, 1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d \geq 2) \\ (k+1) m_{1^{k+1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d=1)\end{cases}
$$

Proof. When $k=0$, the claim is

$$
m_{d+1,1^{0}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)= \begin{cases}m_{d, 1^{0}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d \geq 2), \\ m_{1^{1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d=1)\end{cases}
$$

which is equivalent to

$$
\begin{equation*}
x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}=\left(x_{1}^{d}+x_{2}^{d}+\cdots+x_{i}^{d}\right) x_{i+1} \quad(d \geq 1) . \tag{4.13}
\end{equation*}
$$

Thus, the claim follows by the previous lemma when $k=0$.
We assume that $1 \leq k<i$ in what follows, and we prove the claim of this lemma by induction on $k$. Assume by induction that

$$
m_{d+1,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)= \begin{cases}m_{d, 1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d \geq 2)  \tag{4.14}\\ k m_{1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d=1)\end{cases}
$$

Multiplying $e_{k}\left(x_{1}, x_{2}, \ldots, x_{i}\right)$ to the both sides of (4.13), we have

$$
\begin{align*}
& \left(x_{1}^{d+1}+x_{2}^{d+1}+\cdots+x_{i}^{d+1}\right) e_{k}\left(x_{1}, x_{2}, \ldots, x_{i}\right) \\
& \quad=\left(x_{1}^{d}+x_{2}^{d}+\cdots+x_{i}^{d}\right) e_{k}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} . \tag{4.15}
\end{align*}
$$

By (4.11), the left hand side of (4.15) is equal to

$$
\begin{equation*}
m_{d+2,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)+m_{d+1,1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) \tag{4.16}
\end{equation*}
$$

since $d+1 \geq 2$. By (4.11) and (4.12), the right hand side of (4.15) is equal to

$$
\begin{cases}m_{d+1,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1}+m_{d, 1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d \geq 2)  \tag{4.17}\\ m_{2,1^{k-1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1}+(k+1) m_{1^{k+1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d=1)\end{cases}
$$

In both cases of $d \geq 2$ and $d=1$, the first summands in (4.16) and (4.17) coincide because of the first case of the inductive hypothesis (4.14). Thus, the equality (4.15) implies that

$$
m_{d+1,1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right)= \begin{cases}m_{d, 1^{k}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d \geq 2) \\ (k+1) m_{1^{k+1}}\left(x_{1}, x_{2}, \ldots, x_{i}\right) x_{i+1} & (d=1)\end{cases}
$$

as desired.

For the next proposition, we recall that $\varpi_{i}=x_{1}+x_{2}+\cdots+x_{i}$ for $1 \leq i \leq n-1$ from (4.4).

Proposition 4.6. For $1 \leq a \leq b \leq n-1$, we have

$$
\underbrace{\varpi_{a} \varpi_{a+1} \cdots \varpi_{b}}_{k}=k!e_{k}\left(x_{1}, x_{2}, \ldots, x_{b}\right),
$$

where $k=b-a+1$.

Proof. For the case $k=1$ (i.e., $b=a$ ), the claim is obvious by (4.4). We assume that $k \geq 2$, and we prove the claim by induction on $k$. By the inductive hypothesis, the left hand side can be computed as

$$
\begin{aligned}
& \left(\varpi_{a} \varpi_{a+1} \cdots \varpi_{b-1}\right) \cdot \varpi_{b} \\
& \quad=(k-1)!e_{k-1}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right) \cdot \varpi_{b} \\
& \quad=(k-1)!e_{k-1}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right) \cdot\left(x_{1}+x_{2}+\cdots+x_{b-1}+x_{b}\right) \\
& \quad=(k-1)!\left(\left(x_{1}+\cdots+x_{b-1}\right) e_{k-1}\left(x_{1}, \ldots, x_{b-1}\right)+e_{k-1}\left(x_{1}, \ldots, x_{b-1}\right) x_{b}\right) .
\end{aligned}
$$

Applying (4.12) to the last expression, we obtain

$$
\begin{align*}
& \left(\varpi_{a} \varpi_{a+1} \cdots \varpi_{b-1}\right) \cdot \varpi_{b} \\
& =(k-1)!\left(m_{2,1^{k-2}}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right)+k m_{1^{k}}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right)\right.  \tag{4.18}\\
& \left.+e_{k-1}\left(x_{1}, \ldots, x_{b-1}\right) x_{b}\right) .
\end{align*}
$$

For the second summand in the parenthesis of the right hand side, we have

$$
\begin{aligned}
k m_{1^{k}}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right) & \left.=k e_{k}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right) \quad \text { (by the definition of } m_{1^{k}}\right) \\
& =k e_{k}\left(x_{1}, x_{2}, \ldots, x_{b}\right)-k e_{k-1}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right) x_{b} .
\end{aligned}
$$

Applying this to (4.18), we obtain

$$
\begin{aligned}
&\left(\varpi_{a} \varpi_{a+1} \cdots \varpi_{b-1}\right) \cdot \varpi_{b} \\
&=(k-1)!\left(m_{2,1^{k-2}}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right)+\right. k e_{k}\left(x_{1}, x_{2}, \ldots, x_{b}\right) \\
&\left.\quad(k-1) e_{k-1}\left(x_{1}, \ldots, x_{b-1}\right) x_{b}\right) \\
&=(k-1)!\left(m_{2,1^{k-2}}\left(x_{1}, x_{2}, \ldots, x_{b-1}\right)+\right. k e_{k}\left(x_{1}, x_{2}, \ldots, x_{b}\right) \\
&\left.-(k-1) m_{1^{k-1}}\left(x_{1}, \ldots, x_{b-1}\right) x_{b}\right),
\end{aligned}
$$

where we used $e_{k-1}\left(x_{1}, \ldots, x_{b-1}\right)=m_{1^{k-1}}\left(x_{1}, \ldots, x_{b-1}\right)$ again for the last equality. In the last expression, the sum of the first and the third summands is equal to 0 by the case $d=1$ of Lemma 4.5 since $0 \leq k-2<b-1$. Thus, the last expression is equal to $k!e_{k}\left(x_{1}, x_{2}, \ldots, x_{b}\right)$.

We now obtain the following formula which expresses $\varpi_{J}$ in (4.5) as an integer coefficient polynomial in $x_{1}, x_{2}, \ldots, x_{n}$.

Corollary 4.7. For $J \subseteq[n-1]$, we have

$$
\varpi_{J}=\prod_{k=1}^{m} e_{\left|J_{k}\right|}\left(x_{1}, x_{2}, \ldots, x_{\max J_{k}}\right) \quad \text { in } H^{2|J|}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

where $J=J_{1} \sqcup J_{2} \sqcup \cdots \sqcup J_{m}$ is the decomposition into the connected components.
Proof. The previous proposition implies that

$$
\prod_{i \in J} \varpi_{i}=\prod_{k=1}^{m}\left(\prod_{i \in J_{k}} \varpi_{i}\right)=\prod_{k=1}^{m}\left(\left|J_{k}\right|!e_{\left|J_{k}\right|}\left(x_{1}, x_{2}, \ldots, x_{\max J_{k}}\right)\right)
$$

because each component $J_{k}$ is of the form $J_{k}=\{a, a+1, \ldots, b\}$ for some $a, b \in[n-1]$. Since $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$ is torsion free by Proposition [2.2, we obtain the claim by dividing both sides of this equality by $m_{J}=\left|J_{1}\right|!\left|J_{2}\right|!\cdots\left|J_{m}\right|!$.

Example 4.8. Let $n=7$. Then we have

$$
\begin{aligned}
& \varpi_{\{3,4,5\}}=\frac{1}{6} \varpi_{3} \varpi_{4} \varpi_{5}=e_{3}\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right), \\
& \varpi_{\{2,4,5\}}=\frac{1}{2} \varpi_{2} \varpi_{4} \varpi_{5}=e_{1}\left(x_{1}, x_{2}\right) e_{2}\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right) .
\end{aligned}
$$

4.3. A ring presentation of $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$. Recall from (4.3) that we have

$$
x_{i}=c_{1}\left(\left.\left(E_{i} / E_{i-1}\right)^{*}\right|_{\text {Pet }_{n}}\right) \in H^{2}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

and that it is the image of $\tau_{i}=c_{1}\left(\left(E_{i} / E_{i-1}\right)^{*}\right) \in H^{2}\left(F l_{n} ; \mathbb{Z}\right)$ under the restriction map

$$
i^{*}: H^{*}\left(F l_{n} ; \mathbb{Z}\right) \rightarrow H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)
$$

The ring $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$ is generated by $\tau_{1}, \tau_{2}, \ldots, \tau_{n}$ as we saw in section 4.1, and the map $i^{*}$ is surjective by [20] (see Corollary (3.8). Thus, we have a surjective ring homomorphism

$$
\phi: \mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] \rightarrow H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

which sends $y_{i}$ to $x_{i}(1 \leq i \leq n)$, where $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ is the polynomial ring over $\mathbb{Z}$ with indeterminates $y_{1}, y_{2}, \ldots, y_{n}$. We regard this polynomial ring as a graded ring with $\operatorname{deg} y_{i}=2$ for $1 \leq i \leq n$. By construction, this map factors $H^{*}\left(F l_{n} ; \mathbb{Z}\right)$, and hence it maps $e_{k}\left(y_{1}, y_{2}, \ldots, y_{n}\right)$ to 0 in $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$ for $1 \leq k \leq n$ (see section 4.11).

To give a ring presentation of $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$, we introduce the following homogeneous ideals of $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ :

$$
\begin{align*}
& I:=\left(e_{k}\left(y_{1}, y_{2}, \ldots, y_{n}\right) \mid 1 \leq k \leq n\right) \\
& I^{\prime}:=\left(\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right) \mid 1 \leq i \leq n-1,1 \leq k \leq \min \{i, n-i\}\right) . \tag{4.19}
\end{align*}
$$

Example 4.9. Let $n=4$. The ideal $I$ of $\mathbb{Z}\left[y_{1}, y_{2}, y_{3}, y_{4}\right]$ is generated by

$$
\begin{equation*}
e_{1}\left(y_{1}, y_{2}, y_{3}, y_{4}\right), e_{2}\left(y_{1}, y_{2}, y_{3}, y_{4}\right), e_{3}\left(y_{1}, y_{2}, y_{3}, y_{4}\right), e_{4}\left(y_{1}, y_{2}, y_{3}, y_{4}\right), \tag{4.20}
\end{equation*}
$$

and the ideal $I^{\prime}$ is generated by

$$
\begin{equation*}
\left(y_{1}-y_{2}\right) y_{1},\left(y_{2}-y_{3}\right)\left(y_{1}+y_{2}\right),\left(y_{2}-y_{3}\right) y_{1} y_{2},\left(y_{3}-y_{4}\right)\left(y_{1}+y_{2}+y_{3}\right) \tag{4.21}
\end{equation*}
$$

From what we saw above, it is clear that the map $\phi$ sends the ideal $I$ to 0 in $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$. It follows that $\phi$ also sends $I^{\prime}$ to 0 . To see that, it suffices to show that

$$
\begin{equation*}
\left(x_{i}-x_{i+1}\right) e_{k}\left(x_{1}, \ldots, x_{i}\right)=0 \quad(1 \leq k \leq i \leq n-1) \tag{4.22}
\end{equation*}
$$

in $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$, where we note that the range of $k$ is larger than that of in (4.19). For this purpose, let $1 \leq k \leq i \leq n-1$. By Proposition 4.6, we have

$$
k!e_{k}\left(x_{1}, \ldots, x_{i}\right)=\varpi_{i-k+1} \varpi_{i-k+2} \cdots \varpi_{i}
$$

Recalling that $x_{i}-x_{i+1}=\alpha_{i}$, we obtain

$$
k!\left(x_{i}-x_{i+1}\right) e_{k}\left(x_{1}, \ldots, x_{i}\right)=\alpha_{i} \varpi_{i-k+1} \varpi_{i-k+2} \cdots \varpi_{i} .
$$

The right hand side of this equality is 0 by (4.6) so that we obtain

$$
k!\left(x_{i}-x_{i+1}\right) e_{k}\left(x_{1}, \ldots, x_{i}\right)=0 .
$$

Since $H^{*}\left(P e t_{n} ; \mathbb{Z}\right)$ is torsion free by Proposition [2.2, this implies the equality (4.22). Hence, $\phi$ sends $I^{\prime}$ to 0 , as we claimed above.

Remark 4.10. Geometric meaning of the relation (4.22) can be explained as follows. By Corollary 4.7, it can be expressed as

$$
\alpha_{i} \cdot \varpi_{J}=0,
$$

where we set $J=\{i-k+1, i-k+2, \ldots, i\}$. In [5], two kinds of closed subsets $X_{J}\left(=P e t_{J}\right)$ and $\Omega_{J}$ in $P e t_{n}$ are introduced, and this equality can be explained from the corresponding geometric equality

$$
X_{\{i\}} \cap \Omega_{J}=\emptyset
$$

by an argument similar to that in the proof of [5, Lemma 4.7]. See [5, Sect. 3 and 4] for details.

Since the map $\phi$ sends both of $I$ and $I^{\prime}$ to 0 , it induces a surjective ring homomorphism

$$
\bar{\phi}: \mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right) \rightarrow H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

which sends $y_{i}$ to $x_{i}(1 \leq i \leq n)$. Here, we use the same symbol $y_{i}$ for its image in the quotient $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right)$ by abusing notation. We adopt this notation in the rest of this paper.

The next claim gives Theorem 1.2 in Section 1 which describes the ring structure of $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$.

Theorem 4.11. The induced homomorphism

$$
\bar{\phi}: \mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right) \rightarrow H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

sending $y_{i}$ to $x_{i}=c_{1}\left(\left.\left(E_{i} / E_{i-1}\right)^{*}\right|_{\text {Pet }} ^{n} 10\right)(1 \leq i \leq n)$ is an isomorphism as graded rings, where $I$ and $I^{\prime}$ are the ideals of $\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right]$ defined in (4.19).

The rest of this paper is devoted for the proof of Theorem 4.11.
Remark 4.12. The relation (4.22) for $k=1$ takes the form

$$
\alpha_{i} \cdot \varpi_{i}=\left(x_{i}-x_{i+1}\right)\left(x_{1}+\cdots+x_{i}\right)=0 \quad \text { in } H^{*}\left(\text { Pet }_{n} ; \mathbb{Z}\right)
$$

which appears as the fundamental relations of the presentation of the cohomology ring $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{C}\right)$ in [11, Corollary 3.4] and [17, Theorem 4.1] (cf. [5, Remark 4.8]).

Remark 4.13. Let $n=4$. If we remove $\left(y_{2}-y_{3}\right) y_{1} y_{2}$ from the list (4.21) of the generators of $I^{\prime}$, then the quotient ring $\mathbb{Z}\left[y_{1}, y_{2}, y_{3}, y_{4}\right] /\left(I+I^{\prime}\right)$ is not isomorphic to $H^{*}\left(\operatorname{Pet}_{4} ; \mathbb{Z}\right)$ since $\left(y_{2}-y_{3}\right) y_{1} y_{2}$ gives a non-zero 2 -torsion element of the quotient ring. This can be verified by a computer assisted calculation. Similarly, if we remove $e_{k}\left(y_{1}, y_{2}, y_{3}, y_{4}\right)$ for some $1 \leq k \leq 4$ from the list (4.20) of the generators of $I$, then the quotient ring $\mathbb{Z}\left[y_{1}, y_{2}, y_{3}, y_{4}\right] /\left(I+I^{\prime}\right)$ is not isomorphic to $H^{*}\left(\right.$ Pet $\left._{4} ; \mathbb{Z}\right)$.

Set

$$
M:=\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right) .
$$

If we can construct a subset $\left\{\pi_{J} \mid J \subseteq[n-1]\right\}$ of $M$ which generates $M$ as a $\mathbb{Z}$ module and satisfies $\bar{\phi}\left(\pi_{J}\right)=\varpi_{J}$ for $J \subseteq[n-1]$, then it follows that the map $\bar{\phi}$ is an isomorphism since $\varpi_{J}$ for $J \subseteq[n-1]$ form a $\mathbb{Z}$-basis of $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$ by Theorem 4.1.

Motivated by Corollary 4.7, we define $\pi_{J} \in M$ for each $J \subseteq[n-1]$ as follows. For a subset $J \subseteq[n-1]$ having the decomposition $J=J_{1} \sqcup \cdots \sqcup J_{m}$ into the connected components (see section 2.5), we set

$$
\begin{equation*}
\pi_{J}:=\prod_{k=1}^{m} e_{\left|J_{k}\right|}\left(y_{1}, y_{2}, \ldots, y_{\max J_{k}}\right) \in M \tag{4.23}
\end{equation*}
$$

where we take the convention

$$
\begin{equation*}
\pi_{\emptyset}=1 \in M . \tag{4.24}
\end{equation*}
$$

We also define $\pi_{J}$ for all $J \subseteq \mathbb{Z}$ by taking the convention

$$
\begin{equation*}
\pi_{J}=0 \quad \text { unless } J \subseteq[n-1] . \tag{4.25}
\end{equation*}
$$

Example 4.14. Let $n=7$. Then we have

$$
\begin{aligned}
& \pi_{\{3,4,5\}}=e_{3}\left(y_{1}, y_{2}, y_{3}, y_{4}, y_{5}\right), \\
& \pi_{\{2,4,5\}}=e_{1}\left(y_{1}, y_{2}\right) e_{2}\left(y_{1}, y_{2}, y_{3}, y_{4}, y_{5}\right)
\end{aligned}
$$

in $M$ (cf. Example 4.8). We also have $\pi_{\{0,2\}}=0$ and $\pi_{\{4,5,7\}}=0$ by (4.25).
Recall that we have $\bar{\phi}\left(y_{i}\right)=x_{i}$ for $1 \leq i \leq n$ by definition. Hence, it is clear that we have $\bar{\phi}\left(\pi_{J}\right)=\varpi_{J}$ for $J \subseteq[n-1]$ by Corollary 4.7. Thus, to prove Theorem 4.11, it is enough to show the following claim as we discussed above.

Proposition 4.15. The $\mathbb{Z}$-module $M=\mathbb{Z}\left[y_{1}, y_{2}, \ldots, y_{n}\right] /\left(I+I^{\prime}\right)$ is generated by the subset $\left\{\pi_{J} \mid J \subseteq[n-1]\right\}$.

We prove this in the next subsection.
4.4. A Proof of Proposition 4.15, Before giving a proof of Proposition 4.15, we first establish some basic properties of $\pi_{J}$ for $J \subseteq[n-1]$. We begin with the following identity in $M$ :

$$
\begin{equation*}
e_{k}\left(y_{1}, y_{2}, \ldots, y_{n}\right)=\sum_{\substack{0 \leq p \leq i, 0 \leq q \leq n-i \\ p+q=k}} e_{p}\left(y_{1}, y_{2}, \ldots, y_{i}\right) e_{q}\left(y_{i+1}, y_{i+2}, \ldots, y_{n}\right) \tag{4.26}
\end{equation*}
$$

for $1 \leq k \leq i \leq n$, where we take the convention $e_{0}=1$. One may obtain this identity by decomposing the index set $[n]$ of monomials in the left hand side into two parts: $[n]=\{1,2, \ldots, i\} \sqcup\{i+1, i+2, \ldots, n\}$.

For $1 \leq i \leq n-1$, recall from the definition of $M$ that we have

$$
\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right)=0 \quad(1 \leq k \leq \min \{i, n-i\})
$$

The following claim means that the same equalities hold for a wider range of $k$.
Lemma 4.16. For $1 \leq i \leq n-1$, we have

$$
\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right)=0 \quad(1 \leq k \leq i)
$$

in $M$.
Proof. If $1 \leq k \leq n-i$, then we have $k \leq \min \{i, n-i\}$ (since $k \leq i$, and the claim holds by the definition of $M$ as we saw above.

If $n-i<k \leq i$, then we prove the claim by induction on $k$, where we note that we already verified the claim for $1 \leq k \leq n-i$. Hence, we assume by induction that the claim holds when $k \leq \ell$ for some positive integer $\ell$ satisfying $n-i \leq \ell<i$, and we prove the claim when $k=\ell+1$. Since we have $e_{k}\left(y_{1}, \ldots, y_{n}\right)=0$ by the definition $M$, we know that

$$
\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{n}\right)=0 .
$$

By (4.26), this equality can be written as

$$
\sum_{\substack{0 \leq p \leq i, 0 \leq q \leq n-i \\ p+q=k}}\left(y_{i}-y_{i+1}\right) e_{p}\left(y_{1}, \ldots, y_{i}\right) e_{q}\left(y_{i+1}, \ldots, y_{n}\right)=0 .
$$

Because of the condition $1 \leq k \leq i$, it follows that the summand for $q=0$ (i.e., $p=k$ ) appears in the left hand side of this equality. Thus, we can separate it to obtain

$$
\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right)+\sum_{\substack{0 \leq p \leq i, 1 \leq q \leq n-i \\ p+q=k}}\left(y_{i}-y_{i+1}\right) e_{p}\left(y_{1}, \ldots, y_{i}\right) e_{q}\left(y_{i+1}, \ldots, y_{n}\right)=0 .
$$

In the second summand, we have $p=k-q>(n-i)-q \geq 0$ since we are considering the case $n-i<k \leq i$. This implies that $p \geq 1$ in the second summand. Noticing that $1 \leq p<k$, the inductive hypothesis implies that the second summand vanishes. Thus, we obtain

$$
\left(y_{i}-y_{i+1}\right) e_{k}\left(y_{1}, \ldots, y_{i}\right)=0
$$

For non-negative integers $a$ and $b$, we use the notation

$$
[a, b]:=\{c \in \mathbb{Z} \mid a \leq c \leq b\}
$$

in what follows. For example, we have $[2,5]=\{2,3,4,5\},[3,2]=\emptyset$, and $[0,1]=\{0,1\}$ so that

$$
\pi_{[2,5]}=e_{4}\left(y_{1}, y_{2}, \ldots, y_{5}\right), \quad \pi_{[3,2]}=1, \quad \text { and } \quad \pi_{[0,1]}=0
$$

by (4.23), (4.24), and (4.25), respectively. Noticing that we have

$$
e_{k}\left(y_{1}, \ldots, y_{b}\right)=e_{k}\left(y_{1}, \ldots, y_{b-1}\right)+e_{k-1}\left(y_{1}, \ldots, y_{b-1}\right) y_{b} \quad(1 \leq k \leq b \leq n-1)
$$

it follows that

$$
\begin{equation*}
\pi_{[a, b]}=\pi_{[a-1, b-1]}+\pi_{[a, b-1]} y_{b} \quad(1 \leq a \leq b \leq n-1) \tag{4.27}
\end{equation*}
$$

since we have $\pi_{[a, b]}=e_{b-a+1}\left(y_{1}, y_{2}, \ldots, y_{b}\right)$. When $a=b$, we obtain

$$
\pi_{[a, a]}=\pi_{[a-1, a-1]}+y_{a} \quad(1 \leq a \leq n-1)
$$

since $\pi_{[a, a-1]}=\pi_{\emptyset}=1$. The next claim generalizes Lemma 4.16.

Lemma 4.17. For $1 \leq a \leq b \leq n-1$, we have

$$
\begin{equation*}
\left(y_{i}-y_{i+1}\right) \cdot \pi_{[a, b]}=0 \quad(a \leq i \leq b) \tag{4.28}
\end{equation*}
$$

in $M$.
Proof. When $i=b$, the claim follows by Lemma 4.16 since we have

$$
\left(y_{i}-y_{i+1}\right) \pi_{[a, i]}=\left(y_{i}-y_{i+1}\right) e_{i-a+1}\left(y_{1}, \ldots, y_{i}\right)=0
$$

in this case. We prove the claim by induction on $b-i \geq 0$. Let $\ell(<n-1)$ be a non-negative integer, and assume by induction that (4.28) holds for $b-i=\ell$. We prove that (4.28) holds for $b-i=\ell+1(\geq 1)$. By (4.27), we have

$$
\begin{equation*}
\left(y_{i}-y_{i+1}\right) \cdot \pi_{[a, b]}=\left(y_{i}-y_{i+1}\right) \pi_{[a-1, b-1]}+\left(y_{i}-y_{i+1}\right) \pi_{[a, b-1]} y_{b} . \tag{4.29}
\end{equation*}
$$

We compute the right hand side by taking cases. If $a=1$, then the first summand is equal to zero by (4.25), and the second summand is also equal to zero by the inductive hypothesis since $b-1 \geq i$. If $a>1$, both summands are equal to zero by the inductive hypothesis. Thus, in either case, the right hand side of (4.29) is equal to zero so that we obtain $\left(y_{i}-y_{i+1}\right) \cdot \pi_{[a, b]}=0$.

In particular, for $1 \leq a \leq b \leq n-1$, we obtain

$$
\begin{equation*}
y_{i} \pi_{[a, b]}=y_{b+1} \pi_{[a, b]} \quad(a \leq i \leq b) \tag{4.30}
\end{equation*}
$$

in $M$ by applying (4.28) repeatedly.
To state the next claim, let us recall a basic property of $\varpi_{J}$ in the cohomology $H^{*}\left(\operatorname{Pet}_{n} ; \mathbb{Z}\right)$ : it is clear from the definition (4.5) that, for $1 \leq a \leq i<b \leq n-1$, we have

$$
\varpi_{[a, i]} \cdot \varpi_{[i+1, b]}=\frac{1}{(i-a+1)!} \cdot \frac{1}{(b-i)!} \cdot \varpi_{a} \varpi_{a+1} \cdots \varpi_{b}=\binom{b-a+1}{i-a+1} \varpi_{[a, b]}
$$

in $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$, where $\binom{b-a+1}{i-a+1}$ is a binomial coefficient. As the following claim shows, the analogous equalities hold in $M$ as well.

Proposition 4.18. For $1 \leq a \leq i<b \leq n-1$, we have

$$
\begin{equation*}
\pi_{[a, i]} \cdot \pi_{[i+1, b]}=\binom{b-a+1}{i-a+1} \pi_{[a, b]} \tag{4.31}
\end{equation*}
$$

in $M$.

Proof. We prove the claim by induction on $b \geq 2$. When $b=2$, we have $a=i=1$ so that the claim is

$$
\pi_{[1,1]} \cdot \pi_{[2,2]}=2 \pi_{[1,2]} .
$$

The left hand side can be computed as

$$
\pi_{[1,1]} \cdot \pi_{[2,2]}=\pi_{[1,1]} \cdot \pi_{\{2\}}=\pi_{[1,1]} \cdot\left(y_{1}+y_{2}\right)=\pi_{[1,1]} \cdot 2 y_{2}=2 \pi_{[1,2]},
$$

where the third equality follows from (4.30), and the fourth equality follows from (4.27) with $\pi_{[0,1]}=0$. Thus, we obtain the claim for $b=2$.

Let $2 \leq \ell<n-1$ be a positive integer, and assume by induction that the claim (4.31) holds for $b=\ell$. We prove the claim (4.31) for $b=\ell+1$. The left hand side of (4.31) can be written as

$$
\pi_{[a, i]} \cdot \pi_{[i+1, b]}=\pi_{[a, i]} \pi_{[i, b-1]}+\pi_{[a, i]} \pi_{[i+1, b-1]} y_{b}
$$

by (4.27). Applying (4.27) again to $\pi_{[a, i]}$ in the first summand of the right hand side, we obtain

$$
\begin{equation*}
\pi_{[a, i]} \cdot \pi_{[i+1, b]}=\pi_{[a-1, i-1]} \pi_{[i, b-1]}+\pi_{[a, i-1]} \pi_{[i, b-1]} y_{i}+\pi_{[a, i]} \pi_{[i+1, b-1]} y_{b} . \tag{4.32}
\end{equation*}
$$

We now compute each summands of the right hand side separately. For the first summand, we have

$$
\pi_{[a-1, i-1]} \pi_{[i, b-1]}=\binom{b-a+1}{i-a+1} \pi_{[a-1, b-1]}
$$

which we prove by taking cases as follows. If $a=1$, the claim is obvious since both sides are equal to 0 by (4.25). If $a>1$, then the claim follows by the inductive hypothesis. For the second summand of the right hand side of (4.32), we have

$$
\pi_{[a, i-1]} \pi_{[i, b-1]} y_{i}=\binom{b-a}{i-a} \pi_{[a, b-1]} y_{i}
$$

which we prove by taking cases as follows. If $a=i$, the claim is obvious since both sides are equal to $\pi_{[i, b-1]} y_{i}$ by (4.24). If $a<i$, then the claim follows by the inductive hypothesis. For the third summand of the right hand side of (4.32), we have

$$
\pi_{[a, i]} \pi_{[i+1, b-1]} y_{b}=\binom{b-a}{i-a+1} \pi_{[a, b-1]} y_{b}
$$

which we prove by taking cases as follows. If $b=i+1$, the claim is obvious since both sides are equal to $\pi_{[a, i]} y_{b}$ by (4.24). If $b>i+1$, then the claim follows by the inductive hypothesis.

Combining the above computations of the summands of the right hand side of (4.32), we obtain

$$
\pi_{[a, i]} \cdot \pi_{[i+1, b]}=\binom{b-a+1}{i-a+1} \pi_{[a-1, b-1]}+\binom{b-a}{i-a} \pi_{[a, b-1]} y_{i}+\binom{b-a}{i-a+1} \pi_{[a, b-1]} y_{b}
$$

By applying (4.30) to the second summand of the right hand side, it follows that

$$
\begin{aligned}
\pi_{[a, i]} \cdot \pi_{[i+1, b]} & =\binom{b-a+1}{i-a+1} \pi_{[a-1, b-1]}+\binom{b-a}{i-a} \pi_{[a, b-1]} y_{b}+\binom{b-a}{i-a+1} \pi_{[a, b-1]} y_{b} \\
& =\binom{b-a+1}{i-a+1} \pi_{[a-1, b-1]}+\binom{b-a+1}{i-a+1} \pi_{[a, b-1]} y_{b} \\
& =\binom{b-a+1}{i-a+1} \pi_{[a, b]},
\end{aligned}
$$

where we used (4.27) for the last equality. This completes the proof.

For simplicity, we write

$$
\begin{equation*}
\pi_{i}:=\pi_{\{i\}}=y_{1}+y_{2}+\cdots+y_{i} \quad(1 \leq i \leq n-1) \tag{4.33}
\end{equation*}
$$

(cf. (4.4)). As for the previous proposition, the following is an analogue of [5, Lemma 5.1] which is a claim for $\varpi_{J}$ in the cohomology $H^{*}\left(\right.$ Pet $\left._{n} ; \mathbb{Z}\right)$.

Proposition 4.19. For $1 \leq a \leq i \leq b \leq n-1$, we have

$$
\begin{equation*}
\pi_{i} \cdot \pi_{[a, b]}=(b-i+1) \pi_{[a-1, b]}+(i-a+1) \pi_{[a, b+1]} \tag{4.34}
\end{equation*}
$$

in $M$ with the convention $\pi_{[0, b]}=\pi_{[a, n]}=0($ See (4.25) $)$.
Before giving a proof, we recall that the identity (4.12) was obtained simply by rearranging terms, without using any non-trivial relations between the cohomology classes $x_{1}, x_{2}, \ldots, x_{n}$. Thus, it follows that the same identity holds for $y_{1}, y_{2}, \ldots, y_{n}$ in $M$ as well:

$$
\begin{align*}
\left(y_{1}+\right. & \left.y_{2}+\cdots+y_{b}\right) \cdot e_{k}\left(y_{1}, y_{2}, \ldots, y_{b}\right) \\
& =m_{2,1^{k-1}}\left(y_{1}, y_{2}, \ldots, y_{b}\right)+(k+1) m_{1^{k+1}}\left(y_{1}, y_{2}, \ldots, y_{b}\right)  \tag{4.35}\\
& =m_{2,1^{k-1}}\left(y_{1}, y_{2}, \ldots, y_{b}\right)+(k+1) e_{k+1}\left(y_{1}, y_{2}, \ldots, y_{b}\right)
\end{align*}
$$

for $1 \leq k \leq b \leq n$. We also recall that the claim of Lemma 4.5 was derived only by the relations $\alpha_{i} \varpi_{i}=0(1 \leq i \leq n-1)^{2}$. By the definitions of $M$ and $I^{\prime}$, we have the corresponding relations $\left(y_{i}-y_{i+1}\right) \pi_{i}=0(1 \leq i \leq n-1)$ in $M$. Thus, the claim of Lemma 4.5 holds for $y_{1}, \ldots, y_{n}$ as well. Its claim for $d=1$ gives us that

$$
m_{2,1^{k-1}}\left(y_{1}, \ldots, y_{b}\right)=k m_{1^{k}}\left(y_{1}, \ldots, y_{b}\right) y_{b+1}=k e_{k}\left(y_{1}, \ldots, y_{b}\right) y_{b+1} .
$$

Applying this to the last expression in (4.35), we obtain that

$$
\begin{aligned}
& \left(y_{1}+y_{2}+\cdots+y_{b}\right) \cdot e_{k}\left(y_{1}, y_{2}, \ldots, y_{b}\right) \\
& \quad=k e_{k}\left(y_{1}, \ldots, y_{b}\right) y_{b+1}+(k+1) e_{k+1}\left(y_{1}, y_{2}, \ldots, y_{b}\right)
\end{aligned}
$$

for $1 \leq k \leq b \leq n$. This can be expressed as

$$
\begin{equation*}
\pi_{b} \cdot \pi_{[a, b]}=(b-a+1) \pi_{[a, b]} y_{b+1}+(b-a+2) \pi_{[a-1, b]} \quad(1 \leq a \leq b \leq n) . \tag{4.36}
\end{equation*}
$$

[^1]Proof of Proposition 4.19. We first prove the equality for the case $i=b$. In this case, the claim is

$$
\begin{equation*}
\pi_{b} \cdot \pi_{[a, b]}=\pi_{[a-1, b]}+(b-a+1) \pi_{[a, b+1]} . \tag{4.37}
\end{equation*}
$$

The left hand side is equal to

$$
\pi_{b} \cdot \pi_{[a, b]}=(b-a+1) \pi_{[a, b]} y_{b+1}+(b-a+2) \pi_{[a-1, b]}
$$

by (4.36). Thus, we obtain

$$
\begin{align*}
\pi_{b} \cdot \pi_{[a, b]} & =(b-a+1) \pi_{[a, b]} y_{b+1}+(b-a+2) \pi_{[a-1, b]} \\
& =\pi_{[a-1, b]}+(b-a+1)\left(\pi_{[a-1, b]}+\pi_{[a, b]} y_{b+1}\right) . \tag{4.38}
\end{align*}
$$

In the parenthesis of the last expression, we have

$$
\begin{equation*}
\pi_{[a-1, b]}+\pi_{[a, b]} y_{b+1}=\pi_{[a, b+1]} \tag{4.39}
\end{equation*}
$$

which we prove by taking cases. If $b<n-1$, it is obvious by (4.27). If $b=n-1$, it can be shown as

$$
\begin{aligned}
\pi_{[a-1, b]}+\pi_{[a, b]} y_{b+1} & =\pi_{[a-1, n-1]}+\pi_{[a, n-1]} y_{n} \\
& =e_{n-a+1}\left(y_{1}, y_{2}, \ldots, y_{n-1}\right)+e_{n-a}\left(y_{1}, y_{2}, \ldots, y_{n-1}\right) y_{n} \\
& =e_{n-a+1}\left(y_{1}, y_{2}, \ldots, y_{n}\right) \\
& =0 \quad(\text { by the definitions of } M \text { and } I) \\
& =\pi_{[a, b+1]} \quad(\text { by } b+1=n \text { and }(4.25))
\end{aligned}
$$

in this case as well. Thus, we obtain from (4.38) and (4.39) that

$$
\pi_{b} \cdot \pi_{[a, b]}=\pi_{[a-1, b]}+(b-a+1) \pi_{[a, b+1]} .
$$

This verifies (4.37) which is the desired claim (4.34) for the case $i=b$.
Now we prove the claim (4.34) by induction on $b-i \geq 0$. Let $\ell(<n-1)$ be a non-negative integer, and assume by induction that (4.34) holds when $b-i=\ell$. We prove (4.34) for the case $b-i=\ell+1(\geq 1)$. In this case, the left hand side of (4.34) can be computed as

$$
\begin{equation*}
\pi_{i} \cdot \pi_{[a, b]}=\pi_{i} \pi_{[a-1, b-1]}+\pi_{i} \pi_{[a, b-1]} y_{b} \tag{4.40}
\end{equation*}
$$

by (4.27). We compute each summands of the right hand side separately. For the first summand, we have

$$
\pi_{i} \pi_{[a-1, b-1]}=(b-i) \pi_{[a-2, b-1]}+(i-a+2) \pi_{[a-1, b]}
$$

which we prove by taking cases as follows. If $a=1$, then both sides are equal to 0 by (4.25). If $a>1$, then the claim follows by the inductive hypothesis since $b-1 \geq i$. For the second summand in the right hand side of (4.40), we have

$$
\pi_{i} \pi_{[a, b-1]} y_{b}=\left((b-i) \pi_{[a-1, b-1]}+(i-a+1) \pi_{[a, b]}\right) y_{b}
$$

by the inductive hypothesis since $b-1 \geq i$. Combining the computations of the summands of the right hand side of (4.40), we obtain

$$
\begin{align*}
& \pi_{i} \cdot \pi_{[a, b]}=\left((b-i) \pi_{[a-2, b-1]}+(i-a+2) \pi_{[a-1, b]}\right) \\
& \quad+\left((b-i) \pi_{[a-1, b-1]}+(i-a+1) \pi_{[a, b]}\right) y_{b} \\
&=(b-i)\left(\pi_{[a-2, b-1]}+\pi_{[a-1, b-1]} y_{b}\right)  \tag{4.41}\\
& \quad+\pi_{[a-1, b]}+(i-a+1)\left(\pi_{[a-1, b]}+\pi_{[a, b]} y_{b}\right) \\
&=(b-i)\left(\pi_{[a-2, b-1]}+\pi_{[a-1, b-1]} y_{b}\right) \\
& \quad+\pi_{[a-1, b]}+(i-a+1)\left(\pi_{[a-1, b]}+\pi_{[a, b]} y_{b+1}\right)
\end{align*}
$$

where we used (4.30) to $\pi_{[a, b]} y_{b}$ for the last equality. We now compute the first and the third summands of the last expression separately. For the first summand, we have

$$
\begin{equation*}
(b-i)\left(\pi_{[a-2, b-1]}+\pi_{[a-1, b-1]} y_{b}\right)=(b-i) \pi_{[a-1, b]} \tag{4.42}
\end{equation*}
$$

which we prove by taking cases as follows. If $a>1$, then the claim is obvious by (4.27). If $a=1$, the claim follows since both sides are equal to 0 by (4.25). For the third summand of the last expression of (4.41), we have

$$
\begin{equation*}
(i-a+1)\left(\pi_{[a-1, b]}+\pi_{[a, b]} y_{b+1}\right)=(i-a+1) \pi_{[a, b+1]} \tag{4.43}
\end{equation*}
$$

by (4.39). Applying (4.42) and (4.43) to the last expression of (4.41), we obtain

$$
\pi_{i} \cdot \pi_{[a, b]}=(b-i+1) \pi_{[a-1, b]}+(i-a+1) \pi_{[a, b+1]} .
$$

This verifies (4.34) for the case $b-i=\ell+1$, as desired.
We now prove Proposition 4.15 which completes the proof of Theorem 4.11 as we discussed in section 4.3,

Proof of Proposition 4.15, Let $f \in M$ be a polynomial in $y_{1}, y_{2}, \ldots, y_{n}$. We prove that $f$ can be written as a linear combination of $\pi_{J}$ for $J \subseteq[n-1]$. Recalling that $\pi_{i}=y_{1}+y_{2}+\cdots+y_{i}$, we have

$$
\begin{aligned}
& y_{i}=\pi_{i}-\pi_{i-1} \quad(1 \leq i \leq n-1), \\
& y_{n}=-\pi_{n-1}
\end{aligned}
$$

with the convention $\pi_{0}=0$, where the second equality follows since we have an equality $y_{1}+y_{2}+\cdots+y_{n}=e_{1}\left(y_{1}, y_{2}, \ldots, y_{n}\right)=0$ in $M$. Hence, we can express $f$ as a polynomial in

$$
\pi_{1}, \pi_{2}, \ldots, \pi_{n-1}
$$

For our purpose, we may assume that $f$ is a monomial in these variables with coefficient 1 without loss of generality. Namely, we have

$$
\begin{equation*}
f=\pi_{i_{1}} \pi_{i_{2}} \cdots \pi_{i_{d}} \tag{4.44}
\end{equation*}
$$

for some $d \geq 1$ and $1 \leq i_{1} \leq i_{2} \leq \cdots \leq i_{d}<n$. We prove that this monomial can be expressed as a linear combination of $\pi_{J}$ for $J \subseteq[n-1]$.

First suppose that $d \leq n-1$. We prove the claim by induction on $d \geq 1$. When $d=1$, the claim is obvious since $\pi_{i_{1}}=\pi_{J}$ with $J=\left\{i_{1}\right\}$ by (4.33). Assume by induction that

$$
\pi_{i_{2}} \cdots \pi_{i_{d}}=\sum_{J \subseteq[n-1]} c_{J} \pi_{J}
$$

for some integers $c_{J}(J \subseteq[n-1])$. Then we have

$$
\begin{equation*}
f=\pi_{i_{1}} \sum_{J \subseteq[n-1]} c_{J} \pi_{J}=\sum_{J \subseteq[n-1]} c_{J} \pi_{i_{1}} \pi_{J} . \tag{4.45}
\end{equation*}
$$

It suffices to show that each product $\pi_{i_{1}} \pi_{J}$ is expanded as a linear combination of $\pi_{L}$ for $L \subseteq[n-1]$. For this, we take the decomposition $J=J_{1} \sqcup \cdots \sqcup J_{m}$ into the connected components. By (4.23), we have

$$
\pi_{i_{1}} \pi_{J}=\pi_{i_{1}} \cdot \pi_{J_{1}} \cdots \pi_{J_{m}}
$$

since each $J_{k}$ consists of a single connected component $(1 \leq k \leq m)$. Set $J^{\prime}:=J \cup\left\{i_{1}\right\}$. We consider the case for $J^{\prime} \supsetneq J$ and the case for $J^{\prime}=J$ separately.

If $J^{\prime} \supsetneq J$, then we have $i_{1} \notin J$. We denote by $J^{\prime}\left(i_{1}\right) \subseteq J^{\prime}$ the connected component of $J^{\prime}$ containing $i_{1}$. We have the following three cases:
(1) $J^{\prime}\left(i_{1}\right)=\left\{i_{1}\right\}$,
(2) $J^{\prime}\left(i_{1}\right)=J_{k} \cup\left\{i_{1}\right\}$ for some $1 \leq k \leq m$,
(3) $J^{\prime}\left(i_{1}\right)=J_{k} \cup\left\{i_{1}\right\} \cup J_{k+1}$ for some $1 \leq k<m$.

In the case (1), we have

$$
\pi_{i_{1}} \pi_{J}=\pi_{i_{1}} \cdot \pi_{J_{1}} \cdots \pi_{J_{m}}=\pi_{J^{\prime}}
$$

by the definition of $\pi_{J^{\prime}}$ (see (4.23)). In the case (2), we have $i_{1}=\min J_{k}-1$ or $i_{1}=\max J_{k}+1$. In either case, we have

$$
\begin{aligned}
\pi_{i_{1}} \pi_{J} & =\pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\pi_{i_{1}} \pi_{J_{k}}\right) \pi_{J_{k+1}} \cdots \pi_{J_{m}} \\
& =\pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\binom{\left|J_{k}\right|+1}{1} \pi_{J^{\prime}\left(i_{1}\right)}\right) \pi_{J_{k+1}} \cdots \pi_{J_{m}}
\end{aligned}
$$

by Proposition 4.18 and $\binom{\left|J_{k}\right|+1}{1}=\binom{\left|J_{k}\right|+1}{\left|J_{k}\right|}$. Hence, we obtain

$$
\pi_{i_{1}} \pi_{J}=\binom{\left|J_{k}\right|+1}{1} \pi_{J^{\prime}}
$$

in this case. In the case (3), we have

$$
\begin{aligned}
\pi_{i_{1}} \pi_{J} & =\pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\pi_{J_{k}} \cdot \pi_{i_{1}} \cdot \pi_{J_{k+1}}\right) \pi_{J_{k+2}} \cdots \pi_{J_{m}} \\
& =\pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\binom{\left|J_{k}\right|+1}{\left|J_{k}\right|} \pi_{J_{k} \cup\left\{i_{1}\right\}} \cdot \pi_{J_{k+1}}\right) \pi_{J_{k+2}} \cdots \pi_{J_{m}} \\
& =\pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\binom{\left|J_{k}\right|+1}{\left|J_{k}\right|}\binom{\left|J_{k}\right|+1+\left|J_{k+1}\right|}{\left|J_{k}\right|+1} \pi_{J_{k} \cup\left\{i_{1}\right\} \cup J_{k+1}}\right) \pi_{J_{k+2}} \cdots \pi_{J_{m}} \\
& =\binom{\left|J_{k}\right|+1}{\left|J_{k}\right|}\binom{\left|J_{k}\right|+1+\left|J_{k+1}\right|}{\left|J_{k}\right|+1} \pi_{J^{\prime}}
\end{aligned}
$$

by Proposition 4.18 again. Thus, in either case of (1)-(3), we see that the product $\pi_{i_{1}} \pi_{J}$ is an integer multiple of $\pi_{J^{\prime}}$.

If $J^{\prime}=J$, then we have $i_{1} \in J_{k}$ for some $1 \leq k \leq m$. In this case, let us write $J_{k}=[a, b]$ for some $1 \leq a \leq b \leq n-1$. Then, Proposition 4.19 implies that

$$
\begin{align*}
\pi_{i_{1}} \pi_{J}= & \pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\pi_{i_{1}} \pi_{J_{k}}\right) \pi_{J_{k+1}} \cdots \pi_{J_{m}} \\
= & \pi_{J_{1}} \cdots \pi_{J_{k-1}}\left(\left(b-i_{1}+1\right) \pi_{[a-1, b]}+\left(i_{1}-a+1\right) \pi_{[a, b+1]}\right) \pi_{J_{k+1}} \cdots \pi_{J_{m}}  \tag{4.46}\\
= & \left(b-i_{1}+1\right) \pi_{J_{1}} \cdots \pi_{J_{k-1}} \pi_{[a-1, b]} \pi_{J_{k+1}} \cdots \pi_{J_{m}} \\
& \quad+\left(i_{1}-a+1\right) \pi_{J_{1}} \cdots \pi_{J_{k-1}} \pi_{[a, b+1]} \pi_{J_{k+1}} \cdots \pi_{J_{m}} .
\end{align*}
$$

For the first summand in the last expression, we have

$$
\begin{align*}
& \pi_{J_{1}} \cdots \pi_{J_{k-1}} \pi_{[a-1, b]} \pi_{J_{k+1}} \cdots \pi_{J_{m}} \\
&= \begin{cases}\pi_{J \cup\{a-1\}} & \left(\text { if } \max J_{k-1}<a-2\right), \\
\binom{\left|J_{k-1}\right|+b-a+2}{\left|J_{k-1}\right|} \pi_{J \cup\{a-1\}} & \left(\text { if } \max J_{k-1}=a-2\right),\end{cases} \tag{4.47}
\end{align*}
$$

where the first case follows from the definition of $\pi_{J \cup\{a-1\}}$, and the second case follows by applying Proposition 4.18 to $\pi_{J_{k-1}} \pi_{[a-1, b]}$ in the left hand side. Here, we take the convention $J_{0}=\{-\infty\}$ since only the first case of (4.47) holds when $k=1$. Similarly, for the second summand in the last expression of (4.46), we have

$$
\begin{align*}
& \pi_{J_{1}} \cdots \pi_{J_{k-1}} \pi_{[a, b+1]} \pi_{J_{k+1}} \cdots \pi_{J_{m}} \\
&= \begin{cases}\pi_{J \cup\{b+1\}} & \left(\text { if } \min J_{k+1}>b+2\right), \\
\binom{\left|J_{k+1}\right|+b-a+2}{b-a+2} \pi_{J \cup\{b+1\}} & \left(\text { if } \min J_{k+1}=b+2\right) .\end{cases} \tag{4.48}
\end{align*}
$$

Again, we take the convention $J_{m+1}=\{+\infty\}$ since only the first case of (4.48) holds when $k=m$. Thus, it follows from (4.46) that $\pi_{i_{1}} \pi_{J}$ is a linear combination of $\pi_{J \cup\{a-1\}}$ and $\pi_{J \cup\{b+1\}}$. Applying this result to the right hand side of (4.45), we see that $f$ is a linear combination of $\pi_{J}$ for $J \subseteq[n-1]$.

Finally, we consider the case $d>n-1$. In this case, the number of $\pi_{i_{k}}$ appearing in (4.44) is greater than $n-1$. Hence, we can write

$$
f=\pi_{i_{1}} \pi_{i_{2}} \cdots \pi_{i_{d}}=\left(\pi_{i_{1}} \pi_{i_{2}} \cdots \pi_{i_{n-1}}\right) \cdot\left(\pi_{i_{n}} \pi_{i_{n+1}} \cdots \pi_{i_{d}}\right) .
$$

Applying the argument used in the previous case to the product $\pi_{i_{1}} \pi_{i_{2}} \cdots \pi_{i_{n-1}}$, we see that it is an integer multiple of $\pi_{[n-1]}$. Since we have

$$
\pi_{[n-1]} \cdot \pi_{i_{n}}=0
$$

by Proposition 4.19, we see that $f=0$ in this case. This completes the proof.
