# On integer values of sum and product of three positive rational numbers

#### Abstract

In 1997 we proved that if $n$ is of the form $$
4 k, \quad 8 k-1 \quad \text { or } \quad 2^{2 m+1}(2 k-1)+3,
$$


where $k, m \in \mathbb{N}$, then there are no positive rational numbers $x, y, z$ satisfying

$$
x y z=1, \quad x+y+z=n .
$$

Recently, N. X. Tho proved the following statement: let $a \in \mathbb{N}$ be odd and let either $n \equiv 0(\bmod 4)$ or $n \equiv 7(\bmod 8)$. Then the system of equations

$$
x y z=a, \quad x+y+z=a n .
$$

has no solutions in positive rational numbers $x, y, z$.
A representative example of our result is the following statement: assume that $a, n \in \mathbb{N}$ are such that at least one of the following conditions hold:

- $n \equiv 0(\bmod 4)$
- $n \equiv 7(\bmod 8)$
- $a \equiv 0(\bmod 4)$
- $a \equiv 0(\bmod 2)$ and $n \equiv 3(\bmod 4)$
- $a^{2} n^{3}=2^{2 m+1}(2 k-1)+27$ for some $k, m \in \mathbb{N}$.

Then the system of equations

$$
x y z=a, \quad x+y+z=a n .
$$

has no solutions in positive rational numbers $x, y, z$.

## 1 Introduction

Let $n \notin\{0,3\}$ be an integer. The Diophantine equation

$$
\begin{equation*}
X^{3}+Y^{3}+Z^{3}=n X Y Z \tag{1}
\end{equation*}
$$

has been a subject of much investigation, starting from the works of Sylvester dating back to 1856. Sylvester proved that if $n=-6$, then (1) has no solutions in nonzero integers $X, Y, Z$, see [2]. The cases $n \in\{-1,5\}$ were treated by Mordell [7]. In 1960 Cassels [1] proved that for $n=1$ the equation (1) has no nonzero integer solutions.

Further contribution was made by Dofs [3]. One of his results claims that if $n^{2}+3 n+9$ is a prime number and if all prime divisors of $n-3$ are of the form $2(\bmod 3)$, then (1) has no solutions in nonzero integers $X, Y, Z$.

Considering the equation

$$
\begin{equation*}
\frac{x}{y}+\frac{y}{z}+\frac{z}{x}=n \tag{2}
\end{equation*}
$$

for $n=4$, Sierpinski [8, p.80] noted that it was not known to him whether this equation has a solutions in positive integers $x, y, z$. From the mentioned result of Dofs it follows that for $n=4$ the equation (2) has no solutions even in nonzero integers $x, y, z$.

In [4] we proved that if

$$
n \in\left\{4 k, 8 k-1,2^{2 m+1}(2 k-1)+3\right\},
$$

where $k$ and $m$ run through all positive integers, then (1) has no solutions in positive integers $X, Y, Z$. As a consequence of the Sylvester transformation, we showed that for the indicated set of values of $n$ there do not exist positive rational numbers $x, y, z$ satisfying

$$
x y z=1, \quad x+y+z=n .
$$

In particular, the equation (2) has no positive integer solutions not only for $n=4$ but also for any $n \equiv 0(\bmod 4)$ and for many odd values of $n$ as well. In [6] we also proved that the equation

$$
\left(\frac{x}{y}\right)^{u}+\left(\frac{y}{z}\right)^{v}+\left(\frac{z}{x}\right)^{w}=4 t
$$

has no solutions in positive integers $x, y, z, t, u, v, w$.

Recently, Tho [9] proved the following statement: let $a \in \mathbb{N}$ be odd and let either $n \equiv 0(\bmod 4)$ or $n \equiv 7(\bmod 8)$. Then the system of equations

$$
\begin{equation*}
x y z=a, \quad x+y+z=a n . \tag{3}
\end{equation*}
$$

has no solutions in positive rational numbers $x, y, z$.
In the present paper we shall prove the following result.
Theorem 1. Let $a, b$ and $c$ be positive integers such that at least one of the following conditions hold:

- $c \equiv 0(\bmod 4)$
- $b c \equiv 7(\bmod 8)$
- $a \equiv 0(\bmod 4)$ and $b \equiv 1(\bmod 2)$
- $a \equiv 0(\bmod 2)$ and $b c \equiv 3(\bmod 4)$
- $a \equiv 1(\bmod 2), b \equiv 2(\bmod 4)$ and $c \equiv 0(\bmod 2)$
- $a^{2} b c^{3}=2^{2 m+1}(2 k-1)+27$ for some $k, m \in \mathbb{N}$.

Then there do not exist positive rational numbers $x, y, z$ satisfying

$$
\begin{equation*}
x y z=a b^{2}, \quad x+y+z=a b c . \tag{4}
\end{equation*}
$$

Taking $b=1$ and $n=c$, we obtain the following consequence.
Corollary 1. Let $a$ and $n$ be positive integers such that at least one of the following conditions hold:

- $n \equiv 0(\bmod 4)$
- $n \equiv 7(\bmod 8)$
- $a \equiv 0(\bmod 4)$
- $a \equiv 0(\bmod 2)$ and $n \equiv 3(\bmod 4)$
- $a^{2} n^{3}=2^{2 m+1}(2 k-1)+27$ for some $k, m \in \mathbb{N}$.

Then (3) has no solutions in positive rational numbers $x, y, z$.

## 2 Main Lemma

The following statement is the key of the proof of Theorem 1 .
Lemma 1. Let

$$
n \in\left\{16 k-4,64 k, 32 k-16,8 k-1,2^{2 m+1}(2 k-1)+27\right\}
$$

where $k$ and $m$ run through all positive integers. Then the equation

$$
\begin{equation*}
x^{3}+y^{3}+n^{2} z^{3}=n x y z \tag{5}
\end{equation*}
$$

has no solutions in positive integers $x, y, z$.
Lemma 1 is implicitly contained in our note [5], without proof. Here, we shall give a complete proof of this statement.

We shall often use the following simple observation.
Claim 1. Let $x, y, z, A, B$ be positive integers such that

$$
x^{3}+y^{3}+A z^{3}=B x y z
$$

Assume that $A$ is cubefree, $(x, y, z)=1$, and that any prime divisor of $A$ is also a prime divisor of $B$. Then

$$
(x, y)=(y, z)=(z, x)=(x, A)=(y, A)=1 .
$$

Indeed, if a prime number $p$ divides $(x, y)$, then $p$ also divides $A$, implying that $p$ divides $B$, and therefore $p^{3}$ divides $x^{3}, y^{3}, B x y z$. Hence $p^{3}$ divides $A z^{3}$, which is impossible as $A$ is cubefree and $(x, y, z)=1$. Therefore $(x, y)=1$, from which it also follows the remaining conclusion.

We proceed to prove Lemma 11. Assume that (5) holds for some positive integers $x, y, z$. We shall consider five cases.

### 2.1 The case $n=16 k-4$

We represent $n$ in the form,

$$
n=4 P_{1} P_{2}^{2} P_{3}^{3}
$$

where $P_{1}$ and $P_{2}$ are relatively prime squarefree positive integers. We also have that

$$
P_{1} P_{2}^{2} P_{3}^{3} \equiv 3 \quad(\bmod 4)
$$

which means that $P_{1}, P_{2}, P_{3}$ are odd and

$$
P_{1} P_{3} \equiv 3 \quad(\bmod 4) .
$$

We have that

$$
x^{3}+y^{3}+16 P_{1}^{2} P_{2}^{4} P_{3}^{6} z^{3}=4 P_{1} P_{2}^{2} P_{3}^{3} x y z
$$

Therefore,

$$
x^{3}+y^{3}+2 P_{1}^{2} P_{2} z_{0}^{3}=2 P_{1} P_{2} P_{3} x y z_{0}
$$

where $z_{0}=2 P_{2} P_{3}^{2} z$. Letting $d=\left(x, y, z_{0}\right)$ and denoting $x / d, y / d, z_{0} / d$ again by $x, y, z$, we get that the equality

$$
x^{3}+y^{3}+2 P_{1}^{2} P_{2} z^{3}=2 P_{1} P_{2} P_{3} x y z
$$

holds for some positive integers $x, y, z$ with $(x, y, z)=1$. Note that $P_{1}^{2} P_{2}$ is an odd cubefree integer. Thus, from Claim 1 it follows that $x$ and $y$ are odd integers satisfying

$$
(x, y)=(y, z)=(z, x)=\left(x, 2 P_{1} P_{2}\right)=\left(y, 2 P_{1} P_{2}\right)=1
$$

From

$$
x^{3}+y^{3}=2 P_{1} P_{2} z\left(P_{3} x y-P_{1} z^{2}\right),
$$

it also follows that

$$
\begin{equation*}
x+y \equiv 0 \quad(\bmod 4) \tag{6}
\end{equation*}
$$

There are two possibilities, depending on whether $z$ is an even or an odd number.

Let $z$ be an even number. Then $z=2^{r} z_{1}$, where $r \in \mathbb{N}$ and $z_{1}$ is odd. Then,

$$
x^{3} \equiv-2^{3 r+1} P_{1}^{2} P_{2} z_{1}^{3} \quad\left(\bmod 2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}\right)
$$

whence

$$
X^{2} \equiv-2^{3 r+1} P_{1}^{2} P_{2} x z_{1}^{3} \quad\left(\bmod 2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}\right), \quad X=x^{2} .
$$

Observe that the numbers $2^{3 r+1} P_{1}^{2} P_{2} x z_{1}^{3}$ and $2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}$ are relatively prime positive integers. Indeed, if a prime number $p$ divides both of
these numbers, then clearly $p$ divides $y$, and therefore $x$ as well, which contradicts to $(x, y)=1$. Since $2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}$ is odd, we can pass to the Jacoby symbol and get that

$$
\begin{equation*}
1=\left(\frac{-2^{3 r+1} P_{1}^{2} P_{2} x z_{1}^{3}}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right)=\left(\frac{-2^{3 r+1} P_{2} x z_{1}}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right) . \tag{7}
\end{equation*}
$$

Note that $y^{2} \equiv 1(\bmod 8)$, which implies that

$$
\left(\frac{-1}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right)=-1
$$

We also have that

$$
\left(\frac{2}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right)^{3 r+1}=1
$$

Indeed, it is trivial for $r=1$, and for $r \geq 2$ it follows from the fact that $2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2} \equiv-1(\bmod 8)$.

Thus, from (7) we get that

$$
\begin{equation*}
\left(\frac{P_{2} x z_{1}}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right)=-1 \tag{8}
\end{equation*}
$$

On the other hand, from $2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2} \equiv 3(\bmod 4)$ and the quadratic reciprocity law, we have that

$$
\begin{gathered}
\left(\frac{P_{2} x z_{1}}{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}\right)=(-1)^{\left(P_{2} x z_{1}-1\right) / 2}\left(\frac{2^{r+1} P_{1} P_{2} P_{3} x z_{1}-y^{2}}{P_{2} x z_{1}}\right) \\
=(-1)^{\left(P_{2} x z_{1}-1\right) / 2}\left(\frac{-y^{2}}{P_{2} x z_{1}}\right)=(-1)^{\left(P_{2} x z_{1}-1\right) / 2}\left(\frac{-1}{P_{2} x z_{1}}\right)=1
\end{gathered}
$$

which contradicts to (8).
Therefore, $z$ should be an odd number. Then, from (6) it follows that either $x z \equiv 3(\bmod 4)$ or $y z \equiv 3(\bmod 4)$. Without loss of generality, we can suppose that $x z \equiv 3(\bmod 4)$. We have that

$$
X^{2} \equiv-2 P_{1}^{2} P_{2} x z^{3} \quad\left(\bmod 2 P_{1} P_{2} P_{3} x z-y^{2}\right), \quad X=x^{2}
$$

Since the numbers $2 P_{1}^{2} P_{2} x z^{3}$ and $2 P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime positive integers, with $2 P_{1} P_{2} P_{3} x z-y^{2}$ being odd, we can use the Jacoby symbol:

$$
\begin{equation*}
1=\left(\frac{-2 P_{1}^{2} P_{2} x z^{3}}{2 P_{1} P_{2} P_{3} x z-y^{2}}\right)=\left(\frac{-2 P_{2} x z}{2 P_{1} P_{2} P_{3} x z-y^{2}}\right) \tag{9}
\end{equation*}
$$

We recall that $P_{1} P_{3} \equiv x z \equiv 3(\bmod 4)$. Hence,

$$
2 P_{1} P_{2} P_{3} x z-y^{2} \equiv 2 P_{2}-1 \quad(\bmod 8)
$$

This and $2 P_{2}-1 \equiv 1(\bmod 4)$ implies that,

$$
\left(\frac{-2}{2 P_{1} P_{2} P_{3} x z-y^{2}}\right)=\left(\frac{-1}{2 P_{2}-1}\right)\left(\frac{2}{2 P_{2}-1}\right)=(-1)^{\left(P_{2}^{2}-P_{2}\right) / 2}=(-1)^{\left(1-P_{2}\right) / 2}
$$

From $2 P_{1} P_{2} P_{3} x z-y^{2} \equiv 1(\bmod 4), x z \equiv 3(\bmod 4)$ and the quadratic reciprocity law, we also have that

$$
\begin{aligned}
\left(\frac{P_{2} x z}{2 P_{1} P_{2} P_{3} x z-y^{2}}\right) & =\left(\frac{2 P_{1} P_{2} P_{3} x z-y^{2}}{P_{2} x z}\right) \\
& =\left(\frac{-y^{2}}{P_{2} x z}\right)=(-1)^{\left(P_{2} x z-1\right) / 2}=(-1)^{\left(3 P_{2}-1\right) / 2}
\end{aligned}
$$

Putting the last two relations into (9), we conclude that

$$
1=(-1)^{\left(1-P_{2}\right) / 2}(-1)^{\left(3 P_{2}-1\right) / 2}=(-1)^{P_{2}}=-1 .
$$

The obtained contradiction finishes the case $n=16 k-4$ of our lemma.

### 2.2 The case $n=64 k$

We let

$$
n=64 P_{1} P_{2}^{2} P_{3}^{3},
$$

where $P_{1}, P_{2}$ are squarefree relatively prime integers. Similar to the previous case, we arrive that there exists positive integers $x, y, z$ such that $(x, y, z)=1$ and

$$
x^{3}+y^{3}+P_{1}^{2} P_{2} z^{3}=4 P_{1} P_{2} P_{3} x y z
$$

By Claim [1, we have that

$$
\begin{equation*}
(x, y)=(y, z)=(z, x)=\left(x, P_{1} P_{2}\right)=\left(y, P_{1} P_{2}\right)=1 . \tag{10}
\end{equation*}
$$

It follows that at least one of the numbers $x$ and $y$ is an odd number. Assume that $y$ is odd. Then we can write,

$$
x^{3} \equiv-P_{1}^{2} P_{2} z^{3} \quad\left(\bmod 4 P_{1} P_{2} P_{3} x z-y^{2}\right)
$$

From (10) it follows that the numbers $P_{1}^{2} P_{2} z^{3} x$ and $4 P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime. Indeed, if a prime number $p$ divides both them, then $p$ divides $y$ and hence, $p$ divides $P_{1}^{2} P_{2} z^{3} x$, which contradicts to (10).

Thus, the numbers $P_{1}^{2} P_{2} z^{3} x$ and $4 P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime positive integers, with $4 P_{1} P_{2} P_{3} x z-y^{2}$ being odd, and therefore we can use the Jacoby symbol in the congruence

$$
X^{2} \equiv-P_{1}^{2} P_{2} x z^{3} \quad\left(\bmod 4 P_{1} P_{2} P_{3} x z-y^{2}\right), \quad X=x^{2}
$$

Setting $P_{2} x z=2^{r} t$, where $t$ is odd and $r$ is a nonnegative integer, we get that

$$
\begin{aligned}
1 & =\left(\frac{-P_{1}^{2} P_{2} x z^{3}}{4 P_{1} P_{2} P_{3} x z-y^{2}}\right)=\left(\frac{-2^{r} t}{2^{r+2} P_{1} P_{3} t-y^{2}}\right) \\
& =\left(\frac{-1}{2^{r+2} P_{1} P_{3} t-y^{2}}\right)\left(\frac{2}{2^{r+2} P_{1} P_{3} t-y^{2}}\right)^{r}\left(\frac{t}{2^{r+2} P_{1} P_{3} t-y^{2}}\right) \\
& =-\left(\frac{t}{2^{r+2} P_{1} P_{3} t-y^{2}}\right)=-(-1)^{(t-1) / 2}\left(\frac{2^{r+2} P_{1} P_{3} t-y^{2}}{t}\right) \\
& =-(-1)^{(t-1) / 2}\left(\frac{-y^{2}}{t}\right)=-(-1)^{(t-1) / 2}\left(\frac{-1}{t}\right)=-1 .
\end{aligned}
$$

We have a contradiction, which finishes the case $n=64 k$.

### 2.3 The case $n=32 k-16$

We write

$$
n=16 P_{1} P_{2}^{2} P_{3}^{3},
$$

where $P_{1}, P_{2}, P_{3}$ are odd integers, $P_{1}$ and $P_{2}$ are relatively prime squarefree integers. Similar to the previous cases, we get that for some positive integers $x, y, z$ with $(x, y, z)=1$ one has

$$
x^{3}+y^{3}+4 P_{1}^{2} P_{2} z^{3}=4 P_{1} P_{2} P_{3} x y z .
$$

By Claim 1 we have that

$$
(x, y)=(y, z)=(z, x)=\left(x, 2 P_{1} P_{2}\right)=\left(y, 2 P_{1} P_{2}\right)=1
$$

From our equation it follows that,

$$
x^{4}=-4 P_{1}^{2} P_{2} x z^{3} \quad\left(\bmod 4 P_{1} P_{2} P_{3} x z-y^{2}\right) .
$$

Since the numbers $4 P_{1}^{2} P_{2} x z^{3}$ and $4 P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime positive integers, with $4 P_{1} P_{2} P_{3} x z-y^{2}$ being odd, we can use the Jacoby symbol:

$$
1=\left(\frac{-4 P_{1}^{2} P_{2} x z^{3}}{4 P_{1} P_{2} P_{3} x z-y^{2}}\right)=\left(\frac{-P_{2} x z}{4 P_{1} P_{2} P_{3} x z-y^{2}}\right) .
$$

Let $P_{2} x z=2^{r} t$, where $t$ is odd and $r$ is a nonnegative integer. Note that

$$
\left(\frac{-1}{2^{r+2} P_{1} P_{3} t-y^{2}}\right)=-1, \quad\left(\frac{2}{2^{r+2} P_{1} P_{3} t-y^{2}}\right)^{r}=1
$$

Hence,

$$
\begin{aligned}
1 & =\left(\frac{-P_{2} x z}{4 P_{1} P_{2} P_{3} x z-y^{2}}\right)=-\left(\frac{t}{2^{r+2} P_{1} P_{3} t-y^{2}}\right) \\
& =(-1)^{(t-1) / 2)}\left(\frac{2^{r+2} P_{1} P_{3} t-y^{2}}{t}\right)=-(-1)^{(t-1) / 2)}\left(\frac{-y^{2}}{t}\right) \\
& =-(-1)^{(t-1) / 2)}\left(\frac{-1}{t}\right)=-1 .
\end{aligned}
$$

The obtained contradiction finishes the case $n=32 k-16$.

### 2.4 The case $n=8 k-1$

We write $n=P_{1} P_{2}^{2} P_{3}^{3}$, where $P_{1}, P_{2}, P_{3}$ are odd positive integers, $P_{1}$ and $P_{2}$ are squarefree relatively prime integers. The condition $n \equiv-1(\bmod 8)$ implies that $P_{1} P_{3} \equiv-1(\bmod 8)$. As in the previous cases, we get that there are positive integers $x, y, z$ with $(x, y, z)=1$ such that

$$
x^{3}+y^{3}+P_{1}^{2} P_{2} z^{3}=P_{1} P_{2} P_{3} x y z .
$$

Since $(x, y, z)=1$ and $P_{1}^{2} P_{2}$ is cubrefree, from Claim 1 we get that

$$
(x, y)=(y, z)=(z, x)=\left(x, P_{1} P_{2}\right)=\left(y, P_{1} P_{2}\right)=1
$$

We distinguish two possibilities, depending on whether $z$ is even or odd. Assume that $z$ is even. Then $x y$ is odd. We also have that

$$
x^{4} \equiv-x y^{3} \quad\left(\bmod P_{1} P_{3} x y-P_{1}^{2} z^{2}\right)
$$

Since the positive integers $x y^{3}$ and $P_{1} P_{3} x y-P_{1}^{2} z^{2}$ are relatively prime, with $P_{1} P_{3} x y-P_{1}^{2} z^{2}$ being odd, we can use the Jacoby symbol. Taking into account that $P_{1} P_{3} \equiv-1(\bmod 8)$, we consequently get that

$$
\begin{aligned}
1 & =\left(\frac{-x y^{3}}{P_{1} P_{3} x y-P_{1}^{2} z^{2}}\right)=(-1)^{\left(P_{1} P_{3} x y-1\right) / 2}\left(\frac{x y}{P_{1} P_{3} x y-P_{1}^{2} z^{2}}\right) \\
& =(-1)^{(-x y-1) / 2}(-1)^{((x y-1) / 2)((-x y-1)) / 2}\left(\frac{P_{1} P_{3} x y-P_{1}^{2} z^{2}}{x y}\right) \\
& =(-1)^{(-x y-1) / 2}\left(\frac{-P_{1}^{2} z^{2}}{x y}\right)=(-1)^{(-x y-1) / 2}(-1)^{(x y-1) / 2}=-1 .
\end{aligned}
$$

Here we used that $(-1)^{((x y-1) / 2)((-x y-1)) / 2}=1$.
The obtained contradiction shows that $z$ should be an odd number. We again distinguish two cases, depending on whether $x y$ is an even or an odd number.

Assume that $x y$ is an even number. Without loss of generality, we can assume that $y$ is even. Then $x$ is odd. We have that

$$
x^{4} \equiv-P_{1}^{2} P_{2} x z^{3} \quad\left(\bmod P_{1} P_{2} P_{3} x z-y^{2}\right) .
$$

Since $P_{1}^{2} P_{2} x z^{3}$ and $P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime odd positive integers, we can use the Jacoby symbol and apply the quadratic reciprocity law. We get that

$$
\begin{equation*}
1=\left(\frac{-P_{1}^{2} P_{2} x z^{3}}{P_{1} P_{2} P_{3} x z-y^{2}}\right)=(-1)^{\left(P_{1} P_{2} P_{3} x z-1\right) / 2}\left(\frac{P_{2} x z}{P_{1} P_{2} P_{3} x z-y^{2}}\right) \tag{11}
\end{equation*}
$$

Next, we have that

$$
\begin{aligned}
\left(\frac{P_{2} x z}{P_{1} P_{2} P_{3} x z-y^{2}}\right) & =(-1)^{\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right) \cdot\left(\left(P_{2} x z-1\right) / 2\right)}\left(\frac{P_{1} P_{2} P_{3} x z-y^{2}}{P_{2} x z}\right) \\
& =(-1)^{\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right) \cdot\left(\left(P_{2} x z-1\right) / 2\right)}\left(\frac{-y^{2}}{P_{2} x z}\right) \\
& =(-1)^{\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right) \cdot\left(\left(P_{2} x z-1\right) / 2\right)}(-1)^{\left(P_{2} x z-1\right) / 2} .
\end{aligned}
$$

Inserting this into (11), we see that the number

$$
u=\frac{P_{1} P_{2} P_{3} x z-1}{2}+\frac{P_{1} P_{2} P_{3} x z-1}{2} \cdot \frac{P_{2} x z-1}{2}+\frac{P_{2} x z-1}{2}
$$

should be even. However, $P_{1} P_{3} \equiv-1(\bmod 8)$, and therefore,

$$
\begin{aligned}
u \equiv \frac{-P_{2} x z-1}{2} & +\frac{-P_{2} x z-1}{2} \cdot \frac{P_{2} x z-1}{2}+\frac{P_{2} x z-1}{2} \\
& \equiv-1-\frac{\left(P_{2} x z\right)^{2}-1}{4} \equiv 1 \quad(\bmod 2) .
\end{aligned}
$$

Contradiction.
Therefore, we remained with the case when $x, y, z$ are all odd numbers. From our equation we have that
$x^{4} \equiv-x y^{3} \quad\left(\bmod P_{2} z\right), x^{4} \equiv-P_{1}^{2} P_{2} z^{3} x \quad(\bmod y), y^{4} \equiv-P_{1}^{2} P_{2} z^{3} y \quad(\bmod x)$.
Hence, using the Jacoby symbol, we get that

$$
\left(\frac{-x y^{3}}{P_{2} z}\right)=\left(\frac{-P_{1}^{2} P_{2} z^{3} x}{y}\right)=\left(\frac{-P_{1}^{2} P_{2} z^{3} y}{x}\right)=1,
$$

whence,

$$
(-1)^{\left(P_{2} z-1\right) / 2}\left(\frac{x y}{P_{2} z}\right)=(-1)^{(y-1) / 2}\left(\frac{P_{2} z x}{y}\right)=(-1)^{(x-1) / 2}\left(\frac{P_{2} z y}{x}\right)=1 .
$$

Taking the product, we get that

$$
\begin{equation*}
(-1)^{\left(P_{2} z-1\right) / 2+(x-1) / 2+(y-1) / 2}\left(\frac{x y}{P_{2} z}\right)\left(\frac{P_{2} z x}{y}\right)\left(\frac{P_{2} z y}{x}\right)=1 . \tag{12}
\end{equation*}
$$

Furthermore, from the properties of the Jacoby symbol and the quadratic reciprocity law, we have that

$$
\begin{aligned}
\left(\frac{x y}{P_{2} z}\right) & \left(\frac{P_{2} z x}{y}\right)\left(\frac{P_{2} z y}{x}\right)=\left(\frac{x}{P_{2} z}\right)\left(\frac{y}{P_{2} z}\right)\left(\frac{P_{2} z}{y}\right)\left(\frac{x}{y}\right)\left(\frac{P_{2} z}{x}\right)\left(\frac{y}{x}\right) \\
& =\left(\frac{x}{P_{2} z}\right)\left(\frac{P_{2} z}{x}\right)\left(\frac{y}{P_{2} z}\right)\left(\frac{P_{2} z}{y}\right)\left(\frac{x}{y}\right)\left(\frac{y}{x}\right) \\
& =(-1)^{((x-1) / 2)\left(\left(P_{2} z-1\right) / 2\right)+\left(\left(P_{2} z-1\right) / 2\right)((y-1) / 2)+((y-1) / 2)((x-1) / 2)} .
\end{aligned}
$$

Hence, inserting this into (12), we obtain that the number

$$
\frac{x-1}{2}+\frac{y-1}{2}+\frac{P_{2} z-1}{2}+\frac{x-1}{2} \cdot \frac{y-1}{2}+\frac{y-1}{2} \cdot \frac{P_{2} z-1}{2}+\frac{P_{2} z-1}{2} \cdot \frac{x-1}{2}
$$

is an even integer. Note that for integers $u, v, w$ the number

$$
u+v+w+u v+v w+w u
$$

is even if and only if either $u, v, w$ are all even, or are all odd numbers. Hence, we have

$$
x \equiv y \equiv P_{2} z \equiv r_{0} \quad(\bmod 4),
$$

where $r_{0} \in\{1,3\}$. Take

$$
x=r_{0}+4 x_{0}, \quad y=r_{0}+4 y_{0}, \quad P_{2} z=r_{0}+4 z_{0} .
$$

Returning to our equation and recalling that $P_{1} P_{3} \equiv-1(\bmod 8)$, we see that

$$
x+y+P_{2} z+P_{2} x y z \equiv 0 \quad(\bmod 8) .
$$

Thus,

$$
3 r_{0}+4\left(x_{0}+y_{0}+z_{0}\right)+r_{0}^{3}+4 r_{0}^{2}\left(x_{0}+y_{0}+z_{0}\right) \equiv 0 \quad(\bmod 8)
$$

But this is not true, as the left hand side is

$$
r_{0}\left(3+r_{0}^{2}\right)+4\left(1+r_{0}^{2}\right)\left(x_{0}+y_{0}+z_{0}\right) \equiv 4 \quad(\bmod 8)
$$

This contradiction finishes the case $n=8 k-1$.

### 2.5 The case $n=2^{2 m+1}(2 k-1)+27$

We have that

$$
n-27 \equiv 2^{2 m+1} \quad\left(\bmod 2^{2 m+2}\right)
$$

We write $n=P_{1} P_{2}^{2} P_{3}^{3}$, where $P_{1}, P_{2}, P_{3}$ are odd positive integers, $P_{1}, P_{2}$ are squarefree relatively prime integers. As in the previous cases, we get that there are positive integers $x, y, z$ with $(x, y, z)=1$ such that

$$
x^{3}+y^{3}+P_{1}^{2} P_{2} z^{3}=P_{1} P_{2} P_{3} x y z .
$$

Since $(x, y, z)=1$ and $P_{1}^{2} P_{2}$ is cubefree, from Claim 1 we get that

$$
(x, y)=(y, z)=(z, x)=\left(x, P_{1} P_{2}\right)=\left(y, P_{1} P_{2}\right)=1 .
$$

Clearly, there exists odd integers $u$ and $v$ such that

$$
P_{1} \equiv u^{3} \quad\left(\bmod 2^{2 m+2}\right), \quad P_{2} \equiv v^{3} \quad\left(\bmod 2^{2 m+2}\right) .
$$

For instance, one can take $u=P_{1}^{\left(2^{2 m+1}+1\right) / 3}$ and similarly $v$. Then,

$$
x^{3}+y^{3}+u^{6} v^{3} z^{3}-3 x y u^{2} v z \equiv u^{3} v^{3} P_{3} x y z-3 x y u^{2} v z \quad\left(\bmod 2^{2 m+2}\right) .
$$

Using the decomposition

$$
4\left(A^{3}+B^{3}+C^{3}-3 A B C\right)=(A+B+C)\left((2 A-B-C)^{2}+3(B-C)^{2}\right)
$$

we get that

$$
\begin{aligned}
& \left(x+y+u^{2} v z\right)\left(\left(2 x-y-u^{2} v z\right)^{2}+3\left(y-u^{2} v z\right)^{2}\right) \\
& \equiv 4 x y z u^{2} v\left(u v^{2} P_{3}-3\right) \quad\left(\bmod 2^{2 m+4}\right)
\end{aligned}
$$

Multiplying both hand side by $\left(u v^{2} P_{3}\right)^{2}+3\left(u v^{2} P_{3}\right)+9$ we obtain that

$$
\begin{gathered}
\left(x+y+u^{2} v z\right)\left(\left(2 x-y-u^{2} v z\right)^{2}+3\left(y-u^{2} v z\right)^{2}\right)\left(\left(u v^{2} P_{3}\right)^{2}+3\left(u v^{2} P_{3}\right)+9\right) \\
\equiv 4 x y z u^{2} v\left(u^{3} v^{6} P_{3}^{3}-27\right) \equiv 4 x y z u^{2} v\left(P_{1} P_{2}^{2} P_{3}^{3}-27\right) \\
\equiv 4 x y z u^{2} v(n-27) \equiv 2^{2 m+3} x y z \quad\left(\bmod 2^{2 m+4}\right) .
\end{gathered}
$$

Since $\left(u v^{2} P_{3}\right)^{2}+3\left(u v^{2} P_{3}\right)+9$ is odd, we have that
$\left(x+y+u^{2} v z\right)\left(\left(2 x-y-u^{2} v z\right)^{2}+3\left(y-u^{2} v z\right)^{2}\right) \equiv 2^{2 m+3} x y z \quad\left(\bmod 2^{2 m+4}\right)$.
If $x y z$ were odd, we would have that $x+y+u^{2} v z$ is odd, implying that

$$
\left(2 x-y-u^{2} v z\right)^{2}+3\left(y-u^{2} v z\right)^{2} \equiv 2^{2 m+3} \quad\left(\bmod 2^{2 m+4}\right)
$$

This is obviously impossible, as the highest power of 2 which divides a number of the form $r^{2}+3 s^{2}$ should be even.

Thus, we proved that $x y z$ is an even number. Since $x, y, z$ are pairwise primes, it follows that exactly one of them is even.

Now we show that $z$ should be even. Assume contrary, let $z$ be odd. Then, exactly one of the numbers $x$ and $y$ is even. Without loss of generality, we can assume that $y$ is even, $x$ is odd. From our equation we have the congruence

$$
x^{4} \equiv-P_{1}^{2} P_{2} z^{3} x \quad\left(\bmod P_{1} P_{2} P_{3} x z-y^{2}\right) .
$$

Since $P_{1}^{2} P_{2} z^{3} x$ and $P_{1} P_{2} P_{3} x z-y^{2}$ are relatively prime positive integers, and $P_{1} P_{2} P_{3} x z-y^{2}$ is odd, we can use the Jacoby symbol. We deduce that

$$
\begin{aligned}
1 & =\left(\frac{-P_{1}^{2} P_{2} z^{3} x}{P_{1} P_{2} P_{3} x z-y^{2}}\right)=(-1)^{\left(P_{1} P_{2} P_{3} x z-1\right) / 2}\left(\frac{P_{2} z x}{P_{1} P_{2} P_{3} x z-y^{2}}\right) \\
& =(-1)^{\left(P_{1} P_{2} P_{3} x z-1\right) / 2}(-1)^{\left(\left(P_{2} z x-1\right) / 2\right)\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right)}\left(\frac{P_{1} P_{2} P_{3} x z-y^{2}}{P_{2} z x}\right) \\
& =(-1)^{\left(P_{1} P_{2} P_{3} x z-1\right) / 2}(-1)^{\left(\left(P_{2} z x-1\right) / 2\right)\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right)}\left(\frac{-y^{2}}{P_{2} z x}\right) \\
& =(-1)^{\left(P_{1} P_{2} P_{3} x z-1\right) / 2}(-1)^{\left(\left(P_{2} z x-1\right) / 2\right)\left(\left(P_{1} P_{2} P_{3} x z-1\right) / 2\right)}(-1)^{\left(\left(P_{2} z x-1\right) / 2\right)} \\
& =(-1)^{r+s+r s},
\end{aligned}
$$

where

$$
r=\frac{P_{1} P_{2} P_{3} x z-1}{2}, \quad s=\frac{P_{2} z x-1}{2} .
$$

Thus, $r+s+r s$ should be an even number, implying that both $r$ and $s$ are even numbers. That is,

$$
P_{1} P_{2} P_{3} x z \equiv 1 \quad(\bmod 4), \quad P_{2} x z \equiv 1 \quad(\bmod 4) .
$$

It follows that $P_{1} P_{3} \equiv 1(\bmod 4)$, whence we get that

$$
n=P_{1} P_{2}^{2} P_{3}^{3} \equiv P_{1} P_{3} \equiv 1 \quad(\bmod 4)
$$

which is contradiction with $n \equiv 3(\bmod 4)$.
Thus, we get that $z$ is an even number, $x y$ is odd. From our equation we have that

$$
x^{4} \equiv-x y^{3} \quad\left(\bmod P_{1} P_{3} x y-P_{1}^{2} z^{2}\right)
$$

Again, $x y^{3}$ and $P_{1} P_{3} x y-P_{1}^{2} z^{2}$ are relatively prime positive integers, with
latter being odd. Hence, we can use the Jacoby symbol and get that

$$
\begin{aligned}
1 & =\left(\frac{-x y^{3}}{P_{1} P_{3} x y-P_{1}^{2} z^{2}}\right)=(-1)^{\left(P_{1} P_{3} x y-1\right) / 2}\left(\frac{x y}{P_{1} P_{3} x y-P_{1}^{2} z^{2}}\right) \\
& =(-1)^{\left(P_{1} P_{3} x y-1\right) / 2}(-1)^{((x y-1) / 2)\left(\left(P_{1} P_{3} x y-1\right) / 2\right)}\left(\frac{P_{1} P_{3} x y-P_{1}^{2} z^{2}}{x y}\right) \\
& =(-1)^{\left(P_{1} P_{3} x y-1\right) / 2}(-1)^{((x y-1) / 2)\left(\left(P_{1} P_{3} x y-1\right) / 2\right)}\left(\frac{-P_{1}^{2} z^{2}}{x y}\right) \\
& =(-1)^{\left(P_{1} P_{3} x y-1\right) / 2}(-1)^{((x y-1) / 2)\left(\left(P_{1} P_{3} x y-1\right) / 2\right)}(-1)^{(x y-1) / 2} \\
& =(-1)^{r+s+r s},
\end{aligned}
$$

where

$$
r=\frac{x y-1}{2}, \quad s=\frac{P_{1} P_{3} x y-1}{2} .
$$

Thus, $r+s+r s$ should be an even number, implying that $r$ and $s$ are both even numbers. It follows that

$$
x y \equiv 1 \quad(\bmod 4), \quad P_{1} P_{3} x y \equiv 1 \quad(\bmod 4),
$$

implying again that $P_{1} P_{3} 1(\bmod 4)$ and

$$
n=P_{1} P_{2}^{2} P_{3}^{3} \equiv P_{1} P_{3} \equiv 1 \quad(\bmod 4)
$$

This contradiction finishes the case $n=2^{2 m+1}(2 k-1)+27$.
Lemma 1 is proved.

## 3 Proof of the theorem

We shall use the following statement due to Sylvester [2].
Lemma 2. Let $A, B, C, D, \alpha, \beta, \gamma$ be arbitrary real numbers for which

$$
A \alpha^{3}+B \beta^{3}+C \gamma^{3}=D \alpha \beta \gamma
$$

Then

$$
f^{3}+g^{3}+A B C h^{3}=D f g h,
$$

where

$$
\begin{aligned}
& f=A^{2} B \alpha^{6} \beta^{3}+B^{2} C \beta^{6} \gamma^{3}+C^{2} A \gamma^{6} \alpha^{3}-3 A B C \alpha^{3} \beta^{3} \gamma^{3} \\
& g=A B^{2} \alpha^{3} \beta^{6}+B C^{2} \beta^{3} \gamma^{6}+C A^{2} \gamma^{3} \alpha^{6}-3 A B C \alpha^{3} \beta^{3} \gamma^{3} \\
& h=\alpha \beta \gamma\left(A^{2} \alpha^{6}+B^{2} \beta^{6}+C^{2} \gamma^{6}-A B \alpha^{3} \beta^{3}-B C \beta^{3} \gamma^{3}-C A \gamma^{3} \alpha^{3}\right) .
\end{aligned}
$$

We proceed to prove our theorem. Assume that $a, b, c$ satisfies one of the conditions listed in the theorem and assume that the positive rational numbers $x, y, z$ are such that

$$
x y z=a b^{2}, \quad x+y+z=a b c
$$

First of all we note that if $x=y=z$, then $a^{2} b c^{3}=27$ which is not satisfied by conditions of the theorem.

We apply Lemma 2 with

$$
A=x, B=y, C=z, \quad \alpha=\beta=\gamma=1, \quad D=a b c .
$$

It follows that

$$
f^{3}+g^{3}+a b^{2} h^{3}=a b c f g h
$$

where

$$
\begin{gathered}
f=x^{2} y+y^{2} z+z^{2} x-3 x y z, \quad g=x y^{2}+y z^{2}+z x^{2}-3 x y z, \\
h=x^{2}+y^{2}+z^{2}-x y-y z-z x .
\end{gathered}
$$

Since not all the positive rational numbers $x, y, z$ are equal, from the elementary inequalities we get that $f, g$ and $h$ are also positive rational numbers. We have that

$$
f^{3}+g^{3}+\left(a^{2} b c^{3}\right)^{2} h_{1}^{3}=a^{2} b c^{3} f g h_{1},
$$

where $h_{1}=h / a c^{2}$. Thus, for $n=a^{2} b c^{3}$ the equation

$$
x^{3}+y^{3}+n^{2} z^{3}=n x y z
$$

has a solution in positive rational numbers $x, y, z$. Therefore, it also has a solution in positive integers $x, y, z$.

If $c \equiv 0(\bmod 4)$, then $n$ is of the form $64 k$.
If $b c \equiv 7(\bmod 8)$, then $b c^{3} \equiv 7(\bmod 8)$. Hence, $a^{2} b c^{3}$ is one of the forms $64 k, 32 k-16,16 k-4$ or $8 k-1$.

If $a \equiv 0(\bmod 4)$ and $b \equiv 1(\bmod 2)$, then $n$ is either of the form $64 k$ or of the form $32 k-16$.

If $a \equiv 0(\bmod 2)$ and $b c \equiv 3(\bmod 4)$, then $n$ is one of the forms $64 k$, $32 k-16$ or $16 k-4$.

If $a \equiv 1(\bmod 2), b \equiv 2(\bmod 4)$ and $c \equiv 0(\bmod 2)$, then $n$ is either of the form $64 k$ or of the form $32 k-16$.

By our Lemmannon of theses cases, neither the case $a^{2} b c^{3}=2^{2 m+1}(2 k-$ 1) +27 is possible.

Theorem 1 is proved.

## 4 Remarks

The proof of Lemma 1 also leads to a complete proof of the result that we announced in our work [5]. That is, if

$$
n \in\left\{16 k-4,64 k, 32 k-16,8 k-1,2^{2 m+1}(2 k-1)+27\right\},
$$

where $k$ and $m$ run through all positive integers, then the equation

$$
\begin{equation*}
\frac{(x+y+z)^{3}}{x y z}=n \tag{13}
\end{equation*}
$$

has no solutions in positive integers $x, y, z$. Indeed, assume that there are positive integers $x, y, z$ satisfying this equality. We apply the Sylvester transformation to the equality

$$
x \cdot 1^{3}+y \cdot 1^{3}+z \cdot 1^{3}=(x+y+z) \cdot 1 \cdot 1 \cdot 1 .
$$

It follows that

$$
f^{3}+g^{3}+x y z h^{3}=(x+y+z) f g h,
$$

for some positive integers $f, g, h$. Multiplying by $n^{3}$ and denoting

$$
X=n f, \quad Y=n g, \quad Z=(x+y+z) h
$$

we get

$$
X^{3}+Y^{3}+n^{2} Z^{3}=n X Y Z
$$

By Lemma 1 this is impossible. Thus, for the indicated set of values of $n$ the equation (13) has no solutions in positive integers $x, y, z$.

The problem of representability of integers $n$ in the form (13) with some positive integers $x, y, z$ is due to Richard Guy, see for the details the work of Tho [10] and the references therein.
