# TETRAVALENT VERTEX-TRANSITIVE GRAPHS OF ORDER $6 p$

#### Abstract

A graph is vertex-transitive if its automorphism group acts transitively on vertices of the graph. A vertex-transitive graph is a Cayley graph if its automorphism group contains a subgroup acting regularly on its vertices. In this paper, the tetravalent vertex-transitive non-Cayley graphs of order $6 p$ are classified for each prime $p$.


## 1. Introduction

In this paper we consider undirected finite connected graphs without loops or multiple edges. For a graph $X$ we use $V(X), E(X), A(X)$ and $\operatorname{Aut}(X)$ to denote its vertex set, edge set, arc set and its full automorphism group, respectively. For $u, v \in V(X), u \sim v$ represents that $u$ is adjacent to $v$, and is denoted by $\{u, v\}$ the edge incident to $u$ and $v$ in $X$, and $N_{X}(u)$ is the neighborhood of $u$ in $X$, that is, the set of vertices adjacent to $u$ in $X$. A graph $X$ is said to be $G$-vertex-transitive, $G$-edge-transitive and $G$-arctransitive (or $G$-symmetric) if $G \leq \operatorname{Aut}(X)$ acts transitively on $V(X), E(X)$ and $A(X)$, respectively. In the special case, if $G=\operatorname{Aut}(X)$ then $X$ is said to be vertex-transitive, edge-transitive and arc-transitive (or symmetric). An s-arc in a graph $X$ is an ordered $(s+1)$-tuple $\left(v_{0}, v_{1}, \cdots, v_{s}\right)$ of vertices of $X$ such that $v_{i-1}$ is adjacent to $v_{i}$ for $1 \leq i \leq s$, and $v_{i-1} \neq v_{i+1}$ for $1 \leq i \leq s$; in other words, a directed walk of length $s$ which never includes a backtracking. A graph $X$ is said to be s-arc-transitive if $\operatorname{Aut}(X)$ is transitive on the set of $s$-arcs in $X$. A subgroup of the automorphism group of a graph $X$ is said to be s-regular if it acts regularly on the set of $s$-arcs of $X$. Recall that a permutation group $G$ acting on a set $\Omega$ is called semiregular if the stabilizer of $\alpha \in G, G_{\alpha}=1$ for all $\alpha \in G$ and is called regular if it is semiregular and transitive.

Let $G$ be a finite group and $S$ be a subset of $G$ such that $1 \notin S$ and $S=S^{-1}$ where $S^{-1}=\left\{s^{-1} \mid s \in S\right\}$. The Cayley graph $X=\operatorname{Cay}(G, S)$ on $G$ with respect to $S$ is defined as the graph with vertex set $V(X)=G$ and edge set $E(X)=\{\{g, s g\} \mid g \in G, s \in S\}$. The automorphism group $\operatorname{Aut}(X)$ of $X$ contains the right regular representation $R(G)$ of $G$, the acting group of $G$ by right multiplication, as a subgroup, and $R(G)$ is regular on $V(X)$. A Cayley graph, $\operatorname{Cay}(G, S)$ is said to be normal if $R(G)$ is normal in $\operatorname{Aut}(\operatorname{Cay}(G, S)$ ). By [36, Proposition 3.1], $N_{\operatorname{Aut}(\operatorname{Cay}(G, S))}(R(G))=R(G) \operatorname{Aut}(G, S)$, where $\operatorname{Aut}(G, S)=\{\alpha \in$

[^0]$\left.\operatorname{Aut}(G) \mid S^{\alpha}=S\right\}$. Note that $\operatorname{Aut}(X)$ is normal if and only if $\operatorname{Aut}(G, S)=\operatorname{Aut}(X)_{v}$ for some $v \in V(X)$.

It is well known that a vertex-transitive graph is a Cayley graph if and only if its automorphism group contains a subgroup acting regularly on its vertex set (see, for example, [32, Lemma 4]). There are vertex-transitive graphs which are not Cayley graphs and the smallest one is the well-known Petersen graph. Such a graph will be called a vertex-transitive non-Cayley graph, or a $\mathcal{V N C}$-graph for short.

Many publications have been put into service of investigation the $\mathcal{V N C}$-graphs from different perspectives. For example, in [19], Marušič asked for a determination of the set $\mathcal{N C}$ of non-Cayley numbers, that is, those numbers $n$ for which there exists a $\mathcal{V N C}$-graph of order $n$, and to settle this question, a lot of $\mathcal{V N C}$-graphs were constructed in 12, 14, 15, 20, 21, 22, 23, 24, 25, 27, 30. In [8], Feng considered the question to determine the smallest valency for $\mathcal{V N C}$-graphs of a given order and it was solved for the graphs of odd prime power order. From [6, 18] all cubic or tetravalent $\mathcal{V N C}$-graphs of order $2 p$ are known for each prime $p$. In [38, 39, 40], all cubic $\mathcal{V N C}$-graphs of order $2 p q$ were classified for any primes $p$ and $q$. Also tetravalent $\mathcal{V N C}$-graphs of order $2 p^{2}$ and $4 p$ were classified for any prime $p$ (see [5, 37]). We know that all components of vertex-transitive graphs are isomorphic. So without loss of generality we may assume that $X$ is connected.

A graph $X$ is said to be a bi-Cayley graph over a group $G \leq \operatorname{Aut}(X)$ if it admits $G$ as a semiregular automorphism group with two orbits of equal size. Note that every biCayley graph admits the following concrete realization. Let $R, L$ and $S$ be subsets of a group $G$ such that $R=R^{-1}, L=L^{-1}$ and $R \cup L$ does not contain the identity element of $G$. Let $g_{0}=(g, 0)$ and $g_{1}=(g, 1)$ where $g \in G$. Define the graph $\operatorname{BiCay}(G, R, L, S)$ to have vertex set the union of the right part $G_{0}=\left\{g_{0} \mid g \in G\right\}$ and the left part $G_{1}=\left\{g_{1} \mid g \in G\right\}$ and edge set the union of the right edges $\left\{\left\{h_{0}, g_{0}\right\} \mid g h^{-1} \in R\right\}$, the left edges $\left\{\left\{h_{1}, g_{1}\right\} \mid g h^{-1} \in L\right\}$ and the spokes $\left\{\left\{h_{0}, g_{1}\right\} \mid g h^{-1} \in S\right\}$. Now we introduce the coset graph constructed from a finite group $G$ relative to a subgroup $H$ of $G$ and a union $D$ of some double cosets of $H$ in $G$ such that $D^{-1}=D$. The coset graph $\operatorname{Cos}(G, H, D)$ of $G$ with respect to $H$ and $D$ is defined to have vertex set $[G: H]$, the set of right cosets of $H$ in $G$, and edge set $\{\{H g, H d g\} \mid g \in G, d \in D\}$. The graph $\operatorname{Cos}(G, H, D)$ has valency $|D| /|H|$ and is connected if and only if $D$ generates the group $G$. The action of $G$ on $V(\operatorname{Cos}(G, H, D))$ by right multiplication induces a vertex-transitive automorphism group, which is arc-transitive if and only if $D$ is a single double coset. Clearly, $\operatorname{Cos}(G, H, D) \cong \operatorname{Cos}\left(G, H^{\alpha}, D^{\alpha}\right)$ for every $\alpha \in \operatorname{Aut}(G)$. Conversely, let $X$ be a graph and let $A$ be a vertex-transitive subgroup of $\operatorname{Aut}(X)$. By [31, the graph $X$ is isomorphic to a coset graph $\operatorname{Cos}(A, H, D)$, where $H=A_{u}$ is the stabilizer of $u \in V(X)$ in
$A$ and $D$ consists of all elements of $A$ which map $u$ to one of its neighbors. It is easy to show that $\operatorname{Core}_{A}(H)=1$ and that $D$ is a union of some double cosets of $H$ in $A$ satisfying $D=D^{-1}$. Recall that a graph $\Gamma=(V, E)$ is called an $(m, n)$-metacirculant, where $m, n$ are positive integers, if $\Gamma$ is of order $|V|=m n$ and has two automorphisms $\rho, \sigma$ such that
(a) $\langle\rho\rangle$ is semiregular and has $m$ orbits on $V$,
(b) $\sigma$ cyclically permutes the $m$ orbits of $\langle\rho\rangle$ and normalizes $\langle\rho\rangle$, and
(c) $\sigma^{m}$ fixes at least one vertex of $\Gamma$.

A graph $\widetilde{X}$ is called a covering of a graph $X$ with projection $\wp: \widetilde{X} \rightarrow X$ if there is a surjection $\wp: V(\widetilde{X}) \rightarrow V(X)$ such that $\left.\wp\right|_{N_{\tilde{X}}(\tilde{v})}: N_{\tilde{X}}(\tilde{v}) \rightarrow N_{X}(v)$ is a bijection for any vertex $v \in V(X)$ and $\tilde{v} \in \wp^{-1}(v)$. A covering $\tilde{X}$ of $X$ with a projection $\wp$ is said to be regular (or $K$-covering) if there is a semiregular subgroup $K$ of the automorphism group $\operatorname{Aut}(\widetilde{X})$ such that the graph $X$ is isomorphic to the quotient graph $\widetilde{X} / K$, say by $\Im$, and the quotient map $\widetilde{X} \rightarrow \widetilde{X} / K$ is the composition $\wp \Im$ of $\wp$ and $\Im$ (for the purpose of this paper, all functions are composed from left to right). If $K$ is cyclic or elementary abelian then $\widetilde{X}$ is called a cyclic or an elementary abelian covering of $X$, and if $\widetilde{X}$ is connected $K$ becomes the covering transformation group. The fibre of an edge or a vertex is its preimage under $\wp$. An automorphism of $\widetilde{X}$ is said to be fibre-preserving if it maps a fibre to a fibre, while every covering transformation maps a fibre on to itself. All of fibre-preserving automorphisms form a group called the fibre-preserving group.

Let $\widetilde{X}$ be a $K$-covering of $X$ with a projection $\wp$. If $\alpha \in \operatorname{Aut}(X)$ and $\widetilde{\alpha} \in \operatorname{Aut}(\widetilde{X})$ satisfy $\widetilde{\alpha} \wp=\wp \alpha$, we call $\widetilde{\alpha}$ a lift of $\alpha$, and $\alpha$ the projection of $\widetilde{\alpha}$. Concepts such as a lift of a subgroup of $\operatorname{Aut}(X)$ and the projection of a subgroup of $\operatorname{Aut}(\widetilde{X})$ are self-explanatory. The lifts and the projections of such subgroups are of course subgroups in $\operatorname{Aut}(\tilde{X})$ and $\operatorname{Aut}(X)$, respectively.

Let $m_{1}, m_{2}>1$ be two odd integers such that $\left(m_{1}, m_{2}\right)=1$. Let $1 \leq t \leq m_{2}$, $\left(t, m_{2}\right)=1$ be such that $t^{2} \equiv-1\left(\bmod m_{2}\right)$. Let $H=\langle r\rangle \times\langle s\rangle \cong \mathbb{Z}_{m_{1}} \times \mathbb{Z}_{m_{2}}=\mathbb{Z}_{m_{1} m_{2}}$. Set $R=\left\{r, r^{-1}\right\}, L=\left\{r^{t}, r^{-t}\right\}$ and $S=\{1, s\}$ and $X_{m_{1}, m_{2}, t}=\operatorname{BiCay}(H, R, L, S)$. Then we have the following result.

Proposition 1. [29, Theorem 4.3] Let $X$ be a connected tetravalent vertex-transitive biCayley graph over a cyclic group of odd order n. Then $X$ is a $\mathcal{V N C}$-graph if and only if $X \cong X_{m_{1}, m_{2}, t}$ for some integers $m_{1}, m_{2}$ and $t$.

The following theorem is the main result of this paper.

Theorem 2. Let $X$ be a connected tetravalent vertex-transitive graph of order $6 p$, where $p$ is a prime. Then $X$ is a $\mathcal{V N C}$-graph if and only if $X \cong X_{3, p, t}$, where $1 \leq t \leq p-1$ and $t^{2} \equiv-1(\bmod p)$ or $X$ is one of the nine specified graphs.

## 2. Preliminaries

In this section, we introduce some notation and definitions as well as some preliminary results which will be used later in the paper.

For a regular graph $X$, use $d(X)$ to represent the valency of $X$, and for any subset $B$ of $V(X)$, the subgraph of $X$ induced by $B$ will be denoted by $X[B]$. Let $X$ be a connected vertex-transitive graph, and let $G \leq \operatorname{Aut}(X)$ be vertex-transitive on $X$. For a $G$-invariant partition $\Omega$ of $V(X)$, the quotient graph $X_{\Omega}$ is defined as the graph with vertex set $\Omega$ such that, for any two vertices $B, C \in \Omega, B$ is adjacent to $C$ if and only if there exist $u \in B$ and $v \in C$ which are adjacent in $X$. Let $N$ be a normal subgroup of $G$. Then the set $\Omega$ of orbits of $N$ in $V(X)$ is a $G$-invariant partition of $V(X)$. In this case, the symbol $X_{\Omega}$ will be replaced by $X_{N}$.

For two groups $M$ and $N$, by $N \rtimes M$ we denote the semidirect product of $N$ by $M$. For a group $G$, the largest solvable normal subgroup of $G$ is called the solvable radical of $G$ and is denoted by $\operatorname{Sol}(G)$. The outer automorphism group of the group $G$, is the quotient, $\operatorname{Aut}(G) / \operatorname{Inn}(G)$, where $\operatorname{Aut}(G)$ is the automorphism group of $G$ and $\operatorname{Inn}(G)$ is the subgroup consisting of inner automorphisms. The outer automorphism group is usually denoted by $\operatorname{Out}(G)$. Also a lexicographic product of two graphs $X$ and $Y$ which is denoted by $X[Y]$ is defined as the graph with vertex set $V(X) \times V(Y)$ such that for any two vertices $u=\left(x_{1}, y_{1}\right)$ and $v=\left(x_{2}, y_{2}\right)$ in $X[Y], u$ is adjacent to $v$ in $X[Y]$, whenever either $\left\{x_{1}, x_{2}\right\} \in E(X)$ or $x_{1}=x_{2}$ and $\left\{y_{1}, y_{2}\right\} \in E(Y)$. Note that the lexicographic product of two Cayley graphs is a Cayley graph. For group and graph-theoretic terms not defined here we refer the reader to [4] and [35], respectively. Now we state the following well known result.

Proposition 3. Let $X$ be a $G$-vertex-transitive graph. Then $X$ is symmetric if and only if each vertex stabilizer $G_{v}$ acts transitively on the set of vertices adjacent to $v$, where $v \in V(X)$.

A finite simple group $G$ is said to be a $K_{3}$-group if its order has exactly three distinct prime divisors. By [11, Pages 12-14 ], $G$ is isomorphic to one of the following groups:

The socle of a group $G$ is the subgroup generated by the set of all minimal normal subgroups of $G$, it is denoted by $\operatorname{soc}(G)$. Also a group $G$ is said to be almost simple if
$T \leq G \leq \operatorname{Aut}(T)$, where $T$ is a non-abelian simple group. It is well known that $G$ is an almost simple group if and only if $\operatorname{soc}(G)=T$ for some non-abelian simple group $T$.

Now we prove the following lemma.
Lemma 4. Let $G$ be an almost simple group and $\operatorname{soc}(G)=A$, where $A$ is a non-abelian simple $K_{3}$-group. Then
(i) If $A \cong A_{5}$ then $G \cong A_{5}$ or $S_{5}$.
(ii) If $A \cong A_{6}$ then $G \cong A_{6}$ or $S_{6}$ or $S_{6} \rtimes \mathbb{Z}_{2}$.
(iii) If $A \cong \operatorname{PSL}_{2}(p)$, where $p \in\{7,17\}$, then $G \cong \operatorname{PSL}_{2}(p)$ or $\operatorname{PGL}_{2}(p)$.
(iv) If $A \cong \mathrm{PSL}_{2}(8)$ then $G \cong \mathrm{PSL}_{2}(8)$ or $G / \mathrm{PSL}_{2}(8) \cong \mathbb{Z}_{3}$.
(v) If $A \cong \operatorname{PSL}_{3}(3)$ then $G \cong \operatorname{PSL}_{3}(3)$ or $G / \operatorname{PSL}_{3}(3) \cong \mathbb{Z}_{2}$.
(vi) If $A \cong \mathrm{U}_{3}(3)$ then $G \cong \mathrm{U}_{3}(3)$ or $G / \mathrm{U}_{3}(3) \cong \mathbb{Z}_{2}$.
(vii) If $A \cong \mathrm{U}_{4}(2)$ then $G \cong \mathrm{U}_{4}(2)$ or $G / \mathrm{U}_{4}(2) \cong \mathbb{Z}_{2}$.

Proof. Since $G$ is an almost simple group and $\operatorname{soc}(G)=A$, it implies that $A \leq G \leq \operatorname{Aut}(A)$. If $A \cong A_{5}$, then $A_{5} \leq G \leq \operatorname{Aut}\left(A_{5}\right)$. Now since $\left|\operatorname{Out}\left(A_{5}\right)\right|=2$, it follows that $G \cong A_{5}$ or $S_{5}$ and (i) holds. Also if $A$ is isomorphic to one of $\mathrm{PSL}_{2}(7), \mathrm{PSL}_{2}(17), \mathrm{PSL}_{3}(3), \mathrm{U}_{3}(3)$ or $\mathrm{U}_{4}(2)$ then $|\operatorname{Out}(A)|=2$ and the assertions in (iii), (v), (vi) and (vii) hold. If $A \cong A_{6}$ then $\left|\operatorname{Out}\left(A_{6}\right)\right|=4$ and $\operatorname{Aut}\left(A_{6}\right) \cong S_{6} \rtimes \mathbb{Z}_{2}$. Thus $G \cong A_{6}$ or $S_{6}$ or $S_{6} \rtimes \mathbb{Z}_{2}$ and (ii) holds. Finally if $A \cong \mathrm{PSL}_{2}(8)$ then $\left|\operatorname{Out}\left(\mathrm{PSL}_{2}(8)\right)\right|=3$. Hence $G \cong \mathrm{PSL}_{2}(8)$ or $G / \mathrm{PSL}_{2}(8) \cong \mathbb{Z}_{3}$ and (iv) holds.

## 3. Main Results

In this section we classify all connected tetravalent $\mathcal{V N C}$-graphs of order $6 p$ where $p$ is a prime. To do this we prove the following propositions.

Proposition 5. Let $X$ be a graph, $A=\operatorname{Aut}(X)$ and $N$ be the normal subgroup of $A$. Also let $\Omega$ be the set of orbits of $N$ on $V(X)$ and $X_{N}$ be a Cayley graph on subgroup of $A / K$, where $K$ is the kernel of action $N$ on $\Omega$. Then $X$ is a Cayley graph on some subgroup of A.

Proof. Suppose that $X_{N}=\operatorname{Cay}(H, S)$, where $H \leq A / K$. Thus we may suppose that $H=T / K$, where $T \leq A$. Let $x, y$ be two arbitrary elements of $V(X)$. Set $X=x^{N}$ and $Y=y^{N}$. If $X=Y$ then there is $\alpha \in N$ so that $x^{\alpha}=y$. Thus we may suppose that $X \neq Y$. By our assumption there is an element $K \beta \in T / K$ such that $\left(x^{N}\right)^{K \beta}=\left(y^{N}\right)$ and so $\left(x^{N}\right)^{\beta}=\left(y^{N}\right)$. Now $x^{\beta}=y^{n}$ for some $n \in N$. Now $x^{\left(\beta n^{-1}\right)}=y$, where $\beta n^{-1} \in T$. Thus $T$ acts transitively on $V(X)$. Suppose that $x^{t}=x$, where $t \in T$. Now $\left(x^{N}\right)^{K t}=\left(x^{N}\right)$, a contradiction. Thus $T$ acts regularly on $V(X)$ and $X$ is a Cayley graph on $T$.

Proposition 6. Let $X$ be a connected tetravalent vertex-transitive graph of order $3 p$, where $p$ is a prime. Then $X$ is a $\mathcal{V N C}$-graph if and only if $X$ is isomorphic to $L\left(O_{3}\right)$, the line graph of the Petersen graph.

Proof. Suppose that $X$ is a connected tetravalent $\mathcal{V N C}$-graph of order 3p. By [26], all tetravalent vertex-transitive graphs of order 6,9 and 21 are Cayley graphs. Also a tetravalent vertex-transitive graph of order 15 is not a Cayley graph and is isomorphic to $L\left(O_{3}\right)$. Thus we may assume that $p \geq 11$. If $X$ is symmetric then by [34, Page 215], is isomorphic to one of $L_{3}(2)_{21}^{4}$ or $G(3 p, 2)$, which are Cayley graphs. Thus in the following we may assume that $X$ is not symmetric. Let $A=\operatorname{Aut}(X)$ and $v \in V(X)$. Since $A_{v}$ is a $\{2,3\}$-group we have $|A|=2^{s} 3^{t} p$, for some non-negative integers $s, t$. We claim that $A$ is not solvable.

Suppose by contrary that $A$ is solvable and let $N$ be a minimal normal subgroup of $A$. Then $N$ ia an elementary abelian $r$-group, where $r \in\{2,3, p\}, N=T^{k}$, and $T$ is a simple group. Let $\Omega$ be the set of orbits of $N$ on $V(X)$ and $K$ be the kernel of the action $A$ on the set of orbits of $N$. By considering the order of graph, we see that either $r=3$ or $r=p$. Assume first that $N$ is an elementary abelian 3-group. Then $X_{N}$ has order $p$ and has valency 2 or 4 . It is easy to see that $K$ acts faithfully on each orbits and therefore $K \leq S_{3}$, which implies that $|N|=3$. Let $P$ be a Sylow $p$-subgroup of $A$. Then $|P|=p$ and since $N$ is a normal subgroup of $A$, it follows that the orbits of $N$ form a complete block system of $A$. Moreover $P \times N$ acts regularly on $V(X)$ which implies that $X$ is a Cayley graph, a contradiction. Next assume that $N$ is an elementary abelian $p$-group. Then $X_{N}$ has order 3 and its valency is 2 . Hence $\operatorname{Aut}\left(X_{N}\right) \cong D_{6}$. Suppose that $\Omega=\left\{\Delta_{0}, \Delta_{1}, \Delta_{2}\right\}$ and $\Delta_{i} \sim \Delta_{i+1}$ where the subscripts are taken modulo 3. If $\Delta_{i}$ has an edge, then $X\left[\Delta_{i}\right] \cong C_{p}$ and it is easy to see that $\left|K_{v}\right| \leq 2$ where $v \in V(X)$. Thus we have $|K| \leq 2 p$. In case $\Delta_{i}$ has no edge, then since $\left|V\left(X_{N}\right)\right|=3$ and $p \geq 11$ we conclude that $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong C_{2 p}$. Let $K^{*}$ be the kernel of the action of $K$ on $X\left[\Delta_{i} \cup \Delta_{i+1}\right]$. Now the connectivity of $X$ and transitivity of $A / K$ on $V\left(X_{N}\right)$ imply that $K^{*}=1$ and consequently, $K \leq \operatorname{Aut}\left(X\left[\Delta_{i} \cup \Delta_{i+1}\right]\right) \cong D_{4 p}$. Since $K$ fixes $\Delta_{i}$ it follows that $|K| \leq 2 p$. Since $A / K$ is transitive on $V\left(X_{N}\right)$ it follows that 3 divides $|A / K|$ and $A / K$ has an element of order 3 , say $K \alpha$, where $\alpha \in A$. Therefore $\alpha^{3} \in K$ and hence $o\left(\alpha^{3}\right)=1,2, p$ or $2 p$. If $\alpha^{3}=1$ then $\langle\alpha\rangle . P$ acts transitively and so regularly on $V(X)$, a contradiction. Also if $o\left(\alpha^{3}\right)=2$, $p$ or $2 p$ then $\alpha^{2}, \alpha^{p}$ and $\alpha^{2 p}$ have order 3. In each case there is an element of order 3 , say $\beta$, in $A$ such that $\langle\beta\rangle . P$ acts regularly on $V(X)$, another contradiction. Hence $A$ is not solvable.

Let $L=\operatorname{Sol}(A), \Sigma$ be the set of orbits of $L$ on $V(X)$ and $K$ be the kernel of the action of $A$ on the set of orbits of $L$. Assume first that $L$ is not trivial. Since $K_{v}$ is a $\{2,3\}$-group, it implies that $K_{v}$ is solvable and by considering $K=L K_{v}$ we see that $K$ is solvable. By the
definition of solvable radical we conclude that $K=L$ and $A / L \leq \operatorname{Aut}\left(X_{L}\right)$. If $\operatorname{deg}\left(X_{L}\right)=0$ then $A / L$ is solvable which implies that $A$ is solvable, a contradiction. Since $|X|=3 p$, this implies that $\operatorname{deg}\left(X_{L}\right) \neq 1,3$. In case $\operatorname{deg}\left(X_{L}\right)=2$ we have $\operatorname{Aut}\left(X_{L}\right) \cong D_{2 n}$, where $\left|V\left(X_{L}\right)\right|=n$ and $n \in\{3, p\}$. Now $A / L$ is solvable and so $A$ is solvable, which is impossible. Thus we may assume that $\operatorname{deg}\left(X_{L}\right)=4$ and $L \leq S_{3}$. Thus $X_{L}$ is a circulant graph and $X_{L}=\operatorname{Cay}(G, S)$, where $G \cong \mathbb{Z}_{p}=\langle a\rangle, S=\left\{a^{r}, a^{-r}, a^{s}, a^{-s}\right\}$ where $(r, p)=(s, p)=1$. By [3, Theorem 1.2], $X_{L}$ is normal. Hence $\operatorname{Aut}(G, S)=\operatorname{Aut}\left(X_{L}\right)$. Since $\sigma: a \mapsto a^{r}$ is an automorphism of $G$ we have $S=\left\{a, a^{-1}, a^{i}, a^{-i}\right\}$ where $(i, p)=1$.

Set $B=\operatorname{Aut}\left(X_{L}\right)$ and $Y=X_{L}$. Let $B_{1}^{*}$ be the subgroup of $B_{1}$ which fixes $\{1\} \cup S$ and $Y_{2}(1)$ be the subgraph of $Y$ with vertex set

\{1\} \cup S \cup\left\{a^{2}, a^{-2}, a^{i+1}, a^{-i+1}, a^{2 i}, a^{-2 i}, a^{-i-1}, a^{i-1}\right\} .
$$

Also
$N_{Y}(a)=\left\{1, a^{2}, a^{i+1}, a^{-i+1}\right\}, N_{Y}\left(a^{-1}\right)=\left\{1, a^{-2}, a^{-i-1}, a^{i-1}\right\}, N_{Y}\left(a^{i}\right)=\left\{1, a^{i+1}, a^{2 i}, a^{i-1}\right\}$
and $N_{Y}\left(a^{-i}\right)=\left\{1, a^{-i+1}, a^{-2 i}, a^{-i-1}\right\}$. By a tedious computation we find that $B_{1}^{*}=1$ and $B_{1}$ have no any element of order 4 . Thus $B_{1}$ acts faithfully on $S$ and so $B_{1} \leq S_{4}$. Since $B_{1}$ has no any element of order 4, by considering the subgroups of $S_{4}$ we see that either $B_{1} \cong \mathbb{Z}_{2} \times \mathbb{Z}_{2}$ or $\left|B_{1}\right| \in\{1,2,6\}$. Since $|B|=\left|B_{1}\right||G|$ we see that $|B| \in\{p, 2 p, 4 p, 6 p\}$. Moreover $\alpha: a \rightarrow a^{-1}$ is an element of $\operatorname{Aut}(G, S)$ and $o(\alpha)=2$. Hence $\left|B_{1}\right|=2$ or 4 or 6 . From the fact that $A / L$ acts transitively on $V(Y)$ we have $p||A / L|$ and $|A / L| \in\{p, 2 p, 4 p, 6 p\}$. By considering the order of $B$ we see that $G \leq A / L$. So $G=T / L$ where $T \leq A$ and by Proposition 5, $X$ is a Cayley graph, a contradiction.

Assume now that $L$ is trivial. Then $N$ is not solvable, where $N$ is the minimal normal subgroup of $A$. If $N$ is semiregular then $|N|$ divides $3 p$ and $N$ is solvable, a contradiction. Therefore $N$ is not semiregular and the valency of quotient graph $X_{N}$ is not 4. By considering the order of graph we see that $X_{N}$ is not cubic. Thus $\operatorname{deg}\left(X_{N}\right)=0$ or 2 and since $A / K \leq \operatorname{Aut}\left(X_{N}\right)$ we conclude that $A / K$ is solvable. Moreover, since $K=K_{v} N$ and $K_{v}$ is a $\{2,3\}$-group we conclude that $K / N$ is solvable. From the fact that $A / K \cong$ $(A / N) /(K / N)$ we conclude that $A / N$ is solvable. We claim that $N$ is the unique minimal normal subgroup of $A$. Suppose by contrary that $M \neq N$ is another minimal normal subgroup of $A$. Since $M N / N \cong M /(M \cap N) \leq A / N$ we see that $M /(M \cap N)$ is solvable. But $M \cap N=1$ and so $M$ is solvable, a contradiction. Hence $N$ is the only minimal normal subgroup of $A$. Also since $|A|$ is not divided by $p^{2}$ we conclude that $N$ is a simple group. Therefore $A$ is an almost simple group and $\operatorname{soc}(A)=N$. From the fact that $A$ is a $\{2,3, p\}$-group, we conclude that $N$ is a $K_{3}$-group. Also since $p \geq 11$ it follows that $N$ is isomorphic to either $\mathrm{PSL}_{2}(17)$ or $\mathrm{PSL}_{3}(3)$.

First assume that $N \cong \mathrm{PSL}_{2}(17)$. Then by part (iii) of Lemma 4, $A \cong \mathrm{PSL}_{2}(17)$ or $\mathrm{PGL}_{2}(17)$. If $A \cong \mathrm{PSL}_{2}(17)$ then $\left|A: A_{v}\right|=51$. By [7], we see that $A$ has not any subgroup of index 51 , a contradiction. Also if $A \cong \mathrm{PGL}_{2}(17)$, then by using GAP [10], $A$ has no any subgroup of index 51 , another contradiction.

Assume now that $N \cong \mathrm{PSL}_{3}(3)$. In this case, by part $(v)$ of Lemma 4, $A \cong \mathrm{PSL}_{3}(3)$ or $A=\operatorname{Aut}\left(\operatorname{PSL}_{3}(3)\right)$. In the first case, by using GAP [10], and the fact that $A$ is a transitive permutation group of degree 39 , we see that $A$ has a regular subgroup which means that $X$ is a Cayley graph, a contradiction. However the later case is impossible, because there is no transitive permutation representation of $\operatorname{Aut}\left(\mathrm{PSL}_{3}(3)\right)$ of degree 39 .

Let $X$ be a connected tetravalent vertex-transitive graph of order $6 p$. If $p=2$ or 3 , then by [26], we see that $X$ is a Cayley graph. Also if $p=5$ or $p=7$ then by [13] and using [28] we see that $X$ is isomorphic to one of the graphs in the following lemma.

Lemma 7. A connected tetravalent vertex-transitive non-Cayley graph of order at most 42 are listed below:
(i) The Coxeter graph;
(ii) the Desargues graph;
(iii) the dodecahedron graph;
(iv) one of the six graphs in Figure 1.


Figure 1. Six graphs illustrated in Lemma 7

Proof of the Theorem 2. Let $X$ be a connected tetravalent vertex-transitive graph of order $6 p$. If $p \leq 7$, then $X$ is one of the nine specified graphs in Lemma 7. So we may
assume that $p \geq 11$. Suppose that $X \cong X_{3, p, t}$, then by Proposition 1, $X$ is a $\mathcal{V N C}$-graph. Assume that $X$ is a $\mathcal{V N C}$-graph. Let $A=\operatorname{Aut}(X)$ and $v \in V(X)$. Since $X$ is connected and tetravalent, $A_{v}$ is a $\{2,3\}$-group and so $|A|=2^{s} 3^{t} p$ for some integers $s, t \geq 1$. Assume that $N$ is a minimal normal subgroup of $A$. We know that $N=T^{k}$, where $T$ is a finite simple group. Let $\Omega$ be the set of orbits of $N$ on $V(X)$ and $K$ be the kernel of the action of $A$ on $\Omega$. Now we consider two cases:

Case I. $A$ is solvable.
In this case $N$ ia an elementary abelian $r$-group, where $r \in\{2,3, p\}$. First suppose that $N$ is an elementary abelian 2-group. In this case $X_{N}$ has order $3 p$ and valency 2 or 4. If $X_{N}$ has valency 2 then $X_{N} \cong C_{3 p}$ and $\operatorname{Aut}\left(X_{N}\right) \cong D_{6 p}$. Suppose that $\Omega=$ $\left\{\Delta_{0}, \Delta_{1}, \Delta_{2}, \cdots, \Delta_{3 p-1}\right\}$, where the subscripts are taken modulo $3 p$. Also suppose that $\Delta_{i} \sim \Delta_{i+1}$ in $X_{N}$. If for some $i$, the induced graph $X\left[\Delta_{i}\right]$ has an edge then by considering the valency of $X$, we see that $X\left[\Delta_{i-1} \cup \Delta_{i}\right] \cong C_{4}$ and $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong K_{4}$ where $1 \leq i \leq$ $3 p-1$. Now by considering the induced graph $X\left[\Delta_{0} \cup \Delta_{3 p-1}\right]$, we have a contradiction. Thus we may assume that each $X\left[\Delta_{i}\right]$ has no any edge. Thus for each $i, X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong C_{4}$. It is easy to see that in this case $X \cong C_{3 p}\left[2 K_{1}\right]$, which is a Cayley graph, a contradiction.

Assume now that $X_{N}$ has valency 4. Then $K_{v}=1$ for each vertex $v$. By Proposition 6. $X_{N}$ is a Cayley graph, unless the case where $X_{N}$ is isomorphic to the line graph of the Petersen graph. Since $p \geq 11, X_{N}$ is not isomorphic to the line graph of the Petersen graph. Hence $X_{N}$ is a Cayley graph and by [21, Proposition 1.2], is a (3, p)-metacirculant graph. Thus $X_{N}$ has an automorphism $\sigma$ of order $p$ such that $\langle\sigma\rangle$ is semiregular on the vertex set of $X_{N}$. Moreover $X_{N}$ has an automorphism say $\tau$ such that $\tau$ normalizing $\langle\sigma\rangle$ and cyclically permutes the 3 orbits of $\langle\sigma\rangle$ and has a cycle of size 3 in its cycle decomposition. Thus, for some positive integer $i$, the group $\left\langle\sigma, \tau^{i}\right\rangle$, has order $3 p$ and acts regularly on $V\left(X_{N}\right)$. Therefore we may suppose that $X_{N}=\operatorname{Cay}(H, S)$ where $H=\left\langle\sigma, \tau^{i}\right\rangle$. First suppose that $H \cong F_{3 p}$. If $X_{N}$ is normal then $\operatorname{Aut}\left(X_{N}\right)_{1}=\operatorname{Aut}(H, S)$. Since $X_{N}$ is connected and $\operatorname{Aut}(H, S)$ acts faithfully on $S$ we conclude that $\operatorname{Aut}\left(X_{N}\right)_{1} \leq S_{4}$. Moreover $S=\left\{x, x^{-1}, y, y^{-1}\right\}$ where $x$ and $y$ have not the same order. It is easy to see that $\operatorname{Aut}(H, S)$ has no any element of order 3 or 4 . Thus by considering the subgroups of $S_{4}$ we see that $\operatorname{Aut}\left(X_{N}\right)_{1}=1$ or $\mathbb{Z}_{2}$ or $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$. Therefore $\left|\operatorname{Aut}\left(X_{N}\right)\right| \leq 12 p$ and so $|A / K|$ divides $12 p$. By considering the order of $\operatorname{Aut}\left(X_{N}\right)$ we see that $H \leq A / K$ and so $H=T / K$ for some $T \leq A$. Now $|T|=6 p$ and $T$ acts regularly on $V(X)$, a contradiction. Thus we may suppose that $X_{N}$ is not normal. If $X_{N}$ is not primitive then by [17, Theorem 3.1] we see that the valency of $X_{N}$ is not equal to 4 . Also if $X_{N}$ is primitive then again by [34, Lemma 2.1] we have a contradiction. Therefore $X_{N}$ is a Cayley graph on $\mathbb{Z}_{3 p}$.

Thus $X_{N}$ is a circulant graph and $X_{N}=\operatorname{Cay}(H, S)$, where $S=\left\{a^{i}, a^{-i}, a^{j}, a^{-j}\right\}$ and either $(i, 3 p)=1$ or $(j, 3 p)=1$ or $(i-j, 3 p)=1$. Set $B=\operatorname{Aut}\left(X_{N}\right)$ and $Y=X_{N}$. Let $B_{1}^{*}$ be the subgroup of $B_{1}$ which fixes $\{1\} \cup S$ and $Y_{2}(1)$ be the subgraph of $Y$ with vertex set $\{1\} \cup S \cup\left(S^{2}-(1 \cup S)\right)$. We see that

$$
S^{2}-(1 \cup S)=\left\{a^{2 i}, a^{i+j}, a^{i-j}, a^{-2 i}, a^{-i+j}, a^{-i-j}, a^{2 j}, a^{-2 j}\right\} .
$$

Also

$$
N_{Y}\left(a^{i}\right)=\left\{1, a^{2 i}, a^{i+j}, a^{i-j}\right\}, N_{Y}\left(a^{-i}\right)=\left\{1, a^{-2 i}, a^{-i+j}, a^{-i-j}\right\}, N_{Y}\left(a^{j}\right)=\left\{1, a^{i+j}, a^{-i+j}, a^{2 j}\right\}
$$

and $N_{Y}\left(a^{-j}\right)=\left\{1, a^{i-j}, a^{-i-j}, a^{-2 j}\right\}$. By a tedious computation we have $B_{1}^{*}=1$ and $B_{1}$ has no any element of order 4 . Thus $B_{1}$ acts faithfully on $S$ and so $B_{1} \leq S_{4}$. Since $B_{1}$ has no any element of order 3 , and the fact that $\alpha: a \rightarrow a^{-1}$ is an element of $\operatorname{Aut}(H, S)$ and $o(\alpha)=2$, it implies that $B_{1} \cong \mathbb{Z}_{2}$ or $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$ and so $\left|\operatorname{Aut}\left(X_{N}\right)\right| \in\{6 p, 12 p\}$. Since $A / N$ acts transitively on $V(Y)$ we have that $3 p$ divides $|A / N|$. Thus $|A / N| \in\{3 p, 6 p, 12 p\}$. By considering the order of $B$, we see that $H \leq A / N$ and so $H=T / N$ where $T \leq A$. Now by Proposition [5, $X$ is a Cayley graph, a contradiction.

Now suppose that $N$ is an elementary abelian 3-group and $\Omega=\left\{\Delta_{0}, \Delta_{1}, \Delta_{2}, \cdots, \Delta_{2 p-1}\right\}$, where the subscripts are taken modulo $2 p$. Then $X_{N}$ has order $2 p$ and so $X_{N}$ has valency 2,3 or 4 . First suppose that $X_{N}$ has valency 2 . Then $X_{N} \cong C_{2 p}$ and $\operatorname{Aut}\left(X_{N}\right) \cong D_{4 p}$. Suppose that $\Delta_{i} \sim \Delta_{i+1}$ in $X_{N}$. If $\Delta_{i}$ has an edge then by considering the valency of $X$ we see that $N$ acts faithfully on $X\left[\Delta_{i}\right]$. Hence $|N|=3$ and by considering the valency of $X$ we see that $X\left[\Delta_{i-1} \cup \Delta_{i}\right] \cong 3 K_{2},\left|K_{v}\right| \leq 2$ and $|K| \leq 6$. Since $A / K$ is transitive on $V\left(X_{N}\right)$ it follows that $2 p$ divides $|A / K|$. Hence $A / K \cong \mathbb{Z}_{2 p}$ or $A / K \cong D_{2 p}$ or $A / K \cong D_{4 p}$. If $A / K \cong \mathbb{Z}_{2 p}$ or $A / K \cong D_{4 p}$, then $A / K$ has an element of order $2 p$, say $K \alpha$, where $\alpha \in A$. Therefore $\alpha^{2 p} \in K$ and hence $o\left(\alpha^{2 p}\right)=1,2,3$ or 6 . If $\alpha^{2 p}=1$ then $\langle\alpha\rangle \times\langle\gamma\rangle$, where $\gamma$ is an element of order 3 in $K$, acts transitively and so regularly on $V(X)$, a contradiction. Also if $o\left(\alpha^{2 p}\right)=2,3$ or 6 then $\alpha^{2}, \alpha^{3}$ and $\alpha^{6}$ have order $2 p$. Thus in each case there is an element of order $2 p$, say $\beta$, in $A$ such that $\langle\beta\rangle \times\langle\gamma\rangle$ acts transitively and so regularly on $V(X)$, a contradiction. Thus we may suppose that $A / K \cong D_{2 p}$. Thus $A / K$ has an element of order $p$, say $K \alpha$. Clearly, $K \alpha$ does not fix any element of $V\left(X_{N}\right)$ and so $\alpha$ does not. Clearly, $\alpha^{p} \in K$ and so $o\left(\alpha^{p}\right)=1$ or 2 or 3 or 6 . In each case we can find an element of order $p$, say $\beta$ such that $\langle\beta\rangle$ acts semiregularly on $V(X)$. Set $H=\langle\beta\rangle \times\langle\gamma\rangle$, where $\gamma$ is an element of order 3 in $K$, acts semiregularly on $V(X)$ and has two orbits on $V(X)$, which means that $X$ is a bi-Cayley graph over $H \cong \mathbb{Z}_{3 p}$. Then, by Proposition [1, $X \cong X_{3, p, t}$, where $1 \leq t \leq p-1$, and $t^{2} \equiv-1(\bmod p)$.

Suppose that $\Delta_{i}$ has no edge. Then it is easy to see that either $X\left[\Delta_{0} \cup \Delta_{2 p-1}\right]=$ $X\left[\Delta_{i-1} \cup \Delta_{i}\right] \cong C_{6}(1 \leq i \leq 2 p-1)$ or $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong 3 K_{2}(1 \leq i \leq 2 p-1, i$ is odd $)$ and $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong K_{3,3}(0 \leq i \leq 2 p-1, i$ is even $)$.

First suppose that $X\left[\Delta_{0} \cup \Delta_{2 p-1}\right]=X\left[\Delta_{i-1} \cup \Delta_{i}\right] \cong C_{6}(1 \leq i \leq 2 p-1)$. Then we consider the action of $K$ in $X\left[\Delta_{i}\right](0 \leq i \leq 2 p-1)$. Now it is easy to see that $K$ acts faithfully on $X\left[\Delta_{i}\right]$ and so $K \leq S_{3}$. Since $2 p$ divides $|A / K|$ and $|A / K|$ divides $4 p$ with a similar arguments as above we get a contradiction. Now suppose that $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong 3 K_{2}$ ( $1 \leq i \leq 2 p-1, i$ is odd) and $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong K_{3,3}(0 \leq i \leq 2 p-2, i$ is even $)$.

Let $V\left(\Delta_{i}\right)=\left\{a_{i}, b_{i}, c_{i}\right\}(0 \leq i \leq 2 p-1)$. Without loss of generality we may assume that $a_{i} \sim a_{i+1}, b_{i} \sim b_{i+1}$ and $c_{i} \sim c_{i+1}$. Now it is easy to see that $\alpha: a_{i} \mapsto b_{i}, b_{i} \mapsto c_{i}, c_{i} \mapsto a_{i}$ and $\beta: a_{i} \mapsto a_{i+2}, b_{i} \mapsto b_{i+2}, c_{i} \mapsto c_{i+2}$ are automorphisms of $X$ of orders 3 and $p$, respectively, where $(0 \leq i \leq 2 p-1)$. Clearly $\langle\alpha\rangle \times\langle\beta\rangle \cong \mathbb{Z}_{3 p}$ acts semiregularly and has two orbits on $V(X)$. Therefore $X$ is a bi-Cayley graph over the group $\mathbb{Z}_{3 p}$ and again, by Proposition 1, $X=X_{3, p, t}$, where $1 \leq t \leq p-1$ and $t^{2} \equiv-1(\bmod p)$.

Suppose that $X_{N}$ has valency either 3 or 4 . If $\operatorname{Aut}\left(X_{N}\right)$ is primitive then by [18, Corollary 6.6], $p \geq 313,2 p=m^{2}+1$ for some composite integer $m$. Also $\Gamma$ has valency either $\frac{m(m-1)}{2}$ or $\frac{m(m+1)}{2}$, a contradiction. Thus we may suppose that $\operatorname{Aut}\left(X_{N}\right)$ is imprimitive. Now by [21, Theorem], $X_{N}$ is metacirculant. If $X_{N}$ has valency 3 then by [33, Main Theorem], $X_{N}$ is isomorphic to generalized Petersen graph $\operatorname{GP}(p, k)$. By [9, Theorems 1, 2], we see that $\left|\operatorname{Aut}\left(X_{N}\right)\right|=4 p$. If $\Delta_{i}$ has an edge then $X\left[\Delta_{i}\right] \cong C_{3}(0 \leq i \leq 2 p-1)$. We see that $X_{N}$ can not have valency 3 , a contradiction. Thus we may suppose that $\Delta_{i}$ $(0 \leq i \leq 2 p-1)$ has no edges. Let $V\left(\Delta_{i}\right)=\left\{a_{i}, b_{i}, c_{i}\right\}(0 \leq i \leq 2 p-1)$. Let $\Delta_{i+1}, \Delta_{i+2}$ and $\Delta_{i+3}$ are the vertices adjacent to $\Delta_{i}$. Since $X_{N}$ has valency 3 , we may suppose that $X\left[\Delta_{i} \cup \Delta_{i+1}\right] \cong C_{6}, X\left[\Delta_{i} \cup \Delta_{i+2}\right] \cong 3 K_{2}$ and $X\left[\Delta_{i} \cup \Delta_{i+3}\right] \cong 3 K_{2}$. Now it is easy to see that $\alpha: a_{i} \mapsto b_{i}, b_{i} \mapsto c_{i}, c_{i} \mapsto a_{i}$ is an automorphisms of $X$ of order 3 . Also $K$ acts faithfully on $X\left[\Delta_{i}\right]$ and so $K=N \cong \mathbb{Z}_{3}$. By [1, Theorem 1.1], we see that the generalized Petersen graph is a normal bi-Cayley graph on $H=\mathbb{Z}_{p}$. Clearly, $H$ acts semiregularly on $V\left(X_{N}\right)$. If $H$ is not a subgroup of $A / K$ then $p^{2}| | \operatorname{Aut}\left(X_{N}\right) \mid$, a contradiction. Thus $H \leq A / K$ and $A / K$ has a semiregular element of order $p$, say $K \alpha$. Now $\alpha^{p} \in K$ and so $o\left(\alpha^{p}\right)=1,2$ or 3 . In each case it is easy to find an element of order $p$, say $\beta$, which is a power of $\alpha$. If $\beta$ fixes an element then it is easy to see that $K \alpha$ or $K \alpha^{2}$ or $K \alpha^{3}$ fixes at least one $\Delta_{i}$, a contradiction. Now $\langle\beta\rangle \times\langle\gamma\rangle \cong \mathbb{Z}_{3 p}$ acts semiregularly and has two orbits on $V(X)$ where $\gamma \in K$ and $O(\gamma)=3$. Therefore $X$ is a bi-Cayley graph over group $\mathbb{Z}_{3 p}$ and by Proposition प, $X=X_{3, p, t}$, where $1 \leq t \leq p-1$ and $t^{2} \equiv-1(\bmod p)$. Also if $X_{N}$ has valency 4 then $N=K$. Since $A_{v}$ is $\{2,3\}$-group we conclude that $A$ has a semiregular element of order $p$, say $\delta$. Since $N_{A}(N) / C_{A}(N)$ is a subgroup of $\operatorname{Aut}(N) \cong \mathbb{Z}_{2}$ we conclude
that $\delta$ or $\delta^{2} \in C_{A}(N)$. Also if $N=\langle\gamma\rangle$ then $\langle\delta, \gamma\rangle$ or $\left\langle\delta^{2}, \gamma\right\rangle$ is a semiregular subgroup of $\operatorname{Aut}(X)$ which is isomorphic to $\mathbb{Z}_{3 p}$. Thus $X$ is a bi-Cayley graph over $H \cong \mathbb{Z}_{3 p}=\langle a\rangle$ and by Proposition 1 , $X=X_{3, p, t}$, where $1 \leq t \leq p-1$ and $t^{2} \equiv-1(\bmod p)$.

Finally, suppose that $N$ is an elementary abelian $p$-group. By considering the order of $A$ we see that $|N|=p$. Suppose that $N_{v} \neq 1$ for some $v \in V(X)$ and $w$ is an another arbitrary vertex of $X$. Since $X$ is transitive, there exists $\alpha \in \operatorname{Aut}(X)$ such that $w^{\alpha}=v$ and so $N_{v}=N_{w^{\alpha}}=\alpha^{-1} N_{w} \alpha=N_{w}$. Thus $N$ is trivial, a contradiction. Therefore $N$ acts semiregularly on $V(X)$ and so $X$ is an $N$-regular cover of $X_{N}$. By [26, Page 173] we know that $X_{N}$ is a Cayley graph. Thus $\operatorname{Aut}\left(X_{N}\right)$ has a subgroup which acts regularly on $V(X)$, say $G$. Suppose that $\tilde{G}$ is a lift of $G$. Now it is easy to see that $\tilde{G}$ acts regularly on $V(X)$ and so $X$ is a Cayley graph, a contradiction.

Case II. $A$ is not solvable.
Let $L=\operatorname{Sol}(A)$ be the solvable radical of $A$ and $\Omega$ be the set of orbits of $L$ on $V(X)$. First suppose that $L$ is not trivial. Let $K$ be the kernel of $A$ on $\Omega$. Since $K_{v}$ is a $\{2,3\}$-group it implies that $K_{v}$ is solvable and so by considering $K=L K_{v}$ we see that $K$ is solvable. Now by the definition of $L$ we conclude that $K=L$ and $A / L \leq \operatorname{Aut}\left(X_{L}\right)$. If $\operatorname{deg}\left(X_{L}\right)=0$ then $A / L$ is solvable and so $A$ is solvable, a contradiction. Also if $\operatorname{deg}\left(X_{L}\right)=2$ then $\operatorname{Aut}\left(X_{L}\right) \cong D_{2 n}$, where $\left|V\left(X_{L}\right)\right|=n$ and $n \in\{3,6, p, 2 p, 3 p\}$. Now $A / L$ is solvable and so $A$ is solvable, a contradiction. Thus we may suppose that $\operatorname{deg}\left(X_{L}\right)=3$ or 4 . If $\operatorname{deg}\left(X_{L}\right)=3$ then $n \in\{6,2 p, 3 p\}$. By [16, Theorem 1.1], we see that $\operatorname{Aut}\left(X_{L}\right)$ is solvable and so $A / L$ is solvable. Now $A$ is solvable, a contradiction. Also if $\operatorname{deg}\left(X_{L}\right)=4$ then $L=K$ and $K$ acts faithfully on each orbits of $K$. Moreover, in this case $n \in\{6, p, 2 p, 3 p\}$. If $n=6$, then $X_{L}$ is isomorphic to the octahedral graph and so $\left|\operatorname{Aut}\left(X_{L}\right)\right|=48$. Thus $\operatorname{Aut}\left(X_{L}\right)$ is solvable which implies that $A$ is solvable, a contradiction. If $n=p$ then by $|V(X)|=|L| n$ we see that $|L|=6$ and $L \cong S_{3}$ or $\mathbb{Z}_{6}$. Also since $A_{v}$ is a $\{2,3\}$-group, it implies that $A$ has a semiregular element of order $p$, say $\alpha$. If $L$ as subgroup of $S_{6}$ is isomorphic to $S_{3}$ then since $L$ is semiregular we conclude that $S_{3} \times\langle\alpha\rangle$ acts regularly on $V(X)$, a contradiction. Similarly if $L$ as subgroup of $S_{6}$ is isomorphic to $\mathbb{Z}_{6}=\langle\beta\rangle$ then $\langle\alpha\rangle \times\langle\beta\rangle$ acts regularly on $V(X)$, a contradiction. Also if $\left|V\left(X_{L}\right)\right|=2 p$ then $|L|=3$. Since $A_{v}$ is $\{2,3\}$-group we conclude that $A$ has a semiregular element, say $\alpha$, of order $p$. Since $N_{A}(L) / C_{A}(L)$ is a subgroup of $\operatorname{Aut}(L)$ we conclude that $\alpha \in C_{A}(L)$. Also if $\beta \in L$ and $\beta$ has order 3 then $\langle\alpha, \beta\rangle$ is a semiregular subgroup of $\operatorname{Aut}(X)$ which is isomorphic to $\mathbb{Z}_{3 p}$. Thus $X$ is a bi-Cayley graph over $H$, where $H \cong \mathbb{Z}_{3 p}$. By Proposition 11 $X=X_{3, p, t}$, where $1 \leq t \leq p-1$ and $t^{2} \equiv-1(\bmod p)$. Finally if $\left|V\left(X_{L}\right)\right|=3 p$ then $|L|=2$. By Proposition 6, $X_{N}$ is a Cayley graph, unless the case where $X_{N}$ is isomorphic to the line graph of the Petersen graph. Since $p \geq 11$, it follows that $X_{N}$ is
not isomorphic to the line graph of the Petersen graph. Also if $X_{N}$ is a Cayley graph then $\operatorname{Aut}\left(X_{N}\right)$ has a subgroup say $H$ which acts regularly on $V\left(X_{N}\right)$. Thus $|H|=3 p$ and by [21, Proposition 1.2], $X_{N}$ is a (3,p)-metacirculant graph. Thus $X_{N}$ has an automorphism $\sigma$ of order $p$ such that $\langle\sigma\rangle$ is semiregular on the vertex set of $X_{N}$, and an automorphism $\tau$ normalizing $\langle\sigma\rangle$ and cyclically permuting the 3 orbits of $\langle\sigma\rangle$ such that $\tau$ has a cycle of size 3 in its cycle decomposition. Thus $\left\langle\sigma, \tau^{i}\right\rangle$ for some positive integer $i$, has order $3 p$ and acts regularly on $V\left(X_{N}\right)$. Therefore we may suppose that $X_{N}=\operatorname{Cay}(H, S)$. First suppose that $H=\left\langle\sigma, \tau^{i}\right\rangle \cong F_{3 p}$. If $X_{N}$ is normal then $\operatorname{Aut}\left(X_{N}\right)_{1}=\operatorname{Aut}(H, S)$. Since $\operatorname{Aut}(H, S)$ acts faithfully on $S$ we conclude that $\operatorname{Aut}\left(X_{N}\right)_{1} \leq S_{4}$. Also since $X_{N}$ is connected we conclude that $S=\left\{x, x^{-1}, y, y^{-1}\right\}$ and $x$ and $y$ have not the same orders. Now it is easy to see that $\operatorname{Aut}(H, S)$ has no any element of order 3 or 4 . Thus by considering the subgroups of $S_{4}$ we see that $\operatorname{Aut}\left(X_{N}\right)_{1}=1$ or $\mathbb{Z}_{2}$ or $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$. Therefore $\left|\operatorname{Aut}\left(X_{N}\right)\right| \leq 12 p$ and so $|A / K|$ divides $12 p$. Now by considering the order of $\operatorname{Aut}\left(X_{N}\right)$ we see that $H \leq A / K$ and so $H=T / K$ for some $T \leq A$. Now $|T|=6 p$ and $T$ acts regularly on $V(X)$, a contradiction. Thus we may suppose that $X_{N}$ is not normal. If $X_{N}$ is not primitive then by [17, Theorem 3.1] we see that the valency of $X_{N}$ is not equal to 4 . Also if $X_{N}$ is primitive then again by 34, Lemma 2.1] we have a contradiction. Therefore $X_{N}$ is a Cayley graph on $\mathbb{Z}_{3 p}$. Now similar to the case where $A$ is solvable, we conclude that $X$ is a Cayley graph, a contradiction.

Suppose that $L$ is trivial. By considering the order of $A$, we see that $N$ is a $K_{3}$-group. Since $p \geq 11$, it follows that $N \cong \operatorname{PSL}_{2}(17)$ or $\mathrm{PSL}_{3}(3)$. If $N$ has more than two orbits then $n \in\{3,6,2 p, 3 p\}$. First assume that $n=2 p$ or $3 p$. We know that $A / K$ acts transitively on $V\left(X_{N}\right)$ and $K=K_{\alpha} N$, where $v \in V(X)$. Thus $p^{2}$ divides $|A|$, a contradiction. Thus we may suppose that $n=3$ or 6 . By using GAP [10], it is easy to see that $\mathrm{PSL}_{2}(17)$ and $\mathrm{PSL}_{3}(3)$ does not have any orbit of order $p$ or $2 p$, where $p \in\{13,17\}$. Therefore $N$ has at most two orbits. Now $\operatorname{Aut}\left(X_{N}\right)$ is solvable and so $A / K$ is solvable. Also since $K_{v}$ is $\{2,3\}$ group and $K=K_{v} N$, it follows that $K / N$ is solvable. Since $A / K \cong(A / N) /(K / N)$ we conclude that $A / N$ is also solvable. Suppose that $M$ is another minimal normal subgroup of $A$. Thus by the fact that $M N / N \cong M /(M \cap N) \leq A / N$ we see that $M /(M \cap N)$ is solvable. But $M \cap N=1$ and so $M$ is solvable, a contradiction. Hence $N$ is the only minimal normal subgroup of $A$. Since $|A|$ is not divisible by $p^{2}$ we conclude that $N$ is a simple group. Therefore $A$ is an almost simple group and $\operatorname{soc}(A)=N$. Since $A$ is $\{2,3, p\}$ group, it follows that $N$ is a $K_{3}$-group. Also since $p \geq 11$ we conclude that $N \cong \operatorname{PSL}_{2}(17)$ or $N \cong \operatorname{PSL}_{3}(3)$.

First assume that $N \cong \mathrm{PSL}_{2}(17)$. Then $A \cong \mathrm{PSL}_{2}(17)$ or $\mathrm{PGL}_{2}(17)$. If $A \cong \mathrm{PSL}_{2}(17)$ then $\left|A: A_{v}\right|=102$. By [7], we see that $A$ has two subgroups of index 102 and both of them have an element of order 4. Also we see that $A_{v}$ acts transitively on the set of
vertices adjacent to $v$. By Proposition 3, $X$ is a symmetric graph. If $X$ is one-regular then $|A|=2^{3} .3 .17$, a contradiction. By [2, Theorem 1], we see that $X \cong C_{3 p}\left[2 K_{1}\right]$ and so $X$ is a Cayley graph, a contradiction. Also if $A \cong \mathrm{PGL}_{2}(17)$ then by using GAP [10], $A$ has no any subgroup of index 102, a contradiction.

Assume that $N \cong \operatorname{PSL}_{3}(3)$. Then $A \cong \operatorname{PSL}_{3}(3)$ or $A=\operatorname{Aut}\left(\mathrm{PSL}_{3}(3)\right)$. Let $A=$ $\operatorname{Aut}\left(\mathrm{PSL}_{3}(3)\right)$. Since $A \leq S_{78}$ is a transitive permutation group of degree 78, there exists a core-free subgroup $H$ of $A$ of index 78 such that $A$ is isomorphic to the permutation representation of the action of $A$ on the right cosets of $H$ in $G$ by right multiplication. One can check, by using GAP [10], that in this case $A$ has a regular subgroup of order 78 which means that $X$ is a Cayley graph, a contradiction. Hence $A=\operatorname{PSL}_{3}(3)$ and $X=\operatorname{Cos}\left(\operatorname{PSL}_{3}(3), H, D\right)$, is a coset graph, where $H \cong\left(\mathbb{Z}_{3} \times \mathbb{Z}_{3}\right) \rtimes Q_{8}$ and $D$ is a union of double cosets of $H$ in $G$. Since $X$ is 4 -valent, we have $|D| /|H|=4$. By using GAP [10], there are 15 possibilities for $D$ and in each case $\langle D\rangle$ is a proper subgroup of $\mathrm{PSL}_{3}(3)$ which means that $X$ is disconnected, a contradiction. This complete the proof.
