# ON $S$-1-ABSORBING PRIMARY SUBMODULES

#### Abstract

In this work, we introduce the notion of $S$-1-absorbing primary submodule as an extension of 1 -absorbing primary submodule. Let $S$ be a multiplicatively closed subset of a ring $R$ and $M$ be an $R$-module. A submodule $N$ of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$ is said to be $S$-1-absorbing primary if whenever $a b m \in N$ for some non-unit $a, b \in R$ and $m \in M$, then either $s a b \in\left(N:_{R} M\right)$ or $s m \in M-\operatorname{rad}(N)$. We examine several properties of this concept and provide some characterizations. In addition, $S$-1-absorbing primary avoidance theorem and $S$-1-absorbing primary property for idealization and amalgamation are presented.


## 1. Introduction

In this article, we assume all rings are commutative with non-zero identity and all modules are unital. We will start with certain definitions and notations that will be used throughout the paper. Let $I$ be an ideal of a ring $R$ and $K, L$ be two submodules of $R$-module $M$. The residual $K$ by $L$ and $I$ is defined as $\left(K:_{R} L\right)=$ $\{r \in R \mid r L \subseteq K\}$ and $\left(K:_{M} I\right)=\{m \in M \mid I m \subseteq K\}$, respectively. If $I$ is a principal ideal of $R$ generated by an element $r \in R$, then ( $K:_{M} r$ ) is preferred instead of $\left(K:_{M} R r\right)$. By $M-r a d(N)$, we denote the $M$-radical of $N$ which is the intersection of all prime submodules containing the submodule $N$.

Consider a multiplicatively closed subset $S$ of a ring $R$. Recently, $S$-versions and their features of prime and primary ideals have been thoroughly researched in various studies. Moreover, absorbing-types of such ideals have been proposed and investigated. From the literature, we have gathered the following definitions that we are interested in:
(1) A submodule $N$ of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$ is said to be $S$-1-absorbing prime, if there exists a fixed element $s \in S$ whenever $a b m \in N$ for some non-unit elements $a, b \in R$ and $m \in M$, then $s a b \in\left(N:_{R} M\right)$ or $s m \in N$, 16.
(2) A proper ideal $I$ of $R$ is called 1-absorbing primary if whenever $a b c \in I$ for some non-unit $a, b, c \in R$, then either $a b \in I$ or $c \in \sqrt{I}, ~ 7]$.
(3) A proper submodule $N$ of $M$ is called 1-absorbing primary if whenever $a b m \in N$ for some non-unit $a, b \in R$ and $m \in M$, then either $a b \in\left(N:_{R} M\right)$ or $m \in M-\operatorname{rad}(N)$, [27].

[^0](4) A submodule $N$ of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$ is said to be $S$-primary, if there exists a fixed element $s \in S$ such that whenever $a m \in N$ for some $a \in R$ and $m \in M$, then $s a \in \sqrt{\left(N:_{R} M\right)}$ or $s m \in N$, 3].
(5) A submodule $N$ of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$ is said to be $S$-2-absorbing primary, if there exists a fixed element $s \in S$ such that whenever $a b m \in N$ for some $a, b \in R$ and $m \in M$, then sam $\in N$ or $\operatorname{sbm} \in N$ or $s a b \in$ $\left.\sqrt{\left(N:_{R} M\right)}, ~ 24\right]$.
Our purpose in this paper is to extend the notion of $S$-1-absorbing primary ideals and introduce the concept of $S$-1-absorbing primary submodules. This study is composed of five sections; in the second section, the concept of $S-1$-absorbing primary submodule is defined and examined in detail. Several characterizations of $S$-1-absorbing primary submodules are also presented. We exemplify the differences between $S$-1-absorbing primary and $S$-1-absorbing prime submodules, as well as 1-absorbing primary submodules. We provide some theorems to examine the relations between $S$-1-absorbing primary submodules and the other notions such as $S$-primary and 1 -absorbing primary submodules.

In [20], it has been proposed and investigated the prime avoidance theorem for modules. This theorem says that if a submodule $N$ of $M$ is contained in a union of finitely many prime submodules $P_{i}$ 's with $\left(P_{j}: M\right) \nsubseteq\left(P_{k}: M\right)$ whenever $j \neq k$, then $N$ is contained in $P_{i}$ for some $i$. This theorem has also been extended to primary submodules in various ways [4, 13]. In the third section, we provide $S$ 1 -absorbing primary avoidance theorem under the assumption that $M$ is finitely generated multiplication.

In section 4, we examine the $S-1-$ absorbing primary property for idealization of $M$ in $R$. The idealization of $M$ in $R$ is the ring $R(+) M=\{(r, m) \mid r \in R, m \in$ $M\}$ with component-wise addition and multiplication defined as $\left(r_{1}, m_{1}\right)\left(r_{2}, m_{2}\right)=$ $\left(r_{1} r_{2}, r_{1} m_{2}+r_{2} m_{1}\right)$. For more information and the ideal structure of an idealization of $M$, the reader may see [2].

Let $(A, B)$ be a pair of commutative rings with unity, $f: A \rightarrow B$ be a ring homomorphism and $J$ be an ideal of $B$. In this setting, we can consider the following subring of $A \times B$ :

$$
A \bowtie^{f} J:=\{(a, f(a)+j) \mid a \in A, j \in J\}
$$

called the amalgamation of $A$ with $B$ along $J$ with respect to $f$. This construction is defined and examined by D'Anna et al. 11] and then extensively investigated in different papers [12, 25, 15]. In the last section, we study $S$-1-absorbing primary ideals of the amalgamation $A \bowtie^{f} J$.

## 2. Characterization of $S$-1-ABSORBING Primary submodules

Definition 1. Let $S$ be a multiplicatively closed subset of a ring $R$ and $M$ an $R$ module. We call a submodule $N$ of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$ an $S-1$-absorbing primary if there exists an (fixed) $s \in S$ such that for all non-unit $a, b \in R$ and $m \in M$ if abm $\in N$, then either $\operatorname{sab} \in\left(N:_{R} M\right)$ or $s m \in M-\operatorname{rad}(N)$. This fixed element $s \in S$ is called an $S$-element of $N$.

In particular, if one take $M=R$ as an $R$-module, then we have the definition of $S$-1-absorbing primary ideal of $R$ as following:
Definition 2. Let $S$ be a multiplicatively closed subset of a ring $R$. We call a proper ideal $I$ of $R$ with $I \cap S=\emptyset$ an $S-1$-absorbing primary if there exists an
(fixed) $s \in S$ such that whenever abc $\in I$ for some non-unit $a, b, c \in R$, then either sab $\in I$ or $s c \in \sqrt{I}$. This fixed element $s \in S$ is called an $S$-element of $I$.

Let $N$ be a proper submodule of $M$. It is clear that any $S$-1-absorbing prime submodule is a $S$-1-absorbing primary submodule and that two concepts coincide if $M-\operatorname{rad}(N)=N$. However, this implication is not reversible in general, see the following example.

Example 1. (S-1-absorbing primary submodule that is not $S$-1-absorbing prime) Consider the $\mathbb{Z}$-module $M=\mathbb{Z} \times \mathbb{Z}$ and the submodule $N=3 \mathbb{Z} \times 8 \mathbb{Z}$ of M. For the multiplicatively closed subset $S=\left\{3^{n}: n>0\right\}, N$ is an $S$-1-absorbing primary submodule which is not $S$-1-absorbing prime.

Proof. Suppose that $a b\left(m_{1}, m_{2}\right) \in N$ for some integers $m_{1}, m_{2}$ and $a, b \neq \pm 1$. If $m_{2}$ is even, then $s m \in 3 \mathbb{Z} \times 2 \mathbb{Z}=M-\operatorname{rad}(N)$ for all $s \in S$. If $m_{2}$ is odd, then since $a b m_{2} \in 8 \mathbb{Z}$, we conclude that $a b \in 8 \mathbb{Z}$, and so $s a b \in 24 \mathbb{Z}=\left(N:_{R} M\right)$ for all $s \in S$. Thus $N$ is an $S$-1-absorbing primary submodule. As $2 \cdot 3 \cdot(1,4) \in N$ but neither $6 s \in\left(N:_{R} M\right)=24 \mathbb{Z}$ nor $s(1,4) \in N$ for any $s \in S, N$ is not $S$-1-absorbing prime.

Let $S$ be a multiplicatively closed subset of a ring $R$. In the following proposition, by $S^{*}$, we denote the saturation set of $S$ defined by $\left\{r \in R: \frac{r}{1} \in U\left(S^{-1} R\right)\right\}$. It is clear that $S \subseteq S^{*}$ and $S^{*}$ is also a multiplicatively closed subset of $R$. In case of $S=S^{*}$, then $S$ is said to be a saturated set, [17]. For an $R$-module $M$, by $U_{M}(R)$, we denote the set $\{r \in R: r M=M\}$ which contains $U(R)$ is a saturated multiplicatively closed subset of $R$.

Proposition 1. Let $S$ be a multiplicatively closed subset of a ring $R$, and $N$ be $a$ submodule of an $R$-module $M$.
(1) Let $T \subseteq S$ be two multiplicatively closed subsets of $R$. If $N$ is an $T$-1absorbing primary submodule such that $\left(N:_{R} M\right) \cap S=\emptyset$, then $N$ is also an $S$-1-absorbing primary submodule. Conversely, if for each $s \in S$, there is an element $s^{\prime} \in T$ such that $s s^{\prime} \in T$ and $N$ is a $S$-1-absorbing primary submodule of $M$, then $N$ is an $T$-1-absorbing primary submodule of $M$.
(2) Every 1-absorbing primary submodule $N$ with $\left(N:_{R} M\right) \cap S=\emptyset$, is $S$-1absorbing primary. However, it is clear that these two classes of 1-absorbing primary and $S$-1-absorbing primary submodules coincide if $S \subseteq U(R)$.
(3) $N$ is an $S$-1-absorbing primary submodule of $M$ if and only if $N$ is $S^{\star}$-1absorbing primary.
(4) Suppose that $M=R m$ is a cyclic $R$-module and $S \subseteq U_{M}(R)$. Then $N$ is a 1-absorbing primary submodule if and only if $N$ is an $S$-1-absorbing primary submodule.

Proof. (1) It is clear.
(2) The claim follows by taking $T=\{1\}$ in (1).
(3) Suppose that $N$ is $S$-1-absorbing primary submodule. It is clear that ( $N:_{R}$ $M) \cap S^{*}=\emptyset$. Since $S \subseteq S^{\star}$, then by (1), $N$ is $S^{\star}$-1-absorbing primary. For the converse, let $a b m \in N$ for some non-unit elements $a, b \in R$ and $m \in M$. Since $N$ is an $S^{\star}$-1-absorbing primary submodule, there exists an $s \in S^{\star}$ such that sab $\in\left(N:_{R} M\right)$ or $s m \in M-\operatorname{rad}(N)$. Since $\frac{s}{1}$ is a unit of $S^{-1} R$, sur $\in S$ for
some $u \in S$ and $r \in R$. Say $t:=s u r \in S$. Hence, we conclude $t m \in M-r a d(N)$ or $t a b \in\left(N:_{R} M\right)$, as needed.
(4) Suppose that $N$ is an $S$-1-absorbing primary submodule. Let $a b m^{\prime} \in N$ for some non-unit $a, b \in R$ and $m^{\prime}=r m \in M$. Then there exists an $s \in S$ such that $s a b \in\left(N:_{R} M\right)$ or $\operatorname{srm} \in M-\operatorname{rad}(N)$. If $\operatorname{srm} \in M-\operatorname{rad}(N)$, then since $S \subseteq U_{M}(R)$ we have $s r R m=r M \subseteq M-\operatorname{rad}(N)$ which implies $m^{\prime}=r m \in M-\operatorname{rad}(N)$. If $s a b \in\left(N:_{R} M\right)$, then since $M$ is a multiplication module and $S \subseteq U_{M}(R)$, we conclude $a b M=\operatorname{sab} M \subseteq\left(N:_{R} M\right) M \subseteq M-\operatorname{rad}(N)$. Thus, $N$ is a 1-absorbing primary submodule. The converse part follows from (2).

Example 2. (S-1-absorbing primary submodule that is not 1-absorbing primary) Consider the multiplicatively closed subset $S=\left\{2^{k} 3^{t}: k, t \geq 0\right\}$ of $\mathbb{Z}$. Then the $\mathbb{Z}$-submodule $N=(0)$ of $M=\mathbb{Q} \times \mathbb{Z}_{2} \times \mathbb{Z}_{3}$ is an $S$-1-absorbing primary submodule which is not 1-absorbing primary.

Proof. Suppose that $a b\left(\frac{c}{d}, \bar{x}, \bar{y}\right) \in N$ for some $\pm 1 \neq a, b \in \mathbb{Z}$ and $\left(\frac{c}{d}, \bar{x}, \bar{y}\right) \in M$. Consider the element $6 \in S$. Here, $a b c=0$ which implies $a=0$ or $b=0$ or $c=0$. If $a=0$ or $b=0$, then clearly $s a b \in(N: \mathbb{Z} M)$. If $c=0$, then $6\left(\frac{c}{d}, \bar{x}, \bar{y}\right)=(0, \overline{0}, \overline{0}) \in$ $M-\operatorname{rad}(N)=(0)$, and thus $N$ is an $S$-1-absorbing primary submodule. However, it is not 1 -absorbing primary as $2 \cdot 3 \cdot(0, \overline{1}, \overline{1}) \in N$ but neither $2 \cdot 3 \in(N: \mathbb{Z} M)=0$ $\operatorname{nor}(0, \overline{1}, \overline{1}) \in M-\operatorname{rad}(N)=(0)$.

Theorem 1. Let $S$ be a multiplicatively closed subset of a ring R. For a submodule $N$ of an $R$-module $M$ satisfying $\left(N:_{R} M\right) \cap S=\emptyset$, the following are equivalent.
(1) $N$ is an $S$-1-absorbing primary submodule of $M$.
(2) There exists an $s \in S$ such that whenever $I b m \subseteq N$ for some proper ideal $I$ of $R, b \in R \backslash U(R)$ and $m \in M$ implies either $s I b \subseteq\left(N:_{R} M\right)$ or $s m \in M$ $\operatorname{rad}(N)$.
(3) There exists an $s \in S$ such that whenever $I J m \subseteq N$ for some proper ideals $I, J$ of $R$ and $m \in M$ implies either $s I J \subseteq\left(N:_{R} M\right)$ or $s m \in M-\operatorname{rad}(N)$.
(4) There exists an $s \in S$ such that whenever $I J K \subseteq N$ for some proper ideals $I, J$ of $R$ and a submodule $K$ of $M$ implies either $s I J \subseteq\left(N:_{R} M\right)$ or $s K \subseteq M-\operatorname{rad}(N)$.

Proof. (1) $\Rightarrow(2)$. Let $s$ be an $S$-element of $N$. Suppose that $I b m \subseteq N$ and $s I b \nsubseteq$ $\left(N:_{R} M\right)$. Then $s x b \notin\left(N:_{R} M\right)$ for some non-unit $x \in I$. Since $x b m \in N$ and $s x b \notin\left(N:_{R} M\right)$, we have $s m \in M-\operatorname{rad}(N)$, as needed.
$(2) \Rightarrow(3)$. Let $s$ be the fixed element in (2). Suppose that $I J m \subseteq N$ but $s I J \nsubseteq$ $\left(N:_{R} M\right)$ for some proper ideals $I, J$ of $R$ and $m \in M$. Then $s I b \notin\left(N:_{R} M\right)$ for some non-unit $b \in J$. From our assumption (2), we conclude $s m \in M-\operatorname{rad}(N)$.
$(3) \Rightarrow(4)$. Let $s$ be the fixed element in (3). Suppose $I J K \subseteq N$ but $s K \nsubseteq N$ for some proper ideals $I, J$ of $R$ and a submodule $K$ of $M$. Hence $\operatorname{sm} \notin M-\operatorname{rad}(N)$ for some $m \in K$ which implies $s I J \subseteq\left(N:_{R} M\right)$ by (3).
$(4) \Rightarrow(1)$. Let $a, b \in R$ be non-unit elements, $m \in M$ and $a b m \in N$. Put $I=a R$, $J=b R$ and $K=R m$ in (4), then we are done.

In the following, we characterize $S$-1-absorbing primary ideals of a ring $R$ by taking $M=R$ as an $R$-module in Theorem 1 .
Theorem 2. Let $S$ be a multiplicatively closed subset of $a$ ring $R$ and $I$ an ideal of $R$ with $I \cap S=\emptyset$. Then $I$ is an $S$-1-absorbing primary ideal of $R$ if and only if
there exists an $s \in S$ such that whenever $I_{1} I_{2} I_{3} \subseteq I$ for some proper ideals $I_{1}, I_{2}$ and $I_{3}$ of $R$ implies either $s I_{1} I_{2} \subseteq I$ or $s I_{3} \subseteq \sqrt{I}$.

Recall from [22, Lemma 2.4] that if $M$ is a finitely generated multiplication $R$-module, then $\sqrt{\left(N:_{R} M\right)}=\left(M-\operatorname{rad}(N):_{R} M\right)$ for any submodule $N$ of $M$

Next, we give a characterization for $S$-1-absorbing primary submodules in terms of submodules of a finitely generated multiplication modules.

Theorem 3. Let $S$ be a multiplicatively closed subset of a ring $R$ and $M$ be $a$ finitely generated multiplication $R$-module. A proper submodule $N$ of $M$ with $\left(N:_{R}\right.$ $M) \cap S=\emptyset$ is an $S$-1-absorbing primary submodule of $M$ if and only if there exists an $s \in S$ such that whenever $N_{1} N_{2} N_{3} \subseteq N$ for some proper submodules $N_{1}, N_{2}$, $N_{3}$ of $M$ implies either $s N_{1} N_{2} \subseteq N$ or $s N_{3} \subseteq M-\operatorname{rad}(N)$.
Proof. Suppose that $N_{1} N_{2} N_{3} \subseteq N$ for some proper submodules $N_{1}=I_{1} M, N_{2}=$ $I_{2} M$ and $N_{3}=I_{3} M$ where $I_{1}, I_{2}, I_{3}$ are proper ideals of $R$. Hence $I_{1} I_{2} I_{3} \subseteq$ $\left(N:_{R} M\right)$ and $\left(N:_{R} M\right)$ is a $S$-1-absorbing primary ideal of $R$ by Lemma 4 . This yields that there exists $s \in S$ such that $s I_{1} I_{2} \subseteq\left(N:_{R} M\right)$ or $s I_{3} \subseteq \sqrt{\left(N:_{R} M\right)}$ by Theorem 2. Thus we conclude either $s N_{1} N_{2}=s I J M \subseteq\left(N:_{R} M\right) M=N$ or $s N_{3} \subseteq \sqrt{\left(N:_{R} M\right)} M=M-\operatorname{rad}(N)$, as desired. For the converse, suppose that $I J m \subseteq N$ for some proper ideals $I, J$ of $R$ and $m \in M$. Put $N_{1}=I M, N_{2}=J M$ and $N_{3}=R m$. This follows that $s I J \subseteq\left(N:_{R} M\right)$ or $s m \in s N_{3} \subseteq M-\operatorname{rad}(N)$, thus we are done by Theorem 1

Now, we are ready for a characterization of $S$-1-absorbing primary submodules of finitely generated faithful multiplication modules in terms of presentation ideals of them.

Theorem 4. Let $M$ be a finitely generated faithful multiplication $R$-module and $S$ be a multiplicatively closed subset of $R$. For a submodule $N$ of $M$ provided $\left(N:_{R}\right.$ $M) \cap S=\emptyset$, the following statements are equivalent.
(1) $N$ is a $S$-1-absorbing primary submodule of $M$.
(2) $N=I M$ for some $S$-1-absorbing primary ideal $I$ of $R$.
(3) $\left(N:_{R} M\right)$ is an $S$-1-absorbing primary ideal of $R$.

Proof. (1) $\Rightarrow(2)$. Let $N$ be a $S$-1-absorbing primary submodule of $M$. Then $\left(N:_{R}\right.$ $M)$ is an $S$-1-absorbing primary ideal of $R$ by Proposition 4. Since $M$ is multiplication, put $I=\left(N:_{R} M\right)$, so the claim is clear.
$(2) \Rightarrow(3)$. Since $M$ is cancellation, that is, $I M=J M \Leftrightarrow I=J$ for every ideal $I, J$ of $R$ which means that $\left(N:_{R} M\right)=\left(I M:_{R} M\right)=I$ is an $S$-1-absorbing primary ideal of $R$.
$(3) \Rightarrow(1)$. Suppose that $0 \neq I J K \subseteq N$ for some proper ideals $I, J$ of $R$ and a submodule $K$ of $M$. Since $M$ is a multiplication module, $K=L M$ for some ideal $L$ of $R$. Then we have $I J L M \subseteq\left(N:_{R} M\right)$. We may assume that $L$ is a proper ideal of $R$. Since $\left(N:_{R} M\right)$ is an $S$-1-absorbing primary ideal of $R$, so it is an $S$-1-absorbing primary submodule of an $R$-module $R$ and there exists a fixed $s \in S$ such that $s I J \subseteq\left(N:_{R} M\right)$ or $s L \subseteq \sqrt{\left(N:_{R} M\right)}=\left(M-\operatorname{rad}(N):_{R} M\right)$ by Theorem [2. This yields that $s I J \subseteq\left(N:_{R} M\right)$ or $s K=L M \subseteq M-\operatorname{rad}(N)$ and $N$ is $S$-1-absorbing primary submodule of $M$ by Theorem 1 .

Every $S$-primary submodule of a finitely generated faithful multiplication module is $S$-1-absorbing primary, see the following.

Proposition 2. Let $S$ be a multiplicatively closed subset of a ring $R$ and $M$ be $a$ finitely generated faithful multiplication $R$-module. If $N$ is an $S$-primary submodule of $M$, then it is $S$-1-absorbing primary.

Proof. Let $N$ be an $S$-primary submodule of $M$. Then $\left(N:_{R} M\right)$ is a $S$-primary ideal of $R$ by [3, Proposition 2.11 (1)] and hence $\left(N:_{R} M\right)$ is a $S$-1-absorbing primary ideal of $R$. Thus $N$ is an $S$-1-absorbing primary submodule of $M$ by Theorem 4.

Lemma 1. Let $S$ be a multiplicatively closed subset of $R$. If $I$ is an $S$-1-absorbing primary ideal, then $\sqrt{I}$ is an $S$-prime ideal of $R$.

Proof. Let $s$ be an $S$-element of $I, a, b \in R$ and $a b \in \sqrt{I}$. If $a$ or $b$ is unit, then the claim is clear. So, assume that $a, b$ are non-unit elements. Then $a^{k} b^{k}=a^{t} a^{t} b^{k} \in I$ for some $k=2 t>1$ which implies that $s a^{k} \in I$ or $s b^{k} \in \sqrt{I}$. Thus $s a \in \sqrt{I}$ or $s b \in \sqrt{I}$ and $\sqrt{I}$ is an $S$-prime ideal of $R$.

Proposition 3. Let $S$ be a multiplicatively closed subset of $R$. If $N$ is an $S$-1absorbing primary submodule of $M$, then $M-\operatorname{rad}(N)$ is an $S$-prime submodule of $M$.

Proof. Follows from Theorem 4, Lemma 1 and [26, Proposition 2.9 (2)].
Let $S$ be a multiplicatively closed subset of a ring $R$. Then $S$ is said to satisfy the maximal multiple condition if there exists $s \in S$ such that $t$ divides $s$ for each $t \in S$, [1]. For instance, if $S$ is finite, then $S$ satisfies the maximal multiple condition. Also, $U(R)$ is a multiplicatively closed set satisfying the maximal multiple condition.

Proposition 4. Let $S$ be a multiplicatively closed subset of a ring $R$, and $N$ be $a$ submodule of an $R$-module $M$.
(1) If $N$ is an $S$-1-absorbing primary submodule of $M$, then $S^{-1} N$ is a 1absorbing primary $S^{-1} R$-submodule of $S^{-1} M$.
(2) If $S$ satisfies the maximal multiple condition, and $S^{-1} N$ is a 1-absorbing primary $S^{-1} R$-submodule of $S^{-1} M$, then $N$ is an $S$-1-absorbing primary submodule of $M$.

Proof. (1) Let $\frac{a}{s_{1}}, \frac{b}{s_{2}}$ be non-unit elements of $S^{-1} R$ and $\frac{m}{s_{3}} \in S^{-1} M$ with $\frac{a}{s_{1}} \frac{b}{s_{2}} \frac{m}{s_{3}} \in$ $S^{-1} N$. Then uabm $\in N$ for some $u \in S$. Hence, there exists an $s \in S$ such that suab $\in\left(N:_{R} M\right)$ or $s m \in M-r a d(N)$. This yields either $\frac{a}{s_{1}} \frac{b}{s_{2}}=\frac{s u a b}{s u s_{1} s_{2}} \in S^{-1}\left(N:_{R}\right.$ $M) \subseteq\left(S^{-1} N:_{S^{-1} R} S^{-1} M\right)$ or $\frac{m}{s_{3}}=\frac{s m}{s s_{3}} \in S^{-1}(M-\operatorname{rad}(N))=S^{-1} M-\operatorname{rad}\left(S^{-1} N\right)$ and $S^{-1} N$ is a 1-absorbing primary submodule of $S^{-1} M$.
(2) Let $s_{\max } \in S$ is the element which has the maximal multiple condition. Suppose that $a b m \in N$ for some non-unit elements $a, b \in R$ and $m \in M$. Then $\frac{a}{1} \frac{b}{1} \frac{m}{1} \in S^{-1} N$ which implies $\frac{a}{1} \frac{b}{1} \in\left(S^{-1} N:_{S^{-1} R} S^{-1} M\right) \subseteq S^{-1}\left(N:_{R} M\right)$ or $\frac{m}{1} \in S^{-1} M-\operatorname{rad}\left(S^{-1} N\right)=S^{-1}(M-r a d(N))$. This follows that $u a b \in\left(N:_{R} M\right)$ or $v m \in M-\operatorname{rad}(N)$. Since $u$ and $v$ divide $s_{\max }$, we get $s_{\max } a b \in\left(N:_{R} M\right)$ or $s_{\max } m \in M-\operatorname{rad}(N)$ as needed.

Proposition 5. Let $S$ be a multiplicatively closed subset of $R$, and $M$ be a multiplication $R$-module. If $\left\{N_{i}\right\}_{i=1}^{k}$ is a family of $S$-1-absorbing primary submodules of
$M$ with the same $M$-radical, then $\bigcap_{i=1}^{k} N_{i}$ is also $S$-1-absorbing primary submodule of $M$.
Proof. Let $s_{i} \in S$ be an $S$-element of $N_{i}$ for each $i=1, \ldots, k$. First, note that $\left(\bigcap_{i=1}^{k} N_{i}\right) \cap S=\emptyset$. Put $s=s_{1} s_{2} \ldots s_{k}$. Suppose that $a b m \in \bigcap_{i=1}^{k} N_{i}$ but sab $\notin$ $\left(\bigcap_{i=1}^{k} N_{i}:_{R} M\right)$ for some non-unit elements $a, b \in R$ and $m \in M$. Then $s a b \notin\left(N_{j}:_{R}\right.$ $M$ ) for some $j \in\{1, \ldots, k\}$. Since $N_{j}$ is $S$-1-absorbing primary and $a b m \in N_{j}$, we have $s_{j} m \in M-\operatorname{rad}\left(N_{j}\right)$ and so $s m \in M-\operatorname{rad}\left(N_{j}\right)=M-\operatorname{rad}\left(\bigcap_{i=1}^{k} N_{i}\right)$ by [22, Proposition 2.14 (3)], we are done.

Lemma 2. Let $f: M_{1} \rightarrow M_{2}$ be an $R$-module epimorphism and $S$ a multiplicatively closed subset of $R$.
(1) If $N$ is a submodule of $M_{1}$, then $\left(N:_{R} M_{1}\right) \subseteq\left(f(N):_{R} M_{2}\right)$, 27].
(2) If $K$ is a submodule of $M_{2}$, then $\left(K:_{R} M_{2}\right) \subseteq\left(f^{-1}(K):_{R} M_{1}\right)$, 27].
(3) If $N$ is a submodule of $M_{1}$ and $\operatorname{ker}(f) \subseteq N$, then $f\left(M_{1}-\operatorname{rad}(N)\right)=M_{2^{-}}$ $\operatorname{rad}(f(N)),[19]$.
(4) If $K$ is a submodule of $M_{2}$, then $f^{-1}\left(M_{2}-\operatorname{rad}(K)\right)=M_{1}-\operatorname{rad}\left(f^{-1}(K)\right)$, [19.
Proposition 6. Let $f: M_{1} \rightarrow M_{2}$ be an $R$-module epimorphism and $S$ be $a$ multiplicatively closed subset of $R$.
(1) Suppose that $\left(f(N):_{R} M_{2}\right) \cap S=\emptyset$. If $N$ is an $S$-1-absorbing primary submodule of $M_{1}$ containing $\operatorname{Ker}(f)$, then $f(N)$ is an $S$-1-absorbing primary submodule of $R_{2}$.
(2) If $K$ is an $S$-1-absorbing primary submodule of $M_{2}$, then $f^{-1}(K)$ is an $S$-1-absorbing primary submodule of $M_{1}$.

Proof. (1) Let $a, b$ be non-unit elements of $R$ and $m \in M$ with $a b m \in f(N)$. Say $m=f\left(m_{1}\right)$ for some $m_{1} \in M_{1}$. Since $a b f\left(m_{1}\right) \in f(N)$ and $\operatorname{Ker}(f) \subseteq I$, we have $a b m_{1} \in N$ which implies that there exists an $s \in S$ such that $s a b \in\left(N:_{R} M_{1}\right)$ or $s m \in M_{1}-\operatorname{rad}(N)$. Thus, $s a b \in\left(N:_{R} M_{1}\right) \subseteq f\left((N):_{R} M_{2}\right)$ or $s f(m) \in f(N) \subseteq$ $M_{2}-\operatorname{rad}(f(N))$ by Lemma 2.
(2) First, we show that $\left(f^{-1}(K):_{R} M_{1}\right) \cap S=\emptyset$. Assume that $r \in\left(f^{-1}(K):_{R} M_{1}\right) \cap$ $S$. Then $r M_{1} \subseteq f^{-1}(K)$ implies $r M_{2}=r f\left(M_{1}\right) \subseteq f\left(f^{-1}(K)\right) \subseteq K$, and hence $r \in\left(\begin{array}{ll}K:_{R} & M_{2}\end{array}\right)$, a contradiction. Let $a$ and $b$ be non-unit elements of $R$ and $m \in M_{1}$ with $a b m \in f^{-1}(K)$. Then $a b f(m) \in K$ which implies that there exists $s \in S$ such that $s a b \in\left(K:_{R} M_{2}\right)$ or $s f(m) \in M_{2}-\operatorname{rad}(K)$. Thus, we conclude $s a b \in\left(K:_{R} M_{2}\right) \subseteq\left(f^{-1}(K):_{R} M_{1}\right)$ or $s m \in f^{-1}\left(M_{2}-r a d(K)\right)=M_{1}-r a d\left(f^{-1}(K)\right)$ by Lemma 2. Therefore, $f^{-1}(K)$ is an $S$-1-absorbing primary submodule of $M_{1}$.

As a consequence of Theorem 6] we have the following result.
Corollary 1. Let $S$ be a multiplicatively closed subset of $R$ and $N, K$ be submodules of $R$-module $M$.
(1) Let $K \subseteq N$. Then $N$ is an $S$-1-absorbing primary submodule of $M$ if and only if $N / K$ is an $S$-1-absorbing primary submodule of $M / K$.
(2) If $N$ is an $S$-1-absorbing primary submodule of $M$ with $\left(N:_{R} K\right) \cap S=\emptyset$, then $N \cap K$ is an $S$-1-absorbing primary submodule of $K$.

Proof. (1) It is clear that $\left(N / K:_{R} M / K\right) \cap S=\emptyset$. Consider the canonical epimorphism $\pi: M \rightarrow M / K$ in Proposition 6(1). Then $N / K$ is an $S$-1-absorbing primary submodule of $M / K$. For the converse part, suppose that $a b m \in N$ for some nonunit elements $a$ and $b$ of $R, m \in M$. Hence $a b(m+K) \in N / K$ which yields that there exists a fixed $s \in S$ such that $s a b \in\left(N / K:_{R} M / K\right)$ or $s(m+K) \in M / K$ $\operatorname{rad}(N / K)=M-\operatorname{rad}(N) / K$. Therefore $\operatorname{sab} \in\left(N:_{R} M\right)$ or $\operatorname{sm} \in M-\operatorname{rad}(N)$, so we are done.
(2) Consider that the injection $i: K \rightarrow M$ defined by $i(k)=k$ for all $k \in K$. It is easy to see that $\left(i^{-1}(N): K\right) \cap S=\emptyset$. Then $i^{-1}(N)=N \cap K$ is is an $S$-1-absorbing primary submodule of $K$ by Proposition 6 (2).

Next, we show that if a ring $R$ admits an $S$-1-absorbing primary ideal that is not an $S$-primary ideal, then $R$ is a quasilocal ring. First, recall the following lemma.

Lemma 3. 7] Let $R$ be a ring. Suppose that for every non-unit element $w$ of $R$ and for every unit element $u$ of $R$, we have $w+u$ is a unit element of $R$. Then $R$ is a quasilocal ring.

Theorem 5. Let $R$ be a ring. If there is an S-1-absorbing primary ideal which is not an $S$-primary, then $R$ is a quasilocal ring.
Proof. Let $s^{\prime} \in S$ be an $S$-element of $J$ which is not $S$-primary ideal of $R$. Then there exist non-unit elements $a, b \in R$ with $a b \in J$ satisfying sa $\notin J$ and $s y \notin \sqrt{J}$ for all $s \in S$. Choose $r \in R \backslash U(R)$. Hence $r a b \in J$ which yields $s^{\prime} r a \in J$. We show that $r+u \in U(R)$ for any $u \in U(R)$. Let $u \in U(R)$. Assume that $r+u \in R \backslash U(R)$. Then $(r+u) a b \in J$ and $s^{\prime} y \notin \sqrt{I}$ implies that $s^{\prime}(r+u) a \in I$. Now, since $s^{\prime} r a \in I$, we get $s^{\prime} u a \in I$, and so $s^{\prime} a \in J$, a contradiction. Therefore, $r+u \in U(R)$ and $R$ is a quasilocal ring by Lemma 3

As a direct result of Theorem 5] we have the following corollary.
Corollary 2. Let $I$ be an ideal of a non-quasi local ring $R$ with $I \cap S=\emptyset$. Then $I$ is an $S$-1-absorbing primary ideal of $R$ if and only if $I$ is an $S$-primary ideal of $R$.

Lemma 4. Let $S$ be a multiplicatively closed subset of $R$. If $N$ is an $S$-1-absorbing primary submodule of a finitely generated multiplication $R$-module $M$. Then the following statements hold.
(1) $\left(N:_{R} M\right)$ is an $S$-1-absorbing primary ideal of $R$.
(2) If $\left(N:_{R} m\right) \cap S=\emptyset$ for some $m \in M \backslash \mathfrak{P}$ where $\mathfrak{P}$ is any prime submodule of $M$ containing $N$, then $\left(N:_{R} m\right)$ is an $S$-1-absorbing primary ideal of $R$.
(3) If $\left(\left(N:_{M} r\right):_{R} M\right) \cap S=\emptyset$ for some $r \in R \backslash\left(N:_{R} M\right)$, then $\left(N:_{M} r\right)$ is an $S$-1-absorbing primary submodule of $M$.

Proof. (1) Let $a, b, c \in R \backslash U(R)$ and $a b c \in\left(N:_{R} M\right)$. Then $a b(c M) \subseteq N$ implies that there exists an $s \in S$ such that $\operatorname{sab} \in\left(N:_{R} M\right)$ or $s c M \subseteq M-\operatorname{rad}(N)$ by Theorem [1 Thus we have $s a b \in\left(N:_{R} M\right)$ or $s c \in\left(M-r a d(N):_{R} M\right)=$ $\sqrt{\left(N:_{R} M\right)}$ and $\left(N:_{R} M\right)$ is an $S$-1-absorbing primary ideal of $R$.
(2) Let $a, b, c \in R \backslash U(R)$ and $a b c \in\left(N:_{R} m\right)$. Then we have $a b c m \in N$. As $N$ is an $S$-1-absorbing primary submodule, there exists an $s \in S$ such that sab $\in\left(N:_{R} M\right)$ or $\operatorname{scm} \in M-\operatorname{rad}(N)$. This indicates that $s a b \in\left(N:_{R} m\right)$ or $s c \in\left(M-\operatorname{rad}(N):_{R} m\right)$. For the rest of the proof, we only need to show that (M$\left.\operatorname{rad}(N):_{R} m\right)=\sqrt{\left(N:_{R} m\right)}$. The inclusion $\sqrt{\left(N:_{R} m\right)} \subseteq\left(M-\operatorname{rad}(N):_{R} m\right)$ is satisfied by ([21], Lemma 2.1). For the reverse inclusion, let $a \in\left(M-\operatorname{rad}(N):_{R} m\right)$ which implies $a m \in M-\operatorname{rad}(N)=\bigcap_{N \subseteq P} P$ where $P$ is any prime submodule of $M$ that contains $N$. Since $M$ is multiplication, there exists an ideal $I$ of $R$ such that $N=I M$ and a prime ideal $Q$ of $R$ such that $P=Q M$. It follows that $a m \in \bigcap_{N \subseteq P} P=\bigcap_{I M \subseteq Q M} Q M$. Then, we obtain $a m \in Q M$ for all prime ideals $Q$ containing $I$ by using ([14], Theorem 3.2). This means that $a \in Q$ or $m \in Q M$ for all primes $Q$ containing $I$ by ([14], Lemma 2.10) and hence $a \in \bigcap_{I \subseteq Q} Q=\sqrt{I}$ which implies $a^{n} \in I$ for some $n \in \mathbb{N}$. We conclude that $a^{n} m \in I M=N$, namely $a \in \sqrt{\left(N:_{R} m\right)}$, which completes the proof.
(3) Suppose that $a b m \in\left(N:_{M} r\right)$ for some non-unit $a, b \in R$ and $m \in M$. Then abrm $\in N$ which implies that there exists an $s \in S$ such that $s a b \in\left(N:_{R} M\right) \subseteq$ $\left(\left(N:_{M} r\right):_{R} M\right)$ or $s r m \in M-\operatorname{rad}(N) \subseteq M-\operatorname{rad}\left(\left(N:_{M} r\right)\right)$. Thus $\left(N:_{M} r\right)$ is an $S$-1-absorbing primary submodule of $M$.

Theorem 6. Let $M$ be a finitely generated multiplication $R$-module where $R$ is a non-quasi local ring and $N$ be a submodule of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$. Then $N$ is an $S$-1-absorbing primary submodule of $M$ if and only if $N$ is an $S$-primary submodule of $M$.

Proof. Suppose that $N$ is a $S$-1-absorbing primary submodule of $M$. Then $\left(N:_{R}\right.$ $M)$ is an $S$-1-absorbing primary ideal of $R$ by Lemma 4 and $\left(N:_{R} M\right)$ is $S$ primary ideal of $R$ by Corollary 2, Hence, $N$ is an $S$-primary submodule of $M$ by [3, Theorem 2.17]. Conversely, if $N$ is an $S$-primary submodule of $M$, then $\left(N:_{R} M\right)$ is an $S$-primary ideal of $R$ by [3, Theorem 2.17]. Since every $S$-primary ideal with $\left(N:_{R} M\right) \cap S=\emptyset$ is an $S$-1-absorbing primary ideal, $\left(N:_{R} M\right)$ is an $S$-1-absorbing primary ideal of $R$. Thus, $N$ is an $S$-1-absorbing primary submodule of $M$ by Theorem 1 .

In view of Corollary 2, we have the following result.
Theorem 7. Let $S_{i}$ be multiplicatively closed subset of ring $R_{i}$ for each $i=1, \ldots, n$ and $S=S_{1} \times \cdots \times S_{n}$. For an ideal $I=I_{1} \times \cdots \times I_{n}$ of $R=R_{1} \times \cdots \times R_{n}$, the following are equivalent.
(1) $I$ is an $S$-1-absorbing primary ideal of $R$.
(2) $I$ is an $S$-primary ideal of $R$.
(3) $I_{j}$ is an $S_{j}$-primary ideal of $R_{j}$ for some $j \in\{1, \ldots, n\}$ and $I_{k} \cap S_{k} \neq \emptyset$ for all $k \in\{1, \ldots, n\} \backslash\{j\}$.

Proof. (1) $\Leftrightarrow(2)$ Since $R$ is not quasi-local, $S$-1-absorbing primary ideals and $S$ primary ideals coincide by Corollary 2, $\quad(2) \Leftrightarrow(3)$ Follows from [3, Theorem 2.21] considering $M_{i}=R_{i}$ as an $R_{i}$-module for all $i \in\{1, \ldots, n\}$.

Proposition 7. Let $S$ be a multiplicatively closed subset of $R, M_{1}, M_{2}$ be $R$ modules and $M=M_{1} \times M$ and $N_{1}$ be a proper submodule of $M_{1}$. If $N=N_{1} \times M_{2}$ is an $S \times 0$-1-absorbing primary submodule of $R$-module $M$, then $N_{1}$ is an $S$-1absorbing primary submodule of $M_{1}$.

Proof. Suppose that $N=N_{1} \times M_{2}$ is an $S \times 0$-1-absorbing primary submodule of $M$. Then $N_{1} \cong N /\left(\{0\} \times M_{2}\right)$ is an $S$-1-absorbing primary submodule of $M /(\{0\} \times$ $\left.M_{2}\right) \cong M_{1}$ by Corollary 1

Theorem 8. Let $S$ be a multiplicatively close subset of $R, M_{1}, M_{2}$ be $R$-modules and $M=M_{1} \times M_{2}$ and $N_{1}, N_{2}$ be proper submodules respectively of $M_{1}$ and $M_{2}$. Let $M=M_{1} \times M_{2}, N=N_{1} \times M_{2}$ and $N^{\prime}=M_{1} \times N_{2}$. We suppose that $\left(N_{i}: M_{i}\right) \cap S=\emptyset$, where $i=1,2$.
(1) $N_{1}$ is an S-1-absorbing primary submodule of $M_{1}$ if and only if $N$ is an $S \times\{1\}-1$-absorbing primary submodule of $M$.
(2) $N_{2}$ is an $S$-1-absorbing primary submodule of $M_{2}$ if and only if $N^{\prime}$ is a $\{1\} \times S$-1-absorbing primary submodule of $M$.

Proof. (1) Suppose that $N$ is an $S$-1-absorbing primary submodule of $M$, let $(s, 1)$ be $S \times\{1\}$-element of $N$. Let $a, b$ be non-nunit elements of $R$ and $m_{1} \in M_{1}$ with $a b m_{1} \in N_{1}$, so $(a, 1)(b, 1)\left(m_{1}, 0\right)=\left(a b m_{1}, 0\right) \in N$. Hence $(s, 1)(a, 1)(b, 1) \in\left(N_{1} \times\right.$ $\left.M_{2}: M_{1} \times M_{2}\right)$ or $(s, 1)\left(m_{1}, 0\right) \in M-r a d\left(N_{1} \times M_{2}\right)$. If $(s, 1)(a, 1)(b, 1) \in\left(N_{1} \times M_{2}\right.$ : $\left.M_{1} \times M_{2}\right)$, it is clear that $s a b \in\left(N_{1}: M_{1}\right)$. Now suppose $(s, 1)\left(m_{1}, 0\right) \in M-r a d\left(N_{1} \times\right.$ $M_{2}$ ). By [5] Lemma 2.10], we have $(s, 1)\left(m_{1}, 0\right) \in M_{1}-\operatorname{rad}\left(N_{1}\right) \times M_{2}$, and thus $s m_{1} \in M_{1}-\operatorname{rad}\left(N_{1}\right)$. We conclude that $N_{1}$ is an $S$-1-absorbing primary submodule. Now assume that $N_{1}$ is an $S$-1-absorbing primary submodule of $M_{1}$ and let $s \in S$ be an $S$-element of $N_{1}$. Let $\left(a, a^{\prime}\right),\left(b, b^{\prime}\right)$ be non-units of $R \times R$ and $\left(m, m^{\prime}\right) \in M$ with $\left(a, a^{\prime}\right)\left(b, b^{\prime}\right)\left(m, m^{\prime}\right) \in N$. Then $a b m \in N_{1}$ and so either $s a b \in\left(N_{1}: M_{1}\right)$ or $s m_{1} \in M_{1}-r a d(N)$. If $s a b \in N_{1}$, we conclude that $(s, 1)\left(a, a^{\prime}\right)\left(b, b^{\prime}\right)=\left(s a b, a^{\prime} b^{\prime}\right) \in$ $\left(N_{1} \times M_{2}: M_{1} \times M_{2}\right)$, now if $s a b \in M_{1}-\operatorname{rad}\left(N_{1}\right)$, we get $(s, 1)\left(a, a^{\prime}\right)\left(m, m^{\prime}\right)=$ $\left(s a m, s a^{\prime} m^{\prime}\right) \in M_{1}-\operatorname{rad}\left(N_{1}\right) \times M_{2}=M-r a d\left(N_{1} \times M_{2}\right)$ by [5] Lemma 2.10]. Hence, $N$ is an $S \times\{1\}$-1-absorbing primary submodule of $M$.
(2) The similar proof of (1).

Lemma 5. Let $N$ be a submodule of $M$ and $S$ be a multiplicatively closed subset of $R$. If $(P: M) \cap S=\emptyset$ for all prime submodule $P$ containing $N$, then ( $M$ $\operatorname{rad}(N): s)=M-\operatorname{rad}(N)=M-\operatorname{rad}(N: s)$ for any $s \in S$.

Proof. The inclusions $M-\operatorname{rad}(N) \subseteq M-\operatorname{rad}(N: s)$ and $M-\operatorname{rad}(N) \subseteq(M-\operatorname{rad}(N)$ : $s$ ) are clear. Let $m \in(N: s)$ and suppose that $P$ is a prime submodule of $M$ containing $N$. Then $s m \in N \subseteq P$ implies directly $m \in P$ due to our assumption. Thus, $(N: s) \subseteq P$ and we conclude $M-\operatorname{rad}(N)=M-\operatorname{rad}(N: s)$. Now, let $m \in(M-$ $\operatorname{rad}(N): s)$. Then $s m \in M-\operatorname{rad}(N)$ which means that $s m \in P$ for all prime submodules $P$ containing $N$. Again we have $m \in P$ by our assumption. It follows that $m \in M-\operatorname{rad}(N)$ and consequently we get $(M-\operatorname{rad}(N): s) \subseteq M-\operatorname{rad}(N)$.

In the following proposition, we denote $Z_{I}(R)$ by the set $\{x \in R \mid x y \in$ $I$ for some $y \in R \backslash I\}$.

Proposition 8. Let $N$ be a submodule of $M$ and $S$ be a multiplicatively closed subset of $R$ provided $(P: M) \cap S=\emptyset$ for all prime submodule $P$ containing $N$. If $Z_{(N: M)}(R) \cap S=\emptyset$, then $(N: s)$ is a 1-absorbing primary submodule of $M$ for all $s \in S$.

Proof. Suppose that $a b m \in(N: s)$ for some non-unit $a, b \in R$ and $m \in M$. Hence, sabm $\in M$ and there exists $s^{\prime} \in S$ such that either $s^{\prime} s a b \in(N: M)$ or $s^{\prime} m \in M$ $\operatorname{rad}(N)$. If $s^{\prime} s a b \in(N: M)$, then we conclude $a b \in(N: M) \subseteq((N: s): M)$ since $Z_{(N: M)}(R) \cap S=\emptyset$. Now, assume that $s^{\prime} m \in M-\operatorname{rad}(N)$. Then we have $m \in(M-$ $\left.\operatorname{rad}(N): s^{\prime}\right)=M-\operatorname{rad}(N)=M-\operatorname{rad}(N: s)$ by Lemma 5] so we are done.

## 3. $S$-1-absorbing Primary Avoidance Theorem

In this section, $S$-1-absorbing primary avoidance theorem is proved. Throughout this section, let $M$ be a finitely generated multiplication $R$-module, $N, N_{1}, N_{2}, \ldots, N_{n}$ be submodules of $M$ and $S$ be a multiplicatively closed subset of $R$. Recall that a covering $N \subseteq N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ is said to be efficient if no $N_{k}$ is unnecessary. Besides, if none of the $N_{k}$ may be excluded, the union $N=N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ is efficient [20]. We first state some theorems that we will require.

Lemma 6. (18, Corollary 1) Let $R$ be a ring, $S \subseteq R$ a multiplicatively closed set and $P$ an ideal of $R$ disjoint with $S$. Then $P$ is $S$-prime if and only if there exists $s \in S$, such that for all $I_{1}, \ldots, I_{n}$ ideals of $R$, if $I_{1} \ldots I_{n} \subseteq P$, then $s I_{j} \in P$ for some $j \in\{1, \ldots, n\}$.

Lemma 7. (18], Proposition 4) Let $R$ be a ring, $S \subseteq R$ a multiplicatively closed set and $P$ an ideal of $R$ disjoint with $S$. Then $P$ is $S$-prime if and only if there exists $s \in S$ such that for all $x_{1}, \ldots, x_{n} \in R$, if $x_{1} \ldots x_{n} \in P$, then $s x_{j} \in P$ for some $j \in\{1, \ldots, n\}$.
Theorem 9. Let $N \subseteq N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ be an efficient covering of submodules $N_{1}, N_{2}, \ldots, N_{n}$ of $M$ where $n>2$. Assume that $\sqrt{\left(N_{k}: m\right)}$ is an ideal of $R$ disjoint with $S$ for all $1 \leq k \leq n$ and all $m \in M \backslash P$ where $P$ is any prime submodule of $M$ containing $N_{k}$. If $\sqrt{\left(N_{j}: M\right)} \nsubseteq\left(\sqrt{\left(N_{k}: m\right)}: s\right)$ for all $s \in S$ whenever $j \neq k$, then no $N_{k}$ is an $S$-1-absorbing primary submodule of $M$.

Proof. It can be easily seen that $N=\left(N \cap N_{1}\right) \bigcup\left(N \cap N_{2}\right) \bigcup \cdots \bigcup\left(N \cap N_{n}\right)$ is an efficient union since $N \subseteq N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ is efficient. Thus, there exists an element $m_{k} \in N \backslash N_{k}$ for all $k \leq n$. From ([20], Lemma 2.2), it is known that $\bigcap_{j \neq k}\left(N \cap N_{j}\right) \subseteq N \cap N_{k}$. Now assume that $N_{k}$ is an $S$-1-absorbing primary submodule of $M$ for some $k \in\{1, \ldots, n\}$. Then, $\left(N_{k}: m\right)$ is an $S$-1-absorbing primary ideal of $R$ by Lemma 4. Furthermore, by Lemma 1, $\sqrt{\left(N_{k}: m\right)}$ is an $S$ prime ideal of $R$. By our hypothesis, $s \sqrt{\left(N_{j}: M\right)} \nsubseteq\left(\sqrt{\left(N_{k}: m\right)}\right.$ and then there exists a non-unit element $a_{j} \in \sqrt{\left(N_{j}: M\right)}$ such that $s a_{j} \notin \sqrt{\left(N_{k}: m\right)}$ for all $s \in S$ and all $m \in M \backslash N_{k}$. (If $a_{j}$ is unit, then $\sqrt{\left(N_{j}: M\right)}=R$ and hence $N_{j}=M$ which contradicts with our assumption that the covering is efficient.) So, there exists a positive integer $n_{j}$ such that $a_{j}^{n_{j}} \in\left(N_{j}: M\right)$ where $j \neq k$. From Lemma 6 we also have $\prod_{j \neq k} \sqrt{\left(N_{j}: M\right)} \nsubseteq \sqrt{\left(N_{k}: m\right)}$ due to $\sqrt{\left(N_{k}: m\right)}$ is $S$-prime. Now let us say $a=\prod_{j \neq k} a_{j}$ and $t=\max \left\{n_{j}\right\}_{j \neq k}$. Then we get $a^{t} \in\left(N_{j}: M\right)$ and it follows that $a^{t} m_{k} \in N \cap N_{j}$ for every $j \neq k$. However, $a \notin \sqrt{\left(N_{k}: m\right)}$ by Lemma 7 and this implies that $a^{t} m \notin N_{k}$ for all $m \in M \backslash N_{k}$. As a result, $a^{t} m_{k} \notin N_{k}$ because $m_{k} \notin N_{k}$ as well. This shows that $a^{t} m_{k} \in \bigcap_{j \neq k}\left(N \cap N_{j}\right) \backslash N \cap N_{k}$, which is a contradiction.

Theorem 10 ( $S$-1-absorbing primary avoidance theorem). Let $N, N_{1}, N_{2}, \ldots, N_{n}$ be submodules of $M$ such that $N \subseteq N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ where at most two of
$N_{1}, N_{2}, \ldots, N_{n}$ are not $S$-1-absorbing primary submodules. Suppose that $\sqrt{\left(N_{k}: m\right)} \cap$ $S=\emptyset$ for all $m \in M \backslash N_{k}$ where $1 \leq k \leq n$. If $\sqrt{\left(N_{j}: M\right)} \nsubseteq\left(\sqrt{\left(N_{k}: m\right)}: s\right)$ for all $s \in S$ whenever $j \neq k$, then $N \subseteq N_{k}$ for some $k$.

Proof. We can assume that the covering $N \subseteq N_{1} \cup N_{2} \cup \cdots \cup N_{n}$ is efficient because any cover including submodules of $M$ can be reduced to an efficient covering by eliminating any superfluous terms and therefore $n \neq 2$. Since there is no $S$-1absorbing primary submodule $N_{k}$ from Theorem[9, $n<2$. Hence we obtain $N \subseteq N_{k}$ for some $k \in\{1, \ldots, n\}$.

Corollary 3. Let $N$ be a submodule of $M$. If the $S$-1-absorbing primary avoidance theorem holds for $M$, then the theorem holds also for $M / N$.

Proof. Let $K / N, N_{1} / N, N_{2} / N, \ldots, N_{n} / N$ be submodules of $M / N$ such that at most two of $N_{1} / N, N_{2} / N, \ldots, N_{n} / N$ are not $S$-1-absorbing primary and $K / N \subseteq N_{1} / N \cap$ $N_{2} / N \cap \cdots \cap N_{n} / N$ where $n \geq 2$. Thus, $K \subseteq N_{1} \cap N_{2} \cap \cdots \cap N_{n}$ and at most two of $N_{1}, N_{2}, \ldots, N_{n}$ are not $S$-1-absorbing primary by Corollary 1. Assume that $\sqrt{N_{j} / N: M / N} \nsubseteq\left(\sqrt{N_{k} / N: m+N}: s\right)$ for all $s \in S$ and all $m+N \in M / N \backslash N_{k} / N$ whenever $j \neq k$. Then $\sqrt{\left(N_{j}: M\right)} \nsubseteq\left(\sqrt{\left(N_{k}: m\right)}: s\right)$ for all $s \in S$. Since the $S$-1absorbing primary avoidance theorem is satisfied by the submodules of $M$, the rest of the proof is immediate.

## 4. Idealization of $S$-1-Absorbing primary submodules

Let $M$ be a unitary $R$-module. Recall from [23] the idealization $R(+) M$ of $M$ is the direct sum $R(+) M=R \oplus M$ which is a commutative ring with componentwise addition and multiplication $\left(r_{1}, m_{1}\right)\left(r_{2}, m_{2}\right)=\left(r_{1} r_{2}, r_{1} m_{2}+r_{2} m_{1}\right)$. It is well known that if $N$ is a submodule of $M$ with $I M \subset N$, then $I(+) N$ is an ideal of $R(+) M$.

Proposition 9. Let $S$ be a multiplicatively closed subset of $R, I$ be an ideal of $R$ with $I \cap S=\emptyset$. Then the following statements are equivalent:
(1) $I$ is an $S$-1-absorbing primary ideal of $R$.
(2) $I(+) M$ is an $S(+) 0-1$-absorbing primary ideal of $R(+) M$.
(3) $I(+) M$ is an $S(+) M-1$-absorbing primary ideal of $R(+) M$.

Proof. (1) $\Rightarrow$ (2) It is clear that $(I(+) N) \cap(S(+) 0)=\emptyset$ if and only if $S \cap I=\emptyset$. Suppose that $I$ is an $S$-1-absorbing primary ideal of $R$ and $s$ be an $S$-element of $I$. Let $(a, m)(b, n)(c, p) \in I(+) M$ where $(a, m),(b, n),(c, p)$ are non-unit elements of $R(+) M$. Since $U(R(+) M)=U(R)(+) M$, we conclude that $a, b, c$ are non-units in $R$ and $a b c \in I$. Then either $s a b \in I$ or $s c \in \sqrt{I}$. If $s a b \in I$, then $(s, 0)(a, m)(b, n)=$ $(s a b, s a n+s b m) \in I(+) M$. If $s c \in \sqrt{I}$, then $(s, 0)(c, p)=(s c, 0) \in \sqrt{I(+) M}$ due to $\sqrt{I(+) M}=\sqrt{I}(+) M$. Thus $I(+) M$ is an $S(+) 0-1$-absorbing primary ideal of $R(+) M$.
$(2) \Rightarrow(3)$ Is clear since $S(+) 0 \subset S(+) M$.
$(3) \Rightarrow(1)$ Assume that $I(+) M$ is an $S(+) M$-1-absorbing primary ideal of $R(+) M$. Let $(s, m)$ be an $S(+) M$-element of $I(+) M$ and let $a b c \in I$ for non-unit elements $a, b, c$ of $R$. Then $(a, 0),(b, 0),(c, 0)$ are also non-unit elements of $R(+) M$ since $U(R(+) M)=U(R)(+) M$. Besides, we have $(a, 0)(b, 0)(c, 0) \in I(+) M$. So, either $(s, m)(a, 0)(b, 0)=(s a b, a b m) \in I(+) M$ or $(s, m)(c, 0) \in \sqrt{I(+) M}$ which yields $s a b \in I$ or $s c \sqrt{I}$. Hence $I$ is an $S(+) M$-1-absorbing primary ideal of $R$.

Proposition 10. Let $S$ be a multiplicatively closed subset of $R$ and $I$ be an ideal of $R$ with $I \cap S=\emptyset$. Suppose $N$ is a proper submodule of $M$ such that $I M \subset N$. Then $(1) \Longrightarrow(2) \Longrightarrow(3)$ is satisfied for the below statements:
(1) $I(+) N$ is an $S(+) 0-1$-absorbing primary ideal of $R(+) M$.
(2) $I(+) N$ is an $S(+) M$-1-absorbing primary ideal of $R(+) M$.
(3) I is an $S$-1-absorbing primary ideal of $R$.

Proof. (1) $\Longrightarrow(2)$ It is clear since $S(+) 0 \subset S(+) M$.
$(2) \Longrightarrow(3)$ Let $a b c \in I$ for non-unit elements $a, b, c \in R$. We have $(a, 0)(b, 0)(c, 0) \in$ $I(+) N$ which is $S(+) M$-1-absorbing primary ideal of $R(+) M$ where $(a, 0),(b, 0),(c, 0)$ are non-units in $R(+) M$. Then either

$$
(s, m)(a, 0)(b, 0)=(s a b, a b m) \in I(+) N
$$

or

$$
(s, m)(c, 0)=(s v, c m) \in \sqrt{I(+) N}=\sqrt{I}(+) M
$$

where $(s, m)$ is an $S(+) M$-element of $I(+) N$. Then either $s a b \in I$ or $s c \in \sqrt{I}$. Hence $I$ is an $S$-1-absorbing primary ideal of $R$.

Example 3. The implication $(3) \Longrightarrow(1)$ is not true in general case. If $I$ is an $S$-1-absorbing primary ideal, then $I(+) N$ (where $N$ a proper submodule of $M$ ) is not necessarily $S(+) 0-1$-absorbing primary ideal of $R(+) M$. Take $R=\mathbf{Z}=M$ and $S=\{\mp 1\}$. Then $I=\{0\}$ is an $S$-1-absorbing primary ideal of $\mathbf{Z}$, since $(0(+) 6 \mathbf{Z}$ : $(0,1))=6 \mathbf{Z}(+) \mathbf{Z}$ is not an $S(+) 0$-prime ideal. We conclude that $0(+) 6 \mathbf{Z}$ is not an $S(+) 0-1$-absorbing primary ideal of $\mathbf{Z}(+) \mathbf{Z}$ by Lemma 1 .

## 5. Amalgamation of $S$ - 1 -ABSORBING Primary Submodules

Let $A$ and $B$ be commutative rings with unity, let $J$ be an ideal of $B$ and let $f: A \rightarrow B$ be a ring homomorphism. In this setting, we can consider the following subring of $A \times B$ :

$$
A \bowtie^{f} J:=\{(a, f(a)+j) \mid a \in A, j \in J\}
$$

called the amalgamation of $A$ with $B$ along $J$ with respect to $f$. This construction is a generalization of the amalgamated duplication of a ring along an ideal (cf., for instance [6, 8, 9, 10, 11, 12]).

It is clear that a subset $S$ of $A$ is a multiplicatively closed subset of $A$ if and only if $S \bowtie^{f} J:=\{(s, f(s)+j) \mid s \in S ; j \in J\}$ is a multiplicatively closed subset of $A \bowtie^{f} J$.

Lemma 8. If $I$ is an ideal of $A$, then

$$
\sqrt{I \bowtie^{f} J}=\sqrt{I} \bowtie^{f} J .
$$

Proof. Let $(a, f(a)+j) \in A \bowtie^{f} J$ such that $(a, f(a)+j) \in \sqrt{I \bowtie^{f} J}$. Then there exists a nonzero integer $n$ such that $(a, f(a)+j)^{n}=\left(a^{n}, f\left(a^{n}\right)+j^{\prime}\right) \in I \bowtie^{f} J$ where $j^{\prime}=\sum_{k=0}^{n-1}\binom{n}{k} f\left(a^{k}\right) j^{n-k} \in J$. Then $a^{n} \in I$, so $a \in \sqrt{I}$ and $(a, f(a)+$ $j) \in \sqrt{I} \bowtie^{f} J$. Hence, we conclude that $\sqrt{I \bowtie^{f} J} \subset \sqrt{I} \bowtie^{f} J$. Conversely, let $(a, f(a)+j) \in \sqrt{I} \bowtie^{f} J$. Then there exists $n \in \mathbb{N}^{*}$ such that $a^{n} \in I$. On the other
hand $(a, f(a)+j)^{n}=\left(a^{n}, f\left(a^{n}\right)+j^{\prime}\right)$. Then $(a, f(a)+j) \in \sqrt{I \bowtie^{f} J}$, which yields $\sqrt{I} \bowtie^{f} J \subset \sqrt{I \bowtie^{f} J}$. Finally, we conclude $\sqrt{I \bowtie^{f} J}=\sqrt{I} \bowtie^{f} J$.

Proposition 11. Let $S$ be a multiplicatively closed subset and $I, J$ be ideals of $A$. The following statements are equivalent:
(1) $I$ is an $S$-1-absorbing primary ideal of $A$.
(2) $I \bowtie^{f} J$ is an $S \bowtie^{f} J$-1-absorbing ideal of $A \bowtie^{f} J$.

Proof. Assume that $I \bowtie^{f} J$ is an $S \bowtie^{f} J$-1-absorbing primary ideal of $A \bowtie^{f} J$ and let $(s, f(s)+j)$ be an $S \bowtie^{f} J$-element of $I \bowtie^{f} J$. Take $a b c \in I$ for non-unit elements $a, b, c$ of $A$. Then $(a, f(a)),(b, f(b)),(c, f(c))$ are also non-unit elements of $A \bowtie^{f} J$ and $(a, f(a))(b, f(b))(c, f(c)) \in I \bowtie^{f} J$. Since $I \bowtie^{f} J$ is an $S \bowtie^{f} J$-1absorbing primary submodule, we get either $(s, f(s)+j)(a, f(a))(b, f(b)) \in I \bowtie^{f} J$ or $(s, f(s)+j)(c, f(c)) \in \sqrt{I \bowtie^{f} J}=\sqrt{I} \bowtie^{f} J$ by Lemma 8. Then either $s a b \in I$ or $s c \in \sqrt{I}$. Thus $I$ is an $S$-1-absorbing primary ideal of $A$.

Conversely, suppose that $I$ is an $S$-1-absorbing primary ideal of $A$ and let $s \in S$ be an $S$-element of $I$. Let $(a, f(a)+j),(b, f(b)+k),(c, f(c)+l)$ be non-unit elements of $A \bowtie^{f} J$ such that $(a, f(a)+j)(b, f(b)+k)(c, f(c)+l) \in I \bowtie^{f} J$. Then $a b c \in I$. It is necessary that one of the $a, b, c$ is non-unit, otherwise, $a b c$ is unit and $a b c \in I$, a contradiction. Since $I$ is an $S$-1-absorbing primary submodule of $A$, we get either $s a b \in I$ or $s c \in \sqrt{I}$ which gives either $(s, f(s))(a, f(a)+j)(b, f(b)+k) \in I \bowtie^{f} J$ or $(s, f(s))(c, f(c)+l) \in \sqrt{I} \bowtie^{f} J=\sqrt{I \bowtie^{f} J}$ by Lemma 8. Hence $I \bowtie^{f} J$ is an $S \bowtie^{f} J$-1-absorbing primary ideal of $A \bowtie^{f} J$.

Corollary 4. Let $R$ be a ring and $I, K$ be ideals of $R$ with $K \cap S=\emptyset$. Then the following statements are equivalent:
(1) $K$ is an $S$-1-absorbing primary ideal of $R$.
(2) $K \bowtie I$ is an $S \bowtie I$-1-absorbing primary ideal of $R \bowtie I$.

Proof. It is easy to see that $(K \bowtie I) \cap(S \bowtie I)=\emptyset$. The rest of the proof follows from the previous proposition.

Let $S_{2}$ be a multiplicatively closed subset of the ring $f(A)+J$. Consider the set

$$
{\overline{S_{2}}}^{f}:=\left\{(r, f(r)+j) \mid j \in J, r \in A, f(r)+j \in S_{2}\right\}
$$

It is clear that ${\overline{S_{2}}}^{f}$ is a multiplicatively closed subset of $A \bowtie^{f} J$.
If $K$ is an ideal of $f(A)+J$, then the set

$$
\bar{K}^{f}:=\{(a, f(a)+j) \mid a \in A, j \in J, f(a)+j \in K\}
$$

is an ideal of $A \bowtie^{f} J$.
Lemma 9. Under the above notations, we have

$$
{\sqrt{\bar{K}^{f}}}^{f}{\overline{\sqrt{K}^{\prime}}}^{f}
$$

Proposition 12. Let $f: A \longrightarrow B$ be a ring homomorphism, $J, K$ be ideals of $B$ and $S_{2}$ be a multiplicatively closed subset of $f(A)+J$ with $K \cap S_{2}=\emptyset$. Let

$$
\bar{K}^{f}=\{(a, f(a)+j) \mid a \in A, j \in J, f(a)+j \in K\}
$$

Then the following statements are equivalent:
(1) $K$ is an $S_{2}-1$-absorbing primary ideal of $f(A)+J$.
(2) $\bar{K}^{f}$ is an $\bar{S}_{2}^{f}$-1-absorbing primary ideal of $A \bowtie^{f} J$.

Proof. Assume that $\bar{K}^{f}$ is an $\bar{S}^{f}$-1-absorbing primary ideal of $A \bowtie^{f} J$ and let $(s, f(s)+p)$ be an $\bar{S}^{f}$-element of $\bar{K}^{f}$. Let $(f(a)+j)(f(b)+k)(f(c)+l) \in K$ for non-unit elements $f(a)+j, f(b)+k, f(c)+l \in f(A)+J$. Then $(a, f(a)+j),(b, f(b)+$ $k),(c, f(c)+l)$ are non-unit elements of $A \bowtie^{f} J$ and $(a, f(a)+j)(b, f(b)+k)(c, f(c)+$ $l) \in \bar{K}^{f}$. Thus, we have either $(s, f(s)+p)(a, f(a)+j)(b, f(b)+k) \in \bar{K}^{f}$ or $(s, f(s)+$ $p)(c, f(c)+l) \in \sqrt{\bar{K}^{f}}$. In the first case, we have $(f(s)+p)(f(a)+j)(f(b)+k) \in K$. In
 $(f(s)+p)(f(c)+k) \in \sqrt{K}$. We conclude that $K$ is an $S_{2}$-1-absorbing primary ideal of $B$. Conversely, suppose that $K$ is an $S_{2}$-1-absorbing primary ideal of $B$ and let $f(s)+p$ an $S_{2}$-element of $K$. Let $(a, f(a)+j)(b, f(b)+k)(c, f(c)+l) \in \bar{K}^{f}$ for non-unit elements $(a, f(a)+j),(b, f(b)+k),(c, f(c)+l) \in A \bowtie^{f} J$. Then we get $(a b c,(f(a)+$ $j)(f(b)+k)(f(c)+l)) \in \bar{K}^{f}$. Now suppose that $f(a)+j, f(b)+k, f(c)+l$ are non-unit elements of $f(A)+J$. Since $K$ is an $S_{2}$-1-absorbing primary ideal of $f(A)+J$, we conclude that either $(f(s)+p)(f(a)+j)(f(b)+k) \in K$ or $(f(s)+p)(f(c)+l) \in \sqrt{K}$. In the first case, we have $(s, f(s)+p)(a, f(a)+j)(b, f(b)+k) \in \bar{K}^{f}$. In the second case, we have $(s, f(s)+p)(c, f(c)+l) \in \sqrt{\bar{K}^{f}}$. Now, if one of $f(a)+j, f(b)+k, f(c)+l$ is unit, then the claim is clear. Hence $\bar{K}^{f}$ is an ${\overline{S_{2}}}^{f}$-1-absorbing primary ideal of $A \bowtie^{f} J$.

An $R$-module can be regarded as an $R \bowtie I$-module via the natural projection $R \bowtie I \longrightarrow R ;(r, r+i) \longmapsto r$, and an $R \bowtie I$-module can also be regarded as an $R$-module via the natural injection $\iota: R \longrightarrow R \bowtie I ; r \longmapsto(r, r)$.

Let $R$ be a ring, $I$ an ideal of $R, M$ an $R$-module and set

$$
M \bowtie I:=\left\{\left(m, m^{\prime}\right) \in M \times M \mid m-m^{\prime} \in I M\right\}
$$

which is an $R \bowtie I$-module with the multiplication given by

$$
(r, r+i)\left(m, m^{\prime}\right)=\left(r m,(r+i) m^{\prime}\right)
$$

where $r \in R, i \in I$ and $\left(m, m^{\prime}\right) \in M \bowtie I$. Then the set $M \bowtie I$ is called the duplication of the $R$-module $M$ along the ideal $I$.

Let $N$ be a submodule of $M$. It is clear that

$$
N \bowtie I:\{(n, m) \in N \times M \mid n-m \in I M\}
$$

and

$$
\bar{N}:=\{(m, n) \in M \times N \mid n-m \in I M\}
$$

are submodules of $M \bowtie I$. If $S$ is a multiplicatively closed subset of $R$, then it is obvious that the sets $S \bowtie I:=\{(s, s+i) \mid s \in S, i \in I\}$ and $\bar{S}:=\{(s, s+i) \mid i \in$ $I, s+i \in S\}$ are multiplicatively closed subsets of $R \bowtie I$.

Lemma 10. Let $N$ be a submodule of $M$. Then

$$
\left(N \bowtie I:_{R \bowtie I} M \bowtie I\right)=\left(N:_{R} M\right) \bowtie I
$$

Proof. Let $(a, a+i) \in(N \bowtie I: R \bowtie I M \bowtie I)$. Then $(a, a+i)(M \bowtie I) \subset N \bowtie I$. Clearly, $a M \subset N$ and thus $(a, a+i) \in\left(N:_{R} M\right) \bowtie I$. Conversely, suppose that $(a, a+i) \in\left(N:_{R} M\right) \bowtie I$ and take $\left(m, m^{\prime}\right) \in M \bowtie I$. We have $(a, a+i)\left(m, m^{\prime}\right)=$
$\left(a m,(a+i) m^{\prime}\right) \in M \times M$ and $a\left(m-m^{\prime}\right)-i m^{\prime} \in I M$ since $m-m^{\prime} \in I M$. Hence $(a, a+i) \in\left(N \bowtie I:_{R \bowtie I} M \bowtie I\right)$. Thus, we conclude that $\left(N \bowtie I:_{R \bowtie I} M \bowtie I\right)=$ $\left(N:_{R} M\right) \bowtie I$.

Lemma 11. Let $L$ be a submodule of $M$. Then the following statements are equivalent:
(1) $L$ is a prime submodule of $M$.
(2) $L \bowtie I$ is a prime submodule of $M \bowtie I$.

Proof. Assume that $L \bowtie I$ is a prime submodule of $M \bowtie I$. Let $a m \in L$ for $a \in R$ and $m \in M$. Then $(a, a)(m, m) \in L \bowtie I$. Since $L \bowtie I$ is a prime submodule of $M \bowtie I$, we get either $(a, a) \in\left(L \bowtie I:_{R \bowtie I} M \bowtie I\right)$ which implies $a \in(N: M)$ by Lemma 10, or $(m, m) \in L \bowtie I$ which follows $m \in L$. Hence $L$ is a prime submodule of $M$. Conversely, assume that $L$ is a prime submodule of $M$ and let $(a, a+i)\left(m, m^{\prime}\right) \in L \bowtie I$ for $(a, a+i) \in R \bowtie I$ and $\left(m, m^{\prime}\right) \in M \bowtie I$. Thus $\left(a m,(a+i) m^{\prime}\right) \in L \bowtie I$ and we conclude that $a m \in L$. Due to the fact that $L$ is a prime submodule, we obtain either $a \in(N: M)$ or $m \in L$. In the first case, we have $(a, a+i) \in(N: M) \bowtie I=(N \bowtie I: R \bowtie I M \bowtie I)$. In the second case, we have $\left(m, m^{\prime}\right) \in L \bowtie I$, since $m-m^{\prime} \in I M$. Thus, $L \bowtie I$ is a prime submodule of $M \bowtie I$.

Lemma 12. Let $N$ be a submodule of $M$. Then the prime submodule which contains $N \bowtie I$ are exactly of the form $L \bowtie I$ where $L$ is a prime submodule containing $N$. Moreover, $M \bowtie I-\operatorname{rad}(N \bowtie I)=M-\operatorname{rad}(N) \bowtie I$.

Proof. Let $\varphi: M \bowtie I \longrightarrow M ;\left(m, m^{\prime}\right) \longmapsto m$ be an $R \bowtie I$-epimorphism with $\operatorname{ker} \varphi=0 \times I M$. Then $M \bowtie I / 0 \times I M \simeq M$. So, if $L$ is a submodule of $M \bowtie I$ such that $0 \times I M \subset I$, then there exists a submodule $K$ of $M$ such that $L / 0 \times I M \simeq$ $K$, which implies $L=K \bowtie I$. From Lemma [11, we conclude that $L$ is a prime submodule of $M \bowtie I$ if and only if $K$ is a prime submodule of $M$. Now, if $L$ is a prime submodule of $M \bowtie I$ such that $N \bowtie I \subset L$, then $0 \times I M \subset L$, and so there exits a prime submodule $K$ of $M$ with $L=K \bowtie I$.

Now, it is clear that $\bigcap_{i}\left(K_{i} \bowtie I\right)=\left(\bigcap_{i} K_{i}\right) \bowtie I$ where $K_{i}$ 's are the submodules of $M$ and consequently we have $M \bowtie I-\operatorname{rad}(N \bowtie I)=M-\operatorname{rad}(N) \bowtie I$.

Theorem 11. Let $N$ be a submodule of $M$ with $\left(N:_{R} M\right) \cap S=\emptyset$. Then the following statements are equivalent:
(1) $N$ is an $S$-1-absorbing primary submodule of $M$.
(2) $N \bowtie I$ is an $S \bowtie I$-1-absorbing primary submodule of $M \bowtie I$.

Proof. From Lemma 10, we clearly note that ( $N \bowtie I:_{R \bowtie I} M \bowtie I$ ) $\cap S \bowtie I=\emptyset$ if and only if $\left(N:_{R} M\right) \cap S=\emptyset$. Now suppose that $N \bowtie I$ is an $S \bowtie I$-1absorbing primary submodule of $M \bowtie I$. Let $(s, s+i)$ be an $S \bowtie I$-element of $N \bowtie I$ and let $a b m \in N$ for non-unit elements $a, b \in R$ and $m \in M$. Then $(a, a)(b, b)(m, m) \in N \bowtie I$. Since $(a, a),(b, b)$ are non-units and $N \bowtie I$ is an $S \bowtie I$ -1-absorbing primary submodule of $M \bowtie I$, we have either

$$
(s, s+i)(a, a)(b, b) \in(N \bowtie I: M \bowtie I)
$$

or

$$
(s, s+i)(m, m) \in M \bowtie I-\operatorname{rad}(N \bowtie I) .
$$

In the first case, we have $s a b \in(N: M)$ by Lemma 10. In the second case, $M \bowtie I$ $\operatorname{rad}(N \bowtie I)=M-\operatorname{rad}(N) \bowtie I$ by Lemma 12 and we conclude that $(s m,(s+i) m) \in$ $M-\operatorname{rad}(N) \bowtie I$, and so $s m \in M-\operatorname{rad}(N)$. If such an $N$ does not exists, it is well known that $M-\operatorname{rad}(N)=M$. Then $N$ is an $S$-1-absorbing primary submodule of $M$. Conversely, assume that $N$ is an $S$-absorbing primary submodule of $M$. Let $s \in S$ be an $S$-element of $N$ and let $(a, a+i)(b, b+i)\left(m, m^{\prime}\right) \in N \bowtie I$ for non-unit elements $(a, a+i),(b, b+i) \in R \bowtie I$ and $\left(m, m^{\prime}\right) \in M \bowtie I$. Then $a b m \in N$. If $a$ or $b$ is unit, the claim is clear. Now we can assume $a$ and $b$ are non-unit elements of $R$. Due to the fact that $N$ is an $S$-1-absorbing primary submodule of $R$, we get either $s a b \in(N: M)$ or $s m \in M-\operatorname{rad}(N)$. In the first case, we conclude that $(s, s)(a, a+i)(b, b+i) \in(N: M) \bowtie I=(N \bowtie I: M \bowtie I)$. In the second case, we have $\left(s m, s m^{\prime}+i m^{\prime}\right) \in M-\operatorname{rad}(N) \bowtie I$, since $r\left(m-m^{\prime}\right)-i m^{\prime} \in I M$. Thus, the claim follows by $M-\operatorname{rad}(N) \bowtie I=M \bowtie I-\operatorname{rad}(N \bowtie I)$.
