# HALF-ISOMORPHISMS OF AUTOMORPHIC LOOPS

#### Abstract

Automorphic loops are loops in which all inner mappings are automorphisms. This variety of loops includes groups and commutative Moufang loops. A half-isomorphism $f: G \longrightarrow K$ between multiplicative systems $G$ and $K$ is a bijection from $G$ onto $K$ such that $f(a b) \in$ $\{f(a) f(b), f(b) f(a)\}$ for any $a, b \in G$. A half-isomorphism is trivial when it is either an isomorphism or an anti-isomorphism. Consider the class of automorphic loops such that the equation $x \cdot(x \cdot y)=(y \cdot x) \cdot x$ is equivalent to $x \cdot y=y \cdot x$. Here we show that this class of loops includes automorphic loops of odd order and uniquely 2-divisible. Furthermore, we prove that every half-isomorphism between loops in that class is trivial.

## 1 Introduction

A loop $(L,$.$) is a set L$ with a binary operation $(\cdot)$ such that for each $a, b \in L$ there exist unique elements $x, y \in L$ such that $a \cdot x=b$ and $y \cdot a=b$, and there is an identity element 1 such that $1 \cdot x=x=x \cdot 1$ for every $x \in L$. The operation $\cdot$ is denoted by juxtaposition for the sake of convenience, so $(L, \cdot)$ is denoted by $L$ and $x \cdot y$ by $x y$.
For any $a \in L$, the right translation and left translation by $a$ are the bijections $R_{a}: L \rightarrow L$; $x \mapsto x \cdot a$ and $L_{a}: L \rightarrow L ; x \mapsto a \cdot x$ respectively. These bijections generate the multiplication group $\operatorname{Mlt}(L)=\left\langle R_{a}, L_{a} ; a \in L\right\rangle$. The inner mapping group, denoted by $\operatorname{Inn}(L)$, is the subgroup of $M l t(L)$ containing the elements that stabilize the identity element. Automorphic loops (or A-loops in Bruck's notation [2]) are loops in which every inner mapping is an automorphism, or $\operatorname{Inn}(L)$ is a subgroup of $\operatorname{Aut}(L)$, where $\operatorname{Aut}(L)$ is the automorphism group of $L$. It is well known that automorphic loops are power associative, i.e., each element generates a cyclic group.

Let $(L, *)$ and $\left(L^{\prime}, \cdot\right)$ be loops. A bijection $f: L \longrightarrow L^{\prime}$ is called a half-isomorphism if

$$
f(x * y) \in\{f(x) \cdot f(y), f(y) \cdot f(x)\}, \text { for any } x, y \in L
$$

A half-automorphism and a half-homomorphism are defined in a similar manner. We say that a half-isomorphism is trivial when it is either an isomorphism or an anti-isomorphism. Likewise, a half-isomorphism is nontrivial when it is neither an isomorphism nor an anti-isomorphism (In [9], the word "proper" is used instead).

All half-isomorphisms are trivial for groups, as was shown by Scott [16, but not for loops. For example, in the case of the variety of Moufang loops, there exist loops of even order with nontrivial half-isomorphism [3, 12] as well as loops of odd order in which all half-isomorphisms are trivial [4].
These and more recent studies of half-isomorphisms in different classes of loops have shown that the behavior of these functions is rather unpredictable. For example, investigating dihedral automorphic loops, which is a class of automorphic loops of even order, we proved that there exist half-isomorphisms which are neither isomorphisms nor anti-isomorphisms [10. Another case is the case of the automorphic loops of odd order of the class called Lie automorphic loops for which we proved that all half-automorphisms are trivial [11.
In the current paper, we prove that if $Q$ and $Q^{\prime}$ are automorphic loops, and in $Q^{\prime}$ the equation $x \cdot(x \cdot y)=(y \cdot x) \cdot x$ is equivalent to the equation $x \cdot y=y \cdot x$, then every half-isomorphism from $Q$ onto $Q^{\prime}$ is trivial. The conjecture, presented in [11, that every half-isomorphism between automorphic loops of odd order is trivial, is a corollary of this result.

## 2 Preliminaries

Part of the investigations for this work (section 3) were assisted by Prover9 [13], an automated computational tool for equational reasoning. However, the raw output is usually overcomplicated and here we present only "humanized" versions on these proofs. Also, the LOOPS package [14] for GAP [5] was used.
In this section, the required definitions and basic results are stated. For general facts about loop theory we recommend [1, 15.
Let $L$ be a loop and $x, y \in L$. Consider the following bijections:

$$
\begin{array}{r}
R_{(x, y)}=R_{x} R_{y} R_{(x y)}^{-1}, \\
L_{(x, y)}=L_{x} L_{y} L_{(y x)}^{-1}, \\
T_{x}=R_{x} L_{x}^{-1} . \tag{3}
\end{array}
$$

It is well-known that the inner mapping group of $L$ is generated by these bijections, that is:

$$
\operatorname{Inn}(L)=\left\langle R_{(x, y)}, L_{(x, y)}, T_{x} \mid x, y \in L\right\rangle .
$$

The following lemma is straightforward.
Lemma 2.1. Let $L$ be a loop, $x, y, z \in L$ and $\varphi \in \operatorname{Aut}(L)$. Then
(a) $(y) L_{x}^{-1} \varphi=(y) \varphi L_{(x) \varphi}^{-1}$,
(b) $(y) R_{x}^{-1} \varphi=(y) \varphi R_{(x) \varphi}^{-1}$,
(c) $x(y) L_{x}^{-1}=y$,
(d) $(y) R_{x}^{-1} x=y$,
(e) $x y=y x$ if and only if $(y) T_{x}=y$.

Let $S$ be a non empty subset of $L$ and $K=\{H \leq L \mid S \subset H\}$. The subloop of $L$ generated by $S$, denoted by $\langle S\rangle$, is the following subloop of $L$ :

$$
\langle S\rangle=\bigcap_{H \in K} H
$$

Proposition 2.2. ([2, Thereom 2.4]) Let $Q$ be an automorphic loop. Then
(a) Every maximal commutative subset of $Q$ is a subloop of $Q$.
(b) Every maximal associative subset of $Q$ is a subgroup of $Q$.
(c) $Q$ is power associative, that is, $\langle x\rangle$ is associative, for every $x \in Q$.

If $Q$ is non-commutative (non-associative), then by Zorn's Lemma we have that every commutative (associative) subset of $Q$ is contained in at least one maximal commutative (associative) subset of $Q$. Then the next result is a direct consequence of Proposition 2.2,

Corollary 2.3. Let $Q$ be an automorphic loop and $S$ be a non empty subset of $Q$. If $S$ is commutative (associative), then $\langle S\rangle$ is commutative (associative).

Proposition 2.4. ([2, Theorem 2.6]) Let $Q$ be an automorphic loop. Then, for all $x, y, z \in Q$ and $m, n, r \in \mathbb{Z}$ :
(a) $x^{m}\left(x^{n} y\right)=x^{n}\left(x^{m} y\right)$,
(b) $\left(y x^{m}\right) x^{n}=\left(y x^{n}\right) x^{m}$,
(c) $\left(x^{m} y\right) x^{n}=x^{m}\left(y x^{n}\right)$,
(d) $x((y x)(z x))=((x y)(x z)) x$.

As a direct consequence of the items (a), (b) and (c) of the above Proposition, we have the following result.

Corollary 2.5. Let $Q$ be an automorphic loop and $x \in Q$. Then $\left\langle L_{x^{m}}, R_{x^{n}} \mid m, n \in \mathbb{Z}\right\rangle$ is an abelian group. In particular, we have for all $m \in \mathbb{Z}$ :

$$
\begin{equation*}
T_{x}^{m}=R_{x}^{m} L_{x}^{-m}=L_{x}^{-m} R_{x}^{m} \tag{4}
\end{equation*}
$$

Remark 2.6. We will omit the parenthesis when occur one of the items (a), (b) and (c) of Proposition 2.4. For example, we will write only $x^{-1} y x$ instead of $\left(x^{-1} y\right) x$ or $x^{-1}(y x)$.

Proposition 2.7. (7, Theorem 7.5]) Every automorphic loop has the antiautomorphic inverse property (AAIP), that is, the following identity holds:

$$
\begin{equation*}
(x y)^{-1}=y^{-1} x^{-1} \tag{AAIP}
\end{equation*}
$$

The next result is a consequence of the (AAIP).
Corollary 2.8. If $Q$ is an automorphic loop and $x, y \in Q$, then

$$
\begin{equation*}
\left((y) L_{x}^{-1}\right)^{-1}=\left(y^{-1}\right) R_{x^{-1}}^{-1} \tag{5}
\end{equation*}
$$

Proposition 2.9. ([8, Lemma 2.7]) In an automorphic loop $Q$, the following holds, for all $x \in Q$ :

$$
\begin{equation*}
T_{x}^{-1}=T_{x^{-1}} \tag{6}
\end{equation*}
$$

Define $\gamma: Q \rightarrow Q$ by $(x) \gamma=x^{2}$. We say that $Q$ is uniquely 2 -divisible if $\gamma$ is a bijection. In this case, we define $x^{1 / 2}=(x) \gamma^{-1}$, for every $x \in Q$. Note that, if $\varphi \in \operatorname{Aut}(Q)$ and $x \in Q$, then

$$
\begin{equation*}
\left(x^{1 / 2}\right) \varphi=((x) \varphi)^{1 / 2} \tag{7}
\end{equation*}
$$

Proposition 2.10. ([8, Corollary 4.7]) A finite automorphic loop is uniquely 2-divisible if and only if it has odd order.

A half-isomorphism $f: L \rightarrow L^{\prime}$ is called special if the inverse mapping $f^{-1}: L^{\prime} \rightarrow L$ is also a half-isomorphism. Every trivial half-isomorphism is special. The next example presents a half-isomorphism that is not special.

Example 2.11. Let $L=\{1,2, \ldots, 7\}$ and consider the following Cayley tables:

One can see that $C_{7}=(L, *)$ is the cyclic group of order 7 and $L^{\prime}=(L, \cdot)$ is a non-associative loop. Defining $f: C_{7} \rightarrow L^{\prime} ; f(x)=x$, then it is not difficult to see that $f$ is a half-isomorphism. Furthermore,

$$
f(3 * 2)=4=f(3) \cdot f(2) \neq f(2) \cdot f(3) \quad \text { and } \quad f(3 * 6)=1=f(6) \cdot f(3) \neq f(3) \cdot f(6),
$$

then $f$ is a nontrivial half-isomorphism. Now note that $f^{-1}(2 \cdot 3)=7 \notin\{2 * 3,3 * 2\}$, and so $f^{-1}$ is not a half-isomorphism.

Proposition 2.12. ([11, Theorem 2.5]) Let $L$ and $L^{\prime}$ be loops and $f: L \rightarrow L^{\prime}$ be a halfisomorphism. Then the following statements are equivalent:
(a) $f$ is special.
(b) $\{f(x * y), f(y * x)\}=\{f(x) \cdot f(y), f(y) \cdot f(x)\}$ for any $x, y \in L$.
(c) For all $x, y \in L$ such that $x * y=y * x$, we have $f(x) \cdot f(y)=f(y) \cdot f(x)$.

Proposition 2.13. Let $L$ and $L^{\prime}$ be power associative loops and $f: L \rightarrow L^{\prime}$ be a half-isomorphism. Then $f\left(x^{n}\right)=f(x)^{n}$, for all $x \in L$ and $n \in \mathbb{Z}$.

Proof. By definition, we have $f\left(1_{L}\right)=f\left(1_{L} * 1_{L}\right)=f\left(1_{L}\right) \cdot f\left(1_{L}\right)$, and then $f\left(1_{L}\right)=1_{L^{\prime}}$. Let $x \in L$ and $n \in \mathbb{N}^{*}$. Suppose that $f\left(x^{n}\right)=f(x)^{n}$. Since $L$ and $L^{\prime}$ are power associative, we have that

$$
f\left(x^{n+1}\right)=f\left(x^{n} * x\right) \in\left\{f(x)^{n} \cdot f(x), f(x) \cdot f(x)^{n}\right\}=\left\{f(x)^{n+1}\right\} .
$$

Then $f\left(x^{m}\right)=f(x)^{m}$, for all $m \in \mathbb{N}$. Now, for $n \in \mathbb{N}$, we have that

$$
1_{L^{\prime}}=f\left(x^{n} * x^{-n}\right) \in\left\{f(x)^{n} \cdot f\left(x^{-n}\right), f\left(x^{-n}\right) \cdot f(x)^{n}\right\},
$$

and then $f\left(x^{-n}\right)=f(x)^{-n}$ since $L^{\prime}$ is power associative.

## 3 Some results about automorphic loops

In this section, we will prove that for every uniquely 2-divisible automorphic loop the equation $x \cdot(x \cdot y)=(y \cdot x) \cdot x$ is equivalent to the equation $x \cdot y=y \cdot x$. First, we need to prove some identities for automorphic loops.

Lemma 3.1. In an automorphic loop $Q$, the following identities hold:

$$
\begin{array}{r}
(x y)^{2}=\left(x \cdot(y) R_{x^{-1}}^{-1}\right) y \\
(x y)^{2}=x \cdot(x y) L_{y^{-1}}^{-1} \\
\left(x y x^{-1}\right)^{2}=(x y)\left(y x^{-1}\right) \\
\left(x^{2}\right) R_{y}^{-1}=(x) R_{\left((x) R_{y}^{-1}\right)^{-1}}^{-1} \\
(y x) x^{-1}=x^{-1}(x y) \\
x^{2}=(x) R_{y}^{-1} \cdot(x) L_{y^{-1}}^{-1} \\
\left(y^{2} x\right) x^{-1}=(y x)\left(x^{-1} y\right) \\
\left(y^{2} x\right) x^{-1}=\left(y x^{-1}\right)(x y) . \tag{15}
\end{array}
$$

Proof. (i) Consider $\varphi=R_{y}^{-1} R_{x^{-1}} L_{x y}$. We have that (1) $\varphi=(x y)\left(y^{-1} x^{-1}\right)=1$, where we used (AAIP) in the second equality, and then $\varphi \in \operatorname{Aut}(Q)$. Furthermore, $(x y) \varphi=(x y)\left(x x^{-1}\right)=x y$, and so $\left((x y)^{2}\right) \varphi=(x y)^{2}$. Thus

$$
\left((x y)^{2}\right) R_{y}^{-1} R_{x^{-1}} L_{x y}=(x y) L_{x y},
$$

and hence $(x y)^{2}=(y) L_{x} R_{x^{-1}}^{-1} R_{y}$. Since $R_{x^{-1}}^{-1} L_{x}=L_{x} R_{x^{-1}}^{-1}$ (Corollary [2.5), we get (8).
(ii) Consider $\varphi=L_{x}^{-1} L_{y^{-1}} L_{x y}$. We have that $\varphi(1)=(x y)\left(y^{-1} x^{-1}\right)=1$, where we use (AAIP) in the second equality, and then $\varphi \in \operatorname{Aut}(Q)$. Furthermore, $\varphi(x y)=(x y)\left(y^{-1} y\right)=x y$, and so $\left((x y)^{2}\right) \varphi=(x y)^{2}$. Thus

$$
\left((x y)^{2}\right) L_{x}^{-1} L_{y^{-1}} L_{x y}=(x y) L_{x y},
$$

and hence $(x y)^{2}=(x y) L_{y^{-1}}^{-1} L_{x}$ and we have (9).
(iii) Putting $y=v x^{-1}$ in (8), we get

$$
\left(x v x^{-1}\right)^{2}=\left(x\left(v x^{-1}\right) R_{x^{-1}}^{-1}\right)\left(v x^{-1}\right),
$$

and then (10) follows from the fact that $\left(v x^{-1}\right) R_{x^{-1}}^{-1}=v$.
(iv) Putting $x=(u) R_{y}^{-1}$ in (8), we get

$$
\left((u) R_{y}^{-1} y\right)^{2}=\left((u) R_{y}^{-1}(y) R_{\left((u) R_{y}^{-1}\right)^{-1}}^{-1}\right) y
$$

By Lemma 2.1 (d), we have $u=(u) R_{y}^{-1} y$, and then

$$
\left(u^{2}\right) R_{y}^{-1}=(u) R_{y}^{-1}(y) R_{\left((u) R_{y}^{-1}\right)^{-1}}^{-1},
$$

and using Lemma 2.1 (d) again and Proposition 2.4 we get

$$
\left(u^{2}\right) R_{y}^{-1}\left((u) R_{y}^{-1}\right)^{-1}=(u) R_{y}^{-1}(y) R_{\left((u) R_{y}^{-1}\right)^{-1}}^{-1}\left((u) R_{y}^{-1}\right)^{-1}=(u) R_{y}^{-1} y=u
$$

and hence we have (11).
(v) By (6), (y) $T_{x}=(y) T_{x^{-1}}^{-1}$, and then $(y) R_{x} L_{x}^{-1}=(y) L_{x^{-1}} R_{x^{-1}}^{-1}$. Thus $(y) R_{x} L_{x}^{-1} R_{x^{-1}}=$ (y) $L_{x^{-1}}$ and hence $(y) R_{x} R_{x^{-1}} L_{x}^{-1}=(y) L_{x^{-1}}$ by Corollary 2.5, It follows that $(y) R_{x} R_{x^{-1}}=$ (y) $L_{x^{-1}} L_{x}=(y) L_{x} L_{x^{-1}}$, where we used Corollary 2.5 in the second equality, and therefore we have (12).
(vi) Putting $x=(u) R_{y}^{-1}$ in (9), we get

$$
\left((u) R_{y}^{-1} y\right)^{2}=(u) R_{y}^{-1} \cdot\left((u) R_{y}^{-1} y\right) L_{y^{-1}}^{-1}
$$

and then (13) follows from the fact that $(u) R_{y}^{-1} y=u$ (Lemma 2.1 (d)).
(vii) Let $u, v \in Q$ and $\phi=R_{u} R_{u^{-1}}$. It is clear that (1) $\phi=1$, and then $\phi \in \operatorname{Aut}(Q)$. Thus $\left(v^{2}\right) \phi=((v) \phi)^{2}$, and we have $\left((v u) u^{-1}\right)^{2}=\left(v^{2} u\right) u^{-1}$. By (13), we have

$$
\begin{equation*}
\left(v^{2} u\right) u^{-1}=\left((v u) u^{-1}\right) R_{z}^{-1} \cdot\left((v u) u^{-1}\right) L_{z^{-1}}^{-1}, \text { for all } z \in Q \tag{16}
\end{equation*}
$$

(vii.1) Putting $z=u^{-1}$ in (16), we get

$$
\left(v^{2} u\right) u^{-1}=\left((v u) u^{-1}\right) R_{u^{-1}}^{-1} \cdot\left((v u) u^{-1}\right) L_{u}^{-1}=(v u) \cdot\left((v u) u^{-1}\right) L_{u}^{-1}
$$

Using (12) and Proposition 2.4 (a) we get $\left((v u) u^{-1}\right) L_{u}^{-1}=\left(u^{-1}(u v)\right) L_{u}^{-1}=\left(u\left(u^{-1} v\right)\right) L_{u}^{-1}=$ $u^{-1} v$. Therefore $\left(v^{2} u\right) u^{-1}=(v u)\left(u^{-1} v\right)$ and we have (14).
(vii.2) Putting $z=u$ in (16), we get

$$
\left(v^{2} u\right) u^{-1}=\left((v u) u^{-1}\right) R_{u}^{-1} \cdot\left((v u) u^{-1}\right) L_{u^{-1}}^{-1}
$$

Using Proposition 2.4 (b) we get $\left((v u) u^{-1}\right) R_{u}^{-1}=\left(\left(v u^{-1}\right) u\right) R_{u}^{-1}=v u^{-1}$. Using (12) we get $\left((v u) u^{-1}\right) L_{u}^{-1}=\left(u^{-1}(u v)\right) L_{u}^{-1}=u v$. Therefore $\left(v^{2} u\right) u^{-1}=\left(v u^{-1}\right)(u v)$ and we have (15).

Corollary 3.2. Let $Q$ be an automorphic loop and $x, y \in Q$. Consider that one of the following hold:
(a) $x^{-1}\left(x y^{2}\right)=(x y)\left(x^{-1} y\right)$ or
(b) $x^{-1}\left(x y^{2}\right)=\left(x^{-1} y\right)(x y)$.

Then $x y=y x$.
Proof. (a) Using (12) we get $\left(y^{2} x\right) x^{-1}=(x y)\left(x^{-1} y\right)$, and then $(x y)\left(x^{-1} y\right)=(y x)\left(x^{-1} y\right)$ by (14). Hence $x y=y x$.
(b) Using (12) we get $\left(y^{2} x\right) x^{-1}=\left(x^{-1} y\right)(x y)$, and then $\left(x^{-1} y\right)(x y)=\left(y x^{-1}\right)(x y)$ by (15). Thus $x^{-1} y=y x^{-1}$ and from Corollary 2.3 we get $x y=y x$.

Lemma 3.3. In an automorphic loop $Q$, the following identities hold:

$$
\begin{array}{r}
\left((x) R_{\left((x) R_{y}^{-1}\right)^{-1}}^{-1}\right)^{-1} \cdot(x) R_{y}^{-1}=\left((x) R_{y}^{-1}\right)^{-1} \cdot y^{-1} \\
\left(\left((x) R_{x y}^{-1}\right)^{-1} R_{x^{-1}}^{-1}\right)^{-1} \cdot x=(x) R_{y x}^{-1} \\
\left(\left(x \cdot(y) R_{z}^{-1}\right) z\right) R_{y}^{-1}=(x z) R_{y}^{-1} \cdot\left((z) R_{y}^{-1}\right)^{-1} \\
(x y) R_{z}^{-1} \cdot\left((y) R_{z}^{-1}\right)^{-1}=\left((x) R_{z}^{-1} \cdot\left((y) R_{z}^{-1}\right)^{-1}\right) R_{y} \\
x^{-1}\left((x) R_{(y) T_{x}^{-1}}^{-1} \cdot\left((y) R_{x}^{-1} R_{(y) T_{x}^{-1}}^{-1}\right)^{-1}\right)=(x) R_{(y) T_{x}^{-1}}^{-1} \cdot\left((y) R_{(y) T_{x}^{-1}}^{-1}\right)^{-1} \\
\left((x) R_{x y}^{-1}\right)^{-1} R_{\left.(y) R_{x y}^{-1} \cdot\left((x) R_{x y}^{-1}\right)\right)^{-1}}^{-1}=x . \tag{22}
\end{array}
$$

Proof. (i) We have that

$$
\begin{aligned}
\left((x) R_{y}^{-1}\right)^{-1} \cdot(x) R_{\left((x) R_{y}^{-1}\right)^{-1}}^{-1} \cdot\left((x) R_{y}^{-1}\right)^{-1} & =\left((x) R_{y}^{-1}\right)^{-1} \cdot x \\
& =\left((x) R_{y}^{-1}\right)^{-1}\left((x) R_{y}^{-1} \cdot y\right) \\
& \stackrel{\text { (12) }}{=}\left(y \cdot(x) R_{y}^{-1}\right)\left((x) R_{y}^{-1}\right)^{-1} .
\end{aligned}
$$

Then $\left((x) R_{y}^{-1}\right)^{-1} \cdot(x) R_{\left((x) R_{y}^{-1}\right)^{-1}}^{-1}=y \cdot(x) R_{y}^{-1}$, and applying (AAIP) we obtain (17).
(ii) By Lemma 2.1 (b), we have that $(x) R_{x y}^{-1} T_{x}=(x) T_{x} R_{(x y) T_{x}}^{-1}$. Since $(x) T_{x}=x$ and $(x y) T_{x}=$ $y x$, we get $(x) R_{x y}^{-1} T_{x}=(x) R_{y x}^{-1}$. By (4), $T_{x}=L_{x}^{-1} R_{x}$, and then $(x) R_{x y}^{-1} L_{x}^{-1} R_{x}=(x) R_{y x}^{-1}$. Using (5) in the left side of this equation, we get

$$
\left(\left((x) R_{x y}^{-1}\right)^{-1} R_{x^{-1}}^{-1}\right)^{-1} R_{x}=(x) R_{y x}^{-1} .
$$

Hence we have (18).
(iii) Note that $R_{\left((y) R_{z}^{-1}, z\right)}=R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1}$ since $y=(y) R_{z}^{-1} \cdot z$. Applying this automorphism to $x=(x) R_{(y) R_{z}^{-1}}^{-1} \cdot(y) R_{z}^{-1}$, we get

$$
\begin{aligned}
\left(\left(x \cdot(y) R_{z}^{-1}\right) z\right) R_{y}^{-1} & =(x) R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1} \\
& =\left((x) R_{(y) R_{z}^{-1}}^{-1} R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1} \cdot\left((y) R_{z}^{-1}\right) R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1}\right. \\
& =(x) R_{z} R_{y}^{-1} \cdot\left((y) R_{z}^{-1}\right) R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1} \\
& =(x) R_{z} R_{y}^{-1} \cdot\left(\left((y) R_{z}^{-1}\right)^{-1} R_{(y) R_{z}^{-1}} R_{z} R_{y}^{-1}\right)^{-1} \\
& =(x) R_{z} R_{y}^{-1} \cdot\left((1) R_{z} R_{y}^{-1}\right)^{-1} .
\end{aligned}
$$

Then we have (19).
(iv) Applying the automorphism $R_{\left((z) R_{y}^{-1}, y\right)}=R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1}$ to $x=(x) R_{y}^{-1} \cdot y$, we get

$$
\begin{equation*}
(x) R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1}=\left((x) R_{y}^{-1}\right) R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1} \cdot(y) R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1} \tag{23}
\end{equation*}
$$

By (19), we have

$$
\begin{gathered}
(x) R_{(z)} R_{y}^{-1} R_{y} R_{z}^{-1}=(x y) R_{z}^{-1} \cdot\left((y) R_{z}^{-1}\right)^{-1} \text { and } \\
\left((x) R_{y}^{-1}\right) R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1} \stackrel{\left((x) R_{y}^{-1} \cdot y\right) R_{z}^{-1} \cdot\left((y) R_{z}^{-1}\right)^{-1}=(x) R_{z}^{-1} \cdot\left((y) R_{z}^{-1}\right)^{-1} .}{ } .
\end{gathered}
$$

Furthermore,

$$
(y) R_{(z) R_{y}^{-1}} R_{y} R_{z}^{-1}=\left(y \cdot(z) R_{y}^{-1} \cdot y\right) R_{z}^{-1}=(y z) R_{z}^{-1}=y .
$$

Hence (20) follows from (23).
(v) From (20) we have

$$
\left((u) R_{v}^{-1} \cdot\left((x) R_{v}^{-1}\right)^{-1}\right) x=(u x) R_{v}^{-1} \cdot\left((x) R_{v}^{-1}\right)^{-1},
$$

and applying (AAIP) we get

$$
x^{-1}\left((x) R_{v}^{-1} \cdot\left((u) R_{v}^{-1}\right)^{-1}\right)=(x) R_{v}^{-1} \cdot\left((u x) R_{v}^{-1}\right)^{-1} .
$$

Putting $u=(y) R_{x}^{-1}$ and $v=(y) T_{x}^{-1}$ in this equation, we obtain (21).
(vi) From (19) we have $\left(\left(u \cdot(y) R_{x}^{-1}\right) x\right) R_{y}^{-1}=(u x) R_{y}^{-1} \cdot\left((x) R_{y}^{-1}\right)^{-1}$. Putting $u=\left((y) R_{x}^{-1}\right)^{-1}$ in this equation, we get

$$
(x) R_{y}^{-1}=\left(\left((y) R_{x}^{-1}\right)^{-1} \cdot x\right) R_{y}^{-1} \cdot\left((x) R_{y}^{-1}\right)^{-1}
$$

$$
\begin{array}{ll}
\stackrel{(200)}{\Longrightarrow} & (x) R_{y}^{-1}=\left(\left((y) R_{x}^{-1}\right)^{-1} R_{y}^{-1} \cdot\left((x) R_{y}^{-1}\right)^{-1}\right) R_{x} \\
\Longrightarrow & (x) R_{y}^{-1} R_{x}^{-1}=\left((y) R_{x}^{-1}\right)^{-1} R_{y}^{-1} \cdot\left((x) R_{y}^{-1}\right)^{-1} \\
\Longrightarrow & \left((x) R_{y}^{-1} R_{x}^{-1}\right) L_{\left((y) R_{x}^{-1}\right)^{-1} R_{y}^{-1}}^{-1}=\left((x) R_{y}^{-1}\right)^{-1} \\
\Longrightarrow & \left(\left((x) R_{y}^{-1} R_{x}^{-1}\right) L_{\left((y) R_{x}^{-1}\right)^{-1} R_{y}^{-1}}^{-1}\right)^{-1}=(x) R_{y}^{-1} \\
\xlongequal{(55)} & \left((x) R_{y}^{-1} R_{x}^{-1}\right)^{-1} R_{\left(\left((y) R_{x}^{-1}\right)^{-1} R_{y}^{-1}\right)^{-1}}^{-1}=(x) R_{y}^{-1} .
\end{array}
$$

Putting $x=w y$ in this equation and noticing that $(w y) R_{y}^{-1}=w$, we have

$$
\begin{equation*}
w=\left((w) R_{w y}^{-1}\right)^{-1} R_{\left(\left((y) R_{w y}^{-1}\right)^{-1} R_{y}^{-1}\right)^{-1}}^{-1} \tag{24}
\end{equation*}
$$

From (20) we have $(w y) R_{w y}^{-1} \cdot\left((y) R_{w y}^{-1}\right)^{-1}=\left((w) R_{w y}^{-1} \cdot\left((y) R_{w y}^{-1}\right)^{-1}\right) R_{y}$. Since $(w y) R_{w y}^{-1}=1$, it follows that

$$
\left((y) R_{w y}^{-1}\right)^{-1} R_{y}^{-1}=(w) R_{w y}^{-1} \cdot\left((y) R_{w y}^{-1}\right)^{-1}
$$

and using (AAIP) we get

$$
\left(\left((y) R_{w y}^{-1}\right)^{-1} R_{y}^{-1}\right)^{-1}=(y) R_{w y}^{-1} \cdot\left((w) R_{w y}^{-1}\right)^{-1}
$$

Putting the above equation in (24), we obtain (22).
Proposition 3.4. In an automorphic loop $Q$, the following identity holds:

$$
\begin{equation*}
(x) R_{(x) T_{y}^{-1}}^{-1} \cdot y=(y) T_{x}^{-1} \tag{25}
\end{equation*}
$$

Proof. From (17) we have $\left((u) R_{\left((u) R_{v}^{-1}\right)^{-1}}^{-1}\right)^{-1} \cdot(u) R_{v}^{-1}=\left((u) R_{v}^{-1}\right)^{-1} \cdot v^{-1}$. If $u=(x) R_{x y}^{-1}$ and $v=(y) R_{x y}^{-1} \cdot\left((x) R_{x y}^{-1}\right)^{-1}$, then $(u) R_{v}^{-1}=x$ by (22), and we get

$$
\left(\left((x) R_{x y}^{-1}\right)^{-1} R_{x^{-1}}^{-1}\right)^{-1} \cdot x=x^{-1} \cdot\left((y) R_{x y}^{-1} \cdot\left((x) R_{x y}^{-1}\right)^{-1}\right)^{-1}
$$

Using (18) in the left side and (AAIP) in the right side of this equation, we obtain

$$
(x) R_{y x}^{-1}=x^{-1}\left((x) R_{x y}^{-1} \cdot\left((y) R_{x y}^{-1}\right)^{-1}\right)
$$

Putting $w=y x$ in the above equation and noticing that $y=(w) R_{x}^{-1}$, we get

$$
(x) R_{w}^{-1}=x^{-1}\left((x) R_{x \cdot(w) R_{x}^{-1}}^{-1} \cdot\left((w) R_{x}^{-1} R_{x \cdot(w) R_{x}^{-1}}^{-1}\right)^{-1}\right)
$$

Since $(w) T_{x}^{-1}=x \cdot(w) R_{x}^{-1}$, from (21) we have

$$
(x) R_{w}^{-1}=(x) R_{(w) T_{x}^{-1}}^{-1} \cdot\left((w) R_{(w) T_{x}^{-1}}^{-1}\right)^{-1},
$$

and then

$$
\begin{equation*}
x=\left((x) R_{(w) T_{x}^{-1}}^{-1} \cdot\left((w) R_{(w) T_{x}^{-1}}^{-1}\right)^{-1}\right) R_{w} \tag{26}
\end{equation*}
$$

Putting $z=(w) T_{x}^{-1}$ in (20), we have

$$
(x w) R_{(w) T_{x}^{-1}}^{-1} \cdot\left((w) R_{(w) T_{x}^{-1}}^{-1}\right)^{-1}=\left((x) R_{(w) T_{x}^{-1}}^{-1} \cdot\left((w) R_{(w) T_{x}^{-1}}^{-1}\right)^{-1}\right) R_{w}
$$

and putting this in (26), we obtain

$$
x=(x w) R_{(w) T_{x}^{-1}}^{-1} \cdot\left((w) R_{(w) T_{x}^{-1}}^{-1}\right)^{-1}
$$

$$
\begin{aligned}
& \xrightarrow{\text { Lemma 2.1 }}(b) \quad x=\left((x w) T_{x} R_{w}^{-1} \cdot\left((w) T_{x} R_{w}^{-1}\right)^{-1}\right) T_{x}^{-1} \\
& \stackrel{(x) T_{x}=x}{\Longrightarrow} \quad x=(x w) T_{x} R_{w}^{-1} \cdot\left((w) T_{x} R_{w}^{-1}\right)^{-1} \\
& \stackrel{(x w) T_{x}=w x}{\Longrightarrow} \quad x=(w x) R_{w}^{-1} \cdot\left((w) T_{x} R_{w}^{-1}\right)^{-1} \\
& \Longrightarrow \quad x=(x) T_{w}^{-1} \cdot\left((w) T_{x} R_{w}^{-1}\right)^{-1} \\
& \Longrightarrow \quad(x) L_{(x) T_{w}^{-1}}^{-1}=\left((w) T_{x} R_{w}^{-1}\right)^{-1} \\
& \stackrel{(5)}{\Longrightarrow} \quad\left(x^{-1}\right) R_{\left(x^{-1}\right) T_{w}^{-1}}^{-1}=(w) T_{x} R_{w}^{-1} \\
& \Longrightarrow \quad\left(x^{-1}\right) R_{\left(x^{-1}\right) T_{w}^{-1}}^{-1} R_{w}=(w) T_{x} \\
& \stackrel{(6)}{\Longrightarrow} \quad\left(x^{-1}\right) R_{\left(x^{-1}\right) T_{w}^{-1}}^{-1} R_{w}=(w) T_{x^{-1}}^{-1}
\end{aligned}
$$

Let $Q$ be an automorphic loop. For $x, y \in Q$, consider the following condition:

$$
\begin{equation*}
x(x y)=(y x) x \text { if and only if } x y=y x . \tag{27}
\end{equation*}
$$

By (4), we have $T_{x}^{2}=R_{x}^{2} L_{x}^{-2}$, and then the above condition can be rewritten as:

$$
\begin{equation*}
(y) T_{x}^{2}=y \text { if and only if }(y) T_{x}=y . \tag{28}
\end{equation*}
$$

Remark 3.5. In flexible loops (and therefore in automorphic loops), $x y=y x$ implies that $x(x y)=$ ( $y x$ ) $x$.

As a consequence of (28) and Corollary [2.3, we have the following result.
Lemma 3.6. Let $Q$ be an automorphic loop satisfying (27) and let $x, y \in Q$. If $(y) T_{x}^{2}=y$, then $\langle x, y\rangle$ is commutative.

Corollary 3.7. Let $Q$ be an automorphic loop satisfying (27) and let $x, y \in Q$. If $x y x^{-1}=x^{-1} y x$, then $\langle x, y\rangle$ is commutative.

Proof. By assumption, (y) $R_{x^{-1}} L_{x}=(y) R_{x} L_{x^{-1}}$, and then $(y) R_{x^{-1}} L_{x^{-1}}^{-1}=(y) R_{x} L_{x}^{-1}$ by Corollary (2.5. Thus $(y) T_{x^{-1}}=(y) T_{x}$, and hence $(y) T_{x}^{2}=y$ by (6). Therefore the claim follows from Lemma 3.6

Theorem 3.8. Let $Q$ be an automorphic loop and $x, y \in Q$. Then

$$
x(x y)=(y x) x \text { if and only if } x^{2} y=y x^{2} .
$$

Proof. We have that

$$
\begin{aligned}
x^{2} y=y x^{2} & \Longleftrightarrow\left(x^{2}\right) T_{y}^{-1}=x^{2} \\
& \Longleftrightarrow(x) T_{y}^{-1}=\left(x^{2}\right) R_{(x) T_{y}^{-1}}^{-1} \\
& \left.\Longleftrightarrow(x) T_{y}^{-1}\right)^{2}=x^{2} \\
& \Longleftrightarrow x=\left((x) T_{y}^{-1}\right)\left((x) R_{(x) T_{y}^{-1}}^{-1}\right)^{-1} \\
& \Longleftrightarrow x^{(\mathrm{AAIP})} \\
& \Longleftrightarrow x^{-1}=(x) T_{y}^{-1}=(x) R_{\left((x) R_{(x) T_{y}^{-1}}^{-1}\right)^{-1}}^{\Longleftrightarrow} x^{-1}=\left((x) R_{(x) T_{y}^{-1}}^{-1}\left(\left(x^{-1}\right) T_{y}^{-1}\right)\right. \\
& \Longleftrightarrow\left(R_{(x) T_{y}^{-1}}^{-1}\right)\left((x) T_{y}^{-1}\right)^{-1} \\
& \Longleftrightarrow\left(x^{-1}\right) R_{\left(x^{-1}\right) T_{y}^{-1}=(x) R_{(x) T_{y}^{-1}}^{-1}}^{\Longleftrightarrow} R_{\left(x^{-1}\right) T_{y}^{-1} y=(x) R_{(x) T_{y}^{-1}}^{-1} y} \\
& \Longleftrightarrow(y) T_{x^{-1}}^{-1} T_{x}=y \\
& \Longleftrightarrow(y) T_{x^{-1}}^{-1}=(y) T_{x}^{-1} \\
& (y) T_{x}^{2}=y
\end{aligned}
$$

Corollary 3.9. If $Q$ is an uniquely 2-divisible automorphic loop, then it satisfies (27).
Proof. Let $x, y \in Q$ be such that $x(x y)=(y x) x$. By Theorem 3.8, we have that $x^{2} y=y x^{2}$, and then $\left(x^{2}\right) T_{y}=x^{2}$. Since $T_{y} \in A u t(Q)$, it follows that $(x) T_{y}=x$ by (7).

The next result is immediate from Proposition 2.10 and Corollary 3.9,
Corollary 3.10. Every automorphic loop of odd order satisfies (27).
It is clear that every commutative automorphic loop satisfies (27) and the direct product of two automorphic loops that satisfy (27) also satisfies this condition. Then there are also noncommutative automorphic loops of even whose satisfy (27).

## 4 Main results

In this section, $(Q, *)$ and $\left(Q^{\prime}, \cdot\right)$ are automorphic loops, and $f:(Q, *) \rightarrow\left(Q^{\prime}, \cdot\right)$ is a halfisomorphism. Furthermore, we consider that $Q^{\prime}$ satisfies (27), that is, for every $x, y \in Q^{\prime}$ we have

$$
x \cdot(x \cdot y)=(y \cdot x) \cdot x \text { if and only if } x \cdot y=y \cdot x
$$

Lemma 4.1. Let $x, y \in Q$ be such that $f(x * y)=f(x) \cdot f(y)$ and $f\left(y * x^{-1}\right)=f\left(x^{-1}\right) \cdot f(y)$. Then $f(x) \cdot f(y)=f(y) \cdot f(x)$.

Proof. By Proposition 2.13, $f\left(x^{-1}\right)=f(x)^{-1}$. Then using the definition of half-isomorphisms:

$$
\begin{aligned}
& f\left((x * y) * x^{-1}\right) \in U=\left\{f(x) \cdot f(y) \cdot f(x)^{-1}, f(x)^{-1} \cdot(f(x) \cdot f(y))\right\} \\
& f\left(x *\left(y * x^{-1}\right)\right) \in V=\left\{f(x) \cdot\left(f(x)^{-1} \cdot f(y)\right), f(x)^{-1} \cdot f(y) \cdot f(x)\right\}
\end{aligned}
$$

Since $(x * y) * x^{-1}=x *\left(y * x^{-1}\right)$, we have that $U \cap V \neq \emptyset$. If $f(x) \cdot f(y) \cdot f(x)^{-1}=f(x)$. $\left(f(x)^{-1} \cdot f(y)\right)$, then $f(y) \cdot f(x)^{-1}=f(x)^{-1} \cdot f(y)$, and so $f(x) \cdot f(y)=f(y) \cdot f(x)$ by Corollary 2.3. When $f(x) \cdot f(y) \cdot f(x)^{-1}=f(x)^{-1} \cdot f(y) \cdot f(x)$ we have that $f(x) \cdot f(y)=f(y) \cdot f(x)$ by Corollary 3.7. Now consider that $f\left(x * y * x^{-1}\right)=f(x)^{-1} \cdot(f(x) \cdot f(y))$.
By Lemma 3.1 (b), we have that $\left(x * y * x^{-1}\right)^{2}=(x * y) *\left(y * x^{-1}\right)$, and then

$$
\begin{equation*}
f\left(\left(x * y * x^{-1}\right)^{2}\right) \in\left\{(f(x) \cdot f(y)) \cdot\left(f(x)^{-1} \cdot f(y)\right),\left(f(x)^{-1} \cdot f(y)\right) \cdot(f(x) \cdot f(y))\right\} \tag{29}
\end{equation*}
$$

Note that $\varphi=L_{f(x)} L_{f(x)^{-1}} \in \operatorname{Aut}\left(Q^{\prime}\right)$. Then

$$
f\left(\left(x * y * x^{-1}\right)^{2}\right)=\left(f\left(x * y * x^{-1}\right)\right)^{2}=((f(y)) \varphi)^{2}=\left(f(y)^{2}\right) \varphi=f(x)^{-1} \cdot\left(f(x) \cdot f(y)^{2}\right)
$$

and putting this in (29), we get

$$
\begin{gathered}
f(x)^{-1} \cdot\left(f(x) \cdot f(y)^{2}\right)=(f(x) \cdot f(y)) \cdot\left(f(x)^{-1} \cdot f(y)\right) \text { or } \\
f(x)^{-1} \cdot\left(f(x) \cdot f(y)^{2}\right)=\left(f(x)^{-1} \cdot f(y)\right) \cdot(f(x) \cdot f(y)) .
\end{gathered}
$$

By Corollary 3.2, we get that $f(x) \cdot f(y)=f(y) \cdot f(x)$ in both cases.
Proposition 4.2. $f$ is a special half-isomorphism.

Proof. Let $x, y \in Q$ be such that $x * y=y * x$. It is suffices to prove that $f(x) \cdot f(y)=f(y) \cdot f(x)$ by Proposition 2.12,
The case $f(x * y)=f(y * x)=f(x) \cdot f(y)$ is symmetric to the case $f(y * x)=f(y) \cdot f(x)$, so we only prove the first one. If $f\left(y * x^{-1}\right)=f\left(x^{-1}\right) \cdot f(y)$, then $f(x) \cdot f(y)=f(y) \cdot f(x)$ by Lemma4.1, Now consider that $f\left(y * x^{-1}\right)=f(y) \cdot f\left(x^{-1}\right)$. By Corollary 2.3, we have that $\langle x, y\rangle$ is commutative, and then $y * x^{-1}=x^{-1} * y$ and $f\left(x^{-1} * y\right)=f(y) \cdot f\left(x^{-1}\right)$. Since $f(x * y)=f(x) \cdot f(y)$, using (AAIP) and Proposition 2.13 we get

$$
f\left(y^{-1} * x^{-1}\right)=(f(x * y))^{-1}=f(y)^{-1} \cdot f(x)^{-1}=f\left(y^{-1}\right) \cdot f\left(x^{-1}\right)
$$

By Lemma 4.1, we have that $f\left(y^{-1}\right) \cdot f\left(x^{-1}\right)=f\left(x^{-1}\right) \cdot f\left(y^{-1}\right)$, and then using (AAIP) and Proposition 2.13 we get that $f(x) \cdot f(y)=f(y) \cdot f(x)$.

Since $f$ is special, by Proposition 2.12 we have, for all $x, y \in Q$ :

$$
\begin{align*}
& \text { If } x * y=y * x \text {, then } f(x) \cdot f(y)=f(y) \cdot f(x),  \tag{30}\\
& \text { If } f(x * y)=f(x) \cdot f(y) \text {, then } f(y * x)=f(y) \cdot f(x) \text {, }  \tag{31}\\
& \text { If } f(x * y)=f(y) \cdot f(x) \text {, then } f(y * x)=f(x) \cdot f(y) \text {. } \tag{32}
\end{align*}
$$

Let $L, L^{\prime}$ be flexible loops. A mapping $f$ from $L$ into $L^{\prime}$ is called a semi-homomorphism if $f(x y x)=f(x) f(y) f(x)$, for all $x, y \in L$.

Proposition 4.3. $f$ is a semi-homomorphism.
Proof. Let $x, y \in Q$. We have two cases:
(i) $f(x * y)=f(x) \cdot f(y)$. Since $f$ is special, we have $f(y * x)=f(y) \cdot f(x)$ by (31). Then:

$$
\begin{aligned}
& f((x * y) * x) \in\{f(x) \cdot f(y) \cdot f(x), f(x) \cdot(f(x) \cdot f(y))\} \\
& f(x *(y * x)) \in\{f(x) \cdot f(y) \cdot f(x),(f(y) \cdot f(x)) \cdot f(x)\}
\end{aligned}
$$

Since $Q$ is flexible, either $f(x * y * x)=f(x) \cdot f(y) \cdot f(x)$ or

$$
\begin{equation*}
f(x * y * x)=f(x) \cdot(f(x) \cdot f(y))=(f(y) \cdot f(x)) \cdot f(x) \tag{33}
\end{equation*}
$$

In the second case, we get $f(x) \cdot f(y)=f(y) \cdot f(x)$ since $Q^{\prime}$ satisfies (27). Putting this in (33), we get $f(x * y * x)=f(x) \cdot f(y) \cdot f(x)$.
(ii) $f(x * y)=f(y) \cdot f(x)$. This case is analogous to (i).

Proposition 4.4. $Q$ satisfies (27).
Proof. Let $x, y \in Q$ be such that $x *(x * y)=(y * x) * x$. We have two cases:
(i) $f(x * y)=f(x) \cdot f(y)$. By Proposition 4.3, we have that

$$
f((x * y) * x)=(f(x) \cdot f(y)) \cdot f(x)=f(x) \cdot(f(y) \cdot f(x))=f(x *(y * x))
$$

Since $f$ is special, we get that $f(x *(x * y))=f(x) \cdot(f(x) \cdot f(y))$ and $f((y * x) * x)=(f(y) \cdot f(x)) \cdot f(x)$ by (31). Since $x *(x * y)=(y * x) * x$, we get $f(x) \cdot(f(x) \cdot f(y))=(f(y) \cdot f(x)) \cdot f(x)$, and then $f(x) \cdot f(y)=f(y) \cdot f(x)$ since $Q^{\prime}$ satisfies (27). Therefore $x * y=y * x$.
(ii) $f(x * y)=f(y) \cdot f(x)$. This case is analogous to (i).

Definition 4.5. ([6]) Let $x, y, z \in Q$. The triple $(x, y, z)$ is called a $G G$-triple of $f$ if
(i) $f(x * y)=f(x) \cdot f(y) \neq f(y) \cdot f(x)$,
(ii) $f(x * z)=f(z) \cdot f(x) \neq f(x) \cdot f(z)$.

Remark 4.6. In Example 2.11, $(3,2,6)$ is a GG-triple.
The next lemma is a well-known result about loops. A proof of it can be found in [10, Lemma 1].
Lemma 4.7. Let $L$ be a loop and $H, K$ be subloops of $L$. If $L=H \cup K$, then either $H=L$ or $K=L$.

Let $S$ be a non empty subset of a loop $L$. The commutant of $S$ is the set

$$
C_{L}(S)=\{x \in L \mid x y=y x, \forall y \in S\}
$$

If $L$ is an automorphic loop, then $C_{L}(S)$ is a subloop of $L$ [8, Proposition 2.10].
Proposition 4.8. Let $Q_{1}$ and $Q_{2}$ be automorphic loops and $\varphi: Q_{1} \rightarrow Q_{2}$ be a special halfisomorphism. If $\varphi$ has no $G G$-triple, then $\varphi$ is trivial.

Proof. Let $A=\left\{x \in Q_{1} \mid \varphi(x * u)=\varphi(x) \cdot \varphi(u), \forall u \in Q_{1}\right\}$ and $B=\left\{y \in Q_{1} \mid \varphi(y * u)=\right.$ $\left.\varphi(u) \cdot \varphi(y), \forall u \in Q_{1}\right\}$. Since $\varphi$ has no GG-triple, then $Q_{1}=A \cup B$.
For $x \in A$ and $y \in B$, we have by definition that $\varphi(x * y)=\varphi(x) \cdot \varphi(y)=\varphi(y * x)$, and then $x * y=y * x$. Thus $A \subset C_{Q_{1}}(y)$ and $B \subset C_{Q_{1}}(x)$, for all $x \in A$ and $y \in B$. Since $Q_{1}=A \cup B$, it follows by Lemma 4.7 that, for every $(x, y) \in(A, B)$, either $Q_{1}=C_{Q_{1}}(x)$ or $Q_{1}=C_{Q_{1}}(y)$.
If there exists $x \in A$ such that $C_{Q_{1}}(x) \neq Q_{1}$, then $C_{Q_{1}}(y)=Q_{1}$, for all $y \in B$, and so $\varphi(y * u)=\varphi(u) \cdot \varphi(y)=\varphi(y) \cdot \varphi(u)$, for all $u \in Q_{1}$ and $y \in B$, since $\varphi$ is special. Thus $B \subset A$, and we get that $Q_{1}=A$. Hence $\varphi$ is an isomorphism. Similarly, when $C_{Q_{1}}(x)=Q_{1}$, for all $x \in A$, we get that $A \subset B$, and then $Q_{1}=B$ and $\varphi$ is an anti-isomorphism.

For $x \in Q$, define the mapping $\phi_{x}=R_{x} L_{x^{-1}}$. Then $(u) \phi_{x}=x^{-1} * u * x=u^{x}$, for all $u \in Q$. Since (1) $\phi_{x}=1$, we have that $\phi_{x} \in \operatorname{Aut}(Q)$, and then, for all $u, v \in Q$ :

$$
\begin{equation*}
(u * v)^{x}=u^{x} * v^{x} \tag{34}
\end{equation*}
$$

Lemma 4.9. Let $x, y \in Q$.
(a) If $x * y=y * x$, then $f\left(y^{x}\right)=f(y)^{f(x)}=f(y)^{f(x)^{-1}}$.
(b) If $x * y \neq y * x$ and $f(x * y)=f(x) \cdot f(y)$, then $f\left(y^{x}\right)=f(y)^{f(x)}$ and $f\left(y^{x^{-1}}\right)=f(y)^{f(x)^{-1}}$.
(c) If $x * y \neq y * x$ and $f(x * y)=f(y) \cdot f(x)$, then $f\left(y^{x}\right)=f(y)^{f(x)^{-1}}$ and $f\left(y^{x^{-1}}\right)=f(y)^{f(x)}$.

Proof. Using the definition of half-isomorphisms, we get

$$
\begin{align*}
& f\left(x^{-1} *(x * y)\right) \in U=\left\{f(x)^{-1} \cdot f(x * y), f(x * y) \cdot f(x)^{-1}\right\}  \tag{35}\\
& f\left(x *\left(x^{-1} * y\right)\right) \in V=\left\{f(x) \cdot f\left(x^{-1} * y\right), f\left(x^{-1} * y\right) \cdot f(x)\right\} \tag{36}
\end{align*}
$$

Note that $x^{-1} *(x * y)=x *\left(x^{-1} * y\right)$, and then $U \cap V \neq \emptyset$.
(a) Since $f$ is special, we have that $f(x * y)=f(x) \cdot f(y)=f(y) \cdot f(x)$. Furthermore, $\langle x, y\rangle$ and $\langle f(x), f(y)\rangle$ are commutative by Corollary 2.3. Hence $f(x)^{-1} \cdot f(x * y)=f(x * y) \cdot f(x)^{-1}$ and by (35):
$f\left(x^{-1} * y * x\right)=f\left(x^{-1} *(x * y)\right)=f(x)^{-1} \cdot f(y) \cdot f(x)=f(x) \cdot\left(f(x)^{-1} \cdot f(y)\right)=f(x) \cdot f(y) \cdot f(x)^{-1}$.
(b) Since $f$ is special, we have that $f\left(y * x^{-1}\right)=f(y) \cdot f(x)^{-1}$ by Lemma 4.1 and (30), and then $f\left(x^{-1} * y\right)=f(x)^{-1} \cdot f(y)$ by (31). Putting this in (35) and (36), we get

$$
\begin{aligned}
& f\left(x^{-1} *(x * y)\right) \in U=\left\{f(x)^{-1} \cdot(f(x) \cdot f(y)), f(x) \cdot f(y) \cdot f(x)^{-1}\right\}, \\
& f\left(x *\left(x^{-1} * y\right)\right) \in V=\left\{f(x) \cdot\left(f(x)^{-1} \cdot f(y)\right), f(x)^{-1} \cdot f(y) \cdot f(x)\right\} .
\end{aligned}
$$

Since $f(x) \cdot f(y) \neq f(y) \cdot f(x)$, we have that $f(x)^{-1} \cdot(f(x) \cdot f(y)) \neq f(x)^{-1} \cdot f(y) \cdot f(x)$ and $f(x) \cdot f(y) \cdot f(x)^{-1} \neq f(x) \cdot\left(f(x)^{-1} \cdot f(y)\right)$. Furthermore, $f(x) \cdot f(y) \cdot f(x)^{-1} \neq f(x)^{-1} \cdot f(y) \cdot f(x)$ by Corollary 3.7. Thus

$$
f\left(x *\left(x^{-1} * y\right)\right)=f(x) \cdot\left(f(x)^{-1} \cdot f(y)\right)=f(x)^{-1} \cdot(f(x) \cdot f(y))=f\left(x^{-1} *(x * y)\right)
$$

and hence $f\left(y^{x}\right)=f(y)^{f(x)}$ and $f\left(y^{x^{-1}}\right)=f(y)^{f(x)^{-1}}$ by (31).
(c) Using (AAIP), we get $f\left(y^{-1} x^{-1}\right)=f(x)^{-1} \cdot f(y)^{-1}$. Since $f$ is special, we have $f(y) \cdot f(x)^{-1} \neq$ $f(x)^{-1} \cdot f(y)$ by (30) and Corollary [2.3, and then $f\left(x^{-1} * y\right)=f(y) \cdot f(x)^{-1}$ by Lemma 4.1. Putting this in (35) and (36), we get

$$
\begin{aligned}
& f\left(x^{-1} *(x * y)\right) \in U=\left\{f(x)^{-1} \cdot f(y) \cdot f(x),(f(y) \cdot f(x)) \cdot f(x)^{-1}\right\}, \\
& f\left(x *\left(x^{-1} * y\right)\right) \in V=\left\{f(x) \cdot f(y) \cdot f(x)^{-1},\left(f(y) \cdot f(x)^{-1}\right) \cdot f(x)\right\} .
\end{aligned}
$$

Since $f(x) \cdot f(y) \neq f(y) \cdot f(x)$, we have that $f(x)^{-1} \cdot f(y) \cdot f(x) \neq\left(f(y) \cdot f(x)^{-1}\right) \cdot f(x)$ and $(f(y) \cdot f(x)) \cdot f(x)^{-1} \neq f(x) \cdot f(y) \cdot f(x)^{-1}$. Furthermore, $f(x)^{-1} \cdot f(y) \cdot f(x) \neq f(x) \cdot f(y) \cdot f(x)^{-1}$ by Corollary 3.7. Thus

$$
f\left(x *\left(x^{-1} * y\right)\right)=\left(f(y) \cdot f(x)^{-1}\right) \cdot f(x)=(f(y) \cdot f(x)) \cdot f(x)^{-1}=f\left(x^{-1} *(x * y)\right)
$$

and hence $f\left(y^{x}\right)=f(y)^{f(x)^{-1}}$ and $f\left(y^{x^{-1}}\right)=f(y)^{f(x)}$ by (32).
Theorem 4.10. Let $(Q, *)$ and $\left(Q^{\prime}, \cdot\right)$ be automorphic loops and $f:(Q, *) \rightarrow\left(Q^{\prime}, \cdot\right)$ be a halfisomorphism. If $\left(Q^{\prime}, \cdot\right)$ satisfies (27), then $f$ is trivial.

Proof. Suppose by contradiction that $f$ has a GG-triple $(x, y, z)$. Then $x * y \neq y * x, x * z \neq z * x$, $f(x * y)=f(x) \cdot f(y)$ and $f(x * z)=f(z) \cdot f(x)$. By Lemma 4.9, we have that $f\left(y^{x}\right)=f(y)^{f(x)}$, $f\left(y^{x^{-1}}\right)=f(y)^{f(x)^{-1}}, f\left(z^{x}\right)=f(z)^{f(x)^{-1}}$ and $f\left(z^{x^{-1}}\right)=f(z)^{f(x)}$. Using (34), we get

$$
\begin{aligned}
& f\left(y^{x}\right) \cdot f\left(z^{x^{-1}}\right) \cdot f\left(y^{x}\right)=(f(y) \cdot f(z) \cdot f(y))^{f(x)} \text { and } \\
& f\left(y^{x^{-1}}\right) \cdot f\left(z^{x}\right) \cdot f\left(y^{x^{-1}}\right)=(f(y) \cdot f(z) \cdot f(y))^{f(x)^{-1}}
\end{aligned}
$$

Since $f$ is a semi-homomophism, it follows that

$$
\begin{array}{r}
f\left(y^{x} * z^{x^{-1}} * y^{x}\right)=(f(y * z * y))^{f(x)} \\
f\left(y^{x^{-1}} * z^{x} * y^{x^{-1}}\right)=(f(y * z * y))^{f(x)^{-1}} \tag{38}
\end{array}
$$

If $f(x *(y * z * y))=f(x) \cdot f(y * z * y)$, then $f\left(y^{x} * z^{x} * y^{x}\right)=f\left((y * z * y)^{x}\right)=(f(y * z * y))^{f(x)}$ by (34) and Lemma 4.9, and so $y^{x} * z^{x} * y^{x}=y^{x} * z^{x^{-1}} * y^{x}$ by (37). Thus $z^{x}=z^{x^{-1}}$, and hence $x * z=z * x$ by Proposition 4.4 and Corollary 3.7, which is a contradiction. When $f(x *(y * z * y))=f(y * z * y) \cdot f(x)$ we have that $f\left(y^{x^{-1}} * z^{x^{-1}} * y^{x^{-1}}\right)=f\left((y * z * y)^{x^{-1}}\right)=$ $(f(y * z * y))^{f(x)^{-1}}$ by (34) and Lemma 4.9, and so $y^{x^{-1}} * z^{x^{-1}} * y^{x^{-1}}=y^{x^{-1}} * z^{x} * y^{x^{-1}}$ by (38). Thus $z^{x}=z^{x^{-1}}$, and hence $x * z=z * x$ by Proposition 4.4 and Corollary 3.7, which is a contradiction.
Therefore $f$ has no GG-triple and the claim follows by Proposition 4.8,

As direct consequences of Theorem 4.10 and Corollaries 3.9 and 3.10 we have the following results.

Corollary 4.11. Every half-isomorphism between uniquely 2-divisible automorphic loops is trivial.
Corollary 4.12. Every half-isomorphism between automorphic loops of odd order is trivial.

## 5 Open problems

We proved that every half-isomorphism between loops in the class of automorphic loops satisfying (27) is special, as was demonstrated earlier for automorphic Moufang loops [6, 9]. Examples of nontrivial half-isomorphisms between automorphic loops exist (cf. [10), but so far all of them are special. We propose the conjecture that this can be generalized to all automorphic loops:

Conjecture 5.1. Every half-isomorphism between automorphic loops is special.
