# $\chi$-binding functions for some classes of $\left(P_{3} \cup P_{2}\right)$-free graphs

#### Abstract

The class of $2 K_{2}$-free graphs have been well studied in various contexts in the past. It is known that the class of $\left\{2 K_{2}, 2 K_{1}+K_{p}\right\}$-free graphs and $\left\{2 K_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs admits a linear $\chi$-binding function. In this paper, we study the classes of $\left(P_{3} \cup P_{2}\right)$-free graphs which is a superclass of $2 K_{2}$-free graphs. We show that $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs and $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs also admits linear $\chi$-binding functions. In addition, we give tight chromatic bounds for $\left\{P_{3} \cup P_{2}, H V N\right\}$-free graphs and $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graphs and it can be seen that the latter is an improvement of the existing bound given by A. P. Bharathi and S. A. Choudum [Colouring of $\left(P_{3} \cup P_{2}\right)$-free graphs, Graphs and Combinatorics 34 (2018), 97-107].

## 1 Introduction

All graphs considered in this paper are simple, finite and undirected. Let $G$ be a graph with vertex set $V(G)$ and edge set $E(G)$. For any positive integer $k$, a proper $k$-coloring of a graph $G$ is a mapping $c: V(G) \rightarrow\{1,2, \ldots, k\}$ such that adjacent vertices receive distinct colors. If a graph $G$ admits a proper $k$-coloring, then $G$ is said to be $k$-colorable. The chromatic number, $\chi(G)$, of a graph $G$ is the smallest $k$ such that $G$ is $k$-colorable. Let $P_{n}, C_{n}$ and $K_{n}$ respectively denote the path, the cycle and the complete graph on $n$ vertices. For $S, T \subseteq V(G)$, let $N_{T}(S)=N(S) \cap T$ (where $N(S)$ denotes the set of all neighbors of $S$ in $G$ ), let $\langle S\rangle$ denote the subgraph induced by $S$ in $G$ and let $[S, T]$ denote the set of all edges with one end in $S$ and the other end in $T$. If every vertex in $S$ is adjacent with every vertex in $T$, then $[S, T]$ is said to be complete. For any graph $G$, let $\bar{G}$ denote the complement of $G$.

Let $\mathcal{F}$ be a family of graphs. We say that $G$ is $\mathcal{F}$-free if it does not contain any induced subgraph which is isomorphic to a graph in $\mathcal{F}$. For a fixed graph $H$, let us denote the family of $H$-free graphs by $\mathcal{G}(H)$. If $G_{1}$ and $G_{2}$ are two vertex-disjoint graphs, then their union $G_{1} \cup G_{2}$ is the graph with vertex set $V\left(G_{1} \cup G_{2}\right)=V\left(G_{1}\right) \cup V\left(G_{2}\right)$ and edge set $E\left(G_{1} \cup G_{2}\right)=E\left(G_{1}\right) \cup E\left(G_{2}\right)$. Similarly, the join of $G_{1}$ and $G_{2}$, denoted by $G_{1}+G_{2}$, is the graph whose vertex set $V\left(G_{1}+G_{2}\right)=V\left(G_{1}\right) \cup V\left(G_{2}\right)$ and the edge set $E\left(G_{1}+G_{2}\right)=E\left(G_{1}\right) \cup E\left(G_{2}\right) \cup\left\{x y: x \in V\left(G_{1}\right), y \in V\left(G_{2}\right)\right\}$. Let $\omega(G)$ and $\alpha(G)$ denote the clique number and independence number of a graph $G$ respectively. When there is no ambiguity, $\omega(G)$ will be denoted by $\omega$.

A graph $G$ is said to be perfect if $\chi(H)=\omega(H)$, for every induced subgraph $H$ of $G$. One of the well-known conjectures on graph colorings was given by C. Berge in [2] and later proved by M. Chudnovsky et al., in [10].

Theorem 1.1 ([10]) The Strong Perfect Graph Theorem. A graph is perfect if and only if it does not contain $C_{2 k+1}$ or $\bar{C}_{2 k+1}$ as induced subgraphs, for any $k \geq 2$.

From the Strong Perfect Graph Theorem we see that, $\chi(G)=\omega(G)$ for $\left\{C_{5}, C_{7}, C_{9}, \ldots\right.$, $\left.\overline{C_{5}}, \overline{C_{7}}, \overline{C_{9}}, \ldots\right\}$-free graph $G$. Although, we cannot anticipate the same for other graph classes described in terms of some other forbidden induced subgraphs, the challenge of determining an upper bound on the chromatic number of graphs in terms of their clique number is both fascinating and difficult. In order to determine an upper bound for the chromatic number of a graph in terms of their clique number, the concept of $\chi$-binding functions was introduced by A. Gyárfás in [15]. A hereditary class $\mathcal{G}$ of graphs is said to be $\chi$-bounded [15] if there is a function $f$ (called a $\chi$-binding function) such that $\chi(G) \leq f(\omega(G))$, for every $G \in \mathcal{G}$. We say that the $\chi$-binding function $f$ is special linear if $f(x)=x+c$, where $c$ is a constant. There has been extensive research done on $\chi$-binding functions for various graph classes. See for instance, [3, 6, 7, 15-18, 23, 24]. In [15], A. Gyárfás posed a lot of questions.

The family of $2 K_{2}$-free graphs have been well studied in various contexts: domination (ElZahar and P. Erdős [12]), size (F. R. K. Chung et al., [11]), vertex coloring (S. Wagon [26], S. Gaspers and S. Huang [14], A. Gyárfás [15]), edge coloring (P. Erdős [13]) and algorithmic complexity (Z. Blázsik et al., [4]). One of the earliest results was by S. Wagon [26], in which he showed that the $\chi$-binding function for $2 K_{2}$-free graphs is $\binom{\omega+1}{2}$. Motivated by this A . Gyárfás in [15] posed a problem which asks for the order of magnitude of the smallest $\chi$-binding function for $\mathcal{G}\left(2 K_{2}\right)$. In [6], C . Brause et al., showed that the class of $\left(2 K_{2}, H\right)$-free graphs does not admit a linear $\chi$-binding function when $\alpha(H) \geq 3$. In [17], T. Karthick and S. Mishra focused on finding subfamilies of $2 K_{2}$-free graphs which admit special linear $\chi$-binding functions and proved that the families of $\left\{2 K_{2}, H\right\}$-free graphs, where $H \in\left\{H V N\right.$, diamond, $K_{1}+P_{4}, K_{1}+$ $\left.C_{4}, \overline{P_{5}}, \overline{P_{2} \cup P_{3}}, K_{5}-e\right\}$ admit special linear $\chi$-binding functions. In particular, they proved that $\left\{2 K_{2}, K_{5}-e\right\}$-free graphs and $\left\{2 K_{2}, K_{1}+C_{4}\right\}$-free graphs admit the $\chi$-binding functions $\omega(G)+4$

and $\omega(G)+5$ respectively. These bounds were later improved by Athmakoori Prashant et al., in [21,22] to $\{4$ (for $\omega(G) \leq 3$ ), 6 (for $\omega(G)=4$ ) and $\omega(G)($ for $\omega(G) \geq 5)\}$ and $\omega(G)+1$ respectively. Also, they showed that the class of $\left\{2 K_{2}, K_{2}+P_{4}\right\}$-free graphs admit a special linear $\chi$-binding function $\omega(G)+2$. In [6], C. Brause et al., improved the $\chi$-binding function for $\left\{2 K_{2}, K_{1}+P_{4}\right\}$-free graphs to $\max \{3, \omega(G)\}$. Also they proved that for $s \neq 1$ or $\omega(G) \neq 2$, the class of $\left\{2 K_{2},\left(K_{1} \cup K_{2}\right)+K_{s}\right\}$-free graphs with $\omega(G) \geq 2 s$ is perfect and for $r \geq 1$, the class of $\left\{2 K_{2}, 2 K_{1}+K_{r}\right\}$-free graphs with $\omega(G) \geq 2 r$ is perfect. Clearly when $s=2$ and $r=3$, $\left(K_{1} \cup K_{2}\right)+K_{s} \cong H V N$ and $2 K_{1}+K_{r} \cong K_{5}-e$ which implies that the class of $\left\{2 K_{2}, H V N\right\}-$ free graphs and $\left\{2 K_{2}, K_{5}-e\right\}$-free graphs are perfect for $\omega(G) \geq 4$ and $\omega(G) \geq 6$ respectively which improved the bounds given in [17].

Motivated by C. Brause et al., and their work on $2 K_{2}$-free graphs in [6], we started looking at $\left(P_{3} \cup P_{2}\right)$-free graphs which is a superclass of $2 K_{2}$-free graphs. In [3], A. P. Bharathi and S. A. Choudum obtained a $O\left(\omega^{3}\right)$ upper bound for the chromatic number of $\left(P_{3} \cup P_{2}\right)$-free graphs and obtained sharper bounds for $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$ )-free graphs. Also, T. Karthick and $\mathbf{S}$. Mishra in [18] showed that if $G$ is $\left\{P_{3} \cup P_{2}\right.$, diamond, $\left.K_{4}\right\}$-free, then $\chi(G)=6$. The subclass of diamond-free graphs have been studied in the past. See for instance [1,5,7-9, 16, 19, 25]. In this paper, by using structural results, we obtain linear $\chi$-binding functions for the class of $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs and $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs. In addition, for $\omega(G) \geq 3 p-1$ we show that the class of $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs admits a special linear $\chi$-binding function $f(x)=\omega(G)+p-1$ and $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs are perfect. We also construct an example of a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $\omega(G) \geq 3 p-1$ such that $\chi(G) \geq \omega(G)+\left\lceil\frac{p-1}{2}\right\rceil$. In addition, we give a tight $\chi$-binding function for $\left\{P_{3} \cup P_{2}, H V N\right\}$ free graphs and for $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graphs. This bound for $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graphs turns out to be an improvement of the existing bound obtained by A. P. Bharathi and S. A. Choudum in [3].

Some graphs that are considered as forbidden induced subgraphs in this paper are given in Figure 1. Notations and terminologies not mentioned here are as in [27].

## 2 Preliminaries

Throughout this paper, we use a particular partition of the vertex set of a graph $G$ as defined initially by S. Wagon in [26] and later improved by A. P. Bharathi and S. A. Choudum in [3] as follows. Let $A=\left\{v_{1}, v_{2}, \ldots, v_{\omega}\right\}$ be a maximum clique of $G$. Let us define the lexicographic ordering on the set $L=\{(i, j): 1 \leq i<j \leq \omega\}$ in the following way. For two distinct elements $\left(i_{1}, j_{1}\right),\left(i_{2}, j_{2}\right) \in$ $L$, we say that $\left(i_{1}, j_{1}\right)$ precedes $\left(i_{2}, j_{2}\right)$, denoted by $\left(i_{1}, j_{1}\right)<_{L}\left(i_{2}, j_{2}\right)$ if either $i_{1}<i_{2}$ or $i_{1}=i_{2}$ and $j_{1}<j_{2}$. For every $(i, j) \in L$, let $C_{i, j}=\left\{v \in V(G) \backslash A: v \notin N\left(v_{i}\right) \cup N\left(v_{j}\right)\right\} \backslash\left\{\begin{array}{c}\left(i^{\prime}, j^{\prime}\right)<L(i, j)\end{array} C_{i^{\prime}, j^{\prime}}\right\}$. Note that, for any $k \in\{1,2, \ldots, j\} \backslash\{i, j\},\left[v_{k}, C_{i, j}\right]$ is complete. Hence $\omega\left(\left\langle C_{i, j}\right\rangle\right) \leq \omega(G)-j+2$.

For $1 \leq k \leq \omega$, let us define $I_{k}=\left\{v \in V(G) \backslash A: v \in N\left(v_{i}\right)\right.$, for every $\left.i \in\{1,2, \ldots, \omega\} \backslash\{k\}\right\}$. Since $A$ is a maximum clique, for $1 \leq k \leq \omega, I_{k}$ is an independent set and for any $x \in I_{k}$, $x v_{k} \notin E(G)$. Clearly, each vertex in $V(G) \backslash A$ is non-adjacent to at least one vertex in $A$. Hence those vertices will be contained either in $I_{k}$ for some $k \in\{1,2, \ldots, \omega\}$, or in $C_{i, j}$ for some $(i, j) \in L$. Thus $V(G)=A \cup\left(\bigcup_{k=1}^{\omega} I_{k}\right) \cup\left(\underset{(i, j) \in L}{\cup} C_{i, j}\right)$. Sometimes, we use the partition $V(G)=V_{1} \cup V_{2}$, where $V_{1}=\underset{1 \leq k \leq \omega}{\bigcup}\left(\left\{v_{k}\right\} \cup I_{k}\right)=\underset{1 \leq k \leq \omega}{\bigcup} U_{k}$ and $V_{2}=\underset{(i, j) \in L}{\bigcup} C_{i, j}$.

Let us recall a result on $\left(P_{3} \cup P_{2}\right)$-free graphs given by A. P. Bharathi and S. A. Choudum in [3].

Theorem 2.1 ([3]) If a graph $G$ is $\left(P_{3} \cup P_{2}\right)$-free, then $\chi(G) \leq \frac{\omega(G)(\omega(G)+1)(\omega(G)+2)}{6}$.
Without much difficulty one can make the following observations on $\left(P_{3} \cup P_{2}\right)$-free graphs.

Fact 2.2 Let $G$ be a $\left(P_{3} \cup P_{2}\right)$-free graph. For $(i, j) \in L$, the following holds.
(i) Each $\left\langle C_{i, j}\right\rangle$ is a disjoint union of cliques, that is, $\left\langle C_{i, j}\right\rangle$ is $P_{3}$-free.
(ii) For every integer $s \in\{1,2, \ldots, j\} \backslash\{i, j\}, N\left(v_{s}\right) \supseteq\left\{C_{i, j} \cup A \cup\left(\bigcup_{k=1}^{\omega} I_{k}\right)\right\} \backslash\left\{v_{s} \cup I_{s}\right\}$.

Proof. (i) Suppose a $\left\langle C_{i, j}\right\rangle$ contains a $P_{3}$ say $P$, then $\left\langle\left\{V(P), v_{i}, v_{j}\right\}\right\rangle \cong P_{3} \cup P_{2}$, contradiction.
(ii) Follows immediately from the definitions of $C_{i, j}, A$ and $I_{k}, 1 \leq k \leq \omega(G)$.

When $\omega(G)=2$, by Theorem 2.1 we see that if $G$ is $\left(P_{3} \cup P_{2}\right)$-free, then $\chi(G) \leq 4$. If we consider the Grötzsch graph $\mu\left(C_{5}\right)$ in Figure 2, we can observe that $\left\langle V\left(\mu\left(C_{5}\right)\right) \backslash N\left(V\left(P_{3}\right)\right)\right\rangle$, for any $P_{3}$ in $\mu\left(C_{5}\right)$ is either $K_{1}, 2 K_{1}$ or $3 K_{1}$ and hence $\mu\left(C_{5}\right)$ is $\left(P_{3} \cup P_{2}\right)$-free. Also $\omega\left(\mu\left(C_{5}\right)\right)=2$ and $\chi\left(\mu\left(C_{5}\right)\right)=4$. Thus when $\omega(G)=2$, the bound given in Theorem 2.1 is tight. Therefore while trying to improve the bound given in Theorem 2.1 for $\left(P_{3} \cup P_{2}\right)$-free graphs we shall consider $\omega \geq 3$.

## $3\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs

Let us start Section 3 by observing that when $p=0,\left(\left(K_{1} \cup K_{2}\right)+K_{p}\right)$-free graphs will be $P_{4}$-free and hence perfect. Therefore throughout this section we will assume that $p \geq 1$. Let us make a few more observations on $\left(\left(K_{1} \cup K_{2}\right)+K_{p}\right)$-free graphs.

Proposition 3.1 Let $G$ be a $\left(\left(K_{1} \cup K_{2}\right)+K_{p}\right)$-free graph with $\omega(G) \geq p+2, p \geq 1$. Then $G$ satisfies the following.
(i) For $k, \ell \in\{1,2, \ldots, \omega(G)\},\left[I_{k}, I_{\ell}\right]$ is complete. Thus, $\left\langle V_{1}\right\rangle$ is a complete multipartite graph with $U_{k}=\left\{v_{k}\right\} \cup I_{k}, 1 \leq k \leq \omega(G)$ as its partitions.
(ii) For $j \geq p+2$ and $1 \leq i<j, C_{i, j}=\emptyset$.
(iii) For $x \in V_{2}, x$ has neighbors in at most $(p-1) U_{\ell}$ 's where $\ell \in\{1,2, \ldots, \omega(G)\}$.

Proof. Let $G$ be a $\left(\left(K_{1} \cup K_{2}\right)+K_{p}\right)$-free graph with $\omega(G) \geq p+2, p \geq 1$.
(i) For some $k, \ell \in\{1,2, \ldots, \omega\}$, suppose $\left[I_{k}, I_{\ell}\right]$ is not complete, then there exist nonadjacent vertices $a \in I_{k}$ and $b \in I_{\ell}$. Since $\omega(G) \geq p+2$, there are integers $q_{1}, q_{2}, \ldots, q_{p}$ in $\{1,2, \ldots, \omega\} \backslash\{k, \ell\}$ such that $\left\langle\left\{a, b, v_{k}, v_{q_{1}}, \ldots, v_{q_{p}}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Thus, $\left[I_{k}, I_{\ell}\right]$ is complete for any $k, \ell \in\{1,2, \ldots, \omega\}$ and thereby $\left\langle V_{1}\right\rangle$ is a complete multipartite graph with $U_{k}=\left\{v_{k}\right\} \cup I_{k}$ as its partitions.
(ii) Suppose $C_{i, j} \neq \emptyset$, for some $j \geq p+2$ and $1 \leq i<j$, let $a \in C_{i, j}$. If $S \subseteq\left\{v_{1}, v_{2}, \ldots, v_{j-1}\right\} \backslash\left\{v_{i}\right\}$ such that $|S|=p$, by the definition of $C_{i, j}$, we see that $\left\langle\left\{a, v_{i}, v_{j}, S\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Thus, $C_{i, j}=\emptyset$ for all $j \geq p+2$.
(iii) Let $x \in V_{2}$, that is, $x \in C_{i, j}$ for some $(i, j) \in L$. Suppose there exist $k(\geq p)$ distinct integers $s_{1}, s_{2}, \ldots, s_{k}$ in $\{1,2, \ldots, \omega\}$ such that $N(x) \cap U_{s_{\ell}} \neq \emptyset, 1 \leq \ell \leq k$, then we can find $u_{s_{\ell}} \in U_{s_{\ell}}$ where $x u_{s_{\ell}} \in E(G)$. Let $S=\left\{u_{s_{1}}, u_{s_{2}}, \ldots, u_{s_{k}}\right\} \backslash\left\{u_{i}, u_{j}\right\}$. If $k \geq \omega(G)-1$, then $|S| \geq k-2 \geq \omega(G)-3 \geq p-1$. Suppose $|S|=p-1$, we have $|S|=k-2$ and thus $u_{i}, u_{j} \in\left\{u_{s_{1}}, u_{s_{2}}, \ldots, u_{s_{k}}\right\}$ and we get $\left\langle\left\{v_{i}, x, u_{i}, S \cup\left\{u_{j}\right\}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Suppose $|S| \geq p$, let $S^{\prime} \subseteq S$ such that $\left|S^{\prime}\right|=p$. Then $\left\langle\left\{x, v_{i}, v_{j}, S^{\prime}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. If $k \leq \omega(G)-2$, then there exist distinct integers $q, r$ such that $\left[x, U_{q} \cup U_{r}\right]=\emptyset$ and thus $\left\langle\left\{x, v_{q}, v_{r}, u_{s_{1}}, \ldots, u_{s_{p}}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Thus (iii) holds.

Proposition 3.2 Let $G$ be a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $\omega(G) \geq p+2, p \geq 1$. Then $G$ satisfies the following.
(i) For $(i, j) \in L$, if $\omega\left(\left\langle C_{i, j}\right\rangle\right) \geq p-j+4$, then $\omega\left(\left\langle C_{k, j}\right\rangle\right) \leq 1$ for $k \neq i$ and $1 \leq k \leq j-1$.
(ii) If $\omega(G)=(p+2+k), k \geq 0$, then $\left\langle\left(\underset{j=\max \left\{2, p+1-\left\lfloor\frac{k}{2}\right\rfloor\right\}}{\substack{\bigcup_{2}}}\left(\begin{array}{l}j-1 \\ i=1\end{array} C_{i, j}\right)\right)\right\rangle$ is $P_{3}$-free.

Proof. Let $G$ be a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $\omega(G) \geq p+2, p \geq 1$.
(i) For $j \geq p+2$, by (ii) of Proposition 3.1 we see that $C_{i, j}=\emptyset$. Thus $\omega\left(\left\langle C_{i, j}\right\rangle\right)=0$ for every $i \in\{1,2, \ldots, j-1\}$. Next for $j \leq p+1$, let $\omega\left(\left\langle C_{i, j}\right\rangle\right) \geq p-j+4$. Suppose $\omega\left(\left\langle C_{k, j}\right\rangle\right) \geq 2$ for some $k \neq i$ and $1 \leq k \leq j-1$, then there exists vertices $a, b \in C_{k, j}$ such that $a b \in E(G)$. Let $S$ be the vertices of a maximum clique in $C_{i, j}$. Then, $|S|=\omega\left(\left\langle C_{i, j}\right\rangle\right) \geq p-j+4$. First, we show that $[a, S]$ is complete. On the contrary, let $x \in S$ such that $a x \notin E(G)$. If there exists a vertex $y \in S \backslash\{x\}$ such that $a y \notin E(G)$ then $\left\langle\left\{a, v_{i}, v_{j}, x, y\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Therefore $[a, S \backslash\{x\}]$ is complete and hence for any $S^{\prime} \subseteq S \backslash\{x\}$ with $\left|S^{\prime}\right|=p-j+3,\left\langle\left\{a, x, v_{k},\left\{S^{\prime} \cup\right.\right.\right.$ $\left.\left.\left.\left\{v_{1}, v_{2}, \ldots, v_{j-1}\right\} \backslash\left\{v_{i}, v_{k}\right\}\right\}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Hence, $[a, S]$ is complete. Similarly, we can prove that $[b, S]$ is also complete. Finally, if $S^{\prime \prime} \subseteq S$ such that $\left|S^{\prime \prime}\right|=p-j+4$, then we get that $\left\langle\left\{v_{k}, a, b,\left\{S^{\prime \prime} \cup\left\{v_{1}, v_{2}, \ldots, v_{j-2}\right\} \backslash\left\{v_{i}, v_{k}\right\}\right\}\right\}\right\rangle \cong\left(K_{1} \cup K_{2}\right)+K_{p}$, a contradiction. Hence, $\omega\left(\left\langle C_{k, j}\right\rangle\right) \leq 1$.
(ii) Let $\omega(G)=(p+2+k), k \geq 0$. On the contrary, let $P=\langle\{a, b, c\}\rangle$ be a $P_{3}$ in $\left\langle\left(\underset{j=\max \left\{2, p+1-\left\lfloor\frac{k}{2}\right\rfloor\right\}}{\stackrel{p+1}{\cup}}\left(\underset{i=1}{\substack{\cup}} C_{i, j}\right)\right)\right\rangle$, such that $a \in C_{i_{1}, j_{1}}, b \in C_{i_{2}, j_{2}}$ and $c \in C_{i_{3}, j_{3}}$ where max $\{2, p+$ $\left.1-\left\lfloor\frac{k}{2}\right\rfloor\right\} \leq j_{1}, j_{2}, j_{3} \leq p+1$, and $i_{\ell}<j_{\ell}, 1 \leq \ell \leq 3$. Let $j^{\prime}=\min \left\{j_{1}, j_{2}, j_{3}\right\}$. Clearly, $j^{\prime} \geq \max \left\{2, p+1-\left\lfloor\frac{k}{2}\right\rfloor\right\}$. For $1 \leq \ell \leq 3$, any vertex $x \in C_{i_{\ell}, j_{\ell}}$ has either $\left(j^{\prime}-2\right)$ or $\left(j^{\prime}-1\right)$ neighbors in $\left\{v_{1}, v_{2}, \ldots, v_{j^{\prime}-1}\right\}$. By (iii) of Proposition 3.1, we have $\left|N_{A}(x)\right| \leq p-1$ and hence the vertex $x$ has at most either $\left(p+1-j^{\prime}\right)$ or $\left(p-j^{\prime}\right)$ neighbors in $A \backslash\left\{v_{1}, v_{2}, \ldots, v_{j^{\prime}-1}\right\}$. Thus, $\left|N_{A}(V(P))\right| \leq\left(j^{\prime}-1\right)+3\left(p+1-j^{\prime}\right)=3 p-2 j^{\prime}+2$. Hence there are at least $\omega(G)-\left|N_{A}(V(P))\right|$ vertices in $A$ which are non neighbors of any of the vertex in $P$. Now, $\omega(G)-\left|N_{A}(V(P))\right| \geq$ $(p+2+k)-\left(3 p-2 j^{\prime}+2\right) \geq(-2 p+k)+2\left(\max \left\{2, p+1-\left\lfloor\frac{k}{2}\right\rfloor\right\}\right) \geq 2$. Hence, there exists vertices $v_{r}, v_{s} \in A$ such that $\left[\left\{v_{r}, v_{s}\right\}, V(P)\right]=\emptyset$ and thereby we get $\left\langle\left\{V(P), v_{r}, v_{s}\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction.

As a consequence of Proposition 3.1, we obtain Corollary 3.3 which is a result due to S. Olariu in [20].

Corollary 3.3 [20] Let $G$ be a connected graph. Then $G$ is paw-free graph if and only if $G$ is either $K_{3}$-free or complete multipartite.

Proof. For $\omega(G)=1$ or 2 there is nothing to prove. Let $\omega(G) \geq 3$. If $p=1$, then $\left(\left(K_{1} \cup K_{2}\right)+\right.$ $\left.K_{p}\right) \cong$ paw. By Proposition 3.1, $V(G)=V_{1} \cup V_{2}$ where $V_{1}$ is a complete multipartite graph,
$V_{2}=C_{1,2}$ and $\left[C_{1,2}, V_{1}\right]=\emptyset$. Since $G$ is connected, we have $C_{1,2}=\emptyset$ and thus $G$ is a complete multipartite graph. Conversely, if $G$ is either $K_{3}$-free or a complete multipartite graph, then we can observe that $G$ is paw-free.

Now, for $p \geq 1$ and $\omega \geq \max \{3,3 p-1\}$, let us determine the structural characterization and the chromatic number of $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs.

Theorem 3.4 Let $p$ be a positive integer and $G$ be a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $V(G)=V_{1} \cup V_{2}$. If $\omega(G) \geq \max \{3,3 p-1\}$, then (i) $\left\langle V_{1}\right\rangle$ is a complete multipartite graph with partition $U_{1}, U_{2}, \ldots, U_{\omega}$, (ii) $\left\langle V_{2}\right\rangle$ is $P_{3}$-free graph and (iii) $\chi(G) \leq \omega(G)+p-1$.

Proof. Let $p \geq 1$ and $G$ be a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $\omega(G) \geq \max \{3,3 p-1\}$. By (i) of Proposition 3.1, we see that $\left\langle V_{1}\right\rangle$ is a complete multipartite graph with the partition $U_{k}=\left\{v_{k}\right\} \cup I_{k}, 1 \leq k \leq \omega$. By (i) of Fact 2.2, each $\left\langle C_{i, j}\right\rangle$ is $P_{3}$-free, for every $(i, j) \in L$. Now, we show that $\left\langle V_{2}\right\rangle$ is $P_{3}$-free. Suppose there exist vertices $a, b, c \in V_{2}$ such that $\langle\{a, b, c\}\rangle \cong P_{3}$. Since $p \geq 1$ and $\omega(G) \geq 3$, we have $\omega(G) \geq 3 p-1 \geq p+2$, and hence by (iii) of Proposition 3.1, we have $\left|N_{A}(\{a, b, c\})\right| \leq 3(p-1)$. Therefore there exist distinct integers $s, t \in\{1,2, \ldots, \omega\}$ such that $\left[\{a, b, c\},\left\{v_{s}, v_{t}\right\}\right]=\emptyset$ and thus $\left\langle\left\{a, b, c, v_{s}, v_{t}\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Hence, $\left\langle V_{2}\right\rangle$ is $P_{3}$-free. Now, let us exhibit an $(\omega+p-1)$-coloring for $G$ using $\{1,2, \ldots, \omega+p-1\}$ colors. For $1 \leq k \leq \omega$, let us give the color $k$ to the vertices of $U_{k}$. Let $H$ be a component in $\left\langle V_{2}\right\rangle$. Clearly, each vertex in $H$ is adjacent to at most $p-1$ colors given to the vertices of $V_{1}$ and is adjacent to $\omega(H)-1$ vertices of $H$. Since $\omega(H) \leq \omega(G)$, each vertex is adjacent to at most $\omega(G)+p-2$ colors when coloring the vertices of $H$. Hence, there is a color available for each vertex in $H$. Similarly, all the components of $\left\langle V_{2}\right\rangle$ can be colored properly. Hence, $\chi(G) \leq \omega(G)+p-1$.

Even though we are not able to show that the bound given in Theorem 3.4 is tight, we shall show that the upper bound cannot be made smaller than $\omega+\left\lceil\frac{p-1}{2}\right\rceil$ by providing an example that requires $\omega+\left\lceil\frac{p-1}{2}\right\rceil$ colors.

For $p \geq 1$, let $X_{1}=\stackrel{p-1}{\cup} \cup_{i=1} x_{i}\left(X_{1}=\emptyset\right.$ for $\left.p=1\right), X_{2}=\bigcup_{i=p}^{\omega} x_{i}, Y_{1}={\underset{i=1}{p-1} y_{i}\left(Y_{1}=\emptyset \text { for } p=1\right), ~}_{\text {a }}$ $Y_{2}=\stackrel{\omega}{i=p} y_{i}$ and $Z={ }_{i=1}^{p-1} z_{i}(Z=\emptyset$ for $p=1)$. Also, let $X=X_{1} \cup X_{2}, Y=Y_{1} \cup Y_{2}$. Let $G^{*}$ be a graph with $V\left(G^{*}\right)=X \cup Y \cup Z$ and edge set $E\left(G^{*}\right)=\left\{\left\{x_{i} x_{j}\right\} \cup\left\{y_{i} y_{j}\right\} \cup\left\{z_{r} z_{s}\right\} \cup\right.$ $\left\{x_{m} y_{n}\right\} \cup\left\{y_{m} z_{n}\right\} \cup\left\{x_{n} z_{n}\right\}$, where $1 \leq i, j, m \leq \omega, 1 \leq r, s, n \leq p-1, i \neq j, r \neq s$ and $m \neq n\}$. That is, $X, Y$ and $Z$ form cliques and $\left[X, Y_{1}\right] \cup P M_{1}$ and $[Y, Z] \cup P M_{2}$ are complete, where $P M_{1}=\bigcup_{s=1}^{p-1} x_{s} y_{s}$ and $P M_{2}=\bigcup_{s=1}^{p-1} y_{s} z_{s}$. Also, $\left[X_{1}, Z\right]=\left\{x_{s} z_{s} \mid 1 \leq s \leq p-1\right\},\left[X_{2}, Z\right]=\emptyset$ and $\left[X, Y_{2}\right]=\emptyset$. It is easy to observe that $\omega\left(G^{*}\right)=\omega$.

We claim that $G^{*}$ is a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph. Without much difficulty, one can observe that $\alpha\left(G^{*}\right)=2$. Also, $\alpha\left(P_{3} \cup P_{2}\right)=3$. Hence, $G^{*}$ is $\left(P_{3} \cup P_{2}\right)$-free. Suppose $G^{*}$ contains $\left(K_{1} \cup K_{2}\right)+K_{p}$ as an induced subgraph. Since $[Y, Z] \cup P M_{2},\langle Y\rangle$ and $\langle Z\rangle$ are complete,

any three vertices in $Y \cup Z$ will induce a $P_{3}$ or $K_{3}$ in $G^{*}$, and thus the subgraph $K_{1} \cup K_{2}$ of $\left(K_{1} \cup K_{2}\right)+K_{p}$ cannot be in $\langle Y \cup Z\rangle$. Hence a vertex $x_{i} \in X$, for some $i \in\{1,2, \ldots, \omega\}$ should be the part of either $K_{1}$ or $K_{2}$ of $\left(K_{1} \cup K_{2}\right)+K_{p}$ in $G^{*}$. Similar to the above argument for $Y \cup Z$, the subgraph $K_{1} \cup K_{2}$ of $\left(K_{1} \cup K_{2}\right)+K_{p}$ cannot be in $\left\langle X \cup Y_{1}\right\rangle$. Hence either a vertex $z_{j} \in Z$ or $y_{k} \in Y_{2}$, for some $j \in\{1,2, \ldots, p-1\}$ and for some $k \in\{p, p+1, \ldots, \omega\}$ should be a part of $K_{1} \cup K_{2}$ of $\left(K_{1} \cup K_{2}\right)+K_{p}$ in $G^{*}$. Note that the common neighbors of the vertices $x_{i}$ and $z_{j}$ or $x_{i}$ and $y_{k}$ are contained in $Y_{1} \cup\left\{x_{j}\right\}$ or $Y_{1} \cup\left\{z_{i}\right\}$ respectively, either of these vertices does not induce a $K_{p}$ in $G^{*}$, a contradiction to the fact that $G^{*}$ contains a $\left(K_{1} \cup K_{2}\right)+K_{p}$. Hence, $G^{*}$ is a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph. Since $\alpha\left(G^{*}\right)=2$, we have $\chi\left(G^{*}\right) \geq\left\lceil\frac{\left|V\left(G^{*}\right)\right|}{\alpha\left(G^{*}\right)}\right\rceil=$ $\left\lceil\frac{2 \omega\left(G^{*}\right)+p-1}{2}\right\rceil=\omega\left(G^{*}\right)+\left\lceil\frac{p-1}{2}\right\rceil$.

Next, we obtain a linear $\chi$-binding function for $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs.
Theorem 3.5 Let $p$ be an integer greater than 1. If $G$ is a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph, then $\chi(G) \leq \begin{cases}\omega(G)+\sum_{j=2}^{p+1}(j-1)(p-j+3) & \text { for } 3 \leq \omega(G) \leq p+1 \\ \omega(G)+7(p-1)+\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3) & \text { for } \omega(G)=(p+2+k), 0 \leq k \leq 2 p-5 \\ \omega(G)+4 p-3 & \text { for } \omega(G)=3 p-2 \\ \omega(G)+p-1 & \text { for } \omega(G) \geq 3 p-1 .\end{cases}$

Proof. Let $G$ be a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph with $p \geq 2$. For $\omega(G) \geq 3 p-1$, the bound follows from Theorem 3.4. By (ii) of Proposition 3.1, we see that $C_{i, j}=\emptyset$ for all $j \geq p+2$. We know that $V(G)=V_{1} \cup V_{2}$, where $V_{1}=\underset{1 \leq \ell \leq \omega}{\cup}\left(U_{\ell}\right)$ and $V_{2}=\underset{(i, j) \in L}{\cup} C_{i, j}$. Clearly, the vertices of $V_{1}$ can be colored with $\omega(G)$ colors. Let us find an upper bound for $\chi\left(\left\langle V_{2}\right\rangle\right)$. First, let us consider the case when $3 \leq \omega(G) \leq p+1$. For $1 \leq i<j \leq p+1$, one can observe that $\omega\left(\left\langle C_{i, j}\right\rangle\right) \leq \omega(G)-j+2 \leq p-j+3$. Thus one can properly color the vertices of $\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)$ with at
$\operatorname{most}(j-1)(p-j+3)$ colors and hence $\chi(G) \leq \chi\left(\left\langle V_{1}\right\rangle\right)+\chi\left(\left\langle V_{2}\right\rangle\right) \leq \omega(G)+\sum_{j=2}^{p+1}(j-1)(p-j+3)$.
Next, let us consider $\omega(G)=(p+2+k)$, where $0 \leq k \leq 2 p-4$. By using (ii) of Proposition 3.2, $\left\langle\left(\underset{j=p-\left\lfloor\frac{k}{2}\right\rfloor+1}{p+1}\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)\right)\right\rangle$ is a $P_{3}$-free graph. By arguments mentioned in Theorem 3.4, one can color the vertices of $V(G) \backslash\left\{\begin{array}{c}\substack{\left.p-\frac{k}{2}\right\rfloor} \\ j=2\end{array}\left(\begin{array}{c}j-1 \\ i=1\end{array} C_{i, j}\right)\right\}$ with at $\operatorname{most} \omega(G)+p-1$ colors. For $k=2 p-4$, $\omega(G)=3 p-2$ and we see that $\left\langle V_{2} \backslash C_{1,2}\right\rangle$ is $P_{3}$-free and $\chi\left(\left\langle V(G) \backslash C_{1,2}\right\rangle\right) \leq \omega(G)+p-1$. Also, $\chi\left(\left\langle C_{1,2}\right\rangle\right)=\omega\left(\left\langle C_{1,2}\right\rangle\right) \leq 3 p-2$ and thus $\chi(G) \leq \omega(G)+4 p-3$. Finally, for $0 \leq k \leq 2 p-5$ and $2 \leq j \leq p-\left\lfloor\frac{k}{2}\right\rfloor$, (here $p \geq 3$ ) let us find the number of colors used for $\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)$. Suppose $\omega\left(\left\langle C_{i, j}\right\rangle\right) \geq p-j+4$ for some $(i, j) \in L$ such that $1 \leq i<j \leq p-\left\lfloor\frac{k}{2}\right\rfloor$, by (i) of Proposition 3.2, we see that $\omega\left(\left\langle C_{r, j}\right\rangle\right) \leq 1$ for $r \neq i$ and $1 \leq r \leq j-1$. Also, by (i) of Fact 2.2, each $C_{i, j}$ is a disjoint union of cliques. In this case, one can properly color the vertices of $C_{i, j}$ with $\omega\left(\left\langle C_{i, j}\right\rangle\right)$ new colors and each $C_{r, j}$ with a new color. Hence, the number of colors needed for the vertices of $\left(\cup_{i=1}^{j-1} C_{i, j}\right)$ is at most $\omega\left(\left\langle C_{i, j}\right\rangle\right)+(j-2) \leq(\omega(G)-j+2)+(j-2)=\omega(G)$. Suppose $\omega\left(\left\langle C_{i, j}\right\rangle\right) \leq(p-j+3)$ for every $(i, j) \in L$ such that $1 \leq i<j \leq p-\left\lfloor\frac{k}{2}\right\rfloor$, then one can properly color the vertices of $\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)$ with at most $(j-1)(p-j+3)$ colors. Now, for $4 \leq j \leq p-\left\lfloor\frac{k}{2}\right\rfloor$ let us compare the values of $(j-1)(p-j+3)$ and $\omega(G)$.

$$
\begin{aligned}
(j-1)(p-j+3)-\omega(G) & \geq(j-1) p-(j-1)(j-3)-(3 p-3) \\
& =(j-4) p-(j-1)(j-4)-(j-1)+3 \\
& =(j-4)(p-j)+j-4-j+4 \\
& =(j-4)(p-j) \geq 0 .
\end{aligned}
$$

Thus $(j-1)(p-j+3) \geq \omega(G)$ and hence the vertices of $\left(\bigcup_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)\right)$ can be properly colored with $\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$ colors. For $p \geq 3$ and $j=2,3,(j-1)(p-j+3) \leq 3 p-3$. Therefore the vertices of $C_{1,2}$ and $\left(C_{1,3} \cup C_{2,3}\right)$ can be properly colored with at most ( $3 p-3$ ) colors each. Hence, $\chi(G) \leq(\omega(G)+p-1)+2(3 p-3)+\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)=\omega(G)+7(p-$ 1) $+\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$.

The $\chi$-binding function obtained in Theorem 3.5 is not optimal. For instance, if $p=2,\left(K_{1}+\right.$ $\left.K_{2}\right)+K_{p} \cong H V N$. For $\omega(G) \geq 4$, we shall show that any $\left\{P_{3} \cup P_{2}, H V N\right\}$-free graph is $(\omega+1)$-colorable. This can be seen in Theorem 3.6.

Theorem 3.6 If $G$ is a $\left\{P_{3} \cup P_{2}, H V N\right\}$-free graph with $\omega(G) \geq 4$, then $\chi(G) \leq \omega(G)+1$.

Proof. For $\omega(G) \geq 5$, the bound follows from Theorem 3.4. The only remaining case is $\omega(G)=4$.

By Proposition 3.1, we see that $V(G)=V_{1} \cup V_{2}$ where $V_{1}=\underset{1 \leq k \leq 4}{\bigcup} U_{k}$ and $V_{2}=C_{1,2} \cup C_{1,3} \cup C_{2,3}$ and each vertex in $V_{2}$ is adjacent to the vertices of at most one $\bar{U}_{\ell}, \ell \in\{1,2,3,4\}$. By (i) of Fact 2.2, each $\left\langle C_{i, j}\right\rangle$ is $P_{3}$-free, where $1 \leq i<j \leq 3$. We shall show that $G$ is $\omega(G)+1=5$ colorable. Let $\{1,2,3,4,5\}$ be the set of colors. For $1 \leq k \leq 4$, let us assign the color $k$ to the vertices of $U_{k}$. In order to color the vertices of $V_{2}$, let us break the proof into two cases depending upon the presence of edges in $\left\langle C_{i, j}\right\rangle, 1 \leq i<j \leq 3$.
Case $1\left\langle C_{1,3}\right\rangle$ or $\left\langle C_{2,3}\right\rangle$ contains an edge.
First, let us assume $\left\langle C_{2,3}\right\rangle$ contains an edge, say $a b$. We claim that both $C_{1,2}$ and $C_{1,3}$ are independent sets. Suppose, there exists an edge $c d \in\left\langle C_{1, j}\right\rangle$ for $j \in\{2,3\}$. First, we show that $[\{a, b\},\{c, d\}]$ is neither empty nor complete. If $[\{a, b\},\{c, d\}]=\emptyset$, then $\left\langle\left\{a, v_{1}, v_{j}, c, d\right\}\right\rangle \cong$ $P_{3} \cup P_{2}$, a contradiction. If $[\{a, b\},\{c, d\}]$ is complete, then $\left\langle\left\{a, b, c, d, v_{1}\right\}\right\rangle \cong H V N$, a contradiction. Hence, there exists an induced $P_{3} \in\langle\{a, b, c, d\}\rangle$, say $P$. If $c d \in\left\langle C_{1,3}\right\rangle$, then $\left\langle\left\{V(P), v_{3}, v_{4}\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Thus, $C_{1,3}$ is an independent set. Let us consider $c d \in\left\langle C_{1,2}\right\rangle$. If $\left|N_{\left\{v_{3}, v_{4}\right\}}(V(P))\right| \leq 1$, then $N_{\left\{v_{3}, v_{4}\right\}}(V(P)) \subseteq\left\{v_{\ell}\right\}, \ell \in\{3,4\}$, and hence $\left\langle\left\{V(P), v_{2},\left\{v_{3}, v_{4}\right\} \backslash\left\{v_{\ell}\right\}\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Suppose $\left|N_{\left\{v_{3}, v_{4}\right\}}(V(P))\right|=2$, by (iii) of Proposition 3.1, $\left|N_{A}(c)\right|=\left|N_{A}(d)\right|=1$ and both $c, d \in V(P)$. Without loss of generality, let us assume that $c v_{3}, d v_{4} \in E(G)$ and $V(P)=\{a, c, d\}$ such that $a d \notin E(G)$. Now, we have $\left\langle\left\{v_{3}, v_{4}, d, a, b\right\}\right\rangle \cong P_{3} \cup P_{2}$ when $b d \notin E(G)$ and $\left\langle\left\{a, b, d, v_{2}, v_{3}\right\}\right\rangle \cong P_{3} \cup P_{2}$ when $b d \in E(G)$, a contradiction. Therefore $\left\langle C_{1,2}\right\rangle$ is also an independent set. Similarly when $\left\langle C_{1,3}\right\rangle$ contains an edge, we can show that both $C_{1,2}$ and $C_{2,3}$ are independent sets.

Let $\{i, k\}=\{1,2\}$. If $\left\langle C_{i, 3}\right\rangle$ contains an edge, then we can establish a 5 -coloring for $G$ by assigning the colors from $\{i, 3,4\}, 5$ and $k$ to the vertices of $C_{i, 3}, C_{1,2}$ and $C_{k, 3}$ respectively. Since $\left\langle C_{i, 3}\right\rangle$ is $P_{3}$-free, $\omega\left(\left\langle C_{i, 3}\right\rangle\right) \leq 3, C_{1,2}$ and $C_{k, 3}$ are independent sets, we observe that this is a proper 5 -coloring for $G$.
Case $2\left\langle C_{1,2}\right\rangle$ contains an edge.
Here, by Case 1, $C_{1,3}$ and $C_{2,3}$ are independent sets. Let $S \subseteq C_{1,2}$ be the vertices of a maximum clique in $\left\langle C_{1,2}\right\rangle$. Let us break this case into three subcases depending upon the size of the maximum clique $S$.
Case $2.1|S|=2$
Each vertex in $C_{1,2}$ is adjacent to at most one color in $\{1,2,3,4\}$. Let us assign the available color from $\{1,2,5\}$ to the vertices of $C_{1,2}$ and assign the color 3 and 4 to the vertices of $C_{1,3}$ and $C_{2,3}$ respectively. Since $\left\langle C_{1,2}\right\rangle$ is $P_{3}$-free, $C_{1,3}$ and $C_{2,3}$ are independent sets, this will be a proper coloring for $G$.
Case $2.2|S|=3$
If $I_{k}=\emptyset$ for every $k \in\{1,2,3,4\}$, then a coloring similar to that given in case 2.1 will give us a proper 5 -coloring for $G$. So, let us assume that $I_{k} \neq \emptyset$ for some $k \in\{1,2,3,4\}$ and let $u_{k} \in I_{k}$ and $S=\{a, b, c\}$. We show that $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right| \geq 2$. Suppose $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right| \leq 1$, without loss
of generality, let $b, c \notin N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)$. Let $\ell \in\{1,2\} \backslash\{k\}$. Now, we have $\left\langle\left\{u_{k}, v_{\ell}, v_{k}, b, c\right\}\right\rangle \cong$ $P_{3} \cup P_{2}$, a contradiction. Next, we show that $I_{q}=\emptyset$, for every $q \in\{1,2,3,4\}$ and $q \neq k$. Suppose $u_{q} \in I_{q}$, by using the above arguments we have $\left|N_{S}\left(\left\{v_{q}, u_{q}\right\}\right)\right| \geq 2$ which implies that there exists a vertex in $S$ which has a neighbor in both $\left\{v_{k}, u_{k}\right\} \subseteq U_{k}$ and $\left\{v_{q}, u_{q}\right\} \subseteq U_{q}$, a contradiction.

Now, let us establish a proper 5 -coloring for $G$. If $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right|=2$ or 3 and the vertices of $S$ are adjacent to only vertices of color $k$, then color the vertices of $S$ with the colors $\{1,2,3,4\} \backslash\{k\}$. If $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right|=2$ and the vertices of $S$ are adjacent only to the vertices of colors $k$ and $q$, then assign the color $q$ to a vertex of $N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)$ and the colors $\{1,2,3,4\} \backslash\{k, q\}$ for the remaining vertices of $S$. Similarly, we can color all the components of $\left\langle C_{1,2}\right\rangle$ by using the colors $\{1,2,3,4\} \backslash\{k\}$. Now, if $k=1$, then assign the colors $k$ and 5 to the vertices of $C_{1,3}$ and $C_{2,3}$ respectively. If $k \neq 1$, then assign the colors $k$ and 5 to the vertices of $C_{2,3}$ and $C_{1,3}$ respectively. Clearly, this is a proper coloring for $G$.
Case $2.3|S|=4$
Let $S=\{a, b, c, d\}$. We know that $C_{1,3}$ and $C_{2,3}$ are independent. In addition, we shall show that $\left(C_{1,3} \cup C_{2,3}\right)$ is also an independent set. On the contrary, let us assume that there exists an edge ef $\in E\left(\left\langle C_{1,3} \cup C_{2,3}\right\rangle\right)$, say $e \in C_{1,3}$ and $f \in C_{2,3}$. Since $\omega(G)=4$, we have $\left|N_{S}(e)\right| \leq 3$ and $\left|N_{S}(f)\right| \leq 3$. Suppose $\left|N_{S}(e)\right| \leq 2$, then there exists two vertices of $S$ which are not in $N_{S}(e)$, say $c, d$ and hence $\left\langle\left\{e, v_{2}, v_{1}, c, d\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Thus, the only possibility is $\left|N_{S}(e)\right|=3$. Similarly, we get $\left|N_{S}(f)\right|=3$. Thus, $\left|N_{S}(e) \cap N_{S}(f)\right| \geq 2$. Without loss of generality, let us assume $a, b \in\left(N_{S}(e) \cap N_{S}(f)\right)$. Since $\left|N_{A}(d)\right| \leq 1$, either $d v_{3} \notin E(G)$ or $d v_{4} \notin E(G)$. Without loss of generality, let us assume $d v_{3} \notin E(G)$ and $N_{S}(e)=\{a, b, c\}$. If $x v_{3} \notin E(G)$ for some $x \in\{a, b\}$, then $\left\langle\left\{e, x, d, v_{1}, v_{3}\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Therefore $\left[\{a, b\}, v_{3}\right]$ is complete, but even here we get $\left\langle\left\{a, b, e, f, v_{3}\right\}\right\rangle \cong H V N$, a contradiction. Hence, $\left(C_{1,3} \cup C_{2,3}\right)$ is an independent set. Next, we show that $N_{S}(x)=N_{S}(y)$ for any $x, y \in\left(C_{1,3} \cup\right.$ $\left.C_{2,3}\right)$. Suppose, $N_{S}(x) \neq N_{S}(y)$ for some $x, y \in\left(C_{1,3} \cup C_{2,3}\right)$, by similar arguments we see that $\left|N_{S}(x)\right|=\left|N_{S}(y)\right|=3$. Without loss of generality, let us assume that $N_{S}(x)=\{a, b, c\}$ and $N_{S}(y)=\{a, b, d\}$. Here $\langle\{a, b, c, x, y\}\rangle \cong H V N$, a contradiction.

Let us establish a 5 -coloring for $G$. We first consider the case when $I_{k}=\emptyset$, for all $1 \leq k \leq 4$. Since $\omega(G)=4$, there exists a vertex $x \in S$ such that $x v_{3} \notin E(G)$. Let us assign the color 3 to the vertex $x$ and color the remaining vertices of $S$ with the colors $\{1,2,5\}$. Similarly, we can color all the components of $C_{1,2}$ with the colors $\{1,2,3,5\}$. Finally assign the color 4 to the vertices of $\left(C_{1,3} \cup C_{2,3}\right)$. This yields a 5-coloring for $G$.

Let us next consider $I_{k} \neq \emptyset$, for some $k \in\{1,2,3,4\}$ and let $u_{k} \in I_{k}$. By arguments similar to that given in case 2.2, we can show that $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right| \geq 3$ and as a consequence $I_{q}=\emptyset$, for all $1 \leq q \neq k \leq 4$. Let $k \in\{3,4\}$. If $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right|=3$ or 4 and the vertices of $S$ are adjacent only to vertices with color $k$, then color the vertices of $S$ with the colors $\{1,2,3,4,5\} \backslash\{k\}$. If $\left|N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)\right|=3$ and the vertices of $S$ are adjacent only to vertices with colors $k$ and $q$, then
assign the color $q$ to a vertex of $N_{S}\left(\left\{v_{k}, u_{k}\right\}\right)$ and color the remaining vertices of $S$ with the colors $\{1,2,3,4,5\} \backslash\{k, q\}$. Similarly, we can color all the components of $\left\langle C_{1,2}\right\rangle$ with the colors $\{1,2,3,4,5\} \backslash\{k\}$. Finally, assign the color $k$ to the vertices of $\left(C_{1,3} \cup C_{2,3}\right)$. One can observe that, this is a 5 -coloring of $G$. Next let us consider $k \in\{1,2\}$. Clearly, $N_{S}\left(v_{k}\right)=\emptyset$ and thereby $\left|N_{S}\left(\left\{u_{k}\right\}\right)\right| \geq 3$, for any $u_{k} \in I_{k}$. Since $\omega(G)=4,\left|N_{S}\left(\left\{u_{k}\right\}\right)\right|=3$ for any $u_{k} \in I_{k}$. Now, we show that $\left|N_{S}\left(I_{k}\right)\right|=3$. Suppose $\left|N_{S}\left(I_{k}\right)\right|=4$, there exists at least two vertices $x, y \in I_{k}$ such that $N_{S}(x) \neq N_{S}(y)$. Without loss of generality, let us assume $N_{S}(x)=\{a, b, c\}$ and $N_{S}(y)=\{a, b, d\}$, then $\langle\{a, b, c, x, y\}\rangle \cong H V N$, a contradiction. Hence, $\left|N_{S}\left(I_{k}\right)\right|=3$ and there exists a vertex say $d \in S$ such that $d \notin N_{S}\left(\left\{v_{k}, I_{k}\right\}\right)$. Let us assign the color $k$ to the vertex $d$ and color the remaining vertices of $S$ with the colors $\{1,2,3,4\} \backslash\{k\}$. Similarly, we can color all the components of $\left\langle C_{1,2}\right\rangle$. Finally, assign the color 5 to the vertices of $\left(C_{1,3} \cup C_{2,3}\right)$. Clearly, this is a proper 5 -coloring for $G$.

For $\omega(G) \geq 4$, the bound given in Theorem 3.6 is tight. Let $G^{*}$ be the graph as shown in Figure 3 with $\omega\left(G^{*}\right) \geq 4$ and $p=2$. We have already observed that $G^{*}$ is $\left\{P_{3} \cup P_{2}, H V N\right\}$-free. Clearly, $\left|V\left(G^{*}\right)\right|=2 \omega\left(G^{*}\right)+1$ and $\alpha\left(G^{*}\right)=2$. Hence, $\chi\left(G^{*}\right) \geq\left\lceil\frac{V\left(G^{*}\right)}{\alpha\left(G^{*}\right)}\right\rceil=\left\lceil\frac{2 \omega\left(G^{*}\right)+1}{2}\right\rceil=\omega\left(G^{*}\right)+1$.

## $4 \quad\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs

Any $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs are also a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs. Hence the properties established for $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graphs are also true for $\left\{P_{3} \cup\right.$ $\left.P_{2}, 2 K_{1}+K_{p}\right\}$-free graphs. Note that when $p=0$ or $1,\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$ is $P_{3}$-free and hence perfect. Therefore we shall assume that $p \geq 2$. Let us begin Section 4, by obtaining a structural characterization and the chromatic number of $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph $G$, when $\omega(G) \geq 3 p-1$.

Theorem 4.1 Let $G$ be a $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $p \geq 2$ and $V(G)=V_{1} \cup V_{2}$. If $\omega(G) \geq 3 p-1$, then $\left\langle V_{1}\right\rangle$ is complete, $\left\langle V_{2}\right\rangle$ is $P_{3}$-free and $G$ is perfect.

Proof. Let $G$ be a $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $\omega(G) \geq 3 p-1, p \geq 2$. First, we shall observe that $I_{k}=\emptyset$ for every $k \in\{1,2, \ldots, \omega(G)\}$. On the contrary, let $u_{k} \in I_{k}$ for some $k \in\{1,2, \ldots, \omega\}$. Since $p \geq 2$ and $\omega(G) \geq 3 p-1 \geq p+1$, the vertices $u_{k}, v_{k}$ and any $p$ vertices of $A \backslash\left\{v_{k}\right\}$ will induce a $\left(2 K_{1}+K_{p}\right)$, a contradiction. Thus $V_{1}=A$ and hence complete. Since any $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph is also a $\left\{P_{3} \cup P_{2},\left(K_{1} \cup K_{2}\right)+K_{p}\right\}$-free graph, by Theorem 3.4, we see that $\left\langle V_{2}\right\rangle$ is $P_{3}$-free. Finally, to show that $G$ is perfect, by using Theorem 1.1, it is enough to show that for any $r \geq 2, C_{2 r+1}$ and $\bar{C}_{2 r+1}$ are not induced subgraphs of $G$. Since $G$ is $\left(P_{3} \cup P_{2}\right)$-free, $C_{2 q+1} \notin G, q \geq 3$. Note that $\bar{C}_{5} \cong C_{5}$ and $\omega\left(\bar{C}_{2 r+1}\right)=r$. Suppose there exists $\bar{C}_{2 r+1} \in G, r \geq 2$, then $\bar{C}_{2 r+1}$ can have at most $r$ vertices in $A$ and hence must have at least $(r+1)$
vertices in $V_{2}$ which will induced a $P_{3}$, a contradiction.
As a consequences of Theorem 3.5 and Theorem 4.1, we obtain Proposition 4.2 and Corollary 4.3.

Proposition 4.2 Let $G$ be a $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $p \geq 2$. If $\omega\left(\left\langle C_{1,2}\right\rangle\right) \geq 2 p$, then $\chi(G)=\omega(G)$.

Proof. Let $G$ be a $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $p \geq 2$ and $\omega\left(\left\langle C_{1,2}\right\rangle\right) \geq 2 p$. Since $\omega(G) \geq \omega\left(\left\langle C_{1,2}\right\rangle\right) \geq 2 p \geq p+1$, as in Theorem 4.1, we see that $V(G)=V_{1} \cup V_{2}$, where $V_{1}=A$ and $V_{2}=\underset{(i, j) \in L}{\cup} C_{i, j}$. Now if $\omega(G) \geq 3 p-1$, by Theorem 4.1, we see that $\left\langle V_{2}\right\rangle$ is $P_{3}$-free and $\chi(G)=\omega(G)$. Therefore it is enough to prove that $\chi(G)=\omega(G)$ when $2 p \leq \omega(G) \leq 3 p-2$. Let us consider $S \subseteq C_{1,2}$ such that $\langle S\rangle$ is a maximum clique in $\left\langle C_{1,2}\right\rangle$. For any vertex $a \in V_{2} \backslash C_{1,2}$, we shall show that $N_{S}(a)=S$. Suppose there exists a vertex $a \in V_{2} \backslash C_{1,2}$ such that $N_{S}(a) \neq S$, then there exists a vertex $u \in S$ such that $u a \notin E(G)$. If $\left|N_{S}(a)\right| \geq p$, then there exist $p$ vertices of $N_{S}(a)$ say $S^{\prime}$ such that $\left\langle\{a, u\} \cup S^{\prime}\right\rangle \cong 2 K_{1}+K_{p}$, a contradiction. Thus $\left|N_{S}(a)\right| \leq p-1$. By (iii) of Proposition 3.1, we have $\left|N_{A}(a)\right| \leq p-1$ and thus $\left|A \backslash N_{A}(a)\right| \geq p+1$ as $\omega(G) \geq 2 p$. Since $\omega(G) \leq 3 p-2$ and $|S| \geq 2 p$, there exists a vertex $v_{r} \in A \backslash N_{A}(a)$ such that $N_{S}\left(v_{r}\right) \neq S$ (otherwise $\omega\left(\left\langle S \cup\left\{A \backslash N_{A}(a)\right\}\right\rangle\right) \geq 3 p+1$, a contradiction). For the same reason as mentioned for $\left|N_{S}(a)\right| \leq p-1$, we see that $\left|N_{S}\left(v_{r}\right)\right| \leq p-1$. Therefore $\left|N_{S}\left(\left\{a, v_{r}\right\}\right)\right| \leq 2(p-1)$ and as a consequence there exist at least two vertices $x, y \in S$ such that $\left[\left\{a, v_{r}\right\},\{x, y\}\right]=\emptyset$. Since $a \in V_{2} \backslash C_{1,2}, a v_{t} \in E(G)$ for some $t \in\{1,2\}$, and thereby $\left\langle\left\{a, v_{t}, v_{r}, x, y\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Thus, $N_{S}(a)=S$ for any vertex $a \in V_{2} \backslash C_{1,2}$.

Since $G$ is $\left(2 K_{1}+K_{p}\right)$-free and $|S| \geq 2 p$, we see that $\left\langle V_{2} \backslash C_{1,2}\right\rangle$ is $2 K_{1}$-free. Hence $\langle S \cup$ $\left.\left\{V_{2} \backslash C_{1,2}\right\}\right\rangle$ is a clique and thus it is $P_{3}$-free. By arguments mentioned in Theorem 4.1, we get that $\left\langle A \cup S \cup\left\{V_{2} \backslash C_{1,2}\right\}\right\rangle$ is perfect and these vertices can be colored with $\omega(G)$ colors $\{1,2, \ldots, \omega(G)\}$ such that the color $i$ is assigned to vertex $v_{i}, 1 \leq i \leq \omega(G)$. Now, we show that each of the color given to the vertices of $S$ is available for every vertex in $C_{1,2} \backslash S$. Suppose there exists a color $q$ assigned to a vertex in $S$ which is unavailable to some vertex $b \in\left\langle C_{1,2} \backslash S\right\rangle$ then $N_{S}\left(v_{q}\right) \neq$ $S$ and $b v_{q} \in E(G)$. Again for the same reason as mentioned for $\left|N_{S}(a)\right| \leq p-1$, we have $\left|N_{S}\left(v_{q}\right)\right| \leq p-1$ and there exist two vertices $x, y \in S$ such that $x, y \notin N_{S}\left(v_{q}\right)$. Now, we get $\left\langle\left\{b, v_{q}, v_{1}, x, y\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Since $S$ induce a maximum clique in $\left\langle C_{1,2}\right\rangle$, the vertices in $C_{1,2} \backslash S$ can be colored using the colors assigned to the vertices of $S$. Hence $\chi(G)=$ $\omega(G)$.

Corollary 4.3 Let $G$ be a $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $p \geq 2$, then
$\chi(G) \leq \begin{cases}\omega(G)+\sum_{j=2}^{p+1}(j-1)(p-j+3) & \text { for } 3 \leq \omega(G) \leq p+1 \\ \omega(G)+2 p-1+\sum_{j=3}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3) & \text { for } \omega(G)=(p+2+k), 0 \leq k \leq 2 p-5 \\ \omega(G)+2 p-1 & \text { for } \omega(G)=3 p-2 \\ \omega(G) & \text { for } \omega(G) \geq 3 p-1 .\end{cases}$
Proof. Let $G$ be $\left\{P_{3} \cup P_{2}, 2 K_{1}+K_{p}\right\}$-free graph with $p \geq 2$. When $3 \leq \omega(G) \leq p+1$ or when $\omega(G) \geq 3 p-1$, the bound follows from Theorem 3.5 and Theorem 4.1 respectively. Hence, let us consider $\omega(G)=(p+2+k), 0 \leq k \leq 2 p-4$. As in Theorem 4.1, we see that $V(G)=V_{1} \cup V_{2}$, where $V_{1}=A$ and $V_{2}=\underset{(i, j) \in L}{\cup} C_{i, j}$. Also, by Proposition 4.2, $\chi(G)=\omega(G)$ when $\omega\left(\left\langle C_{1,2}\right\rangle\right) \geq 2 p$. Hence, we shall consider $\omega\left(\left\langle C_{1,2}\right\rangle\right) \leq 2 p-1$. By (ii) of Proposition 3.2, we see that $\left\langle\left(\underset{j=p-\left\lfloor\frac{k}{2}\right\rfloor+1}{\cup+1}\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)\right)\right\rangle$ is a $P_{3}$-free graph. As done in Theorem 4.1, we can observe that $\left\langle A \cup\left(\underset{j=p-\left\lfloor\frac{k}{2}\right\rfloor+1}{p+1}\left(\underset{i=1}{j-1} C_{i, j}\right)\right)\right\rangle$ is perfect and thus we can color the vertices of $V(G) \backslash\left\{\underset{j=2}{p-\left\lfloor\frac{k}{2}\right\rfloor}\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)\right\}$ with $\omega(G)$ colors. In particular, for $\omega(G)=3 p-2,\left\langle V_{2} \backslash C_{1,2}\right\rangle$ is $\omega(G)$-colorable and thus $\chi(G) \leq \omega(G)+2 p-1$. Finally, the cases remaining are $\omega(G)=$ $(p+2+k) \geq 4,0 \leq k \leq 2 p-5$ when $\omega\left(\left\langle C_{1,2}\right\rangle\right) \leq 2 p-1$. For the same reason as given in Theorem 3.5, the vertices of $\left(\bigcup_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}\left(\bigcup_{i=1}^{j-1} C_{i, j}\right)\right)$ can be properly colored with $\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$ colors. Hence the vertices of $V(G) \backslash\left(C_{1,2} \cup C_{1,3} \cup C_{2,3}\right)$ can be properly colored with at most $\omega(G)+\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$ colors and therefore $\chi\left(G \backslash\left(C_{1,3} \cup C_{2,3}\right)\right) \leq \omega(G)+2 p-1+$ $\sum_{j=4}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$. All that remains is to find the number of new colors required to color the vertices of $C_{1,3} \cup C_{2,3}$. Let $\{i, k\}=\{1,2\}$. First let us observe that if $\omega\left(\left\langle C_{i, 3}\right\rangle\right) \geq p+1$, then $C_{k, 3}=\emptyset$. On the contrary let $\omega\left(\left\langle C_{i, 3}\right\rangle\right) \geq p+1$ and $C_{k, 3} \neq \emptyset$. Let $a \in C_{k, 3}$ and $S \subseteq C_{i, 3}$ be vertices which induce a clique of size $p+1$. If $\left|N_{S}(a)\right| \geq p$, then there exist $p$ vertices of $N_{S}(a)$ say $S^{\prime}$ such that $\left\langle\left\{a, v_{k}\right\} \cup S^{\prime}\right\rangle \cong 2 K_{1}+K_{p}$, a contradiction. If $\left|N_{S}(a)\right| \leq p-1$, then there exist two vertices $x, y \in S$ but not in $N_{S}(a)$ and clearly $\left\langle\left\{a, v_{i}, v_{3}, x, y\right\}\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Hence if $\omega\left(\left\langle C_{i, 3}\right\rangle\right) \geq p+1$, then $C_{k, 3}=\emptyset$. Further we see that if $\omega\left(\left\langle C_{i, 3}\right\rangle\right) \geq 2 p$, then by similar arguments as in Proposition 4.2, one can color the vertices of $V(G) \backslash C_{1,2}$ with $\omega(G)$ colors and hence no new color is necessary for coloring the vertices in $C_{1,3} \cup C_{2,3}$. If $p+1 \leq \omega\left(\left\langle C_{i, 3}\right\rangle\right) \leq 2 p-1$, then $C_{1,3} \cup C_{2,3}$ can be colored with at most $2 p-1$ new colors. Suppose $\omega\left(\left\langle C_{1,3}\right\rangle\right) \leq p$ and $\omega\left(\left\langle C_{2,3}\right\rangle\right) \leq p$, the vertices of $C_{1,3} \cup C_{2,3}$ can be colored with at most $2 p$ new colors. Thus in any case, the vertices of $C_{1,3} \cup C_{2,3}$ can be colored with at most $2 p$ new colors. Also,
$(j-1)(p-j+3)=2 p$ when $j=3$. Hence, $\chi(G) \leq \omega(G)+2 p-1+\sum_{j=3}^{p-\left\lfloor\frac{k}{2}\right\rfloor}(j-1)(p-j+3)$.
When $p=2$, we see that $2 K_{1}+K_{p} \cong$ diamond and hence by Theorem 4.1 we see that $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graphs are perfect for $\omega(G) \geq 5$. This was shown by A. P. Bharathi and S. A. Choudum in [3].

Theorem 4.4 ([3]) If $G$ is a $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graph then $\chi(G) \leq \begin{cases}4 & \text { for } \omega(G)=2 \\ 6 & \text { for } \omega(G)=3 \\ 5 & \text { for } \omega(G)=4\end{cases}$ and $G$ is perfect if $\omega(G) \geq 5$.

We further improve the bound given in Theorem 4.4 by obtaining a $\omega(G)$-coloring when $\omega(G)=4$. This can be seen in Theorem 4.5.

Theorem 4.5 If $G$ is a $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graph then $\chi(G) \leq\left\{\begin{array}{ll}4 & \text { for } \omega(G)=2 \\ 6 & \text { for } \omega(G)=3 \\ 4 & \text { for } \omega(G)=4 .\end{array}\right.$ and $G$ is perfect if $\omega(G) \geq 5$.

Proof. For $\omega(G)=2, \omega(G)=3$ and $\omega(G) \geq 5$, the results follows from Theorem 4.4 and 4.1. The only remaining case is $\omega(G)=4$. Let us establish a 4-coloring for $G$ using the colors $\{1,2,3,4\}$. By Proposition 3.1 and Theorem 4.1, we see that $V(G)=V_{1} \cup V_{2}$ such that $V_{1}=A$, $V_{2}=C_{1,2} \cup C_{1,3} \cup C_{2,3}$ and each vertex in $V_{2}$ has at most one neighbor in $A$. By (ii) of Fact 2.2, each $\left\langle C_{i, j}\right\rangle$ is $P_{3}$-free, $1 \leq i<j \leq 3$. For $1 \leq k \leq 4$, let us assign the color $k$ to the vertex $v_{k}$. Let $S$ be the vertices of a maximum clique in $\left\langle C_{1,2}\right\rangle$. Now let us color $V_{2}$ by considering the possibility of $|S|$.

Case $1|S|=4$
It follows from Proposition 4.2 that $G$ is 4-colorable.
Case $2|S|=3$
Here we first observe that for any vertex $x \in C_{1,3} \cup C_{2,3},[x, S]$ is complete. Suppose $[x, S]$ is not complete, then there exists a vertex $a \in S$ such that $x a \notin E(G)$. Let $b \in S \backslash\{a\}$. If $x b \notin E(G)$, then $\left\langle\left\{\left\{x, v_{1}, v_{2}\right\}, a, b\right\}\right\rangle \cong P_{3} \cup P_{2}$. Else, $\langle S \cup\{x\}\rangle \cong$ diamond, a contradiction. Thus $[x, S]$ is complete. As a consequence we see that $\left|C_{1,3} \cup C_{2,3}\right| \leq 1$ (otherwise $\left\langle S \cup C_{1,3} \cup C_{2,3}\right\rangle$ ) will contain an induced diamond or a $K_{5}$, a contradiction). Now, color the vertices of $S$ properly with the colors $\{1,2, q\}$, where $q \in\{3,4\}$ and $C_{1,3} \cup C_{2,3}$ with $\{3,4\} \backslash\{q\}$. Next, let us show that the colors $\{1,2, q\}$ are available for every vertex in $C_{1,2} \backslash S$. Suppose there exist a vertex $u \in C_{1,2} \backslash S$ such that u cannot be colored with $q$ then $u v_{q} \in E(G)$. Since the color $q$ is given to some vertex in $S$ and $v_{q}$ being adjacent to two vertices in $S$ will yield a diamond, $\left|\left[v_{q}, S\right]\right| \leq 1$.

Hence $\left[v_{q},\{a, b\}\right]=\emptyset$ for some $a, b \in S$ and therefore $\left\langle u, v_{q}, v_{1}, a, b\right\rangle \cong P_{3} \cup P_{2}$, a contradiction. Thus we get a proper 4 -coloring for $G$.

Case $3|S| \leq 2$
Here if $\omega\left(\left\langle C_{1,3}\right\rangle\right) \leq 1$ and $\omega\left(\left\langle C_{2,3}\right\rangle\right) \leq 1$, then we can properly color the vertices of $C_{1,2}, C_{1,3}$ and $C_{2,3}$ with the colors $\{1,2\}, 3$ and 4 respectively. Suppose $\left\langle C_{1,3}\right\rangle$ or $\left\langle C_{2,3}\right\rangle$ contains an edge. Without loss of generality, let $a b \in E\left(\left\langle C_{1,3}\right\rangle\right)$. As in Case 1 of Theorem 3.6 we can see that $C_{1,2}$ and $C_{2,3}$ are independent sets. In addition, we can show that $C_{2,3}=\emptyset$. Suppose $C_{2,3} \neq \emptyset$, let $x \in C_{2,3}$. If $\langle\{x, a, b\}\rangle \cong K_{3}$, then $\left\langle\left\{x, a, b, v_{2}\right\}\right\rangle \cong$ diamond. If $\langle\{x, a, b\}\rangle \cong P_{3}$, then $\left\langle\left\{x, a, b, v_{3}, v_{4}\right\}\right\rangle \cong P_{3} \cup P_{2}$. If $[x,\{a, b\}]=\emptyset$, then $\left\langle\left\{x, v_{1}, v_{3}, a, b\right\}\right\rangle \cong P_{3} \cup P_{2}$. Hence we get a contradiction in all the cases. Therefore, $C_{2,3}=\emptyset$ and $|S| \leq 1$. Since $\omega(G)=4$, we see that $\omega\left(\left\langle C_{1,3}\right\rangle\right) \leq 3$ and thereby we can properly color the vertices of $C_{1,2}$ and $C_{1,3}$ with the colors 2 and $\{1,3,4\}$ respectively. Thus we have a proper 4 -coloring for $G$.

Let $G$ be the complement of the Schläfli graph (see, www.distanceregular.org/graphs/complementschlafli.html). Note that $G$ is a 10 -regular graph with 27 vertices such that any two adjacent vertices have exactly one common neighbor (see, http://en.wikipedia.org/wiki/Locally_linear_graph) and hence $G$ is diamond-free. Next, we shall observe that $G$ is $\left(P_{3} \cup P_{2}\right)$-free. Let $u v \cong P_{2}$ in $G$. The vertices $u$ and $v$ have exactly one common neighbor, say $w$. The ends of the edges $u v, v w$ and $w u$ does not have a common neighbor other than $w, u$ and $v$ respectively. Since $G$ is 10regular, each of $u, v$ and $w$ should have exactly 8 distinct neighbors. Clearly, $|V(G)|-|N(u, v)|=$ $27-(3+8+8)=8$. Thus $V(G) \backslash\{N(u, v)\}=N(w) \backslash\{u, v\}$. If $N(w) \backslash\{u, v\}$ contains an induced $P_{3}$, then $\left\langle\left\{w, V\left(P_{3}\right)\right\}\right\rangle \cong$ diamond, a contradiction. Hence $G$ is $\left(P_{3} \cup P_{2}\right)$-free. Also, $\omega(G)=3$ and $\chi(G)=6$ (see, www.win.tue.nl/~aeb/graphs/Schlaefli.html). In addition, the Grötzsch graph $\mu\left(C_{5}\right)$ given in Figure 2 is an example of a $\left\{P_{3} \cup P_{2}\right.$, diamond $\}$-free graph with $\omega\left(\mu\left(C_{5}\right)\right)=2$ and $\chi\left(\mu\left(C_{5}\right)\right)=4$. Thus the bounds given in Theorem 4.5 are optimal for all the values of $\omega(G)$.
