# THERMODYNAMIC FORMALISM AND LARGE DEVIATION PRINCIPLE OF MULTIPLICATIVE ISING MODELS

#### Abstract

The aim of this study is tree-fold. First, we investigate the thermodynamics of the Ising models with respect to 2-multiple Hamiltonians. This extends the previous results of [Chazotte and Redig, Electron. J. Probably., $2014]$ to $\mathbb{N}^{d}$. Second, we establish the large deviation principle (LDP) of the average $\frac{1}{N} S_{N}^{G}$, where $S_{N}^{G}$ is a 2-multiple sum along a semigroup generated by k numbers which are k co-primes. This extends the previous results [Ban et al. Indag. Math., 2021] to a board class of the long-range interactions. Finally, the results described above are generalized to the multidimensional lattice $\mathbb{N}^{d}, d \geq 1$.


## 1. Introduction

In this article, we investigate the thermodynamic formalism (e.g., Gibbs measures, entropy and pressure functions) and the large deviation principle of the multiplicative Ising models on $\mathbb{N}^{d}, d \geq 1$. Before presenting the main results, we provide the motives behind this study. Consider the lattice spin systems with Ising $\pm 1$ spins on $\mathbb{N}$. The Hamiltonian of the standard Ising model on each configuration $\sigma \in\{-1,+1\}^{\mathbb{N}}$ is

$$
H(\sigma)=-\beta\left(\sum_{i \in \mathbb{N}} J \sigma_{i} \sigma_{i+1}+h \sum_{i \in \mathbb{N}} \sigma_{i}\right)
$$

where the parameter $\beta$ is the inverse temperature, $J$ is the coupling strength and $h$ stands for the magnetic field. Note that the Hamiltonian $H(\sigma)$ is a nearest neighbor translation-invariant interaction. The thermodynamics of the Ising models, e.g., the existence of the Gibbs measure, phase transition problem, entropy and pressure functions have been studied in depth. The best reference on this topic is [16].

Motivated from multiple ergodic theory (we refer the reader to [11, 19] for detailed definitions and recent advances in multiple ergodic theory) and the previous works of Kifer [20, Kifer and Varadhan [21, Fan, Liao and Ma [13] on the nonconventional averages, Carinci et al. 7] and Chazottes and Redig [8] investigate the 'multiplicative Ising models'. That is, they consider the Hamiltonian on each

[^0]configuration $\sigma \in\{-1,+1\}^{\mathbb{N}}$ as

H^{[m]}(\sigma)=-\beta\left(\sum_{i \in \mathbb{N}} J \sigma_{i} \sigma_{2 i}+h \sum_{i \in \mathbb{N}} \sigma_{i}\right)
$$

It should be noted that the Hamiltonian $H^{[m]}(\sigma)$ is a long-range non-translation invariant interaction. For $h=0$, the existence and uniqueness of the Gibbs measure with respect to $H^{[m]}(\sigma)$ is constructed [8], which is multiplication invariant.

Theorem 1.1 (Theorem 3.2 [8]). Let

be the finite-volume probability measure corresponding to the Hamiltonian

$$
H_{N}\left(\sigma_{\mathcal{N}_{2 N}}\right)=-\beta \sum_{i=1}^{N} \sigma_{i} \sigma_{2 i}
$$

Then

1. Unique limit measure : The measure $\mu_{N}$ have a unique weak limit denoted by $\mu_{\infty}$ which is the Gibbs measure.
2. Independent Ising layers : Under $\mu_{\infty}$, the $\left\{\tau_{\ell}^{i}=\sigma_{i 2^{\ell}}\right\}_{\ell=0}^{\infty}, i \in 2 \mathbb{N}_{0}+1$ are independent and distributed according to the standard Ising model measure $\mu_{\infty}^{I \operatorname{sing}}$ with a free boundary condition on the left.
3. Multiplication invariance : The measure $\mu_{\infty}$ is multiplication invariant, i.e., for all $i \in \mathbb{N}, \sigma=\left(\sigma_{j}\right)_{j=1}^{\infty}$ and $T_{i} \sigma=\left(\sigma_{i j}\right)_{j=1}^{\infty}$ have the same distribution.

Carinci et al. 7] established the large deviation principle of the average $\frac{1}{N} S_{N}(\sigma):=$ $\frac{1}{N} \sum_{i=1}^{N} \sigma_{i} \sigma_{2 i}$ by calculating the rigorous formula of the free energy function

F_{r}(\beta)=F_{\mathbb{P}_{r}}(\beta)=\lim _{N \rightarrow \infty} \frac{1}{N} \log \mathbb{E}_{\mathbb{P}_{r}}\left(e^{\beta S_{N}}\right)
$$

where $\mathbb{P}_{r}$ is the product of Bernoulli measures with the parameter $r$ on two symbols $\{-1,+1\}$.

Theorem 1.2 (Theorem 4.1 [7]). The explicit expression of the free energy function associated to the multiple sum $S_{N}$ is

F_{r}(\beta)=\log \left((r(1-r))^{\frac{3}{4}}\left|v^{T} \cdot e_{+}\right| \Lambda_{+}\right)+\mathcal{G}(\beta)
$$

where

\mathcal{G}(\beta)=\frac{1}{2} \sum_{\ell=1}^{\infty} \frac{1}{2^{\ell}} \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{\ell}\right)
$$

and $\Lambda_{ \pm}=e^{\beta}\left(\cosh (h) \pm \sqrt{\sinh ^{2}(h)+e^{-4 \beta}}\right), v^{T}=\left(e^{h / 2}, e^{-h / 2}\right), h=\frac{1}{2} \log (r /(1-$ $r)), e_{+}=\frac{w_{+}}{\left\|w_{+}\right\|}$with $w_{+}=\left(-e^{-\beta}, e^{h+\beta}-\Lambda_{+}\right)^{T}$.

Theorem 1.2 has been recently generalized to multidimensional lattice $\mathbb{N}^{d}, d \geq 1$ [2].

Theorem 1.3 (Theorem $3.2[2])$. For any $d \geq 1$ and $\mathbf{p}=\left(p_{1}, \ldots, p_{d}\right) \in \mathbb{N}^{d}$, the following statements hold true.

1. The explicit expression of the free energy function associated to the multiple sum ${ }^{2}$

S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{p}}=\frac{1}{N_{1} \cdots N_{d}} \sum_{\mathbf{i} \in \mathcal{N}_{N_{1} \times \cdots \times N_{d}}} \sigma_{\mathbf{i}} \sigma_{\mathbf{i} \cdot \mathbf{p}}
$$

is

F_{r}(\beta)=\frac{2 p_{1} \cdots p_{d}-1}{2 p_{1} \cdots p_{d}} \log (r(1-r))+\frac{p_{1} \cdots p_{d}-1}{p_{1} \cdots p_{d}} \log \left|v^{T} \cdot e_{+}\right|^{2}+\log \Lambda_{+}+\mathcal{G}(\beta)
$$

where $\Lambda_{ \pm}, v^{T}, h, e_{+}$are defined as above and

\mathcal{G}(\beta)=\sum_{\ell=1}^{\infty} \frac{\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{\ell+1}} \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{\ell}\right)

2. The function $F_{r}(\beta)$ is differentiable with respect to $\beta \in \mathbb{R}$.
3. The multiple average satisfies a $L D P$ with rate function given by

I_{r}(x)=\sup _{\beta \in \mathbb{R}}\left(\beta x-F_{r}(\beta)\right)
$$

Furthermore, if $\left(F_{r}\right)^{\prime}(\eta)=y$, then $I_{r}(y)=\eta y-F_{r}(\eta)$.
The aim of this paper is to study the multiplcative Ising models on $\mathbb{N}^{d}$ and the objective is three-fold.

1. The thermodynamics of the Ising model with respect to 2-multiple Hamiltonian: We establish the thermodynamics formalsm of the multiplicative Ising models on multidimensional lattice $\mathbb{N}^{d}$ with respect to the Hamiltonian $\sum_{i \in \mathbb{N}} \sigma_{i} \sigma_{2 i}$ (call it 2-multiple Hamiltonian). Theorem 3.3 extends Theorem 1.1 to $\mathbb{N}^{d}$ and the formula of the Kolmogorov-Sinai (KS) entropy with respect to the limiting measure constructed in Theorem 3.3 is presented in Theorem 3.9.
2. The large deviation principle of the average $\frac{1}{N} S_{N}^{G}$ : Let $k \geq 1$ and $p_{1}, \ldots, p_{k}$ be co-primes, and $G=\left\langle p_{1}, \ldots, p_{k}\right\rangle=\left\{1=\ell_{1}<\ell_{2}<\cdots\right\}$ be a semigroup generated by $p_{1}, \ldots, p_{k}$. The rigorous formula for the free energy function and the large deviation principle with respect to the average $S_{N}^{G}(\sigma):=\sum_{i=1}^{N} \sigma_{\ell_{j(i)}} \sigma_{\ell_{j(i)+1}}$ on $\mathbb{N}$ is given in Theorem 4.1. Clearly, 2-multiple Hamiltonian is a special case of the $S_{N}^{G}$ with $G=\langle 2\rangle$. Therefore, Theorem 4.1 can be seen as a generalization of Theorem 1.2 to a board class of the long-range non-translation invariant interactions.
3. The $\mathbb{N}^{d}$ version of the aforementioned results: The $\mathbb{N}^{d}$ version of Theorem 4.1 (or the generalization of Theorem 1.3 ) are presented in Theorems 4.4 and 4.5 . We remark that Theorem 4.4 provides a general formula for $F_{r}(\beta)$. Meanwhile, Theorem 4.5 presents a explicit formula for $F_{r}(\beta)$ if the sum of $F_{r}(\beta)$ is along some specific direction. In this circumstance, we call $F_{r}(\beta)$ the directional free energy

function which is defined in Section 4.2. We emphasize that the calculation of the rigorous formula for $F_{r}(\beta)$ along other directions is extremely difficult since the independent sublattices according to the constrains $\mathbf{G}$ are quite hard to analysis. The notation $\mathbf{G}$ represents the semigroup generated by the vectors $\mathbf{p}_{1}, \ldots, \mathbf{p}_{k} \in \mathbb{N}^{d}$, the formal definition can be found in Section 2. And the generlizations of Theorems 3.3 and 3.9 are given in Theorems 3.6 and 3.11 respectively.

We remark that Peres et al. [22] computed the Hausdorff and Minkowski dimensions of the set

where $\Omega \subseteq \Sigma_{m}:=\{0, \ldots, m-1\}^{\mathbb{N}}$ and $\left.x\right|_{i G}:=\left(x_{i \ell_{k}}\right)_{k=1}^{\infty}$. The work of [22] concerns the decomposition of the lattices $\mathbb{N}$ into independent sublattices according to the multiple constraints $G$ and calculates its density among the entire lattice $\mathbb{N}$. The study can be regarded as a study of the thermodynamic formalism of $X_{\Omega}^{G}$ with the potential function $S_{N}^{G}$ in $\mathbb{N}^{d}, d \geq 1$. In addition, the challenge of the current problem is to look at the same issue as [22] in $\mathbb{N}^{d}, d \geq 1$. The results can be summarized in the following table.

## 2. Preliminaries

In this section, we provide necessary materials and results on the decomposition of the multidimensional lattice $\mathbb{N}^{d}$ into independent sublattices and calculate their densities.

Let $\mathbf{p}_{1}, \ldots, \mathbf{p}_{k} \in \mathbb{N}^{d}$ with $\mathbf{p}_{i}=\left(p_{i 1}, \ldots, p_{i d}\right)$ for all $1 \leq i \leq k$. Denote by $\mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}=$ $\left\{\left(i_{1}, \ldots, i_{d}\right) \in \mathbb{N}^{d}: p_{j 1} \nmid i_{1}\right.$ or $\ldots$ or $p_{j d} \nmid i_{d}$ for all $\left.1 \leq j \leq k\right\}, \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}=$ $\left\{\left(p_{11}^{\ell_{1}} \cdots p_{k 1}^{\ell_{k}}, \ldots, p_{1 d}^{\ell_{1}} \cdots p_{k d}^{\ell_{k}}\right): \ell_{j} \geq 0\right.$ for all $\left.1 \leq j \leq k\right\}$ and

is the lattice $\mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$ that starts at $\mathbf{i}$. We also need the following definitions.
Definition 2.1. For $N_{1}, \ldots, N_{d}$ and $M_{1}, \ldots, M_{d} \geq 1$, let

1. $S^{(j)}=\left\langle p_{1 j}, \ldots, p_{k j}\right\rangle=\left\{1=\ell_{1}^{(j)}<\ell_{2}^{(j)}<\cdots\right\}$ for all $1 \leq j \leq d$.
2. $\mathcal{J}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}=\left\{\mathbf{i} \in \mathcal{N}_{N_{1} \times \cdots \times N_{d}}: i_{j} \ell_{M_{j}}^{(j)} \leq N_{j}<i_{j} \ell_{M_{j}+1}^{(j)}\right.$ for all $\left.1 \leq j \leq d\right\}$ be the subset of $\mathcal{N}_{N_{1} \times \cdots \times N_{d}}$ which satisfies $i_{j} \ell_{M_{j}}^{(j)} \leq N_{j}<i_{j} \ell_{M_{j}+1}^{(j)}$ for all $1 \leq j \leq d$.
 which belongs to $\mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$.

The following lemmas are $\mathbb{N}^{d}$ version of Lemmas 2.4 and 2.7 in [1].
Lemma 2.2. For $\mathbf{p}_{1}, \ldots, \mathbf{p}_{k} \in \mathbb{N}^{d}$ with $\operatorname{gcd}\left(p_{i s}, p_{j s}\right)=1$ for all $1 \leq i \neq j \leq k$ and $1 \leq s \leq d$,

Proof. We first claim that for all $\mathbf{i} \neq \mathbf{i}^{\prime} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}, \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}(\mathbf{i}) \cap \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}\left(\mathbf{i}^{\prime}\right)=\emptyset$. If we suppose not, then there exist $\mathbf{i} \neq \mathbf{i}^{\prime} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$ such that $\mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}(\mathbf{i}) \cap$ $\mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}\left(\mathbf{i}^{\prime}\right) \neq \emptyset$. Since $\mathbf{i} \neq \mathbf{i}^{\prime}$,

for some $\ell_{i} \neq \ell_{i}^{\prime}, 1 \leq i \leq k$. Without loss of generality, we may assume $\ell_{i}>\ell_{i}^{\prime}$. Then by the $i_{s} p_{i s}^{\ell_{i}-\ell_{i}^{\prime}} \prod_{j \neq i} p_{j s}^{\ell_{j}}=i_{s}^{\prime} \prod_{j \neq i} p_{j s}^{\ell_{j}^{\prime}}$ for all $1 \leq s \leq d$ and $\operatorname{gcd}\left(p_{i s}, p_{j s}\right)=1$ for all $1 \leq i \neq j \leq k$ and $1 \leq s \leq d$, we have $p_{i s} \mid i_{s}^{\prime}$ for all $1 \leq s \leq d$. This contradicts with $\mathbf{i}^{\prime} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$.

It remains to show that the equality holds. For $\mathbf{i} \in \mathbb{N}^{d}$, there exist $\ell_{j s} \geq 0$ for all $1 \leq s \leq d$ and $1 \leq j \leq k$ such that

\left(i_{1}, \ldots, i_{d}\right)=\left(i_{1}^{\prime} \prod_{j=1}^{k} p_{j 1}^{\ell_{j 1}}, \ldots, i_{d}^{\prime} \prod_{j=1}^{k} p_{j d}^{\ell_{j d}}\right)
$$

where $p_{j s} \nmid i_{s}^{\prime}$ for all $1 \leq j \leq k$ and for all $1 \leq s \leq d$. Take $\ell_{j}=\min \left\{\ell_{j s}: 1 \leq s \leq d\right\}$ for all $1 \leq j \leq k$. Then, we have $\left(i_{1}, \ldots, i_{d}\right) \in \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}\left(\frac{i_{1}}{\prod_{j=1}^{k} p_{j 1}^{\ell_{j}}}, \ldots, \frac{i_{d}}{\prod_{j=1}^{k} p_{j d}^{\ell_{j}}}\right)$ and $\left(\frac{i_{1}}{\prod_{j=1}^{k} p_{j 1}^{\ell_{j}}}, \ldots, \frac{i_{d}}{\prod_{j=1}^{k} p_{j d}^{\ell_{j}}}\right) \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$. The converse is then clear.

Lemma 2.3. For $M_{i}, N_{i} \geq 1$ for all $1 \leq i \leq d$, we have the following assertions.

1. $\left|\mathcal{J}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}\right|=\prod_{i=1}^{d}\left(\left\lfloor\frac{N_{i}}{\ell_{M_{i}}^{(i)}}\right\rfloor-\left\lfloor\frac{N_{i}}{\ell_{M_{i}+1}^{(i)}}\right\rfloor\right)$.
2. $\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{\left|\mathcal{K}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}\right|}{\left|\mathcal{J}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}\right|}=\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} p_{i 2} \cdots p_{i d}}\right)$.
3. $\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \sum_{M_{1}=1}^{N_{1}} \cdots \sum_{M_{d}=1}^{N_{d}}\left|\mathcal{K}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}\right| \log a_{M_{1}, \ldots, M_{d}}=$
$\sum_{M_{1}, \ldots, M_{d}=1}^{\infty} \lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}}\left|\mathcal{K}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}\right| \log a_{M_{1}, \ldots, M_{d}}$.
Proof.
4. Since $\mathbf{i} \in \mathcal{J}_{N_{1} \times \cdots \times N_{d} ; M_{1}, \ldots, M_{d}}$ if and only if $i_{j} \ell_{M_{j}}^{(j)} \leq N_{j}<i_{j} \ell_{M_{j}+1}^{(j)}$ for all $1 \leq j \leq$ $d$. It follows that $\frac{N_{j}}{\ell_{M_{j}+1}^{(j)}}<i_{j} \leq \frac{N_{j}}{\ell_{M_{j}}^{(j)}}$ for all $1 \leq j \leq d$. Therefore

Let $\mathbf{G}=\left\langle\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}\right\rangle=\left\{\mathbf{1}=l_{1}^{(j)} \prec^{(j)} l_{2}^{(j)} \prec^{(j)} \cdots\right\}$ be the semigroup generated by $\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}$ with an order $\prec^{(j)}$ such that $\mathbf{G}$ follows $S^{(j)}$ for each $1 \leq j \leq d$. In particular, when $k=1, \mathbf{G}=\left\langle\mathbf{p}_{1}\right\rangle=\left\{l_{n}=\mathbf{p}_{1}^{n-1}\right\}_{n=1}^{\infty}{ }^{3}$.
3. The infinite-volume limit $\mu_{\infty}$ on $\mathbb{N}^{d}$ and Kolmogorov-Sinai entropy

In this section, we prove the $\mathbb{N}^{d}$ version of Theorem 3.1 in 8 for layer stationarity and multiplication invariance (Theorems 3.1 and 3.4 , and then obtain the limit measures (Theorems 3.3 and 3.6. We also give the $\mathbb{N}^{d}$ version of Lemma 3.4 in [8] (Lemmas 3.8 and 3.10 ) to obtain the Kolmogorov-Sinai entropies (Theorems 3.9 and 3.11.

### 3.1. Existence and invariance of the limit measure on $\mathbb{N}^{d}$.

3.1.1. 2-multiple Hamiltonian. Let $\mathbf{p}_{1}=\left(p_{1}, \ldots, p_{d}\right) \in \mathbb{N}^{d}$ and $\tau^{\mathbf{i}}=\left\{\tau_{\ell}^{\mathbf{i}}=\sigma_{\mathbf{p}_{1}^{\ell} \cdot \mathbf{i}}\right\}_{\ell=0}^{\infty}$ for each $\mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}}$. Then we have following result which is the $\mathbb{N}^{d}$ version of Theorem 3.1 in [8].

Theorem 3.1. Suppose that the $\left\{\tau^{\mathbf{i}}: \mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}}\right\}$ form an i.i.d. stationary processes, then the distribution of the corresponding $\sigma$ is multiplication invariant.

Proof. We are going to show that for every finite collection of points $\mathbf{v}_{1}, \ldots, \mathbf{v}_{k} \in \mathbb{N}^{d}$, and $\mathbf{m} \in \mathbb{N}^{d}$ the joint distribution of

Then, by the independence of the different layers, the joint distribution of $\tau_{\ell_{j}+\ell+\ell_{j}^{\prime}}^{\mathbf{i}_{j}^{\prime}}, j \in$ $\{1, \ldots, k\}$ and $\tau_{\ell_{j}}^{\mathbf{i}_{j}}, j \in\{1, \ldots, k\}$ coincide with the joint distribution of $\otimes_{w=1}^{M} X^{w}$ and $\otimes_{w=1}^{M} Y^{w}$ respectively, where $\otimes$ denotes independent joining.

Therefore, it remains to show that for each $1 \leq w \leq M$, the distributions of $X^{w}$ and $Y^{w}$ coincide. Since the layers $\tau^{\mathbf{i}_{j}^{\prime}}$ and $\tau^{\mathbf{i}_{j}}$ are i.i.d., we have $X^{w}$ and $Y^{w}$ have the same distribution. The proof is complete.

Remark 3.2. We remark that for $\mathbf{i}, \mathbf{i}_{1} \neq \mathbf{i}_{2} \in \mathcal{I}_{\mathbf{p}_{1}}$ if $\mathbf{i} \cdot \mathbf{i}_{1}=\mathbf{i}_{1}^{\prime} \cdot \mathbf{p}_{1}^{\ell_{1}}$ and $\mathbf{i} \cdot \mathbf{i}_{2}=\mathbf{i}_{2}^{\prime} \cdot \mathbf{p}_{1}^{\ell_{2}}$ with $\mathbf{i}_{1}^{\prime}, \mathbf{i}_{2}^{\prime} \in \mathcal{I}_{\mathbf{p}_{1}}$, then $\mathbf{i}_{1}^{\prime} \neq \mathbf{i}_{2}^{\prime}$. When $\ell_{1}=\ell_{2}$, the statement easily true. If we assume $\ell_{1}>\ell_{2}$ and $\mathbf{i}_{1}^{\prime}=\mathbf{i}_{2}^{\prime}$, then $\mathbf{i} \cdot \mathbf{i}_{1}=\mathbf{i} \cdot \mathbf{i}_{2} \cdot \mathbf{p}_{1}^{\ell_{1}-\ell_{2}}$. That gives $\mathbf{i}_{1}=\mathbf{i}_{2} \cdot \mathbf{p}_{1}^{\ell_{1}-\ell_{2}}$ which contradicts with $\mathbf{i}_{1} \in \mathcal{I}_{\mathbf{p}_{1}}$.

As a consequence of Theorem 3.1 with the existence of the infinte-volume limit in each layer of $\tau$ spins we have the following results.

2. Independent Ising layers : Under $\mu_{\infty}$, the $\tau^{\mathbf{i}}, \mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}}$, are independent and distributed according to the standard Ising model measure $\mu_{\infty}^{I s i n g}$ with a free boundary condition on the left.
3. Multiplication invariance : The measure $\mu_{\infty}$ is multiplication invariant.

Theorem 3.4. Suppose that the $\left\{\tau^{\mathbf{i}}: \mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}\right\}$ form an i.i.d. stationary processes, then the distribution of the corresponding $\sigma$ is multiplication invariant.

Proof. We have to show that for every finite collection of points $\mathbf{v}_{1}, \ldots, \mathbf{v}_{N} \in \mathbb{N}^{d}$ and $\mathbf{m} \in \mathbb{N}^{d}$, the joint distribution of

Y^{w}=\left(\tau_{\ell_{j}}^{\mathbf{i}_{j}}: 1 \leq j \leq k, \mathbf{i}_{j}=\mathbf{i}_{n_{w}}\right) .
$$

Then, by the independence of the different layers, the joint distribution of $\tau_{\ell_{j}+m+\ell_{j}^{\prime}}^{\mathrm{i}_{j}^{\prime}}, j \in$ $\{1, \ldots, k\}$ and $\tau_{\ell_{j}}^{\mathbf{i}_{j}}, j \in\{1, \ldots, k\}$ coincide with the joint distribution of $\otimes_{w=1}^{M} X^{w}$ and $\otimes_{w=1}^{M} Y^{w}$ respectively.

Therefore, it remains to show that for each $1 \leq w \leq M$, the distributions of $X^{w}$ and $Y^{w}$ coincide. Since the layers $\tau^{\mathbf{i}_{j}^{\prime}}$ and $\tau^{\mathbf{i}_{j}}$ are i.i.d., we have that $X^{w}$ and $Y^{w}$ have the same distribution. The proof is complete.

Remark 3.5. If $\mathbf{i}, \mathbf{i}_{1} \neq \mathbf{i}_{2} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$ and $\mathbf{i} \cdot \mathbf{i}_{1}=\mathbf{i}_{1}^{\prime} \cdot \mathbf{p}_{1}^{\ell_{11}^{\prime}} \cdots \mathbf{p}_{k}^{\ell_{1 k}^{\prime}}, \mathbf{i} \cdot \mathbf{i}_{2}=\mathbf{i}_{2}^{\prime} \cdot \mathbf{p}_{1}^{\ell_{21}^{\prime}} \cdots \mathbf{p}_{k}^{\ell_{2 k}^{\prime}}$ with $\mathbf{i}_{1}^{\prime}, \mathbf{i}_{2}^{\prime} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$, then $\mathbf{i}_{1}^{\prime} \neq \mathbf{i}_{2}^{\prime}$. When $\left(\ell_{11}^{\prime}, \ldots, \ell_{1 k}^{\prime}\right)=\left(\ell_{21}^{\prime}, \ldots, \ell_{2 k}^{\prime}\right)$, the statement clearly true. If $\left(\ell_{11}^{\prime}, \ldots, \ell_{1 k}^{\prime}\right) \neq\left(\ell_{21}^{\prime}, \ldots, \ell_{2 k}^{\prime}\right)$ and $\mathbf{i}_{1}^{\prime}=\mathbf{i}_{2}^{\prime}$, without loss of generality, we may assume $\ell_{11}^{\prime}>\ell_{21}^{\prime}$. This implies $\mathbf{i} \cdot \mathbf{i}_{1} \cdot \mathbf{c}_{1}=\mathbf{i} \cdot \mathbf{i}_{2} \cdot \mathbf{p}_{1}^{\ell_{11}^{\prime}-\ell_{21}^{\prime}} \cdot \mathbf{c}_{2}$, then $\mathbf{i}_{1} \cdot \mathbf{c}_{1}=\mathbf{i}_{2} \cdot \mathbf{p}_{1}^{\ell_{11}^{\prime}-\ell_{21}^{\prime}} \cdot \mathbf{c}_{2}$ where $\mathbf{c}_{1}, \mathbf{c}_{2}$ are the vectors only multipliable by $\mathbf{p}_{i}$ 's for $2 \leq i \leq k$. Then the coprime property of $\mathbf{p}_{1}$ and $\mathbf{p}_{i}, 2 \leq i \leq k$ gives $\mathbf{p}_{1} \mid \mathbf{i}_{1}$ which contradicts $\mathbf{i}_{1} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$.

As a consequence of Theorem 3.1 with the existence of the infinte-volume limit in each layer of $\tau$ spins we have the following theorem.

Theorem 3.6. Let

\mu_{N_{1} \times \cdots \times N_{d}}\left(\sigma_{\mathcal{N}_{N_{1} \times \cdots \times N_{d}}}\right)=\frac{e^{-H_{N_{1} \times \cdots \times N_{d}}\left(\sigma_{\left.N_{N_{1} \times \cdots \times N_{d}}\right)}\right.}}{\sum_{\sigma_{l_{j}(\mathbf{j})}= \pm 1, \mathbf{i} \in \mathcal{N}_{N_{1} \times \cdots \times N_{d}}} e^{-H_{N_{1} \times \cdots \times N_{d}}\left(\sigma_{N_{N_{1}} \times \ldots \times N_{d}}\right)}}
$$

be the finite-volume probability measure corresponding to the Hamiltonian

$$
H_{N_{1} \times \cdots \times N_{d}}\left(\sigma_{\mathcal{N}_{N_{1} \times \cdots \times N_{d}}}\right)=-\beta \sum_{i_{1}=1}^{N_{1}} \cdots \sum_{i_{d}=1}^{N_{d}} \sigma_{l_{j(i)}^{(j)}} \sigma_{l_{j(i)+1}^{(j)}},
$$

where $\mathbf{j}(\mathbf{i})$ is the unique number such that $\mathbf{i}=\left(k_{1}, \ldots, k_{d}\right) \cdot l_{\mathbf{j}(\mathbf{i})}^{(j)}$ with $\left(k_{1}, \ldots, k_{d}\right) \in$ $\mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$. Then

1. Unique limit measure: The measure $\mu_{N_{1} \times \cdots \times N_{d}}$ have a unique weak limit with respect to order $\prec^{(j)}$ denoted by $\mu_{\infty}^{(j)}$ which is Gibbs.
2. Independent Ising layers : Under $\mu_{\infty}^{(j)}$, the $\tau^{\mathbf{i}}, \mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$ are independent and distributed according to the standard Ising model measure $\mu_{\infty}^{I s i n g}$ with a free boundary condition on the left.
3. Multiplication invariance: The measure $\mu_{\infty}^{(j)}$ is multiplication invariant.

Remark 3.7. We remark that the order $\prec^{(j)}$ leads $\mu_{N_{1} \times \cdots \times N_{d}}$ to be Markov on each independent layer $\tau^{\mathbf{i}}, \mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$.

### 3.2. Kolmogorov-Sinai entropy with respect to the limit measure on $\mathbb{N}^{d}$.

3.2.1. 2-multiple Hamiltonian. Recall that $\mathcal{L}_{N_{1} \times \cdots \times N_{d}}(\mathbf{i})=\mathcal{M}_{\mathbf{p}_{1}}(\mathbf{i}) \cap \mathcal{N}_{N_{1} \times \cdots \times N_{d}}$ is the subset of $\mathcal{M}_{\mathbf{p}_{1}}(\mathbf{i})$, which belongs to the $\mathcal{N}_{N_{1} \times \cdots \times N_{d}}$ lattice. Then we have results as follows.

Lemma 3.8. Let $\phi: \mathbb{N} \rightarrow \mathbb{R}$ be a measurable function such that there exist $C^{\prime}>0$ and $r>0$ such that $|\phi(n)| \leq C^{\prime} n^{r}$ for all $n \in \mathbb{N}$. Then we have

$$
\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \sum_{\mathbf{i} \in \mathcal{I}_{\mathbf{p}}} \phi\left(\left|\mathcal{L}_{N_{1} \times \cdots \times N_{d}}(\mathbf{i})\right|\right)=\sum_{\ell=1}^{\infty} \frac{\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{\ell+1}} \phi(\ell)
$$

Proof. The proof is a direct consequence of Lemma 2.3. More precisely,

$$
\begin{aligned}
& \lim _{1}, \ldots, N_{d} \rightarrow \infty \\
& =\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \sum_{\mathbf{i} \in \mathcal{I}_{\mathbf{p}}} \phi\left(\left|\mathcal{L}_{N_{1} \times \cdots \times N_{d}}(\mathbf{i})\right|\right) \\
& =\sum_{\ell=1}^{K\left(N_{1}, \ldots, N_{d}\right)}\left(1-\frac{1}{p_{1} \cdots p_{d}}\right)\left(\frac{N_{1} \cdots N_{d}}{\left(p_{1} \cdots p_{d}\right)^{\ell-1}}-\frac{N_{1} \cdots N_{d}}{\left(p_{1} \cdots p_{d}\right)^{\ell}}\right) \phi(\ell) \\
& =\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \sum_{\ell=1}^{K\left(N_{1}, \ldots, N_{d}\right)} \frac{N_{1} \cdots N_{d}\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{\ell+1}} \phi(\ell) \\
& =\sum_{\ell=1}^{\infty} \frac{\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{\ell+1}} \phi(\ell)
\end{aligned}
$$

where the last equality holds by Weierstrass M-test with $|\phi(\ell)| \leq C^{\prime} \ell^{r}$ and $K\left(N_{1}, \ldots, N_{d}\right)$ is the maximum cardinality of $\mathcal{L}_{N_{1} \times \cdots \times N_{d}}(\mathbf{i})$ for all $\mathbf{i} \in \mathcal{I}_{\mathbf{p}}$.

Theorem 3.9 below is an immediate consequence of Lemma 3.8 .
Theorem 3.9. The explicit formula for the $K S$ entropy of $\mu_{\infty}$ is

& -\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \mathbb{E}_{\mu_{\infty}} \log \mu_{\infty}\left(\sigma_{\mathcal{N}_{N_{1} \times \cdots \times N_{d}}}\right) \\
& =-\sum_{k=1}^{\infty} \frac{\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{k+1}} \mathbb{E}_{\mu_{\infty}^{I s i n g}} \log \mu_{\infty}^{I \operatorname{sing}}\left(\tau_{0}, \ldots, \tau_{k-1}\right) .
\end{aligned}
$$

3.2.2. Generalization of 2-multiple Hamiltonian to $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}$ on $\mathbb{N}^{d}$. For each $1 \leq$ $j \leq d$ and $\mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}} \cap \mathcal{N}_{N_{1} \times \cdots \times N_{d}}$, let $\mathcal{L}_{N_{1} \times \cdots \times N_{d}}^{(j)}(\mathbf{i})$ be the subset of $\mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}(\mathbf{i})$ which satisfies $i_{j} p_{1 j}^{\ell_{1}} \cdots p_{k j}^{\ell_{k}} \leq N_{j}$. Then the similar result of Lemma 3.8 is obtained.

Lemma 3.10. Let $\phi: \mathbb{N} \rightarrow \mathbb{R}$ be a measurable function such that there exist $C^{\prime}>0$ and $r>0$ such that $|\phi(n)| \leq C^{\prime} n^{r}$ for all $n \in \mathbb{N}$. Then we have

$$
\begin{aligned}
& \lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \sum_{\mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}} \phi\left(\left|\mathcal{L}_{N_{1} \times \cdots \times N_{d}}^{(j)}(\mathbf{i})\right|\right) \\
& =\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} \cdots p_{i d}}\right) \sum_{M_{1}, \ldots, M_{d}=1}^{\infty}\left[\prod_{i=1}^{d}\left(\frac{1}{\ell_{M_{i}}^{(i)}}-\frac{1}{\ell_{M_{i}+1}^{(i)}}\right)\right] \phi\left(M_{j}\right)
\end{aligned}
$$

Proof. Applying the same argument of the Lemma 3.8 with Lemma 2.3 , the proof is complete.

By Lemma 3.10, we have the following result.

Theorem 3.11. For each $1 \leq j \leq d$, the explicit formula for the $K S$ entropy of $\mu_{\infty}^{(j)}$ is

& -\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \frac{1}{N_{1} \cdots N_{d}} \mathbb{E}_{\mu_{\infty}} \log \mu_{\infty}^{(j)}\left(\sigma_{\mathcal{N}_{N_{1} \times \cdots \times N_{d}}}\right) \\
& =-C \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}^{(j)}}-\frac{1}{\ell_{k+1}^{(j)}}\right) \mathbb{E}_{\mu_{\infty}^{I S i n g}} \log \mu_{\infty}^{I \operatorname{sing}}\left(\tau_{0}, \ldots, \tau_{k-1}\right),
\end{aligned}
$$

where $C$ is defined in Theorem 4.5.

## 4. Free energy functions and large deviation principle

In this section, we obtain the generalization of Theorem 1.2 (Theorem 4.1), and we consider two types of generalizations of Theorem 1.3 (Theorems 4.4 and 4.5).
4.1. Generalization of 2 -multiple Hamiltonian to $S_{N}^{G}$ on $\mathbb{N}$. Let $k \geq 1$, $p_{1}, p_{2}, \ldots, p_{k}$ be co-primes, and $G=\left\langle p_{1}, p_{2}, \ldots, p_{k}\right\rangle=\left\{1=\ell_{1}<\ell_{2}<\cdots\right\}$ be a semigroup generated by $p_{1}, p_{2}, \ldots, p_{k}$. Denote $\gamma(G)=\sum_{i=1}^{\infty} \frac{1}{\ell_{i}}$. The LDP of $S_{N}^{G}=\sum_{i=1}^{N} \sigma_{\ell_{j(i)}} \sigma_{\ell_{j(i)+1}}, j(i)$ is the unique number such that $i=i^{\prime} \ell_{j}$ and $p_{n} \nmid i^{\prime}$ for all $1 \leq n \leq k$, is presented in the following theorem.

Theorem 4.1. The following statements hold true.

1. The explicit expression of the free energy function associated to the multiple sum $S_{N}^{G}$ is

$$
F_{r}(\beta)=\frac{1+\gamma(G)^{-1}}{2} \log (r(1-r))+\gamma(G)^{-1} \log \left|v^{T} \cdot e_{+}\right|^{2}+\log \Lambda_{+}+\mathcal{G}(\beta)
$$

where

$$
\mathcal{G}(\beta)=\gamma(G)^{-1} \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right) \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)
$$

2. The function $F_{r}(\beta)$ is differentiable with respect to $\beta \in \mathbb{R}$.
3. The multiple average $\frac{S_{N}^{G}}{N}$ satisfies a LDP with rate function given by

$$
I_{r}(x)=\sup _{\beta \in \mathbb{R}}\left(\beta x-F_{r}(\beta)\right) .
$$

Furthermore, if $\left(F_{r}\right)^{\prime}(\eta)=y$, then $I_{r}(y)=\eta y-F_{r}(\eta)$.

Proof.

1. By the $\mathbb{N}^{d}$ version of Lemma 2.7 in 1 and the similar argument of Theorem 3.2 in [2], we obtain

F_{r}(\beta) & =B \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right) \log (r(1-r))^{\frac{k+1}{2}} Z(\beta, h, k+1) \\
& =B \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right) \log (r(1-r))^{\frac{k+1}{2}} \\
& +B \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right) \log \left(\left|v^{T} \cdot e_{+}\right|^{2} \Lambda_{+}^{k}+\left(2 \cosh (h)-\left|v^{T} \cdot e_{+}\right|^{2}\right) \Lambda_{-}^{k}\right) \\
& =B \frac{1+\gamma(G)}{2} \log (r(1-r))+B \log \left|v^{T} \cdot e_{+}\right|^{2}+B \gamma(G) \log \Lambda_{+}+\mathcal{G}(\beta) \\
& =\frac{1+\gamma(G)^{-1}}{2} \log (r(1-r))+\gamma(G)^{-1} \log \left|v^{T} \cdot e_{+}\right|^{2}+\log \Lambda_{+}+\mathcal{G}(\beta)
\end{aligned}
$$

where the constant $B=\prod_{i=1}^{k}\left(1-\frac{1}{p_{i}}\right)=\gamma(G)^{-1}$,

$$
Z(\beta, h, k+1)=v^{T}\left[\begin{array}{cc}
e^{\beta+h} & e^{-\beta} \\
e^{-\beta} & e^{\beta-h}
\end{array}\right]^{k} v
$$

and

$$
\mathcal{G}(\beta)=\gamma(G)^{-1} \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right) \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)
$$

2. The proof is similar to the (2) of Theorem 3.2 in [2]. More pricisely, we are going to show the sum

$$
\sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}}-\frac{1}{\ell_{k+1}}\right)\left[\log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)\right]^{\prime}
$$

coverge uniformly with respect to $\beta \in \mathbb{R}$, where the notation 'stays for the derivative with respect to $\beta$. Then, we apply the same reasoning on

$$
\left[\log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)\right]^{\prime}
$$

and then apply the Weierstrass M-test, and the proof is complete.
3. The proof is a direct consequence of Theorem 4.1 (2) and Gärtner-Ellis Theorem [2].

## Corollary 4.2 .

1. For $k=1, p_{1} \geq 1, G=\left\langle p_{1}\right\rangle=\left\{p_{1}^{i-1}: i \in \mathbb{N}\right\}$ and $\gamma(S)=\frac{p_{1}}{p_{1}-1}$. The explicit expression of the free energy function associated to the multiple sum $S_{N}^{G}$ is

$$
F_{r}(\beta)=\frac{2 p_{1}-1}{2 p_{1}} \log (r(1-r))+\frac{2\left(p_{1}-1\right)}{p_{1}} \log \left|v^{T} \cdot e_{+}\right|+\log \Lambda_{+}+\mathcal{G}(\beta)
$$

where

$$
\mathcal{G}(\beta)=\frac{p_{1}-1}{p_{1}} \sum_{k=1}^{\infty} \frac{p_{1}-1}{p_{1}^{k}} \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right) .
$$

2. In addition, $p_{1}=2, G=\langle 2\rangle=\left\{\ell_{i}=2^{i-1}: i \in \mathbb{N}\right\}$ and $\gamma(S)=2$. The explicit expression of the free energy function associated to the multiple sum $S_{N}^{G}$ is

$$
F_{r}(\beta)=\frac{3}{4} \log (r(1-r))+\log \left|v^{T} \cdot e_{+}\right|+\log \Lambda_{+}+\mathcal{G}(\beta)
$$

where

$$
\mathcal{G}(\beta)=\frac{1}{2} \sum_{k=1}^{\infty} \frac{1}{2^{k}} \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right) .
$$

Which is coincides with the resilt in Theorem 1.2.
Example 4.3. Figure 1 illustrates the free energy function for different $r \in(0,1)$ which is obtained from Theorem 4.1 by truncating the sum to the first 100 terms. The graph is obtained for the case $d=1$ with $p_{1}=2, p_{2}=3, p_{3}=5, p_{4}=7, p_{5}=11$, $G=\langle 2,3,5,7,11\rangle$ and $\gamma(G)^{-1}=\left(1-\frac{1}{2}\right)\left(1-\frac{1}{3}\right)\left(1-\frac{1}{5}\right)\left(1-\frac{1}{7}\right)\left(1-\frac{1}{11}\right)=\frac{16}{77}$.
4.2. Generalization of 2-multiple Hamiltonian to $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}$ on $\mathbb{N}^{d}$. Recall that $S^{(j)}=\left\langle p_{1 j}, \ldots, p_{k j}\right\rangle=\left\{1=\ell_{1}^{(j)}<\ell_{2}^{(j)}<\cdots\right\}$ is the semigroup generated by $p_{1 j}, \ldots, p_{k j}$. And $\mathbf{G}=\left\langle\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}\right\rangle=\left\{\mathbf{1}=l_{1}^{(j)} \prec^{(j)} l_{2}^{(j)} \prec^{(j)} \cdots\right\}$ be the semigroup generated by $\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}$ with an order $\prec^{(j)}$ such that $\mathbf{G}$ follows $S^{(j)}$ for each $1 \leq$ $j \leq d$. The LDP of $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}=\sum_{i_{i}=1}^{N_{1}} \cdots \sum_{i_{d}=1}^{N_{d}} \sigma_{l_{\mathbf{j} \mathbf{( i )}}^{(j)}} \sigma_{l_{\mathbf{j}(\mathbf{i})+1}^{(j)}}, \mathbf{j}(\mathbf{i})$ is the unique number such that $\mathbf{i}=\left(k_{1}, \ldots, k_{d}\right) \cdot l_{\mathbf{j}(\mathbf{i})}^{(j)}$ with $\left(k_{1}, \ldots, k_{d}\right) \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}$, is described by the following energy function.

The directional free energy function is defined as following. For $1 \leq j \leq d$,

$$
F_{r}(\beta):=\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \log \mathbb{E}_{r}\left(e^{\left.\beta \sum_{i_{1}=1}^{N_{1} \cdots \sum_{i_{d} d=1}^{N_{d}} \sigma_{l_{\mathbf{j}(\mathbf{i})}^{(j)}} \sigma_{l_{\mathbf{j}(\mathbf{i})+1}(j)}}\right) .}\right.
$$

The following result takes the sum over all elements $\mathbf{i}$ if it is less than the maximum element on its layer intersection with the $N_{1} \times \cdots \times N_{d}$ lattice (in the $\prec^{(j)}$ sense). That is, we take the sum over all $\mathbf{i} \in \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}(\mathbf{j}(\mathbf{i}))$ if

$$
\mathbf{i} \prec^{(j)} \max \left\{\mathbf{i}^{\prime}: \mathbf{i}^{\prime} \in \mathcal{M}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}}(\mathbf{j}(\mathbf{i})) \cap \mathcal{N}_{N_{1} \times \cdots \times N_{d}}\right\} .
$$

Theorem 4.4. For $1 \leq j \leq d$, the explicity formula of the directional energy function associated to the multiple sum $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}$ converges to
$F_{r}(\beta)=\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} \cdots p_{i d}}\right) \sum_{k_{1}, \ldots, k_{d}=1}^{\infty} \prod_{i=1}^{d}\left(\frac{1}{\ell_{k_{i}}^{(i)}}-\frac{1}{\ell_{k_{i}+1}^{(i)}}\right) \log (r(1-r))^{\frac{b_{k_{1}, \ldots, k_{d}+1}}{2}} Z\left(\beta, h, b_{k_{1}, \ldots, k_{d}}+1\right)$,
where $b_{k_{1}, \ldots, k_{d}}$ is the number of the elements in $\mathbf{G}$ less than or equal to the maximum element (with the order $\prec^{(j)}$ ) in the $\ell_{k_{1}}^{(1)} \times \cdots \times \ell_{k_{d}}^{(d)}$ lattice.

Proof. The proof is directly by the Lemmas 2.2 and 2.3 with the observation $\left|b_{k_{1}, \ldots, k_{d}}\right| \leq k_{j}$.

Due to the explicity expression of Theorem 4.4 is difficult to obtain, we consider the following type directional free energy function which takes the sum over all $\mathbf{i} \in \mathcal{I}_{\mathbf{p}_{1}, \ldots, \mathbf{p}_{k}} \cap \mathcal{N}_{N_{1} \times \cdots \times N_{d}}$ layers with the layer members $\mathbf{i} \cdot \mathbf{p}_{1}^{\ell_{1}} \cdots \mathbf{p}_{k}^{\ell_{k}}$ satisfy $i_{j} p_{1 j}^{\ell_{1}} \cdots p_{k j}^{\ell_{k}} \leq N_{j}$. Then we have following result.
Theorem 4.5. For $1 \leq j \leq d$,

1. The explicity expression of the directional energy function associated to the multiple sum $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}$ is

$$
F_{r}(\beta)=\frac{C+C \gamma\left(S^{(j)}\right)}{2} \log (r(1-r))+C \log \left|v^{T} \cdot e_{+}\right|^{2}+C \gamma\left(S^{(j)}\right) \log \Lambda_{+}+\mathcal{G}(\beta)
$$

where $C=\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} \cdots p_{i d}}\right) \prod_{1 \leq i \neq j \leq d} \gamma\left(S^{(i)}\right)$ and

$$
\mathcal{G}(\beta)=C \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}^{(j)}}-\frac{1}{\ell_{k+1}^{(j)}}\right) \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)
$$

2. The function $F_{r}(\beta)$ is differentiable with respect to $\beta \in \mathbb{R}$.
3. The multiple average $\frac{S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{G}}}{N_{1} \cdots N_{d}}$ satisfies a $L D P$ with rate function given by

$$
I_{r}(x)=\sup _{\beta \in \mathbb{R}}\left(\beta x-F_{r}(\beta)\right) .
$$

Furthermore, if $\left(F_{r}\right)^{\prime}(\eta)=y$, then $I_{r}(y)=\eta y-F_{r}(\eta)$.
Proof.

1. By Lemmas 2.2 and Lemma 2.3 with the similar process of Theorem 3.2 in [2], we have

$$
\begin{aligned}
F_{r}(\beta) & =\lim _{N_{1}, \ldots, N_{d} \rightarrow \infty} \log \mathbb{E}_{r}\left(e^{\beta \sum_{i_{1}=1}^{N_{1}} \cdots \sum_{i_{d}=1}^{N_{d}} \sigma_{l_{\mathbf{j}(\mathbf{i})}^{(j)}} \sigma_{l_{\mathbf{j}(\mathbf{i})+1}(j)}}\right) \\
& =\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} \cdots p_{i d}}\right) \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{d}=1}^{\infty} \prod_{i=1}^{d}\left(\frac{1}{\ell_{k_{i}}^{(i)}}-\frac{1}{\ell_{k_{i}+1}^{(i)}}\right) \log (r(1-r))^{\frac{k_{j}+1}{2}} Z\left(\beta, h, k_{j}+1\right) .
\end{aligned}
$$

Then replace $k_{j}$ by $k$, we obtain

$$
\begin{aligned}
F_{r}(\beta) & =C \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}^{(j)}}-\frac{1}{\ell_{k+1}^{(j)}}\right) \log (r(1-r))^{\frac{k+1}{2}} Z(\beta, h, k+1) \\
& =\frac{C+C \gamma\left(S^{(j)}\right)}{2} \log (r(1-r))+C \log \left|v^{T} \cdot e_{+}\right|^{2}+C \gamma\left(S^{(j)}\right) \log \Lambda_{+}+\mathcal{G}(\beta)
\end{aligned}
$$

where $C=\prod_{i=1}^{k}\left(1-\frac{1}{p_{i 1} \cdots p_{i d}}\right) \prod_{1 \leq i \neq j \leq d} \gamma\left(S^{(i)}\right)$ and

$$
\mathcal{G}(\beta)=C \sum_{k=1}^{\infty}\left(\frac{1}{\ell_{k}^{(j)}}-\frac{1}{\ell_{k+1}^{(j)}}\right) \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{k}\right)
$$

2. By a similar argument of Theorem 4.1 (2), we have $F_{r}(\beta)$ is differentiable with respect to $\beta \in \mathbb{R}$.
3. The proof is a direct consequence of Theorem4.5 (2) and Gärtner-Ellis Theorem [2].

Corollary 4.6. For $k=1, \mathbf{p}_{1}=\left(p_{1} \cdots p_{d}, 1, \ldots, 1\right) \in \mathbb{N}^{d}$ and $j=1$, then $C=$ $\left(1-\frac{1}{p_{1} \cdots p_{d}}\right), S^{(1)}=\left\langle p_{1} \cdots p_{d}\right\rangle=\left\{\ell_{n}^{(1)}=\left(p_{1} \cdots p_{d}\right)^{n-1}\right\}_{n=1}^{\infty}$ and $\gamma\left(S^{(1)}\right)=\frac{p_{1} \cdots p_{d}}{p_{1} \cdots p_{d}-1}$.
These give the directional energy function associated to the sum $S_{N_{1} \times \cdots \times N_{d}}^{\mathbf{p}_{1}}$ is

$$
F_{r}(\beta)=\frac{2 p_{1} \cdots p_{d}-1}{2 p_{1} \cdots p_{d}} \log (r(1-r))+\frac{p_{1} \cdots p_{d}-1}{p_{1} \cdots p_{d}} \log \left|v^{T} \cdot e_{+}\right|^{2}+\log \Lambda_{+}+\mathcal{G}(\beta)
$$

where

$$
\mathcal{G}(\beta)=\sum_{\ell=1}^{\infty} \frac{\left(p_{1} \cdots p_{d}-1\right)^{2}}{\left(p_{1} \cdots p_{d}\right)^{\ell+1}} \log \left(1+\left(\frac{2 \cosh (h)}{\left|v^{T} \cdot e_{+}\right|^{2}}-1\right)\left(\frac{\Lambda_{-}}{\Lambda_{+}}\right)^{\ell}\right)
$$

Which is coincides with the formula in Theorem 1.3 .

Example 4.7. Figure 2 shows the free energy behaviour for the multidimensional case $d=2$ with $j=1, \mathbf{p}_{1}=(2,3), \mathbf{p}_{2}=(3,5), \mathbf{p}_{3}=(5,7), \mathbf{p}_{4}=(7,11), \mathbf{p}_{5}=(11,2)$, $S^{(1)}=S^{(2)}=\langle 2,3,5,7,11\rangle, \gamma\left(S^{(1)}\right)^{-1}=\gamma\left(S^{(2)}\right)^{-1}=\frac{16}{77}$ and $C=\left(1-\frac{1}{6}\right)\left(1-\frac{1}{15}\right)(1-$ $\left.\frac{1}{35}\right)\left(1-\frac{1}{77}\right)\left(1-\frac{1}{22}\right) \frac{77}{16}=\frac{2261}{660}$.
