# LOCAL-GLOBAL PRINCIPLE FOR HERMITIAN SPACES OVER SEMI GLOBAL FIELDS

#### Abstract

Let $K$ be a complete discrete valued field with residue field $k$ and $F$ the function field of a curve over $K$. Let $A \in{ }_{2} B r(F)$ be a central simple algebra with an involution $\sigma$ of any kind and $F_{0}=F^{\sigma}$. Let $h$ be an hermitian space over $(A, \sigma)$ and $G=S U(A, \sigma, h)$ if $\sigma$ is of first kind and $G=U(A, \sigma, h)$ if $\sigma$ is of second kind. Suppose that $\operatorname{char}(k) \neq 2$ and $\operatorname{ind}(A) \leq 4$. Then we prove that projective homogeneous spaces under $G$ over $F_{0}$ satisfy a local-global principle for rational points with respect to discrete valuations of $F$.


Let $K$ be a complete discrete valued field and $F$ the function field of a curve over $K$. Let $\Omega$ be a set of discrete valuations of $F$. For $\nu \in F$, let $F_{\nu}$ denote the completion of $F$ at $\nu$. Let $G$ be a connected linear algebraic group over $F$ and $X$ a projective homogeneous variety under $G$ over $F$. We say that a local-global principle holds for $X$ with respect to $\Omega$ if $X\left(F_{\nu}\right) \neq \emptyset$ for all $\nu \in \Omega$ implies $X(F) \neq \emptyset$.

If $K$ is a $p$-adic field, $F$ the function field of a curve over $K$ and $G$ a connected linear algebraic group which of classical type with characteristic of the residue field $k$ a 'good' prime for $G$, then local-global principle holds for projective homogeneous spaces under $G$ over $F$ with respect to the set $\Omega_{F}$ of all 'divisorial' discrete valuations ([5], [20], [25], [18]). The aim of this paper is to obtain analogues results for certain unitary groups if $K$ is a complete discrete valued field with any residue field.

Suppose $K$ is any complete discrete valued field with residue field $k$. Let $q$ be a quadratic form over $F$ of rank at least 3 and $G=S O(q)$. If $\operatorname{char}(k) \neq 2$, then Colliot-Thélène-Parimala-Suresh proved that local-global principle holds for projective homogeneous spaces under $G$ over $F$ with respect to $\Omega_{F}$ ([5, Theorem 3.1]). Let $A$ be a central simple algebra over $F$ of degree $n$ and $G=P G L_{1}(A)$. If $n$ is coprime to $\operatorname{char}(k)$ and $k$ contains a primitive $n^{\text {th }}$ root of unity, then Reddy-Suresh proved that local-global principle holds for projective homogeneous spaces under $G$ over $F$ with respect to $\Omega_{F}$ ([20, Theorem 2.6]).

Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ and $h$ a hermitian form over $(A, \sigma)$ and $G=S U(A, \sigma, h)$ if $\sigma$ is of first kind and $G=U(A, \sigma, h)$ if $\sigma$ is of second kind. Suppose that $\operatorname{char}(k) \neq 2$. A theorem of Wu ([25, Theorem 1.2]) asserts that if $\operatorname{ind}(A) \leq 2$ or for every finite extension $\ell / k,\left|\ell^{*} / \ell^{* 2}\right| \leq 2$, then local-global principle holds for projective homogeneous spaces under $G$ over $F$ with respect to $\Omega_{F}$. Since for every finite field $\mathbb{F}$ of characteristic not $2,\left|\mathbb{F}^{*} / \mathbb{F}^{* 2}\right|=2$, if $K$ is a $p$-adic field with $p \neq 2$, then local-global principle holds for projective homogeneous spaces under $G$ over $F$ with respect $\Omega_{F}$.

These results are in the direction of a Hasse principle for projective homogeneous spaces over general semiglobal fields. We however point out that a Hasse principle for principal or projective homogeneous spaces over function fields of $p$-adic curves is a conjecture in ([5]) and proved in many cases (cf. [18]). There are examples to show that a Hasse principle may fail for principal homogeneous space for arbitrary semiglobal field ([6], [7]).

In this paper we prove the following (cf. 7.1, 7.2).

Theorem 0.1. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that char $(k) \neq 2$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ of any kind, $F_{0}=F^{\sigma}$ and $h$ a hermitian form over $(A, \sigma)$. Let $G=S U(A, \sigma, h)$ if $\sigma$ is first kind or $U(A, \sigma, h)$ if $\sigma$ is of second kind. Suppose that one of the following holds: i) $\operatorname{ind}(A) \leq 4$
ii) for every finite extension $\ell / k$, every element $D \in{ }_{2} \operatorname{Br}(\ell)$ has index at most 2. Let $X$ be a projective homogeneous variety under $G$ over $F_{0}$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F$, then $X\left(F_{0}\right) \neq \emptyset$.

As a consequence we get the following (7.4).
Corollary 0.2. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that $k$ is a local field with the characteristic of the residue field not equal 2. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ and $h$ a hermitian form over $(A, \sigma)$ and $F_{0}=F^{\sigma}$. If $h \otimes L$ is isotropic for some odd degree extension $L / F_{0}$, then $h$ is isotropic.

The main technique in the proof of the main theorem is the patching technique of Harbater, Hartman and Krashen ([8, Theorem 3.7]) and the existence of maximal orders over two dimensional complete regular local rings for some suitable division algebras. We now give a brief description of the structure of paper. In $\S(1)$, we recall the patching set up and some known results. Let $R$ be a 2 -dimensional complete regular local ring with residue field $k$, maximal ideal $(\pi, \delta)$ and field of fractions $F$. Suppose that $\operatorname{char}(k) \neq 2$. Let $D$ be a division algebra over $F$ which is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. If $D$ has an involution of any kind, in $\S 2$ and $\S 3$, following Saltman ([22, Theorem 2.1] \& [23, Theorem 1.2]), we give a description of $D$ if $\operatorname{ind}(D) \leq 4$ or if for every finite extension $\ell$ of $k$, every element of ${ }_{2} \operatorname{Br}(\ell)$ has index at most 2 . In $\S 4$, we produce some suitable maximal $R$-orders for such algebras. In $\S 5$, under some assumptions on the existence of maximal $R$-orders in $D$, we show that hermitian spaces satisfy a certain local-global principle. In $\S 6$, we study the behavior of the maximal $R$-orders constructed in $\S 4$ under blowups. Finally using all these we prove the main results in $\S 7$.

## 1. Preliminaries

In this section we recall some basic facts about hermitian forms ([24, Chapter $7 \& 8]$ ), projective homogeneous spaces under unitary groups ([15], [16]) and patching techniques ([8]).

Let $F$ be a field and $A$ a central simple algebra with an involution $\sigma$. Let $F_{0}=F^{\sigma}=$ $\{a \in F \mid \sigma(a)=a\}$. Then $\left[F: F_{0}\right] \leq 2$. If $F=F_{0}$, then $\sigma$ is called an involution of the first kind if $\left[F: F_{0}\right]=2$, then $\sigma$ is called an involution of the second kind. We also say that the involution $\sigma$ is an $F / F_{0}$-involution. Let $h$ be an hermitian form over $(A, \sigma)$. Let $G(A, \sigma, h)=S U(A, \sigma, h)$ if $F=F_{0}$ and $G(A, \sigma, h)=U(A, \sigma, h)$ if $\left[F: F_{0}\right]=2$. Then $G(A, \sigma, h)$ is a connected linear algebraic group over $F_{0}$ which is rational ([4, Lemma 5]).

By a theorem of Wedderburn ([24, Chapter 8, Corollary $1.6 \&$ Theorem 1.9]), we have $A \simeq M_{n}(D)$ for a central division algebra over $D$ over $F$. Since $A$ has a $F / F_{0}$-involution, $D$ has a $F / F_{0}$-involution ([24, Chapter 8, Corollary 8.3]). Let $\sigma_{0}$ be a $F / F_{0}$-involution on $D$.

Then, by Morita equivalence ([12, Chapter 1, 9.3.5]), $h$ corresponds to a hermitian $h_{0}$ over ( $D, \sigma_{0}$ ).

Let $X$ be a projective homogeneous space under $G(A, \sigma, h)$ over $F_{0}$. Then $X$ corresponds to a projective homogeneous space $X_{0}$ under $G\left(D, \sigma_{0}, h_{0}\right)$ over $F_{0}$ such that for any extension $L / F_{0}, X(L) \neq \emptyset$ if and only if $X_{0}(L) \neq \emptyset([15$, Section 5], [16, Section 9], [11, Theorem 16.10]). Hence the study of rational points on projective homogeneous space under $G(A, \sigma, h)$ reduces to the study of rational points on projective homogeneous space under $G\left(D, \sigma_{0}, h_{0}\right)$. Suppose $\sigma^{\prime}$ is an involution on $A$ of the same kind as $\sigma$. Then $\sigma^{\prime}=\operatorname{int}(u) \sigma$ for some $u \in A^{*}$ and $h^{\prime}=u h$ is an hermitian form over $\left(A, \sigma^{\prime}\right)$. Further $X$ corresponds to a projective homogeneous space $X^{\prime}$ under $G\left(A, \sigma^{\prime}, h^{\prime}\right)$ over $F_{0}$ such that for any extension $L / F_{0}, X(L) \neq \emptyset$ if and only if $X^{\prime}(L) \neq \emptyset$. For more details on the structure of projective homogeneous space under $G(A, \sigma, h)$, we refer to ([15], [16]).

Let $\mathscr{X}$ be a regular integral scheme with function field $F$. For a point $P$ of $\mathscr{X}$, let $\mathcal{O}_{P}$ denote the local ring at $P$ on $\mathscr{X}, \hat{\mathcal{O}}_{P}$ the completion of the local ring $\mathcal{O}_{P}$. Let $A$ be a central simple algebra over $F$. Let $P \in \mathscr{X}$. We say that $A$ is unramified at $P$, if there exists an Azumaya algebra $\mathscr{A}$ over the local ring $\mathcal{O}_{P}$ at $P$ such that $\mathscr{A} \otimes F \simeq A$. If $A$ is not unramified at $P$, we say that $A$ is ramified at $P$.

Let $T$ be a complete discrete valuation ring with residue field $k$ and field of fractions $K$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. A two dimensional projective scheme $\mathscr{X} \rightarrow \operatorname{Spec}(T)$ with function field $F$ is called a model of $F$. The fibre $X_{0}$ over the closed point of $\operatorname{Spec}(T)$ is called the closed fibre of $\mathscr{X}$.

Let $\mathscr{X}$ be a model of $F$ with $X_{0}$ its closed fibre. Every codimension one point $x$ of $\mathscr{X}$ gives a discrete valuation $\nu_{x}$ on $F$. A discrete valuation of $F$ is called a divisorial discrete valuation of $F$, if it is given by a codimension one point of a model of $F$. For any discrete valuation $\nu$ of $F$, we denote the completion of $F$ at $\nu$ by $F_{\nu}$.

Let $A$ be a central simple algebra over $F$. The ramification divisor $\operatorname{ram}_{\mathscr{X}}(A)$ of $A$ on $\mathscr{X}$ is the union of codimension one points of $\mathscr{X}$ where $A$ is ramified. Note that there are only finitely many codimension one point of $\mathscr{X}$ where $A$ ramified.

For any point $P \in \mathscr{X}$, let $\hat{\mathcal{O}}_{P}$ be the completion of the local ring $\mathcal{O}_{P}$ at $P$ on $\mathscr{X}$ and $F_{P}$ the field of fractions of $\hat{\mathcal{O}}_{P}$. Let $U \subset X_{0}$ be a nonempty open subset of the nonsingular points of $X_{0}$ which is properly contained in an irreducible component of $X_{0}$. Let $R_{U}$ be the set of $f \in F$ which are regular at every point of $U$. Then $T \subset R_{U}$. Let $t \in T$ be a parameter and $\hat{R}_{U}$ be the $(t)$-adic completion of $R_{U}$. Let $F_{U}$ be the field of fractions of $\hat{R}_{U}$. For any nonempty subset $V$ of $U$, we have $F_{U} \subset F_{V}$. For any point $P \in U$, we have $F_{U} \subset F_{P}$. For more details about $F_{U}$ and $F_{P}$, we refer to [8].

We record the following theorem from ([9, Proposition 5.8]).
Theorem 1.1. Let $T$ be a complete discrete valuation ring with residue field $k$ and field of fractions $K$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$ and $\mathscr{X}$ a model of $F$ with $X_{0}$ its closed fibre. Let $Y$ be a variety over $F$. Suppose that $Y\left(F_{\nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F$. For every irreducible component $C$ of $X_{0}$, there exists a nonempty proper open subset $U$ of $C$ such that $Y\left(F_{U}\right) \neq \emptyset$. In particular there exists a finite subset $\mathscr{P}$ of closed points of $X_{0}$ such that $Y\left(F_{P}\right) \neq \emptyset$ for all $P \in X_{0} \backslash \mathscr{P}$.
Proof. Let $C$ be an irreducible component of $X_{0}$. Then for the generic point $\eta$ of $C, F_{\eta}$ is the completion of $F$ at the discrete valuation given by $\eta$ and hence $Y\left(F_{\eta}\right) \neq \emptyset$. Then, by ([9, Proposition 5.8]), there exists a nonempty proper open subset $U_{\eta}$ of $C$ such that
$Y\left(F_{U_{\eta}}\right) \neq \emptyset$. Let $\mathscr{P}=X_{0} \backslash \cup_{\eta} U_{\eta}$. Since $U_{\eta}$ is a nonempty open subset of the irreducible curve $C, C-U_{\eta}$ is a finite set. Since there are only finitely many irreducible components of $X_{0}, \mathscr{P}$ is a finite set. Let $P \in X_{0} \backslash \mathscr{P}$. Then $P \in U_{\eta}$ for some $\eta$. Since $F_{U_{\eta}} \subset F_{P}$ and $Y\left(F_{U_{\eta}}\right) \neq \emptyset, Y\left(F_{P}\right) \neq \emptyset$.

We record the following from ([20, Proposition 2.4]).
Proposition 1.2. Let $(R, \mathfrak{m})$ be a 2-dimensional complete regular ring with maximal ideal $\mathfrak{m}=(\pi, \delta)$, field of fractions $F$ and residue field $k$. Let $D \in{ }_{d} \operatorname{Br}(F)$ be a division algebra over $F$ which is unramified on $R$ except possibly at $\langle\pi\rangle$ or $\langle\delta\rangle$. Suppose that $d$ is coprime to $\operatorname{char}(k)$ and $F$ contains a primitive $d^{\text {th }}$ root of unity. Then $\operatorname{ind}(A)=\operatorname{ind}\left(A \otimes F_{\pi}\right)$.

Proof. Let $n=\operatorname{deg}(A)$. This result is proved in ([20, Proposition 2.4]) under the assumption that $F$ contains a primitive $n^{\text {th }}$ root of unity. However we note that the same proof goes through if $F$ contains a primitive $d^{\text {th }}$ root of unity.

We end this section with the following.
Theorem 1.3. Let $T$ be a complete discrete valuation ring with residue field $k$ and field of fractions $K$. Suppose that char $(k) \neq 2$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$ and $\mathscr{X}$ a model of $F$. Let $A$ be a central simple algebra over $F$ of period at most 2. Let $L$ be the field $F$ or $F_{P}$ for some closed point $P$ of $\mathscr{X}$. Let $Z$ be a projective homogeneous space under $P G L(A)$ over $L$. If $Z\left(L_{\nu}\right) \neq \emptyset$ for all divisorial discrete valuations of $L$, then $Z(L) \neq \emptyset$.

Proof. This follows from the proof of ([18, Theorem 10.1]) and (1.2).
Corollary 1.4. Let $L$ and $A$ be as in (1.3). Let $Z$ be a projective homogenous space under $G L(A)$ over $L$. If $Z\left(L_{\nu}\right) \neq \emptyset$ for all divisorial discrete valuations of $L$, then $Z(L) \neq \emptyset$.

Proof. This follows from the proof of ([18, Corollary 10.3]) and (1.3).

## 2. Division algebras with involution of first kind over two dimensional LOCAL FIELDS

Let $(R, \mathfrak{m})$ be a 2-dimensional complete regular ring with maximal ideal $(\pi, \delta)$, field of fractions $F$ and residue field $k$. Suppose that $\operatorname{char}(k) \neq 2$. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra over $F$ which is unramified on $R$ except possibly at $\langle\pi\rangle$ or $\langle\delta\rangle$. In this section we show that if $\operatorname{ind}(D)=4$, then $D$ is a tensor product of two quaternion algebras with some properties. Suppose that for any central simple algebra $A \in{ }_{2} \operatorname{Br}(k)$, $\operatorname{ind}(A) \leq 2$. Then we show that $\operatorname{ind}(D) \leq 8$. Further we show that if $\operatorname{ind}(D)=8$, then $D$ is isomorphic to a tensor product of three quaternion algebras with some properties.

We begin with the following well know lemma
Lemma 2.1. Let $A \in{ }_{2} B r(k)$ be a central division algebra over $k$.

1) If $A \otimes_{k} k(\sqrt{a})$ has index at most 2 for some $a \in k^{*}$, then $A=(a, c) \otimes(b, d) \in \operatorname{Br}(k)$ for some $b, c, d, \in k^{*}$.
2) If $A \otimes_{k} k(\sqrt{a}, \sqrt{b})$ is a matrix algebra for some $a, b \in k^{*}$, then $A=(a, c) \otimes(b, d) \in \operatorname{Br}(k)$ for some $c, d, \in k^{*}$.

Proof. If $\operatorname{deg}(A)=1$ or 2 , then 1) and 2) are immediate. Suppose that $\operatorname{deg}(A) \geq 4$.
Suppose $A \otimes_{k} k(\sqrt{a})$ has index at most 2 for some $a \in k^{*}$. Then $\operatorname{deg}(A)=\operatorname{ind}(A)=4$ and $K=k(\sqrt{a})$ is a subfield of $A$. Let $A_{1}$ be the commutant of $K$ in $A$. Then $A_{1}$ is a quaternion algebra over $K\left(\left[24\right.\right.$, Theorem 5.4]). Since $A \in{ }_{2} \operatorname{Br}(k), A$ admits an involution ([24, Chapter 8, Theorem 8.4]) and the non trivial automorphism of $K / k$ can be extended to an involution $\sigma$ on $A([24$, Chapter 8 , Theorem 10.1$])$. Since $\sigma(K)=K$, the restriction of $\sigma$ to $A_{1}$ is an involution of second kind. Thus, by a theorem of Albert ([2, Chapter 10, Theorem 21]), $A_{1}=K \otimes Q_{1}$ for some quaternion algebra $Q_{1}$. Let $Q_{2}$ be the commutant of $Q_{1}$ in $A$. Then $K \subset Q_{2}$ and $A=Q_{2} \otimes Q_{1}$. Since $K \subset Q_{2}, Q_{2}=(a, c)$ for some $c \in k^{*}$. Since $Q_{1}$ is a quaternion algebra, $Q_{1}=(b, d)$ for some $b, d \in k^{*}$. Hence $A=(a, c) \otimes(b, d)$.

Suppose $A \otimes_{k} k(\sqrt{a}, \sqrt{b})$ is a matrix algebra for some $a, b \in k^{*}$. Then $\operatorname{deg}(A)=\operatorname{ind}(A)=4$ and $K=k(\sqrt{a}, \sqrt{b})$ is a maximal subfield of $A$. Then as above we have $A=Q_{2} \otimes Q_{1}$ with $K=k(\sqrt{a}) \subset Q_{2}$. Since $k(\sqrt{a}, \sqrt{b})$ is a maximal subfield of $A$, it follows that $k(\sqrt{b}) \subset Q_{1}$. Hence $Q_{2}=(a, c)$ and $Q_{1}=(b, d)$ for some $c, d \in k^{*}$. Thus $A=(a, c) \otimes(b, d)$.

Lemma 2.2. Let $R$ be a complete regular local ring with residue field $k$ and field of fractions $F$. Suppose that char $(k) \neq 2$. Let $\Gamma_{0}$ be an Azumaya algebra over $R$ and $D_{0}=\Gamma_{0} \otimes_{R} F \in$ ${ }_{2} \operatorname{Br}(F)$. Let $u \in R$ be a unit. If $\operatorname{ind}\left(D_{0} \otimes_{F}(F(\sqrt{u}))\right) \leq 2$. Then there exists $v, w, t \in R^{*}$ such that $D_{0}=(u, v) \otimes(w, t) \in \operatorname{Br}(F)$.

Proof. Suppose that $\operatorname{ind}\left(D_{0} \otimes_{F}(F(\sqrt{u}))\right) \leq 2$. Let $\mathfrak{D}_{0}=\Gamma_{0} \otimes_{R} k$. Since ind $\left(D_{0} \otimes F(\sqrt{u}) \leq 2\right.$, $\mathfrak{D}_{0} \otimes k(\sqrt{\bar{u}}) \leq 2\left([20\right.$, Lemma 1.1] $)$, where $\bar{u}$ is the image of $u$ in $k$. Thus there exist $b, c, d \in k^{*}$ such that $\mathfrak{D}_{0}=(\bar{u}, c) \otimes(b, d)(c f .2 .1)$. Let $v, w, t \in R^{*}$ be the lifts of $b, c, d \in k^{*}$. Since $R$ is a complete regular local ring, $\operatorname{Br}(R) \cong \operatorname{Br}(k)([3], 6.5)$. Hence $D_{0}=(u, v) \otimes(w, t) \in \operatorname{Br}(F)$.

Lemma 2.3. Let $R$ be a complete regular local ring with residue field $k$ and field of fractions $F$. Suppose that char $(k) \neq 2$. Let $\Gamma_{0}$ be an Azumaya algebra over $R$ with $D_{0}=\Gamma_{0} \otimes_{R} F \in$ ${ }_{2} \operatorname{Br}(F)$. Let $u, v \in R$ be units. If $D_{0} \otimes_{F}(F(\sqrt{u}, \sqrt{v}))$ is a matrix algebra, then there exists $w, t \in R$ units such that $D_{0}=(u, w) \otimes(v, t) \in \operatorname{Br}(F)$.
Proof. Let $\mathfrak{D}_{0}=\Gamma_{0} \otimes_{R} k$. Since $D_{0} \otimes_{F}(F(\sqrt{u}, \sqrt{v}))$ is a matrix algebra, $\mathfrak{D}_{0} \otimes k(\sqrt{\bar{u}}, \sqrt{\bar{v}})$ is a matrix algebra. Hence $\mathfrak{D}_{0}=(\bar{u}, c) \otimes(\bar{v}, d) \in \operatorname{Br}(k)$ (cf. 2.1). Let $w, t \in R^{*}$ be lifts of $c, d \in k^{*}$. Since $R$ is a complete regular local ring, $D_{0}=(u, w) \otimes(v, t) \in \operatorname{Br}(F)$.

Lemma 2.4. Let $R$ be a two dimensional complete regular local ring with residue field $k$, maximal ideal $(\pi, \delta)$ and field of fractions $F$. Suppose that $\operatorname{char}(k) \neq 2$. Let $\Gamma_{0}$ be an Azumaya algebra on $R$ and $D_{0}=\Gamma_{0} \otimes F$. Suppose that $D_{0} \in{ }_{2} \operatorname{Br}(F)$. Let $u, v \in R$ units. i) If $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$, then $\operatorname{ind}(D)=\operatorname{ind}\left(D_{0} \otimes F(\sqrt{u}, \sqrt{v})\right)[F(\sqrt{u}, \sqrt{v}): F]$. ii) If $D=D_{0} \otimes(u \pi, v \delta)$, then $\operatorname{ind}(D)=2 \operatorname{ind}\left(D_{0}\right)$.

Proof. Let $\kappa(\pi)$ be the residue field at $\pi$. Then $\kappa(\pi)$ is the field of fractions of the complete discrete valuation $\operatorname{ring} R /(\pi)$ and the the image $\bar{\delta}$ of $\delta$ in $\kappa(\pi)$ is a parameter.

Suppose $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$. Since $D_{0} \otimes(v, \delta)$ is unramified at $\pi$, by ([20, Lemma 2.1]), we have $\operatorname{ind}\left(D \otimes F_{\pi}\right)=\operatorname{ind}\left(\left(D_{0} \otimes(v, \delta) \otimes F_{\pi}(\sqrt{u})\right)\left[F_{\pi}(\sqrt{u}]: F_{\pi}\right]\right.$. Since $\Gamma_{0} \otimes \kappa(\pi)$ is unramified on $R /(\delta)$, by $\left(\left[20\right.\right.$, Lemma 2.1]), we have ind $\left(\Gamma_{0} \otimes(\bar{v}, \bar{\delta}) \otimes \kappa(\pi)(\sqrt{\bar{u}})\right)=\operatorname{ind}\left(\Gamma_{0} \otimes\right.$ $\kappa(\pi)(\sqrt{\bar{u}}, \sqrt{\bar{v}})[\kappa(\pi)(\sqrt{\bar{u}}, \sqrt{\bar{v}}): \kappa(\pi)(\sqrt{\bar{u}})]$. Since $F_{\pi}$ is complete, we have

\operatorname{i} n d\left(\left(D_{0} \otimes(v, \delta) \otimes F_{\pi}(\sqrt{u})\right)=\operatorname{ind}\left(D_{0} \otimes F_{\pi}(\sqrt{u}, \sqrt{v})\right)\left[F_{\pi}(\sqrt{u}, \sqrt{v}): F_{\pi}(\sqrt{u})\right] .\right.
$$

Hence $\operatorname{ind}\left(D \otimes F_{\pi}\right)=\operatorname{ind}\left(\left(D_{0} \otimes F_{\pi}(\sqrt{u}, \sqrt{v})\right)\left[F_{\pi}(\sqrt{u}, \sqrt{v}]: F_{\pi}\right]\right.$. By (1.2), we have ind $(D)=$ $\operatorname{ind}\left(D \otimes F_{\pi}\right), \operatorname{ind}\left(D_{0} \otimes F_{\pi}(\sqrt{u}, \sqrt{v})\right)=\operatorname{ind}\left(\left(D_{0} \otimes F_{\pi}(\sqrt{u}, \sqrt{v})\right)\right)$ and $\left[F_{\pi}(\sqrt{u}, \sqrt{v}): F_{\pi}\right]=$ $[F(\sqrt{u}, \sqrt{v}): F]$. Thus ind $(D)=\operatorname{ind}\left(D_{0} \otimes F(\sqrt{u}, \sqrt{v})\right)[F(\sqrt{u}, \sqrt{v}): F]$.

Suppose $D=D_{0} \otimes(u \pi, v \delta)$. Then as above, we have ind $(D)=\operatorname{ind}\left(D_{0} \otimes F(\sqrt{v \delta})\right)[F(\sqrt{v \delta})$ : $F]$. Since $D_{0}$ is unramified at $\delta$, we have $\operatorname{ind}\left(D_{0} \otimes F_{\delta}(\sqrt{v \delta})\right)=\operatorname{ind}\left(D_{0} \otimes F_{\delta}\right)$. Once again, by $([20])$, we have $\operatorname{ind}\left(D_{0} \otimes F(\sqrt{v \delta})\right)=\operatorname{ind}\left(D_{0} \otimes F_{\delta}(\sqrt{v \delta})\right)=\operatorname{ind}\left(D_{0} \otimes F_{\delta}\right)=\operatorname{ind}\left(D_{0}\right)$. Since $[F(\sqrt{v \delta}): F]=2$, we have $\operatorname{ind}(D)=2 \operatorname{ind}\left(D_{0}\right)$.

We recall the following.
Lemma 2.5. ([25, Lemma 3.6]) Let $R$ be a two dimensional complete regular local ring with residue field $k$, maximal ideal $(\pi, \delta)$ and field of fractions $F$. Suppose that char $(k) \neq 2$. Let $D$ be quaternion division algebra over $F$ which is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. Then $D$ is isomorphic to one of the following:
i) $(u, w)$
ii) $(u, v \pi)$ or $(u, v \delta)$
iii) $(u, v \pi \delta)$
iv) $(u \pi, v \delta)$
for some units $u, v, w, \in R$.
Proposition 2.6. Let $R$ be a two dimensional complete regular local ring with residue field $k$, maximal ideal $(\pi, \delta)$ and field of fractions $F$. Suppose that char $(k) \neq 2$. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra over $F$ which is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. Suppose that $\operatorname{ind}(D)=4$. Then $D$ is isomorphic to one of the following:
i) $(u, w) \otimes(v, t)$
ii) $(u, w) \otimes(v, t \pi)$ or $(u, w) \otimes(v, t \delta)$
iii) $(u, v) \otimes(w, t \pi \delta)$
iv) $(u, w \pi) \otimes(v, t \delta)$
v) $(u, v) \otimes(w \pi, t \delta)$
for some units $u, v, w, t \in R$.
Proof. Suppose that $D$ is unramified on $R$. Let $\Gamma$ be an Azumaya algebra on $R$ with $\Gamma \otimes F \simeq$ $D([3$, Theorem 7.4]). Since $\operatorname{ind}(D)=4$, we have $\operatorname{ind}(\Gamma \otimes k)=4$. Hence $\Gamma \otimes k=(a, b) \otimes(c, d)$ for some $a, b, c, d \in k^{*}$. Let $u, w, v, t \in R$ be lifts of $a, b, c, d$. Since $R$ is complete, we have $\Gamma=(u, w) \otimes(v, t) \in \operatorname{Br}(R)$ and hence $D=(u, w) \otimes(v, t) \in \operatorname{Br}(F)$. Since $\operatorname{deg}(D)=4$, $D \simeq(u, w) \otimes(v, t)$.

Suppose that $D$ is ramified only at $\langle\pi\rangle$. Then, by Saltman's classification ([25], Proposition 3.5), we have $D=D_{0} \otimes(u, \pi)$, where $D_{0}$ is unramified on $R$ and $u \in R$ a unit which is not a square. Since $D=D_{0} \otimes(u, \pi) \otimes(1, \delta)$, by $(2.4(\mathrm{i}))$, we have $\operatorname{ind}(D)=2 \operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)$. Since $\operatorname{ind}(D)=4$, we have $\operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)=2$. Hence, by (2.2), we have $D_{0}=(u, w) \otimes(v, t)$ for some $u, v, w, t \in R$ units. We have $D=D_{0} \otimes(u, \pi)=(u, w) \otimes(v, t) \otimes(u, \pi)=(u, w \pi) \otimes(v, t)$. Since $\operatorname{ind}(D)=4, D \simeq(u, w \pi) \otimes(v, t)$. Similarly if $D$ is ramified only at $\langle\delta\rangle$, then $D \simeq$ $(u, w \delta) \otimes(v, t)$.

Suppose that $D$ is ramified both at $\langle\pi\rangle$ and $\langle\delta\rangle$. Then by ([22, Theorem 2.1] \& [23, Theorem 1.2]), we have $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$ or $D=D_{0} \otimes(w \pi, t \delta)$ for some $u, v \in R-R^{2}$ units, $w, t \in R$ units and $D_{0}$ unramified on $R$.

Suppose $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$. Suppose that $u v \in R$ is a square. Then $D=D_{0} \otimes(u, \pi \delta)$. By (2.4(i)), we have $\operatorname{ind}(D)=2 \operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)$ and hence $\operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)=2$. Thus,
by (2.2), we have $D_{0}=(u, w) \otimes(v, t)$ for some $u, v, w, t \in R$ units. In particular $D \simeq$ $(v, t) \otimes(u, w \pi \delta)$.

Suppose that $u v$ not a square in $R$. By (2.4(i)), we have $\operatorname{ind}(D)=4 \operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)$ and hence $\operatorname{ind}\left(D_{0} \otimes F(\sqrt{u})\right)=1$. Hence $D_{0} \otimes F(\sqrt{u}, \sqrt{v})$ is a matrix algebra. Thus, by (2.3), we have $D_{0}=(u, w) \otimes(v, t)$ for some units $w, t \in R$. In particular $D \simeq(u, w \pi) \otimes(v, t \delta)$.

Suppose $D=D_{0}+(w \pi, t \delta)$. By $(2.4(i i))$, we have $\operatorname{ind}(D)=2 \operatorname{ind}\left(D_{0}\right)$ and hence ind $\left(D_{0}\right)=$ 2. Thus $D_{0}=(u, v)$ and $D \simeq(u, v) \otimes(w \pi, t \delta)$.

Proposition 2.7. Let $R$ be a two dimensional complete regular local ring with residue field $k$, maximal ideal $(\pi, \delta)$ and field of fractions $F$. Suppose that char $(k) \neq 2$ and every central simple algebra in ${ }_{2} \operatorname{Br}(k)$ has index at most 2. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra over $F$ which is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. Then ind $(D) \leq 8$. Further if $\operatorname{ind}(D)=8$, then $D \simeq(w, t) \otimes(u, \pi) \otimes(v, \delta)$ for some units $u, v, w, t \in R$.

Proof. Suppose that $D$ is unramified on $R$. Let $\Gamma$ be an Azumaya algebra on $R$ with $\Gamma \otimes F \simeq$ $D$ ([3, Theorem 7.4]). By the assumption on $k$, $\operatorname{ind}(\Gamma \otimes k) \leq 2$. Since $R$ is complete, we have ind $(D) \leq 2$ ([3, Theorem 6.5]).

Suppose that $D$ is ramified only at $\langle\pi\rangle$. Then, by Saltman's classification ([25], Proposition 3.5), we have $D=D_{0} \otimes(u, \pi)$, where $D_{0}$ is unramified on $R$ and $u \in R$ a unit which is not a square. Since $D_{0}$ is unramified on $R$, by the assumption on $k, \operatorname{ind}\left(D_{0}\right) \leq 2$ and hence $\operatorname{ind}(D) \leq 4$. Similarly if $D$ is ramified only at $\langle\delta\rangle$, then $\operatorname{ind}(D) \leq 4$.

Suppose that $D$ is ramified both at $\langle\pi\rangle$ and $\langle\delta\rangle$. Then by ([22, Theorem 2.1] \& [23, Theorem 1.2]), we have $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$ or $D=D_{0} \otimes(w \pi, t \delta)$ for some $u, v \in R-R^{2}$ units, $w, t \in R$ units and $D_{0}$ unramified on $R$. Since $D_{0}$ is unramified on $R$, by the assumption on $k$, ind $\left(D_{0}\right) \leq 2$. In particular ind $(D) \leq 8$.

Suppose $\operatorname{ind}(D)=8$. Then $D=D_{0} \otimes(u, \pi) \otimes(v, \delta)$ for some units $u, v \in R$ units and $D_{0}$ unramified on $R$. Once again by the assumption on $k$, we have $D_{0}=(w, t)$ for some units $w, t \in R$. Hence $D \simeq(w, t) \otimes(u, \pi) \otimes(v, \delta)$.

## 3. Two torsion division algebras with involution of second kind over two dimensional local fields

Let $R_{0}$ be a 2-dimensional complete regular local ring with maximal ideal $\mathfrak{m}_{0}=\left(\pi_{0}, \delta_{0}\right)$ and residue field $k_{0}$. Suppose that $\operatorname{char}\left(k_{0}\right) \neq 2$. Let $F_{0}$ be the field of fractions of $R_{0}$ and let $F=F_{0}(\sqrt{\lambda})$ be an extension of degree 2 , with $\lambda$ a unit in $R_{0}$ or $\lambda=w \pi_{0}$ for some unit $w \in R_{0}$. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra with $F / F_{0}$-involution $\sigma$. In this section we show that if $\operatorname{ind}(D)=4$, then $D$ is a tensor product of two quaternion algebras with some properties. Suppose that for any central simple algebra $A \in{ }_{2} \operatorname{Br}(k)$, $\operatorname{ind}(A) \leq 2$. Then we show that $\operatorname{ind}(D) \leq 8$. Further we show that if $\operatorname{ind}(D)=8$, then $D$ is isomorphic to a tensor product of three quaternion algebras with some properties.

Let $R$ be the integral closure of $R_{0}$ in $F$. By the assumption on $\lambda, R$ is a 2 -dimensional regular local ring with maximal ideal $\mathfrak{m}=(\pi, \delta)$ ([19, Theorem 3.1, 3.2]), where; if $\lambda$ is a unit in $R_{0}$, then $\pi=\pi_{0}$ and $\delta=\delta_{0}$ and if $\lambda=w \pi_{0}$, then $\pi=\sqrt{\lambda}$ and $\delta=\delta_{0}$.

Proposition 3.1. Let $R$ and $F$ be as above. Let $D \in{ }_{2} B r(F)$ with an $F / F_{0}$ involution. Suppose that $D$ is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. If $\lambda=w \pi_{0}$ for some unit $w \in R_{0}$, then $D=\left(D_{0} \otimes\left(v_{0}, \delta_{0}\right)\right) \otimes_{F_{0}} F$ for some $D_{0} \in{ }_{2} \operatorname{Br}\left(F_{0}\right)$ which is unramified on $R_{0}$ and $v_{0} \in R_{0}$ a unit.

Proof. Since $F / F_{0}$ is ramified at $\pi_{0}$, by $([18$, Lemma 6.3]), $D$ is unramified at $\pi$. Hence, by([25, Proposition 3.5]), $D=D^{\prime} \otimes(v, \delta)$ for some unit $v \in R$ and $D^{\prime}$ unramified on $R$. Let $\Gamma^{\prime}$ be an Azumaya $R$-algebra with $\Gamma^{\prime} \otimes F \simeq D^{\prime}$. Since $R / \mathfrak{m}=R_{0} / \mathfrak{m}_{0}$ and $R$ is complete, there exists an Azumaya $R_{0}$-algebra $\Gamma_{0}$ with $\Gamma^{\prime} \simeq \Gamma_{0} \otimes R$. Let $D_{0}=\Gamma_{0} \otimes F_{0}$. Since $R / \mathfrak{m}=R_{0} / \mathfrak{m}_{0}$, we have $v=v_{0} v_{1}^{2}$ for some $v_{1} \in R_{0}$ a unit. Since $\delta=\delta_{0}$, we have $D=\left(D_{0} \otimes\left(v_{0}, \delta_{0}\right)\right) \otimes F$ as required.

For the rest of the section, we assume that $\lambda \in R_{0}$ is a unit. In particular $\pi=\pi_{0}$ and $\delta=\delta_{0}$ and $F / F_{0}$ is unramified on $R_{0}$. Let $\tau$ denote the non trivial automorphism of $F / F_{0}$.

Proposition 3.2. Let $\Gamma^{\prime}$ be an Azumaya $R$-algebra and $D^{\prime}=\Gamma^{\prime} \otimes F$. Suppose that $D^{\prime} \in$ ${ }_{2} \operatorname{Br}(F)$. Let $D=D^{\prime} \otimes(u, \pi) \otimes(v, \delta)\left(\right.$ resp. $\left.D=D^{\prime} \otimes(u \pi, v \delta)\right)$. If $D$ has a $F / F_{0}$-involution, then $D^{\prime},(u, \pi)$ and $(v, \delta)$ (resp. $D^{\prime}$ and $\left.(u \pi, v \delta)\right)$ have $F / F_{0}$-involutions.
Proof. Suppose $D=D^{\prime} \otimes(u, \pi) \otimes(v, \delta)$ has a $F / F_{0}$-involution. Since $\operatorname{cores}_{F / F_{0}}(D)=0$, by $([18, \operatorname{Lemma} 6.4])$, $\operatorname{cores}_{F_{\delta} / F_{0 \delta_{0}}}\left(D^{\prime} \otimes(u, \pi)\right)=0$ and $\operatorname{cores}_{F_{\delta} / F_{0 \delta_{0}}}(v, \delta)=0$. Since $D^{\prime}$ is unramified on $R$, $\operatorname{cores}_{F / F_{0}}\left(D^{\prime}\right)$ is unramified on $R_{0}$. Since $\pi=\pi_{0} \in R_{0}$ and $\delta=\delta_{0} \in R_{0}$, $\operatorname{cores}_{F / F_{0}}(u, \pi)=\left(N_{F / F_{0}}(u), \pi_{0}\right) \otimes F_{0}$ and $\operatorname{cores}_{F / F_{0}}(v, \delta)=\left(N_{F / F_{0}}(v), \delta_{0}\right) \otimes F_{0}$. In particular $\operatorname{cores}_{F / F_{0}}\left(D^{\prime} \otimes(u, \pi)\right)$ and $\operatorname{cores}_{F / F_{0}}(v, \delta)$ are unramified on $R_{0}$ except possibly at $\left(\pi_{0}\right)$. Hence, by $(1.2), \operatorname{cores}_{F / F_{0}}\left(D^{\prime} \otimes(u, \pi)\right)=0$ and $\operatorname{cores}_{F / F_{0}}(v, \delta)=0$. The same argument implies that $\operatorname{cores}_{F / F_{0}}\left(D^{\prime}\right)=0$ and $\operatorname{cores}_{F / F_{0}}(u, \pi)=0$. Hence $D^{\prime},(u, \pi)$ and $(v, \delta)$ have $F / F_{0}$-involutions.

The case $D=D^{\prime} \otimes(u \pi, v \delta)$ is similar.
Lemma 3.3. Let $D_{1}=(u, \pi)$ (resp. $\left.(u \pi, v \delta),(u, v)\right)$ for some units $u, v \in R$. If $D_{1}$ has a $F / F_{0}$ involution, then $D_{1}=\left(u_{0}, \pi\right)$ (resp. $\left.\left(u_{0} \pi, v_{0} \delta\right),\left(u_{0}, v_{0}\right)\right)$ for some $u_{0}, v_{0} \in R_{0}$ units.

Proof. Suppose $D_{1}=(u, \pi)$ for some $u \in R$ unit. Since $\pi=\pi_{0} \in R_{0}$, we have $\operatorname{cores}_{F / F_{0}}(u, \pi)=$ $\left(N_{F / F_{0}}(u), \pi_{0}\right)$. Since $D_{1}$ has a $F / F_{0}$-involution, we have $\left(N_{F / F_{0}}(u), \pi_{0}\right)=0 \in \operatorname{Br}\left(F_{0}\right)$. Since the residue of $\left(N_{F / F_{0}}(u), \pi_{0}\right)$ at $\pi_{0}$ is the image of $N_{F / F_{0}}(u)$ in $\kappa\left(\pi_{0}\right)^{*} / \kappa\left(\pi_{0}\right)^{* 2}$, the image of $N_{F / F_{0}}(u)$ is a square in $\kappa\left(\pi_{0}\right)$. Since $R_{0}$ is a complete local ring with $\pi_{0}$ a regular prime, $N_{F / F_{0}}(u)$ is a square in $R_{0}$. Let $w_{0} \in R_{0}$ be such that $N_{F / F_{0}}(u)=w_{0}^{2}$. Then $N_{F / F_{0}}\left(w_{0}^{-1} u\right)=1$ and hence $w_{0}^{-1} u=\theta \tau(\theta)^{-1}$ for some $\theta \in R$. We have $u \tau(\theta)^{2}=w_{0} \theta \tau(\theta)=u_{0} \in R_{0}$ and $(u, \pi)=\left(u_{0}, \pi\right)$.

Suppose $D_{1}=(u \pi, v \delta)$. As above, by taking the residues at $\pi$ and $\delta$, we see that $N_{F / F_{0}}(u)$ and $N_{F / F_{0}}(v)$ are squares. Hence as above, we can replace $u$ and $v$ by $u_{0}$ and $v_{0}$ for some $u_{0}, v_{0} \in R_{0}$ units.

Suppose that $D_{1}=(u, v)$ for some $u, v \in R$. Since $D_{1}$ has an $F / F_{0}$-involution and $D_{1}$ is unramified on $R, D_{1}=D_{0} \otimes F$ for some quaternion algebra $D_{0}$ over $F_{0}$ which is unramified on $R_{0}$ ([3, Theorem 7.4]). In particular $D_{0}=\left(u_{0}, v_{0}\right)$ for some units $u_{0}, v_{0} \in R_{0}$

Corollary 3.4. Let $D \in{ }_{2} \operatorname{Br}(F)$ with an $F / F_{0}$-involution. Suppose that $D$ is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$ and ind $(D)=2$. Then one of the following holds
i) $D$ is unramified on $R$
ii) $D \simeq\left(u_{0}, u_{1} \pi_{0}\right)$ or $D \simeq\left(v_{0}, v_{1} \delta_{0}\right)$
iii) $D \simeq\left(u_{0}, u_{1} \pi_{0} \delta_{0}\right)$
iv) $D \simeq\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right)$
for some units $w_{i}, u_{i}, v_{i} \in R_{0}$
Proof. Follows from (2.5), (3.2) and (3.3).

Corollary 3.5. Let $D \in{ }_{2} \operatorname{Br}(F)$ with an $F / F_{0}$-involution. Suppose that $D$ is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$ and ind $(D)=4$. Then one of the following holds
i) $D$ is unramified on $R$
ii) $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(u_{0}, u_{1} \pi_{0}\right)$ or $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right)$
iii) $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(u_{0}, u_{1} \pi_{0} \delta_{0}\right)$
iv) $D \simeq\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right)$
v) $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right)$
for some units $w_{i}, u_{i}, v_{i} \in R_{0}$
Proof. Follows from (2.6), (3.2) and (3.3).
Corollary 3.6. Let $D \in{ }_{2} \operatorname{Br}(F)$ with an $F / F_{0}$-involution. Suppose that $D$ is unramified on $R$ except possibly at $(\pi)$ and ( $\delta$ ) and every element of ${ }_{2} \operatorname{Br}(k)$ has index at most 2. If $\operatorname{ind}(D)=8$, then Then $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(u_{0}, \pi_{0}\right) \otimes\left(v_{0}, \delta_{0}\right)$ for some units $w_{0}, w_{1}, u_{0}, v_{0} \in R_{0}$.

Proof. By the assumptions on $k$ and $D$, by (2.7), $D \simeq\left(w_{0}, w_{1}\right) \otimes\left(u_{0}, \pi\right) \otimes\left(v_{0}, \delta\right)$ for some units $w_{0}, w_{1}, u_{0}, v_{0} \in R$. Since $D$ has a $F / F_{0}$-involution, by (3.2), $\left(w_{0}, w_{1}\right),\left(u_{0}, \pi\right)$ and $\left(v_{0}, \delta\right)$ have $F / F_{0}$-involutions. As in the proof of (3.5), we can assume $w_{0}, w_{1}, u_{0}, v_{0} \in R_{0}$.

## 4. MAXIMAL ORDERS

Let $R$ be a complete regular local ring with residue field $k,(\pi, \delta)$ maximal ideal and field of fractions $F$. Suppose that $\operatorname{char}(k) \neq 2$. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra which is unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. By (([25], Proposition 3.5)), we know that $D=D_{0} \otimes D_{1}$ for some $D_{0} \in{ }_{2} \operatorname{Br}(F)$ which is unramified on $R$ and $D_{1}$ is $(u, v \pi)$ or $(u, v \delta)$ or $(u, w \pi) \otimes(v, t \delta)$ or $(u, v \pi \delta)$ or (um,vס) for some units $u, v \in R$. If $D \simeq D_{0} \otimes D_{1}$, then in this section we show that there is a maximal $R$-order with some properties.

For an integral domain $R$ and $a, b \in R$ non zero elements, let $R(a, b)$ be the $R$-algebra generated by $i, j$ with $i^{2}=a, j^{2}=b$ and $i j=-j i$. Suppose that $2 \in R$ is a unit. Then $R(a, b)$ is a $R$-order in the quaternion algebra $(a, b)$ over $F$. Further note that if $a, b \in R$ are units, then $R(a, b)$ is an Azumaya $R$-algebra.

Proposition 4.1. Let $R$ be a complete discrete valuation ring with residue field $k$ and field of fractions $F$. Suppose that char $(k) \neq 2$. Let $\Gamma_{0}$ be an Azumaya algebra over $R$ and $D_{0}=\Gamma_{0} \otimes_{R} K$. Let $u \in R$ be a unit and $\pi \in R$ a parameter. If $D=D_{0} \otimes(u, \pi)$ is a division algebra, then $\Gamma=\Gamma_{0} \otimes_{R} R(u, \pi)$ is the maximal $R$-order of $D$.

Proof. Suppose that $D$ is division. Let $d=\operatorname{deg}(D)$ and $d_{0}=\operatorname{deg}\left(D_{0}\right)$. Then $d=2 d_{0}$.
There is a discrete valuation on $D$ given by $\nu_{D}(z)=\nu\left(N r d_{D}(z)\right)$ ([21, p. 139]). Furthermore $\Gamma^{\prime}=\left\{z \in D^{*} \mid \nu_{D}(z) \geq 0\right\} \cup\{0\}=\{z \in D \mid z$ is integral over $R\}$ is the unique maximal $R$-order of $D$ ([21, Theorem 12.8]).

Since $\Gamma_{0}$ and $R(u, \pi)$ are finitely generated $R$-modules, $\Gamma$ is a finitely generated $R$-module and hence every element of $\Gamma$ is integral over $R$. Hence $\Gamma \subseteq \Gamma^{\prime}$. We now show that $\Gamma^{\prime} \subseteq \Gamma$.

Let $i, j \in(u, \pi)$ be the standard generators with $i^{2}=u, j^{2}=\pi$ and $i j=-j i$. Let $D_{1}=D_{0} \otimes F(i) \subset D$ and $\Gamma_{1}=\Gamma_{0} \otimes R[i]$. Then $D=D_{1}+D_{1} j$ and $\Gamma=\Gamma_{1} \oplus \Gamma_{1} j$. Since $D_{0}$ is unramified, $D_{1}$ is unramified. Since $D$ is a division algebra, $D_{1}$ is a division algebra. Since $\Gamma_{0}$ is an Azumaya algebra over $R, \Gamma_{1}$ is an Azumaya algebra over $R[i]$. In particular $\Gamma_{1}$ is the maximal $R[i]$-order in $D_{1}$. Since $F(i) / F$ is an unramified extension and $D_{0}$ is unramified on
$R, \pi$ is a parameter in $D_{1}$. Therefore, $\nu_{D}(z)$ is a multiple of $2 d_{0}$ for all $z \in D_{1}$ ([21, p. 139]). Since $j^{2}=\pi$ and $\operatorname{Nrd}_{D}(j)=\pi^{d_{0}}$, we have $\nu_{D}(j)=d_{0}$.

Let $z \in \Gamma^{\prime}$. Then $z=z_{1}+z_{2} j$ for some $z_{1}, z_{2} \in D_{1}$. Suppose that $\nu_{D}\left(z_{1}\right)=\nu_{D}\left(z_{2} j\right)$. Then $\nu_{D}\left(z_{1}\right)-\nu_{D}\left(z_{2}\right)=\nu_{D}(j)=d_{0}$. This is a contradiction, since $\nu_{D}\left(z_{1}\right)$ and $\nu_{D}\left(z_{2}\right)$ are multiple of $2 d_{0}$. Hence $\nu_{D}\left(z_{1}\right) \neq \nu_{D}\left(z_{2} j\right)$. Then $\nu_{D}(z)=\min \left\{\nu_{D}\left(z_{1}\right), \nu_{D}\left(z_{2} j\right)\right\} \geq 0$. In particular $\nu_{D}\left(z_{1}\right) \geq 0$ and hence $z_{1} \in \Gamma_{1}$. Since $\nu_{D}\left(z_{2} j\right)=\nu_{D}\left(z_{2}\right)+\nu_{D}(j)=\nu_{D}\left(z_{2}\right)+d_{0}$, we have $\nu_{D}\left(z_{2}\right) \geq-d_{0}$. Since $\nu_{D}\left(z_{2}\right)$ is a multiple of $2 d_{0}$, it follows that $\nu_{D}\left(z_{2}\right) \geq 0$ and hence $z_{2} \in \Gamma_{1}$. Thus $z \in \Gamma$.
Proposition 4.2. Let $R$ be a discrete valuation ring with residue field $k$, field of fractions $F$ and $\hat{F}$ the completion of $F$. Suppose that $\operatorname{char}(k) \neq 2$. Let $\Gamma_{0}$ be an Azumaya algebra over $R$ and $D_{0}=\Gamma_{0} \otimes_{R} F$. Let $u \in R$ be a unit and $\pi \in R$ a parameter. If $\left(D_{0} \otimes_{F}(u, \pi)\right) \otimes_{F} \hat{F}$ is a divison algebra, then $\Gamma_{0} \otimes_{R} R(u, \pi)$ is the maximal $R$-order of $D_{0} \otimes_{F}(u, \pi)$.
Proof. Let $\hat{R}$ be the completion of $R$. Let $\hat{\Gamma}_{0}=\Gamma_{0} \otimes \hat{R}$. Then $\hat{\Gamma}_{0}$ is an Azumaya algebra over $\hat{R}$. Since $\left(D_{0} \otimes_{F}(u, \pi)\right) \otimes_{F} \hat{F}$ is a divison algebra, by (4.1), $\hat{\Gamma}_{0} \otimes \hat{R}(u, \pi)$ is a maximal $\hat{R}$-order of $\left(D_{0} \otimes_{F}(u, \pi)\right) \otimes_{F} \hat{F}$. Thus, by ([21], Theorem 11.5), $\Gamma_{0} \otimes_{R} R(u, \pi)$ is the maximal $R$-order of $D_{0} \otimes_{F}(u, \pi)$.
Corollary 4.3. Let $R$ be a two dimensional complete regular local ring with residue field $k$, field of fractions $F$ and maximal ideal $\mathfrak{m}=(\pi, \delta)$. For units $u, v \in R$, let $D_{1}$ and $\Gamma_{1}$ be one of the following:
i) $D_{1}=(u, v), \Gamma_{1}=R(u, v)$
ii) $D_{1}=(u, \pi), \Gamma_{1}=R(u, \pi)$
iii) $D_{1}=(\pi, \delta), \Gamma_{1}=R(\pi, \delta)$
iv) $D_{1}=(u, \pi \delta), \Gamma_{1}=R(u, \pi \delta)$
v) $D_{1}=(u, \pi) \otimes(v, \delta), \Gamma_{1}=R(u, \pi) \otimes R(v, \delta)$.

Let $\Gamma_{0}$ be an Azumaya algebra over $R$ and $D_{0}=\Gamma_{0} \otimes_{R} F$. If $D_{0} \otimes_{F} D_{1}$ is a division algebra, then $\Gamma=\Gamma_{0} \otimes_{R} \Gamma_{1}$ is a maximal $R$-order of $D_{0} \otimes_{F} D_{1}$.
Proof. An order of a Noetherian integrally closed domain is maximal if and only if it is reflexive and its localization at all height one prime ideals are maximal orders ([21], Theorem 11.4). Since $\Gamma$ is a finitely generated free module, it is reflexive. Furthermore, $R$ is a regular local ring, hence it is Noetherian and integrally closed. We only need to show that $\Gamma_{P}$ is a


Suppose that $D=D_{0} \otimes_{F} D_{1}$ is a division algebra. Let $P$ be a height one prime ideal of $R$. Suppose $P \neq\langle\pi\rangle,\langle\delta\rangle$. Since $u, v \in R$ are units, $u, v, \pi, \delta$ are units in $R_{P}$ and hence $\Gamma_{1} \otimes R_{P}$ is an Azumaya $R_{P}$-algebra. In particular $\Gamma \otimes R_{P}$ is an Azumaya $R_{P}$-algebra. Hence $\Gamma_{P}$ is a maximal $R_{P}$-order of $D$. Suppose that $P=\langle\pi\rangle,\langle\delta\rangle$.
i) Since $u, v \in R$ are units, $\left(\Gamma_{1}\right)_{P}$ is an Azumaya algebra over $R_{P}$. Hence $\Gamma_{P}$ is a maximal $R_{P}$-order on $D$.
ii) If $P \neq\langle\pi\rangle$ ), then $\Gamma_{1}$ is an Azumaya $R_{P}$-algebra and hence $\Gamma_{P}$ is a maximal $R_{P}$-order on $D$. If $P=\langle\pi\rangle$, then $\Gamma_{P}$ is a maximal $R_{P}$-order on $D$ by (4.2).
iii), iv) If $P=\langle\pi\rangle$ or $P=\langle\delta\rangle$, then $\Gamma_{P}$ is a maximal $R_{P}$-order on $D$ by (4.2).
v) Suppose $P=\langle\pi\rangle$. Let $\Gamma_{0}^{\prime}=\Gamma_{0} \otimes R_{P}(v, \delta)$. Since $v, \delta$ are units in $R_{P}, R_{P}(v, \delta)$ is an Azumaya $R_{P}$-algebra. Since $D=\left(D_{0} \otimes(v, \delta)\right) \otimes(u, \pi)$ and $\Gamma=\left(\Gamma_{0} \otimes R_{P}(v, \delta)\right) \otimes$ $R_{P}(u, \pi)$, by (4.2), $\Gamma_{P}$ is a maximal $R_{P}$-order on $D$. If $P=\langle\delta\rangle$, a similar argument holds.

## 5. A LOCAL GLOBAL PRINCIPLE FOR HERMITIAN FORMS OVER TWO DIMENSIONAL

 LOCAL FIELDSLet $R_{0}$ be a 2-dimensional complete regular local ring with maximal ideal $\mathfrak{m}_{0}=\left(\pi_{0}, \delta_{0}\right)$ and residue field $k_{0}$. Suppose that $\operatorname{char}\left(k_{0}\right) \neq 2$. Let $F_{0}$ be the field of fractions of $R_{0}$ and let $F=F_{0}(\sqrt{\lambda})$ be an extension of degree at most 2 , with $\lambda$ a unit in $R_{0}$ or a unit times $\pi_{0}$. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra with $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$. In this section, under some assumptions on $D, F_{0}$ and $h$, we prove that if $h \otimes F_{0 \pi}$ or $h \otimes F_{0 \delta}$ is isotropic, then $h$ is isotropic.

Let $R$ be the integral closure of $R_{0}$ in $F$. By the assumption on $\lambda, R$ is a 2 -dimensional regular local ring with maximal ideal $(\pi, \delta)$ ([19, pp. 3.1, 3.2]), where; if $\lambda$ is a unit in $R_{0}$, then $\pi=\pi_{0}$ and $\delta=\delta_{0}$ and if $\lambda$ is a unit times $\pi_{0}$, then $\pi=\sqrt{\lambda}$ and $\delta=\delta_{0}$.

Let $G(D, \sigma, h)=S U(D, \sigma, h)$ if $F=F_{0}$ and $G(D, \sigma, h)=U(A, \sigma, h)$ if $\left[F: F_{0}\right]=2$.
We begin with the following, which is proved by $\mathrm{Wu}([25$, Corollary 3.12$])$ for $D$ a quaternion algebra.

Proposition 5.1. Let $F_{0}$ and $F$ be as above. Let $D \in{ }_{2} \operatorname{Br}(F)$ and $\sigma$ an $F / F_{0}$ - involution. Suppose that $D$ is a division algebra which unramified on $R$ except possibly at $(\pi)$ and $(\delta)$. Let $d=\operatorname{deg}(D), e_{0}$ the ramification index of $D$ at $\pi$ and $e_{1}$ the ramification index of $D$ at $\delta$. Suppose that there exists a maximal $R$-order $\Gamma$ of $D$ and $\pi_{D}, \delta_{D} \in \Gamma$ such that $\sigma\left(\pi_{D}\right)= \pm \pi_{D}$, $\sigma\left(\delta_{D}\right)= \pm \pi_{D}$ and $\pi_{D} \delta_{D}= \pm \delta_{D} \pi_{D}$ and $\operatorname{Nrd}\left(\pi_{D}\right)=\theta_{0} \pi^{\frac{d}{e_{0}}}$ and $\operatorname{Nrd}\left(\delta_{D}\right)=\theta_{1} \delta^{\frac{d}{e_{1}}}$ for some units $\theta_{0}, \theta_{1} \in R$. Let $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ be an hermitian form over $(D, \sigma)$. Suppose that for $1 \leq i \leq n, a_{i} \in \Gamma$ and $\operatorname{Nrd}\left(a_{i}\right)$ is a product of a unit in $R$, a power of $\pi$ and a power of $\delta$. If $h \otimes F_{\pi}$ or $h \otimes F_{\delta}$ is isotropic, then $h$ is isotropic.
Proof. Follows from ([25, Corollary 3.3]).
As a consequence we have the following (cf. [25, Corollary 3.12])
Proposition 5.2. Let $F_{0}$ and $F$ be as above. Let $D \in{ }_{2} \operatorname{Br}(F)$ and $\sigma$ an $F / F_{0}$ - involution. Suppose that $D$ is a division algebra which is unramified on $R$ except possibly at ( $\pi$ ) and $(\delta)$. Let $d=\operatorname{deg}(D)$, $e_{0}$ the ramification index of $D$ at $\pi$ and $e_{1}$ the ramification index of $D$ at $\delta$. Suppose that there exists a maximal $R$-order $\Gamma$ of $D$ and $\pi_{D}, \delta_{D} \in \Gamma$ such that $\sigma\left(\pi_{D}\right)= \pm \pi_{D}, \sigma\left(\delta_{D}\right)= \pm \pi_{D}, \pi_{D} \delta_{D}= \pm \delta_{D} \pi_{D}, N r d\left(\pi_{D}\right)=\theta_{0} \pi^{\frac{d}{e_{0}}}$ and $\operatorname{Nrd}\left(\delta_{D}\right)=\theta_{1} \delta^{\frac{d}{e_{1}}}$ for some units $\theta_{0}, \theta_{1} \in R$. Let $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ be an hermitian form over $(D, \sigma)$. Suppose that for $1 \leq i \leq n, a_{i} \in \Gamma$ and $\operatorname{Nrd}\left(a_{i}\right)$ is a product of a unit in $R$, a power of $\pi$ and a power of $\delta$. Let $X$ be a projective homogeneous space under $G(D, \sigma, h)$. If $X\left(F_{0 \pi}\right) \neq \emptyset$ or $X\left(F_{0 \delta}\right) \neq \emptyset$, then $X\left(F_{0}\right) \neq \emptyset$.
Proof. Since the period of $D$ divides 2 by our assumption on $D$, we have ind $(D)=\operatorname{ind}\left(D \otimes F_{\pi}\right)$ (1.2). Suppose that $X\left(F_{0 \pi}\right) \neq \emptyset$ or $X\left(F_{0 \delta}\right) \neq \emptyset$. Using, (5.1), the rest of the proof of ([25, Corollary 3.12]) can be applied here to show that $X\left(F_{0}\right) \neq \emptyset$.

We fix the following.

Notation 5.3. Let $R_{0}$ be a 2-dimensional complete regular local ring with maximal ideal $\mathfrak{m}_{0}=\left(\pi_{0}, \delta_{0}\right)$ and residue field $k_{0}$. Suppose that $\operatorname{char}\left(k_{0}\right) \neq 2$. Let $F_{0}$ be the field of fractions of $R_{0}$ and let $F=F_{0}(\sqrt{\lambda})$ be an extension of degree at most 2, with $\lambda$ a unit in $R_{0}$ or a unit times $\pi_{0}$. Let $R$ be the integral closure of $R_{0}$ in $F$. By the assumption on $\lambda, R$ is a 2-dimensional regular local ring with maximal ideal ( $\pi, \delta$ ) ([19, pp.3.1, 3.2]), where; if $\lambda$ is a unit in $R_{0}$, then $\pi=\pi_{0}$ and $\delta=\delta_{0}$ and if $\lambda$ is a unit times $\pi_{0}$, then $\pi=\sqrt{\lambda}$ and $\delta=\delta_{0}$. Let $u_{i}, v_{i} \in R_{0}$ be units and $D_{1}, \Gamma_{1}$ and $\sigma_{1}$ denote one of the following:
i) $D_{1}=F_{0}, \Gamma_{1}=R, \sigma_{1}=i d$
ii) $D_{1}=\left(u_{0}, u_{1} \pi_{0}\right), \Gamma_{1}=R\left(u_{0}, u_{1} \pi_{0}\right)$, $\sigma_{1}$ the canonical involution
iii) $D_{1}=\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right), \Gamma_{1}=R\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right)$, $\sigma_{1}$ the canonical involution
iv) $D_{1}=\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right), \Gamma_{1}=R\left(u_{0}, u_{1} \pi_{0}\right) \otimes R\left(v_{0}, v_{1} \delta_{0}\right)$, $\sigma_{1}$ the tensor product of the canonical involutions
Let $\Gamma_{0}$ be an Azumaya algebra over $R$ with an $R / R_{0}$ - involution $\tilde{\sigma}_{1}$. Let $D_{0} \simeq \Gamma_{0} \otimes F$ and $\sigma_{0}=\tilde{\sigma_{0}} \otimes 1$. Let $D \simeq D_{0} \otimes D_{1}, \Gamma=\Gamma_{0} \otimes \Gamma_{1}$ and $\sigma=\sigma_{0} \otimes \sigma_{1}$. Then $\sigma$ is a $F / F_{0}$-involution on $D$ and $\sigma(\Gamma)=\Gamma$. Let $d_{i}$ denote the degree of $D_{i}$. The following table gives a choice of $\pi_{D}, \delta_{D} \in \Gamma$ and some of their properties.

Corollary 5.4. Let $F, D, \sigma$ and $\Gamma$ be as in (5.3). Suppose that $D$ is a division algebra. Let $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ be a hermitian form over $(D, \sigma)$ with $a_{i} \in \Gamma$. Suppose $\operatorname{Nr} d\left(a_{i}\right)$ is a unit times a power of $\pi$ and a power of $\delta$. Let $X$ be a projective homogeneous space under $G(D, \sigma, h)$ over $F_{0}$. If $X\left(F_{0 \pi_{0}}\right) \neq \emptyset$ or $X\left(F_{0 \delta}\right) \neq \emptyset$, then $X\left(F_{0}\right) \neq \emptyset$.

Proof. By (4.3), $\Gamma$ is a maximal $R$-order of $D$. Let $e_{0}$ be the ramification index of $D$ at $\pi$ and $e_{1}$ be the ramification index of $D$ at $\delta$. If $D_{1}$ as in (5.3(i)), then $e_{0}=e_{1}=1$. If $D_{1}$ is as in (5.3(ii)), then $e_{0}=2$ and $e_{1}=1$. If $D_{1}$ as in (5.3(iii) or (iv)), then $e_{0}=e_{1}=2$. Let $\pi_{D}$ and $\delta_{D}$ be as in (5.3). Then $\pi_{D}$ and $\delta_{D}$ satisfy the assumptions of (5.2). Hence, by (5.2), $X\left(F_{0}\right) \neq \emptyset$.

## 6. Behavior under blowups

Let $R_{0}$ be a 2-dimensional complete regular local ring with maximal ideal $\mathfrak{m}_{0}=\left(\pi_{0}, \delta_{0}\right)$ and residue field $k_{0}$. Suppose that $\operatorname{char}\left(k_{0}\right) \neq 2$. Let $F_{0}$ be the field of fractions of $R_{0}$ and let $F=F_{0}(\sqrt{\lambda})$ be an extension of degree at most 2 . Let $D \in{ }_{2} \operatorname{Br}(F)$ be a division algebra with $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$ and $G(A, \sigma, h)$ be as in (§5). Let $X$ be a projective homogeneous variety under $G(A, \sigma, h)$ over $F_{0}$. Suppose that $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$. Under some assumptions on $D$, in this section we prove that there exists a sequence of blowups $\mathscr{Y}$ of $\operatorname{Spec}\left(R_{0}\right)$ such that $X\left(F_{0 P}\right) \neq \emptyset$ for all closed points $P$ of $\mathscr{Y}$.

Let $\mathscr{X}_{0}=\operatorname{Proj}\left(R_{0}[x, y] /\left(\pi_{0} x-\delta_{0} y\right)\right)$. Let $Q_{1}$ and $Q_{2}$ be the closed points of $\mathscr{X}_{0}$ given by the homogeneous ideals $\left(\pi_{0}, \delta_{0}, y\right)$ and $\left(\pi_{0}, \delta_{0}, x\right)$. Let $\tau$ be the nontrivial automorphism of $F / F_{0}$ if $F \neq F_{0}$ and let $\tau$ be the identity if $F=F_{0}$.

We begin with the following.
Lemma 6.1. Suppose that $\lambda$ a unit in $R_{0}$ or a unit times $\pi_{0}$. Let $a, b \in R_{0}$ be nonzero and square free. Suppose that the support of $a$ and $b$ is at most $\pi_{0}$ and $\delta_{0}$ and have no common factors. Then for any closed point $P \in \mathscr{X}_{0}$, there exist $a^{\prime}, b^{\prime}, \pi^{\prime}, \delta^{\prime} \in \mathcal{O}_{P}$ such that the maximal ideal at $P$ is generated by $\pi^{\prime}$ and $\delta^{\prime}, a^{\prime}$ and $b^{\prime}$ are square free, have no common factors, the support is at most $\left(\pi^{\prime}\right)$ or $\left(\delta^{\prime}\right)$ and $(a, b) \otimes F_{0 P}=\left(a^{\prime}, b^{\prime}\right)$ and $R_{0}(a, b) \subset \hat{\mathcal{O}}_{P}\left(a^{\prime}, b^{\prime}\right)$.

Proof. Suppose $a$ is a unit $R_{0}$. Then $b=v_{0}$ or $v_{0} \pi_{0}$ or $v_{0} \delta_{0}$ or $v_{0} \pi_{0} \delta_{0}$ for some unit $v_{0} \in R_{0}$. If $b=v_{0}$ or $v_{0} \pi_{0}$ or $v_{0} \delta_{0}$, then it is easy to see that $a^{\prime}=a$ and $b^{\prime}=b$ have the required properties. Suppose $b=v_{0} \pi_{0} \delta_{0}$. Suppose $P \neq Q_{1}, Q_{2}$. Then the maximal ideal at $P$ is given by $\left(\pi_{0}, \delta^{\prime}\right)$ with $\pi_{0}=w^{\prime} \delta_{0}$ for some unit $w^{\prime}$ in $\mathcal{O}_{P}$. We have $(a, b)=\left(a, v_{0} \pi_{0} \delta_{0}\right)=\left(a, v_{0} w^{\prime}\right)$. In this case it is easy to see that $a^{\prime}=a$ and $b^{\prime}=v_{0} w^{\prime}$ have the required property. Suppose $P=Q_{1}$. Then the maximal ideal at $P$ is given by $\left(t, \delta_{0}\right)$ with $\pi_{0}=t \delta_{0}$. We have $(a, b)=\left(a, v_{0} t \delta_{0}\right)$ and $a^{\prime}=a, b^{\prime}=v_{0} t \delta_{0}$ have the required properties. The case $P=Q_{2}$ is similar.

Suppose neither $a$ nor $b$ is a unit in $R_{0}$. Then by the assumption on $a, b$, we have $\{a, b\}=$ $\left\{u_{0} \pi_{0}, v_{0} \delta_{0}\right\}$ for some units $u_{0}, v_{0} \in R_{0}$. Suppose $P=Q_{1}$. Since the maximal ideal of $\hat{\mathcal{O}}_{Q_{1}}$ is given by $\left(t, \delta_{0}\right)$ with $\pi_{0}=t \delta_{0}$, we have $(a, b) \otimes F_{0 Q_{1}}=\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right) \otimes F_{0 Q_{1}}=\left(u_{0} t \delta, v_{0} \delta\right) \otimes F_{0 Q_{1}} \simeq$ $\left(-u_{0} v_{0} t, v_{0} \delta_{0}\right)$. It is easy to see that $a^{\prime}=-u_{0} v_{0} t$ and $b^{\prime}=v_{0} \delta_{0}$ have the required properties. The case $P=Q_{2}$ is similar. Suppose $P \neq Q_{1}, Q_{2}$. Since the maximal ideal at $P$ is given by $\left(\pi_{0}, \delta^{\prime}\right)$ with $\pi_{0}=w^{\prime} \delta_{0}$ for some unit $w^{\prime}$ in $\mathcal{O}_{P}$ and $(a, b)=\left(u_{0} \pi_{0}, v_{0} \delta_{0}\right)=\left(u_{0} \pi_{0}, v_{0} w^{\prime} \pi_{0}\right)=$ $\left(u_{0} \pi_{0}, v_{0} w^{\prime} u_{0}\right), a^{\prime}=u_{0} \pi_{0}$ and $b^{\prime}=v_{0} w^{\prime} u_{0}$ have the required properties.

Lemma 6.2. Suppose that $\lambda$ a unit in $R_{0}$ or a unit times $\pi_{0}$. Suppose $D=\left(u_{0}, u_{1} \pi_{0}\right) \otimes$ $\left(v_{0}, v_{1} \delta_{0}\right)$ is a division algebra for some units $u_{i}, v_{i} \in R_{0}$. Let $\sigma$ be the tensor product of canonical involutions on $\left(u_{0}, u_{1} \pi_{0}\right),\left(v_{0}, v_{1} \delta_{0}\right)$. Then for $P=Q_{1}$ or $Q_{2}$, there exist an isomorphism $\phi_{P}: D \otimes F_{0 P} \rightarrow\left(u_{0}^{\prime}, u_{1}^{\prime} \pi^{\prime}\right) \otimes\left(v_{0}^{\prime}, v_{1}^{\prime} \delta^{\prime}\right)$ for some $u_{i}^{\prime}$, $v_{i}^{\prime}$ units in the local ring $\mathcal{O}_{P}$ at $P$ and the maximal ideal of $\mathcal{O}_{P}$ is given by $\left(\pi^{\prime}, \delta^{\prime}\right)$ such that $\phi_{P}\left(R_{0}\left(u_{0}, u_{1} \pi\right) \otimes R_{0}\left(v_{0}, v_{1} \delta\right)\right) \subset$ $\mathcal{O}_{P}\left(u_{0}^{\prime}, u_{1}^{\prime} \pi^{\prime}\right) \otimes \mathcal{O}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \delta^{\prime}\right)$. Further if $\sigma^{\prime}$ is the tensor product of canonical involutions on $\left(u_{0}^{\prime}, u_{1}^{\prime} \pi^{\prime}\right)$ and $\left(v_{0}^{\prime}, v_{1}^{\prime} \delta^{\prime}\right)$, then there exists $\phi_{P} \in \mathcal{O}_{P}\left(u_{0}^{\prime}, u_{1}^{\prime} \pi^{\prime}\right) \otimes \mathcal{O}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \delta^{\prime}\right)$ such that $\operatorname{int}\left(\theta_{P}\right) \sigma^{\prime}=\phi_{P} \sigma \phi_{P}^{-1}$ and the support of $\operatorname{Nrd}\left(\theta_{P}\right)$ at most ( $\left.\pi^{\prime}\right)$ and $\left(\delta^{\prime}\right)$.
Proof. Since $Q_{1}$ is the closed point given by the homogeneous ideal $\left(\pi_{0}, \delta_{0}, y\right)$, the maximal ideal of $\mathcal{O}_{Q_{1}}$ is given by $\left(t, \delta_{0}\right)$ with $\pi_{0}=t \delta_{0}$. Thus we have $D \otimes F_{0 P}=\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right)=$ $\left(u_{0}, u_{1} t \delta_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right) \simeq\left(u_{0}, u_{1} v_{1}^{-1} t\right) \otimes\left(u_{0} v_{0}, v_{1} \delta_{0}\right)$.

Let $i_{1}, j_{1} \in\left(u_{0}, u_{1} \pi_{0}\right), i_{2}, j_{2} \in\left(v_{0}, v_{1} \delta_{0}\right), i_{3}, j_{3} \in\left(u_{0}, u_{1} v_{1}^{-1} t\right)$ and $i_{4}, j_{4} \in\left(u_{0} v_{0}, v_{1} \delta_{0}\right)$ be the standard generators. Then we have an isomorphism $\phi_{P}:\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right) \rightarrow$ $\left(u_{0}, u_{1} v_{1}^{-1} t\right) \otimes\left(u_{0} v_{0}, v_{1} \delta_{0}\right)$ given by $\phi\left(i_{1} \otimes 1\right)=i_{3} \otimes 1, \phi\left(j_{1} \otimes 1\right)=j_{3} \otimes j_{4}, \phi\left(1 \otimes i_{2}\right)=$ $u_{0}^{-1}\left(i_{3} \otimes i_{4}\right)$ and $\phi\left(1 \otimes j_{2}\right)=1 \otimes j_{4}$. Since $u_{0}$ is a unit in $R_{0}, \phi\left(R_{0}\left(u_{0}, u_{1} \pi_{0}\right) \otimes R_{0}\left(v_{0}, v_{1} \delta_{0}\right)\right) \subset$ $\mathcal{O}_{Q_{i}}\left(u_{0}, u_{1} v_{1}^{-1} t\right) \otimes \mathcal{O}_{Q_{i}}\left(u_{0} v_{0}, v_{1} \delta_{0}\right)$. Let $\theta_{Q_{1}}=i_{3} \otimes j_{4}$. Then it is easy to see that $\theta_{Q_{1}}$ has the required properties. A similar computation gives the required $\theta_{Q_{2}}$.

Lemma 6.3. Suppose that $\lambda$ a unit in $R_{0}$ or a unit times $\pi_{0}$. Suppose $D=\left(u_{0}, u_{1} \pi_{0}\right) \otimes$ $\left(v_{0}, v_{1} \delta_{0}\right)$ is a division algebra for some units $u_{i}, v_{i} \in R_{0}$. Let $\sigma$ be the tensor product of canonical involutions on $\left(u_{0}, u_{1} \pi_{0}\right),\left(v_{0}, v_{1} \delta_{0}\right)$. Let $P \in \mathscr{X}_{0}$ be a closed point not equal to
$Q_{1}$ or $Q_{2}$. Then there exists an isomorphism $\phi_{P}: D \otimes F_{0 P} \simeq\left(u_{0}^{\prime}, u_{1}^{\prime}\right) \otimes\left(v_{0}^{\prime}, v_{1}^{\prime} \pi^{\prime}\right)$ for some $u_{0}^{\prime}, v_{0}^{\prime}, u_{1}^{\prime}, v_{1}^{\prime}$ units in $\mathcal{O}_{P}$ and $m_{P}=\left(\pi^{\prime}, \delta^{\prime}\right)$ such that $\phi_{P}\left(R_{0}(u, \pi) \otimes R_{0}(v, \delta)\right) \subset \mathcal{O}_{P}\left(u_{0}^{\prime}, u_{1}^{\prime}\right) \otimes$ $\mathcal{O}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \pi\right)$. Further if $\sigma^{\prime}$ is the tensor product of canonical involutions on $\left(u_{0}^{\prime}, u_{1}^{\prime}\right)$ and $\left(v_{0}^{\prime}, v_{1}^{\prime} \pi^{\prime}\right)$, then there exists $\theta_{P} \in \mathcal{O}_{P}\left(u_{0}^{\prime}, u_{1}^{\prime}\right) \otimes \mathcal{O}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \pi\right)$ such that int $\left(\theta_{P}\right) \sigma^{\prime}=\phi_{P} \sigma \phi_{P}^{-1}$ and the support of $\operatorname{Nrd}\left(\theta_{P}\right)$ at most $\left(\pi^{\prime}\right)$ and $\left(\delta^{\prime}\right)$.

Proof. Since $P$ is a closed point not equal to $Q_{1}$ or $Q_{2}$, the maximal ideal at $P$ is given by $\left(\pi_{0}, \delta^{\prime}\right)$ and $\delta_{0}=w^{\prime} \pi_{0}$ for some unit $w^{\prime}$ in $\mathcal{O}_{P}$. Thus we have $D \otimes F_{0 P}=\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right)=$ $\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} w^{\prime} \pi_{0}\right) \simeq\left(v_{0}, v_{1} w^{\prime} u_{1}^{-1}\right) \otimes\left(u_{0} v_{0}, u_{1} \pi_{0}\right)$.

Let $i_{1}, j_{1} \in\left(u_{0}, u_{1} \pi\right), i_{2}, j_{2} \in\left(v_{0}, v_{1} \delta_{0}\right), i_{3}, j_{3} \in\left(v_{0}, v_{1} w^{\prime} u_{1}^{-1}\right)$ and $i_{4}, j_{4} \in\left(u_{0} v_{0}, u_{1} \pi_{0}\right)$ be the standard generators. Then we have an isomorphism $\left.\phi_{P}:\left(u_{0}, u_{1} \pi\right)\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right) \rightarrow$ $\left(v_{0}, v_{1} w^{\prime} u_{1}^{-1}\right) \otimes\left(u_{0} v_{0}, u_{1} \pi_{0}\right)$ given by $\phi\left(i_{1} \otimes 1\right)=v_{0}^{-1}\left(i_{3} \otimes i_{4}\right), \phi\left(j_{1} \otimes 1\right)=1 \otimes j_{4}, \phi\left(1 \otimes i_{2}\right)=$ $\left(i_{3} \otimes 1\right)$ and $\phi\left(1 \otimes j_{2}\right)=j_{3} \otimes j_{4}$. Since $v_{0} \in R_{0}$ is a unit, we have $\phi_{P}\left(R_{0}\left(u_{0}, u_{1} \pi\right) \otimes R_{0}\left(v_{0}, v_{1} \delta\right)\right) \subset$ $\mathcal{O}_{P}\left(v_{0}, v_{1} w^{\prime} u_{1}^{-1}\right) \otimes \mathcal{O}_{P}\left(u_{0} v_{0}, u_{1} \pi\right)$. Let $\theta_{P}=i_{3} \otimes j_{4}$. Then $\theta_{P}$ has the required properties.

The following two results are extracted from $([25, \S 4])$.
Lemma 6.4. Let $F_{0}$ and $F$ be as above. Let $D \in \operatorname{Br}(F)$ be a quaternion division algebra over $F$ with a $F / F_{0}$-involution $\sigma$. Then there exists a sequence of blowups $\mathscr{X}_{0} \rightarrow S p e c R_{0}$ such that, the integral closure $\mathscr{X}$ of $\mathscr{X}_{0}$ in $F$ is regular and $r m_{\mathscr{X}}(D)$ is a union of regular curves with normal crossings. Further for every closed point $P$ of $\mathscr{X}_{0}$ with $D \otimes F_{0 P}$ division, $D \otimes F_{0 P}$ is as in (2.5 or 3.4) and not of the type (2.5(iii) or 3.4(iii)).

Proof. There exists a sequence of blowups $\mathscr{Y}_{0} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that the integral closure $\mathscr{Y}$ of $\mathscr{Y}_{0}$ is regular and $\operatorname{ram}_{\mathscr{Y}}(D)$ is a union of regular curves with normal crossings (cf. [18, Corollary 11.3]). Let $P$ be a closed point of $\mathscr{Y}_{0}$. Since the integral closure of $\mathscr{Y}_{0}$ in $F$ is regular, the maximal ideal at $P$ is generated by $\left(\pi_{P}, \delta_{P}\right)$ and $F=F_{0}\left(\sqrt{\lambda_{P}}\right)$ for some $\lambda_{P}=u$ or $u \pi_{P}$ for some unit $u$ at $P$.

Suppose that $D \otimes F_{0 P}$ is division. In particular $F \otimes F_{0 P}$ is a field. Let $R_{P}$ be the integral closure of $\mathcal{O}_{P}$ in $F$. Then $R_{P}$ is a regular two dimensional local ring with maximal ideal $\left(\pi_{P}^{\prime}, \delta_{P}^{\prime}\right)$ with $\delta_{P}^{\prime}=\delta_{P}, \pi_{P}^{\prime}=\pi_{P}$ if $\lambda_{P}$ is a unit in $\mathcal{O}_{P}$ and $\pi_{P}^{\prime}=\sqrt{\lambda_{P}}$ if $\lambda_{P}$ is not a unit in $\mathcal{O}_{P}$. Further $D$ is unramified on $\mathcal{O}_{P}$ except possibly at $\left(\pi_{P}^{\prime}\right)$ or $\left(\delta_{P}^{\prime}\right)$. In particular $D \otimes F_{0 P}$ is as in (2.5 or 3.4).

Suppose $D \otimes F_{0 P}$ as in (2.5(iii) or 3.4(iii)). Note that there are only finitely many such closed points.

Suppose $F \otimes F_{0 P} / F_{0 P}$ is ramified. Then, by (3.1), we can assume that $D \otimes F_{0 P}$ is not of type (3.5(iii)).

Suppose that $F \otimes F_{0 P} / F_{0 P}$ is unramified. Let $\mathscr{X}_{P} \rightarrow \operatorname{Spec}\left(\mathcal{O}_{P}\right)$ be the simple blow up. Then, it is easy to see that for every closed point $Q$ of $\mathscr{X}_{P}, D \otimes F_{0 Q}$ is not of type (3.5(iii) or 3.4(iii)) (cf. [25, Lemma 4.1]).

Proposition 6.5. Let $D$ be a central simple algebra over $F$ with a $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$. Let $X$ be a projective homogeneous variety under $G(D, \sigma, h)$ over $F_{0}$. Suppose that ind $(D) \leq 2$. If that $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$, then there exists a sequence of blowups $\mathscr{Y} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that for every closed point $P$ of $\mathscr{Y}, X\left(F_{0 P}\right) \neq \emptyset$.

Proof. By Morita equivalence ([13, Theorem 3.1, 3.11, 3.20] \& [12, Chapter 1, 9.3.5]), we assume that $D$ is division. If $D=F$, then $X\left(F_{0}\right) \neq \emptyset([25$, Corollary 3.12]) and hence any blowup of $\operatorname{Spec}(R)$ has the required property.

Suppose $\operatorname{ind}(D)=2$. Then $D \simeq D_{0} \otimes_{F_{0}} F$ for some quaternion division algebra over $F_{0}$. Without loss of generality we assume that $\sigma$ is the canonical involution. Then using (6.4), we get a sequence of blowups $\mathscr{Y}_{0}$ of $\operatorname{Spec}\left(R_{0}\right)$ such that for every closed point $P$ of $\mathscr{Y}$ with $D \otimes F_{0 P}$ division, $D \otimes F_{0 P}$ is as in (2.5 or 3.4) and not of the type (2.5(iii) or 3.4(iii)).

Suppose that $D \otimes F_{0 P}$ is not division. Suppose $F \otimes F_{0 P}$ is a field. Since ind $(D) \leq 2, D \otimes F_{0 P}$ is a matrix algebra and hence by Morita equivalence, $h$ corresponds to a quadratic form over $F$. Thus $X\left(F_{0 P}\right) \neq \emptyset\left(\left[5\right.\right.$, Theorem 3.1]). Suppose $F \otimes F_{0 P}$ is not a field. Then $F \otimes F_{0 P} \simeq$ $F_{0 P} \times F_{0 P}, D \otimes F_{0 P} \simeq D_{0} \otimes F_{0 P} \times D_{0}^{o p} \otimes F_{0 P}$ and $G(D, \sigma, h) \otimes F_{0 P} \simeq G L\left(M_{n}\left(D_{0} \otimes F_{0 P}\right)\right)$ ([13, p. 346]). Hence by (1.4), $X\left(F_{0 P}\right) \neq \emptyset$.

Suppose that $D \otimes F_{0 P}$ is division. Then $D \otimes F_{P}=\left(a_{p}, b_{P}\right)$ for some $a_{P}, b_{P}$ as in (6.1). In particular $\mathcal{O}_{P}\left(a_{P}, b_{P}\right) \otimes R$ is a maximal $\mathcal{O}_{P}$-order of $D \otimes F_{0 P}$. We have $h \otimes F_{0 P}=$ $\left\langle a_{1 P}, \cdots, a_{n P}\right\rangle$ for some $a_{i P} \in \hat{\mathcal{O}}_{P}(a, b) \otimes R$.

Let $Y_{0}$ be the special fibre of $\mathscr{Y}_{0}$. By (1.1), there exists a finite subset $\mathscr{P}$ of $Y_{0}$ such that $X\left(F_{P}\right) \neq \emptyset$ for all $P \notin \mathscr{P}_{0}$. Thus replacing $R$ by $\hat{\mathcal{O}}_{P}$, we assume that $D=(a, b)$ for some $a, b$ as in (6.1) and $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ for some $a_{i} \in R(a, b)$.

By ([25, Lemma 4.2]), there exists a sequence of blowups $\mathscr{Y}_{1} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that the support of $\operatorname{Nrd}\left(a_{i}\right)$ is a union of regular curves with normal crossings and for every closed point $Q$ of $\mathscr{Y}_{1}$ with $D \otimes F_{0 Q}$ is division, $D \otimes F_{0 Q}$ is not of the form ( [25, Lemma 3.6(5)]).

Let $Q$ be a closed point of $\mathscr{Y}_{1}$. If $D \otimes F_{0 Q}$ is a matrix algebra, then by ([10, Corollary 4.7]) and Morita equivalence, $X\left(F_{0 Q}\right) \neq \emptyset$. Suppose $D \otimes F_{0 Q}$ is a division algebra. Then, by (6.1), $R(a, b)$ is contained in the corresponding maximal order $\hat{\mathcal{O}}_{Q}\left(a_{Q}, b_{Q}\right)$. Since $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ with $a_{i} \in R(a, b)$ with support of $\operatorname{Nrd}\left(a_{i}\right)$ is a union of regular curves with normal crossings, by (5.4), $X\left(F_{0 Q}\right) \neq \emptyset$.

Lemma 6.6. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with a $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$. Suppose that ind $(D)=4$. Then there exists a sequence of blowups $\mathscr{X}_{0} \rightarrow$ Spec $R_{0}$ such that, the integral closure $\mathscr{X}$ of $\mathscr{X}_{0}$ in $F$ is regular and $\operatorname{ram}_{\mathscr{X}}(D)$ is a union of regular curves with normal crossings. Further for every closed point $P$ of $\mathscr{X}_{0}$ with $\operatorname{ind}\left(D \otimes F_{0 P}\right)=4, D \otimes F_{0 P}$ is as in (2.6 or 3.5) and not of the type (2.6(iii) or 3.5(iii)).

Proof. There exists a sequence of blowups $\mathscr{Y}_{0} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that the integral closure $\mathscr{Y}$ of $\mathscr{Y}_{0}$ is regular and $\operatorname{ram}_{\mathscr{Y}}(D)$ is a union of regular curves with normal crossings (cf. [18, Corollary 11.3]).

Let $P$ be a closed point of $\mathscr{Y}_{0}$. In particular if $\operatorname{ind}\left(D \otimes F_{0 P}\right)=4$, then $D \otimes F_{0 P}$ is as in (2.6 or 3.5). Suppose $D \otimes F_{0 P}=\left(u_{P}, v_{P}\right) \otimes\left(w_{P}, w_{P}^{\prime} \pi_{P} \delta_{P}\right)$ as in (2.6(iii) or 3.5(iii)) for some units $u_{P}, v_{P}, w_{P}, w_{P}^{\prime} \in \mathcal{O}_{P}$. Note that there are only finitely many such closed points.

Suppose $F \otimes F_{0 P} / F_{0 P}$ is ramified. Then, by (3.1), we can assume that $D \otimes F_{0 P}$ is not of type (3.5(iii)).

Suppose that $F \otimes F_{0 P} / F_{0 P}$ is unramified. Let $\mathscr{X}_{P} \rightarrow \operatorname{Spec}\left(\mathcal{O}_{P}\right)$ be the simple blow up. Then, it is easy to see that for every closed point $Q$ of $\mathscr{X}_{P}, D \otimes F_{0 Q}$ is not of type (2.6(iii) or $3.5(\mathrm{iii})$ ).

Proposition 6.7. Let $D \in{ }_{2} B r(F)$ be a central simple algebra over $F$ with a $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$. Let $X$ be a projective homogeneous variety under $G(D, \sigma, h)$ over $F_{0}$. Suppose that ind $(D) \leq 4$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$, then there exists a sequence of blowups $\mathscr{Y} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that for every closed point $P$ of $\mathscr{Y}, X\left(F_{0 P}\right) \neq \emptyset$.
Proof. By (6.5), we assume that $\operatorname{ind}(D)=4$. As in the proof of (6.5), we assume that $D$ is division as in (2.6 or 3.5 ) and not of the type (2.6(iii) or $3.5(\mathrm{iii})$ ). Let $\Gamma$ be the maximal $R$-order of $D$ as in (4.3) and write $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ with $a_{i} \in \Gamma$.

Let $\mathscr{Y}_{1} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ be a sequence of blowups such that the support of $\operatorname{Nrd}\left(a_{i}\right)$ is a union of regular curves with normal crossings. Further replacing $\mathscr{Y}$ by a sequence of blow ups (6.6), we assume that for every closed point $P$ of $\mathscr{Y}, D \otimes F_{0 P}$ is not of the form (2.6(iii) or $3.5($ iii $)$. Once again we have a finite set of closed points $\mathscr{P}_{1}$ of $\mathscr{Y}_{1}$ such that $X\left(F_{0 P}\right) \neq \emptyset$ for all $P \notin \mathscr{P}$.

Let $P \in \mathscr{P}_{1}$ be a closed point. Suppose that $F \otimes F_{0 P}$ is not a field. Then as in the proof of (6.5), $X\left(F_{0 P}\right) \neq \emptyset$.

Suppose that $F \otimes F_{0 P}$ is a field. If $\operatorname{ind}\left(D \otimes F_{0 P}\right) \leq 2$, then by (6.5), there exists a sequence of blowups $\mathscr{X}_{P}$ of $\operatorname{Spec}\left(\mathcal{O}_{P}\right)$ such that for every closed point $Q$ of $\mathscr{X}_{P}, X\left(F_{0 Q}\right) \neq \emptyset$.

Suppose ind $\left(D \otimes F_{P}\right)=4$.
Suppose that $D$ is not of type (2.6(iv) or 3.5(iv)). Then $D \simeq\left(u_{0}, w_{0}\right) \otimes(a, b)$ for some units $u, v, \in R_{0}$ and $a, b \in R_{0}$ as in (6.1). Then, by the choice, we have $\Gamma=R\left(u_{0}, v_{0}\right) \otimes R(a, b)$. By (6.1), $(a, b) \otimes F_{0 P} \simeq\left(a_{P}, b_{P}\right)$ for some $a_{P}, b_{P} \in \mathcal{O}_{P}$ as in (6.1) and $R_{0}(a, b) \subset \hat{\mathcal{O}}_{P}\left(a_{P}, b_{P}\right)$. In particular $\Gamma \subset \hat{\mathcal{O}}_{P}\left(u_{0}, v_{0}\right) \otimes \hat{\mathcal{O}}_{P}\left(a_{P}, b_{P}\right)$. Since $a_{i} \in \Gamma$ and $D \otimes F_{0 P}$ is not of type (2.6(iii)), by (5.4), $X\left(F_{0 P}\right) \neq \emptyset$.

Suppose that $D$ is of type (2.6(iv) or 3.5(iv)). Then $D \simeq\left(u_{0}, u_{1} \pi_{0}\right) \otimes\left(v_{0}, v_{1} \delta_{0}\right)$ for some units $u_{i}, v_{i} \in R_{0}$.

Suppose $P$ is a nodal point of $\mathscr{Y}_{1}$. Then, by (6.2), there exists an isomorphism $\phi_{P}: D \otimes$ $F_{0 P} \rightarrow\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right)$ and $\theta_{P} \in \hat{\mathcal{O}}_{P}\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes \hat{\mathcal{O}}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right)$ such that $\phi_{P}\left(R_{0}\left(u_{0}, u_{1} \pi_{0}\right) \otimes\right.$ $\left.R_{0}\left(v_{0}, v_{1} \pi_{0}\right)\right) \subset \hat{\mathcal{O}}_{P}\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes \hat{\mathcal{O}}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right)$ and $\operatorname{int}\left(\theta_{P}\right) \sigma=\phi_{P}^{-1} \sigma^{\prime} \phi_{P}$, where $\sigma^{\prime}$ is the product of the canonical involutions on the right hand side. Let $h^{\prime}$ be the hermitian form on $\left.\left(\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right)\right), \phi_{P} \sigma \phi_{P}^{-1}\right)$ which is the image of $h$ under $\phi_{P}$. Since $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$, we have $h_{1}=\left\langle\phi_{P}\left(a_{1}\right), \cdots, \phi_{P}\left(a_{n}\right)\right\rangle$. Let $h^{\prime}=\theta_{P} h_{1}$. Then $h^{\prime}$ is an hermitian form with respect $\sigma^{\prime}$. Let $X^{\prime}$ be the projective homogeneous variety under $G\left(\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right), \sigma^{\prime}, h^{\prime}\right)$ associated to $X$. Then $X\left(F_{0 P}\right) \neq \emptyset$ if and only if $X^{\prime}\left(F_{0 P}\right) \neq \emptyset$. Since $\phi_{P}\left(a_{i}\right), \theta_{P} \in$ $\hat{\mathcal{O}}_{P}\left(u_{0}^{\prime}, w_{1}^{\prime} \pi_{P}\right) \otimes \hat{\mathcal{O}}_{P}\left(v_{0}^{\prime}, v_{1}^{\prime} \delta_{P}\right)$, by $(5.4), X^{\prime}\left(F_{0 P}\right) \neq \emptyset$ and hence $X\left(F_{0 P}\right) \neq \emptyset$.

If $P$ is a non-nodal point, then using (6.3), we get $X\left(F_{0 P}\right) \neq \emptyset$ as above.
Proposition 6.8. Let $k, F_{0}$ and $F$ be as above. Suppose that for finite extension $\ell / k$, every element in ${ }_{2} \operatorname{Br}(\ell)$ has index at most 2. Let $D \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with a $F / F_{0}$-involution $\sigma$ and $h$ an hermitian form over $(D, \sigma)$. Let $X$ be a projective homogeneous variety under $G(D, \sigma, h)$ over $F_{0}$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$, then there exists a sequence of blowups $\mathscr{Y} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ such that for every closed point $P$ of $\mathscr{Y}, X\left(F_{0 P}\right) \neq \emptyset$.

Proof. By (6.7), we assume that $\operatorname{ind}(D)>4$. As in the proof of (6.5), we assume that $D$ is unramified on $R_{0}$ except possibly at $\left(\pi_{0}\right)$ and $\left(\delta_{0}\right)$. Then, by $(2.7,3.6), \operatorname{ind}(D)=8$ and $D \simeq\left(u_{0}, u_{1}\right) \otimes\left(v_{0}, v_{1} \pi_{0}\right) \otimes\left(w_{0}, w_{1} \delta_{0}\right) \otimes F$ for some units $u, v_{i}, w_{i} \in R_{0}$. Without loss
of generality we assume that $\sigma$ is the tensor product of canonical involutions on $\left(u_{0}, u_{1}\right)$, $\left(v_{0}, v_{1} \pi\right)$ and $\left(w_{0}, w_{1} \delta\right)$ and $\tau$. Let $\Gamma=R\left(u_{0}, u_{1}\right) \otimes R\left(v_{0}, v_{1} \pi\right) \otimes R\left(w_{0}, w_{1} \delta\right)$. Then $\Gamma$ is a maximal $R$-order of $D$. We have $h=\left\langle a_{1}, \cdots, a_{n}\right\rangle$ for some $a_{i} \in \Gamma$.

Let $\mathscr{X}_{0} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ be a sequence of blowups such that the integral closure of $\mathscr{Y}_{0}$ in $F$ is regular and the support of $\operatorname{Nrd}\left(a_{i}\right)$ and $\operatorname{ram}_{\mathscr{Y}}(D)$ is a union of regular curves with normal crossings. By (1.1), there exists a finite subset $\mathscr{P}$ of $Y_{0}$ such that $X\left(F_{0 P}\right) \neq \emptyset$ for all $P \notin \mathscr{P}_{0}$.

Let $P \in \mathscr{P}_{0}$. Suppose that $F \otimes F_{0 P}$ is not a field. Then as in the proof of (6.5), $X\left(F_{0 P}\right) \neq \emptyset$.
Suppose that $F \otimes F_{0 P}$ is a field. If $\operatorname{ind}\left(D \otimes F_{0 P}\right) \leq 4$, then by (6.7), there exists a sequence of blowups $\mathscr{X}_{P}$ of $\operatorname{Spec}\left(\mathcal{O}_{P}\right)$ such that for every closed point $Q$ of $\mathscr{X}_{P}, X\left(F_{0 Q}\right) \neq \emptyset$.

Suppose ind $\left(D \otimes F_{0 P}\right)>4$. Then as above we have ind $\left(D \otimes F_{0 P}\right)=8$. Arguing as in the proof of (6.7), we get that $X\left(F_{0 P}\right) \neq \emptyset$.

## 7. Main theorem

In this section we prove the main theorems.
Theorem 7.1. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that char $(k) \neq 2$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ of any kind, $F_{0}=F^{\sigma}$ and $h$ a hermitian form over $(A, \sigma)$. Suppose that $\operatorname{ind}(A) \leq 4$. Let $G=S U(A, \sigma, h)$ if $\sigma$ is first kind or $U(A, \sigma, h)$ if $\sigma$ is of second kind. Let $X$ be a projective homogeneous variety under $G$ over $F_{0}$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F$, then $X\left(F_{0}\right) \neq \emptyset$.

Proof. Since $F$ is the function field of a curve over $K, F_{0}$ is also the function field of a curve over $K$. Let $\mathscr{X}_{0} \rightarrow \operatorname{Spec}\left(R_{0}\right)$ be a regular proper model of $F_{0}$ with the closed fibre $X_{0}$ a union of regular curves with normal crossings ([1]). Let $\eta \in X_{0}$ be a generic point. Then $\eta$ gives a divisorial discrete valuation $\nu$ of $F$. Since $X\left(F_{0 \eta}\right) \neq \emptyset$, by ( $[9$, p. 5.8]), there exists a nonempty open set $U_{\eta}$ of the closure of $\eta$ in $X_{0}$ such that $X\left(F_{0 U_{\eta}}\right) \neq \emptyset$. By shrinking $U_{\eta}$, we assume that $U_{\eta}$ does not contain any singular points of $X_{0}$.

Let $\mathscr{P}=X_{0} \backslash \cup_{\eta} U_{\eta}$. Then $\mathscr{P}$ is a finite set of closed points of $X_{0}$ containing all the singular points of $X_{0}$. Let $P$ be a closed point of $X_{0}$. Suppose $P \notin \mathscr{P}$. Then $P \in U_{\eta}$ for some $\eta$. Since $F_{0 U_{\eta}} \subset F_{0 P}, X\left(F_{0 P}\right) \neq \emptyset$.

Let $P \in \mathscr{P}$. Since $\operatorname{ind}(A) \leq 4$ and $A \in{ }_{2} \operatorname{Br}(F)$, by (6.7), there exists a sequence of blowups $\mathscr{X}_{P}$ of $\operatorname{Spec}\left(\mathcal{O}_{P}\right)$ such that $X\left(F_{0 Q}\right) \neq \emptyset$ for all closed points of $\mathscr{X}_{P}$. Thus replacing $\mathscr{X}$ by these finitely many sequences of blowups at all $P \in \mathscr{P}$, we assume that $X\left(F_{0 Q}\right) \neq \emptyset$ for all closed points $Q$ of $X_{0}$. Since for any generic point $\eta$ of $X_{0}, X\left(F_{0 \eta}\right) \neq \emptyset$, we have $X\left(F_{0 x}\right) \neq \emptyset$ for all points $x \in X_{0}$. Since $G$ is a connected rational group ([4, Lemma 5]), by ( $[8$, Theorem 3.7]), we have $X(F) \neq \emptyset$.

Theorem 7.2. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that char $(k) \neq 2$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A$ be a central simple algebra over $F$ with an $\sigma$ of any kind, $F_{0}=F^{\sigma}$ and $h$ a hermitian form over $(A, \sigma)$. Suppose that for every finite extension $\ell / k$, every element in ${ }_{2} B r(\ell)$ has index at most 2. Let $G=S U(A, \sigma, h)$ if $\sigma$ is first kind or $U(A, \sigma, h)$ if $\sigma$ is of second kind. Let $X$ be a projective homogeneous variety under $G$ over $F_{0}$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$, then $X\left(F_{0}\right) \neq \emptyset$.
Proof. Using (6.8), the proof is similar to the proof of (7.1).

Corollary 7.3. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that $k$ is a global field, local field or a $C_{2}$-field with $\operatorname{char}(k) \neq 2$. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ of any kind and $h$ a hermitian form over $(A, \sigma)$. Let $F_{0}=F^{\sigma}, G=S U(A, \sigma, h)$ if $\sigma$ is first kind and $G=U(A, \sigma, h)$ if $\sigma$ is of second kind. Let $X$ be a projective homogeneous variety under $G$ over $F_{0}$. If $X\left(F_{0 \nu}\right) \neq \emptyset$ for all divisorial discrete valuations $\nu$ of $F_{0}$, then $X\left(F_{0}\right) \neq \emptyset$.

Proof. Suppose $k$ is a global field or a local field or a $C_{2}$-field, then any finite extension $\ell$ of $k$ is also same type and hence every element in ${ }_{2} \operatorname{Br}(k)$ is of index at most 2 ([24, Chapter 10, 2.3(vi)], [24, Chapter 10, 2.2(i)], [14, Theorem 4.8]). Hence the corollary follows from (7.2).

Corollary 7.4. Let $K$ be a complete discretely valued field with valuation ring $T$ and residue field $k$. Suppose that $k$ is a local field with the characteristic of the residue field not equal 2. Let $F$ be the function field of a smooth projective geometrically integral curve over $K$. Let $A \in{ }_{2} \operatorname{Br}(F)$ be a central simple algebra over $F$ with an involution $\sigma$ and $h$ a hermitian form over $(A, \sigma)$ and $F=F^{\sigma}$. If $h \otimes L$ is isotropic for some odd degree extension $L / F_{0}$, then $h$ is isotropic.

Proof. Let $\nu$ be a divisorial discrete valuation of $F_{0}$. Then the residue field $\kappa(\nu)$ is either a finite extension of $K$ or a function field of a curve over a finite extension of $k$ ([17, Theorem 8.1]).

Let $\kappa^{\prime}$ be an extension of $\kappa(\nu)$ with $\left[\kappa^{\prime}: \kappa(\nu)\right] \leq 2$. Let $D$ be a central simple algebra over $\kappa^{\prime}$ with a $\kappa^{\prime} / \kappa\left(\nu^{\prime}\right)$-involution $\theta$ and $f$ an hermitian form over $(D, \theta)$. Let $\ell$ be an extension of $\kappa(\nu)$ of odd degree. Suppose that $f$ is isotropic over $\ell$.

Suppose $\kappa(\nu)$ is a finite extension of $K$. Since $K$ is a complete discretely valued field with residue field $k, \kappa(\nu)$ is a compete discretely valued field with residue field a finite extension of $k$. Then by ([25, Lemma 5.6] and [25, Lemma 5.1]), we get that $f$ is isotropic.

Suppose the residue field $\kappa(\nu)$ is a function field of a curve over a finite extension of $k$. Since $k$ is local field, by ([25, Lemma 5.1]) and ([25, Theorem 4.4]), $f$ is isotropic.

Suppose that $h \otimes L$ is isotropic for some odd degree extension $L$ of $F_{0}$. Then, as in the proof of ([25, Theorem 5.8]) and using (7.3), we get that $h$ is isotropic.
