# ON TOPOLOGICAL COMPLEXITY OF GORENSTEIN SPACES

#### Abstract

In this paper, using Sullivan's approach to rational homotopy theory of simply-connected finite type CW complexes, we endow the $\mathbb{Q}$-vector space $\mathcal{E} x t_{C^{*}(X ; \mathbb{Q})}\left(\mathbb{Q}, C^{*}(X ; \mathbb{Q})\right)$ with a graded commutative algebra structure. This leads us to introduce the $\mathcal{E} x t$-version of higher (resp. module, homology) topological complexity of $X_{0}$, the rationalization of $X$ (resp. of $X$ over $\mathbb{Q}$ ). We then make comparisons between these invariants and their respective ordinary ones for Gorenstein spaces. We also highlight, in this context, the benefit of Adams-Hilton models over a field of odd characteristics especially through two cases, the first one when the space is a 2 -cell CW-complex and the second one when it is a suspension.


## 1 Introduction

Throughout this work we assume that $X$ is a 1 -connected CW-complex of finite type and $\mathbb{K}$ a field of arbitrary characteristic. In his famous paper, M. Farber introduced the concept of topological complexity of a space $X, T C(X)$, which is indeed seen as the sectional category, secat $\left(\Delta_{X}\right)$, of the diagonal map $\Delta_{X}: X \rightarrow X \times X$. Recall that if $f: X \rightarrow Y$ is a continuous map, $\operatorname{secat}(f)$ is the smallest integer $m$ for which there are $m+1$ local homotopy sections $s_{i}: U_{i} \rightarrow Y$ for $f$ whose sources form an open covering of $X . T C(X)$ is actually used to assess the complexity of motion planning algorithms of a mechanical system along its configuration space $X$. Later, Y. Rudyak in [22] generalizes Farber's concept and introduces that of higher topological complexity, $T C_{n}(X)(n \geq 2)$, which turns out to be the sectional category $\operatorname{secat}\left(\Delta_{X}^{n}\right)$ of the $n$-diagonal $\Delta_{X}^{n}: X \rightarrow X^{n}$. Determining $T C_{n}(X)$ is as difficult as it is exactly for the Lusternik-Scnirelmann category $\operatorname{cat}_{L S}(X)=\operatorname{secta}(* \hookrightarrow X)$ introduced in [LS]. Spectacular advances using rational homotopy theory methods have however made it possible to establish better approximation of this latter, namely $\operatorname{cat}_{L S}\left(X_{0}\right) \leq \operatorname{cat}_{L S}(X)$ with $X_{0}$ denoting the rationalization $X_{0}$ of $X$. In that sense, J. Carrasquel used in [5] the characterization à la Félix-Halperin to give an explicit definition of the higher topological complexity $T C_{n}\left(X_{0}\right)$ which in turn lowers $T C_{n}(X)$ (cf. Definition 4.1 below). This is achieved thanks to the Sullivan model (called also Sullivan algebra) ( $\Lambda V, d$ ) associated to $X$ (cf. §2 for more details). He also introduced higher (rational) homology (resp. module) topological complexity $H T C_{n}(X)$, (resp. $M T C_{n}(X)$ ) and showed that they interpolate $z c l_{n}(X):=\operatorname{nilker} H^{*}\left(\Delta_{X}^{n}\right)$ and $T C_{n}\left(X_{0}\right)$.

In this paper we are interested in the study of the invariant $H T C_{n}(X)$ when $X$ satisfies the Gorenstein property which we introduce right after. Recall first that to every local commutative ring $R$ with residue field $\mathbb{K}$ it is associated the invariant $E x t_{R}(\mathbb{K}, R)$ and it is said a Gorenstein ring if $\operatorname{dim} E x t_{R}(\mathbb{K}, R)=1$.

Motivated by the deep study of this invariant in the context of local algebra, the authors of [13] introduced the notion of a Gorenstein space and thereby obtain new characterizations of Poincaré duality complexes. Recall from [23] that a finite $n$-dimensional subcomplex $X$ of $\mathbb{R}^{n+k}$ is a Poincaré complex if and only if its Spivak fiber $F_{X}$ (see $\S 4$ ) is an homotopy sphere. They give, in the particular case where $X$ has finite Lusternik-Schnirelmann category $\operatorname{cat}_{L S}(X)$ and $\mathbb{K}=\mathbb{Z}_{p}$ ( $p$ prime or zero), a local analogue of the Spivak characterization in terms of the Eilenberg-Moore Ext functor denoted here by $\mathcal{E x t}$ [13, Theorem 3.1]:

& \Leftrightarrow \operatorname{dim} \mathcal{E} x t_{C^{*}\left(X ; \mathbb{Z}_{p}\right)}\left(\mathbb{Z}_{p}, C^{*}\left(X ; \mathbb{Z}_{p}\right)\right)=1 \tag{1}

[^0](cf. $\S 2$ for the definition of Poincaré duality algebras and the functor $\mathcal{E x t})$. Recall that, $C^{*}\left(X ; \mathbb{Z}_{p}\right)$ is endowed with the left module structure over itself. The equivalences in (1) make sense to the following definition [13].

Definition 1.1. $X$ is a Gorenstein space over $\mathbb{K}$ if $\operatorname{dim} \mathcal{E} x t_{C^{*}(X ; \mathbb{K})}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right)=1$.
For instance, if $X$ is finite dimensional then [13, Proposition 4.5, Theorem 3.1]:

X \text { is Gorenstein over } \mathbb{K} & \Leftrightarrow H^{*}(X, \mathbb{K}) \text { is a Gorenstein algebra } \\
& \Leftrightarrow H^{*}(X, \mathbb{K}) \text { is a Poincaré duality algebra. }
\end{aligned}
$$

E.g. every closed manifold is Gorenstein over any field $\mathbb{K}$. In the rational case, if $\operatorname{dim} \pi_{*}(X) \otimes \mathbb{Q}$ is finite dimensional then $X$ is Gorenstein over $\mathbb{Q}$ [13, Proposition 3.4]. E.g. every rationally elliptic space $X$ (i.e. both if its rational homology and rational homotopy are finite dimensional) is Gorenstein over $\mathbb{Q}$.

The authors of [13] also introduced a morphism of $\mathbb{K}$-graded vector spaces:

e v_{C^{*}(X, \mathbb{K})}: \mathcal{E x t}_{C^{*}(X, \mathbb{K})}\left(\mathbb{K}, C^{*}(X, \mathbb{K}) \rightarrow H^{*}(X, \mathbb{K})\right.
$$

(cf. §2) called the evaluation map of $X$ over $\mathbb{K}$. This is a homotopy invariant which allows to better (algebraically) characterize Poincaré duality spaces [15, Corollary 2]:

(i) X \text { is a Gorenstein space } \\
(i i) e v_{C^{*}}(X, \mathbb{K}) \neq 0 \\
(i i i) H^{*}(X, \mathbb{Q}) \text { is a Gorenstein algebra }
\end{array}\right.
$$

Also, using the evaluation map we know, for instance, that every space $Y=X \cup e^{n}$ with $e^{n}$ representing a non-zero class in $H_{n}(X, \mathbb{Q})$ is Gorenstein over $\mathbb{Q}$ [13, Corollary 2.3 and Proposition 3.4].

In fact, fewer space types for which the invariants $H T C_{n}(X), m T C_{n}(X)$ and $T C_{n}\left(X_{0}\right)$ are determined. However, in [17] a new invariant $L\left(X_{0}\right)$ is introduced and it is shown that $\operatorname{cat}_{L S}\left(X_{0}\right)+L\left(X_{0}\right) \leq$ $T C_{n}\left(X_{0}\right)$ for any pure elliptic coformal space. It is also established that $T C_{n}\left(X_{0}\right)=\operatorname{dim} \pi_{*}(X) \otimes \mathbb{Q}$ for certain particular families of such spaces.

In this work, inspired by Carrasquel's characterizations we will introduce Ext-versions of the aforementioned topological complexities. We start by endowing the graded $\mathbb{Q}$-vector space

(cf. §2 for more details) with a homotopy multiplicative structure denoted in all that follows

\mu_{\mathrm{A}}: \mathrm{A} \otimes \mathrm{~A} \rightarrow \mathrm{~A} . \tag{2}
\end{equation*}

The cohomology of A is neither than $\mathcal{A}={\mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d)) \text { and our first main result reads: }}_{\text {( }}$
Theorem 1.1. The graded vector space $\mathcal{A}$ endowed with the product $\mu_{\mathcal{A}}:=H^{*}\left(\mu_{\mathrm{A}}\right)$ is a graded commutative algebra with unit. Moreover, the evaluation map

e v_{(\Lambda V, d)}: \mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d)) \rightarrow H(\Lambda V, d)
$$

is a morphism of graded algebras.
As a consequence, using [13, Remark 1.3] we have the following:
Corollary 1. The graded vector space $\mathcal{E} x t_{C^{*}(X, \mathbb{Q})}\left(\mathbb{Q}, C^{*}(X, \mathbb{Q})\right)$ is a graded commutative algebra and the evaluation map

$$
\operatorname{ev}_{C^{*}(X, \mathbb{Q})}: \mathcal{E} x t_{C^{*}(X, \mathbb{Q})}\left(\mathbb{Q}, C^{*}(X, \mathbb{Q})\right) \rightarrow H^{*}(X, \mathbb{Q})
$$

is a morphism of graded algebras.
Next, recall from [6] that a morphism of graded commutative differential algebra (cdga for short) $\varpi:(C, d) \rightarrow(D, d)$ admits a homotopy retraction if there exists a map $r:(\Lambda V \otimes C, d)) \rightarrow(C, d)$ such that $r \circ \iota=I d_{C}$, where $\iota:(C, d) \rightarrow(\Lambda V \otimes C, d)$ stands for the relative model of $\varpi$. As a particular
case, consider any Sullivan algebra $(\Lambda V, d)$ and denote by $\mu_{\mathrm{A}, n}: \mathrm{A}^{\otimes n} \rightarrow \mathrm{~A}$ the $n$-fold product of $\mu_{\mathrm{A}}: \mathrm{A} \otimes \mathrm{A} \rightarrow \mathrm{A}$. Using [5, Definition 9], we state in terms of the cdga projection:

the following
Definition 1.2. (a): sc( $\mu_{\mathrm{A}, n}$ ) is the least $m$ such that $\Gamma_{m}$ admits a homotopy retractioe
(b): $m s c\left(\mu_{\mathrm{A}, n}\right)$ is the least $m$ such that $\Gamma_{m}$ admits a homotopy retraction as $\left(\mathrm{A}^{\otimes n}, d\right)$-modules.
(c): $H s c\left(\mu_{\mathrm{A}, n}\right)$ is the least $m$ such that $H\left(\Gamma_{m}\right)$ is injective.
(d): nil $\operatorname{ker}\left(\mu_{\mathcal{A}, n}, \mathbb{Q}\right)$ is the longest non trivial product of elements of $\operatorname{ker}\left(\mu_{\mathcal{A}, n}\right)$.

If $(\Lambda V, d)$ is a Sullivan model of $X$, these are denoted respectively $\operatorname{TC}_{n}^{\mathcal{E} x t}(X, \mathbb{Q}), \operatorname{mTC}_{n}^{\mathcal{E} x t}(X, \mathbb{Q})$ $\operatorname{HTC}_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$ and $z c l_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$. We call theme the rational (resp. module, homology, zero cup length) Ext-version topological complexity.

Our second main result reads as follows
Theorem 1.2. Let $X$ be a 1 -connected finite type $C W$-complex. If $X$ is a Gorenstein space over $\mathbb{Q}$ and $e v_{C^{*}(X, \mathbb{Q})} \neq 0$, then $H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q}) \leq H T C_{n}(X, \mathbb{Q})$ for any integer $n \geq 2$. Furthermore, if $(\Lambda V, d)$ is a Sullivan minimal model of $X,[f]$ is the generating class of $\mathcal{A}$ and $m=H T C_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$, then:

H T C_{n}(X, \mathbb{Q})=H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q})=: m \Leftrightarrow f(1)^{\otimes n} \in\left(\operatorname{ker} \mu_{n}\right)^{m} \backslash\left(\operatorname{ker} \mu_{n}\right)^{m+1}
$$

Notice, referring to [15] that hypothesis on $X$ imply that it is either a Poincaré duality space on $\mathbb{Q}$ or else $H^{*}(X, \mathbb{Q})$ is not noetherian and not a Gorenstein graded algebra. It also should be pointed out here that, when $X$ satisfies Poincaré duality property then $\operatorname{HTC}_{n}(X, \mathbb{Q})=m T C_{n}(X, \mathbb{Q})$ [6, Corollary 4.8]. As Particular cases, we have:

Corollary 2. Hypothesis of Theorem [1.2 and hence its conclusions are satisfied in the following cases:
(a) $X$ is rationally elliptic,
(b) $H_{>N}(X, \mathbb{Z})=0$, for some $N$, and $H^{*}(X, \mathbb{Q})$ is a Poincaré duality algebra,
(c) $X$ is a finite 1-connected CW-complex and its Spivak fiber $F_{X}$ has finite dimensional cohomology.

Next, let $R$ be a principal ideal domain containing $\frac{1}{2}$. Denote by $\rho(R)$ the least non invertible prime ( or $\infty$ ) in $R$ and by $C W_{r}(R)$ the sub-category of finite $r$-connected CW-complexes $X(r \geq 1)$ satisfying $\operatorname{dim}(X) \leq r \rho(R)$.

In [16] (see also [2]), in his attempt to extend Sullivan's theory to arbitrary rings, S. Halperin associated to every $X \in C W_{r}(R)$ an appropriate differential graded Lie algebra $(L, \partial)$ and showed that its Cartan-Eilenberg-Chevally complex $C^{*}(L, \partial)$ is, on one hand, linked with the cochains algebra $C^{*}(X, R)$ by a series of quasi-isomorphisms ([16, p. 274]) and, on the other hand, it is quasi-isomorphic to a free commutative differential graded algebra $(\Lambda W, d)$ [16, §7]. $(\Lambda W, d)$ is then called a free commutative model of $X$ or a Sullivan minimal model of $X$.

In Section 5 we will extend a part of Theorem 1.1 and its corollary to the sub-category $C W_{r}(R)$ when $R=\mathbb{K}$ is a field of odd characteristic and make use of Adams-Hilton models introduced in [1] to obtain an explicit calculation of the homotopy invariant $\mathcal{A}=\mathcal{E} x t_{C^{*}(X, \mathbb{K})}\left(\mathbb{K}, C^{*}(X, \mathbb{K})\right)$ when $X$ is a suspension or a two-cell CW-complex.

The rest of the paper is organized as follows: In Section 2 we recall notions used to state and to establish our results while in Section 3 we introduce the multiplicative structure $\mu_{\mathcal{A}}$ and the proof of Theorem 1.1. Section 4 is devoted to the proof of Theorem 1.2

## 2 PRELIMINARIES

To make this work constructive enough, we summarize in this section most of the results established on Gorenstein algebras and Gorenstein spaces. $\mathbb{K}$ will denote an arbitrary ground field unless otherwise stated.
2.1 Eilenberg-Moore Ext: A graded module is a family $A=\left(A^{i}\right)_{i \in \mathbb{Z}}$ of $\mathbb{K}$-modules denoted also $A=\oplus_{i \in \mathbb{Z}} A^{i}$. Every $a \in A^{i}$ is of degree $i$ denoted thereafter $|a|$.

A linear map of graded modules $f: A \rightarrow B$ of degree $|f|$ is a $\mathbb{K}$-linear map sending each $A^{i}$ to $B^{i+|f|}$. In $|f|=0$ we call it a morphism of graded modules.

In all that follows, unless otherwise stated, modules are over $\mathbb{K}$ and we will assume that $A^{i}=0$ if $i<0$.

A grade algebra $A$ is a graded module together with an associative multiplication $\mu_{A}: A \otimes A \rightarrow A$ that has un identity element $1_{A}=: 1 \in A^{0}$. We will put $\mu_{A}(x \otimes y)=: x y$. Notice that $\left|\mu_{A}\right|=0$. Moreover, if we have $a b=(-1)^{|a||b|} b a$ for all $a, b \in A$, then $A$ is said to be commutative.

A differential graded algebra $(A, d)$ (dga for short) is a graded algebra $A$ together with a linear map $d: A \rightarrow A$ of degree $|d|=+1$ that is a derivation : $d(a b)=d(a) b+(-1)^{|a|} a d(b)$, and satisfying $d \circ d=0$.

A morphism of dga $f:(A, d) \rightarrow(B, d)$ is a linear map of degree zero satisfying $f\left(a a^{\prime}\right)=f(a) f\left(a^{\prime}\right)$, and the compatibility with the differential $d: f(d a)=d(f(a))$.

A dga algebra $A$ is said to be augmented if it is endowed with a morphism $\varepsilon: A \rightarrow \mathbb{K}$ of graded algebras.

A (left) graded $(A, d)$ module is a graded module $M$ equipped with a linear map $A \otimes M \rightarrow M$, $a \otimes m \mapsto a m$ of degree zero such that $a(b m)=(a b) m$ and $1 m=m$, and a differential $d$ satisfying $d(a m)=(d a) m+(-1)^{|a|} a(d m), \quad m \in M, a \in A$.

A morphism of (left) graded modules over a dga $(A, d)$ is a morphism $f:(M, d) \rightarrow(N, d)$ compatible with the differential: $d \circ f=f \circ d$.

A left $(A, d)$-module $(M, d)$ is said semi-free if it is the union of an increasing sequence $M(0) \subset$ $M(1) \subset M(2) \cdots \subset M(n) \subset \cdots$ of sub $(A, d)$-modules such that $M(0)$ and each $M(i) / M(i-1)$ is $A$-free on a basis of cycles. Such an increasing sequence is called a semi-free filtration of $(M, d)$.

A semi-free resolution of an $(A, d)$-module $(M, d)$ is an $(A, d)$-semi-free module $(P, d)$ together with a quasi-isomorphism (i.e. a morphism inducing an isomorphism in homology) $m:(P, d) \xrightarrow{\simeq}(M, d)$ of $(A, d)$-modules. Each of $M(0)$ and $M(i) / M(i-1)$ has the form $(A, d) \otimes(V(i), 0)$ where $V(i)$ is a free $\mathbb{K}$-module. Thus the surjections $M(n) \rightarrow A \otimes V(n)$ and the differential $d$ satisfy :

M(n)=M(n-1) \oplus(A \otimes V(n)), \quad \text { and } \quad d: V(n) \rightarrow M(n-1) .
$$

By [14, Prop. 6.6], every $(A, d)$-module $(M, d)$ has a semi-free resolution $m:(P, d) \xrightarrow{\simeq}(M, d)$ and if $m:\left(P^{\prime}, d\right) \xrightarrow{\simeq}(M, d)$ is a second semi-free resolution, then, there is an equivalence

$$
\alpha:\left(P^{\prime}, d\right) \longrightarrow(P, d)
$$

of $(A, d)$-modules such that $m \circ \alpha$ and $m^{\prime}$ are homotopic morphisms; we denote for short $m \circ \alpha \simeq_{A} m^{\prime}$.
Particularly, let $(A, d)$ be a differential graded algebra and $(P, d) \xrightarrow{\simeq}(\mathbb{Q}, 0)$ an $(A, d)$-semi-free resolution of $(\mathbb{Q}, 0)$. This defines the graded $(A, d)$-module

\operatorname{Hom}_{A}((P, d),(A, d))=\bigoplus_{p \geq 0} \operatorname{Hom}_{A}^{p, *}((P, d),(A, d))=\bigoplus_{p \geq 0} \bigoplus_{i \geq 0} \operatorname{Hom}_{A}\left(P^{i}, A^{i+p}\right),
$$

which, endowed with the differential

$$
D(f)=d \circ f-(-1)^{p} f \circ d ; \quad f \in \operatorname{Hom}_{A}^{p, *}((P, d),(A, d))
$$

yields the Eilenberg-Moore Ext functor:

$$
\mathcal{E} x t_{(A, d)}(\mathbb{K},(A, d))=H^{*}\left(\operatorname{Hom}_{A}((P, d),(A, d)), D\right) .
$$

This is an invariant up to homotopy of differential graded algebras (see [13, Appendix] or [8, Appendix]). More usefully [13, Remark 1.3] if $(A, d) \xrightarrow{\simeq}(B, d)$ is a quasi-isomorphism of differential graded algebras, then $\mathcal{E} x t_{(A, d)}(\mathbb{K},(A, d))$ is identified with $\mathcal{E} x t_{(B, d)}(\mathbb{K},(B, d))$ via natural (induced) isomorphisms

$$

\mathcal{E} x t_{(A, d)}(\mathbb{K},(A, d)) \xrightarrow{\cong} \mathcal{E} x t_{(A, d)}(\mathbb{K},(B, d)) \stackrel{\cong}{\cong} \mathcal{E} x t_{(B, d)}(\mathbb{K},(B, d)) . \tag{3}
\end{equation*}

Particularly, $\mathcal{E} x t_{C^{*}(X ; \mathbb{K})}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right)$ and $\mathcal{E} x t_{C_{*}(\Omega X ; \mathbb{K})}\left(\mathbb{K}, C_{*}(\Omega X ; \mathbb{K})\right)$ depend only on the homotopy class of $X$.

The highest $N$ such that $\left[\mathcal{E} x t_{C^{*}(X ; \mathbb{K})}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right)\right]^{N} \neq 0$ is called the formal dimension of $X$. It is denoted $f d(X, \mathbb{K})$.
2.2 Evaluation map and Gorenstein spaces. Let $\rho:(P, d) \xrightarrow{\simeq}(\mathbb{K}, 0)$ be a minimal $(A, d)$-semi-free resolution of $(\mathbb{K}, 0)$. Consider the chain map

$$
\operatorname{cev}_{(A, d)}: \operatorname{Hom}_{(A, d)}((P, d),(A, d)) \longrightarrow(A, d)
$$

given by $f \mapsto f(z)$, where $z \in P$ is a cocycle representing 1 in $\mathbb{K}$. We call it the chain evaluation map of $(A, d)$. Passing to homology, we obtain the natural map

$$
\operatorname{ev}_{(A, d)}: \mathcal{E} x t_{(A, d)}(\mathbb{K},(A, d)) \longrightarrow H^{*}(A, d),
$$

called the evaluation map of $(A, d)$. The definition of $e v_{(A, d)}$ is independent of the choice of $(P, d)$ and $z$. The evaluation map of $X$ over $\mathbb{K}$ is by definition the evaluation map of $C^{*}(X, \mathbb{K})$.

A Poincaré duality algebra over $\mathbb{K}$ is a graded algebra $H=\left\{H^{k}\right\}_{0 \leq k \leq N}$ such that $H^{N}=\mathbb{K} \alpha$ and the pairing $<\beta, \gamma>\alpha=\beta \gamma, \beta \in H^{k}, \gamma \in H^{N-k}$ defines an isomorphism $H^{k} \xlongequal[\leftrightarrows]{\cong} \operatorname{Hom}_{\mathbb{K}}\left(H^{N-k}, \mathbb{K}\right)$, $0 \leq k \leq N$. In particular, $H=H o m_{\mathbb{K}}\left(\operatorname{Hom}_{\mathbb{K}}(H, \mathbb{K}), \mathbb{K}\right)$ is necessarily finite dimensional.

A Poincaré space at $\mathbb{K}$ is a space whose cohomology with coefficients in $\mathbb{K}$ is a Poincaré duality algebra. In this case, the cohomology class $\alpha$ such that $H^{N}(X, \mathbb{K})=\mathbb{K} \alpha$ has degree $N=f d(X, \mathbb{K})$ [13, Proposition 5.1]. It is called the fundamental class $X$.

A Gorenstein algebra over $\mathbb{K}$ is a differential graded algebra $(A, d)$ whose associated graded vector space $\mathcal{E x t}{ }_{(A, d)}(\mathbb{K},(A, d))$ is one dimensional.

A space $X$ is Gorenstein over $\mathbb{K}$ if the cochain algebra $C^{*}(X ; \mathbb{K})$ is a Gorenstein algebra.
For instance, let $X$ be a simply connected CW complex. If in addition $X$ it finite dimensional then: $C^{*}(X ; \mathbb{K})$ is Gorenstein if and only if $H^{*}(X ; \mathbb{K})$ is a Poincaé duality algebra [13, Theorem 3.1]. But, if $X$ is not finite dimensional, it is Gorenstein provided that $\operatorname{dim} \pi_{*}(X) \otimes \mathbb{Q}<\infty$ [13, Proposition 3.4]. In this case, $\operatorname{dim} H^{*}(X, \mathbb{Q})<\infty$ if and only if $e v_{C^{*}(X ; \mathbb{Q})} \neq 0$ [19].

Along this section, the ground field is $\mathbb{Q}$. Recall from [14] that to every finite-type simply-connected space $X$ it is associated a quasi-isomorphism $(\Lambda V, d) \stackrel{\simeq}{\rightrightarrows} A_{P L}(X)$ from a free commutative differential graded algebra (cdga for short) $(\Lambda V, d)$ to the commutative graded algebra $A_{P L}(X)$ of polynomial forms with rational coefficients. This latter is connected to $C^{*}(X, \mathbb{Q})$ by a sequence of quasi-isomorphisms. More explicitly, $\Lambda V=T V / I$ where $I$ is the graded ideal spanned by $\left\{v \otimes w-(-1)^{\operatorname{deg}(u) \operatorname{deg}(v)} w \otimes\right.$ $v, v, w \in V\}, V=\oplus_{n \geq 2} V^{n}$ is a finite-type graded vector space and the differential $d$ is a derivation defined on $V$ satisfying $d \circ d=0$. ( $\Lambda V, d)$ is called a Sullivan model of $X$. This model is said minimal if moreover $d$ is decomposable, i.e. $d: V \rightarrow \Lambda^{\geq 2} V$ where $\Lambda^{\geq 2} V$ denotes the graded vector space spanned by all the monomials $v_{1} \ldots v_{r}(r \geq 2)$. Notice that such a model is unique up to isomorphisms [14].

Let ( $X, x_{0}$ ) be a based simply-connected finite type CW-complex and denote by

$$
m:(\Lambda V, d) \xrightarrow{\simeq} A_{P L}(X)
$$

its minimal Sullivan model. In fact, the multiplicative structure of $(\Lambda V, d), \mu_{\Lambda V}: \Lambda V \otimes_{\mathbb{Q}} \Lambda V \rightarrow \Lambda V$ is compatible with the one induced on $C^{*}(X, \mathbb{Q})$ by the diagonal map $\Delta_{X}: X \rightarrow X \times X$ and the same holds for the augmentation $\varepsilon_{\Lambda V}:(\Lambda V, d) \rightarrow(\mathbb{Q}, 0)$ and the inclusion $\iota:\left\{x_{0}\right\} \hookrightarrow X$.

Referring for instance to [10] a $(\Lambda V, d)$-semi-free resolution of $(\mathbb{Q}, 0)$ has the form $(P, d)=(\Lambda V \otimes$ $\Lambda s V, d) \xrightarrow{\simeq}(\mathbb{Q}, 0)$ where $s V$ is the suspension of $V$ defined by $(s V)^{k}=V^{k+1}$ and $d(s v)=-s(d v)$ for all $v \in V$.

We are mow ready to define on $\mathrm{A}=: \operatorname{Hom}_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))$ an homotopy multiplication:

which induces in cohomology a multiplicative structure:

on $\mathcal{A}=: \mathcal{E x t} t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))$. The proof of Theorem 1.1 and Corollary 1 follows from the following theorem.

Theorem 3.1. The $\mathbb{Q}$-vector space $\mathcal{A}$, endowed with $\mu_{\mathcal{A}}$, is a graded commutative algebra with unit. Moreover, the evaluation map is a morphism of graded algebras.
Proof. Let $f, g: P \rightarrow \Lambda V$ be elements in A representing two classes in $\mathcal{A}$. As $\Lambda V$ is commutative, the left $\Lambda V$-module $P$ is also a right $\Lambda V$-module by setting $x \cdot a=(-1)^{|x||a|} a \cdot x, \quad x \in P$ and $a \in \Lambda V$.

## Multiplicative structure:

First, we consider

$$

f \otimes g: P \otimes \mathbb{Q} P & \longrightarrow \Lambda V \otimes \mathbb{Q} \Lambda V \\
x \otimes y & \longmapsto(-1)^{|g||x|} f(x) \otimes g(y),
\end{aligned}

and $I$ the ideal generated by $x \cdot a \otimes y-x \otimes a \cdot y ; x, y \in P$ and $a \in \Lambda V$. It is straightforward that the map $\mu_{\Lambda V} \circ(f \otimes g)$ sends $I$ to zero, which then induces on the quotient $P \otimes_{\Lambda V} P=P \otimes_{\mathbb{Q}} P / I$, the dashed map

where

Now, for $a \in \Lambda V$ and $x, y \in P$, we have $(f \cdot g)((a \cdot x) \otimes y)=(-1)^{|f \cdot g||a|} a(f \cdot g)(x \otimes y)$. Therefore $f \cdot g$ is an $\Lambda V$-morphism.

Next, we show that $Q=P \otimes_{\Lambda V} P$ is an $\Lambda V$-semi-free resolution. Recall that a semi-free resolution $(P, d)$ of $\mathbb{Q}$ has the form $W \otimes_{\mathbb{Q}} \Lambda V$ with $W=\bigoplus_{i=0}^{+\infty} W(i)$ and each $W(i)$ is a free graded $\mathbb{Q}$-module and $d: W(k) \rightarrow P(k-1)$, with the semi-free filtration given by $P(k)=\oplus_{i=0}^{k} W(i) \otimes_{\mathbb{Q}} \Lambda V$ [14]. Therefore,

$$
Q=\left(W \otimes_{\mathbb{Q}} \Lambda V\right) \otimes_{\Lambda V}\left(W \otimes_{\mathbb{Q}} \Lambda V\right)=\left(W \otimes_{\mathbb{Q}} W\right) \otimes_{\mathbb{Q}} \Lambda V .
$$

Let $Z=W \otimes_{\mathbb{Q}} W$ and put $Q(k)=\otimes_{i=0}^{k} Z(i) \otimes_{\mathbb{Q}} \Lambda V$ where $Z(l)=\bigoplus_{i+j=l} W(i) \otimes_{\mathbb{Q}} W(j)$ is obviously a free graded $\mathbb{Q}$-module since each $W(i)$ is. For any $x \otimes y \in W(i) \otimes W(j)$, we verify easily that

$$
d x \otimes y \in P(i-1) \otimes W(j) \subseteq Q(k-1) \text { and } x \otimes d y \in W(i) \otimes P(j-1) \subseteq Q(k-1)
$$

whence $D: Z(k) \rightarrow Q(k-1)$. It results that $(Q, D) \simeq(\mathbb{Q}, 0)$ is an $\Lambda V$-semi-free resolution of $(\mathbb{Q}, 0)$. This defines a multiplication

$$
\mu_{\mathrm{A}}: \mathrm{A} \otimes \mathrm{~A} \rightarrow \mathrm{~A}
$$

on $\mathrm{A}=\operatorname{Hom}_{(\Lambda V, d)}(\Lambda V \otimes \Lambda s V, \Lambda V)$. Therefore, passing to cohomology we acquire a well-defined map of vector spaces:

\mu_{\mathcal{A}}: \mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d)) \otimes_{\mathbb{Q}} \mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d)) & \longrightarrow{\mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))}^{[f] \otimes[g]}  \tag{6}\\
& \longmapsto[f \cdot g] \tag{7}
\end{align*}
$$

 tive since the product in $\Lambda V$ is.

## Uniqueness:

Let $m^{\prime}:\left(\Lambda V^{\prime}, d^{\prime}\right) \rightarrow A_{P L}(X)$ be another minimal Sullivan model of $X$. We know, by [14, Proposition 12. 10], that $(\Lambda V, d)$ and $\left(\Lambda V^{\prime}, d^{\prime}\right)$ are isomorphic. The same goes clearly for $Q$ and $Q^{\prime}$. It results from the above commutative triangle that $\mu_{A}$ is independent of the choice of minimal model of $X$.

## Unit element:

Let $\varepsilon: \Lambda V \rightarrow \mathbb{Q}$ be the augmentation. Recall that $P=\Lambda V \otimes \Lambda s V$ is a $(\Lambda V, d)$-semi-free resolution of $(\mathbb{Q}, 0)$.

We extend $\varepsilon$ to $\varepsilon^{\prime}=\varepsilon \otimes \varepsilon_{\Lambda s V}: \Lambda V \otimes \Lambda s V \rightarrow \mathbb{Q}$, then we compose it with the injection $i: \mathbb{Q} \hookrightarrow \Lambda V$ and obtain $\tilde{\varepsilon}: \Lambda V \otimes \Lambda s V \rightarrow \Lambda V$ a representative of a class in $\mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))$. Now, for $f: \Lambda V \otimes \Lambda s V \rightarrow \Lambda V$, a representative of an arbitrary class in $\mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))$, we have

f \cdot \tilde{\varepsilon}:(\Lambda V \otimes \Lambda s V) \otimes_{\Lambda V}(\Lambda V \otimes \Lambda s V)=\Lambda V \otimes \Lambda s V \otimes \Lambda s V \rightarrow \Lambda V

and the map

1 \otimes s v \otimes s w & \longmapsto & 0 \\
1 \otimes 1 \otimes s v & \longmapsto & 0
\end{array}

makes the following diagram commutative:


Thus, it defines a homotopy unit element for $\mathrm{A}=\operatorname{Hom}_{(\Lambda V, d)}((P, d),(\Lambda V, d))$. Passing to cohomology, we get $[f] \cdot[\tilde{\varepsilon}]=[f]$ and similarly $[\tilde{\varepsilon}] \cdot[f]=[f]$. Henceforth, the class $[\tilde{\varepsilon}]$ defines a unit element for $\mu_{\mathcal{A}}$.

## Commutativity:

Let $\tau$ be the flip map $\tau: P \otimes_{\Lambda V} P \rightarrow P \otimes_{\Lambda V} P ; x \otimes y \mapsto(-1)^{|x||y|} y \otimes x$. The diagram

is commutative.
clearly $\tau$ being a quasi-isomorphism, $f \cdot g \sim g \cdot f$ and $[f \cdot g]=(-1)^{|f||g|}[g \cdot f]$ so that, the multiplication on A is homotopy commutative and that on $\mathcal{A}$ is indeed commutative.

We respectively conclude that A is a homotopy commutative differential graded algebra with unit and $\mathcal{E} x t_{(\Lambda V, d)}(\mathbb{Q},(\Lambda V, d))$ is a graded commutative $\mathbb{Q}$-algebra with unit.

Finally, it is clear that the following diagram, where cev is the chain evaluation map of $(\Lambda V, d)$, is commutative:


Thus, passing to cohomology

we deduce that the evaluation map is a morphism of graded algebra.

## $4 \mathcal{E} x t$-VERSIONS APPROXIMATIONS AND THE MAIN THEOREM

Let $(A, d)$ be any commutative differential graded algebra model for a space $X,(\Lambda V, d)$ its minimal Sullivan model given by the quasi-isomorphism $\theta:(\Lambda V, d) \stackrel{\simeq}{\rightarrow}(A, d)$ [14]. Referring to [6], the cdga morphism

$$
\mu_{n}^{\theta}:=\left(\operatorname{Id}_{A}, \theta, \ldots, \theta\right):(A, d) \otimes(\Lambda V, d)^{\otimes n-1} \rightarrow(A, d)
$$

is a special model, called an $s$-model, for the path fibration $\pi_{n}: X^{I} \rightarrow X^{n}$ which is indeed the substitute of the $n$-fold diagonal $\Delta_{X}^{n}: X \rightarrow X^{n}$. This allows the following:
Definition 4.1. (a): $\mathrm{TC}_{n}\left(X_{0}\right)$ is the least $m$ such that the projection

\rho_{m}:\left(A \otimes(\Lambda V)^{\otimes n-1}, d\right) \rightarrow\left(\frac{A \otimes(\Lambda V)^{\otimes n-1}}{\left(\operatorname{ker} \mu_{n}^{\theta}\right)^{m+1}}, \bar{d}\right)
$$

admits an algebra retraction.
(b): $\mathrm{mTC}_{n}(\mathrm{X}, \mathbb{Q})$ is the least $m$ such that $\rho_{m}$ admits a retraction as $\left(A \otimes(\Lambda V)^{\otimes n-1}, d\right)$-module.
(c): $\operatorname{HTC}_{n}(X, \mathbb{Q})$ is the least $m$ such that $H\left(\rho_{m}\right)$ is injective.
(d): nil $\operatorname{ker} H^{*}\left(\Delta_{X}^{n}, \mathbb{Q}\right)$ is the longest non trivial product of elements of $\left.\operatorname{ker} H^{*}\left(\Delta_{X}^{n}\right), \mathbb{Q}\right)$.

It is also well known (cf. for instance [6]) that:

$$

n i l \operatorname{ker} H^{*}\left(\Delta_{X}^{n}, \mathbb{Q}\right) \leq \operatorname{HTC}_{n}(X, \mathbb{Q}) \leq \operatorname{mTC}_{n}(\mathrm{X}, \mathbb{Q}) \leq \mathrm{TC}_{n}\left(X_{0}\right) \leq \mathrm{TC}_{n}(X) \tag{8}
\end{equation*}
$$

Now, if we take $\theta$ to be the identity of $\Lambda V, \mu_{n}^{\theta}=\mu_{n}^{I d_{\Lambda V}}$ becomes the $n$-fold multiplication in $\Lambda V$ denoted by

Therefore, nil $\operatorname{ker} H^{*}\left(\Delta_{X}^{n}, \mathbb{Q}\right)=$ nil $\operatorname{ker} H^{*}\left(\mu_{n}\right)$.
In a similar way, we put

 tion (1.2) the following definition actually reads as the $\mathcal{E x t}$-version of the previous one:

Definition 4.2. (a): $\operatorname{TC}_{n}^{\mathcal{E} x t}(X, \mathbb{Q})$ is the least $m$ such that the projection

\Gamma_{m}:\left(\mathrm{A}^{\otimes n}, d\right) \rightarrow\left(\frac{\mathrm{A}^{\otimes n}}{\left(\operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)\right)^{m+1}}, \bar{d}\right)
$$

admits a homotopy retraction.
(b): $\mathrm{mTC}^{\mathcal{E} x t}{ }_{n}(\mathrm{X})$ is the least $m$ such that $\Gamma_{m}$ admits a homotopy retraction as $\left(\mathrm{A}^{\otimes n}, d\right)$-module.
(c): $\operatorname{HTC}_{n}^{\mathcal{E} x t}(X)$ is the least $m$ such that $H\left(\Gamma_{m}\right)$ is injective.
(d): nil $\operatorname{ker}\left(\mu_{\mathcal{A}, n}, \mathbb{Q}\right)$ is the longest non trivial product of elements of $\operatorname{ker}\left(\mu_{\mathcal{A}, n}\right)$.

The same arguments used to establish the inequalities in (8) allow the following:

The projections

$$
\Gamma_{m}:\left(\mathrm{A}^{\otimes n}, d\right) \rightarrow\left(\frac{\mathrm{A}^{\otimes n}}{\left(\operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)\right)^{m+1}}, \bar{d}\right) \quad \text { and } \quad \rho_{m}:\left((\Lambda V)^{\otimes n}, d\right) \rightarrow\left(\frac{(\Lambda V)^{\otimes n}}{\left(\operatorname{ker} \mu_{n}\right)^{m+1}}, \bar{d}\right)
$$

induce two short exact sequences linked by chain evaluation maps:


As a consequence, we have:
Theorem 4.1. Let $X$ be a 1 -connected finite type $C W$-complex. If $X$ is a Gorenstein space over $\mathbb{Q}$ and $e v_{C^{*}(X, \mathbb{Q})} \neq 0$, then $H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q}) \leq H T C_{n}(X, \mathbb{Q})$ for any integer $n \geq 2$. Furthermore, if $(\Lambda V, d)$ is a Sullivan minimal model of $X,[f]$ is the generating class of $\mathcal{A}$ and $m=H T C_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$, then:

$$
H T C_{n}(X, \mathbb{Q})=H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q})=: m \Leftrightarrow f(1)^{\otimes n} \in\left(\operatorname{ker} \mu_{n}\right)^{m} \backslash\left(\operatorname{ker} \mu_{n}\right)^{m+1} .
$$

Before giving the proof of the theorem, let us first recall that if $X$ is a finite $n$-dimensional subcomplex of $\mathbb{R}^{n+k}, k>n+1$ and $M$ its regular neighborhood, the homotopy fiber $F_{X}$ of the inclusion $\partial M \hookrightarrow M$ is called the Spivak fiber for $X$ and it is a homotopy invariant of $X$. It is introduced in [23] where it is shown that $X$ is a Poincaré complex if and only if $F_{X}$ is a homotopy sphere.

The following corollary presents some essential classes of spaces satisfying the previous theorem:
Corollary 3. Hypothesis of $[1.2$ and hence its conclusions are satisfied in the following cases:
(a) $X$ is rationally elliptic,
(b) $H_{>N}(X, \mathbb{Z})=0$, for some $N$, and $H^{*}(X, \mathbb{Q})$ is a Poincaré duality algebra,
(c) $X$ is a finite 1-connected CW-complex and its Spivak fiber $F_{X}$ has finite dimensional cohomology.
For the sake of completeness, we present below a sketch of the proof of the corollary:
(a) If $X$ is rationally elliptic, then it is Gorenstein and $e v_{C^{*}(X, \mathbb{Q})} \neq 0$ thanks respectively to [13, Proposition 3.4] and [19, Theorem A].
(b) Referring to [8] (cf. also [13, Theorem 3.6]), under the hypothesis, $H^{*}(X, \mathbb{Q})$ is a Poincaré duality algebra if and only if $X$ is a Gorenstein space over $\mathbb{Q}$. Thus, by [13, Theorem 2.2] we have $\operatorname{dim} \pi_{*}(X) \otimes \mathbb{Q}<\infty$ and by [19, Theorem A] we obtain $e v_{C^{*}(X, \mathbb{Q})} \neq 0$.
(c) Here using [13, Corollary 4.5] we have $H^{*}(X, \mathbb{Q})$ is a Poincaré duality algebra, hence it is a Gorenstein algebra. It results that $X$ is Gorenstein over $\mathbb{Q}\left[13\right.$, Proposition 3.2] and $e v_{C^{*}(X, \mathbb{Q})} \neq$ 0 as in the previous case.

Proof. (of Theorem 4.1): Let $(\Lambda V, d)$ be a Sullivan minimal model of $X$. Since $X$ is Gorenstein, $\mathcal{A} \cong \mathbb{Q} \Omega$ where $\Omega$ is the generating class represented by a cocycle $f \in \mathrm{~A}^{N}$ of degree $N=f d(X)$, the formal dimension of $X$ (cf. §5, [13]). Therefore, the diagram (12) induces in cohomology the following one

$$
\begin{array}{cc}
0 \longrightarrow H^{n N}\left(\operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)^{m+1}\right) & \longrightarrow\left(\mathcal{A}^{N}\right)^{\otimes n} \xrightarrow{H^{n N}\left(\Gamma_{m}\right)} H^{n N}\left(\frac{\mathrm{~A}^{\otimes n}}{\operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)^{m+1}}\right) \longrightarrow 0 \\
\mathrm{H}^{n N-1}\left(\frac{(\Lambda V)^{\otimes n}}{\left(\operatorname{ker} \mu_{n}\right)^{m+1}}\right) \longrightarrow H^{n N}\left(\left(\operatorname{ker} \mu_{n}\right)^{m+1}\right) \longrightarrow\left(H^{N}(\Lambda V)\right)^{\otimes n} \xrightarrow[H^{n N\left(\rho_{m}\right)}]{\longrightarrow} H^{n N}\left(\frac{(\Lambda V)^{\otimes n}}{\left(\operatorname{ker} \mu_{n}\right)^{m+1}}\right) \longrightarrow 0
\end{array}
$$

Now, since $e v_{(\Lambda V, d)}=e v_{C^{*}(X, \mathbb{Q})} \neq 0$, this is also the case for the horizontal arrow $e v_{(\Lambda V, d)}^{\otimes n}$. Thus, if $H^{n N}\left(\rho_{m}\right)$ is injective then $H^{n N}\left(\Gamma_{m}\right)$ is also injective. It results that: $H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q}) \leq H T C_{n}(X, \mathbb{Q})$.

Next, let $m$ denote the smallest integer such that $H^{n N}\left(\Gamma_{m}\right)$ is injective or equivalently $f^{\otimes n}$ is a cocycle in $\mathrm{A}^{\otimes n}$ and $f^{\otimes n} \in \operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)^{m+1} \backslash \operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)^{m+1}$ (see Remarque below). Moreover, since $\left(\mathcal{A}^{N}\right)^{\otimes n}$ is one dimensional, $H^{n N}\left(\Gamma_{m}\right)$ is indeed a bijection. Hence, $H^{n N}\left(\rho_{m}\right)$ is injective if and only if $H^{n N}(\theta)$ is injective. But, $e v_{(\Lambda V, d)}^{\otimes n}$ being non-zero, the commutativity of the right diagram implies that this is equivalent to $f(1)^{\otimes n} \in\left(\operatorname{ker} \mu_{n}\right)^{m} \backslash\left(\operatorname{ker} \mu_{n}\right)^{m+1}$. Notice that $\mu_{\mathrm{n}}\left(f(1)^{\otimes n}\right)$ is a cocycle in $(\Lambda V)^{\otimes n}$ and $e v_{(\Lambda V, d)}^{\otimes n}\left[f^{\otimes n}\right]=[f(1)]^{\otimes n} \neq 0$. It results that $H T C_{n}(X, \mathbb{Q})=H T C_{n}^{\mathcal{E} x t}(X, \mathbb{Q})=: m \Leftrightarrow f(1)^{\otimes n} \in$ $\left(\operatorname{ker} \mu_{n}\right)^{m} \backslash\left(\operatorname{ker} \mu_{n}\right)^{m+1}$.

Remark 1. An equivalent definition of $\operatorname{HTC}_{n}(X, \mathbb{Q})$ when $X$ is a Poincaré duality space reads as follows: It is the smallest integer $m \geq 0$ such that some cocycle $\omega$ representing the fundamental class of $(\Lambda V, d)^{\otimes n}$, can be written as a product of $m$ elements of $k e r\left(\mu_{n}\right)$ (not necessarily cocycles). Similarly, for any Gorenstein space $X, \operatorname{HTC}_{n}^{\mathcal{E} x t}(X, \mathbb{Q})$ is the smallest integer $m$ such that some cocycle representing the fundamental class of $\mathrm{A}^{\otimes n}$, namely $\Omega=[f]^{\otimes n}$ where $[f]$ designates the generating element of $\mathcal{A}^{N}$, can be written as a product of length $m$ of elements in $\operatorname{ker}\left(\mu_{\mathrm{A}, n}\right)$. Therefore, in order to determine $H T C_{n}(X, \mathbb{Q})$ we may, using the precedent theorem, calculate $m=H T C_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$ which is quite simpler since $\mathcal{A}^{*}$ is one dimensional, and afterwards deal with the obstruction to have the equality.

Now, if $\operatorname{dim} V<\infty$ and $\operatorname{dim} H(\Lambda V, d)=\infty$ then by [19, Theorem A] we have $(\Lambda V, d)$ is a Gorenstein but not a Poincaré duality algebra. Moreover $\mathrm{ev}_{(\Lambda V, d)}=0$. Hence, in this case, to compare the invariants $H T C_{n}^{\mathcal{E x t}}(X, \mathbb{Q})$ and $H T C_{n}(X, \mathbb{Q})$ we should determine them separately.

## 5 Use of the Adams-Hilton model.

The Adams-Hilton model [1] of an arbitrary CW-complex $X$ over an arbitrary field $\mathbb{K}$ is a chain algebra quasi-morphism $\theta_{X}:(T V, d) \xrightarrow{\simeq} C_{*}(\Omega X ; \mathbb{K})$ i.e. $H_{*}\left(\theta_{X}\right)$ is an isomorphism of graded algebras. Here $V$ satisfies $H_{i-1}\left(V, d_{1}\right) \cong H_{i}(X ; \mathbb{K})$ and $d_{1}: V \rightarrow V$ is the linear part of $d$. $(T V, d)$ is called a free model of $X$.

Now, if $\mathbb{K}$ is a field with odd characteristic (thus containing $\frac{1}{2}$ ) and $X$ is a $q$-connected ( $q \geq 1$ ) finite CW-complex such that $\operatorname{dim} X \leq q \cdot \operatorname{char}(\mathbb{K})$ i.e. $X \in C W_{q}(\mathbb{K})$ (cf. Introduction) it has a minimal Sullivan model $(\Lambda W, d)$ [16, Theorem 7.1]. Therefore, using the isomorphism (3) we have successively:

\mathcal{E} x t_{C^{*}(X ; \mathbb{K})}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right) \underset{10}{\cong} \mathcal{E} x t_{(\Lambda W, d)}(\mathbb{K},(\Lambda W, d)) \tag{13}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{E} x t_{(T V, d)}(\mathbb{K},(T V, d)) \xlongequal{\cong}{\mathcal{E} x t_{C_{*}(\Omega X ; \mathbb{K})}\left(\mathbb{K}, C_{*}(\Omega X ; \mathbb{K})\right) . . . . .} \tag{14}
\end{equation*}
$$

These, combined with the isomorphism of graded $\mathbb{K}$-vector spaces [13, Theorem 2.1]:
gives the isomorphism of graded $\mathbb{K}$-vector spaces:

$$
\begin{equation*}
\mathcal{E} x t_{(\Lambda W, d)}(\mathbb{K},(\Lambda W, d)) \cong{\mathcal{E} x t_{(T V, d)}}(\mathbb{K},(T V, d)) . \tag{16}
\end{equation*}
$$

\left. Argument used in the rational case allows us to conclude that ${\mathcal{E} x t_{(\Lambda W, d)}(\mathbb{K},(\Lambda W, d)) \text { has the structure of }}^{( }\right)$ a graded commutative algebra with unit. The latter isomorphism serves to endow $\mathcal{E} x t_{(T V, d)}(\mathbb{K},(T V, d))$ with the same structure. It results the following

Proposition 5.1. Let $\mathbb{K}$ be a field with odd characteristic and $X \in C W_{q}(\mathbb{K})$. Then, the graded vector spaces $\mathcal{E} x t_{C^{*}(X ; \mathbb{K})}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right)$ and $\mathcal{E x t}_{C_{*}(\Omega X ; \mathbb{K})}\left(\mathbb{K}, C_{*}(\Omega X ; \mathbb{K})\right)$ have isomorphic graded commutative algebra structures with unit. In particular, the Adams-Hilton model can be used to make this structure explicit.

Recall that $\mathcal{E x t} t_{(T V, d)}(\mathbb{K},(T V, d))$ is, as in the rational case, obtained in terms of the acyclic closure of $\mathbb{K}$ of the form $(T V \otimes(\mathbb{K} \oplus s V), \delta)$, where the differential $\delta$ satisfies $\delta s+s d=i d, d$ being the differential of $T V$. That is, for any element $z \otimes s v$ of $T V \otimes(\mathbb{K} \oplus s V)$, we have

$$
\delta(z \otimes s v)=d z \otimes s v+(-1)^{|z|} z v \otimes 1-(-1)^{|z|} z \otimes s d v .
$$

Notice that any element $f$ in $\operatorname{Hom}_{(T V, d)}^{p}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d))$ is entirely determined by its image of $1 \otimes(\mathbb{K} \oplus s V)$ since $T V \otimes(\mathbb{K} \oplus s V)$ is a left $(T V, d)$-module acting on the first factor. Thus we have

$$
\begin{aligned}
(D(g))(1 \otimes s v) & =d \circ f(1 \otimes s v)-(-1)^{p} f \circ \delta(1 \otimes s v) \\
& =d f(1 \otimes s v)-(-1)^{p(|v|+1)} v f(1)+(-1)^{p} f(1 \otimes s d v) .
\end{aligned}
$$

Therefore,
(a) An element $g$ in $H o m_{(T V, d)}^{p-1}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d))$ is in $\operatorname{Im}(D)$ if and only if $g=D(f)$ for some $f$ in $H o m_{(T V, d)}^{p}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d))$, i.e.

$$
g(1 \otimes s v)=d f(1 \otimes s v)-(-1)^{p(|v|+1)} v f(1)+(-1)^{p} f(1 \otimes s d v) .
$$

Consequently:

$$
\begin{equation*}
g \in \operatorname{Im}(D) \Leftrightarrow g(1 \otimes s v)=d f(1 \otimes s v)-(-1)^{p(|v|+1)} v f(1)+(-1)^{p} f(1 \otimes s d v) \text { for some } f . \tag{17}
\end{equation*}
$$

(b) An element $f \in \operatorname{Hom}_{(T V, d)}^{p}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d))$ is in $\operatorname{Ker}(D)$ if and only if $D(f)=0$, that is, $d f(1 \otimes s v)=(-1)^{p(|v|+1)} v f(1)-(-1)^{p} f(1 \otimes s d v)$. Consequently:

$$
\begin{equation*}
f \in \operatorname{Ker}(D) \Leftrightarrow d f(1 \otimes s v)=(-1)^{p(|v|+1)} v f(1)-(-1)^{p} f(1 \otimes s d v) . \tag{18}
\end{equation*}
$$

Now, since $\operatorname{deg}(d)=-1, \mathcal{A}_{*}=\left(\operatorname{Hom}_{(T V, d)}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d)), D\right)$ is a $D G A_{*}$ in the sense of [13]. Using the standard convention $\mathcal{A}^{-q}=\mathcal{A}_{q}$, for all $q \in \mathbb{Z}$, we obtain a $D G A^{*}$ whose cohomology at $-p$ is the $\mathbb{K}$-module:

$$
\mathcal{E} x t_{(T V, d)}^{-p}(\mathbb{Q},(T V, d))=H_{p}\left(\operatorname{Hom}_{(T V, d)}((T V \otimes(\mathbb{K} \oplus s V), \delta),(T V, d)), D\right)
$$

More explicitly, if $f \in \operatorname{Hom}_{(T V, d)}(T V \otimes(\mathbb{K} \oplus s V), \Lambda V)$ is a cycle of (homological) degree $p$, it define a cohomological class $[f] \in \mathcal{E} x t_{(T V, d)}^{-p}(\mathbb{Q},(T V, d))$ of degree $-p$.
5.1 Case of a suspension. Assume that $\mathbb{K}=\mathbb{Q}$ and let $X$ be a simply connected space, and $Y=\Sigma X$ its suspension. The morphism of graded modules $\sigma_{*}: H_{*}(X ; \mathbb{Q}) \longrightarrow H_{*}(\Omega \Sigma X ; \mathbb{Q})$ induced by the adjoint $\sigma: X \rightarrow \Omega \Sigma X$ of $i d_{\Sigma X}$ extends to a morphism of graded algebras $T\left(\sigma_{*}\right): T H_{*}(X ; \mathbb{Q}) \longrightarrow$ $H_{*}(\Omega \Sigma X ; \mathbb{Q})$. In fact, this is an isomorphism of graded algebras since $H_{*}(X ; \mathbb{Q})$ is a free graded $\mathbb{Q}$ module. Therefore ([4])

$$
\left(T H_{*}(X ; \mathbb{Q}), 0\right) \xrightarrow{\simeq} C_{*}(\Omega \Sigma X ; \mathbb{Q})
$$

is an Adams-Hilton model of $Y=\Sigma X$. It results that

$$
\mathcal{E x t}_{C_{*}(\Omega \Sigma X ; \mathbb{Q})}\left(\mathbb{Q}, C_{*}(\Omega \Sigma X ; \mathbb{Q})\right) \cong \operatorname{Ext}_{T V}(\mathbb{Q}, T V)
$$

where $V=H_{*}(X ; \mathbb{Q})$. Now of $(S, d)=(\Lambda W, d)$ is a Sullivan model of $Y=\Sigma X$, using (15) we obtain a commutative diagram


This permits the use of Adams-Hilton models to explicitly describe the algebra structure on $\mathcal{A}$ since it restricts to ordinary Ext which loosen the calculations. Notice that $\Omega(\Sigma X)$ is weakly equivalent to the James space $J(X)$ and referring to [14, Example 7] that there exists a minimal Sullivan model for $\Sigma X$ of the form $(\Lambda W, d)$ with quadratic differential i.e. such that $d(W) \subset \Lambda^{2} W$.
5.2 When $X$ is a 2 -cell CW complex. Let $\mathbb{K}$ any field containing $\frac{1}{2}$. In this subsection, we showcase another use of the Adams-Hiton models to help picture the algebra structure on $\mathcal{A}$. Let then $X=$ $S^{q} \cup_{\varphi} e^{q+1}, q \geq 2$, be the space where the cell $e^{q+1}$ is attached by a map of degree $r$. The Adams-Hilton model of $X$ has the form $(T V, d)$ where $V$ is a $\mathbb{K}$-vector space generated by $a$ and $a^{\prime}$ with $\operatorname{deg}(a)=q-1$, $\operatorname{deg}\left(a^{\prime}\right)=q, \quad d a=0$ and $\quad d a^{\prime}=-r a$.

Let us go back to where we left off at the beginning of this section and apply, in this case, the obtained formulas (17) and (18). This respectively yields:

$$
g \in \operatorname{Im}(D) \Leftrightarrow\left\{\begin{array}{l}
g(1)=d f(1),  \tag{19}\\
\left.g(1 \otimes s a)=d f(1 \otimes s a)-(-1)^{p q} a f(1), \quad \quad \quad \text { ( for some } f\right) \\
g\left(1 \otimes s a^{\prime}\right)=d f\left(1 \otimes s a^{\prime}\right)-(-1)^{p} r f(1 \otimes s a)-(-1)^{p(q+1)} a^{\prime} f(1),
\end{array}\right.
$$

and

$$
f \in \operatorname{Ker}(D) \Leftrightarrow\left\{\begin{array}{l}
d f(1)=0  \tag{20}\\
d f(1 \otimes s a)=(-1)^{p q} a f(1), \\
d f\left(1 \otimes s a^{\prime}\right)=(-1)^{p} r f(1 \otimes s a)+(-1)^{p(q+1)} a^{\prime} f(1) .
\end{array}\right.
$$

Recall that to any pointed topological space $X$, it is associated in [13] an invariant called the formal dimension of $X$ (with respect to a field $\mathbb{K}$ ) defined as follows:

$$
f d(X, \mathbb{K})=\sup \left\{r \in \mathbb{Z} \mid\left[\mathcal{E} x t_{C^{*}(X ; \mathbb{K})}^{p}\left(\mathbb{K}, C^{*}(X ; \mathbb{K})\right)\right]^{r} \neq 0\right\}
$$

or $f d(X, \mathbb{K})=-\infty$ if such integer does not exist. In particular [13, Proposition 5.1], if $H^{*}(X ; \mathbb{K})$ is finite dimensional,

$$
f d(X, \mathbb{K})=\sup \left\{r \in \mathbb{Z} \mid H^{r}(X ; \mathbb{K}) \neq 0\right\} .
$$

Notice that, using cellular homology, we see that $H_{*}(X, \mathbb{Z})=H_{0}(X, \mathbb{Z}) \oplus H_{q}(X, \mathbb{Z}) \cong \mathbb{Z} \oplus \mathbb{Z} / r \mathbb{Z}$. We should then discuss two cases:
(i) If $\operatorname{char}(\mathbb{K})=0$ or co-prime with $r$, we have $H^{*}(X, \mathbb{K})=H^{0}(X, \mathbb{K}) \cong \mathbb{K}$. In this case, $H^{*}(X, \mathbb{K})$ has formal dimension $f d(X)=0$, thus, it is a Poincaré duality space. Moreover, since it has finite dimensional cohomology, it is also a Gorenstein space [13, Theorem 3.1].
(ii) If $\operatorname{char}(\mathbb{K})$ divides $r$ then, $H^{*}(X, \mathbb{K})=H^{0}(X, \mathbb{K}) \oplus H^{q}(X, \mathbb{K}) \oplus H^{q+1}(X, \mathbb{K}) \cong \mathbb{K} \oplus \mathbb{K} \oplus \mathbb{K}$. Thus, since $q \geq 2, X$ is neither a Poincaré duality space nor a Gorenstein space [8, Theorem 1]. In this case, $f d(X)=q+1$, so that $\mathcal{E} x t_{(T V, d)}^{k}(\mathbb{K},(T V, d))=0, \forall k>q+1$.

Example: In this example, we specify the case where $q=2$, i.e. $X=S^{2} \cup_{\varphi} e^{3}$. Thus $V=\mathbb{K} a \oplus \mathbb{K} a^{\prime}$ with $|a|=1$ and $\left|a^{\prime}\right|=2$. We give below an explicit computation of it to illustrate the use of AdamsHilton models.
i. Assume that char $(\mathbb{K})=0$ or co-prime with $r$ (we specialize in the case where $\mathbb{K}=\mathbb{Q}$ ).

Let $f$ be a cycle of degree 0 , we have $d f(1)=0$, then $f(1)$ is necessarily a scalar $f(1)=\gamma$. The second equation in (20) implies that $d f(s a)=\gamma a$, therefore $f(s a)=-\frac{\gamma}{r} a^{\prime}+\gamma^{\prime} a^{2}$. The last equation in (20) gives, after a simple simplification, $d f\left(s a^{\prime}\right)=r \gamma^{\prime} a^{2}$, then $f\left(s a^{\prime}\right)=-\gamma_{1}^{\prime} a^{\prime} \cdot a+\gamma_{2}^{\prime} a \cdot a^{\prime}+\gamma^{\prime \prime} a^{3}$,

$$
K e r(D)=\frac{\mathbb{Q} \oplus \mathbb{Q} a^{\prime} \oplus \mathbb{Q} a^{2} \oplus \mathbb{Q} a^{\prime} \cdot a \oplus \mathbb{Q} a \cdot a^{\prime} \oplus \mathbb{Q} a^{3}}{<x_{1}=-r x_{2} ; x_{3}=-x_{4}+x_{5}>}
$$

Now let $g$ be an arbitrary element of degree 1

$$
\left\{\begin{array}{l}
g(1)=\alpha_{1} a \\
g(s a)=\alpha_{2} a^{\prime} \cdot a+\alpha_{3} a \cdot a^{\prime}+\alpha_{4} a^{3} \\
g\left(s a^{\prime}\right)=\alpha_{5} a^{\prime 2}+\alpha_{6} a^{\prime} \cdot a^{2}+\alpha_{7} a \cdot a^{\prime} \cdot a+\alpha_{8} a^{2} \cdot a^{\prime}+\alpha_{9} a^{4}
\end{array}\right.
$$

by [19] we have

$$
\left\{\begin{array}{l}
D(g)(1)=0 \\
D(g)(s a)=\left(-\alpha_{1}-r \alpha_{2}+r \alpha_{3}\right) a^{2} \\
D(g)\left(s a^{\prime}\right)=\left(\alpha_{1}+r \alpha_{2}-r \alpha_{5}\right) a^{\prime} \cdot a+\left(r \alpha_{3}-r \alpha_{5}\right) a \cdot a^{\prime}+\left(r \alpha_{4}-r \alpha_{6}+r \alpha_{7}-r \alpha_{8}\right) a^{3}
\end{array}\right.
$$

therefore

$$
\operatorname{Im}(D)=\frac{\mathbb{Q} a^{2} \oplus \mathbb{Q} a^{\prime} \cdot a \oplus \mathbb{Q} a \cdot a^{\prime} \oplus \mathbb{Q} a^{3}}{<x_{1}=-x_{2}+x_{3}>}
$$

We consequently obtain $\mathcal{E} x t_{(T V, d)}^{0}(\mathbb{Q},(T V, d))=\mathbb{Q}$.
Applying the same process for $i \neq 0$, we recover the previously stated fact $\mathcal{E} x t_{(T V, d)}^{i}(\mathbb{Q},(T V, d))=0$.
ii. Assume $\operatorname{char}(\mathbb{K})$ divides $r$ so that $r=0(\bmod \operatorname{char}(\mathbb{K}))$ and $d a=d a^{\prime}=0$. Recall that in general, we have:

$$
(D(f))(1 \otimes s a)=d f(1 \otimes s a)-(-1)^{p q} a f(1)=0
$$

and

$$
(D(f))\left(1 \otimes s a^{\prime}\right)=d f\left(1 \otimes s a^{\prime}\right)-(-1)^{p} r f(1 \otimes s a)-(-1)^{p(q+1)} a^{\prime} f(1)=0
$$

These become respectively in this case:

\begin{equation*}
(D(f))(1 \otimes s a)=-(-1)^{p q} a f(1)=0, \text { and }(D(f))\left(1 \otimes s a^{\prime}\right)=-(-1)^{p(q+1)} a^{\prime} f(1)=0 \tag{21}
\end{equation*}
$$

Notice that in this case, for an element $f$ to be in $\operatorname{ker}(D)$ it is necessarily that $f(1)=0$
Let $f$ be a cycle of degree 0 , then we have $f(1)=0$, consequently $d f(s a)=d f\left(s a^{\prime}\right)=0$, which implies $f(s a)=\gamma_{1} a^{\prime}+\gamma_{2} a^{2}$ and $f\left(s a^{\prime}\right)=\gamma_{3} a^{\prime} \cdot a+\gamma_{4} a \cdot a^{\prime}+\gamma_{5} a^{3}$. Therefore

$$
K e r(D)=\mathbb{K} a^{2} \oplus \mathbb{K} a^{\prime} \oplus \mathbb{K} a^{\prime} \cdot a \oplus \mathbb{K} a \cdot a^{\prime} \oplus \mathbb{K} a^{3}
$$

Now let $g$ be an arbitrary element of degree 1

$$
\left\{\begin{array}{l}
g(1)=\alpha_{1} a \\
g(s a)=\alpha_{2} a^{\prime} \cdot a+\alpha_{3} a \cdot a^{\prime}+\alpha_{4} a^{3} \\
g\left(s a^{\prime}\right)=\alpha_{5} a^{\prime 2}+\alpha_{6} a^{\prime} \cdot a^{2}+\alpha_{7} a \cdot a^{\prime} \cdot a+\alpha_{8} a^{2} \cdot a^{\prime}+\alpha_{9} a^{4}
\end{array}\right.
$$

hence

$$
\left\{\begin{array}{l}
D(g)(1)=0 \\
D(g)(s a)=-a g(1)=-\alpha_{1} a^{2} \\
D(g)\left(s a^{\prime}\right)=a^{\prime} g(1)=\alpha_{1} a^{\prime} \cdot a
\end{array}\right.
$$

therefore

$$
\operatorname{Im}(D)=\frac{\mathbb{K} a^{2} \oplus \mathbb{K} a^{\prime} \cdot a}{\left\langle x_{1}=-x_{2}\right\rangle} \cong \mathbb{K}\left(a^{\prime} \cdot a-a^{2}\right) .
$$

we obtain $\mathcal{E} x t_{(T V, d)}^{0}(\mathbb{K},(T V, d)) \cong \mathbb{K} a^{2} \oplus \mathbb{K} a^{\prime} \oplus \mathbb{K} a \cdot a^{\prime} \oplus \mathbb{K} a^{3} \cong \mathbb{K}^{4}$.
An application of the same argument yields

$$
\begin{aligned}
& \mathcal{E} x t_{(T V, d)}^{-1}(\mathbb{K},(T V, d)) \cong \mathbb{K} a^{3} \oplus \mathbb{K} a \cdot a^{\prime} \oplus \mathbb{K} a^{\prime} \cdot a \oplus \mathbb{K} a \cdot a^{\prime} \cdot a \oplus \mathbb{K} a^{2} \cdot a^{\prime} \oplus \mathbb{K} a^{4} \cong \mathbb{K}^{6} \\
& \mathcal{E} x t_{(T V, d)}^{-2}(\mathbb{K},(T V, d)) \cong \\
& \mathbb{K} a^{4} \oplus \mathbb{K} a^{2} \cdot a^{\prime} \oplus \mathbb{K} a \cdot a^{\prime} \cdot a \oplus \mathbb{K} a^{\prime} \cdot a^{2} \oplus \mathbb{K} a^{\prime 2} \oplus \\
& \cong \mathbb{K} a \cdot a^{\prime 2} \oplus \mathbb{K} a^{3} \cdot a^{\prime} \oplus \mathbb{K} a^{2} \cdot a^{\prime} \cdot a \oplus \mathbb{K} a \cdot a^{\prime} \cdot a^{2} \oplus \mathbb{K} a^{5} \\
& \cong \mathbb{K}^{10} .
\end{aligned}
$$

From the previous cases, it is obvious that $\mathcal{E} x t_{(T V, d)}^{-i}(\mathbb{K},(T V, d)) \neq 0, \forall i \geq 0$. Since $f d(X, \mathbb{K})=3$, we have $\mathcal{E} x t_{(T V, d)}^{i}(\mathbb{K},(T V, d))=0, \forall i \geq 4$. It remains then to calculate the cases cases $i=-1,-2,-3$ which are given successively by applying the same process as follows $\left.\mathcal{E} x t_{(T V, d)}^{1} \mathbb{K},(T V, d)\right) \cong \mathbb{K} a^{\prime} \oplus \mathbb{K} a^{2}, \mathcal{E} x t_{(T V, d)}^{2}(\mathbb{K},(T V, d)) \cong \mathbb{K} \oplus \mathbb{K} a$ and $\mathcal{E} x t_{(T V, d)}^{3}(\mathbb{K},(T V, d)) \cong \mathbb{K}$.

Now notice that for $q>2$, Adams-Hilton model for $X=S^{q} \cup_{\varphi} e^{q+1}$ has generators $a$ and $a^{\prime}$ of degrees respectively $q-1$ and $q$, thus the degree of $a^{\prime}$ does not double that of $a$, so the previous example is somewhat a special case. However the computational process still holds, and we have, for the case $\mathbf{i}, \mathcal{E} x t_{(T V, d)}^{0}(\mathbb{K},(T V, d))=\mathbb{K}$ and $\mathcal{E} x t_{(T V, d)}^{i}(\mathbb{K},(T V, d))=0$ for $i \neq 0$. Whereas for the case ii, computation process holds but the results differ, since we might have $\mathcal{E} x t_{(T V, d)}^{-i}(\mathbb{K},(T V, d))=0$ for finitely many $i \geq-(q+1)$ (e.g. for $q=7$ we have $\mathcal{E} x t_{(T V, d)}^{7}(\mathbb{K},(T V, d))=0$ ), on the other hand, we always have $\mathcal{E} x t_{(T V, d)}^{-i}(\mathbb{K},(T V, d))=0, \forall i<-(q+1)$ since $f d(X)=q+1$.
