# Well posedness and stochastic derivation of a diffusion-growth-fragmentation equation in a chemostat

#### Abstract

We study the existence and uniqueness of the solution of a non-linear coupled system constituted of a degenerate diffusion-growth-fragmentation equation and a differential equation, resulting from the modeling of bacterial growth in a chemostat. This system is derived, in a large population approximation, from a stochastic individual-based model where each individual is characterized by a non-negative trait whose dynamics is described by a diffusion process. Two uniqueness results are highlighted. They differ in their hypotheses related to the influence of the resource on individual trait dynamics, the main difficulty being the nonlinearity due to this dependence and the degeneracy of the diffusion coefficient. Further we show by probabilistic arguments that the semi-group of the stochastic trait dynamics admits a density. We deduce that the diffusion-growth-fragmentation equation admits a function solution with a certain Besov regularity.

## 1 Introduction

Developed by Novick and Szilard [26], and Monod [25], the chemostat is a laboratory device used by biologists to raise the microorganisms and study their interactions while at the same time regulating the population size and the experimental medium. It consists in a culture in a container of constant volume in which a substrate is continuously injected and extracted at the same rate. In the literature, it is extensively used to study the population dynamics, their interactions and the adaptative behavior of microorganisms [19, 12, 10]. In this vein, we are interested in the dynamics of a structured asexual population (typically bacteria) coupled with a resource in a chemostat. Each individual is characterized by a quantitative trait $x \in \mathbb{R}_{+}$which models a protein density and evolves according to a diffusion of which coefficients depend on the resource. The goal of this work is to show the existence and uniqueness of the solution of the large population dynamics described by the coupled system

[^0]with a given initial condition $\left(u_{0}, R_{0}\right)$. The first two terms on the right side of the parabolic equation in this system are linked to the trait dynamics. The third one models cell division which is accompanied by a fragmentation of the trait according to the operator

where $M(d \alpha)$ is a symmetric probability measure on $] 0,1[$, and the last term represents death. The second equation describes the resource supply and its dilution at the same rate 1 . The last term corresponds to its consumption by the population. The third equation is a no-flux boundary condition which ensures the quantitative variable to remain non negative.

This model extends the well known growth-fragmentation model that has been extensively studied in the literature (see Bertoin et al. [4, 5, 6, 7], or Doumic et al. [13, 15, 21] who investigated the asymptotic properties of the equation without resource, or Campillo and Fritsch [9] for its well posedness and stochastic derivation in a chemostat). Here, we also include the resource dynamics, and introduce a diffusion term that can be seen as an intrinsic noise resulting from very fast synthesis and degradations of the quantitative trait (see [3] for a similar framework). The main difficulty to get a uniqueness result lies in the degeneracy and the dependence in resource of this term. In order to deal with it, we will develop an approach based on the regularity of the individual trait dynamics Markovian semi-group. As it will also depend on the solution, it will be necessary to show some regularity according to this dependence and the state variable. Such an approach has been developed in [16] for a model without resource with Lipschitz continuous diffusion coefficient in the stochastic trait dynamics. Although this coefficient is less regular in our case, we show that it is possible to adapt their method when it does not depend on the resource dynamics. The general situation is more complicated because we are unable to obtain the Lipschitz dependence of the semi-group according to the solution, that holds in the previous case. We will then require more regularity and bounds on the coefficients in order to deal with this dependence thanks to the regularity of its generator.

Further, another major point consists in showing that the weak solution of the diffusion-growth-fragmentation equation is a function, even if the initial condition is a measure. Classically, this point is directly linked to the stochastic dynamics of the individual trait. Then we will first show that at any time, the distribution of the trait admits a density with respect to the Lebesgue measure on $\mathbb{R}_{+}$, and extend the existence of the density to the solution thanks to a mild formulation of the equation. Again, the main difficulty lies in the degeneracy of the diffusion coefficient, but also its weaker regularity (Hölder continuous). Sato \& Ueno [30, Theorem 2.1 and Appendix] showed the existence and regularity of the density in the uniformly elliptic case, and Bouleau \& Hirsch [8, Theorem 2.1.3, p162] showed the existence of the density in the case of Lipschitz continuous coefficients. Here, we adapt a method inspired by Debussche \& Romito [14] that has been developed by Romito [29], which allows us to show that the density exists outside the degeneracy point 0 for time dependent and Hölder continuous diffusion coefficients. It remains to justify that the law of the trait at any time does not charge this very point in order to conclude that the density exists on the entire non-negative real half-line.

The paper is then organized as follows: in Section 2, we show that (1.1) can be derived from an individual based model that describes each intrinsic dynamics and the resource. For that purpose, we propose a Markovian stochastic process that models the trait distribution within the population coupled to the resource dynamics, given a parameter that scales the initial number of individuals. We show that when this scale parameter goes to infinity, the sequence of laws of the processes admits some limiting values which satisfies a weak formulation of (1.1). In Section 3 , we show that the solution of this weak formulation is unique in a certain set of continuous measure valued processes and under suitable assumptions. We distinguish an easier case where the diffusion coefficient does not depend on the resource, and the general case where it does. As described here above, the method we use in those cases are based on the regularity of the
semi-group of the stochastic process that describes the trait dynamics, according to the state variable and the way it depends on the solution. Finally, in Section 4, we show that this solution admits a density at any time with a Besov regularity. To summarize and including the resource dynamics, we prove that the only weak solution of (1.1) belongs to $\mathbb{L}^{\infty}\left((0, T], \mathbb{L}^{1}\left(\mathbb{R}_{+}\right) \times \mathbb{R}\right)$.

Notations For later use, we introduce the following notations :

- $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$is the space of finite measures on $\mathbb{R}_{+}$. It can be endowed with its vague (respectively weak) topology and denoted $\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right), v\right)$ (respectively $\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)\right.$, w)), that is the weakest topology making all maps $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \ni \mu \mapsto \int_{\mathbb{R}_{+}} f(x) \mu(d x)$ continuous for any $f \in \mathcal{C}_{c}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ (respectively $f \in \mathcal{C}_{b}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ ).
- $\mathcal{M}$ is the subspace of $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$constituted of the finite sums of Dirac masses, thus

## 2 The individual-based model and stochastic derivation

In this section, we propose a stochastic individual-based model describing the population dynamics in the chemostat at the individual level with a carrying capacity $K>1$. Our goal is to derive a weak solution of (1.1) from this stochastic model when $K$ goes to infinity.

### 2.1 Description

Let us first introduce a scaling parameter $K>1$ that represents the carrying capacity of the environment. We assume that it is roughtly proportional to the initial number of individuals. The bacterial population is described by a stochastic measure valued process $\left(\nu_{t}^{K}\right)_{t \geq 0}$ with values in $\frac{1}{K} \mathcal{M}$ given at any time by the sum of the Dirac masses at the trait of each living cell so that each individual has the same mass $1 / K$, and the resource is described by a positive continuous process $\left(R_{t}^{K}\right)_{t \geq 0}$ that corresponds to its mass concentration. Let us denote by $V_{t}^{K} \subset \mathcal{J}$ the collection of the living cells at any time $t \geq 0$. Each individual is characterized by a positive trait that evolves during its life-time, and may give birth or die depending on its trait and the availability of the resource as described as follows :

Between jumps, the trait dynamics of an individual $i \in V_{t-}^{K}$ is described by a non negative diffusion process $X^{i, K}$ that satisfies the following stochastic differential equation

during its life-time. The set $\mathcal{W}=\left\{W^{i}, i \in \mathcal{J}\right\}$ is assumed to be a family of independent Brownian motions.

Furthermore, an individual with trait $x \geq 0$ divides at rate $b\left(x, R_{t-}^{K}\right)$ and its trait is split at the same time so that the mother cell stays with a random proportion $\alpha \in] 0,1[$ chosen according to a symmetric probability distribution $M(d \alpha)$, and the daughter starts its life with the remaining proportion $1-\alpha$. Such an individual dies at rate $d(x)$ either by extraction at rate 1 or by natural death. It is then natural to consider that

but we do not need this hypothesis in the sequel.
Finally, the mechanisms of the resource dynamics are well known for the chemostat and consist in a continuous supply of concentration $r_{i n}>0$ and dilution of the resource at rate 1 , and its consumption by the micro-organisms during their life-time. Let us consider that an individual with trait $x \geq 0$ consumes a small amount $\chi\left(x, R_{t}^{K}\right) / K$ of the resource at time $t \geq 0$, then

In order to describe the coupled dynamics of the population and the resource, we introduce a probability space $(\Omega, \mathcal{F}, \mathbb{P})$ so that the initial condition $\left(\nu_{0}^{K}, R_{0}\right)$ is almost surely $\frac{1}{K} \mathcal{M} \times \mathbb{R}_{+}{ }^{-}$ valued for each $K>1$, and independent of the family $\mathcal{W}$. Let us also introduce the independent Poisson point measures $\mathcal{N}_{1}(d \alpha, d z, d i, d s), \mathcal{N}_{2}(d z, d i, d s)$ on $[0,1] \times \mathbb{R}_{+} \times \mathcal{J} \times \mathbb{R}_{+}$and $\mathbb{R}_{+} \times \mathcal{J} \times \mathbb{R}_{+}$ with intensities $M(d \alpha) \eta(d z, d i, d s)$ and $\eta(d z, d i, d s)$ respectively, where

Those Poisson point measures are assumed to be independent of the families $\mathcal{W}$ and $\left\{\nu_{0}^{K}, K>\right.$ $1\}$. We finally introduce the canonical filtration $\left(\mathcal{F}_{t}\right)_{t \geq 0}$ generated by the sequence of initial conditions $\left\{\nu_{0}^{K}, K>1\right\}$, the family of Brownian motions $\mathcal{W}$ and the Poisson point measures $\mathcal{N}_{1}, \mathcal{N}_{2}$. This filtration is assumed to be complete and right continuous.

We are interested in the dynamics of a coupled stochastic process composed of the $\frac{1}{K} \mathcal{M}$ valued process defined by

The first and the second integrals in the first equation correspond to the trait dynamics and follows from the Itô formula applied on (2.1), and the jumps correspond to births and deaths respectively. We refer to $[17,11]$ for the construction of such a process. In the sequel, we denote $\bar{R}=r_{i n} \vee R_{0}$ and make the following assumptions.

## Assumption 2.1.

(A.1) The coefficients $\zeta(x, r), D(x, r), b(x, r), d(x), \chi(x, r)$ are Lipschitz continuous for $x \geq 0$ and $r \in[0, \bar{R}]$.
(A.2) The coefficients $b(x, r), d(x), \chi(x, r)$ are non negative and bounded for $x \geq 0$ and $r \in[0, \bar{R}]$.
(A.3) The coefficient $D(x, r)$ is non negative and

Remark 2.1. The conditions $\zeta(0, r)>0$ and $D(0, r)=0$ ensure that the trait remains positive, since its diffusion coefficient vanishes and its drift is non-negative when it reaches 0 . Similarly, the condition $\chi(x, 0)=0$ is natural and ensures that the process $\left(R_{t}^{K}\right)_{t \geq 0}$ remains positive, since its drift is positive when it reaches 0 . Moreover, it follows from the comparison principle that

The proof is relatively classical and similar to the one obtained in [22, 11, 16, 31]. It is left to the reader.

Remark 2.2. It follows from (2.14) that the quadratic variation of the martingale part of the above Doob-Meyer decomposition satisfies the property

### 2.2 Large population approximation and existence theorem

In this section, we are interested in a large population approximation of the above stochastic model. The main result consists in showing that under suitable assumptions, the sequence of laws of the coupled stochastic dynamics of the population and resource is tight in the set of probability distributions $\mathcal{P}\left(\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, w \otimes|\cdot|\right)\right)\right.$, and the processes in its limiting values are the solutions of (1.1) in the weak sense. Let us make the following assumptions.

## Assumption 2.2.

(A.1) There exists $\varrho>0$ such that the initial conditions $\nu_{0}^{K} \in \frac{1}{K} \mathcal{M}$ satisfy

The main result of this section follows.
Theorem 2.1. Under Assumptions 2.1 and 2.2, the sequence of laws $\left\{\mathcal{Z}^{K}=\mathcal{L}\left(\nu^{K}, R^{K}\right), K>1\right\}$ is tight in the space of probability measures $\mathcal{P}\left(\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, w \otimes||.\right)\right)\right)$ for all $T>0$. In addition, each process $(\nu, R)$ in the support of its limiting values is continuous, satisfies the bound $\sup _{0 \leq t \leq T}\left\langle\nu_{t}, 1\right\rangle<\infty$ and the system

that is a weak formulation of (1.1) with the initial condition $\left(\nu_{0}, R_{0}\right)$.
Remark 2.3. Equation (1.1) has therefore at least one weak solution.
The proof of Theorem 2.1 is relatively classical and uses the techniques developed in $[1,28,11,22$, 17, 16] or [2], Theorem 7.4. It consists in three main steps: a uniform control of trait distribution tails in the population, the tightness of the sequence of laws $\left\{\mathcal{Z}^{K}, K>1\right\}$ and identification of the limit. It is detailed in Appendix A.

## 3 Uniqueness of the solution

In this section, we show that there exists a unique solution of the system (2.16). The main difficulties are the degeneracy of the diffusion coefficient and the non linearity of the drift and diffusion coefficients. Then we will first of all proceed by a decoupling of this system in order to obtain only one non-linear equation on the measure-valued process and establish some important properties of that decoupling. Secondly, we will write a mild formulation of this equation with continuous test functions thanks to the semigroup of the individual trait. Finally, we will use the properties of this semigroup to show in two different cases that the system (2.16) admits a unique solution.

### 3.1 Decoupling and mild formulation of the limit system

Let us start with the following results that ensure us that the limit system (2.16) can be decoupled so that it is equivalent to only one equation that describes the process $\left(\nu_{t}\right)_{t \in[0, T]}$ for the given initial condition ( $\nu_{0}, R_{0}$ ).

Proposition 3.1. If $(\nu, R) \in \mathcal{C}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, w \otimes||.\right)\right)$ is a solution of (2.16), then the process $\left(R_{t}\right)_{t \in[0, T]}$ is completely defined by the measure valued process $\left(\nu_{t}\right)_{t \in[0, T]}$ in the sense that if $\left(\nu_{t}\right)_{t \in[0, T]}$ is given, then $\left(R_{t}\right)_{t \in[0, T]}$ exists and is unique. More precisely, at any time $t \geq 0$ the quantity $R_{t}$ is characterized by the history of the measure valued process $\nu$ until the time $t$.
Proof. Given the process $\left(\nu_{t}\right)_{t \in[0, T]}$, the resource dynamics is described by the equation

We then introduce the following lemma whose proof is left to the reader.

We saw that for this method, the control on the difference $P_{s, t-s}^{\nu^{1}}-P_{s, t-s}^{\nu^{2}}$ given in Lemma 3.5 is very important. However, in the general situation where the diffusion coefficient of the individual trait dynamics depends on the resource we are not able to get such an inequality. In the following section, we suggest another method for this general case that requires more regularity on the coefficients.

### 3.3 The general case of uniqueness

In this section, we show a more complicated uniqueness result for (2.16) in the general case where the diffusion coefficient depends on the resource dynamics. As in the previous section, the method consists in building a solution of an underlying parabolic partial differential equation in order to remove the derivatives of the test function. We need this function to be regular enough. Let us then introduce the new distance on $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$defined by

& \quad=\mathbb{E}_{x, s}\left\{\mathbb{E}_{Y_{\tau_{n}}, \tau_{n}}\left[\phi^{\prime}\left(Y_{t}\right) e^{\int_{\tau_{n}}^{t} \partial_{x} \zeta[\nu]\left(Y_{u}, u\right) d u}\right] e^{\int_{s}^{\tau_{n}} \partial_{x} \zeta[\nu]\left(Y_{u}, u\right) d u} 1_{\left\{\tau_{n}<t\right\}}\right\}
\end{aligned}
$$

and thanks to the strong Markov property,

As $n$ becomes larger and larger, we deduce that $g^{\phi} \in \mathcal{C}\left([0, t] \times \mathbb{R}_{+}, \mathbb{R}\right) \cap \mathcal{C}^{1,2}([0, t) \times(0, \infty), \mathbb{R})$ and is a classical solution of (3.29). Furthermore, it follows from its definition that

Hence for all $(s, x) \in[0, t) \times(0, \infty)$,

Hence the Step 1 here above holds and the Feynman-Kac characterization (3.24) follows so that the solution is independent of the choice of $\theta$. Let us now denote it by $f_{s}^{\phi}(x)$, then

We denote by $f_{s}^{\phi}(x)$ the solution of (3.22) in the previous theorem for $\nu=\nu^{1}$ and the final condition $\phi$. As in (3.26), we regularize this solution by setting

## 4 Existence of a function solution

In this section, we use the mild formulation (3.11) to show that under suitable assumptions the solution of the decoupled equation (3.7) admits a density with respect to the Lebesgue measure. This density will then be the solution of (1.1) in the weak sense given by (2.16). We first make the following general assumptions.

## Assumption 4.1.

(A.1) There exists $\underline{c}>0$ such that for all $(x, r) \in \mathbb{R}_{+} \times(0, \bar{R}]$,

We easily verify that the above assumption (A.2) implies that the decoupled function $D[\nu]$ satisfies the same Hölder property in its time variable. Indeed, it follows from (3.1) that for all $x \geq 0$ and $s, t \in[0, T]$,

As the diffusion coefficient in equation (3.8) is degenerate at $x=0$, we will first verify that there is no atom at this point and secondly show that there is a density on the open set $\mathbb{R}_{+}^{*}$.

Step 1: No atom on the boundary $\{0\}$. Let us first notice that for all $x \geq 0$ and $0 \leq s<T$, it follows from the comparison theorem that $X_{s, t}^{0} \leq X_{s, t}^{x}$ a.s for all $t \in(s, T]$. It then suffices to show that $X_{s, t}^{0}$ does not have an atom at $\{0\}$.
Let us introduce for $h>0$ the convex continuous and non increasing function

Our aim is to show that $\mathbb{P}\left(X_{s, t}^{0}=0\right)=\lim _{h \rightarrow 0} u_{h}(0, s)=0$ for all $s \in[0, t]$. For that purpose, let us first notice that the function $u_{h}$ is convex since its initial condition $\chi_{h}$ is also convex (see [23]). It follows thanks to (A.1) in Assumption 4.1 that

with the same terminal condition $\chi_{h}$. Further, thanks to (A.1) in Assumption 4.1, it follows from the comparison theorem for stochastic differential equations that $Y_{s, t}^{x} \geq Z_{s, t}^{x}$ a.s, where

\sup _{K} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1+x\right\rangle\right]<\infty
$$

That implies thanks to the Fatou Lemma that if $\psi(x)$ is an increasing function with a compact support such that $\psi \equiv 1$ on $[0,1 / 2]$ and $\psi \equiv 0$ on $[1, \infty)$, then for any $n \geq 1$

$$
\begin{aligned}
\int_{0}^{\infty}(1+x) \psi\left(\frac{x}{n}\right) u_{s}(x) d x & \leq \liminf _{K \rightarrow \infty} \mathbb{E}\left[\int_{0}^{\infty}(1+x) \psi\left(\frac{x}{n}\right) \nu_{s}^{K}(d x)\right] \\
& \leq \sup _{K} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1+x\right\rangle\right]<\infty
\end{aligned}
$$

We conclude by taking the supremum on $s \in(0, T]$ after applying the monotone convergence theorem as $n \rightarrow \infty$, that

$$
\sup _{0<s \leq T} \int_{0}^{\infty}(1+x) u_{s}(x) d x<\infty
$$

which ends the proof.

## Appendix

## A Proof of Theorem 2.1

## A. 1 Step 1: Control of tails

Since the individual trait is unbounded, we need to get a control on the measure valued process tails. We then have the following lemma that is adapted from [22].
Lemma A.1. Let $T>0$, if a subsequence of $\left\{\left(\nu_{t}^{K}\right)_{t \geq 0}, K>1\right\}$ converges in law in the Skorohod space $\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right), v\right)\right)$ then its limit $\left(\nu_{t}\right)_{t \in[0, T]}$ satisfies

$$
\begin{equation*}
\mathbb{E}\left\{\sup _{0 \leq t \leq T}\left[\left\langle\nu_{t}, 1\right\rangle^{1+\varrho}\right]\right\}<\infty \tag{A.1}
\end{equation*}
$$

In addition, there exists a decreasing sequence of inscreasing functions $\left(f_{n}\right)_{n \geq 1} \subset \mathcal{C}_{b}^{2}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ such that $f_{n}=0$ on $[0, n / 2]$ and $f_{n}=1$ on $[n, \infty)$, which satisfies

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \limsup _{K \rightarrow \infty} \mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, f_{n}\right\rangle\right\}=0 \tag{A.2}
\end{equation*}
$$

Proof of Lemma A.1. In order to show (A.1), we approximate the functions $x \mapsto 1$ by an increasing sequence of continuous and compact supported functions in order to use the convergence assumption for the vague topology. We then introduce the uniformly bounded sequence of continuous functions defined for $n \in \mathbb{N}^{\star}$ by

$$
\phi_{n}(x)= \begin{cases}1 & \text { if } 0 \leq x<n-1 \\ n-x & \text { if } n-1 \leq x<n \\ 0 & \text { if } x \geq n\end{cases}
$$

that converges increasingly pointwise towards the constant function $x \mapsto 1$. It follows from the Fatou lemma that holds thanks to the convergence of the sequence of measure valued process for the vague topology, that we have for all $n \in \mathbb{N}$

$$
\mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}, \phi_{n}\right\rangle^{1+\varrho}\right\} \leq \liminf _{K \rightarrow \infty} \mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, \phi_{n}\right\rangle^{1+\varrho}\right\} \leq \liminf _{K \rightarrow \infty} \mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1\right\rangle^{1+\varrho}\right\}
$$

As $n \rightarrow \infty$ in this inequality, we obtain by monotony

$$
\mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}, 1\right\rangle^{1+\varrho}\right\} \leq \sup _{K} \mathbb{E}\left\{\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1\right\rangle^{1+\varrho}\right\}<\infty
$$

In order to show (A.2), we approximate the indicator of the outside of the compacts by a nonincreasing and uniformly bounded sequence of regular fonctions. This allows us to control the tails of the distributions $\left\{\mathcal{Z}^{K}, K>1\right\}$. Let us then introduce an increasing function $f \in \mathcal{C}^{2}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ such that $f \equiv 0$ on $[0,1 / 2]$ and $f \equiv 1$ on $[1, \infty)$. We set

$$
\begin{equation*}
f_{n}(x)=f\left(\frac{x}{n}\right), \forall n \geq 1 \tag{A.3}
\end{equation*}
$$

which are indeed in $\mathcal{C}_{b}^{2}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ with uniformly bounded derivatives. It then follows that for all $s \leq t \leq T$

$$
\begin{aligned}
\left\langle\nu_{s}^{K}, f_{n}\right\rangle & \leq\left\langle\nu_{0}^{K}, f_{n}\right\rangle+M_{s}^{K, f_{n}}+\int_{0}^{s} \int_{0}^{\infty}\left\{\zeta\left(x, R_{u}^{K}\right) f_{n}^{\prime}(x)+D\left(x, R_{s}^{K}\right) f_{n}^{\prime \prime}(x)\right\} \nu_{u}^{K}(d x) d u \\
& +2 \int_{0}^{s} \int_{0}^{\infty}\left\{b\left(x, R_{u}^{K}\right) \int_{0}^{1} f_{n}(\alpha x) M(d \alpha)\right\} \nu_{u}^{K}(d x) d u \\
& \leq\left\langle\nu_{0}^{K}, f_{n}\right\rangle+A_{T}^{K, f_{n}}+2\|b\|_{\infty} \int_{0}^{s}\left\langle\nu_{u}^{K}, f_{n}\right\rangle d u+\sup _{0 \leq u \leq T}\left|M_{u}^{K, f_{n}}\right|
\end{aligned}
$$

where

$$
A_{T}^{K, f_{n}}:=C \int_{0}^{T}\left\langle\nu_{u}^{K},(1+x)\left(f_{n}^{\prime}+\left|f_{n}^{\prime \prime}\right|\right)\right\rangle d u
$$

The sequence $\left(A_{T}^{K, f_{n}}\right)_{K>1}$ is uniformly integrable according to $K$ and converges in law towards the random variable $C \int_{0}^{T}\left\langle\nu_{u},(1+x)\left(f_{n}^{\prime}+\left|f_{n}^{\prime \prime}\right|\right)\right\rangle d u$ as $K \rightarrow \infty$ because the function $x \mapsto(1+$ $x)\left(f_{n}^{\prime}+\left|f_{n}^{\prime \prime}\right|\right)(x)$ is continuous with compact support. We have
$\mathbb{E}\left\{\sup _{0 \leq s \leq t}\left\langle\nu_{s}^{K}, f_{n}\right\rangle\right\} \leq \mathbb{E}\left\{\left\langle\nu_{0}^{K}, f_{n}\right\rangle+A_{T}^{K, f_{n}}+\sup _{0 \leq u \leq T}\left|M_{u}^{K, f_{n}}\right|\right\}+2\|b\|_{\infty} \int_{0}^{t} \mathbb{E}\left\{\sup _{0 \leq u \leq s}\left\langle\nu_{u}^{K}, f_{n}\right\rangle\right\} d s$
that induces thanks to Gronwall's lemma that

$$
\mathbb{E}\left\{\sup _{0 \leq s \leq t}\left\langle\nu_{s}^{K}, f_{n}\right\rangle\right\} \leq \mathbb{E}\left\{\left\langle\nu_{0}^{K}, f_{n}\right\rangle+A_{T}^{K, f_{n}}+\sup _{0 \leq u \leq T}\left|M_{u}^{K, f_{n}}\right|\right\} e^{2\|b\|_{\infty} t} .
$$

As $K \rightarrow \infty$, it follows from (2.15) and the Doob inequality that the right term with the martingale converges towards 0 . In addition the remaining terms in the expectation are uniformly integrable and converge in law, then

$$
\begin{aligned}
& \lim _{n \rightarrow \infty} \limsup _{K \rightarrow \infty} \mathbb{E}\left\{\sup _{K \leq s \leq T}\left\langle\nu_{s}^{K}, f_{n}\right\rangle\right\} \\
& \quad \leq e^{2\|b\|_{\infty} T} \lim _{n \rightarrow \infty} \mathbb{E}\left\{\left\langle\nu_{0}, f_{n}\right\rangle+C \int_{0}^{T} \int_{0}^{\infty} \frac{(1+x)}{n}\left(f^{\prime}\left(\frac{x}{n}\right)+\frac{1}{n}\left|f^{\prime \prime}\right|\left(\frac{x}{n}\right)\right) \nu_{u}(d x) d u\right\}=0 .
\end{aligned}
$$

## A. 2 Step 2: Tightness

Given the above Lemma A.1, the tightness of the sequence of laws $\left\{\mathcal{Z}^{K}=\mathcal{L}\left(\nu^{K}, R^{K}\right), K>1\right\}$ follows. It is adapted from [2], Theorem 7.4.

Proposition A.1. The sequence of laws $\left\{\mathcal{Z}^{K}=\mathcal{L}\left(\nu^{K}, R^{K}\right), K>1\right\}$ is tight in the space of probability measures $\mathcal{P}\left(\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, w \otimes||.\right)\right)\right)$ for all $T>0$.

Proof. Let us first endow the measure space $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$with its vague topology and prove the tightness property for the sequence $\left\{\mathcal{Z}^{K}=\mathcal{L}\left(\nu^{K}, R^{K}\right), K>1\right\}$. By noticing that $\mathcal{C}_{c}^{2}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ is a dense subspace of $\mathcal{C}_{0}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ for the topology of uniform convergence on compact sets, it suffices according to [28] to show that for each test function $f \in \mathcal{C}_{c}^{2}\left(\mathbb{R}_{+}, \mathbb{R}\right)$ the sequence of processes $\left\{\left(\left\langle\nu_{t}^{K}, f\right\rangle, R_{t}^{K}\right)_{t \geq 0}, K>1\right\}$ is tight in the Skorohod space $\mathbb{D}\left([0, T], \mathbb{R}^{2}\right)$. First, remember that we have the decomposition

$$
\left\langle\nu_{t}^{K}, f\right\rangle=\left\langle\nu_{0}^{K}, f\right\rangle+V_{t}^{K, f}+M_{t}^{K, f}
$$

and thanks to (2.15),

$$
\lim _{K \rightarrow \infty} \mathbb{E}\left\langle M^{K, f}\right\rangle_{t}=0, \forall t \geq 0
$$

It then directly follows from Doob's inequality that the sequence of martingales $\left\{M^{K, f}, K>1\right\}$ converges in $\mathbb{L}^{2}$ toward 0 locally uniformly in time. This sequence is then tight in the Skorohod space $\mathbb{D}([0, T], \mathbb{R})$, and all we need to prove now is the tightness of the other sequences $\left\{V^{K, f}, K>\right.$ $1\}$ and $\left\{R^{K}, K>1\right\}$. For that purpose, we use the Aldous criterion (see [1]), that consists in showing the uniform controls

$$
\text { (a) } \sup _{K} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left|V_{t}^{K, f}\right|\right]<\infty, \text { (b) } \sup _{K} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left|R_{t}^{K}\right|\right]<\infty
$$

and showing that the Aldous condition holds for $\left(R_{t}^{K}, V_{t}^{K, f}\right)_{t \geq 0}$. The assertions (a) and (b) are immediate. Indeed, $R_{t}^{K} \leq r \vee R_{0}=\bar{R}$ for any $t \geq 0$ and thanks to the boundedness of the test function,

$$
\sup _{0 \leq t \leq T}\left|V_{t}^{K, f}\right| \leq C_{f} \sup _{0 \leq t \leq T}\left[\left\langle\nu_{t}^{K}, 1\right\rangle+\left|M_{t}^{K, f}\right|\right] .
$$

Let us now consider $\varepsilon>0$ and a stopping time $\tau$ that satisfies $\tau+\epsilon \leq T$, then

$$
\begin{aligned}
\mathbb{E}\left(\left|R_{\tau+\varepsilon}^{K}-R_{\tau}^{K}\right|\right) & \leq \mathbb{E}\left(\int_{\tau}^{\tau+\varepsilon}\left|r_{i n}-R_{s}^{K}-\int_{0}^{\infty} \chi\left(x, R_{s}^{K}\right) \nu_{s}^{K}(d x)\right| d s\right) \\
& \leq \varepsilon\left[r_{i n}+\bar{R}+\|\chi\|_{\infty} \mathbb{E}\left(\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1\right\rangle\right)\right] .
\end{aligned}
$$

By a similar computation, we obtain

$$
\mathbb{E}\left(\left|V_{\tau+\varepsilon}^{K, f}-V_{\tau}^{K, f}\right|\right) \leq C(f) \varepsilon \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, 1\right\rangle\right]
$$

that implies the Aldous condition thanks to Lemma 2.1. The sequence of law $\left(\mathcal{Z}^{K}\right)_{K}$ is then tight and by the Prokhorov's theorem one can extract from each sub-sequence, a sub-sub-sequence that converges in $\mathcal{P}\left(\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, v \otimes||.\right)\right)\right)$. Let us denote by $\mathcal{Z}$ a limit value of this sequence, and for simplicity of the notation, $\left(\mathcal{Z}^{K}\right)_{K}$ a sub-sequence that converges towards $\mathcal{Z}$. For each $K>1$ we have

$$
\begin{equation*}
\sup _{0 \leq s \leq T} \sup _{f \in L^{\infty}\left(\mathbb{R}_{+}\right),\|f\|_{\infty} \leq 1}\left|\left\langle\nu_{t}^{K}, f\right\rangle-\left\langle\nu_{t-}^{K}, f\right\rangle\right| \leq 1 / K \tag{A.4}
\end{equation*}
$$

We then deduce from the continuity of the mapping $\mu \mapsto \sup _{0 \leq t \leq T}\left|\left\langle\mu_{t}, f\right\rangle-\left\langle\mu_{t-}, f\right\rangle\right|$ for $f \in$ $\mathcal{C}_{c}\left(\mathcal{E} \times \mathbb{R}_{+}, \mathbb{R}\right)$, that the limiting law $\mathcal{Z}$ only charges the set $\mathcal{C}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, v \otimes|\cdot|\right)\right)$. We are aiming to prove the same result for the weak topology on $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$and this is where the sequence of functions introduced in Lemma A. 1 is usefull.

Let us denote by $(\nu, R)$ a process of law $\mathcal{Z}$, then according to the above argument its trajectories are in the space $\mathcal{C}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, v \otimes||.\right)\right)$. As in [22], it follows from the Fatou lemma that for $n, l \in \mathbb{N}$,

$$
\mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t},\left(1-f_{l}\right) f_{n}\right\rangle\right] \leq \liminf _{K \rightarrow \infty} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K},\left(1-f_{l}\right) f_{n}\right\rangle\right] \leq \limsup _{K \rightarrow \infty} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, f_{n}\right\rangle\right] .
$$

As $l \rightarrow \infty$ it follows from Beppo-Levi's theorem applied to the left term, that

$$
\mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}, f_{n}\right\rangle\right] \leq \limsup _{K \rightarrow \infty} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, f_{n}\right\rangle\right]
$$

and then by the Lemma A.1,

$$
\lim _{n \rightarrow \infty} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}, f_{n}\right\rangle\right] \leq \lim _{n \rightarrow \infty} \limsup _{K \rightarrow \infty} \mathbb{E}\left[\sup _{0 \leq t \leq T}\left\langle\nu_{t}^{K}, f_{n}\right\rangle\right]=0
$$

One can therefore extract a sub-sequence $\left(\sup _{0 \leq t \leq T}\left\langle\nu_{t}, f_{n_{k}}\right\rangle\right)_{k}$ that converges almost surely towards 0 , and then the limit law $\mathcal{Z}$ only charges the $\operatorname{set} \mathcal{C}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, w \otimes||.\right)\right)$. We deduce that the convergence of $\left\{\mathcal{Z}^{K}, K>1\right\}$ towards $\mathcal{Z}$ for the weak topology on $\mathcal{M}_{F}\left(\mathbb{R}_{+}\right)$holds if the sequence of total masses $\left\{\left\langle\nu^{K}, 1\right\rangle, K>1\right\}$ converges in law towards $\langle\nu, 1\rangle$ in the Skorohod space $\mathbb{D}([0, T], \mathbb{R})$ (see $[24])$. So let us consider a Lipschitz continuous function $\Phi: \mathbb{D}([0, T], \mathbb{R}) \rightarrow \mathbb{R}$, and $n \in \mathbb{N}$.

The function $1-f_{n}$ being continuous with a compact support and the sequence $\left\{\nu^{K}, K>1\right\}$ converging in law toward the limit process $\nu$ in $\mathbb{D}\left([0, T],\left(\mathcal{M}_{F}\left(\mathbb{R}_{+}\right) \times \mathbb{R}, v \otimes|\cdot|\right)\right)$, we have

That is enough to conclude that our initial sequence of laws is tight.

## A. 3 Step 3 : Identification of a limiting process

We are here interested in the characterization of a process $\left(\nu_{t}, R_{t}\right)_{t \in[0, T]}$ whose law is a limiting value of the sequence $\left\{\mathcal{Z}^{K}, K>1\right\}$. Given the operator defined in (2.9), we have the following result

Proposition A.2. Let us denote by $\mathcal{Z}$ a limiting value of the sequence of distributions $\left\{\mathcal{Z}^{K}, K>1\right\}$. Then a process $(\nu, R)$ of law $\mathcal{Z}$ satisfies (2.16).

## B. 1 Proof of Lemma B. 1

We split this proof into the several steps.

Existence and uniqueness : According to [20], Theorem 1.1 it suffices to show that we have weak existence and pathwise uniqueness to conclude that there is weak existence and uniqueness, and strong existence. In addition it follows from the previous paragraph that this solution will be well defined at any time. The stochastic differential equation (B.1) is non homogeneous with continuous coefficients, then the coupled process $\left(Z_{u}, u\right)_{u \geq 0}$ satisfies an homogeneous stochastic differential equation with continuous coefficients. We then have weak existence for each initial condition $x \geq 0$ and initial time $s \in[0, T]$ thanks to [20], Theorem 2.3, p173. Furthermore, for $x, y \geq 0$ and $s \leq u \leq T$ we have by hypothesis

We deduce that the stochastic process $\left(\tilde{Z}_{s, t}^{x}\right)_{t \in[s, T]}$ is almost surely non negative at any time, and it is possible to remove the absolute values in (B.6) to conclude by a uniqueness argument that

\left|\Delta_{h}^{m} f(x)-\Delta_{h}^{m} f(y)\right| \leq C_{m}\|f\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}|x-y|^{\alpha}, \forall x, y \in \mathbb{R} . \tag{C.3}
\end{equation*}
$$

3. If $f \in \mathcal{C}^{m}(\mathbb{R}, \mathbb{R})$,

$$
\begin{equation*}
\left\|\Delta_{h}^{m} f\right\|_{\mathbb{L}^{1}} \leq C_{m}|h|^{m}\left\|\partial_{x}^{m} f\right\|_{\mathbb{L}^{1}} \tag{C.4}
\end{equation*}
$$

4. If $f \in \mathcal{C}_{b}(\mathbb{R}, \mathbb{R})$ and $g: \mathbb{R} \rightarrow \mathbb{R}$ is an integrable function, then for all $a \in \mathbb{R}$,

$$
\begin{equation*}
\int_{\mathbb{R}} \Delta_{h}^{m} f(x+a) g(x) d x=\int_{\mathbb{R}} f(x+a) \Delta_{-h}^{m} g(x) d x \tag{C.5}
\end{equation*}
$$

Proof. For $0<\alpha<1, h \in \mathbb{R}$ and an integer $m \geq 1$,

1. If $f \in \mathscr{C}_{b}^{\alpha}(\mathbb{R})$, we proceed by a recurrence argument on $m \geq 1$. Indeed,

$$
\left\|\Delta_{h}^{1} f\right\|_{\infty}=\sup _{x \in \mathbb{R}}|f(x+h)-f(x)| \leq|h|^{\alpha}\|f\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}
$$

and if we assume that the property holds at range $m$, we get

$$
\left\|\Delta_{h}^{m+1} f\right\|_{\infty}=\sup _{x \in \mathbb{R}}\left|\Delta_{h}^{m} f(x+h)-\Delta_{h}^{m} f(x)\right| \leq 2 C_{m}|h|^{\alpha}\|f\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}
$$

that corresponds to the property with $C_{m+1}=2 C_{m}$. We deduce that it holds for each integer $m \geq 1$.
2. If $f \in \mathscr{C}_{b}^{\alpha}(\mathbb{R})$, then thanks to (C.1) we get for all $x, y \in \mathbb{R}$,

$$
\left|\Delta_{h}^{m} f(x)-\Delta_{h}^{m} f(y)\right| \leq \sum_{j=0}^{m}\binom{m}{j}|f(x+j h)-f(y+j h)| \leq 2^{m}\|f\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}|x-y|^{\alpha} .
$$

3. We proceed by a recurrence argument to show firstly that

$$
(\mathbf{P}): \forall m \geq 1, \Delta_{h}^{m} f(x)=h^{m} \int_{0}^{m} H_{m}(t) \partial_{x}^{m} f(x+t h) d t, \text { if } f \in \mathcal{C}^{m}(\mathbb{R}, \mathbb{R})
$$

where $H_{m}$ is bounded and does not depend on $f$. Indeed for $f \in \mathcal{C}^{1}(\mathbb{R}, \mathbb{R})$, then

$$
\Delta_{h}^{m+1} f(x)=f(x+h)-f(x)=\int_{x}^{x+h} f^{\prime}(t) d t=h \int_{0}^{1} f^{\prime}(x+t h) d t
$$

and hence $H_{1}(t)=1$. We now assume that the property holds at range $m$, then if $f \in$ $\mathcal{C}^{m+1}(\mathbb{R}, \mathbb{R})$,

$$
\begin{aligned}
\Delta_{h}^{m+1} f(x) & =\Delta_{h}^{m} f(x+h)-\Delta_{h}^{m} f(x) \\
& =h^{m} \int_{0}^{m} H_{m}(t)\left[\partial_{x}^{m} f(x+(1+t) h)-\partial_{x}^{m} f(x+t h)\right] d t \\
& =h^{m} \int_{0}^{m} H_{m}(t) \int_{x+t h}^{x+(1+t) h} \partial_{x}^{m+1} f(u) d u d t \\
& =h^{m+1} \int_{0}^{m} H_{m}(t) \int_{t}^{1+t} \partial_{x}^{m+1} f(x+u h) d u d t \\
& =h^{m+1} \int_{0}^{m} H_{m}(t) \int_{0}^{m+1} \partial_{x}^{m+1} f(x+u h) 1_{\{u \in[t, 1+t]\}} d u d t \\
& =h^{m+1} \int_{0}^{m+1} \underbrace{\left(\int_{0}^{m} H_{m}(t) 1_{\{u \in[t, 1+t]\}} d t\right)}_{=H_{m+1}(u)} \partial_{x}^{m+1} f(x+u h) d u
\end{aligned}
$$

where the function $H_{m+1}$ is bounded and does not depend on $f$. We deduce that the property $(\mathbf{P})$ holds, and then for all $f \in \mathcal{C}^{m}(\mathbb{R}, \mathbb{R})$,

$$
\left\|\Delta_{h}^{m} f\right\|_{\mathbb{L}^{1}} \leq|h|^{m}\left\|H_{m}\right\|_{\infty} \int_{\mathbb{R}} \int_{0}^{m}\left|\partial_{x}^{m} f(x+t h)\right| d t d x=m\left\|H_{m}\right\|_{\infty}|h|^{m}\left\|\partial_{x}^{m} f\right\|_{\mathbb{L}^{1}}
$$

4. Let $f \in \mathcal{C}_{b}(\mathbb{R}, \mathbb{R})$, and $g: \mathbb{R} \rightarrow \mathbb{R}$ an integrable function and $a \in \mathbb{R}$, then by changing variables in the integral

$$
\begin{aligned}
\int_{\mathbb{R}} \Delta_{h}^{m} f(x+a) g(x) d x & =\sum_{j=0}^{m}(-1)^{m-j}\binom{m}{j} \int_{\mathbb{R}} f(x+a+j h) g(x) d x \\
& =\sum_{j=0}^{m}(-1)^{m-j}\binom{m}{j} \int_{\mathbb{R}} f(x+a) g(x-j h) d x \\
& =\int_{\mathbb{R}} f(x+a) \Delta_{-h}^{m} g(x) d x
\end{aligned}
$$

The difference operator allows to define the Besov spaces $\mathcal{B}_{1, \infty}^{s}(\mathbb{R})$ as the set of function $f: \mathbb{R} \rightarrow \mathbb{R}$ that satisfy for $m>s$

$$
\|f\|_{\mathcal{B}_{1, \infty}^{s}}:=\|f\|_{\mathbb{L}^{1}(\mathbb{R})}+\sup _{|h| \leq 1}|h|^{-s}\left\|\Delta_{h}^{m} f\right\|_{\mathbb{L}^{1}(\mathbb{R})}<\infty
$$

(see Triebel [32] Theorem 2.5.12, or [33] Theorem 2.6.1). The following result follows
Lemma C.2. Let $\left(E, \mathcal{F}_{E}, \mu\right)$ be a measured space where $\mu$ is a positive measure. Let $(x, y) \mapsto$ $f(x, y)$ an integrable function on $\mathbb{R} \times E$, then if we denote by

$$
\Phi_{f}(x)=\int_{E} f(x, y) \mu(d y), \forall x \geq 0
$$

we have for all $s>0$,

$$
\begin{equation*}
\left\|\Phi_{f}\right\|_{\mathcal{B}_{1, \infty}^{s}(\mathbb{R})} \leq \int_{E}\|f(\cdot, y)\|_{\mathcal{B}_{1, \infty}^{s}(\mathbb{R})} \mu(d y) \tag{C.6}
\end{equation*}
$$

Proof. Let $s>0$, then it follows from Fubini theorem that

$$
\|\Phi\|_{\mathbb{L}^{1}(\mathbb{R})}=\int_{\mathbb{R}}\left|\int_{E} f(x, y) \mu(d y)\right| d x \leq \int_{E}\|f(\cdot, y)\|_{\mathbb{L}^{1}(\mathbb{R})} \mu(d y)
$$

Similarly, for any $m>s$ and $h \in[-1,1]$,

$$
\left\|\Delta_{h}^{m} \Phi\right\|_{\mathbb{L}^{1}(\mathbb{R})}=\int_{\mathbb{R}}\left|\int_{E}\left(\Delta_{h}^{m} f(\cdot, y)\right)(x) \mu(d y)\right| d x \leq \int_{E}\left\|\Delta_{h}^{m} f(\cdot, y)\right\|_{\mathbb{L}^{1}(\mathbb{R})} \mu(d y)
$$

The result directly follows by taking the supremum in $h$ and summing the above inequalities.
Furthermore, the above definition of Besov spaces allows a sufficient condition for the existence of a density for random variables given by the following result

Lemma C. 3 ([29], Lemma A.1). Let $X$ be a real valued random variable. If there are an integer $m \geq 1$, a real number $\theta>0$, a real $\alpha>0$, with $\alpha<\theta<m$, and a constant $K>0$ such that for every $\phi \in \mathscr{C}_{b}^{\alpha}(\mathbb{R})$ and $h \in \mathbb{R}$ with $|h| \leq 1$,

$$
\mathbb{E}\left[\Delta_{h}^{m} \phi(X)\right] \leq K|h|^{\theta}\|\phi\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}
$$

then $X$ has a density $f_{X}$ with respect to the Lebesgue measure on $\mathbb{R}$. Moreover $f_{X} \in \mathcal{B}_{1, \infty}^{\theta-\alpha}(\mathbb{R})$ and

$$
\|f\|_{\mathcal{B}_{1, \infty}^{\theta-\alpha}} \lesssim 1+K .
$$

The consequence that follows gives a sufficient condition that will is used in the paper
Lemma C.4. Let $X$ be a real valued random variable. For a given non negative real valued function $\sigma(x)$ such that $\sigma(X) \in \mathbb{L}^{1}$ with $\mathbb{E}[\sigma(X)] \neq 0$, if there exists an integer $m \geq 1$, a real number $\theta>0$, a real $\alpha>0$ with $\alpha<\theta<m$, and a constant $K>0$ such that for every $\phi \in \mathscr{C}_{b}^{\alpha}(\mathbb{R})$ and $h \in \mathbb{R}$ with $|h| \leq 1$,

$$
\begin{equation*}
\mathbb{E}\left[\sigma(X) \Delta_{h}^{m} \phi(X)\right] \leq K|h|^{\theta}\|\phi\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})} \tag{C.7}
\end{equation*}
$$

then $X$ admits a density $f_{X}$ on $\{x: \sigma(x) \neq 0\}$. In addition, if we denote by $f_{X}$ its density on this set, then the function $x \mapsto \sigma(x) f_{X}(x)$ is in the Besov space $\mathcal{B}_{1, \infty}^{\theta-\alpha}(\mathbb{R})$ and satisfies the bound

$$
\begin{equation*}
\left\|\sigma f_{X}\right\|_{\mathcal{B}_{1, \infty}^{\theta-\alpha}(\mathbb{R})} \lesssim K+\mathbb{E}[\sigma(X)] \tag{C.8}
\end{equation*}
$$

Proof. Let us denote by $\mu(d x)$ the law of $X$ and set

$$
\nu(d x)=\sigma(x) \mu(d x)
$$

that is a non negative finite measure by assumption. Then it follows from (C.7) that

$$
\mathbb{E}\left[\sigma(X) \Delta_{h}^{m} \phi(X)\right]=\|\nu\|_{\mathbb{L}^{1}} \int_{0}^{\infty} \Delta_{h}^{m} \phi(x) \frac{\nu(d x)}{\|\nu\|_{\mathbb{L}^{1}}}=\|\nu\|_{\mathbb{L}^{1}} \mathbb{E}\left[\Delta_{h}^{m} \phi(Y)\right]
$$

where $Y$ is a real valued random variable of law $\nu(d y) /\|\nu\|_{\mathbb{L}^{1}}$. It follows from (C.7) that

$$
\mathbb{E}\left[\Delta_{h}^{m} \phi(Y)\right] \leq \frac{K}{\|\nu\|_{\mathbb{L}^{1}}}|h|^{\theta}\|\phi\|_{\mathscr{C}_{b}^{\alpha}(\mathbb{R})}
$$

that implies thanks to Lemma C. 3 that the probability measure $\nu(d y) /\|\nu\|_{\mathbb{L}^{1}}$ admits a density $g_{X} \in \mathcal{B}_{1, \infty}^{\theta-\alpha}(\mathbb{R})$ with respect to the Lebesgue measure on $\mathbb{R}$ that satisies the bound

$$
\left\|g_{X}\right\|_{\mathcal{B}_{1, \infty}^{\theta-\alpha}(\mathbb{R})} \lesssim 1+\frac{K}{\|\nu\|_{\mathbb{L}^{1}}}
$$

Then $\mu(d x)$ admits a density $f_{X}$ on the set $\{x: \sigma(x) \neq 0\}$ that is defined by

$$
f_{X}(x)=\frac{\|\nu\|_{\mathbb{L}^{1}}}{\sigma(x)} g_{X}(x)
$$

and the bound (C.8) follows.

## D $\quad \mathbb{L}^{1}$ estimates of derivatives of the Gaussian density

We are interested in the density of a centered Gaussian random variable with variance $\sigma^{2}$, that is

$$
g_{\sigma}(x)=\frac{1}{\sigma \sqrt{2 \pi}} \exp \left(-\frac{x^{2}}{2 \sigma^{2}}\right), \forall x \in \mathbb{R}
$$

We have the following result
Lemma D.1. For each integer $m \geq 1$,

$$
\left\|\partial_{x}^{m} g_{\sigma}\right\|_{\mathbb{L}^{1}} \leq \frac{C_{m}}{\sigma^{m}}
$$

where the constant $C_{m}$ does not depend on $\sigma$.
Proof. Because of its exponential factor, let us set

$$
\partial_{x}^{m} g_{\sigma}(x)=\frac{P_{m}^{\sigma}(x)}{\sigma^{m}} \frac{1}{\sigma \sqrt{2 \pi}} \exp \left(-\frac{x^{2}}{2 \sigma^{2}}\right), \forall x \in \mathbb{R}, \forall m \geq 1
$$

Then $P_{1}^{\sigma}(x)=-x / \sigma$ and

$$
P_{m+1}^{\sigma}=\sigma \partial_{x} P_{m}^{\sigma}-\frac{x}{\sigma} P_{m}^{\sigma}
$$

that implies that each $P_{m}^{\sigma}$ is a polynomial, thus

$$
P_{m}^{\sigma}(x)=\sum_{k=0}^{m} A_{k}^{m}(\sigma) x^{k}
$$

with

$$
\begin{aligned}
A_{0}^{m+1}(\sigma) & =\sigma A_{1}^{m}(\sigma) \\
A_{k}^{m+1}(\sigma) & =\sigma(k+1) A_{k+1}^{m}(\sigma)-\frac{1}{\sigma} A_{k-1}^{m}(\sigma), k=1, \ldots, m-1 \\
A_{m}^{m+1}(\sigma) & =-\frac{1}{\sigma} A_{m-1}^{m}(\sigma) \\
A_{m+1}^{m+1}(\sigma) & =-\frac{1}{\sigma} A_{m}^{m}(\sigma)
\end{aligned}
$$

We easily verify by a recurrence argument on $m \geq 1$ that

$$
\forall m \geq 1,\left|A_{k}^{m}\right| \leq \frac{C_{m}}{\sigma^{k}} \text { pour } k=1, \ldots, m
$$

and then

$$
\left\|\partial_{x}^{m} g_{\sigma}\right\|_{\mathbb{L}^{1}}=\frac{1}{\sigma^{m}} \int_{\mathbb{R}}\left|P_{m}^{\sigma}(x)\right| g_{\sigma}(x) d x \leq \frac{1}{\sigma^{m}} \sum_{k=0}^{m}\left|A_{k}^{m}(\sigma)\right| \int_{\mathbb{R}}|x|^{k} g_{\sigma}(x) d x \leq \frac{C_{m}}{\sigma^{m}}
$$
