# TORUS LORENZ LINKS OBTAINED BY FULL TWISTS ALONG TORUS LINKS

#### Abstract

All knots are known to be hyperbolic, satellite, or torus knots, and one important family is Lorenz links, or T-links, which arise from dynamics. However, it remains difficult to determine the geometric type of a Lorenz link from a description via dynamics or as a T-link. In this paper, we consider those T-links that are torus links. We show that T-links obtained by full twists along torus links can never be torus links, aside from a family of cases. This addresses a question of Birman and Kofman.


## 1. Introduction

Lorenz links are knotted closed periodic orbits in the flow of the Lorenz system, which is a system of three ordinary differential equations discovered by meteorologist E. N. Lorenz when he was trying to find equations that model weather patterns [12].

Birman and Kofman found that T-links exactly coincide with Lorenz links [1, Theorem 1]. For $2 \leq r_{1}<\cdots<r_{k}$, and all $s_{i}>0$, the T-link $T\left(\left(r_{1}, s_{1}\right), \ldots,\left(r_{k}, s_{k}\right)\right)$ is defined to be the closure of the following braid

$$
\left(\sigma_{1} \sigma_{2} \ldots \sigma_{r_{1}-1}\right)^{s_{1}}\left(\sigma_{1} \sigma_{2} \ldots \sigma_{r_{2}-1}\right)^{s_{2}} \ldots\left(\sigma_{1} \sigma_{2} \ldots \sigma_{r_{k}-1}\right)^{s_{k}}
$$

Here $\sigma_{i}$ is a standard generator of the braid group $B_{r_{k}}$.
Thurston showed that any non-trivial knot in the 3 -sphere is either a torus knot, a satellite knot, or has hyperbolic complement [14]. These are called the geometric types of the knot.

Birman and Kofman asked the following question [1, Question 6].
Question 1.1. When are Lorenz links torus links?
Recall that a torus link is a link that can be embedded on the surface of an unknotted torus $T$ in $S^{3}$. A torus link is denoted by $T(p, q)$ with $p, q$ integers. Here, $p, q$ denote the number of times that $T(p, q)$ wraps around the meridian, longitude, respectively, of $T$. The torus link $T(p, q)$ has $\operatorname{gcd}(p, q)$ link components. Thus, if $\operatorname{gcd}(p, q)=1$, then $T(p, q)$ is a knot.

The purpose of this paper is to answer Question 1.1 for T-links obtained by full twists along $(p, q)$-torus links. The answer to this question was not previously considered in general for this family of T-links. However, as a consequence of Lee's work on the geometric classification of twisted torus knots, it is known when a T-knot of the form $T((r, s r),(p, q))$ is a torus knot
for $p, q$ coprime [8, Theorem 1.1], [10, Theorem 1.1]. Therefore, when the T-link $T\left(\left(a_{1}, a_{1} s_{1}\right), \ldots,\left(a_{n}, a_{n} s_{n}\right),(p, q)\right)$ is a knot we assume that $n>1$.

Our main theorem is the following.
Theorem 1.2. Let $p, q, a_{1}, \ldots, a_{n}, s_{1}, \ldots, s_{n}$ be positive integers such that $1<q<p$ and $1<a_{1}<\cdots<a_{n}<p$ with $a_{i} \neq q$.

- If $\operatorname{gcd}(p, q)>1$, then the T-link

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus link;

- Otherwise, if $q<a_{n}$, or $p \neq b q+1$, or $s_{1}>1$, or $a_{2} \neq a_{1}+1$ for $b>0$, then the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus knot for $n>1$.
Therefore, Theorem 1.2 answers Question 1.1 for T-links obtained by full twists along $(p, q)$-torus links, aside from a family of cases.

The answer to Question 1.1 is also related to the geometric classification of T-links. The geometric classification of T-links started with the study of the geometric classification of twisted torus knots. The twisted torus knots that are T-knots have the form $T((r, s r),(p, q))$ for $p, q$ coprime. See [2], [8], [10], [9], and [11] for more information about the geometric classification of twisted torus knots. Recently Thiago de Paiva and Jessica Purcell extended these results to general T-knots obtained by full twists along $(p, q)$-torus knots [5], [6]. More precisely, they proved that there exists $B \gg 0$ such that if each $s_{i}>B$, the T-knot $T\left(\left(a_{1}, a_{1} s_{1}\right), \ldots,\left(a_{n}, a_{n} s_{n}\right),(p, q)\right)$ is hyperbolic if and only if there is at least one $a_{i}>q$ that is not a multiple of $q[5]$. But, they didn't make $B$ explicit. However, Theorem 1.2 will help to find this $B$ as they are either hyperbolic or satellite knots if they are not torus knots.

## 2. Main section

In this section we prove Theorem 1.2. We start by proving some lemmas that will be used later to prove this theorem.

Due to [6, Lemma 2.7], we assume that $a_{1}, \ldots, a_{n}$ are different from $q$ for the T-link $T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)$.
Lemma 2.1. Consider $q<a_{n}$. Then, there is an ambient isotopy that takes the T-link

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

to an equivalent link given by the closure of the braid

$$
\begin{aligned}
& \left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{p-a_{n}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n-1}-1}\right)^{s_{n-1} a_{n-1}} \\
& \left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}+q}
\end{aligned}
$$



Figure 1. The red strand in the second drawing can be replaced by a strand that goes below the third strand, as illustrated in the third drawing. This isopoty generalizes the isopoty in Figure 6 of [10].
where this isotopy happens in the complement of the braid axis of the last braid. Furthermore, $K$ has braid index equal to $a_{n}$.

Proof. We start with the standard braid of $K$ :

$$
\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}}\left(\sigma_{1} \ldots \sigma_{p-1}\right)^{q}
$$

If we pull the $\left(a_{n}-q+1\right)$-st strand around the braid closure anticlockwise, we see that it first reaches the bottom of the braid then passes through the sub-braid $\left(\sigma_{1} \ldots \sigma_{p-1}\right)^{q}$ and finally ends in the $\left(a_{n}+1\right)$-st strand as $q<a_{n}$. So the $\left(a_{n}-q+1\right)$-st strand is connected to the $\left(a_{n}+1\right)$-st strand by a strand that goes one time around the braid closure. See the red strand in Figure 1. As this strand is an under strand, we can push it down and shrink it to reduce one strand from the last braid, as shown in Figure 1. After that, this strand becomes an under strand between the $\left(a_{n}-q+1\right)$ and the $\left(a_{n}+1\right)$-st strand. Thus, we obtain the braid

$$
B=\left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}}\left(\sigma_{1} \ldots \sigma_{p-2}\right)^{q}
$$

after this isopoty.
As the sub-braid $\left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)$ of $B$ is a braid on the leftmost $a_{n}$ strands, the $\left(a_{n}-q+1\right)$-st strand is still connected to the $\left(a_{n}+1\right)$-st strand of $B$ by an under strand that goes one time around the braid closure. Then we can apply the last isopoty again. After that, we obtain the braid

$$
\left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{2}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}}\left(\sigma_{1} \ldots \sigma_{p-3}\right)^{q}
$$

Therefore, after repeating this procedure $p-a_{n}-2$ more times, we finally obtain the braid

$$
\begin{aligned}
& \left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{p-a_{n}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n-1}-1}\right)^{s_{n-1} a_{n-1}} \\
& \left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}+q} .
\end{aligned}
$$

As $s_{n} a_{n}+q>a_{n}$, the last braid has at least one full twist on the $a_{n}$ strands. So, it follows from [7, Corollary 2.4] that the link $K$ has braid index equal to $a_{n}$.
Lemma 2.2. Consider $a_{n}<q<p$. Then, the T-link

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

has braid index equal to $q$ and is equivalent to the T-link

$$
K^{\prime}=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(q, p)\right)
$$

Proof. As $a_{n}<q<p$, the T-link $K$ is equivalent to $K^{\prime}$ [1, Corollary 3]. Since $p>q, K^{\prime}$ has braid index equal to $q$ by [7, Corollary 2.4].

The next lemma was proved by Los [13, Corollary 1.2]. See also [3] for a quick proof sketch using the Markov theorem.
Lemma 2.3. Consider $\beta_{1}, \beta_{2}$ two braids which have minimal braid index and are representations of the same torus link. Suppose that these two closed braids travel around the same braid axis C. Then, there is an isotopy in the complement of $C$ that takes $\beta_{1}$ to $\beta_{2}$.
Lemma 2.4. Consider $q<a_{n}<p$. Then, the T-link

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is not a torus link.
Proof. We prove this lemma by induction.
For when $n=1$, consider that $K=T\left(\left(a_{1}, s_{1} a_{1}\right),(p, q)\right)$ is a torus link. By Lemma 2.1, $K$ is equivalent to the link given by the closure of the braid

$$
B_{1}=\left(\sigma_{a_{1}-1} \ldots \sigma_{a_{1}-q+1}\right)^{p-a_{1}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}+q}
$$

and has braid index equal to $a_{1}$. So, $K$ is the ( $a_{1}, k$ )-torus link with $k>0$.
By Lemma 2.3, the link $K_{2}$ given by the closure of the braid

$$
B_{2}=B_{1}\left(\sigma_{a_{1}-1}^{-1} \ldots \sigma_{1}^{-1}\right)^{s_{1} a_{1}}=\left(\sigma_{a_{1}-1} \ldots \sigma_{a_{1}-q+1}\right)^{p-a_{1}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{q}
$$

is the $\left(a_{1}, k-s_{1} a_{1}\right)$-torus link. The braid $B_{2}$ represents the $(p, q)$-torus link. Thus, $a_{1}$ is equal to $p$ or $q$, which is a contradiction.

Now we can consider that all T-links $T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{i}, s_{i} a_{i}\right),(p, q)\right)$ with $q<a_{i}$ are not torus links for $i<n$.

Suppose that $K=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)$ is a torus link. By Lemma 2.1, $K$ is equivalent to the link given by the closure of the braid

$$
\begin{aligned}
& \left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{p-a_{n}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n-1}-1}\right)^{s_{n-1} a_{n-1}} \\
& \left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{s_{n} a_{n}+q}
\end{aligned}
$$

and has braid index equal to $a_{n}$. So, $K$ is the $\left(a_{n}, k\right)$-torus link with $k>0$. By Lemma 2.3, the link $K_{1}$ given by the closure of the braid

$$
\begin{aligned}
& B_{1}=\left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{p-a_{n}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n-1}-1}\right)^{s_{n-1} a_{n-1}} \\
& \left(\sigma_{1} \ldots \sigma_{a_{n}-1}\right)^{q}
\end{aligned}
$$

is the $\left(a_{n}, k-s_{n} a_{n}\right)$-torus link. Since the last isopoty happened in the complement of the braid axis of the last braid, we can apply the isopoty of Lemma 2.1 in the backward direction to see that $K_{1}$ is the T-link $T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n-1}, s_{n-1} a_{n-1}\right),(p, q)\right)$.

Suppose that $q>a_{n-1}$. Then, by Lemma $2.2, K_{1}$ has braid index equal to $q$. So, $k-s_{n} a_{n}=q$. This implies that the sub-braid

$$
\left(\sigma_{a_{n}-1} \ldots \sigma_{a_{n}-q+1}\right)^{p-a_{n}}\left(\sigma_{1} \ldots \sigma_{a_{1}-1}\right)^{s_{1} a_{1}} \ldots\left(\sigma_{1} \ldots \sigma_{a_{n-1}-1}\right)^{s_{n-1} a_{n-1}}
$$

of $B_{1}$ is the trivial braid as $K_{1}$ is the torus $\operatorname{link} T\left(a_{n}, q\right)$, but this is impossible as $a_{n-1}, \ldots, a_{1}>1$. Thus, $q<a_{n-1}$. However, this contradicts the induction hypothesis.

Therefore, $K$ is never a torus link.
Lemma 2.5. Consider $n>1$. If $s_{1}>1$ or $a_{2} \neq a_{1}+1$, then the $T$-knot

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, b p+1)\right)
$$

is not a torus knot for $b>0$.
Proof. Since $p, b p+1$ are coprime, $K$ is a knot.
Consider that $K$ is a torus knot. By [7, Corollary 2.4], $K$ has braid index equal to $p$. By Lemma 2.3, the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, 1)\right)
$$

is also a torus knot. By a Markov move, the last T-knot is equivalent to the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}+1\right)\right) .
$$

By [7, Corollary 2.4], this T-knot has braid index equal to $a_{n}$. Then, the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n-1}, s_{n-1} a_{n-1}\right),\left(a_{n}, 1\right)\right)
$$

which is equivalent to the T-knot, by a Markov move,

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n-1}, s_{n-1} a_{n-1}+1\right)\right)
$$

is also a torus knot. Continuing with this argument, we obtain that the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}+1\right)\right)
$$

which is equivalent to the T - $\operatorname{knot} T\left(\left(a_{1}, s_{1} a_{1}\right),\left(s_{2} a_{2}+1, a_{2}\right)\right)$ by Lemma 2.2, is also a torus knot, but this is a contradiction by [8, Theorem 1.1] and [10, Theorem 1.1].

Lemma 2.6. Let $a_{n}<q<p$. Assume $n>1$ when $p$ and $q$ are coprime. If $p \neq b q+1$, or $s_{1}>1$, or $a_{2} \neq a_{1}+1$ for $b>0$, then the T-link

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is not a torus link.
Proof. As $a_{n}<q<p$, the T-link

$$
K^{\prime}=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(q, p)\right)
$$

is equivalent to $K$ and has braid index equal to $q$ by Lemma 2.2.
Suppose that $K$ is a torus link. Then, $K$ is the $(q, k)$-torus link with $k>0$. Let $r$ be a positive integer such that $0 \leq p-r q<q$. The T-link

$$
K_{-r q}^{\prime}=T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(q, p-r q)\right)
$$

is the torus link $T(q, k-r q)$ by Lemma 2.3.
If $p-r q=0$, then $K_{-r q}^{\prime}$ would be a splittable link. But, by Lemma 3.2 of [4], torus links are irreducible. So, $K_{-r q}^{\prime}$ can't be a torus link, which is a contradiction.

If $p-r q=1$, then $K^{\prime}$ is a knot. However, by Lemma $2.5, K^{\prime}$ can't be a torus knot.

Thus, $p-r q>1$. It is not possible that $a_{n}>p-r q$ by Lemma 2.4. So, $a_{n} \leq p-r q$. If $a_{n}=p-r q$, then, by [6, Lemma 2.7], $K_{-r q}^{\prime}$ is equivalent to the T-link

$$
T\left(\left(a_{1}, s_{1} a_{1}\right), \ldots,\left(a_{n-1}, s_{n-1} a_{n-1}\right),\left(a_{n}, s_{n} a_{n}+q\right)\right),
$$

which has braid index equal to $a_{n}$ by Lemma 2.2. Thus, $a_{n}=k-r q$ as $a_{n} \neq q$. This implies that $k=a_{n}+r q=p$. Hence, $a_{1}, \ldots, a_{n}=0$ as $K$ is the $(p, q)$-torus knot. This is a contradiction. If $a_{n}<p-r q$, then $K_{-r q}^{\prime}$ has braid index equal to $p-r q$ by Lemma 2.2. So, $p-r q=q$ or $k-r q$. It is not possible that $p-r q=q$ since $0 \leq p-r q<q$. If $p-r q=k-r q$, then $k=p$, which we have already ruled out.

Therefore, $K$ is not a torus link.
Proposition 2.7. Let $p, q, a_{1}, \ldots, a_{n}, s_{1}, \ldots, s_{n}$ be positive integers such that $1<q<p, \operatorname{gcd}(p, q)>1$, and $1<a_{1}<\cdots<a_{n}<p$ with $a_{i} \neq q$. Then, the $T$-link

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus link.
Proof. If $q<a_{n}$, then $K$ is not a torus link by Lemma 2.4.
Consider now that $a_{n}<q$. It is not possible that $p=b q+1$ for $b>0$ otherwise $p$ and $q$ would be coprime. Thus, from Lemma $2.6, K$ is not a torus link.

Proposition 2.8. Let $p, q, a_{1}, \ldots, a_{n}, s_{1}, \ldots, s_{n}$ be positive integers such that $1<q<p, \operatorname{gcd}(p, q)=1$, and $1<a_{1}<\cdots<a_{n}<p$ with $a_{i} \neq q$ and $n>1$. If $q<a_{n}$, or $p \neq b q+1$, or $s_{1}>1$, or $a_{2} \neq a_{1}+1$ for $b>0$, then the $T$-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus knot.
Proof. If $q<a_{n}$, then it follows from Lemma 2.4 that $K$ is not a torus knot. If $a_{n}<q$, under the hypotheses, $K$ is not a torus knot from Lemma 2.6 either.

Theorem 1.2. Let $p, q, a_{1}, \ldots, a_{n}, s_{1}, \ldots, s_{n}$ be positive integers such that $1<q<p$ and $1<a_{1}<\cdots<a_{n}<p$ with $a_{i} \neq q$.

- If $\operatorname{gcd}(p, q)>1$, then the T-link

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus link;

- Otherwise, if $q<a_{n}$, or $p \neq b q+1$, or $s_{1}>1$, or $a_{2} \neq a_{1}+1$ for $b>0$, then the T-knot

$$
T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is never a torus knot for $n>1$.
Proof. It follows from Propositions 2.7 and 2.8.
Corollary 2.9. Let $p, q, a_{1}, \ldots, a_{n}, s_{1}, \ldots, s_{n}$ be positive integers such that $1<q<p, \operatorname{gcd}(p, q)=1$, and $1<a_{1}<\cdots<a_{n}<p$ with $a_{i} \neq q$. If each $s_{i}$ is greater than one, then the $T$-knot

$$
K=T\left(\left(a_{1}, s_{1} a_{1}\right),\left(a_{2}, s_{2} a_{2}\right), \ldots,\left(a_{n}, s_{n} a_{n}\right),(p, q)\right)
$$

is not a torus knot.
Proof. If $n=1$, then the T-knot $K$ is not a torus knot by [[8], Theorem 1.1]. Otherwise, the T-knot $K$ is not a torus knot by Theorem 1.2.
