# IRREDUCIBILITY OF THE ZERO POLYNOMIALS OF EISENSTEIN SERIES 

OSCAR E. GONZÁLEZ


#### Abstract

Let $E_{k}$ be the normalized Eisenstein series of weight $k$ on $\mathrm{SL}_{2}(\mathbb{Z})$. Let $\varphi_{k}$ be the polynomial that encodes the $j$-invariants of non-elliptic zeros of $E_{k}$. In 2001, Gekeler observed that the polynomials $\varphi_{k}$ seem to be irreducible (and verified this claim for $k \leq 446$ ). We show that $\varphi_{k}$ is irreducible for infinitely many $k$.


## 1. Introduction

Let $E_{k}$ be the Eisenstein series of even weight $k \geq 2$ on $\mathrm{SL}_{2}(\mathbb{Z})$ given by

E_{k}(z):=1-\frac{2 k}{B_{k}} \sum_{n=1}^{\infty} \sigma_{k-1}(n) e^{2 \pi i n z} \tag{1}
\end{equation*}
$$

and $\Delta:=\frac{1}{1728}\left(E_{4}^{3}-E_{6}^{2}\right)$. Let $j:=\frac{E_{4}^{3}}{\Delta}$ and define the polynomial $\varphi_{k}(X)$ by

\varphi_{k}(X):=\prod_{\substack{E_{k}(z)=0 \\ j(z) \neq 0,1728}}(X-j(z)) \tag{2}
\end{equation*}
$$

For example, $\varphi_{16}(X)=X-\frac{3456000}{3617}$ and $\varphi_{24}(X)=X^{2}-\frac{340364160000}{236364091} X+\frac{30710845440000}{236364091}$. Gekeler observed that the polynomials $\varphi_{k}$ seem to be irreducible, and verified this claim for $k \leq 446$ ( Gek01]). Here we show that the polynomials $\varphi_{k}$ are irreducible for infinitely many $k$. More precisely, we have the following theorem.
Theorem 1. Let $\varphi_{k}$ be as in (2). Then $\varphi_{12 \cdot 2^{\ell}}$ is irreducible for any $\ell \in \mathbb{N} \cup\{0\}$.
Our method employs Dumas' irreducibility criterion and a recurrence for the Eisenstein series $G_{k}$ due to Popa Pop11.

## 2. Preliminaries

Let $G_{k}:=2 \zeta(k) E_{k}$ where $\zeta(k):=\sum_{n=1}^{\infty} \frac{1}{n^{k}}$. For $k \geq 2$ write

G_{k}=\sum_{4 a+6 b=k} w_{a, k} G_{4}^{a} G_{6}^{b} \tag{3}
\end{equation*}
$$

where $w_{a, k} \in \mathbb{Q}$. We have the following recurrence for $G_{k}$.
Proposition 2. We have

c_{k} d_{k} G_{k}= & \sum_{\substack{j=3 \\
j \text { odd }}}^{k / 2-2}\left(\binom{k / 2}{j}+\binom{k / 2-2}{j}\right) d_{j+1} d_{k-j-1} G_{j+1} G_{k-j-1} \\
& \quad+(k-2) d_{2} d_{k-2} G_{2} G_{k-2}+\frac{\pi^{2} d_{k-2}}{2} G_{k-2}^{\prime}+\frac{k}{2} d_{k / 2}^{2} G_{k / 2}^{2} \tag{4}
\end{align*}
$$

where

$$
\begin{gather*}
f^{\prime}:=\frac{1}{2 \pi i} \frac{d f}{d z}, \\
c_{k}=\frac{k}{2(k / 2+1)(k / 2-1)}+(-1)^{k / 2} \frac{(k / 2)!(k / 2-2)!}{2(k-1)!}, \tag{5}
\end{gather*}
$$

and

$$
\begin{equation*}
d_{k}=\frac{(-1)^{k / 2}(k-1)!}{2^{k+1}} \tag{6}
\end{equation*}
$$

Proof. This follows after some computation from equation (A.3) in Pop11 with $m=k / 2$, $\tilde{m}=k / 2-2$, and $w=k-2$.

Remark. The Eisenstein series $\widetilde{G_{k}}$ in Pop11 are normalized so that the coefficient of $q$ in their Fourier expansion equals 1. This differs from our $G_{k}$ by a factor of $\pi^{k} / d_{k}$, so that $G_{k}=\frac{\pi^{k}}{d_{k}} \widetilde{G_{k}}$. The identity in Proposition 2 is equivalent (via Rankin's identity) to the Eichler-Shimura relations for odd periods of cusp forms and $G_{k}$.

The following proposition allows us to relate $w_{a, k}$ to the coefficients of $\varphi_{k}$.
Proposition $3([$ Gek01], (1.17.1)). For $k \equiv 0(\bmod 12)$ we have

2 \zeta(k) \varphi_{k}(j)=\frac{G_{k}}{\Delta^{\frac{k}{12}}} .
$$

Let $\nu_{p}(m)$ be the highest power of the prime $p$ that divides a non-zero integer $m$. Extend this definition to $\mathbb{Q}$ by defining $\nu_{p}(a / b):=\nu_{p}(a)-\nu_{p}(b)$ and $\nu_{p}(0)=\infty$. We will use the following criterion of Dumas.

Proposition 4 ([JK17, Corollary 1.3]). Let $F(x)=x^{n}+a_{n-1} x^{n-1}+\cdots+a_{0}$ be a monic polynomial with coefficients in $\mathbb{Q}$. If there exists a prime $p$ satisfying
(i) $\frac{\nu_{p}\left(a_{r}\right)}{n-r} \geq \frac{\nu_{p}\left(a_{0}\right)}{n}$ for $0 \leq r \leq n-1$, and
(ii) $\left(\nu_{p}\left(a_{0}\right), n\right)=1$,
then $F(x)$ is irreducible over $\mathbb{Q}$.

## 3. Divisibility results

In this section we prove results about the divisibility of certain binomial coefficients which will be needed in the proof of Theorem 1 .

Lemma 5. For any even $k \geq 4$ we have

$$
\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right)= \begin{cases}1 & \text { if } k+2=2^{\ell} \text { for some } \ell \geq 3 \\ 0 & \text { otherwise }\end{cases}
$$

Proof. By Lucas' theorem (see, for example, [Fin47, Thm. 1]) we have

$$
\binom{k}{k / 2-1} \equiv\left\{\begin{array}{lll}
1 & (\bmod 2) \\
0 & (\bmod 2)
\end{array} \quad \begin{array}{l}
\text { if } k+2=2^{\ell} \text { for some } \ell \geq 3 \\
\text { otherwise }
\end{array}\right.
$$

When $k+2=2^{\ell}$ with $\ell \geq 3$ we see from Gra97, Theorem 1] that $\binom{k}{k / 2-1} \equiv 3(\bmod 4)$. Then, $(-1)^{k / 2}+\binom{k}{k / 2-1} \equiv 2(\bmod 4)$ and the result follows.

Lemma 6. Let $c_{k}$ and $d_{k}$ be as in (5) and (6), respectively. Then, for any even $k \geq 4$ and any $j \leq k / 2-2$ the following inequalities hold:

\nu_{2}\left(\frac{d_{k-2}}{2 c_{k} d_{k}}\right) \geq 1  \tag{7}\\
\nu_{2}\left(\frac{k d_{k / 2}^{2}}{2 c_{k} d_{k}}\right)
\end{gathered} \geq 0,1 \begin{gathered}
 \tag{8}\\
\nu_{2}\left(\left(\binom{k / 2}{j}+\binom{k / 2-2}{j}\right) \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) \geq 0 \tag{9}
\end{gather*}
$$

Proof. Recall that for any $m \in \mathbb{N}$ we have

$$
\begin{equation*}
\nu_{2}(m!)=m-s_{2}(m) \tag{10}
\end{equation*}
$$

where $s_{2}(m)$ is the sum of the digits of $m$ in base 2 . We begin by rewriting $\frac{d_{k-2}}{2 c_{k} d_{k}}$ as

$$
\frac{d_{k-2}}{2 c_{k} d_{k}}=\frac{-2(k-2)!}{(k / 2-1)!(k / 2)!\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right)}
$$

Using (10) and Lemma 5 we see that

$$
\begin{aligned}
\nu_{2}\left(\frac{d_{k-2}}{2 c_{k} d_{k}}\right) & =1+\nu_{2}((k-2)!)-\nu_{2}((k / 2-1)!)-\nu_{2}((k / 2)!)-\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right) \\
& =s_{2}(k / 2)-\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right) \\
& = \begin{cases}s_{2}(k / 2)-1 & \text { if } k+2=2^{\ell}, \\
s_{2}(k / 2) & \text { otherwise. }\end{cases}
\end{aligned}
$$

Clearly $s_{2}(k / 2) \geq 1$, so we only need to consider the case when $k+2=2^{\ell}$. Since in this case $s_{2}(k / 2)=s_{2}\left(2^{\ell-1}-1\right) \geq 2$, we conclude that $\nu_{2}\left(\frac{d_{k-2}}{2 c_{k} d_{k}}\right) \geq 1$, proving (77).

To show (8), we start by rewriting $\frac{k d_{k / 2}^{2}}{2 c_{k} d_{k}}$ as

$$
\frac{k d_{k / 2}^{2}}{2 c_{k} d_{k}}=\frac{(k / 2-1)}{(-1)^{k / 2}+\binom{k}{k / 2-1}} .
$$

From this we see that

$$
\begin{aligned}
\nu_{2}\left(\frac{k d_{k / 2}^{2}}{2 c_{k} d_{k}}\right) & =\nu_{2}(k / 2-1)-\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right) \\
& = \begin{cases}\nu_{2}(k / 2-1)-1 & \text { if } k+2=2^{\ell}, \\
\nu_{2}(k / 2-1) & \text { otherwise. }\end{cases}
\end{aligned}
$$

When $k+2=2^{\ell}$ we have $\nu_{2}(k / 2-1)=\nu_{2}\left(2^{\ell-1}-2\right)=1$. Thus, $\nu_{2}\left(\frac{d_{k-2}}{2 c_{k} d_{k}}\right) \geq 0$.

Finally, to prove (19) we work with $\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}$ and $\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}$ separately. First, rewrite $\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}$ as

$$
\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}=\frac{\binom{k-j-2}{k / 2-2}}{(-1)^{k / 2}+\binom{k}{k / 2-1}} .
$$

Then,

$$
\begin{aligned}
\nu_{2}\left(\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) & =\nu_{2}\left(\binom{k-j-2}{k / 2-2}\right)-\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right) \\
& = \begin{cases}\nu_{2}\left(\binom{k-j-2}{k / 2-2}\right)-1 & \text { if } k+2=2^{\ell}, \\
\nu_{2}\left(\binom{k-j-2}{k / 2-2}\right) & \text { otherwise. }\end{cases}
\end{aligned}
$$

When $k+2=2^{\ell}$ we can use Lucas' theorem to obtain

$$
\binom{k-j-2}{k / 2-2}=\binom{2^{\ell}-j-4}{2^{\ell-1}-3} \equiv\left\{\begin{array}{lll}
0 & (\bmod 2) & \text { if } j<k / 2-2 \\
1 & (\bmod 2) & \text { if } j=k / 2-2
\end{array}\right.
$$

Therefore, when $k+2=2^{\ell}$ and $j<k / 2-2$ we have $\nu_{2}\left(\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) \geq 0$ and when $j=k / 2-2$ we have $\nu_{2}\left(\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right)=-1$. We will see below that in the case $j=k / 2-2$ we have $\nu_{2}\left(\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right)=-1$, so that $\nu_{2}\left(\left(\binom{k / 2}{j}+\binom{k / 2-2}{j}\right) \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) \geq 0$.

Now we calculate $\nu_{2}\left(\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right)$. We start by rewriting $\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}$ as

$$
\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}=\frac{\binom{k-j-2}{k / 2}}{(-1)^{k / 2}+\binom{k}{k / 2-1}} .
$$

Thus,

$$
\begin{aligned}
\nu_{2}\left(\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) & =\nu_{2}\left(\binom{k-j-2}{k / 2}\right)-\nu_{2}\left((-1)^{k / 2}+\binom{k}{k / 2-1}\right) \\
& = \begin{cases}\nu_{2}\left(\binom{k-j-2}{k / 2}\right)-1 & \text { if } k+2=2^{\ell}, \\
\nu_{2}\left(\binom{k-j-2}{k / 2}\right) & \text { otherwise. }\end{cases}
\end{aligned}
$$

When $k+2=2^{\ell}$ we have

$$
\binom{k-j-2}{k / 2}=\binom{2^{\ell}-j-4}{2^{\ell-1}-1} \equiv\left\{\begin{array}{lll}
0 & (\bmod 2) & \text { if } j<k / 2-2 \\
1 & (\bmod 2) & \text { if } j=k / 2-2
\end{array}\right.
$$

Therefore, when $k+2=2^{\ell}$ and $j<k / 2-2$ we have $\nu_{2}\left(\binom{k / 2-2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right) \geq 0$ and when $j=k / 2-2$ we have $\nu_{2}\left(\binom{k / 2}{j} \frac{d_{j+1} d_{k-j-1}}{c_{k} d_{k}}\right)=-1$.

## 4. Proof of Theorem 1

We start by showing that $\min _{a}\left(\nu_{2}\left(w_{a, k}\right)\right) \geq 0$ for all even $k$.
Theorem 7. Let $w_{a, k}$ be as in (3) and let $k \geq 4$ be an even integer. Then $\min _{a}\left(\nu_{2}\left(w_{a, k}\right)\right) \geq 0$.
Proof. By induction. The base case is clear. Suppose that r is even and that $\min _{a}\left(\nu_{2}\left(w_{a, k}\right)\right) \geq$ 0 for all even $k \leq r-2$. We will show that $\min _{a}\left(\nu_{2}\left(w_{a, r}\right)\right) \geq 0$. From (4) we have

$$
\begin{aligned}
G_{r}=\sum_{\substack{j=3 \\
j \text { odd }}}^{r / 2-2}\left(\binom{r / 2}{j}+\binom{r / 2-2}{j}\right) & \frac{d_{j+1} d_{r-j-1}}{c_{r} d_{r}} G_{j+1} G_{r-j-1} \\
& +(r-2) \frac{d_{2} d_{r-2}}{c_{r} d_{r}} G_{2} G_{r-2}+\frac{\pi^{2} d_{r-2}}{2 c_{r} d_{r}} G_{r-2}^{\prime}+\frac{r d_{r / 2}^{2}}{2 c_{r} d_{r}} G_{r / 2}^{2} .
\end{aligned}
$$

Note that $\pi^{2} G_{4}^{\prime}=G_{2} G_{4}-\frac{7}{2} G_{6}$ and $\pi^{2} G_{6}^{\prime}=\frac{3}{2} G_{2} G_{6}-\frac{15}{7} G_{4}^{2}$. From (3) we see that $G_{r-2}=$ $\sum_{4 a+6 b=r-2} w_{a, r-2} G_{4}^{a} G_{6}^{b}$. Since $\left(G_{4}^{a} G_{6}^{b}\right)^{\prime}=a G_{4}^{a-1} G_{6}^{b} G_{4}^{\prime}+b G_{4}^{a} G_{6}^{b-1} G_{6}^{\prime}$ and $d_{2}=-1 / 8$ we have

$$
\begin{aligned}
& (r-2) \frac{d_{2} d_{r-2}}{c_{r} d_{r}} G_{2} G_{r-2}+\frac{\pi^{2} d_{r-2}}{2 c_{r} d_{r}} G_{r-2}^{\prime} \\
& =\frac{d_{r-2}}{2 c_{r} d_{r}} \sum_{4 a+6 b=r-2} w_{a, r-2}\left(G_{2} G_{4}^{a} G_{6}^{b}\left(2 d_{2}(r-2)+a+\frac{3 b}{2}\right)-\frac{7 a}{2} G_{4}^{a-1} G_{6}^{b+1}-\frac{15 b}{7} G_{4}^{a+2} G_{6}^{b-1}\right) \\
& =-\frac{d_{r-2}}{2 c_{r} d_{r}} \sum_{4 a+6 b=r-2} w_{a, r-2}\left(\frac{7 a}{2} G_{4}^{a-1} G_{6}^{b+1}+\frac{15 b}{7} G_{4}^{a+2} G_{6}^{b-1}\right) .
\end{aligned}
$$

We also see from (3) that

$$
G_{j+1} G_{r-j-1}=\left(\sum_{4 a+6 b=j+1} w_{a, j+1} G_{4}^{a} G_{6}^{b}\right)\left(\sum_{4 a+6 b=r-j-1} w_{a, r-j-1} G_{4}^{a} G_{6}^{b}\right) .
$$

Using Lemma 6 and the induction hypothesis we conclude that $\min _{a}\left(\nu_{2}\left(w_{a, r}\right)\right) \geq 0$.
We have the following precise conjecture about the value of $\min _{a}\left(\nu_{2}\left(w_{a, k}\right)\right)$.
Conjecture 8. Let $w_{a, k}$ be as in (3) and let $k \geq 4$ be an even integer. Then,

$$
\min _{a}\left(\nu_{2}\left(w_{a, k}\right)\right)= \begin{cases}s(k)-2 & \text { if } k \neq 2^{j} \\ 0 & \text { if } k=2^{j}\end{cases}
$$

This has been verified for $k \leq 3500$.
Lemma 9. Let $k \equiv 0(\bmod 12)$ and let $r \geq 0$. Write

$$
\begin{equation*}
\varphi_{k}(X)=X^{\frac{k}{12}}+t_{k, \frac{k}{12}-1} X^{\frac{k}{12}-1}+\cdots+t_{k, 1} X+t_{k, 0} . \tag{11}
\end{equation*}
$$

Then,

$$
t_{k, r}=\frac{\pi^{k}}{\zeta(k)}(-1)^{k / 12-r} \sum_{a=0}^{r} w_{3 a, k} \frac{2^{2 k / 3-6 r-2 a-1}}{3^{k / 4+3 r} 5^{a+k / 6} 7^{k / 6-2 a}}\binom{k / 12-a}{k / 12-r} .
$$

Proof. We have

$$
\begin{aligned}
\frac{E_{k}}{\Delta^{\frac{k}{12}}}=\frac{G_{k}}{2 \zeta(k) \Delta^{\frac{k}{12}}} & =\frac{\sum_{a=0}^{k / 12} w_{3 a, k} G_{4}^{3 a} G_{6}^{k / 6-2 a}}{2 \zeta(k) \Delta^{k / 12}} \\
& =\frac{\pi^{k}}{3^{k / 2} \zeta(k)} \sum_{a=0}^{k / 12} \frac{w_{3 a, k} \cdot 2^{k / 6-2 a-1}}{5^{k / 6+a} 7^{k / 6-2 a}} j^{a}(j-1728)^{k / 12-a} \\
& =\frac{\pi^{k}}{3^{k / 2} \zeta(k)} \sum_{a=0}^{k / 12} \sum_{i=0}^{k / 12-a} \frac{w_{3 a, k} \cdot 2^{k / 6-2 a-1}}{5^{k / 6+a} 7^{k / 6-2 a}}\binom{k / 12-a}{i} j^{k / 12-i}(-1728)^{i} .
\end{aligned}
$$

From Proposition 3 we see that

$$
\frac{E_{k}}{\Delta^{\frac{k}{12}}}=\varphi_{k}(j)=j^{\frac{k}{12}}+t_{k, \frac{k}{12}-1} j^{\frac{k}{12}-1}+\cdots+t_{k, 1} j+t_{k, 0}
$$

Comparing coefficients, the result follows.
Lemma 10. Let $k=12 \cdot 2^{\ell}$ with $\ell \geq 0$ and let $w_{a, k}$ be as in (31). Then $v_{2}\left(w_{0, k}\right)=0$ and $v_{2}\left(w_{3 a, k}\right) \geq 1$ for $1 \leq a \leq \frac{k}{12}-1$.

Proof. By induction on $\ell$. From [Rad73, (59.6)], we have

$$
\begin{equation*}
(k / 2-3)(k-1)(k+1) G_{k}=3 \sum_{p=2}^{k / 2-2}(2 p-1)(k-2 p-1) G_{2 p} G_{k-2 p} . \tag{12}
\end{equation*}
$$

Note that $G_{12}=\frac{25}{143} G_{6}^{2}+\frac{18}{143} G_{4}^{3}$, so the result holds for $\ell=0$. Suppose that for some $m \geq 0$ we have $\nu_{2}\left(w_{0,12 \cdot 2^{m}}\right)=0$ and $\nu_{2}\left(w_{3 a, 12 \cdot 2^{m}}\right) \geq 1$ for $1 \leq a \leq \frac{k}{12}-1$. Then, paring the terms arising from $p$ and $12 \cdot 2^{m}-p$ in (12) gives

$$
\begin{aligned}
G_{12 \cdot 2^{m+1}} & =\frac{3}{\left(12 \cdot 2^{m}-3\right)\left(12 \cdot 2^{m+1}-1\right)\left(12 \cdot 2^{m+1}+1\right)} \\
& \left(2 \sum_{p=2}^{12 \cdot 2^{m-1}-1}(2 p-1)\left(12 \cdot 2^{m+1}-2 p-1\right) G_{2 p} G_{12 \cdot 2^{m+1}-2 p}+\left(12 \cdot 2^{m}-1\right)^{2} G_{12 \cdot 2^{m}}^{2}\right) .
\end{aligned}
$$

Thus, using Theorem 7, we have $\nu_{2}\left(w_{0,12 \cdot 2^{m+1}}\right)=0$ and $\nu_{2}\left(w_{3 a, 12 \cdot 2^{m+1}}\right) \geq 1$ for $1 \leq a \leq$ $\frac{k}{12}-1$.
Corollary 11. Let $k=12 \cdot 2^{\ell}$ with $\ell \geq 0$ and let $t_{k, r}$ be as in (11). Then, $\nu_{2}\left(t_{k, 0}\right)=\frac{2 k-3}{3}$ and for $1 \leq r \leq k / 12-1$ we have $\nu_{2}\left(t_{k, r}\right) \geq \frac{2 k}{3}-8 r$.

Proof. Recall (see, for example, [Rad73, (5.5), (9.1)]) that

$$
\nu_{2}\left(B_{2 n}\right)=-1,
$$

and that

$$
\zeta(2 n)=(-1)^{n-1} \frac{(2 \pi)^{2 n} B_{2 n}}{2(2 n)!}
$$

Thus, $\nu_{2}\left(\frac{\zeta(k)}{\pi^{k}}\right)=0$. The result now follows from Lemmas 10 and 9 .

We can now prove the main theorem.
Proof of Theorem [1] Let $t_{k, r}$ be as in (11). For $0 \leq r \leq \frac{k}{12}-1$, Corollary (11) gives

$$
\begin{equation*}
\frac{\nu_{2}\left(t_{k, 0}\right)}{k / 12} \leq \frac{\nu_{2}\left(t_{k, r}\right)}{k / 12-r} \tag{13}
\end{equation*}
$$

and

$$
\left(v_{2}\left(t_{k, 0}\right), \frac{k}{12}\right)=\left(2 k / 3-1,2^{\ell}\right)=\left(2^{2 \ell+1} \cdot 3^{\ell-1}-1,2^{\ell}\right)=1 .
$$

Thus, the result follows from Proposition 4 with $p=2$.
