# THE BALANCED SUPERELLIPTIC MAPPING CLASS GROUPS ARE GENERATED BY THREE ELEMENTS

#### Abstract

The balanced superelliptic mapping class group is the normalizer of the transformation group of the balanced superelliptic covering in the mapping class group of the total surface. We prove that the balanced superelliptic mapping class groups with either one marked point, one boundary component, or no marked points and boundary are generated by three elements. To prove this, we also show that its liftable mapping class groups are also generated by three elements. These generating sets are minimal except for several no marked points and boundary cases.


## 1. Introduction

Let $\Sigma_{g}$ be a connected closed oriented surface of genus $g \geq 0$. For subsets $A$ and $B$ of $\Sigma_{g}(g \geq 0)$, the mapping class group $\operatorname{Mod}\left(\Sigma_{g} ; A, B\right)$ of the tuple $\left(\Sigma_{g}, A, B\right)$ is the group of isotopy classes of orientation-preserving self-homeomorphisms on $\Sigma_{g}$ which preserve $A$ setwise and $B$ pointwise. When $A$ is a set of $n$ points and $B$ is a disjoint union of $b$ disks such that $A$ and $B$ have no intersections, we denote the mapping class group by $\operatorname{Mod}_{g, n}^{b}$. We denote simply $\operatorname{Mod}_{g}^{b}=\operatorname{Mod}_{g, 0}^{b}, \operatorname{Mod}_{g, n}=$ $\operatorname{Mod}_{g, n}^{0}$, and $\operatorname{Mod}_{g}=\operatorname{Mod}_{g, 0}^{0}$.

Dehn 4 proved that $\operatorname{Mod}_{g, n}^{b}$ is generated by Dehn twists. After that small finite generating sets for $\operatorname{Mod}_{g}$ by Dehn twists were given by Lickorish 14 and Humphries 11, and finite presentations for $\operatorname{Mod}_{g, n}^{b}$ were given by Gervais 6] for $g \geq 1$ and $n=0$ and by Labruere-Paris 13 for $g \geq 1$ and $b \geq 1$. Generators of these presentations for $n=0,1$ are consist of Dehn twists. In 11, Humphries also proved that $\operatorname{Mod}_{g}$ does not generated by at most $2 g$ Dehn twists and his generating set is minimal in generating sets for $\operatorname{Mod}_{g}$ which consist of Dehn twists.

As a study of more smaller generating set for the mapping class group, Wajnryb 17 proved that $\operatorname{Mod}_{g}^{b}$ is generated by two elements for $g \geq 1$ and $b \in\{0,1\}$. Since $\operatorname{Mod}_{g}^{b}$ is not a cyclic group, this Wajnryb's generating set is minimal. After that, Korkmaz 12 proved that $\operatorname{Mod}_{g}^{b}$ is generated by two elements whose one element is a Dehn twist for $g \geq 1$ and $b \in\{0,1\}$. Monden [15] showed that $\operatorname{Mod}_{g, n}$ is generated by two elements for $g \geq 3$ and $n \geq 0$, and this generating set is also minimal.

For integers $n \geq 1$ and $k \geq 2$ with $g=n(k-1)$, the balanced superelliptic covering map $p=p_{g, k}: \Sigma_{g} \rightarrow \Sigma_{0}$ is a branched covering map with $2 n+2$ branch points $p_{1}, p_{2}, \ldots, p_{2 n+2} \in \Sigma_{0}$, their unique preimages $\widetilde{p}_{1}, \widetilde{p}_{2}, \ldots, \widetilde{p}_{2 n+2} \in \Sigma_{g}$, and the covering transformation group generated by the balanced superelliptic rotation $\zeta=\zeta_{g, k}$ of order $k$ (precisely defined in Section 2.1 and see Figure 1). When $k=2$, $\zeta=\zeta_{g, 2}$ coincides with the hyperelliptic involution, and for $k \geq 3$, the balanced superelliptic covering space was introduced by Ghaswala and Winarski (9].

[^0]Let $D$ be a disk on $\Sigma_{0}-\left\{p_{1}, p_{2}, \ldots, p_{2 n+1}\right\}$ whose interior includes the point $p_{2 n+2}$ and $\widetilde{D}$ the preimage of $D$ with respect to $p$. Then, denote by $\Sigma_{g}^{1}$ for $g \geq 1$ the complement of the interior of $\widetilde{D}$ in $\Sigma_{g}$. For $g=n(k-1) \geq 1$, an orientation-preserving self-homeomorphism $\varphi$ on $\Sigma_{g}$ (resp. on $\Sigma_{g}^{1}$ whose restriction to $\partial \Sigma_{g}^{1}$ is the identity map) is symmetric for $\zeta=\zeta_{g, k}$ if $\varphi\langle\zeta\rangle \varphi^{-1}=\langle\zeta\rangle$ (resp. $\varphi\left\langle\left.\zeta\right|_{\Sigma_{g}^{1}}\right\rangle \varphi^{-1}=\left\langle\left.\zeta\right|_{\Sigma_{g}^{1}}\right\rangle$ ). We abuse notation and denote simply $\left.\zeta\right|_{\Sigma_{g}^{1}}=\zeta$. We regard $\operatorname{Mod}_{g, 1}$ and $\operatorname{Mod}_{g}^{1}$ as the $\operatorname{groups} \operatorname{Mod}\left(\Sigma_{g} ;\left\{\widetilde{p}_{2 n+2}\right\}, \emptyset\right)$ and $\operatorname{Mod}\left(\Sigma_{g} ; \emptyset, \widetilde{D}\right)$, respectively. The balanced superelliptic mapping class group (or symmetric mapping class group) $\operatorname{SMod}_{g ; k}\left(\right.$ resp. $\operatorname{SMod}_{g, * ; k}$ and $\left.\operatorname{SMod}_{g ; k}^{1}\right)$ is the subgroup of $\operatorname{Mod}_{g}$ (resp. $\operatorname{Mod}_{g, 1}$ and $\operatorname{Mod}_{g}^{1}$ ) which consists of elements represented by symmetric homeomorphisms. Birman and Hilden [3] showed that $\operatorname{SMod}_{g ; k}$ (resp. $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ ) coincides with the group of symmetric isotopy classes of symmetric homeomorphisms on $\Sigma_{g}\left(\operatorname{resp} .\left(\Sigma_{g}, \widetilde{p}_{2 n+2}\right)\right.$ and $\left.\Sigma_{g}^{1}\right)$.

We denote by $\Sigma_{0}^{1}$ the complement of the interior of $D$ in $\Sigma_{0}$. An orientationpreserving self-homeomorphism $\varphi$ on $\Sigma_{0}$ (resp. on $\Sigma_{0}^{1}$ whose restriction to $\partial \Sigma_{0}^{1}$ is the identity map) is liftable with respect to $p=p_{g, k}$ if there exists an orientationpreserving self-homeomorphism $\widetilde{\varphi}$ on $\Sigma_{g}$ (resp. on $\Sigma_{g}^{1}$ whose restriction to $\partial \Sigma_{g}^{1}$ is the identity map) such that $p \circ \widetilde{\varphi}=\varphi \circ p$ (resp. $\left.p\right|_{\Sigma_{g}^{1}} \circ \widetilde{\varphi}=\left.\varphi \circ p\right|_{\Sigma_{g}^{1}}$ ), namely, the following diagrams commute:


Put $\mathcal{B}=\left\{p_{1}, p_{2}, \ldots, p_{2 n+2}\right\}$. We regard $\operatorname{Mod}_{0,2 n+2}$ and $\operatorname{Mod}_{0,2 n+1}^{1}$ as the groups $\operatorname{Mod}\left(\Sigma_{0} ; \mathcal{B}, \emptyset\right)$ and $\operatorname{Mod}\left(\Sigma_{0} ; \mathcal{B}-\left\{p_{2 n+2}\right\}, D\right)$, respectively, and denote by $\operatorname{Mod}_{0,2 n+2 ; *}$ the group $\operatorname{Mod}\left(\Sigma_{0} ; \mathcal{B}-\left\{p_{2 n+2}\right\},\left\{p_{2 n+2}\right\}\right)$. The liftable mapping class group $\operatorname{LMod}_{2 n+2 ; k}\left(\right.$ resp. $\operatorname{LMod}_{2 n+2, * ; k}$ and $\operatorname{LMod}_{2 n+1 ; k}^{1}$ ) is the subgroup of $\operatorname{Mod}_{0,2 n+2}$ (resp. $\operatorname{Mod}_{0,2 n+2 ; *}$ and $\operatorname{Mod}_{0,2 n+1}^{1}$ ) which consists of elements represented by liftable homomorphisms. Birman and Hilden 2 proved that $\operatorname{LMod}_{2 n+1 ; k}^{1}$ is isomorphic to $\operatorname{SMod}_{g ; k}^{1}$ and $\operatorname{LMod}_{2 n+2 ; k}\left(\right.$ resp. $\left.\operatorname{LMod}_{2 n+2, * ; k}\right)$ is isomorphic to the quotient of $\operatorname{SMod}_{g ; k}\left(\right.$ resp. $\left.\operatorname{SMod}_{g, * ; k}\right)$ by $\langle\zeta\rangle$.

When $k=2, \zeta=\zeta_{g, 2}$ is the hyperelliptic involution and corresponding symmetric mapping class groups are called the hyperelliptic mapping class groups. In this case, $\operatorname{LMod}_{2 n+2 ; 2}\left(\right.$ resp. $\operatorname{LMod}_{2 n+2, * ; 2}$ and $\operatorname{LMod}_{2 n+1 ; 2}^{1}$ ) is equal to $\operatorname{Mod}_{0,2 n+2}$ (resp. $\operatorname{Mod}_{0,2 n+2 ; *}$ and $\operatorname{Mod}_{0,2 n+1}^{1}$ ) and a finite presentation for $\operatorname{SMod}_{g ; 2}$ was given by Birman and Hilden [1]. Stukow [16] gave a minimal generating set for $\operatorname{SMod}_{g ; 2}$ by two torsion elements.

When $k \geq 3$, Ghaswala and Winarski [9] proved that $\operatorname{LMod}_{2 n+2 ; k}$ is a proper subgroup of $\operatorname{Mod}_{0,2 n+2}$. They also gave a finite presentation for $\operatorname{LMod}_{2 n+2 ; k}$ in [8]. By Lemma 3.6 in [8] and Lemmas 4.2 and 4.4 in [10], we show that the group $\operatorname{LMod}_{2 n+2, * ; k}\left(\right.$ resp. $\left.\operatorname{LMod}_{2 n+1 ; k}^{1}\right)$ is also a proper subgroup of $\operatorname{Mod}_{0,2 n+2 ; *}$ (resp. $\operatorname{Mod}_{0,2 n+1}^{1}$ ) for $k \geq 3$ and also show that $\operatorname{LMod}_{2 n+2 ; k}=\operatorname{LMod}_{2 n+2 ; l}$, $\operatorname{LMod}_{2 n+2, * ; k}=\operatorname{LMod}_{2 n+2, * ; l}$, and $\operatorname{LMod}_{2 n+1 ; k}^{1}=\operatorname{LMod}_{2 n+1 ; l}^{1}$ for $l>k \geq 3$. Hence we omit " $k$ " in the notation of the liftable mapping class groups for $k \geq 3$ (i.e. $\quad$ we express $\operatorname{LMod}_{2 n+2 ; k}=\operatorname{LMod}_{2 n+2}, \operatorname{LMod}_{2 n+2, * ; k}=\operatorname{LMod}_{2 n+2, *}$, and
$\operatorname{LMod}_{2 n+1 ; k}^{1}=\operatorname{LMod}_{2 n+1}^{1}$ for $k \geq 3$ ). Hirose and the author 10 gave another finite presentation for $\operatorname{LMod}_{2 n+2}$ and finite presentations for the groups $\operatorname{LMod}_{2 n+2, *}$, $\operatorname{LMod}_{2 n+1}^{1}, \operatorname{SMod}_{g ; k}, \operatorname{SMod}_{g, * ; k}$, and $\operatorname{SMod}_{g ; k}^{1}$.

The main theorems in this paper are as follows.
Theorem 1.1. $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$ for $n \geq 2$ and $\operatorname{LMod}_{2 n+2}$ for $n \geq 1$ are generated by three elements. $\mathrm{LMod}_{4, *}$ and $\mathrm{LMod}_{3}^{1}$ are generated by two elements.

Theorem 1.2. Assume that $n \geq 1$ and $k \geq 3$ with $g=n(k-1)$. Then, $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ for $n \geq 2$ and $\operatorname{SMod}_{g ; k}$ for $n \geq 1$ are generated by three elements. $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ for $n=1$ are generated by two elements.

Theorems 1.1 and 1.2 are proved in Sections 3 and 4 Theorems 1.1 and 1.2 for $n=1$ is immediately obtained from Corollaries 5.4 and 6.13 in 10 . The integral first homology group $H_{1}(G)$ of a group $G$ is isomorphic to the abelianization of $G$. By Theorem 1.1 in $[7$ and Theorems 1.1 and 1.2 in 10 , the integral first homology groups of the liftable mapping class groups and the balanced superelliptic mapping class groups are as follows:

Theorem 1.3 (Theorem 1.1 in 7 and Theorem 1.1 in 10]). For $n \geq 1$,
(1) $H_{1}\left(\operatorname{LMod}_{2 n+2}\right) \cong \begin{cases}\mathbb{Z} \oplus \mathbb{Z}_{2} \oplus \mathbb{Z}_{2} & \text { if } n \text { is odd, } \\ \mathbb{Z} \oplus \mathbb{Z}_{2} & \text { if } n \text { is even, }\end{cases}$
(2) $H_{1}\left(\operatorname{LMod}_{2 n+2, *}\right) \cong \begin{cases}\mathbb{Z} \oplus \mathbb{Z}_{2} & \text { if } n=1, \\ \mathbb{Z}^{2} \oplus \mathbb{Z}_{n} & \text { if } n \geq 2 \text { is even, } \\ \mathbb{Z}^{2} \oplus \mathbb{Z}_{2 n} & \text { if } n \geq 3 \text { is odd, }\end{cases}$
(3) $H_{1}\left(\operatorname{LMod}_{2 n+1}^{1}\right) \cong \begin{cases}\mathbb{Z}^{2} & \text { if } n=1, \\ \mathbb{Z}^{3} & \text { if } n \geq 2 .\end{cases}$

Theorem 1.4 (Theorem 1.2 in $[10)$. For $n \geq 1$ and $k \geq 3$ with $g=n(k-1)$,
(1) $H_{1}\left(\operatorname{SMod}_{g ; k}\right) \cong \begin{cases}\mathbb{Z} \oplus \mathbb{Z}_{2} \oplus \mathbb{Z}_{2} & \text { if } n \geq 1 \text { is odd and } k \text { is odd, } \\ \mathbb{Z} \oplus \mathbb{Z}_{2} \oplus \mathbb{Z}_{4} & \text { if } n \geq 1 \text { is odd and } k \text { is even, } \\ \mathbb{Z} \oplus \mathbb{Z}_{2} & \text { if } n \geq 2 \text { is even, }\end{cases}$
(2) $H_{1}\left(\operatorname{SMod}_{g, * ; k}\right) \cong \begin{cases}\mathbb{Z} \oplus \mathbb{Z}_{2 k} & \text { if } n=1, \\ \mathbb{Z}^{2} \oplus \mathbb{Z}_{k n} & \text { if } n \geq 2 \text { is even, } \\ \mathbb{Z}^{2} \oplus \mathbb{Z}_{2 k n} & \text { if } n \geq 3 \text { is odd, }\end{cases}$
(3) $H_{1}\left(\operatorname{SMod}_{g ; k}^{1}\right) \cong \begin{cases}\mathbb{Z}^{2} & \text { if } n=1, \\ \mathbb{Z}^{3} & \text { if } n \geq 2 .\end{cases}$

For a group $G$, the minimal number of generators for $H_{1}(G)$ gives a lower bound of the minimal number of generators for $G$. By Theorems 1.3 and 1.4 , we can show that the generating sets in Theorem 1.1 or 1.2 are minimal except for the cases that $\operatorname{LMod}_{2 n+2}$ for even $n$ and $\operatorname{SMod}_{g ; k}$ for even $n$.

## 2. Preliminaries

2.1. The balanced superelliptic covering space. In this section, we review the definition of the balanced superelliptic coverring space from Section 2.1 in 10. For integers $n \geq 1$ and $k \geq 2$ with $g=n(k-1)$, we describe the surface $\Sigma_{g}$ as follows. We take the unit 2 -sphere $S^{2}=S(1)$ in $\mathbb{R}^{3}$ and $n$ mutually disjoint parallel copies $S(2), S(3), \ldots, S(n+1)$ of $S(1)$ by translations along the x-axis such that

$$
\max (S(i) \cap(\mathbb{R} \times\{0\} \times\{0\}))<\min (S(i+1) \cap(\mathbb{R} \times\{0\} \times\{0\}))
$$

for $1 \leq i \leq n$ (see Figure 1 ). Let $\zeta$ be the $\left(-\frac{2 \pi}{k}\right)$-rotation of $\mathbb{R}^{3}$ on the $x$-axis. Then we remove $2 k$ disjoint open disks in $S(i)$ for $2 \leq i \leq n$ and $k$ disjoint open disks in
$S(i)$ for $i \in\{1, n+1\}$ which are setwisely preserved by the action of $\zeta$, and connect $k$ boundary components of the punctured $S(i)$ and ones of the punctured $S(i+1)$ by $k$ annuli such that the union of the $k$ annuli is preserved by the action of $\zeta$ for each $1 \leq i \leq n$ as in Figure 1 . Since the union of the punctured $S(1) \cup S(2) \cup \cdots \cup S(n+1)$ and the attached $n \times k$ annuli is homeomorphic to $\Sigma_{g=n(k-1)}$, we regard this union as $\Sigma_{g}$.

By the construction above, the action of $\zeta$ on $\mathbb{R}^{3}$ induces the action on $\Sigma_{g}$, the quotient space $\Sigma_{g} /\langle\zeta\rangle$ is homeomorphic to $\Sigma_{0}$, and the quotient map $p=$ $p_{g, k}: \Sigma_{g} \rightarrow \Sigma_{0}$ is a branched covering map with $2 n+2$ branch points in $\Sigma_{0}$. We call the branched covering map $p: \Sigma_{g} \rightarrow \Sigma_{0}$ the balanced superelliptic covering map. Denote by $\widetilde{p}_{1}, \widetilde{p}_{2}, \ldots, \widetilde{p}_{2 n+2} \in \Sigma_{g}$ the fixed points of $\zeta$ such that $\widetilde{p}_{i}<\widetilde{p}_{i+1}$ in $\mathbb{R}=\mathbb{R} \times\{0\} \times\{0\}$ for $1 \leq i \leq 2 n+1$, by $p_{i} \in \Sigma_{0}$ for $1 \leq i \leq 2 n+2$ the image of $\widetilde{p}_{i}$ by $p$ (i.e. $p_{1}, p_{2}, \ldots, p_{2 n+2} \in \Sigma_{0}$ are branch points of $p$ ), and by $\mathcal{B}$ the set of the branch points $p_{1}, p_{2}, \ldots, p_{2 n+2}$. Let $D$ be a 2 -disk in $\left(\Sigma_{0}-\mathcal{B}\right) \cup\left\{p_{2 n+2}\right\}$ whose interior includes the point $p_{2 n+2}$ and $\widetilde{D}$ the preimage of $D$ with respect to $p$. Denote by $\Sigma_{g}^{1}$ the complement of interior of $\widetilde{D}$ in $\Sigma_{g}$ and by $\Sigma_{0}^{1}$ the complement of interior of $D$ in $\Sigma_{0}$. Then we also call the restriction $\left.p\right|_{\Sigma_{g}^{1}}: \Sigma_{g}^{1} \rightarrow \Sigma_{0}^{1}$ the balanced superelliptic covering map and we denote simply $\left.p\right|_{\Sigma_{g}^{1}}=p$.


Figure 1. The balanced superelliptic covering map $p=$ $p_{g, k}: \Sigma_{g} \rightarrow \Sigma_{0}$.
2.2. Liftable elements for the balanced superelliptic covering map. In this section, we introduce some liftable homeomorphisms on $\Sigma_{0}$ for the balanced superelliptic covering map $p=p_{g, k}$ for $k \geq 3$ from Section 2.2 in 10 . Let $l_{i}(1 \leq i \leq 2 n+1)$ be an oriented simple arc on $\Sigma_{0}$ whose endpoints are $p_{i}$ and $p_{i+1}$ as in Figure 2 . Put $L=l_{1} \cup l_{2} \cup \cdots \cup l_{2 n+1}$. The isotopy class of a homeomorphism $\varphi$ on $\Sigma_{0}$ (resp. $\Sigma_{0}^{1}$ ) relative to $\mathcal{B}$ (resp. $\left.\left(\mathcal{B}-\left\{p_{2 n+2}\right\}\right) \cup \partial \Sigma_{0}^{1}\right)$ is determined by the isotopy class of the image of $L$ (resp. $L \cap \Sigma_{0}^{1}$ ) by $\varphi$ relative to $\mathcal{B}$ (resp. $\left(\mathcal{B}-\left\{p_{2 n+2}\right\}\right) \cup \partial \Sigma_{0}^{1}$ ). We
identify $\Sigma_{0}$ with the surface on the lower side in Figure 2 by some homeomorphism of $\Sigma_{0}$.


Let $\sigma_{i}$ for $1 \leq i \leq 2 n+1$ be a self-homeomorphism on $\Sigma_{0}$ which is described as the result of anticlockwise half-rotation of $l_{i}$ in the regular neighborhood of $l_{i}$ in $\Sigma_{0}$ as in Figure 3, $\sigma_{i}$ is called the half-twist along $l_{i}$. As a well-known result, $\operatorname{Mod}_{0,2 n+2}$ is generated by $\sigma_{1}, \sigma_{2}, \ldots, \sigma_{2 n+1}$ (see for instance Section 9.1.4 in [5]). Since $\operatorname{Mod}_{0,2 n+2}$ is naturally acts on $\mathcal{B}$, we have the surjective homomorphism

$$
\Psi: \operatorname{Mod}_{0,2 n+2} \rightarrow S_{2 n+2}
$$

given by $\Psi\left(\sigma_{i}\right)=(i i+1)$, where $S_{2 n+2}$ is the symmetric group of degree $2 n+2$.


Figure 3. The half-twist $\sigma_{i}$ for $1 \leq i \leq 2 n+1$.

Put $\mathcal{B}_{o}=\left\{p_{1}, p_{3}, \ldots, p_{2 n+1}\right\}$ and $\mathcal{B}_{e}=\left\{p_{2}, p_{4}, \ldots, p_{2 n+2}\right\}$. An element $\sigma$ in $S_{2 n+2}$ is parity-preserving if $\sigma\left(\mathcal{B}_{o}\right)=\mathcal{B}_{o}$, and is parity-reversing if $\sigma\left(\mathcal{B}_{o}\right)=\mathcal{B}_{e}$. An element $f$ in $\operatorname{Mod}_{0,2 n+2}$ is parity-preserving (resp. parity-reversing) if $\Psi(f)$ is parity-preserving (resp. parity-reversing). Let $W_{2 n+2}$ be the subgroup of $S_{2 n+2}$ which consists of parity-preserving or parity-reversing elements, $S_{n+1}^{o}$ (resp. $S_{n+1}^{e}$ ) the subgroup of $S_{2 n+2}$ which consists of elements whose restriction to $\mathcal{B}_{e}$ (resp. $\mathcal{B}_{o}$ ) is the identity map. Note that $S_{n+1}^{o}$ (resp. $S_{n+1}^{e}$ ) is a subgroup of $W_{2 n+2}$,
isomorphic to $S_{n+1}$, and generated by transpositions (13), (35), .., (2n-1 $2 n+1$ ) (resp. (2 4), (46),.,$(2 n 2 n+2))$. Then we have the following exact sequence:

1 \longrightarrow S_{n+1}^{o} \times S_{n+1}^{e} \longrightarrow W_{2 n+2} \xrightarrow{\pi} \mathbb{Z}_{2} \longrightarrow 1 \tag{2.1}
\end{equation*}

where the homomorphism $\pi: W_{2 n+2} \rightarrow \mathbb{Z}_{2}$ is defined by $\pi(\sigma)=0$ if $\sigma$ is paritypreserving and $\pi(\sigma)=1$ if $\sigma$ is parity-reversing. Ghaswala and Winarski 8 proved the following lemma.

Lemma 2.1 (Lemma 3.6 in [8]). Let $\operatorname{LMod}_{2 n+2}$ be the liftable mapping class group for the balanced superelliptic covering map $p_{g, k}$ for $n \geq 1$ and $k \geq 3$ with $g=$ $n(k-1)$. Then we have

$$
\operatorname{LMod}_{2 n+2}=\Psi^{-1}\left(W_{2 n+2}\right)
$$

Lemma 2.1 implies that a mapping class $f \in \operatorname{Mod}_{0,2 n+2}$ lifts with respect to $p_{g, k}$ if and only if $f$ is parity-preserving or parity-reversing (in particular, when $k \geq 3$, the liftability of a homeomorphism on $\Sigma_{0}$ or $\Sigma_{0}^{1}$ does not depend on $k$ ). The pure mapping class group $\mathrm{PMod}_{0,2 n+2}$ is the kernel of the homomorphism $\Psi: \operatorname{Mod}_{0,2 n+2} \rightarrow S_{2 n+2}$. Since all elements in $\operatorname{PMod}_{0,2 n+2}$ is parity-preserving, $\mathrm{PMod}_{0,2 n+2}$ is a subgroup of $\operatorname{LMod}_{2 n+2}$ and we have the following exact sequence:

$$
\begin{equation*}
1 \longrightarrow \operatorname{PMod}_{0,2 n+2} \longrightarrow \operatorname{LMod}_{2 n+2} \xrightarrow{\Psi} W_{2 n+2} \longrightarrow 1 . \tag{2.2}
\end{equation*}
$$

For mapping classes $[\varphi]$ and $[\psi],[\psi][\varphi]$ means $[\psi \circ \varphi]$, i.e. $[\varphi]$ apply first, and we often abuse notation and denote a homeomorphism and its isotopy class by the same symbol. We will introduce some explicit liftable elements as follows.

The Dehn twist $t_{i, j}$. For a simple closed curve $\gamma$ on $\Sigma_{g}(g \geq 0)$, we denote by $t_{\gamma}$ the right-handed Dehn twist along $\gamma$. Let $\gamma_{i, j}$ for $1 \leq i<j \leq 2 n+2$ be a simple closed curve on $\Sigma_{0}-(\mathcal{B} \cup D)$ such that $\gamma_{i, j}$ surrounds the $j-i+1$ points $p_{i}$, $p_{i+1}, \ldots, p_{j}$ as in Figure 2, We have $\gamma_{i, 2 n+2}=\gamma_{1, i-1}$ for $i \geq 3$ as an isotopy class of a curve. Then we define $t_{i, j}=t_{\gamma_{i, j}}$ for $1 \leq i<j \leq 2 n+2$. Note that $t_{1,2 n+1}=t_{1,2 n+2}=t_{2,2 n+2}=1$ and $t_{i, 2 n+2}=t_{1, i-1}$ for $i \geq 3$ in $\operatorname{Mod}_{0,2 n+2}$. Since the Dehn twist $t_{i, j}$ preserves $\mathcal{B}$ pointwise, i.e. $t_{i, j}$ lies in $\operatorname{PMod}_{0,2 n+2}, t_{i, j}$ lifts with respect to $p$ by Lemma 2.1.

The half-rotation $h_{i}$. Let $\mathcal{N}$ be a regular neighborhood of $l_{i} \cup l_{i+1}$ in $\left(\Sigma_{0}-\mathcal{B}\right) \cup$ $\left\{p_{i}, p_{i+1}, p_{i+2}\right\}$ for $1 \leq i \leq 2 n . \mathcal{N}$ is homeomorphic to a 2 -disk. Then we denote by $h_{i}$ the self-homeomorphism on $\Sigma_{0}$ which is described as the result of anticlockwise half-rotation of $l_{i} \cup l_{i+1}$ in $\mathcal{N}$ as in Figure 4. Note that $h_{i}=\sigma_{i} \sigma_{i+1} \sigma_{i}$ for $1 \leq i \leq 2 n$. Since $\Psi\left(h_{i}\right)=(i i+2)$ for $1 \leq i \leq 2 n$, the mapping class $h_{i}$ is parity-preserving. Thus, by Lemma 2.1. $h_{i}$ lifts with respect to $p$.


Figure 4. The mapping class $h_{i}$ for $1 \leq i \leq 2 n$ on $\Sigma_{0}$.

The parity-reversing element $r_{1}$. Let $r_{1}$ be the self-homeomorphism on $\Sigma_{0}$ which is described as the result of the $\frac{2 \pi}{2 n+2}$-rotation on $\Sigma_{0}$ as in Figure 5 We see that $r\left(l_{i}\right)=l_{i+1}$ for $1 \leq i \leq 2 n$, the order of $r_{1}$ is $2 n+2$, and $\Psi\left(r_{1}\right)=(12)(23) \cdots(2 n+12 n+2)$. Thus $r_{1}$ is parity-reversing and lifts with respect to $p$ by Lemma 2.1.


Figure 5. The mapping class $r_{1}$ on $\Sigma_{0}$.

The parity-reversing element $r$. Let $r$ be the self-homeomorphism on $\Sigma_{0}$ which is described as the result of the $\pi$-rotation of $\Sigma_{0}$ on the axis as in Figure6 We see that $r\left(l_{i}\right)=l_{2 n+2-i}^{-1}$ for $1 \leq i \leq 2 n+1$ and $\Psi(r)=(12 n+2)(22 n+1) \cdots(n+1 n+2)$. Thus $r$ is parity-reversing and lifts with respect to $p$ by Lemma 2.1 .


Figure 6. The mapping class $r$ on $\Sigma_{0}$.
We have the following lemma.
Lemma 2.2. For $n \geq 1$, put

$$
F=\left\{\begin{array}{l}
h_{1}^{-1} \text { for } n=1, \\
\left(h_{1}^{-1} h_{2}^{-1} \cdots h_{2 n-2}^{-1}\right)\left(h_{1}^{-1} h_{2}^{-1} \cdots h_{2 n-4}^{-1}\right) \cdots\left(h_{1}^{-1} h_{2}^{-1}\right) h_{2 n-1}^{-1} \cdots h_{3}^{-1} h_{1}^{-1} \\
t_{2 n, 2 n+1}^{n-1} \cdots t_{6,7}^{2} t_{4,5} \quad \text { for } n \geq 2 .
\end{array}\right.
$$

Then, the relation $r_{1}=r F$ holds in $\operatorname{LMod}_{2 n+2}$.
Proof. Since $r$ is an involution and the isotopy class of a homeomorphism $\varphi$ on $\Sigma_{0}$ relative to $\mathcal{B}$ is determined by the isotopy class of the image $\varphi(L)$ relative to $\mathcal{B}$, we will prove that $F^{-1} r_{1}\left(l_{i}\right)=l_{i}$ for $1 \leq i \leq 2 n+1$ relative to $\mathcal{B}$. The images $r_{1}(L)$ and $r r_{1}(L)$ are described as on the second and third steps in Figure 7. When $n=1$, we clearly show that $F^{-1} r r_{1}\left(l_{i}\right)=h_{1} r r_{1}\left(l_{i}\right)=l_{i}$ for $1 \leq i \leq 2 n+1$ relative to $\mathcal{B}$.

Assume that $n \geq 2$. Put $F_{i}=t_{2 i+1,2 i+2}^{-i} h_{2 i} \cdots h_{2} h_{1}$ for $1 \leq i \leq n-1$. By applying $F_{1} \cdots F_{n-2} F_{n-1}=\left(t_{3,4}^{-1} h_{2} h_{1}\right) \cdots\left(t_{2 n-3,2 n-2}^{-(n-2)} h_{2 n-4} \cdots h_{2} h_{1}\right)\left(t_{2 n-1,2 n}^{-(n-1)} h_{2 n-2} \cdots h_{2} h_{1}\right)$ to $r_{1}(L)$ inductively, we have the image $F_{1} \cdots F_{n-2} F_{n-1} r r_{1}(L)$ as on the sixth step in Figure 7 . Finally, by applying $h_{1} h_{3} \cdots h_{2 n-1}$ to this image, we show that
$h_{1} h_{3} \cdots h_{2 n-1} F_{1} \cdots F_{n-2} F_{n-1} r r_{1}\left(l_{i}\right)=l_{i}$ for $1 \leq i \leq 2 n+1$ as on the bottom in Figure 7 . Since $t_{i, i+1}$ for $1 \leq i \leq 2 n+1$ commutes with $h_{j}$ for $j \notin\{i-2, i-$ $1, i, i+1\}$ and the relation $h_{i} t_{i, i+1}=t_{i+1, i+2} h_{i}$ for $1 \leq i \leq 2 n$ holds in $\operatorname{LMod}_{2 n+2}$, we have

$$
\begin{aligned}
& h_{1} h_{3} \cdots h_{2 n-1} F_{1} \cdots F_{n-2} F_{n-1} \\
& =\quad h_{1} h_{3} \cdots h_{2 n-1} \\
& \cdot\left(\frac{t_{3,4}^{-1}}{\leftarrow} h_{2} h_{1}\right) \cdots \underbrace{\left(t_{2 n-3,2 n-2}^{-(n-2)}\right.}_{\leftarrow} h_{2 n-4} \cdots h_{2} h_{1})\left(t_{\leftarrow}^{t_{2 n-1,2 n}^{-(n-1)}} h_{2 n-2} \cdots h_{2} h_{1}\right) \\
& \stackrel{\text { COMM }}{=} \quad h_{1} h_{3} t_{3,4}^{-1} \cdots \underline{h_{2 n-3} t_{2 n-3,2 n-2}^{-(n-2)}} \frac{h_{2 n-1} t_{2 n-1,2 n}^{-(n-1)}}{h^{\prime}} \\
& \cdot\left(h_{2} h_{1}\right) \cdots\left(h_{2 n-4} \cdots h_{2} h_{1}\right)\left(h_{2 n-2} \cdots h_{2} h_{1}\right) \\
& =\quad h_{1} \frac{t_{4,5}^{-1}}{\leftarrow} h_{3} \cdots h_{2 n-5} \underbrace{t_{2 n-2,2 n-1}^{-(n-2)}}_{\leftarrow} h_{2 n-3} \underbrace{t_{2 n, 2 n+1}^{-(n-1)}}_{\leftarrow} h_{2 n-1} \\
& \cdot\left(h_{2} h_{1}\right) \cdots\left(h_{2 n-4} \cdots h_{2} h_{1}\right)\left(h_{2 n-2} \cdots h_{2} h_{1}\right) \\
& \stackrel{\mathrm{COMM}}{=} \quad t_{4,5}^{-1} \cdots t_{2 n-2,2 n-1}^{-(n-2)} t_{2 n, 2 n+1}^{-(n-1)} h_{1} h_{3} \cdots h_{2 n-1} \\
& \cdot\left(h_{2} h_{1}\right) \cdots\left(h_{2 n-4} \cdots h_{2} h_{1}\right)\left(h_{2 n-2} \cdots h_{2} h_{1}\right) \\
& =F^{-1} \text {, }
\end{aligned}
$$

where $A \stackrel{\text { COMM }}{=} B$ means that $B$ is obtained from $A$ by commutative relations and " $A_{1} \underset{\rightarrow}{\underset{\rightarrow}{A}} A_{2}$ " (resp. " $A_{1} \underset{\leftarrow}{\underset{\leftarrow}{A}} A_{2}$ ") means that deforming the word $A_{1} A A_{2}$ by moving $A$ right (resp. left). Thus we have $F^{-1} r r_{1}\left(l_{i}\right)=$ $h_{1} h_{3} \cdots h_{2 n-1} F_{1} \cdots F_{n-2} F_{n-1} r r_{1}\left(l_{i}\right)=l_{i}$ for $1 \leq i \leq 2 n+1$ and

$$
F^{-1} r r_{1}=1 \Longleftrightarrow r_{1}=r F
$$

in $\operatorname{LMod}_{2 n+2}$. Therefore, we have completed the proof of Lemma 2.2 .
We can regard a mapping class in $\operatorname{Mod}_{0,2 n+2}$ which has a representative fixing $D$ pointwise as an element in $\operatorname{Mod}_{0,2 n+1}^{1}$. Hence we also regard the mapping classes $t_{i, i+1}$ for $1 \leq i \leq 2 n+1$ and $h_{i}$ for $1 \leq i \leq 2 n-1$ as elements in $\operatorname{Mod}_{0,2 n+1}^{1}$.
2.3. Explicit lifts of liftable elements for the balanced superelliptic covering map. In this section, from Section 6.1 in [10], we review explicit lifts of liftable elements for the balanced superelliptic covering map $p=p_{g, k}: \Sigma_{g} \rightarrow \Sigma_{0}$ which are introduced in Section 2.2. Throughout this section, we assume that $g=n(k-1)$ for $n \geq 1$ and $k \geq 3$.

Let $\widetilde{l}_{i}^{l}$ for $1 \leq i \leq 2 n+1$ and $1 \leq l \leq k$ be a lift of $l_{i}$ with respect to $p$ such that $\zeta\left(\widetilde{l_{l}^{l}}\right)=\widetilde{l}_{i}^{l+1}$ for $1 \leq l \leq k-1$ and $\zeta\left(\widetilde{l_{i}^{k}}\right)=\widetilde{l}_{i}^{1}$. We consider a homeomorphism of $\Sigma_{g}$ as in Figure 8 and identify $\Sigma_{g}$ with the surface as on the lower side in Figure 8 .

A simple closed curve $\gamma$ on $\Sigma_{0}-\mathcal{B}$ lifts with respect to $p$ if there exists a simple closed curve $\widetilde{\gamma}$ on $\Sigma_{g}-p^{-1}(\mathcal{B})$ such that the restriction $\left.p\right|_{\tilde{\gamma}}: \widetilde{\gamma} \rightarrow \gamma$ is bijective. By Lemma 3.3 in 8 , a simple closed curve $\gamma$ on $\Sigma_{0}-\mathcal{B}$ lifts with respect to $p$ if and only if the algebraic intersection number of $\gamma$ and $l_{1} \cup l_{3} \cup \cdots \cup l_{2 n+1}$ is zero mod $k$. Hence the simple closed curve $\gamma_{i, i+1}$ on $\Sigma_{0}$ for $1 \leq i \leq 2 n+1$ (see Figure 22) lifts with respect to $p$. By the information of intersections of $\gamma_{i, i+1}$ and each $l_{j}$ $(1 \leq j \leq 2 n+1)$, we can show that a lift of $\gamma_{i, i+1}$ for $1 \leq i \leq 2 n+1$ with respect to $p$ by the simple closed curve $\gamma_{i}^{l}$ on $\Sigma_{g}$ for $1 \leq l \leq k$ as in Figure 9 (precisely, see before Lemma 6.4 in 10 ).

Put $\widetilde{t}_{i, i+1}=t_{\gamma_{i}^{1}} t_{\gamma_{i}^{2}} \cdots t_{\gamma_{i}^{k}}$ for $1 \leq i \leq 2 n+1$. By Lemma 6.4 in 10 , we have the following lemma.

Lemma 2.3. For $1 \leq i \leq 2 n+1, \widetilde{t}_{i, i+1}$ is a lift of $t_{i, i+1}$ with respect to $p$.

Put $\widetilde{h}_{i}=t_{\gamma_{i}^{1}} t_{\gamma_{i+1}^{1}} t_{\gamma_{i}^{2}} t_{\gamma_{i+1}^{2}} \cdots t_{\gamma_{i}^{k-1}} t_{\gamma_{i+1}^{k-1}} t_{\gamma_{i}^{k}}$ for odd $1 \leq i \leq 2 n-1$ and $\widetilde{h}_{i}=$ $t_{\gamma_{i}^{k}} t_{\gamma_{i+1}^{k}} t_{\gamma_{i}^{k-1}} t_{\gamma_{i+1}^{k-1}} \cdots t_{\gamma_{i}^{2}} t_{\gamma_{i+1}^{2}} t_{\gamma_{i}^{1}}$ for even $2 \leq i \leq 2 n$. Then, by Lemma 6.6 in 10 , we have the following lemma.

Lemma 2.4. For $1 \leq i \leq 2 n, \widetilde{h}_{i}$ is a lift of $h_{i}$ with respect to $p$.

Let $\widetilde{r}$ be a homeomorphism on $\Sigma_{g}$ which satisfies $\widetilde{r}\left(\widetilde{l_{2 i-1}^{l}}\right)=\left(\widetilde{l}_{2 n-2 i+3}^{k-l+2}\right)^{-1}$ for $1 \leq i \leq n+1$ and $2 \leq l \leq k$ and $\widetilde{r}\left(\widetilde{l}_{2 i}^{l}\right)=\left(\widetilde{\left.l_{2 n-2 i+2}^{k-l+1}\right)^{-1}}\right.$ for $1 \leq i \leq n$ and $1 \leq l \leq k$. Remark that $\widetilde{r}$ is uniquely determined up to isotopy and is described as the result
of the $\pi$-rotation of $\Sigma_{g}$ as in Figure 10 . The rotation axis of $\widetilde{r}$ intersects with $\Sigma_{g}$ at two points in $S\left(\frac{n+1}{2}\right)$ for odd $n$, at two points in the handle intersecting with $\widetilde{l}_{n+1}^{\frac{k+1}{2}}$ for even $n$ and odd $k$, and at no points for even $n$ and $k$. In actuality, the $\operatorname{arc} \widetilde{l}_{n+1}^{\frac{k+1}{2}}$ in the case of even $n$ and odd $k$ must intersect with the rotation axis of $\widetilde{r}$, however, we describe $\widetilde{l}_{n+1}^{\frac{k+1}{2}}$ in Figure 10 as a parallel arc of $\widetilde{l}_{n+1}^{\frac{k+1}{2}}$ to see well. Since $r\left(l_{i}\right)=l_{2 n-i+2}^{-1}$ for $1 \leq i \leq 2 n+1, \widetilde{r}$ is a lift of $r$ with respect to $p$.

Put $\widetilde{r}_{1}=\widetilde{r}\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1} \cdots \widetilde{h}_{2 n-2}^{-1}\right)\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1} \cdots \widetilde{h}_{2 n-4}^{-1}\right) \cdots\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1}\right) \widetilde{h}_{2 n-1}^{-1} \cdots \widetilde{h}_{3}^{-1} \widetilde{h}_{1}^{-1}$. $\widetilde{t}_{2 n, 2 n+1}^{n-1} \cdots \widetilde{t}_{6,7}^{2} \widetilde{t}_{4,5}$ for $n \geq 2$ and $\widetilde{r}_{1}=\widetilde{r} \widetilde{h}_{1}^{-1}$ for $n=1$. By Lemmas 2.2, 2.3 and 2.4 and the fact that $\widetilde{r}$ is a lift of $r$ with respect to $p$, we have the following lemma.

Lemma 2.5. $\widetilde{r}_{1}$ is a lift of $r_{1}$ with respect to $p$.

## 3. Small generating sets for liftable mapping class groups

Theorem 1.1 follows from the next proposition.
Proposition 3.1. (1) For $n \geq 1, \operatorname{LMod}_{2 n+2}$ is generated by $h_{1}, t_{1,2}$, and $r_{1}$.
(2) For $n \geq 2, \operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$ are generated by $h_{1}, h_{2}$, and $h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}$.
(3) $\operatorname{LMod}_{4, *}$ and $\operatorname{LMod}_{3}^{1}$ are generated by $h_{1}$ and $t_{1,2}$.

We remark that Proposition 3.1 for $\operatorname{LMod}_{4, *}$ or $\operatorname{LMod}_{3}^{1}$ is immediately obtained from Corollary 5.4 in 10 (see also Lemma 3.3). By Proposition 3.1, we can see that $\operatorname{LMod}_{2 n+2}$ is generated by two infinite order elements and one torsion element with order $2 n+2$. In this section, we will prove Theorem 1.1 by showing Proposition 3.1 .
3.1. Proof of the main theorem for $\operatorname{LMod}_{2 n+2}$. In this section, we will prove Proposition 3.1 for $\operatorname{LMod}_{2 n+2}$. First, we prove the following lemma.

Lemma 3.2. For $n \geq 1$ and any parity-reversing element $r^{\prime} \in \operatorname{LMod}_{2 n+2}$, $\operatorname{LMod}_{2 n+2}$ is generated by $h_{i}$ for $1 \leq i \leq 2 n, t_{1,2}$, and $r^{\prime}$.

Proof. Let $r^{\prime} \in \operatorname{LMod}_{2 n+2}$ be a parity-reversing element and $G$ a subgroup of $\operatorname{LMod}_{2 n+2}$ which is generated by $h_{i}$ for $1 \leq i \leq 2 n, t_{1,2}$, and $r^{\prime}$. Recall that we have the surjective homomorphism $\Psi: \operatorname{LMod}_{2 n+2} \rightarrow W_{2 n+2}$ by Lemma 2.1 and $\Psi\left(h_{i}\right)=(i i+2)$ for $1 \leq i \leq 2 n$. Since $S_{n+1}^{o} \times S_{n+1}^{e}$ is generated by $(i i+2)$ for $1 \leq$ $i \leq 2 n$ (for precise definition, see before Lemma 2.1), by the exact sequence (2.1), $W_{2 n+2}$ is generated by $\Psi\left(h_{i}\right)$ for $1 \leq i \leq 2 n$ and $\Psi\left(r^{\prime}\right)$. By Proposition 3.1 in 10, $\mathrm{PMod}_{0,2 n+2}$ is generated by $t_{i, j}$ for $1 \leq i<j \leq 2 n+1$ with $(i, j) \neq(1,2 n+1)$. Thus, by the exact sequence (2.2), $\operatorname{LMod}_{2 n+2}$ is generated by $h_{i}$ for $1 \leq i \leq 2 n, t_{i, j}$ for $1 \leq i<j \leq 2 n+1$ with $(i, j) \neq(1,2 n+1)$, and $r^{\prime}$. It is enough for completing the proof of Lemma 3.2 to prove that $t_{i, j} \in G$ for $(i, j) \neq(1,2)$.

By the relation (2) (a) of Theorem 5.3 in 10, we have the relation $h_{i} t_{i, i+1} h_{i}^{-1}=$ $t_{i+1, i+2}$ for $1 \leq i \leq 2 n$. Thus we have $t{ }_{t, i+1} \in G$ for $2 \leq i \leq 2 n$. By the relation (4) (a) of Theorem 5.3 in [10], we have the relations

$$
t_{i, j}=\left\{\begin{array}{l}
h_{i}^{2} \text { for } j-i=2, \\
t_{j-1, j}^{-\frac{j-i-3}{2}} \cdots t_{i+2}^{-\frac{j-i-3}{2}+3} t_{i, i+1}^{-\frac{j-i-3}{2}}\left(h_{j-2} \cdots h_{i+1} h_{i}\right)^{\frac{j-i+1}{2}} \\
\text { for } 2 n-1 \geq j-i \geq 3 \text { is odd } \\
t_{j-2, j-1}^{-\frac{j-2}{2}} \cdots t_{i+2, i+3}^{-\frac{j-i-2}{2}} t_{i, i+1}^{-\frac{j-i-2}{2}} h_{j-2} \cdots h_{i+2} h_{i} h_{i} h_{i+2} \cdots h_{j-2} \\
\cdot\left(h_{j-3} \cdots h_{i+1} h_{i}\right)^{\frac{j-i}{2}} \quad \text { for } 2 n \geq j-i \geq 4 \text { is even. }
\end{array}\right.
$$

Therefore, we have $t_{i, j} \in G$ for $j-i \geq 2$ and have completed the proof of Lemma 3.2,

Proof of Proposition 3.1 for $\operatorname{LMod}_{2 n+2}$. Let $G$ be a subgroup of $\operatorname{LMod}_{2 n+2}$ which is generated by $h_{1}, t_{1,2}$, and $r_{1}$. Since $r_{1}$ is a parity reversing element, by Lemma 3.2, $\operatorname{LMod}_{2 n+2}$ is generated by $h_{i}$ for $1 \leq i \leq 2 n, t_{1,2}$, and $r_{1}$. Hence it is enough for completing the proof of Proposition 3.1 to prove that $h_{i} \in G$ for $2 \leq i \leq 2 n$.

By the definition of $r_{1}$, we have $r_{1}\left(l_{i} \cup l_{i+1}\right)=l_{i+1} \cup l_{i+2}$ for $1 \leq i \leq 2 n-1$. Thus we have $r_{1} h_{i} r_{1}^{-1}=h_{i+1}$ for $1 \leq i \leq 2 n-1$ and $h_{i} \in G$ for $2 \leq i \leq 2 n$. Therefore we have completed the proof of Proposition 3.1 .
3.2. Proofs of the main theorem for $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$. In this section, we will prove Proposition 3.1 for $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$. By Corollary 5.4 in [10], we have the following lemma.

Lemma 3.3 (Corollary 5.4 in 10 ). For $n \geq 1, \operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$ are generated by $h_{1}, h_{2}, \ldots, h_{2 n-1}$, and $t_{1,2}$.

To prove Proposition 3.1 for $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$, we prepare the following lemma.

Lemma 3.4. For $n \geq 2$ and $1 \leq i \leq 2 n-3$, the relation

\left(h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}\right)^{-1} h_{i}\left(h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}\right)=h_{i+2}
$$

holds in $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$.
Proof. First, since we can check that $h_{i}^{-1} h_{i+1}^{-1} h_{i+2}^{-1}\left(l_{i} \cup l_{i+1}\right)=l_{i+2} \cup l_{i+3}$ for $1 \leq$ $i \leq 2 n-3$, we have $h_{i}^{-1} h_{i+1}^{-1} h_{i+2}^{-1} h_{i} h_{i+2} h_{i+1} h_{i}=h_{i+2}$ for $1 \leq i \leq 2 n-3$ (that is equivalent to the relation (2) (c) of Theorem 5.1 in [10]). Thus we have

$$

$$
\begin{array}{ll}
\mathrm{COMM} & t_{1,2}^{-1} h_{1}^{-1} h_{2}^{-1} \cdots h_{i-1}^{-1} \underline{h_{i}^{-1} h_{i+1}^{-1} h_{i+2}^{-1} \cdot h_{i} \cdot h_{i+2} h_{i+1} h_{i} h_{i-1} \cdots h_{2} h_{1} t_{1,2}} \\
= & t_{1,2}^{-1} h_{1}^{-1} h_{2}^{-1} \cdots h_{i-1}^{-1} \frac{h_{i+2} h_{i-1} \cdots h_{2} h_{1} t_{1,2}}{\leftarrow} \\
\text { COMM } & h_{i+2} .
\end{array}
$$

Therefore, we have completed the proof of Lemma 3.4.
Proof of Proposition 3.1 for $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$. Since Theorem 1.1 for $\operatorname{LMod}_{2 n+2, *}$ and $\operatorname{LMod}_{2 n+1}^{1}$ when $n=1$ is obtained from Lemma 3.3 we assume that $n \geq 2$. We will prove Proposition 3.1 for $\operatorname{LMod}_{2 n+2, *}$ (for the case of $\operatorname{LMod}_{2 n+1}^{1}$, we can prove by a similar argument below). Let $G$ be a subgroup of $\operatorname{LMod}_{2 n+2, *}$ which is generated by $h_{1}, h_{2}$, and $h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}$. By Lemma 3.3. $\operatorname{LMod}_{2 n+2, *}$ is generated by $h_{i}$ for $1 \leq i \leq 2 n-1$ and $t_{1,2}$. Hence it is enough for completing the proof of Proposition 3.1 for $\operatorname{LMod}_{2 n+2, *}$ to prove that $h_{i} \in G$ for $3 \leq i \leq 2 n$ and $t_{1,2} \in G$.

Since the relation $\left(h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}\right)^{-1} h_{i}\left(h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}\right)=h_{i+2}$ holds in $\operatorname{LMod}_{2 n+2, *}$ for $1 \leq i \leq 2 n-3$ by Lemma 3.4, we have $h_{i} \in G$ for $3 \leq i \leq 2 n-1$. Hence $h_{i}$ lies in $G$ for any $1 \leq i \leq 2 n-1$, we have

$$
t_{1,2}=h_{1}^{-1} h_{2}^{-1} \cdots h_{2 n-1}^{-1} \cdot\left(h_{2 n-1} \cdots h_{2} h_{1} t_{1,2}\right) \in G .
$$

Therefore we have completed the proof of Proposition 3.1

## 4. Small generating sets for balanced superelliptic mapping class

 GROUPSThroughout this section, we assume that $g=n(k-1)$ for $n \geq 1$ and $k \geq 3$. From Section 2.3, we recall that

- $\widetilde{t}_{i, i+1}=t_{\gamma_{i}^{1}} t_{\gamma_{i}^{2}} \cdots t_{\gamma_{i}^{k}}$ for $1 \leq i \leq 2 n+1$,
- $\widetilde{h}_{i}=t_{\gamma_{i}^{1}} t_{\gamma_{i+1}^{1}} t_{\gamma_{i}^{2}} t_{\gamma_{i+1}^{2}} \cdots t_{\gamma_{i}^{k-1}} t_{\gamma_{i+1}^{k-1}} t_{\gamma_{i}^{k}}$ for odd $1 \leq i \leq 2 n-1$,
- $\widetilde{h}_{i}=t_{\gamma_{i}^{k}} t_{\gamma_{i+1}^{k}} t_{\gamma_{i}^{k-1}} t_{\gamma_{i+1}^{k-1}} \cdots t_{\gamma_{i}^{2}} t_{\gamma_{i+1}^{2}} t_{\gamma_{i}^{1}}$ for even $2 \leq i \leq 2 n$ (see Figure 9),
- $\widetilde{r}_{1}=\widetilde{r}\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1} \cdots \widetilde{h}_{2 n-2}^{-1}\right)\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1} \cdots \widetilde{h}_{2 n-4}^{-1}\right) \cdots\left(\widetilde{h}_{1}^{-1} \widetilde{h}_{2}^{-1}\right) \widetilde{h}_{2 n-1}^{-1} \cdots \widetilde{h}_{3}^{-1} \breve{h}_{1}^{-1}$ $\widetilde{t}_{2 n, 2 n+1}^{n-1} \cdots \widetilde{t}_{6,7}^{2} \widetilde{t}_{4,5}$ for $n \geq 2$,
- $\widetilde{r}_{1}=\widetilde{r} \widetilde{h}_{1}^{-1}$ for $n=1$.

In this section, we will prove Theorem 1.2 by showing the following proposition.
Proposition 4.1. For $n \geq 2$ and $k \geq 3$ with $g=n(k-1)$,
(1) $\operatorname{SMod}_{g ; k}$ is generated by $\widetilde{h}_{1}, \widetilde{t}_{1,2}$, and $\widetilde{r}_{1}$,
(2) $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ are generated by $\widetilde{h}_{1}, \widetilde{h}_{2}$, and $\widetilde{h}_{2 n-1} \cdots \widetilde{h}_{2} \widetilde{h}_{1} \widetilde{t}_{1,2}$ when $n \geq 2$,
(3) $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ are generated by $\widetilde{h}_{1}$ and $\widetilde{t}_{1,2}$.

Let $\theta: \operatorname{SMod}_{g ; k} \rightarrow \operatorname{LMod}_{2 n+2}$ be the surjective homomorphism with the kernel $\langle\zeta\rangle$ which is obtained from the Birman-Hilden correspondence [2], namely $\theta$ is defined as follows: for $f \in \operatorname{SMod}_{g ; k}$ and a symmetric representative $\varphi \in f$ for $\zeta$, we define $\hat{\varphi}: \Sigma_{0} \rightarrow \Sigma_{0}$ by $\hat{\varphi}(x)=p(\varphi(\widetilde{x}))$ for some $\widetilde{x} \in p^{-1}(x)$. Then $\theta(f)=[\hat{\varphi}] \in \operatorname{LMod}_{2 n+2}$. As a similar construction, we have an isomorphism $\theta^{1}: \operatorname{SMod}_{g ; k}^{1} \rightarrow \operatorname{LMod}_{2 n+1}^{1}$ by Birman and Hilden 2].

Proof of Proposition 4.1 for $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$. When $n=1$, Proposition 4.1 for $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$ is obtained from Corollary 6.13 in 10. Assume that $n \geq 2$. Since $\widetilde{t}_{i, i+1}$ for $1 \leq i \leq 2 n+1$ and $\widetilde{h}_{i}$ for $1 \leq i \leq 2 n-1$ are lifts of $t_{i, i+1}$ and $h_{i}$ with respect to $p$ by Lemmas 2.3 and 2.4 respectively, Proposition 4.1
for $\operatorname{SMod}_{g ; k}^{1}$ is immediately obtained from Proposition 3.1 for $\operatorname{LMod}_{2 n+1}^{1}$ and the isomorphism $\theta^{1}$. The inclusion $\widetilde{\iota}: \Sigma_{g}^{1} \hookrightarrow \Sigma_{g}=\Sigma_{g}^{1} \cup \widetilde{D}$ induces the surjective homomorphism $\widetilde{\iota}_{*}: \operatorname{Mod}_{g}^{1} \rightarrow \operatorname{Mod}_{g, 1}$ by extending homeomorphisms by the identity map on $\widetilde{D}$. The homomorphism $\widetilde{\iota}_{*}$ is called the capping homomorphism. By Lemma 4.9 in 10, we have $\widetilde{\iota}_{*}\left(\operatorname{SMod}_{g ; k}^{1}\right)=\operatorname{SMod}_{g, * ; k}$. Since we have $\widetilde{\iota}_{*}\left(\widetilde{t}_{i, i+1}\right)=\widetilde{t}_{i, i+1}$ for $1 \leq i \leq 2 n+1$ and $\widetilde{\iota}_{*}\left(\widetilde{h}_{i}\right)=\widetilde{h}_{i}$ for $1 \leq i \leq 2 n-1$ by the definitions, $\operatorname{SMod}_{g, * ; k}$ is also generated by $\widetilde{h}_{1}, \widetilde{h}_{2}$, and $\widetilde{h}_{2 n-1} \cdots \widetilde{h}_{2} \widetilde{h}_{1} \widetilde{t}_{1,2}$. Therefore, we have completed the proof of Proposition 4.1 for $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$.

To prove Proposition 4.1 for $\mathrm{SMod}_{g ; k}$, we prepare the following lemmas.
Lemma 4.2. The relation

$$
\widetilde{r}_{1} \widetilde{t}_{i, i+1} \widetilde{r}_{1}^{-1}=\widetilde{t}_{i+1, i+2}
$$

for $1 \leq i \leq 2 n$ holds in $\operatorname{SMod}_{g ; k}$.
Proof. By the definition of $\widetilde{t}_{i, i+1}$ and conjugation relations, we have

$$
\widetilde{r}_{1} \widetilde{t}_{i, i+1} \widetilde{r}_{1}^{-1}=\widetilde{r}_{1} t_{\gamma_{i}^{1}} t_{\gamma_{i}^{2}} \cdots t_{\gamma_{i}^{k}} \widetilde{r}_{1}^{-1}=t_{\widetilde{r}_{1}\left(\gamma_{i}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i}^{2}\right)} \cdots t_{\widetilde{r}_{1}\left(\gamma_{i}^{k}\right)}
$$

for $1 \leq i \leq 2 n$. Since $\widetilde{r}_{1}$ is a lift of $r_{1}$ by Lemma 2.5 and $\gamma_{i}^{l}$ for $1 \leq l \leq k$ is a lift of $\gamma_{i, i+1}$ with respect to $p$, the simple closed curve $\widetilde{r}_{1}\left(\gamma_{i}^{l}\right)$ for $1 \leq$ $l \leq k$ is also a lift of $r_{1}\left(\gamma_{i, i+1}\right)=\gamma_{i+1, i+2}$ with respect to $p$. Hence we have $\left\{\widetilde{r}_{1}\left(\gamma_{i}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i}^{2}\right), \ldots, \widetilde{r}_{1}\left(\gamma_{i}^{k}\right)\right\}=\left\{\gamma_{i+1}^{1}, \gamma_{i+1}^{2}, \ldots, \gamma_{i+1}^{k}\right\}$ and

$$
t_{\widetilde{r}_{1}\left(\gamma_{i}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i}^{2}\right)} \cdots t_{\widetilde{r}_{1}\left(\gamma_{i}^{k}\right)}=t_{\gamma_{i+1}^{1}} t_{\gamma_{i+1}^{2}} \cdots t_{\gamma_{i+1}^{k}}=\widetilde{t}_{i+1, i+2}
$$

in $\mathrm{SMod}_{g ; k}$. Therefore, we have completed the proof of Lemma 4.2.
Lemma 4.3. The relation

\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}=\widetilde{h}_{i+1}
$$

for $1 \leq i \leq 2 n-1$ holds in $\operatorname{SMod}_{g ; k}$.
Proof. When $n=1$, we have

\widetilde{r}_{1}\left(\gamma_{1}^{l}\right) & =\widetilde{r} \widetilde{h}_{1}^{-1}\left(\gamma_{1}^{l}\right)=\widetilde{r}\left(t_{\gamma_{1}^{k}}^{-1} t_{\gamma_{2}^{k-1}}^{-1} t_{\gamma_{1}^{k-1}}^{-1} \cdots t_{\gamma_{2}^{2}}^{-1} t_{\gamma_{1}^{2}}^{-1} t_{\gamma_{2}^{1}}^{-1} t_{\gamma_{1}^{1}}^{-1}\left(\gamma_{1}^{l}\right)\right) \\
& =\widetilde{r}\left(\gamma_{2}^{l-1}\right)=\gamma_{2}^{k-l+1}
\end{aligned}
$$

for $2 \leq l \leq k$. Similarly, when $n=1$, we have $\widetilde{r}_{1}\left(\gamma_{1}^{1}\right)=\gamma_{2}^{k}$ and $\widetilde{r}_{1}\left(\gamma_{2}^{l}\right)=\gamma_{3}^{k-l-1}$ for $1 \leq l \leq k$. Thus, we have

\widetilde{r}_{1} \widetilde{h}_{1} \widetilde{r}_{1}^{-1} & =\widetilde{r}_{1} t_{\gamma_{1}^{1}} t_{\gamma_{2}^{1}} t_{\gamma_{1}^{2}} t_{\gamma_{2}^{2}} \cdots t_{\gamma_{1}^{k-1}} t_{\gamma_{2}^{k-1}} t_{\gamma_{1}^{k}} \widetilde{r}_{1}^{-1} \\
& =t_{\widetilde{r}_{1}\left(\gamma_{1}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{2}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{1}^{2}\right)} t_{\widetilde{r}_{1}\left(\gamma_{2}^{2}\right)} \cdots t_{\widetilde{r}_{1}\left(\gamma_{1}^{k-1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{2}^{k-1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{1}^{k}\right)} \\
& =t_{\gamma_{2}^{k}} t_{\gamma_{3}^{k}} t_{\gamma_{2}^{k-1}} t_{\gamma_{3}^{k-1}} \cdots t_{\gamma_{2}^{2}} t_{\gamma_{3}^{2}} t_{\gamma_{2}^{1}} \\
& =\widetilde{h}_{2} .
\end{aligned}
$$

Thus Lemma 4.3 holds for $n=1$.
Assume that $n \geq 2$ and $1 \leq i \leq 2 n+1$ is odd. Then, we have $\widetilde{h}_{i}=t_{\gamma_{i}^{1}} t_{\gamma_{i+1}^{1}} t_{\gamma_{i}^{2}} t_{\gamma_{i+1}^{2}} \cdots t_{\gamma_{i}^{k-1}} t_{\gamma_{i+1}^{k-1}} t_{\gamma_{i}^{k}}$. A collection $\left(c_{1}, c_{2}, \ldots, c_{m}\right)$ of simple closed curves $c_{1}, c_{2}, \ldots, c_{m}$ on $\Sigma_{g}$ is a m-chain on $\Sigma_{g}$ if $c_{i}$ transversely intersects with $c_{i+1}$ at one point for $1 \leq i \leq m-1$ and $c_{i}$ is disjoint from $c_{j}$ for $j \notin\{i-1, i, i+1\}$. Since $\widetilde{r}_{1}$ is a homeomorphism and $\left(\gamma_{i}^{1}, \gamma_{i+1}^{1}, \gamma_{i}^{2}, \gamma_{i+1}^{2}, \cdots \gamma_{i}^{k-1}, \gamma_{i+1}^{k-1}, \gamma_{i}^{k}\right)$ is a $(2 k-1)$-chain on $\Sigma_{g}$, the collection $\left(\widetilde{r}_{1}\left(\gamma_{i}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i}^{2}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{2}\right), \cdots \widetilde{r}_{1}\left(\gamma_{i}^{k-1}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{k-1}\right), \quad \widetilde{r}_{1}\left(\gamma_{i}^{k}\right)\right)$ is also a $(2 k-1)$-chain on $\Sigma_{g}$. Put $\mathcal{C}_{i}=\left\{\gamma_{i}^{1}, \gamma_{i}^{2}, \ldots, \gamma_{i}^{k}\right\}$ for $1 \leq i \leq 2 n+1 . \quad$ Since $\left\{\widetilde{r}_{1}\left(\gamma_{i}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i}^{2}\right), \ldots, \widetilde{r}_{1}\left(\gamma_{i}^{k}\right)\right\}=\mathcal{C}_{i+1}$ for
$1 \leq i \leq 2 n$ by an argument in the proof of Lemma 4.2, we have $\left(\widetilde{r}_{1}\left(\gamma_{i}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{1}\right), \widetilde{r}_{1}\left(\gamma_{i}^{2}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{2}\right), \cdots \widetilde{r}_{1}\left(\gamma_{i}^{k-1}\right), \widetilde{r}_{1}\left(\gamma_{i+1}^{k-1}\right), \widetilde{r}_{1}\left(\gamma_{i}^{k}\right)\right) \in \mathcal{C}_{i+1} \times \mathcal{C}_{i+2} \times$ $\mathcal{C}_{i+1} \times \mathcal{C}_{i+2} \times \cdots \times \mathcal{C}_{i+1} \times \mathcal{C}_{i+2} \times \mathcal{C}_{i+1}$.

Since $\widetilde{h}_{i}$ and $\widetilde{r}_{1}$ have symmetric representative for $\zeta$, the product

\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}=t_{\widetilde{r}_{1}\left(\gamma_{i}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i+1}^{1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i}^{2}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i+1}^{2}\right)} \cdots t_{\widetilde{r}_{1}\left(\gamma_{i}^{k-1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i+1}^{k-1}\right)} t_{\widetilde{r}_{1}\left(\gamma_{i}^{k}\right)}
$$

also has a symmetric representative for $\zeta$, namely, there exists an integer $1 \leq$ $l^{\prime} \leq k-1$ such that $\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right) \zeta\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right)^{-1}=\zeta^{l^{\prime}}$ in $\operatorname{SMod}_{g ; k}$. Since $n \geq 2$, for $1 \leq l \leq k$, we have $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\left(\gamma_{1}^{l}\right)=\gamma_{1}^{l}$ or $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\left(\gamma_{2 n+1}^{l}\right)=\gamma_{2 n_{n+1}^{l}}^{l}$ with orientations. Hence, for $1 \leq l \leq k$, we also have $\zeta^{l^{\prime}}\left(\gamma_{1}^{l}\right)=\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right) \zeta\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right)^{-1}\left(\gamma_{1}^{l}\right)=\zeta\left(\gamma_{1}^{l}\right)$ or $\zeta^{l^{\prime}}\left(\gamma_{2 n+1}^{l}\right)=\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right) \zeta\left(\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}\right)^{-1}\left(\gamma_{2 n+1}^{l}\right)=\zeta\left(\gamma_{2 n+1}^{l}\right)$ with orientations. Thus, $l^{\prime}=1$ and $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}$ commutes with $\zeta$.

If $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}=t_{\gamma_{i+1}^{\prime}} t_{\gamma_{i+2}^{l^{\prime}+1}} t_{\gamma_{i+1}^{\prime \prime+1}} \cdots t_{\gamma_{i+2}^{\prime^{\prime}+k-2}} t_{\gamma_{i+1}^{\prime^{\prime}+k-2}} t_{\gamma_{i+2}^{\prime^{\prime}+k-1}} t_{\gamma_{i+1}^{\prime^{\prime}+k-1}}$ for $1 \leq i \leq 2 n-1$ and some $1 \leq l^{\prime} \leq k$, where we consider the indices $l^{\prime}, l^{\prime}+1, \ldots, l^{\prime}+k-1$ $\bmod k$, then $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}$ does not commute with $\zeta$. In fact, it is necessarily for the coincidence of $\zeta t_{\gamma_{i+1}^{\prime^{\prime}}} t_{\gamma_{i+2}^{\prime^{\prime}+1}} t_{\gamma_{i+1}^{l^{\prime}+1}} \cdots t_{\gamma_{i+2}^{\prime \prime+k-2}} t_{\gamma_{i+1}^{\prime \prime+k-2}} t_{\gamma_{i+2}^{\prime \prime+k-1}} t_{\gamma_{i+1}^{\prime \prime+k-1}} \zeta^{-1}=$ $t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{\prime^{\prime}+2}} t_{\gamma_{i+1}^{l^{\prime}+2}} \cdots t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-1}} t_{\gamma_{i+2}^{l^{\prime}+k}} t_{\gamma_{i+1}^{l^{\prime}+k}}$ and $t_{\gamma_{i+1}^{l^{\prime}}} t_{\gamma_{i+2}^{l^{\prime}+1}} t_{\gamma_{i+1}^{l^{\prime}+1}} \cdots t_{\gamma_{i+2}^{l^{\prime}+k-2}} t_{\gamma_{i+1}^{l^{\prime}+k-2}} t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-1}}$ to hold the relation

$$
\begin{aligned}
& \left(t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime}+2}} t_{\gamma_{i+1}^{l^{\prime}+2}} \cdots t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-1}}\right) t_{\gamma_{i+2}^{l^{\prime}+k}} t_{\gamma_{i+1}^{l^{\prime}+k}}\left(t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime}+2}} t_{\gamma_{i+1}^{l^{\prime}+2}} \cdots t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-1}}\right)^{-1} \\
& =t_{\gamma_{i+1}^{l^{\prime}}} t_{\gamma_{i+2}^{l^{\prime}+1}}
\end{aligned}
$$

in $\operatorname{SMod}_{g ; k}$. However, this relation does not hold in $\operatorname{SMod}_{g ; k}$. Thus, we have $\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1}=t_{\gamma_{i+1}^{l^{\prime}+k-1}} t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-2}} t_{\gamma_{i+2}^{l^{\prime}+k-2}} \cdots t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime}+1}} t_{\gamma_{i+1}^{l^{\prime}}}$ for some $1 \leq l^{\prime} \leq k$, where we consider the indices $l^{\prime}, l^{\prime}+1, \ldots, l^{\prime}+k-1 \bmod k$. Since we have the relation

$$
\begin{aligned}
& \left(t_{\gamma_{i+1}^{l^{\prime}+k-2}} t_{\gamma_{i+2}^{l^{\prime}+k-2}} \cdots t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime+1}}} t_{\gamma_{i+1}^{l^{\prime}}}\right)^{-1} t_{\gamma_{i+1}^{l^{\prime}+k-1}} t_{\gamma_{i+2}^{l^{\prime}+k-1}}\left(t_{\gamma_{i+1}^{l^{\prime}+k-2}} t_{\gamma_{i+2}^{l^{\prime}+k-2}} \cdots t_{\gamma_{i+1}^{l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime}+1}} t_{\gamma_{i+1}^{l^{\prime}}}\right) \\
& =t_{\gamma_{i+2}^{l^{\prime}}} t_{\gamma_{i+1}^{l^{\prime}-1}}
\end{aligned}
$$

in $\operatorname{SMod}_{g ; k}$, by using this relation inductively, we have

$$
\begin{aligned}
\widetilde{r}_{1} \widetilde{h}_{i} \widetilde{r}_{1}^{-1} & =t_{\gamma_{i+1}^{l^{\prime}+k-1}} t_{\gamma_{i+2}^{l^{\prime}+k-1}} t_{\gamma_{i+1}^{l^{\prime}+k-2}} t_{\gamma_{i+2}^{l^{\prime}+k-2}} \cdots t_{\gamma_{i+1}^{\prime l^{\prime}+1}} t_{\gamma_{i+2}^{l^{\prime}+1}} t_{\gamma_{i+1}^{l^{\prime}}} \\
& =t_{\gamma_{i+1}^{k}} t_{\gamma_{i+2}^{k}} t_{\gamma_{i+1}^{k-1}} t_{\gamma_{i+2}^{k-1}} \cdots t_{\gamma_{i+1}^{2}} t_{\gamma_{i+2}^{2}} t_{\gamma_{i+1}^{1}} \\
& =\widetilde{h}_{i+1} .
\end{aligned}
$$

Thus the relation in Lemma 4.3 for odd $1 \leq i \leq 2 n-1$ holds in $\operatorname{SMod}_{g ; k}$. By an argument similar to the odd $i$ and $n \geq 2$ case, we can show that the relation in Lemma 4.3 for even $2 \leq i \leq 2 n-2$ and $n \geq 2$ also holds in $\operatorname{SMod}_{g ; k}$. Therefore we have completed the proof of Lemma 4.3 .

By Lemma 4.6 in [10], the forgetful homomorphism $\mathcal{F}: \operatorname{SMod}_{g, * ; k} \rightarrow \operatorname{SMod}_{g ; k}$ which is defined by the correspondence $[\varphi] \mapsto[\varphi]$ is injective. Hence we regard $\operatorname{SMod}_{g, * ; k}$ as a subgroup of $\operatorname{SMod}_{g ; k}$. Recall that we have the surjective homomorphism $\widetilde{\iota}_{*}: \operatorname{SMod}_{g ; k}^{1} \rightarrow \operatorname{SMod}_{g, * ; k}$ defined in the proof of Proposition 4.1 for $\operatorname{SMod}_{g, * ; k}$ and $\operatorname{SMod}_{g ; k}^{1}$.

Proof of Proposition 4.1 for $\operatorname{SMod}_{g ; k}$. From the Birman-Hilden correspondence 2], we have the following exact sequence:

$$
1 \longrightarrow\langle\zeta\rangle \longrightarrow \operatorname{SMod}_{g ; k} \xrightarrow{\theta} \operatorname{LMod}_{2 n+2} \longrightarrow 1
$$

Since $\operatorname{LMod}_{2 n+2}$ is generated by $h_{1}, t_{1,2}$, and $r_{1}$ for $n \geq 1$ by Proposition 3.1 and $\widetilde{h}_{1}, \widetilde{t}_{1,2}$, and $\widetilde{r}_{1}$ are lifts of $h_{1}, t_{1,2}$, and $r_{1}$ with respect to $p$ by Lemmas 2.3, 2.4 and 2.5. respectively, $\operatorname{SMod}_{g ; k}$ is generated by $\widetilde{h}_{1}, \widetilde{t}_{1,2}, \widetilde{r}_{1}$, and $\zeta$ by the exact sequence above. It is enough for completing the proof of Proposition 4.1 to prove that $\zeta$ is a product of $\widetilde{h}_{1}, \widetilde{t}_{1,2}$, and $\widetilde{r}_{1}$.

Let $\zeta^{\prime}$ be a self-homeomorphism on $\Sigma_{g}$ which is described as a result of a $\left(-\frac{2 \pi}{k}\right)$ rotation of $\Sigma_{g}^{1} \subset \Sigma_{g}$ fixing the disk $\widetilde{D}$ pointwise (for instance, in the case of $k=3$, $\zeta^{\prime}$ is a $\left(-\frac{2 \pi}{3}\right)$-rotation as on the top in Figure 11). Since the restriction of $\zeta^{\prime}$ to $\widetilde{D}$ is identity, we regard $\zeta^{\prime}$ as an element in $\operatorname{SMod}_{g ; k}^{1}$. The isotopy class of a selfhomeomorphism on $\Sigma_{0}$ (resp. $\Sigma_{g}$ ) relative to $D \cup \mathcal{B}$ (resp. $\widetilde{D}$ ) is determined by the isotopy class of the image of $L$ (resp. $\left.\widetilde{L}=p^{-1}(L)\right)$ relative to $D \cup \mathcal{B}$ (resp. $\widetilde{D}$ ). Since we can show that $p\left(\zeta^{\prime}(\widetilde{L})\right)$ is isotopic to $t_{\partial D}(L)$ relative to $D \cup \mathcal{B}$ (in the case $k=3$, see Figure 11), $\zeta^{\prime}$ is a lift of $t_{\partial D}=t_{1,2 n+1}$ with respect to $p$.

By the relations (4) (a) of Theorems 5.1 and 6.10 in [10], we have

$$
t_{1,2 n+1}=t_{2 n-1,2 n}^{-n+1} \cdots t_{3,4}^{-n+1} t_{1,2}^{-n+1} h_{2 n-1} \cdots h_{3} h_{1} h_{1} h_{3} \cdots h_{2 n-1}\left(h_{2 n-2} \cdots h_{2} h_{1}\right)^{n}
$$

in $\operatorname{LMod}_{2 n+1}^{1}$ and its lift

$$
\zeta^{\prime}=\widetilde{t}_{2 n-1,2 n}^{-n+1} \cdots \widetilde{t}_{3,4}^{-n+1} \widetilde{t}_{1,2}^{-n+1} \widetilde{h}_{2 n-1} \cdots \widetilde{h}_{3} \widetilde{h}_{1} \widetilde{h}_{1} \widetilde{h}_{3} \cdots \widetilde{h}_{2 n-1}\left(\widetilde{h}_{2 n-2} \cdots \widetilde{h}_{2} \widetilde{h}_{1}\right)^{n}
$$

in $\operatorname{SMod}_{g ; k}^{1}$. By the definition of $\zeta^{\prime}$, we have $\widetilde{\iota}_{*}\left(\zeta^{\prime}\right)=\zeta$ clearly. Thus we have

$$
\zeta=\widetilde{t}_{2 n-1,2 n}^{-n+1} \cdots \widetilde{t}_{3,4}^{-n+1} \widetilde{t}_{1,2}^{-n+1} \widetilde{h}_{2 n-1} \cdots \widetilde{h}_{3} \widetilde{h}_{1} \widetilde{h}_{1} \widetilde{h}_{3} \cdots \widetilde{h}_{2 n-1}\left(\widetilde{h}_{2 n-2} \cdots \widetilde{h}_{2} \widetilde{h}_{1}\right)^{n}
$$

in $\operatorname{SMod}_{g ; k}$. By Lemmas 4.2 and 4.2 , we have the relations $\widetilde{h}_{i}=\widetilde{r}_{1}^{i-1} \widetilde{h}_{1} \widetilde{r}_{1}^{-(i-1)}$ for $2 \leq i \leq 2 n-1$ and $\widetilde{t}_{i, i+1}=\widetilde{r}_{1}^{i-1} \widetilde{t}_{1,2} \widetilde{r}_{1}^{(i-1)}$ for $2 \leq i \leq 2 n-1$. Therefore $\zeta$ is a product of $\widetilde{h}_{1}, \widetilde{t}_{1,2}$, and $\widetilde{r}_{1}$ and we have completed the proof of Proposition 4.1.
