# Average order in wreath products

#### Abstract

We obtain an exact formula for the average order of elements of a wreath product of two finite groups. Then focussing our attention on $p$-groups for primes $p$, we give an estimate for the average order of a wreath product $A$ l $B$ in terms of maximum order of elements of $A$ and average order of $B$ and an exact formula for the distribution of orders of elements of $A$ 亿 $B$. Finally, we show how wreath products can be used to find several rational numbers which are limits of average orders of a sequence of $p$-groups with cardinalities going to infinity.

## 1 Introduction

For a finite group $G$, define the average order of elements to be $a(G)=\frac{\sum_{g \in G} \text { order }(g)}{|G|}$ and denote the maximum order of an element of $G$ by $m(G)$. It is well known that among all groups of a fixed cardinality, the cyclic group has the largest average order (see [1, [2]). Other authors have studied the average order function with a view to deriving characterization theorems for nilpotency and solvability (see [4, [5).

Wreath products of groups often provide examples and counter-examples for various group theoretic questions. The famous Krasner-Kaloujnine embedding theorem shows that for any two groups $A$ and $H$, any extension of $A$ by $H$ is isomorphic to a subgroup of the wreath product $A$ l $H$ (see [3).

In this article, we obtain an exact formula for the average order of a wreath product of two finite groups. Following that, we focus our attention on $p$-groups for primes $p$. We give an estimate for the average order of a wreath product $A \imath B$ in terms of $m(A)$ and $a(B)$. In addition, we obtain an exact formula for the distribution of orders of elements of $A \backslash B$, in terms of distributions of orders of elements of $A$ and $B$. Finally, we show how wreath products can be used to find several rational numbers which are limits of average orders of a sequence of $p$-groups with cardinalities going to infinity.

## 2 Notations and Conventions

1. Given two groups $A$ and $B$, let $K=\prod_{b \in B} A$. The group $B$ naturally acts on $K$ by $x \cdot\left(\alpha_{b}\right)_{b}=\left(\alpha_{x^{-1} b}\right)_{b}$, for $x \in B,\left(\alpha_{b}\right)_{b} \in K$. The semidirect product $K \rtimes B$ is called the wreath product of $A$ by $B$ and is denoted by $A \imath B$.
2. $\mu: \mathbf{N} \rightarrow \mathbf{Z}$ denotes the Mobius function. Recall that if $n$ is square-free, $\mu(n)=(-1)^{m}$, where $m$ is the number of distinct prime divisors of $n$. If $n$ is not square-free, $\mu(n)=0$.
3. For a natural number $n$, define $\tau(n)=\prod_{p \mid n, p \text { prime }}(1-p)$. It is easy to see that $\tau(n)=\sum_{d \mid n} d \mu(d)$.
4. For real valued functions $f$ and $g$ we adopt the notation $g=O(f)$ to mean that there is a constant $M>0$ such that $|g| \leq M|f|$ always.
5. Define $\psi(A, B)=\frac{a(A \imath B)}{m(A) \cdot a(B)}$, for $p$-groups $A$ and $B$.
6. Let $A$ be a $p$-group of cardinality $p^{a}$ and $m(A)=p^{d}$. For $k \in \mathbf{Z}$ define $r_{A, k}=\frac{1}{p^{a}} \times$ Number of elements of order at most $p^{d-k}$.
This essentially denotes the cumulative distribution function of the order distribution. So, $r_{A, k}$ is a non-increasing function of $k$, and $r_{A, k}=1$ for $k \leq 0, r_{A, k}=0$ for $k>d$.
7. Fix a prime $p$. Let us call a real number $\beta$ an "Average Order Limit" if there is a sequence of $p$-groups $G_{n}$ with $\left|G_{n}\right| \rightarrow \infty$ and $a\left(G_{n}\right) \rightarrow \beta$.

## 3 Main Results

Theorem 1 Let $A, B$ be finite groups with at least 2 elements. For $m \geq 1$, let $s_{m}$ be the number of elements of $A$ whose $m$-th power is 1 . For $n \mid b$, let $d_{n}$ be the number of elements of $B$ of order $n$. Then

Let $p$ be a prime. From now on, assume $A, B$ are $p$-groups, $|A|=p^{a}$, $|B|=p^{b}, a, b \geq 1$.

Theorem 2 With notations as in theorem 1,

a(A 乙 B)=p^{d} a(B)-(p-1) a(B) \sum_{n \leq b} k_{n} \cdot\left[\sum_{m \leq d-1} p^{m}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}}\right]
$$

where $k_{n}=\frac{p^{-n} d_{p^{b-n}}}{a(B)}$. Note that $k_{n} \geq 0 \forall n, \sum_{n \leq b} k_{n}=1$.
Theorem $3 a(B) \leq a(A \backslash B) \leq p^{d} a(B)$.

Note that Theorem 3 implies that $0 \leq \psi(A, B) \leq 1$ ．
Theorem 4 With notations as in theorem 1，

a(A 乙 B)=p^{d} a(B)-(p-1) a(B) \cdot \sum_{n \leq b} k_{n} \cdot\left[p^{d-1}\left(\frac{s_{p^{d-1}}}{p^{a}}\right)^{p^{n}}\right]+O\left(p^{d-1} a(B)\right)
$$

Here，the implicit constant in $O\left(p^{d-1} a(B)\right)$ is independent of $p$ as well as of the groups．Now，we explicitly write the order distribution of $A$ 亿 $B$ in terms of the order distributions of $A$ and $B$ ．

Theorem 5 Let $m(A)=p^{d}, m(B)=p^{e}$ ．Then we have $m(A \backslash B)=p^{d+e}$ ，and $r_{A \backslash B, k}=\sum_{i=0}^{e}\left(r_{B, i}-r_{B, i+1}\right) r_{A, k-i}^{p^{b-e+i}}$.

Corollary $1 r_{A \zeta \mathbf{Z} / p \mathbf{Z}, k}=\left(1-p^{-1}\right) r_{A, k}+\frac{r_{A, k-1}^{p}}{p}$ ．
In view of theorem 4 ，it is natural to ask whether $a(A 乙 B)=p^{d} a(B)+$ $O\left(p^{d-1} a(B)\right)$ ，i．e．，whether＂$\psi(A, B)=1+O\left(\frac{1}{p}\right)$＂．We shall show that this is not true in general．However，if we assume $A$ is abelian，then it is true．

Corollary 2 Let $A$ be a p－group．Define p－groups $A_{n}$ recursively by $A_{0}=A$ ， $A_{n}=A_{n-1} \backslash \mathbf{Z} / p \mathbf{Z}$ ．Let $B$ be a p－group．Then $\psi\left(A_{n}, B\right) \rightarrow 0$ as $n \rightarrow \infty$ ．

Note that corollary 5.2 shows that＂$\psi(A, B)=1+O\left(\frac{1}{p}\right)$＂cannot be true in general．Now we show how the situation differs if we assume $A$ to be abelian．

Theorem 6 For abelian p－groups $A$ ，define $t(A)$ to be the unique positive in－ teger such that $A \cong \mathbf{Z} / p^{d_{1}} \mathbf{Z} \oplus \mathbf{Z} / p^{d_{2}} \mathbf{Z} \oplus \ldots \oplus \mathbf{Z} / p^{d_{k}} \mathbf{Z} \oplus\left(\mathbf{Z} / p^{d} \mathbf{Z}\right)^{t(A)}$ ，where $d_{1} \leq d_{2} \leq \cdots \leq d_{k}<d$ ．Then，
（i）For each noncyclic group $B, 1-p^{-t(A) p} \leq \psi(A, B) \leq 1$ ．
（ii）For cyclic groups $B, \psi(A, B)=1-p^{-t(\bar{A})}+O\left(p^{-t(A)-1}\right)$ ．
In particular，$\psi(A, B)=1+O\left(\frac{1}{p}\right)$ holds if $A$ is abelian．
Now we prove a result about limiting value of average orders for a sequence of groups whose sizes goes to infinity．

Theorem 7 Suppose $B_{n}$ is a sequence of p－groups with $a\left(B_{n}\right) \rightarrow \beta$ ．Then $a\left((\mathbf{Z} / p \mathbf{Z})^{n} \backslash B_{n}\right) \rightarrow p \beta$ ．So，if $\beta$ is an Average Order Limit，then $p \beta$ is also． Hence $p^{r} \beta$ is an Average Order Limit for each nonnegative integer $r$ ．

Note that whatever the sizes of $B_{n}$ be，sizes of $(\mathbf{Z} / p \mathbf{Z})^{n}\left\langle B_{n}\right.$ always go to infinity． So，taking $\left\{B_{n}\right\}_{n}$ to be a constant sequence $B$ ，we see that $p^{r} a(B)$ is an Average Order Limit，for any $r \geq 2$ ．This guarantees the existence of many non－integral Average Order Limits．For example，taking $B=(\mathbf{Z} / p \mathbf{Z})^{b}$ and $2 \leq r \leq b-1$ ，we get $p^{r+b+1}-\frac{p-1}{p^{b-r}}$ as an Average Order Limit．
Corollary 3 Given any p－group $B$ ，and integer $r \geq 2$ ，there are sequences $G_{n}$ ， $H_{n}$ of $p$－groups with $\left|G_{n}\right| \rightarrow \infty,\left|H_{n}\right| \rightarrow \infty$ and $a\left(G_{n} \backslash H_{n}\right) \rightarrow p^{r} a(B)$ ．

## 4 Proofs of the Theorems

We start with two preliminary lemmas.
Lemma 1 For any semidirect product $H \rtimes K$, we have $a(H \rtimes K) \geq a(K)$. Also, for $(h, k) \in H \rtimes K$, we have order $(k) \mid \operatorname{order}((h, k))$.

Proof. For any $(h, k) \in H \rtimes K,(h, k)^{m}$ has $k^{m}$ as 2nd coordinate. So, $(h, k)^{m}=$ $1 \Longrightarrow k^{m}=1$. So, order $(k) \mid \operatorname{order}((h, k))$, in particular $\operatorname{order}((h, k)) \geq$ $\operatorname{order}(k)$, for all $h \in H$. So, $\mathrm{a}(H \rtimes K) \geq \frac{|H|}{|H| \cdot|K|} \sum_{k \in K} \operatorname{order}(k)=\frac{1}{|K|} \sum_{k \in K} \operatorname{order}(k)=$ $a(K)$.

Lemma 2 Let $p$ be a prime and $b \geq 1$ an integer. Then $a\left(\mathbf{Z} / p^{b} \mathbf{Z}\right)=p^{b}+$ $O\left(p^{b-1}\right)$.

Proof. In $\mathbf{Z} / p^{b} \mathbf{Z}$, there are exactly $\phi\left(p^{n}\right)=p^{n}\left(1-p^{-1}\right)$ elements of order $p^{n}$, for each $1 \leq n \leq b$. So,

a\left(\mathbf{Z} / p^{b} \mathbf{Z}\right)= & \frac{1+\sum_{n=1}^{b} p^{n} \cdot p^{n} \cdot\left(1-p^{-1}\right)}{p^{b}}=\frac{1+p(p-1) \sum_{n=0}^{b-1} p^{2 n}}{p^{b}} \\
& =\frac{1+\left(p^{2}-p\right) \frac{p^{2 b}-1}{p^{2}-1}}{p^{b}}=\frac{1+\frac{p}{p+1}\left(p^{2 b}-1\right)}{p^{b}} \\
& =p^{-b}+\frac{p}{p+1}\left(p^{b}-p^{-b}\right)=p^{b}+O\left(p^{b-1}\right) .
\end{aligned}
$$

Let us recall some standard facts before starting the proof of theorem 1. For groups $H, K$, and injective group homomorphism $\phi: K \rightarrow \operatorname{Aut}(H)$, we have an injective group homomorphism $\psi: H \rtimes_{\phi} K \rightarrow \operatorname{Perm}(H)$ defined by $\psi(h, k)(x)=h \phi(k)(x)$. So, $H \rtimes_{\phi} K$ can be regarded as a subgroup of $\operatorname{Perm}(H)$ consisting of the transformations $T_{h, k}$ defined by $T_{h, k}(x)=h \phi(k)(x)$.

So, if $A$ and $B$ has at least 2 elements, $A \imath B$ is the subgroup of Perm $\left(\prod_{b \in B} A\right)$, consisting of the permutations $T_{\underline{\alpha}, x}, \underline{\alpha} \in \prod_{b \in B} A, x \in B$, where $T_{\underline{\alpha}, x}(\underline{a})=$ $\left(\alpha_{b} a_{x^{-1} b}\right)_{b},\left(\underline{a}=\left(a_{b}\right)_{b}\right)$.

Proof of Theorem 1. Note that lemma 1 yields order $(x) \mid \operatorname{order}\left(T_{\underline{\alpha}, x}\right)$ for all $(\underline{\alpha}, x) \in A$ 亿 $B$. Fix $x \in B$. Let $d=\operatorname{order}(x)$. For $m \geq 1$, we have $T_{\underline{\alpha}, x^{-1}}^{m}(\underline{a})=$ $\left(\alpha_{b} \alpha_{x b} . . \alpha_{x^{m-1} b} a_{x^{m} b}\right)_{b}$.

So,

T_{\underline{\alpha}, x^{-1}}^{d m}=1 \Longleftrightarrow \alpha_{b} \alpha_{x b} . . \alpha_{x^{d m-1} b}=1 \quad \forall b \in B \\
\quad \Longleftrightarrow\left(\alpha_{b} \alpha_{x b} . . \alpha_{x^{d-1} b}\right)^{m}=1 \quad \forall b \in B .
\end{gathered}
$$

Name this condition (1).
Multiplication by $x$ divides $B$ into $\frac{|B|}{d}$ orbits of size $d$, and (1) is equivalent to saying that product of $\alpha_{b}$ 's, for $b$ running in each orbit in cyclic order, has $m$ 'th power $=1$.

Number of $\underline{\alpha} \in \prod_{b \in B} A$ satisfying (1) is exactly $\left(|A|^{d-1} s_{m}\right)^{\frac{|B|}{d}}$. The reason is as follows. Fix a point $p$ in a orbit. For each $b \neq p$ in that orbit, $\alpha_{b}$ can be chosen to be anything in $A$. After that $\alpha_{p}$ has exactly $s_{m}$ choices. Altogether we get $\alpha_{b}$ 's for $b$ running over a fixed orbit has exactly $|A|^{d-1} s_{m}$ choices. There are $\frac{|B|}{d}$ orbits. So in total we have $\left(|A|^{d-1} s_{m}\right)^{\frac{|B|}{d}}$ choices for $\underline{\alpha}$.

From (1), it is clear that $T_{\underline{\alpha}, x^{-1}}^{d|A|}=1$. So, $\frac{\operatorname{order}\left(T_{\underline{\alpha}, x-1}\right)}{d}||A|$
For $m \geq 1$, let $g_{m}=$ number of $\underline{\alpha} \in \prod_{b \in B} A$ with $\operatorname{order}\left(T_{\underline{\alpha}, x^{-1}}\right)=d m$. We have just shown that unless $m\left||A|\right.$, we have $g_{m}=0$. Also, for all $k \geq 1$, $\sum_{m \mid k} g_{m}=$ number of $\underline{\alpha}$ with $\left(T_{\underline{\alpha}, x^{-1}}\right)^{d k}=1=\left(|A|^{d-1} s_{k}\right)^{\frac{|B|}{d}}$.

By Mobius inversion, $g_{m}=|A|^{\frac{|B|(d-1)}{d}} \sum_{n \mid m} \mu\left(\frac{m}{n}\right) s_{n}^{\frac{|B|}{d}}$ for all $m \geq 1$. So,
$\sum_{\underline{\alpha} \in \prod_{b \in B} A} \operatorname{order}\left(T_{\underline{\alpha}, x^{-1}}\right)$
$=\sum_{m| | A \mid} d m g_{m}=d|A|^{\frac{|B|(d-1)}{d}} \sum_{m| | A|, n| m} m \mu\left(\frac{m}{n}\right) s_{n}^{\frac{|B|}{d}}$
$=d|A|^{\frac{|B|(d-1)}{d}} \sum_{n| | A|, c| \frac{|A|}{n}} n c \mu(c) s_{n}^{\frac{|B|}{d}}(m=n c)$
$=d|A|^{\frac{|B|(d-1)}{d}} \sum_{m| | A|, c| \frac{|A|}{m}} m c \mu(c) s_{m}^{\frac{|B|}{d}}$ (rename $n$ by $m$ )
$=d|A|^{\frac{|B|(d-1)}{d}} \sum_{m| | A \mid} m s_{m}^{\frac{|B|}{d}}\left[\sum_{c \left\lvert\, \frac{|A|}{m}\right.} c \mu(c)\right]$
$=d|A|^{\frac{|B|(d-1)}{d}} \sum_{m| | A \mid} m s s_{m}^{\frac{|B|}{d}} \tau\left(\frac{|A|}{m}\right)$
$=|A|^{|B|} d|A|^{-\frac{|B|}{d}} \sum_{m| | A \mid} m s s_{m}^{\frac{|B|}{d}} \tau\left(\frac{|A|}{m}\right)$.
This is true for any $x \in B$ or order $d$. There are $d_{n}$ elements of order $n$ in $B$, for each $n||B|$. So,
$\sum_{x \in A \imath B} \operatorname{order}(x)=\sum_{n| | B \mid} d_{n}|A|^{|B|} n|A|^{-\frac{|B|}{n}}\left[\sum_{m| | A \mid} m s_{m}^{\frac{|B|}{n}} \tau\left(\frac{|A|}{m}\right)\right]$
$=|B||A|^{|B|} \sum_{m| | A|, n||B|} d_{n} \frac{n}{|B|}|A|^{-\frac{|B|}{n}} m s_{m}^{\frac{|B|}{n}} \tau\left(\frac{|A|}{m}\right)$
$=|B||A|^{|B|} \sum_{m| | A|, n||B|} d_{\frac{|B|}{n}} n^{-1}|A|^{-n} m s_{m}^{n} \tau\left(\frac{|A|}{m}\right)$ (by replace $n$ with $\frac{|B|}{n}$ )
$=|B||A|^{|B|} \sum_{m| | A|, n||B|} \frac{m}{n}\left(\frac{s_{m}}{|A|}\right)^{n} d_{\frac{|B|}{n}} \tau\left(\frac{|A|}{m}\right)$.
Dividing by $|B \| A|^{|B|}$ we get the desired result.
Proof of Theorem 2. Theorem 1, together with the observation that $s_{p^{m}}=p^{a}$ for $m \geq d$ yields

$-(p-1) \sum_{m \leq a-1, n \leq b} \frac{p^{m}}{p^{n}}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}} d_{p^{b-n}}$
$=p^{a-b} \sum_{n \leq b} p^{b-n} d_{p^{b-n}}$
$-(p-1) \sum_{d \leq m \leq a-1, n \leq b} \frac{p^{m}}{p^{n}} d_{p^{b-n}}$
$-(p-1) \sum_{m \leq d-1, n \leq b} \frac{p^{m}}{p^{n}}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}} d_{p^{b-n}}$
$=p^{a} \mathrm{a}(B)-(p-1) p^{d}\left[\sum_{m \leq a-d-1} p^{m}\right] \sum_{n \leq b} p^{-n} d_{p^{b-n}}$

& -(p-1) \sum_{m \leq d-1, n \leq b} \frac{p^{m}}{p^{n}}\left(\frac{s_{p} m}{p^{a}}\right)^{p^{n}} d_{p^{b-n}} \\

& =p^{d} \mathrm{a}(B)-(p-1) a(B) \sum_{n \leq b} k_{n} \cdot\left[\sum_{m \leq d-1} p^{m}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}}\right] .

Proof of theorem 3. Theorem 2 proves the second inequality, and the first inequality follows from lemma 1.

Proof of theorem 4. Let us look at theorem 2 more closely. $\frac{s_{p} m}{p^{a}}<1$ $\forall m \leq d-1$. So, $\sum_{m \leq d-2} p^{m}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}} \leq \sum_{m \leq d-2} p^{m}=\frac{p^{d-1}-1}{p-1}$, for each $n \leq b$. We also have $k_{n} \geq 0 \forall n, \sum_{n \leq b} k_{n}=1$. Hence,

(p-1) a(B) \cdot \sum_{n \leq b} k_{n} \cdot\left[\sum_{m \leq d-2}^{-} p^{m}\left(\frac{s_{p} m}{p^{a}}\right)^{p^{n}}\right]=O\left(p^{d-1} a(B)\right)
$$

Proof of theorem 5. Let $x \in B$, order $(x)=p^{e_{1}}, \underline{\alpha} \in \prod_{b \in B} A$. Multiplication by $x$ divides $B$ into $p^{b-e_{1}}$ orbits of size $p^{e_{1}}$; let $b_{1}, b_{2}, \ldots, b_{p^{b-e_{1}}}$ be representatives of distinct orbits. By (1) of theorem 1 , the order of $T_{\underline{\alpha}, x^{-1}}$ equals $p^{e_{1}} . \max _{1 \leq i \leq p^{b-e_{1}}} \operatorname{order}\left(\alpha_{b_{i}} \alpha_{x b_{i}} \cdots \alpha_{x^{p^{e_{1}}-1} b_{i}}\right) \leq p^{e} . p^{d}=p^{d+e}$.

If $x \in B$ is of order $p^{e}$, and $y \in A$ is of order $p^{d}$, then the order of $T_{\underline{\alpha}, x^{-1}}$ equals $p^{d+e}$, where $\underline{\alpha}$ is defined by $\alpha_{1}=y, \alpha_{b}=1 \forall b \neq 1$. So, $\mathrm{m}(A$ 亿 $B)=p^{d+e}$.

Now we prove the second statement.
Again fix $x \in B$, order $(x)=p^{e_{1}}$. Let $k \leq d+e-e_{1}$. Note that

T_{\underline{\alpha}, x^{-1}}^{p^{d+e-k}}=1 \Longleftrightarrow\left(\alpha_{b_{i}} \alpha_{x b_{i}} \ldots \alpha_{x^{p^{e_{1}}-1} b_{i}}\right)^{p^{d+e-e_{1}-k}}=1 \quad \forall i
$$

Name this condition (2).
As we showed in the proof of theorem 1, the number of $\underline{\alpha} \in \prod_{b \in B} A$ satisfying (2) is $\left(\left(p^{a}\right)^{p^{e_{1}}-1} s_{p^{d}+e-e_{1}-k}\right)^{p^{d-e_{1}}}=\left(p^{a p^{e_{1}}} r_{A, k-\left(e-e_{1}\right)}\right)^{p^{b-e_{1}}}=p^{a p^{b}} r_{A, k-\left(e-e_{1}\right)}^{p^{b-e_{1}}}$. (Note that $s_{p^{d}+e-e_{1}-k}=p^{a} r_{A, k-\left(e-e_{1}\right)}$. )

So, for $k \leq d+e-e_{1},\left|\left\{\underline{\alpha} \in \prod_{b \in B} A: T_{\underline{\alpha}, x-1}^{p^{d+e-k}}=1\right\}\right|=p^{a p^{b}} r_{A, k-\left(e-e_{1}\right)}^{p^{b-e_{1}}}$. This is true for $k>d+e-e_{1}$ also, as then both sides are 0 .

So, $r_{A \imath B, k}$
$=p^{-a p^{b}} p^{-b} \sum_{e_{1}=0}^{e}$ (no. of elements of $B$ of order $\left.p^{e_{1}}\right) p^{a p^{b}} r_{A, k-\left(e-e_{1}\right)}^{p^{b-e_{1}}}$
$=\sum_{i=0}^{e} \frac{\text { no. of elements of } B \text { of order } p^{e-i}}{p^{b}} \cdot r_{A, k-i}^{p^{b-e+i}}\left(\right.$ here $\left.i=e-e_{1}\right)$
$=\sum_{i=0}^{e}\left(r_{B, i}-r_{B, i+1}\right) r_{A, k-i}^{p^{b-e+i}}$.
Corollary 5.1 is a direct consequence of theorem 5 .
To prove Corollary 5.2, we need a lemma. Write $r_{n, k}=r_{A_{n}, k}$.
Lemma 3 For all $k, \lim _{n \rightarrow \infty} r_{n, k}=1$.
Proof. We proceed by induction on $k$. For $k \leq 0$, we have $r_{n, k}=1 \forall n$, and nothing to show. For the induction step, let $k \geq 1$ and assume $\lim _{n \rightarrow \infty} r_{n, k-1}=$ 1. By corollary 5.1., $r_{n+1, k}=\left(1-p^{-1}\right) r_{n, k}+\frac{r_{n, k-1}^{p}}{p}$. So,
$\liminf _{n \rightarrow \infty} r_{n+1, k}=\left(1-p^{-1}\right) \liminf _{n \rightarrow \infty} r_{n, k}+p^{-1}$, as induction hypothesis implies $\lim _{n \rightarrow \infty} r_{n, k-1}=1$.

But $\liminf _{n \rightarrow \infty} r_{n+1, k}=\liminf _{n \rightarrow \infty} r_{n, k}$. Hence, $\liminf _{n \rightarrow \infty} r_{n, k}=(1-$ $\left.p^{-1}\right) \liminf _{n \rightarrow \infty} r_{n, k}+p^{-1}$; that is, $\liminf _{n \rightarrow \infty} r_{n, k}=1$. Since we always have $0 \leq r_{n, k} \leq 1$, we get $\lim _{n \rightarrow \infty} r_{n, k}=1$. Induction completes the proof.

Proof of corollary 5.2. Let $m(A)=p^{d},|B|=p^{b}$. By theorem $5, m\left(A_{n}\right)=$ $p^{d+n}$ for all $n$. By theorem 2,
$\psi\left(A_{n}, B\right)=1-\frac{p-1}{p^{d+n}} \sum_{r \leq b} k_{r}\left(\sum_{m=0}^{d+n-1} p^{m} r_{n, d+n-m}^{p^{r}}\right)$
$=1-\left(1-p^{-1}\right) \sum_{r \leq b} k_{r}\left(\sum_{m=0}^{d+n-1} p^{-(d+n-1-m)} r_{n,(d+n-1-m)+1}^{p^{r}}\right)$
$=1-\left(1-p^{-1}\right) \sum_{r \leq b} k_{r}\left(\sum_{m=0}^{d+n-1} p^{-m} r_{n, m+1}^{p^{r}}\right)$ (replace $m$ by $\left.d+n-1-m\right)$.
Fix $M \in \mathbf{N}$. For all sufficiently large $n$, we have $d+n-1>M$, hence $\psi\left(A_{n}, B\right) \leq 1-\left(1-p^{-1}\right) \sum_{r \leq b} k_{r}\left(\sum_{m=0}^{M} p^{-m} r_{n, m+1}^{p^{r}}\right)$. Since $\lim _{n \rightarrow \infty} r_{n, m+1}=1$ by lemma 3 , we get
$\lim \sup _{n \rightarrow \infty} \psi\left(A_{n}, B\right) \leq 1-\left(1-p^{-1}\right) \sum_{r \leq b} k_{r} \sum_{m=0}^{M} p^{-m}$
$=1-\left(1-p^{-1}\right) \sum_{m=0}^{M} p^{-m}\left(\right.$ as $\left.\sum_{r \leq b} k_{r}=1\right)$ for all $M \in \mathbf{N}$.
Taking $M \rightarrow \infty$, we get $\lim \sup _{n \rightarrow \infty} \psi\left(A_{n}, B\right) \leq 0$, that is, $\lim _{n \rightarrow \infty} \psi\left(A_{n}, B\right)=$ 0.

Proof of theorem 6. We use the notation of theorem 2, and write $t$ instead of $t(A)$. Projection gives a surjective group homomorphism $\phi: A \rightarrow\left(\mathbf{Z} / p^{d} \mathbf{Z}\right)^{t}$. Note that the subgroup of $p^{d-1}$-torsion elements of $A$ is $\phi^{-1}\left(\left(p \mathbf{Z} / p^{d} \mathbf{Z}\right)^{t}\right)$, and for $0 \leq m \leq d-2$, the subgroup of $p^{d-m}$-torsion elements of $A$ is contained in $\phi^{-1}\left(\left(p^{m} \overline{\mathbf{Z}} / p^{d} \mathbf{Z}\right)^{t}\right)$. So, $\frac{s_{p^{d-1}}}{p^{a}}=p^{-t}$, and for each $0 \leq m \leq d-2$, we have $\frac{s_{p} m}{p^{a}} \leq p^{-m t} \leq p^{-2 t}$. By theorem 2,

$$
\begin{aligned}
& p^{d} a(B)-a(A \imath B)-(p-1) a(B) k_{0} \cdot\left[\sum_{m \leq d-1} p^{m} \frac{s_{p^{m}}}{p^{a}}\right] \\
& =(p-1) a(B) \sum_{1 \leq n \leq b} k_{n} \cdot\left[\sum_{m \leq d-1} p^{m}\left(\frac{s_{p^{m}}}{p^{a}}\right)^{p^{n}}\right] \\
& \quad \leq(p-1) a(B) \sum_{1 \leq n \leq b} k_{n} \sum_{m \leq d-1} \frac{p^{m}}{p^{t p^{n}}} \\
& =(p-1) a(B)\left(\sum_{1 \leq n \leq b} k_{n} p^{-t p^{n}}\right) \cdot \frac{p^{d}-1}{p-1} \\
& \quad \leq a(B) \sum_{1 \leq n \leq b} p^{d-t p^{n}} k_{n} \\
& \quad \leq a(B) p^{d-t p} \sum_{1 \leq n \leq b} k_{n} \leq a(B) p^{d-t p} .
\end{aligned}
$$

If $B$ is noncyclic, $k_{0}=0$; so $p^{d} a(B)-a(A 乙 B) \leq a(B) p^{d-t p}$. Dividing by $p^{d} a(B)$, we get $1-p^{-t p} \leq \psi(A, B)$. If $B$ is the cyclic group $\mathbf{Z} / p^{b} \mathbf{Z}$, we have
$k_{0}=\frac{\phi\left(p^{b}\right)}{a(B)}=\frac{p-1}{p} \cdot \frac{p^{b}}{a(B)}=\left(1+O\left(\frac{1}{p}\right)\right) \cdot\left(1+O\left(\frac{1}{p}\right)\right)=1+O\left(\frac{1}{p}\right)$ ．Here，we used lemma 2，and the observation that $\left(1+O\left(p^{-1}\right)\right)^{-1}=1+O\left(p^{-1}\right)$ ．So，$\sum_{m \leq d-1} p^{m} \frac{s_{p} m}{p^{a}}=$ $p^{d-1-t}+O\left(\sum_{m \leq d-2} p^{m-2 t}\right)=p^{d-1-t}+O\left(\frac{p^{d-1}-1}{p-1} \cdot p^{-2 t}\right)=p^{d-1-t}+O\left(p^{d-2-2 t}\right)$.

Hence，$\frac{(p-1) a(B) k_{0} \cdot\left[\sum_{m<d-1} p^{m} \frac{s_{p} m}{\left.p^{a}\right]}\right.}{p^{d} a(B)}=\frac{(p-1)\left(1+O\left(p^{-1}\right)\right)\left(p^{d-1-t}+O\left(p^{d-2-2 t}\right)\right)}{p^{d}}=$ $\frac{p^{d-t}+O\left(p^{d-1-t}\right)}{p^{d}}=p^{-t}+O\left(p^{-t-1}\right)$ ．

We have shown
$0 \leq p^{d} a(B)-a(A$ 亿 $B)-(p-1) a(B) k_{0} \cdot\left[\sum_{m \leq d-1} p^{m} \frac{s_{p} m}{p^{a}}\right] \leq a(B) p^{d-t p}$.
So，dividing by $p^{d} a(B)$ we get
$\psi(A, B)=1-\frac{(p-1) a(B) k_{0} \cdot\left[\sum_{m \leq d-1} p^{m} \frac{s_{p} p^{m}}{\left.p^{a}\right]}\right.}{p^{d} a(B)}+O\left(p^{-t p}\right)$
$=1+p^{-t}+O\left(p^{-t-1}\right)+O\left(p^{-t p}\right)=1+p^{-t}+O\left(p^{-t-1}\right)$ ．
Proof of theorem 7．Let $\left|B_{n}\right|=p^{b_{n}}$ ．By theorem 2，

$$
a\left((\mathbf{Z} / p \mathbf{Z})^{n} \imath B_{n}\right)=p \cdot a\left(B_{n}\right)-(p-1) a\left(B_{n}\right) \sum_{m \leq b_{n}} k_{m, n}\left(\frac{1}{p^{n}}\right)^{p^{m}}
$$

for some $0 \leq k_{m, n} \leq 1$ ，with $\sum_{m \leq b_{n}} k_{m, n}=1$ for each $n$ ．
So，for all sufficiently large $n$ ，so that $a\left(B_{n}\right) \leq \beta+1$ ；we have

$$
\left|a\left((\mathbf{Z} / p \mathbf{Z})^{n} \imath B_{n}\right)-p \beta\right| \leq p\left|a\left(B_{n}\right)-\beta\right|+(p-1)(\beta+1) p^{-n} \rightarrow 0
$$

Proof of corollary 7．1．Let $G_{n}=(\mathbf{Z} / p \mathbf{Z})^{n}, H_{n}=(\mathbf{Z} / p \mathbf{Z})^{n} 乙\left((\mathbf{Z} / p \mathbf{Z})^{n}\right.$ 亿 $\left.\left(\ldots\left((\mathbf{Z} / p \mathbf{Z})^{n} \imath B\right)\right)\right)$ ，there are $r-1(\mathbf{Z} / p \mathbf{Z})^{n}$＇s here．Now corollary 7.1 follows by repeated application of theorem 7 ．
