# EXPLICIT CLASS NUMBER FORMULAS FOR SIEGEL-WEIL AVERAGES OF TERNARY QUADRATIC FORMS

#### Abstract

In this paper, we investigate the interplay between positive-definite integral ternary quadratic forms and class numbers. We generalize a result of Jones relating the theta function for the genus of a quadratic form to the Hurwitz class numbers, obtaining an asymptotic formula (with a main term and error term away from finitely many bad square classes $t_{j} \mathbb{Z}^{2}$ ) relating the number of lattices points in a quadratic space of a given norm with a sum of class numbers related to that norm and the squarefree part of the discriminant of the quadratic form on this lattice.


## 1. Introduction and statement of Results

Sums of squares and representations of integers by quadratic forms have a long and storied history. Consider, for example, the Euclidean norm in three-dimensional space, which for a vector $\boldsymbol{x}=\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}$ is given by

$$
\|\boldsymbol{x}\|^{2}:=\sum_{j=1}^{3} x_{j}^{2} .
$$

If one restricts to the lattice $\mathbb{Z}^{3}$, then counting the number of points on this lattice of norm $n$ is equivalent to solving the Diophantine equation

$$
\begin{equation*}
\sum_{j=1}^{3} x_{j}^{2}=n \tag{1.1}
\end{equation*}
$$

Of course, one can also count points on other lattices in an analogous way. Counting the number of points on the lattice $\sqrt{2} \mathbb{Z} \times \mathbb{Z}^{2}$ of norm $n$ yields the Diophantine equation

$$
2 x_{1}^{2}+x_{2}^{2}+x_{3}^{2}=n .
$$

Fermat conjectured in 1638 that every positive integer may be written as the sum of four squares and three triangular numbers $T_{x}=\frac{x(x+1)}{2}$ (which is equivalent to (1.1) with $n \mapsto 8 n+3$ by completing the square), which can be interpreted in Euclidean space via the above geometric relation. These statements were proven in celebrated works of Lagrange in 1770 and Gauss in 1796. Gauss went further, giving the following precise count of the number of solutions $r_{3}(n)$ to (1.1) in terms of the the Hurwitz class number $H(N)(N>0)$ associated to quadratic orders in the ring of integers in

[^0]$\mathbb{Q}(\sqrt{-N})$ (see (3.1) for a definition):

r_{3}(n)= $$
\begin{cases}12 H(4 n) & \text { if } n \equiv 1,2(\bmod 4)  \tag{1.2}\\ 24 H(n) & \text { if } n \equiv 3(\bmod 8) \\ r_{3}\left(\frac{n}{4}\right) & \text { if } 4 \mid n \\ 0 & \text { otherwise }\end{cases}
$$

Formulas like (1.2) for the number of solutions to more general Diophantine equations resembling (1.1) are somewhat special in a sense, but also not entirely isolated in another sense. To describe this, we recall that a positive-definite integer-valued quadratic form is a homogeneous polynomial $Q: \mathbb{Z}^{\ell} \rightarrow \mathbb{N}_{0}:=\mathbb{N} \cup\{0\}$ of degree two that satisfies $Q(\boldsymbol{x})=0$ if and only if $\boldsymbol{x}=\mathbf{0}$. Hence for some $a_{i, j} \in \mathbb{Z}$, one can write

$$
Q(\boldsymbol{x})=\sum_{1 \leq i \leq j \leq \ell} a_{i, j} x_{i} x_{j}
$$

We restrict to the case that $\ell=3$ (the ternary case) and we also further restrict our consideration to quadratic forms that satisfy $a_{i, j} \in 2 \mathbb{Z}$ for $i \neq j$ (these are called integral quadratic forms). For $n \in \mathbb{N}$, we let

$$
r_{Q}(n):=\#\left\{\boldsymbol{x} \in \mathbb{Z}^{\ell}: Q(\boldsymbol{x})=n\right\}
$$

denote the number of solutions $\boldsymbol{x} \in \mathbb{Z}^{\ell}$ to $Q(\boldsymbol{x})=n$. Although equations like (1.2) are "rare" for $r_{Q}(n)$ in general, one expects that they satisfy formulas that "approximate" (1.2). Namely, $r_{Q}(n)$ should essentially satisfy a formula like (1.2) up to an error that in general grows slower than the class numbers as $n \rightarrow \infty$. Taking a natural weighted average $r_{\operatorname{gen}(Q)}(n)$ (see (2.2)), known as the Siegel-Weil average, over the classes in what is called the genus gen $(Q)$ (roughly speaking, those quadratic forms that cannot be distinguished from $Q$ by looking $p$-adically one prime at a time; one cannot $p$-adically distinguish $x_{1}^{2}+4 x_{2}^{2}+9 x_{3}^{2}$ from $x_{1}^{2}+x_{2}^{2}+36 x_{3}^{2}$, for example), one expects that $r_{\operatorname{gen}(Q)}(n)$ is related to class numbers in a manner similar to (1.2), while for $n$ away from finitely many "bad" square classes (i.e., $n \notin t_{j} \mathbb{Z}^{2}$ for some finite set of squarefree positive integers $\left.\left\{t_{1}, \ldots, t_{r}\right\}\right)$, Duke and Schulze-Pillot [6] have proven that

$$
\begin{equation*}
r_{Q}(n)=r_{\operatorname{gen}(Q)}(n)+O\left(n^{\frac{3}{7}+\varepsilon}\right) \tag{1.3}
\end{equation*}
$$

Moreover, Jones [7, Theorem 86] has proven that for $n$ relatively prime to twice the discriminant (the determinant of the matrix whose $(i, j)$-th component is $\left.\frac{1+\delta_{i=j}}{2} a_{i, j}\right) d_{Q}$, the numbers $r_{\operatorname{gen}(Q)}(n)$ are proportional to certain class numbers associated to binary quadratic forms of discriminant -Dn and Siegel [11] has proven that the class numbers grow faster than $(D n)^{\frac{1}{2}-\varepsilon}$. So for $n$ away from finitely many bad square classes (these are known as spinor exceptional square classes due to a connection to the spinor norm map when considering the algebraic theory of quadratic lattices), $r_{Q}(n)$ satisfies a formula like (1.2) up to a "small" error for those $n$ relatively prime to $2 d_{Q}$. The error is zero in the case of (1.2) because the quadratic form given by the sum of three squares lies in a genus with only one class, and hence the average $r_{\operatorname{gen}(Q)}(n)$ equals $r_{Q}(n)$.

As noted in $[1,(1.3)]$, one can uniformly write (1.2) as

$$
r_{3}(n)=12 H(4 n)-24 H(n)
$$

A number of similar formulas relating $r_{Q}(n)$ with sums of class numbers are found in [1, Lemmas 4.1 to 4.56$]$ when $Q$ is diagonal (i.e., $a_{i, j}=0$ for $i \neq j$ ) quadratic forms that lie in a genus with only one class. In [1], analytic techniques were used to obtain the formulas one-by-one. In this paper, we employ algebraic techniques in order to obtain these types of approximate formulas.

Theorem 1.1. Let $Q$ be an integral positive-definite ternary quadratic form and let $s_{Q}$ be the squarefree part of $d_{Q}$. Then there exist $M \in \mathbb{N}$ and constants $a_{Q, f}(m)$ and $c_{Q}(m)$ only depending
on $m$ modulo $M$ such that for $n$ not in any of the finitely-many spinor exceptional square classes $t_{j} \mathbb{Z}^{2}$ we have

$$
r_{Q}(n)=c_{Q}(n) \sum_{f \mid 2 d_{Q}} a_{Q, f}(n) \cdot H\left(\frac{4 s_{Q} n}{f^{2}}\right)+O\left(n^{\frac{3}{7}+\varepsilon}\right) .
$$

In particular,

$$
r_{g e n(Q)}(n)=c_{Q}(n) \sum_{f \mid 2 d_{Q}} a_{Q, f}(n) \cdot H\left(\frac{4 s_{Q} n}{f^{2}}\right) .
$$

Remark 1.2. The assumption that $Q$ is integral (i.e., $a_{i, j} \in 2 \mathbb{Z}$ for $i \neq j$ ) can be removed by noting that $r_{Q}(n)=r_{2 Q}(2 n)$, yielding a result for what are known as integer-valued quadratic forms.

The constants $a_{Q, f}(m)$ and $c_{Q}(m)$ in Theorem 1.1 are recursively constructed by applying a certain reduction theory using transformations of Watson from quadratic forms to "simpler" quadratic forms coming from what are known as stable lattices. In practice, one can compute these constants given an explicit form $Q$ (see Example 5.3, where the case $Q(\boldsymbol{x})=x_{1}^{2}+x_{2}^{2}+75 x_{3}^{2}$ is worked out in detail), but it is difficult to obtain a general formula for these constants due to their recursive definition. However, for the "base case" of a quadratic form coming from a stable lattice (see (2.1) for a definition of a quadratic form coming form a lattice), we obtain the constants explicitly. To state the theorem, for $Q$ coming from a stable lattice $L$, we set (see (3.15) for a definition of $\mathfrak{P}$ for arbitrary lattices/quadratic forms)

$$
\mathfrak{P}=\mathfrak{P}_{Q}:=2^{1-2 \operatorname{ord}_{2}\left(d_{Q}\right)} d_{Q},
$$

we set $e_{Q}:=4$ if $L$ is an odd lattice and $e_{Q}:=1$ if $L$ is an even lattice (see Section 2 for a definition of even and odd lattices), and for a prime $p$ we let $S_{p}^{*}(L)$ denote a modified Hasse symbol defined in (2.3) (which takes values in $\{ \pm 1\}$ ).
Theorem 1.3. Let $Q$ be a positive-definite integral ternary quadratic form associated to a stable lattice $L$. Then for any $n \in \mathbb{N}$ not contained in the finitely-many spinor exceptional square classes $t_{j} \mathbb{Z}^{2}$, we have

$$
r_{Q}(n)=12 \prod_{p \mid \mathfrak{F}}\left(p+S_{p}^{*}(L)\right)^{-1} \times \sum_{f \mid \mathfrak{F}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{e_{Q} d_{Q} n}{f^{2}}\right)+O\left(n^{\frac{3}{7}+\varepsilon}\right) .
$$

In particular,

$$
r_{g e n(Q)}(n)=12 \prod_{p \mid \mathfrak{F}}\left(p+S_{p}^{*}(L)\right)^{-1} \times \sum_{f \mid \mathfrak{B}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{e_{Q} d_{Q} n}{f^{2}}\right) .
$$

The paper is organized as follows. In Section 2, we introduce the theory of quadratic lattices needed for our purposes, including local densities and the Siegel-Weil average $r_{\operatorname{gen}(Q)}(n)$, stable lattices, and reduction theory via Watson transformations. In Section 3, we investigate the SiegelWeil average on quadratic forms related to stable lattices, proving Theorem 1.3. Section 4 is devoted to the recursive formulas coming from reduction from arbitrary lattices to stable lattices and the proof of Theorem 1.1. We conclude the paper by demonstrating how to apply the theory to some explicit examples in Section 5.

## 2. Preliminaries

2.1. Quadratic forms and quadratic lattices. We adopt the language of quadratic spaces and lattices. Any unexplained notation and terminology can be found in [8] or [10]. We let $V$ be a quadratic space over $\mathbb{Q}$, which is a $\mathbb{Q}$-vector space with an associated non-degenerate symmetric
bilinear form $B$ such that $B(\boldsymbol{u}, \boldsymbol{v}) \in \mathbb{Q}$ for all $\boldsymbol{u}, \boldsymbol{v} \in V$. The corresponding quadratic map is defined by $Q(\boldsymbol{x})=B(\boldsymbol{x}, \boldsymbol{x})$ for any $\boldsymbol{x} \in V$. A quadratic $\mathbb{Z}$-lattice is a free $\mathbb{Z}$-module

$$
L=\mathbb{Z} \boldsymbol{v}_{1}+\mathbb{Z} \boldsymbol{v}_{2}+\cdots+\mathbb{Z} \boldsymbol{v}_{\boldsymbol{k}}
$$

of rank $k$, where $\boldsymbol{v}_{\mathbf{1}}, \ldots, \boldsymbol{v}_{\boldsymbol{k}} \in V$ is a basis of $V$. The $k \times k$ symmetric matrix $A_{L}:=\left(B\left(\boldsymbol{v}_{\boldsymbol{i}}, \boldsymbol{v}_{\boldsymbol{j}}\right)\right)$ is called the Gram matrix of $L$ with respect to a basis $\boldsymbol{v}_{\boldsymbol{1}}, \ldots, \boldsymbol{v}_{\boldsymbol{k}}$, and we write $L \cong\left(B\left(\boldsymbol{v}_{\boldsymbol{i}}, \boldsymbol{v}_{\boldsymbol{j}}\right)\right)$. The discriminant $d_{L}$ is defined to be the determinant of $\left(B\left(\boldsymbol{v}_{\boldsymbol{i}}, \boldsymbol{v}_{\boldsymbol{j}}\right)\right)$. Any $\boldsymbol{x} \in L$ may be written as $\boldsymbol{x}=\sum_{j=1}^{k} x_{j} \boldsymbol{v}_{\boldsymbol{j}}$ for some $\left(x_{1}, \ldots, x_{k}\right)^{T} \in \mathbb{Z}^{k}$, and by a quadratic form associated to (or coming from) $L$ (with respect to a basis $\left\{\boldsymbol{v}_{1}, \ldots, \boldsymbol{v}_{\boldsymbol{k}}\right\}$ ), we mean

$$
\begin{equation*}
Q_{L}\left(x_{1}, \ldots, x_{k}\right):=Q(\boldsymbol{x})=\sum_{1 \leq i, j \leq k} B\left(\boldsymbol{v}_{\boldsymbol{i}}, \boldsymbol{v}_{\boldsymbol{j}}\right) x_{i} x_{j} . \tag{2.1}
\end{equation*}
$$

Note that one may also write the quadratic form in terms of the Gram matrix via

$$
Q_{L}\left(x_{1}, \ldots, x_{k}\right)=\left(x_{1}, \ldots, x_{k}\right) A_{L}\left(x_{1}, \ldots, x_{k}\right)^{T}
$$

The quadratic form $Q_{L}$ is integral precisely when the Gram matrix $A_{L}$ has integer entries and integer-valued when the diagonal entries of $A_{L}$ are integers and the other entries lie in $\frac{1}{2} \mathbb{Z}$. If $B\left(\boldsymbol{v}_{\boldsymbol{i}}, \boldsymbol{v}_{\boldsymbol{j}}\right)=0$ for any $i \neq j$ (equivalently, if the Gram matrix is diagonal), then we simply write $L=\left\langle Q\left(\boldsymbol{v}_{\mathbf{1}}\right), \ldots, Q\left(\boldsymbol{v}_{\boldsymbol{k}}\right)\right\rangle$. More generally, if $L=L_{1}+\cdots+L_{r}$ for sublattices $L_{1}, \ldots, L_{r}$ with $B\left(\boldsymbol{x}_{\boldsymbol{j}}, \boldsymbol{x}_{\boldsymbol{m}}\right)=0$ for every $\boldsymbol{x}_{\boldsymbol{j}} \in L_{j}$ and $\boldsymbol{x}_{\boldsymbol{m}} \in L_{m}$ whenever $j \neq m$, then we write

$$
L=L_{1} \perp L_{2} \perp \cdots \perp L_{r} .
$$

Note that $L=\left\langle Q\left(\boldsymbol{v}_{1}\right), \ldots, Q\left(\boldsymbol{v}_{k}\right)\right\rangle$ is precisely the case where each $L_{j}$ has rank one.
The scale ideal $\mathfrak{s}(L)$ (resp. the norm ideal $\mathfrak{n}(L))$ of $L$ is the $\mathbb{Z}$-module generated by the subset $B(L, L)($ resp. $Q(L))$ of $\mathbb{Q}$. We say a $\mathbb{Z}$-lattice $L$ is positive definite if $Q(\boldsymbol{x})>0$ for any $\boldsymbol{x} \in L \backslash\{0\}$. Since $Q_{L}$ is integral precisely when $\mathfrak{s}(L) \subseteq \mathbb{Z}$, we call such a $\mathbb{Z}$-lattice $L$ integral and we call the lattice primitive if $\mathfrak{s}(L)=\mathbb{Z}$. When a lattice is not integral or primitive, it is frequently beneficial to scale the lattice appropriately; hence for $a \in \mathbb{Q}$ and a lattice $L$ in the quadratic space $V$, let $V^{a}$ denote the vector space $V$ provided with a new bilinear form $B^{a}(\boldsymbol{x}, \boldsymbol{y}):=a B(\boldsymbol{x}, \boldsymbol{y})$, and we shall use $L^{a}$ to denote the scaled lattice, which is lattice $L$ when it is regarded as a lattice in $V^{a}$. The quadratic form $Q_{L}$ is integer-valued precisely when $\mathfrak{n}(L) \subseteq \mathbb{Z}$. Throughout this article, we restrict ourselves to positive-definite integral $\mathbb{Z}$-lattice, and hereafter simply use the term "lattice" to refer to such lattices. We say that a lattice $L$ is even if $\mathfrak{n}(L) \subseteq 2 \mathbb{Z}$, and it is odd otherwise.

For two lattices $K$ and $L$, we say $K$ is represented by $L$, denoted $K \rightarrow L$, if there is a linear map $\sigma: K \rightarrow L$ such that

$$
B(\sigma(\boldsymbol{x}), \sigma(\boldsymbol{y}))=B(\boldsymbol{x}, \boldsymbol{y}) \quad \text { for any } \boldsymbol{x}, \boldsymbol{y} \in K
$$

Such a linear map is called a representation from $K$ to $L$ (or a representation of $K$ by $L$ ).
We say $K$ and $L$ are isometric to each other, denoted $K \cong L$, if $K \rightarrow L$ and $L \rightarrow K$, and in this case we call $\sigma$ an isometry. We let $R(K, L)$ be the set of all representations from $K$ to $L$ and denote its size by $r(K, L):=|R(K, L)|$. In particular, the set $O(L):=R(L, L)$ is the group of automorphs of $L$, and we use the notation $o(L)$ to denote $r(L, L)$. Moreover, for any integer $n$, we abbreviate

$$
r(n, L):=r(\langle n\rangle, L)=\#\{\boldsymbol{x} \in L: Q(\boldsymbol{x})=n\}=r_{Q_{L}}(n) .
$$

Note that although $Q_{L}$ depends on the choice of basis, $r_{Q_{L}}(n)=r(n, L)$ does not. This is because $r_{Q_{L}}(n)$ is a class invariant (under isometry) and different choices of basis yield isometric quadratic forms via the isometry defined by the change of basis map.
2.2. Local densities and the Siegel-Weil averaging theorem. For a prime $p$, a quadratic lattice over the ring of $p$-adic integers $\mathbb{Z}_{p}$ and related notations and terminologies may be defined analogously to the definitions given in Section 2.1. Let $M$ and $N$ be two integral $\mathbb{Z}_{p}$-lattices of rank $s$ and $t$ with Gram matrices $S$ and $T$, respectively. Suppose that $t \geq s \geq 1$. Then Siegel $[12,13]$ defined the local density of representations of $M$ by $N$ as

$$
\alpha_{p}(M, N):=2^{-\delta_{s, t} t} \lim _{r \rightarrow \infty}\left(p^{r}\right)^{s(s+1) / 2-s t} \# A_{p^{r}}(S, T)
$$

where $\delta_{m, n}=1$ if $m=n$ and 0 otherwise, and (embedding $\mathbb{Z} / p^{r} \mathbb{Z}$ into $\mathbb{Z}_{p}$ by choosing an integer representative as usual)

$$
A_{p^{r}}(S, T):=\left\{X \in M_{t, s}\left(\mathbb{Z} / p^{r} \mathbb{Z}\right): X^{t} T X \equiv S\left(\bmod p^{r}\right)\right\}
$$

Sometimes the following modified local density is used:

$$
\beta_{p}(M, N):=\lim _{r \rightarrow \infty}\left(p^{r}\right)^{s(s+1) / 2-s t} \#\left\{X \in M_{t, s}\left(\mathbb{Z} / p^{r} \mathbb{Z}\right): X^{t} T X \equiv S\left(\bmod p^{r} E_{s}\left(\mathbb{Z}_{p}\right)\right)\right\},
$$

where $E_{s}\left(\mathbb{Z}_{p}\right)$ is the set of $s \times s$ symmetric matrices over $\mathbb{Z}_{p}$ all of whose diagonal entries belong to $2 \mathbb{Z}_{p}$. In fact, they are related by $\alpha_{p}(M, N)=2^{s \delta_{p, 2}-\delta_{s, t}} \beta_{p}(M, N)$, where $\delta_{p, 2}=0$ if $p$ is odd, and $\delta_{p, 2}=1$ if $p=2$.

Let $L$ be a lattice. For any prime number $p$, we define the localization of $L$ at $p$ by the $\mathbb{Z}_{p}$-lattice $L_{p}:=L \otimes_{\mathbb{Z}} \mathbb{Z}_{p}$. We define the genus gen $(L)$ of $L$ as

$$
\operatorname{gen}(L)=\left\{K \subseteq \mathbb{Q} L: K_{p} \cong L_{p} \text { for any prime } p\right\}
$$

where $\mathbb{Q} L=\{\alpha v: \alpha \in \mathbb{Q}, v \in L\}$ is the quadratic space $V$ on which $L$ lies and $K$ are $\mathbb{Z}$-lattices. The isometric relation induces an equivalence relation on $\operatorname{gen}(L)$, and $\operatorname{gen}(L) / \sim$ is the set of classes in $\operatorname{gen}(L)$. The latter is a finite set and its cardinality is called the class number of $L$. The (isometry) class of $L$ in $\operatorname{gen}(L)$ is denoted by $[L]$. For two lattices $M$ and $N$, and a prime $p$, we simply write $\alpha_{p}(M, N)=\alpha_{p}\left(M_{p}, N_{p}\right)$ and $\beta_{p}(M, N)=\beta_{p}\left(M_{p}, N_{p}\right)$.

Let $L$ be a lattice and let $n$ be a positive integer. We say $n$ is locally represented by $L$ if $n$ is represented by $L_{p}$ over $\mathbb{Z}_{p}$ for any prime number $p$. Define

$$
\begin{equation*}
w(L):=\sum_{[T] \in \operatorname{gen}(L) / \sim} \frac{1}{o(T)} \quad \text { and } \quad r(n, \operatorname{gen}(L)):=\frac{1}{w(L)} \sum_{[T] \in \operatorname{gen}(L) / \sim} \frac{r(n, T)}{o(T)} . \tag{2.2}
\end{equation*}
$$

The value $w(L)$ is called the mass (or weight) of $L$. It is well known that if $n$ is locally represented by $L$, then $n$ is represented by a lattice $K$ in $\operatorname{gen}(L)$ (see [10, 102:5]), and hence $r(n, \operatorname{gen}(L))>0$.

Theorem 2.1 (Minkowski-Siegel Formula). Let $L$ be a lattice of rank $\ell \geq 2$ and $n$ be an integer. Let $\varepsilon_{\ell}=\frac{1}{2}$ if $\ell=2$ and $\varepsilon_{\ell}=1$ otherwise. Then we have

$$
\begin{gathered}
w(L)^{-1}=\frac{1}{2} \cdot \pi^{\ell(\ell+1) / 4} \cdot \prod_{i=0}^{\ell-1} \Gamma((\ell-i) / 2)^{-1} \cdot\left(d_{L}\right)^{-(\ell+1) / 2} \times \prod_{p} \alpha_{p}(L, L), \text { and } \\
r(n, \operatorname{gen}(L))=\varepsilon_{\ell} \cdot \pi^{\ell / 2} \cdot \Gamma(\ell / 2)^{-1} \cdot\left(d_{L}\right)^{-1 / 2} n^{\ell / 2-1} \times \prod_{p} \alpha_{p}(n, L) .
\end{gathered}
$$

Here, $\Gamma$ is the ordinary gamma function and $\alpha_{p}$ is the local density at a prime $p$.
2.3. Stable lattices. We say a primitive ternary lattice $L$ is stable at a prime $p$ if $\operatorname{ord}_{p}\left(d_{L}\right) \leq 1$, and in addition when $p=2, \operatorname{ord}_{2}\left(d_{L}\right)=1$ if and only if $L$ is even. A primitive ternary lattice $L$ is called stable if it is stable at every prime. We say $L_{p}$ is isotropic if $Q(\boldsymbol{x})=0$ for some non-zero element $\boldsymbol{x} \in L_{p}$, and it is anisotropic otherwise. Note that for any ternary lattice $L$, the Hasse
symbol $S_{p}(L)$ of $L$ at a prime $p$ indicates whether $L_{p}$ is isotropic or not; more precisely (see [10, 58:6])

$$
S_{p}^{*}(L):=(-1)^{\delta_{p, 2}} S_{p}(L)= \begin{cases}1 & \text { if } L_{p} \text { is isotropic }  \tag{2.3}\\ -1 & \text { if } L_{p} \text { is anisotropic }\end{cases}
$$

For each prime $p$, a Jordan decomposition of $L_{p}$ for a stable lattice $L$ may be described as follows.
Lemma 2.2. Let $L$ be a stable lattice. For an odd prime $p$, we have

$$
L_{p} \cong \begin{cases}\left\langle 1,1, d_{L}\right\rangle & \text { if } \operatorname{ord}_{p}\left(d_{L}\right)=0, \\ \left\langle 1,-1,-d_{L}\right\rangle & \text { if } \operatorname{ord}_{p}\left(d_{L}\right)=1 \text { and } L_{p} \text { is isotropic, } \\ \left\langle 1,-\Delta_{p},-\Delta_{p} d_{L}\right\rangle & \text { if } \operatorname{ord}_{p}\left(d_{L}\right)=1 \text { and } L_{p} \text { is anisotropic },\end{cases}
$$

where $\Delta_{p}$ denotes a non-square unit in $\mathbb{Z}_{p}$. For $p=2$, we have

$$
L_{2} \cong \begin{cases}\mathbb{A} \perp\left\langle 3 d_{L}\right\rangle & \text { if } L_{2} \text { is anisotropic } \\ \mathbb{H} \perp\left\langle-d_{L}\right\rangle & \text { otherwise }\end{cases}
$$

where $\mathbb{A}=\left(\begin{array}{ll}2 & 1 \\ 1 & 2\end{array}\right)$ and $\mathbb{H}=\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right)$.
The above lemma implies that if $K$ and $L$ are two stable lattices with $d_{K}=d_{L}$, then for any prime $p$ we have $K_{p} \cong L_{p}$ if and only if $S_{p}(K)=S_{p}(L)$. We next give a formula for the local density of a lattice $L$ at an odd prime $p$ at which the lattice is stable. To describe the result, we write $L_{p}=M_{p} \perp U_{p}$, where $M_{p}$ is the leading Jordan component and $\mathfrak{s}\left(U_{p}\right) \subseteq p \mathfrak{s}\left(M_{p}\right)$.

Lemma 2.3. Let $p$ be an odd prime and let $L$ be a ternary lattice that is stable at $p$. For $n \in \mathbb{N}$, let $\nu_{p}:=\operatorname{ord}_{p}(n)$. If $\operatorname{ord}_{p}\left(d_{L}\right)=0$, then we have

$$
\alpha_{p}(n, L)= \begin{cases}1+\frac{1}{p}-\frac{1}{p^{\frac{\nu_{p}+2}{2}}}+\left(\frac{-p^{-\nu_{p}} n d_{L}}{p}\right) \frac{1}{p^{\frac{\nu_{p}+2}{2}}} & \text { if } \nu_{p} \text { is even }, \\ 1+\frac{1}{p}-\frac{1}{p^{\frac{\nu_{p}+1}{2}}}-\frac{1}{p^{\nu_{p+3}}} & \text { if } \nu_{p} \text { is odd. }\end{cases}
$$

If $\operatorname{ord}_{p}\left(d_{L}\right)=1$, then we have

$$
\alpha_{p}(n, L)= \begin{cases}1+\left(1-\frac{1}{p^{\frac{v_{p}}{2}}}-\frac{1}{p^{\frac{\nu_{p}+2}{2}}}\right)\left(\frac{-d_{M_{p}}}{p}\right) & \text { if } \nu_{p} \text { is even }, \\ 1+\left(1-\frac{1}{p^{\frac{\nu_{p}+1}{2}}}+\left(\frac{-p^{-\left(\nu_{p}+1\right)} n d_{L}}{p}\right) \frac{1}{p^{\frac{\nu_{p}+1}{2}}}\right)\left(\frac{-d_{M_{p}}}{p}\right) & \text { if } \nu_{p} \text { is odd. }\end{cases}
$$

Here, $(\dot{\bar{p}})$ is the Legendre symbol.
Proof. This is a direct consequence of Lemma 2.2 and [14, Theorem 3.1].
We also require the local density at the prime 2 for lattices that are 2 -adically stable.
Lemma 2.4. Let $L$ be a ternary lattice that is stable at 2 . For $n \in \mathbb{N}$, write $n=\beta \cdot 2^{a}$ with $\beta \equiv 1(\bmod 2)$ and $a \geq 0$. If $L$ is odd and anisotropic, then we have

$$
\alpha_{2}(n, L)= \begin{cases}3 \cdot 2^{-\frac{a+1}{2}} & \text { if } a \text { is odd, } \\ 3 \cdot 2^{-\frac{a+2}{2}} & \text { if } a \text { is even and } \beta \equiv d_{L}(\bmod 4), \\ 2^{-\frac{a}{2}} & \text { if } a \text { is even and } \beta \equiv 3 d_{L}(\bmod 8), \\ 0 & \text { if } a \text { is even and } \beta \equiv 7 d_{L}(\bmod 8) .\end{cases}
$$

If $L$ is odd and isotropic, then we have

$$
\alpha_{2}(n, L)= \begin{cases}2-3 \cdot 2^{-\frac{a+1}{2}} & \text { if } a \text { is odd }, \\ 2-3 \cdot 2^{-\frac{a+2}{2}} & \text { if } a \text { is even and } \beta \equiv d_{L}(\bmod 4), \\ 2-2^{-\frac{a}{2}} & \text { if } a \text { is even and } \beta \equiv 3 d_{L}(\bmod 8), \\ 2 & \text { if } a \text { is even and } \beta \equiv 7 d_{L}(\bmod 8) .\end{cases}
$$

If $L$ is even, then we have

$$
\alpha_{2}(n, L)= \begin{cases}3-3 \cdot 2^{-\frac{a}{2}} & \text { if } a \text { is even, } \\ 3-3 \cdot 2^{-\frac{a+1}{2}} & \text { if } a \text { is odd and } \beta \equiv d_{L} / 2(\bmod 4), \\ 3-2^{-\frac{a-1}{2}} & \text { if } a \text { is odd and } \beta \equiv 3 d_{L} / 2(\bmod 8), \\ 3 & \text { if } a \text { is odd and } \beta \equiv 7 d_{L} / 2(\bmod 8) .\end{cases}
$$

Proof. Note that when $L$ is even, $L_{2}=\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right) \perp\left\langle-d_{L}\right\rangle$ and

$$
\alpha_{2}(n, L)= \begin{cases}0 & \text { if } n \text { is odd } \\
2 \alpha_{2}\left(\frac{n}{2},\left(\begin{array}{cc}
0 & \frac{1}{2} \\
\frac{1}{2} & 0
\end{array}\right) \perp\left\langle-\frac{d_{L}}{2}\right\rangle\right) & \text { if } n \text { is even. }\end{cases}
$$

Now, the lemma is a direct consequence of Lemma 2.2 and [14, Theorem 4.1].
Corollary 2.5. Let $L$ be a ternary lattice that is stable at a prime $p$. Then the set of p-adic integers that are represented by $L_{p}$ over $\mathbb{Z}_{p}$ is

$$
\begin{cases}\mathbb{Z}_{p} & \text { if } p \text { is odd and } L_{p} \text { is isotropic, } \\ 2 \mathbb{Z}_{2} & \text { if } p=2 \text { and } L \text { is even, } \\ \mathbb{Z}_{p} \backslash\left(-d_{L}\right) \mathbb{Z}_{p}^{2} & \text { if } L_{p} \text { is anisotropic. }\end{cases}
$$

Proof. Note that $n \in \mathbb{Z}_{p}$ is represented by $L_{p}$ if and only if $\alpha_{p}(n, L) \neq 0$. Thus, this is a consequence of Lemmas 2.3 and 2.4. The corollary may also directly be verified from the Jordan decomposition of $L_{p}$ in Lemma 2.2 since it is maximal (see [10, 91:3]).
2.4. Reduction theory: Watson Transformations. We breifly introduce the so-called Watson Transformations of lattices which will play a crucial role in Section 4. Let $m$ be a positive integer. For any lattice $L$, we define

$$
\Lambda_{m}(L):=\{\boldsymbol{x} \in L: Q(\boldsymbol{x}+\boldsymbol{y}) \equiv Q(\boldsymbol{y})(\bmod m) \text { for all } \boldsymbol{y} \in L\},
$$

and for any prime number $p$, we define

$$
\Lambda_{m}\left(L_{p}\right):=\left\{\boldsymbol{x} \in L_{p}: Q(\boldsymbol{x}+\boldsymbol{y}) \equiv Q(\boldsymbol{y})(\bmod m) \text { for all } \boldsymbol{y} \in L_{p}\right\} .
$$

Clearly, $\Lambda_{m}(L)$ is a sublattice of $L$ and $\Lambda_{m}(L) \subseteq\{\boldsymbol{x} \in L: Q(\boldsymbol{x}) \equiv 0(\bmod m)\}$ by taking $\boldsymbol{y}=\mathbf{0}$. Moreover, $\Lambda_{m}(L)_{p}=\Lambda_{m}\left(L_{p}\right)$ for any prime $p$, and $\Lambda_{m}(L)_{p}=L_{p}$ for any prime $p$ not dividing $m$. We refer the readers to [2] and [3] for more properties of the operators $\Lambda_{m}$. We denote by $\lambda_{m}(L)$ the primitive lattice obtained by scaling the quadratic map on $\Lambda_{m}(L)$ suitably. The mappings $L \mapsto \lambda_{m}(L)$ are called Watson transformations.

Now, we describe how $\Lambda_{m}$ transform $L$ when $m$ is prime or 4 . For any prime $p$, we write $L_{p}=M_{p} \perp U_{p}$, where $M_{p}$ is the leading Jordan component and $\mathfrak{s}\left(U_{p}\right) \subseteq p \mathfrak{s}\left(M_{p}\right)$.
Lemma 2.6. Suppose that $M_{p}$ is even unimodular and $\mathfrak{n}\left(U_{p}\right) \subseteq 2 p \mathbb{Z}_{p}$. Then

$$
\Lambda_{e p}(L)_{p}=p M_{p} \perp U_{p}
$$

where $e=2$ if $p=2$, and 1 otherwise. In particular,
(a) if $\operatorname{ord}_{p}\left(d_{L}\right) \geq 2$, then $\operatorname{ord}_{p}\left(d_{\lambda_{e p}(L)}\right)<\operatorname{ord}_{p}\left(d_{L}\right)$,
(b) if $m$ is a squarefree positive integer and $\operatorname{ord}_{p}\left(d_{L}\right) \leq 1$ for all $p \mid m$, then $\lambda_{m}^{2}(L)=L$.

Proof. See [4, Lemma 2.1].
We note that, in particular, for an odd prime $p$ one may recursively use part (a) of Lemma 2.6 to reduce the power of $p$ dividing the discriminant of the lattice until the order is at most one for the reduced lattice. An overview of the corresponding reduction for $p=2$ is given in the next lemma.
Lemma 2.7. Suppose that $L$ is a ternary integral lattice with $\mathfrak{n}\left(L_{2}\right)=\mathbb{Z}_{2}$.
(a) If $\operatorname{rank}\left(M_{2}\right)=2$ and $\mathfrak{s}\left(U_{2}\right) \subseteq 2 \mathbb{Z}_{2}$, then

$$
\lambda_{2}(L)_{2} \cong \begin{cases}M_{2} \perp U_{2}^{\frac{1}{2}} & \text { if } d_{M} \equiv 1(\bmod 8), \\
M_{2}^{3} \perp U_{2}^{\frac{1}{2}} & \text { if } d_{M} \equiv 5(\bmod 8), \\
\left(\begin{array}{ll}
2 & 1 \\
1 & 2
\end{array}\right) \perp U_{2}^{\frac{1}{2}} & \text { if } d_{M} \equiv 3(\bmod 8), \\
\left(\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right) \perp U_{2}^{\frac{1}{2}} & \text { if } d_{M} \equiv 7(\bmod 8)\end{cases}
$$

(b) If $\operatorname{rank}\left(M_{2}\right)=1$ and $\mathfrak{s}\left(U_{2}\right) \subseteq 4 \mathbb{Z}_{2}$, then $\lambda_{2}(L)_{2} \cong M_{2} \perp U_{2}^{\frac{1}{4}}$.
(c) If $\operatorname{rank}\left(M_{2}\right)=1$ and $\mathfrak{s}\left(U_{2}\right)=2 \mathbb{Z}_{2}$, then $\lambda_{2}(L)_{2} \cong M_{2}^{2} \perp U_{2}^{\frac{1}{2}}$.

In particular, if $\operatorname{ord}_{2}\left(d_{L}\right) \geq 2$, then $\operatorname{ord}_{2}\left(d_{\lambda_{2}(L)}\right)<\operatorname{ord}_{2}\left(d_{L}\right)$; and if ord $d_{2}\left(d_{L}\right)=1$, then $\lambda_{2}(L)_{2}$ is unimodular.
Proof. See [4, Lemma 2.2].
Combining Lemmas 2.6 and 2.7, Chan and Oh [4, Corollary 2.4] proved the following.
Corollary 2.8. A primitive ternary lattice $L$ can be transformed, via a finite sequence of Watson transformations at the primes dividing $d_{L}$ or at 4 , to a stable lattice.

To describe the relationship between the reduction theory via Corollary 2.8 and genera, one needs to investigate how isometries commute with the Watson transformations at primes dividing $d_{L}$ or at 4.
Lemma 2.9. Let $L$ be a lattice on a quadratic space $V$ and let $m$ be a prime or 4 . Then
(1) $\sigma \circ \Lambda_{m}(L)=\Lambda_{m} \circ \sigma(L)$ for any $\sigma \in O(V)$. In particular, the group $O(L)$ is a subgroup of $O\left(\Lambda_{k}(L)\right)$.
(2) $\Lambda_{m}$ induces a surjective function from gen $(L) / \sim$ onto gen $\left(\Lambda_{m}(L)\right) / \sim$.

Proof. See [4]. The case when $m=4$ may be shown similarly.
Let $L$ be a lattice and let $m$ be a prime or 4 . For any lattice $N$ in gen $\left(\Lambda_{m}(L)\right)$, we define

$$
\begin{gathered}
\Gamma_{m}^{L}(N):=\left\{T \in \operatorname{gen}(L): \Lambda_{m}(T)=N\right\} \quad \text { and } \\
\Gamma_{m}^{L}(N) / \sim:=\left\{[T] \in \operatorname{gen}(L) / \sim: \Lambda_{m}(T)=N\right\}
\end{gathered}
$$

Clearly,

$$
\begin{equation*}
\operatorname{gen}(L) / \sim=\bigsqcup_{[N] \in \operatorname{gen}\left(\Lambda_{m}(L)\right) / \sim} \Gamma_{m}^{L}(N) / \sim \tag{2.4}
\end{equation*}
$$

Let $\sigma \in O(N)$ and $T \in \Gamma_{m}^{L}(N)$. Since $\Lambda_{p}(\sigma(T))=\sigma\left(\Lambda_{p}(T)\right)=\sigma(N)=N, \sigma(T)$ belongs to $\Gamma_{m}^{L}(N)$. Hence, $O(N)$ act on $\Gamma_{m}^{L}(N)$. Moreover, by Lemma 2.9, if $\tau(T) \in \Gamma_{m}^{L}(N)$ for some $\tau \in O(V)$, then $\tau \in O(N)$. Therefore, we have

$$
\begin{equation*}
\left|\Gamma_{m}^{L}(N)\right|=\sum_{[T] \in \Gamma_{m}^{L}(N) / \sim} \frac{o(N)}{o(T)} \tag{2.5}
\end{equation*}
$$

Furthermore, we have the following.

Lemma 2.10. Let $m$ be a prime or 4 . For any $N \in \operatorname{gen}\left(\Lambda_{m}(L)\right)$

$$
\left|\Gamma_{m}^{L}(N)\right|=\frac{w(L)}{w\left(\Lambda_{m}(L)\right)}
$$

Proof. See [4, Proposition 3.3]. The case when $m=4$ may be shown similarly.

## 3. Class number formulas for stable lattices

In this section, we prove our main theorem regarding the class number formula for the stable lattices. We first describe some properties of primitive class numbers and Hurwitz class numbers. Let $d$ be a negative integer. Let $h(d)$ denote the number of $\mathrm{SL}_{2}(\mathbb{Z})$-equivalence classes of binary quadratic forms $a x^{2}+b x y+c y^{2}$ with $b^{2}-4 a c=d$ and $(a, b, c)=1$. We call $h(d)$ the primitive class number of discriminant $d$. Let $w_{d}$ denote the number of automorphisms of such a binary quadratic form. Note that $w_{d}=6$ if $d=-3, w_{d}=4$ if $d=-4$, and $w_{d}=2$ otherwise.

From a well-known bijection between $\mathrm{SL}_{2}(\mathbb{Z})$-equivalence classes of binary quadratic forms and Picard group of orders in the ring of integers of integers of quadratic fields, together with the relation between the orders of Picard groups, we have the following lemma.

Lemma 3.1. Let $d<0$ be a fundamental discriminant and let $f \in \mathbb{N}$. Then we have

$$
h\left(d f^{2}\right)=\frac{h(d) f}{w_{d} / w_{d f^{2}}} \prod_{p \mid f}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right) .
$$

Proof. This is a direct consequence of [5, Theorems 7.7 and 7.24]. See also [5, Corollary 7.28].
Now, we introduce Hurwitz class numbers. For $N \in \mathbb{N}$, the Hurwitz class number $H(N)$ is a modification of the primitive class number, which counts the number of $S L_{2}(\mathbb{Z})$-equivalence classes of binary quadratic forms $a x^{2}+b x y+c y^{2}$ with $b^{2}-4 a c=-N$, weighted by $2 / g$ for $g$ the order of their automorphism group. Therefore, $H(N)$ may explicitly be defined by

$$
\begin{equation*}
H(N)=\sum_{f^{2} \mid N} \frac{h\left(-N / f^{2}\right)}{w_{-N / f^{2} / 2}} \tag{3.1}
\end{equation*}
$$

Lemma 3.2. Let $N \in \mathbb{N}$ and let $d$ be the discriminant of $\mathbb{Q}(\sqrt{-N})$. Let $F \in \frac{1}{2} \mathbb{N}$ be such that $-N=d F^{2}$. Then we have

$$
H(N)=\frac{h(d)}{w_{d} / 2} \prod_{p}\left(\frac{p^{\operatorname{ord}_{p}(F)+1}-1-\left(\frac{d}{p}\right)\left(p^{\operatorname{ord}_{p}(F)}-1\right)}{p-1}\right),
$$

where the product runs over all prime numbers $p$.
Proof. We first note that the product is indeed a finite product since $\operatorname{ord}_{p}(F)=0$ for almost all primes, in which case the value in the product is equal to 1 . Note also that $F \in \frac{1}{2} \mathbb{N} \backslash \mathbb{N}$ if and only if $N \equiv 1$ or $2(\bmod 4)$, and the both sides of the above equation are zero since $d \equiv 0(\bmod 4)$ and $\operatorname{ord}_{2}(F)=-1$. Now, we assume that $N \equiv 0$ or $3(\bmod 4)$, and hence $H(N) \neq 0$ and $F \in \mathbb{N}$. By (3.1) and Lemma 3.1, we have

$$
H(N)=\sum_{f \mid F} \frac{h\left(f^{2} d\right)}{w_{f^{2} d} / 2}=\frac{h(d)}{w_{d} / 2} \sum_{f \mid F} f \prod_{p \mid f}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)=\frac{h(d)}{w_{d} / 2} \sum_{f \mid F} \prod_{p \mid f} p^{\operatorname{ord}_{p}(f)}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right) .
$$

The right-hand side is multiplicative in $F$ and computing the value for $F$ a prime power yields

$$
\frac{h(d)}{w_{d} / 2} \prod_{p \mid F}\left[1+p\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)+\cdots+p^{\operatorname{ord}_{p}(F)}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)\right] .
$$

Evaluating the geometric series $1+p+\cdots+p^{\operatorname{ord}_{p}(F)}$ and $\left(\frac{d}{p}\right)\left(1+p+\cdots+p^{\operatorname{ord}_{p}(F)-1}\right)$ then yields the claim.

Corollary 3.3. With the same notations as the above lemma, let $\mu_{q}=\operatorname{ord}_{q}(N)-2 \delta_{q=2} \delta_{d \equiv 0}(\bmod 4)$ for a prime $q$. Then we have

$$
H(N)=H\left(N q^{-2\left\lfloor\mu_{q} / 2\right\rfloor}\right) \cdot \frac{q^{\left\lfloor\mu_{q} / 2\right\rfloor+1}-1-\left(\frac{-N q^{-2\left\lfloor\mu_{q} / 2\right\rfloor}}{q}\right)\left(q^{\left\lfloor\mu_{q} / 2\right\rfloor}-1\right)}{q-1} .
$$

Proof. Note that $\left\lfloor\mu_{q} / 2\right\rfloor=\operatorname{ord}_{q}(F)$, and hence

$$
-N q^{-2\left\lfloor\mu_{q} / 2\right\rfloor}=d\left(F \cdot q^{- \text {ord }_{q}(F)}\right)^{2} .
$$

Applying Lemma 3.2 to obtain formulas for $H(N)$ and $H\left(N q^{-2\left\lfloor\mu_{q} / 2\right\rfloor}\right)$, we observe that the values in the product are the same for each prime $p$ except $p=q$. Noting that $\left(\frac{d}{q}\right)=\left(\frac{-N q^{-2\lfloor\mu q / 2\rfloor}}{q}\right)$, the corollary follows.
Proposition 3.4. Let $L$ be a ternary lattice and let $q$ be a prime such that $\left(q, 2 d_{L}\right)=1$. For any $n \in \mathbb{N}$ that is locally represented by $L$, we have

$$
\frac{r\left(n q^{2}, \operatorname{gen}(L)\right)}{r(n, \operatorname{gen}(L))}=\frac{H\left(\frac{4 d_{L} n q^{2}}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)}
$$

for any $f \in \mathbb{N}$ such that $(f, q)=1$ and $H\left(\frac{4 d_{工} n}{f^{2}}\right) \neq 0$.
Proof. Note that $n q^{2}$ is locally represented by $L$ since $n$ is, so neither $r(n, \operatorname{gen}(L))$ nor $r\left(n q^{2}, \operatorname{gen}(L)\right)$ are equal to zero. Now, by the Minkowski-Siegel formula in Theorem 2.1 and by the local density formula in Lemma 2.3 for $\operatorname{ord}_{q}\left(d_{L}\right)=0$, one may verify that

$$
\begin{equation*}
\frac{r\left(n q^{2}, \operatorname{gen}(L)\right)}{r(n, \operatorname{gen}(L))}=q \cdot \frac{\alpha_{q}\left(n q^{2}, L\right)}{\alpha_{q}(n, L)}=\frac{q^{\left\lfloor\nu_{q} / 2\right\rfloor+2}-1-\left(\frac{-q^{-2\left\lfloor\nu_{q} / 2\right\rfloor} n d_{L}}{q}\right)\left(q^{\left\lfloor\nu_{q} / 2\right\rfloor+1}-1\right)}{q^{\left\lfloor\nu_{q} / 2\right\rfloor+1}-1-\left(\frac{-q^{-2\left\lfloor\nu_{q} / 2\right\rfloor} n d_{L}}{q}\right)\left(q^{\left\lfloor\nu_{q} / 2\right\rfloor}-1\right)}, \tag{3.2}
\end{equation*}
$$

where $\nu_{q}=\operatorname{ord}_{q}(n)$. On the other hand, note that $\frac{4 d_{L} n}{f^{2}} \in \mathbb{N}$ and $\mu_{q}:=\operatorname{ord}_{q}\left(\frac{4 d_{L} n}{f^{2}}\right)=\operatorname{ord}_{q}(n)=\nu_{q}$ since $\left(q, 2 d_{L}\right)=(f, q)=1$. By applying Corollary 3.3 for $N=\frac{4 d_{L} n q^{2}}{f^{2}}$ and $\frac{4 d_{L} n}{f^{2}}$ respectively, and by dividing the obtained equalities side-by-side,

$$
\begin{equation*}
\frac{H\left(\frac{4 d_{L} n q^{2}}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)}=\frac{q^{\left\lfloor\nu_{q} / 2\right\rfloor+2}-1-\left(\frac{-4 d_{L} n q^{-2\left\lfloor\nu_{q} / 2\right\rfloor}}{q}\right)\left(q^{\left\lfloor\nu_{q} / 2\right\rfloor+1}-1\right)}{q^{\left\lfloor\nu_{q} / 2\right\rfloor+1}-1-\left(\frac{-4 d_{L} n q^{-2\left\lfloor\nu_{q} / 2\right\rfloor}}{q}\right)\left(q^{\left\lfloor\nu_{q} / 2\right\rfloor}-1\right)} . \tag{3.3}
\end{equation*}
$$

Since the right hand sides of (3.2) and (3.3) are equal, the proposition follows.
Proposition 3.5. Let $L$ be a ternary lattice and let $p$ be an odd prime with $\operatorname{ord}_{p}\left(d_{L}\right)=1$. For any $n \in \mathbb{N}$ that is locally represented by $L$, we have

$$
\frac{r\left(n p^{2}, \operatorname{gen}(L)\right)}{r(n, \operatorname{gen}(L))}=\frac{H\left(\frac{4 d_{L} n p^{2}}{f^{2}}\right)+S_{p}^{*}(L) p H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)+S_{p}^{*}(L) p H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)}
$$

for any $f \in \mathbb{N}$ such that $(f, p)=1$ and $H\left(\frac{4 d_{L} n}{f^{2}}\right) \neq 0$.

Proof. By the Minkowski-Siegel formula in Theorem 2.1, (2.3), and Lemma 2.2, it suffices to show that

$$
p \cdot \frac{\alpha_{p}\left(n p^{2}, L\right)}{\alpha_{p}(n, L)}= \begin{cases}\frac{H\left(\frac{4 d_{L} n p^{2}}{f^{2}}\right)-p H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{4 d_{L^{2}} n}{f^{2}}\right)-p H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)} & \text { if } M_{p} \cong\left\langle 1,-\Delta_{p}\right\rangle,  \tag{3.4}\\ \frac{H\left(\frac{4 d_{L} n p^{2}}{f^{2}}\right)+p H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{d d_{L^{n}}}{f^{2}}\right)+p H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)} & \text { if } M_{p} \cong\langle 1,-1\rangle,\end{cases}
$$

where $M_{p}$ is a unimodular Jordan component of $L_{p}$. To prove (3.4), we follow the same argument as in the proof of Proposition 3.4. Namely, we compute the left-hand side of (3.4) by using the formula in Lemma 2.3, and the right-hand side of (3.4) is computed as in the proof of Proposition 3.4 by applying Corollary 3.3, verifying that they are equal.

When $M_{p} \cong\left\langle 1,-\Delta_{p}\right\rangle$, one may easily show that both sides of (3.4) are equal to 1 , so we only provide a detailed calculation for the case when $M_{p} \cong\langle 1,-1\rangle$. In this case, $\left(\frac{-d_{M_{p}}}{p}\right)=1$. Setting $\nu_{p}:=\operatorname{ord}_{p}(n)$, Lemma 2.3 implies that

$$
\alpha_{p}(n, L)= \begin{cases}2-\frac{1}{p^{\left.\mid \nu_{p} / 2\right\rceil}}-\frac{1}{p^{\nu \nu_{p} / 2 \mid+1}} & \text { if } \nu_{p} \equiv 0(\bmod 2), \\ 2-\frac{1}{p^{\left.\mid \nu_{p} / 2\right\rceil}}+\varepsilon_{p}(n) \frac{1}{p^{\left.\nu \nu_{p} / 2\right\rceil}} & \text { if } \nu_{p} \equiv 1(\bmod 2),\end{cases}
$$

where $\varepsilon_{p}(n):=\left(\frac{\left.-n d_{L} p^{-(o r d} p(n)+1\right)}{p}\right)$. Thus, we have

$$
p \cdot \frac{\alpha_{p}\left(n p^{2}, L\right)}{\alpha_{p}(n, L)}= \begin{cases}\frac{2 p^{\left[\nu_{\nu} / 2\right\rceil+2}-p-1}{2 p^{\left[\nu p_{p} / 2\right]+1}-p-1} & \text { if } \nu_{p} \equiv 0(\bmod 2),  \tag{3.5}\\ \frac{2 p^{\left[\nu_{p} / 2\right\rceil+1}-1+\varepsilon_{p}\left(n p^{2}\right)}{2 p^{\left[\nu_{p} / 2\right]}-1+\varepsilon_{p}(n)} & \text { if } \nu_{p} \equiv 1(\bmod 2) .\end{cases}
$$

On the other hand, note that $\frac{4 d_{L} n}{f^{2}} \in \mathbb{N}$ and

$$
\mu_{p}:=\operatorname{ord}_{p}\left(\frac{4 d_{L} n}{f^{2}}\right)=\operatorname{ord}_{p}(n)+1=\nu_{p}+1 .
$$

Hence $\left\lfloor\mu_{p} / 2\right\rfloor=\left\lceil\nu_{p} / 2\right\rceil$. By applying Corollary 3.3 for $N=\frac{4 d_{L} n}{f^{2}}$ and $\frac{4 d_{L} n}{f^{2} p^{2}}$ when $\nu_{p} \geq 1$, and noting that $H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)=0$ when $\nu_{p}=0$, we have

$$
\begin{align*}
H\left(\frac{4 d_{L} n}{f^{2}}\right) & +p H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)  \tag{3.6}\\
& =H\left(\frac{4 d_{L} n}{f^{2}} p^{-2\left\lceil\nu_{p} / 2\right\rceil}\right) \times \begin{cases}\frac{2 p^{\left\lceil\nu_{p} / 2\right\rceil+1}-p-1}{p-1} & \text { if } \nu_{p} \equiv 0(\bmod 2) \\
2 p^{\left\lceil\nu_{p} / 2\right\rceil} & \text { if } \nu_{p} \equiv 1(\bmod 2) \text { and } \varepsilon_{p}(n)=1, \\
2(p+1) \frac{p^{\left[\nu_{p} / 2\right\rceil}-1}{p-1} & \text { if } \nu_{p} \equiv 1(\bmod 2) \text { and } \varepsilon_{p}(n)=-1 .\end{cases}
\end{align*}
$$

Plugging in (3.6) with $n \rightarrow n p^{2}$ in the numerator and $n$ in the denominator, we obtain

$$
\frac{H\left(\frac{4 d_{L} n p^{2}}{f^{2}}\right)+p H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)+p H\left(\frac{4 d_{L} n}{f^{2} p^{2}}\right)}= \begin{cases}\frac{2 p^{\left[\nu_{\nu} / 2\right]+2}-p-1}{2 p^{\left[\nu_{p} / 2\right]+1}-p-1} & \text { if } \nu_{p} \equiv 0(\bmod 2)  \tag{3.7}\\ p & \text { if } \nu_{p} \equiv 1(\bmod 2) \text { and } \varepsilon_{p}(n)=1 \\ \frac{{ }^{\left[\nu_{p} / 2\right]+1}-1}{p^{\left[\nu_{p} / 2\right]}-1} & \text { if } \nu_{p} \equiv 1(\bmod 2) \text { and } \varepsilon_{p}(n)=-1 .\end{cases}
$$

Noting that $\varepsilon_{p}\left(n p^{2}\right)=\varepsilon_{p}(n)= \pm 1$, one may verify that the right-hand sides of (3.5) and (3.7) are equal. This proves the proposition.

We have a similar result for the prime 2.
Proposition 3.6. Let $L$ be a ternary lattice that is stable at 2. For any $n \in \mathbb{N}$ that is locally represented by L, we have

$$
\frac{r(4 n, \operatorname{gen}(L))}{r(n, \operatorname{gen}(L))}= \begin{cases}\frac{H\left(\frac{16 d_{L} n}{f^{2}}\right)+S_{2}^{*}(L) 2 H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)+S_{2}^{*}(L) 2 H\left(\frac{d_{L^{\prime}} n}{f^{2}}\right)} & \text { if } L \text { is odd } \\ \frac{H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{d_{L} n}{f^{2}}\right)} & \text { if } L \text { is even }\end{cases}
$$

for any $f \in \mathbb{N}$ such that $(f, 2)=1$ and $H\left(\frac{4 d_{L} n}{f^{2}}\right) \neq 0$ (resp. $H\left(\frac{d_{L} n}{f^{2}}\right) \neq 0$ ) if $L$ is odd (resp. if $L$ is even).

Proof. This is a consequence of Lemma 2.4 and Corollary 3.3 by following the same argument as in the proof of Propositions 3.4 and 3.5 . Since the proofs are quite similar to each other, we only provide the proof for the case when $L$ is even.

Assume that $L$ is even. Note that $\operatorname{ord}_{2}\left(d_{L}\right)=1$ and $n$ is an even integer since it is locally represented by $L$. Let us write $n=\beta \cdot 2^{a}$ with $\beta \equiv 1(\bmod 2)$ and $a \geq 1$. By the Minkowski-Siegel formula in Theorem 2.1 and by Lemma 2.4, we have

$$
\frac{r(4 n, \operatorname{gen}(L))}{r(n, \operatorname{gen}(L))}=2 \cdot \frac{\alpha_{2}(4 n, L)}{\alpha_{2}(n, L)}= \begin{cases}\frac{2^{(a+2) / 2}-1}{2^{a / 2}-1} & \text { if } a \text { is even with } a \geq 2  \tag{3.8}\\ \frac{2^{(a+3) / 2}-1}{2^{(a+1) / 2}-1} & \text { if } a \text { is odd, } \beta \equiv d_{L} / 2(\bmod 4) \\ \frac{3 \cdot 2^{(a+1) / 2}-1}{3 \cdot 2^{(a-1) / 2}-1} & \text { if } a \text { is odd, } \beta \equiv 3 d_{L} / 2(\bmod 8) \\ 2 & \text { if } a \text { is odd, } \beta \equiv 7 d_{L} / 2(\bmod 8)\end{cases}
$$

On the other hand, we shall apply Corollary 3.3 with $N=\frac{d_{L} n}{f^{2}} \in \mathbb{N}$ and $q=2$. Note that

$$
\mu_{2}:=\operatorname{ord}_{2}\left(\frac{d_{L} n}{f^{2}}\right)-2 \delta_{q=2} \delta_{d \equiv 0(\bmod 4)}= \begin{cases}a+1 & \text { if } \beta \equiv 3 d_{L} / 2(\bmod 4)  \tag{3.9}\\ a-1 & \text { otherwise }\end{cases}
$$

where $d$ is the discriminant of $\mathbb{Q}\left(\sqrt{-d_{L} n / f^{2}}\right)$. Noting that $\left(\frac{d}{2}\right)=\left(\frac{-N \cdot 2^{-2\left\lfloor\mu_{2} / 2\right\rfloor}}{2}\right)$, Corollary 3.3 implies

$$
\begin{equation*}
H\left(\frac{d_{L} n}{f^{2}}\right)=H\left(\frac{d_{L} n}{f^{2}} \cdot 2^{-2\left\lfloor\mu_{2} / 2\right\rfloor}\right) \cdot\left(2^{\left\lfloor\mu_{2} / 2\right\rfloor+1}-1-\left(\frac{d}{2}\right)\left(2^{\left\lfloor\mu_{q} / 2\right\rfloor}-1\right)\right) \tag{3.10}
\end{equation*}
$$

Plugging in (3.10) (with $n \mapsto 4 n$ in the numerator below and $n$ in the denominator) yields

$$
\begin{equation*}
\frac{H\left(\frac{4 d_{L} n}{f^{2}}\right)}{H\left(\frac{d_{L} n}{f^{2}}\right)}=\frac{2^{\left\lfloor\mu_{2} / 2\right\rfloor+2}-1-\left(\frac{d}{2}\right)\left(2^{\left\lfloor\mu_{q} / 2\right\rfloor+1}-1\right)}{2^{\left\lfloor\mu_{2} / 2\right\rfloor+1}-1-\left(\frac{d}{2}\right)\left(2^{\left\lfloor\mu_{q} / 2\right\rfloor}-1\right)} \tag{3.11}
\end{equation*}
$$

By using (3.9) and by noting that

$$
\begin{cases}d \equiv 5(\bmod 8) & \text { if } a \text { is odd and } \beta \equiv 3 d_{L} / 2(\bmod 8) \\ d \equiv 1(\bmod 8) & \text { if } a \text { is odd and } \beta \equiv 7 d_{L} / 2(\bmod 8) \\ d \equiv 0(\bmod 4) & \text { otherwise }\end{cases}
$$

one may verify through a case-by-case computation that the right-hand sides of (3.8) and (3.11) coincide. This proves the proposition.

In a somewhat orthogonal direction to Jones's [7, Theorem 86], we next relate $r(n, \operatorname{gen}(L))$ to class numbers whenever $\operatorname{ord}_{p}(n) \leq 1$ for $p \nmid 2 d_{L}$.

Lemma 3.7. Let $L$ be a ternary lattice. For any $n \in \mathbb{N}$ with $\operatorname{ord}_{p}(n) \leq 1$ for all $p \nmid 2 d_{L}$,

$$
\begin{align*}
r(n, \operatorname{gen}(L)) & =\frac{12}{\pi} \frac{\sqrt{n}}{\sqrt{d_{L}}} L\left(1, \chi-4 d_{L} n\right) \prod_{p \mid 2 d_{L}} \alpha_{p}(n, L)\left(1-\frac{1}{p^{2}}\right)^{-1}  \tag{3.12}\\
& =\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d|}} H(|d|) \prod_{p \mid 2 d_{L}} \alpha_{p}(n, L)\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)\left(1-\frac{1}{p^{2}}\right)^{-1},
\end{align*}
$$

where $d$ is the discriminant of $\mathbb{Q}\left(\sqrt{-4 d_{L} n}\right), \chi_{a}=(\underline{a})$, and $L\left(s, \chi_{a}\right)$ is a Dirichlet L-function.
Proof. By the Minkowski-Siegel formula in Theorem 2.1, we have

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=2 \pi \sqrt{\frac{n}{d_{L}}} \prod_{p} \alpha_{p}(n, L)=2 \pi \sqrt{\frac{n}{d_{L}}} \prod_{p \mid 2 d_{L}} \alpha_{p}(n, L) \prod_{p \nmid 2 d_{L}} \alpha_{p}(n, L) . \tag{3.13}
\end{equation*}
$$

Note that for any prime $p \nmid 2 d_{L}$, by [14, Theorem 3.1], we have

$$
\alpha_{p}(n, L)= \begin{cases}1+\left(\frac{-n d_{L}}{p}\right) \frac{1}{p} & \text { if } p \nmid n \\ 1-\frac{1}{p^{2}} & \text { if } p \mid n\end{cases}
$$

Thus, using the difference of squares identity $\left(1+\chi(p) p^{-1}\right)\left(1-\chi(p) p^{-1}\right)=1-p^{2}$ for $\chi(p)= \pm 1$ and noting that $\left(\frac{-4 d_{L} n}{p}\right)=0$ for $p \mid 2 d_{L} n$, we have

$$
\begin{aligned}
\prod_{p \nmid 2 d_{L}} \alpha_{p}(n, L) & =\prod_{\substack{p \nmid 2 d_{L} \\
p \nmid n}}\left(1+\left(\frac{-n d_{L}}{p}\right) \frac{1}{p}\right) \cdot \prod_{\substack{p \nmid 2 d_{L} \\
p \mid n}}\left(1-\frac{1}{p^{2}}\right) \\
& =\prod_{p}\left(1-\left(\frac{-4 n d_{L}}{p}\right) \frac{1}{p}\right)^{-1} \cdot \prod_{p \nmid 2 d_{L}}\left(1-\frac{1}{p^{2}}\right) \\
& =L\left(1, \chi-4 d_{L} n\right) \prod_{p \nmid 2 d_{L}}\left(1-\frac{1}{p^{2}}\right)=L\left(1, \chi_{-4 d_{L} n}\right) \cdot \zeta(2)^{-1} \prod_{p \mid 2 d_{L}}\left(1-\frac{1}{p^{2}}\right)^{-1}
\end{aligned}
$$

where $\zeta(2)=\frac{\pi^{2}}{6}$ is the value of Riemann zeta function at 2. Plugging the above equation into (3.13), we obtain the first equality of the lemma. To obtain the second equality of the lemma, we note our assumption that $\operatorname{ord}_{p}(n) \leq 1$ for $p \nmid 2 d_{L}$ implies that for $-4 d_{L} n=d F^{2}$ every prime dividing $F$ must also divide $2 d_{L}$. Hence we may rewrite the $L$-value and use Dirichlet's class number formula to obtain

$$
L\left(1, \chi_{-4 d_{L} n}\right)=L\left(1, \chi_{d}\right) \cdot \prod_{p \mid 2 d_{L}}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)=\frac{2 \pi h(d)}{w_{d} \sqrt{|d|}} \cdot \prod_{p \mid 2 d_{L}}\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right) .
$$

Since $d$ is fundamental, we have $H(|d|)=\frac{h(d)}{w_{d} / 2}$, completing the proof.
For a ternary lattice $L$, let $\mathcal{P}$ be a set of primes defined by

$$
\begin{equation*}
\mathcal{P}=\mathcal{P}_{L}:=\left\{p: \text { prime } \mid L \text { is stable at } 2 \text { if } p=2, \text { and } \operatorname{ord}_{p}\left(d_{L}\right)=1 \text { otherwise }\right\} . \tag{3.14}
\end{equation*}
$$

Note that for any $p \in \mathcal{P}$ we have $p \mid 2 d_{L}$. Also, let us define

$$
\begin{equation*}
\mathfrak{P}=\mathfrak{P}_{L}:=2^{-\delta_{2 \in \mathcal{P}} \cdot \operatorname{ord}_{2}\left(d_{L}\right)} \prod_{p \in \mathcal{P}} p . \tag{3.15}
\end{equation*}
$$

Note that $\mathfrak{P}$ is a squarefree positive integer, and $\mathfrak{P}=2^{1-2 \operatorname{ord}_{2}\left(d_{L}\right)} d_{L}$ if $L$ is a stable lattice, and hence our definition of $\mathfrak{P}$ agrees with the definition in the introduction for stable lattices. We are now ready to prove Theorem 1.3.

Proof of Theorem 1.3. By Duke and Schulze-Pillot's formula (1.3), it suffices to show that

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=12 \prod_{p \mid \mathfrak{F}}\left(p+S_{p}^{*}(L)\right)^{-1} \times \sum_{f \mid \mathfrak{F}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{e d_{L} n}{f^{2}}\right), \tag{3.16}
\end{equation*}
$$

where $e=4$ if $L$ is odd, and $e=1$ if $L$ is even.
We first prove the theorem when $L$ is odd, in which case $\mathfrak{P}=2 d_{L}$ and $e=4$. We prove that (3.16) holds in two steps. We first show that if (3.16) holds for a positive integer $n$, then it also holds for $n q^{2}$ for any prime $q$, reducing the claim to showing that (3.16) holds for any squarefree positive integer $n$. To show the claim, let $n \in \mathbb{N}$ and let $q$ be a prime. First of all, recall that $r(n, \operatorname{gen}(L)) \neq 0$ if and only if $n$ is locally represented by $L$. Hence, since $Q(q \boldsymbol{x})=q^{2} Q(\boldsymbol{x})$, if $r(n, \operatorname{gen}(L)) \neq 0$, then $r\left(n q^{2}, \operatorname{gen}(L)\right) \neq 0$. Conversely, if $n$ is not represented by $L$, then there exists a prime $p$ such that $n$ is not represented by $L_{p}$ over $\mathbb{Z}_{p}$. By Corollary 2.5, $L_{p}$ should be anisotropic (hence $p \mid 2 d_{L}$ ), and $n$ is not represented by $L_{p}$ if and only if $n q^{2}$ is not represented by $L_{p}$. Thus

$$
r(n, \operatorname{gen}(L)) \neq 0 \text { if and only if } r\left(n q^{2}, \operatorname{gen}(L)\right) \neq 0
$$

Now we assume that $r(n, \operatorname{gen}(L)) \neq 0$. If $q \nmid 2 d_{L}$, then $(q, \mathfrak{P})=1$. Hence by Proposition 3.4, for any $f \mid \mathfrak{P}$, we have

$$
\frac{r\left(n q^{2}, \operatorname{gen}(L)\right)}{r(n, \operatorname{gen}(L))}=\frac{H\left(\frac{4 d_{L} n q^{2}}{f^{2}}\right)}{H\left(\frac{4 d_{L} n}{f^{2}}\right)} .
$$

Rearranging and plugging in (3.16) for $n$ yields (3.16) for $n q^{2}$.
On the other hand, if $q \mid 2 d_{L}$, then since $\mathfrak{P}$ is squarefree and $q \mid \mathfrak{P}$, the sum in the right hand side of (3.16) may be written as

$$
\begin{equation*}
\sum_{f \mid(\mathfrak{F} / q)}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot\left(H\left(\frac{4 d_{L} n}{f^{2}}\right)+S_{q}^{*}(L) q H\left(\frac{4 d_{L} n}{f^{2} q^{2}}\right)\right) . \tag{3.17}
\end{equation*}
$$

Thus, noting that $(f, q)=1$ for any $f \mid(\mathfrak{P} / q)$, the claim follows by Propositions 3.5 and 3.6 in a similar manner to the case when $q \nmid 2 d_{L}$.

Now assume that $r(n, \operatorname{gen}(L))=0$. We will show that the right hand side of (3.16) is equal to zero in this case. Note that there is a prime $q_{0}$ such that $n$ is not represented by $L_{q_{0}}$. By Lemma 2.2 and Corollary 2.5, $L_{q_{0}}$ is anisotropic, $S_{q_{0}}^{*}(L)=-1, n \in\left(-d_{L}\right) \mathbb{Z}_{q_{0}}^{2}$, and $q_{0} \mid \mathfrak{P}$. By Corollary 3.3 if $H\left(\frac{4 d_{L} n}{f^{2}}\right) \neq 0$ (i.e., $\frac{4 d_{L} n}{f^{2}} \in \mathbb{N}$ ), then we conclude that $H\left(\frac{4 d_{L} n}{f^{2}}\right)+S_{q_{0}}^{*}(L) q_{0} H\left(\frac{4 d_{L} n}{f^{2} q_{0}^{2}}\right)$ is equal to

$$
H\left(\frac{4 d_{L} n}{f^{2}} q_{0}^{-2 a}\right) \cdot\left[\frac{q_{0}^{a+1}-1-\left(\frac{-4 d_{L} n q_{0}^{-2 a}}{q_{0}}\right)\left(q_{0}^{a}-1\right)}{q_{0}-1}-q_{0} \frac{q_{0}^{a}-1-\left(\frac{-4 d_{L} n q_{0}^{-2 a}}{q_{0}}\right)\left(q^{a-1}-1\right)}{q_{0}-1}\right]
$$

where $a=\left\lfloor\mu_{q_{0}} / 2\right\rfloor, \mu_{q_{0}}:=\operatorname{ord}_{q_{0}}\left(\frac{4 d_{L} n}{f^{2}}\right)-2 \delta_{q_{0}=2} \delta_{d \equiv 0}(\bmod 4)$ with $d$ the discriminant of $Q\left(\sqrt{\frac{4 d_{L} n}{f^{2}}}\right)$.Since $n \in\left(-d_{L}\right) \mathbb{Z}_{q_{0}}^{2}$, we have $\left(\frac{-4 d_{L} n q_{0}^{-2 a}}{q_{0}}\right)=1$, hence the above is equal to zero. Thus, from the viewpoint of (3.17) with $q=q_{0}$, the right hand side of (3.16) is zero as claimed.

We have now reduced the proof of (3.16) to the case that $n$ is a squarefree positive integer which is represented by the genus. Then by Lemma 3.7, we have

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d|}} H(|d|) \prod_{p \mid 2 d_{L}} c_{p}(n, L), \tag{3.18}
\end{equation*}
$$

where $d$ is the discriminant of $\mathbb{Q}\left(\sqrt{-4 d_{L} n}\right)$ and $c_{p}(n, L):=\alpha_{p}(n, L)\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)\left(1-\frac{1}{p^{2}}\right)^{-1}$.
Let $F$ be the positive integer defined by $-4 d_{L} n=d F^{2}$ and let $F_{p}:=p^{\operatorname{ord}_{p} F}$ for each prime $p$. Note that since we are assuming $n$ to be squarefree and $L$ is stable, $F$ is squarefree. Indeed, for any prime $p \nmid 2 d_{L}, F_{p}=1$ and $p \mid d$ if and only if $p \mid n$, and

$$
F_{2}=1 \text { and }|d| \equiv 0(\bmod 4) \text { if } n \not \equiv 3 d_{L}(\bmod 4) \text {, and } F_{2}=2 \text { and }|d| \equiv 3(\bmod 4) \text { otherwise. }
$$

Furthermore, for an odd prime $p \mid d_{L}$, we have

$$
F_{p}=1 \text { and } p \mid d \text { if } p \nmid n \text {, and } F_{p}=p \text { and } p \nmid d \text { if } p \mid n .
$$

By Lemma 2.4 and Corollary 3.3, one may verify that

$$
H(|d|) c_{2}(n, L)=\frac{2}{2+S_{2}^{*}(L)} \times \begin{cases}H(|d|) & \text { if } n \not \equiv 3 d_{L}(\bmod 4), \\ \frac{1}{2}\left(H(4|d|)+S_{2}^{*}(L) \cdot 2 H(|d|)\right) & \text { if } n \equiv 3 d_{L}(\bmod 4) .\end{cases}
$$

Moreover, noting that $H\left(\frac{|d|}{4}\right)=0$ if $n \not \equiv 3 d_{L}(\bmod 4)$, this may be written as

$$
\begin{equation*}
H(|d|) c_{2}(n, L)=\frac{2}{2+S_{2}^{*}(L)} \times \frac{1}{F_{2}}\left(H\left(|d| F_{2}^{2}\right)+S_{2}^{*}(L) \cdot 2 H\left(\frac{|d| F_{2}^{2}}{4}\right)\right) . \tag{3.19}
\end{equation*}
$$

If we plug (3.19) into (3.18), then we have

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d| F_{2}^{2}}} \cdot \frac{2}{2+S_{2}^{*}(L)} \cdot\left(H\left(|d| F_{2}^{2}\right)+S_{2}^{*}(L) \cdot 2 H\left(\frac{|d| F_{2}^{2}}{4}\right)\right) \prod_{p \mid d_{L}} c_{p}(n, L), \tag{3.20}
\end{equation*}
$$

This results in a disappearance of the term $c_{2}(n, L)$ in the formula for $r(n, \operatorname{gen}(L))$ and the 2-powers cancel in

$$
\frac{2 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d| F_{2}^{2}}}=\frac{\sqrt{4 d_{L} n}}{d_{L} \sqrt{|d| F_{2}^{2}}}
$$

because $\operatorname{ord}_{2}\left(4 d_{L} n\right)=\operatorname{ord}_{2}\left(|d| F_{2}^{2}\right)$ and $d_{L}$ is odd, but we obtain a sum of two Hurwitz class numbers instead.

We next combine $c_{p}(n, L)$ times a class number in a similar way for an odd prime $p \mid d_{L}$ to rewrite (3.20) in the desired shape. For any positive integer $f \mid F$ with $(f, p)=1$, one may verify by Lemma 2.3 and Corollary 3.3 that

$$
H\left(|d| f^{2}\right) c_{p}(n, L)=\frac{p}{p+S_{p}^{*}(L)} \times \begin{cases}H\left(|d| f^{2}\right) & \text { if } p \nmid n, \\ \frac{1}{p}\left(H\left(|d| f^{2} p^{2}\right)+S_{p}^{*}(L) \cdot p H\left(|d| f^{2}\right)\right) & \text { if } p \mid n,\end{cases}
$$

which may equivalently be written as

$$
\begin{equation*}
H\left(|d| f^{2}\right) c_{p}(n, L)=\frac{p}{p+S_{p}^{*}(L)} \times \frac{1}{F_{p}}\left(H\left(|d| f^{2} F_{p}^{2}\right)+S_{p}^{*}(L) \cdot p H\left(\frac{|d| f^{2} F_{p}^{2}}{p^{2}}\right)\right) . \tag{3.21}
\end{equation*}
$$

We iteratively use (3.21) to remove each prime factor in (3.20) one-by-one. Note that (3.21) is still valid for any rational number $f$ of the form $\frac{f_{1}}{f_{2}} \notin \mathbb{Z}$ for some positive integers $f_{1}$ and $f_{2}$ such that $\left(f_{1}, f_{2}\right)=\left(f_{1}, p\right)=\left(f_{2}, p\right)=1$, since in that case both sides of (3.21) are equal to zero. If there is an odd prime $p$ dividing $d_{L}$, then we may apply (3.21) for $f=F_{2}$ and $\frac{F_{2}}{2}$, respectively, and then
plug those into (3.19) in order to remove the factor $c_{p}(n, L)$ from (3.20). By induction, iteratively plugging (3.21) into (3.20) yields

$$
r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d| \prod_{p \mid 2 d_{L}} F_{p}^{2}}} \cdot \prod_{p \mid 2 d_{L}} \frac{p}{p+S_{p}^{*}(L)} \times \sum_{f \mid 2 d_{L}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{4 d_{L} n}{f^{2}}\right)
$$

Noting that $|d| \prod_{p \mid 2 d_{L}} F_{p}^{2}=4 d_{L} n$ and $\prod_{p \mid 2 d_{L}} p=2 d_{L}=\mathfrak{P}$, we obtain (3.16).
The proof of the theorem when $L$ is even, in which case $\mathfrak{P}=d_{L} / 2$ and $e=1$, is quite similar to the above, so we just outline the proof. Firstly, we note that if $\operatorname{ord}_{2}(n)=0$, then both sides of (3.16) are equal to zero; the left-hand side is zero by Theorem 2.1 and since $\alpha_{2}(n, L)=0$, and the right-hand side is zero since $d_{L} n \equiv 2(\bmod 4)$, hence all terms $H\left(\frac{d_{L} n}{f^{2}}\right)$ are zero. Using a similar argument to the proof for the case when $L$ is odd, it suffice to show that the formula (3.16) holds for any positive integer $n$ such that $\delta_{p, 2} \leq \operatorname{ord}_{p}(n) \leq 1+\delta_{p, 2}$ for any prime $p$. For those $n$, let $d$ be the discriminant of $Q\left(\sqrt{-d_{L} n}\right)$ and let $F \in \mathbb{N}$ be defined uniquely by $-d_{L} n=d F^{2}$. Using Lemma 2.4, one obtains

$$
\begin{equation*}
H(|d|) c_{2}(n, L)=2 \times \frac{1}{F_{2}} H\left(|d| F_{2}^{2}\right), \tag{3.22}
\end{equation*}
$$

and one may complete the proof in a similar manner to the proof of the case when $L$ is odd.

## 4. Formula construction for reductions to stable lattices

Let $L$ be a primitive ternary lattice. Throughout this section, we always write $L_{p}=M_{p} \perp U_{p}$, where $M_{p}$ is the unimodular Jordan component and $\mathfrak{s}\left(U_{p}\right) \subseteq p \mathfrak{s}\left(M_{p}\right)$. Recall that if $\operatorname{gcd}\left(n, 2 d_{L}\right)=1$, then Jones [7, Theorem 86] obtained a formula for $r(n, \operatorname{gen}(L))$ in terms of Hurwitz class numbers. In the next theorem, we extend this by obtaining a formula for $r(n, \operatorname{gen}(L))$ whenever $n$ is relatively prime to the divisors of $2 d_{L}$ for which the lattice $L$ is not stable. More precisely, we write the number of representations by the genus in terms of Hurwitz class numbers up to a computation of finitelymany local factors $c_{p}(n, L)$ for primes $p$ for which the lattice is not stable $p$-adically, and these local factors can also be easily computed in this case (see Remark 4.2).

Theorem 4.1. Let $L$ be a primitive ternary lattice, and let $\mathcal{P}=\mathcal{P}_{L}$ and $\mathfrak{P}=\mathfrak{P}_{L}$ be defined as in (3.14) and (3.15), respectively, and let $\mathcal{P}^{\prime}$ be the set of prime divisors of $2 d_{L}$ which do not belong to $\mathcal{P}$. Let $N \in\{1,2\}$ be such that $\mathfrak{n}(L)=N \mathbb{Z}$, and let $n \in \mathbb{N}$ be such that $n \in N \mathbb{Z}_{p}^{\times}$for any $p \in \mathcal{P}^{\prime}$. Writing $4 d_{L}=s \cdot t^{2}$ for some squarefree $s \in \mathbb{N}$ and $t \in \mathbb{N}$, we have

$$
r(n, \operatorname{gen}(L))=\frac{\epsilon}{s t}\left[\prod_{p \mid \mathfrak{F}} \frac{p}{p+S_{p}^{*}(L)}\right] \prod_{p \in \mathcal{P}^{\prime}} c_{p}(n, L) \times \sum_{f \mid \mathfrak{F}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{e s n}{f^{2}}\right),
$$

Here $S_{p}^{*}(L)=(-1)^{\delta_{p, 2}} S_{p}(L)(c f .(2.3)), c_{p}(n, L)=\alpha_{p}(n, L)\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)\left(1-\frac{1}{p^{2}}\right)^{-1}$ with $d$ the discriminant of $\mathbb{Q}\left(\sqrt{-4 d_{L} n}\right)=\mathbb{Q}(\sqrt{-s n})$, and $\epsilon$ and $e$ are constants defined by

$$
(\epsilon, e)=\left(\epsilon_{L}, e_{L}\right)= \begin{cases}\left(24(s, n, 2), \frac{1}{(s, n, 2)^{2}}\right) & \text { if } 2 \notin \mathcal{P}, \frac{s n}{(s, n)^{2}} \equiv 3(\bmod 4), \\ \left(12(s, n, 2), \frac{4}{(s, n, 2)^{2}}\right) & \text { if } 2 \notin \mathcal{P}, \frac{s n}{(s, n)^{2}} \not \equiv 3(\bmod 4), \text { or } 2 \in \mathcal{P}, \operatorname{ord}_{2}\left(d_{L}\right)=0, \\ (48,1) & \text { if } 2 \in \mathcal{P}, \operatorname{ord}_{2}\left(d_{L}\right)=1 .\end{cases}
$$

Remark 4.2. For any given $L$ and for any $n \in \mathbb{N}$ under the assumption in Theorem 4.1, note that $\epsilon_{L}$ and $e_{L}$ are indeed constants since $(s, n, 2)^{2}=4$ if $\mathfrak{n}(L)=2 \mathbb{Z}$ and $\operatorname{ord}_{2}\left(d_{L}\right)$ is odd, and 1 otherwise. Moreover, the computation of $c_{p}(n, L)$ is somewhat straightforward, so Theorem 4.1
yields a formula resembling Theorem 1.1 for these $n$. Precisely, for any such $n$ and an odd prime $p \in \mathcal{P}^{\prime}$, we have by [14, Theorem 3.1] that

$$
\alpha_{p}(n, L)= \begin{cases}1-\left(\frac{-d_{M_{p}}}{p}\right) \frac{1}{p} & \text { if rank } M_{p}=2, \\ 1+\left(\frac{n d_{M_{p}}}{p}\right)=0 \text { or } 2 & \text { if rank } M_{p}=1 .\end{cases}
$$

Moreover, note that for any such $n$ and a prime $p,\left(\frac{d}{p}\right)=\left(\frac{-4^{b} s n}{p}\right)$ for some $b \in\{0, \pm 1\}$. Thus, the value $\prod_{p \in \mathcal{P}^{\prime}} c_{p}(n, L)$ only depends on the residue class of $n$ modulo $2^{k} \prod_{p \in \mathcal{P}^{\prime}}$ p for some integer $0 \leq k \leq 4$.

Proof of Theorem 4.1. We will show that the formula holds for any positive integer $n$ such that $\delta_{p, 2} \operatorname{ord}_{2}(N) \leq \operatorname{ord}_{p}(n) \leq 1+\delta_{p, 2} \operatorname{ord}_{2}(N)$ for any prime $p \in \mathcal{P}$ or $p \nmid 2 d_{L}$ (i.e. $p \notin \mathcal{P}^{\prime}$ ). Then by Propositions 3.4, 3.5, and 3.6, the formula will also hold in general as is described in the proof of Theorem 1.3.

Assume that $\delta_{p, 2} \operatorname{ord}_{2}(N) \leq \operatorname{ord}_{p}(n) \leq \delta_{p \notin \mathcal{P}^{\prime}}+\delta_{p, 2} \operatorname{ord}_{2}(N)$. By Lemma 3.7, we have

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d|}} H(|d|) \prod_{p \mid 2 d_{L}} c_{p}(n, L) . \tag{4.1}
\end{equation*}
$$

First, consider the case when $2 \in \mathcal{P}$. For each prime $p \in \mathcal{P}$, we may repeat the same process of removing the term $c_{p}(n, L)$ from (4.1) by using (3.19) or (3.22) and then iteratively applying (3.21), as is done in the proof of Theorem 1.3. This yields

$$
r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{e s n}}\left[\prod_{p \in \mathcal{P}} \frac{p}{p+S_{p}^{*}(L)}\right] \prod_{\substack{p \mid 2 d_{L} \\ p \notin \mathcal{P}}} c_{p}(n, L) \cdot \sum_{f \mid \mathcal{B}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{e s n}{f^{2}}\right),
$$

where $e=4$ if $\operatorname{ord}_{2}\left(d_{L}\right)=0$ and $e=1$ if $\operatorname{ord}_{2}\left(d_{L}\right)=1$. Plugging $d_{L}=s t^{2} / 4$ into the above formula, we have the theorem.

Now we consider the case when $2 \notin \mathcal{P}$. Note that in this case, $L$ is not stable at 2 so that we may not apply Proposition 3.6. However, we may still repeat the same process of removing the term $c_{p}(n, L)$ for each prime $p \in \mathcal{P}$ from (4.1) as is done in the proof of Theorem 1.3 to obtain
$r(n, \operatorname{gen}(L))=\frac{12 \sqrt{n}}{\sqrt{d_{L}} \sqrt{|d| \frac{(s, n)^{2}}{(s, n, 2)^{2}}}}\left[\prod_{p \in \mathcal{P}} \frac{p}{p+S_{p}^{*}(L)}\right] \prod_{\substack{p \mid 2 d_{L} \\ p \notin \mathcal{P}}} c_{p}(n, L) \cdot \sum_{f \mid \mathfrak{F}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{|d| \frac{(s, n)^{2}}{(s, n, 2)^{2}}}{f^{2}}\right)$.
Plugging $4 d_{L}=s t^{2}$, and $|d|(s, n)^{2}=s n$ if $\frac{s n}{(s, n)^{2}} \equiv 3(\bmod 4),|d|(s, n)^{2}=4 s n$ if $\frac{s n}{(s, n)^{2}} \not \equiv 3(\bmod 4)$ into the above formula, we have the theorem.

Since every lattice can be reduced to a stable lattice after applying finitely-many Watson transformations by Corollary 2.8 and we have a formula for $r(n, \operatorname{gen}(L))$ when $L$ is stable by Theorem 1.3, a formula for $r(n, \operatorname{gen}(L))$ for an arbitrary lattice $L$ can be recursively obtained from formulas for $r\left(n, \operatorname{gen}\left(\lambda_{m}(L)\right)\right)$ once one obtains a relation between $r(n, \operatorname{gen}(L))$ and $r\left(n, \operatorname{gen}\left(\lambda_{m}(L)\right)\right)$ (note that in practice we do not always have to apply the full reduction, as we may halt the reduction process whenever the reduced form satisfies the conditions assumed in Theorem 4.1). The next theorem provides such a relation.

Theorem 4.3. Let $L$ be a ternary lattice and $n \in \mathbb{N}$. Suppose that $L$ is not stable at a prime $p$, and write $L_{p}=M_{p} \perp U_{p}$, where $M_{p}$ is the unimodular Jordan component and $\mathfrak{s}\left(U_{p}\right) \subseteq p \mathbb{Z}_{p}$.
(1) If $M_{p}$ is anisotropic and $\mathfrak{n}\left(L_{p}\right)=\mathbb{Z}_{p}$, then

$$
r(p n, \operatorname{gen}(L))=r\left(p n, \operatorname{gen}\left(\Lambda_{p}(L)\right)\right)=r\left(n^{*}, \operatorname{gen}\left(\lambda_{p}(L)\right)\right),
$$

where $n^{*}=n$ if $\mathfrak{s}\left(U_{p}\right)=p \mathbb{Z}_{p}$ or $p=2$ with $\operatorname{rank}\left(M_{2}\right)=2$, and $n^{*}=n / p$ otherwise.
(2) If $M_{2}$ is anisotropic and $\mathfrak{n}\left(L_{2}\right)=2 \mathbb{Z}_{2}$, equivalently $M_{2} \cong\left(\begin{array}{l}2 \\ 1 \\ 1\end{array}\right)$ with $\operatorname{ord}_{2}\left(d_{L}\right) \geq 2$, then

$$
r(4 n, \operatorname{gen}(L))=r\left(n, \operatorname{gen}\left(\lambda_{4}(L)\right)\right) .
$$

(3) Otherwise, $L_{p}=\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right) \perp\left\langle p^{m} \varepsilon\right\rangle$ for some $m \geq 2, \varepsilon \in \mathbb{Z}_{p}^{\times}$, and we have

$$
r(e p n, \operatorname{gen}(L))=2 r(e n, \operatorname{gen}(K))-r\left(e n / p, \operatorname{gen}\left(\lambda_{e p}(L)\right)\right),
$$

where $e=2$ if $p=2$, and 1 otherwise, and $K$ is a lattice such that $K_{p} \cong\left(\begin{array}{ll}0 & 1 \\ 1 & 0\end{array}\right) \perp\left\langle p^{m-1} \varepsilon\right\rangle$ and $K_{q} \cong L_{q}$ for any prime $q \neq p$.
In particular, $\operatorname{ord}_{p}\left(d_{\lambda_{p}(L)}\right)<\operatorname{ord}_{p}(L)$ and $\operatorname{ord}_{p}\left(d_{K}\right)<\operatorname{ord}_{p}(L)$ in any case.
Proof. (1) Assume that $M_{p}$ is anisotropic and $\mathfrak{n}\left(L_{p}\right)=\mathbb{Z}_{p}$. Then it is well known that

$$
r(p n, T)=r\left(p n, \Lambda_{p}(T)\right)
$$

for any $T \in \operatorname{gen}(L)$. Summing up over $[T] \in \operatorname{gen}(L) / \sim$, by (2.4), (2.5), and Lemma 2.10,

$$
\begin{aligned}
\sum_{[T] \in \operatorname{gen}(L) / \sim} \frac{r(p n, T)}{o(T)} & =\sum_{[T] \in \operatorname{gen}(L)} \frac{r\left(p n, \Lambda_{p}(T)\right)}{o(T)} \\
& \stackrel{(2.4)}{=} \sum_{[N] \in \operatorname{gen}\left(\Lambda_{p}(L)\right) / \sim[T] \in \Gamma_{p}^{L}(N) / \sim} \frac{o(N)}{o(T)} \frac{r(p n, N)}{o(N)} \\
& \stackrel{(2.5)}{=} \sum_{[N] \in \operatorname{gen}\left(\Lambda_{p}(L)\right) / \sim}\left|\Gamma_{p}^{L}(N)\right| \frac{r(p n, N)}{o(N)} \\
& =\frac{w(L)}{w\left(\Lambda_{p}(L)\right)} \sum_{[N] \in \operatorname{gen}\left(\Lambda_{p}(L)\right) / \sim} \frac{r(p n, N)}{o(N)} .
\end{aligned}
$$

This yields the first identity of part (1) of the theorem. The second identity follows by Lemmas 2.6 and 2.7.
(2) In this case, $r(4 n, T)=r\left(4 n, \Lambda_{4}(T)\right)$ for any $T \in \operatorname{gen}(L)$, and $\lambda_{4}(L)=\Lambda_{4}(L)^{\frac{1}{4}}$. The rest of the proof may be done in a similar way to (1).
(3) This is indeed a consequence of the results in [9], which introduce a generalization of Watson transformation. We first provide the proof for the case when $p$ is odd. Let $S \in \operatorname{gen}(L)$. There are exactly two sublattices of $S$, say $\Gamma_{p, 1}(S)$ and $\Gamma_{p, 2}(S)$, of index $p$ and of norm ideal $p \mathbb{Z}_{p}$. Note that $\Gamma_{p, 1}(S) \cap \Gamma_{p, 2}(S)=\Lambda_{p}(S)$, and they satisfy

$$
\begin{aligned}
r(p n, S) & =r\left(p n, \Gamma_{p, 1}(S)\right)+r\left(p n, \Gamma_{p, 2}(S)\right)-r\left(p n, \Lambda_{p}(S)\right) \\
& =r\left(n, \Gamma_{p, 1}(S)^{\frac{1}{p}}\right)+r\left(n, \Gamma_{p, 2}(S)^{\frac{1}{p}}\right)-r\left(p n, \Lambda_{p}(S)\right) .
\end{aligned}
$$

Moreover, $\Gamma_{p, 1}(S)$ and $\Gamma_{p, 2}(S)$ are the only sublattices of $S$ which belong to gen $\left(K^{p}\right)$. On the other hand, for any lattice $T \in \operatorname{gen}(K)$, the number of sublattices in $S$ that are isometric to $T^{p}$ is $\frac{r\left(T^{p}, S\right)}{o(T)}$. Hence, from the above equality and properties, we have

$$
\begin{equation*}
r(p n, S)=\sum_{[T] \in \operatorname{gen}(K) / \sim} \frac{r\left(T^{p}, S\right)}{o(T)} r(n, T)-r\left(p n, \Lambda_{p}(S)\right) . \tag{4.2}
\end{equation*}
$$

We refer the readers to the proof of Proposition 4.1 of [9] for more details.

Multiplying by $\frac{1}{o(S)}$ on both sides of (4.2) and summing up over $[S] \in \operatorname{gen}(L) / \sim$, we have

$$
\begin{equation*}
\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{r(p n, S)}{o(S)}=\sum_{[S] \in \operatorname{gen}(L) / \sim} \sum_{[T] \in \operatorname{gen}(K) / \sim} \frac{r\left(T^{p}, S\right)}{o(S)} \frac{r(n, T)}{o(T)}-\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{r\left(p n, \Lambda_{p}(S)\right)}{o(S)} . \tag{4.3}
\end{equation*}
$$

Following the proof of (1), the final sum on the right-hand side of (4.3) is equal to

$$
\begin{equation*}
w(L) \cdot r\left(p n, \operatorname{gen}\left(\Lambda_{p}(L)\right)\right)=w(L) \cdot r\left(n / p, \operatorname{gen}\left(\lambda_{p}(L)\right)\right), \tag{4.4}
\end{equation*}
$$

where in the last step we the used the fact that $\mathfrak{s}\left(\Lambda_{p}(L)\right)=p^{2} \mathbb{Z}_{p}$. To evaluate the first sum in (4.3), we interchange the sums and then use the fact from [9, Lemma 2.7] that

$$
r\left(T^{p}, S\right)=\tilde{r}\left(S^{p}, T\right):=\left\{\sigma: S^{p} \rightarrow T \mid T / \sigma\left(S^{p}\right) \simeq \mathbb{Z} / p \mathbb{Z} \oplus \mathbb{Z} / p \mathbb{Z}\right\}
$$

Since $m \geq 2$, [ 9 , Lemma 3.1] implies that

$$
\begin{equation*}
\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{r\left(T^{p}, S\right)}{o(S)}=\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{\tilde{r}\left(S^{p}, T\right)}{o(S)}=2 p \tag{4.5}
\end{equation*}
$$

Hence, the first double sum in (4.3) is equal to

$$
2 p \cdot \sum_{[T] \in \operatorname{gen}(K) / \sim} \frac{r(n, T)}{o(T)}=2 p \cdot w(K) \cdot r(n, \operatorname{gen}(K)) .
$$

Therefore, we have

$$
r(p n, \operatorname{gen}(L))=2 p \cdot \frac{w(K)}{w(L)} \cdot r(n, \operatorname{gen}(K))-r\left(n / p, \operatorname{gen}\left(\lambda_{p}(L)\right)\right)
$$

We claim that $2 p \cdot \frac{w(K)}{w(L)}=2$, from which the theorem follows. By Theorem 2.1, we have

$$
\frac{w(K)}{w(L)}=\frac{\left(d_{K}\right)^{2}}{\left(d_{L}\right)^{2}} \cdot \frac{\alpha_{p}(L, L)}{\alpha_{p}(K, K)}=\frac{1}{p^{2}} \cdot \frac{\beta_{p}(L, L)}{\beta_{p}(K, K)}
$$

and by using the formula in [8, Theorem 5.6.3], we may compute the local densities

$$
\beta_{p}(K, K)=4 p^{m-1}\left(1-\frac{1}{p}\right) \quad \text { and } \quad \beta_{p}(L, L)=4 p^{m}\left(1-\frac{1}{p}\right) .
$$

Thus, $\frac{w(K)}{w(L)}=\frac{1}{p}$, which proves the claim, hence the proof of (3) when $p$ is odd.
The proof for $p=2$ is the same, although one needs to be careful about the term "primitive" lattice. In [9], it means a lattice $L$ with $\mathfrak{n}(L)=\mathbb{Z}$, whereas we mean a lattice $L$ with $\mathfrak{s}(L)=\mathbb{Z}$, which cause some differences in the definitions of the Watson transformations. Precisely, using the terminology from this paper, two sublattices $\Gamma_{2,1}(S)$ and $\Gamma_{2,2}(S)$ are the only sublattices of $S$ of index 2 and of norm $4 \mathbb{Z}_{2}$, and their intersection is $\Lambda_{4}(S)$. If we replace $n$ by $2 n, \Lambda_{p}(S)$ by $\Lambda_{4}(S)$, and $\lambda_{p}(S)$ by $\lambda_{4}(S)$, respectively, then all the equalities until (4.3) and (4.4) holds. On the other hand, by Lemma [9, Lemma 3.1], (4.5) should be replaced by

$$
c:=\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{r\left(T^{2}, S\right)}{o(S)}=\sum_{[S] \in \operatorname{gen}(L) / \sim} \frac{\tilde{r}\left(S^{2}, T\right)}{o(S)}= \begin{cases}3 & \text { if } m=2, \\ 4 & \text { if } m \geq 3,\end{cases}
$$

so that we may obtain

$$
\begin{equation*}
r(4 n, \operatorname{gen}(L))=c \cdot \frac{w(K)}{w(L)} \cdot r(2 n, \operatorname{gen}(K))-r\left(n, \operatorname{gen}\left(\lambda_{4}(L)\right)\right) \tag{4.6}
\end{equation*}
$$

On the other hand, one may compute by [8, Theorem 5.6.3] that

$$
\beta_{2}(L, L)=2^{m+1} \quad \text { and } \quad \beta_{2}(K, K)= \begin{cases}3 & \text { if } m=2 \\ 2^{m} & \text { if } m \geq 3\end{cases}
$$

By Theorem 2.1, we have

$$
\frac{w(K)}{w(L)}=\frac{\left(d_{K}\right)^{2}}{\left(d_{L}\right)^{2}} \cdot \frac{\alpha_{2}(L, L)}{\alpha_{2}(K, K)}=\frac{1}{2^{2}} \cdot \frac{\beta_{2}(L, L)}{\beta_{2}(K, K)}= \begin{cases}\frac{2}{3} & \text { if } m=2, \\ \frac{1}{2} & \text { if } m \geq 3 .\end{cases}
$$

Thus, we have $c \cdot \frac{w(K)}{w(L)}=2$. Plugging this into (4.6) completes the proof of the theorem.
We are finally ready to prove Theorem 1.1.
Proof of Theorem 1.1. Again using (1.3), it remains to show that

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=c_{L}(n) \sum_{f \mid 2 d_{L}} a_{L, f}(n) \cdot H\left(\frac{4 s_{L} n}{f^{2}}\right), \tag{4.7}
\end{equation*}
$$

where $c_{L}(n)$ and $a_{L, f}(n)$ are constants depending only on the residue class of $n$ modulo some positive integer $M$. Moreover, we may assume that $L$ is primitive. For any ternary lattice $L$, define

$$
\mathfrak{D}_{L}=2^{\delta_{2 \notin \mathcal{P}} \cdot \operatorname{ord}_{2}\left(d_{L}\right)} \cdot \prod_{p \mid d_{L}, p \text { odd }} p^{\operatorname{ord}_{p}\left(d_{L}\right)-1}
$$

and let $k_{L}$ denote the number of prime divisors (counting with multiplicity) of $\mathfrak{D}_{L}$. Note that $k_{L} \geq 0, k_{L}=0$ if and only if $L$ is stable, and $p \mid \mathfrak{D}_{L}$ if and only if $p \mid 2 d_{L}$ and $p \notin \mathcal{P}$.

We prove the theorem by induction on $k_{L}$. When $k_{L}=0$, that is, when $L$ is a stable lattice, we directly obtain (4.7) from Theorem 1.3 (see also (3.16)). Precisely, if $L$ is odd, then noting that $\mathfrak{P}=2 d_{L}, e_{L}=4$, and $s_{L}=d_{L}$, we may take

$$
c_{L}(n)=12 \prod_{p \mid \mathfrak{F}}\left(p+S_{p}^{*}(L)\right)^{-1} \quad \text { and } \quad a_{L, f}(n)=f \cdot \prod_{p \mid f} S_{p}^{*}(L),
$$

which are clearly independent of $n$. If $L$ is even, we put $c_{L}(n)$ as above and take

$$
a_{L, f}(n)=\frac{f}{2} \cdot \prod_{p \mid f} S_{p}^{*}(L) \text { if } \operatorname{ord}_{2}(f)=1 \text { and } a_{L, f}=0 \text { otherwise. }
$$

Noting that $\mathfrak{P}=d_{L} / 2, e_{L}=1, s_{L}=d_{L}$, and $S_{2}^{*}(L)=1$, one may easily observe that the right-hand side of (4.7) with these constants is equal to that of (3.16).

Now, let $k \in \mathbb{N}$ be given and assume that (4.7) is valid for any ternary lattice $L$ with $k_{L}<k$. Let $L$ be a ternary lattice with $k_{L}=k$ and let $\mathfrak{n}(L)=N \mathbb{Z}$ for $N \in\{1,2\}$. We split the argument depending on the divisibility of $n$ by primes dividing $\mathfrak{D}_{L}$.

First suppose that $n \in \mathbb{N}$ satisfies $n \in N \mathbb{Z}_{p}^{\times}$for any $p \mid \mathfrak{D}_{L}$. Then $n \in \mathbb{N}_{p}^{\times}$for any $p \mid 2 d_{L}$ with $p \notin \mathcal{P}$, and we may apply Theorem 4.1. Noting that $\left.\frac{2}{\sqrt{e}} \mathfrak{P} \right\rvert\, 2 d_{L}$, where $e$ is the constant defined in Theorem 4.1, Theorem 4.1 and Remark 4.2 implies that there are $m_{1} \in \mathbb{N}$ and constants $c_{L}^{(1)}(n)$ and $a_{L, f}^{(1)}(n)$ for any $f \mid 2 d_{L}$ depending only on $n$ modulo $m_{1}$ satisfying (4.7) with $c_{L}(n)=c_{L}^{(1)}(n)$ and $a_{L, f}(n)=a_{L, f}^{(1)}(n)$ for any $n$ such that $n \in N \mathbb{Z}_{p}^{\times}$.

Now, we fix a prime $p \mid \mathfrak{D}_{L}$ and consider the case when $n \in p N \mathbb{Z}_{p}$. We claim that there are $m_{p} \in \mathbb{N}$ and constants $c_{L}^{(p)}(n)$ and $a_{L, f}^{(p)}(n)$ for any $f \mid 2 d_{L}$ dependent only on the residue class of $n$ modulo $m_{p}$ satisfying (4.7) with $c_{L}(n)=c_{L}^{(p)}(n)$ and $a_{L, f}(n)=a_{L, f}^{(p)}(n)$ for any $n$ such that $n \in p N \mathbb{Z}_{p}$. The proof of the claim will be done case-by-case, relying on reduction formulas in

Theorem 4.3. Since the proofs are similar for each cases, we only provide the proof for the case when $p$ is an odd prime.

Assume that $p$ is an odd prime. Since $p \mid \mathfrak{D}_{L}, L$ is not stable at $p$. Hence by Theorem 4.3

$$
r(n, \operatorname{gen}(L))= \begin{cases}r\left(n / p, \operatorname{gen}\left(L^{\prime}\right)\right) & \text { if } M_{p} \text { is anisotropic, } \mathfrak{s}\left(U_{p}\right)=p \mathbb{Z}_{p},  \tag{4.8}\\ r\left(n / p^{2}, \operatorname{gen}\left(L^{\prime}\right)\right) & \text { if } M_{p} \text { is anisotropic, } \mathfrak{s}\left(U_{p}\right) \subseteq p^{2} \mathbb{Z}_{p}, \\ r(n / p, \operatorname{gen}(K))-r\left(n / p^{2}, \operatorname{gen}\left(L^{\prime}\right)\right) & \text { if } M_{p} \text { is isotropic },\end{cases}
$$

where $L^{\prime}$ is the lattice $\lambda_{p}(L)$ obtained by Watson transformation, $K$ is a lattice defined in Theorem 4.3 (3), and $L_{p}=M_{p} \perp U_{p}$ is a Jordan decomposition of $L_{p}$ with the leading Jordan component $M_{p}$. Note that $d_{L^{\prime}}=d_{L} / p$ in the first case, $d_{L^{\prime}}=d_{L} / p^{2}$ or $d_{L} / p^{4}$ in the second case, and $d_{L^{\prime}}=d_{L} / p^{2}$ and $d_{K}=d_{L} / p$ in the third case. Moreover, $s_{L^{\prime}}=s_{L} / p$ or $p s_{L}$ in the first case, $s_{L^{\prime}}=s_{L}$ in the other cases, and $s_{K}=s_{L} / p$ or $p s_{L}$. In particular, $k_{L^{\prime}}, k_{K}<k_{L}=k$ for every term on the right-hand side. By the induction hypothesis, we obtain a formula of the form (4.7) for each term on the right-hand side of (4.8).

As an example, for the first case with $s_{L^{\prime}}=s_{L} / p$, there are $m_{p}^{\prime} \in \mathbb{N}$ and constants $c_{L^{\prime}}\left(n^{\prime}\right)$ and $a_{L^{\prime}, f^{\prime}}\left(n^{\prime}\right)$ for any $f^{\prime} \mid 2 d_{L^{\prime}}=2 d_{L} / p$ depending only on the residue class $n^{\prime}$ modulo $m_{p}^{\prime}$ such that

$$
\begin{aligned}
r\left(n / p, \operatorname{gen}\left(L^{\prime}\right)\right) & =c_{L^{\prime}}(n / p) \sum_{f^{\prime} \mid 2 d_{L^{\prime}}} a_{L^{\prime}, f^{\prime}}(n / p) \cdot H\left(\frac{4 s_{L^{\prime}}(n / p)}{f^{\prime 2}}\right) \\
& =c_{L^{\prime}}(n / p) \sum_{\left(p f^{\prime}\right) \mid 2 d_{L}} a_{L^{\prime}, f^{\prime}}(n / p) \cdot H\left(\frac{4 s_{L} n}{\left(p f^{\prime}\right)^{2}}\right) .
\end{aligned}
$$

$\operatorname{Put} c_{L}^{(p)}(n)=c_{L^{\prime}}(n / p)$, and for any $f \mid 2 d_{L}$ put $a_{L, f}^{(p)}(n)=a_{L^{\prime}, f / p}(n / p)$ if $p \mid f$ and $a_{L, f}^{(p)}(n)=0$ otherwise. Then these constants $c_{L}^{(p)}(n)$ and $a_{L, f}^{(p)}(n)$ are dependent only on the residue class of $n$ modulo $m_{p}=p \cdot m_{p}^{\prime}$, and one may observe that (4.7) holds for any $n$ such that $n \in p N \mathbb{Z}_{p}$ with $c_{L}(n)=c_{L}^{(p)}(n)$ and $a_{L, f}(n)=a_{L, f}^{(p)}(n)$. Other cases may also be deduced in the same manner, and we leave the details for the remaining cases to the reader.

Finally, let $\mathcal{S}=\{1\} \cup\left\{\right.$ prime divisors of $\left.\mathfrak{D}_{L}\right\}=\left\{p_{0}=1, p_{1}, \ldots, p_{h}\right\}$, and for any $p \in \mathcal{S}$, let $m_{p} \in \mathbb{N}, c_{L}^{(p)}(n)$ and $a_{L, f}^{(p)}(n)$ for any $f \mid 2 d_{L}$ be constants defined above. Let $M$ be the least common multiple of $m_{1}$ and $m_{p}$ for all $p \mid \mathfrak{D}_{L}$. Clearly, constants $c_{L}^{(p)}(n)$ and $a_{L, f}^{(p)}(n)$ are dependent only on the residue class of $n$ modulo $M$. Define constants $c_{L}(n)$ and $a_{L, f}(n)$ recursively as follows:
(1) for any $n$ with $n \in N \mathbb{Z}_{p}^{\times}$for all $p \mid \mathfrak{D}_{L}$, define $c_{L}(n)=c_{L}^{(1)}(n), a_{L, f}(n)=a_{L, f}^{(1)}(n)$,
(2) for $1 \leq i \leq h$, and for any $n$ with $n \in p_{i} N \mathbb{Z}_{p_{i}}$ and $n \notin p_{j} N \mathbb{Z}_{p_{j}}$ for all $1 \leq j \leq i-1$, define $c_{L}(n)=c_{L}^{\left(p_{i}\right)}(n), a_{L, f}(n)=a_{L, f}^{\left(p_{i}\right)}(n)$.
Then by the construction of the constants, $c_{L}(n)$ and $a_{L, f}(n)$ satisfies (4.7). This completes the proof of the theorem.

Remark 4.4. In practice, one would better find the constants $c_{L}(n)$ and $a_{L, f}(n)$ depending on the condition $n \in\left(\prod_{q \mid \mathfrak{D}_{L}} q^{e_{q}}\right) N \mathbb{Z}_{p}^{\times}(N \mathbb{Z}=\mathfrak{n}(L))$ for all primes $p \mid \mathfrak{D}_{L}$ for some powers $e_{q} \in \mathbb{N}$. One may use the reduction formulas in Theorem 4.3 recursively until one can apply Theorem 1.3 or Theorem 4.1. This should always work by the "in particular"-part of Theorem 4.3. The existence of $M \in \mathbb{N}$ also follows from this since the formula for $r(n, g e n(L))$ will eventually be reduced to certain linear combination of formulas for stable lattices for any $n \in\left(\prod_{q \mid \mathcal{D}_{L}} q^{e_{q}}\right) \mathbb{N}$ for sufficiently large $e_{q} \in \mathbb{N}$.

## 5. Examples

In this section, we provide several examples of how to use Theorems 1.3, 4.1, and 4.3 to obtain a formula for $r(n, \operatorname{gen}(L))$.

### 5.1. Example with stable lattices.

Example 5.1. We first give an example for a stable lattice. Let

$$
L=\langle 1,3,5\rangle .
$$

Clearly, $L$ is a stable lattice, hence we may apply Theorem 1.3. Note that $d_{L}=15$,

$$
\mathcal{P}_{L}=\{2,3,5\} \quad \text { and } \quad \mathfrak{P}_{L}=2^{-0} \cdot 2 \cdot 3 \cdot 5=30 .
$$

Also, $e=4$ since $L$ is odd, and for each $p \mid \mathfrak{P}$, we have

$$
S_{2}^{*}(L)=1, \quad S_{3}^{*}(L)=1, \quad \text { and } \quad S_{5}^{*}(L)=-1 .
$$

Therefore, by Theorem 1.3, we have

$$
\begin{aligned}
r(n, \operatorname{gen}(L))= & 12 \cdot \frac{1}{2+1} \cdot \frac{1}{3+1} \cdot \frac{1}{5-1} \times \sum_{f \mid 30}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{60 n}{f^{2}}\right) \\
= & \frac{1}{4}\left(H(60 n)+2 H(15 n)+3 H\left(\frac{20 n}{3}\right)+6 H\left(\frac{5 n}{3}\right)\right. \\
& \left.\quad-5 H\left(\frac{12 n}{5}\right)-10 H\left(\frac{3 n}{5}\right)-15 H\left(\frac{4 n}{5}\right)-30 H\left(\frac{n}{15}\right)\right) .
\end{aligned}
$$

Example 5.2. We provide another example for a stable lattice, which is even and non-diagonal. Let

$$
L=\left(\begin{array}{lll}
2 & 1 & 0 \\
1 & 2 & 1 \\
0 & 1 & 4
\end{array}\right)
$$

Note that $d_{L}=10$ and $L$ is even, and hence it is a stable lattice. Hence $e=1$,

$$
\mathcal{P}_{L}=\{2,5\} \quad \text { and } \quad \mathfrak{P}_{L}=2^{-1} \cdot 2 \cdot 5=5 .
$$

Moreover, $L_{5} \cong\langle 1,2,10\rangle$ over $\mathbb{Z}_{5}$, hence $S_{5}^{*}(L)=-1$. Therefore, by Theorem 1.3, we have

$$
r(n, \operatorname{gen}(L))=12 \cdot \frac{1}{5-1} \times \sum_{f \mid 5}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{10 n}{f^{2}}\right)=3\left(H(10 n)-5 H\left(\frac{2 n}{5}\right)\right) .
$$

5.2. An example of formulas for arbitrary lattices. We split Theorem 4.1 into further cases for ease of use in our examples. Namely, Theorem 4.1 may be written as

$$
\begin{aligned}
& r(n, \operatorname{gen}(L))=\prod_{\substack{p \mid 2 d_{L} \\
p \notin \mathcal{P}}} \alpha_{p}(n, L)\left(1-\left(\frac{d}{p}\right) \frac{1}{p}\right)\left(1-\frac{1}{p^{2}}\right)^{-1} \\
& \quad \times \begin{cases}\frac{24(s, n, 2)}{s t}\left[\prod_{p \in \mathcal{P}} \frac{p}{p+S_{p}^{*}(L)}\right] \cdot \sum_{f \mid \mathfrak{P}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{s n}{((s, n, 2) f)^{2}}\right) & \text { if } 2 \notin \mathcal{P}, \frac{s n}{(s, n)^{2}} \equiv 3(\bmod 4), \\
\frac{12(s, n, 2)}{s t}\left[\prod_{p \in \mathcal{P}} \frac{p}{p+S_{p}^{*}(L)}\right] \cdot \sum_{f \mid \mathfrak{P}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{4 s n}{((s, n, 2) f)^{2}}\right) & \text { if } 2 \notin \mathcal{P}, \frac{s n}{(s, n)^{2}} \not \equiv 3(\bmod 4), \\
\frac{12}{s t}\left[\prod_{p \in \mathcal{P}} \frac{p}{p+S_{p}^{*}(L)}\right] \cdot \sum_{f \mid \mathfrak{P}}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{4 s n}{f^{2}}\right) & \text { if } 2 \in \mathcal{P}, \operatorname{ord}_{2}\left(d_{L}\right)=0, \\
\frac{48}{s t}\left[\prod_{p \in \mathcal{P} \backslash\{2\}} \frac{p}{p+S_{p}^{*}(L)}\right] \cdot \sum_{f \mid \mathfrak{P} / 2}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{s n}{f^{2}}\right) & \text { if } 2 \in \mathcal{P}, \operatorname{ord}_{2}\left(d_{L}\right)=1 .\end{cases}
\end{aligned}
$$

Example 5.3. Let $n$ be a positive integer and let

$$
L=\langle 1,1,75\rangle .
$$

Note that $4 d_{L}=300, L$ is odd with $\operatorname{ord}_{2}\left(d_{L}\right)=0$, and $L$ is stable at prime numbers 2 and 3 , hence

$$
s=3, \quad t=10, \quad \mathcal{P}_{L}=\{2,3\}, \quad \mathfrak{P}_{L}=2^{-0} \cdot 2 \cdot 3=6, \quad \text { and } \quad(\epsilon, e)=(12,4) .
$$

Moreover, $S_{2}^{*}(L)=1$ and $S_{3}^{*}(L)=-1$.
Assume that $(n, 5)=1$. Noting that $\left(\frac{d}{5}\right)=\left(\frac{-s n}{5}\right)=-\left(\frac{n}{5}\right)$ and by Remark 4.2, we have

$$
c_{5}(n, L)=\left(1-\frac{1}{5}\right) \cdot\left(1+\left(\frac{n}{5}\right) \frac{1}{5}\right) \cdot\left(1-\frac{1}{5^{2}}\right)^{-1}= \begin{cases}1 & \text { if } n \equiv \pm 1(\bmod 5) \\ \frac{2}{3} & \text { if } n \equiv \pm 2(\bmod 5)\end{cases}
$$

Thus, by Theorem 4.1, we have

$$
\begin{align*}
r(n, \operatorname{gen}(L)) & =\frac{12}{3 \cdot 10} \cdot \frac{2}{2+1} \cdot \frac{3}{3-1} \cdot c_{5}(n, L) \times \sum_{f \mid 6}\left[\prod_{p \mid f} S_{p}^{*}(L)\right] \cdot f \cdot H\left(\frac{12 n}{f^{2}}\right)  \tag{5.1}\\
& =c_{L}(n)\left(H(12 n)+2 H(3 n)-3 H\left(\frac{4 n}{3}\right)-6 H\left(\frac{n}{3}\right)\right),
\end{align*}
$$

where $c_{L}(n)=\frac{2}{5}$ if $n \equiv \pm 1(\bmod 5)$, and $c_{L}(n)=\frac{4}{15}$ if $n \equiv \pm 2(\bmod 5)$.
Now assume that $n \equiv 0(\bmod 5)$ and write $n=5 n_{0}$ for some $n_{0} \in \mathbb{N}$. Note that

$$
L_{5} \cong\left\langle 1,-1,3 \cdot 5^{2}\right\rangle \cong\left(\begin{array}{cc}
0 & 1 \\
1 & 0
\end{array}\right) \perp\left\langle 3 \cdot 5^{2}\right\rangle \text { over } \mathbb{Z}_{5} .
$$

By Theorem 4.3 (3),

$$
\begin{equation*}
r(n, \operatorname{gen}(L))=r\left(5 n_{0}, \operatorname{gen}(L)\right)=2 r\left(n_{0}, \operatorname{gen}(K)\right)-r\left(n_{0} / 5, \operatorname{gen}\left(\lambda_{5}(L)\right)\right) \tag{5.2}
\end{equation*}
$$

Here, $\lambda_{5}(L)=\langle 1,1,3\rangle$ and $K$ is a lattice with $d_{K}=15$ whose genus is characterized by

$$
K_{5} \cong\left(\begin{array}{cc}
0 & 1 \\
1 & 0
\end{array}\right) \perp\langle 3 \cdot 5\rangle \text { over } \mathbb{Z}_{5} \text { and } K_{p} \cong L_{p} \text { for any } p \neq 5
$$

Indeed, $K$ may explicitly be chosen as $\langle 1,1,15\rangle$, which is a lattice obtained by scaling one of two sublattices of $L$ of index 5 and of norm ideal $5 \mathbb{Z}$ by $\frac{1}{5}$. Note that both $K$ and $\lambda_{5}(L)$ are stable lattices. Hence by Theorem 1.3, we may have

$$
\begin{aligned}
& r\left(n_{0}, \operatorname{gen}(K)\right)=\frac{1}{3}\left(H\left(60 n_{0}\right)+2 H\left(15 n_{0}\right)-3 H\left(\frac{20 n_{0}}{3}\right)-6 H\left(\frac{5 n_{0}}{3}\right)\right. \\
& \left.\quad+5 H\left(\frac{12 n_{0}}{5}\right)+10 H\left(\frac{3 n_{0}}{5}\right)-15 H\left(\frac{4 n_{0}}{15}\right)-30 H\left(\frac{n_{0}}{15}\right)\right) \\
& =\frac{1}{3}\left(H(12 n)+2 H(3 n)-3 H\left(\frac{4 n}{3}\right)-6 H\left(\frac{n}{3}\right)+5 H\left(\frac{12 n}{25}\right)+10 H\left(\frac{3 n}{25}\right)-15 H\left(\frac{4 n}{75}\right)-30 H\left(\frac{n}{75}\right)\right),
\end{aligned}
$$

and

$$
\begin{aligned}
r\left(n_{0} / 5, \operatorname{gen}\left(\lambda_{5}(L)\right)\right) & =2\left(H\left(12 n_{0} / 5\right)+2 H\left(3 n_{0}\right)-3 H\left(\frac{4 n_{0} / 5}{3}\right)-6 H\left(\frac{n_{0} / 5}{3}\right)\right) \\
& =2\left(H\left(\frac{12 n}{25}\right)+2 H\left(\frac{3 n}{25}\right)-3 H\left(\frac{4 n}{75}\right)-6 H\left(\frac{n}{75}\right)\right) .
\end{aligned}
$$

Plugging the two formulas above into (5.2), we obtain a formula for $n \equiv 0(\bmod 5)$. Combining this together with (5.1), we obtain overall that

$$
\begin{aligned}
r(n, \operatorname{gen}(L))=c_{L}(n) \cdot(H(12 n)+2 H(3 n) & -3 H\left(\frac{4 n}{3}\right)-6 H\left(\frac{n}{3}\right) \\
& \left.+2 H\left(\frac{12 n}{25}\right)+4 H\left(\frac{3 n}{25}\right)-6 H\left(\frac{4 n}{75}\right)-12 H\left(\frac{n}{75}\right)\right),
\end{aligned}
$$

where $c_{L}(n)=\frac{2}{5}, \frac{4}{15}$, or $\frac{2}{3}$ if $n \equiv \pm 1(\bmod 5), n \equiv \pm 2(\bmod 5)$, or $n \equiv 0(\bmod 5)$, respectively.
