# Factorials and Legendre's three-square theorem: II

#### Abstract

Let $\bar{S}$ denote the set of integers $n$ such that $n$ ! cannot be written as a sum of three squares. Let $\bar{S}(n)$ denote $\bar{S} \cap[1, n]$. We establish an exact formula for $\bar{S}\left(2^{k}\right)$ and show that $\bar{S}(n)=1 / 8 * n+\mathcal{O}(\sqrt{n})$. We also list the lengths of gaps appearing in $\bar{S}$. We make use of the software package Walnut to establish these results.


## 1 Introduction

In a previous paper [1], we constructed an automaton accepting integers $n$ such that $n$ ! cannot be written as a sum of three squares. In the current paper we use this automaton and the software package Walnut to explore the sets

$$
\begin{gathered}
S:=\{n: n!\text { is a sum of three squares }\}, \\
\bar{S}:=\{n: n!\text { is not a sum of three squares }\} \\
S(n):=\{x \leq n: x!\text { is a sum of three squares }\} .
\end{gathered}
$$

and

$$
\bar{S}(n):=\{x \leq n: x!\text { is not a sum of three squares }\}
$$

In particular, we establish a formula for $S\left(2^{k}\right)$, or equivalently, $\bar{S}\left(2^{k}\right)$, and show that $\bar{S}(n)=1 / 8 * n+\mathcal{O}(\sqrt{n})$. We also list the lengths of possible gaps in $S$ and its complement $\bar{S}$.

We mention here some similar previous results. In [2], Deshouillers and Luca established the two equivalent bounds

$$
S(n)=7 n / 8+\mathcal{O}\left(n^{2 / 3}\right) \text { and } \bar{S}(n)=x / 8+\mathcal{O}\left(n^{2 / 3}\right)
$$

This bound was improved by Hajdu and Papp [7] to

$$
\bar{S}(n)=x / 8+\mathcal{O}\left(n^{1 / 2} \log ^{2} n\right)
$$

Hajdu and Papp [7] proved that the largest gap between consecutive elements of $\bar{S}$ is 42 . In theorem 3.1, we list the lengths of all gaps that occur between consecutive elements of $S$ and $\bar{S}$.

We make use of the software package Walnut. Hamoon Mousavi, who wrote the program, has provided an introductory article [8]. Papers that have used Walnut include [9], [12], [10], [5], [3]. Further resources related to Walnut can be found at Jeffrey Shallit's page

The free open-source mathematics software system SageMath [14] was essential for the matrix algebra and factoring of polynomials.
In the next section, we describe the automaton that will be used to examine $\bar{S}$ and $\bar{S}(x)$.

## 2 The automaton

We first summarise the conditions satisfied by integers in $\bar{S}$. These come from [1] but were previously established by Granville and Zhu in 1990 [6]. Let $n \in \mathbb{N}$, with binary representation given by $n=\sum_{k \geq 0} a_{k} 2^{k}$, where all but finitely many $a_{i}$ are zero. Let $\gamma$ be the highest power of 2 dividing $n!$. For $i \in\{3,5\}$, define $\alpha_{i}=\alpha_{i}(n)$ by

$$
\begin{align*}
& \alpha_{3}=\alpha_{3}(n):=\#\left\{k \geq 0: \sum_{i=k}^{k+2} a_{i} 2^{i-k} \in\{3,4\}\right\}  \tag{1}\\
& \alpha_{5}=\alpha_{5}(n):=\#\left\{k \geq 0: \sum_{i=k}^{k+2} a_{i} 2^{i-k} \in\{5,6\}\right\} . \tag{2}
\end{align*}
$$

Theorem 2.1. Let $n \in \mathbb{N}$ have binary representation $n=\sum_{k \geq 0} a_{k} 2^{k}$, where all but finitely many $a_{i}$ are zero. If $\gamma$ is the highest power of 2 dividing $n!$, then $n!=2^{\gamma} Z$, where $Z$ satisfies

$$
Z \equiv 3^{\alpha_{3}(n)}(-1)^{\alpha_{5}(n)} \quad(\bmod 8)
$$

Corollary 2.2. If $n \in \mathbb{N}$, then $n$ ! cannot be written as a sum of three squares if and only if $\gamma$ and $\alpha_{3}$ are even and $\alpha_{5}$ is odd.

According to the above two results, whether $n$ ! can be written as a sum of three squares is determined by the triple $\left(\gamma(\bmod 2), \alpha_{3}(\bmod 2), \alpha_{5}(\bmod 2)\right)$. For convenience,

(n): ?1sd_2 \$gamma(n)

we will give this triple a name. For integers $n$, define $\Theta(n)$ by

$$
\Theta(n):=\left(\gamma \quad(\bmod 2), \alpha_{3} \quad(\bmod 2), \alpha_{5} \quad(\bmod 2)\right) .
$$

The components of $\Theta(n)$ are

$$
\begin{equation*}
\Theta_{1}(n):=\gamma \quad(\bmod 2), \quad \Theta_{2}(n):=\alpha_{3} \quad(\bmod 2), \quad \Theta_{3}(n):=\alpha_{5} \quad(\bmod 2) \tag{3}
\end{equation*}
$$

Then, $n \in \bar{S}$ if and only if $\Theta(n)=(0,0,1)$.
We present here three automata which take as input the binary digits of an integer $n$, starting with the least significant digit. The automata were produced by Walnut based on the instructions provided in [1]. The first automaton, which we call gamma, is pictured in figure 1. It accepts integers $n$ if and only if $\gamma(n)$ is even. The second automaton, which we call a3, is pictured in figure 2 . It accepts integers $n$ if and only if $\alpha_{3}(n)$ is even. The third automaton, which we call a5, is pictured in figure 3. It accepts integers $n$ if and only if the $\alpha 5(n)$ is even.
For any triple of binary digits $(x, y, z)$, we can use Walnut to create an automaton which accepts $n$ if and only if $\Theta(n)=(x, y, z)$. We are particularly interested in determining when $\Theta(n)=(0,0,1)$. We create this automaton using the Walnut command:

The resulting automaton has 33 states and is pictured in figure 4 .

## 3 Gaps and runs in $S$ and $\bar{S}$

In this section we investigate the gaps and runs in the sets $S$ and $\bar{S}$. A gap $g$ exists in $S$ (or $\bar{S}$ ) if there are integers $x$ and $y$ which are consecutive elements of $S$ and such that $y-x=g$. A run of length $r$ exists in $S$ (or $\bar{S}$ ) if $S$ contains $x, x+1, \ldots, x+r-1$ but $x-1$ and $x+r$ are not in $S$. Since $S \cup \bar{S}=\mathbb{N}$, gaps in $S$ correspond to runs in $\bar{S}$ and vice versa. For example, if $S$ contains a run of size $r$, then $\bar{S}$ contains a gap of length $r+1$.
In [7], Hajdu and Papp proved that the largest gap between consecutive elements of $\bar{S}$ is 42 .

Theorem 3.1. The gap sizes in $S$ are $\{1,2,3,4\}$. The gap sizes in $\bar{S}$ are

$$
\{1,2,3, \ldots, 23,25,26,28,30,31,33,34,35,37,38,42\}
$$

Proof. We firstly deal with $\bar{S}$. Recall the automaton "factauto" which was defined previously. It accepts integers $n$ such that $n!$ cannot be written as a sum of three squares. We use Walnut to define an automaton, which we call "gaps":

```
def gaps "?lsd_2 $factauto(n) & $factauto(n+r) & (Aj (j < r-1) => ~$
    factauto(n+ j + 1))":
```

This automaton takes as input the integer pair $(n, r)$ and reaches an accepting state if and only if $n \in \bar{S}$ and the next integer in $\bar{S}$ is $n+r$, i.e. there a gap of length $r$ in $\bar{S}$ starting at $n$. Since the automaton has 319 states, we will not display it here. The following Walnut command creates an automaton which accepts an integer $r$ if and only if there is a gap of length $r$ somewhere in $\bar{S}$ :

```
eval tmp "?lsd_2 E n $gaps(n, r)":
```

This automaton is displayed in figure 5. A patient reader will see that the automaton accepts the integers listed in the theorem.
We can use the same approach to find all gaps in the set $S$. We define the automaton "sgaps" which takes as input the integer pair $(n, r)$ and reaches an accepting state if and only if $n \in S$ and the next integer in $S$ is $n+r$, i.e. there a gap of length $r$ in $S$ starting at $n$.

def sgaps "?1sd_2 ~$factauto(n) & ~$factauto(n+r) & (Aj (j < r-1) => $
    factauto(n+ j + 1))":
```

The resulting automaton has 203 states. The following Walnut command creates an automaton which accepts an integer $r$ if and only if there is a gap of length $r$ somewhere in $S$ :

```
eval tmp "?lsd_2 E n $sgaps(n, r)":
```

This automaton is displayed in figure 6. It is clear that it only accepts the integers $1,2,3,4$.

Remarks. A gap of 42 in $\bar{S}$ commences at $n=23268$ as mentioned by Hajdu and Papp. This is the second last gap to appear in the sequence $\bar{S}$. The last gap to appear in $\bar{S}$ is 33 , which commences at $n=153828=(100101100011100100)_{2}$.
Theorem 3.1 is about gaps in the set $\bar{S}$ which contains integers $n$ satisfying $\Theta(n)=$ $(0,0,1)$. The same method can be used for other sets defined in terms of $\Theta$ (see (9) below). Hajdu and Papp showed that the maximum gap length in any of these sets is 42 .

## 4 A formula for $\bar{S}\left(2^{k}\right)$

In this section we establish a formula for $\bar{S}\left(2^{k}\right)$, The method we use is taken from the papers [4], [11], [13]. Firstly, we use Walnut to obtain a linear representation of $\bar{S}(n)$. Walnut produces matrices $M_{0}$ and $M_{1}$ and vectors $v$ and $w$ such that, if $n$ has binary representation $\left(n_{0}, n_{1}, \ldots, n_{k}\right)$ where $n_{0}$ is the least significant digit, then

$$
\begin{equation*}
\bar{S}(n)=v * M_{n_{0}} * M_{n_{1}} * \cdots * M_{n_{k}} * w \tag{4}
\end{equation*}
$$

In the particular case that $n=2^{k}$, we have $\bar{S}\left(2^{k}\right)=v * M_{0}^{k} * M_{1} * w$. The theory of linear recurrences says that there are constants $\left\{c_{i}\right\}$ such that $\bar{S}\left(2^{k}\right)$ can be written as

$$
\begin{equation*}
\bar{S}\left(2^{k}\right)=\sum_{i} c_{i} \lambda_{i}^{k} \tag{5}
\end{equation*}
$$

where $\left\{\lambda_{i}\right\}$ are the roots of the minimal polynomial of $M_{0}$. The constants $\left\{c_{i}\right\}$ can be determined by calculating $\bar{S}\left(2^{k}\right)$ for enough values of $k$ and plugging the values into (5) to obtain a system of linear equations that can be solved.

Theorem 4.1. For $k \geq 2$,

$$
\bar{S}\left(2^{k}\right)= \begin{cases}2^{k-3}-2^{(k-4) / 2}, & \text { if } k \equiv\{0,2,22\} \quad(\bmod 24) \\ 2^{k-3}-2^{(k-3) / 2}, & \text { if } k \equiv\{1,3\} \quad(\bmod 24) \\ 2^{k-3}-2^{(k-5) / 2}, & \text { if } k \equiv 11 \quad(\bmod 24) \\ 2^{k-3}+2^{(k-4) / 2}, & \text { if } k \equiv\{14,16,18\} \quad(\bmod 24) \\ 2^{k-3}+2^{(k-3) / 2}, & \text { if } k \equiv 17 \quad(\bmod 24) \\ 2^{k-3}-3 * 2^{(k-5) / 2}, & \text { if } k \equiv 23 \quad(\bmod 24) \\ 2^{k-3} & \text { otherwise }\end{cases}
$$

Proof. The Walnut command
eval sumfact $n$ "?1sd_2 ( $j>=1$ ) \& ( $j<=n$ ) \& \$factauto $(j)$ ":
produces the matrices $M_{0}$ and $M_{1}$ and the vectors $v$ and $w$ mentioned above. Since the dimensions of these objects are large, we will not display them here. The minimal
polynomial of $M_{0}$ is

$$
\begin{aligned}
& h(x)=x^{20}-7 * x^{19}+20 * x^{18}-30 * x^{17}+24 * x^{16}-40 * x^{14}+64 * x^{13}-128 * x^{11} \\
& \quad+160 * x^{10}-384 * x^{8}+960 * x^{7}-1280 * x^{6}+896 * x^{5}-256 * x^{4} \\
& \quad=(x-2) *(x-1) *(x-i-1) *(x+i-1) *(x-i \sqrt{2}) *(x+i \sqrt{2}) * \\
& \quad *(x+\sqrt{2}) *(x+(-i / 2+1 / 2) * \sqrt{3}+i / 2-1 / 2) * \\
& \quad *(x-1 / 2 * \sqrt{2} * \sqrt{3}+1 / 2 * \sqrt{2}) *(x+1 / 2 * \sqrt{2} * \sqrt{3}+1 / 2 * \sqrt{2}) * \\
& \quad *(x+(i / 2+1 / 2) * \sqrt{3}-i / 2-1 / 2) *(x+(-i / 2-1 / 2) * \sqrt{3}-i / 2-1 / 2) * \\
& \quad *(x-1 / 2 * \sqrt{2} * \sqrt{3}-1 / 2 * \sqrt{2}) *(x+1 / 2 * \sqrt{2} * \sqrt{3}-1 / 2 * \sqrt{2}) * \\
& \quad *(x+(i / 2-1 / 2) * \sqrt{3}+i / 2-1 / 2) *(x-\sqrt{2}) * x^{4}
\end{aligned}
$$

All roots of $h$, apart from 2 and 1 , are of the form $\lambda_{i}=\sqrt{2} *$ (a 24 'th root of unity). We then have for $0 \leq s<24$,

$$
\begin{align*}
\bar{S}\left(2^{24 k+s}\right) & =\sum_{j} c_{j} \lambda_{j}^{24 k+s}=c_{0} * 2^{24 k+s}+c_{1}+\sum_{\lambda_{j} \nless, 2} c_{j} \lambda_{j}^{24 k+s} \\
& =c_{0} * 2^{24 k+s}+c_{1}+2^{12 k} * \sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{s} \tag{6}
\end{align*}
$$

The values of the $\left\{c_{j}\right\}$ can be determined by calculating $\bar{S}\left(2^{k}\right)$ for enough $k$ using (4). We create a matrix $A$ having the same dimension as the number of constants. The $j$ 'th row of $A$ is

$$
2^{j+2}, 1, \lambda_{2}^{j+2}, \lambda_{3}^{j+2}, \ldots
$$

Then the vector of constants is given by

$$
\left(c_{0}, c_{1}, \ldots\right)=A^{-1} *\left(\bar{S}\left(2^{2}\right), \bar{S}\left(2^{3}\right), \ldots\right)
$$

The calculation gives $c_{0}=1 / 8$ and $c_{1}=0$. Since we are only interested in the values for $c_{0}$ and $c_{1}$, an alternative approach is to use (6) and the calculated values of, say, $\bar{S}\left(2^{3}\right)=0, \bar{S}\left(2^{27}\right)=16773120$ and $\bar{S}\left(2^{51}\right)=281474959933440$ to create three linear equations. The equations are:

$$
\begin{aligned}
2^{3} * c_{0}+c_{1}+\tau & =0 \\
2^{27} * c_{0}+c_{1}+2^{12} * \tau & =16773120 \\
2^{51} * c_{0}+c_{1}+2^{24} * \tau & =281474959933440
\end{aligned}
$$

where $\tau=\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{3}$. These can be solved to give $c_{0}=1 / 8, c_{1}=0$ and $\tau=-1$.
Plugging the values for $c_{0}$ and $c_{1}$ into (6), we see that, for each $0 \leq s<24$, the terms $\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{s}$ satisfy

$$
\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{s}=\bar{S}\left(2^{s}\right)-2^{s-3}
$$

As an example of the calculation that is required for each $s, \bar{S}\left(2^{3}\right)=0$ so $\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{3}=$ -1 . Hence, if $n \equiv 3(\bmod 24)$, then $\bar{S}\left(2^{n}\right)=2^{n-3}-2^{12 *\lfloor n / 24\rfloor}=2^{n-3}-2^{(n-3) / 2}$. Here $\lfloor x\rfloor$ is the floor function. A similar calculation can be made for each $s$.

Theorem 4.2. For $k \geq 5$,

$$
\bar{S}\left(3 * 2^{k}\right)= \begin{cases}3 * 2^{k-3}+1, & \text { if } k \equiv\{7,9,13,18,19\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1-2^{(k-3) / 2}, & \text { if } k \equiv\{1,3,5\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1-2^{(k-2) / 2}, & \text { if } k \equiv\{0,4,10\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1-2^{(k-4) / 2}, & \text { if } k \equiv\{2,6,8,12\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1-2^{(k-5) / 2}, & \text { if } k \equiv\{11,23\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1+2^{(k-4) / 2}, & \text { if } k \equiv 14 \quad(\bmod 24) \\ 3 * 2^{k-3}+1+2^{(k-1) / 2}, & \text { if } k \equiv 15 \quad(\bmod 24) \\ 3 * 2^{k-3}+1+3 * 2^{(k-4) / 2}, & \text { if } k \equiv 16 \quad(\bmod 24) \\ 3 * 2^{k-3}+1+2^{(k-3) / 2}, & \text { if } k \equiv 17 \quad(\bmod 24) \\ 3 * 2^{k-3}+1-3 * 2^{(k-4) / 2}, & \text { if } k \equiv\{20,22\} \quad(\bmod 24) \\ 3 * 2^{k-3}+1-2^{(k-1) / 2}, & \text { if } k \equiv 21 \quad(\bmod 24)\end{cases}
$$

Proof. From (4),

$$
\bar{S}\left(3 * 2^{k}\right)=v * M_{0}^{k} * M_{1} * M_{1} * w
$$

We can therefore use the same approach as in theorem 4.1. We have,

$$
\begin{equation*}
\bar{S}\left(3 * 2^{k}\right)=\sum_{i} c_{i} \lambda_{i}^{k} \tag{7}
\end{equation*}
$$

where $\left\{c_{j}\right\}$ are constants and $\left\{\lambda_{j}\right\}$ are the roots of the minimal polynomial of $M_{0}$, which we have already calculated. The constants $c_{0}$ and $c_{1}$ can be calculated using the values of $\bar{S}\left(3 * 2^{3}\right)=3, \bar{S}\left(3 * 2^{27}\right)=50327553$ and $\bar{S}\left(3 * 2^{51}\right)=844424913354753$ to create three linear equations. The equations are:

$$
\begin{aligned}
2^{3} * c_{0}+c_{1}+\tau & =3 \\
2^{27} * c_{0}+c_{1}+2^{12} * \tau & =50327553 \\
2^{51} * c_{0}+c_{1}+2^{24} * \tau & =844424913354753
\end{aligned}
$$

where $\tau=\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{3}$. These can be solved to give $c_{0}=3 / 8, c_{1}=0$ and $\tau=-1$. As before, we have for $0 \leq s<24$,

$$
\begin{align*}
\bar{S}\left(3 * 2^{24 k+s}\right) & =\sum_{j} c_{j} \lambda_{j}^{24 k+s}=3 / 8 * 2^{24 k+s}+1+\sum_{\lambda_{j} \nmid, 2} c_{j} \lambda_{j}^{24 k+s}  \tag{8}\\
& =3 * 2^{24 k+s-3}+1+2^{12 k} * \sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{s}
\end{align*}
$$

The formula for $\bar{S}\left(3 * 2^{k}\right)$ can be deduced once (7) is used to calculate $\sum_{\lambda_{j} \neq 1,2} c_{j} \lambda_{j}^{s}$ for each $0 \leq s<24$.

## 5 A bound for $\bar{S}(n)$

In this section we establish a best possible bound on $\bar{S}(n)$. We borrow an argument from the paper by Hajdu and Papp [7].
We introduce the following sets for any triple $(x, y, z)$ of binary digits:

$$
\begin{align*}
\bar{S}_{(x, y, z)} & :=\{n: \Theta(n)=(x, y, z)\}, \\
\bar{S}_{(x, y, z)}(n) & :=\{r \leq n: \Theta(r)=(x, y, z)\},  \tag{9}\\
\bar{S}_{(x, y, z)}(m, n) & :=\{m<r \leq n: \Theta(r)=(x, y, z)\}
\end{align*}
$$

Then $\bar{S}_{(0,0,1)}=\bar{S}$ and $\bar{S}_{(0,0,1)}(n)=\bar{S}(n)$.
Note that our set $\bar{S}_{(x, y, z)}$ is equivalent to the set $H^{(\alpha, \beta)}$ used by Hajdu and Papp, where $\alpha=x$ and $\beta=3^{y}(-1)^{z}$.
We note that the results from the previous section show that

$$
\bar{S}\left(2^{k}\right)=1 / 8 * 2^{k}+\mathcal{O}\left(\sqrt{2^{k}}\right) \quad \text { and } \quad \bar{S}\left(3 * 2^{k}\right)=1 / 8\left(3 * 2^{k}\right)+\mathcal{O}\left(\sqrt{2^{k}}\right)
$$

The same bound can be shown to apply for other sets of numbers defined by ( $\gamma, \alpha_{3}, \alpha_{5}$ ). In summary, as for the case when $(x, y, z)=(0,0,1)$, the set $\bar{S}_{(x, y, z)}(n)$ is accepted by an automaton constructed from the automata "gamma", "a3" and "a5" displayed earlier. For example, the set of $\{n: \Theta(n)=(1,1,1)\}$ is accepted by the automaton defined by the Walnut command:

```
def factauto111 "?lsd_2 ~$gamma(n) & ~$a3(n) & ~$a5(n)":
```

As before, a linear representation of this automaton in terms of the matrices $M_{0}$ and $M_{1}$ and the vectors $v$ and $w$ comes from the command:

```
eval sumfact111 n "?lsd_2 (j>=1) & (j<=n) & $factauto111(j)":
```

For all choices of $(x, y, z)$, the matrix $M_{0}$ that Walnut produces is the same as the matrix $M_{0}$ that was produced by the automaton "sumfact" that was used in analysing the $\Theta(n)=(0,0,1)$ case. All the previous analysis related to the case $\Theta(n)=(0,0,1)$ therefore applies to the other choices of $(x, y, z)$. As a result, the same methods show that, for any $(x, y, z)$,

$$
\begin{equation*}
\bar{S}_{(x, y, z)}\left(2^{k}\right)=1 / 8 * 2^{k}+\mathcal{O}\left(\sqrt{2^{k}}\right) \quad \text { and } \quad \bar{S}_{(x, y, z)}\left(3 * 2^{k}\right)=1 / 8\left(3 * 2^{k}\right)+\mathcal{O}\left(\sqrt{2^{k}}\right) \tag{10}
\end{equation*}
$$

It then follows that, for any choice of $(x, y, z)$ and $k$,

$$
\begin{align*}
\bar{S}_{(x, y, z)}\left(2^{k}, 2^{k+1}\right) & =1 / 8 * 2^{k}+\mathcal{O}\left(\sqrt{2^{k}}\right) \\
\bar{S}_{(x, y, z)}\left(2^{k+1}, 3 * 2^{k}\right) & =1 / 8 * 2^{k}+\mathcal{O}\left(\sqrt{2^{k}}\right)  \tag{11}\\
\bar{S}_{(x, y, z)}\left(3 * 2^{k-2}, 2^{k}\right) & =1 / 8 * 2^{k}+\mathcal{O}\left(\sqrt{2^{k}}\right) .
\end{align*}
$$

Lemma 5.1 (Hajdu and Papp Lemma 3.1). For any integer $k$ with $k \geq 1$, we have $\gamma\left(t * 2^{k}+i\right)=\gamma(i)+\gamma\left(t * 2^{k}\right)(\bmod 2)$ for $0 \leq i<2^{k}$.

For the following lemma, we divide the region $\left[0,2^{s}\right)$ into four equal sized subregions given by:

$$
\begin{align*}
I_{1} & :=\left\{i: 0 \leq i<2^{s-2}\right\} \\
I_{2} & :=\left\{i: 2^{s-2} \leq i<2^{s-1}\right\} \\
I_{3} & :=\left\{i: 2^{s-1} \leq i<3 * 2^{s-2}\right\}  \tag{12}\\
I_{4} & :=\left\{i: 3 * 2^{s-2} \leq i<2^{s}\right\} .
\end{align*}
$$

Lemma 5.2 (Hajdu and Papp Lemma 3.3). Let $k$ be an integer and $t$ an odd integer with $t \geq 1$. Then, for each $j \in\{1,2,3,4\}$, there exist numbers $c(t, j) \in\{1,3,5,7\}$ such that

$$
3^{\alpha_{3}\left(t * 2^{k}+i\right)} *(-1)^{\alpha_{5}\left(t * 2^{k}+i\right)}=c(t, j) * 3^{\alpha_{3}(i)} *(-1)^{\alpha_{5}(i)} \quad(\bmod 8)
$$

for all $i \in I_{j}$.

Lemma 5.3. For integers $r, s$ and $t$ satisfying $0 \leq r<s, 0 \leq t<2^{s}, 2$ Xt,

$$
\bar{S}\left(t * 2^{s}, t * 2^{s}+2^{r}\right)=1 / 8 * 2^{r}+\mathcal{O}\left(\sqrt{2^{r}}\right)
$$

Proof.

$$
\begin{aligned}
\bar{S}\left(t * 2^{s}, t * 2^{s}+2^{r}\right) & =\#\left\{i: 0 \leq i<2^{r}, \Theta\left(t * 2^{s}+i\right)=(0,0,1)\right\} \\
& =\sum_{j=1}^{4}\left\{i \in I_{j}: \Theta\left(t * 2^{s}+i\right)=(0,0,1)\right\}
\end{aligned}
$$

where $I_{j}$ are the regions defined in (12). From lemma 5.1, if $0 \leq i<2^{s}$,

$$
\Theta_{1}\left(t * 2^{s}+i\right)=0 \Longleftrightarrow \Theta_{1}(i)=-\Theta_{1}\left(t * 2^{s}\right)
$$

From lemma 5.2, if $i \in I_{j}$,

$$
\begin{aligned}
\left(\Theta_{2}\left(t * 2^{s}+i\right),\right. & \left.\Theta_{3}\left(t * 2^{s}+i\right)\right)=(0,1) \\
& \Longleftrightarrow c(t, j) * 3^{\alpha_{3}(i)} *(-1)^{\alpha_{5}(i)} \equiv-1 \quad(\bmod 8) \\
& \Longleftrightarrow\left(\Theta_{2}(i), \Theta_{3}(i)\right)=\left(d_{2}(t, j), d_{3}(t, j)\right)
\end{aligned}
$$

for some $d_{1}, d_{2} \in\{0,1\}$. Hence,

$$
\begin{aligned}
\bar{S}\left(t * 2^{s}, t * 2^{s}+2^{r}\right)= & \sum_{j=1}^{4} \#\left\{i \in I_{j}: \Theta(i)=\left(-\Theta_{1}\left(t * 2^{k}\right), d_{2}(t, j), d_{3}(t, j)\right)\right\} \\
= & \bar{S}_{(x, y, z)_{1}}\left(2^{r-2}\right)+\bar{S}_{(x, y, z)_{2}}\left(2^{r-2}, 2^{r-1}\right)+ \\
& +\bar{S}_{(x, y, z)_{3}}\left(2^{r-1}, 3 * 2^{r-2}\right)+\bar{S}_{(x, y, z)_{4}}\left(3 * 2^{r-2}, 2^{r}\right) \\
= & 4 *\left(1 / 8 * 2^{r-2}+\mathcal{O}\left(\sqrt{2^{r}}\right)\right) \\
= & 1 / 8 * 2^{r}+\mathcal{O}\left(\sqrt{2^{r}}\right) .
\end{aligned}
$$

where $(x, y, z)_{j}=\left(-\Theta_{1}\left(t * 2^{k}\right), d_{2}(t, j), d_{3}(t, j)\right)$ for $j \in\{1,2,3,4\}$ and we have used (11).

The argument in the following theorem comes from theorem 2.3 in the paper by Hajdu and Papp.

Theorem 5.4. $\bar{S}(n)=1 / 8 * n+\mathcal{O}(\sqrt{n})$
Proof. We first note that (10) implies that for any $(x, y, z)$,

$$
\begin{align*}
\bar{S}_{(x, y, z)}\left(2^{k-2}, 2^{k-1}\right) & =1 / 8 * 2^{k-2}+\mathcal{O}\left(\sqrt{2^{k}}\right) \\
\bar{S}_{(x, y, z)}\left(2^{k-1}, 3 * 2^{k-2}\right) & =1 / 8 * 2^{k-2}+\mathcal{O}\left(\sqrt{2^{k}}\right)  \tag{13}\\
\bar{S}_{(x, y, z)}\left(3 * 2^{k-2}, 2^{k}\right) & =1 / 8 * 2^{k-2}+\mathcal{O}\left(\sqrt{2^{k}}\right) .
\end{align*}
$$

Let $n$ be an integer with binary representation $n=\sum_{1}^{j} 2^{f_{i}}$, where $f_{1}>\cdots>f_{j} \geq 0$. Then,

$$
\bar{S}(n)=\bar{S}\left(2^{f_{1}}\right)+\bar{S}\left(2^{f_{1}}, 2^{f_{1}}+2^{f_{2}}\right)+\cdots+\bar{S}\left(2^{f_{1}}+\cdots+2^{f_{j-1}}, 2^{f_{1}}+\cdots+2^{f_{j}}\right)
$$

Any of the terms above can be written as

$$
\bar{S}\left(2^{f_{1}}+\cdots+2^{f_{l-1}}, 2^{f_{1}}+\cdots+2^{f_{j}}\right)=\bar{S}\left(t * 2^{f_{l}}, t * 2^{f_{l}}+2^{f_{l+1}}\right)
$$

where $t<2^{f_{l}}$ is odd. Since,

$$
\bar{S}\left(t * 2^{f_{l}}, t * 2^{f_{l}}+2^{f_{l+1}}\right)=1 / 8 * 2^{f_{l+1}}+\mathcal{O}\left(\sqrt{2}^{f_{l}+1}\right)
$$

by lemma 5.3 , we have

$$
\begin{aligned}
\bar{S}(n) & =\sum_{l=1}^{j} 1 / 8 * 2^{f_{l}}+\mathcal{O}\left(\sqrt{2}^{f_{l}}\right) \\
& =1 / 8 * n+\mathcal{O}\left(\left(\sqrt{2}^{f_{1}+1}-1\right) /(\sqrt{2}-1)\right) \\
& =1 / 8 * n+\mathcal{O}\left(\sqrt{2}^{f_{1}}\right)
\end{aligned}
$$

Since $f_{1} \leq \log _{2}(n)$ we have

$$
\bar{S}(n)=1 / 8 * n+\mathcal{O}(\sqrt{n}) .
$$
