Scattering for the Equivariant U(1) Problem

Abstract

Extending our previous works on the Cauchy problem for the 2+1 equivariant Einstein-wave map system, we prove that the linear part dominates the nonlinear part of the wave maps equation coupled to the full set of the Einstein equations, for small data. A key ingredient in the proof is a nonlinear Morawetz estimate for the fully coupled equivariant Einstein-wave maps. The 2 + 1 dimensional Einstein-wave map system occurs naturally in the 3 + 1 vacuum Einstein equations of general relativity.

Keywords. Critical Wave Maps, U(1) Einstein equations

1 2+1 Equivariant Einstein-Wave Map System

The aim of this work is to complete the task undertaken in [8], on the scattering of the Cauchy problem of 2 + 1 equivariant wave maps coupled to Einstein's equations for general relativity. Let (M, g) be a 2+1 dimensional, globally hyperbolic, regular, Lorentzian spacetime what is foliated by 2 dimensional Riemannian hypersurfaces (Σ, q) such that the group SO(2) acts through isometries with a nonempty fixed point set Γ . The fixed point set Γ forms a timelike boundary of the quotient M/SO(2). In this setting, suppose (M, g) can be represented in double null coordinates (ξ, η, θ) as

$$g = -e^{2Z}d\xi d\eta + r^2 d\theta^2 \tag{1.1}$$

where $Z = Z(\xi, \eta)$ and $r = r(\xi, \eta)$ are functions only of $(\xi, \eta), \theta \in [0, 2\pi)$ is the parameter corresponding to SO(2) action on $(\Sigma, q), r(\xi, \eta) \in [0, \infty)$ is the radius of the area of group orbits of SO(2) so that the curve $\{r = 0\}$ corresponds to the points on Γ . ξ and η are the outgoing and incoming null coordinates respectively, such that

$$\xi = \eta, \quad \partial_{\xi}r + \frac{1}{2} = 0, \quad \partial_{\eta}r - \frac{1}{2} = 0, \quad \text{on} \quad \Gamma.$$

Now consider the 2+1 dimensional equivariant Einstein-wave map system

where **E** is the Einstein tensor of (M, g)

$$\mathbf{E} := R_{\mu\nu} - \frac{1}{2}g_{\mu\nu}R_g,$$

with the Ricci tensor \mathbf{R} and the scalar curvature R_g respectively.

$$U: (M,g) \to (N,h)$$

is an equivariant wave map, where the target (N, h) is a surface of revolution such that

$$f(0) = 0$$
, $f'(0) = 1$ and $\int_0^u f(s)ds \to \infty$ as $u \to \infty$ (1.4)

with the odd and smooth generating function f. The equivariant ansatz $U = (u, k\theta)$, where u is independent of the angular variable θ , reduces the wave maps equation

$$\Box_g U^i + {}^{(h)}\Gamma^i_{jk}(U)g^{\mu\nu}\partial_{\mu}U^j\partial_{\nu}U^k = 0$$

to

as it is well known. The wave maps equation has an associated energy-momentum tensor given by

$$\mathbf{T}_{\mu\nu} := \langle \partial_{\mu}U, \partial_{\nu}U \rangle_{h(U)} - \frac{1}{2}g_{\mu\nu} \langle \partial^{\sigma}U, \partial_{\sigma}U \rangle_{h(U)}.$$

In the double null coordinate system introduced above, the Ricci tensor \mathbf{R} of (M,g) is

we have the Einstein tensor and energy-momentum tensor as

Furthermore,

The components of $\mathbf{T}_{\mu\nu}$ are

$$\begin{aligned} \mathbf{T}_{\xi\xi} &= \partial_{\xi} u \, \partial_{\xi} u, \\ \mathbf{T}_{\eta\eta} &= \partial_{\eta} u \, \partial_{\eta} u, \\ \mathbf{T}_{\xi\eta} &= \frac{e^{2Z}}{4} \frac{f^2(u)}{r^2}, \\ \mathbf{T}_{\theta\theta} &= \frac{r^2}{2} e^{-2Z} \left(4 \partial_{\eta} u \partial_{\xi} u + e^{2Z} \frac{f^2(u)}{r^2} \right). \end{aligned}$$

Suppose we introduce coordinates

we can construct the 'retarded time' coordinates (η,R,θ) such that the metric g of M can be expressed as

Let us now calculate the relevant quantities in the retarded-time coordinates:

Consequently, the Einstein tensor E is given by

The energy-momentum tensor \mathbf{T} is given by

= $-e^{2Z} (\partial_{\eta} u)^{2} - 2e^{-2Z} \partial_{\eta} u \partial_{R} u + \frac{f^{2}(u)}{r^{2}}$ (1.11)

$$\mathbf{T}_{\eta\eta} = \frac{1}{2} \left((\partial_{\eta} u)^2 - 2\partial_{\eta} u \partial_R u + e^{2Z} \frac{f^2(u)}{r^2} \right), \qquad (1.12a)$$

$$\mathbf{T}_{\eta R} = \frac{1}{2} \left(-(\partial_{\eta} u)^2 + \frac{f^2(u)}{r^2} \right), \qquad (1.12b)$$

If we introduce a time coordinate function $T := \eta + R$, we can represent the metric g also in terms of (T, R, θ) coordinates

The Ricci tensor in (T,R,θ) is

The scalar curvature is given by

$$R_g = -2r^{-1}e^{-2Z} \left(r(-\partial_T^2 Z + \partial_R^2 Z) + (-\partial_T^2 r + \partial_R^2 r) \right)$$

The Einstein tensor

$$\mathbf{E}_{TT} = r^{-1} \left(\partial_R Z \partial_R r + \partial_R^2 r - \partial_T Z \partial_T r \right), \qquad (1.19)$$

Initial Value Problem

We shall set up the initial value problem at a T = 0 Cauchy hypersurface (Σ_0, q_0) . The initial data of geometric part of the 2 + 1 Einstein-wave map system consists of a Riemannian 2-manifold (Σ, q) and a symmetric 2-tensor k_0 . The Einstein's equations for general relativity are an overdetermined system, thus to formulate an initial value problem the following constraint equations are imposed on (Σ_0, q_0, k_0)

where e and m are the energy and momentum densities respectively. It follows from a standard result that there exists a unique (upto an isometry) smooth, globally hyperbolic, future development (M, g, U) of the initial data (Σ) [4]. Subsequently, k is the second fundamental form of the embedding $\Sigma \hookrightarrow M$ and if \mathcal{N} is the unit normal of $\Sigma \hookrightarrow M$ the above system is

$$\mathbf{E}(\mathcal{N}, \mathcal{N}) = \mathbf{T}(\mathcal{N}, \mathcal{N}) \tag{1.30a}$$

$$\mathbf{m} = \mathcal{N}(U) \cdot \mathcal{S}(U) \tag{1.31b}$$

with $\mathcal{N} := e^{-Z} \partial_T$ and $\mathcal{S} := e^{-Z} \partial_R$.

The initial data of the wave maps equation are

$$U_0: (\Sigma, q) \to (N, h) \tag{1.32a}$$

$$U_1 : (\Sigma, q) \to T_{U_0}(N, h) \tag{1.32b}$$

Therefore the 5-tuple (Σ, q, K, U_0, U_1) that satisfies the constraint equations constitutes the initial data of the Einstein-wave map system. For our convenience, we introduce the following quantities on the initial Cauchy surface

$$u|_{\Sigma_0} = u_0, \quad \partial_T u|_{\Sigma_0} = u_1,$$

with $r_1|_{\Gamma} = 0$ and $\partial_R r_0|_{\Gamma} = 1$.

Remark 1.1. Define a function v such that u = Rv, then the following results hold

1. v satisfies the 4+1 wave equation:

2. If we define $E_0 := \int_{\Sigma_0} \mathbf{T}(\mathcal{N}, \mathcal{N}) \, \bar{\mu}_q = \int_{\Sigma_0} \mathbf{e} \, \bar{\mu}_q$, the energy of v satisfies the estimate

$$E_0 \ge \|u_0\|_{\dot{H}^1(\mathbb{R}^2)}^2 + \|u_1\|_{L^2(\mathbb{R}^2)}^2$$
(1.36)

$$\geq \|v_0\|_{\dot{H}^1(\mathbb{R}^4)}^2 + \|v_1\|_{L^2(\mathbb{R}^4)}^2.$$

The results follow from the Hardy's inequality and assumptions on the target manifold (see [8]).

In the following, we shall define the notion of asymptotic flatness of the 2metric (Σ, q)

Definition 1.2 (Asymptotic flatness and AV-mass). Suppose (Σ, q, k) is a Riemannian 2-metric, then it is called asymptotically flat if

- 1. for some compact set Ω , \exists a global diffeomorphism $\Sigma \setminus \Omega \to \mathbb{R}^2 \setminus \mathbb{B}_1(0)$
- 2. The (Σ, q, k) admits the asymptotic expansion

$$q = \rho^{-m_{AV}}(\delta_{ab} + \mathcal{O}(\rho^{-1}))$$

$$k = \mathcal{O}(\rho^{-2}), \quad tr(k) = \mathcal{O}(\rho^{m_{AV}-3})$$

and the energy momentum tensor

$$\mathbf{T}_{\mu\nu} = \mathcal{O}(\rho^{m_{AV}-3}) \tag{1.38}$$

in the asymptotic region, where δ_{ab} is the Euclidean metric and $\rho = |x|$. We define the quantity m_{AV} as the Ashtekar-Varadarajan mass of the Cauchy hypersurface (Σ, q, k) [3].

Recall the form of the 2-metric

then a calculation shows that m_{AV} is given by

Furthermore, let us define the mass aspect function, that is closely related to the Hawking mass in 3+1 dimensional spacetimes

Review of Known Results

To put our results into context let first us review the results for the 2+1 equivariant Einstein-wave map system and the the literature on critical wave maps shall be discussed later. For the initial data described in the previous section, we have the following global existence result from [1], which also holds without the smallness restriction of the initial data in view of a non-concentration of energy argument [10].

Theorem 1.3 (Global regularity of equivariant Einstein-wave maps). Let $E_0 < \epsilon^2$ for ϵ sufficiently small and let (M, g, u) be the maximal Cauchy development of an asymptotically flat, compactly supported, regular Cauchy data set for the 2+1 equivariant Einstein-wave map problem (1.3) with target (N, h) satisfying

$$\int_0^s f(s')ds' \to \infty \quad for \quad s \to \infty.$$

Then (M, g, u) is regular and causally geodesically complete.

The results in [11, 1, 8] and the current work are part of the larger program to understand the global behaviour of the 3 + 1 Einstein equations with one translational U(1) symmetry. In global existence proof of [1], it was proved that, in future development of the initial data of the 2+1 equivariant Einstein-wave map system, the trapped surfaces cannot form. In particular, it was proved that

Theorem 1.4 (No trapped surfaces; Theorem 3.1 in [1]). Suppose (M, g, U) is the regular, globally hyperbolic maximal development of the 2+1 equivariant Einstein-wave map system, define $Q := M \setminus U(1)$ and

$$\mathcal{R} := \{ p \in \mathcal{Q} \quad \text{such that} \quad \partial_{\xi} r > 0, \partial_{\eta} r < 0 \}$$

then,

where m_{∞} is the spatial asymptotic limit of m on (Σ, q, k) .

Consider the system of coupled nonlinear wave equations occurring in the 2+1 Einstein-equivariant wave map system:

$$-\partial_T^2 Z + \partial_R^2 Z = -e^{2Z} \frac{f^2(u)}{8r^2} - \frac{1}{8} \left(-(\partial_T u)^2 + (\partial_R u)^2 \right)$$

In a previous work, we have established scattering for the following partially coupled Einstein-wave map equations, classified as Problems I and II below.

Problem I

Consider a function v such that

Problem II

Suppose the function v is such that

and v is coupled to Einstein's equations (1.3) with u = Rv. We were able to prove scattering for both Problems I and II:

Theorem 1.5 (Theorem 2.11 and Theorem 3.2 in [8]). Suppose v is a global solution of the partially linearized wave maps equations (1.47) or (1.48), with the energy $E_0 < \epsilon^2$, then v scatters forward and backward in time

The coupling of the wave maps equation with the Einstein's equations introduces nonlocality into the problem, which causes significant difficulties in closing the estimates at critical regularity. It may be noted that the equations in Problem I and II are partially linearized approximations of the equation (1.46c), where they correspond to the linearization of the equation (1.46b) and equation (1.46a) respectively, which in turn correspond to partial decoupling of the wave maps equation (1.46c). The methods employed in the wave maps equation are based on a optimal control of the Morawetz and Strichartz estimates that allow us to control the bootrap estimates at critical regularity. The nonlinear terms in the wave map equations in Problem I and II involve all the terms of the fully coupled wave maps equation, but in view of the nonlinear theory the equivalent results carry forward. In this work we are able to prove scattering for the fully coupled wave maps equation:

Theorem 1.6. Suppose $E_0 < \epsilon^2$, for ϵ sufficiently small and (M, g, U) is a global solution of the 2+1 equivariant Einstein-wave map system, then v scatters backward and forward in time in the energy topology

In the proof of the above scattering theorem, we use the following nonlinear Morawetz estimate:

Theorem 1.7 (Nonlinear Morawetz estimate). Suppose (M, g, U) is a globally

regular solution of the 2+1 Einstein-equivariant wave map system, then

Subsequently, using the scattering result for v, we obtain scattering for the fully coupled equivarant wave maps:

Theorem 1.8 (Temporal Scattering). Let $E_0 < \epsilon^2$ for ϵ sufficiently small and let (M, g, u) be the maximal geodesically complete Cauchy development of an asymptotically flat, compactly supported, regular Cauchy data set for the 2 + 1 equivariant Einstein-wave map problem (1.3) with target (N, h) satisfying

Then the maximal development (M, g, U) is such that U converges to a linearized system of (1.3b) as $T \to \infty$ along future pointing the timelike curves.

We would like to point out that, both conceptually and technically, the wave map fields (and their conjugate momenta) is the dominant field that represents the true dynamical degrees of freedom of the 2 + 1 dimensional Einstein-wave map system.

The key ingredient in the proof is the non-linear Morawetz estimate (1.52) for the fully coupled Einstein-wave map system. An analogous result holds for the partially coupled equivariant Einstein-wave system (1.48) (Problem II), but (1.52) now holds for the fully coupled system. Likewise, a similar result holds for scattering backwards in time. It may be noted that a canonical notion of energy for the Einstein equations is defined relative to a chosen reference background. However, in view of the Remark 1.1, in this work use we use a weaker notion of mass-energy that nevertheless gives scattering and sharp asymptotics relative to the same reference background.

In view of the fact that the Jacobians of the transition functions between the (T, R, θ) , double-null and retarded-time coordinates are constants, the scattering result of Theorem 1.8 can be adapted to establish equivalent results along the $\eta = const$ in the asymptotic region.

Corollary 1.9. Suppose (M, g, U) is the regular, globally hyperbolic, causally geodesically complete maximal development of the asymptotically flat initial data (Σ, q, k, U) with u compactly supported, then u admits the decay rate

$$|u| \le c(1+\xi)^{-1/2}(1+\eta)^{-1/2} \tag{1.55}$$

in the temporal asymptotic region $(T \to \infty)$ and

as $R \to \infty$ in the $\eta = const.$ hypersurfaces.

Let us now discuss a few salient points about the 2+1 dimensional equivariant Einstein-wave map system.

Metric functions

The wave map U and its conjugate momentum form the dynamical degrees of freedom of the system and drive the dynamics of the whole system. However, in our quest to understand the asymptotic geometry of the maximal future development (M, g, U) of the system, the form of the Einstein tensor poses obstacles. For instance, consider the equation

$$\begin{cases} {}^{1+1}\Box w = e^x & \text{on } \mathbb{R}^{1+1} \\ w(0,x) = 0 & \text{and} & \partial_T w(0,x) = 0 & \text{on } \mathbb{R} \end{cases}$$
 (1.57)

The energy of w in the equation (1.57) goes out of control asymptotically as $T \to \infty$ even though we start with 'small' initial data. Thus we are motivated to analyze the asymptotic behaviour separately for metric functions to rule out such behaviour. As per our analysis, we expect that, as the maximal development (M, g, U) attains its scattaring state near temporal infinity, it converges to the Minkowski space. In other words, as the maximal development attains its

scattaring state near temporal infinity, the geometric mass (Ashtekar-Varadarajan) converges to zero. This topic, with the together the behaviour of the curvature, merits a dedicated discussion and shall be addressed in a separate work.

Sharp Asymptotics

We would like to remark that the scattering methods have an advantage in the characterization of the asymptotic geometry of the initial value problem of the system as the decay rate so obtained is sharp compared to the energy methods in 2+1 dimensions:

1. The asymptotic decay rate obtained is sharp

$$|u| \le c(1+\xi)^{-1/2}(1+\eta)^{-1/2}$$
 in \mathbb{R}^{2+1} , (1.58)

in view of the fact that the geometric mass and spatial asymptotics are conserved globally, including the region where the system (M, g, U) attains its scattering state.

The small data problem and the target

We would also like to remark that our scattering result reaffirms the intuition the curvature of the target manifold (N, h) does not play a decisive role in the scattering in the small data context.

In the above, we mentioned several results for the 2+1 equivariant Einsteinwave system which hold in the asymptotic limits. In the context of Einstein's equations, an important aim of the initial value formulation is the characterization of the asymptotic geometry of the future development of the system. In a classic 1964 work, Penrose had formulated a notion of conformal infinity in the context of Einstein's equations for general relativity. From a PDE perspective, the work of Penrose gave a crucial answer for the question of what it means for solutions of the Einstein equations to exist 'globally'. Following the definition of Penrose, the conformal infinity of in our context is defined as follows:

Definition 1.10. A 2+1 Lorentzian manifold (M, g) is admits a conformal null infinity if $\exists a 2+1$ Lorentzian manifold $(\mathcal{M}, \mathbf{g})$ with boundary \mathscr{I} such that

- $\exists a \ diffeomorphism \ \mathcal{M} \setminus \mathscr{I} \to M$
- \exists a smooth function Ω on $(\mathcal{M}, \mathbf{g}), \mathbf{g} = \Omega^2 g$ in the interior of \mathcal{M} such that $\Omega = 0$ on \mathscr{I} and $\nabla_{\nu} \Omega \neq 0$ at \mathscr{I}

Minkowski Spacetime \mathbb{R}^{2+1}

In our problem, the Minkowski spacetime \mathbb{R}^{2+1} plays an important role as an example of a spacetime that admits a conformal completion. Consider the Minkowski metric

$$ds^2 = -d\eta^2 - d\eta dR + R^2 d\theta^2 \tag{1.59}$$

in the retarded-time coordinates (η, R, θ) . Suppose we introduce the function $\rho = \frac{1}{r}$ and define the unphysical metric with $\Omega = \rho$ then \mathbb{R}^{2+1} admits a conformal infinity at $\rho = 0$. In this work we shall be interested in the geometry and behaviour of fields near the future null infinity, so this choice of the conformal factor to construct null infinity suffices. Likewise, the 4+1 dimensional Minkowski space admits a conformal null infinity similarly.

Wave maps from \mathbb{R}^{2+1} with symmetry have been studied in a series of landmark papers of Christodoulou-Tahvildar-Zadeh and Shatah [7, 6, 18, 17], where global regularity and asymptotics of initial value problems of equivariant and spherically symmetric wave maps were studied (see also[9]).

In [12] the Einstein-scalar wave system without symmetry was studied and stability of Minkowski space in exponential time (\sqrt{t}^{-1}) was established. The techniques in [12] were inspired from [16] which provided a simpler proof of the seminal and classic work on stability of Minkowski space [5]. The asymptotic behaviour of perturbations of the 3+1 Minkowski space in harmonic coordinates is studied in [15].

In a pioneering and influential series of works [21], global behaviour of wave maps in multiple dimensions and regularity levels has been studied. Local and global well-posedness of wave maps at various regularity levels are studied in [23, 22, 24]. Global regularity for small data for critical wave maps $U : \mathbb{R}^{2+1} \rightarrow$

16

 \mathbb{H}^2 was proved in [13]. In a voluminous work [14], the important question of concentration compactness for wave maps $U : \mathbb{R}^{2+1} \to \mathbb{H}^2$ was thoroughly settled. Likewise, scattering for large data for critical wave maps with more general targets was settled in [19][20].

Notation

A wave operator $^{n+1}\square$ without a metric subscript refers to a flat-space wave operator in n + 1 dimensions. We shall use the Einstein summation convention throughout.

2 Asymptotics of a partially linearized Equivariant wave map system

As we already remarked, in a previous work we have proved the scattering for the following problem

Remark 2.2 (Mass loss). Suppose u, $\partial_R u$ and $\partial_\eta u$ admit the asymptotic expansions as in Proposition 2.1, and $Z(\eta, R)$ is a globally regular solution with $|e^{2Z} - 1| \le c(E_0)$ then we have the following mass loss formula

In the case of the fully coupled 2+1 equivariant Einstein-wave map system we shall prove the scattering of the system, but the quantitative aspects asymptotic geometry are encoded in the rate at which the maximal development (M, g, U) of the system converges to its scattering state. A characterization of this rate and its close connection with the asymptotics of the Weyl tensor of the original 3 + 1 metric shall be the subject of a subsequent article.

3 Scattering for 2+1 Equivariant Einstein Wave Map System

Recall the 2+1 dimensional equivarant Einstein-wave system:

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\eta} r + \frac{1}{2}) \partial_{\xi} v \partial_T \bar{v} \bar{\mu}_{\check{g}} \text{ and } \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\xi} r - \frac{1}{2}) \partial_{\eta} v \partial_T \bar{v} \bar{\mu}_{\check{g}} :$$

we have

$$\int_{T_0} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_\eta r + \frac{1}{2}) \partial_\xi v \partial_T \bar{v} R^3 dR dT$$
(3.148)

$$= \int_{T_0} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_\eta r + \frac{1}{2}) \partial_\xi v \partial_T \bar{v} R^3 d\xi \eta$$
(3.149)

$$\leq \int_{\eta_0} (\sup_{R>0} \frac{1}{R} \int_0^R f^2(v) s ds) (\int (dv)^2 d\xi) d\eta$$
(3.150)

going back to (T, R, θ)

$$\leq E(v) \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}}$$
(3.151)

analogously, we have

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\xi} r - \frac{1}{2}) (\partial_{\eta} v) (\partial_T v) \bar{\mu}_{\check{g}} \le E(v) \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}} \qquad (3.152)$$

2. Next, the terms

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} (\partial_{\eta} r + \frac{1}{2}) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} \text{ and } \int_{T_0}^{\infty} \int_{\mathbb{R}^4} (\partial_{\xi} r - \frac{1}{2}) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}}$$

using Cauchy-Schwarz

$$\int_{T_{0}}^{\infty} \int_{\mathbb{R}^{4}} (\partial_{\eta}r + \frac{1}{2}) \frac{v}{R^{2}} \partial_{T} \bar{v} \bar{\mu}_{\check{g}} \\
\leq \int_{T_{0}}^{\infty} \int_{\mathbb{R}^{4}} \frac{1}{R} (\partial_{\eta}r + \frac{1}{2}) (\partial_{T} \bar{v})^{2} \bar{\mu}_{\check{g}} + \int_{T_{0}}^{\infty} \int_{\mathbb{R}^{4}} \frac{1}{R^{3}} (\partial_{\eta}r + \frac{1}{2}) v^{2} \bar{\mu}_{\check{g}} \\
\leq E(v) \int_{T_{0}}^{\infty} \int_{\mathbb{R}^{4}} \frac{v^{2}}{R^{3}} \bar{\mu}_{\check{g}} + \epsilon \int_{T_{0}}^{\infty} \int_{\mathbb{R}^{4}} \frac{v^{2}}{R^{3}} \bar{\mu}_{\check{g}} \tag{3.153}$$

likewise, we have

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} (\partial_{\xi} r - \frac{1}{2}) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} \le E(v) \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}} + \epsilon \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}}$$

3. Controlling the term

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} (e^{2Z} - 1) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}}$$
(3.154)

is similar,

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} (e^{2Z} - 1) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} \leq \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (e^{2Z} - 1) \bar{\mu}_{\check{g}} + \int_{T_0}^{\infty} \int_{\mathbb{R}^4} (e^{2Z} - 1) \frac{v^2}{R^3} \bar{\mu}_{\check{g}}$$
$$\leq E(v) \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}} + \epsilon \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}}.$$
(3.155)

In view of the fact that

$$\lim_{T \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{v^2}{R^3} \bar{\mu}_{\check{g}} = 0$$

we now have

$$\lim_{T_0 \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\eta} r + \frac{1}{2}) \partial_{\xi} v \partial_T \bar{v} \bar{\mu}_{\check{g}} = 0$$
(3.156a)

$$\lim_{T_0 \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\xi} r - \frac{1}{2}) \partial_{\eta} v \partial_T \bar{v} \bar{\mu}_{\check{g}} = 0$$
(3.156b)

$$\lim_{T_0 \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_\eta r + \frac{1}{2}) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} = 0$$
(3.156c)

$$\lim_{T_0 \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{1}{R} (\partial_{\xi} r - \frac{1}{2}) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} = 0$$
(3.156d)

$$\lim_{T_0 \to \infty} \int_{T_0}^{\infty} \int_{\mathbb{R}^4} (e^{2Z} - 1) \frac{v}{R^2} \partial_T \bar{v} \bar{\mu}_{\check{g}} = 0$$
(3.156e)

from the dominated convergence theorem.

4. Now consider the term

$$\int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{R^2}{r^2} e^{2Z} v^3 \zeta(Rv) \partial_T \bar{v} \bar{\mu}_{\check{g}}$$

again expand out $\zeta(R\tilde{v})$:

$$\zeta(Rv) = c_0 + c_1 Rv + c_2 (Rv)^2 + \cdots$$
(3.157)

Then the leading order term of

$$c_j \int_{T_0}^{\infty} \int_{\mathbb{R}^4} \frac{R^{2+j}}{r^2} e^{2Z} v^{3+j} \partial_T \bar{v} \bar{\mu}_{\check{g}}$$
(3.158)

transforms as

$$c_0 \int \frac{R^2}{r^2} \bar{v}^3 \bar{v}_T R^3 \bar{\mu}_{\check{g}} = \left(-\frac{5c_0}{4} \int \frac{R^2}{r^2} \bar{v}^4 \bar{\mu}_{\check{g}} \right) - \frac{c_0}{2} \int \frac{R^2}{r^3} \bar{v}^4 (\partial_T r) \bar{\mu}_{\check{g}}$$
(3.159)

Now by the radial Sobolev embedding theorem, combined with the Morawetz estimates,

$$\int_{T \ge T_0} \int \frac{R^2}{r^3} \bar{v}^4(\partial_T r) \bar{\mu}_{\check{g}} \to 0$$
(3.160)

as $T_0 \rightarrow \infty$. Next, using the radial Strichartz estimate

$$\left\| |x|^{1/2} S(t)((v_S)_0, (v_S)_1) \right\|_{L^2_t L^\infty_x} \le \| (v_S)_0 \|_{\dot{H}^1} + \| (v_S)_1 \|_{L^2}, \qquad (3.161)$$

so

$$\int_{T \ge T_0} \int \frac{R^2}{r^2} v^2 v_S \bar{v}_T R^3 dR dT \le \left(\int_{T \ge T_0} \int v^2 dR dT \right)^{1/2} \cdot \|R^{1/2} v_S\|_{L^2_T L^\infty_x} \|\bar{v}_T\|_{L^\infty_T L^2_x} \|Rv\|_{L^\infty_{T,x}}.$$
(3.162)

If

$$E(\bar{v}(T)) = \|\bar{v}_T\|_{L^2}^2 + \|\nabla\bar{v}(T)\|_{L^2}^2 + \frac{1}{2}\|\bar{v}(T)\|_{L^4}^4, \qquad (3.163)$$

then the Sobolev embedding theorem implies that for small energy, the RHS of eq. 3.162

$$\leq (\sup_{T \ge T_0} E(\bar{v}(T)))^{1/2} E(v) \left(\int_{T \ge T_0} \int v^2 dR dT \right)^{1/2}.$$
 (3.164)

Also,

$$\int_{T \ge T_0} \int \frac{R^2}{r^2} v \cdot v_S \cdot \bar{v} \bar{v}_T R^3 dR dT \le \left(\int_{T \ge T_0} \int v^2 dR dT \right)^{1/2} \\ \cdot \|R^{1/2} v_S\|_{L^2_T L^\infty_x} \|\bar{v}_T\|_{L^\infty_T L^2_x} \|R \bar{v}\|_{L^\infty_{T,x}} \\ \le E(v) \left(\sup_{T \ge T_0} E(\bar{v}(T)) \right).$$
(3.165)

Finally,

$$\int_{T \ge T_0} \int \frac{R^2}{r^2} v_S \bar{v}^2 \bar{v}_T R^3 dR dT \le \left\| |x|^{1/2} v_S \right\|_{L^2_T L^\infty_x} \|v_T\|_{L^\infty_T L^2_x}
\cdot \left(\int v + (v_S)^2 dR dT \right)^{1/2} \||x|\bar{v}\|_{L^\infty_{T,x}}
\le E(v) \left(\sup_{T \ge T_0} E(\bar{v})(T) \right).$$
(3.166)

Now consider,

$$c_j \int_{T_0} \int_{\mathbb{R}^4} \frac{R^{2+j}}{r^2} Z(R,T) v^{3+j} \partial_T \bar{v} \bar{\mu}_{\check{g}}$$
(3.167)

Analogously, we have

$$c_{j} \int_{T_{0}} \int_{\mathbb{R}^{4}} \frac{R^{2+j}}{r^{2}} Z(R,T) v^{3+j} \partial_{T} \bar{v} \bar{\mu}_{\check{g}} \le c(E_{0}) \int v^{2} dR dT \qquad (3.168)$$

We would now like to remark on the decay rates for our scattering problem in comparison with the decay rates for the linear wave equation.

Remark 3.5. Suppose $u : \mathbb{R}^{2+1} \to \mathbb{R}$ satisfies the linear wave equation

$$\begin{array}{rcl} & 2^{+1} \Box \, v &= 0 & \text{on } \mathbb{R}^{2+1} \\ u_0 = u(0,x) & \text{and} & u_1 = \partial_T u(0,x) & \text{on } \mathbb{R}^2 \end{array} \right\}$$
(3.169)

such that the smooth initial data (u_0, u_1) is compactly supported or sufficiently rapidly decaying, then u admits the decay rate:

$$|u| \le (1+\xi)^{-1/2} (1+\eta)^{-1/2}.$$
(3.170)

This decay rate has to be contrasted with the decay rate from the (standard) energy estimates:

$$||u|| \le (1+t)^{n-1/2} (1+|t-x|)^{1/2}.$$
(3.171)

In the following we shall prove that this decay rate is also also consistent with the decay rate for the fully coupled 2+1 equivariant Einstein-wave map system.

Corollary 3.6. Suppose (M, g, U) is the smooth, globally hyperbolic, geodesically complete maximal development of the smooth, asymptotically flat initial data $(\Sigma_0, q_0, k_0, U_0)$, with U_0 compactly supported, then u admits the decay rate

$$|u| \le (1+\xi)^{-1/2} (1+\eta)^{-1/2}$$
(3.172)

in the temporal asymptotic region $(T \rightarrow \infty)$ and

$$|u| \le \mathscr{O}(R^{-1/2}) \tag{3.173}$$

as $R \to \infty$ along the $\eta = const.$ hypersurfaces.

Proof. Now let us turn to the scattering for our problem, we have

$$\|v - v_S\| \to 0$$

this implies

$$||u - \bar{u}||_{L^{\infty}} \to 0, \quad T \to \infty, where \bar{u} = r\bar{v}.$$

Note that if \bar{v} satisfies $\Box v = 0$ then \bar{u} satisfies

$$\Box u_S - \frac{u_S}{R^2} = 0. (3.174)$$

Following [7], if we introduce the following 'projection' formulas

$$u_1 = u_S \cos \theta$$

$$u_2 = u_S \cos \theta$$
 (3.175)

so that $u = u_1 \cos \theta + u_2 \sin \theta$ and

$$^{2+1}\Box u_1 = 0, \quad \mathbb{R}^{2+1}$$
 (3.176)

$${}^{2+1}\Box u_2 = 0, \quad \mathbb{R}^{2+1} \tag{3.177}$$

If we turn to the 2+1 decay rates, we have

$$u_1 \le (1+\xi)^{-1/2} (1+\eta)^{-1/2}$$

$$u_2 \le (1+\xi)^{-1/2} (1+\eta)^{-1/2}$$
(3.178)

which is view of the previous equations gives

$$u_S \le (1+\xi)^{-1/2} (1+\eta)^{-1/2} \tag{3.179}$$
