# BOUNDARY POINTS, MINIMAL $L^{2}$ INTEGRALS AND CONCAVITY PROPERTY IV-FIBRATIONS OVER OPEN RIEMANN SURFACES

#### Abstract

In this article, we consider the minimal $L^{2}$ integrals related to modules at boundary points on fibrations over open Riemann surfaces, and present a characterization for the concavity property of the minimal $L^{2}$ integrals degenerating to linearity.


## 1. Introduction

The strong openness property of multiplier ideal sheaves [26] (conjectured by Demailly (9) is an important feature of multiplier ideal sheaves and has opened the door to new types of approximation technique (see e.g. [26, 34, 31, 4, 5, 16, 6. 45, [28, 46, 47, 17, 32, (7)), where the multiplier ideal sheaf $\mathcal{I}(\varphi)$ is the sheaf of germs of holomorphic functions $f$ such that $|f|^{2} e^{-\varphi}$ is locally integrable (see e.g. 42, 35, 37, 11, 12, 9, 13, 33, 38, 39, 10, 29), and $\varphi$ is a plurisubharmonic function on a complex manifold $M$ (see [8).

Guan-Zhou [26] proved the strong openness property (the 2-dimensional case was proved by Jonsson-Mustaţă (30). Using the strong openness property, Guan-Zhou [27] gave a proof of the following conjecture posed by Jonsson-Mustaţă (see 30]).

Conjecture J-M: If $c_{o}^{F}(\psi)<+\infty, \frac{1}{r^{2}} \mu\left(\left\{c_{o}^{F}(\psi) \psi-\log |F|<\log r\right\}\right)$ has a uniform positive lower bound independent of $r \in(0,1)$, where $\mu$ is the Lebesgue measure on $\mathbb{C}^{n}$, and $c_{o}^{F}(\psi):=\sup \left\{c \geq 0:|F|^{2} e^{-2 c \psi}\right.$ is $L^{1}$ on a neighborhood of $\left.o\right\}$ is the jumping number (see [30).

Recall that Jonsson-Mustaţă 30 posed Conjecture J-M, and proved the 2dimensional case, which deduced the 2-dimensional strong openness property. It is natural to ask: can one find a proof of Conjecture J-M independent of the strong openness property?

In [3], Bao-Guan-Yuan considered the minimal $L^{2}$ integrals related to modules at boundary points of the sublevel sets of plurisubharmonic functions on pseudoconvex domains, and established a concavity property of the minimal $L^{2}$ integrals, which deduced a proof of Conjecture J-M independent of the strong openness property. In [20, Guan-Mi-Yuan generalized the concavity property to weakly pseudoconvex Kähler manifolds.

Note that the linearity is a degenerate concavity. It is natural to ask:

[^0]Question 1.1. How to characterize the concavity property degenerating to linearity?

In [21, Guan-Mi-Yuan gave an answer to Question 1.1 for the case of open Riemann surfaces.

In this article, we give an answer to Question 1.1 for the case of fibrations over open Riemann surfaces.
1.1. Main result. Let $\Omega$ be an open Riemann surface, which admits a nontrivial Green function $G_{\Omega}$. Let $Y$ be an $n-1$ dimensional weakly pseudoconvex Kähler manifold, and let $K_{Y}$ be the canonical line bundle on $Y$. Let $M=\Omega \times Y$ be an $n$-dimensional complex manifold. Let $\pi_{1}$ and $\pi_{2}$ be the natural projections from $M$ to $\Omega$ and $Y$ respectively. Let $K_{M}$ be the canonical line bundle on $M$.

Let $\psi$ be a subharmonic function on $\Omega$. Let $\varphi_{\Omega}$ be a Lebesgue measurable function on $\Omega$ such that $\varphi_{\Omega}+\psi$ is subharmonic function on $\Omega$. Let $F$ be a holomorphic function on $\Omega$. Let $T \in[-\infty,+\infty)$. Denote that

\tilde{\Psi}:=\min \{\psi-2 \log |F|,-T\}
$$

For any $z \in \Omega$ satisfying $F(z)=0$, we set $\tilde{\Psi}(z)=-T$. Denote that $\Psi:=\pi_{1}^{*}(\tilde{\Psi})$ on $M$. Let $\varphi_{Y}$ be a plurisubharmonic function on $Y$. Denote that $\varphi:=\pi_{1}^{*}\left(\varphi_{\Omega}\right)+$ $\pi_{2}^{*}\left(\varphi_{Y}\right)$.

Let $p \in M$ be a point. Denote that $\tilde{J}(\Psi)_{p}:=\{f \in \mathcal{O}(\{\Psi<-t\} \cap V): t \in \mathbb{R}$ and $V$ is a neighborhood of $p\}$. We define an equivalence relation $\sim$ on $\tilde{J}(\Psi)_{p}$ as follows: for any $f, g \in \tilde{J}(\Psi)_{p}$, we call $f \backsim g$ if $f=g$ holds on $\{\Psi<-t\} \cap V$ for some $t \gg T$ and open neighborhood $V \ni p$. Denote $\tilde{J}(\Psi)_{p} / \backsim$ by $J(\Psi)_{p}$, and denote the equivalence class including $f \in \tilde{J}(\Psi)_{p}$ by $f_{p}$.

If $p \in \cap_{t>T}\{\Psi<-t\}$, then $J(\Psi)_{p}=\mathcal{O}_{M, p}$ (the stalk of the sheaf $\mathcal{O}_{M}$ at $p$ ), and $f_{p}$ is the $\operatorname{germ}(f, p)$ of holomorphic function $f$. If $p \notin \cap_{t>T} \overline{\{\Psi<-t\}}$, then $J(\Psi)_{p}$ is trivial.

Let $f_{p}, g_{p} \in J(\Psi)_{p}$ and $(h, p) \in \mathcal{O}_{M, p}$. We define $f_{p}+g_{p}:=(f+g)_{p}$ and $(h, p) \cdot f_{p}:=(h f)_{p}$. Note that $(f+g)_{p}$ and $(h f)_{p}\left(\in J(\Psi)_{p}\right)$ are independent of the choices of the representatives of $f, g$ and $h$. Hence $J(\Psi)_{p}$ is an $\mathcal{O}_{M, p}$-module.

For $f_{p} \in J(\Psi)_{p}$ and $a, b \geq 0$, we call $f_{p} \in I(a \Psi+b \varphi)_{p}$ if there exist $t \gg T$ and a neighborhood $V$ of $p$, such that $\int_{\{\Psi<-t\} \cap V}|f|^{2} e^{-a \Psi-b \varphi} d V_{M}<+\infty$, where $d V_{M}$ is a continuous volume form on $M$. Note that $I(a \Psi+b \varphi)_{p}$ is an $\mathcal{O}_{M, p^{-}}$-submodule of $J(\Psi)_{p}$.

Let $Z_{0} \subset M$ be a subset of $\cap_{t>T} \overline{\{\Psi<-t\}}$ such that there exists a subset $\tilde{Z}_{0}$ of $\Omega$ such that $Z_{0}=\tilde{Z}_{0} \times Y$. Denote that $\tilde{Z}_{1}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right) \geq 2 \operatorname{ord}_{z}(F)\right\}$ and $\tilde{Z}_{2}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right)<\operatorname{ord}_{z}(F)\right\}$, where $d^{c}=\frac{\partial-\bar{\partial}}{2 \pi \sqrt{-1}}$ and $v\left(d d^{c}(\psi), z\right)$ is the Lelong number of $d d^{c}(\psi)$ at $z$ (see [8]). Denote that $\tilde{Z}_{3}:=\left\{z \in \tilde{Z}_{0}\right.$ : $\left.v\left(d d^{c}(\psi), z\right)>2 \operatorname{ord}_{z}(F)\right\}$. Note that $\{\tilde{\Psi}<-t\} \cup \tilde{Z}_{3}$ is an open Riemann surface for any $t \geq T$. Denote $Z_{1}:=\tilde{Z}_{1} \times Y, Z_{2}:=\tilde{Z}_{2} \times Y$ and $Z_{3}:=\tilde{Z}_{3} \times Y$ respectively.

Let $c(t)$ be a positive function on $(T,+\infty)$ such that $c(t) e^{-t}$ is decreasing on $(T,+\infty), c(t) e^{-t}$ is integrable near $+\infty$, and $c(-\Psi) e^{-\varphi}$ has a positive lower bound on $K \cap\{\Psi<-T\}$ for any compact subset $K \subset M \backslash \pi_{1}^{-1}(E)$, where $E$ is an analytic subset of $\Omega$ such that $E \subset\{\tilde{\Psi}=-\infty\}$.

Let $f$ be a holomorphic $(n, 0)$ form on $\left\{\Psi<-t_{0}\right\} \cap V$, where $V \supset Z_{0}$ is an open subset of $M$ and $t_{0}>T$ is a real number. Denote

& \inf \left\{\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi): \tilde{f} \in H^{0}\left(\{\Psi<-t\}, \mathcal{O}\left(K_{M}\right)\right)\right.  \tag{1.1}\\
&\left.\&(\tilde{f}-f)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p} \text { for any } p \in Z_{0}\right\}
\end{align*}
$$

by $G(t ; c, \Psi, \varphi, I(\varphi+\Psi), f)$, where $t \in[T,+\infty)$ and $|f|^{2}:=(\sqrt{-1})^{n^{2}} f \wedge \bar{f}$ for any $(n, 0)$ form $f$. Without misunderstanding, we denote $G(t ; c, \Psi, \varphi, I(\varphi+\Psi), f)$ by $G(t)$ for simplicity.

Recall that $G\left(h^{-1}(r)\right)$ is concave with respect to $r$ (see 21, see also Theorem (2.12), where $h(t)=\int_{t}^{+\infty} c(s) e^{-s} d s$ for any $t \geq T$. In this article, we give a characterization of the concavity degenerating to linearity.

Assume that $\tilde{Z}_{3}$ is finite, and denote that $\tilde{Z}_{3}=\left\{z_{1}, z_{2}, \ldots, z_{m}\right\}$. Let $w_{j}$ be a local coordinate on a neighborhood $V_{z_{j}} \Subset \Omega$ of $z_{j}$ satisfying $w_{j}\left(z_{j}\right)=0$ for any $j \in\{1,2, \ldots, m\}$, where $V_{z_{j}} \cap V_{z_{k}}=\emptyset$ for any $j \neq k$. We give an answer to Question 1.1 for the case of fibrations over open Riemann surfaces as follows.

Theorem 1.2. For any $z \in \tilde{Z}_{1}$, assume that one of the following conditions holds:
(A) $\varphi_{\Omega}+a \psi$ is subharmonic near $z$ for some $a \in[0,1)$;
(B) $\left(\psi-2 q_{z} \log |w|\right)(z)>-\infty$, where $q_{z}=\frac{1}{2} v\left(d d^{c}(\psi), z\right)$ and $w$ is a local coordinate on a neighborhood of $z$ satisfying that $w(z)=0$.

If there exists $t_{1} \geq T$ such that $G\left(t_{1}\right) \in(0,+\infty)$, then $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{T}^{+\infty} c(s) e^{-s} d s\right)$ if and only if the following statements hold:
(1) $f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $\left(V_{z_{j}} \times Y\right) \cap\left\{\Psi<-t_{0}\right\} \cap V$ for any $j \in$ $\{1,2, \ldots, m\}$, where $a_{j} \in \mathbb{C} \backslash\{0\}, k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic ( $n-1,0$ ) form on $Y$ satisfying $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j}\right)_{p} \in \mathcal{O}\left(K_{\Omega}\right)_{p} \otimes$ $I(\varphi+\Psi)_{p}$ for any $p \in z_{j} \times Y$;
(2) $\varphi_{\Omega}+\psi=2 \log |g|+2 \log |F|$, where $g$ is a holomorphic function on $\{\tilde{\Psi}<$ $-T\} \cup \tilde{Z}_{3} \subset \Omega$ such that $\operatorname{ord}_{z_{j}}(g)=k_{j}+1$ for any $j \in\{1,2, \ldots, m\}$;
(3) $\tilde{Z}_{3} \neq \emptyset$ and $\psi=2 \sum_{1 \leq j \leq m}\left(q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)\right) G_{\Omega_{t}}\left(\cdot, z_{j}\right)+2 \log |F|-t$ on $\Omega_{t}$ for any $j \in\{1,2, \ldots, m\}$, where $\Omega_{t}=\{\tilde{\Psi}<-t\} \cup \tilde{Z}_{3} \subset \Omega$ and $G_{\Omega_{t}}$ is the Green function on $\Omega_{t}$;
(4) $\frac{q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)}{\operatorname{ord}_{z_{j}}(g)} \lim _{z \rightarrow z_{j}} \frac{d g}{a_{j} w_{j}^{k_{j}} d w_{j}}=c_{0}$ for any $j \in\{1,2, \ldots, m\}$, where $c_{0} \in$ $\mathbb{C} \backslash\{0\}$ is a constant independent of $j$.

When $F \equiv 1, \psi(z)=-\infty$ for any $z \in \tilde{Z}_{0}=\tilde{Z}_{3}$ and condition $(B)$ holds, Theorem 1.2 can be referred to [1] (see also Theorem 2.30 and Remark 2.31).

When $\tilde{Z}_{3}$ is an infinite analytic subset of $\Omega$, Proposition 3.2 gives a necessary condition of $G\left(h^{-1}(r)\right)$ is linear.

## 2. Preparations

2.1. Properties of products of Bergman spaces. In this section, we recall some results of products of Bergman spaces.

Let $U \subset \mathbb{C}^{n}$ and $W \subset \mathbb{C}^{m}$ be two open sets. Let $\varphi_{1}$ and $\varphi_{2}$ be two Lebesgue measurable functions on $U$ and $W$ respectively. Let $d \lambda_{U}$ and $d \lambda_{W}$ be the Lebesgue
measures on $U$ and $W$ respectively. Denote

\begin{aligned}
A^{2}\left(U ; e^{-\varphi_{1}}\right) & :=\left\{f \in \mathcal{O}_{U}: \int_{U}|f|^{2} e^{-\varphi_{1}} d \lambda_{U}<+\infty\right\} \\
A^{2}\left(W ; e^{-\varphi_{2}}\right) & :=\left\{g \in \mathcal{O}_{W}: \int_{W}|g|^{2} e^{-\varphi_{2}} d \lambda_{W}<+\infty\right\}
\end{aligned}
$$

Denote $\|f\|_{1}:=\left(\int_{U}|f|^{2} e^{-\varphi_{1}} d \lambda_{U}\right)^{\frac{1}{2}}$ for any $f \in A^{2}\left(U ; e^{-\varphi_{1}}\right)$ and $\|g\|_{2}:=\left(\int_{W}|g|^{2} e^{-\varphi_{2}} d \lambda_{W}\right)^{\frac{1}{2}}$ for any $g \in A^{2}\left(W ; e^{-\varphi_{2}}\right)$. Let $M:=U \times W$ and $\varphi:=\varphi_{1}+\varphi_{2}$. Denote

$$
A^{2}\left(M ; e^{-\varphi}\right):=\left\{h \in \mathcal{O}_{M}: \int_{M}|h|^{2} e^{-\varphi} d \lambda_{M}<+\infty\right\}
$$

and $\|h\|:=\left(\int_{M}|h|^{2} e^{-\varphi} d \lambda_{M}\right)^{\frac{1}{2}}$ for any $h \in A^{2}\left(M ; e^{-\varphi}\right)$.
We firstly recall the following lemma.
Lemma 2.1 (see [44). Let $\mu$ be a real positive Lebesgue measurable function on open subset $D_{1} \subset \mathbb{C}^{n}$. Assume that there exists a number $a>0$ such that the function $\mu^{-a}$ is integrable on some open set $D \subset D_{1}$ with respect to Lebesgue measure $d \lambda$. Let $f$ be a holomorphic function on $D$. Assume that $\|f\|_{\mu}<+\infty$, where $\|f\|_{\mu}:=\left(\int_{D}|f|^{2} \mu d \lambda\right)^{\frac{1}{2}}$. Then for any compact set $K \subset D$, there exists $a$ constant $C_{K}>0$ such that

\sup _{K}|f(z)| \leq C_{K}| | f \|_{\mu}
$$

Proof. The following proof can be referred to 44. Let $K$ be a compact subset of $D$. There exists a real number $r>0$ (depends on $K$ ) such that $B(z, r) \subset D$ for any $z \in K$. Let $p:=\frac{1+a}{a}$ and $q=1+a$. Note that $|f|^{\frac{2}{p}}$ is plurisubharmonic function on $D$. It follows from sub-mean value inequality that for any $z \in K$, we have

|f(z)|^{\frac{2}{p}} \leq \frac{1}{\operatorname{Vol}(B(z, r))} \int_{B(z, r)}|f|^{\frac{2}{p}} d \lambda
$$

Then it follows from Hölder inequality that

$$
\begin{align*}
\operatorname{Vol}(B(z, r))|f(z)|^{\frac{2}{p}} & \leq \int_{B(z, r)}|f|^{\frac{2}{p}} \mu^{\frac{1}{p}} \mu^{-\frac{1}{p}} d \lambda \\
& \leq\left(\int_{B(z, r)}|f|^{2} \mu d \lambda\right)^{\frac{1}{p}}\left(\int_{B(z, r)} \mu^{-\frac{q}{p}} d \lambda\right)^{\frac{1}{q}}  \tag{2.1}\\
& \leq\|f\|_{\mu}^{\frac{2}{p}}\left(\int_{B(z, r)} \mu^{-a} d \lambda\right)^{\frac{1}{q}}
\end{align*}
$$

Hence

$$
|f(z)| \leq(\operatorname{Vol}(B(z, r)))^{\frac{-p}{2}}\left(\int_{B(z, r)} \mu^{-a} d \lambda\right)^{\frac{p}{2 q}}\|f\|_{\mu}
$$

Denote $C_{K}:=(\operatorname{Vol}(B(z, r)))^{\frac{-p}{2}}\left(\int_{B(z, r)} \mu^{-a} d \lambda\right)^{\frac{p}{2 q}}$ and for any $z \in K$, we have

$$
|f(z)| \leq C_{K}\|f\|_{\mu}
$$

Lemma 2.1 has been proved.

Remark 2.2. Let $\alpha \in \mathbb{Z}_{\geq 0}^{n}$ be a multi-index. Let $f$ be a holomorphic function on D. For any compact subset $K \subset D$, it follows from Lemma 2.1 and Cauchy integral formula that there exists a constant $C_{K, \alpha}>0$ such that we have

$$
\sup _{K}\left|\partial^{\alpha} f(z)\right| \leq C_{K, \alpha}\|f\|_{\mu} .
$$

In the following discussion, we assume that for any relatively compact set $U_{1} \Subset U$ $\left(W_{2} \Subset W\right)$, there exists a real number $a_{1}>0\left(a_{2}>0\right)$ such that $e^{a_{1} \varphi_{1}}\left(e^{a_{2} \varphi_{2}}\right)$ is integrable on $U_{1}\left(W_{2}\right)$. Then we have the following proposition.

Proposition 2.3. $A^{2}\left(U ; e^{-\varphi_{1}}\right), A^{2}\left(W ; e^{-\varphi_{2}}\right)$ and $A^{2}\left(M ; e^{-\varphi}\right)$ are separable Hilbert spaces.

Proof. We prove that $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ is separable Hilbert space. The same proof also holds for $A^{2}\left(W ; e^{-\varphi_{2}}\right)$ and $A^{2}\left(M ; e^{-\varphi}\right)$.

It is clear that we only need to prove that $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ is complete and separable. Let $U_{1} \Subset U$ be a relatively compact subset of $U$, then there exists $a_{1}>0$ such that $e^{a_{1} \varphi_{1}}$ is integrable on $U_{1}$. It follows from Lemma 2.1] that we

$$

\sup _{U_{1}}|f(z)| \leq C_{U_{1}}\|f\|_{1} . \tag{2.2}
\end{equation*}
$$

Let $\left\{f_{n}\right\}$ be a Cauchy sequence in $A^{2}\left(U ; e^{-\varphi_{1}}\right)$. It follows from inequality (2.2) that $\left\{f_{n}\right\}$ is compactly convergent to a holomorphic function $F$ on $U$. Then

$$
\begin{align*}
\int_{U}\left|f_{n}-F\right|^{2} e^{-\varphi_{1}} d \lambda_{U} & =\int_{U} \liminf _{k \rightarrow+\infty}\left|f_{n}-f_{k}\right|^{2} e^{-\varphi_{1}} d \lambda_{U} \\
& \leq \liminf _{k \rightarrow+\infty} \int_{U}\left|f_{n}-f_{k}\right|^{2} e^{-\varphi_{1}} d \lambda_{U}  \tag{2.3}\\
& =\liminf _{k \rightarrow+\infty}\left\|f_{n}-f_{k}\right\|_{1}
\end{align*}
$$

Hence when $n$ is large enough, we have $\|F\|_{1} \leq\left\|f_{n}-F\right\|_{1}+\left\|f_{n}\right\| \leq \epsilon+\left\|f_{n}\right\|<+\infty$, i.e. $F \in A^{2}\left(U ; e^{-\varphi_{1}}\right)$. It follows from $\left\{f_{n}\right\}$ is a Cauchy sequence in $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ and (2.3) that we know that when $n$ is large enough, we have $\liminf _{k \rightarrow+\infty}\left\|f_{n}-f_{k}\right\|_{1}<$ $\epsilon$, where $\epsilon>0$ is a small constant. Hence we have $\lim _{n \rightarrow+\infty}\left\|f_{n}-F\right\|_{1}=0$. Hence the norm $\|\cdot\|_{1}$ is complete and $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ is a Hilbert space.

Let $L^{2}\left(U ; e^{-\varphi_{1}}\right)$ be the space of the Lebesgue measurable function, which is square integrable with the weight $e^{-\varphi_{1}}$ on $U$. Note that $L^{2}\left(U ; e^{-\varphi_{1}}\right)$ is a separable Hilbert space (see [44). $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ is a closed subspace of $L^{2}\left(U ; e^{-\varphi_{1}}\right)$, hence $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ is a separable Hilbert space.

Next, we recall some results about products of Bergman spaces.
Lemma 2.4. Let $h \in A^{2}\left(M, e^{-\varphi}\right)$. Let $\alpha \in \mathbb{Z}_{\geq 0}^{n}$ be a multi-index (let $\beta \in \mathbb{Z}_{\geq 0}^{m}$ be a multi-index). For any $z_{0} \in U\left(w_{0} \in W\right)$, we have $\partial_{z}^{\alpha} h\left(z_{0}, w\right) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$ $\left(\partial_{w}^{\beta} h\left(z, w_{0}\right) \in A^{2}\left(U, e^{-\varphi_{1}}\right)\right)$.

Proof. It follows from Remark 2.2 that there exists a constant $C_{0}>0\left(C_{0}\right.$ is independent of $w)$ such that for any $w \in W$,

\left|\partial_{z}^{\alpha} h\left(z_{0}, w\right)\right| \leq C_{0}\|h(z, w)\|_{1}
$$

Then it follows from $h \in A^{2}\left(M, e^{-\varphi}\right)$ and Fubini's theorem that we have

\begin{aligned}
\mid \partial_{z}^{\alpha} h\left(z_{0}, w\right) \|_{2}^{2}: & =\int_{W}\left|\partial_{z}^{\alpha} h\left(z_{0}, w\right)\right|^{2} e^{-\varphi_{2}} d \lambda_{W} \\
& \leq C_{0} \int_{W}\|h(z, w)\|_{1}^{2} e^{-\varphi_{2}} d \lambda_{W} \\
& =C_{0} \int_{W} \int_{U}|h(z, w)|^{2} e^{-\varphi_{1}-\varphi_{2}} d \lambda_{M} \\
& =C_{0}\|h\|^{2}<+\infty
\end{aligned}
$$

Hence we have $\partial_{z}^{\alpha} h\left(z_{0}, w\right) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$.
The same proof as above shows that $\partial_{w}^{\alpha} h\left(z, w_{0}\right) \in A^{2}\left(U, e^{-\varphi_{1}}\right)$.
Lemma 2.4 has been proved.

The following lemma will be used in the proof of Lemma 2.6
Lemma 2.5. Let $h \in A^{2}\left(M, e^{-\varphi}\right)$ and $T \in A^{2}\left(U, e^{-\varphi_{1}}\right)$. For any $w \in W$, denote

Then $H(w)$ is a holomorphic function on $W$ and $H(w) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$.
Proof. When $w \in W$ is fixed, it follows from Lemma 2.4 that $h(z, w)$ belongs to $A^{2}\left(U, e^{-\varphi_{1}}\right)$. It follows from Cauchy-Schwarz inequality and both $T$ and $h(z, w)$ belong to $A^{2}\left(U, e^{-\varphi_{1}}\right)$ that

for any $w \in W$.
Let $w=\left(w_{1}, w_{2}, \ldots, w_{m}\right) \in W$ be given. Let $W_{0} \Subset W$ be an open convex neighborhood of $w$ in $W$. Let $\tilde{w}=\left(\tilde{w}_{1}, \tilde{w}_{2}, \ldots, \tilde{w}_{m}\right) \in W_{0}$. It follows from Remark 2.2 that we have

= & \left|\sum_{j=1}^{m}\left(w_{j}-\tilde{w}_{j}\right) \int_{0}^{1} \partial_{w_{j}} h(z, w+t(\tilde{w}-w)) d t-\sum_{j=1}^{m}\left(w_{j}-\tilde{w}_{j}\right) \partial_{w_{j}} h(z, w)\right|^{2} \\
= & \left|\sum_{j=1}^{m} \sum_{k=1}^{m}\left(w_{j}-\tilde{w}_{j}\right)\left(w_{k}-\tilde{w}_{k}\right) \int_{0}^{1} \int_{0}^{1} t_{1}\left(\partial_{w_{j}} \partial_{w_{k}} h\left(z, w+t_{1} t_{2}(\tilde{w}-w)\right)\right) d t_{2} d t_{1}\right|^{2} \\
\leq & |\tilde{w}-w|^{4} \frac{1}{4} \sum_{j=1}^{m} \sum_{k=1}^{m} \sup _{\hat{w} \in W_{0}}\left|\partial_{w_{j}} \partial_{w_{k}}(h(z, \hat{w}))\right|^{2} \\
\leq & C_{1}|\tilde{w}-w|^{4}\|h(z, \cdot)\|_{2}^{2},
\end{aligned}

where $C_{1}>0$ is a constant independent of $z$. Then we have

= & \left|\int_{U}\left(h(z, \tilde{w})-h(z, w)-\sum_{j=1}^{m}\left(w_{j}-\tilde{w}_{j}\right) \partial_{w_{j}} h(z, w)\right) \overline{T(z)} e^{-\varphi_{1}(z)} d \lambda_{U}\right|^{2} \\
\leq & \|T\|_{1}^{2} \int_{U}\left|h(z, \tilde{w})-h(z, w)-\sum_{j=1}^{m}\left(w_{j}-\tilde{w}_{j}\right) \partial_{w_{j}} h(z, w)\right|^{2} e^{-\varphi_{1}(z)} d \lambda_{U}  \tag{2.5}\\
\leq & \|T\|_{1}^{2}|\tilde{w}-w|^{4} C_{1} \int_{U}\|h(z, \cdot)\|_{2}^{2} e^{-\varphi_{1}(z)} d \lambda_{U} \\
= & \|T\|_{1}^{2}|\tilde{w}-w|^{4} C_{1} \int_{U} \int_{W}|h(z, \hat{w})|^{2} e^{-\varphi_{2}(\hat{w})} e^{-\varphi_{1}(z)} d \lambda_{W} d \lambda_{U} \\
= & C_{1}\|T\|_{1}^{2}|\tilde{w}-w|^{4}\|h\|^{2}
\end{align*}
$$

It follows from inequality (2.5) that $H(w)$ is a holomorphic function on $W$. Note that

& \leq\left(\int_{U}|T(z)|^{2} e^{-\varphi_{1}(z)} d \lambda_{U}\right) \int_{W} \int_{U}|h(z, w)|^{2} e^{-\varphi_{1}(z)-\varphi_{2}(w)} d \lambda_{U} d \lambda_{W} \\
& =\|T\|_{1}^{2} \cdot\|h\|^{2}<+\infty \tag{2.6}
\end{align*}

Hence we have $H(w) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$.

The following lemma implies that the product of bases of $A^{2}\left(U ; e^{-\varphi_{1}}\right)$ and $A^{2}\left(W ; e^{-\varphi_{2}}\right)$ make a basis of $A^{2}\left(M ; e^{-\varphi}\right)$.

Lemma 2.6. Let $\left\{f_{i}(z)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ and $\left\{g_{j}(w)\right\}_{j \in \mathbb{Z}_{\geq 0}}$ be the complete orthonormal bases of $A^{2}\left(U, e^{-\varphi_{1}}\right)$ and $A^{2}\left(W, e^{-\varphi_{2}}\right)$ respectively. Then $\left\{f_{i}(z) g_{j}(w)\right\}_{i, j \in \mathbb{Z}_{\geq 0}}$ is a complete orthonormal basis of $A^{2}\left(M, e^{-\varphi}\right)$.

Proof. It follows from Fubini's theorem that $\left\{f_{i}(z) g_{j}(w)\right\}_{i, j \in \mathbb{Z}_{\geq 0}}$ is orthonormal basis of $A^{2}\left(M, e^{-\varphi}\right)$. Now we prove $\left\{f_{i}(z) g_{j}(w)\right\}_{i, j \in \mathbb{Z}_{\geq 0}}$ is complete. Let $h(z, w) \in$ $A^{2}\left(M, e^{-\varphi}\right)$ such that $\int_{M} h(z, w) \overline{f_{i}(z) g_{j}(w)} e^{-\varphi} d \lambda_{M}=0$ for any $i, j \in \mathbb{Z}_{\geq 0}$.

For any $i_{0} \in \mathbb{Z}_{\geq 0}$, denote

H_{i_{0}}(w):=\int_{U} h(z, w) \overline{f_{i_{0}}(z)} e^{-\varphi_{1}} d \lambda_{U}
$$

where $w \in W$. It follows from Lemma 2.5 that $H_{i_{0}}(w) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$. It follows from Fubini's theorem that for any $j_{0} \in \mathbb{Z}_{\geq 0}$, we have

& =\int_{W} H_{i_{0}}(w) \overline{g_{j_{0}}(w)} e^{-\varphi_{2}} d \lambda_{W}
\end{align*}

As $j_{0}$ is arbitrarily chosen and $\left\{g_{j}(w)\right\}_{j \in \mathbb{Z}_{\geq 0}}$ is the complete orthonormal basis of $A^{2}\left(W, e^{-\varphi_{2}}\right)$, we know that $H_{i_{0}}(w)=0$ for any $i_{0} \in \mathbb{Z}_{\geq 0}$.

For any $w \in W$, it follows from $H_{i}(w)=0$ for any $i \in \mathbb{Z}_{\geq 0}$ and $\left\{f_{i}(z)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ is the complete orthonormal basis of $A^{2}\left(U, e^{-\varphi_{1}}\right)$, we know that $h(z, w)=0$, for any $z \in U$. Since $w$ is arbitrarily chosen, we know that $h(z, w) \equiv 0$ on $M$, for any $z \in U$. This shows that $\left\{f_{i}(z) g_{j}(w)\right\}_{i, j \in \mathbb{Z} \geq 0}$ is complete.

Lemma 2.6 has been proved.
Let $\Delta \subset \mathbb{C}$ be the unit disk, and let $Y$ be an $(n-1)$-dimensional complex manifold, and let $N=\Delta \times Y$. Let $\pi_{1}$ and $\pi_{2}$ be the natural projections from $N$ to $\Delta$ and $Y$ respectively. Let $\rho_{1}$ be a nonnegative Lebesgue measurable function on $\Delta$ satisfying that $\rho_{1}(w)=\rho_{1}(|w|)$ for any $w$ and the Lebesgue measure of $\left\{w \in \Delta: \rho_{1}(w)>0\right\}$ is positive. Let $\rho_{2}$ be a nonnegative Lebesgue measurable function on $Y$, and denote that $\rho=\pi_{1}^{*}\left(\rho_{1}\right) \times \pi_{2}^{*}\left(\rho_{2}\right)$ on $N$. We recall the following lemma.

Lemma 2.7 (see [2]). For any holomorphic $(n, 0)$ form $F$ on $N$, there exists a unique sequence of holomorphic $(n-1,0)$ forms $\left\{F_{j}\right\}_{j \in \mathbb{Z}_{\geq 0}}$ on $Y$ such that

where the right term of the above equality is uniformly convergent on any compact subset of $N$. Moreover, if $\int_{N}|F|^{2} \rho<+\infty$, we have

for any $j \in \mathbb{Z}_{\geq 0}$.
In the following discussion, we assume that $U \Subset \mathbb{C}$ is an open subset containing origin 0 in $\mathbb{C}$.

Lemma 2.8. There exists a countable complete orthonormal basis $\left\{\tilde{f}_{i}(z)\right\}_{i \in \mathbb{Z}}{ }_{\geq 0}$ of $A^{2}\left(U, e^{-\varphi_{1}}\right)$ such that $k_{i}:=\operatorname{ord}_{0}\left(\tilde{f}_{i}\right)$ is strictly increasing with respect to $i$.
Proof. For any $k \in \mathbb{Z}_{\geq 0}$, denote

A_{k}^{2}\left(U, e^{-\varphi_{1}}\right):=\left\{f \in A^{2}\left(U, e^{-\varphi_{1}}\right):\left(\partial_{z}^{k} f\right)(0)=1 \&\left(\partial_{z}^{j} f\right)(0)=0 \text { for } j<k\right\}
$$

If $A_{k}^{2}\left(U, e^{-\varphi_{1}}\right) \neq \emptyset$, denote $S_{k}:=\inf \left\{\|f\|_{1}: f \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)\right\}$. We prove that there exists a $F_{k} \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$ such that $S_{k}=\left\|F_{k}\right\|_{1}$.

Let $\left\{F_{j}\right\}_{j \in \mathbb{Z}_{\geq 0}}$ be a sequence of holomorphic functions in $A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$ such that $\left\|F_{j}\right\|_{1} \rightarrow S_{k}$ as $j \rightarrow+\infty$. It follows from Lemma 2.1 that for any relative compact subset $U_{1} \Subset U$, we have $\sup _{U_{1}}\left|F_{j}\right| \leq C_{1}\left\|F_{j}\right\|_{1}$ for some $C_{1}>0$. As $\left\|F_{j}\right\|_{1} \rightarrow S_{k}$
when $j \rightarrow+\infty$, we know that $\sup _{j} \sup _{U_{1}}\left|F_{j}\right|<C_{2}$ for some $C_{2}>0$. Hence there exists a subsequence of $\left\{F_{j}\right\}_{j \in \mathbb{Z}_{\geq 0}}$ (also denote by $\left\{F_{j}\right\}_{j \in \mathbb{Z}_{\geq 0}}$ ) compactly convergent to a holomorphic function $F_{k}$ on $U$. As $\left\{F_{j}\right\}_{j \in \mathbb{Z} \geq 0}$ is compactly convergent to $F_{k}$ and $F_{j} \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$, we know that $\left(\partial_{z}^{k} F_{k}\right)(0)=1$ and $\left(\partial_{z}^{j} F_{k}\right)(0)=0$ for $j<k$. It follows from Fatou's Lemma that we know

\int_{U}\left|F_{k}\right|^{2} e^{-\varphi_{1}} d \lambda_{U} \leq \liminf _{j \rightarrow+\infty} \int_{U}\left|F_{j}\right|^{2} e^{-\varphi_{1}} d \lambda_{U}=S_{k}
$$

which implies that $F_{k} \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$ and $\left\|F_{k}\right\|_{1} \leq S_{k}$. By definition of $S_{k}$, we know that $\left\|F_{k}\right\|_{1}=S_{k}$.

Denote $\mathbb{K}:=\left\{k \in \mathbb{Z}_{\geq 0}: A_{k}^{2}\left(U, e^{-\varphi_{1}}\right) \neq \emptyset\right\}$. Note that $\mathbb{K}$ is a countable infinite subset of $\mathbb{Z}_{\geq 0}$. For any $\bar{k} \in \mathbb{K}$, we take $f_{k}:=\frac{F_{k}}{\left\|F_{k}\right\|_{1}}$.

Now we prove $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is a complete orthonormal basis of $A^{2}\left(U, e^{-\varphi_{1}}\right)$.
Firstly, we prove that $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is orthonormal basis. Let $k \in \mathbb{K}$. We prove that for any $g \in A^{2}\left(U, e^{-\varphi_{1}}\right)$ satisfying $\left(\partial_{z}^{j} g\right)(0)=0$ for any $j \leq k$, we have $\left\langle f_{k}, g\right\rangle_{1}=0$, where $\langle\cdot, \cdot\rangle_{1}$ is the inner product on $A^{2}\left(U, e^{-\varphi_{1}}\right)$. Note that for any $\alpha \in \mathbb{C}$, we have $f_{k}+\alpha g \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$. Hence for any $\alpha \in \mathbb{C},\left\|f_{k}+\alpha g\right\|_{1} \geq S_{k}$. However let $\alpha=-\frac{\left\langle f_{k}, g\right\rangle_{1}}{\|g\|_{1}^{2}}$, then by direct computation we have

\left\|f_{k}+\alpha g\right\|_{1}^{2}=\left\|f_{k}\right\|_{1}^{2}-\left|\frac{\left\langle f_{k}, g\right\rangle_{1}}{\|g\|_{1}^{2}}\right|^{2}

If $\left\langle f_{k}, g\right\rangle_{1} \neq 0$, we will have $\left\|f_{k}+\alpha g\right\|_{1}<S_{k}$, which is a contradiction. Hence we have $\left\langle f_{k}, g\right\rangle_{1}=0$. By the above discussion, we also know that $f_{k}$ is the unique holomorphic function in $A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$ such that $\left\|f_{k}\right\|_{1}=S_{k}$. For any $k_{1}<k_{2} \in \mathbb{K}$, following above discussion, we have $\left\langle f_{k_{1}}, f_{k_{2}}\right\rangle_{1}=0$. By definition, we also have $\left\|f_{k}\right\|_{1}=1$. Hence $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is orthonormal basis.

Secondly, we prove that $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is complete. If $k \in \mathbb{Z}_{\geq 0} \backslash \mathbb{K}$, then we set $f_{k}(z) \equiv 0$. Let $h \in A^{2}\left(U, e^{-\varphi_{1}}\right)$ be a holomorphic function. Let $\left\{a_{k}\right\}_{k \in \mathbb{Z}_{\geq 0}}$ be a sequence of complex numbers which will be determined later. Let

h_{k}(z)=\sum_{j \leq k} a_{j} f_{j}(z) .
$$

Now we will choose $\left\{a_{k}\right\}_{k \in \mathbb{Z}_{\geq 0}}$ such that for any $j \leq k$,

\left(\partial_{z}^{j} h_{k}\right)(0)=\left(\partial_{z}^{j} h\right)(0) \tag{2.8}
\end{equation*}
$$

If $0 \in \mathbb{Z}_{\geq 0} \backslash \mathbb{K}$, we set $a_{0}=0$. If $0 \notin \mathbb{Z}_{\geq 0} \backslash \mathbb{K}$, we set $a_{0}=h(0)\left\|F_{0}\right\|_{1}$. By the construction of $\left\{f_{i}(z)\right\}_{i \in \mathbb{Z}}{ }^{2}$, we know that $h_{k}(0)=h(0)$. Assume that for any $j \leq k-1$, the sequence $\left\{a_{j}\right\}_{0 \leq j \leq k-1}$ has been chosen. Now we choose the number $a_{k}$. If $k \in \mathbb{Z}_{\geq 0} \backslash \mathbb{K}$, then $A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)=\emptyset$. We also note that $h-h_{k-1}$ satisfies

$$
\left(\partial_{z}^{j}\left(h-h_{k-1}\right)\right)(0)=0, \text { for any } j \leq k-1
$$

Then we have $\left(\partial_{z}^{k}\left(h-h_{k-1}\right)\right)(0)=0$, otherwise $\frac{\left(h(z)-h_{k-1}(z)\right)}{\left(\partial_{z}^{k}\left(h-h_{k-1}\right)\right)(0)} \in A_{k}^{2}\left(U, e^{-\varphi_{1}}\right)$ which is a contradiction. Since $\left(\partial_{z}^{k}\left(h-h_{k-1}\right)\right)(0)=0$, we set $a_{k}=0$. If $k \in \mathbb{K}$, it follows from $\left(\partial_{z}^{k} h_{k}\right)(0)=\left(\partial_{z}^{k} h\right)(0)$ that we have the following equation

\end{equation*}

Note that $\left(\partial_{z}^{k} f_{k}\right)(0)=\frac{1}{\left\|F_{k}\right\|_{1}} \neq 0$ and $\left\{a_{j}\right\}_{0 \leq j \leq k-1}$ has been chosen. The equation (2.9) can be solved, i.e. we can find $a_{k}$ such that $\left(\partial_{z}^{k} h_{k}\right)(0)=\left(\partial_{z}^{k} h\right)(0)$ holds. Hence we can choose $\left\{a_{k}\right\}_{k \in \mathbb{Z}_{\geq 0}}$ by induction such that for any $j \leq k$,

Note that for any $j \leq k$, we have $\left(\partial_{z}^{j}\left(h_{k}-h\right)\right)(0)=0$. Hence we know that $\left\langle h_{k}-h, f_{k}\right\rangle_{1}=0$, i.e.

By Bessel inequality, we have $\sum_{j=0}^{+\infty}\left|a_{j}\right|^{2} \leq\|h\|_{1}^{2}$. Denote $H(z):=\sum_{j=0}^{+\infty} a_{j} f_{j}(z)$, where the right hand-side is uniformly convergent to $H(z)$ on any compact subset of $U$ and we have $H(z) \in A^{2}\left(U, e^{-\varphi_{1}}\right)$. Hence for any $k \in \mathbb{Z}_{\geq 0}$, we have

\left(\partial_{z}^{k} H\right)(0)=\lim _{j \rightarrow+\infty}\left(\partial_{z}^{k} h_{k}\right)(0)=\left(\partial_{z}^{k} h\right)(0)
$$

Hence $h \equiv H$, which implies that $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is complete.
Denote $\tilde{f}_{1}:=f_{k_{1}}$, where $k_{1}$ satisfies $\operatorname{ord}_{0}\left(f_{k_{1}}\right)$ is minimal among $k \in \mathbb{K}$. Denote $\tilde{f}_{2}:=f_{k_{2}}$, where $k_{2}$ satisfies $\operatorname{ord}_{0}\left(f_{k_{2}}\right)$ is minimal among $k \in \mathbb{K} \backslash\left\{k_{1}\right\}$. Denote $\tilde{f}_{i}:=f_{k_{i}}$, where $k_{i}$ satisfies $\operatorname{ord}_{0}\left(f_{k_{i}}\right)$ is minimal among $k \in \mathbb{K} \backslash\left\{k_{1}, k_{2}, \ldots, k_{i-1}\right\}$. Now $\left\{\operatorname{ord}_{0}\left(\tilde{f}_{i}\right)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ is strictly increasing with respect to $i$. Note that $\left\{\tilde{f}_{i}(z)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ is a rearrangement of $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ and $\left\{f_{k}(z)\right\}_{k \in \mathbb{K}}$ is a complete orthonormal basis of $A^{2}\left(U, e^{-\varphi_{1}}\right)$. We know that $\left\{\tilde{f}_{i}(z)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ satisfies the requirement of Lemma 2.8 We are done.

In the following discussion, let $U=\Delta \subset \mathbb{C}$ be the unit disk. It follows from Lemma 2.8 that there exists a complete orthonormal basis $\left\{\tilde{f}_{i}(z)\right\}_{i \in \mathbb{Z}_{\geq 0}}$ of $A^{2}\left(U, e^{-\varphi_{1}}\right)$ which satisfies $\operatorname{ord}_{0}\left(\tilde{f}_{i}\right)$ is strictly increasing with respect to $i$. Let $W \subset \mathbb{C}^{m}$ be an open set. Let $\left\{g_{j}(w)\right\}_{j \in \mathbb{Z}_{\geq 0}}$ be the complete orthonormal basis of $A^{2}\left(W, e^{-\varphi_{2}}\right)$. Let $F$ be a holomorphic function on $M:=U \times W$ satisfying that $F \in A^{2}\left(M, e^{-\varphi}\right)$. It follows from Lemma 2.7 that $F=\sum_{l \geq \tilde{k}} z^{l} F_{l}(w)$, where $\left\{F_{l}\right\}_{l \geq \tilde{k}}$ is a sequence of holomorphic functions on $W$ and $F_{\tilde{k}}(w) \not \equiv 0$. Denote $k_{i}:=\operatorname{ord}_{0}\left(\tilde{f}_{i}\right)$ for any $i \in \mathbb{Z}_{\geq 0}$ and $k:=\inf _{i \in \mathbb{Z}}{ }_{\geq 0}\left\{k_{i}\right\}=k_{1}$.

Lemma 2.9. We have $\tilde{k} \geq k$ and for any $l \geq \tilde{k}, F_{l} \in A^{2}\left(W, e^{-\varphi_{2}}\right)$.
Proof. It follows from Lemma 2.6 that $\left\{\tilde{f}_{i}(z) g_{j}(w)\right\}_{i, j \in \mathbb{Z}_{\geq 0}}$ is a complete orthonormal basis of $A^{2}\left(M, e^{-\varphi}\right)$.

As $F \in A^{2}\left(M, e^{-\varphi}\right)$, we know that

$$
F(z, w)=\sum_{i, j \in \mathbb{Z}_{\geq 0}} a_{i j} \tilde{f}_{i}(z) g_{j}(w)=\sum_{i \in \mathbb{Z}_{\geq 0}} \tilde{f}_{i}(z) \sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w)
$$

for some $a_{i j} \in \mathbb{C}$, where the right-hand side is uniformly convergent on any compact subset of $M$. It follows from $F \in A^{2}\left(M, e^{-\varphi}\right)$ that we know $\sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w) \in$ $A^{2}\left(W, e^{-\varphi_{2}}\right)$ for any $i \in \mathbb{Z}_{\geq 0}$.

As $U \subset \mathbb{C}$ is unit disc, we assume that for each $i \in \mathbb{Z}_{\geq 0}, \tilde{f}_{i}(z)=\sum_{l \geq k_{i}}^{+\infty} b_{i l} z^{l}$ on $U$ for some $b_{i l} \in \mathbb{C}$, where the right-hand side is uniformly convergent on any compact subset of $U$. Then we know that $F(z, w)=\sum_{l \geq k} z^{l}\left(\sum_{i \in \mathbb{I}_{l}} b_{i l}\left(\sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w)\right)\right)$,
where the index set $\mathbb{I}_{l}:=\left\{i \in \mathbb{Z}_{\geq 0}: k_{i} \leq l\right\}$ and the right-hand side is uniformly convergent on any compact subset of $M$. For fixed $l \geq k$, as $k_{i} \in \mathbb{Z}_{\geq 0}$ is strictly increasing with respect to $i$, we know that $\mathbb{I}_{l}$ is a finite set for any $l \geq k$.

Recall that it follows from Lemma 2.7 that $F=\sum_{l \geq \tilde{k}} z^{l} F_{l}(w)$ and $\left\{F_{l}\right\}_{l \geq \tilde{k}}$ is unique. The uniqueness of $\left\{F_{l}\right\}_{l \geq \tilde{k}}$ implies that we have $\sum_{i \in \mathbb{I}_{l}} b_{i l}\left(\sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w)\right)=$ 0 for $k \leq l<\tilde{k}$ and $F_{l}(w)=\sum_{i \in \mathbb{I}_{l}} b_{i l}\left(\sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w)\right)$ for any $l \geq \tilde{k}$. It follows from $\mathbb{I}_{l}$ is a finite set for any $l \geq k$ and $\sum_{j \in \mathbb{Z}_{\geq 0}} a_{i j} g_{j}(w) \in A^{2}\left(W, e^{-\varphi_{2}}\right)$ for any $i \in \mathbb{Z}_{\geq 0}$. that we have $F_{l} \in A^{2}\left(W, e^{-\varphi_{2}}\right)$ for any $l \geq \tilde{k}$.

Remark 2.10. By the definition of $k$, we know that for any $l \geq k,|z|^{2 l} e^{-\varphi_{1}}$ is $L^{1}$ integrable near $0 \in \mathbb{C}$. As $\tilde{k} \geq k$, we have $|z|^{2 l} e^{-\varphi_{1}}$ is $L^{1}$ integrable near $0 \in \mathbb{C}$ for any $l \geq \tilde{k}$.
2.2. Concavity property on weakly pseudoconvex Kähler manifolds. In this section, we recall some results about the concavity property on weakly pseudoconvex Kähler manifolds [21] (see also [20]). Let $M$ be a complex manifold. Let $X$ and $Z$ be closed subsets of $M$. We call that a triple $(M, X, Z)$ satisfies condition $(A)$, if the following two statements hold:
I. $X$ is a closed subset of $M$ and $X$ is locally negligible with respect to $L^{2}$ holomorphic functions; i.e., for any local coordinated neighborhood $U \subset M$ and for any $L^{2}$ holomorphic function $f$ on $U \backslash X$, there exists an $L^{2}$ holomorphic function $\tilde{f}$ on $U$ such that $\left.\tilde{f}\right|_{U \backslash X}=f$ with the same $L^{2}$ norm;
$I I . Z$ is an analytic subset of $M$ and $M \backslash(X \cup Z)$ is a weakly pseudoconvex Kähler manifold.

Let $M$ be an $n$-dimensional complex manifold. Assume that ( $M, X, Z$ ) satisfies condition $(A)$. Let $K_{M}$ be the canonical line bundle on $M$. Let $d V_{M}$ be a continuous volume form on $M$. Let $F$ be a holomorphic function on $M$. Assume that $F$ is not identically zero. Let $\psi$ be a plurisubharmonic function on $M$. Let $\varphi$ be a Lebesgue measurable function on $M$ such that $\varphi+\psi$ is a plurisubharmonic function on $M$.

Let $T \in[-\infty,+\infty)$. Denote that

$$
\Psi:=\min \{\psi-2 \log |F|,-T\}
$$

For any $z \in M$ satisfying $F(z)=0$, we set $\Psi(z)=-T$.
Definition 2.11 ([21]). We call that a positive measurable function c on $(T,+\infty)$ is in class $\tilde{P}_{T, M, \Psi}$ if the following two statements hold:
(1) $c(t) e^{-t}$ is decreasing with respect to $t$;
(2) For any $t_{0}>T$, there exists a closed subset $E_{0}$ of $M$ such that $E_{0} \subset Z \cap$ $\{\Psi(z)=-\infty\}$ and for any compact subset $K \subset M \backslash E_{0}, e^{-\varphi} c(-\Psi)$ has a positive lower bound on $K \cap\left\{\Psi<-t_{0}\right\}$.

For $f_{z_{0}} \in J(\Psi)_{z_{0}}$ and $a, b \geq 0$, we call $f_{z_{0}} \in I(a \Psi+b \varphi)_{z_{0}}$ if there exist $t \gg T$ and a neighborhood $V$ of $z_{0}$, such that $\int_{\{\Psi<-t\} \cap V}|f|^{2} e^{-a \Psi-b \varphi} d V_{M}<+\infty$. Note that $I(a \Psi+b \varphi)_{z_{0}}$ is an $\mathcal{O}_{M, z_{0}}$-submodule of $J(\Psi)_{z_{0}}$.

Let $Z_{0}$ be a subset of $\cap_{t>T} \overline{\{\Psi<-t\}}$. Let $f$ be a holomorphic $(n, 0)$ form on $\left\{\Psi<-t_{0}\right\} \cap V$, where $V \supset Z_{0}$ is an open subset of $M$ and $t_{0} \geq T$ is a real
 where $z_{0} \in Z_{0}$. Let $J$ be the $\mathcal{O}_{M, z_{0}}$-module sheaf with stalks $J_{z_{0}}$, where $z_{0} \in Z_{0}$.

Denote the minimal $L^{2}$ integral related to $J$

$$
\begin{align*}
\inf \left\{\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi)\right. & : \tilde{f} \in H^{0}\left(\{\Psi<-t\}, \mathcal{O}\left(K_{M}\right)\right) \\
& \left.\&(\tilde{f}-f)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}, \text { for any } z_{0} \in Z_{0}\right\} \tag{2.10}
\end{align*}
$$

by $G(t ; c, \Psi, \varphi, J, f)$, where $t \in[T,+\infty), c$ is a nonnegative function on $(T,+\infty)$ and $|f|^{2}:=\sqrt{-1}^{n^{2}} f \wedge \bar{f}$ for any $(n, 0)$ form $f$. Without misunderstanding, we denote $G(t ; c, \Psi, \varphi, J, f)$ by $G(t)$ for simplicity. For various $c(t)$, we denote $G(t ; c, \Psi, \varphi, J, f)$ by $G(t ; c)$ respectively for simplicity.

We recall the concavity property for $G(t)$.
Theorem 2.12 ([21). Let $c \in \tilde{P}_{T, M, \Psi}$ satisfying that $\int_{T_{1}}^{+\infty} c(s) e^{-s} d s<+\infty$, where $T_{1}>T$. If there exists $t \in[T,+\infty)$ satisfying that $G(t)<+\infty$, then $G\left(h^{-1}(r)\right)$ is concave with respect to $r \in\left(0, \int_{T}^{+\infty} c(t) e^{-t} d t\right), \lim _{t \rightarrow T+0} G(t)=G(T)$ and $\lim _{t \rightarrow+\infty} G(t)=0$, where $h(t)=\int_{t}^{+\infty} c(s) e^{-s} d s$.

When $F \equiv 1$ and $\psi(z)=-\infty$ for any $z \in Z_{0}, J_{z}$ is an ideal of $\mathcal{O}_{M, z}$ for any $z \in Z_{0}$ and Theorem 2.12 degenerates to the concavity property with respect to the ideals at inner points ([20], see also [19]).

Let $c(t)$ be a nonnegative measurable function on $(T,+\infty)$. Denote that

$$
\begin{array}{r}
\mathcal{H}^{2}(t ; c):=\left\{\tilde{f}: \int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi)<+\infty, \tilde{f} \in H^{0}\left(\{\Psi<-t\}, \mathcal{O}\left(K_{M}\right)\right)\right. \\
\left.\&(\tilde{f}-f)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}, \text { for any } z_{0} \in Z_{0}\right\},
\end{array}
$$

where $t \in[T,+\infty)$.
The following corollary gives a necessary condition for the concavity degenerating to linearity.

Corollary 2.13 ([21). Let $c \in \tilde{P}_{T, M, \Psi}$ satisfying that $\int_{T_{1}}^{+\infty} c(s) e^{-s} d s<+\infty$, where $T_{1}>T$. Assume that $G(t) \in(0,+\infty)$ for some $t \geq T$, and $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left[0, \int_{T}^{+\infty} c(s) e^{-s} d s\right)$, where $h(t)=\int_{t}^{+\infty} c(s) e^{-s} d s$.

Then there exists a unique holomorphic $(n, 0)$ form $\tilde{F}$ on $\{\Psi<-T\}$ such that $(\tilde{F}-f)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}$ holds for any $z_{0} \in Z_{0}$, and $G(t)=\int_{\{\Psi<-t\}}|\tilde{F}|^{2} e^{-\varphi} c(-\Psi)$ holds for any $t \geq T$.

Furthermore

$$
\int_{\left\{-t_{1} \leq \Psi<-t_{2}\right\}}|\tilde{F}|^{2} e^{-\varphi} a(-\Psi)=\frac{G\left(T_{1} ; c\right)}{\int_{T_{1}}^{+\infty} c(t) e^{-t} d t} \int_{t_{2}}^{t_{1}} a(t) e^{-t} d t
$$

holds for any nonnegative measurable function a on $(T,+\infty)$, where $T \leq t_{2}<t_{1} \leq$ $+\infty$ and $T_{1} \in(T,+\infty)$.

Remark 2.14 ([21]). If $\mathcal{H}^{2}\left(t_{0} ; \tilde{c}\right) \subset \mathcal{H}^{2}\left(t_{0} ; c\right)$ for some $t_{0} \geq T$, we have

$$
G\left(t_{0} ; \tilde{c}\right)=\int_{\left\{\Psi<-t_{0}\right\}}|\tilde{F}|^{2} e^{-\varphi} \tilde{c}(-\Psi)=\frac{G\left(T_{1} ; c\right)}{\int_{T_{1}}^{+\infty} c(t) e^{-t} d t} \int_{t_{0}}^{+\infty} \tilde{c}(s) e^{-s} d s
$$

where $\tilde{c}$ is a nonnegative measurable function on $(T,+\infty)$ and $T_{1} \in(T,+\infty)$. Thus, if $\mathcal{H}^{2}(t ; \tilde{c}) \subset \mathcal{H}^{2}(t ; c)$ for any $t>T$, then $G\left(h^{-1}(r) ; \tilde{c}\right)$ is linear with respect to $r \in\left[0, \int_{T}^{+\infty} c(s) e^{-s} d s\right)$.

We recall a characterization of $G(t)=0$, where $t \geq T$.
Lemma 2.15 ([21]). Let $c \in \tilde{P}_{T, M, \Psi}$ satisfying that $\int_{T_{1}}^{+\infty} c(s) e^{-s} d s<+\infty$, where $T_{1}>T$. Let $t_{0} \geq T$. The following two statements are equivalent:
(1) $G\left(t_{0}\right)=0$;
(2) $f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}$, for any $z_{0} \in Z_{0}$.
2.3. Properties of $\mathcal{O}_{M, p}$-module $J_{p}$. In this section, we present some properties of $\mathcal{O}_{M, p}$-module $J_{p}$. The notation used in this section can be referred to Section 1.1.

Let $T \in[-\infty,+\infty)$. Denote

$$
\Psi:=\min \left\{\pi_{1}^{*}(\psi-2 \log |F|),-T\right\} .
$$

If $F(z)=0$ for some $z \in \Omega$, we set $\Psi(z, w)=-T$ for any $w \in Y$. Let $T_{1}>T$ be any real number.

Denote

$$
\varphi_{1}:=2 \max \left\{\pi_{1}^{*}(\psi)+T_{1}, \pi_{1}^{*}(2 \log |F|)\right\}
$$

and

$$
\Psi_{1}:=\min \left\{\Psi,-T_{1}\right\}
$$

Denote $\varphi:=\pi_{1}^{*}\left(\varphi_{\Omega}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)$. By definition we have $I\left(\Psi_{1}+\varphi\right)_{p}=I(\Psi+\varphi)_{p}$, for any $p \in M$. Recall that $\varphi_{\Omega}+\psi$ and $\psi$ are subharmonic functions on $\Omega$, hence for any relatively compact subset $U \Subset \Omega$, there exists a real number $a_{1}>0$ such that $e^{a_{1} \varphi_{\Omega}}$ is integrable on $U$. Note that $\varphi_{Y}$ is a plurisubharmonic function on $Y$ and then for any relatively compact set $W \Subset Y$, there exists a real number $a_{2}>0$ such that $e^{a_{2} \varphi_{Y}}$ is integrable on $W$.

Let $c(t)$ be a positive measurable function on $(T,+\infty)$ such that $c(t) \in \tilde{P}_{T, M, \Psi}$. Let $d V_{M}$ be a continuous volume form on $M$. Let $p \in M$ be a point, denote that $H_{p}:=\left\{f_{p} \in J(\Psi)_{p}: \int_{\{\Psi<-t\} \cap V_{0}}|f|^{2} e^{-\varphi} c(-\Psi) d V_{M}<+\infty\right.$ for some $t>T$ and $V_{0}$ is an open neighborhood of $p\}$ and $\mathcal{H}_{p}:=\left\{(F, p) \in \mathcal{O}_{M, p}: \int_{U_{0}}|F|^{2} e^{-\varphi-\varphi_{1}} c\left(-\Psi_{1}\right) d V_{M}<\right.$ $+\infty$ for some open neighborhood $U_{0}$ of $\left.p\right\}$.

As $c(t) \in \tilde{P}_{T, M, \Psi}$, hence $c(t) e^{-t}$ is decreasing with respect to $t$ and we have $I\left(\Psi_{1}+\varphi\right)_{p}=I(\Psi+\varphi)_{p} \subset H_{p}$. We also note that $\mathcal{H}_{p}$ is an ideal of $\mathcal{O}_{M, p}$.

In [21], we proved the following proposition of $H_{p} / I\left(\varphi+\Psi_{1}\right)_{p}$.
Proposition 2.16 ([21]). There exists an $\mathcal{O}_{M, p}$-module isomorphism $P: H_{p} / I(\varphi+$ $\left.\Psi_{1}\right)_{p} \rightarrow \mathcal{H}_{p} / \mathcal{I}\left(\varphi+\varphi_{1}+\Psi_{1}\right)_{p}$.

We recall the following closedness property of submodule of $\mathcal{O}_{\mathbb{C}^{n}, o}^{q}$.
Lemma 2.17 (see [18]). Let $N$ be a submodule of $\mathcal{O}_{\mathbb{C}^{n}, o}^{q}, 1 \leq q<+\infty$, let $f_{j} \in$ $\mathcal{O}_{\mathbb{C}^{n}}(U)^{q}$ be a sequence of $q$-tuples holomorphic in an open neighborhood $U$ of the origin o. Assume that the $f_{j}$ converge uniformly in $U$ towards a $q$-tuples $f \in$ $\mathcal{O}_{\mathbb{C}^{n}}(U)^{q}$, assume furthermore that all germs $\left(f_{j}, o\right)$ belong to $N$. Then $(f, o) \in N$.

We recall the following well-known result due to Skoda.
Lemma 2.18 (40). Let $u$ be a plurisubharmonic function on $\Delta^{n} \subset \mathbb{C}^{n}$. If $v\left(d d^{c} u, o\right)<1$, then $e^{-2 u}$ is $L^{1}$ on a neighborhood of $o$, where $o \in \Delta^{n}$ is the origin.

Following from Lemma 2.18 and Siu's Decomposition Theorem, we can obtain the following well-known result (see [21]).
Lemma 2.19. Let $\varphi$ be a subharmonic function on the unit disc $\Delta \subset \mathbb{C}$. Then we have $\mathcal{I}(\varphi)_{o}=\left(z^{k}\right)_{o}$ if and only if $v\left(d d^{c}(\varphi), o\right) \in[2 k, 2 k+2)$.

Recall that $\tilde{Z}_{0} \subset \Omega$ is a subset of $\cap_{t>T} \overline{\left\{\left(\pi_{1}\right)_{*}(\Psi)<-t\right\}}$. Recall that $\tilde{Z}_{1}:=\{z \in$ $\left.\tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right) \geq 2 \operatorname{ord}_{z}(F)\right\}, \tilde{Z}_{2}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right)<\operatorname{ord}_{z}(F)\right\}$, and $\tilde{Z}_{3}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right)>\operatorname{ord}_{z}(F)\right\}$. We denote $Z_{1}:=\tilde{Z}_{1} \times Y, Z_{2}:=\tilde{Z}_{2} \times Y$ and $Z_{3}:=\tilde{Z}_{3} \times Y$ respectively.

Lemma 2.20. Assume that $c(t) \geq 1$ near $+\infty$ and $v\left(d d^{c}(\psi), z_{0}\right)+v\left(d d^{c}(\psi+\right.$ $\left.\left.\varphi_{\Omega}\right), z_{0}\right) \notin \mathbb{Z}$ for any $z_{0} \in \tilde{Z}_{2}$. Then for any $p=(z, w) \in Z_{2}$, we have $H_{p}=$ $I(\varphi+\Psi)_{p}$.
Proof. It follows from Proposition 2.16 that $H_{p}=I\left(\varphi+\Psi_{1}\right)_{p}$ if and only if $\mathcal{H}_{p}=$ $\mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{p}$, where $\mathcal{H}_{p}:=\left\{(h, p) \in \mathcal{O}_{M, p}:|h|^{2} e^{-\varphi-\varphi_{1}} c\left(-\Psi_{1}\right)\right.$ is integrable near $p\}$. Now, we prove $\mathcal{H}_{p}=\mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{p}$.

Without loss of generality, we can assume that $M=\Delta \times \Delta^{n-1}, z=0 \in \Delta$ and $p=o \in M$ (the origin of $M$ ). As $c(t) e^{-t}$ is decreasing, we have $\mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o} \subset$ $\mathcal{H}_{o}$. For any $(h, o) \in \mathcal{H}_{o}$, there exists $r_{1}>0$ such that $\int_{\Delta_{r_{1} \times \Delta_{r_{1}}^{n-1}}|h|^{2} e^{-\varphi-\varphi_{1}} c\left(-\Psi_{1}\right) \lll<r}$ $+\infty$, which implies that

$$
\begin{equation*}
\int_{\Delta_{r_{1} \times \Delta_{r_{1}}^{n-1}}}|h|^{2} e^{-\varphi-\varphi_{1}}<+\infty \tag{2.11}
\end{equation*}
$$

where $\Delta_{r_{1}}=\left\{z \in \mathbb{C}:|z|<r_{1}\right\}$. Hence we know that $h \in A^{2}\left(\Delta_{r_{1}} \times \Delta_{r_{1}}^{n-1}, e^{-\varphi-\varphi_{1}}\right)$. Denote that $x_{1}:=v\left(d d^{c}(\psi), 0\right)$ and $x_{2}:=v\left(d d^{c}\left(\varphi_{\Omega}+\psi\right), 0\right)$. It follows from Siu's Decomposition Theorem that

It follows from Lemma 2.17 and $h(z, w)=\sum_{l \geq k} z^{l} F_{l}(w)$ that we have $(h, o) \in \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$. Without loss of generality, we can assume that $M=\Delta \times \Delta^{n-1}, z=0 \in \Delta$ and $p=o \in M$ (the origin of $M$ ). Denote that $x_{1}:=v\left(d d^{c}(\psi), 0\right)$ and $x_{2}:=v\left(d d^{c}\left(\varphi_{\Omega}+\psi\right), 0\right)$.

Firstly, we prove $\mathcal{H}_{o} \subset \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$ under condition $(A)(\varphi+a \psi$ is subharmonic near 0 for some $a \in[0,1)$ ). As $c(t) \geq \frac{e^{t}}{t^{2}}$, we can assume that $c(t) \geq e^{a t}$

It follows from Lemma 2.9 and Remark 2.10 that we know that $h(z, w)=\sum_{l>k} z^{l} F_{l}(w)$, where $\left\{F_{l}\right\}_{l \geq k}$ is a sequence of holomorphic functions on $W$ satisfying $F_{k}(w) \not \equiv 0, F_{l} \in A^{2}\left(\Delta^{n-1}, e^{-\varphi_{Y}}\right)$ and $|z|^{2 l} e^{-\varphi_{\Omega}-\left(\pi_{1}\right)_{*}\left(a \Psi_{1}+\varphi_{1}\right)}$ is $L^{1}$ integrable near $0 \in \Delta$ for any $l \geq k$.

Note that $\varphi_{\Omega}+\left(\pi_{1}\right)_{*}\left(a \Psi_{1}+\varphi_{1}\right)=\varphi_{\Omega}+a \psi+(2-a) \max \{\psi, 2 \log |F|\}$ and $v\left(d d^{c}\left(\varphi_{\Omega}+a \psi\right), 0\right)=v\left(d d^{c}\left(\varphi_{\Omega}+\psi\right), 0\right)-(1-a) v\left(d d^{c}(\psi), 0\right)=x_{2}-(1-a) x_{1}$. It follows from $|z|^{2 l} e^{-\varphi_{\Omega}-\left(\pi_{1}\right)_{*}\left(a \Psi_{1}+\varphi_{1}\right)}$ is $L^{1}$ integrable near $0 \in \Delta$ for any $l \geq k$ and Lemma 2.19 that $\left(z^{l}, 0\right) \in \mathcal{I}\left(\varphi_{\Omega}+\left(\pi_{1}\right)_{*}\left(\Psi_{1}+\varphi_{1}\right)\right)_{0}$ for any $l \geq k$.

It follows from $\left(z^{l}, 0\right) \in \mathcal{I}\left(\varphi_{\Omega}+\left(\pi_{1}\right)_{*}\left(\Psi_{1}+\varphi_{1}\right)\right)_{0}$ and $F_{l} \in A^{2}\left(\Delta^{n-1}, e^{-\varphi_{Y}}\right)$ for any $l \geq k$ that we have $z^{l} F_{l}(w) \in \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$ for any $l \geq k$. It follows from Lemma 2.17 and $h(z, w)=\sum_{l \geq k} z^{l} F_{l}(w)$ that we have $(h, o) \in \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$. It follows from $\left(z^{l}, 0\right) \in \mathcal{I}\left(\varphi_{\Omega}+\left(\pi_{1}\right)_{*}\left(\Psi_{1}+\varphi_{1}\right)\right)_{0}$ and $F_{l} \in A^{2}\left(\Delta^{n-1}, e^{-\varphi_{Y}}\right)$ for any $l \geq k$ that we have $z^{l} F_{l}(w) \in \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$ for any $l \geq k$. It follows from Lemma 2.17 and $h(z, w)=\sum_{l \geq k} z^{l} F_{l}(w)$ that we have $(h, o) \in \mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$. Hence we obtain that $\mathcal{H}_{o}=\mathcal{I}\left(\varphi+\Psi_{1}+\varphi_{1}\right)_{o}$ under condition $(B)$.

Lemma 2.21 is proved.
2.4. Some required lemmas. In this section, we recall and present some required lemmas.

Lemma 2.22 (see [24]). Let $c(t)$ be a positive measurable function on $(0,+\infty)$, and let $a \in \mathbb{R}$. Assume that $\int_{t}^{+\infty} c(s) e^{-s} d s \in(0,+\infty)$ when $t$ near $+\infty$. Then we have
(1) $\lim _{t \rightarrow+\infty} \frac{\int_{t}^{+\infty} c(s) e^{-a s} d s}{\int_{t}^{+\infty} c(s) e^{-s} d s}=1$ if and only if $a=1$;
(2) $\lim _{t \rightarrow+\infty} \frac{\int_{t}^{+\infty} c(s) e^{-a s} d s}{\int_{t}^{+\infty} c(s) e^{-s} d s}=0$ if and only if $a>1$;
(3) $\lim _{t \rightarrow+\infty} \frac{\int_{t}^{+\infty} c(s) e^{-a s} d s}{\int_{t}^{+\infty} c(s) e^{-s} d s}=+\infty$ if and only if $a<1$.

The following Lemma belongs to Fornæss and Narasimhan on approximation property of plurisubharmonic functions on Stein manifolds.

Lemma 2.23 ( 15$)$. Let $X$ be a Stein manifold and $\varphi \in P S H(X)$. Then there exists a sequence $\left\{\varphi_{n}\right\}_{n=1, \ldots}$ of smooth strongly plurisubharmonic functions such that $\varphi_{n} \downarrow \varphi$.

Now, we recall some basic properties of the Green functions. Let $\Omega$ be an open Riemann surface, which admits a nontrivial Green function $G_{\Omega}$, and let $z_{0} \in \Omega$.

Lemma 2.24 (see [36], see also [43]). Let $w$ be a local coordinate on a neighborhood of $z_{0}$ satisfying $w\left(z_{0}\right)=0 . G_{\Omega}\left(z, z_{0}\right)=\sup _{v \in \Delta_{\Omega}^{*}\left(z_{0}\right)} v(z)$, where $\Delta_{\Omega}^{*}\left(z_{0}\right)$ is the set of negative subharmonic function on $\Omega$ such that $v-\log |w|$ has a locally finite upper bound near $z_{0}$. Moreover, $G_{\Omega}\left(\cdot, z_{0}\right)$ is harmonic on $\Omega \backslash\left\{z_{0}\right\}$ and $G_{\Omega}\left(\cdot, z_{0}\right)-\log |w|$ is harmonic near $z_{0}$.

Lemma 2.25 (see [22]). For any open neighborhood $U$ of $z_{0}$, there exists $t>0$ such that $\left\{z \in \Omega: G_{\Omega}\left(z, z_{0}\right)<-t\right\}$ is a relatively compact subset of $U$.

Let $S:=\left\{z_{j}: j \in \mathbb{Z}_{\geq 1} \& j<\gamma\right\}$ be a discrete subset of the open Riemann surface $\Omega$, where $\gamma \in \mathbb{Z}_{\geq 2} \cup\{+\infty\}$. We recall the following two lemmas about $\sum_{1 \leq j<\gamma} q_{j} G_{\Omega}\left(\cdot, z_{j}\right)$.
Lemma 2.26 (see [23). Let $\psi$ be a negative subharmonic function on $\Omega$ such that $\frac{1}{2} v\left(d d^{c} \psi, z_{j}\right) \geq q_{j}$ for any $j$, where $q_{j}>0$ is a constant. Then $2 \sum_{1 \leq j<\gamma} q_{j} G_{\Omega}\left(\cdot, z_{j}\right)$ is a subharmonic function on $\Omega$ satisfying that $2 \sum_{1 \leq j<\gamma} q_{j} G_{\Omega}\left(\cdot, z_{j}\right) \geq \psi$ and $2 \sum_{1 \leq j<\gamma} q_{j} G_{\Omega}\left(\cdot, z_{j}\right)$ is harmonic on $\Omega \backslash S$.

The following lemma will be used in the proofs of Proposition 2.32 and Proposition 2.34

Lemma 2.27 (see [23]). Let $\psi$ be a negative plurisubharmonic function on $\Omega$ satisfying $\frac{1}{2} v\left(d d^{c} \psi, z_{0}\right) \geq q_{j}>0$ for any $j$, where $q_{j}$ is a constant. Assume that $\psi \not \equiv 2 \sum_{1 \leq k<\gamma} q_{j} G_{\Omega}\left(\cdot, z_{j}\right)$. Let $l(t)$ be a positive Lebesgue measurable function on $(0,+\infty)$ satisfying $l$ is decreasing on $(0,+\infty)$ and $\int_{0}^{+\infty} l(t) d t<+\infty$. Then there exists a Lebesgue measurable subset $V$ of $M$ such that $l(-\psi(z))<$ $l\left(-2 \sum_{1 \leq k<\gamma} q_{j} G_{\Omega}\left(z, z_{j}\right)\right)$ for any $z \in V$ and $\mu(V)>0$, where $\mu$ is the Lebesgue measure on $\Omega$.

Let $Y$ be an $n-1$ dimensional weakly pseudoconvex Kähler manifold. Let $M=$ $\Omega \times Y$ be a complex manifold, and $K_{M}$ be the canonical line bundle on $M$. Let $\pi_{1}$, $\pi_{2}$ be the natural projections from $M$ to $\Omega$ and $Y$. Let $\psi_{1}$ be a subharmonic function on $\Omega$ such that $q_{z_{j}}=\frac{1}{2} v\left(d d^{c} \psi_{1}, z_{j}\right)>0$ for any $z_{j} \in S=\left\{z_{j}: 1 \leq j<\gamma\right\}$, and let $\varphi_{\Omega}$ be a Lebesgue measurable function on $\Omega$ such that $\psi_{1}+\varphi_{\Omega}$ is subharmonic on $\Omega$. Let $\varphi_{Y}$ be a plurisubharmonic function on $Y$. Denote that $\psi:=\pi_{1}^{*}\left(\psi_{1}\right)$, $\varphi:=\pi_{1}^{*}\left(\varphi_{\Omega}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)$. Using the Weierstrass Theorem on open Riemann surfaces (see [14]) and Siu's Decomposition Theorem, we have

where $g_{0}$ is a holomorphic function on $\Omega$ and $u_{0}$ is a subharmonic function on $\Omega$ such that $v\left(d d^{c} u_{0}, z\right) \in[0,1)$ for any $z \in \Omega$.

Let $c(t)$ be a positive measurable function on $(0,+\infty)$ satisfying that $c(t) e^{-t}$ is decreasing and $\int_{0}^{+\infty} c(t) e^{-t} d t<+\infty$. We recall the following optimal $L^{2}$ extension theorem.

2.5. Linearity on fibrations over open Riemann surfaces at inner points. In this section, we recall and present some results about the concavity degenerating to linearity on fibrations over open Riemann surfaces at inner points.

Let $\Omega$ be an open Riemann surface, which admits a nontrival Green function $G_{\Omega}$, and let $K_{\Omega}$ be the canonical (holomorphic) line bundle on $\Omega$. Let $Y$ be an $n-1$ dimensional weakly pseudoconvex Kähler manifold. Let $M=\Omega \times Y$ be a complex manifold, and $K_{M}$ be the canonical line bundle on $M$. Let $\pi_{1}, \pi_{2}$ be the natural projections from $M$ to $\Omega$ and $Y$.

Let $\tilde{Z}_{0}$ be a (closed) analytic subset of $\Omega$ and denote $Z_{0}:=\pi_{1}^{-1}\left(\tilde{Z}_{0}\right)$ be an analytic subset of $M$. Let $\psi_{1}$ be a negative subharmonic function on $\Omega$ such that $\psi_{1}(z)=-\infty$ for any $z \in \tilde{Z}_{0}$, and let $\varphi_{\Omega}$ be a Lebesgue measurable function on $\Omega$ such that $\varphi_{\Omega}+\psi_{1}$ is subharmonic on $\Omega$. Let $\varphi_{Y}$ be a plurisubharmonic function on $Y$. Denote that $\psi:=\pi_{1}^{*}\left(\psi_{1}\right), \varphi=\pi_{1}^{*}\left(\varphi_{\Omega}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)$. Let $c$ be a positive function on $(0,+\infty)$ sucht that $\int_{0}^{+\infty} c(t) e^{-t} d t<+\infty, c(t) e^{-t}$ is decreasing on $(0,+\infty)$ and $e^{-\varphi} c(-\psi)$ has a positive lower bound on any compact subset of $M \backslash \pi_{1}^{-1}(E)$, where $E \subset\left\{\psi_{1}=-\infty\right\}$ is a discrete subset of $\Omega$.

Let $f$ be a holomorphic $(n, 0)$ form on a neighborhood of $Z_{0}$. Denote

Recall some notations related to open Riemann surfaces (see [14, see also [25, [22, (19). Let $P: \Delta \rightarrow \Omega$ be the universal covering from the unite disc $\Delta$ to $\Omega$. The holomorphic function $\hat{f}$ on $\Delta$ is called a multiplicative function, if there is a character $\chi$, which is the representation of the fundamental group of $\Omega$ such that $g^{*}(\hat{f})=\chi(g) \hat{f}$, where $|\chi|=1$ and $g$ is an element of the fundamental group of $\Omega$. Denote the set of such $\hat{f}$ by $\mathcal{O}^{\chi}(\Omega)$.

It is known that for any harmonic function $u$ of $\Omega$, there exists a $\chi_{u}$ and a multiplicative function $f_{u} \in \mathcal{O}^{\chi_{u}}(\Omega)$ such that $\left|f_{u}\right|=P^{*}\left(e^{u}\right)$. If $u_{1}-u_{2}=\log |\hat{f}|$, then $\chi_{u_{1}}=\chi_{u_{2}}$, where $u_{1}$ and $u_{2}$ are harmonic functions on $\Omega$ and $\hat{f}$ is a holomorphic function on $\Omega$. Recall that for the Green function $G_{\Omega}\left(\cdot, z_{0}\right)$, there exists a $\chi_{z_{0}}$ and a multiplicative function $f_{z_{0}} \in \mathcal{O} \chi_{z_{0}}(\Omega)$ such that $\left|f_{z_{0}}(z)\right|=P^{*}\left(e^{G_{\Omega}\left(z, z_{0}\right)}\right)$ (see 41).

Let $\tilde{Z}_{0}=\left\{z_{j}: j \in \mathbb{Z}_{\geq 0} \& 1 \leq j \leq m\right\}$ be a finite subset of the open Riemann surface $\Omega$. Let $w_{j}$ be a local coordinate on a neighborhood $V_{z_{j}} \subset \subset \Omega$ of $z_{j}$ satisfying $w_{j}\left(z_{j}\right)=0$ for $z_{j} \in \tilde{Z}_{0}$, where $V_{z_{j}} \cap V_{z_{k}}=\emptyset$ for any $j \neq k$. Denote that $V_{0}:=$ $\bigcup_{1 \leq j \leq m} V_{z_{j}}$. Without loss of generality, assume that $w_{j}\left(V_{z_{j}}\right)=\left\{w \in \mathbb{C}:|w|<r_{j}\right\}$, where $r_{j}>0$. Let $f$ be a holomorphic $(n, 0)$ form on $V_{0} \times Y$. Theorem 2.12 implies that $G\left(h^{-1}(r)\right)$ is concave with respect to $r$, where $h(t)=\int_{t}^{+\infty} c(s) e^{-s} d s$. We recall a characterization of the concavity of $G\left(h^{-1}(r)\right)$ degenerating to linearity for the fibers over sets of finite points as follows.

Theorem 2.30 (1). Assume that $e^{-\varphi} c(-\psi)$ has a positive lower bound on any compact subset of $M \backslash Z_{0}, G(0) \in(0,+\infty)$ and $\left(\psi_{1}-2 q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)\right)\left(z_{j}\right)>-\infty$, where $q_{z_{j}}=\frac{1}{2} v\left(d d^{c}\left(\psi_{1}\right), z_{j}\right)>0$ for any $j \in\{1,2, \ldots, m\}$. Then $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(t) e^{-t} d t\right]$ if and only if the following statements hold:
(1) $\psi_{1}=2 \sum_{j=1}^{m} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$;
(2) for any $j \in\{1,2, \ldots, m\}, f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $V_{z_{j}} \times Y$, where $a_{j} \in \mathbb{C} \backslash\{0\}$ is a constant, $k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic $(n-1,0)$ form on $Y$ such that $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j},\left(z_{j}, y\right)\right) \in \mathcal{O}\left(K_{M}\right)_{\left(z_{j}, y\right)} \otimes$ $\mathcal{I}(\varphi+\psi)_{\left(z_{j}, y\right)}$ for any $j \in\{1,2, \ldots, m\}$ and $y \in Y$;
(3) $\varphi_{\Omega}+\psi_{1}=2 \log |g|+2 \sum_{j=1}^{m} G_{\Omega}\left(\cdot, z_{j}\right)+2 u$, where $g$ is a holomorphic function on $\Omega$ such that $\operatorname{ord}_{z_{j}}(g)=k_{j}$ and $u$ is a harmonic function on $\Omega$;
(4) $\prod_{j=1}^{m} \chi_{z_{j}}=\chi_{-u}$, where $\chi_{-u}$ and $\chi_{z_{j}}$ are the characters associated to the functions $-u$ and $G_{\Omega}\left(\cdot, z_{j}\right)$ respectively;
(5) for any $j \in\{1,2, \ldots, m\}$,

We give a generalization of Theorem 2.30, which will be used in the proofs of Proposition 3.2 and Theorem 1.2

Proposition 2.32. Let $G(0) \in(0,+\infty)$ and $q_{z_{j}}=\frac{1}{2} v\left(d d^{c}\left(\psi_{1}\right), z_{j}\right)>0$ for any $j \in\{1,2, \ldots, m\}$. For any $j \in\{1,2, \ldots, m\}$, assume that one of the following conditions holds:
(A) $\varphi_{\Omega}+a \psi_{1}$ is subharmonic near $z_{j}$ for some $a \in[0,1)$;
(B) $\left(\psi_{1}-2 q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)\right)\left(z_{j}\right)>-\infty$.

Then $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(t) e^{-t} d t\right]$ if and only if the following statements hold:
(1) $\psi_{1}=2 \sum_{j=1}^{m} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$;
(2) for any $j \in\{1,2, \ldots, m\}, f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $V_{z_{j}} \times Y$, where $a_{j} \in \mathbb{C} \backslash\{0\}$ is a constant, $k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic $(n-1,0)$ form on $Y$ such that $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j},\left(z_{j}, y\right)\right) \in \mathcal{O}\left(K_{M}\right)_{\left(z_{j}, y\right)} \otimes$ $\mathcal{I}(\varphi+\psi)_{\left(z_{j}, y\right)}$ for any $j \in\{1,2, \ldots, m\}$ and $y \in Y$;
(3) $\varphi_{\Omega}+\psi_{1}=2 \log \left|g_{1}\right|$, where $g_{1}$ is a holomorphic function on $\Omega$ such that $\operatorname{ord}_{z_{j}}\left(g_{1}\right)=k_{j}+1$ for any $j \in\{1,2, \ldots, m\}$;
(4) $\frac{\operatorname{ord}_{z_{j}}\left(g_{1}\right)}{q_{z_{j}}} \lim _{z \rightarrow z_{j}} \frac{a_{j} w_{j}^{k_{j}} d w_{j}}{d g_{1}}=c_{0}$ for any $j \in\{1,2, \ldots, m\}$, where $c_{0} \in \mathbb{C} \backslash\{0\}$ is a constant independent of $j$.

Proof. The sufficiency follows from Theorem 2.30 and Remark 2.31. Thus, we just need to prove the necessity. It follows form Theorem 2.30 and Remark 2.31 that it suffices to prove $\psi_{1}=2 \sum_{j=1}^{m} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$.

It follows from Corollary 2.13 that there exists a holomorphic $(n, 0)$ form $F$ on $M$ satisfying $(F-f, p) \in\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}(\varphi+\psi)\right)_{p}$ for any $p \in Z_{0}$,

It follows from Lemma 2.29 that $\tilde{k}_{j}+1-k_{j}=0$ for any $j \in I_{F}, \int_{Y}\left|F_{j, l}\right|^{2} e^{-\varphi_{Y}}<+\infty$ for any $j, l$, and

\end{equation*}

Note that $\left|w_{j}^{l}\right|^{2} e^{-\varphi_{\Omega}-\psi_{1}}$ is integrable near $z_{j}$ for any $l \geq k_{j}$ and any $j \in\{1,2, \ldots, m\}$, hence it follows from Lemma 2.17that $\left(\sum_{l \geq k_{j}} \pi_{1}^{*}\left(w_{j}^{l} d w_{j}\right) \wedge \pi_{2}^{*}\left(F_{j, l}\right), p\right) \in\left(\mathcal{O}\left(K_{M}\right) \otimes\right.$ $\mathcal{I}(\varphi+\psi))_{p}$ for any $p \in Z_{0}$. Denote that $\tilde{\psi}_{1}:=2 \sum_{j=1}^{m} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$ and $\tilde{\varphi}_{\Omega}:=$ $\varphi_{\Omega}+\psi_{1}-\tilde{\psi}_{1}$. Note that $\tilde{\psi}_{1} \geq \psi_{1}, \tilde{\varphi}_{\Omega}+\tilde{\psi}_{1}=\varphi_{\Omega}+\psi_{1}$ and $c(t) e^{-t}$ is decreasing on $(0,+\infty)$. Using Theorem 2.28, there exists a holomorphic $(n, 0)$ form $\tilde{F}$ on $M$, such that $(\tilde{F}-F, p) \in\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}\left(\pi_{1}^{*}\left(\tilde{\varphi}_{\Omega}+\tilde{\psi}_{1}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)\right)\right)_{p}=\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}(\varphi+\psi)\right)_{p}$ for any $p \in Z_{0}$ and

G(0) & \leq \int_{M}|\tilde{F}|^{2} e^{-\varphi} c(-\psi) \\
& \leq \int_{M}|\tilde{F}|^{2} e^{-\pi_{1}^{*}\left(\tilde{\varphi}_{\Omega}\right)-\pi_{2}^{*}\left(\varphi_{Y}\right)} c\left(-\pi_{1}^{*}\left(\tilde{\psi}_{1}\right)\right)  \tag{2.37}\\
& \leq\left(\int_{0}^{+\infty} c(s) e^{-s} d s\right) \sum_{j \in I_{F}} \frac{2 \pi e^{-2 u_{0}\left(z_{j}\right)}}{q_{z_{j}}\left|d_{j}\right|^{2}} \int_{Y}\left|\tilde{F}_{j}\right|^{2} e^{-\varphi_{Y}} .
\end{align*}
$$

Combining equality (2.35), inequality (2.36) and inequality (2.37), we obtain that

As $\tilde{F} \not \equiv 0$, it follows from Lemma 2.27 that $\psi_{1}=\tilde{\psi}_{1}=2 \sum_{j=1}^{m} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$.
Thus, Proposition 2.32 holds.
Let $\tilde{Z}_{0}=\left\{z_{j}: j \in \mathbb{Z}_{\geq 1}\right\}$ be an infinite discrete subset of the open Riemann surface $\Omega$. Let $w_{j}$ be a local coordinate on a neighborhood $V_{z_{j}} \subset \subset \Omega$ of $z_{j}$ satisfying $w_{j}\left(z_{j}\right)=0$ for $z_{j} \in \tilde{Z}_{0}$, where $V_{z_{j}} \cap V_{z_{k}}=\emptyset$ for any $j \neq k$. Without loss of generality, assume that $w_{j}\left(V_{z_{j}}\right)=\left\{w \in \mathbb{C}:|w|<r_{j}\right\}$, where $r_{j}>0$. Denote that $V_{0}:=\bigcup_{j=1}^{\infty} V_{z_{j}}$. Let $f$ be a holomorphic $(n, 0)$ form on $V_{0} \times Y$. We recall a
necessary condition such that $G\left(h^{-1}(r)\right)$ is linear for the fibers over infinite analytic subsets as follows.

Proposition 2.33 (1). Assume that $e^{-\varphi} c(-\psi)$ has a positive lower bound on any compact subset of $M \backslash Z_{0}, G(0) \in(0,+\infty)$ and $\left(\psi_{1}-2 q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)\right)\left(z_{j}\right)>-\infty$, where $q_{z_{j}}=\frac{1}{2} v\left(d d^{c}\left(\psi_{1}\right), z_{j}\right)>0$ for any $j \in \mathbb{Z}_{\geq 1}$. Assume that $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(t) e^{-t} d t\right]$, then the following statements hold:
(1) $\psi_{1}=2 \sum_{j=1}^{\infty} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$;
(2) for any $j \in \mathbb{Z}_{\geq 1}, f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $V_{z_{j}} \times Y$, where $a_{j} \in \mathbb{C} \backslash$ $\{0\}$ is a constant, $k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic $(n-1,0)$ form on $Y$ such that $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j},\left(z_{j}, y\right)\right) \in \mathcal{O}\left(K_{M}\right)_{\left(z_{j}, y\right)} \otimes \mathcal{I}(\varphi+\psi)_{\left(z_{j}, y\right)}$ for any $j \in \mathbb{Z}_{\geq 1}$ and $y \in Y$;
(3) $\varphi_{\Omega}+\bar{\psi}_{1}=2 \log |g|$, where $g$ is a holomorphic function on $\Omega$ such that $\operatorname{ord}_{z_{j}}(g)=k_{j}+1$ for any $j \in \mathbb{Z}_{\geq 1}$;
(4) for any $j \in \mathbb{Z}_{\geq 1}$,

\frac{q_{z_{j}}}{\operatorname{ord}_{z_{j}}(g)} \lim _{z \rightarrow z_{j}} \frac{d g}{a_{j} w_{j}^{k_{j}} d w_{j}}=c_{0}

where $c_{0} \in \mathbb{C} \backslash\{0\}$ is a constant independent of $j$;
(5) $\sum_{j \in \mathbb{Z}} q_{1} q_{z_{j}}<+\infty$.

We give a generalization of Proposition 2.33, which will be used in the proof of Proposition 3.2

Proposition 2.34. Let $G(0) \in(0,+\infty)$ and $q_{z_{j}}=\frac{1}{2} v\left(d d^{c}\left(\psi_{1}\right), z_{j}\right)>0$ for any $j \in \mathbb{Z}_{\geq 1}$. For any $j \in \mathbb{Z}_{\geq 1}$, assume that one of the following conditions holds:
(A) $\varphi_{\Omega}+a \psi_{1}$ is subharmonic near $z_{j}$ for some $a \in[0,1)$;
(B) $\left(\psi_{1}-2 q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)\right)\left(z_{j}\right)>-\infty$.

If $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(t) e^{-t} d t\right]$, then the following statements hold:
(1) $\psi_{1}=2 \sum_{j=1}^{\infty} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$;
(2) for any $j \in \mathbb{Z}_{\geq 1}, f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $V_{z_{j}} \times Y$, where $a_{j} \in \mathbb{C} \backslash$ $\{0\}$ is a constant, $k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic $(n-1,0)$ form on $Y$ such that $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j},\left(z_{j}, y\right)\right) \in \mathcal{O}\left(K_{M}\right)_{\left(z_{j}, y\right)} \otimes \mathcal{I}(\varphi+\psi)_{\left(z_{j}, y\right)}$ for any $j \in \mathbb{Z}_{\geq 1}$ and $y \in Y$;
(3) $\varphi_{\Omega}+\psi_{1}=2 \log |g|$, where $g$ is a holomorphic function on $\Omega$ such that $\operatorname{ord}_{z_{j}}(g)=k_{j}+1$ for any $j \in \mathbb{Z}_{\geq 1}$;
(4) for any $j \in \mathbb{Z}_{\geq 1}$,

\frac{q_{z_{j}}}{\operatorname{ord}_{z_{j}}(g)} \lim _{z \rightarrow z_{j}} \frac{d g}{a_{j} w_{j}^{k_{j}} d w_{j}}=c_{0}
$$

where $c_{0} \in \mathbb{C} \backslash\{0\}$ is a constant independent of $j$;
(5) $\sum_{j \in \mathbb{Z}_{\geq 1}} q_{z_{j}}<+\infty$.

Proof. The proof of Proposition 2.34 is similar to Proposition 2.32

It follows form Proposition 2.33 that it suffices to prove $\psi_{1}=2 \sum_{j=1}^{+\infty} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$.
It follows from Corollary 2.13 that there exists a holomorphic $(n, 0)$ form $F$ on $M$ satisfying $(F-f, p) \in\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}(\varphi+\psi)\right)_{p}$ for any $p \in Z_{0}$,

for any nonnegative measurable function $a(t)$ on $(0,+\infty)$. It follows from Lemma 2.7 that $F=\sum_{l \geq \tilde{k}_{j}} \pi_{1}^{*}\left(w_{j}^{l} d w_{j}\right) \wedge \pi_{2}^{*}\left(F_{j, l}\right)$ on $V_{z_{j}} \times Y$ for any $j \in \mathbb{Z}_{\geq 1}$, where $\tilde{k}_{j}$ is a nonnegative integer and $F_{j, l}$ is a holomorphic $(n-1,0)$ form on $Y$ satisfying that $\tilde{F}_{j}:=F_{j, \tilde{k}_{j}} \not \equiv 0$. Denote that

I_{F}:=\left\{j: j \in \mathbb{Z}_{\geq 1} \& \tilde{k}_{j}+1-k_{j} \leq 0\right\}
$$

Using the Weierstrass Theorem on open Riemann surfaces (see [14]) and Siu's Decomposition Theorem, we have

$$

where $g_{0}$ is a holomorphic function on $\Omega$ and $u_{0}$ is a subharmonic function on $\Omega$ such that $v\left(d d^{c} u_{0}, z\right) \in[0,1)$ for any $z \in \Omega$. There exists a nonnegative integer $k_{j}$ such that $d_{j}:=\lim _{z \rightarrow z_{j}} \frac{g_{0}(z)}{w_{j}^{k_{j}}(z)} \in \mathbb{C} \backslash\{0\}$. It follows from Lemma 2.29 that $\tilde{k}_{j}+1-k_{j}=0$ for any $j \in I_{F}, \int_{Y}\left|F_{j, l}\right|^{2} e^{-\varphi_{Y}}<+\infty$ for any $j, l$, and

\sum_{j \in I_{F}} \frac{2 \pi e^{-2 u_{0}\left(z_{j}\right)}}{q_{z_{j}}\left|d_{j}\right|^{2}} \int_{Y}\left|\tilde{F}_{j}\right|^{2} e^{-\varphi_{Y}} \leq \frac{G(0)}{\int_{0}^{+\infty} c(s) e^{-s} d s} \tag{2.39}

Note that $\left|w_{j}^{l}\right|^{2} e^{-\varphi_{\Omega}-\psi_{1}}$ is integrable near $z_{j}$ for any $l \geq k_{j}$ and any $j \in \mathbb{Z}_{\geq 1}$, hence it follows from Lemma2.17 that $\left(\sum_{l \geq k_{j}} \pi_{1}^{*}\left(w_{j}^{l} d w_{j}\right) \wedge \pi_{2}^{*}\left(F_{j, l}\right), p\right) \in\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}(\varphi+\right.$ $\psi))_{p}$ for any $p \in Z_{0}$. Denote that $\tilde{\psi}_{1}:=2 \sum_{j=1}^{+\infty} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$ and $\tilde{\varphi}_{\Omega}:=\varphi_{\Omega}+\psi_{1}-\tilde{\psi}_{1}$. Note that $\tilde{\psi}_{1} \geq \psi_{1}, \tilde{\varphi}_{\Omega}+\tilde{\psi}_{1}=\varphi_{\Omega}+\psi_{1}$ and $c(t) e^{-t}$ is decreasing on $(0,+\infty)$. Using Theorem 2.28, there exists a holomorphic $(n, 0)$ form $\tilde{F}$ on $M$, such that $(\tilde{F}-F, p) \in\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}\left(\pi_{1}^{*}\left(\tilde{\varphi}_{\Omega}+\tilde{\psi}_{1}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)\right)\right)_{p}=\left(\mathcal{O}\left(K_{M}\right) \otimes \mathcal{I}(\varphi+\psi)\right)_{p}$ for any $p \in Z_{0}$ and

$$
\begin{align*}
G(0) & \leq \int_{M}|\tilde{F}|^{2} e^{-\varphi} c(-\psi) \\
& \leq \int_{M}|\tilde{F}|^{2} e^{-\pi_{1}^{*}\left(\tilde{\varphi}_{\Omega}\right)-\pi_{2}^{*}\left(\varphi_{Y}\right)} c\left(-\pi_{1}^{*}\left(\tilde{\psi}_{1}\right)\right)  \tag{2.40}\\
& \leq\left(\int_{0}^{+\infty} c(s) e^{-s} d s\right) \sum_{j \in I_{F}} \frac{2 \pi e^{-2 u_{0}\left(z_{j}\right)}}{q_{z_{j}}\left|d_{j}\right|^{2}} \int_{Y}\left|\tilde{F}_{j}\right|^{2} e^{-\varphi_{Y}} .
\end{align*}
$$

Combining equality (2.38), inequality (2.39) and inequality (2.40), we obtain that

As $\tilde{F} \not \equiv 0$, it follows from Lemma 2.27 that $\psi_{1}=\tilde{\psi}_{1}=2 \sum_{j=1}^{+\infty} q_{z_{j}} G_{\Omega}\left(\cdot, z_{j}\right)$.
Thus, Proposition 2.34 holds.

## 3. A NECESSARY CONDITION FOR $G\left(h^{-1}(r)\right)$ IS LINEARITY

Let $\Omega$ be an open Riemann surface, which admits a nontrivial Green function $G_{\Omega}$. Let $Y$ be an $n-1$ dimensional weakly pseudoconvex Kähler manifold, and let $K_{Y}$ be the canonical line bundle on $Y$. Let $M=\Omega \times Y$ be an $n$-dimensional complex manifold. Let $\pi_{1}$ and $\pi_{2}$ be the natural projections from $M$ to $\Omega$ and $Y$ respectively. Let $K_{M}$ be the canonical line bundle on $M$.

Let $\psi$ be a subharmonic function on $\Omega$. Let $\varphi_{\Omega}$ be a Lebesgue measurable function on $\Omega$ such that $\varphi_{\Omega}+\psi$ is subharmonic function on $\Omega$. Let $F$ be a holomorphic function on $\Omega$. Let $T \in[-\infty,+\infty)$. Denote that

\tilde{\Psi}:=\min \{\psi-2 \log |F|,-T\}
$$

For any $z \in \Omega$ satisfying $F(z)=0$, we set $\tilde{\Psi}(z)=-T$. Denote that $\Psi:=\pi_{1}^{*}(\tilde{\Psi})$ on $M$. Let $\varphi_{Y}$ be a plurisubharmonic function on $Y$. Denote that $\varphi:=\pi_{1}^{*}\left(\varphi_{\Omega}\right)+$ $\pi_{2}^{*}\left(\varphi_{Y}\right)$.

Let $Z_{0} \subset M$ be a subset of $\cap_{t>T} \overline{\{\Psi<-t\}}$ such that there exists a subset $\tilde{Z}_{0}$ of $\Omega$ such that $Z_{0}=\tilde{Z}_{0} \times Y$. Denote that $\tilde{Z}_{1}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right) \geq 2 \operatorname{ord}_{z}(F)\right\}$ and $\tilde{Z}_{2}:=\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right)<2 \operatorname{ord}_{z}(F)\right\}$, where $d^{c}=\frac{\partial-\bar{\partial}}{2 \pi \sqrt{-1}}$ and $v\left(d d^{c}(\psi), z\right)$ is the Lelong number of $d d^{c}(\psi)$ at $z$ (see [8]). Denote that $\tilde{Z}_{3}:=\left\{z \in \tilde{Z}_{0}\right.$ : $\left.v\left(d d^{c}(\psi), z\right)>\operatorname{ord}_{z}(F)\right\}$. Note that $\{\tilde{\Psi}<-t\} \cup \tilde{Z}_{3}$ is an open Riemann surface for any $t \geq T$. Denote $Z_{1}:=\tilde{Z}_{1} \times Y, Z_{2}:=\tilde{Z}_{2} \times Y$ and $Z_{3}:=\tilde{Z}_{3} \times Y$ respectively.

Let $c(t)$ be a positive function on $(0,+\infty)$ such that $c(t) e^{-t}$ is decreasing on $(T,+\infty), c(t) e^{-t}$ is integrable near $+\infty$, and $c(-\Psi) e^{-\varphi}$ has a positive lower bound on $K \cap\{\Psi<-T\}$ for any compact subset $K \subset M \backslash \pi_{1}^{-1}(E)$, where $E$ is an analytic subset of $\Omega$ such that $E \subset\{\tilde{\Psi}=-\infty\}$.

Let $f$ be a holomorphic $(n, 0)$ form on $\left\{\Psi<-t_{0}\right\} \cap V$, where $V \supset Z_{0}$ is an open subset of $M$ and $t_{0}>T$ is a real number. Denote

$$
\begin{align*}
& \inf \left\{\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi): \tilde{f} \in H^{0}\left(\{\Psi<-t\}, \mathcal{O}\left(K_{M}\right)\right)\right. \\
& \left.\qquad \&(\tilde{f}-f)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p} \text { for any } p \in Z_{0}\right\} \tag{3.1}
\end{align*}
$$

by $G(t ; c, \Psi, \varphi, I(\varphi+\Psi), f)$, where $t \in[T,+\infty)$. Without misunderstanding, we denote $G(t ; c, \Psi, \varphi, I(\varphi+\Psi), f)$ by $G(t)$ for simplicity.

Note that there exists a subharmonic function $\psi_{1}$ on $\Omega_{1}:=\{\tilde{\Psi}<-T\} \cup \tilde{Z}_{3}$ such that $\psi_{1}+2 \log |F|=\psi$. Denote that $M^{\prime}:=\Omega_{1} \times Y \subset M$ and $\tilde{\psi}:=\pi_{1}^{*}\left(\psi_{1}\right)$.

For any $z \in \Omega_{1}$, if $F(z)=0$, for any $y \in Y$, we have $\Psi((z, y)) \neq-\infty$, then we know that $e^{-\varphi} c(-\Psi)=e^{-\varphi} c(-\tilde{\psi})$ has a positive lower bound on $K \backslash(\{z\} \times$ $Y) \subset K \cap\{\Psi<-T\}$, where $K \Subset M$ is a neighborhood of $(z, y)$. Combining $e^{-\varphi} c(-\tilde{\psi}) \leq C e^{-\varphi-\tilde{\psi}}=C e^{-\pi_{1}^{*}\left(\varphi_{\Omega}+\psi-2 \log |F|\right)-\pi_{2}^{*}\left(\varphi_{Y}\right)}$ on $K$, we have $v\left(d d^{c}\left(\varphi_{\Omega}+\right.\right.$ $\psi), z) \geq 2 \operatorname{ord}_{z}(F)$. Hence we have $\varphi_{\Omega}+\psi_{1}$ is a subharmonic function on $\Omega_{1}$.

For any $z \in \tilde{Z}_{3}$, if $F(z) \neq 0$, we know that $I(\varphi+\Psi)_{(z, y)}=\mathcal{I}(\varphi+\tilde{\psi})_{(z, y)}$ is an ideal of $\mathcal{O}_{M,(z, y)}$ for any $y \in Y$. For any $z \in \tilde{Z}_{3}$, if $F(z)=0$, we know that
$h_{(z, y)} \in I(\varphi+\Psi)_{(z, y)}$ if and only if there exists a holomorphic extension $\tilde{h}$ of $h$ near $(z, y)$ such that $(\tilde{h},(z, y)) \in \mathcal{I}(\varphi+\tilde{\psi})_{(z, y)}$, where $y \in Y$ and $h_{(z, y)} \in I(\varphi+\Psi)_{(z, y)}$.

Let $f_{1}$ be a holomorphic $(n, 0)$ form on $V_{1}$, where $V_{1} \supset Z_{3}$ is an open subset of $M^{\prime}$. Denote

by $G_{f_{1}}(t)$, where $t \in[\underset{\sim}{T},+\infty)$.
Note that $e^{-\varphi} c(-\tilde{\psi})$ has a positive lower bound on any compact subset of $M^{\prime} \backslash\left(\pi_{1}^{-1}\left(E \cup \tilde{Z}_{3}\right)\right)$ and $E \cup \tilde{Z}_{3} \subset\left\{\psi_{1}=-\infty\right\}$. Let $f_{2}$ be a holomorphic $(n, 0)$ form on $V \cap\left(\left\{\Psi<-t_{0}\right\} \cup Z_{3}\right)=V \cap\left\{\tilde{\psi}<-t_{0}\right\}$ such that $\left(f_{2}\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes H_{p}$ for any $p \in Z_{0}$, where $H_{p}=\left\{h_{p} \in J(\Psi)_{p}: \int_{\{\Psi<-t\} \cap U}|h|^{2} e^{-\varphi} c(-\Psi) d V_{M}<+\infty\right.$ for some $t>T$ and some neighborhood $U$ of $p\}, d V_{M}$ is a continuous volume form on $M, V \supset Z_{0}$ is an open subset of $M$ and $t_{0}>T$ is a real number. Theorem 2.12 shows that $G\left(h^{-1}(r) ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right)$ and $G_{f_{2}}\left(h^{-1}(r)\right)$ are concave with respect to $r$, where $h(t)=\int_{t}^{+\infty} c(s) e^{-s} d s$. We give a relationship between $G\left(h^{-1}(r) ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right)$ and $G_{f_{2}}\left(h^{-1}(r)\right)$, which will be used in the proof of Proposition 3.2

Lemma 3.1. If $H_{p}=I(\varphi+\Psi)_{p}$ for any $p \in Z_{0} \backslash Z_{3}$, then $G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right)=$ $\tilde{G}_{f_{2}}(t)$ for any $t \geq T$.

Proof. For any $t \geq T$ and holomorphic $(n, 0)$ form $\tilde{f}$ on $\{\tilde{\psi}<-t\}$ satisfying ( $\tilde{f}-$ $\left.f_{2}, p\right) \in \mathcal{O}\left(K_{M}\right)_{p} \otimes \mathcal{I}(\varphi+\tilde{\psi})_{p}$ for any $p \in Z_{3}$ and $\int_{\{\tilde{\psi}<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\tilde{\psi})<+\infty$, it follows from $\left(f_{2}\right)_{p \sim} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes H_{p}$ for any $p \in Z_{0}$ and $H_{p}=I(\varphi+\Psi)_{p}$ for any $p \in Z_{0} \backslash Z_{3}$ that $\left(\tilde{f}-f_{2}\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $z \in Z_{0}$. As $\mu\left(Z_{3}\right)=0$, where $\mu$ is the Lebesgue measure on $M$, the definitions of $G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right)$ and $G_{f_{2}}(t)$ show that $G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right) \leq \tilde{G}_{f_{2}}(t)$ for any $t \geq T$.

For any $t \geq T$, let $\tilde{f}$ be a holomorphic ( $n, 0$ ) form on $\{\Psi<-t\}$ satisfying $\left(\tilde{f}-f_{2}\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $z \in Z_{0}$ and $\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi)<+\infty$. For any $p=(z, y) \in Z_{3} \backslash\{\Psi<-t\}$, we have $F(z)=0$. Note that $v\left(d d^{c}(\psi), z\right)>$ $2 \operatorname{ord}_{z}(F)$, then $e^{-\varphi} c(-\Psi)$ has a positive lower bound on $K \backslash(\{z\} \times Y) \subset\{\Psi<-t\}$, where $K \Subset M$ is a neighborhood of $(z, y)$. Following from $\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi)<$ $+\infty$, we get that there exists a holomorphic $(n, 0)$ form $\tilde{f}_{1}$ on $\{\tilde{\psi}<-t\}=\{\Psi<$ $-t\} \cup Z_{3}$ such that $\tilde{f}_{1}=\tilde{f}$ on $\{\Psi<-t\}$, which implies that $\left(\tilde{f}_{1}-f_{2}, p\right) \in \mathcal{O}\left(K_{M}\right)_{p} \otimes$ $\mathcal{I}(\varphi+\tilde{\psi})_{p}$ for any $p \in Z_{3}$ and $\int_{\{\tilde{\psi}<-t\}}\left|\tilde{f}_{1}\right|^{2} e^{-\varphi} c(-\tilde{\psi})=\int_{\{\Psi<-t\}}|\tilde{f}|^{2} e^{-\varphi} c(-\Psi)$. By the definitions of $G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), f_{2}\right)$ and $G_{f_{2}}(t)$, we have $G(t ; c, \Psi, \varphi, I(\varphi+$ $\left.\Psi), f_{2}\right) \geq \tilde{G}_{f_{2}}(t)$ for any $t \geq T$.

Thus, Lemma 3.1 holds.
Note that $\tilde{Z}_{3}$ is a discrete subset of $\Omega$. Let $\tilde{Z}_{3}=\left\{z_{j}: 1 \leq j<\gamma\right\}$, where $\gamma \in \mathbb{Z}_{\geq 2} \cup\{+\infty\}$. Let $w_{j}$ be a local coordinate on a neighborhood $V_{z_{j}} \Subset \Omega$ of $z_{j}$ satisfying that $w_{j}\left(z_{j}\right)=0$ for any $z_{j} \in \tilde{Z}_{3}$, where $V_{z_{j}} \cap V_{z_{k}}=\emptyset$ for any $j \neq k$. We give a necessary condition for the concavity of $G\left(h^{-1}(r)\right)$ degenerating to linearity.

Proposition 3.2. For any $z \in \tilde{Z}_{1}$, assume that one of the following conditions holds:
(A) $\varphi_{\Omega}+a \psi$ is subharmonic near $z$ for some $a \in[0,1)$;
(B) $\left(\psi-2 q_{z} \log |w|\right)(z)>-\infty$, where $q_{z}=\frac{1}{2} v\left(d d^{c}(\psi), z\right)$ and $w$ is a local coordinate on a neighborhood of $z$ satisfying that $w(z)=0$.

If there exists $t_{1} \geq T$ such that $G\left(t_{1}\right) \in(0,+\infty)$ and $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{T}^{+\infty} c(s) e^{-s} d s\right)$, then the following statements hold:
(1) $f=\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)+f_{j}$ on $\left(V_{z_{j}} \times Y\right) \cap\left\{\Psi<-t_{0}\right\} \cap V$, where $a_{j} \in \mathbb{C} \backslash\{0\}, k_{j}$ is a nonnegative integer, $f_{Y}$ is a holomorphic $(n-1,0)$ form on $Y$ satisfying $\int_{Y}\left|f_{Y}\right|^{2} e^{-\varphi_{Y}} \in(0,+\infty)$, and $\left(f_{j}\right)_{p} \in \mathcal{O}\left(K_{\Omega}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in\left\{z_{j}\right\} \times Y$;
(2) $\varphi_{\Omega}+\psi=2 \log |g|+2 \log |F|$, where $g$ is a holomorphic function on $\{\tilde{\Psi}<$ $-T\} \cup \tilde{Z}_{3} \subset \Omega$ such that $\operatorname{ord}_{z_{j}}(g)=k_{j}+1$ for any $1 \leq j<\gamma$;
(3) $\tilde{Z}_{3} \neq \emptyset$ and $\psi=2 \sum_{\tilde{w}_{1 \leq j<\gamma}}\left(q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)\right) G_{\Omega_{t}}\left(\cdot, z_{j}\right)+2 \log |F|-t$ on $\Omega_{t}$ for any $t \geq T$, where $\Omega_{t}=\{\tilde{\Psi}<-t\} \cup \tilde{Z}_{3} \subset \Omega$ and $G_{\Omega_{t}}$ is the Green function on $\Omega_{t}$;
(4) $\frac{q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)}{\text { ord }_{z_{j}}(g)} \lim _{z \rightarrow z_{j}} \frac{d g}{a_{j} w_{j}^{k_{j}} d w_{j}}=c_{0}$ for any $1 \leq j<\gamma$, where $c_{0} \in \mathbb{C} \backslash\{0\}$ is a constant independnet of $j$;
(5) $\sum_{1 \leq j<\gamma}\left(q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)\right)<+\infty$.

Proof. It follows from Remark 2.14 that we can assume that $c(t) \geq \frac{e^{t}}{t^{2}}$ near $+\infty$. Lemma 2.21 shows that $H_{p}=I(\varphi+\Psi)_{p}$ for any $p \in Z_{1} \backslash Z_{3}$.

For any $z_{0} \in \tilde{Z}_{2}$, it follows from Lemma 2.20 and the following remark that $H_{p}=I(\varphi+\Psi)_{p}$ for any $p \in\left\{z_{0}\right\} \times Y$.

Remark 3.3. Let $b \in(0,1)$. Let $\tilde{\varphi}_{\Omega}=\varphi_{\Omega}+b(\psi-2 \log |F|)$ and $\tilde{\psi}=(1-b) \psi+$ $2 b \log |F|$. Denote that $\tilde{\Psi}:=\min \left\{\pi_{1}^{*}(\tilde{\psi}-2 \log |F|),(1-b) T\right\}=(1-b) \Psi$. Let $\tilde{c}(t)=c\left(\frac{t}{1-b}\right) e^{-\frac{b t}{1-b}}$ be a function on $((1-b) T,+\infty)$, and we have $\tilde{c}(t) \geq 1$ near $+\infty$. It is clear that $\tilde{\psi}$ and $\tilde{\varphi}_{\Omega}+\tilde{\psi}=\varphi_{\Omega}+\psi$ are subharmonic functions. Denote that $\tilde{\varphi}:=\pi_{1}^{*}\left(\tilde{\varphi}_{\Omega}\right)+\pi_{2}^{*}\left(\varphi_{Y}\right)$.

Note that $e^{-\tilde{\varphi}} \tilde{c}(-\tilde{\Psi})=e^{-\pi_{1}^{*}\left(\varphi_{\Omega}+b(\psi-2 \log |F|)\right)-\pi_{2}^{*}\left(\varphi_{Y}\right)} c(-\Psi) e^{b \Psi}=e^{-\varphi} c(-\Psi)$ on $\{\Psi<-T\}, \varphi+\Psi=\tilde{\varphi}+\tilde{\Psi}$ on $\{\Psi<-t\}$ and $\tilde{c}(t) e^{-t}=c\left(\frac{t}{1-b}\right) e^{-\frac{t}{1-b}}$. As $z_{0} \in \tilde{Z}_{2}=\left\{z \in \tilde{Z}_{0}: \operatorname{ord}_{z}(F)>v\left(d d^{c}(\psi), z\right)\right\}$, we can choose $b \in(0,1)$ such that $v\left(d d^{c}(\tilde{\psi}), z_{0}\right)+v\left(d d^{c}\left(\tilde{\varphi}_{\Omega}+\tilde{\psi}\right), z_{0}\right)=v\left(d d^{c}(\psi), z_{0}\right)+v\left(d d^{c}\left(\varphi_{\Omega}+\psi\right), z_{0}\right)+$ $b\left(2 \operatorname{ord}_{z_{0}}(F)-v\left(d d^{c}(\psi), z_{0}\right)\right) \notin \mathbb{Z}$.

Note that there exists a subharmonic function $\psi_{1}$ on $\Omega_{1}:=\{\tilde{\Psi}<-T\} \cup \tilde{Z}_{3}$ such that $\psi_{1}+2 \log |F|=\psi$. Denote that $M^{\prime}:=\Omega_{1} \times Y=\{\Psi<-T\} \cup Z_{3} \subset M$ and $\tilde{\psi}:=\pi_{1}^{*}\left(\psi_{1}\right)$. For any $\left(z_{0}, y_{0}\right) \in Z_{3} \backslash\left\{\Psi<-t_{1}\right\}$, we have $F\left(z_{0}\right)=0$. Note that $v\left(d d^{c}(\psi), z_{0}\right)>2 \operatorname{ord}_{z_{0}}(F)$, then $e^{-\varphi} c(-\Psi)$ has a positive lower bound on $\left(V^{\prime} \backslash\left\{z_{0}\right\}\right) \times Y_{0} \subset\{\Psi<-t\}$, where $V^{\prime} \Subset \Omega_{1}$ is a neighborhood of $z_{0}$ and $Y_{0}$ is a neighborhood of $y_{0}$. Following from $\int_{\left\{\Psi<-t_{1}\right\}}\left|f_{t_{1}}\right|^{2} e^{-\varphi} c(-\Psi)<+\infty$, we get that
there exists a holomorphic $(n, 0)$ form $\tilde{f}_{t_{1}}$ on $\left\{\tilde{\psi}<-t_{1}\right\}=\left\{\Psi<-t_{1}\right\} \cup Z_{3}$ such that $\tilde{f}_{t_{1}}=f_{t_{1}}$ on $\left\{\Psi<-t_{1}\right\}$, which implies that $\left(\tilde{f}_{t_{1}}-f\right)_{p} \in \mathcal{O}\left(K_{\Omega}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in Z_{0}$. By the definition of $G(t ; c, \Psi, \varphi, I(\varphi+\Psi), f)$, we have $G(t ; c, \Psi, \varphi, I(\varphi+$ $\Psi), f)=G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), \tilde{f}_{t_{1}}\right)$ for any $t \geq T$. It follows from Lemma 3.1 and $H_{p}=I(\varphi+\Psi)_{p}$ for any $p \in Z_{0} \backslash Z_{3}$ that $G_{\tilde{f}_{t_{1}}}(t)=G\left(t ; c, \Psi, \varphi, I(\varphi+\Psi), \tilde{f}_{t_{1}}\right)$ for any $t \geq T$, which implies that $G_{\tilde{f}_{t_{1}}}\left(h^{-1}(r)\right)$ is linear with respect to $r$. Denote that $\tilde{Z}_{3}^{\prime}:=\left\{z \in \tilde{Z}_{3}: v\left(d d^{c}\left(\varphi_{\Omega}+\psi_{1}\right), z\right)>0\right\}$ and $Z_{3}^{\prime}:=\pi_{1}^{-1}\left(\tilde{Z}_{3}^{\prime}\right)$. Denote

by $\tilde{G}(t)$, where $t \in[T,+\infty)$. For any holomorphic $(n, 0)$ form $\hat{f}$ on $\{\tilde{\psi}<-t\}$ satisfying $\int_{\{\tilde{\psi}<-t\}}|\hat{f}|^{2} e^{-\varphi} c(-\tilde{\psi})<+\infty$ and any $p=\left(z_{0}, y_{0}\right) \in \tilde{Z}_{3} \backslash \tilde{Z}_{3}^{\prime}$, it follows from Lemma 2.7 and Lemma 2.9 that $\left.\hat{f}\right|_{U_{z_{0}} \times Y}=\sum_{j \geq 0} \pi_{1}^{*}\left(w^{j} d w_{j}\right) \wedge \pi_{2}^{*}\left(F_{j}\right)$, where $w$ is a local coordinate on a neighborhood $V_{z_{0}} \Subset\left\{\psi_{1}<-t\right\} \subset \Omega_{1}$ satisfying $w\left(z_{0}\right)=0$ and $U_{z_{0}}=\{|w(z)|<1\} \Subset V_{z_{0}}, F_{j}$ is holomorphic ( $n-1,0$ ) form on $Y$ satisfying $\left(F_{j}, y_{0}\right) \in\left(\mathcal{O}\left(K_{Y}\right) \otimes \mathcal{I}\left(\varphi_{Y}\right)\right)_{y_{0}}$. Note that $\tilde{Z}_{3} \backslash \tilde{Z}_{3}^{\prime}=\left\{z \in \tilde{Z}_{3}: v\left(d d^{c}\left(\varphi_{\Omega}+\psi_{1}\right), z\right)=\right.$ $0\}$, then it follows from Lemma 2.17 that $(\hat{f}, p) \in \mathcal{O}\left(K_{M}\right)_{p} \otimes \mathcal{I}(\varphi+\tilde{\psi})_{p}$. It follows from Proposition 2.32 and Proposition 2.34 (replace $M, \psi, Z_{0}$ and $c(\cdot)$ by $\{\tilde{\psi}<-t\}=$ $\{\Psi<-t\} \cup Z_{3}, \tilde{\psi}+t, Z_{3}^{\prime}$ and $c(\cdot+t)$ respectively, where $\left.t>T\right)$ that the following statements hold:
(a) $\psi_{1}+t=2 \sum_{z \in \tilde{Z}_{3}^{\prime}} q_{z}^{\prime} G_{\Omega_{t}}(\cdot, z)$ on $\Omega_{t}=\left\{\psi_{1}<-t\right\}$ for any $t>T$;

(c) $\varphi_{\Omega}+\psi_{1}=2 \log |g|$, where $g$ is a holomorphic function on $\Omega_{1}=\{\Psi<-T\} \cup \tilde{Z}_{3}$ such that $\operatorname{ord}_{z}(g)=k_{j}+1$ for any $z \in \tilde{Z}_{3}^{\prime}$;
(d) $\frac{q_{z_{j}}^{\prime}}{\operatorname{ord}_{z_{j}}(g)} \lim _{z \rightarrow z_{j}} \frac{d g}{a_{j} w_{j}^{k_{j}} d w_{j}}=c_{0}$ for any $z_{j} \in \tilde{Z}_{3}^{\prime}$, where $c_{0} \in \mathbb{C} \backslash\{0\}$ is a constant independent of $z_{j}$;
(e) $\sum_{z \in \tilde{Z}_{3}^{\prime}} q_{z}^{\prime}<+\infty$.

By definition of $\psi_{1}$, we know that $q_{z}^{\prime}=q_{z}-\operatorname{ord}_{z}(F)$ for any $z \in \Omega_{1}$. It follows from $(a)$, Lemma 2.26 and $\tilde{Z}_{3} \in\left\{z \in \tilde{Z}_{0}: v\left(d d^{c}(\psi), z\right)>2 \operatorname{ord}_{z}(F)\right\}$ that $\tilde{Z}_{3}=$ $\tilde{Z}_{3}^{\prime} \neq \emptyset$ and $\psi=2 \sum_{1 \leq j<\gamma}\left(q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)\right) G_{\Omega_{t}}\left(\cdot, z_{j}\right)+2 \log |F|-t$ on $\Omega_{t}$ for
any $t \geq T$. Note that $\left(\tilde{f}_{t_{1}}-f\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in Z_{0}$, and $\left(\tilde{f}_{j}, p\right) \in \mathcal{O}\left(K_{M}\right)_{p} \otimes \mathcal{I}(\varphi+\tilde{\psi})_{p}$ implies $\left(\tilde{f}_{j}\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $Z_{3}$. Let $f_{j}=f-\pi_{1}^{*}\left(a_{j} w_{j}^{k_{j}} d w_{j}\right) \wedge \pi_{2}^{*}\left(f_{Y}\right)$ on $\left(V_{z_{j}} \times Y\right) \cap\left\{\Psi<-t_{0}\right\} \cap V$, hence $\left(f_{j}\right)_{p}=$ $\left(f-\tilde{f}_{t_{1}}+\tilde{f}_{j}\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in\left\{z_{j}\right\} \times Y$. It follows from (c) and $\psi=\psi_{1}+2 \log |F|$ that $\varphi_{\Omega}+\psi=2 \log |g|+2 \log |F|$.

Thus, the five statements in Proposition 3.2 hold.

## 4. Proof of Theorem 1.2

The necessity of Theorem 1.2 follows from Proposition 3.2. In the following, we prove the sufficiency.

As $\psi=2 \sum_{1 \leq j \leq m}\left(q_{z_{j}}-\operatorname{ord}_{z_{j}}(F)\right) G_{\Omega_{t}}\left(\cdot, z_{j}\right)+2 \log |F|-t$ on $\Omega_{t}$ and $\Psi=$ $\min \left\{\pi_{1}^{*}(\psi-2 \log |F|), T\right\}$, it follows from Lemma 2.25 that

$$
Z_{0}=Z_{0} \cap\left(\cap_{s>T} \overline{\{\Psi<-s\}}\right)=\left\{z_{j}: j \in\{1,2, \ldots, m\}\right\} \times Y=Z_{3}
$$

It follows from Lemma 2.15 that there exists a holomorphic $(n, 0)$ form $f_{t_{1}}$ on $\left\{\Psi<-t_{1}\right\}$ such that $\left(f_{t_{1}}-f\right)_{p} \in \mathcal{O}\left(K_{M}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in Z_{0}$ and $\int_{\left\{\Psi<-t_{1}\right\}}\left|f_{t_{1}}\right|^{2} e^{-\varphi} c(-\Psi)<+\infty$, which implies that $\left(f_{t_{1}}\right)_{p} \in \mathcal{O}\left(K_{\Omega}\right)_{p} \otimes H_{p}$ for any $p \in Z_{0}$, where $t_{1}>0$. Note that there exists a subharmonic function $\psi_{1}$ on $\Omega_{1}:=$ $\{\tilde{\Psi}<-T\} \cup \tilde{Z}_{3}$ such that $\psi_{1}+2 \log |F|=\psi$. Denote that $M^{\prime}:=\Omega_{1} \times Y=\{\Psi<$ $-T\} \cup Z_{3} \subset M$ and $\tilde{\psi}:=\pi_{1}^{*}\left(\psi_{1}\right)$. For any $\left(z_{0}, y_{0}\right) \in Z_{3} \backslash\left\{\Psi<-t_{1}\right\}$, we have $F\left(z_{0}\right)=$ 0 . Note that $v\left(d d^{c}(\psi), z_{0}\right)>2 \operatorname{ord}_{z_{0}}(F)$, then $e^{-\varphi} c(-\Psi)$ has a positive lower bound on $\left(V^{\prime} \backslash\left\{z_{0}\right\}\right) \times Y_{0} \subset\{\Psi<-t\}$, where $V^{\prime} \Subset \Omega_{1}$ is a neighborhood of $z_{0}$ and $Y_{0}$ is a neighborhood of $y_{0}$. Following from $\int_{\left\{\Psi<-t_{1}\right\}}\left|f_{t_{1}}\right|^{2} e^{-\varphi} c(-\Psi)<+\infty$, we get that there exists a holomorphic $(n, 0)$ form $\tilde{f}_{t_{1}}$ on $\left\{\tilde{\psi}<-t_{1}\right\}=\left\{\Psi<-t_{1}\right\} \cup Z_{3}$ such that $\tilde{f}_{t_{1}}=f_{t_{1}}$ on $\left\{\Psi<-t_{1}\right\}$, which implies that $\left(\tilde{f}_{t_{1}}-f\right)_{p} \in \mathcal{O}\left(K_{\Omega}\right)_{p} \otimes I(\varphi+\Psi)_{p}$ for any $p \in Z_{0}$. Following from the definition of $G_{\tilde{f}_{t_{1}}}(t)$ in Section 3, it follows from Lemma 3.1 and $Z_{0}=Z_{3}$ that $G_{\tilde{f}_{t_{1}}}(t)=G(t)$ for any $t \geq T$. Using Proposition 2.32 (replace $M, c(\cdot)$ and $\psi$ by $M^{\prime}, c(\cdot+\tilde{t})$ and $\pi_{1}^{*}\left(\psi_{1}\right)+\tilde{t}$ respectively, where $\tilde{t}>T$ ), we know that $G_{\tilde{f}_{t_{1}}}\left(h_{\tilde{t}}^{-1}(r)+\tilde{t}\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(s+\tilde{t}) e^{-s} d s\right)$ for any $\tilde{t}>T$, where $h_{\tilde{t}}(t)=\int_{t}^{+\infty} c(s+\tilde{t}) e^{-s} d s=e^{\tilde{t}} \int_{t+\tilde{t}}^{+\infty} c(s) e^{-s} d s=e^{\tilde{t}} h(t+\tilde{t})$. Note that $G\left(h^{-1}(r)\right)=G_{\tilde{f}_{t_{1}}}\left(h^{-1}(r)\right)=G_{\tilde{f}_{t_{1}}}\left(h_{\tilde{t}}^{-1}\left(e^{\tilde{t}} r\right)+\tilde{t}\right)$ for any $r \in\left(0, \int_{\tilde{t}}^{+\infty} c(s) e^{-s} d s\right)$. Hence we have $G\left(h^{-1}(r)\right)$ is linear with respect to $r \in\left(0, \int_{0}^{+\infty} c(s) e^{-s} d s\right)$.

Thus, Theorem 1.2 holds.
