# VECTOR-VALUED FRACTAL FUNCTIONS: FRACTAL DIMENSION AND FRACTIONAL CALCULUS

#### Abstract

There are many research available on the study of real-valued fractal interpolation function and fractal dimension of its graph. In this paper, our main focus is to study the dimensional results for vector-valued fractal interpolation function and its Riemann-Liouville fractional integral. Here, we give some results which ensure that dimensional results for vector-valued functions are quite different from real-valued functions. We determine interesting bounds for the Hausdorff dimension of the graph of vector-valued fractal interpolation function. We also obtain bounds for the Hausdorff dimension of associated invariant measure supported on the graph of vector-valued fractal interpolation function. Next, we discuss more efficient upper bound for the Hausdorff dimension of measure in terms of probability vector and contraction ratios. Furthermore, we determine some dimensional results for the graph of the Riemann-Liouville fractional integral of a vector-valued fractal interpolation function.


## 1. INTRODUCTION

In Fractal Geometry, calculation of fractal dimension is one of the major themes for researchers. There are a lot of research available on the study of fractal dimension of sets and the graph of continuous functions, see for more details [2, 9, 28, 21]. In 1986, Barnsley [1] established the theory of real-valued fractal interpolation functions (FIFs) by using the concept of iterated function systems (IFSs) and estimated the Hausdorff dimension of affine FIFs. Also, there are some articles [4, 3], in which researchers calculated the box dimension of affine FIFs. In 1991, Massopust [22] introduced vector-valued fractal interpolation functions and computed the box dimension of the graph of vector-valued fractal interpolation functions. After that, Hardin and Massopust [12] constructed fractal interpolation functions from $\mathbb{R}^{n}$ to $\mathbb{R}^{m}$ and derived a formula for the box dimension of hidden variable FIFs. Recently, Barnsley and Massopust [5] introduced the construction of bi-linear FIFs and gave a formula for the box dimension of the graph of bi-linear FIFs. Also, there are some research available on the study of fractal surfaces, see [23, 6] for more details.

Fractional calculus is a very old area of research and it attracts researchers for its wide applications. There are many researchers, who investigated relationship between fractals and fractional calculus, see for more details [31, 24]. In 2009, Ruan et al. estimated the box dimension of the graph of Riemann-Liouville fractional integral of linear FIFs. Gowrishankar and Uthayakumar [11] also studied theory regarding Riemann-Liouville fractional integral of countable linear FIFs. In 2010, Liang [16] showed that the box dimension of the Riemann-Liouville fractional integral of a continuous function of bounded variation is 1. After that, in 2018, Liang 19 proved that the upper box dimension of the Riemann-Liouville fractional integral of a continuous function can not exceed the upper box dimension of this

[^0]continuous function. Some authors [17, 20, 32] estimated fractal dimension of the graph of the Riemann-Liouville fractional integral of functions like Hölder function and unbounded variation function. Abbas and Chandra [6, 7] worked on mixed Riemann-Liouville fractional integral of fractal surfaces. In [27], Roychowdhury and Selmi determined quantization dimension for the invariant measure of the recurrent IFS. Some recent works on dimension of self-similar measures can be seen in [13, 30] and the references cited therein. However, we should emphasize on the fact that the present paper deals with the measures supported on the graphs of fractal functions, these measures do not belong to the class of self-similar (or self-affine) measures. Here, firstly we convince the reader that dimensional results for vector-valued function and real-valued function are not the same, in general. In this paper, our main focus is to describe some dimensional results for the graph of vector-valued fractal interpolation functions and its Riemann-Liouville fractional integral.

The paper is organized as follows. In the forthcoming Section 2, we give some definitions and required results for our work. Section 3 consists of some dimensional results on the vector-valued fractal function and associated measures. In this section, we first give some propositions and lemmas which describe relations between fractal dimension of vector-valued function and its components. After that, we establish bounds for the Hausdorff dimension of vector-valued fractal interpolation function. We also obtain bounds for the Hausdorff dimension of associated invariant measures supported on the graph of vectorvalued fractal interpolation function. Then, we determine more general upper bound for the Hausdorff dimension of invariant measure in terms of probability vector and contraction ratios. Later, we give some conditions under which vector-valued fractal interpolation function belongs to some special class of function spaces like Hölder space, bounded variation class and absolutely continuous function space. In Section4, we prove that the Riemann-Liouville fractional integral of a vector-valued fractal interpolation function is again a vector-valued fractal interpolation function corresponding to some data set. Next, we compute the Hausdorff dimension and box-counting dimension of the graph of the Riemann-Liouville fractional integral of a vector-valued fractal interpolation function.

## 2. PRELIMINARIES

Definition 2.1. Let $F$ be a subset of a metric space $(X, d)$. The Hausdorff dimension of $F$ is defined as follows
$\operatorname{dim}_{H} F=\inf \left\{\beta>0:\right.$ for every $\epsilon>0$, there is a cover $\left\{U_{i}\right\}_{i=1}^{\infty}$ of $F$ with $\left.\sum_{i=1}^{\infty}\left|U_{i}\right|^{\beta}<\epsilon\right\}$, where $\left|U_{i}\right|$ denotes the diameter of $U_{i}$.

Definition 2.2. The box dimension of a non-empty bounded subset $F$ of $(X, d)$ is defined as

$$
\operatorname{dim}_{B} F=\lim _{\delta \rightarrow 0} \frac{\log N_{\delta}(F)}{-\log \delta}
$$

where $N_{\delta}(F)$ denotes the smallest number of sets of diameter at most $\delta$ that can cover $F$, provided the limit exists. If this limit does not exist then the upper and the lower box dimension, respectively, are defined as

$$
\begin{aligned}
& \overline{\operatorname{dim}}_{B} F=\limsup _{\delta \rightarrow 0} \frac{\log N_{\delta}(F)}{-\log \delta} \\
& \underline{\operatorname{dim}}_{B} F=\liminf _{\delta \rightarrow 0} \frac{\log N_{\delta}(F)}{-\log \delta}
\end{aligned}
$$

Definition 2.3. Let $F$ be a subset of a metric space $(X, d)$. For $r>0$ and $t \geq 0$, let $P_{r}^{t}(F)=\sup \left\{\sum_{i}\left|B_{i}\right|^{t}\right\}$, where $\left\{B_{i}\right\}$ is a collection of disjoint balls of radii at most $r$ with centres in $F$. As $r$ decreases, $P_{r}^{t}(F)$ also decreases. Therefore, the limit

$$
P_{0}^{t}(F)=\lim _{r \rightarrow 0} P_{r}^{t}(F)
$$

exists. We define

$$
P^{t}(F)=\inf \left\{\sum_{i} P_{0}^{t}\left(F_{i}\right): F \subset \bigcup_{i=1}^{\infty} F_{i}\right\},
$$

and it is known as the $t$-dimensional packing measure. The Packing dimension is defined as follows:

$$
\operatorname{dim}_{P}(F)=\inf \left\{t \geq 0: P^{t}(F)=0\right\}=\sup \left\{t \geq 0: P^{t}(F)=\infty\right\} .
$$

Note- We denote the graph of a function $f$ by $G(f)$ throughout this paper.
Definition 2.4. Let $\mu$ be a Borel probability measure on $\mathbb{R}^{n}$, where $n \in \mathbb{N}$. The Hausdorff dimension of measure $\mu$ is defined by

$$
\operatorname{dim}_{H}(\mu)=\inf \left\{\operatorname{dim}_{H}(F): F \text { is a Borel subset such that } \mu(F)>0\right\} .
$$

Definition 2.5. The lower and upper local dimensions of a measure $\mu$ at $x \in \mathbb{R}^{n}$, respectively, are given by

$$
\underline{\operatorname{dim}}_{l o c} \mu(x)=\liminf _{r \rightarrow 0} \frac{\log \mu(B(x, r))}{\log r}, \overline{\operatorname{dim}}_{l o c} \mu(x)=\limsup _{r \rightarrow 0} \frac{\log \mu(B(x, r))}{\log r} .
$$

Proposition 2.6. [8] For a finite Borel measure $\mu$, we have

$$
\operatorname{dim}_{H}(\mu) \leq \inf \left\{s: \underline{\operatorname{dim}}_{l o c} \mu(x) \leq s \text { for } \mu \text {-almost all } x \in \mathbb{R}^{n}\right\} .
$$

Theorem 2.7. [9 Let $f:[0,1] \rightarrow \mathbb{R}$ be a Hölder continuous function with the Hölder exponent $\sigma \in(0,1)$. Then $\overline{\operatorname{dim}}_{B}(G(f)) \leq 2-\sigma$.
2.1. Iterated Function Systems. Let $(X, d)$ be a complete metric space, and we denote the family of all nonempty compact subsets of $X$ by $H(X)$. We define the Hausdorff metric

$$
\mathcal{D}(A, B)=\inf \left\{\delta>0: A \subset B_{\delta} \text { and } B \subset A_{\delta}\right\},
$$

where $A_{\delta}$ and $B_{\delta}$ denote the $\delta$-neighbourhoods of sets $A$ and $B$, respectively. Then it is well-known that $(H(X), \mathcal{D})$ is a complete metric space. A map $f:(X, d) \rightarrow(X, d)$ is called a contraction if there exists a constant $r<1$ such that

$$
d(f(x), f(y)) \leq r d(x, y), \forall x, y \in X .
$$

Definition 2.8. The system $\mathcal{I}=\left\{(X, d) ; f_{1}, f_{2}, \ldots, f_{N}\right\}$ is called an iterated function system (IFS), if each $f_{i}$ is a contraction self-map on $X$ for $i \in\{1,2, \ldots, N\}$.

Let $\mathcal{I}=\left\{(X, d) ; f_{1}, f_{2}, \ldots, f_{N}\right\}$ be an IFS. We define a mapping (widely known as the Hutchinson operator) $S$ from $H(X)$ into $H(X)$ given by

$$
S(A)=\bigcup_{i=1}^{N} f_{i}(A) .
$$

The map $S$ defined above is a contraction map under the Hausdorff metric $\mathcal{D}$. If $(X, d)$ is a complete metric space, then, by the Banach contraction principle, there exists a unique $F \in H(X)$ such that $F=\cup_{i=1}^{N} f_{i}(F)$, and it is called the attractor of the IFS. We refer the reader to see [2, 9] for details.

Definition 2.9. We say that an $\operatorname{IFS} \mathcal{I}=\left\{(X, d) ; f_{1}, f_{2}, \ldots, f_{N}\right\}$ satisfies the open set condition (OSC) if there is a non-empty open set $U$ with $f_{i}(U) \subset U \forall i \in\{1,2, \cdots, N\}$ and $f_{i}(U) \cap f_{j}(U)=\emptyset$ for $i \neq j$. Moreover, if $U \cap F \neq \emptyset$, where $F$ is the attractor of the IFS $\mathcal{I}$, then we say that $\mathcal{I}$ satisfies the strong open set condition (SOSC). If $f_{i}(F) \cap f_{j}(F)=\emptyset$ for $i \neq j$, then we say that the IFS $\mathcal{I}$ satisfies the strong separation condintion (SSC).
2.2. Fractal Interpolation Functions. Consider a set of data points $\left\{\left(x_{i}, \boldsymbol{y}_{i}\right) \in \mathbb{R} \times \mathbb{R}^{M}\right.$ : $i=1,2, \ldots, N\}$ with $x_{1}<x_{2}<\cdots<x_{N}$. Set $T=\{1,2, \ldots, N-1\}$ and $J=\left[x_{1}, x_{N}\right]$. For each $k \in T$, set $J_{k}=\left[x_{k}, x_{k+1}\right]$ and let $P_{k}: J \rightarrow J_{k}$ be a contractive homeomorphism satisfying

$$
P_{k}\left(x_{1}\right)=x_{k}, P_{k}\left(x_{N}\right)=x_{k+1} .
$$

For each $k \in T$, let $F_{k}: J \times \mathbb{R}^{M} \rightarrow \mathbb{R}^{M}$ be a continuous map such that

$$
\begin{aligned}
& \left|F_{k}\left(t, \boldsymbol{z}_{\mathbf{1}}\right)-F_{k}\left(t, \boldsymbol{z}_{2}\right)\right| \leq \tau_{k}\left|\boldsymbol{z}_{\mathbf{1}}-\boldsymbol{z}_{\mathbf{2}}\right|, \\
& F_{k}\left(x_{1}, \boldsymbol{y}_{1}\right)=\boldsymbol{y}_{k}, F_{k}\left(x_{N}, \boldsymbol{y}_{N}\right)=\boldsymbol{y}_{k+1},
\end{aligned}
$$

where $\left(t, \boldsymbol{z}_{1}\right),\left(t, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$ and $0 \leq \tau_{k}<1$. In particular, we can take for each $k \in T$,

$$
P_{k}(t)=a_{k} t+d_{k}, \quad F_{k}(t, \boldsymbol{z})=\alpha_{k} \boldsymbol{z}+q_{k}(t) .
$$

In the above expressions $a_{k}$ and $d_{k}$ are uniquely determined by the condition $P_{k}\left(x_{1}\right)=$ $x_{k}, P_{k}\left(x_{N}\right)=x_{k+1}$. The multiplier $\alpha_{k}$ is called the scaling factor, which satisfies $-1<$ $\alpha_{k}<1$ and $q_{k}: J \rightarrow \mathbb{R}^{M}$ is a continuous function such that $q_{k}\left(x_{1}\right)=\boldsymbol{y}_{k}-\alpha_{k} \boldsymbol{y}_{1}$ and $q_{k}\left(x_{N}\right)=\boldsymbol{y}_{k+1}-\alpha_{k} \boldsymbol{y}_{N}$. Now for each $k \in T$, we define function $W_{k}: J \times \mathbb{R}^{M} \rightarrow J \times \mathbb{R}^{M}$ by

$$
W_{k}(t, \boldsymbol{z})=\left(P_{k}(t), F_{k}(t, \boldsymbol{z})\right) .
$$

Then the IFS $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{1}, W_{2}, \ldots, W_{N-1}\right\}$ has a unique attractor [1] Theorem 1], which is the graph of a function $h$ which satisfies the following functional equation reflecting self-referentiality:

$$
h(t)=\alpha_{k} h\left(P_{k}^{-1}(t)\right)+q_{k}\left(P_{k}^{-1}(t)\right), t \in J_{k}, k \in T .
$$

The above function $h$ is known as the fractal interpolation function (FIF).
Let $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{1}, W_{2}, \ldots, W_{N-1}\right\}$ be an iterated function system (IFS) with probability vector $\left(p_{1}, p_{2}, \cdots, p_{N-1}\right)$. Let $T=\{1,2, \cdots, N-1\}$. Let $T^{n}$ be the set of all finite sequences of $T$ of length $n$, that is, $T^{n}=\left\{\left(i_{1}, i_{2}, \cdots, i_{n}\right): 1 \leq i_{j} \leq N-1\right\}$ and let $T^{*}=\cup_{n \in \mathbb{N}} T^{n}$ denote the set of all sequences of $T$ of finite length. We denote by $\Omega$ the set of all infinite sequences $\Omega=\left\{\left(\omega_{1}, \omega_{2}, \cdots\right): 1 \leq \omega_{j} \leq N-1\right\}$. If $\mathbf{i}=\left(i_{1}, i_{2}, \cdots, i_{n}\right) \in T^{*}$, then the set $\left\{\omega \in \Omega: \omega_{j}=i_{j} \forall j \in\{1,2, \cdots, n\}\right\}$ is called a cylinder of length $n$ in $\Omega$ generated by $\mathbf{i}$ and is denoted by $[\mathbf{i}]$. For $\mathbf{i}=\left(i_{1}, i_{2}, \cdots, i_{n}\right) \in T^{*}$, we write $p_{\mathbf{i}}=p_{i_{1}} p_{i_{2}} \cdots p_{i_{n}}$. Let $\mathcal{B}$ denote the Borel sigma-algebra on $\Omega$ generated by cylinders in $\Omega$. We define a Borel probability measure $\mu$ on $\Omega$ by first defining on cylinders in $\Omega$ as follows:

$$
\mu([\mathbf{i}])=p_{\mathbf{i}} \forall \mathbf{i}=\left(i_{1}, i_{2}, \cdots, i_{n}\right) \in T^{*} .
$$

Then, by the Caratheodory's extension theorem, $\mu$ can be extended to a unique Borel probability measure on $\Omega$ which we again denote by $\mu$. It is clear that the support of $\mu$ is $\Omega$.

## 3. Dimensional results on the vector-valued fractal function and ASSOCIATED MEASURES

In the following lemma, we provide a relationship between the Hausdorff dimension of vector-valued continuous function and the Hausdorff dimension of its components.

Lemma 3.1. Let $f:[a, b] \rightarrow \mathbb{R}^{M}$ be a continuous function and $f_{i}:[a, b] \rightarrow \mathbb{R}$ be the $i$ th component of $f$, that is, $f=\left(f_{1}, f_{2}, \cdots, f_{M}\right)$. Then we have
(1) $\operatorname{dim}_{H}(G(f)) \geq \max _{1 \leq i \leq M}\left\{\operatorname{dim}_{H}\left(G\left(f_{i}\right)\right)\right\}$.
(2) $\operatorname{dim}_{H}(G(f))=\operatorname{dim}_{H}\left(G\left(f_{i}\right)\right)$, provided the component function $f_{j}$ is Lipschitz for each $1 \leq j \neq i \leq M$.

Proof. (1) Let us define a mapping $\Phi: G(f) \rightarrow G\left(f_{i}\right)$ as follows

$$
\Phi(x, f(x))=\left(x, f_{i}(x)\right)
$$

One can easily prove that $\Phi$ is a Lipschitz map. Now, the Lipschitz invariance property of the Hausdorff dimension (Cf. [9, Corollary 2.4(a)]) yields

$$
\operatorname{dim}_{H}(\mathrm{G}(f)) \geq \operatorname{dim}_{H}\left(\mathrm{G}\left(f_{i}\right)\right)
$$

Since the above inequality holds for any $i \in\{1,2, \cdots, M\}$, we get

$$
\operatorname{dim}_{H}(\mathrm{G}(f)) \geq \max _{1 \leq i \leq M}\left\{\operatorname{dim}_{H}\left(\mathrm{G}\left(f_{i}\right)\right)\right\}
$$

completing the proof of item (1).
(2) In this part, we continue our proof with the same mapping $\Phi: G(f) \rightarrow G\left(f_{i}\right)$, defined by

$$
\Phi(x, f(x))=\left(x, f_{i}(x)\right)
$$

By using $f_{j}$ is Lipschitz for each $1 \leq j \neq i \leq M$, one can easily show that the map $\Phi$ is a bi-Lipschitz map. In the light of the bi-Lipschitz invariance property of the Hausdorff dimension (Cf. 9, Corollary 2.4(b)]), we get

$$
\operatorname{dim}_{H}(\mathrm{G}(f))=\operatorname{dim}_{H}\left(\mathrm{G}\left(f_{i}\right)\right)
$$

which completes the proof.

Now, we describe some results similar to the above in terms of other dimensions.
Proposition 3.2. Let $f:[a, b] \rightarrow \mathbb{R}^{M}$ be a continuous function and $f_{i}:[a, b] \rightarrow \mathbb{R}$ be the $i$ th component of $f$, that is, $f=\left(f_{1}, f_{2}, \cdots, f_{M}\right)$. Then we have

$$
\begin{aligned}
& \operatorname{dim}_{P}(\mathrm{G}(f)) \geq \max _{1 \leq i \leq M}\left\{\operatorname{dim}_{P}\left(\mathrm{G}\left(f_{i}\right)\right)\right\} \\
& \overline{\operatorname{dim}}_{B}(\mathrm{G}(f)) \geq \max _{1 \leq i \leq M}\left\{\overline{\operatorname{dim}}_{B}\left(\mathrm{G}\left(f_{i}\right)\right)\right\} \\
& \underline{\operatorname{dim}_{B}}(\mathrm{G}(f)) \geq \max _{1 \leq i \leq M}\left\{\underline{\operatorname{dim}}_{B}\left(\mathrm{G}\left(f_{i}\right)\right)\right\}
\end{aligned}
$$

Proof. The proof is similar to part (1) of Lemma 3.1. Hence, we omit it.
Proposition 3.3. Let $f:[a, b] \rightarrow \mathbb{R}^{M}$ be a continuous function and $f_{i}:[a, b] \rightarrow \mathbb{R}$ be the $i$ th component of $f$, that is, $f=\left(f_{1}, f_{2}, \cdots, f_{M}\right)$. If $f_{j}$ is a Lipschitz function for each $1 \leq j \neq i \leq M$, then we have

$$
\operatorname{dim}_{P}(\mathrm{G}(f))=\operatorname{dim}_{P}\left(\mathrm{G}\left(f_{i}\right)\right), \overline{\operatorname{dim}}_{B}(\mathrm{G}(f))=\overline{\operatorname{dim}}_{B}\left(\mathrm{G}\left(f_{i}\right)\right),
$$

and

$$
\underline{\operatorname{dim}}_{B}(\mathrm{G}(f))=\underline{\operatorname{dim}}_{B}\left(\mathrm{G}\left(f_{i}\right)\right) .
$$

Proof. The proof is similar to part (2) of Lemma 3.1, hence omitted.

Lemma 3.4. Let $f:[a, b] \rightarrow \mathbb{R}^{M}$ be a continuous function and $f_{i}:[a, b] \rightarrow \mathbb{R}$ be the ith component of $f$, that is, $f=\left(f_{1}, f_{2}, \cdots, f_{M}\right)$. If $f_{j}$ is a Lipschitz function on $[a, b]$ for all $1 \leq j \neq i \leq M$, then

$$
\begin{aligned}
& \operatorname{dim}_{H}(G(f))=\operatorname{dim}_{H}\left(G\left(\sum_{j=1}^{M} f_{j}\right)\right)=\operatorname{dim}_{H}\left(G\left(f_{i}\right)\right) \\
& \overline{\operatorname{dim}}_{B}(G(f))=\overline{\operatorname{dim}}_{B}\left(G\left(\sum_{j=1}^{M} f_{j}\right)\right)=\overline{\operatorname{dim}}_{B}\left(G\left(f_{i}\right)\right) \\
& \underline{\operatorname{dim}}_{B}(G(f))=\underline{\operatorname{dim}}_{B}\left(G\left(\sum_{j=1}^{M} f_{j}\right)\right)=\underline{\operatorname{dim}}_{B}\left(G\left(f_{i}\right)\right) \\
& \operatorname{dim}_{P}(G(f))=\operatorname{dim}_{P}\left(G\left(\sum_{j=1}^{M} f_{j}\right)\right)=\operatorname{dim}_{P}\left(G\left(f_{i}\right)\right)
\end{aligned}
$$

Proof. We define a mapping $\Phi: \mathrm{G}\left(\sum_{j=1}^{M} f_{j}\right) \rightarrow G\left(f_{i}\right)$ as follows

$$
\Phi\left(x,\left(\sum_{j=1}^{M} f_{j}(x)\right)\right)=\left(x, f_{i}(x)\right)
$$

By using simple property of norm and using the condition that the function $f_{j}$ is Lipschitz on $[a, b]$ for all $1 \leq j \neq i \leq M$, it is easy to show that $\Phi$ is a bi-Lipschitz map. In the light of Lemma 3.1, Proposition 3.3 and by using the bi-Lipschitz invariance property of Hausdorff dimension, lower box dimension, upper box dimension, and Packing dimension, we get our required result.

Remark 3.5. Note that in [15] the Peano space filling curve $\Theta:[0,1] \rightarrow[0,1] \times[0,1]$ is a Hölder continuous function with exponent $\frac{1}{2}$. Let $\Theta_{i}$ be the $i$ th component of $\Theta$ for $i \in\{1,2\}$. The component function $\Theta_{i}$ satisfy $\operatorname{dim}_{H}\left(G\left(\Theta_{i}\right)\right)=1.5$ for all $i \in\{1,2\}$. However, we have $\operatorname{dim}_{H}(G(\Theta)) \geq 2$. From this, it is clear that the upper bound of the Hausdorff dimension of the graph of a vector-valued function cannot be written in terms of its Hölder exponent as we do for a real-valued function.

From the above discussion, we conclude that the dimensional results for vector-valued functions can be different from that of real-valued functions.

In the rest of the section, we follow the notations introduced in Section 2. Motivated by the work of Barnsley and Massopust [5] on real-valued fractal functions, we define a metric $d_{*}$ on the space $J \times \mathbb{R}^{M}$ as follows

$$
d_{*}\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right)=\left|t_{1}-t_{2}\right|+\left\|\left(\boldsymbol{z}_{\mathbf{1}}-h\left(t_{1}\right)\right)-\left(\boldsymbol{z}_{\mathbf{2}}-h\left(t_{2}\right)\right)\right\| \forall\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}
$$

Then, it is easy to check that $\left(J \times \mathbb{R}^{M}, d_{*}\right)$ is a complete metric space. Further, it can also be seen that the above metric $d_{*}$ is equivalent to the Euclidean metric on $J \times \mathbb{R}^{M}$.

In the next theorem, we prove that $W_{k}$ is a contraction map for each $k \in T$.
Theorem 3.6. Let $W_{k}(t, \boldsymbol{z})=\left(P_{k}(t), F_{k}(t, \boldsymbol{z})\right)$, where $P_{k}$ and $F_{k}$ are defined as in Section 2. Then the map $W_{k}: J \times \mathbb{R}^{M} \rightarrow J \times \mathbb{R}^{M}$ is a contraction map on the complete metric space $\left(J \times \mathbb{R}^{M}, d_{*}\right)$.

Proof. Let $\left(t_{1}, \boldsymbol{z}_{1}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$. Then we have

\begin{aligned}
d_{*}\left(W_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right), W_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) & =d_{*}\left(\left(P_{k}\left(t_{1}\right), F_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right)\right),\left(P_{k}\left(t_{2}\right), F_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right)\right) \\
& =\left|P_{k}\left(t_{1}\right)-P_{k}\left(t_{2}\right)\right|+\|\left(F_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right)-h\left(P_{k}\left(t_{1}\right)\right)\right) \\
& -\left(F_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)-h\left(P_{k}\left(t_{2}\right)\right)\right) \| \\
& =\left|P_{k}\left(t_{1}\right)-P_{k}\left(t_{2}\right)\right|+\|\left(\alpha_{k} \boldsymbol{z}_{\mathbf{1}}+q_{k}\left(t_{1}\right)-h\left(P_{k}\left(t_{1}\right)\right)\right) \\
& -\left(\alpha_{k} \boldsymbol{z}_{\mathbf{2}}+q_{k}\left(t_{2}\right)-h\left(P_{k}\left(t_{2}\right)\right)\right) \| \\
& \leq\left|a_{k}\right|\left|t_{1}-t_{2}\right|+\left\|\alpha_{k}\left(\boldsymbol{z}_{\mathbf{1}}-h\left(t_{1}\right)\right)-\alpha_{k}\left(\boldsymbol{z}_{\mathbf{2}}-h\left(t_{2}\right)\right)\right\| \\
& \leq \max \left\{\left|a_{k}\right|,\left|\alpha_{k}\right|\right\} d_{*}\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) .
\end{aligned}
$$

Since $\max \left\{\left|a_{k}\right|,\left|\alpha_{k}\right|\right\}<1$, it follows that $W_{k}$ is a contraction map for each $k \in T$.
In the following theorem, we describe bounds for the Hausdorff dimension of the graph of vector-valued FIF.

Theorem 3.7. Let $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{k}: k \in T\right\}$ be the IFS as defined earlier such that

c_{k} d\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \leq d\left(W_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right), W_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \leq C_{k} d\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right)
$$

where $\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$ and $0<c_{k} \leq C_{k}<1 \forall k \in T$. Then $r \leq \operatorname{dim}_{H}(G(h)) \leq R$, where $h$ is fractal function and $r, R$ are given by $\sum_{k \in T} c_{k}^{r}=1$ and $\sum_{k \in T} C_{k}^{R}=1$, respectively.

Proof. By using Proposition 9.6 in [9], we easily get the required upper bound of the Hausdorff dimension of the graph of fractal function $h$. Next, we shall determine a lower bound of $\operatorname{dim}_{H}(G(h))$. Let $O_{*}=\left(x_{1}, x_{N}\right) \times \mathbb{R}^{M}$. Then $W_{i}\left(O_{*}\right) \cap W_{j}\left(O_{*}\right)=\emptyset$ for each $i \neq j \in T$ because $P_{i}\left(\left(x_{1}, x_{N}\right)\right) \cap P_{j}\left(\left(x_{1}, x_{N}\right)\right)=\emptyset \forall i \neq j \in T$. We can easily observe that for each $i \in T$, $W_{i}\left(O_{*}\right) \subset O_{*}$ and $O_{*} \cap G(h) \neq \emptyset$. This implies that the IFS $\mathcal{I}$ satisfies the SOSC. Since $O_{*} \cap G(h) \neq \emptyset$, there exists an index $\sigma \in T^{*}$ such that $W_{\sigma}(G(h)) \subset O_{*}$, where $T^{*}:=\cup_{n \in \mathbb{N}} T^{n}$. For each $n \in \mathbb{N}$, let $B_{n}^{*}$ be the attractor of the IFS $\mathcal{I}_{n}=\left\{J \times \mathbb{R}^{M} ; W_{i \sigma}: i \in T^{n}\right\}$. After observing the code space of the IFS $\mathcal{I}$ and the IFS $\mathcal{I}_{n}$, it is clear that $B_{n}^{*} \subseteq G(h)$. For $i \neq j \in T^{n}, W_{i}\left(O_{*}\right) \cap W_{j}\left(O_{*}\right)=\emptyset$. It follows that $W_{i \sigma}\left(B_{n}^{*}\right) \cap W_{j \sigma}\left(B_{n}^{*}\right)=\emptyset$ for $i \neq j \in T^{n}$. Thus, the IFS $\mathcal{I}_{n}=\left\{J \times \mathbb{R}^{M} ; W_{i \sigma}: i \in T^{n}\right\}$ satisfies the SSC. So, it is clear that the IFS $\mathcal{I}_{n}$ satisfies the hypothesis of Proposition 9.7 in [9]. Therefore, Proposition 9.7 in 9] yields that $r_{n} \leq \operatorname{dim}_{H}\left(B_{n}^{*}\right)$, where $r_{n}$ is given by $\sum_{i \in T^{n}} c_{i \sigma}^{r_{n}}=1$. Thus, $r_{n} \leq \operatorname{dim}_{H}\left(B_{n}^{*}\right) \leq \operatorname{dim}_{H}(G(h))$ because $B_{n}^{*} \subset G(h)$. Suppose that $\operatorname{dim}_{H}(G(h))<r$. This implies that $r_{n}<r$ for all $n \in \mathbb{N}$. Let $c_{\text {max }}=\max \left\{c_{1}, c_{2}, \ldots, c_{N-1}\right\}$. We have

$$
c_{\sigma}^{-r_{n}}=\sum_{i \in T^{n}} c_{i}^{r_{n}} \geq \sum_{i \in T^{n}} c_{i}^{r} c_{i}^{\operatorname{dim}_{H}(G(h))-r} \geq \sum_{i \in T^{n}} c_{i}^{r} c_{\max }^{n\left(\operatorname{dim}_{H}(G(h))-r\right)} .
$$

This implies that

c_{\sigma}^{-r} \geq c_{\max }^{n\left(\operatorname{dim}_{H}(G(h))-r\right)} .
$$

We get a contradiction for large values of $n \in \mathbb{N}$. Thus, our assumption is wrong. Therefore, we obtain $\operatorname{dim}_{H}(G(h)) \geq r$. Thus, the proof is complete.

Remark 3.8. In the above theorem, we can also take the mapping $P_{k}$ to be non-linear for all $k \in T$ and also it is not necessary that $\alpha_{k}$ 's are constants. That is, one can consider scalings function $\alpha_{k}: J \rightarrow \mathbb{R}$ such that $\left\|\alpha_{k}\right\|_{\infty}<1$ ( see, for instance, [23]).

Remark 3.9. We may compare the above result with Theorem 4 of [1], wherein Barnsley proved the aforesaid theorem on dimension of FIF using potential theoretic approach.

However, our approach is different from his approach, and our result also gives the same dimension bounds under less restrictive conditions. To be precise, following the same notation as in [1], the assumptions taken therein

t_{1} \cdot t_{N} \leq\left(\operatorname{Min}\left\{a_{1}, a_{N}\right\}\right)\left(\sum_{n=1}^{N} t_{n}^{l}\right)^{2 / l} \text { and } L_{n}(x)=a_{n} x+h_{n}

are not needed to obtain the required lower bound. In this paper, we denote $L_{n}$ by $P_{n}, h_{n}$ by $d_{n}$ and $t_{n}$ by $c_{n}$.

Remark 3.10. In [22], Massopust calculated the exact value of the box dimension of the linear affine vector-valued FIF using covering method under some conditions. However, our above result gives bounds for the Hausdorff dimension of non-linear vector-valued FIF.

Remark 3.11. Barnsley and Massopust gave a formula for the exact value of the box dimension of bilinear FIFs using their own technique in Theorem 6 of [5]. However, it is worth to note that if we choose $q_{k}(x)=h\left(l_{k}(x)\right)-S_{k}\left(l_{k}(x)\right) b(x)$ and $\alpha_{k}(x)=S_{k}\left(l_{k}(x)\right)$, then our class for which we give dimensional result will reduce to the class of bilinear FIFs. Thus, our result gives dimensional result for a much bigger class.

Remark 3.12. In [26], Roychowdhury has considered hyperbolic recurrent IFS consisting of the bi-Lipschitz mapping. He has obtained bounds of the Hausdorff and box dimension of this IFS by using volume arguments and pressure function under the open set condition. Note that the recurrent IFS is a generalized version of the IFS, hence so is Roychowdhury's result. However, in our proof we do not use any pressure function and volume argument. Thus, our proof can be done for general complete metric spaces.

The next theorem can be obtained by [14], however, we include its detailed proof for completeness and record.

Theorem 3.13. Let $W_{k}: J \times \mathbb{R}^{M} \rightarrow J \times \mathbb{R}^{M}$ be defined by $W_{k}(t, \boldsymbol{z})=\left(P_{k}(t), F_{k}(t, \boldsymbol{z})\right)$ as earlier. Also, let $\left(p_{1}, \ldots, p_{N-1}\right)$ be a probability vector. Then there exists a unique Borel probability measure $\mu_{*}$ supported on the graph $G(h)$ of the fractal interpolation function such that

\mu_{*}=\sum_{k \in T} p_{k} \mu_{*} \circ W_{k}^{-1}
$$

Proof. In view of Theorem 3.6, we have a metric $d_{*}$ with respect to which each mapping $W_{k}: J \times \mathbb{R}^{M} \rightarrow J \times \mathbb{R}^{M}$ will be contraction with contracting ratio $C_{k}=\max \left\{\left|a_{k}\right|,\left|\alpha_{k}\right|\right\}$ for each $k \in T$. Recall that the collection of all Borel probability measures on $J \times \mathbb{R}^{M}$, denoted by $\mathcal{P}\left(J \times \mathbb{R}^{M}\right)$, is a complete metric space with respect to the Hutchinson metric $d_{H}$ defined as

d_{H}(\mu, \nu)=\sup \left\{\left|\int f d \mu(t, \boldsymbol{z})-\int f d \nu(t, \boldsymbol{z})\right|: f: J \times \mathbb{R}^{M} \rightarrow \mathbb{R}, \operatorname{Lip}(f) \leq 1\right\}
$$

where the supremum is taken over all Lipschitz functions $f: J \times \mathbb{R}^{M} \rightarrow \mathbb{R}$ satisfying $\operatorname{Lip}(f):=\inf \left\{L_{f}>0:\left|f\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right)-f\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right| \leq L_{f} d_{*}\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \forall\left(t_{1}, \boldsymbol{z}_{\mathbf{2}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in\right.$ $\left.J \times \mathbb{R}^{M}\right\}<1$. Define a mapping $\mathcal{M}: \mathcal{P}\left(J \times \mathbb{R}^{M}\right) \rightarrow \mathcal{P}\left(J \times \mathbb{R}^{M}\right)$ by $\mathcal{M}(\mu)=\sum_{k \in T} p_{k} \mu \circ W_{k}^{-1}$. Now, we have

\begin{aligned}
& d_{H}(\mathcal{M}(\mu), \mathcal{M}(\nu)) \\
& =\sup \left\{\left|\int f d \mathcal{M}(\mu)(t, \boldsymbol{z})-\int f d \mathcal{M}(\nu)(t, \boldsymbol{z})\right|: \operatorname{Lip}(f) \leq 1\right\}
\end{aligned}
$$

$$
\begin{aligned}
& =\sup \left\{\left|\sum_{k \in T} p_{k} \int f d \mu \circ W_{k}^{-1}(t, \boldsymbol{z})-\sum_{k \in T} p_{k} \int f d \nu \circ W_{k}^{-1}(t, \boldsymbol{z})\right|: \operatorname{Lip}(f) \leq 1\right\} \\
& =\sup \left\{\left|\sum_{k \in T} p_{k} \int f \circ W_{k}(t, \boldsymbol{z}) d \mu(t, \boldsymbol{z})-\sum_{k \in T} p_{k} \int f \circ W_{k}(t, \boldsymbol{z}) d \nu(t, \boldsymbol{z})\right|: \operatorname{Lip}(f) \leq 1\right\} \\
& =\sum_{k \in T} p_{k} \sup \left\{C_{k}\left|\int \frac{1}{C_{k}} f \circ W_{k}(t, \boldsymbol{z}) d \mu(t, \boldsymbol{z})-\int \frac{1}{C_{k}} f \circ W_{k}(t, \boldsymbol{z}) d \nu(t, \boldsymbol{z})\right|: \operatorname{Lip}(f) \leq 1\right\} \\
& \leq \sum_{k \in T} p_{k} C_{\max } \sup \left\{\left|\int \frac{1}{C_{k}} f \circ W_{k}(t, \boldsymbol{z}) d \mu(t, \boldsymbol{z})-\int \frac{1}{C_{k}} f \circ W_{k}(t, \boldsymbol{z}) d \nu(t, \boldsymbol{z})\right|: \operatorname{Lip}(f) \leq 1\right\} \\
& \leq \sum_{k \in T} p_{k} C_{\max } d_{H}(\mu, \nu) \\
& =C_{\max } d_{H}(\mu, \nu) .
\end{aligned}
$$

Since $C_{\max }=\max \left\{C_{k}: k \in T\right\}<1$, the mapping $\mathcal{M}$ is a contraction. Now, the Banach fixed point theorem gives a unique probability measure $\mu_{*}$ such that $\mu_{*}=\sum_{k \in T} p_{k} \mu_{*} \circ$ $W_{k}^{-1}$. It remains to show that supp $\mu_{*}=G(h)$. For this, we first prove that supp $\mu_{*} \subseteq$ $\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)$. On applying $\mu_{*}=\sum_{k \in T} p_{k} \mu_{*} \circ W_{k}^{-1}$ to $\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)$, we obtain

\begin{aligned}
\mu_{*}\left(\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)\right) & \left.=\sum_{k \in T} p_{k} \mu_{*} \circ W_{k}^{-1}\left(\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)\right)\right) \\
& =\sum_{k \in T} p_{k} \mu_{*}\left(W_{k}^{-1}\left(\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)\right)\right) \\
& \geq \sum_{k \in T} p_{k} \mu_{*}\left(W_{k}^{-1}\left(W_{k}\left(\operatorname{supp} \mu_{*}\right)\right)\right) \\
& \geq \sum_{k \in T} p_{k} \mu_{*}\left(\operatorname{supp} \mu_{*}\right) \\
& =1 .
\end{aligned}
$$

The above yields that supp $\mu_{*} \subseteq \cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)$. Now, we show that $\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right) \subseteq$ supp $\mu_{*}$. On applying $\mu_{*}=\sum_{k \in T} p_{k} \mu_{*} \circ W_{k}^{-1}$ to supp $\mu_{*}$, we get

1=\mu_{*}\left(\operatorname{supp} \mu_{*}\right)=\sum_{k \in T} p_{k} \mu_{*}\left(W_{k}^{-1}\left(\operatorname{supp} \mu_{*}\right)\right) \leq \sum_{k \in T} p_{k}=1 .

Here, by using the fact that $\sum_{k \in T} p_{k} \mu_{*}\left(W_{k}^{-1}\left(\operatorname{supp} \mu_{*}\right)\right)=1$ and $\sum_{k \in T} p_{k}=1$, we have $\mu_{*}\left(W_{k}^{-1}\left(\operatorname{supp} \mu_{*}\right)\right)=1$ for all $k \in T$. Hence, supp $\mu_{*} \subseteq W_{k}^{-1}\left(\operatorname{supp} \mu_{*}\right)$, which implies that $W_{k}\left(\operatorname{supp} \mu_{*}\right) \subseteq\left(\operatorname{supp} \mu_{*}\right)$ for all $k \in T$. So, $\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right) \subseteq\left(\operatorname{supp} \mu_{*}\right)$. Hence, $\operatorname{supp} \mu_{*}=\cup_{k \in T} W_{k}\left(\operatorname{supp} \mu_{*}\right)$. This completes the proof.

In the next theorem, we obtain bounds for the Hausdorff dimension of associated invariant measures supported on the graph of vector-valued FIF.

Theorem 3.14. Let $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{k}: k \in T\right\}$ be the IFS as defined earlier such that

$$
c_{k} d\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \leq d\left(W_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right), W_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \leq C_{k} d\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right),
$$

where $\left(t_{1}, \boldsymbol{z}_{1}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$ and $0<c_{k} \leq C_{k}<1 \forall k \in T$. Also let $\left(p_{1}, p_{2}, \cdots, p_{N-1}\right)$ be a probability vector corresponding to the IFS $\mathcal{I}$. Then $r \leq \operatorname{dim}_{H}\left(\mu_{*}\right) \leq R$, where $\mu_{*}$ is
an invariant measure corresponding to the IFS $\mathcal{I}$ and $r, R$ are given by $\sum_{k \in T} c_{k}^{r}=1$ and $\sum_{k \in T} C_{k}^{R}=1$, respectively.

Proof. First, we recall the definition of (lower) Hausdorff dimension of measure $\mu_{*}$

\operatorname{dim}_{H}\left(\mu_{*}\right)=\inf \left\{\operatorname{dim}_{H}(A): A \in \mathcal{B}\left(J \times \mathbb{R}^{M}\right) \text { and } \mu_{*}(A)>0\right\}
$$

where $\mathcal{B}\left(J \times \mathbb{R}^{M}\right)$ denotes the set of all Borel-subsets of $J \times \mathbb{R}^{M}$. Theorem 3.13 yields that $\mu_{*}(G(h))=1$. Therefore, by the definition of Hausdorff dimension of measure $\mu_{*}$ and Theorem 3.7, we get

$$

For determining a lower bound of $\operatorname{dim}_{H}\left(\mu_{*}\right)$, let $B$ be any Borel-subset of $J \times \mathbb{R}^{M}$ such that $\operatorname{dim}_{H}(B)<r \leq \operatorname{dim}_{H}(G(h))$. Our aim is to show that $\mu_{*}(B)=0$. We prove it by contradiction. Assume that $\mu_{*}(B)>0$. We define a set $U=\frac{B}{\gamma}$, where $\gamma=\mu_{*}(B)$. So, it is clear that $\mu_{*}(U)=1$. Since $G(h)$ is the support of $\mu_{*}$, therefore, $G(h) \subset U$. Thus, by the monotonic property of Hausdorff dimension, $\operatorname{dim}_{H}(G(h)) \leq \operatorname{dim}_{H}(U)$. Theorem 3.7 gives that $r \leq \operatorname{dim}_{H}(U)$. Since the Hausdorff dimension of a set does not change by scaling by a non-zero constant, therefore, we get $r \leq \operatorname{dim}_{H}(B)$, which is a contradiction. Thus, we have $\mu_{*}(B)=0$. Therefore, by the definition of $\operatorname{dim}_{H}\left(\mu_{*}\right)$, we deduce that $r \leq \operatorname{dim}_{H}\left(\mu_{*}\right)$. Thus, the proof is completed.

In the upcoming result, we establish a more general upper bound for the Hausdorff dimension of invariant measure in terms of the probability vector and the contraction ratios.

Theorem 3.15. Let $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{k}: k \in T\right\}$ be the IFS as defined earlier such that

$$
d\left(W_{k}\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right), W_{k}\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right) \leq C_{k} d\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right)
$$

where $\left(t_{1}, \boldsymbol{z}_{1}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$ and $0<C_{k}<1 \forall k \in T$. Also, let $\left(p_{1}, p_{2}, \cdots, p_{N-1}\right)$ be a probability vector corresponding to the IFS $\mathcal{I}$. Then

$$
\operatorname{dim}_{H}\left(\mu_{*}\right) \leq \frac{\sum_{k \in T} p_{k} \log p_{k}}{\sum_{k \in T} p_{k} \log C_{k}}
$$

where $\mu_{*}$ is the invariant measure corresponding to the IFS $\mathcal{I}$.
Proof. Let $(t, h(t)) \in G(h)$ and let $B((t, h(t)), r)$ be a ball of radius $r$ with center $(t, h(t))$. There is $\sigma=\left(\sigma_{1}, \sigma_{2}, \cdots\right) \in \Omega$ such that $\sigma$ is a code of $(t, h(t))$. Let $q$ be the smallest integer such that

Now, we define two functions $g_{1}, g_{2}: \Omega \rightarrow \mathbb{R}$ such that

where $S_{i}: \Omega \rightarrow \Omega$ is a map defined by $S_{i}(w)=\left(w_{i+1}, w_{i+2}, \cdots\right)$. First, we simplify terms in above equalities

In the next result, we describe some conditions under which vector-valued FIF belongs to the Hölder space.
Theorem 3.16. Let $q_{k} \in \mathcal{H C}^{\sigma}(J)$ for each $k \in T$. Set $a_{\min }:=\min \left\{\left|a_{k}\right|: k \in T\right\}$ and $\alpha_{\max }:=\max \left\{\left|\alpha_{k}\right|: k \in T\right\}$. If $\frac{\alpha_{\max }}{a_{\min }}<1$, then the fractal function $h$ is Hölder continuous with exponent $\sigma$.
Proof. Let us define $\mathcal{H C}_{0}^{\sigma}(J):=\left\{f \in \mathcal{H C}^{\sigma}(J): f\left(x_{1}\right)=\boldsymbol{y}_{1}, f\left(x_{N}\right)=\boldsymbol{y}_{N}\right\}$. By basic real analysis technique, we may see that $\mathcal{H C}_{0}^{\sigma}(J)$ is a closed subset of $\mathcal{H C}^{\sigma}(J)$. Since $\left(\mathcal{H C}^{\sigma}(J),\|\cdot\|_{\mathcal{H C}}\right)$ is a Banach space, it implies that $\mathcal{H C}_{0}^{\sigma}(J)$ will be a complete metric space with respect to metric induced by $\|.\|_{\mathcal{H}}$. We define RB operator $S: \mathcal{H C}_{0}^{\sigma}(J) \rightarrow \mathcal{H C}_{0}^{\sigma}(J)$ by

(S f)(t)=\alpha_{k} f\left(P_{k}^{-1}(t)\right)+q_{k}\left(P_{k}^{-1}(t)\right)
$$

$\forall t \in J_{k}$, where $k \in T$. We shall show that $S$ is well-defined and is a contraction map on $\mathcal{H C}_{0}^{\sigma}(J)$.

{[S f]_{\sigma}=} & \max _{k \in T} \sup _{t_{1} \neq t_{2}, t_{1}, t_{2} \in J_{k}} \frac{\left\|S f\left(t_{1}\right)-S f\left(t_{2}\right)\right\|}{\left|t_{1}-t_{2}\right|^{\sigma}} \\
& \leq \max _{k \in T}\left[\sup _{t_{1} \neq t_{2}, t_{1}, t_{2} \in J_{k}} \frac{\left\|\alpha_{k} f\left(P_{k}^{-1}\left(t_{1}\right)\right)-\alpha_{k} f\left(P_{k}^{-1}\left(t_{2}\right)\right)\right\|}{\left|t_{1}-t_{2}\right|^{\sigma}}\right. \\
& \left.+\sup _{t_{1} \neq t_{2}, t_{1}, t_{2} \in J_{k}} \frac{\left\|q_{k}\left(P_{k}^{-1}\left(t_{1}\right)\right)-q_{k}\left(P_{k}^{-1}\left(t_{2}\right)\right)\right\|}{\left|t_{1}-t_{2}\right|^{\sigma}}\right] \\
& \leq \frac{\alpha_{\max }[f]_{\sigma}}{a_{\min }^{\sigma}}+\frac{[q]_{\sigma}}{a_{\min }^{\sigma}},
\end{aligned}
$$

where $[q]_{\sigma}=\max _{k \in T}\left[q_{k}\right]_{\sigma}$. Let $f, g \in \mathcal{H C}_{0}^{\sigma}(J)$. Then we have

Using Banach contraction mapping theorem, $S$ has a unique fixed point $h \in \mathcal{H C}_{0}^{\sigma}(J)$. This completes the proof.

In the next theorem, we calculate fractal dimensions of the graph of the vector-valued FIF.

Theorem 3.17. Let $\sigma \in(0,1]$ and $q_{k} \in \mathcal{H C}^{\sigma}(J)$ such that

for all $t_{1}, t_{2} \in J, k \in T$ and $C_{q}>0$. Let for each $i \in\{1,2, \cdots, M\}, q_{k, i}$ and $h_{i}$ be the ith component of $q_{k}$ and $h$, respectively. Moreover, if we assume that for each $k \in T$, there are constants $C_{k, i}>0$ and $\delta_{0}>0$ such that for each $t_{1} \in J$ and $0<\delta \leq \delta_{0}$ there exists $t_{2} \in J$ such that $\left|t_{1}-t_{2}\right| \leq \delta$ and

provided $\frac{\alpha_{\max }}{a_{\min }^{\operatorname{m}}}<1$ and $C_{0} a_{\min }^{\sigma}>\alpha_{\max } a_{\max }^{\sigma} h_{q}$ holds, where $C_{0}=\min _{k \in T}\left\{\min _{1 \leq i \leq M} C_{k, i}\right\}$, and $a_{\max }=\max \left\{\left|a_{k}\right|: k \in T\right\}$. Moreover, $\operatorname{dim}_{B}(G(h)) \geq 2-\sigma$.

Proof. Since $\frac{\alpha_{\max }}{a_{\min }}<1$, by Theorem 3.16, we deduce that the fractal function $h \in \mathcal{H C}^{\sigma}(J)$. For $t_{1}, t_{2} \in J$, we have

\end{equation*}

Next, we will give a lower bound of lower box dimension of the graph of $h_{i}$ for each $i \in$ $\{1,2, \cdots, M\}$. Self-referential equation yields that

& \geq\left|q_{k, i}\left(P_{k}^{-1}\left(t_{1}\right)\right)-q_{k, i}\left(P_{k}^{-1}\left(t_{2}\right)\right)\right|-\left|\alpha_{k} h_{i}\left(P_{K}^{-1}\left(t_{1}\right)\right)-\alpha_{k} h_{i}\left(P_{K}^{-1}\left(t_{2}\right)\right)\right|
\end{aligned}
$$

$$
\begin{aligned}
& \geq C_{0} a_{\max }^{-\sigma}\left|t_{1}-t_{2}\right|^{\sigma}-\alpha_{\max } a_{\min }^{-\sigma} h_{q}\left|t_{1}-t_{2}\right|^{\sigma} \\
& =\left(C_{0} a_{\max }^{-\sigma}-\alpha_{\max } a_{\min }^{-\sigma} h_{q}\right)\left|t_{1}-t_{2}\right|^{\sigma} \\
& =R_{0}\left|t_{1}-t_{2}\right|^{\sigma}
\end{aligned}
$$

where $R_{0}=C_{0} a_{\max }^{-\sigma}-\alpha_{\max } a_{\min }^{-\sigma}$. By our assumption, it is clear that $R_{0}>0$. Let $\delta \leq \delta_{1}$. Then we have

\end{equation*}

Using inequalities (3.9), (3.10) and Lemma 3.1, we get our assertion.
Definition 3.18. A vector-valued function $g: J \rightarrow \mathbb{R}^{M}$ is said to be of bounded variation if the total variation $V(g, J)$ of $g$, defined by

V(g, J)=\sup _{\Delta=\left(t_{0}, t_{1}, \ldots, t_{l}\right) \text { partition of } J} \sum_{j=0}^{l-1}\left\|g\left(t_{j}\right)-g\left(t_{j+1}\right)\right\|,

is finite. The space of all vector-valued bounded variation functions on $J$, denoted by $\mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$, forms a Banach space when endowed with the norm $\|g\|_{\mathcal{B} \mathcal{V}}:=\left\|g\left(x_{1}\right)\right\|+V(g, J)$.

In the following theorem, we find out some conditions under which vector-valued FIF becomes a bounded variation function and the Hausdorff dimension and the box dimension of vector-valued FIF is 1 .

Theorem 3.19. Let $q_{k} \in \mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$ for all $k \in T$. Let $\alpha_{\max }=\max \left\{\left|\alpha_{k}\right|: k \in T\right\}$. If $\alpha_{\max }<\frac{1}{(N-1)}$, then $h \in \mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$. Moreover, $\operatorname{dim}_{H}(G(h))=\operatorname{dim}_{B}(G(h))=1$, and either $\operatorname{dim}_{H}\left(\mu_{*}\right)=1$ or the 1-dimensional Hausdorff measure $\left(\mathcal{H}^{1}\right)$ is absolutely continuous with respect to $\mu_{*}$.

Proof. First, we define a set $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)=\left\{f \in \mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right): f\left(x_{1}\right)=\boldsymbol{y}_{1}, f\left(x_{N}\right)=\boldsymbol{y}_{N}\right\}$. It is easily seen that $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$ is a closed subset of $\mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$. Since $\mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$ is a Banach space, $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$ is a complete metric space with respect to the metric induced by norm $\|f\|_{\mathcal{B} \mathcal{V}}:=\left\|f\left(x_{1}\right)\right\|+V(f, J)$. We define an operator $S: \mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right) \rightarrow \mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$ by

(S f)(t)=\alpha_{k} f\left(P_{k}^{-1}(t)\right)+q_{k}\left(P_{k}^{-1}(t)\right)
$$

$\forall t \in J_{k}$ and $k \in T$. Consider a partition $\Delta=\left\{t_{0}, t_{1}, \cdots, t_{l}\right\}$ of $J_{k}$, where $k \in T$ and $l \in \mathbb{N}$. For $f, g \in \mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$, we have

& \leq \alpha_{\max }\left\|(f-g)\left(P_{k}^{-1}\left(t_{j}\right)\right)-(f-g)\left(P_{k}^{-1}\left(t_{j+1}\right)\right)\right\| .

In the above, by taking sum from $j=0$ to $j=l-1$, we get

The above inequality is true for any partition $\Delta$ of $J_{k}$ and $k \in T$. Thus, we deduce that

So, $S$ is a well defined operator on $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$ and by our hypothesis, it is clear that $\alpha_{\max }(N-1)<1$. Therefore, $S$ is a contraction map on the complete metric space $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$. By virtue of the Banach contraction mapping theorem, $S$ has a unique fixed point $h \in$ $\mathcal{B} \mathcal{V}_{0}\left(J, \mathbb{R}^{M}\right)$.

Suppose $\mathcal{H}^{1}$ is not absolutely continuous with respect to $\mu_{*}$. Then there exists a set $A$ such that $\mu_{*}(A)=0$ but $\mathcal{H}^{1}(A)>0$. This yields that $\operatorname{dim}_{H}\left(\mu_{*}\right) \geq 1$. Since $\operatorname{dim}_{H}\left(\mu_{*}\right) \leq$ $\operatorname{dim}_{H}(G(h))=1$, we have $\operatorname{dim}_{H}\left(\mu_{*}\right)=1$. This completes the proof.

Next, we define the absolutely continuous function space for vector-valued functions. The space of all absolutely continuous vector-valued functions on $J$ is denoted by $\mathcal{A C}\left(J, \mathbb{R}^{M}\right)$. We define a norm on $\mathcal{A C}\left(J, \mathbb{R}^{M}\right)$ as follows:

$$
\|f\|_{\mathcal{A C}}=\left\|f\left(x_{1}\right)\right\|+\int_{x_{1}}^{x_{N}}\left\|f^{\prime}(x)\right\| d x
$$

where $f \in \mathcal{A C}\left(J, \mathbb{R}^{M}\right)$. Then $\mathcal{A C}\left(J, \mathbb{R}^{M}\right)$ forms a Banach space under the norm $\|\cdot\|_{\mathcal{A C}}$.
In the upcoming result, we obtain some conditions under which vector-valued FIF belongs to the absolutely continuous function space, and also compute fractal dimension of the graph of vector-valued FIF.

Theorem 3.20. Let $q_{k} \in \mathcal{A C}\left(J, \mathbb{R}^{M}\right)$ for each $k \in T$. Set $a_{\min }:=\min \left\{\left|a_{k}\right|: k \in T\right\}$ and $\alpha_{\max }:=\max \left\{\left|\alpha_{k}\right|: k \in T\right\}$. If $\alpha_{\max }<\frac{a_{\min }}{(N-1)}$, then the fractal function $h$ is also in $\mathcal{A C}\left(J, \mathbb{R}^{M}\right)$. Moreover, $\operatorname{dim}_{H}(G(h))=\operatorname{dim}_{B}(G(h))=1$.
Proof. One can easily prove this theorem by using the similar arguments as in the proof of Theorem 3.19,

Next, for $\alpha \geq 1$, we define a function space as follows:

$$
V_{\alpha}\left(J, \mathbb{R}^{M}\right)=\left\{f \in C\left(J, \mathbb{R}^{M}\right):\|f\|_{\alpha}<\infty\right\} .
$$

Then, by Lemma 3.1 in [10, $\left(V_{\alpha}\left(J, \mathbb{R}^{M}\right),\|\cdot\|_{\alpha}\right)$ is a complete metric space, where

$$
\|f\|_{\alpha}=\|f\|_{\infty}+\sup _{n \in \mathbb{N}} \frac{\sum_{|O|=2^{-n}} R_{f}(O)}{2^{n(\alpha-1)}},
$$

where $R_{f}(O)=\sup _{t_{1}, t_{2} \in O}\left\|f\left(t_{1}\right)-f\left(t_{2}\right)\right\|$ for $O \subseteq J$.
Lemma 3.21. If $\left|P_{k}(J)\right|=\frac{1}{2^{r_{k}}}$ for some $r_{k} \in \mathbb{N}$ with $\sum_{k \in T} \frac{1}{2^{r^{k}}}=1$, then for $n \geq \max _{k \in T}\left\{r_{k}\right\}$, we have

$$
\sum_{|O|=2^{-n}} R_{f}(O)=\sum_{k \in T} \sum_{|O|=2^{-n}, O \subset P_{k}(J)} R_{f}(O)
$$

Proof. One can easily prove this lemma.

Theorem 3.22. Let $q_{k} \in V_{\alpha}\left(J, \mathbb{R}^{M}\right) \forall k \in T$ and let $\left|P_{k}(J)\right|=\frac{1}{2^{2} k}$ for some $r_{k} \in \mathbb{N}$ with $\sum_{k \in T} \frac{1}{2^{r_{k}}}=1$. Then $h \in V_{\alpha}\left(J, \mathbb{R}^{M}\right)$, provided $\sum_{k \in T}\left|\alpha_{k}\right|<1$.

Proof. Let $V_{\alpha}^{0}(J)=\left\{f \in V_{\alpha}\left(J, \mathbb{R}^{M}\right): f\left(x_{1}\right)=\boldsymbol{y}_{1}\right.$ and $\left.f\left(x_{N}\right)=\boldsymbol{y}_{N}\right\}$. From the definition of $V_{\alpha}^{0}(J)$, it is clear that $V_{\alpha}^{0}(J)$ is a closed subset of $V_{\alpha}\left(J, \mathbb{R}^{M}\right)$. Therefore, $V_{\alpha}^{0}(J)$ is a complete metric space with respect to metric induced by norm $\|.\|_{\alpha}$. We define RB operator $S: V_{\alpha}^{0}(J) \rightarrow V_{\alpha}^{0}(J)$ by

$$
(S f)(t)=\alpha_{k} f\left(P_{k}^{-1}(t)\right)+q_{k}\left(P_{k}^{-1}(t)\right)
$$

$\forall t \in J_{k}$ and $k \in T$. In the light of the assumptions taken, it is clear that $S$ is well-defined. Let $f, g \in V_{\alpha}^{0}(J)$. By applying lemma 3.21, we have

$$
\begin{aligned}
\|S f-S g\|_{\alpha} & =\|S f-S g\|_{\infty}+\sup _{n \in \mathbb{N}} \frac{\sum_{|O|=2^{-n}} R_{(S f-S g)}(O)}{2^{n(\alpha-1)}} \\
& \leq \alpha_{\max }\|f-g\|_{\infty}+\sum_{k \in T}\left|\alpha_{k}\right| \sup _{n \in \mathbb{N}} \frac{\sum_{|O|=2^{-n}} R_{(f-g)}(O)}{2^{n(\alpha-1)}} \\
& \leq \sum_{k \in T}\left|\alpha_{k}\right|\left(\|f-g\|_{\infty}+\sup _{n \in \mathbb{N}} \frac{\sum_{|O|=2^{-n}} R_{(f-g)}(O)}{2^{n(\alpha-1)}}\right) \\
& =\sum_{k \in T}\left|\alpha_{k}\right|\|f-g\|_{\alpha} .
\end{aligned}
$$

Since $\sum_{k \in T}\left|\alpha_{k}\right|<1, S$ is a contraction map on $V_{\alpha}^{0}(J)$. Applying the Banach contraction mapping theorem, operator $S$ has a unique fixed point $h$ in $V_{\alpha}^{0}(J)$. Furthermore, the function $h$ satisfies self-referential equation, that is,

$$
h(t)=\alpha_{k} h\left(P_{k}^{-1}(t)\right)+q_{k}\left(P_{k}^{-1}(t)\right),
$$

$\forall t \in J_{k}$ and $k \in T$. This completes the proof.

Remark 3.23. Let us consider functions $\mathbf{f}, \mathbf{g}:[0,1] \rightarrow \mathbb{R}^{2}$ such that $\mathbf{f}=\left(h_{1}, 0\right), \mathbf{g}=\left(0, h_{2}\right)$, where $h_{1}$ and $h_{2}$ are coordinate functions of the Peano space filling curve. It is simple to deduce that ( see [15])

$$
\overline{\operatorname{dim}}_{B}(G(\mathbf{f}))=\overline{\operatorname{dim}}_{B}\left(G\left(h_{1}\right)\right)=1.5 \text { and } \overline{\operatorname{dim}}_{B}(G(\mathbf{g}))=\overline{\operatorname{dim}}_{B}\left(G\left(h_{2}\right)\right)=1.5
$$

and

$$
\overline{\operatorname{dim}}_{B}(G(\mathbf{f}+\mathbf{g}))=\overline{\operatorname{dim}}_{B}\left(G\left(h_{1}, h_{2}\right)\right)=2
$$

So, we conclude that the inequality

$$
\overline{\operatorname{dim}}_{B}(G(\mathbf{f}+\mathbf{g})) \leq \max \left\{\overline{\operatorname{dim}}_{B}(G(\mathbf{f})), \overline{\operatorname{dim}}_{B}(G(\mathbf{g}))\right\}=1.5
$$

does not hold for vector-valued functions in contrast to its real-valued setting [10, Lemma 2.1]. It hints that the space $\left\{f \in \mathcal{C}\left([a, b], \mathbb{R}^{M}\right): \overline{\operatorname{dim}}_{B}(G(\mathbf{f})) \leq \beta\right\}$ will not be a vector space for $M \geq 2$. Thus, the result of Falconer and Fraser [10] cannot be generalized to vector-valued continuous functions.

Thus, due to the above remark, the next result is valid only for real-valued setting. In the next result, we determine an upper bound for the upper box dimension of the graph of real-valued fractal interpolation functions.

Theorem 3.24. Let $q_{k} \in V_{\alpha+\frac{1}{n}}(J, \mathbb{R}) \forall k \in T, n \in \mathbb{N}$ and let $\left|P_{k}(J)\right|=\frac{1}{2^{r} k}$ for some $r_{k} \in \mathbb{N}$ with $\sum_{k \in T} \frac{1}{2^{r} k}=1$. If $\sum_{k \in T}\left|\alpha_{k}\right|<1$, then $\overline{\operatorname{dim}}_{B}(G(h)) \leq \alpha$.

Proof. In Theorem3.22, if we take $N=1$ and replace $\alpha$ by $\alpha+\frac{1}{n}$, then we get $h \in V_{\alpha+\frac{1}{n}}(J, \mathbb{R})$ for all $n \in \mathbb{N}$. By [10, Proposition 3.4], we have

$$
\left\{f \in \mathcal{C}(J, \mathbb{R}): \overline{\operatorname{dim}}_{B}(G(f)) \leq \alpha\right\}=\bigcap_{n \in \mathbb{N}} V_{\alpha+\frac{1}{n}}(J, \mathbb{R})
$$

Therefore, from the above equality, we can deduce that $\overline{\operatorname{dim}}_{B}(G(h)) \leq \alpha$. This completes the proof.

## 4. Riemann-Liouville fractional integral

In this Section, first we define the Riemann-Liouville fractional integral of a vector-valued function.

Definition 4.1. Let $\mathbf{f}$ be a vector-valued integrable function on a closed interval $[a, b]$. The Riemann-Liouville fractional integral of $\mathbf{f}$ is defined as

$$
{ }_{a} \mathfrak{I}^{\beta} \mathbf{f}(t)=\left({ }_{a} \mathfrak{I}^{\beta} f_{1}(t),{ }_{a} \mathfrak{I}^{\beta} f_{2}(t), \ldots,{ }_{a} \mathfrak{I}^{\beta} f_{M}(t)\right)
$$

where

$$
{ }_{a} \mathfrak{I}^{\beta} f_{i}(t)=\frac{1}{\Gamma(\beta)} \int_{a}^{t}(t-\eta)^{\beta-1} f_{i}(\eta) \mathrm{d} \eta, \text { for } i=1,2, \ldots, M
$$

and $\beta>0$.
The following theorem can be deduced from Liang [16].
Theorem 4.2. For $0<a<b<\infty$ and $0<\beta<1$. If $\boldsymbol{f} \in \mathcal{C}\left([a, b], \mathbb{R}^{M}\right) \cap \mathcal{B} \mathcal{V}\left([a, b], \mathbb{R}^{M}\right)$, then ${ }_{a} \mathfrak{I}^{\beta} \boldsymbol{f} \in \mathcal{C}\left([a, b], \mathbb{R}^{M}\right) \cap \mathcal{B} \mathcal{V}\left([a, b], \mathbb{R}^{M}\right)$.

There are several works on fractal dimension of fractional integral of a real-valued continuous functions, see, for instance, [7, 17, 19, 20]. Let us note the following inequality:

$$
\|\mathbf{f}(x)-\mathbf{f}(y)\|_{2} \leq \sqrt{M} \max _{1 \leq i \leq M}\left|f_{i}(x)-f_{i}(y)\right| \leq \sqrt{M} L_{\mathbf{f}}|x-y|^{\sigma}
$$

where $f_{i}$ denotes the $i$-th coordinate function of the vector-valued function $\mathbf{f}, L_{\mathbf{f}}=\max \left\{L_{f_{1}}\right.$, $\left.L_{f_{2}}, \ldots, L_{f_{M}}\right\}$ and $L_{f_{i}}$ is the Hölder constant of $f_{i}$. Using [18] and the above inequality, we can immediately obtain the next remark. Hence, we omit the proof.
Remark 4.3. Let $\mathbf{f}:[a, b] \rightarrow \mathbb{R}^{M}$ be a continuous function.
(1) If $0<\beta<1$, then

$$
1 \leq \operatorname{dim}_{H}\left(\mathrm{G}\left({ }_{a} \mathfrak{I}^{\beta} f_{i}\right)\right) \leq \overline{\operatorname{dim}}_{B}\left(\mathrm{G}\left({ }_{a} \mathfrak{J}^{\beta} f_{i}\right)\right) \leq 2-\beta
$$

(2) If $\beta \geq 1$, then

$$
\operatorname{dim}_{H}\left(\mathrm{G}\left({ }_{a} \mathfrak{I}^{\beta} \mathbf{f}\right)\right)=\operatorname{dim}_{B}\left(\mathrm{G}\left({ }_{a} \mathfrak{I}^{\beta} \mathbf{f}\right)\right)=1
$$

In the following theorem, we prove that the Riemann-Liouville fractional integral of a vector-valued FIF is again a vector-valued FIF corresponding to different data set and show the existence of a unique Borel probability measure supported on the graph of ${ }_{x_{1}} \Im^{\beta} h$.

Theorem 4.4. Let $h$ be the FIF determined by the IFS mentioned before in Section 2. Then ${ }_{x_{1}} \mathfrak{I}^{\beta} h$ is the FIF associated to the the IFS $\mathcal{J}_{1}=\left\{J \times \mathbb{R}^{M}: H_{1}, H_{2}, \ldots, H_{N-1}\right\}$ with data set $\left\{\left(x_{i}, x_{1} \mathfrak{I}^{\beta} h\left(x_{i}\right)\right): i \in 1,2, \cdots, N\right\}$, where $H_{k}(t, \boldsymbol{z})=\left(P_{k}(t), F_{k}^{\prime}(t, \boldsymbol{z})\right)$ for $k \in T$ and $P_{k}(t)$ and $F_{k}^{\prime}(t, \boldsymbol{z})$ are defined as follows

$$
P_{k}(t)=a_{k} t+d_{k}, \quad F_{k}^{\prime}(t, \boldsymbol{z})=a_{k}^{\beta} \alpha_{k} \boldsymbol{z}+Q_{k}(t)
$$

where $a_{k}, \alpha_{k}, d_{k}$ are defined as above, $Q_{k}(t):=\left(Q_{k, 1}(t), Q_{k, 2}(t), \ldots, Q_{k, M}(t)\right)$ is vectorvalued continuous function on $J$ and for each $i \in\{1,2, \cdots, M\}$

$$
Q_{k, i}(t)=\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta+\frac{a_{k}^{\beta}}{\Gamma(\beta)} \int_{x_{1}}^{t}(t-\eta)^{\beta-1} q_{k, i}(\eta) \mathrm{d} \eta
$$

Furthermore, let $\left(p_{1}, p_{2}, \cdots, p_{N-1}\right)$ be a probability vector corresponding to the IFS $\mathcal{J}_{1}$. Then there exist a unique Borel probability measure $\mu^{*}$ supported on the graph $G\left({ }_{x_{1}} \mathfrak{J}^{\beta} h\right)$ such that

$$
\mu^{*}=\sum_{k \in T} p_{k} \mu^{*} \circ H_{k}^{-1}
$$

Proof. Let us first recall the functional equation satisfied by the FIF $h$ :

$$
h\left(P_{k}(t)\right)=\alpha_{k} h(t)+q_{k}(t), \forall t \in J, k \in T
$$

Now, for coordinate function $h_{i}$ of $h$, we have

$$
\begin{aligned}
x_{1} & \mathfrak{I}^{\beta} h_{i}\left(P_{k}(t)\right) \\
& =\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}(t)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta \\
& =\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta+\frac{1}{\Gamma(\beta)} \int_{P_{k}\left(x_{1}\right)}^{P_{k}(t)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta \\
& =\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta+\frac{a_{k}}{\Gamma(\beta)} \int_{x_{1}}^{t}\left(P_{k}(t)-P_{k}(\eta)\right)^{\beta-1} h_{i}\left(P_{k}(\eta)\right) \mathrm{d} \eta \\
& =\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta+\frac{a_{k}^{\beta} \alpha_{k}}{\Gamma(\beta)} \int_{x_{1}}^{t}(t-\eta)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta \\
& +\frac{a_{k}^{\beta}}{\Gamma(\beta)} \int_{x_{1}}^{t}(t-\eta)^{\beta-1} q_{k, i}(\eta) \mathrm{d} \eta \\
& =a_{k}^{\beta} \alpha_{k} x_{1} \mathfrak{I}^{\beta} h_{i}(t)+\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta \\
& +\frac{a_{k}^{\beta}}{\Gamma(\beta)} \int_{x_{1}}^{t}(t-\eta)^{\beta-1} q_{k, i}(\eta) \mathrm{d} \eta \\
& =a_{k}^{\beta} \alpha_{k} \mathfrak{I}_{1}^{\beta} h_{i}(t)+Q_{k, i}(t)
\end{aligned}
$$

where $Q_{k, i}(t)=\frac{1}{\Gamma(\beta)} \int_{x_{1}}^{P_{k}\left(x_{1}\right)}\left(P_{k}(t)-\eta\right)^{\beta-1} h_{i}(\eta) \mathrm{d} \eta+\frac{a_{k}^{\beta}}{\Gamma(\beta)} \int_{x_{1}}^{t}(t-\eta)^{\beta-1} q_{k, i}(\eta) \mathrm{d} \eta$. In the third line we use $\eta=P_{k}(t)$ and $P_{k}(t)=a_{k} t+d_{k}$. Fourth line follows by the functional equation: $h_{i}\left(P_{k}(t)\right)=\alpha_{k} h_{i}(t)+q_{k, i}(t)$ and $P_{k}(t)-P_{k}(\eta)=a_{k}(t-\eta)$. Set $Q_{k}(t):=$ $\left(Q_{k, 1}(t), Q_{k, 2}(t), \ldots, Q_{k, M}(t)\right)$. Then, from the above equation of ${ }_{x_{1}} \mathfrak{I}^{\beta} h_{i}\left(P_{k}(t)\right)$, we may write

$$
x_{1} \mathfrak{I}^{\beta} h\left(P_{k}(t)\right)=a_{k}^{\beta} \alpha_{k x_{1}} \mathfrak{I}^{\beta} h(t)+Q_{k}(t) .
$$

This shows that the Riemann-Liouville fractional integral ${ }_{x_{1}} \mathfrak{I}^{\beta} h$ of the FIF $h$ is again an FIF generated by the IFS $\mathcal{J}_{1}=\left\{J \times \mathbb{R}^{M} ; H_{1}, H_{2}, \ldots, H_{N-1}\right\}$ where $H_{k}(t, \boldsymbol{z})=\left(P_{k}(t), F_{k}^{\prime}(t, \boldsymbol{z})\right)$ for $k \in T$ and $P_{k}(t)$ and $F_{k}^{\prime}(t, \boldsymbol{z})$ are defined as follows

$$
\begin{gathered}
P_{k}(t)=a_{k} t+d_{k} \\
F_{k}^{\prime}(t, \boldsymbol{z})=a_{k}^{\beta} \alpha_{k} \boldsymbol{z}+Q_{k}(t)
\end{gathered}
$$

In order to show the other part of the theorem, we first define a metric $d_{0}$ on $J \times \mathbb{R}^{M}$ as follows :

$$
d_{0}\left(\left(t_{1}, \boldsymbol{z}_{\mathbf{1}}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right)\right)=\left|t_{1}-t_{2}\right|+\left\|\left(\boldsymbol{z}_{\mathbf{1}}-{ }_{x_{1}} \mathfrak{I}^{\beta} h\left(t_{1}\right)\right)-\left(\boldsymbol{z}_{\mathbf{2}}-{ }_{x_{1}} \mathfrak{I}^{\beta} h\left(t_{2}\right)\right)\right\|
$$

for all $\left(t_{1}, \boldsymbol{z}_{1}\right),\left(t_{2}, \boldsymbol{z}_{\mathbf{2}}\right) \in J \times \mathbb{R}^{M}$. Then, it is easy to show that $\left(J \times \mathbb{R}^{M}, d_{0}\right)$ is a complete metric space. Following Theorem [3.6, the map $H_{k}: J \times \mathbb{R}^{M} \rightarrow J \times \mathbb{R}^{M}$ is a contraction map with contraction ratio $s_{k}=\max \left\{\left|a_{k}\right|,\left|a_{k}^{\beta} \alpha_{k}\right|\right\}$ with respect to metric $d_{0}$ on $J \times \mathbb{R}^{M}$. Now, on similar lines of the proof of Theorem 3.13, one can easily prove the existence of a unique measure supported on the graph $G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h\right)$ such that

$$
\mu^{*}=\sum_{k \in T} p_{k} \mu^{*} \circ H_{k}^{-1}
$$

Thus, the proof is complete.
Next, we give an example, which ensures that it is not generally true that $\mu_{*}$ is absolutely continuous with respect to $\mu^{*}$ or $\mu^{*}$ is absolutely continuous with respect to $\mu_{*}$.
Example 4.5. Let $f:[0,1] \rightarrow \mathbb{R}$ be such that $f(t)=1 \forall t \in[0,1]$. Let ${ }_{0} \mathfrak{I}^{\beta} f$ be the Riemann-Liouville fractional integral of $f$. Then

$$
{ }_{0} \mathfrak{I}^{\beta} f(t)=\frac{1}{\Gamma(\beta)} \int_{o}^{t}(t-\eta)^{\beta-1} f(\eta) \mathrm{d} \eta=\frac{t^{\beta}}{\Gamma(\beta+1)}
$$

For $\beta=1,{ }_{0} \mathfrak{I}^{1} f(t)=t$. Let $\mu_{1}$ and $\mu_{2}$ be the Borel probability measure supported on the graphs of $f$ and ${ }_{0} \mathfrak{I}^{1} f$, respectively. Therefore, $\mu_{1}(G(f))=\mu_{2}\left(G\left({ }_{0} \mathfrak{I}^{1} f\right)\right)=1$ and $\mu_{1}\left(G\left({ }_{0} \mathfrak{I}^{1} f\right)\right)=\mu_{2}(G(f))=0$. From this, it is clear that $\mu_{1}$ is not absolutely continuous with respect to $\mu_{2}$ and also $\mu_{2}$ is not absolutely continuous with respect to $\mu_{1}$.

In the next theorem, we estimate the Hausdorff dimension and the box-counting dimension of the graph of the Riemann-Liouville fractional integral of a vector-valued FIF and without any assumption, we also determine an upper bound of the Hausdorff dimension of invariant measures supported on the graph of ${ }_{x_{1}} \mathfrak{I}^{\beta} h$.

Theorem 4.6. Let $\mathcal{I}:=\left\{J \times \mathbb{R}^{M} ; W_{i}: i \in T\right\}$ be the IFS as defined earlier. Set $\alpha_{\max }=$ $\left\{\left|\alpha_{k}\right|: k \in T\right\}$ and $a_{\text {min }}:=\min \left\{\left|a_{k}\right|: k \in T\right\}$.
(1) If $q_{k} \in \mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$ for all $k \in T$ and $\alpha_{\max }<\frac{1}{(N-1)}$, then for $0<\beta<1,{ }_{x_{1}} \mathfrak{I}^{\beta} h \in$ $\mathcal{C}\left(J, \mathbb{R}^{M}\right) \cap \mathcal{B} \mathcal{V}\left(J, \mathbb{R}^{M}\right)$. Moreover,

\operatorname{dim}_{H}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h\right)\right)=\operatorname{dim}_{B}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h\right)\right)=1

(2) Let $q_{k} \in \mathcal{H C}^{\sigma}(J)$ for each $k \in T$, where $\sigma \in(0,1)$ and $\frac{\alpha_{\max }}{a_{\min }^{\sigma}}<1$.
(i) If $0<\beta<1$ and $\beta+\sigma \leq 1$, then ${ }_{x_{1}} \mathfrak{I}^{\beta} h \in \mathcal{H C}^{\beta+\sigma}(J)$. Furthermore, $1 \leq \operatorname{dim}_{H}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h_{i}\right)\right) \leq \overline{\operatorname{dim}}_{B}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h_{i}\right)\right) \leq 2-\beta-\sigma \forall i \in\{1,2, \cdots, M\}$.
(ii) If $\beta+\sigma>1$, then ${ }_{x_{1}} \mathfrak{I}^{\beta} h$ is differentiable on $J$ and

\operatorname{dim}_{H}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h\right)\right)=\operatorname{dim}_{B}\left(G\left({ }_{x_{1}} \mathfrak{I}^{\beta} h\right)\right)=1
$$

Moreover, $\frac{d}{d t} x_{1} \mathfrak{I}^{\beta} h(t) \in \mathcal{H C}^{\beta+\sigma-1}(J)$ and

1 \leq \operatorname{dim}_{H}\left(G\left(\frac{d}{d t} x_{1} \mathfrak{I}^{\beta} h_{i}\right)\right) \leq \overline{\operatorname{dim}}_{B}\left(G\left(\frac{d}{d t} x_{1} \mathfrak{I}^{\beta} h_{i}\right)\right) \leq 3-\beta-\sigma \forall i \in\{1,2, \cdots, M\}
$$

\operatorname{dim}_{H}\left(\mu^{*}\right) \leq \frac{\sum_{k \in T} p_{k} \log p_{k}}{\sum_{k \in T} p_{k} \log s_{k}},
$$

where $\mu^{*}$ is an invariant measure corresponding to the $\operatorname{IFS} \mathcal{J}_{1}$ and support of $\mu^{*}$ is the graph $G\left(x_{1} \mathfrak{I}^{\beta} h\right)$.

Proof. (1) By using Theorem 3.19 and [16, Lemma 2.2], we get our required result.
(2) In the light of Theorem 3.16 and [20, Theorem 2.1], one can easily get this result.
(3) One can easily prove this part by following the proof of Theorem 3.15,

Remark 4.7. The previous result should be compared with Theorem 4 of [25], wherein for a linear FIF $h$, which is determined by

\left\{L_{i}(x), F_{i}(x, y)\right\}_{i=1}^{N-1}, \text { where } L_{i}(x)=a_{i} x+b_{i} \text { and } F_{i}(x, y)=d_{i} y+q_{i}(x)

are such that $\sum_{i=1}^{N-1}\left|d_{i}\right|>1$ and $\operatorname{dim}_{B}(G(h))=D\left(\left\{a_{i}, d_{i}\right\}\right)$, where $D\left(\left\{a_{i}, d_{i}\right\}\right)$ is a unique number $t$ satisfying the equation $\sum_{i=1}^{N-1}\left|d_{i}\right| a_{i}^{t-1}=1$, it is shown that

$$
\operatorname{dim}_{B}\left(G\left(x_{1} \mathfrak{I}^{\alpha} h\right)\right)=\operatorname{dim}_{B}(G(h))-\alpha,
$$

for any $0<\alpha<D\left(\left\{a_{i}, d_{i}\right\}\right)-1$, provided $\operatorname{dim}_{B}\left(G\left({ }_{x_{1}} \mathfrak{\Im}^{\alpha} q_{i}\right)\right)=1$ for any $1 \leq i \leq N-1$ and $\operatorname{dim}_{B}\left(G\left(x_{1} \mathfrak{I}^{\alpha} h\right)\right)>1$. Here we evaluate the Hausdorff and box dimension of the graph of the Riemann-Liouville fractional integral of FIFs by imposing less conditions as compared to [25, Theorem 4]. Let us summarize the above discussion as follows: Ruan [25] has calculated the exact value of the box dimension of the graph of fractional integral of a linear FIF, however, we obtain an upper bound of the graph of fractional integral of a fractal function belonging to a more general class of fractal functions than linear FIFs.
