# Stability, uniqueness and existence of solutions to McKean-Vlasov SDEs in arbitrary moments

#### Abstract

We deduce stability and pathwise uniqueness for a McKean-Vlasov equation with random coefficients and a multidimensional Brownian motion as driver. Our analysis focuses on a non-Lipschitz drift coefficient and includes moment estimates for random Itô processes that are of independent interest. For deterministic coefficients we provide unique strong solutions, even if the drift fails to be of affine growth. The theory that we develop rests on Itô's formula and leads to $p$-th moment and pathwise $\alpha$-exponential stability for $p \geq 2$ and $\alpha>0$ with explicit Lyapunov exponents, regardless of whether a Lyapunov function exists.

## 1 Introduction

The study of McKean-Vlasov stochastic differential equations (McKean-Vlasov SDEs), also called mean-field SDEs, was initiated by Kac [21], McKean [29] and Vlasov [32]. Since then, these integral equations gained much interest in a variety of fields such as physics, economics, finance and mathematics. A crucial reason for this is the fact they can be used to model the propagation of chaos of interacting particles in a plasma, as shown in [32]. In the context of applications of these types, questions regarding stability, uniqueness and existence of solutions arise. To give precise answers under verifiable conditions, we continue our analysis of the companion paper [23] and present new methods.

Let $d, m \in \mathbb{N}$ and $\left(\Omega, \mathscr{F},\left(\mathscr{F}_{t}\right)_{t \in \mathbb{R}_{+}}, P\right)$ be a filtered probability space that satisfies the usual conditions and on which there is a standard $d$-dimensional $\left(\mathscr{F}_{t}\right)_{t \in \mathbb{R}_{+}}$-Brownian motion $W$. Then a McKean-Vlasov equation can be written in the form

\end{equation*}

Thereby, $b$ and $\sigma$ are two measurable maps on $\mathbb{R}_{+} \times \mathbb{R}^{m} \times \mathscr{P}\left(\mathbb{R}^{m}\right)$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively, $P_{X}$ denotes the law map of the solution process $X$ and, as usually, $\mathscr{P}\left(\mathbb{R}^{m}\right)$ stands for the convex space of all Borel probability measures on $\mathbb{R}^{m}$.

The theory of mean-field SDEs has in fact undergone groundbreaking developments since the works of [21], [29] and [32] and proven to be an indispensable mathematical

[^0]tool. For instance, another important application in physics pertains to the analysis of incompressible Navier-Stokes equations that were considered in the classical work [26] by Leray and which have a deep link with mean-field SDEs, according to Constantin and Iyer [15. Recently, this connection was further explored by Röckner and Zhao [31.

Moreover, mean-field games, studied by Lasry and Lions [25, serve as applications in economics and may be used to explain the interaction and behaviour of agents in a vast network. For other works related to mean-field games we refer to [7], [8, [11, [9] and [10]. Regarding applications in finance, see [12], [13], [16], [17] and [24] in connection with systemic risk modelling.

Over the years, mean-field SDEs were studied from a mathematical point of view under various assumptions on the type of noise and the regularity of the coefficients. While the authors in [20] consider Lévy noise, results on unique strong solutions, based on additive Gaussian noise and a discontinuous drift, were established in [3], 1] and [2], by using Malliavin calculus. Results on weak solutions can be found in [19], 14] and [30. In [27] even path-dependent coefficient are treated. It is worth pointing out that mean-field equations of backward type were considered in [4] and [5], and infinite-dimensional partial differential equation (PDEs) related to mean-field SDEs were derived in 66.

In the sequel, let $t_{0} \in \mathbb{R}_{+}$and $\mathscr{P}$ be a separable metrisable topological space in $\mathscr{P}\left(\mathbb{R}^{m}\right)$. For $p \in[2, \infty)$ the Polish space $\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$ of all measures in $\mathscr{P}\left(\mathbb{R}^{m}\right)$ with a finite $p$-th moment, endowed with the $p$-th Wasserstein metric, serves as our main application. Further, assume that along with $\mathscr{P}$ the maps

are admissible in a suitable measurable sense, as explained in Section 2, We shall focus on the following generalised McKean-Vlasov SDE with such random drift and diffusion coefficients:

d X_{t}=\mathrm{B}_{t}\left(t, X_{t}, P_{X_{t}}\right) d t+\Sigma_{t}\left(X_{t}, P_{X_{t}}\right) d W_{t} \quad \text { for } t \in\left[t_{0}, \infty\right) . \tag{1.2}
\end{equation*}
$$

In particular, if $\Sigma$ does not depend on the measure variable $\mu \in \mathscr{P}$, then we recover the setting of the previous work [23], in which a multidimensional Yamada-Watanabe approach was developed.

The objective of this paper is to deduce stability, uniqueness and existence of solutions to (1.2), by presenting methods that handle the dependence of the diffusion coefficient with respect to the measure variable and, at the same time, allow for an irregular drift. Essentially, our contributions to the existing literature can be listed as follows:
(1) Pathwise uniqueness for (1.2) is concisely shown in Corollary 3.4 if B and $\Sigma$ satisfy an Osgood condition that is only partially restrictive for B . In the specific case that both coefficients are independent of $\mu \in \mathscr{P}$, turning (1.2) into an SDE, this condition is required on compact sets only.
(2) As a consequence of the explicit $L^{p}$-comparison estimate for (1.2) in Proposition 3.9, we obtain (asymptotic) p-th moment stability in Corollary 3.11 under partial and complete mixed continuity Hölder conditions on B and $\Sigma$, respectively, and transparent integrability hypotheses on the random partial Hölder coefficients with respect to $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$.
(3) Exponential p-th moment stability follows from Corollary 3.12 if partial and complete Lipschitz conditions hold for B and $\Sigma$, respectively, and the stability factor in (3.9), which can be viewed as functional of the partial Lipschitz coefficients, does not exceed a sum of power functions. The crucial fact is that this result provides explicit p-th moment Lyapunov exponents.
(4) Pathwise exponential stability is shown in Corollary 3.16 under the just mentioned Lipschitz conditions on $B$ and $\Sigma$ with deterministic partial Lipschitz coefficients of certain growth and the same bound involving a sum of power functions for the stability factor $\gamma_{p q, \mathscr{P}}$ in (3.15), where $q \in[2, \infty)$. Then the pathwise Lyapunov exponent agrees with the pq-th moment Lyapunov exponent divided by pq.
(5) As the companion paper [23], this work demonstrates that for a detailed stability analysis of McKean-Vlasov equations verifiable assumptions can be given and the existence of Lyapunov functions does not have to be taken for granted.
(6) Unique strong solutions are derived in Theorem 3.23 under the hypotheses that B and $\Sigma$ are deterministic, an Osgood growth or an affine growth estimate that is only partially restrictive for B holds and partial and complete Lipschitz conditions are satisfied by B and $\Sigma$, respectively. Thus, B is not forced to be of affine growth or Lipschitz continuous relative to $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$, as justified in Example 3.25 involving integral maps.

We note that the contributions (1), (4) and (6) are comparable to those in [23] if we assume for the moment that $\Sigma$ is independent of $\mu \in \mathscr{P}$. In this case, the pathwise uniqueness assertions of Corollary 3.9 in [23] are applicable when $\Sigma$ merely satisfies an Osgood condition on compact sets with random regularity coefficients relative to a random basis of $\mathbb{R}^{m}$. Thereby, in contrast to Corollary 3.4 in this article, B is ought to satisfy $a$ partial Osgood condition that depends on the choice of this basis.

The pathwise exponential stability statements of Corollary 3.19 in [23] require B and $\Sigma$ to satisfy a partial Lipschitz condition and an $1 / 2$-Hölder condition in terms of a random basis, respectively. Then the same bound involving a sum of power functions as in this paper is imposed on the stability factor $\gamma_{\mathscr{P}}$ given by (3.11) in [23]. This entails that one half of the first moment Lyapunov exponent, studied in Corollary 3.16 there, serves as pathwise Lyapunov exponent. We emphasize that while $\gamma_{\mathscr{P}}$ is merely influenced by the regularity of B , the relevant stability factor $\gamma_{p q, \mathscr{P}}$ in (3.15) for Corollary 3.16 in this work, where $q \in[2, \infty)$, is based on the partial Lipschitz coefficients stemming from partial and complete Lipschitz conditions for B and $\Sigma$, respectively.

Moreover, for the strong existence and uniqueness result in [23], Theorem 3.27, to hold, it is assumed that B and $\Sigma$ are deterministic, B satisfies a partial affine growth and a partial Lipschitz condition relative to a random basis and $\Sigma$ vanishes at the origin at all times and satisfies the same Osgood condition on compact sets, as mentioned before. In Theorem 3.23 of this paper, however, the partial affine growth and partial Lipschitz conditions on B are less restrictive, and $\Sigma$ is supposed to satisfy an affine growth and a Lipschitz condition instead.

This work is structured as follows. In Section 2 the setting and the notation of our paper are introduced. In this context, we recall and extend several concepts from [23] that are related to the generalised McKean-Vlasov equation (1.2).

The main results are formulated in Section 3. In detail, Section 3.1 gives a quantitative second moment estimate for the difference of two solutions from which pathwise uniqueness follows. In Section 3.2 we compare solutions in arbitrary moments, which in turn leads to standard, asymptotic and exponential stability in $p$-th moment. Then, Section 3.3 deals with pathwise stability and $L^{p}$-growth estimates. By combining these results, a strong existence and uniqueness result is stated in Section 3.4. Thereby, all results are illustrated by a variety of examples involving integral maps.

Finally, Section 4 derives moment and pathwise asymptotic estimates for random Itô processes, from which our main results will be inferred in the proofs that can be found in Section 5

## 2 Preliminaries

In what follows, for any real-valued monotone function $f$ on an interval $I$ in $\mathbb{R}$ we define $f(a):=\lim _{v \downarrow a} f(v)$ for $a:=\inf I$, if $a \notin I$, and $f(b):=\lim _{v \uparrow b} f(v)$ for $b:=\sup I$, if $b \notin I$. Moreover, we use $|\cdot|$ as absolute value function, Euclidean norm or Hilbert-Schmidt norm and denote the transpose of any matrix $A \in \mathbb{R}^{m \times d}$ by $A^{\prime}$.

### 2.1 Processes with locally integrable elements

For $p \in[1, \infty)$ we introduce a pseudonorm $[\cdot]_{p}$ on the convex cone $\mathscr{L}_{+}^{p}(\Omega, \mathscr{F}, P)$ of all random variables $X$ with $E\left[\left(X^{+}\right)^{p}\right]<\infty$ and a sublinear functional $[\cdot]_{\infty}$ on the convex cone $\mathscr{L}_{+}^{\infty}(\Omega, \mathscr{F}, P)$ of all random variables $X$ with $X^{+} \leq c$ a.s. for some $c \in \mathbb{R}_{+}$by

[X]_{p}:=E\left[\left(X^{+}\right)^{p}\right]^{\frac{1}{p}} \quad \text { and } \quad[X]_{\infty}:=\operatorname{ess} \sup X . \tag{2.1}
\end{equation*}

Then the inequalities of Hölder and Young show that any $\beta, \gamma \in[0, p]$ with $\beta \leq \gamma$, each $X \in \mathscr{L}_{+}^{p / \gamma}(\Omega, \mathscr{F}, P)$, every $\mathbb{R}_{+}$-valued random variable $Y$ and all $x \in \mathbb{R}_{+}$satisfy

p x E\left[X Y^{p-\gamma}\right] E\left[Y^{p}\right]^{\frac{\beta}{p}} & \leq p x E[X]_{\frac{p}{\gamma}} E\left[Y^{p}\right]^{1-\frac{\gamma-\beta}{p}}  \tag{2.2}\\
& \leq[X]_{\frac{p}{\gamma}}\left((\gamma-\beta) x^{\frac{p}{\gamma-\beta}}+(p+\beta-\gamma) E\left[Y^{p}\right]\right)
\end{align*}
$$

provided $x=1$ if $\beta=\gamma$, since $1^{\infty}=\lim _{q \uparrow \infty} 1^{q}=1$. By means of these bounds, we derive the quantitative $L^{p}$-estimate of Theorem 4.6 for $p \geq 2$, on which our main results rely. To allow for infinite values, let us generalise the definitions of $[\cdot]_{p}$ and $[\cdot]_{\infty}$ in (2.1) to any random variable $X$.

Further, let $\mathscr{L}_{l o c}^{p}\left(\mathbb{R}^{m \times d}\right)$ denote the linear space of all $\mathbb{R}^{m \times d}$-valued Borel measurable locally $p$-fold integrable maps on $\left[t_{0}, \infty\right)$ and $\mathscr{L}_{\text {loc }}^{p}\left(\mathbb{R}_{+}^{m \times d}\right)$ stand for the convex cone of all maps in $\mathscr{L}_{\text {loc }}^{p}\left(\mathbb{R}^{m \times d}\right)$ with non-negative coordinates.

The linear space of all $\mathbb{R}^{m \times d}$-valued $\left(\mathscr{F}_{t}\right)_{t \in\left[t_{0}, \infty\right)}$-progressively measurable processes on $\left[t_{0}, \infty\right) \times \Omega$ is denoted by $\mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ and for $p \in[1, \infty]$ we let $\mathscr{S}_{\text {loc }}^{p}\left(\mathbb{R}^{m \times d}\right)$ be the subspace of all $\kappa \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ with locally integrable paths satisfying

\int_{t_{0}}^{t}\left|\left[\kappa_{s}^{(i, j)}\right]_{p}\right| d s<\infty \quad \text { for all } t \in\left[t_{0}, \infty\right)
$$

and any $(i, j) \in\{1, \ldots, m\} \times\{1, \ldots, d\}$, where $\kappa^{(i, j)}$ is the $(i, j)$-entry of $\kappa$. Similarly, let $\mathscr{S}_{2, \text { loc }}^{p}\left(\mathbb{R}^{m \times d}\right)$ be the linear space of all $\kappa \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ with locally square-integrable paths for which $\left[\kappa^{(i, j)}\right]_{p}$ is locally square-integrable for all $(i, j) \in\{1, \ldots, m\} \times\{1, \ldots, d\}$.

For instance, let $X$ be an $\mathscr{F}_{t_{0}}$-measurable random variable and $\hat{\kappa}$ be a measurable map on $\left[t_{0}, \infty\right)$ with values in $\mathbb{R}_{+}^{m \times d}$. Then $\kappa \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ defined by $\kappa_{s}(\omega):=\hat{\kappa}(s) X(\omega)$ lies in $\mathscr{S}_{2, \text { loc }}^{p}\left(\mathbb{R}^{m \times d}\right)$ if and only if $X \in \mathscr{L}_{+}^{p}(\Omega, \mathscr{F}, P)$ and $\hat{\kappa} \in \mathscr{L}_{\text {loc }}^{2}\left(\mathbb{R}^{m \times d}\right)$.

Finally, let $\mathscr{S}\left(\mathbb{R}_{+}^{m \times d}\right)$ and $\mathscr{S}_{\text {loc }}^{p}\left(\mathbb{R}_{+}^{m \times d}\right)$ stand for the convex cones of all processes in $\mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ and $\mathscr{S}_{l o c}^{p}\left(\mathbb{R}^{m \times d}\right)$ with non-negative entries, respectively. These concepts lead to sharp $L^{p}$-estimates for $p \in[2, \infty)$, as will be shown.

### 2.2 Admissible spaces of probability measures and notions of solutions and stability

From now on, we let $\mathscr{P}$ be a separable metrisable topological space in $\mathscr{P}\left(\mathbb{R}^{m}\right)$ that is admissible in the sense of Definition 2.1 in [23]. That is, for every metric space $S$, each
probability space $(\tilde{\Omega}, \tilde{\mathscr{F}}, \tilde{P})$ and any continuous process $X: S \times \tilde{\Omega} \rightarrow \mathbb{R}^{m}$ satisfying $\tilde{P}_{X_{s}} \in \mathscr{P}$ for any $s \in S$, the map

$$
S \rightarrow \mathscr{P}, \quad s \mapsto \tilde{P}_{X_{s}}
$$

is Borel measurable. Thereby, we write $\tilde{P}_{\tilde{X}}$ for the law $\tilde{P} \circ \tilde{X}^{-1}$ of any random vector $\tilde{X}: \tilde{\Omega} \rightarrow \mathbb{R}^{m}$ under $\tilde{P}$. Sufficient conditions for a metrisable topological space in $\mathscr{P}\left(\mathbb{R}^{m}\right)$ to be admissible and examples of such spaces are given in Section 2.2 in [23].

In particular, our main application is included. Namely, for $p \in[1, \infty)$ the Polish space $\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$ of all $\mu \in \mathscr{P}\left(\mathbb{R}^{m}\right)$ admitting a finite $p$-th moment $\int_{\mathbb{R}^{m}}|x|^{p} \mu(d x)$, endowed with the $p$-th Wasserstein metric defined via

\nu_{p}(\mu, \nu):=\left(\inf _{\theta \in \mathscr{P}(\mu, \nu)} \int_{\mathbb{R}^{m} \times \mathbb{R}^{m}}|x-y|^{p} \theta(d x, d y)\right)^{\frac{1}{p}} \tag{2.3}
\end{equation*}
$$

is admissible. In this context, $\mathscr{P}(\mu, \nu)$ denotes the convex set of all Borel probability measures $\theta$ on $\mathbb{R}^{m} \times \mathbb{R}^{m}$ with first and second marginal distributions $\mu$ and $\nu$, respectively, for any $\mu, \nu \in \mathscr{P}\left(\mathbb{R}^{m}\right)$.

Next, let $\mathscr{A}$ represent the progressive $\sigma$-field, consisting of all sets $A$ in $\left[t_{0}, \infty\right) \times \Omega$ for which $\mathbb{1}_{A}$ is progressively measurable. Then we shall call a map

F:\left[t_{0}, \infty\right) \times \Omega \times \mathbb{R}^{m} \times \mathscr{P} \rightarrow \mathbb{R}^{m \times d}, \quad(s, \omega, x, \mu) \mapsto F_{s}(x, \mu)(\omega)
$$

admissible if it is $\mathscr{A} \otimes \mathscr{B}\left(\mathbb{R}^{m}\right) \otimes \mathscr{B}(\mathscr{P})$-measurable. This property, which we also considered in Section 2.3 in [23], ensures that for each $X \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and every Borel measurable map $\mu:\left[t_{0}, \infty\right) \rightarrow \mathscr{P}$, the process

$$
\left[t_{0}, \infty\right) \times \Omega \rightarrow \mathbb{R}^{m \times d}, \quad(s, \omega) \mapsto F_{s}\left(X_{s}(\omega), \mu(s)\right)(\omega)
$$

is progressively measurable. Here and subsequently, we assume that the drift B and the diffusion $\Sigma$ of the McKean-Vlasov equation (1.2) are admissible, as described.

Definition 2.1. A solution to (1.2) is an $\mathbb{R}^{m}$-valued adapted continuous process $X$ such that $P_{X}$ is $\mathscr{P}$-valued, $\int_{t_{0}}^{t}\left|\mathrm{~B}_{s}\left(X_{s}, P_{X_{s}}\right)\right|+\left|\Sigma_{s}\left(X_{s}, P_{X_{s}}\right)\right|^{2} d s<\infty$ for each $t \in\left[t_{0}, \infty\right)$ and

$$
X_{t}=X_{t_{0}}+\int_{t_{0}}^{t} \mathrm{~B}_{s}\left(X_{s}, P_{X_{s}}\right) d s+\int_{t_{0}}^{t} \Sigma_{s}\left(X_{s}, P_{X_{s}}\right) d W_{s} \quad \text { for all } t \in\left[t_{0}, \infty\right) \text { a.s. }
$$

We readily check that for B and $\Sigma$ to be deterministic, it is necessary and sufficient that there are two Borel measurable maps $b$ and $\sigma$ on $\left[t_{0}, \infty\right) \times \mathbb{R}^{m} \times \mathscr{P}$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively, such that

\begin{equation*}
\mathrm{B}_{s}(x, \mu)=b(s, x, \mu) \quad \text { and } \quad \Sigma_{s}(x, \mu)=\sigma(s, x, \mu) \tag{2.4}
\end{equation*}
$$

for all $(s, x, \mu) \in\left[t_{0}, \infty\right) \times \mathbb{R}^{m} \times \mathscr{P}$. In this deterministic setting we may introduce weak and strong solutions and write (1.2) formally as follows:

$$
\begin{equation*}
d X_{t}=b\left(t, X_{t}, P_{X_{t}}\right) d t+\sigma\left(t, X_{t}, P_{X_{t}}\right) d W_{t} \quad \text { for } t \in\left[t_{0}, \infty\right) . \tag{2.5}
\end{equation*}
$$

Namely, any $\mathbb{R}^{m}$-valued $\mathscr{F}_{t_{0}}$-measurable random vector $\xi$ and the Brownian motion $W$ induce a filtration by $\xi_{\mathscr{E}_{t}^{0}}:=\sigma(\xi) \vee \sigma\left(W_{s}-W_{t_{0}}: s \in\left[t_{0}, t\right]\right)$ for all $t \in\left[t_{0}, \infty\right)$. Then a solution $X$ to (2.5) with $X_{t_{0}}=\xi$ a.s. is strong if it is adapted to the right-continuous filtration of the augmented filtration of $\left(\xi \mathscr{E}_{t}^{00}\right)_{t \in\left[t_{0}, \infty\right)}$.

A weak solution is an $\mathbb{R}^{m}$-valued adapted continuous process $X$ defined on some filtered probability space $\left(\tilde{\Omega}, \tilde{\mathscr{F}}^{\prime}\left(\tilde{\mathscr{F}}_{t}\right)_{t \in \mathbb{R}_{+}}, \tilde{P}\right)$ that satisfies the usual conditions and on which there is a standard $d$-dimensional $\left(\tilde{\mathscr{F}}_{t}\right)_{t \in \mathbb{R}_{+}}$-Brownian motion $\tilde{W}$ such that

$$
\tilde{P}_{X} \in \mathscr{P}, \quad \int_{t_{0}}^{t}\left|b\left(s, X_{s}, \tilde{P}_{X_{s}}\right)\right|+\left|\sigma\left(s, X_{s}, \tilde{P}_{X_{s}}\right)\right|^{2} d s<\infty \quad \text { for any } t \in\left[t_{0}, \infty\right)
$$

and $X_{t}=X_{t_{0}}+\int_{t_{0}}^{t} b\left(s, X_{s}, \tilde{P}_{X_{s}}\right) d s+\int_{t_{0}}^{t} \sigma\left(s, X_{s}, \tilde{P}_{X_{s}}\right) d \tilde{W}_{s}$ for all $t \in\left[t_{0}, \infty\right)$ a.s. In such a case, we shall say that $X$ solves (2.5) weakly on $\left(\tilde{\Omega}, \tilde{\mathscr{F}},\left(\tilde{\mathscr{F}}_{t}\right)_{t \in \mathbb{R}_{+}}, \tilde{P}\right)$ relative to $\tilde{W}$.

In general, we measure the regularity of the random coefficients B and $\Sigma$ with respect to the variable $\mu \in \mathscr{P}$ by means of an $\mathbb{R}_{+}$-valued Borel measurable functional $\vartheta$ on $\mathscr{P} \times \mathscr{P}$ and for $p \in[1, \infty)$ we assume that there is $c_{p, \mathscr{P}}>0$ such that

$$
\begin{equation*}
\vartheta\left(P_{X}, P_{\tilde{X}}\right) \leq c_{p, \mathscr{P}} E\left[|X-\tilde{X}|^{p}\right]^{\frac{1}{p}} \tag{2.6}
\end{equation*}
$$

for any two $\mathbb{R}^{m}$-valued random vectors $X, \tilde{X}$ satisfying $P_{X}, P_{\tilde{X}} \in \mathscr{P}$. For example, this condition is satisfied if $\vartheta$ is dominated by the $p$-th Wasserstein metric $\vartheta_{p}$, given by (2.3), as follows:

$$
\begin{equation*}
\vartheta(\mu, \nu) \leq c_{p, \mathscr{P}} \vartheta_{p}(\mu, \nu) \tag{2.7}
\end{equation*}
$$

for any $\mu, \nu \in \mathscr{P}$. Thereby, we extend the definition of $\nu_{p}(\mu, \nu)$ for all $\mu, \nu \in \mathscr{P}\left(\mathbb{R}^{m}\right)$, by allowing infinite values. Note that if in addition $\mathscr{P}$ lies in $\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$ and satisfies

$$
\mu \circ \varphi^{-1} \in \mathscr{P} \quad \text { for all } \mu \in \mathscr{P}
$$

and any $\mathbb{R}^{m}$-valued bounded uniformly continuous map $\varphi$ on $\mathbb{R}^{m}$ with $|\varphi| \leq|\cdot|$ such that $\vartheta$ is a pseudometric generating its topology, then $\mathscr{P}$ is automatically admissible, by Corollary 2.4 in [23].

Example 2.2. Suppose that $\phi: \mathbb{R} \cup\{-\infty\} \rightarrow \mathbb{R}_{+}$and $\varphi: \mathbb{R}^{m} \times \mathbb{R}^{m} \rightarrow \mathbb{R}$ are measurable, $\rho: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$is increasing and there is $c>0$ such that

$$
\varphi(x, y) \leq \rho(|x-y|) \quad \text { and } \quad \rho(v+w) / c \leq \rho(v)+\rho(w)
$$

for any $x, y \in \mathbb{R}^{m}$ and all $v, w \in \mathbb{R}_{+}$. Under the condition that $\mathscr{P}$ is included in the set $\mathscr{P}_{\rho}\left(\mathbb{R}^{m}\right)$ of all $\mu \in \mathscr{P}\left(\mathbb{R}^{m}\right)$ for which $\int_{\mathbb{R}^{m}} \rho(|x|) \mu(d x)$ is finite, we may take

$$
\vartheta(\mu, \nu)=\phi\left(\inf _{\theta \in \mathscr{P}(\mu, \nu)} \int_{\mathbb{R}^{m} \times \mathbb{R}^{m}} \varphi(x, y) \theta(d x, d y)\right) \quad \text { for all } \mu, \nu \in \mathscr{P}
$$

and the following three statements hold:
(1) Whenever $f, g: \mathbb{R}^{m} \rightarrow \mathbb{R}$ are measurable and satisfy $\varphi(x, y)=f(x)-g(y) \leq \rho(|x-y|)$ for every $x, y \in \mathbb{R}^{m}$, then

$$
\vartheta(\mu, \nu)=\phi\left(\int_{\mathbb{R}^{m}} f(x) \mu(d x)-\int_{\mathbb{R}^{m}} g(y) \nu(d y)\right) \quad \text { for any } \mu, \nu \in \mathscr{P} .
$$

(2) For the choice $\phi(v)=v^{1 / p}$ and $\rho(v)=v^{p}$ for any $v \in \mathbb{R}_{+}$and $\varphi(x, y)=|x-y|^{p}$ for all $x, y \in \mathbb{R}^{m}$ we get that $\mathscr{P}_{\rho}\left(\mathbb{R}^{m}\right)=\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$ and $\vartheta=\vartheta_{p}$.
(3) The inclusion $\mathscr{P} \subset \mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$ and the domination condition (2.7) are valid as soon as $\phi(v) \leq\left(v^{+}\right)^{1 / p}$ for each $v \in \mathbb{R} \cup\{-\infty\}$ and $\rho(v)=c_{p, \mathscr{P}}^{p} v^{p}$ for any $v \in \mathbb{R}_{+}$.

We notice that even in the case $(\mathscr{P}, \vartheta)=\left(\mathscr{P}_{2}\left(\mathbb{R}^{m}\right), \vartheta_{2}\right)$ for any solution $X$ to (1.2) the function $\left[t_{0}, \infty\right) \rightarrow \mathbb{R}_{+}, s \mapsto E\left[\left|X_{s}\right|^{2}\right]$ is not necessarily locally integrable. For instance, let for the moment the following partial and complete affine growth conditions hold:

$$
x^{\prime} \mathrm{B}(x, \mu) \leq|x|\left(\kappa+\chi \vartheta_{2}\left(\mu, \delta_{0}\right)\right) \quad \text { and } \quad|\Sigma(x, \mu)| \leq \kappa+\chi \vartheta_{2}\left(\mu, \delta_{0}\right)
$$

for every $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}_{2}\left(\mathbb{R}^{m}\right)$ and some $\kappa, \chi \in \mathbb{R}_{+}$, where $\delta_{0}$ is the Dirac measure in $0 \in \mathbb{R}^{m}$. Then Itô's formula immediately yields that

$$
\begin{aligned}
X_{t}^{2}-X_{t_{0}}^{2}-2 \int_{t_{0}}^{t} X_{s}^{\prime} \Sigma_{s}\left(X_{s}, P_{X_{s}}\right) & d W_{s}=\int_{t_{0}}^{t} 2 X_{s}^{\prime} \mathrm{B}_{s}\left(X_{s}, P_{X_{s}}\right)+\left|\Sigma_{s}\left(X_{s}, P_{X_{s}}\right)\right|^{2} d s \\
& \leq \int_{t_{0}}^{t} 2\left|X_{s}\right|\left(\kappa+\chi E\left[\left|X_{s}\right|^{2}\right]^{\frac{1}{2}}\right)+\left(\kappa+\chi E\left[\left|X_{s}\right|^{2}\right]^{\frac{1}{2}}\right)^{2} d s
\end{aligned}
$$

for all $t \in\left[t_{0}, \infty\right)$ a.s., since $\vartheta_{p}\left(\mu, \delta_{0}\right)^{p}=\int_{\mathbb{R}^{m}}|x|^{p} \mu(d x)$ for any $\mu \in \mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$. Although the first appearing Lebesgue integral is finite, the second may be infinite, since the condition $P_{X} \in \mathscr{P}$ in Definition [2.1] is merely equivalent to the square-integrability of $X$.

Certainly, this observation depends on the positivity of the variable $\chi$. Since if $\chi=0$, then Lemmas 3.19] and 3.20 show that $E\left[|X|^{2}\right]$ is locally bounded. Thus, as in [23], we shall state all uniqueness, stability and existence results under a local integrability condition, which takes growth in the measure variable into account.

For this purpose, we let $\Theta$ denote an $[0, \infty]$-valued Borel measurable functional on $\left[t_{0}, \infty\right) \times \mathscr{P}^{2} \times \mathscr{P}\left(\mathbb{R}^{m}\right)$ when $\mathscr{P}\left(\mathbb{R}^{m}\right)$ is endowed with the Prokhorov metric and the induced Borel $\sigma$-field.

Definition 2.3. Pathwise uniqueness holds for (1.2) (with respect to $\Theta$ ) if every two solutions $X$ and $\tilde{X}$ with $X_{t_{0}}=\tilde{X}_{t_{0}}$ a.s. (and for which the measurable function

$$
\begin{equation*}
\left[t_{0}, \infty\right) \rightarrow \mathbb{R}_{+}, \quad s \mapsto \Theta\left(s, P_{X_{s}}, P_{\tilde{X}_{s}}, P_{X_{s}-\tilde{X}_{s}}\right) \tag{2.8}
\end{equation*}
$$

is locally integrable) are indistinguishable.
To consider a relevant class of functionals such as $\Theta$ let $\mathrm{R}_{c}$ be the cone of all $\mathbb{R}_{+}$-valued continuous functions on $\mathbb{R}_{+}$that are positive on $(0, \infty)$ and vanish at the origin.
Example 2.4. Let $\eta, \lambda \in \mathscr{L}_{l o c}^{1}\left(\mathbb{R}_{+}\right)$and $\rho, \varrho \in \mathrm{R}_{c}$ be such that $\rho$ is concave, $\varrho$ is increasing and

$$
\Theta(s, \mu, \tilde{\mu}, \nu)=\lambda(s) \varrho(\vartheta(\mu, \tilde{\mu}))+\eta(s) \int_{\mathbb{R}^{m}} \rho\left(|x|^{p}\right) \nu(d x)
$$

for any $s \in\left[t_{0}, \infty\right)$, all $\mu, \tilde{\mu} \in \mathscr{P}$ and every $\nu \in \mathscr{P}\left(\mathbb{R}^{m}\right)$. Then $\Theta(s, \mu, \tilde{\mu}, \nu)<\infty$ as soon as $\nu \in \mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$, and for any two continuous processes $X$ and $\tilde{X}$ we have

$$
\Theta\left(\cdot, P_{X}, P_{\tilde{X}}, P_{X-\tilde{X}}\right)=\lambda \varrho\left(\vartheta\left(P_{X}, P_{\tilde{X}}\right)^{p}\right)+\eta E\left[\rho\left(|X-\tilde{X}|^{p}\right)\right],
$$

which yields a locally integrable function if $E\left[|X-\tilde{X}|^{p}\right]$ is locally bounded, for example.
Based on the stability concepts of Definition 2.11 in [23] that involve first moments, we formulate generalised notions of stability for (1.2) in a global meaning. In this regard, a shift of the stochastic drift and diffusion coefficients is not required, as the explicit argumentation preceeding the stability definitions in [23] explains.
Definition 2.5. Let $\alpha>0$ and $p \in[1, \infty)$.
(i) Equation (1.2) is stable in $p$-th moment (relative to $\Theta$ ) if for any two solutions $X$ and $\tilde{X}$ (for which (2.8) is locally integrable) it holds that

$$
\sup _{t \in\left[t_{0}, \infty\right)} E\left[\left|X_{t}-\tilde{X}_{t}\right|^{p}\right]<\infty,
$$

provided $E\left[\left|X_{t_{0}}-\tilde{X}_{t_{0}}\right|^{p}\right]<\infty$. If additionally $\lim _{t \uparrow \infty} E\left[\left|X_{t}-\tilde{X}_{t}\right|^{p}\right]=0$, then we refer to asymptotic stability in $p$-th moment.
(ii) We say that (1.2) is $\alpha$-exponentially stable in $p$-th moment (relative to $\Theta$ ) if there exist $\lambda<0$ and $c \in \mathbb{R}_{+}$such that any two solutions $X$ and $\tilde{X}$ satisfy

$$
\begin{equation*}
E\left[\left|X_{t}-\tilde{X}_{t}\right|^{p}\right] \leq c e^{\lambda\left(t-t_{0}\right)^{\alpha}} E\left[\left|X_{t_{0}}-\tilde{X}_{t_{0}}\right|^{p}\right] \tag{2.9}
\end{equation*}
$$

for each $t \in\left[t_{0}, \infty\right)$ as soon as $E\left[\left|X_{t_{0}}-\tilde{X}_{t_{0}}\right|^{p}\right]<\infty$ (and (2.8) is locally integrable). In this case, $\lambda$ is a $p$-th moment $\alpha$-Lyapunov exponent for (1.2).
(iii) We call (1.2) pathwise $\alpha$-exponentially (relative to an initial $p$-th moment and $\Theta$ ) if there is $\lambda<0$ such that

$$
\underset{t \uparrow \infty}{\limsup } \frac{1}{t^{\alpha}} \log \left(\left|X_{t}-\tilde{X}_{t}\right|\right) \leq \lambda \quad \text { a.s. }
$$

(whenever $E\left[\left|X_{t_{0}}-\tilde{X}_{t_{0}}\right|^{p}\right]<\infty$ and (2.8) is locally integrable), in which case $\lambda$ is a pathwise $\alpha$-Lyapunov exponent for (1.2).
Remark 2.6. Suppose that $E\left[|X-\tilde{X}|^{p}\right]$ is locally bounded. Then from (2.9) we directly infer that

$$
\underset{t \uparrow \infty}{\limsup } \frac{1}{t^{\alpha}} \log \left(E\left[\left|X_{t}-\tilde{X}_{t}\right|^{p}\right]\right) \leq \lambda .
$$

Conversely, the latter bound yields the former for $\lambda+\varepsilon$ instead of $\lambda$ for any $\varepsilon>0$. For a more general reasoning see Remark 2.12 in [23].

## 3 Main results

### 3.1 A quantitative second moment estimate and pathwise uniqueness

By comparing solutions to (1.2) with possibly different drift and diffusion coefficients, we obtain pathwise uniqueness. In this regard, let $\tilde{\mathrm{B}}$ and $\tilde{\Sigma}$ be two admissible maps on $\left[t_{0}, \infty\right) \times \Omega \times \mathbb{R}^{m} \times \mathscr{P}$, taking their values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively.

First, let us introduce an uniform error and continuity condition for the coefficients $(\mathrm{B}, \Sigma)$ and $(\tilde{\mathrm{B}}, \tilde{\Sigma})$ that is only partially restrictive for the drift coefficients B and $\tilde{\mathrm{B}}$ and involves the cone $\mathrm{R}_{c}$ introduced just before Example [2.4:
(C.1) There are $\alpha \in(0,1], \varepsilon, \lambda \in \mathscr{S}_{l o c}^{1}\left(\mathbb{R}_{+}\right), \eta \in \mathscr{S}_{l o c}^{1 /(1-\alpha)}\left(\mathbb{R}_{+}\right)$and $\rho, \varrho \in \mathrm{R}_{c}$ such that $\rho^{1 / \alpha}$ is concave, $\varrho$ is increasing and

$$
2(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\tilde{\mathrm{B}}(\tilde{x}, \tilde{\mu}))+|\Sigma(x, \mu)-\tilde{\Sigma}(\tilde{x}, \tilde{\mu})|^{2} \leq \varepsilon+\eta \rho\left(|x-\tilde{x}|^{2}\right)+\lambda \varrho\left(\vartheta(\mu, \tilde{\mu})^{2}\right)
$$

for any $x, \tilde{x} \in \mathbb{R}^{m}$ and all $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s.
In the case that $(\mathrm{B}, \Sigma)=(\tilde{\mathrm{B}}, \tilde{\Sigma})$ and $\varepsilon$ vanishes, (C.1) is simply a partial uniform continuity condition for the coefficients of (1.2). Moreover, we may interpret the expression $\varepsilon$ as error bound for the differences B- $\tilde{\mathrm{B}}$ and $\Sigma-\tilde{\Sigma}$.

For the succeeding $L^{2}$-estimate based on Bihari's inequality we recall that for any $\rho \in \mathrm{R}_{c}$ the function $\Phi_{\rho} \in C^{1}((0, \infty))$ given by

$$
\begin{equation*}
\Phi_{\rho}(w):=\int_{1}^{w} \frac{1}{\rho(v)} d v \tag{3.1}
\end{equation*}
$$

is a strictly increasing $C^{1}$-diffeomorphism onto the interval $\left(\Phi_{\rho}(0), \Phi_{\rho}(\infty)\right)$. Let $D_{\rho}$ be the set of all $(v, w) \in \mathbb{R}_{+}^{2}$ with $\Phi_{\rho}(v)+w<\Phi_{\rho}(\infty)$ and note that $\Psi_{\rho}: D_{\rho} \rightarrow \mathbb{R}_{+}$given by

$$
\begin{equation*}
\Psi_{\rho}(v, w):=\Phi_{\rho}^{-1}\left(\Phi_{\rho}(v)+w\right) \tag{3.2}
\end{equation*}
$$

is a continuous extension of a locally Lipschitz continuous function that is increasing in each coordinate. Under (C.1), we use the functions $\gamma, \delta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$defined by

$$
\gamma:=\alpha[\eta]_{\frac{1}{1-\alpha}}+\beta E[\lambda] \quad \text { and } \quad \delta:=(1-\alpha)[\eta]_{\frac{1}{1-\alpha}}^{1-\alpha}+(1-\beta) E[\lambda]
$$

for fixed $\beta \in(0,1]$ to give a quantitative $L^{2}$-bound. Thereby, we require until the end of this section that the $L^{p}$-norm bound (2.6) is valid for $p=2$.
Proposition 3.1. Let (C.1) hold, $X$ and $\tilde{X}$ be solutions to (1.2) with respective coefficients $(\mathrm{B}, \Sigma)$ and $(\tilde{\mathrm{B}}, \tilde{\Sigma})$ so that $E\left[\left|Y_{t_{0}}\right|^{2}\right]<\infty$ for $Y:=X-\tilde{X}$ and $E[\lambda] \varrho\left(\vartheta\left(P_{X}, P_{\tilde{X}}\right)^{2}\right)$ be locally integrable. Define $\rho_{0}, \varrho_{0} \in C\left(\mathbb{R}_{+}\right)$via

$$
\rho_{0}(v):=\rho(v)^{\frac{1}{\alpha}} \quad \text { and } \quad \varrho_{0}(v):=\rho_{0}(v) \vee \varrho\left(c_{2, \mathscr{P}}^{2} v\right)^{\frac{1}{\beta}}
$$

and assume that $\Phi_{\rho_{0}}(\infty)=\infty$ or $E\left[\eta \rho\left(|Y|^{2}\right)\right]$ is locally integrable. Then $E\left[|Y|^{2}\right]$ is locally bounded and

$$
\sup _{s \in\left[t_{0}, t\right]} E\left[\left|Y_{s}\right|^{2}\right] \leq \Psi_{\varrho_{0}}\left(E\left[\left|Y_{t_{0}}\right|^{2}\right]+\int_{t_{0}}^{t} E\left[\varepsilon_{s}\right]+\delta(s) d s, \int_{t_{0}}^{t} \gamma(s) d s\right)
$$

for each $t \in\left[t_{0}, t_{0}^{+}\right)$, where $t_{0}^{+}$represents the supremum over all $t \in\left[t_{0}, \infty\right)$ for which

$$
\left(E\left[\left|Y_{t_{0}}\right|^{2}\right]+\int_{t_{0}}^{t} E\left[\varepsilon_{s}\right]+\delta(s) d s, \int_{t_{0}}^{t} \gamma(s) d s\right) \in D_{\varrho_{0}} .
$$

Remark 3.2. From $\Phi_{\varrho_{0}}(\infty)=\infty$ it follows that $\Phi_{\rho_{0}}(\infty)=\infty$ and $D_{\varrho_{0}}=\mathbb{R}_{+}^{2}$. Thus, $E\left[|Y|^{2}\right]$ is bounded in this case if $E[\varepsilon], \gamma$ and $\delta$ are integrable. Moreover, the conditions

$$
\Phi_{\varrho_{0}}(0)=-\infty, \quad Y_{t_{0}}=0 \quad \text { a.s. } \quad \text { and } \quad E[\varepsilon]=\delta=0 \quad \text { a.e. }
$$

imply $t_{0}^{+}=\infty$ and $Y=0$ a.s. This fact will be used to derive pathwise uniqueness.
Example 3.3. Assume that $c_{2, \mathscr{P}}=\alpha=\beta=1$ and $\rho(v)=\varrho(v)=\hat{\alpha} v(|\log (v)|+1)$ for any $v \in \mathbb{R}_{+}$and some $\hat{\alpha} \in(0,1]$. Then $\Phi_{\varrho_{0}}(0)=-\infty, \Phi_{\varrho_{0}}(\infty)=\infty$ and we have

$$
\Psi_{\varrho_{0}}(v, w)= \begin{cases}e^{(1+\log (v)) e^{\hat{\alpha} w}-1} & \text { if } v \geq 1 \\ e^{\frac{\hat{e}^{\hat{\alpha}}}{1-\log (v)}-1} & \text { if } 1>v \geq \exp \left(1-e^{\hat{\alpha} w}\right) \\ e^{1-(1-\log (v)) e^{-\hat{\alpha} w}} & \text { if } v<\exp (1-\hat{\alpha} w)\end{cases}
$$

for every $v, w \in \mathbb{R}_{+}$, which leads to an explicit $L^{2}$-estimate in Proposition 3.1,
To deduce pathwise uniqueness from the comparison, we restrict (C.1) to the case when $(\mathrm{B}, \Sigma)=(\tilde{\mathrm{B}}, \tilde{\Sigma}), \alpha=1, \epsilon=0$ and $\eta$ is deterministic. Further, if B and $\Sigma$ are independent of $\mu \in \mathscr{P}$, then this condition will be imposed on compact sets only:
(C.2) There are $\eta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right), \lambda \in \mathscr{S}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$and $\rho, \varrho \in \mathrm{R}_{c}$ so that $\rho$ is concave, $\varrho$ is increasing and

$$
2(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\mathrm{B}(\tilde{x}, \tilde{\mu}))+|\Sigma(x, \mu)-\Sigma(\tilde{x}, \tilde{\mu})|^{2} \leq \eta \rho\left(|x-\tilde{x}|^{2}\right)+\lambda \varrho\left(\vartheta(\mu, \tilde{\mu})^{2}\right)
$$

for any $x, \tilde{x} \in \mathbb{R}^{m}$ and all $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s.
(C.3) B and $\Sigma$ are independent of $\mu \in \mathscr{P}$ and for each $n \in \mathbb{N}$ there are $\eta_{n} \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$ and a concave function $\rho_{n} \in \mathrm{R}_{c}$ such that

$$
2(x-\tilde{x})^{\prime}(\hat{\mathrm{B}}(x)-\hat{\mathrm{B}}(\tilde{x}))+|\hat{\Sigma}(x)-\hat{\Sigma}(\tilde{x})|^{2} \leq \eta_{n} \rho_{n}\left(|x-\tilde{x}|^{2}\right)
$$

for every $x, \tilde{x} \in \mathbb{R}^{m}$ with $|x| \vee|\tilde{x}| \leq n$ a.e. on $\left[t_{0}, \infty\right)$ a.s., where $\hat{\mathrm{B}}:=\mathrm{B}\left(\cdot, \mu_{0}\right)$ and $\hat{\Sigma}:=\Sigma\left(\cdot, \mu_{0}\right)$ for fixed $\mu_{0} \in \mathscr{P}$.

Under (C.2), pathwise uniqueness for (1.2) follows with respect to the $\mathbb{R}_{+}$-valued Borel measurable functional $\Theta$ on $\left[t_{0}, \infty\right) \times \mathscr{P}^{2} \times \mathscr{P}_{2}\left(\mathbb{R}^{m}\right)$ defined via

$$
\Theta(s, \mu, \tilde{\mu}, \nu):=E\left[\lambda_{s}\right] \varrho\left(\vartheta(\mu, \tilde{\mu})^{2}\right)+\int_{\mathbb{R}^{m}} \rho\left(|y|^{2}\right) \nu(d y) .
$$

If $\Phi_{\rho}(\infty)=\infty$, then the second term plays no role and we consider $\Theta:\left[t_{0}, \infty\right) \times \mathscr{P}^{2} \rightarrow \mathbb{R}_{+}$ given by $\Theta(\cdot, \mu, \tilde{\mu}):=E[\lambda] \varrho\left(\vartheta(\mu, \tilde{\mu})^{2}\right)$ instead, as this yields a weaker local integrability condition.

Corollary 3.4. The following two assertions hold:
(i) If (C.2) holds and $\int_{0}^{1}\left(\rho(v) \vee \varrho\left(c_{2, \mathscr{P}}^{2} v\right)\right)^{-1} d v=\infty$, then pathwise uniqueness for (1.2) relative to $\Theta$ is valid.
(ii) If (C.3) is satisfied and $\int_{0}^{1} \rho_{n}(v)^{-1} d v=\infty$ for all $n \in \mathbb{N}$, then pathwise uniqueness for the SDE (1.2) follows.

Remark 3.5. If B and $\Sigma$ are deterministic, in which case (2.4) holds, then pathwise uniqueness for (2.5) in the standard sense follows from the corollary, by stating the uniform continuity condition (C.2) when $\lambda$ is independent of $\omega \in \Omega$ and lies in $\mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$and by using the domination condition (2.7) instead of the $L^{p}$-bound (2.6) for $p=2$.

As application we consider the case that B and $\Sigma$ are integral maps. Thereby, an $\mathbb{R}^{m \times d}$-valued map on $\left[t_{0}, \infty\right) \times \Omega \times \mathbb{R}^{m} \times \mathbb{R}^{m}$ will be called admissible, as introduced in Section [2.2, by viewing it as a map on $\left[t_{0}, \infty\right) \times \Omega \times \mathbb{R}^{2 m} \times \mathscr{P}$ that is independent of the measure variable $\mu \in \mathscr{P}$.

Example 3.6. Let ${ }_{0} \mathrm{~B}$ and ${ }_{0} \Sigma$ be maps on $\left[t_{0}, \infty\right) \times \Omega \times \mathbb{R}^{m} \times \mathbb{R}^{m}$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$ that are admissible such that ${ }_{0} \mathrm{~B}(x, \cdot)$ and ${ }_{0} \Sigma(x, \cdot)$ are $\mu$-integrable,

$$
\begin{equation*}
\mathrm{B}(x, \mu)=\int_{\mathbb{R}^{m}}{ }_{0} \mathrm{~B}(x, y) \mu(d y) \quad \text { and } \quad \Sigma(x, \mu)=\int_{\mathbb{R}^{m}}{ }_{0} \Sigma(x, y) \mu(d y) \tag{3.3}
\end{equation*}
$$

for all $(x, \mu) \in\left[t_{0}, \infty\right) \times \mathscr{P}$. Then the following two assertions hold:
(1) Suppose that there are $\eta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right), \lambda \in \mathscr{S}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$and concave functions $\rho, \varrho \in \mathrm{R}_{c}$ such that $\varrho$ is increasing and

$$
2(x-\tilde{x})^{\prime}\left({ }_{0} \mathrm{~B}(x, y)-{ }_{0} \mathrm{~B}(\tilde{x}, \tilde{y})\right)+{ }_{0} \Sigma(x, y)-\left.{ }_{0} \Sigma(\tilde{x}, \tilde{y})\right|^{2} \leq \eta \rho\left(|x-\tilde{x}|^{2}\right)+\lambda \varrho\left(|y-\tilde{y}|^{2}\right)
$$

for all $x, \tilde{x}, y, \tilde{y} \in \mathbb{R}^{m}$ a.e. on $\left[t_{0}, \infty\right)$ a.s. Then (C.2) is valid for the choice $\vartheta=\vartheta_{2}$.
(2) If in fact there are $\eta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}^{2}\right), \hat{\eta}_{1} \in \mathscr{L}_{\text {loc }}^{2}\left(\mathbb{R}_{+}\right)$and $\hat{\eta}_{2} \in \mathscr{S}_{\text {loc }}^{2}\left(\mathbb{R}_{+}\right)$such that

$$
\begin{aligned}
(x-\tilde{x})^{\prime}\left({ }_{0} \mathrm{~B}(x, y)-{ }_{0} \mathrm{~B}(\tilde{x}, \tilde{y})\right) & \leq|x-\tilde{x}|\left(\eta_{1}|x-\tilde{x}|+\eta_{2}|y-\tilde{y}|\right) \\
\quad \text { and } \quad\left|{ }_{0} \Sigma(x, y)-{ }_{0} \Sigma(\tilde{x}, \tilde{y})\right| & \leq \hat{\eta}_{1}|x-\tilde{x}|+\hat{\eta}_{2}|y-\tilde{y}|
\end{aligned}
$$

for any $x, \tilde{x}, y, \tilde{y} \in \mathbb{R}^{m}$ a.e. on $\left[t_{0}, \infty\right)$ a.s., then (C.2) follows for $\vartheta=\vartheta_{1}$ and $\rho(v)$ $=\varrho(v)=v$ for each $v \in \mathbb{R}_{+}$. In this case,

$$
\Theta(\cdot, \mu, \tilde{\mu})=\left(\eta_{2}+2\left[\hat{\eta}_{2}\right]_{2}^{2}\right) \vartheta_{1}(\mu, \tilde{\mu})^{2}
$$

for all $\mu, \tilde{\mu} \in \mathscr{P}$ and, under the hypothesis that $\vartheta=\vartheta_{1}$, pathwise uniqueness for (1.2) with respect to $\Theta$ holds.

### 3.2 An explicit moment estimate and moment stability

In this section we compare two solutions with varying drift and diffusion coefficients in the $L^{p}$-norm for $p \in[2, \infty)$. The resulting estimate implies standard, asymptotic and exponential stability in $p$-th moment.

To this end, we require a uniform error and mixed Hölder continuity condition for (B, $\tilde{\mathrm{B}})$ and $(\Sigma, \tilde{\Sigma})$ that is only partially restrictive for the drift coefficients:
(C.4) There are $l \in \mathbb{N}, \alpha, \beta \in[0,1]^{l}$ with $\alpha+\beta \in[0,1]^{l}$, two $\mathbb{R}_{+}^{l}$-valued measurable maps $\zeta, \hat{\zeta}$ on $\left[t_{0}, \infty\right)$ and for each $k \in\{1, \ldots, l\}$ there are

$$
{ }_{k} \eta \in \mathscr{S}_{\text {loc }}^{\frac{p}{1-\alpha_{k}}}(\mathbb{R}) \quad \text { and } \quad{ }_{k} \hat{\eta} \in \mathscr{S}_{2, \text { loc }}^{\frac{p}{1-\alpha_{k}}}\left(\mathbb{R}_{+}\right)
$$

such that $(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\tilde{\mathrm{B}}(\tilde{x}, \tilde{\mu})) \leq \sum_{k=1}^{l} \zeta_{k} \eta|x-\tilde{x}|^{1+\alpha_{k}} \vartheta(\mu, \tilde{\mu})^{\beta_{k}}$ and

$$
|\Sigma(x, \mu)-\tilde{\Sigma}(\tilde{x}, \tilde{\mu})| \leq \sum_{k=1}^{l} \hat{\zeta}_{k} k \hat{\eta}|x-\tilde{x}|^{\alpha_{k}} \vartheta(\mu, \tilde{\mu})^{\beta_{k}}
$$

for any $x, \tilde{x} \in \mathbb{R}^{m}$ and all $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s. Further, for each $k \in\{1, \ldots, l\}$ we have $\zeta_{k}=\hat{\zeta}_{k}=1$, if $\alpha_{k}+\beta_{k}=1$, and the functions

$$
\begin{equation*}
\zeta_{k}^{\frac{p}{1-\alpha_{k}-\beta_{k}}}\left[{ }_{k} \eta\right]_{\frac{p}{1-\alpha_{k}}} \quad \text { and } \quad \hat{\zeta}_{k}^{1-\alpha_{k}-\beta_{k}}\left[{ }_{k} \hat{\eta}\right]_{\frac{p}{1-\alpha_{k}}}^{2} \tag{3.4}
\end{equation*}
$$

are locally integrable.
Remark 3.7. It is feasible to take $\zeta_{k}=\hat{\zeta}_{k}=1$ for any $k \in\{1, \ldots, l\}$ in (C.4). In this case, the functions in (3.4) are automatically locally integrable and we allow for the setting

$$
{ }_{k} \eta={ }_{k} \kappa \quad \text { and } \quad{ }_{k} \hat{\eta}={ }_{k} \hat{\kappa} \quad \text { for each } k \in\{1, \ldots, l\}
$$

and some ${ }_{k} \kappa \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ and ${ }_{k} \hat{\kappa} \in \mathscr{L}_{\text {loc }}^{2}\left(\mathbb{R}_{+}\right)$. However, the possibility to choose $\zeta$ and $\hat{\zeta}$ leads to the error estimate (3.24) in Theorem [3.23, the announced strong existence result.

Example 3.8. For $\alpha, \beta \in] 0,1]$ assume that there exist $\mathbb{R}_{+}$-valued measurable functions $\delta, \hat{\delta}$ on $\left[t_{0}, \infty\right)$ and processes

$$
{ }_{1} \eta \in \mathscr{S}_{\text {loc }}^{\frac{p}{1-\alpha}}(\mathbb{R}), \quad{ }_{2} \eta \in \mathscr{S}_{2, l o c}^{\frac{p}{1-\alpha}}\left(\mathbb{R}_{+}\right), \quad \varepsilon,{ }_{2} \eta \in \mathscr{S}_{\text {loc }}^{p}\left(\mathbb{R}_{+}\right) \quad \text { and } \quad \hat{\varepsilon},{ }_{2} \hat{\eta} \in \mathscr{S}_{2, l o c}^{p}\left(\mathbb{R}_{+}\right)
$$

such that $(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\tilde{\mathrm{B}}(\tilde{x}, \tilde{\mu})) \leq|x-\tilde{x}|\left(\delta \varepsilon+{ }_{1} \eta|x-\tilde{x}|^{\alpha}+{ }_{2} \eta \vartheta(\mu, \tilde{\mu})^{\beta}\right)$ and

$$
|\Sigma(x, \mu)-\tilde{\Sigma}(\tilde{x}, \tilde{\mu})| \leq \hat{\delta} \hat{\varepsilon} \hat{c}+{ }_{1} \hat{\eta}|x-\tilde{x}|^{\alpha}+{ }_{2} \hat{\eta} \vartheta(\mu, \tilde{\mu})^{\beta}
$$

for every $x, \tilde{x} \in \mathbb{R}^{m}$ and any $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$. Further, let $\delta^{p}[\varepsilon]_{p}$ and $\hat{\delta}^{2 p}[\hat{\varepsilon}]_{p}^{2}$ be locally integrable. Then (C.4) holds for $l=3$ if we replace the coefficients

$$
\alpha, \quad \beta, \quad \zeta, \quad \hat{\zeta} \quad\left({ }_{1} \eta,{ }_{2} \eta,{ }_{3} \eta\right) \quad \text { and } \quad\left({ }_{1} \hat{\eta}, 2 \hat{\eta},{ }_{3} \hat{\eta}\right),
$$

appearing there, by $(0, \alpha, 0),(0,0, \beta),(\delta, 1,1),(\hat{\delta}, 1,1),\left(\varepsilon,{ }_{1} \eta,{ }_{2} \eta\right)$ and $\left(\hat{\varepsilon},{ }_{1} \hat{\eta},{ }_{2} \hat{\eta}\right)$.
Generally, we note in (C.4) that for any $k \in\{1, \ldots, l\}$ with $\alpha_{k}=\beta_{k}=0$ the coefficients $\zeta_{k},{ }_{k} \eta, \hat{\zeta}_{k}$ and ${ }_{k} \hat{\eta}$ serve as error terms for $\mathrm{B}-\tilde{\mathrm{B}}$ and $\Sigma-\tilde{\Sigma}$, respectively. Further, under this condition, we introduce two coefficients $\gamma_{p, \mathscr{P}} \in \mathscr{L}_{l o c}^{1}(\mathbb{R})$ and $\delta_{p, \mathscr{P}} \in \mathscr{L}_{l o c}^{1}\left(\mathbb{R}_{+}\right)$by

$$
\begin{align*}
\gamma_{p, \mathscr{P}}:= & \sum_{k=1}^{l}\left(p-1+\alpha_{k}+\beta_{k}\right) c_{p, \mathscr{\mathscr { P }}}^{\beta_{k}}[k \eta]_{\frac{p}{1-\alpha_{k}}} \\
& +c_{p} \sum_{j, k=1}^{l}\left(p-2+\alpha_{j}+\alpha_{k}+\beta_{j}+\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{j}+\beta_{k}}\left[{ }_{j} \hat{\eta}_{k} \hat{\eta}\right] \frac{p}{2-\alpha_{j}-\alpha_{k}} \tag{3.5}
\end{align*}
$$

and

$$
\begin{align*}
& \delta_{p, \mathscr{P}}:=\sum_{k=1}^{l}\left(1-\alpha_{k}-\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{k}} \zeta_{k}^{\frac{p}{1-\alpha_{k}-\beta_{k}}}\left[{ }_{k} \eta\right]_{\frac{p}{1-\alpha_{k}}} \\
& \quad+c_{p} \sum_{j, k=1}^{l}\left(2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{j}+\beta_{k}}\left(\hat{\zeta}_{j} \hat{\zeta}_{k}\right)^{\frac{p}{2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}}}\left[{ }_{j} \hat{\eta}_{k} \hat{\eta}\right]_{\frac{p}{2-\alpha_{j}-\alpha_{k}}} \tag{3.6}
\end{align*}
$$

with $c_{p}:=(p-1) / 2$. Thereby, we observe that the term $\left[{ }_{j} \hat{\eta}_{k} \hat{\eta}\right]_{p /\left(2-\alpha_{j}-\alpha_{k}\right)}$ is indeed locally integrable for any $j, k \in\{1, \ldots, l\}$, since Hölder's inequality gives

$$
\int_{t_{0}}^{t}\left[j \hat{\eta}_{s k} \hat{\eta}_{s}\right]_{\frac{p}{2-\alpha_{j}-\alpha_{k}}} d s \leq \int_{t_{0}}^{t}\left[j \hat{\eta}_{s}\right]_{\frac{p}{1-\alpha_{j}}}\left[k \hat{\eta}_{s}\right]_{\frac{p}{1-\alpha_{k}}} d s<\infty \quad \text { for all } t \in\left[t_{0}, \infty\right)
$$

Moreover, since $\zeta_{k}=\hat{\zeta}_{k}=1$ for all $k \in\{1, \ldots, l\}$ with $\alpha_{k}+\beta_{k}=1$ and $1^{\infty}=\lim _{q \uparrow \infty} 1^{q}=1$, by convention, Young's inequality yields that
$\left(2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}\right)\left(\hat{\zeta}_{j} \hat{\zeta}_{k}\right)^{\frac{p}{2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}}} \leq\left(1-\alpha_{j}-\beta_{j}\right) \hat{\zeta}_{j}^{\frac{p}{1-\alpha_{j}-\beta_{j}}}+\left(1-\alpha_{k}-\beta_{k}\right) \hat{\zeta}_{k}^{\frac{p}{1-\alpha_{k}-\beta_{k}}}$
for any $j, k \in\{1, \ldots, l\}$. This clarifies the local integrability of the expressions appearing inside the second sum in (3.6).

By means of the functions $\gamma_{p, \mathscr{P}}$ and $\delta_{p, \mathscr{P}}$ we get an explicit $L^{p}$-comparison estimate under a local integrability condition involving the $\mathbb{R}_{+}$-valued Borel measurable functional $\Theta$ on $\left[t_{0}, \infty\right) \times \mathscr{P}^{2}$ given by

$$
\begin{equation*}
\Theta(\cdot, \mu, \tilde{\mu}):=\sum_{\substack{k=1, \beta_{k}>0}}^{l} \zeta_{k}[k \eta]_{\frac{p}{1-\alpha_{k}}} \vartheta(\mu, \tilde{\mu})^{\beta_{k}}+\hat{\zeta}_{k}^{2}[k \hat{\eta}]_{\frac{p}{1-\alpha_{k}}}^{2} \vartheta(\mu, \tilde{\mu})^{2 \beta_{k}} . \tag{3.7}
\end{equation*}
$$

For instance, let $\mu, \tilde{\mu}$ be two $\mathscr{P}$-valued Borel measurable functions on $\left[t_{0}, \infty\right)$ for which the function $\left[t_{0}, \infty\right) \rightarrow \mathbb{R}_{+}, s \mapsto \vartheta(\mu, \tilde{\mu})(s)$ is locally bounded. Then $\Theta(\cdot, \mu, \tilde{\mu})$ is locally integrable, because the functions

$$
\zeta_{k}\left[{ }_{k} \eta\right]_{\frac{p}{1-\alpha_{k}}} \quad \text { and } \quad \hat{\zeta}_{k}^{2}\left[{ }_{k} \hat{\eta}\right]_{\frac{p}{1-\alpha_{k}}}^{2}
$$

possess this property for each $k \in\{1, \ldots, l\}$, as another application of Young's inequality shows. In particular, if $\beta=0$, then there is no dependence on the measure variable to consider and $\Theta=0$.
Proposition 3.9. Let (C.4) hold, $X$ and $\tilde{X}$ be solutions to (1.2) with respective coefficients $(\mathrm{B}, \Sigma)$ and $(\tilde{\mathrm{B}}, \tilde{\Sigma})$ such that $E\left[\left|Y_{t_{0}}\right|^{p}\right]<\infty$ for $Y:=X-\tilde{X}$ and $\Theta\left(\cdot, P_{X}, P_{\tilde{X}}\right)$ be locally integrable. Then

$$
\begin{equation*}
E\left[\left|Y_{t}\right|^{p}\right] \leq e^{\int_{t_{0}}^{t} \gamma_{p, \mathscr{P}}(s) d s} E\left[\left|Y_{t_{0}}\right|^{p}\right]+\int_{t_{0}}^{t} e^{\int_{s}^{t} \gamma_{p, \mathscr{P}}(\tilde{s}) d \tilde{s}} \delta_{p, \mathscr{P}}(s) d s \tag{3.8}
\end{equation*}
$$

for all $t \in\left[t_{0}, \infty\right)$. In particular, if $\gamma_{p, \mathscr{P}}^{+}$and $\delta_{p, \mathscr{P}}$ are integrable, then $E\left[|Y|^{p}\right]$ is bounded. If in addition $\gamma_{p, \mathscr{P}}^{-}$fails to be integrable, then

$$
\lim _{t \uparrow \infty} E\left[\left|Y_{t}\right|^{p}\right]=0
$$

Remark 3.10. The term $\delta_{p, \mathscr{P}}$ contains all the coefficients $\zeta_{k}$ and $\hat{\zeta}_{k}$, where $k \in\{1, \ldots, l\}$, and is based on all Hölder exponents in $(0,1)$ appearing in (C.4) in the following sense: $\delta_{p, \mathscr{P}}(s)=0$ for fixed $s \in\left[t_{0}, \infty\right)$ if and only if both conditions

$$
\zeta_{k}(s)=0 \quad \text { or } \quad{ }_{k} \eta_{s} \leq 0 \quad \text { a.s. } \quad \text { and } \quad \hat{\zeta}_{k}(s)=0 \quad \text { or } \quad{ }_{k} \hat{\eta}_{s}=0 \quad \text { a.s. }
$$

hold for every $k \in\{1, \ldots, l\}$ with $\alpha_{k}+\beta_{k}<1$.

Until the end of this section let $(\mathrm{B}, \Sigma)=(\tilde{\mathrm{B}}, \tilde{\Sigma})$. Then (C.4) turns into a mixed Hölder continuity condition for B and $\Sigma$ if all the error terms disappear, that is, $\alpha_{k}+\beta_{k}>0$ for any $k \in\{1, \ldots, l\}$. Noteworthy, even if these expressions are in place, stability still follows.

Corollary 3.11. Let (C.4) be valid. Then (1.2) is (asymptotically) stable in p-th moment with respect to $\Theta$ if $\gamma_{p, \mathscr{P}}^{+}$and $\delta_{p, \mathscr{P}}$ are integrable (and $\int_{t_{0}}^{\infty} \gamma_{p, \mathscr{P}}^{-}(s) d s=\infty$ ).

To analyse the $L^{p}$-boundedness and the rate of $L^{p}$-convergence for solutions in the succeeding Corollary 3.12, we strengthen (C.4) to a partial Lipschitz condition on B and a complete Lipschitz condition on $\Sigma$ :
(C.5) There are $\eta_{1} \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R}),{ }_{2} \eta \in \mathscr{S}_{\text {loc }}^{p}\left(\mathbb{R}_{+}\right),{ }_{1} \hat{\eta} \in \mathscr{S}_{2, l o c}^{\infty}\left(\mathbb{R}_{+}\right)$and ${ }_{2} \hat{\eta} \in \mathscr{P}_{2, l o c}^{p}\left(\mathbb{R}_{+}\right)$such that

$$
(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\mathrm{B}(\tilde{x}, \tilde{\mu})) \leq|x-\tilde{x}|\left(\eta_{1}|x-\tilde{x}|+{ }_{2} \eta \vartheta(\mu, \tilde{\mu})\right)
$$

and $|\Sigma(x, \mu)-\Sigma(\tilde{x}, \tilde{\mu})| \leq{ }_{1} \hat{\eta}|x-\tilde{x}|+{ }_{2} \hat{\eta} \vartheta(\mu, \tilde{\mu})$ for any $x, \tilde{x} \in \mathbb{R}^{m}$ and all $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s.

Let us suppose that (C.5) holds, in which case (C.4) follows for $l=2, \alpha=(1,0)$ and $\beta=(0,1)$, as Example 3.8 shows. Thus, the function $\delta_{p, \mathscr{P}}$ in (3.6) is identically zero and the formula for the stability coefficient $\gamma_{p, \mathscr{P}}$ in (3.5) reduces to

$$
\begin{equation*}
\frac{\gamma_{p, \mathscr{P}}}{p}=\eta_{1}+c_{p, \mathscr{P}}[2 \eta]_{p}+c_{p}\left(\left[{ }_{1} \hat{\eta}\right]_{\infty}^{2}+2 c_{p, \mathscr{P}}\left[1 \hat{\eta}_{2} \hat{\eta}\right]_{p}+c_{p, \mathscr{P}}^{2}[2 \hat{\eta}]_{p}^{2}\right) . \tag{3.9}
\end{equation*}
$$

Thereby, we recall the fact that ${ }_{1} \hat{\eta}=\hat{\kappa}$ for some $\hat{\kappa} \in \mathscr{L}_{\text {loc }}^{2}\left(\mathbb{R}_{+}\right)$is possible in (C.5). Moreover, the functional (3.7) is of the form

\Theta(\cdot, \mu, \tilde{\mu})=\left[{ }_{2} \eta\right]_{p} \vartheta(\mu, \tilde{\mu})+\left[{ }_{2} \hat{\eta}\right]_{p}^{2} \vartheta(\mu, \tilde{\mu})^{2} \tag{3.10}
\end{equation*}
$$

for all $\mu, \tilde{\mu} \in \mathscr{P}$. Hence, by means of the following upper bound on $\gamma_{p, \mathscr{P}}$ that involves sums of power functions we derive exponential moment stability.
(C.6) Condition (C.5) is satisfied and there are $l \in \mathbb{N}, \alpha \in(0, \infty)^{l}$ and $\hat{\lambda}, s \in \mathbb{R}^{l}$ with $\alpha_{1}<\cdots<\alpha_{l}$ and $\hat{\lambda}_{l}<0$ such that

\gamma_{p, \mathscr{P}}(s) \leq \sum_{k=1}^{l} \hat{\lambda}_{k} \alpha_{k}\left(s-s_{k}\right)^{\alpha_{k}-1} \quad \text { for a.e. } s \in\left[t_{1}, \infty\right)
$$

for some $t_{1} \in\left[t_{0}, \infty\right)$ with $\max _{k \in\{1, \ldots, l\}} s_{k} \leq t_{1}$.
Based on the fact that the preceding condition implies the existence of some $\hat{t}_{1} \in\left[t_{0}, \infty\right)$ such that $\gamma_{p, \mathscr{P}}<0$ a.e. on $\left[\hat{t}_{1}, \infty\right)$, we state the just mentioned stability properties.

Corollary 3.12. The following two assertions hold:
(i) Suppose that (C.5) is valid and $\gamma_{p, \mathscr{P}}^{+}$is integrable. Then for the difference $Y$ of any two solutions $X$ and $\tilde{X}$ to (1.2) we have

assuming that $E\left[\left|Y_{t_{0}}\right|^{p}\right]<\infty$ and $\Theta\left(\cdot, P_{X}, P_{\tilde{X}}\right)$ is locally integrable. Moreover, if in addition $\int_{t_{0}}^{\infty} \gamma_{p, \mathscr{P}}^{-}(s) d s=\infty$, then

(ii) Let (C.6) be satisfied. Then (1.2) is $\alpha_{l}$-exponentially stable in $p$-th moment with respect to $\Theta$ with any moment $\alpha_{l}$-Lyapunov exponent in $\left(\hat{\lambda}_{l}, 0\right)$, and $\hat{\lambda}_{l}$ is a Lyapunov exponent provided

To demonstrate how the coefficients in (3.5) and (3.6) can be computed and facilitate access to the preceding results, let us consider certain sums of affine and integral maps.
Example 3.13. Suppose that $\kappa \in \mathscr{S}\left(\mathbb{R}^{m}\right), \eta \in \mathscr{S}\left(\mathbb{R}^{m \times m}\right)$ and $\hat{\kappa}, \hat{\eta} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$. Further, we take $N \in \mathbb{N}$ and $\hat{m} \in \mathbb{N}^{N}$ and for each $n \in\{1, \ldots, N\}$ let

{ }_{n} \eta \in \mathscr{S}\left(\mathbb{R}_{+}^{m}\right), \quad{ }_{n} \hat{\eta} \in \mathscr{S}\left(\mathbb{R}^{m \times \hat{m}_{n}}\right)

and $f_{n}$ and $g_{n}$ be two Borel measurable maps on $\mathbb{R}^{m} \times \mathbb{R}^{m}$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{\hat{m}_{n} \times d}$, respectively, such that $f_{n}(x, \cdot)$ and $g_{n}(x, \cdot)$ are $\mu$-integrable and

\end{equation*}

for all $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$. Then (C.4) is satisfied for the subsequent choice $\vartheta=\vartheta_{1}$ under the following three conditions:
(1) There is $\zeta_{\eta} \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ such that $x^{\prime} \eta x \leq \zeta_{\eta}|x|^{2}$ for all $x \in \mathbb{R}^{m}$ a.e. on $\left[t_{0}, \infty\right)$ a.s. and $[|\hat{\eta}|]_{\infty}^{2}$ is locally integrable.
(2) For $\alpha, \beta \in] 0,1]$ there exists $\lambda_{1}, \ldots, \lambda_{N} \in \mathbb{R}^{m}$ and $v_{1}, \ldots, v_{N} \in \mathbb{R}_{+}^{m}$ such that

for all $x, \tilde{x}, y, \tilde{y} \in \mathbb{R}^{m}$ and every $(n, i) \in\{1, \ldots, N\} \times\{1, \ldots, m\}$. Furthermore, ${ }_{1} \tilde{\eta}:=\sum_{n=1 n}^{N} \eta^{\prime} \lambda_{n}$ and ${ }_{2} \tilde{\eta}:=\sum_{n=1 n}^{N} \eta^{\prime} v_{n}$ lie in $\mathscr{S}_{l o c}^{\frac{p}{1-\alpha}}(\mathbb{R})$ and $\mathscr{S}_{l o c}^{p}\left(\mathbb{R}_{+}\right)$, respectively.
(3) For $\hat{\alpha}, \hat{\beta} \in] 0,1]$ there are $\hat{\lambda}_{1}, \ldots, \hat{\lambda}_{N}, \hat{v}_{1}, \ldots, \hat{v}_{N} \in \mathbb{R}_{+}$such that

for all $x, \tilde{x}, y, \tilde{y} \in \mathbb{R}^{m}$ and each $n \in\{1 \ldots, N\}$. Moreover, ${ }_{1} \bar{\eta}:=\left.\sum_{n=1}^{N}\right|_{n} \hat{\eta} \mid \hat{\lambda}_{n}$ and ${ }_{2} \bar{\eta}:=\sum_{n=1}^{N}|n \hat{\eta}| \hat{v}_{n}$ belong to $\mathscr{S}_{2, \text { loc }}^{\frac{p}{1-\alpha}}\left(\mathbb{R}_{+}\right)$and $\mathscr{S}_{2, \text { loc }}^{p}\left(\mathbb{R}_{+}\right)$, respectively.
Thus, under these requirements, Proposition 3.9 and Corollaries 3.11 and 3.12 entail the following assertions:
(4) The bound (3.8) holds for the difference $Y$ of any two solutions $X$ and $\tilde{X}$ to (1.2) for which $E\left[\left|Y_{t_{0}}\right|^{p}\right]<\infty$ and $\left[{ }_{2} \tilde{\eta}\right]_{p} \vartheta\left(P_{X}, P_{\tilde{X}}\right)^{\beta}+\left[{ }_{2} \bar{\eta}\right]_{p}^{2} \vartheta\left(P_{X}, P_{\tilde{X}}\right)^{2 \hat{\beta}}$ is locally integrable, where

\delta_{p, \mathscr{P}}= & (1-\alpha)\left[{ }_{1} \tilde{\eta}\right]_{\frac{p}{1-\alpha}}+(1-\beta) c_{p, \mathscr{P}}^{\beta}[2 \tilde{\eta}]_{p}+2 c_{p}(1-\hat{\alpha})\left(\left[{ }_{1} \bar{\eta}\right]_{\frac{p}{1-\hat{\alpha}}}^{2}+\left[|\hat{\eta}|_{1} \bar{\eta}\right]_{\frac{p}{1-\hat{\alpha}}}\right) \\

(5) Suppose that $\left(\zeta_{\eta}+\left[{ }_{1} \tilde{\eta}\right]_{\frac{p}{1-\alpha}} \mathbb{1}_{\{1\}}(\alpha)\right)^{+},\left[{ }_{1} \tilde{\eta}\right]_{\frac{p}{1-\alpha}} \mathbb{1}_{] 0,1[ }(\alpha)$,

are integrable. Then $E\left[|Y|^{p}\right]$ is bounded and we have $\lim _{t \uparrow \infty} E\left[\left|Y_{t}\right|^{p}\right]=0$ as soon as the negative part of $\zeta_{\eta}+\left[{ }_{1} \tilde{\eta}\right] \frac{p}{1-\alpha} \mathbb{1}_{\{1\}}(\alpha)$ fails to be integrable.
(6) Let ${ }_{1} \tilde{\eta} \leq 0$ in case that $\alpha<1$ and assume additionally that $\beta=\hat{\alpha}=\hat{\beta}=1$, in which case (C.5) is satisfied and we may define an $\mathbb{R}_{+}$-valued Borel measurable functional $\Theta$ on $\left[t_{0}, \infty\right) \times \mathscr{P}^{2}$ via

(i) If the positive part of $\zeta_{\eta}+\left[{ }_{1} \tilde{\eta}\right]_{\frac{p}{1-\alpha}} \mathbb{1}_{\{1\}}(\alpha)$ is integrable (and its negative part fails to be integrable), then (1.2) is (asymptotically) stable in $p$-th moment relative to $\Theta$.
(ii) If there exist $\tilde{\lambda}<0$ and $\tilde{\alpha}>0$ such that

& +2 c_{p}\left(\left[|\hat{\eta}|_{1} \bar{\eta}\right]_{\infty}+c_{p, \mathscr{P}}\left[|\hat{\eta}|_{2} \bar{\eta}\right]_{p}+c_{p, \mathscr{P}}\left[1 \bar{\eta}_{2} \bar{\eta}\right]_{p}\right) \leq \frac{\tilde{\lambda}}{p} \tilde{\alpha}\left(s-t_{0}\right)^{\tilde{\alpha}-1}
\end{aligned}
$$

for a.e. $s \in\left[t_{0}, \infty\right)$, then (1.2) is $\tilde{\alpha}$-exponentially stable in $p$-th moment with respect to $\Theta$ with Lyapunov exponent $\tilde{\lambda}$.

### 3.3 Pathwise stability and moment growth bounds

In the first part of this section we establish pathwise exponential stability for (1.2). In this regard, we restrict the partial Lipschitz condition (C.5) to the case that all the regularity coefficients are deterministic and a certain growth estimate holds:
(C.8) There are $\eta \in \mathscr{L}_{l o c}^{1}\left(\mathbb{R}^{2}\right)$ and $\hat{\eta} \in \mathscr{L}_{l o c}^{2}\left(\mathbb{R}_{+}^{2}\right)$ with $\eta_{2} \geq 0$ such that

(x-\tilde{x})^{\prime}(\mathrm{B}(x, \mu)-\mathrm{B}(\tilde{x}, \tilde{\mu})) \leq|x-\tilde{x}|\left(\eta_{1}|x-\tilde{x}|+\eta_{2} \vartheta(\mu, \tilde{\mu})\right)
$$

and $|\Sigma(x, \mu)-\Sigma(\tilde{x}, \tilde{\mu})| \leq \hat{\eta}_{1}|x-\tilde{x}|+\hat{\eta}_{2} \vartheta(\mu, \tilde{\mu})$ for every $x, \tilde{x} \in \mathbb{R}^{m}$ and all $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s. Further, there is $\hat{\delta}>0$ so that

\sup _{t \in\left[t_{0}, \infty\right)} \int_{t}^{t+\hat{\delta}} h(s) d s<\infty \quad \text { for each } h \in\left\{\eta_{2}, \hat{\eta}_{1}^{2}, \hat{\eta}_{2}^{2}\right\}

Remark 3.14. The preceding growth estimate is automatically satisfied if the regularity coefficients $\eta_{2}, \hat{\eta}_{1}$ and $\hat{\eta}_{2}$ are in fact locally bounded.

Given $q \in[2, \infty)$ we shall just for the next two results assume that (2.6) holds when $p$ is replaced by $p q$ but may fail to be valid for $p$. Thus, under (C.8), the stability coefficient $\gamma_{p q, \mathscr{P}}$ and the functional $\Theta$, which we considered in (3.9) and (3.10) for $p$ instead of $p q$, can simply be written in the form

and $\Theta(\cdot, \mu, \tilde{\mu})=\eta_{2} \vartheta(\mu, \tilde{\mu})+\hat{\eta}_{2}^{2} \vartheta(\mu, \tilde{\mu})^{2}$ for every $\mu, \tilde{\mu} \in \mathscr{P}$. In addition, we impose the following abstract condition on $\gamma_{p q, \mathscr{P}}$ to deduce a general pathwise stability bound from an application of Theorem 4.13, a pathwise result for random Itô processes.
(C.9) Condition (C.8) is valid and there exist $\hat{\varepsilon} \in(0,1)$ and some strictly increasing sequence $\left(t_{n}\right)_{n \in \mathbb{N}}$ in $\left[t_{0}, \infty\right)$ such that $\gamma_{p q, \mathscr{P}} \leq 0$ a.e. on $\left[t_{1}, \infty\right)$,

\sup _{n \in \mathbb{N}}\left(t_{n+1}-t_{n}\right)<\hat{\delta}, \quad \lim _{n \uparrow \infty} t_{n}=\infty
$$

and $\sum_{n=1}^{\infty} \exp \left(\varepsilon(p q)^{-1} \int_{t_{1}}^{t_{n}} \gamma_{p q, \mathscr{P}}(s) d s\right)<\infty$ for each $\varepsilon \in(0, \hat{\varepsilon})$.
Proposition 3.15. Let (C.9) be valid and $X$ and $\tilde{X}$ be two solutions to (1.2) for which $\Theta\left(\cdot, P_{X}, P_{\tilde{X}}\right)$ is locally integrable. Then for $Y:=X-\tilde{X}$ we have

\limsup _{t \uparrow \infty} \frac{1}{\varphi(t)} \log \left(\left|Y_{t}\right|\right) \leq \frac{1}{p q} \limsup _{n \uparrow \infty} \frac{1}{\varphi\left(t_{n}\right)} \int_{t_{1}}^{t_{n}} \gamma_{p q, \mathscr{P}}(s) d s \quad \text { a.s. }
$$

for each increasing function $\varphi:\left[t_{1}, \infty\right) \rightarrow \mathbb{R}_{+}$that is positive on $\left(t_{1}, \infty\right)$, under the condition that $E\left[\left|Y_{t_{0}}\right|^{p q}\right]<\infty$ or $\eta_{2}=\hat{\eta}_{2}=0$.

Since the following condition, which involves the same sum of power functions as in (C.6), implies (C.9), we obtain pathwise exponential stability.
(C.10) Condition (C.8) is satisfied and there exist $l \in \mathbb{N}, \alpha \in(0, \infty)^{l}, \hat{\lambda}, s \in \mathbb{R}^{l}$ and $t_{1} \in\left[t_{0}, \infty\right)$ with $\alpha_{1}<\cdots<\alpha_{l}$ and $\hat{\lambda}_{l}<0$ such that

$$
\max _{k \in\{1, \ldots, l\}} s_{k} \leq t_{1} \quad \text { and } \quad \gamma_{p q, \mathscr{P}}(s) \leq \sum_{k=1}^{l} \hat{\lambda}_{k} \alpha_{k}\left(s-s_{k}\right)^{\alpha_{k}-1} \quad \text { for a.e. } s \in\left[t_{1}, \infty\right)
$$

Corollary 3.16. Under (C.10), the following two statements hold:
(i) The McKean-Vlasov SDE (1.2) is pathwise $\alpha_{l}$-exponentially with Lyapunov exponent $\hat{\lambda}_{l} /(p q)$ relative to an initial $p q-$ th moment and $\Theta$.
(ii) If B and $\Sigma$ are actually independent of $\mu \in \mathscr{P}$, then the SDE (1.2) is pathwise $\alpha_{l}$-exponentially with Lyapunov exponent $\hat{\lambda}_{l} /(p q)$, without any restrictions.

As possible application let us consider Example 3.13 that involves integral maps.
Example 3.17. Assume that B and $\Sigma$ admit the representations (3.11) and (3.12). In this case, (C.8) follows for $\vartheta=\vartheta_{1}$ from condition (1) in Example 3.13 and the following two requirements:
(2) The two partial and complete Hölder continuity estimates (3.13) and (3.14) hold for each $(n, i) \in\{1, \ldots, N\} \times\{1, \ldots, m\}$ when $\hat{\alpha}=\beta=\hat{\beta}=1$.
(3) There are $\tilde{\eta}_{1} \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ and $\mathbb{R}_{+}$-valued measurable locally bounded functions $\tilde{\eta}_{2}, \bar{\eta}_{1}$ and $\bar{\eta}_{2}$ on $\left[t_{0}, \infty\right)$ such that

$$
\sum_{n=1}^{N}{ }_{n} \eta^{\prime} \lambda_{n} \leq \tilde{\eta}_{1}, \quad \sum_{n=1}^{N}{ }_{n} \eta^{\prime} v_{n} \leq \tilde{\eta}_{2},\left.\quad \sum_{n=1}^{N}\right|_{n} \hat{\eta} \mid \hat{\lambda}_{n} \leq \bar{\eta}_{1} \quad \text { and } \quad \sum_{n=1}^{N}\left|{ }_{n} \hat{\eta}\right| \hat{v}_{n} \leq \bar{\eta}_{2}
$$

a.e. on $\left[t_{0}, \infty\right)$ a.s. Further, $\tilde{\eta}_{1} \leq 0$ in the case that $\alpha<1$.

Based on these coefficients, our considerations in Example 3.13 show that for the stability coefficient $\gamma_{p q, \mathscr{P}}$ in (3.15) and the functional $\Theta$ we have

$$
\begin{aligned}
\frac{\gamma_{p q, \mathscr{P}}}{p q}= & \zeta_{\eta}+\tilde{\eta}_{1} \mathbb{1}_{\{1\}}(\alpha)+c_{p q, \mathscr{P}} \tilde{\eta}_{2}+c_{p q}\left([|\hat{\eta}|]_{\infty}^{2}+\bar{\eta}_{1}^{2}+c_{p q, \mathscr{P}}^{2} \bar{\eta}_{2}^{2}\right) \\
& +2 c_{p q}\left([|\hat{\eta}|]_{\infty} \bar{\eta}_{1}+c_{p q, \mathscr{P}}[|\bar{\eta}|]_{\infty} \bar{\eta}_{2}+c_{p q, \mathscr{P}} \bar{\eta}_{1} \bar{\eta}_{2}\right)
\end{aligned}
$$

and $\Theta(\cdot, \mu, \tilde{\mu})=\tilde{\eta}_{2} \vartheta(\mu, \tilde{\mu})+\bar{\eta}_{2}^{2} \vartheta(\mu, \tilde{\mu})^{2}$ for all $\mu, \tilde{\mu} \in \mathscr{P}$. Thus, if there are $\tilde{\lambda}<0$ and $\tilde{\alpha}>0$ such that

$$
\gamma_{p q, \mathscr{P}} \leq \tilde{\lambda} \tilde{\alpha}\left(s-t_{0}\right)^{\tilde{\alpha}-1} \quad \text { for a.e. } s \in\left[t_{0}, \infty\right),
$$

then Corollary 3.16 yields the following two assertions:
(4) Equation (1.2) pathwise $\tilde{\alpha}$-exponentially stable with Lyapunov exponent $\tilde{\lambda} /(p q)$ with respect to an initial $p q$-th moment and $\Theta$.
(5) In the case that $\tilde{\eta}_{2}=\bar{\eta}_{2}=0$ when B and $\Sigma$ are independent of $\mu \in \mathscr{P}$ the SDE (1.2) is pathwise $\tilde{\alpha}$-exponentially stable with Lyapunov exponent $\tilde{\lambda} /(p q)$.

Now we deduce a second and a $p$-th moment estimate for solutions to (1.2). As the first bound implies that their second moment functions are locally bounded, local integrability in terms of the functional $\Theta$ in Corollary 3.4 is always satisfied.

Similarly, the second bound ensures that the $p$-th moment function of any solution is locally bounded and thus, all local integrability requirements with respect to $\Theta$ in Corollaries 3.11, 3.12 and 3.16 hold automatically.

Let us give two growth conditions on ( $\mathrm{B}, \Sigma$ ) that are only partially restrictive for the drift B. The first is required for the second moment estimate and includes different classes of growth behaviour, by using the cone $\mathrm{R}_{c}$, introduced in Section [2.2. The second yields the $p$-th moment estimate and is of affine nature:
(C.11) There are $\alpha \in(0,1], \kappa, \chi \in \mathscr{S}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right), v \in \mathscr{S}_{\text {loc }}^{1 /(1-\alpha)}\left(\mathbb{R}_{+}\right)$and $\phi, \varphi \in \mathrm{R}_{c}$ such that $\phi^{1 / \alpha}$ is concave, $\varphi$ is increasing and

2 x^{\prime} \mathrm{B}(x, \mu)+|\Sigma(x, \mu)|^{2} \leq \kappa+v \phi\left(|x|^{2}\right)+\chi \varphi\left(\vartheta\left(\mu, \delta_{0}\right)^{2}\right)
$$

for all $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s.
(C.12) There are $l \in \mathbb{N}, \alpha, \beta \in[0,1]^{l}$ with $\alpha+\beta \in[0,1]^{l}$, two $\mathbb{R}_{+}^{l}$-valued measurable maps $\kappa, \hat{\kappa}$ on $\left[t_{0}, \infty\right)$ and for each $k \in\{1, \ldots, l\}$ there are

$$
{ }_{k} v \in \mathscr{S}_{\text {loc }}^{\frac{p}{1-\alpha_{k}}}(\mathbb{R}) \quad \text { and } \quad{ }_{k} \hat{v} \in \mathscr{S}_{2, \operatorname{loc}}^{\frac{p}{1-\alpha_{k}}}\left(\mathbb{R}_{+}\right)
$$

such that $x^{\prime} \mathrm{B}(x, \mu) \leq \sum_{k=1}^{l} \kappa_{k k} v|x|^{1+\alpha_{k}} \vartheta\left(\mu, \delta_{0}\right)^{\beta_{k}}$ and

$$
|\Sigma(x, \mu)| \leq \sum_{k=1}^{l} \hat{\kappa}_{k k} \hat{v}|x|^{\alpha_{k}} \vartheta\left(\mu, \delta_{0}\right)^{\beta_{k}}
$$

for any $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$ a.s. Moreover, for any $k \in\{1, \ldots, l\}$ it holds that $\kappa_{k}=\hat{\kappa}_{k}=1$, if $\alpha_{k}+\beta_{k}=1$, and the functions

$$
\kappa_{k}^{\frac{p}{1-\alpha_{k}-\beta_{k}}}\left[{ }_{k} v\right]_{\frac{p}{1-\alpha_{k}}} \quad \text { and } \quad \hat{\kappa}_{k}^{\frac{2 p}{1-\alpha_{k}-\beta_{k}}}\left[{ }_{k} \hat{v}\right]_{\frac{p}{1-\alpha_{k}}}^{2}
$$

are locally integrable.
Remark 3.18. As in (C.4) we could have $\kappa_{k}=\hat{\kappa}_{k}=1$ for all $k \in\{1, \ldots, l\}$, in which case the additional local integrability requirement is redundant. By admitting more general choices of $\kappa$ and $\hat{\kappa}$, the growth estimate (3.25) in Theorem 3.23 can be derived.

Provided (C.11) is valid and $\beta \in(0,1]$, we define $f, g \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$by

$$
f:=\alpha[v]_{\frac{1}{1-\alpha}}+\beta E[\chi] \quad \text { and } \quad g:=(1-\alpha)[v]_{\frac{1}{1-\alpha}}+(1-\beta) E[\chi]
$$

and apply Proposition 4.4 to state the following quantitative $L^{2}$-estimate, which becomes explicit in the setting of Example 3.3.

Lemma 3.19. Let (2.6) hold for $p=2$, (C.11) be valid, $X$ be a solution to (1.2) such that $E\left[\left|X_{t_{0}}\right|^{2}\right]<\infty$ and $E[\chi] \varphi\left(\vartheta\left(P_{X}, \delta_{0}\right)^{2}\right)$ is locally integrable and $\varphi_{0} \in C\left(\mathbb{R}_{+}\right)$given by

$$
\varphi_{0}(v):=\phi(v)^{\frac{1}{\alpha}} \vee \varphi\left(c_{2, \mathscr{P}}^{2} v\right)^{\frac{1}{\beta}}
$$

satisfy $\Phi_{\varphi_{0}}(\infty)=\infty$. Then $E\left[|X|^{2}\right]$ is locally bounded and

$$
\sup _{s \in\left[t_{0}, t\right]} E\left[\left|X_{s}\right|^{2}\right] \leq \Psi_{\varphi_{0}}\left(E\left[\left|X_{t_{0}}\right|^{2}\right]+\int_{t_{0}}^{t} E\left[\kappa_{s}\right]+g(s) d s, \int_{t_{0}}^{t} f(s) d s\right)
$$

for any $t \in\left[t_{0}, \infty\right)$. In particular, if $E[\kappa], f$ and $g$ are integrable, then $E\left[|X|^{2}\right]$ is bounded.
We recall the constant $c_{p}=(p-1) / 2$ and let the familiar estimate (2.6) be valid. If the growth condition ( (C.12) is satisfied, then we may let $f_{p, \mathscr{P}} \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ and $g_{p, \mathscr{P}} \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$ be given by

& +c_{p} \sum_{j, k=1}^{l}\left(p-2+\alpha_{j}+\alpha_{k}+\beta_{j}+\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{j}+\beta_{k}}\left[{ }_{j} \hat{v}_{k} \hat{v}\right]_{\frac{p}{2-\alpha_{j}-\alpha_{k}}}
\end{align*}
$$

and

$$
\begin{align*}
& g_{p, \mathscr{P}}:=\sum_{k=1}^{l}\left(1-\alpha_{k}-\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{k}} \kappa_{k}^{\frac{p}{1-\alpha_{k}-\beta_{k}}}\left[{ }_{k} v\right] \frac{p}{1-\alpha_{k}} \\
& \quad+c_{p} \sum_{j, k=1}^{l}\left(2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}\right) c_{p, \mathscr{P}}^{\beta_{j}+\beta_{k}}\left(\hat{\kappa}_{j} \hat{\kappa}_{k}\right)^{\frac{p}{2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}}}\left[{ }_{j} \hat{v}_{k} \hat{v}\right] \frac{p}{2-\alpha_{j}-\alpha_{k}} \tag{3.17}
\end{align*}
$$

Further, we define an $\mathbb{R}_{+}$-valued Borel measurable functional $\Theta$ on $\left[t_{0}, \infty\right) \times \mathscr{P}^{2}$ by

\Theta(\cdot, \mu, \tilde{\mu}):=\sum_{\substack{k=1, \beta_{k}>0}}^{l} \kappa_{k}[k v]_{\frac{p}{1-\alpha_{k}}} \vartheta(\mu, \tilde{\mu})^{\beta_{k}}+\hat{\kappa}_{k}^{2}[k \hat{v}]_{\frac{p}{1-\alpha_{k}}}^{2} \vartheta(\mu, \tilde{\mu})^{2 \beta_{k}} .
$$

These formulas are in essence the same as those for the stability coefficients in (3.5) and (3.6) and the functional in (3.7), as the subsequent explicit $L^{p}$-growth estimate and the $L^{p}$-comparison estimate in Proposition 3.9 are implied by Theorem 4.6.

Lemma 3.20. Let (C.12) hold and $X$ be a solution to (1.2) such that $E\left[\left|X_{t_{0}}\right|^{p}\right]<\infty$ and $\Theta\left(\cdot, P_{X}, \delta_{0}\right)$ is locally integrable. Then

\begin{equation*}
E\left[\left|X_{t}\right|^{p}\right] \leq e^{\int_{t_{0}}^{t} f_{p, \mathscr{P}}(s) d s} E\left[\left|X_{t_{0}}\right|^{p}\right]+\int_{t_{0}}^{t} e_{s}^{\int_{s}^{t} f_{p, \mathscr{P}}(\tilde{s}) d \tilde{s}} g_{p, \mathscr{P}}(s) d s \tag{3.18}
\end{equation*}
$$

for all $t \in\left[t_{0}, \infty\right)$. In particular, if $f_{p, \mathscr{P}}^{+}$and $g_{p, \mathscr{P}}$ are integrable, then $E\left[|X|^{p}\right]$ is bounded and from $\int_{t_{0}}^{\infty} f_{p, \mathscr{P}}^{-}(s) d s=\infty$ it follows that $\lim _{t \uparrow \infty} E\left[\left|X_{t}\right|^{p}\right]=0$.

At last, we recast Example 3.13 when the integer $N$ is replaced by $l N$ for some $l \in \mathbb{N}$.
Example 3.21. Let $\kappa \in \mathscr{S}\left(\mathbb{R}^{m}\right), \eta \in \mathscr{S}\left(\mathbb{R}^{m \times m}\right)$ and $\hat{\kappa}, \hat{\eta} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ and $\hat{m} \in \mathbb{N}^{l \times N}$. For every $(k, n) \in\{1, \ldots, l\} \times\{1, \ldots, N\}$ we assume that

$$
k, n \eta \in \mathscr{S}\left(\mathbb{R}_{+}^{m}\right), \quad k, n \hat{\eta} \in \mathscr{S}\left(\mathbb{R}^{m \times \hat{m}_{k, n}}\right)
$$

and $f_{k, n}$ and $g_{k, n}$ are two Borel measurable maps on $\mathbb{R}^{m} \times \mathbb{R}^{m}$ taking their values in $\mathbb{R}^{m}$ and $\mathbb{R}^{\hat{m}_{k, n} \times d}$, respectively, such that $f_{k, n}(x, \cdot)$ and $g_{k, n}(x, \cdot)$ are $\mu$-integrable and

\mathrm{B}(x, \mu)=\kappa+\eta x+\sum_{k=1}^{l} \sum_{n=1}^{N} \operatorname{diag}(k, n \eta) \int_{\mathbb{R}^{m}} f_{k, n}(x, y) \mu(d y)

and

\Sigma(x, \mu)=\hat{\kappa}+\operatorname{diag}(x) \hat{\eta}+\sum_{k=1}^{l} \sum_{n=1}^{N} k, n \hat{\eta} \int_{\mathbb{R}^{m}} g_{k, n}(x, y) \mu(d y)
$$

for every $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$. In this case, (C.12) follows for $\vartheta=\vartheta_{1}$ from condition (1) in Example 3.13 and the following three conditions:
(2) $E\left[|\kappa|^{p}\right]^{1 / p}$ and $E\left[|\hat{\kappa}|^{p}\right]^{2 / p}$ are locally integrable.
(3) For given $\alpha, \beta \in[0,1]^{l}$ with $\alpha+\beta \in[0,1]^{l}$ and every $k \in\{1, \ldots, l\}$ there are $c_{k, 1}, \ldots, c_{k, N} \in \mathbb{R}^{m}$ satisfying

for any $x, y \in \mathbb{R}^{m}$ and all $(n, i) \in\{1, \ldots, N\} \times\{1, \ldots, m\}$ so that ${ }_{k} v:=\sum_{n=1}^{N}{ }_{k, n} \eta^{\prime} c_{k, n}$ lies in $\mathscr{S}_{\text {loc }}^{\frac{p}{1-\alpha_{k}}}(\mathbb{R})$.
(4) Further, there exist $\hat{c}_{k, 1}, \ldots, \hat{c}_{k, N} \in \mathbb{R}_{+}$satisfying

for all $x, y \in \mathbb{R}^{m}$ and any $n \in\{1, \ldots, N\}$ and ${ }_{k} \hat{v}:=\left.\sum_{n=1}^{N}\right|_{k, n} \hat{\eta} \mid \hat{c}_{k, n}$ belongs to $\mathscr{S}_{2, \text { loc }}^{\frac{p}{1-\alpha_{k}}}\left(\mathbb{R}_{+}\right)$.
Thus, if $\vartheta=\vartheta_{1}$ and these four requirements are met, then Lemma 3.20 implies the following two assertions:
(5) For any solution $X$ to (1.2) such that $E\left[\left|X_{t_{0}}\right|^{p}\right]<\infty$ the estimate (3.18) is valid if the local integrability of

holds. Thereby, the formulas (3.16) and (3.17) apply when $l, \alpha, \beta$ and $c_{p, \mathscr{P}}$ are replaced by $l+2,(\alpha, 0,1),(\beta, 0,0)$ and 1 , respectively, with the choice

$\left({ }_{k+1} \nu,{ }_{k+1} \hat{\nu}\right)=(|\kappa|,|\hat{\kappa}|)$ and $\left({ }_{k+2} \nu,{ }_{k+2} \hat{\nu}\right)=\left(\zeta_{\eta},|\hat{\eta}|\right)$.
(6) Define $\underline{v} \in \mathscr{L}_{l o c}^{1}(\mathbb{R})$ by $\underline{\nu}:=\zeta_{\eta}+\sum_{k=1, \alpha_{k}=1}^{l}\left[{ }_{k} v\right]_{\infty}$. Then $E\left[|X|^{p}\right]$ is bounded provided

$$
\underline{\nu}^{+}, \quad[|\hat{\eta}|]_{\infty}^{2}, \quad \sum_{\substack{k=1, \alpha_{k}<1}}^{l}\left[{ }_{k} \nu\right]_{\frac{p}{1-\alpha_{k}}}, \quad \sum_{k=1}^{l}[k \hat{v}]_{\frac{p}{1-\alpha_{k}}}^{2}, \quad E\left[|\kappa|^{p}\right]^{\frac{1}{p}} \quad \text { and } \quad E\left[|\hat{\kappa}|^{p}\right]^{\frac{2}{p}}
$$

are integrable. If additionally $\int_{t_{0}}^{\infty} \underline{\nu}^{-}(s) d s=\infty$, then $\lim _{t \uparrow \infty} E\left[\left|X_{t}\right|^{p}\right]=0$.

### 3.4 Strong solutions with locally bounded moment functions

Now we suppose that $b$ and $\sigma$ are two Borel measurable maps on $\left[t_{0}, \infty\right) \times \mathbb{R}^{m} \times \mathscr{P}$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively, and $\xi: \Omega \rightarrow \mathbb{R}^{m}$ is $\mathscr{F}_{t_{0}}$-measurable. The aim of this section is to deduce a strong solution $X$ to (2.5) with $X_{t_{0}}=\xi$ a.s. such that the measurable $p$-th moment function

$$
\left[t_{0}, \infty\right) \rightarrow[0, \infty], \quad t \mapsto E\left[\left|X_{t}\right|^{p}\right]
$$

is finite and locally bounded for $p \in[2, \infty)$. Namely, we use the preceding comparison and growth results to construct the law of the solution as local uniform limit of a Picard iteration. In this setting, $b(s, \cdot, \mu)$ is not required to be Lipschitz continuous or of affine growth for any $(s, \mu) \in\left[t_{0}, \infty\right) \times \mathscr{P}$.

For a Borel measurable map $\mu:\left[t_{0}, \infty\right) \rightarrow \mathscr{P}$ we define two measurable maps $b_{\mu}$ and $\sigma_{\mu}$ on $\left[t_{0}, \infty\right) \times \mathbb{R}^{m}$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively, by $b_{\mu}(t, x):=b(t, x, \mu(t))$ and $\sigma_{\mu}(t, x):=\sigma(t, x, \mu(t))$. These two coefficients induce the SDE

$$
\begin{equation*}
d X_{t}=b_{\mu}\left(t, X_{t}\right) d t+\sigma_{\mu}\left(t, X_{t}\right) d W_{t} \quad \text { for } t \in\left[t_{0}, \infty\right) \tag{3.19}
\end{equation*}
$$

To obtain strong solutions for this equation, we introduce a growth as well as a continuity and boundedness condition and a spatial Osgood condition on compact sets on $(b, \sigma)$ :
(D.1) There exist $\kappa, v, \chi \in \mathscr{L}_{l o c}^{1}\left(\mathbb{R}_{+}\right)$and $\phi, \varphi \in \mathrm{R}_{c}$ so that $\phi$ is concave, $\int_{1}^{\infty} \phi(v)^{-1} d v=\infty$ and

$$
2 x^{\prime} b(\cdot, x, \mu)+|\sigma(\cdot, x, \mu)|^{2} \leq \kappa+v \phi\left(|x|^{2}\right)+\chi \varphi\left(\vartheta\left(\mu, \delta_{0}\right)^{2}\right)
$$

for every $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$.
(D.2) $b(s, \cdot, \mu)$ and $\sigma(s, \cdot, \mu)$ are continuous for any $\mu \in \mathscr{P}$ for a.e. $s \in\left[t_{0}, \infty\right)$ and for each $n \in \mathbb{N}$ there is $c_{n}>0$ such that

$$
|b(s, x, \mu)| \vee|\sigma(s, x, \mu)| \leq c_{n}
$$

for any $(x, \mu) \in \mathbb{R}^{m} \times \mathscr{P}\left(\mathbb{R}^{m}\right)$ with $|x| \vee \vartheta\left(\mu, \delta_{0}\right) \leq n$ for a.e. $s \in\left[t_{0}, t_{0}+n\right]$.
(D.3) For every $n \in \mathbb{N}$ there are $\eta_{n} \in \mathscr{L}_{l o c}^{1}\left(\mathbb{R}_{+}\right)$and a concave function $\rho_{n} \in \mathrm{R}_{c}$ such that $\int_{0}^{1} \rho_{n}(v)^{-1} d v=\infty$ and

$$
2(x-\tilde{x})^{\prime}(b(\cdot, x, \mu)-b(\cdot, \tilde{x}, \mu))+|\sigma(\cdot, x, \mu)-\sigma(\cdot, \tilde{x}, \mu)|^{2} \leq \eta_{n} \rho_{n}\left(|x-\tilde{x}|^{2}\right)
$$

for all $x, \tilde{x} \in \mathbb{R}^{m}$ with $|x| \vee|\tilde{x}| \leq n$ and each $\mu \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$.
We write $B_{b, l o c}(\mathscr{P})$ for the set of all $\mathscr{P}$-valued Borel measurable maps $\mu$ on $\left[t_{0}, \infty\right)$ such that $\sup _{s \in\left[t_{0}, t\right]} \vartheta\left(\mu(s), \delta_{0}\right)<\infty$ for any $t \in\left[t_{0}, \infty\right)$. Then a local weak existence result from [18, Corollary 3.4 and Lemma 3.19 allow for a concise analysis of the SDE (3.19).

Proposition 3.22. For $\mu \in B_{b, l o c}(\mathscr{P})$ the following three assertions hold:
(i) Under (D.3), we have pathwise uniqueness for (3.19).
(ii) Let (D.1) and (D.2) be satisfied. Then there is a weak solution $X$ to (3.19) with $\mathscr{L}\left(X_{t_{0}}\right)=\mathscr{L}(\xi)$.
(iii) Assume that (D.1)-(D.3) are valid. Then (3.19) admits a unique strong solution $X^{\xi, \mu}$ such that $X_{t_{0}}^{\xi, \mu}=\xi$ a.s.

Now consider the convex space $B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ of all $\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)$-valued Borel measurable maps $\mu$ on $\left[t_{0}, \infty\right)$ such that $\vartheta_{p}\left(\mu, \delta_{0}\right)$ is locally bounded, endowed with the topology of local uniform convergence.

Then $B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ is completely metrisable, as $\vartheta_{p}$ is complete, and a sequence $\left(\mu_{n}\right)_{n \in \mathbb{N}}$ in this space converges locally uniformly to some $\mu \in B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ if and only if $\lim _{n \uparrow \infty} \sup _{s \in\left[t_{0}, t\right]} \vartheta_{p}\left(\mu_{n}, \mu\right)(s)=0$ for all $t \in\left[t_{0}, \infty\right)$.

To deduce a strong solution to (2.5) as local uniform limit of a Picard iteration in $B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right.$ ), we replace the spatial Osgood condition (D.3) on compacts sets by a Lipschitz condition, which implies the former:

for all $x, \tilde{x} \in \mathbb{R}^{m}$ and every $\mu, \tilde{\mu} \in \mathscr{P}$ a.e. on $\left[t_{0}, \infty\right)$.
Assuming that (D.4) is satisfied, from which (C.4) follows for $(\mathrm{B}, \Sigma)=(b, \sigma), l=2$, $\alpha=(1,0)$ and $\beta=(0,1)$, we define $\gamma_{p} \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ and $\delta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$by

So, $\gamma_{p}$ and $\delta$ are defined according to the formulas in (3.5) and (3.6), respectively, for the choice $l=2, \alpha=(1,0), \beta=(0,0)$ and $\zeta_{2}=\hat{\zeta}_{2}=1$, as we will use the $L^{p}$-estimate of Proposition 3.9 when $(\mathrm{B}, \Sigma)=\left(b_{\mu}, \sigma_{\mu}\right)$ and $(\tilde{\mathrm{B}}, \tilde{\Sigma})=\left(b_{\tilde{\mu}}, \sigma_{\tilde{\mu}}\right)$ for $\mu, \tilde{\mu} \in B_{b, l o c}(\mathscr{P})$.

If in addition the following affine growth condition for $(b, \sigma)$ is valid, from which (D.1) follows, by Young's inequality, as $\alpha+\beta \in[0,1]$, then an estimate in $B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ for the Picard iteration holds.

Since the previous condition ensures that (C.12) is satisfied for $(\mathrm{B}, \Sigma)=(b, \sigma)$, we may utilise the coefficients $f_{p, \mathscr{P}} \in \mathscr{L}_{l o c}^{1}(\mathbb{R})$ and $g_{p, \mathscr{P}} \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}\right)$given by (3.16) and (3.17) for the choice $\kappa_{k}=\hat{\kappa}_{k}=1$ for all $k \in\{1, \ldots, l\}$. That is,

As a result, we obtain a unique strong solution to (2.5) with initial value condition $\xi$ together with a semi-explicit error estimate and an explicit growth estimate.
Theorem 3.23. Assume that (D.1) and $p=2$ or (D.5) hold and let (D.2), (D.4) be valid. Further, let $\mathscr{P}_{p}\left(\mathbb{R}^{m}\right) \subset \mathscr{P}, \mu_{0} \in B_{b, \text { loc }}(\mathscr{P}), E\left[|\xi|^{p}\right]<\infty$ and $\Theta:\left[t_{0}, \infty\right) \times \mathscr{P}^{2} \rightarrow \mathbb{R}_{+}$be given by

(i) We have pathwise uniqueness for (2.5) with respect to $\Theta$ and there is a unique strong solution $X^{\xi}$ such that $X_{t_{0}}^{\xi}=\xi$ a.s. and $E\left[\left|X^{\xi}\right|^{p}\right]$ is locally bounded.
(ii) The map $\left[t_{0}, \infty\right) \rightarrow \mathscr{P}_{p}\left(\mathbb{R}^{m}\right), t \mapsto \mathscr{L}\left(X_{t}^{\xi}\right)$ is the local uniform limit of the sequence $\left(\mu_{n}\right)_{n \in \mathbb{N}}$ recursively defined via $\mu_{n}:=\mathscr{L}\left(X^{\xi, \mu_{n-1}}\right)$ and

Then the following three assertions hold:
(1) If there are $\eta \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}^{2}\right)$ and $\hat{\eta} \in \mathscr{L}_{\text {loc }}^{2}\left(\mathbb{R}_{+}^{2}\right)$ with $\eta_{2} \geq 0$ such that

\end{gathered}

for every $x, \tilde{x}, y, \tilde{y} \in \mathbb{R}^{m}$ a.e. on $\left[t_{0}, \infty\right)$, then (D.4) is satisfied.
(2) Given $l \in \mathbb{N}$ and $\alpha, \beta \in[0,1]^{l}$ with $\alpha+\beta \in[0,1]^{l}$, suppose that there are $v \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}^{l}\right)$ and $\hat{v} \in \mathscr{L}_{l o c}^{2}\left(\mathbb{R}_{+}^{l}\right)$ such that

(3) Let $b_{0}(s, \cdot, y)$ and $\sigma_{0}(s, \cdot, y)$ be continuous for all $y \in \mathbb{R}^{m}$ for a.e. $s \in\left[t_{0}, \infty\right)$ and assume that for each $n \in \mathbb{N}$ there is $c_{n}>0$ such that

For instance, let $N \in \mathbb{N}, \hat{b} \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}_{+}^{N}\right)$ and $\hat{c} \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R}^{N}\right)$ and suppose that $\left.\hat{\alpha} \in\right] 0, \infty\left[^{N}\right.$ and $f_{1}, \ldots, f_{N}$ are $\mathbb{R}^{m}$-valued Lipschitz continuous maps on $\mathbb{R}^{m} \times \mathbb{R}^{m}$ such that

for any $x, y \in \mathbb{R}^{m}$ with $x \neq 0$ and $b_{0}(\cdot, 0, \cdot)=\hat{c}_{1} f_{1}(0, \cdot)+\cdots+\hat{c}_{N} f_{N}(0, \cdot)$. Then all the conditions for $b_{0}$ in (1) and (2) are satisfied and the conditions for $b_{0}$ in (3) hold if $\hat{b}$ and $\hat{c}$ are in fact locally bounded. In particular,

## 4 Moment and pathwise asymptotic estimations for random Itô processes

### 4.1 Auxiliary moment bounds

From now on, let $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ satisfy $\int_{t_{0}}^{t}\left|\hat{\mathrm{~B}}_{s}\right|+\left|\hat{\Sigma}_{s}\right|^{2} d s<\infty$ for all $t \in\left[t_{0}, \infty\right)$ and $Y$ be a random Itô process with drift $\hat{\mathrm{B}}$ and diffusion $\hat{\Sigma}$, as introduced in [23] [Section 4.1]. That is, $Y$ is an $\mathbb{R}^{m}$-valued adapted continuous process such that

$$

Our aim is to give quantitative $L^{p}$-estimates for $Y$ in a random seminorm when $p \in[2, \infty)$. For this purpose, we fix $\hat{m} \in \mathbb{N}$ and let $V$ be an $\mathbb{R}^{\hat{m} \times m}$-valued adapted locally absolutely continuous process. For $A \in \mathbb{R}^{\hat{m} \times m}$ we define a seminorm on $\mathbb{R}^{m}$ by

and note that the induced matrix seminorm defined via $|B|_{A}:=\sup _{x \in \mathbb{R}^{d} \backslash\{0\}}|B x|_{A}$ satisfies $|B|_{A}=|A B|$ for any $B \in \mathbb{R}^{m \times d}$. In particular, the random (matrix) seminorm $|\cdot|_{V}$ is an adapted continuous process.

The continuous map $\psi_{d}: \mathbb{R}^{d \times \hat{m}} \times \mathbb{R}^{\hat{m}} \backslash\{0\} \rightarrow \mathbb{R}^{d \times d}$ given by $\psi_{d}(A, x):=A x(A x)^{\prime} /|x|^{2}$ satisfies $\left|\psi_{d}(A, x)\right|=|x|_{A}^{2} /|x|^{2} \leq|A|^{2}$ for any $A \in \mathbb{R}^{d \times \hat{m}}$ and all $x \in \mathbb{R}^{\hat{m}} \backslash\{0\}$. Thus, the map

\mathbb{R}^{d \times \hat{m}} \times \mathbb{R}^{\hat{m}} \rightarrow \mathbb{R}^{d \times d}, \quad(A, x) \mapsto(p-2)|x|_{A}^{p-2} \psi_{d}(A, x)

is continuous once we set $\psi_{d}(\cdot, 0):=0$. Bearing these considerations in mind, we consider the following representation.

for any $t \in\left[t_{0}, \infty\right)$ a.s.
Proof. The function $\varphi:\left(\mathbb{R}^{\hat{m}}\right)^{m} \times \mathbb{R}^{m} \rightarrow \mathbb{R}_{+}$defined by $\varphi\left(a_{1}, \ldots, a_{m}, x\right):=\left|\sum_{j=1}^{m} a_{j} x_{j}\right|^{p}$ is twice continuously differentiable with first-order derivatives with respect to the $j$-th and the last variable given by

for each $j \in\{1, \ldots, m\}$, all $a_{1}, \ldots, a_{m} \in \mathbb{R}^{\hat{m}}$ and any $x \in \mathbb{R}^{m}$, where $A \in \mathbb{R}^{\hat{m} \times m}$ is of the form $A=\left(a_{1}, \ldots, a_{m}\right)$. Its second-order derivative relative to the last variable can be written in the form

We recall the constant $c_{p}=(p-1) / 2$ and employ the just considered bound on the map $\psi_{d}$ to get an auxiliary $L^{p}$-estimate.
Lemma 4.2. Let $E\left[\left|Y_{t_{0}}\right| V_{t_{0}}^{p}\right]<\infty$ and $\tau$ be a stopping time. Assume there is $Z \in \mathscr{S}(\mathbb{R})$ such that $\int_{t_{0}}^{t}\left|Z_{s}\right| d s<\infty$ for any $t \in\left[t_{0}, \infty\right)$ and

### 4.2 Quantitative moment estimates

First, we derive an $L^{2}$-estimate from Section 4.1 and Bihari's inequality. For this purpose, let $l \in \mathbb{N}$ and consider the following assumption on the Itô process $Y$ :

Thus, if we choose the function $u(t)=\exp \left(-\int_{t_{0}}^{t} \hat{\gamma}_{p}(s) d s\right)$ for all $t \in\left[t_{0}, \infty\right)$ and the stopping time $\tau=\inf \left\{\left.t \in\left[t_{0}, \infty\right)| | Y_{t}\right|_{V_{t}} \geq n\right\}$ in (4.11) for any $n \in \mathbb{N}$, then

for each $t \in\left[t_{0}, \infty\right)$, by an application of Fatou's lemma. In particular, $E\left[|Y|_{V}^{p}\right]$ is locally bounded. Thus, a second estimation by means of (2.2) shows that

\left(\int_{t}^{t+\hat{\delta}} \eta_{j, 1}^{+}(s) \max \left\{1,\left[j, 2 \eta_{s}\right]_{\frac{p q}{2-\alpha_{j}}}^{q}\right\} d s\right) \vee\left(\int_{t}^{t+\hat{\delta}} \hat{\eta}_{k, 1}(s) \max \left\{1,\left[k, 2 \hat{\eta}_{s}\right]_{\frac{p q}{2-\hat{\alpha}_{k}}}^{\frac{q}{2}}\right\} d s\right)
$$

is bounded by $\bar{c}_{0}$ for each $t \in\left[t_{1}, \infty\right)$ and any $j, k \in\{1, \ldots, l\}$ with $j \leq l-1$.
Then the pathwise asymptotic behaviour of $Y$ in the next section can be handled with the subsequent $p q$-th moment estimate in a supremum seminorm.

Proposition 4.12. Let ( (A.4) hold, $E\left[\left|Y_{t_{0}}\right|_{V_{t_{0}}}^{p q}\right]<\infty$ and $\sum_{k=1, \beta_{k}>0}^{l}[k \eta]_{p q /\left(2-\alpha_{k}\right)} \theta_{k}^{\beta_{k}}$ be locally integrable and assume there are $\gamma \in \mathscr{L}_{\text {loc }}^{1}(\mathbb{R})$ and $\bar{c}_{\gamma,-1}, \bar{c}_{\gamma, 0}, \bar{c}_{\gamma, q}, \hat{c}_{\gamma, 0} \in \mathbb{R}_{+}$so that

for any $t_{2}, t \in\left[t_{1}, \infty\right)$ with $t_{2} \leq t<\hat{\delta}$ and each $q_{0} \in\{0, q\}$. Then there is $\bar{c}>0$ such that

\end{equation*}

for every $t_{2}, t \in\left[t_{1}, \infty\right)$ with $t_{2} \leq t<\hat{\delta}$.

Proof. As ${ }_{k} \eta=0$ (resp. ${ }_{k} \hat{\eta}=0$ ) a.e. on $\left[t_{1}, \infty\right)$ for any $k \in\{1, \ldots, l\}$ with $\alpha_{k}+\beta_{k}<2$ (resp. $\hat{\alpha}_{k}+\hat{\beta}_{k}<2$ ), it follows from Remark 4.10 together with Lemma 4.11 and Jensen's inequality that

& +p \bar{c}_{0}^{1-\frac{1}{q}} \sum_{k=1}^{l-1} c_{k}^{2-\alpha_{k}}\left(\int_{t_{2}}^{t} \eta_{k, 1}^{+}(s)\left[k, 2 \eta_{s}\right]_{\frac{p q}{2-\alpha_{k}}}^{q} e^{-q \int_{t_{2}}^{s} \gamma\left(s_{0}\right) d s_{0}} E\left[\left|Y_{s}\right|_{V_{s}}^{p q}\right] d s\right)^{\frac{1}{q}}  \tag{4.16}\\
& +\bar{c}_{\gamma,-1}^{1-\frac{1}{q}}\left(\int_{t_{2}}^{t}\left(p\left[l \eta_{s}\right]_{\infty}-\gamma\right)^{+}(s) e^{-q \int_{t_{2}}^{s} \gamma\left(s_{0}\right) d s_{0}} E\left[\left|Y_{s}\right|_{V_{s}}^{p q}\right] d s\right)^{\frac{1}{q}} \\
& +p \bar{c}_{0}^{\frac{1}{2}-\frac{1}{q}} \sum_{k=1}^{l} c_{k}^{1-\frac{\hat{\alpha}_{k}}{2}}\left(\bar{w}_{q} \int_{t_{2}}^{t} \hat{\eta}_{k, 1}(s)\left[k, 2 \hat{\eta}_{s}\right]_{\frac{p q}{2-\hat{\alpha}_{k}}}^{\frac{q}{2}} e^{-q \int_{t_{2}}^{s} \gamma\left(s_{0}\right) d s_{0}} E\left[\left|Y_{s}\right|_{V_{s}}^{p q}\right] d s\right)^{\frac{1}{q}} .
\end{align*}

In this context, we used that $E\left[{ }_{k} \eta^{q}|Y|_{V}^{p \alpha 0 p q}\right] \leq\left[{ }_{k} \eta\right]_{p q / 2}^{q} E\left[|Y|_{V}^{p q}\right]^{p \alpha_{0}}$ for any $k \in\{1, \ldots, l\}$ with $\alpha_{k}=0$ and $\alpha_{p, 0}:=(p-2) / p$, by Hölder's inequality, and

for all $s \in\left[t_{2}, t\right]$ and $q_{0} \in\{0, q\}$. Thus, the sum of the four right-hand terms in (4.16) is bounded by the right-hand expression in (4.15) when $\bar{c}$ is replaced by the constant

Because $\exp \left(-\int_{t_{2}}^{s} \gamma\left(s_{0}\right) d s_{0}\right) \geq \exp \left(-\hat{c}_{\gamma, 0}\right)$ for any $s \in\left[t_{2}, t\right]$, the claimed bound holds for $\bar{c}:=\exp \left(\hat{c}_{\gamma, 0}\right) \bar{c}_{1}$.

### 4.4 Pathwise asymptotic behaviour

Finally, we derive a limiting bound for $Y$ under the random seminorm $|\cdot|_{V}$ from the moment estimate of Proposition 4.12. For this purpose, we recall an application of the Borel-Cantelli Lemma in [23] [Lemma 4.11 and Remark 4.12].

Namely, let $A \in \mathscr{F}$ and $X$ be an $\mathbb{R}_{+}$-valued right-continuous process for which there are a strictly increasing sequence $\left(t_{n}\right)_{n \in \mathbb{N}}$ in $\left[t_{0}, \infty\right)$ with $\lim _{n \uparrow \infty} t_{n}=\infty$, a sequence $\left(c_{n}\right)_{n \in \mathbb{N}}$ in $(0, \infty), \hat{c}>0$ and $\hat{\varepsilon} \in(0,1)$ such that

for each $\varepsilon \in(0, \hat{\varepsilon})$. Then any $(0, \infty)$-valued lower semicontinuous function $\varphi$ on $\left(t_{1}, \infty\right)$ satisfies

Theorem 4.13. Let (A.4) be satisfied and $\sum_{k=1, \beta_{k}>0}^{l}[k \eta]_{p q /\left(2-\alpha_{k}\right)} \theta_{k}^{\beta_{k}}$ be locally integrable. Assume that $\gamma_{p q, c} \leq 0$ a.e. on $\left[t_{1}, \infty\right)$ and there is an increasing sequence $\left(t_{n}\right)_{n \in \mathbb{N} \backslash\{1\}}$ in $\left[t_{1}, \infty\right)$ such that

and $\sum_{n=1}^{\infty} \exp \left(\varepsilon(p q)^{-1} \int_{t_{1}}^{t_{n}} \gamma_{p q, c}(s) d s\right)<\infty$ for all $\varepsilon \in(0, \hat{\varepsilon})$ and some $\hat{\varepsilon} \in(0,1)$. If $E\left[\left|Y_{t_{0}}\right|_{V_{t_{0}}}^{p q}\right]$ is finite or $\beta=\hat{\beta}=0$, then

for each increasing function $\varphi:\left[t_{1}, \infty\right) \rightarrow \mathbb{R}_{+}$that is positive on $\left(t_{1}, \infty\right)$.
Proof. Since $\gamma_{p q, c}=p q\left(\left[{ }_{l} \eta\right]_{\infty}+\sum_{k=1}^{l-1} c_{k}^{2-\alpha_{k}}\left[{ }_{k} \eta\right]_{p q /\left(2-\alpha_{k}\right)}\right)$ a.e. on $\left[t_{1}, \infty\right)$, it follows that $\left[{ }_{l} \eta\right]_{\infty} \leq 0$ a.e. on the same interval. Consequently, if $E\left[\left|Y_{t_{0}}\right|_{V_{t_{0}}}^{p q}\right]<\infty$, then

for all $n \in \mathbb{N}$, as the random Itô process $Y \mathbb{1}_{A_{k}}$ with drift $\hat{\mathrm{B}} \mathbb{1}_{A_{k}}$ and diffusion $\hat{\Sigma} \mathbb{1}_{A_{k}}$ satisfies (A.3) and (A.4). Hence, in both cases the claimed pathwise inequality follows from the result recalled at (4.17) and the fact that $\bigcup_{k \in \mathbb{N}} A_{k}=\Omega$.

## 5 Proofs of the main results

### 5.1 Proofs of the moment estimates, uniqueness and moment stability

Proof of Proposition 3.1. Let $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ be defined via

Then $Y$ is a random Itô process with drift $\hat{B}$ and diffusion $\hat{\Sigma}$ satisfying

a.e. on $\left[t_{0}, \infty\right)$ a.s. with the measurable function $\theta:=\vartheta\left(P_{X}, P_{\tilde{X}}\right)$. For this reason, the proposition is a special case of Proposition 4.4 for the constant choice $V=\mathbb{I}_{m}$.

Proof of Corollary 3.4. For both claims in (i) and (ii) let $X$ and $\tilde{X}$ be two solutions to (1.2) with $X_{t_{0}}=\tilde{X}_{t_{0}}$ a.s. Suppose first that (C.2) holds and the expression

Then Proposition 3.1] gives $E\left[\left|X_{t}-\tilde{X}_{t}\right|^{2}\right]=0$ for any $t \in\left[t_{0}, \infty\right)$, as $\varrho_{0} \in C\left(\mathbb{R}_{+}\right)$given by $\varrho_{0}(v):=\rho(v) \vee \varrho\left(c_{2, \mathscr{P}}^{2} v\right)$ satisfies $(0, w) \in D_{\varrho_{0}}$ and $\Psi_{\varrho_{0}}(0, w)=0$ for all $w \in \mathbb{R}_{+}$. Hence, path continuity implies that $X$ and $\tilde{X}$ are indistinguishable.

Now let (C.3) hold and set $\tau_{n}:=\inf \left\{t \in\left[t_{0}, \infty\right)| | X_{t} \mid \geq n\right.$ or $\left.\left|\tilde{X}_{t}\right| \geq n\right\}$ for fixed $n \in \mathbb{N}$. Then $X^{\tau_{n}}$ and $\tilde{X}^{\tau_{n}}$ are solutions to (1.2) when B and $\Sigma$ are replaced by the admissible maps ${ }_{n} \mathrm{~B}$ and ${ }_{n} \Sigma$ with values in $\mathbb{R}^{m}$ and $\mathbb{R}^{m \times d}$, respectively, given by

{ }_{n} \mathrm{~B}_{s}(x):=\hat{\mathrm{B}}_{s}\left(\varphi_{n}(x)\right) \mathbb{1}_{\left\{\tau_{n}>s\right\}} \quad \text { and } \quad{ }_{n} \Sigma_{s}(x):=\hat{\Sigma}_{s}\left(\varphi_{n}(x)\right) \mathbb{1}_{\left\{\tau_{n}>s\right\}},

where $\varphi_{n}$ is the radial retraction of the ball $\left\{x \in \mathbb{R}^{m}| | x \mid \leq n\right\}$. This $\mathbb{R}^{m}$-valued map on $\mathbb{R}^{m}$ is defined by $\varphi(x)=x$, if $|x| \leq n$, and ${\underset{\sim}{\varphi}}_{n}(x)=(n /|x|) x$, if $|x|>n$.

Because (C.1) holds when $(\mathrm{B}, \bar{\Sigma})=(\tilde{\mathrm{B}}, \tilde{\Sigma})=\left({ }_{n} \mathrm{~B},{ }_{n} \Sigma\right), \varepsilon=0$ and $(\eta, \lambda, \rho)=\left(\eta_{n}, 0, \rho_{n}\right)$, Proposition 3.1 yields $X^{\tau_{n}}=\tilde{X}^{\tau_{n}}$ a.s., which implies that $X=\tilde{X}$ a.s.
Proof of Proposition 3.9. We define $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ by (5.1) and observe that

a.e. on $\left[t_{0}, \infty\right)$ a.s. with $\theta:=\vartheta\left(P_{X}, P_{\tilde{X}}\right)$. So, all claims follow from Theorem 4.6, as our considerations succeeding the definitions (3.5) and (3.6) explain.

Thereby, Young's inequality shows that the local integrability of $\Theta\left(\cdot, P_{X}, P_{\tilde{X}}\right)$ entails that of $\hat{\zeta}_{j} \hat{\zeta}_{k}\left[j \hat{\eta}_{k} \hat{\eta}\right]_{p /\left(2-\alpha_{j}-\alpha_{k}\right)} \theta^{\beta_{j}+\beta_{k}}$ for each $j, k \in\{1, \ldots, l\}$, since
$\left[{ }_{j} \hat{\eta}_{k} \hat{\eta}\right]_{\frac{p}{2-\alpha_{j}-\alpha_{k}}} \leq\left[{ }_{j} \hat{\eta}\right]_{\frac{p}{1-\alpha_{j}}}[k \hat{\eta}]_{\frac{p}{1-\alpha_{k}}} \quad$ and $\quad p \hat{\zeta}_{k}^{2} \leq p-1+\alpha_{k}+\beta_{k}+\left(1-\alpha_{k}-\beta_{k}\right) \hat{\zeta}_{k}^{\frac{2 p}{1-\alpha_{k}-\beta_{k}}}$.

Proof of Corollary 3.11. Definition 2.5 clarifies that both stability claims are immediate consequences of Proposition 3.9,

Proof of Corollary 3.12. From Remark 4.7 we infer the first two assertions, by replacing $\gamma_{p, c}$ by $\gamma_{p, \mathscr{P}}$ there. Regarding the exponential $p$-th moment stability, we note that

To ensure that (5.3) is satisfied for all $t \in\left[t_{0}, \infty\right)$ we take the constant

\hat{c}:=\hat{c}_{0} \vee \exp \left(\int_{t_{0}}^{t_{1}} \gamma_{p, \mathscr{P}}(s) d s-\hat{\lambda}_{1}\left(t_{1}-s_{1}\right)^{\alpha_{1}}\right)

instead of $\hat{c}_{0}$, because $\int_{t_{1}}^{t} \gamma_{p, \mathscr{P}}(s) d s \leq \hat{\lambda}_{1}\left(\left(t-s_{1}\right)^{\alpha_{1}}-\left(t_{1}-s_{1}\right)^{\alpha_{1}}\right)$ for each $t \in\left[t_{1}, \infty\right)$.

### 5.2 Proofs for pathwise stability and moment growth bounds

Proof of Proposition 3.15. Because $Y$ is random Itô process with drift $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and diffusion $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ defined via (5.1) for the choice $(\tilde{\mathrm{B}}, \tilde{\Sigma})=(\mathrm{B}, \Sigma)$, it follows from the estimates (5.2) that the assertion is a special case of Theorem 4.13,

Proof of Corollary 3.16. To show both claims simultaneously, we may argue as in the proof of Corollary 3.19 in [23]. Namely, we take $\hat{t}_{1} \in\left[t_{1}, \infty\right)$ and $\tilde{\delta}>0$ such that $\gamma_{p q, \mathscr{P}} \leq 0$ a.e. on $\left[\hat{t}_{1}, \infty\right)$ and set $t_{n}:=\hat{t}_{1}+\tilde{\delta}(n-1)$ for all $n \in \mathbb{N}$. Then

$$
\int_{0}^{\infty} \exp \left(\frac{\varepsilon}{p q} \int_{\hat{t}_{1}}^{\hat{t}_{1}+\tilde{\delta} t} \gamma_{p q, \mathscr{P}}(s) d s\right) d t \leq \int_{0}^{\infty} \exp \left(\frac{\varepsilon}{p q} \sum_{k=1}^{l} \hat{\lambda}_{k} \int_{\hat{t}_{1}}^{\hat{t}_{1}+\tilde{\delta} t} \alpha_{k}\left(s-s_{k}\right)^{\alpha_{k-1}} d s\right) d t
$$

for any given $\varepsilon>0$. Since $\hat{\lambda}_{l}<0$, the integral on the right-hand side is finite, see Lemma 5.1 in [23], for instance. Thus, the integral test for the convergence of series implies that $\sum_{n=1}^{\infty} \exp \left(\varepsilon(p q)^{-1} \int_{\hat{t}_{1}}^{t_{n}} \gamma_{p q, \mathscr{P}}(s) d s\right)<\infty$.

Consequently, (C.9) follows as soon as $\tilde{\delta}<\hat{\delta}$ and Proposition (3.15 entails that the difference $Y$ of any two solutions $X$ and $\tilde{X}$ to (1.2) for which $\Theta\left(\cdot, P_{X}, P_{\tilde{X}}\right)$ is locally integrable satisfies

$$
\limsup _{t \uparrow \infty} \frac{\log \left(\left|Y_{t}\right|\right)}{t^{\alpha_{l}}} \leq \frac{1}{p q} \limsup _{n \uparrow \infty} \sum_{k=1}^{l} \hat{\lambda}_{k} \frac{\left(t_{n}-s_{k}\right)^{\alpha_{k}}-\left(\hat{t}_{1}-s_{k}\right)^{\alpha_{k}}}{t_{n}^{\alpha_{l}}}=\frac{\hat{\lambda}_{l}}{p q} \quad \text { a.s. }
$$

provided $E\left[\left|Y_{t_{0}}\right|^{p q}\right]<\infty$ or both B and $\Sigma$ are independent of $\mu \in \mathscr{P}$.
Proof of Lemma [3.19, By hypothesis, $X$ is a random Itô process with drift $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and diffusion $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ given by $\hat{\mathrm{B}}_{s}:=\mathrm{B}\left(X_{s}, P_{X_{s}}\right)$ and $\hat{\Sigma}_{s}:=\Sigma_{s}\left(X_{s}, P_{X_{s}}\right)$ so that

$$
2 X^{\prime} \hat{\mathrm{B}}+|\hat{\Sigma}|^{2} \leq \kappa+v \phi\left(|X|^{2}\right)+\chi \varphi\left(\theta^{2}\right)
$$

a.e. on $\left[t_{0}, \infty\right)$ a.s. with the measurable function $\theta:=\vartheta\left(P_{X}, \delta_{0}\right)$. For this reason, the lemma is a special case of Proposition 4.4.
Proof of Lemma [3.20, We let $\hat{\mathrm{B}} \in \mathscr{S}\left(\mathbb{R}^{m}\right)$ and $\hat{\Sigma} \in \mathscr{S}\left(\mathbb{R}^{m \times d}\right)$ be given as in the proof of Lemma 3.19 and readily see that

$$
X^{\prime} \hat{\mathrm{B}} \leq \sum_{k=1}^{l} \kappa_{k}{ }_{k} v|X|^{1+\alpha_{k}} \vartheta\left(P_{X}, \delta_{0}\right)^{\beta_{k}} \quad \text { and } \quad|\hat{\Sigma}|^{2} \leq \sum_{j, k=1}^{l} \hat{\kappa}_{j} \hat{\kappa}_{k j} \hat{v}{ }_{k} \hat{v}|X|^{\alpha_{k}} \vartheta\left(P_{X}, \delta_{0}\right)^{\beta_{k}}
$$

a.e. on $\left[t_{0}, \infty\right)$ a.s. Hence, Theorem 4.6 yields all assertions.

### 5.3 Proofs for unique strong solutions

Proof of Proposition 3.2.2. (i) Because (C.3) is satisfied when (B, $\Sigma)=\left(b_{\mu}, \sigma_{\mu}\right)$, pathwise uniqueness for (3.19) follows from Corollary 3.4 .
(ii) In essence, we may proceed as in the proof of Proposition 3.26 in [23]. First, let $\xi$ be essentially bounded. Then Theorem 2.3 in [18] [Chapter IV] yields a local weak solution $\tilde{X}$ to (3.19).

That is, $\tilde{X}$ is an $\mathbb{R}^{m} \cup\{\infty\}$-valued adapted continuous process on a filtered probability
 the usual and the following conditions hold:
(1) If $(s, \omega) \in\left[t_{0}, \infty\right) \times \tilde{\Omega}$ satisfies $\tilde{X}_{s}(\omega)=\infty$, then $\tilde{X}_{t}(\omega)=\infty$ for any $t \in[s, \infty)$.
(2) $\mathscr{L}\left(\tilde{X}_{t_{0}}\right)=\mathscr{L}(\xi)$ and for the supremum $\tau$ of the sequence $\left(\tau_{n}\right)_{n \in \mathbb{N}}$ of stopping times defined by $\tau_{n}:=\inf \left\{t \in\left[t_{0}, \infty\right)| | \tilde{X}_{t} \mid \geq n\right\}$ we have $\tau>t_{0}$ a.s.
(3) $\tilde{X}^{\tau_{n}}$ solves (1.2) on $\left(\tilde{\Omega}, \tilde{\mathscr{F}},\left(\tilde{\mathscr{F}}_{t}\right)_{t \in \mathbb{R}_{+}}, \tilde{P}\right)$ relative to $\tilde{W}$ when B and $\Sigma$ are replaced by the admissible maps $b_{\mu} \mathbb{1}_{\left\{\tau_{n}>\right\}}$ and $\sigma_{\mu} \mathbb{1}_{\left\{\tau_{n}>\right\}}$, respectively, for every $n \in \mathbb{N}$.
Clearly, (D.1) ensures that (C.11) holds for $(\mathrm{B}, \Sigma)=\left(b_{\mu}, \sigma_{\mu}\right)$, as $\kappa_{\mu}:=\kappa+\chi \varphi\left(\vartheta\left(\mu, \delta_{0}\right)^{2}\right)$ is locally integrable. Consequently, Lemma 3.19 and Fatou's lemma assert that

$$
\tilde{E}\left[\left|\tilde{X}_{t}^{\tau}\right|^{2}\right] \leq \liminf _{n \uparrow \infty} \tilde{E}\left[\left|\tilde{X}_{t}^{\tau_{n}}\right|^{2}\right] \leq \Psi_{\phi}\left(E\left[|\xi|^{2}\right]+\int_{t_{0}}^{t} \kappa_{\mu}(s) d s, \int_{t_{0}}^{t} v(s) d s\right)
$$

for each $t \in\left[t_{0}, \infty\right)$, which implies that $\tau=\infty$ and $\tilde{X} \in \mathbb{R}^{m} \tilde{P}$-a.s. Thus, $\tilde{X} \mathbb{1}_{\{\tau=\infty\}}$ serves as weak solution to (2.5) in the standard sense.

In particular, this derivation applies to the case when $\xi$ is deterministic. Therefore, Remark 2.1 in [18] [Chapter IV] entails that there is a weak solution $X$ to (2.5) with $X_{t_{0}}=\xi$ a.s., regardless of whether $\xi$ is essentially bounded.
(iii) By what we have just shown, pathwise uniqueness for (3.19) holds and there exists a weak solution for any $\mathbb{R}^{m}$-valued $\mathscr{F}_{t_{0}}$-measurable random vector used as initial condition. Hence, Theorem 1.1 in [18][Chapter IV] entails the assertion.

Proof of Theorem 3.23. (i) and (ii) Pathwise uniqueness with respect to $\Theta$ follows from Proposition [3.9, as the underlying filtered probability space and Brownian motion were arbitrarily chosen. In particular, there exists at most a unique solution $X$ to (2.5) such that $X_{t_{0}}=\xi$ a.s. and $E\left[|X|^{p}\right]$ is locally bounded.

Next, for any $\mu \in B_{b, l o c}(\mathscr{P})$ Proposition 3.22 gives a unique strong solution $X^{\xi, \mu}$ to (3.19) with $X_{t_{0}}^{\xi, \mu}=\xi$ a.s., and $E\left[\left|X^{\xi, \mu}\right|^{p}\right]$ is locally bounded, by Lemmas 3.19 and 3.20. We note that this process is also a strong solution to (2.5) if $\mu$ is a fixed-point of the operator

$$
\Psi: B_{b, l o c}(\mathscr{P}) \rightarrow B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right), \quad \Psi(\nu)(t):=\mathscr{L}\left(X_{t}^{\xi, \nu}\right) .
$$

For given $\mu, \tilde{\mu} \in B_{b, l o c}(\mathscr{P})$ we immediately check that (C.4) is valid when (B, $\Sigma$ ) and ( $\left.\tilde{\mathrm{B}}, \tilde{\Sigma}\right)$ are replaced by $\left(b_{\mu}, \sigma_{\mu}\right)$ and $\left(b_{\tilde{\mu}}, \sigma_{\tilde{\mu}}\right)$, respectively. Hence, Proposition 3.9 implies that

$$
\begin{equation*}
\vartheta_{p}(\Psi(\mu), \Psi(\tilde{\mu}))(t)^{p} \leq E\left[\left|X_{t}^{\xi, \mu}-X_{t}^{\xi, \tilde{\mu}}\right|^{p}\right] \leq \int_{t_{0}}^{t} e^{t} \gamma_{p}(\tilde{s}) d \tilde{s} \delta(s) \vartheta(\mu, \tilde{\mu})(s)^{p} d s \tag{5.4}
\end{equation*}
$$

for every $t \in\left[t_{0}, \infty\right)$. In particular, this shows that there is at most a unique fixed-point of $\Psi$, due to Gronwall's inequality.

Further, because $B_{b, \text { loc }}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ is completely metrisable, the fixed-point theorem for time evolution operators in [22] yields the existence of a fixed-point and the error estimate (3.24). Namely, it follows inductively that

$$
\begin{equation*}
\sup _{s \in\left[t_{0}, t\right]} \vartheta_{p}\left(\mu_{m}, \nu_{n}\right)(s) \leq \Delta(t) \sum_{i=n}^{m-1}\left(\frac{c_{p, \mathscr{P}}^{i}}{i!}\right)^{\frac{1}{p}}\left(\int_{t_{0}}^{t} e^{\int_{s}^{t} \gamma_{p}^{+}(\tilde{s}) d \tilde{s}} \delta(s) d s\right)^{\frac{i}{p}} \tag{5.5}
\end{equation*}
$$

for any $m, n \in \mathbb{N}$ with $m>n$ and each $t \in\left[t_{0}, \infty\right)$. Hence, $\left(\mu_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$ and from (5.4) we infer that its limit $\mu$ must be a fixed-point of $\Psi$. Now we may take the limit $m \uparrow \infty$ in (5.5) to get the desired bound (3.24).
(iii) The set $M_{p}$ is closed and convex, since the estimate in (3.25) does not depend on $\mu \in B_{b, l o c}\left(\mathscr{P}_{p}\left(\mathbb{R}^{m}\right)\right)$. An application of Lemma 3.20 entails that

$$
\begin{equation*}
\vartheta_{p}\left(\Psi(\mu)(t), \delta_{0}\right)^{p} \leq e^{\int_{t_{0}}^{t} f_{p, \mathscr{Q}, 0}(s) d s} E\left[|\xi|^{p}\right]+\int_{t_{0}}^{t} e^{\int_{s}^{t} f_{p, \mathscr{P}, 0}(\tilde{s}) d \tilde{s}} g_{p, \mu}(s) d s \tag{5.6}
\end{equation*}
$$

for every $\mu \in B_{b, l o c}(\mathscr{P})$ and all $t \in\left[t_{0}, \infty\right)$ with the two measurable and locally integrable functions

$$
f_{p, \mathscr{P}, 0}:=p \sum_{\substack{k=1, \alpha_{k}=1}}^{l} v_{k}+\sum_{\substack{k=1, \alpha_{k}<1}}^{l}\left(p-1+\alpha_{k}\right) c_{p, \mathscr{P}}^{\beta_{k}} v_{k}^{+}+c_{p} \sum_{j, k=1}^{l}\left(p-2+\alpha_{j}+\alpha_{k}\right) c_{p, \mathscr{P}}^{\beta_{j}+\beta_{k}} \hat{v}_{j} \hat{v}_{k}
$$

and

$$
\begin{aligned}
g_{p, \mu}:= & \sum_{\substack{k=1, \alpha_{k}<1}}^{l}\left(1-\alpha_{k}\right) \vartheta_{p}\left(\mu, \delta_{0}\right)^{\frac{\beta_{k}}{1-\alpha_{k}} p} c_{p, \mathscr{P}}^{\beta_{k}} v_{k}^{+} \\
& +c_{p} \sum_{\substack{j, k=1, \alpha_{j}<1 \text { or } \alpha_{k}<1}}^{l}\left(2-\alpha_{j}-\alpha_{k}\right) \vartheta_{p}\left(\mu, \delta_{0}\right)^{\frac{\beta_{j}+\beta_{k}}{2-\alpha_{j}-\alpha_{k}} p} c_{p, \neq \mathscr{P}}^{\beta_{j}+\beta_{k}} \hat{v}_{j} \hat{v}_{k} .
\end{aligned}
$$

Thereby, we used the fact that $\left(b_{\mu}, \sigma_{\mu}\right)$ satisfies (C.12) for the choice $\beta=0$. Next, Young's inequality gives us that

$$
\left(1-\alpha_{k}\right) \vartheta_{p}\left(\mu, \delta_{0}\right)^{\frac{\beta_{k}}{1-\alpha_{k}} p} \leq 1-\alpha_{k}-\beta_{k}+\beta_{k} \vartheta_{p}\left(\mu, \delta_{0}\right)^{p}
$$

for every $k \in\{1, \ldots, l\}$ with $\alpha_{k}<1$ and

$$
\left(2-\alpha_{j}-\alpha_{k}\right) \vartheta_{p}\left(\mu, \delta_{0}\right)^{\frac{\beta_{j}+\beta_{k}}{2 \alpha_{j}-\alpha_{k}} p} \leq 2-\alpha_{j}-\alpha_{k}-\beta_{j}-\beta_{k}+\left(\beta_{j}+\beta_{k}\right) \vartheta_{p}\left(\mu, \delta_{0}\right)^{p}
$$

for any $j, k \in\{1, \ldots, l\}$ with $\alpha_{j}<1$ or $\alpha_{k}<1$. From these estimates we infer that $f_{p, \mathscr{P}, 1}:=f_{p, \mathscr{P}}-f_{p, \mathscr{P}, 0}$ satisfies

$$
g_{p, \mu} \leq g_{p, \mathscr{P}}+f_{p, \mathscr{P}, 1} \vartheta_{p}\left(\mu, \delta_{0}\right)^{p} .
$$

So, the inequality (5.6), the Fundamental Theorem of Calculus for Lebesgue-Stieltjes integrals and Fubini's theorem show that $\Psi$ maps $M_{p}$ into itself, which implies the claim.
