# The well-posedness of the stochastic nonlinear Schrödinger equations in $H^{2}\left(\mathbb{R}^{d}\right)$

#### Abstract

The Cauchy problem for the stochastic nonlinear Schrödinger equation with multiplicative noise is considered where the nonlinear term is of power type and the noise coefficients are purely imaginary numbers. The main purpose of this paper is to construct classical solutions in $H^{2}\left(\mathbb{R}^{d}\right)$ for the problem. The techniques of Kato [21, [22] work well in overcoming this difficulty even for the stochastic equations.


## 1 Introduction and main results

### 1.1 Stochastic and Deterministic nonlinear Schrödinger equations

We consider the Cauchy problem for the stochastic nonlinear Schrödinger equation (SNLS) with a multiplicative noise in the general spatial dimension $d \in \mathbb{N}$ :

\left\{\begin{align*}
i d X(t, \xi)= & \Delta X(t, \xi) d t+\lambda|X(t, \xi)|^{\alpha-1} X(t, \xi) d t & &  \tag{1.1}\\
& -i \mu(\xi) X(t, \xi) d t+i X(t, \xi) d W(t, \xi), & & t \in(0, T), \xi \in \mathbb{R}^{d} \\
X(0, \xi)= & x(\xi) & & \xi \in \mathbb{R}^{d},
\end{align*}\right.
$$

where the constants $\lambda= \pm 1, \alpha>1$. The Wiener process $W$ and $\mu$ are the functions as follows, where

$$
\begin{align*}
W(t, \xi) & =\sum_{j=1}^{N} i \phi_{j}(\xi) \beta_{j}(t), \quad t \geq 0, \xi \in \mathbb{R}^{d},  \tag{1.2}\\
\mu(\xi) & =\frac{1}{2} \sum_{j=1}^{N} \phi_{j}^{2}(\xi), \quad \xi \in \mathbb{R}^{d} . \tag{1.3}
\end{align*}
$$

Here, $N \in \mathbb{N} \cup\{+\infty\}$, and the $\phi_{j}(\xi)$ are real-valued functions. The $\beta_{j}(t)$ are real-valued function independent Brownian motions with respect to a probability space $(\Omega, \mathcal{F}, \mathbf{P})$ with natural filtration

[^0]$\left(\mathcal{F}_{t}\right)_{t \geq 0}, 1 \leq j \leq N$. This equation was introduced by [6, 7]. In this paper we assume $N<\infty$ as in [6, 7]. But our techniques easily go over to the case where $N=+\infty$ (i.e. infinite dimensional noise). We refer to [26, Remark 2.3.13] for details.

There are a number of papers with results on the deterministic nonlinear Schrödinger equation which is given as in the case $W=0$ in (1.1), (1.2) and (1.3). We introduce the typical condition for the power of nonlinearity,

$$

1<\alpha<1+\frac{4}{(d-2 s)^{+}}, \tag{1.4}
\end{equation*}
$$

for the time local well-posedness in $H^{s}\left(\mathbb{R}^{d}\right), s \geq 0$. Here,

$$
\frac{1}{h^{+}}= \begin{cases}\frac{1}{h}, & h>0 \\ \infty, & h \leq 0\end{cases}
$$

This condition is derived from a scaling argument, and actually the time local well-posedness was shown for $s=1$ by Ginible-Velo [18, for $s=0$ by Tsutsumi [25], for $s=2$ by Kato [21, 22] and for the general $0 \leq s<d / 2$ by Cazenave-Weissler [16. We call the case $s=0$ charge class, $s=1$ energy class respectively since there are the conservation laws for $L^{2}\left(\mathbb{R}^{d}\right)$ and $H^{1}\left(\mathbb{R}^{d}\right)$ respectively. We sometimes call the case $s=2$ classical solution class since the nonlinear Schrödinger equation is a second-order partial differential equation with the Laplacian in $x$.

So a natural question arises. Can we solve the stochastic nonlinear Schrödinger equation under the condition of (1.4)? There are some results. The conservative case (i.e. the special case of purely imaginary noise $\operatorname{Re} W=0$ ) was studied in [11, 12]. In [11] local existence and uniqueness of solutions in $L^{2}\left(\mathbb{R}^{d}\right)$ were proved for $\alpha$ satisfying

\begin{cases}1<\alpha<1+\frac{4}{d} & d=1,2  \tag{1.5}\\ 1<\alpha<1+\frac{2}{d-1} & d \geq 3\end{cases}
$$

and in [12] local existence and uniqueness of solutions in $H^{1}\left(\mathbb{R}^{d}\right)$ were proved for $\alpha$ satisfying

$$
\begin{cases}1<\alpha<\infty & d=1,2  \tag{1.6}\\ 1<\alpha<5 & d=3 \\ 1<\alpha<1+\frac{2}{d-1} \text { or } 2 \leq \alpha<1+\frac{4}{d-2} & d=4,5 \\ 1<\alpha<1+\frac{2}{d-1} & d \geq 6\end{cases}
$$

In the non-conservative case, V. Barbu, M. Röckner and D. Zhang 6, 7] solved the time local well-posedness in $L^{2}\left(\mathbb{R}^{d}\right)$ and $H^{1}\left(\mathbb{R}^{d}\right)$ under the full condition (1.4) by using the rescaling approach with an additional condition (see below $\left.(\mathrm{H} 1)_{s}\right)$. This transformation reduces the stochastic nonlinear Schrödinger equation to an equivalent random Schrödinger equation.

See also [8, 13, 14, 15, 19, 20, 24] for further work on the stochastic nonlinear Schrödinger equation.

In this paper, we study the well-posedness in $H^{2}\left(\mathbb{R}^{d}\right)$ in the conservation case by making use of the rescaling approach as a main tool for dealing with the multiplicative noise, where we need to take advantage of a slight modification of the deterministic Strichartz estimates adapted to the setting of $H^{2}\left(\mathbb{R}^{d}\right)$. Unlike the $L^{2}$ and $H^{1}$-solutions, the difficulties in proving the $H^{2}$-solution are the smoothness argument for the function of the nonlinear terms and the modification of Kato's technique [21, 22] by the modified evolution operator.

### 1.2 Results by the rescaling approach

In this subsection we introduce the four results on the time local well-posedness for (1.1) by using the rescaling approach. The two results in Theorem 1.2 for $s=0,1$, are already known, and the other two results for $s=2$ with different settings in Theorems 1.3 and 1.4 are the main results in this paper. To state those results precisely, we introduce an assumption on $\left\{\phi_{j}\right\}_{j=1}^{N}$ as follows. We assume some decay conditions.
$(\mathrm{H} 1)_{s} \phi_{j} \in C_{b}^{\infty}\left(\mathbb{R}^{d}\right)$ such that

\lim _{|\xi| \rightarrow \infty} \zeta(\xi)\left|\partial^{\gamma} \phi_{j}(\xi)\right|=0
$$

where $\gamma$ is a multi-index such that $|\gamma| \leq s+2,1 \leq j \leq N$ and

$$
\zeta(\xi)= \begin{cases}1+|\xi|^{2}, & \text { if } d \neq 2 \\ \left(1+|\xi|^{2}\right)\left(\log \left(3+|\xi|^{2}\right)\right)^{2}, & \text { if } d=2\end{cases}
$$

Remark. We remark that the assumption (H1) is the almost same with [6, 7]. We assume $|\gamma| \leq 4$ on the derivative of $\phi_{j}$ though it was assumed $|\gamma| \leq 2$ in [6] and $|\gamma| \leq 3$ in [7].

We define the notion of solvability for the stochastic equation.
Definition 1.1. Let $x \in H^{s}(s=0,1,2)$ and let $\alpha>1$. Fix $0<T<\infty$. A solution of (1.1) is a pair $(X, \tau)$, where $\tau(\leq T)$ is an $\left(\mathcal{F}_{t}\right)$-stopping time, and $X=(X(t))_{t \in[0, T]}$ is an $H^{s}$-valued continuous $\left(\mathcal{F}_{t}\right)$-adapted process, such that $|X|^{\alpha-1} X \in L^{1}\left(0, \tau ; H^{s-2}\right)$, P-a.s., and it satisfies P-a.s.

$$
\begin{equation*}
X(t)=x-\int_{0}^{t \wedge \tau}\left(i \Delta X(r)+\mu X(r)+\lambda i|X(r)|^{\alpha-1} X(r)\right) d r+\int_{0}^{t \wedge \tau} X(r) d W(r), \quad t \in[0, T], \tag{1.7}
\end{equation*}
$$

as an equation in $H^{s-2}$.
We say that uniqueness for (1.1) holds in the function space $S$, if for any two solutions of (1.1) $\left(X_{i}, \tau_{i}\right), X_{i} \in S, i=1,2$, it holds P-a.s. that $X_{1}=X_{2}$ on $\left[0, \tau_{1} \wedge \tau_{2}\right]$.

We state the two known results for $s=0$ and $s=1$ which were shown in [6, Theorem 2.2] and [7. Theorem 2.1] respectively in the following theorem.

Theorem 1.2 ( $H^{s}$ local well-posedness for $s=0,1$ ).
Let $s=0$ or 1 . Assume $(\mathrm{H} 1)_{s}$. Let $\alpha$ satisfy (1.4). Then, for each $x \in H^{s}$ and $0<T<\infty$, there is a sequence of local solutions $\left(X_{n}, \tau_{n}\right)$ of (1.1), $n \in \mathbb{N}$, where $\tau_{n}$ is a sequence of increasing stopping times. For every $n \geq 1$, it holds $\mathbf{P}$-a.s. that

$$
\left.X_{n}\right|_{\left[0, \tau_{n}\right]} \in C\left(\left[0, \tau_{n}\right] ; H^{s}\right) \cap L^{\gamma}\left(0, \tau_{n} ; W^{s, \rho}\right),
$$

and uniqueness holds in the function space $C\left(\left[0, \tau_{n}\right] ; H^{s}\right) \cap L^{\gamma}\left(0, \tau_{n} ; W^{s, \rho}\right)$ where $(\rho, \gamma)$ is any Strichartz pair. Here, the Strichartz pair for spatial dimension $d=1,2,3, \cdots$, is defined by

\begin{array}{ll}
\left(p_{i}, q_{i}\right) \in[2, \infty] \times[2, \infty]: \frac{2}{q_{i}}=\frac{d}{2}-\frac{d}{p_{i}}, & \text { if } d \neq 2 \\
\left(p_{i}, q_{i}\right) \in[2, \infty) \times(2, \infty]: \frac{2}{q_{i}}=\frac{d}{2}-\frac{d}{p_{i}}, & \text { if } d=2
\end{array}
$$

Moreover, defining $\tau^{*}(x)=\lim _{n \rightarrow \infty} \tau_{n}$ and $X=\lim _{n \rightarrow \infty} X_{n} \mathbf{1}_{\left[0, \tau^{*}(x)\right)}$, for $n \geq 1$ and $\mathbf{P}$-a.s. $\omega \in \Omega$, the map $x \rightarrow X(\cdot, x, \omega)$ is continuous from $H^{s}$ to $L^{\infty}\left(0, \tau_{n} ; H^{s}\right) \cap L^{\gamma}\left(0, \tau_{n} ; W^{s, \rho}\right)$ where $(\rho, \gamma)$ is any Strichartz pair. Furthermore, we have the blowup alternative, that is, for $\mathbf{P}$-a.s. $\omega$, if $\tau_{n}(\omega)<\tau^{*}(x)(\omega), \forall n \in \mathbb{N}$, then

$$
\lim _{t \rightarrow \tau^{*}(x)(\omega)}\|X(t)(\omega)\|_{H^{s}}=\infty
$$

Now we state our main theorems. The main theorem is shown in the range of the following exponents.

$$
\begin{cases}1<\alpha<\infty, & 1 \leq d \leq 4,  \tag{1.8}\\ 1<\alpha<1+\frac{2}{d-2} \text { or } 2 \leq \alpha<1+\frac{4}{d-4}, & 5 \leq d \leq 7, \\ 1<\alpha<1+\frac{2}{d-2}, & d \geq 8\end{cases}
$$

Theorem 1.3 ( $H^{2}$ local well-posedness).
Assume (H1) $)_{2}$ and let $\alpha$ satisfy (1.8). Then, for each $x \in H^{2}$ and $0<T<\infty$, there is a sequence of local solutions $\left(X_{n}, \tau_{n}\right)$ of (1.1), $n \in \mathbb{N}$, where $\tau_{n}$ is a sequence of increasing stopping times. For every $n \geq 1$, it holds $\mathbf{P}$-a.s. that

$$
\left.X_{n}\right|_{\left[0, \tau_{n}\right]} \in C\left(\left[0, \tau_{n}\right] ; H^{2}\right),
$$

and uniqueness holds in the function space $C\left(\left[0, \tau_{n}\right] ; H^{2}\right)$. Moreover, defining $\tau^{*}(x)=\lim _{n \rightarrow \infty} \tau_{n}$ and $X=\lim _{n \rightarrow \infty} X_{n} \mathbf{1}_{\left[0, \tau^{*}(x)\right)}$, for $n \geq 1$, $\mathbf{P}$-a.s. $\omega \in \Omega$ and $0 \leq s<2$, the map $x \rightarrow X(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{s}\right)$.

Remark. The proof of Theorem 1.3 is based on Kato's technique [21, 22]. Unlike the $H^{2}$-solution of the deterministic Schrödinger equation, the evolution operator modified by the rescaling approach is not commutative with $\nabla$ and $\Delta$ and is not a semigroup. This causes the gap of exponent $\alpha$ in (1.8). This gap came from the condition of Sobolev's embedding. And, we note that we do not use Kato's technique when the exponent $\alpha$ is greater than or equal to 2 .

If we assume that the exponent $\alpha$ is greater than or equal to 2 , we obtain the following better properties for the solution. We can show strictly the space to which the solution belongs and the continuous dependence of the initial values.

Theorem 1.4 ( $H^{2}$ local well-posedness for sufficiently smooth nonlinearities). Assume $d \leq 7$ and (H1) . Let $\alpha$ satisfy $2 \leq \alpha<1+\frac{4}{(d-4)^{+}}$. Then, for each $x \in H^{2}$ and $0<T<\infty$, there is a sequence of local solutions $\left(X_{n}, \tau_{n}\right)$ of (1.1), $n \in \mathbb{N}$, where $\tau_{n}$ is a sequence of increasing stopping times. For every $n \geq 1$, it holds $\mathbf{P}$-a.s. that

$$
\left.X_{n}\right|_{\left[0, \tau_{n}\right]} \in C\left(\left[0, \tau_{n}\right] ; H^{2}\right) \cap L^{q}\left(0, \tau_{n} ; W^{2, p}\right),
$$

and uniqueness holds in the function space $C\left(\left[0, \tau_{n}\right] ; H^{2}\right)$ where $(p, q)$ is given by

$$
\begin{cases}\text { any Strichartz pair } & d=1,2,3, \\ (p, q)=\left(\frac{2(\alpha+2)}{\alpha+1}, \alpha+2\right) & d=4, \\ (p, q)=\left(\frac{d(\alpha+1)}{d+2 \alpha-2}, \frac{4(\alpha+1)}{(d-4)(\alpha-1)}\right) & d=5,6,7\end{cases}
$$

Moreover, defining $\tau^{*}(x)=\lim _{n \rightarrow \infty} \tau_{n}$ and $X=\lim _{n \rightarrow \infty} X_{n} \mathbf{1}_{\left[0, \tau^{*}(x)\right)}$, for $n \geq 1$ and $\mathbf{P}$-a.s. $\omega \in \Omega$, the map $x \rightarrow X(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{2}\right) \cap L^{q}\left(0, \tau_{n} ; W^{2, p}\right)$. Furthermore, we have the blowup alternative, that is, for $\mathbf{P}$-a.s. $\omega$, if $\tau_{n}(\omega)<\tau^{*}(x)(\omega)$, for every $n \in \mathbb{N}$, then

$$
\lim _{t \rightarrow \tau^{*}(x)(\omega)}\|X(t)(\omega)\|_{H^{2}}=\infty
$$

It is natural to consider the existence of global solutions. We introduce the known result in $H^{1}$ which is [8, Theorem 1.2].
Theorem 1.5 ( $H^{1}$ global well-posedness).
Assume (H1) . Let $\alpha$ satisfy $1<\alpha<1+\frac{4}{(d-2)^{+}}$if $\lambda=-1$, or $1<\alpha<1+\frac{4}{d}$ if $\lambda=1$. Then, for each $x \in H^{1}$ and $0<T<\infty$, there exists a unique $H^{1}$-global solution $(X, T)$ of (1.1), such that

$$
X \in L^{\gamma}\left(0, T ; W^{1, \rho}\right), \mathbf{P} \text {-a.s. }
$$

where $(\rho, \gamma)$ is any Strichartz pair. Moreover, for $\mathbf{P}$-a.s. $\omega$, the map $x \rightarrow X(\cdot, x, \omega)$ is continuous from $H^{1}$ to $L^{\infty}\left(0, T ; H^{1}\right) \cap L^{\gamma}\left(0, T ; W^{1, \rho}\right)$ where $(\rho, \gamma)$ is any Strichartz pair.

The following theorem which corresponds to $H^{2}$-solutions is new.
Theorem 1.6 (The existence of global solutions in $H^{2}$ ).
Assume $d \leq 7$ and (H1) $)_{2}$. Let $\alpha$ satisfy $2 \leq \alpha<1+\frac{4}{(d-4)^{+}}$. In addition, we assume that for $x \in H^{2}, 0<T<\infty$, the following holds.

$$
\|X\|_{L^{\infty}\left(0, T ; H^{1}\right)}+\|X\|_{L^{q}\left(0, T ; W^{1, p}\right)}<\infty, \mathbf{P}-\mathrm{a} \text {.s. }
$$

where $(p, q)=\left(\alpha+1, \frac{4(\alpha+1)}{d(\alpha-1)}\right)$. Then, there exists a unique $H^{2}$-global solution $(X, T)$ of (1.1).
So by restricting the range of power to that of $H^{1}$ well-posedness, we may apply Theorem 1.6 to have the following $H^{2}$ globally well-posed result, as a corollary. This method is sometimes called persistence of regularity.

Corollary 1.7. Assume $d \leq 7$ and (H1)2. Let $\alpha$ satisfy $2 \leq \alpha<1+\frac{4}{(d-2)^{+}}$if $\lambda=-1$, or $2 \leq \alpha<1+\frac{4}{d}$ if $\lambda=1$. Then, there exists a unique $H^{2}$-global solution $(X, T)$ of (1.1).

## 2 Rescaling approach

The main tool to prove Theorem 1.3 and Theorem 1.4 is based on the rescaling approach as used for Theorem 1.2 in [6, 7]. We apply the rescaling transformation

$$
\begin{equation*}
X(t, \xi)=e^{W(t, \xi)} y(t, \xi) . \tag{2.1}
\end{equation*}
$$

By an application of Itô's product formula, we see that $\mathbf{P}$-a.s.

$$
d X=e^{W} d y+e^{W} y d W-\mu e^{W} y d t
$$

We apply (2.1) to (1.1) to have

$$
\left\{\begin{array}{l}
\frac{\partial y(t, \xi)}{\partial t}=A(t) y(t, \xi)-\lambda i|y(t, \xi)|^{\alpha-1} y(t, \xi)  \tag{2.2}\\
y(0, \xi)=x(\xi)
\end{array}\right.
$$

where

$$
\begin{align*}
A(t) y(t, \xi) & =-i e^{-W} \Delta\left(e^{W} y\right) \\
& =-i(\Delta+b(t, \xi) \cdot \nabla+c(t, \xi)) y(t, \xi),  \tag{2.3}\\
b(t, \xi) & =2 \nabla W(t, \xi),  \tag{2.4}\\
c(t, \xi) & =\sum_{j=1}^{d}\left(\partial_{j} W(t, \xi)\right)^{2}+\Delta W(t, \xi) . \tag{2.5}
\end{align*}
$$

The definition of solutions to (2.2) are given in the following sense (similar to Definition (1.1).
Definition 2.1. Let $x \in H^{s}(s=0,1,2)$ and let $\alpha>1$. Fix $0<T<\infty$. A $H^{s}$-solution of (2.2) is a pair $(y, \tau)$, where $\tau(\leq T)$ is an $\left(\mathcal{F}_{t}\right)$-stopping time, and $y=(y(t))_{t \in[0, T]}$ is an $H^{s}$-valued continuous $\left(\mathcal{F}_{t}\right)$-adapted process, such that $|y|^{\alpha-1} y \in L^{1}\left(0, \tau ; H^{s-2}\right)$, $\mathbf{P}$-a.s., and it satisfies $\mathbf{P}$-a.s.

$$
\begin{equation*}
y(t)=x+\int_{0}^{t \wedge \tau} A(r) y(r) d r-\int_{0}^{t \wedge \tau} \lambda i|y(r)|^{\alpha-1} y(r) d r, \quad t \in[0, T], \tag{2.6}
\end{equation*}
$$

as an equation in $H^{s-2}$.
We say that uniqueness holds for (2.2) in the function space $S$, if for any two solutions of (2.2) $\left(y_{i}, \tau_{i}\right), y_{i} \in S, i=1,2$, it holds $\mathbf{P}$-a.s. that $y_{1}=y_{2}$ on $\left[0, \tau_{1} \wedge \tau_{2}\right]$.

The following theorem establishes the equivalence between the two definitions of solutions to (1.1) and (2.2) respectively.

Theorem 2.2. For $s=0,1,2$, the following holds.
(1) Let $(y, \tau)$ be a $H^{s}$-solution of (2.2) in the sense of Definition 2.1. Set $X:=e^{W} y$. Then $(X, \tau)$ is a $H^{s}$-solution of (1.1) in the sense of Definition 1.1
(2) Let $(X, \tau)$ be a $H^{s}$-solution of (1.1) in the sense of Definition 1.1. Set $y:=e^{-W} X$. Then $(y, \tau)$ is a $H^{s}$-solution of (2.2) in the sense of Definition [2.1.
Proof. The cases of $L^{2}$ and $H^{1}$ were proved in [6, 7]. Therefore, we prove the case of $H^{2}$. In the first case (1), since $x \in H^{2} \subset H^{1}$ and $y$ satisfies (2.6) in $L^{2} \subset H^{-1}$, Lemma 2.4 in 7 implies that $(X, \tau)$ is a solution of (1.1) in the sense of Definition 1.1, in particular, $X$ solves (1.7) in $H^{-1}$. But, as $y \in C\left([0, T] ; H^{2}\right)$ and $e^{W} \in C\left([0, T] ; W^{2, \infty}\right)$, we deduce that $X \in C\left([0, T] ; H^{2}\right)$. Hence, the right hand side of (1.7) is in $L^{2}$, which implies that $(X, \tau)$ is a solution of (1.1) in the sense of Definition 1.1. thereby completing the proof of (1). The proof for (2) follows analogously.

By the equivalence of two expressions of solutions via the rescaling transformation (2.1), Theorems 1.3, 1.4 and 1.6 are reformulated below in Theorems 2.3, 2.4 and 2.5, respectively.
Theorem 2.3. Assume (H1) . Let $\alpha$ satisfy (1.8). Then, for each $x \in H^{2}$ and $0<T<\infty$, there is a sequence of local solutions $\left(y_{n}, \tau_{n}\right)$ of (2.2), $n \in \mathbb{N}$, where $\tau_{n}$ is a sequence of increasing stopping times. For every $n \geq 1$, it holds $\mathbf{P}$-a.s. that

$$
\left.y_{n}\right|_{\left[0, \tau_{n}\right]} \in C\left(\left[0, \tau_{n}\right] ; H^{2}\right),
$$

and uniqueness holds in the function space $C\left(\left[0, \tau_{n}\right] ; H^{2}\right)$. Moreover, defining $\tau^{*}(x)=\lim _{n \rightarrow \infty} \tau_{n}$ and $y=\lim _{n \rightarrow \infty} y_{n} \mathbf{1}_{\left[0, \tau^{*}(x)\right)}$, for $n \geq 1$, P-a.s. $\omega \in \Omega$ and $0 \leq s<2$, the map $x \rightarrow y(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{s}\right)$.

Theorem 2.4. Assume $d \leq 7$ and (H1) $)_{2}$. Let $\alpha$ satisfy $2 \leq \alpha<1+\frac{4}{(d-4)^{+}}$. Then, for each $x \in H^{2}$ and $0<T<\infty$, there is a sequence of local solutions $\left(y_{n}, \tau_{n}\right)$ of (2.2), $n \in \mathbb{N}$, where $\tau_{n}$ is a sequence of increasing stopping times. For every $n \geq 1$, it holds $\mathbf{P}$-a.s. that

and uniqueness holds in the function space $C\left(\left[0, \tau_{n}\right] ; H^{2}\right)$ where $(\rho, \gamma)$ is any Strichartz pair. Moreover, defining $\tau^{*}(x)=\lim _{n \rightarrow \infty} \tau_{n}$ and $y=\lim _{n \rightarrow \infty} y_{n} \mathbf{1}_{\left[0, \tau^{*}(x)\right)}$, for $n \geq 1$ and P-a.s. $\omega \in \Omega$, the map $x \rightarrow y(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{2}\right) \cap L^{\gamma}\left(0, \tau_{n} ; W^{2, \rho}\right)$. Furthermore, we have the blowup alternative, that is, for $\mathbf{P}$-a.s. $\omega$, if $\tau_{n}(\omega)<\tau^{*}(x)(\omega)$, for every $n \in \mathbb{N}$, then

Theorem 2.5. Assume $d \leq 7$ and (H1) $)_{2}$. Let $\alpha$ satisfy $2 \leq \alpha<1+\frac{4}{(d-4)^{+}}$. In addition, we assume that for $x \in H^{2}, 0<T<\infty$, the following holds.

## 3 Deterministic Strichartz estimate

For the proof of Theorem 2.3 and Theorem [2.4] we discuss the evolution operators and the corresponding Strichartz estimate which was shown in [6] and [7].

Lemma 3.1. Assume (H1) ${ }_{2}$. For P-a.s. $\omega$, the operator $A(t)$ defined in (2.3) generates evolution operators $U(t, s)=U(t, s, \omega), 0 \leq s \leq t \leq T$, in the spaces $H^{2}\left(\mathbb{R}^{d}\right)$. Moreover, for each $x \in H^{2}\left(\mathbb{R}^{d}\right)$, the process $[s, T] \ni t \mapsto U(t, s) x \in H^{2}\left(\mathbb{R}^{d}\right)$ is continuous and $\left(\mathcal{F}_{t}\right)$-adapted, hence progressively measurable with respect to the filtration $\left(\mathcal{F}_{t}\right)_{t \geq s}$.

Proof. The existence of the evolution operator $U$ generated by $A(t)$ is a direct consequence of the fact that, for (P-a.s.) every $\omega \in \Omega$, the Cauchy problem

Indeed, by Theorem 1.1 in [17, under our assumptions on $c$ and $b$, for each $x \in H^{2}$ and $f \in L^{1}\left(s, T ; H^{2}\right)$, the Cauchy problem

has a unique solution $u \in C\left([s, T] ; H^{2}\right)$. Therefore, an evolution operator $U(t, s) \in L\left(H^{2}, H^{2}\right)$ is defined by $U(t, s) x=y(t), 0 \leq s \leq t \leq T$. For details, see Lemma 3.3 in [6] (see also [26]).

We give a precise definition of local smoothing spaces introduced in [23] as used in this paper.
Definition 3.2. Set $B_{0}=\{|\xi| \leq 2\}, B_{j}=\left\{2^{j} \leq|\xi| \leq 2^{j+1}\right\}, j \geq 1$, and $B_{<j}=\left\{|\xi| \leq 2^{j}\right\}$. Let $A_{j}=[0, T] \times B_{j}, j \geq 0, A_{<j}=[0, T] \times B_{<j}, j \geq 1$. We consider a dyadic partition of unity of frequency, i.e. $1=\sum_{k=-\infty}^{\infty} S_{k}(D)$. We say a function $f$ is localized at frequency $2^{k}$, if $\hat{f}$ is supported in $\left\{2^{k-1}<|\xi|<2^{k+1}\right\}$. The functions localized at frequency $2^{k}$ are measured using the norm

where $\langle\xi\rangle=\sqrt{1+|\xi|^{2}}$. Then the local smoothing space $\widetilde{X}_{[0, T]}$ is defined by the norm

\end{aligned}

We modify the deterministic Strichartz estimate in order to deal with $H^{2}$ solution.
Lemma 3.3. (Deterministic Strichartz estimate)
Assume (H1) 2 . Then for any $T>0, u_{0} \in H^{2}$ and $f \in L^{q_{2}^{\prime}}\left(0, T ; W^{2, p_{2}^{\prime}}\right)$, the solution of

Furthermore, the process $C_{t}, t \geq 0$, can be taken to be $\left(\mathcal{F}_{t}\right)$-progressively measurable, increasing and continuous.

where $\tilde{X}^{\prime}$ is dual space of $\tilde{X}$. Indeed, (3.5) is shown in [6] and (3.6) is shown in (7] by using (3.5). (3.2) and (3.3) are direct conclusion from (3.5) and (3.6) respectively. So we give a proof of (3.4) only. The proof is based on Theorem 1.13 and Proposition 2.3(a) in [23]. Let us use the notation $D_{t}:=-i \partial_{t}, D_{j}:=-i \partial_{j}, 1 \leq j \leq d$, to rewrite (3.1) in the form

We regard (3.7) as the equation for the unknown $\Delta u$ and treat the lower order term $\left(D_{j} \nabla \widetilde{b}^{j}+\right.$ $\left.\nabla \widetilde{b}^{j} D_{j}+\nabla \widetilde{c}\right) \nabla u$ and $\left(D_{j} \Delta \widetilde{b}{ }^{j}+\Delta \widetilde{b}{ }^{j} D_{j}+\Delta \widetilde{c}\right) u$ as equal terms with $\Delta f$. This leads to

& \leq C_{T}\left[\left\|\Delta u_{0}\right\|_{L^{2}}+\left\|2 i\left(D_{j} \nabla \tilde{b}^{j}+\nabla \tilde{b}^{j} D_{j}+\nabla \tilde{c}\right) \nabla u\right\|_{\tilde{X}^{\prime}{ }_{[0, T]}}\right. \\
& \left.+\left\|i\left(D_{j} \Delta \tilde{b}^{j}+\Delta \tilde{b}^{j} D_{j}+\Delta \tilde{c}\right) u\right\|_{\tilde{X}^{\prime}{ }_{[0, T]}}+\|\Delta f\|_{L^{q_{2}^{\prime}}\left(0, T ; L^{p^{\prime}}\right)}\right] \\

& \leq C_{T}\left[\left\|\Delta u_{0}\right\|_{L^{2}}+C_{T} \kappa_{T}^{1}\left(\left\|u_{0}\right\|_{H^{1}}+\|f\|_{L^{q_{2}^{\prime}}\left(0, T ; W^{1, p_{2}^{\prime}}\right)}\right)\right. \\
& \left.+C_{T} \kappa_{T}^{2}\left(\left\|u_{0}\right\|_{L^{2}}+\|f\|_{L^{q_{2}^{\prime}}\left(0, T ; L^{p_{2}^{\prime}}\right)}\right)+\|\Delta f\|_{L^{q_{2}^{\prime}}\left(0, T ; L^{p_{2}^{\prime}}\right)}\right] \\
& =C_{T}\left(C_{T} \kappa_{T}^{1}+C_{T} \kappa_{T}^{2}+1\right)\left[\left\|u_{0}\right\|_{H^{2}}+\|f\|_{L^{q_{2}^{\prime}\left(0, T ; W^{2, p_{2}^{\prime}}\right)}}\right] \text {, }

here we are faced at the term of the third derivative of $\tilde{b}^{j}$ which corresponds to the 4th derivative of $W$ which means the 4 th derivative of $\phi_{j}$. This together with (3.2), (3.3) yields the estimate (3.4). The $H^{2}$ continuity follows from Strichartz estimate (3.4) in the usual way. Now, we set

Then it is analogous to the proof of Lemma 4.1 in [6] that the stochastic process $C_{t}, t \geq 0$ is $\left(\mathcal{F}_{t}\right)$-progressively measurable, increasing, and continuous(see also [26]).

Remark. The estimate (3.5) holds only on the bounded interval [ $0, T$ ]. See [6, Appendix] for details. Therefore, the main result statements are that well-posedness is obtained whenever $T>0$ is fixed.

## 4 Proof of Theorem 2.3 and Theorem 2.4

Remark. The proof of Theorem 2.3 is shown for the case $1<\alpha \leq 1+\frac{2}{(d-2)^{+}}$only. For $3 \leq d \leq 7$, Theorem 2.4 yields Theorem 2.3,

Proof of Theorem 2.3. Set $g(y)=|y|^{\alpha-1} y$. We solve the weak equation (2.6) in the mild sense, namely

where $\|y\|_{s t r(t)}:=\|y\|_{L^{\infty}\left(0, t ; L^{2}\right)}+\|y\|_{L^{q}\left(0, t ; L^{p}\right)}, \tau_{1}=\tau_{1}(\omega) \in(0, T]$ and $M_{1}=M_{1}(\omega)>0$ are random variables. The distance is defined by $d\left(y_{1}, y_{2}\right)=\left\|y_{1}-y_{2}\right\|_{\text {str }}$. We differentiate with respect to $t$,

So, if we choose $t$ satisfy $C_{\tau_{1}} t^{\theta} \widetilde{R}^{\alpha-1} \leq \frac{1}{2}$, we obtain

Therefore, we can show the continuous dependence on $\left[0, \tau_{2}\right]$. Reiterating this procedure, we then obtain increasing stopping times $\tau_{n}$, depending on $\left\|y\left(\tau_{n-1}\right)\right\|_{H^{2}}$, such that continuous dependence holds on every $\left[0, \tau_{n}\right]$. Therefore, for $n \geq 1$, P-a.s. $\omega \in \Omega$ and $0 \leq s<2$, the map $x \rightarrow y(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{s}\right)$.

\left\|I_{5}+I_{7}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)} & \lesssim\left\|y_{m}\right\|_{L^{\infty}\left(0, t ; L^{r}\right.}^{\alpha-2} t^{\theta}\left\|\nabla y_{m}-\nabla y\right\|_{L^{q}\left(0, t ; L^{p}\right)} \\
& \lesssim \widetilde{R}^{\alpha-2} t^{\theta}\left\|y_{m}-y\right\|_{L^{q}\left(0, t ; W^{2, p}\right)} . \tag{4.31}
\end{align*}
$$

Here we used Hölder's inequality with

$$
1-\frac{1}{q}=\frac{\alpha-2}{\infty}+\theta+\frac{1}{q}, \quad 1-\frac{1}{p}=\frac{\alpha-2}{r}+\frac{1}{p}, \quad r=\frac{p(\alpha-2)}{p-2} .
$$

Therefore, by (4.29), (4.30) and (4.31),

$$
\begin{align*}
& \left\|y_{m}-y\right\|_{L^{\infty}\left(0, t ; H^{2}\right)}+\left\|y_{m}-y\right\|_{L^{q}\left(0, t ; W^{2, p}\right)} \\
& \lesssim\left\|x_{m}-x\right\|_{H^{2}}+t^{\theta}\left\|y_{m}-y\right\|_{L^{q}\left(0, t ; W^{1, p}\right)}+\widetilde{R}^{\alpha-1} t^{\theta}\left\|y_{m}-y\right\|_{L^{q}\left(0, t ; W^{2, p}\right)} \\
& \quad+\widetilde{R}^{\alpha-2} t^{\theta}\left\|y_{m}-y\right\|_{L^{q}\left(0, t ; W^{2, p}\right)}+\left\|I_{2}+I_{4}+I_{6}+I_{8}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)} . \tag{4.32}
\end{align*}
$$

Also, similar to the proof of Theorem 1.2 of [7], it follows that

$$
\begin{equation*}
\left\|I_{2}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)}+\left\|I_{4}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)}+\left\|I_{6}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)}+\left\|I_{8}\right\|_{L^{q^{\prime}}\left(0, t ; L^{p^{\prime}}\right)} \rightarrow 0, \text { as } m \rightarrow \infty \tag{4.33}
\end{equation*}
$$

Thus, (4.24), (4.32), (4.33) through (4.25) follow. Reiterating this procedure in finite steps we obtain (4.25) on $\left[0, \tau_{1}\right]$.

Now, since $y_{m}\left(\tau_{1}\right) \rightarrow y\left(\tau_{1}\right)$ in $H^{2}$, similarly we can get the above results to $\left[\tau_{1}, \tau_{2}\right]$ with $\tau_{2}$ depending on $\left\|y\left(\tau_{1}\right)\right\|_{H^{2}}$. Therefore, we can show the continuous dependence on $\left[0, \tau_{2}\right]$. Reiterating this procedure, we then obtain increasing stopping times $\tau_{n}$, depending on $\left\|y\left(\tau_{n-1}\right)\right\|_{H^{2}}$, such that continuous dependence holds on every $\left[0, \tau_{n}\right]$. Therefore, for $n \geq 1$ and $\mathbf{P}$-a.s. $\omega \in \Omega$, the map $x \rightarrow y(\cdot, x, \omega)$ is continuous from $H^{2}$ to $L^{\infty}\left(0, \tau_{n} ; H^{2}\right) \cap L^{q}\left(0, \tau_{n} ; W^{2, p}\right)$. The same is true for any Strichartz pair $(\rho, \gamma)$.

Finally, we prove the blowup alternative. Suppose that

$$
\mathbf{P}\left(M^{*}<\infty ; \tau_{n}<\tau^{*}(x), \forall n \in \mathbb{N}\right)>0
$$

where

$$
M^{*}:=\sup _{t \in\left[0, \tau^{*}(x)\right)}\|y(t)\|_{H^{2}} .
$$

Define

$$
\begin{aligned}
Z_{t} & =2 \cdot 3^{\alpha-1} C_{t}^{\alpha}\left(M^{*}\right)^{\alpha-1} t^{\theta}, t \in[0, T] . \\
\sigma & :=\inf \left\{t \in[0, T]: Z_{t}>\frac{1}{3}\right\} \wedge T .
\end{aligned}
$$

For $\omega \in\left\{M^{*}<\infty ; \tau_{n}<\tau^{*}(x), \forall n \in \mathbb{N}\right\}$, since $\tau_{n}(\omega)<T, \forall n \in \mathbb{N}$, by the definition of $\sigma_{n}$ in Step 2, we have

$$
\sigma_{n}(\omega)=\inf \left\{t \in\left[0, T-\tau_{n}(\omega)\right]: 2 \cdot 3^{\alpha-1} C_{\tau_{n}+t}^{\alpha}\left\|y\left(\tau_{n}\right)\right\|_{H^{2}}^{\alpha-1} t^{\theta}>\frac{1}{3}\right\} \wedge\left(T-\tau_{n}\right)
$$

Notice that, for every $n \geq 1,\left\|y\left(\tau_{n}(\omega)\right)\right\|_{H^{2}} \leq M^{*}, C_{\tau_{n}(\omega)+t} \leq C_{T+t}$. It follows that $Z_{t}(\omega) \geq$ $Z_{t}^{(n+1)}(\omega)$, therefore $\sigma_{n}(\omega)>\sigma(\omega)>0$. Hence $\tau_{n+1}(\omega)=\tau_{n}(\omega)+\sigma_{n}(\omega)>\tau_{n}(\omega)+\sigma(\omega)$, which implies $\tau_{n+1}(\omega)>\tau_{1}(\omega)+n \sigma(\omega)$ for every $n \geq 1$, contradicting the fact that $\tau_{n}(\omega) \leq T$. This completes the proof.

## 5 Proof of Theorem 2.5

We prove the time global well-posedness in $H^{2}$ for the equation with power condition $2 \leq \alpha \leq$ $1+\frac{4}{(d-2)^{+}}$which correspond to the condition for $H^{1}$ well-posedness. This is so called persistence argument.

Proof of Theorem 2.5. From Theorem [2.4, for any $x \in H^{2}$ and $0<T<\infty$, there exists a local solution $\left(y, \tau^{*}(x)\right)$ where $\tau^{*}(x)$ is the maximum existence time of $y$. Assume that $\tau^{*}(x)<T$. Then, there exists $\varepsilon$ such that $\tau^{*}(x)-\varepsilon<\tau^{*}(x)+\varepsilon<T$. Set $I=\left[\tau^{*}\left(u_{0}, v_{0}\right)-\varepsilon, \tau^{*}\left(u_{0}, v_{0}\right)+\varepsilon\right]$. Fix $\omega \in \Omega$. Set $(p, q)=\left(\alpha+1, \frac{4(\alpha+1)}{d(\alpha-1)}\right)$. We estimate the map in (4.11). From the deterministic Strichartz estimate, we have

$$
\|F(y)\|_{L^{\infty}\left(I ; H^{2}\right) \cap L^{q}\left(I ; W^{2, p}\right)} \leq\|x\|_{H^{2}}+\left\||y|^{\alpha-1} y\right\|_{L^{q^{\prime}}\left(I ; W^{2, p^{\prime}}\right)} .
$$

Thus, by Sobolev's embedding theorem, we have

$$
\begin{aligned}
& \left\||y|^{\alpha-1} y\right\|_{L^{q^{\prime}}\left(I ; W^{2, p^{\prime}}\right)} \\
& \lesssim\left\||y|^{\alpha-1} y\right\|_{L^{q^{\prime}}\left(I ; L^{p^{\prime}}\right)}+\left\|\left.|y|^{\alpha-1}\left|\nabla y\left\|_{L^{q^{\prime}}\left(I ; L^{p^{\prime}}\right)}+\right\|\right| y\right|^{\alpha-2}|\nabla y|^{2}\right\|_{L^{q^{\prime}}\left(I ; L^{p^{\prime}}\right)}+\left\||y|^{\alpha-1} \mid \Delta y\right\|_{L^{q^{\prime}}\left(I ; L^{p^{\prime}}\right)} \\
& \lesssim(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I\left(I ; L^{p}\right)\right.}^{\alpha-1}\|y\|_{L^{q}\left(I ; L^{p}\right)}+(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; L^{p}\right)}^{\alpha-1}\|\nabla y\|_{L^{q}\left(I ; L^{p}\right)} \\
& \quad+(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; L^{p}\right)}^{\alpha-2}\|y\|_{L^{q}\left(I ; L^{p}\right)}^{2}+\left(2 \varepsilon \theta^{\theta}\|y\|_{L^{\infty}\left(I ; L^{p}\right)}^{\alpha-1}\|y\|_{L^{q}\left(I ; L^{p}\right)}\right. \\
& \lesssim(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; H^{1}\right)}^{\alpha-1}\|y\|_{L^{q}\left(I ; W^{2, p}\right)}+(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; H^{1}\right)}^{\alpha-1}\|y\|_{L^{q}\left(I ; W^{2, p}\right)} \\
& \quad+(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; H^{1}\right)}^{\alpha-2}\|y\|_{L^{q}\left(I ; W^{1, p)}\right)}\|y\|_{L^{q}\left(I ; W^{2, p}\right)}+(2 \varepsilon)^{\theta}\|y\|_{L^{\infty}\left(I ; H^{1}\right)}^{\alpha-1}\|y\|_{L^{q}\left(I ; W^{2, p}\right)} \\
& \lesssim(2 \varepsilon)^{\theta}\|y\|_{L^{q}\left(I ; W^{2, p}\right)} .
\end{aligned}
$$

In the similar way, we estimate the difference to obtain

$$
\left\|F\left(y_{1}\right)-F\left(y_{2}\right)\right\|_{L^{\infty}\left(I ; H^{2}\right) \cap L^{q}\left(I ; W^{2, p}\right)} \lesssim(2 \varepsilon)^{\theta} C(T)\left\|y_{1}-y_{2}\right\|_{L^{q}\left(I ; W^{2, p}\right)} .
$$

Thus, if $\varepsilon$ is sufficiently small, $F$ is a contraction map. Therefore, it contradicts the definition of the maximal existence time $\tau^{*}(x)$.
