# The Probabilities of Large Deviations Associated with Multinomial Distributions

#### Abstract

We consider a multinomial distribution, where the number of cells increases and the cell-probabilities decreases as the number of observations grows. The probabilities of large deviations of statistics, which has form of a sum of Borel functions of cell-frequencies, are studied. Large deviation results for the power-divergence statistics and its most popular special variants, as well as for some count statistics are derived as consequences of general theorems.


Key words and phrases. Chi-square statistic, Count-statistics, Log-likelihood ration statistic, large deviations, multinomial distribution, Poisson distribution, power divergence statistics.

## 1. Introduction

Let $\eta=\left(\eta_{1}, \ldots, \eta_{N}\right)$ be a random vector of frequencies of a multinomial model $M(n, N, \mathrm{P})$ on $n \geq 1$ observations classified into $N>1$ cells with the cell probabilities $\mathrm{P}=\left(p_{1}, \ldots, p_{N}\right)$,
$p_{1}+\ldots+p_{N}=1$, all $p_{j}>0$. Hence $n=\eta_{1}+\ldots+\eta_{N}$ and

where arbitrary non-negative integer $m_{j} \mathrm{~s}$ are such that $m_{1}+\ldots+m_{N}=n$. It is convenient to describe this model in terms of a random allocation of particles into cells: $n$ particles are allocated into $N$ cells indexed 1 through $N$ at random, successively and independently of each other, the probability of a particle falls into $l$-th cell is $p_{l}>0, l=1, \ldots, N, p_{1}+\ldots+p_{N}=1$, then $\eta_{l}$ is the number of particles in the $l$-th cell after allocation of all $n$ particles.

We assume that $N=N(n) \rightarrow \infty$ and all $p_{m}=p_{m}(n) \rightarrow 0$, as $n \rightarrow \infty$, and consider a general class of statistics of the form

where $h_{1}(x), \ldots, h_{N}(x)$ (may depend on $N$ and $n$ ) are real-valued functions defined on the nonnegative axis. These functions can be random, then it is assumed that for any $x_{1}, \ldots, x_{N}$, random variables (r.v.) $h_{1}\left(x_{1}\right), \ldots, h_{N}\left(x_{N}\right)$ are mutually independent and independent of $\left(\eta_{1}, \ldots, \eta_{N}\right)$. We will pay special attention to the family of power-divergence statistics (PDS) of Cressie and Read (1984),
which is a sub-class of (1.1) with $h_{l}(x)=2 x\left(\left(x / n p_{l}\right)^{d}-1\right) / d(d+1)$. The most notably special versions of PDS are

These statistics are known as Pearson's chi-squared, the log-likelihood ratio and the FreemanTukey statistics, respectively. The class of count statistics (CS) forms another important variant of (1.1). In particularly the following CS are of interest:

where $r=0,1, \ldots, n$ and $\mathrm{I}\{A\}$ is the indicator function of $A$. In terms of the aforementioned random allocation scheme the statistics $\mu_{r}, w_{r}$, and $C_{n}$ counts, respectively: the number of cells that contain exactly $r \geq 0$ particles, the number of cells that contain at least $r \geq 1$ particles, and the number of collisions (i.e. the number of times a particle falls in a cell that already has a particle in it). Consider now a random allocation with random level. Let the cell with index $m$ be assigned a non-negative, integer valued r.v. $v_{m}, m=1, \ldots, N$. The cell with index $m$ is said to be filled up if $\eta_{m} \geq v_{m}$ after allocation all the particles. A special version of (1.1) that of interest is the number of unfilled cells $\Phi_{N}$, say, viz.

where $B_{m}(x)$ is a Bernoulli r.v.: $P\left\{B_{m}(x)=1\right\}=P\left\{v_{m}>x\right\}, P\left\{B_{m}(x)=0\right\}=P\left\{v_{m} \leq x\right\}, m=1, \ldots, N$.
If $h_{m}(x)=h(x)$ for all $m$ then (1.1) is said to be symmetric statistics. Obviously $\chi_{N}^{2}, \Lambda_{N}$ and $T_{N}^{2}$ are symmetric if $p_{1}=\ldots=p_{N}=N^{-1}$. All statistics (1.3) are symmetric, whereas statistic $\Phi_{N}$ is symmetric if $v_{1}, \ldots, v_{N}$ are i.i.d. r.v.s.. PDS, specifically statistics (1.2), play a leading role in goodness-of-fit tests on grouped data, whereas CS (1.3), (1.4) are used in problems associated with occupancy problems, see Kolchin et al (1976), Ivanov V.A. (1985), Khmaladze (2011). We also draw the attention of readers to the article by L'ecuyer et al (2002), where the statistics (1.1) and its special versions, including (1.2) and (1.3) are used in construction the serial tests for testing of uniformity and independence of the output sequence of general-purpose uniform random number generators.

In the present paper we are interested in $P\left\{\tilde{R}_{N}(\eta) \geq x_{N}\right\}$, where $\tilde{R}_{N}(\eta)$ is a standardized version of $R_{N}(\eta)$ and $x_{N} \rightarrow \infty$, as $n \rightarrow \infty$. This probability of large deviation has been studied earlier by Sirajdinov et al (1989) and Ivchenko and Mirakhmedov (1995) and Mirakhmedov (2020). The last
article contains a few typos, which are corrected in Mirakhmedov's (2021). In course of revision of that paper the author observed that several refinements of the results on applications of Theorem 2.2 could be made. The purpose of this paper is to present refined results, therefore, it can be considered as updated variant of article Mirakhmedov (2020). As such, we send readers to Mirakhmedov (2020) for motivation and review of the literature on the topic.

The rest of the paper is organized as follows. The general results are presented in Section 2; these theorems are applied for the class of PDS in Section 3, and in Section 4 for the statistics (1.2), (1.3) and (1.4); the proofs are presented in Section 5. The auxiliary Assertions are collected in Appendix.

Throughout the paper we use $c_{i}, C_{i}$ to denote absolute constants whose value may differ at each occurrence, $\varsigma \sim F$ stands for "r.v. $\varsigma$ has the distribution $F$ ", $\operatorname{Poi}(\lambda)$ - the Poisson distribution with parameter $\lambda>0$ and $\Phi(u)$ - the standard normal distribution function. Everywhere in the next sections $\xi, \xi_{1}, \ldots, \xi_{N}$ are independent r.v.s, where $\xi_{m} \sim \operatorname{Poi}\left(n p_{m}\right) ; \xi \sim \operatorname{Poi}\left(\lambda_{n}\right), \lambda_{n}=n / N$, $\pi_{l}(\lambda)=\lambda^{l} e^{-\lambda} / l!, p_{\max }=\max _{1 \leq k \leq N} p_{k}, p_{\min }=\min _{1 \leq k \leq N} p_{k}$. All asymptotic statements are considered as $n \rightarrow \infty$.

## 2. General Results. Set

Note that under very general set-up $A_{N}$ and $\sigma_{N}^{2}$ becomes the asymptotical value of $E R_{N}(\eta)$ and $\operatorname{Var}_{N}(\eta)$, respectively. In particularly, under the conditions of below Theorems 2.1 and 2.2

The following theorem was proved by Ivchenko and Mirakhmedov (1995), see also Siragdinov et al (1989).

where $M_{n}(u)=u^{3}\left(\mu_{0 n}+\mu_{1 n} u+\ldots\right)$ is a series where $\left|\mu_{j n}\right| \leq \mu_{j} N^{-(j+1) / 2}$ for sufficiently large $N, \mu_{j}$ do not depend on $N$. In particularly, due to Sirajdinov et al (1989)

Theorem 2.2. Let $N \rightarrow \infty, p_{\max } \rightarrow 0$ as $n \rightarrow \infty$, and the functions $h_{m}(\cdot)$ be non-negative. If
(i) For each integer $s \in\left[3, k_{n}\right]$ there exist non-negative $a_{1}, a_{2}$ and $b_{1}, b_{2}$ such that

To compare these two theorems we make the following comments. The deviation zone $x_{N}=o(\sqrt{N})$ of Theorem 2.1 is maximally possible for this Cramèr type result; application, however, of Theorem 2.1 is limited by sparse multinomial models only, since conditions (2.3), (2.4), and by class of statistics satisfying Cramèr condition (2.6). For instance, class of PDS with parameter $d>0$ does not satisfy condition (2.6). In contrast, Theorem 2.2 is applicable for the arbitrary multinomial models and for statistics that do not necessarily satisfy Cramér condition. However, condition (i) turns out to be restrictive, and may narrow the deviation zone so that the exponential factor does not effect, see for instance, the applications below.

In what follows, in applications of Theorems 2.1 and 2.2 , we will present the statements, which follows from (2.7) and (2.13) only, while the results similar to (2.14) hold as well.

## 3. Application to the Power Divergence Statistics (PDS).

The PDS of Cressie and Read (1984) is defined as

Note that for $d=0$ the PDS is defined by continuity: $C R_{N}(0)=\lim _{d \rightarrow 0} C R_{N}(d)=\Lambda_{N}$, also $C R_{N}(1)=\chi_{N}^{2}$ and $C R_{N}(-1 / 2)=T_{N}^{2}$. We assume that $d>-1$ in order Theorems 2.1 and 2.2 to be applicable. Further, since we deal with standardized variant of PDS, we can, whenever it is necessary, consider PDS as a special version of statistics $R_{N}(\eta)$ with kernel functions $h_{l}(x)=h_{d, l}(x)$, where

3.1. The sparse multinomial model: $n / N \rightarrow \lambda \in(0, \infty)$. Theorems 2.1 and 2.2 imply

Theorem 3.1. Suppose $n \rightarrow \infty, N \rightarrow \infty$ such that

3.2. The dense multinomial model: $\lambda_{n} \rightarrow \infty$. In this case, each PDS asymptotically in distribution coincides with the chi-square statistics.

Theorem 3.2. Let $p_{\max }=o(1)$ and $n p_{\min } \rightarrow \infty$. Then for each $d>-1$ uniformly in $x_{n} \geq 0$, $x_{n}=o\left(\min \left(N^{1 / 6}, p_{\max }^{-1 / 4}\right)\right)$ one has

Corollary 3.2. Let $p_{\text {max }}=o(1)$ and $n p_{\text {min }} \rightarrow \infty$. Then for each $d>-1$ and $x_{n} \rightarrow \infty$, $x_{n}=o\left(\min \left(N^{1 / 6}, p_{\max }^{-1 / 4}\right)\right.$ one has (3.12).

Remark 3.1. From $n p_{\text {min }} \rightarrow \infty$ it follows $\lambda_{n} \rightarrow \infty$. The condition $n p_{\text {min }} \rightarrow \infty$ can be replaced by $\lambda_{n} \rightarrow \infty$ and $N p_{\min } \geq c>0$, which imply in turn $n p_{\min } \rightarrow \infty$. It is obvious that if $p_{\max }=O\left(N^{-2 / 3}\right)$, then relations (3.12) is hold uniformly in non-negative $x_{N}=o\left(N^{1 / 6}\right)$.
3.3. The very sparse multinomial model: $\lambda_{n} \rightarrow 0$. We assume that $N p_{\max } \leq C$, which in our case, yields $n p_{\max } \rightarrow 0$. The $C R_{N}(d)$, being divergence measure between proposed and observed models, depends on the intended model. As it turns out, this fact plays a role for very sparse models; for example, the asymptotic value of the expectation and the variance of PDS are different
for non-uniform and uniform multinomial models. The standardized version of $C R_{N}(d)$ coincides with standardized version of $R_{N}^{d}=h_{d, 1}\left(\eta_{1}\right)+\ldots+h_{d, N}\left(\eta_{N}\right)$, where $h_{d, m}(x)$ is defined in (3.1). Set $\mathrm{P}_{j N}(a)=p_{1}^{j-a}+\ldots+p_{N}^{j-a}$. The asymptotic value of the expectation and variance of $R_{N}^{d}$, when $d \neq 0$, are equal, respectively to

& \sigma_{N}^{2}(d)=n^{1-2 d}\left[\mathrm{P}_{1 N}(2 d)-\mathrm{P}_{1 N}^{2}(d)\right] \\
& \quad+2 n^{2(1-d)}\left[\left(2^{2 d}-1\right) \mathrm{P}_{2 N}(2 d)-2\left(2^{d}-1\right) \mathrm{P}_{1 N}(d) \mathrm{P}_{2 N}(d)\right], d>-1, d \neq 0 . \tag{3.15}
\end{align*}

Remark 3.2. In the formula for $\sigma_{N}^{2}(d)$ given in Mirakhmedov (2020, Eq. (2.6)), the first term of (3.14) is missed. Let $P\left\{Y=p_{m}^{-d}\right\}=p_{m}, m=1, \ldots, N$. Then $\mathrm{P}_{1 N}(2 d)-\mathrm{P}_{1 N}^{2}(d)=\operatorname{Var} Y$, and hence $\mathrm{P}_{1 N}(2 d)-\mathrm{P}_{1 N}^{2}(d)=0$ if and only if $\left(p_{1}, \ldots, p_{N}\right)=\left(N^{-1}, \ldots, N^{-1}\right)$. Next, $n \mathrm{P}_{2 N}(2 d) \leq n p_{\max } \mathrm{P}_{1 N}(2 d)$ and $n \mathrm{P}_{1 N}(d) \mathrm{P}_{2 N}(d) \leq n p_{\max } \mathrm{P}_{1 N}^{2}(d)$.

Consider now $R_{N}^{0}=\Lambda_{N}$. Let $\left(p_{1}, \ldots, p_{N}\right) \neq\left(N^{-1}, \ldots, N^{-1}\right)$, a r.v. $Z_{N}$ be such that $P\left\{Z_{N}=-\ln n p_{m}\right\}=p_{m}, m=1, \ldots, N$. For the asymptotic value of the expectation and variance of $R_{N}^{0}$ we have

A_{N}(0)=2 \ln 2 n \lambda_{n}, \tilde{\sigma}_{N}^{2}(0)=\sigma_{N}^{2}(0)=8 \ln ^{2} 2 n \lambda_{n} . \tag{3.18}
\end{gather*}

Set $\bar{R}_{N}^{d}=\eta_{1}^{1+d}+\ldots+\eta_{N}^{1+d}, d>-1, d \neq 0$, else $\bar{R}_{N}^{0}=2 \eta_{1} \ln \eta_{1}+\ldots+2 \eta_{N} \ln \eta_{N}$. For the uniform model standardized version of $R_{N}^{d}$ and $\bar{R}_{N}^{d}$ coincides. For $\bar{R}_{N}^{d}$ the quantities (3.2) - (3.7) are:

Put $\Upsilon_{n}(d)=\min \left(n^{1 / 4},\left(W_{N}(d)\right)^{1 /\left(1+2 d^{* *}\right)}\right)$, where $d^{*}=\max (0, d), W_{N}(d)=\sigma_{N}^{3}(d)\left(n p_{\min }\right)^{d}\left(\tilde{\sigma}_{N}^{2}(d)\right)^{-1}$ if $d \neq 0$, else $W_{N}(0)=\sigma_{N}^{3}(0)\left(\tilde{\sigma}_{N}^{2}(0)\left|\ln n p_{\text {min }}\right|\right)^{-1}$.

Theorem 3.3. Let $\left(p_{1}, \ldots, p_{N}\right) \neq\left(N^{-1}, \ldots, N^{-1}\right), \lambda_{n} \rightarrow 0, n \lambda_{n} \rightarrow \infty$ and $n p_{\max } \rightarrow 0\left(\right.$ or $\left.N p_{\text {max }} \leq C\right)$. Then uniformly in $x_{n} \geq 0, x_{n}=o\left(\Upsilon_{n}(d)\right)$ it holds

Set $\bar{\Upsilon}_{n}(d)=\min \left(n^{1 / 4},\left(n \lambda_{n}^{3}\right)^{1 / 2\left(1+2 d^{*}\right)}\right)$.
Theorem 3.4. Let $p_{1}=\ldots=p_{N}=N^{-1}, \lambda_{n} \rightarrow 0$ and $n \lambda_{n}^{3} \rightarrow \infty$. Then uniformly in $x_{n} \geq 0$, $x_{n}=o\left(\bar{\Upsilon}_{n}(d)\right)$ it holds
(i) $P\left\{\bar{R}_{N}^{d}>x_{n}\left|2^{d}-1\right| \sqrt{2 n \lambda_{n}}+n\right\}=\left(1-\Phi\left(x_{n}\right)\right) \exp \left\{M_{d^{*}, n}\left(x_{n}\right)\right\}\left(1+O\left(\frac{x_{n}+1}{\left.\bar{\Gamma}_{n}(d)\right)}\right)\right), d \neq 0$,
(ii) $P\left\{\bar{R}_{N}^{0}>x_{n} 2 \sqrt{2} \ln 2 n \lambda_{n}+2 \ln 2 n \lambda_{n}\right\}=\left(1-\Phi\left(x_{n}\right)\right) \exp \left\{M_{0, n}\left(x_{n}\right)\right\}\left(1+O\left(\frac{x_{n}+1}{\bar{\Gamma}_{n}(0)}\right)\right)$.

Remark 3.3. Let $p_{m}=(1-\alpha) / N^{1-\alpha} m^{\alpha}, m=1, \ldots, N$ and $\alpha \in[0,1)$. This example of the multinomial model has been considered by Rempala and Wesolowski (2016), as it is of interest when testing for signal-noise threshold in data with large number of support points (Pietrzak et al., 2016). We have $n p_{\min }=(1-\alpha) \lambda_{n}, p_{\max }=(1-\alpha) / N^{1-\alpha}, N p_{m}=(1-\alpha) N^{\alpha} m^{-\alpha}$, $1-\alpha \leq N p_{m} \leq(1-\alpha) N^{\alpha}$. Theorem 3.2 for this model states that if $\lambda_{n} \rightarrow \infty$ then the relation (3.12) hold uniformly in $x_{n} \geq 0$ such that: $x_{n}=o\left(N^{1 / 6}\right)$ if $\alpha \in[0,1 / 3]$, and $x_{n}=o\left(N^{(1-\alpha) / 4}\right)$ if $\alpha \in(1 / 3,1)$. Theorem 3.3 can be applied if $\alpha \in[0,1 / 2)$.However, Theorem 3.1 possible to apply for $\alpha=0$, i.e. for uniform model only.

Corollary 3.3. Let $p_{1}=\ldots=p_{N}=N^{-1}, \lambda_{n} \rightarrow 0$ and $n \lambda_{n}^{3} \rightarrow \infty$. Then uniformly in $x_{n} \geq 0$, $x_{n}=o\left(\tilde{W}_{N}(d)\right)$ it holds

& \log P\left\{\bar{R}_{N}^{d}>x_{n}\left|2^{d}-1\right| \sqrt{2 n \lambda_{n}}+n\right\}=-\frac{x_{n}^{2}}{2}(1+o(1)), d \neq 0, \\
& \log P\left\{\bar{R}_{N}^{0}>x_{n} 2 \sqrt{2} \ln 2 n \lambda_{n}+2 \ln 2 n \lambda_{n}\right\}=-\frac{x_{n}^{2}}{2}(1+o(1))
\end{aligned}
$$

We end Section 3 by noting that the theorems of this section should be regarded as results under the null hypothesis that the cell probabilities are $p_{1}, \ldots, p_{N}$.

## 4. Application to the special variants of the statistic $R_{N}(\eta)$.

Consider application of results of Sections 2 and 3 to the statistics (1.2), (1.3) and (1.4). Remind that (1.2) statistics are PDS: $\chi_{N}^{2}=C R_{N}(1), \Lambda_{N}=C R_{N}(0)$ and $T_{N}^{2}=C D_{N}(-1 / 2)$, whereas the (1.3) and (1.4) statistics are out of the class of PDS.
4.1. Chi-square statistic. For the $\chi_{N}^{2}$ statistic $h_{m}(u)=\left(u-n p_{m}\right)^{2} / n p_{m}$,

\tilde{\sigma}_{N}^{2}=\sum_{m=1}^{N} \frac{1}{n p_{m}}+2 N, \quad \sigma_{N}^{2}=2 N+\sum_{m=1}^{N}\left(\frac{1}{n p_{m}}-\frac{1}{\lambda_{n}}\right)=\tilde{\sigma}_{N}^{2}-N \lambda_{n}^{-1} . \tag{4.1}
\end{equation*}
$$

As consequence of Theorem 3.1 (ii) and Theorem 3.2 we obtain
Theorem 4.1. Let $n \rightarrow \infty, N \rightarrow \infty$ such that the condition (3.9) or

Remark 4.1. Let $Y$ be a r.v. such that $P\left\{Y=p_{m}^{-1}\right\}=p_{m}, m=1, \ldots, N$. Then $E Y=N$ and $\operatorname{Var} Y=\sum_{m=1}^{N} p_{m}^{-1}-N^{2}=n \sum_{m=1}^{N}\left(\left(n p_{m}\right)^{-1}-\lambda_{n}^{-1}\right) \geq 0$. Hence $\sigma_{N}^{2} \geq 2 N$. Under the conditions (4.2) $n p_{\min } \rightarrow \infty$, and hence $\sigma_{N}^{2}=2 N(1+o(1))$.

Theorem 4.2. Let $\left(p_{1}, \ldots, p_{N}\right) \neq\left(N^{-1}, \ldots, N^{-1}\right)$ and $\lambda_{n} \rightarrow 0, n \lambda_{n} \rightarrow \infty$ and $N p_{\text {max }} \leq C$. Then for all $x_{n} \geq 0, x_{n}=o\left(\lambda_{n} \sigma_{N}^{3} / \tilde{\sigma}_{N}^{2}\right)$ the Eq. (4.3) hold.

Theorem 4.3. Let $p_{1}=\ldots=p_{N}=N^{-1}, \lambda_{n} \rightarrow 0$ and $n \lambda_{n}^{3} \rightarrow \infty$. Then uniformly in $x_{n} \geq 0$, $x_{n}=o\left(\left(n \lambda_{n}^{3}\right)^{1 / 6}\right)$ it holds

$$
P\left\{\chi_{N}^{2}>x_{n} \sqrt{2 N}+N\right\}=\left(1-\Phi\left(x_{n}\right)\right)(1+o(1)) .
$$

Theorem 2.2 allows deriving relations (4.3) under weaker conditions than Theorem 4.1. Set $\nabla_{n}=\max \left(1,\left(n p_{\min }\right)^{-1}\right)$.

Theorem 4.4. Let $p_{\max }=o(1)$. Then it holds Eq. (4.3) for all $x_{n} \geq 0$, $x_{n}=o\left(\min \left(\left(\sigma_{N}^{3} / \tilde{\sigma}_{N}^{2} \nabla_{n}\right)^{1 / 3}, n^{1 / 6}, p_{\max }^{-1 / 4}\right)\right)$.

Corollary 4.1. Let $n p_{\min } \geq c_{0}>0$. Then Eq. (4.3) hold uniformly in $x_{n} \geq 0$, $x_{n}=o\left(\min \left(N^{1 / 6}, p_{\max }^{-1 / 4}\right)\right)$, and if additionally $p_{\max }=O\left(N^{-2 / 3}\right)$ then for all $x_{n} \geq 0, x_{N}=o\left(N^{1 / 6}\right)$.

Let's consider the multinomial model considered in Remark 3.2. Corollary 4.1 says that if $\lambda_{n} \geq c_{0}$, some $c_{0}>0$ (the condition weaker than $\lambda_{n} \rightarrow \infty$ as in Remark 3.2) then Eq. (4.3) is valid for all $x_{n} \geq 0, x_{n}=o\left(\min \left(N^{1 / 6}, N^{(1-\alpha) / 4}\right)\right)$.

The following consequence of Theorem 4.4 is useful in studying the intermediate asymptotic efficiency of the chi-squared test in verifying uniformity of a discrete distribution versus a family of sequences of alternatives approaching the hypothesis, see Appendix A2.

Corollary 4.2. Let $p_{m}=N^{-1}\left(1+\delta(n) \ell_{m, n}\right), m=1, \ldots, N$, where $\delta(n) \rightarrow 0$ and

$$

Remark 4.2. From (4.3) when $x_{n} \rightarrow \infty$ we obtain $\log P\left\{\chi_{N}^{2}>x_{n} \sigma_{N}+N\right\}=-x_{n}^{2} / 2(1+o(1))$. From Kallenberg (1985, Eq. (2.17)) this relation follows if $\log N=o\left(x_{n}^{2}\right), x_{n}=o\left(N^{1 / 6}\right)$ and $N=o\left(n^{3 / 8}\right)$ (i.e. the multinomial model is so dense that $\left.\lambda_{n} \gg n^{5 / 8}\right)$. Last condition excludes, for instance, the case recommended by Mann and Wald (1942), who obtained the relation $N=\mathrm{cn}^{2 / 5}$ concerning the optimal choice of the number of groups in chi-square goodness of fit test.
4.2. Likelihood ratio statistic $\Lambda_{N}$. Remind that $\Lambda_{N}=R_{N}^{0}$, and hence Theorems 3.3 and 3.4 consist results for statistic $\Lambda_{N}$ in very sparse models. Next, Theorem 3.1 and 3.2 imply

Theorem 4.5. (i) Let condition (3.9) is fulfilled. Then for all $x_{n} \geq 0, x_{n}=o(\sqrt{N})$ it holds

P\left\{\Lambda_{N}>x_{n} \sigma_{N}(0)+A_{N}(0)\right\}=\left(1-\Phi\left(x_{n}\right)\right) \exp \left\{M_{0, n}\left(x_{n}\right)\right\}\left(1+O\left(\frac{1+x_{n}}{\sqrt{N}}\right)\right)
$$

(ii) Let $p_{\max }=O\left(N^{-2 / 3}\right)$ and $n p_{\min } \rightarrow \infty$. Then for all $x_{n} \geq 0, x_{n}=o\left(N^{1 / 6}\right)$ one has

Corollary 4.3. If condition (3.9) is fulfilled then for $x_{n} \rightarrow \infty, x_{n}=o(\sqrt{N})$, and if $n p_{\text {min }} \rightarrow \infty$ and $p_{\text {max }}=O\left(N^{-2 / 3}\right)$ then for $x_{n} \rightarrow \infty, x_{N}=o\left(N^{1 / 6}\right)$ it holds

Remark 4.3. Theorem 4.5 (ii) imply $\log P\left\{\Lambda_{N}>x_{n} \sqrt{2 N}+N\right\}==-x_{n}^{2} / 2(1+o(1))$ if $x_{N} \rightarrow \infty$ and $x_{n}=o\left(N^{1 / 6}\right)$. From Kallenberg (1985, Eq. (2.13)) such relation follows under additionally conditions $N=o\left(n^{3 / 7}\right)$ and $\log N=o\left(x_{n}^{2}\right)$.
4.3. The Freeman-Tukey statistic $T_{N}^{2}$ is $C R_{N}(-1 / 2)$ statistic, therefore directly from Theorems 3.1 and 3.2 it follows

Theorem 4.6. (i) Let condition (3.9) is fulfilled. Then for the $P\left\{T_{N}^{2}>x_{n} \sigma_{N}(-1 / 2)+A_{N}(-1 / 2)\right\}$ it holds Eq. (2.7) uniformly in $x_{n} \geq 0, x_{n}=o(\sqrt{N})$.
(ii) Let $p_{\max }=O\left(N^{-2 / 3}\right)$ and $n p_{\min } \rightarrow \infty$. Then uniformly in $x_{n} \geq 0, x_{n}=o\left(N^{1 / 6}\right)$ it holds

P\left\{T_{N}^{2}>x_{n} \sqrt{2 N}+N\right\}=\left(1-\Phi\left(x_{n}\right)\right)(1+o(1))
$$

(iii) Let $\left(p_{1}, \ldots, p_{N}\right) \neq\left(N^{-1}, \ldots, N^{-1}\right), \lambda_{n} \rightarrow 0, n \lambda_{n} \rightarrow \infty$ and $N p_{\text {max }} \leq C$. Then

P\left\{\frac{T_{N}^{2}-8\left(n-A_{N}(-1 / 2)\right)}{8 \sigma_{N}(-1 / 2)}>x_{n}\right\}=\left(1-\Phi\left(x_{n}\right)\right) \exp \left\{M_{0, n}\left(x_{n}\right)\right\}\left(1+O\left(\frac{x_{n}+1}{\Upsilon_{n}(-1 / 2)}\right)\right),
$$

uniformly in $x_{n} \geq 0, x_{n}=o\left(\Upsilon_{n}(-1 / 2)\right)$, where $\Upsilon_{n}(-1 / 2)=\min \left(n^{1 / 4}, W_{n}(-1 / 2)\right), A_{N}(-1 / 2)$, $\sigma_{N}^{2}(-1 / 2)$ and $\tilde{\sigma}_{N}^{2}(-1 / 2)$ are defined in (3.15),(3.16) and- (3.17), respectively, and $W_{n}(-1 / 2)=\sigma_{N}^{3}(-1 / 2)\left(\sqrt{n p_{\min }} \tilde{\sigma}_{N}^{2}(-1 / 2)\right)^{-1}$.
(iv) Let $p_{1}=\ldots=p_{N}=N^{-1}, \lambda_{n} \rightarrow 0$ and $n \lambda_{n}^{3} \rightarrow \infty$. Then uniformly in $x_{n} \geq 0, x_{n}=o\left(W_{n}\right)$ it holds

P\left\{\frac{T_{N}^{2}-8 n\left(1-\sqrt{\lambda_{n}}\right)}{8(\sqrt{2}-1) \sqrt{n} \lambda_{n}^{3 / 2}}>x_{n}\right\}=\left(1-\Phi\left(x_{n}\right)\right) \exp \left\{M_{0, n}\left(x_{n}\right)\right\}\left(1+O\left(\frac{x_{n}+1}{W_{n}}\right)\right),
$$

where $W_{n}=n^{1 / 4}$ if $N \geq n^{7 / 6}$ and $W_{n}=\sqrt{n \lambda_{n}^{3}}$ if $N \leq n^{7 / 6}$.

### 4.5. The count statistics.

4.5.1. First we consider CS (1.3). Remind, for the $\mu_{r}$ statistic $h_{m}(x)=\mathrm{I}\{x=r\}$. Set $\pi_{s}(\lambda)=\lambda^{s} e^{-\lambda} / s!$. The notation (2.1) in this case has the following form:

\end{aligned}

Set $\Upsilon_{r, n}=\min \left(\sigma_{r N}^{3} / \tilde{\sigma}_{r N}^{2}, n^{1 / 4},\left(n p_{\max }^{2}\right)^{-1 / 4}\right)$.
Theorem 4.7. Let fixed $r \geq 0$. Uniformly in $x_{n} \geq 0, x_{n}=o\left(\Upsilon_{r, n}\right)$ one has

Assume that there exist $c_{1}>0$ and $c_{2}>0$ such that

Condition $\sigma_{r N} \rightarrow \infty$, that is $\operatorname{Var} \mu_{r} \rightarrow \infty$, is necessary for the above results of large deviations to be valid for $\mu_{r}$. In turn, this condition is fulfilled for the following cases of behavior of parameter $\lambda_{n}$ :
(i) $\lambda_{n} \rightarrow \lambda \in(0, \infty)$.
(ii) $\lambda_{n} \rightarrow 0$ and $N \lambda_{n}^{\tilde{r}} \rightarrow \infty$, where $\tilde{r}=\max (2, r)$.
(iii) $\lambda_{n} \rightarrow \infty$ but $\lambda_{n} \leq \delta c_{2}^{-1} \log N+r \log \log N$, some $\delta \in(0,1), c_{2}$ from the condition (4.6). For all these three cases $\sigma_{r N}^{2} \sim \operatorname{Var} \mu_{r} \sim E \mu_{r} \sim A_{r N} \rightarrow \infty$. Moreover,

These (i), (ii) and (iii) cases correspond to the central, left intermediate and right intermediate zones, respectively, defined by Kolchin et al (1976). Applying Theorem 2.1 for (i) case and Theorem 4.5 for (ii) and (iii) cases we obtain the following

Hence, assertions of Corollary 4.3 corresponding to the case $r=0$ can be reformulated for $w_{1}$ and $C_{n}$ statistics as well.
4.5.2. Statistic (1.4) $\Phi_{N}$. We will consider the case when $p_{1}=\ldots=p_{N}=N^{-1}$, the classical random allocation scheme, and assume that the levels $v_{1}, \ldots, v_{N}$ are independent copies of a nonnegative integer-valued r.v. $v$ such that $P\{v=0\}=\beta_{0}<1$. Set

& \left.\left.\leq 2^{3 s-1} E\left(\xi_{m}^{s} \ln ^{s} \xi_{m}+\xi_{m}^{s}\left(-\ln n p_{m}\right)^{s}\right)\right) \leq 2^{3 s-1}\left[E \xi_{m}^{s+1}+\left(-\ln n p_{m}\right)^{s} E \xi_{m}^{s}\right)\right] \\
& \leq 2^{3 s}\left[(s+1)!\left(n p_{m}\right)+s!\left(-\ln n p_{m}\right)^{s}\left(n p_{m}\right)\right] \leq s!\left(-8 \ln n p_{m}\right)^{s}\left(n p_{m}\right) \\
\leq & s!\left[-2^{7} \ln n p_{m}\right]^{s-2} 4\left(n p_{m}\right) \ln ^{2} n p_{m} \leq s!\left[-2^{7} \ln n p_{\min }\right]^{s-2} \operatorname{Varh}_{0 m}\left(\xi_{m}\right) .
\end{aligned}
$$

From this and Assertion1 it follows that

\left|\mathcal{C}_{s}\left(h_{0, m}\left(\xi_{m}\right)\right)\right| \leq s!\left[2\left|\ln n p_{\min }\right|\right]^{s-2} \operatorname{Varh}_{0 m}\left(\xi_{m}\right) .

Hence, condition (2.11) is fulfilled with $V_{n}=2\left|\ln n p_{\min }\right|, v=0, W_{N}=\sigma_{N}^{3}(0) / \tilde{\sigma}_{N}^{-2}(0)\left|\ln n p_{\text {min }}\right|$. By this, (5.36) and that $K_{n}(a, b)=\sqrt{n}$ Theorem 3.3 follows from Theorem 2.2.

Proof of Theorem 3.4. Now $h_{d, m}(x)=h_{d}(x)=x^{1+d}, d \neq 0, h_{0}(x)=2 x \ln x$, and $\xi_{m} \sim \operatorname{Poi}\left(\lambda_{n}\right)$. Therefore, alike (5.35) we obtain

since $\operatorname{Varh}_{d}\left(\xi_{m}\right)=\lambda_{n}(1+o(1))$, see (5.34). Hence in this case by (3.20)

v=d^{*}, W_{N}=\sqrt{n} \lambda_{n}^{3 / 2}\left(2^{d}-1\right)^{3} / \sqrt{2} C(d) . \tag{5.38}
\end{equation*}
$$

Further, we have

E\left(h_{0}\left(\xi_{m}\right)\right)^{s} & =E\left(\xi_{m} \log \xi_{m}\right)^{s} \leq E \xi_{m}^{s+1} \leq(s+1)!\lambda_{n}(1+o(1)) \\
\leq & s!\left[\left((s+1) / \lambda_{n} 8 \ln ^{2} 2\right)^{1 /(s-2)}\right]^{s-2} \lambda_{n}^{2} 8 \ln ^{2} \leq s!\left[\left(\lambda_{n} 2 \ln ^{2} 2\right)^{-1}\right]^{s-2} \operatorname{Varh}_{0}\left(\xi_{m}\right),
\end{aligned}
$$

since $\operatorname{Varh}_{0}\left(\xi_{m}\right)=8 \ln ^{2} 2 \lambda_{n}^{2}$. Hence by Assertion 1

$$
\begin{equation*}
\left|\mathcal{C}_{s}\left(h_{0}\left(\xi_{m}\right)\right)\right| \leq s!\left[8\left(\lambda_{n} \ln ^{2} 2\right)^{-1}\right]^{s-2} \operatorname{Varh}_{0}\left(\xi_{m}\right) . \tag{5.39}
\end{equation*}
$$

Hence, $v=0, W_{N}=16 \sqrt{2} \ln ^{5 / 2} 2 \sqrt{n} \lambda_{n}^{3 / 2}$, by (3.19). Theorem 3.4 follows from Theorem 2.2, since (5.37), (5.38), (5.39) and that $K_{n}(a, b)=\sqrt{n}$.

Proof of Corollaries 3.1, $\mathbf{3 . 2}$ and 3.3 follows from Theorems 3.1, 3.2 and 3.4, respectively, and that $\log (1-\Phi(x)) \sim-x^{2} / 2$, as $x \rightarrow \infty$, and by (2.15).

Proof of Theorems 4.1, 4.2 and 4.3 follows in immediate manner from Theorem 3.1 (ii) case $d=1$, Theorem 3.2, 3.3 and 3.4, respectively.

Proof of Theorem 4.4. For the chi-square statistic $h_{m}(x)=\left(x-n p_{m}\right)^{2} / n p_{m}$, hence $A_{N}=N, \sigma_{N}^{2}$ and $\tilde{\sigma}_{N}^{2}$ as in (4.1). Set $\tilde{\xi}_{m}=\left(\xi_{m}-n p_{m}\right) / \sqrt{n p_{m}}$. Then $h_{m}\left(\xi_{m}\right)=\tilde{\xi}_{m}^{2}$ and $E \tilde{\xi}_{m}^{2 s}\left(\xi_{m}-n p_{m}\right)^{2}$ $\leq 4 s\left(n p_{m}+2 s\right) E \tilde{\xi}_{m}^{2 s}$, since (5.17), hence the condition (2.9) is fulfilled with $b=1$ and $a=1$ if $n p_{m} \geq 2 s$, and with $b=0$ and $a=2$ if $n p_{m}<2 s$. We would remind the notation $\nabla_{n}=\max 1,\left(n p_{\min }\right)^{-1}$. Set $\varsigma_{m}=\left(\tilde{\xi}_{m}^{2}-E \tilde{\xi}_{m}^{2}\right) / \sqrt{\operatorname{Var} \tilde{\xi}_{m}^{2}}$. Using Lemma 5.2 we obtain

$$

since $(2 s)!\leq(s!)^{2} 2^{2 s} e / \pi \sqrt{2 s}, \sum_{l=0}^{s-1}\left(n p_{m}\right)^{-l} \leq s \nabla_{n}^{s-2}$ and $\operatorname{Var} \tilde{\xi}_{m}^{2}=\left(n p_{m}\right)^{-1}+2$. Hence by Assertion 1 $\left|\mathcal{C}_{s}\left(\varsigma_{m}\right)\right| \leq(s!)^{2}\left(2^{8} \nabla_{n} / \sqrt{\operatorname{Var} \tilde{\xi}_{m}^{2}}\right)^{s-2}$. That is $\left|\mathcal{C}_{s}\left(\tilde{\xi}_{m}^{2}\right)\right| \leq(s!)^{2}\left(2^{8} \nabla_{n}\right)^{s-2} \operatorname{Var} \tilde{\xi}_{m}^{2}, s \geq 3$. Thus condition (ii) of Theorem 2.2 is fulfilled with $v=1, V_{n}=2^{8} \nabla_{n}$ and $3 \leq s \leq k_{n}=o\left(\min \left(n^{1 / 3}, p_{\max }^{-1 / 2}\right)\right.$, because $K_{n}(1,1)=p_{\max }^{-1 / 2}$ and $K_{n}(2,0)=n^{1 / 3}$. Theorem 4.2 follows from Theorem 2.2.

Proof of Corollary 4.1. We have $\tilde{\sigma}_{N}^{2} \leq N\left(2+c_{0}^{-1}\right), \nabla_{n} \leq \max \left(1, c_{0}^{-1}\right)$ and $n \geq c_{0} N$, since $n p_{\min } \geq c_{0}$. Yet $\sigma_{N}^{2} \geq 2 N$, see Remark 4.1. Corollary 2.1 follows.

Proof of Corollary 4.2 is straightforward, since in this case $\nabla_{n}=\max \left(1, \lambda_{n}^{-1}\right)$, $\sigma_{N}^{2}=N\left(2+d^{2} \delta^{2}(n) \lambda_{n}^{-1}(1+o(1))\right.$ and $\tilde{\sigma}_{N}^{2}=2 N\left(1+\left(2 \lambda_{n}\right)^{-1}(1+o(1))\right) \leq 2 N \nabla_{n}$.

Proof of Theorem 4.5 and 4.6 follows straightforwardly from Theorems 3.1 and 3.2 by putting $d=0$ and $d=-1 / 2$, respectively.

Proof of Theorem 4.7 follows from Theorem 2.2. Indeed. In this case $h_{m}(x)=\mathrm{I}\{x=r\}$ and it is easy to see that the condition (i) of Theorem 2.2 is fulfilled with $\mathcal{N}=\left\{j: n p_{j}>r\right\}$

a_{1}=0, b_{1}=2 \text { and } a_{2}=0, b_{2}=0 . \tag{5.40}
\end{equation*}
$$

Further. It is obvious that $\operatorname{Varh}_{m}\left(\xi_{m}\right)=\pi_{r}\left(n p_{m}\right)\left(1-\pi_{r}\left(n p_{m}\right)\right)$ and $E h_{m}^{s}\left(\xi_{m}\right)=\pi_{r}\left(n p_{m}\right), s \geq 1$. We have $\left|E\left(h_{m}\left(\xi_{m}\right)-\pi_{r}\left(n p_{m}\right)\right)^{s}\right| \leq 2^{s} \pi_{r}\left(n p_{m}\right)<s!\left[8\left(1-\pi_{r}\left(n p_{m}\right)\right)^{-1}\right]^{s-2} \operatorname{Varh}_{m}\left(\xi_{m}\right) \leq s![8 c(r)]^{s-2} \operatorname{Varh}_{m}\left(\xi_{m}\right)$ , $s \geq 3$ and a constant $c(r)>0$. Therefore, by Assertion 1

$$
\left|\mathcal{C}_{s}\left(h_{m}\left(\xi_{m}\right)\right)\right| \leq s!(16 c(r))^{s-2} \operatorname{Varh}_{m}\left(\xi_{m}\right) .
$$

Hence condition (2.11) is fulfilled with $v=0, V_{n}=8 c(r)$. Thus $W_{n}=\sigma_{r N}^{3} / \tilde{\sigma}_{r N}^{2}, K_{n}\left(a_{2}, b_{2}\right)=n^{1 / 2}$ and $K_{n}\left(a_{1}, b_{1}\right)=\left(n p_{\max }^{2}\right)^{-1 / 2}$, since (5.40). Theorem 4.7 follows.

Proof of Corollary 4.3. The case (i) follows from Theorem 2.1, because $E \exp \left\{H \mathrm{I}\left\{\xi_{m}=r\right\}\right\} \leq e$ and (4.7). In the cases (ii) by (4.8) we have $\sigma_{r N}^{3} / \tilde{\sigma}_{r N}^{2}=n^{r / 2} / N^{(r-1) / 2}, r \geq 2$, and $\sigma_{r N}^{3} / \tilde{\sigma}_{r N}^{2}=n^{3 r / 2} / N^{(3 r-1) / 2}, r=0,1$. Therefore, it is seen that $\Upsilon_{r, n}=n^{1 / 4}$. So the case (ii) follows from Theorem 4.7. Case (iii) follows from Theorem 4.7 and (4.9) straightforwardly.

Proof of Theorem 4.8. Remind that for the statistic $\Phi_{N}$ the kernel function is $h_{m}(x)=\mathrm{I}\left\{v_{m}>x\right\}$ . If $\lambda_{n} \rightarrow \lambda \in(0, \infty)$, then it is not hard to verify that all conditions of Theorem 2.1 are fulfilled, and hence the case (i) follows.

The cases (ii) and (iii) we will derive from Theorem 2.2. Observe that $E h_{m}^{s}\left(\xi_{m}\right)=\tau\left(\lambda_{n}\right), s \geq 1$. Using this we find that $E h_{m}^{s}\left(\xi_{m}\right)\left(\xi_{m}-\lambda_{n}\right)^{2} \leq \lambda_{n}\left(3 \lambda_{n}+2\right) E h_{m}^{s}\left(\xi_{m}\right)$. Hence the condition (i) of Theorem 2.2 is fulfilled with

a=0, b=0 \text { if } \lambda_{n} \leq 1, \tag{5.41}
\end{equation*}

and

a=0, b=2 \text { if } \lambda_{n}>1 . \tag{5.42}

Next, alike to above proof of Theorem 4.7 it can be shown that

\left|\mathcal{C}_{s}\left(h_{m}\left(\xi_{m}\right)\right)\right| \leq s!\left(16\left(1-\tau\left(\lambda_{n}\right)\right)^{-1}\right)^{s-2} \operatorname{Varh}_{m}\left(\xi_{m}\right), s \geq 3,
$$

since $\operatorname{Varh}_{m}\left(\xi_{m}\right)=\tau\left(\lambda_{n}\right)\left(1-\tau\left(\lambda_{n}\right)\right.$. That is condition (2.11) is fulfilled with $v=0$, $V_{n}=16\left(1-\tau\left(\lambda_{n}\right)\right)^{-1}$. Hence

\Upsilon_{n}=\sqrt{N}\left(\tau\left(\lambda_{n}\right)\left(1-\tau\left(\lambda_{n}\right)\right)-\lambda_{n}\left(\tau^{\prime}\left(\lambda_{n}\right)\right)^{2}\right)^{3 / 2} / \tau\left(\lambda_{n}\right) . \tag{5.43}
\end{equation*}
$$

Let $\lambda_{n} \rightarrow 0$. Then from (4.10) and (4.11) by simple algebra we obtain $A_{N}=N\left(1-\beta_{0}\right)(1+o(1))$, $\sigma_{N}^{2}=N \beta_{0}\left(1-\beta_{0}\right)\left(1+O\left(\lambda_{m}^{9}\right)\right), \tau\left(\lambda_{n}\right)\left(1-\tau\left(\lambda_{n}\right)\right)-\lambda_{n}\left(\tau^{\prime}\left(\lambda_{n}\right)\right)^{2}=\beta_{0}\left(1-\beta_{0}\right)\left(1+O\left(\lambda_{m}^{9}\right)\right)$. The case (ii) follows from Theorem 2.2 , (5.41) and (5.43).

Case (iii). In this case from (4.6) we have $\sigma_{N}^{2} \sim \tilde{\sigma}_{N}^{2}=N \tau\left(\lambda_{n}\right)(1+o(1))$. If (4.12) is fulfilled and $\lambda_{n} \leq \delta \mu^{-1} \ln N+\chi \ln \ln N$ then $\tau\left(\lambda_{n}\right) \leq \rho N^{-\delta}$. Also, $\sigma_{N}^{2}=N g \lambda_{n}^{-\varepsilon}(1+o(1))$ if (4.13) is fulfilled. Since these facts and (5.42) and (5.43) case (iii) follows from Theorem 2.2.

## Appendix.

Below $\varsigma$ is a r.v. with $E \varsigma=0, \operatorname{Var} \varsigma=\sigma^{2}>0, \mathcal{C}_{k}(\varsigma)$ and $\alpha_{k}(\varsigma)$ cumulant and moment of $k$ th order, respectively of the r.v. $\varsigma$. The following conditions and assertions are taken from the book by Saulis and Statulevicius (1991), SS(1991) for short.

Bernstein condition ( $B_{v}$ ): there exist constants $v \geq 0$ and $B>0$ such that

$$
\left|\alpha_{k}(\varsigma)\right| \leq(k!)^{v+1} B^{k-2} \sigma^{2}, \text { for all } k=3,4, \ldots
$$

Statulevicius condition $\left(S_{v}\right)$ : there exist constants $v \geq 0$ and $\Delta>0$ such that

$$
\left|\mathcal{C}_{k}(\varsigma)\right| \leq(k!)^{v+1} \Delta^{-(k-2)} \sigma^{2}, \text { for all } k=3,4, \ldots .
$$

Assertion 1 (SS (1991, Lemma 3.1)). If $\varsigma$ satisfy condition $\left(B_{v}\right)$ then it also satisfy condition $\left(S_{v}\right)$ with $\Delta=(2 \max (1, B))^{-1}$.

Assertion 2. Assume $\sigma^{2}=1$ and there exist $v \geq 0, \Delta>0$ and $\kappa \geq 3$ such that

$$
\begin{equation*}
\left|\mathcal{C}_{k}(\varsigma)\right| \leq(k!)^{\nu+1} \Delta^{-(k-2)}, \text { for all } k=3,4, \ldots, \kappa . \tag{A.1}
\end{equation*}
$$

Then there exist constants $c_{i}>0$ such that for all $x: 0 \leq x \leq c_{1} \min \left(\sqrt{\kappa}, \Delta^{1 /(1+2 v)}\right)$ it holds

$$
\begin{aligned}
& P\{\xi>x\}=(1-\Phi(x)) \exp \left\{L_{v}(x)\right\}\left(1+\theta_{3} c_{2} \frac{x+1}{\min \left(\sqrt{\kappa}, \Delta^{1 /(1+2 v)}\right)}\right), \\
& P\{\xi \leq-x\}=\Phi(-x) \exp \left\{L_{v}(-x)\right\}\left(1+\theta_{3} c_{3} \frac{x+1}{\min \left(\sqrt{\kappa}, \Delta^{1 /(1+2 v)}\right)}\right),
\end{aligned}
$$

where $L_{v}(x)=x^{3}\left(l_{0}+l_{2} x+\ldots+l_{\vartheta} x^{\vartheta}\right), \vartheta=\vartheta(v): \vartheta(0)=\infty, \vartheta(v)<v^{-1}-1$ if $v \in(0,1)$, and $L_{v}(x)=0$ if $v \geq 1$. Also $\left|L_{v}(x)\right| \leq 5|x|^{3} / 4 \Delta^{1 /(1+2 v)}$.

Proof based on a revision of the proofs of Lemma 2.1 and Lemma 2.2 from SS (1991). We state their Lemma 2.1 first.

Lemma 2.1 of SS (1991). Let there exist $\Delta>0$ and an integer $v \geq 3$ such that

\left|\mathcal{C}_{k}(\xi)\right| \leq(k-2)!\Delta^{-(k-2)}, \text { for all } k=3,4, \ldots, v .
$$

where an even $v \leq 2 \Delta^{2}$, is fulfilled. Then for all $x: 0 \leq x \leq c_{0} \sqrt{v}$, where $c_{0}<(3 \sqrt{e})^{-1}$, it holds

\begin{gathered}
P\{\xi>x\}=(1-\Phi(x)) \exp \{L(x)\}\left(1+\theta_{1} f_{1}(x, v)(x+1) v^{-1 / 2}\right), \\
P\{\xi \leq-x\}=\Phi(-x) \exp \{L(-x)\}\left(1+\theta_{2} f_{1}(x, v)(x+1) v^{-1 / 2}\right),
\end{gathered}
$$

where $f_{1}(x, v)=(1-3 x \sqrt{e / v})^{-1}\left(117+96 v \exp \left\{-v^{1 / 4} 2^{-1}(1-3 x \sqrt{e / v})\right\}\right)$ and $L(x)=l_{0} x^{3}+l_{1} x^{4}+\ldots$ is a power series such that $|L(x)| \leq 5|x|^{3} / 4 \Delta$ and is converging within the disc $|x|<\Delta(3 \sqrt{e / 2})^{-1}$.

As in inequality (2.61) of SS (1991) we have $(k!)^{1+v} \leq(k-2)!\left(6 \kappa^{v}\right)^{k-2}$, for $k=3, \ldots, \kappa$ and $\kappa \geq 6$ . Therefore from condition (A.1) it follows

$$
\left|\mathcal{C}_{k}(\xi)\right| \leq(k-2)!\Delta_{s}^{-(k-2)}, \text { for all } k=3, \ldots, \kappa, \text { and } \Delta_{\kappa}=\Delta / 6 \kappa^{v} .
$$

Let $\kappa<2 \Delta_{\kappa}^{2}$. If $\kappa$ is an even, then from Lemma 2.1 of $\operatorname{SS}(1991)$ gives

P\{\xi>x\}=(1-\Phi(x)) \exp \{L(x)\}\left(1+\theta_{1} c_{2}(x+1) \kappa^{-1 / 2}\right), \text { for } 0 \leq x<c_{1} \sqrt{\kappa}, \tag{A.2}
\end{equation*}
$$

where $c_{1}=(3 \sqrt{e})^{-1}$ and $c_{2}=f_{1}(x, \kappa)$. If $\kappa$ is an odd, then we use Lemma 2.1 putting $v=\kappa-1$ to get (A.2) with $c_{1}=\sqrt{5} / 3 \sqrt{6 e}$ and $c_{2}=\sqrt{6 / 5} f_{1}(x, \kappa-1)$.

Let, now, $\kappa \geq 2 \Delta_{\kappa}^{2}$, that is $\kappa \geq \tilde{\Delta}_{v}:=\left(\Delta^{2} / 18\right)^{1 /(1+2 v)}$. Without loss of generality we can assume $\tilde{\Delta}_{v} \geq 4$. Put $v=2\left\lfloor\tilde{\Delta}_{v} / 2\right\rfloor \geq \tilde{\Delta}_{v} / 2$, Then $\left\{x: 0 \leq x<c_{0} \sqrt{v}\right\} \supseteq\left\{x: 0 \leq x<c_{0} \sqrt{\tilde{\Delta}_{v} / 2}\right\}$. Therefore, from Lemma 2.1of SS(1991) it follows

$$
P\{\xi>x\}=(1-\Phi(x)) \exp \{L(x)\}\left(1+\theta_{1} c_{2}(x+1) \Delta^{-1 /(1+2 v)}\right), \text { for } 0 \leq x<c_{1} \Delta^{1 /(1+2 v)},
$$

where $c_{1}=c_{0} / \sqrt{2 \cdot 18^{1 /(1+2 v)}}$ and $c_{2}=\sqrt{2 \cdot 18^{1 /(1+2 v)}} f_{1}\left(x,\left(\Delta^{2} / 18\right)^{1 /(1+2 v)}\right)$.At last, exactly as in SS (1991, p. 35-37) we have $L(x)=L_{v}(x)+\theta\left(x / \Delta_{v}\right)^{3}$. Assertion 2 follows.

The following relation is well-known, see SS (1991, Eq. (1.34)).
Assertion 3. One has

$$
\mathcal{C}_{k}(\varsigma)=k!\sum(-1)^{m_{1}+m_{2}+\ldots+m_{k}-1}\left(m_{1}+m_{2}+\ldots+m_{k}-1\right)!\prod_{l=1}^{k} \frac{1}{m_{l}!}\left(\frac{\alpha_{l}(\varsigma)}{l!}\right)^{m_{l}}
$$

here $\Sigma$ is summation over all non-negative integer $m_{1}, m_{2}, \ldots, m_{k}$ such that $m_{1}+2 m_{2}+\ldots+k m_{k}=k$.
