# SECOND-CHERN-EINSTEIN METRICS ON 4-DIMENSIONAL ALMOST-HERMITIAN MANIFOLDS

#### Abstract

We study 4-dimensional second-Chern-Einstein almost-Hermitian manifolds. In the compact case, we observe that under a certain hypothesis the Riemannian dual of the Lee form is a Killing vector field. We use that observation to describe 4-dimensional compact second-ChernEinstein locally conformally symplectic manifolds and we give some examples of such manifolds. Finally, we study the second-Chern-Einstein problem on unimodular almost-abelian Lie algebras, classifying those that admit a left-invariant second-Chern-Einstein metric with a parallel non-zero Lee form.


## 1. INTRODUCTION

An almost-Hermitian manifold $(M, g, J)$ is a manifold $M$ equipped with a Riemannian metric $g$ and a $g$-orthogonal almost-complex structure $J$. The almost-Hermitian structure $(g, J)$ induces the fundamental 2-form $F(\cdot, \cdot)=g(J \cdot, \cdot)$. The Lee form $\theta$ associated to the almost-Hermitian structure $(g, J)$ is defined as

$$
d F^{n-1}=\frac{1}{n-1} \theta \wedge F^{n-1}
$$

where $d$ is the exterior derivative and $2 n$ is the real dimension of the manifold. The almostHermitian metric $g$ (with a unit total volume) is called Gauduchon if $\delta^{g} \theta=0$, where $\delta^{g}$ is the adjoint of $d$ with respect to $g$, and almost-Kähler if $d F=0$. On the other hand, if the almost-complex structure $J$ is integrable then the pair $(g, J)$ is a Hermitian structure and it is Kähler if it is almostKähler. A 4-dimensional almost-Hermitian manifold $(M, g, J)$ is locally conformally symplectic (LCS) if $d \theta=0$, while in higher dimension the LCS condition becomes $d F=\theta \wedge F$ 60, 62, (for a general introduction to the subject see [14]). In the integrable case, LCS is locally conformally Kähler (LCK).

In the Hermitian and almost-Hermitian geometry there are some natural connections other then $D^{g}$ the Levi-Civita one. Among these we have the Chern connection $\nabla$ 41, 42, 32] defined as the unique connection preserving the almost-Hermitian structure and having a $J$-anti-invariant torsion; the Bismut connection $\nabla^{B}$ [32] which is, in the integrable case, the unique connection preserving the Hermitian structure and having a skew-symmetric torsion; and the canonical Weyl connection $D^{W}$ defined as the unique torsion-free connection such that $D^{W} g=\theta \otimes g$. To any of these connections can be associated many different Einstein-type equations. See for example [52, 49, 50, 51, 53, 31, 20, 36, 47, 21] for the Einstein-Weyl problem and [56] for the Bismut-Einstein problem in the Hermitian case.

[^0]In this note we focus on the Second-Chern-Einstein problem, which is stated as follows (for more details see [28, 29, 33, 7]). We define the second Chern-Ricci form $r$ as

$$
r=R^{\nabla}(F),
$$

that is, the image of the fundamental form by the Chern curvature $R^{\nabla}$.
Definition. Given an almost-Hermitian manifold $(M, g, J)$ of real dimension $2 n$, the metric $g$ is said to be second-Chern-Einstein if

$$
r=\frac{t r_{F} r}{n} F .
$$

In the Hermitian case, second-Chern-Einstein metrics were studied in [28, 33, [57, 22, 43, 54, 7, 8]. The condition of being second-Chern-Einstein is conformally invariant (even in the non-integrable case [40]). Since $D^{W}$ is invariant under conformal change of the metric, that led to explore the relation between Einstein-Weyl metrics and second-Chern-Einstein metrics. It turns out that in real dimension 4, in the Hermitian case, the Einstein-Weyl condition and the second-ChernEinstein condition (as well as the Bismut-Einstein condition) are equivalent [33, Theorem 1] and so the only compact Hermitian non-Kähler 4-manifold admitting a second-Chern-Einstein metric is the Hopf surface [33]. Even if this equivalence is no longer true for almost-Hermitian structures some crucial relations persist, see for example Corollary 3 and Proposition 24.

In this note, we investigate the existence of second-Chern-Einstein metrics on 4-dimensional almost-Hermitian manifolds. In Section 3, we collect some general results about the geometry of these manifolds. In particular, we observe the following (for the analog in the Einstein-Weyl case see [58])
Lemma (Lemma 6). Let $(M, \tilde{g}, J)$ be a compact 4-dimensional almost-Hermitian manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym }, J,-}=0$, where $D^{g}$ is the Levi-Civita connection of $g$ and $\theta$ is the Lee form of $(g, J)$. Then, the $g$-Riemannian dual of $\theta$ is a Killing vector field of $g$. Here $(\cdot)^{\text {symm,J,- }}$ denotes the $g$-symmetric $J$-anti-invariant part.

Taking twice the trace of the curvature of $D^{W}$, we get the conformal scalar curvature $s^{W}$, which enters the pictures through the following
Theorem (Theorem (15). Suppose that ( $M, \tilde{g}, J$ ) is a 4-dimensional compact locally conformally symplectic manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$, where $\theta$ is the Lee form of $(g, J)$. Then, either
i) $(M, g, J)$ is a second-Chern-Einstein almost-Kähler manifold, or
ii) $\theta$ is $D^{g}$-parallel and the conformal scalar curvature $s^{W}$ is non-positive. Moreover, $s^{W}$ is identically zero if and only if $J$ is integrable and so $(M, J)$ is a Hopf surface as described in [33, Theorem 2]. Furthermore, if $s^{W}$ is nowhere zero then $\chi=\sigma=0$, where $\chi$ and $\sigma$ are the Euler class and signature of $M$ respectively.

In Section 4 , we give examples of compact 4-dimensional second-Chern-Einstein almost-Hermitian manifolds. Some examples are locally conformally symplectic and some satisfy the condition $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$. We also remark that in those examples the second-Chern-Einstein metrics may have positive or zero Chern scalar curvature. It is observed that in the integrable case (in higher dimension) second-Chern-Einstein Hermitian non-Kähler metrics with negative Chern scalar curvature are still missing (see [8]).

Finally, in Section [5, we study the Bismut-Einstein and the second-Chern-Einstein problems on 4-dimensional almost-abelian Lie algebras. Using these class of manifolds, we show the existence in the almost-Hermitian case of Bismut-Einstein metrics with $d J d F=0$, while we recall that in
the Hermitian non-Kähler case, examples of this kind are still missing. We also give a classification of 4-dimensional unimodular almost-abelian Lie algebras equipped with a left-invariant almostHermitian non-Hermitian second-Chern-Einstein metric such that $\theta$ is $D^{g}$-parallel and non-zero.

Theorem (Theorem(32). Let $\mathfrak{g}$ be a 4-dimensional unimodular almost-abelian Lie algebra equipped with a left-invariant almost-Hermitian non-Hermitian structure $(g, J)$ such that the Lee form $\theta$ is $D^{g}$-parallel and non-zero. Suppose that $(g, J)$ is a solution to the second-Chern-Einstein problem. Then $\mathfrak{g}$ is isomorphic to one of the following Lie algebras
i) $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{3}\right]=-e_{2}, \quad\left[e_{2}, e_{3}\right]=e_{1}$.
ii) $\mathcal{A}_{3,4} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{3}\right]=e_{1}, \quad\left[e_{2}, e_{3}\right]=-e_{2}$.

## Both Lie algebras admit compact quotients.

Here we use the same notation of Lie algebras as 48] (for a classification of locally conformally symplectic Lie algebras see [4, 5]).

## 2. Preliminaries

In all the following $(M, g, J)$ will be an almost-Hermitian manifold of real dimension 4 . We denote by $D^{g}$ the Levi-Civita connection associated to the Riemannian metric $g$ and by $R^{\nabla}, R^{W}, R^{g}, R^{B}$ the curvature tensors of $\nabla, D^{W}, D^{g}, \nabla^{B}$ respectively, where we use the following convention $R_{X, Y}^{\nabla}=$ $\nabla_{[X, Y]}-\left[\nabla_{X}, \nabla_{Y}\right]$, etc. Moreover, given a 2 -tensor $\psi$, we denote by $\psi^{J,+}$ its $J$-invariant part, $\psi^{J,-}$ its $J$-anti-invariant part, $\psi^{s y m}$ its $g$-symmetric part and $\psi^{\text {anti-sym }}$ its $g$-anti-symmetric part. Moreover, a 2 -form $\phi$ can be decomposed into a $g$-orthogonal sum $\phi=\phi^{+}+\phi^{-}$, where $\phi^{+}$is self dual i.e. $*_{g} \phi^{+}=\phi^{+}$and $\phi^{-}$is anti-self dual $*_{g} \phi^{-}=-\phi^{-}$under the action of the Riemannian Hodge operator $*_{g}$.

It follows from [32] that the Chern connection $\nabla$ is related to the Levi-Civita connection $D^{g}$ by

$$
\begin{equation*}
\nabla_{X} Y=D_{X}^{g} Y-\frac{1}{2} \theta(J X) J Y-\frac{1}{2} \theta(Y) X+\frac{1}{2} g(X, Y) \theta^{\sharp}+g(X, N(\cdot, Y)), \tag{1}
\end{equation*}
$$

where $\sharp$ is the isomorphism induced by the metric $g$ between 1 -forms and vector fields. Moreover, the canonical Weyl connection $D^{W}$ is related to the Levi-Civita connection $D^{g}$ by

$$
\begin{equation*}
D_{X}^{W} Y=D_{X}^{g} Y-\frac{1}{2} \theta(X) Y-\frac{1}{2} \theta(Y) X+\frac{1}{2} g(X, Y) \theta^{\sharp} \tag{2}
\end{equation*}
$$

We also remark that (for more details see [37])

$$
\begin{equation*}
g\left(\left(D_{Z}^{W} J\right) X, J Y\right)=-2 g(N(X, Y), Z) \tag{3}
\end{equation*}
$$

where $N$ is the Nijenhuis tensor defined by

$$
4 N(X, Y)=[J X, J Y]-[X, Y]-J[J X, Y]-J[X, J Y]
$$

Moreover, on any 4-dimensional almost-Hermitian manifold, Gauduchon proved [32, Proposition 1] that

$$
\begin{equation*}
g(N(X, Y), Z)+g(N(Y, Z), X)+g(N(Z, X), Y)=0 \tag{4}
\end{equation*}
$$

for any vector fields $X, Y, Z$.
The almost-complex structure $J$ is integrable if and only if $N$ vanishes [45]. Hence, $D^{W}$ preserves $J$ if and only if $J$ is integrable.

We will now list some of the most relevant curvatures that can be obtained tracing the curvature tensors $R^{\nabla}, R^{W}, R^{g}, R^{B}$ together with their relations. To define them we will consider a $J$-adapted $g$-orthonormal frame of the tangent bundle $\left\{e_{1}, e_{2}=J e_{1}, e_{3}, e_{4}=J e_{3}\right\}$.

The first Chern-Ricci form $\rho^{\nabla}$ (called also the Hermitian Ricci form) of the Chern connection $\nabla$ is defined by

$$
\rho^{\nabla}(X, Y)=\frac{1}{2} \sum_{i=1}^{4} g\left(R_{X, Y}^{\nabla} e_{i}, J e_{i}\right),
$$

similarly, the Bismut-Ricci form Ric ${ }^{B}$ is defined by

$$
\operatorname{Ric}^{B}(X, Y)=\frac{1}{2} \sum_{i=1}^{4} g\left(R_{X, Y}^{B} e_{i}, J e_{i}\right) .
$$

These 2 -forms $\rho^{\nabla}$ and Ric $^{B}$ are closed and they are representatives of the first Chern class $2 \pi c_{1}(T M, J)$ in De Rham cohomology. Indeed, they differ by the exact factor $d J \theta$, i.e.

$$
\begin{equation*}
R i c^{B}=\rho^{\nabla}+d J \theta, \tag{5}
\end{equation*}
$$

see [32, Equation (2.7.6)] (see also [1, 13] and the references therein). We also remark that these forms are not necessarily $J$-invariant.

We denote by $r$ the second Chern-Ricci form of $\nabla$ defined by

$$
r(X, Y)=\frac{1}{2} \sum_{i=1}^{4} g\left(R_{e_{i}, J e_{i}}^{\nabla} X, Y\right)
$$

or equivalently,

$$
r=R^{\nabla}(F)
$$

$r$ is a $J$-invariant 2 -form but not closed in general.
Similarly, $R^{W}(F)$ is given by the formula

$$
R^{W}(F)=\frac{1}{2} \sum_{i=1}^{4} g\left(R_{e_{i}, J e_{i}}^{W} X, Y\right)
$$

The tensor $R^{W}(F)$ is a 2 -form and it is not $J$-invariant in general. However, when $J$ is integrable, $D^{W}$ preserves $J$ and so $R^{W}(F)=\left(R^{W}(F)\right)^{J,+}$ is $J$-invariant. The Weyl Ricci tensor $R i c^{W}$ is defined in [33] as

$$
\operatorname{Ric}^{W}(X, Y)=\sum_{i=1}^{4} g\left(R_{e_{i}, X}^{W} e_{i}, Y\right)
$$

Note that the tensor $R i c^{W}$ is symmetric (this is only true in dimension 4). On the other hand, the tensor $\widetilde{R i c}^{W}$, defined as (see for example 51])

$$
\widetilde{\operatorname{Ric}}^{W}(X, Y)=\sum_{i=1}^{4} g\left(R_{X, e_{i}}^{W} Y, e_{i}\right),
$$

is not symmetric in general. Its anti-symmetric part is $d \theta$ while its symmetric part is $R i c^{W}$, that is (see [2])

$$
\widetilde{\operatorname{Ric}}^{W}=\operatorname{Ric}^{W}+d \theta .
$$

We define the Riemannian Ricci tensor Ric $^{g}$ as

$$
\operatorname{Ric}^{g}(X, Y)=\sum_{i=1}^{4} g\left(R_{e_{i}, X}^{g} e_{i}, Y\right)
$$

and the $\star$-Ricci tensor $\rho^{\star}$ as

$$
\rho^{\star}(X, Y)=R^{g}(F)(X, J Y)=\frac{1}{2} \sum_{i=1}^{4} g\left(R_{e_{i}, J e_{i}}^{g} X, J Y\right) .
$$

From the definition, it follows that $\rho^{\star}(X, Y)=\rho^{\star}(J Y, J X)$ so $\rho^{\star}$ is symmetric if and only it is $J$-invariant.

We define the Hermitian scalar curvature $s^{H}$ as

$$
s^{H}=\sum_{i=1}^{4} r\left(e_{i}, J e_{i}\right)
$$

the Riemannian scalar curvature $s^{g}$ as $s^{g}=\sum_{i=1}^{4} \operatorname{Ric}^{g}\left(e_{i}, e_{i}\right)$, the conformal scalar curvature $s^{W}$ as $s^{W}=\sum_{i=1}^{4} \operatorname{Ric}^{W}\left(e_{i}, e_{i}\right)$, and the $\star$-scalar curvature $s^{\star}$ as $s^{\star}=\sum_{i=1}^{4} \rho^{\star}\left(e_{i}, e_{i}\right)$.

The conformal scalar curvature $s^{W}$ is then related to the Riemannian scalar curvature $s^{g}$ by (see for example [2])

$$
\begin{equation*}
s^{W}=s^{g}-3 \delta^{g} \theta-\frac{3}{2}\|\theta\|^{2} \tag{6}
\end{equation*}
$$

where $\|\theta\|^{2}=g(\theta, \theta)$. Furthermore, for any almost-Hermitian manifold of dimension 4 , we have that 59]

$$
\begin{equation*}
\left(\rho^{\star}\right)^{s y m}-\left(R i c^{g}\right)^{J,+}=\frac{s^{\star}-s^{g}}{4} g \tag{7}
\end{equation*}
$$

On the other hand, $s^{\star}$ is related to the Riemannian scalar curvature $s^{g}$ by (see [55, 38], while in the integrable case [61])

$$
\begin{equation*}
s^{\star}-s^{g}=-2 \delta^{g} \theta-\|\theta\|^{2}+2\|N\|^{2} \tag{8}
\end{equation*}
$$

## 3. SECOnd-ChERn-Einstein metrics

Let $(M, g, J)$ be an almost-Hermitian manifold of real dimension 4. We recall that with our notations the metric $g$ is said to be second-Chern-Einstein if

$$
r=\frac{s^{H}}{4} F
$$

(we note that $s^{H}$ is not necessarily constant here).
3.1. Relation between second Chern-Ricci and Weyl-Ricci tensors. Under a conformal change $\tilde{g}=e^{2 f} g$, the conformal variation of the second Chern-Ricci form $r$ of $(g, J)$ is given by (40], in the Hermitian case see [30])

$$
\begin{equation*}
\tilde{r}=r+\left(\Delta^{g} f+g(\theta, d f)\right) F \tag{9}
\end{equation*}
$$

where $\tilde{r}$ is the second Ricci form of $(\tilde{g}, J)$ and $\Delta^{g}$ is the Riemannian Laplacian of $g$. The condition of being second-Chern-Einstein, in the almost-Hermitian setting, is then conformally invariant. Hence, we investigate the relation between the curvature $R^{\nabla}$ of the Chern connection $\nabla$ and the curvature $R^{W}$ of the Weyl connection $D^{W}$.
Proposition 1. The curvatures $R^{\nabla}$ and $R^{W}$ are related by

$$
\begin{aligned}
R_{X, Y}^{\nabla} Z=R_{X, Y}^{W} Z & -\frac{1}{2}(d J \theta)(X, Y) J Z-\frac{1}{2}(d \theta)(X, Y) Z \\
& -\frac{1}{2}\left(D_{X}^{W}\left(D_{Y}^{W} J\right)-D_{Y}^{W}\left(D_{X}^{W} J\right)-D_{[X, Y]}^{W} J\right) J Z \\
& +\frac{1}{4}\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) Z
\end{aligned}
$$

Proof. From (21) and (1), we obtain that

$$
\nabla_{X} Y=D_{X}^{W} Y+\frac{1}{2} \theta(X) Y-\frac{1}{2} \theta(J X) J Y+g(X, N(\cdot, Y))
$$

From (3), we get that

$$
\nabla_{X} Y=D_{X}^{W} Y+\frac{1}{2} \theta(X) Y-\frac{1}{2} \theta(J X) J Y+\frac{1}{2}\left(D_{X}^{W} J\right) J Y
$$

Then, we compute the curvature.
When $J$ is integrable, the relation reduces to (see [33])

$$
R^{\nabla}=R^{W}-\frac{1}{2}(d J \theta) \otimes J-\frac{1}{2}(d \theta) \otimes I d
$$

We remark that the part $\left(R_{X, Y}^{W}\right)^{J,-}$ of $R_{X, Y}^{W}$ that anticommutes with $J$ is given precisely by (see for example [37, Equation (2.15)])

$$
\begin{equation*}
\left(R_{X, Y}^{W}\right)^{J,-}=\frac{1}{2}\left(D_{X}^{W}\left(D_{Y}^{W} J\right)-D_{Y}^{W}\left(D_{X}^{W} J\right)-D_{[X, Y]}^{W} J\right) \tag{10}
\end{equation*}
$$

We obtain then the following
Corollary 2. Let $(M, g, J)$ be an almost-Hermitian 4-dimensional manifold. Then,

$$
\begin{aligned}
R_{X, Y}^{\nabla} Z=\left(R_{X, Y}^{W}\right)^{J,+} Z & -\frac{1}{2}(d J \theta)(X, Y) J Z-\frac{1}{2}(d \theta)(X, Y) Z \\
& +\frac{1}{4}\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) Z
\end{aligned}
$$

where $\left(R_{X, Y}^{W}\right)^{J,+}$ is the part of $R_{X, Y}^{W}$ that commutes with $J$.
It follows from Corollary 2 that we can relate the second Chern-Ricci curvature with $R^{W}(F)$ extending the relation in the integrable case (see [33, Theorem 1])
Corollary 3. Let $(M, g, J)$ be an almost-Hermitian 4-dimensional manifold. Then,

$$
r=\left(R^{W}(F)\right)^{J,+}+\frac{1}{2}\left(\delta^{g} \theta+\|\theta\|^{2}\right) F-\frac{1}{4}\|N\|^{2} F
$$

In particular, $g$ is second-Chern-Einstein if and only if $\left(R^{W}(F)\right)^{J,+}$ is a multiple of $F$.
Proof. We first have that $g(d J \theta, F)=-\delta^{g} \theta-\|\theta\|^{2}$, and $g(d \theta, F)=0$. Moreover, using (3), we see that

$$
\begin{aligned}
\sum_{i=1}^{4} g\left(\left(D_{e_{i}}^{W} J\right)\left(D_{J e_{i}}^{W} J\right)-\left(D_{J e_{i}}^{W} J\right)\left(D_{e_{i}}^{W} J\right) Z, V\right) & =-2 \sum_{i=1}^{4} g\left(\left(D_{e_{i}}^{W} J\right)\left(D_{e_{i}}^{W} J\right) Z, J V\right) \\
& =2 \sum_{i=1}^{4} g\left(\left(D_{e_{i}}^{W} J\right) Z,\left(D_{e_{i}}^{W} J\right) J V\right) \\
& =4 \sum_{i=1}^{4} g\left(N\left(Z,\left(D_{e_{i}}^{W} J\right) J V\right), J e_{i}\right) \\
& =4 \sum_{i, j=1}^{4} g\left(N\left(Z, e_{j}\right), J e_{i}\right) g\left(\left(D_{e_{i}}^{W} J\right) J V, e_{j}\right) \\
& =8 \sum_{i, j=1}^{4} g\left(N\left(Z, e_{j}\right), J e_{i}\right) g\left(N\left(J V, e_{j}\right), J e_{i}\right) \\
& =-8 \sum_{i, j=1}^{4} g\left(N\left(J Z, e_{j}\right), e_{i}\right) g\left(N\left(V, e_{j}\right), e_{i}\right)
\end{aligned}
$$

Now, we use the crucial fact that we are in dimension 4 with $\|N\|^{2}=8\left\|N\left(e_{1}, e_{3}\right)\right\|^{2}$

$$
\begin{aligned}
\sum_{i, j=1}^{4} g\left(N\left(J Z, e_{j}\right), e_{i}\right) g\left(N\left(V, e_{j}\right), e_{i}\right) & =\sum_{i, j, k, l=1}^{4} g\left(J Z, e_{k}\right) g\left(V, e_{l}\right) g\left(N\left(e_{k}, e_{j}\right), e_{i}\right) g\left(N\left(e_{l}, e_{j}\right), e_{i}\right), \\
& =\sum_{j, k, l=1}^{4} g\left(J Z, e_{k}\right) g\left(V, e_{l}\right) g\left(N\left(e_{k}, e_{j}\right), N\left(e_{l}, e_{j}\right)\right) \\
& =\sum_{j, k=1}^{4} g\left(J Z, e_{k}\right) g\left(V, e_{k}\right) g\left(N\left(e_{k}, e_{j}\right), N\left(e_{k}, e_{j}\right)\right), \\
& =\frac{1}{4}\|N\|^{2} g(J Z, V)
\end{aligned}
$$

The result then follows.
The canonical Weyl connection $D^{W}$ is said to be Einstein-Weyl if Ric ${ }^{W}$ (or equivalently the symmetric part of $\widetilde{\operatorname{Ric}}^{W}$ ) is proportional to the metric $g$. When $J$ is integrable, the metric $g$ is second-Chern-Einstein if and only if $D^{W}$ is Einstein-Weyl [33, Theorem 1]. This is due to the fact that $\operatorname{Ric}^{W}(J X, Y)=R^{W}(F)(X, Y)$ because $R_{X, Y}^{W}$ commutes with $J$.

From (2) we also obtain
Corollary 4. Let $(M, g, J)$ be an almost-Hermitian 4-dimensional manifold. Then,

$$
R^{W}(F)_{\cdot, J .}^{J,+}=\left(\rho^{\star}\right)^{s y m}+\left(D^{g} \theta\right)^{s y m, J,+}-\frac{1}{4}\|\theta\|^{2} g+\frac{1}{2}(\theta \otimes \theta)^{J,+}
$$

Then, combining Corollary 3 with Corollary 4 and using (7) and (8), we deduce the following
Corollary 5. Let $(M, g, J)$ be an almost-Hermitian 4-dimensional manifold. Then,

$$
r_{\cdot, J .}=\left(\text { Ric }^{g}\right)^{J,+}+\frac{1}{4}\|N\|^{2} g+\left(D^{g} \theta\right)^{s y m, J,+}+\frac{1}{2}(\theta \otimes \theta)^{J,+} .
$$

3.2. The conditions $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$ and $\mathcal{L}_{\theta^{\sharp}} g=0$. In [29] Gauduchon proved that every conformal class of an almost-Hermitian metric has a unique representative $g$ (up to constant) which satisfies $\delta^{g} \theta=0$. We call such metric (with a unit total volume) a Gauduchon metric. With this assumption, using Corollory 5 we can prove the following (when the metric is Einstein-Weyl see [58] and also [31])

Lemma 6. Let $(M, \tilde{g}, J)$ be a compact 4-dimensional almost-Hermitian manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym, },--}=0$, where $\theta$ is the Lee form of $g$. Then, the $g$-Riemannian dual of $\theta$ is a Killing vector field of $g$.

Proof. The condition $r=\frac{s^{H}}{4} F$ is conformally invariant. Then, from Corollory 5, we have for the Gauduchon metric $g$

$$
\frac{s^{H}}{4} g=\left(\operatorname{Ric}^{g}\right)^{J,+}+\frac{1}{4}\|N\|^{2} g+\left(D^{g} \theta\right)^{s y m, J,+}+\frac{1}{2}(\theta \otimes \theta)^{1,1}
$$

We recall that $\delta^{g} \theta=-g\left(D^{g} \theta, g\right)$. Taking the inner product with $\left(D^{g} \theta\right)^{s y m}=\left(D^{g} \theta\right)^{s y m, J,+}$ and integrating we have

$$
\begin{aligned}
-\int_{M} \frac{s^{H}}{4} \delta^{g} \theta v_{g}=\int_{M} g\left(\left(\operatorname{Ric}^{g}\right)^{J,+}\right. & \left.,\left(D^{g} \theta\right)^{s y m}\right) \\
& -\frac{1}{4}\|N\|^{2} \delta^{g} \theta+\left\|\left(D^{g} \theta\right)^{s y m}\right\|^{2}+\frac{1}{2} g\left((\theta \otimes \theta)^{J,+},\left(D^{g} \theta\right)^{s y m}\right) v_{g}
\end{aligned}
$$

where $v_{g}$ is the volume form. Since the metric is Gauduchon i.e. $\delta^{g} \theta=0$, we obtain

$$
\begin{aligned}
\int_{M}\left\|\left(D^{g} \theta\right)^{s y m}\right\|^{2} v_{g} & =-\int_{M} g\left(\left(\operatorname{Ric}^{g}\right)^{J,+},\left(D^{g} \theta\right)^{s y m}\right)+\frac{1}{2} g\left((\theta \otimes \theta)^{J,+},\left(D^{g} \theta\right)^{s y m}\right) v_{g} \\
& =-\int_{M} g\left(\operatorname{Ric}^{g}, D^{g} \theta\right)+\frac{1}{2} g\left(\theta \otimes \theta, D^{g} \theta\right) v_{g} \\
& =-\int_{M} g\left(\delta^{g} \operatorname{Ric}^{g}, \theta\right)+\frac{1}{2} g\left(\delta^{g}(\theta \otimes \theta), \theta\right) v_{g} \\
& =-\int_{M} g\left(-\frac{1}{2} d s^{g}, \theta\right)+\frac{1}{2}\left(\delta^{g} \theta\left\|\theta^{g}\right\|^{2}-g\left(D_{\theta}^{g} \theta, \theta\right)\right) v_{g} \\
& =-\int_{M}-\frac{1}{2} s^{g} \delta^{g} \theta+\frac{1}{2}\left(-\frac{1}{2} g\left(d\|\theta\|_{g}^{2}, \theta\right)\right) v_{g} \\
& =\frac{1}{4} \int_{M}\|\theta\|_{g^{2}}^{2} \delta^{g} \theta v_{g}=0
\end{aligned}
$$

where we used the contracted Bianchi identity $\delta^{g} R i c^{g}=-\frac{1}{2} d s^{g}$. The Lemma follows.
We have seen that in the integrable case second-Chern-Einstein is equivalent to Weyl-Einstein (also in greater dimension if we ask the LCK condition). Then, second-Chern-Einstein together with LCK implies that $D^{g} \theta=0$ and that both $\theta^{\sharp}, J \theta^{\sharp}$ are Killing real holomorphic vector fields, see [31, 49]. However, in the almost-Hermitian case the condition $\left(D^{g} \theta\right)^{s y m, J,-}=0$ is necessary, see the examples in Section 4.
Moreover, we remark that $\left(D^{g} \theta\right)^{s y m, J,-}=0$ is equivalent to $\left(\mathcal{L}_{\theta^{\sharp}} J\right)^{s y m}=0$, where $\mathcal{L}$ is the Lie derivative, so the flow of the vector field $\theta^{\sharp}$ does not necessarily preserve $J$ i.e. $\theta^{\sharp}$ is not necessarily a real holomorphic vector field. We also remark that when $M$ is compact, the condition that $J \theta^{\sharp}$ is a Killing vector field implies that $(M, g, J)$ is LCS i.e. $d \theta=0$. Indeed, applying the Lie derivative $\mathcal{L}_{J \theta^{\sharp}}$ to the relation $F=g(J \cdot, \cdot)$ we get

$$
d \theta=-2\left(D^{g} J \theta\right)_{J \cdot, \cdot}^{\text {sym }}-g\left(\mathcal{L}_{J \theta^{\sharp}} J \cdot, \cdot\right) .
$$

Hence, if $\left(D^{g} J \theta\right)^{s y m}=0$ then $d \theta$ is $J$-anti-invariant. Thus, $d \theta$ is a self-dual $d$-exact 2 -form on a compact manifold so $d \theta=0$. However, the converse is not true in general: if $d \theta=0$ then only the $J$-invariant part of $\left(D^{g} J \theta\right)^{s y m}$ vanishes i.e. $\left(D^{g} J \theta\right)^{s y m, J,+}=0$ so $J \theta^{\sharp}$ is not necessarily a Killing vector field.
3.3. Constant scalar curvatures. Let $g$ be a second-Chern-Einstein metric. If the Hermitian scalar curvature $s^{H}$ is a constant (respectively a non-constant function) then $g$ is called a strong (respectively weak) second-Chern-Einstein metric [7]. Since the conformal change of the second Chern-Ricci form (9) is the same as in the integrable case, we can generalize [7, Theorem B] to the almost-Hermitian setting (see also [29, [6, 39, 19, 34])
Definition 7. Let $g$ be the Gauduchon metric in the conformal class $[\tilde{g}]$. Then, the fundamental constant [27, 12, 4] is

$$
C(M,[\tilde{g}], J)=\int_{M} s^{H} \frac{F^{n}}{n!}
$$

where $s^{H}$ is the Hermitian scalar curvature of the almost-Hermitian structure $(g, J)$ inducing the fundamental form $F$.
Theorem 8. [7, Theorem B][40, Corollary 5.10] Let $(M, \tilde{g}, J)$ be a compact 4-dimensional almostHermitian manifold and suppose that $\tilde{g}$ is a weak second-Chern-Einstein metric. Then, there is a representative in $[\tilde{g}]$ such that its Hermitian scalar curvature has the same sign as $C(M,[\tilde{g}], J)$. Moreover, if $C(M,[\tilde{g}], J) \leq 0$, then there is a strong second-Chern-Einstein representative in $[\tilde{g}]$.

Moreover, we can prove that $s^{W}$ is constant under some conditions (in the Einstein-Weyl case, see [51, Proposition 2.1]). First of all, thanks to Corollary 5 and Lemma 6, we get the following

Lemma 9. Suppose that $(M, \tilde{g}, J)$ is a compact 4-dimensional almost-Hermitian manifold where $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym,J,- }}=0$, where $\theta$ is the Lee form of $g$. Then

$$
\begin{equation*}
\left(R i c^{g}\right)^{J,+}=\frac{s^{H}}{4} g-\frac{1}{4}\|N\|^{2} g-\frac{1}{2}(\theta \otimes \theta)^{J,+} \tag{11}
\end{equation*}
$$

Then we can prove that
Proposition 10. Let $(M, \tilde{g}, J)$ be a compact 4-dimensional almost-Hermitian manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class [ $\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym,J,- }}=0$, where $\theta$ is the Lee form of $g$. Moreover, suppose that Ric ${ }^{g}$ is J-invariant and $J \theta^{\sharp}$ is a Killing vector field. Then the conformal scalar curvature $s^{W}$ of $g$ is constant.

Proof. We apply the codifferential $\delta^{g}$ to (11) and we use the contracted Bianchi identity $\delta^{g} \operatorname{Ric}^{g}=$ $-\frac{1}{2} d s^{g}$. We obtain

$$
\begin{aligned}
-\frac{1}{2} d s^{g} & =-\frac{1}{4} d s^{H}+\frac{1}{4} d\left(\|N\|^{2}\right)-\frac{1}{4} \delta^{g}(\theta \otimes \theta)-\frac{1}{4} \delta^{g}(J \theta \otimes J \theta), \\
& =-\frac{1}{4} d s^{H}+\frac{1}{4} d\left(\|N\|^{2}\right)-\frac{1}{4}\left(\delta^{g} \theta \otimes \theta-D_{\theta^{\sharp}}^{g} \theta\right)-\frac{1}{4}\left(\delta^{g} J \theta \otimes \theta-D_{J \theta^{\sharp}}^{g} J \theta\right), \\
& =-\frac{1}{4} d s^{H}+\frac{1}{4} d\left(\|N\|^{2}\right)+\frac{1}{4} D_{\theta^{\sharp}}^{g} \theta+\frac{1}{4} D_{J \theta^{\sharp}}^{g} J \theta .
\end{aligned}
$$

Hence

$$
d s^{g}=\frac{1}{2} d s^{H}-\frac{1}{2} d\left(\|N\|^{2}\right)-\frac{1}{2} D_{\theta \sharp}^{g} \theta-\frac{1}{2} D_{J \theta \sharp}^{g} J \theta .
$$

On the other hand, from the trace of (11), we have $s^{g}=s^{H}-\|N\|^{2}-\frac{1}{2}\|\theta\|^{2}$. Thus,

$$
d\left(s^{H}-\|N\|^{2}\right)=d\left(\|\theta\|^{2}\right)-D_{\theta^{\sharp}}^{g} \theta-D_{J \theta^{\sharp}}^{g} J \theta .
$$

Applying again the codifferential $\delta^{g}$, we have

$$
\begin{equation*}
\Delta^{g}\left(s^{H}-\|N\|^{2}\right)=\Delta^{g}\left(\|\theta\|^{2}\right)-\delta^{g} D_{\theta^{\sharp}}^{g} \theta-\delta^{g} D_{J \theta^{\sharp}}^{g} J \theta, \tag{12}
\end{equation*}
$$

where $\Delta^{g}$ is the Laplacian. From Lemma 6, $\theta^{\sharp}$ is Killing. Thus, using Cartan formula and because $\mathcal{L}_{\theta \sharp} \theta=0$ we get

$$
\begin{equation*}
\delta^{g} D_{\theta^{\sharp}}^{g} \theta=\frac{1}{2} \delta^{g}\left(d \theta\left(\theta^{\sharp}, \cdot\right)\right)=-\frac{1}{2} \delta^{g} d\left(\|\theta\|^{2}\right)=-\frac{1}{2} \Delta^{g}\left(\|\theta\|^{2}\right) . \tag{13}
\end{equation*}
$$

Similarly, because $J \theta^{\sharp}$ is a Killing vector field, we have $\delta^{g} D_{J \theta^{\sharp}}^{g} J \theta=-\frac{1}{2} \Delta^{g}\left(\|\theta\|^{2}\right)$. From (12), we obtain

$$
\Delta^{g}\left(s^{H}-\|N\|^{2}-2\|\theta\|^{2}\right)=0
$$

Since $M$ is compact and from (6) we get that $s^{H}-\|N\|^{2}-2\|\theta\|^{2}=s^{g}-\frac{3}{2}\|\theta\|^{2}=s^{W}$ is a constant.

We can also deduce from (2), Lemma 6 and Lemma 9 that
Corollary 11. Suppose that $(M, \tilde{g}, J)$ is a compact 4-dimensional almost-Hermitian manifold where $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$, where $\theta$ is the Lee form of $g$. Then

$$
\begin{aligned}
\operatorname{Ric}^{W} & =\operatorname{Ric}^{g}-\frac{1}{2}\left(\|\theta\|^{2} g-\theta \otimes \theta\right) \\
& =\frac{s^{W}}{4} g+\left(\operatorname{Ric}^{g}\right)^{J,-}+\frac{1}{2}(\theta \otimes \theta)^{J,-}
\end{aligned}
$$

In particular, the metric $g$ is Einstein-Weyl if and only if

$$
\begin{equation*}
\left(\operatorname{Ric}^{g}\right)^{J,-}=-\frac{1}{2}(\theta \otimes \theta)^{J,-} \tag{14}
\end{equation*}
$$

3.4. The main theorems. Combining the equations (7) and (8) we obtain

$$
\begin{equation*}
\left(\rho^{\star}\right)^{s y m}-\left(R i c^{g}\right)^{J,+}=-\frac{1}{4}\left(2 \delta^{g} \theta+\|\theta\|^{2}-2\|N\|^{2}\right) g . \tag{15}
\end{equation*}
$$

We have already computed $\left(\operatorname{Ric}^{g}\right)^{J,+}$ in (11); now we want to compute $\rho^{\star}\left(\theta^{\sharp}, \theta^{\sharp}\right)$ so that we can evaluate (15) on ( $\left.\theta^{\sharp}, \theta^{\sharp}\right)$ and obtain a condition on the almost-Hermitian structure when $g$ is second-Chern-Einstein. We will assume that the Riemannian dual of $\theta$ is a Killing vector field.

Lemma 12. Suppose that $(M, g, J)$ is a 4-dimensional compact almost-Hermitian manifold. Suppose that the Riemannian dual $\theta^{\sharp}$ of the Lee form $\theta$ is a Killing vector field. Then,

$$
\rho^{\star}\left(\theta^{\sharp}, X\right)=-\frac{1}{2}(d \theta)^{J,-}\left(\theta^{\sharp}, X\right)+g\left(d \theta, N_{X}\right),
$$

for any vector field $X$, where $N_{X}(Y, Z)=g(N(Y, Z), X)$.
Proof. Let $\alpha$ be a 1-form. Then

$$
\begin{aligned}
&\left(\delta^{g}\left(D^{g} \alpha\right)^{J,+}-\delta^{g}\left(D^{g} \alpha\right)^{J,-}\right)(X)=-\sum_{i=1}^{4}\left(D_{e_{i}}^{g}\left(\left(D^{g} \alpha\right)^{J,+}-\left(D^{g} \alpha\right)^{J,-}\right)\right)\left(e_{i}, X\right) \\
&= \sum_{i=1}^{4}-D_{e_{i}}^{g}\left(D_{J_{i}}^{g} \alpha(J X)\right)+D^{g} \alpha\left(J D_{e_{i}}^{g} e_{i}, J X\right) \\
&+D^{g} \alpha\left(J e_{i}, J D_{e_{i}}^{g} X\right), \\
&= \sum_{i=1}^{4}-D_{e_{i}}^{g}\left(D_{J e_{i}}^{g} \alpha(J X)\right)+D^{g} \alpha\left(D_{e_{i}}^{g}\left(J e_{i}\right), J X\right) \\
&+D^{g} \alpha\left(J e_{i}, D_{e_{i}}^{g}(J X)\right)-D^{g} \alpha\left(\left(D_{e_{i}}^{g} J\right) e_{i}, J X\right) \\
& \quad-D^{g} \alpha\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right), \\
&= \sum_{i=1}^{4}-\left(D_{e_{i}}^{g}\left(D_{J e_{i}}^{g} \alpha\right)\right)(J X)+D^{g} \alpha\left(D_{e_{i}}^{g}\left(J e_{i}\right), J X\right) \\
&-D^{g} \alpha\left(\left(D_{e_{i}}^{g} J\right) e_{i}, J X\right)-D^{g} \alpha\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right), \\
&= \sum_{i=1}^{4} \frac{1}{2} g\left(R_{e_{i}, J e_{i}}^{g} \alpha^{\sharp}, J X\right)-D^{g} \alpha\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right)-D^{g} \alpha\left(J \theta^{\sharp}, J X\right), \\
&= \rho^{\star}\left(\alpha^{\sharp}, X\right)-D^{g} \alpha\left(J \theta^{\sharp}, J X\right)-\sum_{i=1}^{4} D^{g} \alpha\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right) .
\end{aligned}
$$

On the other hand, using that $g(d \theta, F)=0$ and $\delta^{g}=-*_{g} d *_{g}$, we have

$$
\begin{aligned}
\delta^{g}\left(D^{g} \theta\right)^{J,+}-\delta^{g}\left(D^{g} \theta\right)^{J,-} & =\frac{1}{2} \delta^{g}(d \theta)^{J,+}-\frac{1}{2} \delta^{g}(d \theta)^{J,-} \\
& =\frac{1}{2} \delta^{g}(d \theta)^{-}-\frac{1}{2} \delta^{g}(d \theta)^{+} \\
& =-\frac{1}{2} *_{g} d *_{g}(d \theta)^{-}+\frac{1}{2} *_{g} d *_{g}(d \theta)^{+} \\
& =\frac{1}{2} *_{g} d(d \theta)^{-}+\frac{1}{2} *_{g} d(d \theta)^{+} \\
& =\frac{1}{2} *_{g} d\left((d \theta)^{-}+d(d \theta)^{+}\right)=\frac{1}{2} *_{g} d(d \theta)=0
\end{aligned}
$$

We deduce then

$$
\begin{equation*}
\rho^{\star}\left(\theta^{\sharp}, X\right)=D^{g} \theta\left(J \theta^{\sharp}, J X\right)+\sum_{i=1}^{4} D^{g} \theta\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right) . \tag{16}
\end{equation*}
$$

Now, we would like to compute the second term in the right hand side of (16). We first recall that

$$
\left(D_{X}^{g} J\right) Y=\frac{1}{2} g(X, Y) J \theta^{\sharp}+\frac{1}{2} \theta(J Y) X+\frac{1}{2} g(J X, Y) \theta^{\sharp}-\frac{1}{2} \theta(Y) J X+2(g(N(Y, \cdot), J X))^{\sharp}
$$

which can be easily deduced from (2) and (3). Hence,

\begin{aligned}
\sum_{i=1}^{4} D^{g} \theta\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right)= & \sum_{i=1}^{4} D_{J e_{i}}^{g} \theta\left(\frac{1}{2} g\left(e_{i}, X\right) J \theta^{\sharp}\right)+D_{J e_{i}}^{g} \theta\left(\frac{1}{2} \theta(J X) e_{i}\right) \\
& +D_{J e_{i}}^{g} \theta\left(\frac{1}{2} g\left(J e_{i}, X\right) \theta^{\sharp}\right)-D_{J e_{i}}^{g} \theta\left(\frac{1}{2} \theta(X) J e_{i}\right)+2 g\left(N\left(X, D_{J e_{i}}^{g} \theta^{\sharp}\right), J e_{i}\right), \\
(17) & \frac{1}{2} g\left(D_{J X}^{g} \theta, J \theta\right)+\frac{1}{2} g\left(D_{X}^{g} \theta, \theta\right)+2 \sum_{i=1}^{4} g\left(N\left(X, D_{J e_{i}}^{g} \theta^{\sharp}\right), J e_{i}\right),
\end{aligned}
$$

where we use the fact that $g(d \theta, F)=\delta^{g} \theta=0$. Moreover, using (4), we compute the third term in (17)

$$
\begin{aligned}
\sum_{i=1}^{4} g\left(N\left(X, D_{J e_{i}}^{g} \theta^{\sharp}\right), J e_{i}\right) & =\sum_{i, j=1}^{4} g\left(D_{J e_{i}} \theta^{\sharp}, e_{j}\right) g\left(N\left(X, e_{j}\right) J e_{i}\right), \\
& =\sum_{i, j=1}^{4}-g\left(D_{J e_{i}}^{g} \theta^{\sharp}, e_{j}\right) g\left(N\left(e_{j}, J e_{i}\right), X\right)-\left(D_{J e_{i}}^{g} \theta^{\sharp}, e_{j}\right) g\left(N\left(J e_{i}, X\right), e_{j}\right), \\
& =\sum_{i, j=1}^{4}-g\left(D_{J e_{i}}^{g} \theta^{\sharp}, e_{j}\right) g\left(N\left(e_{j}, J e_{i}\right), X\right)-\left(D_{e_{j}}^{g} \theta^{\sharp}, J e_{i}\right) g\left(N\left(X, J e_{i}\right), e_{j}\right) .
\end{aligned}
$$

Thus,

$$
\begin{aligned}
\sum_{i=1}^{4} g\left(N\left(X, D_{J e_{i}}^{g} \theta^{\sharp}\right), J e_{i}\right) & =-\frac{1}{2} \sum_{i, j=1}^{4} g\left(D_{J e_{i}}^{g} \theta^{\sharp}, e_{j}\right) g\left(N\left(e_{j}, J e_{i}\right), X\right), \\
& =\frac{1}{2} \sum_{i, j=1}^{4} g\left(D_{e_{i}}^{g} \theta^{\sharp}, e_{j}\right) g\left(N\left(e_{i}, e_{j}\right), X\right), \\
& =\frac{1}{2} g\left(d \theta, N_{X}\right) .
\end{aligned}
$$

From (17), we deduce that

$$
\sum_{i=1}^{4} D^{g} \theta\left(J e_{i},\left(D_{e_{i}}^{g} J\right) X\right)=\frac{1}{2} g\left(D_{J X}^{g} \theta, J \theta\right)+\frac{1}{2} g\left(D_{X}^{g} \theta, \theta\right)+g\left(d \theta, N_{X}\right)
$$

Finally, from (16) and (17), we conclude that

$$
\begin{aligned}
\rho^{\star}\left(\theta^{\sharp}, X\right) & =D^{g} \theta\left(J \theta^{\sharp}, J X\right)+\frac{1}{2} g\left(D_{J X}^{g} \theta, J \theta\right)+\frac{1}{2} g\left(D_{X}^{g} \theta, \theta\right)+g\left(d \theta, N_{X}\right), \\
& =\frac{1}{2} D^{g} \theta\left(J \theta^{\sharp}, J X\right)+\frac{1}{2} g\left(D_{X}^{g} \theta, \theta\right)+g\left(d \theta, N_{X}\right), \\
& =-\frac{1}{2}(d \theta)^{J,-}\left(\theta^{\sharp}, X\right)+g\left(d \theta, N_{X}\right) .
\end{aligned}
$$

The lemma follows.

As consequences of Lemma [12, we obtain
Corollary 13. Suppose that $(M, g, J)$ is a 4-dimensional compact locally conformally symplectic manifold. Suppose that the Riemannian dual $\theta^{\sharp}$ of the Lee form $\theta$ is a Killing vector field. Then,

$$
\rho^{\star}\left(\theta^{\sharp}, X\right)=0,
$$

for any vector field $X$.
We also extend [33, Lemma 2] to the almost-Hermitian setting.
Corollary 14. Suppose that $(M, g, J)$ is a compact 4-dimensional almost-Hermitian manifold. Suppose that the Riemannian dual $\theta^{\sharp}$ of the Lee form $\theta$ is a Killing vector field. Then,

$$
\rho^{\star}\left(\theta^{\sharp}, \theta^{\sharp}\right)=g\left(d \theta, N_{\theta^{\sharp}}\right),
$$

where $N_{\theta^{\sharp}}(X, Y)=g\left(N(X, Y), \theta^{\sharp}\right)$.
Notice that when $J$ is integrable $\rho^{\star}\left(\theta^{\sharp}, \theta^{\sharp}\right)=0$. As a matter of fact, this condition simplifies in a natural way the problem, thus we will now prove our main theorems with the assumption that $d \theta=0$ (Theorem (15) or $N_{\theta^{\sharp}}=0$ (Theorem (19).

Theorem 15. Suppose that $(M, \tilde{g}, J)$ is a 4-dimensional compact locally conformally symplectic manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$, where $\theta$ is the Lee form of $g$. Then, either
i) $(M, g, J)$ is a second-Chern-Einstein almost-Kähler manifold, or
ii) $\theta$ is $D^{g}$-parallel and the conformal scalar curvature $s^{W}$ is non-positive and the $\star$-scalar curvature $s^{\star}$ is a positive constant. Moreover, $s^{W}$ is identically zero if and only if $J$ is integrable and so $(M, J)$ is a Hopf surface as described in [33, Theorem 2]. Furthermore, if $s^{W}$ is nowhere zero then $\chi=\sigma=0$, where $\chi$ and $\sigma$ are the Euler class and signature of $M$ respectively.

Proof. From Lemma 6, $\theta^{\sharp}$ is a Killing vector field. Since $d \theta=0$, it follows that $\theta$ is $D^{g}$-parallel and so $\theta^{\sharp}$ has a constant length. Combining Corollary 14 and Corollary 11 and (15), we obtain

$$
\begin{equation*}
\left(s^{H}+\|N\|^{2}-2\|\theta\|^{2}\right)\|\theta\|^{2}=0 . \tag{18}
\end{equation*}
$$

Hence either $\theta=0$ or $s^{H}=2\|\theta\|^{2}-\|N\|^{2}$. Now, if $s^{H}=2\|\theta\|^{2}-\|N\|^{2}$ then $s^{g}=\frac{3}{2}\|\theta\|^{2}-2\|N\|^{2}$. Hence, from (6), we get that

$$
s^{W}=-2\|N\|^{2}
$$

Thus $s^{W} \equiv 0$ if and only if $J$ is integrable. Moreover, if $s^{W}$ is nowhere zero then $5 \chi+6 \sigma=0$ using [10, Lemma 3]. The existence of a non-trivial Killing vector field of constant length implies $\chi=0$ by Hopf theorem [35] hence $\chi=\sigma=0$. Furthermore, using (8) we have that $s^{\star}=$ $s^{g}-\|\theta\|^{2}+2\|N\|^{2}=\frac{3}{2}\|\theta\|^{2}-2\|N\|^{2}-\|\theta\|^{2}+2\|N\|^{2}=\frac{1}{2}\|\theta\|^{2}$ and so $s^{\star}$ is constant.

Remark 16. We recall that there are many restrictions to the existence of a non-zero Killing vector field of constant length on a Riemannian manifold, see for example [15, 46]
Remark 17. When $J$ is integrable, if $\theta$ is $D^{g}$-parallel (the metric $g$ is called Vaisman) then $\theta^{\sharp}$ and $J \theta^{\sharp}$ are both Killing and real holomorphic vector fields [23].

Gauduchon proved in [31 (in dimension 3 see also [53]) that if the conformal scalar curvature of a compact Einstein-Weyl manifold is non-positive but non identically zero then the Gauduchon metric is an almost-Kähler Riemannian Einstein metric (i.e. Ric ${ }^{g}$ is proportional to $g$ ). We can then deduce the following

Corollary 18. [31, Theorem 3] [37, Corollary 4.2] Let $(M, \tilde{g}, J)$ be a 4-dimensional compact locally conformally symplectic manifold. Suppose that the Gauduchon metric $g \in[\tilde{g}]$ is a second-ChernEinstein and an Einstein-Weyl metric. Then $(M, g, J)$ is either an almost-Kähler Riemannian Einstein manifold or a Hopf surface as described in [33].

Proof. It follows from Theorem 15 that either $g$ is almost-Kähler or $s^{W}$ is non-positive. The corollary follows from the fact that if the metric $g$ is an almost-Kähler Einstein-Weyl metric then $g$ is a Riemannian Einstein metric [31].

The vanishing of $N_{\theta^{\sharp}}$ means that $\theta^{\sharp}$ is $g$-orthogonal to $\operatorname{Span}(N)$, which is the distribution spanned by all the vector fields $N(X, Y)$. Moreover, if $N_{\theta^{\sharp}}=0$ then $N_{J \theta^{\sharp}}=0$. In fact, in real dimension 4, at each point the dimension of $\operatorname{Span}(N)$ is equal to 0 or 2 [18] (see also [44] for more details). A similar proof to Theorem 15 gives the following

Theorem 19. Suppose that $(M, \tilde{g}, J)$ is a 4-dimensional compact almost-Hermitian manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym, }},-=0$ and $N_{\theta^{\sharp}}=0$, where $\theta$ is the Lee form of $g$. Then, either
i) $(M, g, J)$ is a second-Chern-Einstein almost Kähler manifold, or
ii) $\theta^{\sharp}$ is a non-zero Killing vector field and the conformal scalar curvature $s^{W}$ is non-positive and the $\star$-scalar curvature $s^{\star}$ is positive. Moreover, $s^{W}$ is identically zero if and only if $J$ is integrable so $(M, J)$ is a Hopf surface as described in [33]. In addition, if $s^{W}$ is nowhere zero then $\chi=\sigma=0$. Furthermore, $s^{\star}$ is a (positive) constant if and only if $\theta^{\sharp}$ is a non-zero Killing vector field of constant length.

Now, we would like to investigate the condition $N_{\theta^{\sharp}}=0$ and see if it can be implied by the $J$-invariance of different Ricci forms.

Lemma 20. Let $(M, J, g)$ be a 4-dimensional almost-Hermitian manifold. Then

$$
\rho^{\nabla}=R^{W}(F)-d J \theta-(d \theta)_{J \cdot, \cdot}^{(2,0)+(0,2)}-\frac{1}{2} \sum_{i=1}^{4}\left(N\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N\left(e_{i}, e_{j}\right)\right)^{b},
$$

where $b$ is the isomorphism between vector fields and 1-forms induced by $g$. In particular

$$
\left(\rho^{\nabla}\right)^{(2,0)+(0,2)}=\left(R^{W}(F)\right)^{(2,0)+(0,2)}-(d J \theta)^{(2,0)+(0,2)}-(d \theta)_{J \cdot, \cdot}^{(2,0)+(0,2)}
$$

Proof. From Proposition 1, we have that

$$
\begin{aligned}
2 \rho^{\nabla}(X, Y)= & \sum_{i=1}^{4} g\left(R_{X, Y}^{\nabla} e_{i}, J e_{i}\right) \\
= & \sum_{i=1}^{4} g\left(R_{X, Y}^{W} e_{i}, J e_{i}\right)-\frac{1}{2}(d J \theta)(X, Y) g\left(J e_{i}, J e_{i}\right)-\frac{1}{2}(d \theta)(X, Y) g\left(e_{i}, J e_{i}\right) \\
& -\frac{1}{2} g\left(\left(D_{X}^{W}\left(D_{Y}^{W} J\right)-D_{Y}^{W}\left(D_{X}^{W} J\right)-D_{[X, Y]}^{W} J\right) J e_{i}, J e_{i}\right) \\
& +\frac{1}{4} g\left(\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) e_{i}, J e_{i}\right) \\
= & \sum_{i=1}^{4} g\left(R_{X, Y}^{W} e_{i}, J e_{i}\right)-2(d J \theta)(X, Y) \\
& +\frac{1}{4} \sum_{i=1}^{4} g\left(\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) e_{i}, J e_{i}\right)
\end{aligned}
$$

Because $D^{W}$ is torsion free, and using the relation

$$
g\left(R_{X, Y}^{W} Z, W\right)+g\left(R_{X, Y}^{W} W, Z\right)=(d \theta)(X, Y) g(Z, W)
$$

we can easily deduce the following relation for any vector fields $X, Y, Z, W$

$$
\begin{aligned}
2 g\left(R_{X, Y}^{W} Z, W\right)=2 g\left(R_{Z, W}^{W} X, Y\right)- & d \theta(Z, W) g(X, Y)+d \theta(X, Y) g(Z, W)-d \theta(X, W) g(Y, Z) \\
& -d \theta(Y, Z) g(X, W)+d \theta(Y, W) g(X, Z)+d \theta(X, Z) g(Y, W)
\end{aligned}
$$

In particular,

$$
\sum_{i=1}^{4} g\left(R_{e_{i}, J e_{i}}^{W} X, Y\right)=\sum_{i=1}^{4} g\left(R_{X, Y}^{W} e_{i}, J e_{i}\right)+d \theta(J X, Y)+d \theta(X, J Y)
$$

Hence,

$$
\begin{align*}
2 \rho^{\nabla}(X, Y)=2 R^{W}(F)(X, Y)-d \theta & (J X, Y)-d \theta(X, J Y)-2(d J \theta)(X, Y)  \tag{19}\\
& +\frac{1}{4} \sum_{i=1}^{4} g\left(\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) e_{i}, J e_{i}\right)
\end{align*}
$$

Moreover, using (3) we have

$$
\begin{aligned}
\sum_{i=1}^{4} g\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right) e_{i}, J e_{i}\right) & =-2 \sum_{i=1}^{4} g\left(N\left(\left(D_{Y}^{W} J\right) e_{i}, e_{i}\right), X\right) \\
& =-2 \sum_{i, j=1}^{4} g\left(N\left(e_{j}, e_{i}\right), X\right) g\left(\left(D_{Y}^{W} J\right) e_{i}, e_{j}\right) \\
& =-4 \sum_{i, j=1}^{4} g\left(N\left(e_{i}, e_{j}\right), X\right) g\left(J N\left(e_{i}, e_{j}\right), Y\right)
\end{aligned}
$$

Hence

$$
\begin{aligned}
\sum_{i=1}^{4} g\left(\left(\left(D_{X}^{W} J\right)\left(D_{Y}^{W} J\right)-\left(D_{Y}^{W} J\right)\left(D_{X}^{W} J\right)\right) e_{i}, J e_{i}\right)= & -4 \sum_{i, j=1}^{4} g\left(N\left(e_{i}, e_{j}\right), X\right) g\left(J N\left(e_{i}, e_{j}\right), Y\right) \\
& +4 \sum_{i, j=1}^{4} g\left(N\left(e_{i}, e_{j}\right), Y\right) g\left(J N\left(e_{i}, e_{j}\right), X\right) \\
= & -4 \sum_{i, j=1}^{4}\left(\left(N\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N\left(e_{i}, e_{j}\right)\right)^{b}\right)(X, Y)
\end{aligned}
$$

From (19), we deduce that

$$
\begin{aligned}
\rho^{\nabla}(X, Y)=R^{W}(F)(X, Y)- & \frac{1}{2}(d \theta(J X, Y)+d \theta(X, J Y))-(d J \theta)(X, Y) \\
& -\frac{1}{2} \sum_{i, j=1}^{4}\left(N\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N\left(e_{i}, e_{j}\right)\right)^{b}(X, Y)
\end{aligned}
$$

Remark 21. We can compute the $J$-anti-invariant part of $R^{W}(F)$ and it is given by

$$
\left(R^{W}(F)\right)^{(2,0)+(0,2)}=-\sum_{i=1}^{4} g\left(\left(D_{e_{i}}^{g} N\right)(\cdot, \cdot), e_{i}\right)+\frac{3}{2} N_{\theta^{\sharp}},
$$

where $N_{\theta^{\sharp}}=g\left(N(\cdot, \cdot), \theta^{\sharp}\right)$.

Corollary 22. Let $(M, g, J)$ be a 4-dimensional almost-Hermitian manifold. Suppose that $\rho^{\nabla}$ and $R^{W}(F)$ are $J$-invariant. Then $N_{\theta^{\sharp}}=0$.

Proof. From Lemma 20, we obtain that

$$
\begin{equation*}
(d J \theta)^{(2,0)+(0,2)}=-(d \theta)_{J \cdot, \cdot}^{(2,0)+(0,2)} \tag{20}
\end{equation*}
$$

Applying the Lie derivative $\mathcal{L}_{\theta^{\sharp}}$ to the relation $F=g(J \cdot, \cdot)$ and using the Cartan formula we obtain

$$
d J \theta=-\|\theta\|^{2} F+\theta \wedge J \theta+2\left(D^{g} \theta\right)_{J \cdot, \cdot}^{s y m}+g\left(\mathcal{L}_{\theta^{\sharp}} J \cdot, \cdot\right) .
$$

In particular

$$
\begin{equation*}
(d J \theta)^{(2,0)+(0,2)}=\left(\mathcal{L}_{\theta^{\sharp}} J\right)^{\text {anti-sym }} . \tag{21}
\end{equation*}
$$

Similarly, we have

$$
d \theta=-2\left(D^{g} J \theta\right)_{J \cdot, \cdot}^{s y m}-g\left(\mathcal{L}_{J \theta^{\sharp}} J \cdot, \cdot\right) .
$$

In particular,

$$
\begin{equation*}
(d \theta)_{J \cdot, \cdot}^{(2,0)+(0,2)}=g\left(J\left(\mathcal{L}_{J \theta \sharp} J\right)^{a n t i-s y m} \cdot, \cdot\right) . \tag{22}
\end{equation*}
$$

Combining (20) (21) and (22) we deduce that

$$
\begin{equation*}
\left(\mathcal{L}_{J \theta^{\sharp}} J\right)^{\text {anti-sym }}=J\left(\mathcal{L}_{\theta^{\sharp}} J\right)^{\text {anti-sym }} . \tag{23}
\end{equation*}
$$

Now, for any almost-Hermitian manifold we have

$$
\mathcal{L}_{J \theta^{\sharp}} J-J\left(\mathcal{L}_{\theta^{\sharp}} J\right)=4 N\left(\theta^{\sharp}, \cdot\right) .
$$

On the other hand from (4) we see that $\left(g\left(\left(N\left(\theta^{\sharp}, \cdot\right), \cdot\right)\right)^{\text {anti-sym }}=-2 N_{\theta^{\sharp}}\right.$ so that

$$
g\left(\left(\mathcal{L}_{J \theta^{\sharp}} J\right)^{\text {anti-sym }}-J\left(\mathcal{L}_{\theta^{\sharp}} J\right)^{\text {anti-sym }} \cdot, \cdot\right)=-2 N_{\theta^{\sharp}} .
$$

From (23), we deduce that $N_{\theta^{\sharp}}=0$.
Corollary 23. Suppose that $(M, \tilde{g}, J)$ is a compact 4-dimensional almost-Hermitian manifold and $\tilde{g}$ is a second-Chern-Einstein metric. Suppose that the Gauduchon metric $g$ in the conformal class $[\tilde{g}]$ satisfies $\left(D^{g} \theta\right)^{\text {sym,J,- }}=0$ and that $\rho^{\nabla}$ and $R^{W}(F)$ are $J$-invariant. Then conclusions of Theorem 19 hold.

Proof. $\rho^{\nabla}$ and $R^{W}(F)$ being $J$-invariant implies that $N_{\theta^{\sharp}}=0$ by Corollary 22, We apply then Theorem 19,
3.5. Relation between second Chern-Ricci and Bismut-Ricci tensors. Finally, we relate the second Chern-Ricci tensor with the Bismut-Ricci tensor. This will give us the possibility to compute it on almost-abelian Lie groups in Section 5. Thanks to Corollary 3 and Lemma 20 we see that both the first Chern-Ricci form $\rho^{\nabla}$ and the second Chern-Ricci form $r$ can be expressed in terms of $R^{W}(F)$. Hence, we get the following

Proposition 24. Let $(M, g, J)$ be a 4-dimensional almost-Hermitian manifold. Then,

$$
r=\left(\rho^{\nabla}+d J \theta\right)^{J,+}+\frac{1}{4}\left(2 \delta^{g} \theta+2\|\theta\|^{2}-\|N\|^{2}\right) F+\frac{1}{2} \sum_{i, j}^{4}\left(N\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N\left(e_{i}, e_{j}\right)\right)^{b}
$$

In particular, thanks to (5),

$$
r=\left(\operatorname{Ric}^{B}\right)^{J,+}+\frac{1}{4}\left(2 \delta^{g} \theta+2\|\theta\|^{2}-\|N\|^{2}\right) F+\frac{1}{2} \sum_{i, j}^{4}\left(N\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N\left(e_{i}, e_{j}\right)\right)^{b}
$$

From this proposition we see that in the integrable case the second-Chern-Einstein problem agrees with the Bismut-Einstein problem

$$
\left(R i c^{B}\right)^{J,+}=\lambda F, \quad \text { for some function } \lambda .
$$

As a matter of fact, on a 4-dimensional Hermitian manifold

$$
R^{W}(F)=\left(R i c^{B}\right)^{J,+} .
$$

This also follows from Lemma 20 and (5).
Remark 25. One can check that the crucial property of 4 -dimensional manifolds that leads to these relations between the second Chern-Ricci form, the first Bismut-Ricci form and $R^{W}(F)$ is $d F=\theta \wedge F$. As a consequence, in higher dimension $2 n$, if we assume the Hermitian structure to be locally conformally Kähler we obtain similar relations (see [1). For example, computations analogous to the one we did here can show that on a LCK manifold

$$
R^{W}(F)=\operatorname{Ric}^{\left(\frac{1}{1-n}\right)}
$$

where $R i c^{(t)}$ is the first Ricci form of the Gauduchon connection $\nabla^{t}$ introduced in [32], see Section 5 for the definition.

## 4. 4-dimensional compact examples with almost-Hermitian second-Chern-Einstein METRICS

Here we use the same notation of Lie algebras as [48].

### 4.1. Conformally locally symplectic Lie algebras associated to compact solvmanifolds.

i) The Lie algebra $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}$ : the structure of the Lie algebra is

$$
\left[e_{1}, e_{3}\right]=-e_{2}, \quad\left[e_{2}, e_{3}\right]=e_{1},
$$

where $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ is a basis of $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}$. The associated simply connected group to the Lie algebra $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}$ admits lattices (see for example [17, 4, 5], in the notation of [4] $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}$ corresponds to $\mathfrak{r}_{3,0}^{\prime} \times \mathbb{R}$ ). We consider the almost-complex structure

$$
J e_{1}=e_{3}, \quad J e_{2}=e_{4}
$$

The almost-complex structure $J$ is non-integrable because $N\left(e_{1}, e_{2}\right)=\frac{1}{4} e_{3}$.
We consider the following $J$-compatible metric $g$

$$
g=(\sqrt{5}-1)\left(e^{1} \otimes e^{1}+e^{3} \otimes e^{3}\right)+e^{2} \otimes e^{2}+e^{4} \otimes e^{4}
$$

where $\left\{e^{1}, e^{2}, e^{3}, e^{4}\right\}$ is the dual basis.
The pair $(g, J)$ induces the fundamental form

$$
F=(\sqrt{5}-1) e^{13}+e^{24}
$$

where $e^{13}=e^{1} \wedge e^{3}$ etc. Remark that the form $d F=e^{134}$. Moreover, the Lee form is given by

$$
\theta=\frac{1}{(\sqrt{5}-1)} e^{4} .
$$

Hence $d \theta=0$. Moreover, $\left(D^{g} \theta\right)^{\text {sym, } J,-}=0$. On the other hand, the second Chern-Ricci form is given by

$$
r=\frac{1}{4} e^{13}+\frac{1}{4(\sqrt{5}-1)} e^{24}
$$

so the metric $g$ is a second-Chern-Einstein metric with a positive Hermitian scalar curvature $s^{H}=\frac{1}{\sqrt{5}-1}$. Thus, $\theta$ is $D^{g}$-parallel. We also remark that $N_{\theta^{\sharp}}=0$ and the first

Chern-Ricci form $\rho^{\nabla}=\frac{1}{2} e^{13}$ is J-invariant.
ii) The Lie algebra $\mathcal{A}_{4,1}$ : the structure of the Lie algebra is

$$
\left[e_{2}, e_{4}\right]=e_{1}, \quad\left[e_{3}, e_{4}\right]=e_{2}
$$

where $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ is a basis of $\mathcal{A}_{4,1}$. The associated simply connected group to the Lie algebra $\mathcal{A}_{4,1}$ admits lattices (see for example [17, 4, 5], in the notation of [4] $\mathcal{A}_{4,1}$ corresponds to $\mathfrak{n}_{4}$ ).

We consider the almost-complex structure

$$
J e_{1}=e_{3}, \quad J e_{2}=e_{4}
$$

The almost-complex structure $J$ is non-integrable because $N\left(e_{1}, e_{2}\right)=\frac{1}{4} e_{2}$.
We consider the following $J$-compatible metric $g$

$$
g=\frac{1}{2}\left(e^{1} \otimes e^{1}+e^{3} \otimes e^{3}\right)+e^{2} \otimes e^{2}+e^{4} \otimes e^{4}
$$

where $\left\{e^{1}, e^{2}, e^{3}, e^{4}\right\}$ is the dual basis.
The pair $(g, J)$ induces the fundamental form

$$
F=\frac{1}{2} e^{13}+e^{24}
$$

Remark that the form $d F=\frac{1}{2} e^{234}$. Moreover, the Lee form is given by

$$
\theta=-\frac{1}{2} e^{3}
$$

Hence $d \theta=0$. However in this example, $\left(D^{g} \theta\right)^{s y m, J,-}$ does not vanish so $\theta^{\sharp}$ is not a Killing vector field. Explicitly, $\left(D^{g} \theta\right)^{\text {sym,J,- }}=\frac{1}{2}\left(e^{2} \otimes e^{4}+e^{4} \otimes e^{2}\right)$. On the other hand, the second Chern-Ricci form $r$ vanishes, so the metric $g$ is a second-Chern-Einstein metric with vanishing Hermitian scalar curvature. We also remark that $N_{\theta^{\sharp}}=0$ and the first Chern-Ricci form vanishes.
iii) The Lie algebra $\mathcal{A}_{4,8}$ : the structure of the Lie algebra is

$$
\left[e_{2}, e_{3}\right]=e_{1}, \quad\left[e_{2}, e_{4}\right]=e_{2}, \quad\left[e_{3}, e_{4}\right]=-e_{3}
$$

where $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ is a basis of $\mathcal{A}_{4,8}$. The associated simply connected group to the Lie algebra $\mathcal{A}_{4,8}$ admits lattices (see for example [17, 5], in the notation of [5] $\mathcal{A}_{4,8}$ corresponds to $\mathfrak{d}_{4}$ ) We consider the almost-complex structure

$$
J e_{1}=e_{4}, \quad J e_{2}=e_{3}
$$

The almost-complex structure $J$ is non-integrable because $N\left(e_{1}, e_{2}\right)=\frac{1}{2} e_{3}$.
We consider the following $J$-compatible metric $g$

$$
g=\sum_{i=1}^{4} e^{i} \otimes e^{i}
$$

where $\left\{e^{1}, e^{2}, e^{3}, e^{4}\right\}$ is the dual basis.
The pair $(g, J)$ induces the fundamental form

$$
F=e^{14}+e^{23}
$$

Remark that the form $d F=-e^{234}$. Moreover, the Lee form is given by

$$
\theta=-e^{4}
$$

Hence $d \theta=0$. However in this example, $\left(D^{g} \theta\right)^{s y m}, J,-$ does not vanish so $\theta^{\sharp}$ is not a Killing vector field. Explicitly, $\left(D^{g} \theta\right)^{\text {sym }, J,-}=e^{3} \otimes e^{3}-e^{2} \otimes e^{2}$. On the other hand, the second

Chern-Ricci form $r$ vanishes, so the metric $g$ is a second-Chern-Einstein metric with vanishing Hermitian scalar curvature. We also remark that $N_{\theta^{\sharp}}=0$ and the first Chern-Ricci form vanishes.
4.2. Non conformally locally symplectic Lie algebra associated to compact solvmanifolds. The Lie algebra $\mathcal{A}_{4,10}$ : the structure of the Lie algebra is

$$
\left[e_{2}, e_{3}\right]=e_{1}, \quad\left[e_{2}, e_{4}\right]=-e_{3}, \quad\left[e_{3}, e_{4}\right]=e_{2}
$$

where $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ is a basis of $\mathcal{A}_{4,10}$. The associated simply connected group to the Lie algebra $\mathcal{A}_{4,8}$ admits lattices (see for example [17, 5], in the notation of [5] $\mathcal{A}_{4,10}$ corresponds to $\mathfrak{d}_{4,0}^{\prime}$ ). We consider the almost-complex structure

$$
J e_{1}=e_{3}, \quad J e_{2}=e_{4}
$$

The almost-complex structure $J$ is non-integrable because $N\left(e_{1}, e_{2}\right)=\frac{1}{4} e_{2}+\frac{1}{4} e_{3}$.
We consider the following $J$-compatible metric $g$

$$
g=\frac{1+\sqrt{17}}{8}\left(e^{1} \otimes e^{1}+e^{3} \otimes e^{3}\right)+\left(e^{2} \otimes e^{2}+e^{4} \otimes e^{4}\right)
$$

where $\left\{e^{1}, e^{2}, e^{3}, e^{4}\right\}$ is the dual basis.
The pair $(g, J)$ induces the fundamental form

$$
F=\frac{1+\sqrt{17}}{8} e^{13}+e^{24}
$$

Remark that the form $d F=-\frac{1+\sqrt{17}}{8} e^{124}$. Moreover, the Lee form is given by

$$
\theta=-\frac{1+\sqrt{17}}{8} e^{1}
$$

Hence $d \theta \neq 0$. In this example, $\left(D^{g} \theta\right)^{s y m, J,-}$ vanishes. On the other hand, the second Chern-Ricci form is

$$
r=\frac{1+\sqrt{17}}{32} e^{13}+\frac{1}{4} e^{24}
$$

so the metric $g$ is a second-Chern-Einstein metric with positive Hermitian scalar curvature $s^{H}=1$. Hence, $\theta^{\sharp}$ is a Killing vector field but not $D^{g}$-parallel. We also remark that in this example $N_{\theta^{\sharp}} \neq 0$ and the first Chern-Ricci form $\rho^{\nabla}=\frac{1}{2} e^{24}-\frac{1}{2} e^{34}$ is not $J$-invariant.

## 5. Special metrics metrics on almost-abelian Lie algebras

An almost-abelian Lie group $G$ is a Lie group whose Lie algebra $\mathfrak{g}$ has a codimension-one abelian ideal $\mathfrak{n} \subset \mathfrak{g}$. Given an almost-Hermitian left-invariant structure $(g, J)$ on a $2 n$-dimensional almostabelian Lie group $G$, define $\mathfrak{n}_{1}:=\mathfrak{n} \cap J \mathfrak{n}$ and $J_{1}:=J_{\left.\right|_{\mathfrak{n}_{1}}}$. Then we can choose an orthonormal basis $\left\{e_{1}, \ldots, e_{2 n}\right\}$ for $\mathfrak{g}$ such that

$$
\mathfrak{n}=\operatorname{span}_{\mathbb{R}}\left\langle e_{1}, \ldots, e_{2 n-1}\right\rangle \quad \text { and } \quad J e_{i}=e_{2 n-i+1} \text { for } i=1, \ldots, n
$$

Hence, the fundamental form $F(\cdot, \cdot):=g(J \cdot, \cdot)$ associated to the almost-Hermitian structure $(J, g)$ is

$$
F=e^{1} \wedge e^{2 n}+e^{2} \wedge e^{2 n-1}+\cdots+e^{n} \wedge e^{n+1}
$$

given in terms of the dual left-invariant frame $\left\{e^{1}, \ldots, e^{2 n}\right\}$.

The algebra structure of $\mathfrak{g}$ is completely described by the adjoint map

$$
\begin{aligned}
\operatorname{ad}_{e_{2 n}}: \mathfrak{g} & \rightarrow \mathfrak{g} \\
x & \mapsto\left[e_{2 n}, x\right] .
\end{aligned}
$$

The matrix associated to this endomorphism is

$$
\operatorname{ad}_{\left.e_{2 n}\right|_{\mathfrak{n}}}=\left(\begin{array}{cc}
a & b  \tag{24}\\
v & A
\end{array}\right), \quad a \in \mathbb{R}, b, v \in \mathfrak{n}_{1}, A \in \mathfrak{g l}\left(\mathfrak{n}_{1}\right)
$$

The data $(a, b, v, A)$ completely characterizes the almost-Hermitian structure $(g, J)$. For example, the integrability of $J$ can be expressed in terms of $(a, b, v, A)$ asking that $b=0$ and $A \in \mathfrak{g l}\left(n_{1}, J_{1}\right)$, where $\mathfrak{g l}\left(n_{1}, J_{1}\right)$ denotes endomorphisms of $\mathfrak{n}_{1}$ commuting with $J_{1}$, see [11, Lemma 4.1].

On an almost-abelian almost-Hermitian Lie group $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, J, g\right)$ the Lee form is given by

$$
\begin{equation*}
\theta=J \delta^{g} F=(J v)^{b}-(\operatorname{tr} A) e^{2 n} \tag{25}
\end{equation*}
$$

with respect to the adapted unitary basis $\left\{e_{1}, \ldots, e_{2 n}\right\}$, see for example [24].
Given an almost-Hermitian manifold $(M, g, J)$, Gauduchon introduced in 32] a 1-parameter family $\nabla^{(t)}$ of canonical Hermitian connections, i.e. $\nabla^{(t)} g=\nabla^{(t)} J=0$. In this family $\nabla^{(1)}=\nabla$ corresponds to the Chern connection; while $\nabla^{(-1)}=\nabla^{B}$ corresponds to the Bismut connection. Any canonical connection $\nabla^{(t)}$ induces the associated first Ricci form

$$
R i c^{(t)}=\frac{1}{2} \sum_{i=1}^{2 n} g\left(R_{X, Y}^{\nabla_{i}^{t}} e_{i}, J e_{i}\right)
$$

where $R^{\nabla^{(t)}}$ denotes the curvature tensor of $\nabla^{(t)}$.
The first Ricci forms of the canonical connections on a Lie group ( $G, \mathfrak{g}$ ) equipped with an almostHermitian structure $(g, J)$ were computed in [63]. In particular, for any parameter $t \in \mathbb{R}$ these are given by

$$
\operatorname{Ric}^{(t)}(X, Y)=-\frac{1}{2}\left\{\operatorname{tr}\left(\operatorname{ad}_{[X, Y]} \circ J\right)-t \operatorname{tr} \operatorname{ad}_{J[X, Y]}+(t-1) g\left(F, d[X, Y]^{b}\right)\right\}
$$

Then, a direct computation leads to the following Lemma
Lemma 26. Let $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$ be an almost-abelian almost-Hermitian Lie group, endowed with an adapted unitary basis $\left\{e_{1}, \ldots, e_{2 n}\right\}$, determining the algebraic data ( $a, b, v, A$ ) by (24). Then, the first Ricci form associated to the canonical connection $\nabla^{t}$ is
$\operatorname{Ric}^{(t)}=-\frac{1}{2}\left\{\left(2 a^{2}+\operatorname{tatr} A+(1-t)|v|^{2}+b \cdot v\right) e^{1}+\left((2 a+t \operatorname{tr} A) b+A^{t} b+(1-t) A^{t} v\right)^{b}\right\} \wedge e^{2 n}$.
In particular,

$$
\begin{equation*}
\operatorname{Ric}^{B}=-\frac{1}{2}\left\{\left(2 a^{2}-a \operatorname{tr} A+2|v|^{2}+b \cdot v\right) e^{1} \wedge e^{2 n}+\left((2 a-\operatorname{tr} A) b+A^{t} b+2 A^{t} v\right)^{b} \wedge e^{2 n}\right\} \tag{26}
\end{equation*}
$$

Before studying the second-Chern-Einstein problem, we examine the Bismut-Einstein problem on almost-Hermitian almost-abelian Lie groups of any dimension. We analyze the Einstein condition together with the request that $d J d F=0$. Indeed, in Hermitian geometry the Einstein problem for the Bismut connection is stated as follows

Definition $27([26])$. Let $(M, g, J)$ be a Hermitian manifold with $g$ a pluriclosed metric (meaning that $d J d F=0$ ). Then $g$ is said to be a Bismut-Hermitian-Einstein metric if $\left(\text { Ric }^{B}\right)^{J,+}=\lambda F$ for some function $\lambda$.

These metrics were firstly studied in [56] as fixed points of a parabolic flow of metrics, the pluriclosed flow. We shall remark that there is a lack of examples of such metrics: the only known are the Kähelr-Einstein and the Bismut-flat metrics, the latter meaning that the whole Bismut curvature tensor vanishes $\left(R^{B}=0\right)$. In the following, we prove that on Hermitian almost-abelian Lie groups the Bismut-Hermitian-Einstein metrics are Kähler. However, as soon as we drop the the integrability assumption we are able to find non-almost-Kähler metrics that satisfy the BismutEinstein equation and such that $d J d F=0$.
5.1. Bismut-Einstein Problem. We study here the Bismut-Einstein problem, $\left(\operatorname{Ric}^{B}\right)^{J,+}=\lambda F$ for $\lambda \in \mathbb{R}$, on an almost-Hermitian almost-abelian Lie group $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$. Thanks to Equation (26) we see that to obtain a solution to the Einstein problem $\lambda$ must vanish. Thus, we obtain the conditions

$$
\left\{\begin{array}{l}
2 a^{2}-a \operatorname{tr} A+2|v|^{2}+b \cdot v=0  \tag{27}\\
(2 a-\operatorname{tr} A) b+A^{t} b+2 A^{t} v=0
\end{array}\right.
$$

Moreover, from a direct computation of $d J d F$ we obtain the following lemma
Lemma 28. Let $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$ be an almost-Hermitian almost-abelian Lie group, endowed with an adapted unitary basis $\left\{e_{1}, \ldots, e_{2 n}\right\}$, determining the algebraic data ( $a, b, v, A$ ) by (24). Then, the metric satisfies $d J d F=0$ (here $J d F=-d F(J \cdot, J \cdot, J \cdot)$ ) if and only if for any $x, y, z \in \mathfrak{n}_{1}$

$$
\left\{\begin{array}{l}
\langle b, x\rangle(\langle A J y, z\rangle-\langle A J z, y\rangle)-\langle b, y\rangle(\langle A J x, z\rangle-\langle A J z, x\rangle)+\langle b, z\rangle(\langle A J x, y\rangle-\langle A J y, x\rangle)=0 \\
a(\langle A J y, z\rangle-\langle A J z, y\rangle)+\langle A J A y, z\rangle-\langle A J z, A y\rangle+\langle A J y, A z\rangle-\langle A J A z, y\rangle=0
\end{array}\right.
$$

Remark 29. In the Hermitian case, i.e. when $b=0$ and $A$ commutes with $J$, the condition $d J d F=0$ (the metric $g$ is then called SKT [16]) is equivalent to ask that

$$
\begin{equation*}
a A+A^{2}+A^{t} A \in \mathfrak{s o}\left(\mathfrak{n}_{1}\right) \tag{28}
\end{equation*}
$$

as showed in [11, Lemma 4.4].
Thus, in the Hermitian case, taking the trace in (28) we see that $a \operatorname{tr} A \leq 0$ with equality if and only if $A \in \mathfrak{s o}\left(\mathfrak{n}_{1}\right)$. This, together with the first equation in (27) (with $b=0$ ), imply that $v=0$ and $A \in \mathfrak{s o}\left(\mathfrak{n}_{1}\right)$, hence also $\operatorname{tr} A=0$ and then $\theta=0$ (see Equation (25)). We have the following
Proposition 30. On a Hermitian almost-Abelian Lie group $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$ the Bismut-Hermitian-Einstein metrics, are Kähler-Einstein.

On the other hand, if we take $A \in \mathfrak{s o}\left(\mathfrak{n}_{1}\right)$ commuting with $J$ but $b \neq 0 \neq v$, we obtain an almost-Hermitian almost-abelian Lie group $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$ which satisfies $d J d F=0$ but is not almost-Kähler (i.e. $\theta \neq 0$ ). Then, any solution of the equations

$$
\left\{\begin{array}{l}
2 a^{2}+2|v|^{2}+b \cdot v=0  \tag{29}\\
2 a b+A^{t} b+2 A^{t} v=0
\end{array}\right.
$$

gives a first-Bismut-Einstein metric on $G$. We focus on the 4-dimensional unimodular case $(a=$ $-\operatorname{tr} A$ ), which corresponds to $a=0$.

Theorem 31. Let $\mathfrak{g}$ be a 4-dimensional unimodular almost-abelian Lie algebra equipped with a left-invariant almost-Hermitian structure $(g, J)$ such that $A \in \mathfrak{s o}\left(\mathfrak{n}_{1}\right)$ and commutes with $J$, in particular it satisfies $d J d F=0$. Suppose that $(g, J)$ is a solution to the Bismut-Einstein problem. Then $\mathfrak{g}$ is isomorphic to one of the following Lie algebras
i) $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{3}\right]=-e_{2}, \quad\left[e_{2}, e_{3}\right]=e_{1}$. The solution is not almost-Kähler.
ii) $\mathcal{A}_{3,1} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{2}\right]=e_{3}$. The solution is almost-Kähler.

Both Lie algebras admit compact quotients.
Proof. The isomorphism classes of almost-abelian Lie algebras can be described using Jordan forms of $\operatorname{ad}_{e_{4} \mid \mathrm{n}}$ up to scaling (see [4, Lemma 2.1] and [3]). Denote by $A_{j}^{i}$ the $(i, j)$-th element of $A$. Equations (27) become

$$
\begin{cases}2|v|^{2}+b \cdot v= & 0  \tag{30}\\ A_{2}^{1}\left(b_{1}+2 v_{1}\right)= & 0 \\ A_{2}^{1}\left(b_{2}+2 v_{2}\right)= & 0\end{cases}
$$

We have then two cases:
i) $A_{2}^{1}=0$. Then,

- either $b \cdot v=-2|v|^{2}<0$ : the canonical Jordan form of $\operatorname{ad}_{e_{4} \mid n}$ up to scaling is $\left(\begin{array}{ccc}0 & 0 & 0 \\ 0 & 0 & 1 \\ 0 & -1 & 0\end{array}\right)$, which corresponds to $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1} . v \neq 0$ so $d F \neq 0$.
- or $b \cdot v=v=0$ : the canonical Jordan form of $\operatorname{ad}_{e_{4} \mid \mathfrak{n}}$ up to scaling is $\left(\begin{array}{lll}0 & 0 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0\end{array}\right)$, which corresponds to $\mathcal{A}_{3,1} \oplus \mathcal{A}_{1} . v=\operatorname{tr} A=0$ so $d F=0$.
ii) $A_{2}^{1} \neq 0$. Then, $b=-2 v \neq 0$ and the canonical Jordan form of $\operatorname{ad}_{e_{4} \mid \mathfrak{n}}$ up to scaling is $\left(\begin{array}{ccc}0 & 0 & 0 \\ 0 & 0 & 1 \\ 0 & -1 & 0\end{array}\right)$, which corresponds to $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1} . v \neq 0$ so $d F \neq 0$.
5.2. Second-Chern-Einstein Probelm. Here we study the second-Chern-Einstein problem on an almost-Hermitian almost-abelian Lie group $\left(G,[\cdot, \cdot]_{(a, b, v, A)}, g, J\right)$ of real dimension 4. We have seen that in the integrable case it reduces to the the Bismut-Einstein problem (Proposition 24), studied in the previous section; while in the non-integrable case a factor depending on the Nijenhuis tensor pops up:

\frac{1}{2} \sum_{i, j}^{4}\left(N_{J}\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N_{J}\left(e_{i}, e_{j}\right)\right)^{b} \tag{31}
\end{equation*}

Choose an adapted unitary basis $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ for $\mathfrak{g}$, determining the algebraic data $(a, b, v, A)$. Then (31) can be written as

$$
\begin{align*}
& \frac{1}{2} \sum_{i, j}^{4}\left(N_{J}\left(e_{i}, e_{j}\right)\right)^{b} \wedge\left(J N_{J}\left(e_{i}, e_{j}\right)\right)^{b}=|b|^{2} e^{1} \wedge e^{4}+\left(\left(A_{1}^{2}+A_{2}^{1}\right)^{2}+\left(A_{1}^{1}-A_{2}^{2}\right)^{2}\right) e^{2} \wedge e^{3}  \tag{32}\\
& \quad+\left(b_{2}\left(A_{1}^{1}-A_{2}^{2}\right)-b_{1}\left(A_{2}^{1}+A_{1}^{2}\right)\right) e^{1} \wedge e^{2}+\left(b_{2}\left(A_{1}^{2}+A_{2}^{1}\right)+b_{1}\left(A_{1}^{1}-A_{2}^{2}\right)\right) e^{1} \wedge e^{3} \\
& \quad+\left(b_{1}\left(A_{1}^{1}-A_{2}^{2}\right)+b_{2}\left(A_{2}^{1}+A_{1}^{2}\right)\right) e^{2} \wedge e^{4}+\left(b_{1}\left(A_{1}^{2}+A_{2}^{1}\right)-b_{2}\left(A_{1}^{1}-A_{2}^{2}\right)\right) e^{3} \wedge e^{4}
\end{align*}
$$

where $b=\left(b_{1}, b_{2}\right)$ and $A_{j}^{i}$ is the $(i, j)$-th element of $A$.
Theorem 32. Let $\mathfrak{g}$ be a 4-dimensional unimodular almost-abelian Lie algebra equipped with a leftinvariant almost-Hermitian non-Hermitian structure $(g, J)$ such that the Lee form $\theta$ is $D^{g}$-parallel and non-zero. Suppose that $(g, J)$ is a solution to the second-Chern-Einstein problem. Then $\mathfrak{g}$ is isomorphic to one of the following Lie algebras
i) $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{3}\right]=-e_{2}, \quad\left[e_{2}, e_{3}\right]=e_{1}$.
ii) $\mathcal{A}_{3,4} \oplus \mathcal{A}_{1}:\left[e_{1}, e_{3}\right]=e_{1}, \quad\left[e_{2}, e_{3}\right]=-e_{2}$.

Both Lie algebras admit compact quotients.
Remark 33. A classification of 4-dimensional almost-abelian Lie algebras with locally conformally symplectic structure is given in [4] (see also [5]). In the notation of [4], the above Lie algebras correspond respectively to $\mathfrak{r}_{3,0}^{\prime} \times \mathbb{R}$ and $\mathfrak{r}_{3,-1} \times \mathbb{R}$.

Proof. We recall that the isomorphism classes of almost-abelian Lie algebras can be described using Jordan forms of $\mathrm{ad}_{e_{4} \mid \mathrm{n}}$ up to scaling (see [4, Lemma 2.1] and [3]).

The Lie algebra $\mathfrak{g}$ is unimodular i.e. $\operatorname{tr} A=-a$. Thanks to equations (26) and Proposition 24, we get

3 a b_{1}+A_{1}^{1} b_{1}+A_{1}^{2} b_{2}+2 A_{1}^{1} v_{1}+2 A_{1}^{2} v_{2}=4 b_{1}\left(A_{1}^{1}-A_{2}^{2}\right)+4 b_{2}\left(A_{2}^{1}+A_{1}^{2}\right) \\
3 a b_{2}+A_{2}^{1} b_{1}+A_{2}^{2} b_{2}+2 A_{2}^{1} v_{1}+2 A_{2}^{2} v_{2}=4 b_{1}\left(A_{2}^{1}+A_{1}^{2}\right)-4 b_{2}\left(A_{1}^{1}-A_{2}^{2}\right)
\end{array}\right.
$$

The Lee form is given by

$$
\theta=v_{1} e^{3}-v_{2} e^{2}+a e^{4}
$$

Then, the condition $D^{g} \theta=0$ implies the following

$$
\begin{aligned}
a & =0, \\
b_{1} v_{2} & =b_{2} v_{1}, \\
v_{1}\left(A_{2}^{1}-A_{1}^{2}\right) & =0, \\
v_{2}\left(A_{2}^{1}-A_{1}^{2}\right) & =0, \\
v_{1}\left(A_{2}^{1}+A_{1}^{2}\right) & =2 A_{1}^{1} v_{2}, \\
v_{2}\left(A_{2}^{1}+A_{1}^{2}\right) & =2 A_{2}^{2} v_{1} .
\end{aligned}
$$

Suppose that $v_{1} \neq 0$. Then the above equations imply that $A_{1}^{1}=A_{2}^{2}=A_{2}^{1}=A_{1}^{2}=0$ and

2 b_{2}^{2}-b_{2} v_{2}-2 v_{2}^{2}=0
\end{array}\right.

We remark that $b \cdot v \neq 0$. We have then two cases:
i) $b \cdot v>0$ : the canonical Jordan form of $\operatorname{ad}_{e_{4} \mid \mathfrak{n}}$ up to scaling is $\left(\begin{array}{ccc}0 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & -1\end{array}\right)$, which corresponds to $\mathcal{A}_{3,4} \oplus \mathcal{A}_{1}$.
ii) $b \cdot v<0$ : the canonical Jordan form of $\operatorname{ad}_{e_{4} \mid \mathfrak{n}}$ up to scaling is $\left(\begin{array}{ccc}0 & 0 & 0 \\ 0 & 0 & 1 \\ 0 & -1 & 0\end{array}\right)$, which corresponds to $\mathcal{A}_{3,6} \oplus \mathcal{A}_{1}$.
Now, if we suppose that $v_{1}=0$ then $\theta=v_{2} e^{2} \neq 0$ implies that $v_{2} \neq 0$. We can then deduce that $b_{1}=A_{1}^{1}=A_{2}^{2}=A_{2}^{1}=A_{1}^{2}=0$. Because $J$ is non integrable, we have $b_{2} \neq 0$. We conclude that $2 b_{2}^{2}-b_{2} v_{2}-2 v_{2}^{2}=0$, with $b_{2} v_{2} \neq 0$. We obtain then the same canonical Jordan forms as above.
