# HAUSDORFF DIMENSION IN QUASIREGULAR DYNAMICS

#### Abstract

It is shown that the Hausdorff dimension of the fast escaping set of a quasiregular self-map of $\mathbb{R}^{3}$ can take any value in the interval $[1,3]$. The Hausdorff dimension of the Julia set of such a map is estimated under some growth condition.


## 1. Introduction

Quasiregular maps are a natural generalization of holomorphic maps to higher dimensions; see $\S 2.1$ for their definition and basic properties. We will be concerned with quasiregular self-maps of $\mathbb{R}^{d}$. These are the analogues of entire maps $f: \mathbb{C} \rightarrow \mathbb{C}$. A quasiregular map $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ is said to be of polynomial type if $\lim _{|x| \rightarrow \infty}|f(x)|=\infty$ and of transcendental type otherwise. Here $|x|$ is the Euclidean norm of a point $x \in \mathbb{R}^{d}$.

The escaping set $\mathcal{I}(f)$ of a quasiregular map $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ is defined by

$$
\mathcal{I}(f)=\left\{x \in \mathbb{R}^{d}:\left|f^{n}(x)\right| \rightarrow \infty\right\} .
$$

Here $f^{n}$ is the $n$-th iterate of $f$. For transcendental entire functions the escaping set was introduced by Eremenko [16] who, in particular, showed that it is always non-empty. This result was extended to quasiregular maps of transcendental type in [8].

The proofs in $[8,16]$ actually show that not only the escaping set $\mathcal{I}(f)$ is nonempty, but that this in fact holds for a subset $\mathcal{A}(f)$ of $\mathcal{I}(f)$ called the fast escaping set. This set was first considered in [10].

In order to define it, recall that the maximum modulus is given by

$$
M(r, f)=\max _{|x|=r}|f(x)| .
$$

Let $M^{n}(r, f)$ denote the $n$-th iterate of $M(r, f)$ with respect to the first variable. We thus have $M^{1}(r, f)=M(r, f)$ and $M^{n}(r, f)=M\left(M^{n-1}(r, f), f\right)$ for $n \geq 2$. For a quasiregular map $f$ of transcendental type there exists $R_{0} \geq 0$ such that $M(R, f)>R$ for $R>R_{0}$. For $R>R_{0}$ we then have $M^{n}(R, f) \rightarrow \infty$ as $n \rightarrow \infty$. For such $R$ the fast escaping set is defined by

$$
\begin{aligned}
& \mathcal{A}(f)=\left\{x \in \mathbb{R}^{d}: \text { there exists } L \in \mathbb{N} \text { such that }\left|f^{n+L}(x)\right| \geq M^{n}(R, f)\right. \\
& \\
& \text { for all } n \in \mathbb{N}\} .
\end{aligned}
$$

This definition does not depend on $R$ as long as $M^{n}(R, f) \rightarrow \infty$; see [28, Theorem 2.2, (b)] for transcendental entire functions and [7, Proposition 3.1, (i)] for quasiregular maps. These papers also contain some equivalent definitions of $\mathcal{A}(f)$.

[^0]The Julia set $\mathcal{J}(f)$ of a transcendental entire function $f$ is defined as the set of all points where the iterates of $f$ do not form a normal family. Eremenko [16] showed that $\mathcal{J}(f)=\partial \mathcal{I}(f)$. As noted by Rippon and Stallard [27, p. 1125, Remark 1], we also have $\mathcal{J}(f)=\partial \mathcal{A}(f)$.

For quasiregular mappings the set where the iterates are not normal does not have the properties one would normally associate with a Julia set. Therefore, instead of using normality, the Julia set $\mathcal{J}(f)$ was defined in $[5,12]$ as the set of all $x \in \mathbb{R}^{d}$ such that $\mathbb{R}^{d} \backslash \bigcup_{k=1}^{\infty} f^{k}(U)$ has capacity zero for every neighborhood $U$ of $x$; see $\S 2.1$ for the definition of capacity. As shown in these papers, the set $\mathcal{J}(f)$ defined this way shares many properties with Julia sets of entire functions. However, there are examples [12, Example 7.3] where $\mathcal{J}(f) \neq \partial \mathcal{I}(f)$. On the other hand, we always have $\mathcal{J}(f) \subset \partial \mathcal{I}(f)$; see [12, Theorem 1.3].

By [9, Theorem 1.1] we also have $\mathcal{J}(f) \subset \partial \mathcal{A}(f)$. Moreover, it was shown in [9, Theorem 1.2] that under the additional hypothesis

$$
\begin{equation*}
\liminf _{r \rightarrow \infty} \frac{\log \log M(r, f)}{\log \log r}=\infty \tag{1.1}
\end{equation*}
$$

we even have $\mathcal{J}(f)=\partial \mathcal{A}(f)$. Thus for quasiregular maps the fast escaping set is perhaps even more relevant for the dynamics than the escaping set.

There is a large literature concerned with the Hausdorff dimension of the above sets for transcendental entire functions; see [20] and [31] for surveys. We will describe some of these results, denoting by $\operatorname{dim} X$ the Hausdorff dimension of a subset $X$ of $\mathbb{R}^{d}$.

Baker [2] proved that the Julia set of a transcendental entire function $f$ contains continua. Thus $\operatorname{dim} \mathcal{J}(f) \geq 1$. On the other hand, for all $\rho \in[1,2]$ there exists a transcendental entire function $f$ satisfying $\operatorname{dim} \mathcal{J}(f)=\rho$. Here the case $\rho \in(1,2)$ is due to Stallard [30, Theorem 1.1] while the case $\rho=1$ is due to Bishop [14]. Examples with $\operatorname{dim} \mathcal{J}(f)=2$ had been known already before. Perhaps the simplest ones are those with $\mathcal{J}(f)=\mathbb{C}$. The first example of such a function $f$ was given by Baker [1].

Rippon and Stallard [27, Theorem 1] showed that every component of $\mathcal{A}(f)$ is unbounded. While a conjecture of Eremenko [16] saying that every component of $\mathcal{I}(f)$ is unbounded was recently disproved [21], the result by Rippon and Stallard implies of course that $\mathcal{I}(f)$ has at least one unbounded component. In particular, $\operatorname{dim} \mathcal{I}(f) \geq \operatorname{dim} \mathcal{A}(f) \geq 1$. On the other hand, it was shown in [25, Corollary 1.2] that for all $\rho \in[1,2]$ there exists a transcendental entire function $f$ such that $\operatorname{dim} \mathcal{I}(f)=\rho$. The main contribution of [25] is the case $\rho=1$. The case $\rho \in(1,2)$ is deduced from results in [30] and [11]. Inspection of the proofs in [11] shows that we actually may achieve $\operatorname{dim} \mathcal{A}(f)=\rho$ for given $\rho \in(1,2)$. For $\rho=2$ such an example is given by the exponential function; this follows from the arguments in [23, Theorem 1.2]. Further examples are given in [29]. Altogether we see that for all $\rho \in[1,2]$ there exists a transcendental entire function $f$ such that $\operatorname{dim} \mathcal{A}(f)=\rho$.

It is the main purpose of this paper to extend this result to quasiregular maps of transcendental type. We will restrict to the case that $d=3$. The reason is that this allows to use a construction of Nicks and Sixsmith [24].
Theorem 1.1. For all $\rho \in[1,3]$ there exists a quasiregular map $f: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ of transcendental type such that $\operatorname{dim} \mathcal{A}(f)=\rho$.

As already mentioned, we have $\operatorname{dim} \mathcal{I}(f) \geq 1$ for a quasiregular map $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ of transcendental type. We do not know whether this bound is sharp. It seems plausible that we have $\operatorname{dim} \mathcal{I}(f) \geq d-1$ for such maps; see Remark 4.7 below.

Perhaps we also have $\operatorname{dim} \mathcal{J}(f) \geq d-1$. However, no positive lower bound is known for $\operatorname{dim} \mathcal{J}(f)$. It was shown in [12, Theorem 1.7] that $\operatorname{dim} \mathcal{J}(f)>0$ if $f$ is locally Lipschitz continuous. We obtain a lower bound under the growth condition (1.1).
Theorem 1.2. Let $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ be a quasiregular map satisfying (1.1). Then $\operatorname{dim} \mathcal{J}(f) \geq 1$.

The structure of the rest of this paper is as follows: In Sections 2 and 3 we recall some definitions and some preliminaries. In Section 4 we prove Theorem 1.1 and finally in Section 5 we prove Theorem 1.2.

We conclude the introduction with a remark on quasiregular self-maps of $\overline{\mathbb{R}^{d}}$.
Remark 1.3. Fletcher and Vellis [18] studied the more general question of when can a Cantor set be the Julia set of a uniformly quasiregular map. It follows from [18, Theorem 1.2] that for any $\rho \in(0, d-1)$ there is a uniformly quasiregular map $f: \overline{\mathbb{R}^{d}} \rightarrow \overline{\mathbb{R}^{d}}$ such that $\operatorname{dim} \mathcal{J}(f)=\rho$.

Moreover, by [18, Corollary 1.4] we can find a uniformly quasiregular map $f: \overline{\mathbb{R}^{3}} \rightarrow \overline{\mathbb{R}^{3}}$ whose Julia set is a Cantor set which is defined as the limit set of an iterated function system of similarities acting on $[0,1]^{3}$. By choosing the right similarities we can make this set have any Hausdorff dimension in $(0,3)$.

## 2. Basic results about quasiregular maps and Hausdorff dimension

2.1. Quasiregular maps. We only sketch the definition and basic properties of quasiregular maps. For a detailed treatment we refer to Rickman's book [26].

Let $\Omega \subset \mathbb{R}^{d}$ be a domain and let $f: \Omega \rightarrow \mathbb{R}^{d}$ be a map. If $f$ is differentiable at a point $x \in \Omega$, let $D f(x)$ be the derivative, $|D f(x)|=\sup _{|h|=1}|D f(x)(h)|$ its norm and $J_{f}(x)=\operatorname{det} J_{f}(x)$ the Jacobian determinant. We will also use the notation $\ell(D f(x))=\inf _{|h|=1}|D f(x)(h)|$. The map $f$ is called quasiregular if it is continuous, belongs to the Sobolev space $W_{d, l o c}^{1}(\Omega)$, and there exists $K \geq 1$ such that

$$
|D f(x)|^{d} \leq K J_{f}(x)
$$

almost everywhere in $\Omega$. The smallest such $K$ is called the outer dilatation $K_{O}(f)$. The last condition is equivalent to the existence of a constant $K^{\prime}>1$ such that

$$
J_{f}(x) \leq K^{\prime} \ell(D f(x))^{d}
$$

almost everywhere in $\Omega$. The smallest such $K^{\prime}$ is called inner dilatation $K_{I}(f)$ of $f$. An injective quasiregular map is called quasiconformal.

For a survey of results concerning the dynamics or quasiregular maps we refer to [4].

In the proof of Theorem 1.2 we also need the concept of the modulus of a path family. We only recall here the relevant definitions, for a more thorough discussion we refer to [26].

Let $\Gamma$ be a family of paths in $\mathbb{R}^{d}$, with $d \geq 2$. We denote by $\mathcal{F}(\Gamma)$ the set of all Borel functions $\rho: \mathbb{R}^{d} \rightarrow[0, \infty]$ such that $\int_{\gamma} \rho d s \geq 1$ for every locally rectifiable path $\gamma \in \Gamma$. Then the modulus $M(\Gamma)$ of $\Gamma$ is defined as

$$
M(\Gamma)=\inf _{\rho \in \mathcal{F}(\Gamma)} \int_{\mathbb{R}^{d}} \rho^{d} d m
$$

where $m$ is the Lebesgue measure. If $E, F, D \subset \mathbb{R}^{d}$, we will denote by $\Delta(E, F ; D)$ the family of paths $\gamma:[0,1] \rightarrow \mathbb{R}^{d}$ such one of the endpoints $\gamma(0)$ and $\gamma(1)$ belongs to $E$, the other one to $F$, while $\gamma(t) \in D$ for all $t \in(0,1)$.

Let $\Omega \subset \mathbb{R}^{d}$ be open and let $C$ be a compact subset of $\Omega$. Then the pair $(\Omega, C)$ is called a condenser and its capacity $\operatorname{cap}(\Omega, C)$ is defined by

$$
\operatorname{cap}(\Omega, C)=\inf _{u} \int_{\Omega}|\nabla u|^{d} d m
$$

where the infimum is taken over all non-negative functions $u \in C_{0}^{\infty}(\Omega)$ satisfying $u(x) \geq 1$ for $x \in C$. If $\operatorname{cap}(\Omega, C)=0$ for some bounded open set $\Omega$ containing $C$, then, by [26, Lemma III.2.2], we have $\operatorname{cap}\left(\Omega^{\prime}, C\right)=0$ for every bounded open set $\Omega^{\prime}$ containing $C$. In this case we say that $C$ is of capacity zero, while otherwise $C$ has positive capacity. A closed subset $C$ of $\mathbb{R}^{d}$ is said to have capacity zero if this is the case for all compact subsets of $C$.

The connection between capacity and the modulus of a path family is given by [26, Proposition II.10.2]

$$
\operatorname{cap}(\Omega, C)=M(\Delta(C, \partial \Omega ; \Omega))
$$

Zorich [34, p. 400] introduced an important example of a quasiregular self-map of $\mathbb{R}^{3}$ which can be considered as a 3 -dimensional analogue of the exponential function. In fact, the construction is quite flexible and also works in $\mathbb{R}^{d}$ for all $d \geq 2$; see [22, § 8.1]. We follow [19, § 6.5.4] in the definition of a Zorich map and consider the cube

$$
Q:=\left\{x \in \mathbb{R}^{d-1}:\|x\|_{\infty} \leq 1\right\}=[-1,1]^{d-1}
$$

and the upper hemisphere

$$
U:=\left\{x \in \mathbb{R}^{d}:\|x\|_{2}=1, x_{d} \geq 0\right\}
$$

Let $h: Q \rightarrow U$ be a bi-Lipschitz map and define

$$
Z: Q \times \mathbb{R} \rightarrow \mathbb{R}^{d}, \quad Z\left(x_{1}, \ldots, x_{d}\right)=e^{x_{d}} h\left(x_{1}, \ldots, x_{d-1}\right)
$$

The map $Z$ is then extended to a map $Z: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ by repeated reflection at hyperplanes. Many results about the dynamics of exponential functions have been extended to Zorich maps [3, 6, 15, 32, 33]. In particular, we note that it follows from the arguments given in $[3, \S 4]$ that for suitable $c \in \mathbb{R}^{3}$ and $f: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$, $f(x)=Z(x)-c$, we have $\operatorname{dim} \mathcal{A}(f)=3$. Thus we may restrict in our proof of Theorem 1.1 to the case that $1 \leq \rho<3$. We will use a modification of the Zorich map introduced by Nicks and Sixsmith [24]; see § 3.1.
2.2. Hausdorff dimension. For the definition and a thorough treatment of Hausdorff dimension we refer to the book by Falconer [17]. To obtain a lower bound for the Hausdorff dimension we will use the following result known as the mass distribution principle [17, Proposition 4.9]. Here and in the following we use the notation $B(x, r)$ for the open ball of radius $r$ around a point $x \in \mathbb{R}^{d}$. Sometimes we will emphasize the dimension by writing $B_{d}(x, r)$ instead of $B(x, r)$. The closed ball is denoted by $\bar{B}(x, r)$.
Lemma 2.1. Let $E$ be a compact subset of $\mathbb{R}^{d}$. Suppose that there exist a probability measure $\mu$ supported on $E$ and positive constants $c, r_{0}$ and $\rho$ such that

$$
\mu(B(x, r)) \leq c r^{\rho}
$$

for each $x \in E$ and each $r \in\left(0, r_{0}\right)$. Then $\operatorname{dim} E \geq \rho$.
To obtain an upper bound for the Hausdorff dimension we will use the following result [3, Lemma 5.2]. It is a simple consequence of a standard covering result [17, Covering Lemma 4.8].

Lemma 2.2. Let $E \subset \mathbb{R}^{d}$ and $\rho>0$. Suppose that for all $x \in E$ and $\delta>0$ there exist $r(x) \in(0,1), d(x) \in(0, \delta)$ and $N(x) \in \mathbb{N}$ satisfying

$$
N(x) d(x)^{\rho} \leq r(x)^{n}
$$

such that $B(x, r(x)) \cap E$ can be covered by $N(x)$ sets of diameter at most $d(x)$. Then $\operatorname{dim} E \leq \rho$.

In [3] it is assumed in addition that $E$ is bounded, but this hypothesis can be omitted since the Hausdorff dimension of an unbounded set is the supremum of the Hausdorff dimensions of its bounded subsets. Note that in [3] it was assumed that $\rho>1$ but the proof also works for $\rho>0$.

Let meas $X$ denote the Lebesgue measure of a measurable set $X$. We will need the concept of the density $\operatorname{dens}(A, B)$ of a set $A$ in a set $B$, where $A, B \subset \mathbb{R}^{d}$ are measurable with meas $B>0$. It is defined by

$$
\operatorname{dens}(A, B)=\frac{\operatorname{meas}(A \cap B)}{\operatorname{meas} B}
$$

To estimate how the density changes under a quasiconformal map we will use the following result. We omit its simple proof.

Lemma 2.3. Let $f: \Omega \rightarrow \mathbb{R}^{d}$ be quasiregular and let $A, B \subset \Omega$ be measurable with meas $B>0$. Suppose that $f$ is injective on $B$. Then

$$
\left(\frac{\operatorname{ess} \inf _{x \in B} \ell(D f(x))}{\operatorname{ess} \sup _{x \in B}|D f(x)|}\right)^{d} \leq \frac{\operatorname{dens}(f(A), f(B))}{\operatorname{dens}(A, B)} \leq\left(\frac{{\operatorname{ess} \sup _{x \in B}|D f(x)|}_{\operatorname{ess}^{\inf }}^{x \in B} \text { } \ell(D f(x))}{}\right)^{d}
$$

## 3. Preliminaries for the proof of Theorem 1.1

3.1. Definition of $f$. Nicks and Sixsmith [24, Section 5] considered a variant of the Zorich map where $h$ maps $[-1,1]^{2}$ not to the upper hemisphere but to the upper faces of a square based pyramid. Specifically, they worked with

$$
h\left(x_{1}, x_{2}\right)=\left(x_{1}, x_{2}, 1-\max \left\{\left|x_{1}\right|,\left|x_{2}\right|\right\}\right) .
$$

The map $Z$ is again defined by

$$
Z(x)=e^{x_{3}} h\left(x_{1}, x_{2}\right) \quad \text { for }\left|x_{1}\right| \leq 1 \text { and }\left|x_{2}\right| \leq 1,
$$

and extended to a map $Z: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3} \backslash\{0\}$ by reflections. They used this map $Z$ to construct a quasiregular map $G: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ which is equal to the identity in a half-space.

For $t \in \mathbb{R}$ we put $\mathbb{H}_{\geq t}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}: x_{3} \geq t\right\}$. The half-spaces $\mathbb{H}_{\leq t}, \mathbb{H}_{>t}$ and $\mathbb{H}_{<t}$ are defined analogously. The quasiregular map $G$ constructed by Nicks and Sixsmith [24, Section 6] has the property that there exists $L>0$ such that

$$
G(x)= \begin{cases}x+Z(x) & \text { for } x \in \mathbb{H}_{\geq L}, \\ x & \text { for } x \in \mathbb{H}_{\leq 0}\end{cases}
$$

The difficult part in the construction is, of course, to define $G$ in the remaining domain $\left\{x \in \mathbb{R}^{3}: 0<x_{3}<L\right\}$. Here we only note that the construction yields that there exists a constant $C$ such that

$$
\begin{equation*}
|G(x)-x| \leq C \quad \text { for } x \in \mathbb{H}_{\leq L} . \tag{3.1}
\end{equation*}
$$

We will also consider the maps $\varphi: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$,

$$
\varphi\left(x_{1}, x_{2}, x_{3}\right)=\left(x_{1}, x_{2}, x_{3}-\left|x_{1}\right|-\left|x_{2}\right|\right)
$$

and $H: \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$,

$$
H=Z \circ \varphi .
$$

The map $\varphi$ is quasiconformal and hence $H$ is quasiregular.
Considering $H$ instead of $Z$ has the advantage that while $Z$ is bounded in a half-space, $H$ is bounded in a larger domain. In fact, with

$$
\begin{equation*}
\Omega=\left\{x \in \mathbb{R}^{3}: x_{3}>\left|x_{1}\right|+\left|x_{2}\right|\right\} \tag{3.2}
\end{equation*}
$$

we have

$$
\begin{equation*}
|H(x)| \leq \max _{y \in[-1,1]^{2}}|h(y)|=\sqrt{2} \quad \text { for } x \in \mathbb{R}^{3} \backslash \Omega \tag{3.3}
\end{equation*}
$$

For $s=\left(s_{1}, s_{2}\right) \in \mathbb{Z}^{2}$ we consider the beam

$$
\begin{aligned}
T(s) & =\left[2 s_{1}-1,2 s_{1}+1\right] \times\left[2 s_{2}-1,2 s_{2}+1\right] \times \mathbb{R} \\
& =\left\{x \in \mathbb{R}^{3}:\left|x_{j}-2 s_{j}\right| \leq 1 \text { for } j \in\{1,2\}\right\} .
\end{aligned}
$$

By construction, $Z$ is injective in $T(s)$. Since $\varphi$ maps $T(s)$ bijectively onto itself, $H$ is also injective in $T(s)$. The definition of $Z$ also yields that there exists $R \geq L$ such that if $x, y \in T(s) \cap \mathbb{H}_{\geq R}$ and $x \neq y$, then $|Z(x)-Z(y)|>|x-y|$ and hence

$$
|G(x)-G(y)| \geq|Z(x)-Z(y)|-|x-y|>0
$$

We deduce that $G$ is injective in $T(s) \cap \mathbb{H}_{\geq R}$.
We also note that if $s=\left(s_{1}, s_{2}\right) \in \mathbb{Z}^{2}$ and $s_{1}+s_{2}$ is even, then both $Z$ and $G$ map $T(s) \cap \mathbb{H}_{\geq R}$ into $\mathbb{H}_{\geq 0}$, provided $R$ is large enough.

Since $\varphi$ leaves $\partial T(s)$ invariant while $Z$ maps $\partial T(s)$ to the plane $\left\{x \in \mathbb{R}^{3}: x_{3}=0\right\}$ we find that

$$
\begin{equation*}
G(H(x))=H(x) \quad \text { for } x \in \partial T(s) . \tag{3.4}
\end{equation*}
$$

We will define $f$ by putting $f(x)=G(H(x))$ in some beams while $f(x)=H(x)$ in the other beams.
In order to define this partition of the set of beams, we will use the following result.

Lemma 3.1. Let $0<\beta<1$. Then there exists a subset $S$ of $\mathbb{Z}^{2}$ with $(0,0) \in S$ such that $s_{1}+s_{2}$ is even for $s=\left(s_{1}, s_{2}\right) \in S$ and such that the following two conditions hold:
(a) If $s, s^{\prime} \in S$ and $s \neq s^{\prime}$, then $\left|s-s^{\prime}\right| \geq|s|^{\beta}+\left|s^{\prime}\right|^{\beta}$.
(b) For all $x \in \mathbb{R}^{2}$ there exists $s \in S$ such that $|x-s| \leq|s|^{\beta}+(|x|+1)^{\beta}+1$.

Proof. Let $\Sigma$ be the set of all $s=\left(s_{1}, s_{2}\right) \in \mathbb{Z}^{2}$ such that $s_{1}+s_{2}$ is even. We put $s_{0}=(0,0)$ and define a sequence $\left(s_{k}\right)$ recursively as follows. Assuming that $s_{0}, s_{1}, \ldots, s_{k-1}$ have been defined, let $A_{k}$ denote the set of all $s \in \Sigma$ such that $\left|s-s_{j}\right| \geq|s|^{\beta}+\left|s_{j}\right|^{\beta}$ for all $j \in\{0,1, \ldots, k-1\}$. Since $\beta<1$ this clearly holds if $|s|$ is sufficiently large so that $A_{k} \neq \emptyset$. We then choose $s_{k} \in A_{k}$ such that $\left|s_{k}\right|=\min _{s \in A_{k}}|s|$. Finally we put $S=\left\{s_{k}: k \geq 0\right\}$.

It follows from the construction that $S$ satisfies (a). To prove (b), let $x \in \mathbb{R}^{2}$. Then there exists $s^{\prime} \in \Sigma$ with $\left|x-s^{\prime}\right|<1$. It follows from the construction of $S$ that there exists $s \in S$ with $\left|s-s^{\prime}\right| \leq|s|^{\beta}+\left|s^{\prime}\right|^{\beta}$. In fact, otherwise one would have to choose $s_{k}=s^{\prime}$ at some point of the construction. It now follows that $|x-s| \leq\left|x-s^{\prime}\right|+\left|s^{\prime}-s\right|<1+|s|^{\beta}+\left|s^{\prime}\right|^{\beta} \leq 1+|s|^{\beta}+(|x|+1)^{\beta}$.

As noted at the end of $\S 2.1$, we may restrict in our proof of Theorem 1.1 to the case that $1 \leq \rho<3$. If $\rho>1$, we put

$$
\begin{equation*}
\beta=\frac{3-\rho}{2} \tag{3.5}
\end{equation*}
$$

and choose $S$ according to Lemma 3.1. If $\rho=1$, we put $S=\{(0,0)\}$. We now put

$$
T=\bigcup_{s \in S} T(s)
$$

The map $f$ is then defined by

$$
f(x)= \begin{cases}G(H(x)) & \text { if } x \in T, \\ H(x) & \text { if } x \notin T\end{cases}
$$

Note that by (3.4) the map $f$ is quasiregular.
We will need the following estimates for the number of points of $S$ in certain disks.

Lemma 3.2. Let $\beta$ and $S$ be as in Lemma 3.1. There exists $r_{0}>0$ and $\alpha_{0}>0$ such that if $r>r_{0}$ and $x \in \mathbb{R}^{2}$, then

$$
\begin{equation*}
\operatorname{card}(S \cap B(x, r)) \leq \alpha_{0} r^{2-2 \beta} \tag{3.6}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
\frac{1}{64}|x|^{-2 \beta} r^{2} \leq \operatorname{card}(S \cap B(x, r)) \leq 6|x|^{-2 \beta} r^{2} \quad \text { for } 8|x|^{\beta} \leq r \leq \frac{1}{2}|x| \tag{3.7}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{card}(S \cap B(x, r)) \leq 324 \quad \text { for } r<8|x|^{\beta} . \tag{3.8}
\end{equation*}
$$

It follows from (3.8) that

$$
\begin{equation*}
\operatorname{card}(S \cap B(x, r)) \leq 324|x|^{-2 \beta} r^{2} \quad \text { for }|x|^{\beta} \leq r \leq 8|x|^{\beta} . \tag{3.9}
\end{equation*}
$$

We thus have an estimate of the same type as (3.7) for a larger range of values of $r$.
Proof of Lemma 3.2. We begin by proving (3.7) and (3.8), from which we will deduce (3.6) afterwards. So let $x$ and $r$ be such that one the conditions in (3.7) or (3.8) is satisfied. If $r$ is large, then so is $|x|$. Choosing $r_{0}$ large we can thus achieve that $8|x|^{\beta}<|x| / 2$ for any $x$ satisfying one of the conditions in (3.7) or (3.8). Thus we have $r \leq|x| / 2$ in both cases. Hence

$$
\begin{equation*}
\frac{1}{2}|x| \leq|y| \leq \frac{3}{2}|x| \quad \text { for } y \in B(x, r) \tag{3.10}
\end{equation*}
$$

By the definition of $S$ we have

$$
B\left(s,|s|^{\beta}\right) \cap B\left(s^{\prime},\left|s^{\prime}\right|^{\beta}\right)=\emptyset \quad \text { if } s, s^{\prime} \in S
$$

Combining the last two equations we find that

$$
\begin{equation*}
B\left(s, 2^{-\beta}|x|^{\beta}\right) \cap B\left(s^{\prime}, 2^{-\beta}|x|^{\beta}\right)=\emptyset \quad \text { if } s, s^{\prime} \in S \cap B(x, r) \tag{3.11}
\end{equation*}
$$

We also have

$$
\begin{equation*}
\bigcup_{s \in S \cap B(x, r)} B\left(s, 2^{-\beta}|x|^{\beta}\right) \subset B\left(x, r+2^{-\beta}|x|^{\beta}\right) . \tag{3.12}
\end{equation*}
$$

If $8|x|^{\beta} \leq r$ we have $r+2^{-\beta}|x|^{\beta} \leq r+2^{-\beta} r / 8 \leq 9 r / 8$. Hence

$$
\bigcup_{s \in S \cap B(x, r)} B\left(s, 2^{-\beta}|x|^{\beta}\right) \subset B\left(x, \frac{9}{8} r\right)
$$

in this case. Taking the measure on both sides and noting that by (3.11) the union on the left hand side is disjoint, we deduce that

$$
\pi 2^{-2 \beta}|x|^{2 \beta} \operatorname{card}(S \cap B(x, r)) \leq \pi \frac{81}{64} r^{2}
$$

so that

$$
\operatorname{card}(S \cap B(x, r)) \leq 2^{2 \beta} \frac{81}{64}|x|^{-2 \beta} r^{2}
$$

This proves the right inequality in (3.7).
If $r<8|x|^{\beta}$, then $r+2^{-\beta}|x|^{\beta} \leq 9|x|^{\beta}$. Then (3.12) yields that

$$
\bigcup_{s \in S \cap B(x, r)} B\left(s, 2^{-\beta}|x|^{\beta}\right) \subset B\left(x, 9|x|^{\beta}\right) .
$$

Taking the measure on both sides now yields that

$$
\operatorname{card}(S \cap B(x, r)) \leq 2^{2 \beta} 81
$$

and hence (3.8).
To prove the left inequality in (3.7), let $y \in B(x, r / 2)$. By the definition of $S$, there exists $s=s(y) \in S$ such that $|y-s| \leq|s|^{\beta}+(|y|+1)^{\beta}+1$. By (3.10) we have

$$
\begin{equation*}
|y-s| \leq|s|^{\beta}+\left(\frac{3}{2}|x|+1\right)^{\beta}+1 \tag{3.13}
\end{equation*}
$$

First we show that this implies that $|s| \leq 2|x|$ if $r_{0}$ is sufficiently large. To do so, suppose that $|s|>2|x|$. Using (3.10) again we find that

$$
|y-s| \geq|s|-|y| \geq|s|-\frac{3}{2}|x|>|s|-\frac{3}{4}|s|=\frac{1}{4}|s| .
$$

Together with (3.13) this yields that

$$
\frac{1}{4}|s| \leq|s|^{\beta}+\left(\frac{3}{2}|x|+1\right)^{\beta}+1<|s|^{\beta}+\left(\frac{3}{4}|s|+1\right)^{\beta}+1
$$

which is a contradiction if $r_{0}$ is large, since then $|x|$ and hence $|s|$ are also large. Hence we have $|s| \leq 2|x|$. It thus follows from (3.13) for large $r_{0}$ that

$$
\begin{equation*}
|y-s| \leq 2^{\beta}|x|^{\beta}+\left(\frac{3}{2}|x|+1\right)^{\beta}+1<4|x|^{\beta} \tag{3.14}
\end{equation*}
$$

Since we are assuming that $8|x|^{\beta}<r$ this implies that $|y-s|<r / 2$. Hence $s \in B(y, r / 2) \subset B(x, r)$. Altogether we have thus shown that for all $y \in B(x, r / 2)$ there exists $s=s(y) \in S \cap B(x, r)$ satisfying (3.14). Hence

$$
B\left(x, \frac{r}{2}\right) \subset \bigcup_{s \in S \cap B(x, r)} B\left(s, 4|x|^{\beta}\right)
$$

Considering the measure on both sides we obtain

$$
\pi \frac{r^{2}}{4} \leq \pi 16|x|^{2 \beta} \operatorname{card}(S \cap B(x, r))
$$

and hence the left inequality of (3.7).
It follows from (3.7) and (3.8) that (3.6) holds if $|x| \geq 2 r$. To prove (3.6) if $|x| \leq 2 r$ we introduce the notation $\operatorname{ann}\left(r_{1}, r_{2}\right):=\left\{x: r_{1} \leq|x| \leq r_{2}\right\}$ for an annulus. It is easy to see that ann $(2 r / 3,4 r / 3)$ can be covered by 8 disks of radius $r / 2$ and center on $\partial B(0, r)$. It thus follows from (3.7) that this annulus contains at most $12 r^{2-2 \beta}$ points of $S$. Replacing $4 r / 3$ by $r$ we find that

$$
\operatorname{card}\left(S \cap \operatorname{ann}\left(\frac{r}{2}, r\right)\right) \leq 12 r^{2-2 \beta}
$$

if $r \geq r_{0}$. It follows that

$$
\operatorname{card}\left(S \cap \operatorname{ann}\left(\frac{r}{2^{k+1}}, \frac{r}{2^{k}}\right)\right) \leq 12 \frac{r^{2-2 \beta}}{2^{(2-2 \beta) k}}
$$

for $k \in \mathbb{N}$ as long as $r / 2^{k} \geq r_{0}$. This implies that $\operatorname{card}(S \cap B(0, r)) \leq \alpha_{1} r^{2-2 \beta}$ with some constant $\alpha_{1}$ for $r \geq r_{0}$. For $|x| \leq 2 r$ we have $B(x, r) \subset B(0,3 r)$ and thus (3.6) follows with $\alpha_{0}=3^{2-2 \beta} \alpha_{1}$.
3.2. Characterization of $\mathcal{A}(f)$. For $m \in \mathbb{N}$ we put

$$
F_{m}= \begin{cases}H & \text { if } k \text { is odd } \\ G & \text { if } k \text { is even }\end{cases}
$$

and

$$
\begin{equation*}
h_{m}=F_{m} \circ F_{m-1} \circ \cdots \circ F_{1}, \tag{3.15}
\end{equation*}
$$

with $h_{0}=$ id. Then

$$
\begin{equation*}
h_{2 n}=f^{n} \quad \text { and } \quad h_{2 n+1}=H \circ f^{n} . \tag{3.16}
\end{equation*}
$$

It follows from the definition of $H$ that

$$
|H(x)| \leq|Z(x)| \leq \exp |x| \quad \text { for all } x \in \mathbb{R}^{3}
$$

while the definition of $G$ and (3.1) yield that

$$
|G(x)| \leq|Z(x)|+|x|+C \leq \exp |x|+|x|+C \quad \text { for all } x \in \mathbb{R}^{3} .
$$

For large $R$ we thus have

$$
M\left(R, F_{j}\right) \leq \exp R+R+C \leq \frac{1}{2} \exp (2 R)
$$

for all $j$ and hence

$$
\begin{equation*}
M\left(R, h_{m}\right) \leq \frac{1}{2} \exp ^{m}(2 R) \tag{3.17}
\end{equation*}
$$

On the other hand,

$$
|H(0,0, R)|=|Z(0,0, R)|=\exp R
$$

for all $R>0$ and

$$
|G(0,0, R)|=|Z(0,0, R)+(0,0, R)|=\exp R+R \geq \exp R
$$

for $R \geq L$. Thus

$$
\begin{equation*}
M\left(R, h_{m}\right) \geq \exp ^{m}(R) \tag{3.18}
\end{equation*}
$$

for $R \geq L$. In particular, it follows from (3.16), (3.17) and (3.18) that

$$
\exp ^{2 n}(R) \leq M^{n}(R, f) \leq \frac{1}{2} \exp ^{2 n}(2 R)
$$

for large $R$. Recalling that the definition of $\mathcal{A}(f)$ is independent of the choice of $R$ as long as $R>R_{0}$, it follows from the above considerations and the definition of $f$ that for all $R>0$ we have

$$
\begin{align*}
\mathcal{A}(f)=\left\{x \in \mathbb{R}^{3}:\right. & \text { there exists } L \in \mathbb{N} \text { such that }\left|f^{n+L}(x)\right| \geq \exp ^{2 n}(R) \\
& \text { and } \left.f^{n+L}(x) \in T \text { for all } n \in \mathbb{N}\right\} . \tag{3.19}
\end{align*}
$$

This easily yields that

$$
\begin{array}{r}
\mathcal{A}(f)=\left\{x \in \mathbb{R}^{3}: \text { there exists } L \in \mathbb{N} \text { such that }\left|h_{m+L}(x)\right| \geq \exp ^{m}(R)\right. \\
\text { for all } \left.m \in \mathbb{N} \text { and } h_{m+L}(x) \in T \text { if } m+L \text { is even }\right\} . \tag{3.20}
\end{array}
$$

The following result can easily be deduced from (3.20).
Lemma 3.3. Let $x \in \mathcal{A}(f)$ and $C>0$. Then $\left|h_{m}(x)\right| \geq\left|h_{m-1}(x)\right|^{C}$ for all large $m$. Moreover, $h_{m}(x)_{3} \rightarrow \infty$ as $m \rightarrow \infty$.

It follows from Lemma 3.3 that given $C>0$ there exists $M \in \mathbb{N}$ such that

$$
\prod_{j=M}^{m-1}\left|h_{j}(x)\right| \leq \prod_{j=M}^{m-1}\left|h_{m}(x)\right|^{C^{j-m}}=\left|h_{m}(x)\right|^{\gamma_{m}}
$$

for $m>M$, with

$$
\gamma_{m}=\sum_{j=M}^{m-1} C^{j-m}=\sum_{k=1}^{m-M} C^{-k} \leq \frac{1}{C-1} .
$$

It follows that if $x \in \mathcal{A}(f)$ and $\delta>0$, then

$$
\begin{equation*}
\prod_{j=1}^{m-1}\left|h_{j}(x)\right| \leq\left|h_{m}(x)\right|^{\delta} \tag{3.21}
\end{equation*}
$$

for all large $m$. It also follows from Lemma 3.3 that if $x \in \mathcal{A}(f)$ and $C>0$, then there exists $\delta>0$ such that

$$
\begin{equation*}
\left|h_{m}(x)\right| \geq \exp \left(\delta C^{m}\right) \tag{3.22}
\end{equation*}
$$

for all large $m$.
3.3. Estimates for the derivatives of $H$ and $G$. The derivative of a branch $\Lambda$ of the inverse of the "classical" Zorich map $Z$ introduced in $\S 2.1$ was estimated in $[3$, inequalities (2.6) and (2.7)]. It is easy to see that the inequalities obtained there also hold for the modified Zorich map $Z$ introduced by Nicks and Sixsmith. Thus there exist constants $\alpha_{1}, \alpha_{2}$ and $M$ such that for a branch $\Lambda$ of the inverse of $Z$ we have

$$
\frac{\alpha_{1}}{|x|} \leq \ell(D \Lambda(x)) \leq|D \Lambda(x)| \leq \frac{\alpha_{2}}{|x|} \quad \text { if } x \in \mathbb{H}_{\geq M},
$$

provided that the derivative exist, which is the case almost everywhere. Since

$$
D \Lambda(x)=D Z(\Lambda(x))^{-1}
$$

this yields that

$$
\begin{equation*}
\alpha_{1} \leq \frac{|Z(x)|}{|D Z(x)|} \leq \frac{|Z(x)|}{\ell(D Z(x))} \leq \alpha_{2} \quad \text { if } Z(x) \in \mathbb{H}_{\geq M} \tag{3.23}
\end{equation*}
$$

We may assume here that $\alpha_{1} \leq 1 \leq \alpha_{2}$.
The following lemma shows in particular that similar estimates hold for $H$ and $G$. Here $M$ is the constant from (3.23).
Lemma 3.4. Let $0<\sigma<\tau<1$. Then there exists $C_{1}, R>0$ with the following properties:

Let $F \in\{Z, H, G\}$, let $x \in \mathbb{R}^{3}$ and let $0<r \leq \sigma|F(x)|$ such that $F(x) \in \mathbb{H}_{\geq R}$ and

$$
\begin{equation*}
B(F(x), r) \subset \mathbb{H}_{\geq M} \tag{3.24}
\end{equation*}
$$

Let $U$ be the component of $F^{-1}(B(F(x), r))$ containing $x$. If $F=G$, suppose in addition that $|F(x)| \geq 3|x|$. Then

$$
\begin{equation*}
\underset{u \in U}{\operatorname{ess} \sup } \max \{|F(u)|,|D F(u)|\} \leq C_{1} \underset{u \in U}{\operatorname{ess} \inf } \min \{|F(u)|, \ell(D F(u))\} \tag{3.25}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{diam} U \leq 2 C_{1} \frac{r}{|F(x)|} \tag{3.26}
\end{equation*}
$$

The condition (3.24) is satisfied in particular if $F(x)_{3} \geq \tau|F(x)|$.

Proof. Suppose first that $F=Z$. For $u \in U$ we have $Z(u) \in \mathbb{H}_{\geq M}$ by (3.24) and

$$
(1-\sigma)|Z(x)| \leq|Z(x)|-r \leq|Z(u)| \leq|Z(x)|+r \leq(1+\sigma)|Z(x)| .
$$

Together with (3.23) we find that

$$
\max \{|Z(u)|,|D Z(u)|\} \leq \frac{1}{\alpha_{1}}|Z(u)| \leq \frac{1+\sigma}{\alpha_{1}}|Z(x)|
$$

while

$$
\min \{|Z(u)|, \ell(D Z(u))\} \geq \frac{1}{\alpha_{2}}|Z(u)| \geq \frac{1-\sigma}{\alpha_{2}}|Z(x)|
$$

if $D Z(u)$ exists. This yields (3.25) for $F=Z$ with $C_{1}=(1+\sigma) \alpha_{2} /\left((1-\sigma) \alpha_{1}\right)$.
It follows from this and the chain rule that (3.25) also holds for $F=H$, with a larger constant $C_{1}$, since $|D \varphi(x)| / \ell(D \varphi(x))$ is constant for all $x$ where $\varphi$ is differentiable. In fact, we have $|D \varphi(x)| / \ell(D \varphi(x))=(2+\sqrt{3}) /(2-\sqrt{3})$ for all such $x$.

To deal with the case that $F=G$ we note that by (3.1) we have $G(u)=Z(u)+u$ for $u \in U$, provided $R$ is sufficiently large. Hence

$$
\frac{1}{2}|D Z(u)| \leq|D Z(u)|-1 \leq|D G(u)| \leq|D Z(u)|+1 \leq 2|D Z(u)|
$$

and

$$
\frac{1}{2} \ell(D Z(u)) \leq \ell(D Z(u))-1 \leq \ell(D G(u)) \leq \ell(D(u))+1 \leq \ell(D Z(u))
$$

for $u \in U$. By hypothesis, $|G(x)| \geq 3|x|$. We deduce that $|Z(x)|=|G(x)+x| \geq 2|x|$ and hence $|Z(x)| / 2 \leq|G(x)| \leq 3|Z(x)| / 2$. It follows that

$$
\frac{1-\sigma}{2}|Z(x)| \leq(1-\sigma)|G(x)| \leq|G(u)| \leq(1+\sigma)|G(x)| \leq \frac{3}{2}(1+\sigma)|Z(x)|
$$

for $u \in U$. We deduce from the last three inequalities that (3.25) also holds for $F=G$ with some constant $C_{1}$.

To prove (3.26) let $v \in \partial U$ with $|v-x|=\max _{u \in \partial U}|u-x|$. Let $\Gamma$ be the straight line segment connecting $F(x)$ and $F(v)$ and let $\gamma$ be the curve in the closure of $U$ such that $\Gamma=F(\gamma)$. It follows from (3.25) that

$$
r=\operatorname{length}(\Gamma) \geq \operatorname{length}(\gamma) \underset{u \in U}{\operatorname{ess} \inf } \ell(D F(u)) \geq|v-x| \frac{|F(x)|}{C_{1}} \geq \frac{\operatorname{diam} U}{2 C_{1}}|F(x)|
$$

Now (3.26) follows.
To prove that (3.24) is satisfied if $F(x)_{3} \geq \tau|F(x)|$ we note that if this is the case and $w \in B(F(x), r)$, then $w_{3} \geq F(x)_{3}-r \geq(\tau-\sigma)|F(x)| \geq(\tau-\sigma) R$. Thus (3.24) follows for large $R$.

We apply Lemma 3.4 to the function $h_{m}$ defined by (3.15).
Lemma 3.5. Let $0<\sigma<\tau<1$. Then there exists $C_{1}, R>0$ with the following properties:

Let $m \in \mathbb{N}$, let $x \in \mathbb{R}^{3}$ and let $U$ be the component of $h_{m}^{-1}\left(B\left(h_{m}(x), \sigma\left|h_{m}(x)\right|\right)\right)$ containing $x$. Suppose that $h_{m}(x)_{3} \geq \tau\left|h_{m}(x)\right|$ and that $\left|h_{j}(x)\right| \geq 3\left|h_{j-1}(x)\right|$ and $h_{j}(x) \in \mathbb{H}_{\geq R}$ for $1 \leq j \leq m$. Then

$$
\underset{u \in U}{\operatorname{ess} \sup } \max \left\{\prod_{j=1}^{m}\left|h_{j}(u)\right|,\left|D h_{m}(u)\right|\right\} \leq C_{1}^{m} \underset{u \in U}{\operatorname{ess} \inf } \min \left\{\prod_{j=1}^{m}\left|h_{j}(u)\right|, \ell\left(D h_{m}(u)\right)\right\} .
$$

Proof. The chain rule implies that

$$
\prod_{j=1}^{m} \ell\left(D F_{j}\left(h_{j-1}(u)\right)\right) \leq \ell\left(D h_{m}(u)\right) \leq\left|D h_{m}(u)\right| \leq \prod_{j=1}^{m}\left|D F_{j}\left(h_{j-1}(u)\right)\right|
$$

provided the derivatives exist. The conclusion follows if we show that

$$
\begin{equation*}
\underset{w \in h_{j-1}(U)}{\operatorname{ess} \sup } \max \left\{\left|F_{j}(w)\right|,\left|D F_{j}(w)\right|\right\} \leq C_{1} \underset{w \in h_{j-1}(U)}{\operatorname{ess} \inf } \min \left\{\left|F_{j}(w)\right|, \ell\left(D F_{j}(w)\right)\right\} \tag{3.27}
\end{equation*}
$$

for $1 \leq j \leq m$. For $j=m$ this follows from (3.25), with $F=F_{m}$ and $r=\sigma\left|F_{m}(x)\right|$. For $1 \leq j \leq m-1$ it would also follow from (3.25) if we show that there exists $r \in\left(0, \sigma\left|h_{j}(x)\right|\right)$ such that

$$
\begin{equation*}
h_{j}(U) \subset B\left(h_{j}(x), r\right) \subset \mathbb{H}_{\geq M} . \tag{3.28}
\end{equation*}
$$

By (3.26) we have $h_{m-1}(U) \subset B\left(h_{m-1}(x), r\right)$ with $r=\operatorname{diam} h_{m-1}(U) \leq 2 C_{1} \sigma$. Thus $B\left(h_{m-1}(x), r\right) \subset \mathbb{H}_{\geq M}$ if $R$ is sufficiently large. Hence (3.28) holds for $j=m-1$. Inductively we see that (3.28) and hence (3.27) also hold for $1 \leq j \leq m-2$.

## 4. Proof of Theorem 1.1

4.1. The upper bound for the dimension. We may assume that $\rho<3$ since otherwise there is nothing to prove. Fix a (large) number $R$ and let $\mathcal{A}_{R}(f)$ be the set of all $x \in T \cap \mathbb{H}_{\geq R}$ such that $h_{m}(x) \in \mathbb{H}_{\geq R},\left|h_{m}(x)\right| \geq \exp ^{m}(R)$ and $\left|h_{m}(x)\right| \geq 3\left|h_{m-1}(x)\right|$ for all $m \in \mathbb{N}$, as well as $h_{m}(x) \in T$ for all even $m$. It follows from (3.19) and (3.20) that $\mathcal{A}(f)=\bigcup_{n=0}^{\infty} f^{-n}\left(\mathcal{A}_{R}(f)\right)$. Since $f$ is locally bi-Lipschitz, it suffices to show that $\operatorname{dim} \mathcal{A}_{R}(f) \leq \rho$ for all $L$.

We will do so using Lemma 2.2. So let $x \in \mathcal{A}_{R}(f)$. It follows from (3.3) that if $m$ is even, then $h_{m}(x)$ is contained in the domain $\Omega$ defined by (3.2). This implies that

$$
\left|h_{m}(x)\right| \leq 2 h_{m}(x)_{3} .
$$

Choose $t>0$ large enough and put

$$
K_{m}=B\left(h_{m}(x), \frac{1}{4}\left|h_{m}(x)\right|\right)
$$

and let $U_{m}(x)$ be the component of $h_{m}^{-1}\left(K_{m}\right)$ that contains $x$. We now define $r_{m}(x)=\operatorname{dist}\left(x, \partial U_{m}(x)\right)$ so that $B\left(x, r_{m}(x)\right) \subset U_{m}(x)$. Let $y_{m} \in \partial U_{m}(x)$ with $\left|y_{m}-x\right|=r_{m}(x)$ and let $\gamma$ be the straight line segment connecting $x$ and $y_{m}$. Then $h_{m}(\gamma)$ connects $h_{m}(x)$ with $\partial K_{m}$. Lemma 3.5 yields that

$$
\frac{1}{4}\left|h_{m}(x)\right| \leq \operatorname{length}\left(h_{m}(\gamma)\right) \leq \operatorname{length}(\gamma) \underset{y \in U_{m}(x)}{\operatorname{esssup}}\left|D h_{m}(y)\right| \leq r_{m}(x) C_{1}^{m} \prod_{j=1}^{m}\left|h_{j}(x)\right| .
$$

Thus

$$
\begin{equation*}
r_{m}(x) \geq \frac{C_{1}^{-m}}{4 \prod_{j=1}^{m-1}\left|h_{j}(x)\right|} . \tag{4.1}
\end{equation*}
$$

If $s=\left(s_{1}, s_{2}\right) \in S$ and if $T(s)$ intersects $K_{m}$, then

$$
\begin{equation*}
\left|\left(h_{m}(x)_{1}, h_{m}(x)_{2}\right)-\left(s_{1}, s_{2}\right)\right| \leq \frac{1}{4}\left|h_{m}(x)\right|+\sqrt{2} \leq\left|h_{m}(x)\right| \tag{4.2}
\end{equation*}
$$

provided $R$ is chosen sufficiently large. Suppose that $\rho>1$. Then $0<\beta<1$ by (3.5) and it follows from (3.6) and (4.2) that

$$
\begin{equation*}
\left.\operatorname{card}\left\{s \in S: T(s) \cap K_{m}\right) \neq \emptyset\right\} \leq \alpha_{0}\left|h_{m}(x)\right|^{2-2 \beta} \tag{4.3}
\end{equation*}
$$

But if $\rho=1$ so that $\beta=1$, then $S=\{(0,0)\}$ and hence $\operatorname{card} S=1$. Thus (4.3) holds trivially also in this case, assuming that $\alpha_{0} \geq 1$.

For each $s$ we can cover $T(s) \cap K_{m}$ by $M$ cubes of sidelength 2 , where

$$
M \leq \frac{1}{2}\left|h_{m}(x)\right|+1 \leq\left|h_{m}(x)\right| .
$$

It follows from the last two inequalities that $T \cap K_{m}$ can be covered by $N_{m}(x)$ cubes of sidelength 2 , where

$$
\begin{equation*}
N_{m}(x) \leq\left|h_{m}(x)\right|^{3-2 \beta}=\left|h_{m}(x)\right|^{\rho} . \tag{4.4}
\end{equation*}
$$

Let $W$ be the image of such a cube under the inverse $\varphi: K_{m} \rightarrow U_{m}(x)$ of the map $h_{m}: U_{m}(x) \rightarrow K_{m}$. As these cubes have diameter $2 \sqrt{3}$, Lemma 3.5 yields that

$$
\operatorname{diam} W \leq d_{m}(x)
$$

where

$$
\begin{equation*}
d_{m}(x):=2 \sqrt{3} \underset{y \in K_{m}}{\operatorname{ess} \sup }|D \varphi(y)|=\frac{2 \sqrt{3}}{\underset{z \in U_{m}(x)}{\operatorname{ess} \inf } \ell\left(D h_{m}(z)\right)} \leq \frac{2 \sqrt{3} C_{1}^{m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|} \tag{4.5}
\end{equation*}
$$

To summarize we see that $B\left(x, r_{m}(x)\right) \cap \mathcal{A}_{R}(f)$ can be covered by $N_{m}(x)$ sets of diameter at most $d_{m}(x)$, where $r_{m}(x), N_{m}(x)$ and $d_{m}(x)$ satisfy (4.1), (4.4) and (4.5), respectively. In order to apply Lemma 2.2 , let $\varepsilon>0$. We deduce that

$$
\begin{aligned}
\frac{N_{m}(x) d_{m}(x)^{\rho+\varepsilon}}{r_{m}(x)^{3}} & \leq\left|h_{m}(x)\right|^{\rho}\left(\frac{2 \sqrt{3} C_{1}^{m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|}\right)^{\rho+\varepsilon}\left(\frac{4 \prod_{j=1}^{m-1}\left|h_{j}(x)\right|}{C_{1}^{-m}}\right)^{3} \\
& =4^{3} \cdot(2 \sqrt{3})^{\rho+\varepsilon} C_{1}^{(3+\rho+\varepsilon) m}\left|h_{m}(x)\right|^{-\varepsilon}\left(\prod_{j=1}^{m-1}\left|h_{j}(x)\right|\right)^{3-\rho-\varepsilon}
\end{aligned}
$$

It follows from (3.21) and (3.22) that the right hand side is less than 1 for large $m$. Lemma 2.2 now yields that $\operatorname{dim} \mathcal{A}_{R}(f) \leq \rho+\varepsilon$. Since $\varepsilon$ can be taken arbitrarily small, we conclude that $\operatorname{dim} \mathcal{A}_{R}(f) \leq \rho$ and hence that $\operatorname{dim} \mathcal{A}(f) \leq \rho$.
4.2. Nested sets. To estimate $\operatorname{dim} \mathcal{A}(f)$ from below we will construct a subset of $\mathcal{A}(f)$ as follows. For $m \in \mathbb{N}$ we construct a collection $\mathcal{E}_{m}$ of disjoint compact subsets of $\mathbb{R}^{3}$ with the property that every element of $\mathcal{E}_{m+1}$ is contained in a unique element of $\mathcal{E}_{m}$. Conversely, every element of $\mathcal{E}_{m}$ contains at least one element of $\mathcal{E}_{m+1}$. Put

$$
E_{m}=\bigcup_{V \in \mathcal{E}_{m}} V \quad \text { and } \quad E=\bigcap_{m=1}^{\infty} E_{m} .
$$

The construction will me made in such a way that $E \subset \mathcal{A}(f)$.
McMullen [23] used Lemma 2.1 to give a lower bound for the dimension of a set $E$ constructed this way in terms of $\sup _{V \in \mathcal{E}_{m}} \operatorname{diam} V$ and $\inf { }_{V \in \mathcal{E}_{m}} \operatorname{dens}\left(E_{m+1}, V\right)$.

Adapting some ideas from [11], we will instead work with bounds for $\operatorname{diam} V$ and dens $\left(E_{m+1}, V\right)$ which depend not only on $m$, but also on $V$.

We will choose the sets $\mathcal{E}_{m}$ such that $h_{m}$ maps the elements of $\mathcal{E}_{m}$ bijectively onto a closed ball of the form $K(t)=\bar{B}((0,0, t), t / 2)$ for some large $t$, say $t \geq R$. Various conditions imposed later will require that $R$ is sufficiently large. We will also consider the box

$$
Q(t)=\left\{x \in K(t): \frac{t}{6} \leq x_{1} \leq \frac{t}{4}, \frac{t}{6} \leq x_{2} \leq \frac{t}{4},\left|x_{3}-t\right| \leq \frac{t}{4}\right\}
$$

Note that $Q(t) \subset K(t)$. The advantage of considering $Q(t)$ will be that points in $Q(t)$ have a definite distance from $\partial K(t)$ and that two beams $T(s)$ and $T\left(s^{\prime}\right)$ intersecting $Q(t)$ are a certain distance apart.

Put $\eta(r)=\log \log r$ and, for $2 \leq k \in \mathbb{N}$ and $s \in S$,

$$
p(s, k)=\left(2 s_{1}, 2 s_{2}, k \eta(k)\right) .
$$

Let $P_{H}(s, k)$ be the component of $H^{-1}\left(K\left(H(p(s, k))_{3}\right)\right)$ containing $p(s, k)$. Here $H(p(s, k))_{3}$ denotes the third component of $H(p(s, k))$. Note that since $\varphi(p(s, k))=$ $\left(2 s_{1}, 2 s_{2}, k \eta(k)-2\left|s_{1}\right|-2\left|s_{2}\right|\right)$ we have $H(p(s, k))=\left(0,0, \exp \left(k \eta(k)-2\left|s_{1}\right|-2\left|s_{2}\right|\right)\right)$ so that $\left.H(p(s, k))_{3}=\exp \left(k \eta(k)-2\left|s_{1}\right|-2\left|s_{2}\right|\right)\right)$. Note that $P_{H}(s, k) \cap P_{H}\left(s^{\prime}, k^{\prime}\right)=\emptyset$ if $(s, k) \neq\left(s^{\prime}, k^{\prime}\right)$, assuming that $k$ and $k^{\prime}$ are large enough.

For large $t$ we consider the set $\mathcal{U}_{H}(t)$ of all $P_{H}(s, k)$ which are contained in $Q(t)$. Note that if $P_{H}(s, k) \in \mathcal{U}_{H}(t)$, then, in particular, $p(s, k) \in Q(t)$. This yields that $2\left|s_{i}\right| \leq t / 4$ for $i \in\{1,2\}$ while $k \eta(k) \geq 3 t / 4$. We deduce that

$$
\begin{equation*}
k \eta(k) \geq 3\left(\left|s_{1}\right|+\left|s_{2}\right|\right) . \tag{4.6}
\end{equation*}
$$

This yields that $k \eta(k)-2\left|s_{1}\right|-2\left|s_{2}\right| \geq k \eta(k) / 3$ and $|p(s, k)| \leq 5 k \eta(k) / 3$. Thus

$$
\begin{align*}
|H(p(s, k))| & =\exp \left(k \eta(k)-2\left|s_{1}\right|-2\left|s_{2}\right|\right) \\
& \geq \exp \left(\frac{1}{3} k \eta(k)\right) \geq \exp \left(\frac{1}{5}|p(s, k)|\right) . \tag{4.7}
\end{align*}
$$

Analogous definitions are made with $G$ instead of $H$. Thus we define $P_{G}(s, k)$ as the component of $G^{-1}\left(K\left(G(p(s, k))_{3}\right)\right)$ that contains $p(s, k)$. Note here that is not difficult to see that $G(p(s, k)) \in K\left(G(p(s, k))_{3}\right)$ if $k$ is sufficiently large; see Remark 4.2 below. Again the $P_{G}(s, k)$ are pairwise disjoint. Also, we define $\mathcal{U}_{G}(t)$ as the set of all $P_{G}(s, k)$ which are contained in $Q(t)$.

Since $G(p(s, k))_{3}=k \eta(k)+\exp (k \eta(k))$ we have

$$
\begin{equation*}
|G(p(s, k))| \geq \exp (k \eta(k)) \geq \exp \left(\frac{3}{5}|p(s, k)|\right) \tag{4.8}
\end{equation*}
$$

It follows from the above definitions that if $F \in\{G, H\}$ and $P \in \mathcal{U}_{F}(t)$, then $F(P)$ is a ball and $F: P \rightarrow F(P)$ is bijective.

For large $t$ and $F \in\{G, H\}$ we put

$$
U_{F}(t)=\bigcup_{P \in \mathcal{U}_{H}(t)} P
$$

For some large $R$ we put $K_{0}=K(R)$,

$$
\mathcal{E}_{0}=\left\{K_{0}\right\} \quad \text { and } \quad \mathcal{E}_{1}=\mathcal{U}_{H}(R) .
$$

Suppose now that $m \in \mathbb{N}$ and that $\mathcal{E}_{m}$ has been defined. Let $V \in \mathcal{E}_{m}$. Then we have $h_{m}(V)=K\left(t_{V}\right)$ for some $t_{V}>R$ and $h_{m}: V \rightarrow K\left(t_{V}\right)$ is bijective. Let $\varphi: K\left(t_{V}\right) \rightarrow V$ be the inverse of this map. We put

$$
\mathcal{E}_{m+1}(V)=\left\{\varphi(P): P \in \mathcal{U}_{F_{m+1}}\left(t_{V}\right)\right\}= \begin{cases}\left\{\varphi(P): P \in \mathcal{U}_{G}\left(t_{V}\right)\right\} & \text { if } m \text { is odd } \\ \left\{\varphi(P): P \in \mathcal{U}_{H}\left(t_{V}\right)\right\} & \text { if } m \text { is even }\end{cases}
$$

and

$$
\mathcal{E}_{m+1}=\bigcup_{V \in \mathcal{E}_{m}} \mathcal{E}_{m+1}(V)
$$

Following [23] we construct a probability measure $\mu$ supported on $E$. In order to do so, we define a sequence $\left(\mu_{m}\right)$ of probability measures inductively. Here $\mu_{m}$ is supported on $E_{m}$, and the restriction of $\mu_{m}$ to an element of $\mathcal{E}_{m}$ is a rescaled Lebesgue measure.

First we define $\mu_{0}$ as the Lebesgue measure on $K_{0}$, rescaled so that $\mu_{0}\left(K_{0}\right)=1$. Thus $\mu_{0}(A)=\operatorname{meas}\left(A \cap K_{0}\right) /$ meas $K_{0}$. Let $m \geq 0$ and suppose that the measure $\mu_{m}$ has been defined. To define the measure $\mu_{m+1}$ it suffices to specify $\mu_{m+1}(W)$ for $W \in \mathcal{E}_{m+1}$. For such $W$ there exists $V \in \mathcal{E}_{m}$ with $W \subset V$. We put

$$
\mu_{m+1}(W)=\frac{\mu_{m}(W)}{\operatorname{dens}\left(E_{m+1}, V\right)}
$$

Note that for $V \in \mathcal{E}_{m}$ we have

$$
\begin{aligned}
\mu_{m+1}(V) & =\sum_{W \in \mathcal{\mathcal { E } _ { m + 1 }}(V)} \mu_{m+1}(W)=\frac{1}{\operatorname{dens}\left(E_{m+1}, V\right)} \sum_{W \in \mathcal{\mathcal { E } _ { m + 1 }}(V)} \mu_{m}(W) \\
& =\frac{1}{\operatorname{dens}\left(E_{m+1}, V\right)} \mu_{m}\left(V \cap E_{m+1}\right)=\mu_{m}(V)
\end{aligned}
$$

We conclude that

$$
\mu_{n}(V)=\mu_{m}(V) \quad \text { for } n \geq m, V \in \mathcal{E}_{m}
$$

Let $\mu$ be a weak limit of the sequence $\left(\mu_{m}\right)$. Then $\mu$ is a probability measure supported on $E$ such that

$$
\mu(V)=\mu_{m}(V) \quad \text { for } V \in \mathcal{E}_{m}
$$

4.3. Estimates for the sets in $\mathcal{E}_{m}$. As already mentioned, we will estimate $\operatorname{diam} V$ and $\operatorname{dens}\left(E_{m+1}, V\right)$ for $V \in \mathcal{E}_{m}$.

Lemma 4.1. There exist $C_{2}, C_{3}, R>0$ such that if $F \in\{G, H\}, t \geq R$ and $P \in \mathcal{U}_{H}(t)$, then

$$
\begin{equation*}
\operatorname{diam} P \leq C_{2} \tag{4.9}
\end{equation*}
$$

and

$$
\begin{equation*}
\text { meas } P \geq C_{3} \text {. } \tag{4.10}
\end{equation*}
$$

Proof. Let $P=P_{F}(s, k)$, with $s \in S$ and $k \in \mathbb{N}$. Put $q=F(p(s, k))_{3}$ and $a=$ $(0,0, q)$. Then $F(P)=B(a, q / 2)$.

If $F=H$, then $F(p(s, k))=a$ and thus $|F(p(s, k))|=q$. If $F=G$, then $F(p(s, k))=\left(2 s_{1}, 2 s_{2}, q\right)$. Using (4.6) we can deduce that

$$
q=k \eta(k)+\exp (k \eta(k)) \geq 20\left(\left|s_{1}\right|+\left|s_{2}\right|\right)
$$

if $R$ and hence $k$ are sufficiently large. Hence

$$
\begin{equation*}
\frac{9 q}{10} \leq q-2\left(\left|s_{1}\right|+2\left|s_{2}\right|\right) \leq|F(p(s, k))| \leq q+2\left(\left|s_{1}\right|+\left|s_{2}\right|\right) \leq \frac{11 q}{10} \tag{4.11}
\end{equation*}
$$

as well as

$$
\begin{equation*}
|F(p(s, k))-a|=\left|\left(2 s_{1}, 2 s_{2}, 0\right)\right| \leq \frac{q}{10} \tag{4.12}
\end{equation*}
$$

for large $k$. It follows from the last two inequalities that

$$
F(P)=B\left(a, \frac{q}{2}\right) \subset B\left(F(p(s, k)), \frac{3 q}{5}\right) \subset B\left(F(p(s, k)), \frac{2}{3}|F(p(s, k))|\right)
$$

Since $F(p(s, k))_{3}=q \geq 10|F(p(s, k))| / 11$ by (4.11) we may apply Lemma 3.4 with $\tau=10 / 11$ and $\sigma=2 / 3$. We deduce from (3.26) that (4.9) follows with $C_{2}=4 C_{1} / 3$.

It also follows from (4.12) that

$$
\operatorname{dist}(F(p(s, k)), \partial F(P)) \geq \frac{2 q}{5} .
$$

Let $\gamma$ be the line segment connecting $p(s, k)$ with the closest point on $\partial P$. Thus length $(\gamma)=\operatorname{dist}(p(s, k), \partial P)$. Recalling that $F$ is injective on $P$ we find that $F \circ \gamma$ is a curve connecting $F(p(s, k)$ ) with $\partial F(P)$. Together with Lemma 3.5 it follows that

$$
\begin{aligned}
\frac{2 q}{5} & \leq \operatorname{length}(F \circ \gamma) \leq \underset{x \in P}{\operatorname{ess} \sup }|D F(x)| \cdot \operatorname{length}(\gamma) \\
& \leq C_{1}|F(p(s, k))| \operatorname{dist}(p(s, k), \partial P)
\end{aligned}
$$

Since $|H(p(s, k))|=q$ we see that the estimate $|F(p(s, k))| \leq 11 q / 10$ given in (4.11) is valid not only for $F=G$ but trivially also holds for $F=H$. Thus $\operatorname{dist}(p(s, k), \partial P) \geq 4 /\left(11 C_{1}\right)$. This yields (4.10) with $C_{3}=4^{4} \pi /\left(3 \cdot\left(11 C_{1}\right)^{3}\right)$.

Remark 4.2. It follows in particular from (4.12) that $F(p(s, k)) \in K\left(F(p(s, k))_{3}\right)$ if $k$ is sufficiently large. Of course this is clear if $F=H$, but (4.12) shows that it also holds for $F=G$ if $R$ is large enough.

It follows from (4.7), (4.8) and (4.9) that if $x \in P_{F}(s, k) \in \mathcal{U}_{F}(t)$ for some $t \geq R$ and $F \in\{G, H\}$, then

$$
|F(x)| \geq \frac{1}{2}|F(p(s, k))| \geq \exp \left(\frac{1}{5}|p(s, k)|\right) \geq \exp \left(\frac{1}{5}|x|-C_{2}\right) \geq 6 \exp \left(\frac{1}{6}|x|\right)
$$

provided $R$ and hence $k$ are sufficiently large. It follows that

$$
\begin{equation*}
\left|h_{m}(x)\right| \geq 6 \exp ^{m}\left(\frac{1}{6}|x|\right) \tag{4.13}
\end{equation*}
$$

for $x \in E$, if $R$ is chosen sufficiently large. Thus $E \subset \mathcal{A}(f)$ by (3.20).

Lemma 4.3. There exists $C_{4}, C_{5}, C_{6}, R>0$ such that if $F \in\{G, H\}$ and $t \geq R$, then

$$
\begin{equation*}
\operatorname{card} \mathcal{U}_{F}(t) \geq C_{4} \frac{t^{\rho}}{\eta(t)} \tag{4.14}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{dens}\left(U_{F}(t), K(t)\right) \geq C_{5} \frac{t^{\rho-3}}{\eta(t)} \tag{4.15}
\end{equation*}
$$

If $x \in Q(t)$, then

$$
\operatorname{card}\left\{P \in \mathcal{U}_{F}(t): P \cap B(x, \tau) \neq \emptyset\right\} \leq \begin{cases}C_{6}(\tau+1) & \text { if } \tau \leq t^{\beta}  \tag{4.16}\\ C_{6} \tau^{\rho} & \text { if } \tau>t^{\beta}\end{cases}
$$

with $\beta$ defined by (3.5). In particular

$$
\begin{equation*}
\operatorname{card} \mathcal{U}_{F}(t) \leq C_{6}(2 t)^{\rho} \tag{4.17}
\end{equation*}
$$

Moreover, if $P, P^{\prime} \in \mathcal{U}_{F}(t)$, then

$$
\begin{equation*}
\operatorname{dist}\left(P, P^{\prime}\right) \geq \frac{1}{4} \eta(t) \tag{4.18}
\end{equation*}
$$

Proof. Recall that $B_{2}\left(\left(x_{1}, x_{2}\right), r\right)$ denotes the planar disk centred at $\left(x_{1}, x_{2}\right)$ and of radius $r$. Assuming that $R$ is large, it follows from (4.9) that if

$$
\begin{equation*}
s \in B_{2}\left(\frac{1}{5}(t, t), \frac{t}{31}\right) \subset B_{2}\left(\frac{1}{5}(t, t), \frac{t}{30}-C_{2}\right) \tag{4.19}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{3 t}{4}+C_{2} \leq k \eta(k) \leq \frac{5 t}{4}-C_{2} \tag{4.20}
\end{equation*}
$$

then $P_{F}(s, k) \subset Q(t)$ and thus $P_{F}(s, k) \in \mathcal{U}_{F}(t)$. By (3.7), the cardinality of the set of all $s \in S$ satisfying (4.19) is at least

$$
\begin{equation*}
\frac{1}{64}\left(\frac{\sqrt{2} t}{5}\right)^{-2 \beta} \frac{t^{2}}{31^{2}}=\frac{2^{-\beta}}{64 \cdot 5^{-2 \beta} \cdot 31^{2}} \cdot t^{2-2 \beta} \tag{4.21}
\end{equation*}
$$

provided $t$ is sufficiently large.
To estimate the cardinality of the set of all $k$ satisfying (4.20) we claim that (4.20) is satisfied if

$$
\begin{equation*}
\left(\frac{3 t}{4}+C_{2}\right) \frac{1}{\eta(t)-1} \leq k \leq\left(\frac{5 t}{4}-C_{2}\right) \frac{1}{\eta(t)} \tag{4.22}
\end{equation*}
$$

To see this note that (4.22) implies that $\sqrt{t} \leq k \leq t$ and thus $\eta(t)-1 \leq \eta(k) \leq \eta(t)$. Using (4.9) we can now deduce (4.20) from (4.22).

The cardinality of the set of all $k \in \mathbb{N}$ which satisfy (4.22) and hence also (4.20) is at least

$$
\begin{equation*}
\frac{1}{3} \frac{t}{\eta(t)} \tag{4.23}
\end{equation*}
$$

provided $t$ is sufficiently large. Combining the bounds (4.21) and (4.23) we find that

$$
\operatorname{card} \mathcal{U}_{F}(t) \geq \frac{2^{-\beta}}{3 \cdot 64 \cdot 5^{-2 \beta} \cdot 31^{2}} \frac{t^{3-2 \beta}}{\eta(t)}
$$

for large $t$. Now (4.14) follows from (3.5).
Combining (4.14) with (4.10) we obtain (4.15) with $C_{5}=C_{3} C_{4} /(6 \pi)$.
To prove (4.16) let $x \in Q(t)$. Arguments similar to the ones used to obtain (4.19) and (4.20) show that if $P_{F}(s, k) \in \mathcal{U}_{F}(t)$ with $P_{F}(s, k) \cap B(x, \tau) \neq \emptyset$, then

$$
\begin{equation*}
s \in B_{2}\left(\left(x_{1}, x_{2}\right), \tau+C_{2}\right) \tag{4.24}
\end{equation*}
$$

and

$$
\left|k \eta(k)-x_{3}\right| \leq \tau+C_{2}
$$

By the definition of $Q(t)$ we have

$$
\begin{equation*}
\frac{t}{6} \leq\left|\left(x_{1}, x_{2}\right)\right| \leq|x| \leq 2 t \tag{4.25}
\end{equation*}
$$

Suppose first that $t^{\beta} \leq \tau \leq t / 24$. Then, provided $R$ is large enough, $\tau+C_{2} \leq 2 \tau$ and hence $B_{2}\left(\left(x_{1}, x_{2}\right), \tau+C_{2}\right) \subset B_{2}\left(\left(x_{1}, x_{2}\right), 2 \tau\right)$. Since $2 \tau \leq t / 12 \leq 2\left|\left(x_{1}, x_{2}\right)\right|$ we can use (3.7) and (3.9) to bound the cardinality of $S \cap B_{2}\left(\left(x_{1}, x_{2}\right), 2 \tau\right)$. This is bigger than the cardinality $N_{1}$ of the set of all $s \in S$ satisfying (4.24). Thus

$$
N_{1} \leq 324\left|\left(x_{1}, x_{2}\right)\right|^{-2 \beta}(2 \tau)^{2} \leq 324 \cdot 6^{2 \beta} \cdot 4 t^{-2 \beta} \tau^{2}
$$

Suppose next that $\tau \geq t / 24$. Then $N_{1} \leq \alpha_{0}(2 \tau)^{2-2 \beta} \leq \alpha_{0} 2^{2-2 \beta} 24^{2 \beta} t^{-2 \beta} \tau^{2}$ by (3.6). Suppose finally that $\tau \leq t^{\beta}$. Then $\tau+C_{2} \leq t^{\beta}+C_{2} \leq 6^{\beta}|x|^{\beta}+C_{2} \leq 8|x|^{\beta}$ for large $R$ by (4.25). Now (3.8) yields that $N_{1} \leq 324$. Altogether it follows that there exists $C_{6}>0$ such that

4 N_{1} \leq \begin{cases}C_{6} & \text { if } \tau \leq t^{\beta}  \tag{4.26}\\ C_{6} t^{-2 \beta} \tau^{2} & \text { if } t^{\beta} \leq \tau\end{cases}
$$

For $s \in S$ we now consider the cardinality $N_{2}(s)$ of the set of all $k$ such that $P_{F}(s, k)$ intersects $B(x, \tau)$. Since

(k+1) \eta(k+1)-k \eta(k) \geq \eta(k) \geq \eta(t)-1 \geq \frac{1}{2} \eta(t) \tag{4.27}
\end{equation*}
$$

if $P_{F}(s, k) \in \mathcal{U}_{F}(t)$ we deduce from (4.9) that

$$
\begin{equation*}
N_{2}(s) \leq N_{2}:=\frac{4\left(\tau+C_{2}\right)}{\eta(t)}+1 \tag{4.28}
\end{equation*}
$$

Combining the above estimates we obtain

$$
\begin{equation*}
\operatorname{card}\left\{P \in \mathcal{U}_{F}(t): P \cap B(x, \tau) \neq \emptyset\right\} \leq N_{1} N_{2} \tag{4.29}
\end{equation*}
$$

Suppose that $\tau \leq t^{\beta}$. Noting that (4.28) yields that $N_{2} \leq \tau+2$ we obtain (4.16) from (4.29) and (4.26).

Suppose next that $\tau>t^{\beta}$. Since $Q(t) \subset K(t) \subset B(x, 2 t)$ we may assume that $\tau \leq 2 t$. By (4.28) we have $N_{2} \leq \tau$ for large $t$. Together with (4.29) and (4.26) this yields that

$$
\operatorname{card}\left\{P \in \mathcal{U}_{F}(t): P \cap B(x, \tau) \neq \emptyset\right\} \leq \frac{1}{4} C_{6} t^{-2 \beta} \tau^{3}=\frac{1}{4} C_{6}\left(\frac{\tau}{t}\right)^{2 \beta} \tau^{\rho} \leq C_{6} \tau^{\rho}
$$

So we obtain (4.16) also in this case. Since, as already mentioned, $Q(t) \subset B(x, 2 t)$, this also yields (4.17).

Finally, (4.18) follows from (4.9) and (4.27), provided $R$ is large enough.
Let $x \in E$. Then $x \in E_{m}$ for all $m \in \mathbb{N}$ and thus there exists $V_{m}(x) \in \mathcal{E}_{m}$ such that $x \in V_{m}(x)$. Recall that by the definition of $\mathcal{E}_{m}$ we have

$$
\begin{equation*}
h_{m}\left(V_{m}(x)\right)=K\left(t_{m}\right), \tag{4.30}
\end{equation*}
$$

for some $t_{m}>R$ satisfying $t_{m} \rightarrow \infty$ as $m \rightarrow \infty$. It is easy to see that $t_{m} / 2 \leq$ $\left|h_{m}(x)\right| \leq 2 t_{m}$.
Lemma 4.4. There exists $C_{7}>0$ such that

\operatorname{dens}\left(E_{m+1}, V_{m}(x)\right) \geq C_{7}^{m} \frac{\left|h_{m}(x)\right|^{\rho-3}}{\eta\left(\left|h_{m}(x)\right|\right)}
$$

Proof. With $h_{m}\left(V_{m}(x)\right)=K\left(t_{m}\right)$ it follows from Lemma 2.3, Lemma 3.4 and (4.15) that

$$
\left.\operatorname{dens}\left(E_{m+1}, V_{m}(x)\right) \geq C_{1}^{-3 m} \operatorname{dens}\left(U_{F_{m+1}}\left(t_{m}\right), K\left(t_{m}\right)\right)\right) \geq C_{1}^{-3 m} C_{5} \frac{t_{m}^{\rho-3}}{\eta\left(t_{m}\right)}
$$

The conclusion now follows since $t_{m} \leq 2\left|h_{m}(x)\right|$ and $\eta\left(2 t_{m}\right) \leq 2 \eta\left(t_{m}\right)$.
Lemma 4.5. There exists $C_{8}>0$ such that if $W \in \mathcal{E}_{m+1}\left(V_{m}(x)\right)$, then

$$
\begin{equation*}
C_{8}^{-m} \leq \operatorname{diam} W \cdot \prod_{j=1}^{m}\left|h_{j}(x)\right| \leq C_{8}^{m} . \tag{4.31}
\end{equation*}
$$

In particular, it follows from Lemma 4.5 that

$$
\begin{equation*}
\frac{C_{8}^{-m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|} \leq \operatorname{diam} V_{m+1}(x) \leq \frac{C_{8}^{m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|} \tag{4.32}
\end{equation*}
$$

Proof of Lemma 4.5. We have $h_{m}\left(V_{m}(x)\right)=K\left(t_{m}\right)$. Let $\varphi: K\left(t_{m}\right) \rightarrow V_{m}(x)$ be the inverse function of $h_{m}: V_{m}(x) \rightarrow K\left(t_{m}\right)$. Each $W \in \mathcal{E}_{m+1}\left(V_{m}(x)\right)$ is of the form $W=\varphi(P)$ for some $P \in \mathcal{U}_{F_{m+1}}\left(t_{m}\right)$. It follows that

$$
\operatorname{diam} W \leq \underset{y \in K\left(t_{m}\right)}{\operatorname{ess} \sup _{2}}|D \varphi(y)| \cdot \operatorname{diam} P=\frac{\operatorname{diam} P}{\underset{w \in V_{m}(x)}{\operatorname{ess} \inf } \ell\left(D h_{m}(w)\right)}
$$

Lemma 3.5 and (4.9) now yield that

$$
\operatorname{diam} W \leq \frac{C_{2} C_{1}^{m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|},
$$

from which the right inequality in (4.31) follows for a suitable $C_{8}>0$.

To prove the left inequality we proceed analogously, considering the measure of $W$ instead of its diameter. We have

$$
\text { meas } W \geq \underset{y \in K\left(t_{m}\right)}{\operatorname{ess} \inf } \ell(D \varphi(y))^{3} \cdot \text { meas } P=\frac{\text { meas } P}{\substack{\operatorname{ess} s u p \\ w \in V_{m}(x)}}\left|D h_{m}(w)\right|^{3} .
$$

Lemma 3.5 and (4.10) now imply that

$$
\text { meas } W \geq \frac{C_{3} C_{1}^{3 m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|^{3}}
$$

Adjusting the value of $C_{8}$ if necessary we obtain the left inequality in (4.31).
Lemma 4.6. Let $W, W^{\prime} \in \mathcal{E}_{m+1}\left(V_{m}(x)\right)$. Then

$$
\operatorname{dist}\left(W, W^{\prime}\right) \geq \operatorname{diam} W
$$

Proof. Let $P=h_{m}(W)$ and $P^{\prime}=h_{m}\left(W^{\prime}\right)$. With $h_{m}\left(V_{m}(x)\right)=K\left(t_{m}\right)$ we then have $P, P^{\prime} \in \mathcal{U}_{F_{m+1}}\left(t_{m}\right)$. Let $\gamma$ be a straight line segment connecting $W$ and $W^{\prime}$ such that length $(\gamma)=\operatorname{dist}\left(W, W^{\prime}\right)$. First we assume that $\gamma \subset V_{m}(x)$. It then follows from Lemma 4.5 and the arguments in its proof that

$$
\begin{align*}
\operatorname{dist}\left(P, P^{\prime}\right) & \leq \operatorname{length}\left(h_{m}(\gamma)\right) \leq \operatorname{dist}\left(W, W^{\prime}\right) \underset{w \in V_{m}(x)}{\operatorname{ess} \sup }\left|D h_{m}(w)\right| \\
& \leq \operatorname{dist}\left(W, W^{\prime}\right) C_{1}^{m} \prod_{j=1}^{m}\left|h_{j}(x)\right| \leq C_{1}^{m} C_{8}^{m} \frac{\operatorname{dist}\left(W, W^{\prime}\right)}{\operatorname{diam} W} . \tag{4.33}
\end{align*}
$$

Using (4.18) we deduce that

$$
\begin{equation*}
\frac{\operatorname{dist}\left(W, W^{\prime}\right)}{\operatorname{diam} W} \geq C_{1}^{-m} C_{8}^{-m} \frac{1}{2} \eta\left(\frac{1}{2} h_{m}(x)\right) \tag{4.34}
\end{equation*}
$$

It now follows from (4.13) that if $R$ is chosen sufficiently large, then the right hand side of (4.34) is at least 1 for all $m$.

Suppose now that $\gamma \not \subset V_{m}(x)$. Then $\gamma$ contains a subsegment $\gamma^{\prime}$ which connects $W$ with $\partial V_{m}(x)$. Thus $h_{m}\left(\gamma^{\prime}\right)$ connects $P$ with $\partial K\left(t_{m}\right)$. Since $P \subset Q\left(t_{m}\right)$, we have length $\left(h_{m}\left(\gamma^{\prime}\right)\right) \geq(2-\sqrt{3}) t_{m} / 4$. Estimating the length of $h_{m}\left(\gamma^{\prime}\right)$ as in (4.33) we obtain

$$
\frac{\operatorname{dist}\left(W, W^{\prime}\right)}{\operatorname{diam} W} \geq C_{1}^{1-m} C_{8}^{1-m} \frac{(2-\sqrt{3}) t_{m}}{4}
$$

instead of (4.34). Again the conclusion follows if $R$ is chosen sufficiently large.
4.4. Proof of the lower bound. We may assume that $\rho>1$. In order to apply Lemma 2.1, let $x \in E$ and $r>0$. For $m \in \mathbb{N}$ we put

d_{m}(x)=\operatorname{diam} V_{m}(x) \quad \text { and } \quad \Delta_{m}(x)=\operatorname{dens}\left(E_{m+1}, V_{m}(x)\right)
$$

We choose $m \in \mathbb{N}$ such that

d_{m+1}(x) \leq r<d_{m}(x) .
$$

It follows from Lemma 4.6 that

\mu(B(x, r))=\mu\left(B(x, r) \cap V_{m}(x)\right)
$$

Let

$$
\mathcal{Y}_{m}=\left\{W \in \mathcal{E}_{m+1}\left(V_{m}(x)\right): W \cap B(x, r) \neq \emptyset\right\}
$$

Then

$$
\mu(B(x, r)) \leq \sum_{W \in \mathcal{Y}_{m}} \mu(W)=\sum_{W \in \mathcal{Y}_{m}} \mu_{m+1}(W)=\sum_{W \in \mathcal{Y}_{m}} \frac{1}{\prod_{j=0}^{m} \Delta_{j}(x)} \frac{\operatorname{meas} W}{\text { meas } K_{0}}
$$

Using Lemma 4.4 and Lemma 4.5 we find that

$$
\begin{align*}
\mu(B(x, r)) & \leq \frac{1}{\operatorname{meas} K_{0}} \operatorname{card} \mathcal{Y}_{m} \cdot \prod_{j=1}^{m} C_{7}^{-j} \frac{\eta\left(\left|h_{j}(x)\right|\right)}{\left|h_{j}(x)\right|^{\rho-3}} \cdot\left(2 \frac{C_{8}^{m}}{\prod_{j=1}^{m}\left|h_{j}(x)\right|}\right)^{3}  \tag{4.35}\\
& =\frac{8 C_{7}^{-m(m+1) / 2} C_{8}^{3 m}}{\text { meas } K_{0}} \operatorname{card} \mathcal{Y}_{m} \cdot \prod_{j=1}^{m} \frac{\eta\left(\left|h_{j}(x)\right|\right)}{\left|h_{j}(x)\right|^{\rho}}
\end{align*}
$$

To estimate $\operatorname{card} \mathcal{Y}_{m}$ we note that

$$
h_{m}(B(x, r)) \subset B\left(h_{m}(x), r \underset{w \in B(x, r)}{\operatorname{ess} \sup }\left|D h_{m}(w)\right|\right) .
$$

If $B(x, r) \subset V_{m}(x)$ or, equivalently, $h_{m}(B(x, r)) \subset K\left(t_{m}\right)$, with $t_{m}$ defined by (4.30), then, by Lemma 3.5,

$$
\begin{equation*}
r \underset{w \in B(x, r)}{\operatorname{ess} \sup _{n}}\left|D h_{m}(w)\right| \leq \tau_{m}:=r C_{1}^{m} \prod_{j=1}^{m}\left|h_{j}(x)\right| . \tag{4.36}
\end{equation*}
$$

Since $h_{m}(x) \in Q\left(t_{m}\right)$, this is the case in particular if $\tau_{m} \leq(2-\sqrt{3}) t_{m} / 4$. It follows that

$$
\operatorname{card} \mathcal{Y}_{m} \leq \operatorname{card}\left\{P \in \mathcal{U}_{H}\left(t_{m}\right): P \cap B\left(h_{m}(x), \tau_{m}\right) \neq \emptyset\right\} \quad \text { if } \tau_{m} \leq \frac{(2-\sqrt{3}) t_{m}}{4}
$$

Let $0<\varepsilon<\rho-1$. If $\tau_{m} \leq 1$, we deduce from (4.16) that card $\mathcal{Y}_{m} \leq 2 C_{6}$. Since $\left|h_{j}(x)\right| \rightarrow \infty$ we have that $\eta\left(\left|h_{j}(x)\right|\right) \leq\left|h_{j}(x)\right|^{\varepsilon / 2}$, for large $j$. Together with (4.35), (4.32) and (3.22) we find that

$$
\begin{aligned}
\mu(B(x, r)) & \leq \frac{16 C_{6} C_{7}^{-m(m+1) / 2} C_{8}^{3 m}}{\operatorname{meas} K_{0}} \prod_{j=1}^{m} \frac{\eta\left(\left|h_{j}(x)\right|\right)}{\left|h_{j}(x)\right|^{\rho}} \\
& \leq C_{8}^{-m(\rho-\varepsilon)} \prod_{j=1}^{m} \frac{1}{\left|h_{j}(x)\right|^{\rho-\varepsilon}} \leq d_{m+1}(x)^{\rho-\varepsilon} \leq r^{\rho-\varepsilon}
\end{aligned}
$$

for large $m$.
If $1<\tau_{m} \leq t_{m}^{\beta}$, then (4.16) yields that card $\mathcal{Y}_{m} \leq 2 C_{6} \tau_{m}$. Together with (4.35), (4.36), (4.32) and (3.22) we deduce that

$$
\begin{aligned}
& \mu(B(x, r)) \leq \frac{16 C_{6} C_{7}^{-m(m+1) / 2} C_{8}^{3 m} C_{1}^{m}}{m e a s} K_{0} \\
& \prod_{j=1}^{m} \frac{\eta\left(\left|h_{j}(x)\right|\right)}{\left|h_{j}(x)\right|^{\rho-1}} \\
& \leq C_{8}^{-m(\rho-1-\varepsilon)} r \prod_{j=1}^{m} \frac{1}{\left|h_{j}(x)\right|^{\rho-1-\varepsilon}} \leq r d_{m+1}(x)^{\rho-1-\varepsilon} \leq r^{\rho-\varepsilon}
\end{aligned}
$$

for large $m$.
Suppose next that $t_{m}^{\beta}<\tau_{m} \leq(2-\sqrt{3}) t_{m} / 4$. It then follows from (4.16) that card $\mathcal{Y}_{m} \leq C_{6} \tau_{m}^{\rho}$. Together with (4.35), (4.36), (4.32) and (3.22) this yields that

$$
\begin{align*}
\mu(B(x, r)) & \leq \frac{8 C_{6} C_{7}^{-m(m+1) / 2} C_{8}^{3 m} C_{1}^{m s}}{\operatorname{meas} K_{0}} r^{\rho} \prod_{j=1}^{m} \eta\left(\left|h_{j}(x)\right|\right)  \tag{4.37}\\
& \leq r^{\rho} d_{m+1}(x)^{-\varepsilon} \leq r^{\rho-\varepsilon}
\end{align*}
$$

for large $m$.
Suppose finally that $\tau_{m}>(2-\sqrt{3}) t_{m} / 4 \geq t_{m} / 15$. It follows from (4.17) that card $\mathcal{Y}_{m} \leq \operatorname{card} \mathcal{U}_{H}\left(t_{m}\right) \leq C_{6}\left(2 t_{m}\right)^{\rho} \leq C_{6} 30^{\rho} \tau_{m}^{\rho}$. As in (4.37) we find that $\mu(B(x, r)) \leq r^{\rho-\varepsilon}$ for large $m$.

Thus in all cases we have $\mu(B(x, r)) \leq r^{\rho-\varepsilon}$ if $m$ is sufficiently large, and hence if $r$ is sufficiently small. Lemma 2.1 yields that $\operatorname{dim} E \geq \rho-\varepsilon$. Since $E \subset \mathcal{A}(f)$ and since $\varepsilon>0$ can be chosen arbitrarily small, we conclude that $\operatorname{dim} \mathcal{A}(f) \geq \rho$. This completes the proof of the lower bound for $\operatorname{dim} \mathcal{A}(f)$ and hence the proof of Theorem 1.1.

Remark 4.7. The function $f$ considered by Rempe and Stallard [25] that satisfies $\operatorname{dim} \mathcal{I}(f)=1$ behaves like $\exp \exp (z)$ in a half-strip and is bounded outside this half-strip. This suggests that in order to construct an example of a quasiregular map for which $\operatorname{dim} \mathcal{I}(f)$ is small one would look for a function $f$ which behaves like $Z(Z(x))$ in a half-beam and which is bounded outside this half-beam. We have been unable to construct such a function.

However, the methods of $[6, \S 4]$ indicate that such a function would have an invariant Cantor set of dimension greater than $d-1$. Arguments similar to those in [13] now suggest that $\operatorname{dim} \mathcal{I}(f) \geq d-1$ for such a function $f$. Perhaps we have $\operatorname{dim} \mathcal{I}(f) \geq d-1$ and $\operatorname{dim} \mathcal{J}(f) \geq d-1$ for all quasiregular maps $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ of transcendental type.

## 5. Proof of Theorem 1.2

We are going to need the following lemma which is implicit in the proof of [9, Theorem 1.2]. We include a sketch of the proof here for convenience.
Lemma 5.1. Let $f: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ be a quasiregular map and $x_{1} \in \mathcal{A}(f) \backslash \mathcal{J}(f)$. Let $r>0$ be such that $B\left(x_{1}, 4 r\right) \cap \mathcal{J}(f)=\emptyset$ and $x_{2} \in B\left(x_{1}, r\right)$. Then there is a constant $c>0$, depending only on $d$ and $r$, such that for all large enough $k \in \mathbb{N}$ we have

$$
\log \frac{\log \left|f^{k}\left(x_{2}\right)\right|}{\log \left|f^{k}\left(x_{1}\right)\right|} \leq c\left(K_{I}(f) K_{O}(f)\right)^{k /(d-1)}
$$

Proof. Since $B\left(x_{1}, 4 r\right) \cap \mathcal{J}(f)=\emptyset$, the iterates $f^{k}$ of $f$ omit a set of positive capacity in $B\left(x_{1}, r\right)$. Let $R>0$ be such that $B(0, R) \cap \mathcal{J}(f) \neq \emptyset$. For all large enough $k$ we will have that $R_{1}:=\left|f^{k}\left(x_{1}\right)\right| \geq R$. Put $R_{2}:=\left|f^{k}\left(x_{2}\right)\right|$. We may assume that $R_{2}>R_{1}$ since otherwise there is nothing to prove.

For any such $k$ now consider the sets $X_{1}:=\left\{x \in B\left(x_{1}, 2 r\right):\left|f^{k}(x)\right| \leq R_{1}\right\}$ and $X_{2}:=\left\{x \in B\left(x_{1}, 2 r\right):\left|f^{k}(x)\right| \geq R_{2}\right\}$. Denote by $Y_{j}$ the component of $X_{j}$ that contains $x_{j}$, for $j=1,2$. The maximum principle now implies that $Y_{2}$ connects $x_{2}$ to $\partial B\left(x_{1}, 2 r\right)$. Moreover, $Y_{1}$ connects $x_{1}$ to $\partial B\left(x_{1}, 2 r\right)$. Indeed, if this was not the
case then $Y_{1}$ would be compactly contained in $B\left(x_{1}, 2 r\right)$ and thus it would be a connected component of $\left(f^{k}\right)^{-1}\left(\bar{B}\left(0, R_{1}\right)\right)$. This would imply that

$$
B(0, R) \subset \bar{B}\left(0, R_{1}\right)=f^{k}\left(Y_{1}\right) \subset f^{k}\left(B\left(x_{1}, 2 r\right)\right)
$$

Since $B(0, R) \cap \mathcal{J}(f) \neq \emptyset$ by complete invariance of the Julia set, this yields that $B\left(x_{1}, 2 r\right) \cap \mathcal{J}(f) \neq \emptyset$. This is a contradiction since $B\left(x_{1}, 4 r\right) \cap \mathcal{J}(f)=\emptyset$.

Let $\Gamma=\Delta\left(X_{1}, X_{2} ; B\left(x_{1}, 2 r\right)\right)$ and $\Gamma_{1}=\Delta\left(Y_{1}, Y_{2} ; B\left(x_{1}, 2 r\right)\right)$. We now argue as in the proof of [9, Theorem 1.2] in order to estimate the modulus $M(\Gamma)$ of the path family $\Gamma$. We find that

$$
c_{1} \leq M\left(\Gamma_{1}\right) \leq M(\Gamma) \leq c_{2} K_{O}\left(f^{k}\right) K_{I}\left(f^{k}\right)\left(\log \frac{\log \left|f^{k}\left(x_{2}\right)\right|}{\log \left|f^{k}\left(x_{1}\right)\right|}\right)^{1-d}
$$

where the positive constants $c_{1}$ and $c_{2}$ depend only on $r$ and $d$. After rearranging and using the fact that $K_{I}\left(f^{k}\right) \leq K_{I}(f)^{k}$ and $K_{O}\left(f^{k}\right) \leq K_{O}(f)^{k}$ this gives the desired inequality.

Proof of Theorem 1.2. Towards a contradiction assume that there is a function $f$ satisfying (1.1) with $\operatorname{dim} \mathcal{J}(f)<1$. Then $\mathcal{J}(f)$ is totally disconnected and $\mathcal{J}(f)=\partial \mathcal{A}(f)$ by [9, Theorem 1.2]. Hence, the complement of $\mathcal{J}(f)$ comprises of one unbounded component $U$ which is contained in $\mathcal{A}(f)$.

Choose $\alpha>\left(K_{I} K_{O}\right)^{1 /(d-1)}$. Then $\alpha>1$. Let also $x_{1} \in U$ and, using (1.1), choose $R>\left|x_{1}\right|$ so large that

$$
\begin{equation*}
M(r, f)>r \quad \text { and } \quad \log M(r, f)>(\log r)^{\alpha} \quad \text { for all } r \geq R \tag{5.1}
\end{equation*}
$$

Since $x_{1} \in U \subset \mathcal{A}(f)$ there exists $L \in \mathbb{N}$ such that

$$
\begin{equation*}
\left|f^{k+L}\left(x_{1}\right)\right| \geq M^{k+1}(R, f) \tag{5.2}
\end{equation*}
$$

for all $k \in \mathbb{N}$. Since $\left|x_{1}\right|<R$ and hence $\left|f^{k}\left(x_{1}\right)\right| \leq M^{k}(R, f)$ this implies that

$$
\begin{equation*}
\left|f^{k+L}\left(x_{1}\right)\right| \geq M\left(M^{k}(R, f), f\right) \geq M\left(\left|f^{k}\left(x_{1}\right)\right|, f\right) \tag{5.3}
\end{equation*}
$$

for all $k \in \mathbb{N}$.
Choose an arc $\gamma$ in $U$ connecting $x_{1}$ and $f^{L}\left(x_{1}\right)$. Cover this arc by $m$ balls $B\left(x_{i}, r_{i}\right)$ so that $x_{m}=f^{L}\left(x_{1}\right)$ and such that $x_{i} \in \gamma$ and $B\left(x_{i}, 4 r_{i}\right) \cap \mathcal{J}(f)=\emptyset$ for $i=1, \ldots m$. Applying now Lemma $5.12 m-2$ times we obtain

$$
\log \frac{\log \left|f^{k+L}\left(x_{1}\right)\right|}{\log \left|f^{k}\left(x_{1}\right)\right|} \leq C\left(K_{I}(f) K_{O}(f)\right)^{k /(d-1)}
$$

for all large enough $k$, where $C$ is a constant that depends on $m, d$ and the radii $r_{i}$.
Combining this with (5.3) yields that

$$
\log \frac{\log M\left(\left|f^{k}\left(x_{1}\right)\right|, f\right)}{\log \left|f^{k}\left(x_{1}\right)\right|} \leq C\left(K_{I}(f) K_{O}(f)\right)^{k /(d-1)}
$$

Since $\left|f^{k}\left(x_{1}\right)\right| \rightarrow \infty$ as $k \rightarrow \infty$ we may apply the second inequality in (5.1) for $r=\left|f^{k}\left(x_{1}\right)\right|$ if $k$ is sufficiently large. It thus follows from the last equation that

$$
\begin{equation*}
(\alpha-1) \log \log \left|f^{k}\left(x_{1}\right)\right| \leq C\left(K_{I}(f) K_{O}(f)\right)^{k /(d-1)} \tag{5.4}
\end{equation*}
$$

for large $k$.

It follows from (5.1) that

$$
\log M^{k}(R, f) \geq(\log R)^{\alpha^{k}}
$$

for all $k \in \mathbb{N}$. Together with (5.2) we thus have

$$
\log \log \left|f^{k}\left(x_{1}\right)\right| \geq \log \log M^{k+1-L}(R, f) \geq \alpha^{k+1-L} \log R
$$

for large $k$. Since $\alpha>\left(K_{I} K_{O}\right)^{1 /(d-1)}$ this contradicts (5.4) for large $k$.
