# HEAT FLOW IN A PERIODICALLY FORCED, THERMOSTATTED CHAIN

#### Abstract

We investigate the properties of a harmonic chain in contact with a thermal bath at one end and subjected, at its other end, to a periodic force. The particles also undergo a random velocity reversal action, which results in a finite heat conductivity of the system. We prove the approach of the system to a time periodic state and compute the heat current, equal to the time averaged work done on the system, in that state. This work approaches a finite positive value as the length of the chain increases. Rescaling space, the strength and/or the period of the force leads to a macroscopic temperature profile corresponding to the stationary solution of a continuum heat equation with Dirichlet-Neumann boundary conditions.


## 1. Introduction

The conversion of mechanical energy to heat, accompanied by the production of entropy, is a very common phenomenon in nature. It occurs on all scales of space and time: from ocean tides to the movement of a charged particle in a fluid under the influence of an electric field. It happens each time we rub our hands or scratch our head. A fully microscopic description of the phenomenon is desirable but very complicated. Here we study an example of this phenomenon in a very simple microscopic model system. In particular, we consider a linear chain (system) of $n+1$ particles, labelled by $x=0, \ldots, n$, in contact with a thermal reservoir at one end and acted upon by a periodic force at its other end.

The interaction of the system with the reservoir is stochastic, modeled as usual by an Ornstein-Uhlenbeck process (the Langevin force). The action of the external force on the other hand, is deterministic described by a time periodic Hamiltonian. There is also a stochastic velocity flip acting on the particles of the system to model non linear interactions, inducing a diffusive behaviour of the energy and producing a finite heat conductivity.


We prove the existence of a unique periodic state approached, as $t \rightarrow+\infty$, from any initial state. The average work done on the system over a period is equal to the time averaged heat flux, $J_{n}$, going into the reservoir. This is computed explicitly for all $n$. The diffusive behaviour of the energy implies that the heat flux $J_{n}$ is proportional to the microscopic gradient ot the temperature. To maintain a spatially constant time averaged macroscopic current $J$ in the limit $n \rightarrow \infty$ one needs to have a spatially constant time averaged temperature gradient proportional to $J$. This can be achieved by appropriately scaling the force and/or period $\theta_{n}$ as a function of $n$. This leads to a macroscopic spatial temperature profile $T(u)$, where $u=x / n \in[0,1]$ is the scaled spatial coordinate, given by the stationary solution of the heat equation with a fixed temperature $T(0)=T_{-}$(the temperature of the heat reservoir that is placed at the left endpoint of the chain) and a fixed energy current $J$ entering the system on the right, $u=1$ (where the periodic force is applied). The thermal conductivity $\kappa$ in the heat equation can be computed explicitly by the Kubo formula for this system (see [2] as well as the comments in Section 10). It is independent of the temperature, so, as a result, $T(u)$ is linear in $u$, with $\kappa T^{\prime}(u)=-J$. As already mentioned above, it is the presence of the stochastic flip in the bulk that is responsible for the conversion of the work done by the periodic force into heat that is diffusively transported through the system. Detailed study of the thermalization in the bulk for such stochastic dynamics has been studied in [14].

We note that our setting differs from the typical setup, in which the stationary macroscopic energy transport has been studied. E.g. in [16, 11, 5, 3] the chain is placed between heat baths at different temperatures. The stationary temperature profile depends then on the boundary temperatures. As far as we know, the present article is the first to derive a rigorous macroscopic limit for a system in a periodic state induced by a periodic external force. Periodic states of a system under external periodic forcing have been previously considered in [13].
1.1. Description of the model. The configuration of particle positions and momenta are described by

We should think of the positions $q_{x}$ as relative displacement from a point, say $x$ in a finite lattice $\{0,1, \ldots, n\}$. The total energy of the chain is defined by the

Hamiltonian: $\mathcal{H}_{n}(\mathbf{q}, \mathbf{p}):=\sum_{x=0}^{n} \mathcal{E}_{x}(\mathbf{q}, \mathbf{p})$, where the microscopic energy is given by

with the pinning constant $\omega_{0}>0$. We adopt the convention that $q_{-1}:=q_{0}$.
The microscopic dynamics of the process $\{(\mathbf{q}(t), \mathbf{p}(t))\}_{t \geqslant 0}$ describing the total chain is given in the bulk by

Here $\Delta_{N}$ is the Neumann discrete laplacian, corresponding to the choice $q_{n+1}:=q_{n}$ and $q_{-1}=q_{0}$. We assume that the forcing $\mathcal{F}_{n}(t)$ is $\theta_{n}$-periodic, with the period $\theta_{n}=n^{b} \theta$, and the amplitude $n^{a}$, i.e.

Here $\theta>0$ and the scaling exponents $a \in \mathbb{R}, b \geqslant 0$ are to be adjusted later. We assume $\mathcal{F}(t)$ is a smooth 1-periodic function such that

Processes $\left\{N_{x}(t)\right\}, x=1, \ldots, n$ are independent, Poisson of intensity 1, while $\widetilde{w}_{-}(t)$ is a standard one dimensional Wiener process, independent of the Poisson processes. The parameter $\gamma>0$ regulates the intensity of the random perturbations and the Langevin thermostat. We have choosen the same parameter in order to simplify notations, it does not affect the results concerning the macroscopic properties of the dynamics.

The generator of the dynamics is given by

where $F: \mathbb{R}^{2(n+1)} \rightarrow \mathbb{R}$ is a bounded and measurable function, $\mathbf{p}^{x}$ is the velocity configuration with sign flipped at the $x$ component, i.e. $\mathbf{p}^{x}=\left(p_{0}^{\prime}, \ldots, p_{n}^{\prime}\right)$, with $p_{y}^{\prime}=p_{y}, y \neq x$ and $p_{x}^{\prime}=-p_{x}$. Furthermore,

The energy currents are given by

1.2. Main results. Our first result concerns the existence and uniqueness of a periodic stationary state for the system. Fix $n \geqslant 1$. Following [8] Section 3.2, we define a periodic stationary probability measure $\left\{\mu_{t}^{P}, t \in[0,+\infty)\right\}$ as a solution of the forward equation $\partial_{t} \mu_{t}^{P}=\mathcal{G}_{t}^{*} \mu_{t}^{P}$ such that $\mu_{t+\theta_{n}}^{P}=\mu_{t}^{P}$. This condition is equivalent to

for any smooth test function $F: \mathbb{R}^{2(n+1)} \rightarrow \mathbb{R}$.
Suppose that $\{(\mathbf{q}(t), \mathbf{p}(t))\}_{t \geqslant 0}$ is the solution of (1.3)-(1.4) initially distributed according to $\mu_{0}^{P}$. Given a measurable function $F: \mathbb{R}^{2(n+1)} \rightarrow \mathbb{R}$ integrable w.r.t. each measure $\left\{\mu_{s}^{P}, s \in[0,+\infty)\right\}$ we denote

where $\mathbb{E}$ is the expectation w.r.t. $\mathbb{P}$ - the probability measure corresponding to the noises and with initial data distributed by $\mu_{0}^{P}$. The function $\bar{F}(t)$ is $\theta_{n}$-periodic. We denote its time average by

The subscript $n$ in the notation of the average $\langle\langle\cdot\rangle\rangle_{n}$ will be sometimes omitted, when it is obvious from the context.

Theorem 1.1. For a fixed $n \geqslant 1$ there exists a unique periodic stationary state $\left\{\mu_{s}^{P}, s \in[0,+\infty)\right\}$ for the system (1.3)-(1.4). The measures $\mu_{s}^{P}$ are absolutely continuous with respect to the Lebesgue measure $\mathrm{d} \mathbf{q} \mathrm{d} \mathbf{p}$ and the density $\mu_{s}^{P}(\mathrm{~d} \mathbf{q}, \mathrm{~d} \mathbf{p})=$ $f_{s}^{P}(\mathbf{q}, \mathbf{p}) \mathrm{d} \mathbf{q} d \mathbf{p}$ is strictly positive. Furthermore $\min _{x}\left\langle\left\langle p_{x}^{2}\right\rangle\right\rangle_{n} \geqslant T_{-}$.

The proof of the result is contained in Appendix A.
From (1.11) we conclude that the time averaged energy current $\left\langle\left\langle j_{x, x+1}\right\rangle\right\rangle$ is constant for $x=-1, \ldots, n$. Denote therefore

We prove, see Theorem 3.1 below, that if $b-a=1 / 2, a \leqslant 0$ and $b \geqslant 0$ (recall that $\theta_{n}=n^{b} \theta$ ), then

where $J^{a, b}<0$ is a constant given by an explicit formula, see (3.3).
In our first main result, see Theorem 3.4 below, we prove the convergence of the time averaged energy functional $\left\langle\left\langle\mathcal{E}_{x}\right\rangle\right\rangle$ to a linear macroscopic profile

where the constant $D>0$ is given by formula (3.10).
Our second result, see Theorem 9.1 below, deals with the question of the vanishing of the fluctuations of the kinetic energy functional in the case when the period of the force is of a fixed microscopic size. More precisely, supposing that $b=0$ and $a=-1 / 2$, we prove that there exists a constant $C>0$ such that

1.3. About the proof. The macroscopic equation for the energy transport emerges from an exact fluctuation-dissipation decomposition of the energy current

where $\mathfrak{F}_{x}$ and $\mathfrak{f}_{x}$ are local second order polynomials in the variables $\left\{q_{x+j}, p_{x+j}, j=\right.$ $-1,0,1\}$ (see (5.1), (5.2) and (5.3) for the precise definitions, valid also at the boundaries). After taking the time average we obtain

Then we establish first (1.18), that takes care of the left hand side of (1.21), i.e. $n\left\langle\left\langle j_{x, x+1}\right\rangle\right\rangle \rightarrow J^{a, b}$. The explicit calculation involved in computing $J^{a, b}$ rely only on the first moments of the periodic states.

Note that the equilibrium average at temperature $T$ of $\mathfrak{F}_{x}$ equals $D T$ (with $D>0$ given by (3.10)). Thus, all we need to prove is a kind of a local equilibrium that allows to conclude that $\left\langle\left\langle\mathfrak{F}_{[n u]}\right\rangle\right\rangle \sim D T(u), u \in[0,1]$. This is the main part of the work. It involves proving the convergence of the second moments of the positions and momenta. The most difficult part is to establish an a priori upper bound for the time average of the total energy that proves it does not grow faster than the size of the system $n$ (cf. (7.10)).

In Section 6 we derive a closed system of equations for the time averages of the covariance matrix (6.17) that involves the discrete Neumann laplacian $\Delta_{N}$. After performing some manipulations with these equation we obtain that the time ageraged position covariances are given by the Green's function $\left(\omega_{0}^{2}-\Delta_{N}\right)^{-1}\left(x, x^{\prime}\right)$ plus an error that is proportional to the averaged current, that is small (of order $O(1 / n))$. In the bulk we have that

Here $\Delta$ is the discrete laplacian on $\mathbb{Z}$, that gives the covariance matrix of the positions of the system in equilibrium. But in order to obtain the correct bounds on the total energy we need a careful control the behavior of the Green's function at the boundaries, cf Lemma B. 2 in Appendix B.

Once the energy bound is established, the next step is to prove local equilibrium, which is contained in Proposition 8.2. After this step the proof of the main result follows directly, see Theorem 8.1.

In Appendix A we prove the existence of the periodic measure. The manipulations done with the equations for the covariance matrix use some ideas from [5]. The harmonic dynamics with self-consistent Langevin reservoirs considered in that article has a similar covariance equations of the corresponding stationary state, see Section 10.

Section 9 contains the proof of the result concerning the vanishing size of time variance of the kinetic energy, see Theorem 9.1. Appendix C is devoted to the presentation of the proofs of auxiliary facts formulated in Section 9.

## 2. Some preliminaries and notation

2.1. The dynamics of periodic means. Define the averages in the periodic state:

Here $\Delta_{\mathrm{N}}$ is the Neumann discrete laplacian, subject to the boundary condition $q_{-1}=q_{0}, q_{n}=q_{n+1}$. We can rewrite the above system using a matrix notation. Let

Here $A$ is a $2 \times 2$ block matrix made of $(n+1) \times(n+1)$ matrices of the form

where $\mathrm{Id}_{n+1}$ is the $(n+1) \times(n+1)$ identity matrix. We also let $\mathrm{e}_{q, \ell}$ and $\mathrm{e}_{p, \ell}$, $\ell=1, \ldots, n+1$ be the $1 \times 2(n+1)$ column vectors whose components are given by

Proposition 2.1. The spectrum of matrix $A$ is contained in the half plane $\operatorname{Re} \lambda>$ 0 . Thus, there exists $c>0$ such that

is well defined in the half-plane $\operatorname{Re} \lambda>-c$, with the integral on the right hand side of (2.5) absolutely convergent.

The proof of the result can be found in Appendix A of [5].
2.2. Time harmonics of the periodic means. Consider the Fourier coefficients of the periodic means

2.3. Green's function corresponding to $L_{\omega_{0}, \theta, \ell}^{n}$. Denote by $G_{\omega_{0}, \theta, \ell}^{n}(x, y)$ the Green's functions corresponding to $L_{\omega_{0}, \theta, \ell}^{n}$. It is defined as the solution of

2.4. Green's function of the lattice laplacian. Recall that the lattice gradient and laplacian of any $f: \mathbb{Z} \rightarrow \mathbb{R}$ are defined as $\nabla f_{x}=f_{x+1}-f_{x}$ and $\Delta f_{x}=$ $f_{x+1}+f_{x-1}-2 f_{x}, x \in \mathbb{Z}$, respectively.

Suppose that $\omega_{0}>0$. Consider the Green's function of $-\Delta+\omega_{0}^{2}$. It is given by, see e.g. $[12,(27)]$,

## 3. Periodic stationary energy transport

3.1. Asymptotics of the time average of the mean current. Our first result gives an explicit formula for the asymptotics of the time average of the mean current. In what follows we shall also be concerned with the functional

& \times\left\{\left[4 \sin ^{2}\left(\frac{\pi z}{2}\right)+\omega_{0}^{2}-\left(\frac{2 \pi \ell}{\theta}\right)^{2}\right]^{2}+\left(\frac{4 \gamma \pi \ell}{\theta}\right)^{2}\right\}^{-1} d z
\end{aligned}

and for $b>0$

Remark 3.2. Calculations made in Appendix $D$ show that

\end{aligned}

and Theorem 3.1 follows.
4.2. $L^{2}$ norms of the position and momentum averages. Denote

with the convention that $q_{-1}=q_{0}, q_{n}=q_{n+1}$. Then

& +\frac{\delta_{x, n} n^{a}}{\theta_{n}} \int_{0}^{\theta_{n}} \mathcal{F}\left(t / \theta_{n}\right)\left(\bar{q}_{n-1}(t)-\bar{q}_{n}(t)\right) \mathrm{d} t, \quad x=1, \ldots, n .

Remark 5.1. Note that the expectation of $\mathfrak{F}_{x}$ with respect to the Gibbs Gaussian measure on the lattice $\mathbb{Z}$, with the Hamiltonian $\sum_{x \in \mathbb{Z}} \mathcal{E}_{x}$ and the inverse temperature $T^{-1}$, is given by

## 6. The covariance matrix of the periodic state

6.1. Dynamics of fluctuations. Denote

Denote by $\overline{\mathbf{X}}$ the vector of its means and by $\mathbf{X}^{\prime}=\mathbf{X}-\overline{\mathbf{X}}$. For any $\ell \geqslant 0$ define $\mathbf{X}_{\ell}(t), t \geqslant-\ell \theta$ - the solution of (6.2)-(6.3) that satisfies $\mathbf{X}_{\ell}(-\ell \theta)=\mathbf{X}$. We call such solutions $\theta$-periodic. Note that

& S^{(p)}(t)=\left[\mathbb{E}\left[p_{x}^{\prime}(t) p_{y}^{\prime}(t)\right]\right]_{x, y=0, \ldots, n} \quad \text { and } \quad S^{(p, q)}(t)=\left[S^{(q, p)}(t)\right]^{T}
\end{align*}

Obviously both $\overline{\mathfrak{p}^{2}}(t), S^{(q)}(t), S^{(p)}(t)$ are $\theta$-periodic and the matrices are symmetric.

We shall also consider $\left\langle\left\langle\overline{\mathfrak{p}^{2}}\right\rangle\right\rangle$ and $\left\langle\left\langle S^{(\alpha)}\right\rangle\right\rangle, \alpha \in\{q, p,(p, q),(q, p)\}$ the respecive vector and matrices of time averages.

Given a vector $\mathfrak{y}=\left(y_{0}, y_{1}, \ldots, y_{n}\right)$, define also the matrix valued function

& 4 \gamma\left\langle\left\langle S^{(q, p)}\right\rangle\right\rangle=\left(\omega_{0}^{2}-\Delta_{\mathrm{N}}\right)\left\langle\left\langle S^{(q)}\right\rangle\right\rangle-\left\langle\left\langle S^{(q)}\right\rangle\right\rangle\left(\omega_{0}^{2}-\Delta_{\mathrm{N}}\right)  \tag{6.17}\\

## 7. Energy Bounds

Throughout the remainder of the paper we shall always assume that the assumptions of Theorem 3.1 are in force. From (6.24) and (6.21) we have

7.1. A lower bound on matrix $\left[M_{x, y}\right.$ ]. The main result of the present section is the following.

& =C_{*} \sum_{x, y=0}^{n} \sum_{j, j^{\prime}=0}^{n}\left(\lambda_{j}-\lambda_{j^{\prime}}\right)^{2} \psi_{j}(x) \psi_{j^{\prime}}(x) \psi_{j}(y) \psi_{j^{\prime}}(y) f_{x} f_{y} \\
& =2 C_{*} \sum_{x, y=0}^{n}\left\{\sum_{j=0}^{n} \lambda_{j}^{2} \psi_{j}^{2}(x) \delta_{x, y}-\sum_{j, j^{\prime}=0}^{n} \lambda_{j} \lambda_{j^{\prime}} \psi_{j}(x) \psi_{j^{\prime}}(x) \psi_{j}(y) \psi_{j^{\prime}}(y)\right\} f_{y} f_{x} \\
& =2 C_{*} \sum_{x, y=0}^{n} f_{y} f_{x}\left\{\delta_{x, y}\left\langle\Delta_{\mathrm{N}}^{2} \delta_{x}, \delta_{y}\right\rangle-\left\langle\Delta_{\mathrm{N}} \delta_{x}, \delta_{y}\right\rangle^{2}\right\} .

As before, here $\Delta_{N}$ is the Neumann laplacian. A careful calculation shows that

7.2. Upper bound on energy. The main objective of the present section is the following.

& =\sum_{y} G_{\omega_{0}}^{n}(y, y)\left\langle\left\langle p_{y}^{2}\right\rangle\right\rangle+\left(T_{-}-\left\langle\left\langle p_{0}^{2}\right\rangle\right\rangle\right) G_{n, \omega_{0}}(0,0), \tag{7.12}
\end{align*}

where $G_{\omega_{0}}^{n}$ is the Green's function of $\omega_{0}^{2}-\Delta_{\mathrm{N}}$, see Section 2.3. The second term on the utmost right hand side of (7.12) is of order $\frac{1}{n}$. Concerning the first term, thanks to Lemma B.2, it equals

& \leqslant H_{*} \sqrt{n}\left\{\sum_{x=0}^{n}\left[\left\langle\left\langle p_{x+1}^{2}\right\rangle\right\rangle-\left\langle\left\langle p_{x}^{2}\right\rangle\right\rangle\right]^{2}\right\}^{1 / 2} \leqslant C\left(\sum_{y=0}^{n}\left\langle\left\langle p_{y}^{2}\right\rangle\right\rangle\right)^{1 / 2}
\end{align*}

and the conclusion of the proposition follows.

& +\left(T_{-}-\left\langle\left\langle p_{0}^{2}\right\rangle\right\rangle\right) \sum_{j, j^{\prime}} \frac{2 \Theta\left(\mu_{j}, \mu_{j^{\prime}}\right) \Upsilon_{j, j^{\prime}}(1) \psi_{j}(0) \psi_{j^{\prime}}(0)}{\mu_{j}+\mu_{j^{\prime}}} .

& \widetilde{\rho}_{n}(y):=\frac{2}{n+1} \sum_{j} \frac{1}{\mu_{j}} \cos \left(\frac{\pi j}{n+1}\right) \cos \left(\frac{\pi j(2 y+1)}{n+1}\right) .

A simple calculation shows that $\widetilde{g}_{n}(1)$ is the Riemann sum approximation of order $1 / n$ of the integral defining $G_{\omega_{0}}(1)$, see (2.15). & \leqslant(n+1)\left\langle\left\langle p_{0}^{2}\right\rangle\right\rangle-2 \gamma n^{2} 2 F_{n}+O\left(n^{2 a}\right) \leqslant C^{\prime}(n+1)
\end{align*}
$$

that gives the bound

& \leqslant \frac{C}{n+1}+C \sup _{x}\left\langle\left\langle p_{x}^{2}\right\rangle\right\rangle \sum_{x=0}^{n}\left\langle\left\langle\bar{p}_{x}\right\rangle\right\rangle^{2} \leqslant \frac{C}{n+1}+\frac{C}{n+1} \sup _{x}\left\langle\left\langle p_{x}^{2}\right\rangle\right\rangle, \tag{7.27}

Using the Cauchy-Schwarz inequality we conclude

## 8. Convergence of the energy density

8.1. Identification of the macroscopic energy density limit. Proof of Theorem 3.4. Let

Let $\widetilde{e}_{n}(u)$ be piecewise linear function obtained by the linear interpolation between the nodal points $P_{x}:=\left(\frac{x}{n+1},\left\langle\left\langle p_{x}^{2}\right\rangle\right\rangle\right), x=0, \ldots, n+1$ (here $\left.p_{n+1}=p_{n}\right)$. By Proposition 7.9

& -\frac{1}{n+1} \sum_{x=0}^{n} \varphi\left(\frac{x}{n+1}\right)\left\langle\left\langle r_{x}^{2}\right\rangle\right\rangle+O\left(\frac{1}{n^{1-a}}\right) .
\end{align*}
$$

Since $r_{0}=0$ the last expression equals

by virtue of (7.10). This ends the proof of (8.28).

## 9. Vanishing time variance of the kinetic energy

A natural question is about the time averaging of the energy functional. We prove that the time variance of the average kinetic energy vanishes as $n \rightarrow \infty$. We consider only the case when $b=0$ and $a^{-1 / 2}$ in the dynamics described by (1.3) (1.5).

Theorem 9.1. Under the assumption stated above there exists a constant $C>0$ such that

& \leqslant \frac{\left(\mathfrak{M V}_{*}\right)^{4}}{\mathfrak{C}^{2} n^{2}}+\frac{\mathfrak{C}^{2}}{2} \sum_{x=0}^{n}\left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle+\frac{\mathfrak{v}_{*}^{2}}{n^{2}},
\end{align*}

and (9.1) follows.

## 10. Concluding Remarks

In this article we studied the energy transport in the periodic state of a pinned harmonic chain with bulk dynamics perturbed by a random flip of the signs of the velocities. Work was done on the system by a periodic forcing acting on the right hand side of the chain and the heat was absorbed by a heat bath coupled to the system via a Langevin stochastic thermostat at temperature $T_{-}$on the left. The asymptotic temperature profile (3.9) should be seen as the stationary solution of the heat equation:

where $J$ is given by (3.3). In a companion work [9] we prove that, under proper conditions on the initial distribution, for any compactly supported test function $\varphi \in C([0,+\infty) \times[0,1])$,
$\lim _{n \rightarrow \infty} \frac{1}{n} \sum_{x=0}^{n} \int_{0}^{+\infty} \varphi\left(t, \frac{x}{n}\right) \mathcal{E}_{x}\left(n^{2} t\right) \mathrm{d} t=\int_{0}^{+\infty} \int_{0}^{1} \varphi(t, u) T(t, u) \mathrm{d} t \mathrm{~d} u, \quad$ in probability,
with $T(t, u)$ the solution of (10.1). Notice the diffusive rescaling of space and time.

The diffusion coefficient appearing in (10.1) (defined in (1.10)) has been computed in a different way in [1, Theorem formula (74)] and [7, Theorem 3.2, formula (3.21)]. It turns out that it equals to the diffusivity of a phonon performing a random walk on the integer lattice with random scattering generated by the noise. As a result

where $\omega^{\prime}(k) /(2 \pi)$ is a group velocity of a phonon of frequency $k$ belonging to the one dimensional unit torus $\mathbb{T}$, that is the interval $[-1 / 2,1 / 2]$ with identified endpoints. Here $\omega(k)=\sqrt{\omega_{0}^{2}+4 \sin ^{2}(\pi k)}$ is the dispersion relation of the harmonic lattice considered in the present paper. In fact, if we consider a more general type of noise that allows to scatter the phonons of given frequency $k$, with the
total scattering kernel $R(k)$ (in the case of the flip noise $R(k) \equiv 1$ ) we would have

As noted before the velocity reversals introduced in the dynamics serve the purpose of making the heat conductivity finite. In their absence the harmonic crystal has an infinite conductivity [16]. The velocity reversals are thus an idealized substitute for the anharmonicities, impurities and other defects which scatter phonons and produce a finite conductivity and establishes the validity of Fourier's law in real solids.

An alternative way of modeling anharmonicity for achieving a finite conductivity is the introduction of "self consistent" reservoirs. This was introduced in [4, 15] and fully analyzed in [5] for describing the heat flow in a harmonic crystal in contact with two heat reservoirs at different temperatures and no external force. In that model one introduces, in addition to the external reservoirs, also "internal" Langevin reservoirs for each particle. Letting $T_{x}$ be the temperature of the reservoir at position $x=0, \ldots, n$, with the same coupling $\gamma$ as used here, Eq. (2.2) remains unchanged while Eq. (1.11) will have an extra term, $2 \gamma\left(T_{x}-p_{x}^{2}\right)$, on its right hand side. Solving for the periodic first and second moments of the system the internal $T_{x}, x=1, \ldots, n-1$, are then determined by the requirement that the time average of the internal heat flux, given by the term in the square bracket above, vanishes in the stationary state. As a result, there is no contribution to the average current from these internal reservoirs and the limiting macroscopic behavior is the same as in a corresponding velocity flip model. This approach can be modified by considering a periodic, instead of a constant, self-consistent temperature profile. This will make the dynamics of the first and second moments of the position and momenta variables identical with that of the flip model. An important property of the self consistent reservoir model is that the periodic measure is Gaussian, consequently it is determined by the first and second moments already computed here.

Various possible extension of the present model are presented in the review article [10]: forcing acting on a particle in the bulk, unpinned dynamics, higher dimensional lattice, anharmonic interactions.

## Appendix A. The proof of Theorem 1.1

Since the result does not depend on the scaling factor $n^{a}$, standing by the force $\mathcal{F}(t)$, and the period size $\theta_{n}$ we assume that $a=0$ and $\theta_{n}=\theta$. Given a Borel probability measure $\mu$ on $\mathbb{R}^{2(n+1)}$ (see (1.1)) we denote by $\left(\mathbf{q}_{\mu}(t), \mathbf{p}_{\mu}(t)\right)$ the solution of (1.3)-(1.4)) such that $\left(\mathbf{q}_{\mu}(0), \mathbf{p}_{\mu}(0)\right)$ is distributed according to $\mu$. Denote then by $\left(\overline{\mathbf{q}}_{\mu}(t), \overline{\mathbf{p}}_{\mu}(t)\right)$ and $C_{\mu}(t)$ the vector of averages and matrix of the mixed second moments of the solution, correspondingly. They are defined by formulas (2.1) and a $2 \times 2$ block matrix

Then, equations (A.1) describe the evolution of the first two
moments of the solution of (1.3)-(1.4)) whose initial distribution is a random vector with the first two moments given by $\bar{X}$ and $S$, respectively.
A.1. The existence and uniqueness of the periodic mean and second moment. In the first step we show the existence of a periodic solution of (A.1) that corresponds to the mean and covariance of a certain probability evolution.

Proposition A.1. There exists a unique vector $\overline{\mathbf{X}}_{\mathrm{per}}=\left(\overline{\mathbf{q}}_{\mathrm{per}}, \overline{\mathbf{p}}_{\mathrm{per}}\right) \in \mathbb{R}^{2(n+1)}$ and a non-negative symmetric matrix $C_{\mathrm{per}} \geqslant \overline{\mathbf{X}}_{\mathrm{per}} \otimes \overline{\mathbf{X}}_{\mathrm{per}}$ such that the solution of (A.1) with

Conversely, any periodic symmetric matrix valued function $C(t)$ satisfying (A.9) is a periodic solution to the second equation of (A.1).

Consider the following linear mapping: $\mathcal{L}:\left[C\left(\mathbb{T}_{\theta}\right)\right]^{n+1} \rightarrow\left[C\left(\mathbb{T}_{\theta}\right)\right]^{n+1}$, where $\mathbb{T}_{\theta}:=$ $\theta \mathbb{T}$ is the torus of size $\theta$, that assigns to a given vector of $\theta$-periodic functions $\mathbf{T}(s)=\left[T_{0}(s), \ldots, T_{n}(s)\right]$ a vector valued function

Obviously, from (A.10), we have $\mathfrak{G}_{x, y}(s) \geqslant 0$. Note also that although $g_{x, x^{\prime}, y}(\cdot)$ need not be $\theta$-periodic the functions $\mathfrak{G}_{x} \mathbf{T}(t), x=0, \ldots, n$ are $\theta$-periodic. In addition, if $C(t)$ satisfies (A.9), then

Conversely, by finding a solution $\mathbf{c}_{2}$ of (A.14) one can define then a $\theta$-periodic function $C(t)$ by the right hand side of (A.9). The entries of the function corresponding to $C_{x, x}, x=n+1, \ldots, 2 n+1$ coincide with the coordinates of the vector $\mathbf{c}_{2}$, by virtue of (A.14). Thus, the function $C(t)$ solves equation (A.9). We have reduced therefore the problem of finding a periodic solution to the second equation of (A.1) to solving equation (A.14).
A.1.3. Solution of (A.14). Let

We shall show that the mapping $\mathfrak{T}$ has a unique fixed point in $\mathcal{C}_{+}$by proving that the mapping is a contraction in the norm $\|\cdot\| \|$. Indeed, for $\mathbf{T}_{j}^{T}=\left[T_{j, 0}, T_{j, 1}, \ldots, T_{j, n}\right]$,

& \leqslant \sum_{x^{\prime}=1}^{n}\left(\int_{0}^{\theta} \mathfrak{G}_{x, x^{\prime}}(s) \mathrm{d} s\right)\left\|T_{1, x^{\prime}}-T_{2, x^{\prime}}\right\|_{\infty} \\

We have shown that $\left\|\mathfrak{T}\left(\mathbf{T}_{1}\right)-\mathfrak{T}\left(\mathbf{T}_{2}\right)\right\|_{\infty} \leqslant \rho\left\|\mathbf{T}_{1}-\mathbf{T}_{2}\right\|_{\infty}$ and the existence of a unique fixed point follows. This ends the proof of Proposition A.1.
A.2. The end of the proof of Theorem 1.1. Suppose now that $\nu$ is a probability law whose first and second moments are $\theta$-periodic, e.g. it could be a Gaussian distribution with the mean and the second moment given by $\mathbf{P}_{\text {per }}$ and $C_{\text {per }}$, respectively. Denote by

We have $\mathbb{P}[E]>0$. Suppose that the dynamics starts at $(\mathbf{q}, \mathbf{p})$. Then, for any $F \geqslant 0$ we can write

Using the hypoellipticity of the time homogeneous Ornstein-Uhlenbeck process $U(t)$ that corresponds to the generator
$\mathcal{G}^{(g)}:=\mathcal{A}+2 \gamma S_{-}$, where

see Section A. 3 below, we can prove that there exist strictly positive transition probability density kernels $\rho_{s, t}$ corresponding to $\mathcal{Q}_{s, t}$. Suppose that the time homogeneous Ornstein-Uhlenbeck process $U(t ; u)$ satisfies the S.D.E.

Here

d w_{0}^{(q)}(s) \\
\vdots \\
d w_{n}^{(q)}(s) \\
d w_{0}^{(p)}(s) \\
\vdots \\

\end{array}\right) .

is a $2(n+1)$-dimensional standard Wiener process. Due to the hypoellipticity, the probability distribution of $U(t ; u)$ have densities that are given by $C^{\infty}$ smooth Gaussians.

The non-homogeneous Ornstein-Uhlenbeck process $V(t ; v)$ that corresponds to the $\mathcal{G}_{t}^{(g)}$ and satisfies $V(0 ; v)=v$, can be described by (cf (2.4)) the solution of

& =U(t ; v)+\int_{0}^{t} e^{-A_{E}(t-s)} \mathcal{F}(s) \mathrm{e}_{p, n+1} \mathrm{~d} s
\end{aligned}

Thus the distribution of $V(t ; v)$ has a density that is also given by a $C^{\infty}$ smooth Gaussian.

Thanks to (A.21) we conclude that

where $c_{*}:=\mathbb{P}[E]$. Then, $\nu_{0, t}:=\nu \mathcal{P}_{0, t}$ describes the law of $(\mathbf{q}(t), \mathbf{p}(t))$ with the prescribed initial data. Thanks to Proposition A. 1 we can see that the total energy $\mathcal{H}(t):=\sum_{x=0}^{n} \mathcal{E}_{x}(t)$ (see (1.2)) is a Lyapunov function for the above system, since $\mathbb{E H}(t)$ is $\theta$-periodic. The above implies that the family of laws $\left\{\nu_{0, t}, t \geqslant 0\right\}$ is tight in $\mathbb{R}^{2(n+1)}$. Thus, also the family $\mu_{N}:=N^{-1} \int_{0}^{N \theta} \nu_{0, s} \mathrm{~d} s$ is tight. Suppose that $\mu_{\infty}$ is its limiting measure, i.e. there exists a sequence $N^{\prime} \rightarrow+\infty$ such that $\mu_{N^{\prime}} \rightarrow \mu_{\infty}$, in the topology of weak convergence. Since $\mathcal{P}_{s, t}$ has the Feller property one can easily conclude that $\mu_{\infty} \mathcal{P}_{0, \theta}=\mu_{\infty}$. Hence $\mu_{s}^{P}:=\mu_{\infty} \mathcal{P}_{0, s}, s \in[0,+\infty)$ is a periodic stationary state.

Suppose that $\mu(\mathrm{d} \mathbf{q}, \mathrm{d} \mathbf{p})=f(\mathbf{q}, \mathbf{p}) \mathrm{d} \mathbf{q} \mathrm{d} \mathbf{p}$, where $f$ is a $C^{\infty}$ smooth probability density. One can show, using the regularity theory of stochastic differential equations, that $\mu \mathcal{P}_{0, \theta}$ is absolutely continuous w.r.t. the Lebesgue measure and its density is also $C^{\infty}$ smooth, see e.g. [6, Corollary III.3.4, p. 303]. This allows us to conclude further that $\mu \mathcal{P}_{0, \theta}$ is absolutely continuous, provided that $\mu$ is absolutely continuous. We shall denote by $\mathcal{P}_{0, \theta}$ the corresponding operator induced on $L^{1}\left(\mathbb{R}^{2(n+1)}\right)$. The operator $\mathcal{Q}_{0, \theta}$ corresponding to the Gaussian dynamics transforms $\mu_{\infty}$ into an absolutely continuous measure. Thanks to (A.24) we conclude that

Therefore the singular part of $\mu_{\infty}$ is of at most mass $1-c_{\star}$. Since $\mathcal{P}_{0, \theta}$ transforms the space of abolutely continuous measures into itself, both the singular and absolutely continuous parts of $\mu_{\infty}$, after normalization, become invariant under $\mathcal{P}_{0, \theta}$. Iterating this procedure we conclude, after $m$ steps, that the singular part can be of at most mass $\left(1-c_{*}\right)^{m}$, which eventually leads to the conclusion that
the measure $\mu_{\infty}$ is absolutely continuous. The respective density is positive, due to (A.24). This ends the proof of Theorem 1.1.

for some constants $c_{0}^{(0)}$ and $d_{0}^{(0)}$. Note that, $\left[\mathcal{X} \mathcal{X}_{0}, \partial_{p_{1}}\right]=\partial_{q_{1}}$. Therefore,

for some constants $c_{0}^{(1)}, c_{1}^{(1)}$ and $d_{0}^{(1)}$. Continuing calculations along those lines we get that

& \mathcal{X}_{2}^{(m)}:=\left[\mathcal{X}_{0}, \mathcal{X}_{2}^{(m-1)}\right]=\sqrt{2 \gamma T_{-}} \partial_{q_{m}}+c_{m}^{(m)} \partial_{p_{m}}+\sum_{j=0}^{m-1} c_{j}^{(m)}(t) \partial_{z_{j}}+\sum_{j=0}^{m-1} d_{j}^{(m)} \partial_{q_{j}} .
\end{aligned}
$$

for some constants $c_{j}^{(m)}, d_{j}^{(m)}$. In conclusion, we can see that $\mathcal{X}_{0}, \mathcal{X}_{1}^{(m)}$ and $\mathcal{X}_{2}^{(m)}$, $0 \leqslant m \leqslant n$ generate the tangent space to $\mathbb{R} \times \mathbb{R}^{2(n+1)}$ so the operator $\left(\mathcal{G}^{(g)}\right)^{*}-\partial_{t}$ is hypoelliptic in $\mathbb{R} \times \mathbb{R}^{2(n+1)}$ by virtue of the Hörmander theorem.

## Appendix B. Green Functions convergence

Recall that $G_{\omega_{0}}$ and $G_{\omega_{0}}^{n}$ are the Green's functions corresponding to $\omega_{0}^{2}-\Delta$ and $\omega_{0}^{2}-\Delta_{\mathrm{N}}$, where $\Delta$ is the free lattice laplacian on $\mathbb{Z}$ and $\Delta_{\mathrm{N}}$ is the Neumann discrete laplacian on $\{0,1, \ldots, n\}$, see Sections 2.3 and 2.4 , respectively.
B.1. Estimates on oscillating sums. Define $\chi_{n}(x)$ as the $n+1$-periodic extension of $\chi_{n}(x):=(1+x) \wedge(n+2-x), x \in[0, n+1]$. Suppose that $\Phi: \mathbb{R}^{2} \rightarrow \mathbb{C}$ is a $\theta, \theta^{\prime}$-periodic function in each variable respectively. Denote

H_{x, x^{\prime}}^{(n)}=\frac{1}{(n+1)^{2}} \sum_{j, j^{\prime}=0}^{n} \Phi\left(\frac{\theta j}{n+1}, \frac{\theta^{\prime} j^{\prime}}{n+1}\right) \exp \left\{\frac{2 i \pi j x}{n+1}\right\} \exp \left\{\frac{2 i \pi j^{\prime} x^{\prime}}{n+1}\right\}
$$

for $x, x^{\prime} \in \mathbb{Z}$.
Lemma B.1. Suppose that $\Phi$ is of $C^{k}$-class for some $k \geqslant 1$. Then, there exists C such that

Proof. To simplify the notation we suppose that $\theta=\theta^{\prime}=1$. Summation by parts yields

& =\frac{1}{(n+1)^{2}\left[\exp \left\{\frac{i \pi x}{n+1}\right\}-1\right]} \sum_{j, j^{\prime}=0}^{n}\left[\Phi\left(\frac{j-1}{n+1}, \frac{j^{\prime}}{n+1}\right)-\Phi\left(\frac{j}{n+1}, \frac{j^{\prime}}{n+1}\right)\right] \\
& \times \exp \left\{\frac{2 i \pi j x}{n+1}\right\} \exp \left\{\frac{2 i \pi j^{\prime} x}{n+1}\right\}
\end{aligned}
$$

Since $\Phi$ is of $C^{1}$ class

\left|\Phi\left(\frac{j-1}{n+1}, \frac{j^{\prime}}{n+1}\right)-\Phi\left(\frac{j}{n+1}, \frac{j^{\prime}}{n+1}\right)\right| \leqslant \frac{C}{n+1}
$$

for some constant $C>0$. In addition, there exists $c>0$ such that

\left|\exp \left\{\frac{2 i \pi x}{n+1}\right\}-1\right| \geqslant \frac{c \chi_{n}(x)}{n+1}
$$

for $x, x^{\prime} \in \mathbb{Z}, n \geqslant 1$. Thus, there exists $C>0$ such that

\left|H_{x, x^{\prime}}^{(n)}\right| \leqslant \frac{C}{\chi_{n}(x)}, \quad x, x^{\prime} \in \mathbb{Z} .
$$

Iterating this argument in the regularity degree $k$ of $\Phi$ we conclude (B.1).
B.2. Application. An application concerns the approximation of the Green's function $G_{\omega_{0}}$ by $G_{\omega_{0}}^{n}$ along the diagonal.

Lemma B.2. We have

As a result we write $G_{\omega_{0}}^{n}(y, y)$ in the form (B.2), with

& \widetilde{S}_{j, j^{\prime}}^{q}(m)\left[\mu_{j^{\prime}}-\mu_{j}-\frac{2 \pi i m}{\theta}\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]+2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right) \widetilde{S}_{j, j^{\prime}}^{q p}(m)=0,  \tag{C.3}\\
& \widetilde{S}_{j, j^{\prime}}^{q p}(m)\left(\mu_{j}-\mu_{j^{\prime}}\right)+\frac{2 \pi i m}{\theta} \widetilde{S}_{j, j^{\prime}}^{q}(m) \mu_{j^{\prime}}+\left(4 \gamma+\frac{2 \pi i m}{\theta}\right) \widetilde{S}_{j, j^{\prime}}^{p}(m)=\widetilde{F}_{j, j^{\prime}}

& =\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)^{-1}\left\{F_{j, j^{\prime}}-\widetilde{S}_{j, j^{\prime}}^{q}\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(\mu_{j}-\mu_{j^{\prime}}\right)^{2}+\frac{\pi i m}{\theta}\left(\mu_{j}+\mu_{j^{\prime}}\right)\right\}\right.
\end{aligned}
$$

Hence

& \widetilde{S}_{j, j^{\prime}}^{q}=\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(\mu_{j}-\mu_{j^{\prime}}\right)^{2}+\frac{\pi i m}{\theta}\left(\mu_{j}+\mu_{j^{\prime}}\right)\right\}^{-1} F_{j, j^{\prime}}  \tag{C.4}\\
& -\widetilde{S}_{j, j^{\prime}}^{p}\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(\mu_{j}-\mu_{j^{\prime}}\right)^{2}+\frac{\pi i m}{\theta}\left(\mu_{j}+\mu_{j^{\prime}}\right)\right\}^{-1} .
\end{align*}
$$

On the other hand, from the first equation of (C.3) we conclude that

& -\widetilde{S}_{j, j^{\prime}}^{p}\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(\mu_{j}-\mu_{j^{\prime}}\right)^{2}+\frac{\pi i m}{\theta}\left(\mu_{j}+\mu_{j^{\prime}}\right)\right\}^{-1}
\end{aligned}
$$

and

\begin{aligned}
& 2 \widetilde{S}_{j, j^{\prime}}^{p}\left[\mu_{j^{\prime}}+\mu_{j}+\left(2 \gamma+\frac{2 \pi i m}{\theta}\right) \frac{\pi i m}{\theta}\right]^{-1} \\
& \times\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(\mu_{j}-\mu_{j^{\prime}}\right)^{2}+\frac{\pi i m}{\theta}\left(\mu_{j}+\mu_{j^{\prime}}\right)\right\}+\widetilde{S}_{j, j^{\prime}}^{p}\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)=F_{j, j^{\prime}}
\end{aligned}
$$

This leads to

\widetilde{S}_{j, j^{\prime}}^{p}=\sum_{y} \Theta_{m}\left(\mu_{j}, \mu_{j^{\prime}}\right) \psi_{j}(y) g_{y} \psi_{j^{\prime}}(y),

& \Theta_{m}\left(c, c^{\prime}\right):=4 \gamma\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)^{-1}\left\{2\left(4 \gamma+\frac{2 \pi i m}{\theta}\right)^{-1}\left[c+c^{\prime}+\left(2 \gamma+\frac{2 \pi i m}{\theta}\right) \frac{\pi i m}{\theta}\right]^{-1}\right. \\
& \left.\times\left\{\left[2\left(2 \gamma+\frac{2 \pi i m}{\theta}\right)\right]^{-1}\left(c-c^{\prime}\right)^{2}+\frac{\pi i m}{\theta}\left(c+c^{\prime}\right)\right\}+1\right\}^{-1} \tag{C.6}
\end{align*}

& \times\left\{\left[c+c^{\prime}+2\left(\gamma+\frac{\pi i m}{\theta}\right) \frac{\pi i m}{\theta}\right]^{-1}\left[\frac{1}{4}\left(\gamma+\frac{\pi i m}{\theta}\right)^{-1}\left(c-c^{\prime}\right)^{2}+\frac{\pi i m}{\theta}\left(c+c^{\prime}\right)\right]+\left(2 \gamma+\frac{\pi i m}{\theta}\right)\right\}^{-1} .

& =\frac{1}{2^{5}(n+1)}\left\{\prod_{k=1}^{4}\left(2-\delta_{0, j_{k}}\right)\right\}^{1 / 2} \sum_{\iota_{1}, \ldots, \iota_{4} \in\{-1,1\}} \cos \left(\frac{\pi}{2(n+1)} \sum_{k=1}^{4} \iota_{k} j_{k}\right) 1_{2(n+1) \mathbb{Z}}\left(\sum_{k=1}^{4} \iota_{k} j_{k}\right)
\end{aligned}
$$

Therefore we can write

& \times \exp \left\{\mathrm{i} \pi\left(\iota u+\iota^{\prime} u^{\prime}+\iota_{1} u_{1}+\iota_{1}^{\prime} u_{1}^{\prime}\right)\right\} \sum_{q \in \mathbb{Z}} \delta_{q}\left(\iota u+\iota^{\prime} u^{\prime}+\iota_{1} u_{1}+\iota_{1}^{\prime} u_{1}^{\prime}\right)+O_{m}\left(\frac{1}{n}\right), \tag{C.14}
\end{align*}
$$

where $O_{m}\left(\frac{1}{n}\right) \leqslant \frac{C}{n}$ for some constant $C>0$, independent of $n$ and $m$, and

\mathfrak{V}_{m}\left(u, u^{\prime}\right):=\Theta_{m}\left(\omega_{0}^{2}+4 \sin ^{2}\left(\frac{\pi u}{2}\right), \omega_{0}^{2}+4 \sin ^{2}\left(\frac{\pi u^{\prime}}{2}\right)\right) \cos \left(\frac{\pi u}{2}\right) \cos \left(\frac{\pi u^{\prime}}{2}\right) .

We claim that there exists $C>0$, independent of $n$ and $m$, such that $\mathfrak{V}_{m}\left(u, u^{\prime}\right) \leqslant C$ for all $u, u^{\prime} \in\left[0, \omega_{0}^{2}+4\right]$. Indeed, as can be seen directly from (C.6), we have $\lim _{m \rightarrow+\infty} \Theta_{m}\left(c, c^{\prime}\right)=0$ uniformly in $c, c^{\prime} \in\left[0, \omega_{0}^{2}+4\right]$. On the other hand the
function $\mathbb{R} \times\left[0, \omega_{0}^{2}+4\right]^{2} \ni\left(m, c, c^{\prime}\right) \rightarrow \Theta_{m}\left(c, c^{\prime}\right)$ is bounded on compact set. If otherwise, this would imply that there exist $\left(m, c, c^{\prime}\right) \in \mathbb{R} \times\left[0, \omega_{0}^{2}+4\right]^{2}$ such that

$$
\begin{aligned}
& 0=\left[\left(2 \gamma+\frac{\pi i m}{\theta}\right)\left(c+c^{\prime}+2\left(\gamma+\frac{\pi i m}{\theta}\right) \frac{\pi i m}{\theta}\right)\right]^{-1} \\
& \times\left[\frac{1}{4}\left(\gamma+\frac{\pi i m}{\theta}\right)^{-1}\left(c-c^{\prime}\right)^{2}+\frac{\pi i m}{\theta}\left(c+c^{\prime}\right)\right]+1 .
\end{aligned}
$$

An easy calculation gives $c+c^{\prime}=\gamma^{2}-2 \alpha^{2}$ and $\left(c-c^{\prime}\right)^{2}=8\left(\alpha^{2}+\gamma^{2}\right)^{2}$, where $\alpha=\pi m / \theta$. This leads to a contradiction, as then $\left|c-c^{\prime}\right|>c+c^{\prime}$ (but both $c, c^{\prime}>0$ ). Thus the conclusion of the lemma follows.
C.3. Proof of Lemma 9.4. From (A.18) we obtain

$$
\left[e^{-A t}\right]_{x+n+1, x^{\prime}+n+1}=\sum_{j=0}^{n} E_{j}(t) \psi_{j}(x) \psi_{j}\left(x^{\prime}\right),
$$

where (cf (6.18))

$$
E_{j}(t):=\frac{1}{2 \sqrt{\gamma^{2}-\mu_{j}}}\left[-\lambda_{j,+} \exp \left\{\lambda_{j,+} t\right\}+\lambda_{j,-} \exp \left\{\lambda_{j,-t} t\right], \quad \text { if } \mu_{j} \neq \gamma^{2} .\right.
$$

In the case $\mu_{j}=\gamma^{2}\left(\right.$ then $\lambda_{j, \pm}=\gamma$, cf (A.19)) we have $E_{j}(t):=(1-\gamma t) e^{-\gamma t}$. Using (A.6) we obtain therefore

$$
\begin{align*}
& \bar{p}_{x}(t)=\frac{1}{n^{1 / 2}} \sum_{j=0}^{n} \int_{0}^{+\infty} \mathcal{F}((t-s) / \theta)\left[e^{-A s}\right]_{x+n+1,2 n+1} \mathrm{~d} s  \tag{C.15}\\
& =\frac{1}{n^{1 / 2}} \sum_{j=0}^{n} \psi_{j}(x) \psi_{j}(n) \int_{0}^{+\infty} \mathcal{F}((t-s) / \theta) E_{j}(s) \mathrm{d} s .
\end{align*}
$$

From (C.15) we conclude that there exists $\mathfrak{p}_{*}>0$ such that

$$
\begin{equation*}
\sup _{t \in \mathbb{R}, x=0, \ldots, n}\left|\bar{p}_{x}(t)\right| \leqslant \frac{\mathfrak{p}_{*}}{n^{1 / 2}}, \quad n=1,2, \ldots . \tag{C.16}
\end{equation*}
$$

Estimate (9.11) is then a straightforward consequence of (C.16) and (4.11).
C.4. Proof of Lemma 9.5. Multiplying both sides of (9.4) by $V_{x}(t)$ and averaging over time we get

$$
\begin{align*}
& \left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle=\sum_{x^{\prime}=1}^{n} \int_{0}^{\theta} \mathfrak{g}_{x, x^{\prime}}(s)\left\langle\left\langle V_{x}(\cdot) V_{x^{\prime}}(\cdot-s)\right\rangle\right\rangle \mathrm{d} s+\left\langle\left\langle V_{x} v_{x}\right\rangle\right\rangle  \tag{C.17}\\
& \leqslant \sum_{x^{\prime}=1}^{n} M_{x, x^{\prime}}\left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle^{1 / 2}\left\langle\left\langle V_{x^{\prime}}^{2}\right\rangle\right\rangle^{1 / 2}+\left\langle\left\langle V_{x} v_{x}\right\rangle\right\rangle .
\end{align*}
$$

Summing up over $x$ we obtain

$$
\begin{aligned}
& \sum_{x, x^{\prime}=0}^{n}\left(\delta_{x, x^{\prime}}-M_{x, x^{\prime}}\right)\left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle^{1 / 2}\left\langle\left\langle V_{x^{\prime}}^{2}\right\rangle\right\rangle^{1 / 2}+\left\langle\left\langle V_{0}^{2}\right\rangle\right\rangle^{1 / 2} \sum_{x=0}^{n} M_{x, 0}\left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle^{1 / 2} \\
& \leqslant \sum_{x=0}^{n}\left\langle\left\langle V_{x} v_{x}\right\rangle\right\rangle .
\end{aligned}
$$

Using (7.4) and the Cauchy-Schwarz inequality we obtain in particular that

$$
M_{0,0}\left\langle\left\langle V_{0}^{2}\right\rangle\right\rangle \leqslant\left\{\sum_{x=0}^{n}\left\langle\left\langle V_{x}^{2}\right\rangle\right\rangle\right\}^{1 / 2}\left\{\sum_{x=0}^{n}\left\langle\left\langle v_{x}^{2}\right\rangle\right\rangle\right\}^{1 / 2} \leqslant \frac{C}{n}\left\{\sum_{x=0}^{n}\left\langle\left\langle V_{x}\right\rangle\right\rangle^{2}\right\}^{1 / 2}
$$

for some $C>0$ independent of $n$. The last estimate follows from (9.11). To finish the proof note that from (7.2) we have

$$
\begin{aligned}
& M_{0,0}=\frac{4}{(n+1)^{2}} \sum_{j, j^{\prime}=0}^{n}\left(1-\delta_{0, j}\right)\left(1-\delta_{0, j^{\prime}}\right) \Theta\left(\mu_{j}, \mu_{j^{\prime}}\right) \cos ^{2}\left(\frac{\pi j}{2(n+1)}\right) \cos ^{2}\left(\frac{\pi j^{\prime}}{2(n+1)}\right) \\
& \approx 4 \gamma^{2} \int_{0}^{1} \int_{0}^{1} \frac{\left[\omega_{0}^{2}+2 \sin ^{2}(\pi u / 2)+2 \sin ^{2}\left(\pi u^{\prime} / 2\right)\right] \cos ^{2}(\pi u / 2) \cos ^{2}\left(\pi u^{\prime} / 2\right) \mathrm{d} u \mathrm{~d} u^{\prime}}{\gamma^{2}\left(\omega_{0}^{2}+2 \sin ^{2}(\pi u / 2)+2 \sin ^{2}\left(\pi u^{\prime} / 2\right)\right)+\left(\sin ^{2}(\pi u / 2)-\sin ^{2}\left(\pi u^{\prime} / 2\right)\right)^{2}},
\end{aligned}
$$

where the equality holds up to a term of order $O(1 / n)$.

## Appendix D. Calculation of $\mathcal{Q}^{a, b}(\ell)$

Consider the Green's function of $-\Delta+\omega_{0}^{2}$ given by (2.15). We can write

$$
\begin{equation*}
G_{\omega_{0}^{2}}(x)=\lim _{\eta \rightarrow 0+} \frac{1}{\lambda \sqrt{1+4 / \lambda}}\left\{1+\frac{\lambda}{2}\left(1+\sqrt{1+\frac{4}{\lambda}}\right)\right\}_{\mid \lambda=\omega_{0}^{2}+i \eta}^{-|x|}, \quad x \in \mathbb{Z} . \tag{D.1}
\end{equation*}
$$

Here the square root denotes the branch of the inverse of $z \mapsto z^{2}$ such that $\operatorname{Re} \sqrt{\lambda}>0$, when $\lambda \in \mathbb{C} \backslash(-\infty, 0]$. By the analytic continuation we have therefore

$$
\begin{align*}
& G_{\lambda}(x)=(-\Delta+\lambda)^{-1}(x)=\int_{0}^{1} \frac{\cos (2 \pi u x) d u}{4 \sin ^{2}(\pi u)+\lambda} \\
& =\frac{1}{\lambda \sqrt{1+4 / \lambda}}\left\{1+\frac{\lambda}{2}\left(1+\sqrt{1+\frac{4}{\lambda}}\right)\right\}^{-|x|}, \quad x \in \mathbb{Z} \tag{D.2}
\end{align*}
$$

for $\lambda \in \mathbb{C} \backslash[-4,0]$.
Recall that $\mathcal{Q}^{a, b}(\ell)$ is given by (3.4) and (3.5) with $a+b=1 / 2$. Let
$\widetilde{\mathcal{Q}}^{-1 / 2,0}(\ell)=4 \gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(\frac{2 \pi \ell}{\theta}\right)^{2} \int_{0}^{1} \cos ^{2}\left(\frac{\pi z}{2}\right)\left\{\left[4 \sin ^{2}\left(\frac{\pi z}{2}\right)+\omega_{0}^{2}-\left(\frac{2 \pi \ell}{\theta}\right)^{2}\right]^{2}+\left(\frac{4 \gamma \pi \ell}{\theta}\right)^{2}\right\}^{-1} \mathrm{~d} z$
and
$\widetilde{\mathcal{Q}}^{b-1 / 2, b}(\ell)=4 \gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(\frac{2 \pi \ell}{\theta}\right)^{2} \int_{0}^{1} \cos ^{2}\left(\frac{\pi z}{2}\right)\left[4 \sin ^{2}\left(\frac{\pi z}{2}\right)+\omega_{0}^{2}\right]^{-2} \mathrm{~d} z, \quad$ when $b>0$.
Let

$$
\lambda\left(\omega_{0}\right):=\omega_{0}^{2}-\left(\frac{2 \pi \ell}{\theta}\right)^{2}+i\left(\frac{4 \gamma \pi \ell}{\theta}\right) .
$$

We have

$$
\widetilde{\mathcal{Q}}^{-1 / 2,0}(\ell)=-\frac{2 \pi \ell|\widetilde{\mathcal{F}}(\ell)|^{2}}{\theta} \operatorname{Im}\left(\int_{0}^{1} \frac{[1+\cos (2 \pi z)] \mathrm{d} z}{4 \sin ^{2}(\pi z)+\lambda\left(\omega_{0}\right)}\right)
$$

Using (D.2) we can write

$$
\begin{aligned}
& \widetilde{\mathcal{Q}}^{-1 / 2,0}(\ell)=-\frac{2 \pi \ell|\widetilde{\mathcal{F}}(\ell)|^{2}}{\theta} \operatorname{Im}\left(G_{\lambda\left(\omega_{0}\right)}(0)+G_{\lambda\left(\omega_{0}\right)}(1)\right) \\
& =-\frac{2 \pi \ell|\widetilde{\mathcal{F}}(\ell)|^{2}}{\theta} \operatorname{Im}\left(\left\{\frac{2}{\lambda\left(\omega_{0}\right) \sqrt{1+4 / \lambda\left(\omega_{0}\right)}}+\frac{1}{2}\right\}\left\{1+\frac{\lambda\left(\omega_{0}\right)}{2}\left(1+\sqrt{1+\frac{4}{\lambda\left(\omega_{0}\right)}}\right)\right\}^{-1}\right)
\end{aligned}
$$

Next, for $b>0$, we have

$$
\begin{aligned}
& \widetilde{\mathcal{Q}}^{b-1 / 2, b}(\ell)=4 \gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(\frac{2 \pi \ell}{\theta}\right)^{2} \int_{0}^{1} \frac{\cos ^{2}(\pi z) \mathrm{d} z}{\left[4 \sin ^{2}(\pi z)+\omega_{0}^{2}\right]^{2}} \\
& =2 \gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(\frac{2 \pi \ell}{\theta}\right)^{2} \int_{0}^{1} \frac{[1+\cos (2 \pi z)] \mathrm{d} z}{\left[2+\omega_{0}^{2}-2 \cos (2 \pi z)\right]^{2}}=\gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(\frac{2 \pi \ell}{\theta}\right)^{2} \mathcal{I},
\end{aligned}
$$

where

$$
\begin{equation*}
\mathcal{I}:=\frac{1}{2 \pi i} \int_{C} f(\zeta) \mathrm{d} \zeta \tag{D.5}
\end{equation*}
$$

is the integral over the circle $C:=[|\zeta|=1]$, oriented counter-clockwise and

$$
f(\zeta):=\left(\frac{\zeta+1}{1+\left(2+\omega_{0}^{2}\right) \zeta-\zeta^{2}}\right)^{2}
$$

The poles of $f(\zeta)$ occur at

$$
\zeta_{ \pm}:=\frac{1}{2}\left[2+\omega_{0}^{2} \pm \sqrt{\omega_{0}^{4}+4 \omega_{0}^{2}+8}\right] .
$$

We have $\left|\zeta_{-}\right|<1<\zeta_{+}$and

$$
f(\zeta):=\left(\frac{A_{-}}{\zeta-\zeta_{-}}+\frac{A_{+}}{\zeta-\zeta_{+}}\right)^{2}
$$

with

$$
A_{-}:=\frac{\zeta_{-}+1}{\zeta_{-}-\zeta_{+}}, \quad A_{+}:=\frac{\zeta_{+}+1}{\zeta_{+}-\zeta_{-}}
$$

Hence, after performing the contour integration, we get

$$
\mathcal{I}=2 A_{-} A_{+}\left(\frac{1}{2 \pi i} \int_{C} \frac{1}{\zeta-\zeta_{+}} \cdot \frac{\mathrm{d} \zeta}{\zeta-\zeta_{-}}\right)=\frac{2 A_{-} A_{+}}{\zeta_{-}-\zeta_{+}}=\frac{2\left(\zeta_{-}+1\right)\left(\zeta_{+}+1\right)}{\left(\zeta_{+}-\zeta_{-}\right)^{3}}
$$

Since

$$
\zeta_{-} \zeta_{+}=1, \quad \zeta_{-}+\zeta_{+}=2+\omega_{0}^{2}, \quad \zeta_{+}-\zeta_{-}=\sqrt{\omega_{0}^{4}+4 \omega_{0}^{2}+8}
$$

we obtain

$$
\mathcal{I}=\frac{2\left(4+\omega_{0}^{2}\right)}{\left(\omega_{0}^{4}+4 \omega_{0}^{2}+8\right)^{3 / 2}} .
$$

and

$$
\widetilde{\mathcal{Q}}^{b-1 / 2, b}(\ell)=\left(\frac{2 \pi \ell}{\theta}\right)^{2} \frac{2 \gamma|\widetilde{\mathcal{F}}(\ell)|^{2}\left(4+\omega_{0}^{2}\right)}{\left(\omega_{0}^{4}+4 \omega_{0}^{2}+8\right)^{3 / 2}} .
$$
