# A NEW APPROACH FOR THE FRACTIONAL LAPLACIAN VIA DEEP NEURAL NETWORKS 

NICOLÁS VALENZUELA


#### Abstract

The fractional Laplacian has been strongly studied during past decades, see e.g. [9]. In this paper we present a different approach for the associated Dirichlet problem, using recent deep learning techniques. In fact, intensively PDEs with a stochastic representation have been understood via neural networks, overcoming the so-called curse of dimensionality. Among these equations one can find parabolic ones in $\mathbb{R}^{d}$, see [20], and elliptic in a bounded domain $D \subset \mathbb{R}^{d}$, see [15].

In this paper we consider the Dirichlet problem for the fractional Laplacian with exponent $\alpha \in(1,2)$. We show that its solution, represented in a stochastic fashion by 22, can be approximated using deep neural networks. We also check that this approximation does not suffer from the curse of dimensionality. The spirit of our proof follows the ideas in [15], with important variations due to the nonlocal nature of the fractional Laplacian; in particular, the stochastic representation is given by an $\alpha$-stable isotropic Lévy process, and not given by a standard Brownian motion.

## 1. Introduction

1.1. Motivation. Deep neural networks (DNNs) have become recent key actors in the study of partial differential equations (PDEs) [29, 30, 20]. Among them, deep learning based algorithms have provided new insights for the approximation of certain PDEs, see e.g. [3, 4, 16, 29, 30]. The corresponding numerical simulations suggest that DNNs overcome the so-called curse of dimensionality, in the sense that the number of real parameters that describe the DNN is bounded by a polynomial on the dimension $d$, and on the reciprocal of the accuracy of the approximation. Even better, recent works have theoretically proved that certain PDEs can be approximated by DNNs, overcoming the curse of dimensionality, see e.g. [5, 14, 15, 17, 20, 21].

In order to describe the previous results in more detail, we start by considering the classical Dirichlet boundary value Problem in $d$-dimensions over a bounded, convex domain $D \subset \mathbb{R}^{d}$ :

$$
\left\{\begin{aligned}
-\Delta u(x)=f(x) & x \in D \\
u(x)=g(x) & x \in \partial D
\end{aligned}\right.
$$

where $f, g$ are suitable continuous functions. In a recent work, Grohs and Herrmann 15 proved that DNNs overcome the curse of dimensionality in the approximation of solution of the above problem. More precisely, they used stochastic techniques such as the Feynman-Kac formula, the so-called Walk-on-Spheres (WoS) processes (defined in Section (4) and Monte Carlo simulations in order to show that DNNs approximate the exact solution, with arbitrary precision.

The main purpose of this paper is to extend the nice results obtained by Grohs and Herrman in the case of the fractional Laplacian $(-\Delta)^{\alpha / 2}$, with $\alpha \in(0,2)$, formally defined in $\mathbb{R}^{d}$ as

$$
\begin{equation*}
-(-\Delta)^{\alpha / 2} u(x)=c_{d, \alpha} \lim _{\varepsilon \downarrow 0} \int_{\mathbb{R}^{d} \backslash B(0, \varepsilon)} \frac{u(y)-u(x)}{|y-x|^{d+\alpha}} d y, \quad x \in \mathbb{R}^{d} \tag{1.1}
\end{equation*}
$$

where $c_{d, \alpha}=-\frac{2^{\alpha} \Gamma((d+\alpha) / 2)}{\pi^{d / 2} \Gamma(-\alpha / 2)}$ and $\Gamma(\cdot)$ is the classical Gamma function. We also prove that DNNs overcome the curse of dimensionality in this general setting, a hard problem, specially because of the nonlocal character of the problem. However, some recent findings are key to fully describe the problem here. Indeed, Kyprianou et al. [22] showed that the Feynman-Kac
formula and the WoS processes are also valid in the nonlocal case. We will deeply rely on these results to reproduce the Grohs and Herrmann program.
1.2. Setting. Let $\alpha \in(0,2), d \in \mathbb{N}$ and $D \subset \mathbb{R}^{d}$ a bounded domain. Consider the following Dirichlet boundary value problem

$$
\left\{\begin{align*}
(-\Delta)^{\alpha / 2} u(x) & =f(x) & & x \in D,  \tag{1.2}\\
u(x) & =g(x) & & x \in D^{c} .
\end{align*}\right.
$$

Here, $f, g$ are functions that satisfy suitable assumptions. More precisely, we ask for the following:

- $g: D^{c} \rightarrow \mathbb{R}$ is a $L_{g}$-Lipschitz continuous function in $L_{\alpha}^{1}\left(D^{c}\right), L_{g}>0$, that is to say

$$
\begin{equation*}
\int_{D^{c}} \frac{|g(x)|}{1+|x|^{d+\alpha}} d x<\infty \tag{Hg-0}
\end{equation*}
$$

- $f: D \rightarrow \mathbb{R}$ is a $L_{f}$-Lipschitz continuous function, $L_{f}>0$, such that

$$
\begin{equation*}
f \in C^{\alpha+\varepsilon_{0}}(\bar{D}) \quad \text { for some fixed } \quad \varepsilon_{0}>0 . \tag{Hf-0}
\end{equation*}
$$

These assumptions are standard in the literature (see e.g. [22), and are required to give a rigorous sense to the continuous solution in $L_{\alpha}^{1}\left(\mathbb{R}^{d}\right)$ of (1.2) in terms of the stochastic representation

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(X_{\sigma_{D}}\right)\right]+\mathbb{E}_{x}\left[\int_{0}^{\sigma_{D}} f\left(X_{s}\right) d s\right], \tag{1.3}
\end{equation*}
$$

where $\left(X_{t}\right)_{t \geq 0}$ is an $\alpha$-stable isotropic Lévy process and $\sigma_{D}$ is the exit time of $D$ for this process. See Theorem 5.1 below for full details.

Problem (1.2) has attracted considerable interest in past decades. Starting from the foundational work by Caffarelli and Silvestre [9], the study of fractional problems has always required a great amount of detail and very technical mathematics. The reader can consult the monographs by [2, 8, 18, 22, 25]. The work of Kyprianou et al. [22] proved that the solution of Problem (1.2) can be represented with the WoS processes described formally in Section (4, namely

\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(\rho_{N}\right)\right]+\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} V_{1}\left(0, f\left(\rho_{n-1}+r_{n} \cdot\right)\right)\right], \tag{1.4}
\end{equation*}
$$

where $\left(\rho_{n}\right)_{n=0}^{N}$ is the WoS process starting at $\rho_{0}=x \in D, N=\min \left\{n \in \mathbb{N}: \rho_{n} \notin D\right\}$ and $r_{n}=\operatorname{dist}\left(\rho_{n-1}, \partial D\right) . V_{1}(0,1(\cdot))$ is defined in Section 5 and represents the expected occupation of the stable process exiting the unit ball centered at the origin.

In this paper we propose a new approach to the Problem (1.2) in terms of some deep learning techniques. We will work with the DNNs described formally in the Section 38 In particular, we work with DNNs with $H \in \mathbb{N}$ hidden layers, one input and one output layer, each layer with dimension $k_{i} \in \mathbb{N}, i=0, \ldots, H+1$. For $i=1, \ldots, H+1$ the weights and biases of the DNN are denoted as $W_{i} \in \mathbb{R}^{k_{i} \times k_{i-1}}$ and $B_{i} \in \mathbb{R}^{k_{i}}$. The DNN is represented by his weights and biases as $\Phi=\left(\left(W_{1}, B_{1}\right), \ldots,\left(W_{H+1}, B_{H+1}\right)\right)$. For $x_{0} \in \mathbb{R}^{k_{0}}$ the realization of the DNN $\Phi$ is defined as

$$
\mathcal{R}(\Phi)\left(x_{0}\right)=W_{H+1} x_{H}+B_{H+1},
$$

where $x_{i} \in \mathbb{R}^{k_{i}}, i=1, \ldots, H$ is defined as

$$
x_{i}=A\left(W_{i} x_{i-1}+B_{i}\right) .
$$

Here $A(\cdot)$ is the activation function of the DNN. In our case we work with activation function of $\operatorname{ReLu}$ type $(A(x)=\max \{x, 0\})$. The number of parameters used to describe the DNN and the dimension of the layers are defined as

$$
\mathcal{P}(\Phi)=\sum_{i=1}^{H+1} k_{i}\left(k_{i-1}+1\right), \quad \mathcal{D}(\Phi)=\left(k_{0}, \ldots, k_{H+1}\right),
$$

respectively. For the approximation of (1.3), we need to assume some hypothesis in relation to the implicated functions. In particular, we suppose that $g$, $\operatorname{dist}(\cdot, \partial D),(\cdot)^{\alpha}$ and $f$ can be approximated by ReLu DNNs $\Phi_{g}, \Phi_{\text {dist }}, \Phi_{\alpha}$ and $\Phi_{f}$ that overcome the curse of dimensionality. The full details of the hypotheses can be found in Assumptions [1, 2 and 3 defined in Section 6. Our main result is the following:

Theorem 1.1. Let $\alpha \in(1,2), p, s \in(1, \alpha)$ such that $s<\frac{\alpha}{p}$ and $q \in\left[s, \frac{\alpha}{p}\right)$. Assume that (Hg-0) and (Hf-0) are satisfied. Suppose that for every $\delta_{\alpha}, \delta_{\text {dist }}, \delta_{f}, \delta_{g} \in(0,1)$ there exist ReLu DNNs $\Phi_{g}, \Phi_{\alpha}, \Phi_{\text {dist }}$ and $\Phi_{f}$ satisfying Assumptions 1, 园 and [3, respectively. Then for every $\epsilon \in(0,1)$, there exists a ReLu DNN $\Psi_{\epsilon}$ and its realization $\mathcal{R}\left(\Psi_{\epsilon}\right): D \rightarrow \mathbb{R}$ which is a continuous function such that:
(1) Proximity in $L^{q}(D)$ : If $u$ is the solution of (1.2)

$$
\begin{equation*}
\left(\int_{D}\left|u(x)-\left(\mathcal{R}\left(\Psi_{\epsilon}\right)\right)(x)\right|^{q} d x\right)^{\frac{1}{q}} \leq \epsilon . \tag{1.5}
\end{equation*}
$$

(2) Bounds: There exists $\widehat{B}, \eta>0$ such that

$$
\begin{equation*}
\mathcal{P}\left(\Psi_{\epsilon}\right) \leq \widehat{B}|D|^{\eta} d^{\eta} \epsilon^{-\eta} . \tag{1.6}
\end{equation*}
$$

The constant $\widehat{B}$ depends on $\|f\|_{L^{\infty}(D)}$, the Lipschiptz constants of $g, \mathcal{R}\left(\Phi_{f}\right)$ and $\mathcal{R}\left(\Phi_{\alpha}\right)$, and on $\operatorname{diam}(D)$.
1.3. Idea of the proof. In this section we sketch the proof of Theorem 1.1. Following [15], we will work with each of the terms in (1.4) by separated, and for each of them we will prove that the value for the solution can be approximated by DNN that do not suffer the curse of dimensionality. For full details see Propositions 6.1 and 7.1 . We will sketch the proof of the homogeneous part, the other term is pretty similar.

The proof will be divided in several steps: First of all we approximate in expectation the respective term of (1.4) with Monte Carlo simulations. Due the nature of WoS processes we need to approximate also random variables such as copies of the number of iterations in the WoS process $N$ and copies of the norm of isotropic $\alpha$-stable process exiting a unit ball centered at the origin, $\left|X_{\sigma_{B(0,1)}}\right|$. Next we find Monte Carlo simulations that approximate the term of (1.4) punctually and latter in $L^{q}(D)$, whose copies satisfy also the approximations of $N$ and $\left|X_{\sigma_{B(0,1)} \mid}\right|$ mentioned before. Those additional terms help us to find ReLu DNNs that approximates the WoS proccesses, then we can approximate the Monte Carlo simulation by a ReLu DNN. Next we use the found ReLu DNN to approximate the term of (1.4), using suitable choices of the parameters in order to have an accuracy of $\epsilon \in(0,1)$ in the approximation. Finally we study the found ReLu DNN, and we prove that the total number of parameters that describes de DNN are at most polynomial in the dimension and in the reciprocal of the accuracy.
1.4. Discussion. As stated before, for the approximation of the solutions of Problem (1.2) we follow the ideas presented in the work of Grohs and Herrmann [15], with several changes due the non local nature of the fractional Laplacian. In particular:
(1) The non local problem has the boundary condition $g$ defined on the complement of the domain $D$ and the local problem has $g$ defined on $\partial D$. This variation changes the way to approximates $g$ by DNNs. The Assumption 1 is classical in the literature for functions defined in unbounded sets (see, e.g. [20]).
(2) The isotropic $\alpha$-stable process associated to the fractional Laplacian has no second moment, therefore the approximation can not be approximated in $L^{2}(D)$, but in $L^{q}(D)$ for some suitable $q<2$.
(3) The process associated to the local case is a Brownian motion that is continuous, then the norm of the process exiting the unit ball centered at the origin is equal to 1 , i.e, $\left|X_{\sigma_{B(0,1)}}\right|=1$. In the non local case the isotropic $\alpha$-stable is a pure jump process, therefore $\left|X_{\sigma_{B(0,1)}}\right|>1$. This is the reason that in our proof we approximate the copies of this random variable to have that the copies of $X_{\sigma_{B(0,1)}}$ exits near the domain $D$.
(4) The last notable difference is about the sum that appears in (1.4): The value of $r_{n}$ is raised to the power of $\alpha$, then we need an extra hypothesis for the approximation of the function $(\cdot)^{\alpha}$ by DNNs. In the local case $r_{n}$ is squared, then can be approximated by DNNs using the Lemma 3.7 stated in the Section 3.

A similar way to represent solutions to the Problem (1.2) is found in the work of Gulian and Pang [18]. Thanks to stochastic calculus results (see, e.g. [1, 6]), the processes described in that work and the isotropic $\alpha$-stable processes are similar. In addition, in that paper they found a Feynman-Kac formula for the parabolic generalized problem for the associated fractional Laplacian. In a possible extension we could see if the parabolic generalized problem can be adapted to our setting, i.e. the solution of the parabolic case can be approximated by DNNs that overcome the curse of dimensionality.

Finally, just before finishing this work, we learned about the research by Changtao Sheng et al. [27, who have showed numerical simulations of the Problem (1.2) using similar Monte Carlo methods. However, our methods are radically different in terms of the main goal, which is here to approximate the solution by DNNs in a rigorous fashion.

## 2. Preliminaries

2.1. Notation. Along this paper, we shall use the following conventions:

- $\mathbb{N}=\{1,2,3, \ldots\}$ will be the set of Natural numbers.
- For any $q \geq 1,(\Omega, \mathcal{F}, \mu)$ measure space, $L^{q}(\Omega, \mu)$ denotes the Lebesgue space of order $q$ with the measure $\mu$. If $\mu$ is the Lebesgue measure, then the Lebesgue space will be denoted as $L^{q}(\Omega)$.
2.2. A quick review on Lévy processes. Let us introduce a brief review on the Lévy processes needed for the proof of the main results. For a detailed account on these processes, see e.g. [1, 6, 23, 26].

Definition 2.1. $L:=\left(L_{t}\right)_{t \geq 0}$ is a Lévy process in $\mathbb{R}^{d}$ if it satisfies $L_{0}=0$ and
i) L has independent increments, namely, for all $n \in \mathbb{N}$ and for each $0 \leq t_{1}<\ldots<t_{n}<$ $\infty$, the random variables $\left(L_{t_{2}}-L_{t_{1}}, \ldots, L_{t_{n}}-L_{t_{n-1}}\right)$ are independent.
ii) L has stationary increments, namely, for all $s \geq 0, L_{t+s}-L_{s}$ and $L_{t}$ have the same law.
iii) $L_{t}$ is continuous on the right and has limit on the left for all $t>0$ (i.e., $\left(L_{t}\right)_{t \geq 0}$ is càdlàg).

Examples of Lévy processes are the Brownian motion, but also processes with jumps such as the Poisson process and the compound Poisson process [1].

Definition 2.2. The Poisson process of intensity $\lambda>0$ is a Lévy process $N$ taking values in $\mathbb{N} \cup\{0\}$ wherein each $N(t) \sim \operatorname{Poisson}(\lambda t)$, then we have

$$
\mathbb{P}(N(t)=n)=\frac{(\lambda t)^{n}}{n!} e^{-\lambda t}
$$

Definition 2.3. Let $(Z(n))_{n \in \mathbb{N}}$ be a sequence of i.i.d. random variables taking values in $\mathbb{R}^{d}$ with law $\mu$ and let $N$ be a Poisson process with intensity $\lambda$ that is independent of all the $Z(n)$. The compound Poisson process $Y$ is defined as follows:

$$
Y(t)=Z(1)+\ldots+Z(N(t))
$$

for each $t \geq 0$.
Another important element is the so-called Lévy's characteristic exponent.
Definition 2.4. Let $\left(L_{t}\right)_{t \geq 0}$ be a Lévy process in $\mathbb{R}^{d}$.

- Its characteristic exponent $\Psi: \mathbb{R}^{d} \rightarrow \mathbb{C}$ is the continuous function that satisfies $\Psi(0)=$ 0 and for all $t \geq 0$,

$$
\begin{equation*}
\mathbb{E}\left[e^{i \xi \cdot L_{t}}\right]=e^{-t \Psi(\xi)}, \quad \xi \in \mathbb{R}^{d} \backslash\{0\} \tag{2.1}
\end{equation*}
$$

- $A$ Lévy triple is $(b, A, \Pi)$, where $b \in \mathbb{R}^{d}, A \in \mathbb{R}^{d \times d}$ is a positive semi-definite matrix, and $\Pi$ is a Lévy measure in $\mathbb{R}^{d}$, i.e.

$$
\begin{equation*}
\Pi(\{0\})=0 \quad \text { and } \quad \int_{\mathbb{R}^{d}}\left(1 \wedge|z|^{2}\right) \Pi(d z)<\infty \tag{2.2}
\end{equation*}
$$

A Lévy process is uniquely determined via its Lévy triple and its characteristic exponent.
Theorem 2.1 (Lévy-Khintchine, [23]). Let $(b, A, \Pi)$ be a Lévy triple. Define for each $\xi \in \mathbb{R}^{d}$

$$
\begin{equation*}
\Psi(\xi)=i b \cdot \xi+\frac{1}{2} \xi \cdot A \xi+\int_{\mathbb{R}^{d}}\left(1-e^{i \xi \cdot z}+i \xi \cdot z \mathbf{1}_{\{|z|<1\}}\right) \Pi(d z) \tag{2.3}
\end{equation*}
$$

If $\Psi$ is the characteristic exponent of a Lévy process with triple $(b, A, \Pi)$ in the sense of (2.1), then it necessarily satisfies (2.3). Conversely, given (2.3) there exists a probability space $(\Omega, \mathcal{F}, \mathbb{P})$, on which a Lévy process is defined having characteristic exponent $\Psi$ in the sense of (2.1).

For the next Theorem we define the Poisson random measure.
Definition 2.5. Let $(S, \mathcal{S}, \eta)$ be an arbitrary $\sigma$-finite measure space and $(\Omega, \mathcal{F}, \mathbb{P})$ a probability space. Let $N: \Omega \times \mathcal{S} \rightarrow \mathbb{N} \cup\{0, \infty\}$ such that $(N(\cdot, A))_{A \in \mathcal{S}}$ is a family of random variables defined on $(\Omega, \mathcal{F}, \mathbb{P})$. For convenience we supress the dependency of $N$ on $\omega$. $N$ is called a Poisson random measure on $S$ with intensity $\eta$ if
i) For mutually disjoint $A_{1}, \ldots, A_{n}$ in $\mathcal{S}$, the variables $N\left(A_{1}\right), \ldots, N\left(A_{n}\right)$ are independent.
ii) For each $A \in \mathcal{S}, N(A) \sim \operatorname{Poisson}(\eta(A))$,
iii) $N(\cdot)$ is a measure $\mathbb{P}$-almost surely.

Remark 2.1. In the next theorem we use $S \subset[0, \infty) \times \mathbb{R}^{d}$, and the intensity $\eta$ will be defined on the product space.

From the Lévy-Khintchine formula, every Lévy process can be decomposed in three components: a Brownian part with drift, the large jumps and the compensated small jumps of the process $L$.

Theorem 2.2 (Lévy-Itô Decomposition). Let $L$ be a Lévy process with triple ( $b, A, \Pi$ ). Then there exists process $L^{(1)}, L^{(2)}$ y $L^{(3)}$ such that for all $t \geq 0$

$$
L_{t}=L_{t}^{(1)}+L_{t}^{(2)}+L_{t}^{(3)}
$$

where
(1) $L_{t}^{(1)}=b t+A B_{t}$ and $B_{t}$ is a standard d-dimensional Brownian motion.
(2) $L_{t}^{(2)}$ satisfies

$$
L_{t}^{(2)}=\int_{0}^{t} \int_{|z| \geq 1} z N(d s, d z)
$$

where $N(d s, d z)$ is a Poisson random measure on $[0, \infty) \times\left\{z \in \mathbb{R}^{d}:|z| \geq 1\right\}$ with intensity

$$
\Pi\left(\left\{z \in \mathbb{R}^{d}:|z| \geq 1\right\}\right) d t \times \frac{\Pi(d z)}{\Pi\left(\left\{z \in \mathbb{R}^{d}:|z| \geq 1\right\}\right)}
$$

If $\Pi\left(\left\{z \in \mathbb{R}^{d}:|z| \geq 1\right\}\right)=0$, then $L^{(2)}$ is the process identically equal to 0 . In other words $L^{(2)}$ is a compound Poisson process.
(3) The process $L_{t}^{(3)}$ satisfies

$$
L_{t}^{(3)}=\int_{0}^{t} \int_{|z|<1} z \widetilde{N}(d s, d z)
$$

where $\tilde{N}(d s, d z)$ is the compensated Poisson random measure, defined by

$$
\widetilde{N}(d s, d z)=N(d s, d z)-d s \Pi(d z)
$$

with $N(d s, d z)$ the Poisson random measure on $[0, \infty) \times\left\{z \in \mathbb{R}^{d}:|z|<1\right\}$ with intensity

$$
d s \times\left.\Pi(d z)\right|_{\left\{z \in \mathbb{R}^{d}:|z|<1\right\}} .
$$

2.3. Lévy processes and the Fractional Laplacian. A particular set of Lévy processes are the so-called isotropic $\alpha$-stable processes, for $\alpha \in(0,2)$. The following definitions can be found in [23] in full detail.

Definition 2.6. Let $\alpha \in(0,2) . X:=\left(X_{t}\right)_{t \geq 0}$ is an isotropic $\alpha$-stable process if $X$ has a Lévy triple $(0,0, \Pi)$, with

$$
\begin{equation*}
\Pi(d z)=2^{-\alpha} \pi^{-d / 2} \frac{\Gamma((d+\alpha) / 2)}{|\Gamma(-\alpha / 2)|} \frac{1}{|z|^{\alpha+d}} d z, \quad z \in \mathbb{R}^{d} \tag{2.4}
\end{equation*}
$$

Recall that $\Gamma$ here is the Gamma function.
Definition 2.7 (Equivalent definitions of an isotropic $\alpha$-stable process).
(1) $X$ is an isotropic $\alpha$-stable process iff

$$
\begin{equation*}
\text { for all } \quad c>0, \quad\left(c X_{c^{-\alpha}}\right)_{t \geq 0} \quad \text { and } \quad X \quad \text { have the same law, } \tag{2.5}
\end{equation*}
$$ and for all the orthogonal transformations $U$ on $\mathbb{R}^{d}$,

$$
\left(U X_{t}\right)_{t \geq 0} \quad \text { and } \quad X \quad \text { have the same law. }
$$

(2) An isotropic $\alpha$-stable process is an stable process whose characteristic exponent is given by

$$
\begin{equation*}
\Psi(\xi)=|\xi|^{\alpha}, \quad \xi \in \mathbb{R}^{d} \tag{2.6}
\end{equation*}
$$

Remark 2.2. For the first definition, we say that $X$ satisfies the scaling property and is rotationally invariant, respectively.

Note by Definition 2.6 and by Lévy-Itô decomposition (Theorem 2.2), an isotropic $\alpha$-stable process can be decomposed as

$$
\begin{equation*}
X_{t}=\int_{0}^{t} \int_{|z| \geq 1} z N(d s, d z)+\int_{0}^{t} \int_{|z|<1} z \tilde{N}(d s, d z) \tag{2.7}
\end{equation*}
$$

From this equation, we can conclude that every isotropic $\alpha$-stable process is a pure jump process, whose jumps are determined by the Lévy measure defined in (2.4). We enunciate further properties about these processes:

Theorem 2.3. Let $g$ be a locally bounded, submultiplicative function and let La Lévy process, then the following are equivalent:
(1) $\mathbb{E}\left[g\left(L_{t}\right)\right]<\infty$ for some $t>0$.
(2) $\mathbb{E}\left[g\left(L_{t}\right)\right]<\infty$ for all $t>0$.
(3) $\int_{|z|>1} g(z) \Pi(d z)<\infty$.

An important result from the previous theorem gives necessary and sufficient conditions for the existence of the $p$ moment of an isotropic $\alpha$-stable process.

Corollary 2.8. Let $X$ be an $\alpha$-stable process and $p>0$, then the following are equivalent
(1) $p<\alpha$.
(2) $\mathbb{E}\left[\left|X_{t}\right|^{p}\right]<\infty$ for some $t>0$.
(3) $\mathbb{E}\left[\left|X_{t}\right|^{p}\right]<\infty$ for all $t>0$.
(4) $\int_{|z|>1}|z|^{p} \Pi(d z)<\infty$.

Remark 2.3. If $\alpha \in(0,1)$, by this corollary we have that $X$ has no first moment. Otherwise, if $\alpha \in(1,2)$ then it has finite first moment, but no second moment.
2.4. Type $s$ spaces and Monte Carlo Methods. We now introduce some results that controls the difference between the expectation of a random variable and a Monte Carlo operator associated to his expectation in $L^{p}$ norm, $p>1$. For more details see [10]. In the following results are simplified the results of [10]. Along this section we work with real valued Banach spaces.

We start with some concepts related to Banach spaces. The reader can consult [10, 24] for more details in this topic.

Definition 2.9. Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space, let $J$ be a set, and let $r_{j}: \Omega \rightarrow\{-1,1\}$, $j \in J$, be a family of independent random variables with for all $j \in J$,

$$
\mathbb{P}\left(r_{j}=1\right)=\mathbb{P}\left(r_{j}=-1\right)=\frac{1}{2} .
$$

Then we say that $\left(r_{j}\right)_{j \in J}$ is a $\mathbb{P}$-Rademacher family.
Definition 2.10. Let $\left(r_{j}\right)_{j \in \mathbb{N}}$ a $\mathbb{P}$-Rademacher family. Let $s \in(0, \infty)$. A Banach space $\left(E,\|\cdot\|_{E}\right)$ is said to be of type $s$ if there is a constant $C$ such that for all finite sequences $\left(x_{j}\right)$ in $E$,

$$
\mathbb{E}\left[\left\|\sum_{j} r_{j} x_{j}\right\|_{E}^{s}\right]^{\frac{1}{s}} \leq C\left(\sum_{j}\left\|x_{j}\right\|_{E}^{s}\right)^{\frac{1}{s}}
$$

The supremum of the constants $C$ is called the type s-constant of $E$ and it is denoted as $\mathscr{T}_{s}(E)$.

Remark 2.4. The existence of a finite constant $C$ in Definition 2.10 is valid for $s \leq 2$ only (see, e.g. 24] Section 9 for more details).
Remark 2.5. Any Banach space $\left(E,\|\cdot\|_{E}\right)$ is of type 1 . Moreover, triangle inequality ensures that $\mathscr{T}_{1}(E)=1$.
Remark 2.6. Notice that for all Banach spaces $\left(E,\|\cdot\|_{E}\right)$, the function $(0, \infty) \ni s \rightarrow \mathscr{T}_{s}(E) \in$ $[0, \infty]$ is non-decreasing. This implies for all $s \in(0,1]$ and all Banach spaces $\left(E,\|\cdot\|_{E}\right)$ with $E \neq\{0\}$ that $\mathscr{T}_{s}(E)=1$.
Remark 2.7. For all $s \in(0,2]$ and all Hilbert spaces $\left(H,\langle\cdot, \cdot\rangle_{H},\|\cdot\|_{H}\right)$ with $H \neq\{0\}$ it holds that $\mathscr{T}_{s}(H)=1$.
Definition 2.11. Let $\left(r_{j}\right)_{j \in \mathbb{N}}$ a $\mathbb{P}$-Rademacher family. Let $q, s \in(0, \infty)$ and $\left(E,\|\cdot\|_{E}\right)$ be a Banach space. The $\mathscr{K}_{q, s}(q, s)$-Kahane-Khintchine constant of the space $E$ is the extended real number given by the supremum of a constant $C$ such that for all finite sequences $\left(x_{j}\right)$ in $E$,

$$
\mathbb{E}\left[\left\|\sum_{j} r_{j} x_{j}\right\|_{E}^{q}\right]^{\frac{1}{q}} \leq C \mathbb{E}\left[\left\|\sum_{j} r_{j} x_{j}\right\|_{E}^{s}\right]^{\frac{1}{s}}
$$

Remark 2.8. For all $q, s \in(0, \infty)$ it holds that $\mathscr{K}_{q, s}<\infty$. Moreover, if $q \leq s$ by Jensen's inequality implies that $\mathscr{K}_{q, s}=1$.
Definition 2.12. Let $q, s \in(0, \infty)$ and let $\left(E,\|\cdot\|_{E}\right)$ be a Banach space. Then we denote by $\Theta_{q, s}(E) \in[0, \infty]$ the extended real number given by

$$
\Theta_{q, s}(E)=2 \mathscr{T}_{s}(E) \mathscr{K}_{q, s} .
$$

Consider the case $(\mathbb{R},|\cdot|)$. Notice that $\left(\mathbb{R},\langle\cdot, \cdot\rangle_{\mathbb{R}},|\cdot|\right)$ is a Hilbert space with the inner product $\langle x, y\rangle_{\mathbb{R}}=x y$. Then it holds for all $s \in(0,2]$ that

$$
\mathscr{T}_{s}:=\mathscr{T}_{s}(\mathbb{R})=1,
$$

in other words, $(\mathbb{R},|\cdot|)$ has type $s$ for all $s \in(0,2]$. Moreover, it holds for all $q \in(0, \infty)$, $s \in(0,2]$ that

$$
\Theta_{q, s}:=\Theta_{q, s}(\mathbb{R})=2 \mathscr{K}_{q, s}<\infty .
$$

With this in mind, we enunciate a particular version of the Corollary 5.12 found in [10], replacing the Banach space $\left(E,\|\cdot\|_{E}\right)$ by $(\mathbb{R},|\cdot|)$.
Corollary 2.13. Let $M \in \mathbb{N}$, $s \in[1,2],(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space, and let $\xi_{j} \in L^{1}(\mathbb{P},|\cdot|)$, $j \in\{1, \ldots, M\}$, be independent and identically distributed. Then, for all $q \in[s, \infty]$,

$$
\begin{align*}
\left\|\mathbb{E}\left[\xi_{1}\right]-\frac{1}{M} \sum_{j=1}^{M} \xi_{j}\right\|_{L^{q}(\Omega, \mathbb{P})} & =\frac{1}{M} \mathbb{E}\left[\left|\sum_{j=1}^{M} \xi_{j}-\mathbb{E}\left[\sum_{j=1}^{M} \xi_{j}\right]\right|^{q}\right]^{\frac{1}{q}}  \tag{2.8}\\
& \leq \frac{\Theta_{q, s}}{M^{1-\frac{1}{s}}} \mathbb{E}\left[\left|\xi_{1}-\mathbb{E}\left[\xi_{1}\right]\right|^{q}\right]^{\frac{1}{q}}
\end{align*}
$$

Remark 2.9. The choice of the Banach space as $(\mathbb{R},|\cdot|)$ ensures that $\Theta_{q, s}$ is finite and the bound above converges for suitable $M$ large.

## 3. Deep Neural Networks

In this section we review recent results on the mathematical analysis of neural networks needed for the proof of the main theorem. For a detailed description, see e.g. [16, 20, 21].
3.1. Setting. for $d \in \mathbb{N}$ define

$$
A_{d}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}
$$

the ReLU activation function such that for all $z \in \mathbb{R}^{d}, z=\left(z_{1}, \ldots, z_{d}\right)$, with

$$
A_{d}(z)=\left(\max \left\{z_{1}, 0\right\}, \ldots, \max \left\{z_{d}, 0\right\}\right)
$$

Let also
(NN1) $H \in \mathbb{N}$ be the number of hidden layers;
(NN2) $\left(k_{i}\right)_{i=0}^{H+1}$ be a positive integer sequence;
(NN3) $W_{i} \in \mathbb{R}^{k_{i} \times k_{i-1}}, B_{i} \in \mathbb{R}^{k_{i}}$, for any $i=1, \ldots, H+1$ be the weights and biases, respectively; (NN4) $x_{0} \in \mathbb{R}^{k_{0}}$, and for $i=1, \ldots, H$ let

$$
\begin{equation*}
x_{i}=A_{k_{i}}\left(W_{i} x_{i-1}+B_{i}\right) . \tag{3.1}
\end{equation*}
$$

We call

$$
\begin{equation*}
\Phi:=\left(W_{i}, B_{i}\right)_{i=1}^{H+1} \in \prod_{i=1}^{H+1}\left(\mathbb{R}^{k_{i} \times k_{i-1}} \times \mathbb{R}^{k_{i}}\right) \tag{3.2}
\end{equation*}
$$

the DNN associated to the parameters in (NN1)-(NN4). The space of all DNNs in the sense of (3.2) is going to be denoted by $\mathbf{N}$, namely

$$
\mathbf{N}=\bigcup_{H \in \mathbb{N}\left(k_{0}, \ldots, k_{H+1}\right) \in \mathbb{N}^{H+2}}\left[\prod_{i=1}^{H+1}\left(\mathbb{R}^{k_{i} \times k_{i-1}} \times \mathbb{R}^{k_{i}}\right)\right]
$$

Define the realization of the DNN $\Phi \in \mathbf{N}$ as

$$
\begin{equation*}
\mathcal{R}(\Phi)\left(x_{0}\right)=W_{H+1} x_{H}+B_{H+1} . \tag{3.3}
\end{equation*}
$$

Notice that $\mathcal{R}(\Phi) \in C\left(\mathbb{R}^{k_{0}}, \mathbb{R}^{k_{H+1}}\right)$. For any $\Phi \in \mathbf{N}$ define

$$
\begin{equation*}
\mathcal{P}(\Phi)=\sum_{n=1}^{H+1} k_{n}\left(k_{n-1}+1\right), \quad \mathcal{D}(\Phi)=\left(k_{0}, k_{1}, \ldots, k_{H+1}\right), \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\|\mathcal{D}(\Phi)\|=\max \left\{k_{0}, k_{1}, \ldots, k_{H+1}\right\} . \tag{3.5}
\end{equation*}
$$

The entries of $\left(W_{i}, B_{i}\right)_{i=1}^{H+1}$ will be the weights of the DNN, $\mathcal{P}(\Phi)$ represents the number of parameters used to describe the DNN, working always with fully connected DNNs, and $\mathcal{D}(\Phi)$ representes the dimension of each layer of the DNN. Notice that $\Phi \in \mathbf{N}$ has $H+2$ layers: $H$ of them hidden, one input and one output layer.

Remark 3.1. For $\Phi \in \mathbf{N}$ one has

$$
\|\mathcal{D}(\Phi)\| \leq \mathcal{P}(\Phi) \leq(H+1)\|\mathcal{D}(\Phi)\|(\|\mathcal{D}(\Phi)\|+1)
$$

Indeed, from the definition of $\|\cdot\| \|$,

$$
\|\mathcal{D}(\Phi)\| \leq \sum_{n=1}^{H+1} k_{n} \leq \mathcal{P}(\Phi)
$$

In addition, the definition of $\mathcal{P}(\Phi)$ implies that

$$
\mathcal{P}(\Phi) \leq \sum_{n=1}^{H+1}\|\mathcal{D}(\Phi)\|(\| \| \mathcal{D}(\Phi) \|+1)=(H+1)\|\mathcal{D}(\Phi)\|(\| \| \mathcal{D}(\Phi)\| \|+1)
$$

Remark 3.2. From the previous remark one has

$$
\mathcal{P}(\Phi) \leq 2(H+1)\|\mathcal{D}(\Phi)\| .
$$

If $\|\mid \mathcal{D}(\Phi)\|$ grows at most polynomially in both the dimension of the input layer and the reciprocal of the accuracy $\varepsilon$ of the DNN, then $\mathcal{P}(\Phi)$ satisfies that bound too. This means that, with the right bound on $\|\mathcal{D}(\Phi)\|$, the DNN $\Phi$ do not suffer the curse of dimensionality, in the sense established in Section [1.
3.2. Operations. In this section we summarize some operations between DNNs. We start with the definition of two vector operators

Definition 3.1. Let $\boldsymbol{D}=\bigcup_{H \in \mathbb{N}} \mathbb{N}^{H+2}$.
(1) Define $\odot: \boldsymbol{D} \times \boldsymbol{D} \rightarrow \boldsymbol{D}$ such that for all $H_{1}, H_{2} \in \mathbb{N}$, $\alpha=\left(\alpha_{0}, \ldots, \alpha_{H_{1}+1}\right) \in \mathbb{N}^{H_{1}+2}$, $\beta=\left(\beta_{0}, \ldots, \beta_{H_{2}+1}\right) \in \mathbb{N}^{H_{2}+2}$ it satisfied

$$
\begin{equation*}
\alpha \odot \beta=\left(\beta_{0}, \beta_{1}, \ldots, \beta_{H_{2}}, \beta_{H_{2}+1}+\alpha_{0}, \alpha_{1}, \ldots, \alpha_{H_{1}+1}\right) \in \mathbb{N}^{H_{1}+H_{2}+3} . \tag{3.6}
\end{equation*}
$$

(2) Define $\boxplus: \boldsymbol{D} \times \boldsymbol{D} \rightarrow \boldsymbol{D}$ such that for all $H \in \mathbb{N}, \alpha=\left(\alpha_{0}, \ldots, \alpha_{H+1}\right) \in \mathbb{N}^{H+2}$, $\beta=\left(\beta_{0}, \ldots, \beta_{H+1}\right) \in \mathbb{N}^{H+2}$ it satisfied

$$
\begin{equation*}
\alpha \boxplus \beta=\left(\alpha_{0}, \alpha_{1}+\beta_{1}, \ldots, \alpha_{H}+\beta_{H}, \beta_{H+1}\right) \in \mathbb{N}^{H+2} . \tag{3.7}
\end{equation*}
$$

(3) Define $\mathfrak{n}_{n} \in \boldsymbol{D}, n \in \mathbb{N}, n \geq 3$ as

$$
\begin{equation*}
\mathfrak{n}_{n}=(1, \underbrace{2, \ldots, 2}_{(n-2) \text {-times }}, 1) \in \mathbb{N}^{n} . \tag{3.8}
\end{equation*}
$$

Remark 3.3. From these definitions and the norm $\||\cdot|| |$ defined in (3.5), we the following bounds are clear
(1) For $H_{1}, H_{2} \in \mathbb{N}, \alpha \in \mathbb{N}^{H_{1}+2}$ and $\beta \in \mathbb{N}^{H_{2}+2}$,

$$
\|\alpha \odot \beta\| \leq \max \left\{\|\alpha\|\|,\| \beta\| \|, \alpha_{0}+\beta_{H_{2}+1}\right\} .
$$

(2) For $H \in \mathbb{N}$ and $\alpha, \beta \in \mathbb{N}^{H+2}$,

$$
\|\alpha \boxplus \beta\| \leq\|\alpha\|\|+\| \beta\| \| .
$$

(3) For $n \in \mathbb{N}, n \geq 3,\left\|\mathfrak{n}_{n}\right\| \|=2$.

Now we state classical operations between DNNs. For a full details of the next Lemmas, the reader can consult e.g. [20, 21.

Lemma 3.2. Let $I d_{\mathbb{R}}: \mathbb{R} \rightarrow \mathbb{R}$ be the identity function on $\mathbb{R}$ and let $H \in \mathbb{N}$. Then $I d_{\mathbb{R}} \in$ $\mathcal{R}\left(\left\{\Phi \in N: \mathcal{D}(\Phi)=\mathfrak{n}_{H+2}\right\}\right)$.

Remark 3.4. A similar consequence is valid in $\mathbb{R}^{d}$. Let $I d_{\mathbb{R}^{d}}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ be the identity function on $\mathbb{R}^{d}$ and let $H \in \mathbb{N}$. Therefore $I d_{\mathbb{R}^{d}} \in \mathcal{R}\left(\left\{\Phi \in \mathbf{N}: \mathcal{D}(\Phi)=d \mathfrak{n}_{H+2}\right\}\right)$. The case with $H=3$ is proved on [21.
Remark 3.5. Let $H \in \mathbb{N}$ and $\Phi \in \mathbf{N}$ such that $\mathcal{R}(\Phi)=I d_{\mathbb{R}^{d}}$. Then by Remark 3.3 we have that $\|\mathcal{D}(\Phi)\|=2 d$.

Lemma 3.3. Let $d_{1}, d_{2}, d_{3} \in \mathbb{N}, f \in C\left(\mathbb{R}^{d_{2}}, \mathbb{R}^{d_{3}}\right), g \in C\left(\mathbb{R}^{d_{1}}, \mathbb{R}^{d_{2}}\right)$, $\alpha, \beta \in \boldsymbol{D}$ such that $f \in \mathcal{R}(\{\Phi \in N: \mathcal{D}(\Phi)=\alpha\})$ and $g \in \mathcal{R}(\{\Phi \in N: \mathcal{D}(\Phi)=\beta\})$. Therefore $(f \circ g) \in \mathcal{R}(\{\Phi \in$ $N: \mathcal{D}(\Phi)=\alpha \odot \beta\})$.
Remark 3.6. Let $\Phi_{f}, \Phi_{g}, \Phi \in \mathbb{N}$ such that $\mathcal{R}\left(\Phi_{f}\right)=f, \mathcal{R}\left(\Phi_{g}\right)=g$ and $\mathcal{R}(\Phi)=f \circ g$. Then by Remark 3.3 it follows that

$$
\|\mathcal{D}(\Phi)\| \leq \max \left\{\left\|\mathcal{D}\left(\Phi_{f}\right)\right\|,\|,\| \mathcal{D}\left(\Phi_{g}\right) \|, 2 d_{2}\right\}
$$

Lemma 3.4. Let $M, H, p, q \in \mathbb{N}$, $h_{i} \in \mathbb{R}, \beta_{i} \in \boldsymbol{D}, f_{i} \in C\left(\mathbb{R}^{p}, \mathbb{R}^{q}\right), i=1, \ldots, M$ such that for all $i=1, \ldots, M \operatorname{dim}\left(\beta_{i}\right)=H+2$ and $f_{i} \in \mathcal{R}\left(\left\{\Phi \in N: \mathcal{D}(\Phi)=\beta_{i}\right\}\right)$. Then

$$
\begin{equation*}
\sum_{i=1}^{M} h_{i} f_{i} \in \mathcal{R}\left(\left\{\Phi \in N: \mathcal{D}(\Phi)=\underset{i=1}{M} \beta_{i}\right\}\right) \tag{3.9}
\end{equation*}
$$

Remark 3.7. For $i=1, \ldots, M$ let $\Phi_{i} \in \mathbf{N}$ such that $\mathcal{R}\left(\Phi_{i}\right)=f_{i}$ and let $\Phi \in \mathbf{N}$ such that

$$
\mathcal{R}(\Phi)=\sum_{i=1}^{M} h_{i} f_{i} .
$$

It follows from Remark 3.3 that

$$
\|\mathcal{D}(\Phi)\| \leq \sum_{i=1}^{M}\left\|\mathcal{D}\left(\Phi_{i}\right)\right\| .
$$

The following Lemma comes from [12] and is adapted to our notation.
Lemma 3.5. Let $H, d, d_{i} \in \mathbb{N}, \beta_{i} \in \boldsymbol{D}, f_{i} \in C\left(\mathbb{R}^{d}, \mathbb{R}^{d_{i}}\right), i=1,2$ such that for $i=1,2$ $\operatorname{dim}\left(\beta_{i}\right)=H+2$ and $f_{i} \in \mathcal{R}\left(\left\{\Phi \in \boldsymbol{N}: \mathcal{D}(\Phi)=\beta_{i}\right\}\right)$. Then

$$
\begin{equation*}
\left(f_{1}, f_{2}\right) \in \mathcal{R}\left(\left\{\Phi \in N: \mathcal{D}(\Phi)=\left(d, \beta_{1,1}+\beta_{2,1}, \ldots, \beta_{1, H+1}+\beta_{2, H+1}\right)\right\}\right) \tag{3.10}
\end{equation*}
$$

Remark 3.8. Let $\Phi_{1}, \Phi_{2}, \Phi \in \mathbf{N}$ such that $\mathcal{R}\left(\Phi_{i}\right)=f_{i}, i=1,2$ and $\mathcal{R}(\Phi)=\left(f_{1}, f_{2}\right)$. Notice by Lemma 3.5 and definition of the norm $\|\cdot\| \|$ in (3.5) that

$$
\|\mathcal{D}(\Phi)\| \leq\left\|\mathcal{D}\left(\Phi_{1}\right)\right\|+\left\|\mathcal{D}\left(\Phi_{2}\right)\right\| .
$$

For sake of completeness, we state the following lemma with his proof. We continue with the notation from [20]:

Lemma 3.6. Let $H, p, q, r \in \mathbb{N}, M \in \mathbb{R}^{r \times q}, \alpha \in \boldsymbol{D}, f \in C\left(\mathbb{R}^{p}, \mathbb{R}^{q}\right)$, such that $\operatorname{dim}(\alpha)=H+2$ and $f \in \mathcal{R}(\{\Phi \in N: \mathcal{D}(\Phi)=\alpha\})$. Then

$$
\begin{equation*}
M f \in \mathcal{R}\left(\left\{\Phi \in \boldsymbol{N}: \mathcal{D}(\Phi)=\left(\alpha_{0}, \ldots, \alpha_{H}, r\right)\right\}\right) . \tag{3.11}
\end{equation*}
$$

Proof. Let $H, \alpha_{0}, \ldots, \alpha_{H+1} \in \mathbb{N}, \Phi_{f} \in \mathbf{N}$ satisfying that

$$
\alpha=\left(\alpha_{0}, \ldots, \alpha_{H+1}\right), \quad \mathcal{R}\left(\Phi_{f}\right)=f, \quad \text { and } \quad \mathcal{D}\left(\Phi_{f}\right)=\alpha
$$

Note that $p=\alpha_{0}$ and $q=\alpha_{H+1}$. Let $\left(\left(W_{1}, B_{1}\right), \ldots,\left(W_{H+1}, B_{H+1}\right)\right) \in \prod_{n=1}^{H+1}\left(\mathbb{R}^{\alpha_{n} \times \alpha_{n-1}} \times \mathbb{R}^{\alpha_{n}}\right)$ satisfty that

$$
\Phi_{f}=\left(\left(W_{1}, B_{1}\right), \ldots,\left(W_{H+1}, B_{H+1}\right)\right) .
$$

Let $M \in \mathbb{R}^{r \times \alpha_{H+1}}$ and define

$$
\Phi=\left(\left(W_{1}, B_{1}\right), \ldots,\left(W_{H}, B_{H}\right),\left(M W_{H+1}, M B_{H+1}\right)\right)
$$

Notice that $\left(M W_{H+1}, M B_{H+1}\right) \in \mathbb{R}^{r \times \alpha_{H}} \times \mathbb{R}^{r}$, then $\Phi \in \mathbb{N}$. For $y_{0} \in \mathbb{R}^{\alpha_{0}}$, and $y_{i}, i=1, \ldots, H$ defined as in (NN4) we have

$$
(\mathcal{R}(\Phi))\left(y_{0}\right)=M W_{H+1} y_{H}+M B_{H+1}=M\left(W_{H+1} y_{H}+B_{H+1}\right)=M\left(\mathcal{R}\left(\Phi_{f}\right)\right)\left(y_{0}\right)
$$

Therefore

$$
\mathcal{R}(\Phi)=M f, \quad \text { and } \quad \mathcal{D}(\Phi)=\left(\alpha_{0}, \ldots, \alpha_{H}, r\right),
$$

and the Lemma is proved.
Remark 3.9. Let $\Phi_{f}, \Phi \in \mathbf{N}$ such that $\mathcal{R}\left(\Phi_{f}\right)=f$ and $\mathcal{R}(\Phi)=M f$. From previous Lemma and the definition of $\|\mid \cdot\| \|$ it follows that

$$
\|\mathcal{D}(\Phi)\| \leq \max \left\{\left\|\mathcal{D}\left(\Phi_{f}\right)\right\|, r\right\}
$$

The following Lemma is from [15].
Lemma 3.7. There exists constants $C_{1}, C_{2}, C_{3}, C_{4}>0$ such that for all $\kappa>0$ and for all $\delta \in\left(0, \frac{1}{2}\right)$ there exists a ReLu DNN $\Upsilon \in N$, with $\mathcal{R}(\Upsilon) \in C\left(\mathbb{R}^{2}, \mathbb{R}\right)$ such that

$$
\begin{equation*}
\sup _{a, b \in[-\kappa, \kappa]}|a b-(\mathcal{R}(\Upsilon))(a, b)| \leq \delta . \tag{3.12}
\end{equation*}
$$

Moreover, for all $\delta \in\left(0, \frac{1}{2}\right)$,

$$
\begin{align*}
\mathcal{P}(\Upsilon) & \leq C_{1}\left(\log _{2}\left(\frac{\max \{\kappa, 1\}}{\delta}\right)\right)+C_{2}  \tag{3.13}\\
\operatorname{dim}(\mathcal{D}(\Upsilon)) & \leq C_{3}\left(\log _{2}\left(\frac{\max \{\kappa, 1\}}{\delta}\right)\right)+C_{4} \tag{3.14}
\end{align*}
$$

## 4. Walk-on-spheres Processes

We start with some key notation that will be extensively used along this paper.
Let $(\Omega, \mathbb{P}, \mathcal{F})$ be a filtered probability space with $\mathcal{F}=\left(\mathcal{F}_{t}\right)_{t \geq 0}$. Let $\left(X_{t}\right)_{t \geq 0}$ be an isotropic $\alpha$-stable process starting at $X_{0}$. For $x \in D$ denote $\mathbb{P}_{x}$ the probability measure conditional to $X_{0}=x$ and $\mathbb{E}_{x}$ the respective expectation. Finally, define for any $B \subset \mathbb{R}^{d}$ the exit time for the set $B$ as

$$
\sigma_{B}=\inf \left\{t \geq 0: X_{t} \notin B\right\} .
$$

Now we introduce the classical WoS process.
Definition $4.1\left([22)\right.$. The Walk-on-Spheres $(W o S)$ process $\rho:=\left(\rho_{n}\right)_{n \in \mathbb{N}}$ is defined as follows:

- $\rho_{0}=x, x \in D$;
- given $\rho_{n-1}, n \geq 1$, the distribution of $\rho_{n}$ is chosen according to an independent sample of $X_{\sigma_{B n}}$ under $\mathbb{P}_{\rho_{n-1}}$, where $B_{n}$ is the ball centered on $\rho_{n-1}$ and radius $r_{n}=\operatorname{dist}\left(\rho_{n-1}, \partial D\right)$.

Remark 4.1. Notice by the Markov property that the process $\rho$ can be written as the recurrence

$$
\rho_{n}=\rho_{n-1}+Z_{n}, \quad n \in \mathbb{N},
$$

where $Z_{n}$ is an independent sample of $X_{\sigma_{B\left(0, r_{n}\right)}}$ under $\mathbb{P}_{0}$.
From the previous Remark, it is possible to rewrite $\rho_{n}$ for $n \in \mathbb{N}$ depending on $x \in D$ and on $n$ independent processes distributing accord $X_{\sigma_{B(0,1)}}$, as indicates the following Lemma.
Lemma 4.2. The WoS process $\rho:=\left(\rho_{n}\right)_{n \in \mathbb{N}}$ can be defined as follows

- $\rho_{0}=x, x \in D$;
- for $n \geq 1$,

$$
\begin{equation*}
\rho_{n}=\rho_{n-1}+r_{n} Y_{n}, \tag{4.1}
\end{equation*}
$$

where $Y_{n}$ is an independent sample of $X_{\sigma_{B(0,1)}}$ and $r_{n}=\operatorname{dist}\left(\rho_{n-1}, \partial D\right)$.
Proof. Note by the scaling property (2.5) that

$$
X_{t} \quad \text { and } \quad r_{n} X_{r_{n}^{-\alpha} t}
$$

have the same distribution for all $n \in \mathbb{N}$. Therefore

$$
\begin{align*}
\sigma_{B\left(0, r_{n}\right)} & =\inf \left\{t \geq 0: X_{t} \notin B\left(0, r_{n}\right)\right\} \\
& =r_{n}^{\alpha} \inf \left\{r_{n}^{-\alpha} t \geq 0: r_{n} X_{r_{n}^{-\alpha} t} \notin B\left(0, r_{n}\right)\right\}  \tag{4.2}\\
& =r_{n}^{\alpha} \inf \left\{s \geq 0: r_{n} X_{s} \notin B\left(0, r_{n}\right)\right\} \\
& =r_{n}^{\alpha} \inf \left\{s \geq 0: X_{s} \notin B(0,1)\right\}=r_{n}^{\alpha} \sigma_{B(0,1)} .
\end{align*}
$$

This equality and the scaling property implies that

$$
\begin{equation*}
X_{\sigma_{B(0,1)}} \quad \text { and } \quad r_{n}^{-1} X_{r_{n}^{\alpha} \sigma_{B(0,1)}} \tag{4.3}
\end{equation*}
$$

are equal in law under $\mathbb{P}_{0}$, and then from Remark $4.1 Z_{n}$ and $r_{n} X_{\sigma_{B(0,1)}}$ have the same distribution under $\mathbb{P}_{0}$. We can conclude that for $n \geq 1, \rho_{n}$ can be written as the recurrence

$$
\rho_{n}=\rho_{n-1}+r_{n} Y_{n},
$$

where $Y_{n}$ is an independent sample of $X_{\sigma_{B(0,1)}}$.

To study the WoS processes, we need to know about the processes $X_{\sigma_{B(0,1)}}$. The following result gives the distribution density of $X_{\sigma_{B(0,1)}}$.
Theorem 4.1 (Blumenthal, Getoor, Ray, 1961. [7). Suppose that $B(0,1)$ is a unit ball centered at the origin and write $\sigma_{B(0,1)}=\inf \left\{t>0: X_{t} \notin B(0,1)\right\}$. Then,

$$
\begin{equation*}
\mathbb{P}_{0}\left(X_{\sigma_{B(0,1)}} \in d y\right)=\pi^{-(d / 2+1)} \Gamma\left(\frac{d}{2}\right) \sin (\pi \alpha / 2)\left|1-|y|^{2}\right|^{-\alpha / 2}|y|^{-d} d y, \quad|y|>1 \tag{4.4}
\end{equation*}
$$

Using this result, one can prove a key result for the expectation of $X_{\sigma_{B(0,1)}}$ moments.
Corollary 4.3. For all $\alpha \in(0,2), \beta \in[0, \alpha)$ we have

$$
\begin{equation*}
\mathbb{E}_{0}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right]=\frac{\sin (\pi \alpha / 2)}{\pi} \frac{\Gamma\left(1-\frac{\alpha}{2}\right) \Gamma\left(\frac{\alpha-\beta}{2}\right)}{\Gamma\left(1-\frac{\beta}{2}\right)}=: K(\alpha, \beta) . \tag{4.5}
\end{equation*}
$$

Remark 4.2. Notice that the value of $K(\alpha, \beta)$ does not depend of the dimension $d$.
Remark 4.3. the condition $\beta<\alpha$ is necessary due to Corollary 2.8. If $\beta \geq \alpha$ then $\mathbb{E}\left[\left|X_{t}\right|^{\beta}\right]=\infty$ for all $t>0$. Moreover, the integral

$$
\int_{1}^{\infty} \frac{r^{\beta-1}}{\left(r^{2}-1\right)^{\alpha / 2}} d r
$$

obtained in the proof of the Corollary 4.3 does not converges if $\beta \geq \alpha$.
Proof of Corollary 4.3. Let $\alpha \in(0,2), \beta \in[0, \alpha)$. Notice by Theorem 4.1 and definition of the expectation that

$$
\begin{align*}
\mathbb{E}_{0}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right] & =\int_{|y|>1}|y|^{\beta} \mathbb{P}_{0}\left(X_{\sigma_{B(0,1)}} \in d y\right) \\
& =\pi^{-(d / 2+1)} \Gamma\left(\frac{d}{2}\right) \sin (\pi \alpha / 2) \int_{|y|>1}\left|1-|y|^{2}\right|^{-\alpha / 2}|y|^{\beta-d} d y \tag{4.6}
\end{align*}
$$

Using spherical coordinates one has

$$
\int_{|y|>1}\left|1-|y|^{2}\right|^{-\alpha / 2}|y|^{\beta-d} d y=\int_{\mathbb{S}^{d}-1} \int_{1}^{\infty}\left|1-r^{2}\right|^{-\alpha / 2} r^{\beta-d} r^{d-1} d r d S,
$$

where $\mathbb{S}^{d-1}$ is the surface area of the unit $(d-1)$-sphere embedded in dimension $d$. One has that [28]

$$
\left|\mathbb{S}^{d-1}\right|=\frac{2 \pi^{d / 2}}{\Gamma\left(\frac{d}{2}\right)},
$$

and then

$$
\int_{|y|>1}\left|1-|y|^{2}\right|^{-\alpha / 2}|y|^{\beta-d} d y=\frac{2 \pi^{d / 2}}{\Gamma\left(\frac{d}{2}\right)} \int_{1}^{\infty} \frac{r^{\beta-1}}{\left(r^{2}-1\right)^{\alpha / 2}} d r .
$$

Replacing this result into (4.6) give us that

$$
\mathbb{E}_{0}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right]=\frac{2}{\pi} \sin (\pi \alpha / 2) \int_{1}^{\infty} \frac{r^{\beta-1}}{\left(r^{2}-1\right)^{\alpha / 2}} d r .
$$

Now we are able to use a change of variables $u=1 / r$, then

$$
\int_{1}^{\infty} \frac{r^{\beta-1}}{\left(r^{2}-1\right)^{\alpha / 2}} d r=\int_{0}^{1} \frac{1}{u^{2}} u^{1-\beta} \frac{u^{\alpha}}{\left(1-u^{2}\right)^{-\alpha / 2}} d u=\int_{0}^{1} u^{\alpha-\beta-1}\left(1-u^{2}\right)^{-\alpha / 2} d u .
$$

Using another change of variable, $t=u^{2}$ we have

$$
\int_{0}^{1} \frac{1}{2 t^{\frac{1}{2}}} t^{\frac{\alpha-\beta-1}{2}}(1-t)^{-\frac{\alpha}{2}} d t=\frac{1}{2} \int_{0}^{1} t^{\frac{\alpha-\beta}{2}-1}(1-t)^{1-\frac{\alpha}{2}-1} d t .
$$

This result implies that

$$
\mathbb{E}_{x}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right]=\frac{\sin (\pi \alpha / 2)}{\pi} \int_{0}^{1} t^{\frac{\alpha-\beta}{2}-1}(1-t)^{1-\frac{\alpha}{2}-1} d t .
$$

The integral has the form of the Beta function, formally defined as:

$$
B(z, w):=\int_{0}^{1} u^{z-1}(1-u)^{w-1} d u
$$

For full details of the Beta function see, e.g. [11]. In particular, the Beta function satisfies

$$
B(z, w)=\frac{\Gamma(z) \Gamma(w)}{\Gamma(z+w)} .
$$

Finally

$$
\mathbb{E}_{0}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right]=\frac{\sin (\pi \alpha / 2)}{\pi} B\left(\frac{\alpha-\beta}{2}, 1-\frac{\alpha}{2}\right)=\frac{\sin (\pi \alpha / 2)}{\pi} \frac{\Gamma\left(1-\frac{\alpha}{2}\right) \Gamma\left(\frac{\alpha-\beta}{2}\right)}{\Gamma\left(1-\frac{\beta}{2}\right)} .
$$

4.1. Relation between WoS and isotropic $\alpha$-stable process. Recall from Section 4 that the process $\left(\rho_{n}\right)_{n \geq 0}$ is related to a family of processes distributing accord $X_{\sigma_{B(0,1)}}$. We want now to have a relation between the processes $\left(X_{t}\right)_{t \geq 0}$ and $\left(\rho_{n}\right)_{n \geq 0}$. For this define $\widetilde{r}_{1}:=\operatorname{dist}(x, \partial D), \widetilde{B}_{1}:=B\left(x, r_{1}\right), \tau_{1}:=\sigma_{\widetilde{B}_{1}}$ and for all $n \geq 1$ define:

$$
\begin{align*}
\widetilde{r}_{n+1} & :=\operatorname{dist}\left(X_{\mathcal{I}(n)}, \partial D\right)  \tag{4.7}\\
\widetilde{B}_{n+1} & :=B\left(X_{\mathcal{I}(n)}, \widetilde{r}_{n+1}\right)  \tag{4.8}\\
\tau_{n+1} & :=\inf \left\{t \geq 0: X_{t+\mathcal{I}(n)} \notin \widetilde{B}_{n+1}\right\} \tag{4.9}
\end{align*}
$$

where

$$
\begin{equation*}
\mathcal{I}(n):=\sum_{i=1}^{n} \tau_{i}, \quad \mathcal{I}(0)=0 \tag{4.10}
\end{equation*}
$$

$\mathcal{I}(n)$ represents the total time of the process $X_{t}$ takes to exit the $n$ balls $\widetilde{B}_{1}, \ldots, \widetilde{B}_{n}$. The following Lemma establishes that for all $n \in \mathbb{N}, \rho_{n}$ is equally distributed to the process $\left(X_{t}\right)_{t \geq 0}$ exiting the $n$ balls $\widetilde{B}_{1}, \ldots, \widetilde{B}_{n}$, that is, $X_{\mathcal{I}(n)}$.
Lemma 4.4. For all $n \geq 0$ and $x \in D, \rho_{n}$ and $X_{\mathcal{I}(n)}$ have the same distribution starting at $x$.

Proof. Note that under $\mathbb{P}_{X_{\mathcal{I}(n-1)}}, X_{\mathcal{I}(n)}$ has the same distribution as $X_{\sigma_{\widetilde{B}_{n}}}$. Thus, by the Markov property and the scaling property one has

$$
X_{\mathcal{I}(n)}=X_{\mathcal{I}(n-1)}+\widetilde{r}_{n} Y_{n}^{\prime},
$$

where $Y_{n}^{\prime}$ is an independent sample of $X_{\sigma_{B(0,1)}}$ under $\mathbb{P}_{0}$. From the two constructions below in addition with induction, one has that $\rho_{n}$ and $X_{\mathcal{I}(n)}$ has the same distribution starting at $x$, for all $n \geq 0$ and $x \in D$.

Let

$$
\begin{equation*}
N=\min \left\{n \in \mathbb{N}: \rho_{n} \notin D\right\} . \tag{4.11}
\end{equation*}
$$

This random variable describes the quantity of balls $\widetilde{B}_{n}$ that the process $\left(X_{t}\right)_{t \geq 0}$ exits before exits the domain $D$. The following Theorem ensures that $N$ is almost surely finite.

Theorem 4.2 ( [22], Theorem 5.4). Let $D$ be a open and bounded set. Therefore for all $x \in D$, there exists a constant $\widetilde{p}=\widetilde{p}(\alpha, d)>0$ independent of $x$ and $D$, and a random variable $\Gamma$ such that $N \leq \Gamma \mathbb{P}_{x}$-a.s., where

$$
\begin{equation*}
\mathbb{P}_{x}(\Gamma=k)=(1-\widetilde{p})^{k-1} \widetilde{p}, \quad k \in \mathbb{N} . \tag{4.12}
\end{equation*}
$$

Remark 4.4. Although the random variable $\Gamma$ has the same distribution for each $x \in D$, it is not the same random variable for each $x \in D$.

Remark 4.5. This theorem implies that

$$
\mathbb{P}_{x}(N>n) \leq \mathbb{P}_{x}(\Gamma>n)=(1-\widetilde{p})^{n}, \quad n \in \mathbb{N} .
$$

The definition of $\mathcal{I}(n)$ and $N$ in (4.10) and (4.11) imply that the total time of $\left(X_{t}\right)_{t \geq 0}$ that takes to exit $N$ balls $\widetilde{B}_{1}, \ldots, \widetilde{B}_{N}$ is equal to the time of $\left(X_{t}\right)_{t \geq 0}$ that takes to exit $D$. More precisely

Lemma 4.5. For $x \in D$, let $X_{t}$ be an isotropic $\alpha$-stable process. Therefore, a.s.

$$
\mathcal{I}(N)=\sigma_{D} .
$$

Proof. For the inequality $\geq$, note by definition of $N$ that

$$
X_{\mathcal{I}(N)} \notin D .
$$

Recall that $\sigma_{D}$ is the infimum time $t \geq 0$ such that $X_{t} \notin D$, then

$$
\mathcal{I}(N) \geq \sigma_{D} .
$$

For $\leq$ suppose by contradiction that $\sigma_{D}<\mathcal{I}(N)$. If $\sigma_{D}<\mathcal{I}(N-1)$, then

$$
X_{\mathcal{I}(N-1)} \notin D .
$$

This is a contradiction with the definition of $N$, because $N-1$ is a natural less than $N$ satisfying the above condition. Therefore $\mathcal{I}(N-1) \leq \sigma_{D}$ and this implies that there exists $t^{*} \geq 0$ such that

$$
\mathcal{I}(N)>\sigma_{D}=\mathcal{I}(N-1)+t^{*}
$$

Using the definition of $\mathcal{I}(n)$, for $n \in \mathbb{N}$ and the supposition $\sigma_{D}<\mathcal{I}(N)$, one has

$$
t^{*}<\tau_{N},
$$

but

$$
X_{\sigma_{D}}=X_{\mathcal{I}(N-1)+t^{*}} \notin D,
$$

therefore, from the definition of $\tau_{N}$ in (4.9),

$$
\tau_{N} \leq t^{*}
$$

a contradiction. Therefore $\mathcal{I}(N-1) \leq \sigma_{D}$ and we can conclude that

$$
\mathcal{I}(N)=\sigma_{D}
$$

Remark 4.6. From the relation between $X_{\mathcal{I}(n)}$ and $\rho_{n}$ for $n \in \mathbb{N}$, it follows that

$$
\mathbb{E}_{x}\left[\rho_{N}\right]=\mathbb{E}_{x}\left[X_{\mathcal{I}(N)}\right]=\mathbb{E}_{x}\left[X_{\sigma_{D}}\right] .
$$

Remark 4.6 give us a relation between $\left(X_{t}\right)_{t \geq 0}$ and $\left(\rho_{n}\right)_{n \geq 0}$. Figure 4.1 shows in an example the relation between WoS and isotropic $\alpha$-stable processes, exiting a bounded domain $D$.


Figure 1. Illustration of isotropic $\alpha$-stable and WoS processes starting at $x$ exiting a domain $D$. The blue line represents the $\alpha$-stable process $\left(X_{t}\right)_{t \geq 0}$, the orange dots are the WoS process $\left(\rho_{n}\right)_{n \geq 0}$ and the red balls are given by Definition 4.1. In this case $N=4$ and $\rho_{4}=X_{\sigma_{D}}$.

## 5. Stochastic representation of the Fractional Laplacian

5.1. Stochastic Representation. Recall Problem (1.2). The following theorem gives an stochastic representation of the solution of problem (1.2) from the process $\left(X_{t}\right)_{t \geq 0}$. The proof of this Theorem can be found in [22]
Theorem 5.1 ([22], Theorem 6.1). Let $d \geq 2$ and assume that $D$ is a bounded domain in $\mathbb{R}^{d}$. Additionally, assume (Hg-0) and (Hf-0). Then there exist a unique continuous solution for (1.2) in $L_{\alpha}^{1}\left(\mathbb{R}^{d}\right)$, given by the explicit formula

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(X_{\sigma_{D}}\right)\right]+\mathbb{E}_{x}\left[\int_{0}^{\sigma_{D}} f\left(X_{s}\right) d s\right], \tag{5.1}
\end{equation*}
$$

valid for any $x \in D$.
The previous representation can be expressed in terms of the WoS process. For this define the expected occupation measure of the stable process prior to exiting a ball of radius $r>0$ centered in $x \in \mathbb{R}^{d}$ as follows:

$$
\begin{equation*}
V_{r}(x, d y):=\int_{0}^{\infty} \mathbb{P}_{x}\left(X_{t} \in d y, t<\sigma_{B(x, r)}\right) d t, \quad x \in \mathbb{R}^{d}, \quad|y|<1, \quad r>0 . \tag{5.2}
\end{equation*}
$$

We have the following result for $V_{1}(0, d y)$.
Theorem 5.2 ([22], Theorem 6.2). The measure $V_{1}(0, d y)$ is given for $|y|<1$, by

$$
\begin{equation*}
V_{1}(0, d y)=2^{-\alpha} \pi^{-d / 2} \frac{\Gamma(d / 2)}{\Gamma(\alpha / 2)^{2}}|y|^{\alpha-d}\left(\int_{0}^{|y|^{-2}-1}(u+1)^{-d / 2} u^{\alpha / 2-1} d u\right) d y \tag{5.3}
\end{equation*}
$$

Denote $V_{r}(x, f(\cdot))=\int_{|y-x|<r} f(y) V_{r}(x, d y)$ for a bounded measurable function $f . V_{r}(x, f(\cdot))$ defines the expected value of $f$ under the measure $V_{r}(x, d y)$ over the ball $B(x, r)$. An important property of this expected value is the following: for $r>0$ and $x \in \mathbb{R}^{d}$

$$
\begin{equation*}
V_{r}(x, f(\cdot))=V_{1}(0, f(x+r \cdot)) . \tag{5.4}
\end{equation*}
$$

The proof of this property can be found in [22]. The following Lemma uses the WoS process and the Theorem 5.2. Recall that $\left(\rho_{n}\right)_{n=1, \ldots, N}$ represents the WoS process defined in Section 4. and $r_{n}=\operatorname{dist}\left(\rho_{n}, \partial D\right)$.

Lemma 5.1 ([22], Lema 6.3). For $x \in D, g \in L_{\alpha}^{1}\left(D^{c}\right)$ and $f \in C^{\alpha+\varepsilon_{0}}(\bar{D})$ we have the representation

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(\rho_{N}\right)\right]+\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} V_{1}\left(0, f\left(\rho_{n-1}+r_{n} \cdot\right)\right)\right] . \tag{5.5}
\end{equation*}
$$

Remark 5.1. Recall that $\rho_{n}$ and $X_{\mathcal{I}(n)}$ are equal on law under $\mathbb{P}_{x}$ for all $n \in \mathbb{N}$. Therefore we can write

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]+\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} V_{1}\left(0, f\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right)\right] . \tag{5.6}
\end{equation*}
$$

5.2. Equivalent representations of non-homogeneous solution. Consider again the problem (1.2). Remember from Remark 5.1 that its solution can be written as

$$
u(x)=\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]+\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} V_{1}\left(0, f\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right)\right] .
$$

Notice also that from the definition of $V_{1}(0, f(\cdot))$, it can be expressed as the expectation of $f$ under the measure $V_{1}(0, d y)$ on $B(0,1)$. This measure is not necessarily a probability measure, so we are going to normalize the measure $V_{1}(0, d y)$. For this define for all $d \geq 2, d \in \mathbb{N}$ and $\alpha \in(0,2)$

$$
\kappa_{d, \alpha}=\int_{B(0,1)} V_{1}(0, d y) .
$$

In the following Lemma we prove that $\kappa_{d, \alpha}$ is positive and finite
Lemma 5.2. For all $d \geq 2$ and $\alpha \in(0,2)$, we have that $0<\kappa_{d, \alpha}<+\infty$.

Proof. Notice first from Theorem 4.1 that

$$
\kappa_{d, \alpha}=\widetilde{c}_{d, \alpha} \int_{B(0,1)}|y|^{\alpha-d}\left(\int_{0}^{|y|^{-2}-1}(u+1)^{-d / 2} u^{\alpha / 2-1} d u\right) d y
$$

where $\widetilde{c}_{d, \alpha}=2^{-\alpha} \pi^{-d / 2} \frac{\Gamma(d / 2)}{\Gamma(\alpha / 2)^{2}}$. Now we work with the interior integral. With a change of variables $u=\frac{1-t}{t}$ and integral properties one has:

$$
\begin{aligned}
& \int_{1}^{|y|^{2}} t^{d / 2}\left(\frac{1-t}{t}\right)^{\alpha / 2-1}\left(-t^{-2}\right) d t \\
& \quad=\int_{0}^{1} t^{d / 2-\alpha / 2-1}(1-t)^{\alpha / 2-1} d t-\int_{0}^{|y|^{2}} t^{d / 2-\alpha / 2-1}(1-t)^{\alpha / 2-1} d t
\end{aligned}
$$

For $z, w>0, x \in[0,1]$ let $B(z, w)$ and $I(x ; z, w)$ be the Beta and the Incomplete Beta functions respectively, defined as

$$
\begin{aligned}
B(z, w) & :=\int_{0}^{1} u^{z-1}(1-u)^{w-1} d u \\
I(x ; z, w) & :=\frac{1}{B(z, w)} \int_{0}^{x} u^{z-1}(1-u)^{w-1} d u
\end{aligned}
$$

For further details of these functions the reader can consult [11]. Notice that $\kappa_{d, \alpha}$ can be written in terms of $B(z, w)$ and $I(x ; z, w)$. Indeed

$$
\kappa_{d, \alpha}=\widetilde{c}_{d, \alpha} B\left(\frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right) \int_{B(0,1)}|y|^{\alpha-d}\left(1-I\left(|y|^{2} ; \frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right)\right) d y .
$$

Note by property of Beta function that

$$
B\left(\frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right)=\frac{\Gamma\left(\frac{d}{2}-\frac{\alpha}{2}\right) \Gamma\left(\frac{\alpha}{2}\right)}{\Gamma\left(\frac{d}{2}\right)}
$$

The Gamma function is well defined and positive on $(0, \infty)$. If $d>\alpha$ then

$$
0<B\left(\frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right)<+\infty
$$

On the other hand side, note by the definition of $I(x ; z, w)$ that for $x<1$,

$$
0 \leq I(x ; z, w)<\frac{1}{B(z, w)} \int_{0}^{1} u^{z-1}(1-u)^{w-1} d u=1
$$

Then for all $|y|^{2}<1$,

$$
0<1-I\left(|y|^{2} ; \frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right) \leq 1
$$

Therefore in $\kappa_{d, \alpha}$ we are integrating the multiplication of two positive functions over a set of positive measure. This implies that

$$
0<\kappa_{d, \alpha} \leq \widetilde{c}_{d, \alpha} B\left(\frac{d}{2}-\frac{\alpha}{2}, \frac{\alpha}{2}\right) \int_{B(0,1)}|y|^{\alpha-d} d y
$$

The above integral can be calculated using a change of variables in spherical coordinates, and his value is finite. Finally we conclude that

$$
0<\kappa_{d, \alpha}<+\infty
$$

Now we are able to define a probability measure $\mu$ on $B(0,1)$ given by

$$
\mu(d y):=\kappa_{d, \alpha}^{-1} V_{1}(0, d y)
$$

Therefore, for any bounded measurable function $f$ we have

$$
\begin{align*}
V_{1}\left(0, f\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right) & =\int_{B(0,1)} f\left(X_{\mathcal{I}(n-1)}+r_{n} y\right) V_{1}(0, d y) \\
& =\kappa_{d, \alpha} \int_{B(0,1)} f\left(X_{\mathcal{I}(n-1)}+r_{n} y\right) \mu(d y) \\
& =\kappa_{d, \alpha} \mathbb{E}^{(\mu)}\left[f\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right] . \tag{5.7}
\end{align*}
$$

where $\mathbb{E}^{(\mu)}$ correspond to the expectation over the probability measure $\mu$ on $B(0,1)$. With this representation, we can rewrite the solution of (1.2) as

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]+\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha} \mathbb{E}^{(\mu)}\left[f\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right]\right] \tag{5.8}
\end{equation*}
$$

From the construction of $\kappa_{d, \alpha}$, the following properties are valid
Lemma 5.3. One has

$$
\begin{equation*}
\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha}\right]=\mathbb{E}_{x}\left[\sigma_{D}\right] \tag{1}
\end{equation*}
$$

$$
\begin{equation*}
\mathbb{E}_{x}\left[\left|\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha}\right|^{2}\right] \leq \mathbb{E}_{x}\left[\sigma_{D}^{2}\right] . \tag{2}
\end{equation*}
$$

Proof.
(1) Notice from the definition of $V_{1}(0, f(\cdot))$, with $f \equiv 1$ that

$$
\kappa_{d, \alpha}=V_{1}\left(0,1\left(X_{\mathcal{I}(n-1)}+r_{n} \cdot\right)\right) .
$$

It follows from (5.4) that

$$
r_{n}^{\alpha} \kappa_{d, \alpha}=V_{r_{n}}\left(X_{\mathcal{I}(n-1)}, 1(\cdot)\right)
$$

Moreover

$$
\begin{aligned}
\mathbb{E}_{x}\left[\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha}\right] & =\mathbb{E}_{x}\left[\sum_{n=1}^{N} V_{r_{n}}\left(X_{\mathcal{I}(n-1)}, 1(\cdot)\right)\right] \\
& =\mathbb{E}_{x}\left[\int_{0}^{\sigma_{D}} 1\left(X_{s}\right) d s\right]=\mathbb{E}_{x}\left[\sigma_{D}\right]
\end{aligned}
$$

(2) From the definition of $V_{r}(x, f(\cdot))$ with $f \equiv 1$, it follows that

$$
V_{r_{n}}\left(X_{\mathcal{I}(n-1)}, 1(\cdot)\right)=\mathbb{E}_{X_{\mathcal{I}(n-1)}}\left[\int_{0}^{\sigma_{B\left(X_{\mathcal{I}(n-1)}, r_{n}\right)}} 1\left(X_{t}\right) d t\right]=\mathbb{E}_{X_{\mathcal{I}(n-1)}}\left[\sigma_{B\left(X_{\mathcal{I}(n-1)}, r_{n}\right)}\right] .
$$

By definition of $\tau_{n}, n \in \mathbb{N}$, (4.9) and Markov property one has

$$
\mathbb{E}_{X_{\mathcal{I}(n-1)}}\left[\sigma_{B\left(X_{\mathcal{I}(n-1)}, r_{n}\right)}\right]=\mathbb{E}_{0}\left[\tau_{n}\right]
$$

Then, Jensen inequality implies

$$
\mathbb{E}_{x}\left[\left|\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha}\right|^{2}\right]=\mathbb{E}_{x}\left[\left|\sum_{n=1}^{N} \mathbb{E}_{0}\left[\tau_{n}\right]\right|^{2}\right] \leq \mathbb{E}_{x}\left[\mathbb{E}_{0}\left[\left|\sum_{n=1}^{N} \tau_{n}\right|^{2}\right]\right]
$$

Finally, by tower property

$$
\mathbb{E}_{x}\left[\left|\sum_{n=1}^{N} r_{n}^{\alpha} \kappa_{d, \alpha}\right|^{2}\right] \leq \mathbb{E}_{x}\left[\mathcal{I}(N)^{2}\right]=\mathbb{E}_{x}\left[\sigma_{D}^{2}\right] .
$$

## 6. Approximation of solutions of the Fractional Dirichlet problem using DNNs: the boundary data case

As usual, Problem (1.2) can be decomposed in two subproblems, that will be treated in a separate way. We first deal with the homogeneous case.
6.1. Homogeneous Fractional Laplacian. We consider (1.2) with $f \equiv 0$, namely,

$$
\left\{\begin{align*}
(-\Delta)^{\alpha / 2} u(x) & =0 & & \text { for } x \in D,  \tag{6.1}\\
u(x) & =g(x) & & \text { for } x \in D^{c} .
\end{align*}\right.
$$

Note that under (Hg-0), one has from (5.1)

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(X_{\sigma_{D}}\right)\right], \quad x \in D . \tag{6.2}
\end{equation*}
$$

The main idea of this section is approximate the solution (6.2) by a deep neural network with $\operatorname{ReLu}$ activation, with an accurateness $\varepsilon>0$. For this we going to assume that $g$ can be approximated by a ReLu DNN satisfying several hypotheses. These hypotheses are expressed in the following assumption.

Recall that $||\cdot|| \mid$ represents the maximum number of hidden layers dimensions introduced in (3.5), $\mathcal{R}$ is the realization of a DNN as in (3.3), and $\mathcal{D}$ was introduced in (3.4).

Assumptions 1. Let $d \geq 2$. Let $g: D^{c} \rightarrow \mathbb{R}$ satisfying Hg-0). Let $\delta_{g} \in(0,1), a, b \geq 1$, $p \in(1, \alpha)$ and $B>0$. Then there exists a ReLu DNN $\Phi_{g} \in \boldsymbol{N}$ with
(1) $\mathcal{R}\left(\Phi_{g}\right): D^{c} \rightarrow \mathbb{R}$ is continuous, and
(2) The following are satisfied:

$$
\begin{align*}
\left|g(y)-\left(\mathcal{R}\left(\Phi_{g}\right)\right)(y)\right| & \leq \delta_{g} B d^{p}(1+|y|)^{p}, & \forall y \in D^{c} .  \tag{Hg-1}\\
\left|\left(\mathcal{R}\left(\Phi_{g}\right)\right)(y)\right| & \leq B d^{p}(1+|y|)^{p}, & \forall y \in D^{c} .  \tag{Hg-2}\\
\left\|\mathcal{D}\left(\Phi_{g}\right)\right\| & \leq B d^{b} \delta_{g}^{-a}, & \tag{Hg-3}
\end{align*}
$$

Remark 6.1. We use the hypotheses presented in [20] for the approximation of function defined over non bounded sets.

In addition to the previous assumptions, we will require structural properties related to the domain $D$ itself.

Assumptions 2. Let $\alpha \in(1,2), a, b \geq 1$ and $B>0$. Suppose that $D$ bounded domain enjoys the following structure.
(1) For any $\delta_{\text {dist }} \in(0,1)$, the function $x \mapsto \operatorname{dist}(x, \partial D)$ can be approximated by a ReLu $D N N \Phi_{\text {dist }} \in N$ such that

$$
\begin{equation*}
\sup _{x \in D}\left|\operatorname{dist}(x, \partial D)-\left(\mathcal{R}\left(\Phi_{\text {dist }}\right)\right)(x)\right| \leq \delta_{\text {dist }}, \tag{HD-1}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|\mathcal{D}\left(\Phi_{\text {dist }}\right)\right\| \leq B d^{b}\left\lceil\log \left(\delta_{\text {dist }}^{-1}\right)\right\rceil^{a} . \tag{HD-2}
\end{equation*}
$$

(2) For all $\delta_{\alpha} \in(0,1)$ there exists a ReLu DNN $\Phi_{\alpha} \in N$ such that

$$
\begin{equation*}
\sup _{|x| \leq \operatorname{diam}(D)}\left|\left(\mathcal{R}\left(\Phi_{\alpha}\right)\right)(x)-x^{\alpha}\right| \leq \delta_{\alpha} . \tag{HD-3}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|\mathcal{D}\left(\Phi_{\alpha}\right)\right\| \leq B d^{b} \delta_{\alpha}^{-a} . \tag{HD-4}
\end{equation*}
$$

Moreover, $\mathcal{R}\left(\Phi_{\alpha}\right)$ is a $L_{\alpha}$-Lipschitz function, $L_{\alpha}>0$, for $|x| \leq \operatorname{diam}(D)$.
Remark 6.2. Notice that Assumption (HD-3) is assured by Hornik's Theorem [19]. Also, (HD-2) may seem too demanding because of the log term, but actually this is the situation in the case of a ball, see [15].

In the next proposition prove the existence of a ReLu DNN such that the Dirichlet problem without source is well approximated.

Proposition 6.1. Let $\alpha \in(1,2), L_{g}>0$ and

$$
\begin{equation*}
p, s \in(1, \alpha) \text { such that } s<\frac{\alpha}{p} \quad \text { and } \quad q \in\left[s, \frac{\alpha}{p}\right) . \tag{6.3}
\end{equation*}
$$

Suppose that the function g satisfies (Hg-0) and Assumptions 1. Suppose additionally that $D$ satisfies Assumptions 园. Then for all $\varepsilon \in(0,1)$ there exists a ReLu $D N N \Psi_{1, \varepsilon}$ that satisfies
(1) Proximity in $L^{q}(D)$ :

$$
\begin{equation*}
\left(\int_{D}\left|\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]-\left(\mathcal{R}\left(\Psi_{1, \varepsilon}\right)\right)(x)\right|^{q} d x\right)^{\frac{1}{q}} \leq \varepsilon . \tag{6.4}
\end{equation*}
$$

(2) Realization: $\mathcal{R}\left(\Psi_{1, \varepsilon}\right)$ has the following structure: there exists $M \in \mathbb{N}, \bar{N}_{i} \in \mathbb{N}$, $Y_{i, n}$ i.i.d. copies of $X_{\sigma_{B(0,1)}}$ under $\mathbb{P}_{0}$, for $i=1, \ldots, M, n=1, \ldots, \bar{N}_{i}$ such that for all $x \in D$,

$$
\begin{equation*}
\mathcal{R}\left(\Psi_{1, \varepsilon}\right)(x)=\frac{1}{M} \sum_{i=1}^{M}\left(\mathcal{R}\left(\Phi_{g}\right) \circ \mathcal{R}\left(\Phi_{\overline{N_{i}}}^{i}\right)\right)(x), \tag{6.5}
\end{equation*}
$$

where $\Phi_{\bar{N}_{i}}^{i}$ is a ReLu DNN approximating $X_{\mathcal{I}\left(\bar{N}_{i}\right)}^{i}=X_{\mathcal{I}\left(\bar{N}_{i}\right)}^{i}\left(x, Y_{i, 1}, \ldots, Y_{i, \bar{N}_{i}}\right)$.
(3) Bounds: There exists $\widetilde{B}>0$ such that

$$
\begin{equation*}
\left.\left\|\mathcal{D}\left(\Psi_{1, \varepsilon}\right)\right\||\leq \widetilde{B}| D\right|^{\frac{1}{q}\left(2 a+a p+\frac{s}{s-1}(1+2 a+a p)\right)} d^{b+2 a p+2 a p^{2}+\frac{p s}{s-1}(1+2 a+a p)} \varepsilon^{-a-\frac{s}{s-1}(1+2 a+a p)} . \tag{6.6}
\end{equation*}
$$

Remark 6.3. The hypotheses (6.3) are non empty if $\alpha \in(1,2)$. This requirement is standard in the literature devoted to the Fractional Laplacian, where some proofs are highly dependent on the cases $\alpha \in(0,1]$ versus $\alpha \in(1,2)$.
Remark 6.4. The condition $\alpha \in(1,2)$ is very important. In particular, if $\alpha \in(0,1)$ the hyportheses (6.3) are empty, and moreover, processes that we are working with not necessarily have finite expectation and there are not guarantee on the convergence of the ReLu DNNs.
6.2. Proof of Proposition 6.1: existence. The proof will be divided in several steps. As explained before, we follow the ideas in [15], with several changes due to the nonlocal character of the treated equation.

Let $s, p$ and $q$ be as in (6.3).
Step 1. Preliminaries. Let $\left(\rho_{n}\right)_{n \in \mathbb{N}}$ be a WoS process introduced in Definition 4.1 starting from $x \in D$. Let also $\mathcal{I}(N)$ and $N$ be defined as in (4.10) and (4.11). Recall that from (5.1),

$$
\begin{equation*}
u(x)=\mathbb{E}_{x}\left[g\left(\rho_{N}\right)\right]=\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right] . \tag{6.7}
\end{equation*}
$$

From the construction of $X_{\mathcal{I}(N)}$, one has that $X_{\mathcal{I}(N)} \in D^{c}$ and it depends on $N$ i.i.d. copies of $X_{\sigma_{B(0,1)}}$, namely

$$
\begin{equation*}
X_{\mathcal{I}(N)}=X_{\mathcal{I}(N)}\left(x, Y_{1}, \ldots, Y_{N}\right) \tag{6.8}
\end{equation*}
$$

where each $Y_{n}, n=1, \ldots, N$, is an independent copy of $X_{\sigma_{B(0,1)}}$ under $\mathbb{P}_{0}$.
Let $M \in \mathbb{N}$. Consider $M$ copies of $X_{\mathcal{I}(N)}$ starting from $x \in D$, as described in (6.8). We denote such copies as

$$
\begin{equation*}
X_{\mathcal{I}\left(N_{i}\right)}^{i}=X_{\mathcal{I}\left(N_{i}\right)}^{i}\left(x, Y_{i, 1}, \ldots, Y_{i, N_{i}}\right), \tag{6.9}
\end{equation*}
$$

with $Y_{i, n}, i=1, \ldots, M, n=1, \ldots, N_{i}$ i.i.d. copies of $X_{\sigma_{B(0,1)}}$ under $\mathbb{P}_{0}$, and where each $N_{i}$ is an i.i.d. copy of $N$. Notice that for each copy, $N_{i}$ can be different (as a random variable).

With this in mind, and following [15], we introduce the Monte Carlo operator

$$
\begin{equation*}
E_{M}(x):=\frac{1}{M} \sum_{i=1}^{M}\left(\mathcal{R}\left(\Phi_{g}\right)\right)\left(X_{\mathcal{I}\left(N_{i}\right)}^{i}\right), \tag{6.10}
\end{equation*}
$$

where $\mathcal{R}\left(\Phi_{g}\right)$ denotes the realization as a continuous function of the DNN $\Phi_{g} \in \mathbf{N}$ that approximates $g$ in Assumption (1) Notice that $E_{M}(x)$ may not be a DNN in the general case.

Our main objective in the following steps is to obtain suitable bounds on the difference between the expectation of $g\left(X_{\mathcal{I}(N)}\right)$ and $E_{M}(x)$, in a certain sense to be determined. Step 2 controls the difference between $\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]$ and the intermediate term $\mathbb{E}_{x}\left[\left(\mathcal{R}\left(\Phi_{g}\right)\right)\left(X_{\mathcal{I}(N)}\right)\right]$. Notice that this last term is not necessarily a DNN, because of the quantity $X_{\mathcal{I}(N)}$.
Step 2. Define

$$
J_{1}:=\left|\mathbb{E}_{x}\left[g\left(X_{\mathcal{I}(N)}\right)\right]-\mathbb{E}_{x}\left[\left(\mathcal{R}\left(\Phi_{g}\right)\right)\left(X_{\mathcal{I}(N)}\right)\right]\right|
$$

Notice that by Jensen inequality and hypothesis (Hg-1) one has

$$
J_{1} \leq \mathbb{E}_{x}\left[\left|g\left(X_{\mathcal{I}(N)}\right)-\left(\mathcal{R}\left(\Phi_{g}\right)\right)\left(X_{\mathcal{I}(N)}\right)\right|\right] \leq B d^{p} \delta_{g} \mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p}\right]
$$

Recall that we have an expression for $\mathbb{E}_{0}\left[\left|X_{\sigma_{B(0,1)}}\right|^{\beta}\right]$ with $\beta<\alpha$ from Corollary 4.3, The idea is to find a bound for $\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p}\right]$ in terms of (4.5).

Let $R>1$ be large enough to have $D \subset B^{*}:=B(x, R)$. The right hand side of the previous inequality is going to be separated in two terms: the case where $\sigma_{D}=\sigma_{B^{*}}$, and otherwise. Notice that $\sigma_{D}>\sigma_{B^{*}}$ is not possible. We obtain:

$$
J_{1} \leq B d^{p} \delta_{g}\left(\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p} \mathbf{1}_{\left\{\sigma_{D}=\sigma_{B^{*}}\right\}}\right]+\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p} \mathbf{1}_{\left\{\sigma_{D}<\sigma_{B^{*}}\right\}}\right]\right)
$$

In the case of the equality, the processes $X_{\mathcal{I}(N)}$ and $X_{\sigma_{B^{*}}}$ are equal on law under $\mathbb{P}_{x}$ from Lemma 4.5 and Remark 4.6. Then the Markov property and the scaling property of the process (see (4.2) and (4.31)) can be used to get

$$
\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p} \mathbf{1}_{\left\{\sigma_{D}=\sigma_{B^{*}}\right\}}\right]=\mathbb{E}_{0}\left[\left(1+\left|x+R X_{\sigma_{B(0,1)}}\right|\right)^{p}\right]
$$

On the other hand note that if $\sigma_{D}<\sigma_{B^{*}}$ then $X_{\mathcal{I}(N)} \in B^{*} \backslash D$. Therefore

J_{1} \leq B d^{p} \delta_{g}\left(\mathbb{E}_{0}\left[\left(1+\left|x+R X_{\sigma_{B(0,1)}}\right|\right)^{p}\right]+\sup _{y \in B^{*} \backslash D}(1+|y|)^{p}\right)

Using the Minkowski inequality and the fact that the sets $D$ and $B^{*} \backslash D$ are bounded, one has

\end{aligned}

where $K_{1}$ and $K_{2}$ are constants such that for all $x \in D, y \in B^{*} \backslash D$

Now using hypothesis $\overline{\mathrm{Hg}-2)}$ and the same results in previous Step to obtain

& \leq 2 B d^{p} \mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p q}\right]^{\frac{1}{q}} \\
& \leq 2 B d^{p}\left(\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p q} \mathbf{1}_{\left\{\sigma_{D}=\sigma_{B^{*}}\right\}}\right]^{\frac{1}{q}}+\mathbb{E}_{x}\left[\left(1+\left|X_{\mathcal{I}(N)}\right|\right)^{p q} \mathbf{1}_{\left\{\sigma_{D}<\sigma_{B^{*}}\right\}}\right]^{\frac{1}{q}}\right),
\end{aligned}
$$

where we recall that $B^{*}$ is a ball in $\mathbb{R}^{d}$ centered in $x$ with radious $R>1$ large enough such that $D \subset B^{*}$. Then using the scaling property of $X$ and Minkowski inequality, we have

Although similar to the steps followed in [15], here we need additional estimates because of the non continuous nature of the Lévy jump processes.

Step 5. In order to bound the following expectation

& \leq\left(\delta_{g}+\frac{2 \Theta_{q, s}}{M^{1-\frac{1}{s}}}\right)^{q}|D| B^{q} d^{p q} C^{q}+\left(\frac{2 \Theta_{q, s}}{M^{1-\frac{1}{s}}}\right)^{q}(1+K(\alpha, q)) \frac{2-\widetilde{p}}{\widetilde{p}^{2}} . \quad=: \operatorname{error}_{g}^{q}
\end{align*}

& \leq \text { error }_{g}^{q} .

Let $\beta_{g}=\mathcal{D}\left(\Phi_{g}\right)$ and $H_{g}=\operatorname{dim}\left(\beta_{g}\right)-2$. By Lemma 3.3 one has that

$$

In addition

\left\|\mathcal{D}\left(\Psi_{1, \varepsilon}\right)\right\| & \leq \sum_{i=1}^{M} \max \left\{\left\|\mathcal{D}\left(\Phi_{g}\right)\right\|, 2 d+\left\|\mathcal{D}\left(\Phi_{\text {dist }}\right)\right\| \|\right\}  \tag{6.37}\\
& \leq M\left(\left\|\mathcal{D}\left(\Phi_{g}\right)\right\|\|+2 d+\| \mathcal{D}\left(\Phi_{\text {dist }}\right)\| \|\right)
\end{align*}

Notice fron (6.31) that the constants $C_{1}$ and $C_{2}$ are bounded by a multiple of $|D|^{\frac{1}{q}} d^{p}$. Therefore, by choice of $M$,

## 7. Approximation of solutions of the Fractional Dirichlet problem using DNNS: THE SOURCE CASE

7.1. Non-homogeneous Fractional Laplacian. In the previous subsection we have proved the the solution (6.2) of the fractional Dirichlet Problem without source can be approximated by a ReLu DNN. In this subsection we focus in the term

We will prove that (7.1) can be approximated by a ReLu DNN that does not suffer of the curse of dimensionality. Notice that (7.1) corresponds to the extra term in the solution (1.3) of the fractional Dirichlet Problem with source (1.2). In order to do this approximation, the following assumption will be introduced
Assumptions 3. Let $d \geq 2$. Let $f: D \rightarrow \mathbb{R}$ a function satisfying (Hf-0). Let $\delta_{f} \in(0,1)$, $a, b \geq 1$ and $B>0$. Then there exists a ReLu $D N N \Phi_{f} \in N$ with
(1) $\mathcal{R}\left(\Phi_{f}\right): D \rightarrow \mathbb{R}$ is $\widetilde{L}_{f}$-Lipschitz continuous, $\widetilde{L}_{f}>0$, and
(2) The following are satisfied:

Proposition 7.1. Let $\alpha \in(1,2), L_{f}>0$ and

Then for all $\widetilde{\varepsilon} \in(0,1)$, there exists a ReLu $D N N \Psi_{2, \widetilde{\varepsilon}}$ such that

Let $M_{2} \in \mathbb{N}$. for all $n=1, \ldots, N$ let $\left(v_{j, n}\right)_{j=1}^{M_{2}}$ be $M_{2}$ copies of a random variable $v$ with distribution $\mu$ over $B(0,1)$. For all $n=1, \ldots, N$ and $\chi \in L^{2}(B(0,1), \mu)$ define the Monte Carlo operator

We want to establish suitable bounds of the difference between (7.1) and the operator $E_{M_{1}}(x)$. For this, in the next step we work for all $n=1, \ldots, N$ with the term

\end{aligned}
$$

From Remark 7.1 it follows that

& \leq \frac{2 \Theta_{q, s}\left(\delta_{f}+\|f\|_{L^{\infty}(D)}\right)}{M_{2}^{1-\frac{1}{s}}}
\end{aligned}

Then for any $n=1, \ldots, N$ there exists $v_{j, n}, j=1, \ldots, M_{2}$, i.i.d random variables with distribution $\mu$ such that

## 8. Proof of the Main Result

This final section is devoted to the proof of Theorem 1.1. Gathering Propositions 6.1 and 7.1. Theorem 1.1 is finally proved.

Step 1. Let $\alpha \in(1,2), p, s \in(1, \alpha)$ such that $s<\frac{\alpha}{p}$ and $q \in\left[s, \frac{\alpha}{p}\right)$. Let Assumptions (Hg-0) and (Hf-0) be satisfied. Recall from Theorem 5.1] and Lemma55.1 that the solution $u$ of (1.2) takes the form of (5.8), namely

For the right approximation of the ReLu DNNs, $\delta_{\text {dist }}$ and $M$ will be defined as

Recall that the constants in $\ell_{1}$ and $\ell_{2}$ are defined in Propositions 6.1 and 7.1. Let $\epsilon \in(0,1)$ and define the ReLu DNN $\Psi_{\epsilon}$ that satisfies for all $x \in D$

Step 2 We now study the ReLu DNN $\Psi_{\epsilon}$. For $i=1, \ldots, M$ Let $\bar{N}_{i, 1}, \bar{N}_{i, 2}$ the random variables $\bar{N}_{i}$ found in the Propositions 6.1 and 7.1, respectively. Recall that the DNN $\Psi_{1, \varepsilon}$ satisfy

We compound each DNN by a suitable ReLu DNN that represents the identity function. Define then the $\operatorname{ReLu}$ DNN $\bar{\Psi}_{1, \varepsilon}$ that satisfy $\mathcal{R}\left(\bar{\Psi}_{1, \varepsilon}\right)=\mathcal{R}\left(\Psi_{1, \varepsilon}\right)$ with

\operatorname{dim}\left(\mathcal{D}\left(\bar{\Psi}_{1, \varepsilon}\right)\right)=\left(H_{\text {dist }}+1\right) \sum_{i=1}^{M}\left(\bar{N}_{i, 1}+\bar{N}_{i, 2}\right)+H_{\alpha}+H_{f}+H_{g}+H_{\Upsilon}+4 .
$$

Therefore we can use Lemma 3.4 to obtain that $\Psi_{\epsilon}$ is a ReLu DNN such that

$$
\mathcal{D}\left(\Psi_{\epsilon}\right)=\mathcal{D}\left(\bar{\Psi}_{1, \varepsilon}\right) \boxplus \mathcal{D}\left(\bar{\Psi}_{2, \widetilde{\varepsilon}}\right),
$$

and

$$
\operatorname{dim}\left(\mathcal{D}\left(\Psi_{\epsilon}\right)\right)=\left(H_{\text {dist }}+1\right) \sum_{i=1}^{M}\left(\bar{N}_{i, 1}+\bar{N}_{i, 2}\right)+H_{\alpha}+H_{f}+H_{g}+H_{\Upsilon}+4
$$

Moreover

$$
\left\|\mathcal{D}\left(\Psi_{\epsilon}\right)\right\| \leq\left\|\mathcal{D}\left(\Psi_{1, \varepsilon}\right)\right\|+\left\|\mathcal{D}\left(\Psi_{2, \widetilde{\varepsilon}}\right)\right\| .
$$

Recall from Propositions 6.1 and 7.1 that there exists $\widetilde{B}>0$ such that

$$
\left\|\mathcal{D}\left(\Psi_{1, \varepsilon}\right)\right\| \leq \widetilde{B}|D|^{\frac{1}{q}\left(2 a+a p+\frac{s}{s-1}(1+2 a+a p)\right)} d^{b+2 a p+2 a p^{2}+\frac{p s}{s-1}(1+2 a+a p)} \varepsilon^{-a-\frac{s}{s-1}(1+2 a+a p)} .
$$

and

$$
\left\|\left.\mathcal{D}\left(\Psi_{2, \widetilde{\varepsilon}}\right)|\| \leq \widetilde{B}| D\right|^{\frac{1}{q}\left(1+2 a+\frac{2 s}{s-1}(1+a)\right)} d^{b} \widetilde{\varepsilon}^{-a-\frac{2 s}{s-1}(1+a)} .\right.
$$

Therefore

$$
\left.\left\|\mathcal{D}\left(\Psi_{\epsilon}\right)\right\||\leq \widehat{B}| D\right|^{\frac{1}{q}\left(1+2 a+a p+\frac{s}{s-1}(2+2 a+a p)\right)} d^{b+2 a p+a p^{2}+\frac{p s}{s-1}(1+2 a+a p)} \epsilon^{-a-\frac{s}{s-1}(2+2 a+a p)},
$$

where $\widehat{B}>0$ is a generic constant. Theorem 1.1 can be concluded choosing $\eta>0$ as the maximum between $\frac{1}{q}\left(1+2 a+a p+\frac{s}{s-1}(2+2 a+a p)\right), b+2 a p+a p^{2}+\frac{p s}{s-1}(1+2 a+a p)$ and $\frac{s}{s-1}(2+2 a+a p)$.
