# Degree–Based Topological Indices of a General Random Chain

**Abstract:** Let G = (V(G), E(G)) a graph, many important topological indices can be defined as  $TI(G) = \sum_{vu \in E(G)} h(d_v, d_u)$ . In this paper, we look at one type of general random chains and an alternative approach to study these kinds of topological indices is proposed. In which their explicit analytical expressions of the expected values and variances are obtained. Moreover, the asymptotic normality of topological indices of a random chain is established through the Martingale Central Limit Theorem.

#### 1 Introduction

All graphs considered in this paper are finite, simple and connected unless otherwise specified. A graph is a pair G = (V(G), E(G)) of sets such that the elements of V(G) are the nodes of the graph G and the elements of E(G) are its edges. Undoubtedly, graph theory concepts are potentially applicable for many purposes, for instance, a chemical graph is a model of a chemical system, i.e., a graph is used to represent a molecule by considering the atoms as the nodes of the graph and the molecular bonds as the edges.

On the other hand, the topological indices quantify the structural information contained in the graph and are independent of the numbering of the nodes and edges. In 1947, Wiener began to use topological indices to study some physicochemical properties of alkanes, thus giving rise to chemical graph theory (Wiener 1947). In fact, since then, several topological indices have been introduced and extensively studied to better understand the molecular structure (Kulli 2020; Rauf, Naeem, and Bukhari 2021; Shao, Jahanbani, and Sheikholeslami 2020). In particular, Sombor index was recently introduced by Gutman in (Gutman 2021). Recent papers about Sombor index can be found in (Liu, Chen, Xiao, Fang, and Tang 2021; Chen, Li, and Wang 2021; Liu, You, Tang, and Liu 2021; Alikhani and Ghanbari 2021; Amin, Virk, Rehman, and Shah 2021; Das, Çevik, Cangul, and Shang 2021). Nowadays, the characterization of molecular structure through topological indices is performed using chemical graph theory, for this reason, this theory plays a vital role in the design of molecular structures with desired physico-chemical or biological properties. By the way, many important topological indices (degree-based topological indices) can be defined as

$$TI(G) = \sum_{vu \in E(G)} h(d_v, d_u), \tag{1}$$

where h is some function with the property h(x, y) = h(y, x) for  $x, y \in \{1, 2...\}$ and  $d_v$  is the degree of a node v. Here  $h_{x,y} := h(x, y)$ .

In the field of random chains analysis, topological indices have been an evolving research topic for the past two decades (Shang 2015). Multiple topological indices have been analyzed for different random chains, such as, random cyclooctane chains ((Raza and Imran 2021),(Wei, Ke, and Wang 2018)), random polyphenyl chains ((Raza, Naz, and Ahmad 2022),(Ke, Wei, and Huang 2021)), random phenylene chains ((Raza 2021), (Raza 2020a)), random spiro chains ((Jahanbani 2020),(Raza 2020b)) and random hexagonal chains ((Dobrynin, Gutman, Klavžar, and Žigert 2002),(Fang, You, and Liu 2021)). In ((Zhang, You, Liu, and Huang 2021), Definition 2.1) the authors introduced the definition of a general random chain ( $G_n = G(n, p_1, p_2, \ldots, p_m)$ ). In addition, the article was devoted to establishing the distributions for Sombor indices in a general random chain, in which their explicit analytical expressions of the expected values and variances were obtained. Note that,  $G_n$  is constructed by a zero-order Markov process (0MP) since the probabilities  $p_i$  are constants.

Now, let  $L_n$  denote the link selected at time  $n \ge 2$ , i.e.,  $L_2$  denote the initial link and for  $n \ge 3$ ,  $L_n$  denote a random variable with range  $\{1, 2, \ldots, m\}$  and let  $p_i = \mathbb{P}(L_n = i)$ . Hence, at time  $n-1 \ge 2$ , the random vector  $(L_2, L_3, \ldots, L_{n-1})$  can be associated to  $G_{n-1}$ , indicating the links chose in the construction of  $G_{n-1}$ . Next at time n, by definition,  $(L_2, L_3, \ldots, L_{n-1}, L_n)$  is the random vector associated to  $G_n$ .

Clearly, let  $n \geq 3$  there is a change between  $G_{n-1}$  and  $G_n$ . This change consists of the degrees of the vertices connected by edges that are in  $G_n$  and were not in  $G_{n-1}$  and the degrees of the vertices in both  $G_{n-1}$  and  $G_n$  connected by edges that were modified by going from  $G_{n-1}$  to  $G_n$  (this type of edges are in both  $G_{n-1}$  and  $G_n$  and also at least the degree of one of its endvertices was modified). We say that a general random chain is a 0MP-random chain, if for all  $n, N \geq 3$ and for all realization of  $G_{n-1}$  and  $G_{N-1}$  the change between  $G_{n-1}$  and  $G_n^i$  is equal to the change between  $G_{N-1}$  and  $G_N^i$ , i.e., the change is independent of n and of the links selected in the previous events (the change depends only on the link selected in the last step).

In this manuscript, our main purpose is to determine explicit formulas for the expected values, variances and asymptotic distribution for topological indices defined in Equation (1) in a 0MP-random chain.

#### 2 Main Results and Proofs

In this section, we state and prove our main results. First, let  $n, m \ge 2$  and  $i \in \{1, 2, ..., m\}$ , then  $TI_n = TI(G_n)$  and for  $n \ge 3$ ,  $TI_{n,i} = TI(G_n^i)$ ,  $\alpha_i = TI_{3,i} - TI_2$ ,  $\alpha = \sum_{i=1}^m \alpha_i p_i$  and  $\beta = \sum_{i=1}^m \alpha_i^2 p_i$ .

**Theorem 1.** Let  $G_n = G(n, p_1, p_2, ..., p_m)$  be a 0MP-random chain, then for  $n \ge 2$ 

$$\mathbb{E}(TI_n) = TI_2 + \alpha(n-2),$$
  
$$V(TI_n) = (\beta - \alpha^2)(n-2).$$

*Proof.* Let  $n \geq 3$ , since  $G_n$  is a 0MP-random chain, it follows by definition of TI(G) in Equation (1) the following almost-sure relation of  $TI_n$  conditional on  $\mathbb{F}_{n-1}$  and the random variable  $L_n$ 

$$TI_{n,L_n} - TI_{n-1} = TI_{3,L_n} - TI_2,$$
(2)

where  $\mathbb{F}_{n-1}$  denotes the  $\sigma$ -field generated by the history of the growth of the random chain in the first n-1 stages. Now for  $n \geq 3$ , we take the expectation with respect to  $L_n$  to get

$$\mathbb{E}(TI_n \mid \mathbb{F}_{n-1}) = \sum_{i=1}^m (TI_{n-1} + \alpha_i)p_i$$
$$= TI_{n-1} + \sum_{i=1}^m \alpha_i p_i,$$

where,  $\alpha_i = TI_{3,i} - TI_2$ . Then, taking expectation, we obtain a recurrence relationship for  $\mathbb{E}(TI_n)$ ,

$$\mathbb{E}(TI_n) = \mathbb{E}(TI_{n-1}) + \sum_{i=1}^m \alpha_i p_i.$$
(3)

We solve Equation (3) with the initial value  $\mathbb{E}(TI_2) = TI_2$  and we obtain the result stated in the theorem,

$$\mathbb{E}(TI_n) = TI_2 + \alpha(n-2),$$

where  $\alpha = \sum_{i=1}^{m} \alpha_i p_i$ . The expression for  $\mathbb{E}(TI_n^2)$  follows in a similar manner,

$$\mathbb{E}(TI_n^2 \mid \mathbb{F}_{n-1}) = \sum_{i=1}^m (TI_{n-1} + \alpha_i)^2 p_i$$
  
=  $\sum_{i=1}^m TI_{n-1}^2 p_i + 2TI_{n-1}\alpha_i p_i + \alpha_i^2 p_i$   
=  $TI_{n-1}^2 + 2TI_{n-1}\alpha + \beta$ ,

where  $\beta = \sum_{i=1}^{m} \alpha_i^2 p_i$ , thus

$$\mathbb{E}(TI_n^2) = \mathbb{E}(TI_{n-1}^2) + 2\alpha \mathbb{E}(TI_{n-1}) + \beta$$
  
=  $\mathbb{E}(TI_{n-1}^2) + 2\alpha TI_2 + 2\alpha^2(n-3) + \beta$ ,

with  $\mathbb{E}(TI_2^2) = TI_2^2$ , then iterating, it is obtained that

$$\mathbb{E}(TI_n^2) = TI_2^2 + (2\alpha TI_2 + \beta)(n-2) + (n-3)(n-2)\alpha^2.$$

The variance of  $TI_n$  is obtained immediately by taking the difference between  $\mathbb{E}(TI_n^2)$  and  $\mathbb{E}(TI_n)^2$ ,

$$V(TI_n) = \beta(n-2) + ((n-2)(n-3) - (n-2)^2) \alpha^2$$
  
= (\beta - \alpha^2)(n-2),

proving the theorem.

Note that the following equivalences are verified:  $TI_n = TI_2 + \alpha(n-2)$  a.s. with  $n \geq 3$  (a deterministic sequence) if and only if  $\beta - \alpha^2 = 0$  if and only if  $\alpha_1 = \alpha_2 = \cdots = \alpha_m$ . Now, we exploit a martingale formulation to investigate the asymptotic behavior of  $TI_n$  when  $\beta - \alpha^2 > 0$ . The key idea is to consider a transformation  $M_n$  and we require that the transformed random variables form a martingale in the next proposition.

**Proposition 1.** For  $n \geq 2$ ,  $\{M_n = TI_n - \alpha(n-2)\}_n$  is a martingale with respect to  $\mathbb{F}_n$ .

*Proof.* Firstly, observe that  $\mathbb{E}(|M_n|) < +\infty$ . Let  $n \ge 3$ , then by Theorem 1,

$$\mathbb{E} \left( M_n \mid \mathbb{F}_{n-1} \right) = \mathbb{E} \left( TI_n - \alpha(n-2) \mid \mathbb{F}_{n-1} \right) = \mathbb{E} \left( TI_n \mid \mathbb{F}_{n-1} \right) - \alpha(n-2)$$
$$= TI_{n-1} + \alpha - \alpha(n-2)$$
$$= TI_{n-1} - \alpha(n-3)$$
$$= M_{n-1}.$$

The proof is completed.

We use the notation  $\xrightarrow{D}$  to denote convergence in distribution and  $\xrightarrow{P}$  to denote convergence in probability. The random variable N ( $\mu, \sigma^2$ ) appears in the following theorem to denote the normal distribution with mean  $\mu$  and variance  $\sigma^2$ .

**Theorem 2.** As  $n \to \infty$ ,

$$\frac{TI_n - \alpha(n-2)}{\sqrt{n}} \xrightarrow{D} N(0, \beta - \alpha^2).$$

*Proof.* Note that, for  $k \geq 3$  and  $i \in \{1, 2, ..., m\}$ , by using Equation (2), we have

$$|\nabla M_k| = |\nabla TI_k - \alpha| \le 2 \max_i \{|\alpha_i|\},\$$

where  $\nabla M_k = M_k - M_{k-1}$  and  $\nabla TI_k = TI_k - TI_{k-1}$ . Then, as n goes to  $\infty$ 

$$\lim_{n \to \infty} \frac{|\nabla M_k|}{\sqrt{n}} = 0.$$

That is, given  $\varepsilon > 0$ , there exists an  $N_0(\varepsilon) > 0$  such that, the sets  $\{|\nabla M_k| > \varepsilon \sqrt{n}\}$  are empty for all  $n > N_0(\varepsilon)$ . In what follows, we conclude that

$$U_n := \frac{1}{n} \sum_{k=3}^n \mathbb{E}\left( (\nabla M_k)^2 \mathbb{I}_{\left\{ |\nabla M_k| > \varepsilon \sqrt{n} \right\}} \mid \mathbb{F}_{k-1} \right),$$

converges to 0 almost surely, hence,  $U_n \xrightarrow{P} 0$ . Then, the Lindeberg's condition is verified. Next, the conditional variance condition is given by

$$V_n := \frac{1}{n} \sum_{k=3}^n \mathbb{E}\left( \left( \nabla M_k \right)^2 \mid \mathbb{F}_{k-1} \right) \xrightarrow{P} \beta - \alpha^2.$$

Note that,

$$\frac{1}{n}\sum_{k=3}^{n} \mathbb{E}\left(\left(\nabla M_{k}\right)^{2} \mid \mathbb{F}_{k-1}\right) = \frac{1}{n}\sum_{k=3}^{n} \mathbb{E}\left(\left(\nabla TI_{k} - \alpha\right)^{2} \mid \mathbb{F}_{k-1}\right)$$
$$= \frac{1}{n}\sum_{k=3}^{n}\sum_{i=1}^{m} (\alpha_{i} - \alpha)^{2} p_{i}$$
$$= \frac{n-2}{n}\sum_{i=1}^{m} (\alpha_{i} - \alpha)^{2} p_{i}.$$

By the Martingale Central Limit Theorem (Hall and Heyde 2014), we thus obtain the stated result, since

$$\sum_{i=1}^{m} (\alpha_i - \alpha)^2 p_i = \sum_{i=1}^{m} \alpha_i^2 p_i - 2\alpha \sum_{i=1}^{m} \alpha_i p_i + \alpha^2$$
$$= \beta - \alpha^2.$$

Using Theorem 1, we may use Theorem 2 to find the following result.

Corollary 1. As  $n \to \infty$ ,

$$\frac{{}^{TI_n-\mathbb{E}(TI_n)}}{\sqrt{V(TI_n)}} \xrightarrow{D} N(0,1).$$

The following theorem gives further details on the distribution for topological indices in a general random chain. Here,  $M_R(\cdot)$  denotes the moment generating function of a random variable R.

**Theorem 3.** Let  $G_n$  with  $n \geq 2$  be a random chain. Then,

$$TI_n = TI_2 + a^T X,$$

where  $m \geq 2$ ,  $a^T = (\alpha_1, \alpha_2, \dots, \alpha_m)$  and  $X = (X_1, X_2, \dots, X_m)$  is a multinomial random variable with parameters n-2 and  $(p_1, p_2, \dots, p_m)$ .

*Proof.* Let  $t \in \mathbb{R}$ , note that,

$$\mathbb{E}\left(e^{tTI_n} \mid \mathbb{F}_{n-1}\right) = \sum_{i=1}^m e^{tTI_{n-1}} e^{t\alpha_i} p_i$$
$$= e^{tTI_{n-1}} \sum_{i=1}^m e^{t\alpha_i} p_i.$$

Thus, we can conclude that

$$M_{TI_n}(t) = M_{TI_{n-1}}(t) \sum_{i=1}^m e^{t\alpha_i} p_i.$$

We may therefore write,

$$M_{TI_{n}}(t) = M_{TI_{2}}(t) \left(\sum_{i=1}^{m} e^{t\alpha_{i}} p_{i}\right)^{n-2}$$
  
=  $M_{TI_{2}}(t) M_{X}(\alpha_{1}t, \alpha_{2}t, \dots, \alpha_{m}t)$   
=  $M_{TI_{2}}(t) M_{a^{T}X}(t),$ 

which completes the proof.

It is useful to note that the approximation given in Corollary 1 is identical to the one obtained by using Theorem 3 and the Central Limit Theorem in the case of random vectors (Severini et al. 2012).

### 3 Examples

In order to apply the results obtained in Section 2, we present the following corollaries.

**Corollary 2.** Let  $RPC_n = RPC(n, p_1, p_2, p_3)$  be a random phenylene chain with  $n \ge 2$ . Then

$$\begin{split} TI_n &= AX + Bn + C, \\ \mathbb{E} \left( TI_n \right) &= (Ap_1 + B)n - 2Ap_1 + C, \\ \mathbb{V} \left( TI_n \right) &= A^2 p_1 \left( 1 - p_1 \right) (n - 2), \\ \frac{TI_n - \mathbb{E} \left( TI_n \right)}{\sqrt{\mathbb{V} \left( TI_n \right)}} \xrightarrow{D} N(0, 1), \end{split}$$

where  $A = 2h_{2,3} - h_{2,2} - h_{3,3}$ ,  $B = h_{2,2} + 2h_{2,3} + 5h_{3,3}$ ,  $C = 4h_{2,2} - 6h_{3,3}$  and  $X \sim Binomial(n-2, p_1)$ .

*Proof.* Let G denote a hexagon, then a random phenylene chain is constructed by the following way: for n = 1 and n = 2,  $RPC_n$  are shown in Figure 1. For  $n \ge 3$ , the terminal hexagon can be attached in three ways, which results in  $RPC_n^1, RPC_n^2$  and  $RPC_n^3$ , respectively, see Figure 2. By definition, we have that  $RPC_n$  is a 0MP-random chain. Hence applying the results obtained in Section 2, we complete the proof.

**Corollary 3.** Let  $RPoC_n = RPoC(n, p_1, p_2, p_3)$  be a random polyphenyl chain with  $n \ge 2$ . Then

 $TI_n = AX + Bn + C,$   $\mathbb{E} (TI_n) = (Ap_1 + B)n - 2Ap_1 + C,$   $\mathbb{V} (TI_n) = A^2 p_1 (1 - p_1) (n - 2),$  $\frac{TI_n - \mathbb{E} (TI_n)}{\sqrt{\mathbb{V} (TI_n)}} \xrightarrow{D} N(0, 1),$ 

where  $A = h_{2,2} - 2h_{2,3} + h_{3,3}$ ,  $B = 2h_{2,2} + 4h_{2,3} + h_{3,3}$ ,  $C = 4h_{2,2} - 4h_{2,3} - h_{3,3}$ and  $X \sim Binomial(n-2, p_1)$ .

*Proof.* Let G denote a hexagon, then a random polyphenyl chain is constructed by the following way: for n = 1 and n = 2,  $RPoC_n$  are shown in Figure 3. For  $n \geq 3$ , the terminal hexagon can be attached in three ways, which results in  $RPoC_n^1, RPoC_n^2$  and  $RPoC_n^3$ , respectively, see Figure 4. By definition, we have that  $RPoC_n$  is a 0MP-random chain. Hence applying the results obtained in Section 2, we complete the proof.

**Corollary 4.** Let  $RCC_n = RCC(n, p_1, p_2, p_3, p_4)$  be a random cyclooctane chain with  $n \ge 2$ . Then

$$TI_n = AX + Bn + C,$$
$$\mathbb{E} (TI_n) = (Ap_1 + B)n - 2Ap_1 + C,$$
$$\mathbb{V} (TI_n) = A^2 p_1 (1 - p_1) (n - 2),$$
$$\frac{TI_n - \mathbb{E} (TI_n)}{\sqrt{\mathbb{V} (TI_n)}} \xrightarrow{D} N(0, 1),$$

where  $A = h_{2,2} - 2h_{2,3} + h_{3,3}$ ,  $B = 4h_{2,2} + 4h_{2,3} + h_{3,3}$ ,  $C = 4h_{2,2} - 4h_{2,3} - h_{3,3}$ and  $X \sim Binomial(n-2, p_1)$ .

*Proof.* Let G denote a octagon, then a random cyclooctane chain is constructed by the following way: for n = 1 and n = 2,  $RCC_n$  are shown in Figure 5. For  $n \geq 3$ , the terminal octagon can be attached in four ways, which results in  $RCC_n^1, RCC_n^2, RCC_n^3$  and  $RCC_n^4$  respectively, see Figure 6. By definition, we have that  $RCC_n$  is a 0MP-random chain. Hence applying the results obtained in Section 2, we complete the proof.

**Remark 1.** By Corollaries 2,3 and 4, we have

- 1.  $A_{RCC_n} = A_{RPoC_n} = -A_{RPC_n}$ ,
- 2.  $C_{RCC_n} = C_{RPoC_n}$ .
- 3.  $h_{2,2} + h_{3,3} = 2h_{2,3}$  if and only if  $TI_n = Bn + C$  for  $n \ge 2$ .
- 4. If  $h(x,y) = x^a + y^a$  with  $a \in \mathbb{R}$ , thus  $h_{2,2} + h_{3,3} = 2h_{2,3}$ , hence  $TI_n = Bn + C = \sum_{v \in V(G)} (d_v)^{a+1}$ , because of the identity (Došlić, Réti, and Vukičević 2011)

$$\sum_{vu \in E(G)} (d_v)^a + (d_u)^a = \sum_{v \in V(G)} (d_v)^{a+1}.$$

5. A similar argument may be used to show that random hexagonal and random spiro chains are 0MP-random chains.

Finally, given a fixed  $p_1 = 0.5$ , we independently generate 500 replications of each random chain after  $n = 10\ 000$  evolutionary steps. Next, we compute some

topological indices of each generated random chain, the resulting histograms are depicted in Figure 7, 8, 9 and 10. In addition, we use the kernel method to estimate the density based on the sample, presented in Figure 7, 8, 9 and 10 as well.
