# MODULES AT BOUNDARY POINTS, FIBERWISE BERGMAN KERNELS, AND LOG-SUBHARMONICITY II- ON STEIN MANIFOLDS

#### Abstract

In this article, we consider Bergman kernels related to modules at boundary points on Stein manifolds and obtain a log-subharmonicity property of the Bergman kernels. As applications, we obtain a lower estimate of weighted $L^{2}$ integrals on Stein manifolds and reprove an effectiveness result of the strong openness property of modules at boundary points on Stein manifolds.


## 1. Introduction

The strong openness property of multiplier ideal sheaves (i.e. $\mathcal{I}(\psi)=\mathcal{I}_{+}(\psi):=$ $\left.\cup_{\epsilon>0} \mathcal{I}((1+\epsilon) \psi)\right)$ has opened the door to new types of approximations, which has been widely used in the study of several complex variables, complex algebraic geometry, and complex differential geometry (see e.g. [39, 47, 8, 9, 22, 10, 59, 42, 7, 60, 61, [23, 48, 11), where $\psi$ is a plurisubharmonic function on a complex manifold $M$ (see [12]) and the multiplier ideal sheaf $\mathcal{I}(\psi)$ is the sheaf of germs of holomorphic functions $f$ such that $|f|^{2} e^{-\psi}$ is locally integrable (see e.g. [57, 50, [52, 15, 16, 14, [17, 49, [53, [54, 13, 43).

The strong openness property is a longstanding problem, which was conjectured by Demailly [14, 13 and proved by Guan-Zhou [39] (the 2-dimensional case was proved by Jonsson-Mustaţă [45). Recall that Jonsson and Mustaţă (see [46], see also (45) posed the following conjecture to prove the strong openness property, and proved the 2 -dimensional case [45, which deduces the 2 -dimensional strong openness property:

Conjecture J-M: If $c_{o}^{F}(\psi)<+\infty, \frac{1}{r^{2}} \mu\left(\left\{c_{o}^{F}(\psi) \psi-\log |F|<\log r\right\}\right)$ has a uniform positive lower bound independent of $r \in(0,1)$, where $\mu$ is the Lebesgue measure on $\mathbb{C}^{n}$, and $c_{o}^{F}(\psi):=\sup \left\{c \geq 0:|F|^{2} e^{-2 c \psi}\right.$ is locally $L^{1}$ near $\left.o\right\}$.

Recall that Guan-Zhou [41 proved Conjecture J-M by using the strong openness property. It is natural to ask:
Question 1.1. Can one complete the approach from Conjecture J-M to the strong openness property?

Bao-Guan-Yuan 4 (see also (31) gave an affirmative answer to the above question by establishing a concavity property of the minimal $L^{2}$ integrals with respect to a module at a boundary point of the sublevel sets.

[^0]In [1], we considered Bergman kernels related to modules at boundary points on pseudoconvex domains, and obtained a log-subharmonicity property of the Bergman kernels, which deduces a new approach from Conjecture J-M to the strong openness property.

In this article, we consider Bergman kernels related to modules at boundary points on Stein manifolds, and obtain the log-subharmonicity property of the Bergman kernels (the case of inner points can be referred to [2, 3,). As applications, we obtain a lower estimate of weighted $L^{2}$ integrals on sub-level sets on Stein manifolds, and reprove an effectiveness result of strong openness property of modules at boundary points on Stein manifolds.
1.1. Main result. Let $M$ be an $n$-dimensional Stein manifold, and let $K_{M}$ be the canonical (holomorphic) line bundle on $M$. Let $\psi$ be a plurisubharmonic function on $M$. Let $F \not \equiv 0$ be a holomorphic function on $M$, and let $T \in[-\infty,+\infty)$. Denote that

$$
\Psi:=\min \{\psi-2 \log |F|,-T\} .
$$

If $F(z)=0$ for some $z \in M$, set $\Psi(z)=-T$. For any $t \in[T,+\infty)$, denote that

$$
M_{t}:=\{z \in M: \Psi(z)<-t\} .
$$

Note that for any $t \geq T, M_{t}=\{\psi+2 \log |1 / F|<-t\}$ on $M \backslash\{F=0\}$. Hence $M_{t}$ is a Stein submanifold of $M$ for any $t \geq T$ (see [21]), and $\Psi=\psi+2 \log |1 / F|$ is a plurisubharmonic function on $M_{t}$.

Let $\varphi$ be a plurisubharmonic function on $M$. For any $t \geq T$, denote that

$$
A^{2}\left(M_{t}, e^{-\varphi}\right):=\left\{f \in H^{0}\left(M_{t}, \mathcal{O}\left(K_{M}\right)\right): \int_{M_{t}}|f|^{2} e^{-\varphi}<+\infty\right\}
$$

where $|f|^{2}:=\sqrt{-1}^{n^{2}} f \wedge \bar{f}$ for any $(n, 0)$ form $f$. For any $t \in[T,+\infty)$ and $\lambda>0$, denote that

$$
\Psi_{\lambda, t}:=\lambda \max \{\Psi+t, 0\}
$$

And for any $f \in A^{2}\left(M_{T}, e^{-\varphi}\right)$, denote that

$$
\|f\|_{\lambda, t}:=\left(\int_{M_{T}}|f|^{2} e^{-\varphi-\Psi_{\lambda, t}}\right)^{1 / 2}
$$

Note that

$$
\|f\|_{T}^{2}:=\|f\|_{\lambda, T}^{2}=\int_{M_{T}}|f|^{2} e^{-\varphi}
$$

for any $\lambda>0$, and

$$
e^{\lambda(T-t)}\|f\|_{T}^{2} \leq\|f\|_{\lambda, t}^{2} \leq\|f\|_{T}^{2}<+\infty
$$

for any $t \geq T$.
It is clear that $A^{2}\left(M_{T}, e^{-\varphi}\right)$ is a Hilbert space. Denote the dual space of $A^{2}\left(M_{T}, e^{-\varphi}\right)$ by $A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$. For any $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$, denote that the Bergman kernel related to $\xi$ is

$$
K_{\xi, \Psi, \lambda}^{\varphi}(t):=\sup _{f \in A^{2}\left(M_{T}, e^{-\varphi}\right)} \frac{|\xi \cdot f|^{2}}{\|f\|_{\lambda, t}^{2}}
$$

for any $t \in[T,+\infty)$, where $K_{\xi, \Psi, \lambda}^{\varphi}(t)=0$ if $A^{2}\left(M_{T}, e^{-\varphi}\right)=\{0\}$.
Denote $E_{T}:=(T,+\infty)+\sqrt{-1} \mathbb{R}:=\{w \in \mathbb{C}: \operatorname{Re} w>T\} \subset \mathbb{C}$. We obtain the following log-subharmonicity property of the Bergman kernel $K_{\xi, \Psi, \lambda}^{\varphi}$.

Theorem 1.2. Assume that $K_{\xi, \Psi, \lambda}^{\varphi}\left(t_{0}\right) \in(0,+\infty)$ for some $t_{0} \geq T$. Then $\log K_{\xi, \Psi, \lambda}^{\varphi}($ Re $w)$ is subharmonic with respect to $w \in E_{T}$.

When $M$ is a pseudoconvex domain in $\mathbb{C}^{n}$, and $T=0$, Theorem 1.2 can be referred to [1].

We recall some notations in [1, 31. Let $z_{0}$ be a point in $M$. Denote that

\tilde{J}(\Psi)_{z_{0}}:=\left\{f \in \mathcal{O}(\{\Psi<-t\} \cap V): t \in \mathbb{R}, V \text { is a neighborhood of } z_{0}\right\}
$$

and

$$
J(\Psi)_{z_{0}}:=\tilde{J}(\Psi)_{z_{0}} / \sim
$$

where the equivalence relation ' $\sim$ ' is as follows:

$$
f \sim g \Leftrightarrow f=g \text { on }\{\Psi<-t\} \cap V, \text { where } t \gg 1, V \text { is a neighborhood of } z_{0}
$$

For any $f \in \tilde{J}(\Psi)_{z_{0}}$, denote the equivalence class of $f$ in $J(\Psi)_{z_{0}}$ by $f_{z_{0}}$. And for any $f_{z_{0}}, g_{z_{0}} \in J(\Psi)_{z_{0}}$, and $\left(h, z_{0}\right) \in \mathcal{O}_{M, z_{0}}$, define

$$
f_{z_{0}}+g_{z_{0}}:=(f+g)_{z_{0}},\left(h, z_{0}\right) \cdot f_{z_{0}}:=(h f)_{z_{0}}
$$

It is clear that $J(\Psi)_{z_{0}}$ is an $\mathcal{O}_{M, z_{0}}$-module. For any $a \geq 0$, denote that $I(a \Psi+$ $\varphi)_{z_{0}}:=\left\{f_{z_{0}} \in J(\Psi)_{z_{0}}: \exists t \gg 1, V\right.$ is a neighborhood of $z_{0}$, s.t. $\int_{\{\Psi<-t\} \cap V}|f|^{2} e^{-a \Psi-\varphi} d V_{M}<$ $+\infty\}$, where $d V_{M}$ is a continuous volume form on $M$. Then it is clear that $I(a \Psi+\varphi)_{z_{0}}$ is an $\mathcal{O}_{M, z_{0}}$-submodule of $J(\Psi)_{z_{0}}$. Especially, we denote that $I(\varphi)_{z_{0}}:=$ $I(0 \Psi+\varphi)_{z_{0}}, I(\Psi)_{z_{0}}:=I(\Psi+0)_{z_{0}}$, and $I_{z_{0}}:=I(0 \Psi+0)_{z_{0}}$. Then $I(a \Psi+\varphi)_{z_{0}}$ is an $\mathcal{O}_{M, z_{0}}$-submodule of $I(\varphi)_{z_{0}}$ for any $a>0$. If $z_{0} \in \bigcap_{t>T}\{\Psi<-t\}$, then $I_{z_{0}}=\mathcal{O}_{M, z_{0}}$.

Let $Z_{0}$ be a subset of $M$. Let $J_{z_{0}}$ be an $\mathcal{O}_{M, z_{0}}$-submodule of $J(\Psi)_{z_{0}}$ for any $z_{0} \in Z_{0}$. For any $t \geq T$, denote that

$$
A^{2}\left(M_{t}, e^{-\varphi}\right) \cap J:=\left\{f \in A^{2}\left(M_{t}, e^{-\varphi}\right): f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}, \text { for any } z_{0} \in Z_{0}\right\}
$$

Assume that $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$ is a proper subspace of $A^{2}\left(M_{T}, e^{-\varphi}\right)$.
Using Theorem 1.2 we obtain the following concavity property related to $K_{\xi, \Psi, \lambda}^{\varphi}$.
Theorem 1.3. Assume that $I(\Psi+\varphi)_{z_{0}} \subset J_{z_{0}}$ for any $z_{0} \in Z_{0}$, and assume that $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$ such that $\left.\xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0$ and $K_{\xi, \Psi, \lambda}^{\varphi}\left(t_{0}\right) \in(0,+\infty)$ for some $t_{0} \geq T$. Then $-\log K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ is concave and increasing with respect to $t \in[T,+\infty)$.

When $M$ is a pseudoconvex domain in $\mathbb{C}^{n}, Z_{0}$ is one point, and $T=0$, Theorem 1.3 can be referred to [1].
1.2. Applications. Recall that $M$ is an $n$-dimensional Stein manifold. Let $\psi$ be a plurisubharmonic function on $M$. Let $F \not \equiv 0$ be a holomorphic function on $M$, and let $T \in[-\infty,+\infty)$. Let

$$
\Psi=\min \{\psi-2 \log |F|,-T\}
$$

If $F(z)=0$ for some $z \in M$, set $\Psi(z)=-T$. For any $t \geq T$, denote that $M_{t}:=\{\Psi<-t\}$. We give the following lower estimate of weighted $L^{2}$ integrals on sublevel sets $\{\Psi<-t\}$ by Theorem 1.2 and Theorem 1.3 .

Corollary 1.4 (see 31). Let $\varphi$ be a plurisubharmonic function on $M$, and let $f$ be a holomorphic $(n, 0)$ form on $\left\{\Psi<-t_{0}\right\}$ for some $t_{0} \geq T$ such that $f \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)$. Let $z_{0} \in M$, and assume that $a_{z_{0}}^{f}(\Psi ; \varphi)<+\infty$, where

$$
a_{z_{0}}^{f}(\Psi ; \varphi):=\sup \left\{a \geq 0: f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes I(2 a \Psi+\varphi)_{z_{0}}\right\} .
$$

Then for any $r \in\left(0, e^{-a_{z_{0}}^{f}(\Psi ; \varphi) t_{0}}\right]$, we have

$$
\frac{1}{r^{2}} \int_{\left\{a_{z_{0}}^{f}(\Psi ; \varphi) \Psi<\log r\right\}}|f|^{2} e^{-\varphi} \geq e^{2 a_{z_{0}}^{f}(\Psi ; \varphi) t_{0}} C
$$

where

$$
\begin{aligned}
C:= & C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right) \\
:= & \inf \left\{\int_{M_{t_{0}}}|\tilde{f}|^{2} e^{-\varphi}: \tilde{f} \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)\right. \\
& \left.\&(\tilde{f}-f)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}\right\},
\end{aligned}
$$

and

$$
I_{+}(p \Psi+\varphi)_{z_{0}}=\bigcup_{p^{\prime}>p} I\left(p^{\prime} \Psi+\varphi\right)_{z_{0}}
$$

for any $p>0$.
Remark 1.5. In Corollary 1.4, for any $z_{0} \in M$, the proof of $a_{z_{0}}^{f}(\Psi ; \varphi)>0$ can be referred to 31.

Theorem 1.2 and Theorem 1.3 also deduce a reproof of the following effectiveness result of strong openness property of the module $I(a \Psi+\varphi)_{z_{0}}$ on Stein manifolds.

Corollary 1.6 (see [31, 1]). Let $\varphi$ be a plurisubharmonic function on $M$, and let $f$ be a holomorphic ( $n, 0$ ) form on $M_{t_{0}}=\left\{\Psi<-t_{0}\right\}$ for some $t_{0} \geq T$ such that $f \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)$. Let $z_{0} \in M$, and assume that $a_{z_{0}}^{f}(\Psi ; \varphi)<+\infty$. Let $C_{1}$ and $C_{2}$ be two positive constants. If
(1) $\int_{M_{t_{0}}}|f|^{2} e^{-\varphi-\Psi} \leq C_{1}$;
(2) $C\left(\Psi, \varphi, I_{+}\left(2 a_{o}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right) \geq C_{2}$,
then for any $q>1$ satisfying

$$
\theta(q)>\frac{C_{1}}{C_{2}}
$$

we have $f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes I(q \Psi+\varphi)_{z_{0}}$, where $\theta(q)=\frac{q}{q-1} e^{t_{0}}$.

## 2. Preparations

## 2.1. $L^{2}$ methods.

We recall the optimal $L^{2}$ extension theorem.
Let $M$ be an $n$-dimensional Stein manifold. Let $D=\Delta_{w_{0}, r}=\{w \in \mathbb{C}$ : $\left.\left|w-w_{0}\right|<r\right\} \subset \mathbb{C}$, and $w$ be the coordinate of $D$. Let $\Omega=M \times D$ be an $(n+1)$-dimensional complex manifold, and $p$ be the natural projection from $\Omega$ to $D$. Denote that $\Omega_{w}:=p^{-1}(w)$ for any $w \in D$. Let $\varphi$ be a plurisubharmonic function on $\Omega$. The following lemma will be used in the proof of Theorem 1.2

Lemma 2.1 (Optimal $L^{2}$ extension theorem (see 37, 40, 38)). For any $u$ in $A^{2}\left(\Omega_{w_{0}}, e^{-\varphi}\right)$, there exists a holomorphic $(n+1,0)$ form $\tilde{u}$ on $\Omega$, such that $\left.\frac{\tilde{u}}{d w}\right|_{\Omega_{w_{0}}}=$ $u$, and

$$
\frac{1}{\pi r^{2}} \int_{\Omega} \frac{1}{2}|\tilde{u}|^{2} e^{-\varphi} \leq \int_{\Omega_{w_{0}}}|u|^{2} e^{-\varphi}
$$

Let $M$ be an $n$-dimensional weakly pseudoconvex Kähler manifold. Let $F \not \equiv 0$ be a holomorphic function on $M$, and $\psi$ be a plurisubharmonic function on $M$. Let $\varphi_{\alpha}$ be a Lebesgue measurable function on $M$ such that $\varphi_{\alpha}+\psi$ is a plurisubharmonic function on $M$. Let $T$ be a real number. Denote that

$$
\tilde{\varphi}:=\varphi_{\alpha}+2 \max \{\psi+T, 2 \log |F|\}
$$

and

$$
\Psi:=\min \{\psi-2 \log |F|,-T\}
$$

If $F(z)=0$ for some $z \in M$, set $\Psi(z)=-T$. The following lemma will be used to prove Theorem 1.3

Lemma 2.2 (31). Let $t_{0} \in(T,+\infty)$ be arbitrarily given. Let $f$ be a holomorphic $(n, 0)$ form on $\left\{\Psi<-t_{0}\right\}$ such that

$$
\int_{\left\{\Psi<-t_{0}\right\} \cap K}|f|^{2}<+\infty,
$$

for any compact subset $K \subset M$, and

$$
\int_{M} \mathbb{I}_{\left\{-t_{0}-1<\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi_{\alpha}-\Psi}<+\infty
$$

Then there exists a holomorphic $(n, 0)$ form $\tilde{F}$ on $M$ such that

$$
\int_{M}\left|\tilde{F}-\left(1-b_{t_{0}}(\Psi)\right) f F^{2}\right|^{2} e^{-\tilde{\varphi}+v_{t_{0}}(\Psi)-\Psi} \leq C \int_{M} \mathbb{I}_{\left\{-t_{0}-1<\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi_{\alpha}-\Psi},
$$

where $b_{t_{0}}(t)=\int_{-\infty}^{t} \mathbb{I}_{\left\{-t_{0}-1<s<-t_{0}\right\}} \mathrm{d} s, v_{t_{0}}(t)=\int_{-t_{0}}^{t} b_{t_{0}}(s) \mathrm{d} s-t_{0}$ and $C$ is a positive constant.
2.2. Some lemmas about submodules of $J(\Psi)$. Let $F$ be a holomorphic function on a pseudoconvex domain $D \subset \mathbb{C}^{n}$ containing the origin $o \in \mathbb{C}^{n}$. Let $\psi$ be a plurisubharmonic function on $D$. Let $\varphi$ be a plurisubharmonic function on $D$. Let $T$ be a real number. Denote that

$$
\Psi:=\min \{\psi-2 \log |F|,-T\}
$$

If $F(z)=0$ for some $z \in D$, we set $\Psi(z)=-T$.
We recall the following lemma.
Lemma 2.3 (31]). Let $J_{o}$ be an $\mathcal{O}_{\mathbb{C}^{n}, o}-$ submodule of $I(\varphi)_{o}$ such that $I(\Psi+\varphi)_{o} \subset$ $J_{o}$. Assume that $f_{o} \in J(\Psi)_{o}$. Let $U_{0}$ be a Stein open neighborhood of o. Let $\left\{f_{j}\right\}_{j \geq 1}$ be a sequence of holomorphic functions on $U_{0} \cap\left\{\Psi<-t_{j}\right\}$ for any $j \geq 1$, where $t_{j} \in(T,+\infty)$. Assume that $t_{0}=\lim _{j \rightarrow+\infty} t_{j} \in[T,+\infty)$,

$$
\limsup _{j \rightarrow+\infty} \int_{U_{0} \cap\left\{\Psi<-t_{j}\right\}}\left|f_{j}\right|^{2} e^{-\varphi} \leq C<+\infty
$$

and $\left(f_{j}-f\right)_{o} \in J_{o}$. Then there exists a subsequence of $\left\{f_{j}\right\}_{j \geq 1}$ compactly convergent to a holomorphic function $f_{0}$ on $\left\{\Psi<-t_{0}\right\} \cap U_{0}$ which satisfies

$$
\int_{U_{0} \cap\left\{\Psi<-t_{0}\right\}}\left|f_{0}\right|^{2} e^{-\varphi} \leq C
$$

and $\left(f_{0}-f\right)_{o} \in J_{o}$.
Let $M$ be an $n$-dimensional Stein manifold, and let $K_{M}$ be the canonical (holomorphic) line bundle on $M$. Let $F \not \equiv 0$ be a holomorphic function on $M$, and $\psi$ be a plurisubharmonic function on $M$. Let $\varphi$ be a plurisubharmonic function on $D$. Let $T \in[-\infty,+\infty)$. Denote that

$$
\Psi:=\min \{\psi-2 \log |F|,-T\}
$$

If $F(z)=0$ for $z \in M$, set $\Psi(z)=-T$. For any $t \in[T,+\infty)$, denote that

$$
M_{t}:=\{z \in M: \Psi(z)<-t\} .
$$

It is well-known that $A^{2}\left(M_{T}, e^{-\varphi}\right)$ is a Hilbert space, where

$$
A^{2}\left(M_{t}, e^{-\varphi}\right):=\left\{f \in H^{0}\left(M_{t}, \mathcal{O}\left(K_{M}\right)\right): \int_{M_{t}}|f|^{2} e^{-\varphi}<+\infty\right\}
$$

for any $t \geq T$. Let $Z_{0}$ be a subset of $M$. Let $J_{z_{0}}$ be an $\mathcal{O}_{M, z_{0}}$-submodule of $J(\Psi)_{z_{0}}$ for any $z_{0} \in Z_{0}$. For any $t \geq T$, denote that

$$
A^{2}\left(M_{t}, e^{-\varphi}\right) \cap J:=\left\{f \in A^{2}\left(M_{t}, e^{-\varphi}\right): f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}, \text { for any } z_{0} \in Z_{0}\right\}
$$

We state that $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$ is a closed subspace of $A^{2}\left(M_{T}, e^{-\varphi}\right)$ if $J_{z_{0}} \supset I(\Psi+$ $\varphi)_{z_{0}}$ for any $z_{0} \in Z_{0}$.

Lemma 2.4. Assume that $J_{z_{0}} \supset I(\Psi+\varphi)_{z_{0}}$ for any $z_{0} \in Z_{0}$. Then $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$ is closed in $A^{2}\left(M_{T}, e^{-\varphi}\right)$.
Proof. Let $\left\{f_{j}\right\}$ be a sequence of holomorphic $(n, 0)$ forms in $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$, such that $\lim _{j \rightarrow+\infty} f_{j}=f_{0}$ under the topology of $A^{2}\left(M_{T}, e^{-\varphi}\right)$. Then $\left\{f_{j}\right\}$ compactly converges to $f_{0}$ on $M_{T}$. Note that $\left(f_{j}\right)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}$ for any $j$ and $z_{0} \in Z_{0}$. According to Lemma 2.3. we can get that $\left(f_{0}\right)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}$ for any $z_{0} \in Z_{0}$, which means that $f_{0} \in A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$. The we know that $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$ is closed in $A^{2}\left(M_{T}, e^{-\varphi}\right)$.
2.3. Some lemmas about functionals on $A^{2}\left(M_{T}, e^{-\varphi}\right)$.

The following two lemmas will be used in the proof of Theorem 1.2
Lemma 2.5. Let $M$ be an $n$-dimensional complex manifold, and let $\varphi$ be a plurisubharmonic function on $M$. Let $\left\{f_{j}\right\}$ be a sequence in $A^{2}\left(M, e^{-\varphi}\right)$, such that $\int_{M}\left|f_{j}\right|^{2} e^{-\varphi}$ is uniformly bounded for any $j \in \mathbb{N}_{+}$. Assume that $f_{j}$ compactly converges to $f_{0} \in A^{2}\left(M, e^{-\varphi}\right)$. Then for any $\xi \in A^{2}\left(M, e^{-\varphi}\right)^{*}$,

$$
\lim _{j \rightarrow+\infty} \xi \cdot f_{j}=\xi \cdot f_{0}
$$

Proof. For any $f \in A^{2}\left(M, e^{-\varphi}\right)$, denote that $\|f\|^{2}:=\int_{M}|f|^{2} e^{-\varphi}$. Let $\left\{f_{k_{j}}\right\}$ be any subsequence of $\left\{f_{j}\right\}$. Since $A^{2}\left(M, e^{-\varphi}\right)$ is a Hilbert space, and $\left\|f_{k_{j}}\right\|^{2}$ is uniformly bounded, there exists a subsequence of $\left\{f_{k_{j}}\right\}$ (denoted by $\left\{f_{k_{l_{j}}}\right\}$ ) weakly convergent to some $\tilde{f} \in A^{2}\left(M, e^{-\varphi}\right)$.

Let $\left\{U_{l}\right\}$ be an open cover of the complex manifold $M$, and $\left(U_{l}, w_{l}\right)$ be the local coordinate on each $U_{l}$. Then we may denote that $f_{j}=g_{j, l} d w_{l}, f_{0}=g_{0, l} d w_{l}$, and
$\tilde{f}=\tilde{g}_{l} d w_{l}$ on each $U_{l}$, where $f_{j, l}, g_{0, l}$ and $\tilde{g}_{l}$ are holomorphic functions on $U_{l}$. For any $z \in M$, denote that $S_{z}:=\left\{l: z \in U_{l}\right\}$. And for any $l \in S_{z}$, let $e_{z, l}$ be the functional defined as follows:

e_{z, l}: A^{2}\left(M, e^{-\varphi}\right) & \longrightarrow \mathbb{C} \\
f & \longmapsto g_{l}(z),
\end{aligned}
$$

where $f=g_{l} d w_{l}$ on $U_{l}$, and $g_{l}$ is a holomorphic function on $U_{l}$. It is clear that the functional $e_{z, l} \in A^{2}\left(D, e^{-\varphi_{0}}\right)^{*}$ for any $z \in M$ and any $l \in S_{z}$. Then we have

$$
f_{0, l}(z)=\lim _{j \rightarrow+\infty} e_{z, l} \cdot f_{j}=\lim _{j \rightarrow+\infty} e_{z, l} \cdot f_{k_{l_{j}}}=e_{z, l} \cdot \tilde{f}=\tilde{f}_{l}(z), \forall z \in M, l \in S_{z}
$$

thus $f_{0}=\tilde{f}$. It means that $\left\{f_{k_{j}}\right\}$ has a subsequence weakly convergent to $f_{0}$. Since $\left\{f_{k_{j}}\right\}$ is an arbitrary subsequence of $\left\{f_{j}\right\}$, we get that $\left\{f_{j}\right\}$ weakly converges to $f_{0}$. In other words, for any $\xi \in A^{2}\left(M, e^{-\varphi}\right)^{*}$,

\lim _{j \rightarrow+\infty} \xi \cdot f_{j}=\xi \cdot f_{0}
$$

Let $\Omega:=M \times \omega$, where $M$ is an $n$-dimensional complex manifold, and $\omega$ is a domain in $\mathbb{C}$. Let $\varphi_{0}$ be a plurisubharmonic function on $M$, and $\varphi:=\pi_{1}^{*}\left(\varphi_{0}\right)$, where $\pi_{1}$ is the natural projection from $\Omega$ to $M$. Let $f$ be a holomorphic ( $n+1,0$ ) form on $\Omega$, such that

$$
\int_{\Omega}|f|^{2} e^{-\varphi}<+\infty
$$

For any $\tau \in \omega$, denote that

$$
f_{\tau}:=\left.\frac{f}{d \tau}\right|_{M_{\tau}}
$$

is a holomorphic $(n, 0)$ form on $M_{\tau}$, where $M_{\tau}:=\pi_{2}^{-1}(\tau)$, and $\pi_{2}$ is the natural projection from $\Omega$ to $\omega$.
Lemma 2.6. For any $\xi \in A^{2}\left(M, e^{-\varphi_{0}}\right)^{*}, \xi \cdot f_{\tau}$ is holomorphic with respect to $\tau \in \omega$.
Proof. We only need to prove that $h(\tau):=\xi \cdot f_{\tau}$ is holomorphic near any $\tau_{0} \in \omega$. Since $\tau_{0} \in \omega$, there exists $r>0$ such that $\Delta\left(\tau_{0}, 2 r\right) \subset \subset \omega$. Then for any $\tau \in$ $\Delta\left(\tau_{0}, r\right)$, according to the sub-mean value inequality of subharmonic functions, we have

\int_{M}\left|f_{\tau}\right|^{2} e^{-\varphi_{0}} \leq \frac{1}{\pi r^{2}} \int_{M \times \Delta(\tau, r)} \frac{1}{2}|f|^{2} e^{-\varphi} \leq \frac{1}{\pi r^{2}} \int_{\Omega} \frac{1}{2}|f|^{2} e^{-\varphi}<+\infty
$$

which implies that $f_{\tau} \in A^{2}\left(M, e^{-\varphi_{0}}\right)$ and there exists $C>0$ such that $\int_{M}\left|f_{\tau}\right|^{2} e^{-\varphi_{0}} \leq$ $C$ for any $\tau \in \Delta\left(\tau_{0}, r\right)$.

Let $\left\{U_{l}\right\}$ be an open cover of the complex manifold $M$, and $\left(U_{l}, w_{l}\right)$ be the local coordinate on each $U_{l}$. For any $z \in M$, Denote that $S_{z}:=\left\{l: z \in U_{l}\right\}$. And for any $l \in S_{z}$, let $e_{z, l}$ be the functional in the proof of Lemma 2.5. In the Hilbert space $A^{2}\left(M, e^{-\varphi_{0}}\right)$, by Riesz representation theorem, there exists $\phi_{z, l} \in A^{2}\left(M, e^{-\varphi_{0}}\right)$ such that

$$
e_{z, l} \cdot g=\sqrt{-1}^{n^{2}} \int_{M} g \wedge \overline{\phi_{z, l}} e^{-\varphi_{0}}
$$

for any $z \in M, l \in S_{z}$. Denote that

$$
H:=\overline{\operatorname{span}\left\{\phi_{z, l}: z \in M, l \in S_{z}\right\}}
$$

is a closed subspace of $A^{2}\left(M, e^{-\varphi_{0}}\right)$. If $H \neq A^{2}\left(M, e^{-\varphi_{0}}\right)$, then the closed subspace $H^{\perp} \neq\{0\}$. Choosing some $g_{0} \in H^{\perp}$ with $g_{0} \neq 0$, we have that for any $z \in M$ and $l \in S_{z}, e_{z, l} \cdot g_{0}=0$ holds. Then it is clear that $g_{0}=0$, which is a contradiction. Thus $H=A^{2}\left(M, e^{-\varphi_{0}}\right)$. Denote that

$$
L:=\operatorname{span}\left\{e_{z, l}: z \in M, l \in S_{z}\right\} \subset A^{2}\left(M, e^{-\varphi_{0}}\right)^{*}
$$

Since $H=A^{2}\left(M, e^{-\varphi_{0}}\right)$, we can find a sequence $\left\{\xi_{k}\right\} \subset L \subset A^{2}\left(M, e^{-\varphi_{0}}\right)^{*}$, such that

$$
\lim _{k \rightarrow+\infty}\left\|\xi_{k}-\xi\right\|_{A^{2}\left(M, e^{-\varphi_{0}}\right)^{*}}=0
$$

It is clear that for any $z \in M$ and $l \in S_{z}, e_{z, l} \cdot f_{\tau}$ is holomorphic with respect to $\tau \in \omega$. Then for any $k, h_{k}(\tau):=\xi_{k} \cdot f_{\tau}$ is holomorphic with respect to $\tau \in \omega$. Besides, for any $\tau \in \Delta\left(\tau_{0}, r\right)$, we have

$$
\begin{aligned}
& \left|h_{k}(\tau)-h(\tau)\right|^{2} \\
= & \left|\left(\xi_{k}-\xi\right) \cdot f_{\tau}\right|^{2} \\
\leq & \left\|\xi_{k}-\xi\right\|_{A^{2}\left(M, e^{\left.-\varphi_{0}\right)^{*}}\right.}^{2} \int_{M}\left|f_{\tau}\right|^{2} e^{-\varphi_{0}} \\
\leq & C\left\|\xi_{k}-\xi\right\|_{A^{2}\left(M, e^{\left.-\varphi_{0}\right)^{*}}\right.}^{2}
\end{aligned}
$$

which means that $h_{k}$ uniformly converges to $h$ on $\Delta\left(\tau_{0}, r\right)$. According to Weierstrass theorem, we know that $h$ is holomorphic on $\Delta\left(\tau_{0}, r\right)$, i.e. near $\tau_{0}$. Then we get that $\xi \cdot f_{\tau}$ is holomorphic with respect to $\tau \in \omega$.

### 2.4. Some properties of $K_{\xi, \Psi, \lambda}^{\varphi}(t)$.

In this section, prove some properties of the Bergman kernel $K_{\xi, \Psi, \lambda}^{\varphi}(t)$.
Let $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\}$. We need the following lemma.
Lemma 2.7. For any $t \in[T,+\infty)$, if $K_{\xi, \Psi, \lambda}^{\varphi}(t) \in(0,+\infty)$, then there exists $\tilde{f} \in$ $A^{2}\left(M_{T}, e^{-\varphi}\right)$, such that

$$
K_{\xi, \Psi, \lambda}^{\varphi}(t)=\frac{|\xi \cdot \tilde{f}|^{2}}{\|\tilde{f}\|_{\lambda, t}^{2}}
$$

Proof. By the definition of $K_{\xi, \Psi, \lambda}^{\varphi}(t)$, there exists a sequence $\left\{f_{j}\right\}$ of holomorphic $(n, 0)$ forms in $A^{2}\left(M_{T}, e^{-\varphi}\right)$, such that $\left\|f_{j}\right\|_{\lambda, t}=1$, and $\lim _{j \rightarrow+\infty}\left|\xi \cdot f_{j}\right|^{2}=$ $K_{\xi, \Psi, \lambda}^{\varphi}(t)$. Then $\int_{M_{T}}\left|f_{j}\right|^{2} e^{-\varphi}$ is uniformly bounded. Following from Montel's theorem, we can get a subsequence of $\left\{f_{j}\right\}$ compactly convergent to a holomorphic $(n, 0)$ form $\tilde{f}$ on $M_{T}$. According to Fatou's lemma, we have $\|\tilde{f}\|_{\lambda, t} \leq 1$, and according to Lemma 2.5, we have $|\xi \cdot \tilde{f}|^{2}=K_{\xi, \Psi, \lambda}^{\varphi}(t)$, thus $K_{\xi, \Psi, \lambda}^{\varphi}(t) \leq \frac{|\xi \cdot \tilde{f}|^{2}}{\|\tilde{\|}\|_{\lambda, t}^{2}}$. Note that $\|\tilde{f}\|_{\lambda, t} \leq 1$ implies $\tilde{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right)$, which means $K_{\xi, \Psi, \lambda}^{\varphi}(t) \geq \frac{|\xi \cdot \tilde{f}|^{2}}{\|\tilde{f}\|_{\lambda, t}^{2}}$. Then we get that $K_{\xi, \Psi, \lambda}^{\varphi}(t)=\frac{|\xi \cdot \tilde{f}|^{2}}{\| \tilde{\|_{\lambda}^{2}, t}}$.

Recall that $Z_{0}$ is a subset of $M$, and $J_{z_{0}}$ is an $\mathcal{O}_{M, z_{0}}$-submodule of $J(\Psi)_{z_{0}}$ such that $I(\Psi+\varphi)_{z_{0}} \subset J_{z_{0}}$ for any $z_{0} \in Z_{0}$. For any $t \geq T$, recall that

$$
A^{2}\left(M_{t}, e^{-\varphi}\right) \cap J:=\left\{f \in A^{2}\left(M_{t}, e^{-\varphi}\right): f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}, \text { for any } z_{0} \in Z_{0}\right\}
$$

Following from Lemma 2.4, we know that $\left[A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J\right.$ is a closed subspace of $\left[A^{2}\left(M_{t}, e^{-\varphi}\right)\right.$. Let $f \in A^{2}\left(M_{T}, e^{-\varphi}\right)$, such that $f \notin A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$. Recall the minimal $L^{2}$ integral (4, 31]) related to $J$ as follows:

C\left(\Psi, \varphi, J, f, M_{T}\right):=\inf \left\{\int_{M_{T}}|\tilde{f}|^{2} e^{-\varphi}:(\tilde{f}-f)_{z_{0}} \in\left(\mathcal{O}\left(K_{M}\right)\right)_{z_{0}} \otimes J_{z_{0}} \text { for any } z_{0} \in Z_{0}\right. \\
\left.\& \tilde{f} \in H^{0}\left(M_{T}, \mathcal{O}\left(K_{M}\right)\right)\right\}
\end{array}
$$

Then the following lemma holds.
Lemma 2.8. Assume that $C\left(\Psi, \varphi, J, f, M_{T}\right) \in(0,+\infty)$, then

$$
\begin{equation*}
C\left(\Psi, \varphi, J, f, M_{T}\right)=\sup _{\substack{\left.\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\} \\ \xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, \Psi, \lambda}^{\varphi}(T)} . \tag{2.1}
\end{equation*}
$$

Proof. Denote that $(\tilde{f}-f) \in J$ if $(\tilde{f}-f)_{z_{0}} \in\left(\mathcal{O}\left(K_{M}\right)\right)_{z_{0}} \otimes J_{z_{0}}$ for any $z_{0} \in Z_{0}$. Note that $\xi \cdot \tilde{f}=\xi \cdot f$ for any $\tilde{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right)$ with $(\tilde{f}-f) \in J$, and $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$ satisfying $\left.\xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0$. Then we have

$$
\begin{aligned}
K_{\xi, \Psi, \lambda}^{\varphi}(T) & =\sup _{h \in A^{2}\left(M_{T}, e^{-\varphi}\right)} \frac{|\xi \cdot h|^{2}}{\int_{M_{T}}|h|^{2} e^{-\varphi}} \\
& \geq \sup _{\substack{\tilde{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right) \\
(\tilde{f}-f) \in J}} \frac{|\xi \cdot \tilde{f}|^{2}}{\int_{M_{T}}|\tilde{f}|^{2} e^{-\varphi}} \\
& =\sup _{\substack{\tilde{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right) \\
(\tilde{f}-f) \in J}} \frac{|\xi \cdot f|^{2}}{\int_{M_{T}}|\tilde{f}|^{2} e^{-\varphi}} .
\end{aligned}
$$

Thus we get that

\begin{aligned}
& \sup _{\substack{\left.\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\} \\
\xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, \Psi, \lambda}^{\varphi}(T)} \\
& \leq \inf _{\substack{\tilde{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right)}}^{\substack{(\tilde{f}-f) \in J}} \mid \\
& =C\left(\Psi, \varphi, J, f, M_{T}\right) .
\end{aligned}
$$

Since $A^{2}\left(M_{T}, e^{-\varphi}\right)$ is a Hilbert space, and $A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$ is a closed proper subspace of $A^{2}\left(M_{T}, e^{-\varphi}\right)$, there exists a closed subspace $H$ of $A^{2}\left(M_{T}, e^{-\varphi}\right)$ such that $H=\left(A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J\right)^{\perp} \neq\{0\}$. Then for $f \in A^{2}\left(M_{T}, e^{-\varphi}\right)$, we can make the decomposition $f=f_{J}+f_{H}$, such that $f_{J} \in A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J$, and $f_{H} \in H$. Note that the linear functional $\xi_{f}$ defined as follows:

\xi_{f} \cdot g:=\sqrt{-1}^{n^{2}} \int_{M_{T}} g \wedge \overline{f_{H}} e^{-\varphi}, \forall g \in A^{2}\left(M_{T}, e^{-\varphi}\right)
$$

satisfies that $\xi_{f} \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\}$ and $\left.\xi_{f}\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0$. Then we have

$$
\sup _{\substack{\left.\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\} \\ \xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, \Psi, \lambda}^{\varphi}(T)} \geq \frac{\left|\xi_{f} \cdot f\right|^{2}}{K_{\xi_{f}, \Psi, \lambda}^{\varphi}(T)}
$$

Besides, we can know that

K_{\xi_{f}, \Psi, \lambda}^{\varphi}(T)=\sup _{h \in A^{2}\left(M_{T}, e^{-\varphi}\right)} \frac{\left|\sqrt{-1}^{n^{2}} \int_{M_{T}} h \wedge \overline{f_{H}} e^{-\varphi}\right|^{2}}{\int_{M_{T}}|h|^{2} e^{-\varphi}} \leq \int_{M_{T}}\left|f_{H}\right|^{2} e^{-\varphi}
$$

and

$$
\xi_{f} \cdot f=\xi_{f} \cdot\left(f_{J}+f_{H}\right)=\xi_{f} \cdot f_{H}=\int_{M_{T}}\left|f_{H}\right|^{2} e^{-\varphi}
$$

Then we have

$$
\frac{\left|\xi_{f} \cdot f\right|^{2}}{K_{\xi_{f}, \Psi, \lambda}^{\varphi}(T)} \geq \int_{M_{T}}\left|f_{H}\right|^{2} e^{-\varphi} \geq C\left(\Psi, \varphi, J, f, M_{T}\right)
$$

which implies that

\sup _{\substack{\left.\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*} \backslash\{0\} \\ \xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, \Psi, \lambda}^{\varphi}(T)} \geq C\left(\Psi, \varphi, J, f, M_{T}\right) .
$$

Lemma 2.8 is proved.
Let $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$, and recall that the Bergman kernel related to $\xi$ is

K_{\xi, \Psi, \lambda}^{\varphi}(t):=\sup _{f \in A^{2}\left(M_{T}, e^{-\varphi}\right)} \frac{|\xi \cdot f|^{2}}{\|f\|_{\lambda, t}^{2}}
$$

for any $t \in[T,+\infty)$ and $\lambda>0$. We state the following Lemma.
Lemma 2.9. $K_{\xi, \Psi, \lambda}^{\varphi}(t)$ is upper-semicontinuous with respect to $t \in[T,+\infty)$, i.e., for any sequence $\left\{t_{j}\right\}_{j=1}^{\infty}$ in $[T,+\infty)$ such that $\lim _{j \rightarrow+\infty} t_{j}=t_{0} \in[T,+\infty)$, we have

$$
\limsup _{j \rightarrow+\infty} K_{\xi, \Psi, \lambda}^{\varphi}\left(t_{j}\right) \leq K_{\xi, \Psi, \lambda}^{\varphi}\left(t_{0}\right)
$$

Proof. Denote that

$$
K(t):=K_{\xi, \Psi, \lambda}^{\varphi}(t)
$$

for any $t \in[T,+\infty)$. It can be seen that

$$
e^{\lambda(s-t)}\|f\|_{\lambda, s}^{2} \leq\|f\|_{\lambda, t}^{2} \leq\|f\|_{\lambda, s}^{2}
$$

for any $t>s \geq T$ and $f \in A^{2}\left(M_{T}, e^{-\varphi}\right)$. Note that $K(s)=0$ for some $s \geq T$ induces $K(t)=0$ for any $t \geq T$. Then it suffices to prove Lemma 2.9 for $K\left(t_{0}\right) \in$ $(0,+\infty)$ and $K\left(t_{j}\right) \in(0,+\infty), \forall j \in \mathbb{N}_{+}$.

We assume that $\left\{t_{k_{j}}\right\}$ is the subsequence of $\left\{t_{j}\right\}$ such that

$$
\lim _{j \rightarrow+\infty} K\left(t_{k_{j}}\right)=\limsup _{j \rightarrow+\infty} K\left(t_{j}\right)
$$

By Lemma 2.7. there exists a sequence of holomorphic $(n, 0)$ forms $\left\{f_{j}\right\}$ on $M_{T}$ such that $f_{j} \in A^{2}\left(M_{T}, e^{-\varphi}\right),\left\|f_{j}\right\|_{\lambda, t_{j}}=1$, and $\left|\xi \cdot f_{j}\right|^{2}=K\left(t_{j}\right)$, for any $j \in \mathbb{N}_{+}$.

Since $\left\{t_{j}\right\}$ is bounded in $\mathbb{C}$, there exists some $s_{0}>T$, such that $t_{j}<s_{0}$ for any $j$, which implies that

$$
\int_{M_{T}}\left|f_{j}\right|^{2} e^{-\varphi} \leq e^{\lambda\left(s_{0}-T\right)}\left\|f_{j}\right\|_{\lambda, t_{j}}^{2}=e^{\lambda\left(s_{0}-T\right)}, \forall j \in \mathbb{N}_{+}
$$

Then following from Montel's theorem, we can get a subsequence of $\left\{f_{k_{j}}\right\}$ (denoted by $\left\{f_{k_{j}}\right\}$ itself) compactly convergent to a holomorphic ( $n, 0$ ) form $f_{0}$ on $M_{T}$. According to Fatou's lemma, we have

\begin{aligned}
\left\|f_{0}\right\|_{\lambda, t_{0}} & =\int_{M_{T}}\left|f_{0}\right|^{2} e^{-\varphi-\lambda \max \left\{\Psi+t_{0}, 0\right\}} \\
& =\int_{M_{T}} \lim _{j \rightarrow+\infty}\left|f_{k_{j}}\right|^{2} e^{-\varphi-\lambda \max \left\{\Psi+t_{k_{j}}, 0\right\}} \\
& \leq \liminf _{j \rightarrow+\infty} \int_{M_{T}}\left|f_{k_{j}}\right|^{2} e^{-\varphi-\lambda \max \left\{\Psi+t_{k_{j}}, 0\right\}} \\
& =\liminf _{j \rightarrow+\infty}\left\|f_{k_{j}}\right\|_{\lambda, t_{j}}=1 .
\end{aligned}
$$

Then $\int_{M_{T}}\left|f_{0}\right|^{2} e^{-\varphi} \leq e^{\lambda\left(t_{0}-T\right)}\left\|f_{0}\right\|_{\lambda, t_{0}}^{2} \leq e^{\lambda\left(s_{0}-T\right)}<+\infty$, which implies that $f_{0} \in$ $A^{2}\left(M_{T}, e^{-\varphi}\right)$. Lemman2.5shows that $\left|\xi \cdot f_{0}\right|^{2}=\lim _{j \rightarrow+\infty}\left|\xi \cdot f_{k_{j}}\right|^{2}=\lim \sup _{j \rightarrow+\infty} K\left(t_{j}\right)$. Thus

K\left(t_{0}\right) \geq \frac{\left|\xi \cdot f_{0}\right|^{2}}{\left\|f_{0}\right\|_{\lambda, t_{0}}^{2}} \geq \limsup _{j \rightarrow+\infty} K\left(t_{j}\right)
$$

which means that $K(t)$ is upper semi-continuous with respect to $t \in[T,+\infty)$.

## 3. Proof of Theorem 1.2

We prove Theorem 1.2 by using Lemma 2.1 (optimal $L^{2}$ extension theorem).
Proof of Theorem 1.2. Denote that $\Omega:=M_{T} \times E_{T}$. Note that $M_{T}$ is an $n$-dimensional Stein manifold, and $\Psi$ is a plurisubharmonic function on $M_{T}$. We get that $\Omega$ is an $(n+1)$-dimensional Stein manifold. Denote that $\pi_{1}, \pi_{2}$ are the natural projections from $\Omega$ to $M_{T}$ and $E_{T}$. Let

\tilde{\Psi}:=\varphi(z)+\lambda \max \{\Psi(z)+\operatorname{Re} w, 0\}
$$

for any $(z, w) \in \Omega$ with $z \in M_{T}$ and $w \in E_{T}$. Then $\tilde{\Psi}$ is a plurisubharmonic function on $\Omega$.

Denote that

K(w):=K_{\xi, \Psi, \lambda}^{\varphi}(\operatorname{Re} w)
$$

for any $w \in E_{T}$. We prove that $\log K(w)$ is a subharmonic function with respect to $w \in E_{T}$.

Firstly we prove that $\log K(w)$ is upper semicontinuous. Let $w_{j} \in E$ such that $\lim _{\lambda \rightarrow+\infty} w_{j}=w_{0} \in E_{T}$. Then $\lim _{j \rightarrow+\infty} \operatorname{Re} w_{j}=\operatorname{Re} w_{0} \in[T,+\infty)$. Following from Lemma 2.9, we get that

$$
\limsup _{j \rightarrow+\infty} \log K\left(w_{j}\right) \leq \log K\left(w_{0}\right)
$$

Thus $\log K(w)$ is upper semincontinuous with respect to $w \in E_{T}$.
Secondly we prove that $\log K(w)$ satifies the sub-mean value inequality on $E_{T}$.

Let $w_{0} \in E_{T}$, and $\Delta\left(w_{0}, r\right) \subset E_{T}$ be the disc centered at $w_{0}$ with radius $r$. Let $\Omega^{\prime}:=M_{T} \times \Delta\left(w_{0}, r\right) \subset \Omega$ be a submanifold of $\Omega$. Let $f_{0} \in A^{2}\left(M_{T}, e^{-\varphi}\right)$ such that

K\left(w_{0}\right)=\frac{\left|\xi \cdot f_{0}\right|^{2}}{\left\|f_{0}\right\|_{\lambda, \operatorname{Re} w_{0}}^{2}}
$$

by Lemma 2.7
Note that $\Omega^{\prime}$ is a Stein manifold, and $\tilde{\Psi}(z, w)=\varphi(z)+\Psi_{\lambda, \operatorname{Re} w}=\varphi(z)+$ $\lambda \max \{\Psi(z)+\operatorname{Re} w, 0\}$ is a plurisubharmonic function on $\Omega^{\prime}$. Using Lemma 2.1 (optimal $L^{2}$ extension theorem), we can get a holomorphic $(n, 0)$ form $\tilde{f}$ on $\Omega^{\prime}$ such that $g\left(z, w_{0}\right)=g_{0}(z)$ for any $z \in M_{T}$, where $\tilde{f}=g(z, w) d z \wedge d w$ and $f_{0}=g(z) d z$ on $(z, w)$, and

\begin{equation*}
\frac{1}{\pi r^{2}} \int_{\Omega^{\prime}} \frac{1}{2}|\tilde{f}|^{2} e^{-\tilde{\Psi}} \leq \int_{M_{T}}\left|f_{0}\right|^{2} e^{-\Psi_{\lambda, \operatorname{Re}} w_{0}} \tag{3.1}
\end{equation*}
$$

Denote that $\tilde{f}_{w}=\left.\frac{\tilde{f}}{d w}\right|_{M_{T} \times\{w\}}$. Since the function $y=\log x$ is concave, according to Jensen's inequality and inequality (3.1), we have

\log \left\|f_{0}\right\|_{\lambda, \operatorname{Re} w_{0}}^{2} & =\log \left(\int_{M_{T}}\left|f_{0}\right|^{2} e^{-\Psi_{\lambda, \operatorname{Re} w_{0}}}\right) \\
& \geq \log \left(\frac{1}{\pi r^{2}} \int_{\Omega^{\prime}} \frac{1}{2}|\tilde{f}|^{2} e^{-\tilde{\Psi}}\right) \\
& =\log \left(\frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)}\left(\int_{M_{T} \times\{w\}}\left|\tilde{f}_{w}\right|^{2} e^{-\Psi_{\lambda, \operatorname{Re} w}}\right) d \mu_{\Delta_{w_{0}, r}}(w)\right) \\
& \geq \frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)} \log \left(\left\|\tilde{f}_{w}\right\|_{\lambda, \operatorname{Re} w}^{2}\right) d \mu_{\Delta_{w_{0}, r}}(w) \\
& \geq \frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)}\left(\log \left|\xi \cdot \tilde{f}_{w}\right|^{2}-\log K(w) \mid\right) d \mu_{\Delta_{w_{0}, r}}(w) \tag{3.2}
\end{align*}
$$

Where $\mu_{\Delta_{w_{0}, r}}$ is the Lebesgue measure on $\Delta_{w_{0}, r}$. It follows from Lemma 2.6 that $\xi \cdot \tilde{f}_{w}$ is holomorphic with respect to $w$, which implies that $\log \left|\xi \cdot \tilde{f}_{w}\right|^{2}$ is subharmonic with respect to $w$. Then we have

\log \left|\xi \cdot f_{0}\right|^{2} \leq \frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)} \log \left|\xi \cdot \tilde{f}_{w}\right|^{2} d \mu_{\Delta_{w_{0}, r}}(w)
$$

Combining with inequality (3.2), we get

\log \left\|f_{0}\right\|_{\lambda, \operatorname{Re} w_{0}}^{2} \geq \log \left|\xi \cdot f_{0}\right|^{2}-\frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)} \log K(w) d \mu_{\Delta_{w_{0}, r}}(w)
$$

which means

\log K\left(w_{0}\right) \leq \frac{1}{\pi r^{2}} \int_{\Delta\left(w_{0}, r\right)} \log K(w) d \mu_{\Delta_{w_{0}, r}}(w)
$$

Since $\log K(w)$ is upper semicontinuous and satisfies the sub-mean value inequality on $E_{T}$, we know that $\log K(w)$ is a subharmonic function on $E_{T}$.

## 4. Proof of Theorem 1.3

In this section, we give the proof of Theorem 1.3. We need the following lemma.
Lemma 4.1 (see [12]). Let $D=I+\sqrt{-1} \mathbb{R}:=\{z=x+\sqrt{-1} y \in \mathbb{C}: x \in I, y \in \mathbb{R}\}$ be a subset of $\mathbb{C}$, where $I$ is an interval in $\mathbb{R}$. Let $\phi(z)$ be a subharmonic function on $D$ which is only dependent on $x=$ Re $z$. Then $\phi(x):=\phi(x+\sqrt{-1} \mathbb{R})$ is a convex function with respect to $x \in I$.

Proof of Theorem 1.3. It follows from Theorem 1.2 that $\log K_{\xi, \Psi, \lambda}^{\varphi}(\operatorname{Re} w)$ is subharmonic with respect to $w \in(T,+\infty)+\sqrt{-1} \mathbb{R}$. Note that $\log K_{\xi, \Psi, \lambda}^{\varphi}(\operatorname{Re} w)$ is only dependent on $\operatorname{Re} w$, then following from Lemma 4.1 we get that $\log K_{\xi, \Psi, \lambda}^{\varphi}(t)=$ $\log K_{\xi, \Psi, \lambda}^{\varphi}(t+\sqrt{-1} \mathbb{R})$ is convex with respect to $t \in(T,+\infty)$. Combining with Lemma 2.9, we get that $\log K_{\xi, \Psi, \lambda}^{\varphi}(t)$ is convex with respect to $t \in[T,+\infty)$, which implies that $-\log K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ is concave with respect to $t \in[T,+\infty)$. Then for any $\xi \in A^{2}\left(M_{T}, e^{-\varphi}\right)^{*}$ with $\left.\xi\right|_{A^{2}\left(M_{T}, e^{-\varphi}\right) \cap J} \equiv 0$, to prove that $\log -K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ is increasing, we only need to prove that $\log -K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ has a lower bound on $[T,+\infty)$.

Using Lemma 2.7 we obtain that there exists $f_{t} \in A^{2}\left(M_{T}, e^{-\varphi}\right)$ for any $t \in$ $[T,+\infty)$, such that $\xi \cdot f_{t}=1$ and

$$
\begin{equation*}
K_{\xi, \Psi, \lambda}^{\varphi}(t)=\frac{1}{\left\|f_{t}\right\|_{\lambda, t}^{2}} \tag{4.1}
\end{equation*}
$$

In addition, according to Lemma 2.2, there exists a holomorphic $(n, 0)$ form $\tilde{F}$ on $M_{T}$ such that

$$
\begin{equation*}
\int_{M_{T}}\left|\tilde{F}-\left(1-b_{t}(\Psi)\right) f_{t} F^{2}\right|^{2} e^{-\tilde{\varphi}+v_{t}(\Psi)-\Psi} \leq C \int_{M_{T}} \mathbb{I}_{\{-t-1<\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\tilde{\varphi}-\Psi} \tag{4.2}
\end{equation*}
$$

where

$$
\tilde{\varphi}=\varphi+2 \max \{\psi+T, 2 \log |F|\}
$$

and $C$ is a positive constant. Then it follows from inequality (4.2) that

\begin{align*}
& \int_{M_{T}}\left|\tilde{F}-\left(1-b_{t}(\Psi)\right) f_{t} F^{2}\right|^{2} e^{-\tilde{\varphi}+v_{t}(\Psi)-\Psi} \\
\leq & C \int_{M_{T}} \mathbb{I}_{\{-t-1<\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi-\Psi}  \tag{4.3}\\
\leq & C e^{t+1} \int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi}
\end{align*}
$$

Denote that $\tilde{F}_{t}:=\tilde{F} / F^{2}$ on $M_{T}$, then $\tilde{F}_{t}$ is a holomorphic $(n, 0)$ form on $M_{T}$. Note that $|F|^{4} e^{-\tilde{\varphi}}=e^{-\varphi}$ on $M_{T}$. Then inequality (4.3) implies that

$$
\begin{equation*}
\int_{M_{T}}\left|\tilde{F}_{t}-\left(1-b_{t}(\Psi)\right) f_{t}\right|^{2} e^{-\varphi+v_{t}(\Psi)-\Psi} \leq C e^{t+1} \int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi}<+\infty \tag{4.4}
\end{equation*}
$$

According to inequality (4.4), we can get that $\left(\tilde{F}_{t}-f_{t}\right)_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes I(\Psi+\varphi)_{z_{0}} \subset$ $\mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes J_{z_{0}}$, which means that $\xi \cdot \tilde{F}_{t}=\xi \cdot f_{t}=1$. Besides, since $v_{t}(\Psi) \geq \Psi$, we
have

\begin{aligned}
& \left(\int_{M_{T}}\left|\tilde{F}_{t}-\left(1-b_{t}(\Psi)\right) f_{t}\right|^{2} e^{-\varphi+v_{t}(\Psi)-\Psi}\right)^{1 / 2} \\
\geq & \left(\int_{M_{T}}\left|\tilde{F}_{t}-\left(1-b_{t}(\Psi)\right) f_{t}\right|^{2} e^{-\varphi}\right)^{1 / 2} \\
\geq & \left(\int_{M_{T}}\left|\tilde{F}_{t}\right|^{2} e^{-\varphi}\right)^{1 / 2}-\left(\int_{M_{T}}\left|\left(1-b_{t}(\Psi)\right) f_{t}\right|^{2} e^{-\varphi}\right)^{1 / 2} \\
\geq & \left(\int_{M_{T}}\left|\tilde{F}_{t}\right|^{2} e^{-\varphi}\right)^{1 / 2}-\left(\int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi}\right)^{1 / 2}
\end{aligned}
$$

Combining with inequality (4.4), we have

\begin{aligned}
& \int_{M_{T}}\left|\tilde{F}_{t}\right|^{2} e^{-\varphi} \\
\leq & 2 \int_{M_{T}}\left|\tilde{F}_{t}-\left(1-b_{t}(\Psi)\right) f_{t}\right|^{2} e^{-\varphi+v_{t}(\Psi)-\Psi}+2 \int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi} \\
\leq & 2\left(C e^{t+1}+1\right) \int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi} .
\end{aligned}
$$

Note that

$$
\begin{aligned}
\left\|f_{t}\right\|_{\lambda, t}^{2} & =\int_{M_{T}}\left|f_{t}\right|^{2} e^{-\varphi-\Psi_{\lambda, t}} \\
& =\int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi}+\int_{\{T>\Psi \geq-t\}}\left|f_{t}\right|^{2} e^{-\varphi-\lambda(\Psi+t)} \\
& \geq \int_{\{\Psi<-t\}}\left|f_{t}\right|^{2} e^{-\varphi}
\end{aligned}
$$

Then we have

\int_{M_{T}}\left|\tilde{F}_{t}\right|^{2} e^{-\varphi} \leq 2\left(C e^{t+1}+1\right)\left\|f_{t}\right\|_{\lambda, t}^{2} \leq C_{1} \frac{e^{t}}{K_{\xi, \Psi, \lambda}^{\varphi}(t)},
$$

where $C_{1}$ is a positive constant independent on $t$. In addition, $\xi \cdot \tilde{F}_{t}=1$ implies that

\int_{M_{T}}\left|\tilde{F}_{t}\right|^{2} e^{-\varphi}=\left\|\tilde{F}_{t}\right\|_{\lambda, T}^{2} \geq\left(K_{\xi, \Psi, \lambda}^{\varphi}(T)\right)^{-1}
$$

Then we get that

-\log K_{\xi, \Psi, \lambda}^{\varphi}(t)+t \geq C_{2}, \forall t \in[T,+\infty)
$$

where $C_{2}:=\log \left(C_{1}^{-1} K_{\xi, \Psi, \lambda}^{\varphi}(T)\right)$ is a finite constant. Since $-\log K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ is concave, we get that $-\log K_{\xi, \Psi, \lambda}^{\varphi}(t)+t$ is increasing with respect to $t \in[T,+\infty)$.

## 5. Proofs of Corollary 1.4 and Corollary 1.6

In this section, we give the proofs of Corollary 1.4 and Corollary 1.6. Before the proofs, we do some preparations.

Let $\varphi$ be a plurisubharmonic function on $M$, and let $f$ be a holomorphic $(n, 0)$ form on $M_{t_{0}}=\left\{\Psi<-t_{0}\right\}$ for some $t_{0} \geq T$ such that $f \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)$. Let
$z_{0} \in M$, and assume that $a_{z_{0}}^{f}(\Psi ; \varphi)<+\infty$. According to Remark 1.5, we know that $a_{z_{0}}^{f}(\Psi ; \varphi) \in(0,+\infty)$.

Let $p>2 a_{z_{0}}^{f}(\Psi ; \varphi)$ and $\lambda>0$. Let $\xi \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)^{*} \backslash\{0\}$ satisfying $\left.\xi\right|_{A^{2}\left(M_{t_{0}}, e^{-\varphi}\right) \cap J_{p}} \equiv$ 0 , where $J_{p}:=I(p \Psi+\varphi)_{z_{0}}$. Denote that

$$
K_{\xi, p, \lambda}(t):=\sup _{\tilde{f} \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)} \frac{|\xi \cdot \tilde{f}|^{2}}{\|\tilde{f}\|_{p, \lambda, t}^{2}}
$$

where

$$
\|\tilde{f}\|_{p, \lambda, t}:=\left(\int_{M_{t_{0}}}|\tilde{f}|^{2} e^{-\lambda \max \{p \Psi+t, 0\}-\varphi}\right)^{1 / 2}
$$

and $t \in\left[p t_{0},+\infty\right)$. Note that

$$
p \Psi=\min \left\{p \psi+(2\lceil p\rceil-2 p) \log |F|-2 \log \left|F^{\lceil p\rceil}\right|,-p t_{0}\right\}
$$

on $\left\{p \Psi<-p t_{0}\right\}$ for any $p>0$, where $\lceil p\rceil:=\min \{m \in \mathbb{Z}: m \geq p\}$. Then definition of $J_{p}$ shows that $f \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right) \backslash\left(A^{2}\left(M_{t_{0}}, e^{-\varphi}\right) \cap J_{p}\right)$, which implies that $A^{2}\left(M_{t_{0}}, e^{-\varphi}\right) \cap J_{p}$ is a proper subspace of $A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)$, and $K_{\xi, p, \lambda}\left(p t_{0}\right) \in$ $(0,+\infty)$. Then Theorem 1.3 tells us that $-\log K_{\xi, p, \lambda}(t)+t$ is increasing with respect to $t \in\left[p t_{0},+\infty\right)$, which implies that

$$
\begin{equation*}
-\log K_{\xi, p, \lambda}(t)+t \geq-\log K_{\xi, p, \lambda}\left(p t_{0}\right)+p t_{0}, \forall t \in\left[p t_{0},+\infty\right) \tag{5.1}
\end{equation*}
$$

Since $f \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)$, following from inequality (5.1), we get that

\|f\|_{p, \lambda, t}^{2} \geq \frac{|\xi \cdot f|^{2}}{K_{\xi, p, \lambda}(t)} \geq e^{-t+p t_{0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, p, \lambda}\left(p t_{0}\right)}, \forall t \in\left[p t_{0},+\infty\right)
$$

In addition, since $f \notin A^{2}\left(M_{t_{0}}, e^{-\varphi}\right) \cap J_{p}$, according to Lemma 2.8, we have

\begin{align*}
\|f\|_{p, \lambda, t}^{2} & \geq \sup _{\substack{\left.\xi \in A^{2}\left(M_{t_{0}}, e^{-\varphi}\right)^{*} \backslash\{0\} \\
\xi\right|_{A^{2}\left(M_{t_{0}}, e^{-\varphi} \cap J_{p}\right.} \equiv 0}} e^{-t+p t_{0}} \frac{|\xi \cdot f|^{2}}{K_{\xi, p, \lambda}\left(p t_{0}\right)}  \tag{5.2}\\
& =e^{-t+p t_{0}} C\left(p \Psi, \varphi, J_{p}, f, M_{t_{0}}\right), \quad \forall t \in\left[p t_{0},+\infty\right)
\end{align*}
$$

Note that for any $t \in\left[p t_{0},+\infty\right)$,

$$
\begin{equation*}
\|f\|_{p, \lambda, t}^{2}=\int_{\{p \Psi<-t\}}|f|^{2} e^{-\varphi}+\int_{\left\{-p t_{0}>p \Psi \geq-t\right\}}|f|^{2} e^{-\lambda(p \Psi+t)-\varphi} \tag{5.3}
\end{equation*}
$$

Since for any $\lambda>0$,

$$
\int_{\left\{-p t_{0}>p \Psi \geq-t\right\}}|f|^{2} e^{-\lambda(p \Psi+t)-\varphi} \leq \int_{\left\{-p t_{0}>p \Psi \geq-t\right\}}|f|^{2} e^{-\varphi}<+\infty
$$

and $\lim _{\lambda \rightarrow+\infty} e^{-\lambda(p \Psi+t)}=0$ on $\left\{-p t_{0}>p \Psi \geq-t\right\}$, according to Lebesgue's dominated convergence theorem, we have

\lim _{\lambda \rightarrow+\infty} \int_{\left\{-p t_{0}>p \Psi \geq-t\right\}}|f|^{2} e^{-\lambda(p \Psi+t)-\varphi}=0
$$

Then equality (5.3) implies

\lim _{\lambda \rightarrow+\infty}\|f\|_{p, \lambda, t}^{2}=\int_{\{p \Psi<-t\}}|f|^{2} e^{-\varphi}, \forall t \in\left[p t_{0},+\infty\right) \tag{5.4}
\end{equation*}
$$

Letting $\lambda \rightarrow+\infty$ in inequality (5.2), we get that for any $t \in\left[p t_{0},+\infty\right)$,

\int_{\{p \Psi<-t\}}|f|^{2} e^{-\varphi} \geq e^{-t+p t_{0}} C\left(p \Psi, \varphi, J_{p}, f, M_{t_{0}}\right) \tag{5.5}
\end{equation*}
$$

Now we give the proof the Corollary 1.4

Proof of Corollary 1.4. Note that $J_{p} \subset I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}$ for any $p>2 a_{z_{0}}^{f}(\Psi ; \varphi)$. Then we have

$$
C\left(p \Psi, \varphi, J_{p}, f, M_{t_{0}}\right) \geq C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right), \forall p>2 a_{z_{0}}^{f}(\Psi ; \varphi)
$$

Since $\int_{M_{t_{0}}}|f|^{2} e^{-\varphi}<+\infty$, it follows from Lebesgue's dominated convergence theorem and inequality (5.5) that

$$
\begin{align*}
& \int_{\left\{2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi<-t\right\}}|f|^{2} e^{-\varphi} \\
= & \lim _{p \rightarrow 2 a_{z_{0}}^{f}(\Psi ; \varphi)+0} \int_{\{p \Psi<-t\}}|f|^{2} e^{-\varphi}  \tag{5.6}\\
\geq & \lim _{p \rightarrow 2 a_{z_{0}}^{f}(\Psi ; \varphi)+0} e^{-t+p t_{0}} C\left(p \Psi, \varphi, J_{p}, f, M_{t_{0}}\right) \\
\geq & e^{-t+2 a_{z_{0}}^{f}(\Psi ; \varphi) t_{0}} C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right),
\end{align*}
$$

for any $t \in\left[2 a_{z_{0}}^{f}(\Psi ; \varphi) t_{0},+\infty\right)$. Let $r:=e^{-t / 2}$, and we get that Corollary 1.4 holds.

In the following we give the proof of Corollary 1.6 .

Proof of Corollary 1.6. For any $q>2 a_{z_{0}}^{f}(\Psi ; \varphi)$, according to inequality (5.5), we get that for any $t \in\left[q t_{0},+\infty\right)$,

$$
\begin{equation*}
\int_{\{q \Psi<-t\}}|f|^{2} e^{-\varphi} \geq e^{-t+q t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) \tag{5.7}
\end{equation*}
$$

It follows from Fubini's Theorem that

$$
\begin{aligned}
& \int_{\left\{\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi-\Psi} \\
= & \int_{\left\{\Psi<-t_{0}\right\}}\left(|f|^{2} e^{-\varphi} \int_{0}^{e^{-\Psi}} \mathrm{d} s\right) \\
= & \int_{0}^{+\infty}\left(\int_{\left\{\Psi<-t_{0}\right\} \cap\left\{s<e^{-\Psi}\right\}}|f|^{2} e^{-\varphi}\right) \mathrm{d} s \\
= & \int_{-\infty}^{+\infty}\left(\int_{\{q \Psi<-q t\} \cap\left\{\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi}\right) e^{t} \mathrm{~d} t .
\end{aligned}
$$

Inequality (5.7) implies that for any $q>2 a_{o}^{f}(\Psi ; \varphi)$,

$$
\begin{aligned}
& \int_{t_{0}}^{+\infty}\left(\int_{\{q \Psi<-q t\} \cap\left\{\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi}\right) e^{t} \mathrm{~d} t \\
\geq & \int_{t_{0}}^{+\infty} e^{-q t+q t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) \cdot e^{t} \mathrm{~d} t \\
= & \frac{1}{q-1} e^{t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right),
\end{aligned}
$$

and

$$
\begin{aligned}
& \int_{-\infty}^{t_{0}}\left(\int_{\{q \Psi<-q t\} \cap\left\{\Psi<-t_{0}\right\}}|f|^{2} e^{-\varphi_{0}}\right) e^{t} \mathrm{~d} t \\
\geq & \int_{-\infty}^{t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) \cdot e^{t} \mathrm{~d} t \\
= & e^{t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) .
\end{aligned}
$$

Then we have

$$
\begin{equation*}
\int_{M_{t_{0}}}|f|^{2} e^{-\varphi-\Psi} \geq \frac{q}{q-1} e^{t_{0}} C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) \tag{5.8}
\end{equation*}
$$

for any $q>2 a_{z_{0}}^{f}(\Psi ; \varphi)$. Note that $J_{q} \subset I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}$ for any $q>$ $2 a_{z_{0}}^{f}(\Psi ; \varphi)$, which implies

$$
C\left(q \Psi, \varphi, J_{q}, f, M_{t_{0}}\right) \geq C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right), \forall q>2 a_{z_{0}}^{f}(\Psi ; \varphi)
$$

Then inequality (5.8) induces

$$
\begin{equation*}
\int_{M_{t_{0}}}|f|^{2} e^{-\varphi-\Psi} \geq \frac{q}{q-1} e^{t_{0}} C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right) \tag{5.9}
\end{equation*}
$$

Let $q \rightarrow 2 a_{o}^{f}\left(\Psi ; \varphi_{0}\right)+0$, then inequality (5.9) also holds for $q \geq 2 a_{o}^{f}\left(\Psi ; \varphi_{0}\right)$. Thus if $q>1$ satisfying

$$
\begin{equation*}
\int_{M_{t_{0}}}|f|^{2} e^{-\varphi_{0}-\Psi}<\frac{q}{q-1} e^{t_{0}} C\left(\Psi, \varphi, I_{+}\left(2 a_{z_{0}}^{f}(\Psi ; \varphi) \Psi+\varphi\right)_{z_{0}}, f, M_{t_{0}}\right) \tag{5.10}
\end{equation*}
$$

we have $q<2 a_{z_{0}}^{f}(\Psi ; \varphi)$, which means that $f_{z_{0}} \in \mathcal{O}\left(K_{M}\right)_{z_{0}} \otimes I(q \Psi+\varphi)_{z_{0}}$. Proof of Corollary 1.6 is done.

## 6. Appendix

In the appendix, we show an example for explaining the results we obtain in the present paper.

Let $M=\Delta^{2}$ be the unit polydisc in $\mathbb{C}^{2}$ with coordinate $(z, w), \psi=2 \log |z|$ a plurisubharmonic function on $\Delta^{2}, F=w^{k}$ a holomorphic function on $\Delta^{2}$ for some positive function $k$, and $T=0$. Then we have

$$
\Psi(z, w):=\min \{\psi-2 \log |F|, 0\}=\min \left\{2 \log \left|\frac{z}{w^{k}}\right|, 0\right\}
$$

where $\Psi(z, o):=0$ for any $z \in \Delta$. Then for any $t \in[0,+\infty)$, we have

$$
M_{t}:=\{\Psi<-t\}=\left\{(z, w) \in \Delta \times \Delta^{*}:|z|<e^{-t / 2}|w|^{k}\right\}
$$

Especially, $M_{0}=\left\{(z, w) \in \Delta \times \Delta^{*}:|z|<|w|^{k}\right\}$. Note that $o$ is a boundary point of $M_{0}$, and $M_{0} \cup o$ is a Reinhardt domain. Then any holomorphic function on $M_{0}$ can be written as its Laurent expansion. Let $f \in \mathcal{O}\left(M_{0}\right)$, and we may write that

$$
f(z, w)=\sum_{(j, l) \in \mathbb{Z}^{2}} c_{j, l} z^{j} w^{l} .
$$

We can compute that

$$
\int_{M_{0}}|f|^{2}=\sum_{(j, l) \in \mathbb{Z}^{2}}\left|c_{j, l}\right|^{2} \int_{M_{0}}|z|^{2 j}|w|^{2 l}
$$

where

$$
\int_{M_{0}}|z|^{2 j}|w|^{2 l}=\frac{\pi^{2}}{(j+1)(j k+k+l+1)}
$$

if $j \geq 0, j k+k+l \geq 0$, otherwise it equals $+\infty$. Similarly, we can compute that

$$
\int_{M_{0}}|f|^{2} e^{-\Psi}=\sum_{(j, l) \in \mathbb{Z}^{2}}\left|c_{j, l}\right|^{2} \int_{M_{0}}|z|^{2 j-2}|w|^{2 l+2 k}
$$

where

$$
\int_{M_{0}}|z|^{2 j-2}|w|^{2 l+2 k}=\frac{\pi^{2}}{j(j k+k+l+1)},
$$

if $j \geq 1, j k+k+l \geq 0$, otherwise it equals $+\infty$. Then it can be noted that

$$
I(\Psi)_{o}=\left\{h(z, w)=\sum_{(j, l) \in \mathbb{Z}^{2}} a_{j, l} z^{j} w^{l} \text { near } o: a_{j, l}=0, \forall(j, l) \in \mathcal{S}\right\}
$$

where $\mathcal{S}:=\left\{(j, l) \in \mathbb{Z}^{2}: j=0\right.$ or $\left.l \leq-(j k+k+1)\right\}$. Let $\xi \in A^{2}\left(M_{0}\right)^{*}$ which is defined as:

$$
\begin{equation*}
\xi \cdot f=c_{0,-k}, \forall f=\sum_{(j, l) \in \mathbb{Z}^{2}} c_{j, l} z^{j} w^{l} \in A^{2}\left(M_{0}\right) \tag{6.1}
\end{equation*}
$$

where it is easy to see that $\xi$ is linear, continuous, $\xi \neq 0$, and $\left.\xi\right|_{A^{2}\left(M_{0}\right) \cap I(\Psi)_{o}} \equiv 0$.
Let $\varphi \equiv 0$, and $\lambda>1$. Then

$$
\Psi_{\lambda, t}:=\lambda \max \{\Psi+t, 0\}=\lambda \max \left\{2 \log \frac{|z|}{|w|^{k}}+t, 0\right\}
$$

Now we can calculate that for any $t \in[0,+\infty)$,

$$
\begin{aligned}
K_{\xi, \Psi, \lambda}^{0}(t) & =\left(\int_{M_{0}}\left|w^{-k}\right|^{2} e^{-\Psi_{\lambda, t}}\right)^{-1} \\
& =\frac{1}{\pi^{2}} \cdot \frac{\lambda-1}{\lambda e^{-t}-e^{-\lambda t}}
\end{aligned}
$$

for $\lambda \neq 1$, and

$$
K_{\xi, \Psi, 1}^{0}(t)=\frac{1}{\pi^{2}} e^{t}
$$

for $\lambda=1$. Then it can be checked that for any $\lambda>0, \log K_{\xi, \Psi, \lambda}^{0}(t)$ is convex with respect to $t \in[0,+\infty)$, and $-\log K_{\xi, \Psi, \lambda}^{0}(t)+t$ increasing on $[0,+\infty)$. These are compatible to Theorem 1.2 and Theorem 1.3

Let $g:=w^{-k} \in A^{2}\left(M_{0}\right)$. Then it can be verified that

$$
C\left(\Psi, 0, I_{+}(\Psi)_{o}, g, M_{0}\right)=\|g\|_{0}^{2}=\int_{M_{0}}|g|^{2}=\pi^{2}
$$

where exactly we have

$$
C\left(\Psi, 0, I_{+}(\Psi)_{o}, g, M_{0}\right)=\frac{|\xi \cdot g|^{2}}{K_{\xi, \Psi, \lambda}^{0}(0)}
$$

for the functional $\xi$ described in (6.1), which can be referred to Lemma [2.8. In addition, it can be computed that $a_{o}^{g}(\Psi ; 0)=\frac{1}{2}$, and

$$
\frac{1}{r^{2}} \int_{\left\{\frac{1}{2} \Psi<\log r\right\}}|g|^{2}=\pi^{2}=C\left(\Psi, 0, I_{+}(\Psi)_{o}, g, M_{0}\right)
$$

for any $r \in(0,1]$. This is compatible to Corollary 1.4. Similar computations can also be given to Corollary 1.6 under these assumptions.
