# REMOVABLE SINGULARITIES FOR SUB-SOLUTIONS OF ELLIPTIC EQUATIONS INVOLVING WEIGHTED VARIABLE EXPONENT SOBOLEV SPACES

## JUAN ALCON APAZA

ABSTRACT. We study the removability of a singular set for elliptic equations involving weight functions and variable exponents. We consider the case where the singular set satisfies conditions related to some generalization of *upper Minkowski content* or a *net measure*, and give sufficient conditions for removability of this singularity for equations in the weighted variable exponent Sobolev spaces  $W^{1,p(\cdot)}(\Omega,\vartheta)$ .

## 1. Introduction

This paper is devoted to the study of conditions guaranteeing the removability of singular set for non-negative weak sub-solutions, in the weighted variable exponent Sobolev spaces, for nonlinear elliptic equations of the form

$$-\operatorname{div} A(x, u, \nabla u) + B(x, u) = 0.$$

For the exacts requirements on the mappings A and B we refer to Section 3. In this work we employ the arguments used to prove the following results.

**Theorem A.** (see [13, Theorem 1]) Let  $\Omega \subset \mathbb{R}^n$ ,  $n \ge 2$ , be an open set, and  $E \subset \Omega$  be closed in  $\Omega$ . Denote by  $\mathcal{M}^{\alpha}(E)$  the  $\alpha$ -dimensional upper Minkowski content of E. Suppose that  $\alpha \in [0, n-2]$  and  $\mathcal{M}^{\alpha}(E) = 0$ . If f is subharmonic in  $\Omega \setminus E$  and satisfies

$$f(x) \leqslant Cd(x, E)^{\alpha + 2 - n} \quad (x \in \Omega \backslash E)$$

for some positive constant C, then f has a subharmonic extension to  $\Omega$ .

**Theorem B.** (see [13, Theorem 3]) Let  $\Omega \subset \mathbb{R}^n$ ,  $n \ge 2$ , be an open set, and  $E \subset \Omega$  be closed in  $\Omega$ . Denote by  $\mathcal{H}^{\alpha}(E)$  the  $\alpha$ -dimensional Hausdorff measure of E. Suppose that  $\alpha \in [0, n-2]$  and  $\mathcal{H}^{\alpha}(E) = 0$ . If f is subharmonic in  $\Omega \setminus E$  and satisfies

$$\frac{1}{|B(x,r)|}\int_{B(x,r)} \max\{f,0\} \mathrm{d}x \leqslant C r^{\alpha+2-n} \quad \left(\overline{B(x,r)} \subset \Omega\right)$$

for some positive constant C, then f has a subharmonic extension to  $\Omega$ .

Motivated by these theorems we given a generalization of the *upper Minkowski content* and the *net measure* involving weight and variable exponents, see the next section. In the case that certain smoothness, Hausdorff measure or uniform Minkowski condition is imposing on the singular set, a different approach can be found in [6, 8, 10].

## 2. Preliminaries

Throughout the whole article  $\Omega$  is a bounded open set in  $\mathbb{R}^n$ ,  $n \geqslant 3$ . We will work on  $\Omega$  with the Lebesgue measure dx. We first recall some facts on spaces  $L^{p(\cdot)}(\Omega, \vartheta)$  and  $W^{1,p(\cdot)}(\Omega, \vartheta)$ . We write

$$L_+^{\infty}(\Omega) = \{ p \in L^{\infty}(\Omega) \mid \operatorname{ess\,inf}_{\Omega} p > 1 \}.$$

For  $p \in L^{\infty}_{+}(\Omega)$ , we define

$$W(\Omega) = \{ \vartheta \in L^1_{loc}(\Omega) \mid \vartheta > 0 \text{ almost everywhere in } \Omega \}.$$

An element in  $W(\Omega)$  is called a weight function. For  $p \in L^{\infty}_{+}(\Omega)$ , set

$$W_p(\Omega) = \left\{ \vartheta \in W(\Omega) \mid \vartheta^{-\frac{1}{p-1}} \in L^1_{loc}(\Omega) \right\}.$$

Let  $p \in L^{\infty}_{+}(\Omega)$  and  $\vartheta \in W(\Omega)$ , we define the functional

$$\rho_{p,\vartheta}(u) = \int_{\Omega} |u|^p \vartheta \mathrm{d}x.$$

The weighted variable exponent Lebesgue space  $L^{p(\cdot)}(\Omega, \vartheta)$  is the class of all functions u such that  $\rho_{p,\vartheta}(tu) < \infty$ , for some t > 0.  $L^{p(\cdot)}(\Omega, \vartheta)$  is a Banach space equipped with the norm

$$||u||_{L^{p(\cdot)}(\Omega,\vartheta)} = \inf\left\{\lambda > 0 \mid \rho_{p,\vartheta}\left(\frac{u}{\lambda}\right) \le 1\right\};$$

see [11, Theorem 2.5]. In the case that  $\vartheta \equiv 1$ , we have  $L^{p(\cdot)}(\Omega,\vartheta) = L^{p(\cdot)}(\Omega)$ . For any  $p \in L^{\infty}_+(\Omega)$ , we denote by  $p' = \frac{p}{p-1}$  the conjugate function.

**Proposition 2.1.** (see [11, Theorem 2.1].) Let  $p \in L^{\infty}_{+}(\Omega)$ . For any  $u \in L^{p(\cdot)}(\Omega)$  and  $v \in L^{p'(\cdot)}(\Omega)$ ,

$$\int_{\Omega} |uv| dx \le 2||u||_{L^{p(\cdot)}(\Omega)} ||v||_{L^{p'(\cdot)}(\Omega)}.$$
(2.1)

**Proposition 2.2.** (see [15, pp. 4], [5, Theorem 1.3].) Let  $p \in L^{\infty}_{+}(\Omega)$ . For any  $u \in L^{p(\cdot)}(\Omega, \vartheta)$ , we have

$$\min \left\{ \rho_{p,\vartheta}(u)^{\frac{1}{p^{-}}}, \rho_{p,\vartheta}(u)^{\frac{1}{p^{+}}} \right\} \leqslant \|u\|_{L^{p(\cdot)}(\Omega,\vartheta)} \leqslant \max \left\{ \rho_{p,\vartheta}(u)^{\frac{1}{p^{-}}}, \rho_{p,\vartheta}(u)^{\frac{1}{p^{+}}} \right\}, \tag{2.2}$$

$$\min\left\{\left\|u\right\|_{L^{p(\cdot)}(\Omega,\vartheta)}^{p^{-}},\left\|u\right\|_{L^{p(\cdot)}(\Omega,\vartheta)}^{p^{+}}\right\} \leqslant \rho_{p,\vartheta}(u) \leqslant \max\left\{\left\|u\right\|_{L^{p(\cdot)}(\Omega,\vartheta)}^{p^{-}},\left\|u\right\|_{L^{p(\cdot)}(\Omega,\vartheta)}^{p^{+}}\right\},\tag{2.3}$$

where  $p^- = \operatorname{ess\,inf}_{\Omega} p$  and  $p^+ = \operatorname{ess\,sup}_{\Omega} p$ .

Let  $p \in L^{\infty}_{+}(\Omega)$  and  $\vartheta \in W_{p}(\Omega)$ . The weighted variable exponent Sobolev space  $W^{1,p(\cdot)}(\Omega,\vartheta)$  is the class of all functions  $u \in L^{p(\cdot)}(\Omega,\vartheta)$  which have the property  $|\nabla u| \in L^{p(\cdot)}(\Omega,\vartheta)$ . The space  $W^{1,p(\cdot)}(\Omega,\vartheta)$  is a Banach space equipped with the norm

$$||u||_{W^{1,p(\cdot)}(\Omega,\vartheta)} = ||u||_{L^{p(\cdot)}(\Omega,\vartheta)} + ||\nabla u||_{L^{p(\cdot)}(\Omega,\vartheta)};$$

see [11, Theorem 3.1] and [15, Proposition 3.2].

In the proof our main results we employed the following type of partition of unity:

**Lemma 2.1.** (see [7, Lemma 3.1]) Let  $\{Q_i\}_{i=1}^N$  be a finite disjoint collection of dyadic of length  $\ell_i$ . For each i, there is a non-negative function  $\varphi_i \in C_0^\infty(\mathbb{R}^n)$  with  $\operatorname{spt} \varphi_i \subset \frac{3}{2}Q_i$  such that  $\sum_{i=1}^N \varphi_i \leqslant 1$  on  $\mathbb{R}^n$ , and  $\sum_{i=1}^N \varphi_i = 1$  on  $\bigcup_{i=1}^N Q_i$ . Furthermore, for each multi-index  $\lambda$ , there is a constant  $C_\lambda = C_\lambda(n,\lambda) > 0$  for which  $|D^\lambda \varphi_i(x)| \leqslant C_\lambda \ell_i^{-|\lambda|}$  for all x and  $i \in \{1,\ldots,N\}$ .

To define the *Minkowski content*, let  $\alpha:\Omega\to[0,n]$  be a measurable function and  $F\subset\mathbb{R}^n$ . For  $\varepsilon>0$ , we write

$$F_{\varepsilon} = \{ x \in \mathbb{R}^n \mid d(x, F) < \varepsilon \},$$

where d(x, F) denote the Euclidean distance from a point  $x \in \mathbb{R}^n$  to F.

**Definition 2.1.** The  $(\alpha, \vartheta)$ -upper Minkowski content of F is defined by

$$\mathcal{M}^{\alpha}_{\vartheta}(F) = \limsup_{\varepsilon \to 0^{+}} \int_{F_{\varepsilon}} \varepsilon^{\alpha - n} d\vartheta,$$

where  $\vartheta \in W(\Omega)$  and  $d\vartheta = \vartheta dx$ .

Now, we proceed to define the *net measure*. For  $x \in \mathbb{R}^n$  and  $\ell > 0$ , we denote by

$$Q(x,\ell) = \{ y \in \mathbb{R}^n \mid |x_i - y_i| \le \ell/2, \ i = 1, \dots, n \},$$

the cube of center x and length  $\ell$ . Recall that a *dyadic cube* is represented as

$$\left[m_1 2^{-k}, (m_1+1) 2^{-k}\right] \times \cdots \times \left[m_n 2^{-k}, (m_n+1) 2^{-k}\right],$$

where  $k, m_1, \ldots, m_n$  are integers.

For a cube Q of length  $\ell(Q) = \ell$ , we let  $\frac{3}{2}Q$  denote the cube with the same center and length  $3\ell/2$ . For any integer k let  $G_k$  be a collection of cubes represented by a form

$$\left[m_1 2^{-k}, (m_1 + 1) 2^{-k}\right] \times \cdots \times \left[m_n 2^{-k}, (m_n + 1) 2^{-k}\right],$$

for some integers  $m_1, \ldots, m_n$ .

Let  $\gamma > 0$  be fixed. For each  $\varepsilon > 0$  we write

$$\mathcal{L}_{\alpha,\gamma,\vartheta}^{\varepsilon}(F) = \inf \left\{ \sum_{j} \left[ \int_{Q_{j}} \left( 2^{-k_{j}} \right)^{\alpha - n} \mathrm{d}\vartheta \right]^{\gamma} \mid F \subset \operatorname{int}\left( \cup_{j} Q_{j} \right), \ Q_{j} \in G_{k_{j}}, \ 2^{-k_{j}} < \varepsilon \right\}.$$

**Definition 2.2.** The  $(\alpha, \gamma, \vartheta)$ -net measure of F is defined by

$$\mathcal{L}_{\alpha,\gamma,\vartheta}(F) = \lim_{\varepsilon \to 0^+} \mathcal{L}_{\alpha,\gamma,\vartheta}^{\varepsilon}(F).$$

We finish this section, introducing the following condition used in this work.

**Assumption 2.1.** Assume  $p \in L^{\infty}_{+}(\Omega)$  and  $\vartheta \in W_{p}(\Omega)$ . Suppose  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$  has compact support  $\operatorname{spt} \varphi = K$ . Then there exist functions  $\varphi_{m} \in C^{\infty}(\Omega)$ , with  $\operatorname{spt} \varphi_{m} \subset K_{d(K,\partial\Omega)/2}$ , such that

$$\varphi_m \to \varphi$$
 in  $W^{1,p(\cdot)}(\Omega,\vartheta)$ .

**Remark.** In the case that  $\vartheta \equiv 1$  and  $p \in \mathcal{P}^{\log}(\Omega)$  is bounded, the Assumption 2.1 is verified, see [2, Corollary 11.2.4]. On the other hand, if  $p \in \mathcal{P}^{\log}(\Omega)$  is bounded and  $\vartheta$  satisfies the Muckenhoupt condition, see [1, 3], following the same lines of the proof of [12, Lemma 2.4] we obtain the Assumption 2.1; for auxiliary results see [14, Theorem 2.1.4], [4, Appendix C.5], [1, Theorem 1.1] and [3, Theorem 1.1]. Finally, if  $p \equiv \text{constant}$  and  $\vartheta$  belongs to Muckenhoupt's  $A_p$ -class, the Assumption 2.1 is satisfied; see [9, Theorem 2.5].

## 3. MAIN RESULTS

In the sequel  $E \subset \Omega$  is a compact set. For us a function is *integrable* if it has an integral (which may equal  $\pm \infty$ ).

**Definition 3.1.** Let  $\vartheta \in W_p(\Omega)$  and  $p \in L^{\infty}_+(\Omega)$ . We define

$$W_{E,\operatorname{loc}}^{1,p(\cdot)}\left(\Omega,\vartheta\right)=\left\{u:\Omega\to\overline{\mathbb{R}}\ |\ u\ \text{is integrable,}\ u|_{\Omega\setminus E}\in W_{\operatorname{loc}}^{1,p(\cdot)}(\Omega\backslash E,\vartheta),\right\}$$

and there is a integrable function  $\widetilde{\nabla u}:\Omega\to\overline{\mathbb{R}}^n$  so that  $\widetilde{\nabla u}=\nabla u$  a.e. on  $\Omega\setminus E$ .

Now, we will divide our main results into two sections.

3.1. Singular set satisfying  $\mathcal{M}^{\alpha}_{\beta}(E) = 0$ . First, we will work with nonlinear elliptic equations of the form

$$-\operatorname{div} A(x, u, \nabla u) + B(x, u) = 0. \tag{3.4}$$

We assume that  $A: \Omega \times [0,\infty) \times \mathbb{R}^n \to \mathbb{R}^n$  and  $B: \Omega \times [0,\infty) \to \mathbb{R}$  are measurable functions. Furthermore, there exists  $\mu > 0$  such that the following conditions are satisfied almost everywhere:

$$\langle A(x, u, \eta), \eta \rangle \geqslant \left(\mu |\eta|^{p(x)} - \mu^{-1} u^{p(x)} + a_1(x)\right) \vartheta(x), \tag{3.5}$$

$$|A(x, u, \eta)| \le \left(\mu^{-1} |\eta|^{p(x)-1} + \mu^{-1} u^{p(x)-1} + a_2(x)\right) \vartheta(x), \tag{3.6}$$

$$|B(x,u)| \le \left(\mu^{-1}u^{p(x)-1} + a_3(x)\right)\vartheta(x),$$
 (3.7)

where  $\vartheta \in W_p(\Omega)$ ,  $a_1 \in L^{q_1}(\Omega, \vartheta)$ ,  $a_2 \in L^{q_2}(\Omega, \vartheta)$ ,  $a_2 \geqslant 0$ ,  $a_3 \in L^{q_3}(\Omega, \vartheta)$ ,  $a_3 \geqslant 0$ ,  $\alpha, \beta : \Omega \to [0, n]$  are measurable functions, and  $p, q_1, q_2, q_3 \in L^{\infty}_+(\Omega)$ . Furthermore,

$$(p\beta)^{+} \leqslant n - \alpha^{+} - p^{+} - 1,$$
 (3.8)

$$q_1^-, q_3^- \geqslant \left(\frac{p}{p-1}\right)^+, q_2^- \geqslant \max\left\{\left(\frac{p}{p-1}\right)^+, \frac{n-\alpha^+}{n-\alpha^+-\beta^+-2}\right\}.$$
 (3.9)

**Definition 3.2.** We will say that  $u \in W_{E, loc}^{1, p(\cdot)}(\Omega, \vartheta)$  is a (weak) sub-solution of equation (3.4) in  $\Omega \setminus E$  if

$$\int_{\Omega \setminus E} \langle A(\cdot, u, \nabla u), \nabla \varphi \rangle + B(\cdot, u) \varphi dx \leq 0$$
(3.10)

for all  $\varphi \in W^{1,p(\cdot)}(\Omega, \vartheta)$ ,  $\varphi \geqslant 0$ , with compact support in  $\Omega \backslash E$ .

**Definition 3.3.** We will say that the sub-solution u of equation (3.4) in  $\Omega \setminus E$  has a removable singularity at E: if  $u \in W_{E,\operatorname{loc}}^{1,p(\cdot)}(\Omega,\vartheta)$  implies  $u \in W_{\operatorname{loc}}^{1,p(\cdot)}(\Omega,\vartheta)$  and the equality (3.10) is fulfilled for all  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$ ,  $\varphi \geqslant 0$ , with compact support.

Inspired by Theorem A we have our first main result.

**Theorem 3.1.** Suppose that (3.5) - (3.9) are satisfied, furthermore  $\mathcal{M}^{\alpha}_{\vartheta}(E) = 0$ . If u is a non-negative subsolution of (3.4) in  $\Omega \backslash E$ , and

$$u \leqslant Cd(\cdot, E)^{-\beta}$$
 a.e. on  $\Omega \backslash E$ , (3.11)

where C is a suitable positive constant, then the singularity of u at E is removable.

*Proof.* 1. Let  $\varepsilon \in (0,1)$  be arbitrary. Since  $M_{\vartheta}^{\alpha}(E) = 0$ , there is  $r_0 \in (0,\varepsilon)$  such that  $\overline{E_{r_0}} \subset \Omega$  and

$$\int_{E_r} r^{\alpha - n} d\vartheta < \varepsilon \quad \text{ for all } r \in [0, r_0]. \tag{3.12}$$

For  $r \in [0, r_0]$  and  $j = 0, 1, \ldots$ , we write

$$K_j = \{ x \in \mathbb{R}^n \mid d(x, E) < 2^{-j} r \},$$

then

$$E_r = \bigcup_{j=0}^{\infty} \left( K_j \backslash K_{j+1} \right),\,$$

and, by (3.11), (3.12) and (3.8),

$$\begin{split} &\int_{K_{j}\backslash K_{j+1}}u^{p}\mathrm{d}\vartheta\leqslant\int_{K_{j}\backslash K_{j+1}}C^{p}d(\cdot,E)^{-\beta p}\mathrm{d}\vartheta\leqslant C_{1}\left(p\right)\int_{K_{j}\backslash K_{j+1}}\left(2^{-(j+1)}r\right)^{-\beta p}\mathrm{d}\vartheta\\ &=C_{1}\int_{K_{j}\backslash K_{j+1}}2^{\beta p}\left(2^{-j}r\right)^{n-\alpha-\beta p}\left(2^{-j}r\right)^{\alpha-n}\mathrm{d}\vartheta\leqslant C_{1}2^{(\beta p)^{+}}\left(2^{-j}r\right)^{n-\alpha^{+}-(\beta p)^{+}}\varepsilon\\ &\leqslant C_{2}(p,\beta)2^{-j-1}r^{p^{+}+1}\varepsilon. \end{split}$$

Therefore, considering |E|=0,

$$\int_{E_r} u^p d\vartheta = \sum_{j=0}^{\infty} \int_{K_j \setminus K_{j+1}} u^p d\vartheta \leqslant C_2 \varepsilon r^{p^++1}, \tag{3.13}$$

for all  $r \in [0, r_0]$ . Thus  $u \in L^{p(\cdot)}_{\text{loc}}(\Omega, \vartheta)$ .

2. Now, we prove  $|\widetilde{\nabla u}| \in L^{p(\cdot)}_{\mathrm{loc}}(\Omega, \vartheta)$ . For  $r < 2r_0/5$ , let  $\psi_r : \mathbb{R} \to \mathbb{R}$  be a smooth function such that

$$\psi_r(t) = \begin{cases} 0 & \text{if } t < r/2 \text{ or } t > 5r/2, \\ 1 & \text{if } r < t < 2r, \end{cases}$$

 $0 \leqslant \psi_r \leqslant 1$  and  $|\psi'_r| \leqslant C_3/r$ , where  $C_3$  is a positive constant. Set

$$\varphi = \left(\psi_r^{p^+} \circ d(\cdot, E)\right) u.$$

We have  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$ ,  $\varphi \geqslant 0$ , with compact support in  $\Omega \backslash E$ . For simplicity we write  $\psi_r = \psi_r \circ d(\cdot,E)$  and  $\psi_r' = \psi_r' \circ d(\cdot,E)$ . Substituting  $\varphi$  into (3.10),

$$\int_{\Omega \setminus E} \left\langle A(\cdot, u, \nabla u), \psi_r^{p^+} \nabla u + p^+ \psi_r^{p^+ - 1} \psi_r' u \nabla d(\cdot, E) \right\rangle + B(\cdot, u) \psi_r^{p^+} u \mathrm{d}x \leqslant 0.$$

By conditions (3.5) - (3.9),

$$q_1^- \geqslant \frac{n - \alpha^+}{n - \alpha^+ - 1}, \ q_2^- \geqslant \frac{n - \alpha^+}{n - \alpha^+ - \beta^+ - 2}, \ q_3^- \geqslant \frac{n - \alpha^+}{n - \alpha^+ - \beta^+ - 1}$$
 (3.14)

and

$$\begin{split} & \int_{\left\{\frac{r}{2} \leqslant d(\cdot, E) \leqslant \frac{5r}{2}\right\}} \psi_r^{p^+} \left(\mu |\nabla u|^p - \mu^{-1} u^p + a_1\right) \mathrm{d}\vartheta \\ & \leqslant \int_{\left\{\frac{r}{2} \leqslant d(\cdot, E) \leqslant \frac{5r}{2}\right\}} \frac{C_3}{r} p^+ \psi_r^{p^+ - 1} \left(\mu^{-1} |\nabla u|^{p - 1} + \mu^{-1} u^{p - 1} + a_2\right) u \mathrm{d}\vartheta \\ & + \int_{\left\{\frac{r}{2} \leqslant d(\cdot, E) \leqslant \frac{5r}{2}\right\}} \psi_r^{p^+} \left(\mu^{-1} u^{p - 1} + a_3\right) u \mathrm{d}\vartheta \end{split}$$

Consequently, by (3.13), (2.1), (2.2), Young's inequality and (3.11),

$$\begin{split} &\int_{\{r\leqslant d(\cdot,E)\leqslant 2r\}} |\nabla u|^p \mathrm{d}\vartheta \leqslant C_4\varepsilon \frac{5r}{2} \\ &+ C_4 r^{\left(n-\alpha^+\right)\left(\frac{q_1^--1}{q_1^-}\right)} \|a_1\|_{L^{q_1(\cdot)}(\Omega,\vartheta)} \left[ \int_{E_{5r/2}} \left(\frac{5r}{2}\right)^{\alpha-n} \mathrm{d}\vartheta \right]^{\left(\frac{q_1-1}{q_1}\right)^-} \\ &+ C_4 \int_{\left\{\frac{r}{2}\leqslant d(\cdot,E)\leqslant \frac{5r}{2}\right\}} C_5\left(\varepsilon_1,p\right) \left(\frac{u}{r}\right)^p + \varepsilon_1 \psi_r^{\frac{(p^+-1)p}{p-1}} |\nabla u|^p \mathrm{d}\vartheta \\ &+ C_4 r^{\left(n-\alpha^+\right)\left(\frac{q_2^--1}{q_2^-}\right)-\beta^+-1} \|a_2\|_{L^{q_2(\cdot)}(\Omega,\vartheta)} \left[ \int_{E_{5r/2}} \left(\frac{5r}{2}\right)^{\alpha-n} \mathrm{d}\vartheta \right]^{\left(\frac{q_2-1}{q_2}\right)^-} \\ &+ C_4 r^{\left(n-\alpha^+\right)\left(\frac{q_3^--1}{q_3^-}\right)-\beta^+} \|a_3\|_{L^{q_3(\cdot)}(\Omega,\vartheta)} \left[ \int_{E_{5r/2}} \left(\frac{5r}{2}\right)^{\alpha-n} \mathrm{d}\vartheta \right]^{\left(\frac{q_3-1}{q_3}\right)^-}, \end{split}$$

where  $C_4 = C_4 (\mu, \alpha, p, C_2) > 0$ . Take  $\varepsilon_1 = \frac{1}{2C_4}$ . From (3.14), (3.11), (3.12), (3.8), we have

$$\frac{1}{2}\int_{\{r\leqslant d(\cdot,E)\leqslant 2r\}}|\nabla u|^p\mathrm{d}\vartheta\leqslant C_6\varepsilon^{\gamma_1}r+C_6\varepsilon r^{n-\alpha^+-(p\beta)^+-1}\leqslant 2C_6\varepsilon^{\gamma_1}r.$$

Therefore,

$$\int_{E_r} |\widetilde{\nabla u}|^p d\vartheta = \sum_{i=0}^{\infty} \int_{\left\{2^{-(i+1)}r \leqslant d(\cdot, E) \leqslant 2^{-i}r\right\}} |\nabla u|^p d\vartheta \leqslant C_7 \varepsilon^{\gamma_1} r, \tag{3.15}$$

where  $C_i = C_i(\mu, \alpha, \beta, p, a_1, a_2, a_3) > 0, i = 6, 7, \gamma_1 = \gamma_1(q_1, q_2, q_3) \in (0, 1).$  Hence  $|\widetilde{\nabla u}| \in L^{p(\cdot)}_{loc}(\Omega, \vartheta).$ 

3. Recall from step 1 and 2 that  $u \in L^{p(\cdot)}_{\mathrm{loc}}(\Omega,\vartheta)$  and  $|\widetilde{\nabla u}| \in L^{p(\cdot)}_{\mathrm{loc}}(\Omega,\vartheta)$ . We now claim  $u \in W^{1,p(\cdot)}_{\mathrm{loc}}(\Omega,\vartheta)$ . To verify this assertion, fix  $\varphi \in C^{\infty}_{0}(\Omega)$ , we assume that  $|\varphi| \leqslant 1$  and  $|\nabla \varphi| \leqslant 1$ . For  $r \in (0,r_{0}/2)$ , let  $\zeta_{r}: \mathbb{R} \to \mathbb{R}$  be a smooth function such that

$$\zeta_r(t) = \begin{cases} 1 & \text{if } |t| \leqslant r, \\ 0 & \text{if } 2r \leqslant |t|, \end{cases}$$

 $0 \leqslant \zeta_r \leqslant 1$  and  $|\zeta_r'| \leqslant C_8/r$ , where  $C_8$  is a positive constant. For simplicity we write  $\zeta_r = \zeta_r \circ d(\cdot, E)$  and  $\zeta_r' = \zeta_r' \circ d(\cdot, E)$ . We have

$$\int_{\Omega \setminus E} u \left[ (1 - \zeta_r) \varphi \right]_{x_i} dx = -\int_{\Omega \setminus E} u_{x_i} (1 - \zeta_r) \varphi dx,$$

where  $i = 1, \ldots, n$ . If  $r \to 0^+$ :

$$\int_{\Omega} u\varphi_{x_i} dx = -\int_{\Omega} u_{x_i} \varphi dx. \tag{3.16}$$

Indeed, (2.1), (2.2) and (3.13) implies

$$\left| \int_{\Omega \setminus E} u \left( \zeta_r \right)_{x_i} \varphi dx \right| \leq 2 \left\| \frac{C_8 u}{r} \vartheta^{1/p} \right\|_{L^{p(\cdot)}(E_{2r})} \left\| \vartheta^{-1/p} \right\|_{L^{p'(\cdot)}(E_{2r})}$$

$$\leq C_9(p,\beta) \left\| \vartheta^{-1/p} \right\|_{L^{p'(\cdot)}(E_{r_0})} (\varepsilon r)^{1/p^+} \to 0 \quad \text{as } r \to 0^+,$$

since  $\vartheta \in W_p(\Omega)$ . So (3.16) is proved.

4. To complete the proof of the theorem. Let  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$  be with compact support and  $\varphi \geqslant 0$ . By Assumption 2.1, we consider the case  $\varphi \in C^{\infty}(\Omega)$ ,  $\varphi \leqslant 1$  and  $|\nabla \varphi| \leqslant 1$ . We show

$$\int_{\Omega} \langle A(\cdot, u, \nabla u), \nabla \varphi \rangle + B(\cdot, u) \varphi dx \leqslant 0.$$

Let  $K = \operatorname{spt} \varphi$ . We may suppose that  $\overline{K_{r_0}} \subset \Omega$ . Choose  $\ell = 2^{-k}$  so small that  $3\ell\sqrt{n} < r_0$ . Cover K by a finite collection of dyadic cubes  $Q_i$  with same length  $\ell(Q_i) = \ell, i = 1, \ldots, N$ . Moreover, we can assume that

$$\frac{3}{2}Q_i \cap E \neq \emptyset \quad \text{ for } i = 1, \dots, N_*,$$

$$\frac{3}{2}Q_i \cap E = \emptyset \quad \text{ for } i = N^* + 1, \dots, N,$$

for some  $N_* \in \mathbb{N}$ ,  $1 \leqslant N^* \leqslant N$ . By Lemma 2.1, we have there exist non-negative functions  $\varphi_i \in C_0^\infty (\mathbb{R}^n)$  with  $\operatorname{spt} \varphi_i \subset \frac{3}{2}Q_i$  such that  $\sum_{i=1}^N \varphi_i = 1$  on  $\bigcup_{i=1}^N Q_i \supset K$ . Furthermore,  $|\nabla \varphi_i| \leqslant C_{10}(n)\ell^{-1}$ ,  $i=1,\ldots,N$ , on  $\mathbb{R}^n$ . Since u is a sub-solution of (3.4) in  $\Omega \backslash E$ , and  $\varphi \varphi_i \in W^{1,p(\cdot)}(\Omega,\vartheta)$ ,  $\varphi \varphi_i \geqslant 0$ ,  $i=N_*+1,\ldots,N$  has compact support in  $\Omega \backslash E$ , we have

$$\int_{\Omega \setminus E} \langle A(\cdot, u, \nabla u), \nabla (\varphi \varphi_i) \rangle + B(\cdot, u) (\varphi \varphi_i) \, \mathrm{d}x \leqslant 0, \tag{3.17}$$

Then, by (3.6) and (3.7),

$$\begin{split} &\int_{\Omega} \left\langle A(\cdot,u,\nabla u), \nabla \varphi \right\rangle + B(\cdot,u) \varphi \mathrm{d}x = \sum_{i=1}^{N} \int_{\frac{3}{2}Q_{i}} \left\langle A(\cdot,u,\nabla u), \nabla \left(\varphi \varphi_{i}\right) \right\rangle + B(\cdot,u) \left(\varphi \varphi_{i}\right) \mathrm{d}x \\ &\leqslant \sum_{i=1}^{N_{*}} \int_{\frac{3}{2}Q_{i}} \left\langle A(\cdot,u,\nabla u), \nabla \left(\varphi \varphi_{i}\right) \right\rangle + B(\cdot,u) \left(\varphi \varphi_{i}\right) \mathrm{d}x \\ &\leqslant \sum_{i=1}^{N_{*}} \int_{\frac{3}{2}Q_{i}} \mu^{-1} (2 + C_{10}) \ell^{-1} \left( |\nabla u|^{p-1} + u^{p-1} \right) + (1 + C_{10}) \ell^{-1} a_{2} + a_{3} \mathrm{d}\vartheta \\ &\leqslant C_{11}(n,\mu) \sum_{i=1}^{N_{*}} \int_{\frac{3}{2}Q_{i}} \ell^{-1} \left( |\nabla u|^{p} + 1 \right) + \ell^{-1} \left( u^{p} + 1 \right) + \ell^{-1} a_{2} + a_{3} \mathrm{d}\vartheta \\ &= C_{11} \int_{E_{3\ell\sqrt{n}}} \ell^{-1} \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) |\nabla u|^{p} + \ell^{-1} \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) u^{p} \mathrm{d}\vartheta \\ &+ C_{11} \int_{E_{3\ell\sqrt{n}}} \ell^{-1} \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) + \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) \mathrm{d}\vartheta \\ &+ C_{11} \int_{E_{3\ell\sqrt{n}}} \ell^{-1} \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) a_{2} + \left( \sum_{i=1}^{N_{*}} \chi_{\frac{3}{2}Q_{i}} \right) a_{3} \mathrm{d}\vartheta. \end{split} \tag{3.18}$$

Here  $\chi_{\frac{3}{2}Q_i}$  is the characteristic function of  $\frac{3}{2}Q_i$ ,  $i=1,\ldots,N_*$ . For each cube  $Q_i$ ,  $i=1,\ldots,N_*$ , there are at most  $3^n$  cubes  $Q_j$ ,  $\ell(Q_j)=\ell$ ,  $j=1,\ldots,N_i\leqslant 3^n$  (adjacent cubes to  $Q_i$  with equal length), such that  $\frac{3}{2}Q_i\cap\frac{3}{2}Q_j\neq\emptyset$ . Then

$$\sum_{i=1}^{N_*} \chi_{\frac{3}{2}Q_i} \leqslant 3^n \quad \text{on } E_{3\ell\sqrt{n}}. \tag{3.19}$$

By (3.18), (3.19), (3.15), (3.13), (3.12), (2.1) and (3.14), we have

$$\begin{split} &\int_{\Omega} \left\langle A(\cdot,u,\nabla u),\nabla\varphi\right\rangle + B(\cdot,u)\varphi \mathrm{d}x \leqslant (C_7 + C_2)C_{11}\ell^{-1}3^n(3\ell\sqrt{n})\varepsilon^{\gamma_1} + C_{12}\ell^{-1}3^n(3\ell\sqrt{n})^{n-\alpha^+}\varepsilon \\ &+ C_{11}\ell^{-1}3^n2(3\ell\sqrt{n})^{(n-\alpha^+)\left(\frac{q_2^--1}{q_2^-}\right)} \left\|a_2\right\|_{L^{q_2(\cdot)}(\Omega,\vartheta)}\varepsilon^{\gamma_1} + C_{11}3^n2(3\ell\sqrt{n})^{(n-\alpha^+)\left(\frac{q_3^--1}{q_3^-}\right)} \left\|a_3\right\|_{L^{q_3(\cdot)}(\Omega,\vartheta)}\varepsilon^{\gamma_1} \\ &\leqslant C_{13}\varepsilon^{\gamma_1}, \end{split}$$

where  $C_{12}$ ,  $C_{13}$  are positive constants independents of  $\varepsilon$ . Since  $\varepsilon \in (0,1)$  was arbitrary, it follows that

$$\int_{\Omega} \langle A(\cdot, u, \nabla u), \nabla \varphi \rangle + B(\cdot, u) \varphi dx \leq 0.$$

This completes the proof of Theorem 3.1.

3.2. Singular set satisfying  $\mathcal{L}_{\alpha,\gamma,\vartheta}(E)=0$ . In this section we will work with nonlinear elliptic equations of the form

$$-\operatorname{div} A\left(x,\nabla u\right) = 0. \tag{3.20}$$

We assume that  $A: \Omega \times \mathbb{R}^n \to \mathbb{R}^n$  is a measurable function. Furthermore, there exists  $\mu > 0$  such that the following conditions are satisfied almost everywhere:

$$\langle A(x,\eta), \eta \rangle \geqslant \mu |\eta|^{p(x)} \vartheta(x),$$
 (3.21)

$$|A(x,\eta)| \le \mu^{-1} |\eta|^{p(x)-1} \vartheta(x),$$
 (3.22)

where  $\vartheta \in W_p(\Omega)$ ,  $\alpha, \tau : \Omega \to [0, n]$  are measurable functions, and  $p \in L^{\infty}_+(\Omega)$ . Moreover,

$$\tau \leqslant n - \alpha - p^{+} - p^{+}/p^{-} \quad a.e. \text{ on } \Omega.$$
(3.23)

**Definition 3.4.** We will say that  $u \in W_{E,\text{loc}}^{1,p(\cdot)}(\Omega,\vartheta)$  is a (weak) sub-solution of equation (3.20) in  $\Omega \setminus E$  if

$$\int_{\Omega \setminus E} \langle A(\cdot, \nabla u), \nabla \varphi \rangle \, \mathrm{d}x \leqslant 0 \tag{3.24}$$

for all  $\varphi \in W^{1,p(\cdot)}(\Omega, \vartheta)$ ,  $\varphi \geqslant 0$ , with compact support in  $\Omega \backslash E$ .

**Definition 3.5.** We will say that the sub-solution u of equation (3.20) in  $\Omega \setminus E$  has a removable singularity at E: if  $u \in W_{E,\text{loc}}^{1,p(\cdot)}(\Omega,\vartheta)$  implies  $u \in W_{\text{loc}}^{1,p(\cdot)}(\Omega,\vartheta)$  and the equality (3.24) is fulfilled for all  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$ ,  $\varphi \geqslant 0$ , with compact support.

**Lemma 3.1.** Suppose that there is a locally bounded function  $\sigma: \Omega \times \Omega \to (0, \infty)$  such that

$$\int_{Q(y,\ell)} \ell^{-\tau} d\vartheta \leqslant \sigma(y,z) \int_{Q(z,\ell)} \ell^{-\tau} d\vartheta, \tag{3.25}$$

for all adjacent dyadic cubes  $Q(y,\ell), Q(z,\ell) \subset \Omega$ . If  $K \subset \Omega$  is a compact set, then

$$\int_{\frac{3}{2}Q(y,\ell)} \ell^{-\tau} d\vartheta \leqslant C(n,\sigma,K) \int_{Q(z,\ell)} \ell^{-\tau} d\vartheta, \tag{3.26}$$

$$\int_{B(y,\ell)} \ell^{-\tau} d\vartheta \leqslant C(n,\sigma,K) \int_{Q(y,\ell)} \ell^{-\tau} d\vartheta, \tag{3.27}$$

where y = z or  $Q(y, \ell), Q(z, \ell) \subset \Omega$  are adjacent dyadic cubes, with  $y, z \in K$  and  $\ell \sqrt{n} < d(K, \partial \Omega)$ .

**Lemma 3.2.** Assume that (3.21) - (3.23), (3.25) are satisfied, and  $\mathcal{L}_{\alpha,\gamma,\vartheta}(E) = 0$  for some  $\gamma \in (0,1/p^+]$ . If u is a non-negative sub-solution of (3.20) in  $\Omega \setminus E$  and satisfies

$$\int_{B(y,r)} u^p d\vartheta \leqslant C_* \int_{B(y,r/\sqrt{n})} r^{-\tau} d\vartheta, \tag{3.28}$$

for all ball  $B(y,r) \subset\subset \Omega$ , where  $C_*$  is a suitable positive constant. Then

$$\min \left\{ \left( \int_{B(y,r_1)} |\widetilde{\nabla u}|^p d\vartheta \right)^{\frac{1}{p^-}}, \left( \int_{B(y,r_1)} |\widetilde{\nabla u}|^p d\vartheta \right)^{\frac{1}{p^+}} \right\} \\
\leqslant C_0 \max \left\{ \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} d\vartheta \right]^{\frac{1}{p^-}}, \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} d\vartheta \right]^{\frac{1}{p^+}} \right\}$$
(3.29)

for all ball  $B(y, r_2) \subset\subset \Omega$  with  $0 < r_2 - r_1 < 1$ , where  $C_0 = C_0(n, \mu, p, \sigma, E, C_*) > 0$ .

*Proof.* 1. Let  $r_2 > r_1 > 0$  and  $y \in \Omega$  be such that  $\overline{B(y,r_2)} \subset \Omega$  and  $r_2 - r_1 < 1$ . Choose  $r_0 \in (0,1)$  such that  $\overline{E_{r_0}} \subset \Omega$ . Take  $\varepsilon \in (0,r_0)$  be arbitrarily. Since  $\mathcal{L}_{\alpha,\gamma,\vartheta}(E) = 0$  there is a finite collection of mutually disjoint dyadic cubes  $Q_i = Q(y_i,\ell_i)$  so that  $E \subset \operatorname{int} \left( \bigcup_{i=1}^N Q_i, \right)$ ,

$$\sum_{i=1}^{N} \left( \int_{Q_i} \ell_i^{\alpha - n} \mathrm{d}\vartheta \right)^{\gamma} < \varepsilon, \tag{3.30}$$

 $3\ell_i\sqrt{n}<\varepsilon$  and  $Q_i\cap E\neq\emptyset$ ,  $i=1,\ldots,N$ .

Now, we attach to each cube  $Q_i$ ,  $\ell(Q_i) = \ell_i$ , i = 1, ..., N, all adjacent dyadic cubes with the same length  $\ell_i$ . Since two dyadic cubes are either mutually disjoint or one is contained in the other, we may drop extra cubes away. Proceeding in this way we get a collection of mutually disjoint cubes  $Q_{j,k} = Q(y_{j,k}, \ell_{j,k})$ ,  $(j,k) \in \{1, ..., N_1\} \times \{1, ..., m_j\}$  satisfying

$$\ell_{j,k} = \ell_{a_j}, \quad j = 1, \dots, N_1 \leqslant N, \quad k = 1, \dots, m_j \leqslant 3^n,$$
 (3.31)

where  $\{1 \leqslant a_1 < \cdots < a_{N_1} \leqslant N\} \subset \mathbb{Z}$ , and furthermore  $Q_{j,k}$  is adjacent to  $Q_{a_j}$ . Additionally, by (3.28) and (3.26),

$$\int_{\frac{3}{2}Q_{j,k}} u^p d\vartheta \leqslant C_1 \int_{Q_{a_j}} \ell_{a_j}^{-\tau} d\vartheta, \tag{3.32}$$

 $j = 1, ..., N_1, k = 1, ..., m_j$ , for some constant  $C_1 = C_1(n, \sigma, E_{2r_0/3}, C_*) > 0$ .

2. We next choose non-negative test functions  $\varphi_i$ ,  $\varphi_{j,k}$ ,  $i=1,\ldots,N,$   $j=1,\ldots,N_1$ ,  $k=1,\ldots,m_j$ , given by the Lemma 2.1, with the following properties:

$$\operatorname{spt} \varphi_i \subset \frac{3}{2} Q_i, \quad |\nabla \varphi_i| \leqslant C_2(n) \ell_i^{-1}, \tag{3.33}$$

$$\operatorname{spt} \varphi_{j,k} \subset \frac{3}{2} Q_{j,k}, \quad |\nabla \varphi_{j,k}| \leqslant C_2(n) \ell_{j,k}^{-1}, \tag{3.34}$$

$$\sum_{i} \varphi_i + \sum_{j,k} \varphi_{j,k} = 1 \quad \text{ on } (\cup_i Q_i) \cup (\cup_{j,k} Q_{j,k}). \tag{3.35}$$

Let  $\psi_0 : \mathbb{R}^n \to \mathbb{R}$  be a smooth function with spt  $\psi_0 \subset B(y, r_2)$ ,  $0 \leqslant \psi_0 \leqslant 1$ ,  $|\nabla \psi_0| \leqslant C_3(n)(r_2 - r_1)^{-1}$ , and  $\psi = 1$  on  $B(y, r_1)$ . Write

$$\xi = \psi_0 \left[ 1 - \left( \sum_i \varphi_i + \sum_{j,k} \varphi_{j,k} \right) \right].$$

Substituting  $\xi^{p^+}u$  into (3.24), we see

$$\int_{\Omega \setminus E} \left\langle A(\cdot, \nabla u), \nabla \left( \xi^{p^{+}} u \right) \right\rangle \mathrm{d}x \leqslant 0,$$

$$\int_{\Omega \setminus E} \xi^{p^{+}} \left\langle A(\cdot, \nabla u), \nabla u \right\rangle \mathrm{d}x \leqslant \int_{\Omega \setminus E} p^{+} \xi^{p^{+} - 1} |u A(\cdot, \nabla u)| |\nabla \xi| \mathrm{d}x.$$

Then, by (3.21), (3.22), (2.1) and (2.2),

$$\begin{split} &\int_{\Omega \setminus E} \xi^{p^{+}} |\nabla u|^{p} \mathrm{d}\vartheta \leqslant \mu^{-2} \int_{\Omega \setminus E} p^{+} \xi^{p^{+}-1} |\nabla \xi| |\nabla u|^{p-1} u \mathrm{d}\vartheta \\ &\leqslant 2\mu^{-2} p^{+} \left\| \xi^{p^{+}-1} |\nabla u|^{p-1} \vartheta^{\frac{p-1}{p}} \right\|_{L^{\frac{p}{p-1}(\cdot)}(\Omega \setminus E)} \left\| |\nabla \xi| u \vartheta^{\frac{1}{p}} \right\|_{L^{p(\cdot)}(\Omega)} \\ &\leqslant 2\mu^{-2} p^{+} \max \left\{ \left( \int_{\Omega \setminus E} \xi^{p^{+}} |\nabla u|^{p} \mathrm{d}\vartheta \right)^{\left(\frac{p-1}{p}\right)^{+}}, \left( \int_{\Omega \setminus E} \xi^{p^{+}} |\nabla u|^{p} \mathrm{d}\vartheta \right)^{\left(\frac{p-1}{p}\right)^{-}} \right\} \\ &\cdot \left[ \sum_{i} \left\| |\nabla \varphi_{i}| u \vartheta^{\frac{1}{p}} \right\|_{L^{p(\cdot)}\left(\frac{3}{2}Q_{i}\right)} + \sum_{j,k} \left\| |\nabla \varphi_{j,k}| u \vartheta^{\frac{1}{p}} \right\|_{L^{p(\cdot)}\left(\frac{3}{2}Q_{j,k}\right)} + \left\| |\nabla \psi_{0}| u \vartheta^{\frac{1}{p}} \right\|_{L^{p(\cdot)}(B(y,r_{2}))} \right]. \end{split}$$

Consequently, using (2.2), (3.28), (3.26), (3.32), (3.23) and (3.30), we compute

$$\begin{split} & \min \left\{ \left( \int_{\Omega \backslash E} \xi^{p^+} |\nabla u|^p \mathrm{d}\vartheta \right)^{1 - \left(\frac{p-1}{p}\right)^+}, \left( \int_{\Omega \backslash E} \xi^{p^+} |\nabla u|^p \mathrm{d}\vartheta \right)^{1 - \left(\frac{p-1}{p}\right)^-} \right\} \\ & \leqslant C_4(n,\mu,p) \max \left\{ \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2)} u^p \mathrm{d}\vartheta \right]^{\frac{1}{p^-}}, \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2)} u^p \mathrm{d}\vartheta \right]^{\frac{1}{p^+}} \right\} \\ & + C_4 \sum_i \max \left\{ \left( \ell_i^{-p^+} \int_{\frac{3}{2}Q_i} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \ell_i^{-p^+} \int_{\frac{3}{2}Q_j} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\} \\ & + C_4 \sum_{j,k} \max \left\{ \left( \ell_{j,k}^{-p^+} \int_{\frac{3}{2}Q_{j,k}} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \ell_{j,k}^{-p^+} \int_{\frac{3}{2}Q_{j,k}} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\} \\ & \leqslant C_5 \max \left\{ \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^-}}, \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^+}} \right\} + C_6 \varepsilon, \end{split}$$

where  $C_5 = C_5(n, \mu, p, \sigma, E_{2r_0/3}, C_*) > 0$  and  $C_6 > 0$  is independent of  $\varepsilon$ . Hence,

$$\begin{split} & \min \left\{ \left( \int_{\Omega \backslash E} \xi^{p^+} |\nabla u|^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \int_{\Omega \backslash E} \xi^{p^+} |\nabla u|^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\} \\ & \leqslant C_5 \max \left\{ \left[ (r_2 - r_1)^{-p^+} \int_{B(y, r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^-}}, \left[ (r_2 - r_1)^{-p^+} \int_{B(y, r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^+}} \right\} + C_6 \varepsilon. \end{split}$$

Since  $\varepsilon \in (0,1)$  was arbitrary:

$$\min \left\{ \left( \int_{B(y,r_1)} |\widetilde{\nabla u}|^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \int_{B(y,r_1)} |\widetilde{\nabla u}|^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\}$$

$$\leq C_5 \max \left\{ \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^-}}, \left[ (r_2 - r_1)^{-p^+} \int_{B(y,r_2/\sqrt{n})} r_2^{-\tau} \mathrm{d}\vartheta \right]^{\frac{1}{p^+}} \right\}.$$

Therefore, we conclude (3.29).

Motivated by Theorem B we have our last result.

**Theorem 3.2.** Assume that (3.21) - (3.23), (3.25) and (3.28) are satisfied, furthermore  $\mathcal{L}_{\alpha,\gamma,\vartheta}(E) = 0$  for some  $\gamma \in (0,1/p^+]$ . If u is a non-negative sub-solution of (3.20) in  $\Omega \setminus E$ , then the singularity of u at E is removable.

*Proof.* 1. Let  $\varphi \in W^{1,p(\cdot)}(\Omega,\vartheta)$  be with compact support. By Assumption 2.1 we can suppose that  $\varphi \in C^{\infty}(\Omega)$  and  $|\nabla \varphi| \leq 1$ . Write  $K = \operatorname{spt} \varphi$ , choose  $r_0 \in (0,1)$  such that  $\overline{K_{r_0}} \subset \Omega$ . Let  $\varepsilon \in (0,r_0)$  be arbitrarily given. Since  $\mathcal{L}_{\alpha,\gamma,\vartheta}(E) = 0$ , there is a finite collection of mutually disjoint dyadic cubes  $Q_i(y_i,\ell_i)$ ,  $3\sqrt{n}\ell_i < \varepsilon$ ,  $i=1,\ldots,N$ , so that  $E \subset \operatorname{int} \left( \bigcup_{i=1}^N Q_i \right)$  and

$$\sum_{i=1}^{N} \left( \int_{Q_i} \ell_i^{\alpha - n} d\vartheta \right)^{\gamma} < \varepsilon. \tag{3.36}$$

We will cover K by a suitable collection of mutually disjoint dyadic cubes:

We attach to each cube  $Q_i$ ,  $\ell(Q_i) = \ell_i$ , i = 1, ..., N, all adjacent dyadic cubes with the same length  $\ell_i$ . Since two dyadic cubes are either mutually disjoint or one is contained in the other, we may drop extra cubes away. Proceeding in this way we get a collection of mutually disjoint cubes  $Q_{j,k} = Q(y_{j,k}, \ell_{j,k})$ ,  $(j,k) \in \{1, ..., N_1\} \times \{1, ..., m_j\}$  satisfying

$$\ell_{j,k} = \ell_{a_j}, \quad j = 1, \dots, N_1 \leqslant N, \quad k = 1, \dots, m_j \leqslant 3^n,$$
 (3.37)

where  $\{1 \leqslant a_1 < \cdots < a_{N_1} \leqslant N\} \subset \mathbb{Z}$ , and furthermore  $Q_{j,k}$  is adjacent to  $Q_{a_j}$ .

Finally, we cover the remaining set  $K \setminus [(\cup_i Q_i) \cup (\cup_{j,k} Q_{j,k})]$  by mutually disjoint dyadic cubes  $\widetilde{Q}_h$ , all with the same length  $\ell\left(\widetilde{Q}_h\right) = \ell_0$ ,  $h = 1, \ldots, N_2$ , where  $\ell_0 = \min\left\{\ell_i \mid i = 1, \ldots, N\right\}$ . We see

$$\frac{3}{2}\widetilde{Q}_h \cap E = \emptyset \quad \text{ for } h = 1, \dots, N_2.$$

2. From (3.29) we have  $|\widetilde{\nabla u}| \in L^{p(\cdot)}_{\mathrm{loc}}(\Omega, \vartheta)$ . We claim  $u \in W^{1,p(\cdot)}_{\mathrm{loc}}(\Omega, \vartheta)$ . To verify this assertion, let  $\psi_i, \psi_{j,k}, i=1,\ldots,N, j=1,\ldots,N_1, k=1,\ldots,m_j$  be non-negative test functions given by the Lemma 2.1, satisfying

$$\operatorname{spt} \psi_{i} \subset \frac{3}{2}Q_{i}, \quad |\nabla \psi_{i}| \leqslant C_{1}(n)\ell_{i}^{-1},$$

$$\operatorname{spt} \psi_{j,k} \subset \frac{3}{2}Q_{j,k}, \quad |\nabla \psi_{j,k}| \leqslant C_{1}(n)\ell_{j,k}^{-1},$$

$$\sum_{i} \psi_{i} + \sum_{j,k} \psi_{j,k} = 1 \quad \text{on } (\cup_{i}Q_{i}) \cup (\cup_{j,k}Q_{j,k}).$$

Write

$$\zeta = \sum_{i} \psi_i + \sum_{j,k} \psi_{j,k}.$$

We have

$$\int_{\Omega \backslash E} u \left[ \left( 1 - \zeta \right) \varphi \right]_{x_b} \mathrm{d}x = - \int_{\Omega \backslash E} u_{x_b} \left( 1 - \zeta \right) \varphi \mathrm{d}x,$$

where  $b = 1, \ldots, n$ . If  $\varepsilon \to 0^+$ :

$$\int_{\Omega} u\varphi_{x_b} \mathrm{d}x = -\int_{\Omega} u_{x_b} \varphi \mathrm{d}x. \tag{3.38}$$

Indeed, (2.1), (2.2), (3.28), (3.26), (3.23) and (3.36) implies

$$\begin{split} & \left| \int_{\Omega \setminus E} u \zeta_{x_b} \varphi \mathrm{d}x \right| \leqslant 2 \left\| u \zeta_{x_b} \vartheta^{1/p} \right\|_{L^{p(\cdot)}(\Omega)} \left\| \vartheta^{-1/p} \right\|_{L^{p'(\cdot)}(\Omega)} \\ & \leqslant C_2(\vartheta) \sum_i \left\| u \left| \nabla \psi_i \right| \vartheta^{1/p} \right\|_{L^{p(\cdot)}\left(\frac{3}{2}Q_i\right)} + C_2 \sum_{j,k} \left\| u \left| \nabla \psi_{j,k} \right| \vartheta^{1/p} \right\|_{L^{p(\cdot)}\left(\frac{3}{2}Q_{j,k}\right)} \\ & \leqslant C_3(\vartheta, n) \sum_i \max \left\{ \left( \ell_i^{-p^+} \int_{\frac{3}{2}Q_i} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \ell_i^{-p^+} \int_{\frac{3}{2}Q_i} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\} \\ & + C_3 \sum_{j,k} \max \left\{ \left( \ell_{j,k}^{-p^+} \int_{\frac{3}{2}Q_{j,k}} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^-}}, \left( \ell_{j,k}^{-p^+} \int_{\frac{3}{2}Q_{j,k}} u^p \mathrm{d}\vartheta \right)^{\frac{1}{p^+}} \right\} \\ & \leqslant C_4(\vartheta, n, \sigma, K) \varepsilon \to 0 \quad \text{as } \varepsilon \to 0^+. \end{split}$$

So (3.38) is proved.

3. Additionally we assume that  $0 \leqslant \varphi \leqslant 1$ . We show

$$\int_{\Omega} \langle A(\cdot, \nabla u), \nabla \varphi \rangle \, \mathrm{d}x \leqslant 0.$$

We next choose non-negative test functions  $\varphi_i$ ,  $\varphi_{j,k}$ ,  $\widetilde{\varphi}_h$ ,  $i=1,\ldots N$ ,  $j=1,\ldots N_1$ ,  $k=1,\ldots,m_j$ ,  $h=1,\ldots,N_2$ , given by the Lemma 2.1, with the following properties:

$$\operatorname{spt} \varphi_{i} \subset \frac{3}{2} Q_{i}, \quad |\nabla \varphi_{i}| \leqslant C_{5}(n) \ell_{i}^{-1},$$

$$\operatorname{spt} \varphi_{j,k} \subset \frac{3}{2} Q_{j,k}, \quad |\nabla \varphi_{j,k}| \leqslant C_{5}(n) \ell_{j,k}^{-1},$$

$$\operatorname{spt} \widetilde{\varphi}_{h} \subset \frac{3}{2} \widetilde{Q}_{h}, \quad |\nabla \widetilde{\varphi}_{h}| \leqslant C_{5}(n) \ell_{0}^{-1},$$

$$\sum_{i} \varphi_{i} + \sum_{j,k} \varphi_{j,k} + \sum_{h} \widetilde{\varphi}_{h} = 1 \quad \text{on } K.$$

Write

$$\xi = \sum_{i} \varphi_{i} + \sum_{j,k} \varphi_{j,k} + \sum_{h} \widetilde{\varphi}_{h}.$$

Since  $\frac{3}{2}\widetilde{Q}_h \cap E = \emptyset$  and  $\operatorname{spt} \widetilde{\varphi}_h \subset \frac{3}{2}\widetilde{Q}_h$ , substituting  $\varphi \widetilde{\varphi}_h$  into (3.24), we have

$$\int_{\frac{3}{2}\widetilde{Q}_{h}} \langle A(\cdot, \nabla u), \nabla(\varphi \widetilde{\varphi}_{h}) \rangle \, \mathrm{d}x \leqslant 0,$$

for  $h = 1, \ldots, N_2$ . From this,

$$\int_{\Omega} \langle A(\cdot, \nabla u), \nabla \varphi \rangle \, \mathrm{d}x = \int_{\Omega} \langle A(\cdot, \nabla u), \nabla(\varphi \xi) \rangle \, \mathrm{d}x$$

$$\leq \sum_{i} \int_{\frac{3}{2}Q_{i}} \langle A(\cdot, \nabla u), \nabla(\varphi \varphi_{i}) \rangle \, \mathrm{d}x + \sum_{j,k} \int_{\frac{3}{2}Q_{j,k}} \langle A(\cdot, \nabla u), \nabla(\varphi \varphi_{j,k}) \rangle \, \mathrm{d}x. \tag{3.39}$$

We can assume that  $\int_{E_{r_0}} |\nabla u|^p d\vartheta < 1$ , since |E| = 0. By (3.39), (3.22), (3.26), (3.29) and (3.36),

$$\int_{\Omega} \left\langle A\left(\cdot,\nabla u\right),\nabla\varphi\right\rangle dx \leqslant C_{6} \sum_{i} \int_{\frac{3}{2}Q_{i}} \ell_{i}^{-1} \left(\left|\nabla u\right|^{p}+1\right) d\vartheta + C_{6} \sum_{j,k} \int_{\frac{3}{2}Q_{j,k}} \ell_{j,k}^{-1} \left(\left|\nabla u\right|^{p}+1\right) d\vartheta \right. \\
\leqslant C_{7}\varepsilon + C_{6} \sum_{i} \int_{B\left(y_{i},3\sqrt{n}\ell_{i}/4\right)} \ell_{i}^{-1} \left|\nabla u\right|^{p} d\vartheta + C_{6} \sum_{j,k} \int_{B\left(y_{j,k},3\sqrt{n}\ell_{j,k}/4\right)} \ell_{j,k}^{-1} \left|\nabla u\right|^{p} d\vartheta \\
\leqslant C_{7}\varepsilon + C_{8} \sum_{i} \ell_{i}^{-1} \max \left\{ \left[ \left(\sqrt{n}\ell_{i} - \frac{3\sqrt{n}\ell_{i}}{4}\right)^{-p^{+}} \int_{B\left(y_{i},\ell_{i}\right)} \left(\sqrt{n}\ell_{i}\right)^{-\tau} d\vartheta \right] \right\} \\
+ \left[ \left(\sqrt{n}\ell_{i} - \frac{3\sqrt{n}\ell_{i}}{4}\right)^{-p^{+}} \int_{B\left(y_{i},\ell_{i}\right)} \left(\sqrt{n}\ell_{j}\right)^{-\tau} d\vartheta \right] \right]^{\frac{p^{-}}{p^{+}}} \\
+ C_{8} \sum_{j,k} \ell_{j,k}^{-1} \max \left\{ \left[ \left(\sqrt{n}\ell_{j,k} - \frac{3\sqrt{n}\ell_{j,k}}{4}\right)^{-p^{+}} \int_{B\left(y_{j,k},\ell_{j,k}\right)} \left(\sqrt{n}\ell_{j,k}\right)^{-\tau} d\vartheta \right] \right\} \\
+ \left[ \left(\sqrt{n}\ell_{j,k} - \frac{3\sqrt{n}\ell_{j,k}}{4}\right)^{-p^{+}} \int_{B\left(y_{j,k},\ell_{j,k}\right)} \left(\sqrt{n}\ell_{j,k}\right)^{-\tau} d\vartheta \right]^{\frac{p^{-}}{p^{+}}} \right\}. \tag{3.40}$$

Combining (3.40), (3.27), (3.23) and (3.36), we deduce that

$$\int_{\Omega} \langle A(\cdot, \nabla u), \nabla \varphi \rangle \, \mathrm{d}x \leqslant C_9 \varepsilon,$$

here the  $C_i$ ,  $i=6,\ldots,9$  are positive constants independents of  $\varepsilon$ . Since  $\varepsilon\in(0,r_0)$  was arbitrary, the proof is complete.
