# BSDEs driven by $G$-Brownian motion under degenerate case and its application to the regularity of fully nonlinear PDEs

#### Abstract

In this paper, we obtain the existence and uniqueness theorem for backward stochastic differential equation driven by $G$-Brownian motion ( $G$-BSDE) under degenerate case. Moreover, we propose a new probabilistic method based on the representation theorem of $G$-expectation and weak convergence to obtain the regularity of fully nonlinear PDE associated to $G$-BSDE.

Key words. $G$-expectation; $G$-Brownian motion; Backward stochastic differential equation; Fully nonlinear PDE

## 1 Introduction

Motivated by volatility uncertainty in finance, Peng 18 21] introduced the notions of $G$-expectation $\hat{\mathbb{E}}[\cdot]$ and $G$-Brownian motion $B$ for each monotone and sublinear function $G: \mathbb{S}_{d} \rightarrow \mathbb{R}$. The Ito's calculus with respect to $G$-Brownian motion was constructed. Furthermore, he studied stochastic differential equation driven by $G$-Brownian motion ( $G$-SDE) and a special type of backward stochastic differential equation (BSDE) containing only the solution $Y$, and then established the relevant theory. Denis et al. [2] (see also [10]) obtained that the $G$-expectation can be represented as an upper expectation over a family of weakly compact and non-dominated probability measures $\mathcal{P}$, and gave the characterizations of some spaces by inner capacity associated to $\mathcal{P}$. By quasi-surely stochastic analysis based on outer capacity, Denis and Martini [3] made a great contribution to study super-pricing of contingent claims under volatility uncertainty. The relationship between these two capacities has been clearly explained in notes and comments of Chapter 6 in 22].

[^0]Hu et al. [7] studied the following BSDE driven by $G$-Brownian motion ( $G$-BSDE)

\begin{equation*}
Y_{t}=\xi+\int_{t}^{T} f\left(s, Y_{s}, Z_{s}\right) d s+\int_{t}^{T} g\left(s, Y_{s}, Z_{s}\right) d\langle B\rangle_{s}-\int_{t}^{T} Z_{s} d B_{s}-\left(K_{T}-K_{t}\right) \tag{1.1}
\end{equation*}
$$

under the non-degenerate $G$, i.e., there exists a constant $\underline{\sigma}^{2}>0$ such that

$$
G(A)-G(B) \geq \frac{1}{2} \underline{\sigma}^{2} \operatorname{tr}[A-B] \text { for } A \geq B
$$

They proved that the above $G$-BSDE has a unique solution $(Y, Z, K)$, where $K$ is a non-increasing $G$ martingale with $K_{0}=0$. Soner et al. 25] studied a new type of fully nonlinear BSDE, called 2BSDE, by different formulation and method, and obtained the deep result of the existence and uniqueness theorem for 2BSDE. For recent advances in these two directions, the reader may refer to [4, 6, 12, 14, 16, 23] and the references therein.

The key step to obtain the solution of $G$-BSDE (1.1) under non-degenerate $G$ is to use Krylov's regularity estimate for fully nonlinear PDEs (see Appendix C. 4 in [22]). But under degenerate $G$, we have to get round the difficulty that the regularity estimation condition (see Definition C.4.3 in [22]) is not satisfied. A natural idea is to construct a family of non-degenerate $G_{\varepsilon}$ with $\varepsilon \in\left(0, \varepsilon_{0}\right]$ such that $G_{\varepsilon} \uparrow G$ as $\varepsilon \downarrow 0$. The corresponding $G_{\varepsilon}$-expectation and the set of probability measures are denoted by $\hat{\mathbb{E}}^{\varepsilon}[\cdot]$ and $\mathcal{P}^{\varepsilon}$, respectively. By the definition of $G$-expectation, we know that $\hat{\mathbb{E}}^{\varepsilon}[X] \uparrow \hat{\mathbb{E}}[X]$ for $X \in L_{G}^{1}\left(\Omega_{T}\right)$ and $\mathcal{P}$ is the closure of $\mathcal{P}_{1}:=\cup_{\varepsilon>0} \mathcal{P}^{\varepsilon}$ under the topology of weak convergece. It is important to note that the quasi-surely stochastic analysis with respect to $\mathcal{P}$ (i.e. $\mathcal{P}$-q.s.) and $\mathcal{P}_{1}$ (i.e. $\mathcal{P}_{1}$-q.s.) are different (see 11]). Following the method proposed in the proof of Proposition A.1. in [24], we can get a process $Z$ in the $\mathcal{P}_{1}$-q.s. sence such that

\inf _{\eta \in M^{0}(0, T)} \hat{\mathbb{E}}^{\varepsilon}\left[\left(\int_{0}^{T}\left|Z_{s}-\eta_{s}\right|^{2} d\langle B\rangle_{s}\right)^{p / 2}\right]=0 \text { for } \varepsilon>0, p>1,
$$

where the definition of $M^{0}(0, T)$ can be found in Section 3. At this point, there is a natural misconception that $Z \in H_{G}^{2, p}(0, T ;\langle B\rangle)$ holds. But we notice Sion's minimax theorem can not be used to obtain

\inf _{\eta \in M^{0}(0, T)} \sup _{\varepsilon \in\left(0, \varepsilon_{0}\right]} \hat{\mathbb{E}}^{\varepsilon}\left[\left(\int_{0}^{T}\left|Z_{s}-\eta_{s}\right|^{2} d\langle B\rangle_{s}\right)^{p / 2}\right]=\sup _{\varepsilon \in\left(0, \varepsilon_{0}\right]} \inf _{\eta \in M^{0}(0, T)} \hat{\mathbb{E}}^{\varepsilon}\left[\left(\int_{0}^{T}\left|Z_{s}-\eta_{s}\right|^{2} d\langle B\rangle_{s}\right)^{p / 2}\right],
$$

because $\left(0, \varepsilon_{0}\right]$ is not compact. Therefore, whether $Z$ belongs to $H_{G}^{2, p}(0, T ;\langle B\rangle)$ remains unsolved, even for $G$-martingale representation theorem, which is a special case of $G$-BSDE (1.1), i.e., $f=g=0$. Thus, one purpose of this paper is to investigate the existence and uniqueness theorem for $G$-BSDE (1.1) under degenerate $G$.

It is well known that the theory of classical BSDEs provides a tool to study the regularity of quasilinear PDEs (see [17]). However, we all know that this classical tool is not suitable for the regularity of fully nonlinear PDEs, and up to our knowledge there is no result on this field. So, the other purpose of this paper is to establish the regularity of fully nonlinear PDEs by $G$-BSDEs.

In this paper, we introduce a quite different method to study the existence and uniqueness theorem for a type of well-posed $G$-BSDEs under degenerate $G$ (see (3.4)), which has two major contributions. The first one is to obtain the soution $(Y, Z, K)$ for $G$-BSDE under degenerate $G$ in the extended $\tilde{G}$-expectation space,
which is essential to show that $K$ is a $G$-martingale in the key Lemma 3.8. The second one is to propose a new probabilistic method based on the representation theorem of $G$-expectation and weak convergence to obtain the uniform lower bound for $\partial_{x x}^{2} u_{\varepsilon}$ with $\varepsilon>0$, where $u_{\varepsilon}$ is a soution to a fully nonlinear PDE associated to a $G_{\varepsilon}$-BSDE under non-degenerate $G_{\varepsilon}$ (see (3.17) and (3.31). This uniform lower bound for $\partial_{x x}^{2} u_{\varepsilon}$ plays a key role in proving $Z \in H_{G}^{2, p}(0, T ;\langle B\rangle)$ in Lemma 3.8, and up to our knowledge, it is completely new in the literature because it does not depend on $\varepsilon$ as the bound by Krylov's regularity estimate for fully nonlinear PDEs. Finally, we use the above probabilistic method to obtain the regularity of fully nonlinear PDE associated to $G$-BSDE under degenerate $G$.

The paper is organized as follows. In Section 2, we present some basic results of $G$-expectations. The existence and uniqueness theorem for $G$-BSDE under degenerate case is established in Section 3. In Section 4, we obtain the regularity of fully nonlinear PDE associated to $G$-BSDE under degenerate $G$.

## 2 Preliminaries

We recall some basic results of $G$-expectations. The readers may refer to Peng's book [22] for more details.
Let $T>0$ be given and let $\Omega_{T}=C_{0}\left([0, T] ; \mathbb{R}^{d}\right)$ be the space of $\mathbb{R}^{d}$-valued continuous functions on $[0, T]$ with $\omega_{0}=0$. The canonical process $B_{t}(\omega):=\omega_{t}$, for $\omega \in \Omega_{T}$ and $t \in[0, T]$. For any fixed $t \leq T$, set

\operatorname{Lip}\left(\Omega_{t}\right):=\left\{\varphi\left(B_{t_{1}}, B_{t_{2}}-B_{t_{1}}, \ldots, B_{t_{N}}-B_{t_{N-1}}\right): N \geq 1, t_{1}<\cdots<t_{N} \leq t, \varphi \in C_{b . L i p}\left(\mathbb{R}^{d \times N}\right)\right\}
$$

where $C_{b . L i p}\left(\mathbb{R}^{d \times N}\right)$ denotes the space of bounded Lipschitz functions on $\mathbb{R}^{d \times N}$.
Let $G: \mathbb{S}_{d} \rightarrow \mathbb{R}$ be a given monotonic and sublinear function, where $\mathbb{S}_{d}$ denotes the set of $d \times d$ symmetric matrices. Then there exists a unique bounded, convex and closed set $\Sigma \subset \mathbb{S}_{d}^{+}$such that

G(A)=\frac{1}{2} \sup _{\gamma \in \Sigma} \operatorname{tr}[A \gamma] \text { for } A \in \mathbb{S}_{d} \tag{2.1}
\end{equation*}
$$

where $\mathbb{S}_{d}^{+}$denotes the set of $d \times d$ nonnegative matrices. If there exists a $\underline{\sigma}^{2}>0$ such that $\gamma \geq \underline{\sigma}^{2} I_{d}$ for any $\gamma \in \Sigma, G$ is called non-degenerate. Otherwise, $G$ is called degenerate.

Peng [20, 21] constructed the $G$-expectation $\hat{\mathbb{E}}: \operatorname{Lip}\left(\Omega_{T}\right) \rightarrow \mathbb{R}$ and the conditional $G$-expectation $\hat{\mathbb{E}}_{t}$ : $\operatorname{Lip}\left(\Omega_{T}\right) \rightarrow \operatorname{Lip}\left(\Omega_{t}\right)$ as follows:
(i) For each $s_{1} \leq s_{2} \leq T$ and $\varphi \in C_{b . L i p}\left(\mathbb{R}^{d}\right)$, define $\hat{\mathbb{E}}\left[\varphi\left(B_{s_{2}}-B_{s_{1}}\right)\right]=u\left(s_{2}-s_{1}, 0\right)$, where $u$ is the viscosity solution (see [1]) of the following $G$-heat equation:

\partial_{t} u-G\left(D_{x}^{2} u\right)=0, u(0, x)=\varphi(x)
$$

(ii) For each $X=\varphi\left(B_{t_{1}}, B_{t_{2}}-B_{t_{1}}, \ldots, B_{t_{N}}-B_{t_{N-1}}\right) \in \operatorname{Lip}\left(\Omega_{T}\right)$, define

$$
\hat{\mathbb{E}}_{t_{i}}[X]=\varphi_{i}\left(B_{t_{1}}, \ldots, B_{t_{i}}-B_{t_{i-1}}\right) \text { for } i=N-1, \ldots, 1 \text { and } \hat{\mathbb{E}}[X]=\hat{\mathbb{E}}\left[\varphi_{1}\left(B_{t_{1}}\right)\right],
$$

where $\varphi_{N-1}\left(x_{1}, \ldots, x_{N-1}\right):=\hat{\mathbb{E}}\left[\varphi\left(x_{1}, \ldots, x_{N-1}, B_{t_{N}}-B_{t_{N-1}}\right)\right]$ for $\left(x_{1}, \ldots, x_{N-1}\right) \in \mathbb{R}^{d \times(N-1)}$ and

$$
\varphi_{i}\left(x_{1}, \ldots, x_{i}\right):=\hat{\mathbb{E}}\left[\varphi_{i+1}\left(x_{1}, \ldots, x_{i}, B_{t_{i+1}}-B_{t_{i}}\right)\right] \text { for } i=N-2, \ldots, 1
$$

The space $\left(\Omega_{T}, \operatorname{Lip}\left(\Omega_{T}\right), \hat{\mathbb{E}},\left(\hat{\mathbb{E}}_{t}\right)_{t \in[0, T]}\right)$ is a consistent sublinear expectation space, where $\hat{\mathbb{E}}_{0}=\hat{\mathbb{E}}$. The canonical process $\left(B_{t}\right)_{t \in[0, T]}$ is called the $G$-Brownian motion under $\hat{\mathbb{E}}$.

For each $t \in[0, T]$, denote by $L_{G}^{p}\left(\Omega_{t}\right)$ the completion of $\operatorname{Lip}\left(\Omega_{t}\right)$ under the norm $\|X\|_{L_{G}^{p}}:=\left(\hat{\mathbb{E}}\left[|X|^{p}\right]\right)^{1 / p}$ for $p \geq 1$. It is clear that $\hat{\mathbb{E}}_{t}$ can be continuously extended to $L_{G}^{1}\left(\Omega_{T}\right)$ under the norm $\|\cdot\|_{L_{G}^{1}}$.

The following theorem is the representation theorem of $G$-expectation.
Theorem 2.1 ([2), 10]) There exists a unique weakly compact and convex set of probability measures $\mathcal{P}$ on $\left(\Omega_{T}, \mathcal{B}\left(\Omega_{T}\right)\right)$ such that

$$
\hat{\mathbb{E}}[X]=\sup _{P \in \mathcal{P}} E_{P}[X] \text { for all } X \in L_{G}^{1}\left(\Omega_{T}\right)
$$

where $\mathcal{B}\left(\Omega_{T}\right)=\sigma\left(B_{s}: s \leq T\right)$.
For this $\mathcal{P}$, define

$$
\mathbb{L}^{p}\left(\Omega_{t}\right):=\left\{X \in \mathcal{B}\left(\Omega_{t}\right): \sup _{P \in \mathcal{P}} E_{P}\left[|X|^{p}\right]<\infty\right\} \text { for } p \geq 1
$$

It is easy to check that $L_{G}^{p}\left(\Omega_{t}\right) \subset \mathbb{L}^{p}\left(\Omega_{t}\right)$. For each $X \in \mathbb{L}^{1}\left(\Omega_{T}\right)$,

$$
\hat{\mathbb{E}}[X]:=\sup _{P \in \mathcal{P}} E_{P}[X]
$$

is still called the $G$-expectation.
The capacity associated to $\mathcal{P}$ is defined by

$$
c(A):=\sup _{P \in \mathcal{P}} P(A) \text { for } A \in \mathcal{B}\left(\Omega_{T}\right)
$$

A set $A \in \mathcal{B}\left(\Omega_{T}\right)$ is polar if $c(A)=0$. A property holds "quasi-surely" (q.s. for short) if it holds outside a polar set. In the following, we do not distinguish two random variables $X$ and $Y$ if $X=Y$ q.s.

Definition 2.2 A process $\left(M_{t}\right)_{t \leq T}$ is called a G-martingale if $M_{t} \in L_{G}^{1}\left(\Omega_{t}\right)$ and $\hat{\mathbb{E}}_{s}\left[M_{t}\right]=M_{s}$ for any $0 \leq s \leq t \leq T$.

The following Doob's inequality for $G$-martingale can be found in [24, 26]. The following proof is based on 9,24 .

Theorem 2.3 Let $1 \leq p<p^{\prime}$ and $\xi \in L_{G}^{p^{\prime}}\left(\Omega_{T}\right)$. Then

\left(\hat{\mathbb{E}}\left[\sup _{t \leq T}\left(\hat{\mathbb{E}}_{t}[|\xi|]\right)^{p}\right]\right)^{1 / p} \leq\left(\hat{\mathbb{E}}\left[\sup _{t \leq T} \hat{\mathbb{E}}_{t}\left[|\xi|^{p}\right]\right]\right)^{1 / p} \leq C\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{1 / p^{\prime}} \tag{2.2}
\end{equation*}
$$

where

$$
C=\left(1+\frac{p}{p^{\prime}-p}\right)^{1 / p}
$$

Proof. By the definition of $L_{G}^{p^{\prime}}\left(\Omega_{T}\right)$, we only need to prove the inequality for $\xi \in \operatorname{Lip}\left(\Omega_{T}\right)$. Define

M_{t}=\hat{\mathbb{E}}_{t}[|\xi|] \text { for } t \leq T
$$

For each fixed $\lambda>0$ and integer $n \geq 1$, define a stopping time

$$
\tau=\inf \left\{t_{i}: M_{t_{i}} \geq \lambda, i=0, \ldots, n\right\}
$$

where $t_{i}=i T / n$ and $\inf \emptyset=\infty$. It is easy to check that

$$
\left\{\tau=t_{i}\right\} \in \mathcal{B}\left(\Omega_{t_{i}}\right), \quad\{\tau=\infty\} \in \mathcal{B}\left(\Omega_{T}\right) \text { and }\left\{\tau=t_{i}\right\} \cap\left\{\tau=t_{j}\right\}=\emptyset \text { for } i \neq j
$$

By Proposition 3.9 in [9], we have

$$
\hat{\mathbb{E}}\left[\sum_{i=0}^{n}|\xi| I_{\left\{\tau=t_{i}\right\}}+0 I_{\{\tau=\infty\}}\right]=\hat{\mathbb{E}}\left[\sum_{i=0}^{n} \hat{\mathbb{E}}_{t_{i}}[|\xi|] I_{\left\{\tau=t_{i}\right\}}+\hat{\mathbb{E}}_{T}[0] I_{\{\tau=\infty\}}\right]
$$

which implies

$$
\hat{\mathbb{E}}\left[|\xi| I_{\left\{\tau \leq t_{n}\right\}}\right]=\hat{\mathbb{E}}\left[\sum_{i=0}^{n} M_{t_{i}} I_{\left\{\tau=t_{i}\right\}}\right] \geq \lambda \hat{\mathbb{E}}\left[I_{\left\{\tau \leq t_{n}\right\}}\right] .
$$

Note that $\left\{\tau \leq t_{n}\right\}=\left\{\sup _{i} M_{t_{i}} \geq \lambda\right\}$, then we have

\lambda \hat{\mathbb{E}}\left[I_{\left\{\sup _{i} M_{t_{i}} \geq \lambda\right\}}\right] \leq \hat{\mathbb{E}}\left[|\xi| I_{\left\{\sup _{i} M_{t_{i}} \geq \lambda\right\}}\right] \leq\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{1 / p^{\prime}}\left(\hat{\mathbb{E}}\left[I_{\left\{\sup _{i} M_{t_{i}} \geq \lambda\right\}}\right]\right)^{1 / q^{\prime}}
$$

where $1 / p^{\prime}+1 / q^{\prime}=1$. Thus,

$$
\hat{\mathbb{E}}\left[I_{\left\{\sup _{i} M_{t_{i}} \geq \lambda\right\}}\right] \leq \frac{1}{\lambda^{p^{\prime}}} \hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right] \text { for each } \lambda>0
$$

For each fixed $\lambda_{0}>0$, we have

$$
\begin{aligned}
\hat{\mathbb{E}}\left[\sup _{i} M_{t_{i}}^{p}\right] & =\sup _{P \in \mathcal{P}} E_{P}\left[\sup _{i} M_{t_{i}}^{p}\right] \\
& =\sup _{P \in \mathcal{P}} p \int_{0}^{\infty} P\left(\sup _{i} M_{t_{i}} \geq \lambda\right) \lambda^{p-1} d \lambda \\
& \leq \int_{0}^{\lambda_{0}} p \lambda^{p-1} d \lambda+\int_{\lambda_{0}}^{\infty} p \lambda^{p-1-p^{\prime}} \hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right] d \lambda \\
& =\left(\lambda_{0}\right)^{p}+\frac{p \lambda_{0}^{p-p^{\prime}}}{p^{\prime}-p} \hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right] .
\end{aligned}
$$

Taking $\lambda_{0}=\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{1 / p^{\prime}}$, we get

$$
\hat{\mathbb{E}}\left[\sup _{i} M_{t_{i}}^{p}\right] \leq\left(1+\frac{p}{p^{\prime}-p}\right)\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{p / p^{\prime}}
$$

Since $|\xi| \in L_{i p}\left(\Omega_{T}\right)$, we have

$$
\sup _{i} M_{t_{i}}^{p} \uparrow \sup _{t \leq T} M_{t}^{p} .
$$

Then we obtain

$$
\begin{equation*}
\hat{\mathbb{E}}\left[\sup _{t \leq T}\left(\hat{\mathbb{E}}_{t}[|\xi|]\right)^{p}\right] \leq\left(1+\frac{p}{p^{\prime}-p}\right)\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{p / p^{\prime}} \tag{2.3}
\end{equation*}
$$

It is obvious that $\left(\hat{\mathbb{E}}_{t}[|\xi|]\right)^{p} \leq \hat{\mathbb{E}}_{t}\left[|\xi|^{p}\right]$. Since inequality (2.3) holds for $|\xi|^{p} \in L_{i p}\left(\Omega_{T}\right)$ and $1<p^{\prime} / p$, we have

\hat{\mathbb{E}}\left[\sup _{t \leq T} \hat{\mathbb{E}}_{t}\left[|\xi|^{p}\right]\right] \leq\left(1+\frac{1}{p^{\prime} / p-1}\right)\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{p / p^{\prime}}=\left(1+\frac{p}{p^{\prime}-p}\right)\left(\hat{\mathbb{E}}\left[|\xi|^{p^{\prime}}\right]\right)^{p / p^{\prime}}
$$

Thus we obtain (2.2).

## 3 BSDEs driven by $G$-Brownian motion under degenerate case

Let $B_{t}=\left(B_{t}^{1}, \ldots, B_{t}^{d}\right)^{T}$ be a $d$-dimensional $G$-Brownian motion satisfying

\begin{equation*}
G(A)=G^{\prime}\left(A^{\prime}\right)+\frac{1}{2} \sum_{i=d^{\prime}+1}^{d} \bar{\sigma}_{i}^{2} a_{i}^{+} \tag{3.1}
\end{equation*}
$$

where $d^{\prime}<d, A^{\prime} \in \mathbb{S}_{d^{\prime}}, a_{i} \in \mathbb{R}$ for $d^{\prime}<i \leq d$,

$$
A=\left(\begin{array}{cccc}
A^{\prime} & \cdots & \cdots & \cdots \\
\cdots & a_{d^{\prime}+1} & \cdots & \cdots \\
\vdots & \vdots & \ddots & \vdots \\
\cdots & \cdots & \cdots & a_{d}
\end{array}\right) \in \mathbb{S}_{d}
$$

$G^{\prime}: \mathbb{S}_{d^{\prime}} \rightarrow \mathbb{R}$ is non-degenerate, $\bar{\sigma}_{i}>0$ for $i=d^{\prime}+1, \ldots, d$. By Corollary 3.5.8 in Peng [22], we know that

\begin{equation*}
\left(\left\langle B^{i}, B^{j}\right\rangle_{t+s}-\left\langle B^{i}, B^{j}\right\rangle_{t}\right)_{i, j=1}^{d} \in s \Sigma \text { for any } t, s \geq 0 \tag{3.2}
\end{equation*}
$$

where $\left\langle B^{i}, B^{j}\right\rangle$ is the mutual variation process of $B^{i}$ and $B^{j}$, and $\Sigma \subset \mathbb{S}_{d}^{+}$is the unique bounded, convex and closed set satisfying (2.1). It follows from (3.1) and (3.2) that, for any $t, s \geq 0$,

The results still hold for $G$-BSDE (3.4), and will be given at the end of this section. In the following, the constant $C$ will change from line to line for simplicity.

### 3.1 Prior estimates of $G$-BSDEs

In this subsection, we give some useful prior estimates of $G$-BSDE (3.5).
Proposition 3.2 Suppose that $\xi_{i}, f_{i}$ and $g_{i}$ satisfy (H1) and (H2) for $i=1,2$. Let $\left(Y^{i}, Z^{i}, K^{i}\right)$ be the $L^{p}$-solution of $G-B S D E$ (3.5) corresponding to $\xi_{i}, f_{i}$ and $g_{i}$ for some $p \in(1, \bar{p})$. Then there exists a positive constant $C$ depending on $p, \bar{\sigma}, L$ and $T$ satisfying

For each $\mathbf{a}=\left(a_{1}, a_{2}\right)^{T} \in \mathbb{R}^{2}$, by Proposition 3.1.5 in Peng [22], we know that $B^{\mathbf{a}}:=a_{1} B+a_{2} \tilde{B}$ is a $G_{\mathbf{a}}$-Brownian motion, where $G_{\mathbf{a}}(b)=\frac{1}{2}\left[\left(\bar{\sigma}^{2}\left|a_{1}\right|^{2}+\left|a_{2}\right|^{2}\right) b^{+}-\left|a_{2}\right|^{2} b^{-}\right]$for $b \in \mathbb{R}$. In particular, $B$ is a $G$-Browinian motion and $\tilde{B}$ is a classical Browinian motion. Thus $\left.\tilde{\mathbb{E}}\right|_{\operatorname{Lip}\left(\Omega_{T}\right)}=\hat{\mathbb{E}}$, which implies that the completion of $M^{0}(0, T)$ (resp. $\left.S^{0}(0, T)\right)$ under the norm $\|\cdot\|_{H_{G}^{p, \bar{p}}(0, T ;\langle B\rangle)}$ (resp. $\left.\|\cdot\|_{S_{\tilde{G}}^{p}(0, T)}\right)$ is $H_{G}^{p, \bar{p}}(0, T ;\langle B\rangle)$ (resp. $\left.S_{G}^{p}(0, T)\right)$. Similar to (3.2), we know that $\langle B, \tilde{B}\rangle_{t}=0$ and $\langle\tilde{B}\rangle_{t}=t$ in the $\tilde{G}$-expectation space.

Then, for each given $p>1, G$-BSDE (3.15) has a unique $L^{p}$-solution $(Y, Z, K)$ in the extended $\tilde{G}$-expectation space such that $Y \in S_{G}^{p}(0, T), Z \in H_{\tilde{G}}^{2, p}(0, T ;\langle B\rangle)$ and $K_{T} \in L_{\tilde{G}}^{p}\left(\tilde{\Omega}_{T}\right)$.

Proof. The uniqueness is due to (3.6) and (3.9) in Proposition 3.2. The proof of existence is divided into two parts.

Part 1. The purpose of this part is to find a solution $(Y, Z, K)$ in the extended $\tilde{G}$-expectation space such that $Y \in S_{\tilde{G}}^{p}(0, T)$ and $Z \in H_{\tilde{G}}^{2, p}(0, T ;\langle B\rangle)$.

For each fixed $\varepsilon \in(0, \bar{\sigma})$, define

The same analysis as in the proof of inequality (4.3) in [7], we get that there exists a positive constant $C$ depending on $\varphi, h, \bar{\sigma}$ and $T$ such that

In order to show that $Z$ obtained in Lemma 3.3 belongs to $H_{G}^{2, p}(0, T ;\langle B\rangle)$, we need to prove that $\partial_{x x}^{2} u_{\varepsilon}$ is uniformly bounded from below for $\varepsilon \in(0, \bar{\sigma})$, where $u_{\varepsilon}$ is the solution of PDE (3.17).

For each fixed $\varepsilon \in(0, \bar{\sigma}), G_{\varepsilon}$ is defined in (3.16). Let $\hat{\mathbb{E}}^{\varepsilon}$ be the $G_{\varepsilon}$-expectation on $\left(\Omega_{T}, \operatorname{Lip}\left(\Omega_{T}\right)\right)$. The canonical process $\left(B_{t}\right)_{t \in[0, T]}$ is the 1-dimensional $G_{\varepsilon}$-Brownian motion under $\hat{\mathbb{E}}^{\varepsilon}$. For each given $(t, x) \in$ $[0, T) \times \mathbb{R}$, denote

Let $\mathcal{P}^{\varepsilon}$ be a weakly compact and convex set of probability measures on $\left(\Omega_{T}, \mathcal{B}\left(\Omega_{T}\right)\right)$ such that

Lemma 3.8 Let $\varphi \in C_{0}^{\infty}(\mathbb{R})$ and $h \in C_{0}^{\infty}\left(\mathbb{R}^{2}\right)$. Then, for each given $p>1, G$-BSDE (3.15) has a unique $L^{p}$-solution $(Y, Z, K)$ in the $G$-expectation space.

Proof. The uniqueness is due to (3.6) and (3.9) in Proposition 3.2 In the following, we give the proof of existence.

By Lemma 3.3, for each given $p>1, G$-BSDE (3.15) has a unique $L^{p}$-solution $(Y, Z, K)$ in the extended $\tilde{G}$-expectation space, i.e.,

\lim _{n \rightarrow \infty} \hat{\mathbb{E}}\left[\left|\left(\tilde{K}_{T}^{n}-\tilde{K}_{t_{1}}^{n}\right)-\left(K_{T}-K_{t_{1}}\right)\right|^{p}\right]=0
$$

By Proposition 2.5 in [7], we know that, for $t \in\left[t_{1}, T\right], \hat{\mathbb{E}}_{t}\left[\tilde{K}_{T}^{n}-\tilde{K}_{t}^{n}\right]=0$ and

$$
\hat{\mathbb{E}}\left[\left|\hat{\mathbb{E}}_{t}\left[K_{T}-K_{t}\right]\right|\right]=\hat{\mathbb{E}}\left[\left|\hat{\mathbb{E}}_{t}\left[K_{T}-K_{t}\right]-\hat{\mathbb{E}}_{t}\left[\tilde{K}_{T}^{n}-\tilde{K}_{t}^{n}\right]\right|\right] \leq \hat{\mathbb{E}}\left[\left|\left(K_{T}-K_{t}\right)-\left(\tilde{K}_{T}^{n}-\tilde{K}_{t}^{n}\right)\right|\right],
$$

which implies $\hat{\mathbb{E}}_{t}\left[K_{T}\right]=K_{t}$ by letting $n \rightarrow \infty$. Thus we obtain an $L^{p}$-solution $(Y, Z, K)$ on $\left[t_{1}, T\right]$. Noting that $Y_{t_{1}}=u\left(t_{1}, B_{t_{1}}, 0\right)$, we obtain the desired result by applying Lemma 3.9 to find an $L^{p}$-solution on $\left[0, t_{1}\right]$.

Now, we give the following existence and uniqueness result of $G$-BSDE (3.5).

Theorem 3.11 Suppose that $\xi, f$ and $g$ satisfy (H1) and (H2). Then $G$-BSDE (3.5) has a unique $L^{p}$ solution $(Y, Z, K)$ for each given $p \in(1, \bar{p})$.

Proof. The uniqueness is due to (3.6) and (3.9) in Proposition 3.2. For each positive integer $n$, by partition of unity theorem, we can find $h_{i}^{n} \in C_{0}^{\infty}(\mathbb{R}), \tilde{h}_{j}^{n} \in C_{0}^{\infty}\left(\mathbb{R}^{2}\right), i \leq k_{n}, j \leq \tilde{k}_{n}$, such that

\begin{gathered}
0 \leq h_{i}^{n} \leq 1 \text { and } \lambda\left(\operatorname{supp}\left(h_{i}^{n}\right)\right) \leq \frac{1}{n} \text { for } i \leq k_{n}, I_{[-n, n]}(y) \leq \sum_{i=1}^{k_{n}} h_{i}^{n}(y) \leq 1, \\
0 \leq \tilde{h}_{j}^{n} \leq 1 \text { and } \lambda\left(\operatorname{supp}\left(\tilde{h}_{j}^{n}\right)\right) \leq \frac{1}{n} \text { for } j \leq \tilde{k}_{n}, I_{[-n, n] \times[-n, n]}(y, z) \leq \sum_{j=1}^{\tilde{k}_{n}} \tilde{h}_{j}^{n}(y, z) \leq 1 .
\end{gathered}
$$

For each $N>0$, set $\tilde{f}(t, y)=f(t, y)-f(t, 0), \tilde{g}(t, y, z)=g(t, y, z)-g(t, 0,0)$,

$$
\begin{gathered}
\tilde{f}^{N}(t, y)=(\tilde{f}(t, y) \wedge N) \vee(-N), \tilde{g}^{N}(t, y, z)=(\tilde{g}(t, y, z) \wedge N) \vee(-N), \\
f^{N}(t, y)=f(t, 0)+\tilde{f}^{N}(t, y), g^{N}(t, y, z)=g(t, 0,0)+\tilde{g}^{N}(t, y, z), \\
f_{n}^{N}(t, y)=f(t, 0)+\sum_{i=1}^{k_{n}} \tilde{f}^{N}\left(t, y_{i}^{n}\right) h_{i}^{n}(y), g_{n}^{N}(t, y, z)=g(t, 0,0)+\sum_{j=1}^{\tilde{k}_{n}} \tilde{g}^{N}\left(t, \tilde{y}_{j}^{n}, \tilde{z}_{j}^{n}\right) \tilde{h}_{j}^{n}(y, z),
\end{gathered}
$$

where $h_{i}^{n}\left(y_{i}^{n}\right)>0, \tilde{h}_{j}^{n}\left(\tilde{y}_{j}^{n}, \tilde{z}_{j}^{n}\right)>0$ for $i \leq k_{n}, j \leq \tilde{k}_{n}$. By Proposition 3.2 and Lemma 3.10, we can easily deduce that $G$-BSDE

\begin{equation*}
Y_{t}^{N, n}=\xi+\int_{t}^{T} f_{n}^{N}\left(s, Y_{s}^{N, n}\right) d s+\int_{t}^{T} g_{n}^{N}\left(s, Y_{s}^{N, n}, Z_{s}^{N, n}\right) d\langle B\rangle_{s}-\int_{t}^{T} Z_{s}^{N, n} d B_{s}-\left(K_{T}^{N, n}-K_{t}^{N, n}\right) \tag{3.60}
\end{equation*}
$$

has a unique $L^{p}$-solution $\left(Y^{N, n}, Z^{N, n}, K^{N, n}\right)$ for each given $p \in(1, \bar{p})$. Noting that

$$
f_{n}^{N}\left(s, Y_{s}^{N, n}\right)=f^{N}\left(s, Y_{s}^{N, n}\right)+\hat{f}_{n}^{N}(s) \text { and } g_{n}^{N}\left(s, Y_{s}^{N, n}, Z_{s}^{N, n}\right)=g^{N}\left(s, Y_{s}^{N, n}, Z_{s}^{N, n}\right)+\hat{g}_{n}^{N}(s),
$$

where $\left|\hat{f}_{n}^{N}(s)\right|=\left|f_{n}^{N}\left(s, Y_{s}^{N, n}\right)-f^{N}\left(s, Y_{s}^{N, n}\right)\right| \leq\left(\frac{L}{n}+\frac{N}{n}\left|Y_{s}^{N, n}\right|\right) \wedge(2 N),\left|\hat{g}_{n}^{N}(s)\right| \leq\left[\frac{L}{n}+\frac{N}{n}\left(\left|Y_{s}^{N, n}\right|+\left|Z_{s}^{N, n}\right|\right)\right] \wedge$ $(2 N)$. By Proposition 3.2, we can easily deduce that, for each given $p \in(1, \bar{p})$,

$$
\lim _{n, m \rightarrow \infty} \hat{\mathbb{E}}\left[\sup _{t \in[0, T]}\left|Y_{t}^{N, n}-Y_{t}^{N, m}\right|^{p}+\left(\int_{0}^{T}\left|Z_{t}^{N, n}-Z_{t}^{N, m}\right|^{2} d\langle B\rangle_{t}\right)^{p / 2}+\left|K_{T}^{N, n}-K_{T}^{N, m}\right|^{p}\right]=0,
$$

which implies that $G$-BSDE

$$
\begin{equation*}
Y_{t}^{N}=\xi+\int_{t}^{T} f^{N}\left(s, Y_{s}^{N}\right) d s+\int_{t}^{T} g^{N}\left(s, Y_{s}^{N}, Z_{s}^{N}\right) d\langle B\rangle_{s}-\int_{t}^{T} Z_{s}^{N} d B_{s}-\left(K_{T}^{N}-K_{t}^{N}\right) \tag{3.61}
\end{equation*}
$$

has a unique $L^{p}$-solution $\left(Y^{N}, Z^{N}, K^{N}\right)$ for each given $p \in(1, \bar{p})$. By (3.7), (3.8) in Proposition 3.2 and Theorem 2.3. we obtain that, for each $p \in(1, \bar{p})$,

$$
\begin{equation*}
\sup _{N>0} \hat{\mathbb{E}}\left[\sup _{t \in[0, T]}\left|Y_{t}^{N}\right|^{p}+\left(\int_{0}^{T}\left|Z_{t}^{N}\right|^{2} d\langle B\rangle_{t}\right)^{p / 2}+\left|K_{T}^{N}\right|^{p}\right] \leq C, \tag{3.62}
\end{equation*}
$$

where the constant $C>0$ depends on $p, \bar{p}, \bar{\sigma}, L$ and $T$. For each fixed $p \in(1, \bar{p})$, we have

\left|f^{N_{1}}\left(s, Y_{s}^{N_{1}}\right)-f^{N_{2}}\left(s, Y_{s}^{N_{1}}\right)\right| \leq\left(N_{1} \wedge N_{2}\right)^{-\delta}\left|\tilde{f}\left(s, Y_{s}^{N_{1}}\right)\right|^{1+\delta} \leq L^{1+\delta}\left(N_{1} \wedge N_{2}\right)^{-\delta}\left|Y_{s}^{N_{1}}\right|^{1+\delta}
$$

$$
\left|g^{N_{1}}\left(s, Y_{s}^{N_{1}}, Z_{s}^{N_{1}}\right)-g^{N_{2}}\left(s, Y_{s}^{N_{1}}, Z_{s}^{N_{1}}\right)\right| \leq L^{1+\delta}\left(N_{1} \wedge N_{2}\right)^{-\delta}\left(\left|Y_{s}^{N_{1}}\right|+\left|Z_{s}^{N_{1}}\right|\right)^{1+\delta},
$$

where $\delta=\left[\frac{1}{2}\left(\frac{\bar{p}}{p}-1\right)\right] \wedge 1$. Thus, by (3.6), (3.9) in Proposition 3.2 (3.62) and Theorem 2.3) we get

\lim _{N_{1}, N_{2} \rightarrow \infty} \hat{\mathbb{E}}\left[\sup _{t \in[0, T]}\left|Y_{t}^{N_{1}}-Y_{t}^{N_{2}}\right|^{p}+\left(\int_{0}^{T}\left|Z_{t}^{N_{1}}-Z_{t}^{N_{2}}\right|^{2} d\langle B\rangle_{t}\right)^{p / 2}+\left|K_{T}^{N_{1}}-K_{T}^{N_{2}}\right|^{p}\right]=0
$$

which implies the desired result by letting $N \rightarrow \infty$ in (3.61).
The following example shows that $f$ can not contain $z$ in $G$-BSDE (3.5).
Example 3.12 Let $B$ be a 1-dimensional $G$-Brownian motion with $G(a):=\frac{1}{2} \bar{\sigma}^{2} a^{+}$for $a \in \mathbb{R}$. For each $n \geq 1$, we know that $\left(\left(n^{-1}+\langle B\rangle_{s}\right)^{-1 / 5}\right)_{s \in[0, T]} \in H_{G}^{2, p}(0, T ;\langle B\rangle)$ for each $p>1$. Since

$$
\left|\left(n^{-1}+\langle B\rangle_{s}\right)^{-1 / 5}-\left(\langle B\rangle_{s}\right)^{-1 / 5}\right| \leq\left(\langle B\rangle_{s}\right)^{-2 / 5}\left|\left(n^{-1}+\langle B\rangle_{s}\right)^{1 / 5}-\left(\langle B\rangle_{s}\right)^{1 / 5}\right| \leq n^{-1 / 5}\left(\langle B\rangle_{s}\right)^{-2 / 5}
$$

we have

$$
\int_{0}^{T}\left|\left(n^{-1}+\langle B\rangle_{s}\right)^{-1 / 5}-\left(\langle B\rangle_{s}\right)^{-1 / 5}\right|^{2} d\langle B\rangle_{s} \leq n^{-2 / 5} \int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-4 / 5} d\langle B\rangle_{s}=5 n^{-2 / 5}\left(\langle B\rangle_{T}\right)^{1 / 5}
$$

Thus $\left(\left(\langle B\rangle_{s}\right)^{-1 / 5}\right)_{s \in[0, T]} \in H_{G}^{2, p}(0, T ;\langle B\rangle)$ for each $p>1$, which implies $\int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s} \in L_{G}^{p}\left(\Omega_{T}\right)$ for each $p>1$. Consider the following linear $G-B S D E$ :

Y_{t}=\int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s}+\int_{t}^{T} Z_{s} d s-\int_{t}^{T} Z_{s} d B_{s}-\left(K_{T}-K_{t}\right) \tag{3.63}
\end{equation*}
$$

we assert that, for each given $p>1$, the above $G$-BSDE has no $L^{p}$-solution $(Y, Z, K)$. Otherwise, there exists an $L^{p}$-solution $(Y, Z, K)$ for some $p>1$.

For each $\varepsilon>0$, we introduce the following $\tilde{G}^{\varepsilon}$-expectation $\tilde{\mathbb{E}}^{\varepsilon}$. Set $\tilde{\Omega}_{T}=C_{0}\left([0, T] ; \mathbb{R}^{2}\right)$ and the canonical process is denoted by $(B, \tilde{B})$. For each $A \in \mathbb{S}_{2}$, define

$$
\tilde{G}^{\varepsilon}(A)=\frac{1}{2} \sup _{\varepsilon^{2} \leq v \leq \bar{\sigma}^{2}} \operatorname{tr}\left[A\left(\begin{array}{cc}
v & 1 \\
1 & \varepsilon^{-2}
\end{array}\right)\right] .
$$

By Proposition 3.1 .5 in Peng [22], we know that $\varepsilon \tilde{B}$ is a classical 1-dimensional standard Brownian motion under $\tilde{\mathbb{E}}^{\varepsilon}$ and $\left.\tilde{\mathbb{E}}^{\varepsilon}\right|_{\text {Lip }\left(\Omega_{T}\right)} \leq \hat{\mathbb{E}}$. Thus $G$-BSDE (3.63) still holds under $\tilde{\mathbb{E}}^{\varepsilon}$. Similar to (3.2), we know that $\langle B, \tilde{B}\rangle_{t}=t$ and $\langle\tilde{B}\rangle_{t}=\varepsilon^{-2} t$ under $\tilde{\mathbb{E}}^{\varepsilon}$. Consider the following $G$-SDE under $\tilde{\mathbb{E}}^{\varepsilon}$ :

d X_{t}=X_{t} d \tilde{B}_{t}, X_{0}=1
$$

The solution is $X_{t}=\exp \left(\tilde{B}_{t}-2^{-1} \varepsilon^{-2} t\right)>0$. Applying Itô's formula to $X_{t} Y_{t}$ on $[0, T]$ under $\tilde{\mathbb{E}}^{\varepsilon}$, we get

X_{T} Y_{T}=Y_{0}+\int_{0}^{T} X_{t} Z_{t} d B_{t}+\int_{0}^{T} X_{t} Y_{t} d \tilde{B}_{t}+\int_{0}^{T} X_{t} d K_{t}
$$

Since $\int_{0}^{T} X_{t} d K_{t} \leq 0$, we obtain

Y_{0} \geq \tilde{\mathbb{E}}^{\varepsilon}\left[X_{T} Y_{T}\right]=\tilde{\mathbb{E}}^{\varepsilon}\left[X_{T} \int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s}\right] \text { for each } \varepsilon>0
$$

Applying Itô's formula to $X_{t} \int_{0}^{t}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s}$ on $[0, T]$ under $\tilde{\mathbb{E}}^{\varepsilon}$, we deduce

$$
Y_{0} \geq \tilde{\mathbb{E}}^{\varepsilon}\left[X_{T} \int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s}\right]=\tilde{\mathbb{E}}^{\varepsilon}\left[\int_{0}^{T} X_{s}\left(\langle B\rangle_{s}\right)^{-1 / 5} d s\right] \text { for each } \varepsilon>0
$$

Let $E^{\varepsilon}$ be the linear $\bar{G}^{\varepsilon}$-expectation with

$$
\bar{G}^{\varepsilon}(A)=\frac{1}{2} \operatorname{tr}\left[A\left(\begin{array}{cc}
\varepsilon^{2} & 1 \\
1 & \varepsilon^{-2}
\end{array}\right)\right] \text { for } A \in \mathbb{S}_{2}
$$

Since $\bar{G}^{\varepsilon} \leq \tilde{G}^{\varepsilon}$, we know that $E^{\varepsilon} \leq \tilde{\mathbb{E}}^{\varepsilon}$. By Proposition 3.1 .5 in Peng [22], we know that $\varepsilon^{-1} B$ and $\varepsilon \tilde{B}$ are two classical 1-dimensional standard Brownian motion under $E^{\varepsilon}$. Then we get

$$
Y_{0} \geq E^{\varepsilon}\left[X_{T} \int_{0}^{T}\left(\langle B\rangle_{s}\right)^{-1 / 5} d B_{s}\right]=\frac{5}{4} T^{4 / 5} \varepsilon^{-2 / 5} \text { for each } \varepsilon>0
$$

which contradicts to $Y_{0} \in \mathbb{R}$. Thus, for each given $p>1, G$-BSDE (3.63) has no $L^{p}$-solution $(Y, Z, K)$.
Finally, we give the following existence and uniqueness result of $G$-BSDE (3.4).
Theorem 3.13 Suppose that $\xi, f, g_{i j}, g_{l}, i, j \leq d^{\prime}, d^{\prime}<l \leq d$, satisfy (H1) and (H2). Then G-BSDE (3.4) has a unique $L^{p}$-solution $(Y, Z, K)$ for each given $p \in(1, \bar{p})$.

Proof. The proof of this theorem is similar to Theorem 3.11, we omit it.

## 4 Application to the regularity of fully nonlinear PDEs

For simplicity of representation, we only consider 1-dimensional $G$-Brownian motion with $G(a)=\frac{1}{2} \bar{\sigma}^{2} a^{+}$, the methods still hold for the $d$-dimensional $G$-Brownian motion with $G(\cdot)$ given in (3.1). For each fixed $t \in[0, T]$ and $\xi \in \cap_{p \geq 2} L_{G}^{p}\left(\Omega_{t}\right)$, consider the following $G$-FBSDE:

d X_{s}^{t, \xi}= & b\left(s, X_{s}^{t, \xi}\right) d s+h\left(s, X_{s}^{t, \xi}\right) d\langle B\rangle_{s}+\sigma\left(s, X_{s}^{t, \xi}\right) d B_{s}, X_{t}^{t, \xi}=\xi, s \in[t, T]  \tag{4.1}\\
Y_{s}^{t, \xi}= & \varphi\left(X_{T}^{t, \xi}\right)+\int_{s}^{T} f\left(r, X_{r}^{t, \xi}, Y_{r}^{t, \xi}\right) d r+\int_{s}^{T} g\left(r, X_{r}^{t, \xi}, Y_{r}^{t, \xi}, Z_{r}^{t, \xi}\right) d\langle B\rangle_{r}  \tag{4.2}\\
& -\int_{s}^{T} Z_{r}^{t, \xi} d B_{r}-\left(K_{T}^{t, \xi}-K_{s}^{t, \xi}\right),
\end{align*}
$$

where $b, h, \sigma:[0, T] \times \mathbb{R} \rightarrow \mathbb{R}, \varphi: \mathbb{R} \rightarrow \mathbb{R}, f:[0, T] \times \mathbb{R}^{2} \rightarrow \mathbb{R}, g:[0, T] \times \mathbb{R}^{3} \rightarrow \mathbb{R}$ satisfy the following conditions:
(A1) $b, h, \sigma, f, g$ are continuous in $(s, x, y, z)$.
(A2) There exist a constant $L_{1}>0$ and a positive integer $m$ such that for any $s \in[0, T], x, x^{\prime}, y, y^{\prime}, z$, $z^{\prime} \in \mathbb{R}$,

$$
\begin{aligned}
& \left|b(s, x)-b\left(s, x^{\prime}\right)\right|+\left|h(s, x)-h\left(s, x^{\prime}\right)\right|+\left|\sigma(s, x)-\sigma\left(s, x^{\prime}\right)\right| \leq L_{1}\left|x-x^{\prime}\right|, \\
& \left|\varphi(x)-\varphi\left(x^{\prime}\right)\right| \leq L_{1}\left(1+|x|^{m}+\left|x^{\prime}\right|^{m}\right)\left|x-x^{\prime}\right|, \\
& \left|f(s, x, y)-f\left(s, x^{\prime}, y^{\prime}\right)\right|+\left|g(s, x, y, z)-g\left(s, x^{\prime}, y^{\prime}, z^{\prime}\right)\right| \\
& \leq L_{1}\left[\left(1+|x|^{m}+\left|x^{\prime}\right|^{m}\right)\left|x-x^{\prime}\right|+\left|y-y^{\prime}\right|+\left|z-z^{\prime}\right|\right] .
\end{aligned}
$$

Under the assumptions (A1) and (A2), for each $p \geq 2$, $\operatorname{SDE}$ (4.1) has a unique solution $\left(X_{s}^{t, \xi}\right)_{s \in[t, T]} \in$ $S_{G}^{p}(t, T)$ and $G$-BSDE (4.2) has a unique $L^{p}$-solution $\left(Y_{s}^{t, \xi}, Z_{s}^{t, \xi}, K_{s}^{t, \xi}\right)_{s \in[t, T]}$ with $K_{t}^{t, \xi}=0$. The following standard estimates of SDE can be found in Chapter 5 in Peng [22].

Proposition 4.1 Suppose that (A1) and (A2) hold. Let $\xi$, $\xi^{\prime} \in \cap_{p \geq 2} L_{G}^{p}\left(\Omega_{t}\right)$ with $t<T$. Then, for each $p \geq 2$ and $\delta \in[0, T-t]$, we have

$$
\hat{\mathbb{E}}_{t}\left[\left|X_{t+\delta}^{t, \xi}-X_{t+\delta}^{t, \xi^{\prime}}\right|^{p}\right] \leq C\left|\xi-\xi^{\prime}\right|^{p} \text { and } \hat{\mathbb{E}}_{t}\left[\left|X_{t+\delta}^{t, \xi}\right|^{p}\right] \leq C\left(1+|\xi|^{p}\right)
$$

where the constant $C>0$ depends on $L_{1}, \bar{\sigma}, p$ and $T$.
Set $\xi=x \in \mathbb{R}$, define

$$
\begin{equation*}
u(t, x)=Y_{t}^{t, x} \text { for }(t, x) \in[0, T] \times \mathbb{R} \tag{4.3}
\end{equation*}
$$

Since $\left(B_{t+r}-B_{t}\right)_{r \geq 0}$ is still a $G$-Brownian motion, we have $Y_{t}^{t, x} \in \mathbb{R}$.
Proposition 4.2 Suppose that (A1) and (A2) hold. Then
(i) For each $(t, x) \in[0, T) \times \mathbb{R}$, we have $Y_{s}^{t, x}=u\left(s, X_{s}^{t, x}\right)$ for $s \in[t, T]$.
(ii) $u(\cdot, \cdot)$ is the unique viscosity solution of the following fully nonlinear PDE:

$$
\left\{\begin{array}{l}
\partial_{t} u+G\left(\sigma^{2}(t, x) \partial_{x x}^{2} u+2 h(t, x) \partial_{x} u+2 g\left(t, x, u, \sigma(t, x) \partial_{x} u\right)\right) \\
+b(t, x) \partial_{x} u+f(t, x, u)=0 \\
u(T, x)=\varphi(x)
\end{array}\right.
$$

Proof. The proof is the same as Theorems 4.4 and 4.5 in [8], we omit it.
In the following, we discuss the regularity properties of $u(\cdot, \cdot)$. First, we study $\partial_{x} u(t, x)$. For each $(t, x) \in[0, T) \times \mathbb{R}$ and $\Delta \in[-1,1]$, by Proposition 4.1. we have, for each $p \geq 2$,

$$
\begin{equation*}
\sup _{s \in[t, T]} \hat{\mathbb{E}}\left[\left|X_{s}^{t, x+\Delta}-X_{s}^{t, x}\right|^{p}\right] \leq C|\Delta|^{p} \text { and } \sup _{s \in[t, T]} \hat{\mathbb{E}}\left[\left|X_{s}^{t, x}\right|^{p}\right] \leq C\left(1+|x|^{p}\right) \tag{4.4}
\end{equation*}
$$

where $C>0$ depends on $L_{1}, \bar{\sigma}, p$ and $T$. It follows from Proposition 3.2. Theorem 2.3 and (4.4) that, for each $p \geq 2$,

$$
\begin{equation*}

and $\left(B_{s}-B_{t}\right)_{s \in[t, T]}$ have the same distribution, we obtain $u(t+\Delta, x)=\bar{Y}_{t}^{t, x, \Delta}$, where $\left(\bar{X}^{t, x, \Delta}, \bar{Y}^{t, x, \Delta}\right.$, $\bar{Z}^{t, x, \Delta}, \bar{K}^{t, x, \Delta}$ ) satisfies the following $G$-FBSDE:

\left|E_{P}\left[\tilde{\varphi}(T) \Gamma_{T}^{t, x}+\int_{t}^{T} \tilde{f}(s) \Gamma_{s}^{t, x} d s+\int_{t}^{T} \tilde{g}(s) \Gamma_{s}^{t, x} d\langle B\rangle_{s}\right]\right| \leq C\left(1+|x|^{2 m}\right) \Delta^{2} \tag{4.33}
\end{equation*}
$$

where $C>0$ depends on $L_{1}, L_{3}, \bar{\sigma}$ and $T$. Thus

$$
\begin{equation*}
\hat{Y}_{t}^{\Delta} \geq \Delta \partial_{x+} u(t, x)-C\left(1+|x|^{2 m}\right) \Delta^{2} \tag{4.34}
\end{equation*}
$$

We can also choose a $P^{\Delta} \in \mathcal{P}_{t, x+\Delta}$ such that

$$
\begin{aligned}
\partial_{x-} u(t, x+\Delta)= & E_{P}\left[\varphi^{\prime}\left(X_{T}^{t, x+\Delta}\right) \hat{X}_{T}^{t, x+\Delta} \Gamma_{T}^{t, x+\Delta}+\int_{t}^{T} f_{x}^{\prime}\left(s, X_{s}^{t, x+\Delta}, Y_{s}^{t, x+\Delta}\right) \hat{X}_{s}^{t, x+\Delta} \Gamma_{s}^{t, x+\Delta} d s\right. \\
& \left.+\int_{t}^{T} g_{x}^{\prime}\left(s, X_{s}^{t, x+\Delta}, Y_{s}^{t, x+\Delta}, Z_{s}^{t, x+\Delta}\right) \hat{X}_{s}^{t, x+\Delta} \Gamma_{s}^{t, x+\Delta} d\langle B\rangle_{s}\right]
\end{aligned}
$$

Applying Itô's formula to $\hat{Y}_{s}^{\Delta} \Gamma_{s}^{t, x+\Delta}$ on $[t, T]$ under $P^{\Delta}$, similar to (4.16) and the analysis of (4.33), we can get

$$
\begin{equation*}
\hat{Y}_{t}^{\Delta} \leq \Delta \partial_{x-} u(t, x+\Delta)+C\left(1+|x|^{2 m}\right) \Delta^{2}, \tag{4.35}
\end{equation*}
$$

where $C>0$ depends on $L_{1}, L_{3}, \bar{\sigma}$ and $T$. Then we obtain (4.31) by (4.34) and 4.35). Similarly, we can deduce (4.32).

Remark 4.10 We can get similar estimates under the assumption

$$
\left|b_{x x}^{\prime \prime}(s, x)\right| \leq L_{4}\left(1+|x|^{m_{2}}\right)
$$

for positive constant $L_{4}$ and positive integer $m_{2}$, similar for the second derivatives of $h, \sigma, f$ and $g$.
