# CERTAIN COMPLEX REPRESENTATIONS OF $SL_2(\bar{\mathbb{F}}_q)$

ABSTRACT. We introduce the representation category  $\mathscr{C}(\mathbf{G})$  for a connected reductive algebraic group  $\mathbf{G}$  which is defined over a finite field  $\mathbb{F}_q$  of q elements. We show that this category has many good properties for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ . In particular, it is an abelian category and a highest weight category. Moreover, we classify the simple objects in  $\mathscr{C}(\mathbf{G})$  for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ .

## 1. INTRODUCTION

Let G be a connected reductive algebraic group defined over the finite field  $\mathbb{F}_q$  of q elements. Let k be another field and all representations in this paper are over k. According to a result of Borel and Tits [1, Theorem 10.3 and Corollary 10.4, we know that except the trivial representation, all other irreducible representations of  $\mathbf{k}\mathbf{G}$  (the group algebra of  $\mathbf{G}$ ) are infinite-dimensional if **G** is semisimple and  $\Bbbk$  is infinite with char  $\Bbbk \neq \operatorname{char} \overline{\mathbb{F}}_q$ . Denote by  $G_{q^a}$  the set of  $\mathbb{F}_{q^a}$ -points of **G**, then we have  $\mathbf{G} = \bigcup G_{q^a}$ . With this basic fact, N.H. Xi studied the abstract representations of  $\mathbf{G}$  over  $\Bbbk$ by taking the direct limit of the finite-dimensional representations of  $G_{q^a}$ and he got many interesting results in [13]. In particular, he showed that the infinite-dimensional Steinberg module is irreducible when  $\operatorname{char} \mathbb{k} = 0$ or char  $\mathbb{k} = \text{char } \mathbb{F}_q$ . Afterwards, R.T. Yang proved the irreducibility of the Steinberg module for any field k with char  $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_q$  (see [14]). Later, motivated by Xi's idea, the structure of the permutation module  $\Bbbk[\mathbf{G}/\mathbf{B}]$  (**B** is a fixed Borel subgroup of  $\mathbf{G}$  ) was studied in [4] for the cross characteristic case and in [5] for the defining characteristic case. We studied the general abstract induced module  $\mathbb{M}(\theta) = \mathbb{k} \mathbf{G} \otimes_{\mathbb{k} \mathbf{B}} \mathbb{k}_{\theta}$  in [6] for any field  $\mathbb{k}$  with  $\operatorname{char} \mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_q$  or  $\mathbb{k} = \overline{\mathbb{F}}_q$ , where **T** is a maximal torus contained in a Borel subgroup **B** and  $\theta$  is a character of **T** which can also be regarded as a character of **B** through the homomorphism  $\mathbf{B} \to \mathbf{T}$ . The induced module

 $\mathbb{M}(\theta)$  has a composition series (of finite length) if char  $\mathbb{k} \neq$  char  $\mathbb{F}_q$ . In the case  $\mathbb{k} = \overline{\mathbb{F}}_q$  and  $\theta$  is a rational character,  $\mathbb{M}(\theta)$  has such composition series if and only if  $\theta$  is antidominant (see [6] for details). In both cases, the composition factors of  $\mathbb{M}(\theta)$  are  $E(\theta)_J$  with  $J \subset I(\theta)$  (see Section 2 for the explicit setting).

Now we have a large class of irreducible  $\Bbbk \mathbf{G}$ -modules. Let  $\Bbbk \mathbf{G}$ -Mod be the  $\Bbbk \mathbf{G}$ -module category. However, this category is too big and thus in the paper [9], we introduce the principal representation category  $\mathscr{O}(\mathbf{G})$  which was supposed to have many good properties. In particular, we conjectured that this category is a highest weight category in the sense of Cline, Parshall and Scott [8]. However, recently X.Y.Chen constructed a counter example (see [3]) to show that this conjecture is not valid in general with the setting given in [9, Section 4]. Thus it deserves to explore other categories besides the category  $\mathscr{O}(\mathbf{G})$  in [9]. We hope that there is a category which satisfies certain good properties such as "finite-ness" and "semi-simplicity", which is also like the BGG category  $\mathscr{O}$  in the representations of complex semisimple Lie algebras. In this paper we introduce a full subcategory  $\mathscr{C}(\mathbf{G})$  of  $\Bbbk \mathbf{G}$ -Mod, whose objects are finitely generated by some  $\mathbf{T}$ -eigenvectors (see Section 2 for the definition of  $\mathscr{C}(\mathbf{G})$ ). The main part of this paper is devoted to study the category  $\mathscr{C}(\mathbf{G})$  for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ .

The rest of this paper is organized as follows: Section 2 contains some preliminary results and we also introduce the category  $\mathscr{C}(\mathbf{G})$  in this section. From Section 3 to Section 5, we assume that  $\mathbb{k}$  is an algebraically closed field of characteristic 0 and study the category  $\mathscr{C}(\mathbf{G})$  for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ . In Section 3, we classify the simple  $\mathbb{k}\mathbf{G}$ -modules with **T**-stable lines. In particular, we get all the simple objects in  $\mathscr{C}(\mathbf{G})$ . Then we show that  $\mathscr{C}(\mathbf{G})$  is an abelian category and has certain good properties in Section 4. In Section 5 we prove that  $\mathscr{C}(\mathbf{G})$  is a highest weight category.

### 2. Background and preliminary results

Let **G** be a connected reductive algebraic group over  $\overline{\mathbb{F}}_q$ , the algebraic closure of  $\mathbb{F}_q$ , e.g.  $\mathbf{G} = GL_n(\overline{\mathbb{F}}_q)$ ,  $SL_n(\overline{\mathbb{F}}_q)$ . Let **B** be a Borel subgroup, and **T** be a maximal torus contained in **B**, and  $\mathbf{U} = R_u(\mathbf{B})$  be the unipotent radical of **B**. We identify **G** with  $\mathbf{G}(\overline{\mathbb{F}}_q)$  and do likewise for the various subgroups of **G** such as  $\mathbf{B}, \mathbf{T}, \mathbf{U} \cdots$ . We denote by  $\Phi = \Phi(\mathbf{G}; \mathbf{T})$  the corresponding root system, and by  $\Phi^+$  (resp.  $\Phi^-$ ) the set of positive (resp. negative) roots determined by **B**. Let  $W = N_{\mathbf{G}}(\mathbf{T})/\mathbf{T}$  be the corresponding Weyl group. We denote by  $\Delta = \{\alpha_i \mid i \in I\}$  the set of simple roots and by  $S = \{s_i := s_{\alpha_i} \mid i \in I\}$  the corresponding simple reflections in W. For each  $\alpha \in \Phi$ , let  $\mathbf{U}_{\alpha}$  be the root subgroup corresponding to  $\alpha$  and we fix an isomorphism  $\varepsilon_{\alpha} : \bar{\mathbb{F}}_q \to \mathbf{U}_{\alpha}$  such that  $t\varepsilon_{\alpha}(c)t^{-1} = \varepsilon_{\alpha}(\alpha(t)c)$  for any  $t \in \mathbf{T}$ and  $c \in \bar{\mathbb{F}}_q$ . For any  $w \in W$ , let  $\mathbf{U}_w$  (resp.  $\mathbf{U}'_w$ ) be the subgroup of  $\mathbf{U}$ generated by all  $\mathbf{U}_{\alpha}$  with  $w(\alpha) \in \Phi^-$  (resp.  $w(\alpha) \in \Phi^+$ ). One is referred [2] for more details.

Now let  $\Bbbk$  be an algebraically closed field of characteristic 0 and all the representations in this paper are over  $\Bbbk$ . Let  $\widehat{\mathbf{T}}$  be the set of characters of  $\mathbf{T}$ . Each  $\theta \in \widehat{\mathbf{T}}$  can be regarded as a character of  $\mathbf{B}$  by the homomorphism  $\mathbf{B} \to \mathbf{T}$ . Let  $\Bbbk_{\theta}$  be the corresponding  $\mathbf{B}$ -module. We consider the induced module  $\mathbb{M}(\theta) = \Bbbk \mathbf{G} \otimes_{\Bbbk \mathbf{B}} \Bbbk_{\theta}$ . Let  $\mathbf{1}_{\theta}$  be a fixed nonzero element in  $\Bbbk_{\theta}$ . We abbreviate  $x\mathbf{1}_{\theta} := x \otimes \mathbf{1}_{\theta} \in \mathbb{M}(\theta)$  for  $x \in \mathbf{G}$ . It is not difficult to see that  $\mathbb{M}(\theta)$  has a basis  $\{u\dot{w}\mathbf{1}_{\theta} \mid w \in W, u \in \mathbf{U}_{w^{-1}}\}$  by the Bruhat decomposition, where  $\dot{w}$  is a fixed representative of  $w \in W$ .

For each  $i \in I$ , let  $\mathbf{G}_i$  be the subgroup of  $\mathbf{G}$  generated by  $\mathbf{U}_{\alpha_i}, \mathbf{U}_{-\alpha_i}$  and set  $\mathbf{T}_i = \mathbf{T} \cap \mathbf{G}_i$ . For  $\theta \in \widehat{\mathbf{T}}$ , define the subset  $I(\theta)$  of I by

$$I(\theta) = \{ i \in I \mid \theta | _{\mathbf{T}_i} \text{ is trivial} \}.$$

The Weyl group W acts naturally on  $\widehat{\mathbf{T}}$  by

$$(w \cdot \theta)(t) := \theta^w(t) = \theta(\dot{w}^{-1}t\dot{w})$$

for any  $\theta \in \widehat{\mathbf{T}}$ .

Let  $J \subset I(\theta)$ , and  $\mathbf{G}_J$  be the subgroup of  $\mathbf{G}$  generated by  $\mathbf{G}_i$ ,  $i \in J$ . We choose a representative  $\dot{w} \in \mathbf{G}_J$  for each  $w \in W_J$  (the standard parabolic subgroup of W). Thus, the element  $w\mathbf{1}_{\theta} := \dot{w}\mathbf{1}_{\theta}$  ( $w \in W_J$ ) is well-defined. For  $J \subset I(\theta)$ , we set

$$\eta(\theta)_J = \sum_{w \in W_J} (-1)^{\ell(w)} w \mathbf{1}_{\theta},$$

where  $\ell$  is the length function on W. Let  $\mathbb{M}(\theta)_J = \mathbb{k} \mathbf{G} \eta(\theta)_J$  the  $\mathbb{k} \mathbf{G}$ -module which is generated by  $\eta(\theta)_J$ .

For  $w \in W$ , denote by  $\mathscr{R}(w) = \{i \in I \mid ws_i < w\}$ . For any subset  $J \subset I$ , we set

 $X_J = \{x \in W \mid x \text{ has minimal length in } xW_J\}.$ 

We have the following proposition.

**Proposition 2.1.** [6, Proposition 2.5] For any  $J \subset I(\theta)$ , the kG-module  $\mathbb{M}(\theta)_J$  has the form

(2.1) 
$$\mathbb{M}(\theta)_J = \sum_{w \in X_J} \mathbb{k} \mathbf{U} \dot{w} \eta(\theta)_J = \sum_{w \in X_J} \mathbb{k} \mathbf{U}_{w_J w^{-1}} \dot{w} \eta(\theta)_J$$

In particular, the set  $\{u\dot{w}\eta(\theta)_J \mid w \in X_J, u \in \mathbf{U}_{w_J w^{-1}}\}$  forms a basis of  $\mathbb{M}(\theta)_J$ .

For  $J \subset I(\theta)$ , define

$$E(\theta)_J = \mathbb{M}(\theta)_J / \mathbb{M}(\theta)'_J,$$

where  $\mathbb{M}(\theta)'_J$  is the sum of all  $\mathbb{M}(\theta)_K$  with  $J \subsetneq K \subset I(\theta)$ . We denote by  $C(\theta)_J$  the image of  $\eta(\theta)_J$  in  $E(\theta)_J$ . We also set

$$Z_J = \{ w \in X_J \mid \mathscr{R}(ww_J) \subset J \cup (I \setminus I(\theta)) \}.$$

The following proposition gives a basis of  $E(\theta)_J$ .

**Proposition 2.2.** [6, Proposition 2.7] For  $J \subset I(\theta)$ , we have

(2.2) 
$$E(\theta)_J = \sum_{w \in Z_J} \mathbb{k} \mathbf{U}_{w_J w^{-1}} \dot{w} C(\theta)_J.$$

In particular, the set  $\{u\dot{w}C(\theta)_J \mid w \in Z_J, u \in \mathbf{U}_{w_Jw^{-1}}\}$  forms a basis of  $E(\theta)_J$ .

The  $\mathbb{k}\mathbf{G}$ -modules  $E(\theta)_J$  are irreducible and thus we get all the composition factors of  $\mathbb{M}(\theta)$  (see [6, Theorem 3.1]). According to [6, Proposition 2.8], one has that  $E(\theta_1)_{K_1}$  is isomorphic to  $E(\theta_2)_{K_2}$  as  $\mathbb{k}\mathbf{G}$ -modules if and only if  $\theta_1 = \theta_2$  and  $K_1 = K_2$ .

For a **kG**-module M, an element  $\xi \in M$  is called a **T**-eigenvector if  $t\xi = \lambda(t)\xi$  for some  $\lambda \in \widehat{\mathbf{T}}$ . Set  $M_{\lambda} = \{\xi \in M \mid t\xi = \lambda(t)\xi\}$ , which is called the weight space corresponding to  $\lambda \in \widehat{\mathbf{T}}$ . A character  $\lambda \in \widehat{\mathbf{T}}$  is called a weight of M if  $M_{\lambda} \neq 0$  and then we denote the weight set of M by Wt(M). Let  $M^{\mathbf{T}} = \bigoplus_{\lambda \in \widehat{\mathbf{T}}} M_{\lambda}$  and set  $\mathfrak{d}(M) = \dim M^{\mathbf{T}}$ . With previous discussion and

the form of  $\mathbb{M}(\theta)_J$  and  $E(\theta)_J$  (see (2.1) and (2.2)), we are interested in the  $\mathbb{K}\mathbf{G}$ -module M which satisfies the following condition:

(\*)  $n = \mathfrak{d}(M) < +\infty$  and there exist **T**-eigenvectors  $\xi_1, \xi_2, \dots, \xi_n$  such that  $M \cong \bigoplus_n \Bbbk \mathbf{U} \xi_i$  as  $\Bbbk \mathbf{B}$ -modules.

Let  $\mathscr{C}(\mathbf{G})$  be the full subcategory of  $\Bbbk \mathbf{G}$ -Mod, which consists of the  $\Bbbk \mathbf{G}$ modules satisfying the condition ( $\star$ ). From the definition of  $\mathscr{C}(\mathbf{G})$ , it seems

very difficult to judge whether it is an abelian category. Naturally, we have the following fundamental questions: (1) Is the category  $\mathscr{C}(\mathbf{G})$  an abelian category? (2) Is this category noetherian or artinian? (3) Classify all the simple objects in  $\mathscr{C}(\mathbf{G})$ . We will solve these problems for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$  in the following discussion.

## 3. SIMPLE MODULES WITH **T**-STABLE LINES.

From now on, let  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ ,  $\mathbf{T}$  be the diagonal matrices and  $\mathbf{U}$  be the strictly upper unitriangular matrices in  $SL_2(\bar{\mathbb{F}}_q)$ . Let  $\mathbf{B}$  be the Borel subgroup generated by  $\mathbf{T}$  and  $\mathbf{U}$ , which is the upper triangular matrices in  $SL_2(\bar{\mathbb{F}}_q)$ . As before, let  $\mathbf{N}$  be the normalizer of  $\mathbf{T}$  in  $\mathbf{G}$  and  $W = \mathbf{N}/\mathbf{T}$  be the Weyl group. We set  $\dot{s} = \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}$ , which is the simple reflection of W. There are two natural isomorphisms

$$h: \bar{\mathbb{F}}_q^* \to \mathbf{T}, \ h(c) = \begin{pmatrix} c & 0\\ 0 & c^{-1} \end{pmatrix}; \quad \varepsilon: \bar{\mathbb{F}}_q \to \mathbf{U}, \ \varepsilon(x) = \begin{pmatrix} 1 & x\\ 0 & 1 \end{pmatrix}$$

which satisfies  $h(c)\varepsilon(x)h(c)^{-1} = \varepsilon(c^2x)$ . The simple root  $\alpha : \mathbf{T} \to \overline{\mathbb{F}}_q^*$  is given by  $\alpha(h(c)) = c^2$ . Moreover, one has that

(3.1) 
$$\dot{s}\varepsilon(x)\dot{s} = \varepsilon(-x^{-1})\dot{s}h(-x)\varepsilon(-x^{-1}).$$

In the following we often denote  $\theta(x) := \theta(h(x))$  simply. For any finite subset X of **G**, let  $\overline{X} := \sum_{x \in X} x \in \mathbb{k}\mathbf{G}$ . This notation will be frequently used later.

later.

In order to understand the irreducible  $\Bbbk \mathbf{G}$ -modules with  $\mathbf{T}$ -stable lines, it is enough to study the simple quotients of the induced module  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$  for each  $\theta \in \widehat{\mathbf{T}}$ . It is not difficult to see that  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta} \cong \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta^s}$  as  $\Bbbk \mathbf{G}$ -modules. We will consider the following two cases: (1)  $\theta$  is trivial; (2)  $\theta$  is nontrivial. When  $\theta$  is trivial, it is easy to see that

$$\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\operatorname{tr}} \cong \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{+} \oplus \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-},$$

where  $\mathbb{k}_+$  is the trivial representation of  $\mathbb{N}$  and  $\mathbb{k}_-$  is the sign representation of W, which also can be regarded as a representation of  $\mathbb{N}$ .

In our case  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ , according to [6, Theorem 3.1],  $\mathbb{M}(\mathrm{tr}) = \mathrm{Ind}_{\mathbf{B}}^{\mathbf{G}} \mathbb{k}_{\mathrm{tr}}$ has a unique submodule St (the Steinberg module) and the corresponding quotient module is trivial. The Steinberg module St =  $\mathbb{k} \mathbf{U} \eta_s$ , where  $\eta_s =$  $(1-s)\mathbf{1}_{\mathrm{tr}}$ . Then we have  $\dot{s}\eta_s = -\eta_s$  and  $\dot{s}\varepsilon(x)\eta_s = (\varepsilon(-x^{-1})-1)\eta_s$  for  $x \neq 0$ 

by (3.1). For any nontrivial character  $\theta \in \widehat{\mathbf{T}}$ ,  $\mathbb{M}(\theta) = \operatorname{Ind}_{\mathbf{B}}^{\mathbf{G}} \Bbbk_{\theta}$  is a simple  $\Bbbk \mathbf{G}$ -module. The main theorem of this section is as following.

**Theorem 3.1.** (1) The trivial  $\Bbbk \mathbf{G}$ -module  $\Bbbk_{\mathrm{tr}}$  is the unique simple quotient module of  $\mathrm{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{+}$  and the Steinberg module St is the unique simple quotient module of  $\mathrm{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-}$ . (2) When  $\theta$  is nontrivial,  $\mathrm{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$  has just two simple quotient modules  $\mathbb{M}(\theta)$  and  $\mathbb{M}(\theta^{s})$ .

Proof of Theorem 3.1(1). For convenience, we abbreviate  $x\mathbf{1}_+ := x \otimes \mathbf{1}_+ \in$ Ind<sup>**G**</sup><sub>**N**</sub> $\Bbbk_+$  and  $x\mathbf{1}_- := x \otimes \mathbf{1}_- \in$  Ind<sup>**G**</sup><sub>**N**</sub> $\Bbbk_-$  for  $x \in \mathbf{G}$ , where  $\mathbf{1}_+$  (resp.  $\mathbf{1}_-$ ) is a fixed nonzero element in  $\Bbbk_+$  (resp.  $\Bbbk_-$ ). Firstly we consider the simple quotient of Ind<sup>**G**</sup><sub>**N**</sub> $\Bbbk_+$ . We construct a submodule of Ind<sup>**G**</sup><sub>**N**</sub> $\Bbbk_+$  as following

$$\mathbb{M}_+ = \{\sum_{g \in \mathbf{G}} a_g g \mathbf{1}_+ \mid \sum_{g \in \mathbf{G}} a_g = 0\}$$

Then it is easy to see that  $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{+} / \mathbb{M}_{+}$  is the trivial  $\Bbbk \mathbf{G}$ -module. Now let  $\xi \notin \mathbb{M}_{+}$  which has the following expression

$$\xi = \sum_{x,y \in \bar{\mathbb{F}}_q} a_{x,y} \varepsilon(x) \dot{s} \varepsilon(y) \mathbf{1}_+$$

where  $\sum_{x,y\in \overline{\mathbb{F}}_q} a_{x,y} \neq 0$ . Firstly there exists an integer  $m \in \mathbb{N}$  such that  $x, y \in \mathbb{F}_q$ .

 $\mathbb{F}_{q^m}$  when  $a_{x,y} \neq 0$ . Now let n > m with  $m \mid n$  and  $u \in \mathbb{F}_{q^n} \setminus \mathbb{F}_{q^m}$ . We consider the element  $\eta = \dot{s}\varepsilon(u)\xi$ , which has the form

$$\eta = \sum_{x,y \in \bar{\mathbb{F}}_q} a_{x,y} \varepsilon (-(u+x)^{-1}) \dot{s} \varepsilon ((u+x) - (u+x)^2 y) \mathbf{1}_+.$$

Choose  $\mathfrak{D}_{q^n} \subset \mathbf{T}$  such that  $\alpha : \mathfrak{D}_{q^n} \to \mathbb{F}_{q^n}^*$  is a bijection. Thus it is easy to check the element

$$\overline{\mathfrak{D}_{q^n}} \ \overline{U_{q^n}} \eta = (\sum_{x,y \in \overline{\mathbb{F}}_q} a_{x,y}) \overline{U_{q^n}} \dot{s} \overline{U_{q^n}^*} \mathbf{1}_+ \in \Bbbk \mathbf{G1}_+$$

which implies that  $\overline{U_{q^n}}\dot{s}\overline{U_{q^n}}\mathbf{1}_+ \in \mathbf{k}\mathbf{G}\xi.$ 

On the other hand, we consider the element

$$\overline{G_{q^n}}\xi = (\sum_{x,y\in \overline{\mathbb{F}}_q} a_{x,y})\overline{G_{q^n}}\mathbf{1}_+ \in \Bbbk \mathbf{G}\xi.$$

Noting that

$$\overline{G_{q^n}}\mathbf{1}_+ = (q^n - 1)(2\overline{U_{q^n}}\mathbf{1}_+ + \overline{U_{q^n}}\dot{s}\overline{U_{q^n}}\mathbf{1}_+) \in \Bbbk\mathbf{G}\xi,$$

 $\mathbf{6}$ 

therefore we have  $\overline{U_{q^n}}\mathbf{1}_+ \in \mathbb{k}\mathbf{G}\xi$  and hence  $\mathbf{1}_+ \in \mathbb{k}\mathbf{G}\xi$  by [10, Lemma 2.6]. Thus for any element  $\xi \notin \mathbb{M}_+$ , we have  $\mathbb{k}\mathbf{G}\xi = \mathrm{Ind}_{\mathbf{N}}^{\mathbf{G}}\mathbb{k}_+$ . So, the trivial module is the unique simple quotient module of  $\operatorname{Ind}_{N}^{\mathbf{G}} \Bbbk_{+}$ .

Now we consider the simple quotient modules of  $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-}$ . For convenience, we denote by

$$\Lambda(z) = (\dot{s}\varepsilon(z) + 1 - \varepsilon(-z^{-1}))\mathbf{1}_{-}$$

for each  $z \in \overline{\mathbb{F}}_q^*$ . Then we have  $h(c)\Lambda(z) = \Lambda(c^{-2}z)$  for any  $h(c) \in \mathbf{T}$ . Moreover, it is easy to check that

(3.2) 
$$\varepsilon(z)\Lambda(z^{-1}) = -\Lambda(-z^{-1}), \quad \dot{s}\Lambda(z) = -\Lambda(-z^{-1}),$$
$$\dot{s}\varepsilon(x)\Lambda(y) = \varepsilon(-x^{-1})\Lambda(x(xy-1)) + \Lambda(x) - \Lambda(y^{-1}(xy-1)),$$

where  $xy \neq 1$ . Let  $\mathbb{M}_{-}$  be the submodule of  $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-}$  which is generated by  $\Lambda(z), z \in \overline{\mathbb{F}}_{q}^{*}$ . Since we have the equation

$$\dot{s}\varepsilon(z)\eta_s = (\varepsilon(-z^{-1})-1)\eta_s$$

in the Steinberg module  $St = \mathbf{k} \mathbf{U} \eta_s$ . Thus it is not difficult to see that  $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-} / \mathbb{M}_{-}$  is isomorphic to the Steinberg module.

Let  $\zeta \in \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \Bbbk_{-}$  which is not in  $\mathbb{M}_{-}$ . According to (3.2), then  $\zeta$  has the following expression

$$\zeta = \sum_{xy \neq 1} a_{x,y} \varepsilon(x) \Lambda(y) \mathbf{1}_{-} + \sum_{z \in \bar{\mathbb{F}}_q^*} b_z \Lambda(z) \mathbf{1}_{-} + \sum_{u \in \bar{\mathbb{F}}_q} c_u \varepsilon(u) \mathbf{1}_{-},$$

where  $c_u \neq 0$  for some u. There exists an integer  $m \in \mathbb{N}$  such that  $x, y, z, u \in \mathbb{N}$  $\mathbb{F}_{q^m}$  when  $a_{x,y} \neq 0, b_z \neq 0$  and  $c_u \neq 0$ . Without lost of generality, we can assume that  $c_0 \neq 0$ . Moreover, we can assume that  $\sum_{u \in \overline{\mathbb{F}}_q} c_u \neq 0$ . Otherwise,

we can consider  $\dot{s}\zeta$  instead of  $\zeta$ . Indeed, if we write

$$\dot{s}\zeta = \sum_{xy \neq 1} a'_{x,y} \varepsilon(x) \Lambda(y) \mathbf{1}_{-} + \sum_{z \in \bar{\mathbb{F}}_q^*} b'_z \Lambda(z) \mathbf{1}_{-} + \sum_{u \in \bar{\mathbb{F}}_q} c'_u \varepsilon(u) \mathbf{1}_{-},$$

it is easy to see that  $\sum_{u\in \bar{\mathbb{F}}_q} c'_u = -c_0$  which is nonzero. For the convenience of later discussion, we denote by

$$A = \sum_{xy \neq 1} a_{x,y}, \quad B = \sum_{z \in \overline{\mathbb{F}}_q^*} b_z, \quad C = \sum_{u \in \overline{\mathbb{F}}_q} c_u.$$

Note that C is nonzero by our assumption.

Now let n > m with  $m \mid n$  and  $v \in \mathbb{F}_{q^n} \setminus \mathbb{F}_{q^m}$ . We consider the element

$$\dot{s}\varepsilon(v)\zeta := \sum_{xy\neq 1} f_{x,y}\varepsilon(x)\Lambda(y)\mathbf{1}_{-} + \sum_{z\in\bar{\mathbb{F}}_q^*} g_z\Lambda(z)\mathbf{1}_{-} + \sum_{u\in\bar{\mathbb{F}}_q} h_u\varepsilon(u)\mathbf{1}_{-}.$$

Then by (3.2), we get

(3.3) 
$$\sum_{xy\neq 1} f_{x,y} = A + B, \quad \sum_{z\in\overline{\mathbb{F}}_q^*} g_z = C, \quad \sum_{u\in\overline{\mathbb{F}}_q} h_u = 0.$$

Choose  $\mathfrak{D}_{q^n} \subset \mathbf{T}$  such that  $\alpha : \mathfrak{D}_{q^n} \to \mathbb{F}_{q^n}^*$  is a bijection. Combining (3.3), it is not difficult to get

(3.4) 
$$\overline{\mathfrak{D}_{q^n}} \, \overline{U_{q^n}} \dot{s}\varepsilon(v)\zeta = (A+B+C)\overline{U_{q^n}} \dot{s}\overline{U_{q^n}} \mathbf{1}_- \in \Bbbk \mathbf{G}\zeta.$$

On the other hand, we also have

(3.5) 
$$\overline{\mathfrak{D}_{q^n}} \, \overline{U_{q^n}} \zeta = (A+B) \overline{U_{q^n}} \dot{s} \overline{U_{q^n}} \mathbf{1}_- + (q^n-1) C \overline{U_{q^n}} \mathbf{1}_- \in \mathbb{k} \mathbf{G} \zeta.$$

If  $A + B + C \neq 0$  and noting that  $C \neq 0$ , then we get  $\overline{U_{q^n}} \mathbf{1}_- \in \mathbb{k}\mathbf{G}\zeta$  using (3.4) and (3.5). Now assume that A + B + C = 0, then by (3.5), we have

$$\zeta' := \overline{U_{q^n}} \dot{s} \overline{U_{q^n}} \mathbf{1}_- - (q^n - 1) \overline{U_{q^n}} \mathbf{1}_- \in \mathbb{k} \mathbf{G} \zeta.$$

Noting that  $\zeta'$  can be written as

$$\begin{aligned} \zeta' &= \sum_{z \in \mathbb{F}_{q^n}^*} \overline{U_{q^n}} \Lambda(z) \mathbf{1}_{-} - (q^n - 1) \overline{U_{q^n}} \mathbf{1}_{-} \\ &= \sum_{x, y \in \mathbb{F}_{q^n}^*, xy \neq 1} \varepsilon(x) \Lambda(y) \mathbf{1}_{-} - (q^n - 1) \overline{U_{q^n}} \mathbf{1}_{-} \end{aligned}$$

using (3.2), thus it is not difficult to see that the sum of the coefficients in  $\zeta'$  is  $-2(q^n - 1)$ . So we can discuss  $\zeta'$  instead of  $\zeta$  form the beginning and also have  $\overline{U_{q^n}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta$ .

In conclusion, we have  $\overline{U_{q^n}}\mathbf{1}_- \in \mathbb{k}\mathbf{G}\zeta$  and thus we get  $\mathbf{1}_- \in \mathbb{k}\mathbf{G}\zeta$  by [10, Lemma 2.6]. Then for any element  $\zeta \notin \mathbb{M}_-$ , we see that  $\mathbb{k}\mathbf{G}\zeta = \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}}\mathbb{k}_-$ . So, the Steinberg module is the unique simple quotient module of  $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}}\mathbb{k}_-$ . Hence Theorem 3.1(1) is proved.

Before the proof of Theorem 3.1(2), we need to introduce some properties of the nontrivial group homomorphisms from  $\overline{\mathbb{F}}_q^*$  to  $\mathbb{k}^*$ , where  $\mathbb{k}$  is an algebraically closed field of characteristic 0 as before.

**Proposition 3.2.** Let  $\lambda : \overline{\mathbb{F}}_q^* \to \mathbb{k}^*$  be a nontrivial group homomorphism and  $u_1, u_2, \ldots, u_n \in \overline{\mathbb{F}}_q^*$ , which are different from each other. Let  $x_1, x_2, \ldots, x_n$  be *n* variables with values in  $\overline{\mathbb{F}}_q^*$ . Denote by  $\mathbf{u} = (u_1, u_2, \ldots, u_n)$  and by

 $\mathbf{x} = (x_1, x_2, \dots, x_n)$ . Let  $A_{\mathbf{u}}^{\lambda}(\mathbf{x})$  be the matrix whose entry in row *i* and column *j* is  $\lambda(x_i + u_j)$ . Thus there exist infinitely many  $\mathbf{x} \in (\bar{\mathbb{F}}_q^*)^n$  such that det  $A_{\mathbf{u}}^{\lambda}(\mathbf{x}) \neq 0$ .

*Proof.* The lemma is obvious when n = 1. Assume that this proposition holds when  $n \leq m$ . Now we consider the case for n = m + 1. We set

$$\mathbf{u}^k = (u_1, \dots, u_{k-1}, u_{k+1}, \dots, u_{m+1}), \quad \mathbf{x}' = (x_1, x_2, \dots, x_m).$$

By cofactor expansion respect to the last row, we have

$$\det A_{\mathbf{u}}^{\lambda}(\mathbf{x}) = \sum_{k=1}^{m+1} (-1)^{m+1+k} \lambda(x_{m+1} + u_k) \det A_{\mathbf{u}^k}^{\lambda}(\mathbf{x}').$$

For each fixed integer k = 1, 2, ..., m+1, we have infinitely many  $\mathbf{x}' \in (\bar{\mathbb{F}}_q^*)^m$  such that det  $A_{\mathbf{u}^k}^{\lambda}(\mathbf{x}') \neq 0$  by the inductive hypothesis. Hence it is enough to show that for any element  $a_1, a_2, ..., a_{m+1} \in \mathbb{k}^*$ , there exists an element  $x_0 \in \bar{\mathbb{F}}_q^*$  such that

(3.6) 
$$a_1\lambda(x_0+u_1)+a_2\lambda(x_0+u_2)+\cdots+a_{m+1}\lambda(x_0+u_{m+1})\neq 0.$$

For an integer s, we let  $\Gamma_s = \lambda(\mathbb{F}_{q^s}^*)$ , which is a finite cyclic group in  $\mathbb{k}^*$ . Set  $b_k = -a_k/a_{m+1}$  and we deal with the following equation

$$b_1 y_1 + b_2 y_2 + \dots + b_m y_m = 1$$

with solutions  $\mathbf{y} = (y_1, y_2, \dots, y_m) \in (\Gamma_s)^m$ . Denote the solution set of this equation by  $S(\mathbf{b}, \Gamma_s)$ . Then by [11, Theorem 1.1], for any  $s \in \mathbb{N}$ , we have  $|S(\mathbf{b}, \Gamma_s)| \leq \mathbb{C}(m)$  for some integer  $\mathbb{C}(m)$  only depends on m. Since  $\lambda : \overline{\mathbb{F}}_q^* \to \mathbb{k}^*$  is nontrivial and then we can choose the integer s large enough such that

$$|\Gamma_s/\ker\lambda| > \mathcal{C}(m) + m.$$

Thus there exists  $x_0 \in \overline{\mathbb{F}}_q^*$  such that  $x_0 + u_j \neq 0$  for any  $j = 1, 2, \ldots, m+1$  and (3.6) holds. The proposition is proved.

According to the above proof of Proposition 3.2, we get the following corollary immediately.

**Corollary 3.3.** Let  $\lambda : \overline{\mathbb{F}}_q^* \to \mathbb{k}^*$  be a nontrivial group homomorphism and  $u_1, u_2, \ldots, u_n \in \overline{\mathbb{F}}_q^*$ , which are different from each other. Given  $a_1, a_2, \ldots, a_n \in \mathbb{k}^*$ , then there exists infinitely many elements  $x \in \overline{\mathbb{F}}_q^*$  such that

$$a_1\lambda(x+u_1) + a_2\lambda(x+u_2) + \dots + a_n\lambda(x+u_n) \neq 0.$$

**Remark 3.4.** Proposition 3.2 and Corollary 3.3 do not hold when  $\mathbb{k} = \overline{\mathbb{F}}_q$ . Indeed, we can choose q elements  $u_1, u_2, \ldots, u_q \in \overline{\mathbb{F}}_q^*$ , which are different from each other and satisfy  $u_1^q + u_2^q + \cdots + u_q^q = 0$ . Let  $\lambda : \overline{\mathbb{F}}_q^* \to \overline{\mathbb{F}}_q^*$  be a group homomorphism such that  $\lambda(x) = x^q$ . Then it is easy to see that

$$\lambda(x+u_1) + \lambda(x+u_2) + \dots + \lambda(x+u_q) = 0$$

for any  $x \in \overline{\mathbb{F}}_q^*$  with  $x + u_i \neq 0$ , which is a counter example to Proposition 3.2 and Corollary 3.3. However I guess that Proposition 3.2 and Corollary 3.3 still hold when char  $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_q$ . Other methods need to be developed.

With the above preparations, now we prove Theorem 3.1(2).

Proof of Theorem 3.1(2). Let  $\varphi_e : \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta} \to \mathbb{M}(\theta)$  be the natural morphism such that  $\varphi_e(\mathbf{1}_{\theta}) = \widehat{\mathbf{1}}_{\theta}$ , where  $\widehat{\mathbf{1}}_{\theta}$  is a fixed nonzero element in  $\mathbb{M}(\theta)_{\theta}$ . Let  $\varphi_s : \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta} \to \mathbb{M}(\theta^s)$  be the morphism such that  $\varphi_s(\mathbf{1}_{\theta}) = \dot{s}\widehat{\mathbf{1}}_{\theta^s}$ . Both  $\mathbb{M}(\theta)$  and  $\mathbb{M}(\theta^s)$  are the simple quotient modules of  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$ . Now let  $\xi$  be a nonzero element in  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$ . We will show that  $\Bbbk \mathbf{G}\xi = \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$  if  $\xi \notin \ker \varphi_e$  and  $\xi \notin \ker \varphi_s$ . Thus  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \Bbbk_{\theta}$  has no other simple quotient modules except  $\mathbb{M}(\theta)$  and  $\mathbb{M}(\theta^s)$ .

Claim ( $\clubsuit$ ): One has that  $\overline{U_{q^n}}\dot{s}\overline{U_{q^n}}\mathbf{1}_{\theta} \in \mathbf{k}\mathbf{G}\xi$  when  $\xi \notin \ker \varphi_e$ .

Proof of Claim ( $\clubsuit$ ): Now we write  $\xi$  as following

$$\xi = \sum_{x \in \bar{\mathbb{F}}_q} a_x \varepsilon(x) \mathbf{1}_{\theta} + \sum_{y, z \in \bar{\mathbb{F}}_q} b_{y, z} \varepsilon(y) \dot{s} \varepsilon(z) \mathbf{1}_{\theta}.$$

Noting that  $\xi \notin \ker \varphi_e$ , the following equation

$$\varphi_e(\xi) = \sum_{x \in \bar{\mathbb{F}}_q} a_x \widehat{\mathbf{1}}_{\theta} + \sum_{y, z \in \bar{\mathbb{F}}_q} b_{y, z} \varepsilon(y) \dot{s} \widehat{\mathbf{1}}_{\theta} \neq 0$$

tells us that  $\sum_{x\in\bar{\mathbb{F}}_q} a_x \neq 0$  or  $\sum_{z\in\bar{\mathbb{F}}_q} b_{y,z} \neq 0$  for some y. Without lost of generality, we can assume that  $\sum_{x\in\bar{\mathbb{F}}_q} a_x \neq 0$ . Otherwise, it is enough to consider the element  $\dot{s}^{-1}\varepsilon(-y_0)\xi$  instead of  $\xi$ . Moreover, we can also assume that  $\sum_{x\in\bar{\mathbb{F}}_q} a_x + \sum_{y,z\in\bar{\mathbb{F}}_q} b_{y,z} \neq 0$ . Otherwise, we can consider the element  $t\xi$  for some  $t\in\mathbf{T}$  instead of  $\xi$ . Indeed, it is easy to see that the sum of the coefficients

 $t \in \mathbf{T}$  instead of  $\xi$ . Indeed, it is easy to see that the sum of the coefficients in  $t\xi$  is

(3.7) 
$$\theta(t) \sum_{x \in \overline{\mathbb{F}}_q} a_x + \theta^s(t) \sum_{y, z \in \overline{\mathbb{F}}_q} b_{y,z}.$$

Noting that  $\sum_{x\in\bar{\mathbb{F}}_q} a_x$  and  $\sum_{y,z\in\bar{\mathbb{F}}_q} b_{y,z}$  are nonzero, we can choose one  $t\in\mathbf{T}$ 

such that (3.7) is nonzero since  $\theta$  is nontrivial.

With the assumption that

$$\sum_{x\in\bar{\mathbb{F}}_q} a_x \neq 0 \quad \text{and} \quad \sum_{x\in\bar{\mathbb{F}}_q} a_x + \sum_{y,z\in\bar{\mathbb{F}}_q} b_{y,z} \neq 0,$$

we show that  $\overline{U_{q^n}}\dot{s}\overline{U_{q^n}^*} \in \mathbb{k}\mathbf{G}\xi$  for some  $n \in \mathbb{N}$ . Firstly there exists  $m \in \mathbb{N}$  such that  $x, y, z \in \mathbb{F}_{q^m}$  when  $a_x \neq 0$  and  $b_{y,z} \neq 0$ . Let n > m and m|n. Given an element  $u \in \mathbb{F}_{q^n} \setminus \mathbb{F}_{q^m}$ , then the element  $\eta := \dot{s}\varepsilon(u)\xi$  has the following form

$$\eta = \sum_{x \in \bar{\mathbb{F}}_q} a_x \dot{s} \varepsilon(u+x) \mathbf{1}_{\theta} + \sum_{y,z \in \bar{\mathbb{F}}_q} b'_{y,z} \varepsilon(-(u+y)^{-1}) \dot{s} \varepsilon((u+y)^2 z - (u+y)) \mathbf{1}_{\theta},$$

where  $b'_{y,z} = b_{y,z}\theta(h(-(u+y)))$ . Thus if we denote by  $\eta$  as following

$$\eta = \sum_{x,y \in \bar{\mathbb{F}}_q} f_{x,y} \varepsilon(x) \dot{s} \varepsilon(y) \mathbf{1}_{\theta},$$

then we get  $f_x := \sum_{y \in \overline{\mathbb{F}}_q} f_{x,y} \neq 0$  for some x. Let  $v \in \overline{\mathbb{F}}_q^*$  such that  $v + x \neq 0$ 

when  $f_{x,y} \neq 0$  and we consider the element

$$\zeta := \dot{s}\varepsilon(v)\eta = \sum_{x,y\in\bar{\mathbb{F}}_q} f_{x,y}\theta(h(-(v+x)))\varepsilon(-(v+x)^{-1})\dot{s}\varepsilon((v+x)^2y - (v+x))\mathbf{1}_{\theta}$$

By Lemma 3.3, we can choose some element v such that the elements  $(v + x)^2 y - (v + x)$  are nonzero when  $f_{x,y} \neq 0$  and this element v also makes

$$f := \sum_{x \in \overline{\mathbb{F}}_q} f_x \theta(h(-(v+x))) \neq 0.$$

As before we choose  $\mathfrak{D}_{q^n} \subset \mathbf{T}$  such that  $\alpha : \mathfrak{D}_{q^n} \to \mathbb{F}_{q^n}^*$  is a bijection. Therefore we get

$$\sum_{t\in\mathfrak{D}_{q^n}}\theta^s(t)^{-1}t\overline{U_{q^n}}\zeta=f\overline{U_{q^n}}\dot{s}\overline{U_{q^n}}\mathbf{1}_{\theta}$$

which implies that  $\overline{U_{q^n}} \dot{s} \overline{U_{q^n}} \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$ . Claim ( $\clubsuit$ ) is proved.

Claim ( $\blacklozenge$ ): When  $\xi \notin \ker \varphi_s$ , one has an element

$$\xi' = \sum_{x \in \bar{\mathbb{F}}_q} a_x \varepsilon(x) \mathbf{1}_{\theta} + \sum_{y \in \bar{\mathbb{F}}_q} b_y \varepsilon(y) \dot{s} \mathbf{1}_{\theta} + \sum_{u \in \bar{\mathbb{F}}_q, v \in \bar{\mathbb{F}}_q^*} c_{u,v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta} \in \mathbb{K} \mathbf{G} \xi$$

such that  $\sum_{y\in \bar{\mathbb{F}}_q} b_y \neq 0.$ 

Proof of Claim ( $\blacklozenge$ ): Firstly we study the form of the elements in ker  $\varphi_s$ . Let

$$\varpi_1 = \sum_{x \in \bar{\mathbb{F}}_q} f_x \varepsilon(x) (e + \sum_{u \in \bar{\mathbb{F}}_q} f_{x,u} \theta^s(-u) \varepsilon(u) \dot{s} \varepsilon(u^{-1})) \mathbf{1}_{\theta},$$

where  $\sum_{u\in \overline{\mathbb{F}}_q} f_{x,u} + 1 = 0$  for any  $x\in \overline{\mathbb{F}}_q$  and set

$$\varpi_2 = \sum_{y \in \bar{\mathbb{F}}_q} \varepsilon(y) \sum_{v \in \bar{\mathbb{F}}_q} g_{y,v} \theta^s(-v) \varepsilon(v) \dot{s} \varepsilon(v^{-1}) \mathbf{1}_{\theta},$$

where  $\sum_{v \in \overline{\mathbb{F}}_q} g_{y,v} = 0$  for any  $y \in \overline{\mathbb{F}}_q$ . Moreover we let

$$\varpi_3 = \sum_{z \in \overline{\mathbb{F}}_q} h_z \varepsilon(z) \dot{s} \mathbf{1}_{\theta}, \quad \text{where } \sum_{z \in \overline{\mathbb{F}}_q} h_z = 0.$$

It is easy to check that  $\varpi_1, \varpi_2, \varpi_3 \in \ker \varphi_s$ . Denote by  $\Omega_i$  the set of the elements with the form of  $\varpi_i$  for i = 1, 2, 3. Then it is not difficult to see that each element of  $\ker \varphi_s$  is a linear combination of the elements in  $\Omega_1, \Omega_2$  and  $\Omega_3$ .

Now let  $\xi$  be the following

$$\xi = \sum_{x \in \bar{\mathbb{F}}_q} \alpha_x \varepsilon(x) \mathbf{1}_{\theta} + \sum_{y \in \bar{\mathbb{F}}_q} \beta_y \varepsilon(y) \dot{s} \mathbf{1}_{\theta} + \sum_{u \in \bar{\mathbb{F}}_q, v \in \bar{\mathbb{F}}_q^*} \gamma_{u,v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}$$

If  $\sum_{y\in \bar{\mathbb{F}}_q} \beta_y \neq 0$ , then  $\xi$  has already satisfied our requirement. Otherwise, we can write

 $\xi = \varpi + \sum \quad \tau_{u,v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}, \quad \tau_{u,v} \in \mathbb{k}$ 

$$\zeta = \omega + \sum_{u \in \bar{\mathbb{F}}_q, v \in \bar{\mathbb{F}}_q^*} \gamma_{u,v} \varepsilon(u) s \varepsilon(v) \mathbf{1}_{\theta}, \quad \gamma_{u,v} \in$$

such that  $\varpi \in \ker \varphi_s$ . Since  $\xi \notin \ker \varphi_s$ , the element

$$\eta := \sum_{u \in \bar{\mathbb{F}}_q, v \in \bar{\mathbb{F}}_q^*} \tau_{u,v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}$$

is not in ker  $\varphi_s$  and in particular, it is not in  $\Omega_2$ . Now for  $x \in \overline{\mathbb{F}}_q$ , set

$$\Xi_x = \{(u, v) \mid \tau_{u, v} \neq 0 \text{ and } (u - x)v = 1\}.$$

Since  $\eta \notin \ker \varphi_s$ , there exist an element  $x_0$  such that

(3.8) 
$$\sum_{(u,v)\in\Xi_{x_0}}\tau_{u,v}\theta^s(-v)\neq 0$$

by some easy computation. Now we consider the following element

$$\xi' = \dot{s}\varepsilon(-x_0)\xi = \dot{s}\varepsilon(-x_0)(\varpi + \eta).$$

Firstly, we have  $\dot{s}\varepsilon(-x_0)\varpi \in \ker \varphi_s$ , which is a linear combination of elements in  $\Omega_1, \Omega_2$  and  $\Omega_3$ . For the second part  $\dot{s}\varepsilon(-x_0)\eta$ , it is easy to check that when  $(u, v) \notin \Xi_{x_0}$ , the element

$$\dot{s}\varepsilon(-x_0)\varepsilon(u)\dot{s}\varepsilon(v)\mathbf{1}_{\theta} = \varepsilon(u')\dot{s}\varepsilon(v')\mathbf{1}_{\theta}$$

for some  $u' \in \overline{\mathbb{F}}_q$  and  $v' \in \overline{\mathbb{F}}_q^*$ . On the other hand, for  $(u, v) \in \Xi_{x_0}$ , we have

$$\dot{s}\varepsilon(-x_0)\sum_{(u,v)\in\Xi_{x_0}}\tau_{u,v}\varepsilon(u)\dot{s}\varepsilon(v)\mathbf{1}_{\theta}=\sum_{(u,v)\in\Xi_{x_0}}\tau_{u,v}\theta(-v^{-1})\varepsilon(-v)\dot{s}\mathbf{1}_{\theta}.$$

Noting that  $\theta(-v^{-1}) = \theta^s(-v)$  and using (3.8), it is easy to check that  $\xi' = \dot{s}\varepsilon(-x_0)\xi \in \mathbf{k}\mathbf{G}\xi$  satisfies our requirement.

With Claim ( $\clubsuit$ ) and Claim ( $\bigstar$ ), now we give the proof of Theorem 3.1(2). Let  $\xi$  be an element such that  $\xi \notin \ker \varphi_e$  and  $\xi \notin \ker \varphi_s$ . By Claim ( $\bigstar$ ), there exists an element

$$\xi' = \sum_{x \in \bar{\mathbb{F}}_q} a_x \varepsilon(x) \mathbf{1}_{\theta} + \sum_{y \in \bar{\mathbb{F}}_q} b_y \varepsilon(y) \dot{s} \mathbf{1}_{\theta} + \sum_{u \in \bar{\mathbb{F}}_q, v \in \bar{\mathbb{F}}_q^*} c_{u,v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta} \in \Bbbk \mathbf{G} \xi$$

such that  $\sum_{y\in \overline{\mathbb{F}}_q} b_y \neq 0$ . We denote by

$$A = \sum_{x \in \overline{\mathbb{F}}_q} a_x, \quad B := \sum_{y \in \overline{\mathbb{F}}_q} b_y, \quad C = \sum_{u \in \overline{\mathbb{F}}_q, v \in \overline{\mathbb{F}}_q^*} c_{u,v}$$

for simple. Let  $n \in \mathbb{N}$  such that  $x, y, u, v \in \mathbb{F}_{q^n}$  when  $a_x \neq 0, b_y \neq 0$  and  $c_{u,v} \neq 0$ . As before we choose  $\mathfrak{D}_{q^n} \subset \mathbf{T}$  such that  $\alpha : \mathfrak{D}_{q^n} \to \mathbb{F}_{q^n}^*$  is a bijection. Hence it is not difficult to see that

$$\sum_{t\in\mathfrak{D}_{q^n}}\theta^s(t)^{-1}t\overline{U_{q^n}}\xi' = A\sum_{t\in\mathfrak{D}_{q^n}}\theta(t^2)\mathbf{1}_{\theta} + (q^n-1)B\overline{U_{q^n}}\dot{s}\mathbf{1}_{\theta} + C\overline{U_{q^n}}\dot{s}\overline{U_{q^n}}\mathbf{1}_{\theta},$$

which is in  $\mathbb{k}\mathbf{G}\xi$ . When *n* is big enough and  $\theta$  is nontrivial on  $\mathbb{F}_{q^n}^*$ , we have  $\sum_{t\in\mathfrak{D}_{q^n}}\theta(t^2)=0$ . By Claim ( $\clubsuit$ ), we have  $\overline{U_{q^n}}\dot{s}\overline{U_{q^n}^*}\mathbf{1}_{\theta}\in\mathbb{k}\mathbf{G}\xi$  and then we get  $\overline{U_{q^n}}\dot{s}\mathbf{1}_{\theta}\in\mathbb{k}\mathbf{G}\xi$  since *B* is nonzero. So using [10, Lemma 2.6], we have

get  $U_{q^n} s \mathbf{1}_{\theta} \in \mathbb{K} \mathbf{G} \xi$  since *B* is nonzero. So using [10, Lemma 2.0], we have  $\mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$  and thus  $\mathbb{k} \mathbf{G} \xi = \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$ . Therefore the induced module  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$  has only two simple quotient modules  $\mathbb{M}(\theta)$  and  $\mathbb{M}(\theta^s)$ . The theorem is proved.

# 4. Abelian category $\mathscr{C}(\mathbf{G})$

In this section, we show that the category  $\mathscr{C}(\mathbf{G})$  is an abelian category for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ . For convenience, we denote

$$\operatorname{Irr}(\mathbf{G}) = \{ \mathbb{k}_{\operatorname{tr}}, \operatorname{St}, \mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}} \text{ is nontrivial} \}.$$

This is the set of the simple objects in  $\mathscr{C}(\mathbf{G})$ . By [7, Theorem 2.5], the induced module  $\mathrm{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_{\theta}$  has a unique simple  $\Bbbk \mathbf{B}$ -submodule

$$\mathcal{S}_{\theta} = \{ \sum_{x \in \bar{\mathbb{F}}_q} a_x \varepsilon(x) \mathbf{1}_{\theta} \mid \sum_{x \in \bar{\mathbb{F}}_q} a_x = 0 \}$$

and the corresponding quotient module is  $\mathbb{k}_{\theta}$ .

**Lemma 4.1.** Let  $S = S_{tr}$  be the unique simple  $\mathbb{k}\mathbf{B}$ -submodule of  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}}$ tr. Then  $S^n$  (the direct sum of *n*-copies of S) can not assign a  $\mathbb{k}\mathbf{G}$ -module structure for any  $n \in \mathbb{N}$ .

*Proof.* Firstly, each element  $\xi \in S^n$  has the following form

$$\xi = \sum_{j,\mu} f_{j,\mu} (e - \varepsilon(x_{j,\mu})) \lambda_j, \quad \text{where } x_{j,\mu} \in \bar{\mathbb{F}}_q^*, \ f_{j,\mu} \in \mathbb{k},$$

where each  $\lambda_j$  denotes the trivial character for j = 1, 2, ..., n. Suppose  $S^n$  has a  $\Bbbk \mathbf{G}$ -module structure and for each i = 1, 2, ..., n, we set

$$\dot{s}(e-\varepsilon(1))\lambda_i = \sum_{j,\mu} g^i_{j,\mu}(e-\varepsilon(x^i_{j,\mu}))\lambda_j, \quad \text{where } x^i_{j,\mu} \in \bar{\mathbb{F}}^*_q, \ g^i_{j,\mu} \in \Bbbk.$$

Using  $t \in \mathbf{T}$  to act on both sides, then it is not difficult to see that for  $y \in \overline{\mathbb{F}}_q^*$ , we have

$$\dot{s}(e-\varepsilon(y))\lambda_i = \sum_{j,\mu} g^i_{j,\mu}(e-\varepsilon(y^{-1}x^i_{j,\mu}))\lambda_j.$$

Therefore we have

(4.1) 
$$\dot{s}\varepsilon(z)\dot{s}(e-\varepsilon(1))\lambda_{i} = \sum_{j,\mu} g^{i}_{j,\mu}\dot{s}(\varepsilon(z)-\varepsilon(x^{i}_{j,\mu}+z))\lambda_{j}$$
$$= \sum_{j,\mu} g^{i}_{j,\mu}\sum_{k,\nu} g^{j}_{k,\nu}(\varepsilon(z^{-1}x^{j}_{k,\nu})-\varepsilon((x^{i}_{j,\mu}+z)^{-1}x^{j}_{k,\nu}))\lambda_{k}$$

for any element  $z \in \overline{\mathbb{F}}_q^*$  such that  $x_{j,\mu}^i + z \neq 0$ . On the other hand, since  $\dot{s}\varepsilon(z)\dot{s} = \varepsilon(-z^{-1})\dot{s}h(-z)\varepsilon(-z^{-1})$ , we get

(4.2) 
$$\dot{s}\epsilon(z)\dot{s}(e-\varepsilon(1))\lambda_i = \varepsilon(-z^{-1})\dot{s}(\varepsilon(-z)-\varepsilon(z^2-z))\lambda_i$$
  
=  $\sum_{k,\nu} g^i_{k,\nu}(\varepsilon(-z^{-1}(1+x^i_{k,\nu}))-\varepsilon(z^{-1}(z-1)^{-1}(x^i_{k,\nu}-z+1)))\lambda_k$ .

Combining the above two equations (4.1) and (4.2), we get the following

(4.3) 
$$\sum_{j,\mu} g_{j,\mu}^{i} \sum_{k,\nu} g_{k,\nu}^{j} (\varepsilon(z^{-1}x_{k,\nu}^{j}) - \varepsilon((x_{j,\mu}^{i} + z)^{-1}x_{k,\nu}^{j}))\lambda_{k}$$
$$= \sum_{k,\nu} g_{k,\nu}^{i} (\varepsilon(-z^{-1}(1 + x_{k,\nu}^{i})) - \varepsilon(z^{-1}(z - 1)^{-1}(x_{k,\nu}^{i} - z + 1)))\lambda_{k}$$

for any  $z \in \overline{\mathbb{F}}_q^*$  such that  $x_{j,\mu}^i + z \neq 0$  and  $i = 1, 2, \ldots, n$ . However it is not difficult to see that (4.3) is not an identity. Indeed, for any fixed  $i = 1, 2, \ldots, n$ , if there exists  $x_{k_0,\nu_0}^i \neq -1$ , then we can choose one  $z_0 \in \overline{\mathbb{F}}_q^*$ such that  $z_0^{-1}(z_0 - 1)^{-1}(x_{k_0,\nu_0}^i - z_0 + 1))$  is different from the following set

$$\{z_0^{-1}x_{k,\nu}^j, \ (x_{j,\mu}^i+z_0)^{-1}x_{k,\nu}^j, \ -z_0^{-1}(1+x_{k,\nu}^i) \mid g_{k,\nu}^j \neq 0, g_{j,\mu}^i \neq 0, g_{k,\nu}^i \neq 0.\}.$$

If there is only one  $x_{k,\nu}^i = -1$  such that  $g_{k,\nu}^i \neq 0$ , then (4.3) does not hold obviously. Therefore  $S^n$  can not assign a  $\Bbbk \mathbf{G}$ -module structure. The lemma is proved.

In general, using the same discussion as in Lemma 4.1, we have the following proposition.

**Proposition 4.2.** Let  $S_{\lambda}$  be the unique simple  $\Bbbk \mathbf{B}$ -submodule of  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_{\lambda}$  for each  $\lambda \in \widehat{\mathbf{T}}$ . One has that  $\bigoplus_{\lambda \in \widehat{\mathbf{T}}} S_{\lambda}^{n_{\lambda}}$  can not assign a  $\Bbbk \mathbf{G}$ -module structure,

where  $n_{\lambda} \in \mathbb{N}$  and only finitely many  $n_{\lambda}$  are nonzero for  $\lambda \in \widehat{\mathbf{T}}$ .

**Theorem 4.3.** The category  $\mathscr{C}(\mathbf{G})$  is an abelian category.

Proof. Recall the definition of  $\mathscr{C}(\mathbf{G})$  in Section 1, it is enough to show that  $\mathscr{C}(\mathbf{G})$  is closed under taking subquotients. Let M be a  $\Bbbk \mathbf{G}$ -module with  $\mathbf{T}$ -eigenvectors  $\xi_1, \xi_2, \ldots, \xi_n$  such that  $M \cong \bigoplus_{i=1}^n \Bbbk \mathbf{U}\xi_i$  as  $\Bbbk \mathbf{B}$ -modules. Following [7, Theorem 2.5], when  $\xi \in M_\theta$ , each  $\Bbbk \mathbf{U}\xi$  is isomorphic to  $\mathrm{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_\theta$ or  $\Bbbk_\theta$ . Thus M is a  $\Bbbk \mathbf{G}$ -module of finite length. Let N be a simple quotient of M, then N has a  $\mathbf{T}$ -eigenvector which implies  $N \in \mathrm{Irr}(\mathbf{G})$ . The Steinberg module St is isomorphic to  $\mathrm{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_{\mathrm{tr}}$  as  $\Bbbk \mathbf{B}$ -modules and  $\mathbb{M}(\theta)$  is isomorphic

to  $\mathbb{k}_{\theta} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \mathbb{k}_{\theta^{s}}$  as  $\mathbb{k}\mathbf{B}$ -modules. However since  $\bigoplus_{\lambda \in \widehat{\mathbf{T}}} S_{\lambda}^{n_{\lambda}}$  can not assign a  $\mathbb{k}\mathbf{G}$ module structure by Proposition 4.2, it is easy to see that the subquotients
of M are also in  $\mathscr{C}(\mathbf{G})$ . The theorem is proved.

Corollary 4.4. The category  $\mathscr{C}(\mathbf{G})$  is notherian and artinian.

A  $\&\mathbf{G}$ -module can be regarded as a  $\&\mathbf{T}$ -module (resp.  $\&\mathbf{B}$ -module) naturally. We denote by  $\mathscr{C}(\mathbf{G})_{\mathbf{T}}$  (resp.  $\mathscr{C}(\mathbf{G})_{\mathbf{B}}$ ) the full subcategory of  $\&\mathbf{T}$ -Mod (resp.  $\&\mathbf{B}$ -Mod), which consists of the objects in  $\mathscr{C}(\mathbf{G})$ .

**Corollary 4.5.** One has that  $\operatorname{Hom}_{\mathbf{T}}(\Bbbk_{\theta}, -) : \mathscr{C}(\mathbf{G})_{\mathbf{T}} \to \operatorname{Vect}$  is a exact functor for any  $\theta \in \widehat{\mathbf{T}}$ . Thus given a short exact sequence

 $0 \longrightarrow M_1 \longrightarrow M \longrightarrow M_2 \longrightarrow 0$ 

in the category  $\mathscr{C}(\mathbf{G})$ , one has that  $M^{\mathbf{T}} \cong M_1^{\mathbf{T}} \oplus M_2^{\mathbf{T}}$  as **T**-modules. In particular, we have  $\operatorname{Wt}(M) = \operatorname{Wt}(M_1) \cup \operatorname{Wt}(M_2)$ .

*Proof.* Using the setting in [12, Section 2], when k is an algebraically closed field of characteristic zero, k**B** is a locally Wedderburn algebra. Thus by [12, Lemma 3],  $\mathbb{k}_{\theta}$  is an injective k**B**-module which implies the exactness of  $\operatorname{Hom}_{\mathbf{B}}(-,\mathbb{k}_{\theta})$ . For  $M \in \mathscr{C}(\mathbf{G})$ , we have  $M \cong \bigoplus_{i=1}^{n} \mathbb{k}\mathbf{U}\xi_{i}$  as k**B**-modules, where  $\xi_{i} \in M_{\lambda_{i}}$ . By [7, Theorem 2.5], the induced module  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}}\mathbb{k}_{\theta}$  has a unique simple k**B**-submodule  $S_{\theta}$  and the corresponding quotient module is  $\mathbb{k}_{\theta}$ . Thus each  $\mathbb{k}\mathbf{U}\xi_{i}$  is isomorphic to  $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}}\mathbb{k}_{\lambda_{i}}$  or  $\mathbb{k}_{\lambda_{i}}$  as k**B**-modules. Therefore it is easy to see that

$$\operatorname{Hom}_{\mathbf{T}}(\Bbbk_{\theta}, M) \cong \operatorname{Hom}_{\mathbf{B}}(M, \Bbbk_{\theta}),$$

which implies the exactness of  $\operatorname{Hom}_{\mathbf{T}}(\mathbb{k}_{\theta}, -)$ . The rest part is obvious.  $\Box$ 

**Corollary 4.6.** Given a short exact sequence in  $\mathscr{C}(\mathbf{G})$ , then it is split regarded as a short exact sequence in  $\mathscr{C}(\mathbf{G})_{\mathbf{B}}$ .

*Proof.* By the definition of  $\mathscr{C}(\mathbf{G})$  and Proposition 4.2, noting that the set of simple objects in the category  $\mathscr{C}(\mathbf{G})$  is

$$Irr(\mathbf{G}) = \{ \mathbb{k}_{tr}, St, \mathbb{M}(\theta) \mid \theta \in \mathbf{T} \text{ is nontrivial} \},\$$

the corollary is proved.

## 5. Highest weight category

In this section, we show that  $\mathscr{C}(\mathbf{G})$  is a highest weight category for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ . Firstly we recall the definition of highest weight category (see [8]).

**Definition 5.1.** Let  $\mathscr{C}$  be a locally artinian, abelian, k-linear category with enough injective objects that satisfies Grothendieck's condition. Then we call  $\mathscr{C}$  a highest weight category if there exists a locally finite poset  $\Lambda$  (the "weights" of  $\mathscr{C}$ ), such that:

(a) There is a complete collection  $\{S(\lambda)_{\lambda \in \Lambda}\}$  of non-isomorphic simple objects of  $\mathscr{C}$  indexed by the set  $\Lambda$ .

(b) There is a collection  $\{A(\lambda)_{\lambda \in \Lambda}\}$  of objects of  $\mathscr{C}$  and, for each  $\lambda$ , an embedding  $S(\lambda) \subset A(\lambda)$  such that all composition factors  $S(\mu)$  of  $A(\lambda)/S(\lambda)$  satisfy  $\mu < \lambda$ . For  $\lambda, \mu \in \Lambda$ , we have that  $\dim_{\Bbbk} \operatorname{Hom}_{\mathscr{C}}(A(\lambda), A(\mu))$  and  $[A(\lambda) : S(\mu)]$  are finite.

(c) Each simple object S(λ) has an injective envelope I(λ) in C. Also, J(λ) has a good filtration 0 = F<sub>0</sub>(λ) ⊂ F<sub>1</sub>(λ) ⊂ ... such that:
(i) F<sub>1</sub>(λ) ≅ A(λ);
(ii) for n > 1, F<sub>n</sub>(λ)/F<sub>n-1</sub>(λ) ≅ A(μ) for some μ = μ(n) > λ;
(iii) for a given μ ∈ Λ, μ = μ(n) for only finitely many n;
(iv) ∪ F<sub>i</sub>(λ) = I(λ).

Actually, to show that  $\mathscr{C}(\mathbf{G})$  is a highest weight category, the main difficulty is to prove that the category  $\mathscr{C}(\mathbf{G})$  has enough injective objects.

**Proposition 5.2.** For any M, N in  $\mathscr{C}(\mathbf{G})$  such that  $\operatorname{Wt}(M) \cap \operatorname{Wt}(N) = \emptyset$ , we have  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(M, N) = 0$ .

*Proof.* Since each object in  $\mathscr{C}(\mathbf{G})$  is of finite length, it is enough to show that  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(M, N) = 0$  for any simple object  $M, N \in \mathscr{C}(\mathbf{G})$ , where  $\operatorname{Wt}(M) \cap \operatorname{Wt}(N) = \emptyset$ . Recall that  $\operatorname{Irr}(\mathbf{G}) = \{ \Bbbk_{\operatorname{tr}}, \operatorname{St}, \mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}} \text{ is nontrivial} \}$  is the set of simple objects in  $\mathscr{C}(\mathbf{G})$ , we will show that

$$\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \mathbb{M}(\lambda)) = 0, \ \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\mu)) = 0 \ \text{and} \ \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\theta), S) = 0.$$

where S is a simple object whose weights are different with  $\theta$  and  $\theta^s$ .

(1)  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\operatorname{tr}}, \mathbb{M}(\lambda)) = 0$ . Suppose we have a short exact sequence

$$(5.1) 0 \longrightarrow \mathbb{M}(\lambda) \longrightarrow M \longrightarrow \Bbbk_{\mathrm{tr}} \longrightarrow 0$$

in  $\mathscr{C}(\mathbf{G})$ . Then using Corollary 4.6, there exists an element  $\xi \in M$  such that  $z\xi = \xi$  for any  $z \in \mathbf{B}$ . Noting that  $M_{\mathrm{tr}} = \Bbbk \xi$ , thus  $\dot{s}\xi = a\xi$  for some

 $a \in \mathbb{k}^*$ . However the following equation

$$\dot{s}\varepsilon(x)\dot{s}\xi = \varepsilon(-x^{-1})\dot{s}h(-x)\varepsilon(-x^{-1})\xi$$

shows that a must be 1. Therefore the short exact sequence (5.1) is split which implies that  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\operatorname{tr}}, \mathbb{M}(\lambda)) = 0.$ 

(2) 
$$\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\mu)) = 0$$
. Suppose we have a short exact sequence

$$(5.2) 0 \longrightarrow \mathbb{M}(\mu) \longrightarrow N \longrightarrow \mathrm{St} \longrightarrow 0$$

in  $\mathscr{C}(\mathbf{G})$ . By Corollary 4.6, there exists an element  $\eta \in N_{\mathrm{tr}}$  such that  $\dot{s}\eta = b\eta$ for some  $b \in \mathbb{k}^*$  and  $\dot{s}\varepsilon(1)\eta = (\varepsilon(-1) - e)\eta + \varpi$  for some  $\varpi \in \mathbb{M}(\mu)$ . Using  $\dot{s}$  to act on both sides, we get b = -1. Moreover we have

$$\dot{s}\varepsilon(x)\eta = (\varepsilon(-x^{-1}) - e)\eta + h(x^{-\frac{1}{2}})\varpi$$

Now we consider the element  $\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\eta$ . Firstly we have

(5.3) 
$$\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\eta = \varepsilon(-z^{-1})\dot{s}h(-z)\varepsilon(-z^{-1})\varepsilon(1)\eta = \varepsilon(-z^{-1})\dot{s}\varepsilon(z^2-z)\eta.$$

On the other hand, we get

(5.4) 
$$\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\eta = \dot{s}(\varepsilon(z-1) - \varepsilon(z))\eta + \dot{s}\varepsilon(z)\varpi.$$

Compare the above two equations (5.3) and (5.4), it is not difficult to get

(5.5) 
$$\dot{s}\varepsilon(z)\varpi = \varepsilon(-z^{-1})h((z^2-z)^{-\frac{1}{2}}))\varpi + (h(z^{-\frac{1}{2}}) - h((z-1)^{-\frac{1}{2}}))\varpi$$

for any  $z \in \overline{\mathbb{F}}_q$ . Denote by

$$\varpi = f \mathbf{1}_{\mu} + \sum_{x \in \bar{\mathbb{F}}_q} g_x \epsilon(x) \dot{s} \mathbf{1}_{\mu}, \quad \text{where } f, g_x \in \bar{\mathbb{F}}_q.$$

Then it is easy to see that f = 0. Moreover if  $g_x \neq 0$  when  $x \neq 0, -1$ , then (5.5) can not hold for any  $z \in \overline{\mathbb{F}}_q$ . Substitute  $\varpi = a\dot{s}\mathbf{1}_{\mu} + b\varepsilon(-1)\dot{s}\mathbf{1}_{\mu}$  into (5.5) and we get  $\varpi = 0$ . Thus the short exact sequence (5.2) is split which implies that  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\mu)) = 0$ .

(3)  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\theta), S) = 0$  for some simple object S whose weights are different with  $\theta$  and  $\theta^{s}$ . Suppose we have a short exact sequence

$$(5.6) 0 \longrightarrow S \longrightarrow L \longrightarrow \mathbb{M}(\theta) \longrightarrow 0$$

in  $\mathscr{C}(\mathbf{G})$ . Then by Corollary 4.6, there exists  $\zeta \in L_{\theta}$  such that  $u\zeta = \zeta$  and thus  $\dot{s}\zeta \in L_{\theta^s}$  since the weights of S are different with  $\theta$  and  $\theta^s$ . Thus the short exact sequence (5.6) is split and we have  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\theta), S) = 0$ .

**Proposition 5.3.** One has that  $\mathbb{k}_{tr}$  and  $\mathbb{M}(\theta)$  are injective objects in the category  $\mathscr{C}(\mathbf{G})$  for any  $\theta \in \widehat{\mathbf{T}}$ .

*Proof.* By [12, Theorem 1], we see that  $\mathbb{k}_{tr}$  is an injective  $\mathbb{k}\mathbf{G}$ -module and thus it is injective in  $\mathscr{C}(\mathbf{G})$ . According to Proposition 5.2, it is enough to show that

$$\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\operatorname{tr}}, \mathbb{M}(\operatorname{tr})) = 0, \ \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\operatorname{tr}))) = 0, \ \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\lambda), \mathbb{M}(\theta)) = 0,$$
  
where  $\lambda = \theta$  or  $\theta^{s}$ .

(1)  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\operatorname{tr}}, \mathbb{M}(\operatorname{tr})) = 0$ . Since there is a short exact sequence

 $0 \longrightarrow \mathrm{St} \longrightarrow \mathbb{M}(\mathrm{tr}) \longrightarrow \mathbb{k}_{\mathrm{tr}} \longrightarrow 0,$ 

we get a long exact sequence

$$0 \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \operatorname{St}) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \mathbb{M}(\operatorname{tr})) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \Bbbk_{\operatorname{tr}}) \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \operatorname{St}) \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \mathbb{M}(\operatorname{tr})) \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \Bbbk_{\operatorname{tr}}) \longrightarrow \dots$$

It is easy to check that  $\operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \mathbb{M}(\operatorname{tr})) = 0$  and  $\operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \Bbbk_{\operatorname{tr}}) \cong \Bbbk$ . Noting that  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \Bbbk_{\operatorname{tr}}) = 0$  because  $\Bbbk_{\operatorname{tr}}$  is injective in  $\mathscr{C}(\mathbf{G})$ , it is enough to verify that  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\Bbbk_{\operatorname{tr}}, \operatorname{St}) \cong \Bbbk$ . Given a short exact sequence

 $0\longrightarrow \mathrm{St}\longrightarrow M\longrightarrow \Bbbk_{\mathrm{tr}}\longrightarrow 0$ 

in  $\mathscr{C}(\mathbf{G})$ , then by Corollary 4.6, we get

$$\operatorname{Hom}_{\mathbf{G}}(\mathbb{M}(\operatorname{tr}), M) \cong \operatorname{Hom}_{\mathbf{B}}(\Bbbk_{\operatorname{tr}}, M) \cong \Bbbk$$

using Frobenius reciprocity. Thus  $M \cong \mathbb{M}(\mathrm{tr})$  or  $M \cong \mathrm{St} \oplus \mathbb{k}_{\mathrm{tr}}$ . Therefore  $\mathrm{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\mathrm{tr}}, \mathrm{St}) \cong \mathbb{k}$  and hence  $\mathrm{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{k}_{\mathrm{tr}}, \mathbb{M}(\mathrm{tr})) = 0$ .

(2)  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\operatorname{tr})) = 0$ . Using the short exact sequence

$$0 \longrightarrow \mathrm{St} \longrightarrow \mathbb{M}(\mathrm{tr}) \longrightarrow \mathbb{k}_{\mathrm{tr}} \longrightarrow 0,$$

we get a long exact sequence

$$0 \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \operatorname{St}) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\operatorname{tr})) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{k}_{\operatorname{tr}}) \\ \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \operatorname{St}) \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\operatorname{tr})) \longrightarrow \operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{k}_{\operatorname{tr}}) \longrightarrow \dots$$

Since  $\mathbb{k}_{tr}$  is injective and we have  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{k}_{tr}) = 0$ , it is enough to show that  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \operatorname{St}) = 0$ . Given a short exact sequence

$$(5.7) 0 \longrightarrow \operatorname{St} \longrightarrow N \longrightarrow \operatorname{St} \longrightarrow 0$$

in  $\mathscr{C}(\mathbf{G})$ , then there exists  $\xi_1, \xi_2 \in N_{\mathrm{tr}}$  such that  $N \cong \mathbb{k}\mathbf{U}\xi_1 \oplus \mathbb{k}\mathbf{U}\xi_2$  as  $\mathbb{k}\mathbf{B}$ -modules and  $\mathbb{k}\mathbf{U}\xi_1$  is isomorphic to the Steinberg module. Firstly it is

easy to see that  $\dot{s}\xi_2 = -\xi_2 + a\xi_1$  for some  $a \in \mathbb{k}$ . Using  $\dot{s}$  to act on both sides, we get a = 0 and thus  $\dot{s}\xi_2 = -\xi_2$ . On the other hand, we have

$$\dot{s}\varepsilon(1)\xi_2 = (\varepsilon(-1) - e)\xi_2 + \varpi$$

for some  $\varpi \in \mathbb{k}\mathbf{U}\xi_1$ . Denote by  $\varpi = \sum_{x\in \overline{\mathbb{F}}_q} a_x \varepsilon(x)\xi_1$  and then we get

$$\dot{s}\varepsilon(y)\xi_2 = (\varepsilon(-y^{-1}) - e)\xi_2 + \sum_{x\in\bar{\mathbb{F}}_q} a_x\varepsilon(xy^{-1})\xi_1$$

for any  $y \in \overline{\mathbb{F}}_q^*$ . Now we consider the element  $\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\xi_2$ . Firstly we have (5.8)

$$\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\xi_2 = \varepsilon(-z^{-1})\dot{s}h(-z)\varepsilon(-z^{-1})\varepsilon(1)\xi_2 = \varepsilon(-z^{-1})\dot{s}\varepsilon(z^2-z)\xi_2.$$

On the other hand, we have

(5.9) 
$$\dot{s}\varepsilon(z)\dot{s}\varepsilon(1)\xi_2 = \dot{s}(\varepsilon(z-1)-\varepsilon(z))\xi_2 + \dot{s}\varepsilon(z)\varpi$$

Combining (5.8) and (5.9), it is not difficult to get

(5.10)  

$$\dot{s}\varepsilon(z)\sum_{x\in\bar{\mathbb{F}}_q}a_x\varepsilon(x)\xi_1 = \sum_{x\in\bar{\mathbb{F}}_q}a_x(\varepsilon(x(z^2-z)^{-1}-z^{-1})+\varepsilon(xz^{-1})-\varepsilon(x(z-1)^{-1}))\xi_1$$

for any  $z \in \overline{\mathbb{F}}_q$ . If  $a_x \neq 0$  when  $x \neq 0, -1$ , then the equation can not hold for any  $z \in \overline{\mathbb{F}}_q$ . However, substitute  $\varpi = a\xi_1 + b\varepsilon(-1)\xi_1$  into (5.10), we get  $\varpi = 0$  easily. Thus the short exact sequence (5.7) is split and we have  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \operatorname{St}) = 0$  which implies that  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\operatorname{St}, \mathbb{M}(\operatorname{tr})) = 0$ .

(3)  $\operatorname{Ext}^{1}_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\lambda),\mathbb{M}(\theta)) = 0$  for  $\lambda = \theta$  or  $\theta^{s}$ . Firstly given a short exact sequence

$$(5.11) 0 \longrightarrow \mathbb{M}(\theta) \longrightarrow K \longrightarrow \mathbb{M}(\theta) \longrightarrow 0$$

in  $\mathscr{C}(\mathbf{G})$ , then by Corollary 4.6, we have

$$K \cong \Bbbk_{\theta} \oplus \Bbbk_{\theta} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_{\theta^{s}} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \Bbbk_{\theta^{s}}$$

as  $\mathbb{k}\mathbf{B}$ -modules and there exists  $\xi_1, \eta_1 \in K_{\theta}$  and  $\xi_2, \eta_2 \in K_{\theta^s}$  such that  $\mathbb{k}\xi_1 + \mathbb{k}\mathbf{U}\xi_2 \cong \mathbb{M}(\theta)$ , which is a  $\mathbb{k}\mathbf{G}$ -submodule of K. We can assume that  $\xi_2 = \dot{s}\xi_1$ . Now suppose

$$\dot{s}\eta_1 = a\xi_2 + b\eta_2, \quad \dot{s}\eta_2 = c\xi_1 + d\eta_1$$

for some  $a, b, c, d \in \mathbb{k}$ . Using  $\dot{s}$  to act on both sides of the two equations, we get  $c = -\frac{a}{b}$  and  $d = \frac{1}{b}$ . In particular, b is nonzero. Now set  $\tilde{\eta}_2 = a\xi_2 + b\eta_2$ .

Thus  $k\eta_1 + k\mathbf{U}\widetilde{\eta_2}$  is isomorphic to  $\mathbb{M}(\theta)$ . So the short exact sequence (5.11) is split which implies that  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\theta), \mathbb{M}(\theta)) = 0$ .

Next we consider the short exact sequence

 $(5.12) 0 \longrightarrow \mathbb{M}(\theta) \longrightarrow L \longrightarrow \mathbb{M}(\theta^s) \longrightarrow 0$ 

in  $\mathscr{C}(\mathbf{G})$ . There exists  $\zeta_1, \varrho_1 \in L_{\theta}$  and  $\zeta_2, \varrho_2 \in L_{\theta^s}$  such that  $\mathbb{M}(\theta) \cong \mathbb{k}\zeta_1 + \mathbb{k}\mathbf{U}\zeta_2$ . We can assume that  $\zeta_2 = \dot{s}\zeta_1$ . Now suppose

$$\dot{s}\varrho_1 = a'\zeta_2 + b'\varrho_2, \quad \dot{s}\varrho_2 = c'\zeta_1 + d'\varrho_1,$$

then we also get  $c' = -\frac{a'}{b'}$  and  $d' = \frac{1}{b'}$ . In particular, b' and d' are nonzero. Set  $\tilde{\varrho_1} = c'\zeta_1 + d'\varrho_1$ , then we get  $\mathbb{M}(\theta^s) \cong \Bbbk \varrho_2 + \Bbbk \mathbf{U}\tilde{\varrho_1}$ . Therefore the short exact sequence (5.12) is split and we also get  $\operatorname{Ext}^1_{\mathscr{C}(\mathbf{G})}(\mathbb{M}(\theta^s), \mathbb{M}(\theta)) = 0$ . The proposition is proved.

**Theorem 5.4.** The category  $\mathscr{C}(\mathbf{G})$  has enough injective objects.

*Proof.* By Proposition 5.3, the injective envelope for each simple object exists in the category  $\mathscr{C}(\mathbf{G})$ . Thus a standard argument shows that  $\mathscr{C}(\mathbf{G})$  has enough injective objects (see [9, Theorem 2.7]).

Now we show that  $\mathscr{C}(\mathbf{G})$  is a highest weight category. In Definition 5.1, the set of weights is  $\Lambda = \{(\theta, J) \mid \theta \in \widehat{\mathbf{T}}, J \subset I(\theta)\}$  and we define the order of the weights by

$$(\theta_1, J_1) \leq (\theta_2, J_2)$$
, if  $\theta_1 = \theta_2$  and  $J_1 \supseteq J_2$ .

Specifically, for  $\mathbf{G} = SL_2(\bar{\mathbb{F}}_q)$ ,  $\Lambda = \{(\mathrm{tr}, \emptyset), (\mathrm{tr}, \{s\}), (\theta, \emptyset) \mid \theta \text{ is nontrivial}\}$ . Let  $S(\mathrm{tr}, \{s\}) = A(\mathrm{tr}, \{s\}) = \mathbb{k}_{\mathrm{tr}}, S(\mathrm{tr}, \emptyset) = A(\mathrm{tr}, \emptyset) = \mathrm{St}$  and  $S(\theta, \emptyset) = A(\theta, \emptyset) = \mathbb{M}(\theta)$ . By Proposition 5.3, we set  $\mathfrak{I}(\mathrm{tr}, \{s\}) = \mathbb{k}_{\mathrm{tr}}, \mathfrak{I}(\mathrm{tr}, \emptyset) = \mathbb{M}(\mathrm{tr})$ and  $\mathfrak{I}(\theta, \emptyset) = \mathbb{M}(\theta)$ . It is not difficult to check that  $\mathscr{C}(\mathbf{G})$  with this setting satisfies all the condition in Definition 5.1 and thus we have the following theorem.

**Theorem 5.5.** The category  $\mathscr{C}(\mathbf{G})$  is a highest weight category.

According to the same discussion as [9, Section 4 and Section 5], all the indecomposable modules in  $\mathscr{C}(\mathbf{G})$  are St,  $\mathbb{k}_{tr}$  and  $\{\mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}}\}$ . Therefore each object in  $\mathscr{C}(\mathbf{G})$  is a direct sum of these modules. In particular, the category  $\mathscr{C}(\mathbf{G})$  is a Krull–Schmidt category.

**Remark 5.6.** In [3], X.Y. Chen constructed a complex representation M of  $SL_2(\bar{\mathbb{F}}_q)$ , which contains the Steinberg module as a proper submodule and the corresponding quotient module is the trivial module. However M has no **B**-stable line. So, this gives a negative answer to [9, Conjecture 3.7]. Thus the principal representation category  $\mathscr{O}(\mathbf{G})$  introduced in [9] is not a highest weight category. Chen's work shows that  $\mathscr{O}(\mathbf{G})$  is very complicated in general. However the representation M he constructed in [3] is not in the category  $\mathscr{C}(SL_2(\bar{\mathbb{F}}_q))$ . Therefore, for general reductive algebraic group  $\mathbf{G}$ , the category  $\mathscr{C}(\mathbf{G})$  may be a good category for further study.
