# CERTAIN COMPLEX REPRESENTATIONS OF $S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$

#### Abstract

We introduce the representation category $\mathscr{C}(\mathbf{G})$ for a connected reductive algebraic group $\mathbf{G}$ which is defined over a finite field $\mathbb{F}_{q}$ of $q$ elements. We show that this category has many good properties for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$. In particular, it is an abelian category and a highest weight category. Moreover, we classify the simple objects in $\mathscr{C}(\mathbf{G})$ for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$.


## 1. Introduction

Let $\mathbf{G}$ be a connected reductive algebraic group defined over the finite field $\mathbb{F}_{q}$ of $q$ elements. Let $\mathbb{k}$ be another field and all representations in this paper are over $\mathbb{k}$. According to a result of Borel and Tits [1, Theorem 10.3 and Corollary 10.4], we know that except the trivial representation, all other irreducible representations of $\mathbb{k} \mathbf{G}$ (the group algebra of $\mathbf{G}$ ) are infinite-dimensional if $\mathbf{G}$ is semisimple and $\mathbb{k}$ is infinite with char $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_{q}$. Denote by $G_{q^{a}}$ the set of $\mathbb{F}_{q^{a}}$-points of $\mathbf{G}$, then we have $\mathbf{G}=\bigcup G_{q^{a}}$. With this basic fact, N.H. Xi studied the abstract representations of $\mathbf{G}$ over $\mathbb{k}$ by taking the direct limit of the finite-dimensional representations of $G_{q^{a}}$ and he got many interesting results in [13]. In particular, he showed that the infinite-dimensional Steinberg module is irreducible when char $\mathbb{k}=0$ or char $\mathbb{k}=$ char $\overline{\mathbb{F}}_{q}$. Afterwards, R.T. Yang proved the irreducibility of the Steinberg module for any field $\mathbb{k}$ with char $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_{q}$ (see [14]). Later, motivated by Xi's idea, the structure of the permutation module $\mathbb{k}[\mathbf{G} / \mathbf{B}]$ ( $\mathbf{B}$ is a fixed Borel subgroup of G ) was studied in [4] for the cross characteristic case and in [5] for the defining characteristic case. We studied the general abstract induced module $\mathbb{M}(\theta)=\mathbb{k} \mathbf{G} \otimes_{\mathbb{k} B} \mathbb{k}_{\theta}$ in [6] for any field $\mathbb{k}$ with char $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_{q}$ or $\mathbb{k}=\overline{\mathbb{F}}_{q}$, where $\mathbf{T}$ is a maximal torus contained in a Borel subgroup $\mathbf{B}$ and $\theta$ is a character of $\mathbf{T}$ which can also be regarded as a character of $\mathbf{B}$ through the homomorphism $\mathbf{B} \rightarrow \mathbf{T}$. The induced module

[^0]$\mathbb{M}(\theta)$ has a composition series (of finite length) if char $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_{q}$. In the case $\mathbb{k}=\overline{\mathbb{F}}_{q}$ and $\theta$ is a rational character, $\mathbb{M}(\theta)$ has such composition series if and only if $\theta$ is antidominant (see [6] for details). In both cases, the composition factors of $\mathbb{M}(\theta)$ are $E(\theta)_{J}$ with $J \subset I(\theta)$ (see Section 2 for the explicit setting).

Now we have a large class of irreducible $\mathbb{k} \mathbf{G}$-modules. Let $\mathbb{k} \mathbf{G}$-Mod be the $\mathbb{k} \mathbf{G}$-module category. However, this category is too big and thus in the paper [9], we introduce the principal representation category $\mathscr{O}(\mathbf{G})$ which was supposed to have many good properties. In particular, we conjectured that this category is a highest weight category in the sense of Cline, Parshall and Scott [8]. However, recently X.Y.Chen constructed a counter example (see [3]) to show that this conjecture is not valid in general with the setting given in [9, Section 4]. Thus it deserves to explore other categories besides the category $\mathscr{O}(\mathbf{G})$ in 9 . We hope that there is a category which satisfies certain good properties such as "finite-ness" and "semi-simplicity", which is also like the BGG category $\mathscr{O}$ in the representations of complex semisimple Lie algebras. In this paper we introduce a full subcategory $\mathscr{C}(\mathbf{G})$ of $\mathbb{k} \mathbf{G}$-Mod, whose objects are finitely generated by some $\mathbf{T}$-eigenvectors (see Section 2 for the definition of $\mathscr{C}(\mathbf{G}))$. The main part of this paper is devoted to study the category $\mathscr{C}(\mathbf{G})$ for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$.

The rest of this paper is organized as follows: Section 2 contains some preliminary results and we also introduce the category $\mathscr{C}(\mathbf{G})$ in this section. From Section 3 to Section 5, we assume that $\mathbb{k}$ is an algebraically closed field of characteristic 0 and study the category $\mathscr{C}(\mathbf{G})$ for $\mathbf{G}=S L_{2}\left(\mathbb{F}_{q}\right)$. In Section 3 , we classify the simple $\mathbb{k} \mathbf{G}$-modules with $\mathbf{T}$-stable lines. In particular, we get all the simple objects in $\mathscr{C}(\mathbf{G})$. Then we show that $\mathscr{C}(\mathbf{G})$ is an abelian category and has certain good properties in Section 4. In Section 5 we prove that $\mathscr{C}(\mathbf{G})$ is a highest weight category.

## 2. BaCKGROUND AND PRELIMINARY RESULTS

Let $\mathbf{G}$ be a connected reductive algebraic group over $\overline{\mathbb{F}}_{q}$, the algebraic closure of $\mathbb{F}_{q}$, e.g. $\mathbf{G}=G L_{n}\left(\overline{\mathbb{F}}_{q}\right), S L_{n}\left(\overline{\mathbb{F}}_{q}\right)$. Let $\mathbf{B}$ be a Borel subgroup, and $\mathbf{T}$ be a maximal torus contained in $\mathbf{B}$, and $\mathbf{U}=R_{u}(\mathbf{B})$ be the unipotent radical of $\mathbf{B}$. We identify $\mathbf{G}$ with $\mathbf{G}\left(\overline{\mathbb{F}}_{q}\right)$ and do likewise for the various subgroups of $\mathbf{G}$ such as $\mathbf{B}, \mathbf{T}, \mathbf{U} \cdots$. We denote by $\Phi=\Phi(\mathbf{G} ; \mathbf{T})$ the corresponding root system, and by $\Phi^{+}$(resp. $\Phi^{-}$) the set of positive (resp. negative) roots determined by $\mathbf{B}$. Let $W=N_{\mathbf{G}}(\mathbf{T}) / \mathbf{T}$ be the corresponding

Weyl group. We denote by $\Delta=\left\{\alpha_{i} \mid i \in I\right\}$ the set of simple roots and by $S=\left\{s_{i}:=s_{\alpha_{i}} \mid i \in I\right\}$ the corresponding simple reflections in $W$. For each $\alpha \in \Phi$, let $\mathbf{U}_{\alpha}$ be the root subgroup corresponding to $\alpha$ and we fix an isomorphism $\varepsilon_{\alpha}: \overline{\mathbb{F}}_{q} \rightarrow \mathbf{U}_{\alpha}$ such that $t \varepsilon_{\alpha}(c) t^{-1}=\varepsilon_{\alpha}(\alpha(t) c)$ for any $t \in \mathbf{T}$ and $c \in \overline{\mathbb{F}}_{q}$. For any $w \in W$, let $\mathbf{U}_{w}$ (resp. $\mathbf{U}_{w}^{\prime}$ ) be the subgroup of $\mathbf{U}$ generated by all $\mathbf{U}_{\alpha}$ with $w(\alpha) \in \Phi^{-}\left(\right.$resp. $\left.w(\alpha) \in \Phi^{+}\right)$. One is refereed [2] for more details.

Now let $\mathbb{k}$ be an algebraically closed field of characteristic 0 and all the representations in this paper are over $\mathbb{k}$. Let $\widehat{\mathbf{T}}$ be the set of characters of T. Each $\theta \in \widehat{\mathbf{T}}$ can be regarded as a character of $\mathbf{B}$ by the homomorphism $\mathbf{B} \rightarrow \mathbf{T}$. Let $\mathbb{k}_{\theta}$ be the corresponding $\mathbf{B}$-module. We consider the induced module $\mathbb{M}(\theta)=\mathbb{k} \mathbf{G} \otimes_{\mathbb{k} \boldsymbol{B}} \mathbb{k}_{\theta}$. Let $\mathbf{1}_{\theta}$ be a fixed nonzero element in $\mathbb{k}_{\theta}$. We abbreviate $x \mathbf{1}_{\theta}:=x \otimes \mathbf{1}_{\theta} \in \mathbb{M}(\theta)$ for $x \in \mathbf{G}$. It is not difficult to see that $\mathbb{M}(\theta)$ has a basis $\left\{u \dot{w} \mathbf{1}_{\theta} \mid w \in W, u \in \mathbf{U}_{w^{-1}}\right\}$ by the Bruhat decomposition, where $\dot{w}$ is a fixed representative of $w \in W$.

For each $i \in I$, let $\mathbf{G}_{i}$ be the subgroup of $\mathbf{G}$ generated by $\mathbf{U}_{\alpha_{i}}, \mathbf{U}_{-\alpha_{i}}$ and set $\mathbf{T}_{i}=\mathbf{T} \cap \mathbf{G}_{i}$. For $\theta \in \widehat{\mathbf{T}}$, define the subset $I(\theta)$ of $I$ by

$$
I(\theta)=\left\{i \in I|\theta|_{\mathbf{T}_{i}} \text { is trivial }\right\} .
$$

The Weyl group $W$ acts naturally on $\widehat{\mathbf{T}}$ by

$$
(w \cdot \theta)(t):=\theta^{w}(t)=\theta\left(\dot{w}^{-1} t \dot{w}\right)
$$

for any $\theta \in \widehat{\mathbf{T}}$.
Let $J \subset I(\theta)$, and $\mathbf{G}_{J}$ be the subgroup of $\mathbf{G}$ generated by $\mathbf{G}_{i}, i \in J$. We choose a representative $\dot{w} \in \mathbf{G}_{J}$ for each $w \in W_{J}$ (the standard parabolic subgroup of $W$ ). Thus, the element $w \mathbf{1}_{\theta}:=\dot{w} \mathbf{1}_{\theta}\left(w \in W_{J}\right)$ is well-defined. For $J \subset I(\theta)$, we set

$$
\eta(\theta)_{J}=\sum_{w \in W_{J}}(-1)^{\ell(w)} w \mathbf{1}_{\theta},
$$

where $\ell$ is the length function on $W$. Let $\mathbb{M}(\theta)_{J}=\mathbb{k} \mathbf{G} \eta(\theta)_{J}$ the $\mathbb{k} \mathbf{G}$-module which is generated by $\eta(\theta)_{J}$.

For $w \in W$, denote by $\mathscr{R}(w)=\left\{i \in I \mid w s_{i}<w\right\}$. For any subset $J \subset I$, we set

$$
X_{J}=\left\{x \in W \mid x \text { has minimal length in } x W_{J}\right\} .
$$

We have the following proposition.

Proposition 2.1. [6, Proposition 2.5] For any $J \subset I(\theta)$, the $\mathbb{k} \mathbf{G}$-module $\mathbb{M}(\theta)_{J}$ has the form

$$
\begin{equation*}
\mathbb{M}(\theta)_{J}=\sum_{w \in X_{J}} \mathbb{k} \mathbf{U} \dot{w} \eta(\theta)_{J}=\sum_{w \in X_{J}} \mathbb{k} \mathbf{U}_{w_{J} w^{-1}} \dot{w} \eta(\theta)_{J} \tag{2.1}
\end{equation*}
$$

In particular, the set $\left\{u \dot{w} \eta(\theta)_{J} \mid w \in X_{J}, u \in \mathbf{U}_{w_{J} w^{-1}}\right\}$ forms a basis of $\mathbb{M}(\theta)_{J}$.

For $J \subset I(\theta)$, define

$$
E(\theta)_{J}=\mathbb{M}(\theta)_{J} / \mathbb{M}(\theta)_{J}^{\prime}
$$

where $\mathbb{M}(\theta)_{J}^{\prime}$ is the sum of all $\mathbb{M}(\theta)_{K}$ with $J \subsetneq K \subset I(\theta)$. We denote by $C(\theta)_{J}$ the image of $\eta(\theta)_{J}$ in $E(\theta)_{J}$. We also set

$$
Z_{J}=\left\{w \in X_{J} \mid \mathscr{R}\left(w w_{J}\right) \subset J \cup(I \backslash I(\theta))\right\} .
$$

The following proposition gives a basis of $E(\theta)_{J}$.
Proposition 2.2. [6, Proposition 2.7] For $J \subset I(\theta)$, we have

$$
\begin{equation*}
E(\theta)_{J}=\sum_{w \in Z_{J}} \mathbb{k} \mathbf{U}_{w_{J} w^{-1}} \dot{w} C(\theta)_{J} . \tag{2.2}
\end{equation*}
$$

In particular, the set $\left\{u \dot{w} C(\theta)_{J} \mid w \in Z_{J}, u \in \mathbf{U}_{w_{J} w^{-1}}\right\}$ forms a basis of $E(\theta){ }_{J}$.

The $\mathbb{k} \mathbf{G}$-modules $E(\theta)_{J}$ are irreducible and thus we get all the composition factors of $\mathbb{M}(\theta)$ (see [6, Theorem 3.1]). According to [6, Proposition 2.8], one has that $E\left(\theta_{1}\right)_{K_{1}}$ is isomorphic to $E\left(\theta_{2}\right)_{K_{2}}$ as $\mathbb{k} \mathbf{G}$-modules if and only if $\theta_{1}=\theta_{2}$ and $K_{1}=K_{2}$.

For a $\mathbb{k} \mathbf{G}$-module $M$, an element $\xi \in M$ is called a $\mathbf{T}$-eigenvector if $t \xi=\lambda(t) \xi$ for some $\lambda \in \widehat{\mathbf{T}}$. Set $M_{\lambda}=\{\xi \in M \mid t \xi=\lambda(t) \xi\}$, which is called the weight space corresponding to $\lambda \in \widehat{\mathbf{T}}$. A character $\lambda \in \widehat{\mathbf{T}}$ is called a weight of $M$ if $M_{\lambda} \neq 0$ and then we denote the weight set of $M$ by $\mathrm{Wt}(\mathrm{M})$. Let $M^{\mathbf{T}}=\bigoplus_{\lambda \in \widehat{\mathbf{T}}} M_{\lambda}$ and set $\mathfrak{d}(M)=\operatorname{dim} M^{\mathbf{T}}$. With previous discussion and the form of $\mathbb{M}(\theta)_{J}$ and $E(\theta)_{J}$ (see (2.1) and (2.21)), we are interested in the $\mathbb{k} \mathbf{G}$-module $M$ which satisfies the following condition:
$(\star) n=\mathfrak{d}(M)<+\infty$ and there exist T-eigenvectors $\xi_{1}, \xi_{2}, \ldots, \xi_{n}$ such that $M \cong \bigoplus_{i=1}^{n} \mathbb{k} \mathbf{U} \xi_{i}$ as $\mathbb{k} \mathbf{B}$-modules.

Let $\mathscr{C}(\mathbf{G})$ be the full subcategory of $\mathbb{k} \mathbf{G}$-Mod, which consists of the $\mathbb{k} \mathbf{G}$ modules satisfying the condition $(\star)$. From the definition of $\mathscr{C}(\mathbf{G})$, it seems
very difficult to judge whether it is an abelian category. Naturally, we have the following fundamental questions: (1) Is the category $\mathscr{C}(\mathbf{G})$ an abelian category? (2) Is this category noetherian or artinian? (3) Classify all the simple objects in $\mathscr{C}(\mathbf{G})$. We will solve these problems for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$ in the following discussion.

## 3. Simple modules with T-stable lines.

From now on, let $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right), \mathbf{T}$ be the diagonal matrices and $\mathbf{U}$ be the strictly upper unitriangular matrices in $S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$. Let $\mathbf{B}$ be the Borel subgroup generated by $\mathbf{T}$ and $\mathbf{U}$, which is the upper triangular matrices in $S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$. As before, let $\mathbf{N}$ be the normalizer of $\mathbf{T}$ in $\mathbf{G}$ and $W=\mathbf{N} / \mathbf{T}$ be the Weyl group. We set $\dot{s}=\left(\begin{array}{cc}0 & 1 \\ -1 & 0\end{array}\right)$, which is the simple reflection of $W$. There are two natural isomorphisms

$$
h: \overline{\mathbb{F}}_{q}^{*} \rightarrow \mathbf{T}, h(c)=\left(\begin{array}{cc}
c & 0 \\
0 & c^{-1}
\end{array}\right) ; \quad \varepsilon: \overline{\mathbb{F}}_{q} \rightarrow \mathbf{U}, \quad \varepsilon(x)=\left(\begin{array}{cc}
1 & x \\
0 & 1
\end{array}\right)
$$

which satisfies $h(c) \varepsilon(x) h(c)^{-1}=\varepsilon\left(c^{2} x\right)$. The simple root $\alpha: \mathbf{T} \rightarrow \overline{\mathbb{F}}_{q}^{*}$ is given by $\alpha(h(c))=c^{2}$. Moreover, one has that

$$
\begin{equation*}
\dot{s} \varepsilon(x) \dot{s}=\varepsilon\left(-x^{-1}\right) \dot{s} h(-x) \varepsilon\left(-x^{-1}\right) . \tag{3.1}
\end{equation*}
$$

In the following we often denote $\theta(x):=\theta(h(x))$ simply. For any finite subset $X$ of $\mathbf{G}$, let $\bar{X}:=\sum_{x \in X} x \in \mathbb{k} \mathbf{G}$. This notation will be frequently used later.

In order to understand the irreducible $\mathbb{k} \mathbf{G}$-modules with $\mathbf{T}$-stable lines, it is enough to study the simple quotients of the induced module $\operatorname{Ind} \mathbf{T}_{\mathbf{T}} \mathbb{k}_{\theta}$ for each $\theta \in \widehat{\mathbf{T}}$. It is not difficult to see that $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta} \cong \operatorname{Ind} \mathbf{T}_{\mathbf{T}} \mathbb{k}_{\theta^{s}}$ as $\mathbb{k} \mathbf{G}$-modules. We will consider the following two cases: (1) $\theta$ is trivial; (2) $\theta$ is nontrivial. When $\theta$ is trivial, it is easy to see that

$$
\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\mathrm{tr}} \cong \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+} \oplus \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-},
$$

where $\mathbb{k}_{+}$is the trivial representation of $\mathbf{N}$ and $\mathbb{k}_{-}$is the sign representation of $W$, which also can be regarded as a representation of $\mathbf{N}$.

In our case $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$, according to [6, Theorem 3.1], $\mathbb{M}(\operatorname{tr})=\operatorname{Ind}_{\mathbf{B}}^{\mathbf{G}} \mathbb{k}_{\operatorname{tr}}$ has a unique submodule St (the Steinberg module) and the corresponding quotient module is trivial. The Steinberg module $\mathrm{St}=\mathbb{k} \mathbf{U} \eta_{s}$, where $\eta_{s}=$ $(1-s) \mathbf{1}_{\mathrm{tr}}$. Then we have $\dot{s} \eta_{s}=-\eta_{s}$ and $\dot{s} \varepsilon(x) \eta_{s}=\left(\varepsilon\left(-x^{-1}\right)-1\right) \eta_{s}$ for $x \neq 0$
by (3.1). For any nontrivial character $\theta \in \widehat{\mathbf{T}}, \mathbb{M}(\theta)=\operatorname{Ind}_{\mathbf{B}}^{\mathbf{G}} \mathbb{k}_{\theta}$ is a simple $\mathbb{k} \mathbf{G}$-module. The main theorem of this section is as following.

Theorem 3.1. (1) The trivial $\mathbb{k} \mathbf{G}$-module $\mathbb{k}_{\text {tr }}$ is the unique simple quotient module of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$and the Steinberg module $S t$ is the unique simple quotient module of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-}$. (2) When $\theta$ is nontrivial, $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$ has just two simple quotient modules $\mathbb{M}(\theta)$ and $\mathbb{M}\left(\theta^{s}\right)$.

Proof of Theorem 3.1(1). For convenience, we abbreviate $x \mathbf{1}_{+}:=x \otimes \mathbf{1}_{+} \in$ $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$and $x \mathbf{1}_{-}:=x \otimes \mathbf{1}_{-} \in \operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-}$for $x \in \mathbf{G}$, where $\mathbf{1}_{+}\left(\right.$resp. $\left.\mathbf{1}_{-}\right)$ is a fixed nonzero element in $\mathbb{k}_{+}$(resp. $\mathbb{k}_{-}$). Firstly we consider the simple quotient of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$. We construct a submodule of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$as following

$$
\mathbb{M}_{+}=\left\{\sum_{g \in \mathbf{G}} a_{g} g \mathbf{1}_{+} \mid \sum_{g \in \mathbf{G}} a_{g}=0\right\}
$$

Then it is easy to see that $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+} / \mathbb{M}_{+}$is the trivial $\mathbb{k} \mathbf{G}$-module. Now let $\xi \notin \mathbb{M}_{+}$which has the following expression

$$
\xi=\sum_{x, y \in \overline{\mathbb{F}}_{q}} a_{x, y} \varepsilon(x) \dot{s} \varepsilon(y) \mathbf{1}_{+}
$$

where $\sum_{x, y \in \overline{\mathbb{F}}_{q}} a_{x, y} \neq 0$. Firstly there exists an integer $m \in \mathbb{N}$ such that $x, y \in$ $\mathbb{F}_{q^{m}}$ when $a_{x, y} \neq 0$. Now let $n>m$ with $m \mid n$ and $u \in \mathbb{F}_{q^{n}} \backslash \mathbb{F}_{q^{m}}$. We consider the element $\eta=\dot{s} \varepsilon(u) \xi$, which has the form

$$
\eta=\sum_{x, y \in \overline{\mathbb{F}}_{q}} a_{x, y} \varepsilon\left(-(u+x)^{-1}\right) \dot{s} \varepsilon\left((u+x)-(u+x)^{2} y\right) \mathbf{1}_{+}
$$

Choose $\mathfrak{D}_{q^{n}} \subset \mathbf{T}$ such that $\alpha: \mathfrak{D}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}^{*}$ is a bijection. Thus it is easy to check the element

$$
\overline{\mathfrak{D}_{q^{n}}} \overline{U_{q^{n}}} \eta=\left(\sum_{x, y \in \overline{\mathbb{F}}_{q}} a_{x, y}\right) \overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{+} \in \mathbb{k} \mathbf{G} \mathbf{1}_{+}
$$

which implies that $\overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{+} \in \mathbb{k} \mathbf{G} \xi$.
On the other hand, we consider the element

$$
\overline{G_{q^{n}}} \xi=\left(\sum_{x, y \in \overline{\mathbb{F}}_{q}} a_{x, y}\right) \overline{G_{q^{n}}} \mathbf{1}_{+} \in \mathbb{k} \mathbf{G} \xi
$$

Noting that

$$
\overline{G_{q^{n}}} \mathbf{1}_{+}=\left(q^{n}-1\right)\left(2 \overline{U_{q^{n}}} \mathbf{1}_{+}+\overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{+}\right) \in \mathbb{k} \mathbf{G} \xi
$$

therefore we have $\overline{U_{q^{n}}} \mathbf{1}_{+} \in \mathbb{k} \mathbf{G} \xi$ and hence $\mathbf{1}_{+} \in \mathbb{k} \mathbf{G} \xi$ by [10, Lemma 2.6]. Thus for any element $\xi \notin \mathbb{M}_{+}$, we have $\mathbb{k} \mathbf{G} \xi=\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$. So, the trivial module is the unique simple quotient module of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{+}$.

Now we consider the simple quotient modules of $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-}$. For convenience, we denote by

$$
\Lambda(z)=\left(\dot{s} \varepsilon(z)+1-\varepsilon\left(-z^{-1}\right)\right) 1_{-}
$$

for each $z \in \overline{\mathbb{F}}_{q}^{*}$. Then we have $h(c) \Lambda(z)=\Lambda\left(c^{-2} z\right)$ for any $h(c) \in \mathbf{T}$. Moreover, it is easy to check that

$$
\begin{gather*}
\varepsilon(z) \Lambda\left(z^{-1}\right)=-\Lambda\left(-z^{-1}\right), \quad \dot{s} \Lambda(z)=-\Lambda\left(-z^{-1}\right),  \tag{3.2}\\
\dot{s} \varepsilon(x) \Lambda(y)=\varepsilon\left(-x^{-1}\right) \Lambda(x(x y-1))+\Lambda(x)-\Lambda\left(y^{-1}(x y-1)\right),
\end{gather*}
$$

where $x y \neq 1$. Let $\mathbb{M}_{-}$be the submodule of $\operatorname{Ind}_{\mathbb{N}} \mathbf{G}_{\mathbb{k}} \mathbb{k}_{-}$which is generated by $\Lambda(z), z \in \overline{\mathbb{F}}_{q}^{*}$. Since we have the equation

$$
\dot{s} \varepsilon(z) \eta_{s}=\left(\varepsilon\left(-z^{-1}\right)-1\right) \eta_{s}
$$

in the Steinberg module $S t=\mathbb{k} \mathbf{U} \eta_{s}$. Thus it is not difficult to see that $\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-} / \mathbb{M}_{-}$is isomorphic to the Steinberg module.

Let $\zeta \in \operatorname{Ind}_{\mathbb{N}}^{\mathbf{G}} \mathbb{k}_{-}$which is not in $\mathbb{M}_{-}$. According to (3.2), then $\zeta$ has the following expression

$$
\zeta=\sum_{x y \neq 1} a_{x, y} \varepsilon(x) \Lambda(y) \mathbf{1}_{-}+\sum_{z \in \overline{\mathbb{F}}_{q}^{*}} b_{z} \Lambda(z) \mathbf{1}_{-}+\sum_{u \in \overline{\mathbb{F}}_{q}} c_{u} \varepsilon(u) \mathbf{1}_{-},
$$

where $c_{u} \neq 0$ for some $u$. There exists an integer $m \in \mathbb{N}$ such that $x, y, z, u \in$ $\mathbb{F}_{q^{m}}$ when $a_{x, y} \neq 0, b_{z} \neq 0$ and $c_{u} \neq 0$. Without lost of generality, we can assume that $c_{0} \neq 0$. Moreover, we can assume that $\sum_{u \in \overline{\mathbb{F}}_{q}} c_{u} \neq 0$. Otherwise, we can consider $\dot{s} \zeta$ instead of $\zeta$. Indeed, if we write

$$
\dot{s} \zeta=\sum_{x y \neq 1} a_{x, y}^{\prime} \varepsilon(x) \Lambda(y) \mathbf{1}_{-}+\sum_{z \in \overline{\mathbb{F}}_{q}^{*}} b_{z}^{\prime} \Lambda(z) \mathbf{1}_{-}+\sum_{u \in \overline{\mathbb{F}}_{q}} c_{u}^{\prime} \varepsilon(u) \mathbf{1}_{-},
$$

it is easy to see that $\sum_{u \in \overline{\mathbb{F}}_{q}} c_{u}^{\prime}=-c_{0}$ which is nonzero. For the convenience of later discussion, we denote by

$$
A=\sum_{x y \neq 1} a_{x, y}, \quad B=\sum_{z \in \overline{\mathbb{F}}_{q}^{*}} b_{z}, \quad C=\sum_{u \in \overline{\mathbb{F}}_{q}} c_{u} .
$$

Note that $C$ is nonzero by our assumption.

Now let $n>m$ with $m \mid n$ and $v \in \mathbb{F}_{q^{n}} \backslash \mathbb{F}_{q^{m}}$. We consider the element

$$
\dot{s} \varepsilon(v) \zeta:=\sum_{x y \neq 1} f_{x, y} \varepsilon(x) \Lambda(y) \mathbf{1}_{-}+\sum_{z \in \overline{\mathbb{F}}_{q}^{*}} g_{z} \Lambda(z) \mathbf{1}_{-}+\sum_{u \in \overline{\mathbb{F}}_{q}} h_{u} \varepsilon(u) \mathbf{1}_{-} .
$$

Then by (3.2), we get

$$
\begin{equation*}
\sum_{x y \neq 1} f_{x, y}=A+B, \quad \sum_{z \in \overline{\mathbb{F}}_{q}^{*}} g_{z}=C, \quad \sum_{u \in \overline{\mathbb{F}}_{q}} h_{u}=0 . \tag{3.3}
\end{equation*}
$$

Choose $\mathfrak{D}_{q^{n}} \subset \mathbf{T}$ such that $\alpha: \mathfrak{D}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}^{*}$ is a bijection. Combining (3.3), it is not difficult to get

$$
\begin{equation*}
\overline{\mathfrak{D}_{q^{n}}} \overline{U_{q^{n}}} \dot{s} \varepsilon(v) \zeta=(A+B+C) \overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta \tag{3.4}
\end{equation*}
$$

On the other hand, we also have

$$
\begin{equation*}
\overline{\mathfrak{D}_{q^{n}}} \overline{U_{q^{n}}} \zeta=(A+B) \overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{-}+\left(q^{n}-1\right) C \overline{U_{q^{n}}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta . \tag{3.5}
\end{equation*}
$$

If $A+B+C \neq 0$ and noting that $C \neq 0$, then we get $\overline{U_{q^{n}}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta$ using (3.4) and (3.5). Now assume that $A+B+C=0$, then by (3.5), we have

$$
\zeta^{\prime}:=\overline{U_{q^{n}}} \stackrel{\bar{s}}{U_{q^{n}}^{*}} \mathbf{1}_{-}-\left(q^{n}-1\right) \overline{U_{q^{n}}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta .
$$

Noting that $\zeta^{\prime}$ can be written as

$$
\begin{aligned}
\zeta^{\prime} & =\sum_{z \in \mathbb{F}_{q^{n}}^{*}} \overline{U_{q^{n}}} \Lambda(z) \mathbf{1}_{-}-\left(q^{n}-1\right) \overline{U_{q^{n}}} \mathbf{1}_{-} \\
& =\sum_{x, y \in \mathbb{F}_{q^{n}}^{*}, x y \neq 1} \varepsilon(x) \Lambda(y) \mathbf{1}_{-}-\left(q^{n}-1\right) \overline{U_{q^{n}}} \mathbf{1}_{-}
\end{aligned}
$$

using (3.2), thus it is not difficult to see that the sum of the coefficients in $\zeta^{\prime}$ is $-2\left(q^{n}-1\right)$. So we can discuss $\zeta^{\prime}$ instead of $\zeta$ form the beginning and also have $\overline{U_{q^{n}}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta$.

In conclusion, we have $\overline{U_{q^{n}}} \mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta$ and thus we get $\mathbf{1}_{-} \in \mathbb{k} \mathbf{G} \zeta$ by [10, Lemma 2.6]. Then for any element $\zeta \notin \mathbb{M}_{-}$, we see that $\mathbb{k} \mathbf{G} \zeta=\operatorname{Ind}_{\mathbf{N}}^{\mathbf{G}} \mathbb{k}_{-}$. So, the Steinberg module is the unique simple quotient module of $\operatorname{Ind}_{\mathbb{N}}^{\mathbf{G}} \mathbb{k}_{-}$. Hence Theorem 3.1(1) is proved.

Before the proof of Theorem 3.1(2), we need to introduce some properties of the nontrivial group homomorphisms from $\overline{\mathbb{F}}_{q}^{*}$ to $\mathbb{k}^{*}$, where $\mathbb{k}$ is an algebraically closed field of characteristic 0 as before.

Proposition 3.2. Let $\lambda: \overline{\mathbb{F}}_{q}^{*} \rightarrow \mathbb{k}^{*}$ be a nontrivial group homomorphism and $u_{1}, u_{2}, \ldots, u_{n} \in \overline{\mathbb{F}}_{q}^{*}$, which are different from each other. Let $x_{1}, x_{2}, \ldots, x_{n}$ be $n$ variables with values in $\overline{\mathbb{F}}_{q}^{*}$. Denote by $\mathbf{u}=\left(u_{1}, u_{2}, \ldots, u_{n}\right)$ and by
$\mathbf{x}=\left(x_{1}, x_{2}, \ldots, x_{n}\right)$. Let $A_{\mathbf{u}}^{\lambda}(\mathbf{x})$ be the matrix whose entry in row $i$ and column $j$ is $\lambda\left(x_{i}+u_{j}\right)$. Thus there exist infinitely many $\mathbf{x} \in\left(\overline{\mathbb{F}}_{q}^{*}\right)^{n}$ such that $\operatorname{det} A_{\mathbf{u}}^{\lambda}(\mathbf{x}) \neq 0$.

Proof. The lemma is obvious when $n=1$. Assume that this proposition holds when $n \leq m$. Now we consider the case for $n=m+1$. We set

$$
\mathbf{u}^{k}=\left(u_{1}, \ldots, u_{k-1}, u_{k+1}, \ldots, u_{m+1}\right), \quad \mathbf{x}^{\prime}=\left(x_{1}, x_{2}, \ldots, x_{m}\right) .
$$

By cofactor expansion respect to the last row, we have

$$
\operatorname{det} A_{\mathbf{u}}^{\lambda}(\mathbf{x})=\sum_{k=1}^{m+1}(-1)^{m+1+k} \lambda\left(x_{m+1}+u_{k}\right) \operatorname{det} A_{\mathbf{u}^{k}}^{\lambda}\left(\mathbf{x}^{\prime}\right)
$$

For each fixed integer $k=1,2, \ldots, m+1$, we have infinitely many $\mathbf{x}^{\prime} \in\left(\overline{\mathbb{F}}_{q}^{*}\right)^{m}$ such that $\operatorname{det} A_{\mathbf{u}^{k}}^{\lambda}\left(\mathbf{x}^{\prime}\right) \neq 0$ by the inductive hypothesis. Hence it is enough to show that for any element $a_{1}, a_{2}, \ldots, a_{m+1} \in \mathbb{k}^{*}$, there exists an element $x_{0} \in \overline{\mathbb{F}}_{q}^{*}$ such that

$$
\begin{equation*}
a_{1} \lambda\left(x_{0}+u_{1}\right)+a_{2} \lambda\left(x_{0}+u_{2}\right)+\cdots+a_{m+1} \lambda\left(x_{0}+u_{m+1}\right) \neq 0 . \tag{3.6}
\end{equation*}
$$

For an integer $s$, we let $\Gamma_{s}=\lambda\left(\mathbb{F}_{q^{s}}^{*}\right)$, which is a finite cyclic group in $\mathbb{k}^{*}$. Set $b_{k}=-a_{k} / a_{m+1}$ and we deal with the following equation

$$
b_{1} y_{1}+b_{2} y_{2}+\cdots+b_{m} y_{m}=1
$$

with solutions $\mathbf{y}=\left(y_{1}, y_{2}, \ldots, y_{m}\right) \in\left(\Gamma_{s}\right)^{m}$. Denote the solution set of this equation by $S\left(\mathbf{b}, \Gamma_{s}\right)$. Then by [11, Theorem 1.1], for any $s \in \mathbb{N}$, we have $\left|S\left(\mathbf{b}, \Gamma_{s}\right)\right| \leq \mathcal{C}(m)$ for some integer $\mathcal{C}(m)$ only depends on $m$. Since $\lambda: \overline{\mathbb{F}}_{q}^{*} \rightarrow \mathbb{k}^{*}$ is nontrivial and then we can choose the integer $s$ large enough such that

$$
\left|\Gamma_{s} / \operatorname{ker} \lambda\right|>\mathcal{C}(m)+m .
$$

Thus there exists $x_{0} \in \overline{\mathbb{F}}_{q}^{*}$ such that $x_{0}+u_{j} \neq 0$ for any $j=1,2, \ldots, m+1$ and (3.6) holds. The proposition is proved.

According to the above proof of Proposition [3.2, we get the following corollary immediately.

Corollary 3.3. Let $\lambda: \overline{\mathbb{F}}_{q}^{*} \rightarrow \mathbb{k}^{*}$ be a nontrivial group homomorphism and $u_{1}, u_{2}, \ldots, u_{n} \in \overline{\mathbb{F}}_{q}^{*}$, which are different from each other. Given $a_{1}, a_{2}, \ldots, a_{n} \in$ $\mathbb{k}^{*}$, then there exists infinitely many elements $x \in \overline{\mathbb{F}}_{q}^{*}$ such that

$$
a_{1} \lambda\left(x+u_{1}\right)+a_{2} \lambda\left(x+u_{2}\right)+\cdots+a_{n} \lambda\left(x+u_{n}\right) \neq 0 .
$$

Remark 3.4. Proposition 3.2 and Corollary 3.3 do not hold when $\mathbb{k}=\overline{\mathbb{F}}_{q}$. Indeed, we can choose $q$ elements $u_{1}, u_{2}, \ldots, u_{q} \in \overline{\mathbb{F}}_{q}^{*}$, which are different from each other and satisfy $u_{1}^{q}+u_{2}^{q}+\cdots+u_{q}^{q}=0$. Let $\lambda: \overline{\mathbb{F}}_{q}^{*} \rightarrow \overline{\mathbb{F}}_{q}^{*}$ be a group homomorphism such that $\lambda(x)=x^{q}$. Then it is easy to see that

$$
\lambda\left(x+u_{1}\right)+\lambda\left(x+u_{2}\right)+\cdots+\lambda\left(x+u_{q}\right)=0
$$

for any $x \in \overline{\mathbb{F}}_{q}^{*}$ with $x+u_{i} \neq 0$, which is a counter example to Proposition 3.2 and Corollary 3.3. However I guess that Proposition 3.2 and Corollary 3.3 still hold when char $\mathbb{k} \neq \operatorname{char} \overline{\mathbb{F}}_{q}$. Other methods need to be developed.

With the above preparations, now we prove Theorem 3.1(2).
Proof of Theorem $3.1(2)$. Let $\varphi_{e}: \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta} \rightarrow \mathbb{M}(\theta)$ be the natural morphism such that $\varphi_{e}\left(\mathbf{1}_{\theta}\right)=\widehat{\mathbf{1}}_{\theta}$, where $\widehat{\mathbf{1}}_{\theta}$ is a fixed nonzero element in $\mathbb{M}(\theta)_{\theta}$. Let $\varphi_{s}: \operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta} \rightarrow \mathbb{M}\left(\theta^{s}\right)$ be the morphism such that $\varphi_{s}\left(\mathbf{1}_{\theta}\right)=\dot{s} \widehat{\mathbf{1}}_{\theta^{s}}$. Both $\mathbb{M}(\theta)$ and $\mathbb{M}\left(\theta^{s}\right)$ are the simple quotient modules of $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$. Now let $\xi$ be a nonzero element in $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$. We will show that $\mathbb{k} \mathbf{G} \xi=\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$ if $\xi \notin \operatorname{ker} \varphi_{e}$ and $\xi \notin \operatorname{ker} \varphi_{s}$. Thus $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}} \mathbb{k}_{\theta}$ has no other simple quotient modules except $\mathbb{M}(\theta)$ and $\mathbb{M}\left(\theta^{s}\right)$.
Claim (\&): One has that $\overline{U_{q^{n}}} \dot{s} \overline{U_{q^{n}}^{*}} \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$ when $\xi \notin \operatorname{ker} \varphi_{e}$.
Proof of Claim ( $\boldsymbol{\phi}$ ): Now we write $\xi$ as following

$$
\xi=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \mathbf{1}_{\theta}+\sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z} \varepsilon(y) \dot{s} \varepsilon(z) \mathbf{1}_{\theta} .
$$

Noting that $\xi \notin \operatorname{ker} \varphi_{e}$, the following equation

$$
\varphi_{e}(\xi)=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \widehat{\mathbf{1}}_{\theta}+\sum_{y, z \in \mathbb{\mathbb { F }}_{q}} b_{y, z} \varepsilon(y) \dot{\boldsymbol{s}} \widehat{\mathbf{1}}_{\theta} \neq 0
$$

tells us that $\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \neq 0$ or $\sum_{z \in \overline{\mathbb{F}}_{q}} b_{y, z} \neq 0$ for some $y$. Without lost of generality, we can assume that $\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \neq 0$. Otherwise, it is enough to consider the element $\dot{s}^{-1} \varepsilon\left(-y_{0}\right) \xi$ instead of $\xi$. Moreover, we can also assume that $\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}+\sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z} \neq 0$. Otherwise, we can consider the element $t \xi$ for some $t \in \mathbf{T}$ instead of $\xi$. Indeed, it is easy to see that the sum of the coefficients in $t \xi$ is

$$
\begin{equation*}
\theta(t) \sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}+\theta^{s}(t) \sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z} . \tag{3.7}
\end{equation*}
$$

Noting that $\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}$ and $\sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z}$ are nonzero, we can choose one $t \in \mathbf{T}$ such that (3.7) is nonzero since $\theta$ is nontrivial.

With the assumption that

$$
\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \neq 0 \quad \text { and } \quad \sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}+\sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z} \neq 0,
$$

we show that $\overline{U_{q^{n}}} \dot{\bar{S}} \overline{U^{n}} \in \mathbb{k} \mathbf{G} \xi$ for some $n \in \mathbb{N}$. Firstly there exists $m \in \mathbb{N}$ such that $x, y, z \in \mathbb{F}_{q^{m}}$ when $a_{x} \neq 0$ and $b_{y, z} \neq 0$. Let $n>m$ and $m \mid n$. Given an element $u \in \mathbb{F}_{q^{n}} \backslash \mathbb{F}_{q^{m}}$, then the element $\eta:=\dot{s} \varepsilon(u) \xi$ has the following form

$$
\eta=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \dot{s} \varepsilon(u+x) \mathbf{1}_{\theta}+\sum_{y, z \in \overline{\mathbb{F}}_{q}} b_{y, z}^{\prime} \varepsilon\left(-(u+y)^{-1}\right) \dot{s} \varepsilon\left((u+y)^{2} z-(u+y)\right) \mathbf{1}_{\theta},
$$

where $b_{y, z}^{\prime}=b_{y, z} \theta(h(-(u+y)))$. Thus if we denote by $\eta$ as following

$$
\eta=\sum_{x, y \in \overline{\mathbb{F}}_{q}} f_{x, y} \varepsilon(x) \dot{s} \varepsilon(y) \mathbf{1}_{\theta},
$$

then we get $f_{x}:=\sum_{y \in \overline{\mathbb{F}}_{q}} f_{x, y} \neq 0$ for some $x$. Let $v \in \overline{\mathbb{F}}_{q}^{*}$ such that $v+x \neq 0$ when $f_{x, y} \neq 0$ and we consider the element

$$
\zeta:=\dot{s} \varepsilon(v) \eta=\sum_{x, y \in \overline{\mathbb{F}}_{q}} f_{x, y} \theta(h(-(v+x))) \varepsilon\left(-(v+x)^{-1}\right) \dot{s} \varepsilon\left((v+x)^{2} y-(v+x)\right) \mathbf{1}_{\theta} .
$$

By Lemma 3.3, we can choose some element $v$ such that the elements $(v+$ $x)^{2} y-(v+x)$ are nonzero when $f_{x, y} \neq 0$ and this element $v$ also makes

$$
f:=\sum_{x \in \overline{\mathbb{F}}_{q}} f_{x} \theta(h(-(v+x))) \neq 0 .
$$

As before we choose $\mathfrak{D}_{q^{n}} \subset \mathbf{T}$ such that $\alpha: \mathfrak{D}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}^{*}$ is a bijection. Therefore we get

$$
\sum_{t \in \mathfrak{Q}_{q^{n}}} \theta^{s}(t)^{-1} t \overline{U_{q^{n}}} \zeta=f \overline{U_{q^{n}}} \dot{S} \overline{U_{q^{n}}^{*}} \mathbf{1}_{\theta}
$$

which implies that $\overline{U_{q^{n}}} \dot{\delta} \overline{U_{q^{n}}^{*}} \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$. Claim ( $\boldsymbol{\varphi}$ ) is proved.

Claim ( $\boldsymbol{(})$ : When $\xi \notin \operatorname{ker} \varphi_{s}$, one has an element

$$
\xi^{\prime}=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \mathbf{1}_{\theta}+\sum_{y \in \overline{\mathbb{F}}_{q}} b_{y} \varepsilon(y) \dot{s} \mathbf{1}_{\theta}+\sum_{u \in \overline{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} c_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi
$$

such that $\sum_{y \in \overline{\mathbb{F}}_{q}} b_{y} \neq 0$.
Proof of Claim ( $\boldsymbol{\phi})$ : Firstly we study the form of the elements in $\operatorname{ker} \varphi_{s}$. Let $\varpi_{1}=\sum_{x \in \overline{\mathbb{F}}_{q}} f_{x} \varepsilon(x)\left(e+\sum_{u \in \overline{\mathbb{F}}_{q}} f_{x, u} \theta^{s}(-u) \varepsilon(u) \dot{s} \varepsilon\left(u^{-1}\right)\right) \mathbf{1}_{\theta}$,
where $\sum_{u \in \overline{\mathbb{F}}_{q}} f_{x, u}+1=0$ for any $x \in \overline{\mathbb{F}}_{q}$ and set

$$
\varpi_{2}=\sum_{y \in \overline{\mathbb{F}}_{q}} \varepsilon(y) \sum_{v \in \overline{\mathbb{F}}_{q}} g_{y, v} \theta^{s}(-v) \varepsilon(v) \dot{s} \varepsilon\left(v^{-1}\right) \mathbf{1}_{\theta},
$$

where $\sum_{v \in \overline{\mathbb{F}}_{q}} g_{y, v}=0$ for any $y \in \overline{\mathbb{F}}_{q}$. Moreover we let

$$
\varpi_{3}=\sum_{z \in \overline{\mathbb{F}}_{q}} h_{z} \varepsilon(z) \dot{s} \mathbf{1}_{\theta}, \quad \text { where } \quad \sum_{z \in \overline{\mathbb{F}}_{q}} h_{z}=0 .
$$

It is easy to check that $\varpi_{1}, \varpi_{2}, \varpi_{3} \in \operatorname{ker} \varphi_{s}$. Denote by $\Omega_{i}$ the set of the elements with the form of $\varpi_{i}$ for $i=1,2,3$. Then it is not difficult to see that each element of $\operatorname{ker} \varphi_{s}$ is a linear combination of the elements in $\Omega_{1}, \Omega_{2}$ and $\Omega_{3}$.

Now let $\xi$ be the following

$$
\xi=\sum_{x \in \overline{\mathbb{F}}_{q}} \alpha_{x} \varepsilon(x) \mathbf{1}_{\theta}+\sum_{y \in \overline{\mathbb{F}}_{q}} \beta_{y} \varepsilon(y) \dot{s} \mathbf{1}_{\theta}+\sum_{u \in \overline{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} \gamma_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}
$$

If $\sum_{y \in \overline{\mathbb{F}}_{q}} \beta_{y} \neq 0$, then $\xi$ has already satisfied our requirement. Otherwise, we can write

$$
\xi=\varpi+\sum_{u \in \widetilde{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} \tau_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}, \quad \tau_{u, v} \in \mathbb{k}
$$

such that $\varpi \in \operatorname{ker} \varphi_{s}$. Since $\xi \notin \operatorname{ker} \varphi_{s}$, the element

$$
\eta:=\sum_{u \in \widetilde{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} \tau_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}
$$

is not in $\operatorname{ker} \varphi_{s}$ and in particular, it is not in $\Omega_{2}$. Now for $x \in \overline{\mathbb{F}}_{q}$, set

$$
\Xi_{x}=\left\{(u, v) \mid \tau_{u, v} \neq 0 \text { and }(u-x) v=1\right\} .
$$

Since $\eta \notin \operatorname{ker} \varphi_{s}$, there exist an element $x_{0}$ such that

$$
\begin{equation*}
\sum_{(u, v) \in \Xi_{x_{0}}} \tau_{u, v} \theta^{s}(-v) \neq 0 \tag{3.8}
\end{equation*}
$$

by some easy computation. Now we consider the following element

$$
\xi^{\prime}=\dot{s} \varepsilon\left(-x_{0}\right) \xi=\dot{s} \varepsilon\left(-x_{0}\right)(\varpi+\eta) .
$$

Firstly, we have $\dot{s} \varepsilon\left(-x_{0}\right) \varpi \in \operatorname{ker} \varphi_{s}$, which is a linear combination of elements in $\Omega_{1}, \Omega_{2}$ and $\Omega_{3}$. For the second part $\dot{s} \varepsilon\left(-x_{0}\right) \eta$, it is easy to check that when $(u, v) \notin \Xi_{x_{0}}$, the element

$$
\dot{s} \varepsilon\left(-x_{0}\right) \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}=\varepsilon\left(u^{\prime}\right) \dot{s} \varepsilon\left(v^{\prime}\right) \mathbf{1}_{\theta}
$$

for some $u^{\prime} \in \overline{\mathbb{F}}_{q}$ and $v^{\prime} \in \overline{\mathbb{F}}_{q}^{*}$. On the other hand, for $(u, v) \in \Xi_{x_{0}}$, we have

$$
\dot{s} \varepsilon\left(-x_{0}\right) \sum_{(u, v) \in \Xi_{x_{0}}} \tau_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta}=\sum_{(u, v) \in \Xi_{x_{0}}} \tau_{u, v} \theta\left(-v^{-1}\right) \varepsilon(-v) \dot{s} \mathbf{1}_{\theta} .
$$

Noting that $\theta\left(-v^{-1}\right)=\theta^{s}(-v)$ and using (3.8), it is easy to check that $\xi^{\prime}=\dot{s} \varepsilon\left(-x_{0}\right) \xi \in \mathbb{k} \mathbf{G} \xi$ satisfies our requirement.

With Claim ( $\boldsymbol{\leftrightarrow}$ ) and Claim ( $\boldsymbol{\oplus}$ ), now we give the proof of Theorem 3.1(2). Let $\xi$ be an element such that $\xi \notin \operatorname{ker} \varphi_{e}$ and $\xi \notin \operatorname{ker} \varphi_{s}$. By Claim ( $\left.\boldsymbol{\uparrow}\right)$, there exists an element

$$
\xi^{\prime}=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \mathbf{1}_{\theta}+\sum_{y \in \overline{\mathbb{F}}_{q}} b_{y} \varepsilon(y) \dot{s} \mathbf{1}_{\theta}+\sum_{u \in \overline{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} c_{u, v} \varepsilon(u) \dot{s} \varepsilon(v) \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi
$$

such that $\sum_{y \in \overline{\mathbb{F}}_{q}} b_{y} \neq 0$. We denote by

$$
A=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}, \quad B:=\sum_{y \in \overline{\mathbb{F}}_{q}} b_{y}, \quad C=\sum_{u \in \overline{\mathbb{F}}_{q}, v \in \overline{\mathbb{F}}_{q}^{*}} c_{u, v}
$$

for simple. Let $n \in \mathbb{N}$ such that $x, y, u, v \in \mathbb{F}_{q^{n}}$ when $a_{x} \neq 0, b_{y} \neq 0$ and $c_{u, v} \neq 0$. As before we choose $\mathfrak{D}_{q^{n}} \subset \mathbf{T}$ such that $\alpha: \mathfrak{D}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}^{*}$ is a bijection. Hence it is not difficult to see that

$$
\sum_{t \in \mathfrak{D}_{q^{n}}} \theta^{s}(t)^{-1} t \overline{U_{q^{n}}} \xi^{\prime}=A \sum_{t \in \mathfrak{D}_{q^{n}}} \theta\left(t^{2}\right) \mathbf{1}_{\theta}+\left(q^{n}-1\right) B \overline{U_{q^{n}}} \dot{\mathbf{1}_{\theta}}+C \overline{U_{q^{n}}} \overline{\dot{U}} \overline{q^{n}} \mathbf{1}_{\theta},
$$

which is in $\mathbb{k} \mathbf{G} \xi$. When $n$ is big enough and $\theta$ is nontrivial on $\mathbb{F}_{q^{n}}^{*}$, we have $\sum_{t \in \mathfrak{Q}_{q^{n}}} \theta\left(t^{2}\right)=0$. By Claim (\&), we have $\overline{U_{q^{n}}} \overline{U_{q^{n}}^{*}} \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$ and then we get $\overline{U_{q^{n}}} \dot{s} \mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$ since $B$ is nonzero. So using [10, Lemma 2.6], we have $\mathbf{1}_{\theta} \in \mathbb{k} \mathbf{G} \xi$ and thus $\mathbb{k} \mathbf{G} \xi=\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}^{\mathbb{k}_{\theta}}}$. Therefore the induced module $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{G}^{\mathbf{G}}} \mathbb{k}_{\theta}$ has only two simple quotient modules $\mathbb{M}(\theta)$ and $\mathbb{M}\left(\theta^{s}\right)$. The theorem is proved.

## 4. Abelian category $\mathscr{C}(\mathbf{G})$

In this section, we show that the category $\mathscr{C}(\mathbf{G})$ is an abelian category for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$. For convenience, we denote

$$
\operatorname{Irr}(\mathbf{G})=\left\{\mathbb{k}_{\mathrm{tr}}, \mathrm{St}, \mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}} \text { is nontrivial }\right\} .
$$

This is the set of the simple objects in $\mathscr{C}(\mathbf{G})$. By [7, Theorem 2.5], the induced module $\operatorname{Ind}_{\mathbf{T}} \mathbf{B}^{\mathbf{B}} \mathbb{k}_{\theta}$ has a unique simple $\mathbb{k} \mathbf{B}$-submodule

$$
\mathcal{S}_{\theta}=\left\{\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \mathbf{1}_{\theta} \mid \sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}=0\right\}
$$

and the corresponding quotient module is $\mathbb{k}_{\theta}$.

Lemma 4.1. Let $\mathcal{S}=\mathcal{S}_{\text {tr }}$ be the unique simple $\mathbb{k} \mathbf{B}$-submodule of $\operatorname{Ind}_{\mathbf{T}}^{\mathrm{B}}$ tr. Then $\mathcal{S}^{n}$ (the direct sum of $n$-copies of $\mathcal{S}$ ) can not assign a $\mathbb{k} \mathbf{G}$-module structure for any $n \in \mathbb{N}$.

Proof. Firstly, each element $\xi \in \mathcal{S}^{n}$ has the following form

$$
\xi=\sum_{j, \mu} f_{j, \mu}\left(e-\varepsilon\left(x_{j, \mu}\right)\right) \lambda_{j}, \quad \text { where } x_{j, \mu} \in \overline{\mathbb{F}}_{q}^{*}, f_{j, \mu} \in \mathbb{k},
$$

where each $\lambda_{j}$ denotes the trivial character for $j=1,2, \ldots, n$. Suppose $\mathfrak{S}^{n}$ has a $\mathbb{k} \mathbf{G}$-module structure and for each $i=1,2, \ldots, n$, we set

$$
\dot{s}(e-\varepsilon(1)) \lambda_{i}=\sum_{j, \mu} g_{j, \mu}^{i}\left(e-\varepsilon\left(x_{j, \mu}^{i}\right)\right) \lambda_{j}, \quad \text { where } x_{j, \mu}^{i} \in \overline{\mathbb{F}}_{q}^{*}, g_{j, \mu}^{i} \in \mathbb{k}
$$

Using $t \in \mathbf{T}$ to act on both sides, then it is not difficult to see that for $y \in \overline{\mathbb{F}}_{q}^{*}$, we have

$$
\dot{s}(e-\varepsilon(y)) \lambda_{i}=\sum_{j, \mu} g_{j, \mu}^{i}\left(e-\varepsilon\left(y^{-1} x_{j, \mu}^{i}\right)\right) \lambda_{j} .
$$

Therefore we have

$$
\begin{align*}
& \dot{s} \varepsilon(z) \dot{s}(e-\varepsilon(1)) \lambda_{i}=\sum_{j, \mu} g_{j, \mu}^{i} \dot{s}\left(\varepsilon(z)-\varepsilon\left(x_{j, \mu}^{i}+z\right)\right) \lambda_{j}  \tag{4.1}\\
& =\sum_{j, \mu} g_{j, \mu}^{i} \sum_{k, \nu} g_{k, \nu}^{j}\left(\varepsilon\left(z^{-1} x_{k, \nu}^{j}\right)-\varepsilon\left(\left(x_{j, \mu}^{i}+z\right)^{-1} x_{k, \nu}^{j}\right)\right) \lambda_{k}
\end{align*}
$$

for any element $z \in \overline{\mathbb{F}}_{q}^{*}$ such that $x_{j, \mu}^{i}+z \neq 0$. On the other hand, since $\dot{s} \varepsilon(z) \dot{s}=\varepsilon\left(-z^{-1}\right) \dot{s} h(-z) \varepsilon\left(-z^{-1}\right)$, we get

$$
\begin{align*}
& \dot{s} \epsilon(z) \dot{s}(e-\varepsilon(1)) \lambda_{i}=\varepsilon\left(-z^{-1}\right) \dot{s}\left(\varepsilon(-z)-\varepsilon\left(z^{2}-z\right)\right) \lambda_{i}  \tag{4.2}\\
& \quad=\sum_{k, \nu} g_{k, \nu}^{i}\left(\varepsilon\left(-z^{-1}\left(1+x_{k, \nu}^{i}\right)\right)-\varepsilon\left(z^{-1}(z-1)^{-1}\left(x_{k, \nu}^{i}-z+1\right)\right)\right) \lambda_{k}
\end{align*}
$$

Combining the above two equations (4.1) and (4.2), we get the following

$$
\begin{align*}
& \sum_{j, \mu} g_{j, \mu}^{i} \sum_{k, \nu} g_{k, \nu}^{j}\left(\varepsilon\left(z^{-1} x_{k, \nu}^{j}\right)-\varepsilon\left(\left(x_{j, \mu}^{i}+z\right)^{-1} x_{k, \nu}^{j}\right)\right) \lambda_{k}  \tag{4.3}\\
& =\sum_{k, \nu} g_{k, \nu}^{i}\left(\varepsilon\left(-z^{-1}\left(1+x_{k, \nu}^{i}\right)\right)-\varepsilon\left(z^{-1}(z-1)^{-1}\left(x_{k, \nu}^{i}-z+1\right)\right)\right) \lambda_{k}
\end{align*}
$$

for any $z \in \overline{\mathbb{F}}_{q}^{*}$ such that $x_{j, \mu}^{i}+z \neq 0$ and $i=1,2, \ldots, n$. However it is not difficult to see that (4.3) is not an identity. Indeed, for any fixed $i=1,2, \ldots, n$, if there exists $x_{k_{0}, \nu_{0}}^{i} \neq-1$, then we can choose one $z_{0} \in \overline{\mathbb{F}}_{q}^{*}$ such that $\left.z_{0}^{-1}\left(z_{0}-1\right)^{-1}\left(x_{k_{0}, \nu_{0}}^{i}-z_{0}+1\right)\right)$ is different from the following set

$$
\left\{z_{0}^{-1} x_{k, \nu}^{j},\left(x_{j, \mu}^{i}+z_{0}\right)^{-1} x_{k, \nu}^{j},-z_{0}^{-1}\left(1+x_{k, \nu}^{i}\right) \mid g_{k, \nu}^{j} \neq 0, g_{j, \mu}^{i} \neq 0, g_{k, \nu}^{i} \neq 0 .\right\}
$$

If there is only one $x_{k, \nu}^{i}=-1$ such that $g_{k, \nu}^{i} \neq 0$, then (4.3) does not hold obviously. Therefore $\mathcal{S}^{n}$ can not assign a $\mathbb{k} \mathbf{G}$-module structure. The lemma is proved.

In general, using the same discussion as in Lemma 4.1, we have the following proposition.

Proposition 4.2. Let $\mathcal{S}_{\lambda}$ be the unique simple $\mathbb{k} \mathbf{B}$-submodule of $\operatorname{Ind}_{\mathbf{T}} \mathbf{B}_{\mathbb{k}_{\lambda}}$ for each $\lambda \in \widehat{\mathbf{T}}$. One has that $\bigoplus_{\lambda \in \widehat{\mathbf{T}}} \mathcal{S}_{\lambda}{ }^{n_{\lambda}}$ can not assign a $\mathbb{k} \mathbf{G}$-module structure, where $n_{\lambda} \in \mathbb{N}$ and only finitely many $n_{\lambda}$ are nonzero for $\lambda \in \widehat{\mathbf{T}}$.

Theorem 4.3. The category $\mathscr{C}(\mathbf{G})$ is an abelian category.
Proof. Recall the definition of $\mathscr{C}(\mathbf{G})$ in Section 1, it is enough to show that $\mathscr{C}(\mathbf{G})$ is closed under taking subquotients. Let $M$ be a $\mathbb{k} \mathbf{G}$-module with $\mathbf{T}$-eigenvectors $\xi_{1}, \xi_{2}, \ldots, \xi_{n}$ such that $M \cong \bigoplus_{i=1}^{n} \mathbb{k} \mathbf{U} \xi_{i}$ as $\mathbb{k} \mathbf{B}$-modules. Following [7, Theorem 2.5], when $\xi \in M_{\theta}$, each $\mathbb{k} \mathbf{U} \xi$ is isomorphic to $\operatorname{Ind}_{\mathbf{T}} \mathbf{B}_{\mathbb{k}_{\theta}}$ or $\mathbb{k}_{\theta}$. Thus $M$ is a $\mathbb{k} \mathbf{G}$-module of finite length. Let $N$ be a simple quotient of $M$, then $N$ has a $\mathbf{T}$-eigenvector which implies $N \in \operatorname{Irr}(\mathbf{G})$. The Steinberg module $\operatorname{St}$ is isomorphic to $\operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \mathbb{k}_{\operatorname{tr}}$ as $\mathbb{k} \mathbf{B}$-modules and $\mathbb{M}(\theta)$ is isomorphic
to $\mathbb{k}_{\theta} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbb{K}_{\theta^{s}}}$ as $\mathbb{k} \mathbf{B}$-modules. However since $\bigoplus_{\lambda \in \widehat{\mathbf{T}}} \mathcal{S}_{\lambda}{ }^{n_{\lambda}}$ can not assign a $\mathbb{k} \mathbf{G}$ module structure by Proposition 4.2, it is easy to see that the subquotients of $M$ are also in $\mathscr{C}(\mathbf{G})$. The theorem is proved.

Corollary 4.4. The category $\mathscr{C}(\mathbf{G})$ is noetherian and artinian.

A $\mathbb{k} \mathbf{G}$-module can be regarded as a $\mathbb{k} \mathbf{T}$-module (resp. $\mathbb{k} \mathbf{B}$-module) naturally. We denote by $\mathscr{C}(\mathbf{G})_{\mathbf{T}}$ (resp. $\left.\mathscr{C}(\mathbf{G})_{\mathbf{B}}\right)$ the full subcategory of $\mathbb{k} \mathbf{T}$-Mod (resp. $\mathbb{k} \mathbf{B}$-Mod), which consists of the objects in $\mathscr{C}(\mathbf{G})$.

Corollary 4.5. One has that $\operatorname{Hom}_{\mathbf{T}}\left(\mathbb{k}_{\theta},-\right): \mathscr{C}(\mathbf{G})_{\mathbf{T}} \rightarrow$ Vect is a exact functor for any $\theta \in \widehat{\mathbf{T}}$. Thus given a short exact sequence

$$
0 \longrightarrow M_{1} \longrightarrow M \longrightarrow M_{2} \longrightarrow 0
$$

in the category $\mathscr{C}(\mathbf{G})$, one has that $M^{\mathbf{T}} \cong M_{1}^{\mathbf{T}} \oplus M_{2}^{\mathbf{T}}$ as $\mathbf{T}$-modules. In particular, we have $\mathrm{Wt}(M)=\mathrm{Wt}\left(M_{1}\right) \cup \mathrm{Wt}\left(M_{2}\right)$.

Proof. Using the setting in [12, Section 2], when $\mathbb{k}$ is an algebraically closed field of characteristic zero, $\mathbb{k} \mathbf{B}$ is a locally Wedderburn algebra. Thus by [12, Lemma 3], $\mathbb{k}_{\theta}$ is an injective $\mathbb{k} \mathbf{B}$-module which implies the exactness of $\operatorname{Hom}_{\mathbf{B}}\left(-, \mathbb{k}_{\theta}\right)$. For $M \in \mathscr{C}(\mathbf{G})$, we have $M \cong \bigoplus_{i=1}^{n} \mathbb{k} \mathbf{U} \xi_{i}$ as $\mathbb{k} \mathbf{B}$-modules, where $\xi_{i} \in M_{\lambda_{i}}$. By [7, Theorem 2.5], the induced module $\operatorname{Ind}_{\mathbf{T}^{\mathbf{B}}}^{\mathbb{k}_{\theta}}$ has a unique simple $\mathbb{k} \mathbf{B}$-submodule $\mathcal{S}_{\theta}$ and the corresponding quotient module is $\mathbb{k}_{\theta}$. Thus each $\mathbb{k} \mathbf{U} \xi_{i}$ is isomorphic to $\operatorname{Ind}_{\mathbf{T}}^{\mathbb{B}_{\boldsymbol{k}_{i}}}$ or $\mathbb{k}_{\lambda_{i}}$ as $\mathbb{k} \mathbf{B}$-modules. Therefore it is easy to see that

$$
\operatorname{Hom}_{\mathbf{T}}\left(\mathbb{k}_{\theta}, M\right) \cong \operatorname{Hom}_{\mathbf{B}}\left(M, \mathbb{k}_{\theta}\right),
$$

which implies the exactness of $\operatorname{Hom}_{\mathbf{T}}\left(\mathbb{k}_{\theta},-\right)$. The rest part is obvious.
Corollary 4.6. Given a short exact sequence in $\mathscr{C}(\mathbf{G})$, then it is split regarded as a short exact sequence in $\mathscr{C}(\mathbf{G})_{\text {B }}$.

Proof. By the definition of $\mathscr{C}(\mathbf{G})$ and Proposition 4.2, noting that the set of simple objects in the category $\mathscr{C}(\mathbf{G})$ is

$$
\operatorname{Irr}(\mathbf{G})=\left\{\mathbb{k}_{\mathrm{tr}}, \mathrm{St}, \mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}} \text { is nontrivial }\right\}
$$

the corollary is proved.

## 5. Highest weight category

In this section, we show that $\mathscr{C}(\mathbf{G})$ is a highest weight category for $\mathbf{G}=$ $S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$. Firstly we recall the definition of highest weight category (see [8]).

Definition 5.1. Let $\mathscr{C}$ be a locally artinian, abelian, $\mathbb{k}$-linear category with enough injective objects that satisfies Grothendieck's condition. Then we call $\mathscr{C}$ a highest weight category if there exists a locally finite poset $\Lambda$ (the "weights" of $\mathscr{C}$ ), such that:
(a) There is a complete collection $\left\{S(\lambda)_{\lambda \in \Lambda}\right\}$ of non-isomorphic simple objects of $\mathscr{C}$ indexed by the set $\Lambda$.
(b) There is a collection $\left\{A(\lambda)_{\lambda \in \Lambda}\right\}$ of objects of $\mathscr{C}$ and, for each $\lambda$, an embedding $S(\lambda) \subset A(\lambda)$ such that all composition factors $S(\mu)$ of $A(\lambda) / S(\lambda)$ satisfy $\mu<\lambda$. For $\lambda, \mu \in \Lambda$, we have that $\operatorname{dim}_{\mathbb{k}} \operatorname{Hom}_{\mathscr{C}}(A(\lambda), A(\mu))$ and $[A(\lambda): S(\mu)]$ are finite.
(c) Each simple object $S(\lambda)$ has an injective envelope $\mathcal{J}(\lambda)$ in $\mathscr{C}$. Also, $\mathcal{J}(\lambda)$ has a good filtration $0=F_{0}(\lambda) \subset F_{1}(\lambda) \subset \ldots$ such that:
(i) $F_{1}(\lambda) \cong A(\lambda)$;
(ii) for $n>1, F_{n}(\lambda) / F_{n-1}(\lambda) \cong A(\mu)$ for some $\mu=\mu(n)>\lambda$;
(iii) for a given $\mu \in \Lambda, \mu=\mu(n)$ for only finitely many $n$;
(iv) $\bigcup F_{i}(\lambda)=\mathcal{J}(\lambda)$.

Actually, to show that $\mathscr{C}(\mathbf{G})$ is a highest weight category, the main difficulty is to prove that the category $\mathscr{C}(\mathbf{G})$ has enough injective objects.

Proposition 5.2. For any $M, N$ in $\mathscr{C}(\mathbf{G})$ such that $\mathrm{Wt}(M) \cap \mathrm{Wt}(N)=\emptyset$, we have $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(M, N)=0$.

Proof. Since each object in $\mathscr{C}(\mathbf{G})$ is of finite length, it is enough to show that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(M, N)=0$ for any simple object $M, N \in \mathscr{C}(\mathbf{G})$, where $\mathrm{Wt}(M) \cap$ $\mathrm{Wt}(N)=\emptyset$. Recall that $\operatorname{Irr}(\mathbf{G})=\left\{\mathbb{k}_{\mathrm{tr}}, \operatorname{St}, \mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}}\right.$ is nontrivial $\}$ is the set of simple objects in $\mathscr{C}(\mathbf{G})$, we will show that
$\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\text {tr }}, \mathbb{M}(\lambda)\right)=0, \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\operatorname{St}, \mathbb{M}(\mu))=0$ and $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\theta), S)=0$,
where $S$ is a simple object whose weights are different with $\theta$ and $\theta^{s}$.
(1) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{M}(\lambda)\right)=0$. Suppose we have a short exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathbb{M}(\lambda) \longrightarrow M \longrightarrow \mathbb{k}_{\text {tr }} \longrightarrow 0 \tag{5.1}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$. Then using Corollary 4.6, there exists an element $\xi \in M$ such that $z \xi=\xi$ for any $z \in \mathbf{B}$. Noting that $M_{\text {tr }}=\mathbb{k} \xi$, thus $\dot{s} \xi=a \xi$ for some
$a \in \mathbb{K}^{*}$. However the following equation

$$
\dot{s} \varepsilon(x) \dot{s} \xi=\varepsilon\left(-x^{-1}\right) \dot{s} h(-x) \varepsilon\left(-x^{-1}\right) \xi
$$

shows that $a$ must be 1. Therefore the short exact sequence (5.1) is split which implies that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{M}(\lambda)\right)=0$.
(2) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathbb{M}(\mu))=0$. Suppose we have a short exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathbb{M}(\mu) \longrightarrow N \longrightarrow \mathrm{St} \longrightarrow 0 \tag{5.2}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$. By Corollary 4.6, there exists an element $\eta \in N_{\text {tr }}$ such that $\dot{s} \eta=b \eta$ for some $b \in \mathbb{k}^{*}$ and $\dot{s} \varepsilon(1) \eta=(\varepsilon(-1)-e) \eta+\varpi$ for some $\varpi \in \mathbb{M}(\mu)$. Using $\dot{s}$ to act on both sides, we get $b=-1$. Moreover we have

$$
\dot{s} \varepsilon(x) \eta=\left(\varepsilon\left(-x^{-1}\right)-e\right) \eta+h\left(x^{-\frac{1}{2}}\right) \varpi
$$

Now we consider the element $\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \eta$. Firstly we have

$$
\begin{equation*}
\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \eta=\varepsilon\left(-z^{-1}\right) \dot{s} h(-z) \varepsilon\left(-z^{-1}\right) \varepsilon(1) \eta=\varepsilon\left(-z^{-1}\right) \dot{s} \varepsilon\left(z^{2}-z\right) \eta \tag{5.3}
\end{equation*}
$$

On the other hand, we get

$$
\begin{equation*}
\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \eta=\dot{s}(\varepsilon(z-1)-\varepsilon(z)) \eta+\dot{s} \varepsilon(z) \varpi \tag{5.4}
\end{equation*}
$$

Compare the above two equations (5.3) and (5.4), it is not difficult to get

$$
\begin{equation*}
\left.\dot{s} \varepsilon(z) \varpi=\varepsilon\left(-z^{-1}\right) h\left(\left(z^{2}-z\right)^{-\frac{1}{2}}\right)\right) \varpi+\left(h\left(z^{-\frac{1}{2}}\right)-h\left((z-1)^{-\frac{1}{2}}\right)\right) \varpi \tag{5.5}
\end{equation*}
$$

for any $z \in \overline{\mathbb{F}}_{q}$. Denote by

$$
\varpi=f \mathbf{1}_{\mu}+\sum_{x \in \overline{\mathbb{F}}_{q}} g_{x} \epsilon(x) \dot{s} \mathbf{1}_{\mu}, \quad \text { where } f, g_{x} \in \overline{\mathbb{F}}_{q}
$$

Then it is easy to see that $f=0$. Moreover if $g_{x} \neq 0$ when $x \neq 0,-1$, then (5.5) can not hold for any $z \in \overline{\mathbb{F}}_{q}$. Substitute $\varpi=a \dot{s} \mathbf{1}_{\mu}+b \varepsilon(-1) \dot{s} \mathbf{1}_{\mu}$ into (5.5) and we get $\varpi=0$. Thus the short exact sequence (5.2) is split which implies that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathbb{M}(\mu))=0$.
(3) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\theta), S)=0$ for some simple object $S$ whose weights are different with $\theta$ and $\theta^{s}$. Suppose we have a short exact sequence

$$
\begin{equation*}
0 \longrightarrow S \longrightarrow L \longrightarrow \mathbb{M}(\theta) \longrightarrow 0 \tag{5.6}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$. Then by Corollary 4.6, there exists $\zeta \in L_{\theta}$ such that $u \zeta=\zeta$ and thus $\dot{s} \zeta \in L_{\theta^{s}}$ since the weights of $S$ are different with $\theta$ and $\theta^{s}$. Thus the short exact sequence (5.6) is split and we have $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\theta), S)=0$.

Proposition 5.3. One has that $\mathbb{k}_{\text {tr }}$ and $\mathbb{M}(\theta)$ are injective objects in the category $\mathscr{C}(\mathbf{G})$ for any $\theta \in \widehat{\mathbf{T}}$.

Proof. By [12, Theorem 1], we see that $\mathbb{k}_{\text {tr }}$ is an injective $\mathbb{k} \mathbf{G}$-module and thus it is injective in $\mathscr{C}(\mathbf{G})$. According to Proposition 5.2, it is enough to show that
$\left.\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{K}_{\mathrm{tr}}, \mathbb{M}(\operatorname{tr})\right)=0, \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\operatorname{St}, \mathbb{M}(\operatorname{tr}))\right)=0, \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\lambda), \mathbb{M}(\theta))=0$,
where $\lambda=\theta$ or $\theta^{s}$.
(1) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\text {tr }}, \mathbb{M}(\operatorname{tr})\right)=0$. Since there is a short exact sequence

$$
0 \longrightarrow \mathrm{St} \longrightarrow \mathbb{M}(\operatorname{tr}) \longrightarrow \mathbb{k}_{\operatorname{tr}} \longrightarrow 0
$$

we get a long exact sequence

$$
\begin{aligned}
& 0 \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathbb{k}_{\mathrm{tr}}, \mathrm{St}\right) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{M}(\operatorname{tr})\right) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{k}_{\mathrm{tr}}\right) \\
& \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathrm{St}\right) \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{M}(\operatorname{tr})\right) \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{k}_{\mathrm{tr}}\right) \longrightarrow \ldots
\end{aligned}
$$

It is easy to check that $\operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathbb{k}_{\text {tr }}, \mathbb{M}(\operatorname{tr})\right)=0$ and $\operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathbb{k}_{\mathrm{tr}}, \mathbb{k}_{\mathrm{tr}}\right) \cong \mathbb{k}$. Noting that $\operatorname{Ext}_{\left.\mathscr{C}_{(\mathbf{G})}\right)}^{1}\left(\mathbb{k}_{\text {tr }}, \mathbb{k}_{\text {tr }}\right)=0$ because $\mathbb{k}_{\text {tr }}$ is injective in $\mathscr{C}(\mathbf{G})$, it is enough to verify that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\mathrm{tr}}, \mathrm{St}\right) \cong \mathbb{k}$. Given a short exact sequence

$$
0 \longrightarrow \mathrm{St} \longrightarrow M \longrightarrow \mathbb{k}_{\operatorname{tr}} \longrightarrow 0
$$

in $\mathscr{C}(\mathbf{G})$, then by Corollary 4.6, we get

$$
\operatorname{Hom}_{\mathbf{G}}(\mathbb{M}(\operatorname{tr}), M) \cong \operatorname{Hom}_{\mathbf{B}}\left(\mathbb{k}_{\mathrm{tr}}, M\right) \cong \mathbb{k}
$$

using Frobenius reciprocity. Thus $M \cong \mathbb{M}(\operatorname{tr})$ or $M \cong S t \oplus \mathbb{k}_{\text {tr }}$. Therefore $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{t r}, S t\right) \cong \mathbb{k}$ and hence $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{k}_{\text {tr }}, \mathbb{M}(\operatorname{tr})\right)=0$.
(2) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathbb{M}(\mathrm{tr}))=0$. Using the short exact sequence

$$
0 \longrightarrow \mathrm{St} \longrightarrow \mathbb{M}(\operatorname{tr}) \longrightarrow \mathbb{k}_{\operatorname{tr}} \longrightarrow 0,
$$

we get a long exact sequence

$$
\begin{aligned}
& 0 \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\mathrm{St}, \mathrm{St}) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}(\mathrm{St}, \mathbb{M}(\mathrm{tr})) \longrightarrow \operatorname{Hom}_{\mathscr{C}(\mathbf{G})}\left(\mathrm{St}, \mathbb{k}_{\mathrm{tr}}\right) \\
& \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathrm{St}) \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathbb{M}(\mathrm{tr})) \longrightarrow \operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathrm{St}, \mathbb{k}_{\mathrm{tr}}\right) \longrightarrow \ldots
\end{aligned}
$$

Since $\mathbb{k}_{t r}$ is injective and we have $\operatorname{Ext}_{\mathscr{G}(\mathbf{G})}^{1}\left(\mathrm{St}, \mathbb{k}_{\text {tr }}\right)=0$, it is enough to show that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathrm{St})=0$. Given a short exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathrm{St} \longrightarrow N \longrightarrow \mathrm{St} \longrightarrow 0 \tag{5.7}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$, then there exists $\xi_{1}, \xi_{2} \in N_{\text {tr }}$ such that $N \cong \mathbb{k} \mathbf{U} \xi_{1} \oplus \mathbb{k} \mathbf{U} \xi_{2}$ as $\mathbb{k} \mathbf{B}$-modules and $\mathbb{k} \mathbf{U} \xi_{1}$ is isomorphic to the Steinberg module. Firstly it is
easy to see that $\dot{s} \xi_{2}=-\xi_{2}+a \xi_{1}$ for some $a \in \mathbb{k}$. Using $\dot{s}$ to act on both sides, we get $a=0$ and thus $\dot{s} \xi_{2}=-\xi_{2}$. On the other hand, we have

$$
\dot{s} \varepsilon(1) \xi_{2}=(\varepsilon(-1)-e) \xi_{2}+\varpi
$$

for some $\varpi \in \mathbb{k} \mathbf{U} \xi_{1}$. Denote by $\varpi=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \xi_{1}$ and then we get

$$
\dot{s} \varepsilon(y) \xi_{2}=\left(\varepsilon\left(-y^{-1}\right)-e\right) \xi_{2}+\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon\left(x y^{-1}\right) \xi_{1}
$$

for any $y \in \overline{\mathbb{F}}_{q}^{*}$. Now we consider the element $\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \xi_{2}$. Firstly we have

$$
\begin{equation*}
\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \xi_{2}=\varepsilon\left(-z^{-1}\right) \dot{s} h(-z) \varepsilon\left(-z^{-1}\right) \varepsilon(1) \xi_{2}=\varepsilon\left(-z^{-1}\right) \dot{s} \varepsilon\left(z^{2}-z\right) \xi_{2} \tag{5.8}
\end{equation*}
$$

On the other hand, we have

$$
\begin{equation*}
\dot{s} \varepsilon(z) \dot{s} \varepsilon(1) \xi_{2}=\dot{s}(\varepsilon(z-1)-\varepsilon(z)) \xi_{2}+\dot{s} \varepsilon(z) \varpi \tag{5.9}
\end{equation*}
$$

Combining (5.8) and (5.9), it is not difficult to get
$\dot{s} \varepsilon(z) \sum_{x \in \overline{\mathbb{F}}_{q}} a_{x} \varepsilon(x) \xi_{1}=\sum_{x \in \overline{\mathbb{F}}_{q}} a_{x}\left(\varepsilon\left(x\left(z^{2}-z\right)^{-1}-z^{-1}\right)+\varepsilon\left(x z^{-1}\right)-\varepsilon\left(x(z-1)^{-1}\right)\right) \xi_{1}$
for any $z \in \overline{\mathbb{F}}_{q}$. If $a_{x} \neq 0$ when $x \neq 0,-1$, then the equation can not hold for any $z \in \overline{\mathbb{F}}_{q}$. However, substitute $\varpi=a \xi_{1}+b \varepsilon(-1) \xi_{1}$ into (5.10), we get $\varpi=0$ easily. Thus the short exact sequence (5.7) is split and we have $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathrm{St})=0$ which implies that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathrm{St}, \mathbb{M}(\operatorname{tr}))=0$.
(3) $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\lambda), \mathbb{M}(\theta))=0$ for $\lambda=\theta$ or $\theta^{s}$. Firstly given a short exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathbb{M}(\theta) \longrightarrow K \longrightarrow \mathbb{M}(\theta) \longrightarrow 0 \tag{5.11}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$, then by Corollary 4.6, we have

$$
K \cong \mathbb{k}_{\theta} \oplus \mathbb{k}_{\theta} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \mathbb{k}_{\theta^{s}} \oplus \operatorname{Ind}_{\mathbf{T}}^{\mathbf{B}} \mathbb{k}_{\theta^{s}}
$$

as $\mathbb{k} \mathbf{B}$-modules and there exists $\xi_{1}, \eta_{1} \in K_{\theta}$ and $\xi_{2}, \eta_{2} \in K_{\theta^{s}}$ such that $\mathbb{k} \xi_{1}+\mathbb{k} \mathbf{U} \xi_{2} \cong \mathbb{M}(\theta)$, which is a $\mathbb{k} \mathbf{G}$-submodule of $K$. We can assume that $\xi_{2}=\dot{s} \xi_{1}$. Now suppose

$$
\dot{s} \eta_{1}=a \xi_{2}+b \eta_{2}, \quad \dot{s} \eta_{2}=c \xi_{1}+d \eta_{1}
$$

for some $a, b, c, d \in \mathbb{k}$. Using $\dot{s}$ to act on both sides of the two equations, we get $c=-\frac{a}{b}$ and $d=\frac{1}{b}$. In particular, $b$ is nonzero. Now set $\widetilde{\eta_{2}}=a \xi_{2}+b \eta_{2}$.

Thus $\mathbb{k} \eta_{1}+\mathbb{k} \mathbf{U} \widetilde{\eta}_{2}$ is isomorphic to $\mathbb{M}(\theta)$. So the short exact sequence (5.11) is split which implies that $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}(\mathbb{M}(\theta), \mathbb{M}(\theta))=0$.

Next we consider the short exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathbb{M}(\theta) \longrightarrow L \longrightarrow \mathbb{M}\left(\theta^{s}\right) \longrightarrow 0 \tag{5.12}
\end{equation*}
$$

in $\mathscr{C}(\mathbf{G})$. There exists $\zeta_{1}, \varrho_{1} \in L_{\theta}$ and $\zeta_{2}, \varrho_{2} \in L_{\theta^{s}}$ such that $\mathbb{M}(\theta) \cong$ $\mathbb{k} \zeta_{1}+\mathbb{k} \mathbf{U} \zeta_{2}$. We can assume that $\zeta_{2}=\dot{s} \zeta_{1}$. Now suppose

$$
\dot{s} \varrho_{1}=a^{\prime} \zeta_{2}+b^{\prime} \varrho_{2}, \quad \dot{s} \varrho_{2}=c^{\prime} \zeta_{1}+d^{\prime} \varrho_{1},
$$

then we also get $c^{\prime}=-\frac{a^{\prime}}{b^{\prime}}$ and $d^{\prime}=\frac{1}{b^{\prime}}$. In particular, $b^{\prime}$ and $d^{\prime}$ are nonzero. Set $\widetilde{\varrho_{1}}=c^{\prime} \zeta_{1}+d^{\prime} \varrho_{1}$, then we get $\mathbb{M}\left(\theta^{s}\right) \cong \mathbb{k} \varrho_{2}+\mathbb{k} \mathbf{U} \widetilde{\varrho_{1}}$. Therefore the short exact sequence (5.12) is split and we also get $\operatorname{Ext}_{\mathscr{C}(\mathbf{G})}^{1}\left(\mathbb{M}\left(\theta^{s}\right), \mathbb{M}(\theta)\right)=0$. The proposition is proved.

Theorem 5.4. The category $\mathscr{C}(\mathbf{G})$ has enough injective objects.
Proof. By Proposition [5.3, the injective envelope for each simple object exists in the category $\mathscr{C}(\mathbf{G})$. Thus a standard argument shows that $\mathscr{C}(\mathbf{G})$ has enough injective objects (see [9, Theorem 2.7]).

Now we show that $\mathscr{C}(\mathbf{G})$ is a highest weight category. In Definition 5.1. the set of weights is $\Lambda=\{(\theta, J) \mid \theta \in \widehat{\mathbf{T}}, J \subset I(\theta)\}$ and we define the order of the weights by

$$
\left(\theta_{1}, J_{1}\right) \leq\left(\theta_{2}, J_{2}\right) \text {, if } \theta_{1}=\theta_{2} \text { and } J_{1} \supseteq J_{2} .
$$

Specifically, for $\mathbf{G}=S L_{2}\left(\overline{\mathbb{F}}_{q}\right), \Lambda=\{(\operatorname{tr}, \emptyset),(\operatorname{tr},\{s\}),(\theta, \emptyset) \mid \theta$ is nontrivial $\}$. Let $S(\operatorname{tr},\{s\})=A(\operatorname{tr},\{s\})=\mathbb{k}_{\operatorname{tr}}, S(\operatorname{tr}, \emptyset)=A(\operatorname{tr}, \emptyset)=$ St and $S(\theta, \emptyset)=$ $A(\theta, \emptyset)=\mathbb{M}(\theta)$. By Proposition [5.3, we set $\mathcal{J}(\operatorname{tr},\{s\})=\mathbb{k}_{\operatorname{tr}}, \mathcal{J}(\operatorname{tr}, \emptyset)=\mathbb{M}(\operatorname{tr})$ and $\mathcal{J}(\theta, \emptyset)=\mathbb{M}(\theta)$. It is not difficult to check that $\mathscr{C}(\mathbf{G})$ with this setting satisfies all the condition in Definition 5.1 and thus we have the following theorem.

Theorem 5.5. The category $\mathscr{C}(\mathbf{G})$ is a highest weight category.
According to the same discussion as [9, Section 4 and Section 5], all the indecomposable modules in $\mathscr{C}(\mathbf{G})$ are $\mathrm{St}, \mathbb{k}_{\text {tr }}$ and $\{\mathbb{M}(\theta) \mid \theta \in \widehat{\mathbf{T}}\}$. Therefore each object in $\mathscr{C}(\mathbf{G})$ is a direct sum of these modules. In particular, the category $\mathscr{C}(\mathbf{G})$ is a Krull-Schmidt category.

Remark 5.6. In [3, X.Y. Chen constructed a complex representation $M$ of $S L_{2}\left(\overline{\mathbb{F}}_{q}\right)$, which contains the Steinberg module as a proper submodule and the corresponding quotient module is the trivial module. However $M$ has no $\mathbf{B}$-stable line. So, this gives a negative answer to [9, Conjecture 3.7]. Thus the principal representation category $\mathscr{O}(\mathbf{G})$ introduced in 9 is not a highest weight category. Chen's work shows that $\mathscr{O}(\mathbf{G})$ is very complicated in general. However the representation $M$ he constructed in [3] is not in the category $\mathscr{C}\left(S L_{2}\left(\overline{\mathbb{F}}_{q}\right)\right)$. Therefore, for general reductive algebraic group $\mathbf{G}$, the category $\mathscr{C}(\mathbf{G})$ may be a good category for further study.
