# DEFORMATIONS OF MODIFIED $r$-MATRICES AND COHOMOLOGIES OF RELATED ALGEBRAIC STRUCTURES

#### Abstract

Modified $r$-matrices are solutions of the modified classical Yang-Baxter equation, introduced by Semenov-Tian-Shansky, and play important roles in mathematical physics. In this paper, first we introduce a cohomology theory for modified $r$-matrices. Then we study three kinds of deformations of modified $r$-matrices using the established cohomology theory, including algebraic deformations, geometric deformations and linear deformations. We give the differential graded Lie algebra that governs algebraic deformations of modified $r$-matrices. For geometric deformations, we prove the rigidity theorem and study when is a neighborhood of a modified $r$-matrix smooth in the space of all modified $r$-matrix structures. In the study of trivial linear deformations, we introduce the notion of a Nijenhuis element for a modified $r$-matrix. Finally, applications are given to study deformations of complement of the diagonal Lie algebra and compatible Poisson structures.

## 1. Introduction

In the seminal work [25], Semenov-Tian-Shansky showed that solutions of the modified classical Yang-Baxter equation, which we call modified $r$-matrices in this paper, play an important role in studying solutions of Lax equations [23, 25, 26]. Furthermore, modified $r$-matrices are intimately related to particular factorization problems in the corresponding Lie algebras and Lie groups. This factorization problem was considered by Reshetikhin and Semenov-Tian-Shansky in the framework of the enveloping algebra of a Lie algebra with a modified $r$-matrix to study quantum integrable systems [24]. Any modified $r$-matrix induces a post-Lie algebra [罒], and a factorization theorem for group-like elements of the completion of the Lie enveloping algebra of a post-Lie algebra was established by Ebrahimi-Fard, Mencattini and Munthe-Kaas in [ [9, 10]. Recently, the global factorization theorem for a Rota-Baxter Lie group was given in [15]. Moreover, modified $r$-matrices are also useful for the construction of flat metrics and Frobenius manifolds

[27], and compatible Poisson structures [18]. Note that in the associative algebra context, such objects are called modified Rota-Baxter algebras by Zhang, Gao and Guo [30, 31].

A classical approach to study a mathematical structure is to associate to it invariants. Among these, cohomology theories occupy a central position as they enable for example to control deformations or extension problems. Note that the cohomology theory for a skew-symmetric classical $r$-matrix was studied in [29] under the general framework of relative Rota-Baxter operators (also called $O$-operators [ [17]). The first purpose of this paper is to study the cohomology theory for a modified $r$-matrix. In [25], Semenov-Tian-Shansky showed that a modified $r$-matrix $R: \mathfrak{g} \rightarrow \mathfrak{g}$ on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ induces a new Lie algebra $\mathfrak{g}_{R}$ in which the Lie bracket $[\cdot, \cdot]_{R}$ is given by

$$
[x, y]_{R}=[R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}, \quad \forall x, y \in \mathfrak{g} .
$$

In [2], Bordemann showed that the induced Lie algebra $\mathfrak{g}_{R}$ represents on $\mathfrak{g}$. We use the corresponding Chevalley-Eilenberg cohomology [7] of the Lie algebra $\mathfrak{g}_{R}$ with coefficients in $\mathfrak{g}$ to define the cohomology of the modified $r$-matrix $R$. It is well known that there is a one-to-one correspondence between modified $r$-matrix $R$ and Rota-Baxter operator $B$ of weight 1 via the relation $R=\mathrm{Id}+2 B$. The cohomology theory of the latter was given in [16] and the Van Est type theorem was established. We also show that the cohomology of the modified $r$-matrix $R=\operatorname{Id}+2 B$ and the cohomology of the Rota-Baxter operator $B$ are isomorphic.

The concept of a formal deformation of an algebraic structure began with the seminal work of Gerstenhaber [13, [14] for associative algebras. Nijenhuis and Richardson extended this study to Lie algebras [20, 21]. There is a well known slogan, often attributed to Deligne, Drinfeld and Kontsevich: every reasonable deformation theory is controlled by a differential graded Lie algebra, determined up to quasi-isomorphism. This slogan has been made into a rigorous theorem by Lurie and Pridham [19, 22]. It is also meaningful to deform maps compatible with given algebraic structures. Recently, the deformation theory of morphisms was developed in [3, 11, ,12], the deformation theories of $O$-operators on Lie algebras and associative algebras were developed in [29, 6]. The second purpose of the paper is to study deformation theories of modified $r$ matrices. We study three kinds of deformations of a modified $r$-matrix $R$ :

- (algebraic deformations) first we consider algebraic deformation $R+R^{\prime}$ for certain linear map $R^{\prime}$, and show that this kind of deformations are governed by a differential graded Lie algebra. This fulfill the general slogan for the deformation theory proposed by Deligne, Drinfeld and Kontsevich;
- (geometric deformations) then we consider smooth geometric deformation $R_{t}$ such that $R_{0}=R$ using the approach developed by Crainic, Schatz and Struchiner in [5]. We show that the tangent space $T_{R} \mathrm{Orb}_{R}$ of the orbit $\mathrm{Orb}_{R}$ is the space of 2-coboundaries $B^{2}(R)$. Consequently, the condition $H^{2}(R)=0$ will imply certain rigidity theorem, and the condition $H^{3}(R)=0$ will imply the space of modified $r$-matrices on the Lie algebra $g$ is a manifold in a neighborhood of $R$. We also give the necessary and sufficient condition on a 2 -cocycle giving a geometric deformation using the Kuranishi map;
- (linear deformation) next we study linear deformation $R+t \hat{R}$. In particular, trivial linear deformations leads to the concept of Nijenhuis elements for a modified $r$-matrix. If $x \in \mathfrak{g}$ is a Nijenhuis element, then $\mathrm{ad}_{x}$ is a Nijenhuis operator on the Lie algebra $\mathfrak{g}_{R}$.
Note that certain particular deformation of classical $r$-matrices are considered in [28] in the study of integrable infinite-dimensional systems.

The papers is organized as follows. In Section $\quad$, we define the cohomology of a modified $r$-matrix $R$ using the Chevalley-Eilenberg cohomology of the Lie algebra $\mathfrak{g}_{R}$ with coefficients
in $\mathfrak{g}$. In Section 3, we construct a differential graded Lie algebra that governs algebraic deformations of a modified $r$-matrix. In Section $\cap$, we study geometric deformations of a modified $r$-matrix. In Section 5, we study linear deformations of a modified $r$-matrix. In Section 6, we study deformations of complement of the diagonal Lie algebra and compatible Poisson structures as applications.

## 2. Сономologies of modified $r$-matrices

In this section, we establish the cohomology theory of a modified $r$-matrix $R$ using the ChevalleyEilenberg cohomology of the Lie algebra $\mathfrak{g}_{R}$ with coefficients in $\mathfrak{g}$.

Definition 2.1. ([25]) Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra. A linear map $R: \mathfrak{g} \rightarrow \mathfrak{g}$ is called a modified $r$-matrix if it is a solution of the following modified classical Yang-Baxter equation:

$$
\begin{equation*}
[R(x), R(y)]_{\mathfrak{g}}=R\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right)-[x, y]_{\mathfrak{g}}, \quad \forall x, y \in \mathfrak{g} . \tag{1}
\end{equation*}
$$

Definition 2.2. Let $R$ and $R^{\prime}$ be modified $r$-matrices on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. A homomorphism from $R$ to $R^{\prime}$ is a Lie algebra homomorphism $\varphi: \mathfrak{g} \rightarrow \mathfrak{g}$ such that

$$
\varphi \circ R=R^{\prime} \circ \varphi
$$

Remark 2.3. The notion of a modified Rota-Baxter operator of weight -1 on an associative algebra was introduced in [8]. More precisely, it is a linear map $P: A \rightarrow A$ on an associative algebra $\left(A,{ }_{A}\right)$ satisfying

$$
P(u) \cdot{ }_{A} P(v)=P\left(P(u) \cdot{ }_{A} v+u \cdot{ }_{A} P(v)\right)-u \cdot{ }_{A} v, \quad \forall u, v \in A
$$

It is straightforward to see that if a linear map $P: A \rightarrow A$ is a modified Rota-Baxter operator of weight -1 on an associative algebra $\left(A,{ }_{A}\right)$, then $P$ is a modified $r$-matrix on the Lie algebra $\left(A,[\cdot, \cdot]_{A}\right)$, where $[\cdot, \cdot]_{A}$ is the commutator Lie bracket.

Remark 2.4. Let $R: \mathfrak{g} \rightarrow \mathfrak{g}$ be a linear map on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Under the condition $R^{2}=\mathrm{Id}$, the following structures are equivalent:

- $R$ is a modified r-matrix;
- $R$ is a Nijenhuis operator;
- $R$ is a product structure;
- There is a vector space direct sum decomposition $\mathfrak{g}=\mathfrak{g}_{1} \oplus \mathfrak{g}_{2}$ of $\mathfrak{g}$ into subalgebras $\mathfrak{g}_{1}$ and $\mathrm{g}_{2}$ such that $R$ is given by

$$
R(x, u)=(x,-u), \quad \forall x \in \mathfrak{g}_{1}, u \in \mathfrak{g}_{2} .
$$

Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra and $R$ be a modified $r$-matrix. Semenov-Tian-Shansky showed that $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ is a Lie algebra which plays important roles in the study of integrable systems [25], where

$$
\begin{equation*}
[x, y]_{R}=[R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}, \quad \forall x, y \in \mathfrak{g} . \tag{2}
\end{equation*}
$$

Recall that a matched pair of Lie algebras consists of Lie algebras $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right),\left(\mathfrak{h},[\cdot, \cdot]_{\mathfrak{h}}\right)$, a representation $\rho: \mathfrak{g} \rightarrow \mathfrak{g l}(\mathfrak{h})$ of $\mathfrak{g}$ on $\mathfrak{h}$ and a representation $\varrho: \mathfrak{h} \rightarrow \mathfrak{g l}(\mathfrak{g})$ of $\mathfrak{h}$ on $\mathfrak{g}$, such that some compatibility conditions are satisfied. Bordemann further showed that the induced Lie algebra $\mathfrak{g}_{R}$ represents on $\mathfrak{g}$ which leads to a matched pair of Lie algebras $\left(\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right),\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)\right)$ [ [ $]$. Here we give a direct proof to be self-contained.

Proposition 2.5. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Define a linear map $\rho: \mathfrak{g} \rightarrow \mathfrak{g l}(\mathfrak{g}) b y$

$$
\begin{equation*}
\rho(x) y=[R(x), y]_{\mathfrak{g}}-R\left([x, y]_{\mathfrak{g}}\right), \quad \forall x, y \in \mathfrak{g} . \tag{3}
\end{equation*}
$$

Then $\rho$ is a representation of the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ on the vector space $\mathfrak{g}$.
Proof. For all $x, y, z \in \mathfrak{g}$, by (11) and (3), we have

$$
\begin{aligned}
& {[\rho(x), \rho(y)] z } \\
= & \rho(x) \rho(y) z-\rho(y) \rho(x) z \\
= & \rho(x)\left([R(y), z]_{\mathfrak{g}}-R\left([y, z]_{\mathfrak{g}}\right)\right)-\rho(y)\left([R(x), z]_{\mathfrak{g}}-R\left([x, z]_{\mathfrak{g}}\right)\right) \\
= & {\left[R(x),[R(y), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}-\left[R(x), R\left([y, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}-R\left(\left[x,[R(y), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right)+R\left(\left[x, R\left([y, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right) } \\
& -\left[R(y),[R(x), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[R(y), R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}+R\left(\left[y,[R(x), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right)-R\left(\left[y, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right) \\
= & {\left[[R(x), R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}-R\left(\left[R(x),[y, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right)-R\left(\left[x,[R(y), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right)+\left[x,[y, z]_{\mathfrak{g}}\right]_{\mathfrak{g}} } \\
& +R\left(\left[R(y),[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right)-\left[y,[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}+R\left(\left[y,[R(x), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right) \\
= & {\left[[R(x), R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}+\left[[x, y]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}-R\left(\left[[R(x), y]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right)-R\left(\left[[x, R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right), }
\end{aligned}
$$

and

$$
\begin{aligned}
& \rho\left([x, y]_{R}\right) z \\
= & \rho\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right) z \\
= & {\left[R\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}-R\left(\left[[R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right) } \\
= & {\left[[R(x), R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}+\left[[x, y]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}-R\left(\left[[R(x), y]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right)-R\left(\left[[x, R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right) . }
\end{aligned}
$$

Thus we have $\rho\left([x, y]_{R}\right)=[\rho(x), \rho(y)]$, which means that $\rho$ is a representation of $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ on the vector space $\mathfrak{g}$.

Let $\mathrm{d}_{\mathrm{CE}}^{R}: \operatorname{Hom}\left(\wedge^{k} \mathfrak{g}, \mathfrak{g}\right) \rightarrow \operatorname{Hom}\left(\wedge^{k+1} \mathfrak{g}, \mathfrak{g}\right)$ be the corresponding Chevalley-Eilenberg coboundary operator of the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ with coefficients in the representation $(\mathfrak{g}, \rho)$. More precisely, for all $f \in \operatorname{Hom}\left(\wedge^{k} \mathfrak{g}, \mathfrak{g}\right)$ and $x_{1}, \cdots, x_{k+1} \in \mathfrak{g}$, we have

$$
\begin{align*}
& \mathrm{d}_{\mathrm{CE}}^{R} f\left(x_{1}, \cdots, x_{k+1}\right)  \tag{4}\\
= & \sum_{i=1}^{k+1}(-1)^{i+1} \rho\left(x_{i}\right) f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right) \\
& +\sum_{i<j}(-1)^{i+j} f\left(\left[x_{i}, x_{j}\right]_{R}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{k+1}\right) \\
= & \sum_{i=1}^{k+1}(-1)^{i+1}\left[R\left(x_{i}\right), f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{g} \\
& -\sum_{i=1}^{k+1}(-1)^{i+1} R\left(\left[x_{i}, f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{g}\right) \\
& +\sum_{i<j}(-1)^{i+j} f\left(\left[R\left(x_{i}\right), x_{j}\right]_{\mathfrak{g}}+\left[x_{i}, R\left(x_{j}\right)\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{k+1}\right) .
\end{align*}
$$

Now, we define the cohomology of a modified $r$-matrix $R: \mathfrak{g} \rightarrow \mathfrak{g}$. Define the space of 0 cochains $C^{0}(R)$ to be 0 and define the space of 1-cochains $C^{1}(R)$ to be $\mathfrak{g}$. For $n \geq 2$, define the space of $n$-cochains $C^{n}(R)$ by $C^{n}(R)=\operatorname{Hom}\left(\wedge^{n-1} \mathfrak{g}, \mathfrak{g}\right)$.

Definition 2.6. Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra and $R$ be a modified $r$-matrix. The cohomology of the cochain complex $\left(\oplus_{i=0}^{+\infty} C^{i}(R), \mathrm{d}_{\mathrm{CE}}^{R}\right)$ is defined to be the cohomology for the modified $r$-matrix $R$.

Denote the set of $n$-cocycles by $Z^{n}(R)$, the set of $n$-coboundaries by $B^{n}(R)$ and the $n$-th cohomology group by

$$
H^{n}(R)=Z^{n}(R) / B^{n}(R), \quad n \geq 0
$$

It is obvious that $x \in \mathfrak{g}$ is closed if and only if

$$
\operatorname{ad}_{x} \circ R=R \circ \operatorname{ad}_{x},
$$

and $f \in \operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ is closed if and only if
(6) $[R(x), f(y)]_{\mathfrak{g}}-R\left([x, f(y)]_{\mathfrak{g}}\right)-[R(y), f(x)]_{\mathfrak{g}}+R\left([y, f(x)]_{\mathfrak{g}}\right)=f\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right)$,
for all $x, y \in \mathfrak{g}$.
At the end of this section, we recall the cohomology theory of Rota-Baxter operators given in [16], and establish its relation with the cohomology theory of modified $r$-matrices.

Definition 2.7. Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra. A linear map $B: \mathfrak{g} \rightarrow \mathfrak{g}$ is called a Rota-Baxter operator of weight $\lambda$ if

$$
[B(x), B(y)]_{\mathfrak{g}}=B\left([B(x), y]_{\mathfrak{g}}+[x, B(y)]_{\mathfrak{g}}+\lambda[x, y]_{\mathfrak{g}}\right), \quad \forall x, y \in \mathfrak{g} .
$$

The following result is well known.
Proposition 2.8. Let $\mathfrak{g}$ be a Lie algebra and $B \in \mathfrak{g l}(\mathfrak{g})$. The linear map $\mathrm{Id}+2 B$ is a modified $r$-matrix on $\mathfrak{g}$ if and only if $B$ is a Rota-Baxter operator of weight 1 on $\mathfrak{g}$.

Let $B$ be a Rota-Baxter operator of weight 1 on a Lie algebra $\mathfrak{g}$. Consider the cochain complex $\left(\oplus_{k=1}^{+\infty} C^{k}(B), \mathrm{d}_{\mathrm{CE}}^{B}\right)$, where $C^{1}(B)=\mathfrak{g}$ and $C^{k}(B)=\operatorname{Hom}\left(\wedge^{k-1} \mathfrak{g}, \mathfrak{g}\right)$ for $k \geq 2$, and $\mathrm{d}_{\mathrm{CE}}^{B}$ is defined by

$$
\begin{aligned}
& \mathrm{d}_{\mathrm{CE}}^{B} f\left(u_{1}, \cdots, u_{k+1}\right) \\
= & \sum_{i=1}^{k+1}(-1)^{i+1} B\left(\left[f\left(u_{1}, \cdots, \hat{u}_{i}, \cdots, u_{k+1}\right), u_{i}\right]_{\mathfrak{g}}\right) \\
& +\sum_{i=1}^{k+1}(-1)^{i+1}\left[B\left(u_{i}\right), f\left(u_{1}, \cdots, \hat{u}_{i}, \cdots, u_{k+1}\right)\right]_{\mathfrak{g}} \\
& +\sum_{i<j}(-1)^{i+j} f\left(\left[B\left(u_{i}\right), u_{j}\right]_{\mathfrak{g}}-\left[B\left(u_{j}\right), u_{i}\right]_{\mathfrak{g}}+\left[u_{i}, u_{j}\right]_{\mathfrak{g}}, u_{1}, \cdots, \hat{u}_{i}, \cdots, \hat{u}_{j}, \cdots, u_{k+1}\right),
\end{aligned}
$$

where $f \in C^{k+1}(B)$ and $u_{i} \in \mathfrak{g}, 1 \leq i \leq k+1$.
It was proved in [16] that $\left(\mathrm{d}_{\mathrm{CE}}^{B}\right)^{2}=0$. The cohomology of the cochain complex $\left(\oplus_{k=1}^{+\infty} C^{k}(B), \mathrm{d}_{\mathrm{CE}}^{B}\right)$ is defined to be the cohomology of the Rota-Baxter operator $B$.

Theorem 2.9. With the above notations, we have

$$
\mathrm{d}_{\mathrm{CE}}^{R}=2 \mathrm{~d}_{\mathrm{CE}}^{B} .
$$

Consequently, for $k \geq 1$, the $k$-th cohomology group $H^{k}(B)$ of a Rota-Baxter operator $B$ is isomorphic with the $k$-th cohomology group $H^{k}(R)$ of the modified $r$-matrix $R=\mathrm{Id}+2 B$.

Proof. For $k \geq 1$, define linear maps $\Phi_{k}: C^{k}(B) \rightarrow C^{k}(R)$ by $\Phi_{k}=2^{k-2} \mathrm{Id}$. Then the following diagram is commutative:


In fact, for any $f \in \operatorname{Hom}\left(\wedge^{k} \mathfrak{g}, \mathfrak{g}\right), x_{i} \in \mathfrak{g}, 1 \leq i \leq k+1$, we have

$$
\begin{aligned}
& \mathrm{d}_{\mathrm{CE}}^{R}\left(\Phi_{k} f\right)\left(x_{1}, \cdots, x_{k+1}\right) \\
= & 2^{k-1}\left(\sum _ { i = 1 } ^ { k + 1 } ( - 1 ) ^ { i + 1 } \left(\left[x_{i}, f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}}\right.\right. \\
& \left.+2\left[B\left(x_{i}\right), f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}}\right) \\
& -\sum_{i=1}^{k+1}(-1)^{i+1}\left[x_{i}, f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}} \\
& -\sum_{i=1}^{k+1}(-1)^{i+1} 2 B\left(\left[x_{i}, f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}}\right) \\
& +\sum_{i<j}(-1)^{i+j} 2 f\left(\left[x_{i}, x_{j}\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{k+1}\right) \\
& \left.+\sum_{i<j}(-1)^{i+j} 2 f\left(\left[B\left(x_{i}\right), x_{j}\right]_{\mathfrak{g}}+\left[x_{i}, B\left(x_{j}\right)\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{k+1}\right)\right) \\
= & 2^{k}\left(\sum_{i=1}^{k+1}(-1)^{i+1}\left(\left[B\left(x_{i}\right), f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}}-B\left(\left[x_{i}, f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{k+1}\right)\right]_{\mathfrak{g}}\right)\right)\right. \\
& \left.+\sum_{i<j}^{i+1}(-1)^{i+j} f\left(\left[B\left(x_{i}\right), x_{j}\right]_{\mathfrak{g}}+\left[x_{i}, B\left(x_{j}\right)\right]_{\mathfrak{g}}+\left[x_{i}, x_{j}\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{k+1}\right)\right) \\
= & \Phi_{k+1}\left(\mathrm{~d}_{\mathrm{CE}}^{B} f\right)\left(x_{1}, \cdots, x_{k+1}\right),
\end{aligned}
$$

which implies that $\mathrm{d}_{\mathrm{CE}}^{R}=2 \mathrm{~d}_{\mathrm{CE}}^{B}$ and $H^{k}(B) \cong H^{k}(R), k \geq 1$.
Example 2.10. Consider the Lie algebra $\mathfrak{g}=\mathfrak{s l}(n, \mathbb{R})$. It is well known that the Cartan subalgebra of $\mathfrak{s l}(n, \mathbb{R})$ is $H=\operatorname{span}\left\{E_{i i}-E_{i+1 i+1} \mid 1 \leq i \leq n-1\right\}$. Denote the Borel subalgebra of $\mathfrak{s l}(n, \mathbb{R})$ by $B(\mathfrak{s l}(n, \mathbb{R}))$. It is well known that $B(\mathfrak{s l}(n, \mathbb{R}))=H \oplus \operatorname{span}\left\{E_{i j} \mid i<j\right\}$. Thus $\mathfrak{s l}(n, \mathbb{R})=B(\mathfrak{s l}(n, \mathbb{R})) \oplus A$ as vector spaces, where $A=\operatorname{span}\left\{E_{i j} \mid i>j\right\}$. Define a linear map $R: \mathfrak{s l}(n, \mathbb{R}) \rightarrow \mathfrak{s l}(n, \mathbb{R})$ by

$$
R(x+u)=x-u, \quad \forall x \in B(\mathfrak{s l}(n, \mathbb{R})), u \in A .
$$

By Remark 2.4, we obtain that $R$ is a modified $r$-matrix on the Lie algebra $\mathfrak{s l}(n, \mathbb{R})$. Assume that $a=x+u \in \mathfrak{s l}(n, \mathbb{R})$ where $x \in B(\mathfrak{s l}(n, \mathbb{R}))$ and $u \in A$, such that $\mathrm{d}_{\mathrm{CE}}^{R} a=0$, that is

$$
\mathrm{d}_{\mathrm{CE}}^{R} a(y)=[R(y), a]-R([y, a])=0, \quad \forall y \in \mathfrak{s l}(n, \mathbb{R}) .
$$

- For any $y \in A,[R(y), a]-R([y, a])=0$ implies that $x \in H$.
- For any $y \in B(\mathfrak{s l}(n, \mathbb{R})),[R(y), a]-R([y, a])=0$ implies that $u=0$.

Thus $\mathrm{d}_{\mathrm{CE}}^{R} a=0$ if and only if $a \in H$. Therefore, $H^{1}(R) \cong \mathbb{R}^{n-1}$.

Example 2.11. Consider the Lie algebra $\mathfrak{g}=\mathfrak{s l}(2, \mathbb{R})$, where the Lie bracket is given by $[e, f]=$ $h,[h, e]=2 e$ and $[h, f]=-2 f$ with respect to the basis $\{e, f, h\}$. Then $R: \mathfrak{s l}(2, \mathbb{R}) \rightarrow \mathfrak{s l}(2, \mathbb{R})$ defined by

$$
R(e, f, h)=(e, f, h)\left(\begin{array}{ccc}
1 & 0 & 0 \\
0 & -1 & 0 \\
0 & 0 & 1
\end{array}\right)
$$

is a modified $r$-matrix. Let $T=\left(\begin{array}{ccc}t_{11} & t_{12} & t_{13} \\ t_{21} & t_{22} & t_{23} \\ t_{31} & t_{32} & t_{33}\end{array}\right): \mathfrak{s l}(2, \mathbb{R}) \rightarrow \mathfrak{s l}(2, \mathbb{R})$ satisfy $\mathrm{d}_{\mathrm{CE}}^{R} T=0$. Then we obtain

$$
\begin{aligned}
& 0=[e, T(f)]+[f, T(e)]-R([e, T(f)])+R([f, T(e)]), \\
& 0=[e, T(h)]-[h, T(e)]-R([e, T(h)])+R([h, T(e)])+4 T(e)
\end{aligned}
$$

and

$$
0=-[f, T(h)]-[h, T(f)]-R([f, T(h)])+R([h, T(f)]) .
$$

Thus we have $t_{11}=t_{21}=t_{31}=0$ and $t_{22}=t_{13}=0$. By Example 2.10, we have $B^{2}(R)=\operatorname{Imd}_{\mathrm{CE}}^{R} \cong$ $\frac{\mathrm{g}}{\operatorname{ker~}^{\mathrm{d}} \mathrm{CE}_{R}^{R}}=\frac{\mathrm{g}}{H^{1}(R)} \cong \mathbb{R}^{2}$. Thus $H^{2}(R) \simeq \mathbb{R}^{2}$.

## 3. Algebraic deformations of modified $r$-matrices

In this section, we construct a differential graded Lie algebra that governs algebraic deformations of a modified $r$-matrix.

Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra. We consider the graded vector space $C^{*}(\mathfrak{g})=\oplus_{k=1}^{+\infty} \operatorname{Hom}\left(\wedge^{k} \mathfrak{g}, \mathfrak{g}\right)$. Define a skew-symmetric bracket operation

$$
\llbracket \cdot, \cdot \rrbracket: \operatorname{Hom}\left(\wedge^{p} \mathfrak{g}, \mathfrak{g}\right) \times \operatorname{Hom}\left(\wedge^{q} \mathfrak{g}, \mathfrak{g}\right) \rightarrow \operatorname{Hom}\left(\wedge^{p+q} \mathfrak{g}, \mathfrak{g}\right)
$$

by

$$
\begin{align*}
= & \llbracket f, g \rrbracket\left(x_{1}, x_{2}, \cdots, x_{p+q}\right)  \tag{7}\\
& \sum_{\sigma \in S(q, 1, p-1)}(-1)^{\sigma} f\left(\left[g\left(x_{\sigma(1)}, \cdots, x_{\sigma(q)}\right), x_{\sigma(q+1)}\right]_{\mathfrak{g}}, x_{\sigma(q+2)}, \cdots, x_{\sigma(p+q)}\right) \\
& -(-1)^{p q} \sum_{\sigma \in S(p, 1, q-1)}(-1)^{\sigma} g\left(\left[f\left(x_{\sigma(1)}, \cdots, x_{\sigma(p)}\right), x_{\sigma(p+1)}\right]_{\mathfrak{g}}, x_{\sigma(p+2)}, \cdots, x_{\sigma(p+q)}\right) \\
& +(-1)^{p q} \sum_{\sigma \in S(p, q)}(-1)^{\sigma}\left[f\left(x_{\sigma(1)}, \cdots, x_{\sigma(p)}\right), g\left(x_{\sigma(p+1)}, \cdots, x_{\sigma(p+q)}\right)\right]_{g},
\end{align*}
$$

for all $f \in \operatorname{Hom}\left(\wedge^{p} \mathfrak{g}, \mathfrak{g}\right), g \in \operatorname{Hom}\left(\wedge^{q} \mathfrak{g}, \mathfrak{g}\right)$.
Then we have the following theorem characterizing modified $r$-matrices.
Theorem 3.1. Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra. Then $\left(C^{*}(\mathfrak{g}),[\cdot \cdot, \cdot]\right)$ is a graded Lie algebra and its Maurer-Cartan elements are precisely Rota-Baxter operators of weight 0 .

Moreover, a linear map $R \in \mathfrak{g l}(\mathfrak{g})$ is a modified $r$-matrix on the Lie algebra $\mathfrak{g}$ if and only if $R$ satisfies the equation

$$
\begin{equation*}
\llbracket R, R \rrbracket=2 \pi . \tag{8}
\end{equation*}
$$

where denote $[\cdot, \cdot]_{\mathfrak{g}}$ by $\pi$.

Proof. By [29, Corollary 6.1], $\left(C^{*}(\mathrm{~g}), \mathbb{[} \cdot, \cdot \mathbb{d}\right)$ is a graded Lie algebra.
For $R \in \mathfrak{g l}(\mathfrak{g})$, we have

$$
\llbracket R, R \rrbracket(x, y)=2\left(R\left([R(x), y]_{\mathfrak{g}}\right)-R\left([R(y), x]_{\mathfrak{g}}\right)-[R(x), R(y)]_{\mathfrak{g}}\right), \quad \forall x, y \in \mathfrak{g} .
$$

By this equality, we can deduce that on the one hand $R$ is a Rota-Baxter operator of weight 0 if and only if $\llbracket R, R \rrbracket=0$, i.e. $R$ is a Maurer-Cartan element. On the other hand, $R$ is a modified $r$-matrix on the Lie algebra $\mathfrak{g}$ if and only if $R$ satisfies (8).

Proposition 3.2. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Then $\llbracket R, R \rrbracket$ is in the center of the graded Lie algebra $\left(C^{*}(\mathfrak{g}), \llbracket \cdot, \cdot \|\right)$.

Proof. Denote the Lie bracket $[\cdot, \cdot]_{\mathfrak{g}}$ by $\pi$. Since $R$ is a modified $r$-matrix on the Lie algebra $\mathfrak{g}$, we have $\llbracket R, R \rrbracket=2 \pi$ via Theorem 3.1. For all $f \in \operatorname{Hom}\left(\wedge^{k} \mathfrak{g}, \mathfrak{g}\right)$, by (7), we have

$$
\begin{aligned}
& \llbracket 2 \pi, f \rrbracket\left(x_{1}, \cdots, x_{k}, x_{k+1}, x_{k+2}\right) \\
= & 2\left(\sum_{\sigma \in S(k, 1,1)}(-1)^{|\sigma|} \pi\left(\pi\left(f\left(x_{\sigma(1)}, \cdots, x_{\sigma(k)}\right), x_{\sigma(k+1)}\right), x_{\sigma(k+2)}\right)\right. \\
& -\sum_{\sigma \in S(2,1, k-1)}(-1)^{|\sigma|} f\left(\pi\left(\pi\left(x_{\sigma(1)}, x_{\sigma(2)}\right), x_{\sigma(3)}\right), x_{\sigma(4)}, \cdots, x_{\sigma(k+2)}\right) \\
& \left.+\sum_{\sigma \in S(2, k)}(-1)^{|\sigma|} \pi\left(\pi\left(x_{\sigma(1)}, x_{\sigma(2)}\right), f\left(x_{\sigma(3)}, \cdots, x_{\sigma(k+2)}\right)\right)\right) \\
= & 0
\end{aligned}
$$

which implies that $\llbracket R, R \rrbracket$ is in the center of $C^{*}(\mathfrak{g})$.
We denote $\llbracket R, \cdot \rrbracket$ by $\mathrm{d}_{R}$. Now we obtain the differential graded Lie algebra that governs algebraic deformations of a modified $r$-matrix.

Theorem 3.3. With the above notations, $\left(C^{*}(\mathfrak{g}), \llbracket \cdot, \cdot \rrbracket, \mathrm{d}_{R}\right)$ is a differential graded Lie algebra.
Furthermore, $R+R^{\prime}$ is still a modified $r$-matrix on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ if and only if $R^{\prime}$ is a Maurer-Cartan element of the differential graded Lie algebra $\left.\left(C^{*}(\mathfrak{g}), \mathbb{[} \cdot, \cdot\right], \mathrm{d}_{R}\right)$.

Proof. It follows from the graded Jacobi identity that $\mathrm{d}_{R}$ is a graded derivation on the graded Lie algebra $\left(C^{*}(\mathfrak{g}), \mathbb{[} \cdot, \cdot \mathbb{]}\right)$. By Proposition 3.2, we have

$$
\mathrm{d}_{R}^{2} f=\llbracket R, \llbracket R, f \rrbracket \rrbracket=\llbracket \llbracket R, R \rrbracket, f \rrbracket-\llbracket R, \llbracket R, f \rrbracket \rrbracket,
$$

which implies that

$$
\mathrm{d}_{R}^{2} f=\llbracket R, \llbracket R, f \rrbracket \rrbracket=\frac{1}{2} \llbracket \llbracket R, R \rrbracket, f \rrbracket=0 .
$$

Therefore, $\left(C^{*}(\mathfrak{g}), \llbracket \cdot, \cdot \rrbracket, \mathrm{d}_{R}\right)$ is a differential graded Lie algebra.
Let $R^{\prime}$ be a linear map from $\mathfrak{g}$ to $\mathfrak{g}$. Then $R+R^{\prime}$ is a modified $r$-matrix if and only if

$$
\llbracket R+R^{\prime}, R+R^{\prime} \rrbracket=2 \pi,
$$

that is

$$
0=\llbracket R, R^{\prime} \rrbracket+\frac{1}{2} \llbracket R^{\prime}, R^{\prime} \rrbracket=\mathrm{d}_{R} R^{\prime}+\frac{1}{2} \llbracket R^{\prime}, R^{\prime} \rrbracket .
$$

Thus $R+R^{\prime}$ is still a modified $r$-matrix on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ if and only if $R^{\prime}$ is a MaurerCartan element of the differential graded Lie algebra ( $\left.C^{*}(\mathfrak{g}), \mathbb{[} \cdot, \cdot \mathbb{\|}, \mathrm{d}_{R}\right)$.

At the end of this section, we establish the relationship between the coboundary operator $\mathrm{d}_{\mathrm{CE}}^{R}$ and the differential $\mathrm{d}_{R}$.

Proposition 3.4. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Then we have

$$
\mathrm{d}_{\mathrm{CE}}^{R}(f)=(-1)^{n-1} \llbracket R, f \rrbracket, \quad \forall f \in \operatorname{Hom}\left(\wedge^{n-1} \mathfrak{g}, \mathfrak{g}\right) .
$$

Proof. For any $f \in \operatorname{Hom}\left(\wedge^{n-1} \mathfrak{g}, \mathfrak{g}\right)$ and $x_{i}, 1 \leq i \leq n$, by (7), we have

$$
\begin{aligned}
& (-1)^{n-1} \llbracket R, f \rrbracket\left(x_{1}, \cdots, x_{n}\right) \\
= & (-1)^{n-1}\left(\sum_{\sigma \in S(n-1,1)}(-1)^{\sigma} R\left(\left[f\left(x_{\sigma(1)}, \cdots, x_{\sigma(n-1)}\right), x_{\sigma(n)}\right]_{\mathfrak{g}}\right)\right. \\
& -(-1)^{n-1} \sum_{\sigma \in S(1,1, n-2)}(-1)^{\sigma} f\left(\left[R\left(x_{\sigma(1)}\right), x_{\sigma(2)}\right]_{\mathfrak{g}}, x_{\sigma(3)}, \cdots, x_{\sigma(n)}\right) \\
& \left.+(-1)^{n-1} \sum_{\sigma \in S(1, n-1)}(-1)^{\sigma}\left[R\left(x_{\sigma(1)}\right), f\left(x_{\sigma(2)}, \cdots, x_{\sigma(n)}\right)\right]_{\mathfrak{g}}\right) \\
= & \sum_{i=1}^{n}(-1)^{i+1} R\left(\left[f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{n}\right), x_{i}\right]_{\mathfrak{g}}\right) \\
& +\sum_{i<j}(-1)^{i+j}\left(f\left(\left[R\left(x_{i}\right), x_{j}\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{n}\right)\right. \\
& \left.-f\left(\left[R\left(x_{j}\right), x_{i}\right]_{\mathfrak{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{n}\right)\right) \\
& +\sum_{i=1}^{n}(-1)^{i+1}\left[R\left(x_{i}\right), f\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{n}\right)\right]_{\mathfrak{g}} \\
= & \mathrm{d}_{\mathrm{CE}}^{R}(f)\left(x_{1}, \cdots, x_{n}\right) .
\end{aligned}
$$

We finish the proof.

## 4. Geometric deformations of modified $r$-matrices

In this section, we study geometric deformations of modified $r$-matrices following the approach developed by Crainic, Schatz and Struchiner. We show that the condition $H^{2}(R)=0$ will imply certain rigidity theorem, and the condition $H^{3}(R)=0$ will imply the space of modified $r$-matrices on the Lie algebra $\mathfrak{g}$ is a manifold in a neighborhood of $R$. We also give the necessary and sufficient condition on a 2-cocycle giving a geometric deformation using the Kuranishi map.

Definition 4.1. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. A geometric deformation of $R$ is a smooth one parameter family of modified $r$-matrices $R_{t}$ on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ such that $R_{0}=R$.
Definition 4.2. Two geometric deformations $R_{t}$ and $R_{t}^{\prime}$ of $R$ are called equivalent if there exists a smooth family of modified $r$-matrices isomorphism $\varphi_{t}: R_{t} \rightarrow R_{t}^{\prime}$ such that $\varphi_{0}=\mathrm{Id}$, where $\varphi_{t}$ are inner automorphisms of the Lie algebra $\mathfrak{g}$.

Let $R_{t}$ be a geometric deformation of $R$. Denote $\left.\frac{d}{d t}\right|_{t=0} R_{t}$ by $\dot{R_{0}}$. Then there is the following proposition.
Proposition 4.3. With the above notations, $\dot{R}_{0}$ is a 2-cocycle in $C^{2}(R)$. Moreover if $R_{t}$ and $R_{t}^{\prime}$ are equivalent geometric deformations of $R$, then $\left[\dot{R}_{0}\right]=\left[\dot{R}_{0}^{\prime}\right]$ in $H^{2}(R)$.
Proof. Since $R_{t}$ is a geometric deformation of $R$, for any $x, y \in \mathfrak{g}$, we have

$$
\begin{equation*}
\left[R(x), \dot{R}_{0}(y)\right]_{\mathfrak{g}}+\left[\dot{R}_{0}(x), R(y)\right]_{\mathfrak{g}} \tag{9}
\end{equation*}
$$

$$
\begin{aligned}
& =\left.\frac{d}{d t}\right|_{t=0}\left[R_{t}(x), R_{t}(y)\right]_{\mathfrak{g}} \\
& =\left.\frac{d}{d t}\right|_{t=0}\left(R_{t}\left(\left[R_{t}(x), y\right]_{\mathfrak{g}}+\left[x, R_{t}(y)\right]_{\mathfrak{g}}\right)-[x, y]_{\mathfrak{g}}\right) \\
& =\dot{R}_{0}\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right)+R\left(\left[\dot{R}_{0}(x), y\right]_{\mathfrak{g}}+\left[x, \dot{R}_{0}(y)\right]_{\mathfrak{g}}\right) .
\end{aligned}
$$

Thus by (6) and (9), we have $\mathrm{d}_{\mathrm{CE}}^{R}\left(\dot{R}_{0}\right)=0$.
Assume that $\varphi_{t}$ is an isomorphism from $R_{t}$ to $R_{t}^{\prime}$, that is

$$
\varphi_{t}\left(R_{t}(x)\right)=R_{t}^{\prime}\left(\varphi_{t}(x)\right), \quad \forall x \in \mathfrak{g}
$$

Denote $\left.\frac{d}{d t}\right|_{t=0} \varphi_{t}$ by $\dot{\varphi}_{0}$. Then we have $\dot{\varphi}_{0}(R(x))+\dot{R}_{0}(x)=R\left(\dot{\varphi}_{0}(x)\right)+\dot{R}_{0}^{\prime}(x)$. Since $\varphi_{t}$ are inner automorphisms of the Lie algebra $\mathfrak{g}$, it follows that $\dot{\varphi}_{0}$ is an inner derivation of the Lie algebra $\mathfrak{g}$. Thus there exists $y \in \mathfrak{g}$ such that $\dot{\varphi}_{0}=\operatorname{ad}_{y}$. Therefore, we have

$$
[y, R(x)]_{\mathfrak{g}}+\dot{R}_{0}(x)=R\left([y, x]_{\mathfrak{g}}\right)+\dot{R_{0}^{\prime}}(x)
$$

which implies $\dot{R}_{0}-\dot{R}_{0}^{\prime}=\mathrm{d}_{\mathrm{CE}}^{R}(y)$. Thus $\left[\dot{R}_{0}\right]=\left[\dot{R_{0}^{\prime}}\right]$ in $H^{2}(R)$.
Next, we consider under which conditions does a cocycle $f \in Z^{2}(R)$ determine a geometric deformation $R_{t}$. Define the Kuranishi map $K: Z^{2}(R) \rightarrow H^{3}(R)$ by

$$
K(f)=[\llbracket f, f \rrbracket], \quad \forall f \in Z^{2}(R) .
$$

Now we give a necessary condition of the above question. The sufficient condition need some preparations and will be given at the end of this section.

Proposition 4.4. Assume that there exists a geometric deformation $R_{t}$ of $R$ on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ such that $\dot{R}_{0}=f \in Z^{2}(R)$, then $K(f)=0$.
Proof. Consider the Taylor expansion of $R_{t}$ around $t=0$, then we have

$$
R_{t}(x)=R(x)+t f(x)+\frac{t^{2}}{2} g(x)+o\left(t^{3}\right)
$$

Since $\left[R_{t}(x), R_{t}(y)\right]_{\mathfrak{g}}=R_{t}\left(\left[R_{t}(x), y\right]_{\mathfrak{g}}+\left[x, R_{t}(y)\right]_{\mathfrak{g}}\right)-[x, y]_{\mathfrak{g}}$ and $f \in Z^{2}(R)$, we have

$$
\begin{equation*}
\frac{t^{2}}{2}\left(\mathrm{~d}_{\mathrm{CE}}^{R}(g)(x, y)+2[f(x), f(y)]_{\mathfrak{g}}-2 f\left([f(x), y]_{\mathfrak{g}}+[x, f(y)]_{\mathfrak{g}}\right)\right)+o\left(t^{3}\right)=0 . \tag{10}
\end{equation*}
$$

Thus by (7) and (10), we obtain $\llbracket f, f \rrbracket=\mathrm{d}_{\mathrm{CE}}^{R} g$, which implies that $K(f)=0$.
Let $E \xrightarrow{\pi} M$ be a vector bundle. Assume that there is a smooth action $\cdot: G \times E \rightarrow E$ of a Lie group $G$ on $E$ preserving the zero-section $Z: M \rightarrow E$. It follows that $M$ inherits a $G$-action. We also denote the action of $G$ on $M$ by $\cdot: G \times M \rightarrow M$. For all $x \in M$, define a smooth map $\mu_{x}: G \rightarrow M$ by $\mu_{x}(g)=g \cdot x$. Denote the tangent map from $\mathfrak{g}$ to $T_{x} M$ by $D\left(\mu_{x}\right)_{e_{G}}$, where $e_{G}$ is the unit of $G$.
Definition 4.5. ([5]) A section $s: M \rightarrow E$ is called equivariant if $s$ satisfies

$$
s(g \cdot x)=g \cdot s(x), \quad \forall g \in G, x \in M .
$$

Denote the zero set of a section $s: M \rightarrow E$ by $z(s)=\{x \in M \mid s(x)=0\}$. A zero $x \in M$ of $s$ is called non-degenerate if the sequence

$$
\mathfrak{g} \xrightarrow{D\left(\mu_{x}\right)_{G}} T_{x} M \xrightarrow{D^{\nu}(s)_{x}} E_{x}
$$

is exact, where $D^{v}(s)_{x}$ is the vertical derivative of $s$ at $x$.

Proposition 4.6. ([6]) Let $s$ be an equivariant section of the vector bundle $E \xrightarrow{\pi} M$ and $x$ be a non-degenerate zero of $s$. Then there is an open neighborhood $U$ of $x$ and a smooth map $p: U \rightarrow G$ such that for all $m \in U$ with $s(m)=0$, one has $p(m) \cdot x=m$. In particular, the orbit of $x$ under the action of $G$ and the zero set of $s$ coincide in an open neighborhood of $x$.

Proposition 4.7. ([5]) Let $E$ and $F$ be vector bundles over a smooth manifold $M$. Let $s \in \Gamma(E)$ be a section and $\phi \in \Gamma(\operatorname{Hom}(E, F))$ be a vector bundle map such that $\phi \circ s=0$. Suppose that $x \in M$ is $s(x)=0$ such that

$$
T_{x} M \xrightarrow{D^{\nu}(s)_{x}} E_{x} \xrightarrow{\phi_{x}} F_{x}
$$

is exact. Then $s^{-1}(0)$ is locally a manifold around $x$ of dimension dim $\operatorname{ker}\left(D^{v}(s)_{x}\right)$.
Denote the group whose elements are inner automorphisms of a Lie algebra $\mathfrak{g}$ by $\operatorname{InnAut}(\mathfrak{g})$. Then its Lie algebra is the Lie algebra of inner derivations of $\mathfrak{g}$ and denote it by $\operatorname{InnDer}(\mathfrak{g})$. Define an action of $\operatorname{InnAut}(\mathfrak{g})$ on $\operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ by

$$
\cdot: \operatorname{InnAut}(\mathfrak{g}) \times \operatorname{Hom}(\mathfrak{g}, \mathfrak{g}) \rightarrow \operatorname{Hom}(\mathfrak{g}, \mathfrak{g}), \quad A \cdot f=A f A^{-1}
$$

for all $A \in \operatorname{InnAut}(\mathfrak{g}), f \in \operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$. Assume that $R$ is a modified $r$-matrix on a Lie algebra $\mathfrak{g}$, then the orbit $\operatorname{Orb}_{R}=\{A \cdot R \mid A \in \operatorname{InnAut}(\mathfrak{g})\}$ of $R$ is a manifold. Define a map $\mu_{R}: \operatorname{InnAut}(\mathfrak{g}) \rightarrow$ $\operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ by $\mu_{R}(A)=A \cdot R$. Then $T_{R} \operatorname{Orb}_{R}$ is $D\left(\mu_{R}\right)_{e_{G}}(\operatorname{InnDer}(\mathfrak{g}))$, where $D\left(\mu_{R}\right)_{e_{G}}$ is the tangent map of $\mu_{R}$ at $e_{G}$.

Proposition 4.8. With the above notations, $T_{R} \operatorname{Orb}_{R}$ is $B^{2}(R)$.
Proof. Since $T_{R} \operatorname{Orb}_{R}=D\left(\mu_{R}\right)_{e_{G}}(\operatorname{InnDer}(\mathfrak{g}))$, for any $v \in T_{R} \operatorname{Orb}_{R}$, there exists $x \in \mathfrak{g}$ such that

$$
\begin{aligned}
v & =\left.\frac{d}{d t}\right|_{t=0} \exp \left(t \mathrm{ad}_{x}\right) \cdot R \\
& =\left.\frac{d}{d t}\right|_{t=0}\left(\exp \left(t \operatorname{tad}_{x}\right) R \exp \left(-t \mathrm{ad}_{x}\right)\right) \\
& =\mathrm{ad}_{x} R-\operatorname{Rad}_{x} \\
& =-\mathrm{d}_{\mathrm{CE}}^{R} x .
\end{aligned}
$$

Thus we have $T_{R} \operatorname{Orb}_{R}=B^{2}(R)$.
Theorem 4.9. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. If $H^{2}(R)=0$, then there exists an open neighborhood $U \subset \operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ of $R$ and a smooth map $p: U \rightarrow \operatorname{InnAut}(\mathfrak{g})$ such that $p\left(R^{\prime}\right) \cdot R=R^{\prime}$ for every modified $r$-matrix $R^{\prime} \in U$.
Proof. Denote by $M=\operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ and $E=\operatorname{Hom}(\mathfrak{g}, \mathfrak{g}) \times \operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right)$. Then $E$ is a trivial vector bundle over $M$ with fiber $\operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right)$. Define an action of $\operatorname{InnAut}(\mathfrak{g})$ on the manifold $E$ by

$$
\cdot: \operatorname{InnAut}(\mathfrak{g}) \times E \rightarrow E, \quad A \cdot(f, \alpha)=\left(A f A^{-1}, A \alpha \circ A^{-1}\right),
$$

for $(f, \alpha) \in E, A \in \operatorname{InnAut}(\mathfrak{g})$, where $A \alpha \circ A^{-1}(x, y)=A \alpha\left(A^{-1} x, A^{-1} y\right)$ for any $x, y \in \mathfrak{g}$. Define a section $s: M \rightarrow E$ by

$$
s(f)=(f, S(f)), \quad \forall f \in M
$$

where $S: \operatorname{Hom}(\mathfrak{g}, \mathfrak{g}) \rightarrow \operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right)$ is given by

$$
S(f)(x, y)=[f(x), f(y)]_{\mathfrak{g}}-f\left([f(x), y]_{\mathfrak{g}}+[x, f(y)]_{\mathfrak{g}}\right)+[x, y]_{\mathfrak{g}},
$$

for all $f \in \operatorname{Hom}(\mathfrak{g}, \mathfrak{g}), x, y \in \mathfrak{g}$. Then for any $A \in \operatorname{InnAut}(\mathfrak{g}), f \in M$ and $x, y \in \mathfrak{g}$, we have

$$
A S(f) \circ A^{-1}(x, y)
$$

$$
\begin{aligned}
& =A\left(\left[f\left(A^{-1} x\right), f\left(A^{-1} y\right)\right]_{\mathfrak{g}}-f\left(\left[f\left(A^{-1} x\right), A^{-1} y\right]_{\mathfrak{g}}+\left[A^{-1} x, f\left(A^{-1} y\right)\right]_{\mathfrak{g}}\right)+\left[A^{-1} x, A^{-1} y\right]_{\mathfrak{g}}\right) \\
& =\left[A f\left(A^{-1} x\right), A f\left(A^{-1} y\right)\right]_{\mathfrak{g}}-A f A^{-1}\left(\left[A f\left(A^{-1} x\right), y\right]_{\mathfrak{g}}+\left[x, A f\left(A^{-1} y\right)\right]_{\mathfrak{g}}\right)+[x, y]_{\mathfrak{g}} \\
& =S\left(A f A^{-1}\right)(x, y) .
\end{aligned}
$$

Thus we have

$$
A \cdot s(f)=\left(A f A^{-1}, A S(f) \circ A^{-1}\right)=s(A \cdot f)
$$

which implies that $s$ is an equivariant section.
Since $R$ is a modified $r$-matrix on the Lie algebra $\mathfrak{g}$, it follows that $R \in z(s)$. Moreover, since $E$ is a trivial vector bundle, we have $D^{v}(s)_{R}=D(S)_{R}: T_{R} M \rightarrow E_{R}$. For any $g \in \operatorname{Hom}(\mathfrak{g}, \mathfrak{g}), x, y \in \mathfrak{g}$,

$$
\begin{align*}
& D(S)_{R}(g)(x, y)  \tag{11}\\
= & \left.\frac{d}{d t}\right|_{t=0} S(R+\operatorname{tg})(x, y) \\
= & \left.\frac{d}{d t}\right|_{t=0}\left([R(x)+\operatorname{tg}(x), R(y)+\operatorname{tg}(y)]_{\mathfrak{g}}\right. \\
& \left.-(R+\operatorname{tg})\left([R(x)+\operatorname{tg}(x), y]_{\mathfrak{g}}+[x, R(y)+\operatorname{tg}(y)]_{\mathfrak{g}}\right)+[x, y]_{\mathfrak{g}}\right) \\
= & {[g(x), R(y)]_{\mathfrak{g}}+[R(x), g(y)]_{\mathfrak{g}}-R\left([g(x), y]_{\mathfrak{g}}+[x, g(y)]_{\mathfrak{g}}\right)-g\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right) } \\
= & \mathrm{d}_{\mathrm{CE}}^{R}(g)(x, y) .
\end{align*}
$$

By Proposition 4.8 and $H^{2}(R)=0$, we have that $R$ is a non-degenerate zero of $s$. By Proposition 4.6, there exists an open neighborhood $U \subset \operatorname{Hom}(\mathfrak{g}, \mathfrak{g})$ of $R$ and a smooth map $p: U \rightarrow$ InnAut $(\mathfrak{g})$ such that $p(R) \cdot R=R^{\prime}$ for every modified $r$-matrix $R^{\prime} \in U$.

Theorem 4.10. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. If $H^{3}(R)=0$, then the space of modified matrices on the Lie algebra $\mathfrak{g}$ is a manifold in a neighborhood of $R$, whose dimension is $\operatorname{dim} Z^{2}(R)$.

Proof. Denote by $M=\operatorname{Hom}(\mathfrak{g}, \mathfrak{g}), E=\operatorname{Hom}(\mathfrak{g}, \mathfrak{g}) \times \operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right)$ and $F=\operatorname{Hom}(\mathfrak{g}, \mathfrak{g}) \times \operatorname{Hom}\left(\wedge^{3} \mathfrak{g}, \mathfrak{g}\right)$. Then $E$ and $F$ are trivial vector bundles over $M$ with fiber $\operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right)$ and $\operatorname{Hom}\left(\wedge^{3} \mathfrak{g}, \mathfrak{g}\right)$ respectively. Define a smooth map $\phi: E \rightarrow F$ by

$$
\phi(f, \alpha)=(f, \llbracket f, \alpha \rrbracket), \quad \forall f \in M, \alpha \in \operatorname{Hom}\left(\wedge^{2} \mathfrak{g}, \mathfrak{g}\right) .
$$

Thus $\phi$ is a vector bundle map.
Moreover, denote the Lie bracket $[\cdot, \cdot]_{\mathrm{g}}$ by $\pi$, define $s(f)=\pi-\frac{1}{2} \llbracket f, f \rrbracket$. By Proposition 3.2, we know that $\pi$ lies in the center, we have $\phi \circ s(f)=\left(f, \llbracket f, \pi \rrbracket-\frac{1}{2} \llbracket f, \llbracket f, f \rrbracket \rrbracket\right)=(f, 0)$, which implies $\phi \circ s=0$. Moreover, denote $\phi_{R}: E_{R} \rightarrow F_{R}$ by $\phi(R, \cdot)$, then $\phi_{R}=\mathrm{d}_{\mathrm{CE}}^{R}$. By (11) and $H^{3}(R)=0$, we have that

$$
T_{R} M \xrightarrow{D^{\nu}\left(s_{R}\right.} E_{R} \xrightarrow{\phi_{R}} F_{R}
$$

is exact. By Proposition 4.7, we obtain that the space of modified $r$-matrices on the Lie algebra $\mathfrak{g}$ is a manifold in a neighborhood of $R$, whose dimension is $\operatorname{dim} Z^{2}(R)$.

At the end of this section, we give the sufficient condition on a 2-cocycle to give a geometric deformation. Recall that the necessary condition is given in Proposition 4.4 using the Kuranishi map.

Corollary 4.11. With the above notations, if $H^{3}(R)=0$, then any $f \in Z^{2}(R)$ gives rise to a geometric deformation of $R$.

Proof. Since $R$ is a modified $r$-matrix and $H^{3}(R)=0$, we have that the space $W$ of modified $r$ matrices on the Lie algebra $\mathfrak{g}$ is a manifold in a neighborhood of $R$, whose dimension is $\operatorname{dim} Z^{2}(R)$. Assume $\gamma(t) \in W$, by Proposition 4.3, we have $\dot{\gamma}(0) \in Z^{2}(R)$. Moreover, $\operatorname{dim} W=\operatorname{dim} Z^{2}(R)$, then $T_{R} W=Z^{2}(R)$. Thus any $f \in Z^{2}(R)$ gives rise to a geometric deformation of $R$.

## 5. Linear deformations of modified $r$-matrices

In this section, we study linear deformations of a modified $r$-matrix using the established cohomology theory. In particular, a trivial linear deformation leads to a Nijenhuis element for a modified $r$-matrix $R$.

Definition 5.1. Let $R$ be a modified $r$-matrix on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ and $\hat{R}: \mathfrak{g} \rightarrow \mathfrak{g}$ be a linear map. If there exists a positive number $\epsilon \in \mathbb{R}$ such that $R_{t}=R+t \hat{R}$ is still a modified $r$-matrix on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ for all $t \in(-\epsilon, \epsilon)$, we say that $\hat{R}$ generates a linear deformation of the modified $r$-matrix $R$.
Definition 5.2. Let $R: \mathfrak{g} \rightarrow \mathfrak{g}$ be a modified $r$-matrix on $\mathfrak{g}$. Two linear deformations $R_{t}^{1}=R+t \hat{R}_{1}$ and $R_{t}^{2}=R+t \hat{R}_{2}$ are said to be equivalent if there exists an $x \in \mathfrak{g}$ such that

$$
\varphi_{t}=\mathrm{Id}_{\mathfrak{g}}+t \mathrm{ad}_{x}
$$

satisfies the following conditions:
(i) $\varphi_{t}\left([y, z]_{\mathfrak{g}}\right)=\left[\varphi_{t}(y), \varphi_{t}(z)\right]_{\mathfrak{g}}, \quad \forall y, z \in \mathfrak{g}$,
(ii) $R_{t}^{2} \circ \varphi_{t}=\varphi_{t} \circ R_{t}^{1}$.

Theorem 5.3. Let $\hat{R}: \mathfrak{g} \rightarrow \mathfrak{g}$ generate a linear deformation of the modified $r$-matrix $R$. Then $\hat{R}$ is a 2-cocycle.

Let $R_{t}^{1}$ and $R_{t}^{2}$ be equivalent linear deformations of $R$ generated by $\hat{R_{1}}$ and $\hat{R_{2}}$ respectively. Then $\left[\hat{R_{1}}\right]=\left[\hat{R_{2}}\right]$ in $H^{2}(R)$.

Proof. Since $R_{t}=R+t \hat{R}$ is a modified $r$-matrix on the Lie algebra ( $\mathfrak{g},[\cdot, \cdot \cdot]_{\mathfrak{g}}$ ), we have

$$
\left[R_{t}(x), R_{t}(y)\right]_{\mathfrak{g}}=R_{t}\left(\left[R_{t}(x), y\right]_{\mathfrak{g}}+\left[x, R_{t}(y)\right]_{\mathfrak{g}}\right)-[x, y]_{\mathfrak{g}}, \quad \forall x, y \in \mathfrak{g} .
$$

Consider the coefficients of $t$ and $t^{2}$ respectively, we have

$$
\begin{align*}
& {[\hat{R}(x), R(y)]_{\mathfrak{g}}+[R(x), \hat{R}(y)]_{\mathfrak{g}} }  \tag{12}\\
= & R\left([\hat{R}(x), y]_{\mathfrak{g}}+[x, \hat{R}(y)]_{\mathfrak{g}}\right)+\hat{R}\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right), \quad \forall x, y \in \mathfrak{g},
\end{align*}
$$

and

$$
\begin{equation*}
[\hat{R}(x), \hat{R}(y)]_{\mathfrak{g}}=\hat{R}\left([\hat{R}(x), y]_{\mathfrak{g}}+[x, \hat{R}(y)]_{\mathfrak{g}}\right) . \tag{13}
\end{equation*}
$$

By (12), we deduce that $\hat{R}$ is a 2-cocycle of the modified $r$-matrix $R$.
If $R_{t}^{1}$ and $R_{t}^{2}$ are equivalent linear deformations of $R$, then there exists $x \in \mathfrak{g}$ such that

$$
\left(\mathrm{Id}_{\mathfrak{g}}+t \mathrm{ad}_{x}\right)\left(R+t \hat{R}_{1}\right)(u)=\left(R+t \hat{R}_{2}\right)\left(\mathrm{Id}_{\mathfrak{g}}+t \mathrm{ad}_{x}\right)(u), \quad \forall u \in \mathfrak{g},
$$

which implies

$$
\begin{equation*}
\hat{R}_{1}(u)-\hat{R}_{2}(u)=[R(u), x]_{\mathfrak{g}}-R\left([u, x]_{\mathfrak{g}}\right), \quad \forall u \in \mathfrak{g} . \tag{14}
\end{equation*}
$$

By (14), we have

$$
\hat{R_{1}}-\hat{R_{2}}=\mathrm{d}_{\mathrm{CE}}^{R} x,
$$

where $\mathrm{d}_{\mathrm{CE}}^{R}$ is given by (母). Thus $\left[\hat{R_{1}}\right]=\left[\hat{R_{2}}\right]$ in $H^{2}(R)$.

Definition 5.4. A linear deformation of a modified $r$-matrix $R$ generated by $\hat{R}$ is trivial if there exists an $x \in \mathfrak{g}$ such that $\mathrm{Id}+t \mathrm{ad}_{x}$ is an isomorphism from $R_{t}=R+t \hat{R}$ to $R$.

Definition 5.5. Let $R$ be a modified $r$-matrix on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. An element $x \in \mathfrak{g}$ is called $a$ Nijenhuis element associated to $R$ if $x$ satisfies

$$
\begin{align*}
{\left[[x, y]_{\mathfrak{g}},[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}} } & =0  \tag{15}\\
{\left[x,[x, R(y)]_{\mathfrak{g}}\right]_{\mathfrak{g}} } & =\left[x, R\left([x, y]_{\mathfrak{g}}\right)\right]_{g} \tag{16}
\end{align*}
$$

for all $y, z \in \mathfrak{g}$.
Let $\hat{R}$ generate a trivial linear deformation of a modified $r$-matrix $R$ on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Then there exists $x \in \mathfrak{g}$ such that

$$
\begin{aligned}
\left(\operatorname{Id}+t \operatorname{tad}_{x}\right)[y, z]_{\mathfrak{g}} & =\left[y+t[x, y]_{\mathfrak{g}}, z+t[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}, \\
R\left(y+t[x, y]_{\mathfrak{g}}\right) & =\left(\operatorname{Id}+t \operatorname{ad}_{x}\right)(R(y)+t \hat{R}(y)),
\end{aligned}
$$

for all $y, z \in \mathfrak{g}$. Therefore, we have

$$
\left[[x, y]_{\mathfrak{g}},[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}=0, \quad[x, \hat{R}(y)]_{\mathfrak{g}}=0, \quad R\left([x, y]_{\mathfrak{g}}\right)=[x, R(y)]_{\mathfrak{g}}+\hat{R}(y) .
$$

Thus a trivial linear deformation gives rise to a Nijenhuis element.
Theorem 5.6. Let $R$ be a modified $r$-matrix on a Lie algebra $\mathfrak{g}$. Then for any Nijenhuis element $x \in \mathfrak{g}, R_{t}=R+t \mathrm{~d}_{\mathrm{CE}}^{R} x$ is a trivial linear deformation of the modified $r$-matrix $R$.
Proof. Denote by $\hat{R}=\mathrm{d}_{\mathrm{CE}}^{R} x$. To show that $R_{t}$ is a linear deformation of $R$, it suffices to show that (12) and (13) hold. Note that (12) means that $\hat{R}$ is closed, which holds naturally since now $\hat{R}=\mathrm{d}_{\mathrm{C} E}^{R} x$ is exact. Thus, we need to verify that Equation (13) holds. For any $y, z \in \mathfrak{g}$, by (\#), we obtain $\hat{R}(y)=[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right)$. Moreover, by (11), (15) and (16), it follows that

$$
\begin{aligned}
& {\left[R\left([y, x]_{\mathfrak{g}}\right), R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}}
\end{aligned}
$$

$$

By (15) and above equations, we have

= & {\left[[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right),[R(z), x]_{\mathfrak{g}}-R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}} } \\
& -\left[R\left(\left[[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right), z\right]\right), x\right]_{\mathfrak{g}}+R\left(\left[\left[[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}, x\right]_{\mathfrak{g}}\right) \\

= & -\left[[R(y), x]_{\mathfrak{g}}, R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}+\left[R\left([y, x]_{\mathfrak{g}}\right), R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}-\left[R\left([y, x]_{\mathfrak{g}}\right),[R(z), x]_{\mathfrak{g}}\right]_{\mathfrak{g}} \\
& -\left[R\left(\left[[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right), z\right]\right), x\right]_{\mathfrak{g}}+R\left(\left[\left[[R(y), x]_{\mathfrak{g}}-R\left([y, x]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}, x\right]_{\mathfrak{g}}\right) \\
& -\left[R\left(\left[y,[R(z), x]_{\mathfrak{g}}-R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right), x\right]_{\mathfrak{g}}+R\left(\left[\left[y,[R(z), x]_{\mathfrak{g}}-R\left([z, x]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}, x\right]_{\mathfrak{g}}\right) \\

Thus $R_{t}=R+t \mathrm{~d}_{\mathrm{CE}}^{R} x$ is a linear deformation of the modified $r$-matrix $R$. Since $x \in \mathfrak{g}$ is a Nijenhuis element, we have $\left(\operatorname{Id}+\operatorname{tad}_{x}\right)[y, z]_{\mathfrak{g}}=\left[y+t[x, y]_{\mathfrak{g}}, z+t[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}$ and $R \circ\left(\operatorname{Id}+t \mathrm{ad}_{x}\right)=$ $\left(\mathrm{Id}+t \mathrm{ad}_{x}\right) \circ\left(R+t \mathrm{~d}_{\mathrm{CE}}^{R} x\right)$. Thus for any Nijenhuis element $x \in \mathfrak{g}, R_{t}=R+t \mathrm{~d}_{\mathrm{CE}}^{R} x$ is a trivial linear deformation of the modified $r$-matrix $R$.

At the end of this section, we consider the relation between linear deformations of modified $r$-matrices and linear deformations of the induced Lie algebras. Recall that a skew-symmetric bilinear map $\omega: \wedge^{2} \mathfrak{g} \rightarrow \mathfrak{g}$ generates a linear deformation of a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ if $[\cdot, \cdot]_{t}=$ $[\cdot, \cdot]_{\mathfrak{g}}+t \omega$ defines a Lie algebra structure on $\mathfrak{g}$ for all $t \in(-\epsilon, \epsilon)$.
Proposition 5.7. Let $\hat{R}$ generate a linear deformation of a modified $r$-matrix $R$ on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$. Then $\omega$ defined by

$$
\omega(x, y)=[\hat{R}(x), y]_{\mathfrak{g}}+[x, \hat{R}(y)]_{\mathfrak{g}}, \quad \forall x, y \in \mathfrak{g},
$$

generates a linear deformation of the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ given by the modified $r$-matrix $R$, which is exactly the one associated to the linear deformation of the modified $r$-matrix $R$.

Proof. It is obvious that

$$
[x, y]_{R_{t}}=[R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}+t\left([\hat{R}(x), y]_{\mathfrak{g}}+[x, \hat{R}(y)]_{\mathfrak{g}}\right)=[x, y]_{R}+t \omega(x, y) .
$$

Since $[\cdot, \cdot]_{R_{t}}$ are Lie algebra structures, we have that $\omega$ generates a linear deformation of the Lie algebra ( $\mathfrak{g},[\cdot, \cdot \cdot]_{R}$ ) given by the modified $r$-matrix $R$.

The notion of a Nijenhuis operator on a Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ was given in [ 7$]$, which gives rise to a trivial linear deformation of the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$.
Definition 5.8. ([7]) Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra. A linear map $N: \mathfrak{g} \rightarrow \mathfrak{g}$ is called Nijenhuis operator if

$$
[N(x), N(y)]_{\mathfrak{g}}=N\left([N(x), y]_{\mathfrak{g}}+[x, N(y)]_{\mathfrak{g}}\right)-N^{2}\left([x, y]_{\mathfrak{g}}\right), \quad \forall x, y \in \mathfrak{g} .
$$

Theorem 5.9. Let $x \in \mathfrak{g}$ be a Nijenhuis element associated to a modified matrix $R$. Then $\operatorname{ad}_{x}$ is a Nijenhuis operator on the Lie algebra ( $\mathfrak{g},[\cdot, \cdot]_{R}$ ).

Proof. For any $x, y, z \in \mathfrak{g}$, by (15) and (16), we have

$$
\begin{aligned}
& {\left[\operatorname{ad}_{x} y, \mathrm{ad}_{x} z\right]_{R} } \\
= & {\left[R\left([x, y]_{\mathfrak{g}}\right),[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[[x, y]_{\mathfrak{g}}, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}} } \\
= & {\left[\left[R\left([x, y]_{\mathfrak{g}}\right), x\right]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}+\left[x,\left[R\left([x, y]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[\left[x, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}, y\right]_{\mathfrak{g}}+\left[x,\left[y, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right]_{\mathfrak{g}} } \\
= & -\left[\left[x,[x, R(y)]_{\mathfrak{g}}\right]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}+\left[x,\left[R\left([x, y]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[\left[x,[x, R(z)]_{\mathfrak{g}}\right]_{\mathfrak{g}}, y\right]_{\mathfrak{g}}+\left[x,\left[y, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right]_{\mathfrak{g}} \\
= & -\left[x,\left[[x, R(y)]_{\mathfrak{g}}, z\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[x,\left[R\left([x, y]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[x,\left[[x, R(z)]_{\mathfrak{g}}, y\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[x,\left[y, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}
\end{aligned}
$$

and

$$
\begin{aligned}
& \operatorname{ad}_{x}\left(\left[\operatorname{ad}_{x} y, z\right]_{R}+\left[y, \operatorname{ad}_{x} z\right]_{R}\right)-\operatorname{ad}_{x}^{2}\left([y, z]_{R}\right) \\
= & {\left[x,\left[R\left([x, y]_{\mathfrak{g}}\right), z\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}+\left[[x, y]_{\mathfrak{g}}, R(z)\right]_{\mathfrak{g}}+\left[x,\left[R(y),[x, z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right]_{\mathfrak{g}} } \\
& {\left[x,\left[y, R\left([x, z]_{\mathfrak{g}}\right)\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}-\left[x,\left[x,[R(y), z]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right]_{\mathfrak{g}}-\left[x,\left[x,[y, R(z)]_{\mathfrak{g}}\right]_{\mathfrak{g}}\right]_{\mathfrak{g}} . }
\end{aligned}
$$

Thus $\left[\operatorname{ad}_{x} y, \operatorname{ad}_{x} z\right]_{R}=\operatorname{ad}_{x}\left(\left[\operatorname{ad}_{x} y, z\right]_{R}+\left[y, \operatorname{ad}_{x} z\right]_{R}\right)-\operatorname{ad}_{x}^{2}\left([y, z]_{R}\right)$, which implies that ad ${ }_{x}$ is a Nijenhuis operator on the Lie algebra $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$.

## 6. Applications

In this section, we give some applications of the above deformation theories, including deformations of complement of the diagonal Lie algebra $\mathfrak{g}_{\Delta}$ and compatible Poisson structures.
6.1. Deformations of complements. Let $\left(\mathfrak{g},[\cdot, \cdot]_{\mathfrak{g}}\right)$ be a Lie algebra, then we have a directproduct Lie algebra structure $[\cdot, \cdot]_{\oplus}$ on $\mathfrak{g} \oplus \mathfrak{g}$, where

$$
\left[\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right)\right]_{\oplus}=\left(\left[x_{1}, x_{2}\right]_{\mathfrak{g}},\left[y_{1}, y_{2}\right]_{\mathfrak{g}}\right), \quad \forall x_{i}, y_{i} \in \mathfrak{g}, i=1,2 .
$$

Define the subspace $\mathfrak{g}_{\Delta}$ by $\mathfrak{g}_{\Delta}=\{(x, x) \mid \forall x \in \mathfrak{g}\}$ and the subspace $\mathfrak{g}_{-\Delta}=\{(x,-x) \mid \forall x \in \mathfrak{g}\}$. It is obvious that $\mathfrak{g}_{\Delta}$ is a Lie subalgebra of $\mathfrak{g} \oplus \mathfrak{g}$, while $\mathfrak{g}_{-\Delta}$ is not a Lie subalgebra. To find a complement of $g_{\Delta}$ which is also a Lie subalgebra, it is natural to consider the graph of certain linear map from $\mathfrak{g}_{-\Delta}$ to $\mathfrak{g}_{\Delta}$. It is known that a complement of $\mathfrak{g}_{\Delta}$ is isomorphic to a graph of a linear map from $\mathfrak{g}_{-\Delta}$ to $\mathfrak{g}_{\Delta}$. Let $R \in \mathfrak{g l}(\mathfrak{g})$ be a linear map. Define a linear map $\hat{R}: \mathfrak{g}_{-\Delta} \rightarrow \mathfrak{g}_{\Delta}$ by

$$
\hat{R}(x,-x)=(-R(x),-R(x)), \quad \forall x \in \mathfrak{g} .
$$

Proposition 6.1. With the above notations, the $\operatorname{graph} \mathcal{G}(\hat{R}):=\left\{\hat{R} u+u \mid u \in \mathfrak{g}_{-\Delta}\right\}$ is a Lie subalgebra of $\left(\mathfrak{g} \oplus \mathfrak{g},[\cdot, \cdot]_{\oplus}\right)$ if and only if $R$ is a modified $r$-matrix.

Proof. For all $x, y \in \mathfrak{g}$, we have

$$
\begin{aligned}
& {[(-R(x),-R(x))+(x,-x),(-R(y),-R(y))+(y,-y)]_{\oplus} } \\
= & \left([x, y]_{\mathfrak{g}},[x, y]_{\mathfrak{g}}\right)+\left([R(x), R(y)]_{\mathfrak{g}},[R(x), R(y)]_{\mathfrak{g}}\right) \\
& +\left(-[R(x), y]_{\mathfrak{g}},[R(x), y]_{\mathfrak{g}}\right)+\left(-[x, R(y)]_{\mathfrak{g}},[x, R(y)]_{\mathfrak{g}}\right) \\
= & \left([x, y]_{\mathfrak{g}}+[R(x), R(y)]_{\mathfrak{g}},[x, y]_{\mathfrak{g}}+[R(x), R(y)]_{\mathfrak{g}}\right) \\
& +\left(-[R(x), y]_{\mathfrak{g}}-[x, R(y)]_{\mathfrak{g}},[R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right) .
\end{aligned}
$$

Thus $\mathcal{G}(\hat{R})$ is a Lie subalgebra if and only if

$$
R\left([R(x), y]_{\mathfrak{g}}+[x, R(y)]_{\mathfrak{g}}\right)=[x, y]_{\mathfrak{g}}+[R(x), R(y)]_{\mathfrak{g}},
$$

i.e. $R$ is a modified $r$-matrix.

Proposition 6.2. Let $R$ be a modified r-matrix. Then $\left(\mathfrak{g}_{\Delta}, \mathcal{G}(\hat{R})\right)$ is a matched pair of Lie algebras.

Proof. It is obvious that $\mathfrak{g} \oplus \mathfrak{g}=\mathfrak{g}_{\Delta} \oplus \mathcal{G}(\hat{R})$ since $\mathfrak{g}_{\Delta} \bigcap \mathcal{G}(\hat{R})=0$. Then the conclusion follows from the fact that both $g_{\Delta}$ and $\mathcal{G}(\hat{R})$ are Lie subalgebras.

Summarizing the above studies, we have the following conclusion.
Theorem 6.3. Let $R_{t}$ be a geometric deformation of a modified $r$-matrix $R$. Then $\mathcal{G}\left(\hat{R}_{t}\right)$ is a deformation of the complement $\mathcal{G}(\hat{R})$. Moreover, $\left(\mathfrak{g}_{\Delta}, \mathcal{G}\left(\hat{R}_{t}\right)\right)$ are matched pairs of Lie algebras.
6.2. Compatible Poisson structures. A compatible Poisson structure consists of two Poisson structures $\pi, \pi^{\prime}$ on a manifold $M$ such that $\pi+\pi^{\prime}$ is also a Poisson structure on the manifold $M$.

Let $R$ be a modified $r$-matrix on a Lie algebra $\mathfrak{g}$. Then $\left(\mathfrak{g},[\cdot, \cdot]_{R}\right)$ is a Lie algebra and we denote by ( $\mathfrak{g}^{*},\{\cdot, \cdot\}_{R}$ ) the corresponding linear Poisson manifold.
Proposition 6.4. Let $R$ be a modified $r$-matrix on a Lie algebra $\mathfrak{g}$ and $R_{t}=R+t \hat{R}$ be a linear deformation of $R$. For any $t_{1}, t_{2} \in \mathbb{R},\{\cdot, \cdot\}_{R_{t_{1}}}$ and $\{\cdot, \cdot\}_{R_{t_{2}}}$ are compatible Poisson structures on $\mathfrak{g}^{*}$.
Proof. By the fact that $R+\frac{t_{1}+t_{2}}{2} \hat{R}$ is also a modified $r$-matrix on the Lie algebra $\mathfrak{g}$, we have

$$
[x, y]_{R_{t_{1}}}+[x, y]_{R_{t_{2}}}=2\left(\left[R(x)+\frac{t_{1}+t_{2}}{2} \hat{R}(x), y\right]_{\mathfrak{g}}+\left[x, R(y)+\frac{t_{1}+t_{2}}{2} \hat{R}(y)\right]\right)
$$

which implies that $[, \cdot,]_{R_{t_{1}}}+[\cdot, \cdot]_{R_{t_{2}}}$ is also a Lie bracket on the Lie algebra $g$ by (2]). Thus, for any $t_{1}, t_{2} \in \mathbb{R},\{\cdot, \cdot\}_{R_{t_{1}}}$ and $\{\cdot, \cdot\}_{R_{t_{2}}}$ are compatible Poisson structures on $\mathfrak{g}^{*}$.
