# HECKE'S THEOREM ON THE DIFFERENT FOR 3-MANIFOLDS

#### Abstract

Hecke has shown that the different of an extension of number fields is a square in the class group. We prove an analog for branched covers of closed 3-manifolds saying that the branch divisor is a square in the first homology group.


## 1. Introduction

Let $E / F$ be an extension of number fields, let $\mathcal{O}_{E}$ be the ring of integers of $E$, and let $\operatorname{Cl}\left(\mathcal{O}_{E}\right)$ be the class group of $\mathcal{O}_{E}$. One associates to the extension $E / F$ the different $\mathcal{D}_{E / F}$, an ideal in $\mathcal{O}_{E}$, see Ser79, Chapter 3]. Hecke has shown that as an element of $\operatorname{Cl}\left(\mathcal{O}_{E}\right)$, the different $\mathcal{D}_{E / F}$ is a square, namely there exists an ideal class $J \in \mathrm{Cl}\left(\mathcal{O}_{E}\right)$ such that $J^{2}=\mathcal{D}_{E / F}$ in $\mathrm{Cl}\left(\mathcal{O}_{E}\right)$. Hecke's proof uses a reciprocity formula for Gauss sums, see Arm67] and Fro78] for a proof and a discussion of related results.

An analog of Hecke's theorem for finite separable extensions of fields of fractions of Dedekind domains fails in general, see FST62. However, there exists an analog in case $E / F$ is a finite separable extension of function fields of curves over finite fields of odd characteristic, see Arm67. Another geometric analog of Hecke's theorem, based on similarities between the inverse of the different and the canonical bundle on a curve, is the theory of theta characteristics.

In this work we consider an analog of Hecke's theorem for 3-manifolds, as suggested by arithmetic topology. We refer to Mor12 for the analogy between rings of integers and primes on the one hand, and 3 -manifolds and knots on the other hand. The analog of $\operatorname{Spec}\left(\mathcal{O}_{F}\right)$ is a closed (not necessarily oriented) 3-manifold $M$. The map $\operatorname{Spec}\left(\mathcal{O}_{E}\right) \rightarrow \operatorname{Spec}\left(\mathcal{O}_{F}\right)$ is replaced by a cover $\pi: \widetilde{M} \rightarrow M$ branched over a link $L \subset M$, so $\widetilde{M}$ is a closed 3 -manifold and $\pi^{-1}(M \backslash L)$ is a covering space of $M \backslash L$. The inverse image of $L$ under $\pi$ is a $\operatorname{link} \widetilde{L}$ in $\widetilde{M}$.

For a prime ideal $\mathfrak{p}$ of $\mathcal{O}_{E}$ we denote by $e_{\mathfrak{p}}$ its ramification index, namely the largest positive integer $e$ for which $\mathfrak{p}^{e}$ contains $\mathfrak{p} \cap \mathcal{O}_{F}$. We view $\operatorname{Spec}\left(\mathcal{O}_{E}\right) \rightarrow \operatorname{Spec}\left(\mathcal{O}_{F}\right)$ as branched over the primes of $\mathcal{O}_{E}$ that ramify, so $\widetilde{L}$ is our analog for $\mathcal{R}_{E / F}=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{E}\right): e_{\mathfrak{p}}>1\right\}$. The analogy is perhaps closest in case $\operatorname{Spec}\left(\mathcal{O}_{E}\right) \rightarrow \operatorname{Spec}\left(\mathcal{O}_{F}\right)$ is tamely ramified, namely $e_{\mathfrak{p}}$ is coprime to $\left|\mathcal{O}_{E} / \mathfrak{p}\right|$ for every $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{E}\right)$. In this case the different of $E / F$ is given by

$$
\mathcal{D}_{E / F}=\prod_{\mathfrak{p} \in \mathcal{R}_{E / F}} \mathfrak{p}^{\mathfrak{e}_{\mathfrak{p}}-1}
$$

The prime ideals in $\mathcal{R}_{E / F}$ are analogous to the components of the link $\widetilde{L}$. For each component $\widetilde{K}$ of this link, let the ramification index $e_{\widetilde{K}}$ be the number of times the image under $\pi$ of a small loop around $\widetilde{K}$ wraps around $\pi(\widetilde{K})$. An analog of $\operatorname{Cl}\left(\mathcal{O}_{E}\right)$ is $H_{1}(\widetilde{M}, \mathbb{Z})$, and a homology class is a square if and only if its image in

$$
H_{1}(\widetilde{M}, \mathbb{Z}) \otimes_{\mathbb{Z}} \mathbb{Z} / 2 \mathbb{Z} \cong H_{1}(\widetilde{M}, \mathbb{Z} / 2 \mathbb{Z})
$$

vanishes. Our analogy of $\mathcal{D}_{E / F}$, or rather of its class in $\mathrm{Cl}\left(\mathcal{O}_{E}\right) / \mathrm{Cl}\left(\mathcal{O}_{E}\right)^{2}$, is the branch divisor

$$
\mathcal{D}_{\pi}=\sum_{\tilde{K} \text { a component of } \widetilde{L}}\left(e_{\widetilde{K}}-1\right)[\widetilde{K}] \in H_{1}(\widetilde{M}, \mathbb{Z} / 2 \mathbb{Z})
$$

of $\pi$. Since we are working with $\mathbb{Z} / 2 \mathbb{Z}$-coefficients, it is not necessary to fix an orientation of $\widetilde{K}$, nor is the sign of $e_{\widetilde{K}}$ significant.
Theorem 1.1. Let $\widetilde{M}$ and $M$ be closed 3-manifolds, and let $\pi: \widetilde{M} \rightarrow M$ be a cover branched over a link in $M$. Then the branch divisor $\mathcal{D}_{\pi}$ represents the trivial class in $H_{1}(\widetilde{M}, \mathbb{Z} / 2 \mathbb{Z})$.

## 2. A central extension of the hyperoctahedral group

Let $n$ be a positive integer, and let $S_{n}$ be the symmetric group. Recall the hyperoctahedral group

$$
B_{n}=(\mathbb{Z} / 2 \mathbb{Z})^{n} \rtimes S_{n}
$$

where $S_{n}$ acts on $(\mathbb{Z} / 2 \mathbb{Z})^{n}$ by permuting the coordinates.
Let $H_{n}$ be the group consisting of pairs $(a, b) \in(\mathbb{Z} / 2 \mathbb{Z})^{n} \times \mathbb{Z} / 2 \mathbb{Z}$ with group law

$$
\left(a_{1}, b_{1}\right)\left(a_{2}, b_{2}\right)=\left(a_{1}+a_{2}, b_{1}+b_{2}+\sum_{1 \leq i<j \leq n} a_{1, i} a_{2, j}\right) .
$$

A straightforward computation shows that this law is associative, and that the inverse of $(a, b)$ is

$$
\left(a, b+\sum_{1 \leq i<j \leq n} a_{i} a_{j}\right)
$$

Projection onto the first factor exhibits $H_{n}$ as a central extension of $(\mathbb{Z} / 2 \mathbb{Z})^{n}$ by $\mathbb{Z} / 2 \mathbb{Z}$.
For $1 \leq i \leq n$ we donte by $e_{i}$ the $i$ th unit vector in $(\mathbb{Z} / 2 \mathbb{Z})^{n}$, set $x_{i}=\left(e_{i}, 0\right) \in H_{n}$, and $\epsilon=(0,1) \in H_{n}$. We denote the unit element $(0,0) \in H_{n}$ by 1 . We can check that

$$
\begin{equation*}
x_{i}^{2}=\epsilon^{2}=1, \quad 1 \leq i \leq n \tag{2.1}
\end{equation*}
$$

that

$$
\begin{equation*}
x_{i} x_{j}=\epsilon x_{j} x_{i}, \quad 1 \leq i, j \leq n, i \neq j, \tag{2.2}
\end{equation*}
$$

and that

$$
\begin{equation*}
\epsilon x_{i}=x_{i} \epsilon, \quad 1 \leq i \leq n . \tag{2.3}
\end{equation*}
$$

Furthermore, the relations in Eq. (2.1), Eq. (2.2), and Eq. (2.3) among the generators $x_{1}, \ldots, x_{n}, \epsilon$ define the group $H_{n}$ since using these relations every word in $x_{1}, \ldots, x_{n}, \epsilon$ can be brought to the form $x_{i_{1}} \cdots x_{i_{k}} \epsilon^{\delta}$ with $1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n$ and $\delta \in\{0,1\}$.

We therefore have an action of $S_{n}$ on $H_{n}$ by automorphisms via

$$
\sigma\left(x_{i}\right)=x_{\sigma(i)}, \sigma(\epsilon)=\epsilon, \quad \sigma \in S_{n}, 1 \leq i \leq n .
$$

Let $G_{n}=H_{n} \rtimes S_{n}$ be the semidirect product defined using this action. Since $\epsilon \in H_{n}$ is central and $S_{n}$-invariant, it lies in the center of $G_{n}$, so

$$
G_{n} /\langle\epsilon\rangle=G_{n} /\{1, \epsilon\} \cong(\mathbb{Z} / 2 \mathbb{Z})^{n} \rtimes S_{n}=B_{n}
$$

We see that $G_{n}$ is a central extension of $B_{n}$ by $\mathbb{Z} / 2 \mathbb{Z}$. We denote by $\beta_{n}$ the class in $H^{2}\left(B_{n}, \mathbb{Z} / 2 \mathbb{Z}\right)$ corresponding to this extension.

Let $\sigma, \tau \in B_{n}$ be two elements that commute, let $\widetilde{\sigma}, \widetilde{\tau}$ be lifts to $G_{n}$, and define

$$
\phi(\sigma, \tau)=[\widetilde{\sigma}, \widetilde{\tau}]=\widetilde{\sigma} \widetilde{\tau} \widetilde{\sigma}^{-1} \widetilde{\tau}^{-1} \in\langle\epsilon\rangle \cong \mathbb{Z} / 2 \mathbb{Z}
$$

Since $G_{n}$ is a central extension of $B_{n}$, the above is indeed independent of the choice of lifts. As every element in $\mathbb{Z} / 2 \mathbb{Z}$ is its own inverse, we see that

$$
\begin{equation*}
\phi(\sigma, \tau)=[\widetilde{\sigma}, \widetilde{\tau}]=[\widetilde{\tau}, \widetilde{\sigma}]^{-1}=[\widetilde{\tau}, \widetilde{\sigma}]=\phi(\tau, \sigma) \tag{2.4}
\end{equation*}
$$

We denote by

$$
C_{B_{n}}(\sigma)=\left\{\tau \in B_{n}: \sigma \tau=\tau \sigma\right\}
$$

the centralizer of $\sigma$ in $B_{n}$.

Proposition 2.1. For every $\sigma \in B_{n}$ the map that sends $\tau \in C_{B_{n}}(\sigma)$ to $\phi(\sigma, \tau)$ is a homomorphism.
Proof. For every $\tau_{1}, \tau_{2} \in C_{B_{n}}(\sigma)$ we have

$$
\phi\left(\sigma, \tau_{1} \tau_{2}\right)=\widetilde{\sigma} \widetilde{\tau}_{1} \widetilde{\tau}_{2} \widetilde{\sigma}^{-1} \widetilde{\tau}_{2}^{-1}{\widetilde{\tau_{1}}}^{-1}, \quad \phi\left(\sigma, \tau_{1}\right) \phi\left(\sigma, \tau_{2}\right)=\widetilde{\sigma} \widetilde{\tau}_{1} \widetilde{\sigma}^{-1} \widetilde{\tau}_{1}^{-1}\left[\widetilde{\sigma}, \widetilde{\tau}_{2}\right]
$$

so after cancelling $\widetilde{\sigma} \widetilde{\tau}_{1}$, it remains to check that

$$
\widetilde{\tau}_{2} \widetilde{\sigma}^{-1} \widetilde{\tau}_{2}^{-1} \widetilde{\tau}_{1}^{-1}=\widetilde{\sigma}^{-1} \widetilde{\tau}_{1}^{-1}\left[\widetilde{\sigma}, \widetilde{\tau_{2}}\right] .
$$

After multiplying by $\widetilde{\sigma}$ from the left, we just need to check that $\left[\widetilde{\sigma}, \widetilde{\tau_{2}}\right]$ commutes with $\widetilde{\tau_{1}}$. This is indeed the case because $\left[\widetilde{\sigma}, \widetilde{\tau_{2}}\right]$ lies in the central subgroup $\{1, \epsilon\}$ of $G_{n}$.
Corollary 2.2. For every $\tau \in B_{n}$ the map that sends $\sigma \in C_{B_{n}}(\tau)$ to $\phi(\sigma, \tau)$ is a homomorphism.
Proof. For $\sigma_{1}, \sigma_{2} \in C_{B_{n}}(\tau)$ we get from Eq. (2.4) and Proposition 2.1 that

$$
\phi\left(\sigma_{1} \sigma_{2}, \tau\right)=\phi\left(\tau, \sigma_{1} \sigma_{2}\right)=\phi\left(\tau, \sigma_{1}\right) \phi\left(\tau, \sigma_{2}\right)=\phi\left(\sigma_{1}, \tau\right) \phi\left(\sigma_{2}, \tau\right) .
$$

as required.
Proposition 2.3. For a $k$-cycle $\sigma=\left(i_{1} \ldots i_{k}\right) \in S_{n} \leq B_{n}$, and

$$
\tau=e_{i_{1}}+\cdots+e_{i_{k}} \in(\mathbb{Z} / 2 \mathbb{Z})^{n} \leq B_{n}
$$

we have $\phi(\sigma, \tau)=\epsilon^{k-1}$. For every $\alpha \in S_{n} \leq B_{n}$ with $\alpha\left(i_{1}\right)=i_{1}, \ldots, \alpha\left(i_{k}\right)=i_{k}$ we have $\phi(\alpha, \tau)=1$.
Proof. We take $\widetilde{\sigma}=\left(i_{1} \ldots i_{k}\right), \widetilde{\tau}=x_{i_{1}} \cdots x_{i_{k}}$ and get that

$$
\begin{aligned}
\phi(\sigma, \tau) & =\widetilde{\sigma} \widetilde{\tau} \widetilde{\sigma}^{-1} \cdot \widetilde{\tau}^{-1}=\sigma\left(x_{i_{1}} \cdots x_{i_{k}}\right) \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1}=x_{\sigma\left(i_{1}\right)} \cdots x_{\sigma\left(i_{k}\right)} \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1} \\
& =x_{i_{2}} \cdots x_{i_{k}} x_{i_{1}} \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1}=\epsilon^{k-1} x_{i_{1}} \cdots x_{i_{k}} \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1}=\epsilon^{k-1} .
\end{aligned}
$$

Taking $\widetilde{\alpha}=\alpha$ we see that

$$
\phi(\alpha, \tau)=\widetilde{\alpha} \widetilde{\tau} \widetilde{\alpha}^{-1} \cdot \widetilde{\tau}^{-1}=\alpha\left(x_{i_{1}} \cdots x_{i_{k}}\right) \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1}=x_{\alpha\left(i_{1}\right)} \cdots x_{\alpha\left(i_{k}\right)} \cdot\left(x_{i_{1}} \cdots x_{i_{k}}\right)^{-1}=1
$$

as claimed.
Corollary 2.4. Let $\sigma \in S_{n} \leq B_{n}$ whose disjoint cycles are

$$
C_{1}=\left(i_{1,1} \ldots i_{1, d_{1}}\right), \ldots, C_{j}=\left(i_{j, 1} \ldots i_{j, d_{j}}\right), \quad \sum_{r=1}^{j} d_{r}=n
$$

and let $\tau \in C_{B_{n}}(\sigma)$. Then there exists a (unique) choice of $\tau^{\prime} \in C_{S_{n}}(\sigma)$ and $\lambda_{1}, \ldots, \lambda_{j} \in \mathbb{Z} / 2 \mathbb{Z}$ such that

$$
\begin{equation*}
\tau=\tau^{\prime} v, \quad v=\sum_{r=1}^{j} \lambda_{r}\left(e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right) \tag{2.5}
\end{equation*}
$$

and

$$
\phi(\sigma, \tau)=\epsilon^{\sum_{r=1}^{j} \lambda_{r}\left(d_{r}-1\right)} .
$$

Proof. The ability to express $\tau$ as in Eq. (2.5) is immediate from the definition of the group law in $B_{n}$. From Proposition 2.1, Corollary 2.2, and Proposition 2.3 we therefore get that

$$
\begin{aligned}
\phi(\sigma, \tau) & =\phi\left(\sigma, \tau^{\prime} \cdot \sum_{r=1}^{j} \lambda_{r}\left(e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right)\right)=\phi\left(\sigma, \tau^{\prime}\right) \cdot \prod_{r=1}^{j} \phi\left(\sigma, e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right)^{\lambda_{r}} \\
& =\left[\sigma, \tau^{\prime}\right] \cdot \prod_{r=1}^{j} \prod_{s=1}^{j} \phi\left(C_{s}, e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right)^{\lambda_{r}}=1 \cdot \prod_{r=1}^{j} \epsilon^{\lambda_{r}\left(d_{r}-1\right)}=\epsilon^{\sum_{r=1}^{j} \lambda_{r}\left(d_{r}-1\right)}
\end{aligned}
$$

as required.

We keep the notation of Corollary 2.4 and denote by $O_{1}, \ldots, O_{z}$ the orbits of the action by conjugation of the subgroup of $S_{n}$ generated by $\tau^{\prime}$ on $\left\{C_{1}, \ldots, C_{j}\right\}$. For $1 \leq y \leq z$ we let $I_{y} \subseteq\{1, \ldots, n\}$ be the set of all indices that appear in one of the cycles in $O_{y}$, and define the permutation $\tau_{y}^{\prime} \in S_{n}$ by

$$
\tau_{y}^{\prime}(i)= \begin{cases}\tau^{\prime}(i) & i \in I_{y} \\ i & i \notin I_{y}\end{cases}
$$

We have a disjoint union

$$
\bigcup_{y=1}^{z} I_{y}=\{1, \ldots, n\}
$$

hence $\tau^{\prime}=\tau_{1}^{\prime} \cdots \tau_{z}^{\prime}$ and the permutations $\tau_{1}^{\prime}, \ldots, \tau_{z}^{\prime}$ commute. We put

$$
\tau_{y}=\tau_{y}^{\prime} v_{y}, \quad v_{y}=\sum_{\substack{1 \leq \leq \leq j \\ C_{r} \in O_{y}}} \lambda_{r}\left(e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right)
$$

and get that

$$
\begin{equation*}
\tau=\tau_{1}^{\prime} v_{1} \cdots \tau_{z}^{\prime} v_{z} \tag{2.6}
\end{equation*}
$$

where the factors $\tau_{1}^{\prime} v_{1}, \ldots, \tau_{z}^{\prime} v_{z}$ commute.

## 3. Proof of Theorem 1.1

It suffices to show, for each $\alpha \in H^{1}(\widetilde{M}, \mathbb{Z} / 2 \mathbb{Z})$, that the pairing of the branch divisor $\mathcal{D}_{\pi}$ with $\alpha$ vanishes, namely

$$
\sum_{\widetilde{K} \text { a component of } \widetilde{L}}\left(e_{\widetilde{K}}-1\right)\langle[\widetilde{K}], \alpha\rangle=0
$$

or equivalently

$$
\sum_{K \text { a component of } L} \sum_{\widetilde{K} \text { a component of } \pi^{-1}(K)}\left(e_{\widetilde{K}}-1\right)\langle[\widetilde{K}], \alpha\rangle=0 .
$$

Associated to $\alpha$ is a degree two covering space $N \rightarrow \widetilde{M}$. Let $n$ be the degree of $\pi: \widetilde{M} \rightarrow M$ which is locally constant away from $L$, thus constant. Away from $L$, we get that $N$ is a degree 2 covering space of a degree $n$ covering space, hence has monodromy group contained in the wreath product

$$
S_{2} \imath S_{n}=(\mathbb{Z} / 2 \mathbb{Z}) \imath S_{n}=(\mathbb{Z} / 2 \mathbb{Z})^{n} \rtimes S_{n}=B_{n} .
$$

We thus have a map $H^{2}\left(B_{n}, \mathbb{Z} / 2 \mathbb{Z}\right) \rightarrow H^{2}(M \backslash L, \mathbb{Z} / 2 \mathbb{Z})$, and we denote by $\gamma \in H^{2}(M \backslash L, \mathbb{Z} / 2 \mathbb{Z})$ the image of $\beta_{n}$.

Consider a tubular neighborhood $Q$ of $L$ and let $S=\partial Q$ be its boundary, a union of tori. Each such torus $T$ corresponds to a unique component $K$ of $L$ - the boundary of a tubular neighborhood of $K$ is $T$. Since $S$ bounds a 3-manifold in $M \backslash L$, i.e. the complement of the tubular neighborhood $Q$, our cohomology class $\gamma$ integrates to 0 on $S$. It follows that

$$
\sum_{T \text { a component of } S} \int_{T} \gamma=0 .
$$

It is therefore sufficient to prove that

$$
\begin{equation*}
\int_{T} \gamma=\sum_{\widetilde{K} \text { a component of } \pi^{-1}(K)}\left(e_{\widetilde{K}}-1\right)\langle[\widetilde{K}], \alpha\rangle . \tag{3.1}
\end{equation*}
$$

Since $T$ is a torus, a covering of $T$ with monodromy $B_{n}$, i.e. a homomorphism from $\pi_{1}(T)$ to $B_{n}$, is given by a pair of elements $m, \ell \in B_{n}$ that commute, where $m$ represents a meridian and $\ell$ represents a longitude. From the standard cell decomposition of the torus, we can see that

$$
\int_{T} \gamma=\phi(m, \ell)
$$

Since the $\mathbb{Z} / 2 \mathbb{Z}$-covering $N \rightarrow \widetilde{M}$ is unbranched over every component $\widetilde{K}$ of $\pi^{-1}(K)$, the monodromy of the meridian $m$ does not swap the two components of the covering, and therefore $m$ is (up to conjugation) contained in $S_{n} \leq B_{n}$.

We shall use here the notation of Corollary 2.4 and the paragraph following it for $\sigma=m$ and $\tau=\ell$, in particular we write $\ell=\ell^{\prime} v$ as in Eq. (2.5). The components of $\pi^{-1}(K)$ are naturally in bijection with the orbits of the action by conjugation of the subgroup of $S_{n}$ generated by $\ell^{\prime}$ on the set of disjoint cycles $\left\{C_{1}, \ldots, C_{j}\right\}$ of $m$. We denote by $O_{\widetilde{K}}$ the orbit corresponding to a component $\widetilde{K}$ of $\pi^{-1}(K)$. As in Eq. (2.6), we can write

$$
\ell=\prod_{\widetilde{K}} \ell_{\widetilde{K}}, \quad \ell_{\widetilde{K}}=\ell_{\widetilde{K}}^{\prime} v_{\widetilde{K}}, \quad v_{\widetilde{K}}=\sum_{\substack{1 \leq r \leq j \\ C_{r} \in \mathcal{O}_{\widetilde{K}}}} \lambda_{r}\left(e_{i_{r, 1}}+\cdots+e_{i_{r, d_{r}}}\right)
$$

We denote the number of cycles in $O_{\widetilde{K}}$ by $t_{\widetilde{K}}$, note that each such cycle is of length $e_{\widetilde{K}}$, and set

$$
d_{\widetilde{K}}=\#\left\{1 \leq r \leq j: C_{r} \in O_{\widetilde{K}}, \lambda_{r}=1\right\} .
$$

It follows from Corollary 2.4 that $\phi\left(m, \ell_{\widetilde{K}}\right) \equiv\left(e_{\widetilde{K}}-1\right) d_{\widetilde{K}} \bmod 2$, so from Corollary 2.2 we get that

$$
\phi(m, \ell)=\sum_{\widetilde{K} \text { a component of } \pi^{-1}(K)} \phi\left(m, \ell_{\widetilde{K}}\right) \equiv \sum_{\widetilde{K} \text { a component of } \pi^{-1}(K)}\left(e_{\widetilde{K}}-1\right) d_{\widetilde{K}} \bmod 2 .
$$

It is therefore enough to show that $d_{\widetilde{K}} \equiv\langle[\widetilde{K}], \alpha\rangle \bmod 2$.
Let $C$ be a longitude curve in a tubular neighborhood of $\widetilde{K}$. Then $[C]=[\widetilde{K}]$ as homology classes in $H_{1}(\widetilde{M}, \mathbb{Z} / 2 \mathbb{Z})$, so it suffices to show that $d_{\widetilde{K}} \equiv\langle[C], \alpha\rangle \bmod 2$. The projection of $[C]$ to $T$ is $a[m]+t_{\widetilde{K}}[\ell]$ for some $a \in \mathbb{Z}$. Thus, the action of $C$ on the covering space $N \rightarrow M$ is given by $m^{a} \ell^{t} \tilde{K}$. We have

$$
m^{a} \ell^{t_{\widetilde{K}}}=m^{a}\left(\ell^{\prime} v\right)^{t}{ }_{\widetilde{K}}=m^{a} \ell^{\prime t_{\tilde{K}}} \cdot\left(v+\ell^{\prime}(v)+\cdots+\ell^{\prime t} \tilde{K}^{-1}(v)\right)
$$

The pairing $\langle[C], \alpha\rangle$ is nonzero if and only if the monodromy along $C$ of the covering $N \rightarrow \widetilde{M}$ is nontrivial, which happens if and only if the action of $m^{a} \ell^{t} \widetilde{K}$ sends one branch of this covering to the other, and that occurs if and only if the $k$ th entry of $v+\ell^{\prime}(v)+\cdots+\ell^{\prime t} \tilde{K}^{-1}(v)$ is nonzero for some (equivalently, every) index $1 \leq k \leq n$ that belongs to one of the cycles in $O_{\widetilde{K}}$. It is therefore sufficient to show that

$$
d_{\widetilde{K}} \equiv\left(v+\ell^{\prime}(v)+\cdots+\ell^{\prime t} \widetilde{K}^{-1}(v)\right)_{k} \quad \bmod 2
$$

We have

$$
\left(v+\ell^{\prime}(v)+\cdots+\ell^{\left.\prime t_{\tilde{K}^{-1}}(v)\right)_{k}=v_{k}+\ell^{\prime}(v)_{k}+\cdots+\ell^{\prime t} \tilde{\widetilde{K}}^{-1}(v)_{k}=v_{k}+v_{\ell^{\prime-1}(k)}+\cdots+v_{\ell^{\prime-t} \widetilde{K}^{+1}(k)} .}\right.
$$

By the orbit-stabilizer theorem, each of the $t_{\widetilde{K}}$ cycles in $O_{\widetilde{K}}$ contains exactly one of the $t_{\widetilde{K}}$ elements $k, \ell^{\prime-1}(k), \ldots, \ell^{\prime-t_{\tilde{K}}+1}(k)$. Thus, from Eq. (2.5) we get that

$$
v_{k}+v_{\ell^{\prime-1}(k)}+\cdots+v_{\ell^{\prime-t} \widetilde{K}^{+1}(k)}=\sum_{\substack{1 \leq r \leq j \\ C_{r} \in \bar{O}_{\widetilde{K}}}} \lambda_{r} \equiv d_{\widetilde{K}} \quad \bmod 2
$$

as desired.
