# VORTICITY CONVERGENCE FROM BOLTZMANN TO 2D INCOMPRESSIBLE EULER EQUATIONS BELOW YUDOVICH CLASS

#### Abstract

It is challenging to perform a multiscale analysis of mesoscopic systems exhibiting singularities at the macroscopic scale. In this paper, we study the hydrodynamic limit of the Boltzmann equations

toward the singular solutions of 2 D incompressible Euler equations whose vorticity is unbounded

\partial_{t} u+u \cdot \nabla_{x} u+\nabla_{x} p=0, \quad \operatorname{div} u=0 . \tag{0.2}
\end{equation*}

We obtain a microscopic description of the singularity through the so-called kinetic vorticity and understand its behavior in the vicinity of the macroscopic singularity. As a consequence of our new analysis, we settle affirmatively an open problem of the hydrodynamic limit toward Lagrangian solutions of the 2D incompressible Euler equation whose vorticity is unbounded $\left(\omega \in L^{\mathfrak{p}}\right.$ for any fixed $\left.1 \leq \mathfrak{p}<\infty\right)$. Moreover, we prove the convergence of kinetic vorticities toward the vorticity of the Lagrangian solution of the Euler equation. In particular, we obtain the rate of convergence when the vorticity blows up moderately in $L^{\mathfrak{p}}$ as $\mathfrak{p} \rightarrow \infty$ (localized Yudovich class).

Introduction. One of the fundamental questions in the area of partial differential equations is the Hilbert's sixth problem, seeking a unified theory of the gas dynamics including different levels of descriptions from a mathematical standpoint by connecting the mesoscopic Boltzmann equations to the macroscopic fluid models that arise in formal limits. The Boltzmann equation is a fundamental model of kinetic theory for dilute collections of gas particles, which undergo elastic binary collisions. The dimensionless form of the equation is given as integrodifferential equation (0.1), where $F(t, x, v) \geq 0$ is a density distribution of particles on the phase space. Here, the Strouhal number and Knudsen number are denoted by St and Kn, which are a ratio of the characteristic length to the characteristic time and a ratio of mean free path to the characteristic length respectively.

The effect of binary collision between particles is described by $Q(F, F)$, which takes various forms of the nonlocal-in-velocity operator depending on the nature of particles and its intermolecular interaction ([1]). An intrinsic equilibrium, satisfying $Q(\cdot, \cdot)=0$, is given by the so-called local Maxwellian associated with $(R, U, \Theta) \in \mathbb{R}_{+} \times \mathbb{R}^{3} \times \mathbb{R}_{+}$

The collision operator enjoys so-called the collision invariance: $\int Q(F, G)\left[\begin{array}{ccc}1 & v & |v|^{2}\end{array}\right] \mathrm{d} v=0$ for arbitrary $F, G$. The celebrated Boltzmann's H-theorem (entropy $H=\int F \ln F \mathrm{~d} v$ ) reveals

[^0]the entropy dissipation: $\int Q(F, F) \ln F \mathrm{~d} v \leq 0$. In this paper, we consider most basic hardsphere collision cross section:

where postcollision velocities are denoted by $v^{\prime}=v-\left(\left(v-v_{*}\right) \cdot \sigma\right) \sigma$ and $v_{*}^{\prime}=v_{*}+\left(\left(v-v_{*}\right) \cdot \sigma\right) \sigma$.
Besides St and Kn, we introduce the Mach number Ma as a size of fluctuations of $F$ around the global Maxwellian $M_{1,0,1}(v)$ of the reference state $(1,0,1)$. Relations between $\mathrm{St}, \mathrm{Kn}$ and Ma are important. Naturally, Ma is bounded above by $\mathrm{St} / c$ where $c$ is denoted by the speed of sound. On the other hand, the famous Reynolds number Re appears as a ratio between the Knudsen number and Mach number through the von Karman relation: $1 / \operatorname{Re}=\mathrm{Kn} / \mathrm{Ma}$. By passing Kn to zero and choosing different $\mathrm{St}(\mathrm{Kn})$ and $\mathrm{Ma}(\mathrm{Kn})$ as functions of Kn , we can formally derive various PDEs of macroscopic variables. Formally the incompressible Euler limit can be realized in the following scaling of large Reynolds number limit

In the diffusive scaling, the same scaling of (0.5) with $\kappa=1$, the corresponding macroscopic PDE is the incompressible Navier-Stokes-Fourier system. This scaling problem is better understood as a singular perturbation in (0.1) is milder than our case (0.5) (see [23, 31, 25, 26] and references therein). In [23], Esposito-Guo-Kim-Marra establish a uniform bound of a perturbation $f$ in $F=M_{1,0,1}+\varepsilon f \sqrt{M_{1,0,1}}$ without a priori information of the fluid solutions, and hence they derive (actually construct) a strong solution of incompressible Navier-StokesFourier system for both steady and unsteady cases in the presence of boundary. One of key ingredients is to obtain an $L_{x}^{6}\left(\hookleftarrow H_{x}^{1}\right.$ in 3 D$)$ control of $f$, by realizing a hidden elliptic equations of the bulk velocity part of $f$ in

for a linearized operator $L$ of $Q$. Unfortunately, a uniform bound of $f$ in the Euler scaling seems not feasible even in 2D without a priori information of solutions of the incompressible Euler equations, due to additional singularity in both macro-micro scale balance and nonlinear perturbation, which are major obstacles in our analysis.

The regularity of fluid solutions plays a crucial rule in the multiscale analysis in the Euler scaling (0.5), which has been revealed differently in a modulated entropy inequality by SaintRaymond [42], and an asymptotic expansion by Jang-Kim [35]. This effect appears as an growth in the microscopic scale (see (0.17)), which resembles the famous Beale-Kato-Majda result [6]. For a spatially Lipschitz continuous velocity field, Saint-Raymond proves in [42] a hydrodynamic limit toward such solutions of the incompressible Euler equations (0.2). It has been an open problem to study the hydrodynamic limit toward solutions of the Euler equations, which are not spatially Lipschitz continuous such as vortex sheet solutions. Due to the transport feature of 2D Euler equations, such singular solutions have been well-understood. For compactly supported initial vorticities in $L^{\mathfrak{p}}$ for $1<\mathfrak{p}<\infty$, global existence theory was first proved by DiPerna-Majda in [21]. Using the so-called concentration-cancellation, the result was extended for a finite measure with distinguished sign by Delort in [18], and $L^{1}$ vorticities by Vecchi-Wu in [43]. Recently, Bohun-Bouchut-Crippa construct Lagrangian solutions of $\omega \in L^{1}$ in [7] using a stability estimate of [8].
A. Main Theorems. We recall the main object of this paper: the scaled Boltzmann equation (0.1) of the scaling (0.5)

In this paper we set that the spatial variables and velocity variables belong to 2 D periodic domain and 3D whole space respectively:

The existence and uniqueness of the Boltzmann equation with fixed scaling have been extensively studied in [28, 29, 30]; initial-boundary value problem [32, 38, 39]; singularity formation [37; boundary regularity estimate [33, 10]; non-equilibrium steady states [22]. For the weak solution contents, we refer to [19, 26] and the reference therein.

As the main quantities in the hydrodynamic limit, we are interested in the following observables and their convergence toward the counterparts in fluid:

Definition 1 (Boltzmann's macroscopic velocity and vorticity).

In 2D, the incompressible Euler equations (0.2) has the vorticity formulation:

We will present the Biot-Savart formula of (0.12) in the periodic box $\mathbb{T}^{2}$ at (1.19). When a velocity field is Lipschitz continuous, there exists a Lagrangian flow $X(s ; t, x)$ solving

Then a smooth solution of the vorticity equation (0.11)-(0.13) is given by

Out of the smooth context, a general notion of Lagrangian flow has been introduced:
Definition 2 ([20, 15]). Let $u \in L^{1}\left([0, T] \times \mathbb{T}^{2} ; \mathbb{R}^{2}\right)$. A map $X:[0, T] \times \mathbb{T}^{2} \rightarrow \mathbb{T}^{2}$ is a regular Lagrangian flow of (0.14) if and only if for almost every $x \in \mathbb{T}^{2}$ and for any $t \in[0, T]$, the map $s \in[0, t] \mapsto X(s ; t, x) \in \mathbb{T}^{2}$ is an absolutely continuous integral solution of (0.14); and there exists a constant $\mathfrak{C}>0$ such that for all $(s, t) \in[0, t] \times[0, T]$ there holds

for every measurable function $\phi: \mathbb{T}^{2} \rightarrow[0, \infty]$.

For a given regular Lagrangian flow to (0.14), we can define the Lagrangian solution $(u, \omega)$ along the regular Lagrangian flow as in (0.15). In fact, the existence and uniqueness (for a given $u$ ) of the regular Lagrangian flow is proved in [20, (15, 8] as long as (0.12) holds while $\omega \in L^{\mathfrak{p}}$ for $\mathfrak{p} \geq 1$.

Our first theorem is about the convergence of $\omega_{B}^{\varepsilon}$ to the Lagrangian solution $\omega$, when vorticities belong to $L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)$ when $\mathfrak{p}<\infty$.

Theorem 1 (Informal statement of Theorem 20: Strong Convergence). Let arbitrary $T>0$ and $\left(u_{0}, \omega_{0}\right) \in L^{2}\left(\mathbb{T}^{2}\right) \times L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)$ for $\mathfrak{p} \geq 1$. Let $(u, \omega) \in L^{\infty}\left((0, T) ; L^{2}\left(\mathbb{T}^{2}\right) \times L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)\right)$ be a Lagrangian solution of 2D incompressible Euler equations (0.11)-(0.13) with initial data $\left(u_{0}, \omega_{0}\right)$. Then we construct a family of solutions to the Boltzmann equation (0.7) whose macroscopic velocity and vorticity $\left(u_{B}^{\varepsilon}, \omega_{B}^{\varepsilon}\right)$ of (0.10) converge to the Lagrangian solution. Moreover, we have

Remark 1. Uniqueness of the incompressible Euler equations in 2D is only known for vorticities with moderate growth of $L^{\mathfrak{p}}$ norm as $\mathfrak{p} \rightarrow \infty$ by Yudovich [36, 45]. In some sense, we can view the theorem as a "selection principle" of a Lagrangian solution of the incompressible Euler equations from the Boltzmann equation.

Remark 2. Our proof does not rely on a result of inviscid limit of the nonlinear NavierStokes equations (cf. 35]) nor the higher order Hilbert expansion (cf. see the results by Guo [31] and de Masi-Esposito-Lebowitz [17]). A direct approach we develop in this paper is based on stability analysis for both the Lagrangian solutions of the inviscid fluid and the Boltzmann solutions with a new corrector.

Our second theorem is about the quantitative rate of convergence/stability of $\omega_{B}^{\varepsilon}$ to $\omega$, when the uniqueness of fluid is guaranteed. In [45], Yudovich extend his uniquness result for bounded vorticities [36] to the so-called localized Yudovich class, namely $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}(\Omega)$ with certain modulus of continuity for its velocity $u$. Here,

\|\omega\|_{Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)}:=\sup _{1 \leq \mathfrak{p}<\infty} \frac{\|\omega\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}}{\Theta(\mathfrak{p})} \text { for some } \Theta(\mathfrak{p}) \rightarrow \infty \text { as } \mathfrak{p} \rightarrow \infty .

Here, we specify $\Theta: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$: there exists $m \in \mathbb{Z}_{+}$such that $\Theta(\mathfrak{p})=\prod_{k=1}^{m} \log _{k} \mathfrak{p}$, for large $\mathfrak{p}>1$, where $\log _{k} \mathfrak{p}$ is defined inductively by $\log _{0} \mathfrak{p}=1, \log _{1} \mathfrak{p}=\log \mathfrak{p}$, and $\log _{k+1} \mathfrak{p}=$ $\log \log _{k} \mathfrak{p}$. Also, we denote the inverse function of $\log _{m}(\mathfrak{p})$ (defined for large $\mathfrak{p}$ ) by $e_{m}$. Finally, we note that $\int_{e_{m}(1)}^{\infty} \frac{1}{p \Theta(\mathfrak{p})}=\infty$ which turns out to be important in uniqueness of the solution.
Theorem 2 (Informal statement of Theorem 21, Rate of Convergence). If we further assume $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$ in addition to Theorem $\mathbb{1}$, then

\omega_{B}^{\varepsilon} \rightarrow \omega \text { strongly in }[0, T] \times \mathbb{T}^{2} \text { with an explicit rate. }
$$

B. Novelties, difficulties and idea. The major novelty of this paper is to establish the incompressible Euler limit in the level of vorticity without using inviscid limit of the NavierStokes equations, in the vicinity of the macroscopic singularity $\left(\omega \notin L^{\infty}\left(\mathbb{T}^{2}\right)\right)$. We study the convergence of Boltzmann's macroscopic vorticity toward the Euler's vorticity, as interesting singular behavior, e.g. interfaces in vortex patches, can be observed only in a stronger topology of velocities. We believe this new approach will shed the light to the validity of Euler equations more direct fashion. Possible application would be direct validity proof of Euler solutions from
the kinetic theory without relying on the inviscid limit results. In addition, we are able to allow quite far-from-equilibrium initial data (see (0.18)).

There are two major difficulties in the proof. First, the macroscopic solutions are singular and their singularity appears as growth in the microscopic level (35]):

This factor becomes significantly difficult to control when we study the Boltzmann solutions close to the solution of Euler equations, instead of Navier-Stokes equations. The diffusion in the bulk velocity has a considerable magnitude, and causes a singular term due to the growth of (0.17). Second, the macro-micro scale balance is singular in the Euler scaling. As the transport effect is weaker, this results the lack of a scale factor of the hydrodynamic bound in the dissipation. In fact, an integrability gain in $L^{p}\left(\hookleftarrow H_{x}^{1}\right.$ in 2D) of [23] or velocity average lemma [24] are not useful to control the singular nonlinearity. In addition, the perturbation equations suffer a loss of scale due to the commutator of spatial derivatives and the linearized operator around a local Maxwellian associated with macroscopic solutions.

To overcome the difficulties, we devise a novel viscosity-canceling correction in an asymptotic expansion of the scaled Boltzmann equations. To handle the low regularity of fluid velocity fields, we regularize the initial data with scale $\beta$ and expand the Boltzmann equations around the local Maxwellian $M_{1, \varepsilon u^{\beta}, 1}$ associated with the Euler solution $u^{\beta}$ starting from $u_{0}^{\beta}$. At first place, one may try a form of the standard Hilbert expansion:

\end{equation*}

by matching to cancel most singular terms. The Euler equation is in the hierarchy of $O\left(\varepsilon^{2}\right)$ : it comes from $\varepsilon \partial_{t} M_{1, \varepsilon u^{\beta}, 1}$ and correctors. However, the third term of order $\varepsilon^{2} \kappa$ introduces the viscosity contribution $-\varepsilon^{2} \kappa_{0} \Delta_{x} u^{\beta} \cdot\left(v-\varepsilon u^{\beta}\right) M_{1, \varepsilon u^{\beta}, 1}$ : and comparing fo $\varepsilon f_{R} \sqrt{M_{1, \varepsilon u^{\beta}, 1}}$, we see that if this term is not canceled, then it will drive the remainder to order $O(\varepsilon \kappa)$ - which is dangerous. Note that this term is hydrodynamic, so we cannot rely on coercivity provided by $L$ : it provides additional $\varepsilon \sqrt{\kappa}$ smallness only for non-hydrodynamic terms.

A simple but useful observation is that still this term is in a lower hierarchy than that of Euler equation. Thus, if we introduce an additional corrector in $\varepsilon \kappa$ level, we may cancel out viscosity contribution. Of course one needs to be careful as we introduce $\varepsilon \kappa$-size term to cancel out $\varepsilon^{2} \kappa$-size term! However, by carefully choosing the form of $\varepsilon \kappa$-size corrector:

we can actually fulfill our goal.
(1) $\varepsilon \kappa \tilde{u} \cdot\left(v-\varepsilon u^{\beta}\right) M_{1, \varepsilon u^{\beta}, 1}$ is fully hydrodynamic, and therefore the most singular term coming from collision with local Maxwellian vanishes. Then the largest term coming from collision is the collision of this corrector with itself, which is of size $\varepsilon \kappa$, but being non-hydrodynamic. Thus, it is in fact, small (due to $\varepsilon \sqrt{\kappa}$ gain for non-hydrodynamic term, non-hydrodynamic source terms of $\varepsilon \sqrt{\kappa}$ drives the remainder to order $O(\varepsilon \kappa)$. )
(2) By imposing $\nabla_{x} \cdot \tilde{u}=0$, we can cancel out the hydrodynamic part for $v \cdot \nabla_{x}(\tilde{u} \cdot(v-$ $\left.\varepsilon u^{\beta}\right) M_{1, \varepsilon u^{\beta}, 1}$ ), which is of order $\varepsilon \kappa$. Also, by introducing additional corrector at $\varepsilon^{2} \kappa$ level, one can cancel out all hydrodynamic terms of $\varepsilon^{2} \kappa$ level by evolution equation for $\tilde{u}$, including $\Delta_{x} u$. Therefore, the remaining hydrodynamic terms are of order $o\left(\varepsilon^{2} \kappa\right)$, and non-hydrodynamic terms are of order $O(\varepsilon \kappa)$, and both are small.
(3) Interaction of this corrector and the remainder also turns out to be innocuous as well.

It is worth to remark that in this corrector-based Hilbert expansion we do not need to set $\operatorname{up} \varepsilon=\kappa$ as in usual Hilbert expansion [17]: we only need $\varepsilon / \kappa^{2} \rightarrow 0$. This is satisfactory, in the sense that a regime which is close to Navier-Stokes regime (whose $\kappa$ vanishes slowly) should be more tractable in philosophy: and indeed for such regime we can allow larger deviation from the equilibrium. In addition, we note that this expansion in fact allows even more general data than (0.18): we have additional freedom in choosing $\tilde{u}_{0}$, so in principle a remainder with certain part of size $\varepsilon \kappa$ is in fact admissible, while in (0.18) all parts of remainder should be of size $o(\varepsilon \kappa)$. We believe that this new idea of correction would have many applications.

Notations. For the sake of readers' convenience, we list notations used often in this paper.

## 1. Approximation of the Lagrangian solutions of the Euler equations

As discussed in the introduction, we would like to obtain a limit to weak solutions, which does not have enough regularity in the framework of the standard Hilbert expansion in general, Moreover, we want a convergent sequence in a stronger topology than $L^{\mathfrak{p}}$ for velocity, as interesting singular behavior can be observed only in a stronger topology. However, control in stronger topology requires more regularity for velocity field as well. A straightforward remedy for low regularity of fluid velocity field is to regularize the initial data: therefore, instead of choosing initial data as a perturbation around the local Maxwellian $M_{1, \varepsilon u_{0}, 1}$, we choose initial data as a perturbation around the local Maxwellian $M_{1, \varepsilon u_{0}^{\beta}, 1}$, where $u_{0}^{\beta}$ is the initial data regularization of $u_{0}$ with scale $\beta$. Then if one can prove stability of the Euler solution under the perturbation of initial data, as well as control of remaining small terms, we can construct a sequence of Boltzmann solutions whose bulk velocity converges to Euler solution.

It turns out that this simple idea works well: in the class of solution of Euler equation we consider, we have a certain stability, so we can prove that solution $u^{\beta}$ starting from $u_{0}^{\beta}$ converges to the solution $u$ from $u_{0}$. Also, for the estimate of remainders, introduction of regularization scale $\beta$ gives an additional freedom in our analysis: by sacrificing the speed of regularization convergence, we can control the size of higher derivatives appearing in the remainder equation. In addition, many weak solutions of fluid equations are interpreted as a limit of smooth solutions. In that regard, this initial data regularization approach is quite natural.
1.1. Regularization. In our proof of the hydrodynamic limit from the Boltzmann equations, it is important to regularize the Largangian solutions of the Euler equation (0.11). We achieve this by regularizing the initial data using the standard mollifier. Let $\varphi \in C_{c}^{\infty}\left(\mathbb{R}^{2}\right)$ be a smooth non-negative function with $\int_{\mathbb{R}^{2}} \varphi(x) d x=1$ and $\varphi(x)=0$ for $|x-(0,0)| \geq \frac{1}{4}$. For $\beta \in(0,1)$, we define

$$
\begin{equation*}
\varphi^{\beta}(x):=\frac{1}{\beta^{2}} \varphi\left(\frac{x}{\beta}\right) \text { for } x \in\left[-\frac{1}{2}, \frac{1}{2}\right]^{2} \tag{1.1}
\end{equation*}
$$

Note that $\varphi^{\beta}$ can be extended periodically so that $\varphi^{\beta} \in C^{\infty}\left(\mathbb{T}^{2}\right)$ and $\int_{\mathbb{T}^{2}} \varphi^{\beta}(x) d x=1$ as well. Also, $\varphi^{\beta}$ is supported on $B_{\frac{\beta}{4}}(0)$. Note that $\left\{\varphi^{\beta}\right\}_{\beta}$ are approximate identities: thus, for
$1 \leq p<\infty$ and $\psi \in L^{p}\left(\mathbb{T}^{2}\right)$, we have

$$
\begin{equation*}
\lim _{\beta \rightarrow 0}\left\|\varphi^{\beta} * \psi-\psi\right\|_{L^{p}\left(\mathbb{T}^{2}\right)}=0 . \tag{1.2}
\end{equation*}
$$

Note that we cannot expect a universal rate of convergence, which is independent of $\psi$ if $\psi$ is merely in $L^{p}\left(\mathbb{T}^{2}\right)$ or $p=\infty$. However, if we have a certain regularity for $\psi$, we have the rate of convergence: for example, if $\psi \in W^{1,2}\left(\mathbb{T}^{2}\right)$, we have

$$
\begin{align*}
& \left\|\varphi^{\beta} * \psi-\psi\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}=\left(\int_{\mathbb{T}^{2}}\left|\int_{\mathbb{T}^{2}} \varphi^{\beta}(y)(\psi(x-y)-\psi(x)) \mathrm{d} y\right|^{2} \mathrm{~d} x\right)^{\frac{1}{2}} \\
& \leq \int_{\mathbb{T}^{2}}\left|\varphi^{\beta}(y)\right|\left(\int_{\mathbb{T}^{2}}|\psi(x-y)-\psi(x)|^{2} d x\right)^{\frac{1}{2}} d y  \tag{1.3}\\
& \leq C \int_{\mathbb{T}^{2}}\left|y\left\|\varphi^{\beta}(y) \mid d y\right\| \psi\left\|_{W^{1,2}\left(\mathbb{T}^{2}\right)} \leq C \beta\right\| \psi \|_{W^{1,2}\left(\mathbb{T}^{2}\right)} .\right.
\end{align*}
$$

We consider approximation solutions $\left(u^{\beta}, \omega^{\beta}\right)$ for the mollified initial data:

$$
\begin{align*}
\partial_{t} \omega^{\beta}+u^{\beta} \cdot \nabla \omega^{\beta}=0 & \text { in }[0, T] \times \mathbb{T}^{2}  \tag{1.4}\\
u^{\beta}=-\nabla^{\perp}(-\Delta)^{-1} \omega^{\beta} & \text { in }[0, T] \times \mathbb{T}^{2}  \tag{1.5}\\
\left.\omega^{\beta}\right|_{t=0}=\omega_{0}^{\beta}:=\varphi^{\beta} * \omega_{0} & \text { in } \mathbb{T}^{2} \tag{1.6}
\end{align*}
$$

Note that, for each $\beta \in(0,1)$ this problem (1.4)-(1.6) has a smooth (therefore unique) solution, which is the Lagrangian solution:

$$
\begin{align*}
& \omega^{\beta}(t, x)=\omega_{0}^{\beta}\left(X^{\beta}(0 ; t, x)\right)  \tag{1.7}\\
& \frac{d}{d s} X^{\beta}(s ; t, x)=u^{\beta}\left(s, X^{\beta}(s ; t, x)\right),\left.\quad X^{\beta}(s ; t, x)\right|_{s=t}=x . \tag{1.8}
\end{align*}
$$

Remark 3. If $u^{\beta}$ is obtained from (0.12) with $\omega^{\beta} \in C^{\infty}(\mathbb{T}), u^{\beta}$ is incompressible and thus associated flow $X^{\beta}$ by (0.14) satisfies (0.16) with an equality and $\mathfrak{C}=1$ (measure-preserving).

We define a pressure as a unique solution of $-\Delta p^{\beta}=\operatorname{div}\left(\operatorname{div}\left(u^{\beta} \otimes u^{\beta}\right)\right)$ with $f_{\mathbb{T}^{2}} p^{\beta}=0$. Then we have

$$
\begin{align*}
\left(\partial_{t}+u^{\beta} \cdot \nabla_{x}\right) u^{\beta}+\nabla_{x} p^{\beta}=0 & \text { in }[0, T] \times \mathbb{T}^{2}, \\
\nabla_{x} \cdot u^{\beta}=0 & \text { in }[0, T] \times \mathbb{T}^{2},  \tag{1.9}\\
u^{\beta}(x, 0)=u_{0}^{\beta}(x) & \text { in } \mathbb{T}^{2} .
\end{align*}
$$

Also, we will consider the following auxiliary linear equation.

$$
\begin{array}{r}
\left(\partial_{t}+u^{\beta} \cdot \nabla_{x}\right) \tilde{u}^{\beta}+\tilde{u}^{\beta} \cdot \nabla_{x} u^{\beta}+\nabla_{x} \tilde{p}^{\beta}-\eta_{0} \Delta_{x} u^{\beta}=0 \text { in }[0, T] \times \mathbb{T}^{2}, \\
\nabla_{x} \cdot \tilde{u}^{\beta}=0 \text { in }[0, T] \times \mathbb{T}^{2},  \tag{1.10}\\
\tilde{u}^{\beta}(0, x)=\tilde{u}_{0}(x) \text { in } \mathbb{T}^{2} .
\end{array}
$$

Here $\eta_{0}$ is given by Lemma 11 .
1.2. Biot-Savart law in a periodic domain. In this part, we discuss the asymptotic form of kernel for Biot-Savart law which gives $u$ from $\omega$, and the singular integral which gives $\nabla_{x} u$ from $\omega$ in our setting, the periodic domain $\mathbb{T}^{2}=\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}$. This is important, since the compactness results we have used, in particular [8], have the $\mathbb{R}^{N}$ setting: in particular, the key estimate, weak $L^{1}$ estimate for $\nabla_{x} u$ relies on the form of Calderon-Zygmund kernel of Riesz transform. Therefore, we need an asymptotic form of Biot-Savart kernels and Riesz transforms.

We start from [12]:
Proposition 3 ([12], Lemma 1). The function $G$, defined on $\mathbb{R}^{2} \simeq \mathbb{C}$ by

\begin{align*}
G(z) & :=\operatorname{Im}\left(\frac{|z|^{2}-z^{2}}{-4 i}-\frac{z}{2}+\frac{i}{12}\right) \\
& -\frac{1}{2 \pi} \log \left|(1-e(z)) \times \prod_{n=1}^{\infty}(1-e(n i+z))(1-e(n i-z))\right|, \tag{1.11}
\end{align*}
$$

where $e(z)=e^{2 \pi i z}$, is $\mathbb{Z}^{2}$-periodic and is the Green's function with mass on $\mathbb{Z}^{2}$, that is,

$$
\begin{equation*}
-\Delta_{x} G(x)=\sum_{\zeta \in \mathbb{Z}^{2}} \delta(x-\zeta)-1 \text { for } x \in \mathbb{R}^{2}, \quad \int G(x) d x=0 \tag{1.12}
\end{equation*}
$$

In particular, the infinite product inside converges absolutely and $G$ is of the form

$$
\begin{equation*}
G(z)=\frac{|z|^{2}}{4}-\frac{1}{2 \pi} \log |\mathfrak{h}(z)|, \tag{1.13}
\end{equation*}
$$

where $\mathfrak{h}$ is a holomorphic function with simple zeros exactly on $\mathbb{Z}^{2}$.
For the sake of completeness, we briefly reason (1.13). We recall the following result from complex analysis:

Proposition 4 (Theorem 15.5 of [41). Suppose that $\left\{g_{n}\right\}$ is a sequence of non-zero holomorphic functions on $\mathbb{C}$ such that

\begin{equation*}
\sum_{n=1}^{\infty}\left|1-g_{n}(z)\right| \tag{1.14}
\end{equation*}
$$

converges uniformly on compact subsets of $\mathbb{C}$. Then the product

$$
\begin{equation*}
g(z)=\prod_{n=1}^{\infty} g_{n}(z) \tag{1.15}
\end{equation*}
$$

converges uniformly on compact subsets of $\mathbb{C}$, and thus $g$ is holomorphic on $\mathbb{C}$. Furthermore, the multiplicity of $g$ at $z_{0}$ (i.e. the smallest nonnegative integer $k$ such that $\lim _{z \rightarrow z_{0}} \frac{g(z)}{\left(z-z_{0}\right)^{k}} \neq$ $0)$ is the sum of multiplicities of $g_{n}$ at $z_{0}$.

Now we see that $\mathfrak{h}(z)$ is the product of $1-e(z)=1-e^{2 \pi i z}, 1-e(n i+z)=1-e^{-2 \pi n+2 \pi i z}$, and $1-e(n i-z)=1-e^{-2 \pi n-2 \pi i z}$. Note that $|1-(1-e(n i+z))|=|1-(1-e(n i-z))|=e^{-2 \pi n}$ so the premise of the proposiiton is satisfied. Thus $\mathfrak{h}(z)$ is holomorphic. Furthermore, the zeros of $\mathfrak{h}$ is exactly the union of zeros of $1-e(z)$, which is $\{m i \mid m \in \mathbb{Z}\}$, zeros of $1-e(n i+z)$, which is $\{m-n i \mid m \in \mathbb{Z}\}$, and zeros of $1-e(n i-z)$, which is $\{m+n i \mid m \in \mathbb{Z}\}$, for each integer $n \geq 1$. The union os exactly $\mathbb{Z}^{2}$. Moreover, the multiplicity of each point in $\mathbb{Z}^{2}$ is 1 , in other words, all roots are simple.

Thus, on $\mathbb{R}^{2} \backslash \mathbb{Z}^{2}, G$ is infinitely differentiable. Furthermore, let $\zeta \in \mathbb{Z}^{2}$. Then there exists a $\mathfrak{r}_{\zeta}>0$ such that

$$
\begin{equation*}
\mathfrak{h}(z)=(z-\zeta) \mathfrak{H}(z), \tag{1.16}
\end{equation*}
$$

where $\mathfrak{H}(z)=\frac{\mathfrak{h}(z)}{z-\zeta}$ is an holomorphic function on $B_{\mathfrak{r}_{\zeta}}(\zeta)$ and $\inf _{z \in B_{\mathfrak{r}_{\zeta}}(\zeta)}|\mathfrak{H}(z)| \geq c_{\zeta}>0$. Therefore, we can rewrite (1.13) in the following form and differentiate: for $z \in B_{\mathfrak{r}_{\zeta}}(\zeta)$,

$$
\begin{align*}
G(z) & =-\frac{1}{2 \pi} \log |z-\zeta|+\mathfrak{B}_{\zeta}(z), \\
\nabla G(z) & =-\frac{1}{2 \pi} \frac{z-\zeta}{|z-\zeta|^{2}}+\nabla \mathfrak{B}_{\zeta}(z),  \tag{1.17}\\
\nabla^{2} G(z) & =\frac{1}{4 \pi} \frac{(z-\zeta) \otimes(z-\zeta)-\frac{1}{2}|z-\zeta|^{2} \mathbb{I}_{2}}{|z-\zeta|^{4}}+\nabla^{2} \mathfrak{B}_{\zeta}(z),
\end{align*}
$$

where $z=x+i y$ is identified with $(x, y), \nabla=\left(\partial_{x}, \partial_{y}\right)$, and

$$
\begin{equation*}
\mathfrak{B}_{\zeta}(z)=\frac{|z|^{2}}{4}-\frac{1}{2 \pi} \log |\mathfrak{H}(z)| \tag{1.18}
\end{equation*}
$$

is a smooth function (in $x, y$ ) whose all derivatives are bounded. In particular, taking $\zeta=$ $0=(0,0)$ and taking $\mathfrak{r}=\mathfrak{r}_{0}$, we have the following:
Proposition 5. Let $G$ be defined by (1.11), so that the solution to Poisson equation $-\Delta_{x} q=$ $h-\int_{\mathbb{T}^{2}} h$ is given by $q=G * h$, and the Biot-Savart law by

$$
\begin{equation*}
u(x)=\mathbf{b} * w=\left(\frac{1}{2 \pi} \frac{x^{\perp}}{|x|^{2}}+\nabla_{x}^{\perp} \mathfrak{B}\right) * \omega . \tag{1.19}
\end{equation*}
$$

Then there exists a $\mathfrak{r}>0$ such that $G, \nabla_{x} G, \nabla_{x}^{2} G$ are smooth and bounded in $\mathbb{T}^{2} \backslash B_{\mathfrak{r}}(0)=$ $\left[-\frac{1}{2}, \frac{1}{2}\right]^{2} \backslash B_{\mathfrak{r}}(0)$ and in $B_{\mathfrak{r}}(0)$ we have

$$
\begin{align*}
G(x) & =-\frac{1}{2 \pi} \log |x|+\mathfrak{B}(x), x \in B_{\mathfrak{r}}(0), \\
\nabla_{x} G(x) & =-\frac{1}{2 \pi} \frac{x}{|x|^{2}}+\nabla_{x} \mathfrak{B}(x), x \in B_{\mathfrak{r}}(0),  \tag{1.20}\\
\nabla_{x}^{2} G(x) & =\frac{1}{4 \pi} \frac{x \otimes x-\frac{1}{2}|x|^{2} \mathbb{I}_{2}}{|x|^{4}}+\nabla_{x}^{2} \mathfrak{B}(x), x \in B_{\mathfrak{r}}(0),
\end{align*}
$$

where $\nabla_{x}^{k} \mathfrak{B}$ are bounded in $B_{\mathfrak{r}}(0)$ for all $k \geq 0$.
1.3. Higher Regularity of the Approximations $\left(u^{\beta}, \omega^{\beta}\right)$. In this section we establish the regularity estimate of $\left(u^{\beta}, \omega^{\beta}\right)$ solving (1.9) and (1.4)-(1.6) and $\left(\tilde{u}^{\beta}, \tilde{p}^{\beta}\right)$ solving (1.10).

First we prove that, for $1 \leq r, p \leq \infty$,

\left\|\nabla^{k} \omega_{0}^{\beta}\right\|_{L^{r}\left(\mathbb{T}^{2}\right)} & \lesssim \beta^{-k-2\left(\frac{1}{p}-\frac{1}{r}\right)_{+}}\left\|\omega_{0}\right\|_{L^{p}} . \tag{1.22}
\end{align*}
$$

From the Young's inequality, for $1+1 / r=1 / p+1 / q$ and $r, p, q \in[1, \infty]$,

$$
\begin{gathered}
\left\|\omega_{0}^{\beta}\right\|_{L^{r}\left(\mathbb{T}^{2}\right)} \leq\left\|\varphi^{\beta}\right\|_{L^{q}\left(\mathbb{T}^{2}\right)}\left\|\omega_{0}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \lesssim \beta^{-2\left(\frac{1}{p}-\frac{1}{r}\right)}\left\|\omega_{0}\right\|_{L^{p}} \text { for } r \geq p, \\
\left\|\nabla^{k} \omega_{0}^{\beta}\right\|_{L^{r}\left(\mathbb{T}^{2}\right)} \leq\left\|\nabla^{k} \varphi^{\beta}\right\|_{L^{q}\left(\mathbb{T}^{2}\right)}\left\|\omega_{0}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \leq \beta^{-k-2\left(\frac{1}{p}-\frac{1}{r}\right)}\left\|\omega_{0}\right\|_{L^{p}} \text { for } r \geq p .
\end{gathered}
$$

For both, we have used

$$
\left(\int_{\mathbb{T}^{2}}\left|\nabla_{x}^{k} \varphi^{\beta}\right|^{q} \mathrm{~d} x\right)^{1 / q}=\left(\frac{\beta^{2}}{\beta^{q(2+k)}} \int_{\mathbb{T}^{2}}\left|\nabla^{k} \varphi\left(\frac{x}{\beta}\right)\right|^{q} \mathrm{~d} \frac{x_{1}}{\beta} \mathrm{~d} \frac{x_{2}}{\beta}\right)^{1 / q}=\beta^{-k-\frac{2(q-1)}{q}}\left\|\nabla^{k} \varphi\right\|_{L^{q}\left(\mathbb{T}^{2}\right)}
$$

Using $\left|\mathbb{T}^{2}\right|=1$, we have

$$
\begin{aligned}
\left\|\omega_{0}^{\beta}\right\|_{L^{r}\left(\mathbb{T}^{2}\right)} & \leq\left\|\omega_{0}^{\beta}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \lesssim\left\|\omega_{0}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \text { for } p \geq r \\
\left\|\nabla^{k} \omega_{0}^{\beta}\right\|_{L^{r}\left(\mathbb{T}^{2}\right)} & \leq\left\|\nabla^{k} \omega_{0}^{\beta}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \lesssim \beta^{-k}\left\|\omega_{0}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \text { for } p \geq r .
\end{aligned}
$$

Collecting the bounds, we conclude (1.21) and (1.22)
1.3.1. Bounds for $\left\|\nabla_{x} u^{\beta}(t)\right\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}$.

Theorem 6. Let $\left(u^{\beta}, \omega^{\beta}\right)$ be the Lagrangian solution of (1.7) supplemented with (1.8) and (1.5). For $\mathfrak{p} \in[1, \infty]$ and $\beta \ll\left\|\omega_{0}\right\|_{L^{\mathfrak{p}}}$, we have the following estimate for all $t \geq 0$,

$$
\begin{equation*}

& -\int_{\mathbb{R}^{3}} \int_{\mathbb{S}^{2}}\left|\left(v-v_{*}\right) \cdot \omega\right| \partial^{s}\left(\sqrt{\mu\left(v_{*}\right)}\right)\left(f(v) g\left(v_{*}\right)+g(v) f\left(v_{*}\right)\right) \mathrm{d} \omega \mathrm{~d} v_{*} .
\end{align*}
$$

We list standard results which will be used later in this section for the sake of readers' convenience. First we note that

& \left|\int \Gamma(f, g) h \mathrm{~d} v \mathrm{~d} x \mathrm{~d} t\right| \\
& \lesssim \int\left[\left(\|\mathbf{P} f\|_{L_{v}^{2}}+\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) f\right\|_{L_{v}^{2}}\right)\|g\|_{L_{v}^{2}}\right. \\
& \left.+\left(\|\mathbf{P} g\|_{L_{v}^{2}}+\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) g\right\|_{L_{v}^{2}}\right)\|f\|_{L_{v}^{2}}\right]\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) h\right\|_{L_{v}^{2}} \mathrm{~d} x \mathrm{~d} t, \\
& \left|\int \partial^{s} \Gamma(f, g) h \mathrm{~d} v \mathrm{~d} x \mathrm{~d} t\right|  \tag{2.11}\\
& \lesssim \varepsilon\left\|\partial^{s} u\right\|_{L_{t, x}^{\infty}} \int\left[\left(\|\mathbf{P} f\|_{L_{v}^{2}}+\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) f\right\|_{L_{v}^{2}}\right)\|g\|_{L_{v}^{2}}\right. \\
& \left.+\left(\|\mathbf{P} g\|_{L_{v}^{2}}+\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) g\right\|_{L_{v}^{2}}\right)\|f\|_{L_{v}^{2}}\right] \\
& \times\left(\|\mathbf{P} h\|_{L_{v}^{2}}+\left\|\nu^{\frac{1}{2}}(\mathbf{I}-\mathbf{P}) h\right\|_{L_{v}^{2}}\right) \mathrm{d} x \mathrm{~d} t .

Next, we introduce a lemma illustrating the structure of higher derivatives of $L f$. Recall the notation $\llbracket \cdot, \rrbracket$ for the commutator (0.28).
Lemma 6. For $s \geq 1, \llbracket \partial^{s}, L \rrbracket f$ is a linear combination, whose coefficient depends only on $s$, of the terms having one of the following forms:
(1) ${ }_{\partial j} L(\mathbf{I}-\mathbf{P}) \partial^{s-j} f$, where $1 \leq j \leq s$,
(2) $L \partial \cdots \llbracket \mathbf{P}, \partial \rrbracket \cdots \partial f$, where $\partial \cdots \llbracket \mathbf{P}, \partial \rrbracket \cdots \partial f$ is an application of $s-1 \partial$ and one $\llbracket \mathbf{P}, \partial \rrbracket$ at $j$-th order to $f(0 \leq j \leq s)$, or
(3) ${ }_{\partial j} L \partial \cdots \llbracket \mathbf{P}, \partial \rrbracket \cdots \partial f$, where $1 \leq j \leq s-1$, and $\partial \cdots \llbracket \mathbf{P}, \partial \rrbracket \cdots \partial f$ is an application of $s-j-1 \partial$ and one $\llbracket \mathbf{P}, \partial \rrbracket$ at $i$-th order to $f(0 \leq i \leq s-j)$.

Proof. We proceed by the induction on $s$ : first we note that

which proves the claim for $s=1$. Next, for $s \geq 1$, we have

& +{ }_{{ }_{j}} L(\mathbf{I}-\mathbf{P}) \partial^{s-j+1} f,
\end{aligned}

which proves the claim.
Also, we have the following straightforward estimate for $\llbracket \mathbf{P}, \partial \rrbracket f$ :

Next, we introduce anisotropic spaces: this will be key to our analysis. For $p \in[1, \infty]$, we recall the space $L^{p}\left(\mathbb{T}^{2} ; L^{2}\left(\mathbb{R}^{3}\right)\right)$ by the norm $\|f\|_{L^{p}\left(\mathbb{T}^{2} ; L^{2}\left(\mathbb{R}^{3}\right)\right)}$ in (0.30). For $p, q \in[1, \infty]$, $L^{q}\left([0, T] ; L^{p}\left(\mathbb{T}^{2} ; L^{2}\left(\mathbb{R}^{3}\right)\right)\right)$ is defined similarly. We have the following anisotropic interpolations:

Lemma 8. We have the following:
(1) (Anisotropic Ladyzhenskaya) $\|f\|_{L_{x}^{4} L_{v}^{2}} \lesssim\|f\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}}\|\partial f\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}}$, and
(2) (Anisotropic Agmon) $\|f\|_{L_{x}^{\infty} L_{v}^{2}} \lesssim\|f\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}}\left\|\partial^{2} f\right\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}}$.

Proof. We only prove the former: the latter is derived in a similar manner.

\|f\|_{L_{x}^{4} L_{v}^{2}} & =\left(\int_{\mathbb{T}^{2}}\left(\int_{\mathbb{R}^{3}}|f(x, v)|^{2} \mathrm{~d} v\right)^{\frac{4}{2}} \mathrm{~d} x\right)^{\frac{1}{2 \cdot 2}} \leq\left(\int_{\mathbb{R}^{3}}\left(\int_{\mathbb{T}^{2}}|f(x, v)|^{4} \mathrm{~d} x\right)^{\frac{1}{2}} \mathrm{~d} v\right)^{\frac{1}{2}} \\
& =\left(\int_{\mathbb{R}^{3}}\|f(\cdot, v)\|_{L_{x}^{4}}^{2} \mathrm{~d} v\right)^{\frac{1}{2}} \lesssim\left(\int_{\mathbb{R}^{3}}\|f(\cdot, v)\|_{L_{x}^{2}}\|\partial f(\cdot, v)\|_{L_{x}^{2}} \mathrm{~d} v\right)^{\frac{1}{2}} \\
& \leq\left(\int_{\mathbb{R}^{3}} \int_{\mathbb{T}^{2}}|f(x, v)|^{2} \mathrm{~d} x \mathrm{~d} v\right)^{\frac{1}{2 \cdot 2}}\left(\int_{\mathbb{R}^{3}} \int_{\mathbb{T}^{2}}|\partial f(x, v)|^{2} \mathrm{~d} x \mathrm{~d} v\right)^{\frac{1}{2 \cdot 2}} \\
& =\|f\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}}\|\partial f\|_{L_{x}^{2} L_{v}^{2}}^{\frac{1}{2}} .

where we applied Minkowski for the first, usual Ladyzhenskaya for the second, and Holder for the last inequalities.

Lemma 10 ([11, 31]). $\left.L\right|_{\mathcal{N}^{\perp}}: \mathcal{N}^{\perp} \rightarrow \mathcal{N}^{\perp}$ is a bijection, and thus $L^{-1}: \mathcal{N}^{\perp} \rightarrow \mathcal{N}^{\perp}$ is well-defined. Also, $L^{-1}$ is symmetric under any orthonormal transformation. In particular, if $f \in \mathcal{N}^{\perp}$ is an even (resp. odd) function, then so is $L^{-1} f$.

Proof. The proof follows the Fredholm alternative and rotational invariance of $Q$. We refer to [11, 31] for the proof.

The term $\left(v-\varepsilon u^{\beta}\right) \otimes\left(v-\varepsilon u^{\beta}\right) \sqrt{\mu}$ and its image over $L^{-1}$ turns out to play an important role in Hilbert expansion. Note that

Thus, we define $\mathfrak{A}:=\mathfrak{A}(t, x) \in \mathbb{M}_{3 \times 3}(\mathbb{R})$ by (see [5])

& +\sum_{s^{\prime}<s}\left(\partial^{s^{\prime}} f\right) \frac{1}{2} \sum_{i, j}\left(\partial^{s-s^{\prime}} \partial_{x_{i}} u_{j}^{\beta}\right) \varphi_{i} \varphi_{j}+R,
\end{align*}
$$

where $|R| \lesssim \varepsilon V(\beta) \nu(v) \sum_{s^{\prime}<s}\left|\partial^{s^{\prime}} f\right|$.
Proof. It suffices to notice that

and that the first two terms of the right-hand side of (2.14) correspond to the terms where all $\partial$ are applied to either $f$ or $\partial_{x_{i}} u_{j}^{\beta}$, and $R$ are all others.

Next, we present pointwise estimates on $A$ and its derivatives ([35])
Lemma 14 (Lemma 3 of [35]). Suppose that (2.3) holds. For $\varrho \in(0,1 / 4)$,

\end{aligned}

Next, we have the following pointwise estimates on $\Gamma$ and $L$ :
Lemma 15 (Lemma 4 of [35). Suppose that $\varepsilon\left|u^{\beta}(x, t)\right| \lesssim 1$. For $0<\varrho<1 / 4, C \in \mathbb{R}^{3}$ and $s \leq 2$, we have

\left|\partial^{s} L f(v)\right| & \lesssim \varepsilon V(\beta)\left\|e^{\varrho|v|^{2}+C \cdot v} f(v)\right\|_{L_{v}^{\infty}} \frac{\nu(v)^{2}}{e^{\varrho|v|^{2}+C \cdot v}} .

Here we can choose the constant for the bound uniformly for $\{|C| \leq 1\}$.
Finally, we present pointwise estimates regarding projections $\mathbf{P}$ and $\mathbf{I}-\mathbf{P}$.

2.4. Scaled $L^{\infty}$-estimate. In this section, we prove a pointwise estimate (with a weight (2.43)) of an $L^{p}$ solution of the linear Boltzmann equation with a force term. We consider the following transport equation with (2.40) term:

Inspired by this, we introduce a suitable weight function, which is appropriate for periodic domain. Unlike the whole Euclidean space, existence of such $Z(x)$ in $\mathbb{T}^{2}$ is less obvious: in fact, if $Z=\left(Z_{1}, Z_{2}\right)$ is smooth, then since $\int_{\mathbb{T}^{1}} \partial_{1} Z_{1}\left(x_{1}, x_{2}\right) d x_{1}=0, \partial_{1} Z_{1}$ will have a mixed sign along the circle $\mathbb{T}^{1} \times\left\{x_{2}\right\}$ for each $x_{2} \in \mathbb{T}^{1}$, unless being 0 over whole circle. Thus, $\nabla_{x} Z+\left(\nabla_{x} Z\right)^{T}$ is neither positive definite nor negative definite over whole domain $\mathbb{T}^{2}$.

To overcome this difficulty, we introduce a weight function which cancels the most problematic term of (2.40) instead of controlling it: we introduce

2.5. Remainder Estimate. To admit far-from-equilibrium initial data, we need to keep the characteristic size of remainder as large as possible. A heuristic calculation suggests that the size $o(\varepsilon \kappa)$ for the remainder is the threshold: if the remainder becomes of the size $O(\varepsilon \kappa)$, we lose the control for nonlinearity of the remainder equation. Thus, we aim to keep our characteristic size of remainder to be slightly smaller than $\varepsilon \kappa$.

There is only a very slight room for this: the only possible gain is the coercivity of the linearized Boltzmann operator $L$. However, many conventional techniques (averaging lemma, $L^{\infty}$-estimates) do not rely on it; up to the authors' knowledge the coercivity of $L$ is exploited only in $L_{v}^{2}$ estimates. If we rely on other techniques in too early stage, we enormously lose the scale and fail to achieve the goal.

As a consequence, we need to push the $L_{v}^{2}$ estimates as far as possible. The important observation made in [29] is that even for nonlinear term, we have control by $L^{2}$-in- $v$ integral of remainders, since nonlinear term is also expressed in terms of an integral with nicely decaying kernel: what lacks is $L^{2}$ integrability in $x$. This observation naturally leads us to pursue $L_{v}^{2}$-estimate for derivatives of remainder and then rely on interpolation - $H_{x}^{2}$, but $L_{v}^{2}$ estimate.

It turns out that this idea gives a sharper scaling than many conventional techniques: the commutator $\llbracket \partial^{s}, L \rrbracket$ between spatial derivatives and $L$ forces us to lose $\sqrt{\kappa}$ scale for each derivative, but we do not lose scale in nonlinearity for 2 -dimensional domain. Thus, by setting initial data decaying to 0 in arbitrary slow rate as $\varepsilon \rightarrow 0$, we can keep $L_{x}^{2} L_{v}^{2}$ norms of remainder and its derivatives small, provided that the source terms are also small, which is the main point of the next idea.

Furthermore, we note that $H_{x}^{2} L_{v}^{2}$ suits very well with our goal to see convergence in a stronger topology: as we can control up to second derivatives of remainder small, we can keep our Boltzmann solution close to the local Maxwellian $M_{1, \varepsilon u^{\beta}, 1}$. Its zeroth and first derivatives may converge - they correspond to the velocity and vorticity. Its second derivatives may blow in general, which represents the formation of singular object, e.g. interfaces.

Now we are ready to prove compactness of $f_{R}$ in a suitable topology, thereby proving convergence. For a fixed $T>0$ and $t \in(0, T)$, we use the following scaled energy and its dissipation:

## 3. Vorticity Convergence of the approximate solutions of Euler

3.1. Stability of regular Lagrangian flow when the vorticity is unbounded. To study the stability of the regular Lagrangian flow when the vorticities do not belong to $L^{\infty}$, we adopt the functional used in [2, 15, 8): for $\left(u^{\beta_{i}}, X^{\beta_{i}}\right)$ solving (1.8),

(3.5) & \left.\leq \frac{1}{\lambda} \int_{\mathbb{T}^{2}} \right\rvert\, u^{\beta_{1}}\left(s, X^{\beta_{2}}(s ; t, x)\right)-u^{\beta_{2}}\left(s, X^{\beta_{2}}(s ; t, x) \mid \mathrm{d} x\right.  \tag{3.8}\\
& \leq \frac{\mathfrak{C}^{3}}{\lambda}\left\|u^{\beta_{1}}(s, \cdot)-u^{\beta_{2}}(s, \cdot)\right\|_{L^{1}\left(\mathbb{T}^{2}\right)}
\end{align*}
$$

with common compressibility bound $\mathfrak{C}=1$. In the rest of the proof, we estimate (3.4).
Step 1. The case of $p>1$. Recall that the maximal function of $u$ is given by

\end{align*}

Now we bound (3.4) for $p>1$, using (3.10) and (3.11), as

(3.4) & \leq \int_{\mathbb{T}^{2}}\left\{M \nabla u^{\beta_{1}}\left(s, X^{\beta_{1}}(s ; t, x)\right)+M \nabla u^{\beta_{1}}\left(s, X^{\beta_{2}}(s ; t, x)\right)\right\} \mathrm{d} x  \tag{3.12}\\
& \lesssim\left\|\nabla u^{\beta_{1}}\right\|_{L^{p}\left(\mathbb{T}^{2}\right)} \text { for } p \in(1, \infty] .
\end{align*}
$$

Using the above (3.12), (3.8), together with (3.3), we derive that

\begin{align*}
\Lambda(s ; t) & \lesssim\left\|\nabla u^{\beta_{1}}\right\|_{L^{1}\left((0, T) ; L^{p}\left(\mathbb{T}^{2}\right)\right)} \\
& +\frac{1}{\lambda}\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)} \text { for all }(s, t) \in[0, t] \times[0, T] . \tag{3.13}
\end{align*}
$$

On the other hand, for any $(s, t) \in[0, t] \times[0, T]$

$$
\begin{equation*}
\mathbf{1}_{\left|X^{\beta_{1}}(s ; t, x)-X^{\beta_{2}}(s ; t, x)\right| \geq \gamma} \log \left(1+\frac{\left|X^{\beta_{1}}(s ; t, x)-X^{\beta_{2}}(s ; t, x)\right|}{\lambda}\right) \geq \log \left(1+\frac{\gamma}{\lambda}\right) . \tag{3.14}
\end{equation*}
$$

Then (3.14) with $\gamma=\sqrt{\lambda}$, together with the definition (3.1), implies that

\mathscr{L}^{2}\left(\left\{x \in \mathbb{T}^{2}:\left|X^{\beta_{1}}(s ; t, x)-X^{\beta_{2}}(s ; t, x)\right| \geq \sqrt{\lambda}\right\}\right) \leq \frac{1}{|\log \sqrt{\lambda}|} \Lambda(s ; t) \tag{3.15}
\end{equation*}
$$

Therefore, by applying (3.13) to (3.15), together with $\mathscr{L}^{2}\left(\mathbb{T}^{2}\right)=1$ and $|x-y| \leq \sqrt{2}$ for $x, y \in \mathbb{T}^{2}$, we establish the stability:

& =\int_{\left|X^{\beta_{1}}(s ; t, \cdot)-X^{\beta_{2}}(s ; t,)\right| \leq \sqrt{\lambda}}+\int_{\mid X^{\beta_{1}(s ; t,)-X^{\beta_{2}}(s ; t,) \mid \geq \sqrt{\lambda}}} \\
& \leq \sqrt{\lambda}+\frac{\sqrt{2}}{|\log \sqrt{\lambda}|} \Lambda(s ; t) \\
& \lesssim \sqrt{\lambda}+\frac{1}{|\log \sqrt{\lambda}|}\left\{\left\|\nabla u^{\beta_{1}}\right\|_{L^{1}\left((0, T) ; L^{p}\left(\mathbb{T}^{2}\right)\right)}+\frac{1}{\lambda}\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}\right\} .
\end{aligned}
$$

Choosing

$$
\begin{equation*}
\lambda=\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)} \tag{3.16}
\end{equation*}
$$

we have that

$$
\begin{align*}
& \left\|X^{\beta_{1}}(s ; t, \cdot)-X^{\beta_{2}}(s ; t, \cdot)\right\|_{L^{1}\left(\mathbb{T}^{2}\right)} \\
& \lesssim\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}^{1 / 2}+\frac{\left\|\nabla u^{\beta_{1}}\right\|_{L^{1}\left((0, T) ; L^{p}\left(\mathbb{T}^{2}\right)\right)}}{\mid \log \left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}} . \tag{3.17}
\end{align*}
$$

For $\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)} \ll 1$, we prove (3.6).
Step 2. The case of $p=1$. Note that $p=1$ fails (3.11), but $\|M u\|_{L^{1, \infty}\left(\mathbb{T}^{2}\right)} \lesssim\|u\|_{L^{1}\left(\mathbb{T}^{2}\right)}$ only holds instead of (3.11). Here, we recall the quasi-norm of the Lorentz space $L^{p, q}$ :

\|u\|_{L^{p, \infty}\left(\mathbb{T}^{2}\right)}^{p} & =\|u\|_{L^{p, \infty}\left(\mathbb{T}^{2}, \mathscr{L}^{2}\right)}^{p}=\sup _{\lambda>0}\left\{\lambda^{p} \mathscr{L}^{2}\left(\left\{x \in \mathbb{T}^{2}:|u(x)|>\lambda\right\}\right)\right\} . \tag{3.18}
\end{align*}
$$

For $p=1$, there exists a map $\tilde{M}$, defined as in Definition 3.1 of 8 with choice of functions in Proposition 4.2 of [8] such that (Theorem 3.3 of [8]),

\tilde{M}: \omega \mapsto \tilde{M} \nabla\left(\nabla^{\perp}(\Delta)^{-1} \omega\right) \geq 0 \text { is bounded in } L^{2}\left(\mathbb{T}^{2}\right) \rightarrow L^{2}\left(\mathbb{T}^{2}\right) \text { and } L^{1}\left(\mathbb{T}^{2}\right) \rightarrow L^{1, \infty}\left(\mathbb{T}^{2}\right) \tag{3.19}
\end{equation*}

Note that if $(u, \omega)$ satisfying (0.12) in the sense of distributions then $\tilde{M} \nabla(B * \omega)=\tilde{M} \nabla u$. The argument follows the line of [8], with translation to the periodic domain by Proposition 5.

Proposition 14. There exists an operator $\omega \rightarrow U(\omega)$, which will be denoted by $\tilde{M} \nabla u$, defined either on $L^{1}\left(\mathbb{T}^{2}\right)$ or $L^{2}\left(\mathbb{T}^{2}\right)$, satisfying

& \|U(\omega)\|_{L^{1, \infty}\left(\mathbb{T}^{2}\right)} \lesssim\|\omega\|_{L^{1}\left(\mathbb{T}^{2}\right)}, \\
& \|U(\omega)\|_{L^{2}\left(\mathbb{T}^{2}\right)} \lesssim\|\omega\|_{L^{2}\left(\mathbb{T}^{2}\right)} .
\end{aligned}
$$

Also, if $\omega \in L^{1}\left(\mathbb{T}^{2}\right)$, and $u=B * \omega$, then there is a Lebesgue measure 0 set $\mathcal{N}$ such that

|u(x)-u(y)| \leq|x-y|(U(x)+U(y)), x, y \in \mathbb{T}^{2} \backslash \mathcal{N} .

Proof. We first identify $x \in \mathbb{T}^{2}$ with $x \in\left[-\frac{1}{2}, \frac{1}{2}\right]^{2} \subset \mathbb{R}^{2}$, denote $K(y):=\nabla_{y}^{2} G(y) \chi_{\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}}(y), y \in$ $\mathbb{R}^{2}$, and define

K_{0}(y)=\frac{1}{4 \pi} \frac{y \otimes y-\frac{1}{2}|y|^{2} \mathbb{I}_{2}}{|y|^{4}}, y \in \mathbb{R}^{2}
$$

Also, we regard $\omega$ and $u$ as a $\mathbb{Z}^{2}$-periodic function in $\mathbb{R}^{2}: \omega(x+m)=\omega(x), u(x+m)=u(x)$ for $m \in \mathbb{Z}^{2}$. Now, for $x \in\left[-\frac{5}{2}, \frac{5}{2}\right]^{2} \subset \mathbb{R}^{2}, \int_{\mathbb{R}^{2}} K(y) \omega(x-y) d y$ is well-defined as it is exactly $\left(\nabla^{2} G *_{\mathbb{T}^{2}} \omega\right)(x-m)$ for some $m \in \mathbb{Z}^{2}$ so that $x-m \in\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}$. Then we see that $D(x)$ defined by

$$
\begin{aligned}
D(x) & :=\int_{\mathbb{R}^{2}} K(y) \omega(x-y)-K_{0}(y) \omega(x-y) \chi_{B_{100}(0)}(x-y) d y \\
& =\int_{\mathbb{R}^{2}}\left(K(y) \chi_{\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}}(y)-K_{0}(y) \chi_{B_{100}(x)}(y)\right) \omega(x-y) d y
\end{aligned}
$$

for $x \in\left[-\frac{5}{2}, \frac{5}{2}\right]$, and $D(x):=0$ for $x \notin\left[-\frac{5}{2}, \frac{5}{2}\right]$ is bounded. First, since $B_{\mathfrak{r}}(0) \subset B_{100}(x) \cap$ $\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}$ and thus $\left(K(y) \chi_{\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}}(y)-K_{0}(y) \chi_{B_{100}(x)}(y)\right)$ is bounded for $y \in B_{\mathfrak{r}}(0)$. For $y \notin$ $B_{\mathfrak{r}}(0),\left(K(y) \chi_{\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}}(y)-K_{0}(y) \chi_{B_{100}(x)}(y)\right)$ is bounded as well. Finally, $\left(K(y) \chi_{\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}}(y)-\right.$ $\left.K_{0}(y) \chi_{B_{100}(x)}(y)\right)$ is supported on $B_{100}(x)$, thus we have

$$
|D(x)| \lesssim \int_{\mathbb{R}^{2}} \chi_{B_{100}(x)}(y)|\omega(x-y)| d y \lesssim C\|\omega\|_{L^{1}\left(\mathbb{T}^{2}\right)}
$$

Furthermore, this implies $|D| \leq C\|\omega\|_{L^{1}\left(\mathbb{T}^{2}\right)} \chi_{\left[-\frac{5}{2}, \frac{5}{2}\right]^{2}}$ so in fact $D \in L^{1}$ as well. Therefore, we have

\nabla_{x} u(x)=D(x)+K_{0} \star_{\mathbb{R}^{2}}\left(\omega \chi_{B_{100}(0)}\right)(x), x \in\left[-\frac{5}{2}, \frac{5}{2}\right]^{2} \tag{3.20}
\end{equation*}
$$

Next, we closely follow the argument of Proposition 4.2 of [8]. Let $\bar{h}$ be a smooth, nonnegative function, supported on $B_{\frac{1}{100}}(0)$ with $\int_{\mathbb{R}^{2}} \bar{h}(y) d y=1$. Also, we denote $\bar{h}_{r}(x)=\frac{1}{r^{2}} \bar{h}\left(\frac{x}{r}\right)$ for $x \in \mathbb{R}^{2}$ and $r>0$. Finally, for $\xi \in \mathbb{S}^{1}$ and $j=1,2$ we define

$$
\mathfrak{T}^{\xi, j}(w):=h\left(\frac{\xi}{2}-w\right) w_{j},
$$

and $\mathfrak{T}_{r}^{\xi, j}$ is similarly defined for $r>0$. Now let $x, y \in \mathbb{T}^{2}=\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}$. Then there exists $\tilde{y} \in\left[-\frac{3}{2}, \frac{3}{2}\right], \tilde{y}-y \in \mathbb{Z}^{2}$, such that the projection of line segment of $\tilde{y}$ and $x$ in $\mathbb{R}^{2}$ is the
geodesic connecting $x, y$ in $\mathbb{T}^{2}$. Then we have

\begin{aligned}
& u(x)-u(y)=u(x)-u(\tilde{y}) \\
& =\int_{\mathbb{R}^{2}} \bar{h}_{|x-\tilde{y}|}\left(z-\frac{x+\tilde{y}}{2}\right)(u(x)-u(z)) d z+\int_{\mathbb{R}^{2}} \bar{h}_{|x-\tilde{y}|}\left(z-\frac{x+\tilde{y}}{2}\right)(u(z)-u(y)) d z
\end{aligned}
$$

We focus on the first term: the other gives similar contribution. Following the argument of Proposition 4.2 of [8], we have

\int_{\mathbb{R}^{2}} \bar{h}_{|x-\tilde{y}|}\left(z-\frac{x+\tilde{y}}{2}\right)(u(x)-u(z)) d z=|x-\tilde{y}| \sum_{j=1}^{2} \int_{0}^{1} \int_{\mathbb{R}^{2}} \mathfrak{T}_{s|x-\tilde{y}|}^{\frac{x-y}{|x-y|}, j}(w)\left(\partial_{j} u\right)(x-w) d w d s
$$

Note that $\mathfrak{T}_{s|x-\tilde{y}|}^{\frac{x-\tilde{y}}{\mid x-\tilde{y}}, j}$ is supported on $B_{\frac{1}{100} s|x-\tilde{y}|}\left(\frac{x-y}{2|x-\tilde{y}|}\right)$, and $|x-\tilde{y}| \leq \frac{\sqrt{2}}{2}$, so if $w \in B_{\frac{1}{100} s|x-\tilde{y}|}\left(\frac{x-\tilde{y}}{2|x-\tilde{y}|}\right)$, $|w| \leq \frac{2}{3}$ and thus $x-w \in\left[-\frac{5}{2}, \frac{5}{2}\right]^{2}$, which implies that (3.20) is satisfied at $x-w$. (Similar consideration shows that at $\tilde{y}-w(3.20)$ is satisfied.) Therefore,

& +|x-\tilde{y}| \sum_{j=1}^{2} \int_{0}^{1}\left|\left(\tilde{T}_{s|x-\tilde{y}|}^{\frac{x-y}{\mid x-y}, j} \star_{\mathbb{R}^{2}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)\right)(x)\right| d s \\
& \leq|x-\tilde{y}| \sum_{j=1}^{2}\left(M_{\left\{\mathfrak{T}^{\xi, j} \mid \xi \in \mathbb{S}^{1}\right\}}(D)(x)+M_{\left\{\mathfrak{T}^{\xi}, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)(x)\right)
\end{aligned}
$$

where

$$
M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}(g)(x)=\sup _{\left\{\mathfrak{T}^{\xi, j} \mid \xi \in \mathbb{S}^{1}\right\}} \sup _{r>0}\left|\left(\mathfrak{T}_{r}^{\xi, j} \star_{\mathbb{R}^{2}} g\right)(x)\right|, x \in \mathbb{R}^{2}
$$

By Theorem 3.3 of [8], we have

$$
\left\|M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)\right\|_{L^{1, \infty}\left(\mathbb{R}^{2}\right)} \leq C\left\|\omega \chi_{B_{100}}\right\|_{L^{1}\left(\mathbb{R}^{2}\right)} \leq C\|\omega\|_{L^{1}\left(\mathbb{T}^{2}\right)}
$$

Also, by Young's inequality, we have

\left\|M_{\left\{\mathfrak{T}^{\xi}, j \mid \xi \in \mathbb{S}^{1}\right\}}(D)\right\|_{L^{1, \infty}\left(\mathbb{R}^{2}\right)} \leq\left\|M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}(D)\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)} \leq C\|D\|_{L^{\infty}\left(\mathbb{R}^{2}\right)} \leq C\|\omega\|_{L^{1}\left(\mathbb{T}^{2}\right)}
$$

Finally, for $x \in \mathbb{T}^{2}$ identified with $\left[\frac{-1}{2}, \frac{1}{2}\right]^{2}$, we define

U(x):=\sum_{\tilde{x} \in\left[-\frac{3}{2}, \frac{3}{2}\right], x-\tilde{x} \in \mathbb{Z}^{2}} \sum_{j=1}^{2}\left(M_{\left\{\mathfrak{T}^{\xi}, j \mid \xi \in \mathbb{S}^{1}\right\}}(D)(\tilde{x})+M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)(\tilde{x})\right)
$$

Then obviously for $x, y \in \mathbb{T}^{2}$

|u(x)-u(y)| \leq d_{\mathbb{T}^{2}}(x, y)(U(x)+U(y))
$$

and if $U(x)>\lambda$, then for $\tilde{x}_{1}, \cdots, \tilde{x}_{9} \in\left[-\frac{3}{2}, \frac{3}{2}\right]^{2}$ such that $\tilde{x}_{j}-x \in \mathbb{Z}^{2}$, at least one of $\tilde{x}_{i}$ satisfies

$$
\sum_{j=1}^{2}\left(M_{\left\{\mathfrak{T}^{\left.\xi, j \mid \xi \in \mathbb{S}^{1}\right\}}\right.}(D)\left(\tilde{x}_{i}\right)+M_{\left\{\mathfrak{T}^{\xi}, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)\left(\tilde{x}_{i}\right)\right)>\frac{\lambda}{9}
$$

and therefore

$$
\begin{aligned}
& \left\{\left.x \in\left[-\frac{1}{2}, \frac{1}{2}\right]^{2} \right\rvert\, U(x)>\lambda\right\} \\
& \subset \bigcup_{m=(a, b), a, b \in\{-1,0,1\}}\left\{y \in\left[-\frac{1}{2}, \frac{1}{2}\right]^{2}+m \left\lvert\, M_{\left\{\mathfrak{T}^{\xi, j} \mid \xi \in \mathbb{S}^{1}\right\}}(D)(y)+M_{\left\{\mathfrak{T}, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)(y)>\frac{\lambda}{9}\right.\right\} \\
& \subset\left\{y \in \mathbb{R}^{2} \left\lvert\, M_{\left\{\mathfrak{T}^{\xi, j} \mid \xi \in \mathbb{S}^{1}\right\}}(D)(y)+M_{\left\{\mathfrak{T}^{\xi, j} \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)(y)>\frac{\lambda}{9}\right.\right\} .
\end{aligned}
$$

Therefore, we see that

\|U\|_{L^{2}\left(\mathbb{T}^{2}\right)} & \leq C\left(\left\|M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}\left(K_{0} \star_{\mathbb{R}^{2}} \omega \chi_{B_{100}}\right)\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\left\|M_{\left\{\mathfrak{T} \xi, j \mid \xi \in \mathbb{S}^{1}\right\}}(D)\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right. \\
& \leq C\left(\left\|\omega \chi_{B_{100}}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\|D\|_{L^{2}\left(\mathbb{R}^{2}\right)} \leq C\|\omega\|_{L^{2}\left(\mathbb{T}^{2}\right)}\right.
\end{aligned}
$$

by again Theorem 3.3 of [8] and Young's inequality.
We return to the proof of (3.42). We have (Proposition 4.2 in [8])

### 3.2. Convergence of Velocity field $u^{\beta}$.

Lemma 18. Let $T>0$. Assume (1.5) holds and

Using $L^{1}\left(\mathbb{T}^{2}\right) \hookrightarrow$ $H^{s}\left(\mathbb{T}^{2}\right)$ for $s<-1$, an elliptic regularity says $L^{\infty}\left((0, T) ; H^{s-1}\left(\mathbb{T}^{2}\right)\right) \ni \operatorname{div}\left(u^{\beta} \otimes u^{\beta}\right) \mapsto \nabla p^{\beta} \in$ $L^{\infty}\left((0, T) ; H^{s-1}\left(\mathbb{T}^{2}\right)\right)$ uniformly-in- $\beta$. Therefore from $\partial_{t} u^{\beta}=-\operatorname{div}\left(u^{\beta} \otimes u^{\beta}\right)-\nabla p^{\beta}$ we derive that $\partial_{t} u^{\beta} \in L^{\infty}\left((0, T) ; H^{s-1}\right)$ uniformly-in- $\beta$ for any $s<-1$. Therefore we conclude that

Finally, we prove Lemma 18 using the Aubin-Lions lemma (3.30).
3.3. Rate of Convergence of $u^{\beta}$ : Localized Yudovich solutions. We use the following version of the theorem, presented in [16]. The theorem in [16] provided the modulus of continuity for $u$ which we will use, and explicitly stated that the unique solution is regular Lagrangian.

We begin with introducing localized Yudovich class of vorticity. Intuitively, the localized Yudovich class consists of vorticities with moderate growth of $L^{p}$ norm as $p \rightarrow \infty$. Existence and uniqueness results of Yudovich class of vorticity extends to localized Yudovich class. We refer to [16] and references therein for further details.

In this paper, we focus on the growth function with the following condition, which gives quantitative bounds on the behavior of velocity field $u$; it would be interesting to see if one
can generalize the presented results to arbitrary admissible growth functions. We assume that $\Theta: \mathbb{R}_{\geq 0} \rightarrow \mathbb{R}_{\geq 0}$ satisfies the following: there exists $m \in \mathbb{Z}_{>0}$ such that

Here, the function space $C_{b}^{0, \varphi \Theta}\left(\mathbb{T}^{2}, \mathbb{R}^{2}\right)$ is defined by

Also, $\|\omega\|_{L^{\infty}\left([0, T] ; Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)\right)}$ and $\|u\|_{C_{b}^{0, \varphi \Theta}\left(\mathbb{T}^{2}, \mathbb{R}^{2}\right)}$ depends only on $\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)}$ and $T$. The dependence is non-decreasing in both $\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)}$ and $T$.

In this subsection, we prove the following proposition:
Proposition 16. Let $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$. There exist constants $M$, depending only on $m$ and $\sup _{t \in[0, T]}\|u(t)\|_{L^{\infty}}$ (and therefore $\left\|\omega_{0}\right\|_{L^{3}}$ ) (and dimension $d=2$ ), and $C(C=2 e$ works), which is universal, such that

In particular, the case $m=0$ corresponds to the Yudovich class, with $\operatorname{Rate}(\beta)=\beta^{2 e^{-C\| \|_{0} \|_{Y_{\mathrm{ul}}}{ }^{T}} .}$.

\frac{d}{2 d t}\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2} \leq \int_{\mathbb{T}^{2}} v \cdot \nabla_{x} u \cdot v \mathrm{~d} x
$$

or

$$
\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2} \leq\|v(0)\|_{L^{2}\left(\mathbb{T}^{2}\right)}+2 \int_{0}^{t} \int_{\mathbb{T}^{2}}\left|\nabla_{x} u \| v\right|^{2} \mathrm{~d} x
$$

Next, we note that by Sobolev embedding

\|v\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}^{2} \leq 2\left(\|u\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}^{2}+\left\|u^{\beta}\right\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}^{2}\right) \leq 2 C\left\|\omega_{0}\right\|_{L^{3}\left(\mathbb{T}^{2}\right)}^{2}
$$

while energy conservation gives

\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2} \leq 2\left(\left\|u^{\beta}(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}+\|u(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}\right) \leq 4\left\|u_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2} .
$$

Therefore, there exists a constant $M$, explicitly given by

where we have used the conservation of $\|\omega\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}$ for every $1 \leq \mathfrak{p}<\infty$. We first treat the case of $m \geq 1$. By Hölder's inequality, for each $\epsilon \in\left(0, \frac{1}{e_{m-1}(1)}\right)\left(\frac{1}{e_{m-1}(1)} \leq 1\right)$ we have

& \leq M^{\epsilon}\left(\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}\right)^{1-\epsilon}\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\ominus}} \phi\left(\frac{1}{\epsilon}\right)=\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\Theta}}\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}\left(\frac{M}{\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)^{\epsilon} \phi\left(\frac{1}{\epsilon}\right) .
\end{aligned}
$$

Now choose

\epsilon^{*}=\frac{1}{\log \frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}} .}
$$

Then since $\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}>e_{m}(1), \log \left(\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}}\right)>\log \left(e_{m}(1)\right)=e_{m-1}(1)$ so $\epsilon^{*} \in\left(0, \frac{1}{e_{m-1}(1)}\right)$. There, we have

& \left(\frac{M}{\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)^{\epsilon^{*}} \phi\left(\frac{1}{\epsilon^{*}}\right) \\
& =e \log \left(\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right) \log \left(\log \left(\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)\right) \cdots \log _{m}\left(\log \left(\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)\right) \\
& =e \Theta\left(\frac{M}{\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right) .
\end{aligned}
$$

For $m=0$ (Yudovich case), $\epsilon \rightarrow\left(\frac{M}{\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)^{\epsilon} \phi\left(\frac{1}{\epsilon}\right)=\left(\frac{M}{\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)^{\epsilon} \frac{1}{\epsilon}$ attains its minimum at $\epsilon^{*}=\frac{1}{\log \left(\frac{M}{\|v\|_{L^{2}\left(\mathbb{T}^{2}\right)}}\right)}$, so we choose $M$ such that $\epsilon^{*}<1$.

Therefore, we have

$$

To sum up, we have

\|v(t)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2} \leq\left\|v_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}+\int_{0}^{t} 2 e\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\ominus}} \Psi\left(\|v(s)\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}\right) \mathrm{d} s,
$$

where

\Psi(r)=r \Theta\left(\frac{M}{r}\right) .
$$

Then by Osgood's lemma, we have

$$

where

\begin{aligned}
& \mathcal{M}(x)=\int_{x}^{a} \frac{\mathrm{~d} r}{\Psi(r)}=\int_{x}^{a} \frac{\mathrm{~d} r}{r \prod_{k=1}^{m} \log _{k}\left(\frac{M}{r}\right)} \\
& =\int_{\frac{M}{a}}^{\frac{M}{x}} \frac{\mathrm{~d} z}{z \prod_{k=1}^{m} \log _{k}(z)}=\int_{\log _{m}\left(\frac{M}{a}\right)}^{\log _{m}\left(\frac{M}{x}\right)} \frac{\mathrm{d} y}{y}=\log _{m+1}\left(\frac{M}{x}\right)-\log _{m+1}\left(\frac{M}{a}\right) .
\end{aligned}
$$

where $a=2\left\|u_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}$ and we have used the substitution $z=\frac{M}{r}$ for the third identity and $y=\log _{m}(z)$ with

for the forth identity. In particular, we have

& \geq \log _{m+1}\left(\frac{M}{\left\|v_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right)-C\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\ominus}} t=\log \left(\log _{m}\left(\frac{M}{\left\|v_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{2}}\right) e^{-C t\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\Theta}}}\right),
\end{aligned}
$$

and taking $e_{m+1}$ and reciprocal gives the desired conclusion. Certainly Rate $(\beta)$ is a continuous function of $\beta$, and it converges to 0 as $\beta \rightarrow 0$ as $\mathcal{M}(0)=\infty$.

### 3.4. Convergence of $\omega^{\beta}$.

Proposition 17. For any fixed $\mathfrak{p} \in[1, \infty]$, suppose $\omega_{0} \in L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)$. Recall the regularization of the initial data $\omega_{0}^{\beta}$ in (1.6). Let $\left(u^{\beta}, \omega^{\beta}\right)$ and $(u, \omega)$ be Lagrangian solutions of (1.4)-(1.5) and (0.11) -(0.12), respectively. For any $T>0$ and the subsequence $\left\{\beta^{\prime}\right\} \subset\{\beta\}$ in Lemma 18 , we have

& +\left|\omega_{0}^{\ell}(X(0 ; t, x))-\omega_{0}^{\ell}\left(X^{\beta^{\prime}}(0 ; t, x)\right)\right| \tag{3.37}
\end{align*}
$$

Using the compressibility (0.16), we derive that, for $\mathfrak{p} \in[1, \infty]$

For the last term, we need a stability of the Lagrangian flows:

& \leq\left\|\nabla \varphi^{\ell}\right\|_{L^{\infty}}\left\|\omega_{0}\right\|_{L^{1}}\left\|X(0 ; t, \cdot)-X^{\beta^{\prime}}(0 ; t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}  \tag{3.39}\\
& \leq \frac{1}{\ell^{3}}\|\nabla \varphi\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}\left\|\omega_{0}\right\|_{L^{1}}\left\|X(0 ; t, \cdot)-X^{\beta^{\prime}}(0 ; t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}
\end{align*}
$$

where we have used (1.22).
For $\mathfrak{p}>1$, we use (3.6) in Proposition 13 and Lemma 18 to have

(\underline{(3.39)}) \lesssim \frac{1}{\ell^{3}} \frac{1+\left\|\nabla u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)\right)}}{\left|\log \left\|u-u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}\right|} \tag{3.40}
\end{equation*}
$$

Now we choose

$$
\begin{equation*}
\ell=\ell\left(\beta^{\prime}\right) \sim\left|\log \left\|u-u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}\right|^{-\frac{1}{10}} \quad \text { for each } \beta^{\prime} \tag{3.41}
\end{equation*}
$$

such that

$$
\begin{array}{r}
\ell=\ell\left(\beta^{\prime}\right) \downarrow 0 \quad \text { as } \beta^{\prime} \downarrow 0 \\
\ell^{3}\left|\log \left\|u-u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}\right| \rightarrow \infty \quad \text { as } \beta^{\prime} \downarrow 0
\end{array}
$$

Therefore, for $\mathfrak{p}>1$, we prove (3.40) $\rightarrow 0$ as $\beta^{\prime} \downarrow 0$. Combining this with (3.38), we conclude (3.35) for $\mathfrak{p}>1$.

For $p=1$, there exists $C_{\varepsilon}>0$ for any $\varepsilon>0$ such that

& \leq \frac{e^{\frac{4 C_{\varepsilon}}{\varepsilon}}}{\frac{4 C_{\varepsilon}}{\varepsilon}} \frac{\left\|u^{\beta_{1}}-u^{\beta_{2}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}^{\gamma}+\varepsilon \text { for any } \gamma>0 .}{\gamma} . \tag{3.42}
\end{align*}
$$

For $\mathfrak{p}=1$, using (3.42), we have

& \leq \int_{\left|X(0 ; t, \cdot)-X^{\beta^{\prime}}(0 ; t, \cdot)\right| \leq \gamma}\left|X(0 ; t, x)-X^{\beta^{\prime}}(0 ; t, x)\right| \mathrm{d} x \\
&+\int_{\left|X(0 ; t, \cdot)-X^{\beta^{\prime}}(0 ; t, \cdot)\right| \geq \gamma}\left|X(0 ; t, x)-X^{\beta^{\prime}}(0 ; t, x)\right| \mathrm{d} x \\
& \leq \gamma+\frac{e^{\frac{4 C_{\varepsilon}}{\varepsilon}}}{\frac{4 C_{\varepsilon}}{\varepsilon}} \frac{\left\|u-u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}^{\gamma}+\varepsilon}{\gamma}
\end{aligned}
$$

and hence

((3.39)) \lesssim \frac{1}{\ell^{3}}\left\{\gamma+\frac{e^{\frac{4 C_{\varepsilon}}{\varepsilon}}}{\frac{4 C_{\varepsilon}}{\varepsilon}} \frac{\left\|u-u^{\beta^{\prime}}\right\|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)}}{\gamma}+\varepsilon\right\} . \tag{3.43}

For each $\varepsilon>0$, we choose $\gamma=\varepsilon$ and $\ell=\varepsilon^{\frac{1}{10}}$. And $\beta^{\prime} \gg_{\varepsilon} 1$ such that $\frac{\frac{4 C_{\varepsilon}}{\varepsilon}}{\frac{14 \varepsilon_{\varepsilon}}{\varepsilon}} \frac{1}{1 \frac{13}{10}} \| u-$ $u^{\beta^{\prime}} \|_{L^{1}\left((0, T) ; L^{1}\left(\mathbb{T}^{2}\right)\right)} \rightarrow 0$. Combining with (3.38), we conclude (3.35) for $\mathfrak{p}=1$.
3.4.1. When $\omega_{0}$ has no regularity. If $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$ and no additional regularity is assumed, one cannot expect a convergence rate which is uniform over $\omega_{0}$ : the rate crucially depends on how fast $\omega_{0}^{\beta}$ converges to $\omega_{0}$. Suppose that $\omega(t)$ is the Lagrangian solution with initial data $\omega_{0}$. Then we have

& +\left|\omega_{0}^{\ell}(X(0 ; t, x))-\omega_{0}^{\ell}\left(X^{\beta}(0 ; t, x)\right)\right|
\end{aligned}
$$

where $\omega_{0}^{\ell}$ is the initial data regularization of $\omega_{0}$ with parameter $\ell$. Therefore, by the compression property we have

& \left\|\omega(t)-\omega^{\beta}(t)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \leq \mathfrak{C}\left\|\omega_{0}-\omega_{0}^{\ell}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}^{\ell}-\omega_{0}^{\beta}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \\
& +\| \omega_{0}^{\ell}\left(X(0, t ; \cdot)-\omega_{0}^{\ell}\left(X^{\beta}(0 ; t, \cdot)\right) \|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} .\right.
\end{aligned}
$$

Using (3.39), we can estimate the first two terms:

\mathfrak{C}\left\|\omega_{0}-\omega_{0}^{\ell}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\left(\left\|\omega_{0}^{\ell}-\omega_{0}^{\beta}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \leq(\mathfrak{C}+1)\left\|\omega_{0}-\omega_{0}^{\ell}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}^{\beta}-\omega_{0}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} .\right.
$$

The last term is estimated by (3.39) and (3.40):

\left\|\omega_{0}^{\ell}(X(0, t ; \cdot))-\omega_{0}^{\ell}\left(X^{\beta}(0 ; t, \cdot)\right)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \leq \frac{C\left(1+\mathfrak{p}\left\|\omega_{0}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} t\right)}{\ell^{3}\left|\log \operatorname{Rate}\left(\omega_{0} ; \beta\right)\right|}
$$

Choosing $\ell=|\log \operatorname{Rate}(\beta)|^{-\frac{1}{4}}$ gives that for $t \in[0, T]$

\left\|\omega(t)-\omega^{\beta}(t)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} & \lesssim\left\|\omega_{0}^{\beta}-\omega_{0}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}-\omega_{0}^{\left|\log \operatorname{Rate}\left(\omega_{0} ; \beta\right)\right|^{-\frac{1}{4}}}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\frac{1+\mathfrak{p}\left\|\omega_{0}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} T}{\left|\log \operatorname{Rate}\left(\omega_{0} ; \beta\right)\right|^{\frac{1}{4}}} \\
& =: \operatorname{Rate}_{\omega}\left(\omega_{0} ; \beta\right) . \tag{3.44}
\end{align*}
$$

Since there is no explicit rate for the convergence of $\left\|\omega_{0}^{\beta}-\omega_{0}\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}$, the first two terms dominate the rate of convergence in general.
3.4.2. When $\omega_{0}$ has some regularity. An important class of localized Yudovich vorticity functions belong to Besov space of positive regularity index: for example, $f(x)=\log (\log |x|) \varphi(x) \in$ $Y_{\mathrm{ul}}^{\Theta}$ with $\Theta(\mathfrak{p})=\log \mathfrak{p}$, where $\varphi(x)$ is a smooth cutoff function, belongs to $W^{1, r}\left(\mathbb{T}^{2}\right)$ where $r<2$, and thus in Besov space $B_{2, \infty}^{s}$ with $s<1$. Of course, vortex patches $\chi_{D}$ with boxcounting dimension of the boundary $d_{F}(\partial D)<2$ belongs to $B_{p, \infty^{p}}^{\frac{2-d_{F}(\partial D)}{p}}$ for $1 \leq p<\infty$ ([14]) and thus vortex patch with a mild singularity in the interior of $D$ also belongs to a certain Besov space with positive regularity.

In this subsection, we provide the rate of convergence of vorticity when $\omega_{0} \in Y_{u l}^{\Theta}\left(\mathbb{T}^{2}\right) \cap$ $B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$ or $\omega_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$. Unlike Yudovich $\omega_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right)$ case, if $\omega_{0}$ is in localized Yudovich class $Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$, even if initial vorticity has additional Besov regularity, that is, $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$ for some $s>0$, the Besov regularity of vorticity $\omega(t)$ may not propagate, even in the losing manner. The key obstruction is failure of generalization of propagation of regularity result. We will explain this after proving the result, following the argument of [13, [3, and 44.

Proposition 18. If $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$ for some $s>0$, then we have

\begin{align*}
& \left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \\
& \leq C\left(T,\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)},\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\left(\beta^{\frac{s^{\prime}}{1+s^{\prime}}}+\left(\frac{1}{\left|\log \operatorname{Rate}\left(\omega_{0} ; \beta\right)\right|}\right)^{\frac{s^{\prime}}{3+4 s^{\prime}}}\right)\right.  \tag{3.45}\\
& =: \operatorname{Rate}_{\omega, s, l o c-Y}(\beta)
\end{align*}
$$

for any $s^{\prime} \in(0, s)$. Moreover, if $\omega_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$,

$$
\begin{equation*}
\left\|\omega^{\beta}(t)-\omega(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C\left(s, T,\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right) \beta^{C(s) e^{-C\left(\left\|\omega_{0}\right\|_{\left.L^{\infty}\left(\mathbb{T}^{2}\right)\right)^{T}}\right.}=: \operatorname{Rate}_{\omega, s, Y}(\beta) . . . . .} \tag{3.46}
\end{equation*}
$$

In particular, if $\omega_{0}$ is Yudovich with some Besov regularity, the vorticity converges with an algebraic rate $\beta^{\alpha}$.
Proof. First, we prove the rate for $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$. We rely on the above rate:

$$
\left\|\omega(t)-\omega^{\beta}(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C\left(\left\|\omega_{0}-\omega_{0}^{\ell}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}\right)+\frac{C\left(1+T\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}\right)}{\ell^{3}|\log \operatorname{Rate}(\beta)|}
$$

Since $\omega_{0} \in B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$, we may use the following interpolation:

\begin{aligned}
& \left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \\
& \leq\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{H^{-1}\left(\mathbb{T}^{2}\right)}^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{H^{s^{\prime}}\left(\mathbb{T}^{2}\right)}^{\frac{1}{1+s^{\prime}}} \leq\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{H^{-1}\left(\mathbb{T}^{2}\right)}^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}^{\frac{1}{1+s^{\prime}}},
\end{aligned}
$$

for arbitrary $s^{\prime} \in(0, s)$, where we have used that $H^{s}=B_{2,2}^{s}$ and $B_{p, q}^{s}\left(\mathbb{T}^{2}\right) \subset B_{p, q^{\prime}}^{s^{\prime}}\left(\mathbb{T}^{2}\right)$ for $s^{\prime}<s$ and arbitrary $q, q^{\prime}$. (The proof for whole space, which is standard, can be easily translated to periodic domain $\mathbb{T}^{2}$.) Since

\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{H^{-1}\left(\mathbb{T}^{2}\right)} \leq\left\|u_{0}-u_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C \beta\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}
$$

we have

$$
\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C \beta^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}}^{\frac{1}{1+s^{\prime}}}\left(\mathbb{T}^{2}\right)
$$

and similarly

$$
\left\|\omega_{0}-\omega_{0}^{\ell}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C \ell^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{\frac{s^{\prime}}{1+s^{\prime}}}\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}}^{\frac{1}{1+s^{\prime}}}\left(\mathbb{T}^{2}\right)^{\prime}
$$

Finally, we match $\ell$ and $\beta$ to find a rate of convergence: we match $\ell$ so that

\frac{1}{\ell^{3}|\log \operatorname{Rate}(\beta)|}=\ell^{\frac{s^{\prime}}{1+s^{\prime}}}
$$

Then we have

\ell^{\frac{s^{\prime}}{1+s^{\prime}}}=\frac{1}{\ell^{3}|\log \operatorname{Rate}(\beta)|}=\left(\frac{1}{|\log \operatorname{Rate}(\beta)|}\right)^{\frac{\frac{s^{\prime}}{3+4 s^{\prime}}}{} \rightarrow 0, \text {, } n=0 .}
$$

as $\beta \rightarrow 0$. To summarize, we have

$$
\left\|\omega_{0}-\omega_{0}^{\beta}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq C\left(T,\left\|\omega_{0}\right\|_{L^{2}\left(\mathbb{T}^{2}\right)},\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right)\left(\beta^{\frac{s^{\prime}}{1+s^{\prime}}}+\left(\frac{1}{|\log \operatorname{Rate}(\beta)|}\right)^{\frac{s^{\prime}}{3+4 s^{\prime}}}\right)
$$

as desired. Note that in the Yudovich class, $\operatorname{Rate}(\beta)=\beta^{C}$, and thus this rate is dominated by $\frac{1}{|\log \beta|^{\alpha}}$, which is much slower than algebraic rate $\beta^{\alpha}$.

Next, we prove the improved rate for the Yudovich initial data $\omega_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right)$. First, we calculate the rate of distance $d\left(X^{\beta}(0 ; t, x), X^{\beta}(0 ; t, y)\right)$ with respect to $d(x, y)$, which is uniform in $\beta$. For the later purpose, we calculate the rate for localized Yudovich class as well: $m=0$ corresponds to $\omega_{0} \in L^{\infty}\left(\mathbb{T}^{2}\right)$.

If $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$, then so is $\omega_{0}^{\beta} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$, with

$$
\sup _{\beta}\left(\left\|\omega_{0}^{\beta}\right\|_{Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}^{\beta}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right) \leq\left(\left\|\omega_{0}\right\|_{Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)}+\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right)
$$

We first estimate the modulus of continuity for $u^{\beta}$ with $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$, given by Theorem 15 ,

$$
\varphi_{\Theta}(r) \leq\left\{\begin{array}{l}
0, r=0 \\
r(1-\log r) \prod_{k=1}^{m} \log _{k}(1-\log r), 0<r<\frac{1}{e^{e_{m}(1)-1}} \\
C(\Theta), r \geq \frac{1}{e^{e_{m}(1)-1}}
\end{array}\right.
$$

where $C(\Theta)$ is a constant depending on $\Theta$.
We have

$$
\begin{aligned}
& \left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right| \leq|x-y|+\int_{0}^{t}\left|\frac{d}{d s} X^{\beta}(s ; t, x)-\frac{d}{d s} X^{\beta}(s ; t, y)\right| \mathrm{d} s \\
& \quad=|x-y|+\int_{0}^{t}\left|u\left(X^{\beta}(s ; t, x), s\right)-u\left(X^{\beta}(s ; t, y), s\right)\right| \mathrm{d} s \\
& \leq|x-y|+\int_{0}^{t} \varphi_{\Theta}\left(\left|X^{\beta}(s ; t, x)-X^{\beta}(s ; t, y)\right|\right) B \mathrm{~d} s
\end{aligned}
$$

Here, by the Theorem 15, $C$ is uniform in $\beta$. Then by Osgood's lemma, we have

$$
-\mathcal{M}\left(\left|X^{\beta}(0 ; t, x), X^{\beta}(0 ; t, y)\right|\right)+\mathcal{M}(|x-y|) \leq B t
$$

where
$\mathcal{M}(x)=\int_{x}^{1} \frac{\mathrm{~d} r}{\varphi_{\Theta}(r)}=\left\{\begin{array}{l}\int_{x}^{\exp \left(\frac{1}{e_{m}(1)-1}\right)} \frac{1}{r(1-\log r) \prod_{k=1}^{n} \log _{k}(1-\log r)} \mathrm{d} r+\int_{\frac{1}{e^{e_{m}(1)-1}}}^{1} \frac{\mathrm{~d} r}{\varphi^{\Theta}(r)}, x<\exp \left(\frac{1}{e^{e_{m}(1)-1}}\right), \\ \int_{x}^{1} \frac{\mathrm{~d} r}{\varphi_{\Theta}(r)}, x \geq \exp \left(\frac{1}{e^{e_{m}(1)-1}}\right),\end{array}\right.$
and $B$ is an upper bound for $\left\|u^{\beta}\right\|_{L^{\infty}\left([0, T] ; C_{b}^{0, \varphi} \Theta\left(\mathbb{T}^{2}, \mathbb{R}^{2}\right)\right)}$. For future purpose, we take $B$ so that $e^{B T}>e_{m}(1)$. Thus, if $x \geq \exp \left(\frac{1}{e^{e_{m}(1)-1}}\right), \mathcal{M}(x) \leq C_{0}$ for some positive constant $C_{0}$. If $x<\exp \left(\frac{1}{e^{e_{m}(1)-1}}\right)$, then

\int_{x}^{\exp \left(\frac{1}{e_{m}(1)-1}\right)} \frac{1}{r(1-\log r) \prod_{k=1}^{m} \log _{k}(1-\log r)} \mathrm{d} r=\log _{m+1}(1-\log x)
$$

using the substitution $y=\log _{m}(1-\log r)$, and thus

$$
\mathcal{M}(x) \in\left[\log _{m+1}(1-\log x), \log _{m+1}(1-\log x)+C_{0}\right]
$$

for a (possibly larger) positive constant $C_{0}$. Therefore, if $|x-y|$ is sufficiently small so that $\log _{m+1}(1-\log |x-y|)-B T>C_{0}$, then since

\mathcal{M}\left(\left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right|\right) \geq \mathcal{M}(|x-y|)-B t \geq \log _{m+1}(1-\log |x-y|)-B T

$\left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right|<\exp \left(\frac{1}{e^{e_{m}(1)-1}}\right)$, and therefore we have

\log _{m+1}\left(1-\log \left(\left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right|\right)\right) \geq \log _{m+1}(1-\log |x-y|)-B T-C_{0}
$$

which gives

1-\log \left(\left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right|\right) \geq e_{m+1}\left(\log _{m+1}(1-\log |x-y|)-B T-C_{0}\right),
$$

or

\left|X^{\beta}(0 ; t, x)-X^{\beta}(0 ; t, y)\right| \leq e \exp \left(-\left(e_{m+1}\left(\log _{m+2}\left(\frac{e}{|x-y|}\right)-B T-C_{0}\right)\right)\right)

which is uniform in $\beta$.
From now on, we assume $m=0$. We closely follow the proof of [13] (and [3]). We rewrite the above as

where $\alpha(T)=\exp \left(-\left(B T+C_{0}\right)\right)$ which is deteriorating in time and $C(T)=\exp \left(1-e^{-\left(B T+C_{0}\right)}\right)$ which increases in time.

Next, we introduce the space $F_{\mathfrak{p}}^{s}\left(\mathbb{T}^{2}\right)$, which belongs to the family of Triebel-Lizorkin spaces $F_{\mathfrak{p}}^{s}=F_{\mathfrak{p}, \infty}^{s}$ for $\mathfrak{p}>1$ :

F_{\mathfrak{p}}^{s}\left(\mathbb{T}^{2}\right)= & \left\{f \in L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right) \mid \text { there exists } g \in L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right) \text { such that for every } x, y \in \mathbb{T}^{2},\right. \\
& \left.\frac{|f(x)-f(y)|}{|x-y|^{s}} \leq g(x)+g(y)\right\}, \tag{3.47}
\end{align*}
$$

and its seminorm $[\cdot]_{F_{p}^{s}}$ is defined by

$$
[f]_{F_{p}^{s}}:=\inf _{g \in L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}\left\{\|g\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \| f(x)-f(y) \mid \leq(|x-y|)^{s}(g(x)+g(y)), \text { for every } x, y \in \mathbb{T}^{2}\right\}
$$

The norm on $F_{\mathfrak{p}}^{s}\left(\mathbb{T}^{2}\right)$ is naturally defined by $\|\cdot\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+[\cdot]_{F_{\mathfrak{p}}^{s}}$.
Now we argue that solution in Yudovich class propagates Besov regularity. First, we use the following embeddings: for $s_{3}>s_{2}>s_{1}$, we have continuous embeddings (the proof for whole space, which is standard, can be easily translated to periodic domain $\mathbb{T}^{2}$.)

$$
\begin{equation*}
B_{\mathfrak{p}, \infty}^{s_{3}}\left(\mathbb{T}^{2}\right) \subset B_{\mathfrak{p}, 1}^{s_{2}}\left(\mathbb{T}^{2}\right) \subset W^{s_{2}, \mathfrak{p}}\left(\mathbb{T}^{2}\right) \subset F_{\mathfrak{p}}^{s_{1}}\left(\mathbb{T}^{2}\right) \subset B_{\mathfrak{p}, \infty}^{s_{1}}\left(\mathbb{T}^{2}\right) \tag{3.48}
\end{equation*}
$$

Therefore, since $\omega_{0} \in B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$ for some $s>0$, we have $\omega_{0} \in F_{2}^{s_{1}}$ for some $s_{1} \in(0, s)$, and thus so are $\omega_{0}^{\beta}$ s with uniform bounds on $F_{2}^{s_{1}}$ norm. Then for any $\beta \geq 0$ (we introduce the convention that $X^{0}=X$ and $\omega^{0}=\omega$ ) we have

$$
\begin{aligned}
& \frac{\left|\omega^{\beta}(x, t)-\omega^{\beta}(y, t)\right|}{(|x-y|)^{s_{1} \alpha(T)}}=\frac{\left|\omega_{0}^{\beta}\left(X^{\beta}(0 ; t, x)\right)-\omega_{0}^{\beta}\left(X^{\beta}(0 ; t, y)\right)\right|}{(|x-y|)^{s_{1} \alpha(T)}} \\
& =\frac{\left|\omega_{0}^{\beta}\left(X^{\beta}(0 ; t, x)\right)-\omega_{0}^{\beta}\left(X^{\beta}(0 ; t, y)\right)\right|}{\left.d\left(X^{\beta}(0 ; t, x), X^{\beta}(0 ; t, y)\right)^{s_{1}}(0 ; t, x)-X^{\beta}(0 ; t, y) \mid\right)^{s_{1}}} \\
& (|x-y|)^{s_{1} \alpha(T)} \\
& \leq\left(g\left(X^{\beta}(0 ; t, x)\right)+g\left(X^{\beta}(0 ; t, y)\right)\right) C(T),
\end{aligned}
$$

for any $g \in L^{2}\left(\mathbb{T}^{2}\right)$ satisfying (3.47). Therefore, $C(T) g \circ X^{\beta}(0 ; t, \cdot)$ satisfies defining condition for (3.47) and thus $\omega^{\beta}(t) \in F_{2}^{s_{1} \alpha(T)}$ with

$$
\left\|\omega^{\beta}(t)\right\|_{F_{2}^{s_{1} \alpha(T)}} \leq C(T)\left\|\omega_{0}\right\|_{F_{2}^{s_{1}}} .
$$

Therefore, using (3.48), we have

\left\|\omega^{\beta}(t)\right\|_{B_{2, \infty}^{s_{1} \alpha(T)}\left(\mathbb{T}^{2}\right)} \leq C\left\|\omega^{\beta}(t)\right\|_{F_{2}^{s_{1} \alpha(T)}\left(\mathbb{T}^{2}\right)} \leq C(T)\left\|\omega_{0}\right\|_{F_{2}^{s_{1}\left(\mathbb{T}^{2}\right)}} \leq C(T)\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}
$$

Now we use the interpolation inequality:

\left.\left\|\omega^{\beta}(t)-\omega(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq\left\|\omega^{\beta}(t)-\omega(t)\right\|_{H-1}^{\frac{s_{0}}{1+s_{0}}} \mathbb{T}^{2}\right)\left\|\omega^{\beta}(t)-\omega(t)\right\|_{B_{2, \infty}^{s_{0} \alpha(T)}}^{\frac{1}{1+s_{0}}} .
$$

for some $s_{0}<s_{1} \alpha(T)$. Therefore, we have
$\left\|\omega^{\beta}(t)-\omega(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} \leq\left\|u^{\beta}(t)-u(t)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)}^{\frac{s_{0}}{1+s_{0}}} C\left(T,\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right) \leq C\left(T,\left\|\omega_{0}\right\|_{B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)}\right) \beta^{C e^{-C\left(\left\|\omega_{0}\right\|_{L^{\infty}\left(\mathbb{T}^{2}\right)}\right) T}, ~}$


Remark 4. One may naturally ask if one can obtain faster rate than (3.45), analogous to (3.46). It seems that the argument we presented for (3.46) does not extend to localized Yudovich space.

First, if $m>0$ for the modulus of continuity given by

$$
\begin{equation*}
\mu(|x-y|, T)=\exp \left(-e_{m+1}\left(\log _{m+2} \frac{e}{|x-y|}-\left(B T+C_{0}\right)\right)\right) \tag{3.49}
\end{equation*}
$$

cannot be bounded by any Hölder exponent $|x-y|^{\alpha}$ for any $\alpha \in(0,1)$. Thus, we cannot continue the argument from there. To see this, suppose that there exists a $\alpha>0$ and $C>0$ such that

for any $r<1$ very small. This amounts to say that

\frac{\log _{m+1} \frac{e}{r}}{\log _{m+1} \frac{1}{C r^{\alpha}}} \geq e^{B T+C_{0}} .
$$

Since both denominator and numerator diverges as $r \rightarrow 0^{+}$, we may apply L'Hopital's rule:

$$
\begin{aligned}
& \frac{d}{d r} \log _{m+1} \frac{e}{r}=\frac{1}{\prod_{k=1}^{m} \log _{k} \frac{e}{r}}\left(-\frac{1}{r}\right), \\
& \frac{d}{d r} \log _{m+1} \frac{1}{C r^{\alpha}}=\frac{1}{\prod_{k=1}^{m} \log _{k} \frac{1}{C r^{\alpha}}}\left(-\frac{\alpha}{r}\right) .
\end{aligned}
$$

Inductively, we have

$$
\begin{aligned}
& \lim _{r \rightarrow 0^{+}} \frac{\log _{0+1} \frac{e}{r}}{\log _{0+1} \frac{1}{C r^{\alpha}}}=\frac{1}{\alpha}, \\
& \lim _{r \rightarrow 0^{+}} \frac{\log _{1+1} \frac{e}{r}}{\log _{1+1} \frac{1}{C r^{\alpha}}}=\lim _{r \rightarrow 0^{+}} \frac{\log _{1} \frac{1}{C r^{\alpha}}}{\log _{1} \frac{e}{r}} \frac{1}{\alpha}=\frac{\alpha}{\alpha}=1, \\
& \ldots \\
& \lim _{r \rightarrow 0^{+}} \frac{\log _{m+1} \frac{e}{r}}{\log _{m+1} \frac{1}{C r^{\alpha}}}=\prod_{k=1}^{m} \frac{\log _{k} \frac{1}{C r^{\alpha}}}{\log _{k} \frac{e}{r}} \frac{1}{\alpha}=1 .
\end{aligned}
$$

Therefore, except for $m=0$, where the limit is given by $\frac{1}{\alpha}$, for any $\alpha>0$ and $C>0$, there exists small $r>0$ such that $\mu(r, T)>C r^{\alpha}$. Thus, control of vorticity in Triebel-Lizorkin space $F_{p}^{s(t)}$ is not available.

There are other methods for propagation of regularity (in losing manner), but it seems that they also suffer from similar issue: flows generated by localized Yudovich class does not propagate enough regularity.

The argument of [3] does not extend to localized Yudovich class as well: when $\omega_{0}$ is locally Yudovich, the modulus of continuity for $u$ is weaker than log-Lipschitz: it is known that the norm defined by

$$
\|u\|_{L L^{\prime}}=\|u\|_{L^{\infty}}+\sup _{j \geq 0} \frac{\left\|\nabla S_{j} u\right\|_{L^{\infty}}}{(j+1)}
$$

where $S_{j} u=\sum_{k=-1}^{j} \Delta_{k} u$, is equivalent to the norm of Log-Lipschitz space (proposition 2.111 of [3], which is for the whole case, but can be adopted the periodic domain easily). However, if $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}$, then $u$ has the modulus of continuity $\varphi_{\Theta}$, and the norm for $C_{b}^{0, \varphi_{\Theta}}\left(\mathbb{T}^{2}\right)$ is equivalent to

$$
\|u\|_{L^{\infty}}+\sup _{j \geq 0} \frac{\left\|\nabla S_{j} u\right\|_{L^{\infty}}}{\prod_{k=1}^{m+1} \log _{k}\left(e 2^{j}\right)},
$$

which is less than $\|u\|_{L L^{\prime}}$. However, the critical growth rate for the denominator in applying the linear loss of regularity result (for example, Theorem 3.28 of [3]) is $j+1$, which is the rate of Log-Lipschitz norm. Therefore, we cannot rely on the argument of [3] to conclude that $\omega(t)$ has certain Besov regularity.

Finally, a borderline Besov space $B_{\Gamma}$, introduced by Vishik in [44]) has a certain regularity (in the sense that $B_{\Gamma}$ restricts the rate of growth of frequency components) propagates, but it
is not clear how to use this to obtain convergence rate for vorticity. For simplicity, we focus on one particular form of growth function: let

$$
\Gamma(r)=(r+2) \frac{\log (r+3)}{\log 2}, \Gamma_{1}(r)=\frac{\log (r+3)}{\log 2}
$$

for $r \geq-1$ and $\Gamma(r)=\Gamma_{1}(r)=1$ for $r \leq-1$. We define the space $B_{\Gamma}$ by

$$
B_{\Gamma}=\left\{f \mid\|f\|_{\Gamma}:=\sup _{N \geq-1} \frac{\sum_{j=-1}^{N}\left\|\Delta_{j} f\right\|_{L^{\infty}}}{\Gamma(N)}<\infty\right\}
$$

and we define $B_{\Gamma_{1}}$ in a similar manner. In [44, the following was proved:
Theorem 19 (44]). If $\omega_{0} \in L^{\mathfrak{p}_{0}} \cap L^{\mathfrak{p}_{1}} \cap B_{\Gamma_{1}}$, for $1<\mathfrak{p}_{0}<2<\mathfrak{p}_{1}<\infty$, then for any $T>0$ there uniquely exists a weak solution $\omega(t)$ of Euler equation satisfying

$$
\|\omega(t)\|_{\Gamma} \leq \lambda(t)
$$

where $\lambda(t)$ depends only on the bounds on $\left\|\omega_{0}\right\|_{L^{p_{0}} \cap L^{p_{1}} \cap B_{\Gamma_{1}}}$.
Therefore, one can prove uniform boundedness of vorticity in $B_{\Gamma}$ space. However, it is not clear how one can interpolate $B_{\Gamma}$ space and the velocity space (where we have rate of convergence) to obtain rate for $L^{p}$ norm of the vorticity.

Indeed, it was recently shown that if the velocity field is worse than Lipschitz ( $u \in W^{1, p}$ for $p<\infty)$, then it is possible for smooth data to lose all Sobolev regularity instantaneously from the transport by u (1]). Instead, only a logarithm of a derivative can be preserved (see, e.g. [9]), and this loss of regularity prohibits faster convergence.

## 4. Proof of the Main theorems

Lemma 19.

$$
\begin{align*}
& \left\|\frac{F^{\varepsilon}(t)-M_{1, \varepsilon u(t), 1}}{\varepsilon \sqrt{M_{1,0,1}}}\right\|_{L_{x}^{p} L_{v}^{2}}  \tag{4.1}\\
& \lesssim e^{\frac{\varepsilon^{2}}{4}\left\|u^{\beta}\right\|_{\infty}^{2}}\left\{\left\|u^{\beta}(t)-u(t)\right\|_{L_{x}^{p}} \varepsilon^{\varepsilon^{2}\left\|u-u^{\beta}\right\|_{\infty}^{2}}+\kappa^{\min \left\{1, \frac{p+2}{2 p}\right\}} \sqrt{\mathcal{E}(t)}+\varepsilon \kappa V(\beta)\right\} . \\
& \left\|\frac{\nabla_{x}\left(F^{\varepsilon}-M_{1, \varepsilon u(t), 1}\right)}{\varepsilon(1+|v|) \sqrt{M_{1,0,1}}}\right\|_{L_{x}^{p} L_{v}^{2}} \\
& \lesssim\left\{\left\|\nabla_{x} u^{\beta}-\nabla_{x} u\right\|_{L_{x}^{p}}+\varepsilon\left\|\nabla_{x} u\right\|_{L_{x}^{p}}+\varepsilon\left\|\nabla_{x} u^{\beta}\right\|_{L_{x}^{p}}\right\} e^{\varepsilon^{2}\left\|u-u^{\beta}\right\|_{\infty}^{2}} e^{\varepsilon^{2}\left\|u^{\beta}\right\|_{\infty}^{2}}  \tag{4.2}\\
& +e^{\frac{\varepsilon^{2}\left\|u^{\beta}\right\|_{L \infty}^{2}}{4}\left(\mathbb{T}^{2}\right)}\left\{\kappa^{\min \left\{\frac{1}{p}, \frac{1}{2}\right\}} \sqrt{\mathcal{E}(t)}+\varepsilon \kappa V(\beta)\right\} .
\end{align*}
$$

Proof. We only prove (4.2), as the proof of (4.1) is similar and simpler. We decompose

$$
\begin{align*}
& \left\|\frac{\nabla_{x}\left(F^{\varepsilon}-M_{1, \varepsilon u, 1}\right)}{\varepsilon(1+|v|) \sqrt{M_{1,0,1}}}\right\|_{L_{x}^{p} L_{v}^{2}} \\
& \leq\left\|\frac{\nabla_{x}\left(M_{1, \varepsilon u^{\beta}, 1}-M_{1, \varepsilon u, 1}\right)}{\varepsilon(1+|v|) \sqrt{M_{1,0,1}}}\right\|_{L_{x}^{p} L_{v}^{2}}+\left\|\sqrt{\frac{M_{1, \varepsilon u^{\beta}, 1}^{1+o(1)}}{M_{1,0,1}}}\right\|_{L_{x, v}^{\infty}}\left\|\frac{\nabla_{x}\left(F^{\varepsilon}-M_{1, \varepsilon u^{\beta}, 1}\right)}{\varepsilon(1+|v|) \sqrt{M_{1, \varepsilon u^{\beta}, 1}^{1+o(1)}}}\right\|_{L_{x}^{p} L_{v}^{2}}  \tag{4.3}\\
& =(4.3)_{1}+(4.3)_{2}(4.3)_{3} .
\end{align*}
$$

The bound of (4.3) ${ }_{1}$ raises the need for consideration of $\sqrt{M_{1, A, 1}^{1+o(1)} / M_{1,0,1}}$ for $A \in \mathbb{R}^{3}$ :

$$
\begin{equation*}
\sqrt{M_{1, A, 1}^{1+o(1)} / M_{1,0,1}} \lesssim e^{\frac{-(1+o(1))|v-A|^{2}+|v|^{2}}{4}} \leq e^{\frac{|A|^{2}}{4}} \tag{4.4}
\end{equation*}
$$

Using (4.4) and the Taylor expansion, we derive that,

$$
\begin{align*}
& \frac{\left|\nabla_{x}\left(M_{1, \varepsilon u^{\beta}, 1}-M_{1, \varepsilon u, 1}\right)\right|}{\varepsilon \sqrt{M_{1,0,1}}} \\
& =\frac{1}{\varepsilon}\left|\int_{0}^{\varepsilon} \nabla_{x}\left(\left((v-\varepsilon u)+a\left(u-u^{\beta}\right)\right) \cdot\left(u^{\beta}-u\right) \frac{M_{1, \varepsilon u-a\left(u-u^{\beta}\right), 1}}{\sqrt{M_{1,0,1}}}\right) \mathrm{d} a\right|  \tag{4.5}\\
& \lesssim\left\{\left|\nabla_{x} u^{\beta}-\nabla_{x} u\right|+\varepsilon\left|\nabla_{x} u\right|+\varepsilon\left|\nabla_{x} u^{\beta}\right|\right\} e^{\varepsilon^{2}\left|u-u^{\beta}\right|^{2}} e^{\varepsilon^{2}\left|u^{\beta}\right|^{2}} \frac{1}{\varepsilon} \int_{0}^{\varepsilon}\left|M_{1, \varepsilon u-a\left(u-u^{\beta}\right), 1}(v)\right|^{\frac{1}{4}} \mathrm{~d} a,
\end{align*}
$$

where we have used $\left|(v-\varepsilon u)+a\left(u-u^{\beta}\right)\right|\left|M_{1, \varepsilon u-a\left(u-u^{\beta}\right), 1^{1}}\right|^{\frac{1}{2}-o(1) / 2} \lesssim\left|M_{1, \varepsilon u-a\left(u-u^{\beta}\right), 1}\right|^{\frac{1}{4}}$ and $\left|\varepsilon u-a\left(u-u^{\beta}\right)\right|=\left|(\varepsilon-a) u-(\varepsilon-a) u^{\beta}+\varepsilon u^{\beta}\right| \leq|\varepsilon-a|\left|u-u^{\beta}\right|+\varepsilon\left|u^{\beta}\right| \leq \varepsilon\left\{\left|u-u^{\beta}\right|+\left|u^{\beta}\right|\right\}$.

Now taking an $L_{x}^{p} L_{v}^{2}$-norm to (4.5), we conclude that

$$
\begin{equation*}
(4.3)_{1} \lesssim\left\{\left\|\nabla_{x} u^{\beta}-\nabla_{x} u\right\|_{L_{x}^{p}}+\varepsilon\left\|\nabla_{x} u\right\|_{L_{x}^{p}}+\varepsilon\left\|\nabla_{x} u^{\beta}\right\|_{L_{x}^{p}}\right\} e^{\varepsilon^{2}\left\|u-u^{\beta}\right\|_{\infty}^{2}} e^{\varepsilon^{2}\left\|u^{\beta}\right\|_{\infty}^{2}} . \tag{4.6}
\end{equation*}
$$

From (4.4), clearly we have

$$
\begin{equation*}
(4.3)_{2} \lesssim e^{\frac{\varepsilon^{2}\left\|u^{\beta}\right\|_{L \infty}^{2}\left(\mathbb{T}^{2}\right)}{4}} . \tag{4.7}
\end{equation*}
$$

Using the expansion (2.2), we can bound (4.3) $)_{3}$ :

$$
\begin{align*}
(4.3)_{3} & \lesssim\left\|\nabla_{x} f^{\varepsilon}\right\|_{L_{x}^{p} L_{x}^{2}}+\varepsilon\left\|u^{\beta}\right\|_{\infty}\left\|f^{\varepsilon}\right\|_{L_{x}^{p} L_{x}^{2}}+\varepsilon \kappa V(\beta) \\
& \lesssim\left\|\nabla_{x}^{2} f_{R}\right\|_{L_{x, v}}^{\frac{p-2}{p}}\left\|\nabla_{x} f_{R}\right\|_{L_{x, v}^{2}}^{\frac{2}{p}}+\varepsilon\left\|u^{\beta}\right\|_{\infty}\left\|\nabla_{x} f_{R}\right\|_{L_{x, v}^{2,2}}^{\frac{p-2}{p}}\left\|f_{R}\right\|_{L_{x, v}^{2}}^{\frac{2}{p}}+\varepsilon \kappa V(\beta)  \tag{4.8}\\
& \lesssim \kappa^{\min \left\{\frac{1}{p}, \frac{1}{2}\right\}} \sqrt{\mathcal{E}(t)}+\varepsilon \kappa V(\beta) .
\end{align*}
$$

We finish the proof by applying (4.6)-(4.8) to (4.3).
We claim that

## Lemma 20.

$$
\begin{equation*}
\left\|\omega_{B}^{\varepsilon}(t)-\omega(t)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \lesssim\left\|\omega^{\beta}(t)-\omega(t)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}+\kappa^{\min \left\{\frac{1}{2}, \frac{1}{\beta}\right\}} \sqrt{\mathcal{E}(t)}+\varepsilon \kappa V(\beta) . \tag{4.9}
\end{equation*}
$$

Proof. Recall $F^{\varepsilon}$ in (2.2). Note that

$$
\begin{align*}
& \omega_{B}^{\varepsilon}(t, x)-\omega(t, x)=\nabla^{\perp} \cdot u_{B}^{\varepsilon}(t, x)-\nabla^{\perp} \cdot u(t, x) \\
& =\frac{1}{\varepsilon} \int_{\mathbb{R}^{3}} \underline{v} \cdot \nabla^{\perp}\left(F^{\varepsilon}(t, x, v)-M_{1, \varepsilon u, 1}(v)\right) \mathrm{d} v \\
& =\frac{1}{\varepsilon} \int_{\mathbb{R}^{3}} \underline{v} \cdot \nabla^{\perp}\left(M_{1, \varepsilon u^{\beta}, 1}(v)-M_{1, \varepsilon u, 1}(v)\right) \mathrm{d} v \quad\left(=\omega^{\beta}-\omega\right)  \tag{4.10}\\
& \quad+\int_{\mathbb{R}^{3}} \nabla^{\perp} f_{R}(t, x, v) \cdot \underline{v} \sqrt{\mu} \mathrm{~d} v  \tag{4.11}\\
& \quad+\nabla^{\perp} \cdot \int_{\mathbb{R}^{3}}\left\{\varepsilon^{2} p^{\beta} \mu-\varepsilon^{2} \kappa\left(\nabla_{x} u^{\beta}\right): \mathfrak{A} \sqrt{\mu}+\varepsilon \kappa \tilde{u}^{\beta} \cdot\left(v-\varepsilon u^{\beta}\right) \mu+\varepsilon^{2} \kappa \tilde{p}^{\beta} \mu\right\} \mathrm{d} v . \tag{4.12}
\end{align*}
$$

Clearly

$$
\|(4.10)\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)}={\underset{55}{\beta}(t)-\omega(t) \|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} . . . . ~} .
$$

From Theorem 12, we conclude that

$$
\|(\underline{4.11})\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \lesssim\left\{\begin{array}{l}
\left\|\nabla_{x} f_{R}(t)\right\|_{L^{2}\left(\mathbb{T}^{2} \times \mathbb{R}^{3}\right)} \lesssim \sqrt{\kappa} \sqrt{\mathcal{E}(t)} \text { for } \mathfrak{p} \in[1,2], \\
\left\|\nabla_{x}^{2} f_{R}(t)\right\|_{L^{2}\left(\mathbb{T}^{2} \times \mathbb{R}^{3}\right)}^{\frac{2}{p}}\left\|\nabla_{x} f_{R}(t)\right\|_{L^{2}\left(\mathbb{T}^{2} \times \mathbb{R}^{3}\right)}^{\frac{2}{p}} \lesssim \kappa^{\frac{1}{\mathfrak{p}}} \sqrt{\mathcal{E}(t)} \text { for } \mathfrak{p} \in(2, \infty),
\end{array}\right.
$$

where we have used (anisotropic) Gagliardo-Nirenberg interpolation for the second, whose proof is analogous to Lemma 8,

Using Theorem 7 we get that $\|(4.12)\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \lesssim \varepsilon \kappa V(\beta)$.
Equipped with Proposition 6, Proposition 17, and Proposition 12, we are ready to prove the main theorem of this paper.
Theorem 20. Choose an arbitrary $T \in(0, \infty)$. Suppose $\left(u_{0}, \omega_{0}\right) \in L^{2}\left(\mathbb{T}^{2}\right) \times L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)$ for $\mathfrak{p} \in[1, \infty)$ and $(u, \omega)$ be a Lagrangian solution of (0.11)-(0.12)-(0.13). Assume the initial data $F_{0}$ to (0.7) satisfies conditions in Theorem 12. Then there exists a family of Boltzmann solutions $F^{\varepsilon}(t, x, v)$ to (0.7) in $[0, T]$ such that

$$
\begin{equation*}
\sup _{t \in[0, T]}\left\|\frac{F^{\varepsilon}(t)-M_{1, \varepsilon u(t), 1}}{\varepsilon \sqrt{M_{1,0,1}}}\right\|_{L^{2}\left(\mathbb{T}^{2} \times \mathbb{R}^{3}\right)} \rightarrow 0 . \tag{4.13}
\end{equation*}
$$

Moreover the Boltzmann vorticity converges to the Lagrangian solution $\omega$ :

$$
\begin{equation*}
\sup _{0 \leq t \leq T}\left\|\omega_{B}^{\varepsilon}(t, \cdot)-\omega(t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \rightarrow 0 . \tag{4.14}
\end{equation*}
$$

Theorem 21. Choose an arbitrary $T \in(0, \infty)$. Suppose $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right)$ for some $\Theta$ in (3.33) with $m \in \mathbb{Z}_{\geq 0}$, and let $(u, \omega)$ be the unique weak solution of (0.11)-(0.12)-(0.13). Assume the initial data $F_{0}$ to (0.7) satisfies conditions in Theorem 12. Then there exists a family of Boltzmann solutions $F^{\varepsilon}(t, x, v)$ to (0.7) in $[0, T]$ such that

$$
\begin{equation*}
\sup _{t \in[0, T]}\left\|\frac{F^{\varepsilon}(t)-M_{1, \varepsilon u(t), 1}}{\varepsilon \sqrt{M_{1,0,1}}}\right\|_{L^{2}\left(\mathbb{T}^{2} \times \mathbb{R}^{3}\right)} \rightarrow 0 . \tag{4.15}
\end{equation*}
$$

Moreover the Boltzmann velocity and vorticity converges to the solution $\omega$ with an explicit rate as in (3.34), (3.44):

$$
\begin{align*}
\sup _{0 \leq t \leq T}\left\|u_{B}^{\varepsilon}(t, \cdot)-u(t, \cdot)\right\|_{L^{2}\left(\mathbb{T}^{2}\right)} & \lesssim \operatorname{Rate}(\beta) \\
\sup _{0 \leq t \leq T}\left\|\omega_{B}^{\varepsilon}(t, \cdot)-\omega(t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} & \lesssim \operatorname{Rate}_{\omega}(\beta) . \tag{4.16}
\end{align*}
$$

Furthermore, if $\omega_{0} \in Y_{\mathrm{ul}}^{\Theta}\left(\mathbb{T}^{2}\right) \cap B_{2, \infty}^{s}\left(\mathbb{T}^{2}\right)$ for some $s>0$, Boltzmann vorticity converges to the solution $\omega$ with a rate which is uniform in $\omega_{0}$ as in (3.45), (3.46):

$$
\begin{align*}
& \sup _{0 \leq t \leq T}\left\|\omega_{B}^{\varepsilon}(t, \cdot)-\omega(t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \lesssim \operatorname{Rate}_{\omega, s, l o c-Y}(\beta), m>0 \text { (localized Yudovich), } \\
& \sup _{0 \leq t \leq T}\left\|\omega_{B}^{\varepsilon}(t, \cdot)-\omega(t, \cdot)\right\|_{L^{\mathfrak{p}}\left(\mathbb{T}^{2}\right)} \lesssim \operatorname{Rate}_{\omega, s, Y}(\beta), m=0 \text { (Yudovich). } \tag{4.17}
\end{align*}
$$
