# SUBCONVEXITY OF TWISTED SHINTANI ZETA FUNCTIONS

#### Abstract

Previously the authors proved subconvexity of Shintani's zeta function enumerating class numbers of binary cubic forms. Here we return to prove subconvexity of the Maass form twisted version.


## 1. Introduction

In a previous paper [14], the authors proved the subconvexity of Shintani's zeta function enumerating class numbers of binary cubic forms. The purpose of this article is to demonstrate that the same approach proves subconvexity for the Maass cusp form twisted version of the zeta function [12]. This is of interest because F. Sato [18] has demonstrated a general method of twisting zeta functions of prehomogeneous vector spaces with automorphic forms, creating a large class of interesting arithmetic objects, some of which can be proved to be subconvex in this way.

Let $V_{\mathbb{Z}}=\left\{f(x, y)=a x^{3}+b x^{2} y+c x y^{2}+d y^{3}: a, b, c, d \in \mathbb{Z}\right\}$ be the space of integral binary cubic forms and let $\phi$ be a Maass cusp form for $\mathrm{SL}_{2}(\mathbb{Z}) \backslash \mathrm{SL}_{2}(\mathbb{R})$. The cusp form twisted zeta function is

\mathscr{L}^{ \pm}(\phi, s):=\sum_{\substack{f \in \operatorname{SL} L_{2}(\mathbb{Z}) \backslash V_{\mathbb{Z}} \\ \pm \operatorname{Disc}(f)>0}} \frac{\phi(f)}{|\operatorname{Stab}(f)|} \frac{1}{|\operatorname{Disc}(f)|^{s}}, \quad \operatorname{Re}(s)>1 \tag{1}
\end{equation*}
$$

Although this zeta function does not satisfy a known functional equation, its analytic growth is degree four as for the untwisted zeta function and it has holomorphic continuation to $\mathbb{C}$. Parallel to the subconvex estimate for the Shintani zeta function, we prove the following subconvex estimate on the critical line for the twisted version.

Theorem 1. The twisted Shintani zeta function satisfies the subconvex bound, for any $\epsilon>0$,

\mathscr{L}^{ \pm}\left(\frac{1}{2}+i \tau, \phi\right)<_{\epsilon, \phi} \tau^{\frac{26}{27}+\epsilon} \tag{2}
\end{equation*}

as $\tau \rightarrow \infty$.
This can be compared to an error term of $\tau^{\frac{98}{99}}+\epsilon$ for the untwisted zeta function, proved in [14.

[^0]1.1. Discussion of method. Since the twisted version of the Shintani zeta function does not satisfy a known functional equation, a significant part of extending the subconvexity estimate in the untwisted case to the twisted case lies in developing an analogue of the approximate functional equation for this zeta function, developed directly from the theory of prehomogeneous vector space zeta functions. Once this is developed, methods in the same spirit as those used on the original zeta function suffice to prove the subconvexity. These include translation between Cartesian and homogeneous coordinates, and van der Corput's method of exponential sums to obtain cancellation in exponential sums.

## Notation

We use the shorthand $e(x)=e^{2 \pi i x}, c(x)=\cos (2 \pi x), s(x)=\sin (2 \pi x)$. On $\mathbb{R} / \mathbb{Z}$ we use the distance

In $V_{\mathbb{R}}=\left\{f(x, y)=a x^{3}+b x^{2} y+c x y^{2}+d y^{3}: a, b, c, d \in \mathbb{R}\right\}$ define the infinity ball at $f$ of radius $R$ to be

The $K$ Bessel function is $K_{\nu}(x)=\int_{0}^{\infty} e^{-x \cosh t} \cosh (\nu t) d t$. The averaging operator $\mathbf{E}_{r \in R} f(r)$ indicates $\frac{1}{|R|} \sum_{r \in R} f(r)$. We use the following asymptotic notation. For positive quantities $A, B$ which may depend on the parameter $\tau, A=O(B)$ means there is a constant $C>0$ such that $A \leq C B$. This has the same meaning as $A \ll B$. We write $A \asymp B$ if $A \ll B \ll A$ and $A=o(B)$ if $\lim _{\tau \rightarrow \infty} \frac{A}{B}=0$. For a function $f$ on $\mathbb{R}^{+}$, the Mellin transform is $\tilde{f}(s)=\int_{0}^{\infty} f(x) x^{s-1} d x$. For differential operators with multi-indices $\alpha, D_{\alpha}=\partial_{x_{1}}^{\alpha_{1}} \ldots \partial_{x_{k}}^{\alpha_{k}},|\alpha|=\alpha_{1}+\ldots+\alpha_{k}$. We use the $C^{j}$ norms on $\mathbb{R}^{n}$,

Our arguments use a smooth partition of unity on the positive reals. Let $\sigma \geq 0$ be smooth and supported in $\left[\frac{1}{2}, 2\right]$ and satisfy $\sum_{n \in \mathbb{Z}} \sigma\left(2^{n} x\right) \equiv 1$ for $x \in \mathbb{R}^{+}$.

## 2. Background

We prove the following variant of the approximate functional equation in the twisted case in Section 5.

Theorem 2 (Twisted approximate functional equation). Let $\phi$ be a Hecke-eigen Maass cusp form. The $\phi$-twisted Shintani $\mathscr{L}$ function $\mathscr{L}^{ \pm}(s, \phi)$ has the representation at $s=$ $\frac{1}{2}+i \tau, \tau \geq 1$,

& =\sum_{x \in \Gamma \backslash V_{\mathbb{Z}} \cap V_{ \pm}} \frac{V\left(g_{x},|\operatorname{Disc}(x)|\right)}{|\operatorname{Stab}(x)||\operatorname{Disc}(x)|^{\frac{1}{2}+i \tau}}+\sum_{\xi \in \Gamma \backslash\left(\hat{\left.V_{\mathbb{Z}} \backslash S\right)}\right.} \frac{\hat{V}\left(g_{\xi},|\operatorname{Disc}(\xi)|\right)}{|\operatorname{Stab}(\xi)||\operatorname{Disc}(\xi)|^{\frac{1}{2}-i \tau}}+O_{A}\left(\tau^{-A}\right),

where $g_{x}, g_{\xi}$ are in a fundamental domain for $\mathrm{SL}_{2}(\mathbb{Z}) \backslash \mathrm{SL}_{2}(\mathbb{R})$. The functions $V$ and $\hat{V}$ satisfy the following properties.
(1) There is $a c>0$ such that, if $g=n_{u} a_{t} k_{\theta}$ then, for any $\epsilon>0$,

(2) For any fixed $\eta>0$, if $h=n_{u^{\prime}} a_{t^{\prime}} k_{\theta^{\prime}}$ with $\left|u^{\prime}\right|,\left|1-t^{\prime}\right|,\left|\theta^{\prime}\right|<\delta<\tau^{-\eta}$ and $t \ll$ $(\log \tau)^{O(1)}$ then, for all $\epsilon>0$

By forming linear combinations to prove Theorem 1 it suffices to prove the following estimates.

Proposition 3. We have the pair of estimates

\sum_{\xi \in \Gamma \backslash\left(\hat{V}_{\mathbb{Z}} \backslash S\right)} \frac{\hat{V}\left(g_{\xi},|\operatorname{Disc}(\xi)|\right)}{|\operatorname{Stab}(\xi)||\operatorname{Disc}(\xi)|^{\frac{1}{2}-i \tau}} \ll \tau^{\frac{26}{27}+\epsilon .} .

2.1. Background regarding $\mathrm{GL}_{2}(\mathbb{R})$. We use the conventions of [8] regarding Lie groups. Let $\Gamma=\mathrm{SL}_{2}(\mathbb{Z})$, and

The Iwasawa decomposition of $\mathrm{SL}_{2}(\mathbb{R})$ expresses $g=n_{u} a_{t} k_{\theta}$. Then for $g \in G^{+}, g=$ $n_{u} a_{t} k_{\theta} d_{\lambda}$ and Haar measure on $G^{+}$is given by $d g=d u \frac{d t}{t^{3}} d \theta \frac{d \lambda}{\lambda}$. There is an involution $\iota: G^{+} \rightarrow G^{+}$,

In coordinates, $g^{\iota}=n_{u} a_{t} k_{\theta} d_{\frac{1}{\lambda}}$. Let $\mathscr{F}$ denote the standard fundamental domain for $\mathrm{SL}_{2}(\mathbb{Z}) \backslash \mathrm{SL}_{2}(\mathbb{R})$,

where $\nu(a)$ is the union of two subintervals of $\left[-\frac{1}{2}, \frac{1}{2}\right]$ and is the whole interval if $a \geq 1$. For constants $A, B>0$, the Siegel set $\mathscr{S}(A, B)$ is

We assume that $F$ is a smooth function, right $K$ invariant, supported on a Siegel set $\mathscr{S}(A, B)$ with bounded derivatives and such that $\sum_{\gamma \in \Gamma} F(\gamma g)=1$. Extend $F$ to $G^{+}$by $F\left(d_{\lambda} g\right)=F(g)$ for all $\lambda \in \mathbb{R}^{+}$.
2.2. Automorphic forms. We consider Maass form $\phi$ which is a smooth function on $\Gamma \backslash \mathrm{SL}_{2}(\mathbb{R}) / \mathrm{SO}_{2}(\mathbb{R})$ that is an eigenfunction of the Casimir operator (hyperbolic Laplacian) and Hecke algebra. The Maass form $\phi$ has a Fourier expansion

This satisfies $\phi(g)=\phi\left(\left(g^{-1}\right)^{t}\right)=\phi\left(g^{l}\right)$. The Fourier coefficients satisfy the Hecke relations

The bound $\left|\rho_{\phi}(n)\right| \ll n^{\frac{7}{64}+\epsilon}$ is proved in [16], while $\sum_{n \leq X}\left|\rho_{\phi}(n)\right|^{2} \ll X$ follows from Rankin-Selberg Theory.
The $K$-Bessel function satisfies exponential decay in large argument, $K_{\nu}(z) \ll e^{-z}$ as $z \rightarrow \infty$, so that $\phi$ decays rapidly in large $t$. Several integral identities involving the $K$-Bessel function are used,

K_{\nu}(z) K_{\nu}(\zeta) & =\frac{1}{2} \int_{0}^{\infty} \exp \left(-\frac{t}{2}-\frac{z^{2}+\zeta^{2}}{2 t}\right) K_{\nu}\left(\frac{z \zeta}{t}\right) \frac{d t}{t} .

The Mellin transform of a pair of $K$ Bessel functions has the following evaluation.
Lemma 4. We have in $\operatorname{Re}(\alpha+\beta)>0$ and $\operatorname{Re}(s)>|\operatorname{Re}(\mu)|+|\operatorname{Re}(\nu)|$,

& \int_{0}^{1} t^{\frac{s-\mu+\nu}{2}-1}(1-t)^{\frac{s+\mu-\nu}{2}-1}\left(1-\left(1-\frac{\beta^{2}}{\alpha^{2}}\right) t\right)^{-\frac{s+\mu+\nu}{2}} d t .

Proof. The claimed Mellin transform can be evaluated in terms of Gauss's Hypergeometric function,

We have in $\operatorname{Re}(\alpha+\beta)>0$ and $\operatorname{Re}(s)>|\operatorname{Re}(\mu)|+|\operatorname{Re}(\nu)|$, ([1] p. 334 eqn (47))

& \quad \times \Gamma\left(\frac{1}{2}(s+\mu-\nu)\right) \Gamma\left(\frac{1}{2}(s-\mu-\nu)\right){ }_{2} F_{1}\left(\frac{s+\mu+\nu}{2}, \frac{s-\mu+\nu}{2}, s ; 1-\frac{\beta^{2}}{\alpha^{2}}\right) .

Combining the evaluations proves the lemma.
Lemma 5. If $\alpha>\beta>0$ and for some $\epsilon>0, \operatorname{Re}(s)>|\operatorname{Re}(\mu)|+|\operatorname{Re}(\nu)|+\epsilon$, then

& \times\left|\Gamma\left(\frac{s+\mu+\nu}{2}\right) \Gamma\left(\frac{s-\mu-\nu}{2}\right)\right|

Proof. Bound

\left(1-\left(1-\frac{\beta^{2}}{\alpha^{2}}\right) t\right)^{-\frac{s+\mu+\nu}{2}} \leq \frac{\alpha^{\operatorname{Re}(s+\mu+\nu)}}{\beta^{\operatorname{Re}(s+\mu+\nu)}}, \tag{22}
\end{equation*}

which is the value at $t=1$. Bound the rest of the integral in $t$ by a constant depending on $\epsilon$. This gives the claim.

Lemma 6. The automorphic form is an eigenfunction of the convolution equation

\int_{G^{1}} \exp \left(-\operatorname{tr} g^{t} g\right) \phi\left(h g^{-1}\right) d g=C \phi(h) \tag{23}
\end{equation*}
$$

with eigenvalue $C=\sqrt{\pi} K_{\nu}(2)$.
Proof. The convolution is right $K$ invariant by definition, since $\exp \left(-\operatorname{tr} g^{t} g\right)$ is, and is an eigenfunction of the Casimir operators and Hecke algebra, with the same eigenvalues as $\phi$, by passing the operators under the integral and applying them to $\phi$. By strong multiplicity 1 , the convolution is a multiple of $\phi$.

To evaluate the eigenvalue, we calculate

Use $\phi\left(g^{-1}\right)=\phi\left(g^{t}\right)$, and integrate away the compact subgroup $K$ under which the integrand is invariant. The integral becomes

& =\frac{2 \sum_{n=1}^{\infty} \rho_{\phi}(n)}{\phi(\mathrm{id})} \int_{0}^{\infty} \int_{-\infty}^{\infty} \exp \left(-t^{2}-\frac{1}{t^{2}}-u^{2}\right) K_{\nu}\left(2 \pi n t^{2}\right) \cos (2 \pi n u t) d u \frac{d t}{t}
\end{align*}

Integrating the Gaussian in $u$ obtains

& \sqrt{\pi} \frac{2 \sum_{n=1}^{\infty} \rho_{\phi}(n)}{\phi(\mathrm{id})} \int_{0}^{\infty} \exp \left(-t^{2}\left(1+\pi^{2} n^{2}\right)-\frac{1}{t^{2}}\right) K_{\nu}\left(2 \pi n t^{2}\right) \frac{d t}{t}  \tag{26}\\
& =\sqrt{\pi} \frac{2 \sum_{n=1}^{\infty} \rho_{\phi}(n)}{\phi(\mathrm{id})} \frac{1}{2} \int_{0}^{\infty} \exp \left(-\frac{t}{2}-\frac{4+4 \pi^{2} n^{2}}{2 t}\right) K_{\nu}\left(\frac{4 \pi n}{t}\right) \frac{d t}{t} \\
& =\sqrt{\pi} K_{\nu}(2) \frac{2 \sum_{n=1}^{\infty} \rho_{\phi}(n) K_{\nu}(2 \pi n)}{\phi(\mathrm{id})}=\sqrt{\pi} K_{\nu}(2) .
\end{align*}
$$

2.3. The prehomogeneous vector space of binary cubic forms. The space of real binary cubic forms is

V_{\mathbb{R}}=\left\{f(x, y)=a x^{3}+b x^{2} y+c x y^{2}+d y^{3}: a, b, c, d \in \mathbb{R}\right\} \tag{27}
\end{equation*}
$$

with integral forms $V_{\mathbb{Z}}$ having $a, b, c, d \in \mathbb{Z}$. The discriminant is

\operatorname{Disc}(f)=b^{2} c^{2}-4 a c^{3}-4 b^{3} d-27 a^{2} d^{2}+18 a b c d \tag{28}
\end{equation*}

There is a bilinear pairing on $V_{\mathbb{R}}$ which identifies it with its dual space,

The Fourier transform on $V_{\mathbb{R}}$ is given by $\hat{F}(\xi)=\int_{V_{\mathbb{R}}} F(x) e^{-2 \pi i\langle x, \xi\rangle} d x$.
The space has a left $\mathrm{GL}_{2}(\mathbb{R})$ action,

and $\operatorname{Disc}(\gamma \cdot f)=\operatorname{det}(\gamma)^{2} \operatorname{Disc}(f)$. Under this action there are two open orbits $V_{ \pm}=\{f$ : $\pm \operatorname{Disc}(f)>0\}$ and a singular set $S=\{f: \operatorname{Disc}(f)=0\}$. The spaces have base points $f_{ \pm}$,

\end{align*}

are bijections between $V_{ \pm}$and subsets of $G^{+}$. The stabilizer of $f_{-}$is trivial and the stabilizer of $f_{+}$is the rotation group generated by rotation by $\frac{2 \pi}{3}$. The bilinear pairing satisfies $\langle x, y\rangle=\left\langle g \cdot x, g^{t} \cdot y\right\rangle$.

The rotation $k_{\theta}$ maps

Meanwhile $a_{t} \cdot(a, b, c, d)=\left(\frac{a}{t^{3}}, \frac{b}{t}, t c, t^{3} d\right)$ and $n_{u} \cdot(a, b, c, d)=\left(a, 3 a u+b, 3 a u^{2}+2 b u+\right.$ $\left.c, a u^{3}+b u^{2}+c u+d\right), d_{\lambda} \cdot(a, b, c, d)=(\lambda a, \lambda b, \lambda c, \lambda d)$.

Putting these formulas together gives the change of coordinates to homogeneous coordinates.

n_{u} a_{t} k_{\theta} d_{\lambda} \cdot f_{+}= & \frac{\lambda}{(108)^{\frac{1}{4}}}\left(t^{-3} s(3 \theta), 3 t^{-3} s(\theta) u+3 t^{-1} c(3 \theta), 3 t^{-3} s(\theta) u^{2}+6 t^{-1} c(3 \theta) u-3 t s(3 \theta),\right. \\
& \left.t^{-3} s(3 \theta) u^{3}+3 t^{-1} c(3 \theta) u^{2}-3 t s(3 \theta) u-t^{3} c(3 \theta)\right) .
\end{align*}

Given $f \in V_{+}$, let $n_{u} a_{t} k_{\theta} d_{\lambda} \cdot f_{+}=f, u \in \mathbb{R}, t \in \mathbb{R}^{+}, \theta \in\left[0, \frac{1}{3}\right), \lambda \in \mathbb{R}^{+}$and set $g_{f}=n_{u} a_{t} k_{\theta} d_{\lambda}$. Given $f \in V_{-}$, let $n_{u} a_{t} k_{\theta} d_{\lambda} \cdot f_{-}=f$ with $u \in \mathbb{R}, t \in \mathbb{R}^{+}, \theta \in[0,1), \lambda \in \mathbb{R}^{+}$ and set $g_{f}=n_{u} a_{t} k_{\theta} d_{\lambda}$. In these expressions let $u=u(f), t=t(f), \theta=\theta(f)$.

We include several lemmas from [14] needed in the proof.
Lemma 7. Suppose that $f=n_{u} a_{t} \cdot f_{ \pm}$then $\log t=\log t_{f}+O(1)$.
Proof. This is 14 Lemma 5.
Integrals over $V_{ \pm}$may be expressed, for $f \in C_{0}\left(V_{ \pm}\right)$,

Thus $|d a \wedge d b \wedge d c \wedge d d|=\frac{\lambda^{3}}{t^{3}}|d \lambda \wedge d \theta \wedge d t \wedge d u|$.
Lemma 8. When $u, t, \theta$ vary in a Siegel set and $\lambda \geq 1$, the change of coordinates $(a, b, c, d)=n_{u} a_{t} k_{\theta} d_{\lambda} \cdot f_{ \pm}$satisfies

O\left(\lambda t^{-3}\right) & O\left(\lambda t^{-1}\right) & O(\lambda t) & O\left(\lambda t^{3}\right) \\
O\left(t^{-3}\right) & O\left(t^{-1}\right) & O(t) & O\left(t^{3}\right)
\end{array}\right)  \tag{36}\\
& \frac{\partial(u, t, \theta, \lambda)}{\partial(a, b, c, d)}=\left(\begin{array}{cccc}
O\left(\lambda^{-1} t^{5}\right) & O\left(\lambda^{-1} t^{4}\right) & O\left(\lambda^{-1} t^{3}\right) & O\left(t^{3}\right) \\
O\left(\lambda^{-1} t^{3}\right) & O\left(\lambda^{-1} t^{2}\right) & O\left(\lambda^{-1} t\right) & O(t) \\
O\left(\lambda^{-1} t\right) & O\left(\lambda^{-1}\right) & O\left(\lambda^{-1} t^{-1}\right) & O\left(t^{-1}\right) \\

Proof. This is 14 Lemma 6.
The proof of the theorems rely on estimates for the derivatives and logarithmic derivatives of the discriminant which are uniform in the cuspidal parameter $t$.

For a multi-index $\alpha=\left(\alpha_{1}, \alpha_{2}, \alpha_{3}, \alpha_{4}\right)$ let $|\alpha|=\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}$ and let $D^{\alpha}=$ $D_{a}^{\alpha_{1}} D_{b}^{\alpha_{2}} D_{c}^{\alpha_{3}} D_{d}^{\alpha_{4}}$.

Lemma 9. Let $f=n_{u} a_{t} d_{\lambda} \cdot f_{ \pm}$with $u=O(1)$ and $t, \lambda \gg 1$. Then

Lemma 10. Let $f=(a, b, c, d) \in \mathbb{R}^{4}$ be a form with $\lambda_{f} \geq 1$ and $t_{f} \gg 1$. For every constant $C_{1}>1$ there is a constant $C_{2}>0$ so that if $\|\tilde{f}-f\|_{2} \leq C_{2} \frac{\lambda_{f}}{t_{f}^{3}}$ then

## 3. Proof of Theorem 1

We give the Proof of Theorem 1 assuming the approximate functional equation, which is proved in the remainder of the paper using oscillatory integrals.

Proof of Theorem 1. Let $F$ be a smooth function supported on a Siegel set, $K$ invariant with $\partial_{t} F, \partial_{u} F=O(1)$, such that $\sum_{\gamma \in \Gamma} F(\gamma \cdot g)=1$.

By the variant of the approximate functional equation

\mathscr{L}^{ \pm}(s, \phi)=\sum_{x \in V_{\mathbb{Z}} \cap V_{ \pm}} \frac{F\left(g_{x}\right) V\left(g_{x},|\operatorname{Disc}(x)|\right)}{|\operatorname{Stab}(x)||\operatorname{Disc}(x)|^{s}}+\sum_{\xi \in \hat{V}_{\mathbb{Z}} \backslash S} \frac{F\left(g_{\xi}\right) \hat{V}\left(g_{\xi},|\operatorname{Disc}(\xi)|\right)}{|\operatorname{Stab}(\xi)||\operatorname{Disc}(\xi)|^{1-s}}+O_{A}\left(\tau^{-A}\right) . \tag{43}
\end{equation*}

The proof in case of forms and dual forms is the same, so we just show the proof for dual forms. By [20] p. 169 Corollary, the number of dual forms of discriminant $m>0$ with $|\operatorname{Stab}(\xi)|>3$ is

Write the dual sum as

The sum of interest is equal to the averaged sum

\end{equation*}

For those $\xi$ for which $t \gg(\log \tau)^{O(1)}$, use item (1) of Theorem 2 to bound

Thus $|\operatorname{Disc}(\xi+y)|=|\operatorname{Disc}(\xi)|+O\left(t^{3} Y^{\frac{3}{4}} R\right)$, and if $g_{\xi}=n_{u} a_{t} k_{\theta}, g_{\xi+y}=n_{u^{\prime}} a_{t^{\prime}} k_{\theta^{\prime}}$, $g_{\xi+y} g_{\xi}^{-1}=n_{u_{1}} a_{t_{1}} k_{\theta_{1}}$ then

\end{equation*}
$$

and $\left|u_{1}\right|,\left|t_{1}\right|,\left|\theta_{1}\right| \ll \frac{t^{O(1)} R}{Y^{\frac{1}{4}}}$. Applying item (2) of Theorem 2 it follows that
(51) $\Sigma=\sum_{\left.\xi \in \hat{V}_{z}, t<(\log t)\right)^{(1)}} \sigma\left(\frac{|\operatorname{Disc}(\xi)|}{Y}\right) F\left(g_{\xi}\right) \frac{\hat{V}_{ \pm}\left(g_{\xi},|\operatorname{Disc}(\xi)|\right)}{\sqrt{|\operatorname{Disc}(\xi)|}} \mathbf{E}_{y \in B_{R(Y)}}\left[|\operatorname{Disc}(\xi+y)|^{i \tau}\right]$

$$
+O\left(Y^{\frac{1}{4}} R \tau^{\epsilon}\left(1+\frac{Y}{\tau^{2}}\right)^{-A}\right) .
$$

Lemma 11 now applies as before and estimates the expectation over $y$ by $O\left(\frac{1}{\tau^{\frac{1}{7}-\epsilon}}\right)$ with a choice of $R$ of $\frac{Y^{\frac{1}{4}}}{\tau^{\frac{7}{27}}-\epsilon}$. This completes the proof.

## 4. Estimates for oscillatory integrals

This section collects together estimates for oscillatory integrals used in proving Theorem 2. Stein 21 gives a thorough treatment of oscillatory integrals as used in this section. In one variable, the standard type integral is

where $\phi, \psi$ are smooth, $\phi^{\prime}(x) \neq 0$ and $\psi$ is compactly supported in $[a, b]$. Define the differential operator $D f(x)=\frac{1}{i \lambda \phi^{\prime}(x)} \frac{d f}{d x}$, with transpose operator $D^{t} f=-\frac{d}{d x}\left(\frac{f}{i \lambda \phi^{\prime}(x)}\right)$. Then $D^{N} e^{i \lambda \phi(x)}=e^{i \lambda \phi(x)}$, and hence, repeated integration by parts obtains, for any $N \geq 0$,

\int_{a}^{b} e^{i \lambda \phi(x)} \psi(x) d x=\int_{a}^{b} e^{i \lambda \phi(x)}\left(D^{t}\right)^{N}(\psi)(x) d x \tag{53}
\end{equation*}
$$

The following lemma is useful for giving uniform estimates.
Lemma 12. The operator $\left(D^{t}\right)^{N} \psi$ is a sum of monomials with coefficients bounded only in terms of $N$,

\left(D^{t}\right)^{N}(\psi)=\sum_{\substack{\alpha=\left(\alpha_{0}, \ldots, \alpha_{k}\right) \\|\alpha|=N}} C_{N, \alpha} \frac{\partial^{\alpha_{0}} \psi \partial^{\alpha_{1}+1} \phi \partial^{\alpha_{2}+1} \phi \ldots \partial^{\alpha_{k}+1} \phi}{\lambda^{N}\left(\phi^{\prime}\right)^{N+k}} . \tag{54}
\end{equation*}

Proof. Applying $D^{t} N$ times differentiates a total of $N$ times, multiplies by a factor of $\lambda$ $N$ times and divides by $\phi^{\prime} N$ times. Each derivative goes on either $\psi$, the denominator, or a derivative of $\phi$ in the numerator. Differentiating the denominator increases the power of the denominator by 1 , and introduces a new factor of a derivative of $\phi$ in the numerator.

In higher dimensions, Stein [21] proves the following estimates.
Lemma 13. Suppose $\psi$ is smooth, has compact support, and that $\phi$ is a smooth real-valued function that has no critical points in the support of $\psi$. Then

I(\lambda)=\int_{\mathbb{R}^{n}} e^{i \lambda \phi(x)} \psi(x) d x=O\left(\lambda^{-N}\right) \tag{55}
\end{equation*}
$$

as $\lambda \rightarrow \infty$ for every $N \geq 0$.
Proof. This is 21] Proposition 4 on p. 341.
When there is a critical point $x_{0}$ of $\phi$ such that $\left[\frac{\partial^{2} \phi}{\partial x_{i} \partial x_{j}}\right]\left(x_{0}\right)$ is invertible, then $x_{0}$ is non-degenerate.

Lemma 14. Suppose $\phi\left(x_{0}\right)=0$, and $\phi$ has a nondegenerate critical point at $x_{0}$. If $\psi$ is supported in a sufficiently small neighborhood of $x_{0}$, then

\int_{\mathbb{R}^{n}} e^{i \lambda \phi(x)} \psi(x) d x \sim \lambda^{-\frac{n}{2}} \sum_{j=0}^{\infty} a_{j} \lambda^{-j} \tag{56}
\end{equation*}

as $\lambda \rightarrow \infty$. The coefficients $a_{j}$ are specified by finitely many derivatives of $\phi$ and $\psi$ at $x_{0}$. The asymptotic holds in the sense that, for every $r, N \geq 0$,

\left(\frac{d}{d \lambda}\right)^{r}\left[I(\lambda)-\lambda^{-\frac{n}{2}} \sum_{j=0}^{N} a_{j} \lambda^{-j}\right]=O\left(\lambda^{-\frac{n}{2}-r-N-1}\right) . \tag{57}
\end{equation*}
$$

Proof. This is 21] p. 344 Proposition 6.
In Section 5 the following oscillatory integral is needed. Let $g_{1} \in G^{1}$ and $w \in \mathbb{C}$ and define
$E\left(g_{1}, w\right)=\int_{0}^{\infty} \int_{G^{1}} \lambda^{4(1-s+w)} \exp \left(-\operatorname{tr} g_{2}^{t}\left(g_{1}^{-1}\right)^{t} g_{1}^{-1} g_{2}\right) e\left(-\lambda\left\langle k_{\theta_{2}} \cdot f_{ \pm}, a_{t_{2}}^{-1} n_{u_{2}}^{-1} \cdot \tilde{f}_{ \pm}\right\rangle\right) \frac{d \lambda}{\lambda} d g_{2}$.
Note that this integral is conditionally convergent in $\lambda$. However, the integral in $G^{1}$ is of the type described by $I(\lambda)$, and thus outside a bounded set of points of stationary phase, saves an arbitrary power of $\lambda$, hence guaranteeing convergence. The contribution of the points of stationary phase are meromorphic in $w$ and hence are equal in the sense of meromorphic continuation to their regularized value. We choose to regularize by introducing a smooth partition of unity $\sum_{n \in \mathbb{Z}} \sigma\left(\frac{\lambda}{2^{n}}\right)=1$ where $\sigma$ has compact support on $\mathbb{R}^{+}$. The regularized integral is the sum of the integrals

\begin{equation*}
\int_{0}^{\infty} \int_{G^{1}} \sigma\left(\frac{\lambda}{2^{n}}\right) \lambda^{4(1-s+w)} \exp \left(-\operatorname{tr} g_{2}^{t}\left(g_{1}^{-1}\right)^{t} g_{1}^{-1} g_{2}\right) e\left(-\lambda\left\langle k_{\theta_{2}} \cdot f_{ \pm}, a_{t_{2}}^{-1} n_{u_{2}}^{-1} \cdot \tilde{f}_{ \pm}\right\rangle\right) \frac{d \lambda}{\lambda} d g_{2} \tag{59}
\end{equation*}
$$

which give the correct value in the domain of absolute convergence and have analytic continuation. The evaluation of these points can be obtained by using Lemma 14 to separate an asymptotic main term in falling powers of $\lambda$, together with an error term that is absolutely convergent in $\lambda$. The main term becomes a Mellin transform of sin and cosine functions, which have meromorphic continuation.

In coordinates, the trace in the exponential function of $E\left(g_{1}, w\right)$ is equal to

This proves the claims regarding $\partial_{t} \Phi$. To prove the final claim, we can differentiate with respect to $u^{2}$ instead, which obtains a linear equation in $u^{2}$. Substituting the resulting value of $u^{2}$ as a function of $t$ now obtains a polynomial equation in $t$ for $\partial_{t} \Phi=0$ which forces $t$ to be bounded.

The claim regarding higher derivatives at points of stationary phase hold because all variables are bounded there.

Estimates for the partial derivatives of the phase function $\Phi$ and the weight function $W$ are recorded in the following lemmas.

Otherwise, $E_{\mathrm{L}}\left(g_{1}, w\right)=O_{A}\left(\tau^{-A}\right)$.
Proof. To treat $E_{\mathrm{SP}}\left(g_{1}, w\right)$, restrict to the case $\frac{t_{1}}{t_{0}}, \frac{t_{0}}{t_{1}} \ll \log \tau,\left|\frac{t_{0}}{t_{1}} u_{0}-\frac{t_{1}}{t_{0}} u_{1}\right| \ll \log \tau$, since outside this range, the exponential factor in the weight function $W$ makes the integral $O_{A}\left(\tau^{-A}\right)$. In this case, throughout the domain of integration, $\lambda \asymp \tau$ and

We first eliminate the case $\lambda>\tau^{1+\epsilon}$. If $P_{ \pm, \pm}<\frac{1}{100}$ then the derivative of $\sqrt{P_{ \pm, \pm}} c(\theta)$ does not vanish and all of the variables are $O(1)$. Integrating by parts along some line in the $\theta, u, t$ hyperplane saves an arbitrary power of $\lambda$, so that this part of the integral satisfies the required bound. If instead $P_{ \pm, \pm}>\frac{1}{100}$ then either we can integrate by parts with respect to $\theta$ many times to save an arbitrary power of $\lambda$, or else $\theta$ is near its point of stationary phase, in which case $\sqrt{P_{ \pm, \pm}} c(\theta)$ is bounded away from 0 . In this case, integrating by parts in $\lambda$ several times gives the required estimate, as the derivative of the phase is bounded away from 0 by at least a constant, see Lemma 16.

In the remaining part of the $\lambda$ integral, restrict to $\lambda \gg_{A} \tau^{-A}$ by using the weight function. If $\left\langle k_{\theta_{2}} \cdot f_{ \pm}, a_{t_{2}}^{-1} n_{u_{2}}^{-1} \cdot \tilde{f}_{ \pm}\right\rangle>0$, set $\lambda_{0}=\frac{4(\tau-\operatorname{Im}(w))}{2 \pi\left\langle\theta_{\theta_{2}} \cdot f_{ \pm}, a_{t_{2}}^{-1} n_{u_{2}}^{-1} \cdot \tilde{f}_{ \pm}\right\rangle}$. Outside the interval $\left[\frac{\lambda_{0}}{2}, 2 \lambda_{0}\right]$, perform a smooth partition of unity into dyadic intervals and integrate by parts several times on each interval. This obtains the desired bound, since the derivative is bounded below on each interval.

Having restricted to $\left|\lambda-\lambda_{0}\right| \ll \frac{\lambda_{0}}{\tau^{\frac{1}{2}-\epsilon}}$, it follows that $\lambda \sqrt{P_{ \pm, \pm}} \asymp \tau$. The integral in $\theta$

\int_{0}^{1} e^{i 4(\tau-\operatorname{Im}(w)) \log \lambda+2 \pi i \lambda \sqrt{P_{ \pm, \pm}(t, u)} c(\theta)} d \theta \tag{90}

thus decays rapidly for $\left|\theta-\frac{1}{2} \mathbb{Z}\right| \gg \tau^{-\frac{1}{2}+\epsilon}$, so that this part can be discarded.
Make the change of variable $u:=u-\left(\frac{t_{1}}{t}\right)^{2} u_{1}$. The integral in $t$ is

Truncate to $\frac{t}{t_{1}}, \frac{t_{1}}{t} \ll \log \tau, u \ll(\log \tau)^{2}$, making error $O_{A}\left(\tau^{-A}\right)$. If $t \ll 1$ is sufficiently small, $\partial_{t} \Phi$ is bounded below, so that integrating by parts several times in $t$ or $u$ shows that the integral is negligible.

Now assume $t \gg 1$ and let $t_{0}$ be a point of stationary phase in the phase function. This implies $\left(u+\left(\frac{t_{1}}{t_{0}}\right) u_{1}\right)^{2} \asymp t_{0}^{4}$. Expand about $t_{0}$ performing a partition of unity. At $t_{0}$ we have the partial derivatives,

We have, with $W^{*}(t)=\frac{\sigma\left(\frac{ \pm t}{2}\right)}{\left(t_{0}+t\right)^{3}} \exp \left(-\left(\frac{t_{0}+t}{t_{1}}\right)^{2}\left(1+u^{2}\right)-\left(\frac{t_{1}}{t_{0}+t}\right)^{2}\right)$,

\begin{align*}
\partial_{t}^{N} W^{*}(t) & \ll_{N}(\log \tau)^{4 N} \min \left(2^{a}, t_{0}+t\right)^{-N} \frac{\|\sigma\|_{C^{N}}}{\left(t_{0}+t\right)^{3}}  \tag{93}\\
& \times \exp \left(-\left(\frac{t_{0}+t}{t_{1}}\right)^{2}\left(1+u^{2}\right)-\left(\frac{t_{1}}{t_{0}+t}\right)^{2}\right) .
\end{align*}
$$

Using the estimate for the second derivative, it follows that the stationary phase integral in $t$ at $t_{0}$ decays rapidly for $\left|t-t_{0}\right| \gg \sqrt{\frac{t_{0}}{\lambda}} \tau^{\epsilon} \gg \frac{t_{0}}{\tau^{\frac{1}{2}-\epsilon}}$.

For $t \gg 1$, we have, by the constraint

The second derivative in $u$ is of order $\frac{\lambda^{4}}{\tau^{3}}$. Thus if $1 \ll t \ll \tau^{\frac{1}{2}-\epsilon}$ the integral in $u$ is $\lll A \tau^{-A}$.

The above estimates cover all but $E_{\mathrm{L}}$ which we now estimate. Subject to the constraint $t_{1}=\tau^{\frac{1}{2}+O(\epsilon)}$ and $t_{0}=t_{0}\left(u_{1}, t_{1}\right)$ such that $\frac{t_{0}}{t_{1}}, \frac{t_{1}}{t_{0}} \ll \log \tau$, which requires $\frac{u_{1}^{2}}{t_{1}^{4}}, \frac{t_{1}^{4}}{u_{1}^{2}}=(\log \tau)^{O(1)}$, the weight function in the integral is bounded by

We record the following expression for $E_{\mathrm{PL}}\left(g_{1}, w\right)$.

\end{align*}

Integrate in $\theta$ to obtain a $J_{0}$ Bessel function, then integrate in $\lambda$ to obtain its Mellin transform, which proves the lemma.

## 5. The approximate functional equation in the twisted case

The goal of this Section is to prove Theorem 2.
Choose a test function $F_{ \pm}\left(g \cdot f_{ \pm}\right)=n_{ \pm} \lambda^{2 k} \exp \left(-\lambda^{2}-t^{2}-\frac{1}{t^{2}}-\left(\frac{u}{t}\right)^{2}\right)$ with $k \geq 6$ sufficiently large. Notice that, for $x \in S$ in the singular set, to approach $x$ in homogeneous coordinates from $V_{ \pm}$we must have $\lambda \downarrow 0$ and hence at least one of $u, t$ or $\frac{1}{t}$ becomes unbounded, and hence $F_{ \pm}$is $C^{\infty}$ on $V_{\mathbb{R}}$ due to the exponential decay.

The orbital zeta function is the function

The advantage of the test function is that on the time side, integration against the Maass form can be written as a convolution equation that has the Maass form as an eigenfunction. We don't currently know of a test function which satisfies this property on the Fourier side as well, so that the convolution equation on the Fourier side will be analyzed directly.

Lemma 20. We have the factorization in $\operatorname{Re}(s)>1$,

where $C$ is the eigenvalue of the convolution equation $\int_{G_{1}} \exp \left(-\operatorname{tr} g^{t} g\right) \phi\left(h g^{-1}\right) d g=$ $\sqrt{\pi} K_{\nu}(2) \phi(h)$. The integral in $\lambda$ evaluates to $\frac{1}{2} \Gamma(2 s+k)$.

By the Poisson summation formula,

and applying Poisson summation in the later integral, then integrating against the resulting series term-by-term.

Notice that, outside a finite set of points of stationary phase in $g_{2}$, the integral in $g_{2}$ is an oscillatory integral and thus saves an arbitrary power of $\lambda_{2}$, which makes the integral in $\lambda_{2}$ absolutely convergent. Making a change of variable $\lambda \mapsto \frac{1}{\lambda}$ and in $g$, and opening the Fourier transform, obtains

The contribution of the integral at points of stationary phase in $g_{2}$ is, as a function in $\lambda_{2}$, possible to expand in falling powers of $\lambda_{2}$ starting from $\frac{1}{\lambda_{2}^{\frac{3}{2}}}$, multiplied by a linear phase in $\lambda_{2}$. Taking enough terms is sufficient to gain absolute convergence in the integrals over $\lambda_{1}$ and $\lambda_{2}$. The integral with a linear phase may be treated as a Gaussian integral. At points of non-stationary phase, the $\lambda_{1}$ and $\lambda_{2}$ integrals may be taken together. Alternatively, the integral may be extended from the domain of absolute convergence in $w$ by analytic continuation, which obtains the same value. Performing the integral in $\lambda_{1}$, which is a Gamma function, this obtains

with the understanding that at the points of stationary phase of $g_{2}$, the integral in $\lambda$ is only conditionally convergent.

It remains to prove the properties of $V$ and $\hat{V}$, and to estimate the integral against $\Sigma^{ \pm}$. Using the Lemma 22, and the definition of the oscillatory integral $E\left(g_{1}, w\right)$ we may express

& \times \int_{G^{1}} \int_{0}^{\infty} \int_{G^{1}} \lambda^{4(1-s+w)} \phi\left(g_{\xi} g_{1}\right) \exp \left(-\operatorname{tr} g_{2}^{t}\left(g_{1}^{-1}\right)^{t} g_{1}^{-1} g_{2}\right) e\left(-\lambda\left\langle f_{ \pm}, g_{2}^{-1} \cdot \tilde{f}_{ \pm}\right\rangle\right) d g_{2} \frac{d \lambda}{\lambda} d g_{1} d w \\
& =\frac{1}{\sqrt{\pi} K_{\nu}(2)} \frac{1}{2 \pi i} \oint_{\operatorname{Re}(w)=2} \frac{1}{y^{w}} \frac{G(w)}{w} \frac{\Gamma(2 s+k-2 w)}{\Gamma(2 s+k)} \int_{G^{1}} \phi\left(g_{\xi} g_{1}\right) E\left(g_{1}, w\right) d g_{1} d w .
\end{align*}

Recall that we split $E$ as $E_{\mathrm{SP}}+E_{\mathrm{L}}+E_{\mathrm{E}}+E_{\mathrm{PL}}$.
Lemma 23. The contribution to $\hat{V}\left(g_{\xi}, y\right)$ from $w$ with $|\operatorname{Im}(w)|>\tau^{\frac{1}{2}+\epsilon}$ is $O_{A}\left(y^{-2} \tau^{-A}\right)$.
Proof. We have $F$ is $C^{\infty}$, and hence

is bounded uniformly in $\xi$ and $w$. The claim now follows from the decay in vertical strips of $G(w)$.
Lemma 24. Let $\epsilon>0$. The contributition to $\hat{V}\left(g_{\xi}, y\right)$ from $|\operatorname{Im}(w)| \leq \tau^{\frac{1}{2}+\epsilon}$ in which $y P_{ \pm, \pm}\left(t_{2}, u_{2}\right)^{2}>\tau^{2+\epsilon}$ is $O_{\epsilon, A}\left(y^{-2} \tau^{-A}\right)$.

Proof. Write this contribution as

& \times\left[\lambda_{2}^{2 k+4} \exp \left(-\lambda_{2}^{2}-\operatorname{tr} g_{1}^{t}\left(g_{2}^{-1}\right)^{t} g_{2}^{-1} g_{1}\right) e\left(-\lambda_{1} \lambda_{2} \sqrt{P_{ \pm, \pm}\left(t_{2}, u_{2}\right)} c(\theta)\right) \psi\left(\frac{\tau^{2+\epsilon}}{P_{ \pm, \pm}\left(t_{2}, u_{2}\right)}\right)\right]
\end{align*}

The inner two integrals, against $\lambda_{2}$ and $g_{2}$, can be expressed as the Fourier transform of a $C^{\infty}$ function, and thus the inner four integrals, against $\lambda_{1}, g_{1}, \lambda_{2}, g_{2}$ converge absolutely for $0<\operatorname{Re}(1-s+w)$. The resulting function is thus analytic in $w$. Assume $0<$ $\operatorname{Re}(1-s+w)<\frac{3}{8}$. Then the evaluation of Lemma 19 can be used to evaluate $E_{\mathrm{PL}}\left(g_{1}, w\right)$. Note that this evaluation has analytic continuation to $\operatorname{Re}(1-s+w)>0$. This obtains

To prove the claim, push the contour an arbitrarily large constant to the right. This may pass poles of $\Gamma(2 s+k-2 w)$, but each of these satisfies the required bound due to the doubly exponential decay in vertical strips of $G(w)$. This also suffices to bound
the horizontal integrals that result. The claim now follows on bounding the integral in absolute value, putting in a sup-bound for the Maass form.

Lemma 25. The functions $V$ and $\hat{V}$ satisfy the following properties.
(1) There is a $c>0$ such that, if $g=n_{u} a_{t} k_{\theta}$ then, for any $\epsilon>0$,

Proof. We have $V(g, y)=\phi(g) V(y)$ where $V(y)$ can be analyzed as in [15] Lemma 5.4. This suffices to prove the bounds for $y^{a} \partial_{y}^{a} V(g, y)$. The decay in $t$ follows from the rapid decay of the cusp form. Let $h=n_{u_{1}} a_{t_{1}} k_{\theta_{1}}, g=n_{u_{2}} a_{t_{2}} k_{\theta_{2}}$, then

& \int_{0}^{\infty} \int_{G^{1}} \lambda^{4(1-s+w)} \exp \left(-\operatorname{tr} g_{2}^{t}\left(g_{1}^{-1}\right)^{t} g_{1}^{-1} g_{2}\right) e\left(\lambda \sqrt{P_{ \pm, \pm}(t, u)} c(\theta)\right) \frac{d t}{t^{3}} d u d \theta \frac{d \lambda}{\lambda}
\end{align*}

and the trace in the exponential given by

By Lemmas 23 and 24, the part of the integral in $w$ with $|\operatorname{Im}(w)|>\tau^{\frac{1}{2}+\epsilon}$ and the part of the integral over $g_{2}$ with $y P_{ \pm, \pm}^{2}>\tau^{2+\epsilon}$ can be discarded while making error $O_{\epsilon, A}\left(y^{-2} \tau^{-A}\right)$. Similarly, arguing as in Lemma 18, truncate to $\lambda=\tau^{O(1)}$ with the same error. The above considerations truncate $\lambda, t_{2}$ and $u_{2}$ in $E\left(g_{1}, w\right)$ to all have size $\tau^{O(1)}$. Using the exponential factor in this integral, truncate the Iwasawa coordinates in $g_{1}$ to $u_{1}, t_{1}=\tau^{O(1)}$ with the same error. Now apply the bounds in Lemma 18 to reduce $E\left(g_{1}, w\right)$ to the two stationary phase terms $E_{\mathrm{SP}}$ and $E_{\mathrm{PL}}$ while making error $O\left(y^{-2} \tau^{-A}\right)$, in the case of $E_{\mathrm{SP}}$ we can take $u_{1}, t_{1}=(\log \tau)^{O(1)}$.

When $y<\tau^{2}$, in the terms from $E_{\text {SP }}$ shift the contour to $\operatorname{Re}(w)=-\epsilon$, bounding the horizontal integrals by $O_{A}\left(\tau^{-A}\right)$. There is a pole at 0 , which we bound together with the $w$ integral. Due to the rapid decay of the $w$ integral, and applying the bounds of Lemma 18 these are bounded by
$O_{A}\left(\tau^{-A}\right)+\sum_{\left(\lambda_{0}, \theta_{0}, t_{0}, u_{0}\right) \in \mathscr{S}} \int_{G^{1}} \phi\left(g g_{1}\right) \exp \left(-\left(\frac{t_{1}}{t_{0}}\right)^{2}-\left(\frac{t_{0}}{t_{1}}\right)^{2}-\left(\frac{t_{0}}{t_{1}} u_{0}-\frac{t_{1}}{t_{0}} u_{1}\right)^{2}\right) \frac{d t_{1}}{t_{1}^{3}} d u_{1} d \theta_{1}$.
Write

g g_{1}=n_{u} a_{t} k_{\theta} n_{u_{1}} a_{t_{1}} k_{\theta_{1}}=n_{u} a_{t} n_{u_{1}} a_{t_{1}}\left(\left(n_{u_{1}} a_{t_{1}}\right)^{-1} k_{\theta} n_{u_{1}} a_{t_{1}}\right) k_{\theta_{1}} . \tag{128}
\end{equation*}
$$

Let $n_{u_{2}} a_{t_{2}} k_{\theta_{2}}=\left(\left(n_{u_{1}} a_{t_{1}}\right)^{-1} k_{\theta} n_{u_{1}} a_{t_{1}}\right)$, so that $t_{2}=u_{1}^{O(1)} t_{1}^{O(1)}$. Hence if $g g_{1}=n_{u^{\prime}} a_{t^{\prime}} k_{\theta^{\prime}}$ then $t^{\prime}=t t_{1}^{O(1)} u_{1}^{O(1)}$. Since $\phi$ decays singly exponentially in $t^{\prime}$ and the exponential factor decays doubly exponentially in $t_{1}$ and $t_{1} u_{1}$, the integral is bounded by $\exp \left(-c t^{c}\right)$ for some $c>0$. If $y<\tau^{\epsilon}$, there is an additional contribution from $\mathbf{E}_{\text {PL }}$ which occurs when $\tau^{1-O(\epsilon)}<\left|u_{1}\right|<\tau^{1+O(\epsilon)}$, and $\frac{u_{1}^{2}}{t_{1}^{4}}=(\log \tau)^{O(1)}$. In this case integrate the $w$ integral on the $\operatorname{Re}(w)=2$ line. The ratio of Gamma factors is bounded by $\ll \tau^{-2 \operatorname{Re}(w)}$, which balances the $w$ contribution from $E_{\mathrm{PL}}$. Bounding the Maass form by a constant, this obtains a bound of

When $y>\tau^{2}$, only $E_{\mathrm{SP}}$ needs to be considered. To obtain the estimate in (1), bound the integral between the Maass form and exponential function as before with $\operatorname{Re}(w)=2$.

To prove (2), in both $\hat{V}(h g, y)$ and $\hat{V}(g, y)$, bound all but the main term from $E_{\mathrm{SP}}$ as for (1), absorbing the errors in the second error term. Arguing as before, this reduces to bounding the integral

\end{align*}

As above, write $g g_{1}=n_{u^{\prime}} a_{t^{\prime}} k_{\theta^{\prime}}$ with $u^{\prime}=u+u_{1}^{O(1)} t_{1}^{O(1)}, t^{\prime}=t u_{1}^{O(1)} t_{1}^{O(1)}$. Then as before,

To prove (3), differentiate under the integral sign. The proof of the estimate is the same as that for (1) when $y \ll \tau^{2}$. When $y \gg \tau^{2}$, bound $E_{\text {SP }}$ by pushing the integral arbitrarily far to the right and estimate as before.
5.1. The singular terms. In this Section we prove the following estimate for singular forms, which, combined with Lemma 25 proves Theorem 2.

Lemma 26. We have the bound

\end{equation*}

Taken together the singular terms have sufficient decay for the integral to be convergent, but taken separately they can diverge. We now regularize the singular terms by introducing a smooth weight $w_{z}(\lambda)=e^{-z\left(\lambda+\lambda^{-1}\right)}$ which tends to 1 as $z \rightarrow 0$. Consider

Note that $\hat{F}_{ \pm}$is $K$ invariant so that the integrals over $K$ are omitted in this section. The singular terms have the fibration

As in [13], integration over the first two terms of the fibration vanishes due to the cusp form. To see this, in the case of $\{0\}$, the integral is

which again vanishes by integrating in $u$, since $(0,0,0, m)$ is stabilized by $n_{u}$ and the cusp form does not have a constant term in its Fourier expansion.

The remaining singular terms are given by

Insert the Fourier series for $\phi$ to obtain

\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)= & \lim _{z \downarrow 0} 2 \int_{0}^{\infty} w_{z}(\lambda) \lambda^{4(1-s+w)} \int_{-\infty}^{\infty} \int_{0}^{\infty} \sum_{\ell=1}^{\infty} \rho_{\phi}(\ell) K_{\nu}\left(2 \pi \ell t^{2}\right) \cos (2 \pi \ell u)  \tag{138}\\
& \times \sum_{m=1}^{\infty} \sum_{n=0}^{3 m-1} \hat{F}\left(0,0, \frac{3 m \lambda}{t}, \frac{\lambda(n+3 u m)}{t^{3}}\right) \frac{d \lambda}{\lambda} \frac{d t}{t^{2}} d u .
\end{align*}
$$

Change variable in $u$ and sum in $n$ to select $3 m \mid \ell$ which we rewrite as $\ell=3 m \ell^{\prime}$. This obtains

& \times \cos \left(\frac{6 \pi \ell m t^{3} u}{\lambda}\right) \hat{F}\left(0,0, \frac{3 m \lambda}{t}, u\right) \frac{d \lambda}{\lambda} t d t d u .
\end{align*}
$$

Integrating in $u$, and writing $\hat{F}_{4}$ for the Fourier transform taken in the first three variables but not the fourth, obtains

& \times \sum_{\ell, m=1}^{\infty} \rho_{\phi}(3 \ell m) K_{\nu}\left(6 \pi \ell m t^{2}\right) \hat{F}_{4}\left(0,0, \frac{3 m \lambda}{t}, \frac{\varepsilon 3 \ell m t^{3}}{\lambda}\right) \frac{d \lambda}{\lambda} t d t
\end{align*}
$$

Evidently there is no longer a issue of convergence so that the weight $w_{z}(\lambda)$ may be removed. This is because the exponential decay of $K_{\nu}$ controls the large $t, m, \ell$ behavior, while when $t$ is small, the third slot of the Fourier transform essentially bounds $\lambda \ll t$ and $\ell m \ll t^{-2}$ which gains the convergence in $t$ for $\operatorname{Re}(w)>-\frac{1}{4}$.

Let $\alpha=\frac{3 m \lambda}{t}, \beta=\frac{3 \ell m t^{3}}{\lambda}$. This obtains

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)= & \frac{1}{9} \sum_{\varepsilon= \pm} \int_{0}^{\infty} \int_{0}^{\infty} \alpha^{6(1-s+w)-\frac{1}{2}} \beta^{2(1-s+w)-\frac{1}{2}}  \tag{141}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(\frac{2 \pi \alpha \beta}{3 m}\right)}{\ell^{2(1-s+w)+\frac{1}{2}}(3 m)^{8(1-s+w)}} \hat{F}_{4}(0,0, \alpha, \varepsilon \beta) \frac{d \alpha}{\alpha} d \beta
\end{align*}
$$

We now open the Fourier transform as an integral over $V_{\mathbb{R}}$. This gives

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)= & \frac{1}{9} \sum_{\varepsilon= \pm} \int_{0}^{\infty} \int_{0}^{\infty} \alpha^{6(1-s+w)-\frac{1}{2}} \beta^{2(1-s+w)-\frac{1}{2}} \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(\frac{2 \pi \alpha \beta}{3 m}\right)}{\ell^{2(1-s+w)+\frac{1}{2}}(3 m)^{8(1-s+w)}}  \tag{142}\\
& \times \int_{\mathbb{R}^{3}} F_{ \pm}\left(\varepsilon \beta, x_{2}, x_{3}, x_{4}\right) e^{-2 \pi i \frac{\alpha x_{2}}{3}} \frac{d \alpha}{\alpha} d \beta d x
\end{align*}
$$

We now write the integral over $\beta, x_{2}, x_{3}, x_{4}$ in $V_{\mathbb{R}}$ as an integral over $G^{+}$using the orbit description of $F_{ \pm}$. In what follows we give the proof for $V_{-}$, the proof in the case of $V_{+}$ being similar. In this case, the first coordinate $\beta$ is given by $\frac{\lambda s(\theta)}{\sqrt{2} t^{3}}$, which we impose the constraint is positive. This obtains

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right) & =\frac{1}{9} \int_{0}^{\infty} \alpha^{6(1-s+w)-\frac{1}{2}} \int_{\theta \in[0,1]} \int_{-\infty}^{\infty} \int_{0}^{\infty} \int_{0}^{\infty}\left|\frac{\lambda}{\sqrt{2}} \frac{s(\theta)}{t^{3}}\right|^{2(1-s+w)-\frac{1}{2}}  \tag{143}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(\frac{2 \pi \alpha}{3 m}\left(\frac{\lambda s(\theta)}{\sqrt{2} t^{3}}\right)\right)}{\ell^{2(1-s+w)+\frac{1}{2}}(3 m)^{8(1-s+w)}} \\
& \times e^{-\frac{2 \pi i \alpha}{3} \frac{\lambda}{\sqrt{2 t}}(c(\theta)+3 s(\theta) u)} \lambda^{2 k} \exp \left(-\lambda^{2}-t^{2}-\frac{1}{t^{2}}-(t u)^{2}\right) \lambda^{3} d \lambda \frac{d t}{t} d u d \theta \frac{d \alpha}{\alpha}
\end{align*}
$$

After a change of variable in $\alpha$ this obtains

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right) & =\frac{1}{9} \int_{0}^{\infty} \alpha^{6(1-s+w)-\frac{1}{2}} \int_{\theta \in[0,1]} \int_{-\infty}^{\infty} \int_{0}^{\infty} \int_{0}^{\infty}\left|\frac{\lambda}{\sqrt{2}} \frac{s(\theta)}{t^{3}}\right|^{-4(1-s+w)}  \tag{144}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}(2 \pi \alpha)}{(3 \ell m)^{2(1-s+w)+\frac{1}{2}}} e^{-2 \pi i \alpha m t^{2}\left(\frac{c(\theta)}{s(\theta)}+3 u\right)} \lambda^{2 k} \\
& \times \exp \left(-\lambda^{2}-t^{2}-\frac{1}{t^{2}}-(t u)^{2}\right) \lambda^{3} d \lambda \frac{d t}{t} d u d \theta \frac{d \alpha}{\alpha}
\end{align*}
$$

Integrate in $\theta$ treating this as a cotangent integral, and integrate in $\lambda$. This obtains

$$
\begin{align*}
\Sigma^{ \pm}(s-w, \phi, & \left.F_{ \pm}\right)=\frac{1}{18} \frac{1}{(2 \pi)^{-(1-2 s+2 w)}} \frac{\Gamma(k+2 s-2 w)}{\Gamma(-1+2 s-2 w)} \int_{0}^{\infty} \alpha^{4(1-s+w)}  \tag{145}\\
& \times \int_{-\infty}^{\infty} \int_{0}^{\infty} t^{1+8(1-s+w)} \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}(2 \pi \alpha) K_{\frac{1}{2}+(1-2 s+2 w)}\left(2 \pi \alpha m t^{2}\right)}{(3 \ell)^{2(1-s+w)+\frac{1}{2}} m^{4(1-s+w)}} \\
& \times e^{-6 \pi i \alpha m t^{2} u} \exp \left(-t^{2}-\frac{1}{t^{2}}-(t u)^{2}\right) \frac{d t}{t} d u \frac{d \alpha}{\alpha} .
\end{align*}
$$

Now integrate in $u$

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)= & \frac{1}{18 \sqrt{\pi}} \frac{1}{(2 \pi)^{-(1-2 s+2 w)}} \frac{\Gamma(k+2 s-2 w)}{\Gamma(-1+2 s-2 w)} \int_{0}^{\infty} \alpha^{4(1-s+w)} \int_{0}^{\infty} t^{8(1-s+w)}  \tag{146}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}(2 \pi \alpha) K_{\frac{1}{2}+(1-2 s+2 w)}\left(2 \pi \alpha m t^{2}\right)}{(3 \ell)^{2(1-s+w)+\frac{1}{2}} m^{4(1-s+w)}} \\
& \times \exp \left(-t^{2}-\frac{1}{t^{2}}-9 \pi^{2} \alpha^{2} m^{2} t^{2}\right) \frac{d t}{t} \frac{d \alpha}{\alpha} .
\end{align*}
$$

Make a change of variable in $\alpha$ to obtain

$$
\begin{align*}
& \Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)=\frac{1}{18 \sqrt{\pi}} \frac{1}{(2 \pi)^{-(1-2 s+2 w)}} \frac{\Gamma(k+2 s-2 w)}{\Gamma(-1+2 s-2 w)} \int_{0}^{\infty} \alpha^{4(1-s+w)} \int_{0}^{\infty}  \tag{147}\\
& \quad \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(\frac{18 \pi \alpha m^{2}}{t^{2}}\right) K_{\frac{1}{2}+(1-2 s+2 w)}\left(18 \pi \alpha m^{3}\right) 3^{6(1-s+w)-\frac{1}{2}} m^{4(1-s+w)}}{\ell^{2(1-s+w)+\frac{1}{2}}} \\
& \quad \times \exp \left(-t^{2}-\frac{1}{t^{2}}-\frac{81 \pi^{2} \alpha^{2} m^{4}}{t^{2}}\right) \frac{d t}{t} \frac{d \alpha}{\alpha} .
\end{align*}
$$

The integral in $t$ is now one of the standard $K$-Bessel function integrals. Exercising this obtains

$$
\begin{align*}
& \Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right)=\frac{K_{\nu}(2)}{18 \sqrt{\pi}} \frac{1}{(2 \pi)^{-(1-2 s+2 w)}} \frac{\Gamma(k+2 s-2 w)}{\Gamma(-1+2 s-2 w)} \int_{0}^{\infty} \alpha^{4(1-s+w)}  \tag{148}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(9 \pi \alpha m^{2}\right) K_{\frac{1}{2}+(1-2 s+2 w)}\left(18 \pi \alpha m^{3}\right) 3^{6(1-s+w)-\frac{1}{2}} m^{4(1-s+w)}}{\ell^{2(1-s+w)+\frac{1}{2}}} \frac{d \alpha}{\alpha}
\end{align*}
$$

After a further change of variable in $\alpha$ this becomes

$$
\begin{align*}
\Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right) & =\frac{K_{\nu}(2)}{18 \sqrt{\pi}} \frac{1}{(2 \pi)^{-(1-2 s+2 w)}} \frac{\Gamma(k+2 s-2 w)}{\Gamma(-1+2 s-2 w)} \int_{0}^{\infty} \alpha^{4(1-s+w)}  \tag{149}\\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m) K_{\nu}\left(\frac{\pi \alpha}{m}\right) K_{\frac{1}{2}+(1-2 s+2 w)}(2 \pi \alpha)}{(3 \ell)^{2(1-s+w)+\frac{1}{2}} m^{8(1-s+w)}} \frac{d \alpha}{\alpha} .
\end{align*}
$$

The integral in $\alpha$ may now finally be expressed as in Lemma 4.

$$
\begin{align*}
\int_{0}^{\infty} & K_{\frac{1}{2}+(1-2 s+2 w)}(2 \pi \alpha) K_{\nu}\left(\frac{\pi \alpha}{m}\right) \alpha^{4(1-s+w)} \frac{d \alpha}{\alpha}  \tag{150}\\
& =\frac{\pi^{-4(1-s+w)}}{2^{3+\nu} m^{\nu}} \Gamma\left(\frac{1}{2}\left(6(1-s+w)-\frac{1}{2}+\nu\right)\right) \Gamma\left(\frac{1}{2}\left(2(1-s+w)+\frac{1}{2}-\nu\right)\right) \\
& \times \int_{0}^{1} t^{1-s+w-\frac{3}{4}-\frac{\nu}{2}}(1-t)^{3(1-s+w)-\frac{5}{4}-\frac{\nu}{2}}\left(1-\frac{4 m^{2}-1}{4 m^{2}} t\right)^{-3(1-s+w)+\frac{1}{4}-\frac{\nu}{2}} d t .
\end{align*}
$$

In the last integral, bound $\left(1-\frac{4 m^{2}-1}{4 m^{2}} t\right)^{-3(1-s+w)+\frac{1}{4}-\frac{\nu}{2}} \ll m^{6 \operatorname{Re}(1-s+w)}$ so that the integral altogether is

$$
\begin{equation*}
\int_{0}^{1} t^{1-s+w-\frac{3}{4}-\frac{\nu}{2}}(1-t)^{3(1-s+w)-\frac{5}{4}-\frac{\nu}{2}}\left(1-\frac{4 m^{2}-1}{4 m^{2}} t\right)^{-3(1-s+w)+\frac{1}{4}-\frac{\nu}{2}} d t \ll m^{6 \operatorname{Re}(1-s+w)} . \tag{151}
\end{equation*}
$$

Proof of Lemma 26. Shift the contour to $\operatorname{Re}(w)=\epsilon$. This obtains

$$
\begin{align*}
& \frac{2}{\sqrt{\pi} K_{\nu}(2) \Gamma(2 s+k)} \frac{1}{2 \pi i} \oint_{\operatorname{Re}(w)=\epsilon} \Sigma^{ \pm}\left(s-w, \phi, F_{ \pm}\right) G(w) \frac{d w}{w}  \tag{152}\\
& =\frac{1}{9} \oint_{\operatorname{Re}(w)=\epsilon} \frac{G(w)}{w} 2^{-2-2 s+2 w} \pi^{-4+2 s-2 w} \\
& \times \frac{\Gamma(2 s+k-2 w) \Gamma\left(3(1-s+w)-\frac{1}{4}+\frac{\nu}{2}\right) \Gamma\left(1-s+w+\frac{1}{4}-\frac{\nu}{2}\right)}{\Gamma(2 s+k) \Gamma(-1+2 s-2 w)} \\
& \times \sum_{\ell, m=1}^{\infty} \frac{\rho_{\phi}(3 \ell m)}{(3 \ell)^{2(1-s+w)+\frac{1}{2}} m^{8(1-s+w)}} \\
& \times \int_{0}^{1} t^{1-s+w-\frac{3}{4}-\frac{\nu}{2}}(1-t)^{3(1-s+w)-\frac{5}{4}-\frac{\nu}{2}}\left(1-\frac{4 m^{2}-1}{4 m^{2}}\right)^{-3(1-s+w)+\frac{1}{4}-\frac{\nu}{2}} d t d w .
\end{align*}
$$

The sum over $\ell$ and $m$ and the integral in $t$ are uniformly bounded. The claim now follows since $G(w)$ decays doubly exponentially in $\operatorname{Im}(w)$, so that we can truncate to $|\operatorname{Im}(w)|<\tau^{\frac{1}{2}+\epsilon}$ with error $O_{A}\left(\tau^{-A}\right)$. In this range, by Stirling's approximation the ratio of Gamma factors is $O_{A}\left(\tau^{-A}\right)$.
